Lok Sabha to hold crucial debate on **SIR** today

New Delhi, Dec 9: Lok Sabha is set for a high-stakes debate on the Special Intensive Revision (SIR) of electoral rolls and wider electoral reforms today, following a prolonged impasse that stalled proceedings. The breakthrough came after intense negotiations between the government and Opposition, culminating in an all-party agreement on Tuesday to bring the matter to the floor of both Houses. According to the schedule finalised at the meeting chaired by Lok Sabha Speaker Om Birla, the Lok Sabha will hold a full debate on electoral reforms on December 9, responding to the Opposition's persistent demand for a structured discussion on the SIR process.

Kochi Dec 9: In a deeply emotional and powerful outpouring following the verdict in the 2017 actress abduction and assault case, veteran dubbing artiste Bhagyalakshmi on Tuesday said that through the long and painful legal battle, it was only the media and society at large that truly stood by the survivor. Actor Dileep, who was the eighth accused in the charge sheet, was acquitted by the trial court on Monday. hagyalakshmi said the public receptions and celebratory words organised in favour of the accused after the verdict shattered the survivor emotionally. "What we have now is not the final verdict. There are still higher courts. Dileep is still only an accused.' she said, underscoring that the legal fight is far

Vikram Bhatt sent to 7-day police custody in Rs 30 crore fraud

JAIPUR, DEC 9: Bollywood filmmaker Vikram Bhatt and his wife Shwetambari have been remanded to seven days of police custody by the ACJM court in Udaipur in connection with an alleged Rs 30 crore fraud case. The couple was arrested from their Mumbai residence on December 7 and brought to Udaipur late Monday night. The duo was produced in court on Tuesday afternoon. DSP Chhagan Singh Rajpurohit is leading the investigation. Upon arrival in Udaipur, both attempted to avoid media cameras. Vikram Bhatt has already challenged the case in the Jodhpur High Court, where the hearing is scheduled. Earlier, the Udaipur Police had arrested co-producer Mehboob Ansari and vendor Sandeep from Mumbai on November 16.

Telangana Rising Global Summit clocks in investments



HYDERABAD (TSIT): The Telangana government announced that it secured investment agreements worth Rs.3.24 lakh crore on the second day of the Telangana Rising Global Summit, generating 1,40,500 employment opportunities. This comes a day after the state signed MoUs worth Rs.2.43 lakh crore.

A wide spectrum of sectors-including food processing, agritech, data centres, pharmaceuticals, biotech, electronics, and clean energy—saw substantial investor response.In the FMCG segment, Reliance Consumer Products Limited (RCPL) will establish a multi-product manufacturing facility on 100 acres with an investment of

Rs.1,500 crore, creating 1,000 direct jobs. Godrej Industries Group will expand its dairy unit to 5 lakh litres per day with a Rs.150 crore investment, generating 300 jobs. Fertis India Pvt. Ltd. proposed a Rs.2,000 crore food and agriculture R&D centre and rare sugars manufacturing facility, set to create 800 jobs in two phases. Vintage Coffee announced a Rs.1,100 crore freeze-dried coffee plant, while KJS India will invest Rs.650 crore in F&B expansion. The data centre and technology sector saw massive commitments. JCK Infra Projects will invest Rs.9,000 crore, while Infraki DC Parks has proposed a game-changing Rs.70,000 crore 1 GW data park. AGP

Group plans a Rs.6.750 crore investment, and Purview Group aims to set up an AI-driven 50 MW data centre creating 3,000 jobs. Cleanenergy-based data centres are also in the pipeline, including Aquellon Nexus Ltd's netzero 50 MW facility.

The pharma, biotech and life sciences industries emerged as major contributors. Hetero Group announced Rs.1,800 crore to expand pharma manufacturing, creating more than 9,000 jobs. Aurobindo Pharma will invest Rs.2,000 crore, while Granules India proposed a Rs.1,200 crore peptide and oncology CDMO unit.

Biological E Ltd committed an additional Rs.3,500 crore, taking its total investment to Rs.4,000 crore and creating 3,000 jobs. Bharat Biotech will set up a Rs.1,000 crore CRDMO facility, and BioVaraum confirmed a Rs.250 crore regenerative medicine centre.In electronics and green energy, Kane's Technology will invest Rs.1,000 crore to expand electronics manufacturing, while Altmin is exploring a battery raw material facility.

The state also presented future opportunities at Bharat Future City, positioning Telangana as a potential gateway for UAE-Africa-India collaborations in tourism, wellness, logistics, and hospitality.

2,501 new confirmed mpox cases, 12 deaths reported from 44 countries in Oct: WHO

NEW DELHI (TSIT): A total of 2,501 new confirmed cases, including 12 deaths due to mpox, were reported from 44 countries in October, said the World Health Organization (WHO) on Tuesday. The latest situation report for the multi-country outbreak of mpox showed that all clades of the monkeypox virus (MPXV) continue to circulate. When mpox outbreaks are not rapidly contained, and human-tohuman transmission is not interrupted, there is a risk of sustained community transmission. "In October 2025, 44 countries, across all WHO regions, reported a total of 2,501 new confirmed mpox cases, including 12 deaths (case fatality ratio [CFR] 0.5 per cent)," the WHO report said. Twenty-one in Africa reported active transmission of mpox in the last six weeks (from October 12 to November 23), with 1,734 confirmed cases, including 10 deaths. Democratic Republic of Congo, Liberia, Ghana, Kenya, and Uganda reported the highest number of cases, with

Mali reporting mpox for the first time. New

imported cases of mpox due to clade Ib $\ensuremath{\mathsf{MPXV}}$

were reported among travellers in Belgium, Germany, Greece, and the United Kingdom of Great Britain and Northern Ireland.

A total of 43 new confirmed cases of mpox due to clade Ib MPXV have been reported across six WHO regions, between September 5 and November 24, outside areas where sustained community transmission of this virus

strain has been occurring.In four of these regions (the Americas, Southeast Asia, Europe, and the Western Pacific), 24 cases reported no recent international travel, suggesting local transmis-

sion. Based on this, Italy, Malaysia, the Netherlands, Portugal, Spain, and the US are now considered to be experiencing community transmission of clade Ib MPXV. In addition, travel-related cases continue to be reported in many countries. Among the 43 cases, half (22) were documented among men who have sex with men, while other cases were linked to travel to countries with known community transmission of clade Ib MPXV, or secondary to travelrelated cases (household contacts and/or sexu-

'No bigger anti-national act than vote chori': Rahul attacks BJP

NEW DELHI, DEC 9: The Lok Sabha witnessed a stormy debate as Congress MP Rahul Gandhi launched a fierce attack on the Rashtriya Swayamsevak Sangh (RSS), accusing it of "systematically seeking to dominate India's institutions", and said that there is "no bigger antinational act than vote chori."

Speaking during a discussion on electoral reforms, Leader of Opposition Rahul Gandhi asserted that "everything in India that exists today has emerged from the vote, and the RSS is trying to capture that."

His remarks provoked loud protests from ruling party members, prompting Speaker Om Birla to intervene multiple times to restore order. Gandhi alleged that the RSS, in collaboration with the Bharatiya Janata Party (BJP), has undermined democratic institutions, beginning with the Election Commission of India (ECI). Gandhi outlined three areas



of institutional capture: education, investigative agencies, and the Election Commission. To support his claims, he posed three questions: why the Chief Justice of India was removed from the selection panel for Election Commissioners; why, in December 2023, the government granted unprecedented immunity to Election Commissioners; and why CCTV footage of polling stations is destroyed after 45 days. He argued that these

manipulation."Today, the Election Commission of India is colluding with those in power to shape the election," he declared, questioning why the Prime Minister and the Home Minister were so intent on deciding who should serve as Election Commissioner. He further claimed that

investigative agencies such the Enforcement Directorate (ED), National Investigation Agency (NIA), and Central Bureau of Investigation (CBI) have been compromised, with bureaucrats appointed to target opposition voices.In a dramatic moment, Gandhi invoked history, recalling Mahatma Gandhi's assassination on January 30, 1948. He argued that the RSS project began after the Father of the Nation was killed, with the aim of dismantling his vision of an equal India where institutions belonged to the people. "These are uncomfortable truths, but they have to be spoken," Gandhi said when treasury benches raised objections to his statements against RSS.

His remarks drew sharp objections Parliamentary Affairs Minister Kiren Rijiju, who insisted Gandhi was straying from the subject of electoral reforms. "He is not speaking anything related to electoral reforms," Rijiju said, urging the Speaker to direct Gandhi to remain rel-


CM Naidu asks NDA leaders to participate in Atal Sandesh yatra

NEW DELHI (TSIT): IndiGo

CEO Pieter Elbers said on Tuesday that the airline's operations have stabilised after days of widespread flight disruptions that left passengers stranded at major airports nationwide, as the low-cost carriers planes were grounded due to an acute shortage of pilots under the new flight duty limitation norms. Elbers claimed in a statement on X that "IndiGo is back on its feet," with efforts to restore the network progressing on a "war footing." He said the airline is now flying more than 1,800 flights a day, restoring its full network of 138 destinations. "As of December 9, our operations are fully stabilised," the CEO remarked. Elbers further stated that IndiGo has "started to focus internally on what led to the issue," indicating a deeper review of processes and resource planning.

Nara Lokesh Pitches AP as Tech Hub in San Francisco Meetings



San Francisco, USA: Andhra Pradesh's Minister for IT, Electronics, and Human Resources, Nara Lokesh, held a series of highlevel meetings with prominent venture capital and technology firms in San Francisco to attract significant investments into the state, focusing on deep tech, creative economy, and IT infrastructure.

During his visit, Lokesh urged international venture capital firm Celesta VC to establish a Deep Tech Innovation Hub in Andhra Pradesh. In a meeting with Managing Partner Arun Kumar, he highlighted Visakhapatnam's rapid growth as an IT and data hub and invited investments in semiconductors, AI, and quantum computing. Lokesh also introduced a pioneering "escrow account" system to ensure direct and timely disbursal of incentives to industries. Kumar stated that Celesta VC, which focuses on the US, India, Israel, and Southeast Asia, would review the proposals.

A key focus of the discussions was the development of Amaravati as a global hub for the creative economy. The minister met with Sajan Raj Kurup, founder of Creative Land Asia, to push for the swift commencement of the 'Creator Land' project. The transmedia city, part of an MoU signed last year, is envisioned to feature AI-driven virtual studios and AR/ VR theme parks. Kurup confirmed that preparations are underway to begin the project within 24 months, which could attract up to Rs.10,000 crore in investments and create 1.5 lakh jobs.

Furthering the vision for Amaravati, Nara Lokesh met with Autodesk's Chief Technologist, Dev Patel, proposing the establishment of a Global Capability Center and a Design & Innovation Academy in the capital. He sought Autodesk's expertise in creating a "digital twin" of Amaravati using its BIM technology and requested technical assistance in designing cycloneresistant buildings for the state's coastal areas. Patel said the proposals would be discussed with the company's senior leadership.

The minister also engaged with Varma Kunapuli, CEO of IT operations management firm OpsRamp, seeking support for modernizing IT infrastructure for the state's smart cities and digital governance initiatives. He proposed a partnership with the AP Tech Academy for AIOps training and internships.

South Asian Liver Institute study reveals alarming rise of multi-drug resistance in tier-2 towns

Hyderabad: A 26-month clinical research study conducted by the South Asian Liver Institute has revealed deeply concerning levels of multi-drug antimicrobial resistance (MDR) even in semi-rural Tier-2 towns, indicating a rapidly escalating public health crisis. The retrospective study analysed 67 liver surgery patients over a two-and-a-halfyear period and found that 24% had bacterial infections—majority caused by Gram-negative organisms.

Of the 46 liver transplant recipients studied, 16 patients tested positive for bacterial infections. Prof. Dr. Tom Cherian, Head of Transplant Surgery and Principal Investigator, stated that a staggering 94% of these bacteria were resistant to both first- and secondline antibiotics, while some showed resistance even to third-line drugs and last-resort options like Oxazolidinones.

Highlighting a critical insight, Dr. Cherian noted that 56% of infected patients were already positive before surgery, indicating that they arrived at the hospital carrying MDR bacteria. "This changes everything. Traditional infection control strategies focus on preventing spread to the patient, but when more than half

detect and neutralize

such infections before elective procedures," he emphasized, calling it a national crisis requiring immediate intervention.

Liver Critical Care Consultant and subinvestigator, Dr. A. Gogineni, added that Klebsiella pneumoniae and Escherichia coli accounted for 58% of the cases. The study found high resistance to commonly used antibiotic classes including fluoroquinolones, penicillins,



Talking to reporters after inaugurating a school wrestling championship at the Veer Lorik Stadium in Ballia, Pathak also targeted the Trinamool Congress and said it will be "wiped out like Babari Masiid".

He asserted that the BJP will score sweeping victories in assembly elections in Uttar Pradesh in 2027 and, more imminently, in West Bengal.

"Just as the people of Bihar have completely rejected the jungle raj of the RJD and given a massive mandate to the NDA, the Congress and the Samajwadi Party (SP) will face a similar outcome in Uttar Pradesh," he said.

Pathak claimed that the BJP would repeat its 2017 performance in the 2027 assembly elections, winning more than 325 seats with a "thumping majority".

Claiming a sweeping political change similarly in West Bengal, Pathak said, "In the 2026 assembly elections,

they (the Trinamool Congress) will be wiped out like the Babri Masjid and the B.IP will form the government.'

The deputy chief minister further asked Yadav and Congress to "look within before commenting on others". He, however, did not mention any

specific comments by the SP chief. Participating in a discussion on the 150th anniversary of "Vande Mataram" in the Lok Sabha on Monday, Yaday hit out at the BJP, claiming that those who did not participate in the freedom struggle were now talking of the values of the national song.

SIR deliberately timed to stall development work in Bengal: Mamata Mamata

KOLKATA: West Bengal Chief Minister Mamata Banerjee on Monday alleged that the special intensive revision (SIR) of electoral rolls was "deliberately timed" to stall development projects in the state.

During an administrative review meeting in Cooch Behar, Banerjee said officials associated with the exercise were under "immense pressure", but urged them to not ignore development work due to the

The revision of electoral rolls began in the state on November 4 with the distribution of enumeration forms, which will continue till December 11.

"I know there is immense pressure on the booth-level officers (BLOs), sub-divisional officers (SDOs) and booth-level agents (BLAs). But, development projects and work on the SIR, both have to continue," the chief minister said.

"This SIR is deliberately timed now to stall development projects of the state government. Why this hurriedness to complete this exercise in two months? Last time, it took two years. But, development work is a continuous process, and there should not be any neglect in it," she said. Baneriee maintained that the SIR was aimed at "snatching away the voting rights" of the common people and help the BJP in elections.

The CM also asked district magistrates to assist the BLOs in the SIR exercise.

Banerjee urged people to attend the hearings of the Election Commission following the SIR, adding that 'May I Help You' booths will be set up in every ward from December 12 to assist voters.

The TMC supremo also likened the ongoing crisis in the aviation sector with the SIR process, alleging that both were a result of poor planning.

Centre sanctions 1.11 cr houses under two schemes of Pradhan Mantri Awas Yojana

tioned 1.11 crore houses under two schemes of Pradhan Mantri Awas Yojana, with 95.54 lakh of those houses having already been completed and handed over to beneficiaries, Minister of Housing and Urban Affairs Manohar Lal informed the Rajya Sabha on

Replying to supplementaries during the question hour, the minister said that, according to a 2020 slum survey, as many as 6.5 crore people, comprising 1.39 crore households, were living in slums across the country. "Under both schemes, the Centre has sanctioned 1.11 crore houses and 1.10 crore have been grounded, of which 95.54 lakh houses have been ready and handed over," the minister told the house.

He said land and colonisation are State subjects and policies and programmes related to slum rehabilitation rest with respective states/Union Territories (UTs). Hence, data related to slum rehabilitation or relocation is not maintained by the ministry, he added.

"However, as regards the National Capital Territory of Delhi (NCTD), the slum rehabilitation and/or demolitions are done by various land owning agencies like Delhi Development Authority (DDA), Delhi Urban Shelter Improvement Board (DUSIB), etc., under the provisions of various applicable Acts.

"As per the information received from DDA, as part of the Slum Rehabilitation/ Relocation programme, DDA has carried out demolition after properly rehabilitating eligible slum

dwellers. It involves a total of 5,158 households, out of which a total of 3,414 were found eligible for alternative rehabilitation as per the DUSIB policy," the minister said in his writ-

The eligible dwellers have been provided with alternative rehabilitaion with all modern facilities, he said.

Implementing agencies execute slum rehabilitation projects based on their own land management policies and the slum rehabilitation policy of States/UTs. During the slum rehabilitation and/or resettlement, land owning agencies/implementing agencies and affected families/beneficiaries may also seek assistance under the Pradhan Mantri Awas Yojana – Urban (PMAY-U) and PMAY-U 2.0, if beneficiaries are otherwise eligible,

"Ministry of Housing and Urban Affairs (MoHUA) is supplementing the efforts of States/UTs by providing central assistance under PMAY-U since June 25, 2015, for the construction of houses for eligible families/ beneficiaries, including slum dwellers. "Further, based on the learnings from the experiences of implementation of PMAY-U, MoHUA has revamped the scheme and launched PMAY-U 2.0 'Housing for All' Mission with effect from September 1, 2024, to support 1 crore additional eligible beneficiaries in urban areas. PMAY-U 2.0 is implemented through four verticals, i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), Affordable Rental Housing (ARH) and Interest Subsidy

Scheme (ISS)," he said.

Cong approaches CBI for probe into 'irregularities' at Tezpur University

TEZPUR: The Congress Legislature Party in Assam on Monday filed a complaint with the Central Bureau of Investigation (CBI) for initiating a probe against Tezpur University Vice Chancellor Shambhu Nath Singh for his alleged corruption and other forms of irregularities.

The opposition party's student wing NSUI has also lodged a police complaint in Hailakandi district against Singh, who has been absent from the central university since September 22 after a student-led agitation was initiated against him.

The varsity in Sonitpur district of Assam has been under a complete shutdown since November 29, as a joint forum of all stakeholders has demanded removal of the VC and start of an enquiry

"I write this letter in the

interest of transparency, public accountability and protection of public funds, with a request that the Anti-Corruption Bureau/CBI conduct an independent enquiry into multiple allegations of financial, administrative and statutory irregularities that have arisen at Tezpur University over the past several years, the Congress said in its letter to CBI's Guwahati head.

These concerns have been widely circulated in public forums, raised formally by students, faculty bodies and staff associations, and some have also emerged through official institutional mechanisms such as replies to Right to Information applications, said the letter signed by Leader of Opposition Debabrata Saikia and MLAs Nurul Huda and Sibamoni Bora.

"Initiate a thorough, time-bound, impartial inquiry into the alleged financial and administrative irregularities at Tezpur University. Examine procurement records, tender documents, and financial transactions from the past several years," the opposition party urged the CBI. The Congress Legislature

Party (CLP) also requested the central probe agency to verify the RTI-related claim that crucial documents pertaining to the VC's appointment and qualifications are 'not available in the office'.

Punjab: Arms smuggling module linked to Pak-based handler busted: 6 held

CHANDIGARH: The Punjab Police on Monday claimed it has dismantled a cross-border arms smuggling module with links to a Pakistan-based handler and apprehended six persons, including a juvenile.

Police recovered six firearms -- five .30 bore pistols, and one 9mm PX5 pistol -from the accused, Director General of Police (DGP) Gaurav Yadav said.

The accused have been identified as Gurbir Singh alias Sonu, resident of Kotli Vasava Singh village in Tarn Taran; Gurpreet Singh alias Gopa, Gorka Singh alias Gora, and Rajwinder Singh alias Raju -- all residents of Khem Karan in Tarn Taran; Jaspal Singh alias Jass, resident of Bachiwind in Amritsar, and a 16-year-old resident of Sultanpur Lodhi.

Preliminary investigation has revealed that the accused were in direct contact with a Pakistan-based handler through social media platforms, who shared coordinates to retrieve and further supply weapon consign-

The organised gang had been supplying these weapon consignments to criminals operating in the Majha and Doaba regions of the state to carry out nefarious activities.

The DGP said further investigation is in progress to establish the network's backward and forward linkages, and identify

receivers and financial channels in the case. Sharing operational details, Amritsar Police Commissioner Gurpreet Singh Bhullar said the first breakthrough came when a police team, in an intelligence-led operation, arrested suspects Gurbir and Gurpreet and recovered two .30 bore pistols.

Interrogation of the suspects revealed the entire network, he said, adding that follow-up raids led to the arrest of their associates Gorka with a .30 bore pistol, Jaspal with a .30 bore pistol, and Rajwinder with a 9MM PX5 pistol.

A juvenile associate was also detained with a .30 bore pistol, he added.

The commissioner said Gorka and Raiwinder have previous criminal cases registered against them, including Narcotic Drugs and Psychotropic Substances (NDPS) Act violations and charges related to rape and offences under the Protection of Chil-

dren from Sexual Offences (POCSO) Act. Two accomplices from Kapurthala district have been identified as receivers of the illegal weapons, he said, adding that raids are being conducted to nab them.

The Little-Known Story Of How Russia Gave Sonia Gandhi Her Name -And Changed Her Family's Fate

The inability of the Gandhis to meet Russian president Vladimir Putin during his recent visit to New Delhi would likely have upset Sonia Gandhi, too, though for reasons non-political as well. For she, in particular, shares special ties with a country that her husband's family befriended and where her father was once a

Sonia, who turns 79 today, received a special birthday message fourteen years ago from the then Russian President, Dmitry Medvedev (currently Deputy Chairperson of the Security Council of Russia and Putin's foremost champion). "You [Sonia] carry on the Gandhi family's legacy, working consistently to strengthen democracy, further India's social and economic development, and improve the international security system and global order, and these efforts have won you great confidence from your people and much respect and influence around the world," Medvedev wrote in the letter, adding, "Russia values highly your contribution to preserving and building on the longstanding traditions of friendship between our countries and your efforts in taking us to a new level in our relations - that of a privileged strategic partnership." A Letter For A 'Personal Loss' The goodwill went both ways. In 2017, in an unusual gesture, Sonia, as the longest serving president of the Indian National Congress, penned a personal condolence letter grieving the death of ambassador Alexander Kadakin. Describing it as a "personal loss", she wrote, "For me and my family, the passing away of Alexander Kadakin's death is a personal loss. Prime Ministers Indira Gandhi and Rajiv Gandhi held him in high esteem and valued his friendship." The letter was addressed to the then Russian minister-counsellor Anatoly V Kargapolov at the New Delhi-based Russian embassy.

Both diplomatic and political sources in the national capital noticed this unusual gesture by a political party in opposition. "It shows her high personal regard for ambassador Kadakin, who was a personal friend of Rajiv Gandhi," recalled an oldtimer in the Congress. Sonia said she remembered Kadakin for his "large-hearted personality, his deep love for India" and "his ability to strike up a real rapport with a wide cross-section of Indians [which] won him countless friends in our country". "He embodied all the warmth, generosity and steadfastness of the Russian soul," she said, adding, "For him India, where he breathed his last, was truly a second home."

The War Years

Sonia's love for Russia, however, was forged in childhood itself. Her father, Stephano Maino, had been a young man when, during World War II, he slung a rifle on his shoulder and marched into Russia with the invading Italian forces. He was detained in the towns of Vladimir and Suzdal for several years, until three Russian women helped him escape. A grateful Stephano named his daughters after the three benefactors: Sonia, Nadia and Anushka.

In his book, diplomat-turned-politician Natwar Singh recounted a trip to Russia he undertook with Sonia in 2005. According to Singh, who was the External Affairs Minister then, they went to a town called Vladimir by helicopter after official meetings concluded. He was amused by the decision to visit this little-known town. "We [Sonia and Natwar] left for Vladimir town in the afternoon by helicopter. I was at a loss why Sonia Gandhi was visiting an obscure medieval town. Soon, we arrived at an unkempt courtyard, the main building had been a church, now converted into a museum. Inside, we came to an octagonal room. One of the walls were stuck with paper slips. Sonia was much interested in these. She reads Russian and obviously was looking for something. 'Natwar, my father was a prisoner of war here during the World War II. He [Stefano Maino] escaped, walking all the way to Italy'. She was deeply moved. This was for her a very special moment, I listened. Any comment would have been banal and inappropriate," out in early 2013.

PUTIN'S VISIT Wasn't All Fireworks. But It Still Mattered

The biggest visit of the year is now over. Russia President Vladimir Putin, after all, is no ordinary head of state. Few leaders have had an arrest warrant against them from the International Criminal Court; fewer still have held their own against the rest of the West in a dangerously escalatory war. For Delhi, however, he is, primarily, the President of a country that has been steadfast in its support to India for decades. But the visit proved that this is not just about bilateral relations. This is political theatre with an international audience watching. And here's what all this translated into for everyone involved.

That Joint Statement

First, the joint statement itself, which, while being all of 70 paragraphs, mostly just lauded existing cooperation in various areas. Despite excitement around 'massive' defence deals and possibly the purchase of the Su-57, the section on military cooperation is the shortest, though a separate read-out from the meeting between Defence Ministers Rainath Singh and Andrei Belousov seems to have borne fruit.

The main joint statement agreed to 'encourage' joint manufacturing in India of spare parts through transfer of technology and setting up of joint ventures for meeting the needs of the Indian armed forces as well as for subsequent export to mutually friendly countries. Sure, those are not the fireworks that many were expecting. But if this arrangement goes through, it will fill a long-persisting gap for the Indian forces, the army in particular. Though Russia has always been upfront in terms of emergency supplies, the need to get spares made in the country has been felt for a long time. This requires private investment, given the now-reinvented Ordnance Factories are yet to find their feet. Meanwhile, it is as well to remember that there is already a deal in place for the S-400s, of which two more batteries are awaited. Buying more of these will, in all probability, merely require an extension of the existing deal. The interest in Su-57 fighters, on the other hand, has always been uncertain. The Air Force had rejected these years ago for a far larger radar signalling system it has developed indigenously. Besides, given that a trade deal with the US, the largest trading partner, remains impera-



tive, a great defence deal with Russia always seemed a bit improbable.

The Real Issue Of Trade

Fortunately, the longest section is on trade. A country that accounts for only 2% of its trade volume is not the healthiest of relationships. This section lists one significant commitment, "to continue their consultations on enabling the interoperability of the national payment systems, financial messaging systems, as well as central bank digital currency platforms". That's something, given that neither side wants to pile up their currencies with each other. This need to bone up trade is a direct factor driving the discussions with the Eurasian Economic Union on a Free

Trade Agreement. All that is nice. But remember that Russia's own bilateral trade with Armenia, Belarus, Kazakhstan, and Kyrgyzstan is in the low millions. Indian companies would thus much rather target Europe, if they turn to actual manufacturing there. Meanwhile, ventures in consumer goods will benefit from an impressive internet penetration of 92% in Russia and the exit of prominent brands. Meanwhile, the Russian enterprise software sector is growing fast, with domestic solutions falling short of meeting demand. This opens up an opportunity for vendors from friendly countries, especially India, to fill this promising niche. And the beauty of it is that it doesn't need a physical trade route.

Improving Trade Routes

Even so, given the \$59 billion trade deficit between India and Russia, a good route is indeed necessary. There have been many positive reports about the International North-South Transport Corridor (INSTC), which point to a rapid growth in imports through this route. However, this apparent 'rise' has yet to reflect in total figures. That, in turn, will depend heavily on whether Washington lifts its sanctions on Iran or not (a temporary waiver has been in place for Chahbahar, which limits it to trade with only Afghanistan).

Then there is the remaining Chennai-Vladivostok Maritime Corridor, which reduces shipping time between India's East Coast and Russia's Far East from 40 to 24 days. So far, that hasn't really led Indian businesses to increase trade with the Far North, given its sparse population. But there is enough potential for mineral wealth, including rare earths, especially since Moscow has thrown the market open to all. India needs to move quickly to get into this market before the Ukraine war ends and American and European companies troop in. There is also the Northern Sea Route, which ties into a 2024 deal to develop ice-breaker vessels at Mumbai's Mazagaon Docks and other shipyards. Nothing seems to have come of this, too, so far. There is, however, an agreement for 'Training of Specialists' for 'Ships Operating in Polar Waters'. These are highly tricky areas.

But there is potentially more to all of this. The recently ratified Reciprocal Exchange of Logistics Support (RELOS), which will grant Indian naval and commercial vessels access to all Russian ports, all of which lie now towards the Arctic for refuelling and repairs and request Russian icebreaker escorts through icy passages. Russian officials have said that the pact may eventually give India access to more than 40 Russian naval and air bases, all the way from Arctic waters to the Pacific. Sure, that's in the future, but, if materialised, it could certainly make a difference.

Energy Gets Short Shrift

The much awaited 'energy' package is short and to the point, though it rather defiantly, notes 'current and potential' cooperation in the entire range of oil and oil products, including oil refining. Also, notwithstanding a 30% drop in imports of oil from Russia - mostly because profit margins have dropped due in part to use of 'ghost ships' in transport - it seems both sides have an eye to the future. The good news, meanwhile, is that Russia is going to expand nuclear energy in India. The country perhaps has the largest pie of nuclear reactors. India, under its 'Viksit Bharat' vision, aims to generate a total of 100 GW of power from nuclear sources, a tenfold increase from its current capacity of 8.8GW, with the Russian collaboration on the Kudankulam nuclear reactor being just the beginning.

he Warner Bros Drama With Netflix, Paramount Is About to Get Spicier

It was about time the resurgent deal boom threw up a really watchable hostile bid. Just days after Hollywood studio Warner Bros Discovery Inc. agreed to be bought by Netflix Inc., Paramount Skydance Corp has made a \$108 billion offer straight to the iconic Hollywood studio's shareholders. The counterbid has many attractions. It puts Warner on the spot to explain precisely why it didn't engage with the interloper, backed by the billionaire Ellison family, more assiduously when a friendly deal was being attempted. Things were already getting ugly before Monday's dramatic twist, with Paramount complaining to Warner last week about being shut out of the sale process. You can see why Paramount didn't give up: A combination with Warner would produce the world's largest studio with a franchise list that goes on and on - Harry Potter, Barbie, Top Gun... Crucially, the bids aren't directly comparable. Netflix is offering shareholders \$27.75 per share for Warner's studio and streaming assets. That will be paid mostly in cash but also in \$4.50 per share of Netflix stock. Warner's shareholders would also be left stuck with the cable television assets that are soon to be spun off. So in sum, they end up with some cash and two stocks, one of which is yet to be valued by the public markets. Analysts at Barclays Plc reckon the cable business is worth around \$4.20 per share. On their math, the Netflix offer overall is worth around \$32 per Warner share. By contrast, Paramount is offering \$30 a share in cash for the whole of Warner. Chief Executive Officer David Ellison - son of Oracle Corp. founder Larry Ellison reckons this pitch is worth more than Netflix's. That's because he values Warner's cable stub at just \$1 per share. That seems pretty harsh, but the gloves are off now and bad-mouthing in hostile deals can get a good deal worse. Where Paramount is making a clearly superior



proposal is in terms of a speedier and more certain path to completion. Netflix's offer needs heavy discounting for likely antitrust scrutiny, given the sheer scale of the combined streaming platform marrying Netflix with Warner's HBO. President Donald Trump had already sounded caution on Netflix's

enlarged market share. All in all, the Netflix payout looks less certain and further away - and so is worth less in real terms. Ellison's pitch doesn't just pose less serious antitrust concerns. It comes wrapped in a Trumpian bow with financing partly from Affinity Partners, the finance boutique led by the president's son-in-law, Jared Kushner. Combine that with backing from Middle East sovereign wealth funds, and Paramount is mimicking the successful playbook evidenced in the leveraged buyout of Electronic Arts Inc., which involved Silver Management partnering with Affinity and the Saudi Public Investment Fund. As analysts at TD Cowen say, it's very hard to argue that Netflix's offer is better. Time to run the credits? Not so fast. There may be more drama to come.

Paramount would surely prefer to reach

an agreed deal with Warner. There's always value in the less conflictual option. It has already indicated it's ready to sit down and talk. Getting to a handshake would perhaps need a sweetener, providing a pretext for Warner to switch sides -- and contribute to the break fee due to Netflix. But having come so far, it would be surprising if Netflix were ready to abandon such a strategic transaction without a fight. With a \$400 billion market value and prodigious cash flow, it surely has the financial capacity to sweeten or simplify its more fiddly proposal. The continued slide in Netflix stock in response to Paramount's intervention suggests investors are bracing for a costly auction. Paramount looks capable of justifying more stretch. It has indicated higher cost-saving potential, at \$6 billion per annum versus Netflix's \$2.5 billion (likely due to the extra opportunity from keeping Warner's legacy television business). Bloomberg Intelligence reckons a deal at \$35 a share would still stack up for Paramount. Moreover, David Ellison may just want this more. The onus now is as much on Warner boss David Zaslav as it is on Netflix to respond.

'Let everything be good': Shivakumar on Yathindra Siddaramaiah's remarks on K'taka CM post



Bengaluru/Belagavi, Dec 9 : Karnataka Deputy Chief Minister and state Congress President D.K. Shivakumar has reacted to the remarks made by MLC Yathindra Siddaramaiah on the CM post issue, saying that he was very happy and wished for everything to be good. Yathindra Siddaramaiah stated on Monday that Chief Minister Siddaramaiah would complete his full term and that the high command had turned down D.K. Shivakumar's claims to the post. Speaking in Bengaluru before leaving for Belagavi on Tuesday, Shivakumar said, "Very happy. Let everything be good, let it be good for the state," when asked about Yathindra's remarks.

After his arrival at the Sambra Airport in Belagavi to participate in the winter session of the state legislature, his supporters raised slogans in his favour, shouting

"Shivakumar next CM".Party sources said the development was a response to Yathindra's statement made in Belagavi on Monday, asserting that Siddaramaiah would complete his five-year tenure as Chief Minister.

Meanwhile, Congress MLC Channaraj Hattiholi posted a message on social media welcoming the Deputy Chief Minister to Belagavi, referring to him as "Chief Minister D.K. Shivakumar", which drew public attention. Channaraj is the brother of Minister Laxmi Hebbalkar, a close associate of Shivakumar. Speaking to the media on Tuesday, MLC Channaraj said that at a time when both Chief Minister Siddaramaiah and Deputy Chief Minister Shivakumar have stated that they will abide by the high command's decisions, and senior leaders have echoed the same, Yathindra's statement was

'When the high command has said it will take an appropriate decision, we need to wait until then," he added.

Reacting to the developments, Transport Minister Ramalinga Reddy said there was no confusion within the party and that the high command's decisions would be final. When asked why no action was being taken against Yathindra for repeatedly commenting on leadership matters, the minister said leaders must be cautious and responsible when making public statements.It can be recalled, responding to questions about an alleged leadership tussle within the ruling Congress, Yathindra Siddaramaiah said on Monday that those predicting a change in the Chief Minister's position were "dreaming". He said the Congress high command has made it clear that there will be no change in leadership in the state.

Yathindra said, "Deputy Chief Minister D.K. Shivakumar has said he is an aspirant for the CM's post. In response, the high command has clarified that this is not the appropriate time and also made it clear that there will be no change in the

Chief Minister."

He added, "The matter ends there. Hence, there is no tussle anymore. Opposition parties are unnecessarily spreading rumours and creating perceptions." When asked about speculation that CM Siddaramaiah would be asked to resign after the Belagavi session, Yathindra said.


Siddaramaiah seeks PM's nod for immediate Toor Dal MSP procurement

BENGALURU: Karnataka Chief Minister Siddaramaiah on Tuesday urged the union Government to immediately approve Minimum Support Price (MSP) procurement of Toor Dal, warning that procedural delays at the Centre were pushing lakhs of farmers towards distress sales ahead of peak market arrivals.

In a detailed letter addressed to union Government, Siddaramaiah said he was writing with "grave urgency and rising alarm" on behalf of Toor Dal growers whose economic stability was coming under "avoidable and unjustifiable risk" due to delayed approval for procurement.He noted that during the current Kharif season (2025–26). Toor Dal had been sown across nearly 16.80 lakh hectares in Karnataka, with an estimated output of over 12.60 lakh metric tonnes. The crop forms the primary income source for farmers across Kalaburagi, Yadgir, Bidar, Raichur, Vijayapura, Koppal, Belagavi, Ballari, Vijayanagara, Bagalkote, Chikkaballapura Chitradurga.

Siddaramaiah said modal market prices were currently between Rs 5,830 and Rs 6,700 per quintal, significantly below the MSP of about Rs 8,000 per quintal for 2025-26.

While peak arrivals are expected between December 2025 and January 2026, the union Government is scheduled to open procurement centres only in February and March, he said, adding that such delays would

Karnataka farmers were seeking only the rightful enforcement of a price already declared by the Centre, he said. Calling the issue a "moral test" of the nation's commitment to those who ensure food security, Siddaramaiah appealed to the union Government to approve procurement without delay and ensure operational deployment across major procurement centres before peak arrivals begin. "Karnataka's farmers have never failed the nation, even during droughts, floods and economic shocks. The nation must now stand firmly with them in return," he said.

KARNATAKA DECLARES PERMANENT SPECIAL AGRICULTURAL ZONE NEAR DEVANAHALLI, **CLARIFIES NO LAND SALE RESTRICTIONS**

Bengaluru: The Karnataka Government has officially declared 1,777 acres across villages Channarayapatna hobli, Devanahalli taluk, as a Special Permanent Agricultural Zone, reaffirming that farmers retain complete freedom to sell their land without any restrictions.Dr. S. Selvakumar, Principal Secretary, Department of Industries, issued a strong clarification following rumours suggesting that farmers' rights to sell their land had been curtailed. "Any claim that this decision causes hardship to farmers is untrue. We are preventing real-estate misuse, not limiting farmers' freedom," he said.

The region was earlier notified for an Aerospace Park, but after farmers expressed their desire to continue agricultural activities, the Government withdrew the acquisition and reserved the area exclusively for farming. Farmers may still voluntarily sell their land to the Government and will be compensated as per the Price Land Determination Committee's

decision, but they are not obligated to do so.In a meeting chaired by Chief Minister Siddaramaiah, Government decided not only to denotify the land but also to grant it enhanced protection as a Permanent Special Agricultural Zone. Officials assured that the region will receive modern agricultural infrastructure and development support.

Farmers in the zone will benefit from high-yield seeds, cold storage, organic farming support, hydroponics, improved water and soil systems, direct market access, e-trading platforms, tax exemptions for agristartups, faster approvals, and opportunities for agroindustrial investment and exports. Plans also include training centres, labs, foodprocessing units, and expanded banking and credit access.

The Government noted that similar agricultural zones exist in Tamil Nadu, Chhattisgarh, Uttarakhand, Maharashtra, and abroad. A committee will study these models to extend the best benefits to Karnataka's farmers.

Kidwai Performs Complex Bone Marrow Transplant on Child with Single Kidney

Advanced Robotic Technology Enables Complex Double Valve Replacement for 53-Year-Old Woman at Apollo Bengaluru

Bengaluru: Doctors at Apollo Hospitals, Bengaluru, have achieved a major medical milestone by successfully performing a rare and highly complex robotic double valve replacement using the latest-generation Da Vinci Xi Surgical System . This achievement places Apollo among the very few centres in India to execute this procedure in the modern era of advanced robotic cardiac surgery

The procedure was led by Dr. Sathyaki Nambala , renowned cardiac surgeon and Chief of Robotic Cardiac Surgery at Apollo Hospitals, Bengaluru. This landmark surgery marks a significant advancement in bringing complex multivalve replacement into the domain of minimally invasive, robotic-assisted cardiac care in India.

Although robotic double valve replacement was reported in India over a decade ago, those early attempts were limited to first-generation robotic systems. With breakthroughs in robotic technology, high-definition visualization, advanced instrumentation, and refined surgical workflow, Apollo Bengaluru has now reestablished and significantly advanced this demanding procedure using today's most sophisticated robotic platform.

The patient, a 53-year-old woman, presented with severe destruction of both the aortic and mitral valves due to infective endocarditis. She also suffered from multiple comorbidities, including rheumatoid arthritis, obesity, thyroid dysfunction, and a prior stroke, making her a high-risk candidate for conventional open-heart surgery.

Given the complexity, the surgical team opted for a minimally invasive robotic approach using the Da Vinci Xi Surgical System. A simultaneous aortic and mitral valve replacement with bioprosthetic valves was successfully performed under transesophageal echocardiographic (TEE) guidance. The entire surgery was completed through small keyhole incisions, without the need for a midline sternotomy. The patient was extubated and mobilised within 12 hours, transferred to the ward shortly thereaf-



ter, and discharged on the third postoperative day. At her one-week follow-up, she remained asymptomatic and in good health, highlighting the safety, precision, and patient-centric advantages of robotic cardiac surgery even in high-risk cases. Dr. Sathyaki Nambala, National Director, Robotic Cardiac Surgery, Apollo Hospitals said: "This achievement represents a major milestone not

only for Apollo, but for the cardiac surgery community in Asia. While robotic double valve replacement has been attempted in the past, performing it today with next-generation robotic platforms introduces an entirely new level of precision, control, and safety. This evolution has allowed us to reinvent what is possible in complex multi-valve surgery through a truly minimally invasive approach."

Puducherry being 'cold-shouldered' by Centre despite alliance, alleges TVK chief Viiav



CHENNAI: Actor and Tamilaga Kazhagam (TVK) president Vijay on Tuesday accused the BJP-led Union government of repeatedly sidelining the Puducherry administration, while refraining from criticising Chief Minister N. Rangaswamy of the NDA alliance.

meeting at the Uppalam harbour grounds, Vijay praised the Puducherry Chief Minister for providing adequate police protection for the event and said the ruling DMK in Tamil Nadu should take note of it. TVK general secretary N Anand, who hails from Puducherry, had earlier contested unsuccessfully on an AINRC ticket in 2016. Vijay said Puducherry's long-standing demands were being ignored in a manner similar to Tamil Nadu's concerns. "Do not assume I speak only for Tamil Nadu. I am equally committed to raising Puducherry's voice. That is my duty," he said.

Height of realty: Chennai's skyline transforms as vertical living takes over

CHENNAI: Even as cities around the world, including those in India, begin growing skyward, Chennai prefers to stay low, and instead targets its growth outward. Now, however, this penchant for low-rise comfort seems to be fading, and developers initiating new projects are increasingly looking at building highrises for both residential and office spaces.

Arun Bharathi, managing director, GTB Urban Developers, who has spent six years studying models in Dubai and Singapore and also cities in India, says the shift is both necessary and inevitable.

"For Chennai to look beautiful and also retain its green cover, this is the way forward," he says. "Vertical structures can help preserve nearly 30% of land. If the floor space index (FSI) allows more floors, there



is no need to restrict the number of floors. Globally too, governments push vertical development to avoid an uncontrolled concrete sprawl." Commenting on this, real estate veteran Prakash Challa, managing director, SSPDL, says the city's long-pending dream of highrises is taking shape. "Chennai is a coastal city and we get good sea breeze after 2.30 pm. There is better ventilation and views in such apartments," he says.

Some of the prominent highrises that are either coming up finished include Appaswamy's Azure The Oceanic (RA Puram), Malkoha (Guindy-Velachery), ParkHouse Mews (Guindy-Velachery), Brigade's Altius (Sholinganallur), Ceebros's 174 (MRC Nagar), Atlantic (Egmore), Temple Tree (CP Ramaswamy Road), ASTA Arise (Alwarpet), E Residences (Anna Salai), One Crest, (Nungambakkam), Residences (Phoenix Mall-cum-Residence, Velachery), Baashyaam Crown Residences (Koyambedu) and Taj Skyview Residences (Aminjikarai). Among the tallest are SPR City's Highliving District in Perambur with 45+ floors, and House of Hiranandani Upscale in Egattur with its 46-storey towers. Pacifica Aurum Pride Towers (Padur), Casagrand's Flagship (Pallikaranai), First City (Sholinganallur), are pushing heights further across OMR and Guindy.

Though these are dwarfs compared to the skyscrapers across the world that stretch beyond the vision limit, this is a start for the city. "Vertical living," Bharathi insists, "is here to stay and will define the Chennai of the future."

Redevelopment rush

More than a design or lifestyle choice, vertical growth is primarily a matter of feasibility. Given the price of land parcels in the city, it is imperative for builders to increase the height of the structure to ensure that these multi-crore projects are profitable.

IMF APPROVES \$1.2 BN FOR PAKISTAN AS STABIL-ITY EFFORTS ADVANCE

Washington: International Monetary Fund (IMF) approved nearly \$1.2 billion in new financing for Pakistan, giving the country a critical infusion of support as it struggles to maintain macroeconomic stability amid severe flooding, rising inflation, and persistent fiscal pressures. According to an official release, the IMF Executive Board completed the second review of Pakistan's xtended Fund Facility (EFF) and the first review of its Resilience and Facility Sustainability (RSF), unlocking "about US\$1 billion" under the EFF and "about US\$200 million" under the RSF. disbursements under the two arrangements now stand at "about \$3.3 billion." Despite devastating "recent floods," the Fund said Pakistan's "strong program implementation" had helped "maintain stability and improve financing and external condi-

tions." The 37-month EFF,

approved in September 2024, aims to entrench stability, rebuild reserves, broaden the tax base, improve competitiveness, reform state-owned enterprises, and restore energysector viability. Fiscal consolidation has been a key anchor. Pakistan recorded a primary surplus of "1.3 percent of GDP" in FY25, while gross reserves climbed to "\$14.5 billion at end-FY25, up from \$9.4 billion" the previous year. driven partly by floodrelated food price spikes, it said. Nigel Clarke, IMF Deputy Managing Director and Acting Chair, said Pakistan must maintain "prudent policies" to strengthen stability and support "stronger, private sector-led, and sustainmedium-term growth." He called the government's adherence to its FY2026 primary balance target, even while responding to flood relief, "a strong signal of their commitment to build fiscal policy credibility.'



ASCI launches AdWise, a school programme aimed at building advertising literacy among 1 mn kids

Mumbai, December 09, 2025: The Advertising Standards Council of India (ASCI) has rolled out AdWise, a national consumer education programme for school children launched in September, that is set to improve advertising literacy amongst children from Grades 3 to 8 across several cities in India over 15 to 18 months. Under the aegis of ASCI Academy, the programme aims to cover 1 million students in 2,000 schools across India via classroom sessions by the end of 2026. It has already covered more than 1,14,000 students across seven states and 240 schools. It is designed to equip school children with the critical thinking skills needed to identify, question and evaluate advertising messages in an increasingly digital world. ASCI Academy tracks improvement in advertising literacy by measuring the increase in the percentage of students recognising and comprehending ads, differentiating ads from content,



and engagement metrics and feedback quality of students, teachers and parents. The students were assessed before and after the sessions to understand the programme's impact. The program shows significant impact with a 59%-86% increase in students correctly answering questions around advertising literacy in the case of Grades 3-5 and a 57%-95% for grades 6-8. With the tagline 'Smart Kids. Smart Choices', AdWise addresses a crucial gap in digital literacy education. While today's children are digital natives, they often

lack the critical awareness needed to navigate the seamless, subtle and immersive advertising that permeates their online and offline worlds. The programme aims to reduce their vulnerability to misleading and potentially harmful advertisements. Children, an important audience for advertisers, are a key focus area for ASCI. It is currently working on an ethnographic report that examines the relationship that children aged 7 to 15 (Gen Alpha) have with media and advertising, including how they identify, classify and interpret comKapoor, CEO and Secretary General of ASCI, said: "Children today are exposed to advertising in ways that are fundamentally different from previous generations. They don't possess critical cognitive abilities to navigate advertising but they are increasingly being exposed online and in the real world to marketing messages in various forms. With children being an important focus of ASCI, we are equipping them, parents and teachers to critically analyse and understand advertising's influence. Enabling children this way fosters responsible media consumption and creates an informed audience." Australia's world-first social media ban for under-16s comes into effect

Melbourne, is quadriplegic and says social media has given him access to a community of like-minded people. Ezra was diagnosed with Hodgkin's lymphoma, which triggered a rare nerve condition that has paralysed him. "I follow the NBA, Australian rules football, I follow movie accounts and music accounts," he says ahead of the ban coming into effect. "Banning social media will make my world smaller," he tells me via Facebook messenger. Sudan air force bombing of towns, markets and schools has killed hundreds, report says



Sudan's air force has carried out bombings in which at least 1,700 civilians have died in attacks on residential neighbourhoods, markets, schools and camps for displaced people, according to an investigation into air raids in the country's civil war. The Sudan Witness Project says it has compiled the largest known dataset of military airstrikes in the conflict, which began in April 2023. Its analysis indicates that the air force has used unguided bombs in populated

areas. The data focuses on attacks by warplanes, which only the Sudanese Forces (SAF) is capable of operating. Its rival, the paramilitary Rapid Support Forces (RSF) does not have aircraft. It launches strikes, but drones were excluded from the research. The RSF has been internationally condemned for allegedly carrying out ethnic massacres in Sudan's western Darfur region, triggering charges of genocide by the United

Congress ups pressure to release boat strike video with threat to Hegseth's travel budget



US lawmakers are trying to pressure the Trump administration to release video of a controversial "double-tap" military strike by limiting Defence Secretary Pete Hegseth's travel budget. The incident on 2 September, in which the US carried out a second deadly strike on a boat in the Caribbean, has raised fresh questions about the legality of Trump's campaign targeting alleged drug-carrying vessels. A provision buried in a lengthy defence spending policy would restrict travel funds for Hegseth's office until the Pentagon hands over unedited footage.

The bill is expected to pass with support from both parties. US President Donald Trump says release of the video is something for Hegseth to decide. Trump denied that he had previously said he would have "no problem" with the footage being made public - despite that comment being made on camera as recently as Wednesday. The threat from Congress to withhold

money from Hegseth's travel budget has emerged amid a clamour for information from lawmakers on both sides of the political aisle. It is buried within a 3.000-page draft bill that is focused on approving next year's defence spending. The annual bill authorises nearly \$901bn in funding (£687m). The bill's final wording, which was first reported by Politico, states that Hegseth's office may spend no more than three-quarters of the funds made available for travel for the year 2026 until it meets certain requirements. These include an obligation to give the House and Senate armed service committees all "unedited video of strikes conducted against designated terrorist organizations in the area of responsibility of the United States Southern Command".

The wording nods to the way Trump has characterised his strikes on boats in the Caribbean and Pacific. He says they are a matter of targeting designated terrorist organisations

WHY ARE THAILAND AND CAMBODIA FIGHTING AT THE BORDER?

Simmering between Thailand Cambodia have once again exploded along their shared border, derailing a fragile ceasefire backed by US President Donald Trump. At least three Thai soldiers and seven Cambodian civilians have been killed since Monday, with the countries accusing one another of starting the violence. The clashes, which have also seen Thailand launch airstrikes along the border, are the most serious since the ceasefire was agreed in July. What is the border dispute about? This is not a recent dispute. The argument between Thailand and Cambodia dates back more



than a century, when the borders of the two nations were drawn after the French occupation of Cambodia. Hostilities escalated in 2008, when Cambodia tried to register an 11th Century temple located in the disputed area as a Unesco World Heritage Site. The move was met with

heated protest from Thailand. Over the years there have been sporadic clashes, with soldiers and civilians killed on both sides. The latest tensions ramped up in May, after a Cambodian soldier was killed in a clash. This plunged relations between

the countries to their lowest point in more than a decade. In the run up to the first bout of fighting in July, both nations had imposed border restrictions. Cambodia banned imports from Thailand, including fruit and vegetables, power supplies and internet services. Both countries had also strengthened troop presence along the border in recent weeks. Why have border tensions flared up again in December? The two sides have given differing versions of what happened. On Monday 8 December, the Thai army said its troops had responded to Cambodian fire in Thailand's

Ratchathani Province.

EU investigates Google over AI-generated summaries in search results

The EU has opened an investigation into Google over its artificial intelligence (AI) summaries which appear above search results. The European Commission said it would examine whether the firm used data from websites to provide this service - and if it failed to offer "appropriate compensation" to publishers. It is also investigating how YouTube videos may have been used to improve its broader AI systems, and whether content creators were able to optout. A Google spokesperson said the probe "risks stifling innovation in a market that is more competitive than ever". "Europeans deserve to benefit from the latest tech-



nologies and we will continue to work closely with the news and creative industries as they transition to the AI era," they said. The EU's investigation will also cover Google's AI Mode, which gives people an answer in a conversational style with some links to other pages.

It is in addition to the tech giant's existing search platform - providing an experience similar to its rivals such as ChatGPT. What is AI and how does it work? Google's introduction of its AI Overview summaries was met with concerns it could result in fewer visitors to websites. Without

people clicking on web pages, sites generate less money from advertising. The Daily Mail previously claimed the number of people who clicked its links from Google search results fell by around 50% since Google introduced its AI Overview feature. The Commission said it was concerned both web publishers and YouTube video creators were not being compensated or given the opportunity to opt-out of their content being used to train the company's AI models. Ed Newton-Rex from AI fairness campaigners Fairly Trained said it was "career suicide" for people to not publish their work on YouTube or online.

Tanzania crackdown on planned protest leaves streets deserted

Security has been tightened across Tanzania with police and military seen patrolling major cities ahead of anticipatanti-government protests called to coincide with independence day. By midday local time (09:00 GMT), however, no demonstrations had begun. Residents in Dar es Salaam, Arusha, Mbeya, Mwanza and several other urban centres reported an unusually slow start to the day, with many people choosing to remain indoors amid uncertainty over whether protests would happen. The demonstrations were called to demand political reforms in the wake of October's

post-election which left an unknown number of people dead. The authorities have admitted using force against protesters, claiming that some groups were attempting to overthrow the regime. On Tuesday, BBC reporters observed nearly empty streets in the commercial capital, Dar es Salaam. This was a stark contrast to the city's usual weekday bustle. Although quiet, the atmosphere remained tense. In a statement, police spokesperson David Misime assured the public of their safety and the protection of their property, saying the situation remained calm nationwide.




