RBI buys bonds worth Rs 50,000 cr to inject more liquidity into banking system



MUMBAI: The Reserve Bank of India (RBI) on Wednesday bought government bonds worth Rs 50,000 crore from the market in order to infuse more liquidity in the banking system to spur growth in the economy. The purchase is part of the RBI's monetary policy

announcement last week to inject Rs 1 lakh crore in the market via the purchase of government securities and another \$5 billion equivalent via a foreign exchange swap facility. The RBI has been selling US dollars in the market to prevent the rupee from going into a free fall, which has resulted in a lot of cash being sucked out of the banking system, which also tends to lead to an increase in interest rates in the market.

## Army mounts rescue after truck plunges into gorge, 21 missing

Itanagar/New Delhi, Dec 11: The Indian Army on Thursday launched a large-scale search and rescue operation in the high-altitude Chaglagam region of Arunachal Pradesh after a truck carrying 22 workers from Tinsukia fell off a cliff along the Hayuliang-Chaglagam road, officials said. The accident, believed to have occurred on the night of December 8 near KM 40, came to light only late on December 10



when the lone survivor managed to reach the Chipra GREF Camp and alerted authorities.

According to preliminary inputs provided by the survivor, the vehicle veered off the treacherous mountain road and

plunged nearly 200

metres into a dense, inaccessible forested gorge. The site, about 12 km short of Chaglagam, lies in a remote stretch with minimal connectivity.

Notably, no information about the missing workers had been reported by any local agency, contractor, or civil representative until the survivor's arrival, prompting immediate mobilisation

of rescue resources. On December 11, the Indian Army's Spear Corps deployed multiple search and rescue columns along with medical teams, GREF personnel, local police, NDRF members and the Additional Deputy Commissioner (ADC) of Hayuliang. "At 1155 hours, after four hours of intensive search and rope descent, the truck was spotted around 200 metres below the road near KM 40 in a reentrant, inaccessible and not visible from helicopters or the road due to dense tree cover and

thick foliage.

Speaking as the chief guest, the Deputy CM said that this two-day seminar should not remain just an academic gathering but must ignite new ideas and inspire fresh perspectives. He emphasized the need for stronger collaboration among institutions, promotion of interdisciplinary research, and positioning Telangana at the forefront of numismatics and heritage-based studies. He stated that the Telangana Government is fully committed to supporting heritage research. Under the leadership of Tourism & Excise Minister Jupally Krishna Rao, the State aims to build a robust hub for scientific research, cultural conservation, and knowledge production. Highlighting the unparalleled legacy of Southern India's coinage, the Deputy CM said the region holds one of the world's richest and most diverse traditions of coinage. From the Satavahanas and the Ikshvakus-who expanded their trade networks through coin-based systems to the Kakatiyas and the Vijayanagara Empire, the coins of this region stand as symbols of innovation, aesthetics, and refined governance. Coins have their own language, he said. They reveal intricate details about taxation, minting technology, trade routes, socio-political priorities, and economic structures of different eras. Studying coins, he noted, is not merely the study of metal but the study of ideas. Calling this seminar a historic milestone, he said that for the first time in the 114-year history of the Heritage, Archaeology & Museums Department, a national-level seminar dedicated solely to coins has been organised-making this a moment of pride for Telangana and for both Telugu States. Elaborating on the depth of numismatic research, the Deputy CM described coins as "com-

pressed data" from ancient times.

## 1st indigenous hydrogen fuel cell passenger vessel begins service in Varanasi

ing Tharoor, should accept



New Delhi, Dec 11: The government on Thursday flagged off the commercial operation of the country's first fully indigenous hydrogen fuel cell passenger vessel at Namo Ghat, Varanasi, marking a major step in its green maritime push.

The vessel is the first in India to demonstrate hydrogen fuel cell propulsion in a maritime setting and features fully indigenous technology. It operates on a 'Low

Temperature Exchange Membrane' fuel cell system that converts stored hydrogen into electricity, releasing only water as a byproduct.

Designed as a 24-meter catamaran for urban transit, the boat can carry 50 passengers in an air-conditioned cabin and runs at a service speed of 6.5 knots.Its hybrid energy system combines hydrogen fuel cells, batteries and solar power,

enabling up to eight hours of operation on a single hydrogen fill. The vessel is certified by the Indian Register of Shipping.

Union Minister for Ports, Shipping and Waterways, Sarbananda Sonowal, said that under the dynamic and visionary leadership of Prime Minister Narendra Modi, India is witnessing a transformative shift toward clean, sustainable and self-reliant transportation systems."The launch of our first indigenous hydrogen fuel cell vessel is a shining example of the Prime Minister's commitment to 'Make in India' and the transition to green mobility across all sectors. This milestone also strengthens the wider mission of rejuvenating and preserving our sacred Ganga," said the minister. ## Delhi's air quality slips further, edges close to 'very poor' mark again

New Delhi, Dec 11 : Delhi's air quality remained lodged in the poor category for the third straight day on Thursday morning, though the overall air quality index (AQI) slipped further to 285, just below the 301 threshold that pushes conditions into the very poor bracket, data from the Central Pollution Control Board (CPCB) showed.

As of 7 a.m., at least ten monitoring stations across the city registered AQI levels above 300, placing them in the very poor range. At Anand Vihar, the AQI stood at 300, Ashok Vihar 328, Chandni Chowk 305, and ITO 309.

Noida's overall AQI was recorded at 294 (Poor), and sector-wise AQI ranged from 246 to 331, while Greater Noida's Knowledge Parks 3 and 5 recorded AQI levels of 235 and 331, respectively. The city's 24-hour average AQI on

Wednesday stood at 259, showing a slight improvement from Tuesday's reading of 282. After nine consecutive days of air quality dipping into the very poor zone, the capital recorded some relief on Tuesday, and due to



daytime winds on Wednesday, conditions managed to remain within the poor category for the second day in a row. ## Luthra Brothers To Be Deported: How Is It Different From Extradition?

The Luthra brothers - who fled to Thailand while their Goa nightclub,

'Birch by Romeo Lane', burned down last week, killing 25 people - have been detained in that country, sources told NDTV Thursday. Sources said this morning that a Goa Police team will leave for Thailand in 24-36 hours in anticipation of the Thai government deporting Saurabh and Gaurav Luthra, who should be back in India shortly. They fled India on a Saturday morning IndiGo flight to Phuket; initial inquiries indicate tickets were bought from aggregator MakeMvTrip at 1.17 am. as firefighters were battling the blaze. Located swiftly – photographs emerged of Gaurav Luthra at Phuket airport - they have since asked a Delhi court for protection from arrest, arguing they cannot face criminal liability as they were not present when the fire broke. They also sought four weeks' transit anticipatory bail, which was refused. Meanwhile, the government has also suspended the brothers' passports, meaning they cannot leave Thailand - with whom India has an extradition treaty - even if they were free to do so. Luthra brothers: deportation or extradition? India and Thailand signed an extradition treaty in 2013, under the terms of which Bangkok is obliged to send the Luthra brothers back if the charges they face carry a minimum jail term of a year. The main (at this time) charge Saurabh and Gaurav Luthra face is culpable homicide not amounting to murder, which carries a minimum sentence of five years. That satisfies the main operational criteria of the 2013 treaty. Therefore, one option is to activate relevant provisions of the treaty. But typically this involves a formal request and proving 'double criminality', i.e., present evidence to a Thai court that says the accused is guilty of a crime punishable by both Indian and Thai laws. And this could take time. Also, attempts to extradite other wanted individuals Nirav Modi and Vijay Mallya from the United Kingdom, Mehul Choksi from Belgium, and Dawood Ibrahim from Pakistan - have rumbled on for years. So, can they be deported? Yes, and that is most likely what will happen. Deportation and extradition are not the same thing, though in both cases a state ejects a foreigner. In the former case a host country, India, for example, can remove foreigners living illegally in its territories. In the latter, as in this case, for instance, India would have to prove to the Thai authorities that its nationals - the Luthra brothers committed acts viewed as criminal by both governments. The difference is in the legal minutiae. Deportation is typically an immigration measure; i.e., a country exercises its sovereign power to remove a foreign national. This typically happens when a foreigner violates the laws of the host country. And have the Luthra brothers broken Thai laws? Yes, although not by their own actions. Suspension of their passports means Saurabh and Gaurav Luthra are in Phuket without valid travel documents, which is an offence under Thailand's immigration laws. They can, therefore, be removed as 'undocumented foreigners', which will likely be a quicker route back to India to face trial. Goa nightclub fire Meanwhile, the investigation so far has uncovered a number of worrying details, including the widespread of use of flammable material, the lack of fire exits, and the absence of fire extinguishers. Also, the club did not have a broad-enough entrance for fire-fighting vehicles to approach the main structure; firefighters said they had to park 400 metres away, which complicated rescue efforts and may have led to some of the deaths. Investigators also found the club did not have a fire safety clearance.

# India-Russia Relations and the **Changing Global Equations**



Ukraine War, Western Sanctions, and a New Test of Indian Strategic Autonomy India's relations with Russia have been built on a strong foundation of strategic partnership, defense cooperation, and political trust for decades. From the Cold War era to the present, Russia has been one of the few countries that supported India's interests even in difficult times. However, the Russia-Ukraine war that began in 2022 has transformed global politics, energy markets, financial structures, and strategic alliances, bringing India-Russia relations to a new turning point. Strict Western sanctions have not only impacted Russia's economy and defense production capabilities, but have also created unprecedented diplomatic challenges for partners like India. While the United States, Europe, and Indo-Pacific partners expect India to adhere to Western norms, India cannot ignore Russia's energy, defense, and international balance needs. India faces a crucial test at this crossroads: how to maintain relations with Russia while firmly establishing its strategic autonomy. The biggest complication today is that Russia appears to be gradually moving closer to China, and this equation is not entirely favorable from the perspective of India's interests. Russia's growing economic, technological, and military cooperation with China is affecting the regional balance within which India formulates its security strategy. India knows that China's intentions are not limited to Asian dominance, but rather to alter the balance power. Consequently, the Russia-China proximity complicates India's strategic calculations. Western sanctions are no less challenging for India. Defense imports from Russia and critical spare parts are being slowed by Western sanctions. Many of the kev systems India's Air Force and

Army rely on are Russian-made or co-produced with Russia. The pressure on the Russian defense industry due to the Ukraine war has made India concerned about the timelines of several military projects. Delays in the delivery of some weapon systems and missiles also reflect this. This situation forces India to diversify its defense sources in the long term and focus more on domestic production. Meanwhile, trade imbalances have emerged as a serious aspect of India-Russia relations. A sharp increase in crude oil imports has made India's trade with Russia lopsided. India's exports to Russia are extremely low, and the payments system has clearly not stabilized. The rupee-ruble trading system has failed to achieve the desired efficiency due to Western sanctions and international banking regulations. This has increased uncertainty and risk in the trade structures between the two countries. On the other hand, Western countries also want India to reduce its support for Russia and adopt a "moral" stance on the Ukraine issue. However, India's foreign policy is based more on national interests than on shared morality. India has repeatedly abstained from voting at the United Nations, making it clear that it will not directly support any side. This balanced stance symbolizes India's strategic autonomy. However, it has received mixed reactions in Western countries. Some call it India's "pragmatic diplomacy," while others see it as "excessive sym-

challenge of having both Russia and the United States as important partners. The United States is India's largest technological and economic partner today, and also an integral part of the Asia-Pacific security architecture through the Quad Russia, meanwhile, is a traditional ally and has been a key pillar of India's defense structure for decades. Maintaining a balance between these two pillars is a complex but essential task for India's diplomacy. India must demonstrate that both partnerships offer complementary benefits, not contradictions.

India can adopt several diplomatic strategies to maintain this difficult balance. First, it must accelerate the implementation of "Make in India" and "Atmanirbhar Bharat" by reducing its dependence on defense imports. Joint production and technical cooperation with Russia can be expanded on Indian soil, reducing dependence on direct imports and minimizing the impact of sanctions. Additionally, India must strengthen new defense partnerships with countries such as Europe, the United States, France, and Israel, Another important step would be for India to diversify its trade with Russia in energy, agriculture, pharmaceuticals, IT, and other non-defense sectors. This would reduce the trade imbalance and stabilize the economies of both countries. Third, India needs to develop a reliable and sanctions-proof payment system. Using BRICS, SCO, and alternative these pressures. India also faces the India must maintain a trustworthy global identity.

dialogue with Russia, while also conveying to Western countries that India's neutrality is a result of responsible strategic thinking. India has previously demonstrated that it can protect its interests without joining any bloc. Today's global situation demands a more mature and multifaceted approach from India. Amid all these changes, it is crucial that India protect its national interests and not follow any superpower. India has always supported a multipolar world order, in which no single power dominates. While maintaining relations with Russia, India must maintain a clear independent foreign policy direction—one that neither makes decisions under pressure nor takes unnecessary sides in any conflict. Ultimately, India-Russia relations stand at a historic juncture. The Ukrainian conflict, the politics of sanctions, and changing alliance structures have made this relationship challenging, but they also hold opportunities. India must recognize that Russia is not just a defense partner, but a partner with whom energy security, international balance, and many aspects of Asian politics are intertwined. Similarly, the West is an essential partner in India's rise. Therefore, India's goal should not be to align itself with any one pole, but to choose a path of balance that strengthens its strategic autonomy, economic stability, and global role. This is the time for India to use its diplomatic skills, cool reasoning and determination to pathy" for Russia. # FDA Delays Approval for Eli Lilly's Experimental Alzheimer's Treatment

The approval of Eli experimental Lilly's Alzheimer's medication donanemab will be delayed beyond the end of the month, the drugmaker announced on March 8. The Food and Drug Administration (FDA) reversed its fast-track approval of the drug and will call a meeting of outside advisors to review its safety and efficacy. Eli Lilly said it had expected the FDA to approve the drug by the end of the first

quarter of this year, which had already been pushed back from an expected earlier approval of sometime last year. If approved, donanemab would become the second drug shown to slow the progression of Alzheimer's disease (AD), a degenerative brain disease affecting more than 6 million Americans. Last July, the FDA approvedTrusted Source a similar drug, lecanemab (Leqembi), from Japanese drugmaker Eisai and Massachusetts-based drugmaker

Both drugs are monoclonal antibodies, given as IV infusions, that target the buildup in the brain of plaques caused by the clumping together of the betaamyloid proteinTrusted Source. Dr. Howard FillitTrusted Source, co-founder and chief science officer of the Discovery Alzheimer's Drug Foundation, said in a statement that the FDA's decision is not a "setback," but is a sign that the FDA is "doing its due diligence" to ensure the safety and efficacy of donanemab. "The decision to hold an advisory committee before granting approval follows the regulatory process that was used for the other drugs in this class, including Leqembi,"

Why was donanemab rejected?

Lilly said the FDA advisory committee will discuss the results of its phase 3 clinical trial, published in JAMATrusted Source in July 2023. The trial, called Trailblazer-Alz 2, tested the efficacy and safety of donanemab in people with early symptomatic Alzheimer's.

As with the Leqembi trial, participants in the donanemab trial took cognitive assessments and underwent brain scans to measure the level of beta-amy-



loid plaques. The FDA will also look at the donanemab study's "unique trial design." Lilly said. This includes allowing participants to stop treatment when scans showed that the beta-amyloid plaques had been cleared from the brain. In contrast, the clinical trial for Legembi had no designated stopping point. "A big question about this [aspect of the trial] is how it might be implemented in realworld practice. Do we stop medication in patients? Do we have to repeat PET scans?" said Dr. James Galvin, founding director of the Comprehensive Center for Brain Health and professor of both neurology and psychiatry and behavioral sciences at the University of Miami Miller School of Medicine in Florida. Another unique aspect Lilly's trial is that it measured the level in the brain of a protein called tauTrusted Source, which collects inside neurons in people with Alzheimer's disease. "Clinically, we have no good way of measuring this,' Galvin told Healthline. "So again, how might this be implemented in practice?"

The clinical trialTrusted Source for donanemab, which included more than 1,300 participants with early symptomatic Alzheimer's disease, separated participants based on the level of tau. Among participants with "low or medium" levels of tau, people who received donanemab had a 35% slower decline in the ability to think clearly and perform daily activities, compared to those receiving an inactive placebo. When researchers also included people with high levels of tau — which suggests they are further along in the course of the disease — the benefit of donanemab

What is the success rate of donanem-

compared to placebo was 22%. In addition, 47% of people who received the drug showed no decline on a test of disease severity after one year, compared to 29% among people in the placebo group. In addition, 47% of people in the "low or medium" tau group who received the drug showed no decline on a test of disease severity after one year, compared to 29% among people in the placebo group.

Is donanemab safe? The main safety concerns of donanemab are brain swelling (edema) and micro-bleeding (hemorrhages), both known as amyloid-related imaging abnormalities, or ARIA.

In the clinical trial, among people receiving donanemab, micro-bleeding occurred in 31.4% and brain swelling in 24%. ARIA usually does not cause symptoms, the company said in a release, but it can be serious and life-threatening. In the trial, three people died from a serious case of ARIA. The rate of ARIA was lower in the clinical trial for Legembi, but the drug has been linked to patient deaths as well. "The seemingly higher rate of ARIA with donanemab compared to lecanemab is of concern and requires further scrutiny [by the FDA] that, in the long run, will serve to benefit current and future generations of patients with Alzheimer's disease," Dr. Seyed Sajjadi, a neurologist at UCI Health in California, told Healthline. These side effects are serious enough to raise concerns among experts about whether these drugs are worth the risks.

"[Some] clinical neurologists continue to not use this family of medications, as they have not significantly improved patient's memory loss in the drug trials, and have caused severe cerebral edema and intracranial bleeding," Dr. Clifford Segil, a neurologist at Providence Saint John's Health Center in Santa Monica, CA, told Healthline. When will donanemab be approved?

The date for the FDA advisory meeting has not been set, Lilly said in its news release. The FDA generally, but not always, follows the advice of its advisory committees.

## **Cancer-Causing Chemical Benzene Found** in Common Acne Products



ccording to Bunick, it's been known for over 100 vears that benzoyl peroxide can break down into benzene. High temperatures accelerate this process.

In one of Valisure's testing experiments storing one commonly-used acne product at 158°F — which is roughly the temperature of a hot compact car — for nearly 17 hours produced levels of benzene gas 1,270 times greater than the threshold the the Environmental Protection Agency (EPA) associates with an increased risk of cancer from long-term inhalation exposure.

Another test, in which the acne

products were stored at 104°F which is roughly the temperature of a hot bathroom — the concentration of benzene reached four times the EPA's threshold for an increased risk of cancer from long-term benzene inhalation. The concerning effect was not observed in acne products that were not made with benzoyl peroxide, including those containing salicylic acid or adapalene, according to the report. The takeaway: Any skincare products made with benzoyl peroxide that have been stored in a car or bathroom should be discarded, Bunick advises."At the current moment, there is not a proven way to stabilize or store benzoyl peroxide-containing products," says Bunick. That said, cold temperatures can delay the breakdown of benzoyl peroxide into benzene, he noted. "I believe, at the moment, the best middle ground for patients who wish to continue benzoyl peroxide products is to always store them in the refrigerator," Bunick said.

## Not Getting Enough Sleep May Increase Your Type 2 Diabetes Risk

People who sleep less than six hours a night are at considerably higher risk for type 2 diabetes than those who sleep seven to eight hours a night, a new study foundTrusted Source. And even those with habitual short sleep who follow a healthy dietary regimen carry that risk, suggesting that sleep is a vital element in type 2 diabetes prevention. The study was published March 5 in JAMA Network Open.

The study followed nearly 250,000 adults in the UK between May and

September of 2023. The mean age of the participants was 55.9 years old, and the group had varying dietary habits ranging from "red meat, processed meat, fruits, vegetables, and fish, resulting in a healthy diet score ranging from 0 (unhealthiest) to 5

Type 2 diabetes is defined by a buildup of glucose levels when the body cannot react to insulin effectively or is unable to produce enough of it. Treatment for type 2 diabetes most commonly involves careful

monitoring of blood sugar levels and medications like metformin or sulfonylureas. Additionally, diet, weight management, and exercise are part of a broader approach to treating the condition. According to the Centers Disease Control PreventionTrusted Source, about 38 million Americans (one in 10, on average) have diabetes, and up to 95% of them have type 2 diabetes. # Trump launches \$1m 'gold card' immigration visas

has launched a scheme offering fast-tracked US visas to wealthy foreigners who can pay at least \$1m (£750,000). The card will give buyers a "direct path to Citizenship for all qualified and vetted people. SO EXCITING! Our American Companies can finally keep their invaluable Talent," Trump said on media Wednesday. The Trump Gold Card, which was first announced earlier this year, is a US visa awarded to those who can demonstrate they will provide a "substantial benefit" to the country, according to the scheme's official website. It comes as Washington intensifies its immigration crackdown, including raising work visa fees and deportundocumented migrants. The Gold Card scheme promises US residency in "record time" and will require a \$1m fee

United States", the programme's website said. Businesses sponsoring employees are required to pay \$2m, along with additional fees. A "platinum" version of the card that offers special tax breaks will also be available soon for \$5m, the website said. Extra fees to the government may be charged depending on each applicant's circumstances, the site said. Individuals are

also required to pay a non-refundable \$15,000 processing fee before application is reviewed. The gold card scheme has faced criticism since it was first announced in February, with some Democrats saying that it would unfairly favour wealthy individuals. When Trump first unveiled the plan he described the visas as similar to green cards, which allow immigrants of various income levels to live and work permanently in the US. Green card holders typically become eligible for citizenship after five years. But the Gold Card is aimed specifically at "high-level" professionals, Trump said, emphasising, "we want people that are productive". "The people that can pay \$5m, they're going to create

jobs," Trump said. "It's going to sell like crazy. It's a bargain." The scheme comes as the Trump administration has devoted significant resources to deporting immigrants. The US has also paused immigration applications by individuals from the 19 countries, mostly in Africa and in the Middle East, which are subject to the president's travel ban. The government has also halted all decisions on asylum applications and said it would review thousands of cases that were approved under administration President Joe Biden. In September, Trump also signed an order to charge a \$100,000 fee for applicants of the H-1B visa programme for skilled foreign workers. The decision caused panic among overseas student in the US and technology firms. The White House later clarified that the fee would apply only to new applicants who are currently abroad.

## Mexico approves up to 50% tariffs on China and other countries

Mexican lawmakers have approved a package of new tariffs, impacting hundreds of products, many of which come from China. The measures, which President Claudia Sheinbaum has said are needed to boost domestic production, were passed by the Mexican Senate on Wednesday. The levies are set to take effect on 1 January 2026 and will apply to goods like metals, cars, clothing and appliances. Dozens of countries that do not have a free trade agreement with Mexico will be affected, including Thailand, India and Indonesia. The move comes as Mexico is in negotiations with the US over steep import taxes that President Donald Trump has threatened to impose on the country. The measures will impose tariffs of up to 50% on more than 1,400 products. The levies will "substantially harm the interests of trading partners, including China," said a spokesperson for Beijing's commerce ministry on Thursday. An investigation into Mexico's trade policy is in progress, they added, urging the country to "correct" its decision. This week, China also signalled its plans for more



involvement with Latin American and Caribbean countries, as it aims to deepen its relationships in the region through trade and innovation. Chinese companies have been expanding their footprint in Mexico in recent years, with car brands like BYD and MG establishing operations in the country. But Washington has said Beijing may be using Mexico as a way to bypass US tariffs. The BBC has contacted the embassies in Mexico of Thailand, India and Indonesia for comment. Sheinbaum's government is in talks with the Trump administration as it tries to reduce tariffs on the country. They include 50% duties on Mexican steel and aluminium. Trump has also threatened to impose

extra tariffs on Mexico for various reasons, including a 25% levy as part of Washington's measures to pressure countries to do more to stop the flow of the synthetic opioid fentanyl into America. On Monday, Trump threatened to impose a new 5% tariff on Mexico, accusing it of violating an agreement that gives American farmers access to water. "It is very unfair to our US Farmers who deserve this much needed water," he posted on social media. Trump was referring to a more than 80-year-old treaty that grants the US water from Rio Grande tributaries. For decades the US has accused Mexico of not meeting the terms of the agreement. The US is Mexico's largest trading partner.

## **BIG TECH BETS BIG ON AI - BUT CAN INDIA** KEEP PACE IN THE GLOBAL RACE?

This week, tech giants Amazon and Microsoft pledged an eye-popping \$50bn-plus combined investment in India, putting artificial intelligence (AI) in the spotlight. Microsoft's Satya Nadella announced his company's largest investment ever in Asia \$17.5bn (£13.14bn) - "to help build the infrastructure, skills, and sovereign capabilities needed for India's AI-first future". Amazon followed suit, and said it was putting in more than \$35bn in the country by 2030, with an unspecified chunk of that investment going into boosting AI capabilities. The announcements come at a particularly interesting juncture. As fears of an AI bubble swept global markets and tech stock valuations soared, several leading brokerages took a contrarian view on India's AI landscape. Christopher Wood of Jefferies said the country's stocks were a "reverse AI trade". That basically means India should outperform other markets in the world "if the AI trade suddenly unwinds" - or simply put, the global bubble bursts. HSBC also held a similar view, saying Indian equities offered a "hedge and diversification" for those uneasy with the ongoing AI rally. This comes as Mumbai stocks have lagged behind their Asian peers over the past year, with foreign investors moving billions



into Korean and Taiwanese AI-driven tech companies in the absence of comparable opportunities in India. In this backdrop, the Amazon and Microsoft investments provide a much-needed fillip - yet it remains worth asking where India truly stands in the global AI race. There are no easy answers. The adoption of AI in India has been rapid. Investments into some parts of the value chain - such as data centres, the physical backbone of AI, or chipmaking facilities - have begun trickling in. Just this week, American chipmaker Intel announced a collaboration with Mumbai-based Tata Electronics to manufacture chips

locally. But when it comes to a sovereign AI model, it appears India is continuing to play catch-up. About a yearand-a-half ago, the Indian government launched an AI mission through which it began supplying start-ups, universities and researchers with high-end computing chips to develop a large homegrown AI model like OpenAI or China's DeepSeek. According to the federal electronics ministry, the launch of the sovereign model - which supports more than 22 languages - is imminent. In the interim though, the likes of DeepSeek and OpenAI have made further advances, launching newer variants. While the

government has recognised the need to reduce over-dependence on foreign platforms because of the risk of surveillance and sanctions, India's \$1.25bn sovereign mission is a shadow of France's \$117bn or Saudi Arabia's \$100bn programmes. The country's ambitions also face numerous other hurdles - from semiconductor availability to skilled talent and fragmented data ecosystems, according to global consultancy EY. India currently lacks enough computational infrastructure or the billions of dollars of research and development (R&D) investment made over decades that gave China and the US a distinct leg up. Despite its global strength in AI talent, India struggles to keep its developers at home. "The current tightening of overseas work visas provides India a window of opportunity to retain domestic talent and attract Indian-origin talent at home. However, given that top-tier AI talent is mobile globally, attractive policy incentives need to be put in place to incentivise relocation to India," the EY report says. China, for example, offers a range of incentives such as "financial support and subsidies, tax incentives and funding for research and development, special talent visas and fast-track immigration", the report says.

# More than 30 dead after Myanmar military air strike hits hospital

At least 34 people have died and dozens more are injured after air strikes from Myanmar's military hit a hospital in the country's west on Wednesday night, according to ground sources. The hospital is located in Mrauk-U town in Rakhine state, an area controlled by the Arakan Army - one of the strongest ethnic armies fighting the country's military regime. Thousands have died and millions have been displaced since the military seized power in a coup in 2021 and triggered a civil war. In recent months, the military has intensified air strikes to take back territory from ethnic armies. It has also deployed paragliders to drop bombs its enemies. The Myanmar military has not commented on the strikes, which come as



the country prepares to vote later this month in its first election since the coup. However, pro-military accounts on Telegram claim the strikes this week were not aimed at civilians. Khaing Thukha, a spokesperson for the Arakan Army, told the BBC that most of the casu-

alties were patients at the hospital. "This is the latest vicious attack by the terrorist military targeting civilian places," he said, adding that the military "must take responsibility" for bombing civilians. The Arakan Army health department said the strike, which occurred at around 21:00

(14:30 GMT), killed 10 patients on the spot and injured many others. Photos believed to be from the scene have been circulating on social media showing missing roofs across parts of the building complex, broken hospital beds and debris strewn across the ground. The junta has been locked



## 'Architects of AI' named Time Magazine's Person of the Year



Time Magazine's Person of the Year for 2025 is not a single person. Instead, the magazine has recognised the year's most influential figure as "the architects" of artificial intelligence (AI). Nvidia boss Jensen Huang, Meta head Mark Zuckerberg, Xowner Elon Musk and AI "godmother" Fei-Fei Li are among those depicted on one of the magazine's two covers. Experts say it highlights how quickly AI, and the firms behind it, are reshaping society. It comes as a boom in the technology, ushered in by OpenAI's launch of ChatGPT in late 2022, con-

tinues at pace. Its boss Sam Altman said in September its chatbot is used by around 800 million people every week. Big tech firms are pouring billions of dollars into AI and the infrastructure behind it in a bid to stay ahead of rivals. There are two covers this year - one a piece of art depicting the letters AI surrounded by workers, and another a painting focused on the tech leaders themselves. At Meta, Zuckerberg has reportedly focused the firm around the tech, including its AI chatbot, which it has embedded in its popular apps.

A senior military official told the BBC's US partner CBS that the helicopters used in the operation launched from the USS Gerald Ford, the world's largest aircraft carrier, which was sent to the Caribbean last month.

# Venezuelan Nobel winner tells she knows 'risks' of Oslo trip after months in hiding

Venezuelan leader María Corina Machado, who has been in hiding for months, has told the BBC that she knows "exactly the risks" she's taking by travelling to Norway to collect her Nobel Peace Prize. Machado appeared in Oslo in the middle of the night, waving from the balcony of a hotel. It was the first time she has been seen in public since January. The 58-year-old made the covert journey despite a travel ban and a threat from the Venezuelan government that she would be labelled as a fugitive. In an emotional moment, Machado waved to cheering supporters who had gath-



ered outside the Norwegian capital's Grand Hotel, blowing them kisses and singing with them. To their delight, she then came outside and greeted them in person, climbing over the security barricades to get closer. "Maria!" "Maria!" they shouted, holding their

phones aloft to record the historic moment. The Nobel Institute awarded Machado the prize this year for "her struggle to achieve a just and peaceful transition from dictatorship to democracy" in Venezuela. Earlier on Wednesday, her daughter, Ana Corina Sosa,

accepted the Nobel Peace Prize on her mother's behalf. Until Wednesday night, the mother of three had not seen her children in about two years, having sent them away from Venezuela for their own safety. In an interview with the BBC's Lucy Hockings after her balcony appearance, Machado said she had missed their graduations, and the weddings of her daughter and one of her sons. "For over 16 months I haven't been able to hug or touch anyone," she said. "Suddenly in the matter of a few hours I've been able to see the people I love the most, and touch them and cry and pray together."

## AUSTRIA BANS HEAD-SCARVES IN SCHOOLS FOR UNDER-14S



Austria has passed a law banning headscarves in schools for girls under the age of 14. The conservative-led coalition of three centrist parties, the ÖVP, the SPÖ and the Neos, says the law is a "clear commitment to gender equality", but critics say it will fuel anti-Muslim feeling in the country and could be unconstitutional. The measure will apply to girls in both public and private schools. In 2020, a similar headscarf ban for girls under 10 was struck down by Constitutional Court, because it specifically targeted Muslims. The terms of the new law mean girls under 14 will be forbidden from wearing "traditional Muslim" head coverings such as hijabs or burkas. If a student violates the ban, they must have a series of discussions with school authorities and their legal guardians. If there are repeated violations, the child and youth welfare agency must be noti-

fied. As a last resort, fam-





## Gautam Gambhir Calls ODI Batting Orders "Over-Rated", AB de Villiers' Reply Can't Be Missed

India head coach Gautam Gambhir backed his philosophy of deploying a floating batting order in ODI cricket, with the positions not being fixed, especially in the middle order. Gambhir remains determined to continue with the same approach, even if certain ODIs haven't gone India's way because of this philosophy. AB de Villiers, one of the greatest batters in the history of the game, isn't entirely in disagreement with Gambhir's approach, but has cautioned him against crossing the 'fine line'. "I do agree with him to a certain extent. I've always enjoyed a floating batting lineup in ODIs. But it's a fine line because you can't really play around too much with the players' roles. It's the top three, four to six, and then your tailenders who can hold the bat. It's almost like three segments, and you can really be creative with that. Play with right and lefthand combinations and certain situations of the game," De Villiers said about Gambhir's statement on his



YouTube channel.

De Villiers was particularly impressed by India's consistency in T20 format, where Gambhir has adopted the same floating batting order philosophy. "It has been incredible, especially for a T20 format. It's the most volatile format of the three, and to have that kind of consistency tells you there must be something going on that's heading in the right direction. I think it's got to do with the depth of Indian cricket," said De Villiers. Gambhir's remarks about floating bat-

ting orders in white-ball cricket came after India sealed a 2-1 ODI series win against South Africa, Barring the opening combination, the India head coach doesn't think any batter needs to play in a specific position. "I think in a one-day format, you should know the template that you want to play with. I've always believed that in white-ball cricket, batting orders are very overrated, except the opening combination," said Gambhir after India beat South Africa 2-1 in the ODI series.


