

NIA chargesheets LeT, TRF in **Pahalgam** terror case

NEW DELHI: The National Investigation Agency (NIA) on Monday filed a chargesheet naming seven accused in connection with the April 22 terror attack in Pahalgam, which claimed the lives of 26 people, most of them tourists.

The chargesheet includes the banned terror outfits Lashkar-e-Taiba (LeT) and The Resistance Front (TRF) along with a Pakistani handler, detailing Pakistan's role and conspiracy behind the attack. According to the NIA, the 1,597-page chargesheet was filed before the special NIA court in Jammu and lays out the roles of the accused, the larger terror conspiracy, and the evidence collected during the probe.

Father and three daughters found dead by apparent mass suicide

PATNA: In a deeply distressing incident that has sent shockwaves through the community, a man and his three young daughters were found dead in an apparent mass suicide in Muzaffarpur district, Bihar.

The tragedy unfolded on Sunday night in Ward Number Four of Mishraulia village, located within the Sakra police station jurisdiction. The deceased were identified as the father, Amarnath Ram, and his three daughters: Radha Kumari (11), Radhika (9), and Shivani (7). The father's wife had reportedly passed away approximately a year ago.

Two PILs filed in Calcutta HC on Messi event chaos in Kolkata

KOLKATA (TSIT): Two public interest litigations (PILs) were filed at a division bench of the Calcutta High Court on Monday regarding the lapses in management at Salt Lake Stadium in Kolkata on December 13 during an event featuring football star Lionel Messi

S.P. Balasubrahmanyam's statue unveiled in Hyderabad amid row

HYDERABAD (TSIT): Amid a controversy, the statue of legendary singer S.P. Balasubrahmanyam was unveiled on Monday at Ravindra Bharathi, a state-run auditorium and cultural centre in the heart of Hyderabad, the state capital of Telangana. Ignoring the protest by some activists of the Telangana statehood movement, authorities went ahead with the unveiling of the statue of SPB, as the late singer was popularly known. Former Vice-President

M. Venkaiah Naidu, Telangana Minister for Information Technology and Industries Duddilla Sridhar Babu, former Governor Haryana Bandaru Dattatreya, BJP's Telangana unit President Ramchander Rao, singer S.P. Shailaja and family members of SPB attended the event. Tight security arrangements were made for the event in view of the protest by a section of Telangana activists. They opposed the installation of SPB's statue on the ground that he had allegedly refused to sing a Telangana song in 2004.

The singer, who was born in the present-day



Andhra Pradesh, had allegedly refused to sing 'Jaya Jayahe Telangana' penned by poet Andesri.

The song was last year declared the state song of Telangana. President of the Telangana Kranti Dal and a Telangana statehood Sangamreddy activist, Prithviraj, and writer and activist Pasham Yadagiri demanded

Telangana government not to install the statue of SPB and instead reserve this honour for cultural icons born in Telangana. Telangana Jagruthi leader K. Kavitha had also backed the Telangana activists. She said that Ravindra Bharathi must be reserved for Telangana folk artists. The 7.2-feet bronze statue of SPB was

especially prepared in East Godavari district of Andhra Pradesh. Speaking at the event, Minister Telangana Sridhar Babu said that SPB left an indelible and enduring imprint on the history of Indian film music.He described SPB as an artiste who transcended linguistic and cultural boundaries. He recalled that SPB had rendered more than 40,000 songs in 14 Indian languages, demonstrating the universal appeal of music.

"With more than 40,000 songs in 14 Indian languages, his voice carried emotion and life, staying ever-fresh across generations and securing a timeless place in people's hearts," he said.

Sridhar Babu said that even as generations change, SPB's songs continue to retain their freshness and emotional resonance, touching the hearts of Telugu audiences and music lovers across the country. The Minister noted that SPB was not only an unparalleled playback singer but also a versatile actor, music composer and dub-

AP seeks Centre's support for AI-powered Skill Census

AMARAVATI (TSIT): Andhra Pradesh Minister for Education, IT Electronics, Nara Lokesh. on Monday sought the Centre's support for rolling out an AI-powered Skill Census Andhra Pradesh.

Sarpanch post died just minutes before polling began at 7 a.m. D. Nagaraju, who was contesting from Anasagar village in Nelkonapalli mandal, reportedly succumbed to stress related to the election campaign. Family members said he fell ill on Saturday night and was admitted to a hospital, where he passed away early Sunday morning. In a separate incident in Ranga Reddy district, a voter collapsed and died shortly after casting his vote.

India very close to sealing interim trade deal with US: Top official

NEW DELHI (TSIT): Commerce Secretary Rajesh Agrawal said on Monday that India is "very close" to concluding an interim trade deal with the US to bring down tariffs, but stopped short of fixing any timeline on the issue.



"We are very close on closing the initial framework deal, but I don't want to put a timeline to it," the Commerce Secretary told journalists here. "We have done six rounds of talks with the US, where we have discussed both the BTA (bilateral trade agreement) as well as an interim deal to lower reciprocal tariffs. There's a fair expectation that both countries will be able to agree to a deal to lower reciprocal tariffs," he said."The visit of Deputy USTR was to take a stock of our trade relations and to see where we are on the BTA as well as the framework deal," Agrawal said.

US Trade Representative (USTR) Jamieson Greer also said recently that the US has received the "bestever offers from India" on the proposed trade agreement. Speaking at a Senate Appropriations Subcommittee hearing in Washington, Greer said that there is resistance in India to certain row crops (corn, soybean, wheat, and cotton) being exported to its market from the US.

Priyanka Gandhi denies objectionable slogans against PM Modi on stage

NEW DELHI (TSIT): Reacting to the controversy over objectionable slogans raised against Prime Minister Narendra Modi at a Congress rally, Priyanka Gandhi Vadra on Monday clarified that no such remarks were made by any-

one present on the stage. The controversy erupted after the Congress party's "Vote Chor, Gaddi Chhod" rally, held at Ramlila Maidan in Delhi on Sunday. Several videos showed Congress workers raising provocative slogans such as "Modi teri kabar while heading towards the rally venue, drawing sharp criticism from the BJP. Speaking to reporters outside Parliament, Priyanka Gandhi dismissed the allegations and questioned the BJP's intent in raising the issue during the parliamentary session.

'We were discussing who actually said this. No one on the stage said anything like that. Later, we came to know that someone from the crowd or a worker may have made such a statement, but it is still not clear who it was," she said. She further questioned why the matter was being



repeatedly raised

Parliament. "Why is this being discussed in the House? It appears they themselves do not want the session to function. Then why raise such issues during Question Hour? I do not think they want to run the session. We wanted a debate on pollution, but they are not allowing that. If they do not want Parliament to function, they should close it, and at least pollution will be reduced," she added.

Congress MP Saptagiri Sankar Ulaka also reacted, saying that he was present at the programme for its entire duration and did not hear any

such slogans.

"Thousands of people had come, including a large number from Odisha. Nearly five to six lakh people attended the rally from across the country. We did not hear any objectionable slogans, and no one from our side raised them," he said. Congress MP Pramod Tiwari also distanced the party from the slogans.

"The Congress party did not say anything personally, so how can we respond to it? On the other hand. Prime Minister Narendra Modi has often used harsh language against our leaders, which should also be taken into account. It has become a habit for him to use such language," he added. Congress MP Vivek Tankha said he was unaware of any such slogans being raised.

"I had not heard about it. If such slogans were raised, I am not aware of them. I would never want any wrong slogans to be raised against any leader," he said. Congress MP Mallu Ravi added that while some individuals may have raised slogans, none of the party's leaders were involved.

Messi lands in Delhi for final stop of his G.O.A.T Tour

NEW DELHI (TSIT): Argentine football legend Lionel Messi arrived in New Delhi on Monday afternoon for the final stop of his G.O.A.T. Tour, after a weather-related delay postponed his flight.

Messi was scheduled to land in the national capital earlier this morning, but his charter flight was delayed due to foggy conditions here. He immediately proceeded to the Leela Palace Hotel, where



he will have a meet-and-greet session for around an hour with a select group of people.

Messi's schedule in the national capital includes an exhibition match, a stage event, a football clinic for children, and several highprofile private meetings; therefore, Delhi has implemented precautionary measures to manage large crowds and traffic congestion in anticipation of his arrival.



Deve Gowda in RS highlights irregularities in voters' list during Nehru, Indira Gandhi tenures

Winter Session of Parliament, the Rajya Sabha continued its discussion on electoral reforms on Monday, with senior JD(S) leader and former Prime Minister H.D. Deve Gowda (92) strongly defending Prime Minister Narendra Modi against opposition allegations of irregularities in voters' lists -- which they call "vote chori".

Former PM Gowda pointed out that lapses in the electoral process have occurred historically, including during the eras of Jawaharlal Nehru and Indira Gandhi. He referenced a specific case of alleged inclusion of 18,000 votes in Kerala during Indira Gandhi's period.

"Even during Nehru's time, there were certain lapses in the electoral system. Such irregularities are not new," Gowda said, emphasising that issues have arisen under various governments, including Congress-led ones. Referring to recent controversies, including those in Bihar where opposition parties raised concerns

A City Without Water Is A Harbinger Of A Thirsty Planet

The history of our cities has been written in water.

In Mesopotamia, Egypt and the Indus valley, the first urban settlements were built around irrigated farmland. Flooded terrace fields for rice, corn and quinoa accompanied the spread of civilization in East Asia and the Americas. Without water, the megacities that will define the 21st century would wither and perish. That's looking like a risk factor in an increasing number of locations. Cape Town and Chennai in recent years endured punishing droughts that left them on the brink of crisis. Similar conditions afflicted the upwardly-mobile Indian cities of Bengaluru and Hyderabad last year. Now Tehran (biggest of all, with about 15 million people) is facing the same emergency.

Residents of Iran's capital are having their taps turned off for hours at a time to ration usage, amid a five-year drought and rainfall that's been running at 96 per cent below average levels. The city may have to be evacuated altogether if a current dry spell doesn't break soon, President Masoud Pezeshkian said last month. That underlines a grim fact of modern life: Even relatively affluent and sophisticated cities might be just a few dry years away from "day zero" — the point where life-giving water supplies run out.

Tehran's desperate situation has its origins in the same mania for food and energy security that's causing many nations to raise trade and regulatory barriers to clean power right now. A commitment to food self-sufficiency following the 1979 Iranian revolution — spurning imports of nutritional energy in favor of homegrown wheat and rice — has drained aquifers and reservoirs to feed thirsty crops. More than 90% of water goes to agriculture, leaving precious little left over for the needs of urbanites. That might be excusable given the widespread sanctions that have crippled Iran's economy for decades, but it's been accompanied by wasteful usage, too. Per-capita water resources are greater than in Germany, India or South Korea, so should be sufficient to supply most of Iran's needs, if they were well managed. That's not what's happened. Flood irrigation, an ancient practice that wastes immense amounts of H2O through evaporation when compared to drip irrigation that uses pipes, is still the predominant method of watering fields.

Tariffs and subsidies mean trade with more productive countries is fragile. China and India are the biggest producers of grain, and also major participants in the barter-style oil trade that gets around international sanctions on Tehran. China, however, barely exports food to Iran, while India's basmati farmers have to contend with occasional import bans imposed whenever the Iranian government wants to prop up its local growers.

Comments from energy minister Abbas Aliabadi earlier this month supporting the import of "virtual water" — thirsty crops that should be produced in countries with more abundant rainfall — are a rare official admission that the drive to self-sufficiency is failing, and more food is going to need to come in from overseas. This crisis is a sign of a planet whose cycles are increasingly slipping out of balance. While a shortage of water is crippling Iran, on the other side of the Indian Ocean an excess from monsoonal rains has caused \$20 billion of flood damages from Sri Lanka to Vietnam. Both situations would have been unlikely without the effects of climate change. Whereas Iran can now expect a drought like that of 2025 every 10 years, in a pre-warming world it would have happened as rarely as once a century. As the world's sixth-biggest emitter and one of the largest exporters of oil, it bears much of the responsibility for the warming now making Tehran unlivable. It's not alone. Many of the countries hit by the recent Asian floods could find their current conditions flipping to Tehran-style droughts in future. In a 2020 study of 12 megacities in developing countries at risk of water shortages, the city ranks relatively low.

India's Exclusion From US' Pax Silica Club Isn't A Snub - But It Matters

The Netherlands controls specialised chipmaking machines that are extremely hard to replace. Singapore is a global hub port and a major semiconductor production node. Australia brings critical minerals depth. And the UK, Israel and the UAE add supply-chain security focus, security-tech innovation, and capital-plus-energy ambition for AI infrastructure. It is a carefully chosen group covering the early links of the tech supply chain, from minerals and chipmaking to shipping and financing. When key parts of a supply chain sit inside one club, trade stops being just business. It starts depending on trust and keys to the warehouse, everyone else has to follow their entry



At the same time, coalitions like this are not just power plays. They can help partners coordinate standards, reduce singlepoint dependencies, and build resilience against shocks.

Missing The Point

India is not part of the initial grouping. Some see this as a snub. Others say it does not matter. Both reactions miss the point. The issue is not optics. It is whether India is moving fast enough up the chokepoint ladder to be treated as a partner rather than a customer.

But it is equally important to be clear that India is not outside the semiconductor ecosystem. For chip design, India is already a critical node. It is home to nearly 20% of the world's chip design engineers, with numerous firms running global capability centres. That is why global chip firms keep designing in India even when geopolitics shifts. You cannot shift thousands of engineers and years of know-how overnight.

India's Strengths

India is also building traction in areas where it can become relevant sooner than many assume. Ten projects across six states have been approved, spanning everything from OSAT - outmembership. Think of it like this. sourced assembly and testing - to sequence, not the prize. India joined in June 2023. The point is When a small group holds the advanced packaging. These are not glamorous, but they are key chokepoints in modern hard- sought, is negotiated from ware. If design is the brain, pack-

aging and testing are what make the brain usable in the real world. India can add what this club lacks at scale, design talent and back-end capacity that reduces concentration risk.

This progress is no longer hypothetical. India's design base and back-end push are real. But dismissing Pax Silica as background noise would be a strategic mistake.

The Inner Circle

The real risk is geopolitical. Supply-chain coalitions can become tools of power. Access becomes conditional unless you are in the trusted circle. In a crisis, insiders get protected first and everyone else discovers that markets do not override politics. Rules get written inside smaller groups, while outsiders end up complying with frameworks they did not shape. In the real world, that can mean delays, extra paperwork, higher costs, and uncertainty at the worst possible time. India is particularly exposed because it is both a huge future market and a big capability base. In supply-chain politics, markets get courted, but capability nodes get seats. Pax Silica is a reminder that India must become more of the second and less of the first. Capability is the priority. Membership is the conladder so that entry, when it is strength.

Latecomer's Advantage

The fastest strategic payoff for India over the next two to three years comes from moving up in two upstream areas. First, critical minerals processing and recycling. India has already approved a ?1,500 crore incentive scheme and issued operational guidelines in October 2025. The geopolitical value is simple. Processing and recycling create leverage fast. They also make India useful to any coalition looking to diversify away from single-country dominance. The more India can process at home, the less it has to worry about sudden bottlenecks elsewhere. Second, in a Pax Silica world, packaging is a practical way to become indispensable without pretending that India can leapfrog the most advanced fab ecosystems. Sanand in Gujarat is emerging as an OSAT cluster, and India should accelerate the wider packaging ecosystem that makes such cluscompetitive. Diplomatically, India should

engage with Pax Silica as a capability contributor, not as a latecomer seeking exceptions. Late entry is not a failure if your leverage is higher. There is a precedent. The Minerals Security Partnership was formed in June 2022, and India needs to climb the chokepoint simple. Build capability now, and India can join later on terms that strengthen autonomy, not shrink it.

Child safety and technological solutionism: Discussing social media restrictions in the digital age Australia proposes a complete ban on social media for children under sixteen. Privacy threats, practical failures, and neglect of underlying psychosocial factors. Rights-based protections through the Digital Personal Data Protection Act, 2023. Parental consent, child monitoring, and restrictions on targeted advertising. Balance the law, digital literacy, family engagement, and platform accountability. In the digital age, the lives of children and adolescents are no longer limited to the physical world. Social media, online platforms, and virtual communities have become a crucial part of their learning, expression, identity, and social connections. At this time, the question of how to ensure the safety of children on these platforms naturally arises. Australia's recent proposal to completely ban social media for children under the age of sixteen stems from this concern. However, this move has also faced criticism as an overly simplistic, technology-based solution to a complex psychosocial problem, a move that has been termed "technological solutionism." Technological solutionism implies the assumption that social, cultural, and psychological problems can be solved solely through technological rules, restrictions, or tools. This

approach appears particularly limited in the context of children, as children's mental health, self-esteem, social comparison, online harassment, loneliness, and behavioral changes are not resolved simply by blocking access to a platform. These problems are deeply intertwined with family, school, peer groups, social environments, and broader cultural trends. Australia's proposal appears focused on outright prohibition rather than addressing these complex causes. According to Australia's proposed law. social media use would be restricted for children under the age of sixteen and mandatory age verification would be implemented. While this measure appears to be drastic and decisive for the safety of children, its practical implications are questionable. Age verification could require the collection of extensive personal information, posing a threat to the privacy of children and their parents. Furthermore, technological measures can be easily circumvented through virtual private networks, fake identities, or new, less regulated platforms. This not only undermines the effectiveness of the law but could also expose children to more risky digital spaces. Another serious aspect of a complete ban is that it could deprive children of the positive opportunities that

social media offers. Today, many children access educational content, participate in creative activities, learn about social issues, and connect with mental health support groups through these platforms. For children, especially those in rural, disadvantaged, or socially marginalized communities, digital platforms are often their only means of expression and collaboration. A complete ban could further deepen social inequalities. This approach also suggests that the root of the problem lies with children or technology, when in reality, the problem lies with the social framework within which children are digitally socialized. India has adopted a different and relatively balanced approach in this regard. The Digital Personal Data Protection Act, 2023, proposes a rights-based and datacentric approach to protecting children. rather than outright prohibition. The Act recognizes that isolating children from the digital world is neither possible nor desirable. Instead, it is essential to hold digital platforms accountable and protect children's rights. The law mandates verified parental consent for the processing of children's personal data, strengthening the role of the family.

An important aspect of the Digital Personal Data Protection Act is that it explicitly prohibits behavioral tracking, personality-based categorization, and targeted advertising of children. This seeks to protect children from exploitation as consumers.

Furthermore, the Act provides children with rights such as access to, correction of, deletion of data, and filing of complaints. This approach is an important step towards viewing children as citizens with rights, rather than merely objects of protection. Additionally, India has established an independent Data Protection Board, which can impose penalties for violations. This ensures accountability for platforms and data processing entities, without requiring children to be excluded from digital platforms. This model also demonstrates that legislation, along with social awareness, digital literacy, online safety education in schools, and the expansion of mental health services, are essential. Ensuring child safety cannot be achieved through legislation alone; it requires a holistic societal effort. Comparing the approaches of Australia and India reveals that while on the one hand there is a policy based on control and prohibition, on the other, there is a framework based on balance, participation, and empowerment.

Usha Chilukuri Vance: The Hindu Republican America Can't Quite Define

America keeps trying to squeeze Usha Vance into a box that was never made for her. Democrats write long, anguished essays about how a vegetarian Hindu who once clerked for the Chief Justice of the US Supreme Court must be dying inside next to MAGA. The extreme-right online crowd crop her out of photographs, call her "the diversity hire", or mutter that a "pagan" now lives in the official residence of the Vice President (that residence, for Indian readers, is the elegant old Naval Observatory mansion in Washington DC - roughly the American equivalent of 7 Lok Kalyan Marg for the number-two leader.) Both camps are wasting their breath. The woman they want to rescue or expel has spent her whole life quietly doing things her own way. She grew up Usha Chilukuri in the orderly San Diego suburb of Rancho Peñasquitos, daughter of Telugu academics from Andhra Pradesh. Vegetarian home, Ganesh Chaturthi pujas, parents who treated anything below Stanford as gentle failure. She played clarinet in the marching band, led the school history club, graduated Yale summa cum laude in history, picked up a master's at Cambridge on a Gates scholarship, then returned to Yale Law. Somewhere along the way, she took one of those silly internet quizzes, discovered she was an "Order Muppet", posted the result on Facebook, and accidentally gave the world the most accurate nickname she will ever have. That nickname explains why she and JD Vance made sense. They met in 2010 in Amy Chua's small section at Yale Law. Professor Chua paired the tattooed Marine veteran from the Ohio rust belt with the professor's daughter from San Diego to co-lead a reading group on working-class decline. Chua later laughed that they were opposites in every dimension except raw intelligence and terrifying ambition. 'Thank You For Saving Me' JD fell first and hardest. In Hillbilly Elegy, he is almost painfully honest about it. Before Usha, his romantic history had been "a



wreckage of bad decisions and worse breakups". On their first proper date he talked for hours about addiction, screaming matches, and children who had never seen a stable home. She listened without flinching, then emailed him a ten-page memo analysing the sociology of Scots-Irish family breakdown. He proposed within months, convinced she would eventually realise she could do better. He still ends every anniversary card the same way: "Thank you for saving me." He credits her with teaching him which fork to use at New Haven faculty dinners, and how to stop himself leaping out of the car in road-rage fury. Without her, he writes, there is no law degree, no bestseller, no Senate seat, no Vice Presidency. Politics arrived like a storm neither of them invited. She was a registered Democrat until roughly the year they married. Old friends remember her calling January 6, 2021 "deeply disturbing" and Trump's behaviour that day "reprehensible" - language her husband himself had used in 2016 when he labelled Trump "America's Hitler" and voted for Evan McMullin. Yet, when JD performed his now-famous pirouette and embraced Trump, Usha did not stage a public crisis. The day after Trump picked him for VP in July 2024,

she simply resigned from her elite California law firm. No press release. Her name and photograph vanished from the website overnight. Since then, she has spoken only when protocol demands it. Her four-minute convention speech introducing JD was warm, self-deprecating and completely free of ideology. She has worn Kanjeevaram silk to state dinners and Levi's to Ohio county fairs. She prepped JD for the vice-presidential debate against Tim Walz and, by all accounts, outworked the entire team. When a Fox interviewer asked what she hoped to accomplish as Second Lady, she smiled and said, "Honestly, I would just like to be a normal person for my kids." Usha Isn't Performing The noise around her is deafening and revealing. Nick Fuentes spent inauguration week asking why America has a "pagan" in the Vice President's official home. JD fed the fire at Ole Miss in early 2025 when he told a chanting Christian crowd he hoped one day Usha would accept the Gospel. He walked it back within hours, insisting she has no plans to convert, but the clip is immortal. Liberal columnists keep publishing tear-stained think-pieces about the prisoner in the mansion. Everyone is performing. She is not.

New Delhi, Dec 15: Amid the leadership crisis in the Karnataka Congress party, Deputy Chief Minister and the party's state President D.K. Shivakumar has said that he will be meeting the party's high command separately. While answering a question on whether he will seek separate meetings with Rahul Gandhi and Sonia Gandhi, he stated on Monday in Delhi, "All these things will be there within the party." When further asked whether this was important at this juncture, Shivakumar

replied, "Don't worry."

He further said, "I need to meet AICC President Mallikarjun Kharge, AICC General Secretary and MP K.C. Venugopal, and others. I have already met Rahul Gandhi and Sonia Gandhi during lunch yesterday. I have met everyone." He stated, "Mallikarjun Kharge ji and I need to go together to Karnataka to attend the funeral of veteran Congress leader Shamanur Shivashankarappa. We were supposed to leave Delhi by 8 a.m., but due to cloud cover, the

travel has been postponed."

On responding to the notice issued by the Delhi Police in the National Herald case, Shivakumar said, "Since there is urgency (funeral of Congress leader Shamanur Shivashankarappa), I have been asking them for time. I am seeking time to appear before them after the session. I will also release my reply to the media because they have not attached a copy of the FIR with the notice. We have already given our response to the Enforcement Directorate. I have not received the contents of the FIR and have only information through media reports." "I will seek a copy of the FIR, and next week, after the winter Assembly session, I will come to Delhi," he added.

It can be recalled that the leadership tussle between Chief Minister Siddaramaiah and Deputy Chief Minister Shivakumar has come to the forefront after party MLA from Ramanagara, Iqbal Hussain, a staunch supporter of Shivakumar, claimed that Shivakumar would assume the post of Chief Minister on January 6, 2026.

The statement has caused ripples in state political circles and within the ruling Congress party.

"The post of Chief Minister should be handed over to Deputy CM Shivakumar. He must be given an opportunity. The high command is responding positively to this demand. There are chances of Shivakumar becoming the Chief Minister on January 6. I am 99 per cent sure about this," Hussain had stated. Responding Hussain's Shivakumar said that no one should believe his words.

350–400 Metric Tonnes of RDF Collected Daily Across GBA Limits: CEO Kari Gowda



Bengaluru: With the objective of effective solid waste management in Bengaluru city, the Bengaluru Solid Waste Management Limited (BSWML), a parastatal agency under the Greater Bengaluru Authority (GBA), has undertaken extensive Information, Education and Communication (IEC) programmes to create public

awareness. As a result of

these initiatives, segregation of waste at source has significantly improved, leading to a notable increase in the collection of low-value plastic waste, also known as Refuse Derived Fuel (RDF). This marks a major achievement in the city's solid waste management efforts.

At present, approximately 350 to 400 metric tonnes of Refuse Derived Fuel (RDF) are being col-

lected every day. Around 100-150 metric tonnes of RDF is being transported to the waste-to-energy plant near Bidadi.

An agreement has been entered into to transport 200-250 metric tonnes of RDF to M/s Dalmia Cement Limited, located neighbouring Kadapa district. On the first day of operations today (15.12.2025), a total of 160 metric tonnes of RDF is being dispatched.

As per the agreement, M/s Dalmia Cement Limited has committed to accept up to 1,000 metric tonnes per day of low-value plastic waste (RDF) from BSWML. Under this arrangement, M/s Dalmia Cement Limited will provide Extended Producer Responsibility (EPR) credits generated through the process to Bengaluru Solid Waste Management Limited. resulting in financial benefits to the organisation.

Commence Development Works at Mahatma Gandhi Park Immediately: N. A. Harris

Bengaluru: BDA Chairman and Shantinagar MLA N. A. Harris on Monday directed officials to immediately commence redevelopment works at Mahatma Gandhi Park in the Shantinagar division under the Bengaluru Central City Corporation. AIADMK ex-minister Vijayabaskar flags staff shortage in government hospitals

CHENNAI: Former Health Minister and AIADMK organising secretary C Vijayabaskar on Sunday condemned the DMK government for failing to fill vacancies in government hospitals across Tamil Nadu.

Terming Health Minister Ma Subramanian's claim that all posts in the Public Health Department had been filled "completely false", he said it was aimed at covering up what he described as the collapse of the healthcare system under the DMK regime.

He alleged that there was an acute shortage of doctors, nurses, medical officers, pharmacists, laboratory technicians and health workers across the State, from Primary Health Centres to Government Medical College Hospitals. Vijayabaskar further claimed that several government hospitals constructed at a cost of crores of rupees in districts such as Krishnagiri, Namakkal, Theni, Tiruchy and Cuddalore remained nonfunctional.Vijayabaskar said that while the Health Minister claimed there were no vacancies, the government had simultaneously called for applications to fill 1,100 doctor

in Tamil Nadu, one of Asia's largest poultry hubs, climbed to a new all-time high of Rs 6.25 per egg on Monday, according to the National Egg Coordination Committee The revised rate was con-

firmed by K Singaraj, Chairman of the NECC, Namakkal Zone. The latest increase marks the culmination of a steady upward trend that began last month.

Egg prices first touched the Rs 6 mark on November 17, a historic milestone for the Namakkal poultry sector.



This was followed by a further rise to Rs 6.10 on November 21. Significantly, the price then remained unchanged at Rs 6.10 for 22 consecutive days until December 12, making it one of the longest periods of stability ever recorded at such a high level. The upward momentum resumed thereafter, with the farm-gate price revised to Rs 6.15 on December 13 and

December 14. The latest hike to Rs 6.25 from December 15 has now set a new benchmark for egg prices in the region. NECC office-bearers attributed the sustained rise in

prices to a combination of seasonal and market-driven factors. Demand for eggs typically increases during the winter months, and consumption has risen further with the onset of the Christmas and New Year festive season. In addition, the improved movement of eggs to markets in North India and steady export demand have provided strong support to prices.

Guchchhi: The Himalayan Mushroom That Defines Luxury and Inequality

Food, it is said, is fuel — fuel that energises human beings, driving them forward in their daily toil. A right mix of the basics — fats, carbohydrates and proteins - forms a balanced diet, sufficient for anybody, anywhere in the world. But evolution and affluence have played their part, shaping our palates with a spectrum of flavours, textures and rarities. What we eat is no longer just about sustenance; it is about identity, status and, sometimes, sheer indulgence.

Some foods remain humble, feeding the masses. Others, however, ascend into the rarefied realms of luxury, reserved for those who can afford their exorbitant price tags. From glistening pearls of caviar to the silky allure of the finest chocolates, from blue fin tuna sashimi to truffle-infused risottos - certain delicacies whisper of exclusivity. Among them is one of the most elusive and expensive mushrooms: guchchhi (Morchella esculanta) or morel mushroom, nature's clandestine bounty, hiding in the misty folds of the Himalayas.

Guchchhi is a fugitive of the fungal world, defying human attempts at cultivation. It does not sprout from orderly beds in climate-controlled greenhouses, nor does it submit to the predictable rhythms of agriculture. Instead, it emerges unbidden, its wrinkled, honeycomblike caps pushing through the damp leaf litter of the Himalayan forests.

This enigmatic mushroom is found at elevations between 2.500m and 3,500m, thriving in the temperate forests of Himachal Pradesh, Uttarakhand and Kashmir; born of snow, raised by deodars. Its preferred companions are the mighty deodar cedars, the very trees that give these forests their ethereal, cathedral-like silence. Guchchhi thrives in soil enriched by decaying wood, growing in scattered clusters after winters



of heavy snowfall. As spring awakens the highlands, melting snow seeps into the earth, triggering the miraculous, almost mystical, emergence of these mushrooms.

Their life cycle is as secretive as their habitat. The spores, invisible to the naked eye, remain dormant in the forest floor, awaiting the perfect confluence of moisture, temperature, and organic decay. Unlike their domesticated fungal cousins — button mushrooms or oyster mushrooms — guchchhis refuse to be tamed. No scientific breakthrough has yet succeeded in their artificial cultivation, ensuring that every guchchhi ever savoured has been foraged from the wild, hand-plucked by weather-worn fingers of villagers who know the land like their own pulse.

If guchchhi were merely another mushroom, it would have remained a footnote in the Himalayan folklore. But nature

has endowed it with an earthy, nutty aroma and a deeply umami-laden taste — an alchemy of flavours that elevates even the humblest broth into a dish fit for royalty. Luxury restaurants in Delhi, Mumbai and Paris auction these mushrooms to the highest bidder. A kilogram of dried guchchhi can command anywhere between Rs 30,000 and Rs 50,000 (\$400-\$600). In comparison, the villagers who brave the steep inclines and bone-chilling winds to harvest them earn barely a fraction of that sum. These foragers — often women and young children — trudge through treacherous slopes, eyes scanning the undergrowth. Each guchchhi they collect is a prize, yet, by the time it travels down the convoluted supply chain passing through middlemen, dealers, exporters and high-end retailers — its price inflates, and the original harvester remains trapped in the unyielding clasp of poverty.

There is no legal framework governing the sale of these mushrooms. Unlike saffron, which is cultivated and traded under a structured system, guchchhi remains an orphan of the economy. There are no cooperatives, no procurement schemes, and no fair-trade certifications to ensure equitable earnings for the real collectors. Therefore, one can say that guchchhi is a taste of privilege, and a tale of inequality. In a world that worships gourmet exclusivity, the irony of guchchhi is stark. A bite of guchchhi-infused risotto or a bowl of creamy morel soup is not just a gastronomic experience, it is an unwitting participation in a system where the ones who gather and deliver nature's treasures remain nameless. Perhaps, the real delicacy here is not the mushroom itself, but the taste of justice — a flavour yet to be cultivated.

Capturing grandeur in Vittorio Sella's images

The great cold cleanses the air, wrote Vittorio Sella during one of his journeys across the higher Himalayas. Born in 1859, just two decades after the invention of photography, the Italian mountaineer and explorer went on to chart a career that brilliantly married art with science. Photography was still in its nascent stages of development when Sella picked it up during the last decades of the 19th century. But one would be hard-pressed to find anything rudimentary about his own images: so superbly did he use the modern form of image-making.

Even before I had the chance to immerse myself in these prints at the recent display on Sella's subcontinental tours organised by DAG, New Delhi, what caught my attention were his discerning words on altitude and clarity. For, they instantly took me back to my childhood in the Himalayas, where coldness invariably acted as a cleansing agent for air. Along with inducing freshness, such cleansing would also deliver a clearness of vision, a sharpness and a luminosity that seemed to impregnate the entirety of Sella's Himalayan oeuvre — from images of K2 in the north to Kanchenjunga in the north-east. Despite researching colonial-era photography for over a decade, the Italian pioneer's work left me stunned by its aura. This was particularly true of the imposing images of some of the world's highest peaks, because until now, I had primarily concentrated on postcard-images from the period, which deliberately lionised settings that were domesticated. To be fair, Sella also engaged in these subjects, and produced handsome frames of buildings and people in Sikkim, Nepal and the Western Himalayas. But it was his panoramic shots, running over 2-3 metres in length, that truly brought out the terrain's matchless appeal.

Well-versed with the alpine landscapes of Europe that he had scaled before travelling to Asia, Sella found an incomparable magnificence in the Himalayas, and declared the 'Siniolchu' mountain as "the most beautiful in the world". Having grown up in a family with strong ties to climbing and photography, Sella was con-



tinually fortunate to find the right inspiration, financial backing and company for his pursuits, especially in the figures of the English alpinist Douglas Freshfield and the Duke of Abruzzi. Scholars have noted that it being the age of empire, these men were very much involved in the colonial project of cartographic domination. But as Roger Härtl, the author of 'Photographs at Edge: Vittorio Sella and Wilfred Thesiger', observes, Sella's own relationship with the porters and staff of his expeditions was respectful, an amicability that rested on the photographer's excellent organisational skills.

It was during 1899-1909 that Sella made his most famous Himalayan journeys, starting from the circumnavigation of Kanchenjunga and culminating with an expedition to K2. Even as he and his fellowmen were unable to climb the peaks, their forays assumed massive significance, given that they were among the first tours by Westerners in these sublime spaces. Beholding the images that Sella took among the gigantic glaciers and treacherous slopes, one also recalls his earlier photographs of the Alps, of which he was quite proud. And indeed, such dual referencing while perceiving new landscapes was integral to the evolving pictorial discourse of the time. But Sella was also a keen observer of the particularities inherent to the Himalayas. Charged by a contemplative spirit, he was drawn to the flora, fauna and the endlessly diverse forms of mountains themselves - an interest that wasn't necessarily shared by his companions. He honed his individual genius through his mastery of techniques like the collodion process and the dexterous use of heavy instruments in an unhospitable geography.



Gold surges Rs 4,000 to fresh lifetime high of Rs 1.37 lakh/10g in Delhi

New Delhi: Gold prices surged by Rs 4,000 to touch an all-time high of Rs 1,37,600 per 10 grams in the national capital on Monday, tracking firm global cues, according to the All India Sarafa Association. The precious metal of 99.9 per cent purity had closed at Rs 1,33,600 per 10 grams on Friday. "Gold prices scaled even higher as international spot gold surged towards the USD 4,350 zone, triggering a strong rally in the domestic market," Jateen Trivedi, VP Research Analyst, Commodity and Currency, LKP Securities, said. He

added that the yellow metal reflected the global strength with a sharp gain, touching a fresh lifetime high. Gold prices had earlier appreciated by Rs 3,200 to touch an alltime high of Rs 1,34,800 per 10 grams on October 17. "The move was driven by renewed safe-haven demand and expectations around upcoming US economic data, including non-farm payrolls and the Core PCE Price Index scheduled this



week, focus has firmly shifted to US macro cues, which are expected to keep volatilitv elevated." Trivedi added. During the current calendar year, gold prices have surged Rs 58,650, or 74.3 per cent, from Rs 78,950 per 10 grams on December 31, 2024. On the other hand, silver prices remained flat at Rs 1,99,500 (inclusive of all taxes), as per the association. So far in this year, silver prices have skyrocketed by Rs 1,09,800, or 122.41 per cent, compared with Rs 89,700 per kilogram on December 31, 2024. In the international markets, spot gold rallied for the fifth consecutive session,

rising USD 49.83, or 1.16 per cent, to USD 4,350.06 per ounce. Over the past five sessions, the vellow metal has added USD 159.32, or 3.80 per cent, from USD 4,190.74 per recorded ounce December 8. "Spot gold trading with a positive bias as the Federal Reserve not only cut the rate into elevated inflation, it is also adding liquidity to the system by buying Treasury bills," Praveen Singh, Research Analyst, Mirae Asset ShareKhan, said. Meanwhile, spot silver advanced by USD 2, or 3.24 per cent, to USD 63.96 per ounce in the overseas

UKRAINE CEASEFIRE TALKS CONTINUE AS US SAYS 'PROGRESS WAS MADE'

Talks between Ukraine and the US aimed at reaching a peace deal with Russia are continuing in Berlin for a second day. Zelensky and his chief negotiator Rustem Umerov met US envoy Steve Witkoff and Donald Trump's son-in-law Jared Kushner for five hours on Sunday, joined by German Chancellor Friedrich Merz. "A lot of progress was made," a US readout said. The same team resumed talks on Monday morning. Ahead of the start of the meeting, Volodymyr Zelensky signalled he would give up ambitions to join Nato in exchange for security guarantees. Recognising that "some partners from the US and Europe" did not support Ukraine's bid for Nato membership, Zelensky said he was instead seeking strong security guarantees modelled on Nato's Article 5 clause of mutual protection. "And this is already a compromise on our part," he said



on Sunday. Witkoff has travelled to Moscow to hold talks with Vladimir Putin on several occasions, but Sunday's meeting at the chancellery in Berlin was the first time he met Zelensky. Nato Supreme Allied Commander Europe General Alexus Grynkewich was also present at the talks. Several European leaders as European Commission President Ursula von der Leyen are

expected to join further talks with the Ukrainian and US delegations on Monday evening. At the core of the discussions in Berlin is the 20-point peace plan proposal presented to the US by Ukraine last week to counter an initial American plan which was seen as heavily favouring Russia. Details haven't been shared, but last week Zelensky said the points should be seen as a

"foundation" on which to build provisions for the reconstruction of Ukraine and security guarantees. For Russia, Kyiv's membership of Nato is a red line, and Moscow has repeatedly demanded that any ambitions for Ukraine to join the alliance are shelved forever. "This issue is one of the cornerstones and requires special discussion," said the

Kremlin on Monday. The US

too has repeatedly stated it does not want Ukraine to be part of Nato. But Kyiv fears that a peace deal without watertight security guarantees would fail to detract Russia from attacking again. Before the talks began, Zelensky also addressed the thorny issue of sovereignty over the eastern region of the Donbas, which Russia mostly occupies and which it wants Kyiv to hand over in their entirety.

World

The Ukrainian president said that while he was open to freezing the conflict along the current front line he was not prepared to have his troops withdraw from the percentage of the Donbas they still hold - unless Russian forces did the same in the areas they control. For it to be a fair arrangement Russia would have to withdraw the same distance, Zelensky said. This matter was "extremely sensitive and heated," he added. Any proposal hashed out by the Ukrainian, American and European side will still have to be presented to Moscow although Zelensky said that the US delegation "so to speak present the Russian side's perspective, because they relay Russia's signals, demands, steps, and indications of readiness or lack thereof."

The Kremlin said it expected the US to provide us with the "concept" discussed on Monday. The talks in Berlin come at a crucial time for Ukraine, which is enduring its fourth winter of war amid sustained power cuts caused by Russia's attacks on its energy facilities. Over the weekend more than a million households in Ukraine were left without electricity following a barrage of strikes. Later this week, EU countries will be voting on a plan to send 90bn (£78.6bn) worth of frozen Russian assets held in a Belgiumbased financial institution to prop up Ukraine's economy.

Manhunt resumes for Brown University gunman after 'person of interest' released



A manhunt has resumed in connection with a deadly shooting at Brown University in the US, after officials said a "person of interest" would be released from detention. In a press conference on Sunday evening, Rhode Island Attorney General Peter Neronha explained that there was "no basis" to still son to be of interest, and that the evidence "now points in a different direction". The investigation is ongoing and authorities are searching for additional video evidence that could help them track down the suspect. Two people were killed and nine others injured after a gunman opened fire on Saturday at the Ivy League university in the city of Providence, the state capital. Also speaking at Sunday evening's press conference, Providence Police Chief Col Oscar Perez said investigators did not think the person detained was the individual shown in CCTV footage of the suspect that was released on the day of the attack. In that footage,

the suspect can be seen walking away from the scene wearing all black clothing. A later post on X from Providence Police confirmed that "the person of interest is being released". The BBC has chosen to stop naming that person. Authorities did not say what had prompted them to detain them in the Col Perez said: "Whether something needs to be ruled out is not a mistake. It's just how investigations work." Earlier on Sunday, FBI director Kash Patel said the person of interest had been detained at a hotel in the town of Coventry in the early hours - based on a lead from Providence Police. At that point, Col Perez had confirmed that officers were not looking for anyone else and were working with prosecutors to collect evidence. Also on Sunday, Providence Mayor Brett Smiley said one of those injured in the incident was in a critical condition, while seven others remained stable and another had been discharged from hospital.

Balloons from Belarus are causing chaos in Lithuania. Is it smugglers or a hybrid attack?



Whenever the wind blows northwest from Belarus, Lithuania braces for problems. That's when giant white balloons are launched across the border, crates of cheap cigarettes dangling beneath. Over the past 10 weeks, the illicit balloon traffic has already forced Lithuania's main airport into shutdown 15 times, stranding or delaying thousands of travellers. On one occasion the airspace was

closed completely for 11 hours. But the government here is sure it is dealing with something far more hostile than smugglers. It says the balloons have been "weaponised" in an act of hybrid warfare by Belarus, Russia's closest ally. It is happening just as Moscow's own shadow war on Europe is escalating again with a wave of arson and sabotage attacks that officials link to Russian intelligence.

Hollywood director Rob Reiner and wife Michele found dead in LA home

Legendary Hollywood filmmaker and actor Rob Reiner and his wife Michele have been found dead in their Los Angeles home. Authorities are investigating the incident as an apparent homicide after police and firefighters were called to the couple's house on Sunday afternoon in an upmarket neighbourhood of LA. Reiner is known for directing classic films in a variety of genres, including When Harry Met Sally, This is Spinal Tap, Stand By Me, Misery and A Few Good Men. A family spokesperson confirmed the couple's death in a statement to US media. Tributes have arrived from major



figures in both Hollywood and politics, as Reiner was also a champion for liberal causes and Democratic politics. "It is with profound sorrow that we announce the tragic passing of Michele and Rob Reiner," the family statement said. "We are heartbroken by this sudden loss, and we ask

for privacy during this unbelievably difficult time." Police said a 78-yearold man and 68-year-old woman were pronounced dead at the home, but officers did not immediately identify the couple or the circumstances surrounding their deaths. Police also said no-one had been arrest-

PRO-DEMOCRACY HONG KONG TYCOON JIMMY LAI **CONVICTED IN HIGH-PROFILE** NATIONAL SECURITY TRIAL



Hong Kong pro-democracy campaigner and media tycoon Jimmy Lai has been found guilty of colluding with foreign forces under the city's controversial national security law (NSL). The 78-year-old UK citizen, who has been in jail since December 2020, pleaded not guilty. He faces life in prison and is expected to be sentenced early next year. Lai used his now-defunct Apple Daily newspaper as part of a wider effort to lobby foreign governments to impose sanctions on Hong Kong and China, the court found. Hong Kong chief executive John Lee welcomed the verdict, noting that Lai's actions "damaged the country's interests and the welfare of Hong Kongers". Rights groups called it "a cruel judicial farce". They say the NSL, which Beijing defends as essential for the city's stability, has been used to crush dissent. Delivering the verdict on Monday, Judge Esther Toh said there is "no doubt" that Jimmy Lai "harboured hatred" for the

(PRC), citing his "constant invitation to the US to help bring down the government of the PRC with the excuse of helping the people of Hong Kong". When Lai testified in November, he denied all the charges against him, saying he had "never" used his foreign contacts to influence foreign policy on Hong Kong. Asked about his meeting with then US Vice President Mike Pence, Lai said he did not ask anything of him: "I would just relay to him what happened in Hong Kong when he asked me." He was also asked about his meeting with then-secretary of state Mike Pompeo, to which he said he had asked Pompeo, "not to do something but to say something, to voice support for Hong Kong". Lai, one of the fiercest critics of the Chinese state, was a key figure in the prodemocracy protests that engulfed Hong Kong in 2019. Beijing responded to the months-long demonstrations, which sometimes erupted into violent clashes with police.

Chile elects far-right José Antonio Kast as next president

Chile has elected the farright wing José Antonio Kast to be its next president, after an election campaign that was dominated by themes of security, immigration and crime. Kast beat the governing left-wing coalition candidate Jeanette Jara decisively with more than 58% of the vote in his third attempt at running for president. It marks the biggest shift to the right since the end of Chile's military dictatorship in 1990. Kast has openly praised Chile's former right-wing dictator, Augusto Pinochet. In his first speech to supporters as president-elect, Kast said: "Chile will once again be free from crime, free from anguish, free from fear." "Criminals, delinquents - their lives are going to change. We're going to look for them, find them,

going to lock them up," he added. At a gathering of his backers in the capital Santiago, many draped in Chilean flags, chanting and taking selfies, there was jubilation as the results came through. "I'm happy we can recover the country's security and patriotism," said Augustina Trancoso, donning a red "Make Chile Great Again" cap. "We've been trying to win an election for years," said Belem Valdivieso. "In Chile, you used to be able to walk the streets peacefully, lately we've experienced problems with insecurity. I'm hoping his promises will be kept and he'll focus on security." Throughout the campaign, Kast portrayed Chile as a country that was descending into chaos and insecurity. He pledged to restore

order and crack down on irregular immigration, as well as implementing sharp spending cuts. Kast is an admirer of Donald Trump, who is likely to become a close ally, and his policies echo those of the US president. He has pledged a border wall on Chile's porous frontier with Peru and Bolivia, maximum-security prisons, and mass deportations of irregular migrants,

many of whom are from Venezuela. Chile is one of the safest and more stable countries in South America, but a rise in immigration and organised crime in recent years has concerned many voters. Kast regularly drew links between the two. His critics, though, say the problem is being exaggerated. One voter in Santiago, Javiera Carrasco, liked some of Kast's policies but Communist Party member Jara. She said she felt "like a false sense of insecurity is becoming widespread." "In other countries, there are much worse things happening than here. It just doesn't add up for me." Chile's murder rate is now falling, and some studies suggest those born abroad commit fewer crimes on average. But the perception of growing insecurity was the motivation for many of Kast's voters. "We are transforming into Colombia, a lot of terrorism, thieves, robbery, society is very unsafe," one voter Max Struber said. "It may sound harsh to say it, but we need the government to continue Pinochet's work. Human rights abuses existed, that's true. But as a government it was good, we used to have peace and tranquility."

Kast's brother was a minister during Pinochet's dictatorship, and his father was a member of the Nazi party. Pinochet was an army general who led a US-backed military coup in 1973 and established a 17-year-long military dictatorship that was marked by brutal human rights abuses, forced disappearances and freemarket economic policies. Chile's current left-wing President Gabriel Boric, who could not run again, had suffered from low approval ratings. Kast's rival Jeannette Jara may have suffered by being seen as a "continuity vote". A supporter at his victory party, Francisco Otero, said neither candidate represented everybody perfectly, but that a continuation of the government was seen as "much worse".



Smooth end to Messi India tour after Kolkata chaos

Football superstar Lionel Messi has wrapped up his three-day India tour in pollution-choked Delhi, after a chaotic opening in Kolkata. On Monday, thousands of fans gathered in a Delhi stadium to get a glimpse of the Argentina and Inter Miami forward. As Messi, accompanied by Inter Miami teammates Luis Suárez and Rodrigo De Paul, strolled on the pitch - kicking balls into the stands, passing with a group of children and signing autographs - the crowd chanted his name. His flight from Mumbai had been delayed due to fog, local media reported, and his itinerary had to be trimmed. On Saturday angry fans vandalised a Kolkata stadium because they didn't get to see him during his appearance there. Messi had a packed schedule in India, attending a string of promotional events in Kolkata, Hyderabad and Mumbai since arriving in the early hours of Saturday. Before

Stadium later that day, he virtually unveiled a 70ft (21m) statue of himself, assembled over 27 days by a 45-strong crew in the eastern city. The tour, however, got off to a disastrous start after angry fans ripped up seats and threw items towards the pitch at the stadium. Football is hugely popular in West Bengal state of which Kolkata is the capital - and thousands of adoring supporters had paid up to 12,000 rupees (£100; \$133) to attend the event. However, most of them didn't even get to see him as he was surrounded by officials and celebrities on his brief walk around the stadium and then quickly whisked away as the situation turned hostile. Kolkata's The Telegraph newspaper said in an editorial that "poor management of a hyped-up event, lack of co-ordination" and security lapses turned the stadium into a "battlefield", as fans - denied even a glimpse of Messi - "vented their anger by indulging in violence". As expected, Josh Tongue replaces fellow pace bowler Gus Atkinson. It is the omission of 22-year-old Bashir that is most striking for a Test where spin is likely to play an important role. It is a huge decision by England captain Ben Stokes and head coach Brendon McCullum for a Test where jobs and reputations could be on the line. 



I was working with TCS in the US, but that life never excited truly me. Professionally it was stable, but personally it felt empty. Even while I was there, cinema kept pulling at me constantly. It was always at the back of my mind, nudging me. That's when I decided to take things seriously. I attended several filmmaking workshops, spent time understanding the craft, and once I gained confidence, I took the risk. I resigned from my job and came back to India. After returning, I began developing this story properly. I already had a core idea in mind.

I find love stories particularly

difficult to narrate. Capturing those emotions honestly on screen is not easy for me. Instead of choosing something high-octane or purely thrilling, I decided to go with rooted, lived-in concepts. The literature I read had a huge influence on me. Writers like Kesava Reddy garu, Yandamoori Veerendranath, and K. Bala Gopal introduced me to worlds I would never have known if not through their writing. That exposure made me think why not return to my Telangana roots and tell a story about a world that many people don't even realise exists. That thought became the high point for me. From there, I decided to focus on the cremation process in rural areas, and the drama, politics, and conflicts that surround it.

Q. Since you are from the US, what research did you do about this rooted culture

apart from reading books? A. The incidents shown in this film are not historical or imaginary. They are things that still happen in villages today. I have personally encountered them.

In our village, we have a cricket ground where we also used to dry paddy.
