#### Soldier dies in explosion in J&K's Kupwara

**SRINAGAR**: A soldier was killed in an explosion in Jammu and Kashmir's Kupwara district, officials said on Tuesday. Officials said that the soldier died on Monday in an explosion in Putaha Khan Gali of the Trehgam area of the district of the Line of Control (LoC).

The soldier has been identified as Havaldar Zubair Ahmad of J&K Light Infantry (JAKLI). "The injured soldier was rushed to a military hospital in the Drugmulla area of Baramulla district, but doctors said he was dead on arrival," officials said.

The officials said that the explosion occurred during road construction in the area, and the soldier was accidentally critically injured in this blast.

#### At least six killed in small plane crash in Mexico

MEXICO CITY: At least six people were killed after a small aircraft crashed in the municipality of San Mateo Atenco in Mexico's central State of Mexico, local authorities said.

Adrian Hernandez Romero, the state's civil protection coordinator, told reporters that 10 people were on board the aircraft. including the pilot and co-pilot. The victims have not vet been identified, he said.

Hernandez said the private jet had registered eight passengers and two crew, but hours after the crash only seven bodies had been recovered. He said the plane had apparently tried to land on a soccer field but hit the metal roof of a nearby business, starting a large fire.

#### Mathura fog: 13 dead, 25 injured in Yamuna Expressway pile-up

#### MATHURA (TSIT):

Thirteen people died of burns, and 43 sustained injuries when a vehicle pile-up in dense fog on the Yamuna

Expressway here early Tuesday turned into an inferno, according to police. Eight buses and three smaller vehicles collided with each other in the thick fog around 4.30 am, the officer said. The incident occurred under the Baldev Police Station jurisdiction.

Some vehicles also caught fire. All injured have been sent to the hospital," Mathura Senior Superintendent of Police Shlok Kumar said. Two of the deceased were identified as 44-year-old Akhilendra Pratap Yadav, a resident of Prayagraj, and 75-year-old Rampal, from Maharajganj district, Baldev Police Station SHO Ranjana Sachan said.

## **Revanth seeks FM support** for residential schools

HYDERABAD (TSIT): Telangana Chief Minister A. Revanth Reddy on Tuesday met Union Finance and Corporate Affairs Nirmala Minister Sitharaman in New Delhi and urged her to extend support for the establishment of Young India Integrated Residential

Schools (YIIRS). The Chief Minister informed the Union Minister that the State government plans to set up 105 YIIRS across Telangana.

According to the Chief Minister's Office (CMO), he highlighted that through the YIIRS, quality education would be provided directly and indirectly to nearly four lakh students.

The Chief Minister also stated that the construction of the YIIRS and other educational institutions would involve an expenditure of Rs 30,000 crore. He requested the Union Finance Minister to exempt the loans raised for this purpose from the Fiscal Responsibility and Budget Management (FRBM) limits, considering the large-scale invest-

ment in education infrastructure. Congress MPs Kiran Kumar Chamala, Dr Mallu Ravi, Suresh Shetkar, and Anil Kumar Yadav accompanied the Chief Minister.

In September, Deputy Chief Minister Mallu Bhatti Vikramarka had met FM Sitharaman and had sought special financial support and FRBM exemption for the Rs 30,000 crore YIIRS programme in the state.

Vikramarka, who is also the state Finance Minister, had also explained that this Rs

30,000 crore initiative will transform education and nutrition for lakhs of children, empower marginalised communities, and strengthen India's demographic dividend.

The Union Finance Minister was also urged to give FRBM exemption for this long-term human capital investment.She was told that the programme was launched to address the challenges of quality education and nutritious food for students.

#### 'Insult to Mahatma Gandhi'

## **Oppn protests outside Parliament** against move to replace MGNREGA

**NEW DELHI:** The Opposition on Tuesday staged a protest outside Parliament, holding placards and raising slogans against the Centre over its move to replace the Mahatma Gandhi National Rural Employment Guarantee (MGNREGA). Raising slogans such as "Gandhiji ka ye apman, nahi sahega Hindustan' and "Mahatma Gandhi Amar Rahe", Opposition parliamentarians accused the BJP-led Centre of removing the name of the Father of the Nation, Mahatma Gandhi, from the rural employment scheme.

Opposition objected to the renaming of the flagship employment programme and marched within the Parliamentary premises to the statue of Mahatma Gandhi, where they continued their protest.

The demonstration followed the introduction of the Viksit Bharat Guarantee for Rozgar and Ajeevika Mission (Gramin) (VB-G RAM G), 2025, a Bill that seeks to replace the Mahatma Gandhi National Rural Emplovment Guarantee Act.



Opposition MPs protested outside Parliament, accusing the Centre

of insulting Mahatma Gandhi and attempting to dilute MGNREGA by renaming it

under a new rural employment Bill.

Union Minister Shivraj Singh Chouhan introduced the Bill in the Lok Sabha on Tuesday, triggering sharp reactions from Opposition members who questioned the rationale behind removing Mahatma Gandhi's name from a landmark welfare scheme that has been in

existence for nearly two decades.

"The truth is that under the pretext of changing the scheme's name, they want to scrap it. Why do they want to change the name of this scheme? Mahatma Gandhi is the Father of the Nation," Congress MP Priyanka Gandhi Vadra told reporters during the protest.

Samajwadi Party chief Akhilesh Yadav, speaking to IANS, questioned the logic behind the "renaming" exercise.
"How will the change in the name benefit the farmers of the country? This politics of changing the name first started in Uttar Pradesh, and now it has arrived in Delhi also," he said.

### Revanth meets Sonia, presents 2047 Vision Document

#### 34 Maoists surrender in Bijapur with Rs.84 lac bounty

RAIPUR/BIJAPUR: In a sig-

nificant victory for anti-Naxal operations, 34 Maoist cadres. including 7 women, surrendered before senior police and CRPF officials in Bijapur district on Tuesday, carrying a combined bounty of Rs 84 lakh.The surrendered cadres, primarily from the South Sub-Zonal Bureau, also include members linked to the Dandakaranya Special **Zonal Committee** (DKSZC), Telangana State Committee, and Andhra-Odisha Border (AOB) Division.Key figures include a Divisional Committee Member (DVCM) from the Keralapal Area Committee with a Rs 8 lakh bounty, several PLGA (People's Liberation Guerrilla Army) members, Area **Committee Members** (ACMs), platoon leaders, militia commanders, and frontal organisation office-bearers like DAKMS and CNM presidents.



# KTR accuses Congress MLAs of high-handedness

HYDERABAD (TSIT): Bharat Rashtra Samithi (BRS) working president K.T. Rama Rao on Tuesday accused the ruling Congress party legislators of arrogance of power and high-handedness.

He asserted that funds for Gram Panchayats and welfare schemes like Indiramma Houses are public money and not the personal property of Congress leaders.

### **Telangana Police Clarify No Local Links in Sydney Terror Attack Case**

Hyderabad (TSIT): Telangana Police have clarified that there is no connection to Telangana or India in the radicalisation of Sajid Akram and his son Naveed Akram, who were involved in the mass shooting at Bondi Beach, Sydney, during a public Hanukkah celebration on December 14, 2025.

According to official information. the attack, which resulted in the deaths of 15 civilians and one of the two attackers, has been classified as a terrorist act by Australian authorities. Investigations have indicated that the perwere 🞽 petrators inspired by ISIS ideol-

ogy, and further inquiries are being conducted by Australian

law enforcement agencies. Sajid Akram (50), originally from Hyderabad, migrated to Australia in November 1998 in search of employment after completing his B.Com degree. He later married Ms. Venera Grosso, of European origin, and settled permanently in Australia. The couple had two children — a son Naveed Akram (24), who was

involved in the attack, and a daughter. While Sajid Akram held an Indian passport, both his children were Australian citizens by birth. Police sources stated that Sajid Akram had minimal contact with his relatives in Hyderabad over the past 27 years and had visited India only six times, mainly for fami-

> ly-related reasons such as property matters and visits to elderly parents. He reportedly did not visit India even at the time of his father's demise.

Family members in India have expressed no prior knowledge of Sajid Akram's radical mindset or extremist activities. Telangana

Police have confirmed that no criminal or adverse record exists against Sajid Akram during his stay in India prior to his migration. The Director General of Police, Telangana, reiterated that the state police remain committed to cooperating with central agencies and international counterparts as required, and urged the media and public to refrain from speculation or unverified attributions.



This belief guided his conscious choice to join the Revenue Department, the only arm of governance that serves citizens from womb to tomb, from birth registration to land rights, welfare delivery, and dignity in death.

While his commitment to farmers and the public remained unwavering, his journey revealed a deeper truth, an employee who understands the system from within can become its most effective reformer. As a government servant himself, he recognized

that public welfare and employee welfare are not competing interests but interdependent responsibilities. This realization transformed him from a conscientious officer into a formidable employ-

#### Leadership Beyond Designation

His leadership was never positional, it was purposeful. Driven by passion rather than power, he founded and strengthened multiple employee organizations while serving as a Tahsildar and later in higher responsibilities. These

Each platform reflected a singular philosophy, empower employees to stand strong, informed, united, and self reliant. Beyond organizational leadership, he initiated and sustained Revenue Masa Patrika, a magazine dedicated to disseminating knowledge on agriculture, land laws, revenue regulations, and public welfare schemes. In doing so, he bridged the gap between policy and people between governance and grassroots.

Managing such vast responsibilities is no easy task. Yet, he invested his time, energy, and personal resources not for recognition, but out of an unwavering belief in collective upliftment of employees, farmers, and society at large.

Like Gompers, our leader Lachi Reddy, prioritizes institutional strength, education, and sustainable welfare over populist rhetoric.Jose Maria Arizmendiarrieta, the visionary behind Spain's Mondragon Corporation, believed in shared ownership, collective leadership, and profit sharing. Similarly, our Leader

Lachnna, shares power rather than centralizing it, nurturing every employee as a potential leader and stakeholder in the system.

At the national level, his qualities echo the spirit of Indian labour reformers who believed that strong institutions and informed employees form the backbone of a just society.Rooted in agriculture, refined through administration, and elevated by sacrifice, he stands as a rare blend of public servant and people's leader. His life's work demonstrates that governance is not merely about authority, but about empathy, empowerment, and ethical courage.

In an era where leadership is often measured by visibility, he is measured by impact,

quiet yet profound, firm yet compassionate. He is not just a leader of employees, he is a builder of future leaders, a custodian of public trust, and a living example of service beyond self.

# SIR within EC's constitutional mandate to purify electoral rolls: Nadda


NEW DELHI: Special Intensive Revision falls within the constitutional powers of the Election Commission to periodically purify electoral rolls to ensure no eligible voter is excluded from the list and no ineligible voter is included, Union Minister JP Nadda said in the Rajya Sabha on Tuesday. Replying to a debate on Election Reforms in the Upper House, the Leader of the House attacked the Congress for creating an atmosphere that mass-scale rigging was taking place in the country in the name of SIR (Special Intensive

He also said that no questions were raised on the credibility of

the EC when its functioning and work "was controlled by a single party" run by one family, without directly naming the Congress. "SIR is a Special Intensive Revision that falls within the constitutional powers of the Election Commission. It is the Commission's duty to periodically purify and rectify the electoral rolls," Nadda asserted.

He further said, "When it comes to preparing voter lists, the Constitution clearly empowers the Election Commission, along with granting it the authority to conduct elections".

The Constitution also mandates that no eligible voter should be excluded from the list and that no



ineligible voter should be included in the electoral rolls, the senior BJP leader added.Noting that SIR is not new, Nadda said it has been part of India's democratic process since 1952.

It was conducted in 1952, 1957 and 1961, when Jawaharlal Nehru was Prime Minister. In 1965, Lal Bahadur Shastri was the Prime Minister. In 1983, Indira Gandhi was Prime Minister. In 1987 and 1989, Rajiv Gandhi was Prime Minister. In 1992, PV Narasimha Rao was Prime Minister, he recollected. In 2002, Atal Bihari Vajpayee was Prime Minister, and in 2004, Manmohan Singh was Prime Minister. "Except for Atal ji, every

time SIR was carried out, the Prime Minister was from the Congress," Nadda said, adding the EC has power under the Constitution to verify the voters' list from time to time.It becomes more important for EC to hold SIR as no deletion of voters has taken place since 2010, he said.

Nadda also hit back at the Opposition's accusation of the government denying discussion on SIR, saying the Modi government never shies away from discussion on any issue in Parliament.He accused the Congress and Opposition parties of misleading the country by targeting the ECI and EVMs.


## Rahul Gandhi warns poll commissioners as Congress protests alleged vote manipulation



NEW DELHI (TSIT): The Congress staged a massive rally at Ramlila Grounds on Tuesday against what it termed "vote chori" (vote theft), days after its electoral rout in Bihar. Party supporters from across the country packed the venue, spilling onto nearby roads and causing traffic disruptions in central Delhi. Addressing the gathering, Leader of the Opposition in the Lok Sabha Rahul Gandhi directly named the Chief Election Commissioner and two Election Commissioners, accusing the Election Commission of acting in tandem with the BJP government. He alleged manipulation of voter lists through the addition of

bogus voters and deletion of genuine ones to benefit the ruling party. Rahul said the 2023 law governing the appointment and protection of election commissioners would be changed if Congress came to power, and warned that accountability would be fixed retrospectively. "You are the election commissioners of India, not Narendra Modi's election commissioners," he said, asserting that the party would continue its campaign despite electoral setbacks.Congress president Mallikarjun Kharge, senior leaders, several chief ministers including those of Telangana and Himachal Pradesh, state unit heads, Sonia Gandhi, and Priyanka Gandhi Vadra were present on the dais. Priyanka urged the crowd to remember the names of the commissioners, saying they would one day have to answer to the country for allegedly undermining the right to vote.Kharge said he attended the rally despite his son undergoing surgery, calling the fight against vote rigging a national cause. While reactions among supporters were mixed on the electoral impact of the issue, Congress claimed to have collected nearly six crore signatures nationwide against alleged voter list manipulation.

# Advanced neuro stenting restores brain blood flow in critical stroke case at Medicover Hospitals, Hitech City

Hyderabad, 16th December, 2025: In a timely and life-altering intervention, doctors at Medicover Hospitals, Hitech City, successfully treated a 69-year-old woman suffering from an acute ischemic stroke caused by a critically narrowed major brain artery—preventing severe disability and further neurological deterioration. The patient was diagnosed with left internal carotid artery (ICA) watershed infarcts, a high-risk form of stroke that occurs when blood flow to the brain drops below critical levels. Advanced imaging revealed critical stenosis of the left terminal ICA ophthalmic segment, a vital artery supplying blood to regions controlling movement, vision, and higher cognitive functions. Stroke experts note that ischemic strokes account for nearly 85% of all strokes in India, with carotid artery disease responsible for up to 20-25% of these cases. The risk increases sharply

after the age of 60, and recent Indian



data shows that elderly women now account for nearly 45–50% of stroke admissions, often presenting later due to subtle or atypical symptoms. India reports an estimated 1.8 million new stroke cases every year, with urban populations showing a rising trend due to sedentary lifestyles, hypertension, diabetes, and cholesterol disorders, while

rural patients often suffer from delayed diagnosis and limited access to advanced stroke care. Given the critical nature of the blockage and the high risk of recurrent or disabling stroke, the patient underwent left ICA stenting on 13 November 2025, using a Neuroform Atlas  $4 \times 24$  mm stent—a next-generation neurovascular device designed for precision,

flexibility, and durable vessel support. The procedure was performed by Dr. Ranjit, Consultant Interventional Neurologist at Medicover Hospitals, Hitech City, who emphasised the importance of early intervention in such cases.

"Watershed strokes are a warning sign of severely compromised brain blood flow. In elderly patients, especially women, these strokes can progress rapidly if the underlying arterial narrowing is not addressed. Advanced neurointerventional procedures now allow us to safely treat even complex carotid artery lesions and significantly reduce long-term disability," said Dr. Ranjit.Medical experts caution that nearly one in four stroke survivors in India is left with long-term disability, affecting independence and quality of life. ## IndiGodot: What We Wait for When We Wait for Change

December 2025, airports across India, those monuments to aspiration, transformed overnight into something resembling a Beckettian staging of waiting. In Beckett, you wait for Godot; here, thousands of passengers found themselves sitting on marble floors, staring at departure boards that had stopped pretending to mean anything. IndiGo, the airline that flies more than half of India, had cancelled over a thousand flights in a single day. Videos circulated on social media this is part of our new national pastime, documenting indignities on phones that cost more than most Indians earn in six months. They showed passengers howled at airline staff who were either struggling too or had clearly stopped listening hours ago. Families camping under airport lights. Not because these passengers were entitled to perfection, but because a promise of reliability had been sold as infrastructure, and when that promise failed, it revealed not the vulnerability of those sitting on the floor, but the fragility of the machine that had been built above them.

The Official Story Which Nobody Believes But Everyone Repeats The explanation was bureaucratic and therefore boring. New flight duty time limitations, FDTL in the jargon, designed to keep pilots from being worked to death. These were not draconian rules, but night landings capped at two instead of six, 48 hours of weekly rest among other things. Kind of regulation that shouldn't cause chaos unless someone decides not to prepare for it. But when you're that big, when you own that much of the sky, caring perhaps becomes optional. IndiGo called it a "reboot." Corporate speak for when you've made a mess and need to pretend it was intentional. A cleansing ritual to realign crew and machines. Very spiritual. Very necessary. Very needed. Very conveniently timed. And then, right on schedule, the DGCA folded. A soft exemption was granted till February 2026. The new rest requirements, designed to keep pilots from flying while half-alive and half-dead, effectively neutered.

In any other country this might be called corporate blackmail. A monopoly leveraging its stranglehold on national mobility to force a regulatory rollback. In India it's called Tuesday. Another day, another capitulation. The market barely blinked. IndiGo's stock dipped marginally, then resumed its upward drift, almost smugly. Investors knew what passengers didn't, this wasn't a failure. This was a demonstration. A flex. When you control 60% of the market, when you own the slots and terminals and routes and manpower, you're not really a company anymore. You're a microstate. You can stall the arteries of national mobility to make a point. You can perform a crisis, watch the regulators scramble, and emerge with exactly the exemption you wanted. Perhaps one can call it brilliant, in a sociopathic sort of way.

What IndiGo revealed, perhaps unintentionally, perhaps not, is that the infrastructure of this nation is not a shared inheritance. It's a gated commons, and when the gate malfunctions and the privileged briefly find themselves outside, the panic is treated as a national emergency.

The Gated Commons and Who Gets to Use the Gate

But what stays with me, what I can't quite shake, is the sight of the elite stranded. Not because their suffering is trivial, but because it exposes how selectively the nation recognises suffering at all.

Aviation in India caters almost entirely to an urban, upper-caste, mostly English-speaking population. It is still a privilege masquerading as normalcy. Less than 5% of Indians have ever been on a plane. In a country of 1.4 billion, the flying class i.e. less than 5% is a rounding error. This is the demographic that also often functions as the soft extension of the political regime. These are people who truly believe and imbibe the shining India narrative, because they are the ones shining.

Test Narco and Constitution: Rights, Morality and Justice

The Supreme Court's re-declaration of involuntary narcoanalysis tests as unconstitutional is a significant reassertion of the Constitution's supremacy in Indian democracy. This decision is not limited to a single technique of criminal investigation, but raises profound questions about the punitive power of the state, the dignity of the individual, and the moral compass of the justice system. A fundamental principle of modern criminal justice is that the fundamental rights of citizens cannot be compromised even in the name of crime control.

Narco testing is essentially a process in which an accused or suspect is administered special chemical drugs to weaken their consciousness, enabling them to answer questions without resistance. It is often presented as a technique for "unearthing the truth." However, any path to the truth that is unconstitutional, inhumane, and unscientific cannot be a path to justice. The Indian Constitution has established clear boundaries to the relationship balance between the state and citizens, violations of which are unacceptable under any circumstances.

Article 20(3) of the Constitution provides the right to protection from self-incrimination. This means that no person can be compelled to give evidence against himself. Involuntary narco-analysis is a direct violation of this right, as it attempts to extract information from a person against his or her will. In the landmark judgment of Selvi v. State of Karnataka (2010), the Supreme Court clearnarco-analysis, brain mapping, and polygraph are unconstitutional if conducted without consent. This judgment is not merely a legal interpretation, but a declaration of the protection of constitutional morality. Article 21, which provides the right to life and personal liberty, takes on an even broader meaning in the context of narcotic testing. The right to life is not limited to physical survival but also includes dignity, mental autonomy, and privacy. Controlling a person's consciousness by injecting them with chemical substances is a serious encroachment on their physical and mental liberty. The Supreme Court has, from time to time, interpreted Article 21 to state that every action by the state must be "just, reasonable, and reasonable." Narcotic testing fails this criterion.

Narco testing also raises numerous questions from a judicial perspective. Under the Indian Evidence Act, only evidence obtained voluntarily and reliably is admissible. Statements made during narco testing are neither completely voluntary nor scientifically reliable. Under the influence of drugs, a person's memory, imagination, and external suggestions become intertwined. Accepting information obtained in such a situation as truth is inviting judicial error. For this reason, the Supreme

Court has refused to accept the results of such tests as evi-Another serious constitutional problem concerns the concept of "consent." Supporters argue that a narco test can be conducted if the accused consents. However, the question of how

free and voluntary consent is given in custodial conditions is complex. Power imbalances are inherent in police custody. Consent given under fear, pressure, and uncertainty about the future cannot be considered genuine consent. The Supreme Court has also recognized that the reliability of consent

modern human rights discourse. Depriving a person of consciousness, chemically controlling them, and extracting information from them violates their dignity. This approach reduces the individual to a "means," whereas Constitution considers the individual to be the "goal." Philosophically, this process also separates a person from their will and conscience, which is unacceptable in any civilized society. From a scientific perspective, the reliability of narcotics testing also faces serious questions. The notion that a person under the influence of drugs will only tell the truth is a myth. Medical science suggests that such drugs impair a person's judgment, leading them to interpret imaginary events as real. Sometimes, the interrogator's questions influence responses, revealing not the truth but the investigator's expectations. Thus, narcotics testing can create confusion rather than uncover the truth. Narco testing is also a serious concern in the context of medical ethics. The medical profession is based on the principle of "do no harm." When a doctor administers drugs to a person without any therapeutic purpose, merely for testing, they violate this principle. Furthermore, health risks exist during narco testing, especially if the person already suffers from a physical or mental illness. This raises questions about the role and responsibility of physicians. The argument in support of narcotics testing is that it can help guide investigations into serious crimes, terrorism, or complex cases. However, this argument falls short in the face of constitutional values. The Constitution does not permit the suspension of fundamental rights under any circumstances, except in exceptional situations like emergencies, and that too within a limited scope. The gravity of a crime does not give the state the right to act arbitrarily. This becomes an easy way to cover up investigative incompetence. In contrast, the modern criminal justice system emphasizes evidence-based, scientific, and professional investigations. Techniques such as DNA analysis, digital forensics, financial investigations, and witness protection are not only more reliable but also in accordance with rights. Police reforms and training are crucial in this context. Unless investigative agencies are equipped with modern technology, adequate resources, and trained in constitutional values, they will continue to be tempted to resort to such shortcuts. The detention guidelines issued by the National Human Rights Commission and the police modernization plan are important steps in this direction, but their effective implementation is required. The role of the judiciary should not be limited to imposing restrictions. Courts must ensure that rights are not violated in any investigative process. Furthermore, judicial training should place special emphasis on constitutional morality and human rights, ensuring that these values ??are upheld in lower courts. Ultimately, the question of narco testing is not just about a technique, but about the way the state views its citizens. Are citizens merely instruments of investigation, or are they dignified individuals with rights? The Indian Constitution clearly chooses the latter. The strength of democracy lies in its unwavering commitment to its values ??even when dealing with crime. In conclusion, the Supreme Court's reminds us that the purpose of justice is not merely conviction, but rather the attainment of truth through a fair, humane, and constitutional process. ## Why Big Tech Has Committed Almost \$80 Billion To India In Two Months

In the 2000s, the Indian economy grew at spectacular rates. Those were heady years, as the growth rate accelerated on the back of a steady flow of foreign direct investment (FDI). From Mumbai to Bengaluru (it was still Bangalore then), there was genuine excitement. India was truly shining. Towards the fag end of the decade, annual FDI touched nearly \$40 billion. At the time, \$40 billion was truly something. Most of that investment went into traditional sectors such as telecom, metals, automobiles, energy and old-world manufacturing. In those years, India had no digital rails, a nascent startup ecosystem and no public cloud strategy. A similar excitement is in the air today. After the doom and gloom of the Covid-19 years, India's economic engine has slipped back into fifth gear. Investor confidence in the India story has fully restored. Compared to the world of the 2000s, the picture today is dramatically different. India is now part of the global high-tech chain: semiconductors, AI, cloud, data centres, electronics. The shift is seismic. Best Of Times? In this backdrop, Big Tech has entered India with confidence and deep pockets. Since October, they have been lining up at India's doorstep with cheque books open. Amazon has promised \$35 billion. Microsoft has

committed \$17.5 billion.



Google is building a \$15 billion AI data hub. Intel has tied up with Tata to anchor India's semiconductor ambitions. After adding a few other players, India has attracted more than \$80 billion in fresh tech pledges within weeks. And this is on top of India's already strong post-pandemic annual FDI inflow of more than \$80 billion. Not long ago, we struggled to attract foreign capital. The sudden surge today feels almost electric. So what has changed? A lot of businessmen and investors here are wondering what has changed in India, why the world's richest tech companies are betting so aggressively on a market that, they insist, still wrestles with paperwork, state-level delays and regulatory bottlenecks. They ask why Big Tech would take this risk when the US under President Trump is nudging

not very difficult to answer these questions. Consider this: India offers what no other democracy can. A digital universe of at least a billion people. The world's second-largest pool of tech talent. A market where cloud consumption is growing faster than almost anywhere else. A state that has made AI infrastructure, semiconductor production and packaging and public digital platforms the spine of its next economic phase. AI models devour data. They need millions of testers. They need languages - India offers at least 22, along with accents and behavioural patterns. They need engineers who can train, tune and monitor them. India has all four in abundance. That is why India beckons Big Tech. But there is a deeper story under the headline numbers. These tech giants are not simply building data centres. They are embedding themselves into India's long-term economic story, at least for 20-30 years. The government's move may be overdue, but it arrives at a decisive moment. A national sovereign AI framework is slated to roll out in February. The outline is clear. Public datasets, compute grids, domestic model building, Indian language AI, sectorspecific guidelines, safety checks and incentives to build indigenous AI capability. It will be India's attempt to ensure that intelligence, like data, becomes a strategic public resource. The new policy will formalise what the world is already sensing. ## Will Congress 'High Command' Fumble **Another State? Possibly**

the grand old party prepares to celebrate its 140th foundation day, Karnataka's 'CONG'-estion point seems to be dampening spirits. The 83vear-old Mallikariun Kharge is staring at the rocky politics of his home state, where a hawkish and somewhat edgy Deputy Chief Minister, DK Shivakumar, is looking for an elevation that was supposedly promised by Kharge in May 2023. Eyewitness accounts have it that it was at 51, Lodhi state, New Delhi, the residence of All India Congress Committee (AICC) General Secretary in-charge of the organisation, KC Venugopal, where the two warring men, Siddaramaiah and Shivakumar, along with Kharge, had spoken twice with Rahul Gandhi over the phone, confirming the rotational chief ministerial formula. Under the arrangement, Siddaramaiah was to run Karnataka for the first two-and-a-half years - that ended last year on November 21 - and Shivakumar would take the reins for the remaining period till May 2028. November 21 has come and gone, but there is no sign of Siddaramaiah either stepping down or accepting any truce that grants him continuation till March-May 2026. Counting on his backward class status, Rahul Gandhi's indifference and support of party MLAs (the majority of Karnataka Congress MLAs are actually more loyal to the Congress than to Siddaramaiah, Shivakumar or any regional satrap), Siddaramaiah is hoping for Shivakumar to make just one 'wrong' move to consolidate his position. Kharge's Failures Significantly, Karnataka is the fourth Congressruled state seeing such mayhem under Kharge. The current AICC chief was a party observer for Punjab when a sordid power struggle between the then state unit chief, Navjot Singh Sidhu, Chief Minister Captain



Amarinder Singh blew up. That led to the appointment of Charanjit Singh Channi as a compromise Chief Minister. The 'experiment', a brainchild of Kharge, ultimately backfired as Singh left the party and the Congress lost to the Aam Aadmi Party (AAP) in Punjab. Similarly, it was Kharge who was the point man of the Congress high command on September 25, 2022, the day Rajasthan Chief Minister Ashok Gehlot refused to step down or hold a meeting of the Congress Legislative Party (CLP) amid the long-festering tussle with Sachin Pilot. In December 2018, when the Congress was selecting its Chief Minister for Chhattisgarh, Kharge, as AICC observer, had favoured Bhupesh Baghel, elbowing out TS Singhdeo. Then, too, a compromise, rotational formula was reportedly worked out. But it was never implemented. Thus, in many ways, Karnataka exposes the Congress high command's old problem of indecision. For a party that is struggling to remain competitive nationally, Karnataka is more than just another state. It is the Congress's sole example of a functioning, full-term government with visible governance outcomes.

This alone should have compelled the high command to treat the state with strategic care. Instead, the leadership appears paralysed once again, unable to convey what it intends to do with the 'secret' power-sharing promise that seemed to have brought some peace in 2023. The political temperature in Karnataka is rising. So far, there has been no confirmation or rejection from the high quarters. This lack of clarity has created the oddest of situations: a government that is functioning on paper but is clouded by questions that refuse to go away. Slogans, Signals And A Growing Weariness One does not need sophisticated political analyses to read the signals: slogans for Shivakumar at the Mangaluru airport as Venugopal arrived, supporters in Belagavi openly invoking the name of the man they want as Chief Minister. For any discerning political observer, the tone in these gatherings is not rebellious; it is weary. Workers are asking the party leadership to tell them where things stand. Karnataka, it needs to be emphasised again, is not Punjab, Madhya Pradesh or Rajasthan, where factional rivalry cost the Congress its governments. The stakes are higher.

ERODE: Tamilaga Vettri Kazhagam (TVK) has put in place elaborate arrangements for the campaign meeting to be addressed by party chief Vijay on December 18 in Tamil Nadu's Erode district. The preparations, party leaders said, go beyond the requirements stipulated by the police and are aimed at ensuring the safety and smooth movement of the large crowd expected at the event. The event will be held near Vijayamangalam plaza in Perundurai taluk of the district.

Speaking to reporters at the venue on Tuesday, TVK administrative committee chief coordinator KA Sengottaiyan said the party was organising the meeting with exceptional attention to security,



crowd management, and public convenience. "The arrangements will set a benchmark for public meetings in Tamil Nadu," he said.

According to Sengottaiyan, 40 CCTV cameras have been installed across the venue to monitor crowd movement and enhance security. In addition, 40 walkie-talkies will be used by organisers for

Designated parking areas have been created, including a separate 20-acre space exclusively for two-wheelers, to avoid congestion on nearby roads. Sengottaiyan added that the police have informed the party that around 1,500 personnel

# TN police detain 5 people involved in major cyber crimes

# Former TN CM Panneerselvam likely to float new political outfit

CHENNAI: The political camp led by former Chief Minister Panneerselvam (OPS) has given fresh momentum to speculation about a possible new political outfit with the renaming of the ADMK Workers Retrieval Rights Committee as the All Anna Dravida Munnetra Workers Retrieval Rights Kazhagam.

Statements issued by the OPS-led group since December 14 have been carrying the new title, triggering differing interpretations within the camp.

While one section of functionaries views the change as a clear indication that Panneerselvam is preparing to formally launch a political party, another group has sought



to downplay its significance, describing it as largely a technical modification.

According to functionaries who are cautious about reading too much into the move, the inclusion of the term "Kazhagam" was considered more appropriate in the present political context, particularly for holding discussions on seat-sharing or alliances with other parties. They

also point out that launching and sustaining an independent political party is a complex exercise requiring substantial organisational strength, finances, and

grassroots presence.

Despite the differing views, expectations remain high among a section of OPS loyalists. The newly renamed Kazhagam is scheduled to hold a meeting of its functionaries on

December 23.
Supporters believe

this gathering could set the stage for a major political announcement following day, December 24, which marks the death anniversary of AIADMK founder and former Chief Minister M.G. Ramachandran (MGR). The date carries strong symbolic value within the AIADMK tradition, further fuelling speculation about a possible party Meanwhile,

Meanwhile, the AIADMK headquarters in Royapettah witnessed heightened activity on Monday as the party began issuing application forms to aspirants seeking tickets for the 2026 Tamil Nadu Assembly elections. A large number of party

members queued up at the headquarters to collect the forms, reflecting the early mobilisation within the party ahead of the crucial polls.

Former Minister and AIADMK organisational secretary D. Jayakumar, speaking to reporters, reiterated that the decision on whether to readmit leaders and functionaries who had exited the party rested solely with the party's top leadership. He also confirmed his intention to contest from his traditional Royapuram constituency.As the AIADMK moves ahead with its electoral preparations, the developments in the OPS camp add another layer of political intrigue to Tamil Nadu's already dynamic pre-election landscape.

# TN announces 12-day half-yearly holiday for schools from Dec 24

CHENNAI: The Tamil Nadu School Education Department has announced a 12-day holiday for school students across the state, beginning December 24, following the completion of the ongoing half-yearly examinations.

The extended break comes as a relief for students, as the usual holiday period after the exams is typically limited to a maximum of nine days. Half-yearly examinations for the current academic year have already commenced in government and aided schools.

While examinations for students of Classes 10, 11, and 12 began on December 10, the exams for students studying in Classes 6 to 9 started on December 15.

According to the official schedule, examinations for all classes are set to conclude on December 23. In view of the uniform completion of exams across all classes on December 23, the School Education Department has decided to grant a continuous 12-day holiday from December 24 to January 4. Classes will resume on January 5, officials confirmed. Traditionally, students in Tamil Nadu are granted a half-yearly

vacation immediately after the completion of their examinations. In previous years, the duration of this holiday was generally restricted to nine days. However, this year's calendar has allowed for a longer break due to the alignment of examination schedules across different classes and the festive season.

The holiday period coincides with major celebrations such as Christmas and the New

Year, enabling students and families to observe the festivities without academic pressure. Schools will remain closed throughout this period, and regular academic activities will recommence only after the New Year celebrations. Officials from the Education School Department said the decision was taken to ensure adequate rest for students after the examinations and to maintain uniformity in the aca-

demic calendar.

The extended break is also expected to help students return refreshed for the next phase of the academic year. Parents and students have welcomed the announcement, noting that the longer holiday provides an opportunity for family time as well as preparation for upcoming academic responsibilities.

With schools reopening on January 5, teaching activities will resume as per schedule, marking the beginning of the posthalf-yearly academic session. #### PIL urges SC to protect judicial independence amid row over Madras HC orders

NEW DELHI: A public interest litigation (PIL) has been filed before the Supreme Court seeking urgent directions to protect the independence of the judiciary and to prevent "intimidation and communalisation of judicial orders", following recent rulings delivered by Justice GR Swaminathan of the Madras High Court.

The PIL, filed by advocate GS Mani under Article 32 of the Constitution, stated that the petition has been moved not to defend any



protect the institution of judiciary, ensure rule of law, prevent communal polarisation, and secure uniform enforcement of constitutional norms across the country".

Referring to the controversy that erupted after Justice Swaminathan's orders relating to the Tiruparankundram Deepam issue, the petitioner has alleged that widespread public reactions, including political statements, protests, lawyer demonstrations and social media campaigns, have "crossed"

the constitutionally permissible limits of criticism and entered the realm of scandalising the judiciary, communalisation of judicial acts, and interference with the administration of justice". The petition said that judges cannot be subjected to pressure through street protests or online abuse for their judicial decisions, adding that "the only constitutionally recognised remedy against a judicial decision is through appeal, review or other lawful procedures".

# dragged by foreign fund outflows

Mumbai: indices Sensex and Nifty declined in early trade on Tuesday as persistent foreign fund outflows and weak global market trends dented investors' sentiment. The 30share BSE Sensex declined 363.92 points to 84,849.44 during initial trade. The 50share NSE Nifty dropped 106.65 points to 25,920.65. From the Sensex firms, Eternal, Axis Bank, HCL Tech, Infosys, Tata Steel, and Bharat Electronics were among the major laggards. However, Bharti Airtel, Asian Paints, Tata Motors Passenger Vehicles, and Titan were among the gainers. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index, and Hong Kong's Hang Seng index quoted lower. US markets ended in negative territory on Monday. Foreign Institutional Investors (FIIs) offloaded equities worth Rs 1,468.32 crore on Monday, while Domestic institutional investors (DIIs) bought stocks worth Rs 1.792.25 crore, according to exchange data. "Major equity indices on Wall Street closed lower amid a risk-off sentiment ahead of key economic data



releases, including non-farm payrolls, retail sales, and inflation figures, which could influence the future course of monetary policy. Asian markets also opened lower, with cautious traders paring positions ahead of the Bank of Japan's crucial monetary policy decision later this week," Ponmudi R, CEO of Enrich Money, an online trading and wealth tech firm, said. On the domestic front, persistent FII outflows and continued pressure on the rupee near record lows remain key near-term headwinds, he said. "However, strong par-

ticipation from domestic institutional investors and retail flows continues to provide a cushion against deeper downside risks. In this backdrop, markets are expected to respect key technical levels rather than exhibit aggressive trending behaviour," Ponmudi R added. Brent crude, the global oil benchmark, declined 0.54 per cent to USD 60.23 per barrel. On Monday, the Sensex dipped 54.30 points, or 0.06 per cent, to settle at 85,213.36. The Nifty edged lower by 19.65 points, or 0.08 per cent, to 26,027.30. Shares fell Monday in Asia as China reported investment fell in November in the latest signal that demand in the world's second largest economy remains weak. The retreat followed a dismal end to last week, when declines for superstar artificial-intelligence stocks knocked Wall Street off its record heights Tokyo's Nikkei 225 index shed 1.5% to 50,092.10, as investors wait to see if the Bank of Japan will raise its benchmark interest rate as expected this week. The BOJ's quarterly "tankan" survey of big manufacturers, released Monday, showed a slight improve-

ment in sentiment among such businesses. The measure of those expressing optimism rose to 15 from 14 in the last quarter, the highest level in four years, the central bank said. The index shows the percentage of companies reporting positive conditions minus the percentage reporting unfavourable ones. While the overall survey showed improvement, forecasts for the next quarter were less positive. Japan's economy contracted at a 2.3% annual pace in the July-September quarter, the first such decline in six quarters. An agreement between Japan and the US over the level of President Donald Trump's higher tariffs, limiting baseline import duties to 15%, has helped to reduce uncertainty for big automakers and electronics companies. Analysts said the stronger results may sway the BOJ toward pressing ahead with a 0.25 percentage point rate hike that will take the key rate to 0.75%. The Kospi in South Korea dropped 1.2%, to 4,117.68. In Hong Kong, the Hang Seng declined 0.7% to 25,786.45. The Shanghai Composite index edged 0.1% higher, however, to 3,892.45.

# Ukraine struggling to keep lights on under Russian attack, says energy boss

Ukraine's biggest private energy provider is living in permanent crisis mode because of Russian attacks on the grid, its chief executive has told the BBC. Most of Ukraine is suffering from lengthy power cuts as temperatures drop and Maxim Timchenko, whose company DTEK provides power for 5.6 million Ukrainians, says the intensity of strikes has been so frequent "we just don't have time to recover". Volodymyr President Zelensky said on Tuesday that Russia knew the winter cold could become one of its most dangerous weapons. "Every night Ukrainian parents hold their children in basements and shelters hoping our air defence will hold.' he told the Dutch parliament. As the fourth anniversary of Russia's scale invasion approaches,



Timchenko says Russia has repeatedly targeted DTEK's energy grid with "waves of drones, cruise and ballistic missiles" and his company has found it difficult to cope. Tens of thousands of people in the southern city of Odesa have been without electricity for three days this week, following a co-ordinated Russian attack. "Life has been difficult,

but people are very supportive of each other," says Yana, who is among those lucky enough still to have power. She has invited friends to her home to charge their phones. Power outages also cut off heat and water supplies and Yana says those still connected to the grid have offered strangers the chance to wash or take a shower. Across Ukraine

electricity is being rationed – with supplies turned on for a few hours each day. Many Ukrainians rely on power banks and generators as a back-up, and the sound of generators in the capital is now more constant than the air raid warnings. Kyiv resident Tetiana says the first thing she does in the morning is to check her phone to find

when her power will be switched on. Like many she has invested in power banks to make life more bearable: "You need to remember when you leave home to leave the powerbanks on so that you have them charged when you get back home." About 50% of Ukraine's energy is currently supplied by three large nuclear power plants in central and western Ukraine. But the network that transfers that power has been severely damaged. DTEK runs about 5 power stations, most of them fuelled by coal. One was recently targeted by five 5 ballistic missiles and Timchenko said some of their power plants and sub stations had been attacked "every three or four days". "I don't remember a single day when I had no reports about some damage to our grid." Finding spare parts

out the daily schedule for

to repair damaged equipment has become a significant challenge. The energy provider used to be able to source equipment from within Ukraine, but now it has to scour the ret of Europe for replacement parts. This year DTEK has had to spend \$166m (£123m) on repairing its damaged thermal power plants and coal facilities. 'We will not give up,' Maxim Timchenko insists: "We have a responsibility to millions of mothers to have power and heat". DTEK's origins are in the Eastern Donbas in Ukraine where the fighting is fiercest and where power supplies have been disrupted the most. Eight of its engineers have been killed doing their job. "Every day they risk their lives to keep power in this area," Mr Timchenko said. Additional reporting by Anastasia Levchenko and Kyla Herrmannsen.

# Police 'shot in the front': NSW premier rejects criticism of Bondi response



The New South Wales pre mier has rejected criticism of the police response to the attack on a Jewish festival at Bondi Beach, saying officers acted with "bravery and integrity". Some witnesses have suggested police were too slow to disarm the two gunmen, who killed 15 people and injured dozens in Australia's most famous beach on Sunday. "There are two officers in critical care... at the moment," Chris Minns said after sustained questioning "They from reporters. weren't shot in the back as they were running away. They were shot in the front." The gunmen went on a shooting spree that

before police shot both men, killing one and critically injuring the other. There have also been questions about whether adequate security was provided before the shooting took place. "They shoot, shoot, change magazine and just shoot," one witness. Shmulik Scuri, told reporters the day of the assault, adding he thought officers "froze". Asked about these criticisms, Minns said the "rush to conclusions" about the police operation was "disrespectful". "They didn't take a backward step. engaged the gunmen on the footbridge with handguns.

#### French court sentences ex-DR Congo rebel and politician to 30 years in jail



A French court has sentenced a former rebel leader and politician from the Democratic Republic of Congo to 30 years in jail after finding him guilty of complicity crimes against humanity more than two decades ago. Roger Lumbala headed a rebel movement backed by accused of committing atrocities during a period known as the Second Congo War. The judge said the 67-year-old was found guilty of ordering or aiding and abetting torture and inhumane crimes, summary executions, rape constituting torture, sexual slavery, forced labour and theft. Lumbala, who was living in France when he was arrested nearly five vears ago, has refused to accept the legitimacy of the court in Paris. He did not attend the trial. which began last month, though he was in the dock to hear the verdict on Monday. Lumbala also served as a minister in DR Congo's transitional government from

2003 to 2005 and later as a member of parliament. Several years later the Congolese government issued an arrest warrant for him over his alleged support for the M23, a rebel group currently active in the eastern DR Congo, prompting him to flee to France. The Second Congo War, which raged from 1998-2003, involved nine countries. numerous rebel groups and led to the estimated deaths of between two and five million people. At the time Lumbala led the Congolese Rally of Democrats and Nationalists (RCD-N). which allegedly carried out atrocities during a campaign between 2002 and 2003 called "Erase the Slate". The operation targeted members of the Nande and Bambuti ethnic groups in the northeastern provinces of Ituri and North Kivu who were accused of supporting a rival militia. A UN team that investigated in its aftermath said it was characterised by "premeditated operations using looting, rape and summary execution as tools of warfare". Lumbala's case was prosecuted under the principle of "universal jurisdiction", which allows French courts to seek justice



Lizzo's team has called the lawsuit a "fabricated sob story," but a Los Angeles judge ruled that the case could move forward last year. Arianna Davis, Crystal Williams and Noelle Rodriguez say they were pressured into attending sex shows and interacting with nude performers between 2021 and 2023. The claims against Lizzo - whose real name is Melissa Viviane Jefferson - include that she "pressured Ms Davis to touch the breasts" of a dancer in a nightclub in Amsterdam.

# Eight killed in latest strikes on alleged drug boats, US military says

The US military says it has carried out strikes on three boats it has accused of trafficking drugs in the Pacific Ocean, killing eight people. The US Southern Command posted footage of the strikes on social media and said the vessels were "transiting along known narco-trafficking routes... and were engaged in narco-trafficking". More than 20 vessels in Pacific and the Caribbean have been targeted in recent months, killing at least 90 people, as part of President Donald Trump's escalating campaign against gangs he accuses of transporting drugs in the region. Some experts say the strikes could violate



laws governing armed conflict. The first attack by the US - on 2 September - has drawn particular scrutiny as there was not one but two strikes, with survivors of the first killed in the second. Several legal experts have told BBC Verify that the second strike on the alleged Venezuelan drug boat by

the US military was probably illegal, and would likely be considered an extrajudicial killing under international law. Previously, a former chief prosecutor at the International Criminal Court told the BBC that the US military campaign more broadly had fallen into the category of a planned, sys-

tematic attack against civilians during peacetime. In response, the White House said it had acted in line with the laws of armed conflict to protect the US from cartels "trying to bring poison to our shores... destroying American lives". Defence Secretary Pete Hegseth is expected on Tuesday to brief members of both chambers of Congress alongside Secretary of State Marco Rubio. Politico reported that the officials were set to show video of the controversial "double-tap" incident to all members of the armed services committees of both the House and Senate later this week.

# 'Best of our country': Australian PM visits Bondi hero in hospital



Australia's Prime Minister has visited Bondi hero Ahmed al Ahmed in hospital, after the bystander tried to disarm one of the gunmen in the nation's deadliest gun attack since 1996. "Your heart is strong", PM Anthony Albanese told the father-of-two, later calling him "the best of our country". The fruit shop owner, who was born and raised in Syria, was shot several times in the shoulder after tackling one of the alleged gunmen. Albanese said Mr Ahmed would "undergo further surgery" on Wednesday. At least 15 people have been confirmed dead after Sunday's attack in Sydney during an event to mark the first night of Hanukkah. Police have declared the attack as a terrorist incident targeting the Jewish community. "He was trying to get a cup of coffee and found himself at a moment where people were being shot in front of him," Albanese said after the bedside visit. "He decided to take action, and his

bravery is an inspiration for all Australians. He is a very humble man." "At a moment where we have seen evil perpetrated, he shines out as an example of the strength of humanity," the prime minister added. "We are a brave country. Ahmed al Ahmed represents the best of our country." He later added: "Ahmed, you are an Australian hero." There has been nationwide support for the 43year-old including from US President Donald Trump who commended his courage, and a US billionaire who donated \$99,999 (US\$ 65,000; £49,000) to Mr Ahmed, calling him a "brave hero". In the footage, Mr Ahmed is seen hiding behind a parked car before he leaps out. He runs at the alleged gunman and seizes his weapon, before turning the gun round on him. The suspected attacker then begins to retreat. Mr Ahmed then lowers the weapon and raises one hand in the air, appearing to show police he was not one of the attackers.

## Trump repeats criticism of killed Hollywood director Rob Reiner

US President Donald Trump has repeated his criticism of Rob Reiner - after his earlier remarks about the killed Hollywood director, a longtime Trump critic, sparked widespread condemnation. The US president told reporters the director was "very bad for our country", having earlier written on Truth Social that Reiner's death was linked to "Trump derangement syndrome" - a term he often uses to describe his critics. Reiner and his wife Michele Singer Reiner were found dead at their Los Angeles home on Sunday, and police have arrested their son Nick on suspicion of murder. They have not suggested any motive in the case, or any evidence that Reiner's politics and criticism of Trump played any role. In his social

media post, which called the

couple's deaths "very sad", Trump criticised Reiner, saying: "He was known to have driven people CRAZY by his raging obsession of President Donald J. Trump." Those comments were widely criticised, including by prominent Republicans. Kentucky representative Thomas Massie, a Republican who has clashed with Trump since the president returned to the White House January, wrote on X: "Regardless of how you felt about Rob Reiner, this is inappropriate and disrespectful discourse about a man who was just brutally murdered." He added: "I guess my elected GOP colleagues, the VP, and White House staff will just ignore it because they're afraid? I challenge anyone to defend it." Georgia Republican

Marjorie Taylor Greene, who was once a staunch supporter of Trump before recently becoming a frequent critic, said that "this is a family tragedy, not about politics or political enemies" and that the murders should be "met with empathy". Multiple other senior members of Trump's party appeared to distance themselves from the remarks. Senator John Kennedy, a Republican rep-

resenting Louisiana, said he thought Trump should not have made the comments. "I think a wise man once said nothing. Why? Because he was a wise man," Kennedy said. "I think President Trump should have said nothing. I think when the president says these sorts of things, it detracts from his policy achievements." Reiner was a lifelong Democrat and prominent liberal activist, and fre-

quently spoke out against Trump. In 2017, for example, he called Trump "mentally unfit" for office. And as recently as October.

Reiner said he believed Trump was ushering in an age of "full-on autocracy" in the US. Hours after his social media post, Trump repeated his thoughts on Reiner in comments given in the Oval Office to reporters, describing the director as a "deranged person" who was partly "behind" previous claims of collusion between Russia and Trump's team, "I was not a fan of Rob Reiner at all, in any way, shape or form," he said. Trump has in the past criticised political foes after their death. Following the death of Arizona Senator John McCain - with whom he clashed regularly - in 2019, for example, Trump said he "was never a fan" and "never will be". In another incident the same year, Trump quipped that the late Democratic law-maker John Dingell could be "looking up" at him from the grave, a comment which was widely interpreted as a suggestion that Dingell was in hell. In a statement following the remarks about Dingell, the White House said that the president was "just riffing".

Reiner, who was 78, was known for directing several iconic films in a variety of genres, including This is Spinal Tap, Stand By Me, Misery and A Few Good Men. He married Michele, an actress, photographer and producer, in 1989, later recalling that they met during the making of one of his best-known films, When Harry Met Sally.

The 29year-old Aquib from Jammu and Kashmir, causing mayhem in domestic cricket with his skillset as a pacer, finally got a home in the biggest league in the world. On the other hand, Veer was picked by CSK for a massive Rs 14.20 crores and could fill in the big shoes of Ravindra Jadeja, one of the franchise's biggest match-winners. For Aquib, DC started the bid, and eventually Rajasthan Royals (RR) and Royal Challengers Bengaluru (RCB) entered the fray.

However, the club's European success was not mirrored in the Premier League, with Tottenham finishing in place in Postecoglou's final season in charge. ## Who Is Abhigyan Kundu? India U19 Star And Vaibhav Suryavanshi's Teammate Who Slammed

India star Abhigyan Kundu made history on Tuesday as he slammed 209 off 125 balls against Malaysia in a U-19 Asia Cup match in Dubai. Kundu brought up his double century in 121 balls. En route to his double ton, Kundu surpassed Ambati Rayudu (177) to register the highest score by an Indian in U-19 ODI cricket. He also beat Vaibhay Suryavanshi to record the highest individual score of tournament. Ultimately, Kundu finished on 209 off 125 balls, hitting nine sixes and 17 fours. Kundu broke South Africa's Jorich van Schalkwyk's record (145 balls) by scoring the fastest double ton in U-19 ODIs. Kundu's 209 is the second-highest individual score in the history of U-19




Schalkwyk's 215 against Zimbabwe. However, all his records wont be counted as he achieved the feat against an associate nation. His knock powered India U-19 to a huge 408 for batting first. seven Abhigyan Kundu is a talented wicketkeeper-batter. Against Pakistan, the leftand safely took a couple of catches. He was born on April 30, 2008, and represents Mumbai at the state

Walking in after the dismissal of Suryavanshi, Kundu scored boundaries right from the get-go. He formed a 181-ball 209-run partnership with Trivedi and then added another 87 handed batter scored 22 runs off just 36 with

Kanishk Chouhan. Abhigyan Kundu smashed boundaries slammed nine sixes. While Kundu reached his fifty off just 44 balls, the left-handed batter brought up his century in just 80 balls, setting the stage for the late innings blitz. The final stages of the innings saw him unleash an array of strokes, bringing up the historic double century in just 121 balls. Kundu's unbeaten 209 not only helped India set a target of 409 but also surpassed Ambati Rayudu's previous record for the highest score by an Indian in Under-19 ODIs--177\*. The only other double-centurian in Youth ODIs is South Africa U19's Jorich Van Schalkwyk, who scored 212 off 153 balls against Zimbabwe U19s in 2025.

#### Teenager Flagg makes history in Mavericks defeat



Cooper Flagg became the youngest player in NBA history to score at least 40 points in a game as the Dallas Mavericks lost 140-133 after overtime to the Utah Jazz. The number one pick at this year's Draft, the 18-yearold forward finished with 42 points, seven rebounds and six assists at Delta Center in Salt Lake City. Only Cliff Robinson (45), GG Jackson (44) and LeBron James (43) have scored more points in a game as a teenager, while Flagg equalled Mark Aguirre's record for a Mavericks rookie. Flagg, who turns 19 on Sunday, is the third teenager in the league's 79-year history - after James and Kevin Durant - to claim 40 points, five rebounds, and five assists. The Mavericks led 75-71 at half-time - by which time Flagg had 24 points - and 124-116 late in the fourth quarter. However, after blowing their eight-point lead to 129-127, trail

required two free throws from Max Christie with less than five seconds remaining to level the game. The Jazz dominated overtime to register their 10th win of the season as Keyonte George finished with 37 points and Lauri Markkanen 33. The Jazz are 10th in the Western Conference and the Mavericks 12th. The 6ft 8in Flagg became the first freshman to be named Maine Player of the Year after leading high school Nokomis Regional to the state title in 2021. He transferred to Montverde Academy in Florida, winning the 2022 USA Basketball Male Athlete of the Year and 2024 National High School Player of the Year awards. He was part of the USA side that won the 2022 Under-17s World Cup and was named in the all-tournament team. In 2024-25 Flagg averaged 19.2 points, 7.5 rebounds, and 4.2 assists in a 37game debut season for Duke University.

However, the narrative keeps circling back to my character, giving it significant importance. Roles like these don't come often. No character in this film exists merely to fill space. Everyone matters.

### Is Dhandoraa a message-oriented film? I wouldn't call Dhandoraa a purely

message-driven film. It's a well-balanced commercial entertainer that blends emotion, drama, and realism. The film has strong emotional layers, but it never feels preachy. What really impressed me was the screenplay. It flows organically and feels very natural. Dhandoraa is, quite simply, a beautifully made film.

## Since this comes after Court, expectations are naturally high. Does your role live up to them?

The response I received for Mangapathi in Court was overwhelming, and I'm confident the character in Dhandoraa will have a similar impact. As an actor, you need a lot of luck to be offered such layered roles. This character has multiple shades and allows me to explore a wide emotional range. The film itself is content-driven and emotionally engaging from start to finish

There have been comparisons to films like Vedam and C/o Kancharapalem when it comes to portraying sensitive characters. How is it handled here? In Dhandoraa, Bindu Madhavi's character has been portrayed with a lot of dignity and class. The treatment is very respectful, and audiences will genuinely connect with both the character and the situation.

## It seems like new directors are approaching you more these days. Any thoughts on that?

I've mostly been working with new directors, and I actually enjoy that. Many filmmakers here tend to overcalculate and hesitate, even when there's so much acting talent within our own industry. Instead, they often look outside. In Dhandoraa, actors like Navdeep, Nandu, and Ravi Krishna are all exceptional performers. Unfortunately, we sometimes underestimate our own people.
