#### Peak coldwave likely across Telangana...

HYDERABAD: The city and several parts Telangana are likely to experience a peak coldwave between December 18 and 21, with temperatures expected to dip further over the next four days, according to weather observers.

According to weather enthusiast T Balaji, parts of Hyderabad may witness 7–9 degrees Celsius making it one of the coldest spells of the season so far.

Minimum temperatures are forecast to fall below 6 degrees Celsius in parts of north and west TelanganaFor the last 10 days, Telangana has been reeling under intense coldwave conditions, especially during early morning and night hours. Residents have been advised to take precautions against the cold.

#### SIR in 3 states, 2 UTs: Over 1 cr electors left out of draft electoral rolls

**NEW DELHI**: As many as 12.32 crore electors have found their names in the draft electoral rolls of three states and two Union territories published on Tuesday as part of the ongoing special intensive revision as compared to the 13.36 crore people who were part of the voters' list on October 27. Election Commission officials said the names in the draft electoral rolls also include new voters who had filled up Form 6 to become part of the electorate.

In West Bengal, out of 7.66 crore electors as on October 27, as many as 7.08 crore were included in the draft electoral rolls, a net difference of 58 lakh. EC officials said the electors who did not return the enumeration forms have been included in the last of ASD -- absent, shifted, dead/duplicate


#### Centre clears major boost for digital governance

The review was conducted through webcasting facilities at the State Election Office, along with State Election Commissioner Kumudini.

to ensure greater transparency in the polling process. He observed that the use of technology in elections helps reduce law and order issues in villages and enhances public confidence, which in turn is likely to improve voter turnout. The Chief Secretary noted that compared to the polling percentages recorded during the first and second phases, voter turnout in the third phase is expected to be higher. He congratulated district collectors, election officials and polling staff for ensuring the smooth and peaceful conduct of the elections.

### **Telangana Speaker dismisses petitions** for disqualification of five BRS MLAs

Assembly Speaker Gaddam Prasad Kumar on Wednesday dismissed the petitions to disqualify five BRS MLAs who allegedly shifted loyalties to the ruling Congress.

Pronouncing the orders on the petitions for disqualification of the MLAs, the Speaker said the petitioners failed to provide evidence that they defected to the Congress.

The Speaker ruled that the anti-defection law does not apply to the MLAs Tellam Venkat Rao, Bandla Krishna Mohan Reddy, T. Prakash Goud, Gudem Mahipal Reddy, and Arekapudi Gandhi.

He made it clear that the MLAs are technically still in Bharat Rashtra Samithi (BRS).

The Speaker pronounced the orders on the petitions for the disqualification of five out of 10 BRS MLAs for allegedly switching loyalties to the ruling party. He had completed the hearing on the petitions



for the disqualification of eight MLAs and reserved the orders. The Speaker is likely to pronounce on Thursday orders on the disqualification of three other MLAs - Kale Yadaiah, Sanjay Kumar, and Pocharam Srinivas Reddy

The decision on the disqualification of two other MLAs, Nagender Danam Kadiyam Srihari, is likely after they submit their replies to the notices served on them.

They sought more time to respond to the notice sent by the Speaker last month.

### Air pollution: SC asks NHAI, MCD to consider shifting or closing 9 toll plazas at Delhi borders

**NEW DELHI (TSIT)**: Taking a serious note of the severe air pollution levels in Delhi-NCR, the Supreme Court on Wednesday issued a slew of directions and asked the NHAI and the MCD to consider either temporary closing or relocating the nine toll plazas of the civic body at borders of the national capital to ease usual massive traffic congestion.

The top described the pollution



crisis as an "annual feature" and called for pragmatic and practical solutions to tackle the menace and modified its own interim order of August 12 and permitted the authorities to take coercive action against older vehicles that do not meet Bharat Stage-IV (BS-IV) emission standards.



# CM Naidu calls for outcome-oriented governance at collectors' conference

Amaravati: Chief Minister N. Chandrababu Naidu on Tuesday called for outcomeoriented governance and meaningful reviews while inaugurating the District Collectors' Conference, urging officials to focus on results rather than routine discussions and procedures.

Emphasising the need for continuous learning, the Chief Minister said officers and public representatives must remain lifelong learners and constantly upgrade their knowledge to contribute effectively to development. He said feedback was being actively

gathered to improve public governance and ensure better delivery of services.

Naidu said the conference would focus on achieving clear targets related to Gross State Domestic Product (GSDP), Key Performance Indicators (KPIs) and Sustainable Development Goals, with an emphasis on measurable outcomes. He cautioned against systemic loopholes being used to evade responsibility, particularly in the Revenue Department, where files are often passed without resolution, and directed that all public grievances be addressed through data-



driven decision-making.

Referring to recent initiatives, the Chief Minister expressed satisfaction over issuing appointment letters to 5,757 newly recruited constables. He recalled an instance where a constable highlighted the absence of a road in his village, leading to on-the-spot sanction of Rs.3.90 crore for road construction after informing the Deputy Chief

Praising the Deputy CM's administrative efficiency, Naidu also highlighted Minister Nara Lokesh's role in bringing a Google Data Centre to Visakhapatnam. He directed all departments to fully adopt online file processing and digital service delivery.

The Chief Minister said several Central government-sponsored schemes weakened earlier had been revived, while the "Super Six" welfare programmes were successfully implemented to uplift backward sections. He listed key initiatives such as timely social security pensions, benefits under Talli Ki Vandanam, Rs.14,000 assistance to farmers under Annadata Sukhibhava in two instalments, and implementation of schemes like Deepam 2.0, Stree Shakti, Mega DSC and constable recruitments.On the development front, Naidu said investments worth Rs.11.20 lakh crore were secured at the Global Partnership Summit in Visakhapatnam, while projects worth Rs.8.50 lakh crore

### 21 Lakh Title Deeds to Be Distributed by Sankranti: Revenue Minister



Amaravati (TSIT) :Andhra Pradesh Revenue, Registration and Stamps Minister Anagani Satyaprasad announced that 21 lakh pattadar passbooks will be distributed in re-surveyed villages by the Sankranti. coming Addressing the Collectors' Conference at Secretariat, the Minister said Re-Survey 2.0 is being implemented effectively and directed collectors to create awareness among farmers and landowners to subdivide joint LCMs up to two lakhs.

He instructed that public grievances be received daily, not limited to a single day, and stressed that Joint Collectors must devote adequate time to resolving revenue issues. Nearly one lakh complaints on land reclassification should be disposed of immediately, he said. The Minister announced that collectors already have powers to cancel illegal registrations of government land, and soon will be empowered to cancel illegal registrations of private lands, with guidelines to be issued shortly. Collectors were also directed to inspect land allotted to companies and projects and submit field-level reports to enhance state revenue.

Highlighting investment growth, he said the state attracted over Rs.20 lakh crore in investments in the last 18 months, calling it a historic achievement under the coalition government. He urged officials to work as a team to ground these investments and create 20 lakh jobs for youth. Emphasizing responsible governance, the Minister said people see collectors as the face of the government and called for vigilance and public awareness against wrong-

#### **CPM Slams Smart Meter Push, Alleges Corporate Nexus and Public Burden**

Vijayawada:The CPM has strongly opposed the installation of electricity smart meters in Andhra Pradesh, alleging that the coalition government has gone back on its promises and is forcibly imposing the meters on consumers. Addressing a press conference at the CPM district office in Vijayawada, CPM state committee member C.H. Baburao and leader Kasinath accused the government of issuing notices threatening disconnection of power supply if smart meters are not installed.

They said the government, which earlier assured that meters would not be installed without public consent, is now acting contrary to its own assurances. The CPM alleged that functional existing meters are being removed and replaced with smart meters, imposing an estimated burden of Rs.25,000 crore on nearly two crore consumers in the state.

Baburao alleged that the move is aimed at benefitting corporate interests, particularly the Adani group, and accused both the Centre and the state government of pushing privatisation of the power distribution system. He said consumers would be forced to bear costs ranging from Rs.8,000 to Rs.15,000 per smart meter, to be collected in instalments over 93 months, along with higher tariffs through prepaid and time-of-day bill-



The CPM leaders termed the notices issued by power officials in Vijayawada as "intimidation" and called the installation of smart meters illegal and against earlier commitments. They claimed public protests have already stalled smart meter installation in several areas, including agricultural connections.

Calling for intensified public resistance, the CPM demanded immediate withdrawal of notices, removal of installed smart meters, and cancellation of all smart meter agreements. The party said it would join hands with people and left parties to intensify the movement against what it called a "corporate-driven attack" on the power sector and consumers.

Amaravati, August 17, 2 5 Dinakar, Chairman of the Twenty-Point Programme (Viksit Bharat - Swarna Andhra), Pradesh Andhra Government, has said that structural reforms to the existing Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGA) are essential to match present-day realities.

After a comprehensive review of all 26 districts under the leadership of Chief Minister N. Chandrababu Naidu, the need for revamping the scheme became evident. The proposed "Viksit Bharat Rozgar and Aajeevika Guarantee Mission (Rural) (VB-G RAM G) Bill, 2025" aims to



ensure guaranteed employment in rural areas, creation of quality assets, transparent implementation, and prevention of fund misuse. Key reforms include increasing guaranteed employment from 100 to 125 days per rural household annually, while retaining the provision for unemployment allowance if work is not provided

### Indian Railways provides free Wi-Fi at 6,117 stations; CCTV surveillance expanded across network

New Delhi: Indian Railways has provided free Wi-Fi services at 6,117 railway stations across the country, while strengthening passenger safety through extensive deployment of CCTV surveillance systems at stations and in coaches, Parliament was informed on Tuesday.

In a written reply to questions in the Lok Sabha, Union Minister for Railways, Information & Broadcasting, and Electronics & Information Technology Shri Ashwini Vaishnaw said no separate funds were sanctioned by the Ministry of Railways for providing Wi-Fi services at railway stations. To access the facility, passengers are required to provide only their mobile number for OTP verification, and no other personal information is sought. He added railway authorities promptly address any issues related to the functioning of services.

On passenger security, the Minister said the installation of CCTV cameras at stations and coaches is an ongoing process. So far, CCTV surveillance systems have been installed at 1,731 stations and in 11,953 coaches to ensure a safe and secure journey for passengers. These systems are funded under capital expenditure.At New Delhi Railway Station, CCTV coverage has been significantly enhanced. Cameras already cover outdoor areas such as entry and exit points, foot over bridges and platforms, as well as indoor areas including waiting halls and ticket counters. Following the development of new areas after February 15, 2025, additional cameras have been installed. At present, 250 CCTV cameras are operational at the station. The measures reflect Indian Railways' continued focus on improving passenger amenities and strengthening security infrastructure across the national rail network.

## Goa nightclub fire: Luthra brothers deported from Thailand, taken into police custody

**NEW DELHI:** Gaurav Luthra and Saurabh Luthra, co-owners of the Birch by Romeo Lane nightclub in Goa where a massive fire killed 25 people, were arrested on Tuesday as soon as they landed in Delhi after being deported from Thailand.

The brothers arrived in the Indian capital in an Indigo flight and were immediately handed over to authorities for further legal proceedings, 10 days after a blaze tore through the Birch by Romeo Lane nightclub in Arpora in North Goa.

Gaurav, 44, and Saurabh, 40, will be produced before a Delhi court where the Goa police will seek their transit remand. They were questioned at the airport, the formalities taking several

Several reporters and camerapersons were travelling on the flight. As the plane landed in Delhi, a TV reporter attempted to record the Luthra brothers inside the aircraft, prompting accompanying officials to tighten security around the two men and prevent them from talking to



anybody.

The Luthra brothers are facing a case of culpable homicide and negligence following the December 6 tragedy, which investigators allege was compounded by the nightclub operating in violation of mandatory fire safety norms. The incident raised serious questions over alleged fire safety violations and lapses by the management.

Gaurav and Saurabh fled to Phuket in the early hours of December 7, hours after the fire at their nightclub, prompting the authorities to issue an Interpol Blue Corner Notice and cancel their passports.

The duo was detained by Thai est litigation (PIL).

authorities at Phuket on December 11 following a request from the Indian government which later coordinated with officials in Thailand to deport them under legal treaties between the two

On December 11, a Delhi court rejected the transit anticipatory bail pleas. Additional Sessions Judge Vandana termed the allegations against the brothers "prima facie grave and serious" and severely criticised their "conduct.

The court took note of the police investigation that the brothers had booked tickets to Phuket one hour after the fire, a fact their counsel had initially "concealed" while seeking protection from immediate arrest.

The judge said that leaving immediately after the tragedy was a clear attempt to "evade the legal process". Observing that "someone has to be held accountable' for the tragedy, the Goa bench of the Bombay High Court on Monday converted a civil suit against the nightclub into a public inter-

### **Kolkata Police Commissioner says Messi** event schedule changed at last minute

Kolkata, Dec 17 Police Kolkata Commissioner Manoj Verma on Wednesday said that Argentine football star Lionel Messi's event schedule at the Salt Lake Stadium was changed at the last minute and that following the change, the police department did not hear from the organiser anymore.

According to the police commissioner, Messi was initially scheduled to stay at the Taj Bengal, which falls under the jurisdiction of Kolkata Police. Later, the event schedule was altered and Messi stayed at the Hyatt, located adjacent to the Salt Lake Stadium, which comes under the jurisdiction of Bidhannagar Police.Speaking at the inauguration of the

Kolkata Police's annual sports competition, Manoj Verma said: "Satadru Dutta had come to talk about Messi staying at the Taj Bengal. But after the event was shifted to a different location, there was no further discussion

Satadru Dutta is currently in police custody. From the beginning, there were allegations that the chaos at the Salt Lake Stadium on December 13 broke out due to the presence of a large number of political leaders, celebrities and organisers.

Everyone knew from the start that Messi would be staying at the Hyatt. However, it is alleged that he was initially supposed to stay at the Taj Bengal, and after the change to a different five-star hotel, Satadru Dutta did not contact the Kolkata Police.

On Tuesday, the committee formed by the Chief Minister and headed by retired Justice Asim Kumar Roy submitted its preliminary report on the incident.The committee also includes Chief Secretary Manoj Pant and Home Secretary Nandini Chakraborty.

The police have been asked to submit a report on their role on the day of the incident, how the arrangements were made, and how surveillance was conducted. Reports were sought from the police and the sports department within 24 hours.On December 13, the Salt Lake Stadium was full long before Messi's event

## Indian Railways nears full electrification with 99.2% of broad gauge network powered

New Delhi: Indian Railways is on the verge of achieving complete electrification, with 99.2 per cent of its Broad Gauge (BG) network already electrified, placing it far ahead of several major global railway systems, including the United Kingdom, Russia and China.

In a written reply to a question in the Lok Sabha on Tuesday, Union Minister Railways, Information & Broadcasting and Electronics & Information Technology Shri Ashwini Vaishnaw said railway electrification has been taken up in mission mode. While 21,801 route kilometres were electrified in the nearly 60 years prior to 2014, as many as 46,900 route kilometres were electrified between 2014 and 2025, reflecting a significant accelerain progress. According to the latest International Union of Railways (UIC) report of June



2025, India's electrification level of 99.2 per cent surpasses that of the UK (39%), Russia (52%), France (60%), Spain (67%), Japan (64%) and China (82%). with only Switzerland achieving 100 per cent electrification.

During the financial years 2023-24 and 2024-25, Indian Railways electrified 7,188 route kilometres and 2,701 route kilometres respectively. The Minister also noted that all new line and multi-tracking projects are being sanctioned and constructed with elec-

Electrification has been completed 100 per cent in 14 railway zones, including Central, Eastern, Northern, South Central, Western and East Coast Railways, among others. Several other zones, such as North Western, Southern, Northeast Frontier and South Western Railways, are nearing full electrification.

At the state and Union Territory level, 25 States/UTs have achieved 100 per cent electrification, including Andhra Pradesh, Telangana, Bihar, Jharkhand, Kerala, Maharashtra, West Bengal and all Northeastern states with existing BG networks such as Arunachal Pradesh, Meghalaya, Nagaland, Tripura and Mizoram. States like Rajasthan, Tamil Nadu, Karnataka, Assam and Goa are close to completion, with electrification works underway on the remaining sections.

The Minister said electrification timelines depend on factors such as forest and statutory clearances, shifting of utilities, terrain conditions, law and order situations and climatic constraints. However, efforts are ongoing to complete the remaining sections at the earliest.

Highlighting environmental benefits, Shri Vaishnaw pointed out that rail transport emits only 11.5 grams of CO per tonne-kilometre, compared to 101 grams for road transport, amounting to nearly 89 per cent lower emissions, as per a NITI Aayog report.

He reiterated that Indian Railways is committed to sustainable operations through near-total electrification and increasing use of renewable energy sources such as solar and wind power, contributing significantly to the reduction of carbon footprint in the transport sector.

## "It Was A Shell From My Tank": When A Father Met The Pak Soldier Who Killed His Son

Reality can hit you harder than any fiction that appears on the big screen. That's true for the film Ikkis, which tells the story of 2nd Lt. Arun Khetarpal, who was just 21 years old (hence the film's name) when he laid down his life on December

#### That Fateful Trip To Lahore

Ikkis has an additional plot point that unfolds a full 30 years after the martyrdom of one of India's youngest Param Vir Chakra awardees. This is how it unfolds... At the fabled Battle of Basantar - said to be the second biggest tank battle since World War 2 - fought on the Indo-Pak border on December 16, 1971, in the Shakargarh-Samba sector between Pathankot and Jammu, Arun Khetarpal, who was serving in 17 Poona Horse tank regiment, destroyed 10 Pakistani tanks before a shell fired from one claimed his life. Of course, Khetarpal's parents mother Maheshwari, and father, retired Brigadier Madan Lal Khetarpal, himself a WWII veteran who also fought in the 1948 and 1965 Indo-Pak wars - were proud of Arun's courage on the battlefield, but they struggled with the pain of losing a son so early. Madan Lal Khetarpal, like many others of his generation, hailed from across the border. His roots lay in the town of Sargodha, which is in present-day Pakistan, not far from Lahore. He had studied at Lahore's well-known Government College before joining the army. "Papa always wanted to go back to Sargodha, the place of his birth, his 'watan'. He doubted he would get a visa, as he was ex-Army. But in 2001, when he was 81, he and four others were invited to a Lahore Govt College Students' Reunion. When he got his visa, he was very excited," recalls Mukesh Khetarpal.

Upon reaching Lahore, Madan Lal accepted the request of retired Pakistan Army Brigadier, Khawaja Mohammad Naser, to stay at his home during the reunion. Naser was also an alumnus of the Government College in Lahore. "Brigadier Naser was a good host. He even organised my father's visit to Sargodha on the second day of his stay. Papa was very touched. On the third and last morning, Brigadier Naser took him for a walk, saying he had something to share with him," Mukesh recounts. "Papa was just not prepared for what Brigadier Naser said next. He said, 'Sir, I am from the 13 Lancers tank regiment, and on 16th December 1971, I was a Major, commanding a squadron of tanks that was confronted by the tanks of 17 Poona Horse."

'My father's immediate response was, "Mera beta Arun bhi 17 Poona Horse mein tha.." ("my son, Arun, was also in 17 Poona Horse." Then came the shock: "I know, sir. It was a shell from my tank that killed Lt Arun."

"My father was stunned by the revelation. For a few moments, he said nothing. Brig. Naser went on - 'Sir, at the Battle of Bade Pind [that's what the Pakistan Army calls the battle], Lt. Arun stood like a rock before our Patton tanks. He was a brave soldier and the main reason for our defeat that day..."

"Recovering some composure, my father asked Brig. Naser, 'How did you find out Arun's name? How did you know it was his tank?"

Mukesh Khetarpal, now well into his 70s, recounts the story thus: "16th December was the last day of the 1971 war; the Pakistan Army surrendered in Dhaka that day. Brig. Naser told my father that by the 17th, the ceasefire was in force, and as he was recovering the bodies of Pakistani soldiers, he saw Indian soldiers around Arun's tank. "Naser added: 'Sir, I asked the Indian soldiers about the officer who had fought bravely commanding this tank. The soldiers told me, 'Sahab shaheed ho gaye' ['he has been martyred']. When I asked them his name, they said he was Arun Khetarpal. I have never forgotten his name, sir."

# Hansi: From the centre of history to the margins and then to the district's threshold

(Hansi: History snatched the district, time returned it)

Hansi was once the capital of the Haryana region. During the reign of George Thomas, it served as an administrative and commercial center. During the Mughal period, a mint and a military cantonment were established here. Due to intense resistance against the British in the 1857 rebellion, Hansi was stripped of its district status, and Hisar was created around 1870-1880. Following the formation of Haryana in 1966, Hisar was reorganized several times. In 2025, Hansi was announced as a district, a move seen as historical justice. History never changes suddenly; it takes a gradual turn. The ancient city of Hansi in Haryana is a living example of this. Once considered one of the most important centers of power, administration, trade, and strategic importance in northern India, this same city was a significant center of governance for centuries. Today, after enduring years of administrative neglect, Hansi is once again moving towards regaining its identity as a district. The announcement of Hansi's new district status in 2025 is being seen not just as an administrative decision, but as an attempt to complete an unfinished chapter of history. Hansi's glory was at its peak long before the British arrived in India. During the reign of George Thomas, Hansi served as the capital of the Haryana region. At that time, the city was one of the major trading centers of northern India under the Delhi

Pargana. Administrative orders

were issued from Hansi, and the British not only altered the surrounding area was governed. This city was not only a center of power but also a major hub of trade, cultural exchange, and military strategies. Hansi's importance remained undiminished even during the Mughal period. Historical documents and maps from Akbar's reign depict Hansi as an important Mughal center. A mint was established here, where coins were minted. The presence of a mint in any city was considered a symbol of its economic and administrative strength. This clearly demonstrates that Hansi was not just a town, but a vital pillar of the economy of that era. Hansi's geographical location also made it extremely strategically important. Located on the routes leading to Delhi, Punjab, and Rajasthan, the Mughals established a military cantonment here. Later, the British, recognizing this strategic importance, maintained a military presence here. Hansi's fortifications, administrative structure, and military system made it one of the safe and organized cities of northern India. But the course of history changed with the First War of Independence of 1857. Hansi and the surrounding areas openly revolted against British rule. This region was among the areas where the British faced the most intense resistance. Local people, soldiers, and landlords challenged British authority. This rebellion was not just a law and order problem for the British, but a direct challenge to their authority. Following the 1857 rebellion, the British adopted a policy of retaliation. Areas that offered the most resistance were administratively weakened. Hansi also fell victim to this policy. Although there is no precise and authentic date for Hansi's district status, historians believe that between 1870 and 1880, the British shifted the district headquarters from Hansi to Hisar, establishing a new district. This virtually eliminated Hansi's administrative importance. By making Hisar a district, the

administrative structure but also marginalized Hansi's historical role. Areas like Fatehabad and Sirsa were governed from Hisar. This change was not merely a matter of convenience, but a strategy to control a region that had dared to rebel against British rule. Historians also point out that around 1700 AD, Haryana existed on maps with a distinct geopolitical identity separate from Punjab. Many maps from that period are still available, showing Hansi as the capital of Haryana. George Thomas ruled the entire region with Hansi as his primary center. This clearly demonstrates that Hansi's importance was not limited to a single ruler or period; rather, it remained a center of power for a long time. After independence, when the state of Haryana was formed in 1966, Hisar was the largest district in the state. At that time, Hansi was hoping to regain its historical status. However, administrative priorities and political balances prevented this from happening. Instead, Hisar district was periodically reorganized. Bhiwani was made a separate district in 1972. Sirsa was followed by district status in 1975 and Fatehabad in 1997. Charkhi Dadri became a new district in 2016, splitting from Bhiwani. All these divisions have continually altered and reduced the administrative map of Hisar, but Hansi has remained excluded from the district list each time. This neglect gradually led to discontent in Hansi. People began to feel that this was not merely administrative neglect, but rather an extension of historical injustice. Over the past ten years, the demand for Hansi to become a district began to gain momentum. Local social organizations, trade associations, and political representatives consistently raised the issue. This demand gradually took the form of a mass movement. The people of Hansi argued that the city met all the criteria for becoming a district—historically, geographi-

cally, and administratively. Several administrative offices already existed Considering the distance from surrounding areas and population pressure, becoming a district was considered logical. But above all these arguments, there was also an emotional aspect—the desire to restore Hansi's lost prestige. When Hansi was announced as a new district in 2025, it wasn't just seen as an administrative news. This announcement was seen as the culmination of Hansi's history, struggle, and wait. People saw it as a partial rectification of the injustices inflicted by the British after 1857, which had long been ignored in independent India. The creation of Hansi as a district is also an important step towards administrative decentralization. This will not only provide better administrative facilities to the local people but will also accelerate regional development. New opportunities are likely to arise in areas such as education, health, roads, and employment. This decision will also strengthen regional balance. History shows that cities removed from the center of power are marginalized not only geographically but also psychologically. Hansi suffered this fate for a long time. But now, with the creation of a district, the city is poised to return to the center of attention. The story of Hansi also teaches us that history isn't just a collection of events recorded in books, but it also influences current policies and decisions. The establishment of Hansi as a district is proof that history, even if delayed, always finds its rightful course. Today, as Hansi stands on the threshold of districthood, it marks not just the expansion of an administrative unit, but the restoration of the soul of a city that once provided Haryana with its capital, that defied authority, and that endured long periods of neglect, yet remained true to its identity. This new chapter for Hansi connects with the same old glory of history from which its journey began.

## Redefining Aravali, The Oldest Hills Chain: Why A Matter Of Concern?

The coming generations will hardly believe that there was a chain of the oldest mountains, namely the Aravali hills. on Indian earth and they will read only in the books that the hills spread over 800 km from Gujarat to Delhi, through Rajasthan and Haryana, ever actually existed. Reason: The recent Supreme Court decision. On November 20, 2025, a Supreme Court bench passed a vital judgement over the definition of the Aravalli Hills, India's oldest mountain range, accepting the recommendations made by a committee spearheaded by the Union Ministry of Environment, Forest and Climate Change (MoEFCC). The Court ruling has narrowed the new definition of the Aravalli hills to the extent of 100 metre elevation threshold, resulting in the outage of hills parts below 100 meters height from the definition of mountains category, which will exclude over 90% of the range from protection, allowing large-scale mining. The former Chief Minister of Rajasthan, Ashok Gehlot warns that this decision is not about environmental protection; it is a 'red carpet' for mining mafias. History will never forgive the injustice the government is inflicting upon future generations by inviting the Thar Desert right up to Delhi's doorstep. This recent controversial redefinition will have severe negative effects on the environment and public health in North-West India, particularly the Delhi-NCR region. Ashok Gehlot tweeted on December 16,2025, "The Aravalli range is not just a mountain for Rajasthan; it is our 'protective

shield.' Limiting it to a '100-meter' scope based on the Union Government's recommendation is tantamount to signing a 'death certificate' for 90% of the state's Aravallis. The most alarming fact is that 90% of the Aravalli hills in Rajasthan are lower than 100 meters in height. If these are excluded from the definition, it is not merely a change of name, but the removal of a legal shield. This directly implies that the Forest Conservation Act will no longer apply in these areas, allowing for unfettered mining." Supporting his point, Gehlot states that a mountain is defined not by its height, but by its Geological Structure. A small rock is part of the same tectonic plate and mountain range as a towering peak. Separating the two is scientifically irrational. How will the vanishing Aravali chain affect the environment and ecological balance? Mr. Gehlot explains that the Aravalli is a wall that prevents the Thar Desert from expanding. Experts warn that even smaller hills (ridges) of 10 to 30 meters are equally effective in blocking dust storms. Opening these small hills to mining is akin to personally inviting the desert to expand into Delhi and Eastern Rajasthan. The rocky structure of the Aravallis intercepts rainwater and channels it underground.

These hills act as groundwater recharge zones for the entire region. Removing them is an invitation to drought in North-West India, a region already grappling with water scarcity. The Aravalli is the barrier that stops the deadly heat waves from the west and prevents the Thar Desert from encroaching upon the fertile plains of Eastern Rajasthan, Delhi, and Uttar Pradesh. Kumari Selja, a former Union Minister, and Sirsa MP, in a press statement on 3rd December, criticizing the decision to remove hills below 100 metres in height from mining restrictions in the Aravalli mountain range, calling it a reckless assault on India's environment and the future of generations to come, said the decision is anti-environment, destructive, and a result of the government's misguided policies that are pushing natural resources towards a crisis. Kumari Selja said the Aravalli is not merely a mountain range-it is the ecological lifeline of North India. It protects the Rajasthan-Haryana-Delhi region from desertification, plays a critical role in water conservation, and safeguards the livelihood and lives of millions of people. In such a situation, giving mining mafias a free hand is utterly irresponsible. She added that the government's move is a dangerous step towards legalising illegal mining and destroying the environment. The destruction of Aravalli hills will directly and severely impact water sources, greenery, groundwater levels, and public health. Kumari Selja warned that Haryana and Delhi-NCR are already facing severe pollution and water scarcity. Weakening the Aravalli range could trigger an environmental disaster for the entire region. It is a well-established fact that the Aravalli hills chain is the oldest mountain on Earth. It spans over 800km from Gujarat to Delhi (through Rajasthan and Haryana). The highest peak in the Aravalli Range is Guru Peak on Mount Abu. The Forest cover in Aravali chains not only preserves humidity in the atmosphere, but it also modulates wind direction and its flow, regulating rainfall patterns and checks drought across some northern states. It also serves as pollution barricades to the Delhi- NCR areas, which are even presently facing higher AQI despite this Hills chain's role in trapping pollutants. What shall be the position of Delhi-NCR pollution, when there will be no Aravali to give protection? Concludingly we can say that the Aravallis act as a crucial natural barrier. blocking dust and sand storms from the Thar Desert from spreading into the fertile Indo-Gangetic plains. Their disappearance would allow the desert to expand eastward, impacting agriculture and quality of life for millions. The hills serve as natural wind regulators and "lungs" that filter the air. Losing this natural shield would significantly worsen air quality in the Delhi-NCR region, leading to increased respiratory illnesses like asthma and bronchitis, and other health problems.

## The Dangerous Logic Behind America's \$1.25 Billion 'Mining' Deal With Pakistan

When Pakistan's Field Marshal, General Asim Munir, presented a box of lustrous mineral samples to US President Donald Trump during his September visit to the White House, it became quite a spectacle - a token of shifting geopolitical directions. Munir's display of Pakistan's alleged mineral wealth has now been quickly followed by a commitment, with the Export-Import Bank of the United States (EXIM Bank) approving \$1.25 billion in financing for the Reko Diq copper-gold mining project in Balochistan on December 10. This move crucially demonstrates one of America's most substantial economic engagements in Pakistan's critical mineral sector, a pivotal shift from its security-centric ties in the past. Donald Trump's sudden - and to many, surprising - embrace of Pakistan comes at a time when the India-US relationship remains fraught. While multiple factors have contributed to this shift, two stand out - Trump's increasingly transactional approach to India and Pakistan's well-timed lobbying efforts in Washington. A 'Personal' Interest In Pak Beyond the official strategic narrative, Trump's personal interest in Pakistan's minerals appears to be augmented by his close associates and family's direct involvement in related private sector ventures. Trump's instinct to treat diplomacy as business deals is, after all, widely established. The conversation around Pakistan's mineral potential is often inflated by domestic and diplomatic rhetoric. For years, Pakistani leaders have cited the figure of \$6 trillion in untapped critical mineral assets. However, this oft-repeated claim remains uncorroborated by internationally certified assessments, those required by global financial markets to determine a mine's economic viability. Much of Pakistan's resource base also faces significant infrastructural challenges and remains underdeveloped. The substantial mineral wealth in Pakistan lies in gold and copper deposits, especially within the Reko Diq and Saindak mines in



Balochistan Province. Reko Diq, operated by Barrick Gold, is reported to contain billions of pounds of copper and millions of ounces of gold. While the company has reported plans to begin production by 2028, the timeline has been subjected to previous delays. This signals the complicated political and technical environment in which projects operate in Pakistan. As the project progresses, the current excitement over the Reko Diq project will likely be dampened by the grim security realities of the location where the US intends to operate. Chagai, a district bordering Afghanistan and Iran, while less affected by insurgency compared to the southern coastal areas near Gwadar, does not remain immune to violence. China's Not-So-Pretty Experience The most lethal insurgent groups in the province, particularly the Balochistan Liberation Army (BLA) and the Balochistan Liberation Front (BLF), have an extensive operational presence in the province. The insurgency is rooted in deep grievances of political and economic marginalisation, compounded by resentment toward foreign-led economic projects. Chinese economic projects, in particular, are perceived by Baloch militants as tools of resource extraction benefiting the Punjabi-dominated Pakistani state. In that light, foreign projects and person-

prime targets. More recently, the security threat manifested in a suicide attack in Nokundi town of Chagai District in late November. The blast, carried out by a female suicide operative targeting the headquarters of a paramilitary force, occurred less than 50 kilometres from the Reko Diq and Saindak sites. The increasing use of female operatives in suicide blasts, a tactic previously employed by the BLA's Majeed Brigade, notably in the Karachi University bombing in 2022 that killed Chinese nationals, informs the expansion of the insurgency's operational scope. ### It exposes hatred towards poor, Mahatma Gandhi: Siddaramaiah on Centre's move to rename MGNREGA

Bengaluru, Dec 16: The Union government led by Prime Minister Narendra Modi, which is attempting to change the name and structure of the Mahatma Gandhi National Rural **Employment Guarantee** Scheme (MGNREGA), has itself exposed its hatred towards the poor and Mahatma Gandhi, said Karnataka Siddaramaiah.

A press statement by Chief Minister Shri Siddaramaiah released on Tuesday in this regard stated, "Implemented by the UPA government 20 years ago, the MGNREGA scheme has played a crucial role in eradicating unemployment and poverty in rural areas. This scheme, which guarantees the right to employment to every individual, has received praise from economists both in India and abroad.'

"However, while MGNREGA was a genuine form of employment guarantee, the proposed new structure under the Narendra Modi government strips away that guarantee and places the assurance of work at the whims of political leaders. This will further deepen caste discrimination and social inequality," the CM highlighted.



The NDA government has altered the very structure of MGNREGA, a scheme whose entire expenditure was earlier borne by the Central government, by shifting nearly 40 per cent of the cost onto the state governments. This stands as clear evidence of the antifederal attitude that Prime Minister Modi has followed ever since coming to power, Siddaramaiah said. "This move will also increase the migration of poor people in search of work, as the proposed form does not guarantee employment in their own location — forcing families to travel long distances to survive," he added.

Naming this scheme after Mahatma Gandhi, who sowed the dream of Gram Swaraj, was a meaningful decision. While Prime Minister Narendra Modi indulges in praising Gandhi during his foreign tours, within the country, has consistently engaged in attempts to erase Gandhi's legacy from key national programmes. #### Mangaluru: **City police issue** guidelines for New Year celebrations

Karnataka

Mangaluru, Dec 17: In view of New Year celebrations, the Mangaluru City Police Commissionerate has issued a set of guidelines in the interest of public safety and maintenance of law and order. As per the guidelines, hotels, restaurants, clubs, resorts and other establishments planning to organise New Year programmes within the limits of the Mangaluru City Police Commissionerate obtain prior permission from the office of the assistant commissioners of police concerned. Applications seeking permission should be submitted on or before Dec 23 by 5 pm. No New Year celebrations will be permitted without prior approval, and legal action will be initiated against violators. All New Year programmes must conclude by 12.30 am, after which no events will be allowed. The use of loudspeakers and sound systems will require prior permission from the competent authority and must strictly adhere to the Noise Pollution Rules, 2000 and Supreme Court directions. The use of DJs has been strictly prohibited. The police have imposed a complete ban on the possession and consumption of prohibited narcotic substances during New Year celebrations. Obscene dances, indecent performances, gambling and other immoral activities under the guise of celebration have also been strictly banned.

### Kharge asks Modi, Shah to resign over dismissal of ED case; Singhvi says law spoke louder than noise

New Delhi: Congress president Mallikarjun Kharge on Tuesday demanded the resignation of Prime Minister Narendra Modi and Union Home Minister Amit Shah after a court refused to take cognisance of the ECIR filed by Enforcement Directorate in the National Herald case, calling the decision a "slap on the face" of the BJP leadership.

Addressing a press conference along with senior party leaders at his residence, Kharge said justice had prevailed and the verdict should serve as a lesson against the misuse of central investigating agencies. He accused the BJP of weaponising the ED, CBI and the Prevention of Money Laundering Act (PMLA) to harass political opponents and malign the Gandhi family and the Congress party.



BJP government had repeatedly used the ED to engineer defections and form governments in several states. He said the Congress would fight back politically on all platforms, from the streets to Parliament, to expose what he termed as the government's misuse of power.

Explaining the legal aspects of the case, senior Congress MP and Supreme Court lawyer Abhishek Manu Singhvi said the law had "spoken louder than the case was heavy on rhetoric but lacked substance, noting that the court refused to take cognisance at the threshold stage as even the minimum legal requirements under the PMLA were not met.

Singhvi said there were internal notings by the CBI and the ED between 2014 and 2021 stating that no predicate offence was made out in the complaint filed by Subramanian Swamy. Despite this, he alleged, the ED proceeded to file the ECIR in June 2021 under pressure from the top, a move now rejected by the court.

Calling it a unique case, Singhvi said not a single rupee had changed hands nor had any immovable property been transferred. He explained that the matter involved a routine conversion of debt into equity by Associated Journals Limited, and pointed out that Young Indian, which acquired the shares, is a not-for-profit company whose directors draw no salary, dividends or perks.

He further noted that between 2021 and 2025, the ED questioned senior Congress leaders, including Sonia Gandhi, Rahul Gandhi and Mallikarjun Kharge, for nearly 90 hours, with Rahul Gandhi alone being questioned for over 50 hours, yet nothing incriminating emerged.



## Tamil Nadu: ED alleges corruption in MAWS, Government, police to reply to petition

K Athinarayanan, president, Maruthu Senai Society of Madurai, filed a petition before the Madras High Court, based on the letter, seeking directions to the Tamil Nadu DGP to obtain the necessary approval from the Chief Secretary and register a case.

CHENNAI: Madras High Court has directed the state government and Directorate Enforcement (ED) to file their responses to a petition seeking the registration of a case in connection with allegations of bribery in appointments in the Municipal Administration and Water Supply (MAWS) department, based on a letter sent by the ED to the police.

During 2024–25, a total of 2,538 appointments, including assistant engineers, junior engineers, and sanitary inspectors, were made in the MAWS department. It has been alleged that bribes ranging from Rs 25 lakh to Rs 35 lakh per post were collected, amounting to Rs



34 crore. In this regard, Enforcement Directorate had sent a letter to the Tamil Nadu Director General of Police (DGP) in October, seeking registration of a case. K Athinarayanan, Maruthu president, Society

Madurai, filed a petition before the Madras High Court, based on the letter, seeking directions to the Tamil Nadu DGP to obtain the necessary approval from the Chief Secretary and register a case.He stated that the ED had sent a 232-page

letter with supporting evidence. If credible information indicating the commission of a cognisable offence received, it is the duty of the police to register a case. As the Enforcement Directorate does not have direct jurisdiction to register corruption cases, it had sent the letter to the DGP requesting registration of a case. As no case has been registered, the ED has been unable to proceed with its investigation, the petition said.

It was further stated that despite sending a letter to the DGP in November seeking registration of a case to ensure transparent governance, no action had been taken. After hearing the peti-

tion, the bench comprising Chief Justice Manindra Mohan Shrivastava and Justice G Arul Murugan, directed the State government, the DGP and the Enforcement Directorate to file their counter-affidavit by January 23.

#### **ANTIDEPRESSANTS**

An unfortunate side effect from some antidepressants is weight gain. Talk to your doctor about making changes to your treatment plan if you think your antidepressant is causing weight gain. But never stop or change your medication on your own. Realize that some people experience weight gain after beginning drug treatment simply because they're feeling better, which leads to a better appetite. Also, depression itself can cause changes in weight.

**STEROIDS** Anti-inflammatory steroid medi-



cations like prednisone are notorious for causing weight gain. Fluid retention and increased appetite are the main reasons. Some people may also see a temporary change in where their body holds fat while taking steroids -- to places like the face, the belly, or the back of the neck. If you've taken steroids for more than a week, don't stop them abruptly. That can lead to serious problems. Check with your doctor

DRUGS THAT MAY CAUSE WEIGHT GAIN Several other prescription drugs are linked to weight gain. The list includes antipsychotic drugs (used to treat disorders like schizophrenia and bipolar disorder), along with medications to treat migraines, seizures, high blood pressure, and diabetes. Work with your doctor to find a medication that treats your symptoms and lessens side effects.

#### DON'T JUMP TO BLAME THE PILL

Contrary to popular belief, combination birth control pills (estrogen and progestin) aren't proven to cause lasting weight gain. It is

thought that some women taking the combination pill may experience some weight gain related to fluid retention, but this is usually short-term. If you're still concerned about possible weight gain, talk to

#### **HYPOTHYROIDISM**

If your thyroid (the butterflyshaped gland in the front of your neck) is not making enough thyroid hormone, you're probably feeling tired, weak, and cold, and gaining weight. Without enough thyroid hormone, your metabolism slows, making weight gain more likely. Even a thyroid functioning at the lower end of the normal range might cause weight gain. Treating hypothyroidism with medication may reverse some of the weight

#### DON'T BLAME MENOPAUSE

Most women do gain some weight around the time of menopause, but hormones probably aren't the only cause. Aging slows your metabolism, so you burn fewer calories. And changes in lifestyle (such as exercising less) play a role. But where you gain weight may be related to menopause, with fat accumulating around your waist more than your hips and

#### **CUSHING'S SYNDROME**

Weight gain is a common symptom of Cushing's syndrome, a condition in which you are exposed to too much of the stress hormone cortisol, which in turn causes weight gain and other abnormalities. You can get Cushing's syndrome if you take steroids for asthma, arthritis, or lupus. It can also happen when your adrenal glands make too much cortisol, or it could be related to a tumor. The weight gain may be most prominent around the face,

#### neck, upper back, or waist. POLYCYSTIC OVARY SYNDROME (PCOS) PCOS is a common hormonal

problem in women of childbearing age. Most women with PCOS grow many small cysts on their ovaries. ### **CPM** opposes changes to MGNREGS, condemns 'majoritarian' law-making



CHENNAI: CPM State secretary P Shanmugam on Tuesday strongly opposed the Union government's proposed amendments Mahatma National Rural Employment Guarantee Act, alleging that the changes would effectively dismantle the 100-day employment scheme that supports crores of rural households.

In a video message posted on social media, Shanmugam said the Cabinet had Union approved a move to replace the existing Act with a new scheme under a different name, which he described as unacceptable. He recalled that the Employment Guarantee

Calling for nationwide protests, he urged rural workers and beneficiaries to unite, drawing parallels with the agitation that led to the repeal of the farm laws

Law was enacted in 2005 during the UPA regime, with the support of Left parties, and had since become a crucial livelihood and poverty-alleviation measure in rural India. He accused the BJP-led Union government of weakening the scheme over the past decade by cutting alloca-

tions, reducing workdays, delaying wage payments and shrinking beneficiary coverage, forcing many rural workers to drop out. In several villages, he said, employment had fallen from the assured 100 days to barely 10 or 20 days a year.

Shanmugam criticised the proposal to remove Mahatma Gandhi's name from the scheme and to alter the funding pattern by reducing the Centre's share to 60 per cent and increasing the States' burden to 40 per cent, while retaining decisionmaking powers with the Union government. He warned that this would place severe financial strain on States, particularly non-BJP-ruled States, and ultimately hurt rural workers.

He also objected to provisions that, he said, diluted the legal guarantee of employment by making work subject to official discretion, thereby denying workers the right to demand jobs or unemployment allowance. Calling for nationwide protests, he urged rural workers and beneficiaries to unite, drawing parallels with the agitation that led to the repeal of the farm laws. He said the CPM would lead sustained protests until the proposed amendments were withdrawn.





### Nato spending pledge is Trump's biggest foreign policy success, Rutte tells



Nato countries' pledge to spend 5% of their economic output on defence Donald Trump's "biggest foreign policy success," the alliance's chief has said. In an interview with the BBC, Mark Rutte said it was thanks to Donald Trump that Nato was "stronger than it ever was", adding that Trump "is good news for collective defence, for Nato and for Ukraine". The US leader has harshly criticised European allies for spending very little on defence - even threatening to withdraw US protection if they fail to do so. The Nato chief has warned that Russia could attack allies within the next five years. Russia's President Vladimir Putin dismissed such talk as "hysteria" on Wednesday. "I've said it repeatedly - it's a lie, nonsense, pure nonsense, about some imaginary Russian threat to European countries," Putin told defence officials in Moscow. After Putin launched Russia's full-scale invasion of Ukraine in February

2022, he announced the annexation of four Ukrainian regions Luhansk, Donetsk, Zaporizhzhia, Kherson. Russia had already annexed Crimea in 2014. It now occupies most of Luhansk, and is understood to demand Ukraine's withdrawal from all of Donetsk, too, even though Ukraine still controls up to 23% of the eastern region. Putin said the goals of what he calls "the special military operation" would be achieved. He said he preferred to do it through diplomacy, before warning that, "if the opposing side and their foreign patrons refuse to engage in substantive discussions, Russia will achieve the liberation of its historical lands by military means". In his interview with the BBC Radio 4's PM programme, the Nato secretary general said it was "insane" that Putin's pursuit of his "historical idea that you want to regain access to Ukraine" - or over the entire territory that used to constitute the former Soviet Union - had caused the death or serious injury to 1.1m of his people. Mark Rutte praised Trump's efforts to find an end to the war. US envoys have been conducting intense negotiations with Ukrainian officials over a Trump-proposed peace plan whose initial draft was seen as

## 'An unspeakable loss': Funeral takes place for rabbi killed in Bondi shooting

The first of the funerals for victims of the Bondi Beach shooting has taken place in Sydney, with thousands gathering to mourn Rabbi Eli Schlanger. He was among 15 people killed when two gunmen opened fire on a festival marking the first day of Hanukkah. Australia's prime minister said that the attackers appear to have been inspired by Islamic State (IS) group. Rabbi Schlanger, who was known as the "Bondi Rabbi" and had helped organise Sunday's event, was born in the UK. His wife gave birth to their fifth child just two months ago. Rabbi Levi Wolff, who opened the service, said his



death as an "unspeakable loss" for the community, the Chabad of Bondi and "the entire Jewish nation". "Eli was ripped away from us, doing what he loved best." he said. "Spreading love and joy and caring for his people with endless self-sacrifice in his life and in his death, he towered above as one of the

highest and holiest souls.' He was mourned by his father-in-law as a person beloved by the community. The 41-year-old was "my son, my friend, my confi-Rabbi Yehoram Ulman told the congregation at the Chabad of Bondi. "My biggest regret was, apart from the obvious, to

tell Eli more often how much we love him, how much I love him, how much we appreciate everything that he does and how proud we are of him," Rabbi Ulman said. "I hope he knew that but I think it should have been said more often." Ulman also urged Jewish people not to hide in the aftermath of the attack and said that on Sunday night the final night of Hanukkah - they would continue a 31year-old tradition, and light the final candle on Bondi Beach. ### Miss Finland's viral 'slanted-eyes' photo stirs racism firestorm



Finland's delegate to last month's Miss Universe pageant held in Thailand has sparked controversy and outrage after a photo of her pulling the corners of her eyes went viral. Sarah Dzafce, who has been stripped of her Miss Finland crown, uploaded the photo with the caption "eating with a Chinese". The slanted-eyes pose is often seen as disrespectful to East Asians. The post drew backlash in Japan, South Korea and China against the 22-year-old and even against her country's flag carrier, Finnair. Finland's prime minister weighed in on Monday, saying that making such gestures was "thoughtless and stupid" and that the controversy that ensued was "damaging" to the country. Ms Dzafce claimed the gesture was her reaction to a headache during dinner. She said a friend added the offensive caption to the 11 December post without her consent, according to local tabloid Ilta-Sanomat. Ms Dzafce has apologised for the

"caused ill will in many people". "That was not my intention in any way... One of the most important things for me is respect for people, their backgrounds and differences," she wrote on an Instagram post. The apology still drew criticism. with some calling it "insincere" given it was written in Finnish. One person wrote: "That was uncalled for, Asian people didn't do anything to you... We [are] still disappointed in you." Two right-wing MPs in Finland, Juho Eerola and Kaisa Garedew, posted photos of themselves mimicking Ms Dzafce's gesture to show their support for the beauty queen. The posts were taken down after backlash. Eerola apologised adding he felt Ms Dzafce was given "disproportionately punishment". Finnish Prime Minister Petteri Orpo condemned the MPs' actions as "childish", adding that lawmakers should set an example of proper conduct.

## US ACCUSED OF USING ILLEGAL WORKERS AT CENTRE PROCESSING REFUGEE CLAIMS IN SOUTH AFRICA

US of using Kenyan nationals who did not have work permits at a facility processing applications by white South Africans for refugee status. Seven Kenyans were arrested after intelligence reports revealed that people "had recently entered South Africa on tourist visas and had illegally taken up work" at the centre, said a statement from South Africa's department of home affairs. The BBC has approached the US State Department for comment. While the US is trying to reduce overall levels of migration, it says that members of South Africa's white Afrikaner community can get asylum because they face persecution - a claim South Africa's government strongly rejects. The US has reduced its yearly intake of refugees from around the world from 125,000 to 7,500, but says it will prioritise Afrikaners, who are mostly descendants of Dutch and French settlers. This is one of the issues that have caused a sharp deterioration in relations between South Africa and the Trump administration. South Africa says the Kenyan nationals arrested in Tuesday's raid will now be deported and will be banned from entering the country for five years. They had previously been denied work visas but were found "engaging in work despite only being in possession of tourist visas, in clear violation of their conditions of entry into the country", the statement said.

South Africa also expressed concern that foreign officials appeared to have coordinated with undocumented workers and said it had reached out to the US and Kenya to resolve the matter. The home affairs department said the raid showcased the commitment that South Africa shared "with the United States to combating illegal immigration and visa abuse in all its forms". No US officials were arrested and the operation was not at a diplomatic site, it said. While the State Department is yet to respond to the BBC's request for comment, in a statement issued to US publications, Tommy Pigott, principal deputy spokesperson for the State Department, said the expected "full cooperation accountability". 

Cameron Green is a generational talent, and for KKR, he is an outstanding acquisition," Ashwin added. Green previously played for Mumbai Indians and Royal Challengers Bengaluru, the defending champions, before missing the 2025 season due to back surgery.

### **Alex Carey Breaks Silence After Snicko Controversy** In Ashes Sees Him Gets Called A 'Cheater'

Alex Carey steered Australia to a dominant position on Day 1 of the third Ashes Test Adelaide Oval on Wednesday. After a shaky start, which saw Australia slump to 94/4 soon after lunch, Carey, along with the last-minute inclusion of Usman Khawaja, added 91 runs for the fifth wicket to rescue Australia. Carey scored 106 off 143 balls. The South Australian, whose father Gordon died in September after a protracted battle with cancer, looked up to the sky after notching his third Test century. This achievement was significant for Carey, who looked skyward in tribute to his late father, who passed away in September from leukaemia. The 34-year-old also became Australia's leading run-scor-



er in Tests this year, surpassing Steve Smith's 618 runs to rank sixth in the world for runs in the format. However, the century didn't come without controversy. Carey survived an early chance in the innings when he flashed at the first ball of the 63rd over

Josh Tongue. Wicketkeeper Jamie Smith and a fielder appealed and celebrated for a catch behind, but standing umpire Ahsan Raza turned it down as England reviewed the decision almost immediately. There was a spike shown on

## **ACTIVE AERO AND OVERTAKE MODE -**F1'S NEW TERMINOLOGY

Formula 1 has revealed the terminology the sport will use to refer to the technical complexities of the new 2026 rules. F1 is introducing arguably the biggest regulation change in its history next season, with new chassis and engine rules, and the mandating of sustainable fuels. The new engines, which remain 1.6-litre V6 turbo hybrids, have significantly increased electrical capacity, which required innovations in the cars' aerodynamics. Drivers will manage electrical energy throughout races - sometimes even on qualifying laps - to secure the best performance. F1 and governing body the FIA have consulted with what is described as a "wide range of new, casual and core fans to understand what kind of terminology would help them better



understand the key features of the new regulations". A statement said this involved "using third-party polling data and our 50,000 strong community 'Fan Voice', as well as consultation with the FIA, F1 teams and other technical experts to finalise and agree on the terms". The aim was to make a series of complex new areas of the sport as easy to understand

as possible to the widest audience. So previous terms for some of the devices such as "x-mode and "zmode" for the active aeroydnamics - have been dropped in favour of descriptions that give a more direct and straightforward indication of what the technology actually does. What's the new technology? Rule-makers say drivers will have more

power in their hands to make decisions over energy deployment, regeneration and conservation. The new rules mean cars will have a series of modes which will be indicated on television graphics to aid the audience's understanding of the action. Overtake mode: Replaces the current DRS overtaking aid. A burst of extra electrical energy available when drivers are within a second of the car in front to deploy power to assist with an overtake. Boost mode: Driver-operated energy deployment from the energy recovery system that can be used in attack or defence. Gives the driver maximum power from the engine and battery at the push of a button. Both these modes will have to be used with calculation as total energy is limited.

### **Bonmati named Fifa Best** women's player of the year





The Spaniard won a domestic treble with Barcelona - scoring 12 and assisting six goals in La Liga F - but was a runner-up in the Champions League with her club, who lost to Arsenal in the final. Bonmati was named the competition's player of the season by Uefa, registering nine goal contributions in her 11 appearances and scoring in their 4-1 semi-final second-leg win at Chelsea. 
