IndiGo cancels 57 flights; Hyderabad among affected airports



Mumbai: Domestic carrier IndiGo on Saturday cancelled 57 flights across its network, citing "bad weather" at various airports, according to the airline's website. The airline has also cancelled 13 flights, as of now, for Sunday, with two of them for "operational reasons", and the remaining largely due to "forecasted bad weather". The Gurugram-headquartered IndiGo, which cancelled thousands of flights early this month on account of stricter norms related to the pilots' duty period and rest, have been cancelling some flights for more than one week now on account of "bad weather". The 57 flights cancelled on Sunday include from Chandigarh, Mumbai, Ahmedabad, Hyderabad, Amritsar, Bengaluru, Delhi, Gaya, Kolkata, Chennai, Jaipur and Pune, among others.

Cong plans 'MGNREGA Bachao Abhiyan' from Jan 5; Kcharge says Modi govt will face people's anger

NEW DELHI (TSIT): The Congress will launch a nationwide campaign against the repeal of the UPA-era rural employment legislation MGNREGA on January 5, similar to the push-back against the three farm laws which eventually forced the Narendra Modi government to roll-back its decision, party president Mallikarjun Kcharge said.

At a press conference here on Saturday after a meeting of the Congress Working Committee (CWC), Kcharge said the party will lead the 'MGNREGA Bachao Abhiyan' across the country. The VB-G RAM G Bill, replacing the 20-year-old MGNREGA, was passed in Parliament during the recently concluded Winter Session of Parliament amid vociferous protests by the opposition. The new law has a provision for 125 days of wage employment for rural workers.



He said the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) was not just a scheme, but the 'Right to Work' given by the Constitution. "People are angry over the repeal of MGNREGA. The government will have to face the consequences," he said. "At the CWC meeting, we took an oath that a campaign would be launched with MGNREGA as its focal point. The Congress would take the lead and start a "MGNREGA Bachao Abhiyan" from

January 5," Kcharge said. He said party leaders took an oath of protecting MGNREGA at any cost. "We will fight unitedly for the rights of rural labourers to dignity, employment, wages and timely payment and will protect the rights of demand-based employment and gram sabha," he said. Kcharge said the Congress would democratically oppose the "conspiracy" to erase Mahatma Gandhi's name from MGNREGA and to "convert the rights of workers into charity".

Referring to the cost-sharing clause between the Centre and state governments under the VB-G RAM G Act, the Congress chief said states will have an additional expenditure burden and termed it a one-sided decision taken without consultation. "This law has been brought to crush the poor. We will fight against it on the streets and in Parliament," he said. Earlier, speaking at the CWC meeting, Kcharge said repealing MGNREGA is an insult to Mahatma Gandhi. The Congress chief cited precedents, including the 2015 amendments to India's land acquisition law that were effectively rolled back. He also quoted the three farm laws, which were first brought in as ordinances and then passed in Parliament amid opposition protests, but had to be repealed following the 2020-21 farmers' protests.

10.56 LAKH NAMES DELETED AS EC RELEASES ASSAM'S DRAFT ELECTORAL ROLLS AFTER SPECIAL REVISION

GUWAHATI (TSIT) The names of 10.56 lakh voters have been deleted after Special Revision of electoral rolls in Assam, where assembly polls would be in less than six months. According to the integrated draft rolls released by the Election Commission on Saturday, the state has a total of 2,51,09,754 voters, excluding 93,021 D-Voters or doubtful voters. Additionally, the names of 10,56,291 voters have been deleted due to death, shifting, or multiple entries.

D-Voters are a category of voters in Assam who have been disenfranchised by the government on account of their alleged lack of proper citizenship credentials. D-Voters are determined by special tribunals under the Foreigners Act, 1946, and the person declared as a D-Voter is not given a voter card. All related particulars,



such as name, age and photograph, of D-Voters have been carried forward to the draft electoral roll without any change. The draft rolls were published after house-to-house verification of the Special Revision was held from November 22 to December 20. Now, voters will be able to file claims and objections till January 22, and the final electoral rolls will be published on February 10, a statement said. Of the 10.56 lakh, 4,78,992 names were deleted because of deaths,

5,23,680 voters were found to have moved from their registered addresses, and 53,619 demographically similar entries were identified for correction, it said. The verification was conducted in 61,03,103 households across the state, it added. The exercise involved 35 District Election Officers (DEOs), 126 Electoral Registration Officers (EROs), 1,260 AEROs, 29,656 Booth Level Officers (BLOs) and 2,578 BLO Supervisors, the statement said.

DMK has earned strong reputation for its governance, welfare schemes: Stalin

TIRUVANNAMALAI: Tamil Nadu Chief Minister M K Stalin on Saturday said the Dravidian model government led by him in the state has earned a good name even from the people who have not voted for the DMK. However, it was not the case with the BJP that governs the Centre, as even its supporters were making searing criticism of the union government, he alleged.



Addressing a government function at Malappambadi near here, the chief minister said the DMK regime is working for the overall development of Tamil Nadu, which includes each and every district and every family. The Dravidian model of governance and growth across sectors speaks volumes about the state overcoming a string of challenges. Due to the BJP-led government's implementation of GST, the state does not have the "right over tax," he alleged and claimed that the funds due to the state have not been released by the Centre. On top of it, the state has a governor who has been deputed by the Centre only to cause trouble to the elected gov-

ernment. In addition to such issues, there are "betrayers" and "slaves", and only by surmounting such challenges the state has recorded impressive growth and this is the Dravidian model, the CM said. Apparently, the "betrayers and slaves" term is perceived as a reference to the rival parties; mainly the main opposition AIADMK and its key ally the BJP and of late, the fledgling TVK as well. Stalin said the state's growth gives stomach cramps to many and even those who hold responsible posts, like ministers at the Centre were spreading so much hatred. "They think that by spreading hatred against Tamil Nadu, they can gain votes in the northern states," the CM claimed.

KTR claims rising public anger against Congress in Telangana

HYDERABAD, DEC 27: BRS Working President K. Taraka Rama Rao (KTR) on Saturday said that a state-wide revolt against the Congress government has begun in Telangana, citing public anger over unfulfilled promises and alleged governance failures. Speaking at an Atmiya Sammelanam of newly elected BRS-backed Sarpanches and Upa-Sarpanches in Hyderabad, KTR asserted that the Bharat Rashtra Samithi (BRS) would reclaim power.



KTR accused the Congress government, led by Chief Minister Revanth Reddy, of betraying farmers by failing to release Rythu Bandhu investment support on multiple occasions. He contrasted this with the previous BRS regime under K. Chandrashekar Rao (KCR), claiming Rs 72,000 crore was directly transferred to farmers without delays. He alleged that the Congress came to power through deception and criticised the government for focusing on inquiries and cases rather than administration. KTR also hailed the BRS-backed candidates'

performance in recent Gram Panchayat elections, calling it a sign of strong grassroots support despite political pressure. Announcing protective measures for elected local representatives, KTR said BRS would set up legal cells and training programmes in every district. He emphasised the constitutional authority of Sarpanches and accused the government of misusing power to harass local bodies. He highlighted that the government's retreat on the Lagacharla land issue was a direct result of the party's massive protest in Mahabubabad.

Develop curriculum to expose urban students to village life: Shivakumar

BENGALURU (TSIT) Deputy Chief Minister D K Shivakumar on Sunday called for the development of a curriculum that creates awareness about village life among urban students, stressing the need to bridge the growing gap between rural and urban realities. gested including two to three days of village tours as part of the academic syllabus. Recalling his personal experiences, Shivakumar said he comes from a farmer's family and had attended a poultry farming course at GKVK during his college days. He noted that his family continues to be connected with agriculture through horticulture and plantation activities, adding that he understands the challenges faced by the farming community.

Prez Murmu honours Hyderabad mountaineer Vishwanath Karthikey with Pradhan Mantri Rashtriya Bal Puraskar

Hyderabad: The Government of India conferred the Pradhan Mantri Rashtriya Bal Puraskar 2025 on mountaineer Vishwanath Karthikey Padakanti, with Droupadi Murmu presenting the national honour in recognition of his historic feat as the youngest Indian and the second youngest person in the world to complete the prestigious 7 Summits Challenge. December 26 is observed annually as Veer Baal Diwas, commemorating the martyrdom of the sons of Guru Gobind Singh. On this occasion, the Pradhan Mantri Rashtriya Bal Puraskar is conferred by the President of India to recognise exceptional achievements by children below the age of 18 across six categories—Bravery, Social Service, Environment, Sports, Art and Culture, and Science and Technology. The national honour recognises Karthikey's completion of the 7 Summits Challenge at the age of 16, placing him among the youngest mountaineers worldwide to achieve the milestone. The challenge



involves scaling the highest peaks on all seven continents—Mount Everest (Asia), Aconcagua (South America), Denali (North America), Mount Elbrus (Europe), Mount Kilimanjaro (Africa), Mount Kosciuszko (Australia), and Mount Vinson (Antarctica). Born on October 30, 2008, in Hyderabad and currently residing in Ferozguda, Balanagar, Vishwanath Karthikey began mountaineering during the COVID-19 pandemic in 2020. At the age of 11, he undertook his first high-altitude attempt at Rudragaira in Uttarakhand. Although the summit remained out of reach, the expedition marked the beginning of a sustained and disciplined pursuit of high-altitude climbing. He later trained at the Nehru Institute of Mountaineering, acquiring essential technical and safety skills for extreme-altitude expeditions. Alongside formal training, Karthikey followed a rigorous fitness routine, often beginning his day at 4 a.m. Over the next five years, he climbed 23 mountains across continents, setting multiple age-related benchmarks. A defining milestone in his journey came on May 27, 2025, when he successfully summited Mount Everest, completing the Seven Summits Challenge. Throughout this period, he also maintained steady academic progress, balancing

school education with demanding international expeditions. Karthikey's journey has been supported by his family, his parents Rajendera Prasad and Laxmi, grandparents Shiva Kumar and Soumya Laxmi, and elder sister Vaishnavi. His training and expeditions were guided by his coach Bharath Thamineni, founder of Boots & Crampon, and Romil Barthwal, whose mentorship played a critical role in his development as a mountaineer. Notably, the award marks a hat-trick for Boots & Crampon, following earlier Pradhan Mantri Rashtriya Bal Puraskar recipients Samanyu Pothuraju (2020) and Virat Chandra Telukunta (2022). Reacting to the honour, Karthikey said mountaineering had taught him discipline, consistency, and resilience in the face of setbacks. He added that receiving the Pradhan Mantri Rashtriya Bal Puraskar has strengthened his resolve to pursue higher goals in the sport.

KL Deemed to be University confers degrees on over 5,000 students at XV Convocation

India to Get National Academy on Rural Buddhist Heritage as Andhra Pradesh Allots Land

Hyderabad/Visakhapatnam: The Andhra Pradesh government has allotted five acres of land at Nagarjunakonda for establishing a National Academy for Rural Buddhist Heritage Conservation and Development, positioning the State at the forefront of India's efforts to revive and protect its vast yet neglected rural Buddhist legacy. The announcement was made at the conclusion of the three-day International Conference on the Preservation of Rural Buddhist Heritage held in New Delhi, where the Delhi Declaration was adopted as a national framework for conservation. The conference brought together scholars, monks, conservation experts and policymakers from India and abroad. Nagarjunakonda, situated in the Krishna river valley, is one of India's most significant archaeological sites associated with early Buddhism. Once a major centre of monastic learning and Buddhist art, the region holds immense historical and cultural value. The proposed academy is expected to build on this legacy by becoming the country's first institution exclusively dedicated to research, training and community-based conservation of rural Buddhist heritage. The academy will focus on documenting lesser-known rural Buddhist sites, developing professional expertise in heritage conservation and ensuring active participation of local communities. The land allotment by the Andhra Pradesh government is being viewed as a crucial step in translating national commitments into action at the State level. During the conference, speakers highlighted the increasing threats faced by rural Buddhist sites, including climate change, environmental degradation and regulatory challenges. His Eminence Kyabje Serkong Tensharp Rinpoche cited damage to the 1,000-year-old Tabo Monastery in Himachal Pradesh due to unseasonal rainfall as a warning sign. Former NITI Aayog CEO Dr. Amitabh Kant stressed the need to treat Buddhist heritage conservation as a national mission, while experts including Professor Amarendra Galla and Dr. Prajapati Trivedi of Harvard University underlined the importance of systematic documentation, academic training and international collaboration.

SC delivered key verdicts on presidential reference, Waqf law in 2025

NEW DELHI: Landmark verdicts on the powers of governors and the president on bills, staying few provisions of the Waqf law and a series of path-breaking judgements defined 2025 for the Supreme Court, a year which saw an unprecedented shoe attack on CJI B R Gavai and the discovery of huge cash at high court judge Yashwant Varma's bungalow here.

The apex judiciary saw a rare transition through three Chief Justices of India (CJIs) within a single year -- Sanjiv Khanna, Gavai, and the incumbent, Surya Kant.

In a move aimed at bolstering judicial independence, justices Khanna and Gavai publicly announced their decisions to not to take any post-

retiral assignments, an issue which has been keenly debated.

This set the stage for further institutional transparency, as the court finally began uploading the asset statements of its judges to the public domain and introduced a first-of-its-kind reservation policy for SC/ST categories in its administrative staffing.

The judiciary was rocked after burnt wads of huge currency notes were found at the official residence of Justice Varma, the then sitting Delhi High Court judge, on March 14. This led to a series of decisions including administrative ones by the then CJI Khanna.

After an in-house inquiry panel indicted Justice Varma, he refused to

resign even after being nudged by CJI Khanna, who was then compelled to write to President Droupadi Murmu and Prime Minister Narendra Modi for his impeachment.

Currently, a parliamentary panel is conducting its inquiry against Varma, a condition precedent before the impeachment.

On October 6, advocate Rakesh Kishore, now suspended, hurled a shoe towards then CJI Gavai during proceedings. He was apparently miffed over Gavai's alleged remarks on Hindu gods in an earlier proceeding. As the incident sparked widespread condemnation, Modi spoke to the then CJI and said the attack was "reprehensible" and angered every Indian.

TN jaggery producers seek inclusion in Pongal gift scheme to revive traditional industry



CHENNAI: As the harvest festival of Pongal approaches, farmers and jaggery producers across Tamil Nadu have urged the state government to include locally produced jaggery in the annual Pongal gift hamper distributed through fair price shops.

They said that such a move would not only support traditional cottage industries but also provide much-needed relief to thousands of rural families struggling with rising production costs and declining demand.

Every year, the Tamil Nadu government distributes essential commodities such as raw rice, sugar and sugarcane to ration card holders as part of its festive welfare initiative.

Jaggery producers argue that replacing refined sugar with locally made jaggery would strengthen rural livelihoods while promoting healthier consumption practices.

Dharmapuri district, one of the major jaggery-producing belts in the state, has over 100 traditional jaggery units spread across areas such as Palacode, Pennagaram, Papparpatti and surrounding villages.

Despite contributing significantly to the state's total jaggery output, producers in the region say the sector has been steadily declining due to low demand, rising input costs and shrinking profit margins. Industry representatives note that Dharmapuri alone accounts for nearly 17 to 20 per cent of Tamil Nadu's jaggery pro-

duction, with around 60 tonnes produced daily. However, escalating costs have made production increasingly unviable. To produce 100 kilograms of jaggery, nearly one tonne of sugarcane is required, costing around Rs 2,800. Additional expenses, such as transportation, fuel, labour and processing, push the total production cost to around Rs 5,200-Rs 5,500, while market prices hover at only Rs 46-Rs 48 per kg, resulting in consistent losses.

Labour shortage has further compounded the crisis. Jaggery production is labour-intensive and requires skilled workers, who now demand daily wages ranging between Rs 700 and Rs 1,000.

Many workers are unwilling to continue in the sector due to the physically demanding nature of the job and uncertain returns. Producers believe that including jaggery in the Pongal gift scheme would provide assured demand, stabilise prices and help sustain traditional production methods.

Officials in the district administration have acknowledged that similar demands were raised in previous years, but clarified that the final decision rests with the state government as it involves policy-level considerations. For thousands of farmers and small-scale manufacturers, the move is seen as a lifeline that could revive a declining rural industry while reinforcing the cultural essence of the harvest festival.

Sabarimala gold theft: SIT hunts for Tamil Nadu jeweller for suspected links



THIRUVANANTHAPURAM: The Special Investigation Team (SIT) investigating the Sabarimala gold theft case on Friday extended its probe to Tamil Nadu in search of a jeweller who has alleged connection to the case, according to police. Police are on the lookout for Balamurugan, also known as D Mani, from Dindigul. According to police sources, Mani and his associate came under the SIT's radar after senior Congress leader Ramesh Chennithala gave a statement, alleging the involvement of an international antique racket

in the Sabarimala gold theft incident.

Based on Chennithala's revelation, the SIT also recorded the statement of an NRI businessman, who told police that the gold from Sabarimala might have reached Mani, who allegedly procured large volumes of temple antiques. The SIT traced Mani's phone number and also obtained a search warrant and reached his office in Dindigul, police said. However, the businessman told the SIT he was not the D Mani they were looking for. He said he was Subramaniam, also known as MS Mani, and was engaged in real estate, not gold trade.

SIT sources said the phone number traced by the team was being used by MS Mani, following which they decided to conduct a detailed investigation to ascertain whether D Mani and MS Mani are the same person. A notice was issued to Subramaniam to appear for interrogation in Thiruvananthapuram. The SIT is also looking for one Srikrishna in Virudhunagar, police said. SIT sources said the involvement of Mani and his associate in the Sabarimala case has yet to be established. So far, it has arrested nine persons, including two former presidents of the Travancore Devaswom Board, in two cases related to the gold theft from the 'dwarapalaka' idols and the 'sreekovil' doorframes.

Centre's green panel gives nod to Dulhasti hydel power project on Chenab river

NEW DELHI: A panel under the Ministry of Environment has approved the 260-megawatt Dulhasti Stage-II hydropower project on Chenab river in Jammu and Kashmir's Kishtwar district, officials said on Saturday.

The clearance comes in the backdrop of India suspending the Indus Waters Treaty with Pakistan following the deadly Pahalgam terror attack in April this year.

The Expert Appraisal Committee on hydel projects accorded the approval during its 45th meeting earlier this month, paving the way for floating construction tenders for the run-of-the-river project, estimated to cost over Rs 3,200 crore.

According to the minutes of the meeting, the panel noted that the water of Chenab basin is shared between India and Pakistan in accordance with provisions of the Indus Water Treaty, 1960, and the project's parameters were planned in accordance with the treaty.

"However, the Indus Water Treaty stands suspended effective from April 23, 2025," the panel noted. When the Indus Water Treaty was in force, Pakistan had rights over the Indus, Jhelum and Chenab rivers, and India over the Ravi, Beas and Sutlej.




With the treaty now in abeyance, the Centre is pushing ahead with several hydroelectric projects in the Indus basin, such as Sawalkote, Ratle, Bursar, Pakal Dul, Kwar, Kiru, and Kirthai I and II.

Dulhasti Stage-II is an extension of the existing 390 MW Dulhasti Stage-I Hydro Electric Project (Dulhasti Power Station), which has been successfully operating since its commissioning in 2007 by National Hydroelectric Power Corporation Limited. Under the plan, water will be diverted from the Stage-I power station through a sepa-

rate tunnel measuring 3,685 metres in length and 8.5 metres in diameter to form a horseshoe-shaped pondage for Stage-II. The project also includes a surge shaft, a pressure shaft, and an underground powerhouse housing two 130 MW units, resulting in a total installed capacity of 260 MW and an annual energy generation.

The total land requirement for the project is estimated at 60.3 hectares. This project will require 8.27 hectares of private land from two villages, Benzwar and Palmar, in Kishtwar district.

Wildlife crushed in the path of development

The December 2025 train accident that killed seven elephants—including a calf—in Assam's Hojai district was no ordinary accident. It symbolized the growing conflict between India's development model and environmental sensitivity. The high-speed train not only killed the elephants, but also derailed the engine and several coaches, highlighting the serious threat such incidents pose not only to wildlife but also to human life and public property.

The elephant is India's "National Heritage Animal" and is protected under Schedule I of the Wildlife Protection Act, 1972. Despite this, the annual deaths of elephants on railway tracks raise questions about whether our development is truly sustainable, or is it proceeding at the expense of nature. According to government data, hundreds of elephants have been killed in train accidents over the past two decades, with Assam, West Bengal, Odisha, and Jharkhand being the worst affected states.

India has seen rapid expansion of railway lines, national highways, power transmission lines, and other linear infrastructure. This expansion was considered essential for economic progress, but problems arise when these projects encroach upon forests, grasslands, and wetlands without adequate ecological planning. Railway tracks are particularly dangerous because trains cannot change direction or stop suddenly. Elephants, on the other hand, have limited vision and their heavy bodies, hindering rapid reaction.

Elephants are large-scale migratory animals and rely on traditional migratory routes for food, water, and breeding. When railway lines cut off these corridors, elephants have no choice but to cross the tracks. Unfortunately, many accident-prone areas have still not been officially declared "elephant corridors." The Hojai region of Assam is a prime example, where legal protection has been lacking despite regular elephant movement for years.

Excessive train speeds are a major cause of accidents. Even in environmentally sensitive areas, trains often reach speeds of 90 to 110 kilometers per hour. At such speeds, it is nearly impossible to stop a train in the face of elephants. Temporary speed restrictions and warnings often prove to be mere formalities. This demonstrates that time and efficiency continue to be prioritized over environmental safety in railway operations.

Visibility problems also contribute to these accidents. Most elephant-train collisions occur at night or early morning, when fog, rain, or dense vegetation limit train drivers' vision. This situation is even more severe in Assam and Northeast India, where unpredictable weather is common. Furthermore, railway tracks themselves attract elephants. Food waste thrown by passengers, salty soil, and ripening crops near the tracks draw elephants to vulnerable areas, especially during the harvest season. The design of railway tracks also often exacerbates the problem. High embankments, concrete walls, and fences trap elephants on the tracks. Cubs are unable to escape quickly, slowing the entire herd down and increasing the risk of accidents.

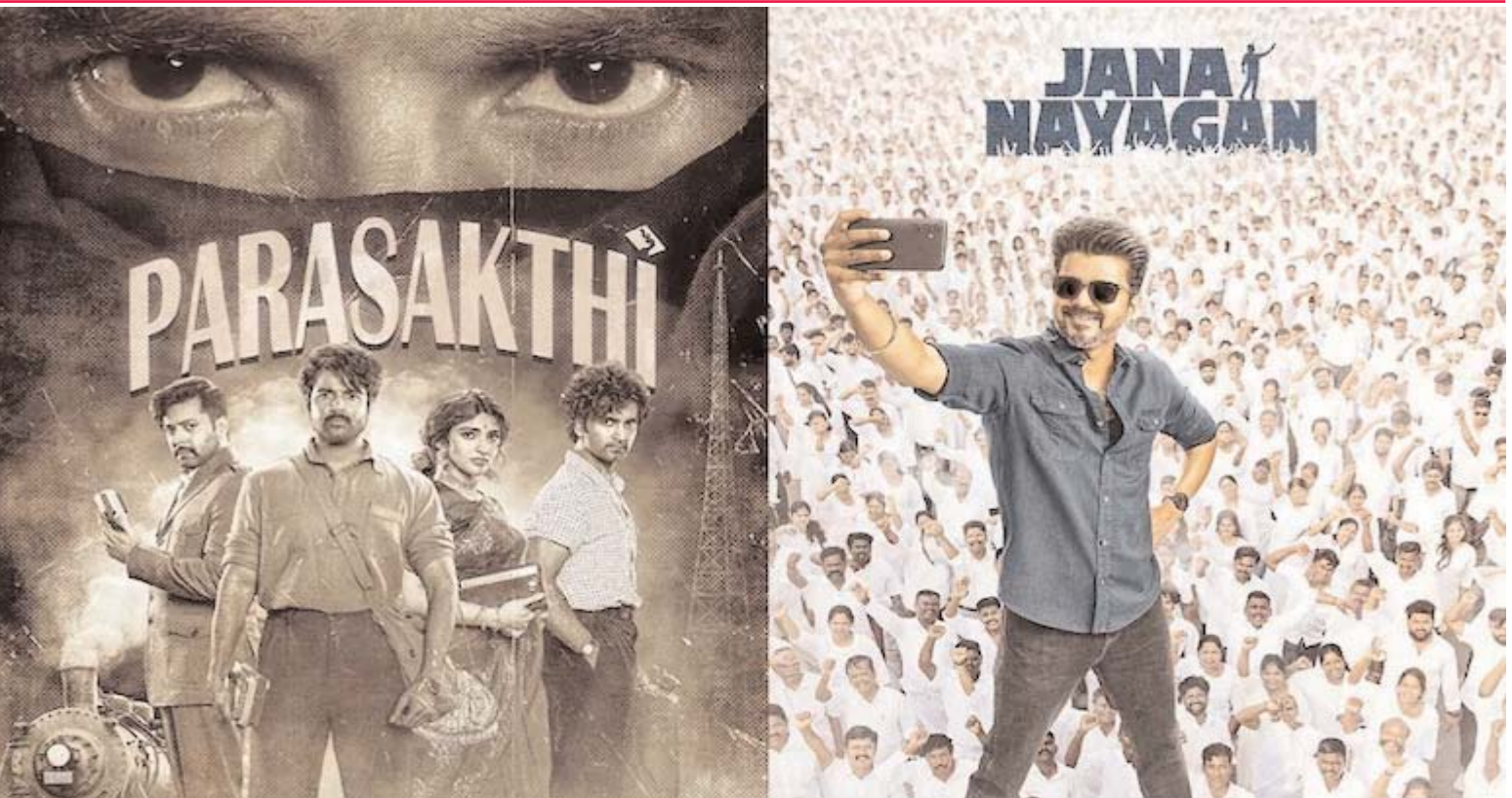
Furthermore, a lack of proper coordination between the Forest Department and the railways is a major challenge. Patrol teams often fail to report elephant presence to the railway control room in time, preventing accidents.

After every major disaster, steps such as investigations, compensation, and temporary bans are taken, but these are all reactive measures. Environmental impact assessments often remain a formality, and changes in animal behavior after project approval are not taken seriously. The need is to treat conservation not as an obstacle to development, but as an essential part of it.

To protect elephants, it is essential to provide legal protection to all known migratory corridors, whether they are already notified or not. Permanent speed limits should be implemented in all such areas. As a technological solution, AI-based intrusion detection systems, which detect elephant movements and alert train drivers in time, could prove extremely effective. Limited use of these systems is not sufficient; they need to be adopted nationwide.

Additionally, scientifically designed underpasses, overpasses, and earthen ramps can play a vital role in ensuring safe elephant transit. According to the Ministry of Environment, such structures can significantly reduce elephant mortality.

Jana Nayagan vs. Parasakthi: The Politics Playing Out On Tamil Nadu's Screens



This Pongal, Tamil cinema isn't just selling tickets - it's signalling the opening moves of the 2026 assembly election. January 9 and 10 promise more than the usual festive box-office fireworks in Tamil Nadu. They mark a cinematic clash freighted with political meaning - one that could shape the narrative heading into the 2026 Assembly elections. On one side is Jana Nayagan, Vijay's much-hyped "final film" before he focused entirely and only on winning the 2026 assembly elections. On the other hand is Parasakthi, a title that echoes with the ideological thunder of Dravidian politics itself. This is not merely a contest between two films; it is a proxy battle for political space, symbolism, and supremacy. At the centre of this confrontation stands Vijay - the undisputed "X factor" in Tamil Nadu's political landscape. His entry into politics has disrupted a system long defined by the DMK-AIADMK binary that has dominated the state since 1967. By positioning the 2026 election as a direct contest between the DMK and his own Tamilaga Vettri Kazhagam (TVK), Vijay has declared his intent to rewrite the rules of the game. Importantly, Vijay is not an ideological disruptor. He has publicly endorsed Dravidian ideology and embraced its political traditions. His challenge is not to the idea of Dravidianism itself but to the electoral dominance of the two parties that have historically claimed ownership of it. That makes him a far more dangerous challenger - an insider with mass appeal, not an outsider railing against the system. Jana Nayagan, which Vijay has declared will be his final film, appears tailor-made for this political moment. Early indications suggest a familiar but potent narrative: the righteous mass hero taking on a corrupt and unjust system. The subtext is hard to miss. This is Vijay, the star, rehearsing Vijay, the politician, toppling a decaying order and offering a new alternative. If the tone for 2026 hasn't already been set, Jana Nayagan aims to set it. From a purely commercial standpoint, the film's success seems all but assured. Vijay's recent track record has made him arguably the most bankable star in Tamil cinema today, if not in India. Box-office dominance has become his default mode. Yet, the Dravida Munnetra Kazhagam (DMK) is not content to cede this symbolic space uncontested. Its counter comes in the form of Parasakthi, starring Sivakarthikeyan, another rising superstar but one whose film carries weight far beyond its leading man. The title Parasakthi is inseparable from Tamil cinema's political history. The 1952 classic, featuring Sivaji Ganesan and scripted by M Karunanidhi, was a cinematic manifesto. Its iconic courtroom monologue - an excoriation of God, social inequality, religious orthodoxy, and moral hypocrisy - became a rallying moment for the Dravidian revolution. Released just two years after the DMK's formation, the film functioned as powerful propaganda to sow the seeds for many such cinematic moments that culminated in an electoral revolution. "Odinen Odinen, Vazhkaain Ellairke Odinen" (I ran and ran, I ran till the end of life itself) thundered Shivaji Ganesan passionately. It has echoed in the Dravidian political theatre since. The 2026 Parasakthi, directed by the largely apolitical Sudha Kongara, is unlikely to replicate that radical substance. But it doesn't need to. The power lies in the name and in the machinery behind it. The film is being distributed by Red Giant Movies, founded by Deputy Chief Minister Udhayanidhi Stalin, a company frequently accused of wielding disproportionate influence over film distribution in the state. The decision to release Parasakthi on January 10 - just a day after Jana Nayagan - is strategic to the point of provocation. It creates the unmistakable optics of a direct challenge to Vijay at the box office during the lucrative Pongal window. Notably, the release was advanced from January 14, a move that followed Vijay's fiery Erode rally, where he branded the DMK an "evil force". The timing suggests retaliation as much as competition. Red Giant, founded by Udayanidhi Stalin and now run by his son, has been accused several times of leveraging political power to secure screens and crowd out rival releases. This time, too, there will be a battle for theatres between the two releases, which could lead to sharp political accusations. The fact that Red Giant is releasing a film with a politically enormous title in a politically timed manner to challenge Vijay, arguably DMK's most powerful threat, leaves no doubt that Parasakthi is political. An impact on Jana Nayagan's opening collections would be symbolically significant for the DMK, but this is not about money. This is about the perception of a cinematic and political challenge to Vijay. Beyond box-office tallies, Parasakthi sends a clear political message: the DMK is ready for Vijay's challenge. It reasserts the party's claim as the original custodian of Dravidian ideology and attempts to dilute the political conversation Vijay hopes to dominate with Jana Nayagan.

AT 14, VAIBHAV SURYAVANSHI MIGHT JUST BE TOO GOOD TO BE 'PROTECTED'

On April 2, 2011, when MS Dhoni hit Nuwan Kulasekara for the ODI World Cup-winning six at the Wankhede stadium, about 1,900 kilometres away, in Tajpur village of the Samastipur district of Bihar, a six-day-old infant lay blissfully unaware of the historic achievement of the Indian men's cricket team. Fast forward just over 14 years, and that kid is being tagged a "generational talent". Some might feel it's a little too early to call him that, but Vaibhav Suryavanshi seems to be on a mission to silence any and all doubters. A batter's job is to simply score as many runs as possible, every single time he or she strides out to the middle. And Vaibhav, who will turn 15 in March next year, has been keeping the scorers and statisticians rather busy. A look at just the last year he has had makes for rather surreal reading. In April, he became the youngest centurion in men's T20s (14 years and 32 days) when he hit a 35-ball 101 for RR vs GT in IPL 2025. In July, he hit the fastest recorded century in a youth One-Day international (a 78-ball 143 vs England in Worcester). In November, he smashed a 32-ball ton for India A vs the UAE in an Asia Cup Rising Stars T20 game, becoming the joint fifth fastest centurion in men's T20s (144 off 42 balls). And



then, just under a year after his senior team debut for Bihar, he became the youngest to score a century in men's List A cricket (One-day cricket, including ODIs and domestic one day cricket) and also broke AB de Villiers' record for the fastest 150 in men's List A cricket (190 off 84 balls), in just his seventh List A match. Keep The Balance The million-dollar question now is, should Vaibhav be fast-tracked into the senior India set-up for T20i cricket? The one caveat here that must be mentioned is that the people in the corridors of power in Indian cricket have to be clear about the fact that while he potentially can be fast-tracked into white ball formats, his development in the red-ball format must not suffer at any cost. For T20i cricket, the wait ideally should-

n't be a long one. He has an average of 41.23 in the format with a strike rate of 204.37, and is not overruled by a 'star player' running in to bowl to him. But at the same time, they must give him time to play more First-Class cricket against quality opposition - something his team, Bihar, is not getting in the Ranji Trophy Plate Group - to ensure that his Test future is not put in jeopardy. That is going to be a tightrope walk. There has to be a proper plan in place in terms of allowing him to express himself fully in one format while continuing to improve in another. But it's difficult to do so, especially with Bihar cricket not in the best of shape. They were sidelined for 17 years after Jharkhand received statehood in November 2000, and their return to the Ranji Trophy

Elite Group for the 2023-24 season made headlines for all the wrong reasons. A 'Special Case' This is where the BCCI has to take the lead. The people in charge of the Centre of Excellence (formerly the National Cricket Academy) have to be directed to handle Vaibhav as a 'special case' and liaise with the selectors on a regular basis vis-à-vis his improvement. Remember, he is just 14, and for many experts, he should be allowed to develop his game and hone his natural skills some more before being pushed into the deep end. But then again, as far as white ball formats are concerned, this is a young man who faced the likes of Mohammed Siraj, Rashid Khan, Ishant Sharma, Prasidh Krishna and Washington Sundar to score a 38-ball 101 in the IPL and has

an average of over 50 in youth ODIs. What if this southpaw is destined to be the next Yuvraj Singh? Would it not make more sense to expose him to the real rigours of senior cricket - one format at a time - and see how he copes with those challenges and pressures? If the experiment doesn't work, he can always go back to domestic cricket and raise his level before he is given another shot at senior international cricket. He is definitely not running out of time. Sure, India have a ton of top order T20i batting options, but given a shot, he might just overshadow some of the 'regulars'. Maybe the national selectors can emulate the Rajasthan Royals' blueprint. Learn From RR? Kumar Sangakkara, the current Director of Cricket at Vaibhav's IPL franchise, the Rajasthan Royals, has predicted a "very, very special" future for the supremely talented teenager, whose power, timing and technique all impressed the former Sri Lankan captain. Maybe Sangakkara had a quiet laugh when he thought about how the stars had aligned for the teenager from Samastipur, who was just days old when Sangakkara had the best seat in the house to watch Team India chase down the target Sri Lanka had set for them in the 2011 ODI World Cup final, from behind the stumps.

RAHUL VS PRIYANKA? NOT REALLY

Imran Masood of the Congress recently said that if Priyanka were made Prime Minister, she would teach Pakistan a lesson, just like Indira Gandhi did. In other words, Imran Masood subtly advocated for Priyanka Gandhi. It's true that many in the Congress see a glimpse of Indira in Priyanka; people find her accessible and natural. However, is this resemblance alone a reason enough to make Priyanka the leader of the Congress in the Lok Sabha? After all, she has been a member of the Lok Sabha for barely 12 months, and that doesn't quite justify being potentially appointed as either the Congress's leader or the Leader of the Opposition in the Lok Sabha. It is true that in Rahul Gandhi's absence recently, Gandhi stepped forward during the Parliament session and led the opposition deftly - especially on issues like the G Ram G Bill and the overhaul of MGNREGA. Her march with the entire opposition to the Gandhi statue was striking, as was her chat over tea and snacks with the Speaker of the Lok Sabha. However, not many have pointed out how this decision was taken by Congress President Mallikarjun Kharge. People



also appreciated Priyanka's style, which stood out in stark contrast to the fact that Rahul never attended such tea meetings. The little-discussed truth, however, is that the decision not to go for tea with the Speaker of the Lok Sabha or the Chairman of the Rajya Sabha was taken by the party itself. And this time as well, the decision to attend the meeting was the party's. That said, it can't be denied that there is certainly a difference between the two siblings' approach to politics. Rahul Gandhi has been much harsher towards the Bharatiya Janata Party (BJP), the reason perhaps being that he has forgotten neither the way the latter had targeted Sonia Gandhi during the UPA years, nor how it mocked him relentlessly through both personal attacks and public ridicule. Rahul has been winning Lok Sabha elections continuous-

ly since 2004. As far as bringing the party to power is concerned, this time, when the Congress won 99 seats in the Lok Sabha, workers were enthused. The party lost elections in many states and won in some, but Rahul kept going. His image is now that of a leader who keeps fighting even after defeat - someone with the courage to walk on foot from Kanyakumari to Kashmir. However, Rahul is surrounded by complacent leaders, and that is a pitfall in itself. Many of them are friendly with the BJP, while many others spend their time pulling down those who are actually fighting. Rahul has his own team of young workers, running the party in their own way, and it is for them to answer why the party's performance has not improved, and whether the issues they are raising will bring success or not - and, if not, why.

Pinarayi Vijayan must not interfere in Karnataka's affairs without knowing the truth: DCM DK Shivakumar

Bengaluru : Deputy Chief Minister D K Shivakumar hit out at Kerala CM Pinarayi Vijayan for unnecessarily interfering in evictions in an encroached land in Bengaluru.

Speaking to reporters at his Sadashivanagar residence, he said, "It is unfortunate that senior leaders like Pinarayi Vijayan has commented on this without knowing the facts of the matter. The land which was cleared of encroachment was a solid waste pit. There are many health-related issues in the area due to this. We also have humanity and we had given them an opportunity to move to other areas. Leaders like Pinarayi Vijayan should not interfere in such matters. Land mafia sets up slums in order to encroach upon the land at a later stage, we won't let that happen. We are willing to



give houses under Rajiv Gandhi scheme if there are eligible people." He was replying to Kerala CM saying Karnataka government was involved in 'Bulldozer raj' in Bengaluru. "We don't have Bulldozer culture, I appeal to Pinarayi Vijayan not to talk like that. We are only pro-

tecting government land in the middle of the city. We will send out a message regarding this to our party leaders in Kerala," he added. "Bengaluru is not like other cities, we don't have many slums. This is Krishna Byre Gowda's constituency and he has spoken to officials about it. This is nothing to do

with minorities. If there is anyone who is genuinely affected, we will provide them with housing elsewhere. Our government under the leadership of CM and Housing Minister Zameer Ahmed has built lakhs of homes for the poor in the state."

Asked about some people protesting in view of Pinarayi Vijayan's statement, he said, "These are all politically motivated statements and protests. He should not comment on matters of our state without knowing the facts. This is a political gimmick in view upcoming Kerala elections."

Asked if the evicted people had any rights, he said, "Whoever lives in Karnataka with valid documents will be provided necessary support. We have instructed officials to give out clear instructions regarding this."

Swathi and Swetha study in classes 11 and 12 at the Government Girls Higher Secondary School in Koothanallur, while Siveshwar studies in class 4 at a government-aided school. Three months ago, Sivakumar also died due to ill health, leaving the children without parental support. Their relatives have not taken responsibility for them, and the three currently



live alone in a thatched house on poromboke land. As they attend school, they have no means to work and have been struggling without income.Their house is in

a dire state with a leaking roof. Even the bathroom has no roof, and they use polythene sheets and cloth as a makeshift cover. Despite these conditions, the children con-

tinue their studies with dedication, and Swathi aspires to become a nurse. The children had sought immediate assistance for food, clothing, shelter and education. After learning of their situation, the Chief Minister instructed officials to extend appropriate support. Minister for Industries TRB Raaja, MLA Poondi K Kalaivanan and District Collector Mohanachandran visited the children's house. During their visit,

Stalin spoke to the children via video call, assured full government support and encouraged them to remain courageous and excel in their studies. A free house site patta was issued to them. Under the Anbukkarangal scheme, arrangements have been made for the three children to receive Rs 2,000 per month from January. The children became emotional and expressed gratitude. Officials, including Mannargudi Assistant Collector Yogeswaran and others, were present.

TN to tweak rules to deploy hired buses on nationalised routes



CHENNAI: The state government has proposed an amendment to the Motor Vehicles Rules to permit State Transport Undertakings to operate hired or leased private buses on nationalised routes when they are unable to deploy their own fleet, in an effort to maintain uninterrupted services.

A draft gazette notification issued by the Home Department dated December 8 said the draft amendment to Rule 288-A of the Tamil Nadu Motor Vehicles Rules, 1989, has been published for public feedback, as required under Section 212 of the Motor Vehicles Act. The change is aimed at ensuring uninterrupted regular bus services in nationalised sectors despite shortages in the fleets of transport corporations.

Under the proposal, the State Transport Undertakings will be per-

mitted to operate private vehicles taken on hire or lease, after obtaining a permit through Form SCPA (STU) for the vehicle concerned. This provision would override existing restrictions in Rule 288 that bar such operations by private vehicles on nationalised routes.

The move comes as transport corporations increasingly turn to alternative fleet deployment models. In Chennai, the Metropolitan Transport Corporation has already begun operating electric buses under the gross cost contract model through the World Bank-supported Chennai City Partnership Programme. In the first phase, it plans to run 625 electric buses, including 225 air-conditioned services, while tenders have been finalised to induct another 600 buses in the second phase.

Fog, strong winds forecast across TN over next two days

CHENNAI: The India Meteorological Department (IMD) has forecast largely dry weather conditions across Tamil Nadu, Puducherry and Karaikal over the next two days, attributing the change to variations in the easterly wind pattern prevailing over the region. While widespread rainfall is not expected, the department has cautioned residents about early morning fog, slightly lower night temperatures in select

areas, and strong surface winds along the coastal belt.According to the IMD, light mist or fog may form during the early morning hours in isolated pockets across Tamil Nadu, Puducherry and Karaikal. The Weather Department noted that there would be no significant change in minimum temperatures across most parts of the state.However, in a few interior regions, particularly in higher elevations, night temperatures may

remain 2 to 3 degrees Celsius below normal until Sunday.Special attention has been drawn to the Nilgiris district and the Kodaikanal hill region in Dindigul district, where cold conditions are expected to persist. The IMD has warned that one or two locations in these areas may experience mist or frost-like conditions during late-night or early morning hours, which could affect visibility and early-morning travel.

TVK's Arunraj slams DMK govt over ongoing working group protests

CHENNAI: Tamilaga Vetti Kazhagam general secretary (policy and propaganda) Arunraj, on Saturday, alleged that the protest by teachers, nurses and cleanliness workers over the non-fulfilment of the promises made to them by the ruling DMK exposes cracks in the Chief Minister's public image and asserted that people would deliver a decisive verdict through the ballot.



In a social media post on Friday, Arunraj accused the Tamil Nadu government of attempting to suppress democratic protests rather than

fulfilling its electoral promises. He criticised the handling of the demonstration by graduate teachers demanding equal pay for equal work, saying police action was being used against those who trusted the promises and voted for the government. He said the police prevented protesting teachers from speaking to the media and forcibly removed them from the protest site.

US pauses OFFSHORE WIND projects over security concerns

The US is immediately pausing leases for offshore wind energy projects currently being built near the Atlantic coastline, citing security concerns. In a statement, the Department of the Interior said it was pausing five large-sale projects to look into how windmills could interfere with radar and create other risks to east coast cities. President Donald Trump has long opposed wind energy, saying it is unreliable and drives up costs, and attempted to stop all projects when he returned to office. Interior Secretary Doug Burgum has said wind farms have no future in the US energy grid. Renewable energy companies, as well as state leaders, have expressed alarm over the administration's stance. In its statement, the Department of the Interior said the pause "addresses emerging national security risks, including the rapid evolution of the relevant adversary technologies, and the vulnerabilities created by large-scale offshore wind projects with proximity near our east coast popula-



tion centres". The five wind farms now on pause are being constructed off the coast of New York, Virginia, Massachusetts, Rhode Island, and Connecticut. Specifically, the announcement noted that officials are concerned about radar interference "clutter" that can obscure real moving targets or, conversely, create false ones. It added that a radar's threshold for false-alarm detection could be increased to reduce some clutter, but

only at the risk of missing actual targets. The wind projects could make it difficult to "determine what's friend and foe in our airspace", Burgum said in an interview with Fox Business on Monday, where he cited drone strikes between Russia and Ukraine and between Iran and Israel as examples. Dominion Energy, the company behind the Virginia wind farm, said its project is far offshore and "does not raise visual

impact concerns." "The project's two pilot turbines have been operating for five years without causing any impacts to national security," it said in a statement. Dominion saw its share price drop more than 3% after the announcement. Orsted, the Danish wind energy giant, recorded a 12% drop in its share price, while turbine maker Vestas' stock fell by 2.6%. Connecticut Governor Ned Lamont, a Democrat, described the pause as an

"erratic" move that "will drive up the price of electricity in Connecticut and throughout the region". "This project is nearing completion and providing good-paying clean energy jobs," he added. "Businesses and residents deserve economic predictability, yet with the administration's constant starts and stops they're left with the opposite." Earlier in December, a federal judge struck down an attempt by President Trump to ban new wind power projects in the US, calling it "arbitrary and capricious and contrary to law". On the first day of his administration in January, Trump issued a memorandum halting permits and new leases until a federal review could be undertaken. Five months later, 17 US states led by New York sued the administration, calling the ban an "existential" threat to the US wind industry. Demand in the US for energy is expected to significantly expand in the years ahead, driven by the needs of artificial intelligence firms.

Coinbase ex-employee held for cyber-crime; CEO thanks Hyderabad Police



Coinbase Global Inc. co-founder and CEO Brian Armstrong thanked the Hyderabad police for arresting an ex-Coinbase customer service agent who allegedly led a cyberattack on the company in May this year. In an X post shared on Friday, December 26, Armstrong said, "We have zero tolerance for bad behaviour and will continue to work with law enforcement to bring bad actors to justice. Thanks to the Hyderabad Police in India, an ex-Coinbase customer service agent was just arrested. Another one down and more still to come." The arrest is linked to one of the most high-profile security breaches involving a crypto-based company this year. Criminals demanded USD 20 million ransom Hackers

allegedly bribed the employees outside the United States to attain sensitive information on customer data and demanded a USD 20 million ransom. The company stated that the breach could cost it up to USD 40 million, Bloomberg reported. Upon confirmation of the breach, the company spokesperson also reported that it had filed charges against a Brooklyn man. In a blog post dated May 15, Coinbase laid out the details of the extortion attempt. The criminals had reportedly targeted their customer support agents overseas, which has now been established as India, and used cash offers to bribe employees to copy data from customer support tools. This primarily affected fewer than 1 per cent of

Coinbase's monthly transacting users. "Their aim was to gather a customer list they could contact while pretending to be Coinbase—tricking people into handing over their crypto. "They then tried to extort Coinbase for USD 20 million to cover this up. We said no," the blog read. The company stated that it would compensate those affected by the cybercrime, instead of paying the ransom. "We're cooperating closely with law enforcement to pursue the harshest penalties possible and will not pay the USD 20 million ransom demand we received," adding, "Instead, we are establishing a USD 20 million reward fund for information leading to the arrest and conviction of the criminals responsible for this attack."

Waymo robotaxis stop in the streets during San Francisco power outage



A massive power outage in San Francisco over the weekend led Waymo self-driving taxis to stop working around the city. "Significant and extensive" damage from a fire in a substation caused the Saturday afternoon outage that left more than 100,000 customers without power, utility provider PG&E said in a statement. Videos posted to social media showed Waymo robotaxis halted in the middle of city streets and intersections with their hazard lights flashing, as traffic jams grew and drivers zigzagged around the stopped cars. Waymo initially paused all service in the Bay Area following the outage, but has

since resumed its operations, a spokesperson said in a statement. During the outage, many traffic signals stopped working, city officials said, and Mayor Daniel Lurie deployed police officers, fire crews, and others to help with the flow of cars on the roads. Some commuter train lines and stations shut down, as well. Waymo said it was working with city officials throughout the outage "While the Waymo Driver is designed to treat non-functional signals as four-way stops, the sheer scale of the outage led to instances where vehicles remained stationary longer than usual to confirm the state of the affected intersections."

GOLD AND SILVER HIT RECORDS AS INVESTORS HUNT FOR SAFETY

The gold price has hit another record high, trading above \$4,400 (£3,275) an ounce for the first time. The price of the precious metal has risen on expectations the US central bank will cut interest rates further next year, analysts said. Gold started the year worth \$2,600 an ounce, but geopolitical tensions, the Trump tariffs and expectations of rate cuts have added to investor demand for safe haven assets, such as gold and other commodities. The prices of other precious metals also rose on Monday, with silver hitting a record high as well. The gold price has risen more than 68% this year, the highest increase since 1979, according to Adrian Ash, director of research at gold bullion marketplace BullionVault. 2025 has seen "slow-burning trends around interest rates, around war and trade tensions", Mr Ash said, which have helped to push up the price of gold. "The precious metals market says that President Trump has really triggered something – and gold has gone crazy this



year. "You've got the trade war, the attacks on the US Federal Reserve and you've got geopolitical tensions, all of those provocations come from Trump," he said. After passing the \$4,400 an ounce mark on Monday, the spot price of gold hit a high of \$4,426.66. Lower interest rate expectations typically mean lower returns for investments such as bonds, so investors look to commodities such as gold and silver to get a return, but also diversify their portfolios. The consensus among analysts currently is that the US will lower interest rates

twice in 2026. Another factor adding to demand is that central banks globally are expanding their own physical holdings of gold as a way to counter economic turbulence, reduce reliance on the US dollar, and diversify their own portfolios, according to analysis from Goldman Sachs, which predicted the pattern would continue in 2026. The steady increase in the price of gold across the year could be because it is seen as a way for traders to help shield themselves from the threat of inflation and economic

turmoil, Anita Wright, chartered financial planner at Ribble Wealth Management, said. "When confidence in financial assets and policy stability starts to wobble, gold tends to respond first as the primary monetary metal," Ms Wright said. A weaker US dollar has also helped push gold prices higher by making the metal cheaper for overseas buyers. Other precious metals have also had record years. The price of silver also hit a record of \$69.44 an ounce on Monday. For 2025 so far, silver is up 138% year-to-date and platinum is at a 17-year high, vastly outperforming gold, underpinned by strong and supply constraints, according to analysts. Unlike gold, the other precious metals are also used widely in industrial manufacturing which helps stoke demand. Separately, oil prices rose on Monday, after the US ordered a "blockade" last week of sanctioned oil tankers entering and leaving Venezuela. The price of Brent crude rose \$1.31 to \$61.78 a barrel, while US oil

Surprise drug checks to be carried out around Hyderabad for New Years

Hyderabad: The Hyderabad Narcotic Enforcement Wing (H-NEW) has formed special teams to conduct surprise special checks at pubs, clubs, bars, and restaurants across the city in view of the New Year celebrations. As part of their special drive on December 26, six decoy teams were deployed randomly to conduct discreet checks without causing any inconvenience to the management or the general public, a press release said. Suspicious persons around the premises of various establishments were screened using rapid drug testing kits, and all results were found to be negative. Such special drives will continue across the city in the upcoming days to deter offenders and safeguard public interest. Hyderabad police to adopt 'zero drugs policy' The Hyderabad Police on Friday said it would adopt a 'zero drugs' policy for the New Year celebrations. City Police Commissioner V C Sajjanar, who chaired a coordination meeting with police officials, issued a stern direc-



tive to top brass and officers on the field to maintain a "hawk-eyed" vigil across the city. Officials of various police wings, including H-NEW, Task Force, Special Branch and local law enforcement, have been tasked with preparing a comprehensive list of known drug peddlers and consumers. Additionally, the police will also collect the details of individuals entering the city for the festivities. The crackdown is not limited to public venues; the police will also monitor private gatherings at service apartments and hostels to prevent illicit activities. The City Police have set a mandatory

1:00 am closing time for all New Year celebrations at pubs, hotels and restaurants. "Strict action will be taken against violators. (They) will face immediate cancellation of licenses if found engaging in any illegal activities this year," the Commissioner warned. To manage the influx of revellers, check-posts and barricades would be set up at major hubs, including Maitrivanam, Necklace Road, Tank Bund, and KBR Park, he added. While the security is set to be intense, the Commissioner emphasised that the general public should not be inconvenienced.

The brand is owned by Japanese drinks giant Suntory Global Spirits, which employs more than 1,000 people across its sites in Kentucky. The firm said its other operations in the state, including a separate distillery and its bottling and warehousing plants, would continue to run next year. The visitor centre in Kentucky also



remains open. Jim Beam also said it was assessing how it would use its workforce during the production pause, and was holding talks with the workers' union. In October, the Kentucky Distillers' Association (KDA) trade body said the amount of bourbon in warehouses across the state was at a record high of more than 16 million barrels.

According to the association, the barrels of bourbon, which are taxed by the state, have cost distillers "a crushing" \$75m (£56m) this year. US distillers have faced retaliatory import taxes on their goods after Trump's so-called "Liberation Day" announcement in April saw the US imposing tariffs on most countries around the world. "Much

of the expansion over the last decade has been geared towards global growth," the KDA said in October as it called for a "for a speedy return to reciprocal, tariff-free trade". Trade tensions between the US and Canada have also affected sales of alcohol, with most Canadian provinces boycotting American spirits earlier in the year.

THOUSANDS WITHOUT POWER in Kyiv after massive Russian attack

A third of residents in Ukraine's capital Kyiv are without power after a "massive bombing" of residential areas and critical infrastructure by Russia overnight, Ukraine's foreign minister has said. Andrii Sybiha said residents had been left without heating in freezing winter temperatures. At least one person was killed and 28 others were injured in the strikes, Ukraine's State Emergency Service reported. The attacks happened hours before Ukrainian President Volodymyr Zelensky departed for Florida, where he will meet Donald Trump on Sunday for peace talks. Russia's ministry of defence said it had launched a "massive retaliatory strike" on Ukrainian energy infrastructure facilities. It said it used long-range, land, air, and sea-based precision weapons to target the facilities,



ties, which it claimed were being used "in the interests of the Ukrainian Armed Forces and enterprises of the Ukrainian military-industrial complex". Following the strikes, Zelensky repeated his claim that Russia does "not want to end the war and is trying to use every opportunity to inflict more pain on

Ukraine". Writing on Telegram, Zelensky said Russia directed almost 500 drones and 40 missiles towards Kyiv, targeting energy and civilian infrastructure. Pictures show apartment buildings with gaping holes and homes on fire following the strikes. The apartment block of BBC journalist Anastasiya

Gribanova was struck, leaving some homes on the higher levels of the high-rise building in flames. Gribanova, who was in the building's elevator at the time, was unharmed. Ukraine's State Emergency Service said that 68 people were evacuated from a retirement home in the eastern Darnytskyi district.

"Russian representatives are having long conversations, but in reality the Daggers [missiles] and Shaheds [drones] are speaking for them," Zelensky wrote on Telegram, saying that Vladimir Putin does not want to end the war. "This sick activity can only be responded to with really strong steps. America has this opportunity, Europe has this opportunity, many of our partners have this opportunity," he wrote, urging allies to show strength against Russian aggression. The strikes saw Poland, which shares a 530km-long (320-miles) border with western Ukraine, ready its fighter jets, ground-based air defence systems and radar reconnaissance. The move was "aimed at securing and protecting the airspace, especially in areas adjacent to the threatened regions," Poland's Armed Forces said. Later on

Saturday morning, it concluded that there had been no violation of the country's airspace. Meanwhile, Russia's defence ministry said its air defences destroyed seven Ukrainian drones overnight. On Saturday, Zelensky, EU leaders and European Commission president Ursula von der Leyen are expected to hold a phone call to discuss the road to peace. Zelensky's new 20-point draft is a revised version of an earlier 28-point plan which was drafted by US special envoy Steve Witkoff, but widely seen as being too favourable to Russia. The Ukrainian president has voiced optimism around the new draft, describing it as "a foundational document on ending the war", but Trump warned that Zelensky "doesn't have anything until I approve it" in an interview with Politico.

FOUR HIKERS FOUND DEAD AFTER AVALANCHE IN CENTRAL GREECE



Four hikers who went missing on Christmas Day have been found dead after being buried by an avalanche in the snow-covered Vardousia Mountains in central Greece. The bodies of three men and a woman were found on Friday evening after a large-scale search in the mountainous region of Fokida, according to Greek state broadcaster ERT. Fire service teams located the bodies partially covered by snow on a steep and inaccessible slope near the summit of Korakas peak, at an altitude of about 2,000m (6,561ft). Rescue officials said the group was swept away by an avalanche. Authorities said

the hikers had begun their ascent in favourable weather, but conditions quickly worsened due to the altitude and the area's terrain. Vasilis Vathrakogiannis, a spokesperson for the Hellenic Fire Service, told the BBC the alarm was raised by a friend of the three men after they failed to return at the expected time. "Weather conditions were extremely difficult, with low temperatures and poor visibility," he said, adding this made it hard for both drones and a helicopter to detect anything. He said a fire service ground team later found the bodies of the three men and a woman.

THOUSANDS OF US FLIGHTS DISRUPTED AS WINTER STORM LOOMS



Thousands of flights across the US have been cancelled or delayed as the north-east braces for a severe winter storm during the peak holiday travel season. As of Friday night, 1,600 flights across the US had been cancelled and 7,400 had been delayed, according to flight tracking website FlightAware. The most affected airports are John F Kennedy International, Newark Liberty, and LaGuardia, which all serve the New York area. Boston, Chicago, and Toronto, Canada, are also impacted. The National Weather Service issued a winter storm warning from 16:00 local time (21:00 GMT) on Friday until 13:00 on Saturday, with as much as 9in (23cm) of snow expected in NewJetBlue Airways had cancelled 229 flights, while Delta Air Lines scrapped 241 flights. Republic Airways and Southwest Airlines cancelled 180 and 151 flights respectively. About 100 scheduled flights by

American Airlines and United Airlines were also cancelled. On social media, airports were warning travellers to check with their airline to determine the status of their flights. The heaviest snow was expected between 18:00 local time (23:00 GMT) and midnight. Drivers were warned of hazardous conditions and advised to bring an emergency supply kit. New York Governor Kathy Hochul said people should avoid unnecessary trips, but if they had to travel, they should "plan ahead, take it slow, and leave plenty of time to get to where you need to go safely". There were similar warnings from the governors of New Jersey and Connecticut. This will be the second significant snowfall of the season for New York City, which was blanketed with several inches on 14 December. Mayor Eric Adams asked people who drove to work on Friday to leave early or consider taking public transport home.

Israel recognises Somaliland as independent state, Netanyahu says

Israel has become the first country to formally recognise Somalia's breakaway region of Somaliland as an independent nation. Prime Minister Benjamin Netanyahu, said Israel intended to immediately expand cooperation in agriculture, health, and technology. Somaliland's president, Abdirahman Mohamed Abdullahi, called the development "a historic moment". Recognition by Israel could encourage other nations to follow suit, increasing the region's diplomatic credentials and access to international markets. Somalia's prime minister, Hamza Abdi Barre, said his country categorically and unequivocally rejected what he called a deliberate attack by Israel on its sovereignty.

eighty. Abdullahi said in a statement that Somaliland would join the Abraham Accords, in what he called a step toward regional and global peace. Somaliland was committed to building partnerships, boosting mutual prosperity and promoting stability across the Middle East and Africa, he added. The decision has been condemned by the foreign ministers of Somalia, Egypt, Turkey and Djibouti, who in a statement affirmed their "total rejection" of Israel's announcement. The two countries had agreed to establish "full diplomatic ties, which will include the appointment of ambassadors and the opening of embassies", Israeli Foreign Minister Gideon Saar said in a statement on X.

Thailand and Cambodia agree ceasefire after weeks of deadly clashes

Thailand and Cambodia have agreed to an immediate ceasefire, the defence ministers of both countries have said in a joint statement. The two sides have agreed to freeze the front lines where they are now and allow civilians living in border areas to return home, halting almost three weeks of intense clashes in which dozens of people have been killed and nearly one million displaced. The ceasefire took effect at noon local time (05:00 GMT) on Saturday. Once it has been in place for 72 hours, 18 Cambodian soldiers held by Thailand since July will be released, the statement said. The breakthrough came after days of talks between the two countries, with diplomatic encourage-



ment from China and the US. The agreement prioritises getting the displaced back to their homes, and also includes an agreement to remove landmines. Thailand's Defence Minister Natthaphon Narkphanit described the ceasefire as a test for the "other party's sincerity". "Should the ceasefire fail to materialise or be violated,

Thailand retains its legitimate right to self-defence under international law," he told reporters. Thailand had been reluctant to accept the ceasefire, saying the last one was not properly implemented. They also resented what they saw as Cambodia's efforts to internationalise the conflict. Unlike the last ceasefire in July, US President Donald

Trump was conspicuously absent from this one, although the US State Department was involved. That ceasefire agreement collapsed earlier this month, when fresh clashes erupted. Both sides blamed each other for the breakdown of the truce. The Thai army said its troops had responded to Cambodian fire in Thailand's Si Sa Ket province, in which two Thai soldiers were injured. Cambodia's defence ministry said it was Thai forces that had attacked first, in Preah Vihear province, and insisted that Cambodia did not retaliate. Clashes have continued throughout December. On Friday, Thailand carried out more air strikes inside Cambodia.

'We will vote but not with our hearts': Inside the election staged by Myanmar's military rulers

On a patch of rough ground near the Irrawaddy River, aspiring member of parliament and retired Lieutenant-General Tayza Kyaw tries to muster some enthusiasm from his audience with a speech promising them better times. He is the candidate for the Union Solidarity and Development Party (USDP), backed by Myanmar's military, in Aungmyayathazan, a constituency in the city of Mandalay. The crowd of 300-400 clutch the branded hats and flags they've been given, but soon wilt in the afternoon heat, some dozing off. Children run and play in between the rows of chairs. Many of these families



lies are victims of the earthquake which badly damaged Mandalay and surrounding areas in March, and are hoping for a hand-out. They disappear the moment the rally finishes. A 'sham' election On Sunday the people of Myanmar get their first

opportunity to vote in an election since the military seized power in a coup nearly five years ago, setting off a devastating civil war. But the poll, already delayed many times by the ruling junta, is being widely condemned as a sham. The most popular party, the

National League for Democracy, has been dissolved, and its leader, Aung San Suu Kyi, is locked up in an undisclosed prison. Voting, which will happen in three stages over a period of a month, will not even be possible in large parts of the country still consumed by war. Even where voting is taking place, it is marred by a climate of fear and intimidation. When the BBC tried asking people at the rally in Mandalay what they thought of the election, we were told not to by party officials. They might say the wrong thing, one man explained – they don't know how to speak to journalists.

Two killed in suspected Palestinian ramming and knife attack in Israel

Two people have been killed in what police say was a "rolling terror attack" in northern Israel. Police said the attacker ran over a pedestrian in the eastern city of Beit Shean, then drove on before stabbing a woman near Ein Harod, about 8 miles (12.5km) to the west. The suspect was eventually shot and wounded by a civilian outside the city of Afula, according to police. Shimshon Mordechai, a 68-year-old man, was killed and a 16-year-old boy was hurt in Friday's ramming, officials said, while the stabbing victim was Aviv Maor, aged 18. A day before the attack, an Israeli reservist was fired after video emerged of him ramming a praying



Palestinian with a quad bike. The suspect in the attack came from the village of Qabatiya, in the northern occupied West Bank, Israeli Defence Minister Israel Katz said. Following the incident, the Israel Defense Forces (IDF) said it was preparing to carry out an operation in the Qabatiya area. Katz

said he had instructed the IDF to act "forcefully and immediately". The IDF said the suspect had "infiltrated into Israeli territory several days ago". Israel's Kan News public broadcaster said the 37-year-old man had been working illegally in Israel and had used his employer's vehicle in the attack.

TWO DEAD IN 50-VEHICLE PILE UP ON JAPAN HIGHWAY

A pile-up involving at least 50 vehicles on a highway in central Japan has left two people dead and 26 injured, according to police. The incident was caused by a crash between two trucks, sparking a chain reaction that set at least 10 vehicles on fire, local police said. A 77-year-old woman from Tokyo was killed, and another body was discovered in the driver's seat of a burnt-out truck. Five people were seriously injured and 21 suffered minor injuries, police said. There was a heavy snow warning in place at the time of the crash. Police believe icy surfaces likely caused the trucks to skid on the roads. The crash happened on the Kan-etsu Expressway in Minakami, Gunma prefecture, about



160km (100 miles) northwest of Tokyo, at about 19:30 local time (10:30 GMT) on 26 December. It took about seven and a half hours to put out the fire, police said. Following the incident, a section of the highway was closed, with a long line of vehicles, many charred beyond recognition, stuck in the outbound lane. Work is under way to tow them

away. A man in his 60s, whose vehicle was involved in the accident, told local media outlet NHK he heard a loud explosion from the far end of the pile-up and saw fire during the crash. The blaze then spread to other vehicles, he said. He said he was evacuated to a nearby toll gate with about 50 other people and spent the night in the hallway there.

Blast at Syrian mosque during Friday prayers leaves at least eight dead



An explosion has killed at least eight people and injured 18 others during Friday prayers inside a mosque in the Syrian city of Homs, the health ministry has said. Pictures from Syria's state-run news agency, Sana, show the inside of the Imam Ali ibn Abi Talib Mosque with black, scorched walls, smashed windows and blood on the carpet. Officials believe that an explosive was detonated inside the building, Sana reports, citing a security source. While authorities are still searching for the perpetrators, jihadist group Saraya Ansar al-Sunnah said it was behind the explosion. The mosque is in the Wadi al-Dhahab neighbourhood, where most people are part of the Alawite ethnoreligious group. Syria's Foreign Ministry condemned the "terrorist crime", writing in a statement on X that the "cowardly act is a blatant assault on human and moral values"

designed to "undermine the security and stability" of the country. Saraya Ansar al-Sunnah, a Sunni extremist group, has said it carried out the attack in collaboration with another unidentified group, using explosives planted at the site. The group's vague origins and opaque affiliations, which came to prominence in June when it said it was behind a deadly church bombing in Damascus, have raised questions about its true links and authenticity. Some observers have speculated that it could be a front for Islamic State group (IS) given the similarity in their messaging and type of targets. The latest claim follows a months-long lull in Saraya Ansar al-Sunnah's claimed attacks, which have largely taken the form of alleged targeted killings of minorities and what the group describes as "remnants" of the former Syrian government of Bashar al-Assad.

Kohli's Brilliant Gesture For Gujarat Spinner Who Dismissed Him In Vijay Hazare Trophy

Up against Gujarat in Delhi's second match of the Vijay Hazare Trophy, Virat Kohli couldn't complete back-to-back centuries in the domestic white-ball tournament on Friday. Kohli, who registered a whopping knock of 131 in the last match against Andhra, looked at his best against Gujarat too, but departed just 23 runs shy of another triple-digit score. It was left-arm orthodox spinner Vishal Jaiswal who got the better of the Indian batting icon. While Kohli was understandably disappointed to miss out on yet another hundred, his gesture for Jayswal after the game said it all about how grounded he is. Kohli could be spotted engaging in a conversation with Jayswal after the game. He even signed the match ball for the spinner, who went on to share a glorious post on Instagram later. "From watching him on TV to sharing the field. Grateful for moments like these," Jayswal wrote in a post.

"From watching him dominate world cricket to sharing the same field and taking his wicket is a moment I never imagined would turn into reality. Getting the wicket of Virat Bhai is something I'll cherish forever. Just grateful for the opportunity, the journey, and everything this beautiful game has given me," he added. Coming to the match, Delhi secured a narrow seven-run victory. Sent in to bat first, Delhi posted a competitive total of 254/9 in their 50 overs, anchored by Virat Kohli's 77 and Rishabh Pant's 70, while Jayaswal's four-fer kept Delhi's total within reach. In response, Gujarat appeared to be in a commanding position at 121/1 before a middle-order collapse shifted the momentum back to Delhi. Despite a fighting 57 from Aarya Desai and a late charge by Saurav Chauhan (49), Gujarat was eventually bowled out for 247 in 47.4 overs. Prince Yadav was the hero with the ball for Delhi,

picking up 3/37, while veterans Ishant Sharma and Navdeep Saini provided crucial breakthroughs to seal the win. Virat Kohli was named Player of the Match for his decisive knock in what could be his final domestic appearance of the season. Not only that, but he also shared a video of Jayswal dismissing Kohli in the game. After taking the wicket, the spinner's happiness knew no bounds, realising what a big scalp he got. On the other hand, after the balls were taken off, Kohli was seen having a look at the pitch as the ball spun viciously past his bat. But life looks slightly different for the Ibragimov family now. Ibragim is a professional mixed martial arts fighter and is regarded as one of the top prospects in PFL, one of the leading MMA leagues. His brothers have taken a different path in sport and have all been signed by Manchester



United - with Amir pushing for a place in the first team. "The main thing for us is to squeeze everything out of our sports," says Ibragim. "I want them to play for all of the best teams in the world. Today it is Man Utd, tomorrow it could be a different team." Dagestan, which is a republic of Russia in the North Caucasus region, has a mythical status among fight fans after producing a slew of UFC champions in recent years. The republic has a long tradition in wrestling, notably in the sambo form of the discipline, and has produced a host of Olympic and world champions in the sport.

Children from the area are often encouraged to take up wrestling almost as soon as they are able to stand. "When I was a kid, my dad was always telling me and my little brothers that we had to be strong, firstly to protect yourself, your family, and your friends," says Ibragim. "So we all got used to fighting, and that's why everyone knows how to fight in Dagestan. It's not a surprise. "Amir was a very good wrestler. You can see the transition from wrestling to football; obviously, it helped my little brothers a lot. "Some of the footballers he comes up against don't have the same base he has.

Stuart Broad Gets Emotional In Commentary Box As England End 5468-Day Wait

England registered a historic win over Australia in the fourth Ashes Test on Saturday at the Melbourne Cricket Ground. Chasing a modest target of 175, England lost six wickets but still managed to cross the finish line. It was a special moment for Ben Stokes and his team, as they ended England's 18-match winless streak in Australia. This was their first victory Down Under since 2011. Despite clinching such a memorable win, England have already missed the chance to reclaim the Ashes, as Australia lead the series 3-1. Apart from the win, one of the biggest highlights of the day was former England pacer Stuart Broad's smiling face. Fans



were quick to draw comparisons between his expressions during the Perth and Melbourne Tests. During the Perth Test, Broad's disheartened expression from the commentary box was captured after he saw Joe Root getting clean bowled. Fast forward to the Melbourne Test, Broad witnessed the

winning runs being hit and joyously celebrated the moment with a big smile. After the match, England skipper Ben Stokes expressed his thoughts on the victory and called it a complete team effort. "It's been a massive effort from everyone, and to come out on the right side of the result

feels really special. Hopefully it means a lot. We play for a lot of people - not just ourselves. The support we get, wherever we go in the world, is incredible. The noise, the chants, the constant backing - the lads out in the middle hear it, feel it, and thrive off it. I know a lot of our fans will be buzzing right now. (the build up to this game and how satisfying to win the game) Definitely very satisfying," said Stokes. "There was a fair bit going on in the build-up to this match, a lot being thrown our way. For the lads to come out, stay focused, and perform the way they did says a lot about the character in this team. Huge credit to the players, support staff.

Updated World Test Championship Points Table: What England's Win Over Australia Means For India

In a Boxing Day miracle for the visitors, England secured a famous victory over Australia at the Melbourne Cricket Ground (MCG) by 4 wickets on Saturday. While the Ashes urn had already been retained by Australia following their 3-0 lead, the result comes as a welcome boost for England, as the Melbourne win is the tourists' first in Australia in 19 Test matches. This result also has massive ramifications for the ICC World Test Championship (WTC) 2025-2027 points table. Before this match, Australia held a flawless 100% points percentage (PCT). This defeat marks their first loss of the cycle, finally opening the door



for the chasing teams. Despite the loss, Australia remain comfortably top of the table, but their PCT has dropped from a perfect 100% to 85.71%. They still look certain to reach the final, but the gap between them and New Zealand has narrowed. For England, the victory sees Ben Stokes' men accumulate a total of 12 points in

the current cycle, but they have a long road ahead. Moving up to a PCT of 35.18%, they remain in 7th place, still trailing India and the top five by a significant margin. New Zealand and South Africa are the teams to benefit the most from Australia's slip-up. With the Aussies finally dropping points, the race for the top spot

(and the psychological advantage it brings) is officially back on. India, at present, sit in 6th place with a PCT of 48.15%. With Australia and New Zealand looking strong, India will need a near-perfect run in their upcoming series to break into the top two. England, having added another win to their tally, haven't leapfrogged India yet will be pushing to surpass them in the coming games. The final Test of the Ashes series moves to the SCG (Sydney Cricket Ground) starting on January 4th. Australia will be looking to re-establish their dominance, while England will hope to carry this momentum to further improve their standing in the WTC table.

Ryan Rickelton's 1st SA20 Ton Goes In Vain As MI Cape Town Lose To Durban's Super Giants



Ryan Rickelton's maiden SA20 century was not enough to save MI Cape Town from a 15-run defeat to Durban's Super Giants in a cracking Season 4 opener at Newlands. On a run-filled opening night when a cumulative total of 449 runs were struck, which included 25 sixes and 40 boundaries, Rickleton's 113 off 65 balls took MI Cape Town to the brink. But ultimately, Durban's Super Giants' record 232/5, which eclipsed Sunrisers Eastern Cape's 204/3 in the Season 2 Final at this venue, was too much on a night when the Newlands faithful were royally entertained. DSG's all-New Zealand opening pair of Devon Conway and Kane Williamson laid the platform as they dominated the Powerplay, racing to 96 in just 8.3 overs before Tristan Luus had Williamson (40 off 25 balls, 7x4) brilliantly caught by MI Cape Town captain Rashid Khan, who ran back from mid-off before diving full length to hold on to a stunning catch. The momentum was maintained by Englishman Jos

Buttler (20 off 12 balls) and Heinrich Klaasen (22 off 14 balls) after Conway (64 off 33 balls, 7x4, 2x6) had been picked up by fellow Kiwi Trent Boult. There was no relief for the defending champions with Aiden Markram and Evan Jones keeping the boundaries flowing. Markram blitzed 35 off 17 balls (5x4, 1x6), while Jones struck an undefeated 33 off only 14 balls (4x4, 2x6). The MI Cape Town run-chase was centered around Rickelton with the left-hander continuing his love affair with Newlands. The League's leading run-scorer cut, drove and pulled powerfully despite Rassie van der Dussen (2) and Reeza Hendricks falling by the wayside. The introduction of Jason Smith, however, changed the momentum with the MI Cape Town debutant smashing an exhilarating 41 off just 14 balls (4x4, 3x6). But DSG kept chipping away with Smith, Nicholas Pooran (15) and Dwaine Pretorius (5) departing during the death overs.

When Billie Jean beat Bobby - the Battle of the Sexes that defined an era

It was the only tennis match to start with a piglet being handed over to one of the competitors - but this was no ordinary match. On 20 September 1973, an estimated 90 million people around the world watched Billie Jean King beat self-proclaimed chauvinist Bobby Riggs in a best-of-five match at the Houston Astrodome. There was pageantry, pomp and a \$100,000 (£74,765) cheque for the winner. It was the second instalment of the Battle of the Sexes - but that name is more than just a marketing slogan. King's victory over Riggs was a part of the women's right movement. It had the potential to influence politics and the future of women's tennis. When Aryna Sabalenka faces Nick Kyrgios on Sunday, it will be under the banner of the Battle of the Sexes, but the



stakes will not be as high as those that faced King 52 years ago. "The only similarity is that one is a boy and one is a girl. That's it," King told BBC Sport when asked about the Sabalenka-Kyrgios match. "Everything else, no. Ours was about

social change; culturally, where we were in 1973. Mine was really political. "I knew I had to beat him for societal change. I had a lot of reasons to win." In 1973, King was 29 years old, a 10-time Grand Slam singles champion and at the height of her powers. Riggs was 55, having won the men's singles, doubles and mixed doubles title at Wimbledon in 1939 before his career was interrupted by World War Two. "He had been following me around for two years, asking me to play. I kept saying 'Bobby, I'm not going to play you'," King told BBC World Service's Sporting Witness programme in 2017. "I only said yes because Margaret lost." Australia's Margaret Court, the 24-time major singles champion and then world number one, was one of King's fiercest rivals.

Marnus Labuschagne Frustrated, Huge Umpiring Controversy Erupts In Ashes 4th Test

The Day 2 of the 4th Ashes Test in Melbourne witnessed a big controversy unfold, forcing Marnus Labuschagne to head back to the pavilion, disappointed with the third umpire's decision. The incident took place in the 18th over of the second innings, when England pacer Josh Tongue managed to get an edge off the bat of Labuschagne, with the ball flying to the slip cordon. It was Joe Root who grabbed the ball, prompting a big appeal from the England camp. Labuschagne remained unmoved, suggesting he isn't sure if the ball carried to Root in the slips. The on-field umpire referred the decision to the third umpire, who ruled the decision in favour of the bowling team



after checking multiple angles. The third umpire suggested that Root's fingers were underneath the ball when he caught it, ruling out the possibility of the ball touching the ground first. Labuschagne, however, wasn't happy with the decision. He looked visibly frustrated as he had to head back to the dressing room. As for the match, England fought back to

bowl Australia out for 132 on Saturday. On a Melbourne Cricket Ground pitch offering substantial sideways movement for pace bowlers, England will be chasing a target of 175 to win after 30 wickets have fallen in 41.2 sessions. Resuming on Saturday on 4-0, an overall lead of 42, Australia staggered to lunch at 98-6. The dismissal of opener Travis Head (46) was quickly fol-

lowed by the departures of Usman Khawaja (0) and Alex Carey (4) in the next two overs as Australia slumped from 82-3 to 88-6 in the morning session. Ben Stokes (3-24) claimed the important wicket of Cameron Green (19) after lunch, caught at second slip, and Brydon Carse sliced through the tail to finish with 4-34. Australia held an overall lead of 46 Friday after scoring 152, running through England for 110, then reaching 4-0 in a dramatic first day England lost each of the first three tests to allow Australia to retain the Ashes in just 11 days of on-field action. Josh Tongue claimed a career-best 5-45 to lead England's bowling attack before Michael Neser grabbed 4-45 for Australia.

England Great Slams MCG Pitch, Calls It "Joke" After 20 Wickets Fall On Day 1 Of 4th Ashes Test



Former England captain criticized the Melbourne Cricket Ground pitch after a dramatic collapse of wickets during the fourth Ashes Test against Australia. A total of 20 wickets fell on Day 1 as Australia were bundled out for 152 after England opted to bowl first. However, the visitors also struggled, getting bowled out for just 110, handing Australia a 42-run lead. On Day 2, the carnage continued as England quickly wrapped up Australia's second innings for 132, setting themselves a target of 175 runs to win.

It was the first time in 74 years that 20 wickets had fallen on Day 1 of a Test match down under. Taking to X (formerly Twitter), Vaughan wrote, "This pitch is a joke .. This is selling the game short .. The players / Broadcasters and more importantly the fans .. 26 wickets in 98 overs !!!!! #Ashes." Talking about the

match, England raced to within 98 runs of winning a chaotic fourth Ashes Test Saturday for the loss of Ben Duckett and Brydon Carse as they aggressively chased 175 to clinch a seesawing contest. At tea on day two, they were 77-2 off just 12 overs with Zak Crawley on 22 and Jacob Bethell nine, as they inched closer to restoring some battered pride after crashing in the first three Tests. The pumped-up tourists dismissed Australia for 132 soon after lunch in front of another bumper crowd at the Melbourne Cricket Ground, following the 20 wickets that tumbled on day one. Travis Head top-scored with 46 while Carse took 4-34. England have not won a Test in Australia since January 2011, losing 16 and drawing two since, and openers Crawley and Duckett had a clear objective to snap the streak -- play ultra-aggressive "Bazball" style.

Progressive Panel Press Meet



In the backdrop of the Telugu Film Chamber elections, a press meet was organized on Saturday afternoon by the Progressive Panel (Supported by Allu Aravind, Daggubati Suresh Babu, Dil Raju), where several producers shared their views on key issues concerning the film industry. Speaking on the occasion, Mr. K.S. Rama Rao said: Progressive activities in the Chamber have not been implemented properly. It is unfortunate that some people are more focused on money-lending and interest business. The Film Chamber building was constructed purely for the benefit of the entire film indus-

try. Even the Filmnagar Society allotted lands only for the welfare of film industry members. The core objective of the Progressive Panel is unity and protection of producers. There should be no difference between big films and small films. Allegations being made against the Guild are only baseless accusations. Mr. Ashok Kumar said: We fought strongly to ensure Film Chamber elections were conducted. Some people deliberately delayed the elections, he alleged. Even as Vice-President, he worked continuously for five months for the elections. The Chamber building exists only for the film

industry, he reiterated. To improve the present situation of the industry, the Progressive Panel must come to power. Only those who actually make films should have a place and role in the Chamber. Mr. Ravikishore said: Responding to allegations on the Guild, he clarified that it was formed to meet the day-today needs of producers. On issues like Qube and UFO, they coordinated with producers and sought workable solutions. He alleged that another panel is planning to sell the Chamber building. Since GST on mediclaim made it expensive, benefits were planned only for eligible members, he explained.
