Cong marks 140th foundation day in Delhi

NEW DELHI: The Delhi Pradesh Congress Committee (DPCC) on Sunday observed the 140 Foundation Day of the Indian National Congress (INC) at the party's Rajiv Bhawan office. DPCC President Devender Yadav hoisted the party flag and joined Seva Dal workers in singing the national song, 'Vande Mataram'.

Earlier in the day, he attended the main event at the party's national headquarters, Indira Bhawan, where Congress President Mallikarjun Kharge unfurled the flag in the presence of CPP Chairperson Sonia Gandhi and Leader of Opposition in Lok Sabha Rahul Gandhi. Several former MPs, ministers, legislators, and party functionaries were present at the Delhi event.

Addressing attendees, Yadav stated that reaching out to people following Congress ideology was essential to provide social justice, equality, and rights to all sections of society.

6 months after inferno at Sigachi unit killed 54, company CEO arrested

HYDERABAD (TSIT): Six months after the devastating fire at Sigachi Industries Limited's unit in Telangana's Sangareddy district claimed the lives of 54 workers, police have arrested the company's Managing Director and Chief Executive Officer, Amit Raj Sinha.

Police presented Sinha before a magistrate, who sent him to judicial custody. In a disclosure to BSE Limited and National Stock Exchange of India Limited, the company informed that Amit Raj Sinha was remanded on Saturday in connection with the ongoing investigation relating to the fire incident.

"The company has taken all necessary measures to ensure the continuity of its operations and day-to-day activities. In the interim, Lija Stephen Chacko, Deputy Group CEO, will oversee the operations of the company," it said.

On June 30, a huge fire broke out following a major

explosion in the manufacturing plant of Sigachi Industries, Pashamalaram industrial area unit in Sangareddy district, killing 54 workers and injuring 33

others. While 46 bodies were identified, eight missing people were presumed dead. The plant manufactures Microcrystalline Cellulose powder, which is used in tablets and capsules as a binding agent. BDL-Bhanur Police had registered a case against the company management. The police had invoked Section 105 of the BNS for culpable homicide not amounting to murder - a cognisable offence that carries a punishment of not less than five years and up to life imprisonment, along with a fine. Besides, the FIR includes charges under

Section 110 (attempt to commit culpable homicide) and Section 117 (voluntarily causing grievous hurt).

However, no arrests were made in the case. Hearing a Public Interest Litigation (PIL), the Telangana High Court had last month taken serious note of the delay in the probe to fix responsibility for the explosion inside the factory.

A Bench of Chief Justice Aparesh Kumar Singh and Justice G.M. Mohiuddin had summoned the Investigation Officer and directed him to furnish all documents connected to the case, including the First Information Report, case diary and the report on the progress of the investigation. In a counter-affidavit filed by the state government in August, the court was told that Sigachi had given a written undertaking to pay Rs 1 crore to each deceased worker's family, though the timeframe for disbursement remains unspecified.

SC to hear CBI plea against bail to Kuldeep Sengar in Unnao rape case

New Delhi, Dec 28 (TSIT) The Supreme Court will hear on Monday (December 29) a petition filed by the Central Bureau of Investigation (CBI) challenging the Delhi High Court's order that granted bail to former Uttar Pradesh MLA Kuldeep Singh Sengar in the Unnao rape case. A vacation bench, comprising Chief Justice of India Surya Kant, Justices J.K. Maheshwari and Augustine George Masih, will hear the matter.

The CBI has approached the Supreme Court through a Special Leave Petition against the High Court's decision to suspend Sengar's life sentence and release him on bail while his appeal against conviction is pending.

Earlier this week, the Delhi High Court granted bail after holding that the stricter provisions of the Protection of Children from Sexual Offences (POCSO) Act and Section 376(2) of the Indian Penal Code were not applicable in Sengar's case.

The High Court reasoned that Sengar could not be treated as a "public servant" under these provisions and, on that basis, suspended his sentence.

The CBI has strongly objected to this reasoning. It has argued that the High Court's order weakens the protection provided to children under the POCSO Act and is not legally sustainable, espe-



cially considering the seriousness of the crime and established principles governing suspension of life sentences. According to the CBI, treating an MLA as not being a "public servant" for the purpose of POCSO defeats the very objective of the law. The agency said the Act is meant to give stronger protection to children and treat abuse of authority as an aggravating factor. A narrow and technical interpretation, it argued, undermines this purpose.

The investigating agency also submitted that POCSO is a welfare legislation and must be interpreted in a way that strengthens, not limits, safeguards for child victims.

Telangana govt selling industrial land worth Rs 5 lac cr: KTR

Hyderabad, Dec 28 (TSIT): Bharat Rashtra Samithi (BRS) working president K.T. Rama Rao reiterated that the Congress government in Telangana is selling away 9,300 acres of industrial land worth almost Rs 5 lakh crore.

"The Congress Govt in Telangana is indulging in not just sale of one chunk of industrial land but 9,300 acres of land worth almost 5 Lakh crores," Rama Rao posted on X while reacting to an X post by Congress MP Karti P. Chidambaram about Infosys selling its prime land in Attibele in Karnataka to



Puravankara for Rs 250 crore.

Chidambaram wrote that if the land was given at a concession for a specific purpose and the land wasn't utilised for that purpose, Infosys has no right to sell it for a commercial rate today. "Return the land & proceeds to the

Government of Karnataka, he posted.

Reacting to this, the BRS leader reiterated his allegation that the Congress government in Telangana is selling industrial land worth Rs 5 lakh crore. "These prime lands were given by Govt at a

concession for a specific purpose (employment generation) Our demand is also the same. They have no right to sell the land and make money for their kith & kin," wrote KTR.

"Return the land to the Govt and put it to effective use for the benefit of people of Hyderabad and Telangana. We need land for schools, hospitals, housing for poor, parks, bus stands and parking," added the former minister.

He claimed that the lands that were once given by the government to industries to create jobs for people are

now being given to private individuals.

The BRS leader alleged that the government is giving industrial lands to build apartments, villas and commercial complexes as it does not want industries. KTR claimed that while the market price for these lands is Rs one lakh per square yard, the government is handing them to private individuals for just Rs 4,000. He urged the real estate developers not to get cheated with the "sale offer" by the government and warned that once BRS returns to power, it would take back these lands.

Amaravati: SRM University-AP hosted the opening day of the 50th All India Sociological Conference (AISC 2025), drawing around 1,800 sociologists, scholars, and students from across India and abroad. The conference is being held on the theme "Mobilities and Inequalities: Shifting Contexts; Changing Paradigms," exploring how sociological perspectives are evolving in the contemporary world order.

The inaugural session witnessed the participation of eminent sociologists and anthropologists, including Dr R K Jain, former Professor at Jawaharlal Nehru University and keynote speaker; Dr Maitreyee Chaudhari, President of the Indian Sociological Society; Dr Swetha Prasad, Secretary of the Society; Dr Sujata Patel, retired Professor from the University of Hyderabad; Prof. Satish Deshpande of the University of Delhi; Prof. Iruvada Rajan, Chairman of the International Institute of Migration



and Development and Guest Faculty at SRM University-AP; and Prof. Anand Kumar, retired Professor at Jawaharlal Nehru University, among others.

In his keynote address, Dr R K Jain spoke on migration from a national and global perspective, highlighting the complex intersections of mobility and inequality. He emphasised the need to view these issues through the lens of South Asian diasporic migration, with a special focus on the mid-twentieth-century Indian diaspora, which he said was shaped more by political, cultur-

al, and psychological factors than by economic marginalisation.

Referring to the H-1B visa system, he noted how contemporary migration reflects narratives of race, class, and culture, underlining migration's continued relevance in understanding social inequality.

Prof. Vishnupad, Dean of the Easwari School of Liberal Arts, highlighted the importance of the conference theme and provided an overview of the university and the school's academic contributions. He observed that the interaction between social and technological

forces is reshaping sociological understanding, making adaptation to these changes essential.

Vice Chancellor Prof. Ch Satish Kumar, in his opening address, remarked that socialisation is increasingly transforming into e-socialisation, redefining individual identities and altering traditional value systems. He said the conference would help scholars understand and balance these emerging generational perspectives.

Shadnagar-Chevella to Be Focal Point in Proposed Future City Police Commissionerate

Consensus eludes Thackeray cousins, Shiv Sena-BJP over seat sharing for BMC polls

MUMBAI: Consensus on seat sharing for the January 15 Brihanmumbai Municipal Corporation (BMC) elections eluded both the Thackeray cousins and the BJP-Shiv Sena camps, as leaders from the respective parties held hectic parleys on Saturday. The Shiv Sena (UBT), led by Uddhav Thackeray, and the Maharashtra Navnirman Sena (MNS) under Raj Thackeray haven't yet declared their lists of candidates for the civic polls in the city. Similarly, the BJP and Shiv Sena, headed by Deputy Chief Minister Eknath Shinde, are yet to share the details of their nominees. BMC has 227 civic wards.

During the day, MNS leaders Bala Nandgaonkar, Nitin Sardesai

and Sandeep Deshpande met Uddhav Thackeray to iron out differences over wards in the Mahim assembly segment, which covers areas like Dadar and Prabhadevi, where both parties are influential.

Talking to reporters, Nandgaonkar said some seats had to be exchanged, for which he met Uddhav. He said there will be another round of meetings with him on Saturday night, after which the seat-sharing talks will reach the final stage. Nandgaonkar said MNS, which has contested all polls independently, is new to seat-sharing talks. Between the BJP and the Shiv Sena, deadlocks over seats persist, said a Sena leader, adding that talks between the two

parties, which are parts of the ruling Mahayuti coalition, are still underway for the civic bodies in Mira Bhayander, Thane, Navi Mumbai and Kalyan Dombivli. The case wasn't much different with the NCP, led by Deputy CM Ajit Pawar, and Sharad Pawar's NCP (SP). Talks between the two parties over a possible alliance for Pune civic polls appear to have hit a dead end, with the NCP not agreeing to the Sharad Pawar-led party's proposal for contesting the elections on their respective poll symbols. Elections to 29 municipal corporations in Maharashtra, including Mumbai and Pune, will be held on January 15. The last date to file the nominations is December 30.

10.56 lakh names deleted as EC releases Assam's draft electoral rolls after Special Revision

GUWAHATI: The names of 10.56 lakh voters have been deleted after the Special Revision of electoral rolls in Assam, where assembly polls would be in less than six months.

According to the integrated draft rolls released by the Election Commission on Saturday, the state has a total of 2,51,09,754 voters, excluding 93,021 D-Voters or doubtful voters.

Additionally, the names of 10,56,291 voters have been deleted due to death, shifting, or multiple entries.

D-Voters are a category of voters in Assam who have been disenfranchised by the government on account of their alleged lack of proper citizenship credentials.

D-Voters are determined by special tribunals under the Foreigners Act, 1946, and the person declared as a D-Voter is not given a voter card.

All related particulars, such as name, age and photograph, of D-Voters have been carried forward to the draft

electoral roll without any change. The draft rolls were published after house-to-house verification of the Special Revision was held from November 22 to December 20. Now, voters will be able to file claims and objections till January 22, and the final electoral rolls will be published on February 10, a statement said.

Of the 10.56 lakh, 4,78,992 names were deleted because of deaths, 5,23,680 voters were found to have moved from their registered addresses, and 53,619 demo-

rolls is underway in 12 states and Union Territories, including Kerala, Tamil Nadu and West Bengal, where elections would be due along with Assam, a Special Revision was ordered by the EC in the northeastern state.

Chief Election Commissioner Gyanesh Kumar had said, "Under the Citizenship Act, there are separate provisions for citizenship in Assam. Under the supervision of the Supreme Court, the exercise of checking citizenship is about to be completed."

According to officials, the Special Revision stands somewhere between the annual special summary revision and the SIR. The statement said the Special Revision is aimed at preparing an error-free electoral roll by facilitating enrolment of eligible un-enrolled electors, correction of clerical errors in name, age and address, removing names of deceased persons, shifting electors, and identifying and deleting multiple entries.

HC upholds man's conviction for stepdaughter's rape, says victim turning hostile can't dismiss case

NEW DELHI: The Delhi High Court has upheld the 20-year jail term of a man for raping his minor stepdaughter, observing that guilt under the POCSO Act cannot be dismissed merely because the victim turned hostile, particularly when scientific evidence was available.

The high court said it considered it apposite to take notice of the plight of such victims, who are defenceless against pressure from their family members and are susceptible to influence.

Nothing can justify a child being faced with the burden of shielding their perpetrator, it said.

It noted that the victim may have retracted from her testimony due to fear of losing shelter, financial stability and the desire to preserve the family unit, especially when the accused is a caregiver or

breadwinner. "A child who is confronted with the prospect of condemning someone who provides her shelter and financial stability is undoubtedly faced with a grave conflict.

The child's instinct for survival coupled with the fear of ostracisation and the desire to preserve the family unit may compel the victim to retract from the truth. In the present case as well, the subsequent hostility of the victim can be traced from her statement under Section 164 of the CrPC itself," Justice Amit Mahajan said.

Suvendu Adhikari accuses Bengal police of arresting BJP worker in Nandigram without reason

KOLKATA: Leader of the opposition of West Bengal Assembly and BJP MLA Suvendu Adhikari on Saturday alleged that police in Nandigram wrongfully arrested a party worker from his residence over vandalism of a Trinamool Congress campaign autorickshaw.

He also accused police of committing atrocities on the worker's wife and child when they could not locate him at home.

A BJP worker was arrested on Friday on charges of tearing TMC flex banners and vandalising a tableau mounted on the three-wheeler at Bhektia village under Nandigram Block No. 1.

The Trinamool alleged that BJP workers vandalised the vehicle and damaged the flex banner listing the 'Unnayancer panchali' (development schemes) of the party.

Following this, Trinamool workers lodged a complaint at Nandigram police station. Within 24 hours of the complaint, the brother of BJP mandal president of Bhektia Gouranga Dhar was arrested on charges of vandalism.

Adhikari reached the police station on Saturday morning and accused police of wrongly confining the BJP worker.

"You will have to face the consequences of what you are doing. Wait for a few months when Mamata Banerjee is removed from power," he was allegedly heard telling the police station in charge.

Adhikari claimed that the BJP worker had been arrested in a false case as the flex banner was torn after the autorickshaw accidentally fell into a ditch. The BJP leader said the alleged incident was being used to intimidate opposition workers. "Beating up SC women

and children in broad daylight? Mamata Banerjee is targeting the marginalised to shield her crumbling political empire," he alleged.

"Remember that this is Nandigram, it has overtaken the Left Front government, it has defeated you in 2021, now it will make you a political outcast," he said.

Responding to the charges, Trinamool's Purba Medinipur district president Sujit Roy said, "BJP workers carry out vandalism, and police are then expected to do nothing just because they belong to the BJP? When a Trinamool worker was arrested at Bhanupur police station in Kolkata in the past, no Trinamool leader went there to stage a protest. When Bengalis are being attacked outside Bengal, the BJP remains silent."

Manufactured Traditions

In the landscape of modern Indian socio-politics, if there is such a word, December 25 has become a date of peculiar botanical urgency. Suddenly, the air is thick with the smell of incense and the aggressive rustle of holy basil. We are told, via high-resolution WhatsApp forwards and saffron-tinted infographics, that it is "Tulsi Pujan Diwas". To the uninitiated, it looks like a quaint revival of Vedic piety. To anyone with a history book and a functioning memory, however, it is a masterclass in the "invention of tradition" - a duplicitous branding exercise designed to turn a plant of peace into a picket line of cultural intolerance. Let us be clear: the Tulsi plant is, and has always been, a cornerstone of the Hindu household. For centuries, it has sat in the Vrindavan of the courtyard, a biological deity representing Lakshmi's grace and the medicinal wisdom of Ayurveda. We have Tulsi Vivah, an ancient, structurally complex festival tied to the lunar cycle of the Hindu calendar. But "Tulsi Pujan Diwas", fixed stubbornly to the Gregorian calendar date of December 25 (a most unVedic practice), is not an ancient ritual. It is a 2014 startup. It has the same historical depth as a seasonal discount sale.

Colonising The Calendar

The manufacture of this "Diwas" is a classic example of what historian Eric Hobsbawm called "Invented Tradition". These are practices that appear old but are actually quite new, designed to instil certain values through repetition and a false sense of continuity with "glorious past". By pinning Tulsi worship to Christmas Day, the architects of this movement aren't trying to honour the plant or our culture; they are trying to colonise the calendar. The logic is transparently reactive. It stems from a profound cultural insecurity that views the celebration of Christmas - or even the mere acknowledgment of it - as a zero-sum game. If a neighbour puts up a star, one must counter with a shrub. If they sing a carol, we must chant a shloka, not out of devotion, but out of a desperate need to "reclaim" a space that was never actually lost. It is "spirituality" as a contact sport, kabbadi with chanting rather than panting. The duplicity lies in the justification. Proponents argue that they are protecting "Indian values" from the "onslaught of Westernisation". This creates a false binary: you are either a "Sattvic" Tulsi-worshipper or a "corrupted" consumer of cake and tinsel. By framing a modern creation as an ancient necessity, they provide a theological shield for contemporary xenophobia. It allows the practitioner to say, "I am not being intolerant of your holiday; I am simply being observant of my own (one-decade-old) tradition."

A Trojan Horse For Intolerance

This is how "manufactured tradition" serves as a Trojan Horse for intolerance. It rewrites history to suggest that Indian culture is a fragile thing that can only survive if it is constantly positioned against an imagined enemy. It replaces the expansive, pluralistic heart of Hinduism - which historically had no trouble assimilating various influences - with a brittle, reactionary mimicry. Furthermore, there is a profound irony in using the Tulsi plant for this purpose. In the Puranas, Tulsi is a symbol of bhakti (devotion), a quality that is internal, quiet, and deeply personal. To turn her into a tool for a "Cultural Cold War" is a form of spiritual malpractice. When worship is motivated by the desire to "cancel out" another person's joy, it ceases to be prayer and becomes a political weapon of intolerance. We see this pattern everywhere: the sudden "discovery" of ancient reasons to do modern, exclusionary things. Whether it is the rebranding of Valentine's Day as "Parents' Worship Day" (why not Karmadeva Diwas, I ask you?) or the fixating of festivals onto specific Western holidays, the goal is the same: to create a psychological ghetto where the "Other" is always an intruder.

Let Tulsi Be Sacred

By pretending that "Tulsi Pujan Diwas" has always existed in this specific, reactionary form, its promoters are gaslighting the public. They are erasing the genuine, organic history of Indian festivals, which are diverse, regional, and tied to the earth's own rhythms, and replacing them with a standardised, "Vedic-flavoured" version of modern "cultural nationalism".

Congress Meltdown: In Digvijaya Singh's 'RSS' Post, A Reckoning For Rahul



"Multiple Chanakyas are advising the prince. The trouble is, there is only one prince. A problem that Machiavelli and Kautilya never faced. Plus, their respective Princes were able," says a senior Congress leader about the meltdown set off by Digvijaya Singh, 78, the former Chief Minister of Madhya Pradesh. Singh, a master politician, recently threw a gauntlet at Rahul Gandhi through a social media post, in which he praised the organisational strength of the RSS and even tagged everyone from Rahul, Priyanka Gandhi, Mallikarjun Kharge and Jairam Ramesh to Prime Minister Narendra Modi. Singh then attended the last Congress Working Committee meeting and made the same point in person. There, he was heard in utter silence, with his intervention espousing no comments from the audience. I spoke to a cross-section of Congress leaders before writing this column - both the rebels who want change in the party and the coterie to Rahul Gandhi who want status quo. The biggest takeaway is that Rahul cannot avoid a change if he continues to be unavailable and elusive. The last five days of the

winter session, Rahul, despite being the leader of opposition, chose to be in Germany to address the diaspora instead of taking up pressing issues such as the air pollution in Delhi, a state the Congress once ruled and where it has now been reduced to zero. The decentralisation and the lack of organisation that Singh underlined in his CWC address is unexceptionable. It is a point that any objective observer would agree with. A Warning For Venugopal? This also points to KC Venugopal, the General Secretary in charge of organisation, who has reduced the Congress party organisation to a hollow shell with state units almost out of business. Many say that is because Venugopal doesn't allow state

leaders to make decisions while endlessly dithering on decisions himself. In fact, the chorus for his ouster is only growing. Venugopal survives on Gandhi's patronage as his chief palace courtier. But he's no Ahmed Patel, who performed a similar role for Sonia Gandhi and was indispensable for the party. The question now is what lies in store for Venugopal. Will he get his dream job as the Congress face in the upcoming Kerala elections, or will he be kicked upstairs to some meaningless office? It may not be a stretch to say that Singh, in fact, was basically targeting Venugopal through his social media post, and by tagging Priyanka Gandhi Vadra publicly, he was seeking her intervention in the party's sorry state of affairs.

Sources close to Singh say that speculation, especially from within the Congress, that Singh is leaning towards the BJP-RSS is laughable. Sure he has been provocative, but his praise, they say, was nuanced and limited to the organisational discipline of the RSS. "They have created the largest political party in the world. The most formidable election winning machine and the biggest war chest. Only a blind person would not seek to emulate it in politics," said a source. This is a valid point. In contrast to such a robust organisation, Gandhi comes across as a leader who has romanticised electoral defeat with his constant pitch of 'vote chor'. Sources close to Singh also scoff at suggestions that the provocation for the tweet was the fact that he wants a new term in the Rajya Sabha. "Singh was a mass leader. He literally poisoned his own roots to come to Delhi and became Gandhi's counsellor. Yet, Gandhi, for reasons unknown, discarded him and fell for the comfort of his palace courtiers. Singh proved with his Narmada Yatra that he still has it in him to do mass politics, touching every district in Madhya Pradesh. He wants a say in the state and a bright future for his son Jaivardhan

Singh. Is that a crime? It can only happen when the Congress does well." Take Responsibility From the row between Siddaramaiah and DK Shivakumar in Karnataka, to the sidelining of leaders like Shashi Tharoor and Manish Tewari, to replacing the leadership in Rajasthan, Gandhi can no longer continue evading responsibility. Against this background, the public praise for Priyanka Gandhi Vadra can be seen as a cry for help from the party. Party leaders want Rahul to go back to bread and butter issues to take on the BJP. Instead, the issues he has taken up so far, such as "vote chor", "surrender Modi", have failed to get any traction. "The Trinamool Congress protested the removal of MGNREGA, the Congress' flagship scheme, much more than the Congress in Parliament. They held an all-night dharna. What did we do?" a Congress leader said. For now, all eyes are on the Rajya Sabha picks to see whether Rahul Gandhi has paid any heed to the discontent brewing within his party. If the usual palace guard makes the cut and there is no organisational overhaul, expect a mega meltdown. Evasion of responsibility isn't an option for the Congress top brass anymore.

Faith vs. Breath: Pigeons, Laws, and Our Collective Irresponsibility

In India, faith often trumps reason. That's why the sound of temple bells sometimes feels more suffocating than the sound of a suffocating sound, but we don't want to listen. A recent Mumbai court ruling—imposing a fine of ₹5,000 for feeding pigeons in a public place—is a clear and bold example of this confrontation. This decision is not against pigeons, but against the mindset that tramples on science, law, and public health in the name of sentimentality.

In our society, feeding pigeons is considered a "virtuous act." Early in the morning, we find a sense of satisfaction in throwing a handful of grains onto our balcony, terrace, or park—as if we've served humanity in a significant way. But the question is: can an act performed without considering the consequences truly be considered compassion?

Medical science has consistently warned that dried pigeon droppings can spread into the air and spread deadly diseases like cryptococcosis, histoplasmosis, hypersensitivity pneumonitis, and salmonella. These diseases are not imaginary fears, but true

stories from real patients admitted to hospitals. Asthmatics, lung patients, the elderly, and children—their lives are at risk first. The Mumbai court did not limit this case to a mere violation of a municipal corporation order, but considered it a direct threat to public health. The punishment under sections of the IPC indicates that the state now seeks not only to treat diseases but also to prevent social habits that cause disease. This is the first time in the country that a socially acceptable act like feeding pigeons has been criminalized. This decision demonstrates that the law will now be guided by its impact, not by emotions.

The most uncomfortable question in this entire controversy concerns religion and tradition. Some are calling it an attack on faith, but does religion ever condone the spread of disease? Does any religious text ever prescribe risking the lives of others to earn merit? The government and health agencies themselves have clearly stated that feeding pigeons is not a religious obligation, yet protests continue. In reality, this protest is not about faith, but stubbornness—a stubborn refusal to change one's habits.

Cities are no longer villages. With dense populations, tall buildings, limited air, and shared spaces, even small negligence can turn into a major crisis. Grain left on a balcony not only attracts pigeons, but also brings with it a whole chain of disease, filth, and infection. Ironically, the same people who question masks, vaccines, and scientific warnings are, in the name of virtue, turning cities into a cesspool of biological waste.

In this debate, it's important to clarify that the pigeons aren't at fault. They're simply living their lives according to their natural instincts. We are to blame—our unscientific sentimentality, our belief in convenience, and our collective irresponsibility. If you truly want to show compassion, do so in controlled, safe, and scientific ways—through animal welfare organizations, not in open public spaces.

This decision by the Mumbai court sends a clear message that faith may be private, but its impact cannot harm public life. Compassion does not necessarily mean harm, and the law is now recognizing this distinction.

Sadhguru urges Centre to amend British-era farm laws

Bengaluru, Dec 28 (UNI) Spiritual leader and environmentalist Sadhguru has urged the union Government to amend British-era laws governing agricultural land, asserting that everything grown on farmland must belong to farmers, including trees. Addressing a large gathering of farmers at an agricultural seminar organised by Isha Outreach's Cauvery Calling initiative in Hosur, Sadhguru called for liberating agriculture from excessive government controls and removing policy hurdles that restrict farmers from freely selling trees grown on their own land.

"Whatever the farmer grows on his land should belong to the farmer," Sadhguru said, emphasising the need to clearly differentiate between forest produce and crops grown on agricultural land. He urged union Agriculture and Farmers



Welfare Minister Shivraj Singh Chouhan to remove roadblocks that require farmers to seek permissions to cut or sell trees cultivated on their farms. Referring to colonial-era regulations, Sadhguru said the law that claims ownership of anything found below eight feet of soil by the government must be amended.

"Farmers should be liberated from all rules. Market rules are the best rules. Let farmers grow what is profitable for them and sell it wherever they want in the world," he said.

Highlighting the rare political unity at the event, Sadhguru said the presence of leaders from all parties

reflected a shared commitment to farmers' welfare.

"The purpose of politics is to serve people. When it comes to the source of our life, we all should not be differently opinionated. Now all of us are on one stage, on the same page. It is very fortunate," he said.



CM, DCM functioning as puppet rulers: Karnataka BJP chief



Bengaluru, Dec 28 (UNI) Karnataka BJP president Vijayendra Yediyurappa on Sunday accused the Congress-led government in the state of reducing governance to what he termed remote-control rule, alleging that Chief Minister Siddaramaiah and Deputy Chief Minister DK Shivakumar were functioning as puppet rulers under the directions of the party high command in Delhi.

Launching a sharp attack on the ruling dispensation, Vijayendra questioned who actually wielded power in Karnataka, asserting that the people had elected a government in Bengaluru and not an "invisible authority" operating from the national capital.

Referring to the controversy over the demolition of unauthorised constructions in Kogilu village, the BJP leader said the Chief Minister and Deputy Chief Minister had initially defended the government's actions with conviction, even as the episode drew wider political debate over what he described as the emerging "bulldozer culture" in governance.

Vijayendra's remarks came in the backdrop of AICC general secretary KC Venugopal's intervention in the Kogilu demolition issue.

Venugopal said he had spoken to Chief Minister Siddaramaiah and Deputy Chief Minister Shivakumar and conveyed the AICC's serious concern that the demolitions should have been carried out with greater caution, sensitivity and compassion, keeping

the human impact at the centre. According to Venugopal, the Chief Minister and Deputy Chief Minister assured him that they would personally engage with the affected families, put in place an appropriate grievance redressal mechanism, and ensure rehabilitation and relief for those impacted. Citing this development, Vijayendra posed a direct question to Siddaramaiah and Shivakumar, asking whether they would show the same courage towards their AICC leadership as they had displayed while defending the demolitions and offering advice to Kerala Chief Minister Pinarayi Vijayan a day earlier, or whether their stand had "conveniently changed after a call from Delhi".

He said the issue went beyond political hypocrisy and amounted to a serious affront to the democratic mandate of the people of Karnataka. Vijayendra alleged that the state was being governed at the pleasure of an unelected authority, with key decisions being shaped outside Bengaluru.

The BJP leader further claimed

that the Chief Minister and Deputy Chief Minister were locked in an intense power struggle over the CM's chair, creating a situation in which the Congress high command had emerged as the final arbiter on major decisions.

"When elected leaders function under an unseen authority, governance collapses and democracy is reduced to remote-control administration," Vijayendra said, adding that such a system stripped the state of accountability and transparency.

He asserted that Karnataka deserved strong and accountable leadership rooted in the state, and not "puppet rulers dancing to the tunes of an invisible and unelected high command".

The BJP cited the high command's intervention in the Kogilu issue as evidence of what it described as "puppet governance", alleging that elected leaders in Karnataka were compelled to recalibrate decisions only after directions from Delhi, raising serious questions over the autonomy of the state government.

Bengaluru: The Karnataka government on Sunday assured direct intervention, rehabilitation and relief for families affected by the demolition of unauthorised constructions in Kogilu village, a development that comes shortly after Kerala Chief Minister Pinarayi Vijayan's remarks criticising the prevailing "bulldozer culture".

Venugopal said he spoke to Chief Minister Siddaramaiah and Deputy Chief Minister D K Shivakumar, who assured him that they would personally engage with the affected families and put in place a grievance redressal mechanism. Great performance in civil services exams under Naan Mudhalvan: DyCM Udhayanidhi

CHENNAI: Deputy Chief Minister Udhayanidhi Stalin on Sunday said Tamil Nadu has shown a strong comeback in national-level competitive examinations, particularly the civil services, with a sharp rise in successful candidates under the State government's 'Naan Mudhalvan Competitive Examinations' (NMCE) initiative.

In a statement, Udhayanidhi said the programme was conceived after Tamil Nadu's performance in the UPSC civil services examination



dipped to a low of 27 successful candidates in 2021, exposing deep inequities in access to quality coaching, guidance and financial support. "The Dravidian model of gov-

ernance intervened to correct this imbalance and restore equal opportunity," he said.

The results, he noted, reflect a decisive turnaround. In 2023-24, 453 students from Tamil Nadu cleared the UPSC preliminary examination. The number rose to 559 in 2024-25, of whom 134 qualified for the Mains exam and 50 secured a place in the final list. In the ongoing 2025-26 cycle, 659 candidates have cleared the prelims so far, while 155 students have qualified for the interview stage.

Revisit farmer connect scheme, appeals Association

CHENNAI: The AITUC-affiliated Tamil Nadu Farmers' Association has appealed to Chief Minister MK Stalin to stop the implementation of the newly launched Uzhavar Aluvalar Thodarbu 2.0 scheme, warning that it would adversely impact agricultural growth and create confusion among farmers.

In a statement on Saturday, general secre-

tary BS Masilamani said the State has justified the new model by citing the high workload of existing field officers, who each handle an average of 6 villages. Under the revised system, officials from agriculture, horticulture, hill crops, agricultural engineering and agricultural marketing departments will be jointly assigned to fewer villages to improve regular interaction with



farmers. He said the arrangement may look efficient on paper, but will falter in practice. Officers are trained and experienced only in their respective fields and cannot be expected to advise farmers on all crops and technologies. This would affect productivity and restrict farmers' access to proper technical knowledge, he said.

Masilamani noted that field officers are already

burdened with clerical tasks, forcing farmers to depend on private retailers for guidance. Instead of restructuring, the government should fill long-pending vacancies and appoint more field officers to ensure timely services, he said. He also cautioned that the move would weaken the standalone horticulture department, which contributes significantly to production value and

exports despite its smaller cultivation footprint. Undermining its role would be a setback at a time when horticulture is critical to future food and income security.

Calling the scheme unnecessary and harmful, he urged the Chief Minister to revisit the plan and take steps that genuinely strengthen agricultural support systems in the State.

The Human Immunome Project has released a Scientific Plan to create the world's largest immunological dataset and develop AI models to better understand and leverage the immune system for improved health outcomes globally. The plan involves establishing global study sites and developing advanced AI tools to analyze immune system variations and responses.

The Human Immunome Project (HIP), a global nonprofit scientific initiative, released its Scientific Plan today, April 29, on World Immunology Day, the organization announced. The plan provides a detailed roadmap of how the Human Immunome Project and its network of global study sites will generate the world's largest and most diverse immunological dataset and use these data to power publicly available AI models of the immune system. Importance of the Immune System

"The immune system is the epicenter of human health, and our newly released Scientific Plan outlines an actionable, global strategy for how we can unlock the secrets of the immune system and harness its power to improve health for all," said Dr. Hans Keirstead, CEO of the Human Immunome Project.

The human immune system is one of the most complex systems in the world—and one of its most important. It determines whether we survive infancy, which diseases we get, how we age, and how long we'll live. Understanding our immune system is the key to fighting disease and improving health for all. Yet its complexity has limited our ability to tap into its potential—until now. Despite these tremendous advances, our understanding of the immune system remains



limited: less than one percent of the immunological data necessary to understand immune function and diversity on a global scale are available. As such, HIP's first mission is generating diverse immunological datasets at scale. "The Human Immunome Project is at the cutting edge of scientific discovery and is uniquely positioned to provide the scientific and medical communities with the knowledge and tools to innovate new diagnostics, drugs, vaccines, and immunotherapies that can address disease, elongate healthspans, and enable more personalized and more effective healthcare for all. I could not be prouder to lead this global effort," said Dr. Keirstead.

Global Data Collection Efforts
To generate these data, HIP is establishing a network of global study sites that reflect the diversity of humanity (across age, ethnicity, geography, sex, and socioeconomic status) and immune responses. Data will be generated through a phased approach and enabled by HIP-engineered Immune Monitoring

Kits—a collection of assays and operating procedures that facilitate rapid, robust, and standardized data collection worldwide.

This collaborative, global effort will produce longitudinal, baseline datasets that enable scientists to assess developmental and age-dependent changes and computationally stitch together the health trajectory of different population groups worldwide. Pilot Sites and AI Development
With the Scientific Plan now fully articulated, the Human Immunome Project is working to establish its initial Pilot Sites—up to 10 state-of-the-art sites that will collect data, help refine the site model, and prepare HIP for scale. These sites will be spread globally with a focus on the Global South and sub-Saharan Africa, specifically. As data collection progresses, HIP will begin to develop AI models—first predictive, then mechanistic—that will deepen our understanding of immune

responses and individual and population-based health trajectories. These models will provide a holistic view of the immune system and empower scientists with a new, transformative tool to advance drug development, strengthen personalized medicine, and increase healthspans. These data and models will additionally produce new insights relevant to nearly all health conditions, including key global health challenges related to maternal health, aging and cognitive decline, and disease evolution.

Collaboration and Refinement of the Scientific Plan

An initial draft of HIP's Scientific Plan was shared with a group of global experts at the "Human Immunome Project Into Action Conference," hosted at CosmoCaixa Museum of Science by the CaixaResearch Institute and HIP in November 2023. The conference provided participants an opportunity to input into the Scientific Plan and concluded with an endorsement of the mission and vision of the Human Immunome Project. Since November, HIP's science team, led by Dr. John Tsang, Dr. Shai Shen-Orr, and Dr. Orit Lavi, has refined the plan using feedback gathered at the conference. The result is a detailed strategy to decode and model the immune system with the ultimate goal of improving health for all. From Theory to Therapy: MIT's Computational Breakthrough in Protein Optimization

MIT researchers plan to search for proteins that could be used to measure electrical activity in the brain. To engineer proteins with useful functions, researchers usually begin with a natural protein that has a desirable function, such as emitting fluorescent light, and put it through many rounds of random mutation that eventually generate an optimized version of the protein. This process has yielded optimized versions of many important proteins, including green fluorescent protein (GFP). However, for other proteins, it has proven difficult to generate an optimized version. MIT researchers have now developed a computational approach that makes it easier to predict mutations that will lead to better proteins, based on a relatively small amount of data.

Advancements in Computational Protein Design

Using this model, the researchers generated proteins with mutations that were predicted to lead to improved versions of GFP and a protein from adenovirus-associated virus (AAV), which is used to deliver DNA for gene therapy. They hope it could also be used to develop additional tools for neuroscience research and medical applications. "Protein design is a hard problem because the mapping from DNA sequence to protein structure and function is really complex. There might be a great protein 10 changes away in the sequence, but each intermediate change might correspond to a totally nonfunctional protein. It's like trying to find your way to the river basin in a mountain range, when there are craggy peaks along the way that block your view. The current work tries to make the riverbed easier to find," says Ila Fiete, a professor of brain and cognitive sciences at MIT, a member of MIT's McGovern Institute for Brain Research, director of the K. Lisa Yang Integrative Computational Neuroscience Center, and one of the senior authors of the study.

Regina Barzilay, the School of Engineering Distinguished Professor for AI and Health at MIT, and Tommi Jaakkola, the Thomas Siebel Professor of Electrical Engineering and Computer Science at MIT, are also

senior authors of an open-access paper on the work, which will be presented at the International Conference on Learning Representations in May. MIT graduate students Andrew Kirchner and Jason Yim are the lead authors of the study. Other authors include Shahar Bracha, an MIT postdoc, and Raman Samusevich, a graduate student at Czech Technical University.

Optimizing Proteins
Many naturally occurring proteins have functions that could make them useful for research or medical applications, but they need a little extra engineering to optimize them. In this study, the researchers were originally interested in developing proteins that could be used in living cells as voltage indicators. These proteins, produced by some bacteria and algae, emit fluorescent light when an electric potential is detected. If engineered for use in mammalian cells, such proteins could allow researchers to measure neuron activity without using electrodes.

While decades of research have gone into engineering these proteins to produce a stronger fluorescent signal, on a faster timescale, they haven't become effective enough for widespread use. Bracha, who works in Edward Boyden's lab at the McGovern Institute, reached out to Fiete's lab to see if they could work together on a computational approach that might help speed up the process of optimizing the proteins. "This work exemplifies the human serendipity that characterizes so much science discovery," Fiete says. "It grew out of the Yang Tan Collective retreat, a scientific meeting of researchers from multiple centers at MIT with distinct missions unified by the shared support of K. Lisa Yang. We learned that some of our interests and tools in modeling how brains learn and optimize could be applied in the totally different domain of protein design, as being practiced in the Boyden lab." For any given protein that researchers might want to optimize, there is a nearly infinite number of possible sequences that could be generated by swapping in different amino acids at each point within the sequence. With so many possible variants, it is impossible to test all of them experimentally.

ROLLS ROYCE PLANS MAJOR EXPANSION IN INDIA

New Delhi: British aero-engine maker Rolls-Royce on Sunday said it is looking at making India its third "home market" outside of the UK in line with a plan to unlock the full potential of opportunities across an array of domains including jet engine, naval propulsion, land systems and advanced engineering. In an interview to PTI, Sashi Mukundan, the executive vice president of Rolls-Royce India, elaborating on the move, said the company is planning for a "big investment" in the country and listed developing a next-generation aero engine in India as a priority to power the combat jets that New Delhi will produce under the Advanced Medium Combat Aircraft (AMCA) programme. Besides the UK, Rolls Royce considers the US and Germany as its "home markets" as the company has considerable presence including manufacturing facilities in these two countries. Mukundan also highlighted how Rolls Royce can contribute significantly to address India's requirement for



electric propulsion capability for boosting the Indian Navy's combat prowess. He suggested that the development of the jet engine for the AMCA involving Rolls Royce could also help India manufacture engines for naval propulsion as the company is among very few engine makers globally to have the capability to "marinize the aero engine". Mukundan, without divulging specific details, said Rolls Royce was eye-

ing to make significant investment to expand its footprint in India, noting that the country has "scale, policy clarity, and a strong push" towards a defence and industrial ecosystem that is expanding rapidly and becoming more sophisticated. "If everything goes well, it would be a significant investment. It'll be big enough that people will notice it, but I don't want to put a number to it. What matters is the impact of this investment, which

would be the development of the entire value chain and ecosystem here across sectors that we operate in," he said. The top Rolls Royce executive said the company will firm up two MoUs with (Memorandum of Understanding) with two defence public sector undertakings in India. While one pact is for manufacturing the engines for the Arjun tanks, the other is for engines for the future ready combat vehicles. In October, CEO Tufan

Erginbilic, during a business roundtable had conveyed to Prime Minister Narendra Modi that India is going to be very critical for Rolls-Royce going forward. "We have developed two other home markets outside the UK — the US and Germany. We want to make India our next one. What do we mean by that? We want to do everything across the field, and it's not just defence," Mukundan said. "That ambition cuts across defence, naval propulsion, land systems, manufacturing, advanced engineering skills, and technology development, all of which align closely with India's own priorities," he said. On the engines for AMCA, Mukundan said extensive discussions and background work are underway on how to move forward. "If India is thinking about next-generation engines, Rolls-Royce is probably the best partner. We have the capability, we have the experience both in India and globally, and we have repeatedly demonstrated that we can do it," he said.

BP has struck a \$6bn (£4.4bn) deal to sell a majority stake in its motor oil division Castrol to a US investment firm. The oil giant sold a 65% stake in Castrol, which makes lubricants for cars, motorcycles and industrial vehicles, to New York-based Stonepeak. The deal valued Castrol at \$10.1bn (£7.5bn), with BP receiving \$6bn in cash, which it will use to pay down debts and allow it to focus on its core business. BP will hold onto a 35% stake in Castrol, which it first took control of in 2000. The London-based oil major said the sale is a "milestone" in its plans to overhaul its business and strip out costs. BP in February announced plans to sell off \$20bn (£15bn) worth of assets in a bid to focus on its core crude oil and gas business and strengthen its balance sheet. Following today's deal and previous announcements, the company says it's over half way to meeting that target. It is also shifting its strategy away from investment in green energy and renewing its focus on oil and gas following pressure from some investors who were frustrated that its profits and share price had



lagged behind rivals. Rivals Shell and Norwegian company Equinor have also scaled back plans to invest in green energy and US President Donald Trump's call to "drill baby drill" has encouraged firms to invest in fossil fuels. The Castrol sale comes a week after BP unveiled its first female chief executive, Meg O'Neill, who will take the helm in April 2026. Her surprise appointment came only three months after BP appointed a new chairman, Albert Manifold. And she was handed the top job less than two years after Murray Auchincloss took over from Bernard Looney as chief executive. Wednesday's deal is the latest in a series of sales by the firm, which included offloading its US onshore wind energy business and its Dutch mobility and convenience arm. Interim chief executive Carol Howle said the sale is a "very good outcome for all stakeholders". "We are reducing complexity, focusing the downstream on our leading integrated businesses, and accelerating delivery of our plan," she added. Russ Mould, investment director at AJ Bell, said the deal was "an early Christmas present" for BP shareholders.

Amazon blocks 1,800 job applications from suspected North Korean agents

A top Amazon executive has said the US technology giant has blocked more than 1,800 job applications from suspected North Korean agents. North Koreans tried to apply for remote working IT jobs using stolen or fake identities, Amazon's chief security officer Stephen Schmidt said in a LinkedIn post. "Their objective is typically straightforward: get hired, get paid, and funnel wages back to fund the regime's weapons programs," he said, adding that this trend is likely to be happening at scale across the industry, especially in the US. Authorities in the US and South Korea have warned about Pyongyang's operatives carrying out online scams. Amazon has seen a nearly one-third increase in job applications from North Koreans in the past year, said Mr Schmidt in his post. He said the operatives typically work with people managing "laptop farms" - referring to computers based in the US that are run remotely from outside



of the country. The firm used a combination of artificial intelligence (AI) tools and verification by its staff to screen job applications, he said. The strategies used by such fraudsters have become more sophisticated, Mr Schmidt said. Bad actors are hijacking dormant LinkedIn accounts using leaked credentials to gain verification. They target genuine software engineers to appear credible, he said, urging firms to report suspicious job applications to the

authorities. Mr Schmidt warned employers to look out for indicators of fraudulent North Korean job applications, including incorrectly formatted phone numbers and mismatched education histories. In July, a woman from Arizona was sentenced to more than eight years in jail for running a laptop farm to help North Korean IT workers secure remote jobs at more than 300 US companies. The DOJ said the scheme generated more than \$17m (£12.6m) in illicit gains for her and Pyongyang.

TREASURY TO COVER BAYEUX TAPESTRY FOR ESTIMATED £800M

The Treasury is set to insure the Bayeux Tapestry against damage for an estimated £800m while it is on loan to the British Museum next year. The 70m-long embroidery depicting the Battle of Hastings in 1066 will travel from France to London as part of a deal between the two nations' governments. The artefact's transit and its time in storage and on display will be covered under the Government Indemnity Scheme (GIS). Indemnity insurance covers situations like loss or damage. A Treasury spokesperson said that, without the long-standing scheme, "public museums and galleries would face a substantial commercial insurance premium, which would be significantly less cost effective". There are concerns about the move, as some French art experts have suggested the nearly 1,000-year-old work was in far too a delicate state to be transported - something French officials have denied. It is understood the Treasury has received an initial valuation for cover-



ing the Bayeux Tapestry that has been provisionally approved. The loan will not be formally confirmed until it receives the final valuation. That final valuation is estimated to be around £800m, according to the Financial Times, citing unnamed officials. The Treasury did not dispute this figure when approached by the BBC. The Bayeux Tapestry will be displayed in the Sainsbury Exhibitions Gallery of the British Museum from next September until July 2027 while its current home, the

Bayeux Museum, undergoes renovations. Comprising 58 scenes, 620 characters and 202 horses, the huge masterpiece charts a contested time in Anglo-French relations when William the Conqueror took the English throne from Harold Godwinson, becoming the first Norman king of England. The government's indemnity scheme allows art and cultural objects to be shown publicly in the UK which "might not have been otherwise because the cost of insurance would have been too high". New Delhi: Adani Group plans to invest Rs 1.8 lakh crore next year in defence manufacturing, with a focus on strengthening capabilities in unmanned and autonomous systems as well as advanced guided weapons as it looks to play a stealth anchor role in India's future warfare capabilities, sources said. Adani Defence & Aerospace in 2025 transitioned from extended planning cycles to rapid deployment with some of its military hardware being used in Operation Sindo. Next year, it will invest in unmanned and autonomous systems, advanced guided weapons, sensors and electronics, AI-enabled multi-domain operations, and scaled-up maintenance, repair and overhaul (MRO) and training infrastructure, company sources said. Autonomous systems across air, sea and land domains are unmanned platforms that use sensors, software and secure networks to operate with minimal human intervention, expanding military reach while reducing risk to personnel. In the air, they include UAVs that conduct intelligence, surveillance and reconnaissance, communications relay and precision-support



missions with long endurance. At sea, unmanned surface and underwater vehicles perform tasks such as maritime surveillance, anti-submarine warfare and mine countermeasures over wide areas. On land, unmanned ground vehicles support logistics, reconnaissance, explosive ordnance disposal and perimeter security. Adani Defence & Aerospace has emerged as India's largest integrated private-sector defence player, with capabilities spanning unmanned aerial and

underwater systems, counter-UAS solutions, guided weapons and loitering munitions, small arms and ammunition, aircraft MRO, simulator-driven training and airborne warning and control systems (AWACS). Sources said in 2025, the company's Drishti 10 UAVs were inducted into the Indian Navy and Army for long-endurance ISR mission (Intelligence, Surveillance, and Reconnaissance). Also, its counter-drone systems cleared trials conducted by the Army, Navy and Air Force, Agniakaa loitering munitions demonstrated endurance and resistance to electronic warfare and ARKA MANPADS - a shoulder-fired missile system - achieved tri-service deployment readiness within compressed timelines. Sources said the company's entry into AWACS platforms helped position it as a sole private-sector player in this segment. Integration of Air Works and Indamer created a major defence-civil MRO platform while the acquisition of FSTC strengthened pilot and engineering training capabilities, they said. Adani Defence & Aerospace has embedded sustainability through digital twins, predictive maintenance and modular design, while higher indigenous sourcing has strengthened supply-chain resilience. Looking ahead to 2026, the company plans to scale autonomous systems across air, sea and land domains, expand precision-strike capabilities, deepen its MRO and training footprint, and advance AI-enabled, multi-domain operational systems in line with India's planned defence investment trajectory, sources added.

Zelensky says Russia 'doesn't want peace' ahead of meeting Trump in Florida

Ukrainian President Volodymyr Zelensky will meet his US counterpart Donald Trump in Florida on Sunday, for the latest round of talks aimed at ending nearly four years of war with Russia. The pair will discuss an updated version of a US-brokered peace plan, which Moscow has yet to support, as well as separate proposals for US security guarantees. Their meeting at the US president's Mar-a-Lago home follows intense Russian bombardment of Kyiv over the weekend, which Zelensky said was evidence that Moscow "doesn't want peace". On Friday night, a 10-hour missile and drone barrage targeting Ukraine's capital killed two people and left 32 others injured, local authorities said. There were further Russian strikes on Saturday night. At the meeting in Florida, Zelensky is expected to raise security guarantees for Ukraine and



territorial concessions, both issues that Russia has previously been unwilling to compromise on. They will also discuss the new 20-point peace plan, a revised version of an earlier 28-point plan drafted by US special envoy Steve Witkoff that was widely seen as being too favourable to Russia. Control of Ukraine's eastern Donbas region has

been a major sticking point so far, but Zelensky has now said a "free economic zone" could be an option. Moscow currently controls about 75% of the Donetsk region, and around 99% of the neighbouring Luhansk. The regions are collectively known as the Donbas. The Kremlin has not commented on Zelensky's offer to withdraw troops from the

Dobbas if Russia pulls back too. But on Saturday, Russian President Vladimir Putin said Ukraine was "in no hurry to resolve this conflict peacefully", according to state-owned news agency Tass. Putin added that if Kyiv did not want to resolve the conflict peacefully, Russia would accomplish its objectives militarily. The Ukrainian president has

voiced optimism about the new peace plan draft, describing it as "a foundational document on ending the war". On Friday, he told reporters that it was 90% complete: "Our task is to make sure everything is 100% ready." But Trump warned in an interview with Politico that Zelensky "doesn't have anything until I approve it".

Trump added that he was expecting to see the new draft on Sunday. "I think it's going to go good with him. I think it's going to go good with Putin," he said in the interview, adding that he expects to speak to Russia's president "soon". Following meetings with Canadian Prime Minister Mark Carney, Zelensky said Moscow's latest attack on Kyiv was "Russia's answer [to] our peace efforts and this really shows that Putin doesn't want peace". Zelensky also took a call with European leaders to

discuss diplomatic "priorities" ahead of his meeting with Trump, adding that "strong positions are needed" to move forward with the plan. Kyiv has the "full support" of European and Nato leaders, German Chancellor Friedrich Merz said.

Russia launched attacks on Ukraine over the weekend - the most destructive of which happened Friday night into Saturday morning. Ukrainian officials said Russia's attacks on Kyiv caused significant damage to energy infrastructure, with 40% of residential buildings in Kyiv and nearby districts left without heating. Russia's defence ministry said long-range precision weapons were used to target energy facilities, which it claimed were being used "in the interests of the Ukrainian Armed Forces and enterprises of the Ukrainian military-industrial complex".

Cruise ship hits reef on first trip since leaving passenger on island



A cruise ship has run aground in Papua New Guinea (PNG) on its first trip since the death of an elderly passenger in late October. The Coral Adventurer is currently under investigation over the death of Suzanne Rees, 80, who died on a remote Australian island after being left behind by the ship. On Saturday, the vessel suffered a "grounding incident" off the eastern coast of PNG, around 30km (18 miles) from the city of Lae, a spokesperson for the ship said. All passengers and crew aboard the cruise ship have been reported safe, and initial inspections have not revealed any damage to the hull. Further inspections will take place on Sunday. A spokesperson for the Australian Maritime Safety Authority (Amsa) told the BBC in a statement that it had not received a distress call from the Coral Adventurer. It added it was monitoring the situation and would support PNG authorities if necessary. No decisions have

Fearing deportation, Hondurans in the US send more cash home than ever before



For over a year, Elías Padilla had been saving up to make the journey from Honduras to the United States as an undocumented immigrant. As an Uber driver in the snarled streets of the capital, Tegucigalpa, it hasn't been easy for him to put money aside. On bad days he makes as little as \$12 (£9) in 12 hours. Now, though, his plans are on

hold. The images of undocumented immigrants in major US cities being dragged away by Immigration and Customs Enforcement (ICE) agents, their wrists in zip-ties, have deterred at least one would-be immigrant in Central America from travelling north. "I want to improve my life conditions because we earn very little here," Elias explains as we drive around the city. "Take this line of work, for example: an Uber driver in the US makes in an hour what I'd make in a day." Like most Honduran immigrants, Elias says the main aim of reaching the US would be to send remittances home. "But I see what Trump is doing, and it's made me think twice," he admits.

POLLS CLOSE ON FIRST DAY OF MYANMAR'S WIDELY CRITICISED 'SHAM' ELECTION



The first of three phases of voting has finished in Myanmar in an election widely dismissed as a "sham", with major political parties dissolved, leaders jailed and as much as half the country not expected to vote due to an ongoing civil war. The military government is holding a phased ballot nearly five years after it seized power in a coup, prompting widespread opposition and spiralling into civil war. Observers say the junta, with China's support, is seeking to legitimise its power as it seeks a way out of the devastating stalemate. More than 200 people have been charged for dis-

rupting or opposing the polls under a new law which carries severe punishments, including the death penalty. There were reports of explosions and airstrikes across multiple regions as the first round of voting took place on Sunday. A rocket attack on

an uninhabited house in the Mandalay region in the early hours of the morning injured three people, the region's chief minister told the BBC. Separately, a series of explosions damaged more than ten houses in the Myawaddy township, near the border with

Thailand, late on Saturday. A resident told the BBC that a child was killed and three others were taken to hospital. Voters have told the BBC that the election feels more "disciplined and systematic" than previous polls. "The experience of voting has changed a lot," said Ma Su Zar Chi, who lives in the Mandalay region. "Before I voted, I was afraid. Now that I have voted, I feel relieved. I cast my ballot as someone who has tried their best for the country." First-time voter Ei Pyay Phy Maung, 22, said she was voting because she believed it is "the responsibility of every citizen".

Nine arrested in Italy for allegedly raising millions for Hamas



Italian police have arrested nine people accused of raising around 7m (£6m) for Hamas over more than two years. The money was ostensibly collected as humanitarian aid for Palestinian civilians, a police statement said, but was instead sent to the militant group via a "complex fundraising system". Alongside the arrests, police say they have seized more than 8m (£7m) in assets as part of the investigation. Police say the suspects are "specifically accused of carrying out financing operations believed to have contributed to terrorist activities". The arrests were made as part of a joint initiative between Italy's counter-terror police and financial police. The investigation

began after the 7 October 2023 Hamas attack in southern Israel. Police say they analysed "a series of reports of suspicious financial transactions" involving some of the suspects in the lead up to the attack. Investigators uncovered a "complex" system of fundraising, which was headquartered in Genoa, with branches in Milan, the

statement adds. "The suspects collected donations intended for the civilian population of Gaza, however, it emerged that over 71% of these funds were diverted to Hamas's coffers to finance its military wing and support the families of suicide bombers or those detained for terrorism," the police statement says.

IRANIAN CINEMA GIANT, BAHRAM BEYZAI, DIES AGED 87



Widespread tributes have been shared for Bahram Beyzai, a giant of Iranian cinema and theatre, who has died aged 87 in the US. The front pages of Iranian newspapers mourn his loss, with opposition voices and those who look back fondly on the Shah era also paying homage to Beyzai. Prince Reza Pahlavi, the exiled son of the last Shah of Iran, described his passing as "a great loss for the art and culture of our country".

Although Beyzai's later films were banned in the 1980s by the Islamic regime that toppled the Shah, a number of senior figures in the current government have also paid tribute to his contribution to Iranian culture. Several of the current crop of

Iranian filmmakers have acknowledged their debt to him, with Jafar Panahi - whose latest film won the top prize at this year's Cannes Film Festival - saying that he taught them "how to stand up to oblivion". Beyzai avoided direct political references in his work, both as a playwright and a film director, and always said he tried not to

Executions in Iran estimated to have doubled in 2025, report says



The number of executions in Iran in 2025 is estimated to have more than doubled compared to the number that took place across the country in 2024. Norwegian-based Iran Human Rights (IHR) group told the BBC it had verified at least 1,500 executions up until the start of December, adding that many more have taken place since. Last year, IHR was able to verify 975 executions - although the exact number is never completely clear as Iranian authorities do not give official figures. However, the analysis shows another significant annual rise, and the figures chime with those provided by other monitoring groups. Iran's government has previously defended its use of the death penalty, saying it is limited to only "the most severe crimes". Execution figures were already on the rise before mass demonstrations broke out across the country in 2022 following the death in custody of Mahsa Amini. The 22-year-old Kurdish woman was detained by morality police in Tehran for allegedly wearing her hijab "improperly". That protest movement represented the biggest challenge to the legitimacy of Iran's theocratic leadership for many years. In response, authorities intensified the rate of executions from around 520 in 2022 to 832 in the following year - according to the figures verified by IHR. There have been some executions for protesters or alleged spies - but 99% of those executed have been for murder or drug offences - a ratio which has remained constant. Activists have said that the rate of executions in Iran increases when the regime feels under threat and that the aim is to forestall internal opposition by instilling fear in the population. It seems to be borne out by the fact that since the 12-day war with Israel in June, as well as major setbacks for Iran's proxy forces across the region, there's been another big surge.



POUND-FOR-POUND STAR INOUE CRUISES PAST PICASSO

Japanese superstar Naoya Inoue outpointed Alan David Picasso Romero with a classy display to retain his undisputed super-bantamweight title in Saudi Arabia. Widely regarded as one of boxing's leading pound-for-pound fighters, Inoue, 32, showcased his ring intelligence, fast hands and sharp combinations over 12 dominant rounds. Picasso, 25, was unable to live with Inoue's speed and body shots in Riyadh as the judges scored the contest 119-109, 120-108 and 117-111 in favour of the champion. Despite the one-sided nature of the victory, Inoue - a four-division world champion and undisputed in two weight classes - said he was disappointed with his display. "My performance tonight is not good enough. I should have done better," he said. The win extended Inoue's perfect record to 32 victories, including 27 by knockout, and sets up a potential showdown in 2026



with compatriot Junto Nakatani. Nakatani outpointed Mexico's Sebastian Hernandez Reyes on the undercard in a close contest marred by a controversial scorecard. In a fight where a case could be made for either boxer, two judges scored it 115-113, with the third returning an inexplicable 118-110 card. Following Terence Crawford's retirement, Inoue can be considered among boxing's leading fighters, alongside heavyweight champion Oleksandr

Usyk, who was ringside. After assessing Picasso in the opening rounds, Inoue moved smoothly through the gears. The taller, rangier Picasso enjoyed some single-punch success in the first half, but Inoue appeared largely untroubled by his opponent's power. Former middleweight world champion Gennady Golovkin, now president of World Boxing, watched from close quarters as Inoue upped the

tempo, throwing fluent combinations and pressing forward with confidence. Heavy right hands in the fifth and sixth rounds, coupled with repeated hooks to the body, slowed Picasso, whose movement began to fade as the outcome became increasingly clear. A thudding left hook in the 12th represented a valiant, last-ditch attempt at an unlikely upset, but the bout had long since become a masterclass. Making a fourth defence of his undisputed crown in 2025,

Inoue continues to set the standard for activity at the elite level and places himself firmly in the conversation for fighter of the year. Inoue said in the build-up that his time in the sport is "running out" - but he has options. There has been speculation about a move up to feather-

weight to face Liverpool's WBA world champion Nick Ball, while he has also welcomed the challenge of hard-hitting unified super-flyweight champion Jesse 'Bam' Rodriguez. The bout many fans - and influential Saudi Arabian boxing figure Turki Alalshikh - are most keen to see, however, is against Nakatani. Nakatani, who vacated his WBC and IBF bantamweight titles to move up in weight, was a heavy favourite against Hernandez and controlled the early rounds with sharp uppercuts and effective body work. Hernandez refused to fade, coming on strongly in the second half as he pressed forward relentlessly and landed telling shots. The controversial 118-110 scorecard underlined familiar judging concerns within the sport. Despite the controversy, the unbeaten Nakatani - a three-weight world champion - extended his record to 32 wins, 24 of them by stoppage.

Shubman Gill's T20 World Cup 2026 Snub Causing Disarray In Team India? Report's Big Claim

The decision by the BCCI selectors to drop star batter Shubman Gill from the squad for the 2026 T20 World Cup has left many fans and experts stunned. Gill, currently India's Test and ODI captain, was also the T20I vice-captain. However, with his recent struggles in the shortest format, he has been left out of the World Cup squad. According to a PTI report, the move has sparked uncertainty among players regarding their place in the side under Gautam Gambhir's coaching. The report claimed that the decision to drop Gill from the squad "had Gambhir's

footprints written all over it." It further stated that the decision has created unease among several players, who now believe that "if Indian cricket's next poster boy could be dumped by the wayside, the next omission could have anyone's name written on it." Gautam Gambhir's record as India's white-ball coach has been impressive, with an ICC and ACC trophy in each of the two formats. This victory propelled Artemiev to 6.5 points, a full point ahead of the field. Following the loss, Carlsen was visibly upset and stormed out of the playing hall. A video going viral on social media shows Carlsen being chased by a cameraman as he exited the venue. In a fit of rage, the Norwegian pushed the cameraperson away, expressing his frustration. After a strong start with 4.5/5 on Day 1, Carlsen's performance dipped on Day 2. In Round 6, he

point. Carlsen bounced back in Round 8 with a win against Armenian GM Shant Sargsyan, and in the final round of the day, he held an advantage on time against US GM Ray Robson.
