RBI TO AUCTION GOVT BONDS WORTH RS 32,000 CRORE ON JAN 2

New Delhi (TSIT): The government of India on Monday announced the sale (re-issue) of "6.48 per cent Government Security 2035" for a notified amount of Rs 32,000 crore through price-based auction using the multiple price method. The auction will be conducted by the Reserve Bank of India's Mumbai Office on January 2. The Government will have the option to retain additional subscription up to Rs 2,000 crore against the security, according to a Finance Ministry statement. Up to 5 per cent of the notified amount of the sale of the security will be allotted to eligible individuals and institutions as per the Scheme



for Non-Competitive Bidding Facility in the Auction of Government Securities, the statement said. Both competitive and non-competitive bids for the auction should be submitted in electronic format on the Reserve Bank of India Core Banking Solution (E-Kuber system) on January 2, 2026. The non-competitive bids should be submitted between 10:30 a.m. and 11:00 a.m., and the competitive bids should be submitted between 10:30 a.m. and 11:30 a.m., the statement explained. The result of the auction will be announced on January 2, and payment by successful bidders will be on January 5.

CM Revanth inspects Legislative Council renovation works



HYDERABAD (TSIT): Chief Minister A. Revanth Reddy on Monday inspected the ongoing renovation and modernization works of the Telangana Legislative Council building located within the Assembly premises. He was accompanied by Legislative Council Chairman Gutha Sukender Reddy. During the inspection, the leaders reviewed the progress of repair works being carried out to strengthen the building's infrastructure and enhance facilities for members and officials.

Officials briefed the Chief Minister on the scope of the renovation, project timelines, and the quality standards being followed. Revanth Reddy directed them to ensure that the works are completed within the stipulated time while maintaining high standards of safety and construction quality. The inspection gains significance as the Telangana Legislature is in session, with the government focusing on upgrading institutional infrastructure to meet current and future requirements.

2 Telangana women killed in California car crash



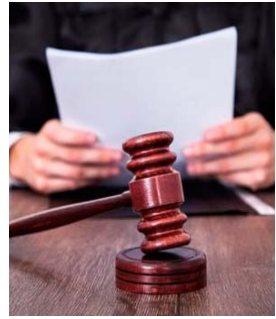
Hyderabad (TSIT): Two women from Telangana were killed in a tragic car accident in California while they were in the United States in search of employment. The incident occurred when the vehicle they were traveling in met with a severe crash, resulting in their death on the spot. According to preliminary information, the victims had recently arrived in the US and were pursuing job opportunities. Local authorities

ties have initiated an investigation into the cause of the accident, while formal identification procedures are underway. The news has sent shockwaves through their families and native places in Telangana. Relatives and friends have appealed to the authorities for support in completing legal formalities and repatriating the bodies to India. Further details regarding the circumstances of the accident are awaited.

UNNAO RAPE CASE: People trying to take political advantage, says SC on allegations against HC judges

NEW DELHI: (DEC 29) After expelled BJP leader Kuldeep Singh Sengar's lawyers said that allegations were made against the Delhi High Court judges who suspended his life sentence in the Unnao rape case, the Supreme Court on Monday observed that some people are trying to take "political advantage". The high court had suspended the jail term of Sengar, who was serving life imprisonment in the Unnao rape case, saying he had already served seven years and five months in prison. "We understand it. We are not sitting in ivory towers. We understand that people are trying to take political advantage and there are people who

are trying to take advantage," Chief Justice of India Surya Kant, who was heading a three-judge vacation bench, said. Senior advocate N Hariharan, appearing for Sengar, pointed out



that some people were making allegations against the high court judges who dealt with the case. He said such persons should refrain from mak-

ing statements or allegations against the judges. "They are doing that on national television," Hariharan said. Another lawyer, who also appeared for Sengar, said photographs of the high court judges were also being circulated. Hariharan said there is a video circulating leveling allegations against the judges and this was a cause of concern. The bench observed that such people are simply forgetting that Sengar was convicted by the judiciary only. "Very frankly, these judges are one of the finest we have," the bench, also comprising Justices J K Maheshwari and Augustine George Masih, said during the hearing.

Rajnath clears 79,000 cr arms procurement

NEW DELHI (TSIT) The defence ministry on Monday approved procurement of long-range rockets, missiles, radar systems and military platforms worth Rs 79,000 crore to bolster the military's combat prowess. The Defence Acquisition Council (DAC), chaired by Defence Minister Rajnath Singh, green-lighted the proposals. The DAC approved procurement of loiter munition systems for the Army's artillery regiments. It also cleared acquisition of low level lightweight radars, long-range guided rocket ammunition for Pinaka rocket system and integrated drone detection and interdiction system (Mk-II) for the Indian



Army, the defence ministry said. Loiter munition will be used for precision strike of tactical targets, whereas low level lightweight radars will detect and track small size, low flying unmanned aerial systems, it said. It said low range guided rockets are being procured to enhance the range and accuracy of Pinaka rocket systems for effective engagement of high value targets.

Andhra Cabinet approves formation of two new districts



AMARAVATI (TSIT): The Andhra Pradesh Cabinet, on Monday, approved formation of two new districts, taking the total number of districts in the state to 28. The Cabinet meeting chaired by Chief Minister N. Chandrababu Naidu approved formation of Polavaram and Markapuram districts. Polavaram district will

have Rampachodavaram as its headquarters. Briefing the media on the Cabinet decisions, state Revenue Minister Anagani Satya Prasad said that the Cabinet approved proposals for changes in 17 out of the total 26 districts. A total of 25 changes were made in these 17 districts, Minister Satya Prasad added.

Telangana Assembly to meet from Jan 2 to 7



HYDERABAD (TSIT): The Telangana Legislative Assembly will hold its session from January 2 to January 7, as decided by the Business Advisory Committee (BAC) at a meeting chaired by Assembly Speaker Gaddam Prasad Kumar on Monday. The Assembly will remain in recess until January 1. The BAC meeting was attended by Deputy Chief Minister Bhatti Vikramarka, Ministers D. Sridhar Babu and Ponnampalapati Prabhakar, along with leaders of various political parties. The committee also finalized the agenda and number of working days for the upcoming session. The Winter Session of the Telangana Legislature began earlier with obituary references in both Houses. The Assembly paid tributes to former MLAs Ram Reddy and Damodar Reddy and

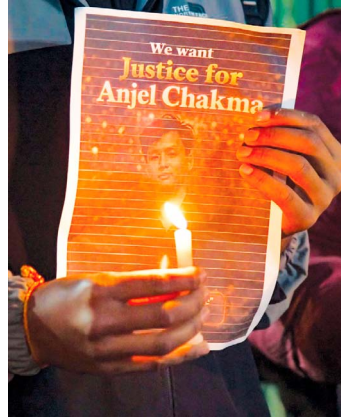
Konda Laxma Reddy, while the Legislative Council mourned former MLAs Madhavaram Jagapathi Rao and Ahmed Peer Shabbir. During the initial proceedings, the government introduced several ordinances in both the Assembly and the Council. Chief Minister A. Revanth Reddy tabled ordinances related to municipal laws, GHMC amendments, BST amendments, and audit reports of Samagra Shiksha and PM Schools for Rising India. Deputy Chief Minister Bhatti Vikramarka introduced the Telangana Public Service Commission amendment ordinance, while Panchayat Raj Minister Seethakka tabled the Panchayat Raj amendment ordinance. Bills will be brought in the session to give statutory backing to these ordinances.

NATIONAL DISGRACE

Leaders call for zero tolerance against hate crimes targeting northeastern people

Dehradun (TSIT) Uttarakhand Chief Minister Pushkar Singh Dhami spoke to the father of the student from Tripura, who was killed in an alleged racial attack here, on phone on Monday and assured strict punishment for the accused, as leaders cutting across political lines called for comprehensive efforts to end "hate crimes" against the people from the northeastern states. Rahul Gandhi and other opposition leaders targeted the BJP, alleging that the murder of MBA student Anjel Chakma (24) was a fallout of the ruling dispensation "normalising" hate and encouraging a "divisive mindset". Samajwadi Party chief Akhilesh Yadav demanded that the Supreme Court step in and ensure justice. Former Union minister Shashi Tharoor said the brutal killing "is a national disgrace", and political and religious leaders must speak out against the abuse of the people from the Northeast as "silence is complicity". Union minister Kiren Rijiju expressed "dismay and anger" over the killing and called upon the people to fight against

such "mindset" together, saying any such incident is "very shameful" and harms the country. He said the issue should not be politicised. Asked about Rahul Gandhi and other opposition leaders holding the BJP responsible for the incident, Rijiju said, "Be it a youngster coming from the north east, Kashmir, Tamil Nadu, Bihar, Uttar Pradesh, Bengal... a student from any of the states in the country, we are all Indians. Everyone should be sad if any such incident happens with anyone from any part of the country. This is not a matter on which politics should be done. Be it the northeast or in any other part of the country, why should anyone from other regions be subjected to such discrimination on the lines of race, religion, caste and looks." AAP chief Arvind Kejriwal said the country needs strict action and a national law against racism and hate crimes. "Justice must be swift and exemplary," he said on X. Speaking in the same vein, Congress leader Gaurav Gogoi demanded that the case be investigated in a time-bound manner and the guilty be given



the harshest punishment to convey a message across the country that there is zero tolerance for such crimes. Rajya Sabha MP Kapil Sibal said Union Home Minister Amit Shah must speak up against the hate crimes. In a post on X, he said the murder is "a shocking display of a hate crime, of bigotry, of the silence of our leaders in government who by their inaction are complicit." Gandhi said on X, "What happened to Anjel Chakma and his brother Michael in Dehradun is a horrific hate crime. Hate doesn't appear overnight. For years now, it has been fed daily — especially

to our youth — through toxic content and irresponsible narratives. And it's being normalised by the hate-spewing leadership of the ruling BJP." Tharoor said the Northeast is "not a distant appendage to the Indian identity; it is central to it. Yet, people from the region are routinely subjected to racial profiling, exclusion, and abuse. This must end." "We must demand justice ... not only in the courts, but in the conscience of the nation. His death must not be reduced to a statistic or a fleeting headline. "It must ignite a movement for education, empathy, and reform. Schools must teach the histories and cul-

tures of all Indian communities. Media must portray Northeast Indians with dignity. And society must unlearn its biases," the Congress MP said on X, and called for building "a society where no Indian is made to feel foreign in their own land". Mizoram Chief Minister Lalduhoma said this tragedy highlights the "continuing challenges faced by people from the Northeast in parts of mainland India. Discrimination and racial prejudice have no place in our Constitution, and the rule of law must prevail to ensure justice". Assam Chief Minister and BJP leader Himanta Biswa Sarma said the death of the student from Tripura "following brutal racial abuse in Dehradun is heart-breaking and unacceptable" and urged Dhami to ensure strict action against the culprits so that justice is served. Dhami, in his phone conversation with Anjel Chakma's father, Tarun Prasad Chakma, said he is saddened by the incident and that the state government stands with the victim's family.

Vikas Raj reviews progress of New High Court building works at Rajendranagar



Hyderabad: Special Chief Secretary, Transport, Roads & Buildings (TR&B) Department, Vikas Raj, convened a review meeting at the site office of the New High Court complex at Rajendranagar on Sunday to assess the progress of construction works.

The meeting was held at 5.00 pm in the presence of the Chief Engineer (R&B) Buildings, Chief Engineer (R&B) Electrical, and Superintending Engineer (R&B) attached to the High Court project. During the review, several key issues were discussed and clear instructions were issued to expedite the works and adhere to timelines. The Special

Chief Secretary directed that weekly review meetings be conducted at the site every Saturday from 9.00 am to 11.00 am. Consultants were instructed to ensure the presence of their structural and MEP sub-consultants in all such meetings. To overcome delays, the consultants were also asked to enhance technical manpower and deploy additional sub-consultants wherever necessary.

Vikas Raj instructed the Chief Engineer (R&B) Buildings to examine the feasibility of engaging an independent engineering firm to provide technical suggestions within the scope of the agreement. He further directed the department, contractor,

and consultants to work in close coordination and take all necessary measures to complete the project within the agreed timeline.

The consultants were told to submit drawings strictly as per the approved schedule and ensure that drawings are submitted at least two months in advance to facilitate procurement of materials and mobilisation of labour. It was also made clear that if consultants fail to adhere to drawing schedules, alternate consultants may be engaged without affecting project progress.

He further stressed that architectural and spatial provisions, including MEP shafts, should be jointly discussed by civil and electrical engineering teams and that all finalised drawings must be thoroughly verified in accordance with National Building Code (NBC) norms.

The review underscored the government's focus on timely completion and quality execution of the prestigious New High Court building project.

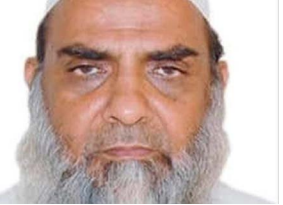

Revanth stalling irrigation project to please 'former boss': KTR

Hyderabad, Dec 29 : Bharat Rashtra Samithi (BRS) working president K.T. Rama Rao on Monday alleged that Telangana Chief Minister A. Revanth Reddy stalled the Palamuru-Rangareddy lift irrigation project to appease his 'old boss' and Andhra Pradesh Chief Minister N. Chandrababu Naidu.

Rama Rao said that Chief Minister Revanth Reddy fears that completion of the project would bring credit to former Chief Minister K. Chandrasekhar Rao (KCR) and invite the displeasure of his former political mentor N. Chandrababu Naidu.

Interacting with the media in the Assembly premises, KTR said it was a standard practice for any government to initiate irrigation projects in the name of drinking water needs and subsequently obtain statutory approvals, but this reality was rarely acknowledged openly.

He recalled that the Polavaram project has been discussed for over 70 years and is still incomplete, whereas the Kaleshwaram Lift Irrigation Project was completed during KCR's tenure due to his unwavering commitment.



"Kaleshwaram stands as testimony to KCR's dedication. Even if investigations are carried out endlessly, the state will only suffer—politically, we will not. People know very well who ensured water for Telangana," KTR asserted. On the Palamuru-Rangareddy project, KTR stated that accepting an allocation of only 45 TMC would be detrimental, and reminded that it was the earlier Congress government that had agreed to 299 TMCs in Krishna. Based on that understanding, the BRS government had approached the Centre for enhanced allocations. Despite this, he alleged, Revanth Reddy has deliberately stalled the project.

On the Greater Hyderabad Municipal Corporation (GHMC),

KTR said there was widespread speculation about splitting GHMC into three parts and even converting the so-called "Fourth City" into a separate corporation. Any restructuring, he insisted, must be done scientifically.

He accused the Congress government of undertaking arbitrary delimitation purely for financial gains, allegedly on the advice of merchant bankers and brokers. "This entire exercise is aimed at raising money. Such reckless actions will not go unanswered," he warned, adding that the BRS would demand a detailed discussion on the issue.

Responding to allegations of phone tapping, KTR said intelligence systems have existed since the Nehru era and are meant for maintain-

ing law and order and safeguarding the state. "Can anyone honestly claim that surveillance mechanisms do not exist today?" he asked.

He questioned whether the Chief Minister could categorically state that opposition leaders' phones are not being tapped. If the tapping was untrue, KTR asked, why were officials not holding press briefings to clarify matters? He also noted that the present DGP had served during earlier regimes and was well aware of how intelligence systems function.

KTR criticised the Congress government for using SITs, inquiries, and cases as tools of distraction. "What has been achieved through so many investigations? Has even one allegation been conclusively proven?" he asked, adding that people clearly see through these diversionary tactics. Referring to recent sarpanch elections, KTR said the results amounted to a referendum on Congress governance. Despite attempts to inflate numbers by including sarpanches from other parties, the people had clearly rejected the Congress government within just two years of its rule.



EDITORIAL

Lessons from 'The Man in The High Castle'

The Man in the High Castle is an alternative history TV series based on the 1962 novel of the same name by Philip K. Dick. It shows a world where the Axis powers have won the second world war. The United States has been divided between Germany and Japan. Nazi Germany rules the East, Imperial Japan controls the West, and a fragile Neutral Zone lies between. Swastikas hang over Manhattan; and the imperial Japanese military police patrol San Francisco. After his sister and her children are murdered for his girlfriend Juliana's ties to the resistance, Frank Frink – an arms-factory worker – seeks solace from Ed McCarthy, a practising Jew who openly lives his faith despite the mortal risk it carries. Ed: One thing I realize about my people (the Jews). We have a different sense of time. These may be dark years, but we will survive. We always do. You've just got to find something to hold on to. That brief exchange distils three profound truths about surviving life under an authoritarian regime: “We have a different sense of time. These may be dark years, but we will survive. We always do. You've just got to find something to hold on to.” History bears out Ed's insight that real resistance moves on a long clock. Apartheid in South Africa took 46 years to dismantle; India's freedom struggle unfolded over two hundred years; Black Americans waited a full century from emancipation to secure basic voting rights; and Ireland's fight against British rule unfolded over more than a century. Even women's suffrage in Britain took about 50 years of sustained agitation. The hardest thing about resistance is not the oppressor's power; it is often the cynicism of those who have already decided defeat is inevitable. Those who are tempted to become weary with the struggle should remember Martin Luther King's words, “The arc of the moral universe is long, but it bends towards justice.” “Find something to hold on to...faith...art...Beauty is important. It gives us hope.” Colour, art, laughter, and imagination refuse the emotional discipline authoritarianism tries to impose. To remain fully alive in soul-deadening times is an act of resistance in itself. In his Power of the Powerless, Czech dissident and later president, Vaclav Havel argued that living truthfully, creatively, and fully was in itself an act of resistance. “The struggle against the system is not just a political struggle, but a struggle for life itself” Arundhati Roy says something similar: “Another world is not only possible, she is on her way. On a quiet day, I can hear her breathing.” It is important for those engaged in resistance to step away from the noise and the struggle regularly, and take time for the things that give them joy and strength so they too may be able to ‘hear the breathing of another world.’ “You've got your own little fascist (in your head) telling you what you can or cannot do. That's how you let them win.” Ed McCarthy's warning about the “inner fascist” highlights the strongest weapon of authoritarianism: the voice inside us that says don't risk it, don't stand out, don't hope. There is a reason fascist regimes plaster their leader's image everywhere, on billboards, walls, newspapers, even vaccination certificates. The purpose is to crowd out thought itself, and to whisper – constantly and subconsciously – this is all there is. It creates the illusion of inevitability. But when we insist on creating, celebrating, and imagining freely, we puncture that illusion and deny authoritarianism its final victory: the occupation of the inner life. Joy, art, music, faith and humour, thus, become some of the most effective ways to disarm the “inner fascist.” In The Man in the High Castle, forbidden newsreel films circulate through the Reich showing an alternate reality in which the Allies won the war. Hitler fears these films so deeply that he orders their destruction. The series turns on this terror: not of weapons or armies, but of imagination itself, and the destabilising power of seeing that history could have turned out differently and that nothing is permanent. The Man in the High Castle ultimately reminds us that authoritarianism is sustained as much by thought as by force—and undone the same way. Long before regimes fall, they begin to crack when we refuse to surrender our inner lives: when we create beauty without permission, hold faith without guarantees, and imagine futures that power insists are impossible.

Maithili Thakur, Feminism and the Politics of Being a Young BJP Leader

For over a decade, we have repeatedly heard the slogan: Narayastu yatra poojayante Ramante tatra Devta – Where women are worshipped, the Gods reside. But despite that, India's most powerful political party has given ample hints that it harbours a deep dislike for feminists. In its aggressive shrillness, their anger toward feminists stands next only to the anger they reserve for the Vaampanthi, Left-wing groups. After the Bihar elections, a young and shy 25-year-old singer, who had had nothing to do with politics thus far, was handpicked and catapulted to fame when she was allocated a ticket from the Alipur constituency. A landslide win for the Bharatiya Janata Party (BJP) coalition followed, and Maithili Thakur became the youngest legislator in the newly elected Bihar Assembly. Why aren't the feminists celebrating Maithili Thakur's victory in Bihar? asked one @anullall, with a link to her longer article in News18 on X, in which the writer suggested it was perhaps because Thakur did not fit the cultural template of imported ‘feminism’. “We have been taught” (by whom?) she went on, without providing proof, to say that all feminists distance themselves from patriarchy, love to smash the accepted mould and have adopted a Western persona. “They don't see strength in desi,” she added. “#Feminism has nothing to do with women empowerment... is a tool of radically Islamic terror to..break Hindu families.” (@rajesh271285400) Maithili is undoubtedly a good singer and had won admiration from her listeners for her obvious musical talent even before she was drawn into politics. But a referendum like the one above magnifies the worst insults feminists have been subjected to by the Right. It is no secret that our democracy is already mired in a rising graph of crimes against women and that pro-women laws have not helped the victims much. There have been multiple controversial legal verdicts where rapists and abusers of women were let out on bail, or the charges against them were suddenly dropped as witnesses turned hostile or died and proofs remained ‘unsubstantiated’. Also read: As Crimes Against Women Rise, Delhi's Women's Commission Stays Closed As a first-time and youngest member of Bihar's



Legislative Assembly, Thakur is unarguably a raw recruit. All she could promise her constituents during her campaign was, with a timid smile, that she would give them regular ‘darshan’ and, party permitting, she would rename her constituency of Alinagar after Sita. Since then, when asked how she sees herself in her new political avatar, reports mostly quote the singer saying, “Party will know what they have in mind for me. I'll do whatever the party orders.” In an atmosphere increasingly turning hostile toward deemed enemies of the state, it was unsurprising that a day before the festival of love, peace and goodwill to all, we learnt that a former BJP MLA, Kuldeep Singh Sengar, serving time under serious charges of rape and murder, had been granted bail by the Delhi High Court, which had also chosen to suspend his life sentence using bureaucratic hair-splitting over his being or not being a ‘public servant’. When the news came, an Uttar Pradesh minister was widely seen smirking on TV screens, while the astonished victim, whose father died in custody, reacted and said she would challenge the verdict and sit in dharna at India Gate in protest against her tormentor being let out of jail. “India Gate?” the media reported the minister saying, “but her home is in Unnao!” On the same day, a Delhi court acquitted three people charged with an acid attack on a young girl in Panipat, who fought her perpetrators in court for long and had the case transferred from Haryana to Delhi, even though she could barely scrape

together the money required to make trips to the court and get herself treated. The victim, who has lost an eye and has a badly scarred face, says she will approach the high court. This is not only about rapists going unpunished. It is also about communalising crimes such as rape and violence. While in Delhi the Prime Minister visited the Cathedral Church of Redemption and made a speech there, tracing his long relationship with the Church, mobs violated and vandalised a shopping mall over its Christmas displays. On Christmas day, in a widely circulated video, one heard a BJP district vice president, a woman, angrily accusing the staff and Christmas revellers of carrying out conversions. During a scuffle that followed, even a visually impaired school teacher's wife was verbally assaulted and intimidated. The district vice president has since apologised and cited ‘misinformation’ for her entry and hot words – but will matters rest there? There is no protest against such behaviour from the BJP's firebrand women leaders who, when in Opposition, went blue in the face demanding resignations after Nirbhaya was raped and killed. One can assume that the party seniors are crusty politicians who tailor their reactions carefully. But why was there no reaction from the youngest MLA from Bihar, who might be the same age as the girl from Unnao or Panipat? Instead, since December 25 also happened to be the birthday of one of her politically idolised leaders, Atal Bihari Vajpayee, we saw Thakur

soulfully sing a poem of his: Geet naya gata hoon / Haar nahin manoonga / Raar Nayi Thanoonga / Kaal ke kapal per likhta mitata hoon... I sing a song of the new / I shall not be defeated / I shall continue to write and erase words / Inscribed on the forehead of Time. Will the demurely dressed young MLA be guided by empathy as a woman, or will she prefer to remain largely dependent on the image the male leadership seeks to build for her? The choice seems to have already been made. From colleges to official meetings, young Indian women and girls mostly prefer to remain in conservative mode. Even most of our campuses are full of male rebellious leaders – very few are women – who stand up to be counted. Women, as Gloria Steinem said, radicalise late. They have first to personally experience some reality checks: about hierarchies in decision-making bodies, lower average allocation of important portfolios and the expected total compliance with male orders that they may not be entirely happy with. The need for legal changes, equal matrimonial status and an end to sexual harassment at workplaces that liberal feminists have gradually ushered in are essential accompaniments for young women as well. But even our first wave of feminists were greying matronly women, such as Sarojini Naidu, Amrit Kaur, Kamala Debi Chattopadhyaya, Ammu Swaminathan, Begum Aijaz Rasool, Durga Bai Deshmukh, Hansa Ben Mehta and Sucheta Kripalani.

2025: A Reform Year That Put Middle Class, Common Citizens First

The year 2025 stands out as a landmark in India's reforms journey-one that decisively placed the middle class and the common man at the heart of policy-making. Guided by the vision articulated by Prime Minister Narendra Modi, this period witnessed a series of interconnected reforms spanning taxation, labour, investment, and ease of living. Together, these measures have reshaped India's economic landscape by strengthening household finances, boosting consumption, and reinforcing confidence in long-term growth. In his Independence Day address, the Prime Minister underscored the central role of the middle class in nation-building, noting that while this segment contributes significantly to the country, it also aspires to a better quality of life. That vision found concrete expression within months through policy actions that directly touched lives. From the new income tax framework to GST 2.0, the reforms of 2025 signal a shift from complexity to clarity, and from burden to empowerment. Among the most impactful steps has been the restructuring of the direct tax system. By



exempting incomes up to Rs 12 lakh and enhancing the standard deduction to Rs 75,000, the government has delivered meaningful relief to a vast majority of taxpayers. As a result, nearly 90 per cent of taxpayers-around seven crore individuals-now fall within the tax-free bracket. The financial gains are tangible: an individual earning Rs 12 lakh saves Rs 1 lakh in taxes, with total savings rising to Rs 1.75 lakh after accounting for the standard deduction. Higher income brackets also benefit, while retirees gain from the doubling of deductions on savings to Rs 1 lakh. This increase in disposable income has significant

macroeconomic implications. With middle-class households typically spending about 80 per cent of additional income, the tax relief alone is projected to inject nearly Rs 5 lakh crore into the economy. Economists estimate that this could lift private consumption growth beyond 10 per cent and push overall GDP growth above 8 per cent in FY26, reinforcing India's position as the world's fastest-growing major economy. Complementing direct tax reform is the introduction of Next-Generation GST, or GST 2.0. Building on the unification achieved since 2017, the new framework focuses on simplification

and affordability. By abolishing the 28 per cent and 12 per cent slabs and consolidating the structure around two principal rates of 5 and 18 per cent, the government has made the tax regime cleaner and more citizen-centric. Everyday essentials such as paneer, milk, rotis, and parathas have been fully exempted, while personal care items like soaps, shampoos, and toothpaste now attract just 5 per cent GST instead of 18 per cent. The benefits extend to key areas of household expenditure. Two-wheelers, small cars, and three-wheelers-once taxed at 28 per cent-are now under the 18 per cent slab, making mobility more

affordable for young professionals and families. Cement has seen a rate cut from 28 to 18 per cent, lowering housing and construction costs. For rural households, tractors, harvesters, and irrigation machinery are now taxed at 5 per cent, reducing input costs and supporting agricultural productivity. Students benefit from exemptions on notebooks, pencils, maps, and erasers, easing education expenses. Healthcare affordability has been another priority. Life-saving cancer drugs and medicines for rare diseases have been placed in the zero-tax category, while medical oxygen, diagnostic kits, and thermometers are taxed at minimal rates. These measures directly reduce out-of-pocket expenses for families and reflect a policy approach that aligns fiscal decisions with social well-being. The reform momentum of 2025 extends beyond taxation. Labour code reforms have simplified compliance while enhancing social security, contributing to formalisation and job creation. FDI liberalisation has strengthened capital inflows and investment, supporting growth across sectors.

R Ashoka slams Congress govt, alleges 'not a New Year celebration but a drug fest in Karnataka'

Kaup, Dec 29: Leader of Opposition in the Karnataka Legislative Assembly, R Ashoka, on Friday lashed out at the Congress-led government, claiming that the state has become a hub for the drug mafia. He alleged that what should have been New Year celebrations has instead turned into a "drug fest" in Karnataka, highlighting the government's alleged failure to control the menace. Speaking at a press conference, Ashoka referred to major drug raids in Bengaluru conducted by the Maharashtra police, criticising the state administration's inaction. "Maharashtra police are conducting raids in Bengaluru and have seized drugs worth crores of rupees. Why didn't our police know about this? Is there any bigger humiliation than this?" he asked.

He said Maharashtra police had conducted two major operations in the state. "This government should be ashamed. Do they have any dignity? Has Karnataka's intelligence system collapsed? You claim the operation was conducted with the help of Karnataka police, then why were you unaware of this mafia earlier?" he questioned, describing the Home Minister as lacking common sense and the administration as irresponsible.

Ashoka alleged that jails in Mangaluru and Bengaluru are filled with drug peddlers and have turned into "five-star facilities." "Drugs, opium and



whisky are freely available. Jails have become wine factories and extortion centres. Every day, a constable earns up to Rs 1 lakh. Biryani, oil and drugs are supplied inside prisons," he claimed.

He further alleged that drugs worth Rs 500-600 crore have entered Karnataka, with police personnel involved in their distribution. "Within two days, everything will be disposed of. Police themselves are acting like thieves. This government has neither the courage nor the strength to control the situation," he said.

Ashoka also criticised the state leadership, saying the home minister was "missing" and the chief minister preoccupied with internal power struggles. "It feels like they are just waiting for retirement. This is a government run on superstition and power-sharing conflicts," he remarked, while also taking a dig at the Congress high command and Rahul Gandhi.

Warning that the situation could invite intervention from neighbouring states, Ashoka said police from Andhra Pradesh and Telangana may be forced to operate in Karnataka.

MP Sports Festival to Begin on January 11 in Haveri-Gadag Constituency

Haveri: The MP Sports Festival-2026 will be organized in the Haveri-Gadag Lok Sabha constituency from January 11, with the aim of promoting indigenous and mainstream sports and encouraging greater participation of youth. Former Chief Minister and Member of Parliament Basavaraj Bommai said nurturing a strong sports culture and creating opportunities for young talent are the key objectives of the initiative.

Presiding over the preliminary meeting for the MP Sports Meet-2026 at the District Collector's Office here, Bommai directed officials to make all necessary arrangements for the successful conduct of the festival with the active involvement of the district administration, Zilla Panchayat, and the Department of Youth Empowerment and Sports.

He instructed that the inauguration be held on January 11 at the district stadium, while the competitions will be conducted in three stages—hobli, taluk, and district levels. Athletes selected at the hobli level will advance to the taluk level, and those selected

at the taluk level will compete at the district level.

The sports meet will include events such as kabaddi, kho-kho, volleyball, 100m, 200m and 400m races, relay races, and other competitions. Bommai also asked officials to prepare detailed plans covering venue selection, partnerships, awareness campaigns, sports infrastructure, availability of coaches and referees, and other logistical arrangements.

Emphasising smooth athlete participation, he instructed that registrations be facilitated through both online and offline modes at key locations, with teams formed based on registered athletes. Arrangements will also be made to provide meals and T-shirts to participants.

The meeting was attended by Zilla Panchayat Chief Executive Officer Ruchi Bindal, Additional Deputy Commissioner Dr. L. Nagaraj, Zilla Panchayat Deputy Secretary Dr. Puneeth, Assistant Director of the Department of Youth Empowerment and Sports Latha, along with other district-level officials.

Babasaheb Dr. B.R. Ambedkar Dalit Seva Samiti demands for Dalit leaders should be appointed as Chief Ministers

New Delhi : Babasaheb B.R. Ambedkar Dalit Seva Samiti, in a unique way, held a banner in front of the Delhi AICC Congress office and submitted a petition to the Congress High Command demanding that G. Parameshwar, the Home Minister of the Karnataka government, be made the Chief Minister, while the CWC national meeting was underway.

Babasaheb Dr.B.R. Ambedkar Dalit Seva Samiti State President Dr. M. Murthy was accompanied by M. Suresh, Raghunath, Shivalingaiah, and hundreds of Dalit community leaders and social thinkers.

Speaking on the occasion, Dr. M. Murthy said that it is a matter of regret that no Dalit community has been the Chief Minister in the state Congress government since independence. There are crores of Dalit people in the state. 100 percent of the votes of the Dalit community have been given to the Congress party. The Congress party won more than 136 seats



in the last assembly elections due to the cooperation and support given by the Dalit community. If a Dalit community is not made the Chief Minister, more than 25 thousand Dalit community leaders and activists will protest across the state, he said.

AICC President Mallikarjun Kharge, Home Minister are good educated leaders. His contribution to the Congress party is immense. The Congress party government came to power in the state during his tenure as the KPCC president. H.C. Mahadevappa has done a good job as the Minister of Social Welfare. K.H. Muniyappa is a senior politician. Our demand is that a Dalit community should become the Chief Minister.

Maize Procurement Centres Must Be Opened in Every Taluk: Basavaraj Bommai

Haveri: Former Chief Minister and Member of Parliament Basavaraj Bommai accused the state government of deceiving farmers over maize procurement and demanded that maize procurement centres be opened at every taluk headquarters. Speaking to the media in Haveri on Monday, he said the government had failed to take concrete steps despite making tall promises.

Bommai stated that nearly 80 percent of farmers in North Karnataka cultivate maize and that the state has produced around 54 lakh metric tonnes of maize this year. The government had announced that it would procure 10 lakh metric tonnes, but in reality, it may have procured only 50 to 60 metric tonnes so far. He alleged that the state government has not released funds nor appointed procurement agencies, and merely instructing molasses traders to buy maize will not help farmers.

It has been over a month since the Chief Minister announced the procurement, yet not a single procurement centre has been opened, he said. As a result, maize-growing farmers in nearly 20 districts are being neglected. Bommai warned that if procurement centres are not opened immediately, farmers will

face severe injustice.

He pointed out that registered farmers have transported maize in tractors and are waiting for days, leading to weight loss and spoilage of produce in the fields. In some cases, farmers are being asked to take their produce to Shikaripura, where they are forced to wait overnight, causing further hardship. This, he said, clearly reflects the anti-farmer policies of the state government.

Government Responsible for Law and Order Failure

Responding to questions on law and order, Bommai said the situation in Karnataka has been deteriorating for a long time, with daily incidents of robbery, murder, extortion, and looting. He cited a daylight robbery in Mysuru as evidence of the collapse of law and order. He further alleged that drug manufacturing units operating within Karnataka and supplying drugs across the country indicate direct involvement of the state government. When Maharashtra authorities conduct raids, he questioned what Karnataka officials were doing. Bommai demanded the suspension of concerned DCPs, holding the Home Minister and Home Department directly responsible.

Protest to Intensify if Maize Procurement Centre Not Opened in Shiggaon: MP Bommai

Haveri (Shiggaon): Former Chief Minister and MP Basavaraj Bommai has warned of an intense farmers' agitation if a maize procurement centre is not opened in Shiggaon at the earliest. Addressing farmers staging a sit-in protest at the Tahsildar's office premises in Shiggaon on Monday, Bommai asserted that he has always stood with farmers and will continue to do so throughout his life. Questioning whether the power of farmers is greater or that of authority, Bommai said nearly 80 per cent of farmers in Shiggaon taluk cultivate maize and are demanding a fair support price purely in the interest of their livelihood. He alleged that certain forces are attempting to politicise and weaken the agitation, but urged farmers not to be discouraged, stating that farmers do not belong to any political party



and that all parties depend on them.

Bommai pointed out that while the Central government has announced a minimum support price for maize, procurement is the responsibility of the State government. He criticised the government for holding meetings for sugarcane growers while ignoring maize farmers across nearly 20 districts. Though the government claimed it would procure 10 lakh metric tonnes, maize is cultivated on 16 lakh hectares producing around 54 lakh metric tonnes, he said, alleging that ethanol companies are

purchasing maize through middlemen instead of directly from farmers.

Recalling his tenure as Chief Minister, Bommai said his government procured every grain of maize during a price crash at Shiggaon APMC and took action against exploitative agents. He also highlighted welfare measures such as scholarships for farmers' children, the Yashasvini health scheme, and subsidies for seeds, fertilisers, and diesel, alleging that the present government discontinued several schemes for political reasons.

Steps to Ensure Uninterrupted Power Supply in the state: Additional Chief Secretary Gaurav Gupta

Bengaluru : Gaurav Gupta, Additional Chief Secretary, Energy Department said, Karnataka has taken decisive steps towards achieving self-reliance in power generation, and there must be coordination between production and distribution to ensure uninterrupted power supply to consumers.

Speaking after inaugurating the Golden Jubilee Commemorative Lecture of the Karnataka Electricity Board Engineers' Association, the release of the 2026 Technical Diary, and a free health check-up camp organized by the Retired Engineers' Association, held on Monday at Sir M. Visvesvaraya Auditorium.

"After COVID, when electricity demand increased significantly, we did not have adequate plans in place to meet the requirement. At that time, Chief Minister Siddaramaiah and Energy Minister K.J. George held meetings and instructed officials to take swift measures to enhance power generation. As a result, power generation in the state was accelerated, and Karnataka has moved towards power self-sufficiency. Now,



focus must be on supplying electricity to consumers without any interruptions. The government has taken steps to strengthen the required infrastructure, and engineers must cooperate in this effort," Gaurav Gupta said.

Responding to various demands raised by engineers of the Energy Department, the Additional Chief Secretary said, "These issues will be discussed in upcoming meetings and appropriate decisions will be taken. The government is committed to addressing the demands of engineers and further strengthening the depart-

ment."

Releasing the diary and calendar, CESC Chairman and MLA Ramesh Bandisiddegowda said, "Earlier, when the Congress government was in power under the leadership of Chief Minister Siddaramaiah, with D.K. Shivakumar as the Energy Minister, priority was given to power generation. Now, under the present government also led by Chief Minister Siddaramaiah, Energy Minister K.J. George has continued this work. In particular, through the KUSUM-C scheme, priority has been given to generating power and supply-

ing uninterrupted electricity for seven hours during the daytime to farmers' agricultural pump sets." "At present, we have achieved success in power generation and supply. Along with this, losses in power transmission and distribution must be reduced further. Moreover, programs should be designed to bring electrical accidents down to zero," he advised officials.

Carcasses of over 30 Olive Ridley turtles washed ashore in Karaikal

KARAIKAL: Over 30 Olive Ridley sea turtles were found dead along the Karaikal coast in a single day, with severe bleeding injuries on their bodies, raising concern just ahead of the nesting season.

Locals suspect the turtles were injured by ships and mechanised fishing boats operating near the private port before washing ashore. The carcasses were found along the coastal stretch from TR Pattinam, Pattinacherry to the Adani port area. Residents said the turtles,

estimated to be five to six years old and weighing between 30 kg and 50 kg, had injuries on their mouths, faces, limbs and bodies. The dead turtles were scattered across nearly five kilometres of coastline, with some lying barely 100 metres apart, and a foul smell was reported from the area.

People have urged the forest department to immediately remove the carcasses and intensify monitoring, as the incident occurred even before the peak nesting period of



Olive Ridley turtles, which usually lasts from December to April. The Karaikal incident comes amid a wider rise in turtle deaths reported along the Tamil Nadu and Puducherry coasts. In and around Chennai, more than 100 Olive Ridley turtles have been found dead so far, including along Neelankarai, Besant Nagar, Kovalam and Injambakkam beaches.

The number is higher than last year, said Shravan Krishnan, senior volunteer of the Students Sea Turtle

Conservation Network [SSTCN] and a member of the State Wildlife Board. While entanglement in fishing nets and injuries caused by propellers of mechanised boats operating in restricted zones are recognised causes of turtle deaths, experts have also pointed to changes in sea currents linked to climate change as a possible contributing factor this year. Olive Ridley turtles, locally known as ‘Panguni aamaigal’, are crucial to marine ecology and are known for returning to the same beaches where they were

born to lay eggs. Conservation efforts by the forest department have increased since 2013, with hatcheries set up across coastal districts. Official data show that while about 74,000 hatchlings were released during 2016-17, around 2.86 lakh hatchlings had been released up to May this year. Despite intensified coastal surveillance and night patrols by forest staff and volunteers, conservationists have called for stricter regulation of fishing and shipping activity near nesting zones to prevent further losses.

In Buddhism, this is known as the wisdom of emptiness. With steady effort, this wisdom becomes our greatest ally in overcoming disturbing emotions. These emotions, and the traces they leave, act as obstacles, preventing us from fully realising our own potential. By nature, our consciousness is open and capable of vast understanding, but these obstructions veil the mind’s true brilliance. When we succeed in clearing away these clouds, the mind naturally becomes fully awake — this is what we call enlightenment.

It is important to remember that enlightenment is not some distant place or heaven-



ly realm. Rather, it is the natural state of the mind, revealed in its fullest and most positive expression. To reach such a state, we start by working patiently to reduce our negative habits and gradually nurture positive qualities, one by one. Over time, there comes a point when these disturbing emotions no longer trouble us — they simply cannot return.

The Buddha’s teachings were never intended as mere philosophical speculation. Every teaching was meant to help people find practical ways to work with their own minds and emotions. To overcome anger and hatred, for example, the Buddha advised meditating on loving-kindness. To loosen the grip of attachment, he recommended looking at the less attractive aspects of what we desire.

Logical reasoning can also help us realise that our belief in things as solid and permanent is mistaken. Ignorance is the root of such confusion, while the wisdom that realises emptiness is its antidote.

If we understand this, we see that disturbing emotions are only temporary visitors to the mind. They are not our true nature, and they can be completely overcome. When the mind is free from such defilements, its essential qualities — clarity, openness, and awareness — shine through. As our understanding deepens, so does our confidence in the possibility of reaching inner peace, nirvana, and ultimately Buddhahood. This discovery is a source of great joy.

Even if every being in the universe were to turn against you, they could not

truly destroy your peace of mind. Yet a single surge of disturbing emotion can bring great suffering in an instant. This is why, in Buddhist teaching, disturbing emotions are seen as our real enemies — far more dangerous than any outside threat. If we give in to the demands of an ordinary enemy, that person might eventually become a friend. But the more we give in to disturbing emotions, the more they harm us. With human enemies, even if you win a battle, they may return to fight another day. But when you have truly uprooted disturbing emotions with the power of wisdom, they cannot come back. Once you see the true nature of reality with clarity, these emotions dissolve — and vanish like mist in the morning sun.

Governance model of UTs needs a reset



INDIA’S constitutional tapestry is woven out of innumerable threads — threads of history and memory, of law and politics, of compromise and conviction — and one of its most peculiar yet enduring strands is the story of Union Territories (UTs), known at the time of constitutional inception as Chief Commissioner’s provinces. The genesis of this constitutional conundrum traces back to the deliberations of the Constituent Assembly, where four members representing Chief Commissioner’s provinces argued for their rightful place in India’s democratic architecture. KM Munshi, an active member of the Constituent Assembly, moved a resolution on April 30, 1947, for the formation of the Union Constitution Committee (UCC) and the Provincial Model Constitution Committee. CM Poonacha (representing Coorg) proposed that a joint subcommittee of three members should specifically address the issues of the Chief Commissioner’s provinces. His proposal was rejected; instead, the UCC assumed charge of the matter.

The July 21, 1947, report of the UCC, recommended maintaining the status quo — that Chief Commissioner’s provinces continue under Central governance in accordance with the Government of India Act of 1935. Yet, the debate was far from settled. On July 30, 1947, Deshbandhu Gupta (representing Delhi) pressed for a special subcommittee to suggest “suitable constitutional changes to be brought in the administrative system of the Chief Commissioner’s provinces”. His amendment carried the day, and soon after the President of the

Constituent Assembly, Rajendra Prasad, appointed a committee chaired by Pattabhi Sitaramayya. The Sitaramayya Committee’s report, tabled in November 1948, offered a cautious blueprint. It proposed that Delhi, Ajmer-Merwara, Coorg and Panth-Piploda should be designated Lieutenant Governor’s provinces with legislative assemblies and councils of ministers, though subject to overriding Union control. Andaman & Nicobar Islands, strategically sensitive, were to remain under direct Central authority. The report was path-breaking for its time, but tragically, it was never debated. The Drafting Committee quietly side-stepped it. Thereafter, the Assembly’s discussions took a different turn. On November 9, 1948, MBL Bhargava, himself a member of the Sitaramayya panel, remarked that the curbs on autonomy it envisaged were accepted by representatives of these provinces only as an unwilling concession. The Drafting Committee, however, found itself perplexed, as Syed Muhammad Saadulla admitted. His defence of the committee’s position articulated the prevailing hesitancy: how could small enclaves with a few lakh people sustain the apparatus of self-government? If Delhi with a population of 20 lakh was made a separate unit, how could Ajmer-Merwara (10 lakh) or Coorg (less than two lakh) be denied the same? Mahavir Tyagi and Mohan Lal Gautam put it mowre bluntly in August 1949: these territories should remain under Central control temporarily and ultimately be merged with larger states.

From baskets to blink: The year 10-minute delivery became a utility

New Delhi: The era of the ‘delivery day’ ended in 2025 as India’s retail landscape underwent a fundamental transformation, with the great convergence of traditional e-commerce and quick commerce erasing the boundaries between planned shopping and instant gratification. What began as an experimental race to deliver groceries in ten minutes has evolved into a multi-billion-dollar infrastructure play that now moves everything from high-end electronics to white goods in minutes. In a single calendar year, the question for the Indian consumer has permanently shifted from “will it arrive?” to “how many minutes until it does?” As the year draws to a close, the data reflect the sector in hyperdrive. According to a year-end report by RedSeer Strategy Consultants, quick commerce has become India’s fastest-growing retail format, reaching 33 million monthly users across 150+ cities. By 2030, it will command 10 per cent of branded retail sales. Rising house-



hold incomes and a growing preference for convenience have made quick commerce the preferred shopping channel for an increasing share of urban consumers. E-commerce giants Amazon and Flipkart had to launch their own quick commerce arms to not miss out on the massive treasure trove of quick commerce market. The launch of ‘Amazon Now’ and ‘Flipkart Minutes’—both offering sub-30-minute deliveries — signalled that speed is no longer a premium vertical but the industry’s new baseline. Dark stores transitioned from small neighbourhood hubs to megapods. These larger facilities, typi-

cally around 10,000-12,000 sq ft, are now capable of stocking over 50,000 stock-keeping units (SKUs), enabling platforms to deliver iPhones and air conditioners with the same velocity as milk and bread. The sheer scale of the Q-com expansion was best illustrated during the Dhanteras festival, where platforms sold and delivered gold and silver coins within minutes. The year’s financial narrative reached a crescendo in December with Meesho’s Rs 5,421 crore IPO, validating the immense purchasing power of the Tier-2 and Tier-3 value shopper. Zepto is also set to pre-file its draft red herring prospectus

(DRHP) with market regulator Sebi through a confidential route, as it targets a stock market listing sometime in 2026, according to sources. However, the rapid physical expansion of dark stores triggered significant friction within the broader retail ecosystem. Consumer unions intensified calls against regulatory oversight as Q-com began eroding the margins of traditional Kirana stores. This “Kirana Conflict” became a central theme in policy circles, in response to which the Competition Commission of India (CCI) in May notified the regulations for determining the cost of production, a move to help the watchdog more effectively assess alleged predatory pricing and deep discounting practices, especially in the quick commerce and e-commerce segments. Consumer protection regulator CCPA issued notices to several quick commerce companies or violations related to packaged product disclosures mandated under the Legal Metrology Act.

Stock markets gather momentum after muted beginning

Mumbai: Stock market benchmark indices Sensex and Nifty eked out marginal gains in early trade on Monday but later picked up momentum, tracking a firm trend in Asian peers and sustained buying by domestic institutional investors. The 30-share BSE Sensex went up by 22.24 points to 85,063.69 in early trade. The 50-share NSE Nifty eked out a marginal gain of 16 points to 26,058.30. Later, the BSE benchmark traded 105.17 points higher at 85,140.33, and the Nifty quoted 35 points up at 26,080.45. From the 30-Sensex firms, Tata Steel, Eternal, Bharat Electronics, Kotak Mahindra Bank, Trent and Maruti were among the biggest gainers. However, Adani Ports, Power Grid, Bajaj Finserv and Axis Bank were among the laggards. In Asian markets, South Korea’s Kospi, Shanghai’s SSE Composite index and Hong Kong’s Hang Seng



index traded in positive territory, while Japan’s Nikkei 225 index quoted lower. US markets ended on a flat note on Friday. Foreign Institutional Investors (FIIs) offloaded equities worth Rs 317.56 crore on Friday, while Domestic Institutional Investors (DIIs) bought stocks worth Rs 1,772.56

crore, according to exchange data. Brent crude, the global oil benchmark, jumped 1.04 per cent to USD 61.27 per barrel. On Friday, the Sensex dropped 367.25 points or 0.43 per cent to settle at 85,041.45. The Nifty declined by 99.80 points or 0.38 per cent to 26,042.30.

DGCA data shows IndiGo share slide to 63.6pc, Air India climbs



New Delhi: Low-cost airline IndiGo, which faced severe crisis earlier this month, witnessed its domestic market share drop to 63.6 per cent in the month of November, according to latest data from the Directorate General of Civil Aviation (DGCA). The country’s largest airline recorded 65.6 per cent market share in October. Air India Group’s (Air India and Air India Express) market share in November went up to 26.7 per cent, from 25.7 per cent in October. Akasa Air also saw its domestic market

share drop to 4.7 per cent in November from 5.2 per cent in October. “Passengers carried by domestic airlines during January-November 2025 were 1,526.35 lakhs as against 1,464.02 lakhs during the corresponding period of the previous year, thereby registering an annual growth of 4.26 per cent and monthly growth of 6.92 per cent,” as per the DGCA data. The overall cancellation rate of scheduled domestic airlines for the month of November 2025 has been 1.33 per cent. Meanwhile, the

government has granted initial approval to three new airlines to start operations, after the recent chaos in IndiGo operations, which stranded passengers for several days across the country and exposed the abuse of dominance by the largest domestic airline. The civil aviation ministry granted a “no-objection certificate” to regional airlines – Shankh Air, Al Hind Air and FlyExpress. IndiGo was forced to cancel over 4,000 flights earlier this month across major destinations such as Delhi,

Mumbai and Hyderabad and Bengaluru airports, mainly due to crew shortages. The low-cost carrier ran into a severe crew shortage due to the implementation of the second phase of the flight duty time limitations (FDTL) norms, which has stranded planes across airports in the country, with travel schedules of flyers going haywire. The government initiated an inquiry into IndiGo’s mass flight cancellations that stranded thousands of flyers across airports in the country.

Trump says progress made in Ukraine talks but 'thorny issues' remain

Donald Trump and Volodymyr Zelensky said progress had been made to end the Ukraine war during Florida talks but the US leader added "one or two very thorny issues" remained. While both the US and Ukrainian presidents described the talks as "great", Trump reiterated that a key sticking point was the question of territory. Russia has previously demanded that Ukraine hand over more land. Addressing reporters at Mar-a-Lago, Zelensky said they had come to an agreement on "90%" of a 20-point peace plan, while Trump said a security guarantee for Ukraine was "close to 95%" done. Zelensky later said US and Ukrainian teams would meet next week for further talks on issues aimed at ending Russia's nearly four-year war in Ukraine. "We had a substantive conversation on all issues and highly value the progress that the Ukrainian and American teams have made over the past weeks," Zelensky said in



a statement on the Telegram messaging app. Russia launched a full-scale invasion of Ukraine in February 2022, and Moscow currently controls about 20% of Ukrainian territory. A proposal to turn the Donbas region in eastern Ukraine, which Russia largely controls, into a demilitarised zone remains "unresolved", Trump said. "Some of that land has been taken," he

told reporters after the meeting. "Some of that land is maybe up for grabs, but it may be taken over the next period of a number of months." Moscow currently controls about 75% of the Donetsk region, and some 99% of the neighbouring Luhansk. The regions are collectively known as Donbas. Russia wants Ukraine to pull back from the small part of the ter-

ritory it still controls in Donbas, while Kyiv has insisted the area could become a free economic zone policed by Ukrainian forces. The US president has repeatedly changed his own position on Ukraine's lost territories, and in September stunned observers by suggesting that Ukraine might be able to take it back. He later reversed course. "[That] is a very tough

issue," he said. "One that will get resolved." Security guarantees for Ukraine are "95% done", Trump said, without formally committing to logistical support or troop deployment to help protect Ukraine from future attacks. Trump floated the possibility of trilateral talks between the US, Russia, and Ukraine, saying it could happen "at the right time". While the US president is keen to add the Ukraine-Russia war to the list of conflicts he claims to have ended, he cautioned that stalled or scrapped talks that go "really badly" could mean that the war continues. Earlier Trump had a phone call with Russian President Vladimir Putin. While the US president did not offer many details of the phone call, he said he believed the Russian leader "wants Ukraine to succeed". At the same time, Trump acknowledged that Moscow had little interest in a ceasefire that would allow Ukraine to hold a referendum. "I understand

that position," he added. Russian foreign policy adviser Yuri Ushakov said the call was initiated by Trump and that he and Putin discussed the latest EU and Ukraine proposals to end the war. Ushakov, Russia's former US ambassador, said Trump listened to the Kremlin's assessment of the proposals and the two presidents left the call united in their belief that a temporary ceasefire proposed by the EU and Ukraine would instead prolong the conflict. Zelensky suggested the Ukrainian officials could meet at the White House in January, potentially alongside European leaders, as the US and Ukrainian delegations finalise plans for further talks. In a post-meeting call with European allies, European Commission President Ursula von der Leyen hailed "good progress" in the Florida talks while reinforcing the need for Ukraine to receive "ironclad security guarantees from day one".

AN ORPHAN'S BRUTAL MURDER SHINES A SPOTLIGHT ON CHILD ABUSE IN SOMALIA



A woman is currently awaiting execution in Somalia after being convicted of killing a 14-year-old girl in her care. The murder of orphan Saabirin Saylaan in November, and the horrific details that emerged about the circumstances surrounding her death, sparked protests near her home in Galkayo, along with renewed calls for greater child protection. The case touched a deep nerve in a country where child abuse often goes unreported, especially when it occurs inside extended families. For many, Saabirin's death symbolised a broader failure in child protection and the

slow implementation of legal safeguards meant to prevent such tragedies. The conviction of 34-year-old Hodan Mohamud Diiriye for murder marked one of the rare instances in Somalia where a court imposed the ultimate penalty for child abuse. Diiriye had denied the charges and her lawyer has filed an appeal against the verdict. Her husband, Abdiiaziz Nor, 65, was acquitted of murder but sentenced to one year in prison and fined \$500 (£375) for negligence. Saabirin was orphaned when both her parents died within a short period when she was just one year old.

China holds military drills around Taiwan as warning to 'separatist forces'



China is holding military drills around Taiwan simulating the seizure and blockade of the island's key areas, as a warning against "separatist forces". The army, navy, air force and rocket force have been dispatched for the drills which include live-fire exercises, the Chinese military said. Codenamed "Justice Mission 2025", the drills are taking place days after the US announced the sale of one of its largest weapons packages to Taiwan worth \$11bn (£8.2bn). That move drew sharp protest from Beijing which in turn sanctioned US defence firms. Taiwan's push to ramp up its defence this year has also angered Beijing, which claims the self-ruled island as its territory. Taiwan's presidential office has criticised the upcoming Chinese drills, calling them a challenge to international norms. Taiwan's defence ministry said that they detected Chinese aircraft and ships around Taiwan on Monday morning, and have deployed their own forces and missile systems

to monitor the situation. Its forces are on "high alert" to defend Taiwan and "protect our people", the ministry said. In a post on Weibo, the Chinese military's Eastern Theater Command - in charge of the Taiwan Strait - described the upcoming military exercise as a "shield of justice". "All those plotting independence will be annihilated upon encountering the shield!" the post read. While some initial drills have begun, the military said it would conduct a major exercise from 08:00 to 18:00 local time on Tuesday. Beijing's foreign ministry called the drills a "severe punishment for separatist forces seeking independence through force" and warned "external forces" against "using Taiwan to contain China". "Any sinister schemes to obstruct China's reunification are doomed to fail," the ministry's spokesman Lin Jian said at a regular press briefing on Monday. While China has long called for the "peaceful reunification" with Taiwan.

Living in fear of Lakurawa - the militant group Trump targeted in Nigeria strikes



Deep fear has long pervaded the arid savannah plains and highlands of north-western Nigeria - even before the US air strikes on the Islamist militants who have made this area their base on Christmas night. The heavily armed jihadists, who dress in camouflage and wear vibrant turbans, have lived in

camp in Tangaza, a remote area of Sokoto state near the border with Niger, for several years. They belong to a group called Lakurawa and hail from areas north of Nigeria in the Sahel. Locals in Tangaza, a community made up of mainly moderate Muslims, believe they come from Niger and Mali - and are terrified of them.

'There are many challenges': Syrians in Turkey consider return after fall of Assad

The pull of home can be strong - even when it is a place you can't remember. That is how it is for Ahmed, 18. He emerges from a mosque in the heart of Gaziantep in south-east Turkey - not far from the Syrian border - wearing a black T-shirt with "Syria" written on the front. His family fled his homeland when he was five years old, but he is planning to go back in a year or two at most. "I am impatient to get there," he tells me. "I am trying to save money first, because wages in Syria are low." Still, he insists the future will be better there. "Syria will be rebuilt and it will be like gold," he says. If he goes back, he will be following in the footsteps of more than half a million Syrians who



have left Turkey since the ousting of Syria's long-time dictator, Bashar al-Assad, in December 2024. Many had been here since 2011, when civil war began devouring their country. In the years that followed, Turkey became a safe haven, taking in more Syrians than any other country. The number reached 3.5 million at its

peak, causing political tension and - on occasion - xenophobic attacks. Officially, no Syrian will be forced to go, but some feel they are being pushed - by bureaucratic changes, and by a waning welcome. Civil society organisations "are getting the message from the authorities that it's time to go", says a Syrian woman who did not want to be

named. "I have a lot of good Turkish friends. Even they and my neighbours have asked why I am still here. Of course we will go back, but in an organised way. If we all go back together, it will be chaos." Aya Mustafa, 32, is eager to leave - but not yet. We meet under a winter sun by the stone walls of a castle, which has towered over Gaziantep since the Byzantine era. Her hometown, Aleppo, is less than two hours' drive away. She says going back is a constant topic of conversation in the Syrian community. "Every day, every hour, we speak about this point," says Aya, whose family were lawyers and teachers back home, but had to start again in Turkey, baking and hairdressing to earn a living.

MEXICO TRAIN CRASH KILLS 13 AND INJURES ALMOST 100



At least 13 people died and almost 100 were injured after a train derailed in Mexico's south-eastern Oaxaca region, the Mexican navy said. The train, which was travelling between the Gulf of Mexico and the Pacific Ocean, was carrying 241 passengers and nine crew members. A total of 98 were injured, of whom 36 were being treated in hospital, the navy said. The train derailed as it rounded a bend near the town of Nizanda, officials said. Mexico's Attorney General confirmed an investigation was under way. Mexican President Claudia Sheinbaum said five of those injured were in a seri-

ous condition. She said top level officials, including the Secretary of the Navy, were travelling to the site of the crash. Photos from the site of the crash showed rescue workers helping passengers alight the train, which had fallen off the rail tracks and partly tilted over the side of

a cliff. The Interoceanic train, which connects the Pacific port of Salina Cruz with Coatzacoalcas on the Gulf Coast, had two locomotives and four passenger cars, the navy said. Mexico's navy operates the country's railway network. The Governor of Oaxaca

Salomón Jara Cruz expressed "deep regret" over the accident in a statement and said state authorities were coordinating with federal agencies to assist those affected. The Interoceanic rail link was inaugurated two years ago to boost the region's economy, an initiative spearheaded by former president Andrés Manuel López Obrador. Designed to modernise the rail link across the Isthmus of Tehuantepec, the Mexican government has sought to develop the area into a strategic trade corridor, expanding ports, railways and industrial infrastructure.

Kosovo's ruling party wins election after months of political deadlock



The Albanian nationalist Vetevendosje party has won a landslide victory in Kosovo's parliamentary elections, according to preliminary results. With 90% of the votes counted, the party, whose name means "self determination", was on 50.8%, meaning a third term in power for its leader, Albin Kurti. The two main opposition parties, the centre-right Democratic Party of Kosovo (PDK) and the Democratic League of Kosovo (LDK), were on 20.98% and 13.89%, respectively. Vetevendosje won elections in February, but without a majority, and Kosovo has been without a functioning government since then. The impasse meant there was one big question hanging over this second parliamentary election of the year. Would voters punish Kurti for the long months of deadlock in the country's National Assembly - or the opposition parties who refused

to countenance a coalition with Kurti's left-wing movement? The electorate has given a clear answer. This will not be quite enough to deliver enough seats for Kurti to govern without coalition partners. But he should not find it difficult to find support among the MPs from the ethnic minority parties who are guaranteed 20 of the 120 seats in the National Assembly. It is the fourth successive victory in parliamentary elections for Vetevendosje. The result is vindication after the opposition parties blocked his attempts to form a government following the previous polls on February 9. Kurti claimed it was "the greatest victory in the history of the country" - and said he expected opposition parties to cooperate, rather than frustrate, this time around. Arben Gashi, of the third-placed Democratic League of Kosovo (LDK), indicated that could be possible.

Bondi hero says he wanted to stop gunman killing innocent people

The man who disarmed one of the gunmen who killed 15 people at a Jewish event at Bondi Beach has revealed his thoughts in the moments before his heroic actions. In verified footage, Ahmed al Ahmed - a Sydney shop owner born and raised in Syria - tackled one of the two shooters from behind, wrestling a long-arm gun from him. "I hold him with my right hand and start saying a word, you know, like to warn him - 'drop your gun, stop doing what you're doing,'" the father-of-two told the BBC's US partner CBS News in an exclusive interview. Mr Ahmed, who was shot several times by the other alleged gunman, said his actions saved "lots

of people... but I feel sorry still for the lost." In the interview, Mr Ahmed recalled the moment he tackled Sajid Akram, 50, who was shooting attendees at a Hanukkah event at Bondi Beach on Sunday 14 December. "My target was just to take the gun from him, and to stop him from killing a human being's life and not killing innocent people." Fifteen people died during the attack - Australia's deadliest mass shooting since 1996 - and 40 others were injured. Police have declared the attack a terrorist incident targeting the Jewish community. Sajid Akram was shot dead by police while his son Naveed, the other alleged

gunman who was hospitalised after the attack, has since been charged with 59 offences including 15 counts of murder and one of committing a terrorist attack. Mr Ahmed described the inner thoughts running through his head in the lead-up to his actions, which authorities and politicians have said saved countless lives. "Emotionally, I'm doing something, which is I feel something, a power in my body, my brain," Mr Ahmed said. "I don't want to see people killed in front of me, I don't want to see blood, I don't want to hear his gun. I don't want to see people screaming and begging, asking for help. "That's my soul asking me to do that.

Three killed in Sweden as major storm sweeps across Nordic countries

A third person has died in Sweden after a powerful winter storm swept across Nordic countries, causing travel disruption and power outages. Sweden's meteorological agency issued alerts for strong winds for large parts of the northern half of the country as Storm Johannes hit. One man in his 50s died after being struck by a tree at the Kungsberget ski resort in the country's south, local media and police reported. Further north, regional utility company Hemab said one of its employees died in an accident while out working. Police also said a man in his 60s was taken to hospital after being hit by a tree while working in a forest in Hofors, east-central



Sweden, and later died of his injuries. Tens of thousands of homes in Sweden, Norway and Finland have been left without power as a result of the storm. In Sweden, more than 40,000 homes were affected by power outages and numerous rail services were cancelled, Swedish news agency TT reported. Several flights, rail and

ferry services across parts of the Nordic nations have been cancelled. Roads and rail services have also been disrupted due to the storm conditions. In Norway's Nordland region, one of the most northerly counties in the country, the fire department responded to more than 200 weather-related incidents, broadcaster NRK reported.

Affordale Fury wins Savills Chase at Leopardstown

Affordale Fury delivered a first Grade One winner for County Down owner Philip Polly in a thrilling Savills Chase at Leopardstown on Sunday. Trained by Noel Meade, the seven-year-old started and finished the three-mile race in fine form to tear up the script. Much of the pre-race narrative focused on a rematch of March's Cheltenham Gold Cup when Inotherwayurthinkin denied Galopin Des Champs a third-straight win, but that duel failed to materialise this time. Instead, it was those in red and black celebrating as Sam Ewing guided Affordale Fury (7-1) to a big win. "I can't believe it - what a week we've had," a delighted Polly told RTE Sport. "We won the Bumper on Boxing Day and now we've rocked up and won the Savills." Champ Kiely was an early faller on the flat as Affordale Fury got out in front of what was a



bunched field. It remained wide open heading into the final two hurdles when favourite Galopin Des Champs made a move. However, the Willie Mullins-trained favourite had to settle for third as Affordale Fury responded brilliantly to surge home from 2024

Grand National winner I Am Maximus in second (50-1). It capped a superb two days for Ewing, who was onboard Favori De Champdou and Solness for Grade One wins on Saturday. "I wanted to be good and positive going into the first and see where we

landed," said Ewing. "He travelled really strong, winged fences for sport and there was no coming back from it. He was gutsy and is a proper horse in the making." The Christmas Hurdle went to second favourite Teahupo (5-2), who produced a strong finish to turn the

tables on Bob Olinger (11-1) from their meeting at Cheltenham in March. It ensured another Grade One win for trainer Gordon Elliott, who had two big wins as part of a four-timer at Leopardstown on Saturday. Rocky's Diamond made the early running, opening a gap on the chasing pack which was led by Ballyburn, and maintained the advantage until the second hurdle from last as Teahupo, ridden by Jack Kennedy, jumped into the lead. There was no looking back despite a challenge from Henry de Bromhead's Bob Olinger, with race favourite Ballyburn (13-8) placing third. "When we jumped the front at the second last and I got him onto the straight, he did fairly well," said Kennedy. "He has been some horse to me and everyone who is involved with him - it's hard to get ones like him."

Gautam Gambhir Told To 'Become Ranji Trophy Coach' In Sensational Verdict By Ex-England Star

Former England spinner Monty Panesar has suggested that Gautam Gambhir should coach a Ranji Trophy team to better understand red-ball cricket. Panesar noted that while Gambhir is a successful white-ball coach, a stint with a Ranji team would allow him to consult with other coaches and learn how to build a squad for the longest format. These comments follow reports that the BCCI approached Indian legend VVS Laxman to potentially take over as the Test head coach. India recently suffered a difficult Test series loss against South Africa-a result that has brought significant criticism toward Gambhir. "Gautam Gambhir is a good coach in white-ball cricket because he has been successful. However, he could benefit from becoming a Ranji Trophy coach; he should talk to those who have coached in the Ranji Trophy about how to build a team in red-ball cricket. Right now, the Indian team is weak in Test

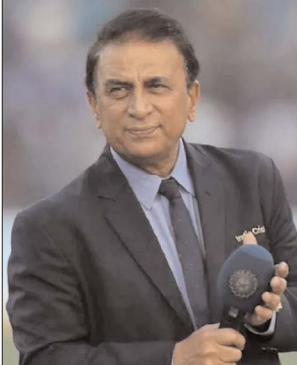


cricket. This is the reality. It will take time. When you retire three big players, it becomes difficult to keep the remaining players ready," Panesar said in an interview with ANI. Panesar also characterized India's Test captain, Shubman Gill, as a "complacent" cricketer, suggesting he may not be ready to lead or play in all formats internationally. While hailing Gill's talent, Panesar noted that he often plays "lazy shots" during matches.

He contrasted this with Virat Kohli, whose intensity and aggression remain evident across all formats-qualities Panesar believes Gill currently lacks. "He is a complacent cricketer. He has a lot of talent, but he starts playing lazy shots. Virat Kohli's intensity and aggression are evident in all formats, but Shubman Gill can't replicate that. It is too much of a burden for him; he can't be the captain across all formats," Panesar added.

Sunil Gavaskar Takes Brutal Dig At Ashes Pitch With "Horrible Groundsmen In India" Remark

The Australia vs England Boxing Day Test at the Melbourne Cricket Ground (MCG) ended in just two days. A total of 36 wickets fell across six sessions in the game that saw the Three Lions end their 18-Test and 15-year winless streak in Australia. The pitch, which had 10 mm of grass left on it, aided the pacers throughout the two days of play. There was enough swing and seam movement for the fast bowlers as batters from both teams haplessly fought for survival. "Another Test match in Australia has finished in less than two days of cricket. The Australian Cricket Board's CEO says it is not good business and most, if



not all, cricket fans in the sub-continent (read India) are screaming blue murder about the quality of the pitch given in Melbourne. They were astonished when the first Test match pitch in Perth was given a very good rating by the match referee Ranjan Madugalle," India great



Sunil Gavaskar wrote in his column for Sportstar. The Perth Test between Australia and England also ended in two days, but the pitch was graded "very good" by ICC match referee Ranjan Madugalle. Taking a sarcastic jibe, Gavaskar said, "Since there is a new match referee, Jeff Crowe,

for the Melbourne and Sydney Test matches, the rating could be different. Since 36 wickets fell in the Melbourne Test instead of 32 in Perth, Crowe might drop the word 'very' from the 'very good' that Madugalle gave for the Perth pitch and rate the MCG pitch as good. Surprises never cease, of course, so we may get another rating." "The curators, or as we found out about the person in charge at the MCG, the Director of Turf, may make a human error and get it slightly wrong, but they are not as devious as those 'horrible groundsmen' in India who do not even prepare a pitch and expect the batters to score runs on them.

Virat Kohli, Rohit Sharma Not Playing In Vijay Hazare Trophy 3rd Round - This Is The Reason

Virat Kohli and Rohit Sharma did not feature for Delhi and Mumbai, respectively, in the third round of the Vijay Hazare Trophy on Monday. While Delhi faced Saurashtra at the Karnataka Cricket Association (KSCA) Stadium in Alur, Mumbai took on Chhattisgarh at the Jaipuria Vidyalaya Ground in Jaipur. Virat and Rohit were originally scheduled to play only two matches in the competition and have now fulfilled those commitments. The two star batters will feature in the ODI series against



New Zealand starting January 11 and are expected to join the national camp soon. Virat slammed 131 and 77 in his two matches for Delhi, while Rohit made a brilliant start to the campaign with a massive 155 before scoring a golden duck against Uttarakhand. According to a report by

Cricbuzz, Kohli will play one more match for Delhi, as he is expected to feature in the game against Railways on January 6. However, the report added that Rohit will not play any further part in the competition for Mumbai. Meanwhile, Jasprit Bumrah and Hardik

Pandya are likely to be rested for the upcoming ODI series against New Zealand. The report claimed that this decision was taken with more important assignments in mind, particularly the 2026 T20 World Cup. PCB Chief Mohsin Naqvi Gives Blunt Take On India's 'No-Handshake' Policy Against Pakistan



Pakistan Cricket Board (PCB) chief Mohsin Naqvi has opened up regarding India's "no-handshake" policy, stating that Pakistan is fine with not reciprocating gestures if the Board of Control for Cricket in India (BCCI) continues its current stance. Since the Asia Cup in September, both the Indian men's and women's teams have refused to shake hands with their Pakistani counterparts during international matches. This gesture is reportedly a show of solidarity with the victims of the Pahalgam terror attack. India maintained this stance most recently during the U19 Asia Cup earlier this month. Speaking to reporters in Lahore, Naqvi-who also serves as the Interior Minister of Pakistan-clarified that the PCB has no intention of forcing handshakes or other formal gestures with India. "Our belief remains the same even today, and believe me, the Prime Minister himself has told me twice that we shouldn't let politics come into all of this.

From day one, our stance has been that cricket and politics should remain separate. On that day, Sarfaraz must have told you what kind of attitude was shown, and what it was like," said Naqvi. Naqvi suggested that while Pakistan will respect whichever path India chooses to take, they will compete with their neighbors on an equal basis. "If they don't want to shake hands, then we have no particular desire to do so either. Whatever happens, it will happen on an equal footing with India. And you will see, this approach will continue going forward. It's not possible for them to do one thing and for us to back down - that simply won't happen," he added. Hostilities between the two nations have reached a peak following the Pahalgam terror attack, where 26 Indian tourists were killed by Pakistan-backed terrorists. In response, India launched a military campaign titled 'Operation Sindoor' aimed at dismantling terror infrastructure across the border.

A source tracking Iyer's recovery said if all goes well and clearance from the CoE is granted, Iyer could play for Mumbai in the Vijay Hazare Trophy matches in Jaipur on January 3 and 6, respectively. It will be interesting to see if the Ajit Agarkar-led selection committee picks Iyer for the three ODIs against New Zealand, starting in Vadodara on January 11. The selection panel is set to meet in the first week of January.

Heaven will not switch from England to Ghana



Manchester United defender Ayden Heaven will not switch allegiance from England to Ghana to play in next summer's World Cup. London-born Heaven, 19, qualifies for Ghana through a grandparent and the Ghana FA has been monitoring his development. Ghana have been drawn in the same group as England, Croatia and Panama for the World Cup in the US, Canada and Mexico. Sources have told BBC Sport that Heaven, who joined United from Arsenal in February after making one appearance for the Gunners, wants to represent England at senior level. Heaven has played for England at various age groups. He suffered an ankle injury playing for the Under-20s against Switzerland in October, was replaced at half-time and was not selected for November's match against Japan. Heaven made two substi-

tute appearances for United in the Premier League this season before starting against West Ham on 4 December in the centre of a three-man defence. He was booked after eight minutes and taken off at half-time, but has started all four matches since and improved significantly in each. He was excellent in the 2-1 defeat at Aston Villa on 21 December and was man of the match in the 1-0 victory over Newcastle on Friday, when United kept only their second clean sheet of the season. Manager Ruben Amorim said: "I am really pleased with Ayden. You can feel that he is improving every game. "He is young, but you can feel that he has a good game, slows the thinking and improves during the game. "He trained really well and, if he continues to play like that, it is going to be really hard to take his place."
