The Anglo-Indian community in Lalaguda in Secunderabad celebrated Christmas with enthusiasm and in a traditional manner. In Little England, as Lalaguda is known, the community cele-

brates the festival in their unique style. Cake and wine making at home is an integral part of the celebrations for the community. Attired in their best, men, women and children attended the midnight services in specially decorated churches. Christian families cut the cakes as part of

Top Maoist Ganesh Uike, carrying Rs.1.1 cr bounty, killed in Odisha gunfight

Ganesh Uike, 69, CPI (Maoist) central committee member and the outfit's Odisha chief, was among six rebels shot dead in back-to-back gun battles with security forces in Kandhamal district, police said on Thursday.Two guerrillas from Chhattisgarh were killed in the Gumma forest late Wednesday; Uike and three others—two of them women—died in fresh fire-fights near Chakapad on Thursday morning. No policeman was hurt.Union Home Minister Amit Shah called the operation a "major breakthrough" and reiterated the Centre's target of making India Naxal-free by 31 March 2026. Odisha Chief Minister Mohan Charan Majhi hailed it as "a remarkable success" that has "broken the Maoist backbone" in the state. DGP Y. B. Khurania said 23 elite teams—20 from the state's Special Operations Group and three from CRPF/BSF—had fanned out along the Kandhamal-Ganjam border after specific intelligence. Two INSAS rifles and a .303 rifle were recovered from the encounter site. Uike, a native of Nalgonda district in Telangana, carried a Rs.1.1 crore reward, while the two slain cadres from Chhattisgarh carried a combined bounty of Rs.23.65 lakh. The killings came two days after 22 lower-rung Maoists surrendered in neighbouring Malkangiri. Police have renewed appeals for rebels to avail the state's "most liberal" surrender-and-rehabilitation package.

Vajpayee made India a nuclear power, says CM Naidu

Amaravati (TSIT)

Andhra Pradesh Chief Minister N. Chandrababu Naidu on Thursday unveiled a life-size statue of former Prime Minister Atal Bihari Vajpayee at Venkatapalem and declared that the poet-statesman's "vision and resolve" turned India into a nuclear power and placed the country on the world's strategic map.

Addressing a large Good Governance Day rally, Naidu said Vajpayee's 1998 Pokhran tests "showed the world our scientific muscle", while his decisive stance during the Kargil conflict "set the template" for the recent Operation Sindoor.

The bronze statue—erected inside the upcoming Vajpayee Smriti Vanam memorial garden—was jointly unveiled with Union Minister

Shivraj Singh Chouhan. A photo exhibition tracing Vajpayee's journey from Jan Sangh founder to three-term PM was opened on the sidelines.

Naidu recalled his personal rapport with Vajpayee, citing the Golden Quadrilateral, telecom de-regulation and the Cyberabad (Hyderabad IT corridor) foundation stone as proj-

ects that "still power India's growth".

The BJP-TDP-Jana Sena alliance plans similar statues in all 26 district headquarters; the yatra, named "Atal-Modi Good Governance Yatra", will cover the state over the next fortnight. The Chief Minister reaffirmed that Amaravati would be shaped into a "quantum-ready global city" as a tribute to Vajpayee's infrastructure legacy.

KARNATAKA BUS FIRE: Death toll rises to six, most victims burnt alive

Flames and smoke billow out after a bus caught fire following a collision with a speeding truck, in Chitradurga, early Thursday,

Chitradurga, Karnataka (TSIT)

A luxury sleeper coach carrying 32 people became a burning death-trap on National Highway-48 early Thursday after a speeding container truck vaulted the median and slammed head-on into its diesel tank, triggering a blaze that killed six occupants, among them a small child.

The truck driver died instantly; five bus passengers—trapped inside as flames swept through the cabin—were burnt beyond recognition. "The fire spread so fast most victims had no time to escape," said East Zone Inspector-General Ravikanth Gowda, revising an earlier toll of nine to six after forensic teams counted remains.

Driver Rafiq, admitted to hospital with severe burns,

recalled steering at 60-70 km/h when the lorry "came flying over the divider". Cleaner Mohammed Sadiq, flung through the windshield on impact, said: "I woke up mid-air, then everything was fire."Miraculously, 26 passengers survived; nine are being treated in Sirsa, three in Tumakuru and one critically-burned woman was shifted to Victoria Hospital, Bengaluru.

Three friends who jumped from a rear window, and two others who crawled through broken glass, escaped with minor injuries.Behind the ill-fated bus, a school vehicle carrying 42 children swerved, clipped the burning coach and skidded off the road, but none of the students was hurt.

Another Hindu lynched as Zia's son returns to Bangladesh after 17 yrs

New Delhi (TSIT)

Local media reported that Amrit Mondal, alias Samrat (29), a member of the Hindu minority community, was beaten to death by a mob late on Wednesday night in Pangsha Upazila of Rajbari district. The killing adds to a growing list of mob violence incidents amid a volatile political climate and sustained unrest following last year's collapse of the Sheikh Hasina government.

The Bharatiya Janata Party (BJP), meanwhile, seized on the incident to attack West Bengal Chief Minister Mamata Banerjee. "Another Hindu has been lynched in Bangladesh. No wonder Mamata Banerjee opposes the CAA, which gives citizenship to Hindus who face persecution in Bangladesh, and also opposes the SIR, which would remove her Bangladeshi and Rohingya vote bank," the West Bengal BJP posted on X.

According to the Dhaka Tribune, the incident occurred around 11 pm at the Hossaindanga Old Market area when locals allegedly assaulted Mondal after accusations of extortion. Pangsha Model police station officer-in-charge

He had allegedly fled to India during the Awami League regime and returned recently.

A fresh lynching of a Hindu man in Bangladesh has sharpened concerns over minority safety in the country, the killing coming just a day ahead of the high-profile return of Bangladesh Nationalist Party (BNP) acting chairman and former PM Khaleda Zia's son Tarique Rahman after more than 17 years in self-exile.

Sheikh Moinul Islam confirmed the death, stating that the body had been recovered and sent for autopsy.

The media report quoting the police and locals claimed Mondal headed a local criminal outfit known as "Samrat Bahini" and was named in multiple cases, including murder.

was beaten to death over an alleged blasphemy accusation, further fuelling fears among minority communities.The incidents are unfolding against the backdrop of widespread protests and political instability following the killing of Sharif Osman Hadi, a prominent figure of last year's mass agitation that

led to the fall of the Hasina government. Hadi's death has also triggered renewed diplomatic strain between India and Bangladesh.

India on Tuesday sought a thorough and transparent investigation into Hadi's killing, rejecting unsubstantiated allegations of an Indian hand in the incidents that have stoked anti-India sentiment in Bangladesh. New Delhi has repeatedly flagged concerns over attacks on minorities, particularly Hindus, under the interim government led by Muhammad Yunus.In another development, the Bangladesh police announced a reward for information on attackers who had set on fire a Hindu-owned house near the south-eastern port city of Chattogram. According to reports, unidentified miscreants set the home on fire on Tuesday night, but the residents managed to come out of the house unharmed.

Attack on minorities unacceptable: CM Stalin

Tamil Nadu Chief Minister MK Stalin on Thursday asserted that attacks on minorities are unacceptable and said curbing riotous groups is a shared and urgent duty to be enforced with firm resolve.

Stalin said the true strength and character of the majority people lies in ensuring that minorities lived without fear.

"When a few right-wing violent groups, acting in

the name of the majority, indulge in attacks and riots, even as the Prime Minister participates in Christmas celebrations, it sends a disturbing message to the nation," he said in a social media post. After Manipur, alleged "reports of attacks on minorities" in Jabalpur, Raipur, and elsewhere are unacceptable to anyone who values harmony.

Telangana to experience minimum temperatures of 3-4°C over next two days: Met

## Punjab CM approves cashless treatment of Rs 10 lakh to every family

Chandigarh, Dec 25 : In a New Year bonanza for residents, Punjab Chief Minister Bhagwant Mann on Thursday gave the green signal to the Health Department to launch Mukh Mantri Sehat Yojna from January to enable cashless treatment of Rs 10 lakh to every family in the state.

Reviewing a meeting of the Health Department here, CM Mann said Mukh Mantri Sehat Beema Yojna is a step towards providing universal healthcare facilities to people without spending even a penny on it. “This is a step towards providing universal healthcare and ensuring that people get cashless treatment of Rs 10 lakh. Punjab will be the first state in the country where every family



will be entitled to cashless treatment of up to Rs 10 lakh,” he said.

The Chief Minister said the yojna is a flagship health assurance initiative of the government aimed at providing financial protection and assured access to quality healthcare to all eligible residents of the state.

“The scheme is a major step towards universal health coverage, under

which each enrolled family is entitled to cashless medical treatment up to Rs 10 lakh per year,” he added.

CM Mann said, “The scheme covers major illnesses, critical care, surgeries, and life-saving treatments at a wide network of empanelled government and private hospitals across Punjab and Chandigarh, ensuring equitable access to

healthcare services.”

The key objective is to ensure cashless and paperless healthcare at empanelled hospitals and to reduce out-of-pocket expenditure on secondary and tertiary healthcare. “Likewise, it will strengthen equitable access to healthcare services across urban and rural areas and provide timely grievance redressal and beneficiary support through digital platforms,” the Chief Minister said.

He said all the expenses like hospitalisation costs, surgeries and medical procedures, ICU and critical care services, diagnostics, medicines, and consumables as per approved packages, pre- and post-hospitalisation expenses and others will be covered under it.

## Delhi’s air quality improves slightly, several areas record ‘moderate’ AQI

New Delhi, Dec 25 : Delhi’s air quality recorded a noticeable improvement on Thursday morning, a day after the Commission for Air Quality Management in Delhi-NCR and adjoining areas revoked restrictions imposed under Stage IV of the Graded Response Action Plan, citing a sustained improvement in pollution levels.

Although the city’s overall air quality continued to remain in the ‘poor’ category with an average Air Quality Index of 221, several locations across Delhi and the National Capital Region registered better readings, falling into the ‘moderate’ category.

This marks a significant shift after weeks of ‘very poor’ to ‘severe’ air quality levels across large parts of the region. As per the AQI classification, readings between 0 and 50 are considered ‘good’, 51 to 100 ‘satisfactory’, 101 to 200 ‘moderate’, 201 to 300 ‘poor’, 301 to 400 ‘very poor’ and 401 to 500 ‘severe’. On Thursday morning, the AQI at India Gate and Kartavya Path

stood at 350, while Akshardham recorded a reading of 245. Sir Aurobindo Marg saw an AQI of 159, IGI Airport reported 119, and Lodhi Road recorded 133, indicating improved air quality conditions in several key areas of the city.

Despite the improvement in pollution levels, a fog warning remains in effect for Delhi and surrounding regions during the morning hours. The India Meteorological Department has forecast a very high probability of dense to very dense fog on Thursday morning across Haryana, Chandigarh, Delhi, Himachal Pradesh, the Jammu region, Punjab, Uttar Pradesh and Uttarakhand.

The weather agency also issued a similar warning for isolated locations in Assam, Meghalaya, Bihar, East Madhya Pradesh, Nagaland, Manipur, Mizoram and Tripura, as well as Odisha, West Bengal and Sikkim, indicating widespread foggy conditions across multiple states.

## Tickets sale for Chennai leg of Hockey India league begins

New Delhi: Tickets for the forthcoming men’s Hockey India League (HIL) 2025-26 in Chennai, starting January 3, went live on Thursday. Hockey India has decided to make tickets free of cost to encourage more fans to attend matches. The Women’s HIL begins on December 28 in Ranchi and ends on January 10, while the Men’s HIL begins on January 3 in Chennai, moves to Ranchi from January 11, and the final leg is held in the cradle of hockey – Bhubaneswar – from January 17 to January 26.

This year’s Hockey India League will showcase an impressive roster of eight men’s and four women’s teams, with both leagues offering fast-paced, exciting games through their newly revamped formats.

The ticket sales for the HIL’s Ranchi leg went live on Monday. As in the previous edition, Hockey India’s endeavour is to take the sport to every corner of the country and make it more accessible to its passionate fans. Hockey India League (HIL) governing committee chairperson Dilip Tirkey had said, “We have once again decided to offer free tickets for hockey fans to come and enjoy all the matches across Chennai, Ranchi and Bhubaneswar. ## Union Budget 2026-27: CII outlines 4-point strategy for macroeconomic stability

New Delhi, Dec 25 : Apex business chamber CII on Thursday proposed a four-pronged fiscal strategy ahead of the Union Budget 2026-27 that includes debt stability, fiscal transparency, revenue mobilisation and expenditure efficiency.

According to a CII statement, at the core of the roadmap is adherence to the government’s debt glide path targeting 50 per cent (plus or minus 1 per cent) of GDP by FY31. Maintaining Central debt at roughly 54.5 per cent of GDP and the fiscal deficit at 4.2 per cent of GDP in FY27 will preserve macro credibility while supporting growth.

Strengthening public finances, however, must extend beyond the Centre to States and Urban Local Bodies (ULBs), whose fiscal positions increasingly shape overall debt dynamics and the durability of macroeconomic stability. Second, to improve predictability and reinforce institutional credibility, CII recommends reviving the Medium-Term Fiscal Framework with a rolling 3-5 year roadmap for revenue, expenditure and debt.

Third, revenue mobilisation remains central to long-term fiscal sustainability. India’s tax-to-GDP ratio at 17.5 per



cent (centre and state combined) remains below that of major emerging economies.

“To finance the developmental needs of the country, India needs to increase its tax-GDP

ratio. Leveraging the data from India’s world-class digital infrastructure could help detect tax evasion and expand tax base,” CII director general Chandrajit Banerjee said.

Greater use of digital and AI-based tools should be leveraged to expand the tax base through seamless data exchange between GST, income tax, and digital payment systems. Linking tax returns with high-value transactions and deploying advanced analytics can enable real-time detection of evasion while lowering compliance costs, the statement said.

To unlock value from public assets, government should announce a three-year privatisation pipeline of Public Sector Enterprises (PSEs) in the non-strategic sectors as announced in the ‘Strategic

Disinvestment Policy, CII further stated.

Fourth, expenditure management, particularly subsidy reform, forms the other pillar of the strategy. Public Distribution System (PDS), covering 813 million people or 57 per cent of the population, faces challenges of outdated data and leakages. Updating beneficiary lists using the latest Household Consumption Expenditure Survey (2023-24), narrowing coverage to the bottom 15 per cent, and shifting towards cash or voucher-based transfers can enhance efficiency while also promoting dietary diversification, the statement said.

“They continued their trip in a replacement bus; the driver will be a key witness,” Gowda added.Prime Minister Narendra Modi and Chief Minister Siddaramaiah announced ex-gratia payments of Rs 2 lakh and Rs 5 lakh respectively to the families of the dead, plus Rs 50,000 for the injured. DNA testing is under way to identify charred bodies, while police trace online ticket bookings to notify next of kin. The highway was closed for eight hours as firefighters doused flames that melted the bus into a skeletal heap of twisted metal and scattered belongings. Officers say the container truck, travelling from Hubballi to Bengaluru, will undergo mechanical inspection to determine whether brake failure or driver fatigue caused the fatal leap across the median.

## Bengal: Child mistakes crude bomb for ball, injured in explosion

Kolkata: A child was seriously injured in a crude bomb explosion after he mistook it for a ball, said the police on Thursday. The incident occurred in the Basanti area in West Bengal’s South 24 Parganas district late Wednesday night. The child has been brought to Kolkata and admitted to a hospital where he is receiving treatment. His condition is said to be serious. The police have launched an investigation to find out the source of the bomb and how it was left in the area. According to the police, the incident occurred in the Kharimachhan area under the Amjhara Gram Panchayat area of Basanti block. Local residents said the child was playing inside an abandoned house when suddenly, the sound of an explosion was heard.

People who were near the house rushed to the scene and found the child lying injured. However, it is still not clear how the crude bomb ended up inside the abandoned house.

Officers from Basanti police station arrived at the scene after being informed and started an investigation. Sources said there were fragments of the exploded bomb everywhere inside the house. The area has been cordoned off. The house was examined by the forensic teams, which arrived at the scene in the morning.

A police picket was set up in the area after the incident. A senior officer of Baruipur Police District said, “A child was injured after he mistook a crude bomb for a ball. As he was playing with the bomb, it exploded. The injured child has been taken to a private hospital in Kolkata for treatment. The child was seriously injured. We have started an investigation into the matter and are trying to ascertain how the crude bomb ended up in that abandoned house. Forensic team members are examining the scene of the explosion and taking evidence. The locals are being questioned for further information.”

## Confident in securing majority whenever Assembly polls are held: Karnataka BJP

Bengaluru, Dec 25 : The Karnataka BJP has stated that it is confident of attaining a majority whenever Assembly polls are held in the state, as public anger is rising against the Congress-led government in the state.

BJP state president and MLA B.Y. Vijayendra made the statement in this regard while speaking at the 101st birth anniversary programme of former Prime Minister and Bharat Ratna awardee Atal Bihari Vajpayee, held on Thursday at the party’s state office, Jagannath Bhavan, in Bengaluru.



He added that the deteriorating condition of the Congress party was evident from the recent town panchayat election results in the state. “Whether it is EVMs or ballot papers, the fate of the Congress party will not change,” he asserted.He said the BJP

has been blessed with the leadership of stalwarts like Atal Bihari Vajpayee and L.K. Advani, and that under the leadership of Prime Minister Narendra Modi, Amit Shah and J.P. Nadda, the BJP is steadily advancing. He also expressed confidence that

the BJP would come to power in West Bengal.

Vijayendra said the BJP was currently in the opposition due to its own shortcomings and that party workers need not be anxious.

He alleged that public anger was rising against the anti-people and anti-poor Congress government in Karnataka. “Whether elections are held in 2028 or even tomorrow, the BJP will come to power in Karnataka with a clear majority of 130-140 MLAs on its own strength. We must all work to strengthen the party,” he said.

## Dense morning fog likely across TN till Dec 28; light rain forecast for coastal, northern regions

Chennai, Dec 25 : The Regional Meteorological Centre has issued a weather advisory warning that dense morning fog is likely to persist across several parts of Tamil Nadu till December 28. In a statement, the India Meteorological Department (IMD), Chennai, said that foggy conditions are expected during the early morning hours over large parts of the state for the next three days, potentially affecting visibility and early-day travel.

Alongside the fog warning, the IMD has forecast light to moderate rainfall at isolated places in

coastal areas, north Tamil Nadu, and parts of Puducherry and Karaikal over the next three days. The rainfall is expected to be scattered, with one or two locations in these regions likely to receive short spells of precipitation, mainly under cloudy conditions.

The weather department attributed the prevailing conditions to seasonal atmospheric changes and moisture accumulation over the Bay of Bengal, which are contributing to cloud formation, intermittent rainfall, and reduced visibility during early morning hours.

## What exactly is Tarique Rahman’s ‘plan’ for Bangladesh and its people?

New Delhi, Dec 25 : Bangladesh Nationalist Party (BNP) Acting Chairman Tarique Rahman has a plan, he told his countrymen on Thursday, December 25, in Dhaka, but did not deal much with its details.

Both the parents of the 60-year-old BNP leader had stints as head of government at different times. While his father Ziaur Rahman was the sixth President of Bangladesh from 1977 until his assassination in 1981, Tarique’s mother was the first female Prime Minister to hold office between 1991-1996, and again, from 2001 to 2006. Given that history, together with the fact that he has returned a little ahead of Bangladesh’s high-stakes February general election, the content had to be political. However, he

kept short of projecting himself as the prospective premier in his short speech, though highlighting his family’s legacy on occasions.

However, his return after a 17-year hiatus signals BNP’s intent to reclaim leadership and mobilise mass support. He spoke of a country where there will be peace, security, and unity, where the current volatility has posed a major threat to law and order and to life itself.

“I have a plan for the people of my country; for my country,” he stated in English, in between a speech in clipped Bengali – unlike the regular, local conversational tone – that may be the result of a long 17 years in exile in the United Kingdom.

That plan is yet to be elaborated, and it will only be known later



whether it will be holistic and include opponents and critics. BNP’s principal Opposition party, Awami League, remains excluded from the 2026 elections; its main challenger, Sheikh Hasina, has taken refuge in neighbouring India.

Tarique should know; he has himself been in exile and has reiterated allegations of suppression and political alienation under the Hasina regime. The assertions were there again in his Thursday speech, but not the fate of his political

opponent, currently facing a death sentence.

Yet, some may find the statement “the people of Bangladesh want to reclaim their right to speak and their democratic rights” can perhaps be tied to the recent ban on Awami League leaders from contesting polls. Meanwhile, he did insist on an all-inclusive society, encompassing citizens of all faiths and religions, but did not directly condemn the arson and killings or offer extensive condolences for the victims.

He paid tributes to Osman Hadi and referred to the need to “regain economic rights” that highlight the economic grievances of ordinary citizens; tied economic justice to the sacrifices of 1971 and 2024, suggesting continuity between past struggles and present

demands. Tarique’s speech positions BNP as the primary alternative force before the February election, appealing to democratic aspirations at a time when many feel disenfranchised.

By invoking Bangladesh’s 1971 Liberation War, the 1975 uprising, and the 1990s mass movement, he positioned himself as heir to Bangladesh’s democratic struggles.

It is yet to be seen if the massive crowd – along the path he took on Dhaka’s streets, those at the event, and people listening to his speech elsewhere found in him the leader they are seeking. And time will also reveal the content of the plan he has brought from Britain to build a new hope and a new beginning for the people in his country in these tumultuous times.

## Telangana journalist unions term GO 252 discriminatory, seek amendments

Hyderabad, Dec 24 (TSIT): Journalist unions in Telangana have stepped up their opposition to recently issued Government Order - 252, dated December 22, 2025, terming it discriminatory and pointing out several shortcomings, particularly in the provisions relating to accreditation. The controversial GO prescribed the Telangana Media Accreditation Rules, replacing the rules in force.

Leaders of the Hyderabad Union of Journalists (HUJ) and the Telangana Working Journalists Federation (TWJF) said the GO had unfairly divided journalists into two categories — accreditation cards for reporters and media cards for desk journalists. They described the move as inappropriate and discriminatory, asserting that every eligible journalist, irrespective of the nature of work, should be issued an accreditation card.

While welcoming the State government’s decision to issue new accreditations, the unions thanked Chief Minister A. Revanth Reddy and Information and Public Relations Minister Ponguleti Srinivas Reddy. However, they said several clauses in GO 252 were confusing and unjust to a section of journalists.

The leaders expressed concern that desk journalists would be adversely affected by the new categorisation. They recalled that railway pass concessions had already been withdrawn due to a Central policy and that RTC subsidies had been reduced. They feared that bus pass facilities for desk journalists could also be withdrawn in the name of media cards and demanded that the decision be immediately withdrawn, with accreditation cards extended to desk journalists as well. The unions further stated that journalists working in small and medium-sized newspapers were being denied accreditation under the revised rules. They said the overall number of cards had been drastically reduced compared to previous years, which could result in hundreds of working journalists being left out. They demanded immediate correction of the shortcomings in GO 252 and support for desk journalists and smaller publications.

Responding to the criticism, Additional Director of Information and Public Relations DS Jagan said there would be no difference in facilities between accreditation cards and media cards. He dismissed as false the claims that desk journalists would be denied bus passes. Separately, HUJ and TWJF leaders urged the government to resolve the pending issue of housing plots for journalists and to introduce a health scheme for them on the lines of that available to government employees. They also demanded pension benefits for retired journalists and night transport facilities for women journalists.

## TTD’s SV Balamandir – A Lifeline for Orphan Children

Tirupati: Sri Venkateswara (SV) Balamandir, functioning under the aegis of Tirumala Tirupati Devasthanams (TTD), has been serving as a true lifeline for orphaned and underprivileged children by filling their lives with hope and light by providing education, accommodation, nutritious food, healthcare, cultural exposure, and moral values. Established in 1943 as SV Orphanage, the institution was renamed SV Balamandir in 1961 by the then Prime Minister of India, Pandit Jawaharlal Nehru, with the vision of ensuring holistic development of orphaned children rather than merely providing shelter.

In 2014, TTD brought SV Balamandir under the purview of Sri SV Sarva Shreyas Trust. Gradual Expansion Over the Years:

Starting with a limited number of children, the intake capacity was enhanced over the years. By 2003, the institution accommodated around 300 students annually, which increased to 500 students by 2005.

In the academic year 2025-26, SV Balamandir is home to 100 girls and 143 boys. After completing Class X, 56 boys and 49 girls are pursuing higher education in TTD-run and other private colleges



under TTD’s care and supervision. By offering free education, boarding, lodging, food, medical care, security, and financial support for higher education, SV Balamandir continues to lay a strong foundation for the future of hundreds of orphaned children.

Selection Process: Children belonging to the Hindu religion, aged between 5 and 10 years, are selected under three categories:

- Category A: Orphaned children with no parents (top priority)
- Category B: Children with either a deceased father or mother
- Category C: Children from economically weaker sections whose parents suffer from chronic illness, mental or physical disability.

Education & Facilities: Selected children are admitted from Classes I to V at SV Primary School and from Classes VI to X at Sri Govindaraja Swamy High School.

The Balamandir provides milk in the morning, breakfast, lunch, evening snacks, and dinner to all students.

After completion of Class X, boys are admitted to SV Junior College and girls to SP Junior College. TTD provides all basic necessities including stationery, clothing, cosmetics, accommodation, healthcare, and security free of cost. All facilities are managed under the close supervision of senior TTD officials and SV Balamandir authorities.

Intermediate Education in Corporate Colleges:

During the SV Sarva Shreyas Trust meeting held on December 4, 2025, under the Chairmanship of TTD Executive Officer Sri Anil Kumar Singhal, a

key decision was taken to provide Intermediate education in corporate colleges for students securing 75% and above marks in Class X. Several alumni of SV Balamandir have already demonstrated exceptional academic excellence by securing over 580 marks out of 600 in SSC and 982 marks out of 1000 in Intermediate.

TTD continues to take robust measures to ensure access to high-quality education for meritorious students.

Alumni in Prestigious Positions

Many former students of SV Balamandir have successfully completed higher education and are today serving in senior positions within TTD, as well as in IT, medical, government services, and other professional fields.

## Principal accused of assaulting senior professor during alumni meet at Hyderabad homeopathy college

Hyderabad: An incident that has sent shockwaves through academic and medical circles allegedly took place at Jayasurya Potti Sriramulu Government Homeopathic Medical College, Ramanthapur, where the Principal, Dr. N. Lingaraju, is accused of physically attacking Senior Professor Dr. G. Srinivasulu. According to eyewitnesses, the incident occurred on Wednesday evening during an Alumni Association Executive Committee meeting held in the Principal’s chamber, in the presence of several members. The alleged assault has triggered widespread outrage among faculty members, alumni, and the medical fraternity. The Alumni Association has



strongly condemned the incident, describing it as immoral, irresponsible, and a grave vio-

lation of academic ethics. Members stated that violence by a person holding such a responsible administrative position is deeply disturbing and sets a dangerous precedent within educational institutions. “This is not merely an internal dispute; it is an assault on the dignity of the teaching profession itself,” said senior alumni members. They emphasized that no form of physical aggression can be justified, especially in an academic environment meant to uphold discipline, respect, and intellectual integrity. The association has demanded immediate and strict disciplinary action against the accused principal and urged the authorities to conduct an impartial

and transparent inquiry. They warned that failure to act decisively could erode trust in institutional governance and compromise campus safety. Faculty members expressed concern that such incidents, if left unaddressed, could demoralize teaching staff and tarnish the reputation of government medical institutions in the state. The matter has reportedly been brought to the notice of higher authorities, and the academic community now awaits a firm response to ensure justice, accountability, and the restoration of decorum within the institution.

Why You Can't Put A 'Measuring Tape' On The 2-Billion-Year Old Aravallis

When the Ministry of Environment, Forest & Climate Change took the question of what constitutes an 'Aravalli hill' to the Supreme Court, the expectation was clarity that would strengthen protection for one of India's most fragile and strategically vital landscapes. What emerged instead was a technical, elevation-based yardstick, rooted in committee recommendations and an older forest-centric exercise, which risks turning judicial approval into a mechanism for narrowing, rather than safeguarding, the Aravalli ecosystem.

The Supreme Court's November order accepted a uniform operational definition, under which a landform must rise at least 100 metres above local relief to qualify as an Aravalli hill, with clustering rules to identify ranges. It also directed the preparation of a "Management Plan for Sustainable Mining" and barred new mining leases until that plan is finalised. The government has since argued that this brings long-needed clarity, prevents misuse of vague definitions, and does not weaken protection, repeatedly citing figures that over 90% of the Aravalli area remains protected and that mining eligibility extends to only 0.19% of the total footprint.

**Who Knows The Aravallis? Not The Supreme Court**

Those assurances sound neat, but they mask deeper flaws in both process and substance. The Aravallis are not merely a set of peaks that can be filtered through a height threshold. They are an ancient, eroded system of ridges, hillocks, pediments and shallow slopes stretching roughly 650 kilometres from Delhi through Haryana and Rajasthan into Gujarat. Their ecological value lies precisely in these low relief formations; they recharge groundwater across some of the most water-stressed districts in the country, stabilise soils, moderate microclimates, support biodiversity, and act as a critical barrier against desert expansion and dust movement from the west. Reducing this complex landscape to a single elevation test ignores how ecological systems actually function.

Before even assessing whether the 100 metre criterion is scientifically appropriate, a more basic constitutional question arises. Does the Supreme Court have the mandate to define hills and mountain systems? Indian courts have unquestionably played a vital role in environmental protection under Article 21, stepping in where executive action has been weak or absent. But courts are not scientific bodies, nor are they meant to settle geomorphological questions through judicial orders. In this case, the Court has accepted a technical definition supplied by the executive even as a comprehensive, Aravalli-specific ecological survey remains incomplete. That blurs the line between judicial oversight and scientific determination. If courts begin freezing technical definitions of landscapes - hills today, perhaps floodplains, wetlands, deserts or coastal systems tomorrow - judicial review risks sliding into environmental rule-making by fiat rather than precaution guided by evolving science."

**Bring Science Back**

The scientific basis itself is thin. The Forest Survey of India - Central Empowered Committee exercise of 2010, often cited in defence of the new definition, was forest-centric and advisory in nature. It was not designed as a multidisciplinary landscape-level assessment of groundwater recharge zones, wildlife corridors, ridge continuity or climate functions. Treating that exercise as definitive in 2025, after years of urban expansion, mining pressure and land-use change, violates the precautionary principle that underpins India's environmental jurisprudence.

This methodological weakness creates concrete loopholes. The 100-metre relative relief cut-off is blunt and exclusionary. Many ecologically critical ridges and low hills that support recharge and suppress dust fall below that threshold and risk being pushed outside formal protection. The mapping exercise mandated by the Court is still underway, yet the definition is already being operationalised, reversing the logical sequence of science first, regulation second. And headline figures about "90%" or "0.19% mining" are meaningless without publicly available, geo-referenced maps, a transparent registry of mining leases, disclosure of exemptions.

BANGLADESH: A LYNCHING, Nationalism, And Blood Sacrifice

"Dream delivers us to dream, and there is no end to illusion." The morning of December 16, 1971, was one such dream, delivered nine months after it was first dreamt on March 26. The birth of a nation. Bangladesh was free. Pakistan had been defeated. The colonial trope had been replicated barely two decades after the British left the Indian subcontinent. It was all supposed to go well for the 'baby' of the region. The carnage in East Pakistan, leading up to the historic surrender of the Pakistan Army to India, was meant to birth a terrible beauty. Except it didn't. And that's one of the biggest paradoxes of the idea of nationalism. An idea as strong as any to mobilise multitudes. Autonomy And Nationhood It suits almost all stakeholders to imagine the independence of Bangladesh as an example of the nationalist collective will finding its just culmination. A beleaguered people, facing political discrimination based on their linguistic and cultural identity, seceded from the hegemonic West Pakistan. The independence of Bangladesh was, after all, a belated correction to address the mistake of the earlier independence project. The dream of 1947 delivering 1971, to go back to the opening quote by Ralph Waldo Emerson. Anthony D Smith, a prominent theorist of nationalism, asserts, "Autonomy is the goal of every nationalist." In Bangladesh's case, the autonomy was achieved twice in less than a quarter of a century. Smith, along with many others, believes in the primordial idea of nationhood: nations predate modernity because they are rooted in associations that are almost visceral. The civic framing of a nation - governance, citizenship, the whole nine yards - is just a vessel to contain and legitimise this a priori idea of belonging. There has been a vehement criticism of this idea of nationalism by the modernists like Elie Kedourie and John Breuilly, who situate nation-ality in rationality. Nations are well-reasoned units of governance, emerging out of the various processes associated



with modernity, including the Industrial Revolution. The modernists argue that for the nationalist, unity makes sense because it achieves several goals ranging from good governance to territorial integrity. But why are we delving into the theory of nationalism? Who Is The More 'Important' One? Because the answers that we are looking for in the aftermath of the latest bloodlust in Bangladesh are all writ large in the boring pages that historians, psychologists, and political philosophers painstakingly produced. The "Too Long, Didn't Read" cohort can stop after the following sentence: The us-and-them framing of human associations finds and rationalises ways to assert that some of us are more important than others, and the latter can be conveniently eliminated for the greater good. For the present idea of Bangladeshi nationalism, a Hindu factory worker claiming that God is one and the same for everyone, despite different names, is an inconvenience. It hasn't been a new inconvenience, though. The much-eulogised secularism of Bangladesh has always had the subterranean current of religious

extremism. It's easy to romanticise Sheikh Mujibur Rehman's call for arms to protect the Bengali pluralism because it's far enough in history. But was it truly that? Or, did it remain so for long? The answer to the second question is a definitive no. And the fault lies in the nature of the beast called nationalism. What To Do With A Coloniser - Once They Leave? Since nationalism, an idea that refuses to die despite its many obituaries, remains one of the most powerful mobilising forces in human society, it doesn't stop at achieving the goals it originally stated. In the context of post-colonial nations, it was the independence from the colonial master. But what does society do with all the energy and momentum once the coloniser has been ousted? The stronger the push to the coloniser, the greater the chances of the unmanageability of the 'yes, we can' euphoria. The nobleness of the decolonising project can go only thus far and no further. We must remember that the birth of Bangladesh was the consequence of a war that caught the attention of the world's superpowers. Now, let's invoke theo-

rists Marvin and Ingle, who shock us by stating that nations can stay together only when the ritual of blood sacrifice is done periodically. So, picture a people mobilised for a noble cause, doing all it takes to assert themselves, suddenly finding themselves twitching, restless once the goal has been achieved. Once "Mukti" from the oppressor - the British, the Pakistani, Sheikh Hasina - is attained, the rites of unity must be performed. The victims are the 'others'. They must be expended to purify, unify, and fructify the 'true' idea of a nation. Because what came before was impure, imperfect, yet importunate. A perfect nation ought to perform and progress unbothered. Wasn't this, after all, the face (of a new perfect nation) that launched a thousand ships? Who knows if Helen was real or just an illusion? To conclude, "Once independence was achieved, however, the new state was faced with the problem of giving substance to that illusion," says Margaret Canovan about the burden that nationalism carries. It has to offload somewhere. Anywhere will do, but the site of least resistance works the best.

Is Congress Looking At A Rahul-Priyanka-Sachin Pilot Troika For 2029?

These are exciting times for the grand old party. The All India Congress Committee (AICC) general secretary in charge of organisation (GSO), KC Venugopal, has reportedly requested Rahul Gandhi to assign him 'mission Kerala' and relieve him of the 'GSO responsibilities' he has been holding since 2019. While a question mark hangs over whether Venugopal, aka KCV, would be projected as a chief ministerial candidate for the May 2026 polls, there is a near unanimity that it is curtains down for him as GSO. The million-dollar question is who would replace KCV as the next GSO. The Congress is undergoing a big churn that may see a meatier and bigger role for Priyanka Gandhi Vadra. The Grand Old Party is, supposedly, a big believer in celestial movements. In such a scheme of things, Congress insiders claim nothing would move till January 14, when the ongoing 'inauspicious' period of 'malmas' would end, and, in astrological terms, astral directions would become more conducive. Apparently, a letter appointing Priyanka Gandhi Vadra as head of the AICC's election management department has been ready



for weeks now. Whether that letter would be junked now and a new assignment would be given to Priyanka remains to be seen. Broadly, there are many contenders to replace Venugopal. A powerful lobby of party leaders known as 'Jai Jagat Groupies' is eyeing the coveted post. The cluster consists of leaders known for their left-of-centre, social justice-oriented leanings. It includes leaders such as Sashikant Senthil, Sachin Rao, Meenakshi Natrajan, Krishna Allavaru and Bhunwar Jitendra Singh, who are all hoping to be in the Rajya Sabha soon and like to sign off as 'Jai Jagat' in all modes of in-house communications. However, most traditional Congress leaders resent the rise of this clique,

resulting in veterans such as Ashok Gehlot, Ajay Maken and Digvijaya Singh throwing their hats in the ring too. However, a Gehlot or a Digvijaya becoming the GSO is unlikely, even more so after the Bharatiya Janata Party's (BJP) move to appoint a 45-year-old Nitin Nabin as their working president. The Congress leadership, that is, the three Gandhis - Rahul, Sonia, Priyanka - and AICC chief Mallikarjun Kharge are under pressure to infuse fresh blood and bring in a younger leader as GSO. These internal rumblings have brought the spotlight on Sachin Pilot, currently the AICC general secretary looking after Chhattisgarh. In Pilot's scheme of things,

the office of the president of the Rajasthan Congress is a top priority, where incumbent Govind Singh Dotasra has already served for five and a half years, since July 2020. Sources say if the Gandhis insist upon Pilot to take up the GSO post, he will have little or no option but to accept it. Given Pilot's greater popularity among partymen cutting across regional, caste and gender considerations, his elevation as GSO would perhaps also bring some sharpness to the AICC secretariat. Pilot also enjoys close proximity to Priyanka. A large section of party leaders feels a troika of Rahul, Priyanka and Sachin Pilot could be a huge leg-up for the Congress ahead of the 2029 Lok Sabha elections. As

for Priyanka, she has always maintained that she would do anything to help her older brother. Her entire politics revolves around making Rahul a success. In fact, she always addresses him as "my leader", recognising his leadership. The Congress has a rich history of family members working as a "pair". When Priyanka formally joined politics in 2019, it was not the first time that two family members of the Nehru-Gandhi family held high posts together. In 1959, Indira became the Congress president - much to the surprise of many in the party - when her father, Jawaharlal Nehru, was Prime Minister. Nehru's detractors had viewed the development as his bid to push Indira into the coveted post. But a large section of Congressmen of that era also felt that Indira earned that post through merit. They had enough reason to believe that, after all. As AICC chief, Indira tackled the Kerala crisis deftly; she was also the one who recommended the creation of Maharashtra and Gujarat to quell linguistic tensions there. When her term ended in 1960, the Congress Working Committee tried hard to convince her to re-run for the post.

Ain't No Mountain High Enough ... To Keep Them From Getting To Aravallis

Ain't no mountain high enough  
Ain't no valley low enough  
Ain't no river wide enough  
To keep me from gettin' to you, babe

The lyrics of this 1960s song perhaps encompass the controversy surrounding the Aravallis best after the Environment Ministry came up with a new definition to allow for what is being termed 'sustainable mining' of the ancient mountain range. A wave of public euphoria for the Aravallis has even irked the Environment Minister, Bhupender Yadav, leading him to lash out at activists and blame YouTube reels for spreading false information. The widespread anger from citizen groups and activists came in the wake of the Supreme Court judgment in late November, adopting the Environment Ministry's new criteria for defining what constitutes the Aravallis. The judgment says that only hills rising at least 100 metres above local relief, or clusters of such hills (of 100 metres and above) within 500 metres of each other, will now be recognised as part of the Aravalli range. Why Do Away With 'Mean Sea Level' Formula? Mr Yadav, whose Ministry



submitted this new criterion, has vociferously defended this stand. The height of 100 metres will be measured from the base of the mountain structure, and mining will not be allowed around or beneath the hill's structure, clarified the Minister. But clearly, this clarification is not enough. Key questions remain. One of the most pertinent questions that the Minister has not responded to is that when hills are measured scientifically from mean sea level (MSL), why has the Ministry of Environment, Forest and Climate Change strangely decided to do away with this conventional standard and add the word 'local relief'? Take the height of the

Qutab Minar, once considered one of the most iconic minaret structures not just in India but in the world. Its height is less than 100 metres, standing at approximately 72 metres. Can we one day pass a rule stating that all heritage structures that are below 100 metres are no longer heritage buildings and therefore need to be razed to the ground to make way for roads and mining projects? That is exactly what we are doing to the Aravallis. In a press release, there is some attempt made to clarify the matter by stating, "Aravalli range has been explained as all the landforms which exist within 500 metres of two adjoining hills of height 100 metres or more.



# India revamps tax regime in 2025, new I-T Act to take effect from April 1

New Delhi: India overhauled its tax regime in 2025 with sharp cuts in Goods and Services Tax (GST) rates and a higher income tax exemption limit, with the spotlight now turning to customs duty rationalisation and procedural simplification in the coming Budget. Next year will see the new simplified Income Tax Act, 2025, to come into effect from April 1, replacing the over six-decade-old current Income Tax Act, 1961. Also, two new laws — one to levy additional excise duty on cigarettes and another to levy cess on pan masala over and above GST rates — will be implemented on a date decided by the government. The tax reforms rolled out by the government in 2025 were aimed at stimulating demand amid a challenging global economic environment. With tariff uncertainties casting a shadow over economic decision-making, India's tax reform measures focused on boosting domestic demand to drive consumption and support growth. A key highlight was the reduction of GST rates on about 375 goods and services effective September 22, which lowered the tax burden on commonly used items and addressed long-standing concerns over inverted duty structures. The move to compress the four-tier GST slab structure of 5, 12, 18 and 28 per cent into two principal rates of 5 and 18 per cent, with a 40 per cent levy retained only for sin goods, marked a major step towards rationalisation and simplification of the indirect tax regime. The GST overhaul was designed to make the indirect tax regime simpler and more predictable, with fewer rate slabs and reduced litigation. On the



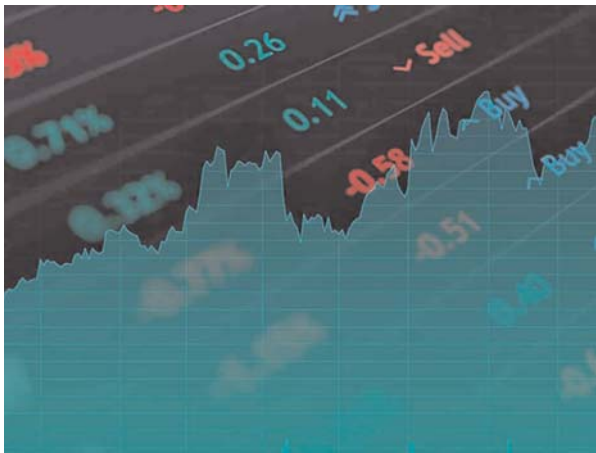
collections front, GST mop up touched a record high of Rs 2.37 lakh crore in April, and was averaging Rs 1.9 lakh crore during the current fiscal year. The sweeping rate cuts have put some pressure on the GST revenues with a slowing growth rate. India's Goods and Services Tax (GST) collections slipped to a year-low of Rs 1.70 lakh crore in November — growing at a meagre 0.7 per cent year-on-year. November was the first month that recorded the full impact of the GST rate cut effective September 22. On the direct tax front,

the government raised the income tax exemption limit, providing relief to middle-income taxpayers and leaving more disposable income in the hands of consumers. The move was seen as a consumption booster, particularly for urban households, while also reinforcing voluntary compliance under the simplified tax regime. The Budget for 2025 announced that no income tax will be payable on income of Rs 12 lakh a year under the new income tax regime, which offers lower tax rates without the benefit of claiming exemptions and

deductions. The tax rates applicable under this regime are 5 per cent of income between Rs 4-8 lakh, 10 per cent (Rs 8-12 lakh), and 15 per cent (Rs 12-16 lakh). Tax at 20 per cent rate is applicable on income between Rs 16-20 lakh, 25 per cent (Rs 20-24 lakh), and 30 per cent on income above Rs 24 lakh. However, the tax cuts slowed down non-corporate income tax collections between April and mid-December. Net non-corporate tax (which includes taxes paid by individuals, HUFs, and firms) grew 6.37 per cent at Rs 8.47 lakh crore between April 1 and December 17, as against a 10.54 per cent growth in net corporate tax collection at Rs 8.17 lakh crore. Refund issuances slowed during the current fiscal year as the Income Tax department did extra analysis of high-value refund claims. Refund issuance dropped 14 per cent compared to last year to over Rs 2.97 lakh crore, according to recent data. With major reforms in GST and income tax largely in place, policymakers have now turned their focus to customs duty rationalisation.

## STOCK MARKETS TRADE HIGHER IN EARLY DEALS

**Mumbai:** Benchmark equity indices Sensex and Nifty rallied in early trade on Wednesday, tracking a positive trend in global markets and consistent buying by domestic institutional investors. The 30-share BSE Sensex climbed 115.8 points to 85,640.64 in early trade. The 50-share NSE Nifty went up by 40.7 points to 26,217.85. From the 30-Sensex firms, Bajaj Finance, NTPC, Trent, Bharat Electronics, Adani Ports and Eternal were among the gainers. However, Tech Mahindra, Infosys, HCL Tech and Sun Pharma were among the laggards. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index and Hong Kong's Hang Seng index traded in positive territory. US markets ended higher on Tuesday. "As 2025 draws to a close the market appears to be moving to a consolidation phase with an upward bias. The strong domestic macros and the supportive earnings growth expectations in Q3 and Q4 of FY26 and for FY27 will provide the fundamental support to the market. "The sustained domestic inflows and consistent DII buying will impart resilience to the



market. However, since FIIs may sell the rallies, a sharp breakout is unlikely," VK Vijayakumar, Chief Investment Strategist, Geojit Investments Limited, said. Vijayakumar further said that the RBI decision to do an additional OMO (Open Market Operations) to the tune of Rs 2 lakh crore will significantly enhance liquidity and bring down yields. "This is positive for credit growth and banking stocks," he added. The Reserve Bank of India on Tuesday said it will purchase government securities worth Rs 2 lakh crore and conduct a USD 10 billion buy/sell dollar-rupee swap auction to inject liquidity in the banking system. The OMO (Open

Market Operations) purchase and swap auctions will be conducted between December 29, 2025 and January 22, 2026. Announcing the decision, the Reserve Bank of India (RBI) said it will continue to monitor evolving liquidity and market conditions and take measures as appropriate to ensure orderly liquidity conditions. The latest announcement comes days after the RBI conducted Rs 1 lakh crore OMO purchase auctions of Government of India securities and USD/INR Buy/Sell Swap auction of USD 5 billion for a tenor of three years. Foreign Institutional Investors (FIIs) offloaded equities worth Rs 1,794.80 crore on Tuesday, according to exchange data.

## Crude oil futures gain on spot demand



**New Delhi:** Crude oil prices on Wednesday rose Rs 26 to Rs 5,280 per barrel in futures trade as participants increased their positions following firm spot demand. On the Multi Commodity Exchange, crude oil for January delivery traded higher by Rs 26 or 0.49 per cent at Rs 5,280 per barrel

in 18,718 lots. Analysts said the rise of bets by participants kept crude oil prices higher in futures trade. Globally, West Texas Intermediate crude was trading 0.17 per cent higher at USD 58.48 per barrel, while Brent crude rose 0.13 per cent to USD 62.46 per barrel in New York.

## BOMBAY HC ASKS VIJAY MALLYA TO SUBMIT TO INDIAN JURISDICTION FIRST

**Mumbai:** The Bombay High Court on Tuesday sent a clear message to fugitive businessman Vijay Mallya that the court will not consider his challenge to the Fugitive Economic Offenders (FEO) Act until he submits to Indian jurisdiction. A bench of Chief Justice Shree Chandrashekhar and Justice Gautam Ankhad also questioned when the businessman plans to return to India. Mallya, based in the UK since 2016, has filed two petitions in the HC — one challenging an order declaring him as a fugitive economic offender and the other questioning the constitutional validity of the 2018 Act. The HC posed the question to the 70-year-old liquor baron, wanted in India to face trial on fraud and money laundering charges, on his return home while hearing his twin pleas. The court made it clear to the embattled businessman's counsel Amit Desai that it would not hear Mallya's plea against the Act unless he first submits himself to the court's jurisdiction. Solicitor General Tushar Mehta, appearing for



the Enforcement Directorate (ED), opposed the pleas arguing fugitives should not be permitted to challenge the validity of an Act without being subjected to courts of the country. He submitted to the court that the FEO Act was brought to ensure such persons do not abuse the law by staying away from the country and filing petitions through their lawyers. Mehta told the court that extradition proceedings initiated against Mallya were at an advanced stage. The bench insisted it cannot allow both petitions filed by Mallya to run together and asked the promoter of the

now-defunct Kingfisher Airlines to clarify which plea he wants to press and which one to withdraw. Desai told the court that financial liability had been effectively neutralised with Mallya's assets worth Rs 14,000 crore attached and liabilities worth Rs 6,000 crore recovered by lending banks. The Solicitor General maintained the fugitive businessman was entitled to legal representation even while staying abroad. The bench, however, questioned as to how does one wipe out criminal liability without submitting to the jurisdiction of the court. The HC posted the matter for further hearing on February 12

by when Mallya will have to inform the court about which petition he wants to proceed with. Mallya was declared a Fugitive Economic Offender in January 2019 by a special court hearing cases under the Prevention of Money Laundering Act (PMLA). The businessman, accused of defaulting on multiple loan repayments and facing money laundering charges, left India in March 2016. The HC posted the matter for further hearing on February 12 by when Mallya will have to inform the court about which petition he wants to proceed with.

## Ola Electric secures Rs 366.78 cr PLI-Auto incentive for FY25

The incentive has been sanctioned in accordance with the applicable terms and conditions of the PLI-Auto Scheme, as amended from time to time, it added. This milestone reinforces Ola Electric's role as a key contributor to India's advanced automotive manufacturing ecosystem and reflects the company's strong execution



across scale, localisation, and technology-led vertically integrated manufacturing, it stated. Commenting on the development, an Ola Electric spokesperson said, "The sanction of Rs 366.78 crore under the PLI-Auto Scheme is a strong endorsement of Ola Electric's manufacturing capabilities and our commitment to building world-class EV technology in India". This incentive recognises the company's sustained efforts in scaling domestic production, deepening localisation, and driving innova-

## IPO BOOM LIFTS FUNDRAISING TO RECORD RS 1.76 LAKH CR IN 2025

**New Delhi:** The IPO market, which scaled a record high in 2025 with companies raising an unprecedented Rs 1.76 lakh crore, driven by abundant domestic liquidity, resilient investor confidence and supportive macroeconomic factors, is expected to carry that momentum into the New Year. This exceptional year not only reflected issuers' confidence but also highlighted investors' eagerness to chase listing-day gains and back companies with strong long-term growth potential. A major highlight of the year was the resurgence of startup listings with as many as 18 startups, including Lenskart, Groww, Meesho and PhysicsWallah, going public and collectively raising over Rs 41,000 crore. In 2024, startups raised Rs 29,000 crore from the primary market. This rebound signals a reset in valuation expectations and business models after a period of caution. At the same time, Offer for Sale (OFS) continued to dominate fundraising activity,



accounting for about 60 per cent of total capital raised in 2025. Overall, companies across market capitalisations, large, mid and small, tapped the IPO route, with the average issue size exceeding Rs 1,700 crore, suggesting the breadth of participation. Looking ahead, market participants remain optimistic about the IPO activity in 2026. Bhavesh Shah, Managing Director and Head of Investment Banking at Equirus Capital, said the IPO

outlook for the New Year remains encouraging, supported by a deep pipeline and sectoral diversity. More than 75 companies have already secured Sebi approval but are yet to launch their issues, while another 100 are awaiting regulatory clearance, he added. The IPO pipeline spans technology, financial services, infrastructure, energy and consumer sectors, indicating broad-based participation rather than concentration in a few

themes. It is also expected to feature marquee offerings such as Reliance Jio, SBI Mutual Fund, Oyo and PhonePe. According to data compiled by IPO Central, 103 maiden public issues, launched in 2025, raised a total of Rs 1.76 lakh crore. The fundraising exceeded the Rs 1.6 lakh crore raised by 90 firms in 2024, and the Rs 49,436 crore garnered by 57 companies in 2023. According to Neha Agarwal, Managing Director and Head, Equity Capital Markets at JM Financial Institutional Securities, strong domestic liquidity and resilient investor confidence drove record fund mobilisation. Equirus Capital's Shah said that India's macroeconomic stability, marked by strong GDP growth, contained inflation and a predictable policy environment, boosted confidence among global and domestic investors. The momentum, however, was not uniform throughout the year. Primary market activity remained muted in the

first seven months amid market volatility, weak foreign portfolio investor participation and geopolitical risks. Conditions improved materially from August onwards, as macro concerns eased, liquidity strengthened and equity markets stabilised, triggering a sharp pickup in listings. V. Prashant Rao, Director & Head, ECM Investment Banking, at Anand Rath Advisors, says that while IPO volumes rose, fund-raising was skewed towards OFS. Of the listed companies, only 23 raised funds entirely through fresh capital, with an average issue size of around Rs 600 crore. In contrast, 15 companies raised funds purely via OFS, mobilising over Rs 45,000 crore, while the rest adopted a mix of both, with OFS forming the larger share. According to Rao, the preference for OFS reflects promoters' and early investors' desire to unlock liquidity efficiently without diluting the company's capital base or altering ownership structures.



# Officials discover a million more documents potentially related to Epstein case

US authorities have discovered more than a million more documents potentially related to the late paedophile Jeffrey Epstein that they plan to release in the coming days and weeks, officials say. The FBI and federal prosecutors in New York informed the Department of Justice (DoJ) of the discovery. "We have lawyers working around the clock to review and make the legally required redactions to protect victims, and we will release the documents as soon as possible," the DoJ said on Wednesday. The department said it could take "a few more weeks" before all the files are released. The DoJ has been under scrutiny after not releasing all Epstein files by 19 December, the deadline mandated under a new law. The agency said it would "continue to fully comply with federal law and President Trump's direction to release the files". The

statement did not specify how the FBI and the US Attorney for the Southern District of New York came across the additional material. Epstein had been facing charges of sex trafficking minors in the state when he died awaiting trial in a New York prison. The news comes after the justice department released thousands of documents - some heavily redacted - related to their investigations into Epstein. The department has been releasing the documents in batches and top officials have said hundreds of thousands of documents still are to be released. Who and what are in the Epstein files? Who was Jeffrey Epstein? The disgraced financier with powerful associates Trump trips, a fake video and 10 possible co-conspirators: Takeaways from new Epstein files The files were released after Congress passed the Epstein Files Transparency Act - signed



into law by US President Donald Trump - that ordered the agency to share all the documents with the public while protecting victims' identities. Many of the released documents, which include videos, photos, emails and investigative documents, have heavy redactions, including names of people the FBI appears to cite as possible co-conspirators in the Epstein case. The justice department has faced criticism from lawmakers on both sides of the aisle over the amount of redactions, which the law permits only to protect victims' identities and active criminal investigations. In a post on X after the discovery of the additional documents was announced, the top Democrat on the House Oversight Committee, a congressional panel that has been investigating the Epstein saga, accused the White House of "illegally" withholding the files. "Every day we see lies, incompetence, missed deadlines, and illegal redactions," Representative Robert Garcia said in a statement. The law passed by Congress and signed last month by Trump states that names

and information that might be embarrassing or cause "reputational harm" are not allowed to be redacted. It specifically asks the DoJ for internal communications and memos detailing who was investigated and decisions on whether "to charge, not charge, investigate, or decline to investigate Epstein or his associates". Included in the documents are emails appearing to be exchanged between FBI personnel in 2019 that mention 10 possible "co-conspirators" of Epstein. The emails said six of the group had been served with subpoenas. This included three in Florida, one in Boston, one in New York City, and one in Connecticut. Possible co-conspirators in Epstein's crimes are a major focus for his victims, and for several lawmakers who have demanded more transparency from the justice department. Previous releases of Epstein documents have

included revelations that reverberated across the Atlantic. Andrew and Epstein is the story that will not go away Andrew stripped of 'prince' title and will move out of Royal Lodge Peter Mandelson: Rise and fall of Labour's political fixer Peter Mandelson was sacked as the UK's ambassador to the US after details emerged about his friendship with the convicted paedophile, and that he told Epstein "I think the world of you", the day before Epstein began his sentence for soliciting prostitution from a minor in June 2008. Lord Mandelson said in a letter to staff that "I deeply regret" the circumstances of his departure from the British embassy in Washington DC. He said being ambassador had been "the privilege of my life" and he continued "to feel utterly awful about my association with Epstein twenty years ago and the plight of his victims".

Algeria's parliament has unanimously passed a law declaring France's colonisation of the North African state a crime, and demanding an apology and reparations. The law also criminalises the glorification of colonialism, state-run TV reports. The vote is the latest sign of increasingly strained diplomatic relations between the two countries, with some observers saying they are at their lowest since Algeria gained independence 63 years ago. France's colonisation of Algeria between 1830 and 1962 was marked by mass killings, large-scale deportations and ended in a bloody war of independence. Algeria says the war killed 1.5 mil-

lion people, while French historians put the death toll much lower. France's President Emmanuel Macron has previously acknowledged the colonisation of Algeria was a "crime against humanity" but has not offered an apology. Lawmakers wore scarves in the colours of the national flag and chanted "long live Algeria" as they applauded the bill's passage through parliament, AFP news agency reports. It says the legislation states that France has "legal responsibility" for the "tragedies it caused", and "full and fair" compensation was an "inalienable right of the Algerian state and people". France has not yet commented on the vote.

## Democratic lawmaker sues to remove Trump's name from Kennedy Center



Democratic US Representative Joyce Beatty has filed a lawsuit seeking to remove President Donald Trump's name from the John F. Kennedy Center for the Performing Arts. Last week, the board of the Kennedy Center - which Trump filled with allies - voted to rename the performing arts centre the Trump-Kennedy Center. Beatty is one of several Democratic lawmakers designated as members of the board by US law. She claimed in her lawsuit that the renaming was illegal because changing the name requires "an act of Congress". The suit says Beatty had called into the meeting about the name change but was muted when she tried to voice her opposition. Beatty argues that Congress intended for the centre to be a "living memorial" to former President Kennedy. "[I]n scenes more reminiscent of authoritarian regimes than the American republic - the sitting President and his handpicked loyal-

ists renamed this storied center after President Trump," the lawsuit states. In a statement provided to the BBC, the White House said Trump had "stepped up" and saved the Kennedy Center "by strengthening its finances, modernizing the building, and ending divisive woke programming". "As a result, the Board of the Kennedy Center voted unanimously to rename it the Trump-Kennedy Center - a historic move that marks a new era of success, prestige, and restored grandeur for one of America's most iconic cultural institutions," White House spokesperson Liz Huston said. On Friday, the president's name was added to the exterior of the building, and the centre's website logo now reads "The Trump Kennedy Center". The name change has been met with harsh criticism, particularly in Washington DC where the centre has been an iconic landmark since it was built and named for Kennedy.

## Sean 'Diddy' Combs files appeal asking for immediate prison release

Sean "Diddy" Combs has asked an appeals court to release him from prison and overturn his conviction on two prostitution-related crimes. In a court filing for an expedited appeal, the rap mogul's attorney argued that he was improperly sentenced, and that the conduct that resulted in his conviction was not criminal in nature. Attorney Alexandra Shapiro called Combs' 50-month prison sentence "unlawful, unconstitutional, and a perversion of justice". She asked an appeals court to order that Combs be resentenced, should the panel choose not to throw out his conviction in its entirety. The request is the latest attempt by his team to reduce his sentence or

throw out his conviction. The Southern District of New York, which prosecuted Combs, declined to comment on the request to the Second Circuit Court of Appeals. Combs' lawyers had previously said they would appeal his sentence and conviction. Federal prosecutors in New York accused Combs of using his money, power, and the threat of violence to coerce women into unwanted sexual encounters. During a high-profile trial this spring, the jury heard from two of Combs' ex-girlfriends, Cassie Ventura and a woman who testified as "Jane Doe". They said Combs abused them and forced them to participate in so-called "freak-offs" with male escorts.

## POPE LEO URGES 'COURAGE' TO END UKRAINE WAR IN FIRST CHRISTMAS ADDRESS

Pope Leo has urged Ukraine and Russia to find the "courage" to hold direct talks to end the war during his first Christmas remarks to crowds in St Peter's square. He called for an end to conflicts around the world during his Urbi et Orbi address, which is traditionally delivered by the pontiff on Christmas Day to worshippers gathered in Vatican City. Speaking about Ukraine, the Pope said: "May the clamour of weapons cease, and may the parties involved, with the support and commitment of the international community, find the courage to engage in sincere, direct and respectful dialogue." His plea comes as US-led negotiations on a deal to end the fighting continues. The US has sought to mediate between Kyiv and



Moscow as it seeks to put together an agreement to end the fighting acceptable to both sides, but direct talks between the warring parties have not taken place during this latest round of diplomatic efforts. Pope Leo also decried turmoil and conflict plaguing other parts of the world, including Thailand and Cambodia where deadly border clashes have flared up despite a ceasefire in July.

He asked that the South East Asian nations' "ancient friendship" be restored and "to work towards reconciliation and peace". During an earlier Christmas Day sermon in St Peter's Basilica, Pope Leo lamented conditions for homeless people the world over, and the damage caused by conflicts. "Fragile is the flesh of defenceless populations, tried by so many wars, ongoing or con-

cluded, leaving behind rubble and open wounds," he said. He said the story of the birth of Jesus showed that God had "pitched his fragile tent" among the people of the world. "How, then," he asked, turning his attention to the conditions of Palestinians, "can we not think of the tents in Gaza, exposed for weeks to rain, wind and cold?" Gaza has been devastated by Israeli bombardment in a two-year war, triggered by Hamas's attack on Israel on 7 October 2023. Winter storms have compounded the plight of the territory's 2.1m population, nearly all of whom have been displaced and their homes damaged or destroyed. Aid agencies have called for Israel to allow more tents and urgently needed supplies into Gaza.

## ELEVEN ARRESTED OVER MASS SHOOTING IN SOUTH AFRICA TAVERN

Eleven suspects have been arrested in connection with a mass shooting that left nine people dead at a tavern in South Africa on Sunday. Police launched a manhunt for the 12 unidentified gunmen who had opened fire at patrons at around 01:00 local time (23:00 GMT Saturday) in the Bekkersdal establishment, near Johannesburg. On Wednesday, provincial deputy commissioner of police, Major General Fred Kekana said nine of the arrested suspects are Lesotho nationals, while one is from Mozambique. Another suspect, believed to be a South African mineworker, was also detained. Murders in South Africa - which has one



of the highest rates in the world - are often the result of arguments, robberies and gang violence. While the attack appeared "unprovoked" at the time, preliminary investigations now appear to suggest a motive linked to illegal mining turf wars. During the attack, gunmen continued to shoot as

people fled the tavern, killing two as well as a taxi driver who had dropped off a passenger nearby. Upon making the arrests, several unlicensed firearms including an AK-47 rifle, were found in the suspects' possession. There are about 3m legally held firearms in South Africa and at least the same number of

unlicensed weapons, according to statistics cited by Gideon Joubert from the South African Gunowners' Association. Although 2025 has seen a decline in reported mass shootings, there has been a significant increase in incidents where four or more people are either killed or injured since 2020, Claire Taylor, a researcher at campaign group Gun Free South Africa, told the BBC. Among the most common locations for these attacks are licensed taverns or illegal drinking spots, known locally as shebeens. Sunday's shooting occurred just two weeks after another attack at the Saulsville Hostel in the capital Pretoria.

## Trump-backed candidate wins in knife-edge Honduran election



Nasry Asfura has been declared the winner of Honduras' razor-thin presidential election, after weeks of delays following technical problems and allegations of fraud. The conservative National Party candidate - backed by US President Donald Trump - won with 40.3% of the vote, according to the National Electoral Council (CNE), edging out Salvador Nasralla of the centre-right Liberal Party, who got 39.5%. In a post on X, Asfura said: "Honduras: I am ready to govern. I will not let you down." Meanwhile, Nasralla said at a press conference: "I will not accept a result built on omissions." But he also urged his supporters to remain calm. US Secretary of State Marco Rubio urged all parties to respect the result "so that Honduran authorities may ensure a peaceful transition of authority". But the president of the country's Congress,

Luis Redondo, posted saying the result was "completely illegal". The vote was held on 30 November but the count was delayed twice by technical outages, which electoral officials called "inexcusable". The president of the CNE, Ana Paola Hall, blamed the private company tasked with tabulating the results for the delay. She said the firm had carried out maintenance without warning or checking with the CNE. The stoppage came a day after the portal displaying real-time results had crashed. Results of the election were tight and, because of the tumultuous nature of the processing system, around 15% of the tally sheets had to be counted by hand for the winner to be decided. There have been tensions in Honduras as a result of the delays with protests held across the country last week. Thousands of supporters of the governing Libre party demonstrated in the capital Tegucigalpa over what they considered fraud in the vote. The outgoing President, Xiomara Castro, had alleged that an "electoral coup" was taking place and earlier this month said the election was being marred by "interference" from Trump.

## Turkey arrests 115 IS suspects 'planning New Year's attacks'

Turkish authorities say they have disrupted planned attacks on Christmas and New Year's events after arresting more than 100 suspected members of the so-called Islamic State group. Mass raids were carried out at 124 addresses across Istanbul, the city's chief prosecutor said, with firearms, ammunition and "organisational documents" seized. Officials said IS supporters had been actively planning attacks across Turkey this week, particularly against non-Muslims. Police detained 115 suspects but efforts are ongoing to trace a further 22, an official statement read. The prosecutor's office said the suspects were in contact with IS operatives outside Turkey. The



announcement comes two days after Turkish intelligence agents carried out a raid against the group on the Afghanistan-Pakistan border. A Turkish national who is alleged to have held a senior role with the IS wing operating in the region was detained and accused of planning attacks against civilians. Turkey's security serv-

ices regularly target people with suspected links to IS. The country shares a 900km (560 mile) border with Syria, where the group continues to operate in parts of the country. Syria's president Ahmed al-Sharaa, who has close ties to the Turkish government, has vowed to work with the US and Europe to root out surviving elements of IS.

## Front-runner to be Bangladesh PM returns after 17 years in exile

Tarique Rahman, the front-runner to be the next prime minister of Bangladesh, has returned to the country after 17 years in exile ahead of landmark general elections. The 60-year-old is the figurehead of the influential Zia family and the son of former prime minister Khaleda Zia. The party he leads, the Bangladesh Nationalist Party (BNP), is eyeing a return to power when Bangladesh goes to the polls in the new year. Rahman, who has lived in London since 2008, is expected to become the country's new leader if the BNP emerges as the largest party. Rahman's return comes in the wake of former Prime Minister Sheikh Hasina being ousted last



year. He had been the subject of various criminal investigations launched while her Awami League party was in power but was cleared of all charges when her regime fell. Hasina is living in exile in India and her party is unlikely to be permitted to take part in the elections, which many view as among the most conse-

quential in Bangladesh's history. Last month, Hasina was sentenced to death for her role in suppressing anti-government protests. According to UN investigators, up to 1,400 people died in the student-led unrest. Hasina, who was put on trial in absentia, has denied committing crimes against humanity.

However, Ashwin pointed out: "Fans are asking, 'what the hell?' Only Elon Musk can telecast these matches on X. Everyone wants to follow Rohit Sharma and Virat Kohli, no doubt. They had a great series and will be facing New Zealand next. They both have turned up, and turned up how! One scores 150 and the other 130, both with incredible strike rates. When players like these come and play, the



matches become more exciting," he said on his YouTube channel. Both Virat and Rohit slammed brilliant hundreds for their respective teams. Rohit slammed 155 off 94 deliveries, while Virat's 131 off 101 guided Delhi to victory over Andhra Pradesh. While fans were not happy with the lack of broadcasting, Ashwin explained that decisions regarding the telecast are taken well in advance and cannot be changed at the last minute, even if big names like Rohit and Virat decide to take part in the competition. "Everyone

wants to see Rohit and Virat in action, sure. But we have to see how early they [the broadcasters] got the information that Rohit and Virat would play. When the international calendar is given, the domestic calendar is given at the same time. Once it is given, the BCCI and broadcasters decide which stadiums are easy to cover from and which matches can be televised in advance. So, the conversation was that Rohit and Virat will play, but when? Making that last-minute switch is difficult," he said.

## Ex-Australia Star Adds Fresh Twist To England's Noosa 'Drinking' Row: "I Was There"

Former Australia batter Darren Lehmann has defended the England team over reports suggesting that the visitors had too much to drink during their mid-Ashes break in Noosa. According to reports in the English media, a number of players got too drunk during their six-day stay in Noosa, a resort town, ahead of the third Test in Adelaide. Ben Duckett has come under scrutiny, with the England and Wales Cricket Board (ECB) investigating for verification of a video appearing to show the batter drunk and struggling to find his way back to the team hotel. However, Lehmann, who represented Australia in 27 Tests and



117 ODIs, has defended the visitors, saying that the Ben Stokes-led side was "really well behaved" during their time in Noosa. "I was in Noosa and this bugs me. I am all for getting stuck into England. They haven't played well enough, their preparation before the first game of the series

(was not good) I get all that. But I was actually there. They were actually really well behaved. They mixed with the locals, had a good time," Lehmann told ABC Sports. The 55-year-old also rubbished media reports of 'too much alcohol' as he revealed that the English players engaged in other

sports and bonded well with the locals. "The reports of them staggering it up are just wrong. They were polite and a delight to the people of Noosa, played golf, played soccer with the locals - all that sort of stuff. They were well liked there," he added. The accusations were levelled at the touring party following their 82-run loss in the third Ashes Test, which ended their hopes of regaining the Urn. Lehmann also addressed the remarks made by England's Director of Cricket, Rob Key, who assured that the allegations of drinking would be investigated. "I would defend them a bit because that's just out of order.

## "Cricket Has Created This": Ex-England Captain's Stunning Take On Mid-Ashes Drinking Row

England's reported mid-Ashes drinking-gate has soured what has already been a tour to forget in Australia. Several reports claimed some England players spent as many as six days drinking between the second and third Ashes Tests, particularly during their four-day break at the Noosa beach resort. A video of England opener Ben Duckett seemingly drunk and unable to find his way back to the team hotel has gone viral on social media. Reflecting on it, former England captain Michael Vaughan has refused to pin the blame on Duckett, instead stating that cricket suffers from a "drinking culture". "I am not going to point the finger at a group of young people who have had



a few beers on a couple of days off. I did exactly the same as them when I played for England, although I did at least know when it was time to go home and that is probably what Ben Duckett needs to learn," Vaughan wrote in his column for The Telegraph. Vaughan stated that cricketers from nations like England, Australia, New Zealand and South

Africa all suffer from a drinking culture. "Duckett should not be reprimanded at all on the evidence we have seen and neither should the other players because it is a wider issue: the game of cricket has created this drinking culture. England, Australia, New Zealand and South Africa all have the same culture," Vaughan wrote. "You give a group of young people three or four days off to relax and they are going to do something like this," he added. Vaughan, instead, criticised England's Ashes preparation. Vaughan, who led England to a famous Ashes series win in 2005, slammed the fact that the trip to Noosa had been booked well in advance, but no prior plan had been made for warm-up games. "The thing about Noosa is that it was booked a year ago. But they did not book the Waca a year ago. How did they not prepare for a bouncy pitch leading into a first Test, but at the same time had booked their holiday in Noosa?" questioned Vaughan. "They also do not have a fielding coach on tour and are dropping catches.

## 'I'M NOT RETIRING' - KIPCHOGE'S MARATHON WORLD TOUR



For more than two decades, Eliud Kipchoge ran with history on his back and won almost everything there was to win. He rewrote what the human body was believed capable of and became, by near-universal agreement, the greatest marathon runner ever. Now the 41-year-old says the chase for medals and validation is over. "What I am doing is not retiring," he says. "I am evolving. I am running for purpose." Kipchoge plans to take his running to the edges of the world with the Eliud Kipchoge World Tour - not to prove his greatness, but to give it away. Over the next two and a half years, the two-time Olympic champion will complete a marathon on all seven continents "Running is the most universal sport," he tells Newsday on the BBC World Service. "It connects us all. With this project, I want to compete not only for records, but for the people. I want to inspire, to give back, and to remind everyone that no human is

limited." To understand the significance of this moment, it helps to understand the magnitude of Kipchoge's success. As well as those Olympic titles, Kipchoge's honours have included a world title, 11 World Marathon Major victories and two official world records. In one of sport's most impressive feats, he became the first person to break the two-hour marathon barrier under special conditions in Vienna in 2019, clocking an unofficial time of one hour, 59 minutes and 40 seconds. "If I look at the last 23 years, the highlight was making history," he says. "Not winning medals, not even breaking world records, but opening the minds of people around the world to believe that they are not limited in anything they are doing." That belief has become the anchor of his next chapter. The tour will operate under Eliud's Running World, a long-term platform designed to promote participation in running while supporting global causes.

such prodigious cricketing talent, it was Sachin Tendulkar - and we all know what became of him. What are we waiting for? VaibhavSuryavanshi for India!" posted Tharoor on X, tagging Gautam Gambhir and

Ajit Agarkar's official accounts as well. Bihar's batters went on a record-breaking spree with teen sensation Vaibhav Suryavanshi and skipper Sakibul Gani leading the carnage with the quickest hundreds to power them to a

world record team total of 574/6 in a Vijay Hazare Trophy match here Wednesday. Bearing the brunt of the sustained onslaught in the plate group match was minnows Arunachal Pradesh, as Gani (128 off 40 balls) raced to his hundred in just 32 balls, the fastest by Indian in List A cricket. Wicketkeeper Ayush Loharuka too joined the party with a 116 off 56 balls but, at a venue that has already witnessed 49 fours and 38 sixes, his whirlwind knock was somewhat put to shade by the unreal batting of Suryavanshi and Gani. With his brutal onslaught against an attack that was pedestrian in terms of quality.

## No spinner for Australia on 'grassy' MCG pitch

Australia will not play a spinner in the Boxing Day Test on a Melbourne pitch stand-in captain Steve Smith described as "quite furry, quite green". The home side have named a 12-man squad for the fourth Ashes Test against England, starting on Friday (23:30 GMT Thursday). The group includes only specialist pace bowlers, meaning off-spinner Todd Murphy misses out. Smith, deputising as captain for Pat Cummins, said Australia will play four seamers, plus all-rounder Cameron Green. Michael Nesar, Brendon Doggett and Jhye Richardson are vying for two places in the final XI. Smith is returning after missing the third Test through illness. Usman Khawaja was initially left out of the third Test, then replaced Smith and made scores of 82 and 40 in Adelaide. Khawaja is retained in Melbourne at the



expense of Josh Inglis. Khawaja will bat at number five, with all-rounder Green dropping to seven. The previous Ashes Test in Melbourne, in 2021, was over inside three days as England were bowled out for 185 and 68. "I daresay it's going to offer quite a bit," said Smith in his Christmas Day news conference. "Tomorrow looks similar conditions today - quite cold and overcast. There's going to be quite a bit of movement in

that surface." Smith said there is 10mm of grass on the surface, leading to the furry and green description. Australia have already won the Ashes after moving 3-0 up in the first three Tests. The home side are now targeting a fourth 5-0 clean sweep, while England are looking to end an 18-match winless streak in this country. Players from both sides trained side-by-side in the nets on Christmas morning,

with many of the England players and staff in Father Christmas hats. Families arrived to spend time on the Melbourne Cricket Ground outfield, before the squads left to celebrate. Australia are once again without captain Cummins, as he continues to manage a back problem, while fellow pace bowler Josh Hazlewood has missed the entire series. Off-spinner Nathan Lyon suffered a series-ending hamstring injury in the third Test in Adelaide, meaning Murphy was called into the squad. But the hosts will instead choose between Doggett, Nesar and Richardson. Doggett played the first two Tests of the series after making his debut in the opener in Perth. Nesar played his first Test for three years in the second match of the series in Brisbane, and claimed five wickets in England's second innings.

## 'Impossible to replace' - Fernandes could miss up to a month



Manchester United head coach Ruben Amorim says it is "impossible" to replace Bruno Fernandes as he faces up to a month without his captain. Fernandes was forced out of Sunday's 2-1 defeat at Aston Villa with a hamstring problem, which Amorim said at the time would rule the Portugal midfielder out of Friday's visit of Newcastle (20:00 GMT). Amorim refused to put a definitive timescale on Fernandes' absence when he spoke to the media on Wednesday, although he did say the expectation was it is "not going to take a lot of time". Sources have said privately they believe the 31-year-old will return for the Manchester derby with City at Old Trafford on 17 January, which would mean a five-match absence. It is a huge blow at a time when key attackers Bryan Mbeumo and Amad Diallo are away at the Africa Cup of Nations and Kobbie Mainoo, Fernandes' obvious replacement, is also missing with a calf injury. "It is impossible to replace Bruno," said Amorim. "I
