Indian-origin man shoots dead wife, 3 relatives in US over family dispute

New York (TSIT) A 51-year-old Indian-origin man has been arrested for allegedly shooting dead his wife and three relatives purportedly due to a family dispute in the US state of Georgia. Vijay Kumar was taken into custody a short distance from the residence in Lawrenceville city where the shooting occurred on Friday, Gwinnett County Police said in a social media post. Gwinnett County Police identified the victims as Kumar's wife Meenu Dogra, 43, who is an Indian national, and the relatives Gourav Kumar, 33, Nidhi Chander, 37, and Harish Chander, 38. The Consulate General of India in Atlanta, expressing grief over the shooting, said the alleged shooter has been arrested and all possible assistance was being extended to the bereaved family. "We are deeply grieved by a tragic shooting incident linked to an alleged family dispute, in which an Indian national was among the victims. The alleged shooter has been arrested, and all possible assistance is being extended to the bereaved family," it said on X.

Landslides, snowfall disrupt rail traffic on Kalka-Shimla route

Shimla, Jan 24 (TSIT) Rail traffic on the historic route was severely disrupted on Friday following rain and snowfall that triggered landslides and the fall of trees and boulders on the track. Train movement was halted for extended periods in forested stretches near Sanwara, Kumarhatti, and Jatog, causing cascading delays throughout the day. According to railway officials, three trains reached three to four hours behind schedule, while one train was delayed by about an hour. The Himalayan Queen, which departed with an initial delay of 35 minutes, remained stranded in the Sanwara forest for nearly half an hour and ultimately reached Shimla around an hour late. The late arrival of up trains led to corresponding delays in down services towards Kalka. The first train of the day, the 52457- Kalka-Shimla Express, departed at its scheduled time of 3:30 am but was held up between Dharampur and Kumarhatti for around 50 minutes, reaching Shimla at 9:50 am, about an hour late.

Trade agreements opening up new opportunities for youth: PM Modi

Trump threatens Canada with 100 pc tariffs over new trade deal with China

WASHINGTON (TSIT) President Donald Trump on Saturday, January 24, threatened to impose a 100 per cent tariff on goods imported from Canada if America's northern neighbour went ahead with its trade deal with China. Trump said in a social media post that if Canadian Prime Minister Mark Carney "thinks he is going to make Canada a Drop Off Port for China to send goods and products into the United States, he is sorely mistaken." While Trump has waged a trade war over the past year, Canada this month negotiated a deal to lower tariffs on Chinese electric vehicles in return for lower import taxes on Canadian farm products. Trump initially had said that agreement was what Carney "should be doing and it's a good thing for him to sign a trade deal." Carney's office did not immediately respond to a request for comment. Trump's threat came amid an escalating war of words with Carney as the Republican president's push to acquire Greenland strained the NATO alliance. Trump had comment-

ed while in Davos, Switzerland, this week that "Canada lives because of the United States." Carney shot back that his nation can be an example that the world does not have to bend toward autocratic tendencies. Trump later revoked his invitation to Carney to join the president's "Board of Peace" that he is forming to try to resolve global conflicts. Trump's push to acquire Greenland has come after he has repeatedly needled Canada over its sovereignty and suggested it also be absorbed the United States as a 51st state. He resumed that this week,

India-EU FTA: EU Foreign Policy Chief Kaja Kallas arrives in India to push "mother of all deals"

NEW DELHI (TSIT) European union foreign policy chief Kaja Kallas arrived in New Delhi on Saturday on her first official visit to India, as Brussels and New Delhi move to deepen cooperation on security, trade and defence. No political interference in SCCL, site visit norm pre-dates Congress: Bhatti

Hyderabad: Deputy Chief Minister Mallu Bhatti Vikramarka on Saturday, January 24, refuted the allegations of irregularities in Singareni Collieries Company Limited (SCCL), saying that the site visit certificate system was in place long before the Congress came to power in Telangana and there was no political interference in tender allocation. Holding a press meet at Jyotirao Phule Bhavan and Excise Minister Jupally Krishna Rao, the Deputy CM demanded managing director of ABN Andhra Jyothi, Vemuri Radhakrishna, retract his statements on SCCL, warning defamation charges otherwise. On January 18, Bhatti had announced that SCCL would cancel the mining tender for the Naini coal block after a report by the news agency alleged he had a role in awarding the contract to certain companies. The Deputy CM condemned the reports, saying that they damage the morale of nearly 42,000 permanent employees and 30,000 out-

sourcing workers of Singareni. "For whose pleasure and to please whom Radhakrishna wrote those articles is known only to him...I have been in politics for 40 years. An attack on my personality, which is built on high ethical values, is unjustified. I have personally witnessed the hardships, blood, and sweat of Singareni workers. I will not allow vultures, predators, or powerful interests to descend on Singareni," Bhatti said. The previous day, Bharat Rashtra Samithi (BRS) leader Harish Rao wrote to Union Coal Minister Kishan Reddy asking for a CBI probe into the SCCL tender cancellation.

8 Maoists, including woman, surrender before police

Peddapalli : In a boost to the state's efforts to curb leftwing extremism, eight Maoists, including a woman, surrendered before the Ramagundam Commissionerate police on Saturday. The surrendered cadres were associated with various Maoist front organisations such as militia units, courier networks, cultural teams and local committees. The surrendered Maoists were identified as Darmaji Srikanth, Podium Kamulu, Mudiam Joga, Kunjam Lakke, Modam Bheema, Kunjam Unga, Mudikam Sukram and Mudiam Mangu. Except Srikanth, all belong to Gampur village under Gangeluru police station limits in Bijapur district of Chhattisgarh and were active in Bijapur and bordering areas of Telangana. Srikanth, a native of Cheggam village in Velgatur mandal of Jagtial district, had worked as a Maoist courier in 2019 and was arrested by Vajedu police in 2024. After his release, he rejoined the banned outfit in Chhattisgarh and later functioned as a courier to senior Maoist leaders Kankanala Raji Reddy, Azad and Damodar.

Major fire breaks out at Nampally, people feared trapped

HYDERABAD (TSIT) A major fire broke out at a furniture store in Nampally in Hyderabad on Saturday, January 24, with at least 2-3 people feared to be trapped inside. The fire occurred at Batcha Furniture Shop, located on the ground floor of a four-storey building, where scrap material had been stored. The blaze was reportedly triggered by accident. According to the fire control room, 17 fire tenders had been deployed at the scene. No casualties have been reported so far, however res-

cue teams faced difficulties getting to the victims due to heavy smoke. The victims are suspected to be trapped on the second cellar and efforts are underway to reach them. Traffic disrupted, public asked to postpone Numaish visitHyderabad Police

Traffic in the area has come to a standstill, and the public has been advised to postpone their visit to Numaish for the day to avoid inconvenience. ICC drops Bangladesh from T20 World Cup, brings in Scotland; informs all member nations

New Delh The International Cricket Council (ICC) has pushed Bangladesh out of the upcoming T20 World Cup, bringing in Scotland after BCB refused to let its team travel to India citing security concerns in the wake of Mustafizur Rahman's ouster from IPL. Scotland's entry ended the month-long suspense after Bangladesh Cricket Board (BCB) repeatedly insisted that their matches be shifted to Sri Lanka and even suggested their group being

swapped with Ireland. The Irish Cricket board however categorically dismissed the suggestion. At the ICC

'Tigers' travelling to India for their games. ICC gave BCB a 24-hour deadline to change its stance but with Asif Nazrul being adamant, the cricket crazy nation's hopes of playing the T20 World Cup went up in smoke. It has been learnt that top ICC officials including chairman Jay Shah were in Dubai on Friday and late evening an e-mail was sent to BCB chairman Aminul Islam Bulbul informing him about global body's decision. "An e-mail was sent last evening to BCB chairman intimating him that his board didn't get

back to ICC officially after the 24-hour deadline that was given to them to decide if they wanted to come to India," an ICC source said on condition of anonymity. "BCB did a press conference in Dhaka before officially intimating the global body which is a violation of protocol. They have been categorically told that they are being replaced. Scotland is the new team in the World Cup." ICC also intimated all the participating member nations separately about Bangladesh being dropped from the tournament.

Vizhinjam Port is Kerala's largest-ever private investment: Karan Adani

Thiruvananthapuram, Jan 24 (IANS) Karan Adani, Managing Director of Adani Ports and Special Economic Zone (APSEZ), on Saturday, said the Vizhinjam International Seaport is the largest investment ever committed by any business house in Kerala and will see an additional investment of Rs 16,000 crore. Speaking at the foundation stone-laying ceremony of Vizhinjam Port Phase-2, Karan Adani said the port has already made a global mark within a short period of commencing operations.

"In just 15 months of commercial operations, Vizhinjam became the fastest Indian port to handle one million TEUs, firmly placing Kerala on the global shipping map. Today, as we lay the foundation for Phase-2, we are not merely expanding a port -- we are expanding a national capability," he said.

Adani announced that Phase-2 will see an additional investment of Rs 16,000 crore, taking the total committed investment to Rs 30,000 crore. With this expansion, the port's capacity will scale up from 1 million TEUs to 5.7 million TEUs by 2029.

Patna, Jan 24 (IANS) As part of his Samriddhi Yatra, Bihar Chief Minister Nitish Kumar visited Vaishali district on Saturday, where he laid the foundation stone for 25 development schemes worth Rs 54 crore and inaugurated 103 schemes worth Rs 98 crore.

Congress leaders openly blaming 'immature' Rahul Gandhi for poll debacles: BJP

New Delhi, Jan 24 (IANS) The Bharatiya Janata Party (BJP), on Saturday, trained its guns on Leader of the Opposition (LoP) in Lok Sabha Rahul Gandhi, alleging that his party members openly call him "immature" and the person responsible for the party's near-100 electoral defeats.

Pradeep Bhandari, BJP National Spokesperson, in a post on social media platform X, said, "No one in the Congress takes Rahul Gandhi seriously!"

"Shakeel Ahmad, a former Union Minister, calls 'virtual Congress President' Rahul Gandhi 'coward' and 'immature', and predicts that under him the Congress will not even be able to emerge as



the third largest party nationally!" Bhandari said, attaching a video clip of Ahmad.

Bhandari captioned the message, "Congress exposes Rahul Gandhi, who is about to complete his century of defeats."

The BJP leader, in a video statement, said Congress leaders believe

Rahul Gandhi for what called his "hypocrisy" over democracy, alleging that the LoP has failed to introduce democracy in his own party.

"Shakeel Ahmad has claimed that Rahul Gandhi has installed Mallikarjun Kharge as a dummy Congress President... in reality, the LoP Rahul Gandhi does not believe in organisational democracy," Bhandari said.

He added that more and more Congress leaders have started admitting in public that Rahul Gandhi has reduced the party into a failed organisation as he alone is responsible for the 95 electoral defeats that the grand old party has tasted under his stewardship.

Tharoor stands firm on Ops Sindoor, dismisses rift talks with Cong leadership

Thiruvananthapuram, Jan 24 (IANS) Senior Congress leader and Thiruvananthapuram MP Shashi Tharoor on Saturday said there was no change in the stand he had taken on "Operation Sindoor" and that he had no regrets about expressing a principled difference of opinion, firmly rejecting suggestions that he had acted against the party line in Parliament.

Speaking at the Kerala Literature Festival (KLF) in Kozhikode, Tharoor said that throughout his parliamentary career, he had never taken a position contrary to the official stand of the Congress. He clarified, however, that the only instance of a principled disagreement was in the context of Operation Sindoor, which he described as a matter of national security rather than partisan politics.

Tharoor's remarks came amid speculation about differences between him and the party leadership, particularly following his absence from a key Congress meeting in Delhi. Addressing the broader narrative, he underlined that matters of national security must be approached with clarity, responsibility, and a sense of national interest.

Referring to a column he had written in the aftermath of the Pahalgam terror attack, Tharoor reiterated that such attacks must not go unpunished and that India was entitled to respond firmly. At the same time, he cautioned against being drawn into a prolonged conflict with Pakistan. India, he said, should remain focused on development and avoid long-term military entanglements, advocating instead for limited and targeted military action against terror camps. Noting that the government later adopted a similar approach, Tharoor said this validated the core argument he had made.

When we celebrate 100 years of independence, UP will become a fully developed state: HM Shah

New Delhi, Jan 24 (IANS) Union Home Minister Amit Shah on Saturday participated in the 'Uttar Pradesh Diwas' celebrations and said that when the nation celebrates 100 years of its Independence on August 15, 2047, Uttar Pradesh will emerge as a fully developed state and play an integral role in building a Viksit Bharat.

Snowfall in J&K brings roadblocks, power cuts; BRO works to make Srinagar Airport operational

Srinagar, Jan 24 (IANS) Significant snowfall and rainfall occurred in Jammu and Kashmir (J&K) during the last 24 hours. Air and surface transport remained disrupted throughout the day on Friday and the Border Roads Organisation (BRO) said on Saturday morning that its men and machinery were working to remove the accumulated snow and ice to make the Srinagar International Airport operational today.

No flight operation could take place from the airport yesterday as the Srinagar-Jammu Highway



also remained closed. the Srinagar-Leh Highway and the Mughal Road yesterday and till

now there is no official word on resuming traffic on these highways.

Due to the gusty winds that went ahead of the rain and snowfall in J&K, most of the electricity supply network was disrupted, but the ground staff and engineers of the electricity corporation worked overnight to restore more than 60 per cent of the supply till Friday evening.

The MET department said on Friday that the Western Disturbance (WD) that caused the precipitation has now moved out of J&K.

While cleaning gun at home, KRK fired two rounds to test if weapon was working properly: Mumbai Police

New Delhi, Jan 24 (IANS) Hours after actor Kamaal Rashid Khan, popularly known as KRK, was arrested by the Mumbai Police in connection with a two-round firing incident reported from the Oshiwara area of the city, the cops on Saturday revealed that the actor fired two rounds while cleaning his gun at home to check whether the weapon was functioning properly.

Sharing details of the case, the police said that Kamaal Rashid Khan had obtained a gun licence and a firearm from Uttar Pradesh in 2005. After acquiring the weapon, he brought it to Mumbai and kept the gun, which was licensed in Uttar Pradesh, at his residence in the city for nearly two decades.

A few days ago, following the implementation of the Model Code of Conduct (MCC) for the Mumbai Municipal Corporation elections, KRK deposited his firearm at the Versova police station, as per procedure. After the MCC was lifted, he retrieved the weapon from the police station.

According to the police, four or five days after taking back the firearm, the actor was cleaning the gun at his home when he allegedly fired two rounds to test whether it was working properly.

During this time, the shots were report-



edly fired in the direction of a tree on Lokhandwala Back Road. However, due to strong winds, the bullets deviated from their path and struck the nearby Nalanda building.

Following the incident, the Oshiwara police registered a case and initiated an investigation from multiple angles. After questioning, actor Kamaal Rashid Khan was arrested in connection with the firing incident.

According to the police, KRK was identified as the prime suspect in the case, taken into custody and brought to the Oshiwara police station late on Friday evening for interrogation.

Bengal SIR: ECI miffed at delayed action by two DEOs in addressing violence at hearing centres

Kolkata, Jan 24 (IANS) The Election Commission of India (ECI) is reportedly miffed at delayed action by two District Magistrates, also the District Electoral Officers (DEOs), in West Bengal in addressing instances of tension and vandalism earlier this week at two centres for hearing on claims and objections on the draft voters' list.

One instance of vandalism was at a hearing centre at Farakka in minority-dominated Murshidabad district, where ruling Trinamool Congress activists led by party legislator from

Farakka Assembly constituency, Manirul Islam, allegedly orchestrated the action.

Although the Commission directed the District Magistrate, as well as the DEO of Murshidabad to register an FIR against Islam by Thursday and also intimate the ECI about the compliance by the same day, there had been no report of compliance with the ECI's order in the matter till Saturday morning, confirmed insiders from the office of the Chief Electoral Officer (CEO), West Bengal.

A similar instance of non-compliance has

surfaced in the case of another incident of vandalism, this time at Itahar in North Dinajpur district earlier this week. The Commission had sought a detailed report from the DEO concerned on the matter at the earliest. However, till Saturday morning, there was no compliance with that direction. An insider from the CEO's office said that the Commission had communicated to the DEOs in the state not to take matters of vandalism at the hearing centres lightly and to instantly register FIRs with the local police stations in such matters.

Davos summit acts as catalyst for Karnataka’s economic growth

Bengaluru: The World Economic Forum (WEF) summit held in Davos, Switzerland, has emerged as a major springboard for Karnataka to achieve significant gains in investments, expansion and partnerships across sectors such as aerospace, food processing, data centres, digital infrastructure, clean energy and advanced manufacturing, with investment commitments amounting to Rs.13,070 crore.

Industries Minister M.B. Patil has said that more than 45 meetings and consultations held over five consecutive days have successfully drawn global attention to Karnataka as one of the country’s leading destinations in artificial intelligence, Global Capability Centres (GCCs), research and sustainable urban development. Sharing details after returning from Davos, the Minister has elaborated on the success of the visit.

The consultations with industry leaders have laid a strong foundation for fresh investment inflows into the State and have also significantly accelerated projects already under implementation. They will help Karnataka strengthen its competitive



position in the next phase of global trade and industrial transformation. Global business leaders have praised the State’s industry-friendly environment and the availability of skilled human resources, reflecting the foresighted, industry-oriented initiatives being implemented by the State Government, the Minister said. He said he had clearly conveyed how Karnataka is emerging as a preferred global destination for investments, industrial establishment and expansion, while explaining the State’s industry-friendly policies and appealing to companies to invest in Karnataka.

The RP-Sanjiv Goenka Group (RPSG) will invest Rs.10,500 crore over the next three years in Vijayapura and Ballari districts, significantly boosting the renewable energy sector and development in north Karnataka. Global brewing major Carlsberg Group has reiterated its commitment to set up a Rs.350 crore bottling plant at Nanjangud. Schneider Electric has come forward to invest Rs.1,520 crore, including in IT operations. INOX GFL, which has already invested Rs.10,000 crore in the State and commenced turbine blade manufacturing for wind power at Kushtagi, is investing an

additional Rs.400 crore in manufacturing wind power towers and solar panels. Belrise Industries is investing Rs.300 crore to expand its Mysuru unit, which supplies components to TVS. Discussions were held with the Singapore Economic Development Board on establishing a ‘Singapore Park’ to attract Singapore-based companies. Efforts were also made to attract a substantial share of Coca-Cola’s proposed Rs.25,760 crore investment in India to Karnataka. Global majors such as Nokia, US-based Vast Space, UAE-based Crescent Enterprises and Voyager Technologies

have shown interest in investing in the State. Bharti Enterprises, which has already invested around Rs.13,000 crore in Karnataka, has expressed interest in setting up new data centre, further strengthening digital infrastructure. Bharat Forge Limited has obtained information on investment opportunities in the State. France-based Mistral AI has expressed interest in establishing a phased research and development centre in Bengaluru. US-based Philip Morris has indicated its intent to manufacture smoke-free products in Karnataka.

Nokia Corporation has expressed its keenness to establish a Global Capability Centre (GCC) and research centres in the State. In line with the State Government’s priority of developing cities beyond Bengaluru as self-sustaining urban centres, Tech Mahindra has shown interest in expanding operations into Tier-2 cities. Bharti Enterprises is keen on setting up a data centre, while Sify Technologies has stated that it will launch one soon in the State.

‘KWIN City’ draws attention

Imperial College, one of London’s most prestigious universities, has shared plans to set up a research and development centre in ‘KWIN City’, coming up between Dabaspet and Doddaballapur. Global cyber security major Cloudflare is also considering becoming part of the ‘KWIN City’ project. US-based Voyager Technologies and space technology company Vast Space have expressed interest in entering into partnership agreements with the State Government. UAE-based Crescent Enterprises has come forward to invest in enterprises and companies across the State. An MoU has been signed to facilitate Swiss companies in leveraging Karnataka’s industry-friendly and innovation-driven ecosystem. Natural Fibre Welding (NFW Earth) has said it would share a detailed expansion proposal with the State Government. With the objective of strengthening bilateral trade ties, the Minister participated in productive discussions with corporate leaders, investors, reputed educational institutions, heads of governments and senior officials of the World Economic Forum.

Brahmavar: Service Road delay, lack of temporary bus stop cause hardship to commuters

Brahmavar, Jan 24: Residents, commuters, students and local organisations in Brahmavar have expressed growing concern over the prolonged delay in the service road project, along with the absence of a temporary bus stop, which has severely affected users of public transport. The service road work has faced repeated delays, with minimal progress visible on the ground. While construction continues at a slow pace, the authorities have failed

to put in place temporary arrangements to mitigate the inconvenience caused to the public. The lack of a temporary bus stop has particularly impacted students and daily wage earners, who rely heavily on public transportation. Earlier in 2025, several local organisations and student groups had warned of launching mass protests if the authorities failed to initiate temporary service road works and address the difficulties faced by commuters. In the absence of a proper bus stop facility, passen-



gers are forced to wait along busy roads, often amidst moving traffic. This situation poses serious safety risks and exposes commuters to harsh weather conditions, especially during the rainy season. Speaking on the issue, Govinda Raj Hegde, trustee of the Brahmavar Foundation, urged immediate intervention from elected representatives. “I request the Member of Parliament to take effective measures to install a tem-

porary bus stop and speed up the ongoing service road work. With the monsoon approaching, road construction will face further challenges, and school students as well as local residents are left without proper shelter during rainfall. If immediate action is not taken, along with local organisations, would be protesting against the concerned authorities,” he said. Residents are now demanding swift action to ensure commuter safety and convenience until the permanent infrastructure is completed.

Minister of State for MSME & Labour and Employment Inaugurates National Level Khadi Exhibition 2025-26 in Bengaluru



Bengaluru: Shobha Karandlaje, Minister of State for MSME & Labour & Employment, inaugurated the National Level Khadi Exhibition 2025-26 at the HMT Grounds, Jahalahalli, Bengaluru. Organized by the State Office of the Khadi & Village Industries Commission (KVIC), the event serves as a major impetus for the KVI sector.

During the ceremony, the Minister distributed 800 toolkits worth Rs.1.49 Crore to 350 beneficiaries under the Gramodyog Vikas Yojana. Instructions to prepare the voter list as per rules and in a transparent manner: Maheshwar Rao

Bengaluru : With regard to the elections to be held under the Greater Bengaluru Authority (GBA), the Chief Commissioner, Maheshwar Rao, instructed officials to prepare the voter list strictly as per rules and in a transparent manner.

Revenue officers, who are also Electoral Registration Officers, must give priority to election-related duties along with property tax collection and ensure that the voter lists are prepared without any errors.

Davos and India’s image

In recent years, Indian participation in the World Economic Forum at Davos has acquired a familiar, ritualistic ring to it. Indian politicians and corporate head honchos make a beeline for their share of the limelight on the global stage, which is dominated by leaders and billionaires from powerful countries. This year, too, it was no different. The political delegation comprised some savvy, English-speaking Union ministers and half a dozen chief ministers. While BJP CMs Devendra Fadnavis and Himanta Biswa Sarma, and leader of its ally the TDP and Andhra Pradesh CM Chandrababu Naidu were there to scout potential investors, Congress and DMK chief ministers of Karnataka and Tamil Nadu gave it a miss, but the CM of Jharkhand made it to Davos in Switzerland.

Each year, national leaders mainly strive to position India as a major foreign investment destination. This year, they wanted to bring the world around to accepting India's transition from an “emerging” economy to a “pivotal” global force. As expected, Union Minister Ashwini Vaishnaw reiterated India's growth projections in the wake of varying degrees of caution or skepticism expressed by some international agencies. Whether there were takers or not depends on their perception about the health of democracy, policy-to-practice conversion, effective governance and ease of doing business, and many of them are unlikely to be swayed by India's claims and perception management and narrative control at home.

Another area where the Indian delegation had to do damage control was with regard to the characterisation of India as a “second-tier AI power”. The popular perception is that compared to the US and China, India is trailing in the global AI race when it comes to building sovereign AI models that match the scale, complexity and efficiency of global models. Ashwini Vaishnaw made a valiant effort to refute this and managed to extract some kind of validation from IMF MD Kristalina Georgieva, who said she was impressed by India's approach to staying competitive in the realm of AI. The chief ministers, on the other hand, try to secure investment commitments and strategic partnerships for their respective states. The state delegations face the onerous task of convincing investors to make impressive announcements, and the flavours of the season were artificial intelligence, scalable high-tech manufacturing and digital infrastructure. States like Andhra Pradesh, Telangana, Gujarat and Maharashtra have a historical edge over other states due to their robust, industry-friendly ecosystems, including skilled labour. States like Madhya Pradesh, Uttar Pradesh and Assam, however, struggle to compete despite generous financial support from the Centre. It is far more difficult to convince foreign investors who need to loosen their purse strings than voters who are more receptive to election campaign messaging. These states need to achieve and demonstrate visible change on the ground, especially with respect to developing a highly skilled talent pool and the prevalence of a cosmopolitan culture, to change investor perception.

WHILE BJP CMS DEVENDRA FADNAVIS AND HIMANTA BISWA SARMA, AND LEADER OF ITS ALLY THE TDP AND ANDHRA PRADESH CM CHANDRABABU NAIDU WERE THERE TO SCOUT POTENTIAL INVESTORS, CONGRESS AND DMK CHIEF MINISTERS OF KARNATAKA AND TAMIL NADU GAVE IT A MISS, BUT THE CM OF JHARKHAND MADE IT TO DAVOS IN SWITZERLAND.

Phone call marketing makes life miserable

Mobile phones were once considered the most powerful means of convenience, security, and connectivity. They bridged distances, saved lives in emergencies, and facilitated communication. However, over time, these same mobile phones have become a source of stress, frustration, and mental disturbance for millions. The biggest reason for this is rampant phone call marketing, which has made life miserable for the common man.

The day often begins with a call from an unknown number. As soon as we wake up, the phone rings, offering a loan, an insurance policy, a credit card, or a "limited-time" investment offer. Whether it's an office meeting, an online class, or an important conversation at home—phone call marketing has no understanding of time or circumstances. When asked, we get the same rehearsed answer—"Sir/Madam, just two minutes." But we don't realize when those two minutes swallow up significant portions of our day. The most worrying aspect is how callers get our mobile numbers. We have neither personally provided them with our numbers nor explicitly authorized any services, yet they speak with complete confidence. Sometimes they even know our name, profession, and needs. This situation is not just a call marketing problem, but a blatant violation of personal data security and privacy. In today's digital age, mobile numbers have become not just a means of communication but a commercial commodity.

The government and regulatory bodies have enacted regulations and implemented services like "Do Not Disturb," but in prac-

tice, their effectiveness appears to be limited. Calls continue to come even when numbers are registered on DND. The complaint process is so complex and lengthy that ordinary people become frustrated and choose to remain silent. This frustration further fuels the problem. The impact of phone call marketing isn't limited to simply wasting time. It gradually leads to mental stress and irritability. Every unknown number raises a sense of apprehension—maybe it's another useless call. The fear of missing an important call persists. This confusion profoundly impacts a person's peace of mind. Many people become so bothered by the constant calls that they become irritated with their mobile phones. This problem is even more serious for the elderly and those with less technical savvy. They often fall prey to these calls and are often scammed. Incidents of fraud involving millions of rupees are being reported under false pretenses related to investments, prizes, KYC updates, or bank account details. The line between call marketing and fraudulent calls has become so blurred that it's difficult for the average person to distinguish between them.

Time is life's most valuable asset, but call marketing openly disrespects it. Calls that arrive early in the morning or late at night are proof that rules are confined to paper only. This problem is even more acute for working people. A ringing phone during a meeting not only distracts attention but also damages professional image. Putting the phone on silent runs the risk of missing important calls, and not keeping it on silent leads to the hassle of

unwanted calls.

It's also important to understand that the caller isn't always at fault. Employees working for telemarketing companies are often under immense pressure. They must make a set number of calls daily, and if they don't meet the target, they face the threat of losing their job. Low pay and an uncertain future force them to stick to this work. They speak according to a set script, no matter how angry the other person may be.

But the real responsibility behind these employees' compulsion lies with the system, which, in the pursuit of profit, tramples on human privacy, time, and peace of mind. Companies know that if even one person in a hundred falls into their trap, their objective is achieved. This is why call marketing has become an organized industry, where ethics and sensitivity have no place.

While India has regulations to regulate telemarketing, their effective enforcement is severely lacking. While there's talk of fines and bans, there's little visible change on the ground. Many calls originate from internet calling or foreign numbers, which are not subject to local regulations. This misuse of technology further complicates the problem. This problem is also affecting social relationships. A person who is repeatedly disturbed becomes irritable, which affects both family and workplace. A phone ringing suddenly while spending time with children or talking to the elderly disrupts the atmosphere. Gradually, people stop picking up unknown calls altogether, which can sometimes lead to missing important and even emergency calls.

The digital age has given us freedom of expression and a wealth of convenience, but responsibility and control are equally important. Allowing apps without reading them, sharing mobile numbers on every website, and ignoring privacy terms—all these habits contribute to the problem of call marketing.

It is now imperative to take concrete steps towards a solution. Personal data security must be given top priority, and strict penalties must be ensured for violations. Systems like DND must be made truly effective to provide relief to consumers. Companies that repeatedly violate the rules must face strict action, not just warnings.

Additionally, consumers must be vigilant. Disallowing unnecessary apps, being wary of suspicious calls, and reporting fraud—these are small but important steps. Only an aware consumer can hold this system accountable. Ultimately, it must be understood that phone call marketing is no longer just a commercial activity, but has become a serious social problem. It invades our privacy, wastes time, and robs us of our peace of mind. The purpose of technology should be to simplify, secure, and improve life, not to make it more difficult. Until the system, companies, and consumers—all three—jointly fulfill their responsibilities, this problem will continue to plague the lives of ordinary people.

The Troubled Indian Republic: The Harsh Reality of 2026

As Republic Day, 2026, approaches, a patriotic frenzy sweeps across the nation. A grand parade on Rajpath, drone shows, military parades—everything dazzling. The President's speech, the Prime Minister's message, and essay competitions in schools. But behind the scenes of celebration, India's republic is struggling. Fifty-seven years later, evils like corruption, violence, rape, and communal hatred continue to ravage society. India, once the world's most populous nation, is shrouded in economic splendor, yet shrouded in the darkness of poverty and inequality. Under the guise of democracy, authoritarian tendencies are flourishing. Youth suffer from unemployment, and farmers are joining the suicide statistics. Women's insecurity is at its peak, and the justice system has collapsed. Republic Day should now be an occasion for reflection—where did we go wrong? Is our Constitution still relevant, or has it become irrelevant over time?

The Republic of India was born in 1950. The Constitution, drafted by Dr. Bhimrao Ambedkar, established lofty ideals—equality, liberty, and fraternity. But fifty-seven years later, the reality is stark. The economy is said to be the world's fifth largest, but eighty-five percent of wealth is concentrated in the top one percent of the rich. More than seventy billionaires together possess

more wealth than the national budget. Multidimensional poverty engulfs twenty-one percent of the population. Forty-six percent of families in rural India lack basic amenities. Urban slums are growing, while luxury towers are sprouting in metro cities. This inequality has led to a social explosion. The female-to-male ratio is nine hundred twenty per thousand, and thirty-five percent of children are stunted due to malnutrition. NFHS-6 data is a warning—India's future cannot be built on nutrition-deprived generations.

Corruption has become a cancer of this republic. India slipped to the 85th position in Transparency International's 2025 index. Corruption is rampant from politics to bureaucracy, from business to judiciary. The electoral bond scam created a new controversy in the 2026 elections. Deepfakes of artificial intelligence made the campaigning more complicated. Corporate money bought the parties. From road construction to airport, every contract is a victim of commission. DBT saved five lakh crores, but Aadhar data leak, PAN card fraud created new problems. Bribery is common at the lower level from peon to police station in-charge. This corruption is hollowing out the roots of democracy.

Criminalization of politics is a serious crisis. In the eighteenth Lok Sabha, more than



two hundred and fifty MPs are facing criminal cases. Those accused of murder, kidnapping, and rape are becoming MLAs. Money and muscle power have distorted the election process. The source of forty percent of the estimated election expenditure of one lakh crore is unclear. Distribution of cash, rivers of liquor, buying and selling in the name of voter slips. Casteism has gripped politics. Yadav-Jat in Uttar Pradesh, Kurmi-Rajput in Bihar, caste politics in every state. Communalism has fueled communal riots. In 2025, riots broke out in Uttarakhand and Manipur. Polarization on social media is at its peak—from WhatsApp forwards to Twitter trends, the poison of hatred.

Women's insecurity is a stigma for the republic. From the Nirbhaya case to Hathras and Unnao, rape incidents are not stopping. Eighty-six cases are

registered every day, the actual figures are double. Atrocities on Dalit women have doubled. Stalking in cities, fear of Khap Panchayats in rural areas. Expenditure of ten thousand crores of Nirbhaya Fund is negligible. Fast-track courts are inadequate, cyber cell is inactive. Sexual harassment has increased at the workplace, from Bollywood to corporate, Me-Too movement has stopped. Gender discrimination persists in education and employment. School dropout rate of girls is high. This insecurity is keeping half the population of the society tied down.

The justice system has collapsed. Four lakh fifty thousand cases are pending, judge-population ratio is nineteen per ten lakh. It takes an average of ten years in the High Courts. Injustice equals delay in justice. Lawyers' strikes, shortage of judges, complex laws. E-court

project in limbo. Police reforms are nominal - colonial mentality prevails. Bribery in police stations, torture in custody is common. Even after the formation of SIT, SIT reports are suppressed. Khap Panchayats have taken the law into their hands. Patriarchy is crushing democracy in families. Regionalism is intensifying - TMC in Bengal, LDF in Kerala against the Centre. Southern states are bent on rebellion in the name of language reservation. Separatism is simmering in the North-East.

Youth unemployment at 23 percent. Those who do not get into civil services from IIT-IIM turn to startups. But most of the unemployed rural youth are skillless. Farmer crisis deepens-demand for minimum support price hanging in balance. Series of suicides due to debt in Punjab-Maharashtra. Floods and droughts destroyed crops. Farmers on the streets even after MSP law was enacted. Pollution fatal-AQI of Delhi crosses 500. Yamuna-Ganga black. Climate crisis, flood-drought compound. Naxalism active in Chhattisgarh-Jharkhand. Terrorism spread from Jammu-Kashmir to Kerala. Misuse of UPAPA, Information Technology rules on freedom of expression. Journalists in jails, social media censorship.

Is a solution possible? DBT has benefited corruption, but

artificial intelligence monitoring and blockchain voting are essential. Full Nirbhaya Fund expenditure, 1,000 fast-track courts. Cybercrime cells in every district. PM Vishwakarma, 4-phase self-reliance, 150 million jobs. Expansion of Skill India. 'Samvidhan Yatra' promotes communal harmony—a curriculum on unity is mandatory in schools. Election Reform Bill—criminal candidates banned for life, state funding transparent. Audit of political parties. E-courts three phases, 50,000 new judges. Maximum judicial time limit. Police reforms—CCTV mandatory in police stations. NITI Aayog two phases to address regional imbalances, special package for southern states. Nation-building internships—one year of service for every youth. Panchayati Raj empowerment—National Women's Reservation for the Seventy-third Amendment. 30% target for electric vehicles, Namami Gange two phases to accelerate. Development package for Naxalite areas.

Mere parades and flag hoisting on Republic Day are not enough. Problems must be acknowledged. Formal democracy was saved, now ensure real social justice. Youth power must come forward to make India a world leader. Diversity must become a strength. Dr. Ambedkar's Constitution must come alive, emerging from the thorny bushes. Otherwise, the republic will become a mere sham. Jai Hind, Jai Bharat!

Zoho chooses Kumbakonam for ERP foray, Zoho Pay rollout on cards

where even a Zoho School of Technology operates, providing opportunities for undergrads to take up on the job training with stipends of Rs 10,000. These undergrads are from in and around Kumbakonam as they chart out their career path with an assurance of being absorbed in

Zoho itself. Vembu said plans are underway to develop a full-fledged campus in the region with capacity for up to 2,000 employees, depending on market adoption. ERP is a massive global opportunity, but it is also one of the hardest software categories to build. That's why only a few players dominate the world. It takes long-term R&D, engineering depth and trust Vembu Zoho's ERP foray is the culmination of nearly 18 years of work in finance and operations software. As per Sivaramakrishnan Iswaran, global head, Zoho's Finance and Operations Business Unit and CEO of Zoho Payment

Technologies, the push was driven by a clear market gap. "Most global ERPs are retrofitted for India. They are not designed for evolving regulations like GST and e-invoicing," he said. Nokia plans GCC, research expansion in Karnataka

The industries minister said the initiative was discussed in detail during a meeting with John Dutton,

Head of UpLink at the World Economic Forum. According to the minister, discussions were also held with global cybersecurity major Cloudflare regarding its potential participation in the 'KWIN City' project and future expansion opportunities in the state. Cloudflare's Global Strategy Head, Stephanie Cohen, described Karnataka as one of the "world's best destinations for attracting advanced technologies," Patil added.

Gold Outperforms as Equity Momentum Softens, Signalling a Strategic Shift in Markets: PL Asset Management

Mumbai, January 24, 2026: PL Asset Management, the asset management arm of PL Capital Group (Prabhudas Lilladher), in its latest report 'PMS Strategy Updates and Insights', noted that Indian equity markets are navigating a phase of consolidation marked by global uncertainty, uneven participation and cautious investor sentiment. While domestic macro fundamentals remain structurally strong, near-term equity performance has been constrained by external headwinds, resulting in market returns being driven by a narrow set of stocks rather than broad-based participation. Market breadth has remained persistently weak over the past year, with a limited group of large-cap stocks supporting headline indices even as broader participation stayed muted. Technical indicators suggest that only a small proportion of stocks have been consistently traded above their long-term moving averages, highlighting the fragility beneath index-level resilience. This divergence indicates that while Indian equities remain fundamentally sound, the market has yet to transition into a durable, broad-based uptrend. This consolidation was also evident across major equity style factors. Value and High Beta strategies posted positive returns in 2025, while Momentum underperformed, highlighting a market driven more by selectivity than by sustained trends. Value stocks drew investor interest due to compelling valuations and stable earnings visibility, serving as a preferred refuge amid elevated volatility. High Beta strategies delivered modest gains, indicating calibrated risk-taking rather than a broad risk-on stance. Meanwhile, repeated trend reversals limited the effectiveness of momentum-based approaches, reflecting narrow market breadth and fragmented leadership. Overall, investor behaviour in 2025 leaned toward caution, with capital favouring stocks that combined valuation support with controlled



risk. The style factor landscape in 2025 was defined by the strong performance of contrasting factors, driven largely by sector- and stock-specific moves. Market breadth remained narrow and momentum was weak, reinforcing a selective and low-risk appetite investing environment. Against this backdrop, precious metals have significantly outperformed Indian equities, reinforcing their role as effective portfolio stabilisers during periods of equity consolidation. Gold and silver have benefited from a combination of global factors, including sustained central bank demand, currency volatility and persistent geopolitical uncertainty. Silver has additionally been supported by its dual role as a precious and industrial metal amid constrained supply conditions. PL Asset Management's analysis indicates that Indian equities are currently trading near multi-cycle relative lows compared with gold and silver. Historically, such valuation divergences between financial and real assets have coincided with phases where diversification beyond pure equity exposure has helped investors preserve capital and manage volatility more efficiently. Importantly, this does not

signal a structural shift away from equities, but rather highlights the importance of balance during transitional phases of the market cycle. Market sentiment indicators suggest that the worst of pessimism may be behind us. Internal sentiment and risk metrics point to a gradual improvement from recent cycle troughs, supported by resilient domestic macro data and an improving earnings outlook. Notably, the high-low beta spread turning positive towards the latter part of 2025 indicates early signs of risk appetite returning, although the recovery is expected to be measured rather than linear. Mr. Siddharth Vora, Head - Quant Investment Strategies & Fund Manager, PL Asset Management, said, "Markets are currently in a phase where outcomes are being driven more by asset allocation than by broad-based equity rallies. While India's long-term growth fundamentals remain intact, near-term volatility is inevitable. Gold and silver have once again demonstrated their relevance as portfolio stabilisers, helping investors manage risk and stay invested through periods of market consolidation." The firm's Risk-o-Meter analysis further supports this view, indicating that sentiment may have moved past pessimism. After remaining elevated through much of 2023 and early 2024, the indicator has begun to trend upward, suggesting a transition from fear-driven behaviour toward selective risk-taking. Historically, such inflection points have marked early stages of stabilisation rather than the end of volatility, reinforcing the need for disciplined positioning. Looking ahead, Indian equities are expected to benefit from a gradual recovery in domestic earnings and potential global capital rotation as valuations in AI-led global markets normalise. However, until market breadth improves meaningfully and volatility moderates, diversified asset allocation remains critical. Portfolios that combine equities with precious metals are better positioned to smooth return profiles while retaining exposure to long-term growth opportunities.

Amazon to lay off around 16,000 employees in new job cut plans

CHENNAI: Amazon has decided to lay off about 16,000 employees as part of efforts to reduce its administrative costs, said a Daily Thanthi report. Starting from January 27, 2026, roughly 14,000 to 16,000 employees will be laid off. The US-based e-commerce company is among the world's largest firms. Amid economic pressure and the impact of artificial intelligence on business, many companies have been reducing their workforce, and Amazon has continued with layoffs in recent years. Between 2022 and 2023, Amazon had cut around



27,000 employees for various reasons, and on October 14, 2025, it eliminated about 14,000 positions. With the latest round of layoffs, Amazon plans to cut a total of about 30,000 corporate jobs in its

30-year history. The job cuts are expected to affect senior officials and software engineers working in Amazon Web Services, retail, Prime Video and human resources divisions.

US warship makes first call at Cambodia’s Chinese-renovated naval base



REAM: A US warship on Saturday made a port call at a Cambodian naval base for the first time since Chinese renovations that have raised concerns in Washington, AFP journalists saw.

The United States has said Ream Naval Base, off Cambodia’s southern coast, could give China a key strategic position in the Gulf of Thailand near the disputed South China Sea, which Beijing claims almost in its entirety. The littoral combat ship USS Cincinatti (LCS-20) docked Saturday morning at one of the base’s piers 150 meters (yards) away from a pair of Chinese warships.

“It is our privilege and our honor to be here as the first US naval vessel to moor pier-side at Ream Naval Base, and we hope this is the beginning of a longstanding tradition and friendship,” Andrew J. Recame, the ship’s commanding officer, told reporters.

Cambodian leaders have repeatedly denied that the base is for use by any single foreign power, following US

media reports in 2022 saying the new facilities at Ream — originally built partly with US funds — would be exclusively for the Chinese navy.

Ream base said in a statement that the five-day US visit would “promote cooperation between the two countries,” and that it showed Cambodia’s “commitment in implementing an open policy, transparent and cooperation with international partners.”

Cambodian Prime Minister Hun Manet and a delegation from China’s People’s Liberation Army inaugurated the base in April last year. Hun Manet denied the new and improved facility would be for Beijing’s “exclusive” use, saying ships from other countries would be allowed to dock. Two weeks after its inauguration, two Japanese warships were the first vessels to dock at the base.

Beijing has since 2022 been contributing to a revamp of the Ream Naval Base, which was originally built partly using US funds. Western concerns about the

base go back as far as 2019, when The Wall Street Journal reported on a secret draft deal allowing China to dock warships there.

In late 2023, Chinese warships first docked at the 363-meter (1,190-foot) pier, on Cambodia’s sole coastline in the south of the country between Thailand and Vietnam. A US warship docked in the commercial Sihanoukville port in 2024 in the first American military port call in Cambodia in eight years. On Saturday morning, AFP journalists saw two Chinese warships still docked at the base.

Cambodia has long been one of China’s staunchest allies in Southeast Asia, and Beijing has extended its influence over Phnom Penh in recent years. Under former leader Hun Sen — Prime Minister Hun Manet’s father — China poured billions of dollars into infrastructure investments, while Washington’s relationship with Phnom Penh has deteriorated in recent years.

Toll in Iran's protest crackdown reaches at least 5,002 dead as Trump says US 'armada' approaching

DUBAI: The toll in Iran’s bloody crackdown on nationwide protests has reached at least 5,002 people killed, activists said Friday, warning many more were feared dead as the most comprehensive internet blackout in the country’s history crossed the two-week mark.

The challenge in getting information out of Iran persists because of authorities cutting off access to the internet on January 8, even as tensions rise between the United States and Iran as an American aircraft carrier group moves closer to the Middle East.

US President Donald Trump likened the carrier group to an “armada” in comments to journalists late Thursday.

Analysts say a military build-up could give Trump the option to carry out strikes, though so far he’s avoided that despite repeated warnings to Tehran.

Meanwhile, Iran’s top prosecutor denied a claim by Trump that his intervention so far had halted the execution of 800 prisoners detained in the demonstrations, calling his comments “completely false.”

“While President Trump now appears to have backtracked, likely under pressure from regional leaders and



cognizant that airstrikes alone would be insufficient to implode the regime, military assets continue to be moved into the region, indicating kinetic action may still happen,” a New York-based think tank called the Soufan Centre said in an analysis Friday.

The latest death toll was given by the US-based Human Rights Activists News Agency, which reported that 4,716 were demonstrators, 203 were government-affiliated, 43 were children and 40 were civilians not taking part in the protests.

It added that more than 26,800 people had been detained in a widening arrest campaign by authorities. The group’s figures have been accurate in previous unrest in Iran and rely on a network of activists in Iran to verify deaths. That death toll exceeds that of any other round of protest or unrest in Iran in decades, and

recalls the chaos surrounding Iran’s 1979 Islamic Revolution.

Iran’s government offered its first death toll Wednesday, saying 3,117 people were killed. It added that 2,427 of the dead in the demonstrations that began December 28 were civilians and security forces, with the rest being “terrorists.”

In the past, Iran’s theocracy has undercounted or not reported fatalities from unrest. The Associated Press has been unable to independently assess the death toll, in part because of authorities cutting access to the internet and blocking international calls into the country.

Iran also reportedly has limited journalists’ ability locally to report on the aftermath, instead repeatedly airing claims on state television that refer to demonstrators as “rioters” motivated by the United States and Israel, without offering evidence to support the allegation. The new toll comes as tensions remain high over Trump laying down two red lines over the protests — the killing of peaceful demonstrators and Tehran conducting mass executions. Iran’s attorney general and others have called some of those being held “mohareb” — or “enemies of God.”

Russian attacks on Ukraine kill 1, wound 23 ahead of second day of peace talks



KYIV: Russian attacks on Ukraine killed at least one person and wounded 23 overnight into Saturday, as negotiators from Ukraine, Russia and the United States were set to meet in Abu Dhabi for a second day of talks to end Russia’s nearly four-year full-scale invasion. One person was killed and four wounded in Russian drone attacks on the Ukrainian capital, Kyiv, according to Kyiv City Military Administration head Tymur Tkachenko.

In Ukraine’s second-largest city, Kharkiv, drone attacks wounded 19 people, Kharkiv Mayor Ihor Terekhov said Saturday.

The attacks came as envoys were expected to meet in the United Arab Emirates for a second day of talks on Saturday. The talks are the first known instance that officials from the Trump administration have sat down with both countries as part of Washington’s push for progress to end Moscow’s nearly 4-year-old invasion.

The UAE’s foreign ministry said the talks are part of efforts “to promote dialogue and identify political solutions to the crisis.”

The White House described Friday’s first day as productive.

US carries out first known strike on alleged drug boat since Maduro’s capture

WASHINGTON: The US military said Friday that it has carried out a deadly strike on a vessel accused of trafficking drugs in the eastern Pacific Ocean, the first known attack since the raid that captured Venezuelan President Nicolas Maduro earlier this month.

US Southern Command said on social media that the boat was “engaged in narco-trafficking operations” and that the strike killed two people and left one survivor. It said it notified the Coast Guard to launch search and rescue operations for that person.

military has focused lately on seizing sanctioned oil tankers with connections to Venezuela since the Trump administration launched an audacious raid to capture Maduro and bring him to New York to face drug trafficking charges. With the latest military action, there have been 36 known strikes against alleged drug smuggling boats in South American waters since early September that killed at least 117 people, according to announcements from the US military and Trump. The majority of those of strikes have occurred in the Caribbean Sea.

Think again: why AI is unlike previous tech booms

Concerns about an AI bubble have intensified since the start of 2026, as investors and policymakers focus on whether, and when, it might burst. But the real question is not whether current valuations are inflated; it is whether AI’s emerging business model differs from those of earlier technological revolutions.

For decades, scale has been the primary driver of tech companies’ performance and valuations. As apps, websites, online retailers, and social media platforms expanded their user bases, marginal costs fell, network effects took hold, and pricing power increased. Valuations came to reflect long-term growth potential rather than short-term profitability.

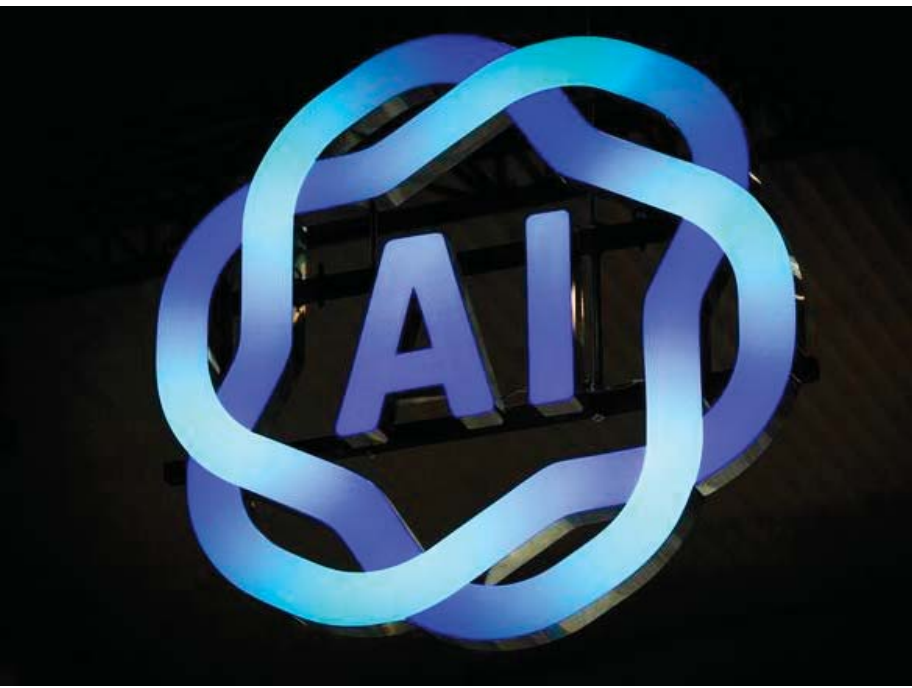
The forces that defined past tech winners are unlikely to dominate AI’s rollout, because the competitive dynamics differ across six critical dimensions. First, capital expenditure is no longer a shallow moat; it is a formidable barrier. In earlier technological waves, capital requirements were largely confined to the startup phase and relatively modest. Facebook, for example, initially raised just \$500,000 in seed funding.

But those earlier innovations were built on top of existing infrastructure such as Linux, Apache, MySQL, and PHP — the so-called LAMP stack — which dramatically lowered upfront costs. AI, by contrast, is extraordinarily capital intensive. Industry-wide capital investment is projected to exceed \$7 trillion by 2030 as companies build data centers, expand computing capacity, and invest in specialized hardware. Unlike previous tech cycles, these investment requirements will not fade as the industry matures and may even intensify.

Political influence now matters as much as market power

Moreover, those costs may never decline meaningfully, since the lifespan of data centers is often measured in years, not decades. While cloud computing also required massive investment in general-purpose servers, AI demands entirely new infrastructure, including graphics processing units and tensor processing units, or TPUs, to handle the vast number of simultaneous calculations involved in training and running AI models. Such systems are expensive and energy intensive. A single large-scale AI training run is expected to cost over \$1 billion by 2027. Only firms that can afford the entry price will survive, giving today’s tech giants — with their enormous cash flows, robust balance sheets, and access to capital markets — a decisive advantage.

Second, AI’s operating-cost structure undermines traditional economies of scale. In earlier tech cycles, marginal costs per user collapsed as platforms grew. Whether it was social media, software, or ride-shar-



ing apps such as Uber, costs were spread across an expanding customer base, enabling platforms to sustain high margins as they scaled up. Those models were also marked by low operating expenses. Once Facebook reached sufficient scale, the marginal cost of adding users became negligible. As a result, companies paid little attention to the cost of serving each user, as it rarely threatened financial viability.

AI flips these dynamics. Controlling marginal costs is no longer optional, since large language models and other AI systems incur significant costs with every interaction, which requires billions of calculations. This is why AI firms focus on reducing per-query costs through custom hardware such as TPUs and by developing leaner, more efficient models such as China’s DeepSeek.

The third area where AI departs from previous tech revolutions is in the weakness and fragility of network effects. Legacy tech platforms benefited from self-reinforcing growth. Buyers and sellers were drawn to Amazon’s marketplace precisely because activity was already concentrated there.

AI users can switch easily between models, use several at once — one for text, another for images, a third for coding — or even build their own. Switching costs are low, and loyalty is weak, making network effects far less influential in determining long-term winners.

For legacy tech companies, the combination of falling marginal costs and network effects amplified the benefits of scale, fueling a race to capture as many eyeballs as possible. That strategy made sense for companies like Facebook, which created value by monetizing consumer attention through

advertising. AI companies confront a different cost structure. Each new iteration of their product requires additional capital investment. Every additional user increases costs, particularly inference costs. While training expenses can be amortized across a larger user base and some economies of scale may emerge, usage growth still leads to higher operating costs.

The fourth difference lies in the shift from market fragmentation to instant saturation. Earlier tech platforms grew within largely siloed markets: Google dominated search; Amazon focused on retail. By seeking distinct niches like college students (Facebook) and professionals (LinkedIn), companies had time to mature before competition intensified. AI, by contrast, is a general-purpose technology that cuts across industries. With users able to gain access to it instantly through apps or application programming interfaces, companies no longer have the luxury of reaching maturity before competitors emerge. This dynamic gives AI the potential to disrupt not just individual sectors but every existing technology business model. Fifth, political influence now matters as much as market power. Earlier innovation waves did not require companies to engage with governments and regulators to the extent AI must. While social media platforms eventually faced scrutiny over their addictive effects, the perceived risks posed by today’s emerging technologies are deeper, and, in many ways, existential, given AI’s potential to cause job displacement, exacerbate inequality, and undermine democratic governance. With AI companies confronting both market forces and political pressures, firms that can shape regulation, influence

public opinion, and absorb reputational risk are better positioned to succeed. Microsoft is a prime example of such a firm. In a clear effort to gain political and social legitimacy, the company recently pledged to cover the electricity costs of its data centers, so that higher prices would not be passed on to consumers. Lastly, AI may be less susceptible to winner-take-all dynamics. Scale, near-zero marginal costs, and strong network effects enabled companies such as Facebook, Google, Amazon, and Apple to dominate social media, search, e-commerce, and smartphones, respectively. The AI sector, at least initially, is unlikely to follow that pattern. Rather than converging on a single monopolistic winner, it could support multiple dominant players, each controlling its own niche. To be sure, an AI company could reach a point at which its technological lead becomes self-reinforcing and effectively insurmountable. Through continuous self-improvement and overwhelming product superiority, or even the development of artificial general intelligence, such a firm could achieve lasting market power, allowing it to dominate the field.

Until then, investors must recognize that AI follows a new strategic logic. Applying legacy technology metrics to this rapidly evolving landscape is not only counterproductive but also potentially costly. Investors who rely on past playbooks risk becoming the losers in today’s AI-driven market. Consider stock-based compensation. Historically, equity incentives enabled tech companies to hire and retain talent, acquire intellectual property, and expand through mergers and acquisitions. But stock options cannot pay for data centers, computing power, or energy infrastructure. To meet these needs, AI companies require real investment, established cash flows, and reliable access to capital markets.

Similarly, investors once tolerated negative margins so long as user growth was robust and advertising revenues were growing. But the uncertainty surrounding AI and the scale of required capital expenditure limit their ability to assess when these investments will break even or how AI-driven transformations will ultimately increase margins. The result is a growing emphasis on strong balance sheets and demonstrable financial resilience. So, the race for AI leadership will not be won by the companies with the most users or fastest growth rates. Instead, the victors will be firms that can combine superior products with financial strength and political influence. In this sense, AI more closely resembles the capital-intensive industries of the mid-20th century than the asset-light tech models of recent years. With operating costs rising and consumers moving easily between models, profitability will depend on capturing elastic demand while translating political capital and regulatory influence into lasting competitive advantage.

Landslide on Indonesia’s Java island kills at least 8 people, leaves more than 80 missing

JAKARTA: A predawn landslide triggered by torrential rains on Indonesia’s main island of Java killed at least eight people on Saturday and left 82 missing as rescuers struggled through deep mud, searching for survivors. Days of torrential rains had caused rivers to burst their banks, tearing through Pasir Langu village in the West Bandung district of West Java province. Mud, rocks and trees tumbled down the mountainside, burying some 34 houses. Rescuers

heavy rain continue to complicate search and rescue operations,” said Teten Ali Mungku Engkun, who heads West Java’s Disaster Management Office.

He said local authorities rapidly assessed the damage and deployed emergency response teams immediately after the landslide. Families living within 100 meters (yards) of the landslide zone were evacuated due to fears of further slope failures. Authorities urged residents in landslide-prone areas to remain vigilant and evacuate



were searching for the 82 residents feared buried under heaps of mud and debris, while 24 people managed to escape the disaster, said spokesperson Abdul Muhari of the National Disaster Management Agency.

Some eight bodies were pulled out in the worst-hit hamlet of Pasir Kuning after the 3 am landslide swept away homes and people. Television stations broadcast footage of workers and residents digging desperately in Pasir Langu, where roads and green-terraced rice fields were transformed into murky brown mud as the village was covered with thick mud, rocks and uprooted trees. “Unstable soil and

In December, catastrophic floods and landslides struck Sumatra, Indonesia’s largest island, killing at least 1,200 people and injuring more than 7,000, the National Disaster Management Agency said. Seasonal rains and high tides from about October to April frequently cause flooding and landslides in Indonesia, an archipelago of more than 17,000 islands where millions of people live in mountainous areas or near fertile flood plains. Last January, more than 20 people were killed after being swept away in floods and landslides caused by torrential rains in Central Java province.

PV Sindhu scripts history with 500th career win at Indonesia Masters

Jakarta, Jan 23: Two-time Olympic medallist PV Sindhu created history on Thursday by becoming the first Indian badminton player to register 500 career wins in women's singles. The landmark achievement came at the Indonesia Masters Super 500 tournament, where she defeated Denmark's Line Hojmark Kjaersfeldt in the round of 16.

Sindhu put up a composed display to secure a straight-games victory, winning 21-19, 21-18. She showed excellent control in crucial rallies, particularly in the closing stages of both games. The win marked her fifth victory in six meetings against Kjaersfeldt, underlining her dominance over the Dane. With this feat, Sindhu has joined an



elite club, becoming only the sixth women's singles shuttler in the world to reach the 500-win milestone. The list includes some of the sport's biggest names such as Ratchanok Intanon, Tai Tzu Ying, Akane Yamaguchi, Carolina Marin and Petya Nedelcheva.

Sindhu's overall career record now stands at 500 wins from 732 singles matches, translating into an impressive win percentage of around 68.3 per cent.

On the BWF Tour alone, she has recorded 456 wins against 227 losses.

The challenge is set to intensify for the world No. 13 Indian in the quarterfinals, where she will face top seed and world No. 4 Chen Yu Fei of China. The Tokyo 2020 Olympic gold medallist is expected to pose a stern test as Sindhu looks to carry her momentum deeper into the tournament. In men's singles, India's Lakshya Sen continued his fine run with a dominant performance. The seventh seed crushed Hong Kong's Jason Gunawan 21-10, 21-11 in just 33 minutes. Fresh from being the only Indian to reach the quarterfinals at the India Open, Lakshya once again looked in complete control.

Sarfaraz Khan's dazzling double century puts Mumbai in command against Hyderabad



Hyderabad, Jan 23: India batter Sarfaraz Khan delivered a breathtaking batting display, smashing a fluent double century to put Mumbai firmly on top against Hyderabad in their Ranji Trophy Elite Group C match at the Rajiv Gandhi International Stadium on Friday. Sarfaraz powered his

way to 227 runs off 219 balls, registering the fifth double hundred of his first-class career. His commanding knock, played at a strike rate of 103.65, was studded with 19 fours and nine towering sixes, underlining his aggressive intent throughout the innings. One of the standout features of his knock

was his dominance against India pacer and Hyderabad captain Mohammed Siraj, from whom he plundered 45 runs off just 39 deliveries, unsettling the opposition attack.

Walking in with Mumbai struggling at 82 for 3, Sarfaraz stitched together a crucial 249-run partnership for the fourth wicket with stand-in skipper Siddhesh Lad, who contributed a composed 104. The duo's effort propelled Mumbai past the 500-run mark and decisively swung the contest in their favour. During the innings, Sarfaraz also crossed the landmark of 5,000 first-class runs.

AUSTRALIAN OPEN: Sinner overcomes Spizzirri, Darderi upsets Khachanov to set up all-Italian affair in round-4



MELBOURNE: Jannik Sinner's Australian Open title defence was pushed to the brink on Saturday, but the World No. 2 dug deep to navigate extreme conditions and a fearless opponent, defeating American qualifier Eliot Spizzirri 4-6, 6-3, 6-4, 6-4 to reach the fourth round at Rod Laver Arena.

Sinner's resilience was tested most severely midway through the match. After splitting the opening two sets, Spizzirri surged ahead 3-1 in the third as Sinner began to visibly struggle with cramping, his movement and service motion clearly compromised in the oppressive Melbourne heat. With the Heat Stress Scale reaching Level 5, officials intervened and ordered the roof closed, triggering a temporary suspension of play.

The short interruption proved pivotal. When play resumed after less than 10 minutes, Sinner looked revitalised. Drawing on his experience and composure, the four-time major champion steadied himself, clawed back the third set, and ultimately completed the victory after three hours and 45 minutes of attritional tennis. For Spizzirri, the match represented a breakthrough moment despite the loss. Playing in the third round of a Grand Slam for the first time, and making his Australian Open main-draw debut, the American showed no hint of intimidation against a Top 10 opponent. He matched Sinner stroke for stroke from the baseline for long stretches, striking freely and taking the fight to the defending

champion. Statistically, the contest was messy and demanding. The first three sets alone lasted nearly three hours, with Sinner committing 46 unforced errors. The decisive margin came on break points: Sinner converted eight of 11 opportunities, while Spizzirri managed just six of 16, including only one from six chances in the third set, a missed opening that allowed Sinner to wrest back control while battling physical distress.

Even after the mandated 10-minute heat break following the third set, Spizzirri refused to fade, again breaking first to lead 3-1 in the fourth. But Sinner's poise under pressure proved decisive, as he reeled off games with controlled aggression to seal the win and book a fourth-round meeting with fellow Italian Luciano Darderi, their first career matchup. Darderi arrived with momentum of his own. The 23-year-old produced one of the standout results of the tournament and scripted history by upsetting 15th seed Karen Khachanov 7-6(5), 3-6, 6-3, 6-4 to reach the second week of a Grand Slam for the first time in his career. Currently ranked No. 25, the Argentine-born Italian showcased a rapidly evolving all-court game on Melbourne's hard courts, outlasting the former Australian Open semifinalist in a high-quality encounter. After edging a tense opening-set tiebreak, Darderi briefly lost momentum as Khachanov claimed the second.

Dhoni back in the nets as CSK icon gears up for IPL 2026

Ranchi, Jan 24: Former India captain Mahendra Singh Dhoni has officially begun preparations for the Indian Premier League 2026, signalling yet another season with Chennai Super Kings, the franchise he has represented since the league's inception. The 44-year-old was recently spotted batting in the nets, fully padded up, in a video shared by the Jharkhand State Cricket Association (JSCA) on social media.

Welcoming their most celebrated cricketer, JSCA described Dhoni as their pride, captioning the Instagram post: "Look who is back. Pride of JSCA: Mahendra Singh Dhoni." The clip also showed Dhoni in a relaxed mood, chatting with JSCA secretary and former India batter Saurabh Tiwary before stepping into practice.



Dhoni, who stepped away from international cricket in 2020, continues to remain active in the IPL, where his association with CSK has become one of the league's most enduring

legacies. Heading into his 17th season with the Chennai-based franchise, he remains a vital figure in the team's leadership group and a guiding force in the dressing room.

Under Dhoni's captaincy, CSK have lifted the IPL trophy five times, establishing themselves as one of the most successful teams in tournament history. However, the previous season proved challenging, with the five-time champions finishing at the bottom of the points table after managing just four wins in 14 matches.

Individually, Dhoni also endured a difficult campaign. The veteran finisher scored 196 runs in 13 innings at an average of 24.50 and a strike rate of 135.17, with a highest score of 30 not out. He also briefly took over the captaincy in the absence of regular skipper Ruturaj Gaikwad due to injury.

Despite the dip in recent form, Dhoni's IPL record remains exceptional. He has amassed

5,439 runs in 278 matches at an impressive average of 38.80 and a strike rate of 137.45, including 24 half-centuries and a career-best score of 84 not out.

Widely regarded as a modern-day great, the legendary wicket-keeper-batter led India across all three formats and guided the national side to historic triumphs, including the inaugural T20 World Cup in 2007 and the ODI World Cup in 2011. Dhoni's illustrious career has been recognised with the Padma Shri, Padma Bhushan, and the Major Dhyani Chand Khel Ratna Award. As the IPL 2026 season approaches, Dhoni's return to training has reignited excitement among fans, who will once again hope to see the iconic captain-scriptwriter produce another memorable chapter in yellow.

On Khelo India Winter Games debut, Kerala's Abhijith Amal Raj returns to ice and brings more than winning gold

Leh (Ladakh), Jan. 24: When figure skating made its debut at the Khelo India Winter Games 2026 in Ladakh, it was more than the introduction of a new discipline, it was the arrival of a long-missing national platform. Standing at the centre of that moment was Abhijith Amal Raj from Kerala, who went on to win gold in figure skating-men's advance category, marking a personal milestone. Abhijith's presence in Ladakh carried weight far beyond a single competition. He is already one of India's most accomplished artistic figure skaters—a world champion in artistic roller skating, having won gold at the World Roller Skating Championship in 2019, along with Gold at the Asian Roller Skating Championships in 2023 and 2025, and the World Skate Oceania and Pacific Cup in 2023. Yet his appearance at Khelo India Winter Games 2026 represented something different, a return to figure skating on ice, and the chance to compete on a serious national stage at home.

Abhijith's journey began almost as soon as he could walk. He wore skates before he could properly speak, starting formal training at the age of three. But in coastal Kerala, ice skating was neither common nor accessible. The cost of equipment, coaching, and infrastructure quickly turned talent into a test of endurance and financial requirements.



His father chose to invest everything into his training.

By the age of nine, Abhijith already had an Arjuna awardee Anup Kumar Yama training him and later was trained by 11 times Artistic Roller Skating World Champion and international coach, Luca d'Alisera for which we had to go to Italy. That coaching costed 100 Euros an hour, four hours a day with expenses running into lakhs for just a month. To sustain this, his family sold property and moved into rented accommodation. Government support came later, but the foundation of Abhijith's career was built on years of finan-

cial strain and personal sacrifice.

Before his rise as an artistic roller skating world champion, Abhijith had already built a strong record in ice figure skating. In 2014, he won gold at the Asian Open Figure Skating Trophy in Taiwan, the Dubai Golden Cup, and the Malaysian Open National Championship, along with national titles in 2013 and 2014. He added another international gold in Malaysia in 2016 before shifting his primary focus to roller skating, where he eventually reached the top of the world podium. His figure skating gold at the Khelo India Winter Games 2026 marked a comeback

to ice skating after nearly a decade.

Abhijith's story reflects the challenges faced by niche sports like figure ice skating in India. For years, meaningful progress in disciplines such as figure skating required going abroad—for rinks, coaching, and competitive exposure—an option most families could not afford. Today, at just 24, Abhijith is working to change that reality.

Along with his figure skating partner, Vacasya Lakshmi Narayanan, a gold medalist (Artistic Partner) at the Asian Roller Skating Championship, 2025, he co-founded Adler Vision,

enrolling future athletes pan India based in Kerala and Tamil Nadu. Since its inception two years ago, the academy has enrolled more than 100 students.

They have invited international coaches like Luca d'Alisera and Rachele Campagnol from Italy so young skaters can gain exposure without leaving the country, beginning with roller skating and with the eventual aim of transitioning athletes to figure skating on both roller and ice, and preparing them for national platforms like Khelo India.

Abhijith says that at the academy they "start with roller skating, and based on a skater's interest and performance, they can move into ice skating or continue to excel in roller skating."

"Our skaters have already participated in multiple national and state-level roller skating competitions, and with platforms like Khelo India, we plan to send select skaters to upcoming ice skating championships," said Abhijith, who was recruited by the Income Tax department of Maharashtra under sports quota in 2024.

For Abhijith Amal Raj, Khelo India is therefore not only about medals. He calls it a "prestigious championship", and says his main purpose in Ladakh is to motivate athletes at his academy and show them that meaningful national platforms. With figure skating introduced for the first time, the 6th edition of the Khelo India Winter Games featured 23 skaters from eight states with the highest from Haryana (8), followed by Andhra Pradesh (4) and Uttarakhand (4). This is an encouraging beginning for a winter sport in a largely tropical country like India.

ICC e-mails Bangladesh board about "replacing" them with Scotland from T20 WC



NEW DELHI: The ICC has officially told Bangladesh Cricket Board about replacing them with Scotland in the upcoming T20 World Cup since it refused to travel to India citing security reasons due to ouster of Mustafizur Rahman from the IPL.

It has been learnt that top ICC officials including chairman Jay Shah were in Dubai on Friday and late evening an e-mail was sent to BCB chairman Aminul Islam Bulbul informing him about global body's decision.

"An e-mail was sent last evening to Bangladesh

Cricket Board chairman intimating him that his board didn't get back to ICC officially after the 24 hour deadline that was given to them to decide if they wanted to come to India. The BCB did a press conference in Dhaka before officially intimating the global body which is a violation of protocol. They have been categorically told that they are being replaced," an ICC source told PTI on conditions of anonymity.

It must be noted that it is Bangladesh's sports ministry advisor Asif Nazrul, who has unilaterally taken

a decision against national team travelling to India, citing security issues despite being given repeated assurances by the ICC.

While Cricket Scotland has maintained that they haven't received any official confirmation but it seems that it is only a matter of time before they will be given greenlight. Scotland will thus play their four group league games against West Indies (February 7), Italy (February 9) and England (February 14) in Kolkata followed by a game against Nepal in Mumbai on February 17.

Naomi Osaka withdraws from Australian Open before third-round match

MELBOURNE: Naomi Osaka withdrew from the Australian Open before her scheduled third-round match against Australian qualifier Maddison Inglis on Saturday, ending a campaign noted for fashion and friction.

The two-time Australian Open champion announced it on social media without divulging her injury, posting on

Instagram that she had to withdraw "to address something my body needs attention for after my last match." "I was so excited to keep going and this run meant the most to me, so having to stop here breaks my heart," Osaka posted, "but I can't risk doing any further damage so I can get back on the court."

A year ago at Melbourne Park, Osaka retired from

her third-round match against Belinda Bencic because of a strained abdominal muscle. Australian Open officials have not commented on Osaka's withdrawal Saturday. Osaka's grand entrance to the tournament earlier this week went viral, when she walked onto the court for her first-round match wearing a wide-brim hat, a
