Indian Army restores key Sri Lankan highway with third Bailey bridge after cyclone damage

New Delhi (TSIT): The Indian Army has completed the construction of a third Bailey bridge on Sri Lanka's B-492 Highway, re-establishing a crucial transport corridor between Kandy and Nuwara Eliya that had remained disrupted for more than a month in the wake of Cyclone Ditwah.

Built at KM 15, the 120-foot-long bridge was erected by the Indian Army's Engineer Task



aimed at restoring critical infrastructure damaged by the cyclone.

Announcing the development on social media platform X, the Indian Army said its engineers had earlier launched two Bailey bridges in the Jaffna and Kandy regions and have now successfully completed the third structure in Sri Lanka's Central Province. The Army noted that the bridge reconnects the Kandy and Nuwara Eliya districts, reviving a vital link that had been cut off since the disaster.

Sammakka-Sarakka tribal shrine gets a permanent facelift

Every two years, on the full moon days of Magha, the dense forests of Medaram in Mulugu district transform into a vast spiritual congregation. The Sammakka-Sarakka (Sarakka) Medaram Maha Jatara, regarded as Asia's largest tribal fair, draws lakhs of devotees from Telangana and neighbouring States. Often described as the "Telangana Kumbh Mela", the four-day jatara—a rare confluence of faith, history and tribal identity.

This year's jatara has assumed added significance with the comprehensive reconstruction and permanent development of the Medaram Sammakka-Sarakka tribal shrine. Chief Minister A. Revanth Reddy is scheduled to inaugurate



the renovated shrine on January 19, marking a major milestone in the pres-

A legacy rooted in resistance

The origins of the Medaram jatara are said to be deeply intertwined with the history of tribal resistance during the Kakatiya period, often remembered as the golden age of Telugu history. During the reign of Kakatiya ruler Prataparudra, the Koya tribals are believed to have fought against oppression, laying down their lives to protect their autonomy and rights. The jatara is held in memory of Sammakka and Sarakka, who are venerated not as conventional idols but as living spirits of sacrifice and resistance. Over centuries, this remembrance has evolved into a massive spiritual gathering, where devotees offer prayers

seeking fulfilment of vows, prosperity and protection.

From temporary arrangements to permanent structures

For decades, infrastructure at Medaram was largely temporary, with crores of rupees spent ahead of every jatara on makeshift facilities. That approach has now given way to permanent reconstruction aimed at preserving the shrine for generations. With the consent of tribal elders and the priests' association, the State government undertook large-scale development works to ensure durability while adhering strictly to tribal customs and traditions. The transformation is visible across the shrine complex, where permanent granite structures have replaced temporary installations.

US will seek 'separate' semiconductor tariff pacts for countries: Official



Washington (TSIT) : US President Donald Trump's administration will seek "separate" semiconductor tariff agreements for "separate countries," a U.S. official said, after the United States and Taiwan reached a deal on the chip levies this week. "Separate agreements for separate countries," a U.S. official said, responding to a question from Yonhap News Agency regarding whether the deal with Taiwan would set a standard for chip tariffs or the U.S. would conduct separate negotiations with other countries for the sectoral tariffs.

The official's remarks came a day after the U.S. Commerce Department released a fact sheet about a trade and investment deal between the United States and Taiwan, which outlined a bilateral agreement on

semiconductor tariffs. According to the fact sheet, Taiwanese companies building new U.S. semiconductor capacity may import up to 2.5 times that planned capacity without paying sectoral duties during the approved construction period.

Taiwanese companies that have completed new chip production projects in the U.S. will still be able to import 1.5 times their new U.S. production capacity without paying sectoral duties. The agreement on the chip tariffs raised questions over whether it will set a standard for chipmakers from other countries, includ-

ing South Korea. On Wednesday, Trump signed a proclamation to levy a 25 percent tariff on certain semiconductors for artificial intelligence (AI), which are imported into the U.S. and then reexported to other countries.

The White House has also said that Trump may impose "broader" tariffs on imports of semiconductors and their derivative products. The president has rolled out various industrywide tariffs, invoking Section 232 of the Trade Expansion Act of 1962, a law that provides the president with the authority to adjust imports into the U.S. when he determines they threaten to impair national security. South Korea's top trade envoy assessed the Trump administration's proclamation on semiconductor tariffs to have a "limited" impact on local chip makers.

Complete planetarium renovation works at earliest: Warangal Mayor



Warangal: City Mayor Gundu Sudharani on Saturday directed officials to expedite and complete the renovation works of the planetarium at the earliest. The Mayor, along with Greater Warangal Municipal Corporation (GWMC) Commissioner Chahat Bajpai, inspected the ongoing development works at the planetarium located in the Baldia premises. During the field-level inspection, the Mayor and Commissioner reviewed the progress and issued necessary instructions to ensure timely completion of the project. Officials informed the Mayor that the renovation works had reached the final stage. They said that interior works have been completed and the civil works have also been finished, with only a few remaining works pending. Emphasising the importance of completing the project on priority, Mayor Gundu Sudharani directed the officials to take up the remaining works on a war footing so that the planetarium can be made ready for public use at the earliest. Executive Engineer Ravi Kumar, Deputy Engineers Raj Kumar and Ragi Srikanth, Assistant Engineers Santosh Kumar and Naresh, along with other officials, were present during the inspection.

Ward reservations finalised for Wardhannapet and Narsampet municipalities



Warangal: The ward reservation process for Wardhannapet and Narsampet municipalities was completed on Saturday through a lottery system at the conference hall of the District Collector's office. In the presence of representatives of recognised political parties, District Election Officer and District Collector Dr. Satya Sharada allotted reservations to municipal election wards by drawing lots, following Election Commission guidelines. For Wardhannapet Municipality, which has 12 wards, reservations were allotted as follows: ST – wards 2, 7 and 8; SC – wards 1 and 12; BC – ward 11; and General – wards 3, 4, 5, 6, 9 and 10. In accordance with the 50 per cent reservation for women, wards 2, 4, 5, 9, 10 and 12 were earmarked for women candidates. In Narsampet Municipality, which has 30 wards, ST reservation was allotted to wards 12, 13 and 16; SC to wards 5, 22, 23 and 30; BC to wards 3, 8, 19, 24, 25, 27 and 29; and General category to wards 1, 2, 4, 6, 7, 9, 10, 11, 14, 15, 17, 18, 20, 21 and 26. As per the 50 per cent women reservation norm, wards 12, 5, 23, 8, 25, 27, 28, 1, 2, 9, 11, 14, 18, 20 and 26 were reserved for women.

Nalgonda to Be Developed as a Super Smart City Minister Komatireddy

Hyderabad: State Roads & Buildings and Cinematography Minister Komatireddy Venkat Reddy on Saturday announced that Nalgonda will be developed as a Super Smart City, leveraging its new status as a Municipal Corporation and ensuring large-scale infrastructure development on par with Hyderabad.

Addressing a gathering after laying the foundation stones for development works worth 18.70 crore at the Nalgonda Municipal Corporation, the Minister said that nearly 2,000 crore has already been spent on the town's development over the last two years. He assured that the government is ready to mobilise another 2,000 crore, if required, to fulfil the growing aspirations of the people.

Stating that he would leave no stone unturned for the people who had "embraced him with affection," the Minister thanked Chief Minister A. Revanth Reddy for upgrading Nalgonda into a Municipal Corporation. He said the new status would facilitate direct Central funding and enable faster execution of



urban infrastructure projects. AP govt. to expand coffee cultivation on another one lakh acres

Vijayawada, Jan 17 (UNI) The Andhra Pradesh Government has taken steps to expand the coffee cultivation on one lakh acres more in the Paderu agency area.

According to official sources, coffee crops are cultivated on over 2.50 lakh acres at Paderu, Araku and Chintapalli regions in the combined Visakhapatnam district.

Chief Minister N Chandrababu Naidu agreed to bring another one lakh acres under coffee cultivation in the regions in the next five years. The government will encourage farmers to take up coffee cultivation by providing incentives.

The government is to spend Rs 202 crore to bring one lakh acres into coffee crop cultivation during the next five years. Andhra Pradesh State stands in third place in coffee cultivation after Karnataka and Kerala. The government aims to keep Andhra Pradesh in second place in coffee cultivation by 2031, sources added.

According to official sources, coffee crops require adequate shade without direct sunlight.

Out of the newly undertaken one lakh acres of cultivation expansion, 60,000 acres will be made available under the shade plantation system. Silver oak, mango, apricot and jackfruit plants will be raised and coffee crops will be grown under their shade. The VB-G RAM G scheme will be synchronized to the coffee cultivation. Shade plantation has been completed in 30 acres of land so far, sources added.

Officials said the government is providing 1000 coffee saplings to the farmers at free of cost to encourage them to take up coffee cultivation. The government also gives 200 pepper plants to the farmers to raise them as an intercrop in the coffee orchards. The government assured to make available two coffee pulping units at a cost of Rs 7 crore at G Madugula.

Future of Mumbai at crossroads, struggle for Marathi Manoos will continue: Shiv Sena (UBT) in Saamana



Mumbai, Jan 17: The Shiv Sena (UBT) on Saturday said that the future of Maharashtra's capital Mumbai and the identity of the Marathi Manoos stand at a critical juncture following what it termed as chaotic and controversial results of elections to the Brihanmumbai Municipal Corporation and 28 other civic bodies.

In a strongly worded editorial in the party mouthpiece Saamana, the Thackeray camp alleged large-scale electoral irregularities, including EVM manipulation, voter bribery and bogus voting, as counting stretched late into the night. It posed a pointed question: who will now protect the interests of the Marathi Manoos in Mumbai?

The editorial said the electoral setbacks suffered by the Shiv Sena (UBT) and the Maharashtra Navnirman Sena (MNS) were not merely political losses but amounted to a betrayal of Mumbai's heritage. Those responsible for weakening regional forces, it claimed, had effectively "traded away" the legacy built on the sacrifices of the city's martyrs.

Referring to the 106 martyrs of the Samyukta Maharashtra movement, the editorial said they would not merely mourn the present situation but would demand a renewed struggle to safeguard Mumbai's soul. Despite "extremely adverse circumstances", the Shiv Sena and MNS fought a close contest, it said, adding that the fight to protect Mumbai and Marathi identity is far from over.

According to Saamana, a BJP wave was engineered across 26 municipal corporations, enabling "opportunistic political elements", including the Eknath Shinde-led faction of the Shiv Sena, to gain power. The editorial claimed that the absence of ideology and principles among such groups could render future elections meaningless. It further alleged that hundreds of voters were deprived of their voting rights while the Election Commission remained inactive.

The gaddelu (sacred platforms) are being rebuilt with stone to withstand time, drawing inspiration from historical monuments. Officials say the reconstruction has been designed to last at least 200 years. The work includes expansion of the gaddelu, construction of a granite enclosure wall, and installation of multiple welcome arches, all of which are nearing completion.

Culture and history carved in stone

One of the most striking aspects of the redevelopment is the artistic narration of Koya tribal culture through stone. Thirty-two granite pillars erected around the gaddelu have been intricately carved with motifs depicting tribal life, customs and history. Sculptures of animals revered by the Koyas—such as tigers, deer, elephants, peacocks and crocodiles—share space with symbols of daily life, including cart wheels, the sun, moon and trident. According to the claims, the carvings are based on 930-year-old Koya palm-leaf manuscripts, lending historical authenticity to the work. Names of nearly 750 Koya clans and about 250 families believed to be descendants of Sammakka and Saralamma have been engraved on stone, allowing future generations to trace their lineage and heritage. More than 7,000 sculptures have been installed across the premises. About 4,000 tonnes of granite have gone into the reconstruction, with white stone sourced from Rayachoti sculpted in Allagadda of Nandyal district of the neighbouring Andhra Pradesh, and transported to Medaram. Nearly 450 artists worked for months to complete the carvings.

Infrastructure with ecological sensitivity

The redevelopment extends beyond the shrine to the surrounding landscape. Roads leading to Medaram have been widened from 60 feet into four lanes, with improved queue lines, inns, watchtowers, drainage and flood management systems. Special attention has been paid to parking facilities, with arrangements to accommodate thousands of vehicles simultaneously near the gaddelu. Importantly, the works have been carried out without removing existing trees. The shrine premises hosts 12 types of sacred trees, including banyan, bamboo, neem and Mahua (ippa). The government has also planned the plantation of 140 varieties of medicinal plants, reinforcing the ecological and cultural ethos of the site.

Modern planning for a traditional gathering

Learning from large congregations such as the Maha Kumbh Mela, a team of experts visited Medaram to study crowd movement, access routes and pressure points, offering suggestions to the authorities. A drone show is planned as a special attraction during the four days of the jatara, along with cultural programmes and a documentary chronicling the festival.

Rs.251 crore for comprehensive development

The State government has sanctioned Rs.251 crore for the comprehensive development of Medaram, of which Rs.101 crore has been allocated exclusively for expansion of the gaddelu. The main gaddelu enclosure spans 271 square metres with 46 pillars, while a circular gaddelu with eight pillars forms the spiritual core. The complex will feature three welcome arches of 40 feet width, five arches of 30 feet, and a grand main arch spanning 50 feet at the entrance. Officials emphasise that every stage of construction has been undertaken with the approval of the priests' association, ensuring that modern infrastructure does not dilute the sanctity of tribal traditions.

A record in preservation

The scale and permanence of the redevelopment mark an unprecedented effort in the history of the Medaram jatara. By embedding tribal history, lineage and belief systems in stone, the project seeks not merely to facilitate a fair, but to preserve a living cultural archive. As Medaram prepares to host lakhs of devotees once again, the renewed shrine stands as a testament to the enduring legacy of Sammakka and Saralamma—and to a conscious attempt to honour tribal faith through respectful, lasting development.

Centre warns sleeper bus operators as deaths mount over safety lapses

New Delhi, Jan 17: With nearly 145 people losing their lives in sleeper bus accidents over the past four months, the Centre has taken a tough stand on safety violations, warning operators and manufacturers that non-compliance will no longer be tolerated and repeat offenders will be forced off the roads.

Secretary to the Union Ministry of Road Transport and Highways, V Umashankar, termed sleeper bus safety a "very serious" concern and said the Ministry's review of recent accidents has revealed systemic failures in manufacturing, fitness certification and ground-level enforcement.

"When it comes to the lives of people, enforcement of rules on the ground has to be tight," Umashankar said, stressing that those found flouting safety norms must face licence cancellation and a complete ban from operations. He said one of the



key issues flagged relates to the manufacturing of sleeper buses, with authorities now examining whether safety regulations were properly followed at the time of construction. A new Bus Body Code, which came into force on October 1, 2025, mandates stricter design and safety standards for all newly registered buses to reduce risks such as fires. In view of the rising death toll, the Ministry is considering even tougher measures, including allowing bus manufacturing only through Original Equipment Manufacturers to eliminate unsafe, unauthorised fabrication practices.

Another major concern is the failure of fitness testing and enforcement by state authorities. Referring to a deadly sleeper bus fire in Rajasthan, Umashankar said the incident exposed serious lapses, with unauthorised alterations being carried out even after the vehicle had cleared mandatory fitness checks. Union Road Transport Minister Nitin Gadkari has advised states to move towards automated fitness testing to reduce human intervention and improve transparency.

The Ministry has also flagged unauthorised alterations made after fitness certificates are issued. Citing an accident in Andhra Pradesh, Umashankar said multiple modifications were found to have been carried out post-certification, underscoring the need for stricter compliance and more vigilant enforcement by transport authorities and police.

Teen dies in Shahdol house fire, mother escapes

Bhopal, Jan 17: A tragic fire in Kathautia village, Shahdol district, Madhya Pradesh, claimed the life of 19-year-old Amit Patel on Friday, while his mother miraculously escaped.



The family lived in a modest single-story mud house. According to Raghvendra Tiwari, investigation officer and Station House Officer of Kotwali police station, Amit returned home around 11 p.m., had dinner, and went to his room. Around midnight, flames quickly engulfed the house, fueled by flammable materials. His mother, sleeping in a nearby room, woke to the fire and managed to flee, raising an alarm.

Neighbours alerted the police and fire brigade, who rushed to the scene. Despite their efforts, Amit could not be rescued. "By the time rescuers reached his room, he had succumbed to severe burns. His charred body was recovered and sent for post-mortem and forensic

examination," said the officer. Preliminary investigations suggest the fire may have been caused by an angithi (traditional brazier) or a candle, as the house had no electricity due to unpaid bills and temperatures were low. An electrical short circuit is also being examined, though no foul play is suspected.

The Naib Tehsildar of Sohagpur tehsil coordinated immediate relief for Amit's mother, arranging temporary shelter and food. Authorities have urged residents to exercise caution with open flames and ensure proper ventilation during winter. A case has been registered, and investigations are ongoing to determine the exact cause of the fire.

Rahul meets Bhagirathpura victims as CM Yadav hits back



Indore, Jan 17: Congress leader Rahul Gandhi arrived in Indore on Saturday to meet families and patients affected by the recent outbreak of vomiting and diarrhoea linked to contaminated water in the Bhagirathpura area.

Gandhi visited patients undergoing treatment at Bombay Hospital, including several in critical condition, and interacted with their family members till around 12.15 pm, enquiring about their health and well-being. He is also scheduled to visit Bhagirathpura to meet affected families and understand their concerns, before departing for Delhi later in the day. Reacting

sharply to Gandhi's visit, Madhya Pradesh Chief Minister Mohan Yadav criticised the Congress leader, accusing him of politicising the tragedy. "Rahul Gandhi should go to Karnataka, where his party is in

power and where 20 people have died. He did not show concern for Hyderabad. Thousands lost their lives in Bhopal during the gas tragedy under Congress rule, and the responsibility of letting Anderson escape lies with the Congress," Yadav said. The chief minister asserted that the state government was focused on people-centric governance and swift action following the Bhagirathpura incident. "For the first time since Independence, our government has suspended an IAS officer after this incident. Action has been taken against all five accused. In times of grief, the government stands sensitively

Vande Mataram's 150 years to be major theme of Republic Day Parade 2026



New Delhi: The sesquicentenary of 'Vande Mataram' will be the dominant theme of this year's Republic Day Parade, with enclosure backdrops along the Kartavya Path displaying old paintings illustrating the opening stanzas of the National Song and floral artworks at the main stage paying homage to its composer Bankim Chandra Chatterjee.

In a departure from traditional practice, 'VVIP' and other labels, used earlier for enclosures at the parade venue, will not be used. Instead, all enclosures have been named after Indian rivers, senior officials of the defence ministry said on Friday, January 16.

These include Beas, Brahmaputra, Chambal, Chenab, Gandak, Ganga, Ghagra, Godavari, Sindhu, Jhelum, Kaveri, Kosi, Krishna, Mahanadi, Narmada, Pennar, Periyar, Ravi, Sone, Sutlej, Teesta, Vaigai, and Yamuna, they said. Similarly, for the Beating Retreat Ceremony on January 29, enclosures will be named on Indian instruments—bansuri, damaru, ektaara, esraj, mridangam, nagada, pakhawaj, santoor, sarangi, sarinda, sard, shehnai, sitar, surbahar, tabla and veena.

President of the European Commission, Ursula von der Leyen, and President of the European Council, Antonio Costa, will be the chief guests at the parade. Defence Secretary R K Singh, in a press briefing at the South Block, shared the broader contours of the 77th Republic Day celebrations that will see many firsts this time. The theme this year is 150 years of 'Vande Mataram' and the parade will celebrate it. The invitation cards will carry the logo of its sesquicentenary and a bunch of balloons carrying a banner themed on 'Vande Mataram' will be released in the air at the end of the parade.

Also, band performances by the military and the Central Armed Police Forces (CAPFs) are being held from January 19-26 on the theme of 'Vande Mataram' at around 235 locations in over 120 cities, he said. These will include bands by the Army, the Navy, the Indian Air Force, and the Indian Coast Guard.

The performance venues will also include the ancestral home and birthplace of Bankim Chandra Chatterjee at Kanthalpara, Naihati, in North 24 Parganas District of West Bengal, presently known as Bankim Bhawan Gaveshana Kendra (also referred to as Rishi Bankim Chandra Chattopadhyay's Residence and Museum or Bankim

As in previous years, various competitions, contests, and quizzes were conducted on the 'MyGov' and 'MyBharat' portals on the theme of 'Vande Mataram' and 'Atmanirbhar Bharat', which received a total participation of 1,61,224, the ministry said in a statement later.

In addition to cash prizes for the top 30 winners, the top 200 winners have been invited to witness the parade, the officials said.

Also, nearly 2,500 cultural

artistes will perform on Kartavya Path in this year's parade, the ministry said.

Around 10,000 people from all walks of society have been invited to witness the event at Kartavya Path as 'special guests' this year.

People with exemplary work in connection with income and employment generation, technology, innovation, start-ups, self-help groups, and best performers under key government initiatives have been identified with the help of the departments concerned and invited to witness the ceremony.

These include winners of the World Athletic Para Championship, farmers practising natural farming, transgender and beggar rehabilitated under the PM-SMILE scheme, best performing scientists or technical persons involved in recent ISRO missions like Gaganyaan and Chandrayaan, and participants of 'Mann ki Baat', the ministry said.

"In order to ensure maximum Janbhagidari, the number of seats for the public has been increased. Accordingly, the number of tickets for the public has been increased, which were available for online booking through 'Aamantaran' portal as well as 'Aamantaran App' and through offline counters at various locations, including two major DMRC stations, from January 5-14," it said.

A post-event 'Swachhata' campaign in coordination with MyBharat volunteers and NCC cadets covering a whole stretch of Kartavya Path has been planned and will be operated accordingly, it added. What Democracy Do We Seek?

The Supreme Court judgement in the Delhi riots bail matter has had predictable reactions. Whilst the government side has expressed satisfaction at two accused not being granted bail, the other side has noted the bail granted to five accused with satisfaction but obviously expressed distress at the denial of bail to Umar Khalid and Sharjeel Imam. The common ground for bail was the long delay of six years with arguments still stuck on framing of charges.

Beyond the 'who got bail, who did not' conundrum of concern, there are serious issues that have emerged in the judgment: first, the relationship between failure of the right to speedy trial and extent of alleged involvement, and second, the judicially expanded definition of terrorism. It is not as if the matter was res integra as lawyers call an area of law not before pronounced upon by courts of law.

The Supreme Court has on several occasions examined how traditional categories of law enforcement regarding law and order, public order etc are separated from national security issues, and obviously, the latter is of paramount concern and inevitably linked with terrorism. These judgments were extensively examined by the Delhi high court in Asif Iqbal Tanha's case but directed by the Supreme Court on the state's appeal, not to be treated as precedents.

The ostensible reason was that the Supreme Court felt that in deciding bail matters, the courts should not delve into detailed discourse on legislation. Yet, in the present case, the 162-page judgment seems to do the same. It is important to know that the senior counsel who argued for the petitioners, keeping in mind the Asif Tanha matter, decided to restrict their arguments to relevant facts but were encountered by extensive arguments by the prosecution in response.

In dealing with the instant judgment, it is only fair to underscore the lip service that the court gave to Article 21 and the right to liberty. Of course, it was right to point out that Article 21 is not qualified and thus requires to make accommodation for national security issues: "At the same time, Article 21 has never been understood as operating in isolation from law. The constitutional promise is not that liberty will be unregulated, but that deprivations of liberty will not be arbitrary, unconscionable, or unfair. The expression "procedure established by law" reflects that balance. The UAPA, as a special statute enacted to address offences alleged to affect the security of the State and the stability of civic life, represents a legislative judgment as to the conditions under which bail may be granted at the pre-trial stage. Section 43D(5) of UAPA embodies the exercise of that judgment." "There is a further constitutional aspect that warrants articulation. Article 21 protects individual liberty. It also, within the same guarantee of life, reflects the State's obligation to protect the life and security of the community. In prosecutions alleging threats to public order and national security, the Court cannot be unmindful that both dimensions are engaged. The constitutional order is not served by an approach that treats liberty as the sole value and societal security as peripheral. Both must be accommodated through reasoned adjudication." There was no discussion on how the individual liberty-national security conundrum is to be resolved. Gross inconvenience to other individuals cannot be taken as part of a utilitarian calculus if rights are to mean anything. Temporary disruption of supply chains cannot be treated as economic security at risk or else any protest would be said to be damaging national security: "Section 15 of the Act defines what constitutes a "terrorist act" for the purposes of the statute. The definition is structured around two essential elements. First, the act must be done with intent to threaten, or be likely to threaten, the unity, integrity, security, including economic security, or sovereignty of India, or with intent to strike terror in the people or any section thereof. Second, the act must be of such a nature as to cause, or be likely to cause, the consequences enumerated in the provision.

Mumbai Polls: How The 'Marathi Manoos' Campaign Ended Up Uniting Others Against It



The Brihanmumbai Municipal Corporation (BMC) elections have delivered a stunning blow to the Thackeray legacy, as the Mahayuti alliance stormed what was once considered an impregnable Shiv Sena bastion. For the first time in the civic body's history, the Bharatiya Janata Party (BJP) is poised to secure the mayor's post, marking a seismic shift in Mumbai's political landscape. While the BJP-plus-Shiv Sena (Shinde) alliance secured 118 seats, (4 more than majority mark of 114), the Thackeray brothers SHS-UBT, MNS and NCP-SP alliance bagged 72 seats, with the Congress chipping in with 24 seats.

The Crumbling of a Fortress

The BMC, long controlled by the undivided Shiv Sena and later by Uddhav Thackeray's faction, has been the cornerstone of Marathi pride and Shiv Sena's political dominance in India's financial capital. Mahayuti's victory represents not just an electoral defeat but the symbolic sunset of Thackeray influence in Mumbai's civic administration. The alliance's commanding performance has given the BJP its first realistic shot at occupying the mayor's chair, a position that controls one of Asia's richest municipal corporations, with an annual budget running into thousands of crores, higher than many small and north eastern states of India. The defeat comes despite an unprecedented alliance between the estranged Thackeray cousins who came together after a gap of 20 years. Uddhav Thackeray's Shiv

Sena (UBT) and Raj Thackeray's Maharashtra Navnirman Sena (MNS) joined forces along with Sharad Pawar's NCP faction, betting that their combined appeal would consolidate the Marathi vote and present a formidable challenge to the Mahayuti juggernaut. Instead, the results have exposed the limitations of identity politics in an increasingly diverse and aspirational Mumbai.

The Marathi Card Falls Flat

The most striking revelation from the election data is the failure to consolidate even the Marathi vote bank. Despite the alliance between UBT and MNS, the Shinde faction of Shiv Sena secured 29 seats mostly in Marathi dominant / influenced seats and in direct head to head contests against each other, showcasing Shinde, too, has earned a slice of the Marathi Manoos votebank. This is a failure of strategy built entirely on linguistic and regional identity. The Marathi manos, it appears, is no longer voting as a monolithic bloc driven solely by cultural pride or fear of outsiders. The Thackeray brothers miscalculated the aspirations of a new generation of Marathi voters-educated, middle-class professionals who prioritize development, infrastructure, and economic opportunities over identity-based appeals. These voters remember the MNS's violent campaigns against north Indians and south Indians, the disruption of businesses, and the creation of an atmosphere of intimidation. While such tactics may

have won applause from certain quarters in the past, they have increasingly alienated moderate Marathi voters who see themselves as part of a cosmopolitan Mumbai rather than a besieged linguistic community.

The Muslim Vote Conundrum

Equally problematic was the alliance's inability to secure Muslim votes, which remained largely with the Congress and parties like the AIMIM, the NCP and the SP. The Thackeray camp had assumed that Muslims would vote strategically for whichever party was best positioned to defeat the BJP. This calculation ignored the deep historical scars left by the Shiv Sena's role during the Babri Masjid demolition and the subsequent Mumbai riots of 1992-93.

Raj Thackeray's past rhetoric and the original Shiv Sena's history made it difficult for Muslim voters to trust the Thackeray alliance, regardless of current political expediency. The community chose to stick largely with the Congress and ethnic parties like AIMIM/SP, even if it meant splitting the opposition vote. This led to failure of the strategy of consolidating the 40% Marathi Manoos and 20% Muslim community vote.

The Counter-Consolidation

Perhaps the most consequential outcome of the Thackeray strategy was the counter-consolidation it triggered. Non-Marathi voters - estimated at 40% - overwhelmingly backed the Mahayuti. The speeches and histori-

cal record of Raj Thackeray, who built his political career targeting south Indians, north Indians, and Gujaratis, came back to haunt the alliance.

Mumbai's demographic transformation over the past two decades has been dramatic. The city is now home to millions of migrants from across India who have made significant economic and social contributions. These communities felt directly threatened by the Thackeray alliance's rhetoric and voted decisively to keep them out of power. The irony is stark: campaign built on Marathi identity ended up uniting everyone else against it.

Development Trumps Identity

Devenendra Fadnavis and the Mahayuti alliance recognised what the Thackerays missed - that Mumbai's voters, including Marathis, are increasingly concerned about quality-of-life issues. The Mahayuti's focus on infrastructure projects, building society amenities, improved roads, better drainage systems, and overall urban development resonated with the aspirational middle class and youth. The Thackeray pitch, by contrast, was not forward-looking. It dwelled on grievances, fears of cultural erosion, and nostalgia for a Mumbai that exists more in imagination than reality. Many voters felt this approach was taking the city backward rather than forward. In a city where traffic congestion, flooding, housing shortages, and infrastructure gaps are daily concerns, promises of cultural preservation felt inadequate.

Crisis of balance in relationships: The social reality of emotional exploitation

Human life is shaped by the fabric of relationships. Family, friendship, love, support, and social connections—all give meaning to our existence. them, relationships are merely a means, not a goal. People with this temperament often live under the illusion that the other person is dependent on them. Their politeness, tolerance, and understanding seem compulsive to them. They assume that this person cannot leave them, cannot question them, and lacks the courage to oppose them. This is where the process of emotional exploitation begins, which gradually becomes normal behavior. But every tolerance has its limits. When the other person becomes aware, introspects, and begins to realize that their existence has become merely a commodity, they try to protect themselves. This is the moment that makes the selfish person most uncomfortable, because now their control is threatened.

As soon as they see the other person asking questions, expressing their opinion, or maintaining mental distance, they resort to a new tactic—accusation. Now, the same person who once considered themselves extremely intelligent and knowledgeable begins to cast aspersions on character. They present the relationship story to outsiders in a way that favors themselves and portrays themselves as the victim and the other person as the culprit. This is where the nature of the relationship completely changes. Dialogue is replaced by accusations. Understanding and patience are replaced by bitterness and hostility. Every conversation is filled with the refrain: "You've changed," "You weren't like this before," "You've become arrogant now."

"The reality is that this isn't a change, but rather a self-realization, which the selfish person can't accept. Gradually, relationships turn into the battlefield of Kurukshetra, where the goal is not resolution but victory. One side attempts to protect itself by remaining silent, while the other side clamors and seeks sympathy. Such people are extremely skilled at garnering sympathy. They craft their arguments in such a way that the listener instinctively sides with them. In these circumstances, a normal, sensitive, and moral person suffers the most mental anguish. He knows that it's impossible to respond to every accusa-

The Great Nobel 'Giveaway': Machado About Nothing?



The recent exchange of a Nobel Peace Prize medal in the Oval Office - passed from Maria Corina Machado to Donald Trump like a baton in a relay race of dubious optics - is a scene that would have been rejected by the writers of the American sitcom "Veep" for being too heavy-handed. Yet, here we are in January 2026, watching the gold-plated collision of Venezuelan desperation and American ego, a moment that managed to offend the sensibilities of the Norwegian Nobel Committee while perfectly encapsulating the transactional nature of modern geopolitics. To understand the absurdity of the current row, one must first look at the players. On one side, we have Machado, the 2025 Nobel Peace Laureate who spent years as the "Iron Lady" of Venezuela's opposition, finally seeing the Maduro Presidency toppled by US intervention earlier this month. On the other, we have an American President who has treated his lack of a Nobel Prize as a personal grievance on par with a missed Oscar. By physically handing over her Nobel medal, Machado performed a piece of political theatre so brazen that it bordered on performance art. It was an attempt to buy, with a gold medal and global prestige, the one thing she currently lacks:

relevance in the eyes of a White House that seems increasingly ready to move on without her. Donald Trump The Nobel Laureate? The Norwegian Nobel Institute's reaction was as swift as it was predictable. Their stern reminder that the prize is "personal and non-transferable" felt like a librarian trying to enforce a "no talking" rule during a courtship between the library stacks. Of course, the title is non-transferable; no one seriously believes Donald Trump is now a Nobel Laureate because he has a new golden paperweight. But the Committee missed the point. In the ecosystem of Mar-a-Lago and the MAGA-verse, the object is the thing. Trump's social media posts regarding the "wonderful gesture" for the "work I have done" suggest that, in his mind, the bookkeeping error of 2019 has finally been corrected. He didn't need the Committee's vote; he just needed a willing donor. But who actually won this exchange? If we look past the flashbulbs, the scorecard is surprisingly bleak for all involved, particularly the person who initiated the trade. Machado's gambit smells of desperation-driven politics. Despite her Nobel pedigree, she finds herself in the untenable position of being the hero of a revolutionary drama whom the libera-

tors find inconvenient at the climax. The Trump administration's sudden pragmatism - favouring a working relationship with interim President Dely Rodriguez and the remnants of the Chavista old guard to ensure the oil keeps flowing - is a cold splash of water for the democratic purists. The damsel in distress finds the knight in shining armour riding in to vanquish the Dark Knight - and then ride away with the wrong damsel! Machado must have thought she now had to make a deal; if Qatar could offer a Boeing, the Swiss gold bars and a custom Rolex, and the Pakistani cryptocurrency assets, what could she gift Trump of remotely comparable value to get what she wanted? Flatter The King But by giving away her medal, Machado didn't just give away a piece of gold; she confessed her own weakness. A leader who is confident in her domestic mandate doesn't need to offer up her highest international honour as a tribute to a foreign patron. It was a move of "flatter the King" supplication that suggested the King has already looked elsewhere. And indeed, the deal looks very one-sided for now: she gives, he takes; next! The Nobel Committee, meanwhile, has emerged as the grumpy uncle of the international community.

S Manohar demands action against Shidlaghatta Congress leader Rajeev Gowda against women officers

No one can suppress Janardhan Reddy-Sriramulu strength, BJP will fight corrupt Congress: Bommai



Ballari: Former Karnataka Chief Minister and MP Basavaraj Bommai on Saturday asserted that no force can suppress the political strength of former ministers Gali Janardhan Reddy and B. Sriramulu, declaring that the BJP will intensify its struggle until the "corrupt Congress government" is uprooted.

Addressing a massive convention held in Ballari to protest clashes over the installation of posters, Bommai said the BJP would go from village to village and wage a decisive battle against the Congress. He said the party would always stand firmly with Janardhan Reddy and Sriramulu, whose unity has unsettled Congress leaders in the district.

Bommai alleged that law and order had completely deteriorated during the last two-and-a-half years of Congress rule, with people disturbed by frequent reports of murders, rapes and police high-handedness. He claimed that Janardhan Reddy's return to Ballari as per court

orders and his coming together with Sriramulu had created fear among Congress leaders. "Sriramulu's speed and Janardhan Reddy's strength together are like a firestorm. Their strength cannot be suppressed," he said. Citing incidents from Hubballi, Kolar, Bhadravati and Magadi, Bommai accused the Congress of fostering a culture of intimidation and violence, alleging that there was no peace for citizens or officials in the State.

On the issue of Scheduled Tribe reservations, Bommai said the BJP had fulfilled the long-pending demand of the Valmiki community by increasing the quota from 3 per cent to 7 per cent during his tenure as Chief Minister. He said this decision, taken under the leadership

of B.S. Yediyurappa, had benefited thousands of students and job aspirants. He accused Congress leaders of misusing nearly Rs.100 crore from the Valmiki Corporation for elections and challenged them to a public debate on who had done more for the community.

Bommai further alleged that shots were fired at Janardhan Reddy's residence and warned that those responsible would face consequences. He praised the developmental work carried out by Janardhan Reddy in Ballari, particularly after 2008, citing improvements in roads and drinking water facilities.

Accusing Congress of being responsible for the Ballari mining loot, Bommai said false cases were filed against Janardhan Reddy, many of which were later dismissed by courts. "Truth always prevails," he said, adding that the BJP would continue its fight for justice in the Rajasekhar death case and work relentlessly for the development of Ballari.

Karnataka attracts Rs.1.53 lakh crore in new investment proposals: M.B. Patil

Bengaluru: Karnataka has attracted new industrial investment proposals worth Rs.1.53 lakh crore in the 11 months following the Global Investors' Meet (GIM) held in February last year, Minister for Large and Medium Industries M.B. Patil said on Saturday. These investments are in addition to the commitments secured during the GIM, reflecting sustained industrial growth in the State.

Ahead of his visit to the Davos economic summit as part of a high-level State government delegation, the Minister said Karnataka's investment outreach is a continuous process and not confined to major events like the Global Investors' Meet. He noted that several leading companies have expressed interest in investing in key sectors such as manufacturing, renewable energy, data centres and Global Capability Centres (GCCs).

According to Patil, of the total proposals, Rs.66,293

crore is in the manufacturing and industrial sector, Rs.20,913 crore in wind and solar power generation, Rs.12,500 crore in GCCs and Rs.6,350 crore in data centres. The proposals are expected to be submitted to Karnataka Udyog Mitra shortly, following which approvals will be taken up on a fast-track basis.

Highlighting key investments, he said Toyota Industries Engine Pvt. Ltd. will invest Rs.1,330 crore at Jigani to manufacture gasoline and hybrid engines, while QpiAI India Pvt. Ltd. will invest Rs.1,136 crore to set up a Quantum Centre of Excellence in Bengaluru. AT&T will invest Rs.2,850 crore in Nanjangud for electronic components manufacturing, and Wipro Hydraulics will invest Rs.499 crore to produce copper laminates for the electronics and PCB sectors. Zenfold Biosciences Pvt. Ltd. will invest Rs.490 crore to manufacture pharmaceutical enzymes, and

Reliance Consumer Products will set up a Rs.1,622-crore beverage manufacturing unit at Mulawad Industrial Area in Vijayapura district.

Patil further said JJG Aerospace will invest Rs.470 crore in Doddaballapura to manufacture aircraft components, Yaskawa will invest Rs.330 crore in electronic products manufacturing, and Inox Wind will invest Rs.305 crore to set up a wind turbine manufacturing unit in Koppala district. SAP will invest Rs.1,960 crore to open its second facility at Devanahalli. Google will invest Rs.2,500 crore in Bengaluru, and NTT will invest Rs.4,000 crore to establish data centres at Devanahalli. Data Samudra will invest Rs.1,350 crore across Mangaluru, Hubballi-Dharawada and Mysuru, while Haldiram Snacks will invest Rs.444 crore to set up a snacks manufacturing unit in Tumakuru district.



US tariff shock batters Coimbatore-Tirupur industries; job losses mount

CHENNAI: Once among India's most vibrant industrial hubs, Coimbatore and Tirupur are facing one of their toughest phases in recent decades as steep tariff hikes imposed by the United States continue to take a heavy toll on jobs and exports. The twin cities, which together provided livelihoods to several lakh workers from Tamil Nadu and other states, have been struggling since the US raised tariffs on Indian goods to 50 per cent in August last year.

Industry sources estimate that job losses have already crossed two lakh in the textile and engineering sectors combined. If allied industries such as castings, pumps and industrial valves are also included, the total number of people affected is

believed to exceed three lakh. Factory closures, reduced shifts and shrinking order books have become common, particularly among small and medium exporters. The impact has been equally severe on exports. According to Dhanabalan, vice-president, apparel export operations and business development at a private mill, annual textile exports from Coimbatore and Tirupur to the US market earlier stood at around \$1.7 billion. Today, that figure has come down by nearly a billion dollars," he said.

"If the 50 per cent tariff on Indian products continues, textile exports to the US could become virtually nil within a year." Industry leaders point out that the headline tariff is not the only burden.

Primordial Magnetism: The Hidden Force Behind Life's Origin

The perplexing phenomenon of homochirality in life, where biomolecules exist in only one of two mirror-image forms, remains unexplained despite historical attention from scientific figures like Pasteur, Lord Kelvin, and Pierre Curie. Recent research suggests the combination of electric and magnetic fields might influence this preference through experiments showing enantioselective effects on chiral molecules interacting with magnetized surfaces, offering indirect evidence towards understanding this mystery. The phenomenon known as homochirality of life, which refers to the exclusive presence of biomolecules in one of their two possible mirror-image configurations within living organisms, has intrigued several prominent figures in science. This includes Louis Pasteur, who first identified molecular chirality, William Thomson (also known as Lord Kelvin), and Pierre Curie, a Nobel Laureate.

A conclusive explanation is still lacking, as both forms have, for instance, the same chemical stability and do not differ from each other in their physicochemical properties. The hypothesis, however, that the interplay between electric and magnetic fields could explain the preference for one or the other mirror-image form of a molecule – so-called enantiomers – emerged early on.

It was only a few years ago, though, that the first indirect evidence emerged that the various combinations of these force fields can indeed "distinguish" between the two mirror images of a molecule. This was achieved by studying the interaction of chiral molecules with metallic surfaces that exhibit a strong electric field over short distances. If only left-handed helicene spirals are deposited on the cobalt-copper surface, they clearly prefer cobalt islands with a certain direction of magnetization. In the image, the two triangular cobalt islands have opposite magnetization; the left-handed helicene molecules bind almost exclusively to the island on the right and avoid the island on the left (except for a few molecules at the edge of the island). Credit: Peter Grünberg Institute/Jülich The surfaces of magnetic metals such as iron, cobalt, or nickel thus allow electric and magnetic fields to be combined in various ways – the direction of magnetization is simply reversed, from "North up – South down" to "South up – North down". If the interplay between magnetism and electric fields actually triggers "enantioselective" effects, then the strength of the interaction between chiral molecules and magnetic surfaces should also differ, for example – depending on whether a right-handed or left-handed molecule "settles" on the surface.

Mirror images prefer opposing magnetic fields And this is indeed the case, as a team of researchers led by Karl-Heinz Ernst from the Empa's Surface Science and Coating Technologies lab and colleagues at the Peter Grünberg Institute



at the Forschungszentrum Jülich in Germany recently reported in the scientific journal Advanced Materials. The team coated a (non-magnetic) copper surface with small, ultra-thin "islands" of magnetic cobalt and determined the direction of the magnetic field in these using spin-polarized scanning tunneling microscopy; as mentioned before, this can run in two different directions perpendicular to the metal surface: North up or South up. They then deposited spiral-shaped chiral molecules – a 1:1 mixture of left- and right-handed heptahelicene molecules – onto these cobalt islands in an ultrahigh vacuum. Then they "simply" counted the number of right- and left-handed helicene molecules on the differently magnetized cobalt islands, almost 800 molecules in total, again using scanning tunneling microscopy. And lo and behold: Depending on the direction of magnetic field, one or the other form of the helicene spirals had settled preferentially (see right side of the graphic). How Chirality Induced Spin Selectivity Manifests Itself? This is how chirality-induced spin selectivity (CISS effect) manifests itself. Electrons (e- or red and green spheres with arrows indicating electron spin, either up or down) with the "wrong" direction of rotation (spin) are held back or filtered out when tunneling through spiral molecules, depending on the handedness of the spirals (left- or right-handed), so that one type of electron spin predominates (electrons with the arrow pointing downwards on the left side). The electric field of a metallic surface (E, pointing upwards, right side) shifts the electrons in the bound heptahelicene molecules; these accumulate slightly in the lower part of the molecule near the surface. In the case of chiral molecules, electrons with different spins are also shifted differently depending on the handedness of the molecule. The molecule becomes "spin-polarized", i.e. also magnetic.

Depending on the direction of magnetization of the metallic surface, chiral molecules therefore interact with it to different degrees. In this example, the purple spiral therefore binds more strongly to the surface than the yellow one, as opposite spins "attract" each other (the red and green electrons with different spins sitting on top of each other). Moreover, the experiments showed that the selection – the preference for one or the other enantiomer – not only occurs during the binding on the cobalt islands, but already beforehand. Before the molecules take up their final (preferred) position on one of the cobalt islands, they migrate long distances across the copper surface in a significantly weaker bound precursor state in "search" for an ideal position. They are only bound to the surface by so-called van der Waals forces. These are merely caused by fluctuations in the electronic shell of atoms and molecules and are therefore relatively weak. The fact that even these are influenced by magnetism, i.e. the direction of rotation (spin) of the electrons, was not known thus far.

Electrons with the "wrong" spin are filtered out

Using scanning tunneling microscopy, the researchers were also able to solve another mystery, as they reported in the journal Small last November. Electron transport – i.e. electric current – also depends on the combination of molecular handedness and magnetization of the surface. Depending on the handedness of the bound molecule, electrons with one direction of spin preferentially flow – or "tunnel" – through the molecule, meaning that electrons with the "wrong" spin are filtered out.

This chirality-induced spin selectivity (CISS effect, see left side of the graphic) had already been observed in earlier studies, but it remained unclear whether an ensemble of molecules is necessary for this or whether individual molecules also exhibit this effect. Ernst and his colleagues have now been able to show that individual helicene molecules also exhibit the CISS effect. "But the physics behind this is still not understood," admits Ernst. The Empa researcher also believes that his findings eventually cannot fully answer the question of the chirality of life. In other words, the question that the Nobel Prize winner in chemistry and ETH chemist Vladimir Prelog described as "one of the first problems of molecular theology" in his Nobel Prize lecture in 1975. But Ernst can imagine that in certain surface-catalyzed chemical reactions – such as those that could have taken place in the chemical "primordial soup" on the early Earth – a certain combination of electric and magnetic fields could have led to a steady accumulation of one form or another of the various biomolecules – and thus ultimately to the handedness of life.

The Glacier That's Rewriting Climate History

Nestled within the immense wilderness of Antarctica, the Thwaites Glacier stretches impressively across approximately 80 miles on the continent's western frontier. Despite its monumental scale, this colossal glacier faces a troubling imbalance, shedding around 50 billion tons of ice annually in excess of what it gains from snowfall. This critical disparity puts its stability in jeopardy.

Accelerating ice loss has been observed since the 1970s, but it is unclear when this significant melting initiated – until now. A new study published in the journal PNAS, led by researchers at the University of Houston, suggests that significant glacial retreat began in the 1940s. Their results on the Thwaites Glacier coincide with previous work that studied retreat on Pine Island Glacier and found glacial retreat began in the '40s as well. "What is especially important about our study is that this change is not random nor specific to one glacier," said Rachel Clark, corresponding author, who graduated from UH last year with a doctorate in geology. "It is part of a larger context of a changing climate. You just can't ignore what's happening on this glacier." Clark and the study authors posit that the glacial retreat was likely kicked off by an extreme El Niño climate pattern that warmed the west Antarctic. Since then, the authors say, the glacier has not recovered and is currently contributing to 4% of global sea-level rise. "It is significant that El Niño only lasted a couple of years, but the two glaciers, Thwaites and Pine Island, remain in significant retreat," said Julia Wellner, UH associate professor of geology and U.S. lead investigator of the Thwaites Offshore Research project, or THOR, an international collaboration whose team members are authors of the study. "Once the system is kicked out of balance, the retreat is ongoing," she added. Nathaniel B. Palmer Sails Past Thwaites Glacier


Their findings also make it clear the retreat at the glaciers' grounding zone, or the area where the glaciers lose contact with the seabed and start to float, was due to external factors. "The finding that both Thwaites Glacier and Pine Island Glacier share a common history of thinning and retreat corroborates the view that ice loss in the Amundsen Sea sector of the West Antarctic ice sheet is predominantly controlled by external factors, involving changes in ocean and atmosphere circulation, rather than internal glacier dynamics or local changes, such as melting at the glacier bed or snow accumulation on the glacier surface," said Claus-Dieter Hillenbrand, U.K. lead investigator of THOR and study co-author. "A significant implication of our findings is that once an ice sheet retreat is set in motion, it can continue for decades, even if what started it gets no worse," added James Smith, a marine geologist at the British Antarctic Survey and study co-author. "It is possible that the changes we see today on Thwaites and Pine Island glaciers – and potentially across the entire Amundsen Sea embayment – were essentially set in motion in the 1940s." Clark and the team used three primary methods to reach their conclusion. One of those methods was marine sediment core collection that was closer to the Thwaites Glacier than ever before. They retrieved the cores during their trip to the Amundsen Sea near Thwaites in early 2019 aboard the Nathaniel B. Palmer icebreaker and research vessel. The researchers then used the cores to reconstruct the glacier's history from the early Holocene epoch to the present. The Holocene is the current geological epoch that began after the last ice age, roughly 11,700 years ago. CT scans were used to take X-rays of the sediment to gather details from its history. Geochronology, or the science of dating earth materials, was then used to reach the conclusion that significant ice melt began in the '40s. Clark used ²¹⁰Pb (lead-210), an isotope that's naturally buried in the sediment cores and is radioactive, as the most important isotope in her geochronology. This process is similar to radiocarbon dating, which measures the age of organic materials as far back as 60,000 years.

Iran supreme leader admits thousands killed during recent protests



Iran's supreme leader has for the first time publicly acknowledged that thousands of people were killed, "some in an inhuman, savage manner", during recent protests. A violent response to the unrest has claimed 3,090 lives, according to US-based Iranian Human Rights Activists News Agency (HRANA), with some activist groups putting the death toll far higher. An internet blackout has made it extremely difficult to get clear information. In a speech on Saturday, Ayatollah Ali Khamenei said thousands had been killed and blamed the US for the deaths. US President Donald Trump recently urged Iranian demonstrators to "keep protesting" and threatened military intervention if security forces kill them. The protests, which began on 28 December over the economy, have turned into calls for the end of the rule

of Iran's supreme leader. The Iranian government has called the demonstrations "riots" backed by Iran's enemies. Protesters have been met with deadly force and videos of security forces shooting at demonstrators have been authenticated by both BBC Persian and BBC Verify. There has also been a near-total shutdown of the internet and communication

services in Iran. On Saturday overall connectivity remained at about 2% of ordinary levels, according to cyber monitor NetBlocks. There have been fewer reports of unrest in recent days but with internet access still restricted developments on the ground remain unclear. A woman in Shiraz, southwestern Iran, told BBC Persian that "security



forces are still patrolling on motorbikes to keep the situation under control, but overall things have gone back to normal". During his speech on Saturday, Khamenei also said Iran considered President Trump to be a "criminal" and said the US must be "held accountable" for recent unrest. He also claimed on social media that "America's goal is to

swallow Iran". Trump has not yet responded to the supreme leader and the BBC has approached the White House for a comment. The US state department said on Saturday that it had "heard reports that the Islamic Republic is preparing options to target American bases". It said Iran would be met with "a very, very powerful force" if it launched such an attack

UGANDAN LEADER EXTENDS 40-YEAR RULE AFTER WINNING CONTESTED POLL



Ugandan President Yoweri Museveni has been declared the winner of Thursday's election extending his four decades in power by another five years. He gained 72% of the vote, the election commission announced, against 25% for his closest challenger Bobi Wine, who has condemned what he described as "fake results" and "ballot stuffing". Wine has not provided any details and the authorities have not responded to his allegations, but African Union election observers said they saw "no evidence of ballot stuffing". Wine has called for non-violent protests. Museveni, 81, first came to power as a rebel leader in 1986 but since then has won seven elections. The election process was marred by violence and Wine, a 43-year-old former pop star, says that at least 21

people have been killed around the country in recent days. The authorities have so far confirmed seven deaths. Access to the internet has been cut in the country since Tuesday, making it hard to verify information. The authorities say the blackout was necessary to prevent misinformation, fraud and the incitement of violence - a move condemned by the UN human rights office as "deeply worrying". Wine has demanded that the internet be restored.

Paracetamol is safe in pregnancy, says study refuting Trump autism claims



Taking paracetamol while pregnant is safe and there's no evidence it raises the risk of autism, ADHD and developmental issues in children, say experts behind a major new review. Pregnant women "should feel reassured" by the findings, they say, which contradict controversial claims from US President Donald Trump last year that paracetamol "is no good" and pregnant women should "fight like hell" not to take it. His views were criticised at the time by medical organisations worldwide. Experts say this latest review, in a Lancet journal, is rigorous and should end the debate over its safety. But US health officials maintain that "many experts" have expressed concern over its use during pregnancy. The US President shocked many doctors worldwide when he and his administration claimed paracetamol - known as acetaminophen in the US - which is

FROM CAMOUFLAGE TO TRACK-SUITS - GUINEA'S JUNTA LEADER BECOMES CIVILIAN PRESIDENT



From the moment he seized power in September 2021 Guinea's Mamadi Doumbouya struck an imposing figure. Just 36 years old at the time, the broad-shouldered colonel, standing at well over six feet (1.8m), wearing military fatigues, mirrored sunglasses and a red beret certainly made an impression when announcing the coup. A relatively unknown member of an elite army unit, he declared that the government of ousted President Alpha Condé had disregarded democratic principles and that citizens' rights were being trampled on. After more than four years of acting as interim president, and going back on a promise not to run for leadership of the country,

Doumbouya, now 41, was sworn in as the elected head of state on Saturday. The discreet, disciplined and private man won 87% of the vote in December's election against a severely depleted field. Ex-Prime Minister Cellou Dalein Diallo, now in exile, described the process as a charade which generated "fabricated" results.

Ajay Banga, president of the World Bank, is something of an exception as a dual-national, Indian-born US citizen. Sir Tony Blair, meanwhile, is a former UK Prime Minister, and his inclusion is likely to further fuel concerns about how the Board of Peace will operate. Over the past few weeks, criticism of Sir Tony's possible inclusion has come from figures like prominent politician Mustafa Barghouti, general secretary of the Palestinian National Initiative, and newspaper reports quoting unnamed officials from Arab states in the region.

US justice department investigating Minnesota Democrats over alleged obstruction of ICE



Two prominent Minnesota democrats are being investigated over alleged attempts to impede federal immigration operations, in an escalation of the Trump's administration's clash with the state's leaders. Gov Tim Walz and Minneapolis Mayor Jacob Frey are facing a US justice department inquiry over comments made about Immigration and Customs Enforcement (ICE), according to the BBC's US partner CBS News. The probe comes as a federal judge limited what tactics ICE and other law enforcement officials

could use in Minneapolis, blocking the use of pepper spray and arrests of peaceful protesters. Protests have ramped up in the city after Renee Good, 37, was shot and killed by an ICE agent last week. New details also came to light

on Friday about Good's death. The Minneapolis woman was found by paramedics with at least three gunshot wounds and possibly a fourth to the head, according to official reports viewed by CBS. Governor Walz responded on Friday to

news of the inquiry against him by posting on X: "Weaponizing the justice system against your opponents is an authoritarian tactic. "The only person not being investigated for the shooting of Renee Good is the federal agent who shot her." In a statement to the BBC, Mayor Frey said "I will not be intimidated". "This is an obvious attempt to intimidate me for standing up for Minneapolis, our local law enforcement, and our residents against the chaos and danger this Administration has brought to our streets," he said.

Japanese mayor apologises after calling staff 'human scum'



The mayor of Yokohama has apologised for insulting colleagues after an official publicly accused him of making offensive remarks. At a news conference, the Japanese city's human resource chief, Jun Kubota, alleged that Mayor Takeharu Yamanaka had used terms such as "idiot" and "human scum" to disparage staff. It is highly unusual in Japan for a serving city official to openly accuse a sitting mayor and demand an apology. Yamanaka initially denied the allegations, but later admitted to some of them. "I want to frankly apologise for placing a psychological burden on the personnel director," he said. At a news conference on Thursday, Kubota accused Mayor Yamanaka of repeatedly making remarks towards officials - including himself - that could amount to workplace harassment. The mayor was accused of calling officials "useless", "silly" and "low-spec", as well as making comments about colleagues' appearance and likening them to animals. He is also accused of threatening Kubota, saying he would have to "commit seppuku" - a Japanese ritual suicide by disembowelment - if he failed to secure an international conference bid. Kubota demanded an apology from Yamanaka and called for an investigation. Yamanaka initially published a statement on his personal website, denying the allegations. But on Friday, he publicly acknowledged some remarks - such as using words like "idiot" and "human scum" - and apologised. "I am reflecting on this. I will be more careful with my words and behaviour," Yamanaka said. He said those comments were made during discussions over personnel evaluations. However, the mayor denied other accusations, including insulting colleagues' appearance.

Bangladesh Break Silence On 'No Handshake' With India During U-19 World Cup

Controversy erupted during the U-19 World Cup 2026 match between India and Bangladesh when the two captains did not shake hands after the toss. India captain Ayush Mhatre and Bangladesh vice-captain Zawad Abrar, who attended the toss in place of captain Azizul Hakim, did not shake hands. There was a lot of chatter on social media over the incident considering the political tensions between the two teams. However, the Bangladesh Cricket Board (BCB) said that the absence of a handshake was "completely unintentional and resulted from a momentary lapse in concentration". "The Bangladesh Cricket Board (BCB) has taken note of an inadvertent and unwarranted action that occurred at the toss prior to the opening match of the ICC Under 19 World Cup 2026, Zimbabwe & Namibia, between Bangladesh and India," the official press release read. "Due to illness, regular captain Azizul Hakim was unable to attend the toss, and vice-captain Zawad Abrar represented the team on the occasion. The BCB wishes to clarify that the absence of a handshake with the opposition captain was completely unintentional and resulted from a momentary lapse in concentration. There was no intent whatsoever to show courtesy or disregard towards the opposition." "The Board has viewed the matter with due seriousness, as upholding the spirit of cricket and respect for opponents is a fundamental prerequisite for representing Bangladesh at any level and immediately advised the team management accordingly. The players have also been reminded of their responsibility to maintain the highest standards of



sportsmanship, camaraderie and mutual respect in all interactions with opposing teams. The Bangladesh Cricket Board remains fully committed to the values of cricket, both on and off the field," the release added. Meanwhile, the BCB remained steadfast on their stance of not playing T20 World Cup 2026 matches in India despite holding multiple meetings with the International Cricket Council (ICC). 
