Delhi govt okays Rs 1,471 Cr 6-lane MB Road project

New Delhi (TSIT): Delhi government's Expenditure Finance Committee(EFC) has approved a major infrastructure project for South Delhi. At an estimated cost of Rs 1,471.14 crore, a six-lane integrated elevated road, along with two underpasses, will be constructed on M.B. Road from Saket G-Block to Pul Prahladpur. The project is targeted for completion by December 2027. The meeting of the EFC was held at the Delhi Secretariat on Tuesday chaired by Delhi CM Rekha Gupta. With a total length of nearly five kilometres, the project will be developed in two phases. The first elevated stretch will run from Saket G-Block to Sangam Vihar, measuring 2.42 kilometres. The second stretch will extend from Maa Anandmayee Marg to Pul Prahladpur, with a length of approximately 2.48 kilometres. The project will be executed by the Delhi Metro Rail Corporation (DMRC). It will be developed along the DMRC corridor alignment to ensure optimal coordination between road and metro infrastructure. The integrated structure will feature a double-decker system, with the metro operating on the upper deck and a six-lane elevated road corridor below.

ED files chargesheet against NCL official in corruption, money laundering case

New Delhi (TSIT): The Enforcement Directorate (ED), Bhopal Zonal Office, stated on Tuesday that it has filed a chargesheet against Shailendra Pasari before a special PMLA court in Jabalpur. A notice for a pre-cognizance hearing has been issued against the accused. The ED initiated its investigation based on two FIRs registered by the CBI's Anti-Corruption Branch in Jabalpur. The first FIR was registered under various sections of the Prevention of Corruption Act. In this case, Shailendra Pasari, then Senior Manager (Civil) at Northern Coalfields Limited's Jayant Project in Singrauli, was caught red-handed while demanding and accepting a bribe of Rs 10,000 for clearing pending escalation bills. Subsequently, during searches conducted by the CBI at his premises, unaccounted cash amounting to Rs 72,97,200 was recovered from Pasari's residence, bank lockers, and office. The second FIR was registered under sections of the Prevention of Corruption Act for possessing disproportionate assets. The CBI alleged that Pasari and his family members were in possession of assets worth Rs 1.30 crore (124.12% disproportionate to his known sources of income) during the check period from January 1, 2014, to September 8, 2018.

Unilever to Explore Setting Up Global Capability Centre in Hyderabad



Davos (TSIT): Global consumer goods major Unilever has expressed interest in exploring the establishment of a Global Capability Centre (GCC) in Hyderabad, following a meeting with the Telangana Rising delegation led by Chief Minister A. Revanth Reddy at the World Economic Forum (WEF) 2026 in Davos on Tuesday.

The Telangana delegation met Willem Uijen, Chief Supply Chain & Operations Officer of Unilever, during which discussions focused on Hyderabad's rapid emergence as a global hub for GCCs. Highlighting the city's strong ecosystem, world-class talent pool, and investor-friendly governance, the Chief Minister outlined Telangana's vision for attracting global corporations.

Mr. Uijen stated that Unilever would be happy to explore the possibility of setting up a GCC in Hyderabad, acknowledging the city's growing reputation as a preferred destination for global opera-

tions. Industries & Commerce Minister D. Sridhar Babu said Hyderabad already hosts GCCs of leading FMCG companies such as McDonald's, Heineken, and Costco, underscoring the State's credibility in the sector. "Unilever is a prized partner of Telangana. The State is known for policy continuity and a fast-paced approval and licensing process for businesses," he said. The delegation, which included Revenue Minister Ponguleti Srinivas Reddy, also invited Unilever to explore FMCG manufacturing opportunities in Telangana's industrial parks.

Discussions further covered aligning Unilever's commitments on climate action, water positivity, and plastic reduction with Telangana's initiatives in renewable energy, water stewardship, and the circular economy, reinforcing the State's focus on sustainable and responsible industrial growth.

EU on cusp of historic trade deal with India: Ursula von der Leyen

DAVOS: (Jan 20) (GNS) The European Union is on the cusp of signing a historic trade agreement with India that is being called 'the mother of all deals', European Commission President Ursula von der Leyen announced on Tuesday, asserting it will create a market for 2 billion people or about one-fourth of the global GDP. In a special address here at the World Economic Forum Annual Meeting, she said the real would crucially provide a first-mover advantage for Europe with one of the world's fastest-growing and most dynamic continents.

"Right after Davos, I will travel to India. There is still work to do. But we are on the cusp of a historic trade agreement. Some call it the mother of all deals," she said.



"Europe wants to do business with the growth centres of today and the economic powerhouses of this century. From Latin America to the Indo-Pacific and far beyond, Europe will always choose the world. And the world is ready to choose Europe," she said. President of the European Council, Antonio Costa and von der Leyen will be in India from January 25 to 27 to grace the Republic Day celebrations as chief guests and hold summit talks with Prime Minister Narendra Modi.

UAE agrees to partner with Telangana for 'Future City' development

Hyderabad, Jan 20 (TSIT) : The United Arab Emirates (UAE) has agreed to partner with Telangana for the development of Bharat Future City as a top global city, the Telangana government said.

UAE Minister of Economy and Tourism Abdulla bin Touq Al Marri met Chief Minister A. Revanth Reddy-led 'Telangana Rising' delegation, at the World Economic Forum in Davos on Tuesday. Touq Al Marri said his national government would be happy to join hands with Telangana. He suggested that the two governments establish a joint task force of officials from both sides for the speedy implementa-



tion of this project, according to a release from the Chief Minister's Office (CMO) here. The delegation discussed potential areas of cooperation in the state's large infra-

Nitin Nabin takes over as BJP's 12th president; PM Modi says 'You are my boss'

NEW DELHI (TSIT): Nitin Nabin on Tuesday took over as the BJP's 12th national president, succeeding J P Nadda and beginning a new chapter for the party as it seeks to tighten its grip on the country's politics and further expand its influence in uncharted territories with a generational shift in the organisation.

Addressing a gathering at the BJP headquarters here on the occasion, Prime Minister Narendra Modi said when it comes to party matters, he is a worker and "honourable Nitin Nabin ji" is his boss.



After a formal announcement of Nabin's name as the new BJP chief, Prime Minister Modi and other senior leaders took him to his new office at the party headquarters, where he officially assumed the charge of the party's national president.

Telangana aims to increase its GDP contribution to 10 pc

Hyderabad (TSIT) : Telangana has set the goal of raising its contribution to India's GDP to 10 per cent, supported by a clear roadmap to build a USD 3 trillion economy, industry minister D. Sridhar Babu said on Tuesday. He invited global industry leaders to partner in Telangana Rising, a long-term vision built on policy stability, ease of doing business, and innovation-led growth. At the inauguration of the India Pavilion at the World Economic Forum annual meeting in Davos, Minister Sridhar Babu invited the industry leaders to invest in the state.

He told them that Telangana today offers a conducive, predictable ecosystem where global companies can scale, invest and participate meaningfully in the state's development journey. He said that life sciences, electronics, semiconductor,



IT, aerospace, renewable energy and green technologies are the priority sectors. The minister stated that with Rs 2.5 lakh crore in investments mobilised over the past two years, the emphasis remains on sustaining growth, creating employment and strengthening Telangana's global standing.

He told the investors that Telangana has become a role model for other states in ease of doing business. Sridhar Babu

said that his government's resolve is not to wait for the future, but to build it. He stated that they have set a target of increasing Telangana's share in the country's GDP to 10 per cent by 2047 and are taking visionary and planned steps accordingly.

He stated that a comprehensive roadmap has been prepared with the participation of experts, industrialists, and the public to propel Telangana's economy to \$3 trillion by 2047.

He added that this vision document gives utmost priority to key sectors that will boost the state's economy. He elaborated on the favourable conditions, opportunities, and the existing ecosystem in Telangana for investments in sectors such as pharmaceuticals, life sciences, biotechnology, healthcare innovation, electronics, semiconductor, hardware manufacturing,

IT, ITES, aerospace, defence, textiles, apparel manufacturing, food processing, agro-based industries, renewable energy, and green technologies.

He affirmed that they are sincerely working to bring new industries to the state and create employment opportunities for the youth. He mentioned that his government has attracted investments worth approximately Rs 2.5 lakh crore in the last two years at the Davos forum. He added that this year too, with the same spirit, they will explain the policies designed to boost industrial development and strive to encourage leading companies to invest in Telangana. The minister announced that the Life Sciences Policy 2.0 and the Telangana AI Innovation Hub (TAIH) will be formally launched at the Davos forum to further enhance the global recognition of the "Telangana brand."

No better investment destination than Andhra Pradesh: CM Chandrababu



Amaravati, Jan 20 (TSIT) : Andhra Pradesh Chief Minister N. Chandrababu Naidu said on Tuesday that there is no better investment destination than Andhra Pradesh. He invited industrialists to visit Andhra Pradesh and personally observe the policies implemented by the state government and the favourable conditions for investments. He urged them to make investment decisions only after witnessing the speed of doing business policies. The Chief Minister, who is attending the World Economic Forum annual meeting in Davos, was addressing the CII session on "India at the Centre: The Geography of Growth - The Andhra Pradesh Advantage".

The Chief Minister posted on X that he told the industry leaders that Andhra Pradesh isn't just an investment destination but a strategic advantage.

He showcased Andhra Pradesh's strengths across various sectors. "With nearly a quarter of India's FDI, our speed of doing business makes AP a premier investment hub. I invited the global industry to

partner with us for long-term growth," he wrote.

According to an official release, the Chief Minister said that India will become a global power by 2047, and Andhra Pradesh will be at the forefront of this transformation.

He said that Andhra Pradesh has attracted 25 per cent of the foreign investments that have come into the country. The session discussed the vast investment opportunities in green energy, technology, fuel, digital infrastructure, logistics, and manufacturing sectors. CM Chandrababu Naidu explained the state government's policies and investment opportunities in various sectors. He informed the industrialists about green ammonia, Google investments, and the Andhra Pradesh brand image. He said that they are focusing on aspects such as Space City, ports, airports, and highway connectivity. The Chief Minister said that the coalition government in Andhra Pradesh is providing all-round support to investors, and that drones will be used in the agriculture and medical sectors.

TN 2026 POLLS: Stalin takes charge of alliance dynamics

In a veiled reference to recent remarks from sections of the Congress, Stalin said that even allies could sometimes create confusion.

CHENNAI (TSIT): Assuring party cadres and functionaries not to worry about alliance dynamics and seat-sharing arrangements, MK Stalin, president of the DMK, on Tuesday said he would personally handle all alliance-related matters.

Chairing a meeting of district secretaries at Anna Arivalayam, the party headquarters here, the Chief Minister said unity among party functionaries and cadres was crucial. "Functionaries and cadres should work together. If there is any lack of coordination, I will take strict action. The party is bigger than any individual," he said.

"Some people, even within our alliance, may try to create confusion. However, we should not fall into such traps," he said, urging party members to remain focused on organisational work. Order for SIR of electoral rolls legislative in nature, lays down guiding principles: EC to SC

Dwivedi referred to legal schemes which govern the preparation and revision of electoral rolls and regulate the conduct of elections.

NEW DELHI (TSIT): The Election Commission on Tuesday told the Supreme Court that its order on special intensive revision (SIR) of electoral rolls in various states is legislative in character, lays down guiding principles, and prescribes documents needed.

The submissions were made by senior advocate Rakesh Dwivedi, appearing for the poll panel, before a bench comprising Chief Justice Surya Kant and Justice Joymalya Bagchi during the final hearings on a batch of petitions challenging the EC's SIR of electoral rolls undertaken in several states, including Bihar.



"Our SIR order is legislative in character. It lays down a complete set of principles and documents prescribed. It is a general order applicable to the whole country, except the Assam case," the senior lawyer said. The petitions, including the lead one filed by NGO 'Association for Democratic Reforms', raise significant constitutional questions concerning the scope of the poll panel's

powers, the determination of citizenship for electoral purposes, and the fundamental right to vote.

Dwivedi referred to legal schemes which govern the preparation and revision of electoral rolls and regulate the conduct of elections.

Referring to Section 62 of the Representation of Peoples Act, he submitted that voter registration is subject to specific statutory conditions. Dwivedi said Articles 324 to 326 of the Constitution, read with Section 19 of the 1950 Act, impose a constitutional obligation on the EC to ensure that only citizens are enrolled as voters.

Dr. Rekha Condemns Indore Water Tragedy Seeks Accountability

Hyderabad : Telangana Pradesh Mahila Congress Vice President Dr. Rekha Boyalapalli strongly condemned the tragic deaths reported in Indore after people consumed contaminated drinking water, calling it a grave failure of governance and civic responsibility. In a statement, Dr. Rekha Boyalapalli said that access to clean and safe drinking water is a fundamental public right and a constitutional obligation of the government, not a favour. She stated that the incident exposes the collapse of basic civic administration and the hollowness of the so-called urban governance model, where authorities respond only after tragedies occur. She asserted that deaths caused by unsafe drinking water are not



accidental but the result of prolonged negligence, poor infrastructure maintenance, and lack of accountability. Will Migration Ever Stop? Tribal Hamlets Await Irrigation and Livelihood

RANGAREDDY : Hopes that assured irrigation would change the fate of tribal communities in the border areas of Rangareddy district have faded, forcing families into poverty and migration. Drought, lack of employment, and the absence of irrigation facilities have pushed several tribal hamlets into a humanitarian crisis, with poverty knocking on every household.

The Palamuru–Rangareddy region has long suffered neglect, even during the undivided state period. Generations born into drought continue to face water scarcity, hunger, and forced migration. In the last-mile areas of Kondurg and Chowderguda mandals, several tribal hamlets under Galiguda and Chegiredighanapur village limits remain largely locked and deserted, as families migrate to Mumbai, other parts of Maharashtra, and Hyderabad in search of livelihood.

Farmers say completion of the Palamuru–Rangareddy Lift Irrigation Scheme, including the Lakshmidhevally reservoir, could resolve irrigation and drinking water problems and help stop migration. However, the ground reality remains grim. Farmers who have land and cattle still lack water facilities. Despite



spending lakhs of rupees on borewells, many have not received even a drop of water, pushing them into debt and forcing them to abandon agriculture and work as daily wage labourers. Even after 75 years of Independence, rural and tribal migration continues. Elderly people are left behind in villages, while younger generations migrate for survival. Key irrigation projects such as Palamuru–Rangareddy Lift Irrigation Scheme, Koilsagar, Bheema, Kalwakurthy, and Nettampadu continue at a slow pace, despite two major rivers flowing through the district.

Many residents had hoped that the formation of Telangana would improve their lives, but conditions have only worsened. Farmers and tribal families now wait with tired eyes, hoping for the day when irrigation water will finally reach their lands and bring an end to forced migration.

Medicover Hospitals Successfully Performs Advanced Hybrid Laparoscopic-Robotic Whipple’s Surgery for Rare Duodenal Cancer



Hyderabad: Medicover Hospitals,HITEC City, has achieved a significant surgical milestone with the successful performance of a complex Hybrid Laparoscopic-Robotic Whipple’s Resection for a rare case of duodenal adenocarcinoma. The procedure was led by Dr. Mannem Manoj Kumar, Consultant Surgical Gastroenterologist and Robotic GI Surgeon, along with a multidisciplinary surgical team.

The patient, Mr. Shaik Rabbani Pasha (57 years), presented with persistent vomiting. After thorough evaluation, the team opted for a Whipple’s procedure, considered one of the most technically demanding surgeries in gastrointestinal oncology.

The surgery was performed using an innovative hybrid approach, combining laparoscopic tumor resection with robot-assisted reconstruction using the DaVinci X robotic system. This technique provided greater flexibility during resection and exceptional precision during critical reconstruction phases.

The robotic platform enabled meticulous performance of complex anastomoses such as pancreatojejunostomy and hepaticojejunostomy, particularly challenging in cases with a soft pancreas and non-dilated ducts. The entire procedure was completed through a minimally invasive approach, requiring only a small incision for specimen retrieval.

The patient had an uneventful postoperative recovery, experienced minimal pain, and was discharged in stable condition without any complications.

Speaking on the achievement, Dr. Mannem Manoj Kumar said, “This successful outcome highlights the growing role of hybrid laparoscopic-robotic techniques in managing complex gastrointestinal cancers. Such advanced approaches offer improved surgical precision, reduced morbidity, faster recovery, and better overall outcomes for patients.”

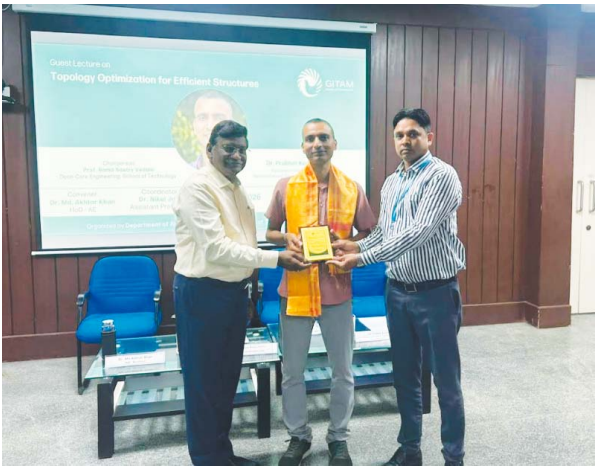

EDITORIAL

THE RISE, EXILE, AND FADING FOOTPRINTS OF KASHMIRI PANDITS

The Kashmiri Pandits are Saraswat Brahmins, one of the oldest ethnic groups of the Indian subcontinent. Their history can arguably be traced back to the first human settlements in the Valley over 4,000 years ago, rooted in a land they believed was reclaimed from a vast lake by the sage Kashyapa. For centuries, Kashmir was the “sharda peeth,” or the seat of learning. The Pandits developed Kashmir Shaivism, a sophisticated school of philosophy that views the universe as a manifestation of pure consciousness. Unfortunately, this highly educated and scholarly community was persecuted in history at least eight times between 1320 and 1990.

1) 1320: It was Zulju, also known as Zul Qadir Khan, a Turco-Mongol invader who attacked in 1320 AD and wreaked devastation when he commanded the force that conquered Kashmir.

2) 1389–1413: Sultan Sikandar, or Sikandar Butshikan, who was also known as the ‘iconoclast,’ destroyed massive temples like Martand and gave Hindus in the area the choice to convert, flee, or die.

3) 1413–1420: Ali Shah, the son of Sikandar, continued his father’s policies with even more brutality, deploying guards to prevent Pandits from escaping so they could be forcibly converted.

4)1500s: Under Kaji Chak and Musa Raina, who were influenced by Shia missionary Mir Shams-ud-Din Iraqi, thousands were forcibly converted. Those who resisted were massacred on the holy day of Ashura, according to K.L. Bhan.

5) Late 1600s: Mughal ruler Aurangzeb’s governor, Iftikhar Khan, used extreme force to convert the community. This led the Pandits to seek help from the Sikh Guru Tegh Bahadur, who was eventually killed while protecting them.

6) 1720s: During a period of Mughal decline, local fanatical leaders including the cleric Mullah Abdul Nabi imposed “jizya” or tax and banned Pandits from wearing turbans, shoes, or even riding horses.

7) 1753-1819: Afghan Rule is widely considered the darkest era. Afghan governors would tie Pandits in pairs in grass sacks and drown them in Dal Lake. It was said that “a Pandit’s life was not worth the price of a hen.”

8) 1989-1990: Modern militancy, the rise of Pakistan-sponsored insurgency and radical Islamism led to targeted killings and mosque announcements. This forced most of the community into exile. The Kashmiri Pandits’ ‘best times’ are often associated with the reign of Lalitaditya Muktapada in the 8th century and later, the peaceful rule of Zain-ul-Abidin in the 15th century. The latter invited Pandits back after a period of persecution, earning him the title Budshah, the great king. During these eras, the community thrived as administrators, scholars, and spiritual leaders. Life moved on after the accession of Jammu and Kashmir to India in 1948. The two communities, Pandits and Muslims, lived in harmony although Kashmiri Pandits were always viewed with a bit of suspicion because of their religious identification with the majority community of mainland India. Pandits were, however, acknowledged as good teachers and professionals (many were doctors and bureaucrats). Interestingly in spite of being Hindus they were very good teachers of the Persian language and were also recognised as good interpreters of the Quran. The most painful chapter in their modern history began in January 1990. As Islamic militancy surged in the Valley, fuelled by external support and internal radicalisation, the minority community was targeted with a campaign of terror. Slogans like “Raliv, galiv ya tchaliv (convert, die, or leave)” reverberated from loudspeakers of the mosques.

How China Got Trapped In Its Own 'Export Miracle'

Last week, China reported the world's largest ever trade surplus for 2025, a year when Donald Trump's tariffs on more than 90 countries gave a jolt to the global economic order. The Chinese trade surplus reached a massive \$1.19 trillion, despite Beijing reducing exports to the US by 20%. It simply sold much more to the rest of the world, including India. The staggering \$1.9 trillion trade surplus of China is just under half the size of India's GDP and close to the size of Saudi Arabia's, a G-20 member. Last year, China was the largest trading partner of Brazil - in America's backyard, of Central Asia - in Russia's backyard and the Gulf countries, where the US used to dominate. The US has already lost Africa to Beijing; if Trump continues with his disastrous tariff policies, even other regions could become China's number one trading partner, replacing the US. China has not had a global trade deficit since 1993. It has come a long way from being one of the world's poorest countries in 1978, when its leader Deng Xiao Ping introduced economic reforms, to becoming the world's second largest economy and a superpower. But in the process, China has also transformed the global economy, making everyone else dependent on it, based on a model that has created problems even for its own people. But can this model survive? The Making Of China's Economic Model Beijing's exports-based economic model has roots in Deng's reforms, which paved the way for the country to become the world's manufacturing hub. Large plants and factories were set up across the country to produce cheaper products for the rest of the world. Gradually, millions of Western manufacturing jobs were outsourced to factories in China. These state-subsidised plants forced many factories in other countries to close down because they could not compete with Chinese products. As early as 1994, silk farmers in India were complaining that the dumping of cheap Chinese synthetic silk in the country was driving them out of business. Beijing has often been accused of dumping its products in other countries. Such accusations have resurfaced after the publication of the lat-



est record surplus figures. But China has continued to expand its production capacity, diversifying into many new fields. The current Chinese leader, Xi Jinping, has taken the country's economic model to a new level. After becoming the head of the Communist Party in 2013, he focused on high-quality development by investing in strategic emerging industries to become a dominant force that could not only challenge China's rivals but also control them. Self-Reliance Or World Domination? At the core of China's economic strategy is making itself self-reliant, according to the Chinese leaders. Xi's 10-year programme, known as Made in China, launched in 2015 to reduce dependence on the West, has achieved most goals. Beijing's unprecedented investment in green technologies has made it the undisputed world leader in renewables, electric vehicles and many other fields. Over the week-end, China's state media reported that the country consumed 10.4 trillion kilowatt-hours of power in 2025, according to the National Energy Administration. This is more than double the use in the United States and exceeds the combined power consumption in India, Russia, Japan

and the European Union. This suggests industrial plants and AI data centres in China are working harder than anywhere else. Xi has also prepared China for a trade war with the United States and ordered his officials to work on choke points for its economy, which he successfully employed last year in response to Trump's tariffs. As early as 2019, Xi described rare earths and other critical minerals as an "important strategic resource." Beijing now has almost total control over the global supply of those minerals. India may be a leading supplier of pharmaceuticals, but China is the world's dominant producer of the ingredients needed to make antibiotics and other pharmaceuticals. The same is the case in the solar power industry. Global Domination But Domestic Repression China's economic growth helped its government to lift tens of millions of people out of poverty and make many others in the country rich, especially in the early years of reform. But its model of increasing growth by selling cheaply to the world has had its implications. For years, Chinese families subsidised the country's rise through foregone returns while the rest of the world splurged on dis-

counted Chinese goods. While the rest of the world is fighting inflation, China is facing an acute problem of deflation, where prices continue to drop, discouraging customers from buying in the fear that goods would be even cheaper later. This is caused by overcapacity in factories and weak domestic demand. A persistent decline in consumption signals deeper economic trouble. Last year, Chinese authorities promised new child-care subsidies, increased wages and better paid leaves to revive a slowing economy. But that has failed to have any meaningful impact. The collapse of the property market in recent years has also made Chinese consumers more risk-averse, leading them to cut back on spending. Domestic consumption drives more than 80% of growth in the US and UK, and about 70% in India. China's share has typically ranged between 50% to 55% over the past decade. So Xi has a hard task to encourage his countrymen to spend more. Falling Birth Rate China is facing another problem that is threatening its economic model. A shrinking population of youngsters and an ever-growing number of elderly people. On Monday, the authorities announced that the birth rate has now fallen to the lowest level since 1949, when Mao Zedong came to power after leading the communist revolution. Last year, only 7.92 million new babies were born, a decline of 17% over 2024. This means China will have fewer people to work in its factories to sustain its export-based economy. On top of that, young families now have to care for their elderly parents. The Social Security System in China is poor in comparison to other industrialised economies. The Chinese government has offered many incentives to encourage youngsters to have children and taxed contraceptives but young Chinese are not keen to produce babies. Currency Manipulation Western countries have often alleged that China's rise has been aided by the manipulation of the global system, using its state-owned or subsidised firms to buy depressed assets in other countries, and, above all, keeping its currency renminbi artificially low - which makes its products cheap.

When the educated stand and the illiterate sit: The insult of education in democracy

Any civilized society is defined by its education system and the respect it receives. Education is not merely a collection of degrees, but rather a culture of conscience, discipline, constitutional understanding, and public responsibility. The question is whether a democracy like India truly respects this education, or whether educated people in the corridors of power are merely destined to stand in a posture of obedience. In India, millions of young people reach the civil services after years of rigorous preparation, failure, and struggle. They enter the IAS, IPS, or other services after a thorough study of the Constitution, administration, economics, sociology, and policymaking. Even after selection, they face lengthy training, field postings, and constant accountability. On the other hand, these same officers are often seen standing with folded hands before public representatives whose educational background and administrative understanding are extremely limited. This is the scene where the truth of the system speaks, not satire—the illiterate are sitting, the educated are standing. The journey to becoming a civil servant is a years-long endeavor. The exam tests not just facts, but also thinking, analytical skills, ethics, and the ability to make decisions under pressure. Even after joining the service, every file, every order, and every signature must stand the test of future scrutiny. In contrast, there is no minimum educational

qualification required for entry into politics, nor is formal training in policy or administration mandatory. Public support is the soul of democracy, but when that very support becomes a veneer to conceal a lack of competence within the entire system, then the problems begin. Democracy means rule by the people, but democracy has never been a celebration of ignorance. Successful democracies value both political leadership and professional administration. There, the decision-making stage is dominated by facts and logic, not emotions. Our situation is developing into one where debates are more noisy and less scholarly. The heat of accusations and counter-accusations is high, and the light of data and facts is low. In such an environment, the bureaucracy, which represents knowledge and process, is reduced to a mere machine that obeys orders. This mentality gives rise to the scenario—the kurta is sitting, the uniform is standing. In the vision of independent India, khadi and khaki were considered complementary. Khadi symbolized public opinion, politics, and policymaking, while khaki symbolized law, order, and impartial implementation. A respectful relationship between the two was supposed to lay the foundation for good governance. Today, the situation is such that khadi often appears to impose its views through numerical strength and positional power, while khaki, fearing transfer, retaliation, or false accusations, refrains from offering prudent advice. Officers have come

to believe that "what the higher-ups want" is more important than "what is right." This mindset not only weakens administrative ethics but also calls into question the rule of law. This environment directly impacts the image of education in society. When young people repeatedly witness the scene where those who studied for years, passed competitive exams, and underwent training are left standing at the end, while those who climbed the political ladder without any preparation are left sitting and making the final decisions, disappointment naturally arises. The message is clear: education does not bring power, knowledge does not make decisions, and hard work does not ensure respect. Gradually, education becomes a mere means to obtain employment, not a means to guide society. Ironically, when policies fail, plans fail to materialize, or corruption is exposed, officers are often the first to be targeted. The reality is that most major decisions are made at the political level, and officers are the implementers of those policies. Yet, the entire responsibility for failure is placed on them. This is a double injustice—limited participation in decision-making, but complete accountability. The result is that honest and forthright officers are discouraged, and "silence and doing what is told" becomes the safe option. Whenever the question is raised about whether a minimum level of education and administrative understanding should be required for policymaking,

the immediate argument is, "Are you questioning the legitimacy of public representatives?" It should be clear that the question is not one of legitimacy, but of competence. Representatives are elected by the people; this is their democratic legitimacy, and it must be respected. But is a mandate in itself a certificate of expertise in every field? Should decisions affecting millions of people be made solely based on political expediency, caste equations, or electoral gains and losses? The question is simple—if qualifications and examinations are required for the jobs of doctors, engineers, teachers, or even ordinary clerks, how can leadership of a major ministry be considered possible without any training and minimal intellectual preparation? Democracy does not mean that "whoever gets elected knows everything"; it means that the elected leadership makes decisions with the help of experts, administrative experience, and constitutional values. The solution lies not in elevating officials to the highest order, nor in diminishing public representatives. The solution lies in balance. Public representatives should set policy direction and priorities; officials should shape that direction in accordance with the constitutional framework and administrative practicalities. Certain steps are necessary for this—mandatory constitutional and administrative training for public representatives, systematic orientation programs for new legislators and ministers.

Dear America, Keep Your Republic and Let Others Keep Theirs

It is not easy to play poker with Washington these days. It holds a trump card never seen in the deck before. It is now an ace, a king, a jack, and a joker with very dark intent. Siddaramaiah warns of Lok Sabha seat cut for southern states

Bengaluru, Jan 20 (UNI) Karnataka Chief Minister Siddaramaiah on Tuesday expressed concerns over a possible reduction in the number of Lok Sabha seats for southern states under the proposed delimitation of parliamentary constituencies, warning that it could undermine federal principles and democratic equity.

Speaking at a conference organised by the Centre for Socialist Studies and Samajwadi Sangama here, the Chief Minister said the proposed delimitation exercise posed a grave risk to southern states that had successfully implemented population control measures.

"The southern states controlled their population, invested in education and empowered women because the nation asked us to. Now we are told that success will be punished with reduced representation," he said.

Siddaramaiah reiterated that if delimitation was carried out strictly on the basis of the latest



census figures, southern states including Karnataka could either lose seats or see no increase, while northern states would gain more representation.

He recalled that earlier estimates suggested Karnataka's Lok Sabha seats could fall from 28 to 26 if the exercise was based on the 2021 or 2031 census. Undivided Andhra Pradesh could see a drop from 42 to 34 seats, Kerala from 20 to 12, and Tamil Nadu from

39 to 31.

The Chief Minister urged the union government to either use the 1971 census as the base for delimitation or expand the total number of Lok Sabha seats in a manner that does not rely solely on population figures.

At the event, Siddaramaiah said democracy could not reward failure and penalise progress. "If this injustice continues, South India will be politi-

cally marginalised in its own country. Federalism is not charity. It is a constitutional right," he asserted.

He also alleged that Karnataka was facing fiscal injustice despite being a major contributor to the national economy. "We contribute nearly Rs 5 lakh crore annually to union taxes and about 8.4 per cent of India's GDP with just around 5 per cent of the population, yet receive barely 13 paise for every rupee sent. Our share was cut by the 15th Finance Commission, special grants were denied, over Rs 53,000 crore was lost through cesses, and even severe drought relief was ignored," he said.

Siddaramaiah accused the Centre of undermining cooperative federalism by centralising resources. "When the union hoards resources through cesses, cuts devolution, delays disaster relief and denies States their constitutional dues, it is not reform, it is a betrayal of the Constitution," he added.

Drive to Remove Unauthorized Hoardings, Flexes and Banners in Bengaluru Central City Corporation Limits: Daljit Kumar

88.91 lakh voters listed in draft rolls of five city corporations

Opportunity to submit claims and objections from January 20 to February 3, 2026

Bengaluru: In connection with the conduct of elections under the Greater Bengaluru Authority (GBA), the draft electoral rolls were published. Citizens are advised to verify whether their names are included in the draft electoral rolls and, if not found, to immediately submit applications in the prescribed forms to get their names included. All citizens aged 18 years and above should ensure that their names are included in the electoral rolls, stated State Election Commissioner G.S. Sangreshi during a joint press conference held at GBA Head Office.

The ward-wise draft electoral rolls of the five City Corporations under the jurisdiction of the Greater Bengaluru Authority include a total of 8,891,411 voters, informed State Election Commissioner G.S. Sangreshi.

Speaking to the media after releasing the draft electoral rolls, he stated that elections will be conducted under the GBA jurisdiction covering five City Corporations —



Bengaluru Central, Bengaluru North, Bengaluru South, Bengaluru East, and Bengaluru West — comprising a total of 369 wards.

The draft electoral rolls have been prepared with October 1, 2025 as the qualifying date. The rolls include 45,69,193 male voters, 43,20,583 female voters, and 1,635 other voters, totaling 88,91,411 voters, he explained.

From January 20, 2026 to February 3, 2026, Booth Level Officers (BLOs) will visit households for verification. During this period, citizens will have the opportunity to submit claims and objections, he said. The disposal of claims and objections will be carried out from February 4 to February 18, 2026, and the final electoral rolls will be published on March 16, 2026, he added.

Among all wards, Ward No. 23 of Bengaluru West City Corporation has the highest number of voters

with 49,530, while Ward No. 16 of Bengaluru East City Corporation has the lowest number of voters with 10,926. A total of 8,044 polling stations will be set up across the 369 wards, he informed.

Nutritious meal employees hold state-wide protest pressing demands

CHENNAI: The nutritious meal employees attached to TNNMEA on Tuesday commenced their four day protests across the state pressing for various demands including revised pension, filling up of vacancies among others.

As the talks held with the government failed on January 19, the association decided to hold protest in all the districts of the State from Tuesday till January 23, 2026, A Jessie, secretary, the Tamil Nadu Nutritious Meal Employees Association (TNNMEA) told reporters.

"We have been hoping that our demands will be fulfilled. We met the department officials on Monday and since the talks have failed, we are forced to stage protest till January 23 in all the district capitals," she added. Expressing her disappointment with the DMK Government for not fulfilling the associations'



long-pending demands, she said over 71,000 workers are taking part in the protests across Tamil Nadu.

"Tamil Nadu has over 1 lakh nutritious meal centres and 71,000 workers are engaged in it. This Association has been functioning for the last 45 years and we have been poorly

paid. Our pension is Rs 2,000 only. During the 2021 elections, the DMK promised that it will fulfil our demands. But in the last 4.5 years it did not," she alleged.

"Since our demands are not met, we are forced to protest. If government is ready to talk with us, we

are ready to reconsider our decision," she said.

As part of intensifying their protest, the association has also planned to stage an agitation in front of the District Collectorates on January 24 and 25, across Tamil Nadu.

Meanwhile, the PMK faction led by Dr Anbumani Ramadoss, in a statement said that due to the protests initiated by the nutritious meal workers, "the students depending on these centres will face a situation where they cannot get food". The Nutritious meal workers serve as the backbone of the government administration. They are the ones who act as a bridge between the government and the people, the statement urged. "Without further delay, the government should hold talks with the nutritious meal workers and fulfil their demands," it further said.

TN asks Centre to scrap VB-G RAM G, restore MGNREGA to reduce financial burden

The discontinuation of the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) has not only hindered development in rural areas but also increased the financial strain on the state government, it said.

CHENNAI: The Tamil Nadu government on Tuesday urged the Centre to withdraw the recently passed VB-G RAM G act and restore UPA-era rural employment scheme, MGNREGA, thereby easing the state's financial burden.

The discontinuation of the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) has not only hindered development in rural areas but also increased the financial strain on the state government, it said.

"Due to the Viksit Bharat-Guarantee for Rozgar and Ajeevika Mission (Gramin) VB-G RAM G, the financial burden on Tamil Nadu will further increase by approximately Rs 5,000 crore per annum," Tamil Nadu Assembly Speaker M Appavu said while reading out Governor's address to the Assembly. The governor had walked out of the state Assembly without delivering his customary address during the maiden session of the year, citing "inaccura-



cies" in the text prepared by the DMK government.

Reading the Tamil version of the governor's address, Appavu said the new scheme VB-G RAM G undermined the fundamental objective of the MGNREGA, a programme designed to ensure wage employment for crores of poor and underprivileged people in rural areas, particularly women and Adi Dravidar communities.

He noted that through MGNREGS, which provides social security to the rural poor, numerous projects such as infrastructure development, natural resource

conservation, greening and watershed management have been successfully implemented in rural areas.

Tamil Nadu has consistently received several national awards for the successful implementation of this scheme. "Considering that the state government is already facing significant challenges in implementing its own schemes due to the increased state share under various Centrally Sponsored Schemes, the introduction of this new scheme must be viewed as part of the Centre's adverse intent," he said. He added that the new scheme should be with-

drawn and the Central government should restore and allocate additional financial resources to MGNREGA.

On language policy, the state government reaffirmed that the Tamil Nadu State Education Policy continues to follow the two-language formula of Tamil and English, a policy maintained since 1968.

"We have been safeguarding the two-language education policy formulated by former Chief Minister C N Annadurai as dearly as our own eyes. When it comes to protecting the Tamil language, which is inseparable from our life and emotions, there can be no room for compromise," he said. The government added that under no circumstances will it, under the leadership of Chief Minister M K Stalin, accept any alteration to this policy. On other matters, the government said the CM's efforts helped Tamil Nadu achieve robust economic growth of 11.19 per cent during the last financial year, the highest in the past 14 years.

ED shares fresh inputs linking Nehru to Rs 366-cr MAWS scam

CHENNAI: The Enforcement Directorate has shared fresh inputs regarding an alleged Rs 366 crore worth money laundering and corruption ring in the transfer and appointments of officials and engineers in the Tamil Nadu Department of Municipal Administration, Urban and Water Supply (MAWS), officials said on Tuesday.

The federal probe agency's Chennai zonal office has sent a letter in this context to state chief secretary and the directorate of vigi-

lance and anti-corruption (DVAC) seeking registration of a police FIR against minister K N Nehru and some others linked to him.

The ED had also written two separate letters to the state government authorities in October and December last year claiming "wide spread" corruption in the MAWS tenders and recruitments and linked Nehru to these charges. The said PMLA provision empowers ED to share information and evidence regarding an offence with the police

or a designated law enforcement agency. In its latest communication, the ED informed the TN government that it has recovered photos, WhatsApp chats and documents which show "many" instances of bribes being collected for the transfer and posting of government officers and engineers in MAWS. It claimed that alleged bribe amounts ranging from Rs 7 lakh to Rs 1 crore, depending on a case-by-case basis, were being transacted in the case of about 340 MAWS officials.

TN Assembly session to continue till January 24

CHENNAI: The maiden session of the year of the Tamil Nadu Legislative Assembly (TNLA), which began here on Tuesday, would be held till January 24. TNLA Speaker M Appavu made an announcement to this effect among media persons in his chamber after the day's proceedings of the House began on a stormy note with Governor R N Ravi not reading the government's address in protest of the non-rendering of the national anthem at the beginning of the address.

Madras HC reserves order on actor Vijay's Jana Nayagan censor certification

CHENNAI: The Madras High Court on Tuesday reserved its order on the censor board's appeal against a single-judge direction to grant U/A certificate to Vijay-starrer 'Jana Nayagan'.

A bench of Chief Justice Manindra Mohan Shrivastava and Justice G Arun Murugan heard the appeal, after the Supreme Court had on January 15 asked the Madras HC to decide on the plea on January 20, and reserved its order. The apex court



had refused to entertain the plea filed by the producer of 'Jana Nayagan', challenging an interim order of the Madras High Court that stayed a single-judge direction to grant censor board clearance to the movie. On January 9, the division bench of the Madras High Court stayed a single judge's

order directing the Central Board of Film Certification (CBFC) to immediately grant a censor certificate to 'Jana Nayagan', leaving the fate of actor-turned-politician Vijay's film, which has drawn attention for its political overtones, in limbo. Vijay recently launched his political party, Tamilaga Vettri Kazhagam (TVK). 'Jana Nayagan', which is widely publicised as Vijay's final film before his full-fledged entry into politics, was slated for a Pongal release on January 9.

WOMAN KILLED, OVER 10 INJURED AS HELIUM GAS CYLINDER EXPLODES AT RIVER FESTIVAL NEAR KALLAKURICHI

CHENNAI: A 50-year-old woman was killed and more than 10 others were seriously injured after a helium gas cylinder exploded during a river festival on the banks of the Thenpennai River near Manalurpet, close to Tirukoilur in Kallakurichi district, on Monday evening. The incident occurred around 7 pm when one of the two helium gas cylinders used by a balloon vendor suddenly exploded with a loud blast, triggering panic among the devotees gathered at the venue.

Green Energy Revolution: Breakthrough in Hydrogen Fuel Cells

As the global shift towards renewable energy sources gains momentum, there arises a crucial challenge: how to store energy effectively for periods when solar and wind power aren't available. One leading contender, the hydrogen fuel cell, just got a big boost, thanks to fundamental research stemming from the Department of Energy's SLAC National Accelerator Laboratory, Stanford University, and the Toyota Research Institute (TRI), that was recently translated to practice in a fuel cell device via a collaboration between Stanford and Technion Israel Institute of Technology.

Hydrogen fuel cells have really great potential for energy storage and conversion,



using hydrogen as an alternative fuel to, say, gasoline," said Michaela Burke Stevens, an associate scientist with SLAC and Stanford University's joint SUNCAT Center for Interface Science and Catalysis and one of the

senior authors on the study. "But it's still fairly expensive to run a fuel cell."

The Cost Dilemma of Fuel Cells

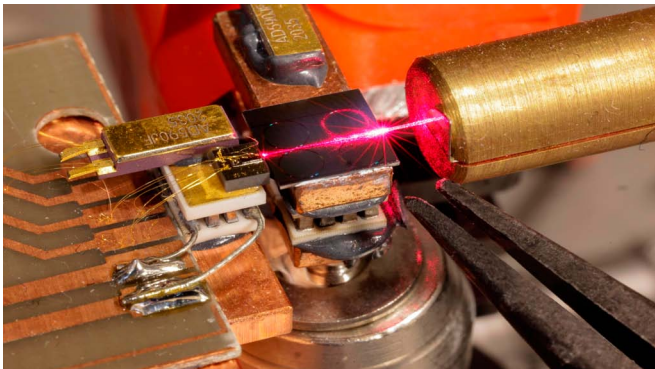
The problem, Burke Stevens said, is that fuel cells typically rely on a catalyst –

packed with expensive platinum group metals (PGM) – that boosts the chemical reaction that makes the system work. That led Burke Stevens and her colleagues to search for ways to make the catalyst cheaper, but making such a fundamental change to a fuel cell's chemistry is a daunting challenge: Scientists often find a catalyst that works in their small lab setup doesn't work out so well when a company tries it in a real-world fuel cell. This time, the researchers balanced costs, by partially replacing PGMs with a cheaper alternative, silver; but the real key was to simplify the chemical recipe for getting the catalyst onto the cell's electrodes. Scientists typically mix the catalyst into a liquid and then spread it onto the mesh electrode,

but these catalyst recipes don't always play out the same way in different lab environments with different tools – making it difficult to translate the work into real-world applications. "Wet chemical processes are not particularly resilient with respect to laboratory conditions," said Tom Jaramillo, director of SUNCAT, which made the collaboration possible.

To get around that issue, the SLAC team instead used a vacuum chamber for more controlled depositions of their new catalyst onto electrodes. "This high-vacuum tool is a very 'what you see is what you get' type of method," said Jaramillo. "As long as your system is calibrated well, in principle, people can reproduce it readily."

Micro-Ring Resonators: Advancing Laser Technology



EPFL researchers have developed a hybrid device that significantly improves existing, ubiquitous laser technology. The team at EPFL's Photonic Systems Laboratory (PHOSL) has developed a chip-scale laser source that enhances the performance of semiconductor lasers while enabling the generation of shorter wavelengths. This pioneering work, led by Professor Camille Brès and postdoctoral researcher Marco Clementi from EPFL's School of Engineering represents a significant advance in the field of photonics, with implications for telecommunications, metrology, and other high-precision applications. Innovative Integration for Improved Coherence and Visibility The study, published in the journal Light: Science & Applications, reveals how the PHOSL researchers, in collaboration with the Laboratory of Photonics and Quantum Measurements, have successfully integrated semiconductor lasers with silicon nitride photonic circuits containing microresonators. This integration results in a hybrid device capable of emitting highly uniform and precise light in both near-infrared and visible ranges, filling a technological gap that has long challenged the industry. Semiconductor lasers are ubiquitous in modern technology, found in everything from smartphones to fiber optic communications. However, their potential has been limited by a lack of coherence and the inability to generate visible light efficiently," explains Professor Brès. "Our work not only improves the coherence of these lasers but also shifts their output towards the visible spectrum, opening up new avenues for their use." Coherence, in this context, refers to the uniformity of the phases of the light waves emitted by the laser. High coherence means the light waves are synchronized, leading to a beam with a very precise color or frequency. This property is crucial for applications where precision and stability of the laser beam are paramount, such as timekeeping and precision sensing. The team's approach involves coupling commercially available semiconductor lasers with a silicon nitride chip. This tiny chip is created with industry-standard, cost-efficient CMOS technology. Thanks to the material's exceptional low-loss properties, there is little to no light that is absorbed or escapes. The light from the semiconductor laser flows through microscopic waveguides into extremely small cavities, where the beam is trapped. These cavities, called micro-ring resonators, are intricately designed to resonate at specific frequencies, selectively amplifying the desired wavelengths while attenuating others, thereby achieving enhanced coherence in the emitted light. The other significant achievement is the hybrid system's ability to double the frequency of the light coming from the commercial semiconductor laser— enabling a shift from the near-infrared spectrum to the visible light spectrum. The relationship between frequency and wavelength is inversely proportional, meaning that if the frequency is doubled, the wavelength is reduced by half.

Neuroscience Revolution: AI Precision in Tracking Moving Neurons

EPFL and Harvard scientists develop an AI-based method for tracking neurons in moving animals, enhancing brain research efficiency with minimal manual annotation. Recent advances allow imaging of neurons inside freely moving animals. However, to decode circuit activity, these imaged neurons must be computationally identified and tracked. This becomes particularly challenging when the brain itself moves and deforms inside an organism's flexible body, e.g. in a worm. Until now, the scientific community has lacked the tools to address the problem.

Development of AI Method for Neuron Tracking

Now, a team of scientists from EPFL and Harvard have developed a pioneering AI method to track neurons inside moving and deforming animals. The study, now published in Nature Methods, was led by Sahand Jamal Rahi at EPFL's School of Basic Sciences. The new method is based on a convolutional neural network (CNN), which is a type of AI that has



been trained to recognize and understand patterns in images. The team has made their CNN accessible, providing a user-friendly graphical user interface that integrates targeted augmentation, streamlining the process into a comprehensive pipeline, from manual annotation to final proofreading. By significantly reducing the manual effort required for neuron

segmentation and tracking, the new method increases analysis throughput three times compared to full manual annotation," says Sahand Jamal Rahi. "The breakthrough has the potential to accelerate research in brain imaging and deepen our understanding of neural circuits and behaviors." This involves a process called "convolution," which looks at small

parts of the picture – like edges, colors, or shapes – at a time and then combines all that information together to make sense of it and to identify objects or patterns. The problem is that to identify and track neurons during a movie of an animal's brain, many images have to be labeled by hand because the animal appears very differently across time due to the many different body deformations. Given the diversity of the animal's postures, generating a sufficient number of annotations manually to train a CNN can be daunting.

Targeted Augmentation

To address this, the researchers developed an enhanced CNN featuring 'targeted augmentation'. BHARAT STEEL TO SHAPE GLOBAL DIALOGUE ON THE FUTURE OF STEEL

New Delhi, 13 Jan, 2026: As India prepares to host Bharat Steel 2026, a global platform to reshape future of steel, the nation is signalling its intent to showcase the next era of global steelmaking forged by R&D, digitalization, innovation, and access to high skilled engineering and technology human resources. The two-day summit in New Delhi will bring together policymakers, technology pioneers and industry leaders to confront the defining challenges of the decade: building resilient supply chains and accelerating the transition to low-emission steel production. Steel has played a pivotal role in modern economies, akin to a skeleton", emphasised Shri Narendra Modi, the Prime Minister of India, remarking that whether it is skyscrapers, shipping, highways, high-speed rail, smart cities, or industrial corridors, steel is the strength behind every success story. "India is striving to achieve the goal of becoming a \$5 trillion economy, with the steel sector playing a significant role in this mission", he added during India Steel 2025, expressing pride in India being the world's second-largest steel producer. The Prime Minister's vision forms the corner-

stone of this year's Bharat Steel summit, which seeks to reimagine a global blueprint for the steel sector at a time marked by economic uncertainty, fragmented trade flows, rising protectionist tariffs, and the urgent imperative of achieving net-zero goals. India's leadership is rooted in both scale as it is already among the largest steel producers and ambition, with a national target of 300 MT of steel production capacity by 2030 and 500 MT by 2047. India's steel demand continues to grow across infrastructure, housing, railways, defence and energy. But achieving 500 MT requires more than added capacity; it demands

secure raw materials, predictable regulations and innovation-led modernisation. Strengthened domestic beneficiation, reduced coking-coal dependence, improved logistics and efficient approvals form the backbone of this supply-side push. The Government's Production Linked Incentive (PLI) scheme for specialty steel is reshaping the sector, shifting India from commodity-grade output toward high-value precision engineered steels essential for aerospace, automotive, defence and advanced infrastructure. 'Green' steel lies at the heart of India's competitiveness. The Ministry of Steel's 2024 Green-Steel Roadmap outlines the transi-

tion to clean energy integration, green hydrogen pilots, CCUS deployment, expanded scrap utilisation and emerging routes like direct electrolysis. Digitalisation; covering IoT monitoring, robotics, automation and predictive maintenance; will be a core Summit theme. AI-based optimisation promises efficiency gains, lower waste and improved quality. This technology thrust will be reinforced by expanded R&D, deeper partnerships, clearer tech-transfer pathways and pilot-scale trials for emerging processes. As global trade moves toward carbon-accounting norms, India aims to position itself as a major exporter of low-emission, high-grade steel. The National Steel Strategy prioritises joint ventures in hydrogen-based DRI, CCUS and electrolysis technologies, supported by targeted investment incentives. The Bharat Steel Summit thus marks a pivotal moment; one in which India seeks to chart a global roadmap for a steel sector that is secure, competitive, climate-aligned and future-ready. Such direction will ensure that steel remains not only the backbone of India's infrastructure, but also the spine of sustainable progress and global industrial leadership.

Chagos sovereignty no longer up for debate, says Mauritius, after Trump criticises UK deal

Mauritius' attorney general has responded to Donald Trump's criticism of the Chagos deal, stressing that it still expects the agreement to go ahead. In the written statement, Gavin Glover says it is "important to remember" that the deal was "negotiated, concluded and signed exclusively between the United Kingdom and the Republic of Mauritius". "The sovereignty of the Republic of Mauritius over the Chagos Archipelago is already unambiguously recognised by international law and should no longer be subject to debate," it says. "We expect the treaty to be implemented as soon as possible, in accordance with the commitments made." The government's opponents argue that giving up the Chagos Islands represents an act of national self-harm and a boost to the United Kingdom's rivals, especially China. The arguments include an element of



post-imperial hand-wringing but also the fear that the base at Diego Garcia, vital to both the UK and United States, will soon be more vulnerable. The base's remote location makes it extremely difficult to monitor, except from space. But if Mauritius decides to open up the waters of the Chagos archipelago to commercial fishing, this could change. "Beijing uses its fishing fleet as the eyes and ears of

its military," Jack Watling of the Royal United Services Institute wrote in November 2024. "There is a significant risk that such vessels will soon ply the waters around the base." If such concerns were shared by in Washington, there was little sign of it last summer when US Secretary of State Marco Rubio spoke in glowing terms of what he called "this monumental achievement". In February

last year, Donald Trump said he had "a feeling that it's going to work out well". It's not clear why he seems to have changed his mind so dramatically. Donald Trump's post on his Truth Social platform earlier positioned the Chagos Islands deal as a matter of national security for America, referring to Diego Garcia as "the site of a vital US Military Base". The US launched a huge construction project

on the island in the 1970s and spent 10 years turning it into a fully operational military airbase. The site, and operations there, are highly secretive. Here are some of the operations it has been involved in before: During former US President George W Bush's so-called War on Terror, following the 9/11 (11 September) attacks, US stealth bombers would stop off at Diego Garcia as they returned from bombing-runs of al-Qaeda targets in Afghanistan. It was later a key base for US and UK operations during the Iraq War. Troops and bombing aircraft were stationed there, as well as the giant US Navy hospital ship USNS Comfort. More recently, in May 2025, satellite imagery from Earth data analytics company Planet Labs showed that the Pentagon had deployed bombers to the island. This came after the US ramped-

up its bombing campaign against the Houthi rebel group in Yemen and amid tensions with Iran. Downing Street has said the US still supports the deal to hand sovereignty of the Chagos Islands to Mauritius, despite President Trump calling it "an act of great stupidity". The prime minister's official spokesperson says: "Our position hasn't changed on Diego Garcia or on the treaty that's been signed." "The US supports the deal and the president explicitly recognised its strength last year," they say. "All our Five Eyes allies support it too and they all understand the national security capabilities that the base provides." When the UK took control of the Chagos Islands - Diego Garcia is the southernmost - from former British colony Mauritius, it sought to rapidly evict its population of more than 1,000 people to make way for the military base.

France makes first interception targeting small boat crossings to UK



French officials have made their first interception on the water as part of a new policy aimed at stopping small boats carrying illegal migrants to the UK. A so-called "taxi-boat" was boarded by French officers on Saturday on the Aa canal in Gravelines, which is on the Channel coast above Calais. It follows a change of tactics agreed in November following growing pressure from the UK government to step up interventions. A photograph of the aftermath of the operation

obtained by the BBC shows a number of men - apparently people-smugglers - on an inflatable dinghy with the police launch alongside. The inflatable is then towed to the dockside. The French maritime prefecture declined to comment to the BBC, saying only that there was "an ongoing judicial investigation" regarding the small boat. France agreed to the new tactics at a summit in the UK last July between President Emmanuel Macron and Sir Keir Starmer.

Palestinian children's football pitch faces Israeli demolition ultimatum



A Palestinian children's football club in the occupied West Bank faces imminent demolition despite an international campaign to save it. Its supporters say it provides a rare sporting opportunity for young Palestinian players. But Israel insists it's been built without the necessary permits. In this deeply divided land so much is contested; from the identities and faiths of the people who live here, to every inch of the ground they stand on. Recently, that has come to include one small patch of artificial turf laid down under the shadow of the giant concrete wall that isolates Israel from much of the occupied West Bank. In the context of the 7 October attacks, the two-year war in Gaza and the fragility of the current ceasefire, there are without doubt far more pressing issues. But this is a story freighted with symbolism and one which has drawn outsized international attention because of its

connection to that other world religion - football. On the day we visit, a group of Palestinian children are lining up to take penalty shots in the winter sunshine. The construction of the pitch began here on the edge of Bethlehem in 2020, and today it provides a place to practise for more than 200 young players from the nearby Aida refugee camp. The cramped and crowded streets contain the homes of the descendants of Palestinian families who were forced or who fled from their homes during the 1948 Arab-Israeli war. On 3 November last year, as the children made their short walk from the camp for that day's training, they found a notice pinned to the gate of the football field declaring it to be illegal. The notice was followed soon by a demolition order. "We don't have anywhere else to play," 10-year-old Naya told me, wearing a Brazil shirt with the name of the footballing legend Neymar emblazoned on the back.

Spain train crash recovery continues as investigators probe 'gap' in rail

Heavy machinery is being used to assist in the recovery following a two-train crash in southern Spain which killed at least 41 people. Rescuers worked through a second night and said the death toll included three bodies still trapped in a wrecked carriage. More than 120 people were injured when carriages on a Madrid-bound train derailed and crossed over to the opposite tracks, hitting an oncoming train in Adamuz on Sunday evening. Sabotage has been ruled out, the interior minister has said, and the initial focus of investigators is on a broken rail on the high-speed line. Prime Minister Pedro Sánchez has cancelled his planned



trip to the World Economic Forum in Davos, pledging to get to the bottom of Spain's worst train disaster in more than a decade. Spain's King Felipe and Queen Letizia visited the site on Tuesday, shaking hands and speaking to emergency service workers near the site of the crash on the first of three days of

national mourning. Transport Minister Óscar Puente said the death toll "is not yet final", and officials are working to identify the dead. Puente said the investigation could take at least a month, describing the incident as "extremely strange". Interior Minister Fernando Grande-Marlaska ruled out sabo-

tage, telling reporters that it "was never considered", and he stressed that all hypotheses remained open. Óscar Puente warned against speculation and said a lot of cracks had been found on the track but investigators would have to determine whether they had caused the derailment or had been caused by it. A 30cm gap in one of the rails is the current focus of the investigation, according to Spanish reports. Technicians told El Mundo newspaper that a "bad" or "deteriorated" weld was "more than likely" the cause for the derailment. Ignacio Barrón, head of Spain's Commission of Investigation of Rail Accidents (CIAF).

US officials probing Minnesota ICE protest that disrupted church service

The US justice department has said it is investigating protesters who disrupted a Sunday service at a Minnesota church because they believed a pastor there worked for Immigration and Customs Enforcement (ICE). Video showed protesters inside the church chanting "ICE out" and "Justice for Renee Good", the woman killed by an ICE agent in Minneapolis earlier this month. Justice department officials, who accuse the protesters of "desecrating a house of worship", say they will investigate them for civil rights violations. President Donald Trump has called them "agitators and insur-



rectionists". Anti-ICE protests continue in the state against Trump's immigration crackdown. Over the weekend, ICE officers arrested a naturalised US citizen at his St Paul home, after breaking down his front door. Videos showed officers escorting Chong Ly

Thao, clad only in shorts with a plaid blanket over his shoulders, out of his house with his hands behind his back. Images of the 56-year-old walking to a car in his snow-covered neighbourhood with an ICE agent at each elbow quickly spread across social media.

Thao was returned home later on Sunday. "I was praying. I was like, God, please help me, I didn't do anything wrong. Why do they do this to me? Without my clothes on," Thao, a Hmong man born in Laos, told Reuters. The Department of Homeland Security told Reuters that officers were investigating two individuals convicted of sexual offences who were linked to the address. Thao's family told Reuters that one of the individuals of interest previously lived at the address, but had moved out. The Pentagon has reportedly put 1,500 soldiers on standby for possible deployment.

Nigerian homicide police investigate death of singer Destiny Boy at 22



Police in Nigeria have made one arrest as they investigate the death at 22 of popular singer Destiny Boy, whose real name was Afeez Adesina. Ogun state police's homicide section is dealing with the case, it said in a brief statement. News of Destiny Boy's death emerged on Sunday, sparking shock and speculation on social media. It is not clear exactly what happened but his family reportedly said he had been suffering from a long-term illness. The body has since been buried in line with Muslim rites. Destiny Boy was seen as a promising young Afrofuji artist, known for blending traditional Yoruba Fuji sounds with modern Afrobeats. He came to national prominence after his 2019 version of popstar Davido's hit song Ife went viral on social media. He later recorded his own renditions of other popular songs as well as original tracks. Following the young man's death, videos shared widely on social media showed what appeared to be his body being transported to a mortuary, triggering

rumours about what may have led to his death. Family members have said the singer had been living with a long-term illness, which they said caused him to have seizures. In an online video, his mother, Saida, stated that the family had sought both medical and traditional treatment for the condition. She said the illness "had almost run him mad", adding that relatives had to physically restrain him during seizures to prevent him from running out. Nigerians online have been sending condolence messages, with some questioning the circumstances of his death. On X, artist Ruger appeared to be complaining that there had been "no autopsy" and "we just have to accept that he's dead." May God RIP Destiny Boy". The artist began his career as a backup dancer for Fuji musician Pasuma at T2 Boys Studios in Agege, a suburb of Lagos, before gaining wider attention in 2019. His death comes about a year after the birth of his first child with his partner, Iremide, in November 2024.

DONALD TRUMP SAYS HE WILL '100%' CARRY OUT GREENLAND TARIFFS THREAT, AS EU VOWS TO PROTECT ITS INTERESTS

Donald Trump has vowed to "100%" follow through on his threat to impose tariffs on European countries who oppose his demand to take control of Greenland. European allies have rallied around Greenland's sovereignty. Denmark's foreign minister emphasised the US president cannot threaten his way to ownership of the semi-autonomous Danish territory. UK Foreign Secretary Yvette Cooper reiterated the UK's position that the future of Greenland is for "Greenlanders and for the Danes alone" to decide. On Monday, Trump declined to rule out the use of force and insisted he would press ahead with the threatened tariffs on goods arriving in the US from the UK and seven other Nato-

allied countries. In a post to Truth Social in the early hours of Tuesday morning, the US president said he had a "very good telephone call" with Nato secretary general Mark Rutte, and agreed to a meeting "of various parties" in Switzerland this week. He went on: "Greenland is imperative for National and World Security. There can be no going back — On that, everyone agrees!" Trump has said he will charge a 10% tariff "on any and all goods" sent from the UK to the US from 1 February, increasing to 25% from 1 June, until a deal is reached for Washington to purchase Greenland from Denmark. He said the same would apply to goods from Denmark, Norway, Sweden, France, Germany, the



Netherlands and Finland - all of whom are members of the defence alliance Nato which was founded in 1949. Asked if he would follow through on the tariff threat, Trump told NBC News: "I will, 100%." When the outlet asked whether he would use force to seize the territory, the president replied "no comment". Trump added: "Europe ought to focus on



the war with Russia and Ukraine because, frankly, you see what that's gotten them... That's what Europe should focus on - not Greenland." Denmark has warned that US military action in Greenland would spell the end of Nato. In recent days, Greenland has received support from European members of the alliance - some even sent a

handful of troops to Greenland last week in a move seen as symbolic. However, Trump followed that deployment with an announcement to impose tariffs on the eight Nato allies. Danish foreign minister Lars Løkke Rasmussen said that Europe had to show President Trump tariff threats were "not the way forward". "We have red lines that can't be crossed," he told Sky News. "You can't threaten your way to ownership of Greenland. I have no intention of escalating this situation." Germany's Chancellor Friedrich Merz said that the tariffs did not benefit anyone, and he hoped to meet with the US president during his trip to Davos for the World Economic Forum. He said:

"We do not want this escalation. We do not want a trade dispute with the United States of America." He also added that the Trump administration would not have been surprised by Nato's so-called reconnaissance mission over the weekend, as it had been announced and agreed upon beforehand. "It was never a military action," the German chancellor said. The European Union is to hold an emergency summit in Brussels for its leaders on Thursday where they will discuss how to respond to Trump's latest threat to take over Greenland. Kaja Kallas, the EU's foreign policy chief, said the bloc has "no interest to pick a fight, but we will hold our ground".

With Tilak out of the first few matches due to injury, Suryakumar revealed that Kishan will be batting at No. 3. While Shreyas Iyer was another option for the No. 3 slot, the India captain explained that Kishan will be given the chance as he is a part of the T20 World Cup squad. Kishan was included in the T20 World Cup squad in place of Shubman Gill, keeping "team combination" in mind, while Shreyas was included as a replacement for Tilak for the first three T20I matches. "Ishan will bat at number 3 because he is a part of our T20 World Cup team and he was picked in the squad first so it's our responsibility to give him a chance," he said in the pre-match press conference. "He hasn't played for India for



past one and half year and in the mean time consistently performed in domestic cricket," the Indian skipper did not leave any room for guess work. "Since he (Ishan) has been picked for World T20, he deserves to play ahead (of Shreyas). Had it been a question of batting slots Nos 4 or 5, it would have been a different question altogether. Unfortunately, Tilak isn't there so Ishan is our best bet," he added. When asked if he himself has any chance of

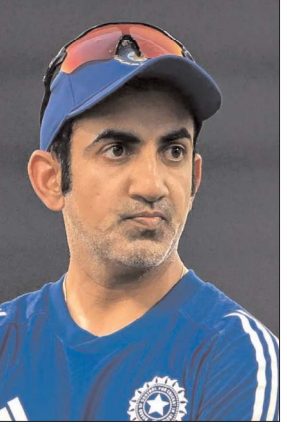
batting at No.3 where he got a lot of success, the skipper indicated that he would like to be flexible. "I have batted at both positions for India. My stats at No. 4 are slightly better although they are good at No. 3 also. But then we are flexible with that," he said. 50-over World Cup, you'll remember each winner from the time the World Cup started. So, yes, if you want to have your setbacks and poor performances, get it out of the system now, in time for the next World Cup," he added. "These bilateral series are sched-

uled, but they're mostly warm up games and one shouldn't read too much into them. In fact, the importance of these bilateral series has become such that, two weeks later, no cricket fan also remembers the result of what happened in that bilateral ODI series," he explained. "It's all about the World Cups and form coming into the World Cup is really not a big indicator of who's going to win the World Cup," he further stated. India take on New Zealand in five T20Is, starting Wednesday, January 21. These five matches will be Suryakumar Yadav-led India's final games before they begin the defence of their T20 World Cup title on home soil.

Manjrekar had described ODIs as the "easiest format", and expressed his disappointment at Kohli's decision to play only the 50-over format. However, after Kohli smashed yet another century on Sunday - this time in a losing cause against New Zealand - his brother took to social media to hit back at Manjrekar's earlier comments. "I wonder if Mr Expert of Cricket has some suggestions for the easiest form of cricket. You need to be there to do that. Anyways, as I said, easier said than done," Vikas Kohli posted on his official Threads account, subtly referring to Manjrekar's statements. This is not Vikas Kohli's first criticism of

Manjrekar's comments, having made a post referring to the same just a few days earlier. "Such an easy format isn't it ... someone gave his gyaan a few days back... easier said than done...", he had said. Ben Affleck Says He Had Food Poisoning While Filming Goodbye Scene With Bruce Willis in 'Armageddon'

Ben Affleck has revealed an unexpected behind-the-scenes detail from Armageddon, sharing that he was severely unwell while filming one of the film's most emotional moments with Bruce Willis. Speaking to Fox 32 Chicago, the actor said he was suffering from food poisoning when he shot the goodbye scene between AJ Frost and Harry Stamper. At the time, Affleck admitted, he didn't feel confident enough to step away from work despite his condition. "I wasn't an experienced enough actor to know that you can just pick up the phone and say, 'I'm too sick to work today,'" he said. Instead, he pushed through the shoot — even though it meant "vomiting between takes". Looking back, Affleck joked that his physical discomfort may have actually enhanced his performance, quipping that it "probably made the scene better." The moment he

refers to is a key emotional beat in Michael Bay's 1998 disaster epic, in which AJ bids farewell to Willis' Harry Stamper, a veteran oil driller who sacrifices himself to manually detonate a bomb and save Earth from a massive, planet-threatening asteroid. Armageddon featured a large ensemble cast including Liv Tyler, Billy Bob Thornton, Will Patton, Steve Buscemi, William Fichtner, Owen Wilson and Michael Clarke Duncan. The film follows a group of roughneck deep-core drillers recruited by NASA for a near-impossible mission to stop an asteroid the size of Texas from colliding with Earth. Despite drawing mixed responses from critics, the film was a box office juggernaut, finishing as the highest-grossing release of 1998 and becoming Touchstone Pictures' most successful film at the time. Affleck also recently reflected on the expe-

rience while reconnecting with Buscemi at the premiere of his new Netflix film, The Rip. The encounter, he said, brought back vivid memories of Armageddon. "We were reminiscing about that movie and thinking about how that was the weirdest, kind of wonderful, strange, otherworldly movie experience," he recalled. The scene from Armageddon that Affleck is referencing is the emotional moment when his character A.J. Frost says his final goodbye to Willis' Harry Stamper, the heroic oil driller. Stamper sacrificed himself and stayed behind the asteroid to destroy it manually before it collided with Earth. Looking back on the experience, Affleck reckoned that his medical emergency, "probably made the scene better." The remark earned a laugh from Matt Damon, who was sitting beside him during the interview. The duo is cur-
