America is now world's hottest economy: Trump

New Delhi (TSIT): US President Donald Trump on Wednesday addressed the World Economic Forum (WEF) in here, where he strongly promoted what he called the "American growth miracle" and praised his administration's economic record. Speaking to global leaders and business executives, Trump said the United States had

transformed from a "dead economy" into the "hottest economy in the world" within one year of his return to the White House. He claimed that growth, productivity, investment and incomes were all rising rapidly, while inflation had been brought under control. "After 12 months back in the White House, our economy is booming. Growth is exploding, productivity is surging, investment is soaring, incomes are rising. Inflation has been defeated," Trump said, calling it the fastest and most dramatic economic turnaround in US history. Trump sharply criticised former President Joe Biden, accusing his administration of creating stagflation, a situation of low growth and high inflation.

7-year-old on way to school crushed to death

Hyderabad (TSIT): A Class-I student of an Army School was killed, and her mother was critically injured when a two-wheeler they were riding skidded and fell under an Army vehicle in Telangana. The shocking incident occurred near Trimulgherry in Secunderabad on Wednesday. The seven-year-old boy, a student of Trimulgherry Army School, was on his way to the school and was riding pillion on the scooter driven by his mother. When they reached near the RK Puram Flyover, the scooter skidded. An Army truck coming behind ran over them. The child died on the spot, while her mother sustained grievous injuries. She was shifted to a hospital, where her condition is stated to be critical. The shocking visuals of the child getting crushed under the front wheel of the Army vehicle were recorded on CCTV. Neredmet police registered a case and took up the investigation. According to police, the boy's father serves in the Indian Army and is currently posted in Jammu and Kashmir. In another road accident in the city, three people were injured when a car overturned.

Telangana targets \$25 billion investment in life sciences by 2030



Hyderabad (TSIT): The Telangana government has set the target of attracting \$25 billion investment in life sciences in the next five years. The government unveiled Telangana Next-Gen Life Sciences Policy 2026-2030 at Davos with a clear roadmap to position Telangana among the top five global life sciences clusters by 2030.

Chief Minister A. Revanth Reddy, who is leading a delegation of ministers and top officials at the World Economic Forum (WEF) annual meeting, released the policy. Industry minister Sridhar Babu said that the policy targets \$25 billion in investments and the creation of 5 lakh new jobs, with a strong focus on high-value R&D, advanced biologics and therapies, and environmentally sustainable manufacturing. According to him, key initiatives include Green

Pharma City, flagship Pharma Villages, and 1Bio, a first-of-its-kind growth-phase centre and biopharma scale-up manufacturing facility. The State government will also establish a dedicated Life Sciences Innovation Fund, scalable up to Rs 1,000 crore (\$111 million). "With Hyderabad already home to the World Economic Forum's Fourth Industrial Revolution (C4IR) Network and the world's first centre focused on healthcare and life sciences, Telangana is uniquely positioned to lead the next wave of global life sciences innovation. We are building a future-ready ecosystem that is science-led, sustainable, and globally competitive," the minister said.

By leveraging its established strengths in pharmaceutical manufacturing, vaccine production, and R&D, while strategically diversifying into emerging

fields such as biologics, precision medicine, and bio-manufacturing, Telangana is poised to redefine healthcare and life sciences innovation, says the policy document. Telangana currently contributes 40 per cent of India's pharmaceutical production. The state is the only region in the world housing over 250 USFDA-approved manufacturing sites.

The state has also earned the reputation of being the vaccine capital of the world and played a key role in saving millions of lives during the COVID-19 pandemic. With a total vaccine production capacity of approximately 14 billion doses, it has solidified its leadership position as a global vaccine hub. The state is also emerging as a leader in the manufacturing of medical devices and diagnostic equipment/reagents with a flourishing ecosystem.

Won't use force, but US needs Greenland for strategic reasons: Trump at Davos

Davos (TSIT) President Donald Trump on Wednesday said the US will not use force to take Greenland and stressed that only America can protect the mineral-rich island, which is at the centre of escalating geopolitical tensions with Europe.

Speaking at the annual meeting of the World Economic Forum, Trump said the US is booming but Europe is "not heading in the right direction".

"I have tremendous respect for people of Greenland and Denmark, but only the US can secure Greenland," Trump said in his 70-minute-long speech during which he launched a blistering attack on NATO allies on a range of issues, including tariffs, environment and immigration.

"We fought for beautiful Denmark, which is not a land, but a big piece of ice, cold and poorly located. It is a very small ask compared to what we have given them for many, many decades. We were stupid to give it back," Trump said, staking claims over the region. "People thought I would use force. I don't have to use force. I don't want to use force. I won't use force." Trump said that Greenland, which is a Danish territory, has a strategic location between the US, Russia and China. "The US needs it for strate-



gic reasons, not for rare earth minerals." Only the US can protect Greenland, and many European nations have also acquired territories; there is nothing wrong with it. "We were a powerful force when we saved Greenland and gave it to Denmark after World War II, but we are much more powerful now," Trump said.

He also called for immediate negotiations for the US to acquire Greenland from Denmark, describing the country as ungrateful, during his speech at Davos. The President also spoke on the US' economic strength and global prosperity, saying "the USA is the economic engine of the planet". "When America booms, the entire world booms."

EAM Jaishankar, Spanish FM pledge deeper ties

New Delhi (TSIT): External Affairs Minister (EAM) S Jaishankar held a meeting with Spanish Minister of Foreign Affairs, European Union and Cooperation Jose Manuel Albares on Wednesday, discussing bilateral cooperation, including in trade, investments, defence, technology, education sectors besides people-to-people ties. EAM Jaishankar expressed gratitude to Spain for its support for deepening ties between India and European Union in various sectors. "Held wide-ranging discussions this morning with FM Jose Manuel Albares of Spain on our bilateral cooperation and world affairs. Spoke about trade, investments, defence, technology, education and people to people ties. Reaffirmed our strong political dialogue," EAM Jaishankar posted on X.



AP Minister Nara Lokesh Accelerates Investment Push at Davos WEF 2026



Amravathi (TSIT) In a high-energy outreach at the World Economic Forum (WEF) Annual Meeting 2026, Andhra Pradesh's Minister for IT, Education, and RTG Departments, Nara Lokesh, intensified efforts to position the state as a premier hub for technology and renewable energy investments.

Lokesh held a series of targeted meetings with top executives from leading

global firms in fintech, green energy, and artificial intelligence, pitching Andhra Pradesh's strategic advantages, infrastructure, and policy support to attract substantial capital inflows.

The minister's agenda focused on transforming Visakhapatnam into a key tech and fintech center while advancing renewable energy projects across the state. He presented clear investment proposals highlighting port infrastructure, skilled talent pools, and supportive ecosystems for startups and innovation.

A standout meeting was with Nikhil Kamath, Founder of prominent stock-broking platform Zerodha. Lokesh proposed establishing a Technology Development Center in Visakhapatnam as part of the city's plan to emerge as a fintech hub. The center would concentrate on platform engineering, backend systems, trading algorithms, and data analytics.

Mamata directs DMs to strictly follow SC guidelines during electoral roll revision, avoid harassment

Kolkata (TSIT): West Bengal Chief Minister Mamata Banerjee on Tuesday instructed district magistrates to strictly adhere to the Supreme Court's directions while conducting hearings related to the Special Intensive Revision (SIR) of electoral rolls, stressing that people should not be harassed in the name of "logical discrepancies".

The chief minister made the remarks after unexpectedly joining a meeting chaired by Chief Secretary Nandini Chakraborty with district magistrates at the state secretariat, Nabanna.

According to a senior official, Banerjee made it

clear that all SIR-related hearings must be conducted strictly as per the apex court's instructions. She expressed concern that people were facing inconvenience due to hearings over so-called logical discrepancies and said the process should be approached with a humanitarian outlook.

"She underlined that documents recognised as valid by the Supreme Court must be accepted without

exception during the hearings. District magistrates were also asked to ensure that receipts are issued to citizens after submission of documents," the official said. The chief minister further directed officials to make alternative arrangements for voters who are unable to attend hearings on the scheduled dates.

Banerjee emphasised that while the Election Commission's work should continue, the state's development programmes must not be disrupted under any circumstances. She also assured officials that they need not fear, stating that her government stands firmly with them.

AP Speaker moots salary cut for MLAs not attending Assembly

Amaravati, Jan 21 : Andhra Pradesh Assembly Speaker Chintakayala Ayyanna Patrudu on Wednesday suggested a 'no work, no pay' policy for MLAs who are not attending the Assembly.

He also mooted the proposal to give voters the 'Right to Recall' such public representatives.

The Speaker made the suggestion at the 86th All India Conference of Presiding Officers on "Accountability of Legislature towards the People" at Lucknow. He was apparently hinting at Opposition YSR Congress Party (YSRCP) MLAs who have not been attending the Assembly.

All 11 MLAs, including



YSRCP president and former Chief Minister Y. S. Jagan Mohan Reddy, have been skipping Assembly sessions to press their demand for Leader of Opposition status for Jagan Mohan Reddy. The Speaker said that the failure of some legislators to perform their duties is most regrettable.

"In the Andhra Pradesh Legislative

Assembly, some of the members have not attended even a single day of sessions nor participated in a single debate till date since their election to the House in June 2024. To make matters worse, most of these members who do not attend the House regularly draw their salaries and allowances. As a Speaker, this causes me great pain," he said.

"How can we avoid being belittled by the public with such unethical behaviour? How can such conduct be justified?" he asked. Stating that there are no specific rules to prohibit this kind of behaviour, he requested the Lok Sabha Speaker to show a way forward. He

also sought advice from his fellow Speakers.

"This is not just an issue for the Andhra Pradesh legislature. The public will use these examples to paint all elected representatives with the same brush. No one is exempt from public criticism," he said.

The Speaker made two suggestions in this regard. He said that just as employees' salaries are withheld if they do not attend duty, the salaries and allowances of public representatives should be cut for non-attendance. "For those elected representatives who still do not learn a lesson, there is no choice but to send them back to the 'People's Court'.

from Nagarkurnool, pushed aside BRS MLA Vijayaram during an argument over a protocol issue at the launch of development programmes at Paipadu in Vaddepally municipality. The MP was angry when Vijayudu, the MLA from Alampur, wanted to break coconuts as part of the tradition. A video of the incident shared by BRS on social media shows Mallu Ravi pushing aside the MLA and shouting, "Who are you to break the coconuts?" BRS MLA, along with party leaders, were at the launch of development works by the MP. AICC General Secretary Sampath Kumar and other Congress leaders were present.

Playback singer Sunitha Upadrashta on Tuesday launched the poster for Band Capricio's 30-city USA tour—billed as the largest-ever American trek by a Telugu live act—at a Hyderabad media gathering. Eknath Kiran and Shravan of the six-piece outfit called the unveiling a "full-circle" moment, recalling that Sunitha first took them to the US years ago when they were starting out.

The February–March 2026 "Rise Tour" will open phase one of the marathon run, presented by New Jersey-based promoter Vedom Art and co-presented by Eleven Point Two. Vedom Art, creator of the GigVedom indie-music festival, will handle production across venues stretching from Dallas to Detroit. Sunitha wished the band "memorable and successful shows," saying their growth symbolises Telugu music's widening global footprint. Tickets go on sale this week; city-wise dates are expected to drop shortly.

Medcover Hospitals, Secunderabad on Wednesday commissioned the city's newest MAKO robotic-arm system for hip and knee replacements, with Hyderabad police commissioner V.C. Sajjanar, IPS performing the ceremonial

launch. The Stryker platform, already used in leading U.S. and European centres, lets surgeons map a patient's anatomy in 3-D before surgery and guides the bone cuts intra-operatively to within 1° and 1 mm accuracy. Chief robotic

joint-replacement surgeon Dr. Uday Krishna Maineni said the technology allows minimally invasive cuts, smaller incisions, less blood loss and, in selected cases, same-day discharge. Chairman Dr. Anil Krishna noted that bringing the 6-crore system to Telangana keeps high-end joint care within India and offloads overseas medical travel. The first robotic cases—two total knee replacements—are scheduled next week. Medcover plans to extend robotic assistance to shoulder and spine units later this year, cementing its pitch as a precision-orthopaedics hub.

Together, they represented the domains of computer science, robotics, and AI-driven research. During their visit, the faculty engaged closely with CMU researchers and academicians to understand how AI is seamlessly integrated into academic programmes, research initiatives, and industry collaborations. Key areas of focus included AI applications in quantum computing,

language models, robotics, and interdisciplinary projects addressing real-world and societal challenges. Speaking about the visit, Prof. Ch Satish Kumar, Vice Chancellor, SRM AP, said, "Our engagement with Carnegie Mellon University offered valuable global perspectives on integrating AI into higher education. Faculty members play a crucial role in systematically embedding artificial intelligence across the curriculum, research initiatives, and institutional strategy. Such international exposure enables us to benchmark our practices and further strengthen SRM AP's vision of research-led education."

He also noted that the faculty members were actively involved in research discussions and academic collaborations, which will contribute significantly to meeting global academic and research standards at SRM AP.

Reflecting on collaborative learning practices, Dr M Naveen Kumar observed, "The emphasis on peer programming, Think-Pair-Share models, and collaborative problem-solving creates an environment



where students actively participate in learning, enhancing critical thinking and adaptability."

Sharing her observations on pedagogy and student engagement, Dr Saleti Sumalatha said, "Carnegie Mellon University follows a deeply student-centric approach to teaching. Methods such as reflection-based learning, critique-based activities, design sprints, pair and mob programming, inquiry-driven discussions, and indirect assessment help students build strong conceptual understanding."

She added that implementing several of these approaches in her own database courses resulted in a 100 per cent student success rate. Highlighting CMU's research ecosystem, Dr Ashu Abdul noted that the university places strong emphasis on societal impact and industry relevance. Students across academic levels are actively involved in addressing real-world industry challenges. He cited insights shared by Professors at CMU who collaborated with Meta, on projects such as compact AI-based language models for SRM University-AP, Andhra Pradesh, Neerukonda, Mangalagiri Mandal, Guntur District.

"Beyond publishing research

papers, CMU prioritises building market-ready prototypes and refining them through user feedback and market research. This application-driven approach plays a key role in producing industry-ready graduates," he added.

Commenting on advanced research infrastructure, Dr Sunil Chinnadurai said, "The visit provided valuable exposure to cutting-edge work in robotics and AI, particularly hyperspectral robotic vision. This has significant applications in assistive robotics and automation." He further noted that the interactions led to the initiation of a collaborative research project involving undergraduate students from SRM AP, offering them hands-on, industry-relevant experience.

Faculty also interacted with Dr Raj Reddy, widely regarded as the Father of AI in India, who shared insights on strengthening AI laboratories and aligning academic research with industry needs at SRM AP. The faculty plan to disseminate these learnings through a Faculty Development Programme to ensure broader institutional impact. The second Cohort has already departed for CMU. The outcomes of the visit are expected to strengthen AI integration, research capacity, and innovative teaching practices at SRM University-AP, reinforcing its commitment to globally relevant education and interdisciplinary research.

EDITORIAL

HOW TO FEED 10 BILLION PEOPLE

Rome: With the world struggling to feed eight billion people today, how will we feed ten billion by 2050? Meeting the nutritional needs of a growing population requires not just a radical increase in food production – almost all of it plant-based – but also a more equitable distribution to ensure that no one is food-insecure. That is a tall order. The current food system is already buckling. Roughly 673 million people go to bed hungry every night, and in 2025, we witnessed two famines (in Gaza and Sudan), each driven by conflict, climate shocks, and soaring food prices. At the same time, 1.66 billion hectares – 60% of which are agricultural land – have been degraded by the very practices we rely on to feed the world.

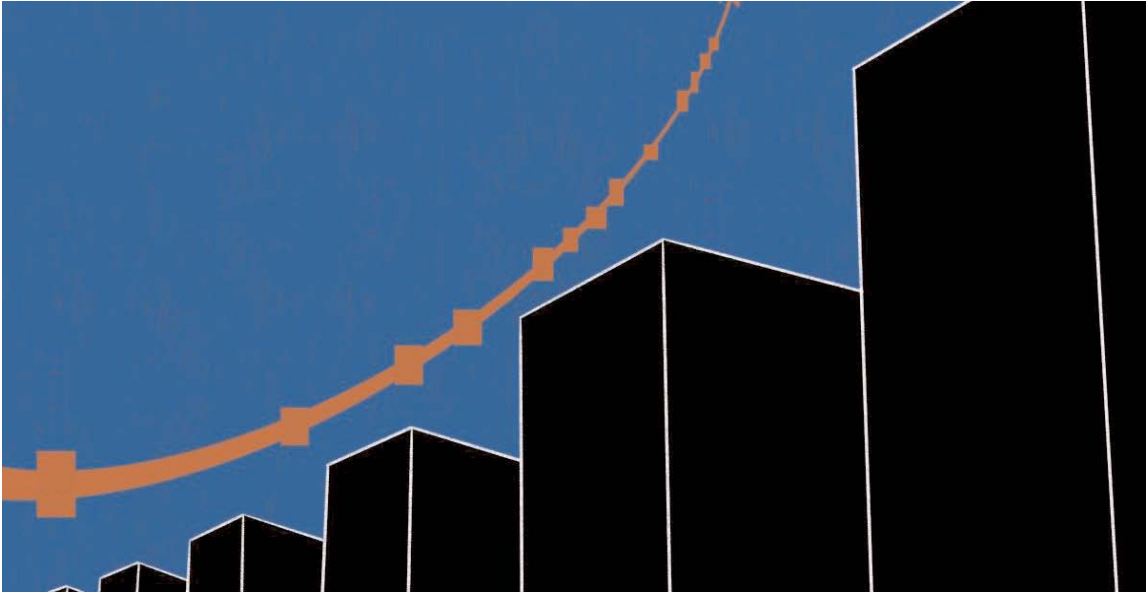
Global hunger stems not from a lack of capacity to produce enough food, but partly from our failure to produce it efficiently and distribute it evenly. Conflict and insecurity remain the dominant causes of hunger across 20 countries and territories, leaving nearly 140 million people facing acute food insecurity. Disasters have inflicted an estimated \$3.26 trillion in agricultural losses worldwide over the past 33 years – an average of \$99 billion annually, or roughly 4% of global agricultural output; and recent supply-driven food-price spikes have pushed tens of millions of people into hunger almost overnight. Worse, these are not one-off shocks. They represent the new normal. For decades, the agriculture sector has responded well to rising demand by developing higher-yielding crops and using more of everything: more fertiliser, more pesticides, and more water. Yet this trend has produced unnecessary waste, polluted rivers, degraded the soil, and released ever-more greenhouse gases (GHGs). We need to find a better path, and science can show us the way. We already have the knowledge and the tools to optimise what we use and diversify what we grow.

One priority is to improve efficiency. Between 1990 and 2020, fertiliser use rose 46% and pesticide use doubled. But only 30-60% of fertiliser nutrients and 20-70% of pesticides are effectively absorbed; the rest washes into rivers, degrades soil, or releases GHGs. Fortunately, research shows that optimising nitrogen use can boost yields by up to 19% and slash fertiliser use by 15-19%. Improved pesticide management – through precision spraying, biopesticides, and residue monitoring – reduces chemical waste while safeguarding biodiversity. Agroecological practices – such as intercropping, crop rotation, and integrating trees into farm systems – further enhance soil health, lower input dependence, and strengthen long-term resilience.

The next priority is to diversify the food system. Decades of productivity gains have fostered a dangerous dependency on just three crops. Wheat, rice, and maize now provide most of the world's calories. Such reliance on monocultures creates profound vulnerability to pests, diseases, and climate change. The solution lies in the crops we have marginalised. Traditional and underused species – hardy millets, nutrient-dense legumes, indigenous fruits, robust yams – offer ample nutrition alongside other benefits such as climate resilience. United Nations Food and Agriculture Organization initiatives like Future Smart Food (in Asia) and 100 Crops for Africa demonstrate how these “forgotten” crops can simultaneously expand diets, boost farm incomes, and restore degraded soils. Finally, we must scale up effective technologies. Data analytics and precision-agriculture tools are already reshaping farming. Drones can plant seeds and deliver inputs with pinpoint accuracy. AI platforms can use satellite imagery to provide tailored, real-time recommendations. Robots can detect weeds for targeted spraying, avoiding the need for blanket herbicide applications.

Venezuela, Greenland and Why The Rich Gathered in Davos Aren't Going to Change Anything

Capitalism always taught us that market economy and fair play were its founding principles. That anybody, any country, could get rich by 'hard-work' and following the rules. Yet, the world doesn't run on the fancies of a market economy. If that were true, we wouldn't have had the many wars in the first place. The latest geopolitical ongoing; the assault on Venezuela, Trump's threats of seizing Greenland, the controversial 'Board of Peace' plan for Gaza, all show that it is time for another round of resource grab. In fact, resource grab is the central principle of capitalism. Its origin story is that of plunder, from colonialism, slave trade, looting of Africa, India and so on. It continues with the policies enacted via Bretton Woods institutions. And it is nourished with a resource-grab war now and then. And this time the self-endorsed leader of the neoliberal paradise, Donald Trump, has made the ambitions of his empire as clear as possible. It's astonishing how a person can go about inciting wars, giving threats to countries and asking for a Nobel Peace Prize all at the same time. Every sane person knows the real motive behind the political turmoil in Venezuela was oil. Yet the American establishment kept shifting the narrative to drugs, and democracy. But as soon as President Nicolas Maduro was brought to the US, everybody from Trump to Marco Rubio reverted to their interest in Venezuelan oil. With high national debt, rising consumer debt, inflation and inequality, the US economy is facing significant challenges at home. It needs more resources to stay afloat. It needs to maintain its petrodollar hegemony to stay on the top. For the unaware, the US dollar is deeply linked with oil money. In the early 1970s, the US signed a contract with Saudi Arabia that all oil trade payments must be done in dollars. That forces countries to maintain a balance of dollars in their forex accounts. But today, the world has shifted. BRICS countries hold over 40% of the world GDP. An estimate says about 20% of global oil trade is already happening in other currencies, Euros, Chinese yuan, rubles and even digital payment systems. And this was exactly the crime of Venezuela. It had started to accept payments for its crude oil in yuan and other currencies. Trump's outbursts on Truth Social clearly show

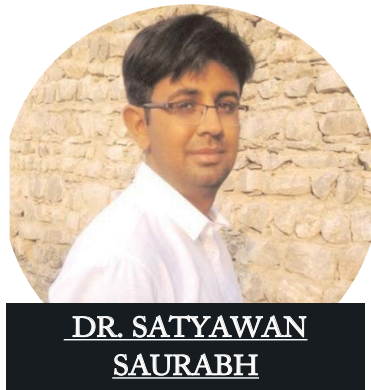


how much a talk of this de-linking of dollar from oil trade ruffles them. Even before he assumed the presidency, in December 2024, he wrote on Truth Social, “The idea that the BRICS Countries are trying to move away from the Dollar while we stand by and watch is OVER.” No wonder that they couldn't stand that Venezuela, a country heavily sanctioned by the US, was still managing to keep itself afloat. When the US sanctions a country, usually the world follows. See the extent of sanctions on the people of Venezuela; its elected government officials can't travel to other countries, and their assets are frozen in the US. Of course there was a ban on oil imports from Venezuela, yet Chevron was granted an exception. Other countries importing Venezuelan oil also faced a 25% extra tariff from the US. Apart from that, efforts were made to sabotage the oil industry in Venezuela, with bans on imports of machinery, technology, even the crucial naphtha used in oil production. Tankers of oil moving in and out of Venezuela were targeted. In such a situation, how could Venezuela develop its oil industry? The country was never left in peace. Political coups destabilised it, while hybrid wars remained a constant feature in Venezuela. After all this, the IMF data says that Venezuela's GDP is going to be -3%. This is like tying someone's hands and then blaming them for not working. A study published in Lancet looked at the impact of US sanctions on 152 countries between 1971 and 2021. It estimated that about 600,000 deaths occurred each year in these 50

years in these countries as a direct and indirect result of US sanctions. The scale of this data is horrifying. Between 1971 and 2021, US sanctions have caused about 3 crore deaths in 152 countries. Unfazed by sanctions, China found a way to trade with Venezuela, and also other Latin American countries. Out of 33 Latin American countries, 24 are part of China's Belt and Road Initiative. China is building critical infrastructure and renewable energy projects in many of these countries. Between 2000 and 2023, China invested \$100 billion in Venezuela. This investment went into crucial infrastructure like railways and power plants. In return, Venezuela supplies oil to China. Last year, 80% of Venezuela's oil exports went to China. Experts say the US attack on Venezuela isn't just about Venezuela – it's also an attack on China's growing influence. Trump is simply not able to digest China's growing influence in Latin America. A few weeks ago, he pressured a Hong Kong-based company to sell two major ports on the Panama Canal. They were sold to the US company BlackRock. And now the unprovoked threat to Greenland, a sovereign nation, is only a testament to the new imperial vision of America. In this new vision, the US refuses to acknowledge the sovereignty of other nations. Either they work as extended colonies of the US, or they face its ire. From tariffs to sanctions or outright military action, this is the new US foreign policy. Though Russia and China often become enemies in this game, they are a smokescreen behind which the

US pursues its interest. What's appalling is these are not even the legitimate interests of a nation, but of a few elite corporations. Perhaps that is why a real-estate man like Trump is their best bet to make the best deals. If you look closely, the US military is carrying out the job of boosting profits and expanding markets for American private companies. From oil companies to Big tech giants, the promoters of the US economy want to reap maximum profits. The controversial 'Board of Peace' initiative further consolidates the power of a few elites over democratic institutions built with decades of effort. Invitations have been sent to over 60 nations, including France, Germany, Italy, Hungary, Australia, Canada, India, Pakistan, and the Middle East countries. Countries can pay \$1 billion for a permanent seat on the board or stay there for free for 3 years. Donald Trump is to remain its chair for life. His son-in-law Jared Kushner is directly involved in the workings of the board. Even Russia has been invited to be a member of the board. What is the message to the world? Is it that the UN and other independent institutions, formed after the second world war, now irrelevant? The world's elites are directly going to thrust themselves in conflicts, and the resulting 'deals'? That the exploits of the genocide are up for grabs, come and take your pick? Morality and humanity are things of the past, forget progress and innovation, just grab natural and public resources, supplement them with cheap labour in slavery like conditions!

Uniform, dignity and a crisis of trust



The police system is the most sensitive and influential face of power in a democracy. The police are not only law enforcement agencies but also a symbol of the state's moral strength. When a top official within this system faces serious ethical allegations, questions are not limited to the individual, but raise concerns about the credibility, accountability, and conduct of the entire system. The suspension of a senior IPS officer and DGP (Civil Rights Enforcement) of Karnataka after the emergence of an allegedly objectionable video points to this deep crisis. The alleged video clips, which went viral on social media, created a stir in administrative and political circles. The state government's swift suspension decision indicates that the matter was not limited to personal conduct, but rather involved the dignity of public office and institutional prestige. However, it is equally essential that a fair and transparent investigation be conducted before any individual is legally convicted. This is the balance of democracy—neither ignoring allegations nor passing judgment before investigation. The police uniform is more than just a mere garb. It symbolizes trust between citizens and the state. An officer, particularly at the rank of DGP, is not merely an administrator issuing orders but also a face that sets ethical standards for the entire force. His or her conduct conveys the message of where the system stands. When such allegations are leveled against a top official, it's

natural for ordinary citizens to question: "If those responsible for formulating policy and enforcing discipline are so careless about decorum, how can we expect justice from the system?" This is the point where personal conduct becomes a matter of public concern. This incident highlights another important aspect—the impact of social media. Today, any alleged video or content can spread widely within hours. This has increased transparency, while also exacerbating the risk of rumors, editing, and misuse. Therefore, the state and investigating agencies face a dual challenge: to thoroughly investigate the facts while respecting public sentiment. Taking administrative action based on viral content on social media is a sensitive decision. The Karnataka government's decision to suspend demonstrates an effort to establish accountability at an early stage, ensuring an impartial investigation. It's important to understand that suspension is not a punishment in itself, but a process to clear the way for an investigation. It's often argued that an official's private life should be separate from their work. This may seem true in theory, but for those in high constitutional or administrative positions, the line between private and public life is very thin. The reason is clear: their every action becomes linked to the image of the institution. If the alleged acts are considered contrary to public morality, the dignity of women, or the dignity of the office, they cannot be dismissed as merely a “private matter,” especially when the acts involve public symbols, uniforms, or official settings. The biggest question in this entire episode is one of institutional accountability, transcending the individual. Are the mechanisms within our administrative structure robust enough to identify behavioral deviations in a timely manner? Is the internal code of conduct for senior officials merely on paper? Society expects a prestigious cadre like the IPS to not only enforce the law but also pro-

vide ethical leadership. If the alleged lapse of a single officer casts doubt on the image of the entire force, it signals the need for a fresh look at internal oversight and ethical training. The most important message in any democratic state is that the law applies equally to everyone, whether ordinary citizens or high-ranking officials. If allegations are proven after investigation, action must be taken that makes it clear that position, influence, and identity are not above the law. Furthermore, if the allegations are found to be false or exaggerated, it is equally important to restore the reputation of the officer involved. Justice does not only mean punishment, but also establishing the truth. The average citizen seeks not only protection from the police but also moral assurance. They want to believe that those in charge of the law are themselves within the bounds of law and decorum. When such incidents occur, public trust is shaken—and this poses the greatest threat to any democracy. Therefore, the responsibility of governments and institutions should not be limited to immediate action. They must also consider how to prevent such incidents from recurring in the future—through training, psychological counseling, ethical evaluation, and clear accountability processes. The Karnataka DGP case isn't just a case of alleged conduct by one officer. It reflects a broader question about how strong our balance is between power, ethics, and accountability. Suspension is a preliminary step, not a final conclusion. The true test will lie in a fair investigation, a transparent process, and a just decision. Democracy is strengthened only when institutions show the courage to reform themselves. To protect the dignity of the uniform, the decorum of office, and the trust of the public—all three require that the law be administered without fear or favor. This should be the most important message to emerge from this entire episode.

India's Timeless Ideals Face the Perils of Majoritarian Power Now

In the Rig Veda, among humanity's earliest surviving texts, a deceptively simple line unsettles every politics of exclusion: Ekam sat vipra bahudha vadanti – truth is one, the wise call it by many names. Long before pluralism became a constitutional principle or a liberal slogan, it was articulated as a civilisational instinct. India did not merely tolerate difference; it theorised it, ritualised it, and—at its best – governed through it. The Upanishads argued not for uniform belief but for shared inquiry. Adi Shankara's Advaita Vedanta did not erase difference; it wove contradiction into coherence. Bhakti and Sufi saints – Kabir, Nanak, Ravidas – collapsed rigid boundaries through devotion that refused to ask whether God answered Ram or Rahim. Disagreement was not a threat to truth; it was its method. This philosophical disposition was not confined to metaphysics. It shaped statecraft. Ashoka, ruling over a vast and wounded empire, responded to the carnage of Kalinga not with triumphalism but remorse. His edicts warned against disparaging other sects, arguing that honouring differences strengthened one's own faith. Akbar later translated this ethic into governance – abolishing discriminatory taxes, convening interfaith dialogue, and articulating sulh-e-kul, peace with all. These were not acts of benevolence alone; they were recognitions that legitimacy in India flowed



from inclusion. Even epic imagination reflected this moral order. Valmiki's Ramayana described Ramarajya not as rule by religious dominance but by impartial justice—where the weak were protected, the poor heard, and power restrained by dharma. Gandhi reclaimed this idea, carefully stripping it of sectarian meaning. His Ramarajya was not a Hindu state but a moral republic, grounded in self-rule, restraint, and equal regard. Independent India's founders attempted to institutionalise this inheritance. Ambedkar's Constitution did not privilege belief; it protected conscience. Nehru insisted that the state must act as an umpire, never a player. Secularism, in the Indian sense, was not hostility to religion but neutrality among them. It is against this long arc that recent developments have unsettled observers – within India and beyond. Critics argue that the post-2014 political order marks not a routine ideological shift

but a redefinition of the state's moral posture. Where the republic once mediated difference, it increasingly appears to arbitrate identity. Where power once sought legitimacy through accommodation, it now draws energy from consolidation. The Citizenship Amendment Act of 2019 crystallised these anxieties. By introducing religion as a criterion for fast-tracked citizenship, it punctured a foundational premise of constitutional equality. Coupled with proposals for a nationwide National Register of Citizens, it triggered fears – particularly among Muslims – of statelessness by bureaucratic design. The protests that followed were among the largest in independent India's history. The state's response – police crackdowns, internet shutdowns, and selective enforcement – deepened the sense that dissent itself was being reclassified as disloyalty. Institutional guardrails have also come under strain. The Election Commission, once admired

for muscular impartiality, has faced sustained criticism for delayed or uneven responses to incendiary campaigning. Judicial independence has been shadowed by opaque transfers and post-retirement appointments that invite questions about incentive and pressure. Investigative agencies, according to publicly available data cited by opposition parties and civil liberties groups, have overwhelmingly pursued leaders outside the ruling coalition – fuelling the perception that law has become an instrument of political management rather than neutral accountability. For minorities, these shifts have been felt less abstractly. Cow-protection vigilantism, documented by independent monitors, has claimed dozens of lives since 2015, disproportionately Muslim and Dalit. The 2020 Delhi riots – sparked amid charged political rhetoric – left over 50 dead, most of them Muslim, and raised troubling questions about policing failures.

Mangaluru: Congress launches hunger strike against ‘dilution’ of MGNREGA, announces 100-km

Mangaluru, Jan 21: Strongly opposing changes to the name and structure of the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Congress workers under the leadership of the Dakshina Kannada District Congress Committee staged a hunger strike on Wednesday in front of the Mahatma Gandhi statue at Rajaji Park near the Town Hall here. Addressing the protesters, District Congress Committee president K Harish Kumar alleged that the NDA-led Central government, by renaming the MGNREGA scheme, had “killed Mahatma Gandhi for the second time”. He said the Centre had altered the very essence of the Act, a move that would impose an increased financial burden on all states.

Condemning the changes, Harish Kumar said the protest was aimed at demanding that



the original form of the MGNREGA Act, enacted during the UPA regime, be retained. To create public awareness on the issue, he announced that a 100-kilometre padayatra would be undertaken from Sullia to Mulki in Dakshina Kannada district from February 9 to 12. Senior Congress leader Ramanath Rai, speaking on the occasion, said that during the tenure of the UPA government, several pro-people legislations were introduced, including the Food Security Act,

MGNREGA, Right to Information Act, and Right to Education Act. He asserted that Congress had never caused hardship to the poor, Scheduled Castes, or minorities in the country, adding that if anyone had been affected, it might have been landlords and capitalists. “The Congress party has always functioned with a pro-people ideology,” he said. Rai also criticised a recent incident during the Paryaya celebrations at Sri Krishna Mutt in Udupi, stating that it was

inappropriate for the district administration to hoist a saffron flag during a religious programme. He said the display of a politically motivated flag at a temple event deserved strong condemnation.

Addressing the gathering, MLC Ivan D’Souza said the Central government, by amending the guidelines of the MGNREGA scheme—which had provided employment to nearly 18 crore people—had dealt a severe blow to the livelihoods of the rural poor. He alleged that the government, unable to tolerate Mahatma Gandhi’s name being associated with the Act, had removed it and renamed the programme as Viksit Bharat-Guarantee for Rozgar and Ajeevika Mission (Gramin) (VB-GRAM G) Act, 2025, with the intention of creating emotional sentiment by invoking the name of Ram.

Data centres in Karnataka: Sify Tech set to launch, Bharti keen to set up, says M.B. Patil

Indian ICT firm Sify Technologies confirmed it will open a new Bengaluru facility within weeks, while Bharti Enterprises signalled plans for its first hyper-scale centre in the state after cumulative investments of 13,000 crore. Talks centred on land, water and power availability, with Tier-2 cities also under consideration to spread growth

beyond the capital. The state delegation, led by Deputy CM D.K. Shivakumar, additionally wooed French AI start-up Mistral for a phased R&D campus, persuaded Imperial College London to scale up its Bengaluru innovation hub and locked in Carlsberg’s 350-crore bottling expansion. Global majors PayPal, Philip Morris, Bharat Forge and Belrise also pledged deeper collaboration, taking Karnataka’s Davos haul to several thousand crores in prospective digital and manufacturing investments.

7 TN fishermen arrested by Lankan Navy, Stalin writes to EAM seeking their release

Chennai, Jan 21 (TSIT) Seven fishermen from Tamil Nadu were on Wednesday arrested by the Sri Lankan Navy along with their two boats for allegedly fishing in their territorial waters, even as Chief Minister M K Stalin wrote to External Affairs Minister Dr S Jaishankar urging him to prevent further apprehensions and secure their release along with their fishing boats by utilising appropriate diplomatic channels.

The fishermen, hailing from Mayiladuthurai district, had ventured into the sea last night and were fishing in the Palk Strait region, when they were arrested by the Lankan Navy personnel for fishing in their waters after crossing the International Maritime



Boundary Line (IMBL). The Lankan Navy personnel later took the seven fishermen into their custody along with their two fishing boats to the Kankesanthurai Port in the Island Nation for further action. The incident comes close on the heels of three fishermen each arrested by the Lankan Navy

on December 28 and 30, 2025, 11 from Karaikal on January two, nine from Nagapattinam district on January 3 and 10 fishermen

from Rameswaram on January 14. The latest arrest of fishermen today while fishing in the Palk Strait, took place despite Mr Stalin time and again writing to the union government seeking urgent steps through diplomatic channels to secure the release of apprehended fishermen, besides convening the Joint Working Group of fishermen between the two countries to find a lasting solution to this vexatious issue, as the continuing frequent

arrests has caused much heartburn among the fishing community in the state. This was also reiterated in the Governor's address in the State Assembly on the opening day of the first session of New Year.

Various fishermen associations condemned the oft-repeated instances of arrests of fishermen and urged the central and the state governments to find a permanent solution to sustain their livelihood and restore their traditional fishing rights in the Palk Strait region. Mr Stalin also urged the Centre to retrieve Katchtheevu, an islet, ceded to Sri Lanka through a pact in 1974 and said this alone will provide a lasting solution to restore the traditional fishing rights of the fishermen.

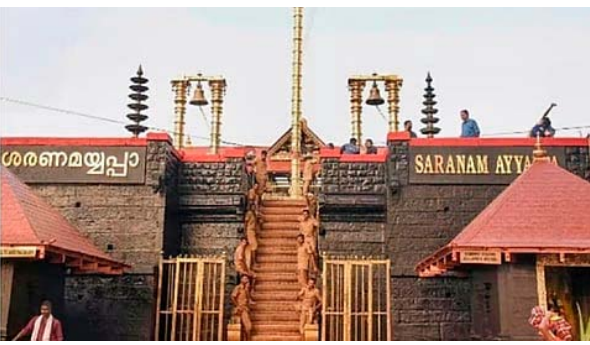
Justice S Srinath said the comments of Udhayanidhi were tantamount to hate speech and held that questioning it was a reaction.

ED freezes Rs 1.3 crore in assets, seizes gold bar in Sabarimala temple money laundering probe

Blue Monday isn't real, but sadness is – and it plays a vital role in children's development

January can feel exhausting. With the magic of Christmas and New Year fading fast, returning to routine brings with it an undeniable emotional slump. But is it really the saddest month?

The idea of "Blue Monday" caught on in 2005, when British psychologist Cliff Arnall announced that he had identified the saddest day of the year using a mathematical formula that factored in climate, post-holiday debt, and dwindling motivation in keeping up with New Year's resolutions. The scientific community quickly (and correctly) dismissed the idea as pseudoscience – far from a psychological finding, Arnall's formula was revealed to be a marketing ploy designed for a travel agency. The agency's proposed cure for the winter blues was, naturally, to purchase a holiday.

You can't schedule sadness term Blue Monday continues to appear each January in the media and in ad campaigns, despite a total lack of evidence that one specific day on the calendar is linked to an overall peak in unhappiness.

Sadness is a complex human response, not a programmed event. While winter weather can certainly affect your mood, there are commercial interests surrounding the concept of sadness, which seek to influence behaviour by encouraging people to consume objects or experiences.

Indeed, some brands have made sadness into a profitable resource, presenting products or experiences as solutions to the same unhappiness they perpetuate. They use the idea of the "saddest day of the year" to influence consumption patterns, leveraging the "misery is not miserly" effect which links low emotional states to increased spending.

This kind of marketing can also influence the emotional dynamics of many households. It creates expectations that are difficult to fulfil, encourages materialism, and creates tensions between adults and children. This all feeds into broader feel-



ings of unhappiness.

But there is further risk when these messages reach children directly. When young people are told that "negative" emotions can be combatted through shopping or digital, artificial distractions, it weakens their ability to recognise, understand and manage what they feel. This makes it vital that we factor media discourse into children's emotional education.

Sadness and the developing mind

from an obstacle to be overcome, sadness plays a fundamental role in children's development. At a very early age, they learn that expressing sadness can gain them the support of parents and carers, and that in most cases, it is much more effective than other emotions in getting attention and solace. Furthermore, sadness helps to readjust goals after a failure, allowing children to modify their approaches and expectations in the face of adverse situations. It also drives introspection processes that allow children to reflect on what they feel, their values, and how they relate to others.

Experiencing sadness therefore contributes to moral growth.

Emotions linked to loss, disappointment and injustice help children to build their sense of right and wrong, develop sensitivity to the suffering of others, and strengthen their empathy. In fact, recent studies have found that experiencing sadness is linked to an increased ability to put oneself in another's shoes.

Adult responses to sadness

The way adults respond to sadness has a decisive impact on how children learn to manage it. A warm, sensitive and caring family environment benefits emotional development, while tense, cold and critical interactions hinder it. Family dynamics – the emotional models that determine the quality of conversations and availability of support – are what shape the way a child interprets and expresses sadness. School and social environments are also key. Children who feel supported not only experience sadness less intensely, but also develop greater confidence to cope with it.

Guiding children in recognising and managing sadness is a

way to help them develop resilience. When they learn strategies for coping with difficult emotions – talking, asking for help, putting their feelings into words, identifying what they need – they acquire internal resources that enable them to face future challenges. This resilience translates into stronger self-esteem and a more realistic and confident perception of their own abilities.

Cultural values and beliefs also play a part in determining which expressions of sadness are accepted, considered appropriate, or suppressed. This means the expression and regulation of sadness vary significantly between cultural and social environments. Understanding these differences allows us to better support children's emotional processes, and avoid misinterpreting their behaviour. When faced with commercial messages like those surrounding Blue Monday, adults must recognise that this emotion is a natural part of growing up – not just one day of the year – and offer children spaces where they can feel heard, supported and understood.

Demographic crisis: China tries everything to make babies

Declaring childbirth a patriotic act. Nagging newlyweds about family planning. Taxing condoms. To get its citizens to have babies, the Chinese Communist Party has pulled every lever. The efforts have largely failed. For the fourth year in a row, China reported more deaths than births in 2025 as its birth rate plunged to a record low, leaving its population smaller and older.

The government said 7.92 million babies were born last year, down from 9.54 million in 2024. The number of people who died in 2025, 11.31 million, continued to climb. The latest figures were reported alongside economic data showing China's economy grew 5% in 2025.

The number of births for every 1,000 people fell to 5.63, the lowest level on record since the founding of the People's Republic of China, according to official data. Around the world, governments are contending with falling birth rates. But the problem is more acute for China: Fewer babies mean fewer future workers to support a rapidly growing cohort of retirees. A worsening economy has made addressing the challenge even more difficult. "China is facing a severe challenge posed by an extremely low fertility rate," said Wu Fan, a professor of family policy at Nankai University.

China's top leaders have redoubled their efforts to try to boost the national birth rate enough to reverse the decline, something that demographers said is probably impossible now that China has crossed a demographic threshold where its fertility rate is so low that its population is shrinking.

Xi Jinping, China's top leader, has called for a "new type of marriage and childbearing culture," urging officials to influence young people's views on "love and marriage, fertility and family." Local officials have responded with increasingly ham-handed measures to get citizens to have babies, including tracking women's menstrual cycles and issuing guidelines to reduce abortions that are medically unnecessary.

Many of the measures have been met with a collective shrug by young people who do not want to start a family.

On Jan. 1, officials placed a 13% value-added tax on contraceptive drugs and condoms, a move that has been met with a mix of indifference, mockery and derision. While the policy was not explicitly directed at boosting the birth rate, it was immediately interpreted by a skeptical



public as yet another futile attempt to encourage more children. Jonathan Zhu, 28, said the price increase would have little effect on his habits. "I'll still use them," he said, citing financial pressure as his reason for delaying fatherhood until marriage. His girlfriend, Hu Tingyan, 26, agreed, noting that the cost of condoms does not influence her willingness to have children. "I don't feel the time is right yet," she said. Some of the government's other baby-boosting measures, such as offering cash and subsidized housing for couples, have also failed to move the needle.

"The empirical evidence from other countries so far is that monetary incentives have almost no effect in raising fertility," said Wang Feng, a professor of sociology at the University of California, Irvine. For many young people, the high costs of raising a child are especially discouraging amid a slowing economy and a property crisis. Youth unemployment remains high, and many recent college graduates are struggling to land a steady paycheck, falling back on their parents with little support from a threadbare social welfare system. "With China's economic woes, young people may want to wait and see, and that's not good news for raising fertility," Wang said.

China arrived at this problem much sooner than it anticipated even a decade ago, when officials relaxed the one-child policy to permit couples to have two children. It adjusted its birth policy again to allow three babies in 2021. This has left the government with less time to fix its severely underfunded pension and health care systems.

At the same time, China experienced a sudden and rapid decline in the working-age population, as the number of citizens age 60 and over is projected to reach 400 million by 2035. Young people often express reluctance to contribute to the public pension fund because of the financial burden.

Rupee declines 76 paise to settle at record low of 91.73 against USD



Mumbai: The rupee crashed 76 paise to close at an all-time low of 91.73 (provisional) against the American currency on Wednesday, January 21, pressured by persistent foreign fund outflow amid heightened uncertainty and risk-off sentiment in global markets. The rupee recorded its previous all-time low of 91.14 on December 16, 2025, and so far this month, the local unit has fallen by 1.50 per cent, forex traders said, adding that the depreciation can be attributed to heightened geopolitical uncertainty. Rising tensions in Europe over the Greenland issue and potential tariffs, along with a negative trend in the domestic market, further dented investor sentiment, they said. At the interbank

foreign exchange, the rupee opened at 91.05 and lost ground to touch an intraday low of 91.74 against the greenback. The domestic unit settled for the day at an all-time low of 91.73 (provisional), registering a decline of 76 paise from its previous close. On Tuesday, the rupee depreciated 7 paise to close at 90.97 against the US dollar. "Emerging economies like India are facing pressure from volatile capital flows," Abhishek Bisen, Head-Fixed Income, Kotak Mahindra AMC, said. Besides, geopolitical tensions, including the Greenland dispute that has strained US-Europe relations (which is a risk of NATO breakdown) and also the control of Venezuela's oil reserves by the US, are creating ripple effects across the

global trade, he said. Bisen further noted that for India, the pending trade agreement with the US remains a key stabilising factor, as its conclusion could boost confidence and bilateral commerce. "Also, until the geopolitical risk eases and the trade deal materialises, the rupee is likely to remain vulnerable to external shocks. However, given the strong forex reserves, the Reserve Bank of India can manage the situation as the depreciation has made INR relatively cheaper on REER basis, which shall help shore up exports," he said. Meanwhile, the dollar index, which measures the greenback's strength against a basket of six currencies, was trading 0.02 per cent lower at 98.61.

Zomato's Deepinder Goyal to step down, Blinkit's Albinder Dhindsa takes over

Mumbai: Zomato's parent firm Eternal Limited on Wednesday, January 21, announced a major leadership change, with its CEO Deepinder Goyal resigning from his position with effect from February 1, 2026. The company said Albinder Dhindsa, who is currently the CEO of Blinkit, will take over as the new chief executive. In a letter addressed to the shareholders, Goyal said he has recently been drawn towards new ideas that involve higher levels of risk, experimentation and exploration. He explained that such ideas are better pursued outside a public company like Eternal, which needs to stay focused and disciplined in its current business strategy. "Of late, I have found myself drawn to a set of new ideas that involve significantly higher-risk exploration and experimentation," he said. "These are the kinds of ideas that are better pursued outside a public company like Eternal," Goyal added. He added that if these ideas belonged inside Eternal's strategic scope, I



would have pursued them within the company. Last week, Aam Aadmi Party (AAP) Rajya Sabha MP Raghav Chadha joined gig workers in celebrating a victory for their "safety, dignity and work conditions" as the government directed food delivery and quick-commerce platforms to do away with rigid "10-minute delivery" commitments. In a video message, Chadha said that it is a memorable day for gig workers as the Central government has struck down the private companies' "10-minute delivery" brand-

ing. "I want to thank the Central government for intervening in the matter," said Chadha, describing the cruelty linked to "10-minute delivery" as real. He said the promise of "10-minute delivery" adds to the mental stress of delivery workers and forces them to drive dangerously to meet the deadline, endangering other road users. Earlier, Labour Minister Mansukh Mandaviya asked major food delivery and quick-commerce platforms to do away with rigid '10-minute' delivery time commitments,

stressing that the safety of delivery partners must come before speed. Mandaviya held discussions with officials of Blinkit, Zepto, Swiggy and Zomato in Delhi, during which he advised them to remove strict delivery deadlines from their platforms and promotional material in the interest of delivery workers' safety. Last week, AAP MP Raghav Chadha joined gig workers in celebrating the government's move to end rigid 10-minute delivery commitments, calling it a win for their safety and dignity.

The year was marked by a robust performance in the super SUV segment, which recorded a total of 17 per cent year-on-year growth, reaffirming the increasing demand for Lamborghini's SUV portfolio in India, it added. This growth reflects the strong customer response to the brand's hybridisation journey and its ability to align performance with evolving consumer preferences, fur-

ther strengthening Lamborghini's position in the Indian market, with close to 800 Lamborghini cars now on Indian roads, the company stated. automaker sold 10,747 units globally in 2025; a 0.56 percent growth over 2024. The 800hp Urus SE likely provided the necessary lift to Lamborghini's overall sales volumes. Lamborghini's India sales dropped by 2 units in 2025 The Urus SE was likely the key driver of sales in 2025 Lamborghini surpassed the 100-unit sales mark in 2023 Lamborghini India sales over the years Lamborghini sold 103 units in 2023, which was nearly a 12 percent improvement over its 2022 numbers. In fact, this was the very first time the Italian marque managed to sell over 100 cars in our country. That figure rose by 10 percent in 2024, with 113 units sold. While Lamborghini's sales did drop this year, the company claims to have sold 17 percent more units of the Urus. Given the soaring popularity of SUVs in our country (and abroad), the Urus has always managed to make bank for Lamborghini.

Trump wants 'immediate negotiations' to acquire Greenland but insists he 'won't use force'

Trump has just finished speaking – after an astonishing scrum to try to get into the room here at Davos. People were turned away. Even heads of state. And the security has been unbelievable, with people – even some famous ones – not being let in or out of the hall. Some of those queuing thought Trump would be a laying down the law of the new rules of the world economy. Trump initially talked in friendly terms about the western allies that had been most perturbed by what they'd seen on his social media posts. He even acknowledged that he probably shouldn't speak about the controversial issue of Greenland. Then, he announced he was seeking immediate negotiations for the USA to acquire Greenland. A negotiated settlement he said. No force required. But the US needed "full title". "We want this land" to build the "greatest Golden Dome ever built" he

said. During his address, Trump said "Biden gave \$350bn to Ukraine" when speaking about support for their war against Russia. He's made similar claims previously - but BBC Verify has found no evidence for this figure. The Kiel Institute, a German-based think tank which tracks defence spending, has put the total amount of support the US government has given, external to Ukraine at \$119bn (£88.5bn) from January 2022 up until October 2025. Former president Joe Biden was in office from January 2021 until January 2024. The US Department of Defense has also done a calculation which looks at a broader range of US military activity in Europe and includes replenishing defence stocks. Its figure was \$182.8bn (£136bn) when Trump came into office - considerably less than the figure the president has mentioned. Trump's description of how



the US economy is doing will sound familiar to anyone who has been listening to the US president over the past year. But does it match reality? Trump's claims often contain some truth – while being significantly exaggerated. Take growth, which he said has been "extraordinarily high". Growth in the US has been stronger than many analysts expected, coming in at an annual pace of 4.3% over

the three quarters to September. But that's not unprecedented – the US had stronger growth during the same period in 2023. And the figures have been jumpy due in part to sharp swings in trade. He says "inflation is defeated" – and again, not quite. Overall, consumer prices jumped 2.7% over the 12 months to December. That's down from 3% a year ago, when Trump took office, but still above the

Fed's 2% target. He's also boasting about investment. Some companies have increased production plans in the US, but there are plenty of reasons to be sceptical about the claims. More now from Trump on tariffs, as he says he imposed them on different countries with large economic deficits. "You're all party to them, in some cases victim to them but in the end it's a fair thing and most of you realise that," he says. In some cases, such as in Switzerland, Trump says he initially imposed a 30% tariff before reducing this, because he doesn't want to hurt people. He says that the "US is keeping the whole world afloat" and it should be paying the lowest interest rate of any countries. Trump turns to the cost of prescription drugs in the US coming down. On tariffs, he says he used them to get favoured nations treatment for drug prices. He says he did it to secure access to goods without having to pay

13,14,15 times more than certain other countries. He recounts a conversation he had with French President Emmanuel Macron - and how he threatened to put up tariffs on French goods unless Macron agreed to Trump's demands on drug prices. He says the US is not going to subsidise the whole world. We'll pay whatever the lowest price is around the whole world, he says. He says because of this, drug prices are going to come down everywhere. "Without tariffs I wouldn't have been able to get it done." US markets rebounded after President Trump told the World Economic Forum he would not use force to acquire Greenland, easing market fears. Shortly after the opening bell, the S&P 500 and Dow Jones Industrial Average both rose around 0.3%, and the Nasdaq also made modest gains. Treasury yields fell as prices rose, while the dollar pared losses.

Could US Congress stop Trump from taking over Greenland?



President Donald Trump's push to acquire Greenland has sparked a backlash from Republicans in Congress, as lawmakers voice growing concern about US military interventions overseas. But it remains unclear if enough Republicans are willing to join Democrats to block a takeover of the island territory - and whether Trump would bow to pressure from Congress, or act alone as he's done several times in a second term marked by growing American entanglements abroad. The focus on

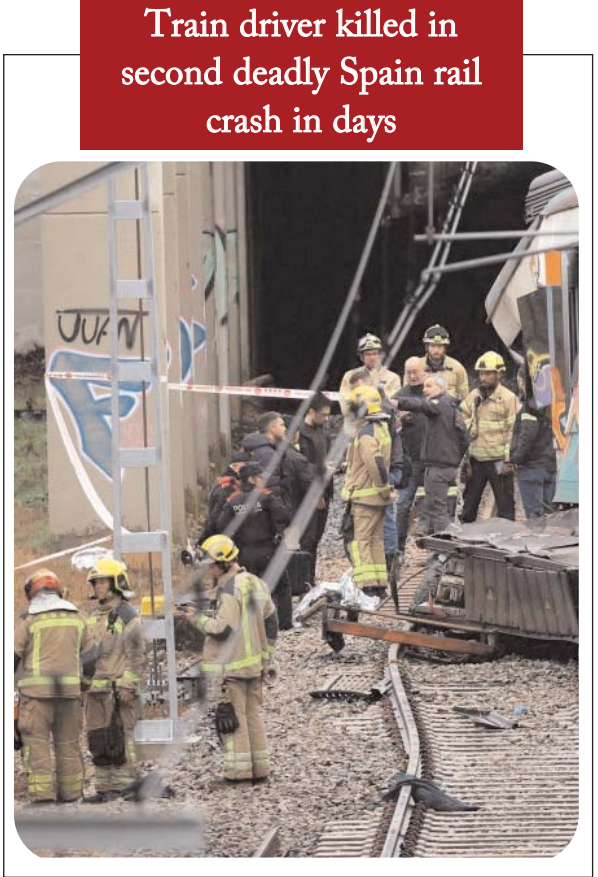
Greenland has grown into a broader discussion over the Trump administration's unilateral use of military force, along with diplomatic and economic coercion, to project power in Venezuela, Iran and elsewhere around the world. Republicans have largely backed Trump's foreign policy agenda since he returned to the White House. But now, a growing number are siding with Democrats in Congress and Nato allies who say a takeover of Greenland would violate US and international law.

LIFE SENTENCE FOR MAN WHO KILLED JAPAN'S EX-PM SHINZO ABE



The man who killed Japan's former prime minister Shinzo Abe has been sentenced to life in prison, three and a half years after he shot him dead at a rally in the city of Nara in 2022. Tetsuya Yamagami had pleaded guilty to murder charges at the trial's opening last year, but how he should be punished has divided public opinion in Japan. While many see the 45-year-old as a cold-blooded murderer, some sympathise with his troubled upbringing. Prosecutors said Yamagami deserved life imprisonment for his "grave act". Abe's assassination stunned the country, where there is virtually no gun crime. Seeking leniency, Yamagami's defence team said he was a victim of "religious abuse". His mother's devotion to the Unification Church bankrupted the family, and Yamagami bore a grudge against Abe after realising the ex-leader's ties to the controversial church, the court heard. On Wednesday, Judge

Shinichi Tanaka from the Nara district court sentenced Yamagami to life in prison without parole, as the prosecution had requested. "The act of waiting for an opportunity, finding an opening, and targeting the victim with a gun is despicable and extremely malicious," said the judge, public broadcaster NHK reports. Yamagami sat quietly with his hands clasped and eyes downcast as the sentence was handed down. Nearly 700 people had lined up in the cold to try to get one of the 31 seats inside the courtroom to attend the hearing. Abe's shocking death in broad daylight prompted investigations into the Unification Church and its questionable practices, including soliciting financially ruinous donations from its followers. The case also exposed links with politicians from Japan's ruling Liberal Democratic Party and resulted in the resignations of several cabinet ministers.



Train driver killed in second deadly Spain rail crash in days

Japan restarts world's largest nuclear plant as Fukushima memories loom large

Japan has restarted operations at the world's largest nuclear power plant for the first time since the 2011 Fukushima disaster forced the country to shut all of its reactors. The decision to restart reactor number 6 at Kashiwazaki-Kariwa north-west of Tokyo was taken despite local residents' safety concerns. It was delayed by a day because of an alarm malfunction and is due to begin operating commercially next month. Japan, which had always heavily relied on energy imports, was an early adopter of nuclear power. But in 2011 all 54 of its reactors had to be shut after a massive earthquake



and tsunami triggered a meltdown at Fukushima, causing one of the worst nuclear disasters in history. This is the latest installment in Japan's nuclear power reboot, which still has a long way to go. The seventh reactor at Kashiwazaki-Kariwa is not

Global markets on alert as Europe to suspend approval of US trade deal

The European Parliament is planning to suspend approval of the US trade deal agreed in July, according to sources close to its international trade committee. The suspension is set to be announced in Strasbourg, France on Wednesday. The move would mark another escalation in tensions between the US and Europe, as Donald Trump ratchets up his efforts to acquire Greenland, threatening new tariffs over the issue on the weekend. The stand-off has rattled financial markets, reviving talk of a trade war and the possibility of retaliation against the US for its trade measures. Shares on both sides of the Atlantic were lower on



Tuesday, with European stock markets seeing a second day of losses. In the US, the Dow Jones slid more than 1.7%, while the S&P 500 dropped more than 2% and the Nasdaq closed about 2.4% lower. Stock markets in the Asia-Pacific region were mixed on Wednesday, with major indexes in Japan and Hong

Kong trading a little lower, while shares in Hong Kong and mainland China were slightly higher. The price of gold continued to make gains as it rose above \$4,800 (£3,570) an ounce for the first time. The price of silver dipped from Monday's record high above \$95 an ounce. Precious metals are seen as safer assets to hold

in times of uncertainty, and the prices of both gold and silver have soared over the past year. On the currency markets, the US dollar held steady against its major peers, having dropped 0.5% overnight - the biggest daily fall since early December. Trade tensions between the US and Europe had eased since the two sides struck a deal at Trump's Turnberry golf course in Scotland in July. That agreement set US levies on most European goods at 15%, down from the 30% Trump had initially threatened as part of his "Liberation Day" wave of tariffs in April. In exchange, Europe had agreed to invest in the US and make changes at on the continent expected to boost US exports.

Nigeria police confirm mass church abductions after previous denial



Nigeria's police have now confirmed that a group of worshippers was kidnapped from three churches in a remote part of the northern Kaduna state, after previously denying it. More than two days after the raid on the Kurmin Wali village, police on Tuesday night said that an earlier statement denying the attack had been "widely misinterpreted". Local residents told the BBC that 177 worshippers had been abducted but that 11 later escaped. Police spokesperson Benjamin Hundeyin did not give any numbers but said subsequent checks by operational units and intelligence sources had confirmed the abduction. He said security forces had been fully deployed to the area, and that search-and-rescue operations and patrols were under way. The police spokesperson added that the earlier statement was "not a denial of the incident but a measured response pending confirmation of details from the field, including the identities and number of those affected". One eyewitness said the attack happened at about 10:00 local time on Sunday. "Some people tried to run, but

they couldn't because the armed men had surrounded the village," he said. "They gathered people together and later forced them to march into the bush." Residents said the attack affected three churches - two which are part of the Cherubim and Seraphim Movement Church, and one from the Evangelical Church Winning All (ECWA). In a joint statement with local government officials on Monday, Kaduna state police commissioner Alhaji Muhammad Rabi described the reports of a kidnapping as "mere falsehood which is being peddled by conflict entrepreneurs who want to cause chaos". He challenged "anyone to list the names of the kidnapped victims and other particulars." The chairman of Kajuru local government area, which includes Kurmin Wali, Dauda Madaki, said security forces had been sent to the area but found no sign of a kidnapping. "We visited the church where the so-called kidnapping took place. There was no evidence of the attack. I asked the village head, Mai Dan Zaria, and he said that there was no such attack."

Israeli PM Netanyahu agrees to join Trump's Board of Peace

Israel's Prime Minister Benjamin Netanyahu has accepted an invitation to join US President Donald Trump's Board of Peace. A statement from his office said Netanyahu would become a member of the board "which is to be comprised of world leaders". The board was originally thought to be aimed at helping end the two-year war between Israel and Hamas in Gaza and oversee reconstruction. But its proposed charter does not mention the Palestinian territory and appears to be designed to supplant functions of the UN. The United Arab Emirates and Bahrain have also agreed to join, as have Albania, Armenia, Azerbaijan, Belarus, Hungary, Kazakhstan, Morocco and Vietnam. Many others have

expressed reservations. It is not clear how many countries have been invited to join Trump's new body - Canada, Russia, Turkey and the UK are among them, but have not yet publicly responded. Norway has said it will not join because the current proposal "raises a number of questions", while France and Sweden have indicated they will do the same. According to a copy of the charter leaked to the media, member states will be given a renewable three-year term, but they can secure a permanent place if they contribute \$1bn (£740m) of funding to the board. The document says the Board of Peace will be "an international organisation that seeks to promote stability, restore dependable and lawful governance, and secure enduring peace



in areas affected or threatened by conflict". It will "undertake such peace-building functions in accordance with international law", it adds. Trump will be the chairman but also "separately serve" as representative of the US. A US official has said the chairmanship can be held by Trump "until he resigns it", but that a future US president may choose a new representative. As chairman, he will

have "exclusive authority to create, modify or dissolve subsidiary entities as necessary or appropriate to fulfil the Board of Peace's mission", according to the document. He will also select "leaders of global stature" to serve two-year terms on an Executive Board that will help deliver the mission of the Board of Peace, US officials say. Last Friday, the White House named the seven members of the

founding Executive Board. They included US Secretary of State Marco Rubio, Middle East special envoy Steve Witkoff, Trump's son-in-law Jared Kushner as well as former British prime minister Tony Blair. Trump also named Nikolay Mladenov, a Bulgarian politician and former UN Middle East envoy, as the Board of Peace's representative on the ground in Gaza during phase two of Trump's peace plan, which should see the reconstruction and demilitarisation of the territory, including the disarmament of Hamas, as well as a full withdrawal of Israeli forces. Mladenov will act as a link with a Palestinian technocratic government which will "oversee the restoration of core public services, the rebuilding of civil institu-

tions, and the stabilisation of daily life". A separate Gaza Executive Board will help support the technocratic government, according to the White House. Witkoff, Kushner, Blair, Rowan, Mladenov will serve on it with Turkish Foreign Minister Hakan Fidan, Egyptian intelligence chief Hassan Rashad, Qatari strategic affairs minister Ali al-Thawadi, UAE minister of state for international co-operation Reem al-Hashimy, billionaire Israeli real estate developer Yakir Gabay, and Sigrid Kaag, a Dutch politician and UN special co-ordinator for the Middle East peace process. On Saturday, Netanyahu's office said the Gaza Executive Board's composition "was not co-ordinated with Israel and runs contrary to its policy".

David Beckham's First Reaction After Son Brooklyn's Explosive 6-Page Note Goes Viral

David Beckham, a legendary footballer, found his name in the top trends on social media after his eldest son, Brooklyn, made some scathing remarks about him and mother, Victoria Beckham, over their attempt to 'control' him and his wife, Nicola Peltz Beckham. Brooklyn shared a 6-page statement on social media, making some serious allegations against his parents while also ruling out the possibility of a reconciliation. While David didn't directly respond to the allegations made by Brooklyn against him and Victoria, he touched upon the topic by suggesting that "children make mistakes". Speaking on CNBC's Squawk Box on Tuesday, David Beckham said that children are bound to make mistakes, and that is the only way for them to learn as well. He has carried the same belief while educating his own children. "I've been



able to use my platform and my following for Unicef and it's been the biggest tool to make people aware of what's going on around the world for children. I've tried to do the same. I've tried to do the same with my children to educate them. They make mistakes.

On T20 World Cup Row, ICC Blasts Bangladesh: "Unrelated Development"

The international Cricket Council (ICC) rejected Bangladesh Cricket Board's request to shift their T20 World Cup 2026 matches from India. The BCB had previously cited 'security concerns' and asked the global cricket governing body to shift their group stage games to Sri Lanka. However, the ICC said that there were no 'credible or verifiable threat to the safety or security of the Bangladesh team in India'. The BCB was also given a 24-hour deadline to take a decision on their participation and if they refuse to travel to India, it is likely that Scotland will replace Bangladesh in the T20 World Cup 2026. "Over the past several weeks, the ICC has engaged with the BCB in sustained and constructive dialogue, with the clear objective of enabling Bangladesh's participation in the tournament. During this period, the ICC has shared detailed inputs, including independent security assessments, comprehensive venue-level



security plans and formal assurances from the host authorities, all of which consistently concluded that there is no credible or verifiable threat to the safety or security of the Bangladesh team in India," an ICC spokesperson's statement in relation to the decision read. "Despite these efforts, the BCB maintained its position, repeatedly linking its participation in the tournament to a single, isolated and unrelated development concerning one of its player's involvement in a domestic league. This link-

age has no bearing on the tournament's security framework or the conditions governing participation in the ICC Men's T20 World Cup." "The ICC's venue and scheduling decisions are guided by objective threat assessments, host guarantees, and the tournament's agreed terms of participation, which apply uniformly to all 20 competing nations. In the absence of any independent security findings that materially compromise the safety of the Bangladesh team, the ICC is unable to relocate fixtures.

"He Might Still Be In Contention": Michael Clarke On Shubman Gill's T20 Axe

One of the most sought-after batters in Indian cricket, Shubman Gill, was surprisingly dropped from the T20 squad as the Board of Control for Cricket in India (BCCI) announced the squad for the World Cup, starting February 07. The Ajit Agarkar-led selection committee picked the likes of Ishan Kishan and Rinku Singh in the team, leaving out Gill, a decision that continues to be debated among fans and experts. However, Gill has now been backed by former Australia captain Michael Clarke to not just return to the team but also take the captain's role. "He might still be (in contention). I don't think that changes too much. I think the squads needed to be



announced by a certain time, and he wasn't batting as well as he would like. India's got so many opening batting options; he's not the captain of the team at this stage, so I think they pretty much made the decision. They wanted these couple of warm-up games to be a real focus on what they are

doing in the World Cup. There were questions about his form. They made that decision specifically in the lead-up to the World Cup," Clarke said in the Beyond23 Cricket Podcast. Gill was named India's T20I vice-captain when he returned to the T20 side last year, replacing Axar Patel. But,

the selection committee took a U-turn and reappointed Axar as the team's vice-captain in the shortest format for the T20 World Cup. As the T20 World Cup ends, however, Clarke feels Gill could end up leading Suryakumar as India's captain in the shortest format. "I think after the World Cup, don't be surprised if he not only comes back into the team, but he also takes over the captaincy. He's an unbelievable player; just not playing his best cricket at the moment. I don't think there are too many concerns moving forward with Shubman Gill. India has made it clear we are 100 per cent focused on this World Cup, and we want to win it," he said.

Abhishek Sharma Shatters World Record With 22-Ball Fifty In 1st T20I Against New Zealand

Indian cricket team batter Abhishek Sharma shattered a sensational world record with a 22-ball half-century during the first T20I encounter against New Zealand in Nagpur on Wednesday. It was a trademark aggressive knock from the left-handed opener as he dominated New Zealand bowlers from the very beginning. Abhishek reached the milestone with the help of 4 fours and 4 sixes. Thanks to his brilliant knock, he became the first batter to score 8 T20I half-centuries in 25 or fewer deliveries. Previously, he was tied with teammate Suryakumar Yadav, Phil Salt and Evis Lewis at 7. This was also the quickest half-century in terms of balls for India against New Zealand in



T20Is. Earlier, the record belonged to KL Rahul and Rohit Sharma who achieved the feat in 23 balls. Earlier, New Zealand won the toss and elected to bowl against India with pacer Kristian Clarke handed a debut cap. Left-handed wicketkeeper-

batter Ishan Kishan returned to the India T20I side for the first time since 2023. With Shubman Gill omitted, Sanju Samson returned as the opener alongside an in-form Abhishek Sharma. The series comes ahead of the

T20 World Cup starting on February 7 in India and Sri Lanka, where the Suryakumar Yadav-led side enter as defending champions. "We were looking to bowl first because we felt there was dew around 8:30pm during our practice. But we don't mind putting runs on the board and we have done well batting first. Shreyas, Harshit, Bishnoi and Kuldeep are the ones who are missing out," said Suryakumar, who's playing his 100th T20I game. Earlier this month, New Zealand defeated India in an ODI series on Indian soil for the first time. "Looks like a pretty good wicket and looks pretty high-scoring. Last week was pretty special. Every team knows how hard it is to come to India and win.

Alcaraz In Splits At Fan's "Carlos Nadal" Quip In Australian Open



Six-time Grand Slam winner Carlos Alcaraz was put through his paces by German journeyman Yannick Hanfmann on Wednesday before swatting him aside to book his place in the Australian Open third round. After overcoming a shaky start in the set, Alcaraz truly made his sporting prowess count, winning the contest in straight sets. The 22-year-old Spaniard came through the arm-wrestle 7-6 (7/4), 6-3, 6-2 on Rod Laver Arena to set up a clash with France's Corentin Moutet or American student Michael Zheng. As Alcaraz chases his maiden Career Grand Slam in Melbourne, comparisons with fellow Spaniard Rafael Nadal are bound to come. In fact, during the match on Wednesday, Alcaraz was called "Carlos Nadal" by a fan in the arena. The quip left the Spaniard in splits. Here's the video: "I knew he was going to play great. I mean, I know his level, I played him a few times already," said the world number one,

who is bidding to become the youngest man to complete a career Grand Slam of all four majors. So far, the Melbourne Park hard courts have proved his nemesis, failing to go past the quarter-finals in his four trips to Australia. He crashed at that stage last year to Novak Djokovic and Alexander Zverev the year before. "To be honest, it was tougher than I thought at the beginning. I didn't feel the ball that good. You know, the ball was coming as a bomb, forehand and backhand," he added. "Really, really happy that I got through a really difficult first set and then I started to feel a little bit better on the court." The turning point came when Hanfmann netted a forehand on serve to give Alcaraz a 5-4 advantage and the Spaniard served to seal a marathon set that spanned 78 minutes. The reigning French Open and US Open champion reset and quickly took a grip on set two as he began to find his rhythm, rattling through it in just 43 minutes.

'Playoffs Start at 0/0': Tristan Stubbs Ahead Of Sunrisers SA20 Clash With Pretoria Capitals

Sunrisers Eastern Cape are in familiar territory. For the fourth straight year, the team is in the SA20 playoffs. Already the most successful side in the league-with two titles and one runner-up finish-the Sunrisers now face a resurgent Pretoria Capitals in Qualifier 1 in Durban on Wednesday. Tristan Stubbs, who took over the captaincy from Aiden Markram ahead of Season 4, does not want to read too much into their run so far. "It doesn't mean much. It's good to know we played well throughout the season, but heading into the playoffs, you start every game 0/0. It's nice to have momentum going into the playoffs, but it doesn't mean much at all," Stubbs said ahead of Qualifier 1. "I don't really



think so," he added when asked whether their track record gives them an advantage. "Having guys who have been in this situation definitely helps. Like I said earlier, it's still a game of cricket. Your experience doesn't really matter if you can't perform on the day. It doesn't count for anything." A big reason behind the

Sunrisers finishing on top of the standings has been Quinton de Kock's form. In eight innings, he has scored 328 runs at an average of 46.85. "De Kock has been awesome for us. Everybody sort of played as a team. It helped us get into the playoffs," Stubbs said. While de Kock is the second-highest scorer in the

SA20 so far, he is closely followed by Pretoria Capitals' Sherane Rutherford in third place with 317 runs at an average of 79.25. "He has been very good for them. They've done well to get into the top two. But in the playoffs, you start on nought for nought. You've got to play well on the day," he said. The winner of Qualifier 1 will progress directly through to the coveted Betway SA20 Season 4 Final on Sunday, January 25 at Newlands. The loser gets another opportunity in Qualifier 2 on Friday, January 23 at the Wanderers against the winner of Thursday's Eliminator between Paarl Royals (third) and Joburg Super Kings (fourth) at Centurion.

RADUCANU'S 'MOST DISPIRITING' SLAM DISPLAY - WHAT WENT WRONG?

When Grand Slam draws are made, we're all guilty of plotting ahead. It turns out we looked one round too far in the case of Emma Raducanu at the Australian Open. A potential shot at top seed Aryna Sabalenka loomed in round three, but the British number one fell to a stinging defeat by Austria's Anastasia Potapova on Wednesday. Former US Open champion Raducanu was seeded 28th in Melbourne, but was completely out of sorts against 55th-ranked Potapova in a 7-6 (7/3) 6-2 second-round loss. "She has had far heavier defeats in Grand Slams before in terms of scoreline, but for me this was the most dispiriting performance of her Grand Slam career," said BBC tennis cor-



respondent Russell Fuller. "She lacked confidence, lacked conviction and lost fight in the final few games." BBC Sport analyses the technical, mental and physical issues facing 23-year-old Raducanu - and whether there is another coaching change in the offing. Raducanu made encouraging

progress last year, climbing back into the world's top 30 and playing more matches than in any previous season. But this defeat means she has still only gone past the third round of a Grand Slam once since her stunning US Open triumph as a teenage qualifier in 2021. Her preparations for the opening major of the

season were disrupted. The off-season technical work she planned to put in with coach Francisco Roig - who helped Rafael Nadal win 16 of his 22 major titles - was compromised by a foot injury. When Raducanu returned in 2026, a tweak to her forehand - a higher and longer takeback, designed to add more spin - was clear. But she seemed to lack trust in the shot against Potapova, landing 70% of her forehand returns in - compared to 96% from her opponent - and making 19 unforced errors off that wing. "I want to be playing a different way. The misalignment with how I'm playing right now and how I want to be playing is something I want to work on," said Raducanu.

PALACE STRIKER MATETA TELLS CLUB HE WANTS TO LEAVE



France striker Jean-Philippe Mateta has told Crystal Palace he wants to leave amid interest from other Premier League and European clubs. Mateta, 28, has 18 months remaining on his current deal at Selhurst Park and as things stand he will not be signing an extension. Italian giants Juventus have tried to sign the striker this month but have so far failed to reach Palace's valuation, which is believed to be around £40m. Aston Villa, who have been keen on Mateta for some time, have also shown interest in a move this month. Speaking last week, Palace manager Oliver Glasner admitted the club are listening to offers for Mateta. "There will be a price that Crystal Palace [accept], with 18 months left on his contract. We'd do the deal, if JP wants. If nobody pays that price, then he will stay," said the Austrian. Palace, who won the FA Cup in May, sold star midfielder Eberechi Eze to Arsenal in the summer and have lost captain Marc Guehi this January, after he joined Manchester City in a £20m

deal. Glasner, who announced last week that he will leave the club at the end of the season, launched a scathing attack on the Palace hierarchy following Saturday's loss to Sunderland - claiming the team had been 'abandoned' by the club's recruitment strategy. Palace were knocked out of the FA Cup at non-league Macclesfield in one of the tournament's greatest shocks earlier this month. Analysis: A blow but not a surprise that Mateta wants out The news will be a blow, but not a surprise to supporters of the club. Mateta, since his remarkable upturn in form over the past 18 months, has always made clear his desire to play at the highest level and has aims of playing in the Champions League and representing France at the World Cup. The 29-year-old's World Cup dream, one that seemed distant before Glasner's arrival at the club, is one that can be achieved now after making his senior debut in October while the frontman has scored in his last two appearances for Les Bleus.

PRABHAS FANS ON HIGH ALERT AS SALAAR 2 TEASER RUMOURS TREND ONLINE

Hyderabad: Over the last few days, fans of Prabhas have been buzzing with excitement after rumours claimed that an announcement teaser for Salaar: Part 2 – Shouryanga Parvam would be released just before Republic Day. Screenshots, fan edits, and bold claims flooded X, Instagram, and Reddit, leaving one big question behind. Is it real, or just another fan driven trend. The speculation reportedly started with unverified posts from Telugu 123. Soon after, multiple fan handles

began repeating the same claim that the Salaar 2 teaser would drop on January 25 or 26. With no official clarification, the rumour spread rapidly and became a trending topic. Despite the excitement, Hombale Films and director Prashanth Neel have remained silent. No poster, no teaser, and no confirmation has been released so far.

FACT CHECK, WHAT IS THE REALITY
Industry sources have now dismissed the teaser rumours as false. According to insiders, there is currently no promotional activity planned for Salaar 2. The project has not gone on floors, and there is no fixed timeline for announcements. Prashanth Neel is busy shooting Dragon with Jr NTR, while Prabhas is occupied with multiple commitments, including Fauji,

Spirit, and the sequel to Kalki 2898 AD. Sources also claim that allocating dates for Salaar 2 in the near future is unlikely. The sudden buzz also comes after Prabhas’ recent film The Raja Saab failed to impress audiences. Shortly after, the release date of Spirit was officially announced as March 5, 2027, which helped divert attention. Many believe the Salaar 2 teaser chatter further helped energize disappointed fans.

WHAT THE SEQUEL WILL EXPLORE
Salaar: Part 1 – Ceasefire released on December 22, 2023, and gained strong popularity on OTT platforms. The sequel title was revealed in the closing credits. The second part will focus on Deva’s transformation into an enemy of Varadha, played by Prithviraj Sukumaran. Rebel Star Prabhas’ Salaar:

Part 1 – Ceasefire has a very special place in Telugu cinema history. The Prashanth Neel directorial showcased Prabhas in a powerful mass role that stood out even in his career. The film has a sequel titled Salaar: Part 2 – Shouryanga Parvam, and it is now back in the headlines. A rumour is widely spreading online that an announcement teaser for Salaar 2 will be released on January 25, 2026. There is nothing from the makers’ end so far, but the buzz is growing among fans and movie lovers. It remains to be seen how much truth this information holds. Prashanth Neel is currently busy shooting Dragon (tentative title) with Jr NTR, and the shoot is taking place at Ramoji Film City, Hyderabad. On the other hand, Prabhas recently appeared in The Raja Saab, which failed to enthrall a majority of audiences.

Hyderabad: Popular stand-up comedian Zakir Khan has announced that he will be taking a long break from live comedy performances. The announcement was made during his recent show in Hyderabad, which is part of his ongoing stand-up special Papa Yaar. Zakir revealed that the break could last until 2028, 2029, or even 2030. He also shared that he had been unwell for over a year but continued performing because he felt it was important at the time. After reaching Dubai, Zakir confirmed that the decision was final through his Instagram stories. He urged fans to attend his remaining shows and wrote, “Every show is a celebration till June 20. I

won’t be able to come to many cities this time, so please make a little extra effort and come to the shows. Thank you for all the love.”

FINAL SHOWS UNTIL JUNE 20
Zakir clarified that although there is no official farewell show, all performances scheduled until June 20 will be his last live appearances before the long hiatus. Fans across social media have been expressing sadness but also support, encouraging him to prioritise his well-being.

For now, his remaining shows are being seen as a celebration of an era before a well-earned pause.
