Sonia Gandhi dis-charged from Ganga Ram hospital



New Delhi (TSIT): Congress leader Sonia Gandhi, who was admitted to Sir Ganga Ram Hospital here nearly a week ago for exacerbation of bronchial asthma due to chest infection, was discharged on Sunday, hospital authorities said. She has responded well to treatment with a good recovery, they said. "The veteran Congress leader was discharged from the hospital today at 5 pm, with advice to continue further treatment at her residence," a senior official of the hospital said. Gandhi was admitted to the hospital on the evening of January 5 under Dr Arup Basu, a chest physician, for "exacerbation of bronchial asthma due to chest infection," the official added.

Indian govt inviting Chinese companies to invest even after Op Sindoor: Owaisi

Jalna (TSIT): The All India Majlis-e-Ittehadul Muslimeen (AIMIM) chief Asaduddin Owaisi, on Sunday, January 11, questioned the ruling BJP's nationalist credentials, accusing the Centre of inviting Chinese companies to invest in India even after Operation Sindoor and failing to respond to what he called US President Donald Trump's repeated insults.



There has been no response from either the government or the BJP on Owaisi's accusations so far. The Hyderabad MP was addressing a rally for AIMIM candidates contesting the January 15 elections to the Jalna Municipal Corporation polls. His party has fielded candidates in 17 of the 65 electoral wards in the civic body. Asaduddin Owaisi alleged that China had supplied arms to Pakistan during Operation Sindoor, which India had launched to respond to the Pahalgalam terror attack. He claimed that nearly 80 per cent of Pakistan's military equipment was sourced from China.

Caracas: Venezuelan lawmaker Nicolas Maduro Guerra has said that his father, President Nicolas Maduro, sent a message through his lawyers saying he is in good condition and remains resolute while being held in the United States.

"The lawyers told us they are strong and that we should not be sad," Guerra said while addressing leaders of the ruling United Socialist Party of Venezuela on Saturday (local time). He quoted his father as saying: "We are well. I am a fighter."

TELANGANA GOVT GEARS UP FOR SLBC TUNNEL RESUMPTION



Hyderabad (TSIT): Nearly a year after a tunnel roof collapse brought work to a halt, the Telangana government has decided to resume construction of the Srisailem Left Bank Canal (SLBC) tunnel, adopting advanced tunneling techniques to overcome geological challenges and meet long-pending deadlines. Irrigation and Civil Supplies Minister N. Uttam Kumar Reddy announced the decision after chairing a high-level review meeting with senior officials of the Irrigation Department at the Secretariat here on Sunday.

The SLBC works had remained stalled since February 22, 2025 following a major cave-in inside the tunnel. Describing the

project as a top government priority, the Minister said the SLBC tunnel is a crucial component of the Alimineti Madhava Reddy Project (AMRP), launched in 1983 to address chronic irrigation and drinking water needs in drought-prone regions of Telangana. Stretching nearly 44 km, the SLBC tunnel is being excavated exclusively from two ends—the Srisailem inlet and the Devarkonda outlet—and, once completed, is expected to become the world's longest tunnel constructed without intermediate shafts, the Minister said. The tunnel is intended to irrigate about three lakh acres and supply drinking water to fluoride-affected villages.

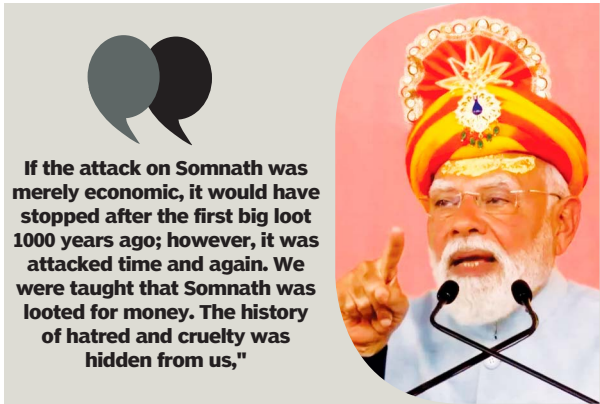
Officials reported that excavation has reached 13.94 km from the inlet side and 20.4 km from the outlet, leaving approximately 9.8 km to be completed, including contingency length. The Minister instructed officials to ensure simultaneous excavation from both ends. The Minister was informed that the project site has been fully readied, including the removal of the Tunnel Boring Machine (TBM) from the outlet side.

Some tried to whitewash religiously motivated attacks for appeasement politics, says PM

Somnath : Prime Minister Narendra Modi launched a strong attack on Sunday against those with a "slave mentality" who opposed the restoration of the Somnath Temple in 1951. He stated that such forces continue to employ "evil means" against India.

He pointed out that there were attempts to "whitewash" the religiously motivated attacks for the sake of "appeasement politics", asserting that the history of hatred and cruelty had been concealed from the public.

Taking aim at the "people with slave mentality", PM Modi told the large gathering in Sadbhavna Maidan here, "India has sites like Somnath, thousands of years old, reflecting India's strength, resilience, and traditions. However, unfortunately, after Independence, people with a slave mentality tried to distance themselves from these. They made every effort to erase



the history of this place."

Remembering the people who made sacrifices for the protection of Somnath Temple, PM Modi, in his impassioned speech, rallied the crowd, stating, "Unfortunately, those who sacrificed everything for the temple weren't given importance, and some politicians and leaders tried to whitewash the religiously motivated attacks, calling them merely a loot for their appeasement politics. However,

Somnath was not attacked just once, but several times."

"If the attack on Somnath was merely economic, it would have stopped after the first big loot 1000 years ago; however, it was attacked time and again. We were taught that Somnath was looted for money. The history of hatred and cruelty was hidden from us," he added.

BJP no alternative to Congress in Telangana, says KTR

Hyderabad (TSIT) : Bharat Rashtira Samithi (BRS) working president K.T. Rama Rao on Sunday asserted that the Bharatiya Janata Party (BJP) will never emerge as a viable alternative to the Congress party in Telangana.

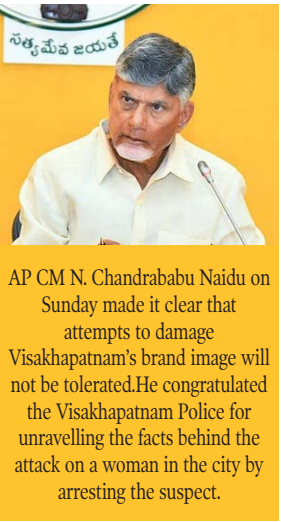
Will not tolerate attempts to damage Vizag's brand image: CM Naidu

Amaravati (TSIT) : Andhra Pradesh Chief Minister N. Chandrababu Naidu on Sunday made it clear that attempts to damage Visakhapatnam's brand image will not be tolerated. He congratulated the Visakhapatnam Police for unravelling the facts behind the attack on a woman in the city by arresting the suspect.

Two days ago, a woman named Vijayadurga posted on social media that she was attacked and abused by a man at Jagadamba Centre in Visakhapatnam.

The police responded immediately and arrested the person responsible for the incident. However, the preliminary investigation revealed that his mental condition was not good.

Officials said the victim expressed satisfaction over the police responding immediately after receiving the information about the incident and arresting the person involved. Though the identity of the accused was not known, the police conducted the investigation and identified and arrested the accused. The woman herself came to the police station



and confirmed that the man was not mentally sound. She requested that he be admitted to a mental hospital. The victim also requested that legal action not be taken against the accused.

Chief Minister Chandrababu Naidu praised the performance of the police, saying that this is proof that law and order is excellent in Visakhapatnam. He said that the Andhra Pradesh Police Department is committed to the safety of the people. Stating that Visakhapatnam ranks first in the country in

terms of protection of women, the Chief Minister advised the high-ranking police officers to be vigilant to prevent any incidents from happening in the future. He also ordered action against those who are trying to politicise such incidents and smear the government. Chief Minister Naidu made it clear that he would not tolerate any damage to the brand image of Visakhapatnam.

The government issued a statement hours after the YSR Congress Party posted a video of the victim, saying she expressed anguish over women's safety in the state. "As fellow Indian citizens, let us stand in support of the woman, and we are demanding immediate strict action against such individuals," reads a post.

The woman narrated that though she was slapped by an unknown person at a crowded place, no one came forward. The victim also stated that she reacts strongly whenever something bad happens to women, but she did not anticipate that this would happen to her one day. She turned emotional while narrating the incident.

India beat New Zealand by four wickets in first ODI

Virat Kohli's fluent 93, supported by fifties from Shubman Gill and Shreyas Iyer, powers India to a four-wicket win over New Zealand in the first ODI, chasing down 301 to take a 1-0 series lead.

VADODARA (TSIT): Virat Kohli struck a 91-ball 93 while captain Shubman Gill made 56 as India beat New Zealand by four wickets in the first ODI to go 1-0 up in the three-match series here on Sunday.

Kohli smashed eight fours and one six during his magnificent innings to help India overhaul the target of 301 with six balls to spare.

Shreyas Iyer chipped in with 49 as India reached 306 for 6 in 49 overs. For New



Zealand, Kyle Jamieson returned with fine figures of 4 for 41 from his 10 overs, while Adithya Ashok and Kristian

Clarke got one wicket each.

Earlier, Indian bowlers, especially pacers Harshit Rana

and Mohammed Siraj, bowled probing line and length but Daryl Mitchell struck a fine counter-attack

ing half-century to guide New Zealand to 300 for 8.

Harshit (2/65), Siraj (2/40) and Prasidh Krishna (2/60) got two wickets apiece while Kuldeep Yadav got one.

Rahul Gandhi to attend TN school event in Nilgiris on Jan 13

Chennai, Jan 11 : Senior Congress leader Rahul Gandhi is scheduled to visit Gudalur in the Nilgiris district on January 13 to attend the golden jubilee celebrations of St Thomas English High School. Party sources said the visit is purely ceremonial, with no political programmes or public meetings planned during his brief stay in the hill town.

According to Congress functionaries, Rahul Gandhi will arrive by helicopter from Mysuru at around 3.30 p.m. After attending the event at the helipad, no additional engagements have been scheduled.

“As far as we know, the leader has no political events or meetings during this visit,” a senior Congress functionary said.

This marks Rahul Gandhi's second visit to Gudalur in recent years. He last visited the region in September 2022 during the Bharat Jodo Yatra, when he addressed supporters and spoke about the scenic beauty of the Western Ghats. During



that visit, he stayed overnight at a private school before continuing his journey towards Karnataka as part of the nationwide march. The golden jubilee celebrations of St Thomas English High School are also likely to be attended by Rev Dr Mathews Mar Makarios Episcopa, Metropolitan of the Malankara Mar Thoma Syrian Church, lending prominence to the event.

Rahul Gandhi's visit comes at a time when the DMK-Congress alliance in Tamil Nadu is facing political undercurrents. In recent weeks, some

Congress functionaries and elected representatives have publicly sought a greater share in power, triggering discussions within the ruling alliance.

The Congress has also intensified its criticism of the BJP over the recent by Rev Dr Mathews Mar Makarios Episcopa, Metropolitan of the Malankara Mar Thoma Syrian Church, lending prominence to the event.

Women-led development at the heart of PM Modi govt's policies: Hardeep Puri

New Delhi, Jan 11 : Union Minister Hardeep Singh Puri on Sunday said that government schemes under Prime Minister Narendra Modi have transformed India's development journey by shifting the focus from women-centred welfare to women-led growth, ensuring dignity, security and greater participation of women in nation-building.

Puri was speaking after an interaction with professionals, industry leaders, academicians, entrepreneurs and students at the 'Professionals Connect 2026' conclave organised

by the Tamil Nadu BJP Professional Cell in Coimbatore. He described Coimbatore as a city that reflects enterprise, discipline and quiet confidence.

"India's quest towards achieving energy security by strengthening and expanding the energy infrastructure across the entire hydrocarbons value chain, and the focus on green energy transition also play a key role in this journey of Viksit Bharat under PM Modi's leadership," Puri wrote on X.

"I have had the privilege of being associated with several of PM Modi's

visionary schemes that changed lives for the better and evoked interest around the world. These schemes have shifted the narrative from women-centred development to women-led development," he added.

During the discussion, Puri highlighted the positive impact of the Modi government's reforms and policies, saying they have strengthened the India growth story and placed the country on track to become the world's third-largest economy.

He added that the benefits of these reforms have

reached all sections of society, leading to unprecedented levels of social and financial inclusion.

The minister also spoke about India's push towards energy security, with a strong focus on expanding energy infrastructure across the hydrocarbons value chain while accelerating the green energy transition.

He said India has already achieved 20 per cent biofuel blending and is making steady progress in future fuels such as green hydrogen as part of the vision of a developed India.

'Reflects Himanta Biswa Sarma's Pakistani thinking', Owaisi hits out at 'Hindu PM' remark

Nagpur, Jan 11 : AIMIM chief Asaduddin Owaisi on Sunday slammed Assam Chief Minister Himanta Biswa Sarma over his assertion on the religious identity of India's leadership, stating that it reflects his "Pakistani thinking".

This came as CM Sarma, on Saturday, said that while the Constitution does not restrict anyone from becoming the Prime Minister, the country's civilisational ethos would ensure that the post remains with a Hindu.

Speaking to IANS, Owaisi said, "His mind is like a tubelight. He



took an oath on the Constitution. Where in the Constitution is this written? Himanta Biswa Sarma's thinking reflects that of Pakistan's, where the Constitution allows only a person from a particular community to become Prime Minister or President. In contrast, the Constitution of India, framed by Dr B.R. Ambedkar, is far more inclusive and thoughtful."

"It is unfortunate that some people neither understand the Constitution nor its spirit. India does not belong to any single community; its beauty lies in the fact

that even those who do not follow any religion have a place here. Such narrow-minded thinking reflects a petty mindset," Owaisi added. Addressing the media, Chief Minister Sarma had said there is "no constitutional bar" on who can occupy the highest executive office in the country.

"Anybody can become the Prime Minister of India," he said, but added that India is essentially a Hindu civilisation and expressed confidence that the Prime Minister would always emerge from that civilisational framework.

CII urges Centre to fast-track privatisation of PSUs

New Delhi, Jan 11 : Apex business chamber CII, in its proposals for the Union Budget 2026-27, has urged the Central government to mobilise resources through a calibrated approach to privatisation to unlock the value of public sector enterprises. Chandrajit Banerjee, Director General, CII, said, "India's growth story is increasingly being powered by private enterprise and innovation. A forward-looking privatisation policy, aligned with the vision of Viksit Bharat, will enable the government to focus on its core functions while empowering the private sector to accelerate industrial transformation and job creation." Against this backdrop, CII has called for accelerating the implementation of the Government's Strategic Disinvestment Policy, which envisions an exit from all Public Sector

Enterprises (PSEs) in non-strategic sectors and a minimal presence in strategic ones. To strengthen and expedite the privatisation programme, CII has outlined a four-pronged comprehensive strategy. First, CII recommends a shift to a demand-based approach in selecting PSEs for privatisation. Presently, the government identifies specific enterprises for sale and subsequently invites investor interest. However, when sufficient demand or valuation is not achieved, the process often stalls. CII suggests reversing this sequence by first gauging investor interest across a broader set of enterprises and then prioritising those that attract stronger interest and meet valuation expectations. Such an approach, CII believes, would ensure smoother execution and better price discovery.

Haryana's Sports Policy: Why Under Criticism?

Two teenage basketball players—Hardik and Aman, died in separate accidents in Haryana after court poles collapsed on them during practice sessions in November 2025. Both the players belonged to Rohtak, Haryana. The painful death of these two promising Haryana Basketball players, not only exposed the ruined infrastructure of playgrounds, but also showed the negligence of the sports officials and the sports department.

These shameful incidents and the negligent and unheeding sports policy of the present BJP-led government has not only fetched criticism from the public but also from politicians. Criticising BJP's sports policy, former Haryana Chief Minister, Bhupinder Singh Hooda, stated that during the Congress tenure, 481 sports stadiums were built in Haryana, and two SAI centres were established. However, the BJP government has not even provided a budget for the maintenance of these stadiums. The BJP government has grossly neglected the interests of sports and athletes in Haryana. The BJP government also scrapped the 'Win a Medal, Get a Job' policy, which the Congress government had implemented

to secure the future of athletes.

The Congress government had formulated the SPAT policy to promote sports and athletes from the first grade onwards at the school level, which the BJP government ultimately abolished. Under the SPAT policy, daughters from the Scheduled Caste community received an incentive of 40,000 upon reaching the district/state level, which the BJP government also discontinued.

Hooda claimed that the Congress government provided employment to 750 athletes in various positions. The BJP government has not provided any appointments to date and has deprived athletes of promotions. They have also been denied cash awards since 2021. Furthermore, this government has even abolished competitions held at the rural level.

In a press statement on January 8, 2026, the former Chief Minister accused the BJP of discriminating against Haryana in matters of sports. He said that the BJP-led central government is deliberately spending very little on Haryana, a state that has brought glory to the country worldwide. On the other hand, the BJP government in Haryana is sitting idly by instead of fighting for the rights of the people of Haryana.

Hooda cited the example of the National Games held in Uttarakhand. He said that in Haryana, only Rs. 4.5 lakh was spent per medal. In contrast, other states like Maharashtra spent Rs. 43.50 lakh, Madhya Pradesh Rs. 1.13 crore, Delhi Rs. 1.13 crore, Bihar Rs. 1.69 crore, Uttar Pradesh Rs. 7.85



crore, and Gujarat Rs. 11.21 crore. These figures show that the investment made in sports in Haryana always yields results. Despite this, Haryana is being ignored in everything from releasing the sports budget to organizing the Olympics. Even in the 'Khelo India' budget of Rs. 3,500 crore, Haryana received only Rs. 80 crore.

Bhupinder Singh Hooda said that despite having only 2% of India's total population, Haryana contributes approximately 50% of India's international medals. At every platform – the Olympics, Asian Games, and Commonwealth Games – Haryanvi athletes have been raising India's flag high for years. Therefore, Haryana's participation and representation in important events like the Commonwealth Games is extremely natural and justified.

Demanding for organizing

Commonwealth Games in the state, Hooda said, if some events of the Commonwealth Games are held in Haryana, it will not only give young players experience in global competitions but will also provide a strong foundation for the sports ecosystem in the state, along with numerous benefits in the form of advanced stadiums, training centres, and modern sports infrastructure.

Congress MP Deepender Singh has also alleged that the Central Government is undermining Haryana's interests, while the State Government is sitting mute. He said the central government and the state BJP government are completely ignoring and neglecting Haryana's rights. Through a press statement, on January 6, 2026, the congress MP demanded that Haryana be designated as the host or co-host state for the 2030

Commonwealth Games and the 2036 Olympics announced by the Government of India in Gujarat. He said Haryana, a state that brings 50% of the medals to India from the Commonwealth Games, Asian Games, and Olympics, has been ignored. "In the last four Olympics, Haryana athletes won more than half of the country's total medals. In the last Olympics, approximately 25% of the athletes were from Haryana. We are proud that since 2006, Haryana has contributed 50 percent of the medals and 25 percent of the athletes in all the Games, including the Olympics," he said.

"However, when our country was given the opportunity to host the 2030 Commonwealth Games, the BJP government at the centre did not choose Haryana as the host state. Instead, Gujarat was selected. Lakhs of crores of Rupees will

now be invested in Ahmedabad for the 2030 Commonwealth Games, and sports infrastructure will be built. If this same sports infrastructure, stadiums, and development had been spent in Haryana, lakhs of crores of Rupees would have been spent on it," he pointed out. "The government has announced the submission of official bids to host the 2036 Olympics in Gujarat. Now, the entire sports budget will be spent there, but if this investment had been made in Haryana, it's easy to imagine how many more medals our athletes would have won. Making Haryana at least a co-host state for the 2030 Commonwealth Games and 2036 Olympics would have diverted some of the crores of Rupees from the budget to Haryana's sports infrastructure and improved the state's sports infrastructure," he added. Deepender Singh added that Haryana received the lowest budget in India's 'Khelo India'. "Gujarat received 600 crore of the country's 3500 crore 'Khelo India' budget, while Haryana, which won the most medals, received only 80 crore, the lowest among the 28 states. The 481 sports stadiums built during the previous Congress government, including the Rajiv Gandhi Sports Stadium and numerous international-level stadiums, have fallen into disrepair and are proving fatal for our athletes. After 2019, these stadiums have been left without repairs, upgrades, or new ones. Sports equipment remains scarce, not to mention the lack of proper infrastructure," he pointed out. On the other hand,

Haryana's Sports Minister, Gaurav Gautam claimed that the main objective of the state government is to provide excellent and modern facilities to players. With this vision, the Haryana Government has released Rs.114 crore through the Sports Department for the repair and rejuvenation of sports stadiums across the state. Work has already started at several locations. He informed that additional resources will be spent by the District Sports Council (DSC) to further improve the grading of the sports fields, and a detailed plan is being prepared for this.

While chairing a review meeting, on January 2, at Tau Devi Lal Stadium, Panchkula, with officers of the Sports Department, Sports University, Rai (Sonapat), and the Public Works Department (PWD), the Sports Minister, Gaurav Gautam, discussed the issue of finalising the drawings and designs of modern sports infrastructure.

The Sports Minister directed that officers at the Deputy Director level must conduct surprise inspections of stadiums in their respective districts at least twice a month. Any shortcomings noticed during inspections will be addressed in a time-bound manner, and accountability of the concerned officers will also be fixed. He said that regular monitoring of sports infrastructure is essential to bring real improvement at the grassroots level.

It seems that the state government has started to pay attention towards the weakness of the system.

A Conversation About Israel That Felt Uncomfortably Familiar

There is a poem by the great German poet Bertolt Brecht. It goes:

General, your tank is a powerful vehicle
It smashes down forests and crushes a hundred men.
But it has one defect:
It needs a driver. General, your bomber is powerful.
It flies faster than a storm and carries more than an elephant.
But it has one defect:
It needs a mechanic.

General, human beings are very useful.
They can fly and they can kill.
But they have one defect:
They can think.

It is difficult to predict, in this day and age, how long this poem will remain relevant. But upon seeing, hearing and speaking with Aida Touma-Suleiman in Jerusalem, this poem came to mind vividly. Sixty-one-year-old Aida Touma-Suleiman is a member of Israel's parliament, known as the Knesset. She is an Israeli citizen, of Arab-Christian origin, but she declares herself an atheist. She is a member of Israel's Communist Party, and represents the coalition Hadash, a feminist, the editor of the party's Arabic-language newspaper Al-Itihad – the first and only female editor in Israel. She is also the first female member of the “high-level committee for Arab Citizens of Israel”. She fights for the rights of Israeli citizens, but also for that of the Palestinian people. Meeting her reminded me of all those activist comrades in my own country who, despite not being Muslim, Christian, Dalit, LGBTQ++ or Adivasi, fight for human justice and often face criticism within their own communities. She is also famous for having passed a law in the Knesset, raising the legal age of marriage for women in Israel from 17 to 18. The conversation I had with her was about Israel, but my own country, India, repeatedly came to my mind with various similar observations. Officially, Israel is a democracy and so is India. But Hitler too rode the chariot of democracy to reach fascist dictatorship, and we see the same is happening in India and Israel today. The capitalist ruling class uses the guise of democracy to carry out anti-people work and secures legitimacy for those crimes in the name of democracy. Whereas, the Left wants to establish that very democracy in the true sense for the welfare and upliftment of the people. Aida says, “It is true that we have gained a few rights by virtue of being Israeli citizens. We are a group of Israeli Arab citizens, who are indigenous to this land, so we can form our own political party, raise our issues in politics, and contest elections. We also have some scope to raise our voice, however little, against any wrong step taken by the Israeli government. But this was true two years ago.” “Now, replace 'is' with 'was' in these statements – all these things have become matters of the past. It is true that whatever democracy existed in Israel, it was the only so-called democracy in the Middle-Eastern countries, and by that token, we had some rights, but in the last two years, these rights have been completely stripped away. In the last two years, an entirely new kind of situation has been created, and it is taking new shape every single day,” she adds. Aida did not condemn the October 7, 2023, Hamas attack in the Israeli Knesset and instead raised her voice against the atrocities by the Israeli army. In response, she was suspended from parliament for two months and penalised with a two-week salary cut. Aida also accused the Israeli army and rulers of bombing hospitals in Gaza, as a result of which only seven out of 48 surgeons survived. She condemned the Israeli army's attack on displaced and unarmed people and refused to apologise or retract her statement.

India's Biggest Policy Challenge Will be Dealing with the US

The US will be India's biggest foreign policy challenge this year far more than it was in 2025. This, when a strategic option has been available to India for the US to woo it instead of the present pathetic state where president Trump openly ridicules prime minister Modi. He has done this regularly since India denied Trump the credit of the ceasefire in Operation Sindoor. The strategic option is for India to turn the table on the US by normalising its ties with China. This will strengthen the Russia-India-China (RIC) format that grew into Brazil, Russia, India, China, South Africa (BRICS) which Trump fears since it has the potential to displace (not replace) the US dollar as the world's reserve currency. To recall, the now famous picture frame of the smiling trio: Putin (President Putin), Xi (President Xi Jinping), and Modi, taken at the SCO summit in Tianjin (China) on September 1, 2025 had sent shock waves across Washington DC with many US Senators blaming the Trump administration for having lost India to China, described as the US's peer competitor in this century. But, for India to do this requires more than courage and wisdom, which itself is a challenge. It requires intellectual honesty to accept that in the present multipolar world, China is a great power whose geo-economics and technology rise manifested in Belt and Road Initiative (BRI) is both unstoppable and uncatchable. Given this, instead of competing with China in South Asia where except for Bhutan all nations have joined the BRI, India would be better served by working with China for mutually beneficial outcomes. This, of course, will not happen as India, with a colonial mindset, would prefer to be photographed with the US leadership, never mind the cost for doing this. And the cost has been huge. Conscious that US could not sustain global military dominance, Trump, describing himself as the 'President for Peace', decided in his first year to minimise the security competition



with China in west Pacific and downgrade the QUAD (Quadrilateral security dialogue between US, Japan, Australia and India for free and open Indo-Pacific region). This robbed India of the strategic role of being the US's military bulwark against China in the Indian Ocean Region (IOR). Interestingly, this role was formally given to India by the first Trump administration in May 2018 when it re-named the US' Pacific Command (responsible for Asia Pacific region) as the US' Indo-Pacific Command to give centrality to India. Now, Trump, the maverick president, talks too much, and thus shares his thoughts to whoever is willing to listen. Given that, since his inauguration on January 20, 2025, Trump started talking about getting Greenland, making Canada the 51st American state and so on, prudence should have guided the Modi government to wait and watch to understand his foreign policy priorities. But, in the rush to be amongst the earliest to please Trump, Modi, on his first visit to the White House, signed the February 13, 2025 joint statement which gave US far more than it expected. India commit-

ted to raise the present bilateral trade at USD 132 billion (2024-25) to USD 500 billion by 2030. With this, India agreed to buy energy (including nuclear), military equipment, green and big (Artificial Intelligence infrastructure) technologies, space cooperation and so on. Moreover, India renewed the 10-year defence framework till 2035 with US aeon 31 October 2025 for joint production and interoperability with the US military. All this was done to demonstrate India's total commitment to Trump's foreign policy called Make America Great Again (MAGA). This is no more than an illusion that the US could once again become the superpower. With no card left to play, the Modi government's problems with the US started with Operation Sindoor. Trump was livid at being denied his peace-making role in Operation Sindoor by India. Interestingly, there is enough evidence in support of Trump's claim. For example, he put on his social media account on May 10, 2025 that India and Pakistan had agreed to 'full and immediate ceasefire'. This was confirmed by India the same evening. Then, The Hindu

newspaper reported on January 7, 2026 that the Indian embassy had hired a US lobby firm to fix meetings with top US officials on May 10 to discuss 'media coverage' on Operation Sindoor. Instead of assuaging Trump, India's actions incited him to publicly say over 60 times that he ended the India-Pakistan war. Trump's tirade, especially on Modi, has continued unabated. He recently said that India has decreased purchase of oil from Russia since Modi knows it is important to keep him happy. On the one hand, Trump's outbursts demeaning Modi should be unacceptable to India. On the other hand, it will be difficult for Modi to meet Trump in person as he can insult him on his face. Given the political angst, it will be difficult to continue business as usual between the two nations. To add to India's anxiety, Trump, after Operation Sindoor, has given a strategic role to Pakistan in the Middle East to share its assessments on Iran, which the US regards as its main enemy. Despite the choices the multipolar world offers to India, the Modi government remains a prisoner of its archaic foreign policy, condemned to bear Trump's hubris.

The Pawars Are Talking Again, And So Are Thackerays

Maharashtra's political landscape is witnessing unprecedented realignments as the state prepares for municipal corporation elections across 29 bodies, a poll that comes four years behind schedule. The most significant of these changes involves the coming together of estranged Thackeray cousins and tentative steps toward reconciliation between the rival Pawar factions. The Thackeray Reunion In a development that few saw coming, Uddhav Thackeray's Shiv Sena (Uddhav Balasaheb Thackeray) has broken away from the Maha Vikas Aghadi (MVA) alliance to join hands with cousin Raj Thackeray's Maharashtra Navnirman Sena for the elections to the Brihanmumbai Municipal Corporation (BMC). This partnership represents more than mere electoral convenience; it is a strategic attempt by both cousins to reclaim the legacy of the legendary Balasaheb Thackeray, whose towering personality once dominated Maharashtra politics. The alliance is built on carefully calculated electoral arithmetic. Together, the Thackerays are wooing the Marathi Manoos, who constitute approximately 40% of Mumbai's population, while also banking on support from the Muslim community, which makes up about 20%. The reasoning behind this strategy is straightforward: the united Thackeray front believes it is better positioned to defeat the Bharatiya Janata Party than the Congress, hence leaving no option for the Muslim community but to back



them. The seat-sharing arrangement reflects the relative strengths of the partners. Shiv Sena (UBT) will contest 165 seats, MNS will field candidates in 52 constituencies, while the Nationalist Congress Party (Sharadchandra Pawar faction) will contest just 10 seats as part of this new coalition. At a joint press conference announcing the tie-up, the Thackeray brothers invoked a potent warning to the Marathi Manoos: "batenge to katenge" - divided we fall, united we stand, taking cue from the BJP's slogan in the 2024 state elections. High Stakes For Uddhav's Shiv Sena For Uddhav Thackeray, these municipal elections represent nothing short of an existential battle. Shiv Sena held sway over the Brihanmumbai Municipal Corporation for nearly three decades, making it not just a political bastion but a symbol of the party's power and reach. The 2022 split that saw Eknath Shinde walk away with a majority of MLAs has left Uddhav's faction at seri-

ous risk of losing this crucial stronghold. The battle between the two Shiv Sena factions has produced mixed results so far. In what can be termed Round One, the Lok Sabha elections, Uddhav's faction emerged victorious. However, Round Two - the Vidhan Sabha polls - went to Eknath Shinde's faction. These municipal corporation elections, particularly in Mumbai, represent the decisive Round Three that could determine which faction truly inherits Balasaheb's mantle. Uddhav has reasons for optimism. Of the 20 seats his party won in the 2024 Vidhan Sabha polls, half came from the Mumbai region corresponding to the BMC. While the party's overall vote share across Maharashtra stood at just 10%, in the Mumbai region it was an impressive 24%. This concentrated support base could prove crucial in municipal elections where local factors often outweigh state-level considerations. The MNS, despite its smaller footprint, also has a sig-

nificant presence in Mumbai. While it recorded less than 2% vote share statewide in the 2024 state elections, it managed 7% in the Mumbai zone, suggesting that Raj Thackeray's appeal, though diminished, remains relevant in the city where his party was born. In direct contests between the two Shiv Sena factions, the scoreline has been close. Of 11 such fights, Uddhav's party won six while Shinde's faction won five, indicating that the battle for Balasaheb's legacy remains evenly poised. An Ascendia Strategies survey adds another dimension to this contest, revealing that 45% of 'Marathi Manoos' in Mumbai believe Shiv Sena (UBT) is the real Sena - a significant psychological advantage in a battle fought as much over legitimacy as over votes. Formidable Challenges Ahead Despite these encouraging signs, the Thackeray brothers face severe challenges that could undermine their alliance.

Bengaluru: Deputy Chief Minister D.K. Shivakumar on Tuesday expressed confidence that the Congress party would take an appropriate decision on his political future, stating that he continues to have faith in the party despite facing criticism and allegations from various quarters.

Speaking at the Udyami Vokkaliga Expo 2026,

Shivakumar said he had risen in politics without coming from a political family and had reached his present position through perseverance and hard work. Recalling his long political journey, he said he had endured many setbacks and challenges, yet remained committed to his principles.

Referring to his interactions with former Chief

Minister B.S. Yediyurappa, Shivakumar spoke about the values required for success, drawing examples from the Mahabharata. He also recalled the difficult phase when he was jailed and thanked people for standing by him with prayers and goodwill.

The Deputy Chief Minister said some leaders whom he had supported were now accusing him of betrayal. He asserted that his conscience was clear about his honesty during H.D. Kumaraswamy's tenure as Chief Minister and said he did not require any external validation.

Addressing entrepreneurs from the Vokkaliga community, Shivakumar emphasized the importance of trust, integrity, and seizing opportunities in life.

Congress opposing scheme as state
treasury is empty: R. Ashok



Mysuru: Opposition Leader R. Ashok alleged that the Congress-led state government is opposing the Centre's newly introduced Viksit Bharat employment guarantee scheme only because it is worried about providing its financial share, claiming that the state treasury is empty.

Addressing a press conference, Ashok said the scheme was introduced by the Narendra Modi-led Union government to correct flaws in the employment guaran-

tee programme over the past 18 years and to curb corruption. He alleged that under the previous system, Congress workers indulged in irregularities such as using heavy machinery, releasing wages in the names of deceased persons, and issuing fake job cards. With biometric attendance and cancellation of bogus cards, such practices are no longer possible, he said. Ashok stated that the Centre has increased administrative costs to nine per cent

and fixed time-lines for wage payments. He pointed out that while 2.5 lakh crore was allocated during former Prime Minister Manmohan Singh's tenure, 8 lakh crore has been provided during Prime Minister Modi's tenure. He said the Centre would provide 17,000 crore to the state, while the state must contribute 10,000 crore, taking the total to 27,000 crore.

Citing delays in Grihalakshmi assistance and lack of funds for KSRTC and BMTC, Ashok claimed the government lacks even 5,000 crore, which is why it is opposing the scheme and calling a special session unnecessarily.

I accept the offer and I am ready for the debate on any platform any time." It would be better if Kumaraswamy came for the debate. Asked about Kumaraswamy coming for the debate, he said, "I welcome him. It would be good if he came for the debate first. Be it BJP State President or the Leader of the Opposition or Kumaraswamy, I am ready. It can be a public platform, session or media platform, I am prepared."

Kumaraswamy is a dialogue king. Asked about

Gejjalagere Gram Panchayat Inclusion in Maddur Municipality,
Order Should Be Cancelled Immediately: R. Ashok Demands

Mandya : Opposition Leader R. Ashok demanded that the Congress government should immediately cancel the order to include Gejjalagere Gram Panchayat in Maddur Municipality.

Speaking at the protest being carried out by the villagers, he said that villages should develop, and all facilities should be available in the villages themselves—this is Mahatma Gandhi's vision. All the people of Gejjalagere village in Maddur taluk have been protesting for the past 22 days. They are demanding not to ruin the village by merging it with the municipality. There are thousands of acres of paddy fields here, and if it is included in the municipality, the agricultural



land will be destroyed, they say. But the Congress government is ignoring the people's sentiments and merging it with the municipality. The government is destroying this village, he said.

The people here are insisting that the village should remain under the Gram Panchayat. If it is merged with the municipality, the schemes coming from the central and state governments will be

halted. This government is doing the work of throwing stones at the farmers' heads. It should not betray the people's sentiment that it should remain as a village. Earlier, when R. Gundu Rao was the Chief Minister, when oppression was carried out on the village, firing took place and two farmers died. Then the government itself fell. Now, respect should be given to

A special session of the Karnataka Legislative Assembly is being called to expose the Central Government Act that has framed the MNREGA scheme as an anti-people scheme. There is almost an opportunity for open debate there and if HD Kumaraswamy is so interested in discussing it in the Karnataka Legislative Assembly instead of the Lok Sabha, he should get special permission from the President and come for discussion in the Karnataka Legislative Assembly.

HD Kumaraswamy has demanded on behalf of the Karnataka Pradesh Congress Party that if he is committed to Karnataka, he should get permission from the Central Government for the follow-

ing state projects.

Major industrial projects in Karnataka that are pending Central Government approval:

Bangalore Second International Airport
The Karnataka government has shortlisted 3 locations around Bangalore. The Airports Authority of India (AAI) has conducted a pre-feasibility study. The approval is pending. As per the Kempegowda International Airport (BIAL) agreement, BIAL approval is required for the construction of a new airport within a radius of 150 km by 2033.

No new project is being proposed now. There is a difference between the earlier plan and the present one. Under the current plan, there will be no environmental damage or destruction of forests. Only a small quantity of water will be lifted from the Bedti river and there



will be no loss of water. He said the state government should explain these facts to the ongoing protests being led by religious heads in that region.

Ready for discussion
He said they are prepared for open discussions on this issue by inviting water experts and environmental scientists, and that an amicable decision should be taken.

"There is drought on our side. If water is stored during the monsoon, it will be beneficial to our region. This issue should not be viewed emotionally. The project must be planned in such a way that it does not cause inconvenience to anyone," he said.

He added that the state government has already given its consent to prepare the DPR (Detailed

Project Report). After the DPR is prepared, the state government should convene a meeting. No river belongs to just one region; rivers are not stagnant water bodies. The Krishna river originates in Maharashtra and flows through Andhra Pradesh and Karnataka—it does not belong only to Maharashtra. Similarly, the Varada-Bedti project must be implemented. "We are ready for any kind of discussion. The confusion must be resolved through dialogue. For that purpose, we will convene a meeting in Haveri involving religious heads and political leaders. We will also create public awareness and gather public opinion through conventions and meetings," he said.

Vande Bharat Sleeper:
Higher fare, no RAC, pay
for minimum 400 km



CHENNAI: The Railway Board has approved the fare structure for the upcoming Vande Bharat Sleeper Express, which is set to be introduced across Indian Railways with higher speed, improved comfort, modern facilities and enhanced safety features. According to a commercial circular issued by the Railway Board, the Vande Bharat Sleeper Express will operate with only confirmed tickets, with no provision for RAC, waitlisted or partially confirmed tickets. The train will have 1AC, 2AC and 3AC classes.

The basic fare will be all-inclusive, while Goods and Services Tax (GST) will be levied separately as applicable. The minimum chargeable distance has been fixed at 400 km, and all available berths will be opened from the first day of the Advance Reservation Period (ARP).

Only select quotas will be applicable on the train, Ladies quota, Senior Citizen quota, quota for Persons with Disabilities (PwD) and Duty Pass quota. No other reservation quotas will be permitted. The circular also states that digital payments will be preferred for ticket purchases to enable initiation of refunds within 24 hours of cancellation. Normal child fare rules will apply, and the system will attempt to allot lower berths to eligible senior citizens and passengers travelling with children, subject to availability. The Centre for Railway Information Systems (CRIS) has been directed to make the necessary software changes, while zonal railways have been instructed to ensure that all operational details are made available to staff well in advance.

Tamil Nadu: 20 injured
in three-bus collision in
Tirupur's Uthukuli



COIMBATORE: A chain of collisions near Tirupur's Uthukuli involving three buses on Sunday injured 20 passengers and triggered traffic disruption on a busy National Highway stretch.

According to the police, a Tamil Nadu State Transport Corporation (TNSTC) bus travelling from Tirupur to Erode was proceeding along the Coimbatore-Salem National Highway when the accident occurred near Pallagoundenpalayam.

Officials said that a vehicle moving ahead of the TNSTC bus suddenly applied the brakes and came to an abrupt halt. The bus driver applied sudden brakes to avoid hitting the vehicle. However, two other

buses trailing the TNSTC bus were also unable to stop in time and collided with the other bus, resulting in a multi-vehicle accident. The TNSTC bus lost its balance on impact, veered off the road, and overturned along the roadside.

Passengers inside the bus screamed for help as residents, motorists, and passersby rushed to the spot and assisted in rescuing the injured. Ambulances were alerted immediately, and all injured passengers were shifted to the Perundurai Government Hospital for treatment. Hospital sources said that the injuries were not life-threatening and the condition of the injured was stable.

Amid Congress chorus for 'share in power,' DMK says 'no' to coalition govt

DINDIGUL: Ruling out scope for a coalition government, senior DMK leader and State Minister I Periyasamy on Sunday asserted that Chief Minister M K Stalin is firm on the stand against sharing power with allies.

Speaking to reporters here, Periyasamy, when asked on Tamil Nadu Congress's demand for share in power, he said it was the right of the grand old party to make that demand.

However, the DMK had never been in favour of such a proposi-

tion. "There had never been a coalition government," he said, adding the state had all along been helmed by the DMK on its own.

"There is no doubt about this stand of the party, there will be no coalition government and the chief minister is firm on this stand," the Rural Development Minister said.

To a question on CM Stalin's scathing criticism of the Censor Board, he alleged it was true that the film board functioned in a partial manner.



Tamil Nadu Congress has revived its demand for a share in power if the DMK-led alliance wins the Assembly election due by March-April this year. Congress MP Manickam Tagore had said recently that it was time to debate "share in

power." CLP leader, Killiyoor (Kanyakumari district) legislator S Rajeshkumar had also battled for a coalition government. Congress party in-charge for Tamil Nadu, Girish Chodankar had asked if any political party, "will

say that they don't want the power; then we should name ourselves as NGO." Since 1967, both the DMK and AIADMK had formed their own governments despite fighting polls in alliance with other parties. Following independence, when the first general election was held in the then composite Madras state in 1952, the Congress party failed to secure an absolute majority.

It was the only during the First Assembly's (1952-57) term that non-Congress leaders

(including Manickavelu Naicker of the Commonweal Party) were accommodated in the Congress-party led State Cabinet.

In 2006, though the DMK did not have an absolute majority, it ran the government for a full five years (2006-11) with support from allies, including the Congress and without sharing power with allies. Without any success, the TN Congress leaders had made the same "share power with us," demand during 2006-11 term of the DMK too.

10 minutes of intense exercise may help
treat colorectal cancer

Exercise may do more than just improve heart health. A new study found that 10 to 12 minutes of intense exercise may be able to provide benefits such as slowing the growth of colorectal cancer cells. In the study, researchers examined blood both before and after an intense workout session and then tested the serum of each blood sample on cancer cells in the lab. When they exposed the cancer cells to the post-exercise blood serum, the scientists saw activity changes in more than 1,300 genes.

While the findings do not prove exercise treats cancer, they do explain how physical activity may protect against colorectal cancer.

The study findings are published in the International Journal of Cancer Trusted Source.

A short, but intense, exercise bike session

Bowel cancer, also called colon or colorectal cancer, is a commonly diagnosed cancer in the U.S., and the American Cancer Society Trusted Source estimates around 150,000 people received a colorectal cancer diagnosis in 2025. The risk of getting colorectal cancer goes up with age, and genetics and lifestyle habits can increase the risk. For example, research has shown that eating a diet high in red meat can increase risk.

Treatment Trusted Source depends on how early someone receives their diagnosis. Doctors may treat early-stage colorectal cancer with surgery to remove the tumor, while more advanced cases may require chemotherapy or radiation therapy in addition to surgery. Since some research shows that exercise may be beneficial for people who have colorectal cancer, the researchers in the new study wanted to take a closer look at how these benefits might occur.

The new study included 30 adults ages 50 to 78 who were overweight or had obesity but were otherwise healthy. According to the study authors, they chose these participants because "people with obesity and people with cancer

exhibit broadly similar acute molecular responses to exercise." The scientists collected blood samples from the participants before and after their exercise session. The workout consisted of a short, high-intensity exercise bike session where the participants steadily increased resistance on the bike until they reached their maximum effort. This took around 10 to 12 minutes.

Faster DNA repair response after exercise

The researchers analyzed blood samples and found that the intense exercise session increased levels of several proteins, including interleukin-6 (IL-6), a

cytokine that contributes to DNA repair. They also found that the intense exercise suppressed genes associated with rapid cell division, meaning it could help slow cancer cell growth.

The scientists' next step involved creating serums from both the pre- and post-exercise blood samples and seeing how colorectal cancer cells reacted to each serum. The post-exercise serum triggered widespread changes in gene activity, including in pathways related to DNA repair and tumor growth.

Cancer cells treated with post-exercise serum showed signs of faster DNA repair. When the researchers intro-

duced radiation to the cancer cells, the cells treated with the post-exercise serum had a faster repair response.

While the scientists noted that high-intensity exercise may not be possible for everyone with colorectal cancer, the findings show how significant a single intense workout session can be. The team mentioned exploring whether lower-intensity exercise may have similar benefits.

"Exciting" findings, but more research needed

Nilesh Vora, MD, board certified hematologist and medical oncologist and medical director of the MemorialCare Todd Cancer Institute at Long Beach Medical Center, spoke with Medical News Today about the study findings. "The study and its results are very thought-provoking," said Vora. "Short bursts of energy can alter many genes and promote DNA repair, and this could help patients with colon cancer fight more cancer cells." Vora said the results align with existing research showing that people with colon cancer who follow structured, high-intensity exercise programs tend to have fewer recurrences. "While these results are promising, more intensive research should be conducted before more definitive conclusions can be drawn from this study," Vora emphasized.

Vora noted that this should include prospective trials to determine whether intense exercise directly improves outcomes for people with colon cancer.

Judy Chiou, MD, a Doctify-registered staff specialist gastroenterologist and hepatologist at Gosford Hospital in Australia, also spoke with MNT about the study. "I think this is an exciting study that helps to explain some of the biological mechanisms of how exercise may help prevent the development of colorectal cancer," said Chiou.

Chiou said that while clinicians previously recommended exercise to patients with cancer, this study will allow them to explain the mechanisms behind how exercise may help fight cancer. Chiou, however, did note a couple of drawbacks to the study.

The first meme of 2026 Is
about not explaining
yourself and buttons

There's a TikTok user who goes by Tamara who is marking 2026 using 365 buttons. How is Tamara doing that exactly? No one is sure. That's the whole point. This slightly confounding practice was introduced to the world this month, when Tamara — who did not respond to an interview request — posted a comment on a TikTok video, explaining that the buttons were a way of being more conscious of the passage of time.

When other users asked follow-up questions, wondering what they were supposed to do with their buttons, Tamara rebuffed them.

"Hey, so it actually only has to make sense to me for me to do it and I don't feel like explaining it to anyone else," Tamara wrote. (That video has since been removed from TikTok and with it, these comments.)

Tamara's retort, and her unwillingness to explain further, quickly became an "if you know you know" joke that has spread widely, thanks partly to the fact that no clarity was given about how buttons might help soften the unstoppable march of time. Soon, the TikTok account for the Philadelphia Eagles had posted a video of a bucket full of team buttons asking "Alright, Tamara, now what?" In a post on the same platform, the account for the Empire State Building declared a new motto for the year: "Hey, so it actually only has to make sense to me for me to do it and I don't feel like explaining it to anyone else."

Jason Saperstone, a 23-year-old publicist in Manhattan, posted a TikTok video trying to explain the layered and somewhat confusing origin of the buttons meme. In the video, he begins by explaining how the meme originated in the comments of a video from a TikTok user posting about her desire to "rebrand" for 2026. The buttons discourse, though, had quickly usurped the original point of the video. The ambiguity of the TikTok comment, Saperstone said in an interview, probably helped it grow as a trend.



"It would have been so simple to get the answer, but not giving the answer and just making it so much more complicated for no reason, which kind of makes it hilarious," he added. Opacity has become a hallmark of popular memes online, where esoteric jokes like "6-7" have recently proliferated among younger generations. What does "6-7" mean? Much like "365 buttons," the answer depends on who you ask — and even then it's almost entirely subjective. That's much to the delight of those who use such terms, gatekeeping them for select groups that understand the joke. (And the few like Saperstone, who are willing to explain.) None of this has stopped TikTok users from offering up their own interpretations. "My theory is that Tamara has two jars. One is empty and one has 365 buttons. And after every day she puts one in the empty jar to show a day going past," Caroline Ayala, 22, wrote in a TikTok. It seemed "self-explanatory," Ayala, who works in sales and lives in Chicago, said in a phone interview. Other users have run with the prompt and have taken up drawing a button each day or writing original songs. Lee Tepper, a therapist in Columbus, Ohio, found the mantra to be a surprisingly "grounding, centering perspective." (If also a little silly.) "The kickoff meme of 2026 being empowerment and a refocus on yourself and what matters to you, I couldn't be more here for it," they said.

Selfie, ‘penny drop’ mandated as KYC for crypto customers in India

New Delhi: Selfie with live-ness detection, recording of geographical coordinates, and verification of bank account by the ‘penny-drop’ method are among the mandatory new measures listed by India’s financial intelligence agency under the anti-money laundering and terrorist financing KYC protocols for cryptocurrency exchanges while onboarding users. The directives also discourage Initial Coin Offerings (ICOs) and Initial Token Offerings (ITOs), equivalent to IPOs in stock markets, by the exchanges. They say that tumblers, mixers, and anonymity-enhancing tokens-linked transactions shall “not” be facilitated. PTI has reviewed the updated set of guidelines brought out by the Financial Intelligence Unit (FIU), a body that functions under the Union Finance Ministry, on January 8 as part of the ‘anti-money laundering (AML) and combating financing of terror (CFT) guidelines for reporting entities providing services related to virtual digital assets (cryptocurrency).’ The guidelines have been updated about three years after they were first published in March 2023. The FIU is the



single-point regulator for cryptocurrency exchanges (reporting entities or VDA service providers) operating in India under the provisions of the Prevention of Money Laundering Act (PMLA). The fresh guidelines mean that all crypto exchanges must register with FIU as reporting entities and submit regular reports on suspicious transactions and maintain records of their clients (customers) to identify and combat money laundering, terrorist financing and proliferation financing risks associated with crypto assets, which India has not identi-

fied as a legal tender but taxes under the Income-Tax law. The guidelines stipulate that exchanges should “mandatorily” obtain the Permanent Account Number (PAN), selfie with liveness detection, and latitude and longitude coordinates of the onboarding location with date and time stamp, alongwith the IP (Internet Protocol) address of the customer as part of the ‘client due diligence’ measures. The RE (crypto exchange) shall also ensure that the client whose credentials are being furnished at the time of onboarding is the same individual who is actu-

ally accessing the application and personally initiating the account creation process, they stipulate. “The authenticity of such access and personal presence shall be established by capturing a live photograph of the client and employing liveness detection technology to verify the client’s physical presence...” it said. Liveness detection is done by specified software and is used for various legal purposes in India, such as generating a life certificate for pensioners, where they have to blink their eyes to establish that they are alive and authentic. The exchanges

have also been directed to collect one more identity and address document of the client— either passport, driving licence, proof of possession of Aadhaar, voter ID or an equivalent ID — apart from verifying their mobile number and email through a one-time password (OTP). A verification of the client’s bank account shall be done through the ‘penny-drop’ mechanism to confirm the ownership and operational status of the account, it said. Under the ‘penny-drop’ method, a refundable Rs 1 credit is taken by the banking or payment gateway from a customer to authenticate their bank account. The exchanges have been asked to do a KYC (Know Your Customer) updation for “high-risk” clients every six months and for all others annually. An ‘enhanced client due diligence’, by gathering details from open sources and consulting independent databases, is to be done for high-risk individuals or entities who either have links to tax haven countries or jurisdictions named under the FATF grey or black list and politically exposed persons (PEPs) or non-profit organisations (NPOs).

Andhra Pradesh Cement Works Recognised at the ASSOCHAM India Water Leadership Conclave 2025



UltraTech’s integrated manufacturing unit Andhra Pradesh Cement Works (APCW), located in Tadipatri, Andhra Pradesh, was felicitated at the ASSOCHAM India Water Leadership Conclave 2025, for its transformational water stewardship initiatives in drought-prone districts of Anantapur and Nandyal. Held in December in New Delhi, in partnership with the Ministry of Jal Shakti, Government of India, the award recognises APCW’s outstanding CSR initiatives in the “Community Water Initiatives by Industry” category. The districts face severe water scarcity,

receiving only 450-500 mm of annual rainfall, which significantly affects agriculture and overall community resilience. Over-extraction has further resulted into groundwater levels declining by almost 30 cm annually, leading to borewells and dug wells drying up after the monsoon season, exacerbating water scarcity. Over the past five years, APCW has implemented a range of interventions, including the construction of water harvesting structures, provision of soil health mapping & fertilizer advisories, establishment of RO water plants, as well as providing livelihood training for women, with focus on millet-based

food processing and micro-enterprise development. These initiatives have delivered measurable improvements in water availability, agricultural productivity, and livelihoods. Nearly 5 lakh m³ of water storage capacity has been created through percolation tanks, check dams, and sunken ponds, alongside rainwater recharge capacity exceeding 11 lakh m³ captured & reused annually. As a result, crop yields have increased by 15 - 40 per cent, and groundwater levels have risen by 24 metres across monitoring wells, benefiting almost 400 farmers, 150 women, and 415 hectares across the two districts.

Simplified Income Tax Act, 2025, to come into force from April 1

New Delhi: Beginning April 1, the Income Tax Act, 2025, will come into force replacing the six-decade old tax law and the changes made in tax laws in 2026-27 Budget will be incorporated in the new legislation. The 2025 I-T law is revenue neutral with no change in tax rates. It has only made direct tax laws simple to understand, removed ambiguities thus reducing scope for litigations. It reduces text volume and sections by about 50 per cent vis-a-vis the 1961 income tax act. The new law simplifies the tax timeline by doing away with the distinction between the assessment year and the previous year, replacing it with a single ‘tax year’ framework. It also allows taxpayers to claim TDS refund even when ITRs are filed after deadlines, without any penal charges. Any changes with regard to taxation of individuals, corporates, HUFs and others, which are announced in the Budget for 2026-27 on February 1 will be incorporated in the new I-T Act, 2025.



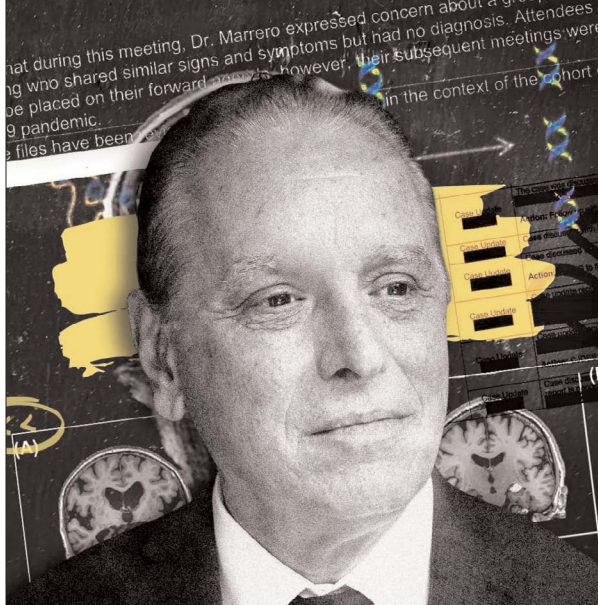
rated in the new I-T Act, 2025. The rules to implement the new Income Tax law are being framed and likely to be notified after the presentation of the FY27 Budget. The new Income Tax law was approved by Parliament on August 12, 2025 after a scrutiny by a Parliamentary committee. It had become an Act after receiving assent of President Droupadi Murmu on August 21, 2025. The rules relating to the Income Tax Act, 2025, are being worked out, while the various tax return forms like those relating to payment of Advance Tax,

TDS, will be notified thereafter. Following is an explainer about the Income Tax Act, 2025. Q. Why the Income Tax Act, 1961, was reviewed? A. Income tax law was enacted 64 years ago in 1961 and since then a lot of changes have taken place in the society, in the way people earn money and companies do business. The 1961 Act was framed at a time when Indian republic was young and faced challenges peculiar to those times. Over the time, as the country progressed, the Act was amended to keep pace with changing times. In view of the technological advance-

ment and changes in the socio-economic fabric of the country, there was a pressing need to completely overhaul the archaic Income Tax Act which has become bulky on account of hundreds of amendments in the law. It has become almost impossible for the common man to comprehend the law and multiple references to different sections, sub-sections, and provisos. Q. What the new Income Tax Act proposes to do? A. The new law is leaner and more reader-friendly. The intention of the government is to halve the volume compared to the old law and make the language simpler so that taxpayer can know his exact tax liability. It would also help in reducing litigations and thereby cut down on disputed tax demands. Q. How will the new law be leaner? A. The Income Tax Act, 1961 deals with imposition of direct taxes — personal I-T, corporate tax, securities transaction tax, besides gift and wealth tax.

'The answer cannot be nothing': The battle over Canada's mystery brain disease

In early 2019, officials at a hospital in the small Canadian province of New Brunswick noticed that two patients had contracted an extremely rare brain condition known as Creutzfeldt-Jakob Disease, or CJD. CJD is both fatal and potentially contagious, so a group of experts was quickly assembled to investigate. Fortunately for New Brunswick, the disease didn't spread. But the story didn't end there. In fact, it was just beginning. Among the experts was Alior Marrero, a soft-spoken, Cuban-born neurologist who had been working in the province for about six years. Marrero would share some worrying information with the other members of the group. He had been seeing patients with unexplained CJD-like symptoms for several years, he said, including young people who showed signs of a rapidly progressing dementia. The number of cases was already more than 20, Marrero said, and several patients had already died.



Because of the apparent similarity to CJD, Marrero had been reporting these cases to Canada's Creutzfeldt-Jakob Disease Surveillance System, or CJDSS. But the results had been coming back negative. Marrero was stumped. More worrying still, he was seeing a dizzying array of symptoms among the patients, according to his notes.

There were cases of dementia, weight loss, unsteadiness, jerking movements and facial twitches. There were patients with spasms, visions, limb pain, muscle atrophy, dry skin and hair loss. Many said they were suffering with both insomnia and waking hallucinations. Patients reported excessive sweating and excessive drooling. Several exhibited

Delusion, which causes someone to believe that a person close to them has been replaced by an identical-looking imposter. Others appeared to lose the ability to speak. One patient would report that she had forgotten how to write the letter Q. Marrero ordered test after test. But he was at a loss. "I just kept seeing new patients, I kept documenting new cases, and I kept seeing new people dying," he recalled. "And an image of a cluster became more clear." Over the coming months, Marrero and the CJDSS scientists began to suspect that instead of a small cluster of CJD patients, the province of New Brunswick might have on its hands a much larger cluster of people suffering from a completely unknown brain disease. Over the next five years, Marrero's cluster would balloon from 20 to an astonishing 500. But there came no scientific breakthrough, no new understanding of neurology, no expensive new treatments.

Asian Thalassemia Conclave 2026 Concludes in Hyderabad, Global Experts Emphasise Prevention to Reduce Disease Burden



Hyderabad, 11 January 2026: The Asian Thalassemia Conclave (ATC) 2026, organised by the Thalassemia and Sickle Cell Society (TSCS), Hyderabad, in collaboration with Kamala Hospital Research Center, concluded successfully with over 400 delegates from across India and around the world participating in the two-day deliberations. The conclave brought together leading clinicians, public health experts, policymakers, researchers, non-gov-

ernmental organisations and patient advocates to strengthen a coordinated response to thalassemia, one of the most serious yet preventable genetic blood disorders. Hon'ble Minister for Health, Medical and Family Welfare, Government of Telangana, Shri Damodar Raja Narasimha, visited the conclave and interacted with organisers and delegates. During his visit, the Minister reiterated the government's commitment to strengthening thalassemia

Iran warns it will retaliate if US attacks as protesters defy crackdown

Iran has warned it will retaliate if it is attacked by the US, as protesters defied a government crackdown on Saturday night despite medics at two hospitals telling the BBC more than 100 bodies had been brought in over a two day period. Videos verified by the BBC and eyewitness accounts appeared to show the government was ramping up its response to the protests, which have spread to more than 100 cities and towns across every province in Iran. US President Donald Trump has threatened to hit Iran "very hard" if they "start killing people". Iran's parliament speaker warned on Saturday that if the US attacks, Israel and all US military and shipping bases in the region would be legitimate targets. The protests were sparked by soaring inflation, and protesters are now calling for an end to the clerical rule of Iran's Supreme Leader Ayatollah



Ali Khamenei. Iran's attorney general said anyone protesting would be considered an "enemy of God" - an offence that carries the death penalty - while Khamenei has dismissed demonstrators as a "bunch of vandals" seeking to "please" Trump. Trump on Saturday said the US "stands ready to help" as Iran "is looking at FREEDOM". As protests intensify,

the number of deaths and injuries continues to rise. Two human rights groups have reported more than 100 people, including security personnel, killed. Staff at several hospitals told the BBC they have been overwhelmed with the injured and dead, with BBC Persian verifying 70 bodies brought to one hospital in Rasht city on Friday night and a health worker

reporting around 38 people dying at a Tehran hospital. Iran's police chief said on state TV that the level of confrontation with protesters had been stepped up, with arrests on Saturday night of what he called "key figures". He blamed a "significant proportion of fatalities" on "trained and directed individuals", not security forces,

but did not give specific details. More than 2,500 people have been arrested since protests began on 28 December, according to a human rights group. The BBC and most other international news organisations are unable to report from inside Iran, and the Iranian government has imposed an internet shutdown since Thursday, making obtaining and verifying information difficult. Nonetheless, some video footage has emerged, and the BBC has spoken to people on the ground. Several videos, confirmed as recent by BBC Verify, show clashes between protesters and security forces in Mashhad, Iran's second largest city. Masked protesters are seen taking cover behind bins and bonfires, while a row of security forces is seen in the distance. A vehicle that appears to be a bus is engulfed in flames. Multiple gunshots and what sounds like banging on pots

and pans can be heard. A figure standing on a nearby footbridge appears to fire multiple gunshots in several directions as a couple of people take cover behind a fence. In Tehran, a verified video from Saturday night shows protesters also taking over the streets in the Gisha district. Other verified videos from the capital show a large group of protesters and the sound of banging on pots in Punak Square, and a crowd of protesters marching on a road and calling for the end of the clerical establishment in the Heravi district. Internet access in Iran is largely limited to a domestic intranet, with restricted links to the outside world. But during the current round of protests, authorities have for the first time severely restricted the domestic intranet. An expert told BBC Persian the shutdown is more severe than during the "Women, Life, Freedom" uprising in 2022.

BRIDE AND GROOM KILLED BY GAS EXPLOSION DAY AFTER PAKISTAN WEDDING



A newly-married couple was killed when a gas cylinder exploded at a house in Islamabad where they were sleeping after their wedding party, police have said. A further six people - including wedding guests and family members - who were staying there also died in the blast. More than a dozen people were injured. The explosion took place at 07:00 local time on Sunday (02:00 GMT), causing the roof to collapse. Parts of the walls were blown away, leaving piles of bricks, large concrete slabs and furniture strewn across the floor. Injured people were trapped under

the rubble and had to be carried out on stretchers by rescue workers. Emergency workers said the blast happened due to gas leakage, which filled the room and then exploded. Three neighbouring houses were also damaged. The chairman of Pakistan's Senate, Yusuf Raza Gilani, called it "a heart-wrenching incident that turned celebrations into mourning". Hanif Masih, the father of the groom, said his son had been married the previous day, and the newlywed couple, along with family members and guests, were sleeping in the house at the time of the explosion.

Last Kurdish forces leave Aleppo after ceasefire deal reached



The final Kurdish fighters have withdrawn from the Syrian city of Aleppo, after the announcement of a ceasefire deal in the early hours of Sunday morning. Mazloum Abdi, leader of the Kurdish-led Syrian Democratic Forces (SDF), said an agreement had been made via international mediation, securing the safe evacuation of "martyrs, the wounded, the trapped civilians and the fighters" from the city. Buses carrying the last Kurdish-led SDF members were seen leaving the Kurdish majority neighbourhood of Sheikh Maqsoud, according to local media reports. The latest clashes in Aleppo started earlier this week, after negotiations to integrate the Kurds into Syria's new government reached a stalemate. At least 12 people were killed in the latest outbreak of violence, which also saw tens of thousands of civilians displaced after they were forced to flee Sheikh Maqsoud and Ashrafieh.

The Syrian army shelled the area on Wednesday afternoon after designating the neighbourhoods "closed military areas", in response to what it alleged were attacks by armed groups in the area. The Kurdish-led SDF - which insists it has no military presence in Aleppo - called it a "criminal attempt" to forcibly displace residents. A ceasefire was raised earlier in the week, but Kurdish forces refused to leave the last stronghold of Sheikh Maksoud under the deal. In March 2025, the Kurdish-led SDF, which controls much of Syria's north-east and has tens of thousands of fighters, signed a deal to integrate all military and civilian institutions into the Syrian state. Both sides accusing each other of trying to derail the negotiations that followed, with the agreement still not realised almost a year later. The newest iteration of the ceasefire agreement was mediated by the US and other world powers.

Author Chimamanda Ngozi Adichie's family accuse hospital of negligence over son's death



The family of Nigerian novelist Chimamanda Ngozi Adichie has accused a hospital of negligence over the death of her 21-month-old son. Nkanu Nnamdi died at a hospital in Nigeria on Wednesday following a short illness, leaving the family of the acclaimed postcolonial feminist writer "devastated". Now, the family allege there was a litany of failures at Euracare Hospital in Lagos that led to

the toddler's death, including being denied oxygen and being given too much sedation, causing a heart attack. The hospital expressed its "deepest sympathies" over the loss of the child but denied improper care, which it said had been in line with international standards. It added that Nkanu had arrived at the hospital "critically ill" and that an investigation into the death was now under way. Adichie's sister-in-law, Dr Anthea Nwandu, made a series of allegations about the hospital in an interview with Nigerian broadcaster Arise TV on Saturday. In it, she said the medical director of Euracare had told Adichie her son "had received too much sedation".

Thousands march and dozens arrested in Minneapolis protests against ICE

Thousands of people joined another night of protests in Minneapolis on Saturday, following the death of a woman who was shot by a US Immigration and Customs Enforcement (ICE) agent in the city. Earlier, city officials said 30 people had been arrested during the weekend's protests, and one police officer was injured after a "chunk of ice was thrown at them". Protests against immigration enforcement have been held across the US after 37-year-old Renee Nicole Good was shot in her car on Wednesday. The Trump administration said the agent who fired the shots acted in self-defence. Local officials have insisted the woman posed no danger.



People gathered in Minneapolis on Saturday night despite bitterly cold weather, while anti-ICE protests also took place elsewhere in the US, including in Austin, Seattle, New York and Los Angeles. The city of Minneapolis said on Saturday that the "vast majority of community members have demonstrated peacefully". On Friday night, Minneapolis Police declared an unlawful assembly as protesters gathered outside the Canopy Hotel in the city, where some ICE agents were believed to be staying. The Minneapolis police department said in a statement that "several hundred people" attended and "some individuals forced

entry into the hotel through an alley entrance". Videos posted online showed protesters flashing bright lights into the area, blowing whistles and banging on drums. Police said some threw ice, snow and rocks at officers, police vehicles and other vehicles, but no serious injuries were reported. One law enforcement officer suffered minor injuries but did not need any medical attention, according to the BBC's US partner CBS News. Officials said another hotel in the city was also targeted and had window and graffiti damage. At a news conference on Saturday, Minneapolis Mayor Jacob Frey applauded the majority of protesters who he said have been peaceful.

ONE PERSON DEAD AND 300 BUILDINGS DESTROYED IN AUSTRALIA BUSHFIRES

One person has died and 300 homes and buildings have been destroyed in bushfires that have torn across south-east Australia. The fires have raged in dozens of locations across the country for several days, mostly in the state of Victoria, but also in New South Wales, burning through land almost twice the size of Greater London. A state of emergency has been declared in Victoria as thousands of firefighters and more than 70 aircraft battled the blaze. Residents in more than a dozen communities have been advised to leave their homes. The authorities fear the blazes, which are being fuelled by very hot, dry and windy conditions, could

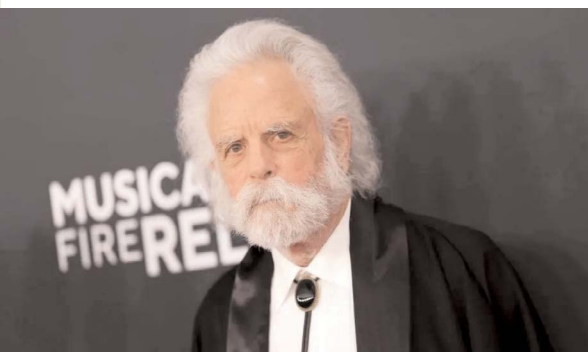


burn for several weeks. Victoria's Premier, Jacinta Allan, said 30 active fires were burning across the state, ten of which were a particular concern. She said 350,000 hectares had been burnt across the state as of 08:00 local time on Sunday (23:00 GMT on Saturday).

"We will see fires continue for some time across the state and that is why we are not through the worst of this by a long way," she told Australian media. "There are fires that are continuing right now that are threatening homes and property." Human remains were found

in the village of Gobur, near the town of Longwood, some 110km (70 sq miles) north of the state capital Melbourne, police said. The victim has not yet been identified. Allan praised the emergency workers who worked to retrieve the body. "This is difficult and confronting work, and it takes a heavy toll." "The Gobur community is grieving," Allan said. Bushfire smoke is impacting air quality in many areas across Victoria, including metropolitan Melbourne. Authorities said the fires were the worst to hit the south-east of Australia since the 2019-2020 blazes that destroyed an area the size of Turkey and killed 33 people.

BOB WEIR, GRATEFUL DEAD CO-FOUNDER, DIES AGED 78



Bob Weir, the guitarist who co-founded the Grateful Dead, has died aged 78. Weir, a cornerstone of the California psychedelic rock group and many of its offshoots, passed away after a battle with cancer and lung issues, according to a post on his Instagram. "There is no final curtain here, not really. Only the sense of someone setting off again," the post says, noting his hopes that his legacy and lengthy catalogue will live on. The post says he "transitioned peacefully, surrounded by loved ones". "He often spoke of a three-hundred-year legacy, determined to ensure the songbook would endure long after him," the post continues. "May that dream live on through future generations of Dead Heads." With a career spanning more than 60 years, Weir's big break was in 1965 with the founding of the Grateful Dead. Within a few years, they became a force within San Francisco's charac-

teristic counterculture. Quickly their style began shaping rock music - blending psychedelia and 1960s drug culture with musical tones that fused folk and Americana. They are considered one of the pioneers of jam bands. The group was inducted in the Rock and Roll Hall of Fame in 1994 and received a Lifetime Achievement Award by the Grammy's in 2007. 'A large amount of weirdness': The long, strange success of the Grateful Dead The group officially halted in 1995 with the death of fellow co-founder Jerry Garcia. But Weir was involved in various spin-offs, including Dead & Company, which had a residency at the Las Vegas Sphere in 2024 and 2025. Weir was diagnosed with cancer in July and even while being treated, he continued to perform, according to the post on his page. "Those performances, emotional, soulful, and full of light, were not farewells, but gifts," the post says.

US MILITARY STRIKES ISLAMIC STATE GROUP TARGETS IN SYRIA, OFFICIALS SAY

The US and its partner forces have carried out large-scale strikes against Islamic State (IS) group targets in Syria, the US Central Command (Centcom) has announced. US President Donald Trump directed the strikes on Saturday, which are part of Operation Hawkeye Strike, in retaliation to the IS's deadly attack on US forces in Syria on 13 December, Centcom wrote on X. The strikes were conducted in an effort to combat terrorism and protect US and partner forces in the region, according to Centcom. "Our message remains strong: if you harm our

warfighters, we will find you and kill you anywhere in the world, no matter how hard you try to evade justice," Centcom said. The US and its partner forces fired more than 90 precision munitions at more than 35 targets in an operation that involved more than 20 aircraft, an official told CBS News, the BBC's US partner. The official added that aircraft including F-15Es, A-10s, AC-130Js, MQ-9s and Jordanian F-16s had taken part in the strikes. The location of the strikes and the extent of any casualties is not yet clear. "We will never forget, and never relent," Defence



Secretary Pete Hegseth wrote on X on Saturday in reference to the military action. The Trump administration first announced the Operation Hawkeye Strike in December after an IS gunman killed two US soldiers and a US civilian interpreter in an ambush

in Palmyra, located in the centre of Syria. "This is not the beginning of a war - it is a declaration of vengeance," Hegseth said when announcing the operation in December. "The United States of America, under President Trump's leadership, will never hesitate and never

relent to defend our people." Prior to the latest strikes on Saturday, US forces killed or captured nearly 25 IS group members in 11 missions between 20 December and 29 December as part of Operation Hawkeye Strike, Centcom said. In the operation's first mission on 19 December, US and Jordanian forces carried out a "massive strike" against the IS group, deploying fighter jets, attack helicopters and artillery to strike "more than 70 targets at multiple locations across central Syria", according to Centcom. That operation, it said, "employed more than 100 precision

munitions" targeting known IS infrastructure and weapons sites. Syria has been in a fragile state since the fall of President Bashar al-Assad's regime in December 2024, which effectively ended a civil war that had ravaged the country for 13 years. Ahmed al-Sharaa, also known by his nom-de-guerre Abu Mohammed al-Jolani, has been serving as the country's president since his rebel group ousted Assad and solidified control. The IS has been weakened in Syria, but still remains active, predominantly carrying out attacks against Kurdish-led forces in the north-east in 2025.

Pant ruled out of India's ODI series against New Zealand

Rishabh Pant has been ruled out of the three-match ODI series against New Zealand with a side strain. The India wicket-keeper-batter picked up the injury during practice ahead of the first match on Sunday. Dhruv Jurel has been named his replacement and has already linked up with the squad in Vadodara. "Pant felt a sudden onset [of] discomfort in his right lateral abdominal area while batting in the nets during India's practice session on Saturday afternoon at the BCA Stadium, Vadodara," a BCCI statement said. "He was taken for MRI scans immediately and the BCCI medical team had a detailed discussion with an expert on his clinical and radiological findings. Pant has been diagnosed with a side strain (oblique muscle tear) and is subsequently ruled out of the ODI series." Pant's

injury does not affect India's first-choice XI, with KL Rahul ahead of him in the pecking order as the designated ODI wicket-keeper-batter. Pant was in the middle of a decent run of form, though, captaining Delhi to the Vijay Hazare Trophy quarter-finals, and scoring two fifties in six innings along the way. Jurel, who is yet to make his ODI debut, will deputise for Rahul. He comes into the squad on the back of six fifty-plus scores in his last seven List A innings. He turned two of those into centuries as well for Uttar Pradesh, a return to form after scores of 14, 13, 0 and 2 in the Test series against South Africa last year. After the first ODI in Vadodara, the teams play in Rajkot (January 14) and Indore (January 18) before shifting focus to the five-match T20I series, in Nagpur (January 21), Raipur (January 23), Guwahati (January 25),

Visakhapatnam (January 28) and Thiruvananthapuram (January 31), which will set them up for the T20 World Cup, to be played in India and Sri Lanka in February-March. Neither Pant nor Jurel figure in India's T20I squad. At India's optional practice session at the BCA B ground, Pant looked organised in his batting session going for almost 50 minutes. But Pant experienced discomfort after being hit above the waist while facing a delivery from a throwdown specialist. He immediately fell to his knees due to the immense pain and was quickly attended to by the support staff members and left the nets. "Scans and assessment by the team doctor showed that Rishabh copped a blow on the ribcage on the right side and a side strain has been detected, thus ruling him out of this ODI series against New Zealand," said sources familiar with the

matter to IANS on Saturday. Pant is now expected to rest for several days before reporting to the BCCI



Three horses die in separate incidents at Kempton

Three horses have died after sustaining injuries in separate incidents during Kempton Park's Lanzarote Hurdle card. Grade One winning Kalif Du Berlais, who was part-owned by former Manchester United manager Sir Alex Ferguson, fell and unseated jockey Harry Cobden in the final stages of the four-runner Silviniaco Conti Chase. The six-year-old sustained a broken shoulder and could not be treated by the veterinary team, with trainer Paul Nicholls describing the loss as "a big kick in the teeth" and a "sad day". Also on Saturday, Wertpol suffered a fatal fall in the juvenile hurdle, while Peso pulled up with an injury in the



Shaker Handicap Chase. Both horses were attended to by the veterinary team but were unable to be saved. A spokesperson for Kempton Park said: "All of us at Kempton Park care deeply about the welfare of all racehorses, as do the thousands of racing staff who provide them with world-class levels of care at home every day. "Our heartfelt condolences are with the connections of all three horses." The British Horseracing Authority (BHA) said, external it will analyse each incident in detail

through its fatality review process. "At this stage there does not appear to be any common factor that can be attributed to these incidents, with each of the injuries different in nature and sustained in unique circumstances," it added. Briton Nicholls said Kalif Du Berlais had been "travelling beautifully" at Kempton and they had "a lot of faith" the horse could go far. "He's won a Grade One and had a big future, there is no doubt about that, but we're not going to know how big, sadly," he said.

Internet Fumes Over Arshdeep Singh's Exclusion From 1st ODI Against New Zealand

include Arshdeep Singh in the playing XI for the first ODI encounter against New Zealand in Vadodara on Sunday. India opted for three specialist bowlers - Harshit Rana, Mohammed Shami and Prasidh Krishna - but did not find any place for Arshdeep. The left-handed fast bowler play all three matches in the series against South Africa but was able to take just three wickets. However, social media users were not pleased with the team management choosing Prasidh over him and even Ashwin came up with a sly dig at the entire situation. "Where-is-deep Singh? That's all," Ashwin posted on X (formerly Twitter). Coming to the

match, India captain Shubman Gill won the toss and elected to bowl first. India copped a major blow on the eve of the ODI series opener as the star wicket-keeper batter Rishabh Pant has been ruled out of the three-match series owing to a side strain (oblique muscle tear). According to a release from the Board of Control for Cricket in India, Pant sustained the injury while batting during a net session at the BCA Stadium in Vadodara on Saturday. Dhruv Jurel replaced Pant in the Indian squad for the New Zealand series. However, he didn't make it into the India XI for the first ODI as KL Rahul has been assigned with the wicketkeeping duties.

Rohit Reaches Epic First With Gigantic Six, Can't Miss Virat Kohli's Reaction

Questioned over his intentions of extending the ODI career, Rohit "Hitman" Sharma once again ventured into territory where no player has gone before. As India took on New Zealand in the 1st ODI of the 3-match series in Vadodara, Rohit arrived at the crease with 648 international sixes to his name, needing just two more to reach a monumental milestone. He didn't make the fans wait long. Chasing a target of 301, Rohit began with his characteristic elegance, but it wasn't too late into the innings that history was made. Facing Kiwi pacer Kyle Jamieson, Rohit advanced down the ground to smash a stunning maximum over the long-on fielder to reach 650 sixes in his international career, reaching a monumental milestone that no other player in the world has before. Rohit's journey to 650 is a testament to his ev-



lution from a middle-order "touch-player" to the most feared opening batter in the white-ball game. To put his achievement into perspective, he sits comfortably ahead of some of the greatest power-hitters to ever

play the game: Rohit was eventually dismissed for 26 off 29 balls by Jamieson. Having retired from T20Is and Test cricket in 2025, Rohit's focus is now purely on "Mission 2027".

Shubman Gill Snubs India Star For 1st ODI vs New Zealand, Irfan Pathan's Rant Can't Be Missed



Another India XI, another omission for all-rounder Nitish Kumar Reddy as skipper Shubman Gill and head coach Gautam Gambhir snubbed the all-rounder for a place in the team in the first ODI against New Zealand on Sunday. As India skipper Shubman Gill won the toss, he opted to field first while also announcing that the management has picked 6 bowlers in the XI. Seeing Reddy being snubbed again, Irfan Pathan went on a rant during the post-toss show for the broadcaster JioStar. "If you don't play him, you can't groom him as an all-rounder. He gets picked, travels with the team, but doesn't feature in the XI. There must be some reason why he isn't getting picked," Irfan said on JioHotstar after the playing XI was named in the first ODI. It isn't the first time that Irfan has advocated Reddy's selection in the team. Even on his YouTube channel, the former India all-rounder had urged the management to

back Reddy for more opportunities in the team. "Nitish Kumar Reddy should be given more opportunities, even if he fails. There are not many all-rounders who can bowl at 130 kmph and can bat in the middle order. Hardik Pandya became the player he is now because he was played regularly for the first 2-3 years. The selectors, the team management, and fans will have to be patient with Nitish Kumar Reddy. After the Test Hundred in Melbourne, we have not seen anything special from him in Tests. When he has had opportunities in white-ball cricket, even there he has not done well. But there are no other players with such a skillset," he added.

Harshit Rana, Shubman Gill Can't Believe As Kuldeep Yadav Drop Absolute Sitter In 1st ODI vs NZ

Not the absolute best fielder in the world, but Kuldeep Yadav isn't someone who is known to produce disasters on the field. Yet, in the first ODI of the 3-match series against New Zealand on Sunday, Kuldeep dropped an absolute sitter on the bowling of Harshit Rana, leaving both the pacer and skipper Shubman Gill in absolute disbelief. It was Henry Nicholls, who looked to take charge after a slow start to the innings. Chasing after a short and wide delivery, however, he got top edge, but Kuldeep's blunder earned him a lifeline. Kuldeep, arguably India's best spinner at the moment, had a forgettable moment in the field, as he ran in from the third man to grab Nicholls' catch. But



the ball popped out of his hand as he hit the ground. India had the opportunity to bag the first wicket in the 6th over, but it went begging. Harshit and Gill couldn't hide their frustration, especially as India struggled to break the opening partnership in the first power play. India Opted To Bowl First India captain Shubman Gill opted to field first after

winning a rare toss. Gill confirmed that India picked 6 bowling options in the playing XI despite snubbing all-rounder Nitish Kumar Reddy. "We will bowl first. Honestly, try different kinds of combinations, you know, see what combination suits us the best for different conditions, obviously when we play in India. Whenever you're bowling second,

there's a bit of a challenge with the dew, and so try out what kind of combination suits our condition the best. It looks like a good wicket. Hopefully, I think it'll be a little bit easier to bat on in the second innings with the dew coming in, and that was the thought process behind bowling first. "I think playing a bit of Vijay Hazare Trophy, everyone is coming after playing some matches, so everyone looks in good form. We've played a lot of cricket together, so you know, the environment is always nice and calm whenever we get together. We are going with six bowlers, with Washi, Jadeja and Kuldeep as the spinners, and Prasidh, Siraj, and Harshit the three pacers," he said.

Who Is Adithya Ashok: Vellore-Born Rajnikanth Fan Playing For New Zealand Against India

Indian-origin leg-spinner Adithya Ashok was named in the New Zealand XI for the first ODI against India in Vadodara on Sunday. Born in Vellore, Ashok lived in India until the age of four before his parents moved to Auckland for better career prospects. He rose through the ranks of Auckland's domestic system, eventually representing New Zealand in the 2020 U-19 World Cup. After making his professional T20 debut for Auckland in December 2021, Ashok quickly became a regular across all formats. His breakthrough season came in 2022-23, when he was honoured as New Zealand's Young Cricketer of the Year.



International Career Ashok received his maiden international call-up for the tour of the United Arab Emirates, where he appeared in a T20I. A few months later, he made his ODI debut against Bangladesh. However, a back injury soon followed,

forcing him to remain sidelined for a significant period. To date, he has claimed two wickets in his three international appearances. The Rajinikanth Connection A massive fan of Tamil superstar Rajinikanth, Ashok has a tattoo on his

bowling arm that reads "En vazhi thani vazhi" (My way is a unique way) in Tamil. The phrase is an iconic dialogue from the movie Padayappa and holds deep personal significance as it was the last film he watched with his late grandfather. Preparing for this subcontinental tour, Ashok notably spent several weeks training at the Chennai Super Kings (CSK) academy in 2025. Bears & Rams claim thrilling NFL play-off wins



The Chicago Bears produced a stunning fightback to beat divisional rivals Green Bay and claim their first play-off win in 15 years. The Bears managed a record six comebacks in the regular season having trailed inside the final two minutes and they pulled off another escape act to beat the Packers 31-27 in Chicago. Green Bay led for most of Saturday's Wildcard Weekend game but Chicago scored 25 points in the fourth quarter to recover from a 18-point deficit - a franchise record for the post-season. The Bears follow the Los Angeles Rams into the Divisional Round after they avoided a huge upset at the Carolina Panthers, with Colby Parkinson's touchdown giving them a 34-31 win with 38 seconds remaining. The rivalry between Chicago and Green Bay is the oldest and most-played rivalry in the NFL, with this the 213th meeting between the divisional rivals - and just the third in the play-offs, the others coming in 1941

and 2011. The Bears surpassed expectations this season to win the NFC North division in Ben Johnson's first year as head coach and claim the NFC's second seed. Green Bay were the seventh seed so had to visit a snowy Chicago for the first play-off game at Soldier Field since 2019, and during the first half it seemed the occasion may be too much for the Bears. Packers quarterback Jordan Love returned after two games out following a concussion and threw three touchdown passes as the visitors charged into a 21-3 lead by half-time. But Chicago's defence stepped up in the second half to stifle the Packers and a field goal made it 21-6 heading into the final quarter. The Bears added another before second-year quarterback Caleb Williams, making his play-off debut, showed why he has been nicknamed 'the Iceman' by leading his team to touchdowns on three straight possessions.

attention, eventually leading her to transition into the film industry as an assistant director to pursue her passion for cinema. During her early career, she married BA Raju, who was making his mark as a film journalist and PRO. Together, they formed a powerful team

rooted in dedication and shared responsibility. In 1994, they founded Superhit Film Weekly. Thanks to their hard work, it became the number one film magazine in the industry. Remarkably, they published the weekly magazine for decades without ever missing a single issue, proving their incredible commitment to their craft. With her husband's support, B. Jaya turned her passion for direction into reality. After supervising the production of their first film, Premalo Pavani Kalyan, she made her directorial debut with Chantigadu. The movie was a massive success, running for 100 days in 25 centers. She followed this up with hits like Premikulu, Gundammagari Manavadu, Lovely, and Vaisakham. These successes solidified her position as a prominent female director alongside the legends of the industry.
