### Class 12 girl student gang-raped inside moving car in Rajasthan's Bikaner

**JAIPUR (TSIT):** A Class 12 girl student was allegedly kidnapped and gang-raped inside a moving car in Rajasthan's Bikaner district, police said on Monday. The incident occurred on January 6 in the Napasar area, but a case was registered only on January 11 following a complaint by the girl's family, they said. According to the complaint, the girl had left home for school on the morning of January 6. Two youngsters intercepted her and abducted in a car and drove away.

### Couple beaten to death over 'love affair' in Etah; woman's kin detained

**ETAH (UP) (TSIT):** A 20-year-old woman and her lover were beaten to death on Sunday, allegedly by her family, after they were caught together at her house in Etah district, police said. SSP Shyam Narayan Singh said some members of the woman's family have been detained for questioning in connection with the double murder at Garhiya Suhagpur village. The deceased have been identified as Shivani (20), daughter of Ashok, and her lover Deepak (25), son of Radheshyam. Both belonged to the same village and community.

## Telangana govt to form panel to review district reorganisation

**Hyderabad (TSIT):** Telangana Chief Minister A Revanth Reddy on Monday, January 12, said the state government would soon appoint a commission led by a retired high court or Supreme Court judge for reorganisation of districts in the state. Speaking after unveiling the 2026 calendar and diary of Telangana Gazetted Officers Central Association here, he said the reorganisation of districts was carried out irrationally during the previous BRS regime.

"We are receiving representations about reorganising districts and mandals. Justice will not be done if we take decisions (on districts) based on political considerations. Soon, we will appoint a committee headed by a retired high court or Supreme Court judge and comprising officers who worked in revenue department and others," he said. The Chief Minister said there would be "rationalisation" of mandals, revenue divisions and districts. He said the government would take up debate on the issue during the budget session of the Assembly.

The number of districts in the state increased to 33 from 10 during the BRS government. Several leaders sought reorganisation of districts and other administrative units. The CM mooted that the proposed panel should undertake field visits to gather public opinion on reorganisation. Reddy announced that he has cleared a pending DA of government

## PSLV suffers rare setback in C62 mission due to third-stage anomaly

**SRIHARIKOTA (TSIT):** India's Polar Satellite Launch Vehicle (PSLV), long regarded as ISRO's most reliable workhorse, suffered a rare setback on Monday morning when the PSLV-C62 mission failed due to an anomaly in its third stage, marking the second such failure linked to the PS3 stage in less than a year. The Indian Space Research Organisation (ISRO) launched the PSLV-C62 mission carrying the Earth Observation Satellite EOS-01 for the Indian Army along with 15 foreign satellites from the second launch pad at the Satish Dhawan Space Centre (SHAR), Sriharikota, Andhra Pradesh, at 10.18 am on Monday.

The mission also included satellite payloads belonging to the United Kingdom, Brazil, Spain, Nepal and France. The lift-off and the performance of the first and second stages were reported to be normal. However, an anomaly occurred during the operation of the third stage (PS3), which uses solid fuel, leading to a deviation in the rocket's trajectory and resulting in mission failure.



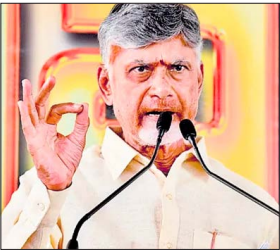
This is the second consecutive failure associated with the PSLV's third stage. The earlier PSLV-C61 mission, launched in May 2025, had also failed due to a malfunction in the PS3 stage, according to ISRO sources. Despite these recent setbacks, PSLV remains India's most dependable launch vehicle. Out of 64

missions conducted so far, only four have failed. These include the maiden PSLV-D1 mission in 1993 due to a second-stage separation and ignition issue, PSLV-C39 in 2017 caused by heat shield separation failure, and the recent PSLV-C61 (2025) and PSLV-C62 (2026) missions, both linked to third stage anomalies. Addressing the media after the launch, ISRO Director V Narayanan

said that the PSLV has four stages, two solid fuel and two liquid fuel stages. "The rocket's performance was normal up to the third stage. However, an anomaly was encountered towards the end of the PS3 stage. A detailed analysis is currently underway," he said. He added that data is being collected from multiple ground stations to thoroughly analyse the mission and identify the root cause of the anomaly.

## Polavaram-Nallamalla project won't harm anyone: CM Naidu

**Amaravati (TSIT):** Amid the ongoing dispute with Telangana over the sharing of river waters, Andhra Pradesh Chief Minister N. Chandrababu Naidu on Monday defended the proposed Polavaram-Nallamalla Sagar link project, saying it will not harm anyone. He wondered what was wrong with using water released from upstream in the Godavari River and diverting it at Polavaram to Nallamalla Sagar. "I never objected when Telangana built its projects. Both Telugu states can efficiently utilise the Godavari waters," he said. The Chief Minister was speaking at a meeting with ministers and secretaries at the Secretariat. He said the Polavaram project will be completed and dedicated to the nation before Godavari Pushkaram. He stated that Polavaram is a magnificent



project and once it is completed, no state in South India can compete with Andhra Pradesh. "Every year, 3,000 TMC of water goes to waste into the sea. By providing water to the Krishna delta through Pattiseema, we are saving water in Srisaillam and giving it to Rayalaseema. Through Nallamala Sagar, there is an opportunity to provide water to Rayalaseema, Prakasam, and other regions," he said. He stated that Telangana State will also have the opportunity to utilise the surplus water from Polavaram. Chief

Minister Naidu said that Bhogapuram International Airport will also be dedicated to the nation soon. He claimed that the coalition government has saved Visakhapatnam Steel Plant with the cooperation of the Central government and the assistance of Rs 12,000 crore. "Visakhapatnam Steel Plant is a sentiment for the people of Andhra Pradesh, and we will definitely protect that plant," he said. The Chief Minister revealed that Andhra Pradesh attracted 25 per cent of the foreign investments that came into the country during the current financial year. Stating that Andhra Pradesh has become a destination for investments, he said that if all the agreements made through Confederation of Indian Industry (CII) materialise, 16 lakh jobs will be created.

## Trump calls himself acting president of Venezuela

Venezuela's vice president and oil minister, Delcy Rodríguez, was formally sworn in as the country's interim president last week.

**New York (TSIT):** US President Donald Trump described himself as the "Acting President of Venezuela" in a Truth Social post, using a picture of his purported Wikipedia profile on Monday, January 12. he post on Truth Social on Sunday has Trump's official portrait and then the designation "Acting President of Venezuela, "Incumbent January 2026." It also has his designation as the 45th and 47th President of the United States, who assumed office on January 20, 2025. This month, the US carried out a "large-scale" strike against Venezuela, capturing the country's leader, Nicolas Maduro, who, along with his wife Cilia Flores, was flown to New York, where they were indicted on narco-terror-



ism conspiracy charges. Trump has said that the US will "run Venezuela until we can do a safe, proper and judicious transition. We can't take a chance that

### IndiGo flight makes emergency landing in Varanasi after bird hit

**Varanasi (TSIT)** A Bengaluru-bound IndiGo Airlines flight with 216 passengers on board made an emergency landing at the Lal Bahadur Shastri International Airport here following a bird strike, airport officials said on Monday. The incident occurred on Sunday night and Airport Director Puneet Gupta said all 216 passengers on board were safely evacuated after the plane landed. The aircraft, operating as flight 6E 437 en route from Gorakhpur to Bengaluru, suffered damage to its front portion following the bird hit during the flight, officials said. Given the seriousness of the situation, the pilot immediately contacted the Varanasi Air Traffic Control and safely landed the aircraft at the Varanasi airport, officials added.

## AI-driven digitisation errors causing widespread hardship during SIR: Mamata to CEC

**KOLKATA (TSIT):** West Bengal CM Mamata Banerjee wrote to CEC Gyanesh Kumar again on Monday, claiming that AI-driven digitisation errors in the 2002 electoral rolls were causing widespread hardship to genuine voters during the SIR exercise. In her fifth letter to the chief election commissioner since the beginning of the Special Intensive Revision (SIR) of electoral rolls, Banerjee said serious

errors occurred in elector particulars during the digitisation of the 2002 voters' list using AI tools, leading to large-scale data mismatches and wrongful categorisation of genuine voters as having "logical discrepancies". Accusing the EC of disregarding its own statutory processes followed over the last two decades, she said electors were being compelled to re-establish identity despite earlier corrections made after

## "The Musi River & Hyderabad's Environmental Reckoning"

The Musi river, once the lifeline of Hyderabad, today presents a distressing picture of neglect. From a river that sustained drinking water needs, irrigation, and livelihoods, the Musi has deteriorated into one of the most polluted urban rivers in the world. Unchecked encroachments, industrial effluents, urban sewage, and decades of administrative apathy have reduced a historic river into a symbol of environmental failure. The consequences are visible not only in ecological degradation but also in recurring floods, public health crises, and the loss of urban resilience.

Against this grim backdrop, the Telangana government's renewed commitment to revive the Musi has generated cautious optimism. Speaking on the floor of the Assembly, Chief Minister A. Revanth Reddy announced the development of the "Gandhi Sarovar" stretch up to Bapughat as the first phase of a comprehensive Musi rejuvenation programme. The declaration has rekindled hope among citizens, urban planners, and environmentalists who have long argued that Hyderabad's future is inseparable from the fate of the Musi.

Past attempts at restoring the river tell a story of good intentions undermined by poor execution. From the Nizam era to successive governments, multiple projects were launched parks were built, funds were allo-

cated, corporations were formed but most initiatives failed to progress beyond the drawing board. Financial constraints, administrative bottlenecks, and political indifference ensured that the Musi remained trapped in a cycle of half-measures. The result has been stagnation, summed up aptly by the Telugu adage: "the blanket remained where it was spread."

Historically, the Musi has been far more than a drainage channel. Originating in the Ananthagiri hills of Vikarabad district, the river flows nearly 267 kilometres before joining the Krishna at Wadapally in Nalgonda district. It once irrigated over one lakh acres of farmland and supported rich aquatic biodiversity, including more than 25 species of fish. Folklore and tradition even attributed medicinal properties to its waters an irony lost on present-day residents who now associate the river with disease and pollution.

The Musi's legacy is deeply woven into Hyderabad's history. Formed by the confluence of the Esi and Musa rivers near Langer Houz, the Musi finds mention in literary and historical accounts. Writer Enugula Veeraswamy, in his Kashi Yatra Charitra, described the strength of the Musi bridge, noting that it could withstand the simultaneous movement of elephants. Yet, the same river also witnessed tragedy. The catastrophic floods of 1908 claimed around 15,000 lives and rendered nearly 80,000 people homeless, prompting the construction of the Osman Sagar and Himayat Sagar reservoirs under the guidance of Sir M. Visvesvaraya.

Despite these safeguards, flooding has continued to plague the Musi basin in 1930, 1954, 1970, 2000, 2016, 2020, and as recently as 2023 underscoring the need for a long-term, scientifically grounded river management strategy.

Within the Greater Hyderabad limits, the Musi flows for about 70 kilometres, much of it heavily encroached upon and contaminated

by untreated industrial and domestic waste. By the time it enters rural stretches of Nalgonda district, the river poses a serious threat to agriculture and public health. The grim distinction of being ranked among the world's most polluted rivers is a stark reminder of the cost of urban indifference.

The current government's approach signals a shift in intent and scale. With Rs.1,500 crore allocated in the 2025-26 budget and plans to develop a 21-kilometre stretch from Osman Sagar and Himayat Sagar to Bapughat, the project has gained momentum. Additional support in the form of a proposed Rs.4,100 crore loan from the Asian Development Bank further strengthens its financial foundation. Proposals to transform Bapughat into a cultural hub with a towering Mahatma Gandhi statue, a museum, and multi-faith prayer spaces aim to reconnect the river with the city's social and cultural life.

Equally significant is the government's emphasis on balance: firm action against encroachments through the HYDRA mechanism, coupled with rehabilitation measures for the urban poor. The Chief Minister's assurance of diverting Godavari waters to provide a permanent solution to the Musi's water flow, if realised, could mark a turning point.

Global examples from the Thames in London to the Cheonggyecheon in Seoul demonstrate that urban rivers can be restored with political will, public participation, and sustained investment. If the Musi rejuvenation programme stays on course and rises above partisan politics, it could redefine Hyderabad's relationship with its natural heritage. Reviving the Musi is no longer an option: it is an imperative. For the city's water security, for farmers downstream, and for ecological balance, the river must be restored to health. This is not merely a development project it is a statement about the kind of future Hyderabad envisions for itself.

## 'Arrive Alive' Initiative Launched to Prevent Road Accidents CM Revanth Reddy



Hyderabad: Chief Minister A. Revanth Reddy on Monday congratulated the Telangana Police for launching the "Arrive Alive" initiative aimed at preventing road accidents and ensuring safer roads across the State. He said the government considers road accidents a serious social problem and is giving top priority to their prevention.

The Chief Minister inaugurated the programme "Arrive Alive A

Campaign for Safer Roads in Telangana" at Yousufguda and the gathering. He appreciated the police department for working with a comprehensive action plan on road safety. Stating that one road accident occurs every minute in the country, the Chief Minister expressed concern that more people lose their lives on roads than in wars. He recalled several tragic instances where even prominent person-

alities lost their children in road accidents. He stressed the need to create awareness on traffic rules from the student stage itself.

The CM said that with the changing nature of crimes, the police system is being modernised. He highlighted the establishment of special mechanisms to control cyber crimes and the formation of the Eagle Force to tackle drugs, which has earned Telangana Police global recognition. He also referred to the creation of HYDRAA for the protection and restoration of lakes, ponds, and nalas.

Observing that the traffic system is currently chaotic, the Chief Minister said it would be strengthened using technology. He suggested measures such as automatic deduction of challans from accounts of violators. He noted that traffic violations have now become a bigger problem than cyber crimes, drugs, or even murders, and assured that traffic control will be treated as a top priority.

## Minister Seethakka Discusses Tribal Police Battalion Issues with DGP

Hyderabad: State Minister Seethakka held a meeting with Director General of Police (DGP) B. Shivadhar Reddy on Monday to discuss issues related to the Tribal Police Battalion. The meeting was attended by MLAs Koram Kanakaiah, Tellam Venkata Rao, and Jare Adi Narayana.

Minister and MLAs highlighted several problems faced by the Sathupalli Tribal Police Battalion, particularly regarding new recruitments, promotions, local status, and transfers. They stated that delays and uncertainties in these matters were causing hardship to tribal youth and police personnel and urged the DGP to take immediate corrective measures.

Minister Seethakka emphasized that strengthening the Tribal Police Battalion requires ensuring job security, timely



recruitments, proper transfers, and promotions. Responding positively, DGP B. Shivadhar Reddy assured that the issues would be examined on priority and appropriate decisions taken.

She later presented the Medaram Jatara invitation to the DGP and invited police personnel and their families to participate in the festival, calling it a symbol of tribal traditions and Telangana culture.

Ahead of Makar Sankranti, NGO urges citizens not to participate in cockfighting



Hyderabad, Jan 12 : Animal protection organisation, Humane World for Animals India, on Monday, urged citizens not to participate in cockfighting, an illegal form of animal cruelty that takes place during Makar Sankranti. The organisation has also appealed to the people to report any instances of cockfighting to local police authorities. In a cockfight, two roosters, often fitted with razor blades on their spurs and are forced to fight each other to death. The fight usually ends with the death of one or both roosters.

Still prevalent in some parts of Andhra Pradesh, Telangana, Tamil Nadu, Maharashtra and Odisha, cockfighting is a punishable offence under several laws. As per the Prevention of Cruelty to Animals Act, 1960, under Section 11(1)(m) (ii), it is illegal to incite animal fights. The act of organising, managing, or even offering a space for such fights is also a cognisable offence under Section 11(1) (n). In addition to these violations, cockfighting events are often linked to illegal gambling and the sale of illicit liquor and child labour, all prohibited practices. "It's horrifying that this still happens, and no festival or celebration can ever justify it. I have seen the fear in their eyes, the desperation in their movements, and it is gut-wrenching. The birds are terrified, trembling as they are forced to face each other. Some are bleeding from previous fights, still they are forced to fight, completely bloodied and struggling for their lives," said Mishi Aggarwal, cruelty response specialist at Humane World for Animals India.

## AP: YSRCP objects remarks of ruling party leaders on RLI project

Ananthapuram, Jan 12 (UND) YSR Congress Party in Andhra Pradesh on Monday slammed the Chandrababu Naidu government over its stand on the Rayalaseema Lift Irrigation (RLI) project.

Speaking to the media here, former MLA S Visweswara Reddy said the silence of Chief Minister Chandrababu Naidu and the “irresponsible remarks” of his cabinet ministers only show that they are endorsing the statement of Telangana CM Revanth Reddy.

“While Chandrababu Naidu is silent on the issue, the Irrigation and Finance Ministers have been stating that RLI is a waste and a theft project, which is demeaning,” Revanth Reddy had said in



the Telangana assembly.

Visweswara Reddy recalled that former Chief Minister Y S Jagan Mohan Reddy started the RLI project to bring water to Rayalaseema from Srisailem. He said the AP finance minister should answer why his government sanctioned Rs 190 crore when it claims the project is a waste.

The project was conceived not only to provide water to Rayalaseema but also to provide drinking

water to Nellore and Chennai, he observed.

“Chief Minister Chandrababu Naidu has remained silent as his name figured in the cash-for-vote case and has yielded to all the demands of Telangana, allowing the neighbouring State to draw water at will,” the MLA said.

The MLA further alleged that Chandrababu Naidu had encouraged his Telangana cadres to file cases against RLI in the National Green Tribunal (NGT) and failed to defend the project in the necessary measure. “Capital city Amaravati is being promoted and money is being funnelled into it at the cost of people from other regions,” he remarked.

## Grazing on the Margins: Why Pastoralists and Rangelands Deserve a Place at the Centre

Imagine a form of livelihood that requires no factories, no irrigation, and no massive infrastructure. It contributes to food security, biodiversity, renewable economies and even climate resilience. It's deeply ecological, quietly productive, and astonishingly widespread. Now imagine it being ignored for over a century.

Across India, close to 10-12 million people and their animals traverse mountains, plains, and deserts, doing what they've done for generations – moving with the rhythms of the seasons in search of grass, water, and opportunities to market their goods. These are pastoralists – managers of one of India's most misunderstood livelihood system and keepers of over 40% of the country's livestock genetic diversity. And yet, for all their contributions, both they and the grazing lands they depend on remain invisible in national policy making and discourse. Misunderstanding pastoralism and grasslands

To be fair, pastoralism can feel like a bit of a mystery. The whole business of people and livestock moving around, refusing to settle down into neat categories , does not sit easily with our understanding of “modern” production systems. Pastoralism ought to have made way for agriculture and then closed shop. Is evolutionary logic appropriate to assess whether pastoralism survives or not? But regardless of whether it survives, we pretend it doesn't exist. Neither pastoralists nor the rangelands where they graze their animals are quantified, understood or even properly enumerated. As for rangelands, they are most often labelled as “wastelands” – a term that suggests not only neglect but a policy green light for takeover by industry, agriculture, or, more recently carbon-sequestering tree plantations. All this, despite the fact that these ecosystems are home to some of India's rarest biodiversity and form the ecological backbone of our dryland ecosystems.

The roots of this problem go deep. Colonial-era foresters, trained in the temperate woods of Europe, looked out at India's scrublands and savannas and saw absence — of trees, of timber and of the potential for revenue. In came the plantations and out went the herders. The British administrative mindset, with its love of neat borders and settled cultivation, was flummoxed by pastoral mobility, which seemed outdated, inefficient and unproductive. Never mind that pastoralists had evolved precisely the kind of adaptive, mobile systems that one would now call climate-adaptive. Their centuries-old knowledge of landscapes, forage and weather patterns was dismissed as backward. The irony is that these systems, derided for their unpredictability, are now being hailed, at least by researchers and civil society organisations, as ‘models of resilience’ in a world of climate chaos. Pastoral mobility, it turns out, is not a bug or a glitch but an integral feature of this extensive production system. It allows herders to track changes in weather and navigate across landscapes that fluctuate wildly in productivity. Where settled agriculture falters under erratic rainfall, pastoralists make do by being on the move. It's not aimless wandering, it's a finely calibrated migration.

Despite this, pastoralists find themselves hemmed in on all sides. Common lands have shrunk and commercial crop agriculture has taken over. Forests have turned into conservation fortresses that shut out the people who once helped maintain them. And now, in the name of climate mitigation, one of our many pledges include greening 26 million hectares, much of which will likely come from open ecosystems wrongly assumed to be barren or “wastelands”. The prevailing logic seems to be: if it doesn't have trees, plant some. But many of these grasslands are naturally treeless ecosystems. Introducing trees can not only damage these fragile ecologies but also displace the pastoralists who rely on them. Economies and ecology in plain sight All this while, the pastoral economy continues to feed us, largely unrecognised and under-appreciated. By the estimates of our team of researchers at the Centre for Pastoralism, the annual value of just the sheep and goat economy in India is Rs 589 billion. Pastoralism, at large, could be valued closer to Rs 1,650 billion – more than India's national education budget and nearly 3% of the agricultural GDP. This includes meat, milk, wool, pashmina, and dung (yes, dung!), all of which flow through informal value chains that rarely make it to NITI Aayog reports or Ministry of Agriculture briefings.

# EditTrump: When 'Ego-Mania' Trumps Rationality

US President Donald Trump is bent on wrecking the global system, just as he is wrecking the US political system. He has become all powerful internally and he wants to be all powerful externally, too. Internally, the constitutional checks and balances system is not working; externally, his depredations remain unchecked. Despite the rise of China and the revival of Russia as a power, the US is once again becoming unilateralist on the global stage under Trump. He has arbitrarily imposed tariffs on all countries in flagrant violation of WTO rules. He is using tariffs as a weapon to extract not only trade and investment concessions from others but also political ones. This is the case with India, on which he has imposed an additional 25% penalty tariffs for buying Russian discounted oil. Trump is rejecting multilateralism. Sure, his predecessors also did that, but he is doing it more scornfully. Earlier, he had walked out of the Paris Climate Change Agreement, the WHO, UNESCO and the UN Human Rights Commission, among other bodies. He has now decided to quit 66 international organisations, including many UN-related ones, the important ones being related to climate change such as the UNFCCC and the IPCC, as well as trade and economic development-related ones such as UNCTAD and the ECOSOC. Trump disparages renewable energy. He dismisses as a hoax the very idea of climate change, disregarding totally the serious concerns of the international community about the phenomenon. This also reflects US unilateralism on a very sensitive issue. Behind this are the interests of the US oil industry, which are strong backers of Trump and the Republican Party. This explains Trump's enthusiastic reference to the slogan "Drill baby Drill" in his inaugural address in January 2024, pressure on Europe (and India, too) to buy American LNG, sanctions on the Russian oil industry, and, more dramatically, his most recent adventure of attacking Venezuela and abducting President Nicolas Maduro with the expressed intention of taking control of Venezuelan oil reserves, which are the world's



biggest. Trump wants to become the dominant oil power in the world. He has made the legally bizarre claim that America owns Venezuelan oil because the infrastructure was developed by American companies in the first instance. Venezuelan oil, according to him, will be shipped to and marketed internationally by the US. The proceeds will be spent as decided by Trump himself, with Venezuela spending what is allocated to it to buy only American products. The aggression against Venezuela is the 'Trump Corollary' to the US revived Monroe Doctrine spelt out in the National Security Strategy 2025. The US Secretary of State, Marco Rubio, has questioned why Venezuela should sell its oil to China - which bought 50% of the country's oil last year - Russia and Iran, forgetting that the United States used to be the main buyer of Venezuelan oil but following sanctions, China became the main destination in the last decade. (Venezuela owes about \$10 billion to China after the latter became the largest lender under late President Hugo Chavez). Trump's unilateralism was also dramatically reflected in his recent interview with The New York Times, where, in the background of his attack on Venezuela violating international law, he said most pre-

sumptuously, "I don't need international law." When asked if there were any limits on his powers on the world stage, he said, "My own morality. My own mind." That means a business morality and an inconsistent mind. As part of his power play, he intends to let the New Start Treaty expire, closing the chapter on US-Russia agreements to end the arms race. With his announcement of an Iron Dome for the entire US and a \$1.5 trillion defence budget for 2027, a new arms race and strategic instability could well be the result. That Trump, with his aggression against Venezuela and the kidnapping of its President - as well as his determination to acquire Greenland by force if necessary - should still feel entitled to the Nobel Peace Prize and accuse Norway for making a big mistake in not awarding it to him, shows how totally unconcerned he is about how others judge him. He says he will accept Venezuelan Opposition Leader Maria Machado's bizarre offer to hand over to him her Peace Prize for 2025. The Norwegian Nobel Institute has ruled this out as the prize cannot be transferred to others, though the prize money can. Trump again asserted that he had solved eight conflicts (including repeating his claim to have stopped the India-Pakistan conflict) and

should therefore be eligible theoretically for eight Nobel Peace Prizes! It continues to rankle him that Obama obtained the Nobel Peace Prize undeservedly. Trump continues to talk down at Modi and India patronisingly, and even offensively, quite unmindful of the damage he is doing to India-US ties. He has made the absurd claim that knowing that he was unhappy, Modi tried to (console him) "make him happy" by stopping the purchase of Russian oil and asked "Sir, may I see you", as if a deferential subordinate was wanting to see his boss. The MEA spokesperson has countered this by clarifying that both leaders address each other with mutual respect as per diplomatic norms. The arch-warmonger, Senator Lindsey Graham, standing alongside Trump in Air Force One, congratulated him for green lighting the new Russia Sanctions Bill that would impose 500% tariffs on those countries that buy Russian oil such as Brazil, India and China, and elicited the remark from the US President that it was easy to impose tariffs on India. This casual way of dealing with what has become a very sensitive issue between the two countries shows how unbothered he is about the reaction in India and also implies a readiness to increase tariffs on India if required.

## Anatomy of a Political Raid: From Lalu to Mamata

Has Mamata Banerjee done something “absolutely unforgivable” by raiding the raiders of the Enforcement Directorate (ED) at the office of the Indian Political Action Committee (IPAC), a private election consulting agency, and by hitting the streets of Calcutta on January 9? At least, the ruling Bharatiya Janata Party's cadres and supporters are vociferous in asserting that the West Bengal chief minister has broken “constitutional norms” by stalling the ED's action against money laundering and corruption under her governance, and they are gunning for her head. Yet, they find it difficult to convince the larger electorate in this election-bound eastern state – and India at large – that the ED raided IPAC's office solely to bust corruption, its primary mandate. Despite its numerical strength in Parliament, the ruling dispensation has been unable to create a consensus among neutral experts and the wider public about its so-called “war against corruption.” However, the purpose of this article is not to investigate allegations of corruption against Banerjee, the BJP's principal political opponent, or that against Suvendu Adhikari and others of his ilk, who were charged by the ED and the Central Bureau of Investigation (CBI) when they were in the Trinamool Congress but secured reprieve after joining the BJP. The purpose, rather, is to understand how the Election Commission of India's special intensive



revision (SIR) and India's premier investigating agencies appear to have been timed and synchronised with the BJP's electoral strategy to corner its opponents and win elections – not only in Bengal but across the country. In this light, Mamata Banerjee's “misadventure” or “street fight” in Calcutta, and even her use of “cuss words” against the BJP's top brass, can also be read as an expression of frustration and helplessness in the face of an opponent making all-out efforts to delegitimise her mandate and snatch power in her home state. One may list the options she might have taken instead: taking a delegation to the governor and submitting a memorandum against the ED; approaching the Election Commission of India to complain that the investigating agency was sabotaging her electoral strategy under the garb of fighting corruption; challenging the ED's action in a

court of law. But the fact remains that she belongs to an enormously large section of Indians who are rapidly losing faith in the neutrality of constitutional institutions – including the investigating agencies, the election commission, and the governors. It would be imprudent to place the judiciary in the same bracket, but by its very nature the judiciary takes time and depends on investigating agencies that have already lost much of their credibility. The Yashwant Sinha route By hitting the streets with thousands of people on January 9, Banerjee has done exactly what the former BJP stalwart, now in the TMC, Yashwant Sinha, had urged the Congress and other opposition parties to do after the Bihar election results of November 2025. In an interview with journalist Neelu Vyas for her digital platform, Sinha – a former Indian Administrative Service officer of repute – said: “There is

no iota of doubt that the Bihar election has been rigged. The only option for the opposition parties, including the Congress, is to hit the streets, get arrested, and not pray for bail. Let the government put you in jail as long as it wishes. The people will eventually find a way to liberate them and save the Constitution that its founding fathers gave them.” He went on in the same vein: “I used to take pride in my pedigree as an IAS officer. But I feel ashamed when I see Gyanesh Kumar, also an IAS officer. Gyanesh Kumar is a disgrace to the IAS... The opposition must bring an impeachment motion against him in Parliament, even if it is defeated.” Sinha had been principal secretary to former Bihar chief minister Karpoori Thakur before relinquishing his post to enter public life. He joined the Janata Dal and later became finance minister in the Chandra Shekhar government.





## Over 60 including Manjeshwar MLA detained in protest against NH-66 toll at Kumbale Arikkadu

Kasaragod, Jan 12: Protests erupted against the collection of toll fees on National Highway 66 at Kumbale Arikkadu between Kasaragod and Mangaluru, during which police detained more than 60 persons, including Manjeshwar MLA AKM Ashraf, on Monday January 12. As soon as information about the toll collection spread on Monday morning, hundreds of people, including public representatives, gathered at the spot and launched a road blockade protest. Tension prevailed at the site as over a thousand protesters assembled, prompting the police to take precautionary measures.

Due to the protest, vehicular movement on the national highway came to a standstill, forcing vehicles to take



alternative routes. With traffic disrupted for several hours, the police forcibly detained MLA A K M Ashraf, other public representatives, and several protesters who were staging a sit-in protest on the road, and took them to the police station. Traffic movement was restored thereafter.

The Toll Fee Opposition Committee pointed out that the high court has not yet

completed the hearing on its petition related to the toll collection. The committee had demanded that toll collection be stopped until a final verdict is delivered. Although discussions were held between the agitation committee and National Highways officials on Monday morning, the authorities did not withdraw the toll collection, following which the protesters intensified their agitation.

The committee warned that the protest would continue until toll collection is suspended. It stated that the collection of toll fees at Kumbale Arikkadu, located just 23 km from Talapady, cannot be accepted under any circumstances. Meanwhile, toll collection was resumed amid the protest.

## Ashok urges Governor to reject hate speech bill

Bengaluru : Opposition Leader R. Ashok said that an appeal has been made to the Governor not to sign the Hate Speech Prohibition Bill and to take action against providing houses to encroachers in Kogilu Cross and Bangla citizens. He spoke to reporters after submitting the appeal to the Governor at Raj Bhavan.

We have apprised the Governor about the lack of law and order in Karnataka, turning it into a jungle raj. We have also appealed to save Karnataka from becoming a goonda state. The session should be called only to draft the bill. However, the Congress government has not given an opportunity for discussion on the Hate Speech Prohibition Bill. A law is being brought where if someone blinks or shows their



hand, they can be arrested. Just like the emergency imposed by former Prime Minister Indira Gandhi in 1975, CM Siddaramaiah is imposing an emergency. Therefore, we have appealed not to sign it.

If this law comes into effect, police can easily arrest opposition MLAs. Based on the government's instructions, police can file cases against anyone. This has been explained as a conspiratorial bill by Congress and a bill that snatches freedom of

speech. A Congress party worker has been murdered in Ballari by Congress members. Without arresting those behind it, allegations have been made against Janardhana Reddy. To bring out the truth, this case should be handed over to CBI investigation, we have requested the Governor. We will hold a convention in Ballari on January 17 to condemn the deterioration of law and order, he informed. Regarding the illegal residents in Kogilu, the fact-finding committee led by MLA Vishwanath

has submitted a report. 36 lakh people are waiting to get houses after paying lakhs of rupees. Just because a cuckoo cooed in Kerala, the crows in the state have shut their mouths. Is the Kerala government ruling Karnataka? Is the CM here listening to Venugopal and the CM there? The government here should not become a puppet of Kerala. Even though the mother tongue rule has been violated in Kerala, the CM has not questioned it. Even though the Kerala government is oppressing Kannadigas in Kasaragod, CM Siddaramaiah has just written one letter and remained silent, he said. BBMP elections should be held as soon as possible. ## MB Patil hands over River Mobility-made Yamaha electric bike

The meeting was attended by the Secretary, Ministry of Heavy Industries; Secretary, Department of Atomic Energy; CMD, IREL (India) Ltd.; Director (Technical), NMDC; Director, NTFDC; and various industrial stakeholders from India and abroad.

In his inaugural address, the Minister emphasized that the Scheme represents a pivotal step towards establishing a self-reliant, resilient, and globally competitive ecosystem for REPMs, aligning with the vision of Viksit Bharat @2047. He urged all



eligible domestic and international players to seize this opportunity and contribute to India's long-term growth story by participating in the bidding process. The Hon'ble Minister also informed that the Ministry is in the process of finalizing the Request for Proposal (RFP).

Joint Secretary, Ministry of Heavy Industries, explained the Scheme, highlighting the key features,

which was notified on December 15, 2025. The total financial outlay for the Scheme is Rs. 7,280 crore, including Rs. 6,450 crore in sales-linked incentives on REPM sales and Rs. 750 crore in capital subsidy for setting up an aggregate 6,000 MTPA of REPM manufacturing facilities, thereby bolstering self-reliance and positioning the country as a prominent player in the glob-

al REPM market. Engaging such tactics and denying them even basic rights of accessing their phones is condemnable,” the former Chief Minister said in a post on the social media platform ‘X.’ He further said the state government would be held accountable if any “minor harm” befell those who have been arrested. “I urge the DMK government to immediately release the arrested teachers,” he said. The government teachers have been on protest since December 26, 2025, seeking the government’s intervention to set right basic pay anomalies between the teachers appointed after June 1, 2009, and those recruited till a day before this date.

## TVK chief Vijay appears before CBI for questioning in Karur stampede case

The CBI took over the case from an SIT following a Supreme Court order, and the investigating agency has been gathering evidence in the matter.

## Ramadoss expels three MLAs supporting Anbumani for alleged anti-party activities

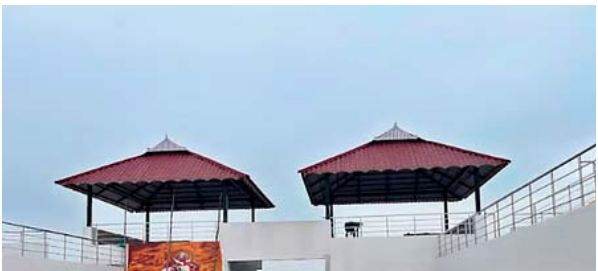

## Tamil Nadu: New mini stadium in Sooriyur set for more events this year

TIRUCHY: The new Jallikattu stadium in Sooriyur in Tiruchy, developed at an estimated cost of Rs 3 crore, would be open for events this year. The stadium is expected to host more events this year as the organisers have planned to approach the officials for permission by this week. As the new jallikattu stadium includes several facilities such as a vast arena along with a permanent vadivasal, two VIP galleries and two galleries



for spectators and usually, moving from the trend of holding only one event in Sooriyur, the organisers across Tiruchy have decided to hold the event in the stadium form this year.

“Because of a permanent structure for galleries in place in the stadium, at least 50 per cent of the total expenditure would be saved. We need at least Rs 5 lakh for establishing gal-

leries for spectators and VIPs, the mini stadium would save such an amount, and instead the fund could be utilised for the other purposes,” said Jallikattu D Rajesh, the Founder President of Tamilar Veera Vilayattu Kazhagam. He welcomed this initiative by the government but urged that the officials should ensure proper collection points. “The present collection point is said to be on private land. Thus, the officials should obtain formal,

permanent permission from their owners to avoid any issues,” Rajesh said. He further noted that as the number of bull owners increased across the State, the number of bulls taking part in each event this year has increased. “The larger bull population will pave the way for the conduct of new events with the government’s permission, and the initiative for online registration for the event is also a boon for the organisers,” he said.

## Madras HC grants interim protection to Kamal Haasan against unauthorised use of his persona



Chennai, Jan 12 (TSIT): The Madras High Court on Monday granted interim relief to veteran actor Kamal Haasan in a John Doe suit, restraining unauthorised commercial exploitation of his personality rights, including the use of his name, image, likeness or other attributes associated with his public persona.

Justice Senthilkumar Ramamoorthy passed the interim injunction while hearing a plea filed by the actor seeking protection against the sale of merchandise bearing his name or image without consent.

The court restrained a Chennai-based firm, Neeve Vidai, along with several other unidentified individuals and entities, from selling products such as T-shirts and shirts featuring the actor’s image, name or screen titles, including “Ulaganayagan”, unless expressly authorised or endorsed by him.

The restraint will remain in force until the next date of hearing.

The interim order was granted after the court was satisfied that the actor had established a prima facie case. Senior counsel Satish Parasaran, assisted by advocate Vijayan Subramanian, appeared for the plaintiff and argued that the unauthorised commercial use of the actor’s persona amounted to a clear violation of his personality and publicity rights. Accepting the submissions, the judge observed that commercial exploitation without consent could not be permitted at this stage. However, the court clarified that the order would not restrict legitimate creative expressions such as caricature, satire or other permissible

artistic works, provided they did not amount to commercial misuse of the actor’s persona.

In his plaint, Kamal Haasan stated that he is widely regarded as one of the greatest and most versatile actors in Indian cinema, known for portraying complex and diverse roles across genres, often involving significant physical and artistic transformations. He noted that he is popularly referred to as a “cinema encyclopaedia” due to his extensive knowledge and mastery over various aspects of filmmaking.

The 71-year-old actor informed the court that he has acted in about 250 films across Tamil, Telugu, Malayalam, Hindi, Kannada and Bengali languages during a career spanning over 65 years.

His accolades include four National Film Awards, 20 Filmfare Awards, 11 Tamil Nadu State Film Awards, and

four Nandi Awards.

He has also been honoured with the Kalaimamani Award (1978), Padma Shri (1978), Padma Bhushan (2014), and the Chevalier of the Ordre des Arts et des Lettres (2016). The veteran actor further pointed out that he was invited in 2025 to become a member of the Actors Branch of the Academy of Motion Picture Arts and Sciences, in recognition of his “indelible contributions to the global filmmaking community”. He argued that his endorsements command significant commercial value and public trust, and therefore unauthorised use of his persona could mislead consumers.

After granting interim relief, the court directed the actor to issue a public notice about the order in both an English and a Tamil daily, noting that the John Doe nature of the suit required wide communication of the injunction.

## WILDFIRES AND MENTAL HEALTH: COMMUNITY FIRST, THEN THERAPY

It was pitch black and smoky at 4 a.m., when Vivianne Parker, 66, of Altadena, California, got the emergency notice to evacuate now as the Eaton Canyon wildfire was approaching her home.

She hurriedly gathered some necessities and set out to walk the 3 miles to the Pasadena Convention Center, the nearest evacuation center. Soon, another neighbor joined her walk, then another neighbor saw them and offered to drive them to the center.

Have you checked in with yourself today? Health experts outline habits that positively impact your mood and protect your state of mind.

Inside the center, she and hundreds of other evacuees had cots and other amenities; outside, representatives from the Federal Emergency Management Agency and other groups had set up shop.

Inside the evacuation center, social worker Elizabeth Hamilton, LCSW, MPH, senior director of regional behavioral health at Kaiser Permanente Southern California, was offering a listening ear to the evacuees. “People are looking for comfort,” she said, and are reaching out to others to get that. “There is comfort in connections, in knowing people have your back.”

Some call this psychological first aid, an approach used by mental health experts to reduce distress, encourage hope, and help people affected reconnect with family and friends. The support and connections just after a wildfire disaster can go a long way in preserving mental health, researchers have found.

After a wildfire disaster, receiving good support from the community is at the top of the list for mental health, according to Vincent Agyapong, MD, PhD, a professor and head of psychiatry at Dalhousie University in Halifax, Nova Scotia, who has long researched the mental health status of people affected by wildfires and other climate events. “The most positive predictor of psychological well-being was the perception you are receiving good support from the community.” That support can come from family, friends, local groups, or government, he said.

As the fires continue to burn, the Los Angeles community continues to offer



support.

As of January 22, according to the California Department of Forestry and Fire Protection, the Eaton Fire was 91% contained; Palisades, 68%. More than 15,700 structures have been destroyed and more than 40,000 acres burned. About 200,000 people were under evacuation orders at first, although some of those orders were later lifted.

Restaurants invited people affected by the fire to stop by for a meal. Hotels and short-term rentals are offering free or discounted stays. One collection point – Santa Anita Park, near the Eaton Fire – was so full of donations just four days after the fires began, the organizers said they didn’t need more of some donations. Animal shelters helped evacuate small and large animals. Music benefits with big names are scheduled. GoFundMe accounts to help people rebuild are being set up at brisk rates. A synagogue in Pacific Palisades that survived the fire put together an information panel with speakers who had lost their homes in previous fires. A Veterans of Foreign Wars post miles from the fires is hosting a \$10-a-bowl pozole benefit, giving proceeds to displaced veterans. Clothing retailers are offering new clothes, gratis, to those affected. In 2024, according to the National Centers for Environmental Information, more than 61,000 U.S. wildfires burned more than 8.8 billion acres, the seventh-most burned acreage over the last 25 years. As the number of wild-

fires grows, research on the mental health effects is increasing. Alison Hwang, MD, PhD, an assistant professor of psychiatry and behavioral sciences at the Stanford School of Medicine, analyzed data from the California Health Interview Survey, which in 2021 added questions about exposure to extreme weather events and mental health. More than half, 53%, reported their mental health was affected by climate events such as wildfires. Young, White, college-educated respondents, as well as women and rural residents, were more likely to report poorer mental health, but Hwang can’t entirely explain that finding. People with mental health issues are more vulnerable, she and others said.

Agyapong’s team tracked the mental health status of residents affected by the 2016 Fort McMurray wildfire in Canada, with 2,400 homes destroyed and 88,000 people evacuated. “Those who reported no support from the community were at greater risk of mental health problems at six months and also at five years,” Agyapong said. Family and friend support also protected people from depression, he found. His team reviewed 63 published studies on the impact of wildfires on mental health, finding an increased rate of posttraumatic stress disorder (PTSD), depression, and anxiety both right after the disaster and for years after. Just after evacuation, “people are seeking immediate relief,” said Dawn Gillam, a licensed clinical social

worker and executive leader of behavioral health services at Kaiser Permanente Southern California. “They want to know where to get a shower, where to get food. They want help walking their dogs, playing with their kids.”

Then, “A few days in, they want to talk about their feelings. People want to talk about their frustration over little things, like they are not getting a warm-enough shower.” Whether a therapist, friend, or family member is listening, people want to feel validated about how they are feeling, therapists said. Hamilton recalled a woman at the evacuation center who told her: “I’m not a crier, but I can’t stop crying.” She was in community leadership roles, and the reversal, of needing help instead of giving it, was difficult for her to accept, Hamilton said. Hamilton assured her that crying was normal, telling her: “We’ve been through the scariest days.”

Humor might help. One woman fretted that she hadn’t gathered the right belongings when she had to evacuate quickly. Hamilton teased her: “You didn’t evacuate right?” That got a laugh. Another man joked: “People have told me my whole life I should see a therapist. Now might be the time.” Hamilton has heard a lot of “I should have” and tells people to ease up on themselves. “All kinds of emotions get triggered by events like this,” said Jeffrey Katzman, MD, a psychiatrist and director of the Silver Hill Academy for Research and Education in New Canaan, Connecticut. He grew up in Pacific Palisades and went to school there. Long-distance, he’s helping family members who had to evacuate and are missing important medical equipment.

“There’s sadness, there is numbness. It’s important to honor those feelings and have someone to listen.” While Katzman said it’s important to honor the range of emotions of someone who’s been through a wildfire, “you don’t want to get stuck there. It’s important to keep moving.” One way to do that, he said, is to regain structure in one’s life. He advises those affected by wildfires to plan, as best and quickly as possible, how they’ll work, where they will live.

## The Ocean has finally entered the global climate debate

In global climate policy, the ocean was long treated as an afterthought, too vast to manage effectively and too resilient to be degraded. Instead, the focus was almost exclusively on reducing greenhouse-gas (GHG) emissions and preserving forests. That era is now over.

At the most recent United Nations Climate Change Conference (COP30) in Belém, the ocean moved from the margins to the mainstream of climate governance. It featured prominently in national climate plans, adaptation frameworks, the follow-up to the first “global stocktake” under the Paris climate agreement, and even the evolving architecture of climate finance.

This shift in the global agenda was likely inevitable, as the ocean increasingly suffers the effects of absorbing over 90% of the excess heat trapped by GHGs and about one-quarter of annual carbon dioxide emissions. The consequences include warming, acidification, deoxygenation, collapsing fisheries, and coastal erosion. But small island developing states (SIDS) and least developed countries (LDCs), many of which are extremely vulnerable to sea-level rise, accelerated the shift by framing ocean governance as a matter not just of environmental management, but of survival and justice.

Consider, for example, COP30’s headline political declaration, the Global Mutirão, which frames climate change, biodiversity loss, and land and ocean degradation as interconnected crises demanding shared solutions and collective action. It explicitly recognizes the role of marine ecosystems in climate stability and sustainable development, giving governments the political cover to integrate ocean and coastal issues into their national climate strategies, development plans, and funding proposals.

A new baseline has been established. For the first time in the UN climate process, the official synthesis of national climate plans contains a section dedicated to the ocean. Roughly three-quarters of these

national plans include marine references, such as blue carbon, offshore renewables, fisheries resilience, and maritime decarbonization. The next step is to move toward quantified ocean-based targets, measurable blue-carbon accounting, and concrete investment pledges for coastal communities.

At COP30, governments also adopted the Belém Adaptation Indicators to track action and progress under the Global Goal on Adaptation. While these indicators are sector-neutral, they are still highly relevant to the health of coastal ecosystems, the resilience of fisheries, the vulnerability of coastal infrastructure and livelihoods, and early-warning coverage. Crucially, climate funds – including the Green Climate Fund, the Global Environment Facility, and the Adaptation Fund – have been encouraged to align their support with these indicators. This could give rise to a new generation of bankable ocean-adaptation projects.

Moreover, ocean-based solutions are attracting more resources. The One Ocean Partnership, which launched at COP30, aims to mobilize \$20 billion for coastal resilience, blue-carbon ecosystems, and ocean protection; create 20 million blue jobs worldwide; and restore 20 million hectares of marine ecosystems by 2030. More consequential was the UN Standing Committee on Finance’s announcement that its 2026 forum will focus on financing climate action in water systems and the ocean – a formal push for blue investment that would have been unthinkable a decade ago. But treaties and conferences are no longer the only means for creating climate obligations. International law has started to converge with climate science. In 2024, the International Tribunal for the Law of the Sea ruled that GHG emissions constitute marine pollution under the UN Convention on the Law of the Sea. In 2025, the International Court of Justice affirmed that states have a binding legal duty to prevent foreseeable climate harm.

# Trump mulls 'very strong' military options as hundreds killed in Iran protests

President Donald Trump says the US military is considering "very strong options" in Iran, as anti-government protests which have reportedly killed hundreds enter a third week. The US-based Human Rights Activist News Agency (HRANA) says it has verified the deaths of nearly 500 protesters and 48 security personnel in Iran, while sources tell the BBC the death toll could be much higher. Trump has threatened to intervene, and said on Sunday that Iranian officials had called him "to negotiate" - but added "we may have to act before a meeting". Iranian leaders have described the demonstrators as a "bunch of vandals", and called on their supporters to take part in pro-government marches on Monday. The government has also announced three days of mourning for what it called "martyrs" killed in a "national battle against the



US and Israel" - two countries that Tehran says are fomenting unrest. Anger over the plummeting value of the Iranian currency sparked protests in late December, which have grown into a crisis of legitimacy for Iran's Supreme Leader, Ayatollah Ali Khamenei. Trump has not yet elaborated on what the US is considering in terms of military options, nor on the proposed negotiations, despite saying that a "meet-

ing is being set up" with Iranian officials. He added that Iranian leaders "want to negotiate", because "they are tired of being beat up by the United States". A US official told the BBC's US news partner CBS that Trump has been briefed on options for military strikes on Iran. Other approaches could include boosting anti-government sources online, using cyber-weapons against Iran's military, or imposing more sanctions,

officials told the Wall Street Journal. Sources told the BBC that protests continued on Sunday night, but at a reduced level compared to previous days, as fears grow of an escalating crackdown by the Iranian government. At least 10,600 people have been detained over the fortnight of unrest, according to HRANA. The BBC counted 180 body bags in footage from a morgue near the Iranian capital, with one source saying on Sunday

that the streets of Tehran were "full of blood". "They're taking away bodies in trucks," the source added. In one video from the site near Tehran, about 180 shrouded or wrapped figures can be seen, the majority lying out in the open. Shouts and cries of distress can be heard from people who appear to be looking for their loved ones. Footage has been blurred to protect the identities of the living, who could face further persecution from the authorities. Sources said large numbers of bodies had accumulated at hospitals and forensic facilities, while some bodies were reportedly buried urgently before dawn by the authorities, limiting the chance for identification. City workers have also removed debris, burned cars and bloodstains from the streets during the night, a source told the BBC. Multiple sources in Iran also said that they had seen

drones flying persistently over crowds and residential neighbourhoods to identify and track protesters. The BBC and most other international news organisations are unable to report from inside Iran, and the Iranian government has imposed an internet shutdown since Thursday, making obtaining and verifying information difficult. Some witnesses are relying on Starlink proxy connections or satellite television for information, but fear that these could be used by the authorities to trace them. "We cannot even send text messages," one source in southern Iran told the BBC, as a blanket internet outage continued. "Only the government is sending threatening messages to people." Trump said on Sunday that he would speak to Elon Musk, owner of company SpaceX which operates Starlink, about restoring internet access to Iran.

## HUNGARY GRANTS ASYLUM TO POLISH EX-JUSTICE MINISTER

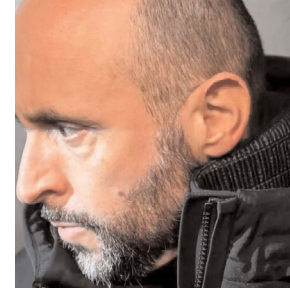


Hungary has granted political asylum to Poland's former Justice Minister Zbigniew Ziobro who is facing charges of embezzlement. Ziobro is facing 26 charges related to embezzling money from a fund meant to be spent on crime victims and rehabilitating criminals. Instead, he is accused of authorising the purchase of spyware that was allegedly used to hack political opponents' phones. He says he is a victim of political persecution. Granting asylum to a citizen of a fellow EU member state goes against the spirit of EU standards. But in the case of Hungary it is neither new nor surprising. Ziobro is the second politician of the former Justice and Law-led government to be granted this status - last year it was his former deputy Michal Romanowski who fled to Budapest to seek protection. Both are accused of corruption and misusing their power - most notably by using the money of the state-controlled Foundation for Justice

which was under their oversight in order to fund their party and its cronies. Ziobro was justice minister between 2015 and 2023 under the previous right-wing PiS-led government, which is politically aligned to Hungarian Prime Minister Viktor Orban. If found guilty he could face up to 25 years in prison. Writing on X, Ziobro said: "I have decided to accept the asylum granted to me by the government of Hungary due to the political persecution in Poland." "I have chosen to stand in opposition to a creeping dictatorship," Ziobro added, accusing Prime Minister Donald Tusk of waging a "vendetta" against him. Ziobro is accused of authorising a 25m zloty (\$7m; £5.15m) purchase from of Israeli-made Pegasus spyware, which Poland's current coalition government and a European Parliament investigative team found was used to secretly hack the phones of political opponents.

## CUSTODY EXTENDED FOR OWNER OF SWISS SKI BAR AFTER DEADLY FIRE

A judge in Switzerland has ordered that one of the two co-owners of the ski resort bar where 40 people died in a fire on New Year's Eve be kept in detention for 90 days. Swiss prosecutors have argued that Jacques Moretti, a French national, is a potential flight risk. He and his wife Jessica, who is also French, are suspected of manslaughter by negligence, bodily harm by negligence and arson by negligence. The blaze at Le Constellation bar in Crans-Montana also left 116 people injured. Many of the victims were aged under 20. The fire is believed to have been started by sparklers in champagne bottles raised too close to the ceiling during celebrations. Authorities



acknowledged last week that the bar in the popular ski resort had not undergone safety checks for five years. Jacques Moretti was first detained on Friday for an initial period of 48 hours. On Monday, a judge at what is known as a court of coercive measures ruled that he should be kept in custody for three months - a period that can be renewed under Swiss law.

## Referee and student among hundreds killed in Iran protests

A referee and a student are among hundreds of people reportedly killed during massive anti-government protests in Iran. Coach Amir Mohammad Koohkan, 26, was hit by live ammunition on 3 January during protests in the town of Neyriz, his friend told BBC Persian. "Everyone knew him for his kindness", they said, adding his family is grieving and "angry because he was killed by the regime". Five days later, student Rubina Aminian, 23, was shot from behind during a protest in Tehran, according to human rights groups. "She fought for things she knew were right", her uncle told CNN. Nearly 500 protesters and 48 security personnel have been killed in two weeks of



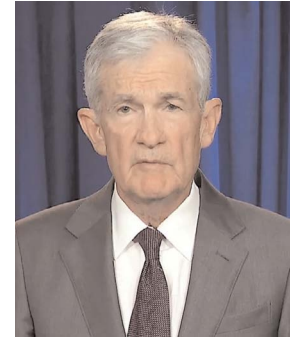
protests, a US-based rights group says. Sources in Iran have told the BBC the death toll is likely higher than reported. Demonstrations began on 28 December over the economy in the capital Tehran and have spread to 186 cities and all 31 provinces, according to the Human Rights Activist News Agency (HRANA). The

protests have grown into the largest in years, with calls for an end to the Islamic Republic and rule of Supreme Leader Ayatollah Ali Khamenei. The protests led to a government crackdown, with at least 10,600 people reportedly arrested and 496 protesters killed, according to HRANA. Medical staff in Iran have

described hospitals overwhelmed with dead and injured patients. BBC Persian verified that 70 bodies were brought to Poursina Hospital in Rasht city on 9 January, and the BBC counted 180 body bags in footage from one morgue near Tehran thought to have been filmed on the same night. The BBC and most other international news organisations are unable to report from inside Iran, and the Iranian government has imposed an internet shutdown since Thursday, making obtaining and verifying information difficult. Among the protest victims was Koohkan, who was killed in Neyriz in south-west Fars Province, his friend told BBC Persian.

## Fed chair Powell hits out at 'unprecedented' probe by US justice department

Federal prosecutors have opened a criminal investigation into Federal Reserve chair Jerome Powell, he said on Sunday. In a highly unusual move, Powell disclosed that the US Department of Justice (DoJ) served the agency with subpoenas and threatened a criminal indictment over testimony he gave to a Senate committee about renovations to Federal Reserve buildings. Calling the probe "unprecedented", Powell said he believed it was opened due to Donald Trump's anger over the Fed's refusal to cut interest rates despite repeated public pressure from the president. Trump said he did not "know anything" about



the investigation. The DoJ has been contacted for comment. Until now, the long-running feud between Trump and Powell has been largely one-sided with the US president calling the banker "Mr. Too Late" and a "numbskull". Powell's statement on Sunday is the first time he

has publicly and robustly pushed back against Trump as he warned that the independence of the US central bank is at stake. "This is about whether the Fed will be able to continue to set interest rates based on evidence and economic conditions, or whether instead monetary policy will be directed by political pressure or intimidation," Powell said. "I have deep respect for the rule of law and for accountability in our democracy. No one, certainly not the chair of the Federal Reserve is above the law, but this unprecedented action should be seen in the broader context of the administration's threats and

ongoing pressure," he went on to say. Trump said in an interview with NBC News on Sunday that he did not have any knowledge of the DoJ's investigation into the Fed. "I don't know anything about it, but he's certainly not very good at the Fed, and he's not very good at building buildings," he said of Powell. The Fed is undertaking the first renovation of two buildings, the Eccles and 1951 Constitution Avenue buildings, since their construction in the 1930s. The "overhaul and modernisation" of the buildings includes health and safety work such as the removal of asbestos and lead contamination.

## JAILED VENEZUELAN POLITICIAN'S SON SAYS TRUMP SHOULDN'T BE 'FOOLED' BY PLEDGE OF PRISONER RELEASES



The son of a jailed Venezuelan opposition leader has warned Donald Trump to "not be fooled" by the country's government, amid accusations it has not kept its promise to release a significant number of political prisoners. Ramón Guanipa, the son of Juan Pablo Guanipa, said he believed the US president was unaware that only about 40 releases out of more than 800 political prisoners had reportedly been confirmed so far. On Saturday, Trump thanked the Venezuelan authorities, saying they had "started the process, in a BIG WAY". The Venezuelan government announced on Thursday it would release detainees considered political prisoners by human rights groups as a "goodwill gesture". The move came after the US seized Venezuela's President Nicolás Maduro in a raid on the capital, Caracas, on 3 January, and took him to New York, where he has been charged with drug trafficking. Jorge Rodríguez, Venezuela's

National Assembly leader and the brother of Interim President Delcy Rodríguez, announced that an "important number of Venezuelan and foreign detainees" would be released "immediately". On Monday, the government said more than 100 such prisoners had already been released - a number far greater than the figure so far confirmed by human rights campaigners. Among those who are confirmed to have been released are several high-profile opposition figures - with Spain's foreign ministry confirming that five Spanish citizens had been freed, including human rights lawyer Rocío San Miguel. Trump claimed credit for the releases, writing on social media on Saturday: "I hope these prisoners will remember how lucky they got that the USA came along and did what had to be done." But relatives of those still behind bars have been expressing their frustration that only a small number of prisoners have been freed.

## Chalamet beats DiCaprio to Golden Globes glory

Timothée Chalamet was among the main winners as Hollywood's finest gathered for this year's Golden Globe Awards. Chalamet, 30, continued his pursuit of greatness, and an Oscar, by beating stars including Leonardo DiCaprio and George Clooney to the award for best actor in a musical or comedy for table tennis caper Marty Supreme. Despite DiCaprio missing out, his film One Battle After Another won the most awards overall, with four prizes including best musical or comedy film and best director. Irish actress Jessie Buckley was named best drama actress for Hamnet, which also scored a surprise win in the best drama film category. Vampire thriller Sinners had been considered the frontrunner, but it instead

went home with the box office achievement prize as well as best score. The Golden Globes are a key stop on the road to the Academy Awards, and other acting winners on Sunday included Teyana Taylor, Rose Byrne, Wagner Moura and Stellan Skarsgård. Unlike the Oscars, the Globes also reward TV shows, and the night saw British actors Stephen Graham, Owen Cooper and Erin Doherty pick up more honours for their performances in Netflix drama Adolescence. With all eyes on the Oscars race, Timothée Chalamet's victory has given him a boost over his rivals. "I'm in a category with many greats," he said when accepting his trophy. It was Chalamet's fifth Globes nomination, but his first win. "My dad



instilled in me a spirit of gratitude growing up, always be grateful for what you have," he said. "It's allowed me to leave this ceremony in the past empty handed, my head held high, grateful just to be here. But I'd be lying if I didn't say those moments make this moment that much sweeter. "For my parents, for my partner, I love you so much," he added, looking at girlfriend Kylie Jenner.

Jessie Buckley was named best actress for her role in the adaptation of Maggie O'Farrell's best-selling novel Hamnet, about the death of William Shakespeare's son. "This is not a normal feeling or situation to be in," she said in her acceptance speech. "It was such an extraordinary set to be part of, because we were telling the story of probably the most famous Brit that ever lived, and we had a

Chinese director, a lot of Irish, a mostly Polish crew, beside our British family." She concluded: "This is a real honour, I love being part of this industry." Shortly afterwards, Hamnet director Chloe Zhao looked visibly shocked when the movie was announced as the winner of best drama film. Accepting the prize, producer Steven Spielberg said he had "loved the book" by O'Farrell, but felt Zhao was "the only filmmaker on the face of the planet who could tell the story". Zhao said: "The village of Hamnet that made this film together. Some of them lost their loved ones while we were making this film, and some of them are still struggling, and I just wanted to say we're thinking of you, we're here because of you, we love you." Elsewhere, singer

and actress Teyana Taylor, whose career started when she choreographed a Beyoncé music video at the age of 15, cemented her Hollywood breakthrough by winning best supporting film actress for One Battle After Another. After tearfully thanking a list of people, she used her acceptance speech to send a message to "my brown sisters and little brown girls watching tonight". "Our light does not need permission to shine," she told them. "We belong in every room we walk into. Our voices matter and our dreams deserve space." Swedish actor Stellan Skarsgård, 74, won best supporting actor for Sentimental Value, and joked that he hadn't prepared a speech "because I thought that I was too old".



# "No Problem If Pakistan, UAE Host Bangladesh's T20 World Cup Matches": Top Government Official On Venue Row

Less than a month remains for the 2026 T20 World Cup to start, yet there is uncertainty over Bangladesh's four group-stage matches in India (three in Kolkata and one in Mumbai). Bangladesh does not want to play in India, citing a 'security threat' in the country. The tussle began after the release of Bangladesh pacer Mustafizur Rahman from IPL franchise Kolkata Knight Riders on the instructions of the BCCI for unspecified reasons. The Bangladesh Cricket Board (BCB) has asked the International Cricket Council (ICC) to shift its matches to Sri Lanka (the hosts of the tournament). In the meantime, a report in Geo Super claimed that the Pakistan Cricket Board (PCB) has now shown interest in hosting the Bangladesh games. Bangladesh government's



Sports Advisor Asif Nazrul, known for his hardline stance against India, has reacted to the report. He was responding to a question on whether the BCB would accept a proposal where Bangladesh matches are shifted from Kolkata and Mumbai to another Indian city. "We are talking about

India, we are not talking about Kolkata. If the venue is changed from India to Sri Lanka, there is no issue. I saw a report, which I don't know is true or not, that claimed Pakistan has offered to host our matches. No problem if Pakistan or UAE host our matches," Nazrul said on Wednesday. Nazrul also

claimed that the Bangladesh Cricket Board (BCB) has received a letter from the ICC's security team. Following is what Nazrul said in a press conference on Monday: "We are yet to receive any reply to the two letters sent to ICC. Also, in the meantime, the ICC security team, those in charge of

security, have given a letter to the BCB. In that letter, it is said that if three things happen, the security threat to the Bangladesh team will increase: If Mustafiz is included in the Bangladesh team. If the supporters of the Bangladesh team roam around wearing the national jersey of Bangladesh, which is our national jersey. As the national elections are forthcoming, the security threat to the Bangladesh team will increase." This statement by the ICC security team has proven that Bangladesh is in no position to play the T20 World Cup in India." The ICC is yet to confirm or deny the existence of the letter from its security team. According to sources, this letter was part of an inter-departmental note, and not ICC's official response to BCB over its request to relocate its T20 World Cup matches from India.

# Afghanistan's Mohammad Nabi Blasts Reporter Over Mustafizur Rahman-KKR IPL Controversy

Former Afghanistan captain Mohammad Nabi lashed out at a reporter over a question surrounding the Indian Premier League (IPL) controversy involving Bangladesh pacer Mustafizur Rahman and the Kolkata Knight Riders (KKR). KKR released Mustafizur from their squad for IPL 2026 following directives from the Board of Control for Cricket in India (BCCI). While a lot has been said and written about KKR and Mustafizur, a Bangladeshi reporter, during a press conference, asked Nabi about the controversy. Nabi, who is currently playing for Noakhali Express in the Bangladesh Premier League (BPL), lost his cool at the journalist, saying that he has nothing to do with the controversy.



"Iska merese kya lena dena bhai. Mera Mustafizur se kya kaam hai? Politics me kya kaam hai mera? (What do I have to do with it? How am I related to Mustafizur? I don't have anything to do with politics)," Nabi responded. The veteran all-rounder insisted that he shouldn't have been asked about the controversy

in the first place. "I know he is a good bowler, all these things. But the way you are questioning, it's not related to me," he added. The 30-year-old drew significant attention after KKR acquired him for a record Rs 9.20 crore at the December mini-auction, making him the highest-paid Bangladeshi cricketer in IPL

history. He was purchased from a starting bid of Rs 2 crore amid a fierce bidding war between the Chennai Super Kings and the Delhi Capitals. The decision to release Mustafizur was made following reports of violence against members of the Hindu community in Bangladesh in December. Additionally, critics had voiced their disapproval of Rahman's involvement in the IPL. The 30-year-old player has claimed 65 wickets over 60 matches, maintaining an economy rate of 8.13 since his IPL debut with Sunrisers Hyderabad in 2016. He has represented several franchises: Mumbai Indians in 2018, Rajasthan Royals in 2021, Delhi Capitals during 2022-23, and Chennai Super Kings in 2024.

# Shubman Gill Told To Follow Virat Kohli's 'Single-Mindedness' By Ravi Shastri: 'It Is A Routine'

Indian cricket's next generation is being reminded that talent alone isn't enough to reach the top; discipline and obsession matter just as much. Ahead of India's ongoing ODI series against New Zealand, former India head coach Ravi Shastri highlighted the unparalleled work ethic of Virat Kohli, saying that young captain Shubman Gill should chase that same drive to take his own game to the next level. Shastri said Kohli's excellence stems not just from talent, but from a daily routine of hard work, discipline, and an unyielding focus on the "little things" that often go unseen—the kind of habits that build champions over time. Shastri made these remarks during commentary on the first ODI between India and New Zealand in Vadodara, where Gill and Kohli batted together early in the innings. He didn't dwell on technique or batting mechanics; instead, he talked about Kohli's obsession with cricket, pointing out how the veteran goes



above and beyond in training, fielding drills, and fitness work, day after day. That kind of "single-minded hunger," Shastri said, sets a standard that rising stars like Gill can learn from as leadership responsibilities grow. "The single-

mindedness, the hunger. The willingness to push that body to the limits. And I have seen that in my time when I was with the team, his work ethics probably second to none. I have seen just the way he goes about his job.

# CARRICK FAVOURITE FOR MAN UTD CARETAKER ROLE



Michael Carrick has emerged as favourite to be appointed Manchester United caretaker head coach, according to sources close to the process. Club chiefs are hoping to have an appointment in place for when players return to training on Wednesday. While a final decision is yet to be reached, talks are said to have progressed with the 44-year-old over the position. Carrick previously had a three-game stint as United's temporary boss following Ole Gunnar Solskjaer's dismissal in 2021. He won two and drew one of those matches but left after Ralf Rangnick's arrival as interim manager. Solskjaer held face-to-face discussions with the club on Saturday about a return. United sacked Ruben Amorim as manager after 14 months in the job on 5 January. Darren Fletcher, a former United and Scotland midfielder, was initially handed temporary responsibility for first-team affairs following Amorim's departure. United suffered an FA Cup

third-round defeat at the hands of Brighton on Sunday in what looks set to be Fletcher's second and final game in charge. He led the side to a draw at struggling Burnley in the Premier League last Wednesday. Former England midfielder Carrick played 464 games in all competitions for United between 2006 and 2018, having been signed from Tottenham by Sir Alex Ferguson. He has been out of work since he was sacked by Championship club Middlesbrough last June after two and a half years in charge. Carrick guided Boro to the Championship play-offs in the 2022-23 campaign, only for them to lose to Coventry in the semi-finals. His side then narrowly missed out on the top six in successive campaigns, resulting in Carrick losing his job. Wallsend-born Carrick does not boast the same managerial experience as Solskjaer, given he has had only one permanent role with Middlesbrough

# Washington Sundar Ruled Out Of New Zealand ODIs Due To Injury. This Star Receives Maiden Call-Up

Indian cricket team all-rounder Washington Sundar was ruled out of the ongoing ODI series against New Zealand due to injury, BCCI confirmed on Monday. Sundar reported an acute onset discomfort in his left lower rib area while bowling during the first ODI at the BCA Stadium, Vadodara, on Sunday. The BCCI said that he will undergo further scans, following which the BCCI Medical Team will seek expert opinion. Ayush Badoni received his maiden call-up as he was named replacement for the all-rounder. The BCCI said that Badoni will link up with the squad in Rajkot ahead of the second ODI encounter on Wednesday. India registered a four-wicket win after successfully chasing



down a target of 301 in 49 overs against New Zealand in Vadodara on Sunday, with captain Shubman Gill and Virat Kohli playing pivotal roles in the run chase. Gill led from the front with a composed 56 off 71 balls, which included three fours and two sixes, anchoring the innings at the top. He found solid support in Kohli, who was the stand-

out performer of the chase, scoring a fluent 93 off 91 deliveries to steer India close to the target. Reflecting on the win, Gill emphasised the importance of contributing during a chase and staying mentally grounded. "Always feels great to chip, especially when you're chasing. Staying in the present is most important, esp for ath-

letes. That's what I try to do," Gill said after the match, as quoted from ESPNcricinfo. The India skipper was full of praise for Kohli, acknowledging the difficulty of batting on the surface. "At the moment, Kohli's making batting look easy, it's tough to start on these pitches. Tough to replicate what he does. Hope he keeps piling on runs," he added. Gill also spoke about the team's bowling combinations and the decision-making around squad rotation, given the limited number of ODIs. "Arshdeep did well last series, (Mohammed) Siraj wasn't there, we want to keep rotating as there aren't that many ODIs," he said, explaining the rationale behind giving opportunities to different players.

# BCB Breaks Silence On Bangladeshi Umpire Officiating During 1st India vs New Zealand ODI

A Bangladesh Cricket Board (BCB) official stated that umpire Sharfuddoula Ibne Shahid Saikat did not need a No Objection Certificate (NOC) from the board to officiate in the first ODI between India and New Zealand in Vadodara on Sunday. Saikat's involvement in the match comes as the BCB has requested the International Cricket Council (ICC) to shift its T20 World Cup 2026 matches out of India, citing "security concerns." While the BCB remains steadfast in its stance regarding the T20 World Cup, Umpire Department Chairman Iftekhhar Rahman clarified that whenever he has an ICC assignment, he is automatically on leave from his duties with us. I don't need to issue any NOC. The contract states that if he has any ICC engagement, he must be automatically released. I have no authority to decide whether to



contracted umpire, the BCB has no authority to prevent him from officiating matches in India. "He (Saikat) is an ICC-contracted umpire, and we are stating clearly that he is not contracted with us (BCB)," Iftekhhar told Cricbuzz. "Our contract stipulates

BCB President Aminul Islam Bulbul confirmed that the board has yet to receive a response from the ICC regarding its concerns about playing in India. He reiterated that the BCB's position remains

How should the PGA Tour react to Brooks Koepka's application to rejoin its lucrative and prestigious circuit of tournaments? Within days of leaving the breakaway LIV Golf League, the five-time major champion signalled his intention to switch back to the leading establishment tour by reapplying for membership on 9 January. Koepka, 35, left LIV one year early, wanting to spend more time with his family. But the Floridian, who remains eligible for all four majors courtesy of his 2023 US PGA Championship victory, is clearly keen to rejoin the tour he dramatically left four years ago. And for the PGA Tour this provides a huge dilemma. 'Get Koepka back ASAP' Koepka is the past decade's most prolific winner of men's majors and an attractive draw for sponsors, television and fans alike. Such appeal brought a gargantuan signing on fee from the Saudi Arabia-backed LIV organisation

and his 2022 departure was a hammer blow for the PGA Tour. Of course they would love to have him back and readmitting Koepka would help the established order administer a painful retaliatory jab that could set up a potential knockout blow to the disrupting upstarts. By welcoming back someone with two US Opens and three US PGAs to his name, the PGA Tour might provide an encouraging return path for other stars such as Bryson DeChambeau and Jon Rahm when they near the end of their LIV contracts. "Does it make sense if Brooks wanted to play the PGA Tour again to get him back as soon as possible? Absolutely," Masters champion Rory McIlroy recently told the Palm Beach Post. "What Brooks has done in the game of golf, it would be good for everyone to have him back." But McIlroy added: "You can't treat one person differently from how you treat others."
