Faridabad gang-rape: Accused threatened to kill victim before dumping her on road



Faridabad (TSIT) A day after a 25-year-old woman was reportedly gang-raped in a moving van through the night and thrown out of the speeding vehicle, chilling details have surfaced pointing at the brutality of the two alleged perpetrators. According to the victim's family members, when the woman, a mother of three, screamed for help, the accused allegedly threatened to kill her before taking turns to rape her. According to officials at a private hospital where the woman was admitted on Wednesday, her condition remains stable on Thursday. "The victim, whose condition is stable now, is undergoing treatment at the hospital," Dr Amit Yadav, director of the private hospital, said.

One dead, 15 fall ill after New Year party in Hyderabad

Hyderabad, (TSIT) : New Year celebrations turned tragic in Hyderabad after a person died and 15 others were taken ill after a late-night party. The incident occurred in Bhavani Nagar under Jagadgirigutta Police Station of Cyberabad Police Commissionerate in Medchal Malkajgiri district. A group of 17 friends celebrated the New Year with a party at Bhavani Nagar Welfare Association, where they ate Biryani and consumed liquor. On returning home past midnight, they took ill. One of them succumbed before he could be taken to the hospital. He was identified as Pandu (53). Fifteen people have been admitted to Narayana Malla Reddy Hospital. Food poisoning is suspected to have led to the tragedy. Police registered a case and took up an investigation.

Tgana formed to protect water rights: CM Revanth



Hyderabad (TSIT): Chief Minister A. Revanth Reddy on Wednesday asserted that the Telangana government is firmly committed to safeguarding the State's rightful share of river waters and correcting historical injustices. Speaking at Praja Bhavan, the Chief Minister said Telangana was formed primarily for water rights and accused previous regimes of compromising the State's interests. He alleged that after State formation, agreements signed during the BRS regime allotted only 299 TMC of Krishna waters to Telangana, while Andhra Pradesh

received 511 TMC, giving it permanent rights. Revanth Reddy said Telangana deserves 79 percent share based on catchment area and is demanding 555 TMC. He accused the previous government of inflating project costs in Palamuru-Rangareddy by changing the water source, leading to massive financial losses. Stating that inquiries would be ordered into past decisions, he said the government is now seeking approvals for 45 TMC to secure Central funds. He praised Irrigation Minister N. Uttam Kumar Reddy for his dedicated efforts in defending Telangana's water rights.

2,731 drunk driving cases booked in Greater Hyderabad



Hyderabad (TSIT): As many as 2,731 people were caught driving vehicles under the influence of alcohol during New Year celebrations in three police commissionerates covering Greater Hyderabad. In the special drive undertaken by police on the intervening night of December 31 and January 1, a total of 1,198 drunk drive cases were booked in Hyderabad commissionerate limits. Police in Cyberabad booked 928 cases while 605 motorists were caught in Rachakonda commissionerate. The Hyderabad traffic police conducted a special enforcement drive

against drunken driving from 7 p.m. to 3 a.m. to ensure road safety and prevent road accidents. The primary objective of this special drive was to ensure that commuters reach their destinations safely, to deter drunken driving, and to minimize the risk of fatal and non-fatal road accidents during the New Year celebrations. Hyderabad Joint Commissioner of Police (Traffic) R. Venkateshwarlu said that the Hyderabad traffic police aimed to welcome the New Year without a single accident, thereby enabling citizens to celebrate responsibly and safely.

KTR seeks opportunity for BRS to make PPT presentation in Telangana Assembly

Hyderabad, Jan 1 (TSIT) : Bharat Rashtira Samithi (BRS) working president K.T. Rama Rao on Thursday demanded that if the Telangana government proposes to make a PowerPoint presentation in the Legislative Assembly, the principal Opposition party, the BRS, must also be given the same opportunity in the spirit of parliamentary democracy.

Speaking to the media at Telangana Bhavan, KTR said that once members enter the Assembly, there is no distinction between the Chief Minister and an ordinary legislator. "All 120 MLAs enjoy equal rights on the floor of the House. If the government presents its version, the Opposition must also be allowed to present its facts," he said. The Telangana government is likely to make a PowerPoint presentation in the Assembly on Friday on irrigation projects and river water-sharing issues. "You present your version and allow us to present ours. As the principal Opposition, we are fully prepared to explain how



Telangana's agriculture and irrigation were transformed over the last ten years under BRS governance," said KTR, as the BRS leader is popularly known. KTR asserted that the BRS is fully prepared to place facts and data before the Assembly. Recalling an earlier instance, KTR said that when former Chief Minister K. Chandrasekhar Rao made a PowerPoint presentation in the Assembly on March 31, 2016, the Congress party had boycotted the House, calling it a violation of parliamentary traditions. "What was unacceptable then—how has it suddenly become acceptable now?" he asked. He said that a letter has been submitted to the Speaker seeking fairness and equal opportunity for the Opposition in the

matter. Launching a sharp attack on the Congress government, KTR questioned the Chief Minister's understanding of irrigation and river water issues. He alleged that the Chief Minister had publicly claimed that the Bhakra Nangal Project was located in Telangana, whereas it is actually located in Himachal Pradesh. "A Chief Minister who does not even know basic river basins wants to lecture us on irrigation?" KTR asked, adding that the Chief Minister was also unaware of the river basin to which the Devadula project belongs. KTR highlighted what he described as the government's failures in the irrigation sector, referring to the collapse of the Srisailem Left Bank Canal tunnel that claimed eight lives, the collapse of the Sunkishala project, and the submergence of the Vattam pump house. "What should we learn from you—how to make check dams fail, how Medigadda collapsed, or how Telangana's rightful share in Krishna waters was handed over to the Krishna River Management Board (KRMB)?" he asked.

Dozens feared dead, about 100 hurt in Swiss Alps bar blaze

Crans-Montana, Switzerland (TSIT) A New Year's party at the Le Constellation bar turned into tragedy when fire tore through the packed venue less than two hours after midnight. Police say "several tens" of revellers are presumed dead and around 100 injured, many critically. Rescue helicopters and ambulances ferried victims to hospitals across Valais canton, whose intensive-care unit and operating theatre quickly reached capacity. Witnesses told French TV that a barmaid holding a lit candle in a bottle accidentally ignited the wooden ceiling; flames spread within seconds, collapsing the roof and trapping partygoers in a basement nightclub. Survivors described

smashing windows and surging up a narrow stairwell to escape; parents arrived in panic searching for children. Investigators have not yet entered the charred building and say it is too early to name a cause, but they rule out foul play. Officials believe combustible gases produced a sudden flash-over. Identifying the dead, including foreign visitors, "will take time," said cantonal police commander Frederic Gisler. Crans-Montana, a leading ski and golf resort set to host World Cup races next month, is less than 5 km from the 2012 Sierre bus-crash tunnel that killed 28. Authorities now urge locals to avoid further strain on overwhelmed medical services.

India & Pak exchange lists of prisoners, nuclear installations

New Delhi, Jan 1 (TSIT): India on Thursday called for early release and repatriation of civil prisoners, fishermen along with their boats, and missing Indian defence personnel from Pakistan's custody. As both countries exchanged - through diplomatic channels simultaneously at New Delhi and Islamabad - the lists of civilian prisoners and fishermen in each other's custody, the Ministry of External Affairs (MEA) stated that Pakistan has been asked to expedite the release and repatriation

tion of 167 Indian fishermen and civil prisoners, who have completed their sentence. "India has shared lists with details of 391 civil prisoners and 33 fishermen in its custody, who are Pakistani or believed to be Pakistani. Similarly, Pakistan has shared lists with details of 58 civil prisoners and 199 fishermen in its custody, who are Indian or believed to be Indian," read a statement issued by the MEA. "The Government of India has called for early



release and repatriation of civil prisoners, fishermen along with their boats, and missing Indian defence personnel from Pakistan's custody.

Pakistan has also been urged to expedite the release and repatriation of 167 Indian fishermen and civil prisoners, who have completed their sen-

tence. In addition, Pakistan has been asked to provide immediate consular access to 35 civil prisoners and fishermen in Pakistan's custody, who are believed to be Indian and have not been provided consular access so far," it added. Under the provisions of the bilateral Agreement on Consular Access 2008, such lists are exchanged every year on January 1 and on July 1. New Delhi asserted that it has asked the government of Pakistan to ensure the safety, security

ty and welfare of all Indian and believed-to-be-Indian civil prisoners and fishermen, pending their release and repatriation to India. "As a result of the sustained efforts by the Government of India, 2,661 Indian fishermen and 71 Indian civil prisoners have been repatriated from Pakistan since 2014. This includes 500 Indian fishermen and 13 Indian civilian prisoners who have been repatriated from Pakistan since 2023 till date," the MEA statement mentioned.



## Telangana student dies in fire accident in Germany



Hyderabad: A student from Telangana died in a fire incident in Germany's Magdeburg on Wednesday, December 31. The deceased was identified as Thokala Hrithin Reddy, a resident of Malkapur village in Chilpur mandal of Jangaon district. After completing his bachelor's degree in Telangana, Hrithin Reddy had gone to Germany to pursue higher education in 2023. He was pursuing his master's degree at the University of

Europe for Applied Sciences in Magdeburg. According to reports, a fire broke out in the apartment he was staying in. In an attempt to escape the flames, he reportedly jumped from the building and suffered severe head injuries. Despite medical efforts, his condition deteriorated and he succumbed to his injuries. Further details regarding the cause of the fire and the exact circumstances of the incident are awaited.

## Harish Rao slams Telangana govt over pending 'Mana Ooru Mana Badi' bills

Hyderabad: Senior BRS leader and former minister T Harish Rao has sharply criticized the Telangana government for failing to clear pending bills of contractors working under the 'Mana Ooru - Mana Badi' programme, accusing the Congress-led regime of negligence and endangering the financial survival of small contractors across the state. On Wednesday, December 31, a delegation of 'Mana Ooru - Mana Badi' contractors met Harish Rao at his Hyderabad residence, where they detailed their worsening financial crisis.

The contractors alleged that they had taken loans to complete school infrastructure works in government schools, but since the Congress government assumed office, their bills have remained stuck without payment, pushing many into severe debt and hard-



ship. Contractors in financial distress The contractors told Harish Rao that they had executed development works in government schools across Telangana under the 'Mana Ooru - Mana Badi' scheme, but the state government has not released their dues

for months. They claimed that, despite submitting all bills and documents, the administration has delayed payments, forcing them to borrow more money and pay heavy interest, while their families struggle to meet basic expenses. They specifically complained that, while big contractors

and large firms have seen their dues cleared, small and medium contractors working on school projects are being ignored, creating a sense of discrimination and injustice in the system. Harish Rao's strong criticism Addressing the contractors, Harish Rao condemned the Congress government's handling of the issue. He said that the 'Mana Ooru - Mana Badi' programme was launched with the vision of improving government schools and providing quality education to poor and middle-class children, but the current chief minister A Revanth Reddy, was now "diluting that very goal." Harish Rao pointed out that Revanth Reddy holds the portfolio of Education Minister in addition to being chief minister, yet shows "not even a trace of concern" for the education sector.

## Election Commission interacts with Jana Sena delegation on electoral reforms

Amaravati, Jan 1 : The Election Commission of India (ECI) on Thursday interacted with a delegation of the Jana Sena Party to seek its suggestions on electoral reforms. Chief Election Commissioner Gyanesh Kumar and Election Commissioners Dr. Sukhbir Singh Sandhu and Dr. Vivek Joshi held discussions with the Jana Sena delegation at Nirvachan Sadan in New Delhi. The Jana Sena Party delegation comprised its representatives E. Pratap Kumar and R.M.V. Sumanth. However, the party has not issued any statement detailing the suggestions it submitted to the ECI during the interaction. The Jana Sena Party (JSP), headed by Andhra Pradesh Deputy Chief Minister Pawan Kalyan, is a constituent of the Telugu Desam Party-led ruling coalition in the state. The Election Commission has been holding meetings with leaders and representatives of recognised political parties as part of its efforts to further strengthen electoral processes within the existing legal framework. The Commission has invited suggestions from all national and state political parties. It was in March 2025



that the Commission had envisaged interactions with party presidents and senior leaders, at mutually convenient times, to discuss measures to strengthen electoral processes in accordance with established law. The ECI has also urged political parties to proactively utilise the mechanism of decentralised engagement with election authorities. In July, the Commission had interacted with a delegation from the Telugu Desam Party (TDP), during which the party suggested strengthening electoral roll verification through annual third-party audits conducted under the Comptroller and Auditor General (CAG) of India to identify anomalies. The TDP delegation had also urged the ECI to initiate the Special Intensive Revision (SIR) process in Andhra Pradesh at an early stage and advocated that deletion of any voter name should be based on a reasoned order, proper notice and an opportunity for the elector to respond.

# From Warangal Nets to HCA Spotlight: The Rise of All-Rounder Rishyanth Panthagani

At just 19, Rishyanth Panthagani has already begun carving a name for himself in Hyderabad Cricket Association (HCA) competitions, emerging as a dependable batting all-rounder for Warangal district. A right-hand batsman and right-arm leg spinner, Rishyanth's journey reflects a blend of early passion, disciplined training, and an unwavering commitment to the game. **EARLY BEGINNINGS :** Rishyanth's interest in cricket took root in early childhood, inspired by watching his elder brother play. A defining moment came on his fifth birthday, when his uncle gifted him a cricket bat — a gesture that unknowingly set him on a serious sporting path. He began attending summer coaching camps in Warangal alongside his brother, where his natural aptitude for the game quickly became evident. Training and Development : After completing school, Rishyanth moved to Hyderabad and joined Phoenix Cricket Academy, an academy suggested by coach Chakravarthy, who had earlier guided inter-

national cricketers such as Ambati Rayudu during their formative years. There, Rishyanth sharpened his technical skills and gained valuable exposure to competitive cricket. Following his intermediate education, he returned to Warangal and enrolled at Sri Venkateshwara Cricket Academy, Gopalpur, where coach Vishnudas Shashank Kashyap played a pivotal role in refining his all-round abilities. Their guidance helped him earn selection to the Warangal district team, representing the side across various HCA tournaments. **IMPACT IN HCA CRICKET :** Rishyanth made his HCA two-day debut last year, and his impact has been immediate and impressive. In a short span, he has registered four five-wicket hauls, underlining his effectiveness with the ball, while also showcasing his batting prowess with a brilliant century and three half-centuries in HCA competitions. In the HCA B-Division T20 League, Rishyanth finished as the third-highest wicket-taker, reinforcing his reputation as a



reliable match-winner in the shortest format. **KAKA VENKATASWAMY MEMORIAL TOURNAMENT & STATE-LEVEL RECOGNITION :** His performances in the Kaka Venkataswamy Memorial Tournament further highlighted his growing stature. Rishyanth scored 157 runs in four matches, including two vital half-centuries, picked up crucial wickets, and was named Man of the Match against

Mahabubabad. In recognition of his consistent performances, Rishyanth has also been selected to play at the state level in the Kaka Venkataswamy Memorial T20 League, which is scheduled to be held from January across various districts in Telangana. **UNIVERSITY CRICKET AND CAREER CHOICES :** Beyond district cricket, Rishyanth has delivered on big occasions at the university level as well. During his first year of engineering, he played a decisive role in helping SR University win the Vaagdevi Inter-University T20 Trophy, almost single-handedly steering the team to the title. Following that season, Rishyanth made the bold decision to step away from engineering despite securing admission through EAMCET, choosing instead to pursue a B.Com at Masterji Degree College, Hanamkonda, allowing him to focus fully on cricket. **ACADEMICS, PERSONALITY, AND INSPIRATIONS :** Off the field, Rishyanth is equally accomplished academically, having scored 95

percent in both Class X and Intermediate examinations. Known for his calm and composed presence on the field, he is a strategic thinker who thrives under pressure and is always eager to make decisive contributions for his team. # Telangana cracks whip as Medaram revamp races to finish line before Jatra 2026

Deep in the woods of Mulugu district, Medaram is being given a new lease of life. Ahead of the four-day Sammakka-Saralamma Maha Jatra beginning 28 January, 2026, the sacred site is undergoing a 251-crore makeover—one that seeks to put an end to patchwork fixes and build something meant to stand the test of time. Minister for Women & Child Welfare and Panchayat Raj Danasari Anasuya (Seethakka) has called the effort a "milestone in history." For the first time, a tribal festival site of such scale is being comprehensively documented, reconstructed and presented without cutting corners or diluting tradition. With the government cracking the whip, work is moving at a brisk pace. "The CM reviews progress every day," Seethakka said, adding that ministers are also keeping a hawk eye on timelines and quality. At the heart of the revamp are the sacred vanadevata platforms, now nearing completion with a dedicated outlay of 101 crore. Designed to be both functional and faithful to custom, these platforms are meant to become the

nerve centre of the Jataara, improving darshan while respecting age-old practices. What truly steals the show, however, is the artistic ambition. Nearly 4,000 tonnes of granite are being shaped into around 7,000 sculptures inspired by 930-year-old Koya palm-leaf manuscripts. From tribal history and folklore to the lineage of Sammakka's clan, the carvings turn Medaram into a living, open-air museum. The main entrance arch alone carries 59 sculptural panels, while the names of 750 Koya clans are etched across the complex—quite literally setting history in stone. More than 250 sculptors, led by Dr Hariprasad and supported by architects Eamani Shivanagi Reddy and Dr Motilal, are bringing this vision to life. Adding academic weight to the exercise, students from the Sammakka-Saralamma Archaeology Research Institute have chipped in with designs rooted in research rather than guesswork. The rebuilt Gaddela Pranganam spans 271 square metres and resembles a stone-fortified monument, complete with 46 pillars and eight imposing arches—three



stretching 40 feet wide and five at 30 feet. A 50-foot archway faces the deity platforms, while circular gaddelas ringed by stone pillars and bamboo elements echo the rhythms of tribal forest life. Nature, too, has not been left by the wayside. Existing trees have been preserved, and 12 culturally significant species—such as banyan, neem and mahua—along with 140 medicinal plants are being added. According to Seethakka, the structures are built to last 200 to 250 years, without sacrificing quality or

cultural authenticity. This marks a clean break from the past. For decades, the Medaram Jatra relied on temporary arrangements that were assembled and dismantled every two years, burning a hole in the exchequer and leaving devotees to bear the brunt. Makeshift platforms buckled under pressure, pathways clogged, sanitation lagged behind, and safety fears—especially the threat of stampedes—hung like a dark cloud. History of poor planning Darshan was often a trial

by fire. Poorly planned layouts led to serpentine queues, pushing and jostling, while the absence of permanent paths worsened crowding during peak hours. Environmental damage followed unchecked footfall, and the rich Koya heritage remained largely invisible, lost amid logistical chaos. Health facilities, water supply and waste management were frequently stretched thin, forcing reliance on traditional stopgaps such as turmeric for its medicinal value. This time, the government

claims to have put in serious effort. Deity platforms are being aligned in a single-line formation to streamline darshan without breaking with tradition. Better access, improved flow and permanent infrastructure are expected to ease the burden on devotees travelling from Telangana and neighbouring states. That said, no project is without loose ends. Details on climate resilience—such as flood-proofing in a forested zone—remain sketchy. Accessibility for differently abled devotees and the use of digital tools for crowd management or virtual outreach are areas yet to be fully addressed. Still, as Seethakka put it, this is "not just infrastructure creation, but history being chiselled in stone." The government, seems to be learning from past mistakes. It is replacing temporary fixes with enduring, culturally rooted solutions. Seethakka said: "Medaram is being prepared not just for the next Jatra, but for several generations to come." In October 2025, teams of Telangana police fanned out across parts of Cyberabad for one whole week, conducting raids each night. By the end of the opera-

tion, they apprehended 10 sex workers and one transgender person, and rescued one victim. The raids were a part of the Cyberabad Anti-Human Trafficking Unit's enforcement, according to a press note by the Women and Children Safety Wing. Alongside the arrests, SHE teams — a division of Telangana Police for enhanced safety and security of women — carried out decoy operations in public spaces. They arrested men misbehaving with women. The raid marked not an isolated action, but a part of the commissionerate's enforcement. # Centre Approves Major Greenfield Corridor Connecting Maharashtra to Chennai via Kurnool and Kadapa

In a significant boost to national infrastructure, the Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has approved the construction of a 6-lane Greenfield corridor between Nashik, Solapur, and Akkalkot in Maharashtra. The project, estimated to cost 19,142 crore, will serve as a vital link connecting to Chennai via Kurnool and Kadapa in Andhra Pradesh.

Spanning 374 kilometers, this access-controlled highway is designed to strengthen connectivity between the western and eastern coasts. The government estimates



that the project will reduce the travel distance between Surat and Chennai by 201 kilometers, bringing travel time down drastically from 31 hours to just 17 hours.

Briefing the media after the Cabinet meeting, Union Minister Ashwini Vaishnaw provided details on the route alignment. "Today, the Nashik-Solapur corridor has been approved. It extends from Akkalkot to Chennai via Kurnool and Kadapa," the Minister stated.

Developing under the

PM Gati Shakti National Master Plan, the corridor will be executed through the Build-Operate-Transfer (BOT) toll model. Authorities expect the project to generate significant employment, creating approximately 251 lakh direct and 313 lakh indirect person-days of work. In the same session, the Cabinet also cleared the widening of National Highway-326 (Mohana-Koraput section) in Odisha. Sanctioned at a cost of Rs.1,526.21 crore, this project aims to improve connectivity across tribal districts including Gajapati, Rayagada, and Koraput, reducing travel time in the region by nearly three hours.

## Prof Anji Reddy assumes charge as Principal of UCA&SS of MG University

# Amaravati revival, big investment and road to trillion-dollar economy

Amaravati, Jan 1 : The re-launch of Amaravati capital development works, Google's announcement to set up a \$15 billion AI data centre in Visakhapatnam, and agreements for major investments across sectors were among the key developments in Andhra Pradesh in the year 2025.

The highlight was the resumption of state capital works, as promised by the Telugu Desam Party (TDP)-led coalition during the elections held in 2024. With the support of the BJP-led government at the Centre, Chief Minister N. Chandrababu Naidu restarted work on his dream project.

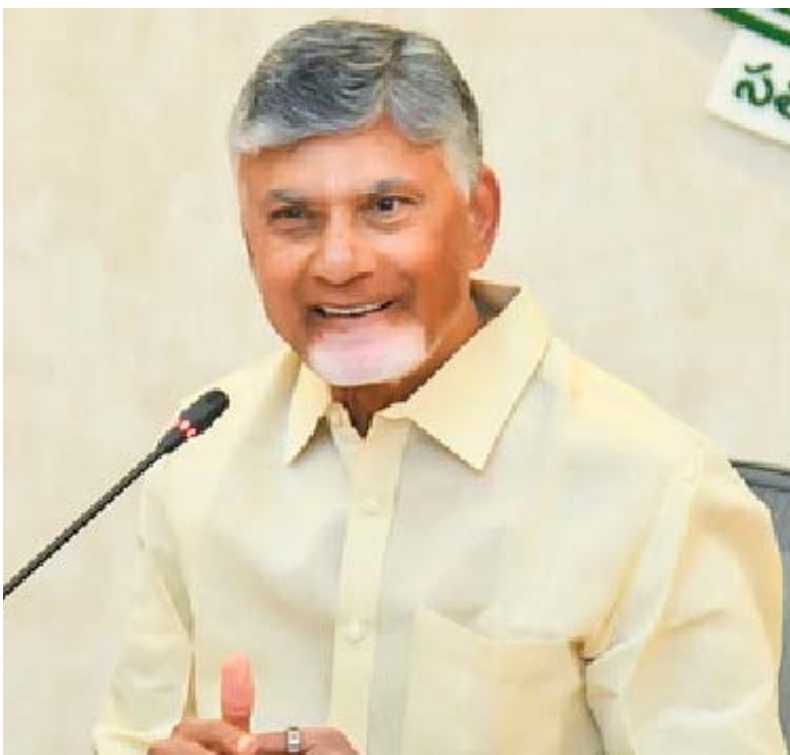
On May 2, 2025, Prime Minister Narendra Modi re-launched the Amaravati development works, nearly 10 years after laying the foundation stone for the new capital of Andhra Pradesh. The state government restarted work on projects worth Rs 56,000 crore, including the High Court, Legislative Assembly, State Secretariat, and four towers housing Heads of Departments (HoDs).

Chief Minister Naidu is confident that the works will be completed by March 2028.

The year also saw the launch of the second phase of land pooling in Amaravati. Under this phase, 16,666 acres of land will be acquired across seven mandals in the Amaravati capital region. According to Naidu, the existing 29-village footprint is inadequate to build a metropolitan entity comparable to Hyderabad.

In October, he inaugurated the Andhra Pradesh Capital Region Development Authority (APCRDA) office, marking a significant milestone in the capital's development. The state-of-the-art seven-storey structure, spread over a built-up area of 28,562 square metres, has been constructed in the upcoming administrative core of Amaravati. In November last year, CM Naidu, along with Union Finance Minister Nirmala Sitharaman, laid the foundation stone for the regional headquarters of 15 public sector banks and insurance companies in Amaravati.

The government also announced



ambitious plans to develop Amaravati as a Quantum Valley, on the lines of Silicon Valley in the United States. Naidu expressed confidence that Andhra Pradesh would lead the quantum revolution in India.

"Within six months, the first quantum computer will be operated from Amaravati and within two years, quantum computers will be manufactured here and supplied to the world," he said in a recent event. Google's announcement to set up its largest data centre in Visakhapatnam came as a major boost to the state. Andhra Pradesh IT Minister Nara Lokesh believes this development will transform Visakhapatnam in the same way Microsoft's facility transformed Hyderabad.

It is estimated that Google's \$15 billion investment over five years would generate employment for 1.88 lakh people, create a Rs 48,000-crore impact on the local economy during the period, and have a 25-times multiplier effect.

The state government claims to have attracted investments worth \$120 billion (Rs 10 lakh crore) over the last 16 months. During the

recently held CII Summit in Visakhapatnam, the government entered into 610 memoranda of understanding (MoUs) involving investments of Rs 13.25 lakh crore, expected to generate 16.13 lakh jobs. The government has decided to set up MSME parks in all 175 Assembly constituencies. Lokesh claimed Andhra Pradesh is attracting massive investments due to the speed of doing business, in which the State ranks first. With a cluster-based approach and vertical and horizontal integration, the government has set a target of transforming Andhra Pradesh into a \$2.4 trillion economy by 2047. The Greater Visakhapatnam Economic Corridor alone is envisioned as a \$1 trillion economy. The state will have three economic corridors, with the other two in Amaravati and Rayalaseema.

Anantapur has been developed as a mobility valley with the KIA Motors plant, while the north Anantapur and Kurnool districts are attracting major renewable energy, pumped storage projects, and cement factories. An electronics manufacturing ecosystem is

being created in Chittoor and Kadapa districts, and Nellore district already has a large industrial ecosystem in the form of Sri City. The government is working towards fulfilling its 'Super Six' promise of creating 20 lakh jobs in five years, with five lakh jobs targeted in the IT sector alone.

To deliver on these commitments, the coalition government rolled out several welfare schemes. Under the Talliki Vandanam scheme, financial assistance of Rs 10,090 crore was disbursed to benefit 67.27 lakh students. The scheme provides Rs 15,000 annually for every child studying in a government school.

On August 15, the government introduced the Stree Sakthi scheme, offering free travel for women in APSRTC buses. So far, 3.25 crore women have availed the facility, with the government spending Rs 1,144 crore on the scheme.

The government also distributed three free LPG cylinders per year, benefiting two crore women at a cost of Rs 2,684 crore. Under the Annadata Sukhibhava scheme, Rs 6,310 crore was credited to the accounts of 46 lakh farmers.

Under the NTR Bharosa pension scheme, Rs 33,000 crore is being distributed annually to over 63 lakh beneficiaries. To improve governance delivery, the government introduced citizen services through WhatsApp Governance and adopted data-driven decision-making for disaster management. In August, the government rolled out the ambitious P4 Initiative (Public-Private-People Partnership) to achieve the goal of zero poverty by 2029. The initiative aims to empower underprivileged families through community participation, mentorship, and access to resources. The P4 model focuses on connecting wealthier individuals and institutions with needy families to provide customised support for employment, healthcare, and entrepreneurship, while integrating existing welfare schemes and leveraging technology, including AI, for needs assessment.

## Andhra man kills his three children; dies by suicide

Amaravati, Jan 1 : In a shocking incident, a man killed his three children by poisoning them and later died by suicide in Andhra Pradesh's Nandyal district. Police said the incident occurred in Thudumaladinne village in Uyyalawada Mandal of Nandyal district.

Vemulapati Surendra killed his three children aged between two and seven years before killing himself. The bodies of Kaavyashri (7), Dhyaneswari (4), and Surya Gagan (2) and Surendra (35) were found in the house on Thursday. Police suspect that Surendra served cold drinks laced with pesticides to the children before hanging himself. Surendra's wife Maheshwari had died by suicide on August 16, 2025. The woman had taken the extreme step due to ill-health and since then



Surendra was taking care of the children.

Police suspect that Surendra killed the children and died by suicide due to personal problems. He is believed to have resorted to the ghastly act under the influence of alcohol. According to locals, Surendra, a construction worker, was devastated by his wife's suicide. He was also facing financial problems and difficulty in bringing up his children all alone.

The incident sent shock waves in the region. Police shifted the bodies for post-mortem examination.

A police officer said they have registered a case and taken up the investigation. Police collected samples of food and cold drinks

from the house and sent them to lab for examination. Meanwhile, in Telangana dispute over a chit fund led to the murder of a man.

The incident occurred in Govindapalle in Jagtial district. According to police, Anjayya (58) was allegedly murdered by a man and his son.

Preliminary investigation by police revealed that Anjayya, a businessman and one Dasoju Sreenu had a dispute over a Rs.1 lakh chit fund. Anjayya, who was running a chit fund scheme, was demanding that Sreenu clear Rs.12,000 dues. Alleging that he was harassing him for payment, Sreenu picked up a quarrel with him. Sreenu and his son Dasoju Venu attacked Anjayya, severely injuring him. The victim was admitted to a hospital where he succumbed to his injuries.

# EDITORIAL

## 'India Out': In South Asia, India Bears the Burden of Nearness

This season, once again, the street in Bangladesh fills before it decides why it has filled. Bangladesh has once again become the place where South Asia’s unease gathers. The protests are familiar in form – students, slogans, police lines – but their cause resists precision. They are not only about water, though the rivers matter. They are not only about borders, though the dead along them are remembered. They are not only about diplomacy, though the language of insult and interference circulates freely. What moves beneath these moments is older and more intimate: a feeling that pressure is being applied from beyond the horizon, that decisions are being made elsewhere and lived locally, that proximity itself has become a burden. India enters these scenes less as an actor than as a presence: structural and unavoidable, and therefore endlessly interpretable.

This essay begins here, not because Bangladesh is exceptional, but because it is emblematic. Over the past half-century, similar moments have surfaced across South Asia, appearing suddenly, intensifying quickly, and dissolving without resolution. Moments like this have come to be called “India Out”, though what they name is not an ideology so much as a recurring strain of proximity. India is rarely absent in South Asia. Even where it is not invoked, it is felt: through rivers that thin without warning, through fuel queues that lengthen toward dusk, through borders that harden unexpectedly, through a rumour that arrives before reason can intervene. For many of its neighbours, India is not a policy problem so much as a condition of life: proximate, immense, and inescapable. It is this condition, more than any single action, that explains why, at moments of strain, the street turns outward and demands that India go.

These moments do not announce themselves as ideology. They do not sustain programs or carry manifestos. They appear instead as moods. A gathering thickens at a crossroads; a slogan hardens; a phrase repeats itself until it no longer sounds like news but like truth. By the time the words ‘India Out’ are painted or shouted, the work has already been done elsewhere: in the mind, in the image, in the shared sense that something has been taken, withheld, or imposed without consent. Over decades, since India ceased to be an episodic actor and became a structural presence in the lives of its neighbours, such moments have surfaced repeatedly across Bangladesh, the Maldives, Nepal, and Sri Lanka. They differ in scale and consequence. Some pass without blood; others do not. Yet they share a peculiar intimacy. India is not a distant empire to be denounced, but a neighbour whose presence is already woven into daily life; into water, trade, labor, language, cinema, and news.

To protest India, then, is not to reject an abstraction. It is to recoil from a closeness that, at certain moments, becomes unbearable. In Bangladesh, the earliest murmur rose not from the street but from the river. When the Farakka Barrage was commissioned in the mid-1970s, the grievance it produced was slow, almost geological. Water does not protest; it withdraws. Crops fail quietly. Livelihoods erode before they break into the open. The Farakka Long March of 1976, disciplined, largely non-violent, did not accuse India of malice so much as of indifference. India appeared there as a force upstream, unseen yet decisive, capable of altering lives downstream without ever crossing a border.

That image endured. Long after the slogans faded, the sense of hydrological vulnerability remained, ready to be recalled whenever scarcity returned. Along the border, death arrived more abruptly. Civilians shot while crossing fields or tending cattle did not require ideological framing to become symbols. Each killing was small in number, large in meaning. Protest followed death, not the other way around.

## The Vishwaguru Complex: Supremacist Rhetoric and National Decline

When Mohan Bhagwat, chief of the Rashtriya Swayamsevak Sangh (RSS), declared that India should aspire not merely to superpower status but to become “Vishwaguru”– teacher of the world – he articulated a vision that demands serious critical scrutiny. This rhetoric, increasingly central to contemporary Indian nationalism, represents a peculiar form of supremacist discourse that claims for India a position of moral, spiritual, and civilisational superiority over other nations. What makes this formulation particularly striking is its divergence from the nationalist idioms of other major nations, which typically emphasise strength, prosperity, or influence rather than pedagogical authority over humanity itself. This column examines the historical, sociological, and psychological roots of this “Vishwaguru complex,” argues that it emerges from specific caste-based epistemologies, and demonstrates how such hyperbolic rhetoric functions as deliberate mystification in an era of measurable national decline. The uniqueness of supremacist pedagogy The rhetoric of “becoming a superpower” or “Vishwaguru” is close to unique to India. No other country speaks of its future greatness with this level of certainty and theatricality. Established powers don’t advertise their ascent: the United States doesn’t run on promises of becoming a superpower – it already behaves like one. China avoids the language of impending supremacy and instead invests steadily in technology, industry, and global influence. Russia talks of restoring lost stature. Even ambitious economies like Brazil, South Korea, or Turkey don’t turn national pride into a public campaign of inevitable world leadership. In this sense, India stands alone. Its political class has converted the idea of superpower status into a collective fantasy and a mass pedagogical project. This boastfulness operates as a substitute for capability. Instead of proprietary technology, industrial depth, or strategic leverage,

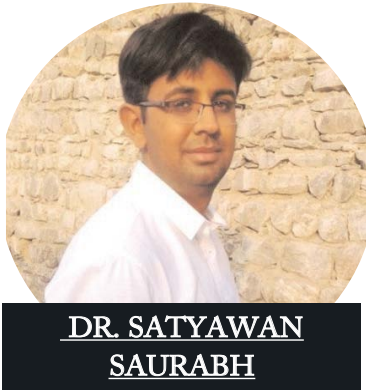


slogans perform the work of achievement. The fixation on future supremacy is less about aspiration than compensation: loud claims filling the vacuum left by institutional decay and developmental stagnation. Nations that genuinely shape the world rarely speak in this register; they demonstrate strength through action, not incantation. The countries that declare destiny most aggressively are usually the ones furthest from realising it. The slogan “Vishwaguru” is even more distinctive. American exceptionalism invokes power; Chinese nationalism invokes rejuvenation; Russian nationalism invokes restoration; even religious states like Iran or Saudi Arabia define themselves by regional authority or theological guardianship. Only India frames itself as the world’s teacher, the bearer of knowledge the rest of humanity supposedly lacks. This is not the language of partnership or even leadership – it is hierarchical, didactic, and civilisationally patronising. It positions India as the enlightened instructor and the world as its classroom. Such confidence does not arise in a vacuum. It draws from a social tradition built on knowledge monopoly and stratified authority: the Brahminical idea that wisdom flows downward from a

self-appointed pinnacle. The modern claim to global tutelage is simply this logic scaled up. It is not confidence born of achievement but the inflation of a historical caste impulse onto the international stage. In that sense, India’s boasts are not just loud – they are structurally unique. The rest of the world speaks of power. Only here do we speak of destiny, mastery, and the world awaiting our instruction. Brahminical epistemology The ideological substratum that informs the RSS and wider Hindutva emerges from a specifically Brahminical epistemology grounded in the premise of congenital hierarchy. Within this framework, human inequality is not merely social but ontological: Brahmins are positioned as inherently superior by virtue of birth, endowed with a putatively greater proximity to sacred knowledge and spiritual authority. The caste system thus operated not as a neutral division of labour but as a division of human worth, naturalised through doctrines of ritual purity, karma, and rebirth that framed hierarchy as cosmic order rather than historical construction. Central to this structure was the consolidation of epistemic power. Access to sacred knowledge – most notably the Vedas – was institutionally

monopolised by Brahmins, who alone possessed the authority to interpret, disseminate, or withhold it. Educational exclusion constituted a mechanism of control rather than mere deprivation: Shudras were legally and theologically barred from hearing Vedic recitation, with violence sanctioned to enforce these boundaries. The result was an epistemological regime in which the Brahmin became teacher by definition, while marginalised castes were structurally designated as non-knowers. Intellectual authority was grounded in claims of exclusive access to transcendence rather than demonstrable competence, producing what can be described as a supremacist epistemology stabilised through ritual, repetition, and punitive enforcement. The RSS inherits this genealogy. Founded by a Brahmin (K.B. Hedgewar), theoretically consolidated by a Brahmin ideologue (M.S. Golwalkar), and repeatedly led by Brahmin leadership thereafter, the organisation’s ideological production bears the marks of this ancestry. While its social base has broadened through strategic lower-caste mobilisation, its conceptual architecture remains Brahminical: the nation is imagined through hierarchical categories, cultural authority flows from the top down.

## CAG Audit Report Finds PMKKKY Goals Are Unmet in Karnataka

On December 17, the Comptroller and Auditor General's Performance Audit report that scrutinised in detail the flagship Pradhan Mantri Khanij Kshetra Kalyan Yojana was tabled in the Karnataka state assembly. This flagship scheme was designed as per the provisions of Mines and Minerals (Development and Regulation) (Amendment) Act, 2015; immediately after National Democratic Alliance government came into power in May 2014. The amendment to India's framework law governing the mining sector was rooted in the belief that part of the royalty paid by mining leaseholders shall remain in the district to ensure the overall welfare of mining affected people. Thus, a specified percentage of mining royalty will remain at district-level District Mineral Fund to be managed by organisations named District Mineral Foundation Trusts. In September 2015, as per the provisions of MMDR (Amendment) Act, the Union ministry of mines issued guidelines for the implementation of what it termed the Pradhan Mantri Khanij Kshetra Kalyan Yojana. The objectives of PMKKKY are: To implement various developmental and welfare projects/ programmes in mining affected areas; To minimise/mitigate the adverse impacts, during and after mining, on the environment, health and socio-economics of people in mining districts; and To ensure long-term sustainable livelihoods for the affected people in mining areas. This performance audit on PMKKKY implementation in Karnataka points out that as on March 31, 2023, the District Mineral Fund amounted to Rs 4003.51 crore; whereas expenditure had remained sluggish at Rs 1826.46 crore (i.e. 45.62%). However, as we analyze the audit findings, the message that emerges is not just sluggish expenditure, but also instances of works getting awarded without inviting tenders, as well as money getting spent to what auditors have termed as “irregular and inadmissible expenditure”. In a shocking audit finding, auditors reveal that authorities had not paid enough attention to planning processes,



thereby defeating the participatory planning purpose that was at the heart of the PMKKKY. In test-checked districts, CAG found that DMFTs had not prepared any Master Plan or Vision Document for the activities to be taken up. While the PMKKKY Guidelines, model rules and Karnataka DMFT Rules provided for the very basic activity of preparing lists of mining affected people and mining affected villages in respective districts, after almost a decade of PMKKKY implementation, these basic lists were not prepared and were not found on records. In absence of such basic lists, the targeting of works under PMKKKY for mining affected villages and people remained an unachieved goal. The performance audit also revealed that monitoring and impact evaluation remained neglected tasks. CAG audit states: “[T]hrough the State Level Steering Committee, headed by honorable Chief Minister, was constituted in March 2018, five years later, as on June 2023 no meeting were held”. As envisaged under Rule 5A of Karnataka DMFT Rules 2016, the SLSC shall meet at least once a year. The mechanism meant to ensure checks and balances has utterly failed, since the State-Level Empowered Committee, headed by Chief Secretary, whose prerogative was to ensure timely monitoring and review the progress of projects financed by DMFTs and functioning of DMFT Managing Committees, had met

only four times between March 2018 and June 2023. As per Rule 5B of Karnataka DMFT Rules 2016, the SLEC shall meet at least three times in a year. Thus, against the mandatory minimum requirement of 15 meetings, the SLEC could meet only four times, exposing poor compliance. Similar shortfalls and non-compliance with basic planning and monitoring mechanism were noticed with regard to mandatory minimum requirement of meetings of DMFT Governing Councils and Managing Committees in test checked districts, as explained in the table below:

\*Vijayanagara DMFT came into being only after the erstwhile Ballari district was bifurcated, leading to creation of Vijayanagara as separate district on November 17, 2021. Hence, the mandatory minimum number of meetings for this test-checked districts are not at the same level as for other four test-checked districts. CAG auditors also found several deviations in the way projects got approved and managed, defeating the very purpose of creating a fund to address the legacy development and welfare issues in mining affected districts. While PMKKKY guidelines of the Union Ministry of Mining, as well as Rule 18(2) of Karnataka DMFT Rules, had unambiguously underlined upon a judicious prioritisation of projects, by defining High Priority Areas (60% fund utilisation) and Other Priority Areas (remaining 40% fund utilisation).

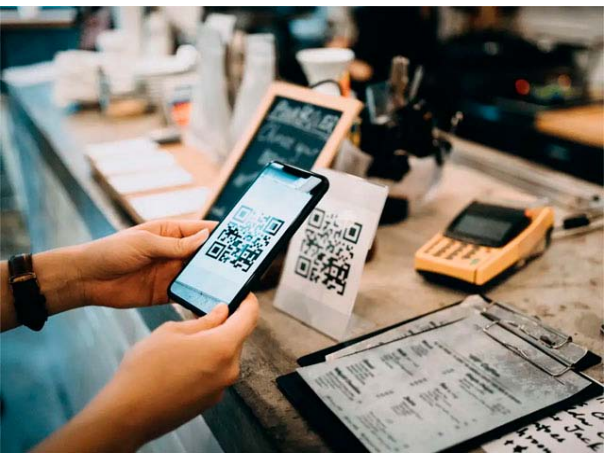
MGMC 2025 in Moscow to bring together MICE professionals from 35 countries

Digital payment growth leads to fall in ATM numbers in FY25

New Delhi, Jan 1: With digital payments gaining momentum across the country, the number of automated teller machines (ATMs) declined during the financial year 2024-25, according to a report released by the Reserve Bank of India on Monday. The RBI's report on Trends and Progress of Banking in India 2025 noted that the expansion of public sector bank networks led to a two per cent increase in the number of bank branches during the year, even as reliance on ATMs reduced. As on March 31, 2025, the total number of ATMs in the country stood at 2,51,057, down from 2,53,417 in the previous



year. The decline has been attributed largely to strategic changes adopted by private sector banks. The ATM network of private sector banks fell from 79,884 to 77,117 during

the year, while public sector banks also saw a marginal reduction, with numbers declining from 1,34,694 to 1,33,544. The report stated that the withdrawal of off-site ATMs by both private

and public sector banks contributed to this drop. The report observed that increased digitisation of payments has reduced the need for customers to conduct transactions through ATMs. In contrast, independently operated white-label ATMs increased from 34,602 in the previous year to 36,216, indicating a shift in the structure of ATM deployment. Despite the growth of digital alternatives, banks continued to expand their physical presence. As of March 31, the total number of bank branches in the country rose to about 1.64 lac, reflecting a growth of 2.8 per cent during the financial year, the report added.

Michael D'Cunha panel uncovers Rs 167 crore Covid irregularities in K'taka; final report submitted

Bengaluru, Jan 1: The Michael D'Cunha Commission, tasked with investigating deaths during the Covid-19 pandemic and alleged irregularities in the procurement of medical equipment, has submitted its final report to the Karnataka government. The panel handed over 684 files from Belagavi district and 171 files from Bengaluru Urban district to Chief Secretary Shalini Rajneesh in the presence of Chief Minister Siddaramaiah on Wednesday. Justice D'Cunha indicated that while the Commission has



not made the report public, the government may choose to release it in the public interest, citing the need for transparency. The retired High Court judge-led Commission was constituted in August 2023 following allegations of corruption

in the Health and Medical Education Departments during the Covid-19 crisis. The panel had submitted a first interim report in 2024, followed by a second interim report spanning 1,808 pages in April 2025.

On the basis of the first interim report, the State Cabinet in November 2024 approved the formation of a special investigation team, and the case was subsequently handed over to the CID for detailed inquiry. The probe centres on alleged financial irregularities worth Rs 167 crore during the previous BJP government's handling of Covid-19. The complaint was lodged by Dr M Vishnuprasad, chief accountant of the Medical Education Department, who alleged misuse of funds and procedural lapses by several officials.

Strict Compliance with Safety Regulations Mandatory in Service Apartments, Hostels and PGs - D.S. Ramesh

Bengaluru: The Commissioner of the Bengaluru East City Corporation, D.S. Ramesh, stated that the owners, operators and managers of all service apartments, hostels and paying guest (PG) accommodations within the City Corporation's limits must inspect their premises and ensure strict compliance, within the stipulated time, with all safety regulations prescribed by the City Corporation, along with all other applicable safety norms. The primary objective of this measure is to prevent the recurrence of tragic incidents such as recent gas explosions and fire accidents, and to ensure the safety of public life and property. In this context, owners, operators and managers must personally ensure that their establishments fully comply with all prescribed safety standards. Key safety regulations to be complied with:

- Safe and authorized use of LPG/gas connections
- Complete prohibition of illegal and unsafe gas cylinders
- Adequate ventilation and fire safety measures
- Electrical safety and measures to prevent overloading
- Valid and existing trade licences and all required registrations

Time granted for compliance: A period of seven (7) days has been granted to all service apartments, hostels and PG establishments to rectify the above-mentioned safety deficiencies and to ensure full compliance with all applicable laws and licence conditions. Inspection and enforcement action:



After the expiry of the stipulated period, the City Corporation will undertake a special inspection drive. Strict action will be initiated against service apartments, hostels and PG establishments that fail to comply with safety regulations. Such action will include sealing of the premises and cancellation or suspension of trade licences. Further, penalties will be imposed under the Greater Bengaluru Authority Act, 2024, and other applicable laws. If violations are found to pose a serious threat to life and public safety, legal action will be initiated against the concerned establishments.

## Pongal bonus doubled for 4.71 lakh pensioners in Tamil Nadu

The Handlooms, Handicrafts, Textiles, and Khadi Department has allocated nearly Rs 100 crore for yarn procurement and wages for weavers.

CHENNAI: In a major relief for pensioners, the Pongal bonus for pensioners and family pensioners under the C and D categories has been increased to Rs. 1,000 from the existing Rs. 500, beginning this Pongal festival. The announcement, made by Chief Minister M.K. Stalin in the Tamil Nadu Assembly in April 2025, has now been implemented.

In a statement issued by the government said that, present employees and teachers belonging to the C and D categories will receive a maximum Pongal bonus of Rs 3,000. Employees working on consolidated pay, those receiving special time-scale pay, and full-time or part-time employees who have completed at least 240 days of service during the 2024-25 financial year will receive a special bonus of Rs. 1,000.

Pensioners and family



pensioners under the C and D categories, former Village Administrative Officers, village assistants, and other individual pensioners will also receive a Pongal bonus of Rs 1,000. For this initia-

tive, the State government has allocated Rs. 183.86 crore, benefiting around 9.90 lakh employees and pensioners.

As per the Chief Minister's Assembly announcement, the increase

in the Pongal bonus from Rs 500 to Rs. 1,000 will benefit nearly 4.71 lakh pensioners and family pensioners, resulting in an additional expenditure of Rs. 20 crore. To further support pensioners during the festive season, the existing festival advance has been enhanced from Rs. 4,000 to Rs. 6,000. This measure will benefit around 52,000 pensioners and involve an additional expenditure of Rs.10 crore. Following the allocation of funds for the Pongal gift hamper, the government has also announced bonuses for employees, teachers, and pensioners. In addition, the Tamil Nadu government has commissioned the production of 1.77 crore dhotis and an equal number of sarees for the 2026 Pongal celebrations. The Handlooms, Handicrafts, Textiles, and Khadi Department has allocated nearly Rs 100 crore for yarn procurement and wages for weavers.

## Procure Pongal sugarcane directly from farmers, Anbumani tells govt

CHENNAI: PMK president Anbumani Ramadoss has urged the Tamil Nadu government to directly procure Pongal sugarcane from farmers and distribute two sugarcanes per family as part of the Pongal gift hamper.

In a statement, Anbumani said with barely two weeks left for the Pongal festival, the state government is yet to announce details about the Pongal gift package or clarify whether sugarcane will be included. This uncertainty has caused deep anxiety among farmers who cultivated paneer karumbu (tender sugarcane), hoping it would be procured for Pongal distribution, he added.

He explained that cultivating sugarcane costs farmers up to Rs 2.25 lakh per acre, including planting, maintenance, harvesting, and labour costs. Despite this, farmers receive only Rs 18 – Rs 19 per cane, even though the government had announced a procurement price of Rs 35 per cane,

inclusive of costs. Middlemen pocket a large share, often taking 10% of the produce for free and charging high transport and handling fees. As a result, farmers earn virtually no profit, while intermediaries allegedly make massive gains.

Anbumani also criticised impractical pro-

curement norms, such as accepting only sugarcane over seven feet tall, which leads to rejection of large quantities. Further, distributing only one sugarcane per family goes against Tamil tradition and reduces demand, worsening farmer losses.

He noted that the sugarcane cultivation area has sharply declined over the last five years due to continuous losses. To protect farmers, he demanded that the government increase the procurement price to Rs 50 per cane, procure sugarcane directly without middlemen, and supply two sugarcanes per family for Pongal.

## INDI alliance unbreakable: TNCC chief

CHENNAI: Tamil Nadu Congress Committee (TNCC) president K Selvaperunthagai on Wednesday asserted that the INDI alliance is strong and unbreakable, and cautioned alliance partners against interfering in the internal affairs of the Congress. He said complaints have been lodged with the All India Congress Committee (AICC) against party functionaries, including Praveen Chakravarthi, for comments against the alliance and the State government. Speaking to reporters at Sathyamoorthi Bhavan, the TNCC chief rejected AIADMK leader Edappadi K. Palaniswami's claim that the Congress is exploring a new alliance with Vijay. He said that while EPS is keeping options open in search of allies, the INDIA bloc remains firm and cannot be destabilised. Responding to questions about statements made by Praveen Chakravarthi, he stated that the leadership has taken serious note of such remarks and will take appropriate action.

## Light to moderate rain likely in parts of Tamil Nadu till January 3

CHENNAI: Light to moderate rain is likely to continue at isolated places across Tamil Nadu till January 3, with a few locations in south Tamil Nadu expected to see more frequent showers, according to the Regional Meteorological Centre, Chennai.

The weather department has warned of heavy rain at isolated locations in the ghat areas of Coimbatore

district, the Nilgiris, Tirunelveli, Thoothukudi and Kanyakumari, mainly due to moisture inflow from the Bay of Bengal.

Rainfall activity is expected to reduce from January 3, with dry weather likely to prevail across the State from January 4 to 6. Chennai is likely to receive light rain in some areas on January 2, with mist or haze during early morning hours.

# Antimicrobial resistance a major health challenge for India: Experts

NEW DELHI: Prime Minister Narendra Modi's call to check the indiscriminate use of antibiotics has been lauded by health experts who said that his message drew attention to a major health concern of antimicrobial resistance (AMR) that the country is presently facing and called for regulating over-the-counter sale of such drugs.

AMR occurs when bacteria, viruses, fungi and parasites no longer respond to antimicrobial medicines, according to WHO. As a result of drug resistance, antibiotics become ineffective and infections become difficult or impossible to treat.

In his monthly 'Mann Ki Baat' radio address, Prime Minister Modi on Sunday said that antibiotics are not medicines that can be taken mindlessly and urged people to take them only on the doctor's advice.

He said the Indian Council of Medical Research (ICMR) recently released a report which said that antibiotics were proving ineffective against many diseases like pneumonia and UTI (Urinary Tract Infections). "This is a matter of great concern for all of us," he said.

Dr M Srinivas, Director of AIIMS-Delhi, underlined that antibiotics should be consumed only when prescribed by doctors and for the exact duration.

"Indiscriminate use of antibiotics will lead to resistance, and if the infection increases, there will be no reserved drugs left to use. The AIIMS has taken the leadership role in this matter... we have SoPs and hospital infection control systems and are creating awareness about the issue," he said. ICMR Director General Rajiv Bahl said, "PM Modi has drawn the nation's attention to a serious issue. Overuse or irrational use of antibiotics for infections like pneumonia can lead to



resistance, making them less effective. Antibiotics should only be used when needed and prescribed by doctors," he said. Dr Atul Gogia, senior consultant and Head of Infectious Diseases at Sir Ganga Ram Hospital, said that antimicrobial resistance is one of the greatest challenges India is currently facing. Indiscriminate use of antibiotics - unsupervised and self-medication - is leading to growing morbidity and mortality, he said.

The common simple-to-treat infections are becoming increasingly difficult to treat because of the growing antimicrobial resistance, Gogia stressed.

"There is a need of the hour to restrict over-the-counter sale of antibiotics as well as restrictions on their use in animals. Ensuring supervised antibiotic use in proper dosage and duration is the need of the hour to prevent

further aggravation in the AMR situation," he said.

The early involvement of physicians and infectious disease doctors for proper implementation of the guidelines is very essential to prevent the onslaught of AMR, he added.

India, bearing a silent and large pandemic in terms of high burden of infectious diseases, with UTI and pneumonia being the major ones, easy over-the-counter availability of antibiotics, irrational prescribing, and incomplete treatment courses have accelerated resistance, said Dr Neha Rastogi, Senior Consultant-Infectious Diseases, Fortis Gurugram.

"With the strategy to empower the community as a modality to combat antimicrobial resistance, Prime Minister Narendra Modi emphasised on mass awareness," she said. Massive impact of

behavioural change, better diagnostics alongside stringent regulation and implementation of national policies on controlling AMR are needed. "Prevention of infections - vaccination, sanitation and environmental factors; pre-empting - early and improved affordable diagnostics, avoidance of self-medication, right dose right duration protocol are key pillars to build and sustain the drive against antimicrobial resistance," Rastogi said.

Dr Manisha Arora, Director of Internal Medicine at CK Birla Hospital, Delhi, said that antibiotic resistance has emerged as one of the most serious global public health crises.

While it is a worldwide concern, India is among the countries most severely affected due to the widespread misuse and overuse of antibiotics, she said.

Studies suggest that nearly 50-70 per cent of antibiotic use in India is inappropriate, she said.

According to the World Health Organization (WHO), the rise of drug-resistant "superbugs" is alarming, with antimicrobial resistance currently responsible for approximately 700,000 deaths each year globally. If left unchecked, this number could rise dramatically to 10 million deaths annually by 2050, surpassing cancer as a leading cause of mortality. "In India, the situation is further worsened by self-medication and the easy availability of antibiotics without a prescription. This is a major concern and calls for stricter regulation and enforcement. "Antibiotics should only be taken when prescribed by a qualified healthcare professional. In parallel, strengthening infection prevention and control measures, along with increasing public awareness and education on responsible antibiotic use, is critical to tackling this growing threat," Dr Arora said.

## Experts call for integrated action to curb antibiotic resistance

CHENNAI: Antibiotic resistance is a critical global health threat due to excessive and inappropriate use of antibiotics in humans, livestock and agriculture, warn health experts. A major concern is the growing tendency among people to take antibiotics without medical advice.

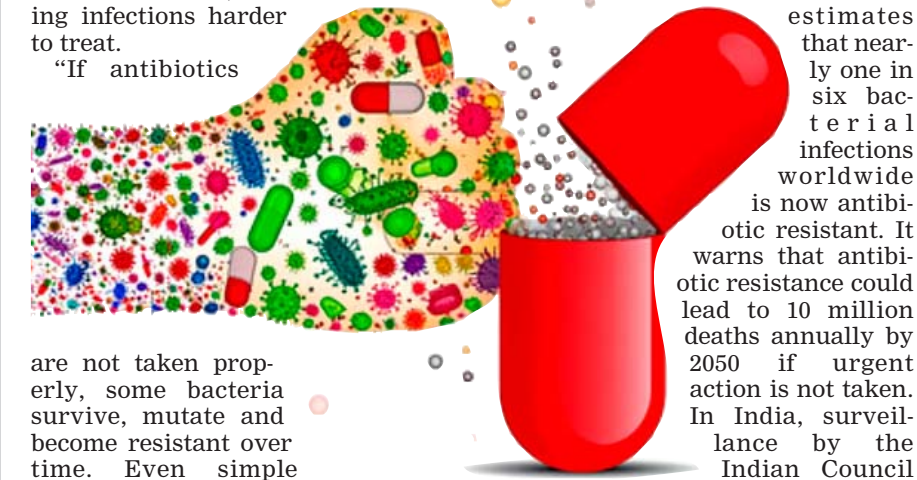
When antibiotics are misused, taken in the wrong dose or stopped midway, bacteria survive, mutate and become resistant, making infections harder to treat.

"If antibiotics

extends beyond humans. Large quantities are used in poultry, dairy and livestock farming to accelerate growth and prevent disease. In agriculture, antibiotics used for crop protection contaminate soil and water. "These residues enter our food chain and water sources, contributing to resistance. # ‘Oracle of Omaha’ Warren Buffett retires as Berkshire Hathaway CEO

After nearly six decades at the helm of Berkshire Hathaway, American investor and philanthropist Warren Buffett has stepped down as its Chief Executive Officer (CEO), handing over charge to his successor and trusted lieutenant, Greg Abel. Previously, the 95-year-old had always maintained he had no plans to retire. His decision in May last year came as a surprise to Abel. According to the Associated Press, Warren’s children, Howard and Susie Buffett, who also serve as board members, knew of his decision. The czar of investments often credited with his sorcery to generate wealth from the stock market, Buffett bought Berkshire Hathaway in 1962 and transformed the once-struggling textile firm into a massive USD 300 billion investment company. In 1972, he bought See’s Candies for USD 25 million. This investment heaped gold and by 2019, it saw a pre-tax earnings of nearly USD 2 billion. Another of his genius ideas was the decision to become a major shareholder in Coca-Cola, which proved to be a “forever stock,” driven by the soft drink company’s strong business model of selling concentrates to bot-



tlers, powerful brand, wide distribution network and ability to set prices. Patience was his virtue. Popularly known as the “Oracle of Omaha,” his approach towards the stock market was patience and not chasing after quick gains. He focused on quality and stressed long-term, value-based investing and sustainable profits. Warren Buffett was born in 1930 to Howard Buffett, a US Congressman. At the age of 20, he graduated from the University of Nebraska and then studied at Columbia Business School. From there, he attended the New York Institute of

Finance to focus on his economics background and soon pursued a business career. Who is Greg Abel, Warren’s successor? Abel joined Berkshire Hathaway in 2000 when it acquired MidAmerican Energy. Known within his peers as more of a hands-on manager, Buffett had often praised Abel as a “tireless worker and an honest communicator.” The 63-year-old has been serving as the company’s vice chairman since 2018. A Reuters report stated he owns about USD 170 million worth of Berkshire stock and his net worth exceeds USD 1 billion.

# Commerical LPG cylinder rates hiked by Rs 111 from Jan 1

**New Delhi:** Starting from January 1, the price of commercial LPG has risen by Rs 111 per cylinder across all major cities, making it the highest hike since June last year. With this, a single 19 kg cylinder will now cost Rs 1,691.50 in Delhi, Rs 1,642.50 in Mumbai, Rs 1,795 in Kolkata and Rs 1,849.50 in Chennai. Domestic cylinder rates remain unchanged at Rs 853 per 14.2-kg cylinder. Petrol and diesel prices continue to remain frozen after a Rs 2 per-litre reduction in March last year; petrol currently costs Rs 94.72 per litre in Delhi and diesel Rs 87.62. Meanwhile, prices of aviation turbine fuel (ATF), or jet fuel, were reduced by 7.3 per cent. The reduction comes after three rounds of monthly price hikes. According to state-owned fuel retailers, which include Indian Oil Corporation, Bharat Petroleum and Hindustan Petroleum, the ATF price in Delhi was cut by Rs 7,353.75 per kilolitre to Rs 92,323.02 per kilolitre. In Mumbai, it was revised to Rs 86,352.19 per kl, while



prices in Chennai and Kolkata were cut to Rs 95,770 and Rs 95,378.02 per kl, respectively. The rate was last raised by Rs 5,133.75 per kl, or 5.4 per cent, on December 1. Before that, prices had risen by about 1 per cent on November 1 and by 3.3 per cent on October 1. The latest reduction is expected to ease pressure on airlines, for which fuel accounts for nearly 40 per cent of operating costs. State-owned fuel retailers revise ATF and LPG prices on the first day of every month based on

international benchmarks and the exchange rate. The revision in commercial LPG prices is significant for sectors that rely heavily on such cylinders, including eateries, catering services and small businesses, as fuel forms a major component of their operating costs. The unchanged domestic LPG prices, meanwhile, ensure that household budgets are not impacted by the latest revision. In August, Union Petroleum Minister Hardeep Singh Puri hailed the Centre’s recent decision

to pay Rs 30,000 crores to oil companies in 12 parts, which has kept prices of Liquefied Petroleum Gas stable in the country. The Union Cabinet, on August 8, led by Prime Minister Narendra Modi, has approved a compensation of Rs 30,000 crore to be paid in twelve parts to oil companies that have kept LPG prices stable despite global uncertainty. The new rates of commercial cylinder are applicable from January 1 and will remain in force until further revision by oil marketing companies.

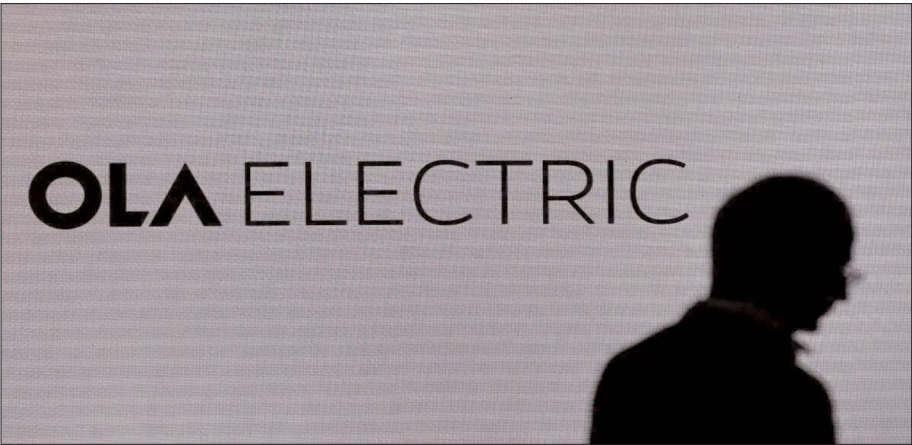

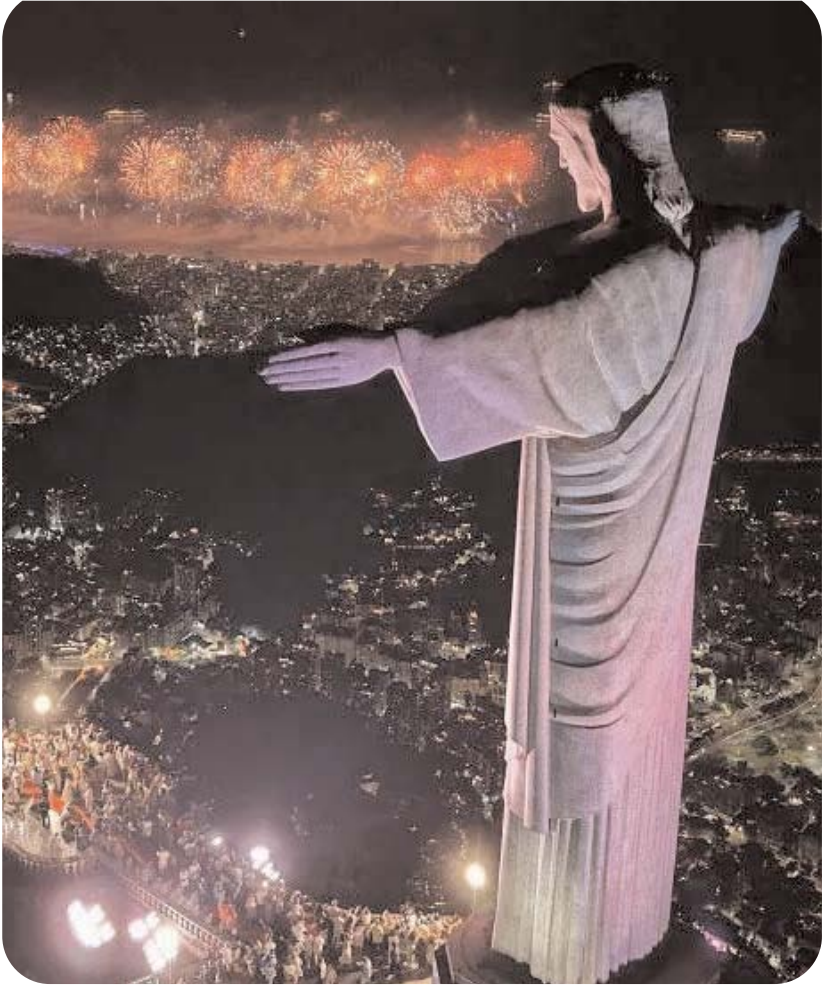

But the episode was soon restored and viewers were able to watch a finale that included massive battle scenes and



emotional tributes that brought in all five seasons, giving closure to the characters that we've fallen in love with over the years. The finale left you on the edge of your seat at moments and had you both cheering and crying in others. A lot was riding on Netflix and The Duffer Brothers, who created the 1980s-inspired, monster-infused, inter-dimensional series. Ending any beloved series comes with both anticipation and a lot of critics. US military says five  
killed in latest strike on  
alleged drug boats



The US military says it struck two boats it alleges were carrying drugs on Wednesday, killing five people on board. US Southern Command did not say where it had carried out the latest strikes but US forces have been targeting vessels they suspect of smuggling narcotics to the Caribbean and the eastern Pacific for the past three months. Wednesday's strike came a day after the US targeted what it said were "three narco-trafficking vessels traveling as a convoy", killing at least three people. The Trump administration has cast its operations as a non-international armed conflict with the alleged traffickers but legal experts say they could be in violation of the laws governing such conflict. In total, there have been more than 30 strikes on vessels as part of the Trump administration's "war on drugs" with more than 110 people

killed since the US carried out its first attack on a boat in international waters on 2 September. That first attack has come under particular scrutiny from lawmakers in Washington since it emerged that US forces struck the targeted boat twice. Two people who had survived the first strike and were clinging to the hull of their boat were killed in the second. Some lawmakers expressed concern that the "double-tap" strike breached the rules of engagement. In its post announcing the strike on a convoy of three boats carried out on 30 December, US Southern Command said that there had been a number of survivors, without specifying how many. It said that "the remaining narco-terrorists abandoned the other two vessels, jumping overboard and distancing themselves before follow-on engagements sank their respective vessels".

New discovery may challenge  
theory Vikings built first Irish  
towns - researcher

A recently discovered large hilltop settlement could challenge the theory that the Vikings built the first towns in Ireland, a researcher has said. Dr Dirk Brandherm and his colleagues have identified more than 600 suspected houses in the Brusselstown Ring making it, to date, the largest nucleated settlement ever discovered in the entirety of prehistoric Britain and Ireland. The settlement, which is thought to have emerged at about 1200 BC (the Late Bronze Age), is located within a region called the Baltinglass Hillfort Cluster in the south-western edge of the Wicklow Mountains. It is among the 13 large hilltop enclosures spread across



the mountain range where there are structures dating back to the Neolithic period and Early Bronze Age. The findings were recently published within Antiquity, a peer-reviewed journal of world archaeology. The study states: "Given its exceptional size, density of occupation and architectural complexity.

SEVERAL DOZEN FEARED DEAD IN  
SWISS SKI RESORT BAR FIRE

Several dozen people are presumed dead and around 100 injured after a fire ripped through a bar in a ski resort in southern Switzerland, officials have said. The fire broke out at around 01:30 (00:30 GMT) during new year celebrations in a bar called Le Constellation in Crans-Montana, police said. People from multiple countries have been affected, according to Swiss authorities, and "significant work" will be needed to identify victims and return bodies to families. Officials investigating the incident have not mentioned any cause, but categorically ruled out an attack. Ten helicopters, 40 ambulances and 150 emergency responders were sent overnight to the scene of the fire in the



Valais region, which is popular with tourists. Most of the injured experienced severe burns and were sent to Valais hospital, said Mathias Reynard, the region's council leader, in a press conference on Thursday morning. Its intensive care unit had reached full capacity and Reynard said the local community must take extra care to avoid needing hos-

pital treatment unnecessarily. Details are still emerging, and it is not yet known the precise number of people who have been killed and injured, their nationalities, the cause of the fire or how many people were in the bar. Officials have, however, confirmed that several nationalities were involved. The Italian foreign ministry said information from Swiss police indi-

cated around 40 people had died. Police at the press conference said "several dozen" were presumed dead, but did not give a more precise number when responding to questions from the media. Local media reports earlier on Thursday suggested pyrotechnics could have caused the incident, although this is unconfirmed. Valais canton prosecutor general Beatrice Pilloud said an investigation was under way "to identify the circumstances which caused this dramatic situation to occur". She told the press conference "currently we are favouring a fire and at no time is there question of any attack", adding out of respect for the families she cannot say more at this time.

NETHERLANDS POLICE FACE 'UNPRECEDENTED' NEW YEAR'S VIOLENCE

Police in the Netherlands were pelted with fireworks and faced an "unprecedented amount of violence" on New Year's Eve, officers have said. A 19th century church in Amsterdam was engulfed by fire in the early hours of New Year's Day, although the cause of the blaze is not yet known. The Vondelkerk, which overlooks the largest park in the city, the Vondelpark, has been a tourist attraction since it was built in 1872. Elsewhere in the Netherlands, a 17-year-old boy and 38-year-old man were killed in fireworks incidents. In Bielefeld, Germany, local police said two 18-year-olds died after



setting off homemade fireworks. The head of the Dutch Police Union, Nine Kooiman, said she had been pelted by fireworks and other explosives on her shift in Amsterdam. The amount of violence was "unprecedented" she said. Reports of attacks against

police and firefighters were widespread across the country. Petrol bombs were thrown at police in the southern city of Breda. In Rotterdam, the city's eye hospital said it had treated 14 patients, including 10 minors, for eye injuries. Two received surgery. A 17-

year-old boy from Nijmegen and a 38-year-old man from Aalsmeer were killed in fireworks incidents, local media reported. In Amsterdam the 50-metre high tower of the historic Vondelkerk church collapsed. Authorities said the roof was badly damaged but the structure was expected to remain intact. The neo-Gothic basilica was designed by architect Pierre Cuypers whose works also include the Rijksmuseum. A ban on unofficial fireworks is due to come into force in 2026. According to the Dutch Pyrotechnics Association, a record 129m (£112m) had been spent on them this year.

ZELENSKY SAYS PEACE  
DEAL IS 90% READY IN  
NEW YEAR ADDRESS



Ukrainian President Volodymyr Zelensky has said a peace agreement to end the war with Russia is "90% ready", in a New Year address that largely focused on resistance to Moscow's full-scale invasion. Zelensky said the remaining 10% of the agreement to end nearly four years of conflict would "determine the fate of peace, the fate of Ukraine and Europe". In his own New Year speech, Russian President Vladimir Putin told his troops that "we believe in you and our victory". Earlier on Wednesday, Moscow also released what it said was evidence of Ukraine using drones to target Putin's private home on Lake Valdai in north-west Russia, allegations Kyiv has strenuously denied. It included a map allegedly showing that the drones were launched from the Sumy and Chernihiv regions of Ukraine and a video of a downed drone lying in

snowy woodland. A serviceman standing next to the wreckage claims it is a Ukrainian Chaklun drone. The BBC hasn't been able to verify the footage, and it is not possible to locate where it was shot. Russia would review its position on the ongoing peace negotiations as a result of the alleged incident, the Kremlin said. However, Kaja Kallas, the EU's top diplomat, on Wednesday described the Russian claims as a "deliberate distraction" and an attempt to derail the peace process. In his 20-minute address to the nation, Zelensky said that Ukraine did not want peace "at any cost", adding that "we want the end of the war - not the end of Ukraine". He said that a Ukrainian withdrawal from the eastern Donbas region means "everything will be over", a reference to Russia's maximalist demand that Moscow secure full control of the industrial area in any peace agreement. Moscow currently controls about 75% of the Donetsk region, and some 99% of the neighbouring Luhansk. The two regions are known collectively as Donbas. Its fate has been a major obstacle throughout negotiations, with Russia consistently unwilling to compromise on its aim to seize full control of Donbas.

SOCIAL MEDIA FUELLED MAMDANI'S RISE. CAN  
HE KEEP THE MOMENTUM AS NEW YORK MAYOR

Jumping into the frigid waters of Coney Island in January for a pun on "I'm freezing... your rent". Visiting food trucks to discuss how city permitting processes have led to "Halalflation". Walking the length of Manhattan to show New Yorkers they "deserve a mayor that they can see, they can hear, they can even yell at". Those social media videos have helped propel Zohran Mamdani and his left-wing policies to a surprise win in New York City's mayoral primary, and then to victory in the November election. The democratic socialist, 34, engaged New Yorkers - particularly young voters who spend much of their time "doom-scrolling" - by using

social media to build an image of someone who is authentic and joyful, experts told the BBC. Now, after he was sworn in as mayor on 1 January, his next challenge will be keeping those same supporters engaged and maintaining the momentum in office. About three-quarters of New York City voters under the age of 30 voted for Mamdani, according to an Associated Press voter poll. Mamdani's robust social media strategy engaged these voters by delivering an image of a political candidate that young people - frustrated with older, more established candidates - craved, said Jane Hall, a communications professor at American University who studies poli-



tics and the media. A candidate does not have to be young to connect with young voters, Hall said, "but I think you have to be seen as being authentic and speaking to what people care about in a way that is hip and makes people want to be on the bandwagon". Jack Bratich, a journalism professor at Rutgers

University who studies political culture and social media, said Mamdani has shown he is able to combine a light-heartedness with serious conversations. That sense of fun stands in contrast to some of the negativity that President Donald Trump has leaned into on social media, Jennifer Stromer-Galley, who teaches

communications, political science, and rhetorical studies at Syracuse University, told the BBC. Despite an unexpectedly friendly first meeting in November between the two politicians, where they said they agreed on a number of issues facing New York City, such as the affordability crisis, the pair locked horns during the mayoral race. Trump painted Mamdani as an extremist "lunatic", threatened to withhold federal funding from the city if Mamdani won, and said he would have him arrested if he stood in the way of immigration enforcement operations. On election night, Mamdani snapped back in his victory speech, telling the president "to get to any of us,

you will have to get through all of us". That comment prompted a raucous cheer from his supporters at the time, but experts say the reality of governing may mean engaging with the Trump administration in a pragmatic way. That warm meeting in November may have been an early sign that Mamdani is willing to do so. How he works with the White House - and the kind of relationship he cultivates with the president - could prove crucial for implementing his agenda. While it may be easy to promise "fast, sweeping change" in campaign videos, things become much more difficult when it comes to actually "governing under a hostile administration.



# Virat Kohli's First Instagram Post Of 2026 With Anushka Sharma Gets Over 5 Million Likes In 3 Hours

Virat Kohli and Anushka Sharma welcomed the New Year 2026 with friends and family. Several photos of the Indian cricket superstar have gone viral on social media, where he can be seen with Anushka and his brother Vikas along with some close friends. Kohli himself posted a photo with Anushka Sharma on Instagram, which was incidentally his first social media post of the year. In the caption of the photo, he used an emoticon. The photo garnered over five million likes in three hours. Earlier, Kohli's last photo of 2025 contained a special message: "Stepping into 2026 with the light of my life @anushkasharma," he posted on Instagram. The post received close to four million likes in less than an hour. Kohli is spending some quality time with his family currently, before he returns to action with the



Vijay Hazare Trophy and the India vs New Zealand ODI series. Kohli is just 25 runs away from breaking a sensational world record held by Sachin Tendulkar. He needs 25 runs to complete

28,000 runs in international cricket, and he could become the fastest cricketer to achieve this milestone. The star batter will be in action for India in the upcoming ODI series against New

Zealand, starting January 11. Kohli will become only the third batter to reach the feat, after Sachin and legendary Sri Lankan cricketer Kumar Sangakkara. While Sachin achieved it in 644

innings and Sangakkara in his 666th, Kohli has already scored 27,975 runs in just 623 innings. As a result, he has ample opportunity to surpass Sachin's record, and it is expected that the Indian star will reach the milestone during the ODI series against New Zealand. Kohli was in good form in the first two games for Delhi, smashing 131 and 77 respectively. In the process, he also became the fastest to 16,000 List A runs, reaching the milestone in his 330th innings and surpassing the iconic Sachin Tendulkar, who touched the landmark in 391 innings. A BCCI source said that while the Indian ODI squad for the New Zealand series is assembling in Vadodara by January 8, there is a possibility that Kohli might arrive a day earlier to train. The three-match ODI series against the Black Caps will begin at the same venue on January 11.

# Pretoria Capitals Enjoy A Rousing SA20 New Year's Eve

New Year's Eve proved to be the good luck charm for Pretoria Capitals as they joined Paarl Royals in opening their SA20 Season 4 accounts with their respective first victories on Wednesday. Capitals eased past MI Cape Town by 85 runs to earn a bonus point victory at Newlands. Sherfane Rutherford enjoyed a New Year's Eve to remember with the West Indies allrounder delivering the perfect all-round performance for Capitals. Rutherford (47 not out 15 balls, 6x6) and Dewald Brevis (36 not out off 13 balls, 1x4, 4x6) brought the fireworks with the bat before the Windies superstar delivered a career-best bowling performance of 4/24 to dismiss MI Cape Town for just 135 in response to the Capitals' mammoth 220/5. The 'Sky Blues' pair delivered an explosive 86-run partnership off just 27 balls that offset a poor Powerplay after a fit-again Kagiso Rabada had helped reduce



the visitors to 36/3. It was a belligerent exhibition of power-hitting with 92 runs for the loss of just one wicket at a run-rate of 18.2 coming in the last five overs. The duo almost matched each other shot for shot, but it was Rutherford's astonishing assault on Dewald Pretorius in the penultimate over that shocked the Newlands faithful. The West Indian blasted four successive maximums, which formed part of a sequence of a half dozen sixes in a row that had been kickstarted by Brevis' double in the previous over. It was the perfect

ending after Shai Hope (45 off 30 balls, 3x4, 2x6) and Wihan Lubbe (60 off 36 balls, 7x4, 2x6) had done the initial resurrection job. The four Player of the Match candidates were Dewald Brevis, Wihan Lubbe, Keshav Maharaj and Sherfane Rutherford with the West Indian winning 77.4% of the fan vote. MI Cape Town's chase was always going to be dependent on their openers Ryan Rickleton (33 off 17 balls) and Rassie van der Dussen (28 off 20 balls) and the pair duly delivered a 60-run stand within the Powerplay.

# Australia Great Tears Into Babar Azam On Live TV After Pak Star's Latest BBL Fifty

Star batter Babar Azam slammed a half-century for the Sydney Sixers during their Big Bash League (BBL) clash against the Melbourne Renegades on Thursday. The former Pakistan captain struck an unbeaten 58 off 46 balls and was the top scorer for his side as the Sixers beat the Renegades by six wickets at Marvel Stadium in Melbourne. Chasing a tricky target of 165, Babar hit four fours and a solitary six, striking at just over 126. This was his second half-century of the campaign following a 58 against the Sydney Thunder on December 20 and his first since being omitted from Pakistan's squad for the upcoming T20I series against Sri Lanka. While there was a huge roar in the



stadium for Babar following his half-century, former Australia wicketkeeper-bat-

ter Adam Gilchrist raised concerns over his approach in the chase. Gilchrist, who

was on commentary duty for Fox Cricket, pointed out that Babar's 'run-a-ball' approach puts unfair pressure on the other batters. A video of the remarks has since gone viral on social media. "Babar is not known to have a power-packed game. He is not going to hoick across the line and slog one over the boundary for a six. He needs to be proactive. He can't just think run a ball and put all the responsibility on his batting partner to get the job done," Gilchrist was heard as saying on-air. Sixers were in a spot of bother in the chase before Joel Davis slammed a quickfire 34 off just 15 balls. They eventually won the game with five balls to spare. Babar has been struggling for touch in recent times.

An embarrassing moment took place for Perth Scorchers' Mahli Beardman during the side's Big Bash League 2025-26 game against Hobart Hurricanes at Bellerive Oval, Hobart, on Thursday. The Hurricanes were chasing a big target of 230. On the sixth ball of the 12th over of their chase, Australian batter Matthew Wade shuffled across the stumps and tried to play a sweep shot. Pacer Beardman nailed his yorker to perfection, cleaning up the stumps. Given Wade had already smashed one six and two fours in the over, Beardman gave the batter



a fiery send-off. Things took a U-turn as the umpire signalled that it was a front-foot no-ball. As a result, Wade was declared not out and returned to his crease, resuming his batting. Talking about the game, Mitchell Marsh's scintillating century powered

Perth Scorchers to a commanding 40-run victory over Hobart Hurricanes. Opening the batting, Marsh smashed a brilliant 102 off just 58 balls, lacing his innings with 11 fours and five sixes. He was well supported by Aaron Hardie, who produced a blistering unbeat-

en 94 off 43 deliveries, striking nine boundaries and five maximums. The duo dismantled the Hurricanes' bowling attack and guided the Scorchers to a formidable total of 229/3 in their allotted 20 overs. "I would like to clarify recent information that has been circling," he wrote. "I recently underwent a preventative medical procedure, planned in advance with my medical team. The procedure was successful, and I am well. I did not suffer a heart attack. "I am recovering well,

and looking forward to returning to full fitness and resuming my professional and personal commitments soon. "I sincerely thank everyone for the messages of support, care, and concern. I would like to reassure everyone that there is no cause for concern. "My heartfelt thanks go to the entire medical team who took care of me." Carlos won four La Liga titles and three Champions Leagues across 527 appearances for Real Madrid, and lifted the World Cup with Brazil in 2002. Renowned as a free-kick specialist, his other clubs included Palmeiras, Inter Milan, Fenerbahce and Corinthians.

# Shubman Gill's Return Date Confirmed, Set To Play In This Tournament After T20 World Cup Snub

Star India batter Shubman Gill is all set to take part in the upcoming round of games for Punjab in the Vijay Hazare Trophy, according to a report. The 26-year-old, who is India's Test and ODI captain, was left out of the T20 World Cup squad last week after a prolonged lean patch with the bat in the shortest format. According to a report in Cricbuzz, Gill is expected to feature in Punjab's matches on January 3 and 6 against Sikkim and Goa in Jaipur. Veteran all-rounder Ravindra Jadeja has reportedly informed Saurashtra that he will play the January 6 and 8 fixtures against Services and Gujarat. Wicketkeeper-batter KL Rahul is also expected to play in the January 3 and 6 games against Tripura and Rajasthan for Karnataka, though there is no official confirmation as of yet. Gill,



Jadeja and Rahul will then join the Indian team ahead of the upcoming three-match ODI series against New Zealand, beginning on January 11. Gill was part of the Punjab squad announced by the side but did not feature in the first four matches. It is worth noting that Gill was dropped

from India's squad for the New Zealand T20Is as well as the 2026 T20 World Cup following a lean patch in the format. He had been brought back into the team for the Asia Cup earlier this year, a return that saw him playing a T20I after a gap of more than one year. However, the comeback proved difficult

for the right-handed batter, who managed just 291 runs in 15 innings at an average of 24.25. His below-par performance led the Board of Control for Cricket in India (BCCI) selectors to drop him from the T20I team. Gill had initially returned to the T20I setup at a time when things were going well for the side. He was the top scorer in the England Test series and, impressed by that form, the selectors recalled him to the T20I squad. Consequently, he replaced Sanju Samson in the opening slot after a year-long absence from the format. The fact that Samson was dropped despite impressive performances in that position drew widespread criticism at the time. However, while naming the squad for the 2026 T20 World Cup, the BCCI selectors performed a U-turn, naming Samson in the team in place of Gill.

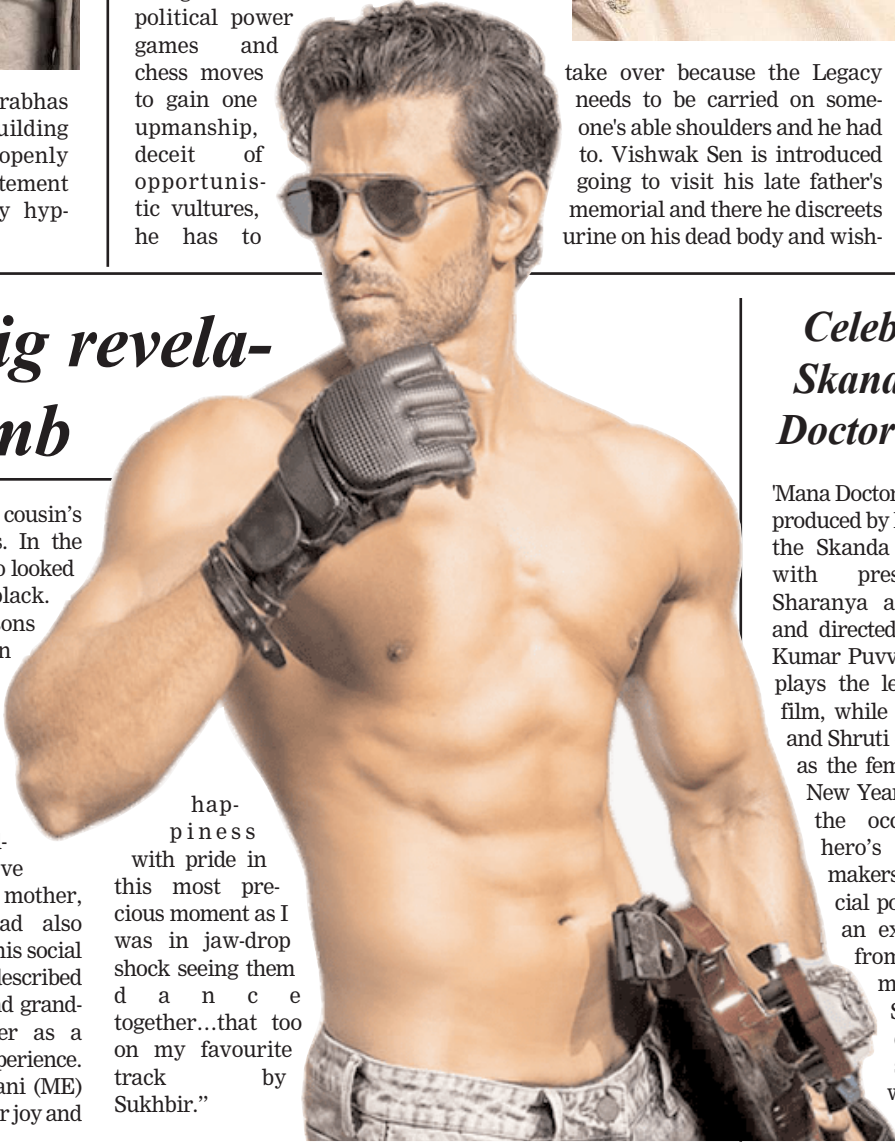
# Hrithik Roshan makes a ‘big revelation’ about his double thumb

You'll find lots to explore on the home page", reported Variety. During the November 26 crash, Netflix was down for about five minutes when the first four episodes of Season 5 released. Season 5 of "Stranger Things" was the most-watched title worldwide thanks to the three new episodes. Between December 22-28, the fifth and final season received 34.5 million views. That marked the season's second-best weekly total after its debut with 59.6 million views in November, which was Netflix's best-ever opening week for an English-language title, according to the website.



The series, created by Matt and Ross Duffer, revolves around the residents of a fictional small town of Hawkins, Indiana. A group of young friends witness supernatural forces and befriend a young girl with psychokinetic abilities, named Eleven.
