PM Modi meets Deve Gowda, praises his insights on key issues



Bengaluru (TSIT): In an important development, former Prime Minister and Janata Dal (Secular) national president H.D. Deve Gowda met Prime Minister Narendra Modi on Thursday and held a discussion. Prime Minister Narendra Modi, taking it to social media X, stated, "Had an excellent meeting with Shri H.D. Deve Gowda Ji. His insights on key issues are noteworthy. Equally admirable is his passion for India's development." The Prime Minister's Office (PMO) has also made a post in the Kannada language in this regard. The development has become a topic of discussion in the state's political corridors. The development has also assumed significance with Deve Gowda and his son, Union Minister H.D. Kumaraswamy, organising a massive rally in their native Hassan and giving a call for the people of the state to overthrow the Congress-led government in the next Assembly election.

235 lakh demat accounts added in FY26 till December

New Delhi (TSIT): India's capital markets are witnessing a strong surge in retail investor participation, with 235 lakh new demat accounts added during FY26 up to December 2025, according to the Economic Survey 2025-26 tabled in Parliament on Thursday. The milestone reflects growing financial awareness and confidence among households, even as global trade uncertainties and geopolitical tensions continue to impact markets worldwide. The Economic Survey noted that despite volatile foreign investment flows, India's equity markets showed measured yet resilient performance during April to December 2025. The Nifty rose by around 11.1 per cent, while the Sensex gained nearly 10.1 per cent in the same period, supported by strong domestic investor participation, improving corporate earnings and supportive policy measures such as tax relief, easing inflation and accommodative monetary policy. A major highlight of the year was the crossing of 12 crore unique demat investors in September 2025, with nearly one-fourth of them being women.

SC stays UGC regulation pertaining to definition of caste discrimination

NEW DELHI (TSIT): The Supreme Court on Thursday stayed a recent University Grants Commission (UGC) regulation after various pleas were filed contending that the Commission adopted a non-inclusionary definition of caste-based discrimination and excluded certain categories from institutional protection.

A bench of Chief Justice Surya Kant and Justice Jyomalya Bagchi issued notices to the Centre and the UGC on the pleas challenging the regulation. The new regulations mandating all higher education institutions to form "equity committees" to look into discrimination complaints and promote equity were notified on January 13.

The University Grants Commission (Promotion of Equity in Higher Education Institutions) Regulations, 2026, mandated that these committees must include members of the Other Backward Classes (OBC), the

Scheduled Castes (SC), the Scheduled Tribes (ST), persons with disabilities, and women.

The new regulations replaces the UGC (Promotion of Equity in Higher Educational Institutions) Regulations, 2012, which was largely advisory in nature.

The pleas assailed the regulation on the grounds that caste-based discrimination is defined strictly as discrimination against members of the SCs, STs and OBCs.

It said that by limiting the scope of "caste-based discrimination" only to SC, ST and OBC categories, the UGC has effectively denied institutional protection and grievance redressal to individuals belonging to the "general" or non-reserved categories who may also face harassment or bias based on their caste identity.

Protests were held at various places against the regulations, with student groups and organisations demanding its immediate rollback.

FM Nirmala tables Economic Survey 2026 in Parliament



New Delhi (TSIT): Finance Minister Nirmala Sitharaman on Thursday tabled the Economic Survey 2026 in Parliament, which will set the official tone on how the economy of the country is performing on a strong note despite global uncertainties and US tariffs. The Economic Survey will reveal India's projected GDP growth estimates for the current fiscal (FY26) as well as the upcoming financial year (FY27).

The key pre-budget document summarises the annual economic development of India and charts out short and medium-term prospects of the economy. Chief Economic Advisor V Anantha Nageswaran will later explain the key findings of policy reforms as stated in the Economic Survey 2026, including key topics like rupee depreciation, geopolitical volatility and more.

Meanwhile, Sitharaman is the first woman to present Union Budget for the ninth consecutive time, making history in the Parliamentary history of the country, Prime Minister Narendra Modi said.

Clean air key to true development, says Bhatti

Hyderabad (TSIT) Deputy Chief Minister Bhatti Vikramarka Mallu said that true development is possible only with clean air and highlighted Telangana's scientific, target-driven approach to improve air quality across the State. He was speaking at a conference on Air Quality Index (AQI) and Air Quality Management, organised by the State Planning Department at the Marri Channa Reddy Human Resource Development Institute (MCRHRD).

Under Chief Minister A. Revanth Reddy's leadership, the government is committed to ensuring a clean and healthy environment for the people, he said. Emphasising that development without environmental protection leads to long-term harm, Bhatti Vikramarka described air quality as a key public health, productivity, and economic indicator, citing studies that rank air pollution as the second leading cause of death globally.

The Deputy CM announced that Telangana has established 40 new air quality monitoring stations, doubling the network for accurate, real-time data. Air Quality Dashboards accessible to the public will be launched soon. He added that the State Clean Air Action Plan 2025 is being implemented to tackle pollution from vehicles, construction, industries, road dust, and open burning. Initiatives include promoting electric vehicles, expanding

public transport, developing charging infrastructure, and introducing vehicle scrapping facilities. On industrial pollution, continuous emission monitoring systems have been linked to Pollution Control Board servers, while cleaner fuels and stricter enforcement

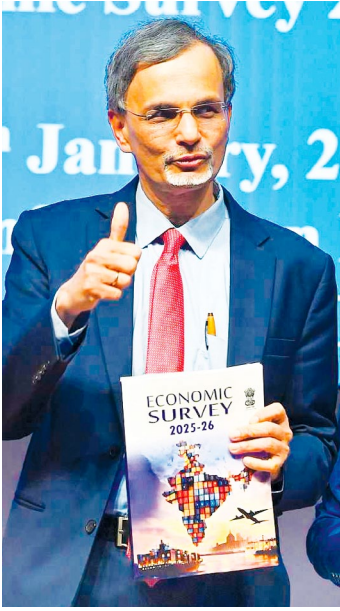
are encouraged. Under the Renewable Energy Policy-2025, Telangana aims to achieve 20,000 MW of renewable energy capacity by 2030.

The Deputy CM also raised concerns over industries operating in residential areas, including Jeedimetla, and announced plans for industrial restructuring, zoning reforms, and better land-use planning. Special response teams will be piloted in two GHMC zones to handle pollution complaints efficiently, with plans to expand statewide. Urging public participation, Bhatti Vikramarka called on citizens, industries, and civil society to adopt eco-friendly practices, emphasising that protecting the environment is a moral duty for future generations.

India to grow 6.8-7.2 % in FY27, 'Swadeshi' growth to be emphasised

New Delhi (TSIT): The Economic Survey, tabled in Parliament on Thursday, projected India's GDP growth at 6.8-7.2% for 2026-27, following an estimated 7.4% growth in the current fiscal year. The survey, prepared under Chief Economic Advisor V. Anantha Nageswaran, noted that policy reforms over recent years have strengthened India's medium-term growth potential to around 7%, with domestic demand emerging as the main driver of expansion.

The report described India as an "oasis of macro stability" in a turbulent global economy. While the outlook is broadly positive, it cautioned that slower global growth, trade wars, and tariff disruptions could weigh on exports and investor sentiment. The survey stressed that initiatives like Make in India serve



dual purposes—protecting domestic production during global shocks while building capabilities—but must not compromise efficiency or integration with global supply chains. Highlighting trade as a key growth enabler, the survey pointed to recent free trade agreements, including the India-EU FTA, as well as deals with the UK, New Zealand, and Oman, which are expected to deepen market access for Indian manufacturers.

The report noted that foreign portfolio investors sold USD 18 billion of Indian shares in 2025, though foreign direct investment surged, mostly via Singapore and Mauritius. Despite a 5.7% fall of the rupee against the dollar over six months, the survey said the currency's weakness reflects capital flow shortages rather than domestic economic weakness.

CM Stalin announces 20% subsidy for textile machinery

COIMBATORE (TSIT): The Chief Minister MK Stalin on Thursday announced a 20 per cent capital subsidy on the purchase of advanced weaving and knitting machinery for textile units.

The Chief Minister, in his address through a video message at the International Textile Summit- 360 in Coimbatore, said the textile firms purchasing state-of-the-art weaving and knitting machinery would be eligible for a 20 per cent capital subsidy with an annual budget allocation of Rs 30 crore under the newly integrated textile policy 2025-26.

"While ensuring inclusive growth and social justice under the Dravidian model of



governance, the State has retained its position as the country's largest exporter of ready-made garments for five consecutive years, accounting for 33 per cent of India's total textile trade, providing direct employment to 31 lakh workers, of whom 60.12 per cent are women," he said, highlighting the State's robust infrastructure and investor friendly ecosystem.

KCR summoned for questioning in phone-tapping case

Hyderabad, Jan 29 : In a significant development in the phone tapping case in Telangana, the Special Investigation Team (SIT) has summoned Bharat Rashtra Samithi (BRS) President and former Chief Minister K. Chandrasekhar Rao. The SIT has issued notice to K. Chandrasekhar Rao (KCR),



directing him to make himself available for questioning at 3 p.m. on Friday (January 30). The SIT officials served the notice at KCR's resident at Nandnagar in Banjara Hills on Thursday.

Considering KCR's age, Investigation Officer P. Venkatagiri has communicated to that he may voluntarily appear before him at the Jubilee Hills Police Station or alternatively may specify any other place within Hyderabad city convenient for examination. The notice, issued under Section 160 of the Criminal Procedure Code, mentioned that during the course of investigation, it has been revealed that he is acquainted with facts and circumstances relevant to the case and hence his examination is necessary.

Sammakka-Sarakka Jatara Is a Tribal Maha Kumbh Union Minister Jual Oram

Hyderabad (TSIT): Union Minister for Tribal Affairs Jual Oram on Thursday described the Sammakka-Sarakka Jatara as the largest tribal festival in the country and a "Tribal Maha Kumbh." Union Minister Jual Oram, along with Union Minister for Coal and Mines G. Kishan Reddy, visited the Medaram temple and offered special prayers to Sammakka-Sarakka, fulfilling their vows Union Ministers were accorded a traditional welcome at the temple entrance by State Ministers Ponguleti Srinivas Reddy, Danasaari Anasuya (Seethakka), and Adhuri Laxman Kumar, amid tribal drum beats. Special rituals were performed, and offerings were made to the goddesses.

Addressing the media, Jual



Oram said he was happy to return to the sacred Jatara after nearly two decades, on the directions of Prime Minister Narendra Modi. He stated that the Union Government is extending full financial support for the development of the region and has arranged special trains for the convenience of devotees.

Highlighting tribal welfare initiatives, the Union Minister said the Centre has allocated 1 lakh crore under the Dharti Aaba Janjatiya Gram Utkarsh Abhiyan, Rs.24,000 crore under the PM Jan-

Man Yojana, and sanctioned 23 Ekalavya Model Residential Schools for Telangana. Union Minister G. Kishan Reddy said the Sammakka-Sarakka Jatara attracts lakhs of devotees from across the country. He thanked the Telangana Government and officials for smooth arrangements and said the Centre and State are jointly undertaking development works, including Rs.80 crore for regional tourism, 140 crore for Ramappa Temple development, and 3.70 crore for this year's Jatara arrangements.

Ajit Pawar cremated with full state honours; Amit Shah, Nabin attend funeral

Baramati (TSIT) The last rites of Maharashtra Deputy Chief Minister Ajit Pawar, killed in a plane crash, were held with full state honours on Thursday at Baramati in Pune district.

Union ministers Amit Shah, Nitin Gadkari, former Union minister Sharad Pawar and BJP president Nitin Nabin attended the 66-year-old Nationalist Congress Party (NCP) chief's funeral at the Vidya Pratishthan ground at Baramati, around 100 km from Pune. Maharashtra CM Devendra Fadnavis and Deputy CM Eknath Shinde were also present, along with Ajit Pawar's wife Sunetra, who is a Rajya Sabha member, and



sons Parth and Jay. Ajit Pawar's cousin Supriya Sule, Lok Sabha member from Baramati, and NCP working president and former Union minister Praful Patel were also present. Parth and Jay lit their

father's funeral pyre. On Thursday morning, the mortal remains of Ajit Pawar were taken from the Punyashlok Ahilyadevi Hospital in Baramati, where they were kept overnight, to his village.

Governor Inaugurates 108-Foot National Flag at Mehdiapatnam Army Garrison

Hyderabad, January 29:Telangana Governor Jishnu Dev Varma inaugurated a 108-foot-high National Flag at the Mehdiapatnam Army Garrison in a ceremony organised by the Indian Army. The event saw senior Army officers, civil dignitaries, veterans, and NCC cadets in attendance, along with a Guard of Honour and the National Anthem.



Addressing the gathering, the Governor paid tribute to the bravery and sacrifices of the Indian Armed Forces, appreciated veterans and Veer Naris, and encouraged NCC cadets to uphold discipline and patriotism. He also thanked Naveen

Jindal, President of the Flag Foundation of India, for sponsoring the high-mast flag. Maj Gen Rahul Dev Sharma said the installation symbolizes strong civil-military collaboration and reinforces the dignity of the National Flag. Officials including Special Chief Secretary C.V. Anand and DGP B. Shivadhar Reddy were present.

Indian Rupee Under Pressure: What
It Means for India in 2026

The Indian rupee is once again under pressure, raising concerns about its impact on the economy in 2026. Warnings that the currency may weaken further against the US dollar have sparked renewed debate among policymakers, economists, and the public. While currency fluctuations are a global phenomenon, their consequences are deeply felt at home. The primary reason for the rupee's weakness lies in the global strength of the US dollar. With the US Federal Reserve maintaining tight monetary policies to curb inflation, investors are shifting funds towards safer, dollar-denominated assets. This has resulted in capital outflows from emerging economies, including India. In addition, ongoing geopolitical tensions and global economic uncertainty have increased risk aversion, further pressuring the rupee. India's trade imbalance also contrib-

utes to the problem. Heavy dependence on imported crude oil, defence equipment, and electronic goods widens the trade deficit. Since oil imports are priced in dollars, any increase in global oil prices directly impacts the rupee and fuels domestic inflation. For the common citizen, a weakening rupee translates into higher prices. Fuel costs rise, pushing up transportation and food prices. Imported goods such as medicines, electronic devices, and educational expenses abroad become costlier, reducing household purchasing power. In effect, currency depreciation acts as an invisible burden on ordinary people. However, a weaker rupee is not without advantages. Export-oriented sectors such as IT services, pharmaceuticals, textiles, and manufacturing benefit as Indian goods become more competitive in global markets. Export earnings increase in rupee terms, offering some relief to businesses. Yet, these benefits are limited if global demand remains sluggish. For the Reserve Bank of India, managing the rupee involves a careful balance. Excessive intervention can drain for-

eign exchange reserves, while limited action risks market volatility. Although India's forex reserves remain strong, they are not a permanent solution. The need of the hour is structural reform. Strengthening domestic manufacturing, attracting stable long-term foreign investment, and diversifying export markets are essential to reduce vulnerability. Fiscal discipline and improved energy security, especially through renewable sources, can also help stabilise the currency in the long run. The rupee's performance in 2026 will serve as a test of India's economic resilience. While global factors are beyond control, sound domestic policies can cushion their impact. A stable rupee is more than a financial indicator—it reflects confidence in the nation's economic direction. As India moves towards becoming a major global economy, protecting currency stability must remain a strategic priority. The challenge is not merely to manage volatility, but to build a stronger, more self-reliant economic foundation capable of withstanding global uncertainty.

Leaders across party lines
hail FM Sitharaman for 9th
consecutive budget



New Delhi, Jan 29 : As Prime Minister Narendra Modi hailed Union Finance Minister Nirmala Sitharaman for becoming the first woman holder of the post to present the Union Budget for the ninth consecutive time, leaders, cutting across party lines, on Thursday backed him and said the milestone reflects the growing power and participation of women in India's public life. Speaking to IANS outside Parliament, AAP Rajya Sabha member Ashok Kumar Mittal said that women reaching top positions and contributing meaningfully to the nation is a strong reflection of women's empowerment. "When women in India rise to positions of responsibility and serve the country, it highlights the strength of women. This is something that deserves appreciation. We must encourage and enable more women to move forward. The Women's Reservation Bill has already been passed,

under which one-third of the seats will be reserved for women, which is a major step," he said. However, some Congress leaders underlined that while the achievement is noteworthy, the focus must remain on the substance of the Budget. Congress MP Deepender Singh Hooda said: "It is a good thing that she is presenting the Budget for the ninth time, but we hope that this Budget is prepared keeping the public in mind. The country is facing several challenges today. The value of the Indian rupee has weakened, unemployment remains a concern, and people are struggling with inflation. The economy is under pressure from multiple directions. In such a situation, it is important that this Budget provides real relief to the common people." Congress MP Vivek Tankha also acknowledged Sitharaman's role, recalling a previous interaction with her.

Hasina slams Bangladesh polls from India, warns
of instability after Awami League barred

Dhaka, Jan 29: Bangladesh's ousted Prime Minister Sheikh Hasina has criticised the country's upcoming election, warning that the February 12 polls could trigger prolonged instability after her party, the Awami League, was barred from contesting. Speaking from exile in India, Hasina told The Associated Press in an email last week that Bangladesh urgently needs "inclusive, free and fair elections," and claimed the interim government led by Nobel Peace Prize laureate Muhammad Yunus has deliberately disenfranchised millions of Awami

League supporters by excluding the party from the vote. "Each time political participation is denied to a significant portion of the population, it deepens resentment, delegitimizes institutions and creates the conditions for future instability," Hasina said, adding that "a government born of exclusion cannot unite a divided nation." Bangladesh, where more than 127 million people are eligible to vote, is heading into what is being seen as the most consequential election in decades — the first since Hasina fled to India on August 5, 2024, following weeks of unrest and a mass



uprising that ended her 15-year rule. Yunus assumed charge three days later and has pledged to ensure a free and fair election. However, concerns have been raised by critics and rights groups over the inclusivity of the process, security arrangements, and uncertainty sur-

rounding a proposed constitutional referendum on sweeping political reforms. Yunus' office said security forces will ensure an orderly election and prevent coercion or violence. The administration has also invited international observers and human rights organisations to monitor the polls. The Election Commission has stated that around 500 foreign observers, including representatives from the European Union and the Commonwealth, are expected to be present. Since Hasina's removal, Bangladesh has faced mounting political and security challenges, with allegations of

rights violations and growing fears over the rising influence of Islamist groups. Minority organisations have raised concerns over attacks, particularly against Hindus, while media freedom has also come under the spotlight, with journalists facing criminal cases and reports of attacks on major newspaper offices. The Bangladesh Nationalist Party (BNP), led by Tarique Rahman, has emerged as a key contender in the election. Rahman, son of former Prime Minister Khaleda Zia, returned to Bangladesh in December after more than 17 years in exile and has promised stability for the nation of 170 million people. His main

challenge is expected from a coalition of 11 groups led by the Islamist Jamaat-e-Islami. Hasina, who was sentenced to death in absentia over her government's crackdown on the 2024 student uprising, dismissed the trial as a "kangaroo court," while international rights groups have expressed concern over the fairness of proceedings. Calling for an end to the cycle of bans and boycotts in Bangladesh politics, Hasina said the country needs a "legitimate government" that rules "with the genuine consent of the people," which she described as the only way for the nation to heal and move forward.

Kerala: Frontline workers get
Rs 1,000 hike; major welfare, infrastructure initiatives unveiled

Thiruvananthapuram, Jan 29: The Kerala Budget 2026-27, presented by Finance Minister K. N. Balagopal on Thursday, has brought a major relief for ASHAs, anganwadi workers, pre-primary teachers, and literacy instructors with a monthly honorarium hike of Rs 1,000, as the state gears up for Assembly elections in the coming months. In addition, anganwadi helpers will receive an extra Rs 500 per month, and noon-meal cooks will get a Rs 25 hike in daily wages. The Finance Minister also assured that Dearness Allowance and Dearness Relief (DA/DR)



for government employees and pensioners would be expedited. From April 2026, the honorarium for elected representatives of local bodies will be enhanced, and a welfare fund board with a corpus of Rs 250 crore will be set up for their benefit. For the first time in India, Kerala will also present an elderly budget document alongside the main budget.

Punjab police and BSF foil cross-border
smuggling, seize heroin and firearms

Chandigarh, Jan 29: In a significant security operation, Punjab Police's Counter Intelligence (CI) Faridkot, in coordination with the Border Security Force (BSF), successfully intercepted a cross-border smuggling attempt along the Fazilka district border, recovering 2.1 kg of heroin and 21 high-powered pistols with ammunition, officials said on Thursday. According to DGP Gaurav Yadav, the seized weapons include 11 Glock pistols with 22 magazines, one Beretta with one magazine, five Zigana pistols with 10 magazines, three Norinco pistols with five magazines, one Ghaffar



Security (MP-5 type) pistol with a magazine, and 310 rounds of 9mm ammunition. Preliminary investigations suggest that Pakistan-based smugglers crossed the zero line, attempting to exploit dense fog and nighttime conditions to transport arms and narcotics into India. Alert BSF troops

fired warning rounds to stop the breach, and a joint search operation led to the recovery of the consignment. Assistant Inspector General Gursewak Singh Brar said the operation was carried out following reliable intelligence inputs, with a special ambush planned in Teja

Ruhela village, Fazilka. The swift response by the BSF and police teams prevented the consignment from entering Indian territory. Authorities confirmed that further investigations are ongoing to identify local accomplices and dismantle the entire smuggling network. An FIR has been filed under Sections 21-C and 29 of the NDPS Act and Section 25 of the Arms Act in Fazilka. DGP Yadav emphasized that the Punjab Police remain vigilant and are committed to zero tolerance against cross-border crimes, ensuring the security of the state.

Kolkata man loses Rs 3.35 crore in stock
scam, cyber police arrest key accused

Kolkata, Jan 29: The Kolkata Police have arrested a man from West Bengal's South 24 Parganas district in connection with a massive cyber fraud that allegedly duped a city resident of Rs 3.35 crore by promising lucrative stock market returns.



The accused, Hasan Molla, was taken into custody following an investigation by the Cyber Crime branch, police officials confirmed on Thursday. According to investigators, the victim, Ashish Kumar Ghora (56), a resident of Entally in central Kolkata, was allegedly drawn into a WhatsApp group that projected itself as a legitimate investment advisory platform. The

group promised exceptionally high returns within a short span, persuading Ghora to transfer large sums of money to multiple bank accounts as directed by its administrators. Police sources said the WhatsApp group contained several members and regularly shared stock market tips, creating an illusion of credibility and active trading. Trusting the assurances, the victim

reportedly transferred around Rs 3.35 crore over time. Trouble began when Ghora attempted to withdraw his funds and found himself unable to do so. Realising he had been cheated, he approached the Cyber Crime branch of the Kolkata Police and lodged a formal complaint. During the probe, investigators discovered that the accused allegedly used forged identities and fake logos of regulatory bodies such as the Securities and Exchange Board of India (SEBI) and the US Securities and Exchange Commission (SEC) to make the scheme appear authentic. Fake documents were also allegedly circulated to win the victim's confidence.

DEALS WITH EU AND UK
GIVE TIPPLERS AND TRADE
REASONS TO BE HIGH

Alcoholic beverages may not figure among the top ten exports from the 27-nation European Union (EU) to India, but the Free Trade Agreement (FTA) signed on Tuesday, January 27, read along with the India-UK Comprehensive Economic and Trade Agreement (CETA) okayed on July 24, 2025, has raised the spirits of the liquor trade and tipplers in India by several pegs. The most obvious benefit, according to industry insiders, is the growing access the market will now have to a greater variety of alcobev brands, from whisky, vodka and beer to wines, cognacs and liqueurs, at lower prices. This positivity stems from the significant reduction of tariffs on spirits (from up to 150% down to 40%), wines (150% to 20% on the premium range; medium range, 30%), and beer (110% to 50%).

The India-UK CETA, meanwhile, promises an immediate reduction of the tariff on India's much-loved Scotch whiskies from the present 150% to 75% next year and further down to 40% in another ten years. India is the No. 1 consumer of Scotch whiskies in the world, having toppled France from that position in 2023. Scotch today accounts for just 3% of India's exploding whisky market, but the Scotch Whisky Association, which has for long being lobbying for tariff reductions, sees India, in the post-CETA world, importing an additional £1 billion worth of Scotch over the next five years. "If that materialises, it won't just shift market dynamics, it could reshape the global Scotch landscape," says Cask Trade, the official mouthpiece of the Masters of Whisky Appreciation, a group of top-end collectors of cask whiskies. "A bottle of Johnnie Walker, once sold in India at around £60, could now be found for £40 as a result of the new tariff reductions." Cask Trade notes optimistically. "Though still expensive compared to locally produced spirits, that reduction will put imported Scotch within reach of tens of millions more consumers." It is how the world now views the Indian Scotch whisky market. Significantly, India's Scotch whisky imports, as Cask Trade points out, includes a substantial percentage of the 'bulk blend' category, which is mixed with local spirits and bottled under blended labels such as 100 Pipers and Royal Stag. It will be cheaper, as a result, to produce premium domestic whiskies, but will the large alcohol companies pass the benefit on to the consumer? That remains to be seen.

Forays by Indian companies into the international Scotch and Irish whisky markets also stand to benefit from the new business environment. It will be interesting to see how the ADS Group's entry into the Irish whiskey market with its brand The Irish Smith, produced in Ireland's Great Northern Distillery by industry veterans John Teeling and Brian Mongan, pans out after the European Parliament adopts the FTA (almost certainly in 2027). Likewise, Radico Khaitan, which has just announced that it will set up a Scotch whisky subsidiary in Scotland, will stand to benefit from the new tariff regime – it gains access into the European market and at the same time can take advantage of lowered tariffs if and when it decides to export its Scotch whisky from Scotland to India.

India's love for premium international alcohol brands, in tune with the rising aspirations of the country's upwardly (and outwardly) mobile class, is not limited to Scotch. Russian vodka exports to India, for instance, are reported to have experienced a 4x surge in 2025. The domestic industry does see it as a threat, but imported premium wines and spirits at present account for a small (albeit fast-growing) segment of the alcobev business in the country. Increases in imports, moreover, are not expected to happen overnight and are most likely to be absorbed by a growing market.

An India Miscalculation, And Ego: Inside
Bangladesh's Costly World Cup Exit

Like everything else, the landscape of global cricket has also changed over the decades. And like in most things of modern life, change has (amongst other things) ushered in heavy doses of chaos, anxiety and bad blood. Gone are the days when a cricket rivalry meant only an on-field battle of skills and nerves between two very talented groups of players. When people would gather in living rooms, in clubs, at roadside tea stalls, in college grounds, etc. to talk about which batter is in red hot form, or which bowler has the skills to torment an opposition batting line-up, or which captain has more tricks up her or his sleeve. Now, the 'rivalry' that is mainly talked about and makes headlines, often well before a tournament commences, is the off-field clashes between countries, cricket boards and officials. Sure, the purists still exist, but they are outnumbered. Trying to keep sports separate from politics is now a futile exercise. In the upcoming ICC men's T20 World Cup, cricketers of a talented team which had officially qualified have been robbed of a chance to play and entertain fans on the biggest stage of them all. Along with that, the almost 18 crore people of that country, where cricket has become an intrinsic part of national identity, will now not get to see their heroes in action. Bangladesh were drawn with England, the West Indies, Nepal and Italy, in Group C of the upcoming World Cup, which will be played in India and Sri Lanka. The Bangla Tigers are the third-highest ranked team in that group and in the extremely fickle T20 format, they could have potentially made it to the Super Eight stage, with one good day's worth of cricket. Beyond that, who knows what could have happened. Now, all that is just a hypothesis, which is a crying shame. India and Sri Lanka were announced as co-hosts in November 2021 as part of the ICC's 2024-2031 cycle of men's tournaments. There were credible reports of the Hindu community in Bangladesh being targeted from August 2024. So, timing-wise, the biggest questions that need to be asked are... If the Bangladesh Cricket Board (BCB) and the Bangladesh government thought that there was a genuine security threat to their players in India, why weren't these concerns raised earlier? Why did their interim government direct the BCB to ask the ICC for a venue change for



their matches scheduled to be played in India exactly a day after the Kolkata Knight Riders released Bangladesh fast bowler Mustafizur Rahman from their IPL 2026 squad (Mustafizur was released on January 3, 2026 and the BCB asked for a venue change on January 4)? Did the BCB confer with the BCCI about this directly? Why did the interim Bangladesh government ban all IPL broadcast and promotions indefinitely - what possible connection does this have with player security in India? Though the reason given for this was "in public interest", this was widely seen as a tit-for-tat retaliation to Mustafizur, the only Bangladeshi player in IPL 2026, being told he can't play in the IPL this season. At this end, could the entire Mustafizur episode have been handled better? Absolutely. Everyone knew just how volatile the situation was in Bangladesh ever since the first anti-establishment protests began against Sheikh Hasina's government in July 2024, which quickly spiralled from peaceful demands to violent clashes. The safest thing to do, to avoid public backlash of any kind in India against Bangladeshi players, would have been not to include Mustafizur in the player auction. Instead, he was included, the Kolkata Knight Riders spent as much as Rs 9.20 crore to buy him, and then the franchise was asked to release him. Bangladesh clearly viewed this as being extremely humiliating. It also made things worse in terms of the diplomatic

standoff. So, could this entire fiasco be avoided? It would have been unfair to Mustafizur himself, of course, but it would have been infinitely better to explain things to him at that stage instead of telling him, after he had secured a team and good money, that he couldn't play. However, what the Bangladesh regime also needed to understand was that they cannot turn this into an ego battle, for the health of their cricket. There was just too much at stake. Despite being given assurances by the ICC of heavy security for their players and staff, while in India, and an ICC internal security assessment that showed no specific threat to their team, Bangladesh risked a bit too much by sticking to their stance of threatening to pull out of the World Cup. And ironically, at the end of the day, their attempt to salvage lost pride has backfired spectacularly and only meant more humiliation, with the ICC promptly replacing them with Scotland in the tournament.

Those in Bangladesh who are taking these decisions need to understand the reality of the times we live in. The ripple effects, financial and otherwise, are going to be enormous. According to reports, there is the participation fee of \$3 million or approximately 36.33 crore Bangladeshi Taka that they will not receive, along with any prize money that the team and the players would have potentially earned. The big blow will be the cut of ICC's central

revenue. Bangladesh receives a 4.46% cut of ICC's annual revenue pie, which translates to about \$27-30 million, going by recent projections. That's almost 60% of BCB's annual income that they have jeopardised. Also, by deciding to stick to their guns and not play the World Cup unless their last-minute demands for change of venue for their matches are met, Bangladesh will also be hit with a \$2 million fine by the ICC. Under the ICC Member Participation Agreement, any member nation that withdraws from a tournament without any justified cause will be hit with this fine. Add to that the almost 300 crore BDT loss for the host broadcaster in the country, other losses in advertisement revenue and Bangladeshi players potentially losing endorsement deals with Indian companies. After all, in the modern game, visibility is the sponsors' holy grail. Time heals almost everything, and perhaps the BCB will somehow tide over the financial repercussions. But what they have also severely risked is India's future bilateral cricket association with their neighbours, or, in other words, millions more in cricketing and broadcast revenue. Regardless of which direction strictly diplomatic relations between the two countries are headed, cricketing relations going forward could well be strained. India are scheduled to tour Bangladesh later this year (the white-ball tour was postponed from August 2025 to September 2026).

Beyond Ajit Pawar: What Happens To
Sharad Pawar's 'Succession' Plan Now?

It's too early to write the obituary of the Nationalist Congress Party (NCP), but the sudden death of Ajit Pawar in a plane crash is undoubtedly a near fatal blow for both factions of the party as well as the family that has controlled the politics of western Maharashtra's sugar belt and its wealthy cooperatives for more than four decades. The timing could not be worse. Ajit Pawar's demise comes at a critical phase in the NCP's evolution after the 2023 split, which tore the party into two and divided one of Maharashtra's foremost political dynasties, pitting nephew against uncle to upturn party patriarch Sharad Pawar's carefully laid succession plan. Firstly, the two factions (one led by Ajit Pawar and the other by Sharad Pawar) are still reeling from the shock of a virtual wipeout in their bastions of Pune and Pimpri-Chinchwad in the recent corporation elections. The Bharatiya Janata Party (BJP) captured both, and the sweep of its victories poses an existential challenge for the two NCPs, as well as the Pawar family possibly. What About The Unification? Secondly, plans for reunification are now up in the air. It was Ajit Pawar who had reached out to his uncle for a merger before the corporation elections following differences with the BJP over seat-sharing. They had agreed on a step-by-step approach. The first step was to forge an alliance for the corporation polls. The next was to contest the upcoming zilla parishad elections on the same symbol. Uncle and



nephew had agreed to use the clock symbol, which the Election Commission had taken away from Sharad Pawar and handed to Ajit Pawar's party. After that, reunification was a mere formality, expected to be completed after the local polls were done. Now, it's anybody's guess whether or not the process will be completed. Much depends on which way Ajit Pawar's 41 MLAs move in the coming weeks. Without his towering presence, they are pretty much orphaned. Given the manner in which Maharashtra parties have splintered since 2022, there is a strong possibility that they will either scatter in different directions or be welcomed wholesale by the BJP. Not that the BJP needs those numbers. Despite the death of one of its two Deputy Chief Ministers, there is no threat to the stability of the Devendra Fadnavis-led Nationalist Democratic Alliance (NDA) state government. The BJP has 131 MLAs of its own. It also has the support of the seven MLAs it had helped

win the last year's assembly election. This brings the BJP's tally to 138, just seven short of the halfway mark of 145. Eknath Shinde's faction of the Shiv Sena adds another 57 MLAs to the NDA's strength in the assembly. While on the face of it, this would seem to make the Shinde Sena indispensable for the government's survival, the party's poor showing in the recent corporation polls has made it vulnerable, leaving it with little room for manoeuvre within the alliance. A Dilemma For BJP There are opportunities as well as challenges for the BJP in Ajit Pawar's unexpected demise. His NCP proved useful as a balancing force against Shinde's Sena. In fact, it was Ajit Pawar's unconditional support that cleared the way for Fadnavis to become the Chief Minister despite Shinde's tantrums and pressure tactics. Every time Shinde tried to rock the boat subsequently, Ajit Pawar came in handy to make him toe the line. In a sense, Fadnavis and the BJP have

lost a valuable ally. Yet, Ajit Pawar's death can also be seen as fortuitous for the BJP's long-term ambition to be the single dominant force in Maharashtra and form a government on its own strength in the next assembly election. Ajit Pawar was groomed by Sharad Pawar from the early 1990s as his heir apparent. He not only familiarised himself with every nook and corner of the state, its demographics, caste composition and its geography, but also learnt from his uncle his canny political skills and the art of managing Maharashtra's complex dynamics. Although Sharad Pawar inducted his daughter Supriya Sule into politics, there was an unstated arrangement within the family that she would be the NCP's face at the Centre where her consummate skills as a parliamentarian and her talent for making friends across the political divide (which she seems to have inherited from her father) would prove useful for the party.

"Crack Team, Internal Unity": Inside
BJP's Bengal Election War Room

As the political adagio of West Bengal builds towards the upcoming assembly elections in March-April 2026, one cannot help but observe the intricate dance of ambition, identity, and power at play. The Bharatiya Janata Party (BJP), a party with an eye firmly trained on national significance, finds itself poised at a critical juncture, seeking to wrest Bengal from the entrenched grasp of the Trinamool Congress (TMC) led by Mamata Banerjee. The BJP's historical absence from the corridors of power in Kolkata is set against a backdrop of an electoral landscape in flux, where 2021's results revealed that the party is still nearly 10 percentage points adrift from the TMC. However, the BJP's impressive growth trajectory in Bengal from 4 seats in the 2016 assembly polls to 77 seats, out of 294, in the 2021 polls, tells a story of an extraordinary surge, beyond its traditional base of the Hindi heartland. Amit Shah's impending visit to focus on Internal Unity: The Imperative for Cohesion The internal dynamics of the BJP will also shape the electoral narrative. Amit Shah's forthcoming visit (on 30th and 31st January) - aimed at fostering unity and quelling factionalism-illustrates a critical recognition of the need for cohesion. In a political arena as turbulent as West Bengal, the fragility of internal alliances could be the Achilles' heel of any electoral endeavour. The previously sidelined former state president Dilip Ghosh and the assertive Leader of the Opposition in the state assembly, Suwendu Adhikari, emerge as key figures in the



push for collective leadership - a necessity that the party must articulate, lest it be exploited by the TMC, which has historically thrived on the politics of fragmentation. In a personal meeting with Amit Shah, Dilip Ghosh, at the end of December 2025, pointed out that "West Bengal is ready for change, but the BJP party is not ready yet." While mollifying Dilip Ghosh and roping him into active campaign mode, Shah had emphasised internal unity and the imperative for cohesion. Amit Shah is planning to hold a State Core Committee meeting in Kolkata, visit Anandpur Math in Barrackpore and a programme in the northern district of Siliguri.

● **The BJP's Ideological Evolution** In the vast and variegated tableau of Indian politics, the BJP stands as a striking testament to the enduring power of ideological lineage. At its core, the BJP is intertwined with the legacy of Shyama Prasad Mukherjee, a founder of the Bharatiya Jana Sangh in 1951, whose vision of a unit-

ed India finds itself reborn in the party's current narrative. Alongside Mukherjee's contributions, the spirit of Bankim Chandra Chattopadhyaya's Anand Math, with its evocative hymn "Vande Mataram," resonates profoundly-echoing aspirations of nationalism, unity, and identity that continue to serve as the party's ideological compass.

● **The Demographic Landscape** West Bengal presents a particularly intricate tableau, marked by its demographic stratifications. Muslims constitute around 32 per cent of the electorate in 2026 (27 per cent according to the 2011 Census), largely anchored to the TMC, while Hindus represent approximately 68 per cent, with about 50 per cent of them reportedly leaning towards the BJP. "The BJP's ambition to capture at least 60 to 65 per cent of the Hindu vote, necessitating a strategic swing of at least 5 plus per cent, underscores the party's awareness that political dominance is as much about arithmetic as it is about

the narratives that resonate with diverse community identities," says Dr Swapan Dasgupta, a member of the newly constituted Manifesto Committee. In this light, the BJP's approach is not merely a matter of winning votes; it involves cultivating a profound understanding of the socio-cultural dynamics that etch the contours of political allegiance. The party's efforts to engage different Hindu sects (the Matuas, the Rajbongshis among the Schedule Caste population, drawing on historical grievances and aspirations as well as the Bhadrolok upper castes) point toward a realisation that winning hearts must precede winning seats. Therefore, serious attempts to implement the Citizenship Amendment Act (CAA) and ensure that the Matuas get the right to vote under the SIR scheme. The CAA provides a legal pathway to Indian citizenship for the Matua community-a Hindu Dalit sect (Namasudras) - who migrated from Bangladesh due to religious persecution.

Karnataka to Host First-Ever Exclusive Job Fair for Persons with Disabilities: Dr Sharanaprakash Patil

Bengaluru: In a major initiative to empower persons with disabilities and integrate them into the social and economic mainstream, the Karnataka government will organise the state's first exclusive job fair for persons with disabilities. The mega event will be held at Kanteerava Stadium in Bengaluru within the next three months, said Minister for Skill Development, Livelihood, Medical Education and Raichur District In-charge Dr



Sharanaprakash R. Patil. Responding to a question by BJP MLA Gururaj Shetty Ganthole during the Question Hour in the Legislative Assembly, the minister said the job fair is being organised by the Department of Skill Development and Livelihood and described it as a novel and significant initiative of the state government.

Dr Patil said the objective of the programme is to make persons with disabilities economically self-reliant by providing suitable employment opportunities. During the current financial year, the Karnataka Skill Development Corporation (KSDC) is implementing market-oriented vocational training programmes for 1,000 persons with disabilities at a cost of Rs.3 crore, including skill training, tool kits, and employment support. He added that reservation for persons with disabilities in training programmes has been increased from 3 per cent to 5 per cent, and entrepreneurship development programmes are also being conducted. From 2017-18 to 2024-25, 540 candidates with disabilities received training, of whom 83 secured jobs, he informed.

Court Order Once Again Proves Siddaramaiah's Integrity: S. Manohar



Bengaluru: KPCC General Secretary S. Manohar said that a recent court order has once again proved that Chief Minister Siddaramaiah is a "pure and honest leader." He was speaking after attending a special puja organised by Congress workers at Bhagwan Sri Maruti Mandir near Bala Bruhi Guest House, following Siddaramaiah receiving a clean chit in the Mysore Development Authority (MUDA) case. Manohar stated that false allegations were made regarding land allotted to Siddaramaiah's wife, Smt. Parvati, and that the Lokayukta investigation had clearly found no irregularities in the matter. He said the court rejected the appeal filed by Sneha Mahi Krishna against the Lokayukta's findings and upheld the clean chit given to Siddaramaiah. He added that with the court confirming that no family member was involved in any wrongdoing, Congress workers organised the special puja to pray for Siddaramaiah's continued strength and leadership. Several Congress leaders, including A. Anand, G. Prakash, Chandrashekhara, Kushal Harvegowda, Naveen Sunkatakatte, Umesh, Sai Naveen, Puttaraju, Praveen Rao, Hemraj, and party workers participated in the programme.

Congress Govt Misused Public Money, Insulted Mahatma Gandhi: R. Ashoka

Bengaluru (TSIT): Leader of the Opposition R. Ashoka strongly criticised the Congress government, alleging that it misused people's tax money and insulted Mahatma Gandhi by publishing advertisements carrying statements of Gandhi never made.

Speaking to reporters, Ashoka said the Congress government released newspaper advertisements on the VBG Ram Ji scheme, attributing statements made by Rahul Gandhi to Mahatma Gandhi by using his image. He termed this a serious misuse of public funds and an attempt to



mislead people by portraying party views as Gandhi's words. Ashoka stated that while laws can be debated in Parliament, criticising them through government-funded advertisements after implementation is unethical.

He alleged that the Congress government, influenced by Rahul Gandhi, distorted facts and disrespected Gandhi's legacy. He recalled that Mahatma Gandhi himself

had once suggested dissolving the Congress after independence.

He further alleged corruption in earlier employment guarantee schemes, citing statements by former Prime Minister Manmohan Singh, Congress leader Jairam Ramesh, and CAG reports on irregularities. He said the Centre introduced transparent reforms to prevent misuse, but the state Congress government chose to politicise the issue. Calling the use of Gandhi's image without permission illegal and immoral, Ashoka said the BJP would strongly oppose and fight against such actions.

India-Canada Talks on Clean Mobility and Critical Minerals Yield Positive Outcomes: H.D. Kumaraswamy



New Delhi : Under the vision of Prime Minister Narendra Modi and aligned with Viksit Bharat@2047 and Net Zero targets, Union Minister for Heavy Industries and Steel H.D. Kumaraswamy held a high-level bilateral meeting with a Canadian delegation led by Natural Resources Minister Tim Hodgson at Udyog Bhawan to strengthen cooperation in clean mobility, critical minerals, and sustainable industrial development.

The Minister highlighted India's rapid progress in automobile and electric mobility sectors, citing initiatives such as FAME-II, PM E-DRIVE, and PM e-Bus Sewa, which are boosting EV adoption, charging infrastructure, and domestic manufacturing. He also emphasized India's nearly USD 2 billion incentive programme for Advanced Chemistry Cell manufacturing and the need for

secure supply chains for critical minerals.

Discussions focused on collaboration in battery manufacturing, next-generation technologies, research and development, and access to minerals like lithium, cobalt, graphite, and rare earth elements. The Canadian side appreciated India's leadership in clean mobility and expressed willingness to share advanced battery technologies and support mineral requirements for India's green transition. Senior officials from the Ministries of Heavy Industries, Steel, External Affairs, and leading PSUs participated in the meeting. Both sides agreed to continue structured follow-ups and industry-level engagements to translate discussions into concrete partnerships, reaffirming a strong and future-ready India-Canada strategic collaboration.

Congress Has No Moral Right to Speak on Mahatma Gandhi: BJP State President B.Y. Vijayendra

Bengaluru: BJP State President and MLA B.Y. Vijayendra strongly criticised the Congress-led state government, alleging misuse of taxpayers' money to spread false information and incite people against the Central Government. He objected to front-page newspaper advertisements released by the state government opposing the Central Government's V.B.G. Ramji Act.

Addressing the media, Vijayendra said the advertisements were filled with misinformation and claimed that had the Congress issued them using party funds, there would have been no objection. However, using public money for political propaganda was an "unpardonable crime," he said.

He alleged that the Congress government had shown disrespect to Mahatma Gandhi by falsely projecting that the Central Government and Prime Minister Narendra



Modi had insulted Gandhi. "The Congress has no moral authority to speak about Mahatma Gandhi," he asserted, accusing the government of attempting to mislead people and create anarchy in the state. Vijayendra further alleged that the state government had no significant achievements to highlight and was using advertisements to cover up its failures. He questioned the government's priorities, citing its inability to mobilise funds for its own guarantees while planning to increase bar licences.

Follow the Path of Fairness to Succeed in Life and Sports: MP Basavaraj Bommai

Delayed but right step, CM Stalin welcomes UGC regulations

He urged the Union government not to succumb to pressure to dilute the regulations or their core intent and expressed apprehension about institutional leadership aligned with particular ideological groups.

CHENNAI: Chief Minister MK Stalin on Thursday said the UGC (Promotion of Equity in Higher Education Institutions) Regulations, 2026, were a delayed but welcome step towards reforming a higher education system affected by deep-rooted discrimination and institutional apathy.

In a statement, the Chief Minister said there had been a visible rise in student suicides in higher education institutions in recent years, particularly among SC and ST students, and instances of harassment targeting students from South India, Kashmir and minority communities.



In this backdrop, equity safeguards were not optional but an unavoidable necessity, he said.

Welcoming the stated objective of dismantling caste-based discrimination and extending the framework to include OBC students, Stalin said the backlash against the

new regulations reflected a regressive mindset, similar to the opposition witnessed during the implementation of the Mandal Commission recommendations. He urged the Union government not to succumb to pressure to dilute the regulations or their core intent and

expressed apprehension about institutional leadership aligned with particular ideological groups. "If the Union government is serious about preventing student deaths, ending discrimination and reducing dropout rates among students from backward communities, these regulations must not only be retained but strengthened, revised to address structural gaps, and enforced with real accountability," the Chief Minister said. He added that meaningful reform in higher education would depend not merely on policy announcements, but on effective and transparent implementation across institutions.

EPS rules out OPS's return to AIADMK

CHENNAI: AIADMK general secretary Edappadi K Palaniswami (EPS) on Thursday ruled out the return of former Chief Minister O Panneerselvam (OPS), saying he had been removed from the party's primary membership through a General Council resolution.

Speaking to reporters in Salem, EPS also said alliance talks with other parties were under way and that seat-sharing would be finalised after discussions.

Earlier in the day, OPS called for the reunification of the AIADMK ahead of the Assembly elections after holding consultations with supporters in Kailasapatti in Theni district.

List action on protestors, asks Supreme Court

NEW DELHI: The Supreme Court on Wednesday sought the Tamil Nadu government's response on a plea for action on protestors who allegedly made caste and religion-based defamatory remarks against Justice GR Swaminathan of Madras High Court following his order allowing the lighting of 'Karthigai Deepam' on the Tiruparankundram hill.

A bench comprising justices Aravind Kumar and PB Varale issued notices to the state government, Director General of Police, Chennai Commissioner of Police and others. The top

court directed the state government to file a status report in the matter and posted the case for hearing on February 2.

The SC was hearing a petition filed by advocate GS Mani alleging that ruling DMK-supported parties, including communist parties, along with certain individuals and lawyers, conducted illegal protests not only in public places but also within the premises of the Madras High Court at Chennai and Madurai, making highly contemptuous remarks against Justice Swaminathan. It alleged that the "caste and reli-

gion-based defamatory remarks" were made with the intention of disturbing social harmony and provoking law and order and communal unrest.

The plea sought directions to the State and police to initiate strict legal action, including criminal proceedings, against those responsible for such acts. On December 1, Justice Swaminathan allowed writ petitions that sought a direction for appropriate arrangements to light the Karthigai Deepam at the 'Deepathoon' on the Tiruparankundram hill-ock close to a dargah.

Childhood trauma increases risk of chronic pain in adulthood

Physical, sexual, or emotional abuse, or neglect, either alone or combined with other types of childhood trauma, increases the risk of chronic pain and related disability in adulthood, according to a new research.

The new findings underscore the urgency of addressing adverse childhood experiences (ACEs) – potentially traumatic events that occur before 18 years of age – and taking steps to mitigate their long-term impact on people's health.

ACEs may affect a child or teenager directly through physical, sexual, or emotional abuse, or neglect – or indirectly through exposure to environmental factors like domestic violence, living with substance abuse or parental loss.

Chronic pain is one of the



leading causes of disability worldwide. Long-term painful conditions such as low back pain, arthritis, headache and migraine, can affect a person's daily functioning to the point they can't work, eat properly, or participate in physical activities. For the study, published in the European Journal of Psychotraumatology, the team conducted a systemat-

ic review that included 85 studies. Of those, results from 57 studies could be pooled in meta-analyses.

They found that individuals exposed to a direct ACE, whether physical, sexual, or emotional abuse, or neglect, were 45 per cent more likely to report chronic pain in adulthood compared to those not exposed.

Childhood physical abuse was associated with a higher likelihood of reporting both chronic pain and pain-related disability.

The odds of reporting chronic pain or pain-related disability in adulthood increased with exposure to any direct ACE, either alone or combined with indirect ACEs.

The risk of reporting chronic pain in adulthood significantly increased from exposure to one ACE to four

or more ACEs. "These results underscore the urgency of addressing ACEs, particularly in light of their prevalence and health repercussions," said Prof Jan Hartvigsen, from the University of Southern Denmark.

"A more nuanced understanding of the precise relationship between ACEs and chronic pain will empower healthcare professionals and policymakers to devise targeted strategies to help diminish the long-term impact of early-life adversity on adult health."

The researchers proposed that future research should delve into the biological mechanisms through which ACEs affect health across the lifespan, aiming to deepen understanding and develop ways to mitigate their impact.

Fragile state of women's safety, BJP blasts DMK government on Nandanam incident

CHENNAI: Following the alleged gang rape of a young woman on the campus of Government Arts and Science College in Nandanam, the BJP on Thursday launched a sharp attack on the DMK government.

The saffron party noted that the incident was yet another grim marker of "breakdown of law and order and women's safety" in Tamil Nadu.

In a statement, BJP state president Nainar Nagenthran said Tamil Nadu was witnessing a disturbing pattern of sexual crimes under the DMK regime. Referring to a recent crime involving the wife of a migrant worker in Taramani, he said that before the



wounds of that brutal incident could heal, reports emerged of a young woman employed as a canteen helper being sexually assaulted within a college campus.

"Such a crime allegedly occurring inside an educational institution is shocking and deeply distressing," the BJP leader

said. Questioning the government's claims on governance, Nainar asked whether educational spaces meant to uphold values and safety were being allowed to turn into dens of predators. He alleged that despite repeated assurances by Chief Minister MK Stalin on cracking

down on crimes against women, sexual violence in the State had risen to unprecedented levels.

Senior BJP leader Tamilisai Soundararajan linked the surge in violent crimes to the growing menace of narcotics. "While the Chief Minister speaks of struggle, the reality is that everyday life itself has become a struggle for the people. This is not a political comment, but an expression of shock," she said.

BJP general council member K Annamalai said the reported assault of a 22-year-old woman working in the college canteen had exposed the fragile state of women's safety even within educational institutions.

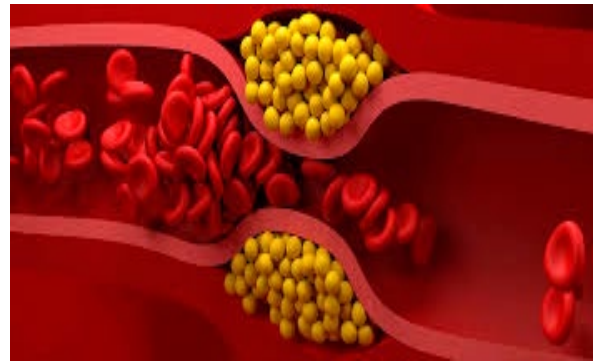

New low-cost vax to lower cholesterol a 'game-changer': Study

New York: Researchers have developed a new vaccine that could be a game-changer, providing an inexpensive method to lower "bad" LDL cholesterol, which creates dangerous plaques that can block blood vessels. High cholesterol contributes to a higher risk of cardiovascular diseases, such as heart disease and stroke. Worldwide cardiovascular diseases claim nearly 18 million lives every year, according to the World Health Organization.

The new vaccines, detailed in a paper published in the journal npj Vaccines, lowered LDL cholesterol almost as effectively as an expensive class of drugs known as PCSK9 inhibitors. "We are interested in trying to develop another approach that would be less expensive and more broadly applicable, not just in the US, but also in places that don't have the resources to afford these



very, very expensive therapies," said Bryce Chackerian, Professor in the Department of Molecular Genetics and Microbiology, at The University of New Mexico (UNM). The PCSK9 monoclonal shot targets the PCSK9 protein. Basically, the more PCSK9 the body makes, the higher the LDL cholesterol will be.

Cardiologist Abinash Achrekar, vice chair and professor in the UNM Department of Internal Medicine said the twice-

monthly injections to block that protein reduce his bad cholesterol by about 60 per cent, but they are expensive and require prior authorisation from a primary care doctor or cardiologist.

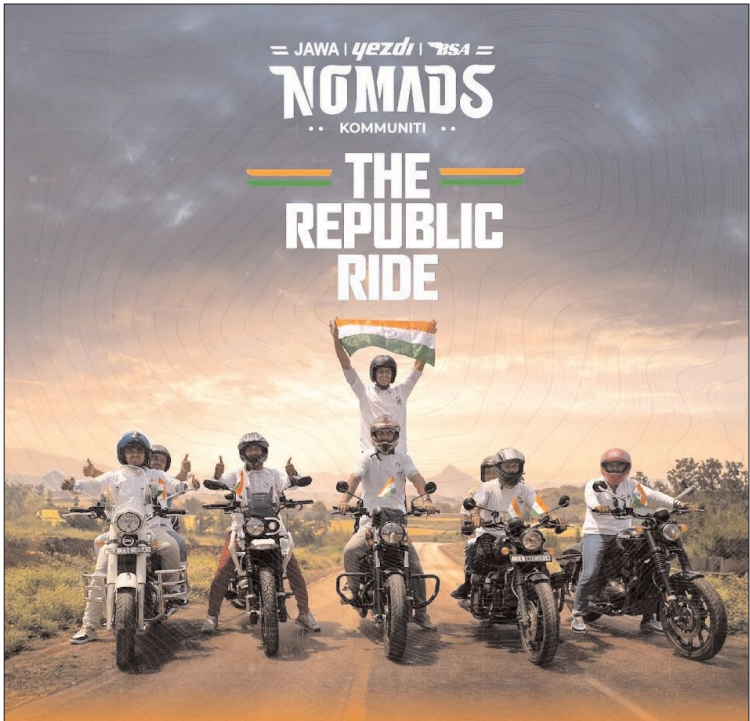
To make it more affordable, the team created a new vaccine that specifically targets PCSK9. "The vaccine is based on a non-infectious virus particle," Chackerian explained. "It is just the shell of a virus, and it turns out that we can use that shell of a virus to develop vaccines

against all sorts of different things." In this case, Chackerian said he stuck tiny pieces of the PCSK9 protein to the surface of these virus particles. "So, your immune system makes a really strong antibody response against this protein that's involved in controlling cholesterol levels," he said. "In the animals that we vaccinated, we see strong reductions in cholesterol levels – up to 30 per cent – and that is going to be correlated with reduced risk of heart disease."

Over the past 10 years, the vaccine has been tested on mice and monkeys with promising results. Chackerian said the next step is to find funding to move into vaccine manufacturing and clinical trials with humans. That process can take years and several million dollars, but it is worth it to develop a vaccine that is pure, safe and affordable.

The 44-year-old revealed that he had casually hugged his manager, but it was portrayed as if he was meeting a girl mid-match. "I had an agent, somebody whom I had just started working with. I had given her a hug. Just when you meet someone, you give them a hug, and

While he admitted that linkup rumours are common for cricketers and celebrities, Yuvraj slammed the media for fueling controversies simply to boost readership. "It's part of the life we live. With a career spanning over 304 ODIs, 58 T20Is, and 40 Tests, Yuvraj cemented his place as a player who could win matches for his side either through his electric fielding, fierce batting, or smart bowling. ICELAND CRICKET'S HILARIOUS OFFER TO REPLACE PAKISTAN IN T20 WORLD CUP GOES VIRAL

Iceland Cricket took a fresh dig at the Pakistan Cricket Board (PCB) amid speculation over a possible boycott of the T20 World Cup, which starts on February 7. Pakistan is expected to confirm its stance on either Friday or Monday, following PCB chief Mohsin Naqvi's meeting with Prime Minister Shehbaz Sharif. Last week, the International Cricket Council (ICC) removed Bangladesh from the tournament and replaced them with Scotland. The decision was made after Bangladesh reiterated its stance of not touring India for the T20 World Cup, citing security issues. Reacting to the uncertainty surrounding the PCB's position, Iceland Cricket joked on Wednesday that they are ready to replace Pakistan if the 2009 champions decide to pull out of the event. "We really need Pakistan to decide soon upon their participation



in the T20 WC. We are ready to take off as soon as they pull out on 2nd Feb, but the flight schedule is a logistical nightmare to get us to Colombo in good time for 7th Feb. Our opening bat is an insomniac!" Iceland Cricket wrote in a post on X. To drive the point home, the account also shared a screenshot of travel plans from Keflavik to Colombo, leaning into the logistical absurdity of a last-minute call-up. PCB chairman Naqvi, after a meeting with Prime Minister Shahbaz Sharif, had con-

veyed that all options were on the table the decision will be taken by either Friday or next Monday. Pakistan has been protesting ICC's decision to replace Bangladesh with Scotland after the Bangladesh Cricket Board and interim government insisted they will not play T20 World Cup matches in India over security concerns. Pakistan, meanwhile, announced their squad for the 20-team tournament which is, with one exception, the same which will face off against Australia.

run chase as Pakistan registered a significant 22-run victory to take a 1-0 lead in the three-match series. Babar endured a rough time in this edition of the Big Bash League scoring just 202 runs in 11 matches with just two half-centuries. His strike-rate was a poor 103 and averaged a mere 22. Babar's appearance in the

league also sparked a controversy when his partner Steve Smith refused a single to him while the former was batting on 47 from 58 balls. Smith later completed a hundred at a strike-rate of 238. Babar's and former T20 opening partner, Muhammad Rizwan also had a forgettable Big Bash scoring just 188 in 10 innings at a strike rate of 102 and in one match was recalled from batting by Melbourne Renegades because of his slow pace. Pacer Shaheen Shah Afridi, who returned home midway because of an injury, too had a mediocre BBL season. All three Pakistan cricketers were appearing in the Big Bash for the first time.

Yuvraj Singh is a legendary India all-rounder. He has won two World Cups with the national cricket team. He played a key role in India's World Cup-winning campaigns in 2007 and 2011. Yuvraj scored 362 runs and picked 15 wickets, and was adjudged the Player of the Tournament. Around a year after the Cricket World Cup, a seasoned campaigner Yuvraj stayed in and out of the national team till he last played for India in 2017, and called time on his career two years later. During this phase, Yuvraj also battled cancer that

took a big toll on his game. The former India all-rounder also revealed that he even lost motivation to play for the national team at one point. Yuvraj opened up on his struggles on Sania Mirza's YouTube show, 'Serving it Up with Sania'. "I got to that space where my career had become a burden. So, I was not enjoying my game. It's a very thin line. I had a feeling that 'why am I playing cricket when I'm not enjoying it?' I was not feeling supported. I was not feeling respected. And I feel 'Why do I need to do this when I don't have it?' Yuvraj said. "When the game has given me so much, I've given my best. So why am I lingering on to something that I'm not enjoying? Why do I need to play? To prove what? I can't do more than this, mentally or physically. It was hurting me, so I decided to stop. The day I decided to stop, I was myself again," he added.

Australian Open Prize Money: Winners To Get Bumper Reward After Big Change

The 2026 Australian Open prize money has increased by 16% from last year, with the organizers of the season's first Grand Slam announcing their largest prize pool ever earlier this month. The total for 2026 is set at 111.5 million Australian dollars (\$75 million), as compared to 96.5 million Australian dollars (\$68.3 million) from last year. Meanwhile, the women's and men's singles champions will bag 4.15 million Australian dollars (\$2.8 million), a 19% jump from the previous edition. Speaking on the record hike in the prize pool, tournament director Craig Tiley said it reflected Tennis Australia's commitment to supporting tennis



careers at every level, from rising stars to Grand Slam champions. "From boosting qualifying prize money by 55 percent since 2023 to enhancing player benefits, we're ensuring professional tennis is sustainable for all competitors," he said. "By supporting players at all levels, we're building

deeper talent pools and more compelling storylines for fans." It was also announced earlier this month that players beaten in the opening round would bag 150,000 Australian dollars (\$100,750), while even those knocked out in the first round of qualifying will

walk away with 40,500 Australian dollars (\$27,200). The lineup for this year's men's and women's singles is confirmed. World No. 1 Carlos Alcaraz will take on third seed Alexander Zverev in the first semi-final, while second seed Jannik Sinner will square off against record 10-time winner Novak Djokovic. In the women's singles, top seed Aryna Sabalenka is set to face off with 12th seed Elina Svitolina. In the other clash, sixth seed Jessica Pegula eyes a place in the final against fifth seed Elena Rybakina. Sinner, the two-time defending champion, is aiming for a hat-trick this year in Melbourne.

Why Are India Struggling In Tests? Rahul Dravid Gives Blunt Reply: "Not Easy"

The Indian cricket team's performances in Test cricket have experienced a drastic slip in quality, with home defeats against New Zealand and South Africa in the past year. While the side has dominated the T20I format without a single series loss under head coach Gautam Gambhir, their Test form has led to criticism from fans and experts alike. Former India head coach Rahul Dravid opened up about the challenges that modern batters face in Test cricket, explaining how switching between formats hampers their preparation. "One of the things I understood as a coach, especially for the guys that play all three formats, is that they



keep moving from one format to the other," Dravid said at the launch of the book The Rise of the Hitman: The Rohit Sharma Story in Bengaluru. "There were times when we would get to a Test match three to four days before the game. When we started practicing for the Test match and looked back

at the last time some of these guys had actually hit a red ball, it might have been four or five months ago." "That's become a real challenge-how do you find the time to develop those difficult skills? To play on turning tracks or seaming wickets for hours in a Test match is not easy. It requires skill. In my genera-

tion, when there were only two formats and no franchise cricket, there were many times where I would have a whole month of practicing for a Test series, playing with the red ball to develop my skills," Dravid added. Dravid also noted that similar issues were pointed out by current skipper Shubman Gill, hinting that this lack of preparation could be behind the star batter's recent struggles. "Now, one of the things that has become tougher in red-ball cricket is that many of our guys who play all three formats or play the sheer amount of cricket they are playing-sometimes don't have the time to practice red-ball cricket as much."

PALACE WANT £50M STRAND LARSEN AS FOREST CHASE MATETA



Crystal Palace have agreed a deal in principle worth in the region of £50m to sign Wolves striker Jorgen Strand Larsen, as Nottingham Forest prepare an improved offer for Jean-Philippe Mateta. Sources have told BBC Sport that Palace's interest in the 25-year-old striker has intensified in the past 24 hours and a formal bid is now set to be submitted. Palace broke their club record with a £35m move for Wales forward Brennan Johnson earlier this month but Strand Larsen's arrival would surpass that deal. Wolves are open to selling the Norway international this month provided they get a fee close to the £55m they rejected from Newcastle for the striker during the summer transfer window. Leeds have already seen an offer of £40m rejected by Wolves, and as things stand the Elland Road club are reluctant to go much higher. Mateta wants to leave Palace and has informed the club's hierarchy of his wishes, with Forest set to return after failing with an initial £35m offer. Juventus and AC Milan are among the clubs to have shown a concrete interest in the France international. Mateta is under-

stood to want to play Champions League football, but a move to Forest is understood to be a financially lucrative option for the 28-year-old and sources are indicating that Forest intend to accelerate their interest. The two clubs face each other in the Premier League on Sunday and no agreement is expected before then. Meanwhile, Forest have bid £20m for Brighton midfielder Yasin Ayari, though the offer is expected to be rejected. Palace are also close to the loan signing of Aston Villa forward Evann Guessand. The Eagles, who looked at signing the 24-year-old last summer, are set to take Guessand until the end of the season in a deal that will give them an option to buy. Guessand has scored twice in 26 Villa appearances - both in the Europa League - having struggled to establish himself in his favoured central striker position. The £18.25m arrival of Tammy Abraham from Besiktas this week also leaves him as likely third choice behind Abraham and Ollie Watkins. And although the Ivory Coast international has been happy to fight for his place at Villa Park, he is expected to leave.

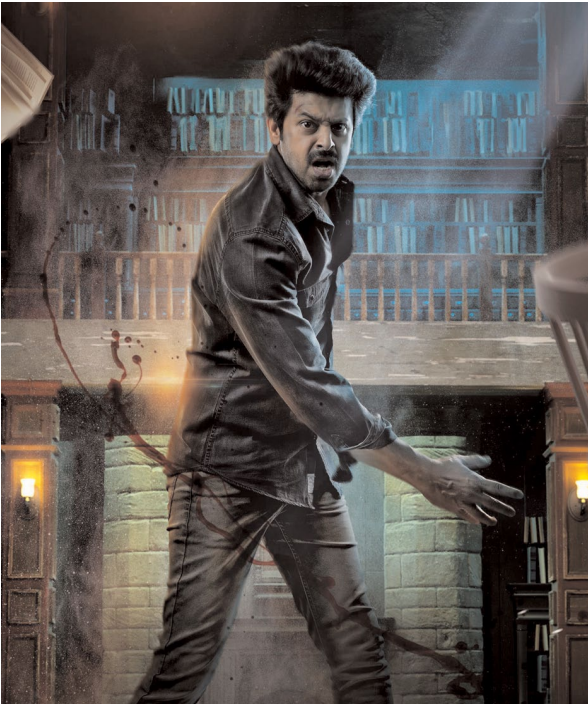
