### AMC TO SHIFT 1200 STRAY DOGS TO SHELTER HOUSE

Agartala: Agartala Municipal Corporation (AMC) has announced plans to implement Supreme Court directives regarding the welfare of stray dogs, marking a significant step towards humane animal management. This decision comes in response to growing concerns about public safety and the well-being of street animals in the city. Mayor Dipak Majumder highlighted that the Supreme Court, in conjunction with the Animal Welfare Board of India, has issued clear guidelines for the management of stray dogs, with Urban Local Bodies being responsible for ensuring humane treatment while safeguarding public safety.

### CRIME BRANCH BUSTS MAJOR COUNTERFEIT SHOE MANUFACTURING UNIT IN NE DELHI

New Delhi: Crime Branch has unearthed a large-scale manufacturing unit producing fake shoes of top international brands, including Nike, Adidas, New Balance, and Skechers, an official said on Friday. The owner of the unit, Sandeep Singh, 44, a resident of Ambey Enclave, Chauhan Patti, Sonia Vihar, has been arrested, the police said. The operation was conducted by the team of the Anti-Extortion & Kidnapping Cell (AEKC) of the Crime Branch, which was followed by a tip-off regarding the illegal production of branded footwear in Northeast Delhi.

# Ajit Pawar's wife Sunetra may take oath as Deputy CM on Sat

## NCP MERGER TALKS ON BACKBURNER



MUMBAI/PUNE (TSIT): Sunetra Pawar, Rajya Sabha MP and the wife of deceased NCP chief Ajit Pawar, is likely to be sworn in as Maharashtra Deputy Chief Minister on Saturday, party sources said. She would be the first woman to hold the post in the state. Following the death of Deputy Chief Minister Ajit Pawar in an air crash in Baramati on Wednesday, a section of Nationalist Congress

Sunetra, Ajit Pawar's wife, is currently not a member of either House of the Maharashtra legislature

Party leaders had demanded that she should get the post.

"Tomorrow, a parliamentary board meeting of the party will take place in Mumbai, where Sunetra Pawar will be elected as the leader of the legislative party," said a source. "It is likely that she will be sworn in as Deputy Chief Minister by tomorrow evening," said the source, privy to the developments.

Until the 2024 Lok Sabha elections, Sunetra Pawar had kept a low profile. In the General Election that year, she stood from Baramati as the candidate of her husband's party, but was defeated by her sister-in-law and incumbent NCP (SP) MP Supriya Sule in the prestige battle.

Sunetra was subsequently elected to the Rajya Sabha.

The legislature wing of the NCP in Maharashtra will hold a meeting in Mumbai on January 31 where she would be named as its leader, state minister and senior party leader Chhagan Bhujbal said earlier on Friday.

Chief Minister Devendra Fadnavis had conveyed that he had no issue if her swearing-in ceremony as Deputy CM took place on Saturday itself, provided a decision to that effect was taken by the party, said Bhujbal.

Sunetra Pawar is currently not a member of either House of the Maharashtra legislature. However, the Baramati Assembly seat in Pune district has fallen vacant after Ajit Pawar's death.

## India, Bangladesh repatriate 151 fishermen

NEW DELHI/DHAKA (TSIT): India and Bangladesh on Thursday completed a reciprocal release and repatriation of fishermen who had inadvertently crossed the International Maritime Boundary Line (IMBL). Officials said the two sides saw it as a humanitarian approach to longstanding maritime boundary issues. A total of 23 Indian fishermen detained by Bangladesh authorities and 128 Bangladeshi fishermen held in India were released and sent back to their respective countries along with their operable fishing vessels, the Ministry of External Affairs said. "The exchange was in view of the

humanitarian and livelihood considerations of the fishing communities on both sides. India remains committed to the well-being and safety of our fishing community," External Affairs Ministry spokesperson Randhir Jaiswal said in a post on X. The fishermen had been arrested in recent weeks after straying into each other's territorial waters during routine fishing activities. Officials said the exchange was finalised through close coordination between the two governments, keeping in view the livelihood concerns of coastal communities that depend heavily on small-scale fishing.

## CM Naidu Highlights Innovation and Future Technologies at Agastya Academy

Chittoor (TSIT) Chief Minister of Andhra Pradesh recently met students at the Agastya Academy Auditorium, where representatives of the Academy showcased a video highlighting the various programs and training provided in science and technology. The Chief Minister viewed the presentation while seated among the students.

Addressing the gathering, the Chief Minister recalled, "The chairman of Agastya Academy told me 25 years ago that he would start a good innovation center, and I agreed. This academy has been running effectively for 25 years and has become a leading center in India." He appreciated the clean and forward-looking environment in which the Academy was established and stated that its policies reflect the future



direction of Andhra Pradesh.

Highlighting the importance of keeping pace with global developments, the Chief Minister urged students to embrace emerging technologies like artificial intelligence. "It is because of early acceptance of IT that Telugu people have made a mark worldwide. I promoted IT then, and now I am saying everyone should think

about AI. We need to change the mindset of students — the future is ours," he said. He announced the establishment of the Ratan Tata Innovation Hub to provide opportunities for new innovations and startup companies, while also citing initiatives such as drones, Space City, and technology-driven electricity reforms that reduce energy costs.

## Telangana Speaker begins hearing on disqualification petitions

Hyderabad (TSIT): Telangana Assembly Speaker Gaddam Prasad Kumar on Friday began hearing on the petitions for disqualification of MLA Danam Nagender who was elected on a Bharat Rashtra Samithi (BRS) ticket but allegedly shifted loyalties to the ruling Congress party.

The Speaker will hear arguments by the counsels of BRS MLA Kaushik Reddy and BJP floor leader in the Assembly A. Maheshwar Reddy and record the evidence. He will later hear the arguments by the counsel of Nagender. The MLA said that he has not yet received any notice from the Speaker for appearance before him.



The Speaker took up hearing on Nagender's petition following recent directive from the Supreme Court, which gave him two weeks to decide on the petitions for disqualification of the remaining MLAs. The Speaker has also already dismissed the petitions to disqualify seven out of 10 BRS MLAs who had allegedly defected to the Congress in

2024. He ruled that the petitioners failed to provide evidence that the MLAs defected to the Congress. He said all the MLAs are technically still in the BRS.

The Speaker last year completed the hearing on the petitions for the disqualification of eight MLAs and reserved the orders. The Speaker is yet to pronounce the order on the plea for the disqualification of MLA Sanjay Kumar. The hearing on the disqualification of two other MLAs, Danam Nagender and Kadiyam Srihari could not be taken up as they had not submitted their replies to the notices served on them.

## Save Gandhi's India from Godse's heirs, CM Stalin in veiled dig at BJP

CHENNAI (TSIT): In a veiled dig at the Bharatiya Janata Party and its ideological mentor, the Rashtriya Swayamsevak Sangh (RSS), Chief Minister MK Stalin on Friday called upon people to "teach a befitting lesson to the inheritors of Godse," referring to Nathuram Godse, who shot dead the Father of the Nation.

CM Stalin went on to accuse "Godse's lineage" of attempting to ruin the country and undermine the values of Mahatma Gandhi, urging people to defeat divisive communal politics. Sharing a social media post on X on the occasion of the 79th death anniversary of Mahatma Gandhi, CM and DMK presi-



The chief minister, in a social media post, said: "Let us eradicate religious fanaticism! Let us honour the Mahatma!"

dent Stalin said Godse's ideological successors are attempting to erase Gandhi's legacy and undermine the country, and called upon citizens to safeguard the land of the Mahatma.

CM Stalin underscored the importance of protecting unity, peace and a non-violent approach to life, actively

promoted by the Father of the Nation. Recalling Gandhi's assassination, Stalin said the Mahatma would continue to live in the hearts of every Indian, even though he was killed by Godse's gun.

Now, the heirs of Godse, a veiled reference to the BJP, RSS workers and supporters, were trying to damage the country's foundations, he alleged. Recalling Gandhi's commitment to peace and harmony, Stalin said his ideals remain relevant in countering forces that seek to divide the nation through hatred and extremism. Stalin, along with Deputy Chief Minister Udhayanidhi Stalin and other Ministers,

## Gold, silver prices crash after record rally: Here's what triggered the sharp sell-off



New Delhi (TSIT) Prices of silver and gold saw one of their steepest single-day fall in the past few months in futures trade on Friday. The silver futures crashed 17 percent to Rs 3.32 lakh per kilogram, while gold tanked 9 percent to Rs 1.54 lakh per 10 grams, tracking weak trends in the global markets and surging American currency.

Gold futures with April expiry on MCX dropped around 9 percent to hit a low of Rs 1,67,406 per 10 grams. This comes a day after the contracts hit a fresh lifetime high of Rs 1,93,096 per 10 grams. This means that the gold futures fell 13 percent (Rs 25,690 per 10 grams) in just one day.

Silver futures with March expiry, meanwhile, plunged nearly 17 percent to Rs 3,32,002 per kilogram. This marks a fall of nearly 21 percent (Rs 88,046 per kilogram) in just one day after hitting a fresh lifetime high of Rs 4,20,048 per kg. Today's steep decline in gold and silver prices could be viewed as a usual case of profit-taking following an extended record rally. While high positioning, strong dollar fluctuations, and an upswing in bond yields have led to a correction in gold prices.



## Free Breakfast Scheme for Government School Students Under Active Consideration: Bhatti Vikramarka

Rangareddy Deputy Chief Minister Bhatti Vikramarka Mallu on Wednesday said that the State government is seriously examining the introduction of a free breakfast scheme for students studying in government schools, subject to favourable financial conditions. He was speaking as the chief guest at the 150th anniversary celebrations of the Mogiligidda Zilla Parishad High School in Farooqnagar mandal.

The Deputy Chief Minister said the proposal is currently under discussion by Chief Minister A. Revanth Reddy and the Cabinet. He informed that the scheme has already been launched on a pilot basis in the Chief



Minister's constituency and aims to ensure proper nutrition for children during their formative years. He assured that the programme would be extended across the State once adequate financial resources are available. Highlighting the importance of a common school system, Bhatti Vikramarka said such a model promotes social equality by bringing together children from different castes, religions and economic backgrounds. As

part of this vision, the government is constructing Young India Integrated Residential Schools across Telangana. Each school is being developed on 25 acres with an estimated cost of Rs.200 crore, with construction underway in 100 constituencies at a total cost of Rs.20,000 crore. He said the people's government is prioritising free education and healthcare to build strong human resources capable of competing globally. He recalled that Chief Minister Revanth Reddy had sanctioned 10 crore last year for the development of the Mogiligidda school, with

works progressing rapidly. The Deputy Chief Minister also spoke about the modernisation of ITIs through upgraded infrastructure and industry-relevant courses to improve employment opportunities. He highlighted welfare measures such as enhanced diet charges in welfare institutions, upgradation of government hospitals, distribution of quality sarees to women, and interest-free loans to women self-help groups, with 26,000 crore already disbursed in the first year.

Recalling the legacy of former Chief Minister Burgula Ramakrishna Rao, he described him as a pioneer of land reforms and democratic governance, noting that the Mogiligidda school has produced several eminent personalities. BC Welfare and Transport Minister Ponnampallabharathi Shadnagar MLA Veerlapalli Shankar, senior officials, education department representatives and local public leaders attended the event.

## Create Widespread Awareness to Eradicate Leprosy: District Collector Harichandana Dasari

Hyderabad: District Collector Harichandana Dasari has called for large-scale public awareness to achieve complete eradication of leprosy.

On the occasion of the death anniversary of Mahatma Gandhi, the Collector administered a pledge on leprosy eradication at the Mahatma Gandhi statue at Babu Ghat, Langer House.

Addressing the gathering, the Collector said that individuals who notice numb patches on the skin and are unable to feel pain or touch in those areas should immediately visit the nearest hospital and consult a doctor for diagnosis and appropriate treatment. She stressed the need to show care and concern towards persons affected by leprosy and those who have developed disabilities due to the disease, and advised them to undergo complete treatment at government hospitals. Collector Dasari appealed to the public to treat leprosy-affected persons as members of their own families and to avoid all forms of discrimination. She explained that leprosy is a



bacterial disease and can be completely cured through MDT (Multi-Drug Therapy). With early detection and timely treatment, disabilities caused by leprosy can be effectively prevented, she said. Calling upon citizens to work together to realise Mahatma Gandhi's dream, the Collector urged collective efforts towards building a leprosy-free India in the future.

On the occasion of Gandhi Jayanti, the Collector, along with medical officers, ANMs, staff and employees, participated in the pledge ceremony at the Gandhi statue. District Medical and Health Officer Dr. Venkati, RDO Ramakrishna, Additional District Medical Officers Dr. Saraswathi and Dr. Muralidhar Rao, medical staff and officials from various departments were present at the programme.

The conference was attended by HR leaders from national and international technology companies, including Social Talent founder Johnny Campbell, Carolan Global Solutions Managing Director Pawan Sachdeva, CrowdStrike Vice-President Rajesh Menon, actor and author Mandira Bedi, along with members of the Fiesta 2026 organising committee.

Hyderabad: With the Medaram Sammakka-Saralamma Jatara witnessing an unprecedented surge of devotees, Director General of Police B. Shivadhar Reddy visited Medaram on Friday to review the security arrangements and crowd management measures on the ground.

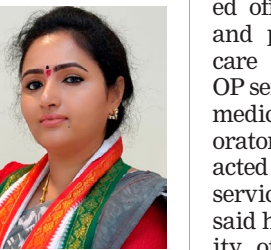
Mandala Sammaiah meets Meenakshi Natarajan, raises fisherman issues

## CS Conducts Comprehensive Review of Key Departments to Achieve Telangana Rising 2047 Goals

Hyderabad: In accordance with the Telangana Rising 2047 vision, State Chief Secretary K. Ramakrishna Rao has been holding department-wise review meetings over the last three days to provide clear direction to all government departments. As per the instructions of the Hon'ble Chief Minister, the Chief Secretary on Friday reviewed several major departments with senior officials at the Dr B.R. Ambedkar Telangana State Secretariat.

## REIMAGINING PUBLIC HEALTHCARE IN TELANGANA

With the health and well-being of its citizens as a central objective, the Telangana government is preparing to usher in a landmark reform in public healthcare. Under the framework of people-centric governance, the State is formulating a Comprehensive Healthcare Policy aimed at strengthening the healthcare delivery system and ensuring equitable access to quality medical services not confined to urban centres, but extended deep into rural areas as well. For decades, access to quality medical care in India has largely been associated with metropolitan cities, private hospitals, and prohibitive costs. Rural citizens, in particular, have been compelled to travel long distances to district headquarters or Hyderabad for specialised treatment. Determined to dismantle this urban-centric healthcare model, the government has adopted a clear guiding principle: healthcare must reach the people, not the other way around. This philosophy forms the foundation of the new healthcare policy. At present, the dependence on cities for speciality and emergency care remains a significant challenge. Critical services such as trauma care, dialysis, and mental health support are especially inaccessible

to rural populations. Recognising these structural gaps, the government is working towards a unified "New Healthcare Policy" by developing individual policies for key medical sectors and integrating them into a comprehensive framework. Notably, the policy places emphasis on 11 critical focus areas: trauma care, dialysis, mental health, ENT services, eye care, de-addiction, digital health, polyclinics, fertility services, geriatric care, and a dedicated Cure Health Policy for Hyderabad. Together, these components signal a shift from fragmented healthcare interventions to an integrated, patient-centric system.

One of the most significant interventions is the expansion of trauma care infrastructure. While Telangana currently has only a handful of trauma care centres, the new policy proposes the establishment of 109 trauma care centres across the State. These centres are expected to play a crucial role in responding to road accidents, industrial mishaps, and other medical emergencies, thereby significantly improving survival rates. This move underscores the government's commitment to prioritising life-saving infrastructure as a public responsibility.

The rise in kidney-related ailments, particularly in rural areas, has been another pressing concern. Patients often undertake arduous journeys for regular dialysis, leading to physical, financial, and emotional strain. Addressing this issue, the government has decided to establish dialysis centres every 25 kilometres, along with expanding machine capacity in existing facilities. Additionally, high-incidence regions will be identified for targeted interventions under a dedicated dialysis policy. This approach reflects a welfare-oriented model aimed at reducing costs while

expanding access to essential care.

For the first time, mental health has been accorded the status of a core public health priority. In the backdrop of rising stress due to unemployment, financial pressures, and social challenges, the government is drafting a comprehensive mental health policy. This includes statewide counselling services, deployment of mental health professionals, and the creation of accessible care centres. By confronting mental health issues openly, the government signals a shift from denial to decisive engagement — treating mental health as a social concern rather than a personal stigma.

The proposed Digital Health Policy is another transformative initiative. Under this system, every citizen's health records will be digitised and linked to a unique health ID. Medical histories from government hospitals will be accessible across facilities, enabling doctors to make informed clinical decisions swiftly. This digital integration promises not only efficiency and continuity of care, but also reduced duplication and delays in treatment.

Special attention is also being given to senior citizens. Dedicated geriatric wards, specialist care, and expanded services for those above 60 years are being planned. Teaching hospitals have already introduced 10-bed geriatric wards, with further expansion on the anvil. This initiative reflects a broader social vision — one that seeks to treat ageing with dignity rather than neglect.

Addressing infertility, an often-overlooked public health issue, the government is formulating a Fertility Policy to provide advanced treatments in government hospitals. This measure aims to reduce dependence on expensive private facilities and make

fertility care affordable and accessible.

In addition, an exclusive Cure Health Policy is being planned for the Hyderabad metropolitan region, recognising the unique health challenges of an urban population. This urban-focused approach is expected to complement the broader State healthcare framework.

The government also plans to strengthen the polyclinic model, enabling patients to access primary and speciality services under one roof. This integrated service delivery mechanism is expected to reduce referrals, travel time, and overcrowding at tertiary hospitals.

The policy formulation process itself reflects institutional seriousness. Medical experts, administrators, and public health professionals are involved in preparing detailed policy documents that assess existing infrastructure, human resource requirements, financial implications, and anticipated public benefits. A comprehensive evaluation is underway, with the possibility of an official announcement during the upcoming Budget session. By placing public health at the centre of governance, the Telangana government is reaffirming that healthcare is not a privilege but a fundamental responsibility of the State. The proposed Comprehensive Healthcare Policy, designed to ensure equal access for rural and urban populations alike, has the potential to position Telangana as a national model in public healthcare delivery. Its implementation is expected to reduce medical expenses, ensure timely treatment, and provide much-needed reassurance to the poor and middle classes. In prioritising health as a cornerstone of welfare governance, Telangana is laying a strong foundation for a healthier, more resilient future.

## Indian Railways Accelerates Kavach 4.0 Safety System Rollout, 472 km Commissioned Across Three Sections



Indian Railways today commissioned 472.3 route kilometres of Kavach Version 4.0 (Automatic Train Protection System) across three sections of its network, marking another significant milestone in strengthening rail safety. The newly commissioned sections include Vadodara-Virar (344 km) on Western Railway, Tuglakabad Junction Cabin-Palwal (35 km) on Northern Railway, and Manpur-Sarmatanr (93.3 km) on East Central Railway. With this commissioning, Indian Railways continues to accelerate the deployment of the indigenous Kavach system to enhance train protection, operational safety, and reliability across high-density routes.

This commissioning marks the highest ever route kilometres of Kavach commissioned on a single day as well as in a month, with 472.3 Rkm brought under Kavach Version 4.0. The previous highest commissioning stood at 324 Rkm on the Kota-Mathura section of West Central Railway. With the latest addition, Kavach Version 4.0 has now been commissioned across five zones of Indian Railways.

After today's inclusion, Kavach Version 4.0 has been commissioned over a total of 1,306.3 Route Kilometres across Indian Railways. Prior to this, Kavach Version 4.0 had been commissioned on 834 Route Kilometres. This included the Palwal-Mathura-Nagda section (633 Rkm) of the Delhi-Mumbai route and the Howrah-Bardhaman section (105 Rkm) of the Delhi-Howrah route. In addition, 96 Route Kilometres were commissioned on Gujarat's first Bajwa (Vadodara)-Ahmedabad section.

**PROGRESS OF KAVACH 4.0 IMPLEMENTATION ON NORTHERN RAILWAY**

Indian Railways successfully commissioned Kavach 4.0 on the 35-km Tuglakabad Junction Cabin-Palwal section of the four-line Delhi-Mumbai route, which spans 152 main line track kilometres. Kavach has been installed in a complete stretch of this corridor comprising Major station Yards, two Main lines with Automatic

Signaling system and two lines with Absolute Block signalling.

This commissioning marks a significant safety upgrade on one of the busiest and high-density corridors of the Indian Railways covering Delhi suburban and long-distance rail network. This section is a high-traffic stretch catering to passenger, suburban, and freight trains. Commissioning of Kavach on this section significantly enhances operational safety, reliability, and passenger confidence.

**PROGRESS OF KAVACH 4.0 IMPLEMENTATION ON EAST CENTRAL RAILWAY**

Indian Railways has also commenced train operations with Kavach 4.0 on the 93.3 km Manpur-Sarmatanr section of the DDUGJ-Pt. Deen Dayal Upadhyaya division. The first Kavach-enabled service, Train No. 13305 Sasaram Intercity Express, operated successfully on this section, departing Sone Nagar at 07:42 hrs and arriving at Manpur at 09:35 hrs. During the run, a head-on collision test was conducted, in which the train automatically stopped, validating the system's effectiveness. Kavach is being installed over 4,235 route kilometres of East Central Railway, including 417 route kilometres on the Pt. Deen Dayal Upadhyaya Junction-Manpur section, a critical part of the Delhi-Howrah trunk route passing through Uttar Pradesh, Bihar, and Jharkhand. The section carries mixed traffic and is currently cleared for 130 kmph, with works in progress under Mission Raftar to enhance the speed potential to 160 kmph.

**PROGRESS OF KAVACH 4.0 IMPLEMENTATION ON WESTERN RAILWAY**

Work on the Vadodara-Surat-Virar section on Delhi-Mumbai route commenced in January 2023, and on 30 January 2026, Kavach has been successfully commissioned on this 344-km section. This historic milestone was achieved with Train No. 20907, Dadar-Bhuj Sayajinagri Express, becoming the first KAVACH equipped train to run from Mumbai.

Work on the Vadodara-Nagda section is progressing at a fast pace and is expected to be commissioned by March 2026, while work on the Virar-Mumbai Central section is also progressing well and is targeted for completion by September 2026. Simultaneously, Kavach installation on locomotives is advancing steadily, with 364 locomotives on Western Railway equipped with Kavach so far. In addition, works on several other sections of Western Railway have been sanctioned, covering a total of 2,667 Route Kilometres, with execution underway on all sanctioned sections.

## CONSUMER BHARAT YATRA RALLY HELD TO PROMOTE CONSUMER AWARENESS



Hanamkonda: A Consumer Bharat Yatra Rally was organised on Friday morning under the leadership of Dr. Pallepadu Damodar, National Senior Secretary of the Consumer Confederation of India, with the objective of creating widespread awareness on consumer rights and protection. The rally began at 9:00 AM from Kaloji Junction, Hanamakonda, and concluded at Raju Hotel Junction on Hunter Road. The programme was jointly organised by the Department of Consumer Affairs and CCI, with the cooperation of other concerned departments.

Speaking on the occasion, Dr. Pallepadu Damodar stated that the Consumer Bharat Yatra aims to educate the public about the Consumer Protection Act, 2019. He said the yatra focuses on creating awareness about frauds in weights and measures, food adulteration, deficiencies in paid services, and the legal mechanisms available to consumers for seeking compensation through the law. Dr. Anantha Sharma, Consumer Man of India, participated as the chief guest and said that the Consumer Bharat Yatra was launched in New Delhi on December 24, 2025, on the occasion of National Consumer Day. He informed that the yatra is being conducted across all states and Union Territories of the country, covering nearly 20,000 kilometres. So far, the campaign has reached about 200 towns and covered nearly 9,000 kilometres, he added. Dr. Anantha Sharma emphasised that the initiative is particularly aimed at spreading awareness among rural communities, farmers, the illiterate and common citizens about consumer laws and their rights.

## TRUMP, XI, PUTIN - IN THE AGE OF STRONGMEN, THE PERIL FOR 'MIDDLE POWERS'

In most of his speeches and social media posts, Donald Trump makes two points, directly or indirectly. First, he is the greatest President of the United States, almost a god's gift to humanity. Second, that he doesn't receive enough recognition for what he has achieved in such a short period. No Nobel Prize, even after resolving at least eight global conflicts. No praise for strengthening the US economy through his tariffs. Facts don't matter much to him; what he feels is more important.

So, Trump should no longer be committed to peace, and the US should get Greenland at any cost because Norway didn't give him the Nobel Prize. India should have extra tariffs for its exports to the US because New Delhi didn't acknowledge Trump's role in ending last May's four-day military conflict with Pakistan and failed to nominate him for the Nobel Peace Prize. In the last 12 months, Trump has abandoned the rules-based global order that the US helped create after the Second World War and embraced a foreign policy based on his whims and preferences, weaponised tariffs and made the US unreliable to its partners. "I don't need international law," Trump told The New York Times earlier this month. When asked if there were limits on his global power, he said: "My own morality. My own mind,"

**The Donroe Doctrine**

The raid on Venezuela and abduction of its leader, Nicolas Maduro, at the beginning of this month was done without any consultation with the US allies or even the Congress. He called it in line with what he called the Donroe Doctrine, his version of the 1823 Monroe Doctrine, to secure the Western Hemisphere from Russian and Chinese influence. Trump's Deputy Chief of Staff, Stephen Miller, minced no words to defend the move. "We are back to a world," Miller declared, "that is governed by strength, that is governed by force, that is governed by power." What Miller meant was that the US under Trump had reverted to the pre-War era, when big powers could seize territory or foreign property by force. In his much-applauded speech at Davos, Canada's Prime Minister, Mark Carney, declared that a rules-based global order was over and that "we are living in the midst of a rupture, not a transition". Quoting ancient Greek historian Thucydides, Carney said the world was entering a period in which "the strong can do what they can and the weak must suffer what they must". He warned, "Middle powers must act together because if we're not at the table, we're on the menu."

**A Slow Death**

Trump began to weaken the rules-based multilateral order during his first term. He withdrew from UN bodies, including the Human Rights Council, UNESCO, UNRWA, and the Paris Agreement on Climate Change. Trump also stopped funding for the World Health Organization (WHO) during Covid-19 and weakened the security guarantees associated with NATO and undercut the WTO. His second term has been the most devastating for multilateral institutions, particularly the United Nations. In his speech to the UN in September, Trump attacked what he called the anti-woke notions in the UN system for the "globalist scam" of climate change and accompanying green policies. Under Trump, the US is not paying dues of even 22% after an 84% reduction in US foreign aid last May. Earlier this month, Trump withdrew the US from 66 international bodies, nearly half of which are UN organisations. Last week, the US pulled out of the WHO. The withdrawal of the US, which has been the organisation's largest funder, could cripple the body and its numerous global health projects.

## In Trump's World, Wikipedia's Lesson On Collaboration

January 2026 has felt like one long stress test for the global order. The US administration parading Venezuela's President in handcuffs in New York City, renewed tensions over Greenland that rattled transatlantic trust, Trump openly alienating the European Union, and the rollout of an almost farcical Board of Peace for Gaza. In short, a new year reminding us that the world's stabilising institutions are either faltering or being reinvented on the fly. The headlines are heavy, the rhetoric sharper, the alliances thinner. And yet, in the midst of this unease, it is worth paying attention to a figure who has spent the last quarter-century quietly disproving the idea that large-scale cooperation is impossible: Jimmy Wales. This author spent an afternoon chatting with the 59-year-old founder of Wikipedia, who does not speak the language of geopolitics. His life's work rests, however, on a proposition that feels almost subversive in 2026: that most people, given the right framework, want to collaborate in good faith. And that optimism, even when it is not fully rational, can be a productive force. He calls himself a "pathological optimist", and he means it. When Wikipedia launched 25 years ago, there was no guarantee it would succeed. It emerged from the failure of Nupedia, a more rigid, expert-driven project that collapsed under the weight of its own seriousness. Wikipedia, by contrast, was built on something lighter but more powerful: fun, openness, and trust in a self-organising community. It worked not because humans are flawless, but because they are persistent. That distinction matters now. A Persistent Loss Of Faith The geopolitical turbulence of early 2026 has been fuelled in part by a loss of faith: in alliances, in norms, in institutions that once seemed unshakable. When the United States openly flirts with transactional diplomacy toward Europe, when territorial rhetoric reenters mainstream discourse, when peace initiatives are announced with more spectacle than consensus, cynicism becomes the default posture. It feels safer to assume bad faith than good intentions. Jimmy Wales offers a counterexample - not a naïve one, but a



grounded one. Wikipedia has never pretended that people are angels. It has policies, moderation, and guardrails precisely because conflict is inevitable. But it also begins from a crucial assumption that most contributors are there because they care about knowledge, accuracy, and something larger than themselves. That assumption has scaled across cultures, languages, and political systems. Wikipedia now exists in over 300 languages, many maintained by communities Wales himself will never meet. This matters because the crises of January 2026 are not just about power; they are about trust. Venezuela's uncertain transition has left citizens hopeful about economic relief but wary of democratic backsliding. Europe's reaction to US unpredictability has been less about outrage and more about recalibration - how much strategic autonomy is necessary when trust erodes? Even the Gaza Peace Board, however controversial, reflects a hunger for frameworks that might restore some measure of faith in diplomacy, however fragile. Serving Knowledge Wales would likely argue that the problem is not ambition but orientation. Wikipedia never set out to "create" knowledge. It set out to serve it. Its neutrality is not passive; it is worked on, debated, enforced, and constantly renegotiated. That

process - messy, slow, human - is precisely what many global institutions now lack the patience for. One of Wales's most striking observations is that Wikipedia's community would continue its work even if the outside world stopped paying attention. That is an extraordinary statement in an era obsessed with metrics, influence, and visibility. It suggests a form of faith that is not performative. Contrast that with the current global mood. Nations posture for leverage. Leaders speak to domestic audiences while quietly fraying international ties. Online spaces amplify hostility until it feels representative, even when it is not. Wales has long warned about this distortion. He says, "Spend too much time in the wrong corners of the internet, and you begin to believe that people are irredeemably angry and irrational. Step back into real communities - festivals, classrooms, collaborative projects - and a different picture emerges". The danger of 2026 is not only instability, but resignation. The idea that fragmentation is inevitable, that cooperation is obsolete, that hope itself is unserious. Wales's life's work argues the opposite. Hope, in his framing, is not blind optimism; it is sustained effort in the absence of guarantees. Wikipedia is not perfect. It has biases, disputes, and ongoing battles

over representation and accuracy. But it has endured because it treats those flaws as reasons to improve, not excuses to abandon the project. Their ethos of incremental progress, anchored in shared values, is precisely what the world needs more of as geopolitical certainties wobble. Truth Is Communal In an age of artificial intelligence, Wales remains stubbornly focused on human-created knowledge. Not because technology is dangerous, but because meaning is communal. Trust is communal. Truth, when it lasts, is negotiated collectively. These are not technological problems but social ones. January 2026 has reminded us how quickly systems can strain under pressure. It has also reminded us how much we depend on invisible forms of cooperation to keep the world intelligible. Jimmy Wales did not set out to build a metaphor for global resilience. He set out to build an encyclopedia. But in doing so, he offered something more enduring. Wikipedia is proof that faith in people, when paired with structure and humility, can scale. That lesson may not resolve conflicts or stabilise markets overnight. But in unsettled times, it offers something just as vital: a reason to believe that cooperation is not a relic of a calmer past, but a tool we can still choose - again and again - if we are willing to do the work.

## Listen to the Call of the Canals: When Faith Communicates with the Environment

Master Bhupendra Godara, born in the village of Gurera, resolved to spread this campaign to the masses. He was joined by many conscious comrades—Subedar Major Dalip Singh, Tekchand Bagri, Mr. Dalveer Potliya, retired Acharya Vijendra Singh, Krishna Kumar, Principal Ajit Singh, Nihal Singh Godara, Mr. Pawan Kumar, and many other dedicated social workers. ## 'Tell My Mother I Like Boys': Chef Suvir Saran Tells His Boldest Story Yet

In his new memoir, Tell My Mother I Like Boys, Michelin-starred chef Suvir Saran trades the precision of a professional kitchen for something far riskier: emotional nakedness. The result is a book that reads less like a celebrity memoir and more like a long, unflinching exhale, the kind you can only take once you have lived through enough fire, enough reinvention, enough heartbreak to stop being afraid of your own truth. Saran begins at the beginning, not with triumph, but with hesitation. He describes his birth as an "unsummoned third", a child kept almost by accident, raised in a Delhi where plurality was an instinct rather than a slogan. These early chapters are among the book's strongest: the rituals with his grandfather, the mixed faith prayer room, the quiet resilience of his mother. Saran approaches memory the way a chef approaches flavour: he lets it simmer, he layers it, he gives it time. And he refuses to simplify anything just because it is painful. Cooking As Memory The first act of the memoir, his childhood in Delhi, Nagpur, and back to Delhi, is told with striking sensory detail. Food is everywhere: laddoos being shaped in Panditji's kitchen, the bitter-sweet ritual of feeding birds as a form of remembrance, the scent of Nagpur oranges, the eggplant pickle from an upstairs neighbour that will later travel with him across continents. But this is not a "chef memoir" in the conventional sense. Cooking is not treated as destiny; it is treated as memory, inheritance,



and sometimes refuge. Saran writes of kitchens the way some people write of prayer halls. What gives the memoir its edge, however, is not nostalgia but confrontation. Saran does not gloss over cruelty, particularly the cruelty children inflict on each other. His descriptions of teasing, shame, and internal panic are direct without being self-pitying. The passages about being dressed up by cousins, the confusion that followed, and the quiet fear of not fitting into the masculine mould expected of him remain some of the most affecting sections of the book. He writes about queerness as a lifelong negotiation, a truth he understood long before he had the language for it. The memoir's second act, Manhattan, is where the book shifts gears. The city is painted as both tormentor and liberator. Saran writes candidly about ambition, love, betrayal, infidelity, illness, and the brutal loneliness of a life that looks glamorous from the outside. The Michelin star is mentioned, of course, but never glamorised. If anything,

Saran questions the very culture that once applauded him. He admits mistakes, he admits vanity, he admits selfishness. That honesty is precisely what strengthens the book. Readers expecting a glossy narrative about culinary success might be startled by how much space Saran devotes to his emotional interior life: relationships that shaped him, relationships that broke him, and the grief that followed him across continents. His reflections on caregiving - both the caregiving he received from friends, and the caregiving he had to offer in times of loss - are some of the memoir's most assured lines. Confession, Observation But the memoir's deepest emotional anchor is his mother. Every few chapters, the narrative returns to her, her pragmatism, her quiet endurance, her refusal to flinch even when the world around her did. In one of the book's early chapters, he recalls her comforting him after he fails a dictation test, turning pain into possibility with nothing more than tenderness and

chhola bhatura. These recurring portraits of his mother are crafted with restraint, not sentimentality. She is not idealised; she is honoured. The writing style is surprisingly literary. At times, almost too lyrical, but Saran generally knows when to pull back. His voice moves between the confessional and the observational with a natural ease, and the book's emotional honesty feels earned rather than performed. There are a few moments where the metaphors crowd each other, but the narrative never loses clarity. The last quarter, his fall, his illness, and his return to India, is the book's emotional core. When he writes about coming home "not in triumph but in tremor", the line lands with the weight of lived experience. And when he writes of India healing him, holding him, and giving him a second life, it is not a nationalistic flourish; it is gratitude, raw and grounded. Tell My Mother I Like Boys is not a typical chef memoir. It is not a coming-out manifesto. It is not a voyeuristic celebrity tell-all. It is something far more intimate: a life examined honestly. A narrative built on vulnerability rather than victory laps. A story that refuses to tidy up the messiness of identity, love, culture, and family. It is also a reminder that some of the most compelling memoirs come from people who have lived several lives in one, and are finally ready to tell the truth about all of them. Saran does exactly that. It is a brave book. A generous book. And a deeply human one.

## KARNATAKA CONG CRISIS: No interference by CM's son Yathindra in administration, says Shivakumar

Opposition leaders keep saying something or the other. Everything they say cannot be taken as the truth." On allegations of interference by Yathindra Siddaramaiah, he said, "When party workers submit representations, they sometimes call officials and request action. What is wrong in asking for something that benefits workers? I receive representations related to all departments and speak to all departments. There should be no interference in administration. I have not seen him interfere in administrative matters."

Responding to rumours regarding his son's inter-

ference resulting in the tendering of resignation of Minister George, Chief Minister Siddaramaiah stated that Minister George had not resigned.

Chief Minister's Legal Advisor and Congress MLA A.S. Ponnanna said, "Minister George and Chief Minister Siddaramaiah are working closely together. Minister George is a strength to Chief Minister Siddaramaiah. The reports in this regard are false. The senior IAS officer did not attend the meeting convened by the Chief Minister. The Chief Secretary sought an explanation from him, and he has submitted his reply. The officer has stated that he was attending an official programme and that he did not intend to ignore the Chief Minister's meeting." Minister George clarified, "Is it so easy for a minister to tender a resignation? There is no interference by Yathindra Siddaramaiah in my department. He is a good person and a young leader." Former minister and senior BJP leader M.P.

Renukacharya alleged that Siddaramaiah's son, Yathindra Siddaramaiah, was interfering in all departments. "No one is able to speak about this. An audio conversation related to this had gone viral earlier. Ministers are fed up. If Chief Minister Siddaramaiah is asked to resign, a conspiracy is being hatched to make his son, Yathindra Siddaramaiah, the Deputy Chief Minister. The entire government is being controlled by Yathindra Siddaramaiah," he claimed.

Earlier, clarifying rumours that claimed Karnataka Energy Minister K.J. George had resigned due to alleged interference by Chief Minister Siddaramaiah's son and Congress MLC Yathindra Siddaramaiah, the Minister stated that all was well with the Chief Minister and that there was no question of resigning. Minister George clarified on the floor of the Karnataka Assembly on Thursday. The issue was raised by senior BJP MLA V. Sunil Kumar after the

Question Hour.

Meanwhile, asked about the postponement of the Apex Bank elections, Deputy Chief Minister Shivakumar said, "The Apex Bank election has not been postponed; no one has filed nominations. The party will decide."

Reacting to allegations that Rs 400 crore had gone missing in Belagavi and that it was Congress money, Shivakumar said, "The opposition has the CBI in its hands; let them get it investigated. We do not know whose money it is. Let an investigation be conducted. Making baseless allegations will only invite ridicule."

On local body elections, Shivakumar said, "We will conduct local body elections. There is a court hearing tomorrow or the day after regarding the reservation for these elections. We have asked panchayat leaders to prepare. The State Election Commission is also preparing and has decided to use ballot papers. Only the schedule needs to be finalised. To protect the 73rd and 74th Constitutional Amendments, we have decided to conduct elections to panchayats and municipalities."

Asked about supporters raising slogans demanding that he become Chief Minister at various programmes, he said, "I have said this issue need not be discussed now; time will give the answer. I am discharging the responsibility given to me by the party."

khadi attire on the first Saturday of every month, and to issue directions to officers and staff of their respective departments to wear khadi while participating in all official government programmes, including the Independence Day and Republic Day celebrations," Rajneesh added.

"The state government believes that this initiative will help foster respect for indigenous products, unity, national spirit, Indianness, self-respect, and a sense of social responsibility among government officers and employees," she said.

The government order has also provided the link which provides

details of the names, addresses, and products of the 176 khadi associations and institutions currently functioning across all districts in the state. The copy of the order has been sent to all Additional Chief Secretaries, Principal Secretaries, Secretaries of the state government.

This decision of the Congress-led state government has been welcomed and received appreciation from the government employees and all sections of the society in Karnataka. The move is also likely to help weaver's community and government-owned khadi production centres in the state.

## Tirunelveli: Cleanliness workers dump foul smelling free breakfast

CHENNAI : Complaining that the quality of food served for them under the free breakfast programme was unfit for human consumption, cleanliness workers from Tirunelveli Municipal Corporation dumped the food in garbage bins.

Like their counterparts across Tamil Nadu, more than 750 cleanliness workers of Tirunelveli Corporation have been getting breakfast as announced by Chief Minister MK Stalin last month, said a Maalaimalar report.

According to them, the quality of food was satisfactory in the initial days, but it deteriorated thereafter. The good being served in the recent days was unfit for consumption, the workers alleged. On Monday (January 26), breakfast distributed to



the workers in the Thachanallur zone of the Tirunelveli Corporation reportedly emitted a foul smell. Angered by the poor quality, the workers refused to consume the food and dumped it into

nearby garbage bins. The workers further stated that substandard food has been supplied consistently over the past few days, leaving them with no option but to discard the meals provided.

## New voters to receive ID cards within 15 days; enrolment period extended

CHENNAI: New voters whose applications are approved will receive their voter ID cards within 15 days, the Election Commission has said, following the Supreme Court's order extending the voter enrolment period by 10 days, said a report by Daily Thanthi.

The draft electoral roll released as part of the special revision in Tamil Nadu saw the deletion of 97.37 lakh names. This included 66,44,881 voters who had shifted homes or were absent, and 3,98,278



voters who were duplicate entries. Of them, only those who had shifted or were absent are eligible to

reapply. Applications for inclusion in the electoral roll were accepted from December 19 to January

18, and the deadline was extended to January 30. During this period, around 16 lakh applications were received. The Supreme Court has now directed that the application window be extended by a further 10 days. Election officials said applications received so far are under scrutiny. Those whose applications are approved will first be allotted a voter ID card number, following which colour photo voter ID cards will be distributed within 15 days.

CHENNAI: The Tamil Nadu government on Friday categorically ruled out the regularisation of temporary government workers, asserting that such appointments, by design and by law, cannot be made permanent, and warning that ongoing protests were being fuelled by external and political instigation rather than genuine labour grievances.

Responding to questions from reporters on agitations by temporary employees, State Minister for Health and Family



Welfare department Ma Subramanian said these workers were engaged on 11-month contractual terms and reappointed

after a mandatory break, a system followed uniformly across States. "There is no provision to regularise such appointments. Not

just Tamil Nadu, no State government in India can do so without violating court directives," he said.

He stressed that the judiciary had consistently held that permanent appointments must follow communal rotation and established recruitment norms. "Any attempt to regularise employees appointed without such procedures will invite court intervention," the Minister said, adding that protests demanding otherwise were misleading workers and the public.

## Supreme Court says right to menstrual health a fundamental right; orders free sanitary pads for school girls

NEW DELHI: The Supreme Court on Friday directed all states and Union Territories to ensure girl students in private and government schools are provided biodegradable menstrual sanitary pads for free, and held that the right to menstrual health is a part of the fundamental right to life enshrined in the Constitution.

A bench of Justices J B Pardiwala and R Mahadevan told states and Union Territories to ensure separate toilets for female and male students in all schools. It also said all schools, irrespective of whether they are state-run or controlled, will have to provide disabled-friendly toilets.



"The right to menstrual health is part of the right to life under Article 21 of the Constitution," the court held. It said that if private schools fail to provide these facilities, they will be de-recognised. The bench also

said that it would hold governments accountable if they too fail to provide for toilets and free sanitary pads to girls. The top court has reserved its verdict on a PIL filed by Jaya Thakur on December 10, 2024,

seeking pan-India implementation of the Union government's 'Menstrual Hygiene Policy for school-going girls' in government and government-aided schools for adolescent girls students from Classes 6 to 12.

Nearly 95% of devices were repaired and delivered within 24 hours, repeat visits were kept below 1%, and customer escalations remained under 0.5%, reflecting high service efficiency, quality resolution, and strong customer confidence in the premium service model.

# Trump says 'it would be great' if US 'didn't have to use' military force on Iran

Donald Trump says he has told Iran it has to do "two things" to avoid military action, as the US builds up its forces in the Gulf. "Number one, no nuclear. And number two, stop killing protesters," the US president said, adding that "they are killing them by the thousands". "We have a lot of very big, very powerful ships sailing to Iran right now, and it would be great if we didn't have to use them." His latest remarks follow weeks of pressure on Iran to negotiate a deal on its nuclear programme. Iran's Foreign Minister Abbas Araghchi has said armed forces were ready "with their fingers on the trigger" to "immediately and powerfully respond" to any aggression. Araghchi arrived in Istanbul on Friday for talks expected to focus on averting the threat of any military action by the US. Later, in a call with his Iranian counterpart



Masoud Pezeshkian, President Recep Tayyip Erdogan said Turkey was willing to help "de-escalate" tensions between Tehran and Washington, his office said. Trump made his latest comments at the premiere of a documentary about his wife Melania. Earlier this

week, Trump wrote on Truth Social: "Hopefully Iran will quickly 'Come to the Table' and negotiate a fair and equitable deal - NO NUCLEAR WEAPONS." He warned that a "massive Armada is heading to Iran", and it was "ready, willing, and able to rapidly fulfil its

mission, with speed and violence, if necessary". In response, Araghchi said: "Iran has always welcomed a mutually beneficial, fair and equitable NUCLEAR DEAL - on equal footing, and free from coercion, threats, and intimidation - which ensures Iran's rights

to PEACEFUL nuclear technology, and guarantees NO NUCLEAR WEAPONS." "Such weapons have no place in our security calculations and we have NEVER sought to acquire them," he added.

Iran's Deputy Foreign Minister Kazem Gharibabadi said that no negotiations with the US were currently under way, despite "exchanges of messages". Earlier this month, Trump said that the US would come to the "rescue" of Iranian protesters if authorities used violence against them. Demonstrations began in late December after a sharp fall in the value of the Iranian currency, but swiftly evolved into a crisis of legitimacy for the country's clerical leadership. Tehran locals told the BBC that the crackdown on protestors was unlike anything that they had witnessed before.

Though Trump initially promised that "help is on the way", he later said that he had been told on good authority that the execution of demonstrators had stopped. The US-based Human Rights Activists News Agency (Hrana) says it has so far confirmed the killing of at least 6,479 people since the unrest began, including 6,092 protesters, 118 children and 214 people affiliated with the government. It is also investigating approximately 17,000 more reported deaths. Iranian authorities said last week that more than 3,100 people had been killed, but that the majority were security personnel or bystanders attacked by "rioters". The European Union has since added Iran's Islamic Revolutionary Guard Corps (IRGC) to its terrorist list, in addition to placing new sanctions on six entities and 15 individuals in Iran.

## BURKINA FASO JUNTA ANNOUNCES BAN ON ALL POLITICAL PARTIES



Burkina Faso's junta has announced a ban on all political parties, whose activities have been suspended since the military seized power in 2022. Junta leader Captain Ibrahim Traoré has been criticised for suppressing dissent and the move will be seen as the latest move to tighten control. According to Burkina Faso's Interior Minister Emile Zerbo, the ban is part of plans to "rebuild the state" after what he said were "numerous abuses" in the country's multiparty system. Zerbo said the system had been

"promoting division among citizens and weakening the social fabric". Parties were previously banned from holding public gatherings but the new decree stops them from operating altogether. All the assets of the dissolved parties would be transferred to the state, Zerbo said, adding that a draft law would be sent to the Transitional Legislative Assembly "as soon as possible". The country had more than 100 registered political parties before the coup, with 15 represented in parliament after the 2020 general election.

## Ukraine sees quieter night as Trump says Putin will not attack its cities



Ukraine has seen a relatively quiet night after Donald Trump said his Russian counterpart Vladimir Putin had agreed not to attack Kyiv and "various towns" during a cold snap. The Kremlin confirmed it had received the US president's request, but declined to give specifics about what was agreed. While Trump did not say when the pause could begin, air raid alerts sounded in just eight Ukrainian regions overnight into Friday, with two minor injuries recorded in Zaporizhzhia. Temperatures in the capital, Kyiv, are due to plummet to -24C (-11F) over the coming days. Russia has recently intensified attacks on Ukraine's energy infrastructure, as it has during cold periods since its invasion began. Kyiv has previously seen periods without aerial attacks, so it is unclear whether a quieter night in the capital was a result of any agreement between Trump and Putin. Kremlin spokesman Dmitry Peskov said on

Friday that Putin had received a personal request from Trump to halt strikes on Kyiv until 1 February, to create favourable conditions for peace talks, but declined to comment further. Ukrainian officials had been expecting a major attack this weekend ahead of the current cold spell - if that does not take place, it could mark a significant step in US-led efforts to bring the war to a close. Ukraine's air force said more than 100 drones and a ballistic missile were fired at regions near the front line overnight. But, as of Friday morning, there have been no fresh attacks on electricity or heating infrastructure crucial for keeping people warm. Trump told a televised cabinet meeting in Washington DC on Thursday: "I personally asked President Putin not to fire into Kyiv and the various towns for a week, and he agreed to do that." He added: "It was very nice. A lot of people said, 'Don't waste the call, you're not going to get that.'"

## Music legend Fela Kuti becomes first African to get Grammys Lifetime Achievement Award



Long crowned by his legion of fans as the king of Afrobeat, the late Fela Kuti is finally being recognised by the global music industry. The Nigerian star will posthumously receive a Lifetime Achievement Award at the Grammys - almost three decades after his death at the age of 58. "Fela has been in the hearts of the people for such a long time. Now the Grammys have acknowledged it, and

it's a double victory," his musician son Seun Kuti tells the BBC. "It's bringing balance to a Fela story," he adds. Rikki Stein, a long-time friend and manager of the late musician, says the recognition by the Grammys is "better late than never". "Africa hasn't in the past rated very highly in their interests. I think that's changing quite a bit of late," Stein tells the BBC. Following the global success of Afrobeats, a genre inspired by Fela's sound, the Grammys introduced the category of Best African Performance in 2024. This year, Nigerian superstar Burna Boy also has a nomination in the Best Global Music Album category. But Fela Kuti will be the first African to receive a Lifetime Achievement Award.

## Paytm Delivers Third Straight Profitable Quarter as PAT Rises to 225 Crore; Revenue Increases to 2,194 Crore in Q3 FY 2026

Paytm (One 97 Communications Limited), India's full stack merchant payments leader serving MSMEs and enterprises, and a leading financial services distribution company, and the pioneer of mobile payments, QR codes, and Soundbox, today announced its financial results for the quarter ending December 2025 (Q3 FY26) reporting its third consecutive profitable quarter, driven by strong monetisation, higher payments GMV, merchant subscriptions, and distribution of financial services revenue. In the December quarter, Paytm reported a profit after tax (PAT) of 225 crore, an improvement of 433 crore year-on-year. EBITDA for the quarter improved to 156 crore with an EBITDA margin of 7%, reflecting an improvement of 379 crore

YoY driven by revenue growth and continued operating leverage. Contribution profit stood at 1,249 crore, up 30% YoY with a contribution margin of 57%, an improvement of 5 percentage points YoY. Paytm UPI continued to gain market share for the third consecutive quarter. Paytm's consumer UPI GMV grew 35% in the last nine months versus industry GMV growth of 16%. In Q3 FY26, operating revenue grew 20% YoY to 2,194 crore, led by higher payments GMV, increase in merchant subscriptions and growth in distribution of financial services. On a like-for-like basis, revenue growth was approximately 25%. Paytm said that there was an insignificant impact on revenue from industry stoppage of rent payments through credit card (PA PG guidelines, Sep

2025) and Real Money Gaming (RMG) Act, Aug 2025, as the company has taken proactive compliance measures over the past few years. Payments services revenue (including other operating revenue) grew 21% YoY to 1,284 crore. Net payment revenue increased by 25% YoY to 613 crore, due to improved payment processing margin and increase in merchant subscriptions which grew by 27 lakh YoY to reach 1.44 crore. Payments GMV grew 24% YoY to 6.2 lakh crore. In Q3 FY 2026, distribution of financial services revenue grew 34% YoY to 672 Cr, driven by continued growth in distribution of merchant loans and wealth products. This is despite lower volumes under the Default Loss Guarantee (DLG) program, which leads to lower revenue and lower

other direct costs. Indirect expenses declined 8% YoY to 1,092 crore, driven by lower employee costs (including ESOP costs) and lower Provisions for Doubtful Debt (PDD). Cash balance stood at 12,882 crore as of the quarter ending December 2025, providing continued capital flexibility to expand business. During the quarter, the offline merchant business was transferred to Payments Services Limited, a wholly owned subsidiary of the company, in line with regulatory guidelines. Payments Services Limited received final approval from the Reserve Bank of India (RBI) to operate as an Online Payment Aggregator. Further, the RBI authorised PPSL to operate as a Payment Aggregator for offline and cross-border payments.

## SYRIAN GOVERNMENT REACHES DEAL WITH KURDISH-LED FORCES

Syria's government has reached a deal with the Kurdish-led Syrian Democratic Forces (SDF) militia alliance that would see the gradual integration of Kurdish forces and institutions into the state. This comes after weeks of clashes which saw Syrian troops reclaim large swathes of territory in the north-east that had been under SDF control for more than a decade. US envoy Tom Barrack called it "a profound and historic milestone in Syria's journey toward national reconciliation, unity, and enduring stability". Earlier this month - and after its major territorial losses - the SDF



agreed to a ceasefire that saw much of its hold brought under government control, but reports of clashes continued. Much like that 14-point agreement, Friday's deal would see SDF withdraw from points of contact, its members join the Syrian army and government, and the

integration of its administrative and civil bodies into those of the state. The SDF said the agreement also includes the formation of a military division consisting of three brigades made of its members. The statement on X added that an agreement on the civil and education-

al rights for Kurdish people was also reached, as well as a guarantee that those displaced would be allowed to return to their homes. Part of the deal saw the transfer of prisons, oil and gas fields - which were under SDF control - to Damascus. Syrian troops seized control of the Omar facility, the country's largest oilfield, after the SDF pulled back. Earlier, the army took the strategic Tabqa dam on the Euphrates river. The Kurds previously controlled nearly a third of Syria's territory with the support of the US after it helped defeat the Islamic State (IS) group.

## Panama voids Hong Kong-based firm's canal port contracts



Panama's Supreme Court has annulled contracts allowing a Hong Kong-based company to operate container ports on the Panama Canal. The ruling comes a year after US President Donald Trump claimed China was "operating the Panama Canal" - the main shipping link between the Atlantic and Pacific oceans - in his inaugural speech. CK Hutchison Holding, through its subsidiary the Panama Ports Company (PPC), has operated two of the five ports since the 1990s. It had previously agreed to sell them to a group led by a US investment firm under a wider deal. The court found that laws allowing the firm to operate the ports were "unconstitutional", but PPC said the ruling "lacks legal basis". Trump has made repeated claims that the Central American canal is under Chinese control. During his address last January, he said: "China is operating the Panama Canal and we didn't give it to China. We gave it to Panama and we're taking it back." The following month, US Secretary of State Marco Rubio also

demanding that Panama make "immediate changes" to what he called the "influence and control" of China over the canal. Panama has previously rejected the US government's claims and President Jose Raul Mulino has said the canal "is and will remain" in his country's hands. There is no public evidence to suggest China exercises control over the canal, though Chinese companies have a significant presence there. CK Hutchison, founded by Hong Kong billionaire Li Ka-shing, is not owned by the Chinese government. But Beijing's tighter political control over Hong Kong in recent years has changed how the company is viewed internationally. Its global assets - which include ports and logistics hubs - are now often seen through the lens of wider concerns about China's influence. Against a backdrop of rivalry between the US and China over global trade routes, as well as the Trump administration's focus on US dominance over the western hemisphere, the ruling on Thursday is likely to be seen as a victory for Washington.

## TRUMP NOMINATES FEDERAL RESERVE CRITIC KEVIN WARSH TO RUN US CENTRAL BANK

US President Donald Trump says Kevin Hassett, who had been seen as a frontrunner for the Fed role, would have made "a great Chairman" but that he couldn't afford to spare him. Hassett is a long-time conservative economist and key Trump economic adviser. Taking to Truth Social in the last few minutes, Trump says Hassett is "highly respected" and "is doing such an outstanding job". "I just didn't want to let him go. Kevin is indescribably good so, as the expression goes, "if you can't do better, don't try to fix it!" In our next post, we'll bring you more on who Kevin Hassett is. Kevin Warsh has been at the top of Trump's list of favourites to lead the Federal Reserve since the president's

first term in office. The fact it took Trump this long to name him is down to one problem: that Warsh has for years been seen as a voice for higher interest rates. That's at odds with Trump - a self-described "low interest rate guy" of longstanding, who has put unprecedented public pressure on the Fed to slash borrowing costs. Since Trump's election, Warsh has taken steps to shed his reputation in media appearances and opinion columns. But Trump has remained uneasy, openly worrying about whether candidates would say one thing while jockeying for the job but do another once it was secured. But he also needs his pick to pass muster in Congress and on Wall Street, where the



potential for an independent streak is seen as a plus. For now, Warsh seems to have satisfied the president's concerns. But Trump's swift turn on his last pick for Fed chair - Powell - should serve as a cautionary tale for anyone taking the job. Trump said Kevin Warsh was from "central casting" - and in many ways he is a fairly typ-

ical central banker, as a former Federal Reserve governor and adviser to the Bank of England. Hence the markets' reaction to rumours of his appointment. Gold prices had been soaring to record highs. This was partly driven by fears that Trump would choose a Fed chairman who would cave in to his demands to cut interest

rates, leading to a falling dollar and rising inflation. Buying gold is a strategy to protect against those things. Compared to other candidates, Warsh is seen as a "relatively safe choice", in the words of Capital Economics' analyst Stephen Brown, and less likely to "morph into a full-blown Trump stooge". Gold slumped as reports of his impending appointment emerged, even falling below \$5000 an ounce at one stage this morning. Kevin Warsh, a Wall Street veteran and a former Federal Reserve member, faces one of the world's most coveted policy-making jobs - but perhaps also one of the trickiest. This selection process has not just been about who gets to be the world's most powerful

banker - but also the future of the central bank's independence. Kevin Warsh is a rare candidate who appears to appease both the president and investors. Warsh believes that rates should be lower and that the AI revolution can help contain inflationary pressures - aligning with the president. Meanwhile, some investors believe Warsh's track record on taking a tough line on inflation during his previous stint as Fed Chair hints at a pragmatic approach. He now undergoes a Senate confirmation, where there is resistance to appointing a new chair while an investigation into the present chair is ongoing. And then, once in post, he will need to prove his credibility to markets.

In a move that sent shockwaves through the digital world, Indian cricket legend Virat Kohli's Instagram account suddenly vanished on Friday morning. The profile, boasting over 274 million followers, left millions of fans in a state of confusion and panic as it appeared to be deactivated without warning. The disappearance was first noticed in the early hours of Friday. Users attempting to access the handle @virat.kohli were met with the standard error messages: "This page isn't available" or "The link may be broken." However, the anxious fans were able to catch their breath hours later when Kohli's Instagram account was reactivated, just hours later after its disappearance. The timing was particularly baffling given Kohli's red-hot form. He recently reclaimed the No. 1 ICC ODI batting ranking, though for a short interval, after a masterful 124-run knock against New Zealand earlier this month. As his Instagram went dark,



his profile on X (formerly Twitter) remained active, though the "King" offered no immediate explanation. With Virat silent, fans turned to the next best source: his wife, actor Anushka Sharma. Her recent posts were quickly repurposed as a community helpdesk, with comments ranging from the desperate to the hilarious. Here are some of the comments left on Anushka's Instagram by fans: It's 2 AM man and Kohli FC has started spamming under Instagram's official handle. Anushka maintained the

couple's trademark privacy, leaving the queries unanswered while fans speculated about everything from a high-level hack to a voluntary "digital detox." What Really Happened? As of Friday morning, the mystery has reached a semi-conclusion: Virat Kohli's account has officially returned to Instagram. While neither Meta nor Kohli's management team has released a statement, the "Nihilist Penguin" meme trend, which shows a penguin walking off into the distance, became the internet's favourite explanation for his brief exit.

## Sri Lanka Breaks Silence On ICC-Bangladesh T20 World Cup 2026 Row

The Bangladesh vs International Cricket Council (ICC) T20 World Cup row continued for over three weeks before the apex cricket board gave its final verdict on the issue. Bangladesh had requested the board to shift their T20 World Cup 2026 matches out of India. They were set to play four matches in Kolkata and Mumbai in the initial stage of the tournament. Bangladesh wanted their games to be moved to Sri Lanka, citing security concerns in India. This request had arrived in the wake of Mustafizur Rahman's exit from the Indian Premier League. While the ICC rejected Bangladesh's request, it gave the side a 24-hour



deadline to make a final decision. As Bangladesh stayed firm on its stance, the apex cricket board eliminated the side and replaced it with Scotland, the top-ranked nation among those failed to qualify for the tournament. Several reports are suggesting that Pakistan may also boycott the event



in solidarity with Bangladesh or decide not to play their matches against India. While so much drama is taking place all around, Sri Lanka stayed silent for a long time. Given they are the co-hosts of the tournament alongside India, there was a lot of attention on their reticence.

The country has finally spoken up on the issue. Cricket Secretary Bandula Dissanayake told AFP that Colombo wanted to avoid being drawn into regional disputes. "In these disputes among India, Pakistan and Bangladesh, we are remaining neutral; all of these are friendly nations," he said. The official, however, added that Sri Lanka would be willing to host future tournaments for any of the countries if asked. Notably, Pakistan and India now play their matches at neutral venues due to deteriorating political tensions. As a result, Pakistan will be playing their T20 World Cup 2026 games in Sri Lanka, including the one against India.

The suspense surrounding the development is reaching a crescendo. Pakistan Cricket Board chief Mohsin Naqvi met the country's Prime Minister Shehbaz Sharif and later posted that a decision on the "ICC matter" will be taken by Friday or Monday (February 2). Bangladesh has already been replaced by Scotland after the former's refusal to play its matches in India. If Pakistan also withdraws, there will be a big gap for the ICC to fill. In these circumstances, Uganda has offered its candidature if "a T20 World Cup seat opens." "Dear @ICC, If a T20 World

was in direct reference to what Iceland Cricket had posted a while back. They first offered to replace Pakistan and then "withdrew" as well. "It is with a heavy heart that we now announce our unavailability to replace Pakistan in the

upcoming T20 World Cup," they wrote, before adding: "Our loss is likely Uganda's gain. We wish them well." Amid the "threat," the Pakistan Cricket Board has already scheduled its T20 World Cup squad to depart for Colombo early on February 2, virtually ruling out any possibility of boycotting either the tournament or the marquee clash against India on February 15, sources close to the board told news agency PTL. "The PCB has already made travel arrangements for the World Cup squad to leave early morning on February 2 for Colombo," the source said.

## MAVERICKS TEENAGER FLAGG BREAKS 46-YEAR NBA RECORD



Dallas Mavericks' Cooper Flagg became the first teenager to score 49 points in an NBA game as they lost 123-121 against the Charlotte Hornets at American Airlines Center. The 19-year-old beat Clifford Robinson's previous record of 45 points set in 1980 when playing for the New Jersey Nets against the Detroit Pistons. Flagg, making his 43rd appearance of the season, also became the youngest player to score at least 40 points and 10 rebounds. The Hornets' Kon Knueppel, who was roommates with Flagg at Duke University, also posted

impressive numbers. The 20-year-old scored a career-high 34 points and was successful with eight of his 12 three-pointer attempts - setting a rookie record for Charlotte. Their combined 83 points was the highest of any opposing rookies in the same game. The Dallas Mavericks sit 12th in the Western Conference after falling to four successive defeats, while the Charlotte Hornets have won five in a row and are 11th in the Eastern Conference.

## Sarfaraz Khan Wears Mask On Field As Pollution Row Strikes Ranji Trophy Match

The Ranji Trophy match between Mumbai and Delhi at the Bandra Kurla Complex (BKC) Ground on Thursday saw an unexpected controversy over pollution erupt, with players seen wearing masks on the field as play continued. While news about air quality causing discomfort to athletes usually makes headlines in Delhi, it was unexpectedly Mumbai where players complained of breathing difficulties this time. The Air Quality Index (AQI) during the first day's play on 29 January was around 160, which falls into the 'unhealthy' category. However, the AQI at the MCG-BKC Ground was likely higher due to nearby construction work, which caused the air quality to deteriorate rapidly. Despite the condi-



tions, the players had no option but to continue. India international Sarfaraz Khan, his brother Musheer Khan, and several other cricketers were seen wearing surgical masks. While these masks offer limited protection against filtering PM 2.5 pollutants, the players utilised whatever resources they had

at their disposal. "...new (building) construction work is being carried out here, and because of that, the players were feeling the pollution and having issues in breathing, so they put those on," Mumbai pacer Mohit Avasthi said on Day 1. According to a report in the Times of India, the Mumbai

team has lodged a formal complaint with the Mumbai Cricket Association (MCA), urging them to take up the matter of the construction dust with the Maharashtra Pollution Control Board (MPCB). A Mumbai team source told the TOI: "Mumbai's team management has written to the MCA regarding the pollution caused by the under-construction building nearby, which has led to a significant amount of dust on the ground. Players and support staff sitting outside the dressing room were also forced to wear masks. In fact, a few players from the Delhi team even requested masks from us. Running on the field is incredibly difficult in such conditions."

## Suresh Raina's Clear Stance On Sanju Samson's Form, Picks India's Top 4 For T20 World Cup 2026

As the 2026 T20 World Cup approaches, former India stalwart and World Cup-winner Suresh Raina has thrown his weight behind Sanju Samson, calling for the team management to show the same level of patience with the Kerala wicketkeeper-batter as they once did with captain Suryakumar Yadav. Despite Samson's recent lean patch - averaging less than 20 since January 2025 - Raina believes the wicket-keeper batter's "class" and ability to handle both pace and spin make him an indispensable asset for the defending champions. Raina drew a direct parallel between Samson's current struggles and the period where Suryakumar



Yadav faced scrutiny over his consistency. "He hasn't scored runs in almost one year. But still, the captain and coach were backing him," Raina noted during a chat with NDTV on the sidelines of World Legends Pro T20 League, referring to Surya. "I think it's the same story with Sanju. If he gets a

chance, he'll definitely do well." Raina emphasized that Samson's experience and past performances, particularly his centuries in South Africa, prove he belongs at the highest level. He argued that the "top four" will be the engine room that determines whether India posts daunting totals of 190 or 210.

Suresh Raina on India's Top 4 A significant portion of Raina's analysis focused on the "Top 4" structure, which he believes will dictate India's success. He argued that the engine room of the batting order determines whether India posts par scores or unreachable totals of 210. Raina is particularly keen on the Abhishek Sharma and Ishan Kishan partnership. He praised their "fearless" intent, noting that they are capable of chasing 150 in just 10 overs. "The way Ishan and Abhishek are playing... they show intent from the first ball," Raina remarked. Raina highlighted the tactical advantage of having a left-right combination at the top.

## FULHAM SIGN MAN CITY WINGER BOBB FOR £27M



Fulham have signed Norway winger Oscar Bobb from Manchester City for £27m. Bobb, 22, has agreed a five-and-a-half-year contract at Craven Cottage and will wear the number 14 shirt. "It feels great to be here. I had a great day meeting everyone and I'm very excited," Bobb said. He added that he consulted Fulham midfielder Sander Berge, his Norway teammate, before agreeing to the move. "I spoke to Sander, my good friend, and I spoke to the manager, and he explained what the system's like, and how the lads are, and how the club is," Bobb said. "He seemed lovely, so it was an easy decision basically." Bobb is a graduate of Manchester City's academy and made 61 appearances for the senior side, scoring 13 and assisting 27 across all competitions. Sources say City will retain a 20% sell-on clause, as well as matching rights for any future bids received by the Cottagers. An example of this being exercised by City came in the summer when they resigned goalkeeper James Trafford from Burnley after they also accepted a

bid from Newcastle. Bobb has fallen down the pecking order at City after the January arrival of Antoine Semenyo from Bournemouth. "I know there are rumours, I know there are talks," manager Pep Guardiola said on Saturday after City's win over Wolves. Asked if Bobb wants to leave the club, Guardiola replied: "I think so." Bobb, who has also had interest from Bundesliga side Borussia Dortmund, has featured 15 times for City this season without scoring. He last played on 17 December against Brentford in the Carabao Cup, when he hobbled off injured inside the opening 20 minutes. Fulham have lost only one of their last seven Premier League games under Silva and sit seventh in the table following their 2-1 win over Brighton on Saturday. Bobb has featured six times for Norway this year, helping them qualify for this summer's World Cup, and would unite with compatriot Sander Berge at Craven Cottage. He missed almost the whole of last season after fracturing a bone in his leg during training in August 2024.
