Cong expresses 'grave concern' over US action in Venezuela



New Delhi (TSIT): The Congress on Sunday expressed 'grave concern' over the US action in Venezuela and the 'capturing' of President Nicolas Maduro and his wife, calling the entire operation a violation of international law. Jairam Ramesh, General Secretary in-charge Communications, Congress, in a post on X, said, "The INC expresses very grave concern on US actions relating to Venezuela in the past 24 hours. Settled principles of international law cannot be violated unilaterally." The Congress reaction to the international development coincided with a protest by Left parties on Sunday at New Delhi's Jantar Mantar. The CPI(M) leadership condemned the US for what they described as an "imperialist military aggression" against Venezuela, calling for worldwide condemnation and urging the Centre to take a clear and firm stand against the action. Another 24 lakh cases involve six or more voters being linked to a single father.

**Telangana steps up legal efforts to stall AP's Polavaram Nallamala Sagar project**



**Hyderabad (TSIT):** Telangana government has intensified its legal battle to halt Andhra Pradesh's proposed Polavaram Nallamala Sagar (Banakacherla link) project, which it alleges is being taken up without statutory approvals and in violation of established guidelines.

Ahead of the hearing of the State's writ petition in the Supreme Court of India scheduled for Monday, Chief Minister A. Revanth Reddy and Irrigation Minister N. Uttam Kumar Reddy on Sunday held a detailed meeting in Mumbai with senior Supreme Court advocate Abhishek Singhvi. During


the meeting, the Chief Minister and the Irrigation Minister instructed the legal team to present a strong and comprehensive case on behalf of Telangana. They also directed irrigation department officials to keep

all technical data, documents, and supporting evidence ready to effectively substantiate the State's objections before the court.

The Telangana government has recently filed a writ petition in the Supreme Court seeking an immediate stay on the expansion works being undertaken by the Andhra Pradesh government to link Polavaram with Banakacherla or Nallamala Sagar, allegedly without obtaining mandatory approvals. In its petition, Telangana has urged the court to direct the Polavaram Project Authority to stop these works forthwith.

The State has maintained that the Polavaram project must strictly adhere to the scope originally approved, and that any expansion or linking works are illegal and untenable. It has objected to the Centre's consideration of pre-feasibility reports for the Nallamala Sagar project without addressing Telangana's concerns, terming the process arbitrary.

**IAF commemorates 25th anniversary of Tejas LCA's first flight**

New Delhi (TSIT): The Indian Air Force on Sunday commemorated the 25th anniversary of home grown Tejas Light Combat Aircraft's (LCA) historic first flight. "On the 25th anniversary of Tejas LCA's historic first flight, #IAF reflects on enduring partnership in building this fighter. Congratulations to ADA's innovative scientists, HAL's skilled engineers, brave IAF & IN test pilots/engineers, and all IAF personnel who've championed self-reliance. Sky is the limit!" said the IAF in a post on social media. The historic first flight of Tejas occurred on January 4, 2001, with Wing Commander Rajiv Kohli piloting the Technology Demonstrator (TD-1) from Bengaluru's HAL Airport. This flight initiated the flight testing phase for the aircraft, eventually



leading to its induction into the Indian Air Force and the development of advanced variants like the Tejas MkIA. The government had established the Light Combat Aircraft (LCA) programme in 1983 with the initial goal of developing a new light combat aircraft to replace the ageing fleet of the IAF. Hindustan Aeronautics Limited (HAL) recently secured a major order for 97 additional LCA Tejas Mk-1A fighters in a deal worth over Rs 62,370 crore, finalised in late 2025.

**India calls Venezuela devts a matter of concern**

**New Delhi (TSIT):** India on Sunday termed the recent developments in Venezuela "a matter of concern" and urged all concerned parties to address issues peacefully through dialogue, ensuring peace and stability of the region. In a statement, the Ministry of External Affairs (MEA) stated that the Embassy of India in Caracas is in contact with members of the Indian community and is providing all possible assistance.

"Recent developments in

Venezuela are a matter of deep concern. We are closely monitoring the evolving situation. India reaffirms its support to the well-being and safety of the people of Venezuela. We call upon all concerned to address issues peacefully through dialogue, ensuring peace and stability of the region," it further read.

MEA's statement comes after US Delta forces attacked an army base in Venezuela on Saturday, capping months of military buildup, and captured President Nicolas Maduro along with his wife, Cilia Flores. According to US officials, the two were placed aboard a warship and transported to New York, where "narco-terrorism" charges have been filed in federal court.

The indictment, made public by US Attorney General Pam Bondi, was filed in the US District Court for the Southern District of New York. Prosecutors allege Maduro used state power for more than two decades to move massive quantities of cocaine toward the United States.



In a statement, the aviation regulator said power banks cannot be used for charging gadgets at any time during a flight, including through aircraft seat power outlets.

# Why Fourth Pillar's Questions Exasperate Leaders in Power?


**F**or smooth functioning of any democracy, 'The four pillars of democracy—the Legislature (law-makers), the Executive (law-implementers), the Judiciary (interpreters of law and justice), and the Media (the fourth estate, responsible for informing the public and holding power accountable)' should work together to ensure a government remains transparent, accountable, and serves the people, upholding principles like justice, liberty, and equality. But it is a sorry state that some pillars try to erode the others to keep their supremacy over them, which creates a situation where battle starts between them. And the media or the fourth pillar, a nearly toothless body, is the foremost target; whenever it tries to remind the other pillars their act of crossing their boundaries, the powerful pillars pounce on it.

Citing Data in her article on January 3, 2026, Jyoti Malhotra, Editor-in-Chief, The Tribune, writes—“Somewhat more worrying, is the staggering 14,875 instances of free speech violations recorded through 2025, including nine killings (eight journalists and one social media influencer), 117 arrests, including eight journalists, and 11,385 instances

of Internet censorship”. When a journalist asked questions to BJP leader and Madhya Pradesh Minister Kailash Vijayvargiya, over the death of 10 kids in Indore by drinking contaminated water, he snapped at the reporter, saying, “Don't ask a worthless (fokat) question.” With the reporter pressing for answers, Vijayvargiya, in the video which has gone viral, is heard using the word “ghanta”, a slang term commonly used to dismiss something as “nonsense” or “rubish”. The journalist is also heard asking the minister to maintain decorum in his language, reports Indian Express. Such incidents are neither rare and not limited to a single political party in India. Journalists generally become the prey of the political leaders or the governments, whenever they ask them unsuitable questions. Another such example is a hot and current issue in Punjab.

Who used Punjab Chief Minister Bhagwant Mann's chopper in India, when he was out of the country?, the question has landed some Punjab journalists and social media activists in hot water. An FIR has been registered against them by the Punjab Police, stating that their alleged posting was based on ‘distorted and unverified content’. And this issue has become the fish bone stuck in the throat for the government, as it is fetching criticism from all corners.

The Chandigarh Press Club has demanded the immediate withdrawal of criminal cases registered against journalists and online content creators over reports alleging misuse of the Punjab chief minister's



official helicopter, warning that it will move the Punjab and Haryana High Court if relief is not granted.

In a memorandum submitted to the Governor of Punjab, on January 3, 2026, Press Club representatives stated that a free and independent media is the cornerstone of democracy. Any attempt to silence journalists not only weakens democratic institutions but also erodes public trust. Club also urged the Governor to step in and seek transparency from the Punjab Government about not just the helicopter usage but also insist on public accountability in use of public funds, instead of criminalising reportage.

Club also mentioned that in November last year, vehicles carrying newspapers were stopped across several parts of Punjab, severely disrupting newspaper distribution.

This directly interfered with the public's right to information and amounted to an indirect censorship of the print media. Press Club requested the Governor to issue appropriate directions to the Punjab government to ensure that journalists are able to perform their duties without intimidation, coercion, or fear of reprisal, now and in the future.

Suggesting the Punjab government an alternative path, Press Club said, “If the government had objections to the facts or interpretation presented in these reports, there were established democratic and legal mechanisms available—such as issuing clarifications, denials, or rebuttals. Resorting to criminal proceedings instead sends a chilling message to journalists and is a deliberate attempt to suppress indepen-

dent voices and discourage investigative journalism”.

Without any discrimination of unions, they belong. Journalists from different media platforms held massive demonstrations at Chandigarh and announced that they will not tolerate the tyranny and will get the FIR cancelled at all cost.

Sukhbir Singh Badal, Supremo Shiromani Akali Dal, while addressing the journalists' congregation at Chandigarh, assured full cooperation to the journalists and said that the media has the right to write about the working of the governments. He said that this is the battle not of journalists, but also of freedom of the people of Punjab. Extending his party's support, SAD leader Badal had previously also said, “The Shiromani Akali Dal condemns this undeclared

Emergency. We stand in solidarity with the affected journalists and the RTI activists and demand immediate withdrawal of this malicious FIR”.

Badal tweeted, “The Aam Aadmi Party and chief minister Bhagwant Mann have unleashed repression against independent journalists & activists who are consistently exposing their anti-Punjabi face. The registration of a false and trumped-up case against RTI activists and journalists is a desperate attempt to muzzle the voice of the independent media and hide the failures of the AAP Punjab govt”.

Reacting over the issue, Punjab state BJP president, Sunil Jakhar, asks, “Bhagwant Mann ji, you yourself used to urge people to question their leaders. Now, when some journalists and social media influencers raised questions regarding usage of your government helicopter, you had cases registered against them. Is this democracy? Mann Sa'b, do not turn democracy into a police state”.

Punjabi Congress president Amarinder Singh Raja Warring condemned the registration of the FIR against some journalists and RTI activists, saying this was the new low of the Aam Aadmi Party government in trying to gag the freedom of expression of common people and it showed frustration and insecurity.

“I wish the AAP government and its police were as proactive in hunting down the criminals and gangsters as the swiftness they have shown in chasing the journalists and the RTI activists, Punjab would be a much better and a much safer place today”, he noted, while tak-

ing a dig at the Punjab Police for going out of way to target the journalists and RTI activists who are doing their job lawfully.

Warring said that instead of shooting the messenger, the AAP government should try to correct itself although it is quite late in the day for it. “Don't shoot the messenger, better correct yourself”, he told the government while pointing out that those who have been slapped with the FIRs have only been trying to show mirror to the government. Sukhpal Singh Khaira, Congress MLA, stated, “Targeting journalists and RTI activists for doing their constitutional duty is nothing but state-sponsored intimidation.” Jatinder S Sodhi Advocate Punjab, sharing his legal opinion with our representative, says, “With the intention of suppressing the voice of the press, the Punjab government wants to silence those who speak the truth by registering false and baseless cases, which is a direct violation of Article 19(1)(a) (Freedom of Expression and Press) of the Indian Constitution.

Important Supreme Court Judgments: Romesh Thapar vs State of Madras (1950) Democracy is impossible without freedom of the press. Bennett Coleman vs Union of India (1972) – Any step of the government that restricts the press is against the Constitution. Indian Express vs Union of India (1985) – Press is the backbone of democracy. This FIR is the opposite direction of the path on which our democracy stands. I too have always considered journalists who write about our shortcomings as my true friends”.

## Harish Rao's Irrigation Presentation Bogus, Revanth Uttam Presentation Correct Jaggareddy

Hyderabad (TIST): Telangana Pradesh Congress Committee (TPCC) Working President Jaggareddy on Sunday strongly criticised BRS leader T. Harish Rao, terming his PowerPoint presentation on irrigation as "bogus," while asserting that the presentations made by Chief Minister A. Revanth Reddy and Irrigation Minister N. Uttam Kumar Reddy were factual and accurate.

Addressing the media at Gandhi Bhavan, Jaggareddy said BRS leaders speak differently when in power and change their stand when in the Opposition. "When you were in office, you never spoke about Andhra Pradesh's water diversion. The issue surfaces only when you sit in the Opposition," he remarked.

Jaggareddy questioned why Harish Rao did not present the same arguments in the Assembly that he later showcased at the BRS Bhavan. He also asked whether Telangana people were drinking water only



because of the Kaleshwaram project and reminded that Congress governments had constructed major projects like Manjeera and Singur, which continue to supply drinking water to Hyderabad and surrounding areas.

He alleged that during the BRS regime, projects such as Kalwakurthy, Nettampadu and Bhima were over 90 per cent completed by the Congress earlier, but the remaining works were ignored. "When Congress leaders like Komatireddy Venkat Reddy and Uttam Kumar Reddy questioned the delay in completing pending projects, microphones were switched off and suspensions were enforced," he said.

Taking a swipe at former Chief Minister K. Chandrashekhar Rao,

Jaggareddy said KCR and Harish Rao grew up drinking water from projects built by Congress governments, yet now criticise the same party. He accused BRS leaders of indulging in political double standards maintaining friendly ties with Andhra Pradesh leaders while in power and raking up regional sentiments when out of office.

Jaggareddy also defended the Chief Minister's remarks in response to provocative statements, stating that political criticism should be viewed in context. "If harsh language is used against us, a strong response is inevitable," he said.

He concluded by asserting that Congress governments never indulged in exaggerated publicity. "We built dozens of projects without boasting, while BRS built one project and spoke about it a hundred times," he added, reiterating that free power to farmers and irrigation expansion remain core achievements of Congress-led administrations.

## AICC Forms Panel for 'MGNREGA Bachao Sangram', Seethakka Gets Key Role

New Delhi: The All India Congress Committee (AICC) has decided to launch a nationwide programme titled "MGNREGA Bachao Sangram" to protect and strengthen the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA). As part of this initiative, the AICC announced that large-scale protests and mass mobilisation programmes will be organised across the country. To effectively implement, monitor, and coordinate the programme, the AICC has constituted a special All-India Coordination Committee. In this national movement aimed at safeguarding the rights of rural poor and wage labourers, Telangana Minister Danasari Anasuya Seethakka has been entrusted with a key responsibility.

The Coordination Committee will be convened by Ajay Maken, with Jairam Ramesh, Sandeep Dikshit, Udit Raj, Priyank Kharge, Minister Seethakka, Deepika Pandey Singh, Sunil Panwar, and Manish Sharma as members. The AICC stated that the MGNREGA Bachao Sangram will be carried forward as a people's movement across the country, opposing the Central government's policies that allegedly weaken the MGNREGA scheme and with the objective of protecting the employment rights of crores of rural workers across India.

## Unlicensed Private Security Agency Booked Under PSARA Act



HYDERABAD (TIST): The Telangana State Controlling Authority under the Private Security Agencies (Regulation) Act, 2005 (PSARA) has registered a case against a private security agency for operating without a valid licence, after its guards were found to be accused in a murder case.

According to officials, two security guards Ranjit Pandey alias Ranjit Rai and Ritesh Kumar Rai alias Ritesh Rai—were named as accused in a murder case registered at Gajwel Police Station. During the investigation, it emerged that both were employed with Sampada Industrial Security Agency, functioning at Quthubullapur in Medchal-Malkajgiri dis-

trict. Further inquiry revealed that the agency was operating without a valid PSARA licence. Consequently, a case was registered against the agency owner under FIR No. 1994/2025, invoking Section 223 of the Bharatiya Nyaya Sanhita (BNS) read with Sections 20 and 22 of the PSARA Act, 2005.

The Controlling Authority stated that

several private security agencies in the State are engaging guards and supervisors without mandatory PSARA licences. Under Section 20 of the PSARA Act, such violations attract punishment of up to one year's imprisonment or a fine of up to Rs.25,000, or both. All PSARA licence applications must be submitted online at www.psara.

gov.in, officials said. Licensed agencies were directed to strictly comply with norms, including mandatory police verification, age limits (18-65 years), verification of identity documents, exclusion of persons with serious criminal antecedents, and completion of prescribed training.

Agencies operating without licences have been instructed to obtain registration immediately, failing which strict legal action will be initiated against directors, owners or partners.

The directions were issued by the Additional Director General of Police (Intelligence), Telangana, who is also the State Controlling Authority under the PSARA Act, 2005.

The Minister was speaking after paying floral tributes to the statue of Louis Braille at the State Department for Persons with Disabilities Welfare office on the occasion of Braille Jayanti. Addressing a gathering later, he said Braille was not merely an individual but an idea and a movement that empowered the visually impaired to live with dignity and self-reliance.

Adluri Laxman Kumar said that under the leadership of Chief Minister A. Revanth Reddy, the Praja Government has completed two years in office and is firmly committed to inclusive governance. He noted that since assuming charge of the department six months ago, he has been working with dedication to resolve the issues faced by persons with disabilities, assuring that he

would stand by them "like an elder brother."

Expressing concern that Braille textbooks are currently available only up to Class 10, the Minister said this limitation has forced many visually impaired students to discontinue their education. He informed that discussions have already been held with officials and concrete steps are being taken to provide Braille textbooks up to Intermediate and degree levels. A Government Order will be issued soon to ensure full educational opportunities for students with visual impairments, he added.

During the programme, Adluri Laxman Kumar spoke over the phone with Transport Minister Ponnambalam Prabhakar regarding the issue of free bus travel for persons with disabilities. He said the matter would be discussed at the Chief Minister's level soon and an appropriate decision would be taken to extend free bus travel across the State.

## 'Factually incorrect': Andhra Pradesh rejects Telangana CM's claim on Rayalaseema project

Amaravati, Jan 4: Andhra Pradesh Chief Minister N. Chandrababu Naidu on Sunday rejected his Telangana counterpart A. Revanth Reddy's claim that the coalition NDA government in the state halted the Rayalaseema Lift Project at the Congress leader's request.

The Telugu Desam Party-led government termed as "factually incorrect and misleading" the remarks made by Chief Minister Revanth Reddy in the Telangana Legislative Assembly on Saturday night while replying to a debate on a short discussion on Krishna waters. The Andhra Pradesh government clarified that there is no truth in Revanth Reddy's claim that the project was stopped at his request and out of respect by Chief Minister N. Chandrababu Naidu. CM Revanth



Reddy stated in the Assembly that he brought pressure on Chandrababu Naidu and the Central government to stop the Rayalaseema project. He also claimed that he told Chandrababu Naidu that he would

be ready to discuss any inter-state issue only if Andhra Pradesh stopped the Rayalaseema project, which was taking away three TMC of water every day.

The Telangana Chief Minister also offered to send a fact-finding committee comprising leaders of all parties, including opposition Bharat Rashtra Samithi (BRS), to verify if the project has stopped or not. However, while rejecting the Telangana CM's claim, the Andhra Pradesh government stated the project's suspension had nothing to do with the present government's decisions or political considerations. The state government pointed out that during the tenure of former Chief Minister Y. S. Jagan Mohan Reddy, the Rayalaseema Lift Project was taken up without obtaining mandatory statutory approvals.

## First test flight lands successfully at Bhogapuram Airport

Visakhapatnam, Jan 4: The first commercial validation flight landed successfully at the Bhogapuram Greenfield International Airport in Vizianagaram district on Sunday, heralding a new era in the aviation sector in Andhra Pradesh.

The Air India flight from New Delhi landed at the Bhogapuram Airport, about 50 km from Visakhapatnam.

Civil Aviation Minister Ram Mohan Naidu Kinjarapu and Vizianagaram MP Kalisetti Appala Naidu, along with senior officials, travelled by the test flight. The test flight landed on the 3.8 km-long runway, the longest in the country, built with the latest

technology. The airport, being constructed by GMR Group in Public Private Partnership (PPP) mode on a design, build, finance, operate and transfer basis, is expected to be inaugurated in June.

GMR Visakhapatnam International Airport Limited (GVIAL), a subsidiary of GMR Group, is constructing the airport on 2,200 acres of land with an estimated cost of Rs 4,592 crore. According to GVIAL, 96 per cent of the airport works have been completed.

Speaking on the occasion, Ram Mohan Naidu said Prime Minister Narendra Modi would inaugurate the airport in 4-5 months.

## YSR Congress accuses Chandrababu Naidu of 'betraying' Rayalaseema

Amaravati, Jan 4: Day after Telangana Chief Minister A. Revanth Reddy claimed that the pressure he mounted on his Andhra Pradesh counterpart N. Chandrababu Naidu led to the latter to stop work on Rayalaseema lift irrigation project, YSR Congress Party on Sunday accused Naidu of "betraying" Rayalaseema for personal and political gain.

The leaders of the Opposition party alleged that Chandrababu Naidu colluded with Revanth Reddy to stall the Rayalaseema project. YSR Congress Party (YSRCP) leaders Sake Sailajanath, former MLAs V. Vishweshwar Reddy and SV Mohan Reddy strongly condemned Chandrababu Naidu's alleged "betrayal" of Rayalaseema.

Reacting to statements made by Telangana Chief Minister Revanth Reddy on the floor of the Telangana Assembly, the YSRCP leaders said Chief Minister Naidu's "Rayalaseema mask" had completely fallen off. They said Revanth Reddy's open assertion,



along with his readiness for an all-party verification, exposed an unholy nexus that resulted in the stoppage of a project vital for Rayalaseema's drinking water and irrigation needs.

Terming the move a "death war-

rant" for Rayalaseema, Sailajanath and Vishweshwar Reddy demanded that Chandrababu Naidu explain what personal interests compelled him to mortgage the future of a drought-prone region. They questioned why the Chief Minister chose silence on Telangana's upstream projects and repeated diversions from Srisailam, and why Andhra Pradesh failed to defend its rights before statutory forums. The leaders recalled that under former Chief Minister YS Jagan Mohan Reddy, the Rayalaseema Lift Irrigation Project was launched with an outlay of about Rs 3,850 crore to fully utilise allocated waters through the Pothireddypadu Head Regulator, primarily for drinking water. Despite initial hurdles before environmental bodies, the project was pursued in the public interest, but was later abandoned by the coalition government, even as Telangana continued with projects like Palamuru-Rangareddy and Dindi despite penalties.

## Tirumala temple to be closed for Ten Hours

Tirumala: The temple doors of Sri Venkateswara Swamy at Tirumala will remain closed for over 10 hours on March 03 owing to Chandra Grahanam. The Lunar Eclipse occurs on March 03 and lasts nearly three and a half hours from 3:20pm to 6:47pm. It is a tradition to close the temple doors six hours prior to Grahanam. The Tirumala temple doors will remain closed from 9am till 7:30pm on March 03. Devotees will be allowed for darshan after Sudhi and other purificatory rituals after 8:30pm on March 03. Owing to the Lunar eclipse, TTD has cancelled Astadala Padapadmaradhana Seva, Kalyanotsavam, Unjal Seva, Arjita Brahmotsavam and Sahasra Deepalakshmi Seva on that devotees.

Tirupati: The annual brahmotsavams in Devuni Kadapa temple will be observed from January 19-27. The Ankurarpana for the annual fete will be observed on January 18 between 6pm and 8pm in the famous temple of Sri Lakshmi Venkateswara Swamy in Devuni Kadapa of Kadapa district. On January 24, Kalyanotsavam will be observed for which two devotees will be allowed on payment of Rs. 300 per ticket at 10:30am. Important days include Dhwajaroahnam on January 19, Garuda Vahanam on January 23, Radhotsavam and Dholi Utasavam on January 25, Vasanthotsavam and Chakra Snanam on January 27 along with Dhwajaroahnam.

## Doctors protest government move on Telangana Medical Council

Mancherla, January 4, TSIT: Doctors in Mancherla district have strongly opposed the Telangana government's decision to appoint four additional government officials to the Telangana Medical Council (TGM), alleging that the move threatens the autonomy of the statutory body.

The protest follows the issuance of G.O. No. 229 on December 22, 2025, which increased the council's strength from 25 to 29 members by add-




ing ex-officio government representatives. Medical associations argued that the decision would

reduce the number of elected doctors to a minority, undermining democratic representation within the council. In a joint statement, the Indian Medical Association (IMA), Healthcare Reforms Doctors Association (HRDA), along with several specialist bodies, described the move as "against the democratic spirit of the medical profession." They asserted that the Medical Council is an independent statutory institution and excessive government intervention would weaken its decision-making authority.

## Indian army chief begins official visit to UAE to boost defence ties

New Delhi, Jan 4 : India's Army chief General Upendra Dwivedi on Sunday departed for an official two-day visit to the United Arab Emirates (UAE) in a key step in strengthening bilateral military and strategic cooperation.

The trip underscores growing defence collaboration under the broader India-UAE strategic partnership, which has been deepening in recent years through high-level engagements and joint initiatives across security and defence sectors.

"#GeneralUpendraDwivedi, #COAS, proceeded on an official visit to the United Arab Emirates #UAE today. The visit underscores a shared commitment to deepening mutual understanding, enhancing cooperation in areas of



common interest and advancing bilateral #DefenceCooperation between the two nations", the India Army's Additional Directorate General, Public Information (ADG-PD) posted on X. General Dwivedi's trip reflects India's

focus on strengthening military diplomacy with strategic partners in the Gulf, a region pivotal for security, economic, and geopolitical interests.

India and the UAE maintain a Comprehensive Strategic Partnership, with defence cooperation emerging as a core pillar alongside trade, energy and cultural exchange. Previous military engagements between the two nations, including reciprocal visits by senior commanders and joint discussions on capability building and defence industry collaboration, highlight the sustained momentum of this bilateral relationship. The Indian Army chief's visit is expected to involve meetings with senior UAE military officials to explore further

cooperation in defence innovation, joint exercises and strategic dialogues.

Later last month, an Indian Army contingent reached the Gulf nation to participate in the second edition of the joint military Exercise 'Desert Cyclone-II', to be conducted at Abu Dhabi, from December 18 to 30.

"The aim of the exercise is to enhance interoperability and foster defence cooperation between the Indian Army and the UAE Land Forces through joint training in an urban environment, with a focus on sub-conventional operations under a United Nations mandate, enabling both forces to operate together in peacekeeping, counter-terrorism and stability operations," the Defence Ministry said in a statement.

### Ram Rahim granted 40-day parole again, critics raise questions

Rohtak, Jan 4: Dera Sacha Sauda chief Gurmeet Ram Rahim Singh, who is serving a 20-year prison sentence for raping two of his disciples, has been granted a 40-day parole once again, sources said on Sunday. Singh is currently lodged at Sunaria jail in Haryana's Rohtak district. This is the latest in a series of paroles and furloughs granted to the self-styled godman since his conviction in 2017. He was earlier given a 40-day parole in August last year. In addition, he was granted



a 21-day furlough in April and a 30-day parole in January ahead of the February 5 Delhi assembly elections. He was also allowed a 20-day parole in October 2024, days before the Haryana assembly polls, and a 21-day furlough in August 2024.

Singh was sentenced in 2017 to 20 years' imprisonment for raping two of his disciples. In 2019, he and three others were also convicted in the murder of a journalist more than 16 years ago. Prior to the latest parole, Singh had been out of jail on parole or furlough 14 times since his conviction, a fact that has repeatedly drawn criticism from Sikh organisations, including the Shiromani Gurdwara Parbandhak Committee. On several occasions in the past, Singh reportedly stayed at the Dera Sacha Sauda ashram in Uttar Pradesh's Baghpat district while out of prison. The Sirsa-based sect has a significant number of followers across Haryana, Punjab, Rajasthan and other states, with a strong presence in districts such as Sirsa, Fatehabad, Kurukshetra, Kaithal and Hissar.

## Octogenarian loses Rs 7 crore in 'digital arrest' fraud in Hyderabad

HYDERABAD: An 81-year-old man here was duped of Rs 7.12 crore in a "digital arrest" scam after fraudsters posing as Mumbai Police officers threatened him of involvement in a drug trafficking racket and extorted the amount on the pretext of "verification", police said on Sunday.

The cyber fraudsters called the victim on October 27 last year claiming to be from a courier company and informed that a parcel was sent on his name from Mumbai to Thailand in which MDMA narcotic drug, passports and some debit and credit cards were found.

They further told him that they intercepted the parcel and forwarded the case to Mumbai police.



Later, another caller called him impersonating as an official from Mumbai police and told him that he is involved in a big racket of drug trafficking, money laundering and terrorist activities, a police official said. On the pretext of verification of his

bank account details and investments, the caller then demanded him to transfer amount in the accounts provided by them in order to "come out of the case" and that the money will be returned if the old man was found to be innocent. The victim

was instructed not to inform anyone about the matter.

The octogenarian transferred Rs 7.12 crore over a period of two months. The offenders then demanded him to transfer another Rs 1.2 crore after which he realised that he was duped by fraudsters and approached the Telangana Cyber Security Bureau (TGCSCB) on December 30.

Based on the complaint, a case was registered, police said adding the victim earlier did business.

Digital arrest is a fraud where imposters posing as officials of police department or other investigating agencies dupe the victims of money, after confining them via video calls.

## Around 500 two-wheelers gutted in fire at Thrissur railway station parking area



entire shed covered with tin sheets was damaged in the fire, the official said.

A spark from an electric line that fell on a two-wheeler parked with a cover on it, was suspected to be the cause of the fire, fire officials added. Thrissur West Police registered a case in connection with the fire incident and launched an investigation. As per the FIR, around 500 two-wheelers were gutted in the fire, along with a parking fee printing machine belonging to Aswathy Enterprises, which holds the contract to operate the parking facility on the western side of the railway station.

Five fire tenders were deployed, and the blaze was brought under control by around 7.45 am, officials said. All measures were taken to prevent the fire from spreading to the railway station platforms and causing further damage.

Even though a locomotive was parked on the railway track near the spot where the fire accident occurred, the Railways has not confirmed any major damage to it, the officer said. Apart from the two-wheelers, the

spot and assessed the situation. "We have made a preliminary assessment based on the statements of employees at the parking area. A special team led by an Additional Superintendent of Police, including an Assistant Commissioner and Circle Inspectors, has been constituted," he told reporters. He said that in the wake of the incident, a decision has been taken to conduct fire audits at paid parking facilities across Kerala.

The Superintendent of Police (Railway) has been tasked with this. He will examine the matter and submit a report. In addition, a joint effort will be made to enhance security apparatus involving local police, railway police and the Railway Protection Force (RPF), Chandrasekhar said. He said preliminary statements indicated that a spark from an electric line may have caused the fire, but further investigation is required to confirm it. Revenue Minister K Rajan also visited the spot and assessed the situation. He said a thorough audit would be conducted to ensure such incidents do not occur again.

## Rajnath to commission ICG ship Samudra Pratap in Goa on Jan 5

PANAJI: Defence Minister Rajnath Singh will commission Indian Coast Guard ship 'Samudra Pratap', the first of two pollution control vessels, in Goa on Monday.


The vessel is equipped with advanced systems to detect oil spills, enabling comprehensive pollution response operations within the Exclusive Economic Zone and beyond.

"It is capable of high precision operations, recover pollutants from viscous oil, analyse contaminants, and separate oil from contaminated water," the Indian Coast Guard said.

Defence Minister Singh will commission the ship Samudra Pratap at Goa Shipyard Limited, Vasco, in South Goa on Monday, it said.

Goa Chief Minister Pramod Sawant, Indian Coast Guard Director General Paramesh Sivamani and other dignitaries will be present on the occasion. As per the ICG, the ship built by the Goa Shipyard Limited has over 60 per cent indigenous content.

The 114.5 metres long and 4,200-ton vessel boasts a speed of more than 22 knots and an endurance of 6,000 nautical



miles, significantly enhancing the ICG's pollution response, fire-fighting and maritime safety and security capabilities.

The vessel is equipped with state-of-the-art technology, including a 30mm CRN-91 gun, two 12.7mm stabilised remote-controlled guns with integrated fire control systems, an indigenously developed integrated bridge system, integrated platform management system, automated power management system, and a high-capacity external firefighting system, as per the ICG. ## Gang rape took place in ambulance, not van: Police

Faridabad, Jan 4: A fresh revelation has emerged in the gang rape case of a 25-year-old woman in Faridabad, with police confirming that the crime was committed inside a private hospital's ambulance and not a van, as initially believed.

A senior investigating officer on Sunday said the two accused were employed as a driver and helper on the ambulance of a private hospital. Both men, natives of Mathura and Jhansi in Uttar Pradesh, have been arrested and remanded to judicial custody. The survivor continues to remain hospitalised, six days after the incident.

Meanwhile, a purported video of the victim has surfaced in which she claims that after offering her a lift, one of the accused transferred Rs 600 to her PayTM account before locking the vehicle and snatching her mobile phone. She alleged that despite shouting for help amid dense fog, no assistance came. Police said the authenticity of the video is yet to be verified.

According to investigators, once the woman recovers, an identification parade will be conducted before a magistrate, following which the accused will be brought on a production warrant for further questioning. As per police records, the woman had visited a friend's house in Sector 23 on Monday evening. While returning, she reached Metro Chowk around midnight, where the accused offered her a lift. Instead of taking her home,

## Priyanka named chairperson of Congress screening committee for Assam ahead of 2026 polls

New Delhi, Jan 4: Congress leader Priyanka Gandhi Vadra has been appointed chairperson of the party's screening committee for the selection of candidates in Assam, which is set to go to Assembly polls in barely three months. Assam is among the key states heading for high-stakes elections in 2026, along with West Bengal, Kerala and Tamil Nadu.

According to a report, the Congress has also named veteran leader Madhusudan Mistry as head of the screen-

ing committee for Kerala, former Chhattisgarh deputy chief minister T S Singh Deo for Tamil Nadu and Puducherry, and senior leader B K Hariprasad for West Bengal. In Assam, the Congress is eyeing a comeback by forging alliances with other opposition parties to challenge the BJP, which has been in power since 2016. The appointment of Priyanka Gandhi is being seen as a significant move, as it marks the first time a member of the Gandhi family has been given charge of a state-level



screening committee. As chairperson, Priyanka Gandhi will play a key role in finalising the party's candidate list and steering alliance talks with smaller parties. Her close aides, Lok Sabha MPs Imran Masood and Saptagiri Sankar Ulaka, along with Sirivella Prasad, have been appointed as members of the Assam screening committee. Gaurav Gogoi, son of former Assam chief minister Tarun Gogoi, is being seen as a frontrunner from the Congress camp.

Gogoi is currently the Deputy Leader of the Opposition in the Lok Sabha, next to Rahul Gandhi. Party sources believe Priyanka Gandhi's involvement could give a strong push to the Congress campaign and bolster Gogoi's challenge against the BJP. Assam is considered a crucial battleground, with the last Assembly elections seeing the BJP-led NDA winning 75 seats in the 126-member House, while the Congress-led alliance secured 50 seats. Notably, the vote share difference

between the two blocs was just 1.6 per cent. Priyanka Gandhi, who entered active politics in 2019, faced a setback in the 2022 Uttar Pradesh Assembly elections, where the Congress performed poorly under her supervision. However, in recent months, she has been on the offensive, taking on the BJP in Parliament, leading protests on issues ranging from voter roll revision to MGNREGA-related legislation, and drawing attention for her sharp interventions and public presence.

## It Is Time for India to Speak Up for its Christians

In recent years, we have witnessed a sharp rise in targeted violence against religious minorities across the country. With Christians in particular, there are disturbing patterns of attacks, vandalism of churches, and arrest of pastors on the allegation of forced conversion. The United Christian Forum (UCF) recorded 814 incidents of violence against Christians in 2024. In 2025 alone, 706 incidents were recorded. Other organisations, like Open Doors, reported an even higher figure, over 2,900 incidents from January to November 2025. On this Christmas, a celebration of joy, peace and harmony, was claimed to be a crime of forced conversion, triggering miscreants of certain organisations to mount attacks, displaying a disturbing trend of hatred against Christians.

Prime Minister Narendra Modi, like last year on the occasion of Christmas, visited churches, met Christian leaders, and even extended wishes on a social media platform. It is a gesture that is worth appreciating. However, for a Christian like me, these symbolic acts lose all meaning when juxtaposed against his silence on the escalating attacks.

What good are platitudes when the fundamental right to celebrate one's faith without fear remains elusive?

It would have been better to spend a minute to condemn the attacks and tell the organisations to stop creating an atmosphere of disharmony. The government's resounding silence is not only causing a deficiency of trust and a breaking of its promise of sabka sath sabka vikas (with all, development for all), but is also conveying a dangerous message.

We all know that the prime minister knows who the perpetrators are and which specific political ideology they are associated with. Take the case in Jabalpur, where a BJP city vice-president assaulted a visually impaired woman, used unacceptable derogatory words against her. To my knowledge, no leader from the party has come out in public to condemn the act. Does silence imply tacit endorsement? Condemning these affiliates might disrupt vote banks, but refraining from unequivocal condemnation, endorsing directly or indirectly, gives more power and immunity to such anti-social elements. What has become the situation of today is the visible result of the prolonged silence of the authorities on recurring attacks on churches. Assam is a case in point. Misguided, communally charged individuals entered a private premise and vandalised a crib and other decorations. Decorations within a school campus are claimed to be aiding forceful conversions with no evidence. Christian leaders from the Northeast and elsewhere, affiliated with the ruling party, have refrained from speaking out, but what about the lakhs of non-Christians, many of whom were educated in Christian institutions across the country? Though the perpetrators in the Nalbari incident are arrested, it would be meaningless if they are not punished as per law, and if the authority does not ensure security to Christians staying there. The news of the attacks on Christians in India is also reported by the international media. The hypocrisy is for the global audience to see. France's laïcité laws prohibit public displays of religious symbols, yet the authorities in Paris allow a grand Ganesha procession, embracing Hindu traditions. If Western nations can accommodate diversity, why has India grown intolerant toward Christianity? Meanwhile, large Hindu communities in the West celebrate other Hindu festivals publicly. What message do these attacks send to them? That their homeland rejects the very inclusivity they experience abroad? A few journalists and concerned citizens have highlighted these issues and their efforts are appreciated. Yet a Christian on a panel on a national news show indirectly justified the attacks, calling it an inevitable friction caused by the actions of "some crazy people in a country of 1.47 billion people."

## A 'SWOT' Analysis Of Abhishek Banerjee As He Embarks On His Bengal Yatra

As the Trinamool Congress prepares for what's shaping up to be an intense political battle in West Bengal, Abhishek Banerjee's Bengal yatra marks a decisive moment. No longer seen merely as the heir apparent, he is increasingly positioning himself as a national-level leader for the party. Here is a SWOT analysis of Abhishek Banerjee at this juncture.

**Strengths** (1) Abhishek Banerjee is a young, 38-year-old leader with a modern outlook and clear generational advantages. He has exposure beyond Bengal, is English-speaking, studied in Delhi, and has a background in management, all of which shape a contemporary political style. (2) He possesses strong common sense and has a keen interest in surveys, election management, and research. Beyond IPAC, he conducts surveys through several other organisations and actively seeks feedback from professional agencies, including gauging public reactions to events such as the Messi incident in Kolkata ahead of elections. (3) He does not believe in sycophancy and is willing to take action against party members, even if they are personally close to him, reinforcing a sense of discipline with

in the organisation. (4) He is attentive to the language and style of his speeches to suit the audience and political context. (5) Mamata nominated him as the second command-in-chief and, unofficially, as the next leader. This gave him a political legacy almost spontaneously. (6) He does not fall into complacency and consistently analyses the BJP's strengths, both nationally and at the state level, to anticipate challenges. (7) He functions primarily as a party leader rather than as a minister or part of the government. This keeps him relatively fresh and untested in governance, allowing him to sell a dream of good gover-

nance as the vision of a new Bengal. **Weaknesses** (1) Mamata has the experience of a long struggle in opposition politics against the CPM, while Abhishek Banerjee lacks such grounding. His outreach to the masses tends to be more cerebral, especially when the TMC is in power. (2) Old-school politicians within the party continue to align more closely with Mamata, while Abhishek wants to induct more young blood. This generational gap is a challenge. (3) He has a brilliant, modern, corporate-style and calculative approach to politics, but this also makes him appear less spontaneous at times. (4)

# The Trump Corollary To The Monroe Doctrine Reaches Venezuela



Welcome to 2026, and under President Trump, America is back! These words by US Secretary of War Pete Hegseth best encapsulate the impact of 'Operation Absolute Resolve,' which resulted in the capture of Venezuelan socialist leader Nicolas Maduro. America is certainly back, in news headlines, as a dominating force in geopolitics, reclaiming influence in Latin America, and perhaps also back to its old ways as an architect of regime change. The operation was audacious: an integrated effort by the US Navy, Air Force, Army, Marine Corps, and the Central Intelligence Agency (CIA), 150 military aircraft from 20 different bases launched military strikes across Venezuela in the early hours of January 3. Turning off the electricity grid in Caracas, US forces entered Maduro's compound at 2:01 am local time - with the help of a confidential source who tracked Maduro's exact location. In a matter of minutes, Maduro was captured. This should come as no surprise: the US deployed more than a dozen warships and military aircraft off the coast of Venezuela since August 2025. Yet, Venezuela was never going to be an easy target. A country twice the size of Iraq, Venezuela has a population of 28 million and more than 130,000 active military personnel, 300,000 paramilitary, 229 military aircraft, a naval fleet of 34 vessels, 172 tanks, and 8,802 armoured vehicles. Conducting an operation on Venezuelan soil without any loss of US life and capturing the country's leader is no small feat. The drivers for a military attack in Venezuela A combination of factors contributed to Washington's decision to attack Venezuela and capture Maduro. First and foremost is oil. Venezuela is home to the world's largest oil reserves, at more than 300 billion barrels. In his recent press conference, Trump made no qualms about the US's interests in Venezuela's oil resources, stating that "very large United States oil companies, the biggest anywhere in the world, [will] go in, spend billions of dollars, fix the badly bro-

ken infrastructure, the oil infrastructure, and start making money for the country." He even mentioned that the 'reconstruction' of Venezuela will be done with the support of and be paid for by US oil companies. The second driver is that Maduro is a dictator, and a socialist one at that. The 2024 and 2018 elections in Venezuela have been widely acknowledged to be fraudulent, and some even question the legitimacy of the 2013 elections that first brought Maduro into power. This is reinforced by Maduro's political lineage as the ideological successor to late Venezuelan socialist Hugo Chavez, who ruled Venezuela from 1999 until he died in 2013. Washington's attack in Venezuela falls in line with the "Trump Corollary" to the Monroe Doctrine, outlined in the White House's National Security Strategy document as a "potent restoration of American power and priorities, consistent with American security interests." This also sends a message to other Latin American leaders that Washington considers troublesome, such as Nicaragua's Daniel Ortega, whose saving grace may be the fact that his country has no oil reserves whatsoever. In case this was intended to win more influence in Latin America, it may instead make the region more wary of

Washington, even if some Trump allies cheer the US's military exploits. The US military operation in Venezuela has immediate and long-term repercussions, both domestically and internationally. From a domestic standpoint, this will likely increase support for the Republican Party amongst Latinos in the US and will be projected as a major win for Trump's support base. Internationally, it is a show of force: a highly coordinated operation in a large foreign country, with no US lives lost, and the chief objective met within minutes. It shows that Washington, Langley, and the Pentagon are ready to conduct sophisticated military and covert operations on foreign soil, even if it may violate international law - as leaders from Spain, Italy, Germany, and even Senators within the US have claimed. Countries and territories that Trump has so far threatened with military force, including Iran, Nigeria, North Korea, or even Panama, will now pay much closer attention; whether Washington follows through or not, though, is anybody's guess. China and Russia, staunch allies of Maduro and providers of military and economic support to Venezuela for more than a decade, will also keep a close watch on Caracas. Although India engaged with high-level officials

from Maduro's regime, India's relationship with Venezuela has remained mostly limited to the oil trade. This is also evidenced by the fact that Maduro has never had a bilateral meeting with Prime Minister Narendra Modi. Between 2007 and 2019, India imported copious amounts of oil from Venezuela, and Indian companies like ONGC Videsh also invested billions in Venezuelan oil fields. After US secondary sanctions were imposed on Venezuela in 2019 and 2020, India's oil imports from the Andean nation reduced dramatically. Now, with the US attempting to exert more influence in Venezuela's local production, India's oil firms may have to wait in line behind Western firms. What next for Venezuela? Trump stated his intention to 'run the country' until Washington can be assured of a 'safe, proper and judicious transition' in Venezuela. Yet, amidst the noise of the US military operation, we should remember that Venezuela has not yet undergone a regime change. The regime in question is the United Socialist Party of Venezuela (PSUV in Spanish), and it remains entrenched in power, at least for the time being. Delcy Rodriguez, the country's vice president, addressed Venezuelans on Saturday afternoon.

## History as Ethical Compass in Crises of the Present and the Future



Of many that engulf our ideas of the present and the future, four are the most significant. First, post-cold war (fall of the Berlin wall, fall of the USSR, and the phase of liberalisation and privatisation in India, for instance), the disparity between the rich and the poor has increased. This development is a result of a paradox between economic and political process. The entrenchment of capitalism, the intensified harnessing of all forms of energy, and the emergence of new forms of global businesses coincided with a push to democratisate and radicalise the formerly elitist political orders. For instance, in a country like India, from the early 1990s through the 2010s, the liberal economic policies that allowed the operation of private capital into various spheres of production and investment went hand in hand with an outlook of social justice politics which, at least theoretically, stood for equitable distribution of resources in the favour of the deprived. Yet, the net result of the last 30-40 years is the widening of the economic gap: the rich have become richer and the poor poorer. The richest 1% of India's population controls almost 50% of the total wealth, which is the highest in the last six decades. Second, the subsequent journey of the relationship between economic liberalisation and political questioning of the erstwhile set-up that turned blind to the growing class disparity has transformed the liberal aspirational journey into a widespread popularity for right-wing politics. As capital became highly mobile and culture began to cross boundaries in a more rapid manner,

erating profit and comfort for themselves, the migrant is not an economic category alone. The value system behind this term works through larger social practices defined by race, religion, class, gender, caste, language, and region. In some places migrants are bad because they happen to belong to a certain religious faith; in others, they are hated and thrashed because they speak different language. The third feature of our current times is the deep and astonishingly normalised practice of sub-or de-humanisation of people who are seen and treated as inferior and unwanted. The current form of capitalism has become a conduit for practising unequal human relationships, which we otherwise casually characterise as feudal. But our own modern values and systems based upon informal work, low-paid jobs, and continued faith in the relevance of maintaining social distinctions have emboldened the process of dehumanisation. Some lives have become cheaper than others; the dignity of a few is precious than the rest. History has never been egalitarian. For centuries, race, gender, and caste, for example, have governed the systems of hierarchies amongst people. But an interesting feature of our times is the effectiveness with which the exclusionary social and political views have been mobilized under the name of nationalism, civilisational legacy, democracy, and even constitutionalism - concepts which are modern in provenance and have at least nominally adhered to establish the principles of equality - to create unequal relationships among people. The inversion of the concepts which otherwise were meant to establish equality and inclusion within the framework of diversity has created one of the biggest intellectual blackholes of our times. The fourth challenge, which is in some ways an aggregate of all three, is the effect of human actions on the planet Earth, leaving a question mark dangling before the future of not only humans but other species as well.

## Case registered over alleged hate speech on social media in Karkala

Karkala, Jan 4: Karkala Rural Police have registered a case against a man for allegedly posting content on social media that promotes communal hatred and disrupts public harmony. According to police sources, the case was registered based on a complaint filed by Rudresh, an official at the Karkala Rural Police Station. During routine monitoring of social media platforms, the police noticed a post published at around 4:45 pm on January 3 on a Facebook page titled 'Sudeep Shetty Nitte'.

In the post, it was stated



that if Hindu-Muslim harmony is truly desired, the so-called harmony committees have many important responsibilities to address. Instead of that, there is no need to organize programs like 'Dhaf Duf Dum' during Hindu processions. The post further stated that if they

genuinely care about harmony, they should work to eliminate issues such as love jihad, cow slaughter, terrorism, attacks on Hindu processions, spitting on food, attacks on Hindu religious places, encroachments, assaults, thefts, and actions that disturb social peace.

The home minister should have called the person in danger and provided protection. But the home minister called the one who fired the gun and inquired about his well-being. We are now seeing the results of the transfer racket. For the first time in Karnataka's history, someone has come to an MLA's house and fired a gun. As the Congress government's term is nearing its end, people will throw Congress MLAs into the trash bin, he said.

A Valmiki corporation officer committed suicide and died. In Raichur, a police officer died due to pressure. CM Siddaramaiah himself tried to slap a police officer on the cheek. In this case, they have suspended the SP. They have taken such action to twist the matter. This is

Corporation officials must reveal who gave permission to put up the banners, he insisted.

## Concern over the Commission gearing up for voter list revision in the state: Dr. Anand Kumar



Bengaluru : Dr. Anand Kumar, National Coordinator of the AICC SC Department and in-charge of Maharashtra said that, The Central Election Commission has embarked on an attempt to weaken the very foundational pillar of democracy by conducting a Special Intensive Revision (SIR) of the electoral rolls, and now the fact that it is preparing to revise the voter list in the state as well is a matter of grave concern. Along with this, the opposition parties have taken up another dangerous and condemnable attempt to vitiate the political atmosphere by using one of the Commission's old surveys.

On one side is the Election Commission, and on the other, the opposition parties are engaged in misleading voters. They are involved in a massive conspiracy to weaken democracy. Basing themselves on an outdated survey conducted by the Commission in May this year, there is an attempt to wrongly portray the current political situation and mislead the public, which amounts to a conspiracy that strikes at democratic values, he alleged.

Leader of the Opposition in the Lok Sabha, Rahul Gandhi, raised his voice regarding electoral irregularities in August this year. However, the Commission has so far not provided any clarification regarding the serious allegations of vote manipulation made by Rahul Gandhi. Meanwhile, the opposition parties in the state

are misleading the public by projecting figures related to the SWEEP (Systematic Voters' Education and Electoral Participation) awareness activities, he criticized.

In a statement issued in this regard, he said that any survey or study conducted by the Commission reflects only the social, economic, and political conditions prevailing at that particular time; it cannot be used to conclude that the same situation continues years later.

However, the opposition parties are concealing this basic truth and are creating confusion among the public by attempting to apply findings from old surveys to the present political context, which is condemnable.

Misinformation will damage public trust and lead to adverse consequences by eroding confidence in constitutional institutions like the Election Commission. Twisting and using the functioning of the Commission for political gain goes against the spirit of democracy. The opposition parties' resort to such old documents to divert public attention exposes their political weaknesses. Instead of engaging in political debate based on facts, descending into misinformation is an insult to the people, he said.

Furthermore, the Election Commission's readiness to undertake voter list revision in the state has given rise to several doubts. Creating an environment in which the very voting process—the cornerstone of democracy—comes under suspicion is an extremely dangerous development. In particular, there are serious doubts about whether the revision process will be conducted transparently, and it has raised grave questions about it being carried out unilaterally.

The timing, purpose, and methodology of revising the electoral rolls are of utmost importance. However, the Commission's recent actions are increasing anxiety among the general public instead of trust. There is a fear that lakhs of genuine voters may be excluded from the rolls, which amounts to a direct attack on democratic rights, he alleged.

Past experiences show that

in the name of voter list revision, the poor, Dalits, minorities, migrant workers, and the urban poor have been excluded from the rolls in large numbers. In this background, suspicions are growing stronger that the ongoing revision process is being carried out with the intention of promoting a particular political agenda, Dr. Anand Kumar expressed concern.

The Commission should have adopted complete impartiality, transparency, and a people-centric approach. However, implementing decisions unilaterally without providing adequate answers to the concerns raised by political parties and civil society is damaging the credibility of the Commission. Removing a name from the voter list effectively deprives that citizen of the right to vote. This is not merely a technical error; it is an assault on the soul of democracy. Any revision process must be carried out with public participation, wide awareness, and clear guidelines. But a clear lack of these is evident, he said.

Therefore, the Commission must immediately review this revision process. It is the Commission's duty to consult all political parties, social organizations, and experts, and to assure that no genuine voter is deprived of the right to vote. For democracy to remain strong, voter trust is essential. Any attempt that undermines this trust must be firmly opposed by the state, Dr. Anand Kumar stated.

Bengaluru : In the wake of technical issues that led to a reduced insurance payout to the family of late IAS officer Mahantesh Bilagi, who died in a road accident last month, Medical Education and Skill Development Minister Dr Sharad Patil has directed that all doctors, officers and staff under his department mandatorily enrol for term insurance as a social security measure.

The issue came up during a governing council meeting of a medical college on Saturday, where a senior official from the Finance Department informed the meeting that the late officer had not updated his service status in the term insurance system after being promoted from the State Civil Services to the IAS. This oversight resulted in his family receiving nearly 50 lakh less than the entitled amount for an IAS officer in the event of death.

Taking serious note of

the lapse, Dr Patil immediately instructed Additional Chief Secretary (ACS) Mohammed Mohsin to issue a circular mandating all medical college and hospital doctors, officers and staff to pay term insurance premiums commensurate with their current salary and designa-

tion. This, the Minister said, would ensure that families receive the full entitled insurance amount in the unfortunate event of an employee's death. The Minister observed that many employees, particularly those in lower pay scales, may not have opted for adequate term insurance

due to financial constraints or lack of awareness. To address this, Dr Patil directed the ACS to convene a meeting with leading banks and insurance companies to offer department employees the best possible term insurance schemes at affordable premiums. The objective is to pro-

vide comprehensive financial security to the families of employees across all cadres. The Minister also asked senior officials to examine the feasibility of extending term insurance benefits to contract employees working in the department.

Outsourced Employees to Be Migrated to Contract Posts

In another employee-friendly decision, Dr Patil directed the ACS and Directors of all medical colleges and hospitals to consider absorbing experienced and meritorious outsourced employees into contract positions, strictly following the reservation roster system.

Instead of resorting to fresh recruitment to fill temporary vacancies, the Minister said institutions may identify eligible outsourced personnel with proven experience and migrate them to the contract category, ensuring continuity and fairness in employment.

## Open to Vedanta to file plea before authorities over green copper plant in Thoothukudi: Madras HC

A writ petition filed by Vedanta seeking a direction to the Tamil Nadu government to decide its representations, "in the matter of starting green copper initiatives by changing the original process," came up for hearing in the high court recently.

**CHENNAI:** Vedanta's Sterlite Copper unit may file a fresh application before the competent authorities in Tamil Nadu in connection with its green copper plant proposal, the Madras High Court has said.

A writ petition filed by Vedanta seeking a direction to the Tamil Nadu government to decide its representations, "in the matter of starting green copper initiatives by changing the original process," came up for hearing in the high court recently.

The matter was heard by the Division Bench of Chief Justice Manindra Mohan Shrivastava and Justice G Arul Murugan.

The State's counsel submitted that earlier, due to breach of consent and other violations, action was taken to close down the industry and the "order was assailed up to the Supreme Court."

The counsel further submitted that "if the petition-



er intends to recommence, proper applications have to be filed before the competent authorities and not mere representations addressed to the Chief Secretary and the other Secretaries of the departments."

He also said another related petition (Fatima vs State of Tamil Nadu, represented by its Principal Secretary, Environment and Forest Department, Secretariat, Chennai and four others; writ plea of 2019) was pend-

ing consideration before the court.

The court directed listing the petition to January 29, 2026 along with the plea of the year 2019 and said:

"The pendency of this petition shall not come in the way of the petitioner in moving fresh application before the competent authorities and it will be open for the authorities to take a decision thereon."

PR Kovilan, Advocate, Supreme Court said: "This paves the way for Vedanta

to initiate the formal application process for setting up a green copper manufacturing plant."

The advocate, part of a citizens group that supports environmentally sustainable initiatives, expressed confidence that Vedanta's green copper plant, when established, will validate that industrial growth and environmental sustainability can coexist. Also, it would prove to be a turning point in the "future-ready" progress of Tamil Nadu."

Vedanta Limited's Sterlite Copper Unit, Thoothukudi was the petitioner.

Tamil Nadu government's Department of Industries and Department of Environment and Climate Change were the first two respondents. The Centre's Ministries of Environment and Mines, the Central Pollution Control Board, and the TN's SIPCOT were the other four respondents.

## Beware the Rise of Superweeds: Mowing's Unintended Consequences



Due to plant defense mechanisms, the flowers of silverleaf nightshade (*Solanum elaeagnifolium*) are consumed less by natural predators like this tobacco hornworm (*Madura sexta*) if the plant is frequently mowed. Research indicates that frequent mowing of *Solanum elaeagnifolium* enhances its defensive traits, making it more resilient and potentially a superweed. The study highlights the necessity for updated weed management practices that consider the adaptive responses of invasive plants to disturbances. Research on the effects of mowing on a common weed has found that what doesn't kill you can make you stronger.

Published in *Nature's* Scientific Reports, the study found that frequent mowing of *Solanum elaeagnifolium* may help create a "superweed." *Solanum elaeagnifolium* — also known as silverleaf nightshade — can be found from south Texas to South Africa and Greece, infesting fields and soaking up valuable nutrients intended for cash crops. The weed with purple flowers — sometimes white and light purple — has prickly spines and poisonous berries. Silverleaf nightshade, scientifically known as *Solanum elaeagnifolium*, is a perennial weed native to the United States and parts of Mexico but has spread to various regions worldwide. It is easily recognized by its silver-green leaves and purple, sometimes white, star-shaped flowers. The plant contains toxic compounds and bears yellow or orange berries that are also poisonous.

Relatives of the plant,

including *Solanum ptychanthum* or black nightshade, and *Solanum carolinense*, or Carolina horsetail, also produce toxic berries and are native to Arkansas. It's a family that also includes some friendly crops such as tomatoes, potatoes, peppers, and eggplants. Rupesh Kariyat, an associate professor of entomology and plant pathology with the Arkansas Agricultural Experiment Station, has been studying silverleaf nightshade for more than a decade. Kariyat began the study while at the University of Texas Rio Grande Valley, when he and his graduate student Alejandro Vasquez took on what turned into a five-year, two-part study to observe the effects of frequently mowed silverleaf nightshade. Kariyat joined the experiment station, the research arm of the University of Arkansas System Division of Agriculture, in 2022. Frequently mowed silverleaf nightshade develops more spines on the stem to protect its flowers from caterpillars.

Although studies have often highlighted weed fitness and

defense against caterpillars feeding on the flowers. The flowers became more toxic to caterpillars, leading to less pressure from natural predators.

Like time bombs, the plant produced some groups of seeds that germinated faster and others that were delayed. This "staggered" germination was the plant's way to ensure survival over the long haul. "You are trying to mow these plants so that the plants are getting eliminated," Kariyat said. "But what you are actually doing here, you are making them much worse, much stronger." Tilling areas with silverleaf nightshade also spreads the plant because the rhizomic roots, like many weeds, can propagate asexually over multiple years and growing seasons.

The observations of mowed, unmowed, and frequently mowed areas with silverleaf nightshade provide evidence that could prompt further studies by weed scientists on best management practices, Kariyat said. Since the studies focus solely on silverleaf nightshade, Kariyat said other weeds — even the plant's family relatives — may or may not react the same way to frequent mowing. However, the study does provide more insight into the defensive capabilities of plants pitted against human disturbance. The current study is the first to ask to what extent these preferences make up their daily life input. "To see what young babies see and look at," says Anderson, a former postdoctoral researcher in Smith's Cognitive Development Lab, she and her colleagues put head cameras on infants to wear in the home during daily life activities.

"You can buy 'baby flash cards' for newborns that show these simple, high-contrast images," she explains. In a follow-up to the current study, published in the 2023 Neural Information Processing Systems Conference Proceedings, they found that if you train an AI system by first feeding it images characteristic of early infancy, it has greater success learning to identify visual images in a random developmental order or simply providing images typical of an adult's daily life. The more precise developmental sequence produced the best results. Their work opens up new avenues for evolutionary speculation.

# US-Venezuelan conflict not to impact India's trade: GTRI

New Delhi: The US-Venezuela conflict will have a negligible impact on India's trade with the South American country, think tank Global Trade Research Initiative (GTRI) said on Sunday. On January 4, American forces carried out a large military operation in Venezuela, capturing President Nicolas Maduro and his wife and taking them to the US to face various charges, including narco-terrorism and drug trafficking. "India faces negligible impact, as trade with Venezuela has collapsed under sanctions, with crude imports down 81.3 per cent in FY2025 and overall bilateral trade remaining marginal," the GTRI Founder Ajay Srivastava said. For India, he said, the Venezuelan disturbance is unlikely to have any material economic or energy impact. Although India was a major buyer of Venezuelan crude in the 2000s and 2010s, bilateral engagement has weakened sharply since 2019 due to US sanctions, which forced India to cut oil imports and scale back commercial activity to avoid secondary



sanctions, he added. As a result, Srivastava said India's trade with Venezuela is now small and declining. In FY2025, India's total imports from Venezuela were just USD 364.5 million, of which crude oil accounted for USD 255.3 million, an 81.3 per cent drop from USD 1.4 billion in crude imports in FY2024. India's exports to Venezuela were modest at USD 95.3 million, led by pharmaceuticals worth USD 41.4 million. "Given the low trade volumes, existing sanctions constraints, and the large geographical distance, the

current developments in Venezuela are not expected to have any meaningful impact on India's economy or energy security," he said. Venezuela holds about 18 per cent of the world's oil reserves, more than Saudi Arabia (around 16 per cent), Russia (about 5.6 per cent), or the United States (around 4 per cent). ## Experts warn tobacco tax hike may boost smuggling, hit revenue

New Delhi: An unprecedented tax hike, coupled with a new excise duty structure on tobacco, could lead to a surge in illicit trade of cigarettes and result in significant tax revenue losses for the country, experts said. Earlier this week, the finance ministry notified amendments to the Central Excise Act, imposing an excise duty ranging from Rs 2,050 to Rs 8,500 per 1,000 sticks based on cigarette length, effective February 1. This duty will be over and above 40 per cent GST. This would imply the overall tax hike of 60-70 per cent, varying across lengths. Currently, the overall tax of about 50-55 per cent, depending on the length. The unexpected tax hikes proposed in the transition from the GST compensation cess to excise on demerit goods have triggered concern of increased smuggling of tobacco products and cigarettes, Think Change Forum Secretary General Ranganath Tannir said. "Public finance theory is clear that excessive taxation of inelastic goods fuels illicit trade, not compliance. This risk is amplified in India, where cigarettes are already among the most unaffordable globally, as measured by the WHO's affordability indicators. Making them even more



expensive will not suppress demand, but redirect it most likely towards smuggled and illegal products — undermining revenue," he said. According to global financial firm J P Morgan's Asia Pacific Equity Research report, a higher rate for the King Size Filter Tip (KSFT) segment implies increased risk of consumer downgrading to cheaper variants, and may also induce an increase in the offtake of illicit cigarettes. In India, illicit tobacco already accounts for about 26 per cent of the total tobacco market, making it the fourth-largest market for smuggled tobacco globally. Another brokerage house, Nomura, in its research report said, "high taxes on cigarettes, while aimed at reducing consumption, have unintended consequences of fuelling growth of illicit cigarettes and pushing consumers

towards cheaper, non-tax paid smuggled cigarettes". Citing a report by the Tobacco Institute of India (TII), Jefferies said the industry body has requested the government for a review, as a wider legal price gap could help non-duty-paid cigarettes, which will also result in tax leakage. International experience from Australia demonstrates how overly aggressive tobacco taxation can backfire by fuelling organised crime. Repeated tax hikes between 2012 and 2020 drove cigarette prices sharply higher, triggering a surge in illicit tobacco from under 2 per cent to around 14 per cent of the market. "The new excise levies are unprecedented. Since they come into effect from February 1, 2026, there is still time to revisit and rectify them before they spawn a much larger problem of uncontrollable illicit networks," an analyst said.

## EV penetration in luxury car segment dips in GST 2.0 era




New Delhi: Electric vehicle (EV) penetration in the luxury car segment has seen a drop by nearly 3 percentage points in the GST 2.0 era with the internal combustion engine versions offering better total cost of ownership, according to industry players. While the trend is also visible in the mass market segment, it is the entry luxury segment that is witnessing a more marked shift towards internal combustion engine (ICE) vehicles as price difference between EV and ICE widened under the new GST rates. "If I look at October and November (2025), it came down by 2 to 3 percentage points across mass market as well as luxury, because of ICE having much better TCO (total cost of ownership) compared to EV. So, the moment the equation changes, we can see a change in (EV) penetration," Mercedes-Benz India Managing Director and CEO Santosh Iyer told PTI. The major "fluctuation" is in the entry luxury EV segment, he said, adding that for Mercedes-Benz India, its

EVs are mostly in the top-end luxury segment. "In the top-end EV, the price sensitivity is a bit lower compared to what you see in the entry segment. The degrowth in the luxury EV is more driven from entry level," Iyer noted. For Mercedes-Benz India, he said EV penetration in its overall sales is 8 per cent but in the top-end vehicle priced above Rs 1.5 crore, it is 20 per cent. BMW Group India President and CEO Hardeep Singh Brar said, "While GST 2.0 has made our ICE portfolio more attractive, we are

seeing strong and sustained momentum in EV demand as well. Customers today are not driven by pricing alone. They value sustainability, lower running costs and future-ready technology." He said on ICE models, BMW Group India had passed on the entire benefit of GST 2.0, with an average reduction of 6.7 per cent across the range and customers took the "double advantage of exclusive financial offers by BMW Smart Finance as well as reduced prices". Brar reiterated that BMW's ICE and EV models have been growing remarkably well. "For the period Sep-Nov, sales of our ICE cars have posted double digit growth YoY. At the same time, BMW and MINI EV sales have grown by over 130 per cent YoY. Our overall growth and EV penetration are ahead of the luxury segment average," he said. For BMW, EV penetration is 21 per cent of its total sales in India. It has set a target of taking it to 30 per cent by 2030. Offering another perspective, Audi India Brand Director, Balbir Singh Dhillon said the GST 2.0 framework is still being absorbed by the market and its full impact is likely to become evident over the coming year.

"In this evolving environment, our electric portfolio has continued to perform steadily, underscoring the growing acceptance of luxury EVs among Indian buyers," he added. Dhillon further said, "The Audi e-tron range has seen consistent demand, with current allocations sold out under our global planning cycle."

## FPIs pull out Rs 7,608 cr from equities in just 2 days of Jan



New Delhi: Foreign portfolio investors have started 2026 on a cautious note, extending their selling streak from last year by withdrawing Rs 7,608 crore (USD 846 million) from Indian equities in the first two trading sessions of January. The withdrawal of funds followed the largest outflow of Rs 1.66 lakh crore (USD 18.9 billion) recorded in 2025, triggered by volatile currency movements, global trade tensions and concerns over potential US tariffs, and stretched market valuations. This sustained selling pressure by foreign portfolio investors (FPIs) has significantly contributed to the nearly 5 per cent depreciation of the rupee against the dollar during 2025. However, market experts believe the tide could turn in 2026. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, said the year is likely to witness a shift in FPI strategy, as improving domestic fundamentals may start

attracting net foreign inflows. A robust GDP growth and the prospects of a recovery in corporate earnings bode well for positive FPI flows in the coming months, he added.

and stability in the USD-INR pair could create a favourable backdrop for foreign investors. He noted that equity valuations have become relatively comforting compared to last year, which could further support a revival in inflows. Despite these positive expectations, FPIs have begun 2026 on a cautious note, and according to data from NSDL, they pulled out nearly Rs 7,608 crore from Indian equities between January 1 and 2. This trend is not unusual, as foreign investors have historically remained guarded in January, having withdrawn funds in eight out of the past ten years, Khan said. # Trump says US will 'run' Venezuela and 'FIX OIL INFRASTRUCTURE'



**MADURO ARRIVES IN NEW YORK TO FACE CHARGES**

The US will "run" Venezuela until a "safe, proper and judicious transition" can be ensured, Donald Trump has said, after US strikes led to the capture of country's President Nicolas Maduro. US oil companies would also fix Venezuela's "broken infrastructure" and "start making money for the country", the US president said. The US launched strikes on Venezuela on Saturday morning in which Maduro and his wife, First Lady Cilia Flores, were captured by US forces and removed from the country. Venezuela announced a state of national emergency and denounced the "military aggression", with the country's vice president saying Maduro is its only leader. Maduro and Flores were flown out of the capital, Caracas, on a US helicopter in the early hours of Saturday morning and

taken aboard the USS Iwo Jima at an unknown location in the Caribbean Sea. They were later flown to the Guantanamo Bay US Naval Base in Cuba before being transferred to another plane to head to New York state, and then flown by helicopter into New York City's

Metropolitan Detention Center in Brooklyn. US Attorney General Pam Bondi said Maduro and Flores had been indicted in the Southern District of New York. The pair have been charged with conspiracy to commit narco-terrorism and import cocaine, possession

of machine guns and destructive devices, and conspiracy to possess machine guns and destructive devices against the US. "They will soon face the full wrath of American justice on American soil in American courts," Bondi wrote on X. Previously,

Maduro has vehemently denied being a cartel leader and has accused the US of using its "war on drugs" as an excuse to try to depose him and get its hands on Venezuela's vast oil reserves.

Trump told a news conference ahead of Maduro's arrival in New York: "The oil business in Venezuela has been a bust, a total bust for a long period of time. "We're going to have our very large United States oil companies, the biggest anywhere in the world, go in, spend billions of dollars, fix the badly broken infrastructure, the oil infrastructure, and start making money for the country." The South American country has approximately 303 billion barrels' worth of crude, accounting for about 20% of the world's oil resources, according to the US Energy

Administration. It is unclear exactly how the US plans to "run" Venezuela, but the president said it will be a "group" of people leading the charge. "We're going to be running it with a group, and we're going to make sure it's run properly," Trump said. When pressed by reporters as to who inside Venezuela would form part of that group, Trump said US Secretary of State Marco Rubio had been talking to Delcy Rodriguez, the country's vice-president. Trump said Rodriguez - who has since been sworn in as interim president by Venezuela's Supreme Court - had expressed her willingness to do "whatever the US asks". However, speaking on state TV after Trump's remarks, Rodriguez called Maduro the "only one president in Venezuela", adding that the government was ready to defend itself.

## Brigitte Bardot Foundation issues warning about scam memorabilia



The charity Brigitte Bardot established has issued a warning about "scam" merchandise purporting to fund its work following the French actress's death. The Brigitte Bardot Foundation said it was aware of "crude fabrications" being advertised online alongside claims the proceeds will go to the animal welfare charity. It threatened to take legal action against anyone taking part in "these alleged illegal fundraising efforts", stating: "Everyone is asked to respect the memory of the deceased." Bardot died aged 91 last Sunday. After revolutionising 1950s French cinema and becoming a symbol of sexual liberation, she quit acting to devote her life to animals. But the actress-turned-activist courted controversy later in life over a string of remarks about Muslims, gay people and the #MeToo movement. She was fined five times for inciting racial hatred. Her death prompted tributes in a statement on Saturday.

## Swiss open criminal case against managers of ski resort bar after deadly fire



The managers of a bar where a fire killed 40 people and injured another 119 have been placed under criminal investigation, Swiss prosecutors have said. The French couple - named by the media as Jacques and Jessica Moretti - are suspected of manslaughter by negligence, bodily harm by negligence and arson

by negligence, the prosecutors' office in Valais said. Eight Swiss nationals from among those killed were the first to be identified on Saturday. The likely cause of the fire at Le Constellation bar in Crans-Montana was sparklers on bottles being carried too close to the ceiling, a preliminary investigation found.

## UK AND FRANCE BOMB UNDERGROUND IS ARMS BUNKER IN SYRIA



Royal Air Force Typhoon jets have joined French aircraft in a joint strike on an underground arms cache in Syria used by the Islamic State group (IS), the UK Ministry of Defence says. "Careful" intelligence analysis led officials to believe the facility was storing arms and explosives, the statement said, and was in mountains just north of Palmyra, an ancient site in central Syria. "Our aircraft used Paveway IV guided bombs to target a number of access tunnels down to the facility... initial indications are that the target was engaged successfully," the MoD said. There was no sign of any harm to civilians in the strike late on Saturday and all the aircraft returned safely, the MoD added. Detailed assessment

of the strikes is under way but officials believe "the target was engaged successfully". The Typhoon FGR4s were supported by a Voyager refuelling tanker. IS imposed jihadist rule over parts of Syria and Iraq until 2019. "This action shows our UK leadership, and determination to stand shoulder to shoulder with our allies, to stamp out any resurgence of Daesh and

their dangerous and violent ideologies in the Middle East," UK Defence Secretary John Healey said. RAF aircraft have carried out patrols over Syria to "prevent any attempted resurgence" of IS following its defeat at the battle of Baghuz in 2019, the ministry said. "I want to thank all the members of our armed forces involved in this operation for their professional

ism and their courage," Healey said. "They were among thousands of British personnel deployed over Christmas and New Year. This operation, to eliminate dangerous terrorists who threaten our way of life, shows how our armed forces are ready to step up, all year round, keeping Britain secure at home and strong abroad." The RAF has been using aerial drones and manned aircraft to strike IS fighters and targets as part of the international coalition since 2014. The United Nations says IS still has between 5,000 and 7,000 fighters in Syria and Iraq. In November, Syria - under the leadership of new President Ahmed al-Sharaa - became the 90th country to join a US-led coalition to combat the group.

## POLICE IDENTIFY 16 MORE VICTIMS OF SWISS BAR FIRE




The bodies of 16 more victims of a bar fire in the Swiss ski resort of Crans-Montana have been identified by police. The youngest person was a Swiss girl aged 14, with nine aged under 18. The group includes people of Swiss, Italian, Romanian, Turkish and French nationalities, police said. This brings the number of people who have been identified as killed in the fire to 24. Among them is 16-year-old Swiss national Arthur Brodard, his mother has said. A criminal investigation into the people who ran Le Constellation bar is under way, while victim's families are enduring an

agonising wait for information about loved ones who are still considered missing. Police said no further details will be released about the victims they had identified out of respect for their relatives. However, Arthur Brodard's mother took to Facebook on

Saturday night to announce that he "has left to party in paradise". "We can start our mourning, knowing that he is in peace and in the light," she said as she appeared visibly upset in a video message. While Arthur was still presumed missing and

information on his whereabouts was scarce, Ms Brodard-Sitre told local newspaper Le Temps that she had been "living a nightmare". Some of his friends had been found with burns covering nearly half their bodies, she told the newspaper. "There are no words - they went through hell." Sparklers on bottles being carried too close to the ceiling are the likely cause of the fire during New Year's celebrations at the bar, a preliminary investigation has found. The devastating fire killed at least 40 people and injured 119 others. Many of the dead and missing are teenagers.

## 'DEEPLY SHOCKED': WORLD LEADERS REACT TO US ATTACK ON VENEZUELA



Leaders around the world have responded with a mix of condemnation and support to the US capture of Venezuela's President Nicolas Maduro. Following a large-scale strike on Venezuela on Saturday, Maduro and his wife were captured by US forces and removed from the country. The pair have been indicted on drug charges in New York. In an initial response, UK Prime Minister Keir Starmer said his government would "shed no tears" for the end of Maduro's regime. Neighbouring Latin American countries condemned the actions, as did Venezuela's long-term allies, Russia and China. China said it was "deeply shocked

and strongly condemns" the use of force against a sovereign country and its president. Russia accused the US of committing "an act of armed aggression". Iran, which is locked in its own dispute with Trump over his promise of intervention in its country, called the strikes a "flagrant violation of the country's national sovereignty". Trump said the US will "run" Venezuela "until we can do a safe, proper and judicious transition". Many Latin American leaders condemned the US actions. Brazil's President Luiz Inacio Lula Da Silva wrote on X that the actions "cross an unacceptable line", adding that "attacking countries in flagrant violation of

international law is the first step toward a world of violence, chaos, and instability". Colombian President Gustavo Petro called the strikes an "assault on the sovereignty" of Latin America, while Chile's President Gabriel Boric expressed "concern and concern" and "rejects, as it always has, military intervention". Trump has indicated that Cuba could become part of a broader US policy in the region, calling it a failing nation. US Secretary of State Marco Rubio said Cuba was a disaster run by incompetent leaders who supported Maduro's administration and that the government in Havana should be concerned.

The Venezuelan Interior Minister Diosdado Cabello urged citizens to remain calm and to trust the country's leadership and military, saying "the world needs to speak out about this attack" according to news agency Reuters. But Argentinian President Javier Milei - who Trump has described as his

"favourite president" - wrote "freedom moves forward" and "long live freedom" on social media.

Meanwhile, UK Prime Minister Sir Keir Starmer refused to be drawn into whether or not the military action may have broken international law. He did not condemn the US strikes in an interview with the BBC's Sunday with Laura Kuenssberg programme on Saturday morning. He said he was waiting to establish all the facts but would not "shy away from this", adding he was a "lifelong advocate of international law". The UK was not involved in the strikes and Sir Keir said he had not spoken to Trump about the operation.



## ICC Open To Moving Bangladesh's T20 World Cup Matches? Report Makes Big Claim

The International Cricket Council (ICC) might consider moving Bangladesh's T20 World Cup 2026 matches out of India following the request from the Bangladesh Cricket Board (BCB), according to a report by Cricbuzz. Bangladesh were set to play all of their league games in India - three in Kolkata and one in Mumbai. However, following an emergency meeting in Dhaka, the BCB said that the Bangladesh cricket team will not be travelling to India for the tournament. The report claimed that ICC has not taken an official call on the request as of now but the global governing body might not be averse to shifting Bangladesh's matches to Sri Lanka, co-hosts of the T20 World Cup. Earlier, the Bangladesh Cricket Board (BCB) said in their official release that they have requested the International Cricket Council (ICC) to shift their T20 World Cup 2026 matches from India to Sri Lanka. 

Albanese's message came ahead of Day 1 of the fifth Ashes Test between Australia and England at the Sydney Cricket Ground on Saturday. The 39-year-old left-handed batter confirmed that the Sydney Test will be his final appearance for Australia at the international level. Born in Islamabad, Khawaja will draw the curtain on his international journey after representing Australia in 87 Test matches. Prime Minister Anthony Albanese took to the social media and acknowledged Khawaja's contribution to Australian cricket and his impact beyond the field. "Thank you Usman for everything you've done for Australia on the field and everything you've meant to Australians off the field. You can be proud of your record, your legacy and the example you have set for



everyone who will follow in your footsteps," wrote Albanese. Khawaja announced his decision to retire while addressing the media at the Sydney Cricket Ground ahead of the fifth Ashes Test, bringing an end to a long and distinguished international career. Over the course of

his Test career, he scored 6,206 runs at an impressive average of 43.39. His record includes 16 centuries and 28 half-centuries across 157 innings. At lunch on Day 1, England reached 114/3 in 24 overs, thanks to an unbeaten 57-run partnership for the fourth wicket between Joe Root and Harry Brook.


## Mumbai's Stasya Pandya Wins Silver Medal At Junior National Equestrian Championship 2025

## Miracle As Australian Test Legend Damien Martyn Wakes Up From Induced Coma



Former Australian cricketer and Test legend Damien Martyn has woken from an induced coma after being hospitalised for over a week due to meningitis, according to the Sydney Morning Herald on Sunday. Martyn, 54, was admitted to Gold Coast University Hospital on December 27 after falling seriously ill and was placed in an induced coma. The development was confirmed by former Australian cricketer Adam Gilchrist, who stated that the 54-year-old is now "able to talk and respond to the treatment". Martyn represented Australia in 67 Tests, 208 One Day Internationals (ODIs), and four Twenty20 Internationals between 1992 and 2006. He remains widely regarded as one of the greatest ODI finishers in cricket history. Australian cricket great Adam Gilchrist revealed to Code Sports that Martyn "is now able to talk and respond to treatment." "He has responded extraordinarily well since coming out of the coma to the point where his family feels it's like some sort of miracle," Gilchrist said. "It has been so positive that they're hopeful he will be able to move

out of the ICU into another part of the hospital which is representative of what a great recovery it's been and how quickly it has flipped around." Gilchrist managed to speak to Martyn's partner Amanda throughout the process. "Amanda just really wants to say to everyone she is convinced that the love, goodwill and sense of care that they felt from everybody, via messages and via the coverage in the press really helped him," he said. "They just feel blessed so many people have wanted to support him in his time in need. He will remain in hospital and continue to receive treatment but the turnaround has been miraculous."

Renowned for his elegant stroke play, Martyn finished his Test career with 4,406 runs in 67 matches at an average of 46.37, including 13 centuries. In ODIs, he scored 5,346 runs in 208 games at an average of 40.80, registering five centuries and 37 half-centuries. One of Martyn's most memorable achievements came during the 2004 Border-Gavaskar Trophy in India, where he was named Player of the Series.

## BCCI Sent Big 'Ruturaj Gaikwad' Message Over New Zealand ODIs Squad, Asked To Drop This Star



Former Indian cricket team opener Sadagoppan Ramesh believes that Ruturaj Gaikwad should have been a part of the squad for the upcoming ODI series against New Zealand. Ramesh said that Ruturaj should have been included in place of all-rounder Nitish Kumar Reddy and questioned the decision to include a fifth seam-bowling option. Gaikwad recently scored a century in the ODI series against South Africa while batting at No. 4 but he was one of the big exclusions for the New Zealand series. What they may have thought is if Shreyas Iyer doesn't clear the fitness test, Ruturaj Gaikwad can slot into the playing eleven. Even if Iyer is fit and plays all three matches, I feel Gaikwad was a must in the squad," he added. 
