3 injured as 5.1-magnitude quake hits Assam

Guwahati (TSIT) At least three people were injured in an earthquake of 5.1 magnitude, which jolted central Assam in the early hours of Monday, officials said. A National Center for Seismology (NCS) report said the quake was recorded at 4:17 am in Morigaon district on the southern bank of the Brahmaputra, at a depth of 50 km. The exact location of the epicentre of the earthquake is at a latitude 26.37 N and longitude of 92.29 E in central Assam, it added. People in the neighbouring Kamrup Metropolitan, Nagaon, East Karbi Anglong, West Karbi Anglong, Hajo, Dima Hasao, Golaghat, Jorhat, Sivasagar, Charaideo, Cachar, Karimganj, Hailakandi, Dhubri, South Salmara-Mankachar and Goalpara districts also felt the jolt. Darrang, Tamulpur, Sonitpur, Kamrup, Biswanath, Udalguri, Nalbari, Bajali, Barpeta, Baksa, Chirang, Kokrajhar, Bongaigaon and Lakhimpur on the northern bank of the Brahmaputra too felt the tremor.

## No to Polavaram–Nallamala link: Uttam

Hyderabad (TSIT) : Telangana Irrigation Minister N. Uttam Kumar Reddy on Monday categorically stated that the Telangana government will not ever agree to the construction of the Polavaram-Nallamala Sagar link project by the Andhra Pradesh government, and will definitely stop it. In an informal chat with media persons, he said that the Andhra Pradesh government's proposals are a clear violation of the Godavari Water Disputes Tribunal 1980 award and interstate water regulations. He said the letter shown by former minister and Bharat Rashtra Samithi (BRS) leader Harish Rao was only an internal communication sent by the Central Water Commission (CWC) for information purposes, and it does not in any way mean that it was approved by the CWC. The minister dismissed the allegations made by BRS party leaders that ruling

Congress party was trying to create confusion among the public regarding Telangana state's water rights. He recalled that the Telangana state government had written letters to the Godavari River Management Board (GRMB), Polavaram Project Authority, Central Water Commission, Union Ministry of

Environment, Forest and Climate Change, and the Union Ministry of Jal Shakti, opposed the Polavaram-Nallamala project. He claimed that that all these institutions agreed with the Telangana government's stand. He said that the letter written by the Central Water Commission to the state government on December 4 was a proof of this. He stated that not only Telangana but also Maharashtra and Karnataka states are opposing this project. The irrigation minister revealed that the state government is also pursuing legal action in the Supreme Court. The government has appointed senior Supreme Court lawyer Abhishek Singhvi to protect the interests of the Telangana and present strong arguments. However, he revealed that the arguments scheduled for today (January 5) have been postponed to next Monday, and Telangana has been advised to convert the writ petition into a suit petition and file it accordingly.

## Avoid non-essential travel to Iran until further notice: MEA

Tehran/New Delhi (TSIT): India on Monday advised its nationals to avoid non-essential travel to Iran until further notice, owing to the recent developments in the country. "Indian citizens and PIOs currently in Iran should exercise due caution, avoid areas of protests or demonstrations, and closely monitor news as well as the website and social media handles of the Embassy of India in Tehran," read an advisory issued by the Ministry of External Affairs (MEA). "Indian nationals living in Iran on resident-visas are advised to register with the Indian Embassy, if not already done so," it added. Iran is witnessing major protests in a number of cities over the sharp depreciation of the national currency rial. Clashes between the security personnel and protesters have resulted in several deaths in Iranian provinces. Earlier on Monday, India time, US President Donald Trump warned Iran against



using violence to suppress protests, saying the United States is closely monitoring the situation and would respond forcefully if Iranian authorities begin killing civilians. Aboard Air Force One on his way back to the White House from Mar-a-Lago, Trump was asked about reports of protesters being killed in Iran and his earlier comments that the US was "locked and loaded." "We'll take a look," Trump said. "We're watching it very closely." Trump drew a clear line around the use of lethal force by Iranian authorities. "If they start killing people as they have in the past, I think they're going to get hit very hard by the United States," he said.

## Mamata moves court over SIR

KOLKATA (TSIT): West Bengal Chief Minister Mamata Banerjee on Monday said she would move court against the EC's SIR of electoral rolls, alleging that fear, harassment and administrative arbitrariness linked to the exercise had led to deaths and hospitalisa-



tions, as she sharpened her confrontation with the poll body ahead of the state assembly polls. Addressing a massive public gathering at Sagar Island in South 24 Parganas district, Banerjee alleged that technology was being "weaponised" to disenfranchise voters ahead of the 2026 Assembly polls, claiming that artificial intelligence and informal digital platforms were being used to arbitrarily delete names from electoral rolls, undermining democratic safeguards.

## Couple from Andhra killed in road accident in US

Palakollu (TSIT) A couple from Andhra Pradesh settled in the United States died in a road accident in Washington, a police official said on Monday. K. Krishna Kishore (49), a native of Palakollu, moved to the US in 1999 and married Asha (45), a native of Kakinada, who had already been settled there. "The cou-



ple, Kishore and Asha, who were settled in the United States, lost their lives in a road accident in Washington on Sunday, leaving their families in West Godavari district devastated," the official said. Kishore's father, Purushottam, who has a vision impairment, and his mother continue to reside in West Godavari district. According to police, the couple had two children—a son and a daughter—while Kishore's sister is also settled in the United States. The couple had recently visited their native village and returned to the US.

## Gas leak, fire at ONGC well triggers panic in Andhra village

Amaravati (TSIT): Huge flames following a gas leak from a well of Oil and Natural Gas Corporation (ONGC) in Andhra Pradesh's Ambedkar Konaseema district on Monday sent people in a state of panic, forcing authorities to evacuate residents of nearby villages. Panic gripped Irusumanda and surrounding villages in Malkikipuram Mandal following a massive gas leak from a well of the ONGC. The crude-



mixed gas suddenly erupted while repair works were

underway using a workover rig after the well had temporarily halted production. A powerful blowout released a massive volume of gas mixed with crude oil, which shot high into the air. Local officials said the leaked gas soon caught fire, with flames erupting at the site. Thick clouds of gas and smoke spread across Irusumanda and the surrounding areas like dense fog, officials said.

## US to receive \$600 bn in tariffs: Trump

Washington (TSIT): US President Donald Trump on Monday said the US has taken in, and will soon receive, more than \$600 billion through tariffs, arguing that the policy has strengthened the country financially and bolstered national security. The President also accused the country's media of downplaying the issue ahead of a key Supreme Court decision.

## CM Stalin to launch distribution of 10 lakh laptops to TN college students

Chennai (TSIT) : Chief Minister M.K. Stalin will inaugurate the first phase of the Tamil Nadu government's ambitious laptop distribution programme, titled 'The World Is in Your Hands', on Monday. ## DELHI RIOTS CASE:

## SC refuses bail to Umar Khalid & Sharjeel Imam, gives it to five others

NEW DELHI (TSIT): The Supreme Court on Monday refused bail to activists Umar Khalid and Sharjeel Imam in the 2020 Delhi riots conspiracy case but granted it to five others, citing "hierarchy of participation" and saying all accused in the case do not stand on the same footing.

There was a prima facie case against Khalid and Imam under the Unlawful Activities (Prevention) Act, a bench of Justices Aravind Kumar and N V Anjaria said. While the two will remain in jail, activists Gulfisha Fatima, Meeran Haider, Shifa Ur Rehman, Mohd. Saleem Khan and Shadab Ahmad have been



given bail. According to the court, delay in trial does not operate as a "trump card" which automatically displaces statutory safeguards. "All the appellants do not stand on equal footing as regards culpability. The hier-

archy of participation emerging from the prosecutions case requires the court to examine each application individually," the bench said, adding that the roles attributed to them are different. "This court is satisfied that the prosecution mate-

Mauritius President offers prayers at ancient Panakala Narasimha Swamy Temple in Andhra

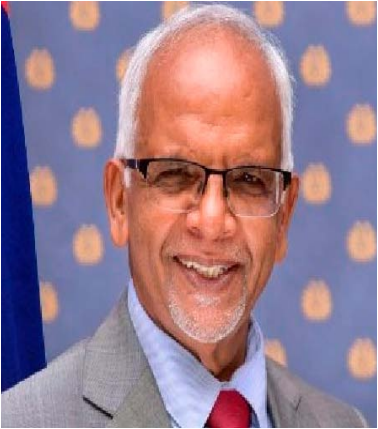

Earlier, during his address at the World Telugu Conference, Dharam Gokhool stated that the language represents more than a means of communication but a living civilisation with a spiritual



legacy.

"Telugu is more than just a language; it embodies a living civilisation and carries a profound spiritual legacy," he said.

Gokhool described the World Telugu Conference as a landmark event uniting the Telugu diaspora from around the world.

Highlighting the significance of Telugu, he said that the language gained recognition from being a regional prominence to a global

presence. He pointed out that Telugu is now spoken in over 50 foreign countries.

He said the Telugu community in Mauritius contributes significantly to nation-building, adding that it uniquely teaches Telugu at primary, secondary, and tertiary levels in its formal education system. Gokhool threw light on 'Telugu culture's integral role in Mauritius' multicultural fabric and enduring people-to-people ties between India and Mauritius. He asserted that the partnership between the two countries is anchored in shared history, values, and civilisational continuity. their toil. Later, he sat down with them for a modest meal on the field itself, interacting closely with the women workers and farm families to understand their daily struggles and livelihood conditions. During the

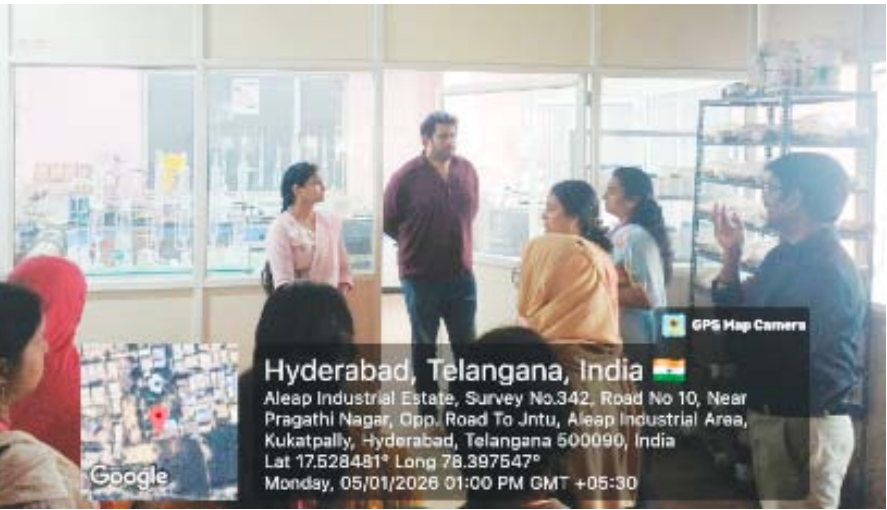

## ED attaches Rs 2.85 crore assets of former NHA official for corruption and money laundering

New Delhi, Jan 5: The Enforcement Directorate (ED) has provisionally attached assets worth Rs 2.85 crore, including flats, land, jewellery, and bank balances, belonging to former NHA deputy general manager Prabhanshu Shekhar over allegations of corruption and money laundering during his tenure in Bihar from 2016 to 2022.

According to officials, Shekhar acquired these assets in his own name and in the names of family members by indulging in corrupt practices, including clearing inflated bills, manipulating measurement books, and overlooking the use of sub-standard construction materials by Ashoka Buildcon Limited. These actions generated significant proceeds of crime, which were deposited into bank accounts of his family and used for daily expenses. Cash proceeds were further invested in immovable properties, insurance policies, and gold and silver jewellery.

The ED action follows



investigations under the Prevention of Money Laundering Act (PMLA), 2002, based on FIRs and charge-sheets filed by the CBI and Bihar's Anti-Corruption Bureau, citing offences under the Prevention of Corruption Act, 1988, and the Indian Penal Code. The CBI charge-sheet revealed that Shekhar amassed disproportionate assets totaling Rs 4.07 crore during his posting.

Officials stated that the ED's attachment includes flats and land in Bihar and Delhi, bank balances, investments, and valuables, aiming to prevent further misuse of illegally acquired assets.

## 13 children hospitalised after consuming soapberries at Jorhat tea estate; 3 in critical condition

Jorhat, Jan 4: At least 13 children fell ill after consuming washnuts, also known as soapberries, at Bor Soycoote Tea Estate in Titabar area of Assam's Jorhat district, officials said on Sunday.

According to a senior official from the health department, the incident occurred on Saturday evening when the minors accidentally consumed the soapberries while playing in the tea garden premises. Their condition report-



edly worsened later in the night, prompting parents to rush them to the estate's garden hospital.

As their health condition deteriorated further, all the affected children were shifted to Jorhat Medical College and Hospital (JMCH) on Sunday morning for advanced treatment.

Hospital authorities confirmed that all 13 children are currently undergoing treatment and are under close medical observation. JMCH superintendent Dr Manab Gohain said that three children have been admitted to the Intensive Care Unit (ICU) in critical condition, while the remaining 10 are out of danger. Doctors said efforts are on to stabilise the condition of the critically ill children. Further details are awaited.

## Govt-backed Bharat Taxi adds 45,000 users daily, crosses 4 lakh users

New Delhi, Jan 5 : A new government-backed cab-hailing app, Bharat Taxi, is gaining rapid traction across India just days after its launch, signalling a strong early response from users, giving fierce competition to ola and Uber.

Supported by the Ministry of Cooperation, the app is seeing a surge in registrations, with around 40,000 to 45,000 new users signing up every day over the past two days.

According to a post by the Ministry of Cooperation on

social media platform X, Bharat Taxi has already crossed four lakh registered customers. The platform is currently ranked ninth on the Google Play Store and thirteenth on Apple's App Store, while its driver-focused app stands at number 20 on the Play Store.

The ministry said this phase marks a build-up towards a larger nationwide rollout under the "Atmanirbhar Bharat" and "Sahkar Se Samridhhi" vision led by Union Home



and Cooperation Minister Amit Shah. Bharat Taxi was formally launched as a cooperative-based alternative to existing cab aggregators.

It positions itself as a transparent and driver-friendly platform, with an emphasis

on police-verified drivers and safer travel. The app is now available on both Android and iOS, and early use suggests it is beginning to make space for itself in India's crowded ride-hailing market.

From a user's point of view, the app offers a clean and simple interface. Booking a city ride is easy, and the app also includes additional services such as metro ticket bookings and cab rentals for up to 12 hours.

Safety features are prominently highlighted, including

options to call the police, alert emergency contacts, reach a safety team, and activate a siren from within the app. While many of these features are similar to those offered by established players, their real-world performance will become clear only as usage grows. Early experience, however, also points to some limitations. Fares do not always appear cheaper than existing platforms, and there are occasional inconsistencies, such as identical pricing for AC and non-AC

cabs, suggesting the app is still being fine-tuned.

The sign-up process is quick and simple, requiring only basic details like a mobile number, name, and email address, but the overall experience still feels like a work in progress. A key promise of Bharat Taxi is its driver-first approach. The platform currently claims it will not charge any commission from drivers, allowing them to keep the full fare paid by passengers.

## UPSC aspirant held for posing as IAS officer for seven years

Palamu, Jan 5: In a startling case of impersonation, Jharkhand police have arrested a man who posed as a senior IAS officer for nearly seven years to fulfil his father's wish and his own dream of joining the civil services. According to police, the accused, identified as Rajesh Kumar (35), walked into the Hussainabad police station in Palamu district on January 2 and introduced himself as a 2014-batch IAS officer of the Odisha cadre, claiming to be posted as a chief accounts officer in Bhubaneswar. He told the officer-in-charge that he was on leave and sought police assistance in a land dispute involving a relative in the Hussainabad area.

## Chouhan hits out at Congress over VB-G-RAM-G scheme protests

Bhopal, Jan 5: Rural Development Minister Shivraj Singh Chouhan on Sunday accused the Congress of spreading "misinformation" about the newly updated Viksit Bharat-Guarantee for Rozgar and Aajeevika Mission-Gramin (VB-G-RAM-G) scheme, saying the programme has been enhanced to benefit the poor. He alleged that corruption had been widespread under MGNREGA and claimed that the Opposition's resistance to the new scheme was politically motivated.

Speaking to the media, Chouhan criticised the Congress after it announced a campaign, 'MGNREGA Bachao Sangram,' against VB-G-RAM-G starting January 10. He questioned the absence of Leader of the



Opposition Rahul Gandhi from the Lok Sabha during discussions on the issue.

Terming the planned campaign "an attempt to protect corruption," Chouhan alleged large-scale irregularities under MGNREGA. "Under social audits done by gram sabhas, there were more than 10,51,000 com-

plaints. Same work was repeated, work was done by machine, and money was siphoned in the name of cleaning canals and roads. Thirty percent workers were above 60 years," he said.

Chouhan added that the Modi government had allocated significantly higher funds to rural employment,

with over ₹8,48,000 crore provided compared to just over ₹2 lakh crore during the UPA regime. He said the new VB-G-RAM-G scheme better safeguards workers' interests and announced that ₹1,51,282 crore would be allocated for the programme in the next financial year, with over ₹95,600 crore coming from the Centre. He assured there would be no shortage of funds to guarantee 125 days of work.

The Opposition has been protesting against the VB-G-RAM-G Bill, passed by voice vote in the Rajya Sabha on December 21, 2025, hours after clearing the Lok Sabha. President Droupadi Murmu gave her assent on the same day, turning the Bill into an Act that replaces MGNREGA.

## Why NHRC's Global Downgrade Demands Urgent Reform

The year 2025 was a turbulent one for the National Human Rights Commission (NHRC), which proclaims to stand tall in its human rights interventions and was once considered a shelter in the storm for Indians. The recent decision by the Global Alliance of National Human Rights Institutions (GANHRI) to downgrade the status of the apex human rights body of the world’s largest democracy, however, is a sobering story. Since its inception in 1993, the NHRC has had chairpersons of four thematic commissions as its deemed members. In 2019, this was expanded to include three more thematic national commissions. To make its services more accessible to citizens, every state has a human rights commission and, in addition, thematic commissions meant for women, children, Scheduled Castes and Scheduled Tribes, among others. In all, there are 169 such institutions, making India the country with the largest number of national and state human rights institutions.

### Accreditation by GANHRI

National human rights institutions around the world are accredited by GANHRI, which ensures their compliance with the Paris Principles. These principles set out the minimum parameters for national human rights institutions, emphasising their broad mandate and functions and their pluralism, independence and effectiveness.

As part of this alliance since 1997, the NHRC was subjected to GANHRI evaluation in 2016, 2023 and 2024, in which its ‘A’ status was deferred thrice by a sub-committee on accreditation, or the SCA. The GANHRI sub-committee recommended actions for the NHRC to consider. These included emphasising plurality of gender, ethnicity and representation of religious minorities within the NHRC. It also recommended a transparent appointment process and independent and effective functioning. The recommendations highlighted the need to effectively intervene in several human rights violations and the lack of civil society engagement by the NHRC. They also raised concerns that only police officers were investigating abuses by their colleagues, which was seen to greatly jeopardise independence and accountability. These recommendations were the result of reports by civil society organisations at the regional, national and international level that communicated the NHRC’s non-compliance with the Paris Principles.

### NHRC downgraded after inaction

While laudable for its large network and broad mandate, the NHRC’s conduct in some of the gravest instances of abuse has been deeply concerning. In 2015, the commission intervened – on the same day as the incident, April 15, 2015 – in the fake encounter killing of 20 Tamil labourers by the Red Sanders Special Task Force in the Seshachalam Forest Range of the erstwhile undivided state of Andhra Pradesh. The NHRC intervened swiftly, conducted rapid investigations and passed effective interim orders, but thereafter failed to ensure their implementation. Even after ten years, it has been unable to vacate the Andhra Pradesh High Court’s stay of its order dated May 29, 2015. Another chilling incident was that of police excesses in 2018 against demonstrators protesting Vedanta’s copper smelting unit in Tuticorin, Tamil Nadu. Infamously called the Sterlite shooting, it led to 16 deaths and left hundreds critically injured. The NHRC did not hold the police accountable. Instead, it closed the case, citing the Tamil Nadu government’s compensation and the appointment of a commission of inquiry. It thus left the victims in the dark, despite eight UN Special Procedures voicing their condemnation of the killings since May 30, 2018.

## ACT OF TERROR WAR?

## Donald Trump Has A New Project: 'Make Venezuela Great Again'

The Trump administration has made a remarkable bet early in the new year by capturing Venezuelan President Nicolas Maduro and his wife in a military raid in Caracas last week. For a President who had come to office pledging to end “forever wars”, this is a serious turnaround as he is now suggesting that the US is “going to run the country [Venezuela] until such time as we can do a safe, proper and judicious transition”. Trump’s “America First” agenda now includes rebuilding a South American nation whose economy is in shambles and whose political institutions have been eroded by the vagaries of dictatorship over decades.

After being charged with drug and weapons offences, Maduro and his wife are reportedly being held at Brooklyn’s Metropolitan Detention Center. Venezuela’s Vice-President Delcy Rodriguez vowed the government is ready “to defend” the country, and condemned “armed aggression”. US oil companies would also fix Venezuela’s “broken infrastructure” and “start making money for the country.” Trump also seems to be not ruling out deployment of American soldiers to Venezuela at this point, saying, “We’re not afraid of boots on the ground...we had boots on the ground last night.” This is a significant policy shift from “Make America Great Again” to “make Venezuela great again”. Operation Absolute Resolve Tensions between the United States under President Donald Trump and Venezuela intensified significantly between 2017 and 2021, when Washington took a hardline stance against Maduro, whom it accused of authoritarianism, human rights abuses, and corruption. After the disputed 2018 presidential election, the United States refused to recognise Maduro’s legitimacy, and in 2019, the Trump administration formally recognised opposition leader Juan Guaidó as Venezuela’s interim president,



dramatically escalating diplomatic tensions. The US imposed sweeping economic sanctions targeting Venezuela’s oil industry, state assets, and key government officials, aiming to pressure Maduro to step down. While Washington argued that sanctions were intended to restore democracy, its actions merely worsened Venezuela’s already severe economic crisis, marked by hyperinflation, shortages of food and medicine, and mass migration. Washington’s recent military intervention, ‘Operation Absolute Resolve’, culminating in the dramatic capture of Maduro, signals a definitive shift in American strategic posture in the Western Hemisphere. By asserting that the US will “run” Venezuela until a transition occurs, Trump has effectively operationalised his recently released National Security Strategy, underlining his penchant for transactionalism and strategic primacy in America’s periphery.

### It's The Oil, Silly

This shift is not merely about regime change; it is a calculated geopolitical move to secure Venezuela’s vast energy reserves

and purge extra-regional influences, namely China, Russia, and Iran, from America’s “near abroad”. Trump’s insistence that American companies will lead the reconstruction of Venezuela’s oil infrastructure underscores a foreign policy where economic interests and national security are inextricably linked. However, the “day after” problem remains acute. While the Chavista leadership is decapitated, the underlying institutional decay and humanitarian crisis persist, risking a protracted period of instability that could haunt Washington’s regional ambitions. For the global order, Trump’s decisive, yet disruptive, unilateralism in Caracas serves as a stark reminder: in the current age of great power competition, the US is increasingly willing to trade global legitimacy for hemispheric dominance. Trump entered office nearly a year ago, projecting himself as a dealmaker-in-chief who is committed to ending wars rather than starting new ones. Yet the record of the past year tells a more familiar story of American power being exercised through force. Despite the rhetoric of restraint, the use of military instruments

has remained central to his foreign policy toolkit.

### Same Old, Same Old

In just the past week, Trump authorised air strikes in Syria and Nigeria, underscoring how quickly crisis management has translated into kinetic action. This pattern has been evident throughout 2025. US forces struck Iranian nuclear facilities, intercepted suspected drug-trafficking vessels in the Caribbean, and carried out operations against rebel groups in Yemen. American military power has also been deployed against armed factions in Somalia and Islamic militants in Iraq. Yet this is nothing new but a continuation of Washington’s longstanding reliance on coercive tools to manage instability and signal resolve. Trump’s presidency, much like of those before him, reveals the structural constraints that limit any US leader’s ability to disengage from global conflicts. The promise of peace has collided with the realities of power, interests, and credibility, leaving military force as an option that Trump, like his predecessors, has shown little hesitation in using. Other powers will be watching and learning.

## How Venezuela's China-Made Weapons Failed To Keep The US Away

The United States' military intervention in Venezuela on the evening of January 3, 2026, has kicked the new year off with great uncertainty for the Western Hemisphere. In hindsight, it seems that while the air strikes and the arrest of Venezuelan President Nicolas Maduro and his wife may have been unprecedented, military tensions between the US and Venezuela were likely to manifest one way or another. The November 2025 National Security Strategy (NSS) released by US President Donald Trump clarified that the 'Monroe Doctrine' was back in action and that the US was putting in place plans to carve an undisputed 'sphere of influence' in the Western Hemisphere. In particular, the NSS highlighted that the US National Security Council will build an interagency task force supported by the Intelligence Community's analytical arm, to "identify strategic points and resources in the Western Hemisphere with a view to their protection and joint development with regional partners". Further, the goal is to keep "Non-Hemispheric competitors" out of the region, so that they do not "harm [the US] strategically in the future". These odes, combined with the buildup in tensions between the US and Venezuela over illicit narcotic trade and sustained American sanctions on Venezuelan oil traders, now constitute the



metaphorical writing on the wall. China As A Competitor It is clear that China is one such 'Non-Hemispheric Competitor' in the US's conception. Maduro's regime was Beijing-friendly, and the economic and military ties between Venezuela and China run deep. Naturally, with Maduro set to face "the full wrath of American justice on American soil", in US Attorney General Pam Bondi's words, and Trump wanting Washington to "run Venezuela", China's interests and stakes in the country and the region are in jeopardy. But what are these interests and stakes? What is China likely to be concerned about now? For starters, if one looks at the statement released by the Chinese Foreign Affairs Ministry a few hours after the US's strikes, there is harsh condemnation of America's actions on the account that it is a violation of Venezuela's sover-

eignty, international law, and principles of the UN Charter. Beijing also opposed the actions on the grounds that they fundamentally "threaten peace and security" in Latin America. As much as China is an aggressor in its own region, in narrative, it has often used international law and UN-centred norms as ideals that each great power must uphold. In that regard, in Beijing's view, the US's actions are a display of raw power, even if the indictments issued by New York courts act as some casus belli for Washington's intervention. But beyond the rhetoric, China would ideally be seriously concerned about two main issues - the failure of some of its military equipment used by the Venezuelan Armed Forces, and the future of its oil and economic ties with both Caracas in specific and Latin America (LatAm) in general. The

Silence Within China Venezuela's National Guard deployed over a hundred Chinese-origin Armoured Utility Vehicles of the VN4 class, its Marines deployed approximately 10 each of the Chinese-origin, VN-1 and VN-18 class Infantry Fighting Vehicles, and its Air Force operated over 20 K-8 'Karakorum' light attack fighter aircraft developed by China's Hongdu Aviation Industry Corporation. Most importantly, the Caracas fielded the China Electronics Technology Group Corporation (CETC)-made JY-27 counter-stealth radar, which the Chinese claimed in May 2025 could capture and locate "extremely stealthy targets". As is evident from the US's successful campaign, which used both F-22s and F-35s in operations, Venezuela's air defence systems failed to respond to, if not detect, threats.

## Why the Murder of Anjel Chakma Exposes India's Everyday Racism Against the Northeast

The year 2025 ended with nationwide protests demanding justice for Anjel Chakma, a 24-year-old youth who was pursuing an MBA in Dehradun. According to news reports, on December 9, 2025, Anjel was out on a routine errand with his brother, Michael Chakma, when they encountered some local men hurling racial slurs at them because of how they looked and the language they spoke. The brothers protested and the altercation quickly escalated. Anjel was repeatedly stabbed and sustained serious injuries, to which he succumbed after fighting for his life in hospital for 16 days. His last words were, “I’m not Chinese. I’m an Indian.” Anjel Chakma was from Tripura, one of the seven northeastern states that have been constitutionally recognised as part of India for a considerable length of time. I am also from Tripura, and as many of my peers from the state would corroborate, we have all had to explain where Tripura is at some point during our stay in any so-called mainland state of the country we call our own. Fellow citizens have asked us whether it is somewhere in Assam. I have personally been asked by a civil services aspirant whether Tripura is in South India because its name resembles Trivandrum or Thiruvananthapuram. As Indian citizens from Tripura, these questions are not nearly as baffling to us as the confidence – and lack of embarrassment – with which they are asked. The shameless ignorance about the Northeast prevalent in mainland India is not merely a matter of individual negligence; it is a symptom of the systematic exoticization of the region and its



people, layered and deeply entrenched. The demography of the Northeast is as varied as that of the rest of India. Contrary to popular belief, we do not all look the same. Factors such as tribal migration, self-acculturation and assimilation from animism into religions like Buddhism, Hinduism and Christianity have shaped the region’s population. Political events, particularly those related to the Indian state and its foreign policies, have also had a significant impact, resulting in states like Tripura and Assam hosting substantial non-indigenous populations. In Tripura especially, Bengali settlement began as early as the mid-fifteenth century. Historian Anindita Ghoshal writes: “Historically, the Hindu rulers of Tripura’s Manikya dynasty had always encouraged the immigration and settlement of non-tribals, especially Bengalis, in Tripura. Rajmala, a court chronicle of the Tripura kings, authenticates the fact that Ratna Manikya (1464–1468) was the first to ‘settle 4,000 Bengalis in four

places’ in Tripura. Gradually, the tribal kings adopted Hinduism as the state religion and assimilated Bengali language and literature into their culture.” During the late colonial period, and again during the Bangladesh Liberation War in 1971, Tripura witnessed a massive influx of Bengalis from East Bengal, further complicating the question of Bengali presence in the state. The assimilated socio-religious culture practised by both indigenous and Bengali communities is another reason why the region’s demography cannot be neatly compartmentalised into exclusive categories. The shifting of political territories on paper maps has displaced cultures, languages and nationalities of indigenous people and Bengalis alike. As one can see, identity politics in Tripura is complex – making it easier for many mainland Indians to either ignore this reality altogether or to deny us the dignity of an Indian identity. In practice, development, modernisation and knowledge production about the Northeast have largely

remained matters of what I can only mock as “the brown man’s burden” – a sympathetic, representative framework rather than a genuine component of nation-building. As young adults, many of us, like Anjel Chakma, are compelled to leave our homes for the so-called mainland to pursue even the most basic of modern livelihoods. In a country that obsessively equates familial duty with physical proximity, we are forced to migrate far away to ensure our families have access to care and opportunity. If we stay back and demand equitable development from the government, we are labelled “extremists”. The systematic ignorance of our demography, cultures, languages and people is excused because we are treated as an exotic anomaly – one that does not fit the acceptable, marketable “image” of an Indian. And because we are “exotic”, we are also perceived as threatening. Among Indians who are blessed with resemblance to that image, we deserve the fate of a snake that appears in broad daylight: either “rescued” and caged.



## Country's First Indigenous Runway Cleaning Vehicle Handed Over to Noida International Airport



Bengaluru: Minister for Large and Medium Industries M.B. Patil on Monday handed over the country's first indigenously manufactured airport runway cleaning vehicles, developed by Bengaluru-based Anlon Technology

Solutions Limited, to Noida International Airport Limited (NIAL). The advanced vehicles have been manufactured under the Government of India's 'Make in India' initiative. Developed in collaboration with Switzerland-based

M/s Bucher Municipal and assembled at Anlon's facility in the Adinarayanahosahalli industrial area near Doddaballapur, the vehicles are designed to enhance runway safety. Minister Patil formally handed over the keys of two vehicles to NIAL representative Pradeep Rana.

The specialised vehicles are capable of removing nails and sharp metal fragments that pose a threat to aircraft tyres. They also vacuum dust and effectively clear algae from runways, reducing the risk of skidding during aircraft landings.

## Siddaramaiah's Record Deserves to Be Buried, Not Celebrated: H.D. Kumaraswamy

Bengaluru: Union Minister H.D. Kumaraswamy said that Chief Minister Siddaramaiah claims that he will break the record of Devaraj Urs. "What merit does he have for all this? Looking at the condition of the State, his record deserves to be buried.

Addressing a press conference at the JD(S) State office, JP Bhavan, the Union Minister said that Siddaramaiah, who boasts of having administered the State for a long time, is in fact a textbook example of bad governance. He expressed anguish, stating that Siddaramaiah's administrative record deserves to be consigned to dust.

"Karnataka, which once stood as a testimony

marking the occasion of Siddaramaiah achieving the distinction of becoming the longest-serving Chief Minister of Karnataka.

Addressing reporters in Mysuru, CM Siddaramaiah on Monday said that with the blessings of the people, he would, on Tuesday (Jan 6), equal the record of late Devaraj Urs in terms of the length of service as Chief Minister of the state. He noted that it was a moment of joy for him as Devaraj Urs also hailed from Mysuru district, to which he himself belongs.

Siddaramaiah said he had never expected to reach such a milestone when he entered politics. "I never imagined that I would become a minister



or the Chief Minister. I had only aspired to become an MLA after serving as a taluk board

member," he said.

The Chief Minister said he has contested 13 elections in total, including taluk board elections. "So far, I have won eight elections and lost two Parliamentary elections and two Assembly elections," he said.

Recalling the tenure of Devaraj Urs, he said there was no comparison between him and the late leader. "Devaraj Urs did not belong to a socially backward community. The Urs community is traditionally a ruling class. Though its population is small, he earned immense popularity and became Chief Minister. There can be no comparison between him and me," he said.

Siddaramaiah said circumstances and chal-

lenges differed from time to time. "When I first contested elections in 1983, people funded me and voted for me. Similarly, people supported and voted for Devaraj Urs during his tenure. Once, Devaraj Urs was elected unopposed in 1962. Times have changed now," he said.

Noting that political records are meant to be broken, he quipped: "Did Virat Kohli not break the records of Sachin Tendulkar?"

The Chief Minister said he did not believe that such milestones would remain unmatched. "Other leaders may emerge, they may rule for a longer period than me and present more budgets than me," he said.

## Kumaraswamy Alleges Double Post-Mortem in Ballari Killing, Demands CBI Probe

Bengaluru : Union Minister H.D. Kumaraswamy, revealed explosive information regarding the firing incident carried out by the gunman of Ballari MLA Nara Bharath Reddy's close associate, alleged that the post-mortem of Congress worker Rajasekhkar, who was killed in the firing, was illegally conducted twice. He demanded that the State Government hand over the case to the CBI for investigation.

Addressing a press conference at the party's State office, JP Bhavan, the Union Minister said that while the murder of party worker Rajasekhkar is one issue, the Congress government has gone to extreme lengths to cover up the killing of its own party worker. This, he said, is shameful. As part of this attempt, the unfortunate worker's body was subjected to post-mortem examination twice, he alleged.

"What were the findings of the first post-mortem report? What does the second post-mortem report say? The government must answer this. As per the information available to me, Rajasekhkar's body was subjected to post-mortem examination twice," he said. "Why was a second post-mortem conducted? Who exerted pressure for it? Who ordered another examination? Was it because the first post-mortem report did not suit your interests?" Kumaraswamy asked sharply. "Aren't you honest? Every day you boast of 'Satyameva Jayate' in advertisements. Now speak the truth. Shouldn't the truth be told to the people of the State? What is there in the second post-mortem report? Hon'ble Chief Minister, tell the truth to the people," Kumaraswamy demanded.

There is information that in the first post-mortem, small pellets were found in the body. By conducting a second post-mortem, a conspiracy was hatched to fix the narrative that Janardhan Reddy himself fired the gun. However, the second post-mortem backfired on this government and on those who attempted to throw light on the issue, the Union Minister said. The Chief Minister says the incident happened due to firing in the air. The Deputy Chief Minister says his party will



stand by MLA Bharath Reddy. The Chief Minister himself has stated that the firing occurred from the gun of Satish Reddy's gunman. Yet, the Home Minister is delaying action through statements instead of ordering the arrest. Under these circumstances, what kind of investigation can this government conduct? Can the truth really come out through their investigation? Kumaraswamy questioned.

Accusing the Chief Minister and Deputy Chief Minister of attempting to bury the Ballari shootout case, Kumaraswamy said that when Janardhan Reddy wrote to the Union Home Minister seeking security, the Deputy Chief Minister mocked it, saying he could seek security from the US or Iran, or deploy 100 BJP workers for protection. "This is the kind of language used by the Deputy Chief Minister," Kumaraswamy lashed out. "The SP has been suspended for dereliction of duty. If that is the case, haven't the Additional SP and the IG also committed dereliction of duty? When the stampede occurred near the Chinnaswamy stadium, several senior police officers were suspended. Then why is action being taken only against the SP in Ballari? Aren't the officers who have been posted there for years also at fault?" the Minister asked angrily. The Deputy Chief Minister has said that disturbances are occurring after Gali Janardhan Reddy came to Ballari, with Home Minister Parameshwara echoing the same line. Janardhan Reddy came to Ballari one-and-a-half years ago with Supreme Court permission.

## Vehicle registrations witness mixed trends in coastal Karnataka during 2025

Mangaluru, Jan 4: While vehicle registrations continued to rise nationally, coastal Karnataka witnessed uneven trends over the past year. India saw 2.62 crore vehicles registered in 2024, which rose by 7.69% to 2.82 crore in 2025. In Karnataka, registrations increased from 18.88 lac in 2024 to 19.09 lac in 2025, marking a 1.15% rise.

Within the Mangaluru and Udupi RTO jurisdictions, registrations showed an upward trend. Mangaluru recorded a 2.44% increase, while Udupi saw a 3.97% rise. In contrast, registrations fell in Bantwal and Puttur RTO areas.

In Mangaluru, light motor vehicles led registrations. A total of 48,485 vehicles were registered in 2025, of which 12,054 were light motor vehicles. Registrations peaked in October with 5,734 vehicles, while June recorded the lowest at 3,280 vehicles. Of these, 25,961 were petrol vehicles, 9,567 petrol-ethanol hybrids, and 4,537



electric vehicles.

Udupi RTO also showed improvement, with 36,433 vehicles registered in 2025, including 24,458 two-wheelers, 8,009 light motor vehicles, 19,265 petrol vehicles, 8,780 petrol-ethanol hybrids, and 2,841 electric vehicles.

Meanwhile, registrations declined in Puttur and Bantwal. Puttur RTO registered 12,283 vehicles in 2025, down 5.15% from 12,950 in 2024, including 7,410 two-wheelers, 3,207 light motor vehicles, 6,329 petrol vehicles, 791 electric vehicles, and six tractors. Bantwal RTO recorded 7,519 registra-

tions, down 6.43% from 8,036 the previous year, with 4,514 two-wheelers and 727 electric vehicles.

Statewide, two-wheelers remain the preferred choice, with 13.42 lac sold in 2025. In coastal districts, Mangaluru led with 30,335, Udupi 24,458, Puttur 7,410, and Bantwal 4,514 two-wheelers sold.

Despite the launch of various electric vehicle models, EV registrations showed limited growth. Nationally, of 2.82 crore vehicles registered in 2025, only 22.70 lac were electric. In Karnataka, of 19.09 lac registrations, just 2.03 lac were electric vehicles.

The department introduced the scheme for the secondary students (Classes 10 to 12) in government and government-aided schools, providing an incentive of Rs 1,500 for students in Classes 10 and 11 and Rs 2,000 for Class 12 students through the Tamil Nadu Power Finance and Infrastructure Development Corporation Ltd (TNPFIC) on completion of Class 12, to reduce dropouts.

A senior official noted that a total of 3.3 lakh students were beneficiaries of the scheme for 2024-2025. "However, the authorities concerned were notified that the bank details of nearly 96,800 students, who did not receive the financial assistance, were verified," he said, adding, "of the total students who are yet to get the aid, bank details of only 54,300 students were scrutinised, and the amount was disbursed to them".



The official stated that the department has instructed all the headmasters to ensure that the bank details of the remaining, a little over 42,000 students who are yet to receive the aid, should be verified immediately.

The department has also sought a detailed report on the same, the official said.

"The school managements have been instructed to upload the students' details, including their bank account numbers, on the Educational Management Information System (EMIS), a common online platform connecting government, schools, and students," he added.

Stating that every year the state government is spending more than Rs 200 crore to implement this scheme, the official attributed the delay in the disbursement of financial assistance to the poor verification of students' data by state-run schools.

Extend new pension to transport staff: AITUC

CHENNAI: AIADMK general secretary Edappadi K Palaniswami on Sunday said the DMK has been announcing new welfare schemes ahead of the 2026 polls out of fear of defeat. Addressing a public campaign in Salem as part of his statewide election outreach, 'Makkalai Kappom Tamilagathai Meetpom', the AIADMK leader said the DMK's announcements are not driven by public welfare. Terming the recent announcements to relax norms under the Kalaingar Magalir Urimai Thogai scheme to include 17 lakh more beneficiaries and a fresh pension scheme for government staff as an attempt to deceive people, the AIADMK leader claimed the moves sound hollow in the backdrop of the DMK's failure to deliver on its earlier commitments. The AIADMK alliance will win with a majority in the 2026 Assembly polls and form its own government, he said. "None can stop AIADMK from forming the government," he added. Alleging that DMK has stopped welfare schemes introduced by the AIADMK, the Leader of the Opposition said the ruling party is concerned only about the welfare of its family, and that corruption has become pervasive across all departments.

CHENNAI: The Regional Meteorological Centre has forecast dry weather over Tamil Nadu, Puducherry and Karaikal on January 5 and 6, with light to moderate rain likely at a few places along coastal Tamil Nadu on January 7. In its bulletin, the weather office said an atmospheric lower-level circulation is prevailing over the Maldives and adjoining Lakshadweep region, while an upper-level circulation lies over the central parts of the south Bay of Bengal near the Equator. Dry weather is expected to continue over interior Tamil Nadu, with light fog likely at isolated places during early morning hours. According to a Daily Thanthi report, minimum temperatures are expected to gradually fall by 2-3 degrees Celsius at a few places across Tamil Nadu, Puducherry and Karaikal between January 5



and 7, remaining below normal in some areas. Frost is likely at isolated places over the Nilgiris district and the Kodaikanal hill areas of Dindigul district during the night and early morning hours on January 5 and 6.

For Chennai and its suburbs, the sky will remain partly cloudy today and tomorrow, with light fog possible in the early morning. The maximum temperature is likely to hover around 29-30 degrees Celsius, while the minimum temperature may range between 21 and 22 degrees Celsius.

CHENNAI: Tamil Nadu State Transport Corporation Employees' Federation (AITUC) general secretary R Arumugam on Sunday urged the State government to extend the Tamil Nadu Assured Pension Scheme (TAPS), announced for government employees, to workers of State transport corporations as well.

In a statement, Arumugam said transport workers had a long history of struggle to secure pension benefits. He recalled that when transport undertakings functioned as a government department, workers who completed 10 years of service were covered under the Madras Liberalised Pension scheme. However, after the formation of transport corporations, the pension scheme was withdrawn and replaced with a contributory provident fund system. He said workers deputed from government departments to transport corporations were also denied pension, forcing AITUC to wage an 18-year-long struggle on the streets, in courts and in the Assembly, following which pension was granted to about 7,000 workers. Sustained agitations from 1998 led to the introduction of a pension scheme through wage settlements, eventually covering about 1.28 lakh transport workers, he added.

India's first government AI clinic to boost public health system

Can regular intake of fast foods lead to illnesses and death?



NEW DELHI: India's first government-run artificial intelligence (AI) clinic, launched recently at the Government Institute of Medical Sciences (GIMS) in Greater Noida, marks a major step in integrating advanced technology in the public health system of the country, according to a media report.

The initiative aims to boost early detection of diseases, diagnostics, and treatment, which can be crucial to improving outcomes and survival rates, Gulf News reported.

The clinic will reportedly perform genetic screening using AI, which can help in faster detection of diseases such as cancer, heart disease, kidney disease, and liver disease. AI tools at the centre will also assist in interpreting X-rays, ultrasounds, CT scans, MRI reports, and laboratory investigations, helping doctors improve accuracy and speed of diagnosis.

"The clinic will use artificial intelligence along with genetic screening to analyse blood tests, imaging scans, and other clinical data," Brigadier (Dr) Rakesh Kumar Gupta, Director of GIMS, was

AI tools are known to play a significant role in healthcare delivery, particularly in labs, radiology, and cancer screening. Another key advantage is that it improves access to quality healthcare, particularly in remote and underserved areas, where the availability of specialists is limited.

While AI tools are already used in select private hospitals and diagnostic labs, this is the first dedicated government AI clinic. The report stated that the AI model could be replicated across government hospitals in other states.

# Crude oil rises in futures trade amid Venezuela crisis

**New Delhi:** Crude Oil prices rose by Rs 42 to Rs 5,197 per barrel in the futures trade on Monday amid cautious sentiment over geopolitical developments. On the Multi Commodity Exchange (MCX), crude oil futures for January delivery rose by Rs 42, or 0.81 per cent, to Rs 5,197 per barrel in a business turnover of 18,270 lots. Similarly, the February contract increased by Rs 37, or 0.72 per cent, to Rs 5,202 per barrel in 3,011 lots. In the international markets, West Texas Intermediate (WTI) crude oil futures went up by 0.24 per cent to USD 57.46 per barrel, while Brent Crude was trading marginally higher at USD 60.78 per barrel in New York. “WTI crude oil futures hovered around USD 57.2 per barrel on Monday, moving between gains and losses as investors assessed the implications of recent US military action in Venezuela, including the capture of President Nicolas Maduro,” Rahul Kalantri, VP Commodities, Mehta Equities Ltd, said. The market sentiment remains cautious amid concerns over potential supply disruptions, given



Venezuela's status as the country with the world's largest proven oil reserves, he added. Market experts believe the immediate impact on global supply may be limited, as Venezuela's current output stands below one million barrels per day, representing less than one per cent of total global production. Meanwhile, rising concerns that the US may intensify pressure on other oil-producing nations, such as Iran, could lead to tighter supply conditions later in the year, Kalantri said. He added that some reports sug-

gest the White House has encouraged US companies to support the revival of Venezuela's oil industry, particularly for firms seeking compensation for assets expropriated nearly two decades ago. Shares in US energy companies have jumped as investors bet that the US capture of Venezuelan President Nicolas Maduro will open opportunities to tap the country's oil reserves. Shares in Chevron opened more than 4% higher, after surging more than 7% in pre-market trading, while other firms, including

ConocoPhillips and Exxon also gained. Precious metal prices and shares in defence stocks also rose as the intervention increased investors' concerns about geopolitical risks. Gold was about 1.9% higher at \$4,412 (£3,275) an ounce, while the price of silver was up by 3.6%, as money was moved into so-called "safe-haven" assets. Prices of precious metals such as gold and silver often rise in times of uncertainty as they are seen as safer assets to hold. The gold price saw its best annual performance last year since 1979 after rising by more than

60%, reaching an all-time high of \$4,549.71 on 26 December. Those gains were driven by several factors including expectations of more interest rate cuts, major purchases of bullion by central banks and investor concerns about global tensions and economic uncertainty. Oil prices fluctuated on Monday as investors weighed whether Washington's intervention in Venezuela would affect crude supplies. Brent crude rose more than 1% to nearly \$61.50 a barrel, still below highs seen in recent years, as analysts said ample global supplies would offset any disruption. Shares in Chevron, the only US company currently operating in Venezuela, rose 4%, while Spanish energy firm Repsol, among the other few Western energy firms with a presence in the country, gained 2%. Oil services firms also climbed, with Haliburton up more than 7%. US President Donald Trump has vowed to tap into Venezuela's vast oil reserves after seizing Maduro and said that the US will "run the country until such time as we can do a safe.

## India wants more passenger jets. Can it also build them?

India is one of the world's fastest-growing aviation markets. IndiGo and Air India, which together hold over 90% of the market, have ordered nearly 1,500 planes over the next decade, highlighting soaring passenger demand. This expansion hinges on Boeing and Airbus, which together supply 86% of the world's aircraft and faced "historically high" delivery backlogs in 2024 - delays expected to affect Indian orders too. This has revived an old question: should India try to build its own passenger planes? The prospect drew attention in October, when India and Russia signed an initial agreement in Moscow to manufacture the SJ-100 passenger plane in India, raising hopes for domestic aircraft production. But is the Russia deal a solution? Its joint manufacturing plan still faces many hurdles before coming to fruition. The SJ-100 is a twin-engine aircraft that can carry up to 103 passengers and is already in service with several Russian airlines, according to its manufacturer, United Aircraft Corporation (UAC). Delhi has described the aircraft as a "game changer" and plans to use it for short-haul routes. But experts have



questioned the project's cost and feasibility - much of which is still unclear. One of the biggest concerns is whether the Russian firm would be able to rapidly set up and scale production in India. The aircraft's manufacturer says it delivered around 200 SJ-100 aircraft between 2008 and 2020. But that trajectory shifted in 2022 when Russia launched its war against Ukraine. Western sanctions cut off key spare parts, forcing the company to replace about 40 systems and operate an "import-substituted" version in 2023. Europe's aviation safety regulator withdrew the aircraft's certification, effectively banning the SJ-100 and other Russian planes from its airspace. India has long aimed to build passenger aircraft domestically but has achieved only limited success. In 1959, the government set up the National Aerospace Laboratories

(NAL) to develop "small and medium-sized civil aircraft". The facility has developed the two-seater Hansa and five-seater trainer planes, but larger passenger aircraft remain out of reach. In the 1960s, India built passenger planes under foreign licenses. State-run Hindustan Aeronautics Limited (HAL) produced dozens of UK-designed Avro 748 jets, used by both commercial airlines and the military before being phased out. In the 1980s, India partnered with German firm Dornier to produce a 19-seat passenger jet, some of which still serve the military and limited civil routes. With the momentum going, India has also tried to ingeniously design its own small passenger planes. In 2000, India also signed an agreement with Russia for help in manufacturing the NAL's 15-seater Saras aircraft.

## Stock markets decline in early trade dragged by IT firms

Mumbai: Equity benchmark indices Sensex and Nifty declined in early trade on Monday, dragged by blue-chip IT stocks. The 30-share BSE Sensex dropped 125.96 points to 85,636.05 during early trade. The 50-share NSE Nifty dipped 30.95 points to 26,297.60. From the 30-Sensex firms, HCL Tech, Infosys, Tech Mahindra, HDFC Bank, Tata Consultancy Services, and NTPC were among the biggest laggards. However, Bharat Electronics, Tata Steel, Axis Bank, and Reliance Industries were among the gainers. Foreign Institutional Investors (FIIs) bought equities worth Rs 289.80 crore on Friday, according to exchange data. Domestic institutional investors (DIIs) also bought stocks worth Rs 677.38 crore. “The year 2026 has begun with major geopolitical developments which can have profound consequences. The US action in Venezuela has the potential to further destabilise global geopolitics,” V K Vijayakumar, Chief



Investment Strategist, Geojit Investments Ltd, said. In Asian markets, South Korea's Kospi index, Japan's Nikkei 225 index and Shanghai's SSE Composite index were trading significantly higher, while Hong Kong's Hang Seng index quoted marginally lower. US markets ended mostly in positive territory on Friday. Brent crude, the global oil benchmark, dipped 0.08 per cent to USD 60.70 per barrel. On Friday, the Sensex climbed 573.41 points, or 0.67 per cent, to settle at 85,762.01. The Nifty went up by 182

points, or 0.70 per cent, to 26,328.55. Foreign portfolio investors have started 2026 on a cautious note, extending their selling streak from last year by withdrawing Rs 7,608 crore (USD 846 million) from Indian equities in the first two trading sessions of January. The withdrawal of funds followed the largest outflow of Rs 1.66 lakh crore (USD 18.9 billion) recorded in 2025, triggered by volatile currency movements, global trade tensions and concerns over potential US tariffs, and stretched market valuations. This sustained selling pres-

sure by foreign portfolio investors (FPIs) has significantly contributed to the nearly 5 per cent depreciation of the rupee against the dollar during 2025. However, market experts believe the tide could turn in 2026. VK Vijayakumar, Chief Investment Strategist at Geojit Investments, said the year is likely to witness a shift in FPI strategy, as improving domestic fundamentals may start attracting net foreign inflows. A robust GDP growth and the prospects of a recovery in corporate earnings bode well for positive FPI flows in the coming months, he added. Echoing similar views, Vaqarjaved Khan, Senior Fundamental Analyst at Angel One, said normalisation in India-US trade relations, a benign global interest rate environment and stability in the USD-INR pair could create a favourable backdrop for foreign investors. He noted that equity valuations have become relatively comforting compared to last year, which could further support a revival in inflows.

## Net office leasing up 25 pc in 2025 in top 8 Indian cities: Report

**New Delhi:** Net leasing of office spaces rose 25 per cent last year to a record 61.4 million sq ft across eight major cities on strong demand from domestic and overseas companies, according to Cushman & Wakefield. Net leasing of office spaces stood at 49.1 million sq ft during 2024 in these eight cities. Net absorption or leasing represents the net change in office space occupied during the year. Real estate consultant Cushman & Wakefield on Monday released the data, showing that net office leasing rose in Bengaluru, Hyderabad, Pune, Delhi-NCR, and Chennai but declined in Mumbai, Kolkata, and Ahmedabad. “The last year's performance reflects more than record numbers, it signals a long-term growth trajectory anchored in strong fundamentals,” said Anshul Jain, Chief Executive, India, SEA, MEA & APAC Office and Retail, Cushman & Wakefield. He projected



that the office demand would remain strong during 2026, driven by expansion of global capability centres (GCCs) in India and rising technology adoption. As per the data, the net office leasing in Chennai almost tripled to 7 million sq ft last year from 2.4 million sq ft in the 2024 calendar year. Delhi-NCR witnessed a sharp growth of 82 per cent in net office leasing to 10.9 million sq ft during 2025 from 6 million sq ft in the preceding year. Bengaluru, the most prominent office market, witnessed a marginal rise

in net office leasing to 14.4 million sq ft from 14.2 million sq ft in 2024. Office demand rose 65 per cent in Pune to 8.2 million sq ft from 5 million sq ft. In Hyderabad, the net leasing grew 15 per cent to 9.1 million sq ft from 7.9 million sq ft. However, Mumbai — the financial capital of India — witnessed a 12 per cent decline in office demand to 9.6 million sq ft from 10.9 million sq ft. In Kolkata, the demand dipped 5 per cent to 1.4 million sq ft from 1.5 million sq ft. Lastly, the net office leasing in Ahmedabad by

28 per cent to 0.8 million sq ft last year from 1.2 million sq ft in the preceding calendar year. According to Cushman & Wakefield, the gross leasing of office space also hit an all-time high at 88.7 million sq ft in 2025, up 1 per cent from 88 million sq ft in the preceding year. The gross leasing factors in all leasing activity in the market, including fresh take-up, open market renewals by occupiers as well as pre-leasing. New supply of office spaces rose 17 per cent to around 53 million sq ft during the last year.

## THE FRENCH UNIVERSITY WHERE SPIES GO FOR TRAINING



University professor Xavier Crettiez admits that he doesn't know the real names of many of the students on his course. This is a highly unusual state of affairs in the world of academia, but Prof Crettiez's work is far from standard. Instead, he helps train France's spies. “I rarely know the intelligence agents' backgrounds when they are sent on the course, and I doubt the names I'm given are genuine anyway,” he says. If you wanted to create a setting for a spy school, then the campus of Sciences Po Saint-Germain on the outskirts of

Paris seems a good fit. With dour, even gloomy-looking, early 20th Century buildings surrounded by busy, drab roads and large, intimidating metal gates, it has a very discreet feel. Where it does stand out is its unique diploma that brings together more typical students in their early 20s, and active members of the French secret services, usually between the ages of 35 and 50. The course is called Diplôme sur le Renseignement et les Menaces Globales, which translates as Diploma of Intelligence and Global Threats. It was developed

by the university in association with the Académie du Renseignement, the training arm of the French secret services. This came following a request from French authorities a decade ago. After the 2015 terrorist attacks in Paris, the government went on a large recruitment drive within the French intelligence agencies. It asked Sciences Po, one of France's leading universities, to come up with a new course to both train potential new spies, and provide continuous training for current agents. Large French companies were also quick to show an interest, both in getting their security staff onto the course, and snapping up many of the younger graduates. The diploma is made up of 120 hours of classwork with modules spread over four months. For external students — the spies and those on placement from businesses — it costs around \$5,000 (\$5,900; £4,400).

# Trump warns new Venezuelan leader as Maduro set to appear in court

Donald Trump has warned Venezuela's new leader Delcy Rodríguez she could "pay a very big price, probably bigger than Maduro" if she "doesn't do what's right". His comments to US magazine The Atlantic came as the country's deposed president Nicolás Maduro was set to appear in a New York court on Monday. The US accuses Maduro, who is charged with drug trafficking and weapons offences, of running a "narco-terrorist" regime, a claim he denies. Rodríguez - who served as Maduro's vice president - adopted a conciliatory tone at her first cabinet meeting on Sunday, offering co-operation with the US. "We invite the US government to collaborate with us on an agenda of co-operation orientated towards shared development within the framework of international law," she said. Backed by Venezuela's



Supreme Court and the military, she will be sworn in as president on Monday in Caracas, at 08:00 local time (12:00 GMT). US Secretary of State Marco Rubio has insisted the US is not at war with Venezuela, after air strikes in Caracas on Saturday led to Maduro and his wife being taken into custody and transported to the US. Some Democratic lawmakers said the operation was an "act of war". In an interview with The Atlantic on Sunday, Trump said of Rodríguez: "If she doesn't do what's right, she is going to pay a very big price, probably bigger than Maduro." He added that for Venezuela, "Regime change, anything you want to call it, is better than what you have right now. Can't get any worse". On Saturday, Trump had vowed the US would "run" the country until "a safe and proper and judi-

cious transition" was possible. Trump also promised US oil companies would move into the country to fix infrastructure "and start making money for the country". Despite the US president's claims, Maduro's allies remain in charge. The Cuban government has said 32 "brave Cuban combatants" died when US forces attacked and captured Maduro and his wife. Cuba - a longstanding socialist ally of Maduro - has announced two days of national mourning. In several TV interviews on Sunday morning, Rubio defended the US's military operation in Venezuela, stressing the action did not mean the US is at war with the South American country. "We are at war against drug trafficking organisations. That's not a war against Venezuela," Rubio told NBC's Meet the Press on Sunday morning. The secretary of state also told CBS that if Venezuela doesn't "make the right decisions", the US "will retain multiple levers of leverage to ensure that our interests are protected". That includes the "quarantine" the US has placed on Venezuela's oil, he said. "We're going to judge everything by what they do, and we're going to see what they do," he added. Trump also threatened Venezuela's neighbour Colombia, in comments to reporters aboard Air Force One. He did not rule out military action against Colombia, saying "it sounds good to me", and

## 'We need Greenland': Trump repeats threat to annex Danish territory

Donald Trump has again proposed annexing Greenland, after Denmark's leader urged him to "stop the threats" over the island. Speaking to reporters, the US president said "we need Greenland from the standpoint of national security". Trump has repeatedly raised the prospect of the semi-autonomous Danish territory becoming an annexed part of the US, citing its strategic location for defence purposes and mineral wealth. Greenland's Prime Minister Jens Frederik Nielsen responded by saying "that's enough now" and described the notion of US control over the island as a "fantasy". He said: "No more pressure. No more insinuations. No more fantasies of annexation. We are open to dialogue. We are open to discussions. But this must happen through the proper channels and with respect for international law." Earlier, Denmark's Prime Minister Mette Frederiksen had said "the US has no right to annex any of the three nations in the Danish kingdom". Frederiksen added that Denmark "and thus Greenland" was a Nato member and covered by the alliance's security guarantee, and said a defence agreement granting the US access to the island was already in place. The Danish prime minister released her statement after Katie Miller - the wife of one of Trump's senior aides, Stephen Miller - posted on social media a map of Greenland in the colours of the American flag alongside the word "SOON". The Danish ambassador to the US responded to the post by Miller - a right-wing podcaster and former aide to Trump during his first term - with a "friendly reminder" that the two countries were allies and saying Denmark expected respect for its territorial integrity.

## Bluefin tuna fetches record \$3.2m at Tokyo auction



A bulky bluefin tuna made a splash at Tokyo's Toyosu fish market on Monday morning, fetching a record 510.3 million yen (\$3.2m; £2.4m) at the market's first auction of the year. The winning bid for the 243kg fish came from Kiyomura Corp, the operator of popular sushi chain Sushi Zanmai, which has outlets across the country and abroad. "The year's first tuna brings good luck," said Kiyoshi Kimura, the company's president and a familiar figure at the annual new year's auction, Kyodo reported. Mr Kimura, who has been dubbed the Tuna King, is known to bid high for bluefin tuna at new year's auctions. The entrepreneur told reporters after the auction that he was "surprised at the price", AFP reported. "I'd thought we would be able to buy a little cheaper, but the price soared before you knew it," he said. Mr Kimura paid 56.5 million yen for a bluefin tuna in 2012 and 155 million yen in 2013 - setting record prices both times. In 2019

he bought a bluefin tuna with 333.6 million yen (\$2.1m; £1.6m) - another historic price. Despite telling reporters at the time that he thought he "did too much", however, Mr Kimura has now gone on to break his own record again. The first auction at Tokyo's Toyosu fish market typically sees fish selling for exorbitant prices. Last year, the first tuna at the auction was bought for 207 million yen by Onodera Group, another food company that owns a sushi chain. It said that the fish would be served at its restaurants across the country. The frenetic energy at fish markets during such pre-dawn auctions has become a popular tourist attraction in Tokyo. Monday's auction, which started at around 05:00 local time (20:00 GMT), was no exception. The million-dollar tuna was sliced up for customers at Kimura's sushi restaurant shortly after it was auctioned off. "I feel like I've begun the year in a good way after eating something so auspicious as the year starts.

## Raw emotions as mourners attend Mass for Swiss bar fire victims



In the snow-dusted street outside St Christopher's Church, hundreds joined a special Sunday Mass for the victims of the fire that tore through Le Constellation bar on New Year's Eve. Many hugged each other, crying quietly, as they remembered the dozens killed and those still in hospital with severe burns, fighting for their lives. During the service, several in the crowd fainted and fell to the ground,

overcome. All 40 of the dead have now been identified, although not named publicly. Their bodies are being returned to their families, some of whom had been holding on to the hope their children might yet be found - injured, but alive. They're now receiving the worst possible news. ## TEN FOUND GUILTY OF CYBER-BULLYING BRIGITTE MACRON



Ten people have been found guilty of cyber-bullying Brigitte Macron, the wife of French President Emmanuel Macron, by a Paris court. The defendants were accused of spreading false claims about her gender and sexuality, as well as making "malicious remarks" about the 24-year age gap between the couple. Most of the defendants were handed suspended prison sentences of up to eight months, but one was jailed immediately for failing to attend court. Some had their social media accounts suspended. The judge said the eight men and two women had acted with a clear desire to do harm to Brigitte Macron, making remarks online that were degrading and insulting. Two of the defendants - self-

styled independent journalist Natacha Rey and internet fortune-teller Amandine Roy - were found guilty of slander in 2024 for claiming that France's first lady had never existed. They said her brother Jean-Michel Trogneux had changed gender and started using her name. They were later cleared on appeal. The argument used by the appeals court in clearing them was

that saying someone had changed gender was not necessarily an "attack on their honour". The Macrons are now taking that case to the high court of appeal. "The most important things are the prevention courses and the suspension of some of the accounts" of the perpetrators, Jean Ennouchi, Brigitte Macron's lawyer, said after the verdict was handed down, the AFP

news agency reported. Tiphaine Auzière, Brigitte Macron's daughter from a previous marriage, previously told the trial that the cyber-bullying had negatively affected her mother's health and living conditions. She said her mother "has had to be careful about her choices of outfits, of posture... she knows perfectly well that her image will be used to back these theories". While her mother had "learned to live with it", Auzière said, she suffered from the repercussions on her grandchildren who were taunted at school. Monday's ruling in France is a forerunner of a much bigger trial due in the US, where the Macrons have filed a defamation lawsuit against right-wing influencer Candace Owens.

## THIRTY-TWO CUBANS KILLED DURING US ATTACK ON VENEZUELA

The Cuban government has said 32 of its nationals were killed during the US operation to seize Venezuelan leader Nicolás Maduro. It said the dead were members of its armed forces and intelligence agencies, with two days of national mourning declared. A short statement did not elaborate on the role of the Cubans in Venezuela, but the two governments are long-standing allies, with Cuba providing security support in exchange for oil. Cuban President Miguel Díaz-Canel said they had been providing protection to Maduro and his wife "at the request" of Venezuela. An official government state-



ment read: "Our compatriots fulfilled their duty with dignity and heroism and fell, after fierce resistance, in direct combat against the attackers or as a result of bombings on the facilities." Venezuela has not confirmed how many people were killed during the US

raid on Maduro's compound in Caracas on Saturday. The New York Times, citing an unnamed Venezuelan official, reported on Sunday that the death toll stood at 80 and was expected to rise. BBC News has not independently verified that report. In the days

following the capture of Maduro, questions have been raised over whether the Trump administration could consider a similar operation against Cuba, which, like Venezuela, has had decades of adversarial relations with the US. Speaking to reporters on Sunday, US President Donald Trump said military action would not be necessary because "Cuba is ready to fall". He continued: "I don't think we need any action. Looks like it's going down. It's going down for the count." On Saturday, US Secretary of State Marco Rubio described Cuba as a "disaster" run by "incompetent, senile men".

## Activist group says it was behind Berlin fire that cut power to thousands



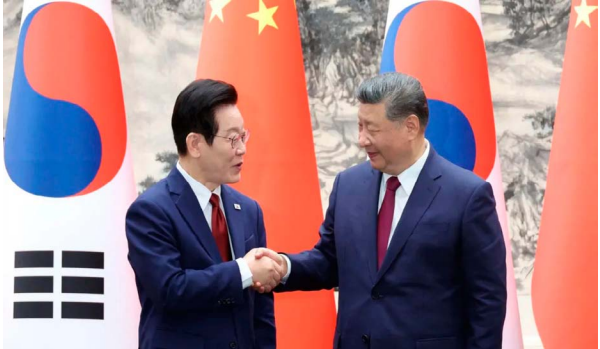
A far-left activist group in Germany has claimed responsibility for a suspected arson attack that left tens of thousands of homes, as well as hospitals and businesses, without power in around-freezing temperatures. The Vulkangruppe (Volcano Group) said in a statement that the fossil fuel economy, not cutting power, was the target of the action. It will take until Thursday to reconnect power for all customers, with some schools due to be closed at the start of this week. Early on Saturday, several cables on a bridge were spotted burning near a power plant in south-west Berlin. The fire was quickly put out, but around 45,000 households and 2,200 businesses were left without electricity. The state economy minister told German media that incendiary devices had caused the damage. Berlin's mayor condemned the attack, accusing "suspected left-wing

extremists" of knowingly endangering lives, especially those of patients in hospitals. Hospitals and care facilities had received emergency power generators, officials said. The response had included transferring individuals from care sites and people requiring care in their own homes from the affected area to care facilities with reported available capacity. Some hospitals had their electricity restored by Sunday. As of Sunday afternoon, around 10,000 households and 300 businesses had been reconnected, with most still waiting to receive power back. Some schools, which were due to reopen on Monday after the Christmas holidays, will remain closed. The capital's electricity operator said it would take until Thursday to reconnect all customers. The Vulkangruppe in its statement apologised to less affluent residents impacted by the power cuts.

## SOUTH KOREA'S LEE JAE MYUNG MEETS CHINA'S XI AS HE SEEKS TO RESET TIES

South Korea's President Lee Jae Myung is meeting Chinese leader Xi Jinping as he seeks to reset frayed ties with his country's biggest trading partner. Regional security and Beijing's unofficial ban on Korean pop culture are also on the agenda for Monday's meeting, which is their second summit since November, when Xi visited South Korea. Given what a vital economic partner China is, experts say Lee is looking for assurances that it would not weaponise that relationship in the face of political tensions in the region. For weeks, China and Japan have been engaged in a diplomatic row over the former's claim on self-governed Taiwan, which

puts Seoul, a key regional power, in an awkward spot. Beijing ramped up the rhetoric against Japan after its prime minister Sanae Takaichi suggested in parliament that Tokyo could respond with its own self defence force in case of a Chinese attack on Taiwan. So visiting Beijing at this time is a significant move for Lee. Like Japan, South Korea too is an ally of the US, which supports Taiwan and supplies arms for its defence. Xi is expected to hold a welcoming ceremony for Lee in Beijing's Great Hall of the People, state-run CCTV reports. Lee, who arrived in Beijing on Sunday, will then meet China's Premier Li Qiang and the chairman of



parliament, Zhao Leji, before flying to Shanghai. Speaking before Korean residents in Beijing on Sunday, Lee said his visit would "serve as a new starting point to fill in the gaps in Korea-China relations, restore them to normal and upgrade them to a new level". This is the first visit by a South Korean leader

since 2019. The relationship soured under Lee's predecessor, impeached ex-president Yoon Suk Yeol, who was very critical of China. On the other side, Xi's eagerness to meet Lee signals the pressure he faces in finding a regional ally, Park Seungchan, professor of China

studies at Yongin University told the BBC. "China may beat around the bush but its demand is clear: side with China and denounce Japan." Beijing has been leveraging the two countries' shared history of fighting against Japan during the 20th Century, Mr Park said. Lee is expected to hold a memorial service in Shanghai for activists who fought for Korea's independence from Japan. While Korea is "still showing all its deference towards China", it wants to "strengthen its relationships with both Japan and China", Mr Park added. Seoul has long walked a diplomatic tightrope between Beijing and Tokyo. Lee is reportedly planning to

visit Japan later this month to meet Takaichi. And on Friday, South Korea's national security director Wi Sung-lac told reporters the country "respects the One China policy" - the diplomatic acknowledgment that Beijing is the only Chinese government. Security on the Korean Peninsula will also be part of the discussions with China, Wi told reporters. Lee has sought to engage North Korea diplomatically, but there has been little progress so far. He needs Chinese cooperation in pressuring the North's Kim Jong Un to give up his nuclear weapons. Beijing is the dictator's biggest supporter, economically and diplomatically, Russia aside.



# Desert Vipers Seal Historic First ILT20 Crown After 46-Run Victory Over MI Emirates

The Desert Vipers secured their maiden DP World ILT20 trophy after beating MI Emirates by 46 runs in front of a packed Dubai International Stadium on Sunday night. The Desert Vipers took home a cash prize of USD 700,000 along with the Black Belt, while MI Emirates were awarded USD 300,000. Curran smashed an unbeaten 74 off 51 balls, studed with eight fours and two sixes, to power his team to an unassailable 182/4. He was well supported by Max Holden (41 off 32) and Dan Lawrence's (23 off 15) late charge. Naseem Shah (3/18), Usman Tariq (2/20), and Khuzaima Tanveer (2/22) led the bowling effort before David Payne's three-wicket haul (3/42) restricted MI Emirates to 136. Fans at the Dubai International Stadium were treated to a spectacular build-up ahead of the final, with a dazzling fireworks display and a drone show lighting up the night sky. The pre-match extravaganza created a carnival-like atmosphere as thousands of spectators



soaked in the visual spectacle that celebrated the league and set the stage for the biggest clash of the season. The Vipers' skipper Sam Curran capped off an impressive tournament by finishing with both the Red Belt (Most Valuable Player) and the Green Belt (Best Batter). Curran ended the season with 397 runs, including three half-centuries, and complemented his batting efforts with seven wickets and 10 catches. In the second innings, the Vipers' Naseem Shah set the tone early,

removing Andre Fletcher (10 off 11) and Tom Banton (7 off 6), while Khuzaima Tanveer capitalised with the key wicket of Muhammad Waseem (26 off 13). MI Emirates lost three wickets inside six overs and crawled to 46/3, leaving Shakib Al Hasan and Sanjay Krishnamurthi with plenty of work to do. Usman Tariq turned up the heat by dismissing Sanjay Krishnamurthi (2 off 9) in the eighth over. Shakib Al Hasan (36 off 27) attempted to steady the innings with calculated strikes, but boundaries were

hard to come by. With Kieron Pollard struggling to break free, MI Emirates reached 72/4 after 10 overs, falling further behind in the chase. MI Emirates' hopes rested on Shakib and Kieron Pollard (28 off 27), who completed their 50-run stand in 38 balls before Tariq delivered a decisive blow by removing Shakib, pushing the equation to a daunting 61 off the final four overs. After Naseem Shah removed Kieron Pollard to end any late resistance, David Payne ripped through the lower order, bag-

ging three wickets in the 18th over. Khuzaima Tanveer sealed the title by clattering Muhammad Rohid's stumps (3 off 4) as the Vipers closed out the match with nine balls to spare. Earlier, the Vipers began briskly in the power-play as Fakhar Zaman (20 off 15) and Jason Roy (11 off 7) put on 34/0 in the first three overs. Momentum shifted in the fourth over when Fazalhaq Farooqi struck twice to dismiss both openers. Sam Curran responded emphatically, smashing three consecutive boundaries in the final over of the power-play to carry the Vipers to 59/2. Curran then joined hands with Max Holden, rotating the strike efficiently and attacking smartly to take the Vipers to 83/2 at the halfway stage. The duo completed their 50-run stand in the 11th over, off just 39 balls. Curran kept the offensive going while Holden played the anchor role before Arab Gul ended their 89-run partnership off 64 balls with Holden's wicket in the 15th over.

# Virat Kohli Takes Stunning Vijay Hazare Trophy Decision Ahead Of New Zealand ODI Series

Indian cricket team star batter Virat Kohli will not be available for Delhi's Vijay Hazare Trophy encounter against Railways on Tuesday. As per the BCCI mandate, Kohli played two matches in the competition for Delhi - against Andhra Pradesh and Gujarat. He looked in brilliant form, scoring 131 and 77 respectively in those matches. Although the star batter was supposed to play one more match for Delhi before joining the national side for the ODI series against New Zealand, Delhi coach Sarandeep Singh confirmed that he will not be available. "No, he is not available," Singh said. Earlier, Delhi and District Cricket Association (DDCA) President Rohan Jaitley stated that Kohli had given his availability for three games in the Vijay Hazare Trophy. "As of now, he is playing. Virat has given



his availability for three games," he told PTI. Shreyas Iyer has been appointed as captain of Mumbai for the remainder of their Vijay Hazare Trophy Elite Group C games in Jaipur, said the Mumbai Cricket Association (MCA) on Monday. Shreyas will take

over the captaincy from injured regular skipper Shardul Thakur who has been sidelined from the rest of the competition due to injury. Mumbai are currently at second place in Group C and will take on Himachal Pradesh on Tuesday, before facing Punjab on January 8.

# "Glad SA20 Has Made It Possible For Me To Finish With Super Kings": Faf Du Plessis

At 41, Faf du Plessis, the former South African captain is still going strong and is hungry to play and perform. Leading the Joburg Super Kings for the fourth season in a row, du Plessis was excited to have another crack at winning the title in yellow. As he sat down with his former Proteas teammate and one of the members of the SA20 commentary panel, Dale Steyn, du Plessis spoke about the Super Kings franchise, mega auction and needing to have a strong bowling attack. Speaking with SA20, looking forward to the new season, Faf du Plessis recalled his journey with the Super Kings franchise, from CSK to now with JSK: "As players, you look back on your career and are very grateful for certain



things that happened at certain times. And for me, getting signed the same year when I made my international debut, by CSK, was obviously something that, if I look back now, was a huge starting point of my career. # KKR Advised To Sign This Star As Mustafizur Rahman's Replacement In IPL 2026 After Bangladesh Player's Release

The release of Bangladesh pacer Mustafizur Rahman by IPL franchise Kolkata Knight Riders, after being instructed to do so by the BCCI, has snowballed into a major controversy. KKR had acquired the services of the 30-year-old left-arm for Rs 9.20 crore from a base price of Rs 2 crore after an intense bidding war with Chennai Super Kings and Delhi Capitals at the players' auction last month. The BCCI said KKR will be allowed to name a replacement player if required for the event scheduled to start on March 26. "The BCCI has asked Kolkata Knight Riders to release Mustafizur Rahman from its squad. They can ask for a replacement, if needed.



And upon request, BCCI will allow a replacement player," BCCI secretary Devajit Saikia told PTI here on Saturday. Asked why the BCCI has asked Kolkata Knight Riders to do so, he replied, "Because of recent developments all across." After the Bangladesh Cricket Board (BCB)

released a press statement that they want Bangladesh's matches to be shifted from India due to 'safety and security' reasons. The broadcast of IPL has also been stopped. In the midst of the developments, former Royal Challengers Bengaluru (RCB) player Shreevats Goswami has suggested

KKR pick Marco Jansen's brother Duan as a replacement. "Marco Jansen's brother Duan Jansen isn't a bad replacement option for the @KKRiders. Like for like and also can definitely bat better. Get him @KKRiders," he wrote on X. Duan, who bowls left-arm pace like Mustafizur Rahman, has been in great form for Joburg Super Kings in the SA20. Earlier, in a statement, KKR said it has released the player as instructed by the BCCI. "Kolkata Knight Riders confirms that BCCI/IPL, as the regulator of IPL, has instructed it to release Mustafizur Rahman from the squad ahead of the upcoming Indian Premier League (IPL) season.

# Paarl Royals Paint Western Cape Pink With Double Derby Win



Paarl Royals made SA20 history at Newlands on Sunday when they beat coastal rivals MI Cape Town for the first time at Newlands. After three previous defeats under the watch of Table Mountain, the Royals completed a Season 4 Western Cape derby double with a comprehensive seven-wicket bonus point victory. The Royals have now leapfrogged Sunrisers Eastern Cape into second place on 13 points - just two points adrift of table-toppers Joburg Super Kings. Zimbabwe international Sikandar Raza has proved to be a revelation since his arrival in the Royals camp with another stirring performance with the ball. Raza followed up his 3/27 on his Royals debut last Friday with a match-winning 4/13 from his four overs. The off-spinner was ably supported by 19-year-old rookie Nqobani Mokoena (2/10)

and the experienced Otneil Baartman (2/8) as MI Cape Town crumbled to 88 all out - their lowest score in the history of the competition. The four Player of the Match candidates were Otneil Baartman, Nqobani Mokoena, Sikandar Raza, Asa Tribe with Raza winning 75.2% of the fan vote. Royals lost Lhuan-dre Pretorius early in the chase to Trent Boult, but a solid 54-run partnership between Asa Tribe and Ruben Hermann for the second wicket set the visitors on the path to victory. Although both Hermann (18, 2x4) and Tribe (34, 3x4, 2x6) fell before the finish line was crossed, there would be no further setbacks with Kyle Verreynne (10 not out, 1x4) and his captain David Miller (19 not out, 2x4, 1x6) sealing the bonus point victory and Cape bragging rights for the boys in pink.

The young batter represented Delhi in age-group and senior domestic tournaments before moving to Railways ahead of last season. Pratika was one of India's standout performers in the tournament, finishing as the fourth-highest run-scorer with 308 runs in seven games, averaging 51.33.

# Man City increase interest in Palace captain Guehi



Manchester City are emerging as contenders to sign Crystal Palace captain Marc Guehi this month. BBC Sport understands City are exploring a move for the England centre-back in the wake of defenders Josko Gvardiol and Ruben Dias suffering injuries in the draw against Chelsea on Sunday. England centre-back John Stones is also currently out injured. City will wait to discover the full extent of the Gvardiol and Dias injuries before making a final decision on whether to proceed with their interest in Guehi during the current transfer window. But sources have told BBC Sport that City's interest in Guehi, 25, has progressed and that a move in January should not be discounted. Meanwhile, City have recalled academy defender Max Alleyne from his loan spell at Championship side Watford and he could be involved in the squad for Wednesday's Premier League game against Brighton. The 20-year-old - son of former England

cricketer and current Gloucestershire head coach Mark Alleyne - made 17 appearances for the Hornets after joining on a season-loan, but that has now been cut short as City try to tackle their growing injury crisis in defence. After the draw with Chelsea, which saw City concede an injury-time equaliser, manager Pep Guardiola told BBC Radio 5 Live "it doesn't look good" for Dias and Gvardiol and that the pair could be sidelined "for a few weeks". The Spaniard added: "We have a lot [of injuries]. John Stones is missing for I don't know how many months. Ruben now will be out, Josko will be out. "Nathan [Ake], always we know he cannot play regularly. It's the situation - stay strong and we will find a solution. "The spirit is there and will be there." Plenty of interest in Guehi Guehi, who has won 26 England caps, is out of contract this summer. It has been expected he will leave Selhurst Park as a free agent at the end of the season.
