Maoin commander with Rs 50,000 bounty arrested in Latehar

Latehar: Jharkhand police arrested a Maoist commander, Adesh Ganjhu, along with two associates, Ujjwal Kumar and Subhash Kumar, during a special operation in Latehar district, officials said on Wednesday. Ganjhu, who carried a ₹50,000 bounty, is an active member of the banned Tritya Sammelan Prastuti Committee (TSPC). Authorities recovered illegal firearms, ammunition, and documents linked to extremist activities from their possession.

10 IAS officers transferred after GHMC reorganisation

Hyderabad: The Department of General Administration on Wednesday, February 11, issued orders transferring 10 IAS officers following the reorganisation of the Greater Hyderabad Municipal Corporation (GHMC) into three separate municipal corporations. With the formation of Malkajgiri Municipal Corporation (MMC) and the Cyberabad Municipal Corporation (CMC), G Srijana, IAS officer of the 2013 batch, serving as the Additional Commissioner of the GHMC, has been transferred and posted as Commissioner of Cyberabad Municipal Corporation.

6 dead in road crash in Rajasthan's Dausa

JAIPUR: Six men were killed when a car in which they were travelling collided with a truck in Dausa district, police said on Wednesday. The incident occurred late Tuesday night when the victims were returning from a programme in Abhaneri village, according to the police, the driver lost control of the car, jumped the divider, and collided head-on with the truck. The victims were identified as Ankit, Samay Singh, Lokesh, Naveen, Dilkhush, and Manish. All six were friends and belonged to Kalkho village of Dausa, the police said.

TELANGANA MUNICIPAL POLLS:

Congress set for landslide victory in Municipal polls, exit poll shows



Hyderabad (TSIT) The ruling Congress party is set to make major gains in the municipal elections held across Telangana, with exit poll surveys by People's Pulse projecting a strong "Congress wave" across municipalities and municipal corporations. According to the survey, Congress is likely to capture nearly 70 per cent of the 116 municipalities and seven municipal corporations. The exit poll predicts a strong performance for the Congress in major municipal corporations such as Mancherial, Ramagundam, Nalgonda, Mahabubnagar and Kothagudem.

The Bharatiya Janata Party (BJP) is projected to emerge as the largest party in Karimnagar and Nizamabad municipal corporations, while the All India Majlis-e-Ittehadul Muslimeen (AIMIM) is expected to play a key kingmaker role in Nizamabad, Karimnagar and Mahabubnagar corporations.

The main opposition Bharat Rashtra Samithi (BRS), according to the survey, is unlikely to win a single municipal corpora-

CM Revanth, Bhatti Cast Votes as Telangana Municipal Polls



Hyderabad (TSIT): Chief Minister A. Revanth Reddy and Deputy CM Mallu Bhatti Vikramarka cast their votes on Wednesday in the municipal elections held across 116 municipalities and seven corporations. Polling is underway in 8,191 stations for 2,961 wards, with over 52 lakh voters deciding the fate of 12,944 candidates. Webcasting and tight security arrangements are in place. The State Election Commission urged citizens to exercise their franchise. Voting continues peacefully till 5 p.m.

Corporation-wise projections indicate Congress dominance in Ramagundam (30-34 wards), Mancherial (39-43), Kothagudem (28-34) and Mahabubnagar (26-30). In Nalgonda, Congress is projected to win 21-26 wards.

In contrast, BJP is likely to secure 26-31 wards in Nizamabad and 24-29 wards in Karimnagar, with AIMIM and other parties expected to influence outcomes in several corporations.

CM Revanth meets Kharge, discusses key political developments



New Delhi (TSIT): Telangana Chief Minister A Revanth Reddy called on Congress president Mallikarjun Kharge, who is also the Leader of Opposition in the Rajya Sabha, in the national capital on Wednesday.

The meeting, described as cordial, saw discussions on key political developments and matters of public importance, an official statement said. The chief minister was accompanied by Congress Rajya Sabha member Mallu Ravi and Lok Sabha MPs Anil Kumar Yadav and K Raghuvver Reddy.

The meeting assumed significance amid the ongoing political developments in Telangana and at the national level, though the specific issues discussed were not immediately shared.

KTR slams Congress 'anarchy' in municipal polls, praises BRS cadres' fight

Hyderabad (TSIT) Bharat Rashtra Samithi (BRS) Working President K T Rama Rao (KTR) on Wednesday strongly criticised the ruling Congress party, alleging large-scale anarchy and atrocities during the municipal elections in Telangana.

In a statement, KTR congratulated BRS activists who, he said, fought "heroically" and organised protest marches despite obstacles, intimidation and alleged inducements by the ruling party. He praised the fighting spirit of BRS cadres, popularly known as the "pink soldiers," from Adilabad to Alampur, saying their resilience had given the party renewed strength and confidence. KTR accused Chief Minister A Revanth Reddy of resorting to violence and misuse of power out of fear of defeat in the municipal elections. He alleged that the Chief Minister was attempting to cover up what he termed the "failures" of the Congress government over the past two years and was determined to avoid a repeat of the setbacks the party faced in the panchayat elections.

Warning that Telangana society would not remain a silent spectator, KTR alleged that attempts were being made to influence the public mandate using illegally looted public funds running into thousands of crores.

MOTHER INDIA HAS BEEN SOLD:

Rahul's fiery trade deal attack sparks uproar in Lok Sabha



New Delhi (TSIT) Accusing the government of having "sold Mother India" under pressure from the United States, Leader of the Opposition Rahul Gandhi on Wednesday launched a blistering attack in the Lok Sabha over the India-US trade deal, triggering sharp protests from the Treasury benches and a forceful rebuttal from Parliamentary Affairs Minister Kiren Rijiju. Participating in the discussion on the union Budget in the Lower House, Gandhi alleged that the Centre had signed the trade agreement "under pressure" from Washington and compromised India's strategic interests, particularly in the digital and agricultural sectors.

"Our data has been sold. Our farmers have been sold," Gandhi declared, his remarks drawing loud objections from BJP members. "If India refused to comply, tariffs would be raised again. Is this how a sovereign nation negotiates?"

The outburst marked the culmination of a week of rising tensions in the Lok Sabha, where the trade pact has dominated proceedings. Since last week, opposition parties have repeatedly demanded greater transparency on the contours of the agreement, alleging that Parliament was being kept in the dark on critical provisions relating to digital trade, data flows and agricultural safeguards. The government, in turn, has accused the Opposition of spreading misinformation and undermining India's global standing.

Framing the global context as one of shifting power equations, Gandhi said the world was moving away from the era of uncontested US dominance. "We are living in a time of war—Ukraine, Gaza, the Middle East. The dollar is being challenged. US dominance is being challenged. We are moving from a world of superpowers to a new world we cannot really predict," he said. In that backdrop, he argued, India's bargaining power lay in its vast digital population and data economy. "The most valuable asset in the competition between the US and China is Indian data. If the US wants to remain a superpower and protect its dollar, Indian data is the most important," he said.

Gandhi outlined what he said would have been his approach had the INDIA bloc been negotiating the deal. "We would tell President Trump: the most

important thing in this equation is Indian data. You want to save your dollar? We are your friends. But if you want access to this data, you will speak to us as equals. You will not speak to us as if we are your servants." He added that energy security and farmers' interests would have been non-negotiable. "We understand you have an agricultural voter base. We understand you need to protect your farmers. But we will also protect our farmers," he said. In one of his sharpest remarks, Gandhi said, "We will not be treated like Pakistan. If President Trump decides to have the Pakistan Army Chief have breakfast with him,

After 5G, India to lead the world in 6G: Jyotiraditya Scindia

New Delhi, Feb 11 (TSIT): Union Communications Minister Jyotiraditya Scindia on Wednesday said that India followed the world in 4G, marched with the world in 5G and will lead the world in 6G. Responding to questions in the Lok Sabha today, the minister highlighted India's rapidly transforming digital landscape and future roadmap.

India has rolled out 5G at the fastest pace in the world. Within just 22 months, 5G services have been launched in 99.9 per cent of the country's districts, setting a global benchmark. Currently, 400 million citizens are ben-



Telecom service providers have invested nearly Rs 4 lakh crore for this expansion, with over 5 lakh BTS (Base Transceiver Stations) installed nationwide."

India has surged from 60 million connections a decade ago to 1 billion today. By 2030, the government aims to further strengthen and deepen this digital infrastructure.

"Under the leadership of Prime Minister Narendra Modi, India is no longer a follower of technology but has emerged as a global digital leader," said Communications Minister, adding that the revolution is no longer confined to metropolitan cities but is reaching villages across the country, reshaping citizens' lives, education, healthcare, and livelihoods.

New Delhi (TSIT): Deputy Chief Minister and Karnataka Congress President D.K. Shivakumar said on Wednesday that "our party" laid the foundation for 'Vande Mataram', adding "it is our party that gave this country the national flag, the national anthem, the Constitution and Independence.

It is our party that has served this nation". "Now the BJP and others are following us. That itself gives us happiness," he said while responding to questions from the media at Karnataka Bhavan in Delhi.

When asked about the demand that 'Vande Mataram' be accorded the same respect as the national anthem and be made mandatory, he said: "We sing 'Vande Mataram' at every stage while beginning our



programmes. We give respect to 'Vande Mataram' and we follow it." Referring to past decisions, he said: "When late S.M. Krishna was the Chief Minister, we made Kuvempu's 'Jaya Bharata Jananiya Tanujate' compulsory as the state anthem. It contains the line 'Sarvajanagada Shantiya Thota' (garden of peace for all communities). Ours is a garden of peace

for all communities. It mentions what is to be said and which religions are to be referred to. Hindus, Christians and Muslims are all mentioned in the song itself. We are the ones who have grown up on such soil." When asked whether this would result in two national anthems, he replied: "We will speak about that later."

When asked about his brother, former Congress MP D.K. Suresh's statement that though there may be some delay, Siddaramaiah would keep his word, Shivakumar said: "I have said that time will give the answer. I have also said that only we know what we have spoken about." When asked when that time would come, he replied cryptically: "I will tell you at the appropriate time."

Rekha further criticised Sanjay's past silence during earlier employee protests and demanded a white paper on his performance as Karimnagar MP, citing pending projects such as the Kazipet Coach Factory and Bayyaram Steel Plant. Highlighting Congress government welfare measures, she said public support for schemes benefiting women, farmers, and poor families was increasing, and challenged the BJP to secure Central funds for retirees instead of "political drama."



TGSRTC to operate 2,243 special buses for Maha Shivaratri

Hyderabad: Telangana State Road Transport Corporation on Wednesday, February 11, announced 2,243 special buses to 43 Shiva temples across the state for Maha Shivaratri. Although the festival falls on February 15, buses will operate from February 14 to 16. The corporation has allocated a specific number of buses to major pilgrimage sites including 781 buses to Srisailem, 416 buses to Vemulawada, 249 buses to Edupalya, 326 buses to Keesaragutta, 127 buses to Velala and 71 buses to Kaleshwaram.

Telangana govt splits Greater Hyderabad into three municipal corporations

Hyderabad, Feb 11 : The Telangana government has divided the Greater Hyderabad Municipal Corporation (GHMC) into three separate corporations. It has created two new corporations, Cyberabad and Malkajgiri, while retaining six out of 12 zones under GHMC.

A Government Order (GO) was issued on Wednesday, constituting three municipal corporations -- Cyberabad Municipal Corporation, Malkajgiri Municipal Corporation and Greater Hyderabad Municipal Corporation.

The government also appointed Jayesh Ranjan, Special Chief Secretary to the Government, Metropolitan Area and Urban Development Department, as Special Officer for the three corporations. R.V.Karnan will continue as the



Commissioner of GHMC. G. Srijana has been transferred and posted as Commissioner, Cyberabad Municipal Corporation. T. Vinay Krishna Reddy, Additional Commissioner, GHMC, has been transferred and posted as Commissioner, Malkajgiri Municipal Corporation.

According to the GO, the existing GHMC has been reorganised after careful examination/consideration of the administrative requirements arising out of the expansion of the city. The move came a couple of months after the

merger of the surrounding 27 urban local bodies with the GHMC to create the Core Urban Region (CURE). The government, in December last year, had approved the reorganisation of GHMC into 12 zones and 60 circles. Cyberabad Municipal Corporation will comprise the areas constituted by the Serilingampally, Kukatpally and Qutbullapur zones. Malkajgiri Municipal Corporation will comprise the areas constituted by the Malkajgiri, Uppal and L.B. Nagar zones. Areas under Shamshabad, Rajendernagar, Charminar, Golconda, Khairatabad and Secunderabad will come under GHMC. The two new corporations will have a population of 35 lakh each, while GHMC will cover a population of 70 lakh.

Congress sends 'RR tax' collected in Telangana: Kishan Reddy

Hyderabad: Stepping up attack on the Telangana government, Union Coal Minister G Kishan Reddy on Wednesday alleged that the 'first instalment of RR tax' collected from builders and others here has reached poll-bound Kerala.



Jagga Reddy Demands Suspension of CI After Alleged Manhandling of Congress Candidate

Sangareddy (TSIT) : Congress Working President Jagga Reddy on Wednesday demanded the immediate suspension of Circle Inspector Shivakumar, alleging that the officer caught a Congress candidate by the collar during polling for the Sangareddy municipal elections at Ward No. 34 in Rajampet. self?" Reddy accused CI Shivakumar of acting irresponsibly and demanded his immediate suspension. He also alleged that despite a change in government, the police mindset remained biased in favour

of the BRS party. "Has the police mindset not changed even after the government changed?" he questioned, warning authorities not to create law and order problems in Sangareddy. In an angry outburst, Reddy made controversial remarks, saying, "If you have the guts, shoot with a revolver... I will handle it. Let us see who he is and who I am." He also claimed he had not visited polling booths for the past 26 years and alleged that his candidate was being unfairly targeted. Reddy further demanded the cancellation of polling arrangements at Ward No. 34. His remarks and actions have sparked intense discussions across political circles in the region.

NEW DELHI (TSIT): Parliamentary Affairs Minister Kiren Rijiju on Wednesday alleged that Congress leader Rahul Gandhi's speech in the Lok Sabha was "full of lies" and the ruling alliance will seek to expunge from the House records the "lies" he has spoken.

Soon after Gandhi's speech during a debate on the Union Budget, Rijiju said the ruling alliance members will serve a notice before the chair seeking authentication of whatever the leader of opposition has spoken.

"We will demand expunging of whatever lies Rahul Gandhi has spoken," he told reporters here.

Even though Gandhi has promised to authenticate what he has spoken, the minister said, "I know he cannot authenticate them because he lied. He lied in the House." Rijiju further alleged that the Congress leader often lies deliberately and then leaves



the House, instead of sitting there to listen to the reply of the minister concerned.

It was unfortunate, he said, that the country does not have a person with a serious nature befitting the position of the leader of opposition in Lok Sabha.

"Our party has taken a stand that we will counter Rahul Gandhi's lies outside, but inside the House, a notice will be

issued," he said. Rijiju said Gandhi has made a major allegation against Petroleum Minister Hardeep Singh Puri without giving any notice, which is a serious breach of privilege.

"We will file the necessary notice with the speaker. The leader of the opposition did not make any useful substantive contribution to the budget discussion but only made some wild

allegations," he said. The minister said he told Gandhi to be present in the House when Finance Minister Nirmala Sitharaman would reply to the budget discussion.

"After his speech, he immediately went out of the House. The rule is that once a member delivers his speech, he cannot leave the House immediately," he said. Gandhi alleged in the Lok Sabha that the government has "sold Bharat Mata" through the India-US interim trade deal and that it was a "wholesale surrender" with India's energy security handed over to America and farmers' interests compromised.

Rijiju said no one can sell or buy India, no one can think of that. "In 2011-12, India was considered as one of the fragile five country. Now we are the fourth largest economy and poised to become the third largest," he said.

72-Year-Old Avoids Open-Heart Surgery in Rare Recovery at Medicover



Secunderabad, February 11, 2026 - A 72-year-old woman with acute heart failure has recovered without undergoing open-heart surgery, thanks to a minimally invasive, catheter-based procedure at Medicover Hospitals, Secunderabad.

The patient had been suffering from progressive breathlessness and severe fatigue for months before her condition worsened, requiring hospitalisation.

Doctors diagnosed a severe mitral valve leak, a form of heart valve disease that affects nearly one in ten Indians above the age of 65. Many dismiss such symptoms as signs of normal ageing, leading to delayed treatment.

Given the patient's age and clinical profile, conventional open-heart surgery was deemed high-risk. A multidisciplinary Heart Team—comprising interventional cardiologists, cardiac surgeons, imaging

specialists, anaesthetists, and heart failure experts—collaboratively opted for a transcatheter intervention.

The procedure was led by Dr. Pramod Kumar Kuchulakanti, Director - Structural Heart Disease and Advanced Coronary Interventions, along with Dr. Sagar Chandrashekhara Bhuyar, Dr. N. Siva Prasad Naidu, Dr. Amrendra Kumar Singh, Dr. Parvatraj Varun Gautam, and Dr. Subramanyam. Using

advanced cardiac imaging, the team successfully reduced the mitral valve leakage, resulting in significant improvement in heart function and symptoms.

"Heart valve disease in elderly patients is often underdiagnosed because symptoms are mistaken for normal ageing," said Dr. Kuchulakanti. "Timely evaluation and a structured Heart Team discussion helped us choose a safer, minimally invasive solution. With advanced imaging and transcatheter therapies, we can treat complex valve conditions even in patients above 70 years, improving quality of life while reducing hospital stay and recovery time." The patient is now stable and recovering well, with marked improvement in breathing and daily activity levels.

Doctors said such team-based, minimally invasive interventions are increasingly transforming outcomes for elderly and high-risk cardiac patients. The hospital management was acknowledged for supporting advanced cardiac care services closer to home.

SC asks ex-TDB secretary to appear before SIT for interrogation in Sabarimala gold-loss case

NEW DELHI: The Supreme Court on Wednesday directed a former Travancore Devaswom Board (TDB) secretary to appear before the Special Investigation Team (SIT) probing the Sabarimala gold-loss case as it extended her anticipatory bail period. A bench of Justices Dipankar Datta and S C Sharma extended the protection from arrest granted to former TDB secretary S Jayasree and asked her to appear before the investigating officer of the case.

"Having regard to the contents of paragraph 16 of the counter-affidavit of the respondent-State of Kerala, we direct the petitioner to appear before the investigating officer on February 18, 2026, at 12 noon once again for further interrogation. Interim protection, granted earlier, shall continue till the next date of hearing," the court said.

It directed the matter to be listed on February 20.

On December 18, 2025, the top court, while granting protection from arrest to Jayasree considering her health condition, directed her to appear before the investigating officer on January 8-9. Jayasree, who is the



fourth accused in the case related to the loss of gold from Dwarapalaka (guardian deity) plates, was the TDB secretary in 2019. The allegation against Jayasree is that following her order, the gold-clad copper plates of the Dwarapalaka idols were handed over to prime accused Unnikrishnan Potty for re-plating in 2019. However, Jayasree has claimed that she had issued the order based on a decision taken by the board. The former TDB secretary had maintained that she had not taken any independent decision on handing over the Dwarapalaka plates or the Sreekoil (sanctum sanctorum) doorframe plates and that she had acted in accordance with the board's directions. The SIT, constituted in accordance with the Kerala High Court's directions, is probing two cases related to the gold-loss incident and has arrested 10 people so far.

When Universities Become Sites of Silent Repression

Recent developments at the Indian Institute of Technology (IIT) Delhi, including protests directed at philosopher Divya Dwivedi, have brought into sharp focus a question Indian universities have been quietly postponing: what happens to disagreement when institutions stop treating it as an intellectual matter and begin managing it as a problem of order? The issue at stake is not the correctness of any one scholar's arguments, nor the intent of those who oppose them.

It is the growing tendency for universities to respond to contested ideas not through debate, critique, or counter-argument, but through procedural escalation, reputational anxiety, and administrative intervention. When philosophical disagreement over caste, feminism, or political thought is shifted from classrooms and seminars into committees and complaints, something fundamental changes in how democratic institutions relate to dissent. This is not an argument about individual guilt, intent, or the correctness of any particular scholarly position. Nor is it a defence of one person's views. It is an attempt to understand a broader institutional shift, one in which disagreement increasingly migrates from the domain of intellectual engagement into the terrain of discipline, procedure, and risk management. What that shift reveals is less about ideology than about the condition of democratic institutions today.

India continues to describe itself as a democracy committed to free expression. Constitutional guarantees remain intact, courts periodically reaffirm them, and censorship is officially disavowed. Yet writers, journalists, academics, and students continue to experience forms of silencing. Not through mass bans or explicit prohibitions, but through slower, more diffuse mechanisms that make speech costly, uncertain, and professionally risky. Episodes like the one at IIT Delhi are not aberrations. They are symptoms of this wider transformation. Censorship in contemporary India rarely announces itself. It does not arrive as a ban on books or a formal prohibition on speech. Instead, it operates through procedure. Through complaints, inquiries, notices, and committees. Through reputational anxiety and institutional caution. Through the quiet reclassification of disagreement as disruption, and critique as liability. At IIT Delhi, this logic has been visible in the way philosophical disagreement has been shifted out of the space of intellectual contestation and into administrative terrain. Work on caste, feminism, and political philosophy has been framed not simply as scholarship open to critique, but as material requiring institutional response. The question subtly changes from whether arguments are persuasive to whether they should circulate without consequence. This shift matters because it alters how disagreement is resolved. Not through argument, but through management. This is how democratic censorship often works today. It does not silence by decree. It silences by changing the costs of speaking.

The same pattern can be seen across India's public life. Journalists face legal harassment, access denial, strategic litigation, and economic pressure. Poets and writers encounter criminal cases, forced withdrawals, and sustained intimidation. Academics increasingly operate under reputational and political constraint rather than intellectual autonomy. Speech remains legally permissible, but institutionally hazardous. Universities occupy a particularly revealing position within this landscape. They are meant to be spaces where disagreement is not only tolerated but constitutive. Yet increasingly, they resemble risk management institutions. Administrations must navigate donor expectations, government scrutiny, media attention, and social media outrage. In this environment, caution becomes a rational strategy. Silence begins to look like responsibility.

What has unfolded at IIT Delhi echoes developments at other institutions. At Ashoka University, political controversy around faculty research and public commentary has led to administrative distancing, resignations, and faculty protests over academic freedom. Even when courts intervene to protect scholars, the broader signal remains clear. Think carefully. Speak cautiously. Know the limits.

Public universities face an additional constraint. As state institutions, they are tasked with producing critical knowledge while remaining subject to intense political oversight. Faculty learn, often implicitly, that dissent can be reframed as indiscipline, critique construed as misconduct, and disagreement converted into administrative procedure. Universities do not ban ideas outright.

India's New Ambitions On Trade Must Be Paired With Domestic Reform



Trade deals with the United States and European Union in the last two weeks have underscored India's newfound confidence toward global trade. While the agreement with the United States was negotiated under duress, it is consistent with India's recent trade policy, which has shifted away from protectionism to focus on domestic support programs and trade deals. But more hard work lies ahead. For the United States and India to realise the potential of this burgeoning commercial relationship, domestic reforms must be prioritised at all levels of government in India. Prime Minister Narendra Modi's government took office in 2014. Due to India's goods trade imbalances and the need to create low-skilled employment, the government kicked off the "Make in India" campaign with a goal of increasing manufacturing as a percentage of GDP from 15% to 25% by 2024. The toolkit to support the campaign consisted of a mix of protectionism, domestic reforms, and a global push to attract multinational manufacturers. The target year came and went, and the manufacturing-to-GDP ratio actually

declined slightly. The Union government had pushed ahead with key reforms such as creating the national Goods and Services Tax, relaxing foreign direct investment restrictions, pursuing labour deregulation, and implementing sectoral reforms in areas like hydrocarbon exploration. However, nascent attempts to push states to improve their local business environments - like the erstwhile "Business Reforms Action Plan," which ranked states' business environments - have faltered. But about midway through the government's second term, there was a noticeable shift in its approach to trade. Successive Union budgets tended to have more tariff reductions than increases. The government began to promote domestic support programs for manufacturers called "Production Linked Incentives" programs. And India began to aggressively pursue trade agreements, finalising six agreements in a little over three years. The free trade agreement with the European Union had been in the works for nearly 20 years, though a

formal "restart" was announced in 2022 after a long pause in talks. Talks on a bilateral trade agreement with the United States were formally announced as part of the February 2025 United States-India Joint Leaders Statement after the White House summit. India understandably will keep import restrictions on some products, notably the staple grains that are critical to hundreds of millions of small farmers. But in other sectors, India has shown a willingness to cut tariffs deeply. The government recognises that, despite aspirations (and some success) in attracting technology investments, the country's immediate potential strength is in labour-intensive sectors. While concrete details on the tariff-and-timeline elements of the U.S.-India interim agreement are not yet available, India has staggered tariff cuts over different periods of time. This presents real urgency to Indian policymakers. Yielding the full benefits of these agreements will require recommitting to the difficult domestic policy reforms that investors require, such as transparent land acquisition, increased labour flexibility, improvements in

electric power pricing and reliability, and faster resolution of disputes. Most of this agenda lies not in Delhi, but instead with India's 28 state governments. State governments, for their part, have tended to focus investment policy on crafting sector-specific incentive programs such as an "electronics policy," "data centre policy," "green hydrogen policy," or "electric mobility policy." In recent years, most of these sectoral policies have focused on capital-intensive industries, the strength areas of India's partners in these new trade agreements. Relatively few states have been willing to do the hard work of improving the general business operations for land, labour, and capital. Improved commercial ties between the United States and India will allow the two countries to continue to "grow together" well into the future. The interim agreement is a critical step toward reducing tensions and improving trade policy stability. The harder work now begins, at least in India. This burden of policy improvement must be shouldered from Bombay to Bhubaneswar, from Chennai to Kolkata, and from Patna to Panaji.

If you were on tenterhooks about whether the India vs Pakistan match in the ongoing T20 World Cup would happen or not, let the final outcome of a 10-day (forced) impasse serve as a lesson - nothing barring a genuine act of God (including wars) can derail "the mother of all cricket battles". There is just too much at stake. Period. This match was never in any serious danger of being called off. There is just too much riding on it - for all the stakeholders of the international cricket ecosystem. As former ICC CFO Faisal Hasnain said, an India-Pakistan match is "not just another game of cricket; it is one of the commercial backbones of an ICC event".

Why Pak Did What It Did

What then were the real motivations behind Pakistan's stance to boycott the match against India, despite it being played at a neutral venue (Colombo)? And also, who are the real winners and losers at the end of a period of drama that unfortunately distracted all of us from the on-field action at the World Cup, which is dishing out quite a few exciting contests, thanks largely to the minnows playing some exceptional cricket. The thing is, no one either won or lost fully. To understand this, one must first keep two things in mind.

The first - just how lucrative an India vs Pakistan cricket match at an ICC event is. A single ICC game between the two neighbours generates anywhere between Rs 2,200 and Rs 4,500 crore in total, including broadcast, sponsorship, ticketing, etc., in-stadia ads, corporate boxes, merchandise, among other things. In other words, if the match doesn't happen, the key stakeholders could end up losing a

mind-boggling amount of money. If an ICC match is cancelled before it begins, the face value of the ticket purchased is refunded, as per ICC policy. According to reports, Indian host broadcaster JioStar could have lost up to Rs 250 crore in advertisement revenue. Just 10-second prime time ad slots for this clash can be as expensive as USD 50,000. The second factor is this: after the ouster of Sheikh Hasina from Bangladesh and the once strong ties between India and Bangladesh becoming strained, Pakistan had extra motivation to back Bangladesh politically, and cricket became a pawn in this game.

How Bangladesh Benefited

I had written earlier about how the "money-spinning" superpower of an India-Pakistan ICC tournament match is what Pakistan is trying to hold hostage and use as leverage to back Bangladesh, at a time when it is politically perfectly suitable for them to forge an alliance. One wouldn't be surprised if it was on Pakistan's insistence that Bangladesh demanded that

all their matches be shifted from India to Sri Lanka. At the January 21 ICC virtual Board meeting, the cricket boards of the two countries were the only two bodies that voted in favour of Bangladesh playing their games in Sri Lanka. Which is why when the ICC adopted a hardline stance against the Bangladesh Cricket Board (BCB), first refusing to give in to their demand (for which there was no legitimate reason, as more than one security assessment showed) and second expelling them from the World Cup and replacing them with Scotland, Bangladesh were suddenly the big losers in all of this. They were not going to get their participation fees, nor any prize money, had risked a \$2 million ICC fine as per the member participation agreement (MPA) and were in danger of losing their share of the ICC's annual revenue share, not to mention having jeopardised all future bilateral cricket with India and even possible legal action by the ICC for breach of contract (as per the Members Participation Agreement, or MPA).

Bangladesh Polls: How Yunus' Fate Will Also Decide The Country's Fate

Plus ça change, plus c'est la même chose: The more things change, the more they stay the same, is an apt description of the mood in Bangladesh on the eve of the elections due on February 12. The masks have fallen, one by one. The events of July-August 2024 that led to Prime Minister Sheikh Hasina's ouster - a movement once touted as a "spontaneous students' uprising" - are now recognised as the most recent among regime change operations that Bangladesh has witnessed, such as in 1975 (following the assassination of Bangabandhu Sheikh Mujibur Rahman) and in 1981 (after the assassination of Zia-ur-Rahman). How Sheikh Hasina escaped with her life is another episode altogether. The 13th national parliamentary elections are being hailed as 'different', quite distinct from those organised by Sheikh Hasina's government, most recently in 2024. The Yunus-led interim regime has banned the activities of the Awami League, barring them from participation in the forthcoming elections. By definition, this decision to ban the single largest political party in Bangladesh, with a steady vote share of 35-40%, has rendered the forthcoming elections non-inclusive and non-participatory. Such elections can hardly be described as credible since they flout the basic tenets of democracy. Bangladesh's second-largest political party, the BNP (Bangladesh Nationalist Party, presently led by Tarique Rahman, son of Begum Khaleda Zia), was never banned by the Awami League. The BNP made a deliberate choice not to participate in the 2024 elections. The Wind Blows Many Ways The national opinion survey conducted by Bangladesh's leading vernacular daily, Prothom Alo, in October 2025, published on December 9 that year, revealed that close to 70% of those surveyed want the Awami League to participate in these elections, conditionally or unconditionally. Twenty-eight per cent said they did not want the Awami League to participate in the elections. However, in terms of likely vote share, the survey revealed that close to



66% would vote for the BNP, and nearly 26% would vote for Jamaat-e-Islami, with only 7.2% voting for the Awami League. It is not a coincidence that the vote share of the Jamaat-e-Islami (JeI) and the percentage of those who do not want the Awami League's participation is approximately the same. The Jamaat-e-Islami has been the de facto ruler of Bangladesh for the last 18 months, with Mohammed Yunus as their willing spokesperson. Their prime interest is to transform this into a de jure control through the February 12 elections. Is this possible? Using tactics like mobocracy and street riots, accompanied by the most brutal and horrendous violence, the JeI has forced the resignations of the entire senior judiciary, as well as key bureaucrats, university vice chancellors and any academician whose political views or affiliations were considered unacceptable. The attacks on religious minorities (Hindus, Buddhists, Christians, Sufis and Ahmaddiyas) follow the same pattern, and have continued unabated, bringing these communities to their knees, even as such attacks are described - even justified - as 'political' and 'non-communal' in nature. The media has similarly been brought under control through board-room takeovers, large-scale dismissals of 'inconvenient' journalists, and even imprisonment (including on murder charges) for scores of media personnel. As the traditional democracies of the West watch on in

mute acquiescence, the JeI has acquired strong control over the levers of power, sabotaging every institution of democracy. The victory of the JeI's youth wing, the Islami Chhatra Shibir, in all the students' union elections held so far (Dhaka University, Jahangirnagar University, Jagannath University) signals strong control over students' bodies, pushing away both BNP and the recently formed NCP (National Citizen's Party, comprising the students' who were active in last year's events and dubbed the 'King's party' for its affiliation with Yunus). Notably, a recent article in The Washington Post reporting the transcript of an American diplomat's conversation seems to signal the US's support for the JeI. The 'Undecided' Ones On January 13 this year, Prothom Alo published the results of the December 2025 poll survey conducted by four organisations, covering all 64 districts of Bangladesh. This survey indicates a sharp increase in the support for JeI, now running neck-to-neck with the BNP. The results brought out that "over 34 per cent of voters intended to vote for the BNP, while over 33 per cent intend to vote for the Jamaat". The NCP, which has now joined the JeI's 11-party alliance, is shown as receiving a little over 7% of the vote share, while the Islami Andolan Bangladesh, which supports the declaration of Sharia law in Bangladesh, is reported as receiving over 3% of the vote share.

New Delhi: Deputy Chief Minister of Karnataka D.K. Shivakumar on Wednesday asserted that the Congress party laid the foundation for the independence movement, the national flag, the national anthem, the Constitution, and Vande Mataram.



Speaking to reporters at Karnataka Bhawan in New Delhi, Shivakumar said, "Ours is a party which got independence and served the country. The BJP is following our footsteps now, and we are happy about it."

When asked about the new regulations making Vande Mataram mandatory before the national anthem, the DCM said, "We sing Vande Mataram before starting any of our programmes. We respect that and follow it."

Congress government's role in adopting the state song. "During S.M. Krishna's time, we made Kuvempu's Jaya Bharatha Jananiya Tanujate the state song. The song talks about a garden of peace for all faiths. It represents everyone—including Hindus, Christians, and Muslims. We come from such a land," he said.

Asked about his brother and Congress MP D.K. Suresh's comment that Chief Minister Siddaramaiah would keep his word even if there is a delay, Shivakumar said, "I have said that time will answer. I have also said that only we know what we have discussed."

When pressed further on when "time will answer," he quipped, "I will tell you at an appropriate time."

Deve Gowda Proposes Bengaluru-Mangaluru Industrial Corridor in Rajya Sabha

New Delhi: Former Prime Minister and Rajya Sabha MP H.D. Deve Gowda on Wednesday proposed extending the industrial corridor from Bengaluru to Mangaluru to connect three major ports and accelerate industrial growth in the region.



Participating in the debate on the Union Budget 2026-27, Deve Gowda welcomed the budget presented by Finance Minister Nirmala Sitharaman, describing it as conducive to the nation's holistic development. He, however, put forward two key suggestions. "I welcome the government's decision to approve industrial corridor projects linking key ports between Chennai and Bengaluru, and Hyderabad and Bengaluru. Similarly, if this industrial corridor is extended from Bengaluru to

jamun—on the lines of the Makhana Board—to promote these three crops widely cultivated in Karnataka, Tamil Nadu, Kerala, and other southern states.

Two metal idols wrapped in gunny bags were found inside the vehicle. The occupants failed to produce any documents to establish ownership.

Vedanta seeks panel to study Sterlite green copper plant proposal, MHC seeks responses from TN govt, TNPCB

The government had ordered the closure of the copper plant in 2018, citing air, water and land pollution. The matter took a devastating turn after 13 people, most of them protesters, were killed when the police opened fire.

CHENNAI: The Madras High Court directed the State government and the Tamil Nadu Pollution Control Board (TNPCB) to file their responses to a petition filed by Vedanta challenging the government's order refusing permission to set up a green copper manufacturing plant at the Sterlite unit premises in Thoothukudi.



The government had ordered the closure of the copper plant in 2018, citing air, water and land pollution. The matter took a devastating turn after 13 people, most of them protesters, were killed when the police opened fire. Later, when Vedanta, which owns Sterlite cop-

per unit, challenged the government order, it was dismissed by the Madras High Court in 2020, which was upheld by the Supreme Court subsequently. On January 9, Vedanta submitted an application to the State seeking permission to establish a

green copper manufacturing unit at the premises. It submitted several research and technical reports on green copper production to press its case, but the government rejected the plea through an order dated January 27. Challenging this,

Vedanta approached the High Court seeking to quash the order and to direct the constitution of a multidisciplinary expert committee monitored by the court. As per its proposal, the committee should have officials from TNPCB, the Ministries of Environment and Forest and Mines, and Central Pollution Control board (CPCB), and other technical experts to conduct a detailed study on the feasibility of establishing the green copper plant. The company also sought a direction to the government to take appropriate decisions based on the report submitted by the expert committee.

Madras HC seeks TNPCB response on Vedanta's Green Copper proposal, TN Govt's stand on forming expert panel

Chennai, Feb 11 (UNI) The Madras High Court on Wednesday directed the Tamil Nadu Pollution Control Board (TNPCB) and other respondents to file their replies on a writ petition filed by Vedanta Limited challenging the rejection of its application for a proposed Green Copper facility at the Sterlite premises in the southern Thoothukudi districts and the Tamil Nadu government's stand to form an expert committee to study the proposal.

Copper initiative, as presented before the Court, is designed as a transformative hybrid production model integrating 70% primary copper production with 30% recycled copper usage.

The Ministry of Mines to undertake a detailed technical assessment.

The First Bench comprising Chief Justice Manindra Mohan Shrivastava and Justice Arul Murugan, hearing the Vedanta's plea challenging the TNPCB's rejection of its application for 'Consent to Operate' (CTO) sought to know the State government's stand on constituting an expert committee to study the proposal. As the TNPCB refused to issue a CTO to the multinational business conglomerate for establishing the 'Green Copper' plant on the Thoothukudi Sterlite plant premises, which has remained non-functional since 2018, the company has, knocked the doors of the High Court with a plea to quash the rejection order.

Vedanta submitted an application to the TNPCB on January 9, seeking the CTO, but the Board rejected it on January 27. The First Bench directed Additional Advocate General (AAG) J. Ravindran to get instructions by February 26 regarding the constitution of an expert committee to study the possibility of permitting the 'Green Copper' facility. Senior Counsel Satish Parasaran, appearing for Vedanta, argued that the rejection failed to take into account the fundamental differences between the earlier smelting operations and the newly proposed Green Copper project. He submitted that the application was rejected "mechanically," without a scientific or technical evaluation of the new proposal.

There need to be an opportunity to explain the benefits of Green Copper and how it is sustainable. The Green



Opposing the petition, Additional Advocate General J. Ravindran, appearing for the State, contended that there is no difference in the earlier process as compared to the proposed process of Green Copper and this Court has appointed an expert committee for remediation process in the other litigation which is still pending. After hearing preliminary submissions from both sides, the Bench adjourned the matter to enable the respondents to file their written replies, including on the question of why the proposal was rejected without a hearing.

Cosmic Drama: A giant star is changing as astronomers watch in real time

NEW YORK: For decades, astronomers have been observing WOH G64, a massive star in the Large Magellanic Cloud, a galaxy visible to the naked eye from the Southern Hemisphere.

an ordinary red giant. Later, in the 1980s, data from the InfraRed Astronomical Satellite revealed it to be the most luminous, coolest and dustiest red supergiant in the Large Magellanic Cloud, which contains more than a thousand such stars. Observations over the following decades showed steady brightness variations typical of pulsating red supergiants. In 2024, astronomers captured an unprecedented close-up image of WOH G64 using telescopes of the European Southern Observatory. The image revealed a fresh dust cloud close to the star, the sharp-

est picture of a star in another galaxy ever taken. Scientists found that the star had begun ejecting significantly more dust in the past decade, though the cause remained unclear. During the same period, the star dimmed, possibly due to the dust cloud, and its pulsations slowed slightly while becoming faster in rhythm, indicating that it may have shrunk. The star also appeared warmer, leading to speculation that it might have entered a new evolutionary stage called a yellow hypergiant. Recent observations using SALT have provided further clues. The data

showed strong presence of ions near the star, indicating very hot gas. At the same time, astronomers detected molecular signatures that indicate cooler gas within the star's atmosphere. These findings suggest that WOH G64 has not yet transitioned into a yellow hypergiant. Astronomers have long suspected that the red supergiant may have a smaller, hotter companion star. The hotter star could be heating gas captured from the red supergiant's wind, making the heated gas more visible as the larger star fades. If the companion star moves farther away again, WOH G64 might regain some of its earlier characteristics. Alternatively, it may shed its outer layers entirely, removing dust and revealing its inner structure. The star could also behave in entirely unexpected ways, reminding astronomers that stellar evolution still holds many mysteries.

Russia allows Indian labourers in bulk due to labour shortage, Ukraine war

Moscow: While it is not new that Indians work as labourers in foreign countries, Reuters reported that Russia has eased the visa process for Indians in bulk to keep up with its acute labour shortage, partly due to the ongoing war in Ukraine. The report painted a picture of the situation, with a group of unsure-looking Indian men at the passport control line in Moscow airport carrying sports bags as their only luggage, who flew over 4,000 km to get a job.



"I have a contract for one year. In the rubbish disposal business. The money is good," one of the men, Ajit, told the news outlet. According to authorities, there is an immediate shortage of at least 2.3 million workers, a phenomenon further intensified due to the Russia-Ukraine war.

Major surge in Indian workers cleared to work in Moscow

Traditionally, Russia relied on its neighbouring countries like Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan and Kazakhstan in Central Asia for foreign labour. However, with the war-ravaged scene, labourers from Central Asia are no longer enough, forcing

Russia to look for new sources.

A year before Russia sent its military into Ukraine, in 2021, around 5,000 work permits were granted for Indian nationals. In 2025, 72,000 permits were estimated to be approved for Indians, which is almost a third of the total number of migrant workers on visas allowed annually.

Alexei Filipenkov, director of one such company that draws in Indian workers, said labourers from the ex-Soviet Central Asia stopped coming in adequate numbers.

Central Asians generally do not need a visa to enter Russia, but starting June

2025, Russia introduced a pre-entry requirement, imposing visa-like restrictions.

"Currently, expatriate employees from India are the most popular," he said, adding that official data shows that Central Asians still contribute to the majority of the 2.3 million foreign workers allowed without a visa in 2025.

Unskilled labour from India points to strong ties between the two countries

A weaker rouble, anti-immigrant discourse within Russian politicians and stricter migration laws have likely diminished their fig-

ures, instead encouraging Moscow to increase visa quotas for other foreign workers.

Russia's choice of India as an alternative for unskilled labour reflects more deeply rooted ties between Moscow and New Delhi. India is known to buy cheaper Russian oil that Moscow cannot readily sell because of Western sanctions, but with the new India-US bilateral trade agreement, the deal remains questionable. In December 2025, Prime Minister Narendra Modi and Russian President Vladimir Putin signed a deal, essentially making it easier for Indians to be employed in

Russia. During the signing, Russia's First Deputy Prime Minister, Denis Manturov, said the country can accept an "unlimited number" of Indian labourers. He said as many as 8,00,000 workers were required in manufacturing and 1.5 million in the construction and service sector.

Indians put to work at farms and factories

A Russian textiles company called Brera Intex reportedly hired at least 10 workers from South Asia to make bed sheets and curtains.

A 26-year-old Indian migrant worker, Gaurav said he has been working in Russia for three months now. "I was told to come (over) to this side, that the work and money are good," he told Reuters.

"Russian life is very good," he said, adding that he talks to his wife and two children back home in India on call every day.

The company's owner, Olga Lugovskaya, said the workers adapted to the work fairly quickly and were in good spirits. "Some of the guys who came in didn't even know how to switch on a sewing machine," she said. "(But) after two or three months.

crop - Kharif, Rabi and Summer, is grown in warm, humid and water-logged conditions making it ideal for pest attacks throughout the year. In the early critical stage, i.e. vegetative stage during 15-30 DAT, Stem Borer damages the plant and makes it difficult for farmers to detect early.

Later at reproductive stage during 40-60 DAT, both Stem Borer and Leaf Folder attack the plant. Leaf Folder feeds on the leaf tissue by folding the leaves thereby reducing the plant's photosynthetic area and hence crop growth. It is at these stages that TAKAI should be applied at a dose of 160 ml when the crop is 15-30 days old and again at 40-60 DAT.

GROWING DEMAND for Used Cars in Hyderabad Fuels Higher Sales for Cars24



Canada mourns with you, tearful PM Carney tells community where nine killed in shootings

The only thing on Prime Minister Mark Carney's itinerary today, according to his office, is a meeting with MPs at 10:00 local time (15:00 GMT). The rest of the prime minister's previously announced schedule has been suspended "in light of Tuesday's tragic events in Tumbler Ridge", according to a statement. We learnt earlier how the PM had suspended his planned trip to Germany for the Munich Security Conference, which begins on Friday. The conference hosts more than 60 heads of state and government, and covers issues from AI to support for Ukraine. Prime Minister Mark Carney has just arrived at Parliament Hill in Ottawa, where he tells reporters it is a "difficult day" for Tumbler Ridge and Canada. "Parents and grandparents, sisters and brothers in Tumbler Ridge will wake up without someone they love," Carney says. "The nation mourns with you. Canada stands by



you." Carney thanks emergency services and world leaders who have reached out to him in solidarity - including King Charles III, who is Canada's head of state. The PM then says he has instructed that flags across all government buildings are to be flown at half mast for the next week. "We will get through this," Carney continues. "But right now it is a

time to come together, like Canadians do in these terrible situations. To support each other, to mourn together and to grow together." As we've been reporting, nine people have been killed in a shooting attack in Tumbler Ridge, British Columbia. For the moment, there are certain details which haven't yet been made public - including the identities of the suspect

and victims. Here's a reminder of the facts that have been shared by police so far: At approximately 13:20 local time (20:20 GMT), the Royal Canadian Mounted Police received a report of an active shooter at a secondary school in the area. Attending the scene, officers found the bodies of six victims - as well as the body of a suspect which had sustained a self-

inflicted injury. A seventh victim died on the way to hospital while two further victims were found at a nearby residence. More than 20 others were injured during the attack - two were transported to hospital with serious or life-threatening injuries. At 17:45 local time a Police Initiated Public Alert was cancelled - as authorities believed there was no further suspects. Following the statement from King Charles III, we can now bring you a message shared by the Prince and Princess of Wales. In a post on social media, they say they "stand with all Canadians" following the shootings that took place in Tumbler Ridge. "Our hearts are with the entire Tumbler Ridge community, and we extend our deepest condolences to the families and friends affected by this devastating loss. "We are so thankful for the courage shown by the students, staff, and emergency responders who acted with selflessness in the face

of such violence." King Charles III has expressed his profound "shock and sadness" at the "senseless act of brutal violence" in British Columbia, western Canada. In a message posted to Instagram, the King - who is Canada's head of state - says: "My wife and I were profoundly shocked and saddened to learn of the most dreadful attack at Tumbler Ridge Secondary School in British Columbia. "We can only express our deepest sympathy to the families who are grieving the unimaginable loss of their loved ones and those still awaiting news from hospital. In such a closely connected town, every child's name will be a neighbour. "We can only begin to imagine the appalling shadow that has now descended across Tumbler Ridge and our hearts go out to all those whose lives have been so shattered by this senseless act of brutal violence.

TUMBLER RIDGE MASS SHOOTING



Canadian police say nine people have been killed in a mass shooting at a school and home in the remote rural community of Tumbler Ridge in the western province of British Columbia. Another 25 people were injured, and the suspect's body was also found at the scene. This is what we know so far about one of the deadliest gun attacks in Canada's history. When did the attack start? The Royal Canadian Mounted Police (RCMP) said they received a report of an active shooter at Tumbler Ridge Secondary School at 13:20 local time on Tuesday (20:20 GMT). The police responded by deploying officers to the

scene, and issuing an active shooter alert for the rural community and a surrounding area. "Shelter in place, lock your doors and refrain from leaving your home or business at this time" local residents were told. A "hold and secure" lockdown was activated at Tumbler Ridge Secondary School and nearby Tumbler Ridge Elementary School. British Columbia's Minister of Public Safety and Solicitor General Nina Krieger said police officers arrived at Tumbler Ridge Secondary school "within two minutes" of receiving the call of an active shooting. She said such a swift response "no doubt" saved lives.

RUSSIAN STRIKES NEAR KHARKIV KILL FOUR, INCLUDING CHILDREN, UKRAINE SAYS



Overnight Russian air strikes have killed at least four people, including three young children in Ukraine's north-eastern Kharkiv region, local officials have said. Regional head Oleh Synegubov said two boys, both aged two, a one-year-old girl and a 34-year-old man died after a drone hit their house in the town of Bohodukhiv. A 35-year-old pregnant woman and another woman, 73, were injured during the strike on the town, Synegubov said. The Russian aerial attack comes as Moscow renews strikes after a week-long pause that Donald Trump had asked Vladimir Putin to observe as a fierce cold swept Ukraine. Bohodukhiv, north-west of Ukraine's second largest city of Kharkiv, has been under almost daily Russian attack in recent days. On Monday, a 41-year-old woman and a 10-year-old boy were killed in the town, Synegubov said. Russian forces also dropped seven bombs on the city of Slovyansk on Tuesday, Donetsk regional head Vadym Filashkin said on Telegram. Three people, including an 11-year-old girl, were killed. Moscow has

increased pressure on the area by targeting transport and energy infrastructure with a record number of ballistic missiles, Ukrainian President Volodymyr Zelensky has said. A state of emergency has been declared over the energy situation in the Kharkiv region by local authorities. It comes after a so-called "energy truce", which was meant to allow Ukraine's energy sector a reprieve during -20C (-4F) temperatures, expired last week. Tens of thousands of people across Ukraine are experiencing severe power cuts, and many households have no running water or heating. Zelensky has said the US wants the war with Russia to end by June, and that both sides had been invited to the US for talks next week. Meanwhile, a massive attack by Ukrainian drones on Volgograd region in Russia, was reported on Wednesday night. Regional Governor Andrei Bocharov said an apartment was damaged in the strike and a fire broke out at a factory. Russia launched a full-scale invasion of Ukraine in February 2022.

POLICE RELEASE MAN DETAINED IN CONNECTION TO NANCY GUTHRIE DISAPPEARANCE

Police have released a man hours after they detained him in connection to the disappearance of Nancy Guthrie, the mother of US news anchor Savannah Guthrie, CBS News, the BBC's US partner, has reported. After taking the man into custody at a traffic stop, police searched his home in Rio Rico, south of Tucson, Arizona, sources familiar with the investigation told CBS News. After his release, the man, identified only as Carlos, told reporters outside his home that he did not know who Nancy Guthrie was. "I don't follow the news," he said. Guthrie, 84, was abducted from her home near Tucson more than a week ago, sparking a widespread search and desperate appeals from her family. "I

hope they get the suspect, because I'm not it," Carlos said, according to a video posted on X by CBS reporter Andres Gutierrez. Carlos, reportedly a deliveryman, said he had been driving around and noticed authorities were following him. He added that the officers did not ask him any questions and made him wait for hours in a car park. A woman who identified herself as his mother-in-law earlier said that he had nothing to do with the case. "They're just invading my property," she was quoted as saying by CBS. The Pima County Sheriff's Department had confirmed police were conducting a court-authorized search at a location in Rio Rico, south of Tucson, Arizona.

US LAWMAKERS TELLS ANDREW SHOULD TESTIFY OVER EPSTEIN FILES

Andrew Mountbatten-Windsor is facing growing pressure from US officials and the family of his prominent accuser Virginia Giuffre to testify in the US about his links to paedophile financier Jeffrey Epstein. Speaking to the BBC, Democratic Congressman Ro Khanna said the Royal Family had "not been transparent", while Democratic Congresswoman Teresa Leger Fernandez said King Charles III "should direct his brother" to go to the US to answer questions. On Monday, the King said the Royal Family were "ready to support" police in their inquiries. Andrew has repeatedly denied any wrongdoing and reached an out-of-court settlement with Giuffre in 2022 con-



taining no admission of liability. In the King's first intervention in the latest round of revelations in the Epstein scandal, a Buckingham Palace spokesperson said if they were approached by the police, they stood "ready to support them" in their investigation. It added the King had "made clear...his profound concern" over allegations against his

shared confidential information with Epstein from his official work as trade envoy in 2010 and 2011, according to material in the latest release of files seen by the BBC. Andrew has been contacted for comment but is yet to respond. When asked by the BBC if the former prince should go to the US, Khanna said that would be "appropriate". The Congressman, who co-sponsored the law that compelled the justice department to release the Epstein files last year, also said the Royal Family should "come clean" and lay out what they knew and what "action they're going to take". "They have a large wealth, they should probably be compensating these survivors for the horrors that have taken place.

Swiss bar owners face questions from victims' lawyers over fire disaster

Swiss bar owner Jacques Moretti was questioned by lawyers acting for victims' families on Wednesday, over the New Year's Day fire disaster in Crans-Montana that left 41 people dead and 115 injured. He arrived for the hearing in Sion with his wife, Jessica, whose lawyer Yaël Hayat described the latest hearings as "moments of truth". Jessica Moretti faces questions on Thursday. Ahead of the hearing, one mother told Swiss TV she needed to know what had gone wrong and why. "What's important is that the whole truth comes out," said Laetitia Brodard-Sitre, whose 16-year-old son Arthur died in the fire.



"There must be no more lies," she told public broadcaster SRF. "I want everyone to take responsibility; politics and parties don't matter to me." Jacques and Jessica Moretti are under criminal investigation for involuntary manslaughter, as well as bodily harm and arson through negligence. Neither

is being held in custody; Mr Moretti was released on bail last month. His wife's lawyer told French radio the couple had made clear from the outset that neither was trying to shirk justice for their part in the tragedy at Le Constellation bar in the popular Swiss ski resort of Crans-Montana. US reopens airspace over Texas border town after 'drone incursion'



The US Department of Defense "took action" to disable drones that it said were part of an incursion over El Paso, Texas, which sits on the border with Mexico, and has lifted its order to shut down the area's airspace for 10 days. "The threat has been neutralized, and there is no danger to commercial travel in the region," Transportation Secretary Sean Duffy posted on X. The Federal Aviation Administration (FAA) on Tuesday night suddenly ordered flights in and out of the El Paso International Airport to be halted until 20 February, causing shock and confusion among local residents and elected leaders. The agency said on Wednesday morning restrictions had been lifted and flights could resume. City Council member Chris Canales, who represents an area on the southwestern side of El Paso, told the BBC that local authorities did not receive any advance notice or reason for the closure. Long-term airspace closures are rare. Since 2018 the FAA has cut airspace closures from an average of more than four hours per launch to just more than two hours, according to its

web site. The restriction covered a 10-mile radius around El Paso, including parts of southern New Mexico, west of the town San Teresa. After the initial closure, El Paso International Airport said in a statement it was told "on short notice" to halt all flights and contacted the FAA for more information. "The notice was published without any advance notice to local governments or to local air traffic controllers," Canales said. "There are some folks who are panicking a bit because of how highly unusual this is, and if you look at El Paso on the map you can see what unique geographical position it is," he added. The cancellations were so abrupt that people reported being told by airlines that their flights were still scheduled, even after the FAA's announcement. "Just called (United Airlines) about my flight this morning and they said it's still scheduled to leave???" one woman commented on Instagram early Wednesday. Some on social media speculated about broader conspiracy theories and wondered if the US was on the brink of war.

Netanyahu to meet Trump as Iran nuclear talks reach critical stage

President Donald Trump will host Israeli Prime Minister Benjamin Netanyahu at the White House on Wednesday, as tensions continue to rise across the Middle East and negotiations intensify over curbing Iran's nuclear weapons programme. Netanyahu is expected to press Trump to pursue a deal that would not only halt Iran's uranium enrichment, but also cut its ballistic missile programme and support for proxy groups like Hamas and Hezbollah. "I will present to the president our outlook regarding the principles of these negotiations," he said before leaving for the US. Iran has suggested it is ready to limit its nuclear programme in return for sanctions relief, but it has rejected the other demands. Ahead of the White House meeting, Iranian President Masoud

Pezeskian warned that his country would "not yield to their excessive demands". Netanyahu's visit on Wednesday marks his sixth trip to the US since Trump's return to office - more than any other world leader. A close Trump ally, Netanyahu has long argued that Iran represents an existential security threat to Israel and has pushed the US to curb Tehran's influence in the region. "The prime minister believes that any negotiations must include limiting ballistic missiles and ending support for the Iranian axis," Netanyahu's office said in a statement ahead of his trip. After arriving in Washington on Tuesday, Netanyahu met Trump's special envoy Steve Witkoff and son-in-law Jared Kushner. The pair "provided an update on the first round



of negotiations they held with Iran last Friday", according to the prime minister's office. Netanyahu's visit comes as the US increases its military presence in the Middle East, with Trump warning Tehran of strikes if it fails to reach a deal on its nuclear programme and to stop killing protesters. On

Tuesday, the president said that he was "thinking" about sending a second aircraft carrier strike group to the Middle East. The USS Abraham Lincoln carrier strike group was sent to the region last month after Trump threatened to strike Iran to stop a government crackdown on mass protests

in which thousands of people were killed. "We have an armada that is heading there and another one might be going," Trump said in an interview with Axios. He said Iran "wants to make a deal very badly", adding that a diplomatic solution remained possible. Trump told Fox Business that a good deal would mean "no nuclear weapons, no missiles". In a speech at a rally in Tehran on Wednesday marking the 47th anniversary of Iran's Islamic revolution, Pezeskian said: "Our Iran will not yield in the face of aggression, but we are continuing dialogue with all our strength with neighbouring countries in order to establish peace and tranquillity in the region." The Iranian president also reiterated that his country was "not seeking to acquire nuclear weapons".

"We have stated this repeatedly and are ready for any verification," he added. Israeli officials have also said their country reserves the right to take military action against Iran if it does not reach a nuclear agreement with the US. Netanyahu is under pressure from far-right allies in his government to use his ties to Trump to push for a wide-ranging US-Iran deal that meets the Israeli government's security concerns, experts say. "Israel is concerned that in the haste to get a deal with Iran, the president might embrace a deal that doesn't address Iran's missile programme or support for proxy groups, or that allows it to have some remnant of its nuclear programme," said Daniel Byman, a professor at Georgetown University's School of Foreign Service.

Why Frank at Tottenham was a gamble that ended in bitter failure

Thomas Frank's appointment as Tottenham head coach was a gamble by both parties. It was a gamble that failed - ending in a storm of toxicity. Frank left behind the stability and structure that underpinned his superb work at Brentford for the chaos of Spurs. In place of the bedrock of Brentford owner Matthew Benham and director of football Phil Giles, Frank stepped into a high-stakes environment where even winning the Europa League - Spurs' first trophy in 17 years - did not spare predecessor Ange Postecoglou the sack. Spurs, in turn, were employing a head coach who had operated away from the sort of harsh spotlight and high expectations that awaited him in his new job. It was an ill-starred alliance, and Frank quickly found himself out of his depth. This has been a joyless, miserable spell characterised by constant hostility aimed in Frank's direction by the vast majority of Spurs supporters, who



decided very quickly he was not the man for them or the job he was required to do. Frank's dismissal will be a bitter disappointment for the popular, personable Dane, who earned his big opportunity at Spurs by taking Brentford into the Premier League and keeping them there for four seasons. So where did it go wrong? Frank took over a side that finished 17th in the Premier League last season, having lost 22 games in the process. They won the Europa League, but the true measure of a side is

league position - and by that metric, Frank inherited a mediocre squad. The notion this could be fully corrected - or even significantly transformed - in a matter of months is from the realms of fantasy. Spurs not only needed a change in team, but a change in culture. This must be factored into Frank's downfall. The club has struggled to find anyone to match the popularity of Mauricio Pochettino, who was sacked six months after Spurs' defeat by Liverpool in the 2019 Champions League final.

Vaibhav Suryavanshi already has the world at his feet at the age of just 14, and he may have just received the biggest compliment yet. Just days after smashing an incredible 175 off just 80 balls to lead India to the U19 World Cup 2026 title over England, Suryavanshi has been compared to one of cricket's greatest ever. Former England cricketer Mark Butcher likened Suryavanshi's style to legendary West Indies all-rounder Sir Garfield Sobers, highlighting the similarity in their batting. "The first thing that flashed in my head was Gary Sobers. The violence in the bat swing, the timing and the purity of the contact. The hand speed, the way



that he uses his legs on the ground. The way that the bat literally follows through all the way around until it slaps him in the middle of his bat is pure Sobers," said Butcher, speaking on the Wisden Cricket Weekly Podcast.

Sobers is widely regarded as one of cricket's greatest all-rounders. In a career spanning over 20 years, Sobers smashed 26 centuries and averaged nearly 58 in Test cricket. To justify his comparison, Butcher took the example of Sobers'

historic six sixes in an over for Nottinghamshire against Glamorgan, when he became the first batter in professional cricket history to do so. "I would urge people from a different generation who don't have that picture of Sir Gary Sobers in their mind's eye to seek out the video of him hitting the six sixes off Malcolm Nash. And just watch. And I swear to God; it looks exactly the same. He (Suryavanshi) is just astonishing to watch," Butcher explained. 14-year-old Suryavanshi's breathtaking knock saw India win the U19 World Cup final by 100 runs. He took home both the 'Player of the Match' and the 'Player of the Series' awards.

NEW F1 RULES 'RIDICULOUSLY COMPLEX' - HAMILTON



Lewis Hamilton says that the new rules this year make Formula 1 "ridiculously complex" and that "none of the fans are going to understand it". The seven-time champion was referring to the increased degree of energy management required by the new engines, which have a near 50-50 power split between internal combustion engine and electrical components. Briton Hamilton, speaking after driving the Ferrari on the first morning of this week's pre-season test in Bahrain, said: "I sat in a meeting the other day and they're taking us through it. And yeah, it's like you need a degree to fully understand it all." The rules have set up a situation where the engines are energy starved most of the time, and teams and drivers have to maximise the amount of energy recovery they do. This has led to unusual technical strategies and driving techniques. These will include not going flat out exiting a corner before starting a qualifying lap, and backing off on the straights to conserve energy. Regenerative braking, where the motor

recovers energy while slowing for a corner Part-throttle overload, where the battery takes power from the engine in parts of the track where the driver does not need full throttle, such as cornering, where engines may run at high revs when a driver is not on the power Lift and coast - lifting off before corners so the electric motor can run against the engine 'Superclip' - the electronic control unit diverts energy to the battery when the driver is still at full throttle on the straight These are all complicated by the fact that the drivers can operate a 'boost' button for extra power to facilitate an overtake, but then risk being short of power and vulnerable to being re-passed on the following straight. Hamilton said: "If you look at Barcelona, for example, we're doing 600 metres lift and coast on a qualifying lap. That's not what racing is about. Here (in Bahrain), we're not having to do that because there's lots of braking zones." Drivers will also have to use lower gears than they would like to help with energy recovery.

Taking to X, Shukla, who is also a member of the Rajya Sabha, denied making such statements and urged social media users not to circulate similar videos without verifying them. The viral video, which was aired on Pakistani news channel ARY News, falsely suggested that the BCCI pressured Pakistan to play India in the upcoming clash in Colombo. It is a good and amicable solution

The 36-year-old, from County Down in Northern Ireland, became just the sixth man to win each of the sport's four majors - the Masters, US Open, Open Championship and US PGA Championship - in April when he earned a first Green Jacket at Augusta National to complete the career Grand Slam. The Players, held in March at TPC Sawgrass, has long been nicknamed 'the fifth major', and used to boast of the strongest field in golf, although has been without a number of big names since the start of LIV Golf in 2022. Last week, the tournament began a promotional campaign for this year's edition with the tagline 'March is going to be major'. While women's golf already has five majors, McIlroy does not feel the men's game needs to expand its own designation. "Look, I'd love to have seven majors

instead of five, that sounds great," McIlroy said referencing his two previous Players Championships to go alongside his five majors. "I think the Players is one of the best golf tournaments in the world. I don't think anyone disputes that or argues that. I think from a player perspective it's amazing. I think from an on-site fan experience it's amazing. It's an amazing golf course, location, venue. "But I'm a traditionalist, I'm a historian of the game. We have four major championships. If you want to see what five major championships looks like, look at the women's game. I don't know how well that's went for them." McIlroy also called for the US PGA Championship to be moved back to August. His PGA titles in 2012 and 2014 came when the tournament was held in August, but since 2019, it has been staged in May in between the Masters and US Open. When it was the final major of the year, it was branded 'glory's last shot', and McIlroy believes "it needs to go back to August" to regain that identity.
