Man shot, Rs 6 lakh looted



Hyderabad: A man who went to deposit Rs 6 lakh cash at the SBI Main Branch ATM at Koti was shot in the leg before the assailants fled with his cash and scooter during the early hours of Saturday, January 31. Here is what the police investigation has uncovered so far. The victim, identified as Rinshad, is a businessman dealing in readymade kids' clothing from Kozhikode, Kerala. He had come to the city on January 7 and brought Rs 6 lakh in cash to purchase wholesale stock at Dewan Devdi, a release from the Hyderabad City Police read. However, as he was unable to make the purchases, his cousin Mishban advised him to deposit the cash into his bank account. When he reached the SBI Main Branch ATM at Bank Street in Koti at around 7:00 am to deposit the money, two unidentified persons approached him from behind and threatened him by pressing a firearm against his abdomen. The accused fired two rounds, one of which struck Rinshad's right leg. They proceeded to snatch the bag of cash and the vehicle keys from him and fled the spot in his vehicle.

TN CM Stalin opens new agricultural college in Karaikudi



CHENNAI (TSIT): Tamil Nadu Chief Minister MK Stalin on Saturday inaugurated the Agricultural College and Research Institute in the Chettinad area near Karaikudi in Sivaganga district, marking the beginning of a packed two-day visit during which projects worth Rs 2,872 crore are being inaugurated and dedicated to the public.

The Agricultural College and Research Institute has been constructed in Kanadukathan, near Karaikudi, at a cost of Rs 61.78 crore. The institution is expected to play a key role in strengthening agricultural education, research, and extension services in the southern districts of Tamil Nadu, particularly benefiting students from rural and agrarian backgrounds.

Along with the college, the Chief Minister also inaugurated the C Subrahmaniam Multi-Purpose Hall located within the campus premises. The facility has been designed to host academic events, conferences, farmer training programmes, and community activities, thereby enhancing the institution's overall utility.

Economic Survey Validates Telangana's Growth Story: Minister Sridhar Babu

Hyderabad (TSIT) : Minister for IT and Industries Sri D. Sridhar Babu said the Government of India's Economic Survey 2025-26 stands as strong evidence of Telangana's all-round progress, economic stability, and transparent governance under the leadership of Chief Minister A. Revanth Reddy. Addressing a press meet at the Secretariat on Saturday.

Minister stated that the survey has effectively countered misinformation campaigns aimed at damaging Telangana's image. He said criticism is a healthy democratic tradition and the State government welcomes constructive feedback. However, he cautioned that opposition criticism must be



based on facts and not fabricated narratives driven by political motives. Certain vested interests, unable to digest Telangana's rapid development and welfare measures, were deliberately spreading false claims that the State economy had collapsed, he alleged. Citing survey data, Sridhar Babu pointed out that

Telangana has shown strong improvement in inflation control. While the national inflation average for 2024-25 stood at 4.63%, Telangana recorded a lower 3.67%.

For the current financial year (April-December), national inflation averaged 1.72% compared to just 0.20% in Telangana. He highlighted the steady decline in headline inflation in the State—from 8.61% in 2022-23 to 6.36% in 2023-24 and further down to 3.67% in 2024-25. Minister said Telangana is not dependent solely on Central grants and has demonstrated strong fiscal capacity through its own tax revenues. The survey confirms investor confidence and robust annual growth, he added.

ED files supplementary chargesheet in fraud involving Andhra Govt skill scheme

Hyderabad (TSIT): The ED filed a supplementary chargesheet in a Special PMLA Court in Visakhapatnam over cheating and diversion of crores of rupees invested by the Andhra Pradesh government in a skill development project involving a private company, an official said on Saturday. The Enforcement Directorate (ED), Hyderabad Zonal Office, filed the Supplementary Prosecution Complaint against Vikas Khanvelkar, Suman Bose, Mukul Chandra Agarwal, Suresh Goyal and others.

The chargesheet also named a company - Designtech Systems Private Limited (DTSPL). The total attachment of properties in the case, so far, is Rs 54.74 crore, the ED said. The Special Court, Visakhapatnam, took cognizance of

the supplementary chargesheet on January 28, said an ED statement. The agency initiated investigation on the basis of FIR registered by the Andhra Pradesh CID in the case of APSSDC Siemens Project against DTSPL and others for cheating the Andhra Pradesh government.

The accused diverted the funds invested by the state government for other purposes. The project was originally meant to promote skill development and entrepreneurship. The ED investigation revealed that Khanvelkar, Managing Director of DTSPL, Soumyadri Sekhar Bose alias Suman Bose, ex-Managing Director of Siemens Industry Software India, and their close associates, Agarwal and Suresh Goyal diverted the government funds with the help of shell or defunct entities.



Doctors welcome Supreme Court ban on stem cell therapy for autism

New Delhi, Jan 31 (TSIT) : Doctors on Saturday welcomed the Supreme Court's order against the use of stem cell therapy to treat autism – a neurodevelopmental condition affecting communication, social interaction, and behaviour. A bench comprising Justice JB Pardiwala and Justice R Mahadevan noted that stem cell therapy lacks "scientific support and has not been recognised as a sound medical practice backed by empirical evidence".

The Bench ruled that "every use of stem cells in patients outside an approved clinical trial is unethical and shall be considered as malpractice."

Doctors welcomed the move by SC as many private labs are misusing money from patients over the promise of treatment

for autism, amid a lack of scientific evidence.

"This is absolutely the best thing that can happen because there is no proof or evidence of the utility of stem cell therapy in autism or in any neurological disorder as of now," Dr Manjari Tripathi, Head of Department, Neurology, AIIMS Delhi, told IANS.

"Many people in India, and private labs, are advertising stem cells for autism and other disorders like cerebral palsy

and charging patients anywhere between Rs 6 and 20 lakh. Many families have lost money with no improvement. So, it's a correct move by the Supreme Court, and should have come earlier," she added.

Notably, the Ethics and Medical Registration Board (EMRB), under the National Medical Commission (NMC), had, in December 2022, constituted the Committee on Stem Cell Use in Autism Spectrum Disorder (ASD). It had stated that none of the current international

guidelines recommend stem cell therapy as a treatment for ASD and added that the therapy is not recommended as a treatment for ASD in clinical practice. Moreover, the Court also noted that an unproven therapy cannot be "demanded by a patient as a matter of right". It stated "patients may remain under therapeutic misconception and anticipate such results from an unproven treatment as may be expected from routine treatment and care.

Following through with the medical treatment even when patients are under such a misconception is, in our view, a gross violation of medical ethics," the Court noted.

5,582 Children Rescued
Under ‘Operation Smile-XII’

Hyderabad: A total of 5,582 children were rescued across Telangana during the month-long special drive Operation Smile-XII, aimed at eradicating child labour and tracing missing children, Additional Director General of Police (Women Safety Wing) Charu Sinha said on Saturday.

operation was conducted from January 1 to 31 under the guidance of the Union Ministry of Home Affairs. As part of the drive, 121 sub-divisional police teams involving 605 personnel carried out intensive inspections across the State. The operation was executed in coordination with the departments of Women & Child Welfare, Labour, Health, Child Welfare Committees, and voluntary organizations.

Prior to the drive, a state-level coordination meeting was held on December 29, during which personnel received special training on the Juvenile Justice Act and

child labour prohibition laws. Following this, extensive raids were conducted at railway stations, bus stands, brick kilns, mechanic workshops, tea stalls, and other vulnerable locations.

Among the rescued children, 5,108 were boys and 474 were girls. Of them, 2,292 children belonged to nearly 15 states including Bihar, Uttar Pradesh, Odisha, and Andhra Pradesh. Additionally, 43 children from neighboring Nepal were also rescued.

Officials identified 4,567 children as child labourers, 486 as street children, 38 engaged in begging, and 491 in other forms of exploitation. Police registered 1,480 FIRs and arrested 1,483 accused persons involved in employing children. The Labour Department issued 1,363 inspection reports and imposed fines totaling 41.78 lakh under the Minimum Wages Act.

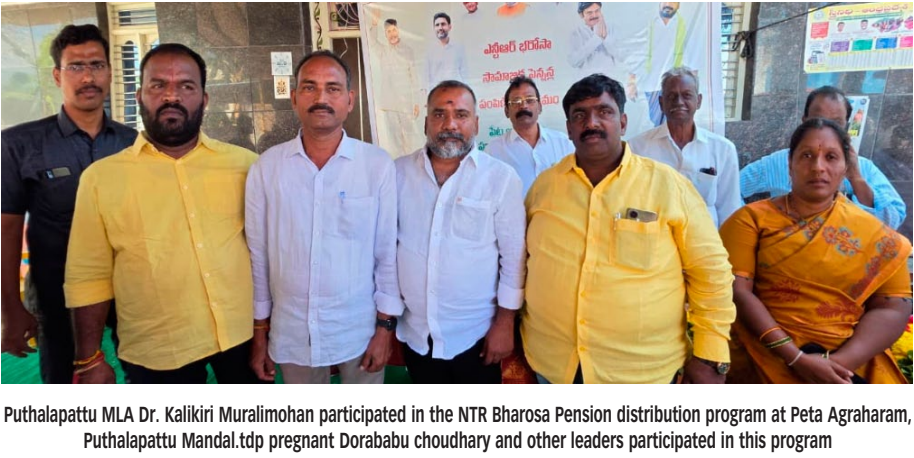

Addressing the gathering, Dr. M. Ramesh, IPS, noted that head and neck cancers account for nearly 30 per cent of all cancer cases in India, with around 2.25 lakh new cases and 1.25 lakh deaths annually. He pointed out that while the disease is commonly seen in the 50-70 age group, Indian patients tend to be diagnosed at a younger age compared to Western countries. He said the launch of the AI-based clinic highlights Yashoda Hospitals' continued focus on advanced, early-detection solutions.

Sunkavalli, Clinical Director and Robotic Surgical Oncologist at Yashoda Hospitals – Hi-Tech City, said the clinic represents a shift from conventional treatment protocols to biology-based, patient-specific cancer care, aligned with global best practices. He added that the summit featured expert-led discussions on emerging trends and future strategies in head and neck oncology, with internationally renowned faculty such as Dr. Jatin P. Shah and Dr. Anil K. D'Cruz participating in the deliberations.

The Union Budget presented by the Union Finance Minister, Nirmala Sitharaman, on the floor of Parliament is not merely an annual statement of income and expenditure. It is, in fact, a mirror reflecting the country's economic direction, social priorities, and future possibilities. At a time when India is rapidly consolidating its identity on the global stage as an emerging economic power, while simultaneously grappling with global uncertainties, geopolitical tensions, climate challenges, and rapid technological change, this Budget assumes even greater significance. From individual citizens to traders, industrialists, farmers, workers, youth, and the middle class—everyone's eyes are fixed on the Budget, as it offers not only a snapshot of the current year's economic landscape but also a glimpse of the "India of the future."

The Economic Survey presented ahead of the Budget has offered several important insights into the government's thinking and policy vision. It emphasises that development should not be confined merely to numerical growth, but should focus on the expansion of opportunities, inclusive progress, and long-term sustainability. The Survey acknowledges that while the Indian economy does face challenges, its potential far outweighs them. This very perspective should form the core spirit of the Budget—an audacious attempt to transform challenges into opportunities. The foremost and most crucial expectation from the Budget relates to enhancing the purchasing power of the lower-income sections. An economy attains real strength only when the person standing

at its lowest rung is able to live a life of dignity and actively participate in consumption. When the incomes of the lower-income groups rise and they gain access to affordable and accessible services, the immediate impact is felt on demand. Increased demand, in turn, stimulates production, investment, and employment.

Therefore, the Budget must focus on concrete measures for employment generation, along with direct cash transfers, food security, healthcare, and education. Strengthening programmes such as MGNREGA, introducing similar initiatives for the urban poor, and ensuring social security for workers in the unorganised sector can prove to be significant steps in this direction.

Urban development should be another major focal point of this Budget. India is rapidly urbanising, and cities are facing mounting pressure on housing, transport, water supply, sanitation, and the environment. Continued over-reliance on a few metropolitan cities is no longer a viable option. The idea of urban decentralisation suggested by World Bank President Ajay Banga is particularly relevant in today's context. Transforming small and medium cities into centres of economic activity and promoting industries and services there would not only reduce the burden on megacities but also help correct regional imbalances. If the Budget introduces special urban infrastructure packages for Tier-2 and Tier-3 cities—covering transport networks, digital connectivity, and skill development—it could lay the foundation for far-reaching transformation.

At the global level, rising tariffs, trade barriers, and protectionist tendencies present both challenges and opportunities for India. Ajay Banga's observation that greater attention should be paid to trade opportunities rather than excessive concern over tariffs offers a perspective well suited to India's current position. India possesses a vast domestic market, a young population, strong digital capabilities,



and a vibrant entrepreneurial spirit. If this Budget extends meaningful support to export-oriented industries, start-ups, manufacturing, and value-added sectors, India can further strengthen its position in global supply chains. Initiatives such as "Make in India" and "Atmanirbhar Bharat" must move beyond slogans and be backed by practical policy support—through a simplified tax structure, easy access to credit, greater investment in research and innovation, and improved ease of doing business.

In this context, ignoring the role of the middle class would be economically self-defeating. The middle class forms the backbone of any economy—it is both the largest consumer base and the most significant taxpayer. Ironically, this very segment often finds itself relatively neglected in Budget deliberations. Rising inflation, the high costs of education and healthcare, housing loans, and the burden of taxes have adversely affected both the savings and consumption capacity of the middle class. Rational reforms in income tax slabs, tax relief on education and healthcare, and incentives for housing in this Budget would not only provide much-needed relief to the middle class but also strengthen demand-led growth.

From the perspective of industry and the business community, the foremost expectation from the Budget is a stable and predictable policy environment. Investors are wary of uncertainty. Frequent changes in tax policies, complex compliance requirements, and regulatory ambiguities hinder investment. If this Budget clearly signals a long-term tax policy framework, provides affordable credit to

the MSME sector, encourages technological upgradation, and introduces special packages for green industries, it would significantly boost business confidence. The MSME sector, in particular—being the largest source of employment—must be positioned at the centre of economic revival.

The vision of India's future cannot be limited to economic growth alone. Environmental sustainability, social justice, and human development are equally vital. In the context of climate change, the Budget must prioritise green energy, clean transportation, and sustainable agriculture. This would not only protect the environment but also create new industries and employment opportunities. Investment in education and skill development will prepare the future workforce for global competition, while increased spending on healthcare will lay the foundation for a healthy and productive society. Ultimately, this Budget represents a test of balance—between fiscal discipline and developmental expenditure, between short-term relief and long-term reforms, and among the expectations of different sections of society. If the Budget succeeds in enhancing the purchasing power of the lower-income groups, providing relief to the middle class, accelerating urban decentralisation, and transforming global challenges into opportunities, it will emerge not merely as a financial document but as a manifesto for progress towards a "Developed India." What the country needs today is precisely such a Budget—one that inspires hope, builds confidence, and presents a positive and courageous vision for the future.

Menstrual health is fundamental right: SC orders free sanitary pads, separate toilets in school

NEW DELHI: Declaring the right to dignified menstrual health as part of the right to life and education under the Constitution, the Supreme Court on Friday directed all states and Union Territories to provide free oxo-biodegradable sanitary napkins to girl students and functional, gender-segregated toilets for all the students.

In a landmark judgment to ensure gender justice and educational equity, a bench comprising Justices J B Pardiwala and R Mahadevan issued a slew of directions to all states and UTs to ensure that these facilities are provided in schools irrespective of whether they are government-run, aided or private.

"A period should end a sentence, not a girl's education," Justice Pardiwala opened the 126 judgment with a poignant quote from American educator, social activist and producer Melissa Berton, and said, "The issues that have unfolded before us echo the very

same judicial disquiet. Even with the passage of time, the challenges that beset a girl child's education persist in much the same form."

The verdict warns of stringent consequences for non-compliance, including the derecognition of private schools and holding state governments directly accountable for failures in public institutions.

"The right to life under Article 21 of the Constitution includes the right to menstrual health. Access to safe, effective and affordable menstrual hygiene management measures helps a girl child attain the highest standard of sexual and reproductive health. The right to healthy reproductive life embraces the right to access education and information about sexual health," the bench held.

It then referred to Article 21A (right to education) and said it has been termed as a "multiplier right" as it enables the exercise of other human rights.



"The right to education forms part of the broader framework of the right to life and human dignity, which cannot be realised without access to education," it said. On the substantive approach to equality under Article 14, the verdict said it demands that treatment be accorded with due regard to the individual, institutional, systemic and contextual barriers that impede the translation of rights in reality.

"At the same time, the State, as a benefactor, is under an obligation to remedy such structural disadvantages," it said. "Inaccessibility of menstrual hygiene management measures undermines the dignity of a girl child, as dignity finds expression in conditions that enable individuals to live without humiliation, exclusion or avoidable suffering. Privacy is inextricably linked with dignity. "As a corollary, the right

to privacy entails a duty on the State to not only refrain from violating privacy but an accompanying obligation on the State to take necessary measures to protect the privacy of an individual," it said. The bench said inaccessibility of menstrual hygiene management measures strips away the right to participate on equal terms in school and the domino effect of the absence of education is the inability to participate in all walks of life later. It said the fundamental right to education under Article 21A and the Right to Education (RTE) Act comprises free, compulsory and quality education and it includes all kinds of charges or expenses that would prevent a child from pursuing and completing elementary education. Issuing a slew of directions, it directed that "all States and UTs shall ensure that every school, whether government-run or privately managed, in both urban and rural areas, provides oxo-biodegradable sanitary nap-

kins manufactured in compliance with the ASTM D-6954 standards free of cost."

Such sanitary napkins shall be made readily accessible to girl students, preferably within the toilet premises through sanitary napkin vending machines, or, where such installation is not immediately feasible, at a designated place or with a designated authority within the school, it added. As regards the "toilet and washing facilities", it asked them to ensure that every school is provided with the "functional, gender-segregated toilets with usable water connectivity".

It said all the existing and newly constructed toilets in schools shall be designed, constructed and maintained to ensure privacy and accessibility, including by catering to the needs of children with disabilities. It said all school toilets shall be equipped with functional handwashing facilities, with soap and water available at all times. "All states

and UTs shall ensure that every school... establish Menstrual Hygiene Management (MHM) corners. Such MHM corners shall be equipped with, including but not limited to, spare innerwear, spare uniforms, disposable bags and other necessary materials to address menstruation-related exigencies," it ordered. It directed the authorities to ensure that every school is equipped with a safe, hygienic, and environmentally compliant mechanism for the disposal of sanitary napkins, in accordance with the latest Solid Waste Management Rules.

On the issue of "awareness and training about menstrual health and puberty", it asked the National Council of Educational Research and Training (NCERT) and the State Councils of Educational Research and Training (SCERTs) to incorporate gender-responsive curricula, more particularly on menstruation, puberty and other related health concerns.

President, PM pay tributes to Mahatma Gandhi at Rajghat on death anniversary

NEW DELHI: President Droupadi Murmu and Prime Minister Narendra Modi paid homage to Mahatma Gandhi at the Rajghat memorial on his 78th death anniversary on Friday.

Vice President CP Radhakrishnan and several Union ministers, including Defence Minister Rajnath Singh, also visited the memorial to pay tributes to the Father of the Nation.

A two minutes silence was observed by the dignitaries in his memory.

At an all-faith prayer meeting held at the memorial, Gandhi's favourite devotional songs, including "Raghupati



ti Raghav Raja Ram", were rendered. Mohandas Karamchand Gandhi, popular as Mahatma Gandhi, was the leading figure of India's

struggle for Freedom from the British rule. He was assassinated by Nathuram Godse on January 30, 1948, in Delhi.

Gandhi a way of thinking which ideology of hate unsuccessfully tried to erase: Rahul

NEW DELHI: Congress leader Rahul Gandhi on Friday said Mahatma Gandhi is not just a person, but a way of thinking that an empire, an ideology of hatred and arrogance of power, unsuccessfully tried to erase at different points in time.

Terming Mahatma Gandhi the "immortal soul of India", the leader of the opposition in the Lok Sabha paid tributes to the Father of the Nation, saying that along with Independence, he gave the nation a fundamental principle that the power of truth is greater than the power of authority.

"Mahatma Gandhi is not just a person, but a way of thinking that an empire, an ideology of hatred, and an arrogance of power have all unsuccessfully tried to erase at different points in time," he said in a post in Hindi on X.

"The Father of the Nation gave us, along with Independence, the fun-

damental principle that the power of truth is greater than the power of authority and that non-violence and courage are greater than violence and fear," Rahul Gandhi said.

This way of thinking cannot be extinguished, because Gandhi is immortal in the soul of India, he said. Sharing lines of a Bhajan that Mahatma Gandhi used to sing, Congress president Mallikarjun Kharge said, "The hatred that separated us from Bapu, its solution also lies in Bapu's path. The light of truth, the power of non-violence, and the compassion of love. Homage to the Father of the Nation on Martyr's Day."

Congress General Secretary Priyanka Gandhi Vadra also paid tributes to Mahatma Gandhi on his death anniversary.

Party general secretary in charge of communications, Jairam Ramesh, recalled two separate letters written by Jawaharlal Nehru and Sardar



Vallabhbhai Patel in 1948 to Syama Prasad Mookerjee, in which they strongly criticised and raised questions on the activities of the Hindu Mahasabha and the RSS.

"Both are damning indictments of the self-declared custodians of nationalism. And to think that there is a Lok Sabha MP wedded to that ideology and who was blessed by the PM himself, who said that he could not choose between Gandhi and Godse. His mindset is revealing,"

Ramesh said on X, in an apparent reference to BJP MP Abhijit Gangopadhyay's controversial remarks in 2024.

Ramesh also shared a link to Nehru's address on All India Radio on the night of January 30, 1948, after Mahatma Gandhi's assassination.

In his letter to Mookerjee, Nehru had said the Hindu Mahasabha had held meetings in Pune, Ahmednagar and Delhi in defiance of the ban order. "Speeches were delivered that Mahatma Gandhi was an impediment, and the sooner he died, the better it would be for the country. The RSS has behaved in an even worse way, and we have collected a mass of information about its very objectionable activities," Nehru had said in his letter.

Ramesh also shared a screenshot of Patel's letter to Mookerjee in which the former criticised the activities of the RSS and the Hindu Mahasabha.

Rahul disrespected NE by not wearing 'gamosa' at President's R-Day event: Shah

DIBRUGARH: Union Home Minister Amit Shah on Friday accused Congress leader Rahul Gandhi of disrespecting the North East by refusing to wear 'gamosa', presented by President Droupadi Murmu at the 'At Home' reception hosted by her on Republic Day.

All dignitaries, including those from abroad, had worn the scarf as a mark of respect, but Gandhi was the "only person to refuse" to do so, Shah claimed, while addressing a public rally at the Khanikar Parade Ground here.

"Rahul Gandhi can do whatever he wants, but as long as the BJP is in power, it will not allow



any disrespect of the North East's culture", he said.

Shah alleged that the Congress did nothing for Assam's development. "I want to ask Rahul Gandhi what his party has given to Assam except guns, bullets, conflict and deaths of youth," the union

home minister said. Shah also accused the Congress of using infiltration as a "weapon for its vote bank politics".

"There has been no infiltration in Assam since the BJP came to power. Those who had come to India illegally will be identified and sent back," he added.

Heroin worth nearly Rs 2 crore seized, one arrested in Lucknow

LUCKNOW: The Central Bureau of Narcotics (CBN) has seized 280 grams of heroin, estimated to be worth about Rs 1.96 crore in the illegal market, and arrested one person, an official said on Friday. Deputy Narcotics Commissioner (Uttar Pradesh Unit) Praveen Bali told PTI the recovery was made during an operation conducted on Friday at the Itaunja toll plaza on the Lucknow-Sitapur Road in Bakhshi ka Talab tehsil.

The operation was carried out on specific intelligence and also involved the P&I (preventive and intelligence) cell of Barabanki, the officer said. He said a CBN team intercepted a person travelling in a roadways bus after inputs suggested that the suspect was carrying heroin for delivery in Lucknow.

Is it RTI's turn to get murdered? Kharge asks

NEW DELHI: A day after the Economic Survey called for re-examining the RTI law, Congress president Mallikarjun Kharge on Friday asked whether it was RTI's turn to get murdered after MGNREGA's "killing".

In a post on X, Kharge accused the Union government of systematically weakening the RTI Act and unleashing a climate of terror that punishes truth-seekers as he pointed out that over 100 RTI activists had been murdered since 2014.

"The Economic Survey has called for 're-examination' of the Right to Information Act. It also suggests a possible 'Ministerial veto' to withhold information and wants to explore the possibility of shielding public service records, transfers and staff reports of bureaucrats from public scrutiny. "The Modi Government has systematically weakened the RTI Act -- Over 26,000 pending cases as of 2025. In 2019, the Modi Government hacked away



at the RTI Act, seizing control over Information Commission's tenure and pay, converting independent watchdogs into submissive functionaries," Kharge said in his post.

He said the Digital Personal Data Protection Act, 2023 gutted the RTI's public interest clause, "weaponising privacy to shield corruption and stonewall scrutiny."

Until last month (December 2025), the Central In-

formation Commission had been functioning without a chief information commissioner. It was the seventh time in 11 years that this key post was deliberately kept vacant, the Congress chief claimed.

Why DGCA allowed flight operations at Baramati airport: Raut

MUMBAI: Shiv Sena (UBT) leader Sanjay Raut on Friday targeted the Directorate General of Civil Aviation (DGCA) over Maharashtra Deputy Chief Minister Ajit Pawar's death in an air crash, asking why it allowed flight operations at the Baramati airport if it was not fully equipped.

Talking to reporters, Raut also referred to the last year's catastrophic Air India flight 171 crash in Ahmedabad, and said the DGCA announces a probe after every such incident but its outcome remains unknown.

According to a statement issued by the Ministry of Civil Aviation after the death of Pawar and four others in Wednesday's crash, Baramati has an 'uncontrolled airfield' (one without a dedicated Air Traffic Control), and traffic information is provided by instructors/pilots from the local flying training organisations.



The chartered aircraft carrying Pawar was cleared for landing in Baramati after a go-around forced by poor visibility, but having finally received the clearance it did not give any 'read-back' or confirmation, and moments later burst into flames.

"There was no radar at Baramati airport or ATC. There was no system and there was just an airstrip, and the DGCA is respon-

sible for it (air crash). There isn't enough staff at Baramati airport," said Raut, a Rajya Sabha member.

"Who is responsible for such accidents? There is a need to probe such incidents. We have lost an important person in Maharashtra and the DGCA should take responsibility for it. How do you allow such airports or airstrips to operate?" asked the Sena (UBT) leader.

SUNETRA PAWAR: FROM
BEHIND THE SCENES TO
PINNACLE OF POWER

In the political corridors of Maharashtra, the name 'Pawar' has long been synonymous with power. But right now, the spotlight is not on a seasoned politician from the Pawar family, but a face that has spent decades observing the machinery of governance from behind the scenes: Sunetra Pawar, affectionately known as 'vahini' (sister-in-law). Amid the political vacuum created after Maharashtra Deputy Chief Minister Ajit Pawar, Rajya Sabha MP Sunetra Pawar is emerging as a decisive force in state politics. Leaders of the Ajit Pawar faction appear ready to accept her leadership as she steps into the forefront. Academically, a graduate, Sunetra Pawar's parliamentary record so far has been average.

Legislative Track Record

Her inquiries focus on grounded issues: agriculture, Western Ghats conservation, railway projects, and the upcoming Nashik Kumbh Mela 2027. Challenge: With an attendance of 69 per cent and only 4 participations in debates, it is clear that she is still carving out her identity as an orator within the House. Growing Stature: Her recent nomination to the Panel of vice-chairpersons of the Rajya Sabha in February 2025 serves as a testament to her growing political weight and the trust reposed in her by the leadership.

Roots In Power

Born in 1963 in Dharashiv (formerly Osmanabad), Sunetra Pawar's political DNA predates her marriage into the Pawar family. Her father, Bajirao Patil, was a veteran regional leader, and her brother, Padamsinh Bajirao Patil, was a formidable figure in district politics during the 1980s. She grew up in a household where public life and politics were part of everyday conversation. Sunetra Pawar holds a BCom degree from SB College, Aurangabad. Despite her commerce degree, she has led large industrial ventures like the Baramati High-Tech Textile Park, where she was responsible for decision-making on four fronts: production, investment, employment, and women's empowerment. As a business entrepreneur, she translated her academic background into institutional management. As a trustee of a large educational group like Vidya Pratishthan, she oversees the education, academic quality, and administrative structure for over 25,000 students. Known for her clean image, she has often been seen involved in social service activities. According to information on her website, she founded the Environmental Forum og India (EFOI), under which she played a key role in transforming Katewadi village into India's first 'eco village', a model for water conservation and solar energy.

Sunetra Pawar's greatest strength is the support she enjoys from her party leaders and workers. She carries both the family legacy and a proven track record of social work.

How The Economic Survey Redefines
India's Growth Constraints

India enters 2026 with macroeconomic indicators that compare favourably with most large economies. Real GDP growth has remained above 7 per cent for a second consecutive year. The Union government's fiscal deficit declined to 4.8 per cent of GDP in FY25, marginally outperforming budget estimates, and is projected to fall further to 4.4 per cent in FY26, less than half the pandemic peak of 9.2 per cent recorded in FY21. Public capital expenditure has remained elevated, bank balance sheets are strong, credit growth has accelerated, and foreign exchange reserves provide a substantial buffer against external shocks. Yet the defining feature of this year's Economic Survey is that it treats these outcomes not as an endpoint, but as a starting point for a more demanding diagnosis. The Survey's central claim is that India's binding constraint is state capacity, i.e., the ability of institutions to act coherently, learn under uncertainty, and deliver outcomes in a more hostile and fragmented global environment. This marks a substantive shift in emphasis from earlier Surveys. The Survey situates India's recent performance within a global environment characterised by persistent geopolitical uncertainty, fragmented trade regimes, and rising risk premia. Despite sound domestic fundamentals (moderate inflation, manageable external debt, and credible fiscal consolidation) the Indian rupee depreciated more than many peers in 2025. The Survey attributes to the structure of India's external balance. India continues to run a sizeable merchandise trade deficit that is only partially offset by services exports and remittances. Consequently, external stability remains dependent on capital inflows that are increasingly shaped by global risk sentiment rather than domestic fundamentals alone. This vulnerability is reflected in sovereign borrowing costs. India's 10-year government bond yield has hovered around 6.7 per cent, higher than that of peers such as Indonesia (approximately 6.3 per cent), despite comparable sovereign credit ratings. Markets are increasingly pricing the consolidated public-sector balance sheet, including the fiscal behaviour of States, where populist expenditure pressures have intensified. The global context has also become struc-



turally less benign. Reciprocal tariffs of up to 25 per cent imposed by the United States in 2025 disrupted expectations that India would benefit unambiguously from trade reconfiguration. Financial markets responded by pricing in heightened uncertainty. Gold prices rose from roughly USD 2,600 per ounce at the start of 2025 to over USD 4,300 by year-end, crossing USD 5,100 by January 2026. These movements reflect a durable rise in geopolitical and financial tail risks rather than transient volatility. Against this backdrop, the Survey undertakes a conceptual reworking of the Swadeshi debate. Import substitution is neither rejected nor endorsed as a general doctrine. Instead, it is positioned as one element within a broader strategic sequence, i.e., import substitution ? strategic resilience ? strategic indispensability. Strategic resilience is defined as the capacity to withstand shocks without systemic disruption. Strategic indispensability goes further, referring to the embedding of domestic capabilities so deeply into global production systems that other economies acquire a stake in India's stability and continuity. This distinction allows the Survey to differentiate between insulation and influence. To operationalise this framework, the Survey introduces a tiered approach to indigenisation. It distinguishes between sectors where import dependence creates acute

vulnerability, sectors where domestic capability is feasible but hindered by coordination failures or scale disadvantages, and sectors where substitution would impose economy-wide efficiency costs without materially improving resilience. Crucially, any protection or support is framed as conditional, time-bound, and linked to performance, with export exposure treated as a necessary disciplining mechanism. Permanent shelter without productivity upgrading is explicitly identified as a source of long-term fragility. One of the Survey's more analytically novel contributions is its treatment of input costs as a macroeconomic constraint rather than a sectoral issue. Tariff inversion, high logistics and energy costs, and regulatory compliance burdens are presented as horizontal distortions that raise transaction costs across the economy. The proposed National Input Cost Reduction Strategy reframes competitiveness as a public good. Once domestic capacity in widely used inputs has been established, the Survey argues, these inputs should not continue to be treated as revenue instruments or protected indefinitely. Elevated input costs may benefit a narrow set of producers, but they undermine downstream manufacturing, exports, and employment generation. This diagnosis is grounded in export performance. Since 2020, India's total exports have grown at a

compound annual rate of roughly 9.4 per cent. However, merchandise exports have expanded at only about 6.4 per cent, with services exports accounting for most of the aggregate momentum. The Survey is explicit that services exports, however successful, cannot substitute for manufacturing exports in delivering employment absorption, supplier ecosystems, and durable external balance. Manufacturing occupies a central analytical role in the Survey, not merely as a growth driver but as an institutional stress test. Manufacturing exposes weaknesses in power supply, logistics, regulation, standards enforcement, and coordination that more footloose service activities can often bypass. For an efficient manufacturing ecosystem, state capacity becomes a prerequisite. Advanced manufacturing requires predictable regulation, reliable infrastructure, disciplined standards, and rapid problem resolution across multiple agencies. Failures in governance become immediately visible and economically costly. This framing informs the Survey's engagement with East Asian experience. Japan, South Korea, Singapore, and Vietnam are not presented as models to be replicated, but as examples of a shared institutional logic, i.e., bounded experimentation, tolerance for good-faith failure, and credible withdrawal of support when performance thresholds are not met."

"Hamberder" To "Furniture Of Children",
Trump And His 'Unpresidential' English

The English language is a stubborn, ancient beast. It has rules, syntax, and a generally agreed-upon spellings. But the language keeps evolving, and rarely has it been bludgeoned into such fascinating new shapes as it is by the 47th President of the United States. It is no secret that where world leaders prefer to lean into diplomatic opacity, the most powerful leader in the world prefers unfiltered creativity: "I know words. I have the best words," he had declared at a rally in 2015, in the run-up to his first term. As the first year of his second term concludes, one can only add, "and how!" When Donald Trump approaches a podium or a smartphone, he does not merely use English; he negotiates with it. He stares down syllables until they surrender and rearranges vowels until they agree to his terms. To the pedantic linguist, these are errors. But to the connoisseur of chaos, they are "Trumpisms" - accidental masterpieces of a man who seems to view the dictionary rather as Italian drivers regards traffic lights, not as a binding standard-setter but as a suggestion that can be ignored whenever one can get away with it - and when you are the President of the United States, that means pretty much any time. Remember 'Covfefe'? It begins, of course, with the Presidential thumbs and their propensity for careless tweeting. Historians of the future will likely dedicate entire semesters to the "Covfefe" incident. It remains the Mona Lisa of typos: mysterious, evocative, and utterly unintelligible. Was it a nuclear code? A cry for help? A nickname for a White House intern? Years later, "covfefe" retains a mystical aura. It is a word that means nothing, yet somehow encompasses the entire surreal experience of the Trumpian tweet era. But "covfefe" was merely the opening act. We must consider the culinary innovation of the "hamberder". When the President tweeted about serving "hamberders" to the Clemson Tigers, he didn't just mistype a fast-food staple; he created a new category of cuisine. A hamburger is something you eat at a picnic; a 'hamberder' sounds heavier, darker - a beef patty that requires heavy breathing and a nondisclosure agreement to consume. Then there is the persistent case of the "stollen" election. In post after post, the President has rallied against the vote being "stollen". To the uninitiated, this is a misspelling of "stolen". To those of us with a penchant for German baking, however, it is a delightful image. Stollen is a dense, powdered sugar-coated fruit bread eaten at Christmas. Every time the President rages about the "stollen", one cannot help but picture ballot boxes stuffed not with fraudulent votes, but with dried fruit, marzipan, and holiday greetings in the language of Mr Trump's paternal ancestors, the German Trumpfs. Origins And Oranges If his thumbs are agents of chaos, his tongue is a revolutionary. The President often speaks with the confidence of a Ferrari engine inside a golf cart; the momentum is high, but the steering is loose. This leads to phonetic collisions like "oranges". During a discussion on an FBI investigation, the President repeatedly insisted on looking at the "oranges" of the probe. He meant "origins", of course, but by saying "oranges" three times, he turned a legal inquiry into a quest for Vitamin C. Similarly, he once spoke with great passion about the "furniture of our children". He meant to say "future", but in the heat of the moment, he accidentally suggested that America's youth are merely decorative ottomans in the living room of democracy. And let us not forget the "anonymous" op-ed writer-a pronunciation that sounded less like a person withholding their name and more like a shy species of dinosaur. The Trumpian worldview

strained by the globe when you can invent nations? He once praised the healthcare system of "Nambia" while addressing African leaders. Nambia does not exist, though it sounds like a lovely place, likely bordering Wakanda, where the golf courses are tremendous and the tariffs are low. He has also taken us to "Thigh-land" and introduced us to the "Yo-Semites". This last one, intended to be Yosemite National Park, was pronounced as a casual greeting to a group of Jewish people ("Yo! Semites!"), transforming a tourist valley into an oddly precise demographic shout-out. Perhaps his most practical contribution to English, however, is his approach to names. The President is a busy man; he values efficiency. Why waste seconds saying "Tim Cook, CEO of Apple", when "Tim Apple" conveys the same data in half the time? It is a return to medieval naming conventions, like John the Baker or Donald the Builder. It is ruthless, corporate efficiency applied to identity. Critics may call his occasional "bragghadocious" effulgences (the adjective comes from his speech to the United Nations General Assembly, no less) a "word salad", but that implies a mix of vegetables. This is more of a word khichdi - spicy, thick, and full of things you can't quite identify. Whether he is acting "unpresidential" (a Freudian slip for the ages) or winning "bigly", Donald Trump has proven that he possesses the best words. They just aren't always the ones in the dictionary. On January 24, China announced that its two top military officers, Generals Zhang Youxia and Liu Zhenli, were placed under investigation for violating party discipline and law. They are accused of "seriously trampling the Chairman Responsibility System," i.e., directly defying President Xi Jinping's supreme authority and damaging the Party and the People's Liberation Army (PLA)'s combat capability. The speed and severity of the investigation reflect Xi's drive to remove the last bits of independent authority in China - a purge aimed at pre-empting potential 'mountain-tops' in the PLA, ahead of next year's leadership renewal at the 21st Party Congress. The key question is, what does this purge mean for China's defence policy? And, how will it impact India's security, especially along the Line of Actual Control (LAC)?

Nevertheless, this action has created concealed anxiety within the Communist Party. Beijing has moved swiftly, employing multiple methods, even media drip-feeds alleging grave, unpatriotic conduct, to contain potential unrest among the military's rank and file and beyond.

The upheaval in China's elite politics, especially within the PLA, will likely persist for several years. Repopulating a hollowed-out Central Military Commission (CMC) with fresh faces untainted by the older generation will take time. Even if the CMC receives a new crop of leaders in the next year's Party Congress, the vetting will be protracted and rigorous. However, the PLA's combat capability, primarily under the domain of the theatre commands and subordinate echelons below the CMC, should remain largely impervious. While scores of senior military officers have fallen in recent years, the PLA still employs thousands of general-rank

officers, from major general upward. Therefore, Xi has the latitude to cycle through multiple rounds of promotions and purges until he finds his exact cohort of competent and loyal officers.

Taiwan and India

These developments offer Taiwan some breathing space. Despite Xi's sense of urgency, he remains a rational actor and appears not fully confident of the PLA's ability to deliver on the Taiwan front. In addition, obtaining frank assessments of the PLA's real capabilities to counter US and allied forces in the eastern theatre will become increasingly difficult for him. Younger officers are likely to avoid delivering bad news, while earning Xi's trust would be harder, especially after the downfall of a close friend. Xi remains particularly confident in grey-zone operations, as they can be calibrated at will, and this will continue. However, the launch of an outright attack is a gamble, putting all his grey-zone achievements at risk of an uncertain outcome. Xi is

likely to reevaluate the costs and benefits of such an adventure carefully. The same is true on the Indian front. In recent months, India and China have pursued a cautious rapprochement: economic ties have improved, and both states have taken steps to ease interaction between governments, institutions and people. This has, however, not reduced the structural competition and about 50,000 troops remain deployed on the LAC. China's close collaboration with Pakistan during Operation Sindoor and its expanding activities in the Indian Ocean don't inspire much confidence either. The purge is, therefore, more likely to maintain relative calm and a managed status quo on the LAC, even as the PLA continues to enhance its leverage over time.

Time as a Weapon

India consistently misreads three core strategic variables vis-à-vis China: treaties, time, and ambiguity. India considers treaties as binding commitments; China counts them as instruments to shape the adversary's behaviour while protecting the PLA's freedom of action. So, New Delhi's self-restraint enables Beijing's misadventures. Similarly, while India views time as a stabilising factor in the long run, China uses time to prepare, consolidate, and progressively alter facts on the ground. Moreover, China doesn't resolve an ambiguity but exploits it as a leverage. India must internalise this logic to make its LAC policy proactive and outcome-shaping, rather than reactive.

Mangaluru: Bacteria detected in Gujjarakere water, declared unfit for drinking

Mangaluru, Jan 31: Gujjarakere, once revered as a sacred theertha lake believed to cure ailments, is now found to be contaminated with disease-causing bacteria. Laboratory test reports have once again confirmed that the lake water is completely polluted and unsafe for consumption. Although the lake has been developed under the Smart City project at a cost of several crores of rupees and appears visually appealing, its water body is severely contaminated. The primary reason cited is the inflow of sewage water into the lake. Despite repeated appeals by local residents to the Mangaluru City Corporation and Smart City authorities, no effective action has reportedly been taken. Water samples drawn from the lake and tested in a laboratory revealed alarming results. In every 100 ml of water, the total coliform count was found to be 1,600, while the faecal coliform count was also 1,600. The presence of such high levels of bacteria in 100 ml of water is considered extremely dangerous, and the report has clearly stated that the water is unfit for drinking. The lake water had been tested around seven months ago as well, and contamination was detected then too. At that time, the total coliform count was 1,600 and the faecal coliform count stood at 500. Compared to those findings, the bacterial levels have now doubled.Gujjarakere water has been tested multiple times in the past, and each time dangerous bacteria were detected. Tests conducted in 2014 and 2015 showed bacterial levels of around 1,100. When tested again in 2016, the bacterial count had increased further. Typically, water testing involves checking for total coliform bacteria (generally considered non-harmful) and faecal coliform bacteria, which indicate contamination from sewage or toilet waste.For water to be considered good and suitable for drinking, the total coliform count in 100 ml of water should be zero. A count of 1 to 3 is considered satisfactory, while 4 to 10 is not very good. If the count exceeds 10, the water is deemed unfit for drinking. Similarly, faecal coliform bacteria must also be at zero level for water to be potable. However, the current level in Gujjarakere stands at a dangerously high 1,600. Gujjarakere is one of the oldest lakes in Mangaluru and holds immense religious significance. It is believed to have been formed through the penance and spiritual power of Guru Goraknath, a disciple of Nath Panth sage Guru Machendranath. References to these sages are found in the historical accounts of the Mangaluru's presiding deity, Shri Mangaladevi Amma. For centuries, the sacred theertha from this lake was used with great reverence for ritual bathing of the deity at the historic Bolar Hale Kote Shri Mariyamma Temple. "It has now been conclusively proven that the water of Gujjarakere is not clean. Once a vital water source contributing to groundwater conservation and holding rich historical and religious significance, this sacred lake urgently requires protection and conservation. The negligence of officials from the concerned departments in matters related to the development and preservation of the lake is evident," said Nemu Kottari, general secretary of the Gujjarakere Theertha Conservation Forum.

Davos visit accelerates investments, expansion and partnerships: Industries Minister M.B. Patil

AN IMPETUS TO PREPARE FOR THE CHALLENGES POSED BY EMERGING TECHNOLOGIES



Bengaluru: The World Economic Forum (WEF) summit held in Davos has laid a strong foundation for the rapid materialisation of new investments, industrial expansion and partnerships in areas such as advanced manufacturing, food processing, clean energy and data centres in the State, said Minister for Large and Medium Industries M.B. Patil on Saturday.

The Minister shared details of the meetings and discussions held at the World Economic Forum in Davos while addressing a press conference at Vidhana Soudha. "Productive meetings were held with over 25 international companies and more than 15 Indian companies across priority sectors such as aerospace and defence, advanced manufacturing, beverages and food processing, space technology, life sciences, data centres, digital infrastructure and clean energy. Heads of multinational companies have expressed readiness to prioritise and fast-track their commit-

ments related to setting up and expanding industries in Karnataka," the Minister stated.

He said it was a matter of pride that industry leaders have lauded the State Government's industry-friendly industrial policies, adopted with the objective of developing Karnataka as a leading State on the country's industrial map.

Discussions were also held on India's evolving role in the context of current global economic developments. Several companies expressed interest in investing and expanding in Tier-2 and Tier-3 cities of the State. In line with the Government's priority of developing cities beyond Bengaluru into self-sustaining urban centres, companies such as Bharti Enterprises and Sify Technologies, which have plans to set up data centres in Tier-2 cities, have shown interest. Similarly, Tech Mahindra has evinced interest in expansion in Tier-2 cities, he said.

He added that global

investors and technology leaders were clearly conveyed Karnataka's position as a preferred destination for next-generation industries, including artificial intelligence (AI), data centres, semiconductors, space technology and Industry 4.0.

Priority to adopting new ideas

The Minister emphasised the Davos visit strongly underscored the need to adopt new approaches to effectively address the challenges posed by future technologies such as artificial intelligence, robotics and quantum technology, and that the State Government would actively work in this direction.

Citing the example of a mobile manufacturing company in China, the Minister said tasks earlier performed by 500 workers are now being handled by just five or six people with the help of artificial intelligence. He noted that future technologies such as AI, robotics and quantum computing are no longer limited to software

alone, but have entered the manufacturing sector as well, raising concerns about potential job losses. While these technologies bring benefits, they also pose certain challenges. He said priority is being given to creating employment opportunities for the State's large youth population and women, and that the summit witnessed meaningful discussions on effectively addressing such challenges.

He said priority would be given to harnessing future technologies for the welfare of the people of the State, and that discussions with the governments of Liechtenstein and Singapore focused on jointly attracting investments to Karnataka.

A conscious decision

The Minister said a conscious decision was taken not to sign any Memoranda of Understanding (MoUs) with domestic companies at the summit. Instead, detailed discussions were held on future investments. "There is no need to travel to Davos to sign agreements with Indian companies, as these can be finalised within the country itself. This thoughtful decision was appreciated," he said, adding that discussions were also held with 15 Indian-origin multinational companies regarding investments, industrial activity and expansion of data centres. He said Tata Sons has expressed interest in becoming a part of the State's ambitious 'KWIN City' project, and that Tata Sons Chairman N. Chandrasekaran has shown willingness to continue discussions in this regard.

Site inspections must be conducted to verify whether construction is being carried out in violation of approved plans. In cases where plan violations are detected, electricity connections should be immediately disconnected and appropriate action initiated against such buildings. Two towing vehicles have already been procured to remove abandoned vehicles that have been parked along roadsides for several months within the Bengaluru North City Corporation limits. He instructed officials to coordinate with Traffic Police authorities and immediately commence the removal of abandoned vehicles across all areas.

CM Stalin inaugurates Rs 28-crore mini TIDEL park in Karaikudi



CHENNAI (TSIT): Tamil Nadu Chief Minister M K Stalin on Saturday inaugurated a new Mini TIDEL Park in Karaikudi, Sivaganga district, built at a cost of Rs 28 crore. The facility is expected to generate employment for about 600 IT professionals and was launched under the Industries, Investment Promotion and Commerce Department, said a Daily Thanthi report. According to a Tamil Nadu government release, the TIDEL model dates back to 2000, when the late Chief Minister M Karunanidhi established the first TIDEL Park in Taramani, Chennai, laying the foundation for the state's IT boom.

As part of continued expansion, foundation stones were laid on

February 18, 2025 for new TIDEL parks in Madurai (Rs 314 crore, 5.34 lakh sq ft) and in Panchappur, Tiruchirappalli (Rs 403 crore, 5.58 lakh sq ft), both currently under construction.

Additionally, a 21-storey TIDEL Park in Pattabiram with a built-up area of 5.57 lakh sq ft was inaugurated on November 22, 2024. The government has also announced a new TIDEL Park in Hosur at a cost of Rs 400 crore, spanning 5 lakh sq ft. Tender processes are under way and construction is expected to begin soon. Each of these projects is projected to create around 6,000 IT and IT-related jobs, further strengthening Tamil Nadu's technology ecosystem.

Adyar triple murder case: Post-mortem rules out sexual assault of migrant worker's wife

CHENNAI: In a fresh development in the Adyar triple murder case, police on Friday said the post-mortem examination of the slain migrant worker's wife Munita Kumari (22), found no signs of sexual assault.



According to a report in Daily Thanthi, the autopsy was conducted at the Government Royapettah Hospital on January 31, 2026. It concluded that Munita Kumari died due to a head injury caused by being struck with an iron rod. The case came to light after Gaurav Kumar (24), a native of Nalanda district in Bihar, was found murdered and stuffed into a gunny bag that was dumped at Indira Nagar First Avenue in Adyar on January 26. Following the discovery, Adyar police arrested three men from Bihar's Nalanda district — security guard Sikandar alias Satyendar (30), Lalith Yadav (40), and Vikash Kumar (24) — and remanded them in judicial custody.

During interrogation, the accused allegedly confessed to killing Gaurav Kumar, his wife Munita Kumari, and their two-year-old son Birmanee Kumar. The child's body was later recovered from the Buckingham Canal beneath the Madhya Kailash railway bridge, while Munita Kumari's body was found at the Perungudi dump yard after an extensive three-day search involving more than 100 police personnel and Greater Chennai Corporation workers using earth-moving machinery. Police said investigators had earlier suspected a sexual assault attempt as a possible motive, but the post-mortem findings have now ruled out sexual assault and confirmed fatal head trauma as the cause of death.

Tamil Nadu Cabinet to meet on February 5, budget to follow week later



CHENNAI: Chief Minister MK Stalin will chair the State Cabinet meeting on February 5 to approve the interim general budget for the 2026-27 financial year, official sources said. The Assembly is expected to convene in the second week of February for the budget session, which will also be the final sitting of the 16th Tamil Nadu Legislative Assembly.

As the State is heading into an election, the government will present only an interim budget for 2026-27. However, coming as it does ahead of a key election where the DMK is facing the AIADMK-BJP combine and Vijay's TVK, speculations are rife that the chief minister may make an announcement enhancing the amount and expanding the scope of the

party's flagship scheme, Kalaingar Magalir Urimai Thogai Thittam.

Recently, the AIADMK had promised to increase the cash assistance to Rs 2,000 and also make all ration cardholders eligible if voted to power, triggering speculation that the ruling DMK may go one step ahead to attract women voters.

Also, the opinions and suggestions that were garnered from the public through the recent survey, Unga Kanava Sollunga, are likely to find space in the announcements that Stalin will make in the Assembly. Ahead of the session, the Cabinet on February 5 will hold detailed discussions on financial allocations, expenditure proposals, development projects, and other administrative matters.

Tanker mows down cattle herd in Virudhunagar, 7 dead



VIRUDHUNAGAR: Seven cattle were killed and more than 10 injured after a milk tanker rammed into a herd near Mudukankulam, close to Kariapatti in Virudhunagar district, early on Friday.

The cattle belonged to Rajagopal (31), a farmer from Salai Ippaikulam village near Kariapatti, who rears over 1,000 native cattle. On Friday morning, a milk tanker travelling at high speed allegedly lost control and crashed into the cattle.

Seven died on the spot, while several others suffered injuries. Cattle owners stopped the tanker and alerted Mukkulam police.

Police rushed to the spot and took the tanker to the police station. Further investigation is under way.

DMK says Congress has not sought power sharing in alliance talks

CHENNAI: The DMK on Saturday asserted that the Congress high command had not insisted on any power-sharing arrangement during alliance discussions.

Former DMK MP TKS Elangovan said that even if such an issue were to be raised, the party leadership was capable of responding appropriately.

Addressing a press conference at Anna Arivalayam, Elangovan said neither the Congress leadership in Delhi nor its State unit had sought power sharing. He added that even if a demand was made, the DMK leadership knew how to handle alliance partners with maturity.



Elangovan was speaking ahead of the DMK's month-long campaign, Tamil Nadu Won't Bow, which is scheduled to begin on

Sunday across all 234 Assembly constituencies in the State.

He said around 22 star campaigners would tour Tamil Nadu, highlighting the policies of the DMK government and what he described as the betrayal of the State by the BJP-led Union government.

Responding to speculation surrounding alliance negotiations, Elangovan reiterated that there had been no formal demand from the Congress leadership on power sharing.

Rajya Sabha MP Kanimozhi Somu and MLA Dr Ezhilan Naganathan were present at the press conference.

Vijay rules out kingmaker role, says TVK will win Tamil Nadu Assembly polls

CHENNAI: Actor-turned-politician Vijay has sent out a clear political signal, asserting that he would win and be the king in the upcoming Tamil Nadu Assembly elections and not play the role of a kingmaker.

In a candid interaction with NDTV team at his residence here, the president of Tamilaga Vettri Kazhagam said he was confident of a decisive mandate, pointing to the crowds at his public engagements as evidence of growing support. "I will win. Why would I be a kingmaker? Have you seen the crowds that are coming? I have been a star for decades, and now I have put my mind into



politics. The switch has not been easy," Vijay said.

Reflecting on the Karur stampede during one of his rallies, which claimed 41 lives, he described the

incident as a profound shock that continued to weigh on him. "I never expected anything like that to happen. It still haunts me in some ways," he said.

On the controversy surrounding his film Jana Nayagan, Vijay said politics was now his future, but admitted he felt distressed for the producer. "I expected my film to be targeted because of my political entry. I was mentally prepared for this," he said.

The actor-politician also spoke of his influences, calling Shah Rukh Khan his favourite actor and naming M G Ramachandran and J Jayalalithaa as his political role models.

Vijay said his political journey would be driven by conviction and perseverance as he prepared for his first full-fledged electoral test.

EPS will not beg for alliance: Rajenthra Bhalaji

VIRUDHUNAGAR: Former minister KT Rajenthra Bhalaji said on Friday that AIADMK general secretary Edappadi K Palaniswami would not approach anyone, knocking on their doors, for the sake of an alliance and that the party was confident of forming the government on its own. Rajenthra Bhalaji said the AIADMK was a strong party and Palaniswami a strong leader. He said the



AIADMK-BJP alliance would win the Assembly election and claimed that the return of TTV Dhinakaran would only add to the party's strength. He also said no

talks had been held with the DMK. He said people no longer wanted the DMK government and wished to see Palaniswami return as chief minister.

AI-enabled stethoscopes may boost diagnosis of heart diseases: Study

NEW DELHI: Amid growing influence of artificial intelligence (AI) in healthcare, a new large-scale clinical trial published in The Lancet on Thursday showed that an AI-enabled stethoscope can boost early detection of various heart diseases. A team of Spanish researchers found that an AI-enabled stethoscope helped doctors in identifying early signs of serious heart conditions, such as heart failure, arrhythmias, and valve disease, in primary care clinics.

The study found that introducing the technology to doctors led to a substantially faster and more frequent detection — nearly twice as many new heart failure cases and three times as many detections of irregular heart rhythms —

of these cardiovascular conditions, indicating that the device performed well.

"Primary care faces a growing workload and limited resources, making it the ideal recipient of the efficiencies promised by artificial intelligence (AI). The potential of AI to improve diagnostic accuracy through decision support systems or image analysis is clear. However, implementing these tools into primary care workflows remains challenging," said corresponding author Sergio Cinza-Sanjurjo from Santiago de Compostela University, Spain.

The TRICORDER trial is the first cluster randomised controlled implementation trial (RCIT) of a clinical AI technology on a national



scale, involving 205 UK NHS general practices and more than 1.5 million registered patients in the UK. Many practices reported declining use of the AI stethoscope over time, citing extra steps in routine work and limited electronic health record integration as key barriers. The AI stethoscope integrates three algorithms designed to detect heart failure, irregular heart rhythms, and valve disease during routine appointments.

Over the 12-month study period, doctors performed nearly 13,000 AI-assisted cardiac examinations.

While the overall heart failure detection rates were similar between the groups (1,342 new cases in the AI group versus 1,984 in usual care), subgroup analyses

showed that patients examined with the AI stethoscope had significantly higher detection rates compared to patients who were not examined with the AI device.

The trial suggests that AI tools such as smart stethoscopes could help physicians detect heart problems earlier in routine care, but only if they're properly integrated into day-to-day clinical operations. Despite strong algorithmic accuracy, real-world benefit depended heavily on clinician engagement and workflow integration. As Iran–US tensions soar, Strait of Hormuz caught in the middle

Dubai: The Strait of Hormuz, the narrow mouth of the Persian Gulf, again has become a focus of tensions as Iran prepares to launch a military drill that could see fire into a lane crucial for global shipping. Iran has warned ships that it will conduct a live fire drill on Sunday and Monday in the strait, which sees a fifth of all oil traded pass through the tight corridor between the Islamic Republic and Oman. The United States military's Central Command issued its own warning early Saturday, telling Tehran that any "unsafe and unprofessional behaviour near US forces, regional partners or commercial vessels increases risks of collision, escalation and destabilisation." Here's what to know about the drill, the US warning, what caused the tensions and what might happen next in the Strait of Hormuz. A key waterway for global shipping The Strait of Hormuz resembles a bend looking down from space. Its narrowest point is just 33 kilometres (21 miles) wide. It flows from the Persian Gulf into the Gulf of Oman. From there, ships can then travel to the rest of the world. While Iran and Oman have their territorial waters in the strait, it's viewed as an international waterway where all ships can ply. The United Arab Emirates (UAE), home to the skyscraper-studded city of Dubai, also sits near the waterway. The Strait of Long has been important for trade The Strait of Hormuz through history has been important



for trade, with ceramics, ivory, silk and textiles moving from China through the region. In the modern era of supertankers, the narrow strait proved deep and wide enough to allow for oil to pass through it. While there are pipelines in Saudi Arabia and the UAE that can avoid the passage, the US Energy Information Administration says "most volumes that transit the strait have no alternative means of exiting the region." The vast majority of the oil and gas moving through the strait goes to markets in Asia. Threats to the route have spiked global energy prices in the past, including during the 12-day war Israel launched against Iran in June. Iran plans a

drill that could enter the trade route A notice to mariners sent Thursday by radio warned that Iran planned to conduct "naval shooting" in the Strait of Hormuz on Sunday and Monday. The coordinates provided by the message put the drill potentially going into what is known as the Traffic Separation Scheme — a 3.2-kilometre (2-mile) wide, two-lane system in which ships coming into the Persian Gulf go north and ships exiting onto the Gulf of Oman go south. That northern lane is within the coordinates of the drill. While Iran has provided no other public details about the drills, it will likely involve the country's paramilitary

Revolutionary Guard. The Guard operates a fleet of small fast-attack vessels in the strait that routinely have tense encounters with the US Navy. US issues warning over the Iranian drill Early Saturday, the US military's Central Command issued a strongly worded warning to Iran and the Revolutionary Guard over the drill. While acknowledging Iran's "right to operate professionally in international airspace and waters," it warned against interfering with or threatening American warships or passing commercial vessels. The command, which oversees the US Navy's Bahrain-based 5th Fleet, said it "will not tolerate unsafe (Guard) actions" that could include its aircraft or vessels getting too close to American warships or pointing weapons toward them. The command added that "the US military has the most highly trained and lethal force in the world." Tensions high US President Donald Trump has threatened to launch a military strike against Iran after its bloody crackdown on nationwide protests. He has laid down two red lines — the killing of peaceful protesters and Iran launching a wave of mass executions of those held. In recent days, he's also included the fate of Iran's nuclear programme. The USS Abraham Lincoln aircraft carrier and supporting guided missile destroyers are now in the Arabian Sea, where they could launch an attack if Trump calls for it.

WIDESPREAD STEROID USE EMERGING AS A KEY TRIGGER FOR SECONDARY GLAUCOMA, SAY DOCTORS

Hyderabad January 2026: Doctors across India are raising concern over the widespread use of steroids, warning that it is emerging as a major trigger for secondary glaucoma, a sight-threatening condition that can lead to irreversible blindness. Steroids commonly used for allergies, skin conditions, respiratory illnesses, and even as over-the-counter eye drops can significantly raise eye pressure when used for prolonged periods, often without patients realizing the long-term damage being caused to the optic nerve. India is already home to an estimated 12-13 million people living with glaucoma, accounting for nearly one-sixth of the global burden. Globally, glaucoma affects around 75-80 million individuals, a number expected to rise beyond 110 million by 2040. Despite being the leading cause of irreversible blindness worldwide, glaucoma remains vastly underdiagnosed in India. A particularly alarming concern is that 85-90% of glaucoma cases in the country remain undiagnosed. The disease progresses silently, and by the time symptoms become evident, irreversible optic nerve damage has often already occurred. Late diagnosis results in avoidable vision loss, reduced quality of life, and significant socioeconomic

ic impact. "We are seeing a noticeable rise in steroid-induced glaucoma, particularly in patients who use steroid medications or eye drops without medical supervision," said Dr. Kousalya, Glaucoma Surgeon, Dr Agarwal's Eye Hospital, Hyderabad. "What makes this dangerous is that patients feel symptom-free initially, while eye pressure continues to rise silently, causing permanent damage", she adds. Over the past two to three years, doctors have reported a notable rise in diagnosed glaucoma cases, driven by an ageing population, a higher prevalence of diabetes and myopia, advancements in diagnostic technologies, and improved public awareness. However, experts caution that a growing proportion of cases are linked to secondary glaucoma caused by prolonged or unsupervised steroid use—an avoidable risk factor if identified and addressed early through timely screening and medical guidance. Glaucoma is most commonly diagnosed in individuals above 40 years of age, with incidence peaking between 50 and 70 years. That said, clinicians are increasingly detecting juvenile and early-onset glaucoma, particularly among individuals with a family history of the disease or secondary triggers.

Primary open-angle glaucoma continues to be the most prevalent form, followed by primary angle-closure disease, while steroid-induced glaucoma and pseudoxfoliation glaucoma are also frequently observed in clinical practice. "Many patients don't recognize early signs like peripheral vision loss, frequent changes in glasses, or seeing halos. Since central vision is often unaffected at first, this can delay timely diagnosis and treatment." Dr. Kousalya added. Doctors also caution against common myths, including the belief that good vision means healthy eyes, that glaucoma affects only older adults, or that normal eye pressure rules out the disease. Individuals with diabetes, hypertension, thyroid disorders, high myopia, hypermetropia, long-term steroid use, or a history of eye injury including injuries sustained during childhood are at a higher risk and should undergo annual eye screening. As part of Glaucoma Awareness Month, experts stress that routine eye examinations are crucial. Individuals over 40 years should undergo comprehensive screening every one to two years, while high-risk groups require yearly evaluations. Vision tests alone are insufficient without assessment of eye pressure and optic nerve health.

Stock markets snap 3-day rally on intense selling ahead of Budget

Mumbai: Equity benchmark indices Sensex and Nifty ended lower on Friday, January 30, snapping a three-day rally, due to heavy selling pressure in metal, IT and commodity stocks as investors booked profits at higher levels ahead of the Budget 2026-27. However, buying on select blue-chip counters restricted the sharp fall in domestic equities amid prolonged weakness in the rupee, traders said. As a bearish trend gripped the street, the 30-share BSE Sensex declined 296.59 points, or 0.36 per cent, to settle at 82,269.78. During the day, it tumbled 625.34 points or 0.75 per cent to 81,941.03. A total of 2,424 stocks advanced while 1,783 declined and 160 remained unchanged on the BSE. The 50-share NSE Nifty dropped 98.25 points or 0.39 per cent to end at 25,320.65 in a volatile session. "Indian equity markets remained volatile ahead of the Union Budget, with benchmark indices dragged lower by weak-



ness in IT and metal stocks. The IT sector lagged due to global growth concerns and higher US bond yields, while gold and silver declined amid a stronger dollar. "Persistent FII selling and continued rupee depreciation kept market sentiment cautious," Vinod Nair, Head of Research, Geojit Investments Limited, said. With geopolitical risks and global tariff pressures rising, the Union Budget is keenly awaited for cues on

growth support and fiscal discipline, he added. Among the Sensex firms, Tata Steel suffered the most, tanking by 4.57 per cent. ICICI Bank, Power Grid, HCL Tech, Tech Mahindra, Infosys and Kotak Mahindra Bank were also among the laggards. Mahindra & Mahindra, State Bank of India, ITC and Bharat Electronics were among the gainers. "Indian equity markets traded with a weak and cautious bias,

retreating from recent highs amid aggressive selling in metal and IT stocks. Mixed cues from overseas markets, along with persistent weakness in the rupee, capped intra-day recovery attempts. "Overall, sentiment remained cautious, with market participants balancing pre-Budget positioning against external headwinds," Ponnudi R, CEO of Enrich Money, an online trading and wealth tech firm, said.

ISRAELI AIR STRIKES KILL AT LEAST 28 Palestinians in Gaza, rescue officials say

At least 28 people have been killed in a wave of Israeli air strikes across the Gaza Strip on Saturday, according to local authorities. The civil defence agency, which is operated by Hamas, says children and women were among those killed. It added that in one attack, helicopter gunships hit a tent sheltering displaced people in the southern city of Khan Younis. Palestinians have described these strikes as the heaviest since the second phase of the ceasefire, brokered by President Trump in October, came into effect earlier this month. The Israeli military confirmed that a number of strikes were carried out in response to what it said was a Hamas violation of the agreement on Friday. Both Israel and Hamas have accused each other of violating the truce since it came into effect last year. In a statement, the Israel



Defense Forces (IDF) said "eight terrorists were identified exiting the underground terror infrastructure in eastern Rafah", an area in Gaza where Israeli forces are deployed under the October agreement. The IDF said it had, together with the Israel Security Agency (ISA), struck targets in various locations

including "four commanders and additional terrorists" as well as a weapons storage facility, a weapons manufacturing site and "two launch sites belonging to Hamas in the central Gaza Strip". Hamas has condemned the strikes and urged the US to take immediate action, adding that "these ongoing violations"

confirm that the Israeli government "continues its brutal war of genocide against the strip". It said that seven of the victims were from one displaced family in Khan Younis, with a civil defence spokesman adding that the strikes hit residential apartments, tents, shelters and a police station.

Officials at Gaza City's Shifa hospital said an air strike on the city hit a residential apartment, killing three children and two women. "We found my three little nieces in the street. They say 'ceasefire' and all. What did those children do? What did we do?" said Samer al-Atbash, an uncle of the three dead children, according to Reuters news agency. Video footage and images from across Gaza showed several bodies being lifted out of rubble and a number of buildings destroyed. The war between Israel and Hamas began after the Hamas-led attack on southern Israel on 7 October 2023, when about 1,200 people were killed and 251 were taken hostage. Israel responded by launching a military campaign in Gaza, during which more than 71,660 people have been killed, according to the Hamas-run health ministry.

It says at least 509 Palestinians have been killed since the ceasefire began on 10 October 2025. Four Israeli soldiers have also been killed. Though Israel has previously disputed figures from the Hamas-run health ministry, a senior security source was reported by local media as saying that the military accepts that more than 70,000 Palestinians have been killed during the war in Gaza. The health ministry's figures have been deemed reliable by the UN and other human rights groups and widely cited by international media. Israel does not allow news organisations, including the BBC, into Gaza to report independently. The strikes come as the Rafah crossing, Gaza's border with Egypt, is due to reopen on Sunday after the IDF recovered the body of Israel's last hostage earlier this week.

Israel split over plans to bring back death penalty for deadly attacks



Israel has only twice used the death penalty against a convicted prisoner. The last time was more than sixty years ago, to hang the notorious Nazi war criminal, Adolf Eichmann. But in the wake of the Hamas-led attacks on 7 October 2023, Israel's deadliest ever day, there is a political push to pass a highly controversial new capital punishment law, targeting Palestinians convicted by Israeli courts of fatal terrorist attacks. "It's another brick in the wall of our defence," the far-right chair of the parliament

mentary national security committee, Zvika Fogel tells me. "To bring in the death penalty is the most moral, the most Jewish and the most decent thing." But human rights groups see the bill as "one of the most extreme legislative proposals" in the history of Israel. They argue it is unethical, and because it is designed to apply only to Palestinians, they say it will bring about "racialized capital punishment." There have been heated hearings in Israel's parliament involving rabbis, doctors, lawyers and security officials. Families whose loved ones were killed in the brutal assault on southern Israel more than two years ago, and in the fighting in the devastating war in Gaza that followed, have turned out to speak against and in favour of the legislation.

US government partially shuts down despite last minute funding deal



The US federal government has partially shut-down despite a last-ditch funding deal approved by the Senate. The funding lapse began at midnight US eastern time (05:00 GMT) on Saturday, hours after senators agreed to fund most agencies until September. The bill includes just two weeks' funding for the Department of Homeland Security, which oversees immigration enforcement, instead of shutting it down entirely. The bill has yet to be approved by the House of Representatives, which is out of session. US President Donald Trump struck the deal with Democrats after they refused to give more funding for immigration enforcement following the fatal shooting of two US citizens in Minneapolis by federal agents. It is the second such government shut-down in the past year and comes just 11 weeks after the end of the previous funding impasse that lasted 43 days, the longest in US history. That shut-

down in 2025, which spanned 1 October to 14 November, had widespread impacts on essential government services including air travel and left hundreds of thousands of federal workers without pay for weeks. This shutdown, however, is unlikely to be that long or widespread as the House of Representatives is set to be back in session on Monday. The White House, though, has directed several agencies, including the departments of transportation, education and defence to execute shut-down plans. "Employees should report to work for their next regularly scheduled tour of duty to undertake orderly shut-down activities," a White House memo to agencies said. "It is our hope that this lapse will be short." Trump has urged Republicans, who hold the majority of seats in the US House, to vote for the deal. Lawmakers plan to use the fortnight in which the DHS will continue to be funded to negotiate a deal.

A fiery tweeter who is in charge of Uganda's military, Gen Muhoozi Kainerugaba is decried by his critics as being in the middle of an unholy trinity, or alliance, of three men who rule the East African nation with an iron fist. Kainerugaba, the son of the country's long-time leader Yoweri Museveni, has posted on social platform X about the killing of opposition supporters during this month's

fiercely contested presidential election. In posts which were subsequently deleted, he also threatened to have the testicles of defeated opposition candidate Bobi Wine removed. With the 81-year-old president winning a seventh term, analysts say this is likely to be his last term and he is grooming his 51-year-son to succeed him. The so-called "unholy alliance" - a play on the Christian doctrine of the Holy Trinity - is made up of Museveni, Kainerugaba, and the president's powerful brother and special adviser, Salim Saleh. Kenya-based analyst for the Institute for Security Studies think-tank, Nicodemus Minde, tells the BBC that he heard the description during a recent research trip to Uganda.

PEDRO PASCAL AND MERYL STREEP LEAD TRIBUTES TO CATHERINE O'HARA

Meryl Streep, Pedro Pascal and Ben Stiller are among celebrities to have paid tribute to Emmy-winning actor Catherine O'Hara, who died on Friday aged 71. The Canadian-born star was best known for her roles in the films Beetlejuice and Home Alone, as well as comedy TV series including Schitt's Creek and The Studio. Streep said O'Hara brought "love and light to our world, through whipsmart compassion for the collection of eccentrics she portrayed", while The Last of Us co-star Pascal said he was "eternally grateful" to have worked with her. Ben Stiller said it was "hard to explain the impact she had on comedy", adding that for him there was "no one better". O'Hara died on Friday at



her home in Los Angeles following a brief illness, her agent told the BBC. After starting her career in Canada's comedy scene, she turned out a series of unforgettable film performances netting her critical acclaim. Streep, who appeared alongside O'Hara in the 1980s comedy Heartburn, described her death as "such a loss for her family and friends, and the audience she graced as friends". Michael Keaton,

who co-starred in 1988's Beetlejuice and its 2024 sequel Beetlejuice Beetlejuice, remarked: "We go back before the first Beetlejuice. She's been my pretend wife, my pretend nemesis and my real life, true friend. 'This one hurts. Man am I gonna miss her.' Tim Burton, who directed both films, shared a picture of the cast of the latter film on Facebook. "Catherine, I love you," he said. "This picture shows

how much light you gave to all of us. You were a special part of my life and after-life." Alec Baldwin, who also starred in the film, said O'Hara possessed "a quality that was all her own" and described her as "one of the greatest comic talents in the movie business". In his tribute, Pascal said "there is less light in my world" adding: "This lucky world that had you will keep you, always." Her on-screen son in holiday classics Home Alone and Home Alone 2: Lost In New York, Macaulay Culkin, also paid an emotional tribute on Instagram. "Mama. I thought we had time. I wanted more. I wanted to sit in a chair next to you," he wrote. "I heard you. But I had so much more to say. I love you. I'll see you later."

WHAT WE LEARNED - AND DIDN'T - FROM THE MELANIA DOCUMENTARY

From televised cabinet meetings to late night Truth Social posts, US President Donald Trump has rarely stepped out of the spotlight since he resumed office in January. But more often than not, he's done it without his wife. So where is Melania? A new documentary co-produced by the first lady herself aims to answer that question. Melania: 20 Days to History promises viewers an intimate glimpse into Melania Trump's life in the days leading up to her husband's January 2025 inauguration. The film opened in cinemas across the US on Friday amid controversy. It has received



significant attention from administration critics and watchdogs, who have criticised the project's funding and dismissed the timing of its release as insensitive as mass protests swell over two fatal shootings by federal agents in Minneapolis. Politics aside, those seeking answers about how

Trump spends her time might find the film unsatisfying - much of it shows her in transit, at public events or drifting between meetings to review fabric samples and dinnerware. Still, small interactions with her closest friends offer some glimpses at how the famously enigmatic first

lady is approaching her husband's second term. "Everyone wants to know, so here it is," she says in an opening voiceover. Here's what we've learned from watching the film - and what we didn't. Early on, Trump is clear about her intent: "I want to show the American people my journey from private citizen to first lady." The film touches briefly on the controversy around its creation, in a meta moment that shows Trump's staff fielding an inquiry from a journalist about its commission. It is a co-production from Trump herself and director Brett Ratner, along with other partners.

Pokémon cancels event at controversial Japan shrine following backlash



A Pokémon card game event at a shrine honouring Japan's war dead has been cancelled following a backlash in China. The Pokémon Company apologised for advertising the event, organised by a certified third party, through its official website, and said it "should not have been held in the first place". The event was due to be held on Saturday at the Yasukuni Shrine, near the Imperial Palace in Tokyo, which commemorates those who died in several wars including convicted war criminals. The blunder comes at a moment of worsening relations between China and Japan over the stance of the latter's new prime minister on Taiwan. The Yasukuni Shrine honours Japanese soldiers who died in a number of wars, including both Sino-Japanese wars and the Pacific theatre of World War Two. But the enshrinement of the names of more than 1,000 convicted war criminals among the roughly 2.5 million people it honours has long made it a controversial site for nations that were subject to harsh treatment under Japanese occupation. "Brands that disregard history and hurt the feelings of

the Chinese people will ultimately be abandoned," the People's Daily, the Chinese Communist Party's official news site, commented when the event came to light earlier this week. "The relevant enterprises must accordingly take social responsibility and not make light of the heavy weight of history in the name of entertainment." Meanwhile, the state-run Global Times praised "China's young netizens" for criticising the event, adding: "Any enter-tain-ment or leis-ure activ-i-ties held at such a site consti-tute an open affront to his-tor-ical truth, and sta-ging events aimed at children there is even more egre-gious." The Pokémon Company said in a statement on Friday that the event had been "mistakenly posted" on its official card game website "due to a lack of due diligence". "After the incident was discovered, the event was promptly cancelled," it said. "We sincerely apologise for the various reactions and opinions that have been generated as a result of this publication." The firm said it would "thoroughly review and strengthen" its approval process to prevent a similar incident from occurring again.

Takeaways from the millions of newly released Epstein files

Millions of new files relating to the late sex offender Jeffrey Epstein have been released by the US Department of Justice, the largest number of documents shared by the government since a law mandated their release last year. Three million pages, 180,000 images and 2,000 videos were posted publicly on Friday. The release came six weeks after the department missed a deadline signed into law by US President Donald Trump that mandated all Epstein-related documents be shared with the public. "Today's release marks the end of a very comprehensive document identification and review process to ensure transparency to the American people and compliance," Deputy Attorney General Todd Blanche said. The files

include details about Jeffrey Epstein's time in prison - including a psychological report - and his death while incarcerated, along with investigative records on Ghislaine Maxwell, Epstein's associate who was convicted of helping him traffic underage girls. They also include emails between Epstein and high-profile figures. Many of the emails and documents go back more than a decade, showcasing Epstein's relationships amid his legal troubles. He was convicted in 2008 in Florida for soliciting sex from a 14-year-old girl after coming to a controversial plea agreement with prosecutors. He died in August 2019 while in jail on charges in a sprawling sex trafficking case. Epstein invited 'The Duke' to meet Russian woman The docu-



ments shed light on the disgraced financier's close association with Britain's elite. They include emails between Epstein and a person named "The Duke" - believed to be Andrew Mountbatten-Windsor - discussing having dinner at Buckingham Palace, where there was "lots of privacy". Another message from Epstein includes an offer to introduce "The Duke" to a 26-year-old Russian woman.

The emails are signed "A", with a signature that appears to read "HRH Duke of York KG". They were exchanged in August 2010, two years after Epstein pleaded guilty to soliciting a minor. The emails do not indicate any wrongdoing. The BBC has contacted Andrew, formerly known as the Duke of York, for a response. Mountbatten-Windsor has faced years of scrutiny over his past

friendship with Epstein. He has repeatedly denied any wrongdoing. Some emails in the latest release appear to be between Epstein and Sarah Ferguson, Andrew's ex-wife. One email dated 4 April 2009, was signed "Love, Sarah, The red Head.!!" It says that she was going to be in Palm Beach and wanted to have tea. The email goes on to discuss ideas for Ferguson's company, Mother's Army. The former Duchess of York refers to Epstein as "My dear spectacular and special friend Jeffrey". She calls him a "legend" and says "I am so proud of you". The financier was still under house arrest for his 2008 conviction when the email exchange was sent. Epstein sent money to Mandelson's husband Other emails show Epstein sent £10,000 (\$13,692) to Lord

Peter Mandelson's husband Reinaldo Avila da Silva in 2009. In an email to Epstein, da Silva sets out the costs of an osteopathy course, provides his bank details and thanks the financier for "anything you can help me with". Epstein replies a few hours later saying he would wire the loan amount and da Silva, who married Mandelson in 2023, replies with a thank you the following day. In another batch of emails, Lord Mandelson asks to stay at one of Epstein's properties. The emails are from 16 June 2009, when Epstein was serving a prison sentence for soliciting prostitution from someone under the age of 18. For much of his sentence, Epstein was allowed to work from his office during the day and returned to jail each night.

India vs Pakistan, U-19 World Cup:

5 Players Who Hold The Key In Battle For Last Semi-Final Spot

India face Pakistan in a crucial U-19 World Cup Super Six match in Bulawayo on Sunday. With three semi-final spots already booked, the result of the India vs Pakistan clash will decide the fourth semi-finalist. While Vaibhav Suryavanshi will be in focus, several other Indian players will also hold the key in the game. India lost to Pakistan by 191 runs in the Under-19 Asia Cup final in Dubai last December after winning the group match of the same tournament against the arch-rivals by 90 runs. Here are the key players in the India vs Pakistan clash: Wicketkeeper Abhigyan Kundu (183 runs from four matches, highest score 80) and Vaibhav Suryavanshi (166 runs from four matches) have been consistent with the bat, scoring two fifties each. However, both will



look to convert those starts into three-figure scores. Vihaan Malhotra (151 runs from four matches) is another batter India will be banking on. The left-hander smashed an unbeaten 109 against Zimbabwe in the last match and will be eager to continue his good form. On

the bowling front, right-arm medium pacer Henil Patel (10 wickets in four matches) and left-arm fast bowler Udhav Mohan, who picked up three wickets in the previous match against Zimbabwe, have been stand-out performers for India. Skipper Ayush Mhatre also

impressed with his off-breaks, taking three wickets against Zimbabwe, while right-arm medium pacer RS Ambrish has been among the wickets with the new ball. What About Pakistan Pakistan, on the other hand, lost their opening group game against England but

bounced back with wins against Scotland and Zimbabwe. They notched a comprehensive eight-wicket win over New Zealand in their Super Six match on January 27 and head into the India clash with confidence. Opener Sameer Minhas, who orchestrated India's defeat in the U-19 Asia Cup final with a magnificent 172, has been in impressive form in the tournament. BARCELONA 'SHAKEDOWN' OFFERS FIRST HINTS OF F1 2026



Mercedes were pre-season favourites for 2026 long before any of the new cars ran on track, and nothing that happened in the Formula 1 'shakedown' in Spain this week has changed that. The new Mercedes made a strong impression on rivals. The team did the most miles, and set the fastest times while the car was on the track, albeit Lewis Hamilton posted the quickest time of the week late on the final day in the Ferrari. The seven-time champion's lap of one minute 16.348 seconds pipped George Russell's best for Mercedes, set the previous day, by 0.097 seconds. World champion Lando Norris was second fastest on the final day, and third over-

all, in the McLaren, 0.246secs off Hamilton. Judging performance from pre-season testing is always fiendishly difficult because of the number of variables involved, all the more so after a week such as this. The test was held behind closed doors, with no independent media allowed access. No official timing

was released. Only very few photographs were taken, and most of those were vetted by the teams who released them. The test was exactly how it was billed - a shakedown is motorsport terminology for giving a car a first run-out to make sure everything works. On top of that, everything the teams were using was new - cars,

engines, tyres and fuel - after the biggest regulation change in the sport's history. Testing outright pace was very much not on the agenda for anyone. So the headline lap times meant almost nothing, not that that erases the general impression that Mercedes are in the best place at this early stage. The test was all about learning about the new cars and, particularly, the new power-units. It was held in private because teams were scared by memories of the last time new engines were introduced, in 2014, when many suffered major reliability problems. But those fears did not come to fruition, partly because the standards in F1 are so high these days.

FOREST AGREE ORTEGA DEAL AND TARGET INTER'S FRATTESI



Nottingham Forest have agreed a deal for Manchester City goalkeeper Stefan Ortega worth up to £500,000. Sean Dyche's side are also trying to sign Inter Milan midfielder Davide Frattesi, initially on loan with the option for a permanent transfer. The 26-year-old has won 33 caps for Italy and has played 19 games for Inter this season. German Ortega, 33, is currently third choice at the Etihad behind Gianluigi Donnarumma and James Trafford. He is out of contract this summer and is yet to feature for Pep Guardiola's side this season. Forest's need for a keeper stems from a knee injury suffered by John Victor that is set to rule

him out for the rest of the season. The City Ground club had held talks with Wolves over a move for Jose Sa, but have since pivoted to Ortega. Ortega has played 56 games for City since joining in 2022 and played a key role in their Premier League title win in 2024. He played 22 games last season, including appearances in the Club World Cup in July and the FA Cup final defeat by Crystal Palace. Forest, who are in the Europa League play-offs and are 17th in the Premier League, have already signed Napoli striker Lorenzo Lucca on loan and had a bid of £35m rejected by Crystal Palace for striker Jean-Philippe Mateta.

Reaction & analysis as Rybakina overcomes Sabalenka to win Australian Open

World No. 5 Elena Rybakina launched an incredible comeback in the final set to break World No. 1 Aryna Sabalenka twice and clinch the Australian Open 2026 women's singles title. Rybakina won the first set 6-4, breaking Sabalenka in the very first game of the match. Sabalenka roared back to win the second set 6-4, and soared into a dominant 3-0 lead in the deciding third set. "I want to be real hands on, I want to take the club in a direction maybe it hasn't been before," he told Wales Online., external "We want to take Swansea to the Premier League, and to do that we are going to need money -



that's the reality of the game these days. "I want to introduce sponsorship deals and publicity that will make them a global name." The West Coast rapper has sold more than 30 million albums worldwide but is yet to attend a Swansea game, though his son Cordell Broadus was in the direc-

tors' box for the Welsh side's draw with Watford last August. American billionaire businesswoman Martha Stewart, who joined Snoop Dogg and Real Madrid legend Luka Modric as a Swansea co-owner in December, was in Wales for the game against Wrexham just before Christmas.

Swansea have said Snoop Dogg is likely to attend a game at some point this season, though there is still no confirmation of when he may appear at the Swansea.com Stadium. "For real I want to meet with the fans," Snoop Dogg said. "These fans are passionate, they are real, and I want to hear what they got to say when I am in Swansea. "I knew I always wanted to invest in a soccer team - it's been a dream of mine for years, it was all about waiting for the right opportunity." Modric was the first celebrity name to get involved at Swansea, with the former Ballon d'Or winner named as a co-owner last April.

When Dominic Calvert-Lewin left Everton last summer after nine years with the club, he could be forgiven for being a little fearful of what his future held. The striker struggled with injuries in the latter stages of his Toffees career and managed just three goals in his final season, meaning whoever did sign him was likely taking a bit of a risk. But that gamble has paid off for Leeds, with Calvert-Lewin having revived his career with an excellent scoring run under Daniel Farke, scoring seven goals in his past six games. That form has also led to talk of his return to the England squad and possibly even a place at the 2026 World Cup - something that seemed very unlikely just six months ago. Calvert-Lewin sat down with BBC Sport's Betty Glover to talk about his return to goalkeeping, the reality of being a free agent and his England chances. After almost a decade at Everton, the change of scenery has clearly done Calvert-Lewin the world of good. With nine Premier League goals he has outscored big-money arrivals like Hugo Ekitike, Viktor Gyokeres and

Benjamin Sesko. "I just felt like I needed a fresh start," he said. "I think that I'd gone from a 19-year-old boy to a 28-year-old man and deep down a fresh start is what I felt like I needed. "So obviously when communication started with Leeds, I felt that this was the place for me to come in and thrive and get back to my best level." Key for Calvert-Lewin has been the faith Farke has shown in him. The German coach said recently that he had always been a big fan of Calvert-Lewin and would always sign him if the opportunity presented itself. "I had a phone call with him one or two days before I signed and he spoke for maybe 30 minutes," Calvert-Lewin said of his first conversation with Farke. "I was just listening and his personality came through. I could tell that he was a caring person and he cared about his players, and he was just emphasising how he wanted to get me back to my best level. "That relationship's just grown and grown and grown. "You know he has a human side, which I think that then gets the players to be more attentive to the messaging and ultimately makes us play better."
