Cong to win Nizamabad Corporation, 7 municipalities: CM Revanth

HYDERABAD / NIZAMABAD TSIT BUREAU: Chief Minister A. Revanth Reddy on Thursday expressed confidence that the Congress party would win the Nizamabad Municipal Corporation along with seven municipalities in the district in the upcoming civic elections. Addressing a large public meeting in Nizamabad, he said voters were ready to give a decisive mandate in favour of Congress. The Chief Minister



said Nizamabad has a rich political and agricultural legacy and has produced leaders with clean public records. He

alleged that despite long years of BJP rule at the Centre and BRS governance in the State, major civic and infrastructure issues in the district remained unresolved. He questioned BJP MP Dharmapuri Arvind over the absence of key projects such as Smart City status, an airport, and an outer ring road. Highlighting development initiatives, Revanth Reddy said Rs.600 crore had been sanctioned for educational institutions and about Rs.1,045 crore was being spent on municipal works in the undivided Nizamabad district.

INDIA CREATES HISTORY: India defeat England, win sixth Under-19 World Cup



Harare (TSIT): Batting prodigy Vaibhav Sooryavanshi lit up the grand stage with a jaw-dropping 175 to power India to a record-extending sixth ICC Under-19 World Cup title with a 100-run victory over England in the final here on Friday. The triumph adds to India's previous titles in 2000, 2008, 2012, 2018 and 2022, underlining their dominance in the tournament's history. The 14-year-old Sooryavanshi blazed his way to a stunning

175 off just 80 balls, recording the fastest 150 in Under-19 cricket history, reaching the milestone in 71 deliveries, as India piled up a daunting 411 for 9 after electing to bat. In response, England kept the required run rate within sight for large parts of the chase but lost wickets at regular intervals, which steadily derailed their pursuit. They were eventually bowled out for 311 with Caleb Falconer scoring a 66-ball 115. Sooryavanshi, who shot into the lime-

light during last year's Indian Premier League, smashed 15 sixes and an equal number of boundaries, registering the highest individual score by any batter in an ICC tournament final. **Brief Scores: India 411/9 in 50 overs (Vaibhav Sooryavanshi 175, Ayush Mahatre 53; James Minto 3/63, Sebastian Morgan 2/74). RBI holds rates at 5.25%, keeps neutral stance as inflation outlook improves



Mumbai (TSIT) India's central bank on Friday kept its key policy rate unchanged and maintained a neutral policy stance, citing easing inflation pressures, strong economic fundamentals, Reserve Bank of India Governor Sanjay Malhotra said after the Monetary Policy Committee (MPC) meeting. The Monetary Policy Committee (MPC) unanimously decided to hold the policy repo rate at 5.25% at the conclusion of its monetary policy review. All other policy rates were also left unchanged. Malhotra said, "Indian economy remains resilient; Monetary policy will be guided by new inflation data based on revised series." Malhotra added geopolitical tensions remain elevated and global trade pressures are rising, but the Indian economy continues to show resilience. The RBI projected retail inflation at 3.2 percent in the fourth quarter of the current fiscal year and 2.1% for the full year. Inflation is expected to rise to 4.0% in the first quarter of FY27 and 4.2% in the second quarter, largely due to a sharp increase in gold and silver prices, the governor said.

31 killed, 169 injured in suicide attack in Pak



Islamabad (TSIT) A suicide bomber blew himself up at a Shia mosque during Friday prayers in Pakistan's capital, killing at least 31 people and injuring 169, said officials, in one of the worst terror attacks targeting the community in recent years. The powerful explosion, which was heard from a far distance, took place at Khadijatul Kubra mosque-cum-imambargah in the Tarlai area of Islamabad, the police said in a statement. The suicide bomber was stopped at the gate of the imambargah, but he detonated himself, police and eyewitnesses said. At least 31 people were killed and 169 others injured in the explosion, a district administration spokesperson said in a post on X. No group immediately claimed responsibility for the blast.

Ghee made with bathroom cleaners used in Tirupati laddu, says CM Naidu

Amaravati (TSIT) : Andhra Pradesh Chief Minister N. Chandrababu Naidu, on Friday, claimed that Tirupati laddu was prepared with ghee made with chemicals used for cleaning bathrooms during the previous YSR Congress Party (YSRCP) government's tenure. He accused the YSRCP of trying to tarnish the sanctity of Sri Venkateswara Swamy Temple by adulterating the 'prasadam' (offering).

"For five years, they (YSRCP) had made 'prasadam' with ghee prepared from chemicals. The ghee was made with chemicals used for cleaning bathrooms," the Chief Minister said. Chief Minister Chandrababu Naidu was addressing a public meeting at Yemmiganur in Kurnool district on the occasion of distribution of 'your land - your right' pattadar passbooks among farmers. He said that YSRCP leader and former Chief Minister Y.S. Jagan Mohan Reddy is claiming that the Central Bureau of Investigation and Special Investigation Team gave them a clean chit but his own



uncle Y.V. Subba Reddy, who served as the Chairman of Tirumala Tirupati Devasthanam (TTD), admitted that adulteration did occur. The Chief Minister claimed that he tried to rectify the situation after YSRCP desecrated the TTD with adulterated prasadam. He said that there is a significant difference between the laddu offered in the past and the laddu offered now. He also accused the YSRCP of engaging in a show of strength for political purposes instead of fighting for public issues. A show of strength should be done during elections, Chief Minister Chandrababu Naidu remarked. Referring to Jagan Mohan Reddy's recent visit to Guntur, Chandrababu Naidu said he caused inconvenience to motorists. "In the past, they


ran over a person named Singayya under their convoy. In Bangarupalyam, they threw mangoes on the ground, trampled on them, and engaged in hooliganism," the Chief Minister said, adding that he knows how to deal with this kind of politics. He said the Telugu Desam Party-led coalition government in Andhra Pradesh was providing pattadar passbooks to farmers with all security features to prevent tampering of land records. He made it clear that anyone attempting to manipulate the records will be sent to jail. He criticised his predecessor Jagan Mohan Reddy for issuing passbooks with his photograph. "Who is he (Y.S. Jagan Mohan Reddy) to put his photos on the land inherited from our ancestors," the Chief Minister asked, and accused the YSRCP leader of spending Rs 700 crore to put his pictures on land survey stones. Chief Minister Chandrababu Naidu alleged that the YSRCP leaders tried to seize lands of farmers through fraudulent methods.





Pawan Kalyan urges people to be ‘conscious guardians of Dharma’

Amaravati, Feb 6 : Andhra Pradesh Deputy Chief Minister Pawan Kalyan on Friday called upon people to act as conscious guardians of dharma. In the wake of the controversy over alleged adulteration of ghee used for making sacred Tirupati laddu, the Jana Sena leader reminded Hindus of their dharmic responsibility.

“Every devotee carries a Dharmic responsibility! Let us come out of the slumber and convenience of an average Hindu mind, where there is a fear of God and respect for faith.

“However, when someone desecrates Hindu Gods or mocks our Dharma, we often feel hurt in private, leave it to karma, and move on. This must change,” Pawan Kalyan said in a post on ‘X’. “Though we may be divided by caste, creed, region, and language, the Dharma is one and the gods remain the same. It is indeed our duty to voice our pain when our Dharma and



faith are deliberately mocked with malicious intent. Silence in such moments weakens the collective conscience,” he said.

“Beyond being devotees, we must also act as conscious guardians of our faith. Protecting Hindu Dharma does not mean being against other faiths. It simply means safeguarding one’s own,” added the actor-politician. He used the hashtags ‘no ghee in TTD laddu’ and ‘Sanatana Dharma Raksha Board’. Pawan Kalyan along with Chief Minister N. Chandrababu Naidu, state BJP president PVN Madhav and several ministers had

addressed a joint press conference on Thursday. They denied that the CBI’s SIT gave the previous Andhra government the clean chit in the Tirupati laddu adulteration case and accused it of committing a grave sin. The Jana Sena leader quoted CBI as stating that substance used for making laddus is not prepared from milk fat. He claimed that no ghee was used and that the substance used was made from chemicals. Chief Minister Chandrababu Naidu on Friday claimed that the Tirupati laddu was prepared with ghee made with chemicals used for cleaning bathrooms. He accused the YSRCP of trying to tarnish the sanctity of Sri Venkateswara Swamy by adulterating the prasadam (offering). “For five years, they had made prasadam with ghee prepared from chemicals. The ghee was made with chemicals used for cleaning bathrooms,” he said at a public meeting in Kurnool district.

Kishan Reddy slams CM Revanth over religion-based reservations



New Delhi: Union Minister of Coal and Mines G. Kishan Reddy on Thursday strongly criticised Telangana Chief Minister A. Revanth Reddy over his remarks on making the 4 per cent Muslim reservation permanent, accusing the Congress of pursuing religion-based appeasement politics at the cost of social justice. In a statement, Kishan Reddy said the Congress party’s approach validated Prime Minister

Narendra Modi’s observation that the party had effectively turned into a “Muslim League Congress.”

He alleged that the Telangana Congress government was attempting to institutionalise religious reservations by submitting documents to the Supreme Court, despite such quotas having been struck down twice earlier by the High Court as unconstitutional. The Union Minister

claimed the Congress had a two-pronged agenda — retaining the 4 per cent Muslim reservation and adding another 10 per cent by including Muslims under the backward classes category, effectively pushing reservations to 14 per cent on religious lines.

He further alleged that under the guise of a caste survey, the Congress government inflated BC population figures and included 10 per cent Muslims in the BC list, thereby reducing the effective quota meant for genuine backward classes. Referring to the 2020 GHMC elections, Kishan Reddy said a majority of BC-reserved seats were won by non-BC candidates, undermining the purpose of reservations. Warning that the people of Telangana were closely watching these developments, he said the Congress would face electoral consequences for betraying the principles of constitutional equality and social justice.

35 Years of Pain Ends with Rare High-Risk Surgery at Medcover Hospitals

Hyderabad, 06 February, 2026: Medcover Hospitals has successfully treated a 43-year-old woman who had been living with severe back pain and continuous discharge for over 35 years, in a rare and high-risk surgical intervention.

The patient had undergone multiple surgeries nearly 30 years ago outside India for a swelling in the lower back, with no medical documentation available. Despite these procedures, her symptoms persisted for decades, significantly affecting her quality of life.

After presenting to Medcover Hospitals, the patient was evaluated by Dr Venkata Pavan Kumar, Senior Surgeon. Advanced CT imaging revealed a large sacral (tailbone) tumor involving the spinal cord and rectum, a rare presentation associated with a high risk of neurological injury and bowel complications. Sacral tumors account for less than 5% of all spinal tumors, making such cases uncommon and technically demanding.

Given the complexity, a multidisciplinary surgical



approach was planned and executed. The team included Dr Aneel Kumar, Neurosurgeon; Dr Damodar Kakumanu, Trauma Surgeon; Dr Rajasekhar Madala, Plastic Surgeon; and Dr Venugopal N, Chief Anaesthesiologist. The high-risk surgery lasted nearly six hours and required meticulous coordination across specialties. The surgical team successfully removed a large tailbone tumor measuring approximately 15 cm × 20 cm, carefully separating it from the spinal cord and rectum. Following tumor excision, advanced flap reconstruction was performed to manage the extensive defect and

ensure proper wound healing. Despite the prolonged duration and high-risk nature of the procedure, the surgery was completed without neurological deficits. The patient’s postoperative recovery was smooth, and on follow-up, she is pain-free, free from discharge, and has returned to normal daily activities—bringing an end to decades of chronic suffering. Doctors at Medcover Hospitals stated that the success of this case highlights the importance of early specialist evaluation, advanced imaging, and coordinated multidisciplinary care in managing rare and long-standing spinal conditions.

THE DESCENT OF
MAN (AND MP) - BY
SHASHI THAROOR

One often hears of an MP's "precipitous drop" in political fortunes, but I hadn't expected to illustrate the metaphor so physically on the steps of Parliament on Wednesday. Having spent decades navigating the slippery slopes of policy and the treacherous inclines of debate, it was, quite ironically, a simple marble step that proved to be my undoing. One has often been warned about the dangers of "shooting oneself in the foot" in the political arena, but I have managed the far more literal, if slightly less dignified, feat of tripping over it. It was a singular, unassuming step outside the House that finally brought me low - in full view, mortifyingly, of the television cameras.

One often hears of an MP's "precipitous drop" in political fortunes, but I hadn't expected to illustrate the metaphor so physically on the steps of Parliament on Wednesday. Having spent decades navigating the slippery slopes of policy and the treacherous inclines of debate, it was, quite ironically, a simple marble step that proved to be my undoing. One has often been warned about the dangers of "shooting oneself in the foot" in the political arena, but I have managed the far more literal, if slightly less dignified, feat of tripping over it. It was a singular, unassuming step outside the House that finally brought me low - in full view, mortifyingly, of the television cameras.

My initial reaction was to make light of it, quote-tweeting a video-post of the incident with a Hindi couplet: "Jis diye ko toofaan me jalna hoga, usey sambhal sambhal ke chalna hoga" ("a lamp that must stay lit in a storm must watch its step"), and adding, "I am okay." Except that, as I found out when I got an X-ray done the next morning, I wasn't.

A "Bottom-Up" View

I had initially hoped my tweet - invoking that resilient lamp braving the storm - would be the final word on the matter. Alas, the medical profession has a way of grounding one's poetic flights of fancy. An X-ray, that most uncompromising of critics, has revealed a hair-line fracture. Consequently, I have been "sentenced" to a month of immobilisation, a regimen of anti-inflammatories that should ideally temper the rhetoric of some other politicians, and an Air Cast on my right foot that is significantly less aerodynamic than its name suggests. This bulky contraption, coupled with a stern medical admonition against perambulation, has effectively "grounded" me in a way my political opponents never quite managed. I now find myself navigating the corridors of power from the vantage point of a wheelchair, a transition that brings with it a certain rueful perspective. There is, I've discovered, a profound humility in being eye-level with the waistbands of one's colleagues; it gives one a literal "bottom-up" view of Indian democracy that is as enlightening as it is humbling. I have become, quite overnight, a man of "wheel-power" rather than willpower, though I suspect the pace of my progress through the Makar Dwar and into the Lok Sabha chamber will now be measured in rotations rather than strides. While I have long advocated for "moving the needle" in Parliament, I didn't anticipate doing so on four wheels. Of course, it is salutary for anyone with delusions of grandeur to be confined to the View from Below. One notices quickly that the world looks quite different when you are eye-level with the gun holsters of the security guards.

"If The Lamp Must Watch Its Step..."

Despite this involuntary shift to a more sedentary existence, I have no intention of letting a mere headline fracture impede the business of the people. While my gait has been forcibly slowed, my resolve remains unfractured. I fully intend to chair my Committee meetings with the same commitment (though perhaps less pacing), deliver my speeches from a seated position - a posture that, I am told, lent the legendary FDR a certain gravitas - and be steered through Parliament with the navigational precision of a slow-moving tugboat. There is a certain rueful irony in being silenced by a stair after surviving so many scuffles at the dispatch box. However, I am embracing this temporary "static" phase of my career. If the lamp must watch its step, it might as well do so while enjoying the comfort of a padded footrest. I shall simply have to ensure that my rhetoric remains more balanced than my gait.

Trust Tested: What The India-US Trade Deal Really Signals

The India-US trade deal comes at a critical moment not only for bilateral relations, but amid a broader churn in the global political economy. While the fine print of the agreement is yet to emerge, the initial impression suggests that India may not have conceded significant ground. Crucially, the deal arrives at a time when preventing disruption to sectors asymmetrically dependent on the US market was essential, thereby averting a potential hard landing for the Indian economy. At one level, the agreement in principle is symbolic of the underlying trust that managed to endure a period of pronounced political turbulence in the relationship. At another, it reflects a calculated jostling between two large economies seeking to safeguard their respective domestic interests and geoeconomic positioning. The deal marks the end of a phase in which two decades of steady investment in trust-building gave way to a period of strain. More critically, this phase had pushed questions of geopolitics, regional balancing in the Indo-Pacific, and perhaps most importantly, strategic trust to the back burner. In that sense, the agreement was much needed to restore momentum at a time when global conflicts are intensifying, and protectionism is once again on the rise. Nothing Is To Be Taken For Granted One of the most important lessons from the past six months of intense negotiations and strain with the United States is that, for India, nothing in geopolitics can be taken for granted. Every nation must continuously curate and defend its own interests. It is, however, unfortunate that a protectionist America seems to be closing the gate on long-standing conversations around open economies and free trade. When the world's largest economy adopts the kind of tariff-centric behaviour that the United States has recently displayed, the effects ripple across the global system, impacting emerging and consequential economies most acutely. Donald Trump's approach to negotiations, his transactional tactics, and his disregard for normative and institutional frameworks offer a stark lesson for the world. For India, the experience of the last six months



should be particularly instructive in hindsight. The India-US relationship had, until recently, been anchored in strong political ties between two democracies, a deep diaspora connection, technology transfer, a robust defence partnership, and a growing great-power resonance - an alignment that took clearer shape since the George W. Bush administration, if not earlier. Subsequent administrations of Clinton, Obama, Trump in his first term, and Biden expended considerable political capital in nurturing the relationship. Business and investment flows followed, further consolidating the partnership. Trump's first presidency, while widely viewed as an aberration from textbook governance, nevertheless offered early signals of disruption for India, most notably its removal from the Generalized System of Preferences (GSP). His policy reversals on climate and global governance now appear less anomalous and more symptomatic of a deeper rupture that fully unfolded in his second term. Yet, despite these disruptions, Trump's first term was not overtly antagonistic toward India and largely aligned with Indian interests globally and in the Indo-Pacific. His second term,

however, proved to be the proverbial eye of the storm. New Realities For India, the recent economic jostling with the United States has come at a glass-half-full moment. While global conflicts such as in Ukraine and Gaza provide some context for Trump's assertive behaviour, India's own rapid economic ascent has also altered power dynamics, not only with the United States but with other major powers as well. India's economic and geopolitical categorisation is shifting rapidly, driven by robust growth projections that place it among the fastest-growing large economies. As India climbs the power ladder, friction with established powers is inevitable, bringing new realities into a relationship that previously operated on different assumptions. The past six months have thus served as a meaningful stress test for the India-US relationship. They reveal not only that India is now viewed differently by major powers, but also that tactical geoeconomics, which is a Trumpian forte, cannot rest on trust alone. It requires the scaffolding of contingencies forged through moments of tension. Going forward, the India-US relationship is likely to be viewed through two distinct lenses: pre-Trump and post-

Trump. Not everything about this transition is necessarily negative. While the new realities may be uncomfortable for some in India, a pragmatic assessment suggests that the ground has shifted. One such reality is the imposition of an 18% tariff on Indian exports to the United States. Although these tariffs are not India-specific and in fact leave India among the least-tariffed economies in the Indo-Pacific, they nonetheless represent a structural change in the bilateral relationship. It is difficult to imagine a future US president with the political will or domestic support to fully reverse this new baseline. India and the United States will now have to move forward within this altered framework. The political agreement on the trade deal provides the necessary comfort on either side that was needed to assuage the domestic tensions in both countries, which are connected by a strong diaspora. The agreement could also help guide the domestic narrative, particularly in the United States, where nativist churn in the political discourse targeted at Indians from the American hard right may be chipping away at the foundations of the India-US relationship. The actual challenge now lies in implementing the promise of the trade deal.

Why Foreign Investors Are Growing Worried
About Their 'Minerals' Bets In Pakistan

Pakistan's geoeconomic ambitions find themselves in an anticipated predicament amid the resurgence of violence in the restive province of Balochistan. The Baloch Liberation Army (BLA) on January 31 launched the second phase of its 'Operation Herof', targeting over ten districts across the province. While conflicting casualty reports have emerged, local reports state the involvement of suicide bombers, including female fighters in the operation. In retaliation, the Pakistani security forces launched a counter-militancy operation and reported the killing of over 150 BLA-linked militants in the aftermath of the violence. During the operation, the authorities reportedly suspended mobile services in several districts, including the provincial capital of Quetta, and Mastung, Kalat, Khuzdar, Nushki, Dalbandin, and Kharan. Military measures have often accompanied communication blackouts as part of the state's response to security challenges in Balochistan. However, the Pakistani state framed the insurgency as externally driven, designating BLA militants as 'Pitna-al-Hindustan' to allege Indian involvement. Within hours of the incident, Pakistan's Interior Minister Mohsin Naqvi in a statement said, "These were not normal terrorists. India is behind these attacks. I can tell you for sure that India planned these attacks along with these terrorists." The Pakistani authorities have previously also accused Afghanistan and Iran's role in the Baloch militancy theater. While Baloch militants are known to operate out of southern Afghanistan and south-eastern Iran, Pakistan's accusations of state involvement continue to lack credibility or independently verifiable evidence. The Nushki Gateway During the operation, the BLA held control over Nushki, therefore highlighting the district as a critical flashpoint between the militants and Pakistani security forces. Strategic control over the territory of Nushki enables militants to sever the land link between the provincial capital, Quetta, and the western part of the province. More significantly, Nushki serves as the entry point to Chagai district, known to be the heart of Pakistan's mineral capital. Home to the Reko Di



gold and copper mines as well as the Saindak copper-gold project, Nushki holds considerable significance for Pakistan's currently expanding geoeconomic calculus. By maintaining a presence in the region, BLA has gestured with intention and capacity to disrupt the logistics of upcoming mining projects, which they have historically portrayed as 'colonial extraction' by the federal government. The focus on Nushki reflects the insurgents' strategy to exploit geographic bottlenecks and paralyse state-led economic corridors and extractive projects. Foreign investors must be closely monitoring the existing security faultlines in Pakistan's restive provinces. Weeks after Pakistan's Army Chief, Field Marshal Asim Munir, showcased a briefcase of mineral samples in the presence of Pakistani Prime Minister Shehbaz Sharif at the White House in September 2025, Washington signalled interest in Pakistan's purportedly untapped mineral resources. Billions Invested In December 2025, the US Export-Import Bank approved USD 1.25 billion in financing for the Reko Diq copper-gold mining project, with US President Donald Trump publicly expressing business interest in Pakistan. In the following days, the 7th China-Pakistan foreign ministers' Strategic Dialogue's joint statement

announced the prioritisation of the mining sector on January 4. Meanwhile, Pakistan's Federal Minister for Petroleum Ali Pervaiz Malik held a meeting on January 28 with the Australian High Commissioner to discuss bilateral cooperation in the mining and rare earth sectors. While analysts have been tempted to frame the narrative around Pakistan's mineral wealth as a US-China competition, the domestic security challenges warrant foremost attention. For foreign investors, it is expected to remain an irritant, also considering that Pakistan's internal security resources already remain stretched thin. Alongside separatist violence in Balochistan, Khyber Pakhtunkhwa remains a conflict zone with the continued operations of Islamist factions, most prominently the Tehreek-e-Taliban Pakistan (TTP). In the Balochistan insurgency, the reported involvement of female fighters in active combat operations underscores the current character of the insurgency. This marks a big shift from the auxiliary roles Baloch women have historically played in the insurgency, thereby suggesting an expansion of the recruitment pool and psychological impact of the conflict. Ambition vs Capacity The sustenance of this conflict presents a challenge for large-scale extractive and connectivity projects for all foreign investors.

There Are Two Big Problems Trump May
Run Into If He Actually Attacks Iran

The growing US military presence in the Gulf signals a potential military operation targeting Iran. While the objectives remain unclear, any use of military force would come with distinct constraints for the Trump administration. The Trump administration faces two broad military options with differing objectives and limitations. The first is a limited air operation aimed at the destruction of the Iranian leadership and the Islamic Revolutionary Guard Corps (IRGC) and/or destroying the country's nuclear-enriched stockpiles. The second option involves a sustained campaign aimed at ensuring that the current Iranian regime and its nuclear programme are eradicated from their roots and are replaced by a system that is acceptable to the United States and its regional allies. For the administration, the first option has several external, long-term constraints despite being a comfortable immediate one. The second option might have greater domestic, immediate constraints, but might be safer for attaining the desired outcome in the long term. Limited Strike This option carries the fewest immediate constraints. It also appears the most likely outcome given the current US military posture, which has limited ground offensive capability but strong air and maritime capability. Without a sustained on-ground troop deployment, such an operation would not require prior Congressional backing. It would also limit risks to US



personnel and assets. A limited strike would receive support from partners such as Israel, as was seen during the June 2025 strikes. The United Kingdom is also likely to play a defensive role focused on asset protection. The primary constraints under this option emerge in the post-conflict phase. Israel, the central US partner in this scenario, seeks a permanent end to the Iranian threat. This would require the removal of the current regime, its replacement with a pro-Western system, and the destruction of Iran's nuclear stockpile. As demonstrated during the June 2025 confrontation, limited strikes alone do not guarantee the desired outcomes. The destruction of nuclear stockpiles without a regime change is likely to provoke strong Iranian retaliation in the short

term. Over the longer term, Iran would attempt to re-establish its nuclear programme. This, in turn, would stall negotiations between Iran and the West for the foreseeable future, while sanctions remain in place. Iran would be left more distrustful of the West, allowing greater leverage for China and Russia. If regime change were to follow the destruction of the IRGC, the administration would face the challenge of managing the resulting power vacuum. Wider instability within Iran and the surrounding region would become likely. On-ground troop deployment remains the only effective means of ensuring post-regime change stability and the establishment of civilian governance. However, this option is constrained by political and coalition limits. Limits To A Sustained

Campaign If Trump were to launch a sustained ground campaign in Iran, he would face significant resistance from Congress and from allied partners. These constraints would narrow operational flexibility and increase pressure to bring the campaign to a rapid conclusion. There is bipartisan consensus within Congress against sustained military intervention in Iran. This opposition is driven by fears of prolonged foreign entanglement and the risk of regional escalation. At the same time, Congress has expressed concern over deteriorating human rights conditions within Iran. The members have repeatedly expressed growing concerns about the misuse of presidential authority to deploy force that is largely derived from Authorization for Use of Military Force (AUMF) provisions.

Namakkal: Loudspeaker noise during temple event delays fire rescue call

CHENNAI: A sudden fire that broke out near a canal close to the Avathipalayam bus stand in Pallipalayam on Thursday evening highlighted concerns over excessive loudspeaker noise, after a passer-by reportedly struggled to contact the Fire and Rescue Services due to blaring festival music.

According to a Daily Thanthi report, the fire erupted around 4 pm near the canal, where garbage had been dumped. The flames spread quickly as the accumulated waste caught fire, sending thick smoke billowing into the air.

A youth identified as Hariharan (28), who was passing through the area, attempted to alert the Fire and Rescue Department using his mobile phone. However, he was unable to communicate clearly as loud film songs were being played through public address systems for the Mariamman temple festival in Avathipalayam.

He then rode his two-wheeler towards the Aghraharam area in search of a quieter spot to make the call, but encountered similar noise due to a temple kumbabishekam event. Loudspeakers had reportedly been installed for nearly two kilometres up to the Sandhai Pettai area, continuing to play music at high volume. After considerable difficulty, he finally managed to inform the



Fire and Rescue Services. A fire tender later reached the spot and extinguished the blaze before it could spread further.

Following the incident, social activists and local residents reiterated calls for stricter regulation or a complete ban on high-volume horn loudspeakers during temple festivals, citing public safety and emergency communication concerns.

TN announces shuffle among police officials

of Police and posted as DCPs in Salem City (North) and Tiruchy City (South), respectively.

At the inspector general of police level, S. Rajeswari, formerly Member Secretary of TNUSRB, is now IGP for Crimes Against Women and Children (CAWC) in Chennai. She replaces A. Kayalvizhi, who has been posted as IGP and Member Secretary of TNUSRB. R. V. Ramya Bharati has been posted as IGP (Crime), Chennai. Other key postings include N. U. Sivaramani moving from DCP, North, Salem City to SP of Vellore district, while A. Mylvaganam, former SP of Vellore, is now SP of Vigilance and Anti-Corruption, Southern Range, Chennai. G. Nagajothi, SP of TNUSRB, has been posted as Superintendent of Police and Principal of the Police Training College in Chennai.

Tiruchy: Woman jumps into well with infant, mom-in-law held

TIRUCHY: A young woman, along with a six-month-old baby girl, jumped into a well and died by suicide on Wednesday night, reportedly after dowry harassment by her in-laws. Police arrested her mother-in-law on Thursday, and a search is on for her father-in-law.

Sivabalan (33), a temporary staff member at Cooperative Credit Society at Ayakkaranpulam near Vedaranyam in Nagapattinam, married Kavya (20) after a love affair. It is said that

Sivabalan's mother, Senthamizh Selvi (53), a school teacher and his father Palanidurai (57), a noon meal organiser in a school, were in the habit of quarrelling with Kavya for failing to bring dowry. The frequent quarrel frustrated Kavya, and so Sivabalan sent his wife to her paternal house nearby. Still, Sivabalan's parents continued to torture her, and so the frustrated Kavya, on Wednesday night, took the baby and jumped into the well near the house after recording her statement and sharing it on social media.

Tamil Nadu: From footwear to missiles, investments for Rs 34,200 crore gets cabinet nod

CHENNAI: Continuing its push to take industrial development to districts that remained below the radar for decades, the State government on Thursday cleared 15 industrial proposals to manufacture a range of products from footwear to ships and missiles, with a total investment of Rs 34,237 crore. The projects have the potential to generate about 55,000 direct and indirect jobs.

Besides greenfield projects, the list of proposals that were cleared by the State Cabinet chaired by Chief Minister MK Stalin also includes expansion of



automobile major Hyundai, and Gensol Engineering, which provides engineering, procurement, and construction services for solar power sector.

The biggest among them are Evervan Kothari's Rs 5,000 crore investment in

Ranipet to manufacture footwear for German giant Adidas, and Keynes Circuit India's Rs 4,995 crore investment to set up an electronic component manufacturing unit in Thoothukudi. Equally noteworthy is the Rs 4,500 crore

that Jeanuvs is pumping into Thoothukudi. Beyond the quantum of investment, what stands out about the project is that the unit would manufacture components for radar, artillery, missile, etc. Briefing reporters after the Cabinet meeting, Industries Minister TRB Rajaa pointed out that the units that would come up in Ranipet, Tiruvannamalai, Krishnagiri, Tiruchy, Karur, Ramanathapuram, and Thoothukudi show the government's commitment to balanced industrial development across the State.

AI booster: Budget offers tax holiday for global cloud firms using Indian data centres

NEW DELHI: The Union Budget on Sunday proposed a tax holiday till 2047 for foreign companies that provide cloud services to customers globally using data centres located in India, signalling the government's push to make the country a major hub for AI and digital infrastructure.

The big push on data centres comes at a time when India is gearing up to take the centrestage in global discourse on Artificial Intelligence. It is expected to position India not just as a consumer of global cloud and AI services, but as a thriving base for the world's digital backbone.

By linking tax benefits to serving global customers from India, the policy seeks to turn the country into an export hub for cloud computing. Presenting the Union Budget 2026-27, Finance Minister Nirmala Sitharaman said: "Recognising the need to enable critical infrastructure and boost investment in data centres, I propose to provide tax holiday till 2047 to any foreign company that provides cloud services to customers globally by using data centre services from India."

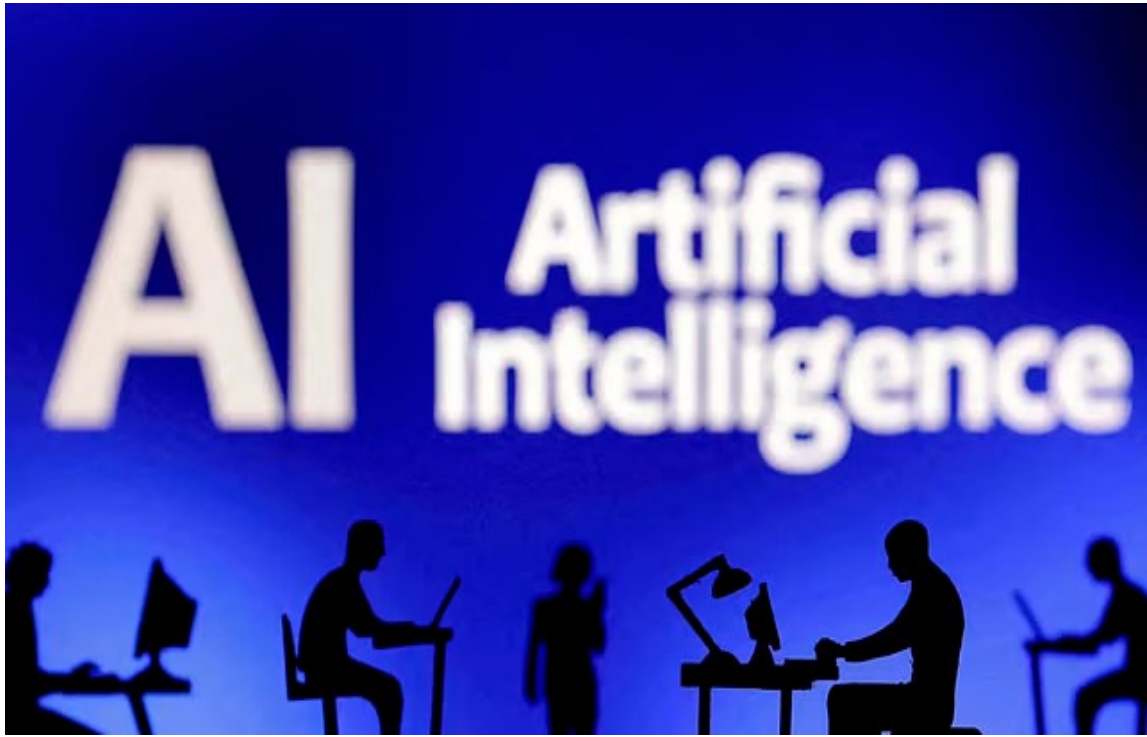
It will, however, need to provide services to Indian customers through an Indian reseller entity.

"I also propose to provide a safe harbour of 15 per cent on cost in case the company providing data centre services from India is a related entity," the FM said.

Put simply, data centres are secure facilities filled with powerful computers and servers that store, process and transmit digital data behind services ranging from emails and banking all the way to streaming and cloud platforms.

The data centres, which resemble fortified bases, run on specialised infrastructure, from uninterrupted power supply to advanced cooling and round-the-clock monitoring (even one minute of downtime can affect millions of users).

With AI, cloud computing and digital payments growing, data centres are becoming as critical as



roads and power plants, forming the backbone of India's digital economy. India is eyeing a leading role in global AI conversations with New Delhi all set to host the India AI Impact Summit, the first-ever in the Global South.

The mega conference scheduled from February 16-20, 2026, at Bharat Mandapam, New Delhi, will mark the biggest congregation on AI in the world till date, bringing together 15 global leaders and Heads of State/Government, over 40 Ministers, 100s of leading CEOs and CXOs, and eminent academics from all over the world.

IT Minister Ashwini Vaishnaw, earlier this week, noted that investments worth nearly USD 70 billion are already flowing into the AI infrastructure layer, with the potential to double by the conclusion of the Summit.

Last year, big tech companies Microsoft and Google grabbed headlines as they collectively pledged billions of dollars in fresh capital to build out gigawatt-scale data centres and sovereign AI

infrastructure in India.

Sindhu Gangadharan, SAP Labs India and Chairperson, Nasscom, said the Budget strengthens the policy backbone required for India to operate as a global technology and AI execution hub.

"The focus on cloud infrastructure and long-term clarity for cloud services directly addresses a core constraint in scaling enterprise platforms, the ability to run regulated, data-intensive workloads with confidence and continuity," Gangadharan said.

She added that for GCCs, this creates the conditions to move beyond delivery into ownership, where India increasingly designs, builds, and runs core platforms and mission-critical systems for global enterprises.

S Anjani Kumar, Partner, Deloitte India, noted the Budget treats AI as a horizontal enabler for the whole economy. It explicitly positions it as a force multiplier for better governance alongside structural reforms and financial-sector deepening.

The tax holiday signals a bet on India as a long-term compute hub, which is the infrastructure backbone for all of this AI adoption, Kumar added.

Piyush Prakashchandra Somani, Promoter, Managing Director and Chairman, ESDS, observed that the tax holiday for cloud services with local data centres is a timely and strategic move that reinforces India's commitment to data sovereignty and a resilient digital economy.

"By directly incentivising domestic data centre operations, the government is not only accelerating investments in India-based cloud infrastructure but also creating a stronger foundation of trust, security, and compliance for enterprises. "This policy will encourage cloud providers to scale locally, reduce dependence on offshore data storage, and position India as a preferred global hub for secure, compliant, and future-ready cloud services," Somani added.

Wikipedia inks AI deals with Microsoft, Meta and Perplexity as it marks 25th birthday

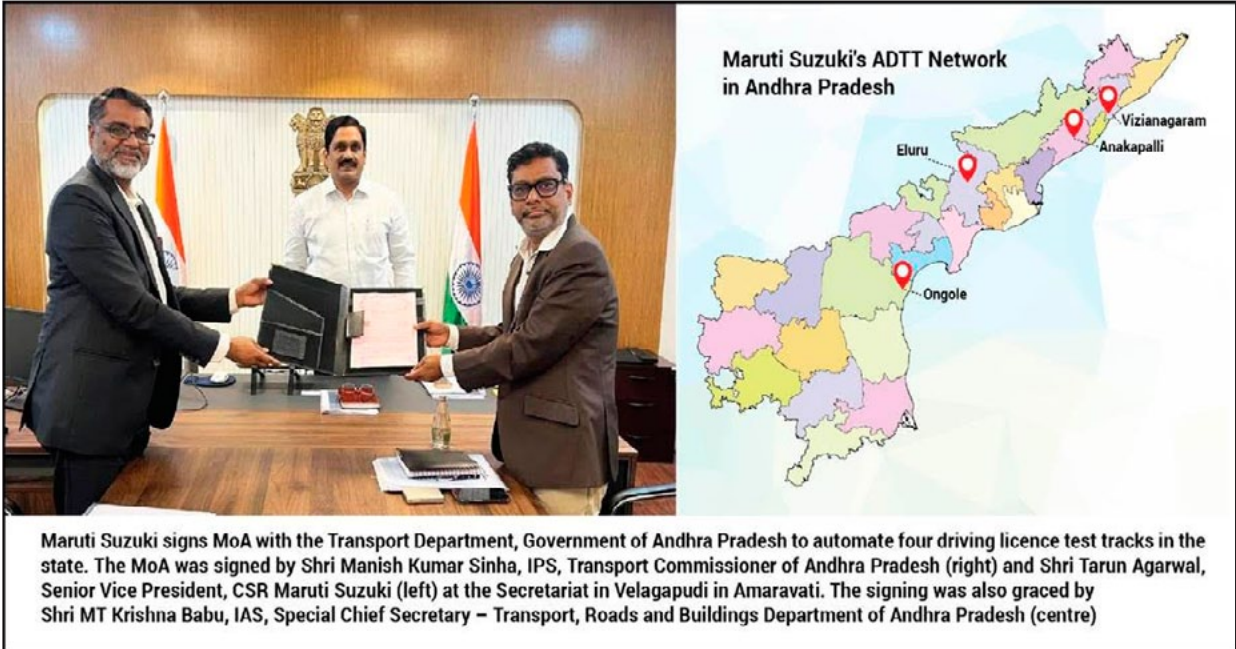
Wikipedia unveiled new business deals with a slew of artificial intelligence companies on Thursday as it marked its 25th anniversary. The online crowdsourced encyclopedia revealed that it has signed up AI companies including Amazon, Meta Platforms, Perplexity, Microsoft and France's Mistral AI. Wikipedia is one of the last bastions of the early internet, but that original vision of a free online space has been clouded by the dominance of Big Tech platforms and the rise of generative AI chatbots trained on content scraped from the web. Aggressive data collection methods by AI developers, including from Wikipedia's vast repository of free knowledge, has raised questions about who ultimately pays for the artificial intelligence

boom. The Wikimedia Foundation, the nonprofit that runs the site, signed Google as one of its first customers in 2022 and announced other agreements last year with smaller AI players like search engine Ecosia. The new deals will help one of the world's most popular websites monetize heavy traffic from AI companies. They're paying to access Wikipedia content "at a volume and speed designed specifically for their needs," the foundation said. It did not provide financial or other details. While AI training has sparked legal battles elsewhere over copyright and other issues, Wikipedia founder Jimmy Wales said he welcomes it. "I'm very happy personally that AI models are training on Wikipedia data because it's human curated."

EXPECTEDLY, RBI KEEPS INTEREST RATES UNCHANGED

Mumbai: The Reserve Bank of India kept its benchmark interest rate unchanged on Friday, February 6, as expected, as inflation remained at manageable levels, and growth concerns eased following trade agreements with the US and the European Union. The central bank's six-member Monetary Policy Committee (MPC) voted unanimously to keep the repurchase, or repo rate, at 5.25 per cent. The RBI retained its neutral policy stance, signalling rates will stay low for some time. US President Donald Trump earlier this week announced a cut in tariffs on Indian goods to 18 per cent from 50 per cent, easing a key pressure point on India's economy and markets. The first tranche of the pact is likely to be finalised by next month, which includes a reduction in US tariffs. Announcing the decisions of the MPC, RBI Governor Sanjay Malhotra said external headwinds



have intensified, but the successful completion of the trade deal with the United States bodes well for the economy. The RBI has cut rates by a total of 125 basis points since February 2025, marking its most aggressive easing cycle since 2019. It reduced rates by 25 basis points at its previous meeting in December. While the inflation remains benign, economic activity remains resilient. "Amidst heightened geopolitical tensions and elevated uncertainty, the Indian economy is in a good spot with strong growth and low inflation. Inflation remains below the

tolerance band, and its outlook continues to be benign," Malhotra said. "With the signing of a landmark trade deal with the European Union and the US trade agreement in sight, growth momentum is likely to be sustained for a longer period." The current policy rate is appropriate, the governor said, adding that inflation was benign and future rate moves will depend on growth outlook and inflation. "Inflation, especially underlying inflation, is low. It's much lower than even our forecast...underlying inflation is very, very benign.

FACING HIGH TRUMP TARIFFS, SOUTH AFRICA CLOSE TO NEW TRADE DEAL WITH CHINA



Cape Town: China and South Africa signed a framework agreement for a new trade deal on Friday, February 6, as Africa's leading economy looks to

other options following the high import tariffs imposed on it by the US and its diplomatic fallout with the Trump administration. South Africa's Ministry of Trade and Industry said the agreement would start negotiations over a deal that would give some South African goods, such as fruit, duty-free access to the Chinese market. The ministry said it expected the trade deal to be finalised by the end of March. In return, the trade ministry said China will get enhanced investment opportunities in South Africa, where its car sales have seen rapid growth. The US slapped 30 per cent duties on some South African goods under President Donald Trump's reciprocal tariffs policy — one of the higher rates applied across the world. South Africa has said it is still

negotiating with the US for a better deal. The China-South Africa deal follows others looking for alternatives to US partnership in the face of Trump's aggressive trade policies. China is already South Africa's largest trade partner for both imports and exports, while Chinese economic influence across the African continent continues to grow and it dominates in the extraction of Africa's critical minerals that are key components for new high-tech products. "South Africa looks forward to working with China in a friendly, pragmatic, and flexible manner," the trade ministry said. Trade and Industry Minister Parks Tau, who travelled to China to sign the agreement, said the deal would benefit South Africa's mining, agriculture, renewable energy and technology sectors. US-South Africa diplomatic ties have plunged to their worst point in decades after the Trump

administration accused South Africa of pursuing an anti-American foreign policy and allowing the violent persecution of a white minority group at home. South Africa's government has denied allegations that white Afrikaner farmers are being killed in a widespread effort to seize their land as baseless. Trump has also barred South Africa from taking part in meetings of the Group of 20 rich and developing nations this year in the US. South Africa's biggest exports to China are gold, iron ore and platinum-group metals, while Chinese cars have quickly grown their market share in South Africa. Industry groups estimate Chinese brands have grown from around 2.8 per cent of the South African market in 2020 to between 11 per cent and 15 per cent last year. China's BYD overtook Elon Musk's Tesla in 2025 as the world's biggest electric vehicle maker.

MORE THAN 30 KILLED IN BLAST AT PAKISTAN MOSQUE, OFFICIALS SAY

At least 31 people have been killed and 169 injured in an explosion at a mosque during Friday prayers in Pakistan's capital, Islamabad, according to a city official. Police officials say a suicide bomber detonated a device after approaching the gates of the Shia mosque in the Tarlai area of the city, while eye-witnesses have told the BBC the blast was preceded by the sound of gunfire. An emergency was declared as hospitals began to receive the wounded, with an appeal sent out for blood donations. Pakistan's Prime Minister Shehbaz Sharif has condemned the incident, expressing "deep grief". In a statement released on social media, he called for a thorough investigation and the immediate identification of those behind the attack. Pakistan's President Asif Ali Zardari said in his own statement that "targeting



innocent civilians is a crime against humanity". Zaheer Abbas was inside the Khadijatul Kubra Mosque praying when he first heard the sound of bullets. "After that, we bowed and then prostrated, and then there was an explosion," he told BBC Urdu. "After which there were injured people lying everywhere." Pictures from the mosque in the aftermath show footwear scattered across the floor, shattered glass, and people sat among the wreckage.

Abbas, who said he "lost his senses" in the moments after the explosion, was eventually pulled out by emergency services and taken to hospital, where he was quickly released. "Fortunately, I did not suffer much injury," he said. The mosque's caretaker Syed Ashfaq - who lives next door - also heard gunfire, and began running towards the mosque to help. "By the time I reached it there had already been an explosion," he told the BBC. "Bodies



were lying everywhere, some were missing arms, some missing legs. We took the most injured in our own vehicle [to hospital]." Islamabad's deputy commissioner Irfan Memon said on X that the death toll stood at 31, with the injured numbering 169. Pictures from local hospitals show the injured being brought by private vehicles and ambulances, with one photographer for news agency AFP saying they saw dozens of people arriving at hospital.

Attacks are relatively rare in the capital, although one in November left 12 dead. Another 27 were injured in the blast, outside a courthouse. The blast on Friday comes after a week of violence which saw 58 civilians killed in coordinated attacks in the province of Balochistan. The Balochistan Liberation Army (BLA) rebel group said it was behind the attacks. The military - which has been fighting an insurgency in the region for

decades - said it had killed more than 200 militants in response. Last year was also Pakistan's deadliest in over a decade as combat-related deaths surged 74%, with militants accounting for more than half the death toll, according to a new report released by an independent think tank. The Pakistan Institute for Conflict and Security Studies (PICSS) said violence in Pakistan left 3,413 people dead - up from 1,950 in 2024 - with 2,138 militants killed.

RUSSIAN GENERAL SHOT SEVERAL TIMES IN MOSCOW

A high-profile general in Russia's military has been shot several times and wounded in Moscow. Lt Gen Vladimir Alexeyev was immediately taken to hospital after the attack in a residential block of flats on the north-western outskirts of the Russian capital and his condition is unknown. Alexeyev is number two in the main directorate of Russia's GRU military intelligence and the latest high-ranking military figure to have been targeted in the capital since the full-scale invasion of Ukraine began almost four years ago. He was placed under European Union and UK sanctions after the GRU was accused of being behind the 2018 nerve agent attack in Salisbury in the UK. "The victim has been hospitalised at one of the city's hospitals," said Svetlana Petrenko of Russia's Investigations Committee, which said it opened a criminal case for attempted murder. The gunman fled and investigators searched CCTV footage for clues and



began interviewing witnesses. A neighbour of Alexeyev told the Reuters news agency she had been woken up by the sound of "several" shots and had then heard another neighbour screaming for help. "This is all I heard. Other neighbours rushed out, too. They asked how they could help, should they call ambulance and police, but she had already called them." Alexeyev has played a significant role during the war in Ukraine, taking part in talks with Ukraine during the Russian siege of the city of Mariupol in 2022. He was also sent to negotiate with the head of the Wagner mercenary group.

Canada and France to open Greenland consulates after Trump demands



Canada is set to open its first diplomatic outpost in Greenland in a significant show of solidarity following US President Donald Trump's threats to take control of the territory. A delegation of senior Canadian officials, including Governor General Mary Simon, and foreign minister Anita Anand, are travelling to Nuuk on Friday to formally open Canada's consulate, accompanied by a Canadian Coast Guard ship. Ahead of the trip, Simon said in a speech that Canada "stands firmly in support of the people of Greenland who will determine their own future". Their visit comes amid a similar trip made by French officials, who are due to open their own consulate in the territory the same day. The Canadian and French missions are a historic expansion of foreign engagement in Greenland. Until this week, only Iceland and the US offered formal consular services in Nuuk. It is also a signal of the continued support offered by

Nato allies to Greenland, after Trump repeatedly stated that the US needs to "own" it for national security reasons. The president has since walked his comments back, saying he is now exploring a potential deal after talks with Denmark, European allies and Canada. Greenland has been on Canada's radar for some time. The consulate was first announced in early 2024, when Ottawa reviewed its Arctic foreign policy. The opening had been slated for late 2025, but that was delayed due to bad weather. Now, the consulate carries even more weight, said Michael Byers, a professor at the University of British Columbia who has authored several books on the Arctic. "I'm only surprised it hasn't occurred sooner, given the important connections between Greenland and Arctic Canada," he added. He noted that Iqaluit, the capital of Canada's northern territory of Nunavut, is only an hour flight away from Nuuk.

COIN PORTRAIT OF LATE QUEEN DRAWS CRITICISM IN AUSTRALIA



Two commemorative coins, released by the Royal Australian Mint and bearing a portrait of Queen Elizabeth II, have been criticised for their lack of resemblance to the late monarch. The \$5 (£2.56) and 50-cent silver coins, created to commemorate the centenary of the Queen's birth, were released in an online ballot that closed on Wednesday. "That's got to be the most unpleasant portrait on a coin," said one of several

people who reacted negatively online. The Royal Australian Mint defended the portrait, saying: "Our coin images don't always capture the full beauty of a design once it's etched in metal." Queen Elizabeth II died in 2022 at the age of 96 and was the UK's longest serving monarch. "There's a reason most portraits are from the side. Looks like she just ran into a wall," one person commented underneath a Facebook post from the mint. "If I saw that face without the hairdo and pearls, would never guess who it was meant to be," another said. Comparisons have been made with various TV characters, including Mrs Doubtfire - the beloved fictional housekeeper in the comedy film of the same name, played by the late Robin Williams.

IRANIAN FOREIGN MINISTER SAYS US TALKS IN OMAN A 'GOOD BEGINNING'

Senior US and Iranian officials have held talks in Oman amid a crisis that has raised fears of a military confrontation between the two countries. The indirect discussions in the capital Muscat happened as the US military builds up its presence in the Middle East in response to Iran's violent repression of nationwide anti-government protests last month, which human rights groups say killed many thousands of people. Speaking on state television after the talks, Iranian Foreign Minister Araghchi said negotiators would return to their capitals for consultations, but described the meeting as a "good beginning". Iran had previously said the talks would be limited to its



nuclear programme. The US, which is demanding Iran freezes its nuclear programme and discards its stockpile of enriched uranium, had said they should also involve Iran's ballistic missiles and the country's support for regional armed groups. Earlier, Oman said its foreign minister had held separate talks with Araghchi, and US special



envoy Steve Witkoff and President Trump's son-in-law and emissary Jared Kushner. It said the "consultations focused on preparing the appropriate conditions for resuming diplomatic and technical negotiations". The last round of talks between the US and Iran over the Iranian nuclear programme had been scheduled for last June but col-

lapsed after Israel's surprise attack on Iran. In recent weeks, Trump has threatened to bomb Iran if it does not reach a deal. The US has sent thousands of troops and what Trump has described as an "armada" to the region, including an aircraft carrier along with other warships as well as fighter jets. Iran has vowed to respond to an attack with force, threatening to strike American military assets in the Middle East and Israel. For Iran's embattled leaders, the talks could be the last chance to avert US military action that could further destabilise the regime, which analysts say is in its weakest position since it came to power following the 1979 Islamic Revolution.

Savannah Guthrie's brother renews plea for proof mother is alive

The brother of US news presenter Savannah Guthrie has renewed his family's plea for proof that their mother is still alive after she disappeared last weekend. As the first deadline from an alleged ransom letter passed, Camron Guthrie said in a video posted to Instagram that the family had not heard anything about their missing mother, Nancy Guthrie. The 84-year-old is believed to have been abducted from her home in Tucson, Arizona in the middle of the night. Police launched a massive hunt, with officials offering a reward of \$50,000 (£36,000)



for information that leads to an arrest. "We have to know that you have our mum," Camron said in the latest video message. "We want to talk to you." "We haven't heard anything directly," he said in the video, posted on Thursday just after 17:00 local time in Arizona

(00:00 GMT). "We need you to reach out, and we need a way to communicate with you so we can move forward." It came as the first supposed deadline for the Guthrie family to hand over money passed. At a briefing on Thursday, FBI Special Agent Heith

Janke said his agency was reviewing an alleged ransom note. It gave a deadline for payment of 17:00 on Thursday, he said, without specifying which time zone, and had a second deadline for Monday. No further information was shared about what was threatened if the deadline was not met. "We're not going to go into specifics," Janke said. It was announced the same day that authorities had made an arrest over a fake ransom note. Earlier in the week, Savannah Guthrie shared an emotional video message, along with her siblings.

TikTok told to change 'addictive design' by EU or face massive fines



The EU has told TikTok it must change its "addictive design" or face heavy fines, after it found the video sharing platform had breached its online safety rules. It follows an investigation which began in February 2024 into the Chinese-owned app by the European Commission. In its preliminary findings, the Commission said TikTok did not "adequately assess" how features like autoplay could harm the wellbeing of its users, including children, and said it failed to implement measures to mitigate the risks. A TikTok spokesperson told the BBC the findings presented a "categorically false and entirely meritless depiction of our platform" and it planned to challenge them. The platform has been invited to respond to the EU's findings. Depending on the outcome of this step, the Commission could fine TikTok up to 6% of its total global annual turnover - estimated to be in the tens of billions. EU tech chief Henna Virkkunen told reporters if TikTok wanted to avoid being fined, it would have to "change the design of their service in Europe". The Commission gave several suggestions for actions the

platform could take, including implementing "screen time breaks" when people are using it at night and changing its algorithms, which feed users personalised content. It also suggested TikTok disable so-called "infinite scroll", which allows people to quickly cycle through millions of videos on the platform. "The Digital Services Act makes platforms responsible for the effects they can have on their users," Virkkunen said. "In Europe, we enforce our legislation to protect our children and our citizens online." Professor Sonia Livingstone at the London School of Economics said while TikTok had introduced some tools to improve the online safety of its users, it was not enough to comply with the guidelines set down by the EU. "Young people are calling for such changes," she said. "They are frustrated that the platform does not prioritise their wellbeing over profit." And social media expert Matt Navarra said while the word addictive was "often abused" in these debates, the Commission's findings seemed to be rooted in "true behavioural science".

Trump endorses Japan's Takaichi ahead of snap election

Donald Trump has endorsed Japan's Prime Minister Sanae Takaichi ahead of a snap election in her country on Sunday. Takaichi has "already proven to be a strong, powerful, and wise leader... one that truly loves her country," the US president wrote in a Truth Social post on Thursday, adding: "She will not let the people of Japan down!" While it is rare for US presidents to publicly back candidates in foreign elections, Trump has done so before, endorsing Argentina's Javier Milei and Hungary's Viktor Orban most recently. Takaichi has courted the US president as Tokyo seeks more stability in its relationship with Washington, its closest ally, in the wake of Trump's tariffs. Trump had threatened

a 25% tariff initially, but Japan then struck a deal in July to invest \$550bn (£407bn) in the US. In exchange, Washington lowered import levies to 15%. Takaichi, 64, became PM in October after she won the leadership race in her party and secured enough support in parliament. But she has called an election to seek a public mandate. Just one week after she took office, Tokyo rolled out the red carpet for Trump, deploying a full military guard of honour and band to welcome him at the Akasaka Palace, the government's state guesthouse. It was her diplomatic debut, and the optics were striking: Takaichi aboard the aircraft carrier USS George Washington, fists pumping as the US president praised her in front of thousands of

Vaibhav Suryavanshi Achieves Huge Record In U19 World Cup Final. No Other Player Has Ever Done It

Vaibhav Suryavanshi captivated the crowd with yet another explosive innings in the U19 World Cup 2026 final against England on Friday in Harare. The young prodigy brought up his century in just 55 balls, giving India a commanding position in the match. His knock included six fours and six sixes, making it the fastest century by an Indian in U19 World Cup history. The 14-year-old from Bihar broke the previous record held by Raj Angad Bawa, who had reached a hundred in 69 balls against Uganda in 2022. Suryavanshi became the first India batter ever to score a century under sixty balls in an U19 World Cup match. In the overall tournament records, Suryavanshi became the second fastest centurion in U19 World Cup history, beating Qasim Akram of Pakistan, who brought up his ton in 63 balls against Sri Lanka in 2022. Australia's Will Malajczuk



holds the mark for the fastest century in the U19 World Cup, achieving the milestone in 51 balls against Japan in the 2026 edition. Fastest U19 WC hundreds (by balls faced) 51 - Will Malajczuk (AUS) vs Japan, Windhoek, 2026 55 - Vaibhav Sooryavanshi (IND) vs ENG, Harare, 2026 63 - Qasim Akram (PAK) vs SL, North Sound, 2022 65 - Ben Mayes (ENG) vs SCOT, Harare, 2026 69 - Raj Bawa (IND) vs Uganda, Tarouba, 2022 Suryavanshi ended his knock at 175 off 80, consisting of 15 boundaries and 15

Suryavanshi smashed 30 sixes in this tournament, eclipsing Brevis' tally of 18 from 2022. Earlier in the day, India Under-19 captain Ayush Mhatre won the toss and elected to bat first against England in the ICC U19 World Cup 2026 final at the Harare Sports Club.

Smriti Mandhana Was Down With 103 Degree Fever Before WPL 2026 Final, Nobody In RCB Knew About Illness

Smriti Mandhana was at her aggressive best in the Women's Premier League (WPL) 2026 final. The Royal Challengers Bengaluru skipper smashed a 41-ball 87 as her team chased down a 204-run target against the Delhi Capitals in 19.4 overs. Mandhana finished as the highest run-scorer of the WPL 2026 after leading her side to their second title at the BCA Stadium in Vadodara on Thursday. The 29-year-old ended the season with 377 runs in nine innings and claimed the Orange Cap for the first time. Mandhana scored her runs at an average of 53.86 and a strike rate of 150. Her highest individual score of the season (96 off 61 balls) came against the Delhi Capitals during the league



stage. She also played a match-winning knock of 87 in the final, helping RCB lift the trophy for the second time after their maiden title in the 2024 season. After the match, the RCB coach revealed that Smriti had been running a fever a day

before the final. "Smriti, thank you so much for being such a wonderful captain and for turning up for this game without any complaints. I know how ill you were last night. The effort you put in... For people who didn't know, she had a fever

of 103 degree F last evening," said RCB coach Malolan Rangarajan in his dressing-room speech. He went on to say that Mandhana saved her best innings for the final. "Massive, massive flu. She was seriously unwell with a high fever. But she turned up and didn't show it - nobody in the team knew. Not for a second did she show it. That's the person Smriti is. When I spoke to her this afternoon, she said, 'Nahi, Malo, koi problem nahi (No, Malo, there's no problem), I'll be there.' That's her work ethic," Rangarajan said after the six-wicket win. "I think she saved one of her best innings for the final," he added. "The way she battled was... inhuman? I don't even know the right word. So classy, so elegant.

Guardiola received both praise and criticism for his passionate words, with Jewish community leaders advising the Spaniard to "focus on football" and "be more careful in his future language". But the 55-year-old did not back down when asked to respond to those comments by BBC Sport, saying: "To be honest, I didn't say anything special. I don't feel that." Last week, Guardiola gave a speech in support of Palestinian children at a charity event in his home city of Barcelona. He used the news conference before Manchester

City's Carabao Cup semi-final second leg against Newcastle to speak about children being killed and injured in conflict zones across the world, saying the footage he sees "hurts me". He referenced conflicts in Palestine, Ukraine, Sudan and even recent shootings by Immigration and Customs Enforcement (ICE) agents in the United States. The Jewish Representative Council of Greater Manchester & Region said Manchester City have been "let down" by Guardiola "repeatedly straying into commentary on international affairs". Speaking in his news conference before Sunday's Premier League game at Liverpool, Guardiola said: "Why should I not express what I feel, just because I am a manager? I don't agree but I respect absolutely all opinions. "What I said basically is how many conflicts are there right now all around the world? How many? A lot - I condemn all of them.

From £70 a week to brink of Premier League record 24 years later



"People joke that I only did it because he didn't do his homework," says former Premier League referee Jon Moss about the time he sent off James Milner. Twenty-four years after making his debut, Milner, 40, will equal the record for most Premier League appearances if he features for Brighton against Crystal Palace on Sunday. A stellar career spanning more than two decades, six top-flight clubs, 652 Premier League appearances, 61 England caps, three Premier League titles, two FA Cups and one Champions League triumph has also delivered some unexpected moments. Like the time Milner - known as 'Millie', external by those close to

him - was sent off by Moss, his former teacher at Westbrook Lane Primary School in Horsforth, Leeds, while playing for Liverpool against Crystal Palace in 2019. "He said I couldn't wait to get my card out," laughs Moss about dismissing his former pupil after switching careers. "People say I'm the only teacher to send off one of his pupils in a Premier League game. We can both laugh about it now." Milner is set to go level with Gareth Barry, who played 653 times, at the top of the all-time Premier League appearance list some 8,491 days after making his debut for hometown club Leeds United soon after leaving school in 2002.

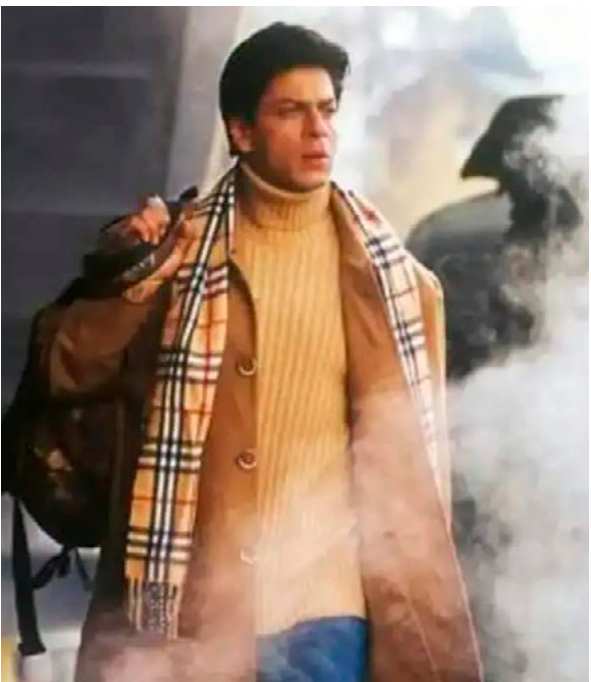
