Telangana Assembly passes Bill for salary cut for parental neglect

Hyderabad (TSIT): The Telangana Legislative Assembly on Sunday unanimously passed a Bill to deduct 15 per cent of salary from employees neglecting their parents.

The Bill provides for deduction of up to 15 per cent or Rs 10,000 — whichever is lower — from the gross salary of employees found to be neglecting their parents.

SC, ST Welfare and Senior Citizens Minister Adhuri Laxman Kumar moved the motion for passing the Bill, which was adopted with a voice vote.

"Article 21 of the Constitution of India asserts that the right to life includes the right to live with dignity. Parents are an inseparable part of the Indian family system. It is therefore considered necessary to pro-

vide enforceable norms among employees who neglect their parents and to ensure that every employee acts as a role model in society," reads the Bill.

2 Indian ships with LPG cargo sail safely out of Gulf region

New Delhi (TSIT) : Two Indian LPG carriers, BW TYR and BW ELM, carrying a combined LPG cargo of about 94,000 metric tonnes, have safely transited the Gulf region and are moving towards Indian shores.

24x7 and has handled 4523 calls and 8,985 emails since activation. In the past 24 hours, 92 calls and 120 emails have been received. DG Shipping has facilitated the safe repatriation of over 942 Indian seafarers so far, including four in the last 24 hours.

Cong faults govt's foreign policy for Pak, US bonhomie

New Delhi (TSIT): The Congress on Sunday faulted the government's foreign policy for once-isolated Pakistan acquiring new acceptance and respect from US President Donald Trump amid the West Asia conflict.



Claiming that Prime Minister Narendra Modi has not been able to gain any diplomatic leverage with the US, Ramesh said, "That Pakistan has become - in the words of the learned Dr. S. Jaishankar - a 'dalal' is a reflection of the colossal failure of the Modi Govt's foreign policy, diplomatic engagement, and narrative management following India's striking military success in Operation Sindoor."

The Congress MP, General Secretary in charge of party communications, said, "Undoubtedly, President Trump (Mr Modi's 'good friend') has contributed heavily to Pakistan's current respectability." This is not the first time that the Congress has criticised PM Modi and the government amid recent developments in West Asia and their impact on India.

DMK promises Rs 2,000 pension, Rs 8,000 household support



CHENNAI (TSIT): The Dravida Munnetra Kazhagam on Sunday released its manifesto for the 2026 Assembly election, promising enhanced financial assistance, expanded welfare schemes and large-scale housing initiatives.

The increase in monthly assistance under the Kalaingar Magalir Urimai Thogai scheme to Rs 2,000. Old-age pensions will also be raised from Rs 1,200 to Rs 2,000, while assistance for persons with disabilities will be increased from Rs 1,500 to Rs 2,500.

Stalin said the manifesto focuses on "six steps towards progress", adding that development and welfare would go hand in hand, while ensuring long-term growth.

77 MAOISTS SURRENDER IN ODISHA;

DGP urges remaining cadres to lay down arms

Bhubaneswar (TSIT) : Odisha Director General of Police (DGP) Y.B. Khurania on Sunday said that coordinated operations by security forces over the past one year have led to the surrender of 77 Maoists and the neutralisation of 27 ultras in the state, while urging the remaining cadres to lay down their arms to avoid action by the forces.



Khurania, who was in Phulbani to attend a special programme to honour security personnel involved in anti-Maoist operations, said that around a year ago, security forces received a call to eliminate the influence of Maoists in the country by March 31, 2026.

The Odisha DGP stated that significant successes have

Operations Group (SOG), Special Intelligence Wing (SIW), and District Voluntary Force (DVF).

"As many as 77 Maoists have surrendered to the Odisha Police, while 23 active Maoist cadres from Odisha have laid down their arms in Chhattisgarh. Security forces have neutralised 27 Maoists in various operations during this period, including 17 cadres - among them a Central Committee member of CPI (Maoist) - who were killed near the Nuapada-Gariaband border in a joint operation carried out by Odisha Police, Chhattisgarh Police, and other security forces on January 25, 2025," DGP Khurania said.

PM Modi says Kerala is ready for change; targets LDF and UDF

Palakkad (Kerala) (TSIT): Prime Minister Narendra Modi on Sunday intensified the BJP-led NDA's campaign for the 2026 Kerala Assembly elections, telling a large gathering in Palakkad that the state was witnessing a "different vibe" and showing signs of political change.



Addressing a rally at Kotta Maidan, PM Modi said the BJP and the NDA were drawing growing support from key sections of Kerala society, especially youth, women and farmers. The PM credited what he described as the alliance's rising acceptance to the blessings of the people, the commitment of party workers and their sac-

rifices on the ground. The Prime Minister sought to project the NDA as an emerging alternative in a state long dominated by the LDF and the UDF. In a sharp political attack, PM Modi alleged that Kerala had remained trapped for decades in the grip of "selfish politics" under the alternating rule of the Left Democratic Front and the United

Democratic Front. He accused both fronts of failing to unlock the state's full potential and argued that repeated shifts between the two coalitions had not translated into meaningful transformation for ordinary people.

Positioning the NDA as a development-oriented force, the Prime Minister said Kerala's future lay in embrac-

ing a new political direction backed by what he called his guarantees and vision for governance. He asserted that the BJP would work to turn Kerala into a developed state, promising a model of progress that would focus on opportunity, growth and better prospects for coming generations.

The PM's speech appeared to be aimed at reinforcing the NDA's message that Kerala is ready to move beyond traditional bipolar politics.

PM Modi arrived in Palakkad after landing at the Mercy College helipad and travelled to the venue through a roadshow route in the town, where party workers and supporters had gathered in large numbers earlier in the day. Senior BJP and NDA leaders were also present at the event.

24.91 CRORE REFUNDED TO CYBER CRIME VICTIMS THROUGH NATIONAL LOK ADALAT TGCYBER SECURITY BUREAU DIRECTOR SHIKHA GOEL

Hyderabad TSIT: In a major relief to victims of cyber fraud, Telangana Police have facilitated the refund of 24.91 crore to 4,627 victims across the state through the National Lok Adalat, said Cyber Security Bureau Director Shikha Goel.



In a statement issued on Sunday, she said the initiative was successfully carried out in coordination with the Telangana State Legal Services Authority, banks, digital payment platforms, and police units across all commissionerates and districts.

Highlighting the performance, Goel stated that record recoveries were achieved in the first quarter of 2026 itself. The TGCyber Security Bureau headquarters facilitated refunds of 5.64 crore to 87 victims, while Malkajgiri zone recovered 4.79 crore for 832 victims, and Hyderabad zone returned 3.99 crore to 553 victims. Cyberabad and Sangareddy units each helped refund Rs.1.52 crore to victims.

She noted that the state has significantly strengthened its cyber crime response system compared to previous years, ensuring faster

justice through structured platforms like Lok Adalat.

Since its inception, the Cyber Security Bureau has enabled refunds of Rs.399.06 crore to 53,434 victims across Telangana. The refund amounts have seen a sharp rise—from Rs.8.3 crore in 2023 to Rs.183.9 crore in 2024, and Rs.183 crore in 2025. In 2026 alone, Rs.24.91 crore has already been refunded within just three months, reflecting sustained efforts by the department.

Director said that cases involving UPI frauds, investment scams, and identity thefts are being addressed through continuous coordination with banks and legal institutions to expedite recovery.

Procurement centres for maize, paddy sought



Khammam: The government should immediately open procurement centres for maize and ensure a minimum support price of Rs.2,400 per quintal through Markfed, while also launching paddy procurement without any restrictions, CPI district secretary Dandi Suresh said. Speaking at a CPI district committee meeting held at Giriprasad Bhavan on Sunday, he said farmers were incurring heavy losses due to the absence of procurement centres, with private traders purchasing maize at much lower prices, causing a loss of Rs.800 to Rs.1,000 per quintal. He noted that maize cultivation had expanded significantly in the district this season as it was profitable last year and that the Yasangi harvest has begun. He also demanded that water be released through the Nagarjuna Sagar left canal till April 30, as crops are at various stages and any disruption would affect farmers. Highlighting lack of employment in rural areas, he called for immediate implementation of works under the VBG Ramji scheme to ensure continuous employment and timely wage payments. CPI leaders Hemanta Rao, Mohammed Maulana and Jitender Reddy were present.

Govt Introduce Ethanol In place of LPG for Domestic cooking



New Delhi, March 29: India's petroleum sector may soon introduce ethanol in place of LPG for household cooking as a measure to reduce dependency on imported LPG. Speaking in New Delhi today in an industry event R S Ravi of the Federation of Indian Petroleum Industry significant progress is being made on ethanol-based cooking solutions. Research institutions, including IITs and the LPG Equipment Research Centre, are currently developing efficient ethanol-compatible stoves, with prototypes at the earliest.

Ravi urged the distillery sector, represented by the All India Distillers' Association, to play an active role in scaling the initiative—both by partnering with manufacturers to produce stoves on a large scale and by helping build a robust supply chain to deliver ethanol directly to households. "This is a different ballgame," Ravi noted, highlighting the need to move beyond bulk industrial supply toward a consumer-focused distribution model. He stressed that logistics, packaging formats, and last-mile delivery systems will be critical to making ethanol a viable cooking fuel. The proposal comes as India accelerates its ethanol blending programme, having already rolled out 20% ethanol-blended petrol (E20).

Bhatti Vikramarka Slams BRS for Disruptions in Assembly Defends Government's Welfare Agenda

Hyderabad TSIT: Deputy Chief Minister Bhatti Vikramarka on Sunday criticized BRS MLAs for disrupting Assembly proceedings...

Speaking in the Assembly, he said that during the Congress tenure from 2014 to 2023, party MLAs never resorted to tearing budget copies, walking out, or creating disturbances during discussions.

He pointed out that despite being aware of parliamentary traditions and rules, BRS MLAs resorted to sloganeering and even violated norms by disclosing a minister's name without prior notice.

Referring to allegations raised by BRS, Bhatti Vikramarka said Chief Minister A. Revanth Reddy had already ordered a CBCID inquiry into mining irregularities from 2014 to March 28, 2026, and said the opposition should

welcome such a move instead of disrupting the House.

Deputy CM also took a dig at the previous BRS government, stating that although three House Committees were formed during its tenure, they failed to function effectively. "No meetings were held, no reports were made public, and the committees were misused for political purposes," he alleged.

He further accused BRS of attempting to derail budget sessions and block discussions on welfare schemes, including initiatives like the student breakfast scheme.

Targeting the BJP, Bhatti Vikramarka said that despite demanding a CBI probe into the Kaleshwaram project for the past eight months, no action had been taken,

suggesting a tacit understanding between BJP and BRS. Raising concerns over land issues, he alleged that lands distributed to the poor during previous Congress governments were brought under Dharani Part-B and reassigned to favored individuals during the BRS regime.

Welcoming Chief Minister's announcement to constitute a House Committee to probe Dharani-related land irregularities and illegal land transfers in Balanagar, he challenged BRS MLAs to support the committee if they truly believed in democratic processes.

BRS demands dismissal of Telangana minister over alleged corruption, illegal mining

Hyderabad, March 29 : Bharat Rashtra Samithi (BRS) on Sunday demanded the immediate dismissal of Telangana Minister Ponguleti Srinivas Reddy over allegations of corruption and illegal mining.



BRS Deputy Leader in Assembly T. Harish Rao and party working president K.T. Rama Rao, along with other MLAs stages protest at Gun Park. Carrying placards, they demanded that the House Committee probe the allegations against Raghava Construction, a company linked to the revenue minister.

BRS MLAs also wrote a letter to Chief Minister A. Revanth Reddy, seeking a probe by the House Committee or a sitting judge.

Talking to media persons, Rama Rao warned that if the government fails to act, the party will approach the Governor with a formal complaint and, if necessary, take the issue directly to the people on a large scale.

He pointed out that after the exposure by Harish Rao, the Chief Minister admitted that irregularities had indeed taken place. However, instead of taking responsibility, he attempted to counterattack by claiming that the government itself had revealed the issue. KTR criticised the Chief Minister's claim that the company belonged to "distant relatives" of Minister Ponguleti, calling it absurd.

KTR stated that the minister's wife, son, and brother are directly linked to the company and that the minister himself served as its chairman between 2020 and 2022. He accused the Chief Minister of making contradictory and misleading statements, reflecting a lack of credibility.

He further alleged that the Chief Minister's strong defence of Raghava

Constructions indicates his own involvement in the matter. He cited the allocation of contracts under the Kodangal Lift Irrigation Project to the same company and raised concerns over large-scale land irregularities in the state involving the Chief Minister and his associates.

Questioning the government's inaction, he asked why no action has been taken against the minister's family company despite clear evidence. He pointed out that under the law, a second notice in such cases can lead to imprisonment of up to one year, yet the government continues to protect the accused.

He also criticised the Mining Minister for downplaying the issue as a mere Rs 4 lakh matter, stating that officials had detected violations worth Rs 32 lakh in a single day during inspections. He said this clearly indicates a much larger scam involving public resources over a prolonged period.

CHARU SINHA: RECORD DISPOSAL OF CASES IN NATIONAL LOK ADALAT

Hyderabad TSIT: CID Additional Director General of Police Charu Sinha said that the National Lok Adalat has emerged as an effective platform for amicable settlement of compoundable offences and civil disputes, with a record number of cases resolved across Telangana.



She stated that 1,44,251 cases were disposed of during the National Lok Adalat held on Sunday. The Lok Adalat, initially scheduled for March 14 and later rescheduled to March 28 as per directions of the Telangana State Legal Services Authority, witnessed an overwhelming response from the public.

Charu Sinha noted that the number of cases resolved this time was 37.14 percent higher than the Lok Adalat held in December last year, with an additional 39,069 cases being settled. Highlighting a key achievement, she said special focus was given to cyber crime cases, with 4,635 cases resolved and around 24.95 crore refunded to victims.

Among the units, Hyderabad topped the list with 15,719 cases disposed of, followed by Malkajgiri, Siddipet, Ramagundam, and Nalgonda districts. Additional DGP said the police machinery began groundwork from March 19 by identifying eligible cases and issuing notices to both parties. She attributed the success to strong coordination between the judiciary and the police, which helped reduce the burden on courts while saving time and money for litigants.

Charu Sinha urged citizens to make use of such platforms in the future to resolve disputes amicably and efficiently.


'Mann Ki Baat' inspires focus on environment, health and youth: Ramchander Rao

BOOK 'HYDERABAD DAYS' BY MICROSOFT EXECUTIVE TRACES ROOTS OF LEADERSHIP

Washington, March 28 : An Indian American senior executive at Microsoft has turned to memory and meaning in a new memoir that argues leadership is shaped long before one writes a line of code.



Ravi Vedula, Corporate Vice President at Microsoft, said his book 'Hyderabad Days' draws from "recollections and vignettes of life in the 80s and 90s", adding that those years remain "very formative" and continue to guide his thinking in engineering and leadership. "Those childhood memories are things I use till today," Vedula said in an interview with IANS, describing them as "the value system and the operating principles of how I think about leadership now and in engineering."

The book, releasing March 31, centres on growing up in a Hyderabad colony and frames those experiences as a "proxy for all neighbourhoods where anyone grew up," he said, stressing that "this is not just my story, it's yours too."

Vedula said each chapter ends with a reflective "postscript" linking childhood incidents to present-day lessons. Simple episodes - pooling money to buy a cricket ball or resolving disputes in gully cricket - become "a story of teamwork... doing more with less... finding community with each other." He said the structure allowed him to move

beyond "slice of life vignettes" and connect them to a broader leadership frame rooted in storytelling rather than formal frameworks. A recurring theme is community. "I felt like I was raised by everybody in the neighbourhood," he said, recalling a chapter titled "everybody's child." He also points to "resourcefulness" - often described in India as jugaad - and teamwork as defining traits. Family influences, especially his mother's quiet sacrifices, form another strand. "It was service. It was leadership," he said.

Vedula, who moved to the United States in 1993 for higher studies and joined Microsoft in 2000, said the book deliberately focuses on what he calls the "pre-immigrant story". "No one ever tells the pre-immigrant story," he said, adding that his life has been shaped by "India, America, and India, where America gave me wings, India gave me grounding and roots." Reflecting on the rise of Indian professionals in the US technology sector, he said those early influences may play a role. "We tend to be resourceful... we tend to work within constraints..."

Venkaiah Naidu seeks passage of Bill in Parliament for legal status to Amaravati

Amaravati: Former Vice President of India, M. Venkaiah Naidu, has urged Union Home Minister Amit Shah to pass a Bill in the current session of Parliament to provide legal status to Andhra Pradesh's capital, Amaravati. Venkaiah Naidu on Sunday spoke to Amit Shah about the resolution passed by the state Assembly, urging the Centre to amend the Andhra Pradesh Reorganisation Act 2014 to accord legal status to the capital. Naidu recalled that when Prime Minister Narendra Modi laid the foundation stone for the Andhra Pradesh capital, Amaravati, he was the Union Urban Development Minister then. The former Vice President also



mentioned the assistance rendered by the Centre for the development of the state capital. Venkaiah Naidu also referred to developments following 2019 and the setbacks received by the state capital. To prevent a similar situation arising in future, he suggested that the Bill to accord legal

status to Amaravati as Andhra Pradesh's capital be passed during the current Parliament session. TDP Celebrates 44th Formation Day, CM Chandrababu recalls party's achievement. Amit Shah is reported to have responded positively to the suggestion. He informed Venkaiah

Naidu that the Union Home Ministry has completed the groundwork and that once the Union Cabinet clears the Bill, the same would be tabled in Parliament. The Andhra Pradesh Legislative Assembly held a special session on Saturday to pass a resolution, requesting the Central government to declare and notify Amaravati as the sole capital city of the state. The resolution said the words 'at Amaravati' be inserted in Section 5 (2) of the A.P. Reorganisation Act, 2014 (APRA) and 'and Amaravati includes the Capital city areas notified under the A.P. Capital Regional Development Act, 2014' be added to the explanation to Section 5 as per the advice of the High Court contained in its order dated March 3, 2022.

Salakatla Vasanthotsavam in Tirumala on March 30, 31 and April 01



Tirumala, 29 March 2026: Salakatla Vasanthotsavam in Tirumala will be observed from March 30 to April 01. Vasanthotsavam is a three-day annual spring festival, usually held in March or April (Chaitra month) to welcome Spring season and is performed in Tirumala on the auspicious days of Trayodashi, Chaturdasi and Pournami every year. According to the temple Legend, the Vasanthotsavams were introduced during the period of King Achyutaraya in 1460s. The processional deities are given aromatic bath on these three days which is believed to give a soothing relief to the deities from

the scorching Sun in the spring season. This three-day festival starts with ankurarpanam (sowing the nine kinds of seeds) ceremony conducted on the day of Uttarabhadra star, one day before the commencement of Vasanthotsavam festival. Punyahavachanam, (purification rites), Vasthu Santhi (worship of deity and lord of nature and their elements and natural forces) and samprokshanam (sprinkling of holy water as a symbolic representation of purification) rituals are performed by the temple priests. Access to these rituals is not open to public. On all these three days, Sri Malayappa Swamy and his consorts

are brought to beautifully decorated Vasanta Mandapam. In Vasanta Mandapam, Abhisekham which means Snapana Tirumanjanam (Holy Bath with aromatic ingredients) is performed to the processional deity of Sri Malayappa Swamy and His consorts on first two days. On the morning of the second day, the utsava deities parade on Swarna Ratham along four mada streets to bless devotees. On the third day, Sri Rama with Sita, Lakshmana and Anjaneya and Sri Krishna with Rukmini and Satyabhama are also taken out in procession along with Malayappa Swamy and His consorts Sridevi and Bhudevi. At the end of procession, all Utsava murthies are brought to Vasanta Mandapam where Snapana Tirumanjanam is performed with religious fervour. TTD has cancelled Kalyanotsavam, Unjal Seva, Arjita Brahmotsavam and Sahasra Deepalakara Sevams on these three days besides Astadala Padapadmaradhana on March 31.

Tiger poisoned to death near Satpura Reserve in MP, 5 held

BHOPAL: A radio-collared tiger was allegedly poisoned to death, following which five persons were arrested on Saturday, Madhya Pradesh police said.

The tiger's body was found buried in a pit in West Chhindwara division revenue area on Friday, the official said.

"The tiger was brought from Bandhavgarh Tiger Reserve in Umaria in December 2004. It had formed its territory outside the reserve. Five persons have been arrested for poisoning the animal. They have been remanded in judicial custody," STR field director Rakhi Nanda told PTI.

The accused, who laced

tiger kill with poison, allegedly took this step as the big cat had killed their cattle, Nanda added.

The accused are also involved in illegal opium cultivation, the official said.

Meanwhile, wildlife activist Ajay Dubey on Saturday lodged a formal complaint in the matter with Secretary, Ministry of Environment, Forest and Climate Change (MoEFCC), Member Secretary, National Tiger Conservation Authority (NTCA), Principal Secretary (Forest), MP, among others.

In his complaint, Dubey alleged that no movement was seen in the radio-collar monitor since March 3, but

the forest department ignored the development.

"The tigress was poisoned by poachers and her carcass was found buried in a pit in Sanga Kheda village area under Chhindwara South Forest Division. It is not merely a case of poaching, but a glaring example of administrative and monitoring failure," Dubey said while seeking immediate intervention from higher authorities.

He also sought the removal of STR field director Nanda "for free and fair investigation into the glaring incident".

A total of 14 tigers have died in MP since January this year, he pointed out.

Several 'B teams' were formed to 'break' AIADMK: Palaniswami

CHENNAI: AIADMK general secretary Edappadi K Palaniswami on Saturday alleged that several "B teams" were formed and many tried to "break" the AIADMK by filing cases in court, but all that has been smashed and shattered into pieces.

Without naming expelled AIADMK leader O Panneerselvam, Palaniswami, while garnering votes in North Chennai for the April 23 Assembly polls, here, said, "Several internal problems were created in the party and now see where they (Panneerselvam) have gone."

"The true face (of Panneerselvam) has come

out. The cat is out of the bag. After Amma's (As Jayalalithaa is fondly called, meaning mother) demise, many tried to capture this movement intentionally. But with the help of you all and party supporters, we stopped and have proven that AIADMK is a strong movement," he said.

"After Amma passed away (on December 5, 2016) they thought the party would break. They tried so much to break this party by creating some B teams. But, along with the support of the people and party cadres, all that has been smashed and shattered into piec-

es," he said. Stressing that the party had been started for the welfare of the poor by the late Chief Minister M G Ramachandran, Palaniswami said after his demise the movement got split. "But Amma (Jayalalithaa) united them and fulfilled the dreams of our revolutionary leader (M G Ramachandran)," he said amid thunderous applause from the audience.

The only party to have ruled Tamil Nadu for 31 years is the AIADMK and because of it, the state secured top rank among other states in India, he claimed.

Observing that the party follows democracy,

he said in the DMK it is not so, as no matter how much one toils hard for the party's growth they would not get any recognition. The ruling DMK's objective was to only "loot", he said, and asked the people whether such a party should come to power again. The people replied, "no".

Development projects worth Rs 12Cr launched in Palam area of Delhi

NEW DELHI: Development works valued at over Rs 12 crore were launched in the Palam Assembly constituency on Saturday, with South Delhi MP Ramvir Singh Bidhuri and local MLA Kuldeep Solanki participating in the foundation-laying ceremony.

According to details shared during the event, the projects focus on improving basic infrastructure, including roads, internal lanes, drainage systems and parks in the area. The foundation stones were laid at Gokal Garden, with several works planned across Palam Village, Rajnagar and nearby localities. The planned developments include construction and repair of roads and drains in Palam Village, installation of open-air gyms and children's play equipment in parks, and reconstruction of lanes in Rajnagar.

TMC counters Shah's 'chargesheet' with similar document; seeks answer for Manipur violence

KOLKATA: The Trinamool Congress slammed Union Home Minister Amit Shah on Saturday with a counter to his "chargesheet" against the Mamata Banerjee government, accusing the BJP of trying to polarise the people of poll-bound West Bengal and evade accountability for its own record on a host of issues, including women's safety.

Hours after Shah's press conference here, the incumbent TMC questioned the BJP-led Centre over the prolonged violence in Manipur, women's safety in BJP-ruled states and the Centre's handling of illegal immigration.

Senior TMC leaders Mahua Moitra, Bratya Basu and Kirti Azad held a joint press conference where they targeted the Union Home minister over his criticism of the TMC government on women's safety. "Amit Shah is talking about women's security. What is the condition

of women's safety in BJP-ruled states?"

"Shah should first answer about violence in Manipur, which has bled continuously for the past three years," TMC MP Moitra said.

The counter-charges came after Shah, earlier in the day, sharpened the BJP's campaign for the West Bengal assembly elections, releasing a political "chargesheet" against the TMC government and framing the polls as a battle not merely for Bengal, but for the country's security.

At a packed press conference, Shah alleged that after 15 years of TMC rule, West Bengal had become the country's "principal corridor" for infiltration because of the ruling party's appeasement politics, corruption and political violence.

Rejecting the allegation, the TMC noted that the BJP has been in power at the Centre for over a decade and



has been ruling several border states.

"BJP rules at the Centre. It rules 15 states and most border states through which infiltration is happening. Amit Shah himself is the Union Home Minister. So what exactly has he been waiting for?" senior TMC leader and West Bengal Education minister Bratya Basu said.

Questioning the Centre's claims on infiltration,

Basu asked why the Union Home Ministry had "failed" to identify and deport illegal immigrants.

"Why has the BJP-controlled Election Commission failed to release the names of foreign nationals found on the electoral rolls?" he asked.

In a separate statement, Basu alleged that the BJP was using the issue of infiltration to create divisions in Bengal.

Karnataka BJP MLA Suresh Kumar refuses IPL tickets, slams 'VIP culture'

BENGALURU: Calling the decision to allot two IPL tickets to MLAs "VIP culture", senior Karnataka BJP MLA Suresh Kumar on Saturday said he does not want them.

He expressed surprise that the government was eager to make such an announcement just 24 hours after the discussion in the Assembly. Karnataka Deputy Chief Minister D K Shivakumar said on Friday that the KSCA had agreed to provide two tickets per MLA for the IPL match on March 28 at the city's Chinnaswamy Stadium.

IPL 2026 kicked off here with Royal Challengers Bengaluru facing Sunrisers Hyderabad in the opening match.

Shivakumar had met officials of the Karnataka State Cricket Association, which manages the stadium, a day after legislators across party lines raised the issue in the Assembly regarding improper ticketing and seating arrangements at the city's premier venue.

During the discussion, Speaker U T Khader had asked the government to ensure that every MLA receives four VIP tickets for matches at the stadium.

Kumar also wrote to the Speaker on Saturday, declining the IPL match tickets.

"As per my conscience, I politely decline to accept any IPL match ticket or pass issued

by the government or the KSCA. Therefore, please do not issue any ticket or pass in my name," he said in his letter.

Chief Minister Siddaramaiah, responding to a reporter's question in Mysuru about Kumar's stand, said, "If someone does not want the tickets, that is fine. Whoever wants to watch the match can go."

When asked whether discussing IPL tickets for MLAs in the Assembly was appropriate, he said, "Tickets were given by the KSCA to MLAs and MLCs in the past as well. Even now, they are giving tickets—this time, instead of one, they have been asked to give two. That's all." The CM said he would try to attend the match if time permitted. "It won't be possible until April 9 due to the by-elections," he added.

Earlier in the day, Kumar said in a statement, "The state government, led by Siddaramaiah, claims to be socialist. It is truly surprising and unfortunate that VIP culture continues even under the rule of this self-proclaimed socialist CM."

"Oh, I forgot! When RCB won the IPL last year, we all saw how this same 'Samajwadi' chief minister took his grandson to the victory stage built in front of the Vidhana Soudha," he added, taking a dig at the government.

Nominations open for Rashtriya Vigyan Puraskar

NEW DELHI: The Centre has invited nominations for the Rashtriya Vigyan Puraskar (RVP) 2026, a national initiative to recognise outstanding contributions in the fields of science, technology, and innovation.

The awards are administered by the RVP Secretariat, Council of Scientific and Industrial Research (CSIR), the Ministry of Science and Technology, under the chairmanship of the principal scientific advisor to the government.

"The Rashtriya Vigyan Puraskar reflects the government's unwavering commitment to fostering excellence in science, technology, and innovation. These awards celebrate the spirit of inquiry and dedication of our scientists and innovators who are driving India's transforma-

tion into a global knowledge leader," Union Minister Jitendra Singh said in a statement on Saturday.

Nominations, including self-nominations, are open across a wide range of domains, including agricultural science, atomic energy, biological sciences, chemistry, defence technology, Earth science, engineering sciences, environmental science, medicine, physics, space science and technology, and others.

The awards will be presented in four distinct categories: Vigyan Ratna to recognise lifetime achievements in science and technology; Vigyan Shri to acknowledge distinguished contributions to the field; Vigyan Yuva-Shanti Swarup Bhatnagar to encourage young scientists (up to 45 years of age).

Himachal CM's Himcare facts incorrect, scheme should not be discontinued: LoP

SHIMLA: A heated debate occurred between the ruling Congress and the opposition BJP in Himachal Pradesh Vidhan Sabha on Saturday during a discussion on a cut motion related to the health department.

Leader of the Opposition Jairam Thakur raised several questions regarding the state government's handling of the Himcare scheme and health services. He also objected to statements made by Chief Minister Sukhvinder Singh Sukhu.

The BJP leader asserted that the chief minister's facts regarding the Himcare scheme are inaccurate. Specifically addressing the issue of bills related to "hysterectomies performed on men".

He said that the medicines in

question are actually used in the treatment of cancer patients and added that an investigation into the matter revealed these medications had indeed been utilised for the treatment of patients suffering from cancer.

The Himcare scheme, launched during the tenure of the previous BJP government, provides free healthcare services to low-income individual groups who are not covered under the Ayushman Bharat Yojana or Jan Arogya Yojana.

He further alleged that the information being provided by the chief minister's health advisor is incorrect.

Chief Minister Sukhvinder Singh Sukhu on Friday had said that irregularities like bills for

ovarian surgeries of men and implant of expired lenses have come to light during an internal audit of the Himcare scheme, following which a vigilance inquiry has been ordered.

The Leader of Opposition countered and said that if any irregularities occurred within the Himcare scheme, they should be investigated, but discontinuing the scheme entirely would be inappropriate.

He also argued that it is unfair to tarnish doctors' reputations by levelling allegations of irregularities against the scheme. He further alleged attempts are being made to alter the fundamental structure of the Nerchowk Medical University, a move he deemed improper.

Jairam Thakur also raised questions regarding the infrastructure of health services. He said that while introducing robotic surgery in two major institutions is logical, launching it across five locations without adequate infrastructure could impose an additional financial burden on patients.

He also highlighted the issue of termination of outsourced employees who served during the COVID-19 pandemic, stating their removal is unjustifiable given their crucial role during a difficult period.

He also pointed out that the current government took approximately three and a half years to install the PET-scan machine, an initiative for which

the previous government had already laid the groundwork.

Furthermore, Thakur alleged that the procurement of furniture for the medical colleges in Chamba and Hamirpur has remained incomplete for the past year and a half.

The LoP remarked that Union Health Minister Jagat Prakash Nadda is willing to provide funds from the Centre for various health schemes, but the state government must ensure proper utilisation of those funds.

He pointed out that while the state government receives financial assistance from the Centre for numerous schemes, it does not even acknowledge or appreciate it.

When Supply Chains Break, Waste Can Fill the Gap

What if the solution to rising fuel and fertiliser costs is already in our bins? LPG cylinders are running dry in our favourite food establishments. A few more weeks and they will squeeze our household budgets as well. Some 90% of India's LPG imports come through the Strait of Hormuz. The International Energy Agency will release 400 million barrels of oil from emergency reserves, which would cover four days of global consumption. India claims to have more than 60 days of oil reserves, but only two days of LPG reserves. The other impending crisis few people are talking about is fertilisers. The Kharif sowing season is soon upon us and urea and phosphates will be critical ingredients for a hearty crop. Interestingly, these too depend on natural gas. India's fertilisers also predominantly come from the Gulf. Freight rates have reportedly risen ten-fold to account for the risk of passing through the Strait. Remember when Sri Lanka banned costly chemical fertilisers to save money? It cost them over USD 400 million in tea export, nearly half their food production and arguably led to the fall of the government as shortages sparked public anger. You may say we will get our gas and fertilisers from elsewhere. Russia is offering alternatives, after all. Yes, but this will be much more expensive than what we have had so far. Typically, when energy prices rise, anger grows against the government. Will the current government withstand rising food and fuel prices? Or will it strongly subsidise fuel and fertiliser and reverse its hard-earned gains in reducing India's fiscal deficit? I would argue the current crisis may be an opportunity in disguise. We have long struggled to manage our wet waste. Kitchen scrapings, animal dung, sewage water, agricultural waste have long polluted our soil, water and air. Many programmes attempt to salvage value out of organic residues through conversion to biogas or compost. Yet none of these programmes have taken off or sustained momentum after the initial impetus. Consumers are often to blame for this. We are locked into familiar patterns and reluctant to try something new. The stigma of waste-derived material is an added deterrent. I would urge those so inclined to visit some oil dumps or at least look them up on the internet. Given the right infrastructure and human attention, anything can be transformed into a finished product. After all, the most important discovery that boosted food production was a pile of bird guano off the Latin American coast. And of course, animal dung is the oldest fertiliser known to man. Is it all worth it though? Spending thousands of crores from the government exchequer to subsidise biowaste transformation for a passing storm? "This too shall pass," right? Wrong, most likely. This war has been forty years in the making, with all sides declaring it a holy war. There is an adage in foreign policy: "Allies are temporary, interests are permanent." Unfortunately, conflict appears inevitable in this region with ethnic and religious divides. Since we have entered a new state of disorder in geopolitics, supply shortages will be a recurring theme. Two more straits in the South China Sea and the Red Sea are also chokepoints that are likely to be held hostage at some point. Besides war, long-term strategy dictates a transition to renewable sources of energy and fertiliser. Firstly, oil imports may be a much bigger drain on India's finances than subsidies for renewable energy. Moreover, special economic zones and other incentives support India's petroleum industry. India also has strong decarbonisation targets dependent on weaning off of fossil fuels. Decarbonisation would be best done quickly as exports to European countries will soon include a carbon tax. So what needs to be done? Major challenges include inconsistent market prices, lack of adequate storage and transport for feedstocks and products such as biogas and compost. Backyard biogas plant subsidies are set to expire in March 2026. These should be extended. Offtake agreements must be prioritised to ensure steady prices and limit uncertainty. Capital expenditure for storage and transport infrastructure for biogas and compost must be sanctioned. Research into best practices in treatment processes and operations should be incentivised.

How the NEP is Reshaping Autonomy for Minority Institutions

As India's higher education system reorganises itself under the National Education Policy 2020, a quieter constitutional question is taking shape: what happens to institutional autonomy when governance is redefined through standardisation, metrics and centralised regulation? However, most of the public debate on the policy has focussed on its other aspects - curriculum reform, multidisciplinary expansion and institutional consolidation. The Union Budget 2026-27 increased education allocation to Rs 1,39,289 crore, an 8.27% rise that signals NEP implementation has entered its operational phase. Less examined, however, is a constitutional question: how does a governance model built on standardisation, performance metrics and regulatory restructuring interact with the autonomy granted to minority educational institutions? The NEP preserves constitutional protections on paper. Article 30(1) affirms that minorities based on religion or language have the right to establish and administer educational institutions of their choice. Yet when oversight shifts from political discretion to technocratic standardisation, the meaning of autonomy can change. The policy proposes replacing the UGC, AICTE and NCTE with a unified Higher Education Commission of India. The Cabinet's approval of the Viksit Bharat Shiksha Adhishthan Bill in December 2025 advances this framework, bringing all non-medical, non-legal higher education institutions under a single regulatory body. Alongside institutional consolidation, graded autonomy tied to accreditation marks a decisive turn towards performance-based governance. Under existing UGC regula-

tions, universities with high NAAC scores receive greater flexibility in admissions and curriculum design, while those with lower scores face tighter oversight. Institutions are evaluated through common benchmarks: governance structures, faculty qualifications, research output, infrastructure and financial transparency. These metrics operate through a points-based system that privileges certain institutional models. A university that publishes frequently in indexed journals and maintains state-of-the-art labs will score well; one that invests primarily in community outreach or trains teachers for underserved regions may not. Budgetary priorities reinforce this orientation, linking increased allocations to measurable outcomes and employability. In this framework, autonomy becomes something earned and retained through compliance. Quality assurance regimes promise transparency and accountability. Yet standardisation inevitably favours institutional forms aligned with measurable research productivity and infrastructure expansion. Evaluation systems assume that all institutions share the same purpose, and they reward outputs that regulators can easily count and compare. A college that prioritises community access, teaches in a regional language or organises its mission around service to a particular population may find that these commitments carry little weight in the scoring rubric. Minority institutions occupy a distinctive place in India's constitutional design. In T.M.A. Pai Foundation v. State of Karnataka (2002), the Supreme Court affirmed that Article 30 grants minorities substantial autonomy in administration, admissions

and fee structures, subject to reasonable regulation. Crucially, the Court cautioned that regulation cannot "whittle down" the right itself. Autonomy, therefore, has historically meant more than non-interference. It has signified the capacity to preserve institutional character while participating in the national system. When recognition and status are tied to uniform benchmarks, structural tension emerges. Institutions must align internal processes with externally defined criteria to retain accreditation grades, expand programmes or secure funding. NAAC criteria emphasise indexed research publications, UGC-aligned faculty qualifications and infrastructure standards. While these metrics suit research-intensive universities, institutions oriented towards community service, cultural preservation or teaching in regional languages may struggle to perform comparably. Over time, compliance cultures reshape priorities. Hiring committees begin to favour candidates with strong publication records over those with deep community ties. Curricula tilt towards subjects that produce quantifiable research. Governance procedures converge towards models more compatible with prevailing evaluation systems. Recent budgetary decisions illustrate how fiscal design shapes this environment. While overall education spending has risen, allocations for minority-targeted scholarship schemes have been sharply reduced. The Merit-cum-Means Scholarship for professional and technical courses fell from Rs 7.34 crore to Rs 0.06 crore. The Maulana Azad National Fellowship declined from Rs 42.84 crore to Rs 36.14 crore. In 2025-26, the Post-Matric Scholarship

carried a Budget Estimate of Rs 413.99 crore but a Revised Estimate of Rs 0.06 crore before being nominally restored the following year. These figures do not merely signal allocation shifts. They are representative of changing priorities within an outcome-driven framework. What is lost sight of in such a system is that allocation alone does not determine impact. Execution, administrative prioritisation and alignment with dominant performance frameworks matter just as much. Each of these factors determines which schemes gain traction and which languish. In a system increasingly organised around measurable outputs, targeted equity programmes that do not directly contribute to an institution's accreditation score risk becoming peripheral, regardless of their social significance. This is not about overt encroachment on constitutional rights: No provision in the NEP explicitly revokes Article 30 protections, and minority institutions remain free to exist and govern themselves. The pressure is subtler. Institutions that score well on NAAC parameters gain access to greater funding, research grants and programmatic flexibility. Those that do not must submit to closer regulatory scrutiny. In practice, this means that a minority college whose mission centres on community education or vernacular instruction faces a choice: reshape its priorities to match accreditation benchmarks, or accept a lower institutional standing that limits growth. The legal right to operate is never formally challenged. What shifts is the practical capacity to sustain a distinctive institutional identity within a system that rewards a particular model of academic performance.

AGENTIC AI IN WAR: FROM IRAN TO UKRAINE

Minutes before the airstrike, the only thing that had changed was a number on a screen. A young Gazan man was sleeping in a crowded apartment with his parents and younger siblings. Across the border, an Israeli intelligence officer sat in a darkened command center, staring at a list of AI-ranked targets. The system known as 'Lavender' had flagged the man as a 'likely militant' and spat out a coordinate. The officer, under pressure and staring at a long list of similarly ranked targets, hit approve in seconds. Minutes later, the building collapsed. The man, his parents, and the children did not survive. On paper, the AI had simply "cleared" another target. In the street, there was a crater and a family erased by a decision made in moments and never revisited. When news broke of the missile strike that obliterated the Shajareh Tayyebah girls' elementary school in Minab, southern Iran, killing 175 people - over 100 of them schoolchildren - fingers immediately pointed to AI as the villain. Emerging reports now blame outdated human intelligence for the disaster. But the Minab tragedy is a perfect window into the slippery, terrifying world of AI in warfare we have just stumbled into: a place where algorithms promise precision, but human error - or worse - still turns schools into craters. This is agentic AI in war: not a distant sci-fi experiment, but the quiet hand that helps pick a street, a face, a home, and then hands that choice to a human who has just enough time to say yes. The technology is no longer just a lab curiosity. It is now embedded in the very machinery that decides who lives, who dies, and who disappears from the records as if they were never there.

Wars Find New Forms
Wars never really end. They just find new forms and new frontiers. Today, the battlefield is not just trenches, tanks, and infantry; it is also server racks and software. Artificial intelligence has slipped into the ranks of modern warfare, not as a side project,



but as a quiet co-pilot in the chain of killing. In the war with Iran, we are seeing AI used at scale for the first time, a brutal, systematized version of the battlefield automation that first flickered across Ukraine's skies. Agentic AI isn't creeping onto the battlefield; it's kicking down the door to the command center, quietly taking over how modern militaries see, decide, and kill. It promises something chillingly simple: let software do what humans do too slowly, watch every camera, scrape every feed, sift every intercept, and then lean in to whisper to power: "Here is the target. Here is the timing. Here is what happens next." For decades, intelligence work was defined by scarcity: too few analysts, too little time, too many dots to connect. Now the problem is abundance. Armies drown in satellite imagery, drone video, social media chatter, and sensor data. Agentic AI turns that flood into something like a weaponized recommendation engine, ranking threats instead of Netflix shows and turning "collect - analyze - warn" from a bureaucratic cycle measured in weeks into an automated loop measured in minutes.

Maven, Palantir, And The Privatized Kill Chain
Nowhere is that transformation more visible than in the recent confrontation with Iran. According to a leaked Pentagon memo and subsequent reporting, the Maven Smart System, a command-and-control AI platform built by Palantir, has effectively become the US military's central brain for target selection. It ingests surveillance feeds, battlefield reports, and classified intelligence, then evaluates that information to pinpoint targets and generate prioritized strike lists. US officials openly credit Maven with enabling a wave of precision strikes on Iranian assets in a matter of days, not months. Crucially, Maven is no longer a quirky pilot project run out of a Pentagon lab. The Defense Department is moving to designate it a "program of record," locking Palantir's system into the long-term force structure and guaranteeing sustained funding.

Gaza And Iran: AI's Human Toll
The same logic plays out in Gaza, where the human cost is far more visible. Injuries, grief, and rubble do not rate well on a screen, but they are the real outcome of the "efficiency" Israel has termed its AI-assisted systems like "the

Gospel" and "Lavender." These tools analyzed data on most of Gaza's 2.3 million residents, assigned them probabilities, and at one point marked around 37,000 people as potential militants. Iran is no innocent bystander. Tehran's operators use the same AI logic - automate, personalize, and scale to generate fake personas, multilingual disinformation, and synthetic media aimed at shaping narratives in Israel, Europe, and North America. If Palantir's Maven is the flagship of kinetic AI warfare, Iran's campaigns prove the same machinery works just as well when the targets are minds and newsfeeds. **Ukraine's Live-Fire AI Lab**
Then there is Ukraine, where AI is less a prestige project than a survival mechanism. Ukrainian officials say their forces now receive over 50,000 drone video feeds from the front every month, an impossible volume for human teams to process without help. AI systems classify vehicles, trenches, and movements, rapidly mapping targets for artillery or loitering munitions. Ukrainian and Russian units alike are fielding drones that can lock onto the image of a target and continue the attack even if the communication link is jammed.

WHEN THE CLOCK RUNS OUT: A WARGAMER'S GUIDE TO THE NEXT 10 DAYS IN IRAN



Most conflict analysis explains what just happened. Wargaming does something different. Before events occur, you define the specific observable signals that will tell you which war you are actually watching - so that when something happens, you are reading it, not reacting to it. That discipline is not about predicting the future. It is about knowing, the moment a specific signal fires, exactly what it means for what comes next. Four weeks into the 2026 Iran War, the analysis behind this article has been running that wargame in real time. What it has identified is a ten-day window - expiring April 6 - that will determine the shape of this conflict for months. There are specific things to watch that will tell you which future is arriving before it gets here.

The Clock
On March 26, President Trump announced a ten-day pause on strikes against Iranian energy infrastruc-

ture, pushing his deadline to April 6. Before that date, one of these three things can happen: a framework for de-escalation emerges; the deadline passes without one and Trump extends again, further draining whatever credibility his ultimatums still carry; or the pause ends and the US strikes Iranian power plants - triggering what Tehran has publicly committed to, a large-scale counter-attack against Gulf energy and water infrastructure. The third path is the default if the first two fail. That is not a rhetorical warning. It is the structural logic of the situation. Six Things To Watch - And What Each One Means Pakistan has confirmed it is relaying messages between Washington and Tehran. Pakistani Foreign Minister Ishaq Dar stated publicly that the US has shared a 15-point peace proposal, currently being deliberated by Iran. Iran has reportedly responded through unnamed intermediaries and is now awaiting

Washington's reply. Watch for one specific thing: does Iran send back a formal counter-position, or does it return silence while the IRGC continues firing? A counter-position - even a maximalist one - means a live diplomatic back-channel exists. Silence plus continued escalation means it does not. Iran's publicly stated five conditions include war reparations and formal sovereignty over the Strait of Hormuz. Neither is acceptable to Washington. But an opening position in diplomacy is not a final one. The question is whether there is a conversation at all. Watch whether Iran's maritime operations continue at the same tempo and structure, or whether they stutter and reconfigure. If they continue without a visible gap, Iran pre-positioned a parallel command structure - meaning the institution is more resilient than any individual. If they pause or reconfigure, the strike achieved genuine disruption. Either reading changes what comes next in the waterway through which one-fifth of the world's oil normally flows. Iran's parliament is drafting legislation to formally establish Iranian sovereignty over the Strait of Hormuz and create a legal basis for charging ships passage fees. The Gulf Cooperation Council (GCC) Secretary-General has confirmed Iran is already collecting this fee, in violation of international law.

Properties of 51 Property Tax Defaulters to be Taken Over by the Corporation - D.S. Ramesh

Bengaluru: Commissioner D.S. Ramesh stated that, The property tax collected from properties within the jurisdiction of the Bengaluru East City Corporation is utilized for the development of essential civic infrastructure, implementation of public welfare programs, and maintenance activities. As per the Greater Bengaluru Governance Act-2025, all property owners within the corporation limits are mandatorily required to pay property tax every financial year. In cases of non-payment, action will be taken in accordance with the Property Tax Assessment, Collection, and Management Rules-2024.

In line with the provisions of the Act and Rules, show-cause notices and demand notices were issued to property tax defaulters, and sufficient time was provided for payment. Additionally, multiple reminders were sent through mobile messages to the property owners to clear their dues. Despite these efforts, some property owners have failed to pay the pending property tax.

In this context, properties belonging to tax defaulters in Mahadevapura and K.R. Puram zones were subjected to auction proceedings. During this process, some property owners cleared their dues and retained ownership, while in certain cases, properties were auctioned to recover the

outstanding tax.

However, in the Mahadevapura zone (28 properties) and K.R. Puram zone (23 properties), a total of 51 properties neither had their dues cleared nor were sold through auction. Therefore, in accordance with the Greater Bengaluru Authority Act and relevant rules, these 51 properties will be taken into possession by the Bengaluru East City Corporation, the Commissioner informed.

Under the principles of natural justice, a final opportunity has been provided to the property owners. If the full outstanding property tax is paid within one month from the date of this notification, necessary steps will be taken to

return the properties to the respective owners.

Failing this, as per the Proclamation and Written Notice of Sale (Form-11) already issued, the corporation will take ownership of the properties based on the guideline value, deduct the outstanding tax amount, and deposit the remaining balance into the respective property owners' bank accounts.

Property tax remains a major source of revenue for carrying out infrastructure development works within the corporation limits. Therefore, all property owners are urged to pay their taxes on time. Public cooperation is essential for the overall development of the city and improvement of civic services, the Commissioner appealed.

Study uncovers key genes behind Parkinson's in young Indians



Burden of Disease Study (2018), Parkinson's has doubled across the globe over the past two decades, while India accounts for approximately 10 per cent of the global burden. This translates to nearly 0.58 million patients living with the disease in the country. The first of its kind study conducted in India aimed included 1,000


A team of scientists has identified key genes that raise the risk of Parkinson's disease in young Indians. The team, led by Parkinson's Research Alliance of India (PRAI) and MedGenome, a global genomics company in South Asia, made a comprehensive analysis of rare and common genetic variations in young Indian population which can enhance the understanding of the genetic basis of Parkinson's disease. This also opens door for a first ever genetic screening in India for the disease in high-risk individuals and affected families, said the team of scientists in the paper published in the prestigious journal, Movement Disorders. "Parkinson's is not a single gene disease. It can occur due to multiple genetic mutations and multiple gene causes. Knowing what patients with Indian patients will have it will have more impact in understanding and treatment of that," Dr Prashanth L.K., a specialist in movement disorders from PRAI, told IANS. Parkinson's disease is the second most common neurodegenerative disorder in adults in the age bracket of 60 years and above. According to the Global

patients through a network of 10 specialty Movement Disorder Centers/Neurology clinics across India.

Dr Prashanth told IANS that the team found high probability of non-mutation and Parkinson's mutations are quite common in Indian patient.

"We also found a lot of what we call it is variants of unknown significance. These are all important genes which have not been reported in literature and have been found here. "We need to work on these genes further to see how these genes can be important for occurrence of parkinson disease in in patients," he said. Further, the expert noted that Indian patients carry lot of BSN gene mutations. BSN gene primarily affects gait and balance for people and is normally not reported in Parkinson's. Dr. Prashanth also noted that currently there is single answer as to how to prevent the disease, because Parkinson disease is an ageing related disorder. "However, very important is good quality of life. proper food, timing, food timings, regular exercises." He also emphasised the need for a "stress-free life"

Women with PCOS more likely to have memory, thinking issues in middle age



Polycystic Ovary Syndrome (PCOS) is a hormonal disorder that affects a significant number of women worldwide, impacting their reproductive health and overall well-being. Recent research has unveiled a concerning link between PCOS and cognitive function, particularly in middle-aged women. A study published in the journal Neurology suggests that women suffering from PCOS may be more likely to experience memory and thinking problems as they reach midlife.

What is PCOS? PCOS is characterized by a range of symptoms, including irregular menstruation, elevated levels of androgens (male hormones), excess hair growth, acne, infertility, and metabolic issues. The condition is prevalent, affecting up to 10 percent of women, according to Dr. Heather G.

Huddleston from the University of California, who led the study. While the physical symptoms of PCOS are well-documented, its effects on cognitive health have not been thoroughly explored until now.

The Study Overview The study involved approximately 907 female participants aged between 18 and 30, tracked over a period of 30 years. The researchers aimed to assess the cognitive abilities of women with PCOS compared to those without the condition. A specific attention test was employed, where participants were shown a list of words in various colors and asked to identify the color of the ink instead of reading the word itself. For instance, if the word "blue" was displayed in red ink, the correct response would be "red."

The results were revealing. Women with PCOS scored, on average, about 11 percent lower in the attention test than their counterparts without the condition. This decline in cognitive performance raises important questions about the long-term effects of PCOS on brain health. After adjusting for factors such as age, race, and education, it was found that women with PCOS performed worse on three out of five cognitive tests, particularly in areas relating to memory, attention, and verbal abilities. Dr. Huddleston emphasized the broader implications of these findings, noting that cognitive decline can significantly affect various aspects of a person's life. Memory and thinking problems can hinder quality of life, career success, and even financial stability. This highlights the need for increased

awareness and research into how PCOS affects not just physical health but also mental and cognitive health.

Potential Interventions In light of these findings, Dr. Huddleston suggests that lifestyle modifications could play a crucial role in improving cognitive function among women with PCOS. Incorporating more cardiovascular exercise and focusing on mental health strategies may help mitigate some of the cognitive decline associated with the condition. Exercise has been shown to have a positive impact on brain health, enhancing memory and cognitive function, which could be particularly beneficial for women with PCOS.

Conclusion The link between PCOS and cognitive decline is a critical area of research that warrants further investigation. As awareness of PCOS grows, it is essential to recognize its multifaceted impact on women's health, extending beyond reproductive issues to include cognitive well-being. By understanding the implications of PCOS on brain health, healthcare providers can better support women in managing their symptoms and improving their overall quality of life.

In conclusion, the findings from this study underscore the importance of addressing both the physical and cognitive aspects of PCOS. As more research emerges, it is hoped that effective strategies can be developed to support women living with this common yet complex disorder.

CHENNAI: The Union Ministry of Railways has stated that a Final Location Survey (FLS) has been sanctioned for laying third and fourth railway lines between Chengalpattu and Melmaruvathur, covering about 35 km via Madurantakam.

noted in a reply at the Rajya Sabha that a survey has been approved for the preparation of a Detailed Project Report. The proposal is on the busy Chennai-Villupuram corridor, which handles suburban, passenger and freight traffic. The Ministry said the project is at a preliminary stage and will require further approvals, including appraisal by NITI Aayog and the Ministry of Finance, before it can be taken up for execution. No timeline has been fixed as of now. The update comes alongside the T a m b a r a m - Chengalpattu fourth line project, which has

already been sanctioned and is under execution. The Railways also noted that as of April 2025, 15 projects spanning nearly 1,700 km have been sanctioned in Tamil Nadu, of which around 665 km have been completed. Several works are currently under way, including the Tambaram-Chengalpattu fourth line, Attipattu-Gummidipundi third and fourth lines, Chennai-Cuddalore new line via Mahabalipuram, and doubling projects such as Tirupati-Katpadi and Thiruvananthapuram-Kanniyakumari. Of the 4,326 hectares required for ongoing projects in Tamil Nadu, only about 1,052 hectares, or 24 per cent, have been acquired so far. Many projects, including new lines such as T i n d i v a n a m - Tiruvannamalai, Attipattu-Puthur and M a n n a r g u d i - Pattukkottai, have been affected by the acquisition delay. 1.5L ration shop workers, family members will skip TN 2026 Assembly polls, warns assn

CHENNAI: Fair Price Shop workers across the State have decided to boycott the upcoming Assembly elections, accusing the government of reneging on its promise to create a separate department for the Public Distribution System (PDS).

Announcing the decision, Tamil Nadu Ration Shop Employees' Association general secretary Dinesh Kumar said the protest was triggered by the government's failure to act on a key electoral assurance made in 2021 and warned that 1.5 lakh family members of 30,000 workers would skip polls.

"The DMK had promised to consolidate ration shops functioning under multiple departments and establish an exclusive department for the PDS. Five years on, that assurance has not moved beyond paper," he said.

The association said nearly 30,000 workers, who had supported the promise during the last Assembly polls, now feel "betrayed" and continue to work under fragmented administrative control.

Highlighting their role during crises, Kumar said ration shop employees had ensured doorstep delivery of food grains and relief materials during the COVID-19 pandemic and floods, often at personal risk. "We have functioned as



the government's field interface, delivering every welfare scheme to the people. Yet, our long-pending demand has been ignored," he said.

Kumar, however, said the association remains open to reconsidering its stand if any political party formally endorses their demand and offers a clear assurance to establish a separate department for the PDS. "Should any party commit to fulfilling our long-pending demand, we will review our decision and

extend our support accordingly," he said. Calling it a collective decision, the association warned that around 30,000 employees and their family members, amounting to nearly 1.5 lakh votes, would boycott the election. "We consider this a breach of trust. Having come to power on promises that included our demands, the government has failed to honour them. We will use this election to register our protest," Kumar added.

Meat-based low-carb diet may not aid in weight loss

Chennai Hot on the heels of a deadly Covid-19 pandemic, the recent pneumonia outbreak reported in China is a concern for the rest of the world as our interconnected world still poses risks, said experts on Thursday, while calling on the need for preparing for the worst. A recent post on ProMED Mail, the online reporting system of the International Society for Infectious Diseases, reported that China was experiencing a major pneumonia outbreak with no known cause in children.

It said that the outbreak, causing symptoms such as high fever, and some developing pulmonary nodules is overwhelming paediatric hospitals in the country.

Upon request, Chinese officials informed the World Health Organisation (WHO) that no new pathogens were detected in the outbreak, and instead the illnesses were caused by known seasonal viruses such as the flu and RSV, along with the bacteria Mycoplasma pneumoniae.

Netherlands and Denmark have also reported a similar uptick in pneumonia cases among children. While there is currently no report of a spread, it may be too early to say whether it can spread, said health experts calling for increasing surveillance.

"While the risk of the new China flu threatening India is currently low, the potential for spillover remains. Implementing proactive preventive measures and strengthening public health infrastructure are crucial to safeguard India's health security," Dr Tushar Tayal, Consultant, Internal Medicine, CK Birla Hospital, Gurugram, told IANS.

"In the wake of the pneumonia outbreak in China, vigilance becomes our greatest shield. Although, there is no imminent threat to India, given our robust preparedness. Drawing from our past encounters with novel viruses, our readiness is evident. The lessons learned have fortified our capabilities to effectively address potential challenges posed by emerging infectious agents. However, our interconnected world still poses risks, and in such a case awareness and precautions are potent tools," added Dr Nidhin Mohan, Consultant, Internal Medicine, Narayana Health City, Bengaluru.

A new paper in the Lancet journal shows a significant resurgence of Mycoplasma pneumoniae cases post Covid in several countries including Singapore and Sweden since April.

Last week, the Union Health Ministry noted that it is "closely monitoring the reported outbreak of H9N2 cases and clusters of respiratory illness in children" in northern China. "There is low risk to India from both the avian influenza case reported from China as well as the clusters of respiratory illness," said a statement from the Ministry.

AI can reliably detect emotions at par with psychotherapist

AI systems can reliably determine the emotional states of patients as accurately as a psychotherapist, according to research. The face reflects a person's emotional state. The interpretation of facial expressions as part of psychotherapy or psychotherapeutic research, for example, is an effective way of characterising how a person is feeling in that particular moment. But the process of analysing and interpreting recorded facial expressions as part of research projects or psychotherapy is extremely time-consuming, which is why psychiatry specialists often use less reliable, indirect methods such as skin conductance measurements, which can also be a measure of emotional arousal.

Researchers at the University of Basel in Switzerland said AI could become an important tool in therapy and research. AI systems could be used in the analysis of existing video recordings from research studies in order to detect emotionally relevant moments in a conversation more easily and more directly. This ability could also help support the supervision of psychotherapists, they noted in the study published in the journal Psychopathology. To determine whether



AI systems can reliably determine the emotional states of patients in video recordings, they used freely available

artificial neural networks that were trained in the detection of six basic emotions (happiness, surprise, anger, disgust,

sadness and fear) using more than 30,000 facial photos. This AI system then analysed video data from therapy sessions with a total of 23 patients with borderline personality pathology. The high-performance computer had to process more than 950 hours of video recordings for this study. The results were astonishing: Statistical comparisons between the analysis of three trained therapists and the AI system showed a remarkable level of agreement, the researchers said.

The AI system assessed facial expressions as reliably as a human but was also able to detect even the most fleeting of emotions within the millisecond range, such as a brief smile or expression of disgust. These types of micro expressions have the potential to be missed by therapists or may only be perceived subconsciously. The AI system is therefore able to measure fleeting emotions with an increased level of sensitivity compared to trained therapists. "We were really surprised to find that relatively simple AI systems can allocate facial expressions to their emotional states so reliably," said Dr. Martin Steppan, psychologist at the University's Faculty of Psychology. "Nevertheless, therapeutic work is still primarily about human relationships,


Eat your breakfast, dinner early to reduce heart attack risk

London: Are you one of those people who skip their first meal of the day or eat a late breakfast and dinner? Beware, you may be at risk of heart attack, warns a study. The study suggested eating the first meal of the day at 8 a.m. and dinner by 8 p.m. to avoid risk of cardiovascular disease. Cardiovascular diseases are the leading cause of death in the world according to the Global Burden of Disease study, with 18.6 million annual deaths in 2019, of which around 7.9 are attributable to diet. This means that diet plays a major role in the development and progression of these diseases.

The study by French research institute INRAE - National Research Institute for Agriculture, Food and Environment showed that having a first meal later in the day (such as when skipping breakfast), is associated with a higher risk of cardiovascular disease, with a 6 per cent increase in risk per hour delay. For example, a person who eats for the first time at 9 a.m. is 6 per cent more likely to develop cardiovascular disease than someone who eats at 8 a.m.



When it comes to the last meal of the day, eating late (after 9 p.m.) is associated with a 28 per cent increase in the risk of cerebrovascular disease such as stroke compared with eating before 8 p.m., particularly in women. Finally, a longer duration of night-time fasting - the time between the last meal of the day and the first meal of the following day - is associated with a reduced risk of cerebrovascular disease, supporting the idea of eating one's first and last meals earlier in the day. For the study, published in Nature Communications, the scientists used data from 103,389 participants to study the associations between food intake patterns and cardiovascular disease. The findings, which need to be replicated in other cohorts and through additional scientific studies with different designs, highlight a potential role for meal timing in preventing cardiovascular disease. The team suggest that adopting the habit of eating earlier first and last meals with a longer period of night-time fasting could help to prevent the risk of cardiovascular disease.



'Govt caught off guard in handling energy crisis amid West Asia war': Asaduddin Owaisi at TV9 Network's 'What India Thinks Today Summit 2026'

New Delhi: "India is reeling under an acute energy crisis amid the war in West Asia and the ruling government has been caught off guard and is unable to handle the crunch," said Asaduddin Owaisi, Member of Parliament, and President of the All India Majlis-e-Ittehadul Muslimeen (AIMIM). He was speaking at the fourth edition of TV9 Network's 'What India Thinks Today Summit 2026', in New Delhi on March 24.



'Govt didn't create strategic petroleum reserves'

Owaisi pointed out that the BJP-ruled government did not create strategic petroleum reserves even though it has been in power for 11 years. As a result, he claimed today we are facing urea, LPG, gas and crude oil crisis. "After the Assembly elections, the prices of petrol and diesel will be increased," the MP from Hyderabad said. He added that the small vendors are bearing the brunt of the current crisis and the situation will get worse if it drags on. Owaisi questioned: "Why is the US deciding our oil imports? Why is India begging to the US and seeking Trump's approval to buy

Russian oil? Where has our self-respect gone?" He pointed out that all ships of China and Russia are being passed without any hassle from the Strait of Hormuz, but India had to request Iran to give passage to two vessels from the waterway. "Even these vessels aren't carrying enough to meet the demand of fuel and the demand-supply gap is yawning," Owaisi added.

'Doesn't untreated sewage going into Ganga hurt religious sentiments?'

Responding to allegations about an iftar party on a boat and claims that chick-

en biryani waste was dumped into the Ganga, Owaisi underlined that so much untreated sewage flows into the river but nobody is bothered about it. "Doesn't sewage finding its way into river Ganga hurt religious sentiments and cause outrage?" he asked, adding that many cruises and waste released from them also pollute the river.

'Constitution must be upheld'

Citing alleged cases of discrimination and ill-treatment being faced by Muslims in India, he said they are as much citizens of

the country as anyone else and did not come from elsewhere. "The Constitution must be upheld — we should have faith in it and run the country in adherence with its principles," the MP pointed out. "This country has no (official) religion. But the ruling party has turned nationalism into Hindu nationalism (given it a Hindu identity)," Owaisi said. He added that he didn't need a certificate to prove that he is an Indian, while raising concern about narratives spread by Hindutava groups about celebrating 'Khooon Ki Holi' on Eid in Delhi's Uttam Nagar.

Hits out at Assam CM

The Hyderabad MP Asaduddin Owaisi accused Assam CM Himanta Biswa Sarma of promoting hatred between religious communities. He alleged that the Assam CM circulated a "violent video" depicting "shooting Muslims" and hit out at his remark urging people to pay Rs 2 less to "miyan Musalman". Owaisi said that if Sarma needed Rs 2, he could give it himself, questioning why a Chief Minister would make such statements. He pointed out

that Sarma is saying that he will create an environment where Muslims will be forced to go out of the state. Owaisi also pointed at that Supreme Court-monitored National Register of Citizens (NRC) exercise in Assam, noting that around 20 lakh people were left out of the list. Of these, he said 2.5 lakh were Muslims while 17.5 lakh were non-Muslims, asking who should then be considered "infiltrators". He criticised the move to grant citizenship to non-Muslims under the Citizenship Amendment Act while asking Muslims to produce documents to prove that they are Indians. He added that with agencies like the Border Security Force and the Home Ministry under government control, questions remain about how infiltrators are entering the state. He further stated that Mizoram CM reportedly said that around 2,000 foreigners entered the state and later moved into Myanmar. Owaisi alleged that Matthew Aaron VanDyke, who was arrested from Kolkata airport recently, was an US agent bringing drones into India and providing drone training.

Shops and restaurants in Egypt told to close early as energy crisis deepens

Shops, restaurants and cafes in Egypt have been told to close early as part of a raft of temporary measures to combat soaring energy prices caused by the Iran war. Retail and dining premises will have to close by 21:00 (19:00 GMT) each night for the next month, beginning on Saturday. The "exceptional measures" introduced by the Egyptian government also include dimming street lights and roadside advertising, as well as a return to home working for one day a week in April for many. Egypt has been particularly affected by the Middle East conflict and the effective blockade of the Strait of Hormuz, a key shipping route for oil and liquefied natural gas. Global oil prices have skyrocketed since supply via the waterway came to a near-total halt, with fears there could be a knock-on effect on the price of food, medicine and other goods if left unresolved. Even though Egypt has no involvement in the war, its reliance on imported fuel has made it vulnerable to supply shocks. Egypt's Prime Minister



Mostafa Madbouly said on Saturday that its petrol bill alone had more than doubled from January to \$2.5bn (£1.9bn) in March. Hotels and tourist attractions will be exempt from the energy-saving measures, the government has said. Tourism is estimated to make up around a 10th of Egypt's economy. However, several hotels in Cairo, including the Marriott and Cosmopolitan, told broadcaster RFI that they had acquired generators in case of power cuts and would keep their restaurants open for guests irrespective of closing times elsewhere.

While most employees will be told to work from home for one day a week, essential workers - such as those in hospitals, schools and factories - will be excluded. Since Iran began threatening to strike ships transporting good through the Strait of Hormuz, most international shipping through the narrow chokepoint has ceased. Usually, around 20% of the world's oil and gas supply flows through it. US President Donald Trump has repeatedly vented his frustration that allied nations were unwilling to help escort ships through the waterway.

Some ships have passed through the strait since the war began, though several of these had links to Iran, China or India. Thailand said on Saturday that it had reached an agreement with Iran, giving its oil tankers safe passage. The Egyptian government has already raised petrol prices and the cost of taking public transport to limit the impact of the conflict on its public finances. It will also slow down large, energy-intensive state projects and cut government vehicle fuel allowances by nearly a third, news agency Reuters reports.

Iran says its forces are 'waiting' for US ground troops, as more American marines arrive in region

Despite the heavy rain, hundreds of people gathered this morning in a cemetery in the southern suburbs of Beirut for the funeral of three Lebanese journalists killed in a targeted Israeli air strike in southern Lebanon yesterday, an attack that has sparked commotion and anger in this country. The mourners included relatives and other journalists who carried pictures of Ali Shoeb, Fatima Fetoni and Mohamed Fetoni. The emotional ceremony happened in the area known as Dahieh, where the Iranian-backed group Hezbollah holds sway. Other graves were marked with the bright yellow flag of the group. Shoeb was a well-known reporter for Al-Manar, a Lebanese TV station affiliated with Hezbollah. The Israeli military described him as a "terrorist" in the intelligence unit of Hezbollah's elite Radwan Force, but it provided no evidence to support the claim that he played a mili-



tary role in the organisation. The Committee to Protect Journalists said last year that "Israel, in particular, has repeatedly killed journalists whom it subsequently - and in some cases preemptively - alleged were militants, without providing credible evidence to support its claims". It also says that impunity is virtually the norm in Israel in cases where journalists are killed by the country's military. The

Israeli military has not offered any comment on the killings of the Fetonis - Fatima was a correspondent with the Al-Mayadeen channel and her brother worked as a cameraman. Lebanon's President Joseph Aoun condemned the killing of the journalists as a "blatant crime" that "violated the most basic rules of international law". Human rights groups fear Israel is carrying out in Lebanon similar tactics that it employed in Gaza, with deliberate attacks on journalists, healthcare professionals and others, often providing unfounded claims that those killed had military involvement with Hezbollah. The cases are almost never investigated by the Israeli military. Verified video shows damage to a building where the Qatari TV network al-Araby has an office in north-east Tehran. One clip, filmed from

Vafamaneh Street near Heravi Square, shows the building's windows blown out, with debris and dust scattered across the area. Signs on the building indicate a beauty salon, a cafe and another office are also located there. Another video, filmed by al-Araby correspondent Hazem Kallas, shows damage inside the building. Kallas also films outside, where Iranians are gathered near damaged cars, and says adjacent buildings were badly damaged. Al-Araby shared the footage, saying its office in Tehran had been damaged by a missile. It said its staff were unharmed but there was "significant material damage". It's not immediately clear from the videos what the target of the reported strike was. BBC Verify has asked the Israel Defense Forces and the US military's Central Command to comment on what happened. Normally, during the roughly two-week Persian New Year holidays, which

began on 21 March, businesses like tourism and hospitality would flourish. But I've heard it hasn't been the same as last year. A restaurant owner in Tehran, a man in his 30s, told me: "Many businesses are completely shut down now. My situation is not better than theirs. It's been very quiet, and I think I can hold up the business for one month maximum." Some businesses are struggling because of the government-imposed internet outage. Others need to repair their homes after strikes. A woman in her 20s, who had travelled to a northern province to "distract" herself from the war, said: "My mum called me to tell me that all the glasses of our windows had been shattered when a strike happened behind our house in Tehran. Luckily my parents had blankets on them when it happened, and nothing happened to them." There are also those in Tehran suffering with their pets, as the city has seen the heaviest strikes.

It is a story that is gripping Germany and has led to one of its best known TV stars tearfully telling thousands of protesters from a stage in Hamburg how she had to wear a bulletproof vest, due to death threats. ONE ANT FOR \$220: THE NEW FRONTIER OF WILDLIFE TRAFFICKING



The ants are flying in Kenya at the moment. During this rainy season, swarms can be seen leaving the thousands of anthills in and around Gilgil, a quiet agricultural town in Kenya's Rift Valley that has emerged as the centre of a booming illegal trade. The mating ritual sees winged males leave the nest to impregnate queens, who also take flight at this time. This makes it the perfect time to chase down queen ants to sell on to smugglers who are at the heart of a growing global black market, that taps into the pet craze for keeping ants in transparent enclosures designed to observe the insects as they busily build a colony. It is the giant African harvester ant queens, which are large and coloured red, that are most prized by international ant collectors - one can fetch up to £170 (\$220) on the black market, which tends to operate online. A single fertilised queen is able to create a whole colony and can live for decades - and can be easily posted as scanners do not tend to detect organic material. "At first, I did not even know it was illegal," a man, who asked not to be named, told the BBC about how he had once acted as a

broker, linking foreign buyers with local collection networks. Also known as Messor cephalotes, these ants are native to East Africa and known for their distinctive seed-gathering behaviour making them popular with ant collectors. "A friend told me a foreigner was paying good money for queen ants - the big red ones which are easily seen around here," the former broker said. "You look for the mounds near open fields, usually early morning before the heat. The foreigners never came to the fields themselves - they would wait in town, in a guest house or a car, and we would bring the ants to them packed in small tubes or syringes they supplied us with." The scale of the illicit trade in Kenya became apparent last year when 5,000 giant harvester ant queens - mainly collected around Gilgil - were found alive at a guest house in Naivasha, a nearby lakeside town popular with tourists. The suspects - from Belgium, Vietnam and Kenya - had packed the test tubes and syringes with moist cotton wool, which would enable each ant to survive for two months, according to the Kenya Wildlife Service (KWS).

Welcome to Cake Picnic, Sydney edition. It's the viral event that's already sold out dates in San Francisco, New York and Los Angeles. Tickets in Dubai, London and Mexico City were harder to come by than a double-yolk egg. And now it's landed on Australian shores, with a Melbourne event earlier this month boasting 1,600 cakes in one sitting. "I had no idea that I could ever go on tour for cake," laughs Cake Picnic founder Elisa

Sunga, part-time hobby baker and full-time Google employee. "People go on tour for music and whatnot, but for cake? It just seems so whimsical and delightful to be able to do that." The concept is simple. Two years ago, Sunga - who moved to San Francisco aged 12 from her hometown of Baguio City in the Philippines - posted an online invitation for a small gathering with one request: everyone must bring a cake.

IRANIAN ATTACKS ACROSS GULF CONTINUE AS MAJOR INDUSTRIAL SITES HIT

Gulf nations reported a series of attacks as the US-Israel war against Iran entered its fifth week, including strikes on major industrial infrastructure. The United Arab Emirates (UAE) said a number of people had been injured in an Iranian strike on a key aluminium plant in Abu Dhabi, with significant damage reported by operator Emirates Global Aluminium. Meanwhile, state-controlled Aluminium Bahrain said two employees were wounded by an Iranian attack on one of the world's largest aluminium smelting facilities. It comes after Yemen's Iran-backed Houthis entered the conflict on Saturday, raising fears of further economic disruption should they target shipping in the Red Sea.



The group said it had launched a barrage of missiles against Israel targeting "sensitive" military sites, and vowed to continue such attacks. Israel said it had shot down two missiles coming from Yemen. Oil and gas prices have already spiked as Iran has effectively shut the Strait of Hormuz, a key shipping route for global energy supplies between the Persian Gulf and the Gulf of Oman.

If the Houthis decided to attack shipping - as it did in support of Hamas after war erupted in Gaza, following the Hamas-led attacks on Israel on 7 October 2023 - it would risk sending energy prices higher. As the war entered its second month, Oman said it was investigating "cowardly attacks" for which no one had yet claimed responsibility after a foreign worker was reportedly injured in a

drone strike on its southern port of Salalah. Kuwait's defence ministry said the radar system at its international airport had been significantly damaged after being attacked by 15 drones. Tehran separately accused Israel of targeting two of its steel production operations, while its Islamic Revolutionary Guard Corps (IRGC) threatened retaliatory action against the US and Israel after two of Iran's universities were hit. It said Israeli and American universities in the Middle East were considered legitimate targets "until two of their universities are struck". Meanwhile, Israel continued its strikes against Iran and Lebanon, where journalists were killed in a targeted Israeli strike on Saturday, according to their employers.

THREE LEBANESE JOURNALISTS KILLED IN ISRAELI STRIKE, SAY BROADCASTERS

Three Lebanese journalists were killed in a targeted Israeli strike in southern Lebanon on Saturday, their employers have said. Ali Shoeb, a reporter for the Hezbollah-affiliated Al Manar TV, was killed in the town of Jezzine alongside reporter Fatima Ftouni and her brother, cameraman Mohamed Ftouni, both from the channel Al Mayadeen, according to the stations. The strike reportedly hit the journalists' car just before noon local time (10:00 GMT). The Israel Defense Forces (IDF) confirmed it had killed Shoeb, describing him as a "terrorist" from Iranian-backed Hezbollah's elite Radwan Force who had



"operated for years under the guise of a journalist". It said he had worked to "expose the locations of IDF soldiers operating in southern Lebanon and along the border", including during the current fighting, and had used his position "to disseminate Hezbollah propaganda

materials". The IDF provided no evidence to support its claim that Shoeb had a military role. It did not comment on the deaths of Fatima or Mohamed Ftouni. Hezbollah denounced the strike as the "deliberate criminal targeting of journalists". "The enemy's false claims are

nothing but an expression of its weakness and fragility, and a desperate attempt to evade responsibility for this crime," the group said in a statement on Telegram. Lebanese President Joseph Aoun described it as a "brazen crime" that broke the "most basic rules" of international law by targeting reporters, "who are ultimately civilians performing a professional duty". Prime Minister Nawaf Salam likewise condemned the attack in a statement on X, branding it a "flagrant violation of international humanitarian law and a clear breach of the rules that guarantee the protection of journalists in times of war".

PRISON PHONE CALL RECORDINGS RAISE QUESTIONS OVER EX-ABERCROMBIE BOSS' FITNESS FOR TRIAL



Former Abercrombie & Fitch CEO Mike Jeffries was recorded telling his British partner "we're screwed" and in "big trouble" if he was found fit to stand trial on sex trafficking charges later this year, a New York federal court has heard. The audio was part of more than 100 phone calls between the ex-fashion boss and Matthew Smith referred to during a four-day mental competency hearing this week on Long Island. Jeffries' lawyers argue that he is suffering with dementia and late onset of Alzheimer's disease and is unfit to face trial alongside his partner and their alleged middleman James Jacobson, 73, were charged with running a global sex trafficking and prostitution business in October 2024. They have pleaded not guilty to the charges, which carry a maximum sentence of life in prison. Their arrests followed an October 2023 BBC investigation and ongoing podcast series that revealed the trio had been at the centre of a sophisticated operation scouting young men for sex around the world while Jeffries was CEO of Abercrombie & Fitch.

treated for four months in a mental health unit at a federal prison in North Carolina to see if he could regain competency. The 81-year-old had previously been found mentally incompetent last May but prison officials then declared in December that he was fit for trial following his hospital stay. Prosecutors told the court Jeffries frequently complained about prison conditions and was caught on tape describing to Smith how "horrible jail was", adding: "that's why we got to pull this off". Jeffries, his partner Smith, 62, and their alleged middleman James Jacobson, 73, were charged with running a global sex trafficking and prostitution business in October 2024. They have pleaded not guilty to the charges, which carry a maximum sentence of life in prison. Their arrests followed an October 2023 BBC investigation and ongoing podcast series that revealed the trio had been at the centre of a sophisticated operation scouting young men for sex around the world while Jeffries was CEO of Abercrombie & Fitch.

Tears and defiance as Lebanese family bury child, 11, killed in Israeli strike

A funeral has been held in a southern Lebanese village for an 11-year-old boy and his uncle who were killed in an Israeli air strike. Jawad Younes and 41-year-old Ragheb Younes were laid to rest in Saksakiyeh on Saturday after their family compound was hit a day earlier. They are among the latest casualties in Israel's offensive against the Iranian-backed armed group Hezbollah, after the group fired rockets into Israel earlier this month amid the war between the US and Israel against Iran. Lebanese health officials say more than 1,100 people have been killed since the escalation began, with civilians increasingly caught in the crossfire. The Israeli military did not



respond to a request for comment on the intended target of the strike that hit the Younes family compound. Hundreds gathered in Saksakiyeh town centre for Jawad and Ragheb's funeral. Women dressed in black robes wailed over the bodies, one of which was draped in Hezbollah's yellow flag - a reflection of the group's support in this largely Shia area.

Mary Kom, 6-Time World Champion, Considering Move To Professional Boxing



Olympic bronze medallist and six-time world champion Indian boxer MC Mary Kom on Sunday said she is considering a move into professional boxing. The 43-year-old, who became the first Indian woman boxer with an Olympic medal when she bronze in the 2012 London Games, is past the age eligibility to compete on the amateur circuit. "What can I say about the high points? Winning six World Championships was incredible. Although I reached a stage where age restrictions prevented me from competing further in amateur boxing for the country, a new opportunity has surfaced in Professional Boxing," she said on the sidelines of Sundays on Cycle event. "I am currently taking some time to consider it. I am working hard and trying to make a comeback to show people what I can still do. Widely considered one of the greatest amateur boxers, Mary Kom also underlined her commitment to grassroots development through her academy

Then in the fifth round when I caught him with the uppercut, I thought 'did I really do that?'" Itauma said on BBC Radio 5 Live. Talk will now turn to bigger fights and world titles after the unbeaten prospect recorded his 12th stoppage in 14 professional fights. Franklin - stopped for the first time in 27 bouts - had previously only been beaten by British fighters Anthony Joshua and Dillian Whyte. Itauma said he would "love to fight"

After witnessing Kohli's match-winning performance against Sunrisers Hyderabad in the Indian Premier League (IPL) opener, Rayudu asked the Royal Challengers Bengaluru (RCB) icon to reconsider his Test retirement. Speaking on a post-match show, Rayudu insisted that Kohli still has plenty to offer in the longest format and should be reinstated as the leader of the side, replacing current skipper Shubman Gill. "I don't think he is anywhere close to the end of his career. I think he still has five or six quality years left in him and, as Sanjay (Bangar) and I were discussing earlier, he should make a comeback in



Test cricket as well, hopefully as a captain," Rayudu said during a chat on ESPNCricinfo. Rayudu's comments underline the respect Kohli continues to command as a red-ball leader. He went on to describe Kohli as the finest Test captain India has produced, praising both his tactical acumen and the aggressive brand of cricket he instilled during his tenure. "We are serious. He is

the best red-ball captain I have seen in Indian cricket, and the way he is batting now, it is a loss for Indian cricket," he added. Kohli, who stepped down from Test captaincy in early 2022, has since focused on his batting across formats. His recent form (in white-ball cricket) has reignited discussions about whether India should consider bringing him back into a leadership role.

Japan Strike Late To Win Scotland Friendly


Scotland's first outing since ending a 28-year wait to qualify for the World Cup ended in defeat as Junya Ito's late strike earned Japan a 1-0 win at Hampden Park. In a stark contrast to the jubilant scenes that accompanied a thrilling 4-2 victory over Denmark in November to secure the Tartan Army's trip to North America, a subdued atmosphere contributed to a tame encounter. Japan had left a number of their key men, including Ito, on the bench in preparation for Tuesday's clash against England at Wembley. But they continued their impressive form in friendlies since securing qualification a year ago, which includes a first ever win over Brazil in October, as Ito scored the only goal six



minutes from time. Scott McTominay had Scotland's best chance of the match inside the opening 10 minutes, but the Napoli midfielder's effort was brilliantly saved by Zion Suzuki. Japan then slowly began to take control to extend Scotland's miserable record of not having won a home friendly for the past 10 years. Angus Gunn made a fine save from Ito when the

Genk forward ran clear on goal just after the hour mark. Gunn faces a battle with 43-year-old Craig Gordon to be Steve Clarke's number one for Scotland's opening game of the World Cup against Haiti on June 14. The Nottingham Forest 'keeper did himself few favours in that debate for the winning goal, though, as he went to ground too early and allowed Ito's tame effort to trickle into the net.

ARYNA SABALENKA SINKS COCO GAUFF TO WIN SECOND STRAIGHT MIAMI OPEN TITLE



Aryna Sabalenka won her second straight Miami Open title on Sunday beating Coco Gauff 6-2, 4-6, 6-3 to complete a "Sunshine Double" Indian Wells-Miami sweep. The world number one from Belarus, fresh off her first triumph in the California desert, became the fifth woman - and the first since Iga Swiatek in 2022 - to win both of the elite early season hardcourt WTA 1000 titles. "It means a lot," Sabalenka said after joining Poland's Swiatek, German great Steffi Graf, Belgian Kim Clijsters and fellow Belarusian Victoria Azarenka on the list of women to win both titles in the same year. "My goal always been to put my name in the history, and I just did it." Sabalenka underscored her WTA dominance in a season in which her only defeat to date was her Australian

Open finals loss to Elena Rybakina - who she went on to beat in the Indian Wells title match and in the semi-finals here. She handed Gauff her first career defeat in a hardcourt final. The American had won her first nine, including a triumph over Sabalenka in the 2023 US Open championship match. Gauff had also beaten the Belarusian for the title on the red clay of Roland Garros last year. So Sabalenka said she wasn't surprised to see Gauff dig in, even after the Belarusian pocketed the first set with a ruthless display of power and precision. She broke Gauff to open the match and, after Gauff saved three break points in a gritty fifth game, broke the American again in the seventh before serving it out in 37 minutes without facing a break point herself.

FITZPATRICK CREATES HISTORY WITH FIRST DP WORLD TOUR WIN

England's Alex Fitzpatrick claimed his first DP World Tour title at the Indian Open thanks to a strong final nine holes to continue his family's good run of form. The 27-year-old is the younger brother of European Ryder Cup player Matt Fitzpatrick who won last week's Valspar Championship and the siblings have made history as the first to win in successive weeks on the DP World Tour and the PGA Tour. But things turned from the 15th as the Spaniard found a bunker off the tee to start a run of three consecutive bogeys and Fitzpatrick's birdie gave him the lead. Fitzpatrick birdied the 17th to go four ahead and played the par-five 18th cautiously with a double-bogey seven still enough for victory.


