No ship movement in Strait of Hormuz skyrockets oil prices

FRANKFURT (TSIT): Oil prices rose sharply on Monday, March 2, as disruptions to tanker traffic through the Strait of Hormuz chokepoint raised uncertainty about how US and Israeli attacks on Iran would affect supply to the world economy.



Higher oil prices raise the prospect of costlier gasoline for US drivers as well as increased prices for other goods at a time when people in many countries have been stung by inflation.

Add a key focus was the Strait at the southern end of the Persian Gulf, through which 20 per cent of the world's oil supply passes.

Tanker traffic dropped sharply amid disruption of satellite navigation systems, data and analytics firm Kpler said on X, while the UK Maritime Trade Operations Centre reported attacks on several ves-

sels in the area on either side of the strait and warned of elevated electronic interference to systems that show where ships are. A bomb-carrying drone boat struck a Marshall Islands-flagged oil tanker in the Gulf of Oman, killing one mariner, Oman said.

Iran has been threatening vessels approaching the Strait of Hormuz and is believed to have launched multiple attacks. Saudi authorities reported they intercepted Iranian drones that attacked the Ras Tanura oil refinery near Dammam and the refinery was shut down as a precaution, Saudi state television reported.

Market attention has focused on whether the conflict would widen to other oil-producing countries in the region. There are pipelines that circumvent the Strait, but they

don't have enough capacity to move all the oil that passes the strait. Saudi Arabia, Iraq and the United Arab Emirates all depend on tankers to get the bulk of their oil to global markets. Analysts say completely blocking the Strait would hurt Iran too since all of its 1.6 million barrels per day passes through the Strait, most of which goes to China, where refineries are less concerned about US sanctions that prevent Iran from selling its oil elsewhere.

The Strait is also a key route for liquefied natural gas. European futures contract for April delivery shot up to 45.46 euros (USD 53.26) on the ICE commodities exchange.

The jump came after QatarEnergy said Monday it would stop its production of liquefied natural gas as the US-Israeli military campaign on Iran rages. The state-owned firm blamed the war for the decision. Qatar is a major gas supplier for Europe, which relies on shipments of liquefied gas, or LNG, to replace supplies of Russian pipeline gas lost due to the invasion of Ukraine.

Emirates, Etihad resume limited flights from Dubai airport

New Delhi, March 2 : UAE-based airlines Emirates and Etihad Airways announced on Monday that they will start operating a limited number of flights from the evening, after Dubai Airports confirmed a partial resumption of operations after the airport was closed due to the outbreak of hostilities between the US-Israel alliance and Iran.

Three US jets downed in Kuwait, friendly fire: CENTCOM

Washington, March 2 : Three U.S. F-15E Strike Eagles flying in support of Operation Epic Fury were shot down over Kuwait in what American military officials described as an apparent friendly fire incident, with all six aircrew safely recovered.



The incident occurred at 11:03 p.m. ET on March 1, according to a statement issued by CENTCOM. "At 11:03 p.m. ET, March 1, three U.S. F-15E Strike Eagles flying in support of Operation Epic Fury went down over Kuwait due to an apparent friendly fire incident," the release said.

The aircraft were operating during active combat conditions. During active combat involving attacks from Iranian aircraft, ballistic missiles, and drones, the U.S. Air Force jets were mistakenly shot down by Kuwaiti air defences.

The U.S. military confirmed that all crew members survived the incident. All six aircrew were safely recovered and are in stable condition, according to the release.

It added that "Kuwait has acknowledged this incident, and we are grateful for the efforts of the Kuwaiti defence forces and their support in this ongoing operation."

Iran war: Andhra CM directs officials to ensure safe return of stranded Telugus

Amaravati (TSIT): N. Chandrababu Naidu on Monday directed officials to ensure the safe return of people from Andhra Pradesh stranded in Middle East countries affected by the ongoing conflict. Reviewing the situation at his camp office with officials of the Real Time Governance Society (RTGS) and representatives of the Andhra Pradesh Non-Resident Telugu Society (APNRTS), the Chief Minister instructed authorities to coordinate closely with the Central government and Indian embassies to facilitate the return of people from Saudi Arabia, Dubai, Qatar and Kuwait.

Middle East tensions: Modi speaks to Saudi Crown Prince, Bahrain and Jordan

New Delhi (TSIT): Prime Minister Narendra Modi on Monday spoke to the King of Bahrain and the Crown Prince of Saudi Arabia and condemned the recent attacks on the two countries in violation of their sovereignty and territorial integrity, asserting that India stands in solidarity with their people in this difficult hour.



The prime minister also spoke to King Abdullah II of Jordan and conveyed deep concern at the evolving situation in the region.

During his telephonic conversations with Bahrain King Hamad Bin Isa Al Khalifa and the Crown Prince and Prime Minister of Saudi Arabia, Mohammed Bin Salman, Prime Minister Modi said that the earliest restoration of regional peace and stability is of utmost importance and thanked them for looking after the well-being of the Indian community living there in these difficult times.

"Discussed the evolving situation in West Asia with Crown

India condemns the attacks on Bahrain and stands in solidarity with its people in this difficult hour. I thank him for the steadfast support extended to the Indian community in Bahrain."

About his phone call with the King of Jordan, Modi said: "Spoke with His Majesty King Abdullah II, the King of Jordan. Conveyed our deep concern at the evolving situation in the region"

"We reaffirm our support for peace, security and the well-being of the people of Jordan. I thanked him for taking care of the Indian community in Jordan in this difficult hour," he wrote on 'X'.

The telephonic conversations took place in the wake of the attack on Iran by the US and Israel, in which Iran's Supreme Leader Ayatollah Ali Khamenei was killed, and Iran's retaliation, in which it fired drones and missiles at Israel and US military installations around the Gulf, and also at the global business and aviation hubs Dubai and Doha.

Centre prepared to bring back Indians stranded in West Asia: Union Minister Pralhad Joshi

BENGALURU: (March 2) The Centre is fully prepared to bring back Indians stranded in the Gulf region and is in touch with Indian missions abroad to ensure their safety, Union Minister Pralhad Joshi said on Monday.



In a statement, Joshi said discussions have been held with senior officials of the concerned embassies to facilitate the safe return of those affected by the war situation.

"Whenever Kannadigas and other Indians face distress anywhere in the world, the Central Government has ensured their safe return. Earlier, we brought back those stranded in Ukraine. Wherever Indians are, their safety remains our first priority," he said.

Joshi said information has been received about Kannadigas facing hardship due to the severity of the Iran-Israel conflict, and urgent consultations have been held with senior ministers to take necessary measures for their protection. Reassuring anxious fami-

lies, the Minister said there was no need to panic and that the government is committed to bringing back all Indians safely. He noted that air travel in war-affected regions is currently risky and expert advice is being sought before taking further steps. Joshi said efforts are also underway to assist those stranded in Dubai, where flight operations have been affected. "No one should be anxious. Serious efforts are being made to bring them back safely," he added.

**Residents Urge District Collector to Curb Illegal Encroachments in Begumpet**

Sangareddy, March 2 (TSIT) Serious concerns are being raised over the functioning of the administration in Sangareddy district, with villagers alleging that public grievances are repeatedly being ignored. Complaints submitted during the Prajavani grievance redressal program are allegedly ending up "in the dustbin" without any resolution. Residents of Begumpet village in Kandi mandal have appealed to the District Collector to immediately stop alleged illegal encroachments on government land in their village. They expressed anger that despite open occupation of government land, officials have remained indifferent. According to villagers, certain individuals have encroached upon government land near the village water tank and are continuing construction activities. They claim to have submitted multiple complaints to the concerned authorities, but no action has been taken so far. Victims questioned whether the repeated lack of response indicates that their petitions are being deliberately sidelined. Adding to the controversy, villagers alleged that forged signatures of the Gram Secretary were used to create fake documents to facilitate illegal construction on govern-



ment land. They also criticized officials for allegedly ignoring a Gram Panchayat resolution related to the issue. "Why are incompetent officials who cannot resolve problems continuing in their positions? Have they forgotten their responsibilities due to the lure of bribes?" villagers questioned sharply. They urged the District Collector to inspect on the state of district administration if even the first citizen of the village is left without support.

These apps may gain access to OTPs, banking details, contacts, and social media accounts, leading to financial loss and identity misuse. How the Fraud Operates Victims receive attractive Holi offers or greeting links. Clicking the links leads to fake websites or

malicious app downloads. Fraudsters collect OTPs, card details, and login credentials. Compromised accounts are used to further defraud victims and their contacts. Immediate Action in Case of Fraud The Bureau advised citizens to Stop financial transactions immediately if suspicious activity is detected.

**MINISTER STUCK IN DUBAI**



Khammam (TSIT): Tummala Nageswara Rao, Telangana Agriculture Minister, has been stranded in Dubai following the suspension of flight operations at Dubai International Airport amid escalating tensions in the West Asia region. According to official sources, the Minister had travelled to Dubai about five days ago to visit a close relative who is undergoing treatment at a private hospital there. He was scheduled to return to Hyderabad shortly, but the sudden closure of airspace and cancellation of several international flights disrupted his travel plans. Sources clarified that Mr. Rao is safe and staying in Dubai while awaiting the resumption of flight services. He is said to be in regular touch with government officials in Telangana and monitoring the situation closely. His return is expected once normal flight operations are restored and travel advisories are reviewed. Meanwhile, several passengers from Telangana and other parts of India are reportedly stranded at airports across the Middle East due to widespread cancellations and diversions of flights triggered by the prevailing regional tensions. Airline authorities are assessing the situation on a day-to-day basis, and services are likely to resume depending on further developments.

**Special focus on cervical cancer prevention, child mental health.**

Mancherial, March 2, TSIT: The district administration has intensified efforts to prevent cervical cancer among women while giving priority to the mental well-being of children, said Additional Collector (Local Bodies) P. Subbarayudu, IPS, under the supervision of RSASTF SP Sri P. Srinivas, IPS, and under the supervision of Adtl SP Sri J. Kulasekar.



As part of that, in order to trace the absconding accused in the case of Claim No. 02/2026, based on the secret information received with the help of intelligence, yesterday evening i.e. 01.03.2026, they reached Siddapura village and post, Harathnahalli village, Hassan district, Karnataka state, and reached the nearby godown with the help of Karnataka police. At that time, some people were there with three vehicles, but they tried to flee on seeing the police. However, the task force personnel cleverly chased them and took 8 people into custody while some others fled. After questioning the arrest-

ed persons and based on the information provided by them, an open shed similar to a chicken farm was inspected and 195 red sandalwood logs, red sandalwood reapers and scrapers along with three vehicles used for smuggling red sandalwood were seized. It is learnt that some of the abscond-

ing persons are major smugglers. The value of the seized red sandalwood logs and vehicles may be around Rs. 5 crore. The main perpetrators of this smuggling are being identified and arrested. Special teams have been formed for this purpose. In this case, the task force

## Four money lenders arrested in triple suicide case in Hyderabad

Hyderabad, March 2 : Hyderabad police have arrested four illegal money lenders, as harassment by them for repayment of loans drove three members of a family to suicide last month.

Deputy Commissioner of Police, Secunderabad Zone, Rakshitha Krishna Murthy, on Monday announced the arrests.

Kadgekar Ramraj, 54, his wife Madhavi, and younger brother Kadgekar Shashank Raj were found dead at their residence in Babu Nagar, Amberpet, on February 24.

Amberpet police had regis-

tered a case and took up an investigation. Suicide notes were recovered from the scene in which the deceased mentioned the illegal demands and harassment by illegal financiers.

According to the DCP, the suicide letters and statements of family members and witnesses revealed that the deceased were facing severe financial harassment from certain money lenders from whom they had taken a loan of Rs 57 lakh for running "King's Biryani" hotels at Mallapur and Chakripuram.

The accused were collecting



high interest on a daily basis. They were demanding excessive and illegal interest and had forcibly obtained blank cheques, promissory notes,

MOUs, and original land documents. The accused had repeatedly threatened and humiliated the deceased over the phone. They had also

threatened to visit their house and insult them publicly. Call data records confirmed that on the intervening night of February 23 and 24, the accused contacted the family and threatened them with dire consequences, with a demand for repayment of loan amounts. Based on the evidence collected during the investigation, the section of law was altered to Section 108 of BNS (Abetment to Suicide).

On March 2, the accused were arrested. They have been identified as Mohd Wasi Uz Zaman alias Irfan, who has a real estate and scrap business,

P. Rajasekhara Reddy, who is into construction work, Mohd. Nawaz, a businessman, and Syed Majeed Hyder, an electrician. During interrogation, the accused admitted to lending money at high interest rates and pressuring the deceased's family members for repayment. They also confessed to forcibly collecting blank cheques, promissory notes, and property documents as collateral security. The continuous harassment, unlawful financial pressure, threats, and humiliation caused severe mental trauma to the deceased family members.

# EDITORIAL

## How Khamenei's Killing Is Doing Exactly The Opposite Of What US-Israel Wanted

In 2019, I was on a reporting assignment to Kargil, which was my first visit to the place. I knew the town was Shia-majority, but I wasn't ready for what I saw outside the city centre mosque. There were larger-than-life cutouts of Iran's Supreme Leader, Ayatollah Ali Khamenei, who was killed on February 28 in Israeli-American air strikes on his office complex in Tehran. Back then, I was so struck by the cutouts that I wondered if I had gotten it wrong. Maybe it wasn't Khamenei at all, maybe it was someone else, I wondered. A few men in Iranian-style black headgear stood outside the mosque, perhaps preparing for afternoon prayers. I walked up and asked if those were indeed cutouts of Ali Khamenei. They confirmed it. So I asked the obvious question: why would his image be displayed here, in faraway Kargil? They answered almost in unison. Khamenei was their number-one spiritual leader, the global temporal head of all Shias. A couple of years later, I happened to visit Lucknow and went to the iconic Bada Imambara. Once again, the walls were covered with photos and cutouts of the same man. Cut to today. Outside the Iran Cultural Centre in Delhi, hundreds of mourners from across India have gathered, wearing black badges, visibly in mourning. Social media is flooded with videos of people marching through the main roads of Srinagar, grief smeared across their faces. In India's western neighbourhood, we have seen videos of at least eight mourners killed after security forces opened fire on pro-Iran protesters outside the US Consulate in Karachi.

### Shias and Sunnis

The Muslim world is divided broadly between the majority Sunni and minority Shia. Outside Iran, which is almost entirely Shia, the largest Shia population lives in the Indian subcontinent. Shias have lived peacefully in India and are treated like any other community, though they have often been subjected to violence by Sunni groups in Pakistan. But when it comes to the Ayatollah, both Shias and Sunnis revere him in nearly equal measure. And when it comes to his killing at the hands of Israel and the US, the majority in both communities will express their grief and solidarity in one voice. Some Shia and Sunni friends sent me messages yesterday saying it was "one of the worst days of their life". Of course, there are reports from within Iran, reported by Western media, of celebrations over the news of Khamenei's death. And if you are looking at him from the Trumpian lens, he was, as the President said, "one of the most evil people in history". Instead, however, we have witnessed lakhs of people take to the streets of Tehran, mourning the assassination of their beloved spiritual figurehead.

### From Placeholder To The Ayatollah

What Israel and the US have done is make Khamenei, who was running a country dealing with extreme economic hardships, protests and internal squabbles, a martyr. But we will come to that in a bit. First, how did Khamenei acquire such a cult status? We need to turn the pages of history. In 1979, Iran's Islamic Revolution toppled the corrupt regime of King Reza Shah Pahlavi and brought Ayatollah Ruhollah Khomeini back from exile in France, where he had spent 14 years orchestrating opposition through cassette tapes smuggled into Iran. Khomeini's return to Tehran was met by millions, and he swiftly established himself as the Supreme Leader of the new Islamic Republic. Those who lived during the revolution years and after would remember how Khomeini was revered by Shias all over the world. Fondly called the 'Ayatollah', he was successful in fusing religious authority with absolute political power.

# Gulf Confronts An Ugly Truth About Aligning With America

The enormity of America's political assassination of Iran's Supreme Leader Ali Khamenei cannot be overstated. Iran had not committed any aggression against the US, and yet its top leader and generals have been physically eliminated. It was also not planning any military strikes against either the US or Israel, and, therefore, the latter cannot justify a 'pre-emptive' strike.

What is worse, serious and productive diplomatic negotiations were being conducted by the US and Iran with Oman's mediation. The Omani Foreign Minister, in a bid to prevent a US strike, had said publicly in an interview with a US news channel that Iran had all US demands on its nuclear programme on enrichment, stockpiles, IAEA (International Atomic Energy Agency) inspection and a formal commitment to never acquire nuclear weapons. According to him, Iran had gone beyond what it had conceded in its 2015 nuclear deal with President Barack Obama. The IAEA chief himself was involved in these negotiations. The next round of discussions at the technical level was to be held in Geneva. But before these could be held, President Trump short-circuited the diplomatic effort and decided to attack Iran. This is the second time that Trump has decided to attack Iran in the midst of negotiations. The first was when the 12-day war in June 2025 was initiated while talks were being held.

### Iran's Concessions, US Double Standards

The Iranian nuclear issue has to be seen in perspective. Iran is a signatory to the Non-Proliferation Treaty (NPT), but under the framework, it has the right to enrich uranium for peaceful purposes - a right that Iran has been unwilling to forswear, though in the latest round of negotiations with the US, it made concessions on enrichment limits. This is something it had not done earlier. Irrespective of all this, the fact also is that the US ignores the nuclear status of Israel, which is an open secret. The US has also reconciled itself to North Korea's repudiating the NPT and acquiring nuclear weapons. It has been complicit in Pakistan becoming a nuclear power and has not made an issue of continuing nuclear cooperation between



Pakistan and China. The US has walked out of all disarmament treaties negotiated with Russia and has announced that it will resume nuclear testing. Against this background, the US's focus on Iran's nuclear programme, which is under strict IAEA supervision, seems to be dictated by considerations related principally to Israel's security and regional pre-eminence. Trump had announced in June 2025 that during the 12-day war, the US had obliterated Iran's nuclear programme. If that is the case, then why make Iran's nuclear issue the *casus belli*, or, case for war?

### Where Are The Nuclear Weapons, Anyway?

That Iran is either a few months or a few weeks away from acquiring nuclear weapons is a narrative assiduously pushed by Israel and the US for a long time. However, years have passed without Iran going nuclear. Accusations that Iran has pursued a clandestine programme in secret facilities have never been proved. No doubt, Iran has increased enrichment levels, possibly as a negotiating tactic - a phased response presumably to Trump walking out of the Joint Comprehensive Plan of Action (JCPOA) during his first term. Perhaps Iran wanted to use its growing enrichment capacity as a bar-

gaining chip in negotiations for obtaining sanctions relief.

### Can't Expect A Country Not To Defend Itself

The US under Obama, too, had demanded curbs on Iran's missile capability and its regional role, which the latter had rejected. The JCPOA was thus limited strictly to the nuclear issue. But Trump revived these demands in the recent negotiations, primarily in view of Iran's demonstrated capability to attack Israel with devastating effect - which was seen during the 12-day war - and its support for Hamas and Hezbollah.

The point here is, there is no international regime, such as the NPT, that bars countries from possessing missile capability. To expect that Iran would give up its deterrence capabilities would have been unrealistic.

### No Rights And Wrongs Here

If Iran's regional role is a problem for the US, then Iran could view the regional role of the US and Israel as a problem, too - especially Israel's expansionism. In these matters, no clear judgment can be made on rights or wrongs, though it can be said that Iran has committed a serious strategic error by projecting itself as the biggest opponent of Israel and the principal supporter of the Palestinian cause, way beyond the support the

leaders of the Arab countries have given to the Palestinians. Arab countries have been more open towards Israel, either openly or more discreetly. Israel and the US, therefore, see Iran as the main obstacle to the regional acceptance of Israel, which the Abraham Accords represent.

### Is The Gulf Disillusioned?

One can seriously question Trump's strategy in seeking regime change in Iran without putting boots on the ground and encouraging the opposition elements to take over power from a weakened clerical dispensation. Earlier regime changes in the region undertaken by the US have failed abysmally in achieving their objectives, be it in Iraq, Libya or Syria. Political instability, divisions, violence, Islamism, economic distress, and refugee flows have ensued. It is not clear why Trump and his advisors believe that the consequences of de-stabilising Iran would be any more manageable. After all, Iran had warned the world repeatedly publicly that if attacked, it would target US bases in the region. The existence of these bases allows the US to exercise power regionally, and this includes providing security against Iran, which is viewed as a threat by Gulf states. That Iran is attacking bases and other sites in the UAE, Qatar, Bahrain, Saudi Arabia - even Oman - is not surprising.

# ASIA IS A VICTIM OF CONSPIRACIES AROUND THE WORLD

Asia's geopolitical landscape has been fraught with conflict, interference, and intrigue for centuries. This continent is not only a hub of population and culture, but is also considered the world's richest region in terms of natural resources. Yet, ironically, this same Asia has repeatedly been plunged into the flames of war, instability, and poverty. Whether it's the escalating tensions on the Iran-Pakistan border or the border conflict between Cambodia and Thailand, these events do not appear to be mere coincidences. Behind them, a broader global strategy appears to be at work, in which external powers pursue their own interests by keeping Asia in turmoil. Let Asia burn, and the coffers of developed countries fill - this is the naked truth of this politics. Countries in the Global South are rich in resources but lack decision-making power. Despite possessing oil, gas, coal, rare minerals, fertile land, and a young population - these countries remain mired in debt, unemployment, and instability. The root cause of this is not merely internal weaknesses, but the global system that has been designed to keep them dependent for decades. The plunder that developed countries began during the colonial period continues today in new forms - sometimes in the name of free trade, sometimes under the guise of democracy and human rights. The Iran-Pakistan tensions are the latest example. Long-standing sanctions on Iran have weakened its economy, while

Pakistan continues to live under foreign debt and economic pressure. Consequently, the escalating border tensions are no longer merely a local issue. Instability in sensitive areas like Balochistan could pit the two countries against each other. If this tension escalates, energy routes throughout South Asia and West Asia will be disrupted. Oil and gas prices will rise, directly benefiting the powers that control global markets. While war may be in Asia, profits will be reaped elsewhere. History bears witness to the frequent attempts by external powers to incite local conflicts to further their own interests. Sometimes they act as mediators, and sometimes they establish their bases under the guise of military aid and security. Afghanistan is a prime example, where decades of war raged, society was torn apart, and ultimately the very country they claimed to "help" suffered the most. Similar situations are being replicated in other parts of Asia. The Cambodia-Thailand dispute in Southeast Asia appears to be part of this strategy.

Tensions over temples and historical sites in the border region are not new, but the military overtones they have taken in recent years are worrying. The region is considered rich in rare minerals, demand for which is rapidly increasing in the era of new technologies and energy transition. When two neighboring countries engage in conflict, it becomes easier for outside powers to intervene. Access to resources is gained in exchange for military aid, investment, and loans. Ultimately, the local population suffers - in the form of environmental destruction, displacement, and economic inequality. This situation in the Global South did not arise suddenly. Since the mid-20th century, developed countries have used Asia, Africa, and Latin America as a source of raw materials and a market for finished goods. Colonial rule ended, but the economic structure remained unchanged. Even today, international financial institutions provide loans, but in return, they impose conditions that

strip these countries of their policy independence. Privatization of resources, reduction of subsidies, and import dependence - these are all part of the same trap. Internal weaknesses within this system are no less responsible. Corruption, power struggles, ethnic and religious divisions erode these countries from within. When societies are divided, external interference becomes easier. Those in power compromise long-term national interests for short-term gains. The voice of the people is suppressed, and decisions are limited to a select few. Nevertheless, it would be a grave mistake to assume that the Global South is helpless. Solutions exist, provided there is will. The first step is regional solidarity. Asian countries must resolve their disputes through dialogue and cooperation. Whether it's border disputes or the sharing of resources - the solution lies not in war, but in shared understanding. When neighboring countries stand together, the scope for external forces will automatically diminish. Another important aspect is economic self-reliance. Real control over resources is possible only when local industries and the public sector are strong. Emphasis must be placed on value addition rather than simply exporting raw materials. Transfer of technology is essential, but production capacity must be developed within the country. Self-reliance does not mean cutting off from the world, but connecting on an equal basis. Environmental justice is also a crucial part of this struggle. Indigenous and rural communities are bearing the brunt of the increased mining being carried out in the name of the energy transition. The countries most affected by the adverse effects of climate change are those that have contributed the least to it. Therefore, it is imperative to demand equitable participation and accountability on global platforms. Change is also necessary at the societal level. The education system must develop not only technical knowledge but also an understanding of history, politics, and the global economy.

# How The Iran-Israel War Can Pinch Pockets Across The World

The escalation of hostilities between Israel and Iran has brought West Asia back to the centre of global economic anxiety. While the immediate headlines focus on missiles, retaliation, and geopolitics, the deeper and more enduring impact of this conflict may be felt far beyond the battlefield - in global trade flows, energy markets, inflation trajectories, and maritime security. For a world economy already strained by fragmentation, protectionism, and slowing growth, this conflict threatens to become yet another systemic shock. At the heart of global concern lies oil and trade. West Asia is not merely a geopolitical flashpoint; it is the connective tissue of global commerce. Nearly one-fifth of the world's oil trade and a substantial share of liquefied natural gas (LNG) shipments pass through the Strait of Hormuz. Any sustained disruption - whether through direct military action, proxy attacks, or heightened insurance and security costs, will have an immediate knock-on effect across supply chains. Even without a complete closure of shipping lanes, uncertainty alone raises freight rates, delays deliveries, and forces rerouting, adding time and cost to global trade. The experience of recent years should make this worryingly familiar. From the pandemic to the Ukraine conflict and Red Sea disruptions, global trade has become increasingly vulnerable to geopolitical shocks. The Israel-Iran conflict adds another layer



of risk, particularly because it sits astride the world's most critical energy corridor. Unlike earlier disruptions that were to some extent regionally contained, this conflict has the potential to simultaneously affect energy supply, maritime logistics, and investor confidence - an unusually toxic combination. Oil markets will be, perhaps, the most immediate casualty. Even though the conflict escalated only 48 hours ago, it has already triggered volatility in crude prices, reflecting fears of supply disruption rather than actual shortages. History suggests that markets price in risk faster than reality. A prolonged conflict could push oil prices significantly higher, not because production collapses overnight, but because risk premiums rise across futures markets, shipping insurance spikes, and strategic stockpiling intensifies. For oil-importing economies like India, this acts as an inflationary tax, one that governments

can neither easily predict nor control. Energy costs ripple through transport, manufacturing, fertilisers, and feed directly into inflation prices. For developing economies, the consequences are harsher: weaker currencies, widening current account deficits, and shrinking fiscal space. In effect, geopolitical conflict in West Asia risks exporting inflation to the rest of the world. For India, these risks are particularly acute. India imports over 85% of its crude oil requirement, making it highly sensitive to price shocks. While diversification of suppliers and increased purchases from Russia have provided some insulation, India is very susceptible to price volatility. A USD 10-15 increase in crude prices can materially alter India's inflation outlook and complicate macroeconomic management. Yet oil is only part of India's vulnerability. Approximately 95% of India's trade by volume and around 70% by value moves

by sea. If maritime trade routes in and around West Asia become riskier or costlier, India's exports, from engineering goods and chemicals to textiles and electronics, will face immediate pressure. Higher freight costs could erode competitiveness, delivery delays will certainly impact contracts, and insurance premiums could eat into margins. For small and medium exporters, already operating on thin buffers, such shocks could be existential. There is also a strategic dimension. India's western ports are deeply integrated with trade routes passing through the Arabian Sea and the Gulf. Any instability in these waters could affect not just energy imports but also India's broader trade with Europe, Africa, and the Americas. In an era where 'friend-shoring' and resilient supply chains are becoming policy priorities, maritime insecurity undermines the very logic of dependable trade corridors.

## Middle East conflict: 109 from Karnataka stranded in UAE & Bahrain, says CM Siddaramaiah

Bengaluru, Mar 2: As the geopolitical conflict in the Middle East continues to escalate, chief minister Siddaramaiah confirmed on Monday, March 2, that 109 people from the state are currently stranded in the UAE and Bahrain. The disruptions follow the closure of airspace and widespread flight cancellations in the region.

According to the latest data, approximately 100 Kannadigas are stuck in the UAE, primarily in Dubai, while 9 others are stranded in Bahrain. The chief minister emphasized that the safety of every citizen abroad is the government's "highest priority" and that teams are in constant contact to verify details and extend necessary assistance.

Legislators and tourists among stranded include JD(S) MLC S.L. Bhojgowda, who is currently staying at a hotel in Dubai. Other stranded legislators



include MLAs Na Ra Bharath Reddy, S R Srinivas, and A C Srinivas. District-wise figures indicate that Ballari has the highest number of stranded individuals at 32, followed by Bengaluru with 25. Other affected residents hail from Davangere, Chikkamagaluru, Kodagu, and Udupi, among other districts. A group of 150 students from

Chikkaballapur, who were on vacation in Dubai, are also reportedly among those awaiting travel clearance. Government seeks central intervention

Chief minister Siddaramaiah stated that the Karnataka Chief Secretary has written to the Ministry of External Affairs and the Ministry of Civil Aviation seeking urgent intervention for

the safe repatriation of the stranded citizens. The state has also requested airlines to provide flexibility in ticket rescheduling and ensure adequate return flights once operations resume.

The State Emergency Operations Centre (SEOC) and all District Emergency Operations Centres (DEOCs) remain activated 24x7 to monitor the situation. A dedicated helpline has been operationalized to assist affected families.

The chief minister urged those stranded to remain calm and strictly follow advisories issued by local authorities and Indian embassies. He advised affected persons to register with the nearest embassy or consulate through official helpline numbers. Earlier, Siddaramaiah condemned the ongoing military strikes in the region, calling for peace and expressing hope that flight operations would be cleared soon to ensure everyone's safe return.

## Over 3,400 cancer cases detected in five years; Dakshina Kannada tops Karnataka list

Mangaluru, Mar 2: Dakshina Kannada (DK), Hassan and Kalaburagi have recorded the highest number of cancer detections in Karnataka over the last five years, accounting for a disproportionate share of diagnoses despite large-scale screening across the state and zero reports from several other districts, according to Lok Sabha data.

Between 2020-21 and 2024-25, Dakshina Kannada reported a total of 3,432 cases of oral, cervical and breast cancer. Kalaburagi followed closely with 3,397 cases, while Hassan recorded 2,436 cases during the same period. The data from Dakshina Kannada reveals a sharp year-on-year increase. In 2022-23, 18 cases were detected out of 16,41,913 people screened, which rose to 67 cases from 41,088 screenings in 2023-24. In 2024-25, the number of detections surged to 3,328 from 70,033 screenings. In Kalaburagi, 1,112 cases were detected in 2021-22 and 2,073 in 2022-



23, before declining sharply from 182 in 2023-24 to 30 in 2024-25. Hassan saw relatively low detections initially, which spiked to 2,224 in 2023-24, before dropping to 99 cases in 2024-25.

Other districts with notable cumulative detections over the five-year period include Belagavi with 849 cases, Kolar with 844, Tumakuru with 538, Haveri with 463, and Chikkamagaluru with 1,648 cases, most of which were concentrated in the first two years.

In 2024-25 alone, Dakshina Kannada recorded the highest number of

detections at 3,328 cases, followed by Kolar with 402 and Davanagere with 189. Bagalkot reported 168 cases, Tumakuru 117, and Hassan 99 cases. Between 2020-21 and 2024-25, a total of 13,91,301 people were screened in Bengaluru, with 292 cancer cases detected. Despite extensive screening in several districts, very low or zero detections have been reported. Yadgir and Chamaraanjag screened approximately 50,000 and 84,000 people respectively, but reported zero cases. Vijayapura and Kodagu reported two cases each, Mandya three cases, and

Udipi and Ballari four cases each.


Over the past five years, Karnataka has significantly expanded cancer screening under the National Programme for Prevention and Control of Non-Communicable Diseases. In many districts, over 10 lakh people are screened annually. Under the community health programme, ASHA workers conduct door-to-door awareness campaigns, encouraging at-risk individuals to visit health sub-centres or Ayushman Arogya Kendras for early screening. Suspected cases are referred to primary health centres. District-level NCD clinics and day-care cancer centres provide follow-up chemotherapy. The state currently supports 19 state cancer institutes and 20 tertiary care cancer centres, with approval granted for 16 new district cancer centres in 2025-26. However, officials note that there continues to be a shortage of specialist cancer doctors across the state.

## World Leaders Must Act Before Further Disaster: MP Basavaraj Bommai

### "CHINA AND RUSSIA ARE WATCHING CLOSELY"

Bengaluru: Former Chief Minister and MP Basavaraj Bommai appealed to global leaders to immediately intervene and stop the ongoing war between Israel and Iran before it leads to further catastrophe. Speaking to the media in Bengaluru on Monday, he expressed deep concern over the escalating conflict and said while Israel has launched attacks on Iran, Iran is retaliating, creating a highly alarming situation. Not only Israel but also the United States stands behind the current developments. The Middle East is a crucial region for the world's economic and cultural stability and has historically witnessed several wars. "Earlier, wars were fought over Jerusalem in the name of religion. Now conflicts are being driven by petroleum and religious issues. The United States is trying to assert control over oil resources and is not in a position to heed anyone's advice," he said.

Responding to a question about the possibility of a third



world war, the former CM said China and Russia have not yet entered the battlefield and appear to be observing the situation strategically. If they join the war, it could escalate to a much larger scale. Before such

a major disaster occurs, world leaders must act to stop the war.

When asked about Kannadigas reportedly stranded in the UAE, the MP said that under the leadership of Prime

Minister Narendra Modi, the central government has previously ensured the safe evacuation of Indians during various international crises. Necessary steps would be taken once the situation stabilizes.

Bommai pointed out that conflicts are affecting places like Dubai, Abu Dhabi, and Saudi Arabia, creating widespread concern as Indians reside in large numbers across these regions. The Government of India must coordinate with all embassies to ensure food and accommodation for affected citizens.

India, which has been dependent on oil imports, could face serious economic repercussions. A decade ago, people had to stand in queues for fuel. A similar situation could arise again.

Referring to incidents of violence in Pakistan and other nations, Bommai said that India has not witnessed such instability. There were incidents of firing in Pakistan. Such situations will not be allowed to occur in India.

## High Court Upholds 12 Crore BWSSB Demand, Dismisses Jain School's Plea

Bengaluru: In a major relief to the Bangalore Water Supply and Sewerage Board (BWSSB), the Karnataka High Court has dismissed a writ petition filed by Jain International Residential School, upholding a demand notice exceeding 12 crore towards pro-rata water charges.

The dispute dates back to 2004 when the school, located in Kanakapura Taluk, sought bulk water supply from BWSSB after its borewell water was found unfit for consumption. The government sanctioned 9 lakh litres per day, and the institution paid 93 lakh for pipeline installation. An agreement was executed on May 6, 2004.

In 2016, following a tariff revision, BWSSB issued notices demanding 4.32 crore as pro-rata charges and 8.64 crore as additional pro-rata charges, warning of disconnection in case of non-payment.

Challenging the notices, the school sought quashing of the 2016



demands and a refund of 1.01 crore allegedly collected as excess tariff prior to November 2014.

However, the High Court ruled that BWSSB has statutory authority under Section 16 of the BWSS Act to levy pro-rata charges, and that contractual agreements cannot override statutory provisions. The Court also clarified that there is no separate tariff category for educational institu-

tions, as water supply is classified only as 'Residential' or 'Non-residential/Commercial'.

Noting that the petitioner had described its premises as a "commercial complex," the Court dismissed the writ petition in full, while granting liberty to approach the appellate authority under Section 120 solely to contest any mathematical discrepancies in the calculation.

## Opposition Leader R. Ashok Slams Govt Over Debt, Alleges 'Unauthorized Team' Monitoring DCM

He further accused the CM of forming an "unauthorized" team led by an SP to monitor Deputy Chief Minister D. K.



Shivakumar, calling it an "invisible SIT."

Ashok also criticised the government's guarantee schemes and pending dues of 37,000 crore to contractors, alleging that the Congress manifesto promises remain unfulfilled. He defended the fiscal management of former CM Basavaraj Bommai post-COVID.

Referring to global developments, Ashok condemned processions allegedly held in support of Ali Khamenei and called for legal action against those taking the law into their hands. He praised Prime Minister Narendra Modi for efforts to bring back Kannadigas stranded abroad and urged state leaders to coordinate with the Centre to ensure their safety.

## 34 Leading Global Scientists Write to Minister N.S. Boseraju, Back Karnataka's Q-MINt Initiative

Bengaluru : Karnataka's technology vision has received significant global endorsement, with 34 eminent scientists from some of the world's most prestigious research institutions formally writing to Minister for Science and Technology N.S. Welcoming the global backing, Minister Boseraju said the support from 34 leading quantum researchers reaffirms Karnataka's direction in building a world-class innovation eco-





The publications cover themes ranging from the spiritual significance of Rameswaram and the philosophy of Sri Ramanuja to the Nadukal tradition, the ancient trade centre of Arikamedu, and Bhakti literature of the Nayanmars and Alwars. Architectural landmarks, including the Meenakshi

Amman Temple and the Brihadeesvara Temple, also feature in the series.

Addressing the gathering, the Vice-President said, "Bharat is a land of many languages, but its soul is one," asserting that India has remained culturally united through a shared Dharma despite its linguistic and religious diversity. He said the idea reflects the spirit of *Vasudhaiva Kutumbakam*.

He also released a book on Bankim Chandra Chatterjee in Tamil, English and Hindi, recalling that "Vande Mataram" carries "the fragrance of our soil and the spirit of our motherland." Praising Prime Minister

Narendra Modi for promoting Tamil globally, Radhakrishnan cited the establishment of a Tiruvalluvar Chair in Malaysia and the Kashi Tamil Sangamam as symbols of national integration.

## SINGAMPUNARI: THREE KILLED, 65 INJURED IN ARALIPPARAI MANJUVIRATTU



SIVAGANGA: Three persons, including a 23-year-old private company employee who had come to watch the event, were killed and over 65 were injured during the historic Aralippurai manjuvirattu held near Singampunari in Sivaganga district on Sunday.

The deceased were identified as Jammulal Lalji (55), an ice vendor from Rajasthan; Sundararajan (34), son of Manoharan from Adappan Vayal in Pudukkottai district; and Ramanathan (23), son of Nattarmangalam in Madurai district.

Police said Jammulal Lalji died at the spot after being gored by a bull. Sundararajan, who was running a food stall near the arena, sustained severe injuries and died on the way to the Singampunari Government Hospital. Ramanathan, who had completed his studies in Coimbatore and was employed in a private firm, was injured while watching the event and died on the way to a private hospital in Ponnamaravathi.

Their bodies were kept at the Singampunari Government Hospital for post-mortem. The manjuvirattu was

held with government permission as part of the Masi Magam festival at the Balasubramaniyar Temple in Aralippurai, which is associated with the *Kundrakudi Tiruvannamalai Adheenam*. The 10-day festival concluded with the bull event on Sunday.

Over 50,000 people gathered at Aralippurai and the surrounding areas to witness the event. Medical teams led by Block Medical Officer Nabishabanu, along with doctors from Singampunari and nearby government hospitals, were stationed at the venue.

Bulls that participated in the event underwent medical examination before release from the *vaadivaasal*. However, more than 65 people sustained injuries after being gored. Several of them were referred to government hospitals in Singampunari and Sivaganga for further treatment.

## Southern Railway announces Guruvayur-Chennai Egmore train service revisions



CHENNAI: Southern Railway has announced changes in the Guruvayur-Chennai Egmore Express service due to maintenance work.

According to a Daily Thanthi report, the train departing from Guruvayur at 11.15 am, from March 4 till end of month, to Chennai Egmore will now run via an alternate route through Madurai, Manamadurai, Karaikudi and Tiruchy, instead of its usual path. Train No 16128 will not travel via

Cholavandan, Kodaikanal Road or Dindigul on these dates. The revised service will include additional stops at Sivaganga and Pudukkottai. Other long-distance trains in the Madurai division, such as the special Hyderabad train on March 6, 13, 20 and 27, will also follow alternate routes via Madurai, Karaikudi and Tiruchy with additional stoppages at Aruppukottai, Sivaganga and Pudukkottai, part of the ongoing changes.

## SPECIAL TRAINS ANNOUNCED FOR POURNAMI GIRIVALAM AT TIRUVANNAMALAI

CHENNAI: The Southern Railway has announced the operation of special unreserved trains to manage the anticipated surge in passenger traffic during the forthcoming Pournami Girivalam festival at Tiruvannamalai.

According to a press release issued on Monday, one pair of special trains will be operated between Villupuram and Tiruvannamalai on March 3, (Tuesday). Train 06130, Villupuram - Tiruvannamalai unreserved special will depart Villupuram at 10:10 am and arrive at Tiruvannamalai at 11:45

am on the same day. In the return direction, Train 06129, Tiruvannamalai - Villupuram unreserved special will leave Tiruvannamalai at 12:40 pm and reach Villupuram at 14:15 pm.

En route, the trains will halt at Venkatesapuram, Mambalapattu, Ayandur, Tirukoilur, Adichchanur, Andampallam and Tandurai.

The special services will be operated with an 8-car MEMU (Mainline Electric Multiple Unit) rake. The trains are intended to facilitate devotees traveling to Tiruvannamalai for the Pournami Girivalam observance.

## Administrators of Tiruchy children's home held for ill-treating inmates

TIRUCHY: After complaints of ill treatment and verbal abuse of inmates in a private children's home in Tiruchy, the district Collector, who conducted an inquiry, ordered the police to register a case against the administrators and sent them to prison on Monday, while the inmates were shifted to various homes in the city. It is said that a government-aided children's home, Annai Ashram, has been functioning at Wireless Road near the airport in Tiruchy for several years, where the orphaned girl children and aged persons are being taken care of. The Ashram has been providing

vocational training to the inmates. Among the inmates, there are as many as 84 girl children residing in the home.

Against such a backdrop, the Tiruchy Collector V Saravanan recently received complaints against the administrators of the home for ill-treating the girls and making verbal abuses, and he ordered to form a committee comprised of the PA to Collector Athiyaman Kaviyarasu, Deputy Collector Farook, District Social Welfare Officer Vijayalakshmi and Child Welfare Committee official Sandhya to probe the issue. The committee,

which conducted an inquiry, confirmed that the children underwent torture at the home. The committee also recommended relocation of the children from the Annai Ashram to other homes nearby. Subsequently, they were shifted to other homes for a couple of days. Meanwhile, on Monday, the Collector stopped the government grant to the home and asked the Ponnalai All Women Police to register a case against the Ashram Superintendent Uma, Counsellor Fencia Roselin, Warden Tamilarasi and Cook Asha Banu. Based on the recommendation.

## Antibiotics and 6 other medications linked to disrupted gut microbiome

The study, published in the American Society for Microbiology's *Journal of Systems*, found that, in addition to antibiotics, antidepressants, beta-blockers, stomach acid reducers, and anti-anxiety drugs, these substances could continue to disrupt the microbiome long after use.

Babak Firoozi, MD, board certified gastroenterologist at MemorialCare Orange Coast Medical Center in Fountain Valley, CA, welcomed the study, but urged caution when interpreting the findings: "The methodology was robust, and convincingly linked changes in gut microbiome to medication uses, but this was not a controlled trial. There are far too many variables that cannot be accounted for, such as environmental factors, diet, geographic location. The most surprising finding is how many classes of drugs appeared to have influence on the gut biome."

The researchers utilized data from 2,509 adults in the Estonian microbiome cohort, a component of the Estonian biobank — a population-based databank of volunteers in Estonia. The volunteers, who were ages between 23 and 89 years, provided blood, cheek swab, and stool samples. The researchers then used shotgun metagenomics sequencing-Trusteed Source on the stool samples to analyze the make-up of their gut microbiomes. A subsample of the cohort — 328 people — provided a second stool sample after a median follow-up period of 4.4 years, which the researchers also analyzed.

They accessed details of participants' current and historical prescription drug usage from their electronic health records. At the time of the first sample, participants were using a total of 433 different prescription drugs, and in the five years preceding it, they had used 507 different medications. Just over one-third of the participants (857 people) were taking no medications at the time of the first sample, and those taking medications were using, on

average, three different types of medication. The researchers did not assess the effects of antibiotics at the first time point, so they excluded anyone who had taken antibiotics within 90 days of the first sample, but the second sample was assessed for the effects of antibiotics.

In total, the researchers analyzed the effects of 186 drugs. Of these, 167 affected the microbiome in some way, and 78 showed long-term effects on the composition of the microbiome.

Measurable changes in the microbiome were seen in people who had taken the following medications:

Antibiotics — medications that treat bacterial infections by killing bacteria or stopping them from multiplying  
Antidepressants — these increase neurotransmitters in the brain to relieve symptoms of depression  
Antipsychotics — medications that treat psychosis associated with some mental health conditions, such as schizophrenia and bipolar disorder  
Beta-blockers — medications used to treat cardiovascular symptoms, such as angina and high blood pressure  
Biguanides — metformin, used to treat type 2 diabetes  
Proton pump inhibitors (PPIs), which reduce stomach acid to treat acid reflux, heartburn, and stomach ulcers  
Benzodiazepines, which are prescribed for anxiety and sleep disorders. As well as antibiotics, beta-blockers, benzodiazepine derivatives, glucocorticoids, PPIs, biguanides, and antidepressants all had effects on the microbiome that were seen many years after previous drug intake. The researchers found that the longer people took medications for, and the more medications they took, the greater the effect on the microbiome. Multiple medications appeared to interact and have a greater impact on the microbiome, but for individual drugs, it was benzodiazepines that seemed to have the greatest negative impact. In their paper, the authors warned:

## Flavanol-rich foods may protect blood vessels from damage caused by prolonged sitting

Modern lifestyles mean that people spend an increasing amount of time sitting, whether working at a desk, watching TV, or travelling by car, train or plane. Prolonged sitting can adversely affect the function of the blood vessels. A new study has found that foods high in flavanols — antioxidants found in plant foods, such as cocoa, tea, and some fruits and vegetables — may improve vascular function during sitting or being sedentary. Sitting for long periods is linked to declines in vascular function, particularly in the legs, even in people who are physically fit. Recent research suggests that adults in the United States sit for at least 6 hours every day, and adolescents even more. Decline in vascular function can increase the risk of cardiovascular diseases. Trusted Source, such as strokes and heart attacks. However, many of us have sedentary jobs, spend a lot of time travelling by car, train, or plane, or enjoy watching TV or playing computer games, so we may spend much of the day sitting down. Now, researchers from the University of Birmingham, in the United Kingdom, have found that flavanols may help counteract the effects of prolonged sitting.

In their small-scale study, published in the *Journal of Physiology*, researchers found that young men who drank a high-flavanol cocoa drink before sitting for 2 hours maintained better blood flow in the femoral (leg) and brachial (arm) arteries than those who drank a low-flavanol version of the drink. "Even though the trial was small, its randomized, double-blind, placebo-controlled, crossover design gives it strong internal validity for detecting acute physiological changes. However, the external validity is narrow: all were young, healthy, male, and the experiment lasted only two hours. The outcome, flow-mediated dilation, is a well-validated marker of endothelial function but still a surrogate, not a clinical endpoint. Thus, the findings are mechanistically meaningful but not clinically definitive."

High vs. low flavanol cocoa  
Researchers recruited 40 healthy men, ages between 18 and 34, into the study. Half were high in fitness, and half were low, as measured by a cardiorespiratory fitness test conducted by the researchers. Before the experimental visits, participants fasted for 12 hours, and avoided caffeine, alcohol, polyphenol-containing foods and drinks, and any vigorous exercise for 24 hours. Upon arrival, they rested in a supine position for 15 minutes, after which researchers measured their blood pressure, resting heart rate, flow-mediated dilatation (FMD), a higher value indicating better



vascular function) in the superior femoral and brachial arteries, and tissue oxygenation in the gastrocnemius (calf) muscle. As soon as these tests were completed, participants sat still in a comfortable chair for 2 hours, with their legs parallel and both feet flat on the floor. They were allowed to make gentle arm movements, such as using a computer, writing, or texting. When they sat down, researchers gave them a randomly assigned high-flavanol cocoa or low-flavanol cocoa drink to consume within 10 minutes. The drinks, made using cocoa and 350ml spring water, were identical apart from their flavanol content, 695mg in the high-flavanol drink, and 5.6mg in the low-flavanol. During sitting, researchers recorded tissue oxygenation in the medial gastrocnemius, and after 2 hours, they repeated the other 4 tests done at the start. Researchers assessed FMD of the superior femoral and brachial arteries using ultrasound.

They found no differences in retrograde shear rate. Trusted Source (a measure of friction that can damage the lining of arteries) or blood flow between the groups. However, there were differences in FMD. In both arteries, FMD reduced during sitting in the low-flavanol group, and not in the high-flavanol group. After sitting, FMD remained higher in the high-flavanol than the low-flavanol group. Neither measure was influenced by the individual's fitness. "We have known for some time that flavanols have beneficial effects for blood flow from observational studies. It is surprising we can see such strong effects from one off dose on negative effects of sitting down."

—Eamon Laird, Assistant Lecturer in Human Nutrition at Atlantic Technological University Sligo and Adjunct Assistant Professor Trinity College Dublin, who was also not involved in the study. "Previous research already showed that prolonged sitting impairs endothelial function, and that cocoa flavanols acutely enhance FMD in other contexts. The novel contribution here is

showing that flavanols can preserve both upper- and lower-limb endothelial responsiveness during sitting and that cardiorespiratory fitness did not confer natural protection."

Why might flavanols have this effect?

Laird told *Medical News Today*: "Essentially, [flavanols] increase nitric oxide (NO) production that helps blood vessels relax and dilate, improving circulation. They can also reduce inflammation and have been associated with reduced oxidative stress. We are also unsure if the other dietary components that are often found with flavanols may also have an additive beneficial effect."

Yi explained further:

"Flavanols enhance endothelial nitric-oxide (NO) signaling by stimulating endothelial NO synthase (eNOS) activation, reducing oxidative stress and superoxide-mediated NO breakdown, and improving vascular smooth-muscle responsiveness to NO."

"By preserving NO bioavailability, flavanols maintain vasodilatory capacity and counteract the temporary endothelial 'stiffening' that occurs when leg blood flow and shear stress fall during sitting," he added. Together with exercise, flavanols may help vascular function. Experts agreed that although flavanols had a positive effect on vascular function, exercising or keeping active throughout the day is likely the most effective approach.

"Flavanol consumption may buffer the short-term vascular stress caused by sitting, but movement remains the most powerful tool for vascular health. [...] The most effective strategy is to take regular breaks from sitting by standing up or walking for a few minutes every 30 minutes, which helps restore blood flow and shear stress in your arteries. Even small movements, such as calf raises, fidgeting, or using a foot pedal under your desk, can keep circulation active and reduce the negative effects of prolonged immobility."

"In addition to movement, maintaining a consistent aerobic exercise routine strengthens overall endothelial health, while a diet rich in fruits, vegetables, tea, berries, and other polyphenol-containing foods provides further antioxidant and anti-inflammatory support. Managing blood pressure, cholesterol, and blood sugar remains essential for long-term vascular protection. Flavanol-rich foods and drinks should be viewed as helpful adjuncts — not replacements — for an active lifestyle."

Laird echoed this warning:

"These findings [...] are highly significant and could be an easy, enjoyable way to try and stave off effects of sitting down. However, it is not a magic bullet and we shouldn't take this study as evidence to eat chocolates everyday as they contain fat, sugar, and energy!"

# OIL AND GAS PRICES JUMP AS CONFLICT ESCALATES

Oil and gas prices have surged as Iran continues to launch strikes across the Middle East in response to ongoing attacks by the US and Israel. Natural gas prices spiked by nearly 50% on Monday after QatarEnergy, one of the world's biggest exporters, halted production following "military attacks" on its facilities. Brent crude, the global benchmark for oil prices, jumped by 10% to touch more than \$82 a barrel on Monday after at least three ships were attacked near the Strait of Hormuz at the weekend. Iran warned vessels not to pass through the crucial waterway in the south of the country, through which about 20% of the world's oil and gas is shipped. In the US, stock market indexes opened lower with the Dow Jones Industrial Average off nearly 1% while the Nasdaq index and S&P 500 also began trading in the red. In London, the FTSE 100 share index fell 1%, with the owner of British Airways among the biggest fallers following the disruption to Middle East airspace. Banks such as Barclays, Standard Chartered and HSBC also saw their share prices slide due to concerns that a sus-



tained rise in energy prices risks fueling inflation which, in turn, could lead to fewer interest rate cuts by central banks. Leading stock markets in Europe sustained bigger drops. In France, the CAC-40 fell by 1.8% while Germany's Dax extended earlier declines to fall by 2.1% in early afternoon trading. Meanwhile, the price of gold, which is viewed as a safe-haven asset during periods of uncertainty, added 2% to \$5,388 an ounce. QatarEnergy, which is owned by the state, said that it had suspended producing liquefied natural gas (LNG) after the country's Ministry

of Defence (MoD) said a drone launched from Iran targeted a facility in Ras Laffan Industrial City. Qatar's MoD also said a drone went after a water tank belonging to a power plant in Mesaieed, south of the capital Doha. Meanwhile in neighbouring Saudi Arabia, Aramco temporarily shut its major oil refinery at Ras Tanura on the coast after being hit by a drone. International shipping has almost come to a standstill at the entrance to the Strait of Hormuz, with analysts warning that a prolonged conflict could push energy prices even higher. The UK

Maritime Trade Operations Centre (UKMTO) said that two vessels had been struck, and an "unknown projectile" was reported to have "exploded in very close proximity" to a third. After its initial surge, Brent crude fell back to \$79 a barrel while US-traded oil was up by around 7.6% at \$72.20. "The market isn't panicking", Saul Kavonic, head of energy research at MST Marquee told the BBC. "There is more clarity that so far, oil transport and production infrastructure hasn't been a primary target by any side," he added. "The market will be watching for signs

that traffic through the Strait of Hormuz returns, which would see oil prices subside again." But some analysts have warned it could go over \$100 in the event of a prolonged conflict which could have a knock-on effect on inflation and interest rates. Robin Mills, chief executive at Dubai-based consultancy Qamar Energy and a former executive at oil giant Shell, said: "The jump in prices will feed through almost immediately because the oil traders are very much following the news too. "At the moment, oil prices are not particularly high, they are still below where they were even two years ago so we're not in full-blown oil crisis mode yet." On Sunday, the Opec+ group of oil producing nations agreed to increase their output by 206,000 barrels a day to help cushion any price rises, but some experts doubt this would help much. Edmund King, president of the AA, warned the disruption could drive up petrol prices around the world. "The turmoil and bombing across the Middle East will surely be a catalyst to disrupt oil distribution globally, which will inevitably lead to price hikes," he said.

# AVIATION, TRAVEL STOCKS TUMBLE AS MIDDLE EAST TENSIONS ESCALATES



**New Delhi:** Shares of airline companies, tour and travel-related service providers tumbled on Monday, March 2, amid escalating tensions in the Middle East. The stock of InterGlobe Aviation ended 6.25 per cent lower after falling 7.50 per cent during intraday trade on the BSE. Shares of SpiceJet also dropped 5.72 per cent and in intraday trade, it had declined 9.20 per cent. Shares of Yatra Online tumbled 9.59 per cent, Easy Trip Planners slumped 7.08 per cent, TBO TEK dived 4.04 per cent, Thomas Cook dropped 3.57 per cent, and Le Travenues Technology dipped 2.08 per cent. In the equity market, the 30-share BSE Sensex tanked 2,743.46

points or 3.37 per cent to 78,543.73 in early trade. It later ended at 80,238.85, down 1,048.34 points or 1.29 per cent. The 50-share NSE Nifty tumbled 575.15 points or 2.28 per cent to 24,603.50 in intraday trade. The benchmark later settled 312.95 points or 1.24 per cent down at 24,865.70. Brent crude, the global oil benchmark, jumped 7.75 per cent to USD 78.49 per barrel. The conflict between Israel, the US, and Iran has resulted in multiple airspace closures in the Middle East, massively disrupting flight operations. The Indian Association of Tour Operators (IATO) on Sunday, March 1, reported a noticeable rise in booking cancellations and reschedul-

ing requests, particularly for sectors connecting India with Europe via major Gulf hubs, due to airspace restrictions arising from the Middle East crisis. IATO President Ravi Gosain told PTI that travel agents across the country are working closely with airlines and overseas partners to minimise inconvenience to passengers by facilitating re-bookings, refunds, and alternate routings. "Aviation stocks also saw some profit-taking amid fears of escalated ATF prices," Vikram Kasat, Head - Advisory, PL Capital, said. The conflict between Israel, the US, and Iran has resulted in multiple airspace closures in the Middle East.

## India and Canada agree series of deals as Carney and Modi reset ties in Delhi

After nearly three years of diplomatic tensions, India and Canada have taken a major step towards restoring their relationship as leaders from both countries unveiled a wide-ranging set of measures aimed at deepening economic cooperation. Among the agreements is a long-term uranium supply deal, which experts say will bolster India's energy security as it comes under pressure from the US. Plans for an expanded economic partnership could also boost trade and investment between the two nations. Cooperation in areas such as critical minerals, clean energy, space and higher education promises new opportunities for innovation and joint development. Analysts describe the announcements as a potential "reset" in India-Canada relations, signalling a willingness on both sides to move past recent strains and focus on shared strategic and economic priorities. After concluding his engagements in India, Carney is scheduled to continue his Indo-Pacific tour with stops in Australia and Japan, according to the official itinerary released by



his government. His visit to India, which included a meeting with PM Modi in Delhi on Monday, was the first leg of a broader diplomatic push aimed at diversifying Canada's trade and strategic partnerships beyond North America. From India, Carney is scheduled to fly to Sydney where he will arrive on Tuesday. He will then travel to Canberra on 5 March, where he is due to hold bilateral talks with Prime Minister Anthony Albanese, with discussions expected to focus on trade expansion, defence cooperation and emerging technology partnerships. "He will deliver an address to both houses of Australia's Parliament and invited dignitaries - marking the first such

address by a Canadian prime minister in nearly 20 years," read a statement, external by the Canadian government. Carney's final stop on this tour is Tokyo where he is due to arrive on 6 March. He is expected to meet Prime Minister Sanae Takaichi to advance cooperation in areas, including clean energy, critical minerals, advanced manufacturing and food security. As we wind up our coverage of an eventful day, here is a look back in photos at Carney's time in India. As we've been reporting, in a significant reset of relations, India and Canada today unveiled a sweeping package of measures aimed at restoring and deepening economic and strategic cooperation.

Here's a quick recap: PM Modi and PM Carney agreed to fast-track negotiations towards a Comprehensive Economic Partnership Agreement (CEPA), with the aim to conclude talks by the end of the year. They also set an ambitious target of boosting bilateral trade to around \$50bn by 2030. In a major announcement, Canadian company Cameco has signed a long-term deal to supply uranium to India. The leaders also outlined new frameworks for cooperation on critical minerals, clean energy and AI. With a large number of Indian students studying in Canada, education featured prominently in the talks. Both governments announced plans to expand academic partnerships, ease exchanges for students and researchers and strengthen mutual recognition of qualifications. The two countries will also relaunch a structured defence dialogue and step up maritime and broader security cooperation, underlining a strategic convergence which, analysts point out, extends well beyond trade.

## Limited flights leave UAE but disruption continues amid Iran strikes

A limited number of flights have been able to leave the United Arab Emirates as departures across the Middle East continue to be disrupted by the joint Israeli and US war on Iran. More than 4,000 flights a day have been cancelled across the region, according to flight tracking service Flightradar24 with hundreds of thousands of passengers affected. The disruption "will only increase the longer the crisis continues" and it "will have enormous repercussions for the industry," director of communications Ian Petchenik said. The ongoing airline disruption comes as more than 100,000 Britons have registered their presence in the Middle East with the UK government. On Monday morning, 79% of global flights to Qatar and 71% of flights to the United Arab Emirates had been cancelled, according to aviation analytics firm Cirium, while 81% of flights to Israel and 92% of flights to Bahrain have also been grounded. United Arab Emirates national carrier



Ethihad Airways had suspended services until 14:00 local time (10:00 GMT) but departures after that included an Etihad flight to London Heathrow (EY67), which is due to land in the UK in the early evening. Other Etihad flights have left for destinations including Moscow, Paris, Cairo, Delhi and Karachi, according to the flight-tracking service Flightradar 24. The airline told Reuters, "Some repositioning, cargo and repatriation flights may operate in coordination with UAE authorities and subject to strict operational and safety approvals". All regular scheduled services remain cancelled. Dubai Airports has announced on

social media that a "limited resumption of operations" will begin on Monday evening, with a small number of flights allowed to operate from the region's two main hubs - Dubai International and Dubai World Central. The Dubai-based airline Emirates says it will accommodate customers with earlier bookings on these flights as a priority, and will contact passengers directly. No flights are so far taking off or landing from Doha, as Qatari airspace remains closed. Earlier in the day, Qatar's national airline Qatar Airways said its flight operations remain temporarily suspended on Monday due to the closure of Qatari air-

space. "Qatar Airways will resume operations once the Qatar Civil Aviation Authority announces the safe reopening of Qatari airspace," the airline wrote on X. Ian Scott, from Wedmore in Somerset, told BBC Your Voice he had been travelling back from Melbourne to Venice when his Saturday morning flight out of Doha was forced to turn back mid-air due to the conflict. "We were in airport for 15 hours before evacuation to a hotel. That was full and we had to shelter underground due to close explosions," he said. Since then, Scott said he could hear blasts in the area, and is still waiting for an opportunity to leave. Foreign Secretary Yvette Cooper told the BBC the situation was "deeply stressful" for those affected. She said many of those stuck were people travelling for holiday or business. Asked if the government was considering launching an evacuation, she said it was in close contact with airlines, airports, Middle Eastern governments and the travel industry.

## How Aston Martin must adapt to meet changing needs

It is the firm famed for making the car James Bond drives, but its history has been almost as turbulent as some of the adventures of the Ian Fleming hero. Aston Martin confirmed this week it would be cutting a fifth of its workforce, after the firm's net losses jumped by more than 50% last year. Bosses at the luxury car firm blamed its woes on US president Donald Trump's tariffs in a statement made last month. Experts believe Aston Martin, which is headquartered in Gaydon, Warwickshire, was particularly susceptible to those headwinds but believed there were opportunities for its fortunes to be revived once again. The firm is a significant part of the West Midlands' manufacturing prowess, and employs about 3,000 people. This means job losses could total about 600. Its troubles come at a time when the car industry is facing one of the most difficult periods in its history, according to former Aston Martin




CEO Andy Palmer. He said car makers were having to adapt to manufacturing electric vehicles and plug-in hybrids, as well as changes in consumer behaviour. He added that China was the largest automotive market in the world and that vehicles produced there were now competing within the luxury market traditionally occupied by the likes of McLaren and Aston Martin. "There are competitors, there are emerging competitors, and they're hitting in places like China where historically most of those vehicle manufacturers have been taking their profits from. "Whilst the Chinese

manufacturers may not be a direct challenge in the luxury market, they're undoubtedly skewing expectations." Palmer also agreed that volatility created by tariffs on imports to the USA was also having an impact on firms like Aston Martin. "Tariffs are ultimately paid for by the consumer, and both manufacturers and consumers are waiting." He explained that firms could consider manufacturing their vehicles in the USA to avoid tariffs, but this was only likely to only be an option for larger manufacturers. Despite that, the firm's brand recognition remains a large part of its appeal.

Economists reckon that broadly, a sustained rise in oil prices of about 5% adds about 0.1% to inflation in major economies - so the current increase in crude costs would point to a rise of about

0.2% to inflation. But then there's gas futures to consider. They are now up more than 40% which, if sustained, may mean a considerable bump to energy bills (albeit not until the summer). Even so, we're a long way off the peak movements we saw during the war in Ukraine. As it stands, barring a more extensive surge in energy costs, the impact on inflation could be unhelpful - but not disas-

trous. However, these are early days, and much could change. Previously, Iranian media had said that Khamenei's daughter, grandchild and son-in-law have been killed. Khamenei and his wife had six children, four sons and two daughters. Earlier, we visited a school in Beirut that, since the very early hours of the morning, has turned into a shelter for the large number of displaced people who fled their houses for fear of being killed by the Israeli military campaign. We saw people in their pyjamas; others coming with a small bag containing all they could grab as they left their houses in a rush. A few had also brought their pets along. "I wouldn't leave them [the pets] behind. They are souls," a woman who left her house in southern Beirut alongside her three children told me. As we were there, news came of a new Israeli strike.

## UK will allow US to use bases to strike Iranian missile sites, PM says



The UK has agreed to a US request to use British military bases for "defensive" strikes on Iranian missile sites, Sir Keir Starmer has said. But the prime minister said the UK had learned lessons from the "mistakes of Iraq", and was not involved in the initial strikes on Iran and "will not join offensive action now". The BBC understands the US is likely to use RAF Fairford in Gloucestershire and Diego Garcia in the Indian Ocean for strikes on Iranian missile sites. The PM made the announcement, which the Telegraph reported US President Donald Trump said "took far too long", just hours before a British RAF base in Cyprus was hit by a drone strike on Sunday night with no casualties reported. Investigations are under way to establish where it was fired from. The attack at RAF Akrotiri in Cyprus took place at around midnight local time (22:00 GMT) with the MoD later saying that "minimal damage" was caused. In a video

statement released earlier on Sunday, Sir Keir said the basis of the decision to accept the US request was the "collective self-defence" of allies and protecting British lives, accusing Iran of pursuing a "scorched-earth strategy". The prime minister added the US would use UK bases for the "specific and limited defensive purpose" of destroying Iran's missiles "at source". He added that the move was in accordance with international law, and the UK government had published what it said was a summary of its legal advice. Trump, in an interview with the Telegraph.

## MORE THAN 100,000 BRITONS REGISTER FOR HELP IN MIDDLE EAST



A total of 102,000 Britons have registered their presence in the Middle East with the UK government, as Iranian strikes continue across the region. Foreign Secretary Yvette Cooper told the BBC there were an estimated 300,000 British citizens in Gulf countries, where much of the airspace is closed. She said many of those trapped were holiday-makers, passengers transiting through or people on business visits. Foreign Office sources said no evacuation was imminent but the government was preparing for potential scenarios if commercial flights remained grounded. British nationals in Bahrain, Israel, Kuwait, Palestine, Qatar and United Arab Emirates have been urged to register their presence to receive updates from the Foreign Office. The government has previously used registration schemes to provide urgent updates to people affected by international crises but the number of people and countries affected in this case is unprecedented. Cooper told BBC Breakfast the situation was "deeply stressful" for those affected. She urged people to follow local advice, which in most countries was to shelter in place. Asked if

the government was planning to launch an evacuation, Cooper said: "We are in close contact, for example, with the travel industry, with airline companies and airports and also with the governments in the region." She added: "But we will need to provide updates for people as we go along... That's why we're encouraging people to register their presence so we know where they are so we can get information to them swiftly." Cooper said that in previous similar situations the government had wanted to work with airline companies so people could fly home in the normal way. Layla Hamood and Matthew McGinn, who are on their honeymoon with their three-year-old son, are among those stuck in Dubai. The family have not left their hotel since the attacks started. "It's been terrifying to be honest," Layla told BBC Breakfast. "The bombing hasn't stopped. We can hear the missiles." She added: "No one knows what to do. We're in a limbo, we don't know how we can get home." Nearly half of the flights scheduled to depart from London Heathrow to the region on Sunday were cancelled, according to analytics company Cirium.

## KIDNAPPING OF FOREIGNERS SOARS IN AFRICA'S LAWLESS SAHEL REGION



When Marin Petrovic arrived in Bamako in early September last year, he was elated. The Bosnian national had spent years applying for tourist visas to Mali, only to be repeatedly denied on security grounds. The West African country has long been afflicted by civil war, foreign military interventions, and Islamist insurgencies. "Now it was finally approved and I couldn't wait to start this trip," he wrote in Bosnian in

a public Instagram post on 15 November 2025. Petrovic declined to speak to the BBC for this article. The plan was to visit some of the country's dramatic landmarks, before returning home. In Bamako, Petrovic enjoyed the sights and sounds of markets, busy roads, schools, and even sampled some local beers, according to the post. "The next day I set off for Mopti, known for its 100-year-old mud mosque," he continued, referring to the Grand Mosque of Mopti, a 15m (49ft) tall architectural feat made from mud bricks. On Instagram, Petrovic describes himself as a "mountain rescue" expert and "guide", whose motto is not to "dream your life", but to "live your dream".

## ALLIES OF US IN THE GULF BEAR BRUNT OF IRAN ATTACKS

In the clear blue skies above Abu Dhabi, white contrails streak high above the sand-coloured villas and well-watered gardens. These are no incoming Dreamliners or Airbuses bringing in the next manifest of tourists and guest workers. They are incoming ballistic missiles, launched by the Emirates' giant neighbour just across the Gulf. Iran. As of Sunday afternoon, the United Arab Emirates (UAE) defence ministry said it had so far "dealt with" 165 incoming ballistic missiles, two cruise missiles and 541 Iranian drones. In Bahrain, a friend alerted me on Sunday morning that the airport was under attack after having a sleepless night. "Woken by huge bangs and wailing siren," he texted. "I think



maybe around 20 booms and bangs. At least two hits". These are not familiar scenes in this region, but since this conflict began on Saturday morning, Iran appears to have expanded its target set from just hitting military targets, like the US Navy's 5th Fleet headquarters in Bahrain, to airports and other civilian sites. Now luxury hotels and

shopping malls, high-rise apartment blocks, state-of-the-art airport departure terminals are getting sporadically hit as gaps appear in the Arab states' air defences in the Gulf. These places were never built with the prospect in mind that they would one day come under attack from drones and ballistic missiles. Iran's Foreign Minister, Abbas

Aragchi, has denied targeting his country's neighbours, telling Al Jazeera: "We are not attacking our neighbours in the Persian Gulf countries, we are targeting the presence of the US in these countries. Neighbours should direct their grievances to the decision-makers of this war". Some of the damage to civilian infrastructure in the Gulf states is accidental - resulting from debris falling from intercepted missiles. But not all. The number of attacks on airports in Bahrain and the UAE point to more than coincidence. Iran always made it clear in advance that, if it was attacked, it would retaliate at any country it considered to be complicit in that attack.

## ISRAEL STRIKES LEBANON AFTER HEZBOLLAH ROCKET FIRE AS IRAN CONFLICT WIDENS

Israel's military has said it has struck Hezbollah targets in Lebanon, after the Iranian-backed Shia group said it launched rockets and drones at the Israeli city of Haifa to avenge the killing of Iran's Supreme Leader Ayatollah Ali Khamenei. Lebanon's health ministry said 31 people were killed by Israeli strikes in Beirut's southern suburbs, where Hezbollah has a strong presence, and the country's south. There were no reports of casualties in Israel from Hezbollah's fire, which the group said was retaliation for Khamenei's "pure blood" and Israeli strikes in Lebanon since a cease-



fire ended a war between them 15 months ago. The Israeli defence minister vowed Hezbollah would pay a "heavy price". On Monday, Israel Katz said he had ordered the Israeli military to "act forcefully" against the group and that its leader Naim Qassem

was now a "marked target for assassination". Lebanese President Joseph Aoun denounced the Israeli strikes while also warning against turning Lebanon into a battleground for conflicts "that do not concern us". Later, Prime Minister Nawaf

Salam announced that his government was immediately banning Hezbollah's military activities in Lebanon in response to the rocket fire. It had been widely expected that Hezbollah, which has close financial and ideological ties to Iran, would join the conflict between Iran, Israel and the US. The conflict has spread quickly across the Middle East since the joint US-Israeli attack on Iran's leadership and armed forces on Saturday, with Iran responding by launching missiles and drones towards Israel and Gulf Arab states hosting US military bases.

## Michael B Jordan upends Oscars race as Sinners wins big at Actor Awards



US actor Michael B Jordan has scored a surprise win at the Actor Awards, formerly known as the Screen Actors Guild Awards, giving him a surge of momentum in the final weeks before the Oscars. He was named best actor for his role in vampire horror film Sinners, which also scored the top prize of the night - best ensemble cast. "I don't even know where to begin, I wasn't expecting this at all," Jordan said in his speech, adding that he felt "so honoured and privileged" to have been nominated. Accepting the best ensemble prize, his co-star Delroy Lindo said making Sinners had been an "incredible journey", adding: "Every single day we brought ourselves, our hearts, our souls, to this endeavour." Lindo said: "To be recognised by you all, 'thank you' does not come anywhere near to encompassing what we feel, the gratitude." The awards for Sinners came a week after the Bafta Film Awards, where Jordan and Lindo were praised for their composure after Tourette's campaigner John Davidson involuntarily shouted a racial slur while the pair were on

stage. Other winners at the Actor Awards included Sean Penn (One Battle After Another) and Jessie Buckley (Hamnet), as well as a surprise supporting actress victory for Amy Madigan (Weapons) and a posthumous win for Catherine O'Hara (The Studio). In his acceptance speech, Jordan paid tribute to his mother Donna, who he has been bringing to events as his guest throughout awards season, for supporting his acting career from a young age. "Mom, thank you for driving me back and forth to New York when we didn't have enough money to go through the Harlem tunnel, when we were looking for gas money, parking spaces," he said. Jordan also thanked Sinners director Ryan Coogler and his co-stars, commenting: "Everybody that had something to do with this movie, you gave us your time and your talents and vulnerability and allowed me to do my best work." Voting for this year's Actor Awards ceremony closed on Friday, five days after the Baftas ceremony, where the N-word was shouted while Lindo and Jordan were on stage.

## Could Kim's teen daughter become North Korea's next leader?

As North Korean leader Kim Jong Un threatened Seoul and vowed to continue expanding his sanctioned nuclear weapons programme at the party congress, the big question was whether his 13-year-old daughter would be anointed as his heir. That news, or any unquestionable indication of it, didn't materialise this week. But it has launched a debate about the young Kim Ju Ae's viability as the next leader for the country of 25 million - a dictatorship which has only ever been ruled by a member of the Kim family. The party congress, a key meeting of North Korean leaders and officials that takes place every five years, is usually watched closely for Kim's message to Seoul and Washington. But this time the focus shifted. Last week

Seoul's spy agency briefed lawmakers that it believes Kim has selected his daughter as his heir, and that she was seen giving her opinion on policy matters. Although she is becoming more visible alongside her father on state media, much about her remains a mystery. North Korea has never published her name or age. Her existence was first publicised when basketball star Dennis Rodman told The Guardian her name after his visit to Pyongyang in 2013. She is widely believed to be 13 years old partly based on estimates by intelligence reports. Seoul's spy agency had earlier said she has an older brother, but they have since distanced themselves from the assessment. "It was an intelligence failure," says Cheong Seong-chang, a North Korea watcher and



vice-president at Sejong Institute who was an early proponent of the theory that Ju Ae will become the heir. Cheong and other analysts now believe that Ju Ae is the oldest child and has a nine-year-old sister. She first appeared in public in a state TV report in 2022, holding her father's hand while inspecting North Korea's latest missile. Cheong says her TV appearances - where she is placed in the centre of the

frame and the state media's description of her as "the respected child" - are the clearest sign that she has become the official heir. "The state media is using words reserved for the supreme leader. It underlines her own cult of personality." Her proximity to the country's military is another sign, Cheong adds. She inspected troops and weapons alongside her father. Several times, the top

generals were seen kneeling beside her to whisper in her ear as she sat with her father watching military parades. Kim Jong Un's power rests in his control of the military, Cheong explains. If Ju Ae were to succeed him, she would need to appear as a credible military commander. When inspecting troops with her father, she dons the same long black leather coat and dark sunglasses that he wears. When Kim Jong Un inherited power, it happened rather suddenly. He only appeared publicly a year before his father's passing. Cheong believes Kim is trying to avoid such a rapid transition by introducing Ju Ae early to the regime and the public. There is no evidence that Kim Jong Un is suffering from ill health, aside from references to his weight, smoking and drink-

ing habits. But Kim might be trying to appoint his heir early to avoid a succession crisis, according to Cheong. However, former North Korean official Ryu Hyun-woo sees little possibility of a woman ruling over the country. Ryu, who served as a diplomat before defecting in 2019, says the North Korean legal code, created by the Kim family, requires the country to be run by a person of the Paektu bloodline - in other words, a direct descendant of the country's founder Kim Il Sung. Although Ju Ae is of the bloodline, North Korea's patriarchal system would not see her as being of the bloodline, Ryu says. Women at every level struggle to be treated equally in North Korea. Female officials are rare and female military commanders are even rarer.

## "WHAT SORT OF CALL IS THAT?"

### Australia Great Unhappy With Umpiring In India vs West Indies T20 World Cup 2026 Virtual Quarter-Final

Australia great Matthew Hayden was not too pleased with the umpiring in the India vs West Indies T20 World Cup 2026 Super 8 Group 1 match. On the fourth ball of the 19th over bowled by Arshdeep Singh, Hayden called out on-field umpire Alex Wharf. Arshdeep delivered one outside off-stump, but the umpire initially did not signal it a wide - much to Hayden's dismay in the commentary box. "That has to be a wide. What sort of call is that? Has to be some action there," Hayden said. Replays confirmed the umpire had erred. Talking about the match, Sanju Samson led India's recovery with captain Suryakumar Yadav in support as India reached 98/2 at the halfway mark of their chase of 196 in a must-win encounter. India need another 98 runs from 60 balls to make the semifinals. Samson smashed



three sixes and six fours to bring up a 26-ball fifty and was unbeaten on 54, while Suryakumar was on 18 not out. The duo added 57 runs for the unbroken third wicket. Suryakumar also survived a chance when

Gudakesh Motie failed to hold on to a tough return catch in the 10th over. Having lost two key wickets inside the powerplay, India were 53/2 after six overs, but Samson and Suryakumar stabilised the

innings, maintaining the run rate around 10 per over. West Indies executed a clear attacking blueprint in their virtual quarter-final, riding on Roston Chase's foundation before launching a late assault to

post an imposing 195/4. Chase, making full use of two reprieves, struck a fluent 40 off 25 balls while adding 68 runs for the opening wicket with Shai Hope (32 off 33). The pair provided solid early momentum with a measured yet proactive approach. India clawed back briefly when Jasprit Bumrah delivered a double strike in the 12th over to halt the charge, but the respite did not last long. Rovman Powell (34 not out off 19; 3x4, 2x6) and Jason Holder (37 not out off 22; 2x4, 3x6) launched a ferocious counter-attack, stitching together an unbeaten 76-run partnership for the fifth wicket off just 35 balls to provide the perfect finishing flourish. India bowled Bumrah in short bursts and held him back for the death overs despite his impact in the middle phase. The strategy, however, misfired,

### Mitchell Starc Emotional As Alyssa Healy Slams Ton In Final ODI For Australia

In the annals of Australian cricket, Alyssa Healy is a name that will be etched permanently. Healy bid an emotional farewell to white-ball international cricket with a breathtaking 158-run knock in the third and final match at Bellerive Oval in Hobart on Sunday. The 35-year-old wicketkeeper-batter had earlier confirmed that the bilateral series against India would mark the conclusion of her 16-year international career. Australia, asked to bat first in the final ODI, were chasing a clean sweep against the touring Indian side. Healy was greeted with a guard of honour as she walked to the crease. She wasted no time asserting her dominance, striking 27 fours and two sixes in a quickfire 98-ball knock that helped Australia reach an imposing 409/7. Her teammate Beth Mooney also contributed an unbeaten 106 off 84 balls, ensuring the hosts



crossed the 400-run mark. Alyssa Healy's husband and Australia skipper Mitchell Starc was present in the stands when she reached the milestone. He was visibly emotional after Healy's feat. Healy, who debuted for Australia at 19 in February 2010, finishes her ODI career with over 3,500 runs. In T20 internationals, she amassed 3,054 runs at an average of 25.45, including a career-best 148 not out - the highest

individual T20I score among Full Member nations. She holds the record for the most T20I dismissals (as wicketkeeper) globally and ranks second in appearances for Australia in the format. Her glittering career includes six T20 World Cup triumphs (2010, 2012, 2014, 2018, 2020, 2023) and two ODI World Cup titles (2013, 2022). Healy was also recognised as the ICC T20I Cricketer of the Year in both 2018 and 2019.

India wicket-keeper batter Sanju Samson's journey up to the match-winning 97 against West Indies has been nothing short of a rollercoaster. Despite being India's first-choice T20I opener for more than a year, Samson found himself out of India's playing XI at the start of the tournament after Ishan Kishan's impressive form. However, now Samson has grabbed his second chance with both hands. Following his incredible knock against West Indies, a pep talk given to him by former India captain Rohit Sharma went viral on social media. Rohit had been present at the Wankhede Stadium in Mumbai ahead of India's opening game of the tourna-



ment against the United States of America (USA). However, Samson did not feature in India's playing XI. This was when Rohit walked up to Samson to offer him support. "Kaisa hai? Dukhi mat ho bhai. It is a long tournament, kabhi bhi mauka aa sakta hai ("How are you? Don't be dis-

heartened. It is a long tournament. The opportunity can come at any moment," Rohit had said to Samson, as revealed in a video posted by the official Instagram account of the International Cricket Council (ICC). Rohit's words have turned out to be true. Samson was able to make a return to the

team following India's defeat to South Africa. While he played a fiery cameo in India's win over Zimbabwe, he then smashed an innings against the West Indies that will go down in Indian cricket folklore. Samson also paid tribute to Rohit and Virat Kohli after the match. "Playing IPL for around 10 to 12 years and being with the Indian team for the last 10 years... I have not always been playing, but I was looking from the dugout, learning from greats like Virat Kohli and Rohit Sharma. It was very important to observe, learn, and see what they were doing," Samson said after master-minding India's highest-successful run chase in T20 World Cup history.

Arvid Lindblad is Formula 1's newest sensation. At just 18, he is set to drive for Racing Bulls, the sister team of multiple-time F1 world champions Red Bull Racing. Lindblad made a special visit to India just a week before his long-awaited F1 debut, for the Red Bull Moto Jam event, and spoke candidly on his Indian heritage and on the potential return of the Indian Grand Prix. He also shared his thoughts on tackling the 2026 regulations, handling pressure, going shoulder-to-shoulder with the likes of Max

driving to what I've got." "You could argue it's easier because it's slower, but I think it's much more complicated now. Because there's a lot more new elements, a lot more things you have to be aware of whilst driving." Handling pressure as a rookie Lindblad enters the F1 2026 season as the only rookie on the grid. The 18-year-old never doubted his capability to be among motorsport's very best. Arvid Lindblad: "To be honest, from when I started this journey when I was five, I always believed I could be in Formula One, and that was always what I was working towards. That was always what it was gonna be, that was always what I was working towards."

### SIX NATIONS TROPHY TO BE REPLACED AFTER FIRE DAMAGE



The Six Nations trophy is to be "retired from ceremonial use" and replaced after being damaged by fire in an accident during transit. The trophy was damaged after round three of the tournament, when the vehicle carrying it was involved in an incident, according to a statement, external on the Six Nations website. No passengers were injured but the trophy sustained "fire damage" in the aftermath and the manufacturers decided it cannot be restored to its former state. An "identical exhibition trophy" will be used for the remainder of the championship, with a new one being commissioned in time for the 2027 Six Nations. "Whilst in transit during round three of the Guinness Men's Six Nations, an incident occurred involving the vehicle carrying the championship trophy," the statement reads. "Thankfully no passengers were injured, however the trophy sus-

tained fire damage and following an assessment by the official trophy manufacturer, unfortunately it cannot be restored to its full presentation standard. "In keeping with these presentation standards, respect for the significance of winning the Six Nations - one of sport's most prestigious titles - and to preserve the integrity of the trophy and its heritage, it will be retired from ceremonial use." The trophy, which is 75cm tall and made of silver, was created in 2015 to reflect the tournament's evolution to six teams after Italy joined the fold in 2000. Current holders France are favourites to retain their crown after winning the opening three games of this year's tournament. "Whilst this accident is hugely unfortunate, the situation adds another chapter to the history of a trophy that represents one of global sport's most celebrated tournaments, with its roots reaching back to 1883.

### ENGLAND 'GIVEN REASSURANCES' OVER SAFETY IN TURKEY

Manager Sarina Wiegman says England have been given reassurances there are no safety concerns about their Women's World Cup qualifier against Ukraine being held in Turkey as the conflict in the Middle East widens. The Lionesses play in Antalya at 17:00 GMT on Tuesday because Ukraine are unable to play in their home country as a result of the war with Russia, which is in its fifth year. On Saturday the US attacked Iran as part of a joint operation with Israel, sparking retaliatory strikes across the Middle East. The Iranian regime has responded with attacks on US assets and countries in the region with a US military presence, including Bahrain, Qatar, the United Arab Emirates, Kuwait and Iraq. Turkey borders Iran and Iraq and is close to Cyprus, where an Iranian drone crashed into a British RAF base on Sunday. Israel and Hezbollah in Lebanon have also exchanged strikes. "Yes, we did have reassurances. We are in close contact with the government and the people here that are responsible," said Wiegman. "We're fine here but we're keeping an eye on it. We're in contact all the time with the responsible



authorities. "Of course, you're concerned about what's happening in the world. When we think, or our government thinks it's unsafe, we will go back. At this moment, we don't have signals of that." England travelled to Turkey last Wednesday for a training camp but it is unclear how many fans will attend the match following the weekend's developments, with some supporters and several media outlets already choosing to withdraw. Wiegman says the fact

Ukraine are having to host the match in Turkey because of conflict in their home country following Russia's invasion is "really sad". "We have great facilities here and the climate is really good so we can prepare really well. But the reason we're here is not nice," she added. "You want Ukraine to be able to play in their home country. They had to travel a lot themselves to get here. The things they have in front of them in their country is really horrible. "We hope this game unites a bit. It's a chance for Ukraine to show themselves to the world in another way where hopefully football unites and brings some joy." England are in a group with Ukraine, Iceland and Spain, with only the top team qualifying automatically for the 2027 Women's World Cup in Brazil. Midfielder Georgia Stanway hopes England can get off to a winning start this week when they face Ukraine, before hosting Iceland at the City Ground on Saturday. "Our main task is to qualify as fast as possible but we also understand the process behind it and what it takes to get to a Euros and a World Cup," said Stanway. "We know it's super difficult.

### WHAT CAN PLAYERS AND CLUBS DO ABOUT 'AI SLOP'?



You do not have to look far on social media to find images and videos of footballers in unlikely or bizarre situations. Scroll through TikTok and you may soon stumble across Lionel Messi and Cristiano Ronaldo cutting each other's hair, or boarding the Titanic in Edwardian dress. You might even see Kylian Mbappe on a ski-lift with a turtle. This is the result of the exponential growth of artificial intelligence (AI). Or, more precisely, AI 'slop'. AI can be asked to deliver pretty much anything. By anyone. The tools are becoming ever more sophisticated and easily accessible. It will become even harder to spot what is real and what is, in AI terms, deepfake. It may seem, for the most part, like harmless fun. After all, who really thinks Messi and Ronaldo have been serving burgers? But is there a point at which players and clubs will try to draw the line? Options are limited for players to take action as football has become a commercial juggernaut, players and clubs have had to learn how to look after their brands. That could be by protecting

the club crest or challenging the use of a player's name in unauthorised promotional material. Take Chelsea midfielder Cole Palmer, who has trademarked the term 'Cold Palmer' with the UK government's Intellectual Property Office. The 23-year-old did the same with his name, autograph and signature 'shivering' celebration. Creating protections is one thing. Being able to tackle this new AI world of relentless content is another. In the UK there is limited legislation covering someone's likeness. Or, as it is called in football, image rights. Jonty Cowan, legal director at law firm Wiggin LLP, told BBC Sport that AI was presenting "lots of novel challenges". "Various governments around the world are trying to figure out... how do we react to AI?" said Cowan. AI is being used to put players into real-life scenarios, as well as those more obviously fake. Take the unveilings of Antoine Semenyo and Marc Guehi by Manchester City in January. The club's official photographs show each player with director of football Hugo Viana.
