Kempegowda-centric works added to civic budgets; corporations asked to rework plans



Bengaluru (TSIT): Weeks after Bengaluru's five corporations presented budgets with a combined outlay of Rs 20,218 crore, the state government has directed them to accommodate a series of additional projects centered on Nadaprabhu Kempegowda.

While approving the budgets as part of the routine process, the Urban Development Department (UDD) — which reports to Deputy Chief Minister DK Shivakumar, who also holds the Bengaluru Development portfolio — proposed a set of new works linked to the 16th-century founder of Bengaluru. Among the key proposals is the development of neglected

historical sites in Magadi, once established as a capital by Kempegowda. The project is estimated at Rs 90 crore, with the five corporations directed to collectively set aside Rs 30 crore in the current financial year.

A similar initiative has been proposed at the hillocks of Hutridurga (Uttari Betta) in Kunigal, where stone inscriptions associated with Kempegowda are located. The corporations have been asked to contribute Rs 10 crore for works to be executed by the Kempegowda Development Authority. The government has also proposed establishing a town planning institute in

Kempegowda's name, with each corporation directed to allocate Rs 10 crore, taking the total outlay to Rs 50 crore. In addition, Rs 5 crore has been earmarked for the maintenance of the Nadaprabhu Kempegowda Advocates' Training Centre.

Continuing last year's initiative, the corporations will also fund Kempegowda Jayanthi celebrations across the state. A total of Rs 2.4 crore has been set aside for celebrations in all taluks. In Bengaluru, events will be held in all ward offices with Rs 3.69 crore allocated, at Rs 1 lakh per ward. A further Rs 5 lakh has been earmarked for an event to be organised by the Bengaluru Advocates' Association. With no additional budgetary provision announced for these works, officials indicated that corporations may have to revisit existing allocations and prune ongoing projects to accommodate the new proposals. In the state budget, Chief Minister Siddaramaiah announced a Rs 3,000-crore grant for Bengaluru's development. The UDD has distributed the funds among the five corporations based on their revenue potential.

Noble effort 'derailed,' DMK, Cong made it target of hatred: PM Modi on women's reservation bill

Prime Minister Narendra Modi on Saturday said his government's women's reservation bill was a noble effort that got 'derailed' due to the DMK and Congress which made it a "target of hatred and petty politics." Especially targeting the ruling DMK in Tamil Nadu and the Congress over the amendment bill being defeated in the Lok Sabha on Friday, the PM asked, "Why does it trouble DMK, Congress to see ordinary women rise?" He said he had personally appealed to the opposition parties to support the bill and even offered to give them credit as "I only wanted sisters from ordinary families to come to parliament, assemblies in good numbers."

"But unfortunately, this noble effort was derailed. DMK, Congress and their allies made it a target of hatred and petty politics," he charged.

Had this bill been passed, many Tamil women from ordinary families would have become MPs and MLAs. Based on 2011 census, Tamil Nadu was going to get so many more seats in Lok

Sabha, "but clearly the DMK didn't want this to happen," he said, addressing a poll rally here. Anyhow, the DMK's actions are now very clearly exposed. By wearing black clothes, DMK cannot cover up their wrong intention. "I want to tell the DMK, that you people know your black deeds, you cannot escape your black deeds any longer."

9,000 Punjabis among 30,000 face deportation risk in Canada

Chandigarh (TSIT) Nearly 9,000 Punjabi international students and asylum claimants are among 30,000 migrants in Canada who have received notices putting them at risk of deportation following the enactment of the new immigration law, Bill C-12. The Bill called the 'Strengthening Canada's Immigration System and Borders Act', which received



royal assent on March 26, has tightened asylum rules, making claims filed more than one year after entering Canada generally ineligible for a full hearing at the Immigration and Refugee Board (IRB). The provision applies retroactively to those who entered after June 24, 2020. According to CBC News, the Immigration, Refugees and Citizenship Canada (IRCC) has started issuing procedural fairness notices to around 30,000 asylum seekers.

Iranian gunboats fire on tanker in Strait of Hormuz

London (TSIT): The UK Maritime Trade Operations (UKMTO) Centre said on Saturday that a tanker came under fire from two gunboats of Iran's Islamic Revolutionary Guard Corps (IRGC). The UKMTO published a warning on their website saying, "Master UKMTO has received a report of an incident 20NM northeast of OMAN. The Master of a Tanker reports being approached by 2 IRGC gun boats, no VHF challenge that then fired upon the tanker. Tanker and crew are reported safe. Authorities are investigating." Iran announced on Saturday that the control of the Strait has "reverted to its previous state" amid the continuing US naval blockade of Iranian ports.

PM Modi to chair CCS meeting amid West Asia tensions

New Delhi, Apr 18: Prime Minister Narendra Modi will chair a meeting of the Cabinet Committee on Security (CCS) in New Delhi on Saturday amid ongoing tensions in West Asia, according to official sources. The meeting is expected to review the steps taken by various ministries to safeguard India's interests as the situation in the region continues to evolve. This will be the third CCS meeting chaired by the Prime Minister since March focusing on developments in West Asia. In earlier meetings, PM Modi had directed ministries and departments to ensure the availability of essential supplies for the public and to take measures to protect key economic and strategic sectors. He had reviewed actions related to energy, agriculture, fertilisers, aviation, shipping and logistics, along with measures to maintain stability in supply chains. The Prime Minister had also been briefed on the steady supply of Liquefied Natural Gas (LNG), Liquefied Petroleum Gas (LPG) and petroleum products, as well as fertiliser availability for upcoming agricultural seasons. Emphasising the need to curb misinformation, PM Modi had instructed that accurate and timely information be shared with the public to prevent rumours. The government has also constituted an inter-ministerial group chaired by Defence Minister Rajnath Singh to monitor the West Asia situation. The group, which includes Home Minister Amit Shah and Finance Minister Nirmala Sitharaman, has been holding regular meetings to assess developments and recommend necessary measures.

CM Stalin slams BJP led Union government, thanks INDIA bloc leaders



CHENNAI (TSIT): Chief Minister and DMK President MK Stalin on Saturday flayed the BJP-led government at the Centre and accused it of having tried to divide the people as North and South, weaken and defeat them, redraw India's political map for their own gains but INDIA stood together and defeated their designs.

In a social media post, Stalin hailing the INDIA bloc leaders for unilaterally defeating the Constitutional (131st Amendment) Bill, which sought to redistribute Lok Sabha seats on the basis of 2011 census to expedite the implementation of the Women's Reservation Bill providing 33% quota in Legislatures.

The blows the BJP would be facing in the coming days must be far more decisive, Stalin said and stressed the importance of continuing to stand united as one

Opposition in this regard as this was only the beginning. "A big thanks to the leaders of INDIA," the CM wrote on X handle. "I thank my brother, Rahul Gandhi, for voicing our concerns against the delimitation bill that the BJP tried to rush through without consultation or consensus."

Stalin said, "I thank Sonia Gandhi, Kharge, Pinarayi Vijayan, D Raja, Revanth Reddy, Siddaramaiah, Mamata, Akhilesh Yadav and all Opposition leaders. They (BJP) tried to divide us as North and South, to weaken and defeat us, and to redraw India's political map for their own gain. But INDIA stood together and defeated their design. This is only the beginning. The blows the BJP will face in the coming days must be far more decisive."

For that, we must continue to stand united as one Opposition."

CM Revanth slams BJP over women's bill defeat, seeks all-party talks on delimitation

Telangana Chief Minister A. Revanth Reddy on Saturday launched a scathing attack on the BJP over the defeat of the Women's Reservation Bill in the Lok Sabha, accusing the Union government of conspiring to weaken reservations through a Constitutional amendment.

Addressing a press conference in Delhi, the Chief Minister alleged that the BJP's "Char Sau Paar" slogan during the 2024 general elections was aimed at securing enough numbers to amend the Constitution and dilute quota protections for all sections.

Revanth Reddy challenged Prime Minister Narendra Modi and the BJP to prove their sincerity on women's reservation by bringing a fresh Bill immediately and implementing 33 per cent reservation in the 2027 Uttar Pradesh Assembly elections. He said the proposed law should reserve one-third of the existing 543 Lok Sabha seats and one-third of seats in all State Legislative Assemblies for women.

The Chief Minister said the



INDIA alliance would fully support such a Bill if it is introduced in Parliament without delay.

He maintained that the Women's Reservation Bill passed in 2023 could be implemented with minor modifications and asserted that the Centre has no excuse to delay the process, as the Election Commission already possesses 2011 Census data and other required information.

Revanth Reddy said delimitation carried out in 2009 and existing statistical data were sufficient to operationalise women's reservation by August 15, 2026. He said this would allow the reservation policy to be put into effect in the 2027 Uttar Pradesh elections.

HIGHLIGHT POINT:

Revanth Reddy demanded immediate implementation of 33% women's reservation and warned against delimitation models that could disadvantage southern states, while seeking wider consultations and opposition unity on the issue.

He also announced his readiness to initiate consultations with the Chief Ministers of southern states — M.K. Stalin, Siddaramaiah, Pinarayi Vijayan, N. Chandrababu Naidu, and Puducherry Chief Minister N. Rangasamy — to build support for the women's quota legislation.

Thanking opposition leaders for ensuring the defeat of what he described as "black

bills," the Chief Minister said the Congress and other opposition parties had once again prevented the BJP from using the Women's Reservation Bill, delimitation and expansion of constituencies as tools to alter the Constitution and abolish reservations.

He alleged that the BJP's failure to pass the Bills exposed its lack of sincerity and blamed Prime Minister Modi's "arrogance" for the setback in Parliament. On the issue of delimitation, Revanth Reddy reiterated his opposition to any pro-rata model that would politically disadvantage southern, northeastern and smaller states.

Govt rolls out Rs 12,980-crore insurance cover for Indian ships amid global risks



New Delhi (TSIT)

The government on Saturday approved a Rs 12,980-crore sovereign-backed insurance cover for Indian vessels, creating a domestic pool to ensure uninterrupted protection against maritime risks and secure India's shipping lifelines.

The scheme - 'Bharat Maritime Insurance Pool' (BMI Pool) - will provide insurance cover to Indian-flagged ships and cargo

moving to and from Indian ports, even while passing through high-risk and conflict-prone regions.

Approved at a Cabinet meeting chaired by Prime Minister Narendra Modi, the initiative comes amid rising global tensions that have driven up insurance costs and created uncertainty over the availability of cover from foreign insurers.

At present, Indian shipping depends heavily on overseas players such as the International Group of Protection and Indemnity Clubs for Protection and Indemnity (P&I) insurance, which covers liabilities like oil spills, cargo damage, crew injury, collision and wreck removal. Officials said such dependence leaves Indian trade exposed, particularly during geopolitical crises when global insurers may pull back or impose restrictions.

Iranian Ambassador summoned after IRGC gunboats fire at Indian vessels transiting Hormuz

New Delhi (TSIT):

The Ministry of External Affairs (MEA) on Saturday summoned Iran's Ambassador to India, Mohammad Fathali over the shooting incident involving Indian vessels in the Strait of Hormuz.

India is believed to have lodged a strong protest with Tehran over the incident as the Indian-flagged vessels - one of which is believed to be a Very Large Crude Carrier (VLCC) - came under fire from gunboats of Iran's Islamic Revolutionary Guard Corps (IRGC) even though the tanker and crew are reported to be safe.

Earlier, the UK Maritime Trade Operations (UKMTO)



"A report of a Container Ship being hit by an unknown projectile which caused damage to some of the containers, no fires or environment impact reported. Authorities are investigating. Vessels are advised to report suspicious activity to UKMTO," it stated.

Centre confirmed that a tanker came under fire from IRGC gunboats. The UKMTO published a warning on their website saying, "Master UKMTO has received a report of an incident 20NM northeast of Oman. The Master of a Tanker reports being approached by 2 IRGC gun boats, no VHF challenge that then fired upon the tanker. Tanker and crew are reported safe. Authorities are investigating." Another UKMTO

warning Saturday evening, India time, stated that the organisation has received a report of an incident 25NM northeast of Oman.

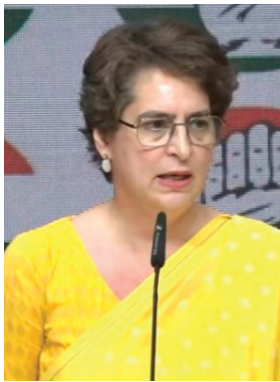
Iran's Khatam al-Anbia Central Headquarters' spokesman was quoted as saying by the country's semi-official Tasnim news agency that the Strait of Hormuz is under "strict control" of the Iranian Armed Forces and will remain in its previous operational state. The

spokesperson further stated that under the pretext of a blockade, the United States continued acts of "sea robbery" and "piracy" with repeated breaches of commitments and a history of misconduct due to which "control over the Strait of Hormuz has been returned to its previous state, and this strategic waterway is under strict management and control by the Armed Forces".

He also mentioned that the situation will remain tightly controlled and unchanged from its previous status until the restrictions on the free movement of vessels from Iran to their destination and from elsewhere to Iran are removed by the United States.

Oppn unity defeated Centre's conspiracy: Priyanka on Women's quota Bill

New Delhi, April 18 : Congress General Secretary and Wayanad MP, Priyanka Gandhi Vadra, on Saturday said that through the "unity" of the Opposition, the Centre's "conspiracy" to allegedly alter the federal structure and weaken democracy was "defeated".



She made these remarks during a press conference following the defeat of the Constitution (131st Amendment) Bill, 2026, in the Lok Sabha a day earlier. The Bill, which aimed to provide 33 per cent reservation for women in Parliament, failed to secure the required two-thirds majority, triggering a sharp political confrontation between the ruling NDA and the Opposition INDIA bloc.

The proposed legislation, which also sought to expand the strength of the House, could not obtain the constitutionally mandated two-thirds majority despite a day-long debate. The Bill secured 278 votes in favour and 211 against, falling short of the required

threshold for passage. Addressing a press conference at the All India Congress Committee office in New Delhi, Priyanka Gandhi said, "What happened yesterday was a huge victory for democracy. The government's conspiracy to alter the federal structure and weaken democracy was defeated and halted. This was a victory for the Constitution, for the country, and for the unity of the Opposition. It was clearly visible on the faces of the ruling party leaders."

Narendra Modi and Home Minister Amit Shah, she said, "Both the Prime Minister and the Home Minister several times said that if we did not support the Bill, then we would never be able to win and come to power. This made it clear what their intention was."

The Congress leader said that the Opposition was "shocked" that this Special Session was called amid the ongoing Assembly elections. "I think it's a conspiracy that somehow they need to stay in power. So, this was a plan to stay in power permanently using women," she said.

"They thought that if it was passed, they'd win. If it's not passed, they'll become the 'messiah' of women by calling other parties anti-women. Being a woman, I know that becoming a 'messiah' of women isn't easy," the Wayanad MP added.

Citing incidents such as the Unnau rape, the Hathras rape and murder case, issues faced by

Olympic athletes, and developments in Manipur, Priyanka Gandhi questioned, "No one supported those women. And today, you are standing in the Parliament and saying that you want to become a 'messiah' of women?"

"This was not about the Women's Reservation Bill but delimitation... Everyone saw how they (the government) can be defeated when the Opposition unites," she said. Describing the day as a "Black Day" for the Centre, she said it was because "they've felt a shock for the first time, which they deserved".

"The problems and struggles of women are growing. Women are not fools; they see everything. The PR and media won't work anymore. If you want to do something substantial, bring back the Bill that was passed unanimously in 2023, which was supported by all parties. You can make a few small amendments to it if you want; do it and implement it now," she said.

Govt's true intent is to alter constitutional framework, seize executive power: Kharge on women's quota, delimitation

New Delhi, April 18 : Congress President Mallikarjun Kharge on Saturday alleged that the government's true intent is to alter the constitutional framework and concentrate executive power in its hands. He stated that the Congress in 2023, supported the Women's Reservation Bill and ensured its passage but now the Centre is linking the Bill with delimitation, which was unacceptable to the Opposition.

Mallikarjun Kharge took to social media 'X' and said, "The Congress Party has always been in favour of women's reservation. In 2023, we supported the Women's Reservation Bill and ensured its passage. However, the Modi government has now introduced another amendment — under the guise of women's reservation — by incorporating a provision for delimitation."

He further alleged that by linking the Bill with



delimitation, the Modi government is attempting to consolidate its power.

"In doing so, the government has conflated the legislation regarding women's reservation with that of delimitation. By introducing a Bill linked to delimitation, the Modi government seeks to consolidate its power," he said.

Kharge also asserted that women's reservation should be implemented within the existing framework of 543 Lok Sabha seats. "Our contention to

the government was that if women's reservation is to be implemented, it should be done within the existing framework of 543 Lok Sabha seats. Subsequently — once the census and delimitation exercises are completed — the government could expand it for the next election; however, they are unwilling to do so," he said.

Reiterating his criticism, he added, "In reality, the Modi government's true intent is to alter the constitutional framework

and seize executive power for itself."

Meanwhile, both Houses of Parliament, the Lok Sabha and the Rajya Sabha, were adjourned after the Bill to amend the Women's Reservation framework failed to clear a key hurdle, as the Centre could not secure the required majority in the Lok Sabha. The government needed a two-thirds majority to pass the Constitution (131st Amendment) Bill, 2026, but fell short. The proposed legislation saw 298 MPs voting in its favour and 230 against. The Constitution (One Hundred and Thirty-First Amendment) Bill, 2026, was introduced with the stated aim of enabling women's reservation and facilitating delimitation. Following its defeat, the Centre decided not to proceed with voting on delimitation and the expansion of Lok Sabha seats, stating that the proposals were interlinked.

India is gradually becoming a hub for NAFLD and metabolic liver disorders, this year's theme, "Good Habits, Strong Liver," reminds us that our health is shaped by daily choices. Nearly one in three urban Indians is affected by fatty liver disease. Warning signs of liver damage include fatigue, weakness, loss of appetite, nausea, jaundice, and abdominal swelling. Dr. Chandan Kumar shares five key principles for a healthy liver: eat whole foods with fiber and lean proteins while reducing processed foods and excess sugars; exercise daily for at least 30 minutes; avoid or limit alcohol to no more than 10 units per week; get regular check-ups as liver diseases often show no early symptoms; and reduce abdominal fat while building muscle strength to lower the risk of diabetes, heart disease, and cancer. Small changes, practiced consistently, are the foundation of a strong liver.

SILENT LIVER CRISIS: 1 IN 3 AT RISK, WARN EXPERTS



Hyderabad: Ahead of World Liver Day, Medicover Hospitals has raised concern over a growing "silent" liver disease crisis in India. Dr. Pavan Addala said nearly one in three Indians may have fatty liver disease, many without diagnosis. Alarming, cases are rising among people

in their 20s and 30s with advanced liver damage. He highlighted that Non-Alcoholic Fatty Liver Disease is now the leading cause, driven by sedentary lifestyles, junk food, obesity, diabetes, and stress. In high-risk groups, prevalence can exceed 50%. Experts warned that liver disease often shows no symptoms until severe stages, potentially leading to cirrhosis, liver failure, or cancer. However, over 70% of cases are preventable through healthy lifestyle choices. Doctors advised maintaining a balanced diet, regular exercise, avoiding alcohol, and undergoing periodic health screenings. While liver transplantation remains an option in advanced cases, prevention is key.

RECORD TUNNELLING ACHIEVEMENTS FOR EAST COAST RAILWAY IN THE EASTERN GHATS REGION



The South India Times, Visakhapatnam : East Coast Railway has created a rare record in the development of key infrastructure in the Eastern Ghats mountain range. During the financial year 2025-26, it successfully completed five major tunnels under challenging geological conditions, marking the most productive year in its history. Recently, on April 14, 2026, Tunnel No. 30 (1,043 meters) in the Sikarapai-Keutguda section achieved a successful breakthrough. This tunnel was constructed with a 5-degree curvature, and excavation carried out from both ends achieved 100 per cent precise alignment, standing as a testament to engineering excellence.

Similarly, significant progress has been recorded in the strategically important Khurda Road-Balangir railway line project. In this project, Tunnel T-4 (4,185

meters) and Tunnel T-2 (1,775 meters) have been successfully completed, resulting in nearly 6 kilometers of tunneling work being finished. Additionally, T-5 and T-6 (each 250 meters) were completed in July 2025, while T-7 (1,975 meters) was completed in November 2025. Overall, during this financial year, breakthroughs were achieved in 7,051 meters of tunnels, while 2,475 meters of tunnels have been fully completed with lining. Progress is also continuing in the doubling projects between Koraput-Rayagada and Koraput-Singapur Road.

These tunneling achievements will not only improve railway connectivity between the coastal and western regions of Odisha, but also enhance the capacity for freight and passenger transportation. Furthermore, they will play a crucial role in extending modern railway services to remote and tribal areas.

CBIT Organizes Expert Lecture on Future Learners and Evolving Teaching Practices

Let's raise awareness about liver health and the importance of prevention.

Hyderabad, 18th April, 2026: A silent health concern is rapidly emerging in urban India. Nearly one in three urban Indians may have fatty liver disease, often without noticeable symptoms. On the occasion of World Liver Day 2026, themed "Solid Habits, Strong Liver," doctors at CARE Hospitals caution that what was once seen largely in older adults is now increasingly being diagnosed among individuals in the 30-50 age group. Early detection allows timely intervention and significantly improves outcomes," said Dr. Sonal Asthana, Senior Consultant - HPB & Liver Transplant at CARE Hospitals.

In response to this growing burden, CARE Hospitals has adopted a comprehensive, multidisciplinary approach, integrating gastroenterology, hepatology, critical care, and transplant services to ensure early detection and timely treatment. Doctors emphasise that early identification, appropriate treatment, and lifestyle changes are critical in

Eating balanced meals, choosing low-fat diets, engaging in at least 30 minutes of daily physical activity, avoiding unnecessary medications, and limiting alcohol intake can significantly reduce the burden on the liver. For those in desk jobs, taking short breaks and staying active during the day can also help in the long run.

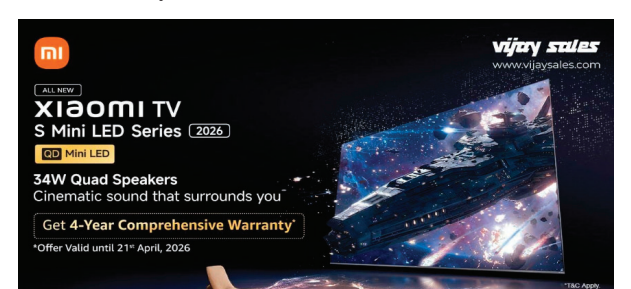

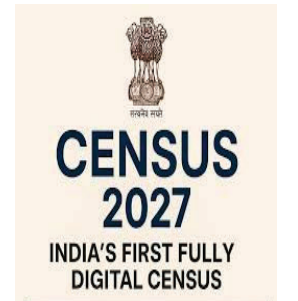

Seats In South And West That Hold Key To Tamil Nadu

In an earlier opinion piece on the Tamil Nadu elections, I had stated that this election is not a big wave election, but one that's being fought on a seat-by-seat basis. In any general election, there are tough contests and then there are defining battles. The first is about candidates; the second will reveal a battle that's bigger—one that could reflect a decisive trend that will determine the overall result. From our extensive travel across the state, below are the defining contests and why. This is not about high-profile candidates; this piece is about the key contest seats in the western and southern districts. In the next piece, I will list out Central (Delta districts), north Tamil Nadu, and Chennai city seats to watch out for.

Western Region

The AIADMK alliance swept this region in 2021, winning 46 out of 61 seats here. It swept Salem with 10 of 11 seats, won all 10 in Coimbatore, six of eight in Tiruppur, five of eight in Erode, and all five in Dharmapuri. In Namakkal, it won only two of six, and in the hilly Nilgiris, it lost all three. "The reason this is important is because Coimbatore, Tiruppur, Erode, Salem, and Dharmapuri are the districts where the DMK must make gains this time to offset losses elsewhere. The DMK had a full sweep in Chennai and peaked in the north and central districts and the south in 2021. If it faces losses after five years in power in these regions, the only space for gains, arguably, is in the west.

Coimbatore South

This seat will show if the DMK's most powerful face in the region—the one known for his organizational might and the one facing ED cases, former minister Senthil Balaji—can rewrite the DMK's Coimbatore calculus. In fact, across this region, the candidates have been selected by Senthil Balaji, who has vacated his traditional Karur seat to contest from here and prove a point.

The BJP's Vanathi Srinivasan (AIADMK alliance) beat MNM Chief and actor Kamal Haasan (DMK alliance) by less than 2,000 votes in 2021. She has shifted to Coimbatore North and Senthil Balaji is facing off with AIADMK strongman Amman K Arjunan, who won Coimbatore North in 2021 and is now contesting from here.

Results here will test whether the AIADMK can hold on to its bastion. Vijay's TVK and Seeman's NTK are also factors here, and the impact they will have on a classic AIADMK vs DMK battle is being closely watched.

Gobichettipalayam (Erode district)

Eight-time AIADMK MLA from this seat and now one of the TVK's biggest faces, KA Sengottayan, will show whether the loyalty to "Two Leaves", which is deep and emotional, can shift to the TVK's whistle on voting day. The AIADMK has fielded a young VB Prabhu to take on Sengottayan. In 2021, the DMK had lost by over 25,000 votes, but if the AIADMK vote gets split, it could throw open an opportunity for the DMK.

In the big picture, this seat will show how strong the "Two Leaves" vote is in seats where former AIADMK leaders have shifted to the TVK. It's also a crucial test for the TVK on whether it can win seats. The possible tacit grassroots understandings between the DMK and AIADMK to keep the TVK at bay would also be crucial to watch out for here.

Tiruchengode (Namakkal District)

The TVK's general secretary and former IRS officer, one known as a crucial strategist in the party, KG Arun Raj, is facing off with the sub-regional, caste-based Kongu Makkal Desiya Katchi's incumbent MLA ER Easwaran (part of the DMK alliance) and AIADMK's R Chandrashekar.

A scripted battle for sympathy

(Hisar incident and the new theatre of politics)

What unfolded on the streets of Hisar wasn't just a simple confrontation; it was a vivid reflection of the complexities of our times' politics, where emotions, power, police behavior, and public opinion are all entangled. The dispute between the former Deputy Chief Minister and a police inspector is no longer merely a matter of law and order, but has transformed into a major political debate. The way this entire incident is being presented on social media and public platforms indicates that in today's politics, the events themselves are not as important as their presentation. The question is no longer what happened, but what is being shown and what sentiment is being generated. In today's times, sympathy has become the most powerful political asset. Emotions often have a greater impact than statistics in electoral mathematics. This is why small incidents are often hyped to symbolize a larger injustice or conflict. This incident in Hisar appears to be moving in this direction, attempting to frame a conflict as a "victim versus the system" narrative. People are drawing their own conclusions based on video clips—sometimes the inspector's behavior appears aggressive, while others see the political parties' reaction as agitated. But assessing the full truth based on these fragmented images is not only difficult but also dangerous, as incomplete information often leads to misconceptions. It's important to understand that every political event has a "post-event life"—that is, how it is exploited after the event. Sometimes events occur spontaneously, but the narrative that is crafted after them is entirely strategic. The Hisar incident raises the same question: whether it was merely a random confrontation or is being exploited for a larger political purpose. Looking at past political events, it's clear that cultivating a "victim" image has become a common strategy for leaders after losing power. Those who stood with power until yesterday now stand against it, seeking to gain



public sympathy.

This is not a new political formula, but a tried-and-true strategy. However, the role of the police cannot be ignored in this entire debate. If the behavior depicted in the video is true, it certainly raises serious questions about police conduct. The police's job is to enforce the law, not to display their personal or institutional power. When police behavior appears aggressive or biased, it deepens existing distrust among the public. However, it is equally important that no public representative or political activist be considered above the law. Inappropriate behavior by a leader or their supporters should be viewed with equal seriousness. This is where the entire issue transcends the boundaries of "politician versus inspector" and turns into a battle of "system versus truth." The biggest danger in this battle is that truth gets lost somewhere and emotions take over. In this age of social media, everyone considers themselves an analyst, and every video clip becomes "evidence." But it's easy to forget that every video has a context, a background, which is often not captured

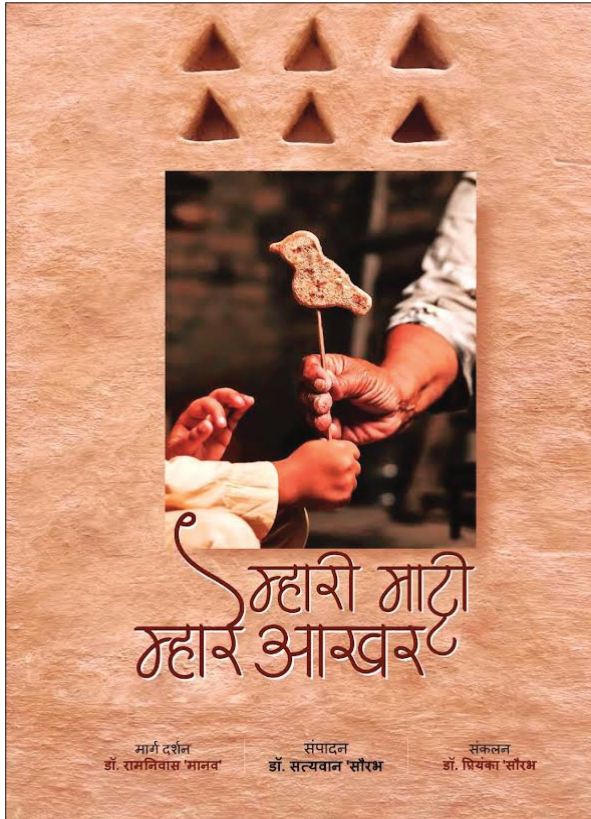
on camera. Today's society is increasingly moving toward "instant judgment," where decisions are made based not on facts but on emotions. People already harbor a certain anger toward the police, which is often justified. But if that anger is channeled into supporting a political figure, it transforms into sympathy. This transformation is subtle, but its impact is profound. This is why every controversy is transformed into a "narrative battle," where the real issue is left behind and emotional appeals take center stage. The most important aspect of this entire episode is what happens next. The response of the government and administration will determine what the case truly was. If no action is taken against the police officer, it will strengthen suspicions that something is being suppressed. And if action is taken, it remains to be seen whether it represents genuine accountability or mere lip service. The history of investigative committees and administrative action in our country has often eroded public trust. Often, investigations become mere time-buying measures, and ultimate-

ly, the case is shelved. Therefore, it is not enough to view this incident solely as a personal dispute. It is part of a broader political and social context, where every incident is seen as an opportunity—either to strengthen one's own position or to weaken the opponent. Therefore, the public has the greatest responsibility to view this entire incident with understanding and consider all aspects before reaching any conclusions. Today, we need neither blind support nor blind opposition. We must understand that the greatest strength in a democracy is public awareness. If we blindly view every incident through the lens of "hero versus villain," we ourselves become part of the game played by politics for its own benefit. This incident in Hisar is both a warning and an opportunity—a warning that we should not get carried away by emotions and move away from the truth, and an opportunity to use our understanding and discretion to correctly evaluate such incidents. Ultimately, it's important to remember that the most dangerous thing in a democracy isn't just lies, but the silence that unquestioningly accepts them.

A new milestone in Haryanvi short story: 'My soil, my letters'

For the first time, "Mhari Matti, Mhare Akhar" brings together 33 Haryanvi short story writers from India and abroad. This unique collection of 99 short stories offers a vivid glimpse of Haryana's soil, folk culture, and human sensibilities. This work is dedicated to the memory of Mr. Manumukt 'Manav', IPS, a youth inspiration. Published in 2026 under the guidance of Dr. Ramniwas 'Manav', compiled by Dr. Priyanka Saurabh, edited by Dr. Satyavan Saurabh, and with a cover designed by Surendra Bansal, this 121-page work is priced at ₹275. It is a must-have for lovers of Haryanvi literature. The true strength of every language lies in its soil, and from that very soil its letters are born. "Mhari Matti, Mhare Akhar" is a collection of short stories that captures this sweet fragrance, not only bringing to the fore the vibrant Haryanvi dialect but also strengthening the influential literary genre that has become the most relevant in today's fast-paced life—the short story. This collection, edited by Dr. Satyavan Saurabh and compiled by Dr. Priyanka Saurabh, includes a total of 99 short stories by 33 short story writers. This number is not just a statistic, but an indication of the emerging form of the Haryanvi short story. For a long time, Haryanvi literature was largely limited to folk songs, raginis, and storytelling, but this collection shows that this dialect is now making its strong presence felt in modern literary genres as well. The defining characteristic of a short story is its brevity, but reading this collection, one feels that the words are few, yet the impact is profound. Each work is centered on a single event, emotion, or social situation, instantly engaging the reader. These stories are not only read, but also felt—and this is the



greatest success of this collection. The book's greatest strength lies in its diverse subject matter. It explores life's many shades—the sweetness of relationships, the harsh realities of society, the simplicity of rural life, and the complexities of changing times. "Tadakai Ki Maa" reflects the sensitivity of motherhood, "Izzat Ki Paribhasa" questions social norms, "Bahu Bihar Ki" exposes social prejudices, while works like "Mati Ki Sondh" and "Ghunghat Aur Ghadi" offer a vivid portrait of Haryana's connection to its cultural roots. The simplicity and straightforward nature of the Haryanvi language make these short stories even more impressive. There's no artificiality or pretense in the language, but rather a natural flow that reaches directly to the reader. This collection reinforces the belief that the depth of literature lies not in the complexity of language, but in its sensitivity.

However, there is one aspect of this book that draws attention—the lack of linguistic uniformity. Since it includes works by many authors, different forms of Haryanvi emerge. In some places, the language is pure folk, while in others, the influence of Hindi is clearly visible. This diversity, on the one hand, makes the collection comprehensive, but on the other, it also lacks a uniform linguistic flow. Nevertheless, this should be seen as a natural condition of the evolving form of Haryanvi rather than a shortcoming. Many of the works in this collection sharply attack social anomalies. Short stories like "Dogla," "Kagzi Samaj Seva," "Leader," and "Crowd and Leader" satirize the hypocrisy, pretense, and hollow leadership prevalent in society. Works like "Daughter's Honor," "Lioness Mother," and "Women's Rights" effectively present women's struggles, self-

respect, and changing social roles. The hallmark of these stories is their straightforward portrayal of reality without unnecessary sentimentality. An important aspect of this book is that it features both new and experienced writers. This not only maintains literary balance but also provides new writers with an opportunity to express themselves. This effort is also important because the emergence of new talent is essential for the development of any language. Dr. Ramniwas 'Manav's' preface provides an ideological foundation for this collection. The clarity with which he presents the current state of the Haryanvi short story, its challenges, and its potential, makes the reader realize the seriousness of this genre. Meanwhile, Surendra Bansal's "Creative Enterprise Nai Sadhuwad" commends this effort and establishes it as a positive literary initiative. Overall, "Mhari Matti, Mhare Akhar" is not just a short story collection, but an important document for Haryanvi literature. It attempts to fill a void where very little work has been done so far. This collection not only highlights current writing but also points to future possibilities. Ultimately, it can be said that this book fully achieves its objective. It not only entertains readers but also inspires them to think, understand, and view their society from a new perspective. This is an invaluable work for lovers of the Haryanvi language, as well as for all those interested in the literature of Indian folk languages. "Mhari Matti, Mhare Akhar" is indeed a remarkable literary effort that powerfully presents the fragrance of its soil and the power of its letters—which has the potential to give a new identity and a new direction to the Haryanvi short story.

When plates are thrown away full and stomachs go to sleep empty

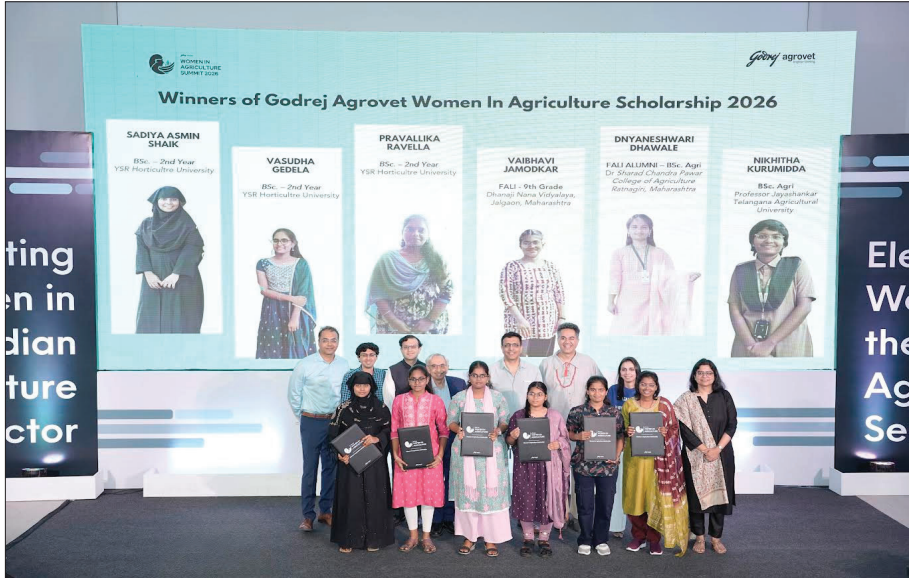

DA HIKE: Cabinet Approves 2% Dearness Allowance Hike For Government Employees And Pensioners



The Cabinet on Saturday approved a 2% hike in Dearness Allowance (DA) for central government employees, providing an increase in take-home pay amid rising living costs, sources told NDTV. The decision comes at a time when pressure is mounting from employee unions for a comprehensive revamp of pay structures under the proposed 8th Pay Commission. In a memorandum submitted to the government, the National Council-Joint Consultative Machinery (NC-JCM) has called for a substantial upward revision in salaries, seeking a fitment factor of 3.83. If the

demand is accepted, the minimum basic pay could rise sharply from the current Rs 18,000 to about Rs 69,000, representing a major overhaul of the existing pay framework. Earlier, The Confederation of Central Government Employees & Workers (CCGEW) had written a letter addressed to the Finance Minister Nirmala Sitharaman expressing concern over the delay in announcing the next DA hike. The organisation pointed out that while the government had last revised DA in October 2025, effective from July 2025, employees have been waiting for the subsequent

revision since January 2026. Their main demand is that the government should immediately announce the pending DA/DR hike effective from Jan. 1, 2026, for both central government employees and pensioners. Because the DA revision is pending, pensioners are also not getting the Dearness Relief (DR), which is linked to DA. The government usually revises the DA twice a year to adjust salaries and pensions for inflation. Since the 7th Pay Commission started on January 1, 2016, such delays in announcements have not happened for this long before.

What is Bharat Maritime Insurance Pool? Key Features, Benefits Explained

The Union Cabinet, chaired by Prime Minister Narendra Modi, on Saturday approved the creation of the Bharat Maritime Insurance Pool (BMI Pool), a domestic maritime insurance mechanism backed by a sovereign guarantee of Rs 12,980 crore. The move is aimed at ensuring uninterrupted and affordable maritime insurance coverage for Indian trade amid rising geopolitical tensions, sanctions risks and global shipping disruptions. According to an official statement issued by the Press Information Bureau, the BMI Pool will provide insurance support to vessels carrying cargo to and from India, including ships transiting through volatile maritime routes. The government said the decision comes against the backdrop of heightened global uncertainty, which has driven up insurance premiums and increased the risk of coverage disruptions for ships and cargo. "Accordingly, there was a need for a domestic maritime risk covering pool to maintain sov-



ereignty and continuity of trade in face of withdrawal of coverage due to sanctions or due to geopolitical tensions," the government said. The proposed pool will cover a broad range of maritime risks, including hull and machinery, cargo, protection and indemnity (P&I), and war risk insurance. The BMI Pool will cater to: Indian-flagged vessels Indian-controlled vessels Ships carrying cargo to or from India The government said the insurance policies will be issued by

member insurers using the pool's combined underwriting capacity, estimated at around Rs 950 crore. India currently relies heavily on international insurers, especially the International Group of Protection and Indemnity Clubs, for P&I coverage. Such insurance typically covers third-party liabilities, including oil pollution, wreck removal, cargo damage, crew injury and collision liabilities. The government said the new pool would help India develop domestic expertise in

marine underwriting, claims management and legal processes while also reducing dependence on foreign insurers. "The rationale for providing a sovereign guarantee to the proposed domestic insurance entity is rooted in the objectives of strengthening self-reliance, sanctions resilience and ensuring greater sovereign control," the government said. The Bharat Maritime Insurance Pool will initially operate for 10 years, with the option to extend it up to 15 years. Among the key expected benefits are: Continuity of insurance coverage during global crises Lower dependence on foreign insurers Reduced foreign exchange outgo on insurance premiums Greater ability to secure reciprocal coverage arrangements with non-IG insurance clubs The move comes as shipping routes across West Asia remain vulnerable to conflict-related disruptions, leading insurers to approve coverage on a case-by-case basis and significantly raise premium costs.

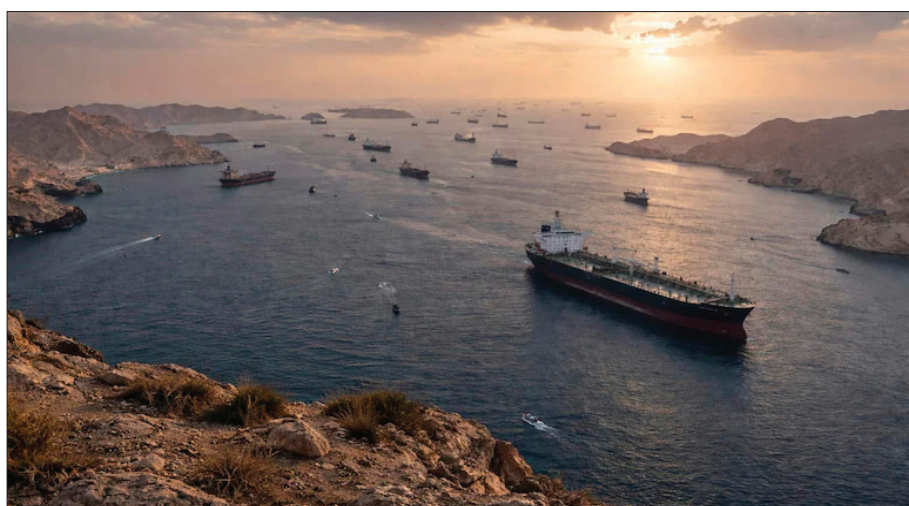

Indian-Flagged Tanker Targeted In Hormuz; MEA Conveys 'Deep Concern' To Iranian Envoy

Two Indian-flagged vessels were forced to turn back from the Strait of Hormuz after Iranian gunboats opened fire near the key shipping route northeast of Oman. The incident took place after Iran declared the Strait of Hormuz closed and announced that control of the vital waterway had reverted to its previous state amid the continuing US naval blockade of Iranian ports. According to sources in the Directorate General of Shipping, there has been no Reuters reported that more than a dozen tankers, including three sanctioned vessels, transited through the Strait of Hormuz after the 50-day blockade was lifted on Friday, shipping data showed. Meanwhile, the US military said it has forced 23 ships to turn back near the Strait of Hormuz since imposing a naval blockade on Iranian ports. In a post on X, US Central Command said American forces continue to enforce the block-



ade "against ships entering or exiting Iranian ports and coastal areas". The blockade, ordered by President Donald Trump, began on April 13 as part of Washington's efforts to pressure Iran into reopening the Strait of Hormuz, damage to either vessel and no injuries have been reported among crew members. "As of now, no damage or injuries to crew on Indian-flagged vessels,"

sources said. "Safety of seafarers and ships is the priority," DG Shipping sources told. Following the incident, New Delhi summoned the Iranian ambassador. In a statement, the Ministry of External Affairs (MEA) said that the Ambassador of the Islamic Republic of Iran in New Delhi was called in by the Ministry of External Affairs for a meeting with Foreign Secretary this evening. During the meet-

ing, Foreign Secretary conveyed India's deep concern at the shooting incident earlier today involving two Indian-flagged ships in the Strait of Hormuz. "He noted the importance that India attached to the safety of merchant shipping and mariners and recalled that Iran had earlier facilitated the safe passage of several ships bound for India. Reiterating his concern at this serious incident of fir-

ing on merchant ships, Foreign Secretary urged the Ambassador to convey India's views to the authorities in Iran and resume at the earliest the process of facilitating India-bound ships across the Strait. The Ambassador of Iran undertook to convey these views to the Iranian authorities." Sources said the two Indian vessels came under fire from Iranian gunboats while transiting through the strategically important shipping lane. Both vessels were forced to change course and turn back. One of the two ships involved in the incident is a very large crude carrier (VLCC), a class of tanker designed for transporting massive quantities of crude oil over long distances. The Strait of Hormuz is one of the world's most critical oil transit chokepoints, with a significant share of global crude shipments passing through the narrow waterway every day.

Ships report attacks after Iran closes Strait of Hormuz, as Trump says US 'won't be blackmailed'

Hezbollah has denied involvement in the incident that left a French peacekeeper dead and three others wounded in southern Lebanon this morning. The United Nations Interim Force in Lebanon (Unifil) said earlier that an initial assessment "indicates the fire came from non-state actors (allegedly Hezbollah)". It says it has launched an investigation. French President Emmanuel Macron has also said that the available information suggests Hezbollah is responsible. Hezbollah, the militant group backed by Iran, says it is "surprised" that others have "rushed to make arbitrary accusations", adding that it affirms "the necessity of coordination between the Lebanese Army and UNIFIL in its movements, especially under these sensitive conditions". The Israel Defense Forces (IDF) says it has set up a "yellow line" security perimeter in southern Lebanon. It's the first time

the IDF has spoken of a demarcation in this way since the ceasefire with Hezbollah began on Thursday night, when Israeli Prime Minister Benjamin Netanyahu announced a 10km (6.2-mile) deep "security zone" would be established. A similar line was set up by the IDF in Gaza after a ceasefire deal there last year, to separate its forces from territory held by Hamas. In a statement today, the IDF said it had struck "terrorists [who] violated the ceasefire understandings by approaching from north of the Yellow Line toward IDF soldiers". There's no word yet on who may have been injured or killed in this attack the Israelis carried out. It said its soldiers are allowed to take action against threats, even during the ceasefire. There's been no immediate response from Hezbollah or the Lebanese government, which agreed to the 10-day truce with Israel. In Gaza, Israeli troops have opened



fire dozens of times at Palestinians they say were trying to cross the "Yellow Line". Earlier this year, the Associated Press reported that 77 people had been killed by Israeli gunfire in the three months since the ceasefire began. The UK Maritime Trade Operations (UKMTO) says a cruise ship located three nautical miles east of Oman has reported seeing "a splash in close proximity". This comes after reports of

attacks on a tanker and a container ship announced in the past two hours off the coast of Oman. Now, let's bring you some comments from Donald Trump in the Oval Office. He spoke briefly about Iran before taking questions from reporters at his executive order signing. He says there are "very good conversations going on" with Iran, and describes Iran as acting "a little cute as they have for 47 years". Trump says Iranian

leaders want to close the Strait of Hormuz, but the US won't let them "blackmail us". The US is taking a tough stand, he adds. The president says there will be "some information by the end of the day" on Iran, but he did not take any direct questions about the conflict before the session ended. Some more now from Iran's Supreme National Security Council (SNSC). In a statement on social media, it says that "as long as the enemy intends to disrupt the passage of vessels and apply its naval blockade, Iran will view that as a violation of the ceasefire and prevent the conditional and limited reopening of the Strait of Hormuz". On negotiations to bring about an end to the war, the SNSC says that new proposals have been put forward by the US, which Tehran is "currently reviewing and has not yet responded to". Iran's Supreme National Security Council, the country's top security body, has said on state TV

that Tehran is "determined to enforce monitoring and control over transit through the Strait of Hormuz until the definitive end of the war and the establishment of lasting peace in the region". The statement says this will be done by collecting full information from vessels passing through, issuing transit certificates, and requiring payment of service fees for "security, safety, and environmental protection services". As the Strait of Hormuz started reopening, some vessels were forced to change their route. Two Indian-flagged vessels, the cargo ship JAG ARNAV and the oil tanker SANMAR HERALD, both received orders to change their travel routes as they were denied access to the Strait of Hormuz by Islamic Revolutionary Guard Corps (IRGC) officials. Tracking data from MarineTraffic shows the vessels slowing down and making a U-turn after passing Larak Island along the agreed route.

DR Congo accepts first set of deportees from the US



Fifteen people deported from the US, who are reportedly from South America, have arrived in the Democratic Republic of Congo. This is the first group of an unknown number of people that the US has expelled which the DR Congo had agreed to take in. The government in Kinshasa has stressed that their stay in the country is only temporary and that Washington is funding "their reception, support and care". The US has already sent deportees to several other African countries, including Ghana, South Sudan and Eswatini, as part of the crackdown on immigration. Earlier this month, when details of the deportation deal first emerged, the Congolese government said

the decision to receive what are known as third-country migrants - that is those who come from neither the sending nor receiving nation - aligns with its commitment to human dignity, to protecting the rights of migrants and international solidarity. The Congolese authorities also said that the scheme was not a "permanent relocation mechanism or an outsourcing of migration policies". The US State Department said that while it did not comment on "diplomatic communications with other governments" the administration remained "unwavering" in its "commitment to end illegal and mass immigration and bolster America's border security".

FRENCH PEACEKEEPER KILLED IN SOUTHERN LEBANON



A French peacekeeper has been killed and three others wounded after a UN patrol came under fire in southern Lebanon, in what officials described as a deliberate attack. The soldier was serving with the United Nations Interim Force in Lebanon (Unifil), which confirmed that one peacekeeper had died and three others were injured, two of them seriously, when their patrol came under small-arms fire. French President Emmanuel Macron blamed the attack on Hezbollah. The Iran-backed armed group denied "any connection" to the incident. It comes amid heightened tensions in southern Lebanon, where peacekeepers have faced growing risks since renewed fighting between Hezbollah and Israel erupted on 2 March. A 10-day ceasefire between Israel and Lebanon came into effect on 16 April. The US, which announced the deal, urged Hezbollah to abide by its terms. "Everything suggests that responsibility for this attack lies with Hezbollah," Macron said. "France demands that the Lebanese authorities immediately arrest the perpetrators and take their responsibilities alongside

Unifil." France's Armed Forces Minister Catherine Vautrin said the peacekeeper had been part of a mission to reopen access to a Unifil position that had been cut off by the recent fighting when it had been "ambushed by an armed group at very close range". Vautrin added that he was "hit immediately by a direct shot from a small arms weapon" and was pulled away by fellow soldiers, who were unable to revive him. Unifil said the patrol had been clearing explosive ordnance along a road in the village of Ghanduriyah to reconnect isolated positions. It said the team came under fire from what it described as non-state actors and condemned the attack as "deliberate". The Lebanese Armed Forces said the incident followed exchanges of fire with armed individuals, adding that it was co-ordinating closely with Unifil during what it described as a sensitive phase in southern Lebanon. Lebanon's President Joseph Aoun condemned the attack and told Macron during a phone call that those responsible would be brought to justice. Prime Minister Nawaf Salam has also ordered an investigation.

THREE SENTENCED FOR 'MAN IN BEAR SUIT' INSURANCE SCAM



Three men have been sentenced in California for an insurance scam using someone in a bear costume to stage fake attacks on luxury cars. Viral video handed to insurers as evidence seemed to show a bear in a 2010 Rolls-Royce Ghost in Lake Arrowhead on 28 January 2024. Similar claims were filed on the same date and location for two high-end Mercedes

models. But biologists at the California Department of Fish and Wildlife reviewed the footage and determined it showed a human in a bear suit. The state insurance department launched "Operation Bear Claw", executing a search warrant and finding a bear outfit in the suspects' home. The fraud involved \$141,839 (£105,000) in insurance payments.

MADONNA JOINS SABRINA CARPENTER TO SURPRISE COACHELLA

Madonna surprised fans at Coachella making a guest appearance during Sabrina Carpenter's Friday night headline set. The Queen of Pop joined Carpenter on stage for a duet of Vogue, Like a Prayer and a song seemingly from Madonna's new album. The performance followed days of speculation that Madonna would appear at the festival in the Colorado desert in California. On Wednesday, Madonna officially confirmed the release of Confessions II - a sequel to her 2005 Confessions On A Dance Floor. After Carpenter finished a rendition of Juno, Madonna emerged while the intro of Vogue played out and dancers struck a pose. With matching blonde hair and lace corsets, the pair



sang the 1990 house hit, before strutting across the stage to perform a new song. "Thank you so much for inviting me on your show," the Hung Up singer said. "No thanks needed, Madonna," Carpenter replied. "You can have whatever you want." Speaking to the crowd, Madonna said: "Twenty years ago today, I performed at Coachella - I was in the

dance tent and it was the first time I performed Confessions On A Dance Floor: Part I in America and that was such a thrill for me." "So you can imagine what a thrill it is for me to be back 20 years later... so it's a like a full circle moment you know - very meaningful for me," she added, before discussing astrology with the crowd. The 5ft 4in star then pointed

out it was the first time she has performed with someone shorter than her. "Thank you for giving me that experience," Madonna joked. The pair then joined forces for a duet of Like A Prayer. ORBÁN'S ERA WAS OVER IN A FLASH AND HUNGARY'S NEXT PM IS A MAN IN A HURRY

Péter Magyar and his victorious Tisza party have wasted no time preparing for the transfer of power in Hungary after their dramatic landslide defeat of Viktor Orbán last Sunday. They won 52% of the vote to put an end to his party's 16 years of continuous rule, which translates into 141 seats in the 199-seat National Assembly. Orbán's Fidesz have slumped from 135 to 52 seats. The count will be finalised on Saturday - including recounts in closely tied constituencies, and votes cast abroad. Magyar has won a pledge from President Tamás Sulyok to bring forward the formation of the new parliament to the week beginning 4 May. Parliament



can then elect the new government. He also gave combative interviews to public service TV and radio, which have largely ignored or attacked him for the past two years. He has promised to pass laws to suspend their news programmes, until impartial editors can be

appointed. All this will take time. Armed with a so-called super-majority of more than two-thirds of seats in parliament, he also plans retroactively to limit the number of terms a prime minister can serve to two. Viktor Orbán has already served five. If that goes through, Magyar

could slam the door on Orbán's return. It was not until late on Thursday that Orbán finally broke his silence after Sunday's defeat, in an interview on the Patrióta YouTube channel. "This is the end of an era," said Hungary's beaten leader. "We must bear this defeat with dignity." He spoke of feeling "pain and emptiness" about the defeat, taking full personal responsibility for what happened. But he offered no analysis of the main mistakes of his campaign, other than the failure to finish the Russian-designed Paks 2 nuclear power station, which is running six years behind schedule.

Millions listen to Ethiopian star's song taking swipe at government



In a country where criticising the authorities has often landed people in trouble, the latest song from Ethiopia's biggest musician - which appears to condemn the government - is attracting attention. Teddy Afro's track Das Tal, meaning "put up the tent" in English, has been viewed more than seven million times on YouTube since its release on Thursday. Referencing a traditional mourning tent, Teddy Afro - whose real name is Tewodros Kassahun - sings that he is grieving a country he says has been lost. The build-up to the song's release had already drawn controversy after a preview event for journalists in the capital Addis Ababa failed to go ahead, for reasons which are unclear. "The spirit of being Ethiopian is now pushed away," the 49-year-old laments on Das Tal. "Now I understand the sorrow and pain. Where can someone go to mourn, where do you cry? In the place that raised me, in the village where I grew up, I have become a stranger, like someone with no country." The star has been a thorn in the side of previous governments. Two decades ago he was imprisoned for 16 months for being involved in a hit-and-run, and said the

charges were politically motivated. His last album, 2017's Ethiopia, enjoyed significant sales in the country and topped the Billboard World Albums chart for weeks. It dwelt on historical themes and called for unity among Ethiopians. But its official release in the country was blocked by the authorities. There were huge anti-government protests at the time over the marginalisation of the country's largest ethnic group, Oromos, which eventually saw the downfall of the then-prime minister. "All of my music is based on love," Teddy Afro told the BBC in 2017. "Like Martin Luther King said: 'Hate cannot drive out hate: only love can do that.' And for us to come out of the situation we are in, I believe the only choice we have is love." Prime Minister Abiy Ahmed, who is Oromo himself, came to power in the wake of the protests and promised a new age of unity in the country, which comprises many ethnic groups. Teddy Afro initially embraced that promise, but has since been disillusioned by widespread violence and the government's actions - not least the two-year civil war in the north, which led to the deaths of hundreds of thousands of people.

FRENCH FILM STAR NATHALIE BAYE DIES AGED 77, MEDIA REPORT

One of France's most celebrated film stars, Nathalie Baye, has died aged 77, French media report. President Emmanuel Macron said the much-loved stalwart of French cinema had been "an actress with whom we loved, dreamed and grew up". A four-time acting winner at the Césars - France's equivalent of the Oscars - Baye starred in some 80 films in her lifetime after breakout roles in the early 1970s. Her family told the French news agency AFP she had died at her home in Paris on Friday evening from a form of dementia. Born into a bohemian family of artists in Normandy in 1948, she began her career as a dancer before turning to acting. Baye got her break in François Truffaut's

1973 comedy La Nuit Américaine, titled Day for Night in English - when she was fresh out of drama school, Le Monde reported. She went on to become one of France's most decorated actresses over a career spanning five decades. She won her first César in 1981 for her supporting role in Jean-Luc Godard's dark comedy Sauve qui peut (la vie), or Every Man for Himself. She was again named best supporting actress in 1982 and best actress the following year for Une Étrange Affaire (Strange Affair) and La Balance. Baye was named best actress at the 1999 Venice Film Festival for Une Liaison Pornographique, titled An Affair of Love in English. Later in her career she



appeared in high-profile international projects, such as Steven Spielberg's 2002 film Catch Me if You Can, in which she played Leonardo DiCaprio's mother. More

recently, she played a parody of herself in the acclaimed series Call My Agent! alongside her daughter, actress Laura Smet, and a French aristocrat in the second Downton

Abbey film. Baye had Smet with rock artist Johnny Hallyday, nicknamed the French Elvis, with whom she had had a five-year relationship. In 2017, Hallyday's death sparked national mourning. Baye's final on-screen role came in the 2023 Franco-Lebanese drama La nuit du verre deau (Mother Valley). Away from acting, French media reported that Baye publicly supported action to tackle climate change and reform French assisted dying legislation. Among those paying tribute was one of Baye's earliest co-stars - Isabelle Adjani, who appeared alongside her in 1974's La Gifle (The Slap) and who called her an "actress of dazzling spontaneity" in a post on social media. Richard

Berry, who starred alongside her in La Balance in 1982, wrote on Instagram: "Nathalie, you take with you our laughter and the fond memories of our early days." Macron, meanwhile, wrote on X: "We loved Nathalie Baye so much. With her voice, her smile and her grace, she has been a constant presence in French cinema over the past few decades, from François Truffaut to Tonie Marshall. "She was an actress with whom we loved, dreamed and grew up. Our thoughts are with her family and loved ones." Culture Minister Catherine Pégard told AFP that Baye had "lit up a long chapter in the history of French cinema with her talent and radiant personality".

Former Wimbledon champion Marketa Vondrousova says she was at "breaking point after months of physical and mental stress" when she refused a visit from a doping control officer to her home in December 2025. The Czech player has been charged with refusing a doping test by the International Tennis Integrity Agency (ITIA) after denying the officer entry to conduct the test. Players are required to log their whereabouts for an allotted hour each day so that authorities can conduct anti-doping tests outside of competition. Should the 26-year-old be found guilty of the charge, she could be banned for up to four years. But Vondrousova says she feared for her safety when the officer called at her home and said they failed to follow "protocol". "The recent doping control incident happened because I reached a breaking point after months of physical and mental stress," Vondrousova wrote on Instagram. "When someone rang my door late at night without properly identifying themselves or following protocol - I reacted as a person who felt scared. "In that moment it was about feeling



safe, not about avoiding anything." The 2023 Wimbledon women's singles champion added that "experts confirmed" she had "suffered an acute stress reaction and generalised anxiety disorder". The ITIA said it was "aware of the player's comments" and, while it could "confirm that an investigation is under way and the player has been charged with refusing a test", it was "not able to comment any further on the specifics".

SCOTT POWERS TO IMPRESSIVE MEDLEY WIN IN LONDON

Double Olympic champion Duncan Scott won the men's 200m individual medley title in style as the Aquatics GB Swimming Championships continued in London. Scott, 28, has won silver medals in the event at the last two Olympics and showed he remains a class act, winning in a time of 1:56.08 to qualify for this summer's European Aquatics Championships in Paris. He saw off Evan Jones in second, while Max Litchfield took bronze. Scott said: "It was pretty good, I think. "In terms of my technique, my strokes and transitions between them felt pretty good, and I'm happy - that's a good place for me to be at this time of the season." The



Scottish swimmer won gold in the men's 4x200m freestyle relay at both Tokyo 2020 and Paris 2024. Earlier on Friday evening Oliver Morgan won the 50m backstroke and Eva Okaro became champion in the women's 50m butterfly. Morgan set a new personal best of 24.36, and Okaro claimed her second title of the week with a PB of 25.95 to

break the sub-26-second mark for the first time. She said: "I'm really happy with that. The 50m is a bit of a fun one for me, but I really enjoyed that race. "I wanted to race the event to break up the meet a bit, but I'm also quite good at a splash and dash, so why not!" British titles are being awarded in 36 medal events across the meet in London this week.

"I HAVE DEBT": Chris Gayle Told Lalit Modi After Going Unsold In IPL. Then A Turnaround



Former Indian Premier League (IPL) chairman Lalit Modi claimed that he requested former Royal Challengers Bengaluru (RCB) owner Vijay Mallya to include Chris Gayle in his team after the West Indies legend went unsold in the auction. Gayle, who played for Kolkata Knight Riders in 2009 and 2010, did not find any takers in the IPL 2011 auction. However, Lalit Modi said that he received a call from the West Indies international where he requested the then IPL chairman to find him a team as he had to pay off his debts. As a result, Lalit Modi approached Mallya, and he decided to take Gayle in place of the injured Dirk Nannes. "I had just left the IPL, come back

to London, and my good friend Chris Gayle wasn't picked up at the auction. I get a call from him that nobody's picked me up at the auction. I said, you didn't perform. IPL is all about performing. You played for the Kolkata Knight Riders, and it is my feeling that you didn't perform. You can perform, but you just got lazy. He said, I have a huge debt coming and I need to pay my bills. I made a few calls. Call one, two, three - everybody said no. "I went across the road to Vijay Mallya's house. I said, Vijay, give this bloke a try. He said, you know, I think Nannes has been injured or something. He said, I have an opening, but I'll pay him if he performs. I told Chris, go there and perform.

Hardik Pandya's Captaincy Receives Brutal Verdict After Mumbai Indians' Loss

Former Indian cricket team all-rounder Irfan Pathan delivered a brutal verdict on Hardik Pandya's captaincy following Mumbai Indians' loss against Punjab Kings in their IPL 2026 match on Friday. Quinton De Kock slammed a brilliant century for MI but dismal show from the bowlers meant that Prabhsimran Singh and Shreyas Iyer were able to guide PBKS to victory. It was MI's fourth loss in five matches this season and they are currently struggling at 9th in the IPL points table. It was a poor outing for Hardik as well after he scored just 14 runs and did not take a single wick-

et. Pathan said that Hardik's recent performances have been quite concerning before pointing out that he needs to manage situations in a better manner. "It is also about managing things in a better manner. Hardik's batting average since 2024 is in the early 20s. We expect better from him. He needs to do better in the powerplay in bowling too. Things became easier in this match as Allah Ghazanfar picked up wickets. But he is looking very worried when there is pressure," Pathan said on his YouTube channel. Pathan also took aim at the MI bowlers for their disappointing performances and pointed

out that they need to play a 'proper wicket-taker'. While the likes of Shardul Thakur and Deepak Chahar have struggled massively to keep runs in check, star pacer Jasprit Bumrah has not taken a single wicket in this year's competition. "Out of the five bowlers, Shardul Thakur and Hardik Pandya are all-rounders, and Deepak Chahar is not taking wickets. They are left with just two bowlers then. How will you take wickets with just two bowlers? They need to improve their bowling unit and play a proper wicket-taker," he added. Hardik Pandya did not mince his words after Mumbai Indians

crashed to their fourth successive defeat in IPL 2026, warning about taking a few "difficult calls" and reminded his misfiring teammates of the need to take "ownership" of the team's poor outings. In their latest debacle, the five-time champions lost to Punjab Kings by seven wickets and are now languishing ninth on the table with just two points. "To be very honest, I don't have much to say right now. I think we really need to go back on the drawing board and see where are we lacking. Is it individuals? Is it as a group? Is it planning? We'll just figure it out and see what we can do next," said Pandya.
