**ISI-BKI TERROR MODULE BUSTED, 11 ARRESTED IN DELHI-PUNJAB ESPIONAGE PLOT**

New Delhi, Apr 10: The Delhi Police Special Cell on Friday busted a major terror module allegedly backed by Pakistan's intelligence agency Inter-Services Intelligence (ISI) and Babbar Khalsa International (BKI), arresting 11 suspects from Delhi and Punjab. Police said the module was involved in espionage, arms smuggling and planning terror attacks. Acting on leads, officials recovered nine solar-powered CCTV cameras installed near sensitive defence and security establishments across multiple locations. These cameras were transmitting live feeds to handlers in Pakistan using SIM cards. Authorities also seized four pistols, including foreign-made weapons, and 24 live cartridges.

**PUNJAB POLICE BUST ISI-BACKED BKI TERROR MODULE, TWO ARRESTED WITH EXPLOSIVES**

Chandigarh, Apr 9: In a significant counter-terror operation, Punjab Police, in coordination with central agencies and the State Special Operation Cell (SSOC) of the Counter Intelligence Wing, has dismantled an ISI-sponsored Babbar Khalsa International (BKI) module, arresting two operatives, officials said. The accused, identified as Akash Masih and Jablaun, residents of Dulla Nangal in Gurdaspur, have prior criminal records. Their apprehension led to the seizure of a large cache of explosives and terror-related materials, including five hand grenades, two special detonators, a Push-to-Talk (PTT) timer with coder and decoder, a 9V battery, one kilogram of high explosive packed with nails, an improvised explosive device (IED), and a Baofeng walkie-talkie with trigger mechanism. Director General of Police Gaurav Yadav stated that the recovered materials indicated preparations for high-impact attacks aimed at destabilizing public peace in Punjab. Deputy Inspector General of Police, Border Range, Sandeep Goel, added that initial investigations suggest the terror module was directed by foreign-based handlers.

## 10 pilgrims from Punjab dead, several missing after boat capsizes in Mathura's Vrindavan



Jagraon (TSIT) A boat carrying pilgrims, primarily from Punjab, capsized in Vrindavan's Yamuna on Friday afternoon, leaving 10 persons dead and several others missing. The accident occurred near Kesi Ghat when the boat carrying pilgrims moved into deeper waters and hit a floating pontoon.

A group of pilgrims, including children, had set out on a Yamuna trip in a private steamer. They were part of a larger group of 150 pilgrims from Ludhiana and Muktsar in Punjab. The deceased include six men and four women.

Authorities noted that a pontoon bridge had recently been dismantled in the area due to rising water levels, leaving some pontoon drums in the river, one of which the boat is believed to have collided

with. District Magistrate Chandra Prakash Singh reported six fatalities earlier, and later rescuers recovered four more bodies, taking the toll to 10, district administration officials confirmed.

"Sixteen to 17 people have been rescued safely so far. Efforts are ongoing to locate the missing," the DM said earlier, adding that all tourists onboard were from Punjab. The district magistrate said the exact number of people on board the boat at the time of the accident is yet to be ascertained. However, based on inputs from accompanying pilgrims, three to four persons are still reportedly missing.

Chief Minister Yogi Adityanath has taken cognisance of the incident and expressed deep grief over the loss of lives. He conveyed his condolences to the

bereaved families.

The chief minister has directed officials to expedite the ongoing relief and rescue operations and ensure that the injured are provided immediate and proper medical treatment, officials said. Punjab Chief Minister Bhagwant Mann spoke to Adityanath and said all necessary assistance would be provided to the victims. He said the boat was carrying 32 people hailing from Jagraon city in Punjab for darshan in Vrindavan. The Ludhiana administration has set up dedicated control rooms in Ludhiana and Jagraon - 01624223226 (SDM Jagraon office) and 01612403100 (Deputy Commissioner Office Ludhiana). Special teams of civil and police officers have already been dispatched from Ludhiana to Vrindavan, officials said.

## CM Revanth Attends CWC Meeting in Delhi

Chief Ministers from Congress-ruled states, including Siddaramaiah (Karnataka) and Sukhvinder Singh Sukhu (Himachal Pradesh), joined key deliberations. The CWC focused on political strategies and organizational matters to strengthen the party's national framework.

## 42 Maoists Surrender, Telangana Now Maoist-Free: DGP

HYDERABAD TSIT BUREAU: Telangana Police declared the state free of armed Maoist formations after 42 CPI (Maoist) cadres, including key members of the PLGA Battalion, surrendered on Thursday. DGP B. Shivadhar Reddy said the surrender has dismantled the Telangana State Committee (TSC) and neutralized extremist operations in the region.

The cadres handed over 36 firearms (including AK-47s and INSAS rifles), over 1,000 rounds of ammunition, two grenades, and 800 grams of gold. So far in 2026, 205 Maoists have surrendered, and 206 firearms recovered. Since 2024, a total of 761 cadres have laid down arms. The DGP credited sustained police operations and a progressive rehabilitation policy—offering financial aid



up to Rs.20 lakh, weapon surrender incentives, and healthcare. A reward of Rs.1.93 crore will be distributed among the surrendered cadres. Appealing to remaining underground members, the DGP urged them to surrender and return to a dignified mainstream life.

## AP CABINET APPROVES RS. 10,239 CR CHIP PLANT, EYES VIZAG AS AI HUB



Amaravathi (TSIT): The Andhra Pradesh Cabinet, led by CM Nara Chandrababu Naidu, approved multi-billion rupee investments on April 10, 2026, with a strategic focus on making Visakhapatnam a global AI and IT hub. Key clearances include the Adani Infra AI Data Center, IT parks by iSprout (Rs.1,000 crore), and a Rs.10,239 crore semiconductor OSAT facility by RRP Electronics in Sri Sathya Sai district. Other major nods went to a Shyam Metals steel complex (Rs.3,678 crore) and AM/NS pellet plant expansion (Rs.1,400 crore). The Cabinet also greenlit green energy projects, Amaravati Quantum Valley, healthcare AI systems, tourism infrastructure, and ex-gratia for accident victims.

## Karnataka Home Minister clarifies no 'zombie drugs' exist; police arrest man for posting video

Bengaluru, April 10 : The Karnataka Police have arrested the man who posted the viral video claiming the availability of "zombie drugs" in Bengaluru city on Friday. However, Home Minister G. Parameashwara has clarified that no such drugs exist in Bengaluru.

He stated that the man in the video had consumed alcohol and taken tablets simultaneously, which caused him to behave unusually on a public road. The police in Bengaluru have arrested the accused, identified as Hemanth Kumar, a resident of the Vidyanarayana locality. He had recorded the video three days ago and posted it on social media.

The video showed a man acting like a "zombie" through his body language on a busy arterial road in broad daylight.

The police have also tracked down the man seen in the video in the city. He was subjected to a medical examination to check for the presence of narcotic substances.

The police stated that no narcotic substance was found during the tests. The accused, Hemanth Kumar, works as a field executive for an eyewear brand. Police investigations revealed that while he was travelling on Bagalur Main



Road at around 11.30 a.m. on April 7, he spotted a man in an intoxicated state, struggling to walk and behaving unusually. He recorded a 32-second video of the man and posted it on his Instagram account, the police said. The police were able to track him with the help of the scooter seen in the video. The clip later went viral and raised concerns about so-called "zombie drugs."

Sharing the video, Kannada film popular hero Duniya Vijay appealed to parents to take care of their children. "A new narcotic drug is available in Bengaluru, and youth should be careful. Parents must also remain vigilant. The police department should clarify the facts regarding the 'zombie

drug'. People must inform the police if they receive any information about it," he said.

After the video went viral on social media, the police launched an investigation and identified Hemanth as the person behind it. Police have also clarified that claims about "zombie drugs" are false.

Responding to the rumours, Home Minister G. Parameashwara dismissed the claims as baseless. He said preliminary information indicated that the individual was a lorry driver who had come from northern states such as Haryana or Punjab for work. The person had reportedly consumed medication for an illness along with alcohol, which led to his unusual behaviour.

## 'Let my work do the talking': Raghav Chadha shares video amid AAP rift

New Delhi, April 10 : Amid internal rift within the Aam Aadmi Party (AAP), Rajya Sabha member Raghav Chadha on Friday shared a message on Instagram asserting that his parliamentary work would speak for itself.

Taking to the social media platform Instagram, Chadha posted a video and wrote, "With respect, to those questioning my parliamentary performance, I'll let my work do the talking."

The video featured a compilation of his interventions and questions raised in the Rajya Sabha, highlighting a wide range of public policy issues he has addressed.

In the video, Chadha is seen raising concerns on several matters, including the problem of data expiry, the need to make paternity leave a legal right, and the demand to end minimum balance penalties in banks. He also spoke about issues such as food adulteration, incoming call charges, 28-day recharge scam, taxation concerns, and excess baggage charges in airlines.

Further, he addressed broader systemic challenges such as paper leak scams, air pollution, exploitation of gig workers, delays in health insurance claims, and alleged irregularities at toll plazas. The video



also included his remarks on expensive airport food, data privacy breaches, the demand for a free annual health check-up as a right, and rising airfares. Chadha additionally raised concerns over digital copyright strikes, GST reforms, the debt-to-GDP ratio, and tax relief for persons with disabilities and members of the armed forces. His interventions also touched upon the legalisation of virtual digital assets, labour reforms such as "right to hire and fire", and comparisons of taxation and service delivery standards. Among other issues highlighted were rising inflation, the cancer train of Punjab, joint tax filing, rural banking infrastructure, water scarcity, and the digitisation of land records using blockchain technology. He also spoke about expanding UDAN cafes across India, urban traffic congestion, misleading product branding, and the gap between education and employment.

The video further showcased his demands related to wage indexation, conferring the Bharat Ratna on Bhagat Singh, 'One Nation, One Medical Treatment', menstrual hygiene, and Minimum Support Price (MSP) for farmers. Chadha also raised concerns about vanishing groundwater levels in Punjab, access to drinking water, and issues related to the state's heritage and infrastructure, including international flight connectivity.

The post comes at a time when speculation is mounting about Chadha's position within AAP. On April 8, a separate Instagram post shared by him drew attention after it featured a purported supporter suggesting that he should form a new youth-led political party instead of joining any existing organisation.

In the 22-second video, the supporter said that forming a "Gen Z party" could be a better option for Chadha, as it would attract strong youth backing and avoid potential backlash that might come from joining another political outfit. Reposting the clip, Chadha responded briefly, writing, "Interesting thought", accompanied by a thoughtful emoji.

He instructed that village-level road safety committees should be formed in every village with the involvement of sarpanches and youth. These committees should identify local road safety issues and take necessary steps to prevent accidents. To reduce accidents, he emphasized the importance of defensive driving practices. He also suggested creating awareness by displaying visuals of road accidents in the district through LED screens and flex banners.



The SP directed officials to intensify awareness campaigns by painting road safety messages on village walls and organizing short skits through police cultural teams to educate the public. He stressed that police personnel must strictly follow traffic rules themselves and act as role models. He also ordered that traffic chals should be imposed even on police officers and staff who violate traffic rules. Additionally, he advised conducting meetings with auto, lorry, and bus driver unions to discuss traffic regulations and common issues faced by drivers. He recommended using public addressing systems, loudspeakers, and social media platforms to widely spread awareness about traffic rules.

# Madras HC dismisses Ramadoss' plea, refuses to freeze 'Mango' symbol

The matter was taken up as an urgent hearing before Justice TV Thamilselvi of the Madras High Court

CHENNAI: The Madras High Court has dismissed a petition filed by Dr Ramadoss, founder of the Pattali Makkal Katchi, seeking to freeze the party's 'mango' symbol.

The petition was filed challenging an order of the civil court which had refused to freeze the 'mango' symbol until the disposal of a civil suit concerning intra-party disputes.

The matter was taken up as an urgent hearing before Justice TV Thamilselvi of the Madras High Court.

During the hearing, counsel appearing for Anbumani Ramadoss and Vadivel Ramanan contended that the petition was not maintainable, as the final list of candidates had already



been published and symbols had been allotted.

It was further submitted that candidates of the petitioner's faction had already accepted the 'cylinder' symbol allotted to them, and that the election process in Pudukcherry had been completed. Therefore, no direction could be issued to the Election Commission of India to freeze the symbol.

Election Commission of India submitted that the election process has

commenced, and candidate lists have been finalised, and only campaigning and polling remain.

In response, Ramadoss's counsel submitted that the petition was filed as the representation made before the Election Commission had not been considered.

Counsel appearing for Anbumani Ramadoss and Vadivel Ramanan contended that the petition was not maintainable, as the final list of candidates had already

been published and symbols had been allotted hearing all parties, Justice TV Thamilselvi dismissed the petition seeking to freeze the 'mango' symbol.

On March 26, civil court Judge M Dharmaprabhu had dismissed the interim applications seeking to freeze the symbol. The court noted that because the election process had already commenced and the Model Code of Conduct was in effect, any interference would create confusion among the electorate and disturb the level playing field.

Later, the Madras High Court had declined to treat the petition as an urgent matter and advised Ramadoss to approach the ECI for relief, though the courts emphasised they would not intervene at this critical stage of the elections.

# Schools unsafe with Pocco convicts: PMK president Anbumani

CHENNAI: A government school teacher in Salem district has been arrested under the Protection of Children from Sexual Offences (Pocco) Act for allegedly sexually harassing girl students, prompting PMK president Anbumani Ramadoss to launch a scathing attack on the DMK government over women and child safety.

IOCL raises commercial LPG quota to 70% in Tamil Nadu, fuel supplies remain stable. The teacher, P Balasubramanian, was posted at the Government Middle School in Devur near Sankagiri. Police action followed complaints from multiple students of Classes 6 to 8, who alleged that the teacher threatened and sexually abused them. He is also accused of intimidating the children by claiming he possessed supernatural powers and would harm them if they disobeyed him. According to reports, a similar Pocco case was already pending against the teacher at



Suramangalam police station, raising serious questions about his appointment and monitoring. Reacting to the incident, Anbumani Ramadoss issued a statement on Friday said that the arrest exposes a "complete failure" of the DMK government to ensure safety even within school premises. He alleged that educational institutions have become unsafe for girls under the present regime. Citing official data, he claimed that Pocco cases in Tamil Nadu have risen 129%. Ever since the DMK government assumed power in the State, there has been no safety for women and children, he charged.

# IOCL raises commercial LPG quota to 70% in Tamil Nadu, fuel supplies remain stable

CHENNAI: In a move aimed at stabilising the regional energy market, AS Sahney, chairman, Indian Oil Corporation Limited, on Friday announced that the commercial LPG quota for Tamil Nadu has been increased to 70% of original levels with immediate effect.

Following a review of the State's fuel position, Sahney, who had also met with Chief Secretary N Sai Kumar at the Secretariat, said that the supply of petrol, diesel and aviation fuel remained "absolutely comfortable", with refineries operating at near-full capacity.

"Domestic LPG continues to be the top priority, with Oil Marketing Companies (OMCs) meeting 100% of TN's daily demand of around 5 lakh cylinders. While a waiting period of 6-8 days persists in some areas, efforts are under way to reduce delays. Essential sectors, including hospi-



itals and educational institutions, are receiving their full requirements without restrictions," he clarified.

Responding to reports of delays of over 20 days in parts of suburban Chennai, he said that a detailed review had been carried out and the situation would be normalised by Saturday evening. To check hoarding and irregularities, the State government has conducted more than 10,000 inspections, while OMCs have carried out over 1,500 surprise raids across

TN, leading to action against erring distributors.

Highlighting India's resilience amid an ongoing 40-day global conflict, Sahney said, "Crude oil sourcing has been diversified to 41 countries from 25 earlier, with LPG procurement also

expanded. The public must avoid panic buying, as adequate inventories are available." He added that the government's focus remains on ensuring availability, distribution and affordability, while promoting a gradual shift to piped natural gas as a cleaner and more economical alternative. Referring to global logistics, he noted that transit through key routes such as the Strait of Hormuz remains sensitive, but affirmed that energy security continues to be the priority.

# Why hasty delimitation, asks CPI

CHENNAI: CPI state secretary M Veerapandian on Friday criticised the Union government's move to push ahead with constituency delimitation, terming it "hasty and anti-democratic".

In a statement, he said that amid the ongoing five-state Assembly polls, the Union government was attempting to hastily introduce delimitation, which he described as undermining democratic principles.

He claimed that under the guise of constituency reorganisation, the Centre was attempting to weaken the voice of southern States in Parliament. According to him, the real intent is to increase the number of constituencies in northern states, where the BJP is electorally stronger, thereby helping the Union government retain power at the Centre. # Both diet and regular sodas are linked to liver disease, new study finds

Diet versions of beverages are often hailed as healthier than the sugar-sweetened original versions.

Research is ongoing regarding the potential dangers of sugar-sweetened and artificially sweetened drinks.

Recent study results identified a link between drinking higher amounts of sugar-sweetened beverages and low or non-sugar-sweetened beverages and an increased risk for metabolic dysfunction-associated steatotic liver disease (MASLD).

Metabolic dysfunction-associated steatotic liver disease (MASLD) Trusted Source involves a buildup of fat in the liver that did not result from drinking alcohol. People with this condition have a possible risk for more significant liver problems or other conditions like cardiovascular disease.

A recent study focused on how sugar-sweetened and low or non-sugar-sweetened beverages related to liver health. Based on analysis of over 103,000 participants, higher consumption of both beverage types was linked to a higher risk for MASLD.

Additionally, low or non-sugar-sweetened beverages were linked to a greater risk for liver-related mortality. While the study hasn't been published yet, the findings shed light on the potential risks of these beverages, particularly low or non-sugar-sweetened beverages. The study results were presented at UEG Week 2025, the annual congress of United European Gastroenterology. They are yet to appear in a peer-reviewed journal.

Drinking more than 1 can of

any soda daily linked to liver problems

This study was a prospective cohort study where researchers used data from the UK Biobank. Researchers examined data from 103,251 participants who did not have baseline liver disease. The median follow-up was a little over 10 years, and during this time "949 participants developed MASLD, and 103 died from liver-related causes."

Participants reported on their consumption of sugar-sweetened and low or non-sugar-sweetened beverages. Researchers were also able to consider participants' liver fat content based on MRI data. Researchers looked at the associations between drinking these beverages and someone's risk for MASLD. They also looked at liver-related mortality and liver-fat content and their association with the related beverages.

Consuming more than 330 grams (g), or about 1 can, of drinks from either beverage category daily was associated with a higher risk for developing MASLD. Sugar-sweetened beverages were associated with about a 50% greater risk for MASLD, and low or non-sugar-sweetened beverages were associated with 60% greater risk. The results also found that consuming either beverage type was linked to liver fat content.

At the same time, drinking low or non-sugar-sweetened beverages was associated with an increased risk for liver-related mortality, but sugar-sweetened beverages did not have a significant association. The researchers also found that the association between low or non-sugar-sweet-

ened beverages and liver-related mortality was dose-dependent; drinking more was linked to a higher risk. Swapping soda for water helps lower liver disease risk

When looking at substituting beverages, researchers found that switching out 330 g of either beverage type daily for water helped to decrease risk for MASLD.

The effect was a little larger when switching out sugar-sweetened beverages for water, which decreased MASLD risk by 14.7%.

Researchers found that switching out the beverage types for each other did not change the risk for MASLD. The findings highlight the potential danger of both beverages, but particularly low or non-sugar-sweetened beverages, on liver outcomes. Study author Lihe Liu, a graduate student in the Department of Gastroenterology at the First Affiliated Hospital of Soochow University in Suzhou, China, explained to Medical News Today that: The full study has not been published in a peer-reviewed journal yet, which makes it challenging to know the full limitations of the research. However, beverage intake was something reported by participants, which may not have been their true intake. The data also does not establish that consumption of these beverages causes liver problems. It's also unclear what covariates researchers adjusted for in their analyses. The UK Biobank is has its own limitations too, including the fact that it includes primarily white participants, and they tend to be healthier than the United Kingdom's general population. For this reason, additional follow-up research will be helpful.

# EDITORIAL

## Over 1 Lakh US Troops Are Stationed In Europe. What Happens If They Leave?

Wednesday was the day after the United States and Iran had agreed on a two-week ceasefire. Obviously, the pause in the West Asia war was going to dominate the press conference at the White House. During the press briefing, White House Press Secretary Karoline Leavitt dropped a bombshell. In response to a question, she casually revealed that President Donald Trump would be discussing the US's potential exit from the North Atlantic Treaty Organization (NATO) with Secretary General Mark Rutte later that day.

Trump has been angry over the fact that several European NATO members refused his call to support the US-Israeli military campaign against Iran. Only days earlier, he had signalled how far he was willing to go, saying America's membership was not "beyond reconsideration". Then came the meeting itself. Trump and Rutte spoke privately for nearly two hours, described afterwards as a blunt and tense exchange. If there had been hope that diplomacy might cool tempers, it faded quickly. Within minutes, Trump took to Truth Social and delivered a pointed message:

"NATO WASN'T THERE WHEN WE NEEDED THEM, AND THEY WON'T BE THERE IF WE NEED THEM AGAIN."

### The Leaked Messages

One could see it coming. Last year, in an accidentally leaked WhatsApp chat, Vice President JD Vance and War Secretary Pete Hegseth called the Europeans "free-loading". There is a strong feeling in the Trump administration that Europe has taken the US for a ride for far too long. "Yeah I think they've been free-loading," Trump had told reporters back then, when asked if he agreed with Hegseth, who was quoted as saying in the leaked Signal chats. A user identified as Vance had even said, "I just hate bailing Europe out again", and a user identified as Hegseth replied: "I fully share your loathing of European free-loading. It's PATHETIC." Will the US, however, really leave the 32-nation alliance? If America, its most powerful member, were to leave, defence experts in Europe believe the consequences would extend far beyond the continent.

### The Unmistakable Numbers

To understand the scale of such a move, it is important to begin with what the US currently provides to NATO. Around 1 lakh highly trained American troops are stationed across Europe. The US has air bases in Germany and Italy, naval facilities in Spain, intelligence hubs, logistics networks, missile defence systems and rapid response units across Europe. These forces are deeply integrated into NATO command structures and would be among the first to respond during a crisis. Needless to say, their presence acts as a deterrent in a big way, particularly against Russia. It is to be noted that the American role is not limited to troops. The US makes up the backbone of NATO's nuclear deterrence. It is no secret that American nuclear weapons are stationed in several European countries under NATO's nuclear-sharing arrangement. More important than the weapons is the guarantee behind them. The credibility of NATO rests on the assumption that the US would come to Europe's defence. If Washington were to withdraw, that assumption would certainly weaken. Even if treaties remained, the psychological impact would be immediate, because deterrence depends as much on perception as on capability.

## COMMERCIALIZATION OF FAITH: A Serious Question on VIP Darshan and Neglect of Common Devotees

In a country like India, where religion and faith are not merely a matter of personal belief but an integral part of social and cultural life, temples and pilgrimage sites have played a vital role. For centuries, these places have been considered symbols of equality, peace, and spiritual balance. "All are equal in God's court"—this statement is not just an ideal but a deeply held belief in Indian society. However, in recent years, this belief has been questioned. Many major temples and pilgrimage sites across the country charge hefty fees for VIP darshan, special pujas, abhishekam, and aarti. In exchange for these services, devotees are promised relief from long queues, reduced darshan time, and a more convenient experience. At first glance, this system appears to be an alternative, but when it impacts the experience of ordinary devotees, it becomes a serious social problem. Today, the situation is such that on one hand, there are those who, by paying extra money, can easily have darshan in a few minutes, while on the other, large numbers of ordinary people stand in queues for hours, sometimes even entire days. During this time, they face crowds, jostling, rude behavior, and sometimes even physical violence. This experience is not only



uncomfortable but also humiliating—especially when one has come there with faith and devotion. It's natural to question whether faith itself is becoming a "premium service"? Should there be discrimination based on economic status even for the sake of seeing God? This situation isn't limited to religious sites, but rather reflects the growing inequality in our society. From ration shops to gas cylinder lines, and now even temples—the middle class and common people often face chaos and struggle. The argument in favor of VIP culture is that it provides additional revenue to temples, which can be used to improve their facilities and services. This argument is somewhat valid. Large temples receive millions of devotees daily, making it difficult to manage them. Therefore, if some people pay an additional fee and demand special arrangements, the proceeds could be used for public amenities. But problems arise when this system becomes unbalanced. When VIP privileges

become so abundant that the resources and time available to ordinary devotees begin to fall short, it becomes a form of injustice. It has often been observed that general queues are blocked for VIP darshan, further prolonging the wait for ordinary people. This naturally leads to dissatisfaction and resentment. Furthermore, the behavior of temple staff and security personnel is also a significant issue. In many cases, ordinary devotees are treated rudely and disrespectfully, while VIPs are treated with extreme courtesy. This duality further deepens the existing class divide in society. This is also negatively impacting the very spirit of religious sites. Temples are not just places of worship, but also centers of mental peace and spiritual balance. When visitors encounter chaos, crowds, and discrimination, their spiritual experience is affected. This experience can leave them feeling disappointed and frustrated. The solution to this problem is not easy, but it is not impossi-

ble. First, temple administrations should ensure that the number and impact of VIP services are limited. These services should only be intended to provide additional convenience, not to curtail the rights of ordinary devotees. Second, modern technologies can be used for crowd management. Measures such as online booking, time slot systems, and digital queue management can better manage crowds, ensuring an orderly and respectful experience for all devotees. Third, staff and security personnel should be trained in sensitivity and courtesy. Every devotee, whether VIP or ordinary, deserves respect. This sentiment should be reflected not only in policies but also in practice. Fourth, the government and relevant trusts should establish clear guidelines on this issue. Ensuring equality and transparency at religious sites is not just an administrative responsibility, but also a moral one. Finally, it's also essential that society itself becomes aware of this issue.

## THE SKILLS THAT SUSTAIN US BEGIN LONG BEFORE SCHOOL



Much of the public conversation about education focuses on curriculum. We ask what children should know, how quickly they should learn it, and how systems can measure whether learning is happening at scale. These questions matter, especially in countries like India where millions of children are moving through education systems at the same time. But anyone who spends time observing young children knows that the foundations of learning are laid long before formal schooling takes shape. In the early years of life, children are forming the capacities that will guide them through everything that comes later. They are learning how to persist with a task that is difficult. They are discovering how to regulate frustration. They are learning how to trust others and how to work alongside them. These are often called "all-round skills," but they are simply the human abilities that allow us to navigate life with other people. What makes these skills difficult to build through policy alone is that they do not emerge primarily from instruction. They grow through repeated interactions with adults and with the environments children

inhabit. A small example illustrates the point. When an adult tells a child they will return in ten minutes and then actually does so, something meaningful is taking place. The child is not simply waiting. They are experiencing consistency. They are learning that the world has rhythms they can rely on. When this happens repeatedly, children begin to feel confident exploring beyond immediate reassurance. They try things that may not work the first time. They ask questions that may not have immediate answers. Over time, these interactions accumulate into something larger. Trust begins to form. Confidence grows. The child develops the emotional stability that allows learning to take root. In many ways this is the true work of early childhood. It happens through ordinary moments that rarely appear in assessment frameworks. A teacher noticing when a child is discouraged and encouraging them to try again. A caregiver responding to a question with patience rather than dismissal. A group of children solving a problem together without an adult stepping in immediately. These interactions shape the way children approach

the world. Some children come to see effort as something worthwhile because they have experienced encouragement when they tried. Others hesitate because earlier experiences have taught them that mistakes lead to correction rather than curiosity. The environments surrounding children are now shifting rapidly. Digital tools and intelligent systems are entering homes and classrooms with increasing speed. In many situations they offer real advantages. Teachers managing large classrooms can use them to organise information more efficiently. Programmes working across entire districts can identify patterns in learning that might otherwise take months to detect. Yet the deeper question remains whether these systems strengthen the conditions through which children develop the abilities that sustain them through life. Technology can organise information and reduce administrative burden. It can offer educators insights that help them plan better. But the core experiences through which children develop resilience, trust, and curiosity still emerge through human interaction. Children learn persistence

by encountering challenges that require effort. They learn empathy through relationships with other people. They develop problem-solving skills by trying things that do not always work immediately. These processes cannot be compressed without changing their nature. The challenge for education systems is therefore not whether to introduce technology, but how to ensure that technological systems support rather than replace the relational foundations of learning. This requires careful design choices. Systems that assist teachers rather than override their judgment. Tools that reduce administrative work so that educators can spend more time observing and responding to children. Platforms that encourage exploration rather than simply rewarding speed and correctness. If the goal of education is to prepare children for life, then the skills that sustain life must remain central to the environments we build. Long after the details of a curriculum fade, the habits children develop in the early years continue to shape how they face uncertainty, how they work with others, and how they approach the challenges ahead.

## WHAT MAY HAPPEN AT THE END OF THE 14-DAY CEASEFIRE

The two-week ceasefire between the United States and Iran, announced on April 7, 2026, has provided a temporary halt to what had become an accelerating cycle of escalation. US President Donald Trump framed it as a victory, claiming the US had met its military objectives and that a longer agreement was close to finalisation. Iran accepted the ceasefire on the condition that ships transiting the Strait of Hormuz would do so in coordination with its armed forces. Both sides had reasons to welcome an off-ramp. Neither side has fully stopped fighting. The ceasefire, as it stands, may be better understood as a pause rather than a settlement.

### • What Iran Wants From This Deal

After months of experiencing constant high-alerts, missile strikes, and assassinations, Iran's primary incentive for accepting a two-week pause for talks has been a promise of breathing space. Iran's agreement to the talks despite the temporary two-week window, countering the very first point of its 10-point proposal, only confirms this theory. In these two weeks, irrespective of the negotiation's outcome, Iran is looking to recover and regroup, in terms of military strength, public morale and broader political consolidation under the new leadership. However, hours after the ceasefire announcement, Israel has reportedly continued its strikes on Iran, as confirmed by Israeli military officials. These Israeli strikes may derail US-Iran negotiations, as proven twice in the past. The IRGC may not observe a political agreement that does not address the core condition of a ceasefire. These reported ceasefire violations are not marginal complications. They suggest this deal rests



on the assumption that US agreement ensures Israel's alignment. This assumption, however, might not hold true in reality.

### • The Hormuz Question

The ceasefire is conditional on Iran reopening the Strait of Hormuz. This can be considered the primary point in Iran's proposal that incentivised the US to accept it as a framework for negotiations. Iran has agreed to allow passage, but emphasised that this will be under the supervision of its armed forces. This is not a full return to pre-war conditions. Iran's parliament has already passed legislation

formally enshrining a toll system on Hormuz traffic. The IRGC has been operating a de facto vetting and fee arrangement since mid-March. The ceasefire does not appear to resolve either of these developments. Splitting this transit fee between Iran and Oman might also draw criticism from other Gulf nations like the UAE, Qatar and Saudi Arabia, which are key US allies in the region. The UAE has already expressed opposition, stating that the waterway cannot be held hostage by any single country and that free navigation must be part of any final settlement. Their exclusion from the

transit arrangements is likely to be a source of friction in the weeks ahead.

The broader stakes of Hormuz extend beyond the immediate conflict. Control and assured access to the sea lanes of communication has been a foundational pillar of US power projection for decades. Iran's ability to impose coordinated passage through the Strait represents a structural shift in the waterway's legal and strategic status. While the successful blockade has emerged as proof of Iran's dominance over the Strait of Hormuz at a military level, this transit fee is a step toward institutionalising control. Should that arrangement become codified through any longer-term agreement, the US may find itself under pressure to counter it, regardless of the diplomatic framing around the current pause.

### • The Gaza-Lebanon Problem

Within hours of the announcement, Israel's Prime Minister Benjamin Netanyahu made clear that the ceasefire did not include Lebanon. Israel's strikes against Hamas have also continued despite a ceasefire in early 2025. Pakistani mediators had urged all warring parties to observe a ceasefire everywhere, and Islamabad initially indicated that Lebanon was covered. Netanyahu and US Vice-President JD Vance have directly rejected that reading. In mid-March, Israel launched a ground invasion of southern Lebanon, and its forces have remained in active combat with Hezbollah ever since. Fighting between Israel and Hezbollah is, therefore, expected to continue regardless of what is agreed between Washington and Tehran. Despite mentioning it in their proposal as a symbolic gesture.

# Attack on Saudi pipeline wipes out 10 pc of oil export capacity, disrupts supply

According to the Saudi Press Agency, a strike on a pumping station along the strategic pipeline reduced throughput by around 700,000 barrels per day. The route has become a critical export lifeline, enabling crude shipments to bypass the constrained Strait of Hormuz. Regional tensions have escalated since the February 28 offensive by the United States (US) and Israel on Iran, which killed Supreme Leader Ali Khamenei and triggered a wider regional conflict, increasingly drawing energy infrastructure into the crossfire. The US and Iran agreed on Wednesday, April 8, to a two-week conditional ceasefire, with direct talks scheduled in Islamabad aimed at resolving differences and securing a lasting peace.

## ENERGY NETWORK TARGETED ACROSS REGIONS

Saudi officials said the attacks struck a broad range of facilities, including oil and gas production sites, transport networks, refineries, petrochemical plants and electricity infrastructure in Riyadh, the Eastern Province and Yanbu Industrial City.

Major refining facilities in Jubail, Ras Tanura, Yanbu and Riyadh sustained damage, directly affecting exports of refined petroleum products. Gas processing plants in Ju'aymah were also impacted by fires, disrupting shipments of liquefied petroleum gas and natural gas liquids.

The attacks resulted in the death of one Saudi national from industrial security personnel and injuries to seven others. Several facilities reported operational shutdowns, compounding the disruption across the energy sector.

## GLOBAL SUPPLY CONCERNS INTENSIFY

Saudi authorities warned that continued strikes could undermine supply security and slow recovery in global energy markets, contributing to increased volatility and inflationary pressure worldwide. The developments come as diplomatic efforts intensify ahead of expected talks in

Islamabad, even as uncertainty persists over maritime access and regional stability. With critical infrastructure under strain and export routes constrained, the scale of disruption is likely to keep global energy markets on edge in the coming weeks. The East-West Pipeline has a maximum capacity of about 7 million barrels per day, of which around 5 million bpd are available for export. Saudi Arabia, the world's top oil exporter, plays a central role in global crude markets. It has come under attack from hundreds of Iranian missiles and drones since the start of the U.S.-Israeli war on Iran, most of which were intercept-

ed, authorities have said. Below are some reactions from analysts and traders:

## SHOHRUH ZUKHRITDI-NOV, A DUBAI-BASED OIL TRADER:

"This is a logistics shock layered on top of a production shock. The market has lost its main work-around for the Strait of Hormuz."

## EDWARD MEIR, MAREX ANALYST:

"The oil market is quite tight, and although the Saudis have the benefit of exporting via their pipeline to the Red Sea the fact that this has also been impacted is somewhat surprising and even more bullish (to oil prices), as the thinking was that this transit point was experiencing fewer problems. The outage of Gulf exports also explains why physical prices are well above futures and have not dropped much of late."

## JOHN PAISIE, PRESIDENT OF STRATAS ADVISORS:

"The lost production and exports through the East-West Pipeline builds on the ongoing disruption of oil supply stemming from the effective closure of the Strait of Hormuz - and adds to the upward pressure on oil prices."

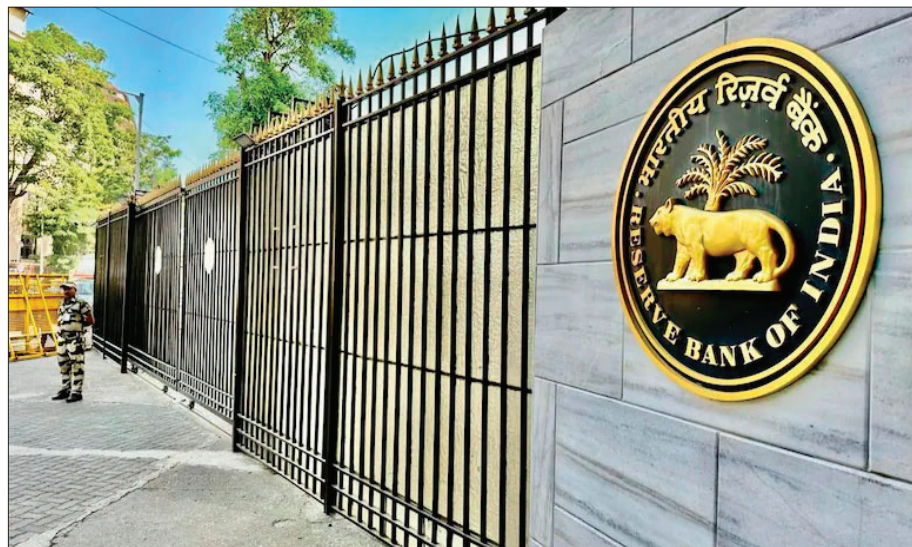

# RBI Proposes Rs 1 Lakh Crore Asset Threshold For Upper Layer NBFC Classification

The Reserve Bank of India (RBI) has proposed a major overhaul of the framework used to classify upper layer non-banking financial companies (NBFCs), introducing a Rs 1 lakh crore asset size threshold as the primary criterion for identification. Under the draft amendment to the Scale-Based Regulatory (SBR) framework, NBFCs with asset sizes of Rs 1 lakh crore and above would be categorised as upper layer (NBFC-UL) entities. This marks a shift from the existing two-pronged methodology that combined asset size and a parametric scoring system. The central bank has also proposed including government-owned NBFCs in the upper layer classification, aligning with its broader objective of maintaining an ownership-neutral regulatory regime. Currently, such entities are placed in the Base Layer or Middle Layer and are excluded from upper layer categorisation. Despite the proposed shift to a more transparent and absolute asset-based criterion, the RBI



said parametric scoring would continue to play a role in identifying systemically important NBFCs. The methodology assigns a 70% weightage to quantitative parameters and 30% to qualitative factors. Additionally, the top 50 NBFCs based on total exposure would automatically be considered for inclusion in the upper layer. In addition, Upper layer NBFCs will be identified periodically and Rs 1 lakh crore asset size threshold will be

reviewed every five years. As part of the regulatory tightening, NBFCs classified in the upper layer will be required to comply with enhanced prudential norms within a two-year transition period. This is aimed at strengthening risk management and ensuring financial stability in the sector. In another key proposal, the RBI has allowed upper layer NBFCs to use state government guarantees as a credit risk transfer instrument without any cap, sub-

ject to specified conditions. This move is expected to improve credit flow while maintaining safeguards. The RBI has invited feedback from NBFCs, stakeholders, and the public on the draft amendment directions until May 4, 2026. The proposed changes are part of the regulator's ongoing efforts to simplify classification norms, enhance transparency, and better align regulatory oversight with the scale and systemic importance of large NBFCs.

# White House staff told not to place bets on prediction markets

White House staff were warned last month not to use insider information to place bets on predictions markets. The email was sent to staff on 24 March, a day after US President Donald Trump announced a five-day pause on his threat to attack Iranian power plants and energy infrastructure. It referred to press reports that raised concerns over government officials using non-public information to place bets on platforms like Kalshi or Polymarket. White House spokesman Davis Ingle told the BBC that "any implication that Administration officials are engaged in such activity without evidence is baseless and irresponsible reporting." The Wall Street Journal first reported the email on Thursday. Ingle also said that all federal employees are subject to government ethics guidelines that prohibit the use of insider information for financial gain. "The only special interest that will ever guide President Trump is the best interest of the



American people," he added. The BBC has contacted Kalshi and Polymarket for comment. Polymarket came under scrutiny in January after a gambler made nearly half a million dollars on the capture of Venezuelan president Nicolás Maduro just before it was officially announced. It was unclear who placed the bet. The anonymous account had a blockchain

identifier of letters and numbers. The incident raised concerns about whether they had benefited from inside information of the US military operation. Predictions markets, which host more than \$44bn (£33bn) in trades, have become increasingly popular in the past year. The predictions can be related to anything. They mostly involve sports but users can

also place bets on whether, for instance, the US central bank will cut rates or the results of local elections. Prediction market bets on conflicts have fuelled debate over how industry should be regulated. This week, US Congressman Ritchie Torres, a Democrat who sits on the House Financial Services Committee, sent a letter to the Commodity Futures Trading Commission that called for an investigation into "suspicious" trades. The commission regulates the derivatives trading, which includes prediction markets. In March, Democrat leaders introduced legislation that would completely ban prediction market betting related to war or military action. "Corruption and exploitation are thriving right now within the gaps and loopholes of prediction markets," said US Senator Andy Kim from New Jersey. "This manipulation leaves the select few winning big, at the expense of working Americans," he said.

# Eli Lilly's Market Share Stumbles As Generic Weight-Loss Drugs Gain Ground In India

Weight loss drug manufacturer Eli Lilly's market share in India declined in March, while rival drugmaker Novo Nordisk's share remained steady. The slip came after patent for a key ingredient in these weight loss drugs, such as semaglutide, expired earlier in the month, and the pharma market got flooded with cheaper generic Indian substitutes. The market share fell from 61% in February to 56% in March, CNBC reported, citing data from industry intelligence provider Pharmarack. The data pointed out that Novo Nordisk's market share held steady at 25%. The shift to generic and more affordable alternatives was expected to impact sales of Novo Nordisk and Eli Lilly both, but early data has revealed that the latter has taken the bigger hit. A further erosion is expected in sales of Eli Lilly's more expensive tirzepatide-based brands as the presence of cheaper weight loss drugs grows, according to experts. Within a matter of weeks, the



Pharmarack report noted that 13 Indian generic drug companies have collectively launched 26 brands of semaglutide, which is prescribed for both weight loss and diabetes management. India's 100 million diabetics and 125 million pre-diabetics make for a huge market for such drugs. The starting price of Eli Lilly's Mounjaro is around 13,800 rupees (\$148) per month, Mumbai-based diabetologist Rajiv Kovil told CNBC. He pointed out that, it is twice the price for Novo's semaglutide drugs and 10 times more than the cheapest

of the generic versions. A long list of pharma giants, including Dr Reddy's Laboratories Ltd., Sun Pharmaceutical Industries Ltd., Biocon Ltd. and Lupin Ltd., are in the frontline for providing generic substitutes. Patent Expiry Recap For years, the 'miracle' weight-loss drug semaglutide — an engine behind global blockbuster Ozempic — was a luxury reserved for the few who could stomach a Rs 20,000 monthly bill. On March 20, 2026, things changed when patent for Semaglutide officially expired in India.

# India's resilient macros and strong domestic liquidity cushion geopolitical shocks for now, but confluence of global risks could turn the tide: PL Asset Management

Mumbai, April 10, 2026: According to PL Asset Management, the asset management arm of PL Capital Group (Prabhudas Lillardher), while global markets reacted sharply to disruptions in energy supply and shifting monetary policy expectations, Indian equities showed relative stability, underpinned by strong domestic macroeconomic fundamentals, robust liquidity conditions, and continued institutional participation. It highlights that resilient macro and supportive domestic liquidity has cushioned India against any geopolitical headwinds. However, PL Asset Management warns that India's macro picture could turn adverse as a confluence of risks — rising crude prices, a weaker rupee, slower global growth, disrupted logistics chains, and tighter global financial conditions — could together widen the fiscal deficit, slow GDP growth, and erode the macro tailwinds currently supporting market confidence. The firm notes that this scenario



demands vigilance, not complacency. Escalating geopolitical tensions, particularly US-Israel strikes on Iran in late February, have raised concerns around potential disruptions in the Strait of Hormuz—a critical artery handling nearly 20% of global oil supply—thereby heightening risks to India's current account and inflation trajectory through elevated crude prices. PL Asset Management highlights that India's growth momentum continues to remain robust, with Q3 GDP expanding by 7.8% and full-year FY26 growth projected at 7.6%, supported by healthy private

consumption growth of 8.7% and a sharp 13.3% expansion in manufacturing. It expects the India-US tariff reduction, the progress on the India-EU FTA, and the government's ₹12.2 lakh crore infrastructure push under Budget 2026 to boost export competitiveness, unlock new growth avenues, and accelerate the domestic capex cycle, reinforcing India's medium-term growth outlook. On inflation, PL Asset Management notes that it remains comfortably within the RBI's tolerance band, providing policymakers with room to manoeuvre. In fixed income markets, bond

yields have edged higher, with the 10-year G-Sec hovering around 6.70%, largely influenced by global yield movements and elevated supply expectations. Importantly, it notes that the recent market corrections have created a more favorable valuation backdrop, with the Nifty trading at a 5.6% discount to its five-year average PE, enhancing the medium-term risk-reward for investors. FIIs recorded net outflows of ₹6,640 crore, strong countervailing inflows from DIIs to the tune of ₹38,423 crore, along with sustained SIP participation, have helped anchor equity markets. Mr. Siddharth Vora, Head - Quant Investment Strategies & Fund Manager, PL Asset Management said, "The global environment is transitioning into a high-uncertainty, liquidity-constrained regime, driven by geopolitical risks and persistent energy disruptions. Elevated crude prices are expected to keep inflation sticky and interest rates higher for longer, creating pressure on

earnings, fiscal balances, and currency stability, with the rupee remaining vulnerable. While valuations may appear reasonable on the surface, rising input, energy, and financing costs pose a meaningful risk to earnings, increasing the likelihood of valuation compression. Market sentiment remains fragile, with flows and liquidity conditions playing a critical role in near-term direction. As a result, markets are likely to remain event-driven and volatile, reacting sharply to developments in geopolitics and energy prices. In this environment, disciplined risk management and selective positioning become essential. A preference for large caps, along with factors such as value, quality, and low volatility, is likely to be more resilient. Sectorally, metals, energy, pharma, industrials, autos, and PSU financials appear relatively better placed, supported by domestic and cyclical drivers. Gold continues to serve as an important hedge in portfolios.

# Trump says Iran's handling of Strait of Hormuz is 'not the agreement we have'

US President Donald Trump has accused Iran of doing a "very poor job" in its handling of oil passing through the pivotal Strait of Hormuz, arguing it was "not the agreement we have". The comments reflect the fragile nature of the ceasefire agreement, with reports showing conflicts on what was included in the accord. It came as Israeli Prime Minister Benjamin Netanyahu said his government was to begin direct talks with Lebanon, focusing on the disarmament of Hezbollah, the Iran-backed militant group, and establishing peaceful relations. A US State Department official confirmed it would host a meeting next week in Washington "to discuss ongoing ceasefire negotiations with Israel and Lebanon". Lebanese officials had called for a ceasefire before the talks begin, but Netanyahu said in a subsequent address to residents of northern Israel: "There is no ceasefire



in Lebanon." After Israeli strikes continued in Lebanon throughout Thursday - targeting what it described as Hezbollah rocket launch sites in the south - attacks appeared to at least temporarily taper off overnight in the region. Trump said in an interview that Israel would be "scaling back" its strikes in the country to support peace talks. "I spoke with Bibi and he's going to

low-key it. I just think we have to be sort of a little more low-key," Trump told NBC News after a phone call with Netanyahu. The strikes on Thursday led to new evacuation warnings for residents in the southern suburbs of the capital, Beirut. The head of the World Health Organization (WHO), Tedros Adhanom Ghebreyesus, said on X that this included the Jnah area, which includes

two major hospitals. "At this time, no alternative medical facilities are available to receive approximately 450 patients from the two hospitals (including 40 patients in the ICU), rendering their evacuation operationally unfeasible," he said. Among those being treated at the hospitals, Tedros added, were some of the 1,150 people that Lebanon's health ministry said were wounded in

Wednesday's massive wave of Israeli strikes. At least 303 people were killed. Tedros also said that the headquarters of the Ministry of Public Health, which "hosts five shelters accommodating more than 5,000 people", is in the evacuation area. That ceasefire began with confusion over whether Lebanon, Israel's second front, was to be included. Iranian officials and mediators from Pakistan said it was, US and Israeli officials said clearly that it was not. Amid the confusion, the wave of Israeli strikes on Lebanon - the heaviest since the conflict began six weeks ago - prompted Iran to declare that Israel was breaking the terms of the ceasefire, to once again halt passage of shipping through the Strait of Hormuz, and to threaten retaliatory strikes. Trump posted to Truth Social over ship traffic through the pivotal waterway, which typically sees 20% of the world's oil and liquefied natural gas

(LNG) passing through. "There are reports that Iran is charging fees to tankers going through the Hormuz Strait," he wrote. "They better not be and, if they are, they better stop now." Israel's military continues to occupy a large part of the south of Lebanon, where it has destroyed villages in recent days. Without a commitment to a temporary ceasefire at least, it is not clear how productive talks could proceed between the two sides. It is also unclear how much sway the Lebanese government, with which the Israelis will be negotiating, will have over Hezbollah, which despite having representation in the Lebanese government is a separate entity backed by Iran. The Lebanese government banned Hezbollah's military activities in early March, days after the start of war with Israel, but it has not stopped the group from carrying out military operations.

## GERMAN TRANSGENDER FAR-RIGHT EXTREMIST ARRESTED IN CZECH REPUBLIC



A convicted German transgender right-wing extremist, who has been on the run for months, has been arrested in the Czech Republic. Liebich was arrested on the basis of a European arrest warrant in Krásná in the east of the country, some 100km (62 miles) east of the capital, Prague. In August 2025, Marla-Svenja Liebich, formerly known as Sven, failed to appear at the prison in the German town of Chemnitz, where she was to serve an 18-month jail term. German media reports say Liebich used to be a member of a neo-Nazi group called Blood and Honour. In July

2023, Liebich was sentenced by the Halle District Court in Saxon-Anhalt to a total of one year and six months in prison without parole for extreme right incitement to hatred, defamation, and insult. Liebich appealed against the sentence and lost. At the time she was known as Sven Liebich. A spokesperson for the Halle public prosecutor's office told the BBC that Liebich was now in custody in the Czech Republic. Liebich is expected to be extradited to Germany. At the end of 2024, Liebich had her gender entry in official records changed from male to female.

## TAIWAN OPPOSITION LEADER MEETS XI JINPING IN BEIJING



China's President Xi Jinping received Taiwan's main opposition party leader on Friday, in a rare meeting which saw both sides stress a desire for cross-strait peace. Cheng Li-wun is the Kuomintang's (KMT) first sitting leader to visit China in a decade. In 2016, Beijing cut off high-level communications with Taiwan after the ruling Democratic Progressive Party's (DPP) Tsai Ing-wen became president, citing her refusal to endorse the concept of a single Chinese nation. The DPP is among those who have criticised Cheng's trip, accusing her of being "subservient" to Beijing. Beijing claims Taiwan as part of its territory and has not ruled out taking the self-governed island by force. "The leaders of our two parties are meeting today in order to safeguard the peace and stability of our shared homeland, to promote the peaceful development of cross-strait relations, and to allow future generations to share in a bright and beautiful future," said Xi in a meeting at China's Great Hall of the People on Friday. He added that China was willing to strengthen exchange and

dialogue together with various parties, including the KMT - though it would have to be on the condition of opposing Taiwan independence. Xi also reiterated that those on both sides of the Taiwan Strait are Chinese, and that they all wanted peace. In response, Cheng said the "rejuvenation of the Chinese people is a shared aspiration of the people on both sides of the Strait". She added that it would be a "positive contribution to world peace and human progress". In a press conference after her closed-door meeting with Xi, Cheng said young people of every generation had to understand that opposing Taiwan independence and maintaining the 1992 Consensus was a way to "avoid war, prevent tragedy, work together and create peace." ## Hip-hop pioneer, Afrika Bambaataa, dies aged 68

Afrika Bambaataa, one of the founding figures of hip-hop culture, has died at the age of 68, the Hip Hop Alliance has confirmed. In a statement, the organisation said Bambaataa helped shape a "global movement rooted in peace, unity, love, and having fun", paying tribute to his role in the emergence of hip-hop as both a musical genre and a cultural force. Born Lance Taylor in the Bronx, Bambaataa grew up during the era of the black liberation movement. In 1973, he co-founded the Universal Zulu Nation, an international hip-hop awareness group. In his later years, Bambaataa's reputation was overshadowed by allegations of child sexual abuse and trafficking, which he denied. TMZ, which was first to report his



death, said the artist died in Pennsylvania due to complications from cancer on Thursday. Bambaataa was born to Jamaican and Barbadian immigrant parents. As a teen, he became a member of the Black Spades gang, parlaying his leadership abilities to form the Universal Zulu Nation, that sought to channel youth culture away from violence and towards creativity.

## Ceasefire or no ceasefire, the Middle East's reshuffling is not yet done

The best hope for the ceasefire talks in Pakistan is that both the United States and Iran have strong reasons to call a halt to the war. The biggest obstacle to their success is a total absence of trust, no discernible common ground and the fact that Israel, America's full partner in the war, has hugely escalated its onslaught on Lebanon. US President Donald Trump is already speaking about the war in the past tense. He has declared victory and needs an exit. Not only does he have a state visit from King Charles in the diary for later this month, followed by a summit with China's President Xi Jinping in May, there are midterm elections in November. With America's summer



holiday season looming, Trump also needs petrol prices to fall back to where they were before he went to war. Royal visits, summits and elections do not mix well with wars. Iran's regime has its own reasons to end the war. It is as defiant as ever, still able to

launch missiles and drones, with its social media warriors pouring out AI videos lampooning Donald Trump. But Iran has suffered massive damage. Cities have come to an economic standstill and the regime needs time to regroup and will try to use the talks in Pakistan

to strengthen its position. The Pakistani intermediaries who will be shuttling between the two delegations have a tough job on their hands. The declared positions of the two sides are as far apart as it is possible to be. Trump has a 15-point plan that has not been published but leaked versions make it sound more like a surrender document than a basis for negotiation. Iran's 10-point plan contains a list of demands that America has consistently rejected in the past. Creating a more durable ceasefire will require some kind of agreement to at least keep talking about the two sides' contradictory lists of intractable issues. It would be hard enough to work through them in peacetime.

her remarks were put on its daily schedule. The president told news outlet MS Now he did not know about his wife's statement ahead of time. Meanwhile, the New York Times quoted a spokesperson for Melania Trump as saying the president knew that the first lady

planned to make a statement, but later said it was unclear if he was aware of the topic of the remarks. Melania Trump said she had not been a victim of Epstein, with whom she only briefly "crossed paths" in 2000. "I have never had any knowledge of Epstein abuse of his victims," she said. "I was never involved in any capacity. I was not a participant." She also denied knowing Ghislaine Maxwell, the disgraced financier's jailed associate. She referred to a 2002 email between her and Maxwell released in the Epstein files, calling it nothing more than "casual correspondence" and a "polite reply".

## US has let in 4,499 refugees since October - all but three were South African



President Donald Trump's overhaul of US refugee policies has created a major shift in the number and nationalities of people admitted to the country, US government data shows. Since October 2025, 4,499 refugees were resettled in the US, according to the Refugee Processing Center. All, except three from Afghanistan, were South African. In the last full fiscal year of the Biden administration, which started in October 2023, 125,000 people were accepted from 85 countries. Last year, Trump halted all refugee admissions, including for applicants from warzones, but allowed Afrikaners, a white minority group he said was persecuted, to seek resettlement. South Africa objected to his characterisation. In announcing the change, Trump said it would help strengthen national security and public safety. Priority was to be given to Afrikaner South Africans and "other victims of illegal or unjust discrimination in their respective homelands", according to an announcement. The president "has explained why we are resettling Afrikaner refugees in the United

States", a state department spokesperson told the BBC when asked about the latest resettlement figures. "The US position on this humanitarian initiative has not changed." Diplomatic tensions between Washington and Pretoria have been rising since Trump returned to the White House. Just over a year ago, South Africa's ambassador in the US, Ebrahim Rasool, was expelled after accusing Trump of "mobilising a supremacism" and trying to "project white victimhood as a dog whistle". Then, in the Oval Office in May, Trump confronted his South African counterpart, Cyril Ramaphosa, where he claimed that white farmers in South Africa were targets of persecution and "genocide". Ramaphosa tried to refute Trump's assertions and was backed up by John Steenhuisen, the white leader of the Democratic Alliance, which is part of the coalition government. "Certainly, the majority of South Africa's commercial and smallholder farmers really do want to stay in South Africa and make it work," Steenhuisen told Trump.

## Dutch police urge victims of 'international sextortion campaign' to come forward

Dutch police have issued a social media plea for victims of an alleged "international sextortion campaign" to come forward, warning that dozens of women and girls were coerced into degrading sexual acts on camera. Investigators say a 22-year-old Dutch man, posing online as a teenage girl, contacted victims on popular platforms and persuaded them to send explicit photos. Once he had the images, he allegedly blackmailed them into creating increasingly graphic, extreme and sadistic photos and videos - including performing sex acts on themselves and licking

toilet seats - under threat of sharing the photos with friends, family or classmates. Prosecutors say the suspect, identified only as Damian A. under Dutch privacy laws, has confessed. He was arrested in January 2025 and went on trial this week in the city of Dordrecht. He is charged with online sexual assault and online rape. Prosecutors have requested a nine-year prison sentence plus psychological treatment. "I didn't think about the consequences. That you can hurt people," Dutch media reports quote him as saying. A verdict is expected in the coming weeks.

# BRONNY JAMES SETS UP FATHER LEBRON IN LAKERS WIN

Bronny James passed to parent LeBron for the first son-to-father assist in NBA history as the Los Angeles Lakers beat the Golden State Warriors 119-103. Bronny, 19, stole possession and passed to LeBron, who ran the length of the court for an uncontested dunk that was part of a 26-point contribution from the 41-year-old. The pair recorded the first father-to-son assist in a match against the Brooklyn Nets last month. LeBron also added 11 assists while Bronny scored 10 points with three assists as the Lakers saw off their state rivals. The Lakers sit fourth in the Western Conference while the Warriors are in 10th, with both having already qualified for the post-season play-offs that begin on 18 April. Elsewhere, the New York Knicks won 112-106 against the Boston Celtics, with Josh Hart scoring 26 points, to put pressure on their opponents

in the Eastern Conference. The sides are third and second respectively in the standings, with two matches left to play in the regular season. # Stojsavljevic, 17, wins as GB take charge in BJK Cup

Teenager Mika Stojsavljevic stunned Talia Gibson, ranked more than 200 places above her, in straight sets as Great Britain took a 2-0 lead over Australia in the Billie Jean King Cup. The world number 275, making her debut in the competition, defeated Gibson, 56th in the WTA rankings, 7-6 (7-4) 7-5 in the opening singles match in Melbourne. Harriet Dart, ranked 173rd in the world, then fought back from a set down to beat Kimberly Birrell 4-6 6-3 6-3 in a little under two and a half hours. A doubles and two reverse singles follow on Saturday, with Great Britain only needing to win one match to advance to the eight-team finals in Shenzhen, China, in September. The losers face a play-off in November. Stojsavljevic, 17, is the second-lowest ranked player in a Great Britain team missing Emma Raducanu, Sonay Kartal, Katie Boulter, and Fran Jones - all of whom



are ranked inside the world's top 100 for singles. But the 2024 US Open junior champion, described by Great Britain captain Anne Keothavong as "not your average 17-year-old", was unfazed by her underdog status and the Australian crowd, holding her nerve to clinch the first set in a tie-break after letting a 3-1 lead slip. She later saved five break points in the penultimate game of the match before converting her first match point. "It feels amazing. I can't believe it. I can't even remember the last point,"

Stojsavljevic said. "I had amazing support from the side and managed to get through. "Going into it, I knew she'd have the home ground. I'm grateful to the people supporting GB today. "It was a good match. We have very similar games, both quite aggressive, so I'm happy I got through it." Keothavong added: "She's not your average 17-year-old. For some, it can be overwhelming, but I think for Mika, she's really taken it into her stride. I also have to credit her team-mates.

# Lucknow Super Giants Bring In South African All-Rounder To Replace Rs 2 Crore Star

Lucknow Super Giants (LSG) have signed Protea all-rounder George Linde as a replacement for Wanindu Hasaranga, who has been ruled out of the Indian Premier League (IPL) 2026. Hasaranga was signed by LSG for INR 2 crore at the auction but has been sidelined due to a hamstring injury he sustained in Sri Lanka's opening game of the ICC Men's T20 World Cup 2026. Linde, a left-handed batting all-rounder who bowls slow left-arm orthodox, has represented South Africa in 3 Tests, 4 ODIs and 37 T20Is. In T20Is, Linde has scored 403 runs and picked up 35 wickets. He brings extensive experience in the



shortest format, having played 250 T20 matches. This will be his maiden stint in the IPL. He will join LSG at his reserve price of INR 1 crore. "We are preparing for the fact that he isn't going to be able to join us. We are

looking at replacements, that should be announced in 24-48 hours," LSG's Director of Cricket Tom Moody had said during the game at the Eden Gardens on Thursday, which LSG won by three wickets on the last ball.

His recent T20 game came in the bilateral series against New Zealand last month, where he picked up only one wicket in four innings. Linde, 34, was in the Proteas squad for the Men's T20 World Cup and has also been part of franchise leagues such as SA20, the Hundred, Major League Cricket, and the PSL. In all, he has taken 218 wickets in 250 T20s at an economy rate of 7.42. He now joins the Rishabh Pant-led side at his base price of Rs 1 crore. LSG will next face Gujarat Titans (GT) at their home ground BRSABV Ekana Cricket Stadium in Lucknow on Sunday afternoon.

# Pakistan Selector Misbah Ul Haq Defends Working With PSL Franchise Amid Controversy

The Pakistan Cricket Board's policy of allowing its employees to work with franchises in the Pakistan Super League has come under scrutiny after former captain Misbah ul Haq confirmed he was involved with Peshawar Zalmi as consultant. The PCB at the start of the PSL had stopped Sarfaraz Ahmed and Wahab Riaz from working with the Quetta Gladiators franchise. The board said under its policy former players who were on the PCB payroll were not allowed to work in the PSL in any capacity as it was a conflict of interest. But Misbah defended his involvement with Peshawar Zalmi despite being a paid national selector and batting consultant with the PCB. "I had signed a contract with Zalmi before I became national selector and I only work for them as consultant on given days in a season," Misbah told the media wearing the Peshawar Zalmi kit. Asked how he got permission from the PCB to work in the PSL when Sarfaraz who was with him on the selection committee and Wahab were stopped from working with Quetta Gladiators, Misbah said his case was different and the PCB



can best explain this. Misbah who has also remained the national team's head coach and chief selector and has been in and out of the PCB in some capacity since 2019 said as a national selector it was helpful for him to work closely in the PSL and watch the young players in action. "When you watch and observe them up close and see how they react to a particular situation it becomes easier for you to take decisions as a national selector," he said.

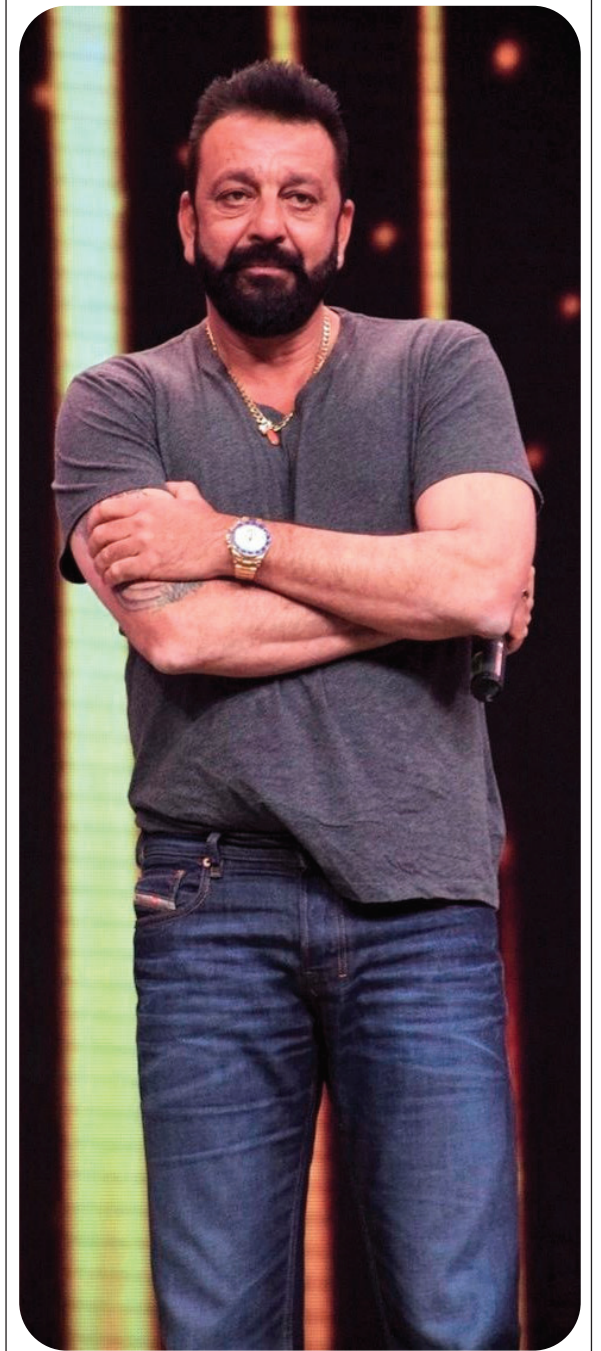

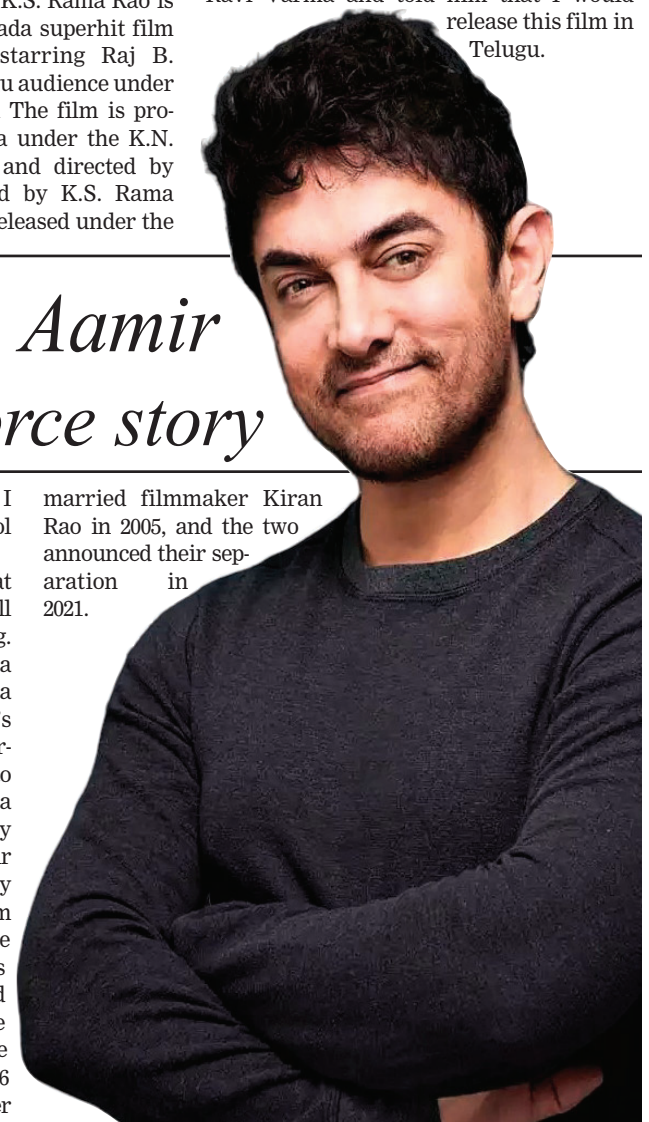
