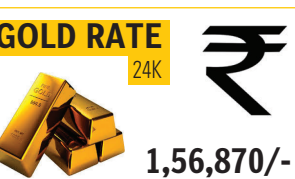
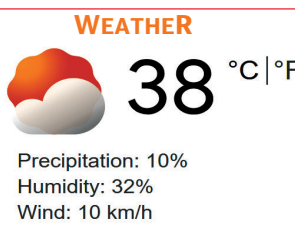
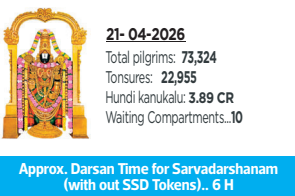

BJP SEEKS EC ACTION AGAINST KHARGE OVER 'TERRORIST' REMARK ON PM MODI

New Delhi (TSIT): A Bharatiya Janata Party (BJP) delegation led by Union Finance Minister Nirmala Sitharaman on Wednesday approached the Election Commission of India (EC), seeking strict action against Congress minister Mallikarjun Kharge over his "terrorist" remark targeting Prime Minister Narendra Modi. The delegation, which also included Union Ministers Kiren Rijiju and Arjun Ram Meghwal, along with BJP national general secretary Arun Singh, submitted a complaint to the poll panel, terming the remark "outrageous" and "an insult to the democratic mandate". Addressing reporters after meeting the full Election Commission, Sitharaman said Kharge's statement was condemnable and unacceptable, particularly when made in an election-bound state like Tamil Nadu.

MOBILE PHONES BANNED IN BIHAR SCHOOLS DURING CLASS HOURS

Madhubani (TSIT): District Magistrate Anand Sharma has announced a ban on the use of mobile phones during class hours in Madhubani district, warning that violators will face action under provisions of the Bharatiya Nagarik Suraksha Sanhita. The directive comes amid a viral video showing the 2013-batch IAS officer instructing teachers to refrain from using mobile phones during school hours and to focus on teaching. The announcement was made during a 'Census Festival' organised by the district administration on Tuesday, aimed at achieving "100 per cent self-enumeration" in the district, which shares a border with Nepal. Addressing school authorities, Sharma said, "It is essential that teachers devote class hours to imparting education and shun the use of mobile phones." He further stated that Section 163 has been imposed across the district, and any use of mobile phones during class hours would be treated as a violation of the order.

Bengal CM Mamata put democracy in peril, says SC

criticises her for 'interference' in ED raids on I-PAC

New Delhi (TSIT)

On the eve of the first phase of polling in West Bengal, Chief Minister Mamata Banerjee on Wednesday came in for scathing criticism from the Supreme Court which made strong remarks against her for alleged interference in the Enforcement Directorate's raids against political consultancy firm I-PAC in Kolkata in January this year.

While hearing petitions filed by the ED and its officers, a Bench of Justice PK Mishra and Justice NV Anjaria said that constitutional stalwarts such as BR Ambedkar would not have conceived of such a situation created by her acts that put the democracy in peril. "This is not a dispute between the State and the Union. A Chief Minister of any State cannot walk in the midst of an investigation, put the democracy in peril, and then say... don't convert this into a dispute between the State and the Union. This is per se an act committed by an individual who happens to be the Chief Minister putting the whole democracy in jeopardy," the Bench said.



The top court's comments came after senior counsel Menaka Guruswamy questioned the maintainability of the ED's petitions and sought to emphasise that a petition under Article 32 couldn't have been filed.

As senior lawyer Siddharth Luthra said the ED and its officers should have gone to a magistrate, the Bench said it can't ignore the ground situation in West Bengal.

Referring to the case where several judicial officers were held hostage, the Bench said, "And you say the petitioner should have gone to a magistrate under Section 200! We cannot shut our eyes to the reality of what's happening (in West Bengal). We cannot lose sight of the practical situation which is present in the state."

Remember human impact in every decision: Bhatti to Group-1 officers

Deputy Chief Minister Mallu Bhatti Vikramarka urged newly recruited Group-1 officers to remember the human impact behind every administrative decision, stating that governance must be rooted in empathy and integrity.

Addressing the valedictory session of the six-week Group-1 Foundation Course (Batch-II) at the MCRHRD Institute of Telangana, the Deputy CM said, "Every file you sign carries the hopes of a common citizen. It is not just paper—it has the power to change someone's life."

Speaking to 214 officers who completed their training, he emphasized that while intelligence helps in clearing competitive exams, it is discretion and integrity that truly define an officer in the field. "Your decision is the face of the government to the citizen. More than intellect, purity of intent matters," he said.

He advised officers not to lose sight of people in the rush of files and reviews, noting that farmers' assistance, student scholarships, and patients'



well-being often depend on timely administrative decisions. He stressed that governance should be both lawful and humane.

Highlighting the importance of empathy, he remarked that systems may continue, but it is the compassion shown by individuals that brings real change. He encouraged officers to use modern technologies like

Artificial Intelligence and data analytics in governance, while reminding them that technology can never replace human sensitivity. The Deputy CM also called upon officers to play a key role in implementing flagship programmes such as Indira Mahila Shakti and to ensure inclusive growth reaches every section of society. He underlined that resisting pres-

sure and upholding ethical values would strengthen public trust in governance. "Integrity is your true identity. When faced with temptations or pressures, your judgment becomes your shield," he said.

Reaffirming the government's vision, he stated that the leadership under Chief Minister A. Revanth Reddy is committed to using power as a tool to transform lives and build confidence among citizens. He noted that investments in education, health-care, and infrastructure are aimed at strengthening human resources, which he described as the State's greatest asset.

He further said Telangana aims to become a \$3 trillion economy by 2047 through sustained development and global competitiveness.

Congratulating the officers, he urged them to give back to the State that shaped their journey and contribute to making Telangana a leading state in the country. Rs.5,400 cr renew energy mega-project set for Rambilli; CM NAIDU TO LAY FOUNDATION ON THURSDAY

Amaravati (TSIT)

Anakapalli district is poised to add another jewel to its industrial crown. Days after the foundation ceremony of the ArcelorMittal steel plant, the region is now gearing up for a massive renewable energy project that promises to put North Andhra firmly on the global clean energy map. Leading clean energy firm ReNew Energy Global will establish a large-scale energy plant in Rambilli with a total investment of Rs.5,400 crore. Chief Minister N. Chandrababu Naidu will lay the foundation stone on Thursday, marking a major step in the coalition government's push to make Andhra Pradesh a renewable energy hub.

The project includes a 6 GW solar ingot-wafer manufacturing unit (Rs.4,200 crore) and a 125 MW hybrid captive renewable power project (Rs.1,200 crore). Both are expected to be completed within two years and will generate employment for around 2,100 people, giving a significant boost to local youth. ReNew Energy Global, which already operates 19.2 GW of

clean energy projects nationwide, had announced phased investments worth Rs.82,000 crore in Andhra Pradesh during the CII Partnership Summit in Visakhapatnam last November. As part of that roadmap, another mega hybrid renewable project with an investment of nearly Rs.22,000 crore is being planned in Anantapur district.

Since the coalition government took office, North Andhra has seen a surge in industrial activity. Major firms like ArcelorMittal and Cognizant have begun construction, TCS has started operations, and a major Google investment is expected to break ground this month. With the Bhogapuram International Airport nearing completion, the region is rapidly emerging as a hub for software, energy, steel, med-tech, and pharmaceuticals.

Chief Minister Naidu will depart Amaravati at 9:30 AM, reach Rambilli at 11:10 AM for the ceremony, and return to Amaravati by 2:35 PM.

Trump extends US-Iran ceasefire; Iranian forces fire on 3 ships in Strait of Hormuz

WASHINGTON (TSIT):

US President Donald Trump extended the ceasefire with Iran indefinitely at the request of Pakistan to give Tehran's leadership more time to prepare a unified proposal to end the war, even as Iranian forces fired on three ships and seized two of them in the Strait of Hormuz on Wednesday. Trump's dramatic announcement, welcomed by Pakistan's top leadership, came just hours before the two-week ceasefire was set to expire.

Iran's semi-official Tasnim news agency reported that Tehran has not issued any official statement confirming its agreement to extend the ceasefire. Pakistan had urged an extension of the truce due to uncertainty surrounding the second round of talks. There was still no clarity on the date of the



next round of talks. On Wednesday, The New York Post quoted President Trump as saying that the second round of the US-Iran talks could take place as early as Friday. Such development was "possible" within the next 36 to 72 hours, the paper reported, quoting Trump. However, Iranian Foreign Ministry spokesman Esmail Bagaei said Tehran has not yet decided whether to attend a new round of Pakistani-mediated talks in Islamabad. "We have made it clear that if we conclude that going to Islamabad is in our national interest.

INDIA CAN GROW ABOVE 7 PC EVEN IF CRUDE OIL COSTS USD 90-100/BARREL: ASSOCHAM

NEW DELHI (TSIT): The Indian economy, largely driven by consumption, has the potential to grow over 7 per cent annually even if crude oil costs USD 90-100 per barrel, industry body Assocham said on Wednesday. India's resilience to high energy costs has increased significantly over the years, as the country has absorbed severe oil shocks while growth has remained strong, it said. Based on its analysis, the industry body said that India has demonstrated its ability to manage high energy prices without compromising its economic growth trajectory.

Kolkata/Murshidabad, April 22 (TSIT)

Armoured vehicles rumble along rural roads and Central Armed Police forces patrol through bazaars. Checkpoints dot the highways, where cars and busses are stopped and searched for cash or liquor meant to influence voters. A day before Bengal heads for a crucial election, and the unprecedented deployment by the Election Commission is supposed to curb possible political clashes and "vote buying." However, the "war zone movie set" scenario, belies the fact that the real battle for Bengal's ballot box may not be unfolding on these roads at all. It is being fought, more quietly but no less consequentially, in tribunals tasked with determining who has the right to vote in the forthcoming elections, and by implication who is an Indian.

Some 91 lakh people had their names removed from voter rolls, through an exercise called the Special Intensive Revision (SIR) of electoral rolls. Out of these 91 lakh, some 27 lakh had their names struck off after being placed under adjudication by an Artificial Intelligence generated filter which felt their entry had "logical discrepancies".

Deletions based on "logical discrepancy" could be on as flimsy a ground as why a son's surname is spelled differently from his father's, such as Rai and Ray, Chhattopadhyaya (Sanskritised surname for Brahmins from the Chattal region) and Chatterjee (Anglicised version of Chattopadhyay).

For Bengali Muslims, most of whom have no fixed surname, this has meant whole villages have been left out of the voter list. The deletions have impacted minorities, women and the poor the most say researchers work-

ing with the data officially available.

The border districts of Malda, Murshidabad, North and South 24 Parganas, with huge Muslim and Dalit populations have been hit the hardest, with the number of deleted names ranging from 2.2 lakh (South 24 Parganas) to 4.6 lakh (Murshidabad).

However, the "privileged class" too have been hit by the role purification drive, often inexplicably. In Joka, where the appellate tribunal set up by the Supreme Court is sited to adjudicate cases arising from the mass deletions, the most famous building is that of India's first Ivy League management school - the Indian Institute of Management, Calcutta.

Nandita Roy who teaches at Joka's IIM, has discovered to her horror that her name is among those struck off. "I have given all the documents needed for what I assumed was a clerical error... but I still don't find my name on the voter's list," the 39-year-old IIM professor told UNI. "I am from a privileged background, an academic, my father is a retired Air Force officer, and I am facing this... imagine the plight of poor, semi-educated people who have to struggle with the bureaucracy to get back their voting rights," said Roy.

She is not alone among the 'privileged set' to have lost their right to vote with a question mark placed on their Indian citizenship. Scores of people who belong to the family of the last Nawab of Murshidabad find themselves stripped of their right to vote.

"What crimes have we committed that our names have been struck off the voter list," asked 82-year-old Syed Reza Ali Mirza, also known as 'Chota Nawab', a descendant of the Nawabs of Bengal who were turned pensioners by the British 'East India Company' in the 18th century.

Famously, while the Nawabs of Dhaka traditionally supported the demand for creation of a separate Pakistan, the Murshidabad Nawab family had favoured being part of India.

The TMC, which was facing an anti-incumbency wave in Malda and Murshidabad, has actually benefited because of Muslim vote consolidation rallying around the "known devil," even though the Congress and a Muslim party will probably manage to win a few seats this time round.

However, a reverse vote consolidation among Hindus who feel threatened by the rising Muslim population is unlikely given the way SIR has affected the scheduled

castes. Bengal's more than 2.53 million strong Matua community, many of whom come from the scheduled caste, have seen huge numbers of deletions and are up in arms against the SIR.

"We have already held protests and are waiting for the election to end and then we will decide our future course of action," said Dileep Matua, Secretary of the Matua Samaj, who says his village in South 24 Parganas alone has had 200 names deleted. Those who have shifted to Bengal for work have similarly faced deletion by a bureaucratic machinery that refuses to accept the paperwork they have provided. Mohd Shamim Akhtar who shifted from Madhubani in Bihar to teach at the Alia University on the outskirts of Kolkata, and had voted in the previous elections starting with 206, has produced "every possible document that I have including my passport" but finds his name excluded. "The Citizenship Act does not empower the Election Commission to determine questions of citizenship. Yet, in practice, Chief Election Commissioner appears to have steered the electoral machinery toward scrutinizing it," charged Jawhar Sircar, former IAS officer who resigned as an MP of the upper house protesting against TMC's policies.

note issued on Wednesday, the Principal, Prof. K. Ashoka Reddy, stated that Dr. Bondala Venu Maheswar Rao submitted

his doctoral thesis titled "Signal Processing Methods for PPG Signal Enhancement and Analysis." He carried out his research under the supervision of Dr. K. Ashoka Reddy, Professor, Department of ECE and Principal, KITS Warangal. His research work focused on the development of an effective motion artifact suppression framework using wavelet transform and adaptive filtering techniques, eliminating

the need for additional motion sensors. He also designed an ensemble-based machine learning and deep learning model for accurate estimation of respiratory rate and blood oxygen saturation from PPG signals. In addition, he developed a hybrid deep learning-based model for obesity forecasting. His work has been published in reputed international journals and conferences.

Don't cut CCTV nos in districts: Opposition to Election Commission

CHENNAI: The AIADMK has urged the Election Commission to prevent any reduction in the number of CCTV cameras at polling booths, warning that it could compromise free and fair elections.

In a petition to Chief Electoral Officer Archana Patnaik, AIADMK MP M Inbadurai flagged alleged attempts in certain districts to scale down the number of cameras originally approved for installation.

He noted that CCTV surveillance is mandated in all polling stations to ensure transparency and curb malpractices, but reports suggest efforts are underway



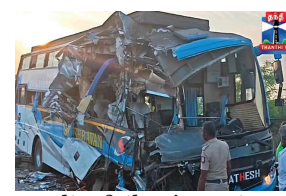
in some areas to reduce coverage.

Any such move, he cautioned, could lead to violations including booth capturing, bogus voting and other irregularities, directly affecting the integrity of the electoral process.

Inbadurai sought immediate intervention to ensure that all approved cameras are installed without exception and that their numbers are not reduced under any circumstances. He also called for intensified monitoring measures, including strict inspections, to safeguard the sanctity of elections in the state.

20 injured as omni bus crashes into cement mixer lorry in Kovilpatti

CHENNAI: Around 20 people were seriously injured after a private omni bus met with an accident near Kovilpatti in Thoothukudi district on Wednesday (April 22), according to Thanthi TV. The bus, which was travelling from Coimbatore to Nagercoil, collided with a cement mixer lorry. As a



result of the impact, 20 passengers sustained serious injuries in the accident. Further details are awaited. Meanwhile, in a

separate incident in Krishnagiri district, three people were killed after a car collided with an omni bus in the early hours of Wednesday (April 22) while they were travelling from Bengaluru to Pennagaram to cast their votes. One person survived with serious injuries.

Officials travel 160 km to ensure 12 votes at remote booth in Kodayar

NAGERCOIL: For just 12 voters living in a remote hill settlement, election officials travelled 160 km with voting machines to set up a polling station at Mel Kothaiyar in Padmanabhapuram Assembly constituency. 2026 TN elections | Poll gifts seized from godown linked to AIADMK candidate

The voters — employees of a power station and their families — reside in quarters in Mel Kothaiyar, an area without direct road access from nearby Keel Kothaiyar due to hilly terrain. Transport between the two locations is limited to a winch system operated by power station staff.

To conduct polling, a 14-member team comprising election officials, polling personnel and three police personnel left the Thiruvattar taluk office at around 12 pm on April 22. They carried voting machines, including reserve units to handle any technical issues. The team was flagged off by Padmanabhapuram Assembly constituency election officer and sub-collector Vinay Kumar Meena. They travelled via Thuckalay, Nagercoil, Panagudi, Kalakkad, Ambasamudram, Kallidaikurichi, Manimuthar and Manjolai before reaching the polling



station, set up at a recreation centre in the settlement.

Braving hills and odds, EC pushes limits to reach every last voter

Mel Kothaiyar is the first polling station in the constituency. Though geographically close to Keel Kothaiyar, the lack of road connectivity means access is only via a long road route. Officials undertook the journey in line with the Election Commission's emphasis on the importance of every vote, ensuring that all registered voters in the remote location could cast their votes.

NCW takes cognisance of 'horrific gang rape' of minor girl in Tamil Nadu, seeks police report

CHENNAI: The National Commission for Women on Wednesday took suo motu cognisance of the "horrific gang rape" of a minor girl in Tamil Nadu's Tiruvannamalai district, and sought a detailed action taken report from police in 5 days. The commission said the "brutal assault on a 15-year-old girl in Cheyyar has raised grave concerns about the safety and security of young girls" and highlighted the urgent need for stronger preventive and protective mechanisms against such heinous crimes. "The Commission has strongly condemned this barbaric act, stating that violence against minor girls is a gross violation of human rights and leaves deep physical, emotional, and psychological scars on the survivor. Such incidents demand immediate accountability and the strictest legal action," the NCW said in a post on the social media platform 'X'. The commission chairperson Vijaya Rahatkar has directed the Tamil Nadu DGP to ensure prompt registration of FIR under the Bharatiya Nyaya Sanhita and POCSO Act, and immediately arrest all the accused, initiate a fair and time-bound investigation, and facilitate comprehensive medical, counselling, rehabilitation, and protection support for the survivor and her family.

What to eat and drink before and after a flu shot: Expert Q&A

All international and national health organizations, including the Centers for Disease Control and Prevention (CDC) Trusted Source, agree that it is important to get vaccinated against the flu on a yearly basis, typically in the autumn and winter season, to prevent not just getting ill due to infection with the influenza virus, but also potential serious complications that may arise from getting the flu. Flu shots are both safe and effective, but some people may still worry about potential side effects. The most common side effects are mild and do not last very long, and they can include low grade fever, headache, muscle aches, and nausea. These side effects are expected, and they are often a sign that the vaccine is working — it is teaching the body's immune system to fight the influenza virus, which can result in these mild and temporary inflammatory responses.

Other people might worry about feeling faint during vaccination — this can be due to anxiety around needles or about vaccines. So what can you do to prevent or mitigate these reactions during and after a flu shot? What you eat and drink before getting the vaccine could help your body go through this experience more smoothly. To get some expert tips on how to keep your flu shot experiences positive with the help of healthy dietary choices, Medical News Today spoke to Michelle Routhenstein, MS, RD, CDCES, CDN, a preventive cardiology dietitian at EntirelyNourished, and to Elena Rolt, MSc, DipION, IFMCP, rCNHC, nutritional thera-

pist at Health.Miro, and ebneM Ünlüler, MSc, genetic engineer and Chief Longevity Officer at the London Regenerative Institute in the United Kingdom. For those worried about becoming dizzy and feeling faint during or immediately after a flu shot, Routhenstein recommended hydrating well and eating light, whole foods.

"To help prevent dizziness or lightheadedness, stay well-hydrated and eat a light, balanced snack before a flu shot," she advised. "As a genetic engineer, I often look at how nutrition can support our immune system at a cellular level, particularly around vaccination. While food and drink cannot change the efficacy of the flu jab itself, certain choices may help the body respond more smoothly and ease common side effects," Ünlüler clarified. She also emphasized the importance of stabilizing blood sugar levels before getting vaccinated, "particularly for those who may feel lightheaded or anxious about needles." Like Routhenstein, Ünlüler recommended a protein- and complex carb-rich snack pre-flu jab, suggesting yogurt with oats or wholegrain toast. She also cautioned that "even mild dehydration can increase feelings of dizziness," recommending drinking "water or an electrolyte-rich drink [as] a simple preventive measure." "What should you eat after a flu shot, and why? Rolt told us that when it comes to what to eat and drink after a flu shot, it is important to have a balanced meal filled with an array of nutrients. "After receiving a flu vaccine, the immune system initiates an inflammatory response to process the vaccine antigens.

EDITORIAL

When The Snack Becomes The Story

On the TV on April 19, the image arrived the way certain smells do in a city- unexpected, vivid, briefly undeniable. While barnstorming in West Bengal, Prime Minister Narendra Modi at a public stall in Jhargram, Purulia, eating jhalmuri: puffed rice crackling with spice, roadside heat, during the summer scorcher, meeting the language of the everyday. Ten rupees, the story insisted.

Ten rupees, maximum impact

Ten rupees for a bowl of pleasure that looked like it had been made not for cameras, but for hunger. Yet the true magic of such moments is that they don't feel manufactured. They pretend not to be politics at all. They borrow the rhythms of street life: chit chat at the dhaba with the young owner. Insisting that the owner take the money. Talk about eating onions or not. "Pyaz khata hun, dimaag Nahin" (I eat onions, nor brains), said PM Modi. The spontaneous laughter and mirth that doesn't quite match the choreography of a tight election campaign schedule, the hands that reach out in a way that suggests, Here - let me be part of this Bengali common folk tradition.

A symbolic gesture of proximity with the aam aadmi In Bengal, where public space is never just public space, but a stage for identity, the symbolism lands with extra weight. A man is judged not only by what he says, but by what he is willing to be seen doing. The point was not merely culinary. It was symbolic-almost liturgical-an enacted gesture of proximity with the aam aadmi. PM Modi's unique political grammar: The body as witness

There is, in PM Modi's political grammar, a long-running theme: the body as witness. One week, he is meditating in the Rudra Gufa near the Kedarnath Temple in May 2019, located at 12,250 feet, offering a tranquil view of the Kedarnath Temple. Another week, May 14, 2024, another place: PM Modi offers prayers at the Kal Bhairav temple in Varanasi. PM Modi visits to seek blessings from the "Kotwal of Kashi" (guardian deity of Varanasi) before filing his election nomination. Previously, on December 13, 2021, PM Modi had again prayed in the Kal Bhairav temple before inaugurating the Kashi Vishwanath Corridor.

Yet another week, on April 6, 2025, PM Modi offered prayers at the Ramanathaswamy Temple in Rameswaram, Tamil Nadu. During this visit, he also inaugurated the new Pamban rail bridge. He also visited the same temple on January 20, 2024, ahead of the Ayodhya Pran Pratishtha ceremony. The temple is a sacred site associated with Lord Ram and is one of the Char Dham and 12 Jyotirlingas. Eat, pray, meditate: Three styles, same impulse Varanasi, Uttarakhand, Rameswaram - PM Modi meditates, prays in places that confer a certain spiritual weather on whoever enters them. Then comes another season of the same doctrine, now expressed as street realism: eat where others eat; meet where others meet. Three styles, same impulse-an effort to collapse the distance between leader and led. In earlier eras, proximity was achieved through speeches and promises; in this era, proximity is performed through images that look spontaneous. Social media did what it always does with such performances: it translated them into fellowship. The views multiplied into something like a digital bonfire, millions gathering around an act that, in any other context, would have been ordinary. But in politics, ordinariness is the rarest currency.

The moral math of the Jhalmuri stall

The Jhalmuri stall scene offered a kind of moral math: if he can lower himself to the street, perhaps the street will rise for him. If he eats the same spicy, noisy snack, perhaps he will also share the same fate.

Mamata Banerjee critiques it as "drama"

His opponents have tried to puncture the spell. The West Bengal Chief Minister called it "drama," suggesting secret cameras, a set of invisible eyes making the whole thing feel staged. The accusation has a familiar shape: if you planned it, then it isn't real. And this is the problem with symbolic politics-its critics must either accept its image as political labour, or reject it as deception. But here the question becomes less "Is it genuine?" and more "What does it feel like to the viewer?" Political meaning is often an emotion with a caption. In sharp contrast, Mamata Banerjee's stopover at a public tea stall at Kolkata's Collin Street on April 21, during her election campaign, appeared strained. Mamata Banerjee, sitting on her plastic chair, surrounded by her party leaders, appeared tense and, in fact, looked positively worried. There was no banter with the tea stall owner, no chit-chat, no mirth, no laughter.

Parallel with Trump's McDonald's moment

There is also a broader pattern, one that transcends party lines. In the American campaign imagination, Donald Trump's story of working and eating for a day at a McDonald's became a kind of parable-an act of solidarity with white working-class MAGA supporters. It was less about hamburgers than about dignity: the insistence that a president should be able to stand in the same light as the people who wipe tables. Whether one agrees with Trump's politics is almost irrelevant beside the mechanism: the image signalled belonging and respectability at once. PM Modi in Jhargram invokes a Bengali sensory memory Bengal, for all its worldliness, has always been sensitive to this mechanism. A leader seen as too distant becomes suspect; a leader seen as touching the everyday becomes intimate. Bengal loves cleverness, but it also loves the performance of simplicity, especially when simplicity carries an unmistakable scent of Bengali life. Jhalmuri isn't just food; it is sound and texture: the crackle of puffed rice, the tang, the street-side abundance, the spice that clings. It is the kind of snack that carries a regional intimacy. By eating it in Jhargram, PM Modi is not simply imitating folk culture; he is invoking a Bengali sensory memory and claiming it as a shared one. Will Jhalmuri snack fetch votes for the BJP in Bengal?

Still, the question is a million-dollar one: will such tricks fetch votes in Bengal for the BJP? Here, the answer must be split into two layers: the magnet and the machine.

How A War Destroyed America's Strongest Financial Weapon, Built Over 50 Years

In 1977, Danish chess grandmaster Bent Larsen was asked whether he preferred to be lucky or good. "Both," he replied. Kenneth Rogoff, in his recent book, *Our Dollar, Your Problem*, deploys this anecdote to make a point about the American dollar that Americans rarely acknowledge - that the dollar's extraordinary post-war dominance was the product of skill and luck in roughly equal measure. Had Russia liberalised its economy in the mid-1960s, had Japan not been browbeaten into a destabilising currency appreciation in the mid-1980s, had China floated its exchange rate in the 2010s, the dollar would still be on top, but less so. Interest rates would have been higher. The exorbitant privilege would have been less exorbitant.

The title of Rogoff's book comes from a remark by Nixon's Treasury Secretary, John Connally, to his foreign counterparts in the early 1970s: "It's our dollar, but your problem." For obvious reasons, the statement was the epitome of American arrogance. It also described, precisely, how the system worked. America issues the currency. The rest of the world absorbs the consequences.

The Saudi Deal

In 1974, Henry Kissinger struck one of the most consequential financial deals in modern history. Saudi Arabia would price its oil in dollars and park the surpluses in US Treasuries. America would provide security guarantees. The rest of the Gulf Cooperation Council followed. As recently as 2023, JP



Morgan Chase estimated that roughly 80% of global oil transactions were still settled in dollars.

The elegance of the petrodollar system lay in its circularity. Oil importers paid in dollars. Those dollars flowed to Riyadh and Abu Dhabi. From there, they flowed back into American government debt. This structural demand for Treasuries subsidised Washington's borrowing costs for fifty years and cemented the dollar as the world's reserve currency. It also handed Washington an extraordinary weapon: by controlling SWIFT, the messaging infrastructure connecting banks worldwide, the US could freeze a country out of the international economy almost overnight. This happened to Iran starting 2012, and to Russia in 2022. The Russian sanctions were,

in retrospect, a turning point, though not the kind Washington intended. The United States demonstrated to every other government on earth that dollar reserves were not savings by simply freezing approximately \$300 billion in Russian central bank assets. They were hostages. Much had changed before the first American strikes on Iran this February. The shale revolution had made the United States energy-independent, which meant Saudi Arabia was now selling four times as much oil to China as to its American security guarantor. Eighty-five percent of Middle East crude flows to Asia. The foundational premise of the 1974 deal (that America was the indispensable customer) had quietly expired. More concretely, Saudi Arabia had joined Project mBridge, a

blockchain-based platform developed with the People's Bank of China, the Hong Kong Monetary Authority, and the central banks of Thailand and the UAE. It allows settlement in central bank digital currencies without touching SWIFT or dollar-correspondent banking. Deutsche Bank's research team, writing in March 2026, noted with some precision that mBridge is already at "minimum viable stage". The rails to transact outside the dollar system have been built. They were not yet busy, but they were ready.

The War As Catalyst

The US-Israel war on Iran has cost the United States roughly \$12 billion a week. It has also broken the petrodollar loop at both ends simultaneously. On the importing side, central banks in

Turkey, India, Thailand, and other oil-importing nations have been selling US Treasuries to defend their currencies against an oil-driven dollar surge. Holdings at the Federal Reserve Bank of New York dropped approximately \$82 billion to \$2.7 trillion, the lowest level since 2012. The 10-year Treasury yield rose from 3.9% at end-February to above 4.4% within weeks. In every major crisis of the past two decades - the Russia-Ukraine war, the Silicon Valley Bank collapse, the Hamas attacks of October 2023 - money had flooded into Treasuries, not out. This time, yields rose. The safe-haven playbook has failed.

On the exporting side, Gulf producers cut output by at least 10 million barrels per day in March. Qatar declared force majeure on LNG exports after strikes on its

Ras Laffan facility. Kuwait, Saudi Arabia, and the UAE collectively held approximately \$300 billion in Treasuries as of January. They are now earning less, spending heavily on defence, and examining force majeure clauses in their investment commitments to Washington. There are no surpluses to recycle when there is no oil to ship. For the first time since 1996, global central banks hold more gold in aggregate than US government bonds.

Into this vacuum, Iran has inserted a toll booth. Ships transiting the Strait of Hormuz are being charged approximately \$2 million per vessel, denominated in Chinese yuan. Lloyd's List confirmed it. China's Ministry of Commerce acknowledged it in a social media post. Iran's embassy in Zimbabwe declared the era of the "petroyuan" had arrived. (One notes the choice of venue for this announcement with some curiosity.) The larger point still remains relevant despite Iran agreeing to open the Strait of Hormuz for commercial traffic for the rest of the ceasefire.

Right Answers, Wrong Questions

The sceptics deserve a hearing. Diana Choyleva of Enodo Economics argues in the Wall Street Journal that the war has actually reinforced the petrodollar: the Gulf states backed Washington, the security guarantee was tested and held, and China's years of patient infrastructure-building have been disrupted. Dan Alamaris of Alpine Macro calls the petroyuan "far-fetched".

When compliments aren't received, it leads to anxiety, self-doubt, and a faltering self-esteem. This is the moment when a girl, who could have been strong and self-reliant from

within, becomes dependent on external reactions. This dependence leads to mental exhaustion and depression, but ironically, it's all hidden behind a smiling face. What you see on social media isn't the whole truth. Everyone here only shows the best parts of their lives. No one posts pictures of their loneliness, no one shares their fears or failures. So when you see someone always happy, in love, or successful, it's important to understand that that's not the whole story. It's just a chosen frame, with the rest of the truth deliberately cut out. The biggest danger is that this virtual comparison makes you underestimate yourself. You think you're not as beautiful, not as happy, not as successful. The truth is, you're complete in your own right. Your simplicity, your thinking, your nature—all of these make you unique. But when you try to be like someone else, you weaken your own identity. In today's world, "trend" has become the new religion. Whatever's trending is considered right. But not every trend is meant for you. Sometimes, these trends take a toll on your health, your self-esteem, and your peace of mind. Strange beauty standards, unnatural lifestyles, and a habit of showing off—all of these slowly lead you in a direction where you drift away from your true self. It's also true that social media has opened up new avenues for expression. But when this expression turns into comparison and competition, it loses its positivity. When every post becomes a performance, every photo a message saying "I'm happy," it's no longer natural life, but an act. And constantly acting is exhausting. The most important thing in this entire scenario is to connect with yourself. Understanding that your true worth isn't determined by likes and comments. Your identity is bigger than any trend or filter.

DIGITAL MEMORIES AND THE RIGHT TO BE FORGOTTEN

The clash between privacy and transparency in the digital world

The "right to be forgotten" (RTBF) has become one of the most complex and multifaceted legal-ethical debates of today's digital age. The expansion of the internet and digital technology has made information permanent, accessible, and global, making it permanent, and once published, it remains online for a long time, continuously impacting a person's life. In such a scenario, RTBF grants individuals the right to demand the removal, or at least the limitation of the visibility, of outdated, irrelevant, misleading, or harmful information. This right becomes particularly important in situations where information about a person's past is negatively impacting their current life, employment, social standing, and mental state. At first glance, this right appears essential to protect human dignity, privacy, and self-respect, but when it conflicts with freedom of the press and the public's "right to know," it creates a serious constitutional and ethical dilemma that is difficult to resolve. The concept of RTBF gained global traction in 2014 with the famous EU case "Google Spain," where the Court ruled that search engines may, under certain circumstances, remove information from their search results that is no longer relevant or unnecessarily infringes on an individual's privacy. This decision opened a new chapter in the field of digital rights and resulted in the legal recognition of the right to erasure in Article 17 of the General Data Protection Regulation (GDPR). However, the European model made it clear that this right is not absolute and must be balanced with important exceptions such as freedom of expression, public interest, historical records, and scientific research. Thus, RTBF was developed as a conditional right that seeks to strike a

balance between individual privacy and the broader interests of society. While no clear and dedicated legal framework for RTBF has yet been developed in India, its foundation can be traced to the right to privacy enshrined in Article 21 of the Constitution, which was recognized as a fundamental right by the Supreme Court in the landmark 2017 Puttaswamy judgment. Furthermore, the Digital Personal Data Protection Act, 2023 (DPDP Act) provides a limited right to data erasure, but it remains inadequate in providing clear guidelines for matters related to media reports, public records, and journalism. The Information Technology Rules, 2021, also provide a framework for grievance redressal, but they are unable to effectively handle this complex balance. As a result, judicial decisions on the application of RTBF in India are inconsistent and ambiguous, underscoring the need for a coherent policy. The concept of "informational self-determination" is crucial to understanding the conflict between RTBF and freedom of the press. This principle grants individuals the right to control their personal data, digital identity, and online presence. This right becomes even more relevant today, when a person's online image impacts their professional opportunities, social relationships, and personal life. For example, if a person was once charged with a crime but was later acquitted by a court, old news reports available on the internet can still negatively impact their lives. In such cases, RTBF can serve as a means of providing a "second chance," allowing them to move forward in the present, free from the shadows of their past. On the other hand, freedom of the press, enshrined in Article 19(1)(a) of the Constitution, is a fundamental pillar of democracy. It embodies not only the right to expression but also the public's "right to know." The role of the media is not only to provide information but also to monitor power, expose corruption, and ensure transparency in public life. If RTBF is widely used to suppress news reports, investigative journalism, or information of public interest, it could seriously undermine democratic accountability. This could become a dangerous trend for society, especially if influential individuals or public officials use this right to suppress inconvenient information related to their past. In recent years, gag orders have

been issued in the name of RTBF in some judicial cases, preventing the media from publishing or disseminating specific information. These orders often take the form of "prior restraints," which are preventive restrictions on freedom of expression and are considered highly questionable from a constitutional perspective. The problem is further exacerbated when such orders are passed unilaterally, without hearing the media or other stakeholders. This also raises questions about the transparency and impartiality of the judicial process. While in some cases, courts have ruled in favor of acquitted individuals and ordered the removal of old information, in other cases, such orders have been overturned, prioritizing press freedom. These contradictory decisions have made it clear that a consistent and clear legal framework on this subject is urgently needed in India. The potential for misuse of RTBF is also not insignificant. Influential individuals, politicians, or those involved in economic crimes could use this right to "cleanse" their past and control public memory. Furthermore, lawsuits such as Strategic Lawsuits Against Public Participation (SLAPP) could become a means of exerting legal pressure on journalists and media outlets, preventing them from reporting on sensitive issues. Furthermore, there is the risk of the "Streisand effect," where attempts to suppress information only lead to greater publicity, further complicating the situation. Considering all these challenges, it is essential that India develop a well-thought-out statutory balancing test that strikes the right balance between RTBF and press freedom. This test should include key elements such as the nature of the information—whether it is purely private or clearly related to public interest; the role of the individual involved—whether they are a private citizen or a person engaged in public life; the status of the case—whether it is merely the accusation stage or a final verdict has been reached; and an assessment of actual harm—whether the availability of the information is causing concrete and proven harm to the individual. Furthermore, the principle of "least restrictive alternative" should be adopted, whereby information can first be revised, contextualized, or simply removed from search results, rather than removed entirely.

Trump buys time for Iran deal after frantic day of diplomacy

Tuesday began as a frantic day of diplomacy in Washington, with Air Force Two ready to fly Vice President JD Vance to Islamabad for another round of peace talks between the US and Iran. Several hours later, Air Force Two hadn't taken off and the negotiations were postponed. President Donald Trump announced that he would extend the ceasefire with Iran, set to expire on Wednesday evening, to allow the regime more time to create a "unified proposal" to end the war. In between, Trump weighed his options as the world waited to see if the countries were any closer to ending the war. Trump's decision marked the second time in as many weeks that he has backed off a threat to escalate the war, buying himself more time to wind down a conflict as it approaches the two-month mark. Vance never officially announced the Islamabad trip, leaving Washington guessing. And Iran never officially committed to attending the talks, leaving the White House in the difficult position of deciding whether or not to send Vance with no assurance that Tehran would even come to the table. As the day



were on, signs of a postponement emerged. Special envoy Steve Witkoff and Trump's son-in-law Jared Kushner, senior members of the US negotiating team led by Vance, flew to Washington from Miami instead of heading straight to Islamabad. Soon after, Vance made his way to the White House for "policy meetings" as the president and his senior advisers debated what to do next. In the end, Trump announced the ceasefire extension on Truth Social, his preferred means for war updates since it began in late February. The president said he made

the decision at the request of Pakistan, which has mediated talks between Tehran and Washington. "We have been asked to hold our Attack on the Country of Iran until such time as their leaders and representatives can come up with a unified proposal," Trump said. Notably, Trump this time did not specify how long the ceasefire might last. Earlier this month, he set a two-week deadline for the first ceasefire. That came after conflicting comments in press interviews, during which he said the talks were going well but also warned that he would

consider resuming the war if Iran refused to negotiate. "There is no clear formula" for ending wars, James Jeffrey, a former US ambassador to Iraq and Turkey, told the BBC. Trump isn't the first US president to "threaten significant military escalation," Jeffrey added, "while also putting a good deal on the table." Trump's open-ended statement on Tuesday was more measured than his past social media attacks on Iran. That may signal Trump's desire to end a war that has roiled the global economy and is unpopular with anti-interventionist

supporters in Trump's MAGA base. "This is a pragmatic decision based on what are quite obvious fractures in the current leadership of the Iranian government," said Brian Katulis, a senior fellow at the Middle East Institute. But Katulis said Trump's decision also created more uncertainty about how long the war will last. "This move begs the question though for Trump about how he can deal with the economic pain that Americans are experiencing and the political pain he's experiencing from his base," Katulis said. "He hasn't answered the questions that are still driving this crisis." With the ceasefire extension, the US and Iran now have more time to make a durable peace deal. But major questions remain. Iran has said that the US blockade of the Strait of Hormuz is an act of war. While Trump chose not to restart the war immediately, he gave no indication he would end the blockade, which the US hoped would pressure Tehran to back down. So far that hasn't happened, leaving Trump with fewer options other than ramping up the military campaign.

META TO TRACK WORKERS' CLICKS AND KEYSTROKES TO TRAIN AI

Meta will start tracking the way employees work, including their keystrokes and mouse clicks, to train its artificial intelligence (AI) models. The company, which owns Instagram and Facebook, told workers on Tuesday that a new tool will run on Meta's computers and internal apps, logging their activity to be used as training data for AI technology. A Meta spokesman told the BBC: "If we're building agents to help people complete everyday tasks using computers, our models need real examples of how people actually use them." "The data is not used for any other purpose," he said, adding that the tool has "safeguards in place to protect sensitive content". But one Meta employee, who asked not to be identified, said having their smallest actions on a computer being used to train AI model as workers expect a slew of additional job cuts feels "very dystopian". "This company has become obsessed with AI," they told the BBC. Another per-



son who recently left the company said the tracking tool is "just the latest way they're shoving AI down everyone's throat". Meta has already laid off around 2,000 employees this year in smaller rounds of cuts, but employees have been expecting deeper job losses in the coming months, as the BBC previously reported. Last month, the company enacted a partial hiring freeze which now appears to be more far-reaching. A website that Meta uses to advertise all of its jobs hosted about 800 listings in March. Now, it is advertis-

ing just seven jobs. Meta's spokesman declined to comment on the company's removal of job listings or plans for cuts. Meta's new tracking tool is called Model Capability Initiative or MCI, according to Reuters which first reported the move. The BBC has been told that an employee's activity on a Meta computer would have been accessible to the company before, however tracking and logging specifically for the purpose of training and improving AI tools is new. Mark Zuckerberg, Meta's co-founder and chief executive, recently pledged to

ramp up spending on AI projects this year and is attempting to position the firm at the forefront of the technology. Meta plans to spend roughly \$140bn on AI in 2026, almost double the amount it invested in the technology a year ago. In 2025, it took over nearly half of Scale AI with a \$14bn (£10.3bn) investment, and brought some executives of the data-labeling firm into Meta to help it build out its AI models and tools. The first significant launch from the company's reformed Meta Superintelligence Labs group emerged last month with the AI model Muse Spark. With the data gathered from the new employee tracker, Meta is hoping to train new AI models that will come out of the lab. In January, Zuckerberg said that 2026 will be "the year that AI dramatically changes the way we work". "We're starting to see projects that used to take big teams now be accomplished by a single, very talented person," he said at the time.

Iran says it has seized two cargo ships in Strait of Hormuz after three vessels attacked

The Greek-owned container ship *Epaminondas* has "not been detained" by the Islamic Revolutionary Guard Corps (IRGC), according to Greek Foreign Minister Giorgos Gerapetritis. Speaking to CNN earlier, he said it was attacked and has faced "extensive damage". Greek media is reporting that the shipping ministry also denies that it has been detained. Earlier, the IRGC said that the ship, along with the *MSC Francesca*, was "seized" and directed towards the Iranian coast, Iranian media reported. The UK Maritime Trade Operations Centre said it was approached by an IRGC gunboat, which opened fire and caused significant damage to the bridge. Donald Trump says "it's possible" that a second round of peace talks with Iran could begin by Friday, according to the New York Post. The newspaper says it was told by Pakistani officials that talks might be possible within the next "36 to 72 hours". When the Post put this to Trump, the US president replied in a text message: "It's possible! President DJT." Yesterday, Trump announced that he would extend the ceasefire with Iran, set to expire on Wednesday evening, to allow the regime more time to create a "unified proposal" to end the war. The first reactions here to President Trump's ceasefire extension, by spokesmen on social media, was predictable, sceptical, defiant. Mahdi Mohammadi, an adviser to Iran's lead negotiator, dismissed it as meaningless, a ploy to buy time for a surprise attack. It underlines the deep distrust here about US diplomacy. Previous rounds of talks - last year and this year - were shattered by surprise Israeli-American attacks. Iran has its own commitment to keep as part of this ceasefire. But it's making it clear it won't open the



strategic Strait of Hormuz, on its conditions, until the US lifts its naval blockade and releases its seized vessel - that's the political logjam now. And there's no clear sign of how and when it will be resolved. When we speak to Iranians here, we hear a range of views, not surprisingly. Iranians taking to the main squares in this city every night in response to the government's call to show solidarity, are also defiant. Others tell us they're just trying to get on with their lives, exhausted by years of failed nuclear talks, spiralling prices, tightening security and surveillance, and all the many restrictions on their lives, their futures. A second French peacekeeper has died after being seriously wounded by Hezbollah fighters, says French President Emmanuel Macron. In a statement on X,

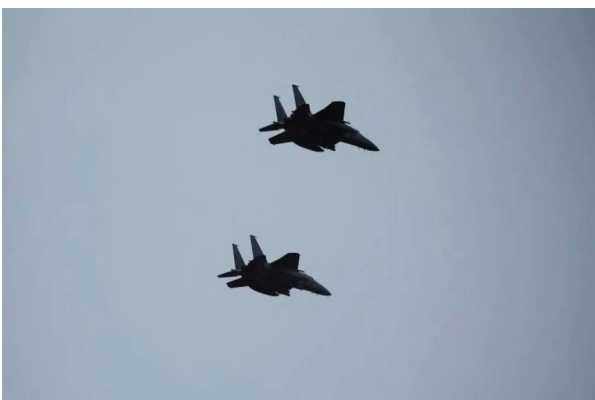
Macron says Corporal Anicet Girardin was repatriated yesterday and died this morning. On Saturday, a French peacekeeper who was serving with the UN mission in southern Lebanon, Unifil, was killed after a patrol came under fire. Macron blamed Hezbollah for the attack, though the Iran-backed armed group denied "any connection" to the incident. Two other peacekeepers have been injured. Macron said earlier that he "fully" supports the ceasefire between Hezbollah and Israel, and is concerned that it may "already be undermined by the continuation of military operations". He called for Hezbollah to renounce its weapons and for Israel to respect Lebanese sovereignty. The company which owns an Indian-flagged tanker that was attacked in the Strait of Hormuz over the weekend, despite its captain saying the ship had been granted clearance by Iran, has denied the

UAE-backed Colombian mercenaries provided support to Sudan paramilitary, report says



A network of Colombian mercenaries backed by the United Arab Emirates (UAE) provided critical support to Sudan's paramilitary Rapid Support Forces (RSF) enabling it to capture the western city of el-Fasher last year, a new report says. The investigation, by security analysis organisation the Conflict Insights Group (CIG), used data obtained from tracking the mobile phones of the Colombian fighters. The UAE has long denied supporting the RSF, which has been fighting Sudan's regular army for three years. El-Fasher's fall was one of the most brutal chapters of the conflict, which has led to the world's worst humanitarian crisis with tens of thousands killed and millions forced from their homes. The CIG has been closely following evidence of extensive Emirati military assistance to the RSF, but "this is the first research where we can prove UAE involvement with certainty", says director Justin Lynch. "We are making public what governments have long known - that there is a direct link between Abu Dhabi and the RSF." The report "shows mercenaries involved with drones travelling from a UAE base to Sudan before the RSF takeover of el-Fasher", he says.

South Korean fighter jets collided due to pilots taking pictures, report finds



South Korean authorities have found that two fighter jets collided mid-air in 2021 because the pilots were taking pictures and videos. The incident took place while the jets were on a flight mission in the central city of Daegu, according to Seoul's Board of Audit and Inspection. The pilots survived with no injuries, but the collision damaged the planes, costing the military 880 million won (\$596,000; £440,500) in repairs. One of the pilots, who has since left the military, was made to pay a fine of 88 million won. The incident took place because that pilot had wanted to take photos to commemorate his last flight with his military unit. Taking photos of significant flights was "a widespread practice among pilots at the time", the audit board said in a report published on Wednesday. The pilot had declared his intent to do so in a briefing before the flight, according to the report. He was flying the wingman aircraft and was following the lead aircraft during the mission. While flying back to their base, he started taking pictures using his personal

mobile phone. Upon noticing this, the pilot of the lead aircraft then asked another pilot on his plane to film a video of the wingman aircraft. The wingman pilot then abruptly flew his jet up higher and flipped it so that it could be better captured on camera. This manoeuvre brought the two planes very close to each other. To avoid a crash, the lead aircraft tried to rapidly descend. But the two F-15K jets eventually collided, damaging the lead aircraft's left wing and the wingman aircraft's tail stabiliser. South Korea's air force suspended the wingman pilot, who has since left the military to work for a commercial airline. Subsequently, the air force sought to fine the wingman pilot 880 million won to cover the full amount of the repair costs. When the pilot appealed against the fine, it prompted an investigation by the audit board. The wingman pilot acknowledged his sudden manoeuvre led to the collision, but argued that the lead aircraft's pilot had "tacitly consented" to the manoeuvre since he was aware that filming was taking place.

From Epstein to sock puppets: Key takeaways from Kevin Warsh's Fed confirmation hearing

Kevin Warsh has clashed with Democratic senators during a fiery confirmation hearing to decide whether he should be installed as Federal Reserve chairman. From suggestions that he would be President Donald Trump's "sock puppet" to questions over his links to paedophile financier Jeffrey Epstein, here are the key takeaways from Tuesday's showdown in the Senate. Warsh denies being Trump's "sock puppet" Senator Elizabeth Warren, the ranking Democrat on the banking committee that is overseeing his confirmation, said Warsh would be little more as Fed chairman than Trump's "sock puppet". Trump has suggested that, if confirmed, Warsh would conform to his agenda and lower interest rates, which



the president argues is necessary to boost the US economy. Trump has repeatedly clashed in public with the current Fed boss, Jerome Powell - especially on the issue of interest rates. Powell's term expires in May. In Tuesday's hearing, which considered Warsh's suitability to replace Powell, Warren said that "having a sock puppet in charge of the Fed would give the president access to the Fed's powerful authorities to enrich himself.

EU approves €90bn loan for Ukraine as pipeline is turned on ending deadlock

Ukraine says it has resumed pumping Russian oil through a pipeline into Hungary and Slovakia, bringing to an end months of deadlock over a 90bn (£78bn) loan seen as vital European Union support for Kyiv. Soon afterwards, EU ambassadors meeting in Brussels gave preliminary approval to the loan, as well as a 20th package of sanctions on Russia, officials said. It is now expected to be signed off on Thursday. Although the funding was agreed last December, Hungary's Viktor Orbán slapped a veto on the payment in February after Ukraine said damage caused by a Russian attack had brought supplies to a halt. Ukrainian oil and government sources told officials in



Hungary and Slovakia that pumping had restarted, hours after the EU ambassadors began discussing the loan. Orbán had demanded the oil start flowing again before the loan could be paid out, and Ukraine confirmed the repairs had been completed on Tuesday. His election defeat last Sunday also cleared the air for the EU, bringing to an end his 16-

Deputy Prime Minister Taras Kachka as "a matter of life and death" for Kyiv, and two-thirds of it will be spent on bolstering Ukraine's defence needs while the rest will go on broader financial assistance. Slovak Economy Minister Denisa Sakova said she had been told by energy operator Ukrtransnaft, which looks after the Druzhba pipeline in Ukraine, that pressurising of the pipeline had begun on Wednesday morning and crude oil would start flowing into Slovakia on Thursday, for the first time since 27 January. The volume of pumping was not yet clear, but a Ukrainian government source was quoted as saying that the transit of oil had begun at 12:35 local time (09:35 GMT).

LUFTHANSA CUTS 20,000 SUMMER FLIGHTS AS FUEL PRICES SURGE

German airline Lufthansa will cut 20,000 European short-haul flights over the summer, saying soaring fuel prices have made many journeys "unprofitable" for the firm. Jet fuel has doubled in price since the start of the US-Israel war with Iran as the conflict has slowed its production and transportation across the Middle East. Several airlines, including KLM-France and Delta, have also temporarily cut some flights while others have raised ticket prices as they pass on expenses to customers. Analysts have warned that travellers should expect further ticket price rises and more cancelled flights as the



conflict continues. The Gulf is a major source of aviation fuel, accounting for about 50% of Europe's imports. The bulk of it comes through the Strait of Hormuz, which Iran has effectively closed in response to US and Israeli attacks. Lufthansa said on Tuesday it would save

roughly 40,000 metric tons of jet fuel through its flight cuts, the majority of which will come from the closure of its CityLine service. It said this means it will temporarily stop flying to and from Heringsdorf, Cork, Gdansk, Ljubljana, Rijeka, Sibiu, Stuttgart, Trondheim, Tivat, and Wroclaw. The firm will either refund affected passengers or book them on to alternative flights with one of its other airlines - SWISS, Austrian Airlines, Brussels Airlines, and ITA Airways - where possible. Some of the flight cuts could become permanent. Lufthansa said it was reviewing its whole European schedule and would release more details later in April. Shortage concerns The International Energy Agency warned last week that Europe could run out of jet fuel in weeks, though the UK government and airlines say they are not seeing a disruption in supply.

Taiwan president cancels trip after African countries revoke flight permits

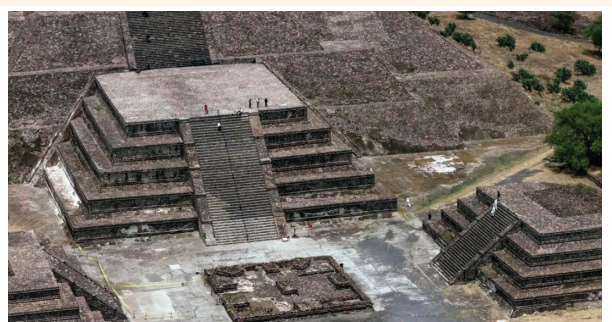


Taiwan President Lai Ching-te has cancelled a trip to the southern African nation of Eswatini, accusing China of putting pressure on other countries to bar his aircraft from flying over their territories. Seychelles, Mauritius and Madagascar revoked Lai's flight permits after "intense pressure" and economic coercion from China, said a Taiwan official. China denied coercion, while praising the three Indian Ocean nations saying it had "high appreciation" for them. This is the first publicly known instance where Taiwan's leader has had to cancel a trip due to revoked flight permits. Eswatini is one of 12 nations which are diplomatic allies of Taiwan and the only one in Africa. According to news agency Reuters, Seychelles and Madagascar said they took the decision because they do not recognise Taiwan. Taiwanese officials claimed that the three African countries revoked the flight permits "unexpectedly and without prior notice". China adheres to the "one China" principle in which Beijing asserts sovereignty over Taiwan, though many in

Taiwan consider themselves to be a sovereign nation. Beijing sees the self-governed island as a breakaway province that will eventually be part of the country, and has not ruled out the use of force to achieve this. The Chinese government has been vocal in its dislike of Lai, whom it has previously described as a "troublemaker" and a "destroyer of cross-strait peace". In a statement on X, Lai criticised China's "coercive actions", saying that it "exposed the risks authoritarian regimes pose to the international order". "No amount of threats or coercion will shake Taiwan's resolve to engage with the world." The government of Eswatini, formerly known as Swaziland, said it was regrettable that Lai was unable to visit, but that this would not "change the status of our longstanding bilateral relationship", according to reports. Lai was due to spend 22 to 26 April in Eswatini to attend celebrations marking the 40th anniversary of King Mswati III's accession and the king's birthday. Taiwan said that a special envoy will be appointed to attend the celebrations on Lai's behalf. China's Ministry of Foreign Affairs also said that it was "clear...[that] the so-called 'President of the Republic of China' no longer exists in the world", in a reference to Lai's official title in Taiwan. Some in the US have criticised Seychelles, Mauritius and Madagascar, with the House Foreign Affairs Committee Majority saying they "stood with Taiwan against this blatant coercion" in a post on X.

Mexico officials say Teotihuacán gunman carried material related to US mass shooting

The gunman who opened fire atop Mexico's ancient Pyramid of the Moon appeared to have been influenced by other violent shootings and showed signs of psychological problems, the country's president said on Tuesday. Julio César Jasso Ramirez, 27, a Mexican national, carried a handgun, dozens of cartridges, a knife and literature referencing acts of violence, officials said on Tuesday. Mexico's top prosecutor said Jasso Ramirez planned and carried out the attack alone. The gunman fatally shot himself after a standoff with police. A Canadian woman was killed and 13 others were injured at the popular tourist site northwest of Mexico City.



"Based on everything indicated by the prosecutorial authorities, this person showed signs of psychological problems and was influenced by incidents that occurred abroad," President Claudia Sheinbaum said during a Tuesday media conference. The gunman carried documents that apparently referenced the 1999

Columbine High School massacre in the US, according to José Luis Cervantes Martínez, attorney general of the State of Mexico, which is home to the Teotihuacán pyramid complex. "Among his belongings, authorities also found ... literature, images and documents allegedly related to acts of violence that ... may have

occurred in the United States in April 1999," he said. A tourist who witnessed the shooting told Reuters news agency that visitors heard Jasso Ramirez refer to the notorious Columbine shooting, which took place exactly 27 years prior. During the media conference, Cervantes and Mexican authorities said that Jasso Ramirez had repeatedly visited the archaeological site - about 50km (31 miles) from Mexico City - and arrived there on Monday just before noon local time. "This act was not spontaneous," said Cervantes Martínez. After the gunman scaled the ancient pyramid, he began shooting from one of its platforms.

LOS ANGELES BECOMES FIRST MAJOR US SCHOOL DISTRICT TO LIMIT CLASSROOM SCREEN TIME

Los Angeles' education board has voted to restrict student screen time in classrooms, making it the first major US school system to do so. The resolution requires staff to develop screen-time policies based on grade level and bans first-grade and younger students from using devices. It comes as the district, which serves about half a million students, sought to reduce its reliance on tablets and laptops, which was prompted by the Covid-19 pandemic. Nick Melvoin, a board member who brought forward the resolution, said student devices were a "lifeline" in 2020, but that "years later, it's time that we reset". "I believe that we have the opportunity to lead the nation, to establish comprehensive, developmentally grounded screen-time limits

that puts students before screens," Melvoin said at a meeting on Tuesday. "This is not about going backwards. This is about rethinking screen time in schools to make sure we are doing what actually helps students learn best." The restrictions, which are expected to be implemented in the next school year, will ban YouTube and other video-streaming platforms on school-issued devices. They will also allow parents to opt their children out of using specific digital tools. The resolution cited research indicating that children aged 8 to 11 who exceed screen-time guidelines are at higher risk for obesity and depressive symptoms and have scored lower on cognitive assessments.

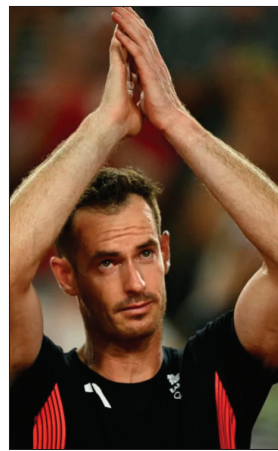

Tennis Great Andy Murray Opens Up On Coaching Plans In Future

British tennis great Andy Murray has opened up about his coaching journey after retirement, revealing he remains open to returning to the role in the future while also backing Novak Djokovic in his pursuit of a historic 25th Grand Slam title. Murray, who briefly worked with Djokovic following his retirement from professional tennis, reflected candidly on the experience and the lessons it offered him from a completely different perspective within the sport. "Djokovic probably learned nothing (from me). No, I learned a lot and honestly, I would coach again but probably not right now. I've had a few opportunities to coach but I don't really want to do loads of travelling right now unless it's with my family,"



Murray told Sky Sports. The Brit, who joined Djokovic's team in late 2024, described the transition from player to coach as a significant shift, especially after years of competing at the highest level against the Serbian. "I knew lots about

Novak's game. I played against him for years and studied his game. It was interesting to see what his day to day looked like in comparison to what I might have been doing and how those things differ," said the former world No 1. Murray emphasised that communication and understanding are central to coaching, admitting that his personal life has shaped his approach in this regard. "From a coaching perspective, it's about how you communicate your message to the player that you're working with and how to listen to them. I really think that having kids has helped me with that - learning to be more understanding and seeing something from another person's point of view and perspective.

Real Madrid's Aurelien Tchouameni has emerged as one of the international midfielders Manchester United are monitoring as they look to address their priority position this summer. After focusing on their forward options and, eventually, the goalkeeping position last year, United want to target midfield reinforcements at the end of the current campaign. Nottingham Forest's Elliot Anderson, Carlos Baleba of Brighton and Crystal Palace's Adam Wharton are three players who have been mentioned regularly.
