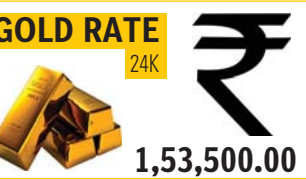
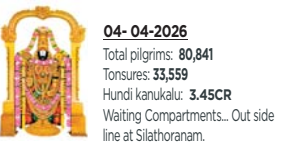

**Telangana urges Centre to pass bill to restore five villages merged with Andhra**

Hyderabad (TSIT): The government of Telangana has urged the Centre to pass a Bill in the Parliament to restore five villages that were merged with Andhra Pradesh in 2014. Agriculture Minister Tummala Nageswara Rao has written a letter to Union Home Minister Amit Shah, urging him to table a bill during the current session of the Parliament to re-merge five villages with Telangana. The state minister, who comes from Khammam district, demanded that the five villages near Bhadrachalam be restored to Telangana for administrative convenience. He also highlighted the problems faced by tribals due to these five villages being under the control of Andhra Pradesh. The demand for passing a bill to restore five villages comes close on the heels of Parliament passing a Bill to accord statutory status to Amaravati as the only and permanent capital of Andhra Pradesh.

**At least 14 people killed in Israeli strikes across Lebanon**

Beirut (TSIT) Israeli strikes across southern Lebanon and the capital, Beirut, have killed at least 14 people, a day after Israel threatened to hit Lebanon's main border crossing with Syria, forcing its closure. Israeli strikes on Beirut's southern suburbs on Sunday killed at least four people while 10 people – including a family of six – were killed in Israeli attacks on southern Lebanon. A further 39 people were wounded in an Israeli strike on Beirut's Jnah neighbourhood, according to Lebanon's Ministry of Public Health. The strike hit about 100 metres (330ft) from Rafik Hariri University Hospital, the country's largest public medical facility, a medical source told the AFP news agency. Israel has launched air strikes across Lebanon since March 2 after the Lebanese armed group Hezbollah fired rockets into Israel in response to the United States-Israeli war on Iran. Israeli forces have also launched a ground invasion of southern Lebanon.

## All pillars of democracy must work with mutual respect, says Revanth

Hyderabad (TSIT) : Telangana Chief Minister A. Revanth Reddy said on Sunday that all pillars of democracy must work with mutual respect and avoid confrontations. He stated that his government gives the highest respect not only to all court verdicts and judgments, but also to various observations and feedback. He was speaking at the foundation-laying of Zone-II of the new building of Telangana High Court in the presence of Chief Justice of India Justice Surya Kant.

"In our democracy, the three branches operate with autonomy, inter-dependence and respect for each other: legislature, executive and judiciary. For a common citizen, the court represents the final door to knock, the last resort. Therefore, it is a great opportunity for me, maybe of a lifetime, that my government could initiate the project to build a new High Court complex for Telangana," he said. Revanth Reddy said many governments and Chief Ministers in the past could have taken up this project, but for some reason, it was left for his government to undertake

this noble task. "The new High Court will become an icon, a functional lifeline for society and democracy. This will be the platform where the poor and weak will come seeking justice. For the next 100 years, the poor, the weak, the voiceless and the oppressed will come to this temple of justice, seeking to be heard, and will hope to find justice," said the Chief Minister.

He noted that the current High Court, a building of great historical significance, was no

longer able to physically support the needs of all stakeholders. "Beyond legacy, this building shows my government's view and values of democracy. We believe that all pillars must work collaboratively, with mutual respect. My government gives the highest respect for the judiciary," he said.

He believes that it is the duty of the political executive to provide the judiciary with the best modern facilities to perform to their highest level of capabilities. "What we are building here will not only be one of the largest High Court buildings in India, but a benchmark of modernity and excellence in public infrastructure.

## BENGAL POLLS: MAMATA CALLS FOR 'REVENGE' OVER VOTER LIST DELETIONS

Samsanganj (TSIT): West Bengal Chief Minister Mamata Banerjee on Sunday, April 5, urged people to cast their votes to "take revenge" for the deletion of people's names from the electoral rolls. The Trinamool Congress chief urged people whose names have been deleted from the voter list during the Special Intensive Revision (SIR) of electoral rolls to move appeals before the tribunal.

Addressing an election rally at Samsanganj, which was the epicentre of violence during the protests against the Waqf (Amendment) Act in Muslim-majority Murshidabad district in April 2025, she said, "Cast your votes to take revenge for deletion of people's names, and against the SIR so that the results reflect that." Banerjee asked the TMC workers to remain vigilant till the counting date on May 4. Assembly polls in West Bengal will be held in two phases on April 23 and 29. In an apparent reference to Union Home Minister Amit Shah, Banerjee alleged that he was behind the deletion of voters' names in West Bengal during the SIR exer-



cise. "If you have the guts, fight directly," she said.

Asking all TMC workers to be on guard during the poll period, Banerjee said, "I hope none of our booth agents will sell themselves off to the BJP, in the interest of West Bengal." Claiming that EVM machines will be made to malfunction at some places, the TMC chief instructed party workers not to allow EC officials to repair the machines and instead demand replacements. Speaking at the rally in support of Mohammed Nur Alam in Samsanganj and Mohammed Amirul Islam in Farakka, Banerjee accused the BJP of spreading canards against her that she did not do much for the interest of the Muslims, maintaining that she has fought hard against the implementation of the Waqf (Amendment) Act.

**Rahul slams Assam CM for corruption, vows accountability ahead of elections**

Guwahati (TSIT): Rahul Gandhi, senior leader of the Congress Party, on Sunday launched a fierce attack on Assam chief minister Himanta Biswa Sarma, accusing him of corruption and divisive politics, and



promising that the people of the state would hold him accountable. Addressing a rally in Biswanath district, Gandhi said, "Himanta Biswa Sarma is the most corrupt and the most communal chief minister in the country. He has betrayed and misled the people of Assam—the evidence is before the public."

## All Indian seafarers in Persian Gulf are safe: Govt

New Delhi, (TSIT) : All Indian seafarers in the Persian Gulf region are safe, and no incident involving Indian-flagged vessels has been reported in the past 24 hours, according to a statement issued by the Ministry of Ports, Shipping and Waterways on Sunday. A total of 17 Indian-flagged vessels with 460 Indian seafarers remain in the western Persian Gulf region, with Director General (DG) Shipping, in coordination with ship owners, placing agencies and Indian Missions, actively monitoring the situation, the statement said. The Ministry also said that it continues to closely monitor shipping movements, port opera-



tions and the safety of Indian seafarers, while ensuring continuity of maritime trade. The DG Shipping Control Room remains operational 24x7 and has handled 5,088 calls and 10,547 emails since activation; in the past 24 hours, 73 calls and 122 emails have been received. The DG Shipping has facilitated the safe repatriation of more than 1,479 Indian seafarers so far, including 159 in the last 24 hours from airports and various regional locations

across the Persian Gulf. Port operations across India remain normal, with no congestion reported, as confirmed by State Maritime Boards of Gujarat, Maharashtra, Goa, Kerala, Andhra Pradesh and Puducherry.

The Ministry of Ports, Shipping and Waterways continues to coordinate with the Ministry of External Affairs, Indian Missions and maritime stakeholders to ensure seafarer welfare and uninterrupted maritime operations. Meanwhile, across the region, Indian Missions and Posts remain in close contact with the Indian community, while continuing to provide assistance and issue necessary advisories for their safety and well-being, according to the Ministry of External Affairs.

## Malda gherao reflects TMC's maha jungleraj: Modi in Bengal

Kolkata (TSIT): Prime Minister Narendra Modi on Sunday made the Malda gherao of judicial officers the fulcrum of the BJP's campaign on lawlessness in West Bengal, accusing the TMC government of running a "maha jungleraj" and pitching the 2026 assembly polls as a straight contest between the "bhay" spread by the ruling party and the BJP's "bharosa".

Addressing his first election rally in Cooch Behar in north Bengal after the poll schedule was announced, Modi used the Malda incident to sharpen the BJP's twin campaign planks of "poor law and order" and alleged demographic change, besides the issues of safety of women and infiltration from Bangladesh to attack the TMC. "Just a few days ago, the entire nation witnessed judicial officers being held hostage in Malda. What kind of government is this, where judges and constitutional procedures are not safe? We cannot expect such a government to keep the people of Bengal safe," Modi said.

The Prime Minister was referring to Wednesday night's incident in Malda's Kaliachak-II block office, where seven judicial officers, including three women, were gheraoed for sev-



eral hours by a mob during hearings on names marked "under adjudication" in the draft electoral rolls prepared during the Special Intensive Revision exercise. "What happened in Malda is an example of TMC's maha jungleraj," he said, alleging that the ruling party was "bent on carrying out the funeral procession of law and order" in the state.

Modi also sought to frame the contest in binary terms. "On one side, there is the 'bhay' (fear) of the TMC, and on the other side, you have the BJP's 'bharosa' (trust). On one side is the fear of TMC's cut money and corruption, and on the other side is the BJP which accelerates development," he said. The PM also contrasted the fear of infiltration and settling foreigners in Bengal with the BJP's confidence in stopping infiltration and driving infiltrators out.

## Andhra town tense as temple row escalates; several detained

Amaravati (TSIT): Tension prevailed in Akividu town of Andhra Pradesh on Sunday as police detained leaders of several organisations attempting to hold a rally demanding construction of a temple at a disputed structure. Police



stopped and took into custody members of Hindu groups heading towards the town, while imposing prohibitory orders to prevent gatherings amid tensions between sections of Hindus and Dalits. Authorities made it clear that no rallies or public meetings were permitted and warned of strict action against violators. Heavy security was deployed, with checkpoints set up at entry points and vehicles, including RTC buses, being thoroughly inspected to prevent outsiders from entering and escalating the situation. Actor Karate Kalyani was detained at Kaikalur while en route to Akividu in support of the temple demand. She was placed under preventive detention and later condemned the police action.

## ENTERED PARLIAMENT NOT TO CREATE RUCKUS; INTERVENTIONS DOCUMENTED: RAGHAV CHADHA ON PUNJAB ROW

New Delhi, April 5 : Rajya Sabha MP Raghav Chadha has strongly refuted allegations made by leaders of the Aam Aadmi Party (AAP), who accused him of failing to raise issues concerning Punjab in Parliament. In a detailed public statement released on Sunday, Chadha termed the accusations "completely false" and politically motivated, asserting that his parliamentary record clearly contradicts such claims.

"I outrightly dismiss the baseless and maliciously motivated allegations being levelled... that I failed to raise Punjab's issues in Parliament," Chadha said, emphasising that his interventions are documented and accessible in official records. He added, "This is not a matter of opinion, propaganda, or political convenience. It is a matter of official record, available for every citizen to verify."

Addressing one of the key



accusations -- that he failed to raise the issue of pending funds for Punjab -- Chadha stated, "I categorically raised this demand on 31st July 2024," pointing to recorded proceedings available via Sansad TV. He specifically mentioned raising concerns about pending Rural Development Fund (RDF) dues and what he described as "financial injustice" toward the state.

Chadha further highlighted a wide range of issues he claims to have consistently raised in Parliament. These include groundwater depletion, farmers' distress, Minimum Support Price (MSP) concerns, rising agricultural costs, and the need for crop diversification. He also cited discussions on federalism, industrial revival, employment generation, infrastructure gaps, and border security challenges in Punjab. In addition, Chadha pointed to his advocacy on sensitive and culturally significant

matters, including the expansion of the Kartarpur Sahib Corridor and improved pilgrimage access to Nankana Sahib. He stressed that these were "serious, documented interventions" rather than symbolic gestures.

"My role as a Member of Parliament has never been to indulge in noise, theatrics, or performative outrage," he stated. "I entered Parliament to create impact, not to create ruckus." Concluding his remarks, Chadha criticised what he described as a "coordinated misinformation campaign" against him, asserting, "No smear campaign can silence my voice or weaken my resolve. Truth will prevail. Facts will prevail. And every lie will stand exposed." The statement comes amid ongoing political tensions within AAP, with Chadha positioning his record as evidence of his continued commitment to Punjab and its people.

## Right to Education does not include right to choose school: High Court

**NEW DELHI:** A child's right to education does not encompass the right to select a particular school for it, the Delhi High Court has held.

A bench of Chief Justice D K Upadhyaya and Justice Tejas Karia said the Right to Education (RTE) Act was a beneficial legislation, enacted to achieve the objectives of social inclusion and ensuring that schools become a common space which was not differentiated by barriers of caste, ethnic group or caste lines.

"However, such a right to education cannot be translated into right to select a particular school," the court ruled on March 25.

The court's verdict came on a mother's appeal seeking to admit her ward in Class 2 under the EWS category in a private school for the academic session 2024-2025.

The appellant had earlier approached a single-judge bench of the high court for admission of her ward under the EWS category in Class 1 of the private school for the 2023-2024 academic session.

In the appeal, the appellant assailed the single judge's order, which said that although the school lacked a legitimate basis for refusing admission to the appellant's ward, the conclusion of the relevant academic year precluded the court from issuing an order for her ward's admission in the subsequent academic year, i.e. 2024-25.

The single judge, however, had said that the unfilled EWS seats in Class 1 for the academic year would be carried forward next year for the same class and would be available to any EWS candidate, including the appellant's ward, if they choose to apply.

The appellant, however, argued before the division bench that her ward ought to be given admission in Class 2 in the school for the academic year 2024-2025.



## R Gandhi alleges Kerala CM linked to those 'attacking' minorities, slams 'LDF-BJP tie up'

**ALAPPUZHA:** Top Congress leader Rahul Gandhi on Saturday targeted the ruling LDF in Kerala and the BJP, alleging that Chief Minister Pinarayi Vijayan is in a partnership with people who "attack minorities" in other parts of the country.

Addressing an election gathering here, Gandhi reiterated his allegation of a BJP-LDF understanding and accused Prime Minister Narendra Modi of not speaking about the Sabarimala issue during the election campaign.

Elections to 140 Assembly seats in the state will be held on April 9.

Referring to former CPI(M) leader G Sudhakaran, who shared the stage with the Congress leader, Gandhi said his presence reflected a deeper shift within the CPI(M)-led LDF.

Sudhakaran is contesting as an Independent with UDF support from Ambalapuzha.

"We have a senior Left leader on the stage. There is a reason he is sitting here. It is not that he has suddenly changed his thinking. People who spend many years in a political organisation absorb its values. He is not here out of opportunism. He is here because something fundamental has happened to the LDF," Gandhi said.

He said for many years the Congress-led UDF fought the LDF as opponents, but they stood for certain ideas and were known as a symbol of the Left.

"What does LDF stand for-- Left Democratic Front. Now, frankly, there is nothing Left in the LDF. After the election, there will be nothing left in it," he added.

Gandhi alleged that what was disturbing leaders and workers within the Left was a "hidden hand" guiding the LDF.

"That hidden hand is communal, does not accept the Constitution of India, divides people and spreads hatred. Everyone in Kerala can see the connection between BJP, RSS and CPI(M)," he charged.

The Leader of Opposition in the Lok Sabha further said there were two types of leaders in the LDF -- "opportunists who want power and do not care about the help of BJP and RSS," and those who had worked for the party for years but now feel "betrayed" and upset with its direction.

Gandhi also targeted Modi, saying he frequently speaks about religion and temples in his speeches elsewhere but remained silent on the alleged Sabarimala issues in Kerala, apparently referring to the gold loss cases.

"I fight BJP and RSS; they attack me, cases are filed, I am interrogated, but I do not back down. Modi attacks me daily. But why does he not attack the Kerala chief minister and his family," he asked.

He said Modi speaks about God, religion and temples in every speech.

"But when he comes to Kerala, he forgets all that because he wants to help the LDF. The truth is he knows the LDF will never challenge him nationally," Gandhi alleged.

Gandhi further alleged that minorities are facing widespread attacks in different parts of the country.

"Two nuns from here were attacked in Chhattisgarh. In Manipur, churches were burnt. The chief minister (Vijayan) has a partnership with the people who are doing this. The very people who are attacking minorities--Muslims, Christians and Sikhs--have a partnership with the chief minister," he alleged.

He alleged that both PM Modi and Vijayan, after being in power for a long period, have become "arrogant" and disconnected from the people.

He claimed that when five to six women MPs stood up in Parliament, Modi perceived it as an attempt to attack him.

Drawing a comparison with Vijayan, Gandhi alleged that when a few Congress workers showed black flags, they were "physically beaten almost to death".

"He imagines that they are going to attack him to kill him, so he attacks them. Both these are examples of people who are drunk on power. They have already broken their relationship with the people," Gandhi charged.

## Cong betrayed northeast; BJP govt bridged "gap" between region, country: Nitin Nabin

**RAM KRISHNA NAGAR/LAKHIPUR:** BJP chief Nitin Nabin on Saturday accused the Congress of betraying the people of the northeast and playing with their sentiments, while asserting it was his party's governments that have "bridged the gap" between the region and the rest of the country.

He alleged that successive Congress governments in Assam had turned the Barak Valley into a "crime hub" for its vote bank politics.

People punished the Congress for "appeasing" infiltrators by voting it out of power in the state, Nabin told an election rally



in Cachar district. Canvassing for the BJP's Lakhipur candidate, Nabin said, "When the opposition asks what we have done in this last decade, I want to ask them about their policy and intention. For 70 years, they

betrayed the people of the northeast and played with their sentiments."

He claimed that when people from the region visited Delhi earlier, they said that they were going to India. "But now, the entire India is visible in ev-

ery nook and corner of the northeast. This has been possible as development is reaching every corner under Prime Minister Narendra Modi."

He maintained that the Modi government's biggest achievement has been opening bank accounts for the marginalised sections under Jan Dhan Yojana, which has ensured that the benefits of all schemes reach the intended beneficiaries directly.

Asserting that the BJP-led government will score a hat-trick of winning the Assembly polls, Nabin said, "We do not contest elections for power but to bring change in people's lives. People have blessed

us in the last two Assembly elections, and they will do so again this time."

Nabin claimed the Barak Valley was discriminated against by the Congress governments, and travelling to this region from Guwahati 12 years ago was an ordeal.

"Now, the roads are good... Once known for violence and unrest, the state is now known for development and hope," he added.

Speaking at another rally in Sribhumi district, Nabin said, "Previous governments had turned Barak Valley into a crime hub for vote-bank politics. Appeasement politics was at its peak during the Con-

gress rule, as they were more concerned about infiltrators."

Canvassing for the party's Ram Krishna Nagar candidate, he said people decided to "punish" the Congress and brought the BJP-led NDA to power with a "clear vision for development".

Asserting that the BJP-led government has ensured taking 'Virasat and vikash' together, Nabin said crime has been checked in the southern part of the state.

"No criminal dares to trouble the people anymore as they know that Chief Minister Himanta Biswa Sarma will not spare anyone," he said.

## UP: Man sentenced to life for killing nephew in 2019

**BUDAUN:** A court here on Saturday sentenced a man to life in prison for the murder of his nephew in a seven-year-old case, officials said.

Additional District and Sessions Judge (Court Number 1) Rinku Kumari pronounced the verdict, holding the accused Shahid guilty of murder.

According to Special Public Prosecutor Sanjeev Kumar Gupta, the incident dates back to February 5, 2019, in the Bisauli area. The complainant, Mohammad Miyan, had received information that his nephew Farooq, was killed while he was asleep at his house.

The victim was brutally attacked with sharp construction tools, including a chisel-like implement and an iron tool, causing fatal head injuries, the prosecution said.

During investigation,



police identified the accused Shahid, who is Farooq's uncle. Evidence and witness statements revealed that a dispute over money had taken place between the two on the night of the incident.

Shahid had also allegedly stolen the victim's mobile phone and later killed him out of fear of being caught.

The court relied on witness testimonies and material evidence, including blood-stained tools, to convict the accused under Sections 302 (murder) and 452 (house trespass) of the Indian Penal Code.

## BJP targets Congress, Rahul Gandhi over remarks on West Asia conflict

**NEW DELHI:** The BJP on Saturday accused the Congress and its leader Rahul Gandhi of using falsehood to "praise" Pakistan and criticise India's stance on the West Asia conflict, and alleged that "INC now means Islamabad National Congress".

It said some Congress leaders are also holding up a mirror to Gandhi, who has "undermined India's position simply because he opposes the BJP".

BJP national spokesperson Shehzad Poonawalla, in a series of posts on X, alleged that the Congress had wrongly claimed that Indian vessels such as Shivalik and Nanda Devi were not reaching the country and that India's ties with Iran had collapsed.

"Facts: seventh tanker of India Green Sanvi crosses Hormuz for India in another big embarrassment for 'Islamabad National Con-

gress," he said, adding that India has not only secured its people in the affected region but has safeguarded its energy interests.

Poonawalla, in a video message shared on X, accused Rahul Gandhi of "continuously spreading falsehoods and politicising foreign policy".

"Politicising foreign policy has become Rahul Gandhi's standard operating procedure and that too based on falsehoods," he said.

"Rahul Gandhi, as Leader of Opposition, seems to behave like a 'Leader of Pakistan'. The same Pakistan he praises is not even in a position to stabilise its own economy. It is struggling to repay loans, and fuel is being distributed in small bottles. Iran and other countries have rejected Islamabad as a mediator," he said.

Poonawalla accused Gandhi of prioritising "pol-

itics over national interest" and alleged that even leaders within the Congress had publicly disagreed with his statements on the issue.

"Rahul Gandhi has repeatedly undermined India's position simply because he opposes the BJP; Every time national interest is discussed, Congress resorts to petty politics, even on foreign policy. Once again, Congress leaders themselves are holding up a mirror to Rahul Gandhi. Will he accept it?" Poonawalla said.

He cited remarks by former Union minister Ashwani Kumar backing the government's handling of the situation, and claimed that it exposed the Congress party's "double standards".

"After Tharoor, Tiwari, Kamal Nath, Anand Sharma, now Ashwini Kumar holds a mirror to Rahul Baba," he said.

Poonawalla said Kumar

has openly praised the Modi government's stance on the Iran-Israel war issue while holding a mirror to the Congress party.

"He clearly stated that the contribution of India's prime minister in these difficult circumstances is commendable.

"This statement of his completely exposes the Congress party's false propaganda and double standards because, on the very issue where the Congress has been continuously trying to spread confusion, one of its former senior leaders has acknowledged the truth and praised the Modi government's policy and leadership," he added.

BJP spokesperson Pradeep Bhandari also said that despite reports of large-scale disruptions in the Strait of Hormuz due to escalating tensions, India has managed to secure its critical energy supplies without interruption.

## EC suspends four cops for 'failing' to maintain order during Suwendu Adhikari's nomination filing

**KOLKATA:** The Election Commission on Saturday directed the suspension of four Kolkata Police officials and initiation of disciplinary proceedings against them for "failing" to maintain law and order during BJP leader Suwendu Adhikari's nomination filing in the hotly contested Bhabaniour seat.

Union Home Minister Amit Shah had accompanied Adhikari for the filing of the nomination papers on April 2 in the seat in south Kolkata, where the leader of the opposition in the outgoing Assembly is pitted against incumbent Chief Minister Mamata Banerjee.

In a communique to the West Bengal chief secretary, the poll panel said the direction is based on a recommendation from state Chief Electoral Officer Manoj Kumar Agarwal.

The missive directed



action against Kolkata Police's Deputy Commissioner (DC-II), South Division, Siddhartha Dutta, Officer-in-Charge of Alipore Police Station Priyankar Chakraborty, Additional OC Chandni Charan Banerjee, and Sergeant Saurabh Chatterjee.

"The commission has agreed to the proposal and directs that the aforementioned police officers be suspended and disciplinary proceedings be initiated

against them immediately," it stated. The poll body has asked the state authorities to ensure that its directions are implemented without delay and that a compliance report be submitted by 11 am on Monday.

Moreover, the poll panel has sought an urgent proposal from the state government to fill up the vacant posts, including that of DC-II, South Division, and the officer-in-charge

positions at Alipore Police Station. The BJP held a massive roadshow before the filing of the nomination on April 2 that moved through the constituency, considered Mamata Banerjee's bastion, with Shah and Adhikari standing on an open-hood, flower-decked vehicle. As the convoy approached Kalighat, barely a few hundred metres from Banerjee's residence, Trinamool Congress workers and supporters gathered on the roadside waving green-and-white party flags, shouting 'Joy Bangla' and 'Mamata Banerjee zindabad' slogans.

However, the situation turned tense when the BJP roadshow and the TMC protest came face to face near Kalighat.

For several minutes, supporters of the two rival camps stood barely a few metres apart, hurling slogans at each other.

## Rajasthan anti-narcotics force carries out 258 ops in 175 days of its formation

**JAIPUR:** Rajasthan's Anti-Narcotics Task Force (ANTF) has carried out 258 operations within 175 days of its formation, seizing narcotic substances worth approximately Rs 563 crore, police said on Saturday.

The seized value pertains only to drugs and does not include the cost of confiscated vehicles, weapons or factories, officials said, terming it a record in terms of scale and effectiveness since the unit's inception on October 7, 2025.

Director General of Police Vikas Kumar said the ANTF has taken strong action against all forms of drug trafficking across the state.

"Major consignments have been seized, and five significant cases of illegal cultivation of ganja and opium have been busted," he said. He added that 30 illegal MD drug manufacturing units have been busted, including six directly by ANTF teams.

The force has also intercepted five major opium smuggling consignments and taken action against 45 notorious and wanted drug traffickers, he said.

Officials said the ANTF has established 18 outposts, one police station and a dedicated headquarters across the state, with trained personnel deployed to intensify anti-narcotics operations.

### 327 TAMIL NADU FISHERMEN EVACUATED FROM IRAN REACH CHENNAI



CHENNAI: In a high-stakes evacuation from conflict-hit Iran, as many as 345 Indian fishermen, including 327 from Tamil Nadu, were brought back safely to Chennai on Saturday, capping a coordinated rescue operation mounted by the Union government. Fishermen are returning to their home towns from Chennai (Photo: Hemanathan M)

The fishermen, stranded amid intense bombardment, were moved out of Iran via Armenia and flown to Chennai on a special flight. Union Minister Piyush Goyal, BJP state president Nainar Nagenthran and senior leader Tamilisai Soundararajan received them at the airport.

Detailing the operation, Nainar Nagenthran said, "A total of 345 fishermen, including 327 from Tamil Nadu, were rescued safely. The Union government made all necessary arrangements. Around Rs 93,000 was spent per person to bring them back." He added, "No matter how much importance is given to Tamils, there are always attempts here to find fault."

The returnees recounted harrowing moments from the conflict zone.

"Bombs kept falling continuously. There was no guarantee for life," Peter, a fisherman, said. Another fisherman, Sagaya George, added, "We could not sleep at night due to the sound of explosions. We were living in constant fear." Several fishermen said they had appealed to the Indian government for evacuation as the situation worsened. "We were terrified and did not know if we would survive. We are relieved to be back home," George said.

All 327 Tamil Nadu fishermen were arranged to be sent to their native districts in separate buses, while those from other states were also assisted in returning home.

Medical intern from city killed in car overturn. Addressing reporters, Union Minister Piyush Goyal said the Centre had acted swiftly to bring back those stranded due to the conflict. He also took aim at Chief Minister MK Stalin, alleging that false accusations were being made against the Union government.

"We have been clear that all children should learn Tamil, while also learning an additional language. However, false narratives are being created," he said, referring to the three-language policy controversy.

### BJP HOLDING FCRA BILL OUT OF POLL FEAR, SAYS CM STALIN

KANNIYAKUMARI: Chief Minister MK Stalin on Saturday termed the Centre's proposed FCRA Amendment Bill 2026 as "draconian", and alleged it targeted minorities, especially Christian service organisations and demanded that it be dropped. He was addressing a campaign rally in Nagercoil for the Assembly polls.

Across the country, Christians are enraged due to the proposed amendment, which, if passed, would lead to the cancella-



tion of the recognition of the beneficiary-recipient-institution, and funds can be taken away even for minor lapses, such as a delay in submitting proof, the CM said. Even hospitals, schools and hostels

could be taken over by the government for lapses. Even institutions built using funds from both domestic and foreign sources could be taken over, he said.

The Foreign

Contribution Regulation Amendment Bill, introduced in the Lok Sabha on March 25 by Union Minister of State for Home Nityanand Rai, seeks to enhance transparency and ensure proper utilisation of foreign funds, while preventing their misuse against national security and interests. Stalin said Modi had praised Christian institutions for their services in education and healthcare. "However, now what is he doing? This is his true face."

### Modi govt doesn't treat those from Tamil Nadu as Indian fishers: Stalin

KANNIYAKUMARI: Chief Minister MK Stalin on Saturday assured that special relief assistance for fishermen will be raised to Rs 12,000 per month and the lean period assistance to Rs 9,000 per month as part of DMK's poll promises for the upcoming election. Rs 11 lakh cash seized from DMK functionary's house in Tiruchirappalli.

The CM, recalling that his government had increased the fishing ban period special relief assistance to Rs 8,000 from Rs 5,000, said, "Hereafter, the assistance will be Rs 12,000 per month and not Rs 8,000. Similarly, the fishing lean period assistance will be Rs 9,000 per month and not Rs 6,000. Are you all happy?" Referring to other ongoing welfare schemes, he made new assurances. The upper age limit to enrol as a member of the Fishermen Welfare Board will be enhanced to 70 from 65, and members between 70 and 75 will be provided a monthly pension in addition to the existing welfare measures. "However, the BJP-led union government, which holds the foreign policy in its hands, has failed to protect our fishermen. It has also failed in



foreign policy. Prime Minister (Narendra) Modi has created a situation where India has no influence even over its small neighbouring countries," Stalin alleged. Medical intern from city killed in car overturn.

CM Stalin promised that fishing ban period assistance would be hiked to Rs 12,000 per month from Rs 9,000. Tamil Nadu fishermen as Indian fishermen and the consequence of this was the continuous attacks by the Sri Lankan Navy on fishermen, he claimed. When fishermen were attacked during the Congress regime at the Centre, Modi accused the then PM Manmohan Singh of being "weak" and said such incidents would not have happened if a strong PM were at the helm.

Rs 11 lakh cash seized from DMK functionary's house in Tiruchirappalli.

The celebrations began with the Paschal Vigil ceremony. During the ritual, the "Paschal Light," symbolising the resurrection of Jesus Christ, was lit by the Rector of the Basilica, Fr. Irudhayaraj, followed by solemn prayers. 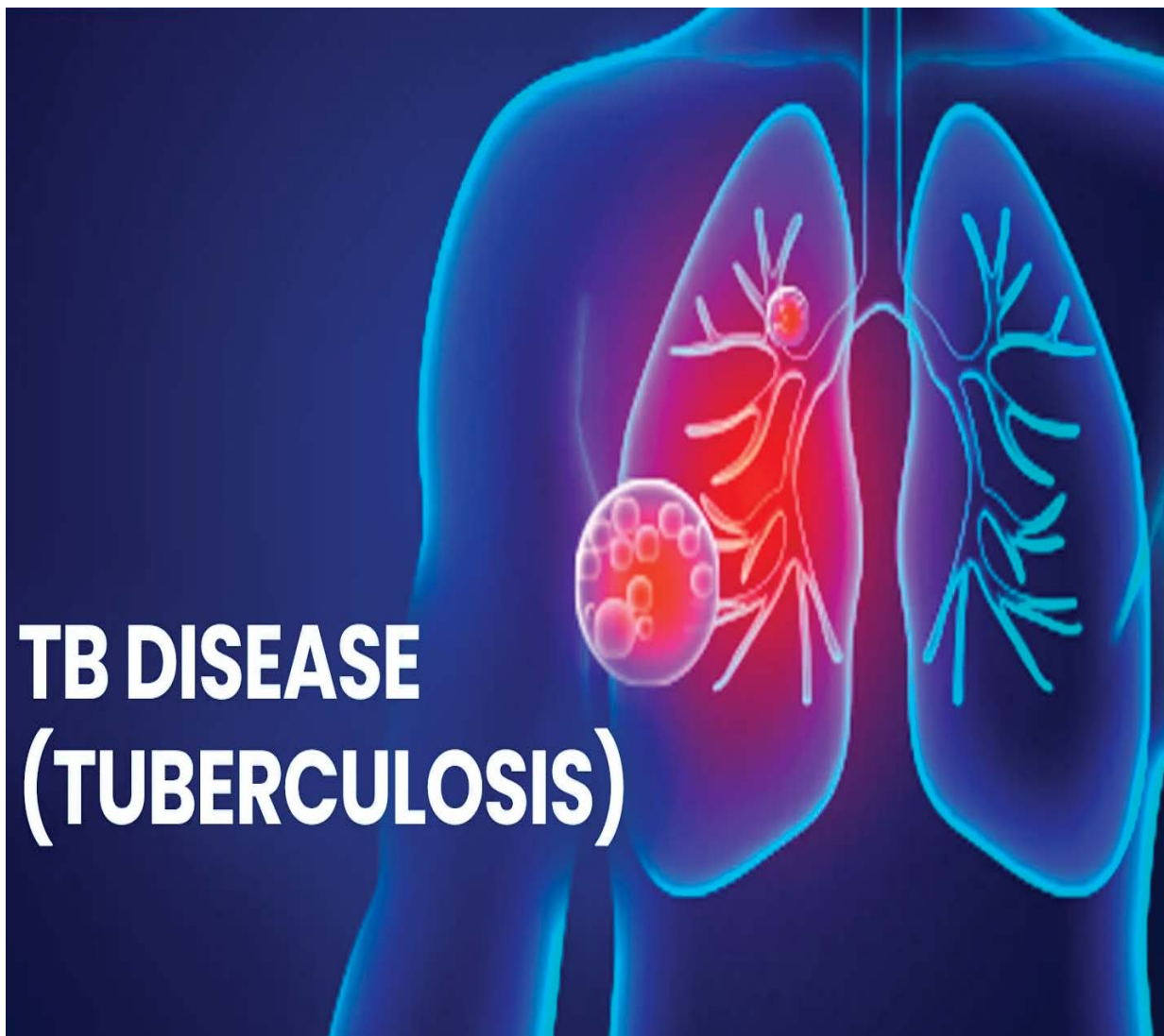
## Early Diagnosis Saves Lives: Recognizing TB Symptoms

Mangaluru, Mar 26: Tuberculosis is a communicable disease that we have been fighting worldwide since times unknown. We have come from Tuberculosis sanatoriums to give missed calls to nikshay tele support while taking medicines at the ease of our home. Yet despite all these efforts, it remains to hound us.

Therefore, what is tuberculosis and how does it affect us?

This is an infectious disease quite prevalent in our society, commonly seen to affect crowded townships with poor socioeconomic structure due to cramped homes with poor ventilation, inadequate protein diet and poor hygiene measures. However, having said that it can affect anyone who has a slightly suppressed immunity, reason being cancer treatment, HIV patients, Patients on immunomodulators and even patients undergoing any stressful life event, crash diets. The symptoms and signs depend on the organ affected and the route of entry.

The most common being droplets of cough, patients present with prolonged fever which might be daily evening rise not high grade, typically described as slight warmth of body, associated with cough which is persistent since more than 2 weeks with or without sputum, weight loss more than 10 kg or significant without any other cause, loss of appetite. While most of the symptoms are systemic labelled as constitutional symptoms, which are common irrespective of organ affected. Pulmonary tuberculosis presents with an unremitting cough, which is a red flag as it is infectious. Patients may also present with blood in the sputum which might be a few spoons or even a large bout of 500 to 1000 ml. Patients with Lymph node tuberculosis present with lymph node swelling in various areas most peculiar being cervical neck, near the ear and in armpits. These are painless cold to touch swelling on worsening lead to break down to sterile pus, which may cause it to be boggy to touch. When it breaks open, it leads to discharge and chronic non-healing sinus formation. This type is a non-infectious variety unless discharging fluids. Pleural



tuberculosis which is the TB, affecting the lining of the lung leads to chest pain on breathing, dry cough and breathlessness, these symptoms are due to filling up of fluid in this layer causing compression of the lungs and difficulty in breathing. These patients need immediate attention and drainage of the fluid, failure to do so might lead to respiratory failure and conversion to empyema or pus filled outside lungs needing surgical intervention. Patients with nervous system involvement may present initially with fits, headache, even paralysis; some may have vision problems depending on the region of brain and spine involved. TB can manifest in bones and spine

as abscesses or pus filled collections leading to poor healing and local symptoms or pain and joint swelling and immobility. In the heart the usual involvement is again the lining covering it and may fill up with fluid, this is a medical emergency as compression of the heart like lead to cardiac arrest and also needs urgent expert drainage by interventional cardiologist. In the abdomen most common presentations are abdominal pain, lymph node swelling, some may present with diarrhoea and ulcers on biopsy proven as Tuberculosis, fluid can again fill up in the abdomen known as ascites, which again requires drainage. TB of the genitourinary

tract also is common but difficult to identify hence are delayed in diagnosis, recurrent urine infection with sterile culture should raise a suspicion. Skin manifestations are plenty in number any unhealing skin lesion should be immediately consulted to a dermatologist for evaluation and the usual go to steroids medicines makes the condition worse. One has to remember that although the list of symptoms seem extensive, on correct diagnosis it is easily and completely curable with oral medicines if one adheres to the regimen thoroughly. Therefore, in case of suspicion it is best to visit a specialist and confirm.

## India's pharma exports cross \$28 billion, maintain steady growth



New Delhi, Apr 5: India's pharmaceutical sector has continued its upward trajectory, with exports surpassing \$28 billion up to February in the current financial year, registering growth of over 5 percent compared to the same period last year, according to a senior government official. Speaking at the 'Chintan Shivir: Scaling Up Pharma Exports', the official said the expansion was driven by strong demand for formulations, biologicals, vaccines, and AYUSH products. Despite global economic headwinds, the sector has remained resilient and sustained its growth momentum.

Exports during April-February FY26 stood at \$28.29 billion, marking a 5.6 percent increase over the previous financial year. Rajesh Agrawal, Secretary in the Department of Commerce, noted that even if dollar-based targets prove challenging, export figures are likely to show gains in rupee terms due to the weakening of the Indian currency against the US dollar.

He also pointed out that India's pharmaceutical exports had reached \$30.47 billion in FY24-25, reflecting a strong year-on-year growth of 9.4 percent despite pricing pressures and global trade

uncertainties.

India currently ranks third worldwide in pharmaceutical production by volume and exports medicines to more than 200 countries. Notably, over 60 percent of these exports are shipped to highly regulated markets, highlighting the industry's adherence to stringent quality and compliance standards.

The United States remains the largest destination, accounting for 34 percent of exports, followed by Europe with a 19 percent share.

Alongside pharmaceuticals, India's medical devices sector is also poised for rapid expansion. According to an earlier industry report, the segment is expected to grow to \$50.1 billion by 2030 from \$15.2 billion in 2025, driven by initiatives such as the National Medical Devices Policy, Production-Linked Incentive (PLI) scheme, and the development of medical devices parks. The report highlighted that while medical device exports reached \$4.1 billion in FY25, imports stood significantly higher at \$8.6 billion, indicating that a large portion of domestic demand—especially for advanced technology equipment—continues to be met through imports.

## The Himanta Biswa Sarma Show: Forever No.2 To No.1

Assam election 2026 is Himanta Biswa Sarma's litmus test. While he has been around in Assam politics, and very visibly so, since the 1990s, this is the election when he is the incumbent and the face. The last two BJP victories were also largely credited to him, but in 2016, he was a neo-convert to the BJP, which picked Sarbanand Sonowal as the Chief Minister after the party's first win, and fought the next election in 2021 under his leadership. Himanta was not on the ballot, so to say. He became the Chief Minister after the victory. But this time he is. After a full 5-year-term, he is trying to deliver a hat-trick for the BJP, but more than that, he is trying to make a bigger political and personal point: that he is the winner, not just a backroom boy. The stakes are highest for Sarma in 2026 than ever.

### The No.2 who always wanted to be No. 1

When former Assam Chief Minister and Congress veteran Hiteshwar Saikia was trying to bring young people to the party fold after the restive 1980s of the Assam Agitation, he found his man in Himanta Biswa Sarma. A young student activist in those days, Sarma, who had built a name for himself in campus politics by then, was associated with the influential All Assam Students Union. Since joining the Congress in 1991 and quitting it in 2015, he remained the go-getter for both Saikia and later, Tarun Gogoi. Sarma helmed key ministries such as finance, health, PWD, and was the driver of key govt programmes. But he remained No. 2. The man who was trusted by the top. The man who would get the job done. The trusted lieutenant, not the general. He thrived, he rose, but not to the top. As Tarun Gogoi's health started to fail after 2011 Assembly elections, Sarma was transparent in his ambition to be the Chief Minister. When it became clear to him that Gogoi would rather push his son, and not him, for the top, he walked away. Since joining BJP in 2015, Sarma has been the party's face not just in Assam but the entire northeast. He is the party's chief strategist, alliance maker, the opposition breaker. The man trusted by the Centre. But even in the BJP, with all the accolades, and being credited for the party's first win in 2016, he remained the necessary No.2. That jinx broke in 2021, and the BJP put Sarma in the driver's seat as Sarbanand Sonowal stepped aside. Sarma got what he always believed he deserved and worked tirelessly for it.

### Enter Chief Minister Himanta Sarma

This is the first election where Himanta is the face, front and centre, not a backroom planner and manipulator. This is his election. And he has consciously worked for it to be this way. His five-year reign has been all about himself. He is the face of the government. Learning from his own experience and political curve, Sarma has made sure that there is no No. 2 in his regime. He is a one-man show. From addressing press conferences, to inaugurations, to levelling stunning charges against his rivals, it is only the Chief Minister you see. To the extent that he even announces the board exam dates himself. It was Sarma, not a top cop, who addressed the press on the findings of SIT against Gaurav Gogoi over his alleged Pakistan connections. Sarma has imbibed the rule book of three BJP leaders - Prime Minister Narendra Modi, who is the face of all things in his government, former Madhya Pradesh Chief Minister Shivraj Singh Chouhan, who created an image of a benevolent 'mama' (uncle) for himself, and Uttar Pradesh Chief Minister Yogi Adityanath, whose contested bulldozer governance has made him a darling of hardliners as an unapologetically majoritarian leader. Sarma plays all three with great success. Welfare push of Modi, personal touch of Shivraj, and the muscular Hindutva of Yogi. The presence of bulldozers at rallies, where he dances and mingles with the people, is a stark contrast - presenting Sarma as a leader who cares for his people and would go to any extent to "protect" their interests and their "land".

# From Punishment to Reform: A Trust-Based Judicial Journey



In India's democratic system, the purpose of law is not merely to punish, but also to create an environment of order, discipline, reform, and trust. With this perspective, the Jan Vishwas Bill 2026, after being passed by the Lok Sabha, has now also been approved by the Rajya Sabha, clearing the way for its implementation as law. Through this legislation, an effort has been made to move away from a system in which minor mistakes or routine violations of rules resulted in imprisonment; now, such violations will attract monetary penalties instead. Undoubtedly, the passage of this bill is an important and historic step—like a new dawn in India's legal environment. This law clearly signals a transition from a punitive system to a reformative one. This legislation amends about 79 central laws and introduces changes in 784 provisions, with more than 700 minor offences being decriminalized. This will reduce the burden of cases in courts and ease the pressure on the judicial system. For example, even if a driving license expires, it will remain valid for 30 days, and creating a traffic jam on a national highway will attract a fine instead of imprisonment. Similarly, in many other cases, imprisonment has been replaced with financial penalties. Several of these changes are related to business regulations; for instance, earlier, violations under the Drugs and Cosmetics rules could lead to imprisonment, but now only fines will be imposed. Small business owners,



who were often fearful of punishment due to unintentional violations of complex regulations, will now feel relieved and more confident. One of the major goals of the BJP government and Prime Minister Narendra Modi has been to simplify India's systems and laws, and this legislation is a constructive step in that direction. This law will not only reduce the burden on the judicial system but will also increase trust among citizens, entrepreneurs, and investors in the government. It can be seen as a practical implementation of the concept of "Minimum Government, Maximum Governance." By emphasizing reform rather than punishment, this law will free common citizens from complicated legal procedures and corruption-prone systems. For a long time, India's legal system remained punishment-oriented, where even minor violations resulted in criminal cases. This led to a backlog of cases in courts and unne-

cessary legal complications for ordinary citizens. The Jan Vishwas Bill attempts to change this mindset. The objective of law will now not be to punish, but to reform and maintain order. Determining penalties according to the seriousness of the offence is more aligned with the fundamental principles of justice. This law will speed up judicial processes and allow greater focus on serious crimes. It is also a major step toward judicial reform because it will save the time and resources of courts, making the justice system more efficient. Another important objective of this law is to create an environment of trust in the business and industrial sectors. Previously, even minor regulatory violations led to criminal cases, creating fear among entrepreneurs and investors. Now, with provisions for monetary penalties instead of criminal prosecution, compliance burdens will be reduced and ease of doing business will improve.

This will encourage small entrepreneurs, startups, and industries, and further improve the investment climate in India. Globally, India's image as a simple and investment-friendly country will also be strengthened. One of the most significant aspects of this law is that its spirit closely reflects Indian culture. In Indian tradition, reform is valued more than punishment, forgiveness more than revenge, and correction more than condemnation. Our scriptures and traditions acknowledge that human beings are prone to mistakes, but they must be given an opportunity to improve. Harsh punishment for minor mistakes may sometimes be closer to injustice than justice. Therefore, if the legal system incorporates forgiveness, reform, and correction, society can become more humane and sensitive. Indian culture has historically been reformative and harmonious rather than punitive.

## The journey from generic to innovative

(Leading in export of low-cost medicines, but dependent on imports for active ingredients)

India has today become one of the largest suppliers of affordable medicines globally. Its recognition as the "pharmacy of the world" is not just a metaphor, but a powerful testament to its production capacity, export expansion, and contribution to global public health. By 2025-26, the Indian pharmaceutical market will surpass \$50 billion and contribute more than 20 percent to the global generic drug supply. Even in developed countries like the United States, Indian companies supply approximately 40 percent of generic medicines, while India plays a crucial role in the availability of life-saving medicines in regions like Africa and South Asia. This achievement is a result of changes in patent laws in the 1970s, when India adopted a process patent system, empowering domestic industry and paving the way for the production of affordable medicines. But behind this dazzling achievement lies a profound contradiction. While India is a major exporter of finished medicines, it is also heavily dependent on imports for the raw materials and active pharmaceutical ingredients needed for their manufacture. It is estimated that India imports approximately 60 to 70 percent of its active pharmaceutical ingredients, with the major share coming from China. For critical ingredients like penicillin G, clavulanic acid, and paracetamol, this dependence exceeds 80 percent. This situation is a serious concern not only from an economic perspective, but also for national security and supply chain stability. The COVID-19 pandemic starkly exposed the reality of this dependence. As soon as the lockdown in China disrupted supplies, pharmaceutical production in India was affected. Many pharmaceutical manufacturing units had to reduce production and some had to temporarily

shut down. This made it clear that disruptions in the supply of raw materials could immediately impact India's pharmaceutical production capacity. This experience made the need for self-reliance even more relevant. In this context, the government announced an investment of approximately ₹16,000 crore through the Production Linked Incentive Scheme, which aims to promote domestic production of active pharmaceutical ingredients. Although some progress has been made, several structural problems remain. High production costs, technical limitations, and stringent environmental regulations have led to the closure of many manufacturing units, limiting domestic production capacity. Weak regulatory frameworks also pose a major challenge in this sector. Drug regulatory agencies at the central and state levels clearly lack resources and trained manpower. Several Indian pharmaceutical manufacturing facilities have faced international criticism due to lapses in quality control. In some cases, import restrictions have been imposed by foreign regulatory bodies due to manufacturing process flaws and violations of quality standards. This impacts India's global reputation and adversely affects export prospects. Additionally, the growing market for counterfeit drugs is emerging as a serious problem. This not only poses a threat to consumer health but also undermines the credibility of the pharmaceutical industry. Price control policies limit companies' profitability, preventing them from investing adequately in research and development and limiting them primarily to generic production. Lack of investment in research and development is a major weakness of the Indian pharmaceutical sector. While global pharmaceutical companies spend a significant portion of their revenue on research, this proportion in India is relatively low. As a result, India lags behind in emerging areas such as innovation-based medicine, biological drugs, and personalized medicine. These areas are expected to grow rapidly in the future, and if India does not increase investment in these areas in time, it could fall behind in global competition. Lack of skills development also poses a significant obstacle. Advanced pharmaceutical manufacturing, biotechnology, and artificial intelligence-based research require trained human resources, which are currently insufficiently available. Lack of proper coordination between

educational institutions and industry prevents students from gaining practical knowledge, which hinders the pace of innovation. Environmental challenges are also affecting the sector. The pharmaceutical manufacturing process is energy-intensive and polluting, making it expensive to comply with environmental standards. This increases production costs and reduces competitiveness. Furthermore, limited use of digital technology creates obstacles in supply chain management and quality monitoring. To address these challenges, a comprehensive, balanced, and long-term strategy is essential. First, domestic production of active pharmaceutical ingredients must be promoted. This should be done by expanding production-based incentive schemes and developing industrial clusters. Small and medium-sized enterprises must be encouraged and enabled to actively participate in this sector. Second, the government must prioritize research and development by taking concrete steps to increase tax incentives and strengthen public-private partnerships. The use of modern technologies such as artificial intelligence and machine learning can make the drug discovery process faster and more effective. Third, regulatory reforms are essential. Drug regulatory bodies must be provided with greater resources, technical capacity, and autonomy. Quality monitoring and transparency must be ensured through digital platforms. Skill development also requires special attention. Developing a better synergy between educational institutions and industry will promote practical training to create a competent and innovative workforce. Adopting green technologies is also essential for environmental sustainability. This will not only ensure environmental protection but also reduce production costs and increase competitiveness. Ultimately, India must not limit its role to merely a supplier of affordable medicines, but must move towards establishing global leadership in innovation-based medicines, biological products, and personalized medicine. This requires a clear vision, strong policy support, and sustained investment. If India successfully addresses these challenges, it will not only strengthen its self-reliance but also emerge as a leading force in the global pharmaceutical landscape.

## From Red Corridors to Strategic Horizons: India After Naxalism

"For communities that lived for decades between fear and neglect, this transition marks the first credible and continuous presence of the state in everyday life." After decades of internal unrest, India stands at the cusp of a structural transition—from chronic insurgency to a new phase of consolidated state authority. This milestone goes beyond the resolution of a security challenge; it opens a new chapter of deeper integration, sustainable governance, and expanded strategic horizons, positioning the nation with renewed credibility both domestically and globally. Tracing back to Naxalbari in 1967, the movement evolved into a contest over state authority across central and eastern India. The Communist Party of India (Maoist) entrenched itself in inaccessible terrain, social grievance, and chronic administrative absence. As Manmohan Singh observed, Naxalism was India's "single biggest internal security challenge"—not only for its violence, but for the structural limits it imposed. Long before casualties were inflicted, the insurgency curtailed governance reach, stifled developmental momentum, and constrained strategic confidence. The insurgency's rollback reflects a steady consolidation of state authority across regions once defined by absence rather than governance. Coordinated security operations cleared territory, disrupted insurgent networks, and reasserted the state's writ. These gains were reinforced through roads, telecommunications, banking access, schools, and health infrastructure. What unfolded was a security-led state-building enterprise. This sequence—from stabilisation to governance—transformed episodic presence into enduring authority, laying the foundation for long-

term integration. Central to this transformation was sustained political prioritisation, particularly under Narendra Modi, whose tenure integrated security, development, and governance into a unified strategy. The aim was not only to neutralise insurgency, but to dismantle the conditions that sustained it, ensuring territorial control became durable rather than transient. This vision converted the fight against insurgency into a blueprint for institutional expansion and developmental integration. Geography underscores the broader stakes. Former Left Wing Extremism-affected districts coincide with mineral-rich and rare-earth-bearing belts essential to India's industrial base and strategic autonomy. For decades, insecurity imposed a silent tax—detering investment, fragmenting logistics, and excluding regions from national supply chains. Stabilisation now transmutes these liabilities into strategic economic assets, enabling infrastructure corridors, regulated resource extraction, and integration into national production networks. Where violence once vetoed development, governance can now accelerate it. This trajectory has been consistently recognised in policy and institutional assessments. National security leadership, articulated by Ajit Doval, has underscored that internal instability imposes enduring strategic and economic costs. Global institutions, including the World Bank, document how conflict suppresses growth and deters long-horizon investment. Domestic evaluations by the NITI Aayog identified affected districts as persistent development outliers due to chronic insecurity. The difference today is tangible: diagnosis has

translated into decisive action. The convergence of security, development, and governance now projects India's credibility beyond its borders. Internal instability was long perceived as political risk; territorial control is now a prerequisite for investor trust and strategic partnership. Rival powers often assumed domestic disorder would cap ambition. As India positions itself as a manufacturing hub and supply-chain alternative, internal stability underwrites confidence, attracts long-horizon capital, and reinforces global credibility. For the first time since Independence, India's internal map no longer constrains external ambition. Foreign policy credibility for rising powers rests as much on domestic control as diplomatic articulation. The international system evaluates states not only by growth metrics or rhetoric, but by their ability to govern territory and integrate peripheries. A post-Naxal India signals durable state capacity—an unambiguous marker of strategic bandwidth expanded through domestic consolidation. Achieving this outcome required sustained sacrifice. Thousands of personnel from the armed forces, Central Armed Police Forces, civil services and state police served in unforgiving terrain under constant threat. Many were injured; many did not return. As Amit Shah has emphasised, success stemmed from decisive political resolve, coordinated Centre-state action, and frontline courage. Victory here is measured not abstractly, but in lives placed at risk and duty fulfilled. With the security phase receding, the imperative now is governance. Integration must be comprehensive—regions, commu-

# Yellow metal falls 7% during the US-Iran war. Is it a right time to buy gold?

US-Iran war: Safe haven asset gold has remained volatile since the beginning of the US-Iran war. Despite continued geopolitical tensions, gold prices have declined by nearly 7% since February 28, indicating a shift in investor preference toward the US dollar as the primary safe-haven asset. Gold prices rose around 2.2% over the week, though gains were limited as crude oil jumped more than 10%, heightening inflation worries and disrupting the usual safe-haven appeal, according to Sugandha Sachdeva, Founder of SS WealthStreet. COMEX gold settled at \$4,679.70 per ounce, while MCX gold closed at ₹1,49,650 per 10 grams for the week. Why are gold prices falling? Sachdeva further explained that the geopolitical developments remain uncertain as early indications from Donald Trump and Iran pointed toward a possible ceasefire, but the tone has since shifted, with stronger rhetoric and fresh threats of extended military action. Meanwhile, Iran's IRGC Navy continues its blockade of the Strait of Hormuz,



keeping oil prices elevated, fuelling concerns around imported inflation, and strengthening expectations of a tighter monetary policy stance in the US. From a macro standpoint, the US economy showed resilience in March, with labour market data exceeding expectations. Non-farm payrolls rose by 178K against estimates of 65K, the unemployment rate came in lower at 4.3% versus the 4.4% forecast, and wage growth remained steady. These factors reinforce the likelihood of the Federal Reserve main-

taining a hawkish stance, which supports the dollar and caps gains in bullion. Meanwhile, continued ETF outflows during March, with redemptions far outpacing inflows, signal weakening investor demand for gold, Sachdeva opined. Gold prices likely to remain volatile Sachdeva believes that as long as oil prices remain elevated and rate-cut expectations stay delayed, bullion is likely to witness sharp, headline-driven volatility rather than a sustained directional rally. "In essence, gold remains

caught between geopolitical uncertainty and macro headwinds, with price action increasingly dictated by crude oil trends and dollar strength," she added. Meanwhile, Ponnudi R, CEO of Enrich Money, said that overall sentiment remains cautiously optimistic, with commodities slowly transitioning from consolidation to a recovery phase. However, the lack of strong follow-through buying across global markets clearly indicates a wait-and-watch approach. "Investors are pricing in uncertainty,

but not committing to a clear trend. Near-term direction will remain event-driven, influenced by currency movement, central bank signals, and evolving geopolitical developments, particularly in the Middle East and global growth outlook," Ponnudi added. Technical outlook of the gold prices On the technical outlook of COMEX gold, Ponnudi said that the prices are holding above key short-term moving averages while continuing to face resistance in the \$4,700-\$4,750 zone. Price action indicates underlying weakness, with geopolitical support failing to generate strong upside momentum. "A decisive breakout above \$4,800 can push prices toward \$4,850, with further upside extending to \$4,900, where strong supply is expected. On the downside, a sustained break below \$4,600 may accelerate selling toward \$4,550-\$4,500, with extended weakness dragging prices toward \$4,400. The overall structure remains fragile, with downside risks dominating unless key resistance levels are reclaimed," he added.

## Amul crosses Rs. 1 lakh crore mark, reports 11% growth



New Delhi: Dairy major Amul on Sunday said its total turnover rose 11 per cent in the last fiscal year to cross the Rs 1 lakh crore milestone on better demand for dairy products. In a statement, the Gujarat Cooperative Milk Marketing Federation Ltd (GCMMF) said the total turnover of the Amul brand crossed the Rs 1 lakh crore mark for the financial year 2025-26. "The total unduplicated revenue of the Amul brand has increased by 11 per cent over a base of Rs 90,000 crore in 2024-25," it added. The turnover of GCMMF, which sells products under the Amul brand, grew 11.4 per cent to Rs 73,450 crore last fiscal from Rs 65,911 crore in the preceding financial year.

"The surge is powered by a massive product portfolio of more than 1,200 product packs, a vast distribution network, and a rapid adaptation to the evolving needs of modern consumers," GCMMF said. Amul's entry into overseas markets, including fresh milk sales in Europe and the US, played a key role in FY26 growth. This expansion aligns with a broader strategy to make Amul a household name globally, echoing India's ambition to place its food products on dining tables worldwide. The move also ensures that gains from technology and trade reach farmer-members directly. India's dairy sector is experiencing renewed export momentum,

with rising global demand and diversification away from traditional suppliers. Amul's scale, cost advantages, and processing capabilities position it well to capture market share. However, sustaining this growth will require navigating global competition, compliance with evolving standards, and consolidating its domestic dominance. If Amul successfully scales its cooperative model nationally and deepens overseas penetration, it could emerge as a top-tier global dairy brand within the decade. Alternatively, failure to adapt to global regulatory and competitive pressures could slow momentum, confining growth largely to domestic markets.

## Apple at 50: Products that changed how we live - and that really didn't

Few companies have managed to define how people use technology in their everyday lives as resoundingly as Apple. The company, which celebrated its 50th birthday this week, was started by two Steves in a San Franciscan garage. It has had some truly standout successes - and some notable flops. These days, nearly one out of every three people on the planet owns an Apple product - a success that Emma Wall, chief investment strategist for financial services company Hargreaves Lansdown, said had as much to do with the company's marketing as it did its hardware. "They sold a dream," she said, and they added something that was "quite new at the time - the idea that branding was as important as the product line". Apple's string of hits has arguably slowed since the death of its visionary co-founder Steve Jobs, as the company focuses more on refining its existing technology. Ken Segall, Jobs's creative director for 12 years, told the BBC that Apple's current chief executive, Tim Cook, had done an "amazing job" at



changing with the times and keeping the company profitable. But he added that many Apple purists still do not feel as excited by the company's current phase because "they remember that older Apple was Steve Jobs". As the company pushes past its half-century, we asked technology analysts and experts to take a look at some of the significant ways the company changed the tech world, and some of the ways it arguably missed the mark. While by no means the first portable digital music player when it was released in 2001, the iPod

is one of "Apple's most iconic products" argued Craig Pickering of The Apple Geek. Not just because of what it was, but "because of what it changed". "MP3 players were clunky, storage was limited, and managing your music library felt like a chore," he said. "The iPod changed all of that almost overnight." The click-wheel design distinguished the device and introduced the iTunes library, paving the way for legal digital music downloading to hit the mainstream. Released in 2007, the iPod Touch was designed by the same team,

who later invented the iPhone - which quickly overshadowed the iPod. "Without the iPod, Apple would likely have lacked both the financial strength and the operational maturity required to take on the complexity of the smartphone industry," said Francisco Jeronimo, technology analyst at market research firm IDC. More than 200 million iPhones are sold each year - with roughly seven purchased somewhere in the world every second. To Ben Wood of CCS Insight, a market research firm, it is the "Hotel California of smartphones" - once you have one, you are "very unlikely to leave" the Apple ecosystem for a rival Android-powered device. "An iPod, a phone, and an internet communicator. These are not three separate devices, this is one device," said a beaming Steve Jobs holding up the first edition of the phone at its unveiling to the world in 2007. Like many revolutionary Apple products, the iPhone was not the first example of its kind - other phones had internet capabilities.

## Moody's cuts India's FY27 GDP growth estimates to 6 pc amid West Asia conflict

New Delhi: Moody's Ratings has slashed India's economic growth estimates for the current fiscal to 6 per cent from 6.8 per cent earlier, saying the ongoing conflict in West Asia will moderate growth momentum and raise inflation risks. In its credit opinion report on India, Moody's said prolonged disruptions, particularly LPG shipments due to the conflict, would lead to near-term household shortages, higher fuel and transport costs, and spillovers to food inflation through India's reliance on imported fertilisers. The region accounts for around 55 per cent of crude oil imports and over 90 per cent of liquefied petroleum gas (LPG) supplies to India. "While inflation remains contained for now, geopolitical risks have tilted the inflation outlook to the upside," Moody's said while projecting inflation to average 4.8 per cent in FY27, up from 2.4 per cent in FY26. With inflation risks re-emerging and growth remaining robust, policy rates are like-



ly to be held steady or raised gradually in fiscal 2026-27, depending on the duration of geopolitical tensions and their pass-through to food and fuel prices, Moody's said. "In light of India's economic exposure to the ongoing military conflict in the Middle East, we expect real GDP growth to moderate to 6 per cent in fiscal 2026-27 from 6.8 per cent earlier, driven by subdued private consumption, softer industrial activity and a weakening in the momentum of gross fixed capital formation amid elevated prices

and higher input costs," according to the Moody's report, dated March 31, accessed by PTI. Last month, the Organisation for Economic Cooperation and Development (OECD) projected India's GDP growth to moderate to 6.1 per cent in the current fiscal from 7.6 per cent growth recorded in 2025-26. Besides, an Economy Watch report by EY has said that India's real GDP growth for FY27 could erode by around 1 percentage point, while retail inflation could rise by about 1.5 percentage points from their baseline estimates if the West Asia conflict persists through 2026-27. Domestic rating agency Ica expects the growth to moderate to 6.5 per cent in FY27, owing to the adverse impact of elevated energy prices and concerns around energy availability amid the West Asia conflict. It further said the government's sustained emphasis on infrastructure spending and a gradual easing of trade barriers will continue to support investment activity. India's real GDP growth remained robust at 7.5 per cent in calendar year 2025, up from 7.2 per cent in CY 2024 and the highest among G-20 economies, driven primarily by a strong rebound in manufacturing. Moody's said elevated oil, gas and fertiliser prices would intensify pressures on targeted subsidies, resulting in higher outlays, alongside revenue erosion compared to the budget. Global crude prices have risen by almost 50 per cent since the United States and Israel launched military strikes against Iran on February 28, triggering sweeping retaliation from Tehran.

## RBI policy, US-Iran tensions likely to drive stock market next week

Mumbai: Indian stock markets ended their sixth consecutive week lower, with benchmark indices slipping nearly 0.5 per cent amid heightened volatility triggered by a mix of global uncertainties and domestic concerns. Investors are now bracing for another eventful week, where the Reserve Bank of India's policy decision, escalating geopolitical tensions, and surging crude oil prices are expected to dictate market direction. The holiday-shortened week began on a weak footing, as rising tensions between the United States and Iran, coupled with a sharp spike in crude oil prices, dented investor sentiment and led to broad-based selling. However, markets staged a midweek recovery as fears of an immediate escalation eased and oil prices showed some signs of cooling. Despite the rebound, volatility remained elevated due to inconsistent global cues, persistent foreign institutional investor outflows, concerns over inflation, and



a weakening rupee. By the end of the week, the Nifty settled at 22,713.10, while the Sensex closed at 73,319.55. Commenting on Nifty technical outlook, experts said that from a technical standpoint, the 22,150-21,900 zone is likely to act as a key support area. "On the upside, resistance is seen in the 23,000-23,500 range. The Relative Strength Index (RSI) on the weekly timeframe stands at 27.88," an analyst stated. Looking ahead, all eyes will be on the upcoming monetary policy decision by the Reserve Bank of India. The Monetary Policy Committee (MPC) is scheduled to meet from April 6 to April 8 for its

first session of FY27. Geopolitical developments will also remain a key overhang. The ongoing conflict between the United States and Iran appears to be intensifying, with reports of military escalation and strong warnings issued by Donald Trump. Any further deterioration in the situation could significantly impact global risk sentiment and trigger fresh volatility in equities. Crude oil prices, already on a sharp upward trajectory, will be another crucial factor. Brent crude has surged to around \$109 per barrel following disruptions in the Strait of Hormuz, a vital artery for global energy supplies.

## IPO PIPELINE STRENGTHENS; 38 COS FILE DRAFT PAPERS IN MARCH

New Delhi: As many as 38 companies, including SBI Funds Management and Manipal Health Enterprises, filed preliminary IPO papers with Sebi in March 2026, signalling improving issuer sentiment even as regulatory timelines contributed to the surge. This marks a sharp jump from 22 filings in March 2025 and 16 in March 2024, data from the Securities and Exchange Board of India (Sebi) showed, indicating a stronger pipeline of public issues. The momentum is expected to continue, with several high-profile companies, including the National Stock Exchange (NSE) and Reliance Industries' telecom arm Jio, preparing to submit their draft papers in the coming weeks, according to merchant banking sources. In addition, Singapore-based Sembcorp Industries' Indian renewable energy arm, Sweden-based Modern Times Group's subsidiary PlaySimple, TPG-backed



online lending platform Fibe and Tiger Global-backed BatterySmart are also likely to file DRHPs soon, they added. Of the 38 companies that filed their draft papers with Sebi, a total of 9 firms, including Zetwerk, SNVA Traveltech, Rediff.com India, Torrent Gas, Synergy Advanced Metals, Garuda Aerospace, and Sohan Lal Commodity Management, opted for the confidential filing route. According to Axis Capital report, as many as 64 companies have filed Draft Red Herring Prospectuses (DRHPs) with

Sebi and are awaiting clearance, while 124 companies have already received regulatory approval but are yet to hit the market. Another 20 firms have filed confidential DRHPs since March 2025. The report further noted that FY2025-26 (up to March-end) saw 109 mainboard IPOs, of which 69 listed above their issue price, while three companies were yet to debut on the exchanges as of March 31, 2026. The IPO market is expected to gain further momentum in the first quarter of FY2026-27, supported

by a robust pipeline, with a large number of companies both awaiting Sebi approval and holding valid approvals for launch, it added. So far in 2026, 18 companies have launched IPOs, with 8 issues hitting the market in March alone despite volatile market conditions and geopolitical tensions. On the other hand, digital payments company PhonePe temporarily deferred its public market listing process due to the current geopolitical conflicts and market volatility. However, Sameer Nigam, PhonePe's CEO, stated the company remains committed to a public listing in India. Market participants said the spike reflects a combination of improved issuer confidence and regulatory considerations. Feroze Azeez, Joint CEO at Anand Rathi Wealth, said the surge cannot be attributed to timelines alone. "It is a mix of both issuer confidence and regulatory compliance pushing filings before

March-end, but it would be too simplistic to attribute it only to timelines," he said. Echoing a nuanced view, Pratik Loonker, MD & Head-ECM and Co-Head-Financial Sponsor Group at Axis Capital, said the trend is driven more by preparedness than outright confidence. "Given regulatory approval timelines and the difficulty of timing markets, companies are filing early to stay ready for favourable windows as they emerge. Regulatory approvals are valid for up to 12 months," he said. Typically, companies tend to file towards the end of the financial year to keep their approval window open. However, the scale of filings this time is notable, with more than a dozen firms submitting DRHPs in the last two days of March alone, Azeez added. Importantly, the quality of companies entering the IPO pipeline also points to improving sentiment.

# Trump issues expletive-laden threat to Iran demanding Strait of Hormuz be opened

US President Donald Trump says he is considering "blowing everything up and taking over the oil" in Iran if a deal to end the war is not reached quickly, Fox News reports. But, in the interview with Fox's chief foreign correspondent, Trump says there is a "good chance" a deal will be reached tomorrow. Mahdi Tabatabaei, an aide at Iran's President's Office, says the Strait of Hormuz "will be reopened" when "a portion of transit tolls is used to compensate for all the damage caused" by the war. Iranian officials and lawmakers have previously raised the possibility of imposing transit fees or tolls on vessels using the strait. Responding to Donald Trump's latest comments, Tabatabaei says the US president "has instigated a full-scale war in the region and is still issuing threats". He says Trump's "insults and nonsense" are born of "sheer desperation and anger". The key battleground between Iran



and the US may now be at sea, not on dry land. President Trump has repeated that the Strait of Hormuz must be re-opened or - come Tuesday - Iranians will be "living in hell". The narrow waterway, which connects the Gulf and the Arabian Sea, used to be the route for one fifth of global oil supplies. Not anymore. With the US countdown under way, we headed for the strait - or as

close as we could get - setting sail from the port of Khasab, on the coast of Oman. The view from our dhow, a traditional wooden sailing boat, was of ships at anchor close to the mouth of the strait. We counted eight vessels just one nautical mile ahead of us. Maritime organisations say as many as 2,000 are stranded in the area. Under clear blue skies, with the sun glinting on the waves, the strait

looked calm and peaceful - but is now perhaps the most powerful weapon in the hands of Iran. A container ship in the UAE has reported "multiple splashes from unknown projectiles" nearby, according to UK Maritime Trade Operations (UKMTO). The incident happened at Khor Fakkan Port while the container was being loaded, UKMTO says. UKMTO is a Royal Navy-led

organisation that liaises between merchant shipping and military forces for maritime security. Iran has said "non-hostile vessels" can use the Strait of Hormuz, but the war - in which several ships have been attacked - has halted normal transport activity. Last week commercial ships anchored off the UAE and Qatar were struck by projectiles. The Strait of Hormuz is a key trade artery through which around 20% of the world's oil passes. Since the beginning of the US-Israeli war with Iran, numerous ships have come under attack in the area. About 3,000 ships usually sail through the strait each month but this has dramatically decreased recently, with Iran threatening to attack tankers and other ships. About one-third of the world's fertiliser trade also passes through the strait, and it is a vital channel for imports to the Middle East, including food, medicines and techno-

logical supplies. The effective blockade of the the strait has caused energy prices to spike. There are fears it could fuel higher inflation. Donald Trump has just repeated his threats to Iran unless it opens the Strait of Hormuz by 6 April. He has shifted his deadlines during the war - here's a recap. Deadline 1: On 21 March, Trump said he would "hit and obliterate" power plants, "starting with the biggest ones first", if Iran didn't reopen the waterway within 48 hours. Deadline 2: Two days later, he said there had been "very good and productive conversations" between the countries and postponed strikes against energy infrastructure for five days. Deadline 3: On 27 March, Trump said he would postpone attacking energy plants for 10 days, "as per [an] Iranian government request", bringing the deadline to 6 April. 48-hour warning: Yesterday, with the 6 April deadline looming.

## AI VIDEOS FUEL RHETORIC AS ORBÁN BIDS FOR FOUR MORE YEARS IN HUNGARY



When a video went viral appearing to show a Hungarian soldier's execution, its disturbing nature came as a shock to anyone who saw it. Ahead of pivotal Hungarian elections on Sunday 12 April, the AI-generated, fake clip was posted on the social media accounts of Prime Minister Viktor Orbán's Fidesz party in February. It tells the story of a young girl at a window yearning for her father's return home from war, and then the video cuts to him - blindfolded, bound by the hands, and then shot by his captors. The video targeted Orbán's election rival, Péter Magyar, who could unseat him after 16 years in office.

The Fidesz campaign has made unsubstantiated claims about the war in Ukraine and Magyar's intentions, at times using AI-generated videos like this, even though it makes clear the video is fake. "The video is an AI video, but the war is really horrible," the video says. "Péter Magyar doesn't want you to see this video. He doesn't want you to see what an irreversible tragedy it is to join a war." Fidesz alleges that Magyar, from the centre-right party Tiszta, will bring Russia's war against Ukraine to its doorstep if elected, even using pension money to support Ukraine and imposing forced conscription.

## Man charged over fatal shooting of baby in pram in New York



A man has been charged with murder after a seven-month-old baby died after being shot while sitting in her pushchair in New York. Amuri Greene, 21, has been charged with three counts of murder and one of attempted murder after police accused him of fatally shooting Kaori Patterson-Moore on 1 April. Greene appeared in court on Friday where he pleaded not guilty, according to CBS News, the BBC's US partner. Officers believe the baby was the unintended victim of a gang-related shooting. Police said a second suspect, Matthew Rodriguez, 18, had been arrested in connection with the shooting in Pennsylvania and charges were pending. Footage from the incident appears to show two men on a motorcycle riding against the flow of traffic through the Williamsburg neighbour-

hood of Brooklyn, before a man on the back of the vehicle took out a gun and fired, police said. Officers believe Greene carried out the shooting and was on the back of the scooter, CBS reported. He was thrown from the vehicle following the incident and was taken to hospital for treatment where he was placed in police custody. Greene also pleaded not guilty to charges of five counts of criminal possession of a weapon, two counts of attempted criminal possession of a weapon, and two counts of assault, CBS reported. Rodriguez is believed to be the man seen driving the scooter the gunman was on during the shooting. The driver crashed into oncoming traffic after the gunfire and fled, police said. Family and friends gathered on Friday night for a candlelight vigil at the corner where the shooting took place.

## CAMBODIA UNVEILS STATUE TO HONOUR FAMOUS LAND-MINE-SNIFFING RAT



A famous mine-clearing rat, who was awarded a gold medal for his heroism, has been commemorated with the world's first statue dedicated to a landmine-detecting rat. Magawa, who lived to eight years old, sniffed out over 100 landmines and other explosives in Cambodia during his five-year career that started in 2016. A statue of the rodent carved from local stone by artists was unveiled in Siem Reap, Cambodia on Friday, in time for the International Day for Mine Awareness on 4 April.

Landmines remain an ongoing risk to Cambodia, and more than a million people continue to work and live on land contaminated by mines and unexploded ordnance, according to the United Nations. Magawa, an African giant pouched rat, was trained by the Belgian charity Apopo before moving to Cambodia to begin his bomb-sniffing career in 2016. Using his acute sense of smell and training to detect a chemical compound within explosives, Magawa would then alert human handlers of mines that could be later safely removed. During his time, Magawa cleared more than 141,000 square metres (1,517,711 sq ft) of land - the equivalent of 20 football pitches - and could search a field the size of a tennis court in just 20 minutes.

## US AIRMAN INJURED BUT SAFE AFTER RESCUE FROM INSIDE IRAN

A second US crew member who was missing in Iran after an American F-15 fighter jet was shot down has been rescued. Posting to social media, US President Donald Trump said the rescued weapons systems officer had "sustained injuries" but would be "just fine", describing the rescue as "one of the most daring search and rescue operations in US history". Following the downing of the aircraft on Friday, both the pilot and crew member ejected - with the pilot recovered shortly afterwards. Following this, both the US and Iran scrambled to locate the missing crew member in a mountainous region of southwestern Iran. The search presented a serious test for the US, with the possibility of a prisoner of war situation if Iran found



the missing airman - something which would have likely involved him being used as part of propaganda material. Iran's Islamic Revolutionary Guard Corps (IRGC) was said to have launched its own search for the missing American, reportedly using troops and locals, and offering them a reward of about \$66,000 (£50,000) to capture him alive. Videos on social media

appeared to show hundreds of people heading to a mountainous area in south-western Iran to search for the missing US airman. Details of the second airman being rescued emerged in US media late on Saturday night. A short time later, Trump confirmed the successful mission on Truth Social, writing "WE GOT HIM!", adding the crew member was a "respected colonel". The US rescue operation was described to the BBC as "huge" by one person familiar with the details. The BBC understands that there was an engagement between the US and Iranian forces during the rescue, and that the pilot may have been injured during his initial ejection from the aircraft. Tasnim, the semi-official news agency associated with the IRGC, said five Iranians were killed during the operation. Trump said dozens of aircraft had been involved in the operation, with the White House not giving an update after the pilot was recovered on Friday to protect the ongoing rescue. Earlier reports suggested the missing crew member might be in the mountainous area of Kohgiluyeh and Boyer-Ahmad province, in the southwestern regions of Iran.

## POPE LEO CALLS FOR GLOBAL LEADERS TO CHOOSE PEACE IN HIS FIRST EASTER MASS

Thousands of worshippers flocked to St Peter's Square on Sunday to hear Pope Leo XIV deliver his first Easter Mass address as pontiff. Framed by white roses on the central balcony of the Vatican's basilica, the pope called on "those who have the power to unleash wars" to choose peace. "On this day of celebration, let us abandon every desire for conflict, domination and power, and implore the Lord to grant his peace to a world ravaged by wars," he said. The first US-born pope has become a vocal critic of the Iran war, and has used recent public addresses to denounce global conflicts and urge de-escalation.



Pope Leo waved to the crowd gathered in the square below before delivering his "Urbi et Orbi" blessing - Latin for "to the city and the world". St Peter's Square was decorated with bright spring blooms, with rows of daffodils and thousands of pur-

ple, red and white flowers arranged for the Easter Mass. "We are growing accustomed to violence, resigning ourselves to it, and becoming indifferent, indifferent to the deaths of thousands of people," the pope said in his address. "Let those who have weapons lay them down. Let those who have the power to unleash wars choose peace." In a break with recent tradition, Leo did not explicitly name any country or conflict in his message. He paid tribute to his predecessor, Pope Francis, who gave his final address on Easter Sunday last year hours before his death. Referring to the Easter story of Christ's resurrection, three days after he was nailed to the cross, he said Jesus had been "entirely nonviolent" in the face of suffering. For Christians, Easter is the most important date in the liturgical calendar, marking the resurrection of Christ - a central tenet of the faith.

## Artemis's stunning Moon pictures - science or holiday photos?



Nasa is releasing a steady stream of stunning pictures of the Moon and Earth taken by the astronauts on its Artemis II Moon mission. Attracting millions of likes on social media, the images show the two bodies from unusual angles in glorious high definition. There is no denying the drama: four astronauts are embarking on a mission that will take them further from Earth than any human has ventured since 1972. But is there unique scientific value in these images, or are these simply the equivalent of holiday photos? Nasa wants the American public behind them to support the mission. They are live-streaming the 10-day journey, and the four astronauts are doing regular video updates, describing their progress in triumphant tones. The crew have been so excited to watch the world and Moon go by, Nasa has said, that the window inside the Orion spacecraft got dirty and the astronauts were sent instructions on how to clean it. This is the first time that digital cameras have been taken this far into space. Orion has 32 cameras and devices - 15

mounted onto the spacecraft and 17 handheld by the crew. According to Nasa, the astronauts are using standard 10-year-old cameras, including the Nikon D5, as well as GoPros and smartphones. Nasa's photostream on flickr even tells you the device used to take each of the published photos. On Friday we saw the first results of their intense observations. "Hello, World" was taken by Commander Reid Wiseman when the mission was about equidistant from the Moon and Earth - 142,000 miles (228,500 km) from Earth, and 132,000 miles from the Moon. It shows two auroras as the Earth eclipses the Sun, and the planet Venus glowing at the bottom of the image. Our planet appears upside down, with the Sahara desert and the Iberian peninsula visible to the left and the eastern portion of South America to the right. It's a lovely picture, but nothing new when it comes to science. In fact, Nasa has a satellite with its Deep Space Climate Observatory with a camera called Earth Polychromatic Imaging Camera (Epic).

# LSG BEAT SRH TO ACHIEVE 1ST WIN OF IPL 2026

Mohammed Shami asked probing questions not only to Sunrisers Hyderabad batters but also to the national selection committee with an opening spell for ages while skipper Rishabh Pant upped his game when it mattered to headline Lucknow Super Giants' thrilling five-wicket victory in an IPL 2026 match on Sunday. In a spell that oozed skill and class in equal measure, Shami bowled an astounding 18 dot balls to finish with 2 for 9 in four overs which largely became responsible for Sunrisers Hyderabad being restricted to 156 for 9. LSG rode on Aiden Markram's 27-ball-45 and skipper Rishabh Pant's 50-ball-68 not out to surpass the target with one ball to spare. The chase got a touch tricky towards the end with 9 needed off the final over but Pant smote Jaydev Unadkat for two straight boundaries - second a fore-



hand tennis like slap before another lofted boundary over mid-off to finish the game in style. It was an innings that had nine boundaries and his choice of strokes was measured on a slowish track where SRH spinners Harsh Dubey and Shvang Kumar made the ball talk. But it was Shami, the 35-year-old artist, who

set up the match in the LSG's bowling Powerplay itself. His scalps were the crack opening pair of Abhishek Sharma and Travis Head, dismissed off successive deliveries across two overs with different variation of slower deliveries. Shami was ably supported by young Prince Yadav (2/34 in 4 overs),

whose outswinger (inswinger for Ishan Kishan) was the ball of the match. While Pant would have fancied bowling SRH out for less than 100 after restricting them to 26 for 4 at one stage, Heinrich Klaasen (62 off 41 balls) and all-rounder Nitish Kumar Reddy (56 off 33 balls) counter-attacked to add 116 runs

for the fifth wicket. But there was a third act to the tale as SRH had another batting collapse losing five wickets for 14 runs in last 2.2 overs. During the chase, LSG did stutter in phases but Pant, who curbed his impetuosity showed glimpses of his vintage self but also concentrated on crossing the line. Overlooked time and again, 35-year-old Shami sent a stern reminder to the national selection committee with an opening spell for the ages that was pivotal to Lucknow Super Giants choking Sunrisers Hyderabad despite the Klaasen-Reddy stand. The cerebral operator in Shami quickly understood that he would have to take the pace off the deliveries on this track and did so promptly. He bowled four fullish blockhole deliveries to Head and allowed a single. When Abhishek took strike.

## Liverpool 'gave up' in FA Cup exit - Van Dijk

Liverpool captain Virgil van Dijk has apologised to the club's supporters and said his side "gave up" as they were dumped out of the FA Cup by Manchester City. The Reds' hopes of winning silverware this season now rest on Champions League glory following Saturday's humbling 4-0 quarter-final defeat at Etihad Stadium. Manchester City demolished Liverpool in an 18-minute period which spanned the half-time break, scoring twice either side of the interval following an evenly matched opening half an hour. "I can only apologise to the fans for what we have shown, especially the second half," said Netherlands centre-back Van Dijk, 34. "Obviously you come out with the right intentions from the dressing room [after half-time], to hopefully score for 2-1 as soon as possible to change the game. "The opposite happens and to come back from 3-0 is obviously very difficult here - but also you shouldn't give up and that's maybe, at a cer-



tain point, what happened. "We let our fans down, we let ourselves down, and the manager. "The way we played in the second half, especially, must hurt for everyone. It definitely hurts me." It was Van Dijk's foul on Nico O'Reilly which gave Erling Haaland the opportunity to kickstart City's demolition job from the penalty spot after 39 minutes. The Norway striker went on to complete a hat-trick in the second half with 57 minutes played, after Antoine Semenyo had added his

side's third. The result and performance increases the pressure on manager Arne Slot, who led the club to the Premier League title in his first season in charge last year, before the first leg of their crucial Champions League quarter-final tie against Paris St-Germain. ## Price calls for Shields fight after beating Pineiro

A bloodied Lauren Price dug deep to beat Stephanie Pineiro on points to retain her welterweight world titles in Cardiff before calling for a future fight with Claressa Shields. The 31-year-old picked up a terrible cut after a clash of heads in the fifth round against the previously unbeaten Puerto Rican. Price rallied to fight to the final bell and was rewarded with a unanimous decision on the scorecards. After the fight, American Shields - who has held 15 world title belts across five weight divisions - stepped into the ring to face off with Price. "I want the biggest fights in boxing, and what a great honour it would be to share the ring with Shields," said Price. "It makes for a great fight, but not just one fight. I said to her tonight, 'Let's do it, I'll come to America



and then you come to Wales," and she shook on it. So hopefully we can make that happen. "It is why I'm in the game, I want to fight the best. Credit to Shields - I respect her - but I back myself!" Shields said the location of any fight would have to be discussed but hinted at a meeting between the two stars at the end of 2026 and said the bout would be at middleweight. "When you are an Olympic champion you

are a special fighter," said Shields. "Me and you have talked online and me and you can make it happen, you did great tonight. "No disrespect to you, you've got a little bit of time. I've got one more fight and then we can fight at the end of the year." Price has spoken often about staging a future fight at either the 33,000-seat Cardiff City Stadium or Principality Stadium, which can hold almost 80,000 fans.

## Boxer Anthony Joshua Makes First Public Appearance Since Fatal Car Crash

Former world heavyweight champion Anthony Joshua has made his first public appearance since he survived a car crash in Nigeria that killed his close friends Sina Ghani and Latif Ayodele. Joshua had kept a low profile since the accident on December 29, but he was seen at London's O2 Arena on Saturday watching a Derek Chisora bout. The British fighter was ring-side as Chisora made the 50th and final fight of his career against Deontay Wilder. Boxing promoter Eddie Hearn has said Joshua needs time to heal before considering stepping back into the ring himself. Dressed in a white tracksuit, Joshua emerged with Hearn from a black people carrier as he



walked into the arena past a number of camera crews. There was no friendly welcome from his old rival Wilder, who was repeatedly linked with a world title bout with Joshua during the peak of their powers. The American went straight past Joshua without any acknowledgement in a tight corridor inside the arena. Joshua last fought before Christmas

when he faced YouTube-turned-boxer Jake Paul in Miami, but speculation continues over a potential bout with British rival Tyson Fury. During a ring-side interview with DAZN, Joshua said: "It's amazing to be here. Boxing, especially British boxing, is booming. "I'm obviously biased, I'm rocking with Derek regardless, so I'm Team Chisora."

Right-back Ian Fray burst down the flank and crossed for Messi, who equalized with a rare headed goal to make it 1-1. 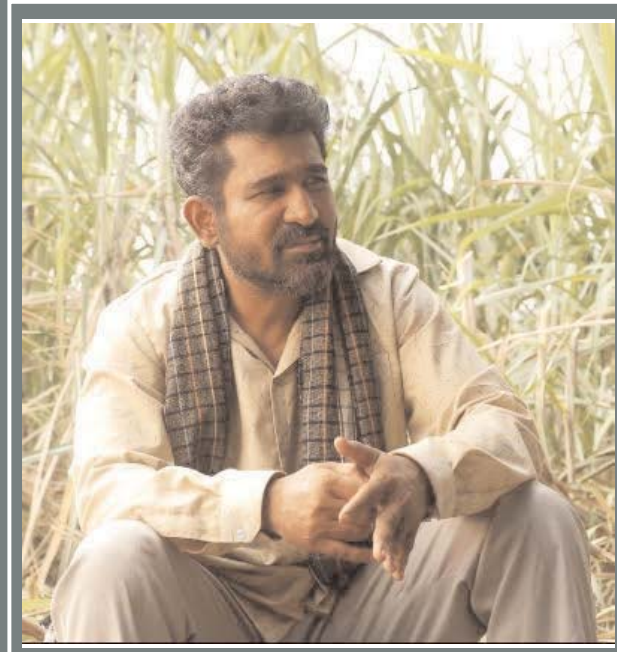
