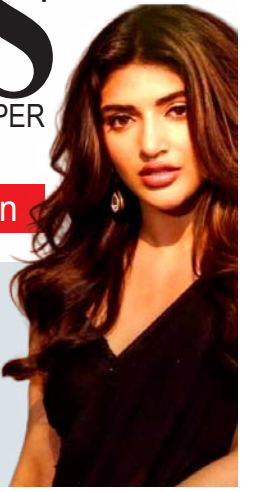

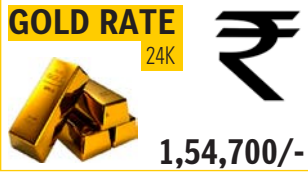

ANGANWADI TEACHER TIED TO TREE IN TELANGANA, FIVE HELD

Hyderabad, April 9 (TSIT) : Five persons were arrested in Telangana's Sangareddy district on Thursday for tying an Anganwadi teacher to a tree over the alleged financial cheating by her husband, police said. The shocking incident took place in Rasole village in Kangti mandal on Wednesday. Few villagers tied

Vasanta Kumari to a tree with a rope and humiliated her as her husband, Prabhakar, had allegedly cheated them in the name of a finance company. Prabhakar had collected money from some villagers in Ramaragidda village under "HBM Finance" and fled. Angered over this, some villagers went to Rasole, where Vasanta Kumari was attending duty.

PARTH PAWAR TAKES OATH AS RAJYA SABHA MEMBER FROM MAHARASHTRA

New Delhi, Apr 9 (TSIT) Parth Ajit Pawar was on Thursday administered the oath of office by C P Radhakrishnan, Vice President of India and Chairman of the Rajya Sabha, as a newly elected Member of the Rajya Sabha from Maharashtra at Parliament House. The oath-taking ceremony, held in the presence of senior officials and members, formally marked Parth Pawar's entry into the Upper House of Parliament.

Assam sees over 84% polling, Kerala voter turnout at 75% & Puducherry 86%

Guwahati/Thiruvananthapuram/Puducherry (TSIT)

A groundswell of voter enthusiasm marked the high-stakes Assembly elections on Thursday, as voters turned out in huge numbers across urban and rural constituencies, with polling figures by 5 pm touching a striking 84.42 per cent in Assam, 75.01 per cent in Kerala, and 86.87 per cent in the union Territory of Puducherry.

No major untoward incident was reported in any part of the two states and the union Territory, and polling was held peacefully overall.

Over 5.3 crore electors queued up before the booths, reflecting robust participation as they cast their votes to shape the political future of the two states and the union Territory. Polling commenced at 7 am and is set to continue until evening across 140 constituencies in Kerala, 126 in Assam, and 30 in Puducherry. Officials said elaborate arrangements, including heightened security deployment, extensive webcasting, and drone surveillance in sensitive areas, were put in place to ensure free and fair elections. Over three-fourths of the 2.51 crore-plus electors across Assam cast their vote amid stringent security despite intermittent rains in the

single-phase Assembly elections that remained generally peaceful except for some sporadic incidents. According to police, polling has remained overall peaceful. Nine people were held for their alleged involvement in poll-related unrest at three places in the state. Some people also sustained minor injuries in clashes that broke out at polling booths after voting began. Among the prominent person-

alities who cast their votes are Chief Minister Himanta Biswa Sarma, state Congress president Gaurav Gogoi, Rajor Dal chief Akhil Gogoi and Rajasthan Royals captain Riyan Parag.

Sarma, accompanied by his wife and son, voted at a booth in state capital. He is contesting from the Jalukbari constituency. Gogoi voted in his home turf Jorhat, from where he is fighting his maiden Assembly election. A record turnout was witnessed Puducherry, with an estimated 86.87 per cent of the total 9.53 lakh electorate pressing the EVM button till 5 pm, as the polling to elect the 30-member Territorial Assembly reached the final stretch, amid tight security.

Going by the unprecedented turnout, and with an hour's time left for the polling to end, the voting percentage was all set to cross the 90 per cent mark

Education key to progress, says Bhatti;

Announces key initiatives to improve quality of education

Khammam (TSIT)

Telangana Deputy Chief Minister Bhatti Vikramarka Mallu on Thursday said education is the true weapon for progress and stressed that only education can empower children and build an equal and progressive society.

Addressing after distributing free bicycles to students of government schools and colleges under Amma Foundation initiative at Bonakal here, Bhatti said students must shape their future by treating education as their strongest weapon and added that disparities in society can be eliminated only through education.

He said the recent socio-economic, educational, employment and caste survey conducted by the



state government has clearly shown that development is possible only through education.

He announced that the state government will launch a breakfast scheme for 20 lakh students studying in government schools from June 2, stating that no child should attend school hungry as it affects learning ability. He further

said free mid-day meals will also be extended to Intermediate students from the next academic year. Stating that the government is investing thousands of crores in education, he said every child in the state should be given an opportunity to study as far as they wish and develop into quality human resources.

Petroleum Minister Puri to visit Qatar to discuss LNG supply amid West Asia crisis

New Delhi (TSIT) : Union Petroleum and Natural Gas Minister Hardeep Singh Puri is set to visit Qatar between April 9 and April 10 to discuss liquefied natural gas (LNG) supplies amid disruptions triggered by the ongoing Iran conflict, the ministry said on Thursday.

In a post on X, the Ministry said, "Union Minister for Petroleum &



Natural Gas, Hardeep S. Puri, will be on an official visit to the State of Qatar on April 9-10, 2026. India has been ensuring adequate gas availability for households,

as global supply chains remain under stress.

Earlier, state-run QatarEnergy last month declared force majeure on long-term LNG supply contracts for up to five years, affecting shipments to countries such as Italy, Belgium, South Korea and China. While India was not specifically mentioned, it remains one of the key buyers of LNG from Qatar.

Regime change in Bengal inevitable, TMC's repository of sins full: PM Modi

ASANSOL (WB) (TSIT): Prime Minister Narendra Modi on Thursday asserted that a regime change in West Bengal is inevitable as the TMC's "repository of sins" has become full. Beginning his speech at this coal and industrial belt by invoking local deities Goddesses Kalyaneshwari and Ghagar Buri Chandi, Modi highlighted the state's "economic decadence", saying, "Bengal's contribution in national GDP has slid to mere five per cent from 12 per cent earlier".

"A regime change in Bengal is now cast in stone and sought by the people of Bengal. TMC's repository of sins is now full. Asansol is being ruled by syndicate raj, coal and sand mafia," the Prime Minister said. He asserted that West Bengal will scale new heights after the change in guard.

"Investment has taken flight from the once-thriving industrial belt of Asansol. Only the BJP's double-engine can rectify it," Modi said. He said the Centre allocated Rs 45,000 crore for the revival of industries in Asansol. The PM alleged, "The TMC has only given 'hirmamta' (cruelty) to Bengal, while the BJP has developed Asansol despite hurdles created by the ruling party."

Vijay to campaign in Karaikudi on Friday amid tight security arrangements

Chennai (TSIT): Actor-turned-politician Vijay, leader of the Tamilaga Vettri Kazhagam (TVK), is set to intensify his election campaign with a major public outreach programme in Karaikudi on Friday.

The visit is part of his ongoing statewide campaign ahead of the Tamil Nadu Assembly elections, where he has been actively engaging with voters across key constituencies. During his visit, Vijay will campaign in sup-



port of his party candidates contesting in four constituencies -- Karaikudi, Manamadurai, Sivaganga,

and Tirupathur. In Karaikudi, he will specifically canvass votes for party candidate Dr D.K. Prabhu, with party lead-

ers expressing confidence that the event will draw significant public attention.

Party sources said that permission has been sought to conduct a public meeting near the Thevar statue in Karaikudi between noon and 4 p.m. In preparation for the event, officials from the Election Commission and the police department convened a coordination meeting to review arrangements and ensure compliance with election guidelines.

Jagga Reddy Reacts to Jeevan Reddy's Exit from Congress



Hyderabad (TSIT): TPCC Working President T.Jagga Reddy expressed concern over senior Congress leader Jeevan Reddy's decision to leave the party, describing it as "unfortunate."

Addressing the media, Jagga Reddy said that Jeevan Reddy, known for his long-standing loyalty to the Congress party and its leadership, including Sonia

Gandhi and Rahul Gandhi, quitting the party is a matter of sadness.

He stated that the developments surrounding Jeevan Reddy should have been reviewed at the AICC level. "It would have been better if the Delhi leadership had directly intervened and resolved the issue," he remarked, adding that this was his personal opinion.

Jagga Reddy also noted that party switching by MLAs and leaders has become common in present-day politics. However, he maintained that the reasons behind Jeevan Reddy's exit would not be discussed publicly and would instead be addressed internally within the party.

Chief Secretary Pushes Innovative Steps to Curb Road Accidents



Hyderabad, TSIT: Chief Secretary Ramakrishna Rao on Thursday reviewed the implementation of the "Arrive Alive" road safety programme during a video conference with District Collectors, as part of the 99-day Praja Paalana Pragati Pranalika.

Expressing concern over the rising number of road accidents, he said that despite several pro-

active measures by the government, accidents continue to increase due to rapid growth in vehicles, higher speeds on improved roads, lack of proper driver training, over-speeding, and reckless driving. He directed District Collectors to prioritise road safety and come up with innovative, locally relevant solutions. He also instructed officials to

immediately convene District Road Safety Committee meetings and ensure effective implementation of the week-long programme with active involvement of public representatives. The "Arrive Alive" programme will be conducted across the State from April 13 to 18, focusing on awareness and responsible road usage.

Director General of

Police B. Shivadhar Reddy said the initiative is a comprehensive multi-departmental effort and not a routine exercise. He noted that pedestrians and two-wheeler riders form a majority of accident victims, stressing the need for targeted awareness campaigns. As part of the programme, village-level road safety committees will be formed on April 13, followed by road safety pledges on April 14, Children Road Safety Day on April 15, special campaigns for government employees on April 16, "Golden Hour" emergency response training on April 17, and counselling sessions for traffic violators on April 18.

Provide Nutritious Food to Students According to the Menu: District Collector Anurag Jayanti



Yadadri Bhongir TSIT: Yadadri Bhongir District Collector Anurag Jayanti stated that special focus must be placed on enhancing educational standards within schools, and that students should be provided with nutritious and tasty food strictly in accordance with the prescribed menu. On Thursday, the District Collector visited the Telangana Social Welfare Residential Centre of Excellence located in Hanuman Wada, Bhongir town. During this visit, the District Collector conducted a comprehensive inspection of various aspects of the school, including the infrastructure facilities provided, teaching methodologies, teacher attendance, classrooms, and the dormitory hall. The Collector personally interacted with the students to ascertain whether they were being served nutritious meals daily,

strictly adhering to the prescribed menu. He also inquired if the school was facing any other issues or challenges. CMC COMMISSIONER SRUJANA DIRECTS STRICT ADHERENCE TO CONSTRUCTION NORMS AT BUILDERS' MEET

Cyberabad TSIT: : The Commissioner of the Cyberabad Municipal Corporation (CMC) on Wednesday held a meeting with representatives of NAREDCO, CREDAI, Telangana Developers Association, and individual builders, emphasizing strict compliance with construction regulations and responsible development practices. The meeting focused on ensuring that all ongoing and upcoming projects within the CMC limits adhere to approved building plans, environmental standards, and statutory norms. The Commissioner issued a series of key directives to builders and developers. He stressed that adequate safety measures must be ensured at construction sites. Builders were instructed to take effective steps to control dust and air pollution, and to regulate construction activities to minimise noise pollution as per prescribed norms.

Residents of the colonies along Siddipet Road in Husnabad town submitted a memorandum to the Municipal Commissioner on Thursday, requesting the immediate removal of nutgrass (Tunga gadidi) growing in a vacant field adjacent to Nagulamma Road. They stated that the nutgrass, which has spread across approximately 20 acres, is causing distress to residents as its airborne pollen drifts into their homes, citing the risk of respiratory ailments, they urged the authorities to take immediate remedial action. Municipal Vice-Chairperson Chittari Padma Ravinder, 17th Ward Councilor Gadapaka Ravinder, BRS leaders Aleni Mallikarjuna Reddy, Donthaboyina Srinivas, and others participated in this initiative.

The people of the village have long been impatient with this scandal of irregularities that came to light as a witness in the Gram Sabha. In this context, in the last Gram Sabha, the people and ward members came together and publicly denounced the Panchayat Secretary and the current Sarpanch. "Where were the works done in the village? In which accounts did the money go?" The officials and the Sarpanch were speechless, unable to answer the questions asked by the people. This discussion held in the Gram Sabha and all the



objections expressed by the people have been recorded in the records. After complaining to the district and mandal authorities several times, the village's B. R. S. leader Kotha Prabhakar approached the Lokayukta with complete evidence. In the petition, the former Gram Panchayat Secretary, former Special Officer, and the Mandal Assistant Engineer (AE) allegedly created fake resolutions and fake bills that were crucial in sanctioning funds, and signed the M-book for the respective works without seeing the work at the field level.

ONSITE FIR SYSTEM LAUNCHED IN FUTURE CITY COMMISSIONERATE



RANGAREDDY (TSIT) In a citizen-friendly move, the Future City Commissionerate has introduced the "Onsite FIR" system to ensure quicker police response and immediate registration of cases at the scene of an incident. The new system was implemented following a chain-snatching case in Kondannaguda village under Shadnagar Police Station limits. According to the victim Veeramma, an unidentified man came on a motorcycle at around 2.30 pm on Thursday, approached her from behind while she was near her farmland, and snatched a gold mangalsutra chain weighing nearly four tolas before fleeing. Naidu Mocks Jagan's 'MAVIGUN' Proposal, Reaffirms Amaravati as Sole Capital

Amaravati, April 9 : Andhra Pradesh Chief Minister, N. Chandrababu Naidu, on Thursday mocked YSR Congress Party President, Y.S. Jagan Mohan Reddy, over his 'MAVIGUN' proposal and also took a swipe stating "good that he didn't suggest Vatican as the state capital."

For the uninitiated, Vatican City is an independent city-state enclaved within Rome, Italy and is the spiritual and administrative centre of the Roman Catholic Church.

Addressing a public meeting in Bapatla district, the Chief Minister lashed out at the former Chief Minister for mooted 'MAVIGUN (Machilipatnam - Vijayawada, Guntur) corridor as the state capital.

He made it clear that Amaravati will be developed as the only and permanent capital of Andhra Pradesh.



Pradesh.

"Amaravati will not stop even if 1,000 psychos like you try to stop it," said the Chief Minister. He said 49 parties in the Parliament supported the bill to give statutory recognition to Amaravati as the sole and permanent state capital. He said not just NDA partners but other parties also supported it. Chandrababu Naidu said YSRCP was the only one party to oppose the Bill. "We use to call a leader

a psycho but the entire party has become psycho," he remarked.

The Chief Minister said YSRCP was talking about women's dignity and recalled that the same party insulted Amaravati women and indulged in their character assassination. He said they also abused his wife in the Assembly.

"A rowdy batch exhibiting psychotic behaviour, is engaging in perverse arguments. They are attacking a

newspaper without any provocation. They have harassed women. This psycho party is in no position to provide an explanation for such behaviour," he said.

Alleging that attempts are being made to destroy the state, he called up on people to unitedly defeat such attempts. "The state has already suffered immense losses due to its bifurcation and the actions of previous rulers. We have just begun the process of rebuilding it," he said. Stating terrorists lurking in forests launch attacks and then flee, he remarked that this individual is no different as he operates from a distance, spreads malicious propaganda, and runs away. "We are prepared to respond to constructive criticism but they are spreading falsehoods by claiming that Rs. 2 lakh crore are being spent on Amaravati. The fact is that

Amaravati is self-financed project," he said. He said the YSRCP keep mentioning Vijayawada, Guntur, and Machilipatnam, apparently unaware that this entire area constitutes the CRDA (Capital Region Development Authority) region.

"Out of an aversion to even uttering the name Amaravati, they are attempting to create chaos and cause distress to the public. It would take mere moments to have individuals of this nature arrested but the law will be allowed to take its own course," he said. "If individuals intent on creating destruction are allowed to roam free, can the people, particularly the women of this state ever truly feel safe," he asked. Chandrababu Naidu stated that is in the best interest of the people to simply forget about such parties and individuals.

He further criticized the minister for ignoring pressing issues like farmer distress while making provocative statements. "Instead of addressing farmers' suicides, attention is being diverted through baseless allegations," he remarked.

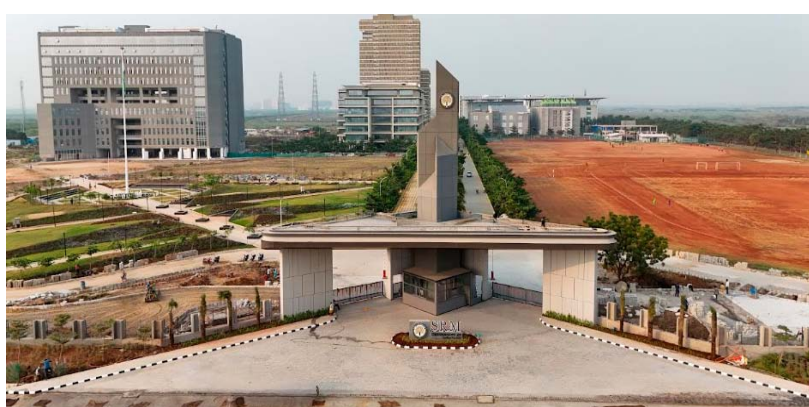
SRM University-AP Sets Up India's First Quantum Reference Facility

Ensuring income, dignity and sustainability of weavers a top priority: Yogi

Lucknow, April 9 : Uttar Pradesh Chief Minister, Yogi Adityanath, on Thursday said that ensuring the income, dignity and long-term sustainability of weavers remains a top priority for the state government, underlining the need for a comprehensive and coordinated approach to address challenges faced by the sector.

Chairing a review meeting of the Handloom Department, Chief Minister Adityanath said, "Weavers are not just carriers of tradition but also a strong pillar of the state's economy. Therefore, ensuring their income, dignity, and livelihood stability is among the government's top priorities."

He noted that weavers currently face challenges such as rising raw material costs, lack of modern design and technology, and limited market access. "Such challenges cannot be resolved through schemes alone. A robust, result-oriented and cluster-based system must be developed," he said, directing officials to prepare a practical action plan focussed on cluster-based development.

During the meeting, officials informed that around 1.99 lakh weavers are engaged in the sector in the state, with Uttar Pradesh ranking sixth nationally.



The state has a leading position in the production of carpets, durries and mats, along with a strong presence in bedsheets, furnishings, and blankets.

In 2024-25, India's total handloom exports stood at Rs 1,178.93 crore, of which Uttar Pradesh contributed Rs 109.40 crore, accounting for about 9.27 per cent.

Emphasising the need to identify weaver-dominated regions, the Chief Minister directed the development of clusters that integrate production, quality control, and marketing. He said these clusters should function on a value chain model, covering design, branding, packaging and market access rather than being limited to production alone. The meeting also discussed cluster selection, baseline surveys, preparation of Detailed

Project Reports (DPRs), implementation and monitoring. The Chief Minister suggested organising a limited number of weavers into registered units with in each cluster to encourage collective production and marketing, while also linking them with modern technology, advanced tools and skill development programmes.

Highlighting the importance of design and market alignment, Yogi Adityanath stressed the effective implementation of mechanisms such as designer-cum-marketing executives and design houses or export agencies to enhance product quality and expand market reach. He further called for greater use of digital platforms, e-commerce and branding initiatives to connect weavers directly with consumers.

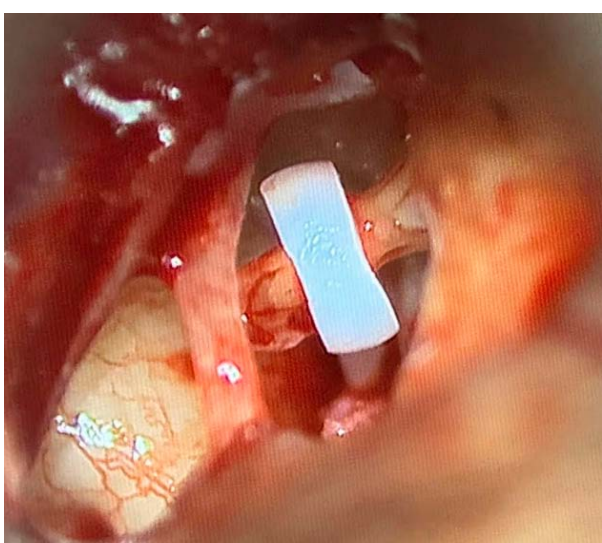

A few years ago, the patient was diagnosed with Stage II breast cancer (T1N1aM0). Further evaluation revealed that her cancer was hormone receptor positive (ER/PR+) and HER2 negative. shown that it is possible not only to survive cancer but to come back stronger and achieve personal goals. Fear and anxiety are natural during treatment, but with the right medical care, family support, and a positive attitude, patients can successfully overcome cancer."

Doctors also emphasized that breast cancer cases are increasingly being seen in younger women. They urged regular screening, self-examination, and early consultation with specialists. Symptoms such as a lump in the breast, pain, changes in breast shape, or skin alterations should never be ignored, as early detection dramatically improves the chances of successful treatment.

AMIKA at Five: An Indian Startup in Dispute Resolution That Went Global

HYDERABAD (TSIT) Five years ago, on April 9, 2021, the Amika Arbitration and Mediation Council (AAMC) was established following the recommendations of the Justice B.N. Srikrishna Committee on the institutionalisation of arbitration. What began as a local initiative has now evolved into an internationally recognised dispute resolution institution, offering a peaceful alternative to India's overburdened court system. Dr. P. Madhava Rao, Registrar of AAMC, announced today that over 500 parties involved in matrimonial, family, and property disputes have successfully sought and found resolution through the centre. This achievement comes at a critical time, with over 50 million cases currently pending in the Indian judicial system, leaving countless litigants trapped in lengthy and expensive court battles.

AAMC positions itself as a vital bridge between the traditional adversarial system and modern restorative justice. Dr. Rao explained that the centre's growing popularity stems from its ability to demonstrate to the public that even deep-seated



family conflicts can be settled in a peaceful atmosphere—without ever stepping into a courtroom.

BUILDING CAPACITY, GAINING GLOBAL TRUST

Over the past five years, AAMC has conducted four intensive 40-hour training programs, producing 50 skilled mediators by following the curriculum developed by the Mediation and Conciliation Project Committee (MCCPC) of the Supreme Court of India. The institution's excellence has received international validation from the United Nations Commission on International Trade Law (UNCITRAL), which approved Amika's Arbitration and Mediation Rules for resolving

international commercial disputes. Further demonstrating its global reach, AAMC has designed and implemented "Training of Trainers" programs for lawyers in Myanmar.

On the domestic front, the Indian government has recognized the centre's expertise by inviting it to provide advice on mediation legislation. Additionally, national stock exchanges now utilize AAMC's mediators and arbitrators to settle investment-related conflicts.

Unlike many business-oriented firms, AMIKA views disputes holistically—particularly in marital cases, where the priority is to reunite couples or provide fair settlements that protect women's rights and preserve family ties. The centre has registered over 500 cases involving sensitive issues such as matrimonial disputes, child custody, and property division. Notably, 60% of these cases involve young couples seeking resolution within the first week of marriage—a significant shift in social trends. Dr. Rao highlighted that many disputes are resolved in just one or two sessions, allowing the parties to leave as friends rather than enemies.

RECOGNITION AND THE ROAD AHEAD

The Telangana High Court has recently forwarded AAMC's request for official recognition to the state government. The centre's unique case management system is built on the pillars of confidentiality, transparency, and speed. Unlike public court proceedings, all mediation details are kept strictly private.

The Real Reason China Stayed 'Quiet' About Its US-Iran Ceasefire Role

Pakistan's media is ecstatic. After all, it was the country's apparent mediation that paused a disastrous war, and it is probably going to host the first delegation as early as next week. This is Pakistan's moment in the sun, or so it seems. But a tweet posted by the Prime Minister exposed embarrassingly enough that there might have literally been a US handle working the mediation machine. Standing quietly in the shadows is China. Its Foreign Minister has been busy, having made some 26 calls recently. It is also to host the US President soon. Meanwhile, Trump acknowledged Beijing's intervention in a single line. That counts for something. From this mess, some will emerge as winners. Others will scramble to clean up the dust.

The Key Motivation To Mediate

At first sight, Pakistan's diplomatic cup seems to be overflowing. Iran's Foreign Minister, Abbas Araghchi, has expressed gratitude and appreciation on X for the 'brotherly country' of Pakistan, though not just praising Prime Minister Shahbaz Sharif but also Field Marshal Asim Munir. That should cloud the former's already knitted brow a bit. But Munir has apparently been working the lines the whole night, talking to the US and Iranian negotiators, all of which adds considerably to his stature. That's a big plus for his longevity in a country where former political heads or even army chiefs have had a sticky end. Consider that former Chief of Army Staff Javed Bajwa died un-mourned and mysteriously recently. The biggest win for Munir, and for his country, however, cannot be publicised. And that is, keeping Pakistan out of the Iran-Saudi war, and thereby sliding out of implementing last year's 'Strategic Mutual Defence Agreement'. That was a black-and-white commitment that required Islamabad to aid the Saudis if they were attacked. When the first drone attack hit, the Saudis summoned the Field Marshal, with Defence Minister Prince Khalid posting pointedly that the two had discussed the attacks "and the measures needed to halt them within the framework of our Joint Strategic Defence Agreement". Any support to the Saudis would have had Iran venting its wrath on Pakistan, with a couple of missiles landing in its capital. An already enraged Shia population, which was told by an arrogant Munir to "go to Iran" if it so wished, would have risen up against the army. A catastrophe was averted through the mediation exercises. Danger again came perilously close when Iran recently hit the Jubail Petrochemical complex days ago, which led to Sharif yet again thanking Riyadh for its "restraint". It's not over, though. Even after the declaration of the ceasefire, a vital pipeline that bypasses the Hormuz has been hit. That could upset the apple cart.

Fronting For The US

Into all this desperation came the US. The New York Times story confirms that a tweet, posted ostensibly by the Pakistan PM, was in fact drafted in the White House. Trump couldn't be seen as asking for a ceasefire, so he got Pakistan to 'front' the exercise, while pulling the levers behind. Recall that the tweet was mistakenly posted as 'Draft: Pakistan PM's message on X calling for an extension to the deadline to the US, and cooperation from "Iranian brothers"'. It was a dead giveaway. Then came another kerfuffle. Sharif again posted that Iran and the US, "along with their allies", would also implement the ceasefire in Lebanon. That was denied almost immediately by Vice President JD Vance, who said the ceasefire was Iran-focused. Yet another post earlier by Sharif, appealing for an end to attacks by all parties, was marked to everyone but Israel. Clearly, the perils of a mediation exercise are immense when the mediator doesn't recognise one of the central parties to the war. Pakistan's passport explicitly states that travel to Israel is barred. It seems then that a Prime Minister cannot acknowledge its existence in a post on X.

After all, what did the war bring?

From Institution Builder to Life Mentor: The Journey of Dr. Vijay Garg

The world of education in India today is becoming increasingly entangled in a dazzling array of statistics, percentages, and rankings. The quality of schools and colleges is now judged by how many students top exams, secure prestigious jobs, and crack competitive examinations. But amidst this landscape, a fundamental question often goes unaddressed—is education merely a means to deliver results, or is it also a process of shaping human beings? A living answer to this question is Dr. Vijay Garg, whose life and work introduce us to the true meaning of education.

Dr. Vijay Garg's name cannot be remembered solely as an administrative officer or principal. He led educational institutions for nearly four decades, but his contributions transcended the boundaries of position or responsibility. He was one of those rare educators for whom education was not a profession, but a moral obligation. His personality embodies the simplicity of a teacher, the depth of a thinker, and the sensitivity of a guide.

He understood every aspect of the school—classroom activities, teachers' problems, and students' needs. He approached problems not by issuing orders, but by understanding and solving them. His administrative style was characterized by sensitivity, not rigidity; by dialogue, not distance. He never considered teachers subordinates, but rather as colleagues. He never judged students solely by their roll numbers or results, but instead strived to develop them as complete individuals. For him, the measure of an institution's success was not exam results, but the character and thinking of the students who graduated. Dr. Garg's colleagues and students often recount his ability to recognize his students by name, even years later. This wasn't simply a matter of memory, but a testament to the deep connection he forged with them. He saw potential in every student and made every effort to fulfill that potential.

Often, he would quietly help students who were falling behind. Sometimes by offering a piece of advice, sometimes by providing an opportunity, he shaped the lives of many. For him, education meant more than just teaching, but also holding the hand of anyone who was on the verge of falling.

Over time, when his formal tenure ended, he didn't turn to retirement as a means of relaxation. For him, it was simply a change in his approach to work. He separated himself from administrative responsibilities, but never from the world of ideas and contemplation.

Today, he expresses his views on issues of education and society through his writings. His writings clearly reflect his depth of experience and clarity of thought. He writes on topics such as education policy, the challenges facing youth, and the decline of values, but his approach is always balanced and practical. He not only points out problems but also suggests solutions. His writing doesn't feel like a sermon, but rather like a dialogue. Readers feel as if they are talking to someone who has seen life closely, understood its complexities, and yet has not given up hope.

Dr. Garg's influence wasn't limited to his institutions. His students are now making their mark in various fields—some as doctors, some as engineers, some as teachers, and some as administrative officers. But his greatest achievement isn't that his students were successful, but that they became sensitive and responsible citizens.

Karnataka bypolls see over 60 pc turnout till 5 pm

The polling, which began at 7 am, saw a gradual rise in voter participation through the day. Earlier trends indicated around 27 per cent turnout in

Bagalkot and about 22 per cent in Davanagere South by late morning, which increased to over 54 per cent and nearly 50 per cent respectively by 3 pm, reflecting a steady upward trend. Voting was largely peaceful, with elaborate security arrangements in place. Thousands of police personnel and polling staff were deployed across the two constituencies to ensure smooth conduct, with several polling stations identified as sensitive and kept under close watch. The Bagalkot bypoll was necessitated following the demise of sitting Congress MLA H Y Meti, while the Davanagere South seat fell vacant after the

passing of senior legislator Shamanur Shivashankarappa. In Bagalkot, the Congress has fielded H Y Meti's son, Umesh Meti, seeking to retain the seat, while the BJP has nominated Veeranna Charantimath, making it a high-stakes contest. In Davanagere South, the Congress has nominated Samath Mallikarjun Shannur, grandson of Shivashankarappa, while the BJP has fielded Srivinas Dasakariyappa as its candidate, setting up a direct electoral battle. The bypolls have drawn significant political attention, with the Congress aiming to retain both seats.

Fraud complaint filed against Sundar C at Chennai police commissioner office

CHENNAI: A fraud complaint has been filed against filmmaker Sundar C at the Greater Chennai Police Commissioner's Office, alleging breach of agreement and failure to return advance payment. According to the complainant, Sundar C had entered into an agreement with a production company to direct a film with a budget of Rs 20 crore, with his remuneration fixed at Rs 5 crore. An advance of Rs 50 lakh was reportedly paid to him, while Rs 59 lakh was disbursed as initial payments to actors.



However, the director allegedly failed to commence the project within the agreed timeline. According to a Daily Thanthi report, the complainant further stated that following the success of

Aranmanai 4, Sundar C demanded an increased budget of Rs 30 crore and a revised remuneration of Rs 10 crore. As talks failed to reach a settlement, the producers decided to drop the proposed project, reportedly titled Kalakalappu 3, and sought a refund of the advance. The complainant has alleged that Sundar C neither returned the amount nor honoured the agreement, and instead issued threats. The petitioner has urged police to initiate legal action against the director.

MBBS FEES ONLY FOR 4½ YEARS, SAYS NATIONAL MEDICAL COMMISSION



CHENNAI (TSIT): The National Medical Commission (NMC) has directed all medical colleges, institutions and universities to collect tuition fees only for 4½ years for the MBBS course, warning that violations will invite action. According to Daily Thanthi report. The directive follows reports that some institutions were collecting fees for 5 or 5½ years. The NMC stated that such practices violate the prescribed academic structure and result in students being charged for periods without instruction. As per the Graduate Medical Education Regulations (GMER) 2024 and Competency-Based Medical Education (CBME) guidelines, the MBBS course has an academic duration of 4½ years (54 months), followed by a one-year compulsory internship. In a circular issued to deans, principals and heads of institutions, NMC secretary Dr Raghav Langer said that institutions must adhere strictly to this duration while collecting fees. Citing court rulings, the commission said tuition fees must be reasonable and non-exploitative, and charging fees without providing educational services could amount to contempt of court. The Supreme Court has also criticised the collection of internship fees and non-payment of stipends.

Railway Protection Force seizes 6 kg ganja in Tambaram

CHENNAI: RPF seized six kilograms of ganja, valued at around Rs 3 lakh, during a routine inspection at Tambaram Railway Station on Wednesday. Mohanraja assumes charge as Southern Railway PCPO. The Tambaram Railway Protection Force was conducting inspections when the K a c h e g u d a - Pondicherry Express, coming from Telangana via Chennai, arrived at Platform 7. During a search of the general compartment, the police noticed an unclaimed black bag under a seat. When questioned,



none of the passengers in the coach claimed ownership of the bag. Suspecting foul play, officers opened and examined it, discovering six packets concealed inside. Tamil Nadu schools to reopen on June 1. Upon inspection, the packets were found to contain ganja weighing

a total of 6 kg valued at Rs 3 lakh. The RPF immediately seized the narcotics and alerted the Anti-Narcotics Wing. 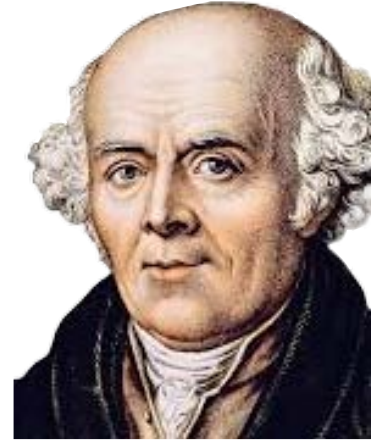

The prospects of the European right after France's local elections

French voters made their voices heard in the mid-March municipal elections, whose insights into the trajectory of the far-right National Rally party, led by Marine Le Pen and her protege Jordan Bardella, were closely followed. The party first rose to prominence in the early 1970s as the National Front, led by its founder Jean-Marie Le Pen, Marine's father. Its rise in the decades since has been striking, as it evolved from an anti-immigrant, populist opposition movement into a genuine "party of power" that boasts more than 100,000 members and nationwide support.



The party's transformation into a force to be reckoned with is not only reflected in its consolidation in parliament and local councils, but also its success in reaching the decisive second round of presidential elections three times (in 2002, 2017 and 2022). While the numbers suggest that the far right at least secured its place in the second round, there is another important element to consider: in all three instances, traditional right and left-wing parties (along with centrists, environmentalists and others) formed tactical electoral alliances with the sole aim of preventing the far-right candidate from reaching the Elysee: Jean-Marie Le Pen in 2002 and Marine Le Pen in 2017 and 2022. Such tactical alliances sought to create a bulwark against an "extremist threat" and inherently demanded that traditional parties compromise on significant elements of their platforms and find some common ground. One might argue that such alliances have both advantages and drawbacks. Political parties exist, after all, to offer voters a perspective on public affairs, social and security developments, and economic and monetary priorities. When two or more parties are compelled to unite behind a single candidate, they inevitably abandon elements of their platforms that reflect their supporters' priorities. Unlike ideologically rigid "cadre parties,"

traditional parties often pay a heavy price for compromise and lose credibility with their base, which could drift toward candidates or parties that more directly represent their core concerns. Most traditional parties in democratic countries were shaped by exceptional figures who strengthened their standing among supporters. In Germany, not every chancellor has matched the stature of Konrad Adenauer or Willy Brandt. In Britain, figures like Winston Churchill or Margaret Thatcher do not come often. And in France, not every post-Second World War president can be compared to Charles de Gaulle on the right or Francois Mitterrand on the left. The departure of such figures, whether through death or retirement, often deprives their parties of their political legacy and charismatic appeal. Meanwhile, changing conditions and rising challenges across Europe have engendered several key shifts. Firstly, the collapse of the Eastern bloc after the fall of the Berlin Wall and the Soviet Union reshaped Europe's political map, elevating the EU as a bloc confronting a new Russia and undermining the communist left. Secondly, rapid technological development has dealt a severe blow to the labor market. Robotics, the information revolution and now artificial intelligence weaken labor unions and, with them, the socialist and communist parties. In their place, "niche issue" parties have emerged: environmental, regional (including separatist parties) and single-issue movements such as those focused on equal rights or abortion.

Thirdly, migration (especially from the Global South) has intensified, driven by population growth, development disparities, economic and political crises, and civil wars. Against this backdrop, doubts have emerged about what once seemed a durable broad consensus. Just as the British distanced themselves from a unified "European identity," the Germans and Italians seem to have forgotten the horrors of Nazism and fascism, flirting with their return. Meanwhile, segments of the French working class, especially less skilled workers, have directed their frustration at immigrants, leading many to shift from the communist left to nationalist extremism. They do, however, provide a useful snapshot of emerging opportunities, shifting priorities and the issues mobilizing voters and parties. Oil prices rise again on the fragile Iran ceasefire

Hong Kong: Oil rose again to above USD97 a barrel and Asian stocks were trading lower Thursday, April 9, on skepticism over a fragile ceasefire between the US and Iran. Investors were closely watching whether a two-week ceasefire between the United States and Iran was already slipping after a round of deadly Israeli strikes on Lebanon that killed and injured hundreds. Iran again closed the Strait of Hormuz, in response to the attacks in Lebanon. Tokyo's Nikkei 225 dropped 0.9% to 55,824.30, while South Korea's Kospi lost 1.6% to 5,776.03. Hong Kong's Hang Seng fell 0.4% to 25,801.87. The Shanghai Composite index was down 0.7% to 3,965.70. Australia's S&P/ASX 200 edged down 0.1%, while Taiwan's Taiech was also 0.1% lower. US futures were down more than 0.1%. Oil prices were up Thursday, reversing an earlier plunge on optimism over the temporary ceasefire agreement. Brent crude, the international standard, was up 2.4% to USD97.02 per barrel. It previously fell briefly to below USD92 a barrel following the temporary ceasefire announcement.



Benchmark US crude was 3.3% higher on Thursday at USD97.50 a barrel. Uncertainties over global energy supply remained. The Strait of Hormuz, a chokepoint for energy transport where a fifth of the world's oil typically passes, was largely closed even though the US repeatedly demanded that the strait must be reopened. Talks to pursue a permanent end to the war could be taking place as soon as Friday in Pakistan, and US Vice President JD Vance is expected to be leading the negotiating team for the United States. Wall Street closed

higher Wednesday following US President Donald Trump's announcement of a two-week ceasefire with Iran late Tuesday. The S&P 500 jumped 2.5% to 6,782.81. The Dow Jones Industrial Average rose 2.9% to 47,909.92. The Nasdaq composite was up 2.8% to 22,635.00. Following renewed hopes over deescalation of the war, shares of United Airlines surged 7.9% on Wednesday, American Airlines was up 5.6%, while cruise ship operator Carnival jumped 11.2%, trimming losses since the Iran war began on concerns over

rising fuel costs. In other dealings, gold and silver prices fell. Gold's price dropped 0.7% to USD4,743.20 an ounce. The price of silver fell 1.6% to USD74.18 per ounce. The US dollar rose to 158.66 Japanese yen from 158.57 yen. The euro was trading at USD1.1668, up from USD1.1663. Iranian President Masoud Pezeshkian said Israel's continued strikes on Lebanon amount to a "flagrant violation" of the ceasefire and could undermine ongoing negotiations. In a post on X, he said the repeated attacks were a "dangerous indicator

of deceit and lack of commitment" to potential agreements, warning that continued strikes would render diplomacy meaningless and that Iran would not abandon Lebanon. Latest updates here UAE reports no aerial threats as ceasefire takes effect ahead of talks The UAE Ministry of Defence confirmed that on April 9 the country's airspace remained free of any aerial threats, with no ballistic missiles, cruise missiles or drones originating from Iran detected in recent hours. The update comes after the United States and Iran agreed to a two-week ceasefire on April 8 and are expected to hold peace talks in Pakistan on April 11. Since the start of Iran's attacks, UAE air defences have intercepted 537 ballistic missiles, 26 cruise missiles and 2,256 drones. Authorities said 224 people have been injured and 13 killed. Iran nuclear chief rejects limits on enrichment Iran's atomic energy chief Mohammad Eslami said the country's uranium enrichment programme will not be curtailed, asserting that external pressure will not succeed in limiting it.

Anthropic, the American artificial intelligence (AI) company behind the Claude assistant, has built an AI model so sharp at reading software code that it found security flaws hiding in major operating systems and web browsers for over two decades — flaws that the best human experts and automated tools had missed. The model is called Claude Mythos Preview, and Anthropic has no plans to release it to the public. Instead, it has pulled together Amazon, Apple, Google, Microsoft, NVIDIA, Cisco, CrowdStrike, JPMorganChase and others into a coalition called Project Glasswing to use Mythos defensively, hunting down and fixing vulnerabilities before attackers find them. Anthropic is backing this with USD 100 million in credits and USD 4 million in donations to open-source security bodies. What Mythos actually did Mythos found a 27-year-old bug in OpenBSD, an operating system considered unbreakable. It found a 16-year-old flaw in FFmpeg video software used by almost every streaming app



on your phone in a line of code that automated scanners had tested 50 lakh times without catching. It chained together multiple Linux kernel flaws to show how an attacker could seize full control of a server. It did most of this without human guidance. Why this matters in India Every UPI transaction you make, every Aadhaar verification at a ration shop, every IRCTC tatkal booking, every medical record stored at a government hospital — all of it runs on layers of the same open-source software that Mythos is now scanning. Linux powers your Android

phone and bank servers. A serious vulnerability in any of these systems is not some faraway American problem. It is our problem. Why Anthropic will not release this model The same capability that makes Mythos brilliant at defence makes it equally dangerous for attack. If freely available, ransomware gangs, state-backed hackers and freelance criminals would have a tool that finds exploitable flaws faster than any human. Cybercrime already costs the world an estimated USD 500 billion a year. Whether Anthropic's intentions are noble or not,

the fact that this capability exists at all changes the game permanently. The real danger: When open-source catches up Mythos is locked away today. But AI capability spreads fast. Open-source models have been closing the gap with proprietary ones for years. When an open-source model reaches this level, anyone with a laptop will have it. Picture what that means for India. Not wearing helmets can now lead to 3-month driving license ban

Hyderabad: Riders caught without a helmet in Hyderabad will face a three-month suspension of their driving licence under stricter traffic rules being implemented by the city traffic police to curb violations and improve road safety. The proposed penalties, part of a broader crackdown on traffic offences, include a fine of Rs 100 for the first helmet violation, while a second offence will attract a fine of Rs 1,000 along with suspension of the licence, officials said. According to a News 18 report, India records nearly 5 lakh road accidents annually, resulting in approximately 2 lakh deaths. Other proposed changes include higher penalties for over-speeding, with Rs 2,000 for the first offence and Rs 20,000 for the second. Jumping a traffic signal will invite Rs 500 for the first offence and Rs 5,000 for the second. Allowing a minor to



drive will attract a fine of Rs 25,000 and three years in jail. Not giving way to an ambulance will cost Rs 1,000 for the first offence and Rs 10,000 for the second. Under digital enforcement measures, vehicles may be blacklisted if challans for offences committed over the past five years are not cleared within 45 days. Offenders' registration certificates (RC) and driving licences could also be frozen. Once

frozen, the vehicle cannot be sold, insurance renewal will be blocked and driving with a cancelled licence will lead to seizure of the vehicle. Officials said vehicles may also be blocked in the online database if pending challans remain unpaid beyond the 45-day deadline. The digital enforcement methods will include black listing of vehicles if the challans of less than five years aren't paid in 45 days.

Amazon expands Counterfeit Crimes Unit to India combat fake goods



New Delhi: E-commerce major Amazon on Thursday, April 9, announced the expansion of its Counterfeit Crimes Unit (CCU) to India, aimed at strengthening consumer protection and intensifying the crackdown on the sale of fake goods. The unit will bring together local experts to work closely with Indian brands, sellers, and law enforcement agencies to dismantle counterfeit operations and safeguard intellectual property rights in the country's fast-growing e-commerce sector. "The

unit will focus on proactively detecting and removing counterfeit listings, safeguarding intellectual property, and enabling coordinated enforcement action against bad actors, while deepening collaboration with industry bodies and government stakeholders. This effort is in line with Amazon's broader long-term commitment to India, including its plan to invest more than USD 35 billion across its businesses in the country through 2030," Amazon said in a statement.

Israel issues new warnings for Beirut as Iran says attacks breach ceasefire

Capitol Hill has been empty for days now, with lawmakers out of town on their "spring break". There's been bipartisan frustration, with politicians away from their desks at a time when the US is engaged in a war with Iran. That concern reached a peak on Monday when President Donald Trump threatened to end a "whole civilization". Democratic lawmakers were furious at the president and dozens called for the 25th Amendment to be invoked - a method to remove a president from office. The key check lawmakers have on the president in times of war is via the War Powers Act, which attempts to limit a president's ability to wage war. The measure, if approved by Congress, would stop military operations against Iran until the Trump administration could obtain congressional approval. Early in March, just after Trump announced that Israel and the US had invaded Iran,



both the senate and the house voted on war powers resolutions. They both failed. Today, in a symbolic gesture, House Democrats will try once again to pass a war powers measure. They're trying to show Americans that they want to rein in the president. It will almost certainly fail. But it may give Americans who want the war to end a glimmer of hope. Israel's Defence Minister Israel Katz

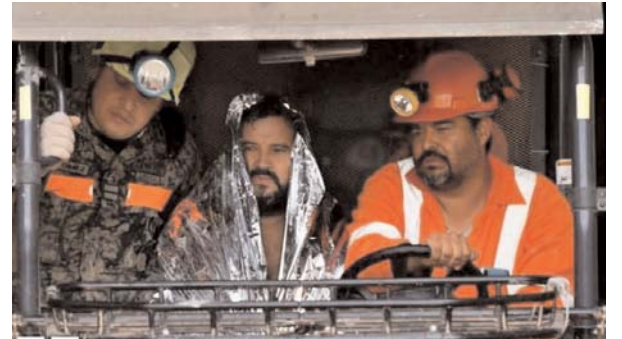
says his country's operation in Lebanon has dealt a "very strong blow to Hezbollah's face, leaving it stunned and confused by the depth of the penetration and the scope of the blow". The defence minister says the Israel Defense Forces is "prepared and ready to act forcefully if Iran fires at Israel". As a reminder, Iranian officials have said that the Israeli strikes on Lebanon are a violation of the ceasefire agreement - and the president has warned Iran's hands will "remain on the trigger". Katz says that over 200 people, who he describes as terrorists, were killed on Wednesday in Lebanon, bringing the total number of those killed during the operation to over 1,400. Earlier, Lebanon's health ministry said 203 people were killed in Israeli strikes on Wednesday

and officials have said more than 1,700 people have been killed since Israel launched its latest campaign in Lebanon last month. Lebanon's Prime Minister Nawaf Salam has asked his Pakistani counterpart, Shehbaz Sharif, for his country's support in putting an end to Israeli strikes against Lebanon, according to a readout of a phone call between the pair released by Pakistan's Prime Minister's Office. Pakistan acted as a mediator for the US-Iran ceasefire agreement. The readout reports that Sharif told Salam he "strongly condemned Israel's ongoing aggression". It says Salam "sought Pakistan's support for bringing an immediate end to the attacks targeting Lebanon and its people". The head of Iran's nuclear agency has ruled out any restrictions on uranium enrichment, a key demand of the United States, adding to concerns that the current ceasefire

may not result in a peace deal. It's unclear who's making the big decisions in Iran - after its leadership was decimated - but a number of top officials have been making comments that put in question the foundations on which the talks due to take place with the US in Islamabad this weekend are based - at least according to Washington. Throughout the war, the US and Israel have insisted that their key aim was to end Iran's ability to build a nuclear weapon for good. The US Defence Secretary Pete Hegseth has said that Iran must either hand over its enriched uranium or the US will take it. The remarks by the head of Iran's nuclear agency clearly contradict this - a preview of just how difficult negotiations are likely to be. One view is that President Trump could make Israeli Prime Minister Benjamin Netanyahu accept Lebanon's inclusion in the Iran ceasefire deal.

Twenty-one managed to get out, but four were trapped. José Alejandro Cástulo was rescued after five days under ground, and another miner died, but it took rescuers a full 13 days to locate Francisco Zapata. Following more than 300 hours of searching, divers finally spotted the blinking of the miner's torch light, which Zapata had turned on and off to alert them to his location. "How are you, how are you?" rescuers asked as they reached him. Once they had identified themselves as specialised military divers, they tell the miner that "your torch-light helped us a lot".

TRAPPED MINER RESCUED FROM FLOODED MEXICAN TUNNEL AFTER 14 DAYS



Mexican army divers have rescued a miner from a flooded underground tunnel two weeks after he was first trapped. Francisco Zapata Nájera, 42, was stuck 300m (985ft) below ground after an embankment collapsed at the gold mine in the northern Mexican state of Sinaloa. Video of the rescue shows him standing in waist-deep water, telling his rescuers that he never lost faith during his ordeal. The search continues for another miner who is still missing. Twenty-five workers were inside the gold mine when the tailings dam - a structure which holds mining waste - burst on 25 March.

Hezbollah to stop attacking Israel, Khatibzadeh responded that Hezbollah was a "Lebanese freedom movement" which he was "not shy to say" received "support" from Iran. He said the deal that was reached - "which Trump called a workable framework" - meant Iran, Washington and each of their allies were to adhere to the ceasefire, and claimed Hezbollah had "very much abided by that". The minister was also asked about Tehran's warning that ships passing through the Strait of Hormuz without its permission "would be targeted and destroyed" despite the ceasefire, during which ships are meant to be allowed through the vital waterway - and whether this could be considered an act of war.

TRUMP CRITICISES NATO AS ALLIANCE CHIEF DESCRIBES MEETING AS 'VERY FRANK'



Donald Trump has again attacked Nato for not supporting the US in the Iran war, following a private meeting with its Secretary General Mark Rutte at the White House. In a post shared to Truth Social after the meeting, the US President said: "NATO WASN'T THERE WHEN WE NEEDED THEM, AND THEY WON'T BE THERE IF WE NEED THEM AGAIN." Meanwhile, Rutte has described his meeting to CNN with Trump as "very frank" and "very open", despite clear disagreements. Ahead of the talks on Wednesday, Trump had toyed with the idea of quitting the trans-Atlantic military alliance after several Nato countries resisted his calls to help reopen the Strait of Hormuz to ease rising global oil prices. The White House did not disclose details of the talk. The Secretary General was at the White House for over two hours on Wednesday, although it is unknown how long the meeting with Trump was. The meeting was expected to cajole and convince Trump that it's in his interest, and America's, to stay in the Nato alliance.

What is clear, however, is that Trump still has deep misgivings about the alliance and the member countries that he believes did not help the US enough before and during Operation Epic Fury. In recent weeks, Trump has threatened to withdraw from the 32-member transatlantic alliance. Asked about Nato's role in the ongoing conflict with Iran, White House Press Secretary Karoline Leavitt on Wednesday said in a direct quote from the president that Nato was "tested and they failed". Leavitt said Nato countries had "turned their backs on the American people," who fund their nations' defense, and that Trump would have a "very frank and candid conversation" with the Nato chief. Meanwhile, much of Rutte's message to Trump appears to be that many European countries did not stand in the way. The Secretary General told CNN that he pointed out that "the large majority of European nations has been helpful with basing, with logistics, with overflights". "It's therefore a nuanced picture," Rutte said.

BEST-SELLING THE HOUSEMAID AUTHOR FREIDA MCFADDEN REVEALS TRUE IDENTITY

One of the biggest mysteries in publishing has been solved, after the best-selling US author known to millions of readers as Freida McFadden revealed her true identity. McFadden has been one of the world's most popular authors of recent years, thanks to thrillers like The Housemaid. The author has never made a secret of the fact Freida McFadden is a pseudonym, and that she also works as a doctor, but had never revealed her real name. She has now told USA Today she is actually Sara Cohen. "I'm at a point in my career when I'm tired of this being a secret," she explained. "I'm tired of people debating if I'm a real person or if I'm three men. I am a real person and I have a real identity and I don't



have anything to hide." Under the name McFadden, she was the second best-selling author of 2025 in the UK, selling 2.6 million books, and sold six million print copies in her home country. Those sales were fuelled by the success of The Housemaid, which was first published in 2022 and was turned into a film last year starring Sydney Sweeney and Amanda Seyfried.

Israeli strikes in Lebanon 'grave violation' of ceasefire, Iran minister tells

An Iranian minister has told the BBC that Israeli strikes in Lebanon on Wednesday constituted a "grave violation" of the US-Iran ceasefire agreement. Deputy Foreign Minister Saeed Khatibzadeh said Lebanon was covered by the two-week deal agreed on Tuesday - something the US and Israel dispute - and said the US must choose "between war and ceasefire". The Lebanese health ministry has said at least 203 people were killed on Wednesday in air strikes on what Israel called Hezbollah command centres and military sites. Pressed on whether Tehran would likewise ask Hezbollah to stop firing rockets toward Israel, Khatibzadeh claimed the Iranian-backed militant group had "abided" by the



ceasefire. Hezbollah said on Thursday that it had fired at Israel overnight in response to what it called ceasefire violations. It has also threatened to keep up its attacks until "Israeli-American aggression" against Lebanon comes to an end. Speaking to BBC Radio 4's Today programme, Khatibzadeh said Tehran had sent a "crystal clear" message to the White House

late on Wednesday which could be summarised as "you cannot have cake and eat it at the same time". "You cannot ask for a ceasefire and then accept terms and conditions, accept all the areas that a ceasefire is applied to, and name Lebanon, exactly Lebanon in that, and then your ally just starts a massacre." Pressed on whether this meant Iran would also ask

He's Australia's most decorated soldier. Now he's at the centre of a historic war crimes case



One of the most significant moments in Australian military history unfolded without fanfare on a tarmac at Sydney airport, when Ben Roberts-Smith was calmly escorted off a plane and into a waiting police car. The country's most-decorated living soldier and the most famous of his generation, Roberts-Smith was on Tuesday charged with five counts of the war crime of murder. It follows a high-profile civil defamation case, which three years ago found that the former Special Air Service (SAS) corporal and Victoria Cross recipient had unlawfully killed several unarmed Afghan detainees. Roberts-Smith, who left the Australian Defence Force (ADF) in 2013, denies all wrongdoing and says the allegations are "egregious" and driven by spiteful and jealous peers. His case - now set to be tested to a higher, criminal standard - has become the face of Australia's reckoning over the country's alleged conduct in Afghanistan, which has cast a pall over its much-mythologised military legacy. "For Roberts-Smith to

now be charged with war crimes - and not just one, but multiple war crimes - is a very significant cultural and social moment for a country that, for much of its history... has placed a lot of store in the exploits and contributions of the members of its defence forces." Professor Donald Rothwell told the BBC. But the prosecution of such a highly-decorated veteran is also an extraordinary moment for the globe. "We've never seen this before," says Deane-Peter Baker, a special forces ethics scholar. When Roberts-Smith came home from Afghanistan in 2013, he was considered a national hero, having been awarded Australia's highest military honour for single-handedly overpowering Taliban fighters attacking his SAS platoon. Plum speaking engagements and board gigs, magazine covers and massive portraits, accolades and awards - like Father of the Year - followed. But in 2018, Nine newspapers began publishing a series of articles alleging misconduct during his time with the SAS - claims of unlawful beatings and killings of prisoners.

ARGENTINA PASSES BILL LOOSENING PROTECTION OF ITS GLACIERS

Argentina's Congress has passed a controversial amendment making it easier to mine in glacier regions, a move environmentalists say weakens protections for crucial water sources. The pioneering Glacier Law, approved in 2010, prohibited all mining and exploration activities in glacier regions by protecting them as water reserves. The reform shifts the responsibility of defining protected glacier areas from the Argentine Institute for Snow, Ice and Environmental Sciences (Ianicla) to the provincial governments. President Javier Milei, who backed the reform, said the change

"empower[s] the provinces to utilise their resources" and allows mining activities "where there was nothing to protect". Argentina's Senate had already approved the bill in February 2026, so approval by the lower house was the last major hurdle left. Opponents of the reform argued that it would put a fundamental resource - water - at risk. "Without water, we can't even think about a growth and development project," Congresswoman Natalia de la Sota said. But a backer of the bill, Congresswoman Nancy Picón Martínez, said that the mining industry was being portrayed "as if it were a monster".



Tyson Fury Faces Bear-Wrestling Arslanbek Makhmudov In His Latest Comeback

Tyson Fury's latest comeback has revived the prospect of a long-awaited showdown with Anthony Joshua. First, though, the self-described "Gypsy King" needs to deal with a Russian-born heavyweight who wrestled a bear for fun. Arslanbek Makhmudov is Fury's opponent in their 12-round fight Saturday at Tottenham Hotspur Stadium. Fury, the former two-time heavyweight champion, came out of retirement for the fifth time because he wants to "punch men in the face and get paid for it." The 37-year-old Fury had called it quits shortly after losing to Oleksandr Usyk in December 2024 for a second time - his only two professional defeats. Usyk holds the WBC, WBA and IBF titles and at age 39 has indicated he only has a few fights left in him. The Ukrainian's next bout, though, has taken everyone by surprise - he's set to face kickboxing star Rico



Verhoeven in May at the Pyramids of Giza in Egypt. Also in May, WBO title holder Fabio Wardley faces Daniel Dubois in Manchester. Usyk told The Associated Press in a recent interview he foresees a trilogy bout with the charismatic Englishman: "In my head, Tyson Fury, it's the last dance." In their first meeting, Fury had lost his WBC

title to Usyk via split decision in May 2024. The rematch was a unanimous decision for Usyk. Fury (34-2-1, 24 KOs), if he can take care of business Saturday, has his sights set on Joshua, telling DAZN: "That's the fight we're looking to make next." The 36-year-old Joshua had called out Fury after breaking Jake Paul's jaw in a stoppage victory in

December. Days later, though, Joshua was involved in a fatal car crash in Nigeria. He was a passenger in the vehicle and two of his close friends were killed. Fury has said the tragedy is part of what motivated him to come out of retirement. Joshua appears set to resume fighting. Last weekend, he attended the Deontay

Wildner vs. Derek Chisora bout in London and had a brief exchange with Wildner after the American beat Chisora. The 36-year-old Makhmudov (21-2, 19 KOs) has created some buzz by posting a video that showed him wrestling a bear. He explained in a Feb. 21 social media post that "the goal was to overcome the threshold of fear and learn to control yourself in critical situations." Makhmudov hails from the Russian southern republic of Dagestan but lives in Canada. His most recent fight was a 12-round unanimous decision over Dave Allen in October. Babar Azam, Marnus Labuschagne's 'Peace Gesture' During PSL Brutally Trolled By Internet

A "peace gesture" was made before the start of a Pakistan Super League (PSL) 2026 game between Peshawar Zalmi and Hyderabad Kingsmen on Wednesday, as team captains Babar Azam and Marnus Labuschagne, along with PSL CEO Salman Naseer, released a white dove during the toss. The act came in the aftermath of the two-week ceasefire between the United States and Iran concerning geopolitical tension in the Gulf region. However, the PSL's "peace gesture" received criticism from several users on social media. Meanwhile, Babar Azam found himself at the centre of a heated moment off the field after dismissing comparisons with Virat Kohli during a post-match press conference in the Pakistan Super League 2026. The Peshawar Zalmi skipper, who guided his side to a tense last-ball



victory over the Hyderabad Kingsmen, appeared visibly displeased when questioned about his ability to finish games in comparison to Kohli. While Babar contributed a measured 43 off 37 balls in the chase of 146, he was not at the crease at the end, prompting the query. Responding in a seemingly frustrated manner, Babar brushed aside the suggestion and urged the journalist to move on from such debates. "Finish these things. Keep these things

to yourself. End the comparison and move on. It's your misconception that I have not finished matches," he said. The exchange quickly gained traction, once again highlighting the scrutiny surrounding cross-border comparisons between leading cricketers. Widely regarded as Pakistan's premier batter, Babar has often been praised for his consistency, though his approach in T20 cricket has drawn criticism, particularly around strike rate and finishing ability.

Bangladesh Cricketers 'Highly Underpaid', New BCB Head Tamim Iqbal 'Reportedly Shocked'

There has been a big change in Bangladesh cricket since the change in government. Former Bangladesh Cricket Board (BCB) chief Aminul Islam Bulbul has been removed, while former captain Tamim Iqbal is now leading the organisation. Reflecting on the decision to substantially increase domestic match fees and the salaries of men's and women's cricketers, Tamim said players had long been "highly underpaid" and warranted better financial acknowledgment. This decision marks the first move by the Tamim-led ad hoc committee, which began its work earlier this week, providing much-needed relief to Bangladesh's domestic cricketers, especially those



in the women's league. Although there was a hike, Tamim recognised that the updated figures represent only progress in the right direction. "This may not be ideal, but it is certainly an improvement, considering there are limits to how much can be increased at once," he told

ESPNcricinfo. Tamim was reportedly shocked, according to the ESPNcricinfo story, to learn that women cricketers earned as little as BDT 1,000 per match in domestic one-day competitions, a figure that has increased only slightly in recent years. As per the BCB's new salary

structure, match fees have been raised across different formats, with women players now earning BDT 10,000 for T20 matches, BDT 15,000 for 50-over games, and BDT 20,000 for first-class fixtures. Additionally, the monthly retainers for the top 36 women cricketers have been raised from BDT 30,000 to BDT 40,000, highlighting a wider effort to enhance financial stability within the system. The overhaul extends beyond women's cricket. Male domestic players have also received a salary increase, with Category A players now earning BDT 65,000 per month, while those in Categories B and C will receive BDT 50,000 and BDT 40,000 respectively.

'Dead Ball' Rule Row Strikes IPL After Delhi Capitals' 1-Run Defeat vs Gujarat Titans. Internet Reacts

Gujarat Titans pulled off a thrilling one-run win over Delhi Capitals with Kuldeep Yadav getting run-out on the final ball of the IPL 2026 encounter on Wednesday. With 2 runs needed off 2 balls, David Miller refused to take a single in order to stay on strike and that decision backfired massively as his team fell short of the target by the smallest of margins. SEVEN GAMES TO GO - HOW WILL DE ZERBI TRY TO SAVE SPURS?

Clubs at risk of relegation tend to hire pragmatic coaches. But that is not how you would describe new Tottenham boss Roberto de Zerbi. The Italian is known for his attacking style of possession-based football, and has stayed true to his footballing ideas throughout his managerial career. Three years after starting in management in Italy's fourth division, De Zerbi was in charge of Serie A side Palermo, where he struggled to showcase his initial potential. When he was sacked, newly promoted Benevento hired him, but relegation followed. Despite that, De Zerbi's reputation was boosted - and he has enjoyed much success since. The 46-year-old's quality is clear but his system relies on smart and technical play-



ers more than most tactical plans. So what tactics will De Zerbi implement at Spurs, and will this relegation-threatened group of players be able to execute them? Looking at De Zerbi's Brighton and Marseille sides, you soon notice how often they repeat certain patterns of play. When building up, the idea is to draw opponents towards defenders on the ball before

using quick passing routines to find free players facing forward. They are better positioned to play the ball up the pitch quickly into the attackers. When it works, De Zerbi's sides turn possession in their own half into shots near the opposition's goal within a few seconds. It's an electrifying watch - but the level of potential attacking reward comes with great risk. De Zerbi's approach requires defensive players to take responsibility with the ball - delaying actions until they have forced opponents to press them. In a recent training clip, external he was seen coaching his new players through concepts to make his tactics easier to implement. For central defenders under no pressure, the advice was to take many touches.

Strategic Shift In Dhaka: Bangladesh Makes Fresh Attempt To Repair Cricketing Relations With India

The appointment of former Bangladesh captain Tamim Iqbal as the interim president of an 11-member ad-hoc committee has offered the board fresh hope of reviving relations with India. Under his leadership, the board has formalised its interest in touring India while simultaneously inviting the BCCI to Bangladesh for a bilateral series later this year. This move carries significant weight, as India is already scheduled to visit Bangladesh under the current World Test Championship cycle. The development appears to be a clear diplomatic effort by the new administration in Dhaka to mend fences and move beyond recent friction between the two nations. Cricketing relationship between the two countries



hit an all-time low after Bangladesh pulled out of the T20 World Cup 2026 over 'security concerns' in India. Bangladesh were replaced by Scotland in the tournament after ICC refused to entertain the former's 'venue change' request. The BCB ad-hoc committee has also been tasked with conducting fresh elections within the next 90 days, marking a transition phase

in Bangladesh's cricket administration following the removal of chairman Aminul Islam Bulbul. Aminul Islam Bulbul Appeals to the ICC The ousted Bulbul has written to the International Cricket Council (ICC) seeking intervention after being removed by the National Sports Council. However, the plea is unlikely to gain much traction.

YUVRAJ SINGH OPENS UP ABOUT HIS CANCER DIAGNOSIS



One of the biggest match-winners in Indian cricket, Yuvraj Singh's story is one that would inspire several generations of cricketers. From winning Player of the Series awards in the 2007 T20 World Cup and the 2011 ODI World Cup to making a return after battling cancer, Yuvraj's life is a true cricketing hero's memoir. The man who beat cancer and made a comeback to the Indian team opened up on his battle with the deadly disease, revealing that he was told he had only three to six months left to live. Yuvraj was battling cancer during the 2011 World Cup, but he chose to fight the pain and doubt to deliver some of the finest performances of his career. After the World Cup ended, however, the former all-rounder realised how much his health had deteriorated. "It was hard to accept. At the peak of your career, you're on top of a mountain and then you fall into a ditch. I was in Delhi. We were going on tour to the West Indies and England. Ganguly had retired and my Test spot had just opened. I was waiting seven years for that spot. I said, 'I don't care if I die, I need that spot.' But I got sick-

er and sicker. "Dr Nitesh Rohatgi said to me, 'The tumour is sitting between your heart and lung. Either you go and play cricket or you might have a heart attack. You've got three to six months left to live if you don't do chemotherapy.' That's when I realised I needed to think," Yuvraj said during a chat with Michael Vaughan on The Overlap Cricket. This is when Yuvraj moved to the USA for treatment and was told that he might never get to play cricket again. But the winner's mentality in him didn't let him lose hope. "I went to the US to see Dr Einhorn, who treated Lance Armstrong. It took a whole year to come to terms with the fact that I might never play again. Mentally, it was harder. I needed something to motivate myself. If I don't play cricket, who am I? I'm no one. That's what I believed," he said. Yuvraj added that he kept watching cricket videos while undergoing treatment. During this period, the likes of Anil Kumble and Sachin Tendulkar paid him a visit to see him. Kumble even advised him to take rest and not put strain on his mind by watching videos.

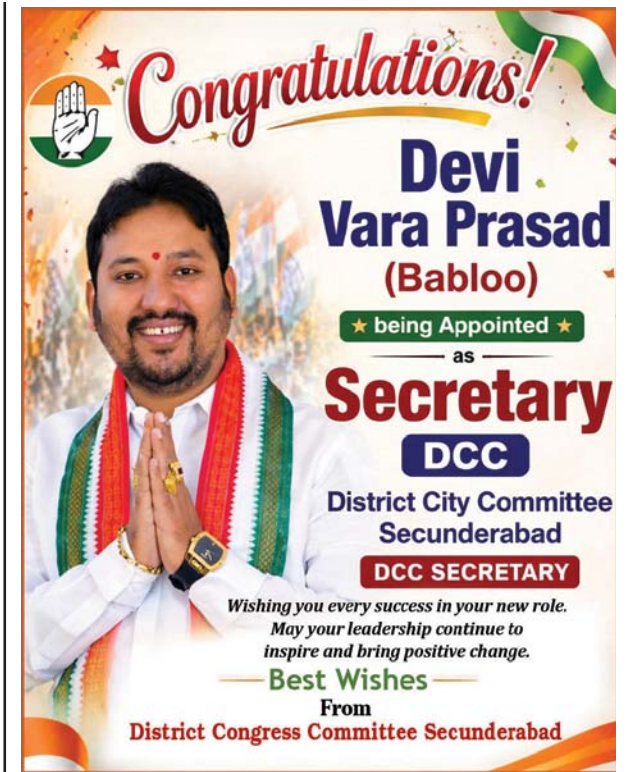

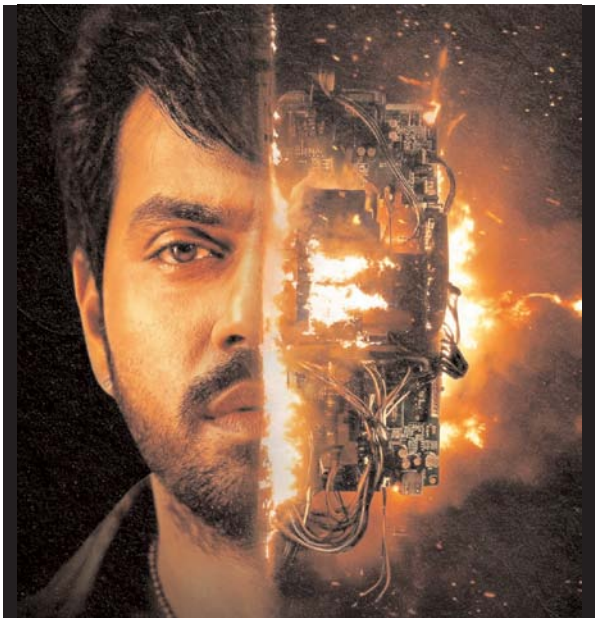
