ASHA BHOSLE HOSPITALIZED AFTER SUFFERING CARDIAC ARREST



Mumbai (TSIT) : Legendary playback singer Asha Bhosle has been admitted to the Breach Candy Hospital in Mumbai after she suffered a cardiac arrest on Saturday. The 92-year-old singer is currently undergoing treatment in the Emergency Medical Services unit. Breach Candy Doctor Pratit Sandani has shared a statement saying, "Legendary playback icon Asha Bhosale suffered a cardiac arrest on Saturday, April 10 and has been admitted to Breach Candy Hospital in Mumbai where she is currently undergoing treatment in the Emergency Medical Services unit." One of the most influential singers of her time, Asha Bhosle, sang her first song as a playback for the 1943 Marathi drama "Majha Bal".

BJP STRATEGY WILL NOT WORK IN BENGAL: SHATRUGHAN SINHA

Patna (TSIT) : Veteran Bollywood actor-turned-TMC MP Shatrughan Sinha launched a sharp attack on the Bharatiya Janata Party (BJP), asserting that its political strategies in West Bengal would not succeed (cholbe na). While interacting with the media persons in Patna on Saturday, Shatrughan Sinha referred to a recent viral video and claimed that it contains substantial truth and has exposed alleged conspiracies by the BJP. According to Sinha, TMC General Secretary Abhishek Banerjee has, through his astuteness, exposed the BJP's '1,000-crore deal' scandal—an impact of which is now visible across the entire country.

Bhatti flags delimitation concerns, reaffirms social justice commitment



Hyderabad TSIT: Bhatti Vikramarka Mallu on Saturday expressed serious concerns over the proposed delimitation of constituencies based solely on the 2011 Census, warning that such a move could weaken the political significance of southern states.

Addressing the Mahatma Phule Bicentenary celebrations at Ravindra Bharati, the Deputy Chief Minister said that ignoring caste census data while undertaking delimitation would adversely impact weaker sections across the country. He emphasized that southern states, which are leading social transformation, are being unfairly treated in the distribution of central tax revenues.

Highlighting disparities in tax devolution, he pointed out that

Telangana receives only 37 paise for every rupee contributed to the Centre, while states like Bihar and Uttar Pradesh receive significantly higher returns. He termed this imbalance as discriminatory and detrimental to federal principles. Calling for unity among Bahujan communities, Bhatti Vikramarka cautioned against attempts by feudal forces to regain influence and urged people to stand united in support of the people's government.

On the issue of backward class empowerment, he said the 42% BC reservation bill in education, employment, and political representation is currently pending with the Centre. He expressed hope that the Centre would approve the bill soon, enabling the state to implement it effectively. He also noted

that Telangana has conducted a caste survey, identifying 56% of the population as belonging to backward classes. The Deputy CM reiterated the government's commitment to social justice under the leadership of A. Revanth Reddy, stating that welfare policies are being designed with a focus on equitable development.

He further announced key initiatives in the education sector, including the launch of Young India Integrated Residential Schools, expansion of welfare hostels, and introduction of a breakfast scheme for nearly 20 lakh government school students from June 2. He added that the state has allocated 13.5% of its budget to education, reflecting its priority towards building an inclusive society.

PM Modi urges change of Bengal regime ruling over lies for 15 years

Promises probe into corruption and justice for victims if BJP comes to power

Kolkata (TSIT): Prime Minister Narendra Modi, in the last of his three campaign rallies in West Bengal on Saturday amid the crucial two-phase Assembly polls in the state next month, gave a call to the people of the state to change the Trinamool Congress regime, which he said had been ruling the people "over lies" for the last 15 years.

He said, "You gave a chance to the previous Left Front regime for 34 years. Then you gave three consecutive chances to the Trinamool Congress government, which ruled over you for the last 15 years. They are winning consecutive elections, just making fake promises and abusing me."

"But I want to ask you, when there was no development in the state for the last 15 years, then how could there be any future development if you give Trinamool Congress another term of five years? For the last 15 years, a ruling model of corruption and terror. So change this regime this

time, which has been ruling on lies for the last 15 years. Give us a chance for five years." The Prime Minister was addressing a campaign rally in Kushmandi, South Dinajpur district, West Bengal. Earlier, he addressed two other campaign rallies, first at Katwa in East Burdwan district

and the other at Jangipur in Murshidabad district.

Speaking on the occasion, he also said that if the BJP comes to power in West Bengal, it would constitute a special committee with representation from retired judges of the Supreme Court to reveal instances of corruption and other related misrule during the 15 years of the Trinamool Congress regime.

"The said committee will ensure justice for the victims of such misrule and corruption. Our sole aim is to bring out the people of West Bengal from this constant feeling and assure them of future development and peace," PM Modi said.

He also said that after coming to power, the first task of the BJP government in West Bengal will be to reopen all the rape and murder-related files in the state. "This is my guarantee to the women of West Bengal. Each such file will be reopened, and every culprit will be accounted for," PM Modi said.

Another 312 Indian fishermen safely evacuated from Iran to India through Armenia: EAM Jaishankar



New Delhi (TSIT) : External Affairs Minister, S. Jaishankar, on Saturday said that another 312 Indian fishermen were safely evacuated from Iran to India through Armenia. He further thanked the government of Armenia for making it possible.

EAM S. Jaishankar took to social media 'X' and said, "Another 312 Indian fishermen safely evacuated from Iran to India through Armenia. Thank the Government of Armenia and my friend Ararat Mirzoyan for making it possible." Earlier on April 5, a total of 345 Indian fishermen stranded in Iran amid the ongoing West Asia conflict had arrived safely in Chennai after being evacuated through Armenia. According to the Ministry of External Affairs, the fishermen were brought back as part of India's continued efforts to ensure the safety of its nationals in the conflict-affected region. EAM Jaishankar, in a social media post had expressed gratitude to the Armenian government for facilitating the evacuation and thanked his counterpart Ararat Mirzoyan for enabling the safe transit of Indian nationals from Iran to India amid the conflict. Armenia has been facilitating the evacuation of Indian nationals in Iran. The MEA had said that more than 1,200 Indian nationals have been safely evacuated from Iran, out of which 996 moved to Armenia. Meanwhile, the delegations from the United States and Iran reached Islamabad for negotiations aimed at addressing the escalating tensions in the Gulf region.

20+ Karnataka MLAs to visit Delhi amid reshuffle buzz

TPCC Chief Mahesh Kumar Goud Targets Opposition, Highlights Welfare and Development Initiatives

Mulugu TSIT: Telangana Pradesh Congress Committee (TPCC) President and MLC Mahesh Kumar Goud launched a sharp attack on the opposition while highlighting the state government's welfare and development agenda during his address in Mulugu.

He remarked that governments may come and go, but



political parties remain permanent. Criticizing former Chief Minister K. He stated that Rs.600 crore has been allocated for land acquisition under the Devadula Lift

Irrigation Scheme and announced plans to establish medical and nursing colleges in the district.

Praising Minister Seethakka, he said her journey from armed struggle to serving as a minister reflects dedication to public service. He also noted that the recent Global Summit attracted investments worth over Rs.5 lakh crore to the state.

Goud alleged that corruption within the previous regime is evident from issues surrounding the Kaleshwaram Lift Irrigation Project, blaming it on mismanagement and corrupt practices. He further accused political families of internal conflicts driven by power struggles.

Taking aim at the Bharatiya Janata Party, he said the party has failed to deliver tangible benefits to Telangana over the past decade and has no significant future in the state. He alleged that profitable public sector enterprises were handed over to corporate giants like Mukesh Ambani and Gautam Adani, and criticized BJP leaders for mixing religion with politics.

De-Addiction Centres Launched in 35 Government Hospitals Minister Damodar Raja Narasimha



Hyderabad, April 11: Telangana Health Minister Damodar Raja Narasimha on Saturday launched de-addiction centres in 35 government general hospitals across the state, marking a major step towards tackling substance abuse as a public health issue. The initiative was formally inaugurated at Gandhi Hospital, where the Minister also inspected the newly established facilities.

Addressing a state-level awareness programme organised by the Drug Control Authority, the Minister said that addiction to drugs and intoxicants can be completely overcome with timely treatment and proper counselling. He emphasized that support from family members and friends plays a crucial role in helping individuals recover and reintegrate into normal life. The de-addiction centres will provide comprehensive services including screening, treatment, counselling, and follow-up care. Special

intoxication care units have also been set up to ensure dedicated medical attention for affected individuals.

The Minister reiterated that the government will not tolerate the misuse of drugs and medicines. Strict action will be taken against the illegal sale of medicines, particularly those being abused as intoxicants, including antibiotics. He also warned against the growing threat of Anti-Microbial Resistance due to indiscriminate use of antibiotics.

Highlighting Telangana's prominence as a global pharmaceutical hub, he noted that the state houses over 1,500 manufacturing units, 80 testing centres, and more than 50,000 medical shops. Medicines and vaccines produced in Telangana are widely used across the world, and maintaining quality and safety standards remains a top priority.

He further stated that regular inspections are being conducted statewide, and

stringent action is being taken against those involved in the sale of spurious or substandard drugs. The government has also strengthened enforcement mechanisms through systems like EAGLE to curb drug-related crimes effectively.

Calling for a collective effort, the Minister urged pharmacists to ensure responsible dispensing of medicines strictly based on prescriptions, and appealed to the public not to stigmatize individuals suffering from addiction, but instead encourage them to seek treatment. "Prevention is better than cure. Let us work together to build a healthy, drug-free Telangana," the Minister said. On the occasion, awareness posters were released, and students who excelled in related competitions were awarded. The Minister also felicitated journalists for their role in spreading awareness about health initiatives under the Praja Palana-Pragati Plan.

were invited in November 2025 for 38,130 mobile phones through the Government e-Marketplace (GeM) portal in the presence of an expert committee. While the Centre fixed the price at Rs. 11,800, the State government procured the devices at Rs. 11,650 each.

She added that the package included multiple additional components such as a power adapter, USB cable, protective accessories, and a two-year Mobile Device Management system, making the procurement cost-effective. Telangana, she said, secured the devices at a

lower price compared to several other states.

Defending Minister Seethakka, Indira Shobhan said targeting her character for political mileage was highly condemnable. She described Seethakka as a leader who rose from humble beginnings and continues to work tirelessly for the welfare of the poor with integrity.

She warned that if defamatory campaigns and social media trolling continue without evidence, legal action would be initiated against those responsible, including Krishank and other BRS leaders. She advised the opposition to pursue legal channels if they have proof, instead of resorting to personal attacks. by Ram Mohan and Venu and taken to Paradise Colony. Later, Kanakavalli Brahmaiah alias Anna Reddy and Ravi alias Madhu joined them and shifted the victim to a villa at CSK Villas. After confirming the cash under the guise of conducting rituals, the gang carried out the robbery. At the villa, four masked men barged in, threatened the victim with weapons, and took away the cash. The

victims were then confined inside before the accused fled the scene.

Based on a complaint, police launched an investigation under the supervision of Commissioner K. Sudheer Babu, DCP C.H. Sirisha, and S. Lakshminarayana. The probe was handled by Rural Inspector Srinivasulu and CI Seetharam, with the crime team using CCTV footage and technical evidence to identify the suspects.

YSRCP MLC alleges Rs 60 crore plantation scam in Nellore

Nellore, Apr 11 (UNI) YSR Congress Party MLC Parvathareddy Chandrasekhar Reddy alleged that a massive Rs 60 crore scam, in the name of plantation works in Nellore Municipal Corporation, took place and accused Minister P Narayana of orchestrating large-scale misuse of public funds.

Addressing the media at the YSRCP office here on Saturday, he claimed that a plan was drawn to plant 48,000 saplings with an expenditure of nearly Rs. 12,000 per plant, far higher than the Rs. 750 per sapling spent during the previous YSRCP government.

"In the first phase alone, Rs 8.03 crore was paid for 14,741 saplings, with Rs 5,446 spent per plant, including tree guards, while an additional Rs 1.24 crore was estimated just for watering 1,800 plants, amounting to Rs 6,888 per plant for watering alone," he slammed.

The YSRCP MLC charged that contracts were awarded to 25 contractors linked to the



ruling party and that works were being executed without adherence to norms, including planting saplings on gravel roads while claiming cement road cutting in tenders, and raising bills even for plants placed on private lands.

The YSRCP leader further pointed out that in several locations, tree guards were not installed, saplings were planted under electric lines, and unsuitable flowering plants with limited lifespan were being used instead of shade-giving trees. Criticising the timing, he said plantations

were being carried out in peak summer without concern for survival, indicating that the objective was only to generate bills.

Chandrasekhar Reddy also said the minister's "N-team" of turning corruption into a system in Nellore, citing irregularities across multiple civic projects, including smart street vending, traffic signals, bio-toilets, garbage transport, silt cleaning, mosquito control, and road works, most of which were allegedly executed through nominated contracts.

He contrasted this with the government's treatment of the poor, stating that water connections were cut for non-payment of as little as Rs. 350 while crores were being siphoned off through inflated contracts.

He further highlighted penalties imposed on small vendors for minor encroachments, stating that the government is burdening common citizens with taxes while enabling large-scale corruption at the top.

PROSECUTORS KEY TO ERADICATING TRAFFICKING, BONDED LABOUR: AP HOME MINISTER



Visakhapatnam, April 11: Andhra Pradesh Home Minister Vangalapati Anitha stated that public prosecutors play a vital role in eliminating social evils such as bonded labour and human trafficking. She was inaugurating a capacity-building workshop for public prosecutors at Four Points by Sheraton Visakhapatnam.

Addressing the gathering, the Minister that strict punishment for offenders is possible only through effective coordination between the police and prosecution departments. She stressed the need for prosecutors to be actively involved from the stage of filing charge sheets and highlighted the importance of collecting forensic evidence during the "golden

hour" to improve conviction rates. She appreciated the swift disposal of a recent POCSO case in Ongole, where a 20-year sentence was delivered in a short period. Highlighting government initiatives, she said that under "Operation Trace," around 900 children have been rescued, while 180 individuals were safely brought back from abroad.

The Minister also called for increased use of modern technologies, including artificial intelligence, in investigations. She noted that rescued victims of bonded labour are being provided financial assistance of Rs.30,000 by the Central Government, along with skill development training by the State Government for rehabili-

tation.

Visakhapatnam Police Commissioner Shankhabrata Bagchi said the workshop was jointly organised by the Andhra Pradesh Prosecution Department and International Justice Mission. He explained that paying wages below the minimum wage amounts to forced labour under Article 23 of the Constitution.

He highlighted victim protection measures such as in-camera trials and audio-visual recording of evidence under new legal provisions. Calling human trafficking an organised crime, he stressed the need for extradition of accused persons through international cooperation and suggested confiscation of offenders' assets to compensate victims. The Commissioner emphasized coordinated efforts among police, prosecution, and the judiciary to safeguard victims' rights and ensure justice, while also advocating a humane approach toward victim rehabilitation. Later, the Minister felicitated public prosecutors for their outstanding performance. The event was attended by Director of Prosecution Ramakoteswara Rao, Clement David, public prosecutors from various districts, and police officials.

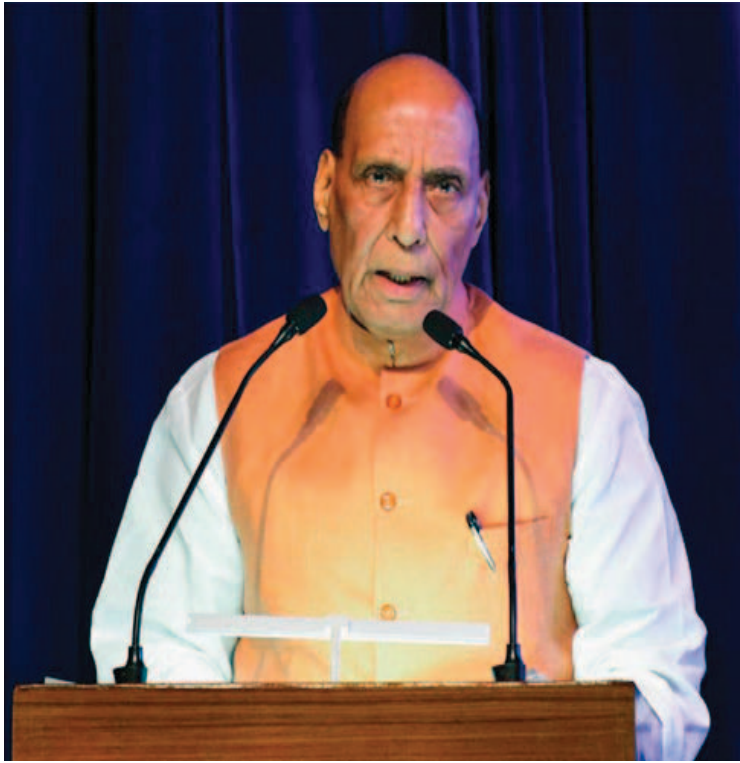
The summit marked a significant step toward strengthening autism care and promoting an inclusive ecosystem for individuals with ASD.

Rajnath highlights growth, defence boost and development vision in Lucknow

Lucknow, Apr 11: Defence minister Rajnath Singh on Saturday said that India continues to remain one of the fastest-growing major economies despite ongoing global geopolitical challenges, while stressing that the vision of a developed nation by 2047 requires collective effort.

Speaking at an event in Lucknow, he underlined that the idea of "Viksit Bharat@2047" is rooted in inclusive growth, where every citizen contributes to and benefits from development. He said the principle of ensuring that "no one is left behind" must guide the country's progress.

Highlighting Lucknow's growing importance in the defence sector, Singh said the city has emerged as a key hub, having been designated a defence node along with Agra and Kanpur. He noted that the BrahMos missile is now being manufactured in Lucknow, with the first batch already delivered to the armed forces. He added that several small and large defence manufacturing units are being set up in the region, strengthening local industry.



Earlier, addressing the annual celebration of the Jan Kalyan Maha Samiti in Gomti Nagar, the minister reflected on Uttar Pradesh's transformation. He said the state, once labelled as

"BIMARU," is now being recognised as "Uttam Pradesh," pointing to improvements in law and order and overall development.

He also spoke about cultural initiatives, mentioning the Lucknow Culture and Art Museum at the Hussainabad Clock Tower, which aims to preserve and showcase the heritage of Awadh. According to him, such projects will not only strengthen cultural identity but also boost tourism and create employment opportunities for local artisans and businesses.

On infrastructure, Singh announced the construction of National Highway 927, a 101-kilometre four-lane corridor from Barabanki to Bahraich, with an estimated investment of Rs 7,000 crore. The project is expected to significantly cut travel time between the two locations from about 2.5 hours to nearly 1.25 hours.

He added that the highway will also support the development of a new corridor around the state capital region, further accelerating economic growth and connectivity in and around Lucknow.

Global delegates laud India's electoral system after witnessing Kerala, Puducherry and Assam polls

New Delhi, Apr 11: A group of 38 international delegates from 22 countries has praised the Election Commission of India after observing the conduct and organisation of the April 9 Assembly elections in Kerala, Puducherry, and Assam, describing India's polling system as a model of efficiency and participation. The delegation, hosted under the Election Commission of India's International Election Visitors' Programme (IEVP) 2026, closely witnessed multiple stages of the electoral process, including dispatch centres, mock polling exercises, and live voting at designated polling stations.

Branimir Farkas of Croatia described India's



elections as a "true festival of democracy," highlighting the enthusiasm of voters and the scale of operations involved. He noted that the experience demonstrated how a complex democratic exercise can be conducted smoothly and effectively.

Uuc-Kib Espadas Ancona from Mexico also praised the process, saying that India's election sys-

tem serves as a valuable learning example for democracies worldwide.

During the visit, delegates were taken to polling stations across Assam (Kamrup Metro and Kamrup Rural), Kerala (Kochi and Thiruvananthapuram), and Puducherry, where they observed live voting procedures and election management practices.

'Punjab govt should announce crop insurance scheme during Apr 13 special Assembly session'

CHANDIGARH: Punjab BJP president Sunil Jakhar on Friday said the state government should announce the implementation of a crop insurance scheme for farmers during the special Vidhan Sabha session scheduled for April 13.

Jakhar said he has also written a letter to Chief Minister Bhagwant Mann in this regard.

He said that although the Centre has already implemented a crop insurance scheme, the Punjab government has not notified it.

By doing so, the chief minister is committing a major injustice toward farmers, Jakhar alleged.

He said that farmers in Punjab are currently facing severe natural calamities.

"Unseasonal rains and hailstorms have caused large-scale crop damage.

Earlier, floods in 2023 and 2025 also led to massive destruction, and even now many farmers have not received compensation because no crop insurance scheme is in place in Punjab. Even today, farmers remain worried about how their losses due to such disasters will be compensated," the BJP leader said.

He reminded the chief minister that three years ago, it was announced that the Punjab government would introduce its own agricultural insurance scheme in place of the central government's Pradhan Mantri Fasal Bima Yojana.

"However, despite three years having passed and farmers suffering losses worth thousands of crores, the scheme is still awaited," he said.

Jakhar said that since

the Punjab government has called a special Assembly session on April 13, Mann should fulfil his promise and, without delay, announce Punjab's own crop insurance scheme during this session so that farmers can be compensated during natural disasters.

The AAP government has convened a special session of the Punjab Vidhan Sabha on April 13 to amend the Jagat Jot Sri Guru Granth Sahib Satkar Act, 2008, for stricter punishment against sacrilege of Guru Granth Sahib and other religious texts.

He further advised that if the state government's financial condition is weak, it should immediately implement the central government's crop insurance scheme, which is already operational in other states

and has proven beneficial for farmers.

The BJP leader alleged that every section of society is unhappy with the current government; with farmers not receiving compensation, traders and industrialists not getting a peaceful environment, and poor law and order along with drug issues have created fear among the people.

Jakhar also said that thousands of government employees and pensioners in Punjab are facing financial hardship because the state government has not provided the due increase in Dearness Allowance (DA).

He pointed out that while the central government and neighbouring states are giving 58 per cent DA, Punjab is providing only 42 per cent.

Kharge flags delimitation, women quota timing

NEW DELHI: Congress president Mallikarjun Kharge on Friday raised concerns over the proposed delimitation exercise and the timing of a special Parliament session on the women's reservation Bill, calling for wider consultations.

Addressing a meeting of the Congress Working Committee, Kharge said the proposed delimitation could have "serious consequences" and requires detailed discussion.

He said the special session of Parliament scheduled from April 16 to 18 to consider constitutional amendments related to women's reservation raises concerns, alleging that the timing could influence upcoming Assembly elections.

Kanhaiya hits out at Centre, flags threats to democracy

JALNA: Congress leader Kanhaiya Kumar has slammed the BJP-led Central government, accusing it of weakening democratic institutions, and stated that power has become concentrated in the hands of a few, reducing citizens to mere members of a crowd.

Kumar lamented that leaders across party lines pay symbolic tributes to Dr B R Ambedkar but fail to follow his teachings.

The Congress leader was speaking on the topic "Indian democracy and its challenges" at Dr Babasaheb Ambedkar lecture series in Maharashtra's Jalna on Thursday, to mark the Dalit icon's 135th birth anniversary.

He alleged that electoral processes are being manipulated by money power, with voters being influenced before elections and elected representatives being "purchased" afterwards.

Referring to the ideas of Dr B. R. Ambedkar, he stressed that political democracy cannot survive without social and economic democracy.

He said that the current situation in the country reflects Ambedkar's warnings, alleging that public assets are being handed over to a select group of industrialists.

"Today, only those with money can contest and win elections, while the common man is left behind," the

Opposition party leader said, adding that citizens have become part of a crowd and have been stripped of their identity.

Issues like polarisation and hatred are deliberately used during elections to garner votes, he claimed, and accused the ruling party of spreading false narratives and diverting public attention from real issues by creating artificial problems and encouraging social divisions.

The National Students Union of India (NSUI) in-charge criticised leaders across party lines for paying symbolic tributes to Ambedkar while failing to follow his teachings.

The country is being run with the

power of lathis and guns, he claimed, alleging that the government is deepening social divisions based on caste and religion.

Kumar also alleged that dissent is being suppressed, with those raising their voices against the government being labelled as anti-national.

"The real power does not lie with the visible faces of governance, but with those controlling the system from behind," he claimed.

Kumar called for the creation of an egalitarian society based on Ambedkar's ideology, and urged people to unite around the principles of equality to safeguard democracy and the Constitution.

Mizo students Org call for stricter ILP enforcement

AIZAWL: Mizoram's influential student organisation, the Mizo Zirlai Pawl (MZP), has called for stronger enforcement and tightening of the Inner Line Permit (ILP) system in the state, citing growing concerns over the increasing entry of non-locals without valid permits, a student leader said on Friday.

The demand was a central pillar of the resolutions passed during the Mizo Zirlai Pawl (MZP)'s federal council meeting, the organisation's highest decision-making body, held in Aizawl on Friday, according to MZP general secretary Lalhminganga Chhangte. He said that the council unanimously resolved to push the state government for a more stringent and advanced ILP system to curb illegal influx of non-tribal people from outside.

Addressing the council, MZP president C Lalremruata emphasised that protecting the ILP system is not just a policy issue but a collective responsibility as it serves as a safeguard for the identity, security, and future of the indigenous people of Mizoram.

He said that the recent rise in the alleged unauthorised

entry of outsiders (non-tribal) poses a serious challenge.

Lalremruata urged the MZP leaders across all branches to intensify ground-level monitoring and utilise the ILP system more effectively to ensure the state's security.

He emphasised the need for stricter monitoring, more effective implementation, and wider public awareness regarding the ILP mechanism.

The student leader also expressed concern regarding identity issues among 'Zofa' (ethnic Mizos) living in different parts of the country and the world. "While the MZP remains committed to the unity of all Zofa and embraces all our sisters and brothers, it discourages superficial association or the use of the Mizo nomenclature solely for personal gain," he said.

Apart from ILP, the council also discussed a wide range of issues and adopted several resolutions urging the state government to take proactive measures to address the shortage of teachers and ensure rationalisation, to promote Mizo code of ethics (Zonun zemawi) in educational institutions.

Delhi Govt to study transplanted trees, bring in new machines to improve survival rates

NEW DELHI: Amid concerns over the low survival rates of transplanted trees, the Delhi government has commissioned a scientific study to understand survival trends and planned to import advanced tree transplanter machines from abroad to make the process more effective.

Officials said the Forest Research Institute, Dehradun has been asked to conduct a study within three months. "These steps are being taken to make changes in the Delhi Tree Transplantation Policy 2020 based on scientific evidence," they said.

The move follows concerns over low survival rates of transplanted trees, with a previous report by the Forest Research Institute estimating an overall survival rate of 35.45 per cent, with significant variation across species.

Forest department data also showed that of the 1,357 trees transplanted between 2019 and 2022, 578 survived, translating to a survival rate of 42.5 per cent.

Delhi Environment and Forest Minister Manjinder Singh Sirsa told PTI, "We are taking steps

to make the tree transplantation process in Delhi more effective and better. We are conducting this study to understand why transplantation has faced persistent challenges over the years.

"The findings will help us adopt a more scientific approach based on field evidence and expert inputs, and make the city greener," he said. The minister further said that a new Expression of Interest has been floated that will also help in bringing advanced tree transplanter machines from abroad to the national capital that can improve survival rates and help the process.

A senior official aware of the matter said the institute had sought a year to complete the study but that they have been asked to submit the report within three months "so that necessary changes can be made and further loss of transplanted trees can be prevented".

Speaking about the new machinery, officials said that existing methods use backhoe loaders that often damage roots and cause transplant shock.

"These machines have been used in Gujarat and can uproot medium-sized trees. The proposed study will help assess their effectiveness in Delhi conditions," officials said.

The Forest Research Institute report noted that survival rates remain below expectations and vary widely, prompting a review of existing practices which officials said need greater standardisation and scientific inputs.

According to a minutes of a meeting of the Delhi forest department with empanelled agencies held in January noted that agencies were not consistently following permissions issued by Tree Officers or adhering to approved Tree Preservation Plans and timelines. The meeting also stressed the need for stronger oversight, including inspection of transplantation sites by Tree Officers and directions to improve survival outcomes.

Officials further suggested developing a system to capture detailed data on each transplanted tree, including species, girth and survival rates, to guide future pol-



icy decisions.

Consultations with the empanelled agencies highlighted that factors such as species, age, girth and size play a critical role in determining survival, reinforcing the need for a more scientific and standardised transplantation process.

The meeting identified species-specific trends. Trees such as peepal, bargad, gular, pilkhan, ar-

jun, semal, amaltas, sahan, gulmohar, peltophorum and alstonia showed relatively higher survival and can be transplanted up to a girth of 350 cm.

Ficus species were found to have the best survival performance among transplanted trees, and officials noted that their branches could also be used for plantation through vegetative propagation where feasible.

EDITORIAL

The Art of Institutional Double Standards

Sir Humphrey Appleby, the incomparable bureaucrat of British television, once explained governance to a bemused minister with characteristic wit: "The correct procedure, Minister, is not a means to an end. It is the end. Once you understand that, everything becomes quite straightforward." He was, of course, joking. Those who understood his character, however, know that he wasn't. There is a distinct sophistication to institutional double standards. They arrive cloaked in procedure, bolstered by precedent, and supported by regulation. They do not say we are favouring ourselves. They say the framework requires this outcome. The framework, conveniently was designed by those it now serves. The honourable Supreme Court of India was recently moved to act against three authors of a 14-page chapter in a Class 8 NCERT Political Science textbook. The chapter dealt with one of the pillars of Indian democracy the judiciary. Its fault lay primarily in two paragraphs touching on challenges facing it: pendency and corruption that took up just two paragraphs in 14 pages. The decree that followed, as widely reported, involved excluding the authors from government opportunities without a hearing, and without the due process that courts exist to guarantee. The chapter is understood to be under revision. The stated concern, that 13-year-olds should not be exposed to uncomfortable questions about one institution while others go unexamined, is itself a proposition that warrants examination. Courts routinely ask the most powerful institutions in the land to account for themselves. That is, in fact, the point of having them. I am not a constitutional expert or a lawyer, but I suppose the judiciary should expect of itself what it demands from other institutions: transparency, credibility, legitimacy and due process. A guild, however honourable, that seeks to protect its image ahead of its principles is still a guild. Such examples can be traced to other institutions as well. Consider, for example, the Telecom Regulatory Authority of India (TRAI) established in 1997 as an independent buffer between a liberalising market and a government that retained, through Bharat Sanchar Nigam Limited (BSNL), a fully state-owned legacy operator. It offers a more nuanced illustration of double standards that have been visible at several points in its regulatory evolution, not just in outcomes but in design. Spectrum, the life force of the telecom sector, has been allocated to BSNL administratively, at rates bearing little resemblance to auction-determined values. Interconnection tells a similar story. Early Interconnect Usage Charges, the fees an operator pays another to terminate calls on a rival network, were structured in ways that favoured the incumbent. Of the nine chairpersons TRAI has had since inception, eight have come from government service. Six of the nine have emerged from a single service cadre. The cadre, like any guild, protects its own. Outsiders are not welcome and criticism even less so. Such regulatory sinecures, prestigious and well-compensated, provide limited incentive to take on the ministry that, for all practical purposes, owns the public sector operator. This is not to suggest that private players have been passive innocents. They have navigated the regulatory environment with considerable skill, litigating effectively, lobbying strategically and occasionally managing to benefit from regulatory shifts. The double standard has therefore not always been binary, even if in the final analysis, BSNL might edge ahead. One solution, as in the case of Air India, would be to sell BSNL at a more appropriate time, excluding the land it owns, and permanently rid the sector of the conflicts of interest and double standards that seep through ownership structures. International institutions are not immune from such tendencies either. Consider the World Trade Organisation's architecture on agricultural subsidies, perhaps the most glaring example in contemporary trade law of process that is now well past its expiry date.

ECI's Motto of 'No Voter to Be Left Behind' Has Now Been Left Far Behind

As the Special Intensive Revision (SIR) in West Bengal has concluded and assembly elections are only days away, about 90 lakh names have been removed from the voter lists. About 57% of them are from districts bordering Bangladesh. Exclusions highlighted in the media include a former justice of the Calcutta high court, the 88-year-old grandson of Nandalal Bose who decorated the original copy of the Constitution, a decorated Indian Air Force veteran, and a Kargil war veteran, among many others. Without going into the legality of whether the Election Commission of India (ECI) was empowered to conduct SIR in the manner it is being conducted, we would have been happy if ECI had succeeded in its avowed motto of 'no voter to be left behind.' Till now, SIR has been completed in nine major states viz. Bihar, Chhattisgarh, Gujarat, Kerala, Madhya Pradesh, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal. Combined with special revision in Assam, the eligible population covered so far has been more than 63% of persons above 18 years, is quite substantial and diversified. About 45 million names were deleted on account of them having been 'absentee', 'shifted', or 'missing', as per the draft rolls in the nine SIR states. Moreover, in the final rolls, the gap between the expected eligible citizens and the number of registered electors in these 10 states is around 70 million. If a similar trend persists in the remaining states also, the gap for all-India is likely to become more than 110 million. As this significant gap can largely be attributed to deletion of absentees, shifted and missing voters, and logical discrepancies, in this article we propose to discuss whether any eligible citizen, as enshrined in section 19 of Representation of the People Act 1950 (RPA), can be deprived from registration in the



electoral rolls.

RECAPITULATION OF STATUTORY PROVISIONS

In the SIR, electors whose filled-in enumeration forms were not submitted, have been excluded from the draft rolls, presuming them to have shifted elsewhere without intent to return. The 'absentee' or 'shifted' status hinges on the ordinary residence. Any question as to where a person is ordinarily resident at the relevant time has to be determined with reference to several facts and is to such rules as may be made in this behalf. However, neither the Union government nor the ECI have made any rules defining it. The procedure currently followed is based on the judgement of the Gauhati high court in the Manmohan Singh case, which defined the 'Ordinary Resident' to mean a usual and normal resident of that place, permanent in character, not temporary or casual and for a considerable time. It is the place where one habitually sleeps at night. The Supreme Court has also held that the person has to have an

intention to stay at that place for a considerably long time. RPA's Section 20(1A) also stipulates that persons absenting themselves temporarily from their place of ordinary residence shall not, by reason thereof, cease to be ordinarily resident therein. Accordingly, the ECI manual stipulates that the temporary absence from place of ordinary residence will not deprive a person of the qualification of ordinary residence, if they possess the ability to return and has intention to return to that place.

EXCLUSION FROM DRAFT ROLLS

In fact, the exclusion of absentee or shifted persons was built into the SIR, as their names were not to be included in the draft rolls. Most of the persons who were absent or temporarily shifted, albeit otherwise ordinarily resident of that constituency, may not have been available to receive the forms. Most of them may not have been in a position to come back immediately from their current place of work or residential to submit required docu-

ments to the BLO. It was quite a demand to expect a person, particularly poor migrant workers, to travel to their home town or village. Most of them may have been very poor to afford travel to their place where they were registered as voters. Though the facility for online uploading of forms and documents was provided by ECI, but the question is how many such migrants are sufficiently digitally literate to avail themselves of it. Moreover, even in case of online uploading, the BLO is to verify the documents by visiting the household. This makes the facility ab initio redundant for the absentee or temporarily shifted voter. Hence, all such electors whose names were not included in the draft rolls, as their filled-in forms were not returned by the stipulated dates, did not get any opportunity to be heard in person under Section 22 of the RPA. Whether the statutory rights of these persons can be curtailed in SIR is to be addressed in the judicial fora.

This Ceasefire Should Be a Moment of Introspection for India

As Iran negotiates from strength and Pakistan claims a peacemaker's laurels, the Narendra Modi government's silence and strategic drift have left India watching from the margins of a reordering world. The entire world will cautiously welcome the two-week ceasefire in the West Asia conflict between the United States and Israel on one side and Iran on the other. It is a pause, not a peace. But even a pause, in a conflict that threatened to engulf civilisation itself, is cause for measured relief. What the ceasefire has revealed, however, is as consequential as the conflict it has temporarily silenced: a new map of global influence is being drawn, and India is not among the cartographers. The conflict began on 28 February with the targeted assassinations of the topmost echelons of the Iranian regime. These strikes commenced just two days after Prime Minister Narendra Modi completed his much-trumpeted visit to Israel. A visit that said nothing about Israel's continuing genocide in Gaza, nothing about its aggressively expansionist policies in the occupied West Bank, and everything about where India's moral compass now points. That silence, at such a moment, diminished India's global stature in ways that will take years to recover. The role played by Pakistan in brokering the ceasefire is a severe setback to both the substance and the style of Modi's highly personalised diplomacy. For a decade, the policy has been to isolate Pakistan internationally, to convince the world that it is a failed state, a terror sponsor, unworthy of the global high table. That policy has now collapsed spectacularly in full public view. As recently as 2018, Pakistan was on infamous FATF list for supporting terror networks. Now it is the peace maker. A bankrupt, broken Pakistan could play peacemaker. A resur-

gent India could only watch. The question is not what happened, but why. A bankrupt economy, wholly dependent on the largesse of the IMF, the Gulf states, and China; a country broken in so many institutional ways, Pakistan was able to play the role of indispensable mediator in the most consequential conflict of recent times. This is not merely a diplomatic embarrassment. It is a strategic failure of the first order. One recalls what Manmohan Singh's government accomplished after the 2008 Mumbai terror attacks: the methodical, evidence-based international isolation of Pakistan's terror networks, achieved without bellicose posturing and without abandoning India's moral voice on the world stage. The contrast with the present dispensation is not merely stylistic. Modi or his team have also never explained why Operation Sindoor was suddenly and abruptly halted on May 10, 2025. The first public announcement of which came not from South Block but from the United States and for which President Trump has claimed credit almost a hundred times since. Iran, for its part, has written a chapter that history will not forget. Faced with the threat of obliteration, a word Donald Trump used with casual menace, Iran's people became a human shield for their own civilisation. The asymmetry of the conflict was total: the world's most powerful military and the most sophisticated air force in West Asia against a country under decades of sanctions, its infrastructure degraded, its alliances limited. And yet Iran did not capitulate. It extracted conditions at the negotiating table that, a year ago, would have been considered unimaginable. Among those conditions is a principle with enormous long-term strategic significance: the monetisation of the Strait of Hormuz.

Through one of history's most critical chokepoints, through which flows a fifth of the world's oil, Iran has now established a framework for transit pricing. Combined with the accelerating shift toward yuan-denominated energy trade, what we are witnessing is not merely a ceasefire but a structural reconfiguration of global energy economics. The dollar's long dominance over oil markets has taken another body blow. Iran answered Trump's threat of civilisational obliteration not with surrender but with negotiating conditions that reshaped the strategic landscape. India has reason to breathe more easily now. The conflict was devastating for Indian interests, threatening energy supply chains, imperilling LPG and CNG imports, exposing vulnerabilities in fertiliser and pharmaceutical inputs, and placing the Chabahar port project and India's entire INSTC investment in jeopardy. The ceasefire gives India space. But space to do what? The Modi government squandered its strategic position before and during the conflict, and there is little evidence that it has the capacity for honest introspection now. India was not at the negotiating table. It was not even in the antechamber. As BRICS chair this year, India had a historic opportunity to articulate the voice of the Global South, to insist on a ceasefire, to refuse the binary of alignment with Western military adventurism. Instead, it chose silence. That silence, calculated, cowardly, and consequential, has betrayed the very architecture of BRICS and the non-aligned tradition that gave India its distinctive global voice for seven decades. External affairs minister S. Jaishankar once asked, in a moment of public candour widely celebrated by his admirers: how can India fight a power like China? It was presented as strategic

realism. But contrast it with what Iran's Foreign Minister said as American bombers circled his country's skies: let them come, we will teach them. One statement diminishes a nation; the other, dignifies one. Jaishankar also once dismissed Pakistan's role in regional diplomacy as that of a dalal, a broker, a middleman, with all the contempt that word carries. Today, that dalal has brokered a ceasefire between nuclear-armed America and a defiant Iran. Words, in diplomacy, have a way of returning. The increased influence of Pakistan, however temporary it may prove, must be a cause of serious concern for India. Pakistan's diplomatic rehabilitation, earned by playing an indispensable role in a global crisis, will have consequences on the margins of every international forum where India seeks to press its case on cross-border terrorism, on Jammu and Kashmir, on the legitimacy of military responses to provocations. The ground that India has lost is not merely rhetorical. It translates directly into reduced leverage, reduced credibility, and reduced room to manoeuvre. And then there is the matter of the relationship with Washington. Donald Trump has humiliated India in ways that would have drawn a sharp public response from any government with a spine. He forced an asymmetric and deeply unfair trade framework on India, extracting concessions under threat of tariffs while India's negotiators smiled for photographs. He sent back Indian nationals, shackled and chained in military aircraft, a deliberate act of degradation that no self-respecting nation should have absorbed in silence. He took credit for halting India's own military operation. And through it all, the government that wraps itself in nationalist rhetoric offered not a syllable of public protest.

Ahead Of Bengal Polls, Decoding The Bhadrakol's Views On SIR

In Kolkata's social vocabulary, a particular group has long held a special place - the 'bhadrakol', or what is often referred to as the 'mahyabitta' (middle-class). In English-language discourse, this social class was once described as the "middle class", and the term later evolved into the "educated middle class", sometimes simply called the "middle class". During the colonial period, British officials, who first encountered this social group, referred to them as "educated natives." Like most modern social classes, however, the boundaries of the bhadrakol community are difficult to define precisely. In West Bengal, and particularly in Kolkata, the bhadrakol have historically played a central role in shaping public opinion. In earlier decades, the Congress party enjoyed considerable support among Kolkata's urban middle class, while rural Bengal leaned more towards the Left parties. Later, during the final phase of Left rule, Buddhadeb Bhattacharjee maintained significant support among urban educated voters, while Mamata Banerjee emerged as the political favourite in rural Bengal. Eventually, Banerjee managed to expand her influence across both demographics. However, in the 2026 Assembly election, a different pattern appears to be emerging in parts of urban Kolkata. In some areas, there is visible anti-incumbency after nearly fifteen years of Banerjee's government. Among sections of the bhadrakol, too, a certain level of dissatisfaction has become evident. Their concerns revolve around several issues that have dominated political debates in the state, including the education recruitment scam, allegations of corruption in political campaigns, and the activities of the so-called



"syndicate" networks involved in construction and local contracting. For many members of the Bengali bhadrakol community, these controversies have created a sense of disillusionment with the present administration. The Special Intensive Revision (SIR) of the voter list has added another layer of controversy. Some argue that the deletions disproportionately affect slum residents or minority communities in Kolkata, while others suggest that the exercise targeted illegal infiltrators, including Bangladeshis living in railway colonies or old refugee settlements. Differing Opinions Renowned filmmaker Arindam Sil said, "We are not against SIR, but we are worried about the abrupt huge deletion. Bengali cultural degradation is a wrong perception because there are good films Bengalis are still creating. Tagore's songs, dance and book fairs - all are still happening. But deleted voters can't get hearings from tribunals. This is unthinkable." Painter and renowned artist Samir Aich disagreed. "After the RG Kar and Sandeshkhali incidents, Bengali culture has completely eroded. I do not subscribe to any particular party but, as a creative per-

son, I think Bengal has lost its cultural glory in the past 15 years. Vote bank politics should be stopped. The SIR idea is good," he said. Retired police officer Nazrul Islam also said implementing the SIR was a good decision and that the Trinamool Congress government in the state had "destroyed" the state's development model. Banerjee and the Trinamool have argued that many genuine voters have been removed from the list and that the deletions do not affect only minority communities, but also a significant number of Hindu voters. There have been several reported instances where academicians, teachers, professors, college students, and government employees discovered that their names were missing from the voter lists. For many people, the process of correcting the records and re-entering their names has proven to be complicated. The SIR verification procedure requires filling out multiple forms and appearing for inquiries, which many citizens have found difficult and stressful. The BJP has tried to counter these criticisms by arguing that voter list revisions have taken place in several other states as well, including Kerala, Assam and Tamil Nadu, without similar politi-

cal turmoil. The party says the protests in West Bengal are largely incited by the Trinamool. Banerjee, however, has argued that there is a political conspiracy behind the process, claiming that it is being used as a method to remove voters sympathetic to her party. In her campaign speeches, she accused the Election Commission of functioning as a political instrument of the BJP, an accusation that the saffron party has denied. Voices Raised As a result, two parallel currents are now visible in Kolkata's public discourse. On the one hand, there is genuine discontent among sections of the bhadrakol community regarding governance issues. Many of these voices regularly appear in television debates and discussions across social media platforms. Among sections of the Bengali middle class, criticism of the government has been growing. However, the SIR controversy has also caused discomfort among several independent intellectuals and professionals who do not align with the Trinamool Congress. For example, Dr Kunal Sarkar, a well-known cardiologist, and Professor Sukanta Chowdhury, emeritus professor of Jadavpur University.

Siddaramaiah does not stand for social justice," says H.D. Deve Gowda

CM absent from rally held to support a Muslim candidate: HDD

Bengaluru : Former Prime Minister H.D. Deve Gowda slammed Chief Minister Siddaramaiah, alleging that the latter does not genuinely uphold the principles of social justice. Addressing the Greater Bengaluru JDS convention, he remarked that the Chief Minister invokes the rhetoric of social justice primarily for political expediency. He further stated that Siddaramaiah must introspect and question his own commitment to these ideals, accusing him of using the concept selectively for political gain.

Recalling past political developments, Deve Gowda noted that certain AHINDA leaders had played a role in the fall of Kumaraswamy's government and had also attempted to weaken the JDS. In response to such circumstances, he said, the decision to align with the BJP was taken with his approval. He added that Shri H.D. Kumaraswamy is presently discharging his responsibilities effectively as a Union Minister, but alleged that the State Government has not been cooperative, citing issues related to Kudremukh and HMT. He emphasised that matters concerning the State's interest should not be politicised and affirmed that Kumaraswamy continues his work with resolve.

He also highlighted the strength of the NDA alliance in Bihar, noting that Prime Minister Narendra Modi has reinforced the leadership of Shri Nitish



Kumar, fostering governance based on trust and stability. In contrast, he remarked that the conduct of the Congress towards JDS had eroded trust, compelling the party to join the NDA alliance.

Referring to the 'Daridra Narayana' rally, Deve Gowda criticised the Chief Minister for his absence at a crucial event organised to support a Muslim candidate, stating that such actions raise serious questions about his commitment to social justice. He pointed out that Siddaramaiah arrived only towards the conclusion of the programme, which, he argued, reflected a lack of seriousness on the issue. In a strongly worded observation, Deve Gowda described the present State Government as the worst he has witnessed in his six decades of political life. He asserted that public dissatisfaction is growing and that people are awaiting an opportunity to deliver a fitting response. He further stated that the JDS is fully prepared for the forthcom-

ing elections, having already appointed coordinators across five divisions across the city, and expressed confidence in the party's organisational strength.

Highlighting JDS's contributions, he underscored that the party had championed women's reservation, recalling that he had personally initiated discussions in Parliament during his tenure as Prime Minister. He noted that while the proposal did not materialise at the time, it has now been realised under Prime Minister Narendra Modi's leadership. He also welcomed the decision to convene a special session of Parliament to deliberate further on women's reservation. Concluding his address, the 93-year-old veteran leader reaffirmed his commitment to strengthening the party, stating that he remains ready to travel across the State to mobilise leaders and workers. He called for unity within the party and expressed confidence that collective efforts would further strengthen its prospects in the State.

KARKALA: UNTIMELY RAINS BOOST MUNDLI RESERVOIR, EASE SUMMER WATER WORRIES

Karkala, Apr 10: Even as the intensity of heat continues to rise day by day along the coastal belt, untimely rains occurring two to three times a week in the foothills of the Western Ghats have come as a boon for Karkala.

The rains have significantly increased the water level in the Mundli reservoir, bringing relief to residents of the town who were otherwise apprehensive about a summer water crisis this year. Mundli reservoir, a key source of water supply within the municipal limits, is now filled due to the recent rainfall. With sufficient storage available,



excess water is being released. The reservoir, which has a storage capacity of 3 MLD, is being used to pump water round-the-clock to the Ramasamudra sump. From there, water is supplied to various wards in the town as well as to the Bandimath tanks.

In hilly areas with rocky terrain such as

Banglegudde, Sadbhavanagar and Parneeru, public wells have already dried up. Residents in these localities depend solely on the water supplied from the Bandimath tank. However, with the Mundli reservoir now replenished, drinking water concerns in these regions have eased.

Kundapur: Woman killed after tipper lorry rams scooter at Bijadi



Kundapur, Apr 11: In a tragic incident, a woman lost her life after a tipper lorry, which was proceeding from Udipi towards Kundapur, rammed into a scooter from behind at the Bijadi divider on Friday. The deceased has been identified as Sharada (55), wife of late Manjunath Achari, a resident of Neerukodlu in Vaddarse. According to details, Sharada was on her way to her sister's house at Ankada

Katta in Koteswar. At the time of the accident, the scooter was being ridden by her son. Due to the severity of the impact, the woman died on the spot, while her son, who was riding the scooter, fortunately escaped without any life-threatening injuries. On receiving information, Kundapur police visited the spot, registered a case, and have taken up further investigation.

Bangalore : As the world observes World Parkinson's Day, leading neurologists, neurosurgeons and patient advocacy groups are calling for urgent action to improve awareness, early diagnosis, and access to treatment for Parkinson's disease a progressive neurological disorder affecting over 10 million people globally and among the fastest-growing neurological conditions worldwide. Despite its significant and rising burden, Parkinson's disease continues to be widely misunderstood, underdiagnosed, and inadequately treated.

Parkinson's disease is a chronic, degenerative disorder of the central nervous system caused by the gradual loss of dopamine-producing neurons in the brain, leading to impaired movement and coordination. While the exact cause remains unknown, experts believe it results from a combination of genetic and environmental factors. While medications remain the initial line of treatment, many patients experience reduced effectiveness over time, along with fluctuations in symptom control. Advanced therapies such as Deep Brain Stimulation (DBS) have transformed the treatment landscape, offering significant improvement in motor symptoms like tremors, stiffness, and movement difficulties. With ongoing advancements, adaptive DBS systems are further enhancing treatment precision by automatically adjusting stimulation based on a patient's activity and brain signals. Patients with advanced Parkinson's disease should not lose hope, as these therapies can help restore independence and improve daily functioning. Early consultation with a neurologist and neurosurgeon along with timely evaluation for advanced therapies can make a meaningful difference in quality of life," said Dr. Raghuram Gopalakrishnan, Director & Senior Consultant, Head of Stereotactic and Functional Neurosurgery, KIMS Hospital.

Both leaders were initially booked on the same IndiGo passenger flight departing from Chennai to Tiruchy at 12.40 pm. This led to heightened activity at the Chennai airport, as security officials weighed potential concerns amid the



heightened political tensions. In recent days, both leaders have traded sharp remarks against each other on the campaign trail. Officials were apprehensive that the two travelling together on the same flight could lead to an uncomfortable situation. In this backdrop, Udhayanidhi Stalin cancelled his booking on the

IndiGo flight around 10 am and arranged to travel separately by a chartered aircraft. He is scheduled to depart from the old Chennai airport terminal at 2 pm and reach Tiruchy at 2.45 pm. Edappadi K Palaniswami will proceed as planned on the IndiGo flight, departing Chennai at 12.40 pm and arriving in Tiruchy at 1.30

pm. ECI transfers Home Secretary Dheeraj Kumar; K Manivasan appointed. The change in travel plans brought relief to officials, who said the revised arrangements would prevent potential tensions at both the Chennai and Tiruchy airports, including during reception events organised by party workers.

Consumers Beware! Why you should never leave a child alone in a car

Leaving a child alone in a car is fraught with danger. If the car is locked with all the windows closed, the child runs the risk of suffering severe heat stroke, as cars heat up very quickly and children are extremely susceptible to heat. If you keep the engine idling, with the key in the ignition and the air-conditioner running, your child can get kidnapped, or your car may get stolen, along with the child. A couple in Kerala learnt this the hard way when their car got stolen, along with their toddler in the backseat, in January this year. On their way to a relative's house in Kozhikode, the couple stopped at a bakery. Their child was sleeping at the back, so they left the car engine idling to keep the air-conditioning on and stepped out to buy a few items. To their horror, their car was stolen, along with the child at the back! Fortunately for them, it all ended on a happy note — the thief was caught and the child, abandoned after two hours on the roadside, was picked up safe and sound!

There was an almost identical incident in Delhi last June. Here, the couple left their two kids — an 11-year-old girl and her three-year-old brother — in the car, with the AC running, while they went into a confectionery shop in East Delhi. When they returned, they found their car stolen, along with the children. After a three-hour police chase involving 20 police vehicles, the culprits abandoned the vehicle and the children too.

One may find it hard to believe, but there are innumerable instances of parents, and in some cases a grandparent, leaving behind a sleeping child in the car by mistake. There are also cases of parents leaving a child behind in the car while going on a short errand, believing the car to be a safe place. With the windows up and the car locked, the temperature inside the car goes up so quickly that a child is unable to withstand it. In May last year, a couple from Kota district, Rajasthan, lost their three-year-old daughter to vehicular hyperthermia. The parents were going to a wedding with their two daughters and when the father stopped the car in front of the venue, his wife and the elder



daughter exited. The father presumed that all three had left and so parked and locked the car and went in, leaving the sleeping child behind. By the time they realised that three-year-old Gorvika was missing and went to get her, it was too late.

In another tragic incident on October 30, three-year-old Vartika became a victim of heat stroke in a locked car in Meerut. In this case, it was not her parents, but a colleague of her father who took her for a ride in the car and then left her in the parked car, planning to return shortly. The heat inside the car killed the child. There are several websites that help you calculate the temperature inside a car at different ambient temperatures. When the outside temperature is 30°C, for example, the temperature inside a car goes up to almost 50°C (48.89 °C, to be precise) in just 30 minutes! In 15 minutes, it hovers over 43°C. Eighty per cent of the temperature rise, it is estimated, occurs within the first half an hour. A study published in March 2009 in the International Journal of Meteorology reveals that even on cloudy days with lower ambient air temperatures, the temperatures inside a car can reach dan-

gerous levels.

The National Highway Traffic Safety Administration in the United States says that a child's body temperature rises three to five times faster than an adult's and heat stroke occurs when the body temperature reaches 104°F (40°C). A child can die when it reaches 107°F (41.6°C).

Cars seem to hold a special attraction for children when it comes to playtime and that's how many of them enter the vehicle and get trapped when the doors automatically get locked. In Kochi, Kerala, two-year-old Rithick got inside his father's car parked in front of the house and locked himself up by pressing the lock button on the key. The parents did not have the spare key and eventually had to call the Fire and Rescue Services to get the child out — the entire process took 45 minutes early in the morning and the child was traumatised inside. There was a similar incident in Thiruvananthapuram, Kerala, in July. Here, the parents were lucky but there are many unfortunate cases where the children are found too late.

In November, four siblings, aged 2-7 years, died in a car in Radadiya

village in Gujarat's Amreli district. The parents had gone to work on a farm and the children got into the car of the farm owner and were unable to get out when the doors automatically locked. By the time they were found, all had succumbed to heat stroke. Earlier, in May, a three-year-old girl in Bhadradi Kothagudem district in Telangana met the same fate when she accidentally got locked inside a car parked in front of her house. The same month, six-year-old Kaunen and his four-year-old cousin Abdullah, playing in the compound of their house in Raebareilly district in Uttar Pradesh, got into a parked SUV and got locked. Heat stroke claimed their lives.

A month prior to that, two children reported missing by their parents in Central Mumbai were found dead in an abandoned car parked in Antop Hill. So, never leave a child alone in a car, even for a short time, and if you are the forgetful type, keep a paper reminding you of the child at the back, pasted on the windshield! Make sure that any child that enters a car exits safely. Always keep your car locked and store the key in a place where children cannot access it.

Food Talk: Pistachio in the Indian imagination

More than three decades back, I was busy researching Indian aphrodisiac recipes. My good friend, a peerless food impresario, sprang a surprise when he disclosed that he was in possession of the heirloom recipe from the rural kitchens of Patiala — Pistiyanda salan. He had been 'gifted' this recipe by a food-loving scion of the princely family. When we got heritage chef Mohammad Farooq to cook it for us, it turned out to be exquisite. It was creamy chicken curry with the gravy having hardly a hint of the emerald tint. It tasted rich and had, perhaps, served the patrons in urgent need of tonic restorative food well. Chef Farooq's exertions made us realise that, to mix metaphors, this was not everyone's 'cup of tea'. Years passed by, and we had almost forgotten about the magical properties of the pistachio when we suddenly encountered the recipe of 'pista gosht' in Chef Nishant Choubey's forthcoming cookbook, 'Stay With the Indus'. This time, the nut was favouring not the murg, but a mutton chop.

Pista has always occupied the top spot in Indian imagination. Above cashewnuts, walnuts, and even almonds. Imported from Afghanistan, it had great scarcity value. Thin slivers were used to garnish phirni, kulfi and burfi. This was before liberalisation of imports that made access to all kinds of nuts easy.

Memory is still green of the 'pista ki launjee' that was crafted with unalloyed pista. It is seldom seen at the desi sweetshop counters these days, though, at times, served

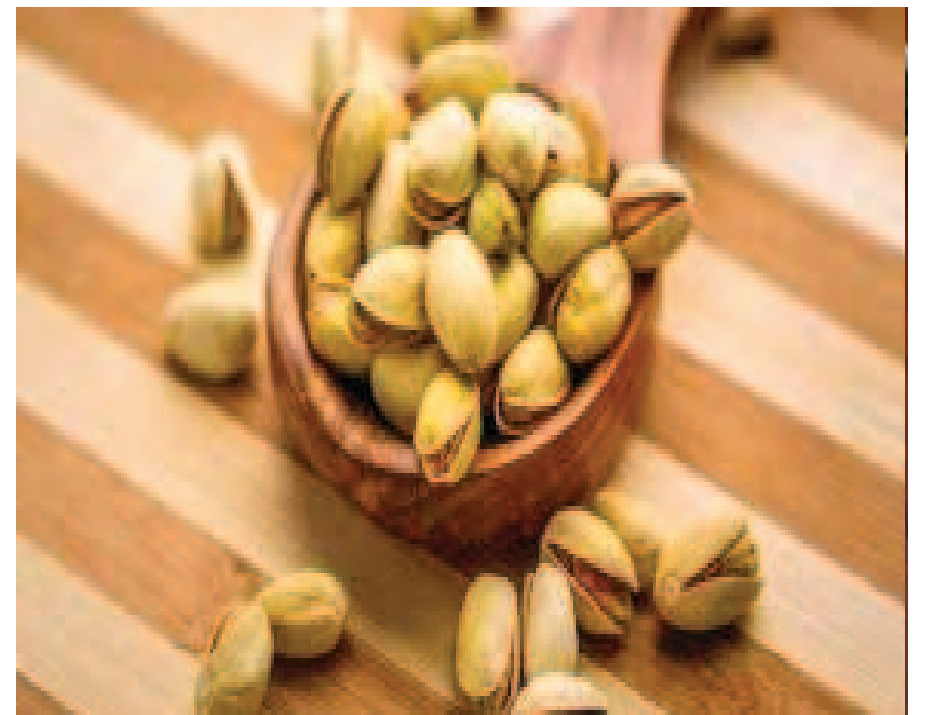
in lieu of pralines and petit-fours.

We are glad that pistachios are enjoying a well-deserved revival. Chef Parvinder Bali, who directs the School of European Pastry and Culinary Arts in Gurugram, treated us to an absolutely out-of-this-world 'pista gelato' when we visited his pastry studio — that in itself is a work of art. Chef Bali informed us that the best pistachios are imported from Turkey, and this is what Chef Nishant seconds. 'Pista-crusted mutton chops' do not claim any aphrodisiac properties but would have easily found a place in any princely dastarkhwan — Awadhi, Patialashahi or Hyderabad. Try it out before the weather changes, and you start worrying about its garam taseer! Prepare a crust for lamb chops by mixing chopped pistachios, jalapenos, chopped capers, green olives, parsley and breadcrumbs.

Marinate lamb chops with salt, pepper, olive oil, minced garlic, minced ginger, turmeric powder and garam masala for at least two hours. Cook these in a pre-heated oven at 220°C for 10-12 minutes, and let these rest.

Meanwhile, roast the pumpkin at 180°C for 10 minutes with some chopped garlic, turmeric powder and olive oil. Take it out of the oven. Mash it well. Spice it up with cumin powder, red chilli powder and cilantro. Take a separate pan and cook the prunes in red wine vinegar and sugar on low flame for 3-4 minutes, stirring continuously.

Spread the crust on a flat tray and place the chops in it, turning once or twice to coat evenly. Serve with warm mash and cooked prunes.



Iran Says US Agreed To Release Frozen Assets In Qatar, Foreign Banks, Official Denies

Iran on Saturday reportedly claimed that the United States agreed to release frozen Iranian assets held in Qatar and other countries. However, Washington moved quickly to push back as a senior US official denied the report, saying, "False. The meetings have not even started yet." The denial came after a senior Iranian source told Reuters that Washington had agreed to release Iranian frozen assets held in Qatar and other foreign banks, welcoming the purported move as a sign of "seriousness" in reaching a deal. The source said it was one of Iran's demands "in messages conveyed to the US side" and that Tehran had received a US agreement to release the assets. A second Iranian source put a figure on it, saying the US had agreed to release \$6 billion of frozen funds held in Qatar. ALSO READ: Islamabad Hosts US-Iran Talks: Where, When And What To Expect — Check Key Leaders Attending Iran's Parliament Speaker Mohammad Bagher Ghalibaf had publicly warned as recently as Friday that talks could not begin unless Washington releases the blocked funds and Israel halted its strikes in Lebanon. Ghalibaf said the two measures had been



"mutually agreed upon between the parties" but had "yet to be implemented." The frozen assets question has a long and tangled history. The most recent significant transfer came in September 2023, when around \$6 billion in Iranian oil revenues frozen in South Korean banks since 2019 were moved to restricted accounts in Qatar under a US sanctions waiver, tied to a prisoner exchange. Iran could access the funds only for humanitarian purchases, food, medicine, under strict US oversight. Those funds were subsequently blocked again after the Hamas-led attacks of October 7, 2023, due to Iran's links to the

group. The exact total value of Iran's frozen assets abroad is unclear, but several estimates place the figure above \$100 billion. Before the war, Iran was already in acute economic distress, with year-on-year inflation running at over 68 percent, the highest since World War II, making the release of frozen funds a central demand in any settlement. The final agreement being negotiated is expected to include Iranian commitments not to pursue nuclear weapons in exchange for sanctions relief and the return of frozen assets, Reuters reported. Iran's broader 10-point proposal, which forms the basis of the current negotiations,

includes lifting all sanctions, the release of frozen assets abroad, and full payment of Iran's war-related damages. Washington has not publicly confirmed the scope of any asset release. US President Donald Trump confirmed on Saturday that peace talks between the United States and Iran had officially begun in Islamabad. However, Trump called Iran a 'failing nation' and expressing deep uncertainty about the outcome of the negotiations. In a phone call with Trump, White House Correspondent Kellie Meyer asked Trump about his Truth Social post touting US oil and gas supplies, Trump said the movement of tankers toward

American shores was not a consequence of Iran keeping the Strait of Hormuz shut. "Take a look out of the great seas of our world — many of them heading to the United States to load up with oil, we have plenty of it," he said. The Strait, he added, would reopen "in the not too distant future." When asked whether Trump believed Iran was acting in good faith, he was non-committal. "I'll let you know that in a very short period of time, won't take long," he said. When pressed on how talks were going, Trump said he had "no idea." Asked if he was hopeful, the president shrugged off the question in characteristic fashion: "Whatever, otherwise we'll reset. We're ready to go." Meanwhile, Trump earlier stated that a large empty oil tankers were on their way to the United States to load up with American oil and gas. "Massive numbers of completely empty oil tankers, some of the largest anywhere in the World, are heading, right now, to the United States to load up with the best and 'sweetest' oil (and gas) anywhere in the World," Trump wrote. "We have more oil than the next two largest oil economies combined — and higher quality."

RBL BANK CALLS FOR SHAREHOLDER VOTE ON EMIRATES NBD DEAL

RBL Bank Ltd. on Saturday said that it has called an extraordinary general meeting on May 4 to seek shareholder approval for changes linked to Emirates NBD Bank's planned investment, including revised board nomination rights and amendments to the bank's articles of association. Emirates NBD is set to subscribe to new RBL Bank shares at Rs 280 per equity share under the preferential allotment announced earlier. The proposed issue covers up to 95.91 crore fully paid-up equity shares, or a lower number equal to 60% of the post-issue equity capital, subject to adjustments under the investment agreement. The bank said its board approved an amendment agreement on April 11 to align the original October 2025 investment pact with conditions set out in the Reserve Bank of India's approval. The central bank had cleared Emirates NBD to acquire up to 74% of RBL Bank's paid-up share capital through a letter dated April



1. The transaction is set to become one of the most significant foreign investments in an Indian private lender and would give Emirates NBD management control of RBL Bank once completed. India permits foreign investment of up to 74% in private banks, though larger holdings by a single foreign institution require regulatory approval. NDTV Profit had reported on April 2 that the RBI had approved the proposed acquisition of majority shareholding in RBL Bank by Emirates NBD, following earlier clearance from the Competition Commission of India. The deal is expected to close in the first quarter of FY27,

subject to remaining approvals and customary conditions. Deal Terms Under the deal structure, if Emirates NBD holds more than 50% of the bank, it can nominate all non-independent directors, including executive directors, subject to applicable law. That right reduces as shareholding falls. If its stake is 50% or below but at least 30%, it may nominate up to three non-executive directors. ACCOUNTABILITY BY DESIGN: REGULATORY CHALLENGES IN INFRASTRUCTURE SECTORS

The panel on "Accountability by Design: Shaping AI Regulations, Platforms, and Critical Digital Infrastructure" at the recent 7th Digital Citizen Summit (DCS) 2025, hosted by Digital Empowerment Foundation (DEF) in partnership with Centre for Development Policy and Practice (CDPP), highlighted that accountability must be built into artificial intelligence (AI) systems from the earliest stages of design. As AI becomes central to India's critical infrastructure, discussions across sectors point to the same conclusion, ie, responsibility cannot be retrofitted. From automobiles to algorithms, the conversation repeatedly drew on the automobile sector, which gradually built a shared framework of responsibility, manufacturers meeting safety norms, owners ensuring vehicles, drivers following licensed rules, governments designing road systems and even pedestrians playing their part. This evolution showed



how accountability works only when it is structurally designed into the system. Speakers also cautioned that automobile design often prioritised user convenience over broader societal interests, offering a lesson for AI. This is why privacy by design and privacy by default must be foundational. The discussion highlighted how choices made at the model-design stage, such as adopting open-weighted or closed-weighted systems, directly shape transparency, customisation and oversight. These early deci-

sions ultimately determine how responsibility is tracked and enforced throughout an AI system's life cycle. AI introduces risks that do not align neatly with traditional data categories. Beyond data at rest and in transit, AI involves "data during computation," which requires new forms of protection. Privacy-enhancing technologies, such as federated learning, differential privacy, homomorphic encryption and secure multi-party computation, were highlighted as tools that integrate privacy into system operation.

US-Iran peace talks begin in Islamabad through Pakistani mediators

According to the United Nations, around a third of the world's fertilisers - such as urea, potash, ammonia and phosphates - normally pass through the Strait of Hormuz. Data from the World Trade Organization, shows that, since the conflict began, out-bound shipments of fertiliser-related products through the waterway have collapsed. We're hearing that indirect talks between the US and Iran have started through Pakistani mediators. Even if indirect, this is a significant moment for Pakistan, and was hard to imagine in these six weeks of war, given how far apart the two sides stand on key issues and the deep mistrust. If this leads to face-to-face talks that would be a tangible and historic result for Pakistan as a mediator. What we're watching for is whether by the end of this process, these talks deliver an extended ceasefire, any form of agreement, or even a promise to keep talking. US



President Donald Trump says Iran is "LOSING BIG" in the conflict as talks in Islamabad kick off. In a lengthy Truth Social post, Trump claims members of the media "love saying that Iran is 'winning' when, in fact, everyone knows that they are LOSING and LOSING BIG". He then goes on to repeat assertions his administration has made during the conflict: "Their Navy is gone,

their Air Force is gone, their Anti Aircraft apparatus is nonexistent, Radar is dead, their Missile and Drone Factories have been largely obliterated along with the Missiles and Drones themselves and, most importantly, their longtime 'Leaders' are no longer with us, praise be to Allah!" After referring to Iran laying sea mines, he goes on to say the US is now starting "clearing out the Strait of

Hormuz as a favor to Countries all over the World". Sources have told the BBC that talks have now started between the US and Iran - but for the moment are still indirect through Pakistani mediators. We were taken through their multiple checkpoints and escorted by armed police into the centre of Islamabad's diplomatic area: the red zone. The convention centre is surrounded by billboards embla-

zoned with the US, Iranian and Pakistan flags and the words "Islamabad talks", the centre full of journalists who have travelled from around the world to cover them. Large screens fill the centre's auditorium broadcasting television stations from around the world covering the news from Islamabad. Rarely has Pakistan found itself at the heart of such significant international diplomacy. Across the road is the Serena Hotel where American Vice President JD Vance arrived shortly after noon after visiting the US embassy. It is here, along with special envoy Steve Witkoff and Jared Kushner, that he met with Pakistani Prime Minister Shehbaz Sharif, and the interior minister, Mohsin Naqvi. Sharif is said to have expressed his hope that these talks would serve as a stepping stone towards durable peace in the region. The Iranians also met the prime minister, although no

images of their meeting have been shared. Iran's network of regional allies and proxies - Hezbollah in Lebanon, the Houthis in Yemen, Hamas in Gaza and an assortment of militias in Iraq - has given Tehran regional clout, allowing Iran to exercise what is often called "forward defence" in its long-running disputes with Israel and the United States. Since the start of the Gaza war in October 2023, the network Iran calls the "Axis of Resistance" has been under constant attack. One part of it, the regime of the former Syrian dictator Bashar al-Assad, no longer exists. But Israel sees what it calls the "Axis of Evil" as representing an existential threat, which needs to be fully eradicated. At a time when the Iranian economy is buckling, many Iranians would also like to see their government spending less on foreign adventurism and more on making their lives easier.

FINAL PUSH FOR VOTES AS CHALLENGER TO HUNGARY'S ORBÁN SENSES VICTORY



On the eve of Hungary's bitterly fought and highly significant election, the two main rivals are taking their campaigns to the wire, as Péter Magyar attempts to end 16 years of continuous rule by Viktor Orbán's party Fidesz. "We're at the gates of a two-thirds majority victory," he told cheering supporters, before mingling for selfies. "Let's gear up and push for the last 100 metres!" His final campaign stop will be in the second city, Debrecen, in the north-east, while Orbán, who trails in most of the polls, will address a rally in Budapest. But perhaps the biggest rally of all came on Friday

night, when tens of thousands of Hungarians crammed the capital's Heroes' Square and surrounding streets for an anti-Fidesz concert. "I feel it in my bones something's going to change," said first-time voter Fanni, who came with her mother from a village two hours' drive away in the south. "I don't believe I'd vote for [Magyar] in an ideal situation, but this is our only chance." Orbán's biggest threat is that he is facing a cross-section of public anger, and it has been largely channelled into one single opposition movement, led by a former Fidesz insider who rebelled.

Artemis II mission was a triumph. Now comes the hard part



Nasa's Artemis II mission has successfully sent four astronauts sweeping around the far side of the Moon and landed them safely back home. The Orion spacecraft performed admirably and the images the astronauts captured have delighted a whole new generation about the possibilities of space travel. But does this mean that the children enthralled by the mission will be able to live and work on the Moon in their lifetimes? Perhaps even go to Mars, as the Artemis programme promises? It seems churlish to say, but looping the Moon was relatively easy. The really hard part lies ahead, so the answer is "maybe, maybe not". When Neil Armstrong and Buzz Aldrin became the first humans to land on the Moon in July 1969, many assumed it was only the beginning and that people would soon be living and working in space. That didn't happen because the Apollo programme was born not from a love of exploration, but from the Cold War, to demonstrate US superiority over the Soviet Union. That feat was achieved by Armstrong's

"one small step" off his lunar lander - job done. Just a few years after he planted the American flag on the lunar surface, the TV audience figures for subsequent missions plummeted and future Apollo missions were scrapped. This time, Nasa's stated ambition is different. Administrator Jared Isaacman has set out plans for one crewed lunar landing per year, beginning in 2028, with the fifth Artemis mission - planned for later that same year - marking the start of what the agency calls its Moon base. It sounds like science fiction, but here are the words of a serious space player dealing in science fact: "The Moon economy will develop," Josef Aschbacher, Director General of the European Space Agency (ESA), tells me. "It will take time to set up the various elements, but it will develop." But as the commander of Apollo 13 famously said when his spacecraft malfunctioned on the way to the Moon: "Houston, we've had a problem..." The lander problem To get boots on the lunar surface, Nasa needs a lander.

California governor candidate Eric Swalwell denies sexual assault allegations

Democratic Congressman Eric Swalwell, one of the leading candidates in the race to be California's next governor, has denied allegations of sexual misconduct from former staff. "These allegations are false and come on the eve of an election against the frontrunner for governor," he said in a statement after multiple women made allegations ranging from sexual harassment to rape. His opponents - and several supporters, including House Democratic Leader Hakeem Jeffries - have called on him to leave the race. Democrats will pick their candidate in a primary on 2 June. The winner, expected to become the next governor in the heavily Democratic state, will go on



to the 3 November general election. The first allegation against Swalwell emerged publicly on Friday in the San Francisco Chronicle. A former staff member told the newspaper that, shortly after being hired to work in his district office in Castro Valley, Swalwell began making inappropriate comments, including soliciting her for sex and sending her sexual messages.

Artemis crew home safely after completing historic mission to the Moon

The four astronauts who flew in Nasa's Artemis II mission around the Moon have splashed down safely in the Pacific Ocean after a flawless return. The crew are now safely aboard a waiting ship and recovering from a nine-day voyage that took them further from Earth than any humans in history. Their Orion spacecraft was travelling at more than 24,000mph (38,600km/h) when it hit the Earth's upper atmosphere and its heatshield was subjected to temperatures half as hot as found on the surface of the Sun. Their safe return clears the way for the next stage of the Artemis programme, which aims to land humans on the lunar surface and eventually build a permanent base



on the Moon. The extreme heat meant the capsule, which the astronauts named Integrity, lost contact with mission control in Houston for six minutes during the descent. There were cheers when Commander Reid Wiseman's voice was heard

the Nasa commentary enthused repeatedly, until the capsule hit the ocean for a perfect splashdown. "A perfect bull's eye splashdown for Integrity and its four astronauts," Nasa commentator Rob Navias said moments after the landing. The astronauts - Wiseman, pilot Victor Glover, mission specialist Christina Koch and Canadian astronaut Jeremy Hansen - were carefully extracted from the capsule and taken by helicopter to the USS John P. Murtha, where they will undergo medical evaluations. Nasa said they would be flown to Houston to be reunited with their families on Saturday. As they waited on the ship's deck they could be seen smiling and chatting while posing for photos.

'YOU ARE MY GOD', JAPAN'S PM TELLS BRITISH ROCK BAND DEEP PURPLE

The British rock band Deep Purple met a long-time super fan in Tokyo on Friday - who just happened to be the Japanese prime minister. "You are my god," Sanae Takaichi, a hard rock enthusiast, told the band's drummer Ian Paice, beaming as she handed him a pair of signed Japanese-made drumsticks. An avid drummer herself, Takaichi played in a Deep Purple tribute band as a girl after becoming a fan in primary school. "These days, when I fight with my husband I drum to Burn and cast a curse on him," the 65-year-old conservative leader told the musicians at her office in the Japanese capital, Tokyo, on



Friday. The band met Japan's first female prime minister as they returned to tour across the country where they recorded the 1972 live album Made in Japan - considered to be one of the greatest rock albums ever recorded. "I can't believe Deep Purple are here,"

Takaichi said, smiling as she greeted the musicians. "I have the deepest respect for the way you continue to make rock history while embracing new challenges and creating captivating music to this day," she said through an interpreter. The prime minister said she

hoped the tour would "thrill and excite fans all over Japan" and promote cultural exchange between the UK and Japan. The band wrote in a post on Instagram: "A lifelong fan of hard rock and heavy metal, Takaichi has often named Deep Purple as one of her favourite bands. "She even told the group she bought their Machine Head album back in grade school." Formed in England in 1968, Deep Purple became known as one of the "unholy trinity" of British heavy metal bands, alongside Black Sabbath and Led Zeppelin. Perhaps their most renowned hit - Smoke on the Water - came on their 1971 album Machine Head.

Djibouti's president wins unprecedented sixth term with 97.8% of vote



Djibouti's President Ismail Omar Guelleh has won an election with 97.8% of the vote, keeping him at the helm of the strategically-placed Horn of Africa nation for a sixth term, preliminary official results show. The 78-year-old's sole challenger Mohamed Farah Samatar got 2.19% of the vote, in a poll boycotted by most of the opposition. In power for 27 years, Guelleh had promised to step down, but ran for re-election after the constitution was amended in November to remove the upper age limit of 75 for presidential candidates. Guelleh's campaign focused on the fact that he had maintained stability in Djibouti at a time when other regional states, and the Middle East, had been hit by conflict. Lying on the Bab el-Mandeb Strait, Djibouti serves as a gateway to the Suez Canal, one of the world's busiest shipping routes. The US, China, France, Italy and Japan have military bases in the country. Guelleh is only Djibouti's

second president since it gained its independence from France in 1977. The leaders of the main opposition parties - including Dahir Ahmed Farah - have boycotted elections since 2016, saying there was no free political activity. Guelleh celebrated his victory at his home, saying it was a victory for the entire nation. Officials said that more than 80% of registered voters cast their ballots in Friday's election. Samatar, who was the flag-bearer of a small party with no parliamentary seats, has not yet commented. The results were released by the interior ministry but still need to be validated by judges on the constitutional council before Guelleh can be sworn in for another five-year term. He won the 2021 election by a similar margin. In 2010, Djibouti's parliament scrapped term limits, and shortened presidential mandates from six to five years. It also set 75 as the age limit for candidates, before changing the constitution in November so that Guelleh could run for office again.

Chimpanzees in Uganda locked in vicious 'civil war', say researchers

The world's largest known group of wild chimpanzees has split and been locked in a vicious "civil war" for the last eight years, according to researchers. It is not clear exactly why the once close-knit community of Ngoro chimpanzees at Uganda's Kibale National Park are at loggerheads, but since 2018 the scientists have recorded 24 killings, including 17 infants. "These were chimps that would hold hands," lead author Aaron Sandel said. "Now they're trying to kill each other." The study, published in the journal Science, says the intensity and duration of

the violence may inform how early human conflict developed. Sandel, an anthropologist from the University of Texas in the US, and co-director of the Ngoro Chimpanzee Project, says chimpanzees are "very territorial", and have "hostile interactions with those from other groups". "[It's] like a fear of strangers," he told the Science podcast. But over several decades, Sandel said the nearly 200 Ngoro chimpanzees had lived in harmony. There were divided into two sets - known to researchers as Western and Central - but they had existed overall as a cohesive group.



IPL 2026: Iyer's unbeaten 69 guides Punjab Kings to 6-wkt win over SRH

New Chandigarh (TSIT): Captain Shreyas Iyer remained unbeaten at 69 while Priyansh Arya and Prabhsimran Singh scored quick half-centuries as Punjab Kings (PBKS) chased down the target of 220 runs in just 18.5 overs against Sunrisers Hyderabad (SRH) in the 17th match of Indian Premier League (IPL) 2026 at the PCA New International Cricket Stadium in New Chandigarh on Saturday.

With this win, PBKS remain unbeaten this season. They now have seven points from four matches, with one game against Kolkata Knight Riders (KKR) abandoned due to rain. Chasing a big total, the Punjab Kings got off to a flying start. Openers Priyansh Arya and Prabhsimran Singh continued their good form and attacked the SRH bowlers right from the start. Priyansh took the lead early, playing aggressive shots all around the ground.

He scored 21 runs in the final over of the Power-play off Harshal Patel and reached his fifty in just 16 balls with back-to-back boundaries. This became the

second-fastest fifty for Punjab Kings, just behind KL Rahul's 14-ball half-century in 2018. Prabhsimran also played his part well, and PBKS reached 93/0 at the end of the Power-play.

SRH finally got a breakthrough in the seventh over when Shivang Kumar dismissed Priyansh Arya, who scored 57 off just 20 balls with five fours and five sixes. Shivang struck again in his next over, removing Prabhsimran Singh after he completed his fifty in 24 balls. He scored 51 runs, hitting four fours and four sixes. Despite these wickets, PBKS are in a strong position at 124/2 after 10 overs.

Shivang continued his good spell and picked up another wicket, dismissing Cooper Connolly with a wide delivery outside off stump. Captain Shreyas Iyer steadied the innings along with impact substitute Nehal Wadhwa. The pair rotates the strike well and punishes loose deliveries to keep the pressure on SRH.

Iyer then shifted gears after the 13th over and reached his fifty in 24 balls with a six off Eshan Malinga in the 16th over. He stayed unbeaten on 69, while Shashank Singh supported him with an unbeaten 16, as PBKS chased down the target with seven balls to spare and six wickets in hand.

For SRH, Shivang Kumar was the standout bowler, finishing with figures of 3/33 in four overs. Harsh Dubey chips in with one wicket.

Earlier in the match, Sunrisers Hyderabad

made a strong start after being put in to bat, with openers Abhishek Sharma and Travis Head attacking from the very beginning. Abhishek led the charge, scoring 20 runs in one over off Arshdeep Singh and reaching his fifty in just 18 balls with two consecutive sixes. Head also played aggressively, hitting three boundaries in an over, as SRH raced to 105/0 at the end of the powerplay.

Punjab Kings made a comeback in the ninth over when Shashank Singh dismissed Head for 38, ending the 120-run opening partnership. Just two balls later, Abhishek was also dismissed for a brilliant 78 off 28 balls, which included five fours and eight sixes.

After the quick wickets, Ishan Kishan and Heinrich Klaasen stabilised the innings by rotating the strike. However, Arshdeep Singh broke their partnership by dismissing Kishan for 27. SRH lost further momentum as Aniket Verma was run out due to a mix-up, and Salil Arora managed only 9 runs.

Samson's hundred and Mhatre's fifty guide CSK to 212/2 against DC



CHENNAI: Sanju Samson shed his indifferent start to IPL 2026 season with a blazing hundred and Ayush Mhatre offered another glimpse into the future with a fluent half-century as Chennai Super Kings posted a competitive 212 for two against Delhi Capitals here on Saturday. His unbeaten 115 off 56 balls (15x4, 4x6) was the cornerstone of Chennai's one of better outings with

the bat in this IPL. After being asked to bat first, the CSK man brought up his first substantial knock in a Yellow jersey, and was involved in an excellent stand with Mhatre for the second wicket - 113 runs in a little over 11 overs.

It was Samson's fourth IPL hundred, the first for CSK and the first in IPL 2026.

A big score from Samson

was essential for himself and CSK to restore the belief of 'Abu-den' faithfuls in their team, and he did that on the night with a brilliant innings in front of home fans.

It was the typical Samson innings. The Kerala batter had looked unsure of his feet and field placings in earlier matches this season, but on this instance a familiar Samson returned.

Babar Azam Gets Hit By Nasty Bouncer From Ubaid Shah In Pakistan Super League, Sits Down On Ground

Babar Azam is currently in action in the Pakistan Super League (PSL). Once Pakistan's all-format captain, Babar Azam has seen his stocks decline in recent times and is now on something of a comeback trail, particularly in T20 cricket. Recently, the star batter etched his name into the record books by becoming the fastest player to reach 12,000 runs in T20 cricket. He achieved this milestone during his 351st match in Karachi, playing for Peshawar Zalmi in the ongoing PSL against the Karachi Kings. Babar reached the landmark in just 338 innings. Currently captaining Peshawar Zalmi, Babar was struck by a nasty bouncer from Lahore Qalandars' Ubaid Shah. The delivery hit him on



the neck, forcing him to sit down on the ground immediately. Azam has established himself as one of the tournament's most consistent batters, with over 100 matches played, multiple 50-plus scores, and two centuries. He surpassed the previous record

held by former West Indies legend Chris Gayle, who had reached the mark in 343 innings and remains the highest run-scorer in T20s. India's star batter Virat Kohli sits third on the list, having taken 360 innings to achieve the feat. Babar needed just 13 runs dur-

ing the PSL clash between Peshawar Zalmi and the Karachi Kings to enter the 12,000-run club in T20 cricket, and he reached the milestone in the fourth over of Zalmi's innings. With this achievement, Babar became only the second Pakistani batter to cross the 12,000-run mark in T20s. The record for the most T20 runs by a Pakistani player is still held by veteran batter Shoaib Malik. Babar opened the innings for Peshawar Zalmi and remained unbeaten on 87 off 51 deliveries. He struck 10 fours and two sixes during his fluent knock and stitched a commanding 191-run partnership for the second wicket with Kusal Mendis, guiding Zalmi to an imposing total of 246/3 in their allotted 20 overs.

'More Bollywood Movie Than Actual Cricket': PSL Overseas Star Drops 'IPL' Bombshell

South Africa cricket team batter Rilee Rossouw, who is currently playing for Pakistan Super League (PSL) side Quetta Gladiators, made a stunning remark on the Indian Premier League (IPL). In a video that has surfaced on social media, he claimed that the PSL was more competitive than the IPL and added that the IPL is a long tournament with a lot of backing from Bollywood. As a result, he said that the tournament becomes "more of a movie" than "actual cricket." "The IPL is a very long tournament, and the PSL is a much more compact tournament where the competition is a lot more fierce. The IPL obviously has the whole Bollywood backing it,



so it's a lot more of a movie than actual cricket," he said. Earlier, the Pakistan Cricket Board's policy of allowing its employees to work with franchises in the Pakistan Super League has come under scrutiny after former captain Misbah ul Haq con-

ferred he was involved with Peshawar Zalmi as consultant. The PCB at the start of the PSL had stopped Sarfaraz Ahmed and Wahab Riaz from working with the Quetta Gladiators franchise. The board said under its policy former players who were

not allowed to work in the PSL in any capacity as it was a conflict of interest. But Misbah defended his involvement with Peshawar Zalmi despite being a paid national selector and batting consultant with the PCB. "I had signed a contract with Zalmi before I became national selector and I only work for them as consultant on given days in a season," Misbah told the media wearing the Peshawar Zalmi kit. Asked how he got permission from the PCB to work in the PSL when Sarfaraz who was with him on the selection committee and Wahab were stopped from working with Quetta Gladiators, Misbah said his case was different and the PCB can best explain this.

R Ashwin Coins Brand New Term To Describe Vaibhav Sooryavanshi's Huge Knock Against RCB

Former Indian cricket team spinner R Ashwin was left stunned by Rajasthan Royals young sensation Vaibhav Sooryavanshi's explosive batting against Royal Challengers Bengaluru in IPL 2026 on Friday. He took on the likes of Bhuvneshwar Kumar and Josh Hazlewood but was able to play his natural game during a competitive run chase. Such was the prowess shown by the youngster that Ashwin went on to coin a new term - 'Vaiball' - in order to describe the young batter's performance. "This is insane! This is Vaiball Suryanvanshi. Let's vibe with this fella," Ashwin posted on X (formerly Twitter). Former India all-rounder Irfan Pathan also took to social media to praise the young sensation. The video appears to show footage of Rodriguez training with a punch bag and sparring in front of a line of prison cells. The details of Rodriguez's arrest have not been disclosed and BBC Sport has asked Mexican legal authorities and the UFC for comment. "Eight months in a cage in Tijuana, Mexico never



killed my spirit. I did everything possible to stay on point and ready for my return to the UFC octagon," said Rodriguez. "Expect a hungrier, more focused version of myself. They tried to take it all away, now it's time for me to come back and show you all the monster that prison created. Thank you to my legal and man-

agement team, family and real friends to help me be a free man." Rodriguez - who is 14th in the UFC's welterweight rankings - has not fought since July last year, when he beat American Kevin Holland by unanimous decision. He made his debut in the UFC in 2020 and has won 10 of his 14 fights in the promotion.

He bounced back strongly to register a 10-21, 21-19, 21-17 win, turning the match around with sharp attacking play and control in the longer rallies. Taking to X, she wrote, "I have consistently maintained that he is a generational talent. In terms

of pure natural ability, he stands right up there with the very best young players I have come across. There is a prodigious level of talent in him, and it is something you immediately recognise when you see him on court. He has been training in my training group for the past three weeks along with coach Irwan, and this period has only reinforced my belief in his potential." Sindhu went on to say that he has a "strong presence on court" and that his height gives him an "excellent reach". Light & lean Fury happy to be 'young fresh hunter' again

Tyson Fury says he took his undefeated record "for granted" as the British heavyweight appeared lean and sharp before Saturday's bout with Arslanbek Makhmudov at Tottenham Hotspur Stadium. The 37-year-old - returning to the ring after two consecutive defeats to Oleksandr Usyk in 2024 - weighed in at 19st 2lb (122kg), three pounds heavier than his Russian opponent. Fury briefly retired after suffering the first losses of his career to Usyk in Saudi Arabia, but outlined his desire to become a three-time world champion.

"Whoever has the belts I want to get them back. I was undefeated for 17 years and took it for granted," he said at Friday's weigh-in in London. "I had two losses in a row and I'm not the hunted now but I'm the hunter. It feels great to be the young fresh hunter again. I want to make a statement, so I've come in nice and light and lean." Fury - who had the infamous 11-minute and 20-second stare down with Usyk before their second fight 16 months ago - shared just a short seven-second face-off with Makhmudov, before the 36-year-old left the stage. Fury was in the

same upbeat mood he has shown all week - making time for fans outside beforehand, laughing and joking with the media, and strolling out to Eminem's "Without Me" with the line "guess who's back?" blasting on the speakers. But the focus soon turned to the scales, with weight a talking point throughout the Morecambe fighter's career. He was a career-heaviest 20st 1lb (127kg) - although fully clothed - for his rematch with Usyk in December 2024, while during his hiatus from boxing between 2016 and 2018 he ballooned to around 28st

(178kg) amid personal struggles. Fury - who has spent his training camp in Pattaya, Thailand - weighed the same as he did for his last fight in the United Kingdom in December 2022 when he beat fellow Briton Derek Chisora. "It's a decent, comfortable, happy weight for Fury. A lot of people thought he'd come in heavier, but that's a good weight," said BBC Radio 5 Live boxing pundit Steve Bunce. "He looks like a man that has been training in the heat for an awful long time. He might have been 23 or 24 stone when he started training for this fight.
