INDIAN ARMY LAUNCHES FIRST BORDER COMMUNITY RADIO STATION IN SIKKIM

Gangtok, Apr 12: In a notable initiative aimed at strengthening communication in high-altitude border regions, the Indian Army has launched Sikkim's first border village community radio station, 88.4 FM Radio Sikkim Sundari, in eastern Sikkim. The station has been set up under the Trishakti Corps and is designed to address the long-standing information gap in remote villages that often face harsh weather conditions and limited access to mobile and internet connectivity. The initiative aims to ensure that residents in isolated border areas receive timely and reliable information. The community radio will broadcast local news, weather updates, government welfare schemes, and public service messages, helping residents stay informed and better connected with administrative services. Beyond information delivery, the station will also focus on preserving and promoting the region's cultural identity. Programs featuring local traditions, folk music, and community discussions will be aired, giving indigenous voices a dedicated platform and encouraging cultural engagement.

163 MINOR BOYS RESCUED FROM TRAFFICKING ATTEMPT ON TRAIN IN MADHYA PRADESH

Katni, Apr 12: In a major anti-trafficking operation, as many as 163 minor boys were rescued from an express train in Madhya Pradesh's Katni district, officials said on Sunday. The children, aged between six and 13 years, were allegedly being trafficked from Bihar to Maharashtra for labour work. Acting on a tip-off from the Child Welfare Committee (CWC), personnel of the Railway Protection Force (RPF) and Government Railway Police (GRP) intercepted the group on Saturday night. During the joint overnight operation, eight persons accompanying the children were detained onboard the Patna-Purna Express at Katni railway station. Officials found that the accused were travelling without proper tickets and valid documents, raising suspicion.

Uttam orders fast-track rehabilitation of Kaleshwaram barrages

Hyderabad TSIT: Telangana Irrigation Minister N.Uttam Kumar Reddy has directed officials to expedite the rehabilitation of the three key barrages of the Kaleshwaram Lift Irrigation Project Medigadda, Annaram and Sundilla and make them operational at the earliest.

At a high-level review meeting held at the Secretariat, the Minister stressed that the repair works must be completed under a strict time-bound programme. He said the next two working seasons would be crucial and expressed confidence that Annaram and Sundilla barrages could be fully restored within the timeline, while Medigadda could be made partially operational.

He noted that agencies like



the National Dam Safety Authority and Vigilance Commission had flagged serious defects in the barrages, including issues related to design, foundations, and execution. The government has

appointed AFRY India in partnership with IIT Mumbai to prepare fresh designs. The Minister directed the consultants to work round-the-clock and complete designs at the earliest for approval from the Central

Water Commission. He also instructed that all required geotechnical and hydraulic studies be taken up on priority. A high-powered Steering Committee has been constituted with Col. Parikshit Mehra as convener to oversee the rehabilitation works. The committee will review progress regularly, while daily monitoring will also be carried out.

Executing agencies, including L&T, have been asked to immediately mobilise resources, reactivate camps, and ensure smooth execution of works without delays. Minister reiterated that the government is committed to restoring the Kaleshwaram project to full functionality at the earliest.

Asha Bhosle passes away at 93

last rites to be held on Monday at Shivaji Park

Mumbai (TSIT): Legendary playback singer Asha Bhosle passed away at the age of 93 in Mumbai on Sunday. The singer was admitted to the Breach Candy Hospital on Saturday. Ashish Shelar, the Culture Minister of Maharashtra made the announcement outside the hospital. Her last rites will be held at Shivaji Park on Monday at 4:00 pm. On Saturday, her granddaughter, Zana Bhosle had revealed that her grandmother was admitted to the hospital due to extreme exhaustion and a chest infection.

She requested privacy during such times. Dropping a photo with Asha Bhosle on her official Instagram handle, Zana wrote, "My grandmoth-



er, Asha Bhosle due to extreme exhaustion and suffering a chest infection has been admitted to hospital and we request you to value our privacy. Treatment is ongoing and hopefully everything will be well and we shall update you positively (sic). (Folded hands emoji)."

Many people will lose shelter in Bengal if BJP comes to power: Mamata

Kolkata (TSIT): West Bengal Chief Minister Mamata Banerjee said on Sunday that several people will lose their shelters if the Bharatiya Janata Party (BJP) comes to power in the state after the elections this month. "In the coming days, there will be no address, no shelter and no family. BJP will take away everything," the Chief Minister said while addressing a campaign rally at Khandagosh in East Burdwan district while addressing a campaign rally there amid the crucial two-phase Assembly elections in the state on April 23 and April 29. Speaking on the occasion,



she also targeted the Prime Minister, without directly naming him, over his promise at a campaign on Saturday that if the BJP comes to power in West Bengal, the state government employees would be granted pay as per the 7th Pay Commission.

"They are liars. They are

promising to grant pay as per the 7th Pay Commission. He should have enquired first and given respect to his chair. We have already announced the 7th Pay Commission in our state budget in February this year. West Bengal is the only state where the state government employees get a pension. This facility is not available in any other state," the Chief Minister said.

Without directly naming the Prime Minister, she also said that he made a vague promise that popular food products and sweets from West Bengal would be exported worldwide if the BJP comes to power in West Bengal.

Convene all-party meeting to discuss delimitation after April 29: Kharge to Modi

NEW DELHI (TSIT): Congress president Mallikarjun Kharge has conveyed to Prime Minister Narendra Modi that it would be "impossible" to have any useful discussion on the women's quota law without details of delimitation and other aspects, and demanded that an all-party meeting be called on the matter after the current round of state polls are over on April 29.

In his letter to PM Modi, Kharge said that calling Parliament's special sitting amid state polls reinforces the belief that the government is hurrying the implementation of women's reservation law for "political mileage". Kharge reiterated the demand that an all-party meeting



be called to discuss the delimitation issue, which is being linked to the amendments to the Nari Shakti Vandan Adhiniyam, 2023, after April 29.

Kharge's letter came in response to a missive from the prime minister on the special sitting of Parliament for a discussion on the Nari Shakti Vandan

Adhiniyam from April 16. "I have just received your letter on the special session of Parliament for a discussion on the Nari Shakti Vandan Adhiniyam from the 16th of April," the Leader of the Opposition in Rajya Sabha said in his letter to Modi dated April 11.

Trump orders Hormuz blockade after Iran talks fail

Washington (TSIT): US President Donald Trump on Sunday announced a sweeping naval blockade of the Strait of Hormuz, accusing Iran of refusing to abandon its nuclear ambitions despite nearly 20 hours of talks mediated in Pakistan.



In a series of lengthy posts on Truth Social, Trump said negotiations "went well" and "most points were agreed to", but asserted that Tehran remained "unyielding as to the single most important issue", adding: "IRAN IS UNWILLING TO GIVE UP ITS NUCLEAR AMBITIONS!"

The US President added that

he had been "fully debriefed" by Vice-President JD Vance, Special Envoy Steve Witkoff and Trump's son-in-law Jared Kushner following the Islamabad meeting, which Trump said was facilitated by Pakistan's leadership. He also accused Iran of renegeing on assurances to keep the Strait of Hormuz open, saying the situation had caused "anxiety, displacement, and pain to many people and Countries throughout the World".

"They say they put mines in the water," Trump wrote, adding that uncertainty over maritime safety had effectively deterred shipping.

Cong institutionalised corruption in T'gana, alleges KTR



Hyderabad (TSIT): Bharat Rashtira Samithi (BRS) Working President K.T. Rama Rao (also known as KTR) on Sunday accused the Congress government in Telangana of institutionalising corruption through what he termed a "loot-and-hide scheme" across the state. Addressing party leaders and workers at the BRS office in Mancherla district after felicitating elected representatives of Kyathanpalli municipality, he alleged that Congress leadership -from Ministers to MLAs - were indulging in widespread corruption in every Assembly constituency and scheme.

Last mile push key for entire alliance: Stalin

CHENNAI (TSIT): Chief Minister and DMK president MK Stalin on Sunday called upon the party cadre to step up campaign efforts in the final stretch ahead of polling on April 23, emphasising close engagement with voters not just for the party but also for allies.



In a letter to party workers, Stalin noted that only 10 days remain for polling and said people across constituencies are expressing expectations for the continuation of welfare schemes under the "Dravidian model 2.0". "The relationship with the people must continue. The cadre should work closely with voters and intensify ground-level campaign activities over the next 10 days," he

said. Highlighting the commitment within the alliance, Stalin pointed out that senior leaders, despite age and harsh summer conditions, are actively campaigning. He cited leaders such as DMK chief K Veeramani (92), P Chidambaram (80), Vaiko (81) and Duraimurugan (87) as examples to emulate.

Expressing confidence in victory, Stalin said the alliance's strength lies in support from women, confidence among youth, and backing from all sections, including minorities. "Our responsibility is to convert this goodwill into votes on polling day. Every vote matters," he said.

He also urged the cadre to work not just for DMK candidates but for the entire alliance, stressing coordination with partners to secure a comprehensive victory across all constituencies.

Calling for united efforts, Stalin said sustained ground-work over the next few days would help the alliance achieve a record mandate for a second consecutive term.

Telangana sanctions Rs 54.90 crore for 2025 beedi leaf season, aiming to lift tribal women's income



The Telangana government has rolled out a 54.90 crore plan for the 2025 beedi leaf season, promising both a steady income stream for tribal communities and a tighter grip on a trade long dogged by middlemen. With the issuance of Government Order (GO) Rt No.37 on 10 April, the state has given the green light for full-scale implementation of the Beedi Leaf Scheme across 30 districts and 37 forest divisions.

The Telangana Forest Development Corporation Limited (TFDC) has been appointed as the government's sole agent for procurement and trade. By doing so, the state hopes to streamline operations, ensure fair pricing, and bring transparency through e-portal auctions, effectively cutting out the middlemen who once had the last laugh. This latest order is in continuation of a series of earlier decisions, including the appointment of TFDC as the nodal agency in 2024, the formation of an advisory panel to fix rates, and the approval of auction conditions earlier this year.

Recommendations from the Principal Chief Conservator of Forests ultimately sealed the deal, paving the way for what officials describe as a calibrated and consistent policy initiative.

A key aspect of the scheme is the uniform procurement rate of

3,300 per Standard Bag (SB), with each bag containing 1,000 bundles of 50 leaves, adding up to a staggering 50,000 leaves. The state has set its sights high, targeting the collection of 1,22,000 Standard Bags, or roughly 6.1 billion leaves. The numbers tell a story of scale and spread. The Bhadradri Circle leads the pack with 47,300 S.Bs across 40 units, followed by the KTR Mancheril Circle with 38,500 S.Bs. Kaleshwaram Circle is not far behind with 32,900 S.Bs. Smaller allocations have been earmarked for Basara, Rajanna, and Charminar circles. The 54.90 crore outlay has been split with an eye on both recovery and welfare.

A lion's share — 4,102 lakh — is expected to be recouped through auction proceeds, while 1,388 lakh is earmarked as non-reimbursable expenditure. Collection costs alone account for over 4,000 lakh, directly tied to payments made to leaf pluckers. Operational expenses such as transport, staffing, and monitoring form another significant chunk. The government has also factored in insurance coverage for workers and storage facilities, a safety net that had long been missing.

According to officials, from data-entry operators and godown keepers to field-level forest staff, the scheme casts a wide net in

terms of employment. Facilitation charges have been structured to incentivise the staff on the ground, ensuring the machinery runs like a well-oiled engine even in remote forest areas, the sources said.

For thousands of tribal and forest-dwelling families, the beedi leaf season is more than just a harvest; it is a lifeline. In districts like Bhadradri-Kothagudem and Mancheril, the seasonal collection provides crucial income during lean agricultural months.

By guaranteeing a fixed rate and eliminating exploitative intermediaries, the government aims to put more money directly into the hands of collectors. With the current targets, payouts to pluckers alone are expected to cross 40 crore, injecting much-needed liquidity into rural economies.

The scheme also doubles as a job generator. From plucking and bundling to transportation and storage, it creates a ripple effect of temporary employment. The introduction of the TG Beedi Leaf Management Information System (BLMIS) further ensures real-time tracking and accountability, plugging loopholes that once led to leakages, the sources said.

Beyond economics, the scheme walks a fine line between utilisation and conservation. Beedi leaves, sourced from naturally

occurring Abnus (tendu) trees, are collected under regulated conditions to prevent overharvesting. By restricting operations to notified forest and government lands, the state tries to protect ecology.

Operationally, the scheme must contend with tight timelines, unpredictable weather, and the logistical challenge of coordinating across 37 forest divisions. Timely payments to collectors will be crucial; any delay could take the sheen off an otherwise promising initiative.

What sets this scheme apart is its continuity. By largely retaining last year's pricing and administrative framework, the government has sent a clear signal of stability. The provision allowing TFDC to raise working capital loans also ensures that cash flow hiccups do not derail operations.

With the season already underway, the onus is seen as resting on the forest department and TFDC to hit the ground running. Mobilising manpower, setting up logistics, and ensuring smooth auctions will be key to translating policy into practice. For tribal communities, the stakes could not be higher. If executed well, the scheme could be a shot in the arm—putting money in pockets, dignity in labour, and order in a trade that once operated in the shadows.

PUBLIC HEALTH PROTECTION IS THE GOVERNMENT'S GOAL — REVOLUTIONARY CHANGES IN THE MEDICAL SECTOR HEALTH MINISTER SATYA KUMAR YADAV

The South India Times, Visakhapatnam : State Medical, Health and Family Welfare Minister Satya Kumar Yadav stated that the government's primary objective is to provide corporate-level medical services to the poor. He said that the medical sector in the state has achieved significant progress over the past two years. On Sunday, he, along with District Collector Abhishek Kishore, inaugurated the Endobronchial Ultrasound (EBUS) machine and other development works at the Chest and Communicable Diseases Hospital in Visakhapatnam. Speaking on the occasion, the Minister said that it is a matter of pride that this advanced ultrasound machine has been installed for the first time in the Telugu states. He noted that this would enable more efficient diagnosis of respiratory diseases. He revealed that OP and IP services in the hospital have increased significantly, with OP services rising from 35,000 in 2023 to 45,000 by 2025. He appreciated the dedication of the medical staff, noting that major surgeries increased from 359 to 649. He stated that a free cancer screening program is being implemented across the state for the first time in the country,



and that modern cancer centers have been established in Kurnool, Visakhapatnam, Kadapa, and Guntur. He added that comprehensive cancer centers will also be set up in Kakinada and Anantapur in the coming financial year, moving towards a cancer-free Andhra Pradesh. The Minister said that funds under Arogyasri (NTR Vaidya Seva) have been significantly increased, with the limit rising from Rs. 6 lakh earlier to Rs. 3.76 crore at present. He noted that public trust in government hospitals has increased. He further explained that steps are

being taken to make a new dialysis machine available every three days across the state, increasing the total number from 550 to 725. He announced that a 'Universal Health Scheme' will soon be implemented to provide free medical facilities up to Rs. 25 lakh for every family. The posters, put up by the ruling BJP and bearing the party's "lotus" symbol, urge devotees of Lord Jagannath to support the saffron party in West Bengal, which goes to polls in two phases on April 23 and 29. The campaign materials have been strategically placed in high-footfall locations such as the sea beach,

bus stand, railway station and Grand Road beside the Jagannath temple frequented by pilgrims and tourists. The Swargadwar cremation ground area, often referred to as "mini-Bengal" due to the presence of Bengali shopkeepers and visitors, has also seen such posters. The campaign material targets Bengali tourists, urging them to vote for the BJP in the upcoming West Bengal elections. Some tourists expressed disapproval of the campaign.

"We have come to Puri to keep away from the election campaign bustle and

for relaxation. The prime objective is to pay obeisance to Lord Jagannath," said Prof. Tama Basu, a visitor. The development has also not gone down well with the opposition BJD.

"I was born and raised in this town, but have never seen Bengal election posters being pasted on the walls of Puri. The BJP is misusing the pilgrimage town. Puri is one of the sacred four 'dhams' of the Hindus and should be kept out of politics," BJD Rajya Sabha MP Subhashish Khuntia said. He also urged the Odisha government to remove the posters and maintain the

town's sanctity. A section of the locals echoed similar concerns. Rathindra Mishra, a resident of the town, said it was for the first time that a political party from another state had used the town for election campaigning. The BJP, which came to power in Odisha in 2024 defeating the BJD, however, does not see anything wrong in it. "There is nothing wrong with fixing posters in Puri or some other places where Bengal voters are frequently visiting. It has nothing to do with religion," state BJP spokesperson Manoj Mohapatra told PTI.

"This programme brings together the most transformative technologies of recent times - Artificial Intelligence, Machine Learning, Data Science, the Internet of Things, and Robotics, seamlessly integrated with the core pillars of management:



operations, marketing, finance, and manufacturing," he said at the institute's convocation ceremony for its first MBA batch. The programme, which has 70 seats, is designed to meet the evolving needs of digitally driven industries by creating

future-ready professionals who can operate at the intersection of technology and business leadership, he said. Tiwari said that the degree programme, which will cost Rs 6-7 lakh per year, will be in collaboration with the Indian Institute of Technology

Bombay (IIT Bombay) and several industry partners who will teach the students the technology aspect. "IIM Mumbai will teach the business management aspect with a guarantee of 100 per cent placement," he said. The selections are being done through the Joint Entrance Examinations - Main (JEE-Main), followed by an interview, said Tiwari.

"We will also give third-year students in the third year of the course the option to pursue a Master's in Business Administration (MBA), which they can complete in one year immediately after the four-year bachelor's programme," he added.

Rush on final day of filing nominations papers for Gujarat local body elections

AHMEDABAD: Candidates scrambled to file their papers on the last day of filing nominations for the April 26 local body elections in Gujarat where the contest is mainly expected between the BJP, Congress and the AAP.

As per the schedule announced by the State Election Commission, scrutiny of nominations will take place on April 13 and candidates can withdraw from the race till April 15. Counting of votes is scheduled for April 28.

Several candidates who received party mandates at the last moment hurried to submit their papers on Saturday, while some of those who were denied tickets expressed dissatisfaction.

Besides the BJP, Congress and AAP, the Nationalist Congress Party as well as the All India Majlis-e-Ittehadul Muslimeen



(AIMIM) too are in the fray, which would lead to multi-cornered contests in several places. Among notable candidates are former Gujarat-cadre IPS officer M L Ninama, former radio jockey Abha Desai and former AAP MLA Bhupendra Bhayani. Ninama, who recently took voluntary retirement and joined the BJP, has been field-

ed from Odh seat in Shamlaji taluka for the Arvalli district panchayat elections. Bhupendra Bhayani, who resigned as AAP MLA from Visavadar in 2024 and joined the BJP, has been nominated by the ruling party from Bhesan seat of the Junagadh district panchayat. Abha Desai, popularly known as 'RJ Abha', has been nominated by the Congress from

ward number 10 of the Rajkot Municipal Corporation.

Elections will be held to 34 district panchayats, 260 taluka panchayats, 84 municipalities and 15 municipal corporations including Ahmedabad, Surat, Vadodara, Rajkot, making it one of the largest electoral exercises in the state.

State Election Commissioner S Murali Krishna had said that there were over 4.18 crore eligible voters across 9,992 seats. The polls are being held under revised norms for Other Backward Class (OBC) reservations, which required extensive delimitation and restructuring of wards in several districts. Voting will be conducted between 7 am and 6 pm on April 26. If required, re-polling will be held on April 27, and the entire election process is expected to be completed by April 30, officials said.

Mercury continues to rise in Delhi; temp likely to hit 40 deg Celsius by next week

NEW DELHI: The National Capital continued to see a rise in the temperature on Saturday, with forecasts by the India Meteorological Department (IMD) suggesting a further rise in the coming days. Safdarjung, representative of the city's weather, recorded a maximum temperature of 34.7 degrees Celsius, 1.4 degrees below the normal and 1.9 degrees more than a day before.

The minimum temperature was logged at 18.6 degrees Celsius, 2.4 degrees below normal, but a 2.3 degree rise from the day before. Other weather stations also logged a significant rise in both maximum and minimum temperatures. Palam recorded a maximum of 34.4 degrees Celsius, a 2.6 degree rise from Friday and a minimum of 19.5 degrees Celsius, 3.9 degrees more than the day before. Lodhi Road recorded a minimum of 17.8 degrees Celsius, 2.6 degrees rise from the day before.

Meanwhile, THE IMD has forecast the minimum temperature to be around 18-22 degrees Celsius by Sunday and 20-22 degrees Celsius by Tuesday. The maximum temperature is likely to be around 35-37 degrees by Sunday and 38-40 degrees Celsius by next Wednesday. The MeT department has also forecast gusty winds of speed 15-25 kmph, even reaching 35 kmph, to continue through the daytime hours of Sunday.

Meanwhile, the city's air quality index (AQI) saw further improvement on Saturday morning. The 24-hour average AQI was recorded at 123 (moderate) at 4 pm, compared to an AQI of 151 (moderate) recorded at the same time on Friday.

According to CPCB standards, an AQI of 0-50 is considered 'good', 51-100 'satisfactory', 101-200 'moderate', 201-300 'poor', 301-400 'very poor', and 401-500 'severe'.

The Air Quality Early Warning System (AQEWS) for Delhi has forecast the AQI to remain in the moderate category for the next few days and then see a deterioration to the poor category in the subsequent days.

Boy killed in leopard attack in Gondia

GONDIA: A 7-year-old boy was killed in a leopard attack in Arjuni Morgaon tehsil of Gondia district, a forest department official said on Saturday.

The incident took place around 8pm on Friday when Prajwal Govardhan Meshram was playing in front of his house in Dhabetkedi village, Range Forest Officer Rajendra Bahure said.

"The leopard pounced on the boy and dragged him into the thicket. Onlookers managed to free him from the clutches of the leopard but he had sustained severe injuries. He died some time later. An initial compensation amount of Rs 1 lakh has been given to his kin," the official said. On Saturday, three cages were installed in the area along with six camera traps and a drone camera to monitor the movement of the leopard to capture it.

BJP-RSS attempting to change Constitution, replace democracy with dictatorship, alleges Tejashwi Yadav

PATNA: RJD leader Tejashwi Yadav on Saturday alleged that the BJP and RSS were attempting to change the Constitution, and replace democracy with dictatorship.

Addressing a programme organised by the RJD minority cell in Patna, the leader of the opposition in the assembly called on party workers for a united fight against "adversaries of the Constitution". "RSS and BJP want to replace the Constitution of India with that of RSS. They seek to eliminate democracy and establish a dictatorship. For us, this is a time for struggle," he said.

"If such changes occur, they will adversely affect backward classes, extremely backward classes, Dalits, and other margin-

alised communities," he asserted.

The RJD leader urged party workers to fight against the alleged "divide and rule" policy of the "communal forces". "If any leader, Hindu or Muslim, including me, delivers an inflammatory speech or engages in communal politics, they should be strongly opposed," he said.

Yadav alleged that the BJP and RSS were working to "derail peace and fraternity in the country by 'instigating conflict' for decades.

"I am the son of Lalu Prasad, who stopped LK Advani's 'rath' and got him arrested for trying to facilitate Babri Mosque demolition. Neither my father bowed down to communal forces, nor will I," he said.

He accused the Centre of filing false cases against him and his family members as "part of a conspiracy to defame and divide" them.

"Cases are filed against my entire family and me. There are conspiracies to defame and divide us. Whenever Tejashwi raises questions about law and order, false cases are filed against him to divert public attention," he said. Yadav accused AJUP founder Humayun Kabir of allegedly taking Rs 1,000 crore from the BJP to defeat "secular forces" in poll-bound West Bengal, referring to a viral video shared by the TMC. "The BJP is trying to topple governments in opposition-ruled states to make sweeping changes in the Constitution," he claimed.

Bypolls: K'taka Cong Minority chief Abdul Jabbar resigns amid allegations of 'internal conspiracy'

BENGALURU: Karnataka Congress Minority Department President K Abdul Jabbar announced his resignation from the post on Saturday, a day after a group of Muslim leaders accused members of their own party of "conspiring" to defeat the official candidate in Davanagere South.

Jabbar, an MLC, was an aspirant for the Congress ticket from the Davanagere South Assembly segment. "It has been an honor for me to serve as Chairman of the KPCC Minority department and have worked to the best of my ability during assembly elections 2023 and followed by Parliament polls and many such occasions whenever the party needed the minority department and showed results. I have toured the entire state of Karnataka and worked to align the mi-

norities with Congress values and principles. Most of it is available in the public domain," Jabbar said in a letter to the party.

"Minority voters and minority office bearers are the backbone of our great Congress party and certainly deserve better," he said. Deputy Chief Minister D K Shivakumar, who is also the Karnataka Pradesh Congress Committee President, confirmed Jabbar's resignation.

"I won't speak about this now, I have got some reports. The Minority President has submitted his resignation. I will verify things, I will seek a report from local leaders after that I will speak," he told reporters in response to a question on internal conspiracy.

A rift within the Karnataka Congress surfaced on Friday, a day after the bypolls to two

Assembly constituencies in the state, as a group of Muslim leaders alleged a "conspiracy" by some of their own senior party leaders to defeat the official candidate in Davanagere South.

However, they asserted that despite efforts by some within to project that Congress "betrayed" Muslims, the party candidate Samarth Mallikarjun will win in Davanagere South, the constituency where the community has a significant presence.

They said the party finally named Samarth Mallikarjun as the candidate after considering all factors and taking all Muslim leaders into confidence. Despite this, a massive campaign, including from some within the party, projected the Congress as having "betrayed" the minorities by denying them tickets.

Chief Whip in the Legislative Council Saleem Ahmed, MLAs Rizwan Arshad, Yasir Ahmed Khan Pathan, MLC Bilkis Bano, and other Congress leaders addressed a joint press conference on Friday, claiming an "internal conspiracy".

According to party sources, these Muslim leaders have also complained to AICC and state party leadership, alleging "internal sabotage" in Davanagere South. Though the leaders did not name anyone, several party sources said their attack was directed at State Housing Minister B Z Zameer Ahmed Khan and Jabbar among others. Khan, who had openly demanded the Davanagere South ticket for a Muslim candidate, initially stayed away from campaigning in the constituency, citing his Kerala poll responsibilities.

Man found sleeping in temple office after stealing Rupees 8,500, arrested

THIRUVANANTHAPURAM: A man who allegedly broke into a temple office and stole Rs 8,500 cash, somehow slept there in tiered, leading to his arrest on Saturday, police said. The incident happened in the Kuzhuvattam Sree Bhagathy temple in Kudappanamoodu in Amboori. When temple committee members arrived at the office at around 5.30 am, as usual, they were shocked to see the doors broken. They were also taken by surprise to see a man sleeping inside, police added.

He was found to have stolen Rs 8,500 from the office. The temple staff immediately alerted the police, who reached the spot and took him into custody. Vellarada police registered a case and recorded his arrest.

The accused was identified as Senthil (40), from Tamil Nadu. He allegedly broke open the doors and entered the temple office on Friday night. After stealing money, he felt tired and slept there, police said, adding that he was allegedly involved in multiple theft cas-



es. He was later produced before a court and remanded to judicial custody.

Shahdara Cyber Police nab 3 in Rs 10L investment fraud

NEW DELHI: The Cyber Police of Shahdara district has busted a high-return investment fraud racket and arrested three accused for allegedly cheating a Delhi resident of Rs 10 lakh through a fake stock market scheme.

According to police, the victim was lured in December 2025 via a WhatsApp group where fraudsters promised guaranteed and high returns on stock market investments. Trusting the claims, the complainant transferred Rs 10 lakh, but received neither returns nor a refund. The accused later cut off all communication, confirming the fraud.

During the investigation, the cyber team used technical surveillance and digital analysis to trace the money trail, which led them to Rohini. Acting on inputs, police conducted a raid in Vijay Vihar Phase-2 area and apprehended three accused identified as Sumit (26), Sandeep (42), and Kamal Kumar (41).

Police revealed that the accused were operating mule bank accounts to receive and transfer the cheated money, helping the main fraudsters conceal their identities. During the operation, officials recovered five mobile phones, six debit cards, and crucial digital ev-

idence including WhatsApp chats, bank credentials, and account details linked to the fraud.

Deputy Commissioner of Police, Shahdara, Rajendra Prasad Meena (IPS) said, "Our cyber team used advanced technical analysis to track the financial trail and identify the accused. This action is part of our ongoing efforts to curb organized cyber fraud. Further investigation is underway to trace the larger network and recover the cheated amount."

Police said efforts are continuing to identify other members of the syndicate and uncover the full extent of the fraud network.

Punjab BJP forms teams to assess crop loss

CHANDIGARH: The Punjab BJP has assigned senior leaders to visit villages affected by rain and hailstorms to gather feedback from farmers regarding crop damage. Estimated crop damage has impacted over 1.25 lakh acres due to recent weather conditions in various parts of the state.

"To assess the damage and gather first-hand feedback from farmers in rain-affected areas of Punjab, the Bharatiya Janata Party (BJP) Punjab has deputed its senior leaders to visit the affected regions and take stock of the situation," said a statement.

According to a list released by state general secretary Anil Sarin, the party has constituted five teams to cover ten affected districts across the state.

The team assigned for Fazilka and Sri Muktsar Sahib comprises Manpreet Singh Badal, Dyal Singh Sodhi, Sujeet Jyani, Ashwani Sekhri, Vandana Sangwan, and Lakhbir Singh. For Ferozepur and Bathinda, the team includes Rana Gurmeet Singh Sodhi, Jagmeet Singh Brar, Sushil Rinku, Harminder Jassi, Jagdeep Singh Nakai, Sarabhjit Singh Makkar, and Darshan Singh Neneval.

The team for Barnala and Sangrur consists of Som Parkash, Kewal Singh Dhillon, Maharani Parnet Kaur, Harbans Lal, Mangat Rai Bansal, Ranjit Singh Gill, and Jagdeep Singh Cheema. Meanwhile, the team for Amritsar and Pathankot includes Vijay Sampla, Shwet Malik, Tikshan Sood, Dinesh Singh Babbu, Fateh Jang Singh Bajwa, Manjit Singh Manna, and Balwinder Singh Laddi. For Hoshiarpur and Kapurthala, the team comprises Manoranjan Kalia, Avinash Khanna, Jangi Lal Mahajan, Sheetal Angural, K D Bhandari, and Jagbir Singh Brar.

Poppy husk worth Rs 1.25 cr seized in Palamu, 2 arrested

MEDININAGAR: Two persons were arrested after poppy husk worth Rs 1.25 crore was seized from their possession in Jharkhand's Palamu district, officials said on Saturday. The consignment was intercepted following a tip-off in the forest area near the Jawar village under Naudiha police station on Friday, they said.

"We have recovered 815 kg of poppy husk packed in 60 plastic sacks from a pickup van. The vehicle was being escorted by two persons

riding on a motorcycle. The driver of the van somehow fled the scene, and raids are being conducted to nab him," said Chhattarpur SDPO Awadh Kumar Yadav. The market value of the seized contraband is estimated at approximately Rs 1.25 crore, he added. The police also seized the motorcycle and two mobile phones from the arrested persons, and an FIR has been lodged against them under the NDPS Act at Naudiha police station.

Man trapped under uprooted tree in Uttam Nagar rescued

NEW DELHI: A 26-year-old man, trapped under an uprooted tree in West Delhi's Uttam Nagar area, was rescued on Friday afternoon, officials from the Delhi Fire Services (DFS) said. "A call was received at 4.36 pm regarding the incident at A-Block cremation ground near a gurudwara in the area," a DFS official said, adding that two fire tenders were rushed to the spot. A tree got uprooted, possibly due to strong winds and a man, identified as Kallu, got trapped under it.

Asha Bhosle Is Gone, But Her 'Bad Girl' Anthems Live On

The year is 1971, Helen is dancing in a blingy red dress, with a faux Big Ben in the background, in Caravan, a thriller directed by Nasir Hussain. It's described as the last word in cabaret by several writers. But for Asha Bhosle fans, it was the first glimpse of modernity, with the chorus "Monica My Darling" continuing to be echoed in popular culture, most recently in last year's Dhurandhar in the Reble rap song, 'Run Down the City', set in a Karachi night club. The singer of the original song, Asha Bhosle, is no more, but her "bad girl" voice will live forever. Before the rise of the modernists in Hindi film industry music, composers like OP Nayyar and RD Burman, both of whom had long partnerships with Bhosle, the good girl voice was epitomised by Lata Mangeshkar, Bhosle's elder sister, with voices like that of Geeta Dutt being used for drink-sodden, late night songs. But Bhosle was the first to bring a rare sensuousness into modern Hindi music, represented in yet another blockbuster from 1971, 'Dum Maaro Dum', in the film Hare Rama Hare Krishna. The song was originally to be sung by Usha Uthup, whom the director Dev Anand and music composer RD Burman first heard at The Oberoi in New Delhi. The song soon became the anthem of rebellious youth, with its incendiary lyrics written by Anand Bakshi: "Duniya ne humko diya kya/Duniya se humne liya kya (What has the world ever given us/What have we ever taken from the world)." It was pictured on Zeenat Aman as Jasbir/Janice in Kathmandu, wearing a marigold necklace, dark glasses on her hair, and resting her head on Gautam Sarin's broad shoulders, supposedly lost in a drug haze. For those who grew up in the 1970s, Asha Bhosle was the voice of cosmopolitanism, which was showcased later in her global collaborations, from singing flirtatiously with Brett Lee ('You're the One for Me', 2007) to Boy George ('Bow Down Mister', with Bhosle chanting a 'Hare Krishna' mantra, 1991) to the British band Gorillaz on 'The Shadow Light (along with Ajay Prasanna and Aman and Ayaan Ali Bangash) as late as early this year. She was the voice of Zeenat Aman shimmying in 'Chura Liye Hai Tumne' in Hindi cinema's first modern multistarrer Yaadon Ki Baarat, directed by Nazir Hussain; as much as she was the voice of Parveen Babi in the self-designed body hugging silver gown in Shaan (1980), singing 'Pyaar karne wale'. It wasn't a coincidence that both Aman and Babi were unique in breaking the good girl/bad girl binary that was the fate of women in Hindi cinema till then. But Bhosle had range as well, as she displayed to the surprise of many in Umrao Jaan (1981), where she sang Rekha's lovelorn ghazals penned by Shahryar and set to music by Khayyam. Anyone who can listen to 'Dil cheez kya hai/Aap meri jaan lijiye' (What is my heart/You can take my life as well) without a lump in her throat can only have a heart of stone. The iconic song contains multitudes - not merely Umrao Jaan's tragic life, but also the heartbreaks of Rekha and Bhosle. Despite her upbeat attitude to life, Bhosle's life was strewn with loss and longing, whether it was her abusive first husband Ganpatrao Bhosle, her long struggle to establish herself in an industry where her sister was already the reigning queen of music, her enduring love affair with RD Burman cut short by his untimely death at 54, the suicide of her daughter Varsha and the death by cancer of her eldest child Hemant. But whether it was in concerts or in rehearsals, rarely did she display her wounds. Bhosle's voice created stars. Remember 'Tanha tanha, composed by AR Rahman, and shot on Urmila Matondkar in a variety of flowing minidresses by the beach in Ram Gopal Varma's Rangaala (1995)? Or Gracy Singh in Lagaan (2001) singing the feisty 'Radha kaise na jale' in a duet with Udit Narayan? And it solidified stars such as Madhubala, oozing mischief and playfulness with songs such as 'Haal kaisa hai janaab ka' from Chalti ki Naam Gaadi (1958) and 'Aaiye Meherban' from Howrah Bridge (1958).

WHEN TOM CRUISE SHOWED UP AT 'ASHA'S'

It was August 21, 2021. The world was still recovering from the Covid pandemic and restaurants had barely started doing regular business. So, you can imagine how surprised the staff of Asha's, a Michelin-starred restaurant in Birmingham (one of six owned by Asha Bhosle, the singing legend and passionate cook), must have been when Tom Cruise, dressed in a Henley-style round-necked, full-sleeved tee, jeans and bombardier jacket, casually walked in with his entourage, bodyguards and all, which included Mission: Impossible writer and director, Christopher McQuarrie. Cruise was in Birmingham shooting for Dead Reckoning: Part One, the seventh installment of the multi-billion-dollar Mission: Impossible franchise, and he left the Asha's staff gobsmacked when he asked for a second Chicken Tikka Masala (CTM) after finishing the first - and he wanted the spice quotient to be amped up for this one. "The greatest compliment," said the chuffed restaurant in an Instagram post. The CTM was not all that Cruise loved at Asha's. He also had - and relished - the Palak Paneer, but at the Birmingham restaurant he will always be remembered as "two tikka Tom". No one was happier at the superstar's surprise appearance than the restaurant's owner, the singer with the jaunty voice that still gets the nation grooving and the equally accomplished cook. She took to Instagram at once and said: "I was very happy to hear that Mr Tom Cruise enjoyed his fine dining experience at Asha's (Birmingham) and I look forward to him visiting us again soon!" Cruise, meanwhile, got himself photographed outside the restaurant, its senior staff at a distance behind him out of respect for Covid social distancing norms. And that picture went viral.



A Childhood Relish

It also reminded the world about Asha Bhosle's love for cooking and eating good food, a talent she developed during her childhood spent travelling with her father Dinanath Mangeshkar's peripatetic theatre company. Her constant craving to know more about the food she ate at different places stayed with her throughout her life, getting a boost when she had to plan the meals of her son Anand, who went on to launch Asha's. It may be the reason why Asha's menu has such a pan-Indian footprint.

The restaurant, though, may not have happened, according to Farzana Contractor, founder and editor of Upper Crust, had the Emirati entrepreneur and royal, Sheikh Manna-bin-Halifa al Makhtoum, not read a Gulf News interview in which the singer who'll forever be remembered for 'Dum Maro Dum' and 'Mehbooba Oh Mehbooba' talked about her love

for food and her dream of opening an Indian eatery. That was in 1998-99 when Asha Bhosle was visiting Dubai for concerts. Sheikh Manna-bin-Halifa's management team contacted the singer and they got talking about the prospect of opening restaurant after her name in Dubai. Asha Bhosle could have just lent her name and go on to count her share of the earnings, but, as Contractor points out, she insisted on personally training the restaurant's opening chefs, Sachin Tilak and Salim Qureshi.

Momos, Biryani, And Everything Else

The durability of the Dubai restaurant, which opened in 2002 with Anand helming it, and the fact that it has spread its wings to other locations internationally, only goes to show the drawing power of Asha Bhosle's eclectic table, where you could have been served everything - from momos, which Mala Sinha

(whose family had Nepali origins) taught the singer to make, to Raj Kapoor's favourite Peshawari biryani, to a delicious boneless chicken cooked with ginger, garlic and almonds in a coconut gravy, which she picked up from the lyricist Majrooh Sultanpuri's wife (who, incidentally, had a formidable repertoire of Awadhi delicacies). People talk about Asha Bhosle and RD Burman's partnership being one of the most enduring in Hindi cinema - and Burman, being an epicure whose favourite was the Goan prawn curry, made demands not only on his wife's exceptional singing talent, but also on her cooking skills.

Looking back at her days with him in her conversation with Contractor, Bhosle recalled how Burman, popularly known as Pancham Da, loved to entertain. "Burman saab would call and say he is bringing some people over for dinner.

QUESTION ON PENSION OF PUBLIC REPRESENTATIVES

(The Supreme Court of India's strong remarks have sparked a debate—is the pension reserved by former MPs in accordance with the principle of equality or is it an example of privilege?)

India is a democratic country, where the people are considered supreme and public representatives act as public servants. However, from time to time, issues arise that question this fundamental principle. The recent debate over the pensions and benefits of former MPs falls into this category. When the Supreme Court of India questioned the Central Government about the justification for the pensions and benefits provided to former MPs, it sparked a new debate across the country. This question is not merely an administrative or legal issue, but one that concerns social justice, equality, and democratic values. Why should one class enjoy privileges while others are bound by strict rules and limitations? This question naturally arises in the minds of ordinary citizens. In a democracy, public representatives are elected by the people to protect their interests and work for the development of society. This is a responsibility, not a means to obtain permanent benefits. However, when public representatives are granted lifelong pensions, various privileges, and special rights, the question arises whether this system fosters a sense of service or turns it into a privilege. A typical government employee must serve for years to receive a pension, often only after 20 to 30 years of service. In contrast, a sin-

gle term—of five years—is sufficient to become a Member of Parliament. This inequality is worrying not only from an economic perspective but also from a moral perspective.

The Indian Constitution is based on the principle of equality. Every citizen should have equal opportunities and equal rights. However, when special privileges are granted to a particular class, this principle appears to be weakened. The issue of pensions for former MPs has become a symbol of this inequality. When a large section of the country is struggling economically, troubled by problems like unemployment and inflation, such privileges create public discontent. This discontent is not only economic, but also psychological and social. It's also important to note that the cost of these pensions and benefits is ultimately met by public taxes. This raises the question: is this a wise use of resources? Shouldn't this money be invested in education, health, employment, and infrastructure? While it could be argued that this expenditure is not significant in the overall budget, the issue is not just about the amount, but about the principle. If a system promotes inequality, it cannot be justified simply because its economic impact is limited. One perspective on this issue is that public representatives should receive certain benefits after their term. They argue that becoming an MP requires a person to distance themselves from their profession, business, or job. Consequently, they lack a stable source of income after their term ends. Furthermore, it is argued that if public representatives are not provided with financial security, they will be unable to make independent and impartial decisions. They may become more vulnerable to external influences, which could impact the quality of democracy. These arguments seem reasonable, but the question is whether the current system is balanced, or whether this benefit has gone beyond "necessity" and become a "privilege."

An important aspect of this entire issue is how transparent the

process for determining these benefits is. Is public opinion considered in these decisions? Is the advice of experts and economic analysts given importance? It is often observed that decisions related to the benefits of public representatives are made by them. This situation gives rise to conflicts of interest. Therefore, it becomes necessary to increase the role of independent and impartial institutions on these issues.

If we look at other democratic countries, they too provide certain benefits to public representatives, but in most places, these are subject to strict rules and conditions. Many countries have established minimum service periods, age limits, and other criteria. Such a system could be implemented in India, maintaining balance and strengthening the principle of equality. Measures such as determining pensions based on service period, providing them for a limited period, or balancing them with other government pension systems could be effective in this direction.

Public awareness and participation are crucial in any democracy. Positive change is possible only if citizens remain vigilant and raise their voices on these issues. Today, discussions on this topic have increased through social media and other platforms, which is a positive sign. This demonstrates that people no longer want to be mere spectators, but rather active participants. Ultimately, this debate over the pensions and benefits of former MPs is not merely a matter of policy, but rather one that touches the very heart of democracy. It forces us to consider whether we are truly adhering to the principles of equality and justice. The government and policymakers must take this issue seriously and develop a system that is not only rational but also just. Public representatives should be respected and protected, but this system must be designed to ensure that it does not become a privilege. A strong democracy is one where public trust is paramount, and to maintain this trust, transparency, equality, and accountability must be given top priority in policies.

TREATMENT OR BUSINESS? THE TRUTH BEHIND THE WHITE COAT

(When the doctor broke his silence, the dark side of the system came to the fore)

Thercent story of a young doctor has shocked society. The courage with which she spoke on camera about her reasons for leaving her job raises serious questions about not just a personal decision but the entire healthcare system. She said she was pressured to admit as many patients as possible—whether their condition was critical or not. Furthermore, patients were often kept in the ICU for longer than necessary to increase hospital bills. This is more alarming than it sounds. Because healthcare is no ordinary service; it is a sensitive field based on trust, responsibility, and ethics. When profiteering and unethical practices take root in this field, it directly impacts human life. The state of healthcare in India is already beset by many challenges—overcrowding in government hospitals, a lack of resources, and expensive treatment in private hospitals. Consequently, ordinary citizens often turn to private hospitals, hoping for better and faster treatment. However, if they face unnecessary hospitalizations, unnecessary tests, and inflated bills, this not only creates a financial burden but also a psychological drain. The most important question in this entire matter is: Is medicine no longer a service, but a "business"? Are doctors also being subjected to pressures that dis-



tance them from the true spirit of their profession? It's important to understand that not every doctor or every hospital engages in such activities. Even today, thousands of doctors in the country treat patients with complete honesty and dedication despite limited resources. However, the corrupt policies and greed of some institutions tarnish the image of the entire profession. This step taken by a doctor—quitting his job—is not easy, especially when medical education costs lakhs of rupees and there is pressure to maintain a stable career. Standing up for one's ethics is a courageous decision. It also shows us that many people working within the system are uncomfortable with this situation, but not everyone is able to speak out openly. This problem isn't limited to hospital management, but rather, it's become part of a broader system. A complex relationship has developed between insurance companies, the pharmaceutical industry, and private hospitals, in which the patient is sometimes reduced to a mere "case" or "client." The purpose of treatment shifts from improving health to

maximizing revenue. Keeping patients unnecessarily in the ICU is not only financial exploitation but also a serious moral offense. In a sensitive setting like the ICU, patients and their families are already under psychological pressure. Taking advantage of this situation to inflate the bill is considered a betrayal. Additionally, unnecessary testing and treatment are a major problem. Patients are often subjected to tests that are not immediately necessary. This directly impacts their pockets, leaving many families in debt. Another dangerous aspect of this situation is that it erodes society's trust in doctors. When people begin to believe that doctors are more concerned with their bills than with their treatment, it poses a serious threat to the entire healthcare system. The relationship between doctor and patient is based on trust, and when this trust is broken, it is not easy to rebuild it. So what is the solution then? First, it is crucial to increase transparency in the health sector. Hospitals should clearly disclose their fees, treatment procedures, and admission standards. Patients and their families

have the right to know what treatment they are receiving and why. Second, the role of regulatory bodies must be strengthened. The government and relevant health authorities must ensure that ethical standards are followed in hospitals. Strict action should be taken against irregularities to prevent recurrence. Third, doctors must also have a safe and independent work environment. If they face unethical pressure from management, they must have a robust mechanism to complain and seek justice. Whistleblower protections can also be an important step in this direction. Fourth, patients and society need to be more aware. We should be aware of our rights and ask questions when necessary. Seeking a second opinion during treatment can also be a good option. Additionally, medical education should place greater emphasis on ethics. The process of becoming a doctor should not be limited to technical knowledge, but should also include a deep understanding of human values and responsibility. Finally, it's important to understand that healthcare isn't a typical industry.

Karnataka forests hit by illegal trekking surge amid fire season clampdown and weak enforcement



Hubballi, Apr 12: With the Karnataka Eco-Tourism Development Board (KEDB) portal — aranyavihaara.karnataka.gov.in suspending trekking slot bookings indefinitely due to the ongoing fire season, forest authorities are struggling to contain a surge in unauthorised trekking across sensitive forest zones in Karnataka. Despite the restrictions, hundreds of adventure seekers continue to trespass into forest areas, openly flouting rules and posing a growing threat to fragile ecosystems. While KEDB has officially identified 38 trekking routes in the state, regular trekkers and organisers claim there are over 175 trekking spots in and around forest regions, many of them unmanned and poorly regulated.

Recently, 10 youths from Dharwad district entered restricted forest areas in Khanapur to reach Vajrapoha waterfalls. Videos circulating on social media show them ignoring forest department warning boards. In one clip, a youth is heard claiming links to an elected representative, implying that action against them would not be possible. Based on the footage, forest officials detained all 10 youths. However, they were

later released on station bail after being issued warnings, as the offence is non-cognisable and carries a maximum penalty of a Rs 500 fine or up to six months' imprisonment. "We wanted to teach them a strict lesson as they had knowingly violated the rules. But most of the time, we are helpless as the law is weak," a senior forest department officer in Belagavi said.

The videos also show the youths swimming in deep waters at the waterfall, with some allegedly consuming alcohol and smoking. Officials warned that this is a particularly dangerous period, as dry leaves cover the forest floor and even a small spark could trigger large-scale fires in sensitive elephant corridors.

"This is not the first such incident in the Khanapur forests. Every year, four to five cases of trespassing are reported in the area. One major issue is the lack of forest watchers or guards," the officer added, noting that the Khanapur-Chorla Ghat stretch has several minor waterfalls that frequently attract unauthorised visitors. Similar violations are being reported in Kodagu, Chikkamagaluru, Uttara

Kannada, Dakshina Kannada and Udupi districts, where individuals increasingly enter forest areas to create social media content or "discover hidden gems".

Experts caution that such irresponsible behaviour not only endangers trekkers but also threatens forest biodiversity. The recent case of Kerala IT professional G S Sharanya going missing in Kodagu forests — later rescued after straying from a permitted trek to Tadiandamol — has further raised concerns over unregulated trekking groups.

Following these incidents, Forest Minister Eshwar Khandre has directed officials to formulate a standard operating procedure, develop a tracking app for trekkers, and introduce group insurance. However, experts remain doubtful whether these measures will effectively prevent future violations.

Bengaluru-based trekker Rakhi Gowda said authorities cannot fully prevent such trespassing. "The forest and tourism departments lack the manpower to monitor all areas. Instead, regulated access with local guides should be allowed. This can also generate employment for villagers," he said, adding that entry fees could be used to improve facilities.

Environment activist Girish D V from Chikkamagaluru criticised the state's approach, stating that trekking is being permitted without scientific assessment of carrying capacity. He also alleged that unauthorised trekking camps continue to operate unchecked, questioning what action is being taken against them.

NETAJI'S GREAT-GRANDSON CHANDRA KUMAR BOSE JOINS TRINAMOL CONGRESS

Kolkata, April 12: Netaji Subhas Chandra Bose's great-grandson Chandra Kumar Bose on Sunday joined the Trinamool Congress after completely disassociating himself from the BJP.

Bose was officially inducted into the party at Trinamool Bhavan in the presence of state minister Bratya Basu and party MP Kirti Azad, who handed him the Trinamool flag.

Earlier, after being called for the Special Intensive Revision (SIR) hearing, Chandra Bose became disillusioned with the BJP, wondering why there was any doubt about

his citizenship, even after being the great-grandson of a freedom fighter like Netaji. Ahead of the Assembly polls, Chandra Bose has officially joined the Trinamool. "A few years ago, I made a historic mistake by joining the Bharatiya Janata Party. I have corrected that mistake today," he said at the press conference.

In 2016, Chandra Bose had joined the BJP in the presence of then party President Amit Shah during a rally in Howrah. However, he distanced himself from the party after the 2019 Lok Sabha polls. "When (Prime

Minister) Narendra Modi first came to power in the country in 2014, I liked him very much. He took the country forward on the path of progress. Then, in 2016, when I joined the party, I gradually saw that the Bharatiya Janata Party does not respect the constitution of the country. Moreover, they have no similarity with the culture of Bengal. The politics that is going on across the country now, the politics of communalism, the politics of division, is disastrous," he said at the press conference.

TN POLLS: VIJAY UNVEILS WELFARE, AI GOVERNANCE VISION; TARGETS CM STALIN

Kanyakumari (TSIT) : Tamilaga Vettri Kazhaagam (TVK) president Vijay on Sunday outlined an ambitious governance roadmap while sharply criticising Chief Minister M. K. Stalin during an election campaign in Kanyakumari district.

Addressing a gathering in Mahadhanapuram, Vijay promised a corruption-free delivery of welfare schemes, asserting that benefits would reach citizens without the need for applications or bribes. He announced that every family in Tamil Nadu would be issued a "priority card," similar to Aadhaar, containing comprehensive household data. This, he said, would enable the government to deliver welfare benefits seamlessly from birth onwards.

"People should not have to struggle or pay bribes to access what is rightfully theirs. Government schemes will reach your doorstep,"



Vijay declared. He emphasised that artificial intelligence would power this system, ensuring efficiency and transparency.

Taking a dig at Stalin, he remarked that his proposals were not mere "stories," but scientifically achievable plans backed by technology. Vijay also alleged deep-rooted corruption within the current system, claiming that bribes collected at the administrative level often extend up to ministers.

"Stopping corruption will be our first priority," he said, adding that a

TVK-led government would implement a comprehensive "Tamil Nadu Government Service Scheme" within six months of coming to power. A key highlight of his vision is the launch of a unified digital platform named "Vetri Tamil Nadu Super App," through which all government services would be made accessible. He assured that delays in service delivery would invite immediate action against responsible officials. Positioning citizens as active stakeholders, Vijay proposed a participatory governance model. He

announced plans for a dedicated government portal where people could submit ideas, monitor public finances, and directly petition the Assembly. Petitions signed by 10,000 people would receive official responses, while those backed by one million citizens would be taken up for legislative debate. He also promised to allocate a full day in Assembly sessions to discuss public petitions. Highlighting economic concerns, Vijay criticised the state's rising debt, which he said had crossed Rs 10.05 lakh crore.

He accused the current government of excessive borrowing and pledged to increase revenue and rationalise spending without imposing additional taxes. Concluding his address, Vijay said Tamil Nadu would be transformed into India's artificial intelligence and digital capital, with a dedicated AI ministry under a TVK government.

Stalin's paddy incentive charge politically driven, slams Nirmala

CHENNAI: Denying Chief Minister and DMK president MK Stalin's allegation that the Union government had directed the State to withhold incentives for paddy cultivation, Union Finance Minister Nirmala Sitharaman on Sunday said the letter issued by the Department of Expenditure, Ministry of Finance, in this regard was aimed at aligning the bonus policies with national priorities and farmer welfare.

Terming the charge factually baseless, the minister said it was "factually baseless, politically motivated, and a deliberate distortion designed to mislead the farmers of Tamil



Nadu." The Expenditure Secretary's DO had sent a letter dated January 9, 2026, to the Chief Secretaries, asking them to align their State's bonus policy to promote pulses, oilseeds, and millets in line with the national priorities for nutritional security, self-reli-

ance, and sustainable agriculture, the Finance Ministry said in a statement. This was done after noting that the bonus policies were heavily skewed in favour of wheat in northern states and paddy in several states across the country, it said. Such additional incentives over and above MSP further encourage their cultivation, leading to reduced acreage under pulses, oilseeds, and millets, it said, noting that it would put greater environmental stress due to water and fertilizer-intensive farming, and higher import dependence for essential crops like pulses and edible oilseeds. Enhancing domestic production of these crops is essential not only for strategic and economic reasons.

Chronic challenge: High prevalence of long COVID a stark reminder

A high prevalence of long COVID is the starkest reminder that the pandemic is far from over. The latest New Zealand Health Survey confirms the impacts continue, six years after the initial outbreak. Data show most New Zealanders (77.7% or about 3.3 million people) have had COVID at least once. Many reported health changes after infection, but about one in 11 adults (4,01,000 people) described symptoms lasting three months or longer. These were impacts not experienced prior to infection and could not be explained by a different diagnosis.

Women were more likely to report symptoms — about 1 in 7 (14.9%) compared to 1 in 12 men (8.5%). Only among those aged over 65 were the rates similar. One in six Mori adults (15.5%) reported long COVID symptoms, compared to one in nine non-Mori (11.3%), while one in four people living with dis-



abilities (22.8%) experienced lasting symptoms.

Overall, 11.9% of adults who contracted COVID developed long COVID, and almost half (48.5%) were still experiencing symptoms at the time of the survey. New Zealand must take this seriously. Denial and delays in care mean missing opportunities to limit harms.

The results are backed by international studies and previous research showing a fifth of New Zealand children reported persisting symptoms. While self-reported

surveys can vary, this is representative and likely an underestimate because the risk increases with reinfection. Since the survey, many more cases have occurred; New Zealand is now in a ninth wave. Long COVID can affect every organ, including the cardiovascular, immune and nervous systems. Main symptoms include brain fog, fatigue and post-exertional malaise. However, infection can also cause chronic disease without symptoms, with "silent" organ damage predisposing people to later ill-

ness. The findings are concerning. A rare disease is defined as one case in 2,000 people. If a condition is more common, the volume of patients requires specific health services. The prevalence of 9.2% of all adults in New Zealand is more than a hundred times greater than this threshold.

More than 12 months ago, we published an analysis of long COVID in Aotearoa, New Zealand. We noted it remained a risk following any infection or reinfection and carried an increased risk of sudden death and organ damage. We also noted that vaccination reduces the risk. The government should establish a coordinated response, including treatment, public health measures, a vaccination programme, a clear information campaign and targeted surveillance. Very little has been instituted. This indifference extends even to the government's own data.

Sivaganga: Home-alone woman killed, body dumped in well

The deceased, identified as Susila (42), wife of Suresh (48), resident of Keezhakandani. Due to a family dispute, Suresh had separated from his wife. Susila's children were staying at Kootturapati vil-



lage. Susila, a cleanliness worker, was living alone. When she did not report for work, a co-worker tried to contact her, but her phone was switched off. Upon information, her sister came to the house and found Susila missing. Blood stains were found near the well. Police rushed to the spot and recovered her body from the well. Police have detained three suspects.

Pioneering CRISPR Gene Editing Trial: 79% of Participants See Improvement

CRISPR gene editing shows potential in treating blindness, with 79% of trial participants experiencing improved vision. About 79% of clinical trial participants experienced measurable improvement after receiving experimental, CRISPR-based gene editing that is designed to fix a rare form of blindness, according to a paper published today (May 6) in the New England Journal of Medicine.

"This trial shows CRISPR gene editing has exciting potential to treat inherited retinal degeneration," said Mark Pennesi, M.D., Ph.D., a corresponding author on the paper, an ophthalmologist and Oregon Health & Science University's lead scientist for the Phase 1/2 BRILLIANCE trial and a corresponding author on the paper.

"There is nothing more rewarding to a physician than hearing a patient describe how their vision has improved after a treatment. One of our trial participants has shared several examples, including being able to find their phone after misplacing it and knowing that their coffee machine is working by seeing its small lights. While these types of tasks might seem trivial to those who are normally sighted, such improvements can have a huge impact on quality of life for those with low vision." The trial evaluated the safety and effectiveness of EDIT-101, an experimental gene editing treatment that uses CRISPR technology and was developed by Editas Medicine. The experimental treatment was specifically designed to edit a mutation in the CEP290 gene, which provides instructions to create a protein that is critical for sight. People with this mutation have a rare condition that is commonly called Leber Congenital Amaurosis, or LCA, Type 10, for which there is no treatment available. LCA's various types occur in a total of about 2 or 3 out of 100,000 newborns. The OHSU Casey Eye Institute treated the trial's first participant in early 2020. That procedure also marked the first time that CRISPR had been used to edit genes within the human body, which is also called in vivo gene editing. Today's paper describes the study's findings through February 2023, and details how the trial's 14 participants — 12 adults of whom were adults, while two were children — responded to receiving EDIT-101 in one eye. Key results include:

11 participants, or about 79%, showed improvement in at least one of four measured outcomes. 6 participants, or about 43%, showed improvement in two or more outcomes. 6 participants, or about 43%, reported improved vision-related quality of life. 4 participants, or about 29%, had clinically meaningful improvement in visual acuity, or how well they could identify



objects or letters on a chart. There were no treatment-related serious adverse events. Most adverse events were mild or moderate, and all have since been resolved. Four specific outcomes were used to evaluate the experimental treatment's effectiveness: visual acuity, as described above; how well participants saw colored points of light while looking into a specialized device, which scientists call a full-field test; how well participants navigated a research maze with physical objects and varying amounts of light; how much participants reported experiencing improved quality of life. This is the first time that the trial's results have been published in a peer-reviewed scientific journal. Previously, interim results had been shared through conference presentations by investigators and in press releases issued by the trial sponsor.

Future Research Directions In November 2022, trial sponsor Editas Medicine announced that it was pausing the trial's enrollment and would seek another partner to continue the experimental therapy's development. Pennesi and colleagues are exploring working with other commercial partners to conduct additional trials, in collaboration with Editas. The researchers hope future studies can examine ideal dosing, whether a treatment effect is more pronounced in certain age groups such as younger patients, and include refined endpoints to measure impacts on activities of daily living. "This research demonstrates that CRISPR gene therapy for inherited vision

loss is worth continued pursuit in research and clinical trials," said Mass Eye & Ear ophthalmologist Eric Pierce, M.D., Ph.D., who is also a corresponding author. "While more research is needed to determine who may benefit most, we consider the early results promising. To hear from several participants how thrilled they were that they could finally see the food on their plates — that is a big deal. These were individuals who could not read any lines on an eye chart and who had no treatment options, which is the unfortunate reality for most people with inherited retinal disorders." "Our patients are the first congenitally blind children to be treated with gene editing, which significantly improved their daytime vision," said the paper's third corresponding author, Tomas S. Aleman, M.D., a pediatric ophthalmologist at the Children's Hospital of Philadelphia and the University of Pennsylvania's Scheie Eye Institute. "Our hope is that the study will pave the road for treatments of younger children with similar conditions and further improvements in vision. This trial represents a landmark in the treatment of genetic disease, in specific genetic blindness, by offering important alternative treatment when traditional forms of therapy, such as gene augmentation, are not an option."

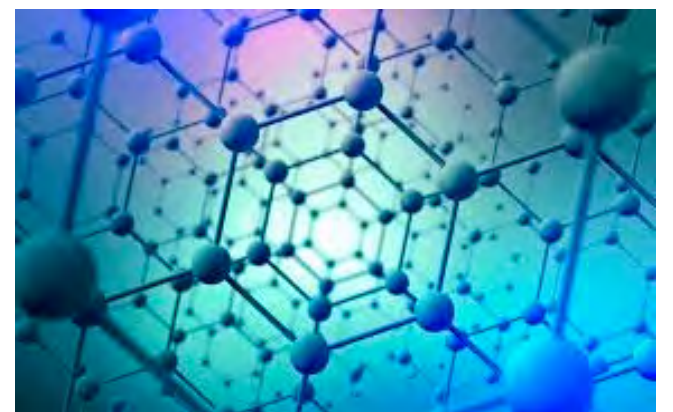

Quantum Transformation: TiS3 Nanoribbons Become Superconductors Under Pressure

A study has shown that compressing TiS3 nanoribbons transforms them from insulators to superconductors, enabling electricity transmission without energy loss. This discovery opens new possibilities for advancing energy-efficient technologies and material science. According to a study in the journal Nano Letters, compressing nanoribbons made of titanium and sulfur can significantly alter their properties, transforming them into materials capable of conducting electricity without energy loss. The authors have made the discovery during their painstaking search for new materials that can transmit electricity without loss of energy, a hot topic that has for long haunted the scientific community.

"Our research focuses on one such promising material: TiS3 nanoribbons, which are tiny, ribbon-like structures made of titanium and sulfur. In their natural state, TiS3 nanoribbons act as insulators, meaning they do not conduct electricity well," says Mahmoud Rabie Abdel-Hafez, an associate professor at University of Sharjah's Department of Applied Physics and Astronomy. "However, we discovered that by applying pressure to these nanoribbons, we could change their electrical properties dramatically," adds Abdel-Hafez, who is the study's main author.

Experimental Findings The scientists exposed TiS3 to gradual pressure. As they increased the pressure, they found that the TiS3 system underwent a series of transitions, from being insulators to becoming metals and superconductors, for the first time. TiS3 materials are known to work as good insulators, but it is the first time scientists have discovered that under pressure they can function as superconduc-



tors, paving the way for the development of superconducting materials.

Credit: Nano Letters (2024). <https://doi.org/10.1021/acsnanolett.4c00824> "Superconductors are special because they can conduct electricity with zero energy loss, which is incredibly valuable for technological applications," says Abdel-Hafez. "[But] imagine a world where electrical power could be transmitted without any energy being wasted as heat. This would revolutionize how we use and distribute electricity, making everything from power grids to electronic devices far more efficient." It is exactly this potential which the authors tout as a breakthrough: the potential of TiS3 to turn into materials causing no waste when transmitting electricity. By carefully controlling the pressure applied to these materials, the authors identified the exact points where they changed from one state to another. "This is significant because understanding these transitions helps us learn how to manipulate other materials in similar ways, bringing us closer to discovering or designing new superconductors that can operate at higher temperatures and more practical conditions,"

notes Abdel-Hafez.

The study shows that TiS3 has the potential to become such materials when subjected to the right conditions. By gradually increasing the pressure on the investigated materials, the authors observed that they transitioned from being insulators (poor conductors) to metals (good conductors) and finally to superconductors (perfect conductors with no energy loss). Discovering that TiS3 materials can become superconductors under pressure is certain to help scientists understand more about the conditions required for superconductivity. This knowledge is crucial for developing new materials that might be superconductors at higher, more practical temperatures, the authors maintain.

Collaborative Efforts and Future Prospects

"This research not only enhances our understanding of superconductivity but also demonstrates the power of international collaboration in achieving groundbreaking scientific results," affirms Sweden's Uppsala University Professor of Physics and Astronomy, a co-author. The project is part of the University of Sharjah's research quest to develop materials that can transmit electricity without energy loss, offering new insights into how pressure can transform the electrical properties of TiS3 nanoribbons.

DONALD TRUMP ORDERS US NAVY BLOCKADE OF STRAIT OF HORMUZ

THREATENS TO 'FINISH' IRAN OVER NUCLEAR DISPUTE

US President Donald Trump said on Sunday that the Navy would "shortly" begin a blockade of ships entering and leaving the Strait of Hormuz.

"So, there you have it, the meeting went well, most points were agreed to, but the only point that really mattered, NUCLEAR, was not. Effective immediately, the United States Navy, the Finest in the World, will begin the process of BLOCKADING any and all Ships trying to enter, or leave, the Strait of Hormuz," he posted on Truth Social.

"At some point, we will reach an 'ALL BEING ALLOWED TO GO IN, ALL BEING ALLOWED TO GO OUT' basis, but Iran has not allowed that to happen by merely saying, 'There may be a mine out there somewhere,' that nobody knows about but them. THIS IS WORLD EXTORTION, and Leaders of Countries, especially the United States of America, will never be extorted. I have also instructed our Navy to seek and interdict every vessel in International Waters that has paid a toll to Iran. No one who pays an illegal toll will have safe passage on the



high seas," Trump said. The development follows collapsed talks with Iran in Pakistan. The US president has vowed to destroy Iranian mines, warning US forces are "locked and loaded". "We will also begin destroying the mines the Iranians laid in the Straits. Any Iranian who fires at us, or at peaceful vessels, will be BLOWN TO HELL! Iran knows, better than anyone, how to END this situation which has already devastated their Country. Their Navy is gone, their Air Force is gone, their Anti Aircraft and Radar are use-

less, Khomeini, and most of their "Leaders," are dead, all because of their Nuclear ambition," he added. Trump said other countries would also be involved with this blockade and Iran would not be allowed to profit off this "Illegal Act of EXTORTION". "The Blockade will begin shortly. They want money and, more importantly, they want Nuclear. Additionally and, at an appropriate moment, we are fully 'LOCKED AND LOADED,' and our Military will finish up the little that is left of Iran! President DONALD J. TRUMP," he added.

The Middle East teeters on the brink of an expanded conflict today, with Al Jazeera reporting that the Israeli army chief has explicitly ordered his forces to prepare for a possible resumption of war on Iran. This stark military escalation, broadcast by the Qatar-based news network, arrives at a critical and volatile moment for the region, directly following the abrupt collapse of international diplomatic efforts to halt the ongoing hostilities.

Ceasefire Talks Hit Dead End

The alarming directive from Israel coincides with a complete standstill in US-Iran ceasefire negotiations. High-stakes diplomatic talks aimed at ending the six-week war have officially failed. Following 21 hours of gruelling, face-to-face marathon negotiations in Pakistan, the US delegation—led by Vice President J.D. Furthermore, Iranian officials maintained a hardline stance, asserting that any successful truce hinged entirely on the United States acknowledging Iran's "legitimate rights and interests." With neither side willing to concede, Vice President Vance confirmed the US delegation's return without a resolution.

The dual blow of Israel's potential military mobilisation and the failure of international diplomacy is sending immediate shockwaves through global markets. Meanwhile, Tata Pension Fund and Axis Pension Fund will serve as the designated pension fund managers. Further, it stated that the Aditya Birla Health Insurance provides the integrated top-up insurance cover, with Medi Assist TPA managing claims administration. "The initiative addresses a growing gap in India's retirement landscape, where healthcare costs are projected to rise by 11.5 per

cent to 14 per cent in 2026, significantly outpacing inflation and putting long-term financial security under pressure for millions," PFRDA said. The scheme has been introduced at a time when the pension ecosystem rapidly scales with NPS and Atal Pension Yojana (APY), having a cumulative subscriber base of 9.64 crore. TCS Suspends Employees, Launches Enquiry Following Sexual Harassment Allegations In Nashik

Tata Consultancy Services (TCS) has suspended several employees pending an internal enquiry following serious allegations of sexual harassment at its Nashik office. The IT firm initiated immediate disciplinary action upon learning of the matter, reaffirming its strict stance against workplace misconduct. The corporate response follows formal complaints made by tech employees in Nashik. In connection with the allegations, local law enforcement has arrested six individuals, including a team lead, from the multinational company's office. Emphasising its commitment to a secure working environment, TCS highlighted the priority it places on staff welfare and safety. "TCS has a long-standing zero-tolerance policy towards harassment and coercion of any form," a company



spokesperson stated. "We have always ensured the highest standards of safety and wellbeing of our employees at the workplace." Addressing the prompt intervention, the spokesperson detailed the immediate steps taken by the firm's management regarding the accused personnel. "As soon as we were made aware of the matter in Nashik, we took swift action. The employees being investigated have been suspended

pending enquiry." The technology giant confirmed it is fully supporting the ongoing police probe into the arrested individuals. Moving forward, the company's final disciplinary decisions will be guided by the official findings. "We are cooperating with the local law enforcement authorities, and any further action will be based on the conclusion of this investigation," the spokesperson concluded.

Music giant Universal gets \$64bn takeover offer

Universal Music Group, the entertainment giant behind acts such as Taylor Swift, Sabrina Carpenter and Kendrick Lamar, has received a takeover offer estimated to be worth \$64.3bn (£48bn). US investment company Pershing Square is offering to buy Universal in a merger that would see the new company listed in America, its billionaire chief executive Bill Ackman said. As well as representing a huge list of artists, the world's largest music company also runs Abbey Road studios and owns labels such as EMI and Island Records. Pershing Square, which already owns a stake in Universal, also has holdings in Google, Meta and Amazon, as well as Restaurant Brands International, which includes Burger King. Universal said it had received Pershing's proposal and would assess its implications for shareholders, employees, artists, songwriters and other stakeholders. The company's board also expressed full confidence in chief executive Sir Lucian Grainge, his management team and strategy. Ackman



said its management had "done an excellent job nurturing and continuing to build a world-class artist roster and generating strong business performance". He said Universal had reshaped the industry to put artists at its centre, and had shown it could seize growth opportunities from artificial intelligence while protecting intellectual property. But he said the company's stock price had "languished" due to issues unrelated to the performance of its music business, which could all be "addressed with this transaction". Dan Coatsworth, head of markets at AJ Bell, said: "On paper, you might think is a money-

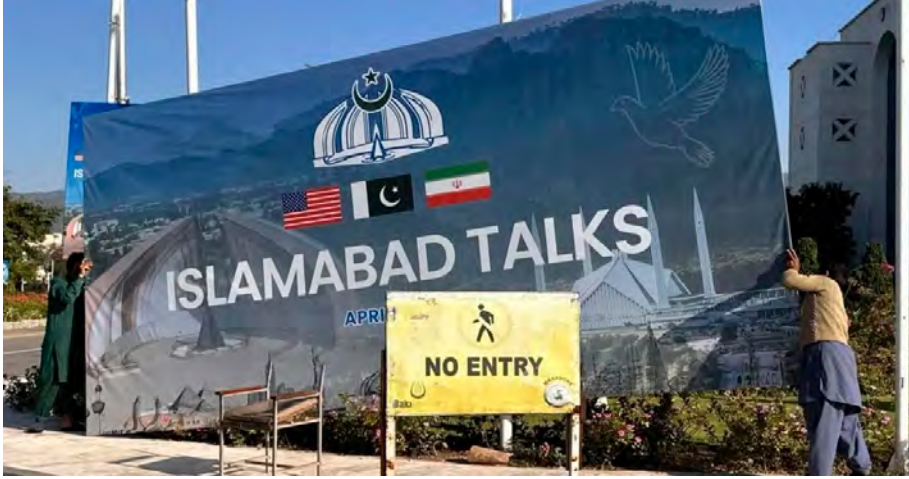
making machine. In reality, it's not that simple." Universal "is home to nine of the top 10 global recording artists of 2025", said Coatsworth but growth in the music streaming market had been slower than expected which matters "because Universal relies heavily on the likes of Spotify and Apple Music for royalty payments". Global music revenues have been growing year-on-year as streaming subscriptions rescued the industry from a period of piracy and financial decline. But a heated debate has been ongoing about how much these platforms pay out in royalties. The industry is also battling a rise in deepfakes - songs by

fraudsters impersonating its artists - which are created by AI and are flooding platforms. He blamed a variety of factors, including uncertainty around an 18% stake in Universal owned by Bolloré Group, the family conglomerate of billionaire Vincent Bolloré, as well as a recent decision to delay listing the company's shares on the New York Stock Exchange. Universal is currently listed in Amsterdam but Ackman has long campaigned for the company to float in the US. Ackman became a high-profile supporter of Donald Trump in July 2024 during his bid for a second term in the Oval Office. His intervention was seen as an important electoral endorsement of the now president from the business world. Adrian Cheesley, a former senior vice president at Universal, said the company would be the only music major to be listed on the S&P 500 stock market index in the US if the move went ahead. Commenting on Ackman's motives, Cheesley told BBC Radio 4's Today Programme he believed the billionaire investor was happy with the

current management. "I think this is about financial engineering, I don't think it's gonna affect the day-to-day running of the business," he said. Universal's share price initially soared by nearly 30% after the offer emerged on Tuesday. By the afternoon, it was 10% ahead. How music businesses earn revenue has changed as listeners switched to the likes of TikTok and Instagram. In 2024 Universal threatened to pull its songs from TikTok, claiming the platform wasn't paying fair value for music, and it was also concerned about "protecting human artists from the harmful effects of AI, and online safety for TikTok's users". Coatsworth said this dispute, while now settled, points to broader concerns around getting paid by social media networks. Added to that, he said: "Cut-throat competition in the music business also doesn't help. Record labels must plough significant amounts into marketing to make their artists stand above the crowd, and that means Universal must constantly spend money to make money."

Trump says US to 'blockade' Strait of Hormuz after talks failed over Iran's 'nuclear ambitions'

US President Donald Trump's threat to blockade the Strait of Hormuz will only affect a small handful of vessels that are still navigating the waterway, shipping expert Lars Jensen says. "If this is actually done by the Americans, it will halt a very tiny trickle of vessels. In the greater scheme of things, it doesn't really change anything," he says. Jensen, chief executive of Vespucci Maritime, says Trump's threat of preventing safe passage for any ships paying tolls to Iran would also have little impact, as any company doing so would already face sanctions for paying the regime. "First of all, there's very few ships that pass. There's even fewer of those that pay, and those that pay will already be subject to American sanctions," he says. Most shipping companies will continue to wait and see if there is a tentative peace agreement and whether that might hold,



Jensen says, and if that occurs, a slow ramping up of shipping may resume. As for what it would take shipping lines to decide whether it was safe to transit the strait again, he says the honest answer from those firms would be that they don't know. "Because at the end of it, it boils down to trust: trust that any agreement between the US and Iranians will hold for a significant portion of time,

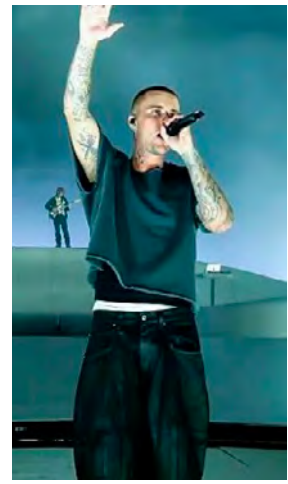
and that's a subjective feeling, there is nothing hard and tangible you can point to," he says. As we watch to see whether the next few days bring more talks or a resumption of the war, the US president has made various threats in a lengthy Truth Social post. We knew Iran's nuclear point was a huge point of contention and one that Trump has confirmed negotiators couldn't get past.

The future of the Strait of Hormuz is clearly an immediate concern, and the US is now threatening a blockade. Not only that, Trump is threatening any country who pays Iran "an illegal toll" to get through the vital shipping lane. There have been reports that some ships have passed through after paying a very expensive fee to Iran. Before these talks, he claimed there has been regime change in

Iran, with new and more "reasonable" leaders, but they are now "volatile, difficult, unpredictable people". But, he did acknowledge there had been points of agreement during these talks, and that's a sense we had here in Islamabad, as we heard technical experts became involved and talks continued into the early hours of the morning. Trump has also said the US delegation became "very friendly" and "respectful" of Iran's delegation, which would suggest some sort of working relationship difficult to imagine before this weekend. He had wondered how he might react to the failure to agree to come to an agreement in Islamabad... we can now see his first response. Across two lengthy social media posts, he says he will block the few ships that are currently making it through the Strait of Hormuz. "I have instructed our Navy to seek and interdict every vessel in International Waters that has

paid a toll to Iran. No one who pays an illegal toll will have safe passage on the high seas." The posts do not make it clear how "safe passage" will be denied, but it is worth remembering that the US has, in just the last few months, boarded vessels en route to or from Venezuela. Crucially, he also says "Other Countries will be involved with this Blockade", without specifying who. Iran's selective - but effective - blockade of one of the world's most important waterways has generally only been bypassed by ships either aligned to Iran, to nations Tehran considers friendly, or by vessels that are thought to have paid a toll, believed to be around \$2m (£1.5m). He also suggests that Iran has promised to open the Straits. Going by their public statements, they have repeatedly said the reverse, seeking formal recognition of what has become maybe their key strategic point of leverage.

Justin Bieber headlines Coachella with nostalgia-fuelled set



Justin Bieber made a nostalgia-fuelled return to the major stage as Coachella's much-anticipated headline act. The 32-year-old spent much of Saturday night's gig sitting in front of a laptop and singing to YouTube music videos of his older hits, such as Baby and Never say Never - delighting the crowd in an apparent tribute to the platform on which he was discovered. He also played some of the home videos that had brought him to the industry's attention aged 12, pulling them up on the big screen, and appeared to

interact with the live comments on the YouTube stream of his set. It marked the star's biggest live show in four years, having cancelled his Justice world tour following health issues. He opened the gig alone on an otherwise empty stage, performing tracks from his 2025 albums Swag and Swag II - before telling the crowd he wanted to take them "on a journey" and reaching back into his archive. He repeatedly asked the audience: "How far back do you go?" Bieber also played the clip for which he most recently went viral - and which prompted speculation about his mental state - in which he confronted a photographer and said: "It's not clocking to you, I'm standing on business." Dressed in a hoodie and shorts on a stripped-back stage, Bieber was joined by musical guests including The Kid Laroi, Wizkid, Tems and Dijon. The star's wife Hailey Bieber was spotted in the crowd, alongside celebrity couple Timothée Chalamet and Kylie Jenner.

Voters in Hungary set to decide whether Viktor Orbán remains in power after 16 years



Tensions between Budapest and Kyiv were heightened earlier this year when oil stopped passing through a major pipeline to Hungary and Slovakia. Deliveries via the Druzhba pipeline came to a halt after the major oil hub at Brody in western Ukraine was damaged in a Russian attack on 27 January. The channel supplies oil from Russia to Hungary and Slovakia and runs across Ukraine. Kyiv says the damage is severe and that it does not have the resources to repair it quickly, but Orbán's government has accused it of stalling. The situation highlights Hungary and Slovakia's continued dependence on Russian oil. Ukraine has accepted "technical support" and funding from the EU to speed up the mends. The stand-off resulted in

Orbán vetoing a 90bn (£78bn) EU loan to Ukraine, holding up a crucial support package for the country. Even before the first reports suggesting possible Russian efforts to bolster Orbán's position, Ukraine had already become a central issue in Hungary's parliamentary election campaign, dominating government messaging. It argues the EU and Kyiv risk dragging Hungary into the war, and that only Orbán's Fidesz party can prevent it. The party has amplified the message using AI-generated campaign videos. Fidesz has previously mobilised perceptions of external threat during election periods - most notably migration in 2018 and the war in Ukraine in 2022 - and analysts say the current campaign shows similar patterns.

GERMANY'S FAR-RIGHT AFD ADOPTS 'RADICAL'

The far-right Alternative für Deutschland (AfD) party is riding high in the opinion polls in the eastern German state of Saxony-Anhalt and could win an outright majority in regional elections there in September. It would be the first time a far-right party has held power in a German state since World War Two. This weekend the AfD officially adopted what has been described as a "radical" and pro-ethnic German government programme for Saxony-Anhalt at a party conference in the central city of Magdeburg. The AfD's leading candidate in the state, Ulrich Siegmund, a TikTok star who was given a standing ovation by the delegates, said it was an historic moment, not just for Saxony-Anhalt. "The whole of Germany is watching this



historic election," he told the conference. "Parts of Europe are watching this historic election, because from here, finally, the political turnaround can also happen here in Germany." He said his party had the courage to speak out about what was going wrong in Germany, "that we don't feel safe anymore, that we scarcely feel at home anymore, that we don't recognise our homeland anymore".

After Iran talks falter, the big question is 'what happens next?'

Twenty-one hours was not enough to end 47 years of hostility between Iran and the US. The historic high-level talks in Islamabad, during a pause in weeks of grievous war, were always unlikely to end any other way. Calling this marathon negotiating session a failure belies the scale of the challenge in narrowing wide gaps on complex issues ranging from age-old suspicion about Iran's nuclear programme to new challenges this war has thrown up - most of all Iran's control of the strategic Strait of Hormuz, whose closure is causing economic shocks worldwide. To do a deal, they also needed to overcome a deep chasm of distrust. A day ago, it wasn't even certain the two sides would meet, and even more, sit down in the same room. A long-



standing political taboo was broken. The urgent question now is: what happens next? What happens to the contested two-week ceasefire which pulled the world back from US President Donald Trump's alarming threat to destroy a "whole civilisation" in Iran? Would the US president be

ready to send his negotiators back to the bargaining table? We're hearing reports from sources here in Islamabad that some conversations have continued after US Vice-President JD Vance boarded his plane at sunrise, declaring the US delegation had made their "final and best offer".

Will the US now escalate or negotiate? We still don't know enough about what happened behind tightly closed doors in a five-star hotel in leafy locked-down Islamabad during talks that went on long into the night. There are still few details on the disputes and discussion between the two sides, assisted by Pakistani mediators, the calls to and from experts, advisers, and, according to Vance, "dozens" of calls to Trump himself. The vice-president spoke of the "core goal" of the US during his brief dawn news conference. "We need to see an affirmative commitment that [Iran] will not seek a nuclear weapon and they will not seek the tools that would enable them to quickly achieve a nuclear weapon," he said.

Why this disillusioned Trump voter spends hours searching Epstein files

After Cayden McBride finishes class in Rome, Georgia, the 19-year-old goes home, opens his laptop, and starts searching. For the past few months, he has been spending hours at a time combing through the Jeffrey Epstein files on the US Department of Justice (DOJ) website and following others online who are doing the same. Flight logs. Transcripts. Images. Videos. The material released by the DOJ has given new insight into the crimes of the late convicted sex offender and into his high-profile connections. McBride believes the Epstein files still matter, even if the headlines have



moved on to the Iran war recently. "As a Christian, I don't believe anybody should endure what these women have been through," he says. "There is so much bad stuff in these files." McBride was a self-described "Trump guy" and "very anti-establishment".

He said he would always defend the US president in the belief that Donald Trump's Make America Great Again (Maga) movement stood for exposing corruption. But the DOJ's delay in releasing all the files, and the perceived lack of accountability afterwards,

has left him and many others disheartened with the movement, and especially with Pam Bondi, Trump's former attorney general. Bondi was removed from her post just last week, to be replaced, in the interim, by her deputy Todd Blanche. Trump has lauded Bondi for doing a "tremendous job" and Blanche denied reports that his predecessor's handling of the Epstein files had been a factor in her departure. But McBride hailed the changing of the guard, expressing hope that there could now be renewed focus on the Epstein issue. His wish was granted this week, from an unlikely quarter.

AT LEAST 30 FEARED DEAD IN CRUSH AT HAITIAN TOURIST SITE



At least 30 people are feared to have been killed in a stampede at a popular tourist site in Haiti on Saturday. The incident took place on Saturday during an annual Easter gathering at the Laferrière Citadelle, a Unesco World Heritage site, Jean Henri Petit, head of civil protection for Haiti's Nord department, said, warning the death toll could yet rise. Prime Minister Alix Didier Fils-Aimé said the incident occurred "during a tourist event attended by many young people" at the site, in the northern town of Milot. He said an investigation had been launched and "all relevant authorities" mobilised to support those affected. "The government sends its sincere condolences to the affected families," Fils-Aimé said in a statement. The site had been packed with students and visitors after the event - commemorating the 19th Century fortress's found-

ing - was advertised on social media, local media report, citing officials. The stampede was said to have started near the entrance to the site and was exacerbated by the onset of heavy rain. Haiti's Le Nouvelliste newspaper first reported the death toll, citing Petit. The government statement did not say how many had died. Citadelle Laferrière, also known as Citadelle Henry, was built by revolutionary Henri Christophe shortly after Haiti gained independence from France. The stronghold took more than a decade to construct and was a crucial part of a network of fortifications to protect the new Caribbean island nation against attacks. The site has since become a symbol of Haitian independence. The deadly stampede comes as Haiti grapples with widespread gang violence that has led to thousands being killed.

Manhattan prosecutor investigates abuse claims against congressman Eric Swalwell

The Manhattan District Attorney's Office says it has launched an investigation into sexual misconduct allegations against US Congressman Eric Swalwell. Four women have accused him of misconduct ranging from sexual harassment to rape, including an alleged incident in New York. Swalwell, a leading contender in California's governor race, denies the claims, vowing to defend himself with "facts". "We urge survivors and anyone with knowledge of these allegations to contact our Special Victims Division," said the New York City prosecutor's office. Representatives for

Swalwell - who was elected in 2012 to a district near San Francisco - did not immediately respond to the BBC's request for comment. In urging accusers to come forward, the district attorney's office said on Saturday: "Our specially trained prosecutors, investigators and counsellors are well-equipped to help you in a trauma-informed, survivor-centered manner." The investigation comes a day after Swalwell said the allegations were "false". "For nearly 20 years, I have served the public - as a prosecutor and a congressman, and have always protected women," the married father-of-three added.



IPL 2026: Salt, Patidar power-hitting help RCB post 240/4 against Mumbai Indians

Mumbai, April 12 : Phil Salt, Virat Kohli, and skipper Rajat Patidar scored contrasting half-centuries as defending champions Royal Challengers Bengaluru smashed 240/4 against Mumbai Indians in Match 20 of the Indian Premier League (IPL) 2026 at the Wankhede Stadium in Mumbai on Sunday. It was fireworks all around as Salt (78 off 36 balls) and Patidar (53 off 20) put on a brilliant display of power-hitting while Kohli struggled to a pedestrian 50 off 38 balls. After the Mumbai Indians had pulled things back, Tim David provided a late boost with a 16-ball 34 as RCB made the most of the batting-friendly conditions to post a challenging total, and set a record chase for five-time winners Mumbai Indians. Asked to bat first, Phil Salt came out with guns blazing as he and Virat Kohli raised 100 runs for the opening wicket stand. They scored 13 runs off Trent Boult's opening over, with Kohli blasting him for a six and Salt for a four. After steady scores off Hardik Pandya, Jasprit Bumrah, and Boult, Phil Salt welcomed Mitchell Santner by hammering a hat-trick of sixes (first a heave over deep square leg, the



next clubbed over wide long-on, and third smashed over deep square leg), followed by a four off his first four deliveries of the match, blasting 22 runs from the over. While Kohli scored at a sedate pace, Salt continued to operate in the third gear, hitting Mayank Markande for a hat-trick of boundaries as he raced to his fifty in 25 balls. A six to celebrate his fifty off Markande in the eighth over meant Salt motored to 61 off just 27 balls. He eventually fell to Shardul Thakur in the 11th over, hitting an easy catch straight to Pandya at extra cover. Salt scored 78 off 36

balls, blasting half a dozen fours and sixes on the way. But there was no respite for the Mumbai Indians as Rajat Patidar took over the role of power-hitter. Starting with a four off Thakur, Patidar smashed a hat-trick of sixes off Markande in the 12th over. He smashed a six and a couple of fours off Thakur as they scored 23 runs off the 13th over and struck a four and six off Boult in the 1th over as he threatened to smash the record for the fastest fifty in IPL history, reaching 44 off 11 balls. Meanwhile, Kohli struggled to a sluggish fifty off 37 balls before Patidar blazed to

his half-century from 16 balls, with a streaky four off Santner. Both Kohli and Patidar fell soon after completing their fifties, as the Mumbai Indians applied the brakes as the RCB fell from 185/1 to 194/3 within eight balls. Kohli ended his misery by holing out to Suryakumar Yadav at long-on off Pandya for 50 (38 balls, 5x4, 1x6) while Patidar fell to Santner, attempting to shank him over long-on but miscuing it to Tilak Varma. Patidar hammered four boundaries and five maximums in his 20-ball 53.

Things went a bit quiet after that, though Tim David blasted Pandya for a six off a free hit and helped them score fifty runs in the last five overs. David remained unbeaten on 34 off 16 balls, reached with a six off the last ball bowled by Boult, as RCB, who were threatening to go beyond 250 after reaching 115/0 at the halfway mark and 201/3 in 17.

Sanju Samson Breaks MS Dhoni's Record With 1st Ton For CSK, Joins KL Rahul In Super Elite IPL Club

Sanju Samson announced his arrival at Chennai Super Kings in style in his fourth match for the franchise in IPL 2026. Samson stayed unbeaten on 115* (56b, 15x4s, 4x6s) as the star became the first wicket-keeper to hit a century for Chennai Super Kings (CSK). He reached the triple-figure mark in 52 balls. He also broke MS Dhoni's record for the most runs in an innings by a designated CSK wicket-keeper in the IPL - 84 against Royal Challengers Bengaluru in 2019. Samson is also the second batter to score a century for three IPL franchises. He has scored centuries for Delhi Daredevils (now Delhi Capitals), Rajasthan Royals (RR) and CSK. KL Rahul (Punjab Kings, Lucknow Super Giants, DC) was the first to achieve the feat. Sanju Samson shed his indifferent start to IPL 2026 season with a blazing hundred and Ayush Mhatre offered another glimpse into



the future with a fluent half-century as Chennai Super Kings posted a competitive 212 for two against Delhi Capitals in Chennai on Saturday. His unbeaten 115 off 56 balls (15x4, 4x6) was the cornerstone of Chennai's one of better outings with the bat in this IPL. After being asked to bat first, the CSK man brought up his first substantial knock in a Yellow jersey, and was involved in an excellent stand with Mhatre for the second wicket - 113 runs in a little over 11 overs.

It was Samson's fourth IPL hundred, the first for CSK and the first in IPL 2026. A big score from Samson was essential for himself and CSK to restore the belief of 'Anbu-den' faithfuls in their team, and he did that on the night with a brilliant innings in front of home fans. It was the typical Samson innings. The Kerala batter had looked unsure of his feet and field placings in earlier matches this season, but on this instance a familiar Samson returned.

Ayush Mhatre Becomes First 'Retired Out' Batter Of IPL 2026 After Scoring 59 Off 36 Balls

Chennai Super Kings finally came into their own in IPL 2026 on Saturday, with Sanju Samson leading the charge. Samson made history by becoming the first batter in the history of the Indian Premier League (IPL) to score centuries for three different franchises after he brought up his maiden hundred in Chennai Super Kings (CSK) colours against Delhi Capitals (DC) at the Chepauk Stadium. During the clash at Chepauk, a wounded Samson, following three poor outings, roared back into form with an unbeaten 115* off 56 balls, which included 11 fours and four sixes, at a strike rate of 205.36. Out of his four IPL hundreds, Sanju has scored two for Rajasthan Royals (in the 2019 and 2021 seasons) and



one for Delhi Capitals (in the 2017 season). He later added a 113-run stand with Ayush Mhatre (59 off 36 balls, with three fours and four sixes), while a fiery cameo from Shivam Dube (20* off 10 balls, with two fours and a six) powered CSK to 212/2 in 20 overs.

DC skipper Axar Patel (1/39) was among the wickets. Interestingly, Mhatre was retired out after the third ball of the 18th over, becoming the first batter to be retired out in this IPL. The internet reacted strongly to the decision. Ayush Mhatre is a better hit-

ter than Shivam Dube and retiring Ayush out was a bad move. Samson also completed 400 sixes in T20 cricket, becoming the fourth Indian to reach the milestone after Rohit Sharma (554), Virat Kohli (441), and Suryakumar Yadav (442). He now has 401 sixes in the shortest format of the game. The 113-run partnership between Samson and half-centurion Ayush Mhatre is the second-highest for CSK against DC for any wicket in IPL history, behind the 141 runs added by Devon Conway and Ruturaj Gaikwad for the first wicket in Delhi in 2023. Sanju was sensational against both pace and spin, but he showed a particular liking for the pacers, scoring 84 runs off 39 balls at a strike rate of 215.4, with 11 fours and three sixes.

SARA TENDULKAR IN THE STANDS DURING LSG VS GT IPL 2026 MATCH

There was no shortage of support for Lucknow Super Giants in their IPL 2026 match against Gujarat Titans at the Ekana Cricket Stadium on Sunday. Though LSG lost the match, the team can vouch for the fact that they will never be short of backing at the venue. Sachin Tendulkar's daughter Sara, an entrepreneur, was present at the stadium. Sachin's son Arjun is part of the LSG squad. A sensational four-wicket haul by Prasad Krishna and fifties from skipper Shubman Gill and Jos Buttler helped Gujarat Titans (GT) to a seven-wicket win over Lucknow Super Giants (LSG) in their Indian Premier League (IPL) clash on Sunday. GT are placed fifth with two wins and two losses,



collecting four points. LSG have slipped to sixth spot with an identical win-loss record. Put in to bat first, LSG scored 164/8, with only Aiden Markram (30 off 21 balls, with five fours and a six) crossing the 20-run mark, while Krishna picked up 4/28 in his spell. During the chase, fifties from Gill (56 off 40 balls, with

six fours and a six) and Buttler (60 off 37 balls, with 11 fours) helped GT reach the target comfortably, with seven wickets in hand and eight balls to spare. Sai Sudharsan got GT off to a solid start, hitting two fours off Mohammed Shami in the first over. He and skipper Shubman Gill played cau-

tiously until the fifth over, when Gill smashed Shami for 4, 6, 4 and 4 to pick up 20 runs. Digvesh Rathi, however, pulled things back for LSG by dismissing Sai Sudharsan for a 14-ball 15 (three fours) off his first delivery. GT were 45/1 in 5.1 overs. Courtesy of a back-foot punch from Jos Buttler, GT brought up the 50-run mark in 5.5 overs. Buttler and Gill then collected plenty of runs against left-arm spinner George Linde, taking 21 runs off his first two overs, with both batters sharing the spoils. At the halfway stage, GT were well placed at 86/1, with Buttler (22*) and Gill (48*) unbeaten. Gill, who had also completed 4,000 IPL runs, brought up his second successive fifty in 34 balls, hitting six fours and a six.

AUSTRALIAN TEENAGER GOUT FASTER THAN BOLT AT 18

Eighteen-year-old Australian Gout Gout ran 200m faster than sprinting great Usain Bolt managed by the same age as he raced to a national title on Sunday. The teenager clocked a superb time of 19.67 seconds to set a world under-20 record. It was the first time that Gout had gone under the 20-second mark legally, after a wind-assisted 19.84 last season, and is the leading time in the world this year. Gout previously had the quickest-ever time by a 16-year-old, setting a national record of 20.06 when he burst on to the scene in 2024. Sunday's mark in Sydney put him ahead of Jamaican eight-time Olympic champion Bolt's time of 19.93 back in 2004. Bolt was aged 17 when setting what was then a world junior record and never bettered that time as a teenager, before setting a string of senior world records later in his career. United States sprinter Erriyon Knighton's 19.49 run in 2022 remains the fastest time by an U20 athlete, though it was not ratified as a world U20 record. Knighton was nevertheless the holder of the U20 record with an official time of 19.69, set in June 2022, until Gout went quicker. Aidan Murphy, who was second to Gout on



Sunday, also beat the 20-second mark with a time of 19.88. "This is what I've been waiting for," said Gout, who was born in Queensland to parents from South Sudan.

It's Carlos Alcaraz vs Jannik Sinner Again In Monte Carlo Masters Final

Carlos Alcaraz and Jannik Sinner will renew their "Sincaraz" rivalry when they meet in the Monte Carlo Masters final on Sunday with the No. 1 ranking at stake. Four-time Grand Slam champion Sinner will reclaim the top spot if he beats seven-time major winner Alcaraz, the Monte Carlo defending champion. Sinner reached his first Monte Carlo final by beating Alexander Zverev 6-1, 6-4 an eighth straight time on Saturday. In his semifinal, Alcaraz eliminated home hope Valentin Vacherot 6-4, 6-4, concluding with a sublime drop shot. Alcaraz leads their head-to-head 10-6 going into their ninth final.



Both players are bidding for a 27th career title. Sinner swept Indian Wells and Miami and became only the fourth man to reach the final at the first three Masters tournaments of the season, matching Roger

Federer (2006), Rafael Nadal (2011) and Novak Djokovic (2015). Alcaraz's two titles this year include the Australian Open, where he downed Djokovic and became the youngest man ever to win all four tennis majors.

PROGRAIS ANNOUNCES RETIREMENT FOLLOWING BENN LOSS



=Former world champion Prograis has announced his retirement at the age of 37. The two-time super-lightweight world champion was beaten convincingly by Conor Benn at Tottenham Hotspur Stadium on Saturday night and then revealed the fight would be his last. "Going in, I knew I was going to retire," the American told Ring Magazine. "This is my last fight. I knew this months ago - I just didn't tell anybody but I was terrified going into this. "It's a great fight to be my last against someone like Conor Benn, someone that was strong - an arena like this with 70,000 in a stadium. I couldn't ask for

a better going away party, perfect end to my story." There were reports circulating prior to the fight that Prograis was hurt, which he confirmed following the defeat, saying he thought about pulling out as little as 24 hours prior to the bout. He added: "The rumours about me being hurt were true. I wanted to pull out of this fight so bad a month ago but kept pushing. I was terrified and thinking about pulling out even yesterday." Prograis retires with a 30-4 record, with 24 victories by knockout. He held the WBA super-lightweight title in 2019, and WBC super-lightweight crown from 2022 to 2023.

Landmark Moment In Bundesliga: Union Berlin Appoint Female Head Coach Marie-Louise Eta For Men's Team

A tectonic shift has taken place in European football, as Bundesliga club Union Berlin has decided to appoint Marie-Louise Eta as manager for the remainder of the season. Eta's appointment was confirmed by the German club following the departure of Steffen Baumgart. Though there is no confirmation of Eta being given a long-term role yet, the management's decision to bank on a female coach to help them stay in the German top division speaks volumes about the belief they have in her. While it is the first time that

a female coach will take over a men's team in Europe's top five leagues, Eta is not an unknown figure in European football. The 34-year-old is a Champions League winner as a player with Turbine Potsdam in 2010, and she also won three consecutive Bundesliga titles from 2009 to 2011.

A veteran of German football, Eta has spent years refining her tactical philosophy away from the limelight. She did not arrive at this position by chance, but has earned it through meticulous work within the German youth national

setups and as a trusted assistant at Union. It was in 2019 that she first took up a coaching role with the Germany U19 women's team, and she also worked with the U17 and U15 teams before landing the top job at Union Berlin.

Challenges Ahead

Placed 11th in the Bundesliga standings, Union Berlin find themselves in a tricky position. The identity that defined their rise to the Champions League has been tested to the core this season. Eta's task is not just to help the club maintain its position in

the table, but also to strengthen its push for a top-half finish. With no transfer window to rely on, Eta must find a way to galvanise a squad that has lost its clinical edge and restore the defensive solidity that once made them the league's most feared underdogs. Whether Eta remains in the post beyond June is almost secondary to what has already been achieved. By stepping into the technical area as the person in charge, she has provided hope to aspiring coaches everywhere, regardless of gender.

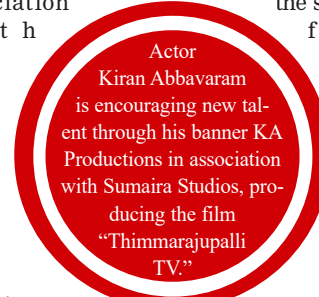
