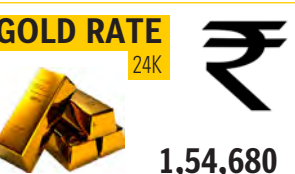

AMIT SHAH PROMISES POLITICAL SOLUTION FOR NORTH BENGAL HILLS

Kolkata TSIT: Union home minister Amit Shah stated that if the Bharatiya Janata Party comes to power in the upcoming West Bengal Assembly Elections, it will work towards a lasting political resolution for the hill regions of Darjeeling, Kurseong, and Kalimpong without separating them from the state. Addressing a public rally in Gangarampur in West Dinajpur district, Shah said the proposed solution would address the long-standing demands of the Gorkha community while keeping the hills within West Bengal.

2,926 CANDIDATES IN FRAY FOR BENGAL POLLS

KOLKATA (TSIT): A total of 2,926 candidates remain in the fray for the upcoming West Bengal assembly elections following the completion of the nomination withdrawal process, the Election Commission said on Tuesday. According to an official press note issued by the poll panel, 1,478 candidates will contest in 152 constituencies in the first phase, while 1,448 candidates are in the race for 142 constituencies going to polls in the second phase. The last date for filing nominations for the second phase was April 9, with scrutiny held on April 10 and withdrawals permitted till April 13.

CM Revanth seeks pro-rata seat increase, flags injustice to South

Hyderabad (TSIT): Telangana Chief Minister A. Revanth Reddy on Tuesday called for a pro-rata approach in the proposed increase of Assembly and Parliament seats, warning that the current formula could lead to injustice for Southern states. Speaking at the 135th birth anniversary celebrations of Dr. B. R. Ambedkar, the Chief Minister expressed concern that a uniform 50% increase in seats would adversely affect representation, particularly for women, SCs, and STs in the South. Alleging that the Bharatiya Janata Party is attempting to reduce the political representation of Southern states through delimitation, he called for a united and sustained struggle to protect federal balance.

Highlighting the government's focus on social justice, Revanth Reddy said initiatives aimed at Dalit empowerment and welfare are being implemented across sectors. He criticised the previous Bharat Rashtra Samithi regime, alleging it failed to honour Dr. Ambedkar during its tenure. He also took a swipe at former Chief Minister K. Chandrashekar Rao, stating



that his absence from Assembly sessions reflected disregard for democratic institutions.

The Chief Minister urged Dalit communities to support inclusive governance and reject divisive politics,

highlighting schemes such as Indiramma housing, enhanced hostel diet charges, and the establishment of Young India Integrated Schools and Telangana Public Schools.

Describing Mahatma Gandhi and Dr. Ambedkar as the "two eyes of the nation," he said their ideals continue to guide governance and reaffirmed the government's commitment to democracy, social justice, and inclusive development.

China warns US against interference as Hormuz blockade tensions escalate



Beijing, Apr 14 (TSIT): China has issued a strong warning to the United States over its decision to impose a blockade in the Strait of Hormuz, urging Washington not to interfere in Beijing's trade and energy ties with Iran. Chinese Defence Minister Dong Jun on Monday said that China would continue to honour its agreements with Tehran, asserting that Chinese vessels would keep operating in the region despite escalating tensions.

"Our ships are moving in and out of the waters of the

Strait of Hormuz. We have trade and energy agreements with Iran. We will respect and honour those agreements and expect others not to interfere in our affairs," he said.

He also maintained that Iran controls the strait and that it remains open for Chinese shipping.

The warning comes after the United States Central Command enforced a naval blockade, leading to disruptions in maritime movement. At least two oil and chemical tankers were

reportedly forced to turn back, including a vessel bound for China that reversed course shortly after the blockade took effect.

The Strait of Hormuz remains a critical energy corridor for China, supplying nearly 40 per cent of its oil and around 30 per cent of its LNG requirements. Any disruption in the region has significant implications for global energy markets.

US President Donald Trump announced that vessels entering or leaving Iranian ports would be stopped, warning that any Iranian naval craft approaching US ships would be "eliminated."

CENTCOM stated that the blockade would be enforced impartially on vessels of all nations operating in and around Iranian ports, including those along the Arabian Gulf and Gulf of Oman. The development follows the collapse of recent talks between the US and Iran, which were aimed at reaching a broad agreement after a temporary ceasefire, further heightening tensions in the region.

Centre tables Constitution Amendment Bill to expand Lok Sabha to 850 seats



New Delhi (TSIT): The Union government has proposed increasing the strength of the Lok Sabha from 543 to 850 members through The Constitution (One Hundred and Thirty First Amendment) Bill, 2026, to be taken up during a special session of Parliament on April 16 and 17. Under the proposed amendment to Article 81, a maximum of 815 members will be chosen from states, with not more than 35 members to be chosen from Union Territories (UT). The Bill also proposes amending Article 82, which currently governs the readjustment of parliamentary constituencies following each Census. The proposed amendment seeks to delete the existing proviso mandating that the next delimitation exercise be carried out based on the first Census conducted after 2026, thereby allowing delimitation to proceed before the 2026-27 Census is completed. Alongside the Constitution Amendment Bill, the Centre is also moving the Delimitation Bill, 2026, to repeal and replace the Delimitation Act, 2002.

AP becomes India's first quantum technology hub: CM Naidu



Amaravati (TSIT): Andhra Pradesh has emerged as India's first quantum technology hub with the inauguration of open-access quantum reference facilities by Chief Minister N. Chandrababu Naidu. The Chief Minister inaugurated the Amaravati Quantum Reference Facility-1 at SRM University AP and virtually launched Facility-2 at Medha Towers, marking a major step in the state's technological advancement. The launch coincided with World Quantum Day and the birth anniversary of Dr. B. R. Ambedkar.

Naidu described the initiative as a "once-in-a-generation opportunity," stating that the state is committed to developing indigenous quantum computing capabilities and assured full support for innovation and research. The newly launched sys-

tems, Amaravati Quantum 1S and 1Q, are designed as advanced hardware test beds for validation, benchmarking, and real-time performance testing. While the SRM University facility will cater to academic and research needs, the Medha Towers centre will focus on industry applications.

The project has been developed with support from premier institutions such as TIFR, IISc Bengaluru, and DRDO, along with industry partners, with a strong emphasis on domestic supply chains. Highlighting the future potential of quantum technology, the Chief Minister said it could revolutionize sectors like healthcare, agriculture, and advanced research while generating employment in areas such as hardware engineering, software development, and cryogenics.

CM REVANTH WRITES TO PM MODI, Seeks All-Party Meet on Delimitation; Proposes 'Hybrid Model'

Hyderabad, TSIT: Telangana Chief Minister A. Revanth Reddy has written to Prime Minister Narendra Modi, urging the Union Government to hold wide-ranging consultations and convene an all-party meeting on the proposed delimitation of parliamentary constituencies. In his letter, the Chief Minister stressed that decisions of such national importance must be taken only after building broad consensus among all states and political parties, particularly to ensure fairness for southern states.

He pointed out that delimitation, women's reservation, and the proposed increase in Lok Sabha seats are being wrongly viewed as inter-linked issues, creating confusion



among the public. He clarified that these should be treated separately. Revanth Reddy reaffirmed support for the Women's Reservation Bill and called for the immediate implementation of 33% reservation for women in the existing 543 Lok

Sabha seats, along with similar provisions in State Assemblies. On delimitation, he noted that previous exercises were conducted by redrawing constituency boundaries without increasing the total number of seats, suggesting that a similar approach could be followed now. Expressing concern over proposals to expand Lok Sabha seats to around 850, he warned that a purely population-based (pro-rata) model would disproportionately disadvantage southern states like Telangana, Tamil Nadu, Karnataka, Andhra Pradesh, Kerala, and Puducherry—states that have achieved better population control and human development outcomes. He also highlighted existing disparities in

central fund allocations, stating that increasing seats on a population basis could further deepen political and economic imbalances. As an alternative, the Chief Minister proposed a "Hybrid Model", under which: 50% of additional seats would be allocated based on population, and 50% based on economic contribution and development indicators. He said this balanced approach would ensure fair representation while safeguarding the interests of progressive states. Calling for inclusive dialogue, Revanth Reddy urged the Prime Minister to initiate discussions to arrive at a solution that upholds federal balance, unity, and democratic fairness.

'Final warning...': Stalin threatens massive agitation over delimitation

Chennai (TSIT): Issuing a direct warning to Prime Minister Narendra Modi, Tamil Nadu Chief Minister M. K. Stalin cautioned that the state will launch a massive agitation if the Union government proceeds with the proposed delimitation exercise that could reduce its parliamentary representation.

In a strongly worded video message posted on X, Stalin questioned the rationale behind the move, particularly in the context of southern states like Tamil Nadu that have successfully implemented population control measures.



"Is delimitation a punishment for Tamil Nadu, which succeeded in population control?" he asked, warning that the state would resist what he described as an impending "injustice at its doorstep". Stalin alleged that the Centre is attempting to push ahead

with the delimitation process without consulting states, calling it a unilateral decision that undermines the federal structure. He stressed that Tamil Nadu would not remain passive if its political voice is weakened. "If the Union government proceeds with this exercise, Tamil Nadu will undertake a massive protest," he said, adding that the issue goes beyond electoral considerations. "For us, elections and governance are secondary -- policy and self-respect come first," Stalin asserted, underlining the emotional and political weight of the issue.

Education Central to Ambedkar's Vision

Hyderabad TSIT: Telangana Social Welfare Minister Adluri Laxman Kumar said the State government is advancing with a strong focus on education in line with the ideals of B. R. Ambedkar, emphasizing that education is the key to addressing social inequalities. Minister paid floral tributes to Ambedkar on his 135th birth anniversary in the presence of Chief Minister A.Revanth Reddy in Hyderabad. Addressing a gathering later, he said the people's government is committed to social justice and inclusive development. He highlighted the government's decision to establish Young India Integrated Schools in every Assembly



constituency, each spanning about 25 acres with an estimated cost of Rs. 200 crore, to ensure quality education for Dalit, Tribal, BC and Minority students. These institutions, he said, will serve as centres for holistic education and per-

sonality development. The Minister noted that Ambedkar's vision of development through smaller states was reflected in the formation of Telangana. He added that the government is taking concrete steps to implement the

Constitution effectively. He further stated that welfare measures such as a 40% increase in diet charges and a 200% rise in cosmetic charges for students are improving living standards and educational outcomes.

Union minister calls Telangana CM's 'hybrid model' anti-Ambedkar

Hyderabad (TSIT): Union Coal and Mines Minister G Kishan Reddy has ridiculed Telangana Chief Minister A Revanth Reddy's 'hybrid model' proposed for increasing the number of Lok Sabha seats, as being totally against Bharat Ratna Dr BR Ambedkar's ideology. Addressing the media after an all-party meeting held in Delhi on women's reservation in the legislative bodies on Tuesday, April 14, Kishan Reddy said that if the seats in Parliament are increased based on the economic index and the Gross State Domestic Product (GSDP), Gujarat will get the maximum number of seats. "Should we allow that to happen?" he asked, describing Revanth Reddy as only coming next to Leader of Opposition



Rahul Gandhi in terms of intellectuality. Accusing Revanth Reddy of attempting to create a north-south divide, he sought answers from Rahul Gandhi on the former's views on delimitation. He said that currently, only the caste and population census is being conducted, which could take time to be tabled in Parliament. This would be followed by the constitution of a delimitation committee to study the modal-

ties of the exercise. "The delimitation committee will visit all Lok Sabha segments across the country, meet representatives of various political parties, and seek inputs from civil society and the media before submitting its report," he said, estimating that the process would take between 2.5 and 3 years. He added that after the 2029 Lok Sabha elections, reservations for women, Scheduled Castes, and Scheduled Tribes would be determined based on the final census data and the committee's report. He said that a major challenge in the delimitation exercise would be identifying BC-reserved constituencies, and stressed that all stakeholders must approach the issue in an apolitical manner.

Telangana transport minister appeals to RTC employees to withdraw strike call

Hyderabad, April 14 : Telangana Minister for Transport Ponnampati Prabhakar on Tuesday urged the TGSRTC employees to withdraw their decision to go on strike, reiterating that the government is always ready to resolve employee issues amicably through dialogue. The minister said in a statement that the matter relating to the merger of Telangana State Road Transport Corporation (TGSRTC) with the government and issues related to trade unions fall within the government's jurisdiction. He, however, affirmed that the government is prepared to discuss all other employee-related issues, excluding these two specific topics. The minister clarified that their doors remain open at all times to listen to the grievances of the employees. His appeal came a day after the Joint Action



Committee (JAC) of TGSRTC employees announced that the employees would go on indefinite strike from April 22 to press for their demands. The minister noted that a 2.1 per cent Dearness Allowance (DA) was recently implemented for RTC employees, and currently, there are no pending DA arrears. He also mentioned that the government is actively considering the issue of the Pay Revision Commission (PRC) for RTC employees. The minister declared that the govern-

ment remains fully committed to the welfare of its employees. He recalled that the previous government had constituted a committee regarding the merger of RTC employees on September 9, 2023, hastily bringing the merger issue to the forefront just 10 days prior to the announcement of the election schedule. He stated that within just 10 days of the committee's formation, the election schedule was released on October 10, 2023; elections were held on November 30; and the results were declared on December 3. He explained that although the 'people's government' was formed on December 7, 2023, the election code remained in force for an extended period - until June 6 - as the Lok Sabha election schedule was announced on March 16, 2024, before the government could fully settle down.

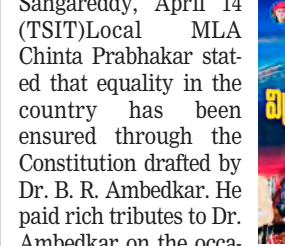

RS. 1.6 CRORE DRINKING WATER PROJECT INAUGURATED IN NAGARAM VILLAGE

Amalapuram, April 14: A comprehensive protected drinking water project, developed at a cost of Rs.1.6 crore under CSR funds of GAIL (India) Limited, was inaugurated and dedicated to the public in Nagaram village by Amalapuram MP Ganti Harish Madhur and P. Gannavaram MLA Giddi Satyanarayana.

Biomarker Testing Launched in Uddanam to Detect Kidney Disease Risk

Visakhapatnam: In a major step to tackle the chronic kidney disease crisis in Uddanam, an advanced research initiative introducing biomarker testing has been launched for early detection and prevention.

For the first time in the region, blood and urine samples are being analyzed using biomarker-based techniques to identify individuals at risk of developing kidney disease within the next three to four years. Around 1,500 samples have already been collected, along with detailed data on family history and lifestyle patterns.

A state-of-the-art laboratory has been set up at King George Hospital, equipped with advanced analytical systems, centrifuges, and secure storage



facilities adhering to strict biosafety standards.

The project, supported by the Indian Council of Medical Research with a grant of Rs.6.2 crore, will run for three years. In addition to biomarker testing, researchers will also conduct RNA sequencing-based genetic studies to better understand the root causes of the disease.

The study is being carried out under the mentorship of Tatapudi Raviraj,

with G. Prasad leading the research team.

The initiative was recently reviewed by Andhra Pradesh Health Minister Satyakumar Yadav, who directed officials to expedite the project and assured full government support.

Officials said the findings will help in early identification of high-risk individuals, enabling timely medical intervention and reducing the burden of kidney disease in

Specialised headache clinic launched at CARE Hospitals Vizag



Visakhapatnam, April 14: CARE Hospitals has launched a dedicated Headache Clinic to address the rising burden of chronic and recurrent headaches, particularly among individuals aged 25-45 years.

Doctors noted that headaches, often dismissed as minor ailments, are increasingly linked to stress, prolonged screen exposure, and irregular lifestyles. Despite migraine affecting nearly one in seven people globally, a significant number of cases remain undiagnosed, with many relying on self-medication instead of seeking medical advice. The newly established clinic adopts a multidisciplinary approach, integrating neurology, neurosurgery, and interventional radiology to ensure precise diagnosis and long-term management. It offers struc-

tured evaluation methods, including pattern mapping, trigger identification, and personalised treatment protocols, moving beyond temporary pain relief.

Specialists highlighted that certain headache conditions can now be treated through minimally invasive, image-guided procedures, reducing dependence on long-term medication and enabling faster recovery.

Experts cautioned that symptoms such as vomiting, vision disturbances, or neurological issues accompanying headaches should not be ignored and require immediate medical evaluation. Hospital officials said the initiative aims to improve awareness, encourage early diagnosis, and provide evidence-based treatment, ultimately enhancing patient outcomes and quality of life.

Founded in 1979 by Balasaheb Deoras, Sewa Bharti has grown into a major non-governmental organisation focused on empowering disadvantaged sections of society. Its work spans across



education, healthcare, and skill development, particularly in underserved areas known as Sewa Bastis.

The organisation runs kindergartens, student hostels, and coaching centres to support education among economically weaker groups. In the healthcare sector, it operates mobile clinics and organises medical camps to reach those with limited access to services. Additionally, Sewa Bharti promotes self-reliance by

offering vocational training programs, including typing and shorthand courses for youth. With a strong emphasis on women's empowerment, the NGO also establishes sewing and tailoring centres to help women gain financial independence. Functioning through an extensive volunteer network, Sewa Bharti is part of the larger Rashtriya Sewa Bharati framework, continuing its mission of grassroots-level social transformation.

Noida unrest 'well-planned conspiracy', 300 arrested; Pakistan link under probe: UP minister



Noida, Apr 14: Uttar Pradesh Labour Minister Anil Rajbhar on Monday termed the violence during workers' protests in Noida a "well-planned conspiracy," adding that agencies are probing a possible Pakistan link in light of recent terror-related arrests in the region.

The minister said preliminary findings suggest the unrest may have been aimed at disrupting law and order and development in the state. He noted that four suspected terrorists were recently arrested from Noida and Meerut, with alleged links to handlers based in Pakistan, strengthening suspicions of a broader conspiracy. Rajbhar's remarks came after protests by factory workers demanding a wage hike turned violent across several areas,

including Phase-2, Sector 60, Sector 62 and Sector 84. Incidents of arson, vandalism and stone-pelting were reported, with vehicles torched, property damaged and traffic severely affected.

Police deployed heavy force and used tear gas to disperse crowds and restore control. Authorities have arrested around 300 people in connection with the violence, while over 100 others have been detained for questioning. CCTV footage from factories is being scanned to identify those involved.

The minister further alleged that the unrest may have been intended to disrupt a programme of Chief Minister Yogi Adityanath in Muzaffarnagar, accusing "anti-national forces" of attempting to create instability.

Samrat Choudhary elected BJP legislative party leader, set to be next Bihar CM



Patna, April 14 : In a major political development, Samrat Choudhary has been elected as the leader of the BJP legislative party, paving the way for him to become the next Chief Minister of Bihar. The decision was taken during a crucial BJP legislative party meeting held on Tuesday at the party's state headquarters on Veer Chand Patel Path in Patna. The meeting was presided over by Union Minister Shivraj Singh Chouhan, who had been appointed as the central observer by the party leadership. Senior leaders, including BJP National President Nitin Nabin, B. L. Santosh, and Bhikhu Bhai Dalsaniya, were also present

during the meeting. Deputy Chief Minister Vijay Kumar Sinha proposed the name of Samrat Choudhary as the leader of the BJP legislative party leader and it was supported by former Deputy Chief Minister Renu Devi. With consensus achieved across the party, Samrat Choudhary is set to lead the BJP and the government of Bihar. This development signals the beginning of a new political chapter in Bihar, marking the transition from the era of Nitish Kumar to a new leadership under Samrat Choudhary. Earlier in the day, Nitish Kumar officially resigned as Chief Minister after chairing his final cabinet meeting.

'Modiji aapka swagat hai' echoes in Dehradun as people welcome PM



Dehradun, April 14 : Prime Minister Narendra Modi was warmly welcomed by an enthusiastic crowd during a roadshow in Dehradun on Tuesday, following his arrival in Uttarakhand to inaugurate the Delhi-Dehradun Economic Corridor. Large numbers of people gathered along the sides of the road, chanting phrases such as "Modiji aapka swagat hai," "Bharat Mata Ki Jai," and "Modi, Modi," while waving the Tricolour and the BJP flag.

Dressed in traditional attire from Uttarakhand, women and children also lined the route to greet the Prime Minister as his convoy passed by the excited crowd. Earlier,

PM Modi offered prayers at the Jai Maa Daat Kali Temple in Dehradun. During his visit, he was welcomed by children dressed in traditional attire who performed the Durga Devi Stotram. He also interacted with other devotees present at the temple. The Prime Minister also reviewed the Wildlife corridor on the elevated section of the Delhi-Dehradun Economic Corridor in Saharanpur.

During this, Union Highways and Transportation Minister Nitin Gadkari, UP Governor Anandiben Patel, UP Chief Minister Yogi Adityanath, and Deputy CMs Keshav Prasad Maurya and Brajesh

Pathak were also present.

An exhibition showcasing the construction procedure of the wildlife corridor was presented, and the officials briefed the Prime Minister about the project. PM Modi also held a roadshow along the Wildlife Corridor in Saharanpur. A large crowd gathered along the road to catch a glimpse of the Prime Minister as he waved back at them.

Many attendees wore costumes and performed traditional folk dances to welcome the Prime Minister.

Later, the Prime Minister will inaugurate the Delhi-Dehradun Economic Corridor at a public function in Dehradun and address the gathering on the occasion.

The 213 km long six-lane access-controlled Delhi-Dehradun Economic Corridor has been developed at a cost of over Rs 12,000 crore.

The corridor traverses through the states of Delhi, Uttar Pradesh and Uttarakhand, and will reduce travel time between Delhi and Dehradun from over six hours at present to around two and a half hours.

EC sets up dedicated helpline for West Bengal voters ahead of polls

Kolkata, Apr 13: In a move to ensure smooth and peaceful elections, the Election Commission of India has launched a dedicated toll-free helpline and email service for voters in West Bengal to report any law-and-order concerns directly.

Apart from the existing nationwide helpline (1950), a special number—18003450008—has been introduced specifically for the upcoming West Bengal Assembly elections. Voters can also lodge complaints via a dedicated email ID set up for the purpose.

The initiative is aimed at enabling citizens to promptly report incidents such as threats, intimidation, violence, or interference with polling agents.

State Chief Electoral Officer Manoj Agrawal said the Commission has already begun receiving complaints related to



law and order, prompting the need for a more direct and responsive communication channel. He assured that every

complaint would be investigated and appropriate action taken. Reaffirming its commitment

to free and fair elections, the Commission has already deployed central security forces across the state. These forces are conducting route marches in sensitive areas to build voter confidence ahead of polling.

Senior officials, including district magistrates, police superintendents, and force coordinators, have jointly appealed to citizens to participate in the voting process without fear. They have also issued strict warnings to potential troublemakers, stating that any attempt to disrupt polling—through booth capturing, intimidation, or harassment—will invite stringent legal action. Authorities emphasised that the elections will be conducted in a manner that is free from violence, coercion, inducement, and malpractice, ensuring that voters can exercise their democratic rights safely and confidently.

India's passenger vehicle sales jump 16 pc in March: Report

New Delhi, April 14 : Domestic passenger vehicle dispatches to dealers increased by 16 per cent (year-on-year) to 4,42,460 units in March, driven by improved demand and inventory build-up at dealerships, according to data released by the Society of Indian Automobile Manufacturers (SIAM) on Tuesday.

Passenger vehicle wholesales had stood at 3,81,358 units in March last year. Two-wheeler dispatches also recorded strong growth, increasing 19.3 per cent to 1,97,128 units last month



compared to 16,56,939 units in the corresponding period a year ago, the industry body said in a statement.

Similarly, three-wheeler dispatches rose 21.4 per cent year-on-year to 76,273 units

in March, up from 62,813 units in March 2025.

Moreover, domestic passenger vehicle dispatches from companies to dealers had risen 10.6 per cent year-on-year to 4,17,705 units in

February, reflecting continued positive market sentiment, according to data from Society of Indian Automobile Manufacturers.

The broader outlook for the passenger vehicle segment also remains positive, though growth is expected to moderate going ahead.

According to an earlier report, the industry is likely to clock wholesale volume growth of around 7-9 per cent in FY26, supported by strong festive demand, recent GST rate cuts and a steady pipeline of new model launches.

CBI arrests absconding kidnap accused, files chargesheet in Rs 23 crore cyber fraud case

New Delhi, Apr 13: The Central Bureau of Investigation (CBI) on Monday arrested a fugitive accused in a 2014 abduction case, tracking him down in Surat after years on the run.

The accused, Bhola Singh—also known by aliases Gautam Kumar and Amit Sharma—was apprehended from his hideout where he had been living under a false identity. The case, involving the abduction of two residents from Kolkata, was handed over to the CBI by a High Court. Officials said



Singh had been absconding since 2015 and is wanted in at least 11 cases registered by the Bihar Police, including charges of kidnapping, attempted murder, murder, and possession of illegal arms and explosives. He was located in Surat using forged documents and arrested during a coordinated operation. Following his arrest, Singh was produced before a local court to secure transit remand to Kolkata, where he will be presented before a court for custodial interrogation. In a separate development, the CBI has also filed a chargesheet in a major cyber fraud case involving the alleged cheating of a Delhi-based senior citizen of nearly Rs 23 crore.

Fresh clashes erupt in Noida as wage protests turn violent again

Noida, Apr 14: Fresh violence broke out in parts of Noida on Tuesday as workers protesting over low wages clashed with police, with incidents of stone-pelting reported from Sector 80 and adjoining areas. Police said the situation escalated after miscreants allegedly tried to take advantage of the protest, leading to clashes and forcing security personnel to disperse the crowd. Another incident was reported from Garhi Chaukhandi village in Sector 121, where protesters targeted a police vehicle despite heavy deployment. Earlier, workers had gathered peacefully, demanding a minimum monthly wage of Rs 20,000. However, tensions flared as protests intensified, with reports of vandalism and stone-pelting also emerging from residential areas where domestic workers were staging demonstrations. Workers from an industrial unit had also raised concerns over wage disparities, alleging that skilled and unskilled labourers were being paid similar allowances. Some claimed that employees were terminated within months and rehired to avoid benefit hikes, while others highlighted a drop in hourly wages after apprenticeship periods. The unrest, which entered its second day, saw participation from nearly 45,000 workers across multiple locations in the commissionerate on Monday. Violence had earlier been reported from Sector 63 and near industrial premises.

Tejashwi Yadav slams Bihar govt, alleges remote control rule and poor governance

Patna, Apr 13: Rashtriya Janata Dal (Tejashwi Yadav) leader Tejashwi Yadav launched a strong attack on the ruling BJP-JD(U) alliance in Bihar on Monday, alleging widespread misgovernance and claiming that the state is effectively being controlled "from Gujarat."

Speaking to IANS, Yadav accused the Bharatiya Janata Party and its ally Janata Dal (United) of failing to address Bihar's longstanding developmental challenges. He alleged that individuals aligned with the BJP were influencing the administration, including elements within the JD(U), contributing to the current law and order situa-

tion. He asserted that people were aware of the prevailing issues but would respond politically in due course.

Yadav further criticised the government's economic performance, claiming that Bihar's resources had been exhausted despite two decades of rule. He said the state continues to struggle with poverty, low per capita income, weak education and healthcare systems, and a lack of industrial growth.

He also dismissed political attention on ministerial visits to the Chief Minister's residence, stating that public concerns such as unemployment, inflation, migration, and agricultural dis-



stress were being ignored. According to him, gover-

nance priorities have shifted away from people's wel-

fare. The RJD leader alleged administrative stagnation, claiming that Cabinet meetings have not been held for months and that decision-making has slowed significantly. He also pointed to rising crime and corruption, along with unmet electoral promises.

Commenting on reported changes in political posters featuring Chief Minister Nitish Kumar, he made a brief remark suggesting ongoing internal shifts within the ruling setup.

Reiterating his "remote control" allegation, Yadav claimed that real power in Bihar does not rest within the state leadership and that decisions are influenced externally. He said

successive governments over the past 20 years have failed to deliver meaningful development.

Separately, he announced that the party's student wing has been renamed from Chhatra RJD (CRJD) to the Socialist Students Association of India (SSAI), citing compliance with a Supreme Court directive restricting political party activity in educational institutions.

On national politics, Yadav expressed confidence in West Bengal chief minister Mamata Banerjee, predicting her electoral success and stating that his party would extend support to the Trinamool Congress in the state.

How Netanyahu Is Fast Turning Into The Worst 'Deal' Trump Ever Made

On April 11 and 12, delegations from the United States and Iran held talks in Islamabad to discuss mutually acceptable terms amidst a two-week ceasefire. Late on April 12, US Vice President JD Vance, who led the US delegation, asserted that the talks had failed to yield an outcome, and US President Trump announced that the US Navy would "blockade" the Strait of Hormuz. Amidst uncertainty, two fundamental characteristics of the ceasefire still remain - neither Tehran nor Washington have ruled out further talks, and Iran is yet to resume missile/drone attacks at US bases in the Gulf (which keeps the US-Iran ceasefire technically intact). A third, more crucial, characteristic also remains intact: that Israel (which was not in the room in Islamabad) continues to significantly influence, if not upend, American diplomacy with Iran. Regardless of the substance, the Iranian delegation (led by Parliament Speaker Mohammed Bagher Ghalibaf) meeting JD Vance represented the highest level of direct US-Iran contact in 47 years. However, it became evident that while talks began on a positive trajectory, with technical teams, written exchanges, and structured discussions, the Iranians maintain that a call by Israeli Prime Minister Benjamin Netanyahu to VP Vance turned the US position more untenable in subsequent negotiations, which lasted for 21 hours overall. Israeli influence over US decision-making is old, as is its impact on broader US foreign policy. However, two elements are new: the first is the degree to which Israel has influenced Trump, and the second is the fresh challenges that this influence is facing.

Since 1985, the last five US Presidents prior to Donald Trump have overseen considerable consistency in American financial assistance to Israel, through a combination of economic and military aid. From Ronald Reagan to Barack Obama, this aid has remained between approximately \$2.8 billion and \$3.5 billion annually. By 2008, towards the end of George Bush's second term, American financial assistance to Israel became almost exclusively military. By 2012, under President Barack Obama, the US Congress legislated that it was US policy "to help the Government of Israel preserve its qualitative military edge". Functionally, this meant that no defence deal that the US would conclude with other states in the region could threaten Israel's QME. A prominent example of this policy is that Israel is the only country that operates the F-35s with specific customisations, while other Arab states continue to fail in their efforts to procure the world's most potent fighter jet. The cornerstone of this historically lopsided relationship has been the influence of the 'Israel Lobby', a diffuse but coherent political action group that has historically succeeded in directing US policy towards pro-Israel positions, even when not in the US national interest, as John Mearsheimer and Stephen Walt note in their 2007 book of the same name.

Palestine As An Outlier

However, neither domestic compulsions nor the institutional sustenance of US deference to Israel's security needs could prevent multiple US Presidents from keeping US policy on Palestine in line with international law, at least nominally, and account for the Arab interest. Among other things, this meant officially viewing Israeli settlements in the West Bank (and Gaza before 2005) as illegal, recognising Tel Aviv as Israel's capital (and not Jerusalem, as Israel had maintained since 1980), and not recognising Israel's rights over the Golan Heights in Syria, which the former had been occupying since the 1967 war. More importantly, successive US Presidents have not hesitated to criticise Israel. Ronald Reagan famously characterised Israel's massive - at the time unprecedented - bombardment of Beirut in 1982 as a "holocaust", forcing then Israeli PM Menachem Begin to change course (even as Israel continued its larger invasion of Lebanon).

Pakistan Has Already Got Its 'Prize', Even If The US-Iran Talks Collapsed

Only the eternal optimist or someone completely detached from reality could have expected the Islamabad talks between the US and Iran to lead to an actual peace deal. That the talks collapsed after marathon discussions doesn't come as a surprise. Even the 'event manager' - Pakistan - which was basking in its newfound glory as the global peacemaker, the saviour of the world, and centre of international diplomacy, had started to dampen its expectations. Mouthpieces of the regime had started spinning stories about how Pakistan had fulfilled its duty to the world by organising the talks between the two belligerents. They, however, insisted that the outcome of the parleys depended on the protagonists and not on Pakistan. Of course, had the talks succeeded, Pakistan would have taken the credit.

A Pros And Cons List

As far as Islamabad is concerned, it has already milked the event for whatever it was worth and did all the virtue-signalling possible to burnish its image in the comity of nations. It will now take stock of all its gains and the possible losses it might incur in the coming days, weeks and months because of the role it played as a broker.

On the plus side of Pakistan's balance sheet is the profile it believes it has built up for itself as the venue of the talks. While talks between the US and Iran have been held earlier in various cities - Geneva, Muscat, Doha - Pakistan presented the Islamabad talks as something epochal. The hype within Pakistan and its military - and state-controlled private media - was bigger than anything in the international media. The global media mentioned Pakistan, in most part, only as the location of the parleys. The stream of phone calls between Pakistan's (nominal) Prime Minister and global leaders was nothing extraordinary and was part and parcel of the kind of international diplomacy practised in fraught times. It in no



way signified Pakistan's centrality to any peace deal. Even so, Islamabad was satisfied that after decades, the country's name was not being taken in a negative context - war, terrorism, double-dealing, instability, insolvency, military rule, stolen elections ... Well, it's a long list.

The Real 'Medal Of Honour'

Pakistan can also claim to have won the goodwill of the Trump administration. After all, it went out of its way in trying to bail out Trump by pushing for a ceasefire. Not only did the Pakistanis copy-paste messages handed down to them from Americans, but they also tried to align Turkey, Egypt and even Saudi Arabia behind its efforts to push for peace talks. This drew appreciation from the US Vice-President, who thanked them quite profusely. For the Pakistanis, who have done everything possible to woo Trump & Co - from nominating him for the Nobel Peace Prize to signing crypto and mining deals with his buddies, and even entering into an agreement on the Roosevelt hotel in New

York City - getting a pat on the head from the Americans will be worn as a medal of honour.

More substantively, the Pakistanis seem to have managed the Saudis rather well. Not only did they avoid jumping into the fray against Iran in defence of Riyadh, but they also managed to convince the Saudis that they were doing this to protect the interests of the Kingdom. In doing so, they even managed to ingratiate themselves with the Saudis to a point that there were reports that Pakistan would be given a deposit of \$5 billion by the Kingdom to build up its foreign exchange reserves, which were depleted after the UAE asked them to pay back their money. There are also reports that Qatar will aid Pakistan financially and that the Saudis could make some big investments in Pakistan.

A Bigger Role In Middle East?

In other words, the Pakistanis believe that, in tangible terms, they have managed to make some much-needed money by playing peacemaker. There is also an expectation that Pakistan has positioned itself to play

a significant role as a net security provider and security guarantor in the Middle East. This would open up enormous diplomatic, political, economic and strategic opportunities for the country. Domestically, the regime has cemented its position by creating an impression that the opposition can forget about any pressure from outside over the incarcerated Imran Khan.

The 'Peacemaker's' Perils

There is, however, also a downside to the role Pakistan has played, especially since the talks collapsed and there is a real possibility of hostilities restarting. Worse, the second round of war could be far more destructive and could pull Pakistan into the vortex. Under its mutual defence agreement with the Saudis, Pakistan is reported to have dispatched thousands of soldiers and some fighter aircraft to the Kingdom, presumably to support it against Iranian attacks if hostilities resume. If Pakistan gets dragged into the war, then Iran could be forced to target infrastructure in Pakistan.

WE ARE PEOPLE WITH ACCESS, OUR SORROW IS ALSO VIP

Whether it's a house groundbreaking ceremony or a shop inauguration, the joys of a wedding or the grief of a loved one's death—posting pictures of prominent politicians and officials everywhere is no longer a display of "respect," but a display of influence and influence. This gives rise to a mentality where a person's true identity is determined not by their actions but by their "connections." Once, the walls of homes were adorned with pictures of gods and goddesses, instilling faith. Then came family photos, conveying a sense of belonging. Today, those same walls are filled with photographs taken with politicians and officials, conveying neither faith nor belonging—simply a message: "We are people with influence." This "access" is no longer a privilege, but a certificate of social status. This phenomenon isn't confined to walls; it has penetrated deep into our psyche. Today, individuals identify themselves less by their names and more by their "connections." They rarely mention their qualities, their work, or their personality in their introductions, but instead take pride in revealing which leader or official they are close to. This trend has reached a dangerous point, where self-respect has been replaced by veiled arrogance—an arrogance born of standing tall, not on one's own, but on the pedestal of others. The most painful situation arises when this pretense intrudes even into our most private and sensitive moments. Grief, once a time of simplicity, silence, and deep compassion, is now being buried under banners and posters. Even when a loved one dies, erecting large billboards and affixing photographs with politicians has become a way to say, "Our



grief is VIP too." This statement is as ironic as it is frightening, as it bears testimony to the dying sensitivity within us. Does grief even have a category? Are tears now shed based on identity? Is death still a matter of mourning, or has it also become a social display? This situation isn't just a habit, but the result of a deep-seated insecurity. Deep down, we've become a race to gain respect, but rather, "worth it." This mindset leads us away from self-reliance and toward dependency. Instead of forging our own identity, we borrow it—sometimes from a leader, sometimes from an official, and sometimes from an influential figure. Social media has deepened this trend. Wall photos are no longer confined to homes; they reach hundreds of thousands of people through Facebook, Instagram, and WhatsApp. Every joy is now a post, and every sorrow a status. In a world of likes and comments, even emotions have become "content."

People are more concerned with appearing happy than being happy, and more concerned with showing sadness than being sad. This pretense is slowly swallowing up our true feelings. When every emotion becomes a display, its depth is lost. Happiness becomes an event, and sadness a formality. This ostentation is also giving rise to an invisible competition in society. If one person posts a photo with a prominent leader, another tries to find an even bigger name. It becomes a race that seems endless. In this race, humanity, simplicity, and self-respect gradually fade away. Individuals forget who they are and become preoccupied with proving who they are with. This is an identity crisis—where the "I" is lost and "my connections" take over. This trend is also deeply worrying from a democratic perspective. When a person's identity in society begins to be determined by their connections, fundamental principles like equality and justice begin to weaken. People begin to believe that those with "access" are above the rules, and those without are mere spectators. This mindset not only fosters cor-

ruption but also deepens inequality in society. Gradually, the belief that respect can be earned through hard work and honesty begins to fade. This is having the most profound impact on our new generation. Children and young people are growing up seeing that connections are more important than competence to gain respect in society. They are learning that the path to success lies not through hard work, but through connections. This thinking leads them in the wrong direction, where they start looking for shortcuts instead of hard work. This is not only a personal loss but also a serious threat to the future of society. We need to understand that not everything needs to be shown. Some feelings are private, and their dignity is maintained in simplicity. Mourning is not a time for display, but for introspection and compassion. Happy times are also not for show, but for sharing affection. We don't need to prove every relationship, every achievement, and every connection to the world. True respect and dignity are built on our behavior, our actions.

The Great North-South Debate, And Prickly Questions About 'Fairness'

The ongoing debate over delimitation and parliamentary representation, provoked by the government calling a special three-day session of Parliament this week to debate constitutional amendments on the Women's Reservation Bill (but really to alter the delimitation of constituencies in the North's favour before the 2029 elections) has reopened one of India's most sensitive political and constitutional fault-lines. The core question is: how should a diverse federal union balance the democratic principle of "one person, one vote" with the need to ensure that smaller states or states with slower-growing populations retain a meaningful voice in national decision-making? The issue has acquired renewed urgency as population growth diverges sharply between regions, raising concerns that strict population-based seat allocation could deepen the emerging North-South divide. This dilemma is not unique to India.

The European Union has grappled with a similar challenge for decades: how to design a representative assembly for a political union in which Germany and Malta, or France and Estonia, must coexist as equal members. The EU's solution - degressive proportionality - offers a useful framework for India's current debate. Europe balances democracy and federal equity through a clever formula set into law under the Treaty of Lisbon. Under it, the European Parliament is built on three constraints that together preserve both democratic legitimacy and federal balance:

A minimum threshold: No member state can have fewer than six seats.

** A maximum ceiling: No state can have more than 96 seats.*

An inverse ratio: The larger a state's population, the more citizens each representative must correspond to.

This means that while Germany has far more Members of the European Parliament (MEPs) than Malta, a Maltese MEP represents roughly 80,000 citizens, while a German MEP represents around 850,000. The system ensures that the "Big Four" - Germany, France, Italy, and Spain - cannot dominate the Parliament simply by virtue of population. Smaller states retain a meaningful voice, preserving the federal spirit of the Union.

The EU's approach is not perfect, but it reflects a recognition that pure proportionality can undermine the cohesion



of a political union. Representation must reflect population, but not only population: it must also cater to needs of state identities. India, of course, faces a similar challenge. Since, unlike the EU, we are one country, India's federal structure is more deeply rooted in our constitution and more politically consequential than the EU's. Yet the underlying tension is similar. States that successfully implemented population control - Kerala, Tamil Nadu, Andhra Pradesh, and others - now face the prospect of losing relative political influence if Lok Sabha seats are reallocated strictly on the basis of population. Conversely, states with high population growth - Uttar Pradesh, Bihar, Rajasthan, Madhya Pradesh, all in the Hindi heartland - stand to gain significantly.

This raises a fundamental issue: should states be penalised or rewarded for their demographic behaviour? And should political power shift dramatically in ways that could destabilise the federal compact?

The concern is not merely theoretical. A strict population-based delimitation could produce a Lok Sabha in which a handful of large northern Hindi-belt states hold a permanent majority, enabling them to shape national policies even against the preferences of the rest of the country. This would mirror the very scenario the EU sought to avoid. The government has cleverly sought to divert the public conversation toward the case for women's representation - an important reform, but one that enjoys broad consensus and does not address the structural challenge at hand. Its real objective is to use women's representation as a "hook" to permit delimitation ahead of the constitutionally-mandated 2027 Census,

which would otherwise give us new constituencies only in time for the 2034 elections.

Sensing its own vulnerabilities in 2029, the ruling party wishes to advance that deadline by implementing women's reservation along with an expanded parliament and newly-delimited constituencies in time for the next general elections. Hence the unseemly rush to meet this week, even as election campaigning is going on in Tamil Nadu and Bengal.

The government's cleverness is not just to cloud the issue by presenting it as being about women's representation. It is also by seeming to address the concerns of Southern states by retaining the present proportion of seat differences between them and the North, by the simple expedient of raising all states' seats by 50%. The government argues that this would ensure that ratios between states remain the same: for example, UP's 80 seats would become 120 and Kerala's 20 seats would become 30, but the ratio between them remains 4:1. This masks the fact that the absolute difference in the number of MPs between these states changes from 60 (80 versus 20) to 90 (120 versus 30), giving more UP MPs a say in determining who forms the next government. That, in fact, is really the point of the entire exercise, which is why the Opposition parties have publicly expressed scepticism about it.

If all you want is women's representation, they say, go ahead and reserve one-third of the seats in the present Lok Sabha for women and we will support you. But don't do any delimitation until after the 2027 Census is over and a new Delimitation Commission has done its work while taking all these concerns into account.

Unemployed youth must take to the streets and fight for their rights," says H.D. Kumaraswamy

Bengaluru : Union Minister H. D. Kumaraswamy stated that unemployment is rampant in the state and that the Karnataka Public Service Commission (KPSC), which is expected to conduct transparent recruitment, is mired in irregularities. He alleged that the present government has not carried out even a single recruitment exercise. In such a situation, he asserted that unemployed youth must come out onto the streets and fight for their rights.



Addressing media representatives at the party office, the Union Minister urged the youth to protest against the government and not to fear police cases, assuring them that it would be their responsibility to fight and nullify such cases. He encouraged unemployed youth to stand firm and assert their rights.

He further stated that protests must be carried out across the entire state and not be confined to Dharwad alone. Clarifying that his remarks were not politically motivated, he said he was speaking out of concern and anguish after witnessing the plight of talented unemployed youth.

Responding to a question, he remarked that while the Chief Minister continues to claim that KPSC will be "cleaned up," the situation remains unchanged, with the institution deteriorating further. He pointed out that circumstances have now

forced unemployed youth to resort to street protests.

He alleged that those responsible for wrongdoing within KPSC have not been held accountable, while attempts are being made to target individuals unjustly. He called upon students across the state to protest against what he termed a "failing government," stating that without such resistance, justice would not be achieved. He also criticised the government for failing to fulfil its assurances of filling 60,000-70,000 posts, and recalled that the current Chief Minister had, in 2011, cancelled a recruitment process conducted by KPSC. He questioned the extent of harassment being inflicted and accused the government of targeting individuals selectively. He called upon the youth to be prepared and to bring about change.

"Will be in Karnataka two days a week"

The Union Minister stated that he would not remain passive and would actively raise his voice in support of the people. He announced that he would

henceforth spend two days every week in Karnataka, work towards strengthening the party organisation, and lead efforts in support of public causes.

He added candidly that the state would not witness progress under the present government, and asserted that development had taken place only during his tenure. He emphasised the need to defeat the Congress in order to fulfil the aspirations of the people.

On Women's Reservation

He stated that the full implementation of women's reservation would significantly transform the political landscape. Under the leadership of Narendra Modi, 33% reservation for women is being ensured. He further noted that following delimitation, Karnataka is expected to have 42 Lok Sabha constituencies, of which 33% would be reserved for women. He added that his party would provide greater encouragement and opportunities to women workers.

Similar tributes were paid in Zone-2 at Bagalagunte, where Joint Commissioner Pallavi led the celebrations and interacted with sanita-



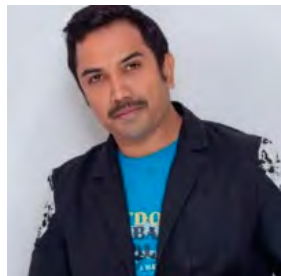

influence within the party. He alleged that internal rivalry among Congress leaders aspiring for the post is affecting governance and development.

Ashoka also took a swipe at the party, remarking that Congress has now become a "party of fights," similar to how political infighting was once associated with the Janata Dal. On the tem-

ple event, he said Narendra Modi is expected to attend the inauguration of the Guru Bhairavaikya Temple at the Adichunchanagiri Sansthan, where elaborate arrangements have been made to accommodate thousands of devotees. He noted that the Prime Minister will participate in special rituals before addressing a public gathering.

M. K. Stalin urges protecting Constitution, pluralism on Ambedkar Jayanti

CHENNAI: Tamil Nadu Chief Minister MK Stalin on Tuesday paid tribute to BR Ambedkar on his 135th birth anniversary as he urged people to defend the Constitution, uphold social justice and protect the voices of the oppressed.

In a post on X, Stalin invoked Ambedkar's vision on social progress and equality, stating, "I measure the progress of a community by the degree of progress which women have achieved. - Ambedkar. On the birth anniversary of revolutionary Ambedkar, let us strengthen our resolve to protect the Constitution, establish social justice, and safeguard every oppressed voice! India's strength lies in our pluralism; not in imposed uniformity." Emphasising inclusivity, Stalin further said, "If progress is the measure, let us reject uniformity and hierarchies, choose pluralism and equality; let us establish justice! I measure the progress of a community by the degree of progress which women have



achieved." - B. R. Ambedkar. On the birth anniversary of Babasaheb, let us strengthen our resolve to defend the Constitution, uphold social justice, and protect every oppressed voice. India's strength lies in its pluralism, not in imposed uniformity. If progress is the measure, let us reject uniformity and hierarchy; choose pluralism and equality, and uphold justice." The Tamil Nadu Chief Minister's remarks came as leaders across the political spectrum remembered Ambedkar's contributions to India's democratic and constitutional

framework on his 135th birth anniversary.

Meanwhile, Congress MP Manickam Tagore also invoked Ambedkar's warning on the functioning of the Constitution, alleging that a special session of Parliament scheduled for April 16 was being rushed. He moved as turning parliamentary democracy into a "mere formality." Tagore stated, "A special session of Parliament is being rushed on April 16, right at the peak of election campaigning in Tamil Nadu and West Bengal. A reasonable demand for an all-party meeting after the elections

has been rejected... This is not democracy. This is bulldozer governance."

He also raised concerns over delimitation, calling for wider consultation and transparency, and emphasised that Parliament "is not a rubber stamp" but the foundation of people's voice. Senior Congress MP P Chidambaram also paid tribute to Ambedkar, saying, "We remember Babasaheb Ambedkar today on his birthday! We also remember his precious gift to the people of India - the secular democratic Constitution of India!" Dr BR Ambedkar, popularly known as Babasaheb, was the chief architect of the Indian Constitution and a key figure in India's social reform movement. Born into a Dalit Mahar family, he dedicated his life to securing equal rights for marginalised communities and promoting social justice. Ambedkar served as independent India's first Law and Justice Minister and was posthumously awarded the Bharat Ratna in 1990 for his contributions to the nation.

Annamalai hits out at Stalin's 'warning' on delimitation, accuses him of fear-mongering

Chennai, April 14 : BJP leader K. Annamalai on Tuesday launched a scathing attack on Tamil Nadu Chief Minister M.K. Stalin over his remarks on the proposed delimitation process, calling his "warning" to the Centre "uncalled for" and alleging that it was aimed at creating "fear" among the public.

Annamalai said the Modi government is committed to taking all stakeholders along on the issue and dismissed Stalin's concerns as an attempt to generate unnecessary apprehension among people in the state.

The remarks come ahead of a Special Session of Parliament scheduled to begin on April 16, during which the amendments to the Nari Shakti Vandan Adhiniyam, 2023, and a proposed Delimitation Bill are expected to be discussed to facilitate one-third reservation for women in Parliament.

Earlier, Stalin, in a video message, had cautioned the Centre against proceeding with delimitation in a manner that could adversely impact southern states.



He said Tamil Nadu would launch a large-scale agitation if its interests were compromised or if the southern region faced disproportionate consequences. He also questioned the timing of the special session, noting that it coincides with Assembly elections in Tamil Nadu and West Bengal scheduled for April 23.

The Chief Minister argued that Tamil Nadu and other southern states had implemented population control measures in line with the Centre's guidance and should not now face adverse outcomes as a result. He maintained that

the state would not remain silent if its interests were undermined.

Responding to these remarks, Annamalai told IANS, "It is very unfortunate that the Chief Minister is trying to sow discord and create fear-mongering in the minds of the Tamil population. We all know, if you look at the video, the kind of language he has used, saying that Tamil Nadu will go back to the 1960s, threatening the Prime Minister is uncalled for." He further said that the Prime Minister has made a "lot of effort" to bring everybody together.

"Since 1996, it (women's reservation issue) has been stuck. Many senior leaders of various political parties in the current INDIA bloc have opposed reservations for our mothers and sisters. The Prime Minister made the effort from September 2023 to pilot this and get this bill passed in both Houses of Parliament by bringing everybody together," he said.

Slamming Stalin, Annamalai said, "What is the problem of the Tamil Nadu Chief Minister? Nowhere have we said it's a population-based increase. Everywhere we have said we will take everybody together. The Home Minister in Coimbatore a year back said it's going to be a pro rata increase."

"Whatever increase we are going to bring, it is going to be pro rata so that nobody suffers. It is very, very unfortunate that the Tamil Nadu Chief Minister, by putting out this video, has gone against the oath he took on the Constitution of India," the BJP leader said, referring to Stalin's video post on X.

Southern Railway to celebrate 75th Formation Day



CHENNAI (TSIT): When Southern Railway marks its 75th year on April 14, its network today covers over 5,100 km across the south. Its evolution can be traced back to a single train that left Royapuram for Arcot in 1856. Formed in 1951 through the merger of the Madras and Southern Maharratta Railway, the South Indian Railway and the Mysore State Railway, the zone was part of a larger post-Independence effort to reorganise railways into administrative units.

But much of its footprint had already taken shape decades earlier. By the 1860s, lines had reached the west coast through Beypore (a Kerala port town) and Calicut (present-day Kozhikode). In the following decades, Madras was linked to Bombay and later to Howrah, creating long-distance connectivity across the country. Rail access to ports such as Kochi and Thoothukudi

further expanded the network's reach. The zone has since been reshaped more than once, with parts carved out to form South Central Railway in 1966 and South Western Railway in 2003.

What remains today covers Tamil Nadu, Kerala, Puducherry and parts of Karnataka and Andhra Pradesh, with six divisions headquartered in Chennai, Madurai, Tiruchy, Salem, Palakkad and Thiruvananthapuram.

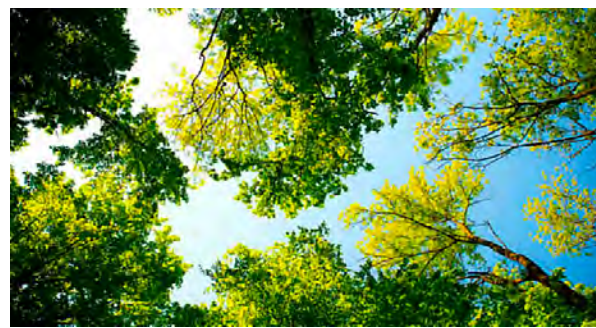
Along the way, the network has retained some of its oldest and most recognisable structures, including Dr MGR Chennai Central, Chennai Egmore railway station, Royapuram railway station, the Nilgiri Mountain Railway and the recently commissioned vertical-lift Pamban bridge.

Operationally, the biggest changes came in the late 20th and early 21st centuries. Metre-gauge lines were converted to broad gauge between 1990 and 2010, routes were doubled to handle higher traffic, and electrification expanded to cover more than 97 per cent of the network.

To combat extreme heat: State's green program for passive cooling solutions extended to 100 govt schools

CHENNAI: Following a successful pilot phase, Tamil Nadu is set to expand its 'Green School Program' to 100 government schools, aiming to tackle rising heat stress and create safer, more comfortable learning environments across the state. BJP mirrors AIADMK welfare pitch, pushes temple agenda in TN manifesto; minority, dalit assurances missing

The initiative, launched in partnership with the UNEP and the Cool Coalition, uses passive cooling solutions to protect students from heat-related disruptions. The expansion comes as extreme heat tightens its grip on urban and coastal Tamil Nadu. Cities like Chennai experience intensified temperatures due to the urban heat island effect, where built-up areas trap heat, pushing local temperatures 10-15 degrees Celsius higher than surrounding regions. In sev-



eral schools with limited green cover, playground and terrace temperatures have been recorded between 40°C and 45°C.

Research shows that student concentration begins to decline once classroom temperatures cross 30°C. At around 32°C, exam pass rates can drop by nearly 10%. Prolonged exposure also leads to fatigue, dehydration, headaches, and increased absenteeism, particularly among younger children.

impact on students

To address this, TN has adopted passive cooling techniques that rely on design and natural elements rather than energy-intensive AC. Key interventions include cool roofs with reflective coatings that reduced heat absorption, lowering roof surface temperatures by up to 20°C and indoor temperatures by 8°C.

Schools were also being equipped with better ventilation systems, including jaali-style perforated walls and roof ventilators to release trapped hot air. Tree planting, shaded

structures like pergolas, and energy-efficient BLDC fans (consuming up to 60% less electricity) further improve conditions.

Cool roofs, green cover ease classrooms

Initial results from the 8 pilot schools have been encouraging. One pilot saw 78% reduction in cooling energy costs through a combination of cool roofs, insulation, and shading. Teachers have reported improved student attentiveness and reduced discomfort during peak afternoon hours. Beyond infrastructure, the programme integrates climate awareness into the school ecosystem. Students are encouraged to maintain green spaces and understand sustainable practices, becoming active stakeholders in climate action. With the next phase targeting 100 institutions, officials say the long-term goal was to replicate the model across Tamil Nadu, particularly in heat-vulnerable districts.

New Research Indicates That Loneliness Triggers Sugar Cravings in Women

A UCLA Health study has discovered that lonely women are more inclined to crave high-calorie, sugary foods, demonstrating a link between loneliness, unhealthy eating behaviors, and poor mental health. The research highlights the brain's role in these correlations and suggests holistic interventions as potential remedies to break the cycle of loneliness and unhealthy eating. Research indicates that lonely women show heightened brain activity in areas linked to cravings for food.



A recent study by UCLA Health discovered that women who feel lonely show brain activity in areas linked to cravings and the drive to eat, particularly when viewing images of high-calorie foods like sugary treats. These women also displayed unhealthy eating habits and suffered

from poor mental health. Arpana Gupta, Ph.D., a researcher and co-director of the UCLA Goodman-Lusk Microbiome Center, wanted to research the negative impacts of loneliness, especially as people continue to be working remotely after the COVID-19 pandemic, and how the brain interplays with social isolation, eating habits, and mental health. While it is established that obesity is linked to depression and

anxiety and that binge eating is understood to be a coping mechanism against loneliness, Gupta wanted to observe the brain pathways associated with these feelings and behaviors. Methodology and Findings The researchers surveyed 93 women about their support system and their feelings of loneliness and isolation, then separated them into two groups: those who scored high on the perceived social isolation scale, and those who

scored low. The researchers found that women who had higher levels of social isolation tended to have higher fat mass, lower diet quality, greater cravings, reward-based eating, and uncontrolled eating, and increased levels of anxiety and depression.

The women were then shown pictures of food versus non-food, sweet food versus non-food, and savory food versus non-food. MRI scans recorded the participants' brain activity while they viewed these images. The researchers found that the group of women who perceived themselves to be lonely experienced increased activation in regions of the brain associated with greater cravings to eat sugary foods, and decreased activation in the brain region associated with self-control toward eating behaviors.

Unlocking Tomorrow's Water Secrets Through Sci-Fi

Human activities are reshaping the Earth's water cycle, leading to significant changes in cloud formation and precipitation. Colorado State University's Patrick Keys has explored these impacts through interdisciplinary research, employing narrative scenarios to envision future water management challenges. Credit: SciTechDaily.com Through a blend of science and storytelling, new research delves into the future of water management amidst changing environmental dynamics. Human activity is changing the way water flows between the Earth and atmosphere in complex ways and with likely long-lasting consequences that are hard to picture.

Land use change is altering where clouds form and how precipitation is distributed. Meanwhile, weather modification activities like cloud seeding are shifting how nations plan for water use in the face of climate change. These and other changes to the planet's atmospheric water cycle were once hard to imagine but are increasingly part of modern water management on the planet.

Colorado State University Assistant Professor Patrick Keys is an expert in climate and societal change. He has been studying these types of issues for years and realized there was a potential gap when it came to understanding



– not only in the public but among the water research community – the lasting implications of these changes. To better grasp how those kinds of activities could shape the world, he enlisted water scientists from around the globe to write story-based scenarios about the possible futures humanity is facing but perhaps can't quite comprehend yet. The results were recently published in Global Sustainability as part of a creative pathway to understand atmospheric water research with an eye towards the potential economic and policy issues that may be just beyond the horizon. The work features striking artist-made images that pair with traditional science fiction narratives as well as alternative story forms like first-person journal entries. Keys

said the package offers a wide path – grounded in science – to build a shared understanding of future water management activities and problems. "Stories are everywhere and are an integral part of human life," he said. "They tell you something different from a graph in a research paper. They allow you to explore how people may feel or react to these kinds of changes. This kind of work provides agency for people and an opportunity to consider these changes no matter their background or level of understanding." Research for this work came in three distinct phases, according to Keys. First, he used computational text analysis to find recurring themes in journal abstracts about the current state of atmospheric water cycle research.

India received highest number of regressive tax recommendations from IMF: Oxfam

New Delhi: India received the highest number of regressive tax recommendations from the International Monetary Fund (IMF) between 2022 and 2024, according to an analysis by Oxfam. The analysis, released ahead of the IMF and World Bank spring meetings in Washington, has flagged that the global body is applying "double standard" by giving largely progressive advice to wealthy countries while suggesting regressive measures for others that are "likely to exacerbate inequality". The report said 59 per cent of the IMF's tax advice to low- and lower-middle-income countries was regressive, while 52 per cent of its recommendations to high-income countries were progressive. A regressive tax refers to a uniform taxation system which burdens those in lower income groups more than high earners. In contrast, a tax levied in proportion to one's income is termed progressive. Oxfam examined 1,049 tax recommendations made by the IMF to 125 countries between 2022 and 2024 and found that only 30 recommendations, or around three per cent, focused on net wealth taxes and the taxation of income from wealth, namely capital gains. The



report said that despite the rapid growth of extreme wealth, billionaire wealth has surged by 81 per cent since 2020. The analysis found that the United States and Brazil received the most progressive IMF tax advice. Canada, Australia, France, the United Kingdom, the Netherlands, Switzerland, Sweden and Norway also received more progressive recommendations, along with China, Kazakhstan, Angola and Botswana. "While high-income countries generally receive IMF recommendations that are tilted towards progressive measures, amounting to 52 per cent of the overall total classifiable advice to these countries, poorer countries

don't seem to get the same treatment," the report said. On the other hand, India received the highest number of regressive recommendations, followed by several other countries in the Global South. "This regressive aspect of tax advice for Global South countries means that most measures advised by the IMF are likely to exacerbate inequality in these countries, by placing the bulk of the tax burden on middle- and low-income people while leaving the wealthiest unscathed." The report said that the IMF's tax advice to South Asia was "by far the most regressive", followed by those suggested for Latin America and the Caribbean and sub-Saharan

Africa. The analysis cited Chile, Nigeria and Hungary as examples of countries where the IMF recommended measures that could disproportionately burden low- and middle-income groups. In Chile, with one of the highest levels of income inequality, the IMF advised raising tax rates for low- and middle-income groups while leaving rates on top income brackets untouched. In Nigeria, where nearly one-third of the population lives in poverty (the highest rate in Africa), it suggested increasing value-added tax, while in Hungary, it advised against a windfall profit tax on energy companies. "A progressive tax system ensures those who have

higher income and more wealth pay proportionally more taxes than those who have less. Progressive tax measures like net wealth and capital gains taxes were rarely recommended, and when they were, advice was concentrated in high-income contexts," the report said. The report also highlighted several country cases reflecting concerning tax policy advice. In New Zealand, the IMF expressed concern that the corporate income tax in the country is "relatively high compared to peer advanced economies" and advised the government to lower it. In Sweden, it recommended "lowering taxes on deferred capital gains" to address distortions in the housing market. In the Philippines, the IMF called for broadening the value-added tax base by rationalising exemptions, while in Cote d'Ivoire, or the Ivory Coast, it recommended eliminating VAT exemptions and applying statutory VAT rates. Oxfam said the IMF publicly acknowledges that tax policy is a critical tool for addressing inequality, but it links its tax advice to inequality far more often for high-income countries (34 per cent) than low- and lower-middle-income countries (8 per cent).

The couple landed at Melbourne airport around 06:30 on Tuesday (21:30 BST Monday) on a commercial Qantas flight from Los Angeles. It is Harry and Meghan's first time in



Australia since 2018 when they spent around nine days in the country as part of an intense tour just a few months after their marriage. While that trip saw large crowds gather to greet them wherever they went, this time there are no events planned to meet members of the public. After stepping down as working royals in January 2020 and giving up their His and Her Royal Highness (HRH) titles, Prince Harry and Meghan are visiting as private citizens and say that the trip is privately funded. But there

are questions over whether Australian taxpayers are picking up any of the bill for policing during the visit. The visit will take in Melbourne, Canberra and Sydney, and while charitable causes, issues and organisations close to their hearts are central to the visit, as private citizens, the couple are free to personally profit from the trip. At the Royal Children's Hospital in Melbourne, hundreds of people gathered in the foyer for a glimpse of Harry and Meghan on Tuesday. The couple talked animatedly to

children being treated there, and their parents - posing for selfies giving hugs and shaking hands. The duke and duchess then met with other onlookers - mainly staff and patients with their families. Among the crowd was Emily Burke and her three-year-old daughter Phoebe who had just been discharged from an overnight stay. "We just found out they were coming so we hung around," Burke told the BBC, adding that "Meghan came and had a little chat with Phoebe... she was commenting on her Bluey slippers".

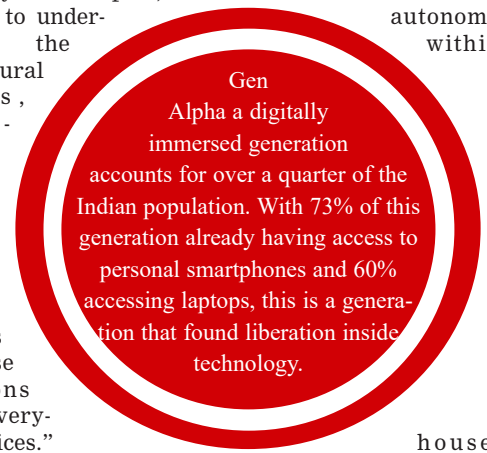

Trump says Iran talks could resume 'over next two days' as ships pass Hormuz Strait despite US blockade

Talks between the US and Iran could restart "in the next two days", Donald Trump has told the New York Post, external. "Something could be happening over the next two days, and we're more inclined to go there [Pakistan]," he tells the newspaper. This comes after a weekend meeting in Islamabad, Pakistan, involving US Vice-President JD Vance and Iran's Parliament Speaker Mohammad Bagher Ghalibaf, among others. The talks ended without a deal. Earlier today, Iran's state-run media said messages have been exchanged between Tehran and Pakistan, but there is "no information" about any agreement to hold further talks with the US. For the first time in decades, the ambassadors to the US of Israel and Lebanon, countries that do not have diplomatic relations, are meeting in Washington, in what many hope will pave the way for a ceasefire in the war



here, where Israel has been fighting the Iranian-backed group Hezbollah. There is very little the Lebanese authorities can offer, however. The state is not a party to the conflict, and has almost no influence over Hezbollah, which is accused by opponents of defending the interests of Iran and dragging Lebanon into unwanted wars. This one has killed more than 2,000 people, according to the health ministry, which does not distinguish combatants from civilians, and displaced a fifth of the population. Communities are in ruins, and many residents may never be able to go back. Invading Israeli troops continue their ground operations, to create what officials describe as a security buffer zone along the border, which has raised fears that parts of the country will remain under occupation even after

the war. One of the roots of this conflict is Hezbollah's arsenal. Disarmament is a demand from the US, Israel and many Lebanese, but the government in Beirut cannot deliver it without Hezbollah's consent, amid concerns the use of force could result in violence. Supporters say Hezbollah is the only protection they have from Israel, and the group is already saying it will not abide by any decision.

Lebanon's President Joseph Aoun, who is not in the US, says he hopes the talks will mark the "beginning of the end" of Lebanon's suffering. He also says stability "will not return" to southern Lebanon if Israel "continues its occupation". For context, Israeli troops are carrying out ground operations in southern Lebanon to create what officials describe as a security buffer zone along the border. This has raised fears that parts of Lebanon could remain under occupation even after the war. Now let's return to Washington DC, where Israeli and Lebanese ambassadors are in talks. Before the talks began behind closed doors, a photo was taken in the Benjamin Franklin Room of those taking part. From the US side, participants include US Secretary of State Marco Rubio, US Ambassador to Lebanon Michel Issa, and US Ambassador to the UN Mike Waltz. Standing next to them are Lebanese Ambassador to

the US Nada Hamadeh and Israeli Ambassador to the US Yechiel Leiter. Secretary of State Rubio has just spoken briefly, describing this as a historic opportunity. Rubio says this meeting is about "a lot more" than a ceasefire - it's about "bringing a permanent end" to Hezbollah's influence. He says they understand they are working against decades of complexities that won't be resolved in the next one hour of talks, but the hope is to outline a framework for a permanent, lasting peace. French woman, 86, held by ICE after moving to US to reunite with long-lost love



An 86-year-old French woman who moved to the US last year after rekindling a 1960s romance is being detained at an immigration enforcement centre in Louisiana. The son of Marie-Thérèse, from the city of Nantes, sounded the alarm after his mother was arrested in Anniston, Alabama, earlier in April. "They handcuffed her hands and feet like she was a dangerous criminal," he told French outlet Ouest-France. The US Department of Homeland Security, which oversees Immigration and Customs Enforcement (ICE), told the BBC that an "illegal alien from France" matching Marie-Thérèse's name had entered the country in June 2025 and overstayed her 90-day visa. According to her son, however, Marie-Thérèse was awaiting a green card when she was detained. Marie-Thérèse mother had moved to the US after marrying her long-lost love - an American man named Billy whom she had met in the 1960s, when he was a soldier stationed in the Nato base of Saint-Nazaire, and she a secretary. Billy returned to the US in 1966. He and Marie-Thérèse lost touch, got mar-

ried - each in their own country - and had children. The two reconnected in 2010 and visited one another with their spouses. Ouest-France reported. By 2022, both were widowed and started a relationship. Billy was a "charming, adorable man", Marie-Thérèse's son said, and the couple were in love "like teenagers". They married last year and Marie-Thérèse relocated to Alabama, applying for a green card - a long-term visa - that would grant her the right to remain in the US. But she had not yet received the green card when Billy died suddenly in January, leaving her immigration status unclear. Shortly after Billy's death, his son and Marie-Thérèse reportedly entered a dispute over his inheritance. Billy's son "threatened her, intimidated her, and even went so far as to cut off her water, internet, and electricity," her son told Ouest-France. Marie-Thérèse hired a lawyer, but was arrested by ICE the day before a scheduled hearing. Neighbours alerted her children. There is no proof that it was a report by Billy's son that landed his stepmother in an ICE detention centre.

RETRIAL OVER DEATH OF ARGENTINA LEGEND MARADONA TO BEGIN

A retrial into the death of the football great Diego Maradona, who died aged 60 after suffering heart failure, starts on Tuesday. The first trial in May 2025 collapsed after one of the three judges on the case allegedly allowed unauthorised filming in court for a documentary. Maradona's medical team are accused of failing to administer proper medical care, and seven people will be tried for homicide with possible intent. They deny the allegations. If convicted, they face between eight and 25 years in prison. The football legend had been recovering at his home in Tigre, in Buenos Aires province, after successful surgery on a brain blood clot earlier that month. Investigators classified the



case as culpable homicide, a crime similar to involuntary manslaughter, because they said the accused were aware of the seriousness of Maradona's health condition but did not take the necessary measures to save him. The heart failure caused him to suffer acute pulmonary oedema, when fluid builds up in the lungs, the preliminary autopsy confirmed.

JD Vance defends backing 'great guy' Orbán's campaign after landslide defeat

US Vice-President JD Vance has insisted he was right to stage a two-day campaign visit to back Hungarian Prime Minister Viktor Orbán five days before he was voted out of office by opposition party Tisza's landslide victory. Insisting Orbán was a "great guy" who did a "very good job", Vance told Fox News he was "one of the few European leaders we've seen who's been willing to stand up to the bureaucracy in Brussels". While he was sad Orbán had lost, he was sure the US would "work very well" with the new government, he said. Péter Magyar, who led Tisza to victory, had been critical of Vance's intervention, warning last week that "no foreign country may interfere in Hungarian elections".



However, he said on Monday the US was a "strong and important" Nato partner and if President Donald Trump or anyone else called him he would talk to them. Orbán will continue to run Hungary in a caretaker role until Magyar is sworn in, and the three party leaders with seats

resign, calling him a "puppet" of Orbán's government. Magyar has suggested that he could become prime minister on 5 May, or even sooner. Sulyok's office has made clear to Hungarian media he will not resign, however he is expected to discuss with the three party leaders when to convene the National Assembly and propose a new prime minister. In another striking development, the incoming prime minister said he would appear on public radio and TV on Wednesday ahead of his visit to the president. Magyar said on Monday that in all the time he had led Hungary's main opposition party he had never been allowed on public TV, until he was asked on Monday morning, after he had swept Fidesz from power.

Accusers seek justice after unwanted explicit messages from Congressman Eric Swalwell

Two women who have accused Congressman Eric Swalwell of sending unwanted explicit photos say they are grateful he is facing consequences now and leaving Congress after acting with impunity for years. Annika Albrecht and Ally Sammarco told the BBC's US partner CBS News they feel vindicated. But Albrecht said there is more to be done. "For me, justice won't be until he can't ever harm a woman ever again, and he has faced the consequences for the women that he has harmed," she said. Swalwell, a Democrat, said on Monday that he will resign. He has also dropped



out of the California governor's race. He apologised to his wife and supporters for making mistakes but denied claims of sexual abuse. In a statement, Swalwell has said he is "deeply sorry to my family, staff, and constituents for mistakes in judgement I've

made in my past". "I will fight the serious, false allegation made against me," he added. "However, I must take responsibility and ownership for the mistakes I did make." He was elected to the House of Representatives in 2012 to represent a district near

San Francisco. Last week, four women accused him of misconduct ranging from sexual harassment to rape. As a result, Congress opened an ethics inquiry, and lawmakers were considering expelling the congressman. "He was pushed into a corner, essentially, because they were planning to expel him... so I think he did that to save face a little," Sammarco told CBS News. "But I also felt very vindicated that he realized it was over for him." Sammarco told CNN last week that Swalwell sent her unsolicited nude messages over Snapchat, an app that deletes messages after they're sent.

Cameroon separatists to pause fighting ahead of Pope visit



Anglophone separatists in Cameroon have announced a period of "safe travel passage" and halted fighting ahead of Pope Leo XIV's visit to the conflict-hit region this week. Leaders of several armed and secessionist groups said the three-day measure was in recognition of the "profound spiritual importance" of the papal visit, which starts on Wednesday, and the need to safeguard civilian life. In a statement from Unity Alliance - which brings the groups together - they said they would facilitate the movement of those celebrating the visit. The government is yet to comment. A near-decade of violence in the English-speaking regions has left at least 6,000 dead and many more forced from their homes. Pope Leo is currently in Algeria for a second day as part of his 11-day tour of the continent, in which he will also visit Cameroon, Angola and Equatorial Guinea. Peace is one of the major themes of his visit. The pontiff arrived in Algeria on Monday, marking the first visit by any pope to

the predominantly Sunni Muslim country. It is also the birthplace of St Augustine, and Leo XIV is the first pontiff from the order to follow his teachings. He is now in Annaba - where the saint was a bishop - and in the afternoon, is expected to celebrate Mass at the Basilica of Saint Augustine. During a meeting at a nearby nursing home run by Catholic nuns, the Pope reiterated his message of peace. "God's heart is torn apart by wars, violence, injustice and lies," he said, explaining that his heart was "not with the wicked, the arrogant or the proud". "God's heart is with the little ones and the humble, and with them he builds up his kingdom of love and peace day by day, just as you are striving to do here in your daily service, friendship and life together." The Pope's second country stop is Cameroon, where he will visit Bamenda, the capital of the country's North-West region. The city is regarded as the centre of Cameroon's conflict between Anglophone separatists and state forces.

GREEK POLICE USING MASKED MIGRANTS TO FORCIBLY PUSH OTHER MIGRANTS BACK ACROSS BORDER

Police in Greece have been recruiting migrants to violently push other migrants back across its land border with Turkey, according to wide-ranging evidence uncovered by the BBC. We have seen internal police documents in which guards describe how the recruitment of so-called mercenaries was ordered and overseen by senior officers. Our findings reveal allegations of brutality, with witnesses reporting migrants being stripped, robbed, beaten and even sexually assaulted. It has been claimed that mercenaries have been unofficially employed on the border since at least 2020. The Greek prime minister told the BBC he was "totally

unaware" about allegations of the use of migrants for pushbacks, while the country's authorities have not responded to our written detailed requests for comment. Pushbacks - forcing migrants and asylum seekers back across borders without due process - are generally considered illegal under international law. Claims that they were being carried out in Greece by foreign masked men were reported in 2022 by the Netherlands-based news organisation, Lighthouse Reports. Our own investigation - carried out in collaboration with the Consolidated Rescue Group (CRG) - began last autumn, when we were sent distur-



ing video allegedly showing migrants being mistreated by mercenaries. It was shared with us by a smuggler, who claimed to have become disgruntled with his associates. We have not been able to verify the content but it mirrors accounts we have gathered from other independent sources.

We have since pieced together information from migrants, former mercenaries, police sources, official documents and leaked transcripts: One border guard told a disciplinary hearing they had information, reported to their superiors, that mercenaries had been raping female migrants Two

migrants and an ex-mercenary say they saw extreme violence by both mercenaries and Greek police, including people being beaten until they passed out. A migrant says a masked man took off her daughter's nappy in the hunt for valuables Greece has seen well over a million migrant arrivals since 2015 - chiefly through sea crossings but also along its land border with Turkey. This frontier runs 200km (124 miles) along the Evros River. It marks the outer edge of the European Union, separating Greece's Evros region and the Turkish territory of East Thrace. Refugees or illegal migrants crossing the river into Greece enter a heavily

militarised restricted zone, dotted with watchtowers. A police source in the region told us that mercenaries have been used to push back as many as hundreds of people a week. "There is no soldier, police officer or Frontex (EU border agency) officer serving here in Evros who does not know that pushbacks are taking place," they added. We have found that the mercenaries are themselves migrants, recruited from countries including Pakistan, Syria and Afghanistan, and that they can be rewarded with cash and mobiles looted from other migrants, as well as papers that, in effect, allow passage through Greece.

Punjab Kings are among the most consistent teams in IPL 2026. After finishing runners-up in IPL 2025, Punjab Kings have begun the new season in right earnest. They are the only team in the IPL to remain undefeated so far. In four matches, they have won three, while one ended in a no-result. This performance has seen PBKS placed among the top two teams on the points table. Bollywood superstar Salman Khan also had a message for Preity Zinta as the team continued their strong run. "Well done, Zinta. Congratulations, Zinta. Team is playing well..." @realpreityzinta, Salman wrote on X. Meanwhile, former South African cricketer Faf du Plessis has praised the batting depth of Punjab Kings (PBKS) in the ongoing Indian Premier League (IPL) 2026 season, calling them one of the strongest contenders for the title. Speaking on Star Sports,



JioStar expert du Plessis said Punjab Kings' batting unit has been consistently delivering, just as it did in the previous season when the team reached the final. Carse has been ruled out of the ongoing IPL



season due to an injury," the Indian Premier League said in a statement released on Tuesday. Dilshan Madushanka, a left-arm medium pacer, has represented Sri Lanka in one Test, 28 ODIs, and 19 T20Is and has 70 wickets in international cricket to his name. He will join SRH for INR 75 lakh. The Sri Lankan

bowler was previously part of the Mumbai Indians (MI) in the IPL, the statement added. Madushanka's entry will further bolster the SRH bowling unit, which already includes youngsters Praful Hinge and Sakib Hussain, along with experienced pacers Harshal Patel and Jaydev Unadkat. Designated captain Pat

Cummins is likely to join the group on April 17. Madushanka has not played a match in the IPL so far. He was acquired by the Mumbai Indians (MI) for Rs 4.6 crore in 2024 but was ruled out due to a hamstring injury. The 25-year-old Sri Lankan left-arm pacer is known for his ability to swing the ball early in the powerplay. Ishan Kishan is leading the side in Cummins' absence. Under his captaincy, the team has won two out of five matches in the ongoing season. They are currently placed fourth in the points table with a net run rate of +0.576. SRH defeated table-toppers Rajasthan Royals (RR) on Monday, courtesy of a brilliant bowling display by debutants Praful and Sakib, who took four wickets each.

SEXIST ABUSE OF UNION BERLIN BOSS 'EMBARRASSING'

Union Berlin's director of football has condemned "insane" sexist abuse directed towards new head coach Marie-Louise Eta. Eta became the first woman appointed to manage a men's team in one of Europe's top five leagues after being named interim head coach of the Bundesliga side. Since her appointment on Sunday, the 34-year-old has been the target of sexist comments on social media. "It's just embarrassing. I've noticed it, but I also refuse to read or even just expose myself to that kind of nonsense because for me this is about quality - leadership quality," said Horst Heldt. "We have 100% confidence in Loui - complete conviction. I find it insane that we have to deal with this in this day and age. "We're talking about a highly competent leader here, and you can be sure that everyone here at Union, whether in the stands or within the club itself, stands 100% behind this decision and will do everything in their power to ensure that this doesn't lead to any further discussion in the future." Eta, a former Germany youth international and Women's Champions League winner with Turbine Potsdam, will take charge of Union Berlin's women's side this summer. She



became the Bundesliga's first female assistant coach, with Union Berlin, in November 2023. She deputised for manager Nenad Bjelica, who was serving a three-match suspension, during a 1-0 win over Darmstadt in January 2024 to become the first woman to lead a Bundesliga team from the touchline. Union Berlin, who are 11th in the 18-team Bundesliga, are 11 points clear of the automatic relegation zone with five matches remaining but have won only twice in 14 league outings in 2026.

Tall Boy, Taller Ambitions: Ayush Shetty's China Breakthrough Signals India's Next Big Badminton Star



"Generational talent." - that is how PV Sindhu described Ayush Shetty after his giant killing act in China's Ningbo when he beat World No. 1 Kunlavut Vitidsarn at Asian Badminton Championships 2026. When PV Sindhu uses that phrase, it carries weight. Standing at 6ft 4in, Ayush Shetty has long been impossible to miss physically. After his exploits in China this week, he became impossible to ignore. But the final against Shi Yuqi, was a reminder of where he needs to tighten his game. The World No. 2 belted out a masterclass in control and precision. In front of a partisan crowd, the Indian struggled to impose his trademark attacking game. The result was a swift 42-minute defeat-8-21, 10-21. For Shetty, it was more a lesson. "I think in the final,

my opponent executed his game plan really well," he admitted. "He didn't give me many openings to attack... his length control was very precise and he kept me away from the net. So yes, adapting better in such situations-being more patient, extending rallies, and transitioning smoothly between attack and defence- is definitely something I need to work on." The week that led up to the final was a delight for the badminton fans who saw his steep angles, booming smashes and court coverage, thanks in part to that towering frame. And he did spend some time with the Dane. As a youngster, he idolised Lee Chong Wei, drawn to the Malaysian legend's speed and attacking flair. He also idolised Kidambi Srikanth. But with his body evolving, his blueprint for success also changed.

Peaty on his return to the pool, LA 2028 and Gordon Ramsay's speech

Adam Peaty is back for more, again. The three-time Olympic champion, who almost quit the sport before the Paris Olympics and considered doing so after taking silver in the French capital, returns to the London Aquatics Centre on Tuesday. It is a key step on the road he hopes will lead to a fourth Olympic Games in Los Angeles in 2028 - and possibly another Olympic gold. "The next two years are probably going to be the hardest of my career," Peaty tells BBC Breakfast. "There probably won't be much winning, but the one win

that does matter is LA." It is almost a year since Peaty, who got married while swimming took a back seat, confirmed he will go again. He made the decision after it was confirmed the 50m breaststroke event would be added to the schedule in 2028. It gives Peaty a second shot at more individual golds - the chance to add the 50m title to the 100m medals he won in 2016 and 2021. He has raced here and there in recent months with mixed results, but will compete over both distances at this week's British Championships - a crucial step which he hopes will

lead to the Commonwealth Games, World and European Championships and America's west coast. "It's like tasting an amazing steak and then having to go back to a McDonald's burger," he says. "The Olympics is the one that excites me. That is the one that really gets me out of bed every day, the one I dream of. "We have to set that path now. "Two years out, it is about how much racing and experience can we gather to give the best performance in LA." Peaty was beaten to a third successive gold in Paris by Italy's Nicolo Martinenghi, having contracted coron-

avirus in the days before the final. "With the cards I was dealt I swam out of my skin," he says. "I shouldn't have got a silver medal." Before the Paris Games, Peaty shared his struggles with injury and his mental health, describing the period as a "self-destructive spiral". He says he has not allowed himself to think about what another Olympic medal might mean but remains confident similar issues will not return as he chases more success in LA. "Can we avoid burnout? Absolutely," he says. "It is the logistical and strategic thinking we have to do.

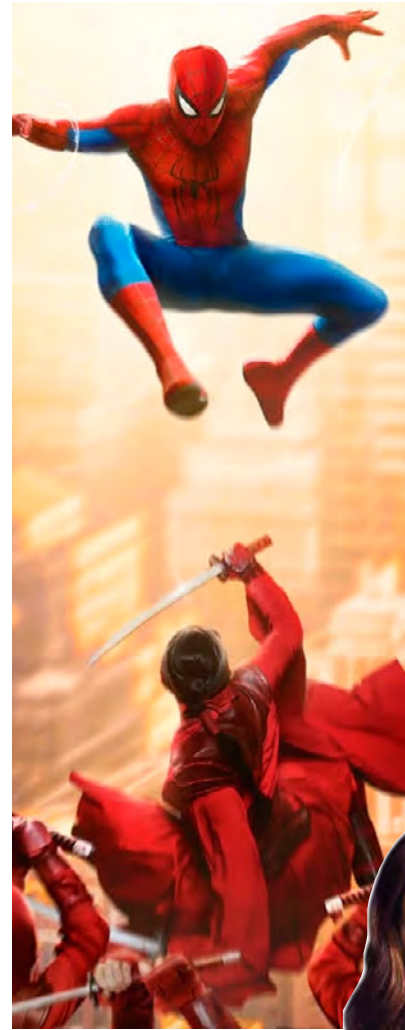
