INDIAN CITIZEN INJURED IN DRONE ATTACK IN UAE

Dubai (TSIT) An Indian national was injured when he was hit by shrapnel from a drone intercepted by the air defence system in the United Arab Emirates on Wednesday, local government said. The incident occurred near the Umm Al Thuob Industrial Area in Umm Al Qaiwain, one of the seven emirates, state-run WAM news agency reported. The Umm Al Qaiwain Government Media Office confirmed that the relevant authorities in the emirate responded to an incident that occurred near a facility in the Umm Al Thuob Industrial Area, resulting from falling shrapnel following the successful interception of a drone by air defence systems. "The incident led to the injury of one Indian national," the agency quoted the office as saying. Earlier last week, five Indians were injured in the UAE when debris fell in the vicinity of the Khalifa Economic Zones Abu Dhabi (KEZAD) as a ballistic missile was intercepted by the country's air defence system, local media reported on Saturday. Before that, on Thursday, an Indian national was among the two killed in the UAE when debris of missiles intercepted by the country's air defence system fell on a street, Abu Dhabi Media Office reported. Starting February 28, the US and Israel have launched a massive joint attack on Iran and with the Islamic nation's retaliation, it has extended to the entire Gulf region.

UPI OUTAGE: USERS REPORT FAILED TRANSACTIONS ACROSS CITIES

New Delhi, April 1 : Digital payment services faced disruption across India on Wednesday, leaving many users unable to complete transactions through UPI platforms. According to outage tracking platform Downt detector, complaints surged sharply during the day -- indicating a widespread issue. The impact appeared significant on State Bank of India, which saw over 500 outage reports, while UCO Bank recorded around 40 complaints. Overall, UPI-related downtime reports also crossed 40, with numbers continuing to rise as more users flagged issues. The disruption was not limited to a single region, with users from cities like New Delhi, Mumbai, Bengaluru, Jaipur and Pune reporting failed transactions and payment errors. In the case of SBI, the outage appeared more widespread, with complaints also coming in from Kolkata, Guwahati and Chennai. Meanwhile, UCO Bank users facing issues were largely concentrated in New Delhi, Jaipur and Kolkata. Many users took to X to share their experience. While some expressed frustration over failed payments, others were unsure whether the issue was with their bank or their own devices. Several users reported transactions getting stuck midway, while in some cases UPI apps failed to load completely. Responding to the situation, SBI said on social media that a scheduled maintenance activity had been extended till 12:30 pm on April 1. The bank warned that services such as UPI, IMPS, YONO, internet banking, NEFT and RTGS may face disruptions during this period. It advised customers to use alternatives like UPI Lite, eRupee (CBDC) app and ATM services in the meantime, while apologising for the inconvenience caused.

"Hello Kerala" CM Revanth Strikes Political Pitch in Campaign Trail

Hyderabad (TSIT): Telangana Chief Minister A. Revanth Reddy launched an energetic campaign in Kerala, combining cultural connect with sharp political criticism while canvassing support for Congress-led UDF candidates. Opening his speech with "Hello Kerala...", he engaged the crowd in Malayalam and Telugu, praising Kerala as a model state in education, literacy, and human development. He highlighted the legacy of Congress stalwarts like K. Karunakaran, Oommen Chandy, and A. K. Antony for transforming the state into "God's Own Country." Taking aim at the BJP-led Centre and the ruling Left government, Revanth Reddy alleged both failed to deliver development, jobs, and investments. He said while one promotes "communal politics" and the other claims communism, both have resulted in unemployment and stagnation. The Chief Minister raised concerns over migration of



Kerala youth to Gulf countries, urging the Union Government to introduce support schemes for returning workers amid global uncertainties. He also criticized both governments for failing to control inflation and rising living costs.

Reaffirming Congress' commitment to inclusive development, he promised that a Congress-led government would boost investments and create employment opportunities. Adding a lighter touch, he referenced football star Lionel Messi,

saying Telangana brought him to Hyderabad and Kerala could do the same under Congress rule. Concluding with popular Malayalam phrases, he urged voters to back Congress in the Assembly elections, expressing confidence of victory.

THIS IS NOT OUR WAR, STRAIT OF HORMUZ MUST REOPEN: UK PM STARMER

reopen: UK PM Starmer London, April 1 (UNI UK's Prime Minister Keir Starmer on Wednesday sought to clear his stand on the West Asia war, saying the conflict is not UK's war, and reassured the British public that the

UK will not be drawn into the fighting, while outlining a decisive plan to protect national security, energy supplies, and the economy. "This is not our war," Starmer said, "we will not be drawn into the conflict.



That is not in our national interest," as he underlined the fact that the conflict in the Middle East has now entered its second month, prompting urgent action from the UK government. The Prime Minister stressed that UK's priority

is de-escalation and the reopening of the Strait of Hormuz, a critical energy artery in the region. "The most effective way we can support the cost of living in Britain is to push for peace and maritime security in the Gulf," he said.

RAJYA SABHA PASSES CAPFS ADMINISTRATION BILL TO STREAMLINE RECRUITMENT AND SERVICE RULES

New Delhi (TSIT) The Rajya Sabha on Wednesday approved the Central Armed Police Forces (General Administration) Bill, 2026, a key legislation aimed at standardizing recruitment, deputation, promotion and service conditions of senior officers across India's Central Armed Police Forces (CAPFs). The Bill, introduced in the Upper House on March 25, seeks to create an overarching legal framework to regulate Group A General Duty officers and other senior personnel in the forces, addressing what the government described as a fragmented regulatory system that has led to litigation and administrative challenges in recent years. According to the provisions of the legislation, the central

government will be empowered to frame rules governing recruitment, deputation, promotions and service conditions for officers across five CAPFs - the Central Reserve Police Force (CRPF), Border Security Force (BSF), Central Industrial Security Force (CISF), Indo-Tibetan Border Police (ITBP), and Sashastra Seema Bal (SSB). The government may also extend the law to other forces by amending the schedule through notification. A significant feature of the Bill is its overriding authority, which allows the central government to frame rules "notwithstanding any other law, judgment, or court order," while ensuring that existing rules and financial benefit orders remain in force until revised.

'Not even God safe in God's Own Country': Rajnath Singh targets LDF, UDF

Thiruvananthapuram, April 1 : Defence Minister Rajnath Singh on Wednesday launched a sharp political offensive in Kerala, alleging that "not even God is safe in God's Own Country", as he accused both the Left Democratic Front (LDF) and the United Democratic Front (UDF) of corruption and appeasement politics. Campaigning for NDA candidate Vatsala Prasanna Kumari in Paravur, Singh invoked a Biblical analogy, saying Judas betrayed Jesus for silver coins, and alleged that the LDF had "betrayed Lord Ayyappa for gold". He further claimed that those responsible for the alleged gold theft were being shielded, adding that a photograph had surfaced showing a senior Congress leader alongside the accused. The Defence Minister asserted that the



alleged Sabarimala gold theft would be probed by the CBI and demanded strict action against those accused of looting public wealth. Taking aim at both fronts, Rajnath Singh alleged that despite their political rivalry, the LDF and UDF were "two sides of the same coin" when it comes to corruption. "Their flags may be different, but their thinking is the

Amaravati will remain as one and only capital: CM Naidu

Nellore: Chief Minister N Chandrababu Naidu reiterated that Amaravati will remain as one and only capital of Andhra Pradesh state, asserting that no one can shift it "even an inch." He expressed happiness over the passage of the Capital Bill in Parliament granting legal status to Amaravati. Addressing a public meeting during the Pedala Sevalo programme at Vinjamuru in Nellore district today, the Chief Minister said Amaravati symbolizes the self-respect of the people of Andhra Pradesh. He termed the approval of the bill in the Lok Sabha as a matter of pride for the state and said it removes all uncertainties surrounding the capital's future. The Chief Minister thanked Prime Minister Narendra Modi and Union Home Minister Amit Shah, along with leaders of various parties who supported the bill. He criticized previous regimes for creating confusion with a three-capital proposal and alleged that they neglected legislative responsibility on the capital issue. The Chief Minister highlighted that the government is implementing large-scale welfare measures through the Pedala Sevalo initiative on the first of every month. He noted that Andhra Pradesh spends Rs 2,750 crore monthly on pensions, sig-



nificantly higher than neighboring Tamil Nadu. He said schemes like Thalliki Vandanam and Deepam 2.0 are being implemented effectively, with free LPG cylinders and plans to provide piped gas to households. An annual subsidy of Rs 2,400 will be credited to beneficiaries' accounts.

On irrigation, he stated that the Centre has released Rs 1,300 crore for the Polavaram Project, which the government aims to dedicate to the nation before Godavari pushkaram. The Chief Minister announced Rs 34 crore for bringing water from the Somasila canal to Vinjamuru's Patacheruvu and assured that the tank will be filled by October. He praised local efforts in water conservation.

TRUMP TO ADDRESS NATION ON IRAN CONFLICT



Washington, April 1 : US President Donald Trump will address the nation on Wednesday night (Thursday morning, India time) with an update on the ongoing conflict with Iran, the White House said, as fighting involving the US and Israel enters its second month. White House Press Secretary Karoline Leavitt announced the address, saying: "Tune In: Tomorrow night at 9 PM ET, President Trump will give an Address to the Nation to provide an important update on Iran." This would be his first address to the nation from the Oval Office of the White House after the Iran war started on February 28. The address to the nation comes amid intensifying military activity and mounting questions over Washington's next steps. The Trump Administration is signalling two fold approach which encompasses both military resolve and a potential diplomatic opening. The US-Israeli campaign against Iran has stretched into its second month, with recent polling showing growing public unease over the trajectory of the conflict and the risk of deeper American involvement.

TVK flags security lapse for Vijay; letter to MHA sparks row over official name error

Chennai, April 1 : The Tamilaga Vettri Kazhagam (TVK) has written to the Union Home Ministry alleging inadequate security arrangements for its President, actor-turned-politician Vijay, during his ongoing election campaign in Tamil Nadu. The development has triggered controversy after the letter reportedly mentioned the name of a serving Governor instead of a current Union Home Ministry official. In its communication addressed to Union Home Minister Amit Shah, the party claimed that despite Vijay being provided 'Y' category security, the arrangements on the ground during campaign



events were insufficient and raised concerns over his safety as well as that of the public attending the rallies. The issue came to the fore following Vijay's nomination

filing on March 30 from the Perambur Assembly constituency. After submitting his papers, he had planned a series of campaign programmes across Perambur,

Kolathur and Villivakkam constituencies. Party sources said necessary permissions were obtained and a structured campaign plan had been put in place. However, the actor-politician reportedly cut short parts of his campaign, citing inadequate police protection. While he addressed gatherings in Perambur and Kolathur, his scheduled visit to Villivakkam was cancelled at the last minute. TVK leaders claimed that the security deployment was insufficient to manage both the crowd and potential threats, prompting the decision. Subsequently, the party lodged a formal complaint

with the Tamil Nadu Chief Electoral Officer, seeking immediate intervention to ensure proper protection during campaign events. Continuing its escalation, TVK executive C.T.R. Nirmal Kumar is said to have forwarded a detailed representation to the Union Home Ministry highlighting these concerns. Amid this, a fresh controversy erupted when a copy of the letter surfaced in public. The document reportedly referred to Ajay Kumar Bhalla as the Union Home Secretary — an apparent factual error, as he is currently serving as the Governor of Manipur and no longer holds that position in the ministry.

**ERZL REBRAND SPARKS FRESH PUBLIC HEALTH CONCERNS**

Hyderabad TSIT: The relaunch of an electrolyte drink under the name ERZL has triggered renewed concerns among doctors and public health experts, with warnings that brand similarity to Oral Rehydration Salts (ORS) could mislead consumers and pose risks to children.

ORS, a World Health Organization (WHO) recommended formulation, is a proven life-saving treatment for dehydration caused by diarrhoea — a condition that continues to claim over one lakh children annually in India. Medical experts emphasise that ORS is a precise clinical solution and not interchangeable with commercial electrolyte beverages.

The controversy follows earlier concerns over ORSL, a



product marketed by Kenvue, which was criticised for resembling ORS in name and packaging. Hyderabad-based paediatrician Dr. Sivarajani Santosh had raised repeated objections, stating that such similarity could lead parents to use the product in place of medically appropriate ORS.

Subsequently, a case filed by parents and healthcare professionals in the Delhi High Court reportedly resulted in a ban on ORSL and a directive to recall stocks.

**DRIVERS' UNION SUBMITS MEMORANDUM TO BIOENERGY BOARD CHAIRMAN OVER LPG, CNG SHORTAGE**

Hyderabad TSIT: Office bearers of a Drivers' Trade Union, led by Union President S. Dadafir, met S. E. Sudheendra, Chairman of the Karnataka State Bioenergy Development Board, at the Board's administrative office on Tuesday and submitted a memorandum highlighting issues arising from the ongoing shortage of LPG and CNG in the State.

During the meeting, the union representatives explained the severe difficulties faced by drivers due to the shortage, stating that many are forced to wait for days to refill fuel and travel across multiple locations in search of gas. This, they said, has resulted in significant loss of income and hardship in sustaining their livelihoods.

Responding to the concerns, the Chairman informed that the Chief Minister and the



Minister for Food, Civil Supplies and Consumer Affairs are closely monitoring the situation on a daily basis and are taking necessary steps to prevent further shortages.

Welcoming the union's proposal to establish more gas filling stations across the State, Sudheendra noted that the government has already issued orders to set up biodiesel retail outlets. He assured that a similar proposal for expanding gas retail outlets would be brought to the attention of the Chief Minister for appropriate action.

**FOCUS ON WOMEN EMPOWERMENT, EDUCATION AND HEALTHCARE DEVELOPMENT**

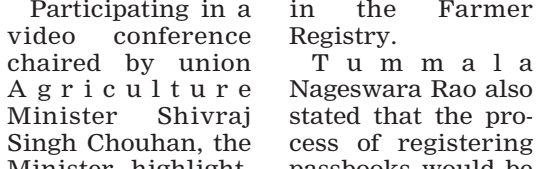

## Jagan terms Amaravati 'capital of corruption'

Amaravati, April 1 : Former Andhra Pradesh Chief Minister and YSRCP President, YS Jagan Mohan Reddy, on Wednesday termed Amaravati as the 'capital of corruption' and accused Chief Minister Chandrababu Naidu of engineering unprecedented and impractical policies to enrich him and his coterie. On a day when the Lok Sabha passed a Bill to give statutory recognition to Amaravati as the sole capital of Andhra Pradesh, Jagan Mohan Reddy addressed a press conference here to lash out at Chandrababu Naidu.

He asked from where Chandrababu Naidu would get Rs 2 lakh crore to build the state capital. He also wanted to know long it would take to complete Amaravati. "When Chandrababu boasted that the capital city is a self-financed model, why were loans taken, allocations made in the budget, which all pointedly speak of the rampant corruption and the layers of scams involved, right from land acquisition to tendering process and the exorbitant rates being given to favoured contractors," the YSRCP chief said. The former Chief Minister



defended the three capitals formula of the YSRCP government saying it was mooted keeping in view the exorbitant cost and with a view to not burdening the people and continuing the welfare and development process. "Visakhapatnam as the executive capital, as it already has the infrastructure and with little investment, it would serve the purpose. For regional balance, we kept Amaravati as the legislative capital and Kurnool as the law capital," he explained. While making it clear that YSRCP is not against Amaravati or any other region, he said they were only opposing the rampant corruption in the name of capital, the neglect of other regions and

welfare and development coming to a grinding halt due to all the focus of the government on Amaravati. He revealed that YSRCP had also given a plan B to develop the Machilipatnam-Vijayawada-Guntur corridor as the capital region, but it was also not considered. "Chandrababu has been going ahead with his corrupt practices and speaking of a capital which is tall in talk, exorbitant in cost and pushes the state into a debt trap. We are concerned about the finances of our state and will expose all the scams," he said. The YSRCP chief alleged that the resolution for the capital city passed in the House was only to divert the attention of the people, as the Centre has nothing to do with the capital

of any state. He pointed out that when Chhattisgarh, Jharkhand, and Uttarakhand were formed, the Centre did not mention the capital cities. He also stated that while passing the resolution, the Legislative Council was not taken into confidence, as this would have exposed CM Chandrababu's corruption. Giving the details of the cost of the five towers being built in Amaravati, YS Jagan said the price being paid to contractors is over Rs 14,000 per square feet, while for quality construction in developed cities the cost is only Rs 4,000 per sq ft. "For flyovers, he has been spending Rs 170 crore per kilometre, while we spent Rs 35 crore per km, which shows the stark contrast," YS Jagan said. YS Jagan stated that when the entire focus is concentrated on Amaravati, other welfare schemes in the fields of education, health, and agriculture take a back seat, and all sections of people are affected. He claimed that the much hyped one lakh acre capital city is now reduced to only 200 acres, as was evident from CM Chandrababu Naidu's recent speech in the Assembly.

## Government Stands by Maize Farmers, Assures Remunerative Prices

The South India Times, Visakhapatnam : The Andhra Pradesh government is fully committed to supporting maize farmers and ensuring they receive remunerative prices for their produce, said State Agriculture Minister Kinjarapu Atchannaaidu. ## Telangana Minister seeks urgent additional LPG supplies from Centre for autorickshaws

**HYDERABAD:** Telangana Civil Supplies Minister N Uttam Kumar Reddy on Tuesday urged Union Minister for Petroleum and Natural Gas Hardeep Singh Puri for urgent additional LPG supplies by the Centre in view of shortages being faced by LPG autorickshaws in the state, mainly in Hyderabad. In a letter addressed to Puri, Reddy said the domestic LPG supply is being maintained at 10 per cent to meet essential household needs, and commercial LPG allocations are being regulated in accordance with the Union government's guidelines. However, the auto LPG segment in Telangana has been significantly impacted, he said.

A large number of autorickshaws in the state operate on LPG and as per available data, around one lakh LPG autorickshaws are plying in the state, he said.

The auto LPG distribution network in Telangana comprises both PSUs and private operators, with PSUs, including IOCL,



and BPCL, collectively accounting for a share of 20 per cent operating 33 outlets, while private operators operate network of 110 outlets accounting for 80 per cent market share.

"Due to prevailing supply constraints, there is a shortfall of around 55 MTs per day of auto LPG, the majority of private outlets are facing a dry-out, leading to disruptions in public transport services and consequent public disorder," Reddy said.

Reddy urged the union minister to ramp up auto

LPG availability at PSU outlets and immediately issue instructions to IOCL, HPCL and BPCL to support the private marketing companies by supplying the deficit LPG to private entities engaged in auto LPG distribution.

While the current price of auto LPG at public sector outlets is Rs 75 per litre, the private marketing companies are selling at Rs 93 per litre, he said, adding regulatory measures should be put in place to prevent unwarranted price increase by private entities during the crisis.

# World Autism Day: Expert Calls for Early Detection and Awareness

Hyderabad: As the clock strikes midnight tonight, landmarks across the globe will glow in brilliant blue – a symbol of unity on World Autism Awareness Day, observed every April 2nd since 2008 under the United Nations banner. Here in Hyderabad, at KIMS Cuddles, we join this movement not just with lights, but with knowledge and compassion. As a pediatric neurologist with over a decade of experience in neurodevelopmental disorders, I've witnessed firsthand how early awareness can rewrite the story of countless children and families. Today, I share my insights to dispel myths, highlight hope, and urge you – parents, educators, and communities – to become part of the solution. Autism Spectrum Disorder (ASD) is more than a diagnosis; it's a lifelong neurodevelopmental condition that shapes how individuals perceive and interact with the world. Globally, the Centers for Disease Control and Prevention (CDC) estimates that 1 in 36 children (up to) is identified with ASD, with boys diagnosed four times more often than girls. In India, while exact figures are elusive due to underdiagnosis, studies from the Indian Academy of Pediatrics suggest prevalence rates around 1 in 100 urban children. The "spectrum" nature means no two cases



are identical: some children might excel in pattern recognition or memory but struggle with social cues, while others face profound communication challenges alongside sensory sensitivities. From my clinic at KIMS Cuddles, I've seen the subtle red flags emerge as early as infancy. Parents often recount how their toddler avoided eye contact during play, fixated intensely on spinning objects, or melted down over changes in routine – like a preferred toy being moved. Delayed speech milestones, such as not babbling by 12 months or losing acquired words by 18 months, are common. Repetitive behaviors,

like hand-flapping or lining up toys meticulously, and sensory quirks – hypersensitivity to lights, sounds, or textures – paint the picture. If your child lines up cars obsessively instead of pretending to drive them, or shies away from cuddles, these aren't just quirks; they could signal autism. Early screening tools like the Modified Checklist for Autism in Toddlers (M-CHAT) can flag risks before age two, opening doors to intervention that dramatically improves outcomes. Yet, stigma and misinformation hinder progress. Let me bust some pervasive myths head-on. No, vaccines do not cause autism – exhaustive studies, including a landmark Danish cohort of over 650,000 children, confirm this unequivocally. Parenting styles aren't to blame either; autism stems from a complex interplay of genetics (over 100 genes implicated) and early brain development factors, possibly influenced by prenatal exposures. And crucially, autism isn't a "disease" to cure. It's a different wiring of the brain, often accompanied by extraordinary gifts: hyperfocus leading to expertise in math, music, or art. Think of historical figures like Albert Einstein or modern icons like Temple Grandin, whose autistic traits fueled groundbreaking contributions.

## Why A 'Defeat' Is Now Essential For The Disoriented Left In Kerala

An expression attributed to King Louis XV of France is "Après moi, le deluge" (After me, the deluge). Kerala Chief Minister Pinarayi Vijayan's desperate attempts to cling to power with a public relations overdrive might be reminiscent of the nihilistic statement. For, the Communist Party of India-Marxist (CPI-M), which the octogenarian has been leading since 1998 in Kerala, is showing clear signs of decay.

The undivided Communist Party, which came to power democratically in the first election held to the state Assembly in 1957, has been an integral part of Kerala politics ever since. However, unlike its uninterrupted 34-year stint in West Bengal, the Left had never managed to win a successive term in Kerala until 2021, when Vijayan managed to buck that trend. The initial euphoria notwithstanding, a section of the Left base in Kerala has been increasingly vocal about leaders getting drunk on power and using all means to perpetuate it.

**Bengal Redux?**  
In Gangster State: The Rise And Fall of the CPI-M in West Bengal, author Sourjya Bhowmik uses the iconic lines "it was the best of times, it was the worst of times" from Charles Dickens to describe the final term of the party in Bengal. He recalls how the party went from its peak to getting decimated in 2011, wondering if the youth were drawn to it due to ideology or were driven merely by power. Such a situation has also been brewing in Kerala for a while now, shaped by the trappings of power and visible loss of Communist values.

So much so that poet and Kerala Sahitya Akademi president K Satchidanandan himself came out publicly demanding that the Left should stay out of power for a term to regenerate itself. This was reminiscent of poetess Mahaswetha Devi publicly questioning the Buddhadev regime in West Bengal in 2007. Satchidanandan's exhortation has since come to vertically split Kerala's literary and cultural space. Noted litterateurs Sarah Joseph, Kalpetta Narayanan, and MN Karassery have all reiterated his prophecy that the Left will be beyond salvation in the state if it gets another term.

### A String Of Desertions

Satchidanandan was particularly critical of Vijayan's appeasement of community leaders like Vellappally Natesan, despite the latter making several sectarian statements against the Muslim community. The rot the CPI-M is seeing in Kerala has been visible even in the electoral arena, with several veteran leaders across the state deserting the party ahead of the polls. These include G Sudhakaran, the seniormost leader of the party outside Malabar, and the duo of TK Govindan and P Kunhikrishnan in Kannur. Those who quit have referred to ideological issues, such as an alleged right turn of the party under Vijayan's stewardship, along with nepotism and corruption.

It was inconceivable even a decade ago that there would be desertions (likened to apostasy in the past) in the CPI-M's Kannur unit, where tribal kinship to the party trumped every other societal connection. G Sudhakaran's quitting, who had served as minister under Vijayan during the first term, came as a jolt to the party in its cradle in Travancore.

If P Kunhikrishnan's rebellion in Kannur was sparked by corruption perpetuated by Payyannur MLA PI Madhusoodanan, his candidature as an independent (supported by the Congress) was prompted by the CPI-M's refusal to act against the erring leader. Veteran TK Govindan's exit was a reaction to the candidature of PK Shyamala - wife of namesake MV Govindan, the CPI-M state secretary - thrust down the Kannur district committee by the party. In fact, this is a repetition of the 2021 arrangement when the CPI-M-nominated R Bindu - wife of then state secretary A Vijayaraghavan in Irinjalkkuda - was elevated as minister, along with PA Mohammed Riyas, son-in-law of Vijayan.

## 'Go Get Your Oil': Is Trump About To Cut And Run On His Own War?

Iran's stubborn resistance and its ability to withstand the US and Israel's relentless military campaign for over a month have disrupted Donald Trump's calculations. The war's increasing economic and political costs have pushed him to seek a quick exit. He now wants to leave Iran in two to three weeks, whether or not there is a deal. His comment, ahead of a national address on Wednesday evening, underlines a stark reality: even after losing its leadership and suffering significant damage to its military and economic infrastructure, Tehran has shown no signs of being as desperate as Trump to end the war.

In his latest comment at the Oval Office on Tuesday, Trump insisted again that Iran was "begging" for a deal, adding that whether it happens is irrelevant to America's timetable. Iran strongly denied that it was engaged in negotiations with the US to reach a deal, while admitting that messages had been exchanged between the two sides. Iran's president, Masoud Pezeshkian, has said his country has the "necessary will" to end the war with the United States and Israel as long as certain conditions are met. Trump's comment came amid a growing buildup of US forces in the Gulf. Thousands of US Marines have already reached the region and many more are on their way. The US military also began flying B-52 bomber missions over Iran on Tuesday for the first time in the war, a sign that Trump is keeping the option open of escalating in the belief that it would help end the conflict swiftly.

### Trump's Ever-Changing Wishlist

Trump has maintained that the US has achieved its goal of addressing Iran's nuclear programme, despite roughly 450 kg of enriched uranium still being present in Iran, believed to be hidden in Isfahan. His previous objective of regime change also remains unfulfilled, although he says the regime has already changed. He claims that Iran's new regime is reasonable, disregarding the fact that more hardline elements now appear



to be in control of the country. Some of his Gulf allies, including the UAE and Saudi Arabia, want him to carry on the military operation for that reason. The most important strategic card Tehran has played in the war has been to block the Strait of Hormuz, through which about a fifth of the world's oil and gas passes. The near-closure of Hormuz, along with attacks on US bases and energy targets in Gulf countries, has driven global crude oil prices to \$117 per barrel on Tuesday and the average petrol price in the US to exceed \$4 per gallon for the first time in nearly four years. Now, Trump claims Hormuz is a problem for other countries to handle. Oil prices fell after Trump's comments about leaving Iran.

### Allies No More?

Donald Trump has been angry with America's European allies for their refusal to get more involved in the Iran war, particularly for not sending their warships to protect ships at Hormuz. "Go get your own oil," from

the Strait of Hormuz, Trump said on Tuesday, lashing out at his allies. But his anger at US partners in Europe is not limited to Hormuz. He wants them to join the American and Israeli military in fighting Iran, a war he started with Israel, without any consultation with his allies.

"You'll have to start learning how to fight for yourself, the USA won't be there to help you anymore, just like you weren't there for us," Trump told his European allies in a post on Truth Social on Tuesday.

Two weeks ago, he had angrily declared, "We don't need anybody; we're the strongest nation in the world", adding that his request for assistance in reopening the Strait of Hormuz instead amounted to a "loyalty test of America's allies".

What Trump forgets is that unlike previous US Presidents, he went to war with Iran without building any support at home or abroad. President George HW Bush in 1991 formed a coalition of more than 40 countries when he launched Operation Desert

Shield to free Kuwait from Iraqi dictator Saddam Hussein. Two decades later, his son, President George W Bush, also received support from his allies for launching another war against Iraq, though it was based on the false premise of getting rid of weapons of mass destruction. Europe was part of both coalitions, though the second time, France and Germany didn't join America's war.

### Not Europe's War To Lose

NATO members in Europe have made clear that the current conflict in the Gulf is not their war. They do not feel obliged to join it because no NATO country has been attacked. On the other hand, Iran has been hit by the US and Israel. They have reminded Trump that the only time NATO's Article 5, which states that an attack on one member is an attack on all, was invoked was when the US suffered terror attacks on September 11, 2001, by al-Qaeda. Back then, NATO had joined America in a coalition to invade Afghanistan.

## ON APRIL FOOLS' DAY, A Reality Check For US, Iran And The World

As a new month dawns, the confrontation between the United States, Israel, and the Islamic Republic of Iran has transitioned from a series of shadow plays into a high-stakes war of attrition. What began as a devastating campaign of maximum destruction has evolved into a kinetic reality where the definitions of "victory" and "survival" are increasingly at odds. In evaluating where the conflict stands today, one must look past the daily skirmishes and analyse the diverging strategic goals, the resilience of the Iranian state, and the looming threat of regional devastation.

### A Fundamental Mismatch

At the heart of the current deadlock is a fundamental asymmetry in what each side is fighting for. For the Iranian leadership, the conflict is existential; it reached that threshold on Day One, when the Supreme Leader and much of his family were killed. History suggests that when a regime perceives a threat as a "war of survival", it gains a grim kind of domestic strength. Despite internal dissent and economic hardship, the external pressure from the US and Israel has, for the moment, allowed the regime to consolidate its grip on the military apparatus and the Islamic Revolutionary Guard Corps (IRGC). The "horizontal escalation" doctrine, under which Iran dispersed its military authority in a "mosaic" pattern to independent regional commanders, allowing them to continue the fight, launching missiles and drones even when instructions were unable to reach them from Tehran, has underscored Iran's resilience in the face of severe military adversity. This has been compounded by the Yemen-

based Houthi rebels joining the war on Iran's side, firing missiles to disrupt shipping via the Red Sea and the Bab el-Mandeb strait, "the Gate of Tears". The willingness of Iran and its allies to hit whatever targets they can, and their ability to inflict damage on the prosperous Gulf countries whose "safe haven" image is crucial to their success, has already given Tehran an upper hand and increased the costs to the rest of the world - leading many outside the region to seek a swift end to the war. In contrast, for the United States, this remains a "war of choice". While the rhetoric from Washington is maximalist, the political commitment is subject to the whims of an election cycle and waning public appetite for another "forever war".

This creates a paradox: Iran wins simply by surviving and maintaining its (undoubtedly degraded) effectiveness, which its critics might dismiss as "nuisance value" - specifically its ability to choke the Strait of Hormuz - while the US must achieve a far more overwhelmingly convincing result to claim success. If the month ends with the Iranian flag still flying over its primary naval assets and nuclear facilities, the strategic momentum arguably sits with Tehran.

### A Divergence Between The US And Israel?

But it gets worse. While the US and Israel are aligned in their desire to see a diminished Iran, their tactical endgames have begun to diverge in a way that complicates the coalition's thus far unified front. The Israeli doctrine is clear: For Israel, the Iranian threat is viewed through a permanent, existential lens. Their strategy is often described as "mowing the lawn" - a relentless effort to

degrade Iranian proxies and nuclear capabilities to the absolute minimum. (Hence the assault on Lebanon, where Hezbollah resides, in parallel with the war on Iran.) To Jerusalem, any deal that leaves the Iranian infrastructure, and its network of allies and proxies in the region, intact is merely a stay of execution.

The American calculus is more difficult to figure out, given the extraordinary statements by President Trump, at press conferences and on Truth Social, that seem to change logic, intentions and desired outcomes with dizzying and bewildering rapidity. But inasmuch as one can glean a consistent thread in his pronouncements, it would seem that Washington appears more interested in a transactional halt to the conflict.

The US strategy involves a dual track of building pressure through heavy troop deployments (estimated at 10,000 additional personnel this month) and the threat of targeted strikes on Kharg Island or other energy hubs, to force a diplomatic capitulation. Iran, in turn, accuses the US of proposing negotiations while planning military strikes - a tactic that the Americans have twice used already. (Diplomats from both countries were at the negotiating table under Omani mediation when the current war was launched on February 28.) How then, they ask, can they trust that negotiations will be sincere and not merely a cover for further attacks?

This friction is most visible in the "Hit List" problem. Diplomacy requires a stable interlocutor, yet continued assassinations of high-ranking Iranian officials - the strategy favoured by Israeli intelligence - undermine the very channels the US

might use to negotiate a face-saving exit for both sides. Who will you negotiate with if you kill those who have the authority to negotiate?

### The Case Of The 'Wounded Lion'

As a new month starts and we approach the April 6 deadline set by the Trump administration, the risk of a "next stage" escalation is at its highest point since the conflict began. The deployment of US troops suggests a shift from containment to the potential seizure of strategic Iranian islands and, judging by Trump's latest blood-curdling threats on Truth Social, far worse. However, the costs of such a move are astronomical. Iran's primary deterrent is not its conventional air force, but its ability to turn the Persian Gulf into a graveyard for global energy infrastructure. Should the US or Israel target Iranian power plants or refineries, Tehran is expected to retaliate by targeting desalination plants and oil terminals in the neighbouring Gulf states. This creates a "Wounded Lion" scenario: states like Saudi Arabia and the UAE may privately wish for the US to "finish the job" and remove the Iranian threat forever, yet they are simultaneously the most vulnerable to the resulting blowback.

### Russia And China

The conflict is no longer a regional vacuum. The reports of deepening military cooperation between Moscow and Tehran have begun to change the mathematics of the war. Russia's alleged supply of advanced drone technology and potential electronic warfare support could provide Iran with a replenished toolkit to offset US technological superiority.

## Why 2 Gulf States Want Iran War To Continue - Even As They're Battered By It

When the Kingdom of Saudi Arabia signed the Strategic Mutual Defence Agreement (SMDA) with Pakistan, a number of members of Iran's Strategic community had expressed optimism. Since the agreement had followed Israel's first and unprecedented attacks on Qatar - even if on Hamas members it alleged were being sheltered there - these strategic thinkers felt it would strengthen anti-Israel cooperation and alliance in the region. Some in Iran even expressed willingness to join the alliance, as just a couple of months prior to the SMDA, Iran had fought its first direct war against Israel. It had ended in a stalemate, but it put Iran on notice. No longer was the conflict between the two adversaries in the shadows, fought through proxies. Now, any confrontation would be direct. The current war - named Operation Epic Fury and Roaring Lion by the US and Israel, respectively, has laid that optimism to rest. Since the early days of the war, American media have reported that Saudi Crown Prince Mohammed bin Salman (MBS), the de facto power behind the throne, had been urging the US to go to war with Iran. In public posturing, though, the kingdom has struck a different note. It has called for diplomacy, for easing of tensions between the Kingdom and Iran.

### A Decades-Old Problem

For Saudi Arabia, as indeed for other states of the Gulf Cooperation Council - UAE, Bahrain, Kuwait, Oman and Qatar - Iran has been a threat since the Islamic Republic was born in 1979, and whose ideology and motto has been to import the Revolution. The Gulf monarchies are one of the last absolute monarchies in the world.



Regime survival is prioritised over everything else. Over the decades, Iran has been a challenge to Saudi leadership of the Muslim world, with its support for Palestinians, the import of its ideology, and by propping up proxies in neighbouring Arab countries. Even though Shiites constitute only 13-15% of the entire Muslim world, Iran, with its strategically located proxies, was able to create the Shia crescent, stretching all the way from Iran through Iraq, Lebanon and into Syria. Today, Syria is back in the Sunni fold, but the Saudis have the Houthis close to their borders, with Yemen on one hand and the Popular Mobilisation Forces of Iraq on the other - both of them Iran's proxies. Moreover, though Saudi Arabia is overwhelmingly Sunni, it has a Shia population inhabiting the very sensitive region where its oil wells are located.

### Be Underestimated

At the same time, Iran, which has been under major sanctions for decades, has proved how battle-hardened it is, first through its eight years of war with Iraq, later with the proxy wars it fought with the US and

Israel, and now in its direct confrontation with both. The Saudis and Emiratis, however, having invested billions of dollars in procuring expensive and modern weapons systems, have practically lost their military campaign against the ragtag Houthis of impoverished Yemen, who have even succeeded in targeting Saudi Aramco.

The 2023 "truce" between Iran and Saudi Arabia, brokered by China, had been a moment of great hope. In hindsight, however, it was only a camouflage for the deep-seated suspicion and the great trust deficit between the two.

### The Post-Oil World

For the Saudis and the Emiratis, the prime concern now is the pursuit of development for a post-oil world. The UAE began earlier, positioning Dubai and Abu Dhabi as the cities of the future, as important trade and logistics hubs and as finance and tax havens. For the Saudis, it is Vision 2030 - moving to a non-oil economy to accommodate the large youth population, and focusing on creating an economy driven by tourism, projects like the NEOM city, IMEC connectivity and

logistical hubs, AI, etc. Constant conflict and the threat of war is a major obstacle to these plans. The Hamas-Israel war, beginning from 2023 October, has been an irritant, and the non-settlement of the Palestinian issue has only played up the ineffective Arab role in the region. Instead, it was the Houthis and Hezbollah - Iran's proxies - who intervened on behalf of Palestinians and demonstrated their ability to disrupt global trade along the Red Sea by closing the Bab-el-Mandeb, a vital waterway for Saudi and Emirati shipping. It is possible that these considerations were at play when, as per the first New York Times report, the Saudi reportedly urged the US to launch an attack on Iran. Now, after the war has actually begun, the Saudis and Emiratis realise just how insecure their defence proximity to the US has rendered them. For decades, their security has been tied to the US, but there is no defence pact between them that would activate American involvement should the Arabs go to war. Neither did the US care to inform them when it went to war with Iran.

## “Tax Plunder on Karnataka”: CM Siddaramaiah Slams Centre

Bengaluru: Karnataka Chief Minister Siddaramaiah has strongly criticized the Union Government over what he termed as “tax injustice,” questioning whether the current system amounts to “tax terrorism” or “tax plunder.”



In a press statement, Siddaramaiah alleged that for every one rupee contributed by Karnataka in taxes, the state receives only 15 paise in return. He stated that while the Centre collected over 4.50 lakh crore from the state in the last financial year, Karnataka received only 79,000 crore.

The Chief Minister pointed out that despite being one of the top contributors to GST—ranking second in total collections and first in growth rate—the state gets only about 52% in return. He blamed the “flawed implementation” of GST for causing significant financial losses to Karnataka.

Targeting BJP leaders, including Basavaraj Bommai and R. Ashoka, Siddaramaiah accused them of remaining silent on the issue when it mattered and failing to defend the interests of Kannadigas.

He further alleged that the Centre has weakened Karnataka’s financial position by denying its rightful share under the Finance Commission, withholding cess and surcharge revenues, and underfunding centrally sponsored schemes. This, he said, has forced the state to rely on borrowing.

Addressing a meeting of the Arya Vaishya community at Sri Vasavi Kalyana Mantapa in Davanagere, Bommai campaigned in favor of BJP candidate Srinivasa Dasakariyappa. He appealed to the community to make a “calculated decision” and ensure BJP’s victory, expressing confidence that the party could end its 30-year losing streak in the constituency.

Davanagere: Former Chief Minister and MP Basavaraj Bommai predicted a fierce political battle for power in May and urged voters to support the BJP in the ongoing by-election.

Citing rising national debt under Narendra Modi, Siddaramaiah noted that the country’s debt has surged from 51.06 lakh crore in 2014 to 214 lakh crore in the 2026-27 Budget, placing a significant burden on citizens, including those in Karnataka.

## “Power Battle in May”: Bommai Urges Voters to Back BJP in By-Poll



Senior leaders including B. S. Yediyurappa and G.M. Siddeshwara were present at the event, expressing confidence in the victory of BJP candidate Srinivasa Dasakariyappa.

The BJP leader claimed that political infighting within the ruling party has only paused due to the by-election and warned of a major power struggle in the coming months. He called on voters to “oust the corrupt government” and bring back a people-oriented BJP.

Bommai alleged that the Congress government led by Siddaramaiah had neglected backward classes and diverted funds meant for their development. He accused the government of misusing resources, including

He has written a letter regarding this on March 30 to Union Railway Minister Ashwini Vaishnaw and Minister V. Somanna.

In the letter, he stated that the Alamatti-Wandal section, part of the Gadag-Hotgi double-line project, has now been completed. During an earlier meeting, it was mentioned that once this work was finished, an express train between

Bengaluru and Vijayapura could be introduced. He has now requested that this be given priority. He highlighted that thousands of people from Vijayapura and Bagalkote districts travel daily to Bengaluru for education, healthcare, administrative work, and business, and this train service would greatly benefit them.

Currently, the train journey between the two cities takes about 15 hours, which is inconvenient. He stressed the need to reduce this travel time to around 10 hours. He also requested that trains departing from Bengaluru be given a limited stop to Hubballi, and that trains proceeding to Vijayapura should be routed via the Hubballi and Gadag bypass lines.

## Renowned Drs from Bangalore drives chickenpox immunization for underprivileged Girls through G.A.U.R.I initiative

Bangalore: Dr. Anuradha Vinod, pediatrician from Manipal Hospital, & Dr Sandesh Alva, pediatrician from Apollo Clinic in Electronics City, Bangalore, have taken a strong step forward to promote equitable healthcare by vaccinating underprivileged girls against chickenpox. This effort was part of G.A.U.R.I. (Generating Awareness on Underprivileged Girls’ Right to Immunization). An initiative by Novo Medi Sciences Pvt. Ltd. focused on improving access to the chickenpox vaccine for girls from marginalized communities. The event was supported by CRY (Child Rights and You), to further strengthen its impact. The initiative encouraged people across the country to show their support for immunization



rights through a simple missed call, and what began as a symbolic gesture of solidarity has grown into a wider movement advocating for preventive healthcare access for deprived girls.

Gaps in protection continue to persist, as several

important vaccines are not covered under India’s Universal Immunization Programme (UIP). As a result, many children miss out on essential vaccinations, including the chickenpox vaccine, which remains outside the programme and therefore out of reach for many families. These disparities are particularly evident in rural regions and among low-income households, where access to comprehensive immunization is more limited compared to urban and affluent communities. This leads to continued variation in vaccine coverage across geographies and socioeconomic groups.

Dr. Anuradha Vinod, pediatrician from Manipal Hospital, Bangalore, shed light on the motivation behind this initiative, stat-

ing, “Chickenpox is a preventable disease, yet many children—particularly underprivileged girls from communities—remain unvaccinated. Ensuring timely immunization for every underprivileged girl child is crucial for building healthier communities. Through the G.A.U.R.I. initiative, the initiative has worked to raise awareness and directly address gaps in vaccine access for underprivileged girls. I am proud to have been part of this initiative, which demonstrates how collaborative efforts with communities can help us protect children from preventable diseases.” Despite the fact that chickenpox is avoidable, many children—especially underprivileged girls from communities—do not have the vaccination.

During his visit to KR Market under the Bengaluru Central City Corporation limits today, he reviewed the situation along with officials and stated that a detailed action plan should be prepared covering proper waste disposal, installation of CCTV cameras, concreting of internal roads, providing proper connectivity to the flower market, and other development works. and the service road has been developed with concrete. In this regard, officials were directed to facilitate smooth vehicular movement from the flyover down ramp at the earliest.

Proper connectivity to the flower market:

## Toll fees hiked upto Rs 40 at 68 plazas across Tamil Nadu from April 1

CHENNAI: Toll fee hikes at 68 plazas across Tamil Nadu came into effect on Tuesday, with charges increased by 3 per cent to 5 per cent on both National and State Highways. The revision applies to 60 toll plazas on National Highways and 8 on State Highways. The increase ranges from Rs 5 to Rs 40, and is expected to have a bearing on transport costs and prices of essential commodities.

The hike has also been implemented at key toll plazas located in the suburban areas of Chennai, including Paranur,

which charges have now been revised at 60. Officials said toll fees at the remaining 17 plazas will be increased from September 1. At the Paranur toll plaza in Chengalpattu district, the fee for cars remains unchanged at Rs 75. However, other categories have seen a marginal increase. Charges for light motor vehicles have gone up from Rs 115 to Rs 120, while buses and trucks will now pay Rs 250 instead of Rs 245. Similarly, the fee for three-axle vehicles has been increased from Rs 270 to Rs 275. Vehicles with more than five axles will



Vanagaram, Athur, Surapattu, Nallur and Patteri Perumbudur, apart from other locations such as Kappalur, Samayapuram and Nanguneri. Tamil Nadu has a total of 77 toll plazas on National Highways, of

be charged Rs 395, up from Rs 385, and those with more than seven axles will now pay Rs 480 compared to the earlier Rs 470. Officials said the annual revision is part of the standard toll adjustment process.

## TAMIL NADU: SPECIAL BUSES TO OPERATE FOR LONG WEEKEND TRAVEL DEMAND

CHENNAI: The Tamil Nadu State Transport Corporations will operate special bus services for the long weekend from April 2-5, including Good Friday, according to the State Express Transport Corporation Managing Director.

With April 2 (Thursday), April 3 (Good Friday), April 4 & 5 (weekend) forming a continuous holiday period, a surge in passenger movement from Chennai and other parts of the State is expect-



ed between April 2 and 4. To manage the anticipated rush, additional buses will be operated alongside regular services. From

Kilambakkam, 575 special buses will be operated on April 2 to destinations including Tiruvannamalai,

Tiruchy, Kumbakonam, Madurai, Tirunelveli, Nagercoil, Kanniyakumari, Thoothukudi, Coimbatore, Salem, Erode and Tirupur. On April 3 and 4, 395 buses will be operated. From Koyambedu, 100 buses will be operated on April 2 to destinations such as Tiruvannamalai, Nagapattinam, Velankanni, Hosur and Bengaluru, while 90 buses each will be operated on April 3 and 4.

## Summer season: Film shooting banned in Ooty Botanical Garden, other parks

CHENNAI: Film shooting has been banned in key horticultural parks in Ooty during the summer season to manage the surge in tourist footfall, said a report by Daily Thanthi.

Known as the "Queen of the Hills," Ooty in the Nilgiris district attracts large numbers of visitors for its tea estates, green landscapes and scenic viewpoints.

The hill station is also a popular filming location, with Tamil, Malayalam, Telugu and Hindi films frequently capturing its mist-covered mountains and natural beauty.

Shooting in horticultural parks across the Nilgiris is permitted on payment of



fees, subject to approval from the Director of Horticulture in Chennai.

The fee is 50,000 for locations such as the Government Botanical Garden, Rose Garden and Arboretum, while tea garden locations are priced at 25,000. These sites are often featured in films for their exotic trees, manicured lawns, glass houses and vibrant flower dis-

plays.

Seasonal restriction

The Nilgiris summer season, spanning April and May, draws lakhs of tourists from across the State and beyond, with flower shows and exhibitions organised as part of the annual festivities.

In view of the heavy tourist inflow, a seasonal ban on film shooting has been enforced for the past

few years in the Botanical Garden during this period.

Ban extended to multiple parks

From Wednesday, the restriction has been extended to eight horticultural parks in the district, including the Botanical Garden and Sims Park.

Horticulture Department Joint Director Navaneetha said that tourist numbers are expected to rise significantly during the season. Flowering plants have been laid out along walkways, and the restriction aims to prevent damage to plants and avoid inconvenience to visitors. He added that film shooting will not be permitted in these parks during April, May and June.

## Supreme Court halts trial against Minister Duraimurugan in disproportionate assets case

"THERE SHALL BE NO FURTHER PROCEEDINGS UNTIL THE NEXT DATE OF HEARING. ISSUE NOTICE RETURNABLE ON APRIL 20," THE BENCH SAID



NEW DELHI: The Supreme Court on Monday stayed trial-court proceedings against DMK general secretary and minister Duraimurugan in a disproportionate-assets case.

A bench of Justices BV Nagarathna and Ujjal Bhuyan issued a notice to the state government on an appeal filed by Duraimurugan, challenging an order of the Madras High Court. "There shall be no further proceedings until the next date of hearing. Issue notice returnable on April 20," the bench said.

The order came after senior advocate Abhishek Singhvi, who represented Duraimurugan in the court, sought a stay on the trial and told the bench that he had been granted similar relief in another case.

The High Court, on April 23 last year, directed a special court in Vellore district to frame charges in accordance with law against Duraimurugan and his family members in the disproportionate-assets case.

The High Court had passed the order while allowing revision petitions filed by the Directorate of Vigilance and Anti-Corruption (DVAC), challenging an order of the special court discharging Duraimurugan and his family members from the case. The High Court judge had said since the check period in the case was between 1996 and 2001, the special court was directed to dispose of the matter within six months by conducting the trial on a day-to-day basis.

The prosecution's case was that Duraimurugan amassed wealth to the tune of Rs 3.92 crore in his name and in the names of his relatives, disproportionate to his known sources of income, when he held the Public Works Department (PWD) portfolio between 1996 and 2001.

On February 23, 2007, the special court discharged Duraimurugan, his wife D Santhakumari, brother Durai Singaram, son DM Kathir Anand (the Lok Sabha MP from Vellore currently) and daughter-in-law K Sangeetha from the case registered in 2002 under the provisions of the Prevention of Corruption Act. Challenging this order, the DVAC filed the revision petitions in March 2012.

## Experts Assure Safety of Beta-Blockers Amid Concerns Over Potassium Levels

In response to a recent alert from the Indian Pharmacopoeia Commission (IPC) regarding the potential risks associated with beta-blockers, medical experts have come forward to clarify the safety profile of these widely prescribed medications. They emphasize that beta-blockers are generally well-tolerated and do not commonly lead to low potassium levels, a condition known as hypokalemia. Beta-blockers, including commonly prescribed medications such as Metoprolol,



Propranolol, and Atenolol, are primarily used to manage conditions such as hypertension (high blood pressure) and irregular heartbeats. These medications work by blocking the effects of adrenaline on the heart and blood vessels, resulting in a decrease in heart rate and blood pressure. They are often prescribed to patients with cardiovascular issues and have been a staple in treatment protocols for decades.

The IPC, an autonomous body under the Union Health Ministry, issued a warning earlier this week, stating that beta-blockers could potentially cause serious risks of hypokalemia. This alert has raised concerns among patients and healthcare providers alike, prompting a wave of anxiety regarding the safety of these medications. Dr. Rajeev Jayadevan, Chairman of the Kerala State IMA Research Cell, addressed these concerns in an interview, asserting that beta-blockers are not commonly known to cause low potassium levels. He noted that patients who are taking only beta-blockers are "extremely unlikely" to develop hypokalemia. Instead, he pointed out that low potassium levels are typically associated with the use of diuretics, such as

hydrochlorothiazide and furosemide, which are often prescribed alongside beta-blockers for patients with high blood pressure.

"Low potassium levels can be caused only in people who use diuretics," Dr. Jayadevan explained. "Diuretics help reduce fluid buildup in the body, and they can lead to the loss of potassium. Therefore, it is crucial to consider the entire medication regimen when assessing the risk of hypokalemia."

Symptoms of hypokalemia can range from mild to severe and may include muscle weakness, fatigue, heart palpitations, and elevated blood pressure. In severe cases, low potassium levels can lead to dangerous heart rhythm abnormalities. However, Dr. Jayadevan reassured patients that those taking beta-blockers alone are at minimal risk for developing this condition. Cardiologist Dr. Ashwani Mehta, from a city-based hospital, echoed Dr. Jayadevan's sentiments, calling the IPC's alert unnecessary and potentially panicking patients. "We have been using beta-blockers extensively in our country for the last 25 to 30 years," Dr. Mehta stated. "Rarely have any of our patients developed hypokalemia, unless there are serious comorbidities that con-

tribute to the condition."

Dr. Mehta emphasized that the alert could create undue fear among patients who rely on beta-blockers for managing their heart conditions. "I do not think that beta-blockers can cause significant hyperkalemia. They are one of the very well-tolerated drugs," he said. "This alert has created panic in the general public, which is really not required."

The IPC's warning prompted healthcare professionals to closely monitor patients on beta-blockers for any potential adverse reactions, including the possibility of low potassium levels. However, experts are urging caution and reminding both healthcare providers and patients that the risk associated with beta-blockers is minimal, particularly when used appropriately.

In light of this situation, medical professionals are encouraging patients to maintain open lines of communication with their healthcare providers. Patients should feel empowered to discuss any concerns they may have about their medications, including beta-blockers. It is also essential for patients to inform their doctors about all medications they are taking, including diuretics, as this can help healthcare

providers assess the overall risk of hypokalemia and make informed treatment decisions.

Moreover, healthcare providers are advised to monitor potassium levels in patients who are on diuretics, especially if they are also prescribed beta-blockers. Regular blood tests can help ensure that potassium levels remain within a healthy range, allowing for timely interventions if needed.

As the healthcare community navigates this alert, it is crucial to balance patient safety with the need to avoid unnecessary alarm. Beta-blockers have been a cornerstone in the treatment of various cardiovascular conditions, and their benefits often outweigh the potential risks when used correctly.

In conclusion, while the IPC's alert regarding beta-blockers and potassium levels has sparked concern, experts in the field are reassuring patients that these medications are generally safe and well-tolerated. The key takeaway for patients is to remain informed, communicate openly with healthcare providers, and adhere to prescribed treatment plans. By doing so, patients can continue to manage their health effectively without undue worry about the risks associated with beta-blockers.

Every time a patient suffering from a chronic disease like diabetes, hypertension, thyroid disorder or, for that matter, obesity consults me, I always ask, "At what time do you go to bed?" And the reply usually startles me. Most of my patients tell me that they go to sleep after midnight, some even as late as one or two o'clock.

Next morning, they have a hectic day ahead of them. With no time to spare for exercise and meditation, they are caught in a vicious cycle. Their erratic lifestyle takes a toll on their health. Thus, sleep deprivation has become a serious scourge of the modern times. Many people are suffering its serious consequences. As I listen to the tales of sleep-deprived patients, I am reminded of my childhood days, when we would usually be in bed by 9 pm. Hardly a soul stayed awake after ten o'clock. Our cots were spread under the canopy of a starlit sky, and

we drifted into the dream world in no time. The first rays of the sun would awaken us to begin our day with renewed vigour and vitality. But, alas, those days are long gone and we are paying a heavy price for the progress we have made by cutting down on our sleep hours.

Recently, my wife and I visited New Delhi to attend the marriage of my cousin's daughter. Complying with the laws, the din of the DJ stopped exactly at ten o'clock. At 10.30 pm, the bar was closed. Used to the high-decibel music and non-stop flow of liquor well past midnight at marriage functions, we were mesmerised by the serenity at the outdoor venue. We had dinner in the company of our relatives and friends, whom we had met after a long time, and chatted freely without straining our vocal cords. The marriage ceremony was over well in time, and we woke up mint-fresh the next day to congratulate the newly wedded cou-

ple with wide smiles at the breakfast table. Such is the power and magic of a restful sleep.

Studies show that if you are sleep-deficient, you may have trouble making decisions, solving problems, controlling your emotions and behaviour and coping with change. Children and teenagers who are sleep-deficient may feel angry and impulsive and lack motivation. They may get lower grades and feel stressed.

Patients often ask me that even though their health parameters are normal, they don't feel fit. I tell them to follow the time-tested adage of having adequate exercise, sunlight, sleep and mindful eating. 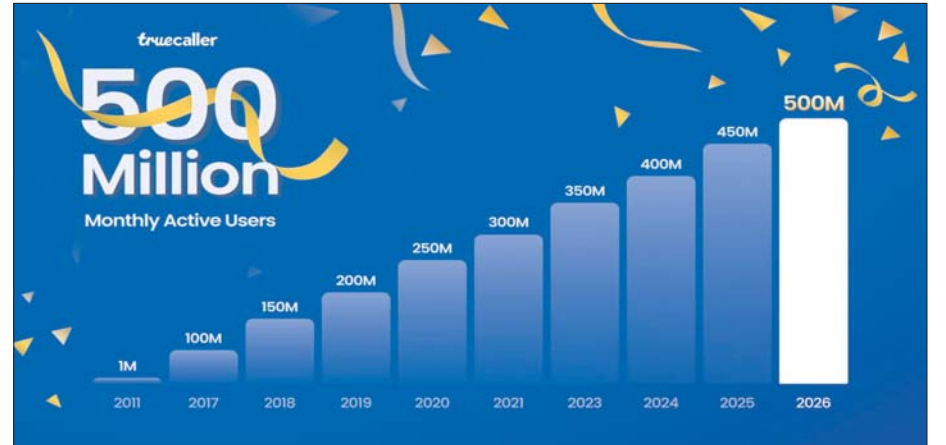

Technologies evaluated included 2G, 3G, 4G, and 5G, reflecting the service experience of users across multiple handset capabilities. The findings of the



IDT have been intimated to all the TSPs concerned.

# Global Headwinds Intensify – Can India Inc Stay the Course

**Mumbai, 1st April 2026:** According to CareEdge Ratings Credit Ratio, which measures the proportion of rating upgrades to downgrades, stood at 1.93 times in the second half of fiscal 2026, lower than 2.56 times observed in the first half. During this period, 363 entities were upgraded and 188 were downgraded. While the credit ratio remains above the 10-year average of 1.55, the moderation suggests early signs of stress amid a more challenging environment. The downgrade rate, at 7%, remains below the long-term average of 10%; however, the moderation in upgrades, from the long-term average of 15% to 13% in the current period, suggests that improvement in credit profiles is becoming more selective. Nevertheless, reaffirmations remained high at 80%, indicating that the bulk of the rated universe continues to hold its ground even as the external environment grows more complex. This relative stability is underpinned by the continuing corporate deleveraging trend, as also highlighted in



our Oct. 2025 edition of the Credit Quality Assessment. Total gearing remained low at 0.50 times as of Mar. 31, 2025, compared with Sachin Gupta, Executive Director and Chief Rating Officer, CareEdge Ratings, commented on the evolving economic landscape, stating, "The escalation of the West Asia conflict has added a new and potent layer of uncertainty. Given India's high dependence on energy imports, a prolonged conflict situation could have cascading effects - fuelling inflation, widening the current account deficit, exerting pressure on

fiscal balances, and weighing on growth. In this context, CareEdge estimates that if crude oil were to average USD 100 per barrel in FY2027, GDP growth could moderate to 6.5%, while inflation may rise to 5.1-5.3%." He further added, "While domestic policy measures and relatively stronger corporate balance sheets provide some cushion, the critical question is whether these domestic levers will be sufficient to keep credit quality on course if the global environment deteriorates further. For now, the answer leans towards yes - but the

margin for comfort is narrowing." Amidst the emerging geo-political environment, the credit ratio for the manufacturing and services sector improved to 2.06 times in H2FY26, up from 1.72 times in H1FY26. Ranjan Sharma, Senior Director, CareEdge Ratings (Corporate Ratings), noted, "The upgrades during H2FY26 were fairly broad-based, with key sectors driving the momentum being pharmaceuticals, auto ancillaries, real estate leasing, mid-sized entities in capital goods and agricultural food products, along with hospi-

tality and healthcare in the services space. On the flipside, sectors bearing the brunt of downgrades were small-sized commodity trading and distribution entities, seafood exporters, and paper and paper product companies. The chemical sector continued to face pressure from the twin forces of Chinese dumping and weak global demand. Looking ahead, the sudden outbreak of conflict in West Asia has introduced sectoral vulnerabilities that did not exist around a month ago. Industries like airlines, ceramics, chemicals, glass, fertilizers, oil marketing companies, basmati rice exporters, packaging, tyres, synthetic textiles, gas distribution, cement, paints, semiconductor & electronics, auto ancillaries, and hospitality - face earnings headwinds if the West Asia conflict prolongs. MSMEs, in general, are likely to be the most vulnerable to these shocks. However, Corporate India's deleveraged balance sheets, are expected to provide some cushion in the near term."

# Donald Trump says he's considering leaving Nato as Starmer says UK will host talks on Strait of Hormuz

Donald Trump says "Iran's New Regime President" has asked the US for a ceasefire. In a statement on Truth Social, he does not mention the top official by name, but describes the individual as "much less Radicalized and far more intelligent than his predecessors". He adds: "We will consider when Hormuz Strait is open, free, and clear. Until then, we are blasting Iran into oblivion or, as they say, back to the Stone Ages!!!" The United Arab Emirates (UAE) says five ballistic missiles have been launched from Iran today. There have also been 35 drone attacks, says the update by the country's ministry of defence. This brings the total number of ballistic missiles launched from Iran to 438, and drone attacks to 2,012, it adds. Iran's retaliatory attacks against US allies in the Gulf have continued unabated since the beginning of the US and Israeli strikes on 28 February. In the UAE alone, two members of



the country's armed forces have been killed since then, in addition to one military contractor and nine civilians, the latest briefing says. In his latest written message, Iranian Supreme Leader Mojtaba Khamenei reaffirms support to the leader of Lebanon's Iran-backed armed group Hezbollah, Naim Qassem. The message also expresses "appreciation for Hezbollah's condolences" following the killing of for-

mer Supreme Leader Ali Khamenei, Mojtaba Khamenei's father, on 28 February - the first day of US and Israeli strikes. Mojtaba Khamenei has not been seen in public or featured in Iranian media since succeeding his father on 8 March. Israel, however, had previously vowed, both before and after his succession, that he would be a target. US President Donald Trump said that Mojtaba

Khamenei was "either dead or in very bad shape, because no one has heard from him". Meanwhile, Iran's ambassador to the United Nations in Geneva said that Khamenei's absence from public view was due to "security considerations". "We are heading towards a major, major disruption." That's what Fatih Birol, the head of the International Energy Agency (IEA), is warning. He

tells the In Good Company podcast that shortages of jet fuel and diesel will soon be felt in Europe. "April will be much worse than March", he says, because there were still be some cargoes of oil and gas arriving at ports around the world that had been loaded up before war broke out. "In April, there is nothing," he says, estimating that the loss of oil "will be twice the loss of oil in March". Describing shortages of jet fuel and diesel as "the biggest problem today", Birol says that "we are seeing [the shortages] already in Asia", but this supply issue will "soon" be felt in Europe. Donald Trump's latest warning that he might be thinking of pulling out of Nato clearly stems from a major fit of pique over the reluctance of members to play a more active role in the war with Iran. Put aside for a moment the fact that joining wars of choice beyond Europe was never the purpose of the

alliance, and that the US attacked Iran, not the other way around. The president's disenchantment with Nato has been well known for a decade. Angry over the failure of members to spend 2% of their GDP on defence, Donald Trump came close to pulling out in 2019, according to Nato's former chief Jens Stoltenberg. Trump's ambivalence and occasional outright hostility towards Nato have already led to calls for Europe to take a more leading role. In a report published last week, the MPs and peers that make up the parliamentary Joint Committee on the National Security Strategy, said this should be an increasingly urgent priority. "The UK and its European allies," they wrote, "must develop a clear plan for a transition towards greater European leadership of Nato." Of all the warnings in President Trump's arsenal, leaving the Nato military alliance is among those he's wielded the most.

## US journalist Shelly Kittleson kidnapped in Baghdad



A US freelance journalist has been kidnapped in the Iraqi capital Baghdad, and one of the suspects is linked to an Iran-backed militia, Iraqi and US officials say. Shelly Kittleson was abducted on Tuesday evening, said Al-Monitor, a news outlet for which she has contributed articles. The Iraqi interior ministry said security forces had chased the reporter's abductors in a pursuit that resulted in one of the kidnappers' cars overturning and the arrest of one suspect. A US state department official said an individual with ties to an Iranian-aligned militia group, Kataib Hezbollah, was detained by Iraqi authorities. Dylan Johnson, assistant secretary of state for global public affairs, confirmed the abduction of an American journalist, without naming Kittleson. He posted on X: "The State Department previously fulfilled our duty to warn this individual of threats against them and we will continue to coordinate with the FBI to ensure their release as quickly as possible." It is understood that US officials had contacted Kittleson a number of times to warn of threats against her, including as late as Monday night. The US state department said in a statement to the BBC: "Due to privacy and other considerations, we have nothing further to share at this time."

## Divorced couples in Japan can now share custody of their children



Divorced couples in Japan are now allowed to share custody of their children, after a landmark revision to Japan's Civil Code took effect on Wednesday. Before the amendment was approved by parliament in 2024, Japan was the only G7 country that did not recognise the legal concept of joint custody. Custody was typically granted to one parent - in most cases the mother - who had power to cut off the other parent's access to their children. Domestic and international criticism has been mounting against the sole custody system in Japan, which critics say led many divorcees to become estranged from their children after losing custody of them. Previously, divorcing couples in Japan were free to decide custody and visitation arrangements. But if they went to court over it, custody would only be awarded to one parent. Under the new law, a family court can decide whether to grant sole or joint custody to divorcing couples. Parents who divorced under the old system are also now eligible to have their custody arrangement reviewed by the family court. The Civil Code revision

also mandates child support payments after divorce, allowing the parent living with the child to claim 20,000 yen (£95; \$125) from their ex-spouse every month. Some are hopeful that the changes will help prevent cases of parental abduction, which have come into the spotlight in recent years - especially after allegations made by foreigners with Japanese ex-spouses. In 2023, Japanese table tennis star Ai Fukuhara was accused by her Taiwanese ex-husband of abducting their son. He said she had cut off contact with him and refused to bring their son back to Taiwan. The pair later came to a settlement. During the Tokyo Olympics in 2021, a French father who was based in Japan staged a hunger strike, calling attention to what he said was the kidnapping of his children by his ex-wife. While some see the joint custody bill as a way to solve such controversies, not everyone is supportive of the revision. Some previously told BBC that they feared joint custody would force women to maintain ties with husbands even in cases of domestic violence.

## Mass robotaxi malfunction halts traffic in Chinese city

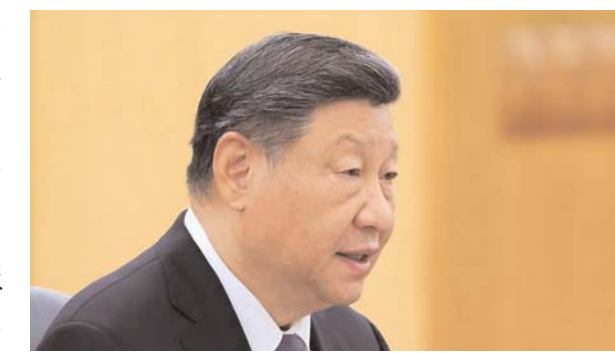


A mass robotaxi outage in the Chinese city of Wuhan caused at least a hundred self-driving cars to stop mid-traffic, sparking renewed debate around the safety of driverless vehicles. Local police said initial findings suggested a "system malfunction" caused multiple vehicles to stop in the middle of the road on Tuesday. Videos on social media have documented the outage, with one appearing to show it

resulting in a highway collision, although police said no injuries had been reported and passengers exited their vehicles safely. Baidu did not immediately respond to a request for comment. According to the police statement, posted on social media site Weibo, the cause of the incident is still under further investigation. ## CHINA IS TRYING TO PLAY PEACEMAKER IN THE IRAN WAR - WILL IT WORK?

As the war in the Middle East enters its second month, choking the world's energy supply and sending oil prices soaring, China is trying to step in as a peacemaker. It comes as President Donald Trump says US military action in Iran could end in "two to three weeks", but there is no clear sense yet of how that will happen or what comes after. China joins Pakistan, which has emerged as an unlikely mediator in the US-Israel war against Iran. Officials in Beijing and Islamabad have presented a five-point plan with the aim of bringing about a ceasefire and re-opening the vital Strait of Hormuz. Pakistan, which has been a US ally in the past, seems to have won over Trump to mediate this conflict. Beijing, however, is



entering the fray as a rival to Washington, ahead of crucial trade talks between Chinese leader Xi Jinping and Trump next month. China's backing on this is "very important," says Zhu Yongbiao, a Middle East expert and director of the Centre for Afghanistan Studies at Lanzhou University. "Morally, politically and diplomatically, China is providing comprehensive support with the

hope that Pakistan can play a more distinctive role." It is also a turnaround for Beijing, whose official response to the war has so far been quite muted. So why is China stepping in now? The peace plan was drafted after Pakistan's foreign minister flew to Beijing to ask for Chinese support for the country's efforts to negotiate an end to this conflict. His efforts appear to have

worked. China's Foreign Ministry said the two were making "new efforts towards advocating for peace." The joint statement agreed that dialogue and diplomacy were "the only viable option to resolve conflicts", and it called for waterways, including the blockaded strait, to be protected. It's not just about oil, although that will be a concern. China, the biggest importer of crude oil in the world, has enough stockpiled to get it through the next few months. Beijing will likely have decided to play the role of peacemaker because the war in Iran jeopardises something Xi covets: stability. China needs a stable global economy as it is heavily reliant on selling goods around the world as it tries to revive an ailing domestic economy.

## Israel intensifies Lebanon attacks and hits areas not in Hezbollah's control

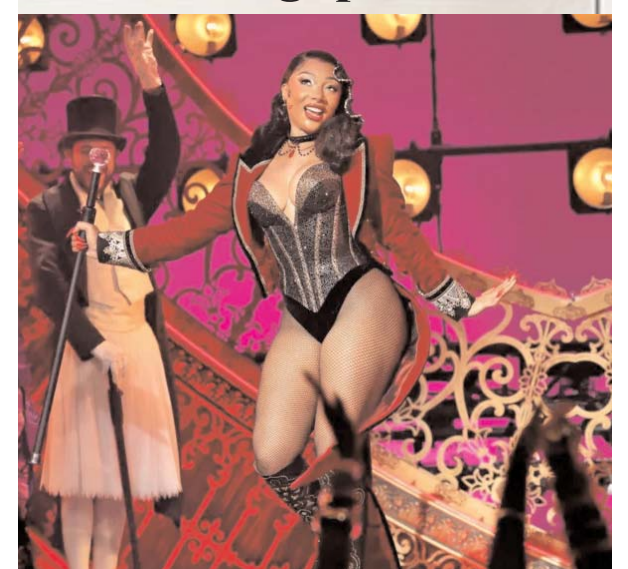
Israel has intensified its attacks on Lebanon this week, hitting areas outside of Hezbollah's control on Tuesday. Strikes without warning hit a vehicle north of Beirut and the Jnah neighbourhood in the heart of the capital. Attacks also continued in the city's southern suburbs and the country's south, both where Hezbollah has a strong presence. A building was destroyed on the road to Beirut's airport after an evacuation order, and in the south, a strike hit a health facility, killing a paramedic, according to Lebanon's health ministry. Israel's military said it had hit Hezbollah infrastructure in



Beirut and killed a senior commander and another senior figure from the Iran-backed armed group. Hezbollah joined the ongoing regional war on 2 March, sending missiles towards Israel, after the US and Israel attacked the armed group's ally Iran on 28 February.

of the capital was attacked after midnight. The Lebanese health ministry said the Al-Zahra Hospital had received and treated "a number of those injured in the air strike". Hassan Jalwan, who lives near Jnah, told AFP he heard several "big explosions" overnight. "Nobody knows what's happening," he said, adding that "displaced people have been sleeping in the open" in the area. The Dahieh neighbourhood to the south of Beirut, where Hezbollah has a strong presence, continues to be a target. A building was destroyed on Tuesday in Gobeiry on the road to the airport following an evacuation order.

May, the Moulin Rouge website says. Ahead of her premiere, she expressed excitement for briefly substituting concerts with theatre performances. But worsening air quality in the Thai city, especially during this time of the year, have prompted them to consider relocating for the sake of their children. Two of their daughters have experienced frequent nosebleeds. "I've been thinking,

maybe we really should move during this time... because if something bad happens to our child, we'll feel terrible forever," Tirayut, 41, told the BBC. Smoke from raging fires have choked parts of northern Thailand this past week, with Chiang Mai ranking among the world's most polluted cities, according to monitoring group IQAir.

setback so surreal is the comparison between Italy's recent European Championship glory and their repeated inability to navigate World Cup qualification. The despair in the stands, the disbelief among pundits, and the raw emotion on the pitch underline a crisis of identity: how can a team capa-

ble of continental brilliance stumble so dramatically on the global stage? The fallout will be fierce-calls for structural reform, tactical reinvention, and a renewed focus on nurturing attacking flair. Yet beyond the technical analysis lies a deeper truth: Italy's absence from the World Cup is not just a sporting disappointment, but the repeated destruction of a football giant. Esmir Bajraktarevic shot the winning spot-kick in Zenica where the Bosnians booked a place in Group B and matches against co-hosts Canada, Switzerland and Qatar, and plunged Italy into a new nightmare.

## 'THAT WAS BAD' - POTTS ON HIS ASHES HORROR SHOW

There were various lows during England's terrible Ashes tour of Australia, many of which have been pored over endlessly in recent months. Few, though, were as brutal as the horror show Matthew Potts suffered in Sydney. Taken apart by Travis Head, he conceded 141 runs in 25 wicketless overs. Had he conceded six more he would have returned the worst figures by an England seamer in Tests. "There's a little period of reflection where you sum up your day's work and look back at it," Potts says, speaking almost three months on. "I just had three words: 'That was bad.'" Potts' first three overs cost 25 runs, while he ended day



two with figures of 0-58 from seven. When he was first brought into the attack on day three, Head pounced immediately, flogging boundaries from each of the Durham seamer's first three

balls. Potts conceded 100 runs after 15.1 overs. He was not used at all by captain Ben Stokes in the second innings as Australia chased 160 for a five-wicket win. "Sometimes you have to roll with the punches," he says. "I got dealt a few punches and I didn't throw too many the other way."

## Raducanu pulls out of another tournament after illness



Emma Raducanu has delayed the start of her clay-court season as she continues her recovery from a viral illness, according to her representatives. The British number one was due to play at the Linz Open in Austria next week, but BBC Sport was told on Wednesday she has withdrawn from the WTA 500 event. It is understood Raducanu, 23, wants to focus on making a full recovery before returning to competitive action on the clay. The world number 28 started feeling unwell while playing during February's Middle East hard-court swing. She competed in Indian Wells last month, but then decided to skip Miami. It has led to another period of uncertainty for Raducanu. Her career has been littered with injury and physical issues since winning the Grand Slam title in New York as a teenage qualifier. Last sea-

son she made encouraging strides, completing a half-century of matches in a season for the first time. But it has been another stuttered start this year. The opening three months have seen a familiar mix: signs of progress, chastening defeats, a coaching change and disruption caused by her health. Raducanu has played six tournaments this season, winning seven of her 14 matches. Four of those wins came in a run to the Transylvania Open final, where she was aiming for a first title since her shock US Open triumph in 2021. Raducanu hopes to return for the Madrid Open, which is the opening WTA 1000 event of the European clay-court season. Raducanu's withdrawal from Linz comes a day after fellow Briton Jack Draper pulled out of the Monte Carlo Masters as he continues his cautious comeback following an arm injury.

## Retirement Loading: Lionel Messi In Tears As He Plays His Final Game In Argentina

In his final game at home, an emotional Lionel Messi struggled to hold back tears as he lined up with his teammates for the last time on Argentinian soil on Tuesday. Messi's Argentina faced Zambia at La Bombonera in Buenos Aires in a friendly, with the former Barcelona star scoring one goal and setting up another. Argentina went on to thrash Zambia 5-0, before beginning the defence of their World Cup crown. Messi, restored to the starting line-up by coach Lionel Scaloni after Argentina's lacklustre win over Mauritania last Friday,

made an instant impact in Tuesday's friendly at La Bombonera. The 38-year-old superstar set up the opening goal for Julián Álvarez before bagging his 116th goal for Argentina with an individual strike just before half-time. Tuesday's game marked a World Cup send-off for the reigning champions, who will face Algeria, Austria and Jordan in Group J of the finals in June. As Messi stood with his teammates on the pitch, the crowd's songs and chants moved him to tears. In a video that surfaced on social media, the Inter Miami forward could be seen wiping

his eyes, realising it was the last time he would play in front of his home fans. Argentina will also play a friendly against Serbia in June and are seeking to arrange another warm-up fixture before the tournament. Messi is firmly expected to captain Argentina into what will be a record sixth World Cup finals as the South American giants target back-to-back titles. The Inter Miami playmaker once again demonstrated his enduring influence on the Albiceleste with a typically decisive contribution in a comfortable win. Álvarez fired Argentina into

the lead after just four minutes when Messi effortlessly controlled a lofted pass on the edge of the area and threaded a ball into the feet of the Atlético Madrid striker to score. Messi doubled Argentina's lead with the 902nd goal of his career two minutes before half-time, working a clever one-two with Liverpool midfielder Alexis Mac Allister before tucking a low finish past Zambia goalkeeper Willard Mwanza. Messi could have added to his tally just after half-time when Argentina were



awarded a penalty following Albert Kangwanda's foul on Thiago Almada.

Initially, there was a change in producers, and we brought new producers on board. - According to the story, the hero needed to look physically strong and powerful enough to take on villains. So I gained weight for the

role. Until then, I had been dieting, but I stopped for this film. I also changed my hairstyle and mustache to achieve a strong look. Working with Dijo is very comfortable, he's calm on set and never seems to lose his temper. - During breaks from shooting, I like to go on vacations. I enjoy traveling and spending time with my family. I don't prefer hectic back-to-back schedules. Taking breaks helps me observe the industry from an outsider's perspective. Although I'm part of the industry, I like to look at it objectively. I've had discussions about several Telugu projects, but none have been finalized. I am currently in a strong position in Malayalam cinema, and moving to another language

might affect those who trust me with projects there. Even without doing a Telugu film, I'm happy that Telugu audiences appreciate my Malayalam movies. - I have previously worked with producers Noufael and Brijesh, who distributed my earlier films. Director Dijo ensured that there were no compromises in anything required for this project. I'm also happy that producers Chaitanya, Chanakya, and Charan from Telugu cinema joined this film. Jakes Bejoy has enhanced the intensity and emotional depth of the film with his music. I've worked with him before, he's an excellent composer. - "Pallichattambi" is a fictional story inspired by incidents from 1950s Kerala. It portrays the social condi-
