**Elderly man duped of Rs 84.5 lac in 'digital arrest'**



**Lucknow:** In a shocking case of cyber fraud, an 85-year-old man from Lucknow was allegedly duped of Rs 84.5 lakh by scammers posing as police and Anti-Terrorism Squad (ATS) officials, who kept him under a prolonged "digital arrest" through threats and intimidation. The victim, Badruddin Ansari, a resident of Janakipuram's Sector-G, approached cyber police after enduring weeks of psychological pressure and financial extortion. According to police, the ordeal began on March 7 when Ansari received a call from a fraudster posing as a senior inspector from Lucknow police headquarters. The caller claimed Ansari's name had surfaced in a money laundering case in Pune and alleged that a fake HDFC Bank account had been opened in his name for illegal transactions.

**Major fire engulfs flats in Ghaziabad housing society, firefighting underway**

**Ghaziabad:** A major fire broke out in a residential apartment at Gaur Green Avenue society in the Abhay Khand area of Indirapuram on Wednesday morning, triggering panic among residents. Thick plumes of smoke were seen billowing from the building as the blaze rapidly spread, with initial reports suggesting that multiple flats were affected. Fire department teams rushed to the spot soon after receiving the alert, and several fire tenders were deployed to bring the flames under control. A resident, identified as Rohit, said around 10 to 12 flats were gutted in the fire. He suspected a possible electrical issue.

## Telangana Govt takes over Hyderabad metro rail from L&T



Hyderabad TSIT BUREAU:

In a significant development, the Telangana government has taken over the Hyderabad Metro Rail, which was previously operated by Larsen & Toubro (L&T). The State had earlier decided to acquire Phase-I of the metro through Hyderabad Metro Rail Limited (HMRL), and discussions with L&T were held over the past few days to finalize the deal. A meeting was held at the State Secretariat on Wednesday, attended by Chief Secretary K. Ramakrishna Rao (Chairman, HMRL), Special Chief Secretary for Municipal Administration and Urban Development Jayesh Ranjan, HMRL Managing Director Sarfaraz Ahmed, and representatives of L&T and L&T Metro Rail (Hyderabad) Limited (LTMRLH).

Following the discussions, a



Share Purchase Agreement (SPA) was signed between the parties. As per the agreement, the Telangana government has acquired 100% equity shares of LTMRLH for a value of Rs.1,461.47 crore. The agreement was signed by Sarfaraz Ahmed on behalf of HMRL, D.K. Sen for L&T Ltd, and K.V.B. Reddy for LTMRLH. Under the agreement, the existing debt of Rs.13,538.53 crore (as

of April 30, 2026), backed by L&T, will be refinanced with a State government guarantee. The transaction advisory services were provided by IDBI Capital, while legal advisory was handled by Saraf & Partners.

TOWARDS BETTER SERVICES AND EXPANSION

The Hyderabad Metro Rail Phase-I has been operational since November 2017, covering three corridors with a total network of 69 km. Currently, the metro serves approximately 4.5 lakh passengers daily, with a cumulative ridership of nearly 86 crore Travelers since inception. With the government taking over Phase-I, better coordination is expected in planning, execution, and expansion of both Phase-I and the proposed Phase-II network. The move is aimed at creating a more integrated, efficient, and commuter-friendly metro system for the city.

L&T CHAIRMAN MEETS CM REVANTH REDDY

Prior to the agreement, L&T Chairman and Managing Director S.N. Subrahmanyam met Chief Minister A. Revanth Reddy. The two held discussions on various aspects related to the metro project and future urban infrastructure development.

## Karnataka continues Jal Jeevan Yojana despite no central funds: Siddaramaiah

Bengaluru (TSIT):

Karnataka Chief Minister Siddaramaiah on Wednesday stated that the state has continued implementing the Jal Jeevan Yojana over the past two years despite not receiving any funds from the Central Government.

Addressing a video conference with Union Jal Shakti Minister C.R. Patil on Jal Jeevan Mission 2.0, the Chief Minister highlighted that significant progress has been achieved in providing rural households with drinking water connections.

Out of 101.31 lakh rural families, 88.06 lakh households have been connected so far, achieving 86.93 percent coverage. He noted that of the 66,344 works undertaken under the scheme, around 48,789 have been physically completed. These include 28,809 works in villages and 19,980 projects in schools and Anganwadis, reflecting a strong focus on rural infrastructure development. Siddaramaiah also pointed out that several regions in the state face issues of arsenic and fluoride contamination in water.

To address this, the govern-



The Chief Minister emphasized Karnataka's efforts in strengthening institutional systems, including the implementation of an Operations and Maintenance policy and the formation of gender-balanced rural water committees.

ment has prioritized improving water sources and implementing large-scale supply systems to ensure safe drinking water. Despite the lack of central support, the state has invested Rs. 17,554.63 crore in the last two

years, including Rs. 8,880.71 crore spent in anticipation of the Centre's share. He termed the delay in fund release as unfortunate and urged the Centre to expedite pending grants. Digital tools such as the Jeeva Jal App, GIS-based asset management, and real-time monitoring are enhancing governance.

Additionally, over 1.51 lakh women have been trained in water quality testing, while independent verification is being carried out by Bureau Veritas. He added that 259 villages have already achieved 24/7 water supply, showcasing the mission's impact.

## CM Naidu urges TDP cadres to increase vote share in next polls



Amaravati (TSIT):

Andhra Pradesh Chief Minister N. Chandrababu Naidu on Wednesday urged party leaders and cadres to strengthen the TDP more at every polling booth level to increase its vote share in the next elections. "In the next elections, we must secure a higher number of votes than we did in the 2024 elections," he said while addressing the party leaders after administering an oath to the new politburo, national and state committees of the TDP at the party headquarters at Mangalagiri. He urged the party leaders to highlight the development works undertaken by the government in the upcoming local body elections. He exuded confidence of a landslide victory in the local body polls. "Remember that the next general elections will be held in just three years.

## Exit polls predict BJP win in Assam, edge in Bengal; DMK to return in TN, UDF to take Kerala

NEW DELHI (TSIT)

Several exit polls on Wednesday predicted a thumping victory for the BJP in Assam and a clear edge for the party over the ruling TMC in West Bengal, while projecting a return of the DMK government in Tamil Nadu and a comeback by the Congress-led UDF in Kerala after 10 years. The pollsters also forecast a return to power for the AINRC-led NDA government in Puducherry.

Axis My India predicted a sweep for the BJP in Assam, forecasting 88-100 seats for the BJP and its allies and 24-36 seats for the Congress and its partners. People's Pulse predicted that the NDA would get 68-72 seats while the Congress plus would secure in the range of 22-26 seats.

Matrize said the NDA is likely to get between 85-95 seats and the Congress and its allies 25-32. The Assam assembly has 126 seats with the magic mark being 64. In Kerala, Axis My India forecast that the UDF would get 78-90 seats, LDF 49-62 and NDA 0-3. People's Pulse predicted that the Congress-led UDF would get 75-85 seats, the LDF 55-65 and the NDA 0-3. Matrize forecast 60-65 seats for the LDF, 70-75 seats for the UDF and 3-5 seats for the



NDA. Kerala Assembly has a total of 140 seats with the magic mark being 71. In West Bengal, the People's Pulse exit poll predicted that the TMC would get 177-187 seats, BJP 95-110, Left Front 0-1 and the Congress 1-3.

Matrize, however, predicted a BJP edge in the state, and said it is likely to get 146-161 seats. It said the TMC would get 125-140 seats. P-Marq predicted 150-175 for the BJP and 118-138 to the TMC. West Bengal has a total of 294 seats with the majority mark being 148. In Tamil Nadu, the People's Pulse predicted 125-145 for the DMK-led alliance, 65-80 for AIADMK-BJP and 18-24 for TVK. Matrize forecast that the DMK-Congress would get 122-132, NDA 87-100 and TVK 10-12. The Tamil Nadu has a total of 234 seats with the magic mark being 118. Most exit polls have had a chequered history and have been off the mark on several occasions in the past. In Puducherry, Axis My India predicted 16-20 seats for the NDA and 6-8 for the DMK-Congress.

## Next milestone South Asia league: CM Stalin

CHENNAI: Chief Minister MK Stalin, on Tuesday, hailed Dravidian governance as the secret behind the State clocking 10.33 per cent growth in 2025-26 and setting a record by registering double-digit economic growth for the second year in a row, asserting that Tamil Nadu is now ready to compete with South Asian countries, not just other states in the nation.

The Chief Minister said that the accomplishment was "just the beginning" and that more achievements would follow with people's support, hinting at winning a mandate in the April 23 election, with vote-counting on May 4.

Tamil Nadu was synonymous with "achievement,"

Stalin said. The Dravidian model was unique as it matched what it says with statistics, he added.

"Having laid the foundation in the first three years (of DMK rule), we have now achieved a record of double-digit growth for two consecutive years. Thanks to the people of the State for supporting our excellent administration and hard work. This is just the beginning. With your support, we are sure to reach many more heights," the Chief Minister said on 'X'.

In its pursuit of excellence, Tamil Nadu's competition was not with other Indian states, he said, asserting that "the State should rise as a leading state in South Asia."

## BENGAL POLLS: VOTING PICKS UP PACE, 39.97 PC RECORDED IN 1ST FOUR HOURS

Kolkata (TSIT)

The polling percentage in the first four hours till 11 a.m. on Wednesday in the second phase of West Bengal Assembly elections has been recorded at 39.97.

This is slightly lower than the 41.1 per cent recorded in the first four hours of April 23 voting in the first phase in 152 Assembly constituencies.

District-wise till 11 a.m. East Burdwan district recorded the highest polling percentage at 44.50, followed by Hooghly district at 43.12, Nadia at 40.34, Howrah at 39.45, North 24 Parganas at 38.43, the electoral dis-

trict of Kolkata (Uttar) at 38.39, South 24 Parganas at 37.92 and the electoral district of Kolkata (Dakshin) at 36.78. Incidentally, this polling percentage is substantially higher than the average percentage of 28.10 recorded in the seven-phase 2024 Lok Sabha polls.

On Wednesday, the Union Home Minister called up the Leader of Opposition in the West Bengal Assembly, Suwendu Adhikari, and enquired about the progress of polling in the Bhabanipur Assembly constituency in South Kolkata, which is witnessing a high-profile



contest between Adhikari and Chief Minister Mamata Banerjee.

Meanwhile, sporadic tension continues to prevail in the hyper-sen-

sitive Bhangar Assembly constituency in South 24 Parganas district. A team of the National Investigation Agency (NIA) reached

Meanwhile, the Bharatiya Janata Party (BJP) had demanded repolling at Falta Assembly constituency in South 24 Parganas district, which, during the last couple of days, witnessed a battle of dialogues between the Election Commission of India (ECI)-appointed police observer Ajay Pal Sharma and the Trinamool Congress candidate from Falta, Jahangir Khan.

At Kanchrapara in North 24 Parganas district, the Trinamool Congress councillor from Kanchrapara

Municipality, Kalyan Kar, got into an argument with an Independent candidate for standing within a hundred meters of the polling booth. Finally, the councillor got into a scuffle with an Independent candidate.

Later, the police arrived and brought the situation under control. A Trinamool Congress polling agent was arrested in Nadia's Chapra Assembly constituency by the central forces personnel deployed there. The agent of booth 54 of Chapra Assembly constituency was accused of influencing voters.

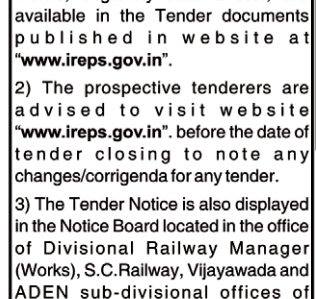

## YSRCP leader Srihari arrested again for abusive social media post

Amaravati, April 29 : YSR Congress Party (YSRCP) General Secretary (Media), Pudi Srihari, has been arrested once again for an allegedly abusive social media post targeting Chief Minister N. Chandrababu Naidu. Police from Kuppam town arrested him in Bengaluru on Wednesday. He was being brought to Kuppam. The arrest came a day after the Supreme Court declined to intervene in Andhra Pradesh High Court's order, suspend-



ing the remand rejection order of the trial court. Srihari, who served as Chief

Public Relations Officer (CPRO) to then Chief Minister Y. S. Jagan Mohan Reddy, had approached the Supreme Court, apprehending arrest after the High Court suspended the remand rejection order given by the trial court in Kuppam. Srihari was arrested on April 15 in Vijayawada in the case registered against him over making objectionable social media posts with morphed images of Chief Minister Chandrababu Naidu.

He was subsequently shifted to Kuppam, where the case was registered against him and another YSRCP functionary Girish Kumar Reddy. Srihari was produced before the trial court on April 16. He was released after the court rejected the petition by the police to send him to judicial remand. Later, the High Court suspended the order of the trial court. The matter was scheduled for further hearing in the High Court on Wednesday.

## Collector stresses focus on drinking water, sanitation and public services

Sangareddy, April 29: District Collector Prateek Jain has directed officials to give special priority to drinking water supply, sanitation, and delivery of public services across the district. During a video conference held at the Collectorate on Wednesday, the Collector reviewed key issues with sub-divisional officers, Tahsildars, MPDOs, and officials from Mission Bhagiratha, housing, electricity, and municipal departments. He issued several instructions aimed at improving basic services and governance. The Collector emphasized that there should be no shortage of drinking water in any part of the district. Reviewing the supply situation



with Mission Bhagiratha Superintending Engineer Raghuvver, he examined bulk supply, pumping issues, and grid-related concerns. He advised citizens to contact the 1916 toll-free helpline in case of water supply problems. He also instructed electricity officials to closely monitor feeders to prevent power interruptions during the summer season.

Revenue officials were directed to expedite the processing of Sada Bainama applications by conducting proper inquiries and forwarding files without delay. To improve public service delivery, the Collector ordered a special drive for quick issuance of essential documents such as family member, birth, and death certificates. He also directed audits on the utilization of funds

in municipalities and gram panchayats to ensure transparency. Expressing concern over poor sanitation, he instructed authorities to address garbage accumulation and plastic waste along major roads on a priority basis. Additionally, officials were asked to visit government schools and hostels at least twice a week to identify infrastructure needs and ensure timely repairs. Reviewing the progress of the Indiramma Housing Scheme, the Collector urged officials to motivate beneficiaries to complete construction at the earliest, stressing that proactive efforts at the mandal level would accelerate overall development in the district.

## "Allegations of Court Order Violations and Land Irregularities" - YSRCP Leaders Slam Speaker Ayyannapatru



Visakhapatnam (TSIT) Political tensions intensified in Andhra Pradesh as leaders of the YSR Congress Party (YSRCP) levelled serious allegations against Speaker Ayyannapatru during a detailed press conference held at the party office in Visakhapatnam on Wednesday. They accused him of fostering a "toxic political culture" in North Andhra and defying court directives. YSRCP Visakhapatnam district president K.K. Raju stated that continuing construction activities in violation of court orders poses a threat to democratic values. He condemned alleged attacks

on individuals who attempted to inspect the construction sites, calling them unlawful and undemocratic. He demanded immediate registration of a case and arrest of the Speaker, and urged the police to function impartially. He also warned that the party would seek legal recourse if necessary. Former MLA Petla Umashankar Ganesh criticized the Speaker for allegedly ignoring High Court orders, stating that such actions are unbecoming of a constitutional authority. He alleged that the construction of "Srushti Kshetram" on a government pond is politically motivated and aimed at

personal gains. He termed it "political business in the name of spirituality" and claimed it was intended to promote the Speaker's son politically. He further accused the Speaker of large-scale irregularities in land dealings, claiming that crores were amassed through layouts and land rights. He also alleged illegal tax collections at quarries in the Rolugunta region and attempts to encroach upon nearly 100 acres of endowment lands. The leaders expressed dissatisfaction over the lack of action despite filing complaints with authorities. They stated that they would pursue legal action against the Speaker, officials, and police if required. They reaffirmed their commitment to protecting public assets, safeguarding temple lands, and ensuring enforcement of court orders. Several party leaders, including Anakapalli district president Boddeti Prasad and others, attended the press conference.

## Challenge for Open Debate on Investments and Development in Visakhapatnam

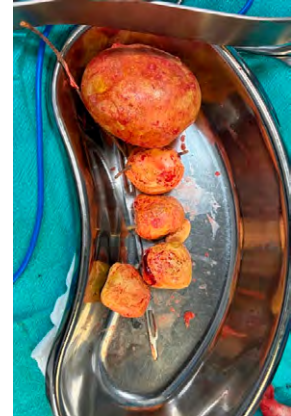
KK RAJU SLAMS COALITION GOVERNMENT



Visakhapatnam (TSIT): YSRCP Visakhapatnam district president KK Raju challenged coalition leaders to an open debate on investments and development in North Andhra. He highlighted that significant investment commitments were secured during the Global Investors Summit held in Visakhapatnam. Raju also criticized Nara Lokesh for making political remarks in the presence of industrialists, stating that it affected the state's image. He remarked that in Visakhapatnam, "V" stands for credibility" under YSRCP, while it signifies "betrayal" under TDP rule. Several party leaders were present at the press meet.

## More than Half Kilogram Stones Removed from 42 year old patient at Vizag by AINU Doctors

Visakhapatnam, April 29, 2026: Doctors at AINU Visakhapatnam pulled off a tough feat when they removed 600 grams of giant stone—from the urinary bladder of a 42-year-old man—which includes an almost the size of tennis ball, along with several smaller stones. Finally, months of gruelling pain and discomfort ended for Mr. G. Raju.



He'd been putting up with it quietly at first. What started as just a slight burning while passing urine slowly grew into something much worse. Over the past few months, things went downhill fast. He felt sharp pain in his lower abdomen and sides, constantly needed to use the bathroom but barely got any relief, found urinating tough, and couldn't get good sleep because of the endless discomfort. The pain wore him down, not just physically but mentally, throwing his whole life off balance.

Years ago, in 2019, Mr. Raju went through serious kidney stone treatments—including major surgeries—so he never imagined this nightmare would return, especially not in such an intense way. But when things got unbearable, he finally reached out to AINU Visakhapatnam. There, the

doctors ran a thorough examination and a CT scan, only to find a jaw-dropping surprise—several large bladder stones, with one huge stone nearly matching the size of a snooker ball. The doctors said stones like this show up slowly, usually because the early warning signs get brushed off, and by the time they're discovered, they bring severe complications. With so many stones and one gigantic one, there was no way to handle the case with minimally invasive procedures. Dr. G. Ravindra Varma, Managing Director and Sr Consultant Urologist, Andrologist, Uro-oncologist, Transplant and Robotic Surgeon led the expert team that decided on open surgery. They opened the bladder carefully,

removed all five stones—including the giant one—and then stitched the bladder back up with care. Post-op, they made sure the healing went smoothly. The whole surgery went off without a hitch. Right after surgery, Mr. Raju felt relief—finally, the symptoms that tortured him for months were gone. His recovery is going well, and he's on his way to getting his life back. This case is a real eye-opener—ignoring early symptoms really can lead to serious health issues down the line. Dr. Ravindra Varma made it clear when talking about the case: too often, people shrug off early urinary problems like burning or mild pain, hoping they'll just go away. But waiting only lets the problem get worse. His advice to everyone? If you feel pain when urinating, notice lower abdominal pain, trouble passing urine, or keep getting urinary infections—see a doctor soon. Catching these things early can spare you bigger problems and even surgery. Dr. Amit Saple, Executive Director and Senior Consultant Urologist, Andrologist & Transplant Surgeon and Dr. P. Sridhar, Consultant Urologist have participated in the surgery.

He urged the public not to believe rumours and avoid panic buying. On Wednesday, the Collector inspected an HP petrol bunk near Rama Talkies in the Resapuvanipalem area. Along with Civil Supplies and Legal Metrology officials, he reviewed the ground situation, checked stock registers, and interacted with the fuel station management. He stated that all 123 petrol bunks across the district are functioning normally and there is no shortage of fuel anywhere. He explained that temporary stock unavailability at one or two outlets in the past week led to misinformation about fuel scarcity. Due to false rumours, fuel sales have increased beyond normal levels,



resulting in queues at some filling stations. The Collector advised citizens to purchase fuel only as needed and avoid unnecessary hoarding. He further assured that oil companies such as Bharat Petroleum, Hindustan Petroleum, and Indian Oil have adequate reserves and supply is continuing without disruption. The situation remains completely normal, he reiterated, warn-

ing that strict action will be taken against those spreading false information. JC Inspection Meanwhile, Joint Collector Gobbilla Vidhyadhari inspected another HP petrol bunk near Polamamba Temple. She reviewed stock levels and assured the public that there is no need for concern, as sufficient fuel supplies are available.

# CM Mamata alleges voter harassment by central forces during Bengal polls

Kolkata, April 29 : West Bengal Chief Minister Mamata Banerjee on Wednesday cast her vote around 4.30 p.m. at a polling booth at Mitra Institution under the Bhabanipur Assembly constituency in south Kolkata and alleged that central forces deployed by the Election Commission of India (ECI) for the second phase of Assembly polls for 142 constituencies had harassed and beaten innocent voters, including women and children, in the name of ensuring free, fair and violence-free polling. She also accused the central forces of deliberately and selectively targeting Trinamool Congress leaders, workers and even polling agents throughout the day under the instructions of police officers appointed by the ECI.



"Is it really a free and fair poll? I have seen the central forces resorting to so many atrocities on polling day. But despite this, I am confident of Trinamool Congress's victory in the Assembly elections this year," the Chief Minister told mediapersons after casting her vote. She is the voter, sitting MLA and Trinamool Congress candidate from the Bhabanipur Assembly constituency, and this time she is pitted against

Khanakul and Goghat areas in Hooghly district. There have been similar incidents in the Canning area of South 24 Parganas district. The atrocities have been going on since Tuesday night," the Chief Minister alleged.

According to her, since the ECI had deployed police officers from other states, and none of them understood Bengali, there had been a communication gap. "Some of these police officers are instructing the central forces to crack down on innocent voters and even some of the Trinamool Congress candidates," the Chief Minister said. There were reports of sporadic tension in Bhabanipur through Wednesday, though there were no reports of casualties or major injuries. At times, central forces personnel had to resort to baton charge to disperse agitated crowds.

# KTR slams CM Revanth Reddy for 'sadistic pleasure' remark

Hyderabad, April 29 : Bharat Rashtra Samithi (BRS) working president K. T. Rama Rao on Wednesday condemned Telangana Chief Minister Revanth Reddy over his reported remark that he derives "sadistic pleasure" when opposition parties criticise him. Addressing a gathering at Telangana Bhavan, KTR termed the reported statement as "shameful" and accused the Chief Minister of being insensitive to public suffering.

He said that people across the state, distressed by what he described as failures of the Congress government over the past two-and-a-half years, are voicing their anger, but the Chief Minister appears to be celebrating such criticism instead of addressing issues.

KTR questioned whether the Chief Minister feels no remorse over the reported deaths of 140



Gurukul students and alleged that the government has failed to ensure basic responsibilities, such as uninterrupted power supply and timely disbursal of Rythu Bandhu benefits. He also highlighted the plight of farmers, stating that paddy is lying exposed to the rains on roads while procurement remains stalled.

"People from all sections are suffering. When the opposition raises these concerns, the Chief Minister, calling it a source of pleasure, reflects

a disturbing mindset," KTR said, adding that the public would ultimately judge such leadership. Earlier in the day, several leaders from different political parties in Kalwakurthy constituency joined the BRS in the presence of KTR.

On the education front, KTR alleged that pending fee reimbursement dues have pushed students into uncertainty, with many colleges reportedly withholding certificates and restricting attendance. Referring to a recent High

Court direction permitting institutions to collect dues from parents, he said students' futures were being jeopardised.

KTR noted that the fee reimbursement scheme, originally introduced during the tenure of former Chief Minister Y. S. Rajasekhara Reddy, was continued effectively during the BRS government, but is now being neglected.

He further alleged that crop procurement across the state has nearly come to a standstill, with farmers unable to sell paddy, maize and jowar. He accused the government of deliberately delaying procurement processes to avoid paying bonuses. Reaffirming the party's stance, KTR said BRS has consistently stood with the people for 25 years, both in power and in opposition, and will continue to fight for public issues and aspirations.

## TELANGANA RELEASES RS 1,000 CRORE TOWARDS PENDING DUES FOR EMPLOYEES

Hyderabad, April 29 : Taking another significant step towards resolving long-pending issues of the government employees in Telangana, the state government has released Rs 1,000 crore towards pending dues. Acting on the directions of the Deputy Chief Minister and Finance Minister, Mallu Bhatti Vikramarka, the funds were released on



Wednesday. Principal Secretary of the Finance Department, Sandeep Kumar Sultania, issued the orders for the release. With this, the Deputy CM has fulfilled the assurance given in the Assembly, said an official release. Last year, during discussions with employee unions, the government had promised to release Rs 700 crore per month.

## Ensure transparency in procurement, says Collector

Nagarkurnool: District Collector Hemant Keshav Patil has directed officials to maintain complete transparency in paddy and maize procurement and ensure that farmers do not incur any losses. During a review meeting on Yasangi paddy procurement held at the Collectorate on Wednesday, the Collector instructed civil supplies officials and millers to carry out procurement in a systematic and farmer-friendly manner. He said paddy brought by farmers should be procured immediately as per quality standards without delay. Emphasizing maize safety, he direct-



ed millers to provide suitable storage spaces and take precautions to protect produce from moisture and rain. Adequate arrangements such as tarpaulins and covers must be ensured to maintain quality. The Collector stressed the need for quick transportation and proper coordination

among departments to avoid prolonged storage at procurement centers. He also directed officials to provide basic facilities including drinking water, shade, weighing machines, and gunny bags for farmers' convenience. He highlighted that transparency must be maintained in moisture testing, weighing, and quality checks. Records should be updated promptly and payments processed without delay. The Collector warned that strict action would be taken in case of negligence and reiterated that protecting farmers' interests remains the government's top priority.

## Rainwater conservation works boost groundwater and irrigation in Tirupati

Tirupati, April 29: Efforts to conserve rainwater flowing through the Seshachalam forests are showing positive results in Tirupati district, with groundwater levels improving under the Jaladhara - Jala Harati programme.

Water conservation works have been underway for the past week in Dodlamitta village of Karakambadi Gram Panchayat in Renigunta mandal. As part of the initiative, 30 works were identified in the mandal with an estimated cost of Rs.2.27 crore. District Collector Dr. S. Venkateswar has so far accorded administrative sanction for 15 works, which include water conservation ponds, fish ponds, and contour trenches.



In Dodlamitta village, a pond measuring 30x30 feet with a depth of two metres is currently under construction with the participation of local labourers. These structures are expected to recharge wells and borewells in nearby villages such as Dodlamitta, Gollapalle, and BC Colony.

The initiative is proving beneficial for agriculture and horticulture, supporting crops like paddy, mango, and groundnut, as well as jasmine, rose, and tulsi cultivation. Farmers say the improved water

availability is enhancing productivity and strengthening livelihoods.

Local resident Tyagaraju said the ponds help store rainwater flowing from forest streams before it reaches the Mallimadugu project. As the stored water percolates, groundwater levels have risen, ensuring sufficient drinking and irrigation water. He added that increased workdays under MGNREGA to 125 days have provided steady employment, with workers earning Rs.305 per day.

Another villager, Aruna, said local employment has reduced migration and enabled families to focus on education and welfare. She noted that the ponds also provide water for livestock, benefiting the entire rural community.

*To Understand UAE's OPEC Exit, Go Back In Time - To A Leaked 'Cable'*

Yesterday, the UAE announced that it was quitting the Organization of Petroleum Exporting Countries (OPEC) and the wider OPEC+, with effect from May 1. For a while, this announcement, so consequential as it is, shifted international focus away from the Iran war. The UAE has been a member of OPEC since 1967, first through Abu Dhabi, the most oil-producing Emirate, and then since 1971 as the seven-emirate federation it is today. The UAE's decision, while certain to trigger a chain reaction in the energy markets, will help keep oil prices down, as it will enable it to produce and export more crude, free from the cartel's constraints. For India, this is good news, as not only is it closely aligned with the UAE on many issues, including energy, but also because of its geographical proximity to the Emirates. One of the reasons for the UAE's decision is, apart from not being constrained in its crude production, to also find buyers closer to it geographically. India is the closest, largest oil importer.

**The Saudi Factor Is Just One Of The Reasons**

The UAE's decision is also demonstrative of its widening rift with the Kingdom of Saudi Arabia (KSA), the founding member and leader of OPEC. Both in quantitative and in terms of trade routes and corridors, the decision will be a challenge to the Saudis, while giving a freer hand to the Emirates and making them less dependent on the former. The current war has battered its economy, with Iran directing more missiles and drones at it than at any other country - including Israel, which, together with the US, started the war. On a broader note, however, surprising as the UAE's decision is, it is also fully in keeping with its strong resolve to forge an independent path for itself, grounded in strategic autonomy. This also translates to breaking with regional, in particular, Arab consensus on many issues. The most recent case in point is the report by Axios that during the war, Israel moved an Iron Dome battery and operating personnel to the UAE's territory, which helped deflect many of the strikes launched on it by Iran.

**That Leaked Cable**

But to understand what drives the UAE's worldview, we need to step back in time. In 2005, according to a cable made public by WikiLeaks, Mohamed bin Zayed, or 'MBZ' as he is more commonly known, had told a United States ambassador, James Jeffrey, that his biggest concern was Wahhabism. It is this concern - coupled with, of course, geography - that has shaped much of the UAE's current policies. MBZ, now the UAE's President, is widely believed to have inherited his appreciation for diversity and religious tolerance from his father and the founder of the UAE, Zayed bin Sultan al-Nahyan. With time, he found political Islam - manifested best in the region through the 'Muslim Brotherhood' - to be incompatible both with that vision and with clan loyalty and leadership. Consequently, by 1994, the UAE became one of the first Arab countries to ban the Dubai branch of Islamist Jamiat-e-Islah, an Islamist group affiliated with the Muslim Brotherhood; a total ban was imposed 20 years later in 2014. In due course, a string of events vindicated the UAE's view.

**Iran Revolution, 9/11, Mumbai Attacks**

First were the twin events of 1979 - the Islamic revolution in Iran, and then the Soviet invasion of Afghanistan with the Afghan jihad that followed. Both upended the existing order, resulting in upheaval and chaos. The overthrow of the Shah put the Gulf monarchies on notice, leading to the formation of the Gulf Cooperation Council (GCC). On the other hand, the Afghan jihad plunged Afghanistan into chaos - something it has not recovered from even today, five decades later. Political mobilisation of any kind thus became anathema to the UAE. This was followed by the invasion of Kuwait by Iraq under Saddam Hussein, and the arrival of Hamas, the extended arm of the Muslim Brotherhood in Gaza, as well as Hezbollah, an Iranian proxy in Lebanon. The NATO wars in Afghanistan and Iraq followed, where the fall of the Saddam government paved the way for sectarian politics and greater Iranian influence there, extending into Syria. However, two incidents that really spooked the UAE were the September 11 attacks in New York and the 2008 Mumbai attacks. If New York could happen - went the thinking - then such attacks could happen inside the Emirates too. Moreover, two of the attackers in the 9/11 were from the UAE. Soon, a number of arrests took place across the country. The Mumbai attacks, where the attackers came by sea, were also a warning for the Emirates, which has a long coastline.

**Here Comes The Arab Spring**

A pivotal moment came with the Arab Spring. The UAE, which had aligned itself closely with the US by then, procuring weapons systems from it and housing US bases on its territory, was deeply disappointed when America, which had for years supported the Hosni Mubarak regime in Egypt, signalled its acceptance of Mohammed Morsi as President when his Muslim Brotherhood party won at the polls. Together with neighbouring Saudi Arabia, the UAE expended considerable effort in seeking the removal of the Morsi government and backing military man Abdel Fattah Al Sisi as President. This paved the way for the UAE's active involvement in other conflict zones, specifically those that threatened to elevate Islamists to power. One example is post-Gaddafi Syria, where the UAE backed the anti-Islamist faction of Khalifa Haftar.

The most decisive intervention, however, was in Yemen in 2015, when Houthi militias, sponsored by Iran, overran the internationally recognised government of President Abdur Hadi Mansour. This came at a time when the US was busy negotiating the nuclear deal (the Joint Comprehensive Plan of Action) with Iran. The thought of a strong, emboldened, sanctions-free Iran, taking over yet another Arab country and jeopardising trade routes along the Gulf of Aden, was a nightmare the UAE did not want to see coming true. With Pakistan unwilling to intervene militarily, the UAE and Saudi Arabia, under a Saudi-led coalition, had to act. The UAE eventually withdrew from Yemen in 2019, after putting in place trained troops in Southern Yemen.

THE 'MARKET FOR LEMONS' IN HIGHER EDUCATION

The rapid expansion of higher education in India has brought opportunities as well as serious challenges. While the number of universities, colleges, and private educational institutions has grown rapidly, questions about quality, transparency, and credibility are constantly being raised. At this time, economist George Akerloff's "Market for Lemons" theory appears highly relevant. According to this theory, when consumers lack accurate information about a product's actual quality, low-quality products dominate the market, and quality products are relegated. In higher education, students are consumers, and institutions are service providers. When students lack accurate information about the actual state of institutions, the quality of faculty, employment prospects, research work, and infrastructure, they are forced to enroll in weak institutions. The expansion of higher education in India has been driven primarily by policy initiatives. The new education policy emphasized increasing enrollment in higher education, encouraging distance learning, promoting online learning, and attracting private investment. This increased access to education and provided opportunities for more students, but the quality of institutions has not improved at



the same pace. Many private institutions attract students with attractive advertisements, grand campuses, and lofty claims, while in reality, they lack qualified faculty, a research environment, and employment-oriented education. Government data is also often delayed or available in complex forms beyond the understanding of the general public. As a result, students and parents are unable to make informed decisions. This situation gives rise to a low-quality education market. To address this problem, the Government of India launched the National Institutional Ranking System. Its purpose is to evaluate the country's higher education institutions based on specific criteria. It considers aspects such as teaching, resources, research, graduate outcomes, inclusion, and reputation. For the first time, this system provided students with a

platform to assess the relative standing of various institutions. This fostered healthy competition among institutions, and many colleges and universities began improving faculty recruitment, research publications, employment support centers, and infrastructure. The most significant achievement of this ranking system has been its ability to provide indicators of quality in the higher education sector. Students no longer rely solely on advertisements or promotional materials, but can make informed decisions based on information such as an institution's status, research performance, exam results, and inclusion. This has somewhat alleviated the problem of information gaps. It has also proven to be an important policy tool for the government, enabling comparative studies of the status of various institutions.

Nevertheless, this system is not a complete solution. Its biggest limitation is that it relies heavily on data provided by the institutions themselves. If an institution provides incorrect or exaggerated information, the credibility of the rankings is compromised. Second, the increased emphasis on research leaves colleges that focus primarily on teaching behind. Third, it becomes difficult for rural or newly established institutions to compete with larger, older urban institutions. Fourth, rankings are released once a year, while students require real-time information more frequently. Fifth, compared to the country's vast higher education infrastructure, only a limited number of institutions are highlighted, leaving many institutions outside of transparent evaluation. Globally, universities in various countries have adopted models for ranking that

also consider factors such as alumni satisfaction, international recognition, employer perceptions, research impact, and global collaboration. India can learn from these experiences by making its system more comprehensive and multifaceted. To protect students' interests, some concrete reforms are necessary. First, the data provided by institutions should be verified by independent agencies to eliminate the tendency to provide inaccurate information. Second, greater importance should be given to teaching quality, student-teacher ratio, employment availability, and profitability over fees. Third, instead of simply assigning rankings, a group-based ranking system should be adopted, so that even small and emerging institutions can receive respectable recognition. Fourth, a centralized digital platform should be developed where up-to-date information about each institution is available. Fifth, state and regional rankings should also be developed to provide local students with better options in their surrounding areas. Sixth, feedback from students and parents should also be included in the evaluation process. Ultimately, higher education isn't just a matter of increasing the number of institutions, but rather a question of quality, trust, and equal opportunity. A lack of transparency will leave students trapped in substandard institutions, jeopardizing their futures. The national ranking system has certainly made a positive beginning, but making it more independent, credible, and student-centric is the need of the hour. Only when accurate information, effective regulation, and quality institutions come together will India be able to move strongly toward becoming a truly knowledge-based, developed nation.

Uco Bank Posts Strong Q4 Growth With 23 % Profit Surge

**KOLKATA, APR. 29:** UCO Bank reported a robust financial performance for the fourth quarter of FY 2025-26, registering a 22.66 per cent year-on-year rise in net profit to Rs.801 crore, compared to Rs.653 crore in the corresponding period last year. The bank's total business rose by 14.95 per cent to Rs.5,90,314 crore as of March 31, 2026. Gross advances grew sharply by 19.44 per cent to Rs.2,62,752 crore, while total deposits increased by 11.59 per cent to Rs.3,27,563 crore. The lender also recorded steady improvement in asset quality, with gross non-performing assets declining by 52 basis points to 2.17 per cent and net NPA falling by 23 basis points to 0.27 per cent. The capital adequacy ratio stood at a healthy 18.61 per cent, including a Tier I capital ratio of 16.59 per cent. CASA deposits rose by 12.46 per cent to Rs.1,17,752 crore, improving the CASA ratio to 38.65 per cent. Savings deposits grew by 11.78 per cent, while current deposits saw a stronger growth of 16.77 per cent. Advances under the retail, agriculture and MSME segments registered a combined growth of 24.23 per cent to Rs.1,52,324 crore. Retail advances grew by 26.62 per cent, agriculture advances by 26.24 per cent and MSME advances by 19.36 per cent. For the full financial year, net profit increased by 13.21 per cent to Rs.2,768 crore, while operating profit rose by 6.49 per cent to Rs.6,429 crore. Net interest income grew by 5.89 per cent to Rs.10,197 crore. Operational efficiency improved, with business per employee rising to Rs.28.08 crore and business per branch increasing to Rs.172.91 crore. The bank's cost-to-income ratio improved significantly to 52.66 per cent. The provision coverage ratio stood at 97.79 per cent, reflecting strong risk management, while the slippage ratio was contained at 0.78 per cent. The bank has proposed a dividend of 4.40 per cent, equivalent to 44 paise per equity share, for FY 2025-26, subject to shareholder approval. As of March 31, 2026, the bank operated 3,412 domestic branches along with overseas branches in Hong Kong and Singapore, and a representative office in Iran. Notably, 61 per cent of its domestic branches are located in rural and semi-urban areas, supporting financial inclusion efforts.

'On Verge Of Stopping': Inside The Panic That Led To Indian Airlines' SOS Call

In 1953, the Air Corporations Act nationalised commercial aviation in India. JRD Tata's airline, which had begun in October 1932 with a single de Havilland Puss Moth, carrying mail from Karachi to Bombay, was taken into state hands. The argument made at the time was that the carriers were small, fragmented, and financially unviable, and that aviation was too strategic to be left to the market. India then had two state airlines and no domestic competition for the next four decades. On April 26, 2026, three private airlines (Air India, IndiGo and SpiceJet) wrote to the Ministry of Civil Aviation, through the Federation of Indian Airlines (FIA), to say that they were on the verge of stopping operations. The argument from 1953 was, in a quiet way, older than they were. That, however, is not the interesting question.

**Only 3 Groups Have Signalled For Help**

The interesting question is comparative. The same shock has hit every airline in the world. Brent has gone from around \$85 a barrel in late February, before the war and the Strait of Hormuz blockade, to around \$150 a barrel. The crack spread - the refining margin between crude and Jet A-1 - has widened with it. The IATA monitor put jet fuel at \$179 a barrel for the week ending April 24, against \$80 in early March. Lufthansa has cancelled 20,000 flights for the summer and permanently retired 27 of its CityLine aircraft. Air France-KLM has raised long-haul fares by EUR 50 per round trip. Cathay Pacific has cut 2% of its scheduled passenger flights and raised its fuel surcharge by 34%. Qantas has delayed an A\$150 million share buy-back. United expects to recover 85 to 100% of its fuel-



cost increase through fares by the fourth quarter. Of the world's serious carriers, only three groups have written to their governments to keep them flying: Spirit Airlines (asking the Trump administration for hundreds of millions to avoid liquidation), the Nigerian operators (who threatened a nationwide shutdown), and the Federation of Indian Aviation's three. India keeps an interesting kind of company. Why can the others absorb a shock that we cannot? The answer is in four pieces, and the cleanest way to see them is on the cost line.

**The Tax Layers**

The first is the tax wedge. ATF sits outside the Goods and Services Tax. It bears central excise of 11% on the base price. State VAT is then charged on base-plus-excise (25% in Delhi, 29% in Tamil Nadu, 16 to 20% across most other major hubs). The cascade is multiplicative. At Tamil Nadu rates, every Re 1 of base-price increase lands on the airline as approximately Rs 1.43; at Delhi, Rs 1.39; at lower-VAT hubs, Rs 1.29. Six states still levy VAT of 18% or more, the Civil Aviation Ministry told the Lok Sabha in February. The taxes being ad valorem, the

absolute pass-through grows with the underlying. No other major aviation market layers tax this way on its single largest input. The second is the unhedged balance sheet. Michael O'Leary of Ryanair said this week that his airline had hedged 80% of its fuel through fixed-price swaps and called itself "the best insulated, most hedged airline in Europe". EasyJet has hedged 70% of summer fuel at \$706 a tonne. Singapore Airlines runs a continuous rolling hedge combining swaps and collars two to three quarters out. Indian carriers, with brief and abandoned exceptions, do not. They also lease most of their fleet under sale-and-leaseback contracts (IndiGo's lessor share is among the highest in the global top ten) with monthly rentals denominated in dollars, alongside dollar-denominated maintenance reserves and a fuel input priced in dollars. Roughly 60 to 65% of operating cost is USD-linked; over 90% of revenue is in rupees, with the fare ceiling on competitive routes set by the marginal entrant. The exchange-rate exposure is unhedged in any scaled, board-approved sense. This is not, in a strict definition, an airline. It is a leveraged

short position on the rupee, written against the price of crude.

**Caught Unprepared**

The third is the missing war chest. IndiGo posted its two most profitable years on record in FY24 and FY25, operating margins in the high teens. Air India, under Tata, narrowed losses sharply and was, by its own reporting, on its strongest financial footing since the acquisition. Where did the surplus go? Into fleet-expansion orders (IndiGo's 500-aircraft Airbus order in June 2023, Air India's 470-aircraft order across Airbus and Boeing the same year), not into balance-sheet buffers. The relevant liquidity ratio for a carrier is fuel-burn days. Cash and equivalents divided by daily fuel-and-lease outflow. Singapore Airlines and Ryanair have, in recent years, run buffers equivalent to several hundred days of operating outflow. Indian carriers, even after their best two years, run at well under a hundred. Decomposed on cost-per-available-seat-kilometre, Indian non-fuel-non-lease CASK is competitive with Ryanair's and below most European legacy carriers'. The fragility is not in operations. It rather sits one line above operations.

## Seven dead in Bengaluru rains; Kumaraswamy seeks permanent solutions

Bengaluru: Union Minister H.D. Kumaraswamy has expressed deep shock over the death of seven people, including children, following heavy rains that lashed Bengaluru on Wednesday. He called on the State Government to implement permanent measures to prevent such tragedies in the future.



In a statement, the Minister said the incident involving the collapse of a compound wall at Bowring and Lady Curzon Hospital was deeply disturbing and heartbreaking. He extended his condolences to the families of the victims and prayed for the speedy recovery of those injured in the

mishap. Kumaraswamy urged the authorities to ensure immediate and comprehensive medical treatment for the injured and provide necessary support to the affected families. He stressed that such incidents occurring repeatedly during heavy rains indicate a failure to learn from past experiences. Raising serious con-

cerns, he questioned how the compound wall collapsed and sought details regarding its construction and maintenance. He demanded a thorough investigation into the incident and called for strict action against those responsible for any negligence. The Union Minister emphasized that offering compensation alone is not

sufficient in cases involving loss of lives. He said the government must focus on long-term structural solutions and preventive measures to ensure public safety.

Highlighting the need for better preparedness, he noted that rain management should be a continuous and proactive process rather than a reactive response after disasters occur. He expressed concern that current efforts appear inadequate and delayed, likening the situation to preparations being made only after a crisis has struck. Kumaraswamy reiterated that effective planning, infrastructure maintenance, and accountability are essential to prevent the

## KASARGOD: POLICE ARREST ONE IN CONNECTION WITH SEETHANGOLI YOUTH'S MURDER

Kasargod, Apr 29: The Kumbala police have arrested a 39-year-old man in connection with the brutal murder of a youth in Seethangoli. The arrested accused has been identified as Srinivas, a resident of Kotekar, Kumbala. The victim, Safayat (30), a resident of Bapalipona and a driver for a poultry transport vehicle, was found dead in a pool of blood in a deserted area near Seethangoli town on Tuesday afternoon. Preliminary investigations suggest that old enmity was the motive behind the crime.

According to the police, Safayat and his friends had consumed alcohol together on April 27, which had led to a minor scuffle. On Tuesday afternoon, Safayat and Srinivas reportedly pur-

chased alcohol from a beverages outlet in Seethangoli and headed to a secluded spot behind a nearby building to consume it. As they were drinking, a heated argument broke out between the two. While two other companions who were present earlier had already left the spot, the confrontation between Safayat and Srinivas turned violent. Srinivas allegedly pushed Safayat to the ground and bludgeoned his head with a wooden plank found at the site. Local residents, who rushed to the spot after hearing screams, found Safayat lying in a pool of blood. Srinivas had fled the scene by then. Although Safayat was rushed to the hospital in critical condition, he could not be saved.

## Extension of Sarala Kaveri Scheme: Golden Opportunity for the Public to Get Water Connections via EMI



BENGALURU : With the objective of protecting public health by providing healthy and pure Cauvery water to all citizens of Bengaluru, as per the wishes of Deputy Chief Minister Shri D. K. 12-month window is provided to pay the remaining 80% of the amount.

Facility for Non-Domestic Consumers: The EMI-based Sarala Kaveri facility has been extended beyond residential homes to include commercial buildings. Non-domestic consumers can now also take full advantage of this initiative. Pure Water to Every Home: Deputy Chief Minister D. K. Shivakumar has made a firm resolve to protect public health by delivering healthy, pure Cauvery water to every home. The scheme has been extended against this specific backdrop.

Providing further information, BWSSB Chairman Dr. Ram Prasath Manohar appealed, "Under the leadership of Hon'ble Deputy Chief Minister Shri D. K. Shivakumar, the BWSSB has always prioritized pro-people programs. This EMI facility will offer massive financial relief to apartments and commercial buildings struggling to pool the full Demand Notice amount at once. The public should make the best use of this scheme. To ensure an adequate and equitable water supply across the city, the Water Board has already implemented several proactive measures, and the extension of this scheme will further benefit the citizens of Bengaluru.

## Karnataka targets major milestones in Quantum City by 2028



Bengaluru (TSIT): Karnataka is set to achieve significant milestones in the development of its ambitious 'Quantum City' project by 2028, according to Minister for Minor Irrigation, Science and Technology N. S. Boseraju.

After inspecting the 6.23 acres of land allotted for the project near Hesaraghatta, the Minister said the state is positioning itself as a global hub for quantum technology. He noted that Karnataka is already a leader in the quantum sector and is now moving towards large-scale implementation of advanced infrastructure.

The proposed Quantum City, also referred to as Q-City, is envisioned as a world-class ecosystem that will host pilot fabrication lines, common computing infrastructure, and cutting-edge research laboratories. The project will also provide dedicated workspaces for startups along with advanced incubation facilities aimed at supporting deep-tech innovation and entrepreneur-

ship. Boseraju stated that the government has already released a comprehensive quantum roadmap to promote research and technological growth. ## Scientists Sequence Arabica Genome, Opening Doors to Climate-Resilient Coffee

The work makes it possible to tell the story of the fusion of genomes that gave rise to the world's most consumed species, as well as identifying genes responsible for resistance to rust and other diseases.

Coffee is one of the world's most traded commodities, and *Coffea arabica* is the most widely consumed of the 130 or so species that exist. It is the result of the fusion of two other species: *Coffea canephora* (known in Brazil as Conilon or Robusta coffee) and *Coffea eugenioides*. In the last decade, almost every major commodity in the world has had a reference genome sequenced, but coffee has only recently joined the list.

The reference genome is essential for developing varieties that are better adapted to climate change and resistant to disease. By sequencing the reference genome of Arabica coffee in an unprecedented endeavor, a consortium of scientists was able to select genes that may be responsible (candidate genes) for coffee's resistance to rust and other diseases. At the same time, they identified the expression of some genes related to the aroma of Arabica. The Power of Genomic Knowledge "With the knowledge of the genome, it is possible to obtain information that allows us to go in two directions: the development of varieties by directing crossbreeding, in other words, as a reference to guide us in future crossbreeding that produces new varieties; and more direct interventions, such as modifying a gene specifically," summarizes Douglas Domingues, currently a



researcher at the Plant Genomics and Transcriptomics Group of the Luiz de Queiroz School of Agriculture at the University of São Paulo (ESALQ-USP), in Brazil, and one of the authors of the paper (developed when he was still working at the Rio Claro campus of the São Paulo State University).

According to him, there was a bit of a race to sequence the genome. "The price of sequencing has come down a lot, and coffee was one of the few commodities that hadn't had its reference genome sequenced. There were other groups trying, and there was a paper published just before ours. But most of them used the standard strategy: choosing an interesting plant for cultivation and sequencing its genome," he reports.

Unique Approach to Sequencing

The group to which Domingues belongs has sequenced a plant that is not interesting from an agronomic point of view but has a lot to offer from a genetic point of view. "The advantage of our reference genome is that it's derived from a 'dihaploid' individual. This results in a homogeneous reference genome that will be a superior standard for future research," explains Patrick Descombes, coordinator of the work and senior expert in genomics at the Nestlé Institute of Food Safety & Analytical Sciences. He explains that Arabica coffee is a tetraploid: it has two genomes in one because it is the fusion of two other species.

By sequencing a dihaploid derived from Arabica coffee compared to a common tetraploid variety, scientists get a clearer and more simplified view of the

genome. This makes it possible to identify variations between similar genes with greater precision, facilitating the use of molecular information for improvement studies.

In this study, the group was able to determine more precisely when this fusion took place: no more than 600,000 years ago, *C. canephora* and *C. eugenioides* fused to form this tetraploid hybrid, which continued its evolutionary path. "We came to this conclusion using DNA information from Arabica, Robusta and *Eugenioides*: we were able to make a more accurate inference because previously this interval was dated at between 50,000 and 1 million years. We reduced that window to 350,000 to 600,000 years," reports Domingues. The article, published recently in *Nature Genetics*, was the result of a consortium of scientists from more than ten countries, including Brazil, which participated with more than one institution. In Domingues' case, his participation was partially funded by FAPESP through a Young Researcher project and a postdoctoral fellowship awarded to Suzana Tiemi Iwamoto-Suzuki, also an author of the article. "We used the reference sequence to understand the diversity that exists in wild Arabica coffees, from the African region of origin, and compare this with the Arabica coffees that are cultivated today," says the ESALQ-USP scientist, explaining that the group resequenced Arabica coffee varieties planted in different parts of the world, as well as wild specimens collected in the forests of Ethiopia, and managed to understand the difference between the wild and cultivated ones.

## A Lunar Orbit That's Just Right for Humanity's First Space Station Around the Moon

A unique halo orbit is the road less traveled around the Moon. As NASA prepares for humanity's long-term return to the lunar surface through the Artemis missions, the agency is introducing novel concepts — backed up by science and decades of experience in human spaceflight — to blaze new trails on and around the Moon.

An international collaboration, Gateway is a human-tended, small station that will orbit the Moon. The lunar outpost is specially designed to enable deep space exploration with many capabilities for maintaining a sustained presence in space and conducting research in a deep space environment. Features like a human habitat, multiple docking ports for a variety of spacecraft, including Orion, and the ability to host experiments that will study space weather will all help contribute to future exploration efforts. Similarly, Gateway's unique near-rectilinear halo orbit, or NRHO, was specifically chosen to help ensure the success of future Artemis missions. There is no shortage of options for how a spacecraft could orbit the Moon, but two in particular — low lunar orbit and distant retrograde orbit — are helpful for understanding why NRHO is the right fit for Gateway. A spacecraft in low lunar orbit follows a circular or elliptical path very close to the lunar surface, completing an orbit every two



hours. Transit between Gateway and the lunar surface would be quite simple in a low lunar orbit given their proximity, but because of the Moon's gravity, more propellant is required to maintain the orbit. Therefore, low lunar orbit is not very efficient for Gateway's planned long-term presence at the Moon — at least 15 years. Meanwhile, a distant retrograde orbit provides a large, circular, and stable (or more fuel-efficient) orbit that circles the Moon every two weeks. However, what Gateway would gain in a stable orbit, it would lose in easy access to the Moon: the distant orbit would make it harder to get to the lunar surface. A third option, NRHO, is just right for Gateway, marrying the upsides of low lunar orbit (surface access) with the benefits of distant retrograde orbit (fuel efficiency).

# Vijay heads to Shirdi after Thiruchendur visit, continues post-poll spiritual tour

Chennai, April 29: Actor-politician Joseph Vijay, founder of the Tamilaga Vettri Kazhagam (TVK), departed for Shirdi on Wednesday, a day after he visited the Thiruchendur temple, continuing his spiritual engagements following the conclusion of polling in the 2026 Tamil Nadu Legislative Assembly election.



Vijay left from his Neelankarai residence in Chennai and proceeded to the airport, where he boarded a private flight from the old terminal at around 11.10 a.m. on Wednesday. He is scheduled to offer prayers at the renowned Sai Baba Temple and is expected to return to Chennai either late Wednesday night or early Thursday morning.

The Shirdi trip comes immediately after he visited the Thiruchendur Murugan Temple on

Tuesday, where he took part in the early morning 'Viswaroopa Darshan'. The temple visit had drawn large crowds and significant public attention, with supporters gathering in large numbers to catch a glimpse of the actor-turned-politician.

Tamil Nadu went to the polls in a single phase on April 23 across all

234 Assembly constituencies, marking one of the most closely watched elections in recent years.

With polling over, several political leaders have stepped back briefly from public engagements ahead of the counting of votes scheduled for May 4.

Vijay's temple visits are being seen as part of a broader personal

and symbolic outreach following his first major electoral test as a political leader. The Tamilaga Vettri Kazhagam contested multiple seats in the Assembly elections, marking Vijay's formal entry into electoral politics after years of speculation.

Observers point out that such spiritual visits often carry political undertones in Tamil Nadu's socio-political landscape, where religion and public life are closely intertwined. Vijay's movements since polling day have been closely tracked, reflecting the heightened interest surrounding his political trajectory. As the state awaits the results, Vijay's back-to-back temple visits – first to Thiruchendur and now to Shirdi – highlight a brief pause from active politics while maintaining public visibility during the post-poll period.

## Release 2.5 TMC water to Tamil Nadu: Cauvery Management Authority directs Karnataka

CHENNAI: The Tamil Nadu government on Wednesday urged the Cauvery Water Management Authority (CWMA) to direct the upper riparian state of Karnataka to release 2.5 TMC of water from the Cauvery basin.



The CWMA meeting, chaired by Saumitra Kumar Halder, was held via video conference.

Representing Tamil Nadu, Water Resources Secretary J Jayakanthan and Cauvery Technical Committee Chairman R Subramanian participated. Officials said Karnataka's primary representative did not attend the meeting, and a nominee participated instead. During the deliberations, Karnataka argued that the excess water released

downstream to Biligundlu, the inter-state border point, should be factored into the overall calculation of water sharing. The state claimed it had released 326.945 TMC between June 1, 2025 and April 27, 2026, compared to the stipulated 174.500 TMC.

Tamil Nadu, however, strongly opposed this position. State representatives argued that surplus water released due to storage con-

straints in reservoirs cannot be counted as part of Karnataka's allocated share. "Karnataka cannot claim credit for excess water released when it was unable to store it in its reservoirs," a Tamil Nadu representative said during the meeting. The storage level of Mettur dam was 42.397 TMC as on April 28, and 1,503 cubic feet of water has been released for drinking water and industrial purposes.

## AMMK urges postponement of Cauvery Management Authority meeting in Delhi

CHENNAI: The AMMK, an ally of opposition AIADMK, on Wednesday called for the immediate postponement of the meeting of the CMA scheduled to be held today in Delhi to discuss the provision of Cauvery water to Tamil Nadu and Puducherry.



In a statement here, AMMK chief TTV Dhinakaran emphasised that any discussion on water distribution to TN and Puducherry should wait until a new political leadership is in place.

"It must be ensured that the meeting takes place only after democratically elected govern-

ments have been established in Tamil Nadu, Kerala, and Puducherry," he said.

Dhinakaran claimed that the Tamil Nadu

farmers' demand to postpone the meeting in Delhi has been rejected, and that the meeting is set to take place as originally planned.

"The results of the recently concluded Assembly elections in Tamil Nadu, Kerala, and Puducherry (excluding Karnataka) have not yet been declared. It is inappropriate to convene the Cauvery Management Authority (CMA) through officials alone and to deliberate on river water-related issues at this juncture," he argued.

Referring to the Karnataka government's proposal to construct the

Mekedatu dam across the Cauvery River, he warned that the project threatens to turn Tamil Nadu's Cauvery delta regions into a desert. "Tamil Nadu's farmers fear that the meeting of the CMA scheduled for today could create an environment favourable to that state".

He said the CMA meeting should be postponed to accede to the demands of TN's farmers and ensure that this meeting is conducted only after a newly elected government is duly formed in the states of Tamil Nadu, Kerala, and Puducherry.

## Married one day, widowed the next: Inside Koovagam festival

KOOVAGAM: "When the society turns us away, Lord Aravan embraces us," said a teenager from the trans persons community. "This is the joyful time of the year for us. Next year, I hope to participate in Miss Koovagam."

Tamil Nadu: Education department issues guidelines for schools to beat the heat in the Tamil month of Chithirai (April-May), the small village of Koovagam near Villupuram comes alive with thousands of brides in vibrant sarees, jewellery and matching bangles, congregating to marry Lord Aravan, also known as Koothandavar. Among them



are members of the trans persons community along with men and even children.

The annual festival at the Koothandavar temple is root-

ed in the legend of Aravan, the son of Arjuna, who agreed to sacrifice his life to ensure victory for Pandavas in the Kurukshetra war.

Before his sacrifice, Lord Krishna took the form of Mohini and married him, only to become a widow the very next day. During the festival, thousands of devotees dress as brides with the finest jewellery and flowers. The streets are lined with shops selling bangles and nuptial thread (thaalis), adding to the festive spirit. "Once a year, we come here, tie the thaali, and experience the joy of being brides. The next day, we remove it as part of the ritual and return to our lives. It's an emotional moment for all of us to stand here and be part of this tradition," said Bavana, a trans woman from Bengaluru.

## Rising heat triggers spike in kidney issues, warn doctors

Hyderabad, April 29: Doctors are raising concerns over a noticeable increase in kidney-related ailments during the summer, warning that rising temperatures can silently impact kidney health. Specialists at CARE Hospitals, Malakpet report a surge in cases of kidney stones, urinary tract infections (UTIs), burning urination, and severe flank pain as heat levels climb.

According to urologists, dehydration during summer is a major contributing factor. Excessive sweating leads to significant fluid loss, and if not replenished, results in highly concentrated urine. This environment promotes the crystallisation of minerals such as calcium, oxalate, and uric acid, eventually leading to kidney stone formation.

Dr. Naveen Kumar, Senior Consultant Urologist and Andrologist at CARE Hospitals, stated that such conditions do not develop overnight but build gradually due to consistent low water intake. He noted that



hospitals witness a clear rise in urology cases with the onset of summer.

Studies suggest that nearly 12 percent of

Indians are likely to develop kidney stones at some stage, with higher prevalence in regions experiencing prolonged heat. Doctors emphasize that apart from dehydration, lifestyle and dietary habits also play a significant role. High salt intake, processed foods, frequent consumption of outside meals, and excessive intake of soft drinks can increase the risk.

Dr. Venu Manne, Senior Consultant Urologist, highlighted that urinary tract infections are also more common during summer. Reduced water intake lowers urine output, allowing bacteria to remain in the urinary tract longer, increasing infection risk.

Vulnerable groups include women, diabetics, men with prostate issues, and individuals with a history of recurrent UTIs. Doctors advise regular water intake rather than relying on thirst signals. They also caution against replacing water with caffeinated or sugary drinks, stressing that adequate hydration is essential to prevent complications.

## Study identifies three patterns of cognitive decline in Alzheimer's disease

A new study has identified three distinct trajectories of cognitive decline in patients at risk of Alzheimer's disease—stable, slow decline, and fast decline—highlighting the variability in how the condition progresses. The research, conducted by scientists at the University of Southern California, analysed brain scans of over 1,100 individuals in the United States who had elevated levels of amyloid protein deposits, a hallmark of Alzheimer's, but were still cognitively unimpaired.

Alzheimer's disease is a neurodegenerative condition in which memory and thinking abilities progressively deteriorate, eventually affecting daily functioning. Brain scans typically reveal abnormal protein build-ups such as amyloid and tau. The study found that individuals who experienced gradual or rapid cognitive decline had higher levels of tau and phosphorylated tau (P-tau217), compared to those who remained stable. Additionally, these participants showed a smaller hippocampus, a



brain region critical for memory and among the first to be affected in the disease. The findings, published in Alzheimer's & Dementia, underscore that Alzheimer's progression is not uniform across patients. Lead author Michael Donohue noted that most studies focus on average outcomes, which can obscure significant differences among individuals. "This suggests that Alzheimer's disease is more variable than often depicted," he said.

Researchers also highlighted that this is among the first studies to link patterns of cognitive decline with biological markers such as phosphorylated tau. Using a combination of blood tests and brain imaging, the team was able to classify participants into stable or declining groups with about 70 per cent accuracy. The findings also point to challenges in early-stage Alzheimer's research, as some individuals may remain stable without treatment, making it harder to assess the effectiveness of new therapies. The researchers suggested that future clinical trials should focus more on individual patterns of decline rather than average results to better understand and treat the disease.

## Study links high pesticide exposure to elevated cancer risk, raises safety concerns

A major new study published in Nature Health has raised concerns over the long-term health effects of environmental pesticide exposure, warning that people living in high-exposure regions could face up to a 150 per cent higher risk of developing certain cancers. The research, involving scientists from institutions including the University of Toulouse and the National Institute of Neoplastic Diseases, is being described

as one of the most comprehensive real-world analyses on the subject.

Unlike earlier studies that focused on single chemicals, the new research examined how multiple pesticides interact simultaneously — a scenario researchers say better reflects everyday exposure through food, water and air. The study, conducted in Peru, analysed 31 commonly used pesticides and compared exposure patterns with health



records of over 150,000 cancer patients between 2007 and 2020.

Researchers found a consistent link between regions with high pesticide exposure and significantly higher cancer rates. Indigenous and rural farming communities were found to be particularly vulnerable, with people in some areas exposed to an average of 12 pesticides at the same time. The study also suggested pesticide exposure

may trigger silent disruptions in normal cellular processes long before cancer develops, with the liver emerging as a key organ affected.

Researchers said current chemical safety standards may be inadequate as they typically assess one chemical at a time and may fail to account for the combined effects of multiple substances. The findings also raised concerns that climate-related

factors such as El Nino could alter pesticide use and spread, potentially increasing exposure risks further.

Though focused on Peru, scientists said the implications are global, particularly for countries with intensive agriculture and weak regulatory oversight. The study has renewed calls for updated safety policies, stronger monitoring and a broader rethink of how environmental health risks are assessed.

# Meta Gets EU Rap For Failing To Keep Kids Away From Facebook, Instagram

The European Commission (EC) has ruled that Meta has failed to find, address and minimise the risk its social media platforms (Instagram and Facebook) pose to minors under the age of 13, according to a press release from the organisation on Wednesday.

The executive branch of the European Union (EU) found Meta's safeguards and related measures to enforce restrictions on usage for minors to be inadequate.

"The measures do not adequately prevent minors under the age of 13 from accessing their services nor promptly identify and remove them, if they already gained access," the release said. The EC stated that minors could easily circumvent its age verification policy by putting in a false birthdate that affirms that they are at least 13 years old.

The Commission called Meta's tool for reporting minors under 13 "difficult to use and not effective", with users having to make an average of seven clicks in order to access its



reporting form. The process becomes more arduous with users having to manually enter information, with it not being filled automatically. It also stated that Meta does not follow up on cases where minors are reported for being under 13, which leads to minors being able to continue using the platform without facing action. The EU body also found Meta's risk assessment of the dangers its platforms posed to exposing minors to inappropriate content to be lacking, calling it

"incomplete and arbitrary". It stated that the assessment contradicts large swathes of evidence from the EU that found 10-12% of children below the age of 13 accessing Instagram or Facebook. "Meta seems to have disregarded readily available scientific evidence indicating that younger children are more vulnerable to potential harms caused by services like Facebook and Instagram," the release said. The Senate Banking Committee vote coincides with the US Federal Reserve's meeting, during which Fed officials are expected to keep the benchmark interest rate steady. He served in the White House during the Bush administration as a special assistant to the President on economic policy. Notably, this is not the first time when he has been linked to the position of Federal Reserve chairman. He had come close to being nominated back in 2017, when he lost the race to Powell.

# Israeli 'double-tap' strike kills three rescue workers in Lebanon, officials say

Two successive Israeli air strikes on a building in southern Lebanon have killed five people, including three emergency workers, Lebanese officials say, in what the country's prime minister has described as a "war crime". The Lebanese health ministry said the three members of the Lebanese Civil Defense, a state-run emergency service, had been sent to rescue those wounded in the first strike in the town of Majdal Zoun on Tuesday. They were trapped under rubble caused by the second strike and later confirmed dead. The ministry did not identify the two other fatalities. Two Lebanese army soldiers were also wounded in the attack. The Israeli military has been approached for comment. It has previously failed to explain attacks on health professionals while they were on rescue missions. The tactic, known as "double tap", sees an initial



attack followed by a second or more - often hitting civilians and rescuers. It has been used by Israel in Lebanon and Gaza. Human rights groups say deliberate attacks on health workers could constitute a war crime. The latest conflict between Israel and Hezbollah - the Lebanese militia and political party

that is funded and armed by Iran - started on 2 March after the group fired rockets into Israel, which responded with widespread air strikes and a ground invasion of southern Lebanon. Since then, more than 2,500 people have been killed in Lebanon, including 103 health professionals, according to the Lebanese health

ministry. It does not distinguish between combatants and civilians but says the number includes at least 270 women and more than 170 children. Two civilians have been killed by Hezbollah attacks in Israel, while 16 Israeli soldiers and one civilian have been killed in Lebanon, Israeli authorities say. Last month, the BBC

spent several days with the Tyre-based Lebanese Civil Defense team that was attacked on Tuesday to report on the risks emergency teams in Lebanon face amid constant Israeli attacks. The three rescue workers killed on Tuesday were Hussein Ghadbouni, Hussein Sati and Hadi Daher. The strike happened amid a US-brokered ceasefire between Israel and Lebanon that has led to a reduction in the hostilities but has failed to completely stop the war, particularly in southern Lebanon. Israel says its actions in Lebanon are in response to what it describes as violations of the deal by Hezbollah, which was not involved in the agreement but had indicated it would abide by its terms if the ceasefire was respected by Israel. The text of the deal gives the Israeli military the "right to take all necessary measures in self-defence, at any time, against

planned, imminent, or ongoing attacks" - phrasing that is broad enough to justify any action it takes. Lebanon's Prime Minister Nawaf Salam said the "targeting" of the rescuers was a "war crime perpetrated by Israel", condemning Israel's "ongoing violations of the ceasefire". A 5 to 10km-deep strip along the border, amounting to about 5% of Lebanon's territory, remains under Israeli occupation, with Israeli officials saying they aim to create a security buffer zone to protect the country's northern communities. The Israeli military has also continued its air strikes and said it had hit Hezbollah infrastructure sites in southern Lebanon on Tuesday, killing "three Hezbollah terrorists" who had attacked its soldiers. A day earlier, it also hit the eastern Bekaa Valley, where Hezbollah has a strong presence and part of its arsenal is located.

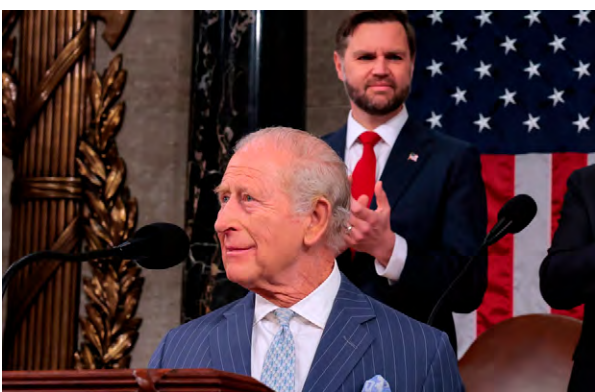
## Irish government announces further fuel supports after protests



The Irish government has announced further fuel supports for some workers and businesses, after nationwide protests in recent weeks. Irish government ministers are insisting the package of supports was being worked on by the government before the protests, which saw many major motorways, as well as the main street in the nation's capital, brought to effective standstill. Before nationwide protests kicked off, excise duty had already been cut on petrol and diesel. But since the protests there have been further cuts to diesel and petrol and a package of sup-

ports for farmers, hauliers and coach drivers has been promised. The details of this package were laid out by Irish government ministers on Wednesday at Government buildings in Dublin. The Road Transporters Supports Scheme is worth 120m (€104m) and is for hauliers and bus and coach operators. This scheme will be backdated to March and will apply from when average national diesel prices exceeded 1.90 per litre (€1.65) which is being benchmarked at the point at which fuel costs become unsustainable for commercial transport operators.

## TAKEAWAYS FROM THE KING'S HISTORIC ADDRESS TO CONGRESS



King Charles III's visit to the US was meant to be a celebration - of America's 250th anniversary, of enduring Anglo-American ties and of the "special relationship". But it has also been billed as a rescue mission. The current state of US-UK relations is strained - a reflection of British reluctance to fully back the joint US-Israeli war against Iran. So the King's goal has been to ease those tensions with a royal charm offensive, most notably with his joint address to Congress on Tuesday afternoon. The King spoke of the "reconciliation and renewal" that he said characterised the centuries of interactions between the two nations, a theme he returned to later at the White House state banquet. But there were also some lines in his speech, the first royal address to Congress since Queen Elizabeth II spoke at the Capitol in 1991, that may have buoyed Democrats - and raised eyebrows in the White House. Admitting you have a problem is the first step of recovery, as the saying goes. And so King Charles started his speech by diving right into the "times of great uncertainty" that confront both the US and the UK.

He ticked through conflicts in the Middle East and Europe - sources of recent contention between the US and the UK - while also noting the threat to democracy presented by the kind of political violence that upended Saturday night's White House Correspondents' Dinner. From there, the King pivoted to talking about the fact that the US and the UK haven't always seen eye to eye. "With the spirit of 1776 in our minds," he said, "we can perhaps agree that we do not always agree". That was all a set-up, however, for his conclusion that the two nations, when in alignment, can do great things "not just for the benefit of our peoples, but of all peoples". When King Charles noted that executive power "subject to checks and balances" was a British legal tradition, enshrined in the Magna Carta, which became a bedrock principle in the US Constitution, he received another standing ovation - with a twist. The cheers started on the Democratic side of the chamber, before spreading across the entire room. Donald Trump's critics on the left have frequently denounced the president for what they see as his abuse of power.

## TWO DEAD AFTER SMALL PLANE CRASHES INTO AUSTRALIA AIRPORT HANGAR



Two people have died after a small plane crashed into a hangar at an airport in South Australia, authorities say. The aircraft burst into flames at Parafield Airport in Adelaide after it crashed on Wednesday afternoon local time. South Australian premier Peter Malinauskas wrote on social media that a "number of others" have been injured. The plane involved was a twin-engine

Diamond DA42, according to the Australian Transport Safety Bureau (ATSB), which has launched an investigation into the accident. According to the manufacturer's website, each Diamond DA42 aircraft can seat up to four people. The South Australian police said in a statement that "the immediate area has been evacuated as emergency services deal with the incident".

## Former US officials criticise Pentagon silence on deadly Iran school attack

Five former US officials, including a former top military lawyer, have criticised the Pentagon for not acknowledging potential American involvement in a deadly strike on an Iranian school earlier this year. Some of those officials said it was highly unusual not to release even basic details of the strike after such a length of time. A missile hit a primary school in Minab during the opening salvos of the US-Israeli war on February 28, killing 168 people including around 110 children according to Iranian officials. In the two months since then the Pentagon has said only that the incident is under investigation. US media reported in early March that US military investigators believed American forces were likely responsible



for hitting the school unintentionally but had not reached a final conclusion. Asked a series of questions by the BBC about the strike and the accusations of a lack of transparency, a Pentagon official said "this incident is currently under investigation," adding that more details would be provided when they became available. The BBC has reviewed three historical

cases in which civilians were killed during US military operations and in each case significantly more information had been released by the Pentagon within less than a month. The current US position "strikingly departs from the standard response," said Lt Col Rachel E VanLandingham, a retired Judge Advocate General in the US Air Force and former

senior legal adviser at US Central Command during the wars in Iraq and Afghanistan. "Administrations in the past at least demonstrated fidelity, a commitment to the law of war," said VanLandingham, who argued what was "missing" from the administration's statements was a commitment to accountability and "importantly to ensure this doesn't happen again". President Trump said on 7 March that in his "opinion" Iran was to blame for the Minab strike, without providing evidence. Days later, when asked about video showing a US Tomahawk hitting the military base next to the school, he said: "I haven't seen it" and claimed without evidence that Iran had Tomahawk missiles.

## COMEY CHARGED WITH THREATENING TRUMP'S LIFE IN INSTAGRAM POST

Former FBI Director James Comey has been charged with threatening the life of US President Donald Trump, a formal accusation that stems from an image he briefly shared on social media. The image posted on Instagram last year showed seashells forming the numbers "86 47". "Eighty-six" is a slang term used to mean "eject" or "remove". Comey has insisted he did not know what the numbers on the image meant, but Trump and other administration officials have said the post was a threat against the 47th president. Responding to the charges on Tuesday, Comey said: "I'm still innocent, I'm still not afraid, and I still

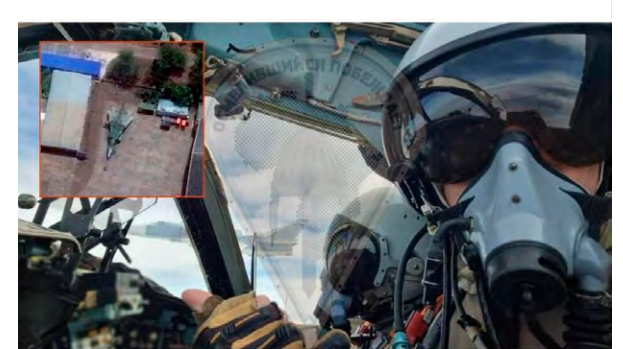

encouraged a threat on President Trump's life and posted it on Instagram for the world to see," Kash Patel said on Tuesday. Comey was fired by Trump during his first term, after the former FBI director opened an investigation into Russian interference in the US 2016 presiden-

tial election. Since then, Trump has repeatedly called for his prosecution - Tuesday's charges are the administration's second attempt to do so. "Well, they're back. This time about a picture of sea shells on a North Carolina beach a year ago. And this won't be the end of it, but nothing has changed with me," Comey said in a statement. Comey faces charges of making a threat against the president and transmitting a threat in interstate commerce, according to court documents. Each charge carries a maximum penalty of 10 years in prison. The criminal charges were filed in the Eastern District of North Carolina.

## RUSSIAN PARAMILITARY CARRIED OUT AIR STRIKES IN MALI AS REBELS ADVANCED, FOOTAGE SHOWS



A Russian paramilitary launched air strikes against rebel forces near Mali's capital Bamako, video footage shows, following a shock offensive against the ruling military government. Jihadist and Tuareg separatist forces on Saturday carried out attacks across Mali and killed the country's Defence Minister Sadio Camara. Russian forces claimed up to 12,000 fighters took part in the offensive. The Kremlin-controlled Africa Corps, which supports Malian military operations, has posted several videos since Saturday showing air strikes and attack helicopters engaging with rebel troops. BBC Verify located the clips to the town of Kati, around 20km (12 miles) from Bamako. Despite the show of force, the mercenaries confirmed that they have pulled out of Kidal in northern Mali, which housed significant numbers of troops and was at the core of the military's operations in the region. Verified footage now shows rebels roaming the base. Mali has

fought a long-running conflict against a broad array of rebel groups for more than a decade. Military leaders seized power in 2020 after accusing the civilian administration of failing to properly manage the security situation. Since then the military has had limited success targeting the al-Qaeda linked Jama'at Nusrat al-Islam wal-Muslimin (JNIM) group and the separatist Azawad Liberation Front (FLA), with Bamako coming under a blockade late last year. But the latest attacks mark a "major escalation in the conflict" between the military government and the rebels, said Jean-Hervé Jezequel, Sahel director with the International Crisis Group. Fighting has been recorded across the country, with BBC Verify confirming 22 videos showing rebel movements in seven locations since Saturday. "Whereas JNIM's strategy initially relied primarily on conquering rural or peripheral areas, it now also targets major cities," Jezequel said.

## FRANCE URGES CITIZENS TO LEAVE MALI AFTER REBEL ATTACKS

France has urged its citizens to leave Mali "as soon as possible", after a weekend of coordinated attacks by separatist fighters and Islamist militants. In an update on Wednesday, the advice also warned French citizens not to travel to the West African nation, describing the situation as "extremely volatile". Explosions and sustained gunfire were reported across the country, including the capital, Bamako on Saturday. In Kati, the defence leader Sadio Camara was killed in an apparent suicide bombing by militants, while in the north, separatist forces have taken control of the city of Kidal. Mali's military leader Gen Assimi Goïta said the security situation in the country was under control. Speaking in public for



the first time on Tuesday evening, he said the army had dealt a "violent blow" to the attackers, and signalled operations were still ongoing. The foreign ministry of France, Mali's former colonial power, said: "French nationals are advised to make arrangements to leave Mali temporarily as soon as possible on the commercial flights that are still avail-

able." Pending their departure, they should stay at home, limit their movements and follow instructions from local authorities, it said, adding that they should also keep their relatives informed. "Travel to Mali is still strongly discouraged, regardless of the reason." The UK has also advised "against all travel to Mali due to the unpredictable security

conditions", and asked its citizens to leave. The travel guidelines - which have been in place since the weekend - told British citizens in Mali to "leave immediately by commercial flight if you judge it safe to do so". It also warned them not to travel by land to neighbouring countries, deeming it "too dangerous" due to what it called "terrorist attacks along national highways". "If you choose to remain in Mali, you do so at your own risk. You should have a personal emergency plan that does not rely on the UK government," the foreign office added. Bamako International Airport is currently open, but travellers have been warned to check the latest information in case of delays or cancellations.

## TUPAC'S FAMILY FILES WRONGFUL DEATH LAWSUIT IN LA



The family of the late rapper Tupac Shakur has filed a wrongful death lawsuit in Los Angeles, seeking unspecified damages tied to the artist's murder in 1996. The suit names former gang leader Duane "Keefe D" Davis, who is currently awaiting trial for his alleged role in the shooting, as the main defendant, alongside additional unnamed co-conspirators.

Davis is the only person ever charged in connection with Tupac's death, after years of investigations. He has pleaded not guilty. The new lawsuit, reported by several US media outlets, alleges there was a "complex conspiracy" to murder the star, and says its aim is to uncover the identity of the "individuals who were involved" through discovery. Shakur was one of the most prominent rappers of the early 1990s, selling more than 75 million records, including hit singles Hit Em Up and California Love. He also had a burgeoning acting career, with roles in Juice, Above the Rim and Poetic Justice. But his career came to an abrupt halt when he was shot four times in a drive-by attack in Las Vegas in September 1996.



## IPL 2026: Mumbai Indians Set 343/5 Target for Sunrisers Hyderabad

Ryan Rickelton slammed his maiden IPL century as Mumbai Indians posted a massive total of 243 for 5 in 20 overs against Sunrisers Hyderabad in their IPL 2026 game at the Wankhede Stadium tonight. Rickelton brought up his ton in 44 balls, becoming the fastest MI batter to reach the mark. He and Will Jacks added 93 runs off 43 balls for the opening wicket. Jacks was dismissed for 46 off 22, while Rickelton carried his bat on 123 off 55, the highest score by an MI batter. Earlier, MI captain Hardik Pandya won the toss and opted to bat first. Rohit Sharma was not part of the Mumbai Indians' playing XI during their IPL 2026 encounter against Sunrisers Hyderabad in Mumbai on Wednesday. Rohit, who missed the last three matches for MI due to a hamstring injury, was not fully cleared to play against SRH. Rohit picked up the injury during the game against Royal



Challengers Bengaluru on April 12, where he showed signs of hamstring discomfort and had to receive treatment on the field. At the toss on Wednesday, MI captain Hardik Pandya said that Rohit will need a couple more games to come back, adding that he has been trying to get match-fit. "Ro is going to take a couple more games. He has been trying,

but he is not exactly where he would want to be. So, he is not available for this game. I just want to come out and play my best cricket. That will definitely help the group and the team." Mumbai Indians won the toss and elected to bat against Sunrisers Hyderabad. Mumbai Indians made multiple changes to their lineup, bringing in Ryan Rickelton,

Britons Fury and Joshua - both two-time world champions - have signed a deal to fight this year. But Joshua, 36, must first get past little-known Albanian Kristian Prenga on 25 July in Saudi Arabia. "If he loses to this guy, it kills the fight," Warren told. The head of Queensberry Promotions, which represents 37-year-old Fury, said the 'Gypsy King' will earn a career-high payday against Joshua, surpassing the reported £80m he earned against Oleksandr Usyk in 2024.

### Question Of Privacy Was Raised By IPL Captains Before Riyan Parag Was Caught On Video Vaping In Dressing Room

After Riyan Parag's vaping row, in which the Rajasthan Royals captain was video-graphed indulging in the act in the dressing room during a match against Punjab Kings, a report by news agency PTI said that IPL and BCCI officials involved in the conduct of the tournament termed it a careless act in the age of social media and intrusive television cameras. A "well-placed IPL source" added: "A lot of players consume e-cigarettes, but they don't do it in the dressing room. It is too risky and careless to be doing that with so many cameras around. With Parag caught vaping so openly, the BCCI might be forced to act," said the source. Another IPL source told PTI that the issue of players' privacy in the



dressing room was raised at the captains' meeting in Mumbai ahead of IPL 2026. Some of the captains had objected to cameras panning to the dressing room during live broadcasts. "It was not specifically related to the use of e-cigarettes in the dressing room. It was broadly about players' privacy. There are times when play-

ers are not fully dressed in the dressing room or may want to avoid cameras. "They were told that it is up to the broadcaster, and not the BCCI, to decide whether cameras show feeds from the dressing room. After this incident, it may perhaps be reviewed." Having said that, it was careless of Parag, and it is difficult to defend some-

thing like this. An elite athlete being caught smoking like this does not set a good example for the public," said the source. As per the Prohibition of Electronic Cigarettes Act (PECA), 2019, "no person shall, directly or indirectly, (i) produce or manufacture or import or export or transport or sell or distribute electronic cigarettes, whether as a complete product or any part thereof; and (ii) advertise electronic cigarettes or take part in any advertisement that directly or indirectly promotes the use of electronic cigarettes. "...no person, being the owner, occupier, or having control or use of any place, shall knowingly permit it to be used for storage of any stock of electronic cigarettes."

### Vaibhav Sooryavanshi "Might Just Leave For Mumbai Indians"? England Great Throws 'Player Retention' Possibility

When Vaibhav Sooryavanshi was picked by Rajasthan Royals at the IPL 2025 auction for Rs 1.1 crore, many said it was a wild bet. RR's Director of Cricket, Zubin Bharucha, however, recently revealed that he had told the franchise to keep up to Rs 10 crore aside just for Sooryavanshi. Bharucha added that his first impression of the youngster had left him in awe. The 15-year-old has repaid that faith this season. His scores so far in IPL 2026 are 52, 31, 39, 78, 0, 46, 8, 103 and 43. He currently sits atop the run-getters' list with 400 runs in nine innings at an average of 44.44 and a strike rate of 238.09. He is the first player in IPL 2026 to reach the 400-run mark. Stuart Broad, the



former England fast bowler, presented an interesting perspective while lauding Rajasthan Royals' scouting system. "Fair play to Rajasthan Royals' scouting system or academy system whatever they have done. I remember when they signed him at the auction - he was 14, maybe even 13 - and I thought it was a bit

odd for top-flight domestic cricket to bring in someone so young. That's a lot of pressure, just having him around the squad for three years. What's the point of that? It's not as if you can sign him on a 10-year contract; he might just leave for the Mumbai Indians or something if given an opportunity," Broad told

former England teammate Jos Buttler on the For the Love of Cricket podcast. "I mean, to be fair, when he walks into his next player retention, he can go into the auction, if he wants, 'you have to give me some sort of numbers.'" Former RR batter Buttler, who is currently playing for Gujarat Titans, was full of praise for Sooryavanshi, particularly for hitting bowlers like Jasprit Bumrah, Josh Hazlewood and Pat Cummins for first-ball sixes. "He is only 15, and he is playing with the fearlessness of peak Chris Gayle or Virender Sehwag-except those guys were 30 or 35 when they were doing it. He is just consistently wrecking bowlers around the park. It's outrageous.

Sabalenka is a three-time champion in Madrid and reached the final in the Spanish capital in each of the last three editions of the event but was unable to shake off the 30th-seeded Baptiste, who peppered her with huge serves



and ultra-aggressive groundstrokes to reach a maiden WTA 1000 semi-final. Baptiste came up with huge serves in several crucial moments - finishing the duel with a total of 12 aces and 10 double faults - and even saved a match point with a bold serve-and-volley approach on her way to a memorable two-hour

30-minute triumph. "I feel incredible... It was a super tight match, 7-6 in the third, I had to fight off some match points," Baptiste said. "It just shows me where my game lies, and I've always believed it. And I feel like now I'm starting to put it into action, and the world is seeing it as well. So I'm very confident right now." Next up for the 24-year-old Baptiste is ninth-seeded Mirra Andreeva, who gave herself an early birthday gift by defeating Canadian Leylah Fernandez 7-6(7/1), 6-3 to reach her first Madrid semi-final. The Russian teenager, who turns 19 on Wednesday, was a recent champion in Linz and improved her clay-court record to 11-1 this season.

### Babar Azam Equals Virat Kohli, Abhishek Sharma's Big T20 Feat With Blistering Ton In PSL



Babar Azam smashed yet another century as Peshawar Zalmi defeated Islamabad United in the Qualifier of the Pakistan Super League (PSL) 2026 on Tuesday. Batting first, Peshawar posted an imposing total of 221/7, with Babar leading the charge by scoring a brilliant 103 off just 59 balls. In reply, Islamabad United were bowled out for 151, suffering a heavy 70-run defeat. With this comprehensive win, Peshawar Zalmi sealed their place in the final of PSL 2026, scheduled to be played on May 3. Apart from guiding his team into the final, it was a memorable night for Babar, who also etched his name into the record books. The knock marked Babar's ninth T20 century as captain, the most by any skipper in the format. He went past South Africa's Faf du Plessis, who previously held the record with eight hundreds. The elite list also includes India's Virat Kohli, who is fourth with five centuries as captain. Babar also drew level with Kohli and Abhishek Sharma for the most T20 centuries in a single country. While Kohli and

Abhishek have eight T20 hundreds in India, Babar now has eight T20 centuries in Pakistan. In PSL history, this was Babar's fourth century, joint-most in the tournament alongside Usman Khan. He has now amassed 588 runs in PSL 2026, equalling Fakhar Zaman's record for the most runs in a single PSL season, set in 2022. "I'm starting to feel like I'm getting back to my best. I'm trying to keep things simple, trust my skills, and play according to the situation - what the pitch demands, how to handle different bowlers, and when to attack. The hard work I put in before the PSL is helping now. Things weren't the same earlier, but they're starting to come back, and I want to keep this consistency going," Babar said after the match. "When you get a good start in the first six overs, it gives you a cushion to play your natural game and maintain the run rate. The way Haris plays and puts pressure on the opposition helps, and then I just try to play my role and carry that momentum forward," he added.

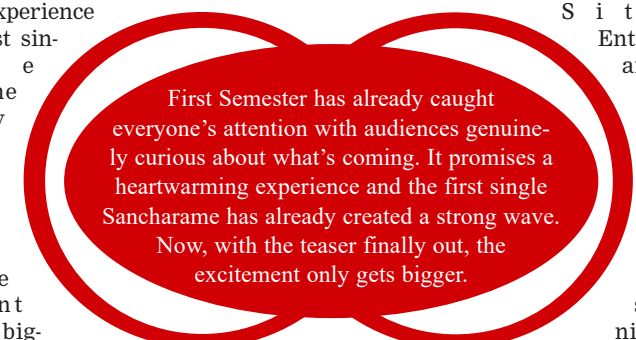
