Abusive language alone not obscenity under Indian Penal Code: SC

New Delhi: The Supreme Court has held that mere use of abusive language such as the word "bastard" during a heated altercation would not amount to an offence of obscenity under Section 294(b) of the Indian Penal Code (IPC). A bench of Justices Pamidighantam Sri Narasimha and Manoj Misra made the observation while partly allowing appeals filed by two accused persons challenging their conviction in a 2014 case arising out of a long-standing boundary dispute between close relatives in Tamil Nadu. In its detailed judgment, the Justice Narasimha-led Bench examined the scope of "obscenity" under Section 294 IPC and clarified that not all vulgar or abusive expressions would attract penal consequences. "Mere use of the word 'bastard', by itself, is not sufficient to arouse the prurient interest of a person. More so, when such words are commonly used in the modern era during heated conversations," the apex court observed.

Woman burnt alive after she rejects marriage proposal in Kolkata

Kolkata (TIST): A 30-year-old Muslim woman was allegedly set on fire and succumbed to her injuries on Monday, April 6, after she refused to marry a man who lured her on the pretext of a job interview in Kolkata, West Bengal. According to local media, the incident took place in Babughat in the Maidan area on Saturday, April 4. The victim, Shagufta Parveen, suffered 90 per cent burn injuries and made a declaration moments before passing away at the SSKM Hospital, revealing the accused's name. Siddhartha Chariwal allegedly called Parveen to a secluded spot by falsely claiming it was for an interview. A heated argument broke out between the two at the spot when the accused asked to marry the victim. Chariwal reportedly poured kerosene on Parveen following her refusal and set her ablaze. Eyewitnesses called police and she was rushed to the hospital, where she was in critical condition for two days before passing away.

Revanth lays foundation for Rs 225 cr Basara temple renovation work



Hyderabad, April 6 (TSIT): Telangana's famous Gnana Saraswati temple is to get a big facelift as Chief Minister A. Revanth Reddy on Monday laid the foundation for the temple's expansion and development works to be undertaken at a cost of Rs 225 crore.

Accompanied by Deputy Chief Minister Mallu Bhatti Vikramarka and some other ministers, the Chief Minister performed Bhoomi Puja at the temple in Basara town of Nirmal district. Before performing Bhoomi Puja, the Chief Minister, along with his family members, performed prayers at the temple. They participated in various rituals amid the singing of Vedic hymns by priests.

Situated on the banks of the sacred river Godavari, which is also revered as the "Dakshina Ganga" (Southern Ganges), the temple boasts a glorious history spanning thousands of years.

According to the legend, following the Kurukshetra War, Veda Vyasa came to reside on the banks of Godavari at Basara and during his stay, he sculpted and consecrated the idols of Goddesses - Gnana Saraswati, Mahalakshmi, and Mahakali. From then, Basara gained popularity as a holy site with the enshrine of "Trimataas".

Devotees come to the temple to perform Aksharabhyasam (the traditional initiation ceremony into formal education) for their children. In view of the increasing number of visitors and lack of

adequate facilities in the temple, the Chief Minister resolved to take up comprehensive development of the Basara temple and instructed the officials to formulate a master plan to execute the developmental works in strict adherence to the temple's established traditions and rituals.

The authorities consulted with the spiritual heads of the Sringeri Peethadhipatis before formulating the Master Plan and obtained their approval for the construction of the sanctum sanctorum ('Garbhhalayam'), 'Artha Mandapam', 'Raja Gopuram' (main tower), other towers, 'Mada Veedhulu' (processional streets), temple tank ('Koneru'), and the Northern Gateway. In view of the growing number of devotees and future requirements, the sanctum sanctorum and Artha Mandapam, currently spanning 2,000 square feet, are being expanded to cover 5,000 square feet. The plans included the construction of a nine-storey Raja Gopuram on the northern side, seven-storey towers in the remaining three directions, Mada Veedhulu (processional streets) 33 feet in width encircling the temple on all four sides and a northern Gateway. In total, the temple's built-up area is being expanded from 20,000 square feet to 62,000 square feet.

Mamata questions PM Modi's silence over Pak minister's Kolkata threat



Kolkata, April 6 (TSIT): West Bengal Chief Minister Mamata Banerjee on Monday accused Prime Minister Narendra Modi of maintaining a deliberate silence at his election campaign rally in Cooch Behar district on Sunday regarding the threat issued by Pakistan's Defence Minister Khawaja Asif, who said that Pakistan would retaliate with a strike on Kolkata if India tried to stage any false-flag operation against Pakistan in the future.

"How could a Pakistani minister speak about targeting Kolkata? Why did the Prime Minister not say anything about this when he came here on Sunday? Why couldn't he say that strict action would be taken against this? Why was he silent? Why hasn't action been taken against Pakistan?" "Who made their Pakistan

minister say such things? We demand an investigation in the matter. If they talk about attacking Kolkata, we won't accept it," the Chief Minister said at an election campaign rally in Nadia district on Monday, ahead of the two-phase Assembly polls in the state later this month.

Speaking on the occasion, the Chief Minister also cautioned that on the counting day on May 4, Trinamool Congress workers should not be misled by false rumours in the early hours of counting, suggesting that the Bharatiya Janata Party (BJP) candidates are ahead in the majority of the Assembly constituencies in West Bengal. "In the morning hours, they would like to project as if their candidates are winning in most of the constituencies. But do not get disheartened by that. Watch till the end. We will finally win. Do not leave the counting centres till the counting is over," the Chief Minister said.

The Director General of the Border Security Force (BSF), Praveen Kumar, became the Centre of the Chief Minister's attack during her speech.

Iran rejects ceasefire proposal as Trump calls it a 'significant step'

Tehran (TSIT) Iran on Monday, April 6, rejected a United States (US)-backed ceasefire proposal, insisting any agreement must guarantee a permanent end to hostilities across West Asia, even as President Donald Trump described the plan as a "significant step" but insufficient. Tehran conveyed its response via Pakistan, according to the Islamic Republic News Agency (IRNA), stating it would only consider a truce if the US and Israel immediately halt strikes, including those targeting senior leadership.



Iran's 10-clause response rejects a temporary ceasefire and calls for a definitive end to conflicts across the region, including Gaza and Lebanon, with enforceable guarantees.

Andhra launches 100-day action plan for water security



Amaravati, April 6 (TSIT): Andhra Pradesh Chief Minister N. Chandrababu Naidu on Monday launched the 'Jaladhara' programme, a 100-day action plan taken up across the state for water security. With the goals of desilting tanks, repairing canals, recharging groundwater, and conserving water, the government has designed the Jaladhara programme to ensure water for every acre and confidence for every farmer. The Chief Minister launched the programme in Yadiki in Anantapur district, in the drought-prone Rayalaseema region.

Speaking on the occasion, the Chief Minister stated that the government initiated a public movement for water conservation. He said in this programme, led by 60,000 members of water user associations, every single citizen should become a stakeholder. The Chief Minister stated that by utilising the earth itself as a natural reservoir for storage, we can achieve more effective water management. He called upon the people, government officials, and water user associations to join hands and increase groundwater levels. "We must ensure that groundwater is available at a depth of 6 meters before the monsoon season, and at less than 3 meters after it. If we can achieve this, the state will no longer face any water scarcity." He emphasised the need to fill the reservoirs to their capacity so that the state can have the opportunity to utilise the water whenever necessary.

Stalin to campaign in Puducherry today as Assembly polls enter final phase

Puducherry, April 6 (TSIT): Tamil Nadu Chief Minister and DMK President M.K. Stalin is set to campaign in Puducherry on Monday, as the union territory heads into the final phase of high-voltage electioneering ahead of the April 9 Assembly polls. The visit comes at a crucial juncture, with just days left for voters to decide the fate of candidates contesting across all 30 constituencies.

Stalin will address a public meeting at 5 p.m. at the Thattanchavady Regulated Sales Complex, where he is expected to canvass support for candidates of the INDIA bloc. His speech is likely to focus on local political themes, alliance unity, and voter mobilisation



in the closing stretch of the campaign.

Voting for the 30-member Puducherry Legislative Assembly will take place on April 9 (Thursday), with a total of 294 candidates in the fray. Candidates have been actively campaigning across constituencies, engaging in door-to-door outreach, public meetings, and local interactions in

an effort to consolidate support. The electoral contest has taken the shape of a multi-cornered fight.

The National Democratic Alliance (NDA) comprises the Bharatiya Janata Party (BJP), the All India N.R. Congress (AINRC), the All India Anna Dravida Munnetra Kazhagam (AIADMK), and the Lakshya Jananayaga Katchi.

The INDIA bloc includes the Dravida Munnetra Kazhagam (DMK), the Indian National Congress, and several allied parties. In addition, regional players such as the TVK and Naam Tamilar Katchi (NTK) are also in the fray, making the contest more competitive and unpredictable.

No talks with Iran on Hormuz transit levy, reports baseless: Govt

New Delhi, April 6 (TSIT): The government on Monday dismissed reports suggesting that India was in discussions with Iran over imposing a transit levy through the Strait of Hormuz, calling such claims baseless and without any foundation. Speaking on the issue, Mukesh Mangal, Additional Secretary in the Ministry of Shipping, clarified that India has held no talks with Iran regarding any levy for passage through the Strait of Hormuz.

"The government is not aware of any such development, seeking to allay concerns amid heightened tensions in the region," he stated. Providing an update on maritime movement, Mangal said that 16 Indian vessels operating west of the Strait of Hormuz are being closely



tracked. "LPG carriers Green Sanvi and Green Asha have safely crossed the critical shipping route and are expected to arrive in India on April 7 and April 9, respectively," he added. The two vessels are carrying 46,500 tonnes and 15,500 tonnes of LPG, ensuring continuity in energy supplies. On the energy front, Sujata Sharma, Joint Secretary in the Ministry of Petroleum and Natural Gas, noted that LPG imports have seen some decline while domestic production remains limited.

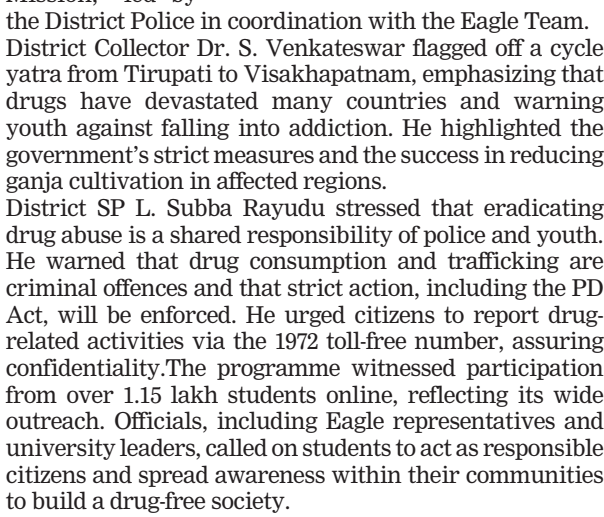
LIFE SKILLS CAPACITY BUILDING WORKSHOP

Young India at Risk: CARE Doctors Flag Surge in Lifestyle Diseases, Urge Early Screening

Hyderabad: Doctors from CARE Hospitals have raised serious concerns over the rising incidence of lifestyle diseases among younger Indians, warning that conditions like Type 2 Diabetes, Hypertension, and Fatty Liver Disease are increasingly affecting people in the 30-50 age group. On the occasion of World Health Day, experts highlighted that a majority of cases are being diagnosed late due to poor preventive health practices and lack of routine screenings. This delay often leads to complications and long-term health risks.



According to Dr. H. Guru Prasad, the alarming trend is not just the rise in cases but the early age of onset. Many individuals, despite appearing healthy, are unknowingly living with underlying risk factors that go undetected until advanced stages. Doctors attribute the surge to modern urban lifestyles marked by sedentary

habits, poor diet, stress, irregular sleep, and heat exposure. They strongly recommend annual health check-ups for individuals above 30, including blood sugar tests, blood pressure monitoring, lipid profiles, liver function tests, and BMI evaluation. The hospital group continues to promote preventive healthcare through awareness programmes and screenings, stressing that early detection is key to reducing India's growing disease burden.

Severe Accidents Can Turn Fatal in Hours—Hyderabad Doctors Push for Faster, Smarter Care

Hyderabad : It takes just a second—a skid, a crash, a fall—for life to change forever. But what happens in the next few hours often determines whether a person survives or not. In response to this critical reality, Medicovert Hospitals, Secunderabad, in collaboration with Osmania Medical College and leading orthopaedic associations, has taken a significant step towards strengthening emergency trauma care by training doctors to handle some of the most life-threatening injuries seen after major accidents. Nearly 200 young orthopaedic surgeons from across the country participated in an intensive, hands-on cadaveric workshop focused on advanced pelvic and acetabular



trauma care—injuries that are among the most complex and dangerous, often caused by high-speed road accidents. Dr. Uday Krishna Myneni, Organizing Secretary of the workshop, highlighted the urgency involved in such cases. "These injuries are extremely critical because they can lead to severe internal

bleeding. If patients do not receive expert care within the first few hours—the "Golden Hour"—the risk to life increases significantly," he explained. The workshop, organized in association with the Telangana Orthopaedic Surgeons Association (TOSA) and the Twin Cities Orthopaedic Society (TCOS), aimed to bridge a crucial gap—ensuring that more surgeons are trained and confident to take swift, life-saving decisions during emergencies. Senior experts, including Organizing Chairman Dr. P.L. Srinivas and renowned trauma surgeon Dr. Ramesh Kumar Sen from Chandigarh, led the training sessions, sharing advanced surgical techniques and real-world insights

into managing complex trauma cases. Beyond surgical training, the experts delivered a strong message for the public: many of these life-threatening injuries are preventable. Road accidents—often caused by speeding, lack of caution, and drunk driving—remain the leading contributors. Doctors emphasized that while prevention through responsible driving is the first line of defense, access to well-equipped hospitals with advanced trauma care capabilities is equally vital in saving lives when accidents do occur.

Himachal govt sets target to increase state's forest cover to 32 per cent by the year 2030

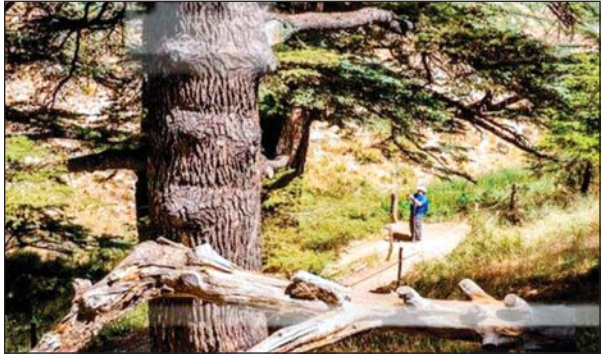
SHIMLA: The Himachal Pradesh government has set a target to increase the state's forest cover from the existing 29.50 per cent to 32 per cent by the year 2030, a spokesperson said on Sunday.

The government, in its Budget for the 2026-27 fiscal, had announced an initiative, 'Mission 32 Per cent', he said.

Chief Minister Sukhvinder Singh Sukhu had said the decision marks "a major step towards making Himachal a green Himalayan state" and is expected to enhance biodiversity.

"The target is not merely statistical, it forms part of a broader strategy to address climate change, maintain ecological balance and ensure sustainable development," the spokesperson added.

taken in this direction, he said to achieve this objective, the state government over the past three years has introduced several innovative initiatives that integrate forest expansion, conservation and community participation.

"Among these, the Mukhyamantri Van Vastara Yojana stands as a key intervention. The scheme aims to convert barren and unproductive hills into

also creates future livelihood opportunities for local communities.

"Similarly, the Rajiv Gandhi Van Samvardhan Yojana represents a significant step towards the rejuvenation of forest areas. Large-scale plantation is being carried out on forest land, supported by dedicated financial provisions for maintenance, which is a major component of the scheme," he said.

He added that an amount of Rs 1.20 lakh per hectare is being provided to ensure not only the plantation but also the survival and proper upkeep of saplings.

The scheme is being implemented on the ground through self-help groups, Mahila Mandals and youth groups, generating employment and strengthening the rural economy, the spokesperson said.

"Inspector Shailendra Singh Jharkhar of Samaypur Badli police station was named best Station House Officer, while Assistant Commissioner of Police Rakesh Kumar of the same station led the best-performing sub-division.

Odisha police registers FIR over death of Bengali actor Rahul Arunoday Banerjee

BALASORE: The Odisha police have registered an FIR over the death of actor Rahul Arunoday Banerjee, who allegedly drowned during a shoot of a Bengali television serial at Talsari beach in Balasore district, officials said on Sunday.

Banerjee, 43, drowned during a TV serial shooting at Talsari beach in Odisha on March 29 by accidentally slipping into seawater. He was declared dead by a doctor at a Digha hospital, where he was taken by his associates, the police said.

An FIR was registered at Talasari Marine police station on Saturday night after receiving a complaint from the actor's wife, a police officer said on Sunday.

The police officer said they will investigate from



all angles, including if any criminal conspiracy to the incident and evidence will be collected before coming to a definite conclusion.

Banerjee rose to fame with the 2008 Bengali film 'Chirodini Tumi Je Amar', directed by Raj Chakraborty, which starred him opposite Pri-

yanka Sarkar and became a major hit.

Banerjee, who had started his career in early 2000, acted in several critically acclaimed Bengali films and TV soaps after the blockbuster success of Chirodini in 2008 and also started hosting a podcast which gained popularity.

The West Bengal Motion Picture Artists' Forum on Saturday had lodged a complaint at the Regent Park police station in Kolkata against the producers in connection with the incident.

Kolkata Police said the complaint was treated as a 'Zero FIR' against the serial's producers, accusing them of conducting the shoot in a "negligent manner" that endangered human lives.

India supports ongoing efforts to stop war: Iran after EAM Jaishankar-Araghchi talks

Tehran, April 6 : India has stressed the importance of restoring stability and security in West Asia, and expressed support for ongoing efforts aimed at stopping the war, the Iranian Foreign Ministry has said. External Affairs Minister (EAM) S. Jaishankar held a phone conversation with his Iranian counterpart, Abbas Araghchi, on Sunday and discussed the recent developments about the situation in West Asia.

"Iran's Foreign Minister, referring to what he described as grave crimes committed by US and Israeli forces against the Iranian people - including attacks on industrial and production infrastructure, as well as peaceful nuclear facilities under safeguards - also highlighted continued rhetoric by US officials openly threatening strikes on Iran's energy infrastructure," read a statement by Iran's Foreign Ministry after the phone



conversation between the two leaders.

During the conversation, Araghchi emphasised the responsibility of the international community and the United Nations to "confront violations of international law and prevent the normalisation of war crimes".

The Iranian Foreign Minister stressed the

"firm determination" of the country's people and armed forces to defend the national interests and security, "warning about the broader consequences of US and Israeli military actions for regional and global stability".

"India's Foreign Minister, noting the importance of restoring stability and security in

the region, expressed support for ongoing regional and international efforts aimed at stopping the war," the Ministry statement read.

Earlier on Sunday, EAM Jaishankar said he received a call from Araghchi, during which the two leaders discussed the prevailing situation in the region.

Min Ravinder Indraj Singh launches 7 projects in Outer Delhi's Bawana

NEW DELHI: Development works in outer Delhi's Bawana Assembly constituency received a fresh push on Sunday as Ravinder Indraj Singh inaugurated seven infrastructure projects simultaneously in Rohini's Sector-24.

The projects, launched under the Chief Minister Development Fund (CMDF), include the construction of roads and drainage systems across pockets 06, 08, 09, 17, 18, 20, and 22.

Officials said the works are aimed at improving basic civic amenities and

enhancing living conditions for residents in the area.

Addressing the gathering, Singh, who holds the Social Welfare and SC/ST/OBC Welfare portfolios, described the initiative as a "significant step towards holistic development" of the constituency.

He, in his statement, added that the projects are being executed by the Municipal Corporation of Delhi (MCD) and form part of a broader push to upgrade infrastructure across the capital.

The minister credited the leadership of Chief

He noted that several schemes approved under CMDF will further strengthen roads, drainage, water supply, street lighting, and parks. the coordinated efforts of multiple agencies, including the Delhi Jal Board, Public Works Department, Irrigation and Flood Control Department, DSIIIDC, and TPDDL, in implementing these projects.

Stressing the government's focus on both rural and urban areas, Singh said the administration is committed to ensuring visible, on-ground progress in every locality.

Continuous inauguration of such projects, he added, is intended to sustain development momentum and deliver timely benefits to citizens.

UP CM urges BJP youth to counter Op's negative narratives ahead of elections

GORAKHPUR: Uttar Pradesh Chief Minister Yogi Adityanath on Sunday called upon BJP's young workers to remain vigilant and respond firmly, while maintaining decorum, to the negative narratives being spread by a frustrated and disheartened opposition on social media platforms.

"In view of the upcoming Assembly elections, the opposition would launch a fresh wave of fabricated allegations online, and BJP's booth-level teams must stay strong and prepared to counter and rebut such attacks," Adityanath said.

Adityanath was addressing the 'Yuva Samvad' programme organised by the BJP's city unit on Sunday. Speaking at the event, he encouraged party workers, stating that the youth must focus on development while also respecting heritage.

"Just as soldiers remain alert to safeguard the nation's borders, party workers too must stay vigilant in their responsibilities," he said.

He emphasised that booth-level workers must actively promote the achievements of the double-engine government and remain alert at their respective booths.

The chief minister urged them to stay vigilant on social media as well, noting that those who once created an identity crisis for the youth of Uttar Pradesh, having failed on all fronts, will now resort to social media.

"They will attempt to set negative narratives through false and fabricated allegations, and workers must be ready to counter them

effectively. To counter such narratives, workers should highlight past instances of lawlessness, including mafia dominance, extortion, insecurity of women and traders, and communal unrest during festivals," he said.

"They should present evidence such as newspaper clippings and examples from that time, and respond assertively while maintaining the dignity of language," Adityanath said.

The chief minister also said that emphasis should be placed on promoting positive aspects. By creating quality content, social media platforms can be used effectively to highlight developments across sectors, thereby strengthening the campaign of the double-engine government.

Citing examples from the lives of Lord Rama, Lord Krishna, Abhimanyu, Guru Gobind Singh and his four sons, Swami Vivekananda, Maharana Pratap, Chhatrapati Shivaji Maharaj, Rani Lakshmbai, Subhas Chandra Bose and Vinayak Damodar Savarkar, he said these figures symbolise the power and inspiration of youth who dedicated everything for the nation and dharma.

Drawing a comparison with the previous regime, Adityanath said, "First-time voters may not be aware of the situation in Uttar Pradesh before 2017. Riots used to occur every third day, and there was widespread fear during festivals."

He cited examples from regions like Kushinagar and Maharajanji, where criminal gangs operated freely.

IOCL actively strengthens auto LPG distribution in Karnataka

BENGALURU: IOCL on Sunday said it is actively strengthening Auto LPG distribution across its network in Karnataka to address the surge in demand arising from the ongoing geopolitical situation. The company, however, highlighted that infrastructure limitations—including a limited number of Auto LPG Dispensing Stations (ALDS), constrained dispensing capacity, and operational challenges—are making it difficult to fully offset the supply gap caused by the closure of private Auto LPG outlets.

Bengaluru and several other parts of the state are witnessing disruptions in auto-rickshaw services due to a shortage of Auto LPG. Long queues of autos have been seen outside fuel stations at many locations, with drivers waiting for hours for supplies.

"In Karnataka, Oil Marketing Companies (OMCs) collectively operate 72 ALDS, with Indian Oil Corporation accounting for 55 of these outlets. In comparison, over 300 ALDS were operated by private players; however, nearly 80 per cent of these private

stations have become non-operational due to prevailing geopolitical challenges," Indian Oil Corporation Limited said in a release.

Stating that IOCL has significantly scaled up its supply in Karnataka with the support of the Government of India, the company said its average daily supply, which stood at approximately 43.5 MT per day in February, increased to 59.53 MT per day in March and has been further ramped up to 68.53 MT per day with effect from April 4. "Despite these efforts, infrastructure

limitations—including a limited number of ALDS, constrained dispensing capacity, and operational challenges—make it difficult to fully offset the supply gap caused by the closure of private Auto LPG outlets," it added.

Highlighting that pricing disparities are influencing consumer behaviour, the company said PSU-operated outlets, including those of IOCL, are retailing Auto LPG at Rs 89.52 per litre in Bengaluru, whereas private marketers are selling it between Rs 99 and Rs 105 per litre.

Delhi Police bust Rs 70 lakh racket diverting free govt. medicines; 5 held

NEW DELHI: Delhi Police busted a syndicate that was involved in an illegal diversion and sale of government-supplied medicines, recovering stocks worth approximately Rs 70 lakh, an officer said on Sunday.

According to the police, the operation was carried out by the NR-II unit of the Crime Branch, which got their hands on three accused, Neeraj Kumar (53), Sushil Kumar (47), and Laxman Mukhia (48), while they were transporting a large consignment of medicines marked "Govt Supply Not For Sale."

"The accused were inter-

cepted at Jai Bharat Transport in Tis Hazari on Thursday, where the medicines were being moved in a tempo and a car," they added.

The seized medicines included high-value antibiotics and critical care drugs such as Cefixime, Amoxicillin with Clavulanate, Ceftriaxone, Cefazidime, Meropenem, Erythropoietin injections, and Rabies Antiserum, all meant for free distribution in government hospitals. While being interrogated, Neeraj Kumar, who is said to be the kingpin of the racket, disclosed that he had been running the illegal network for over a year.

Clash between groups in Malkangiri, Odisha; 5 arrested

BHUBANESWAR: A clash broke out between two groups in Odisha's Malkangiri district, a senior police officer said on Sunday.

The incident took place at a tribal-populated Palakonda village on Saturday evening over the holding of prayer by a particular group of people in the village, the police officer said.

"The disturbance erupted between the two groups as one majority group asked the other to conduct the prayer in another place on the outskirts of the village, as they had to conduct some puja inside the village. However, the other group objected to it, which led to a heated argument between them," Raj Kishore Dash, additional superintendent of police (ASP), Malkangiri, told PTI over the phone.

In anger, some people of the majority group removed the asbestos from the roofs of three houses of the other group, he said, adding, "the roofs are being restored by the district administration."

Is Trump The President Who Lost Asia To China?

For at least a decade, developing countries across Asia and Africa have worried about growing dependent on China. They're concerned about debt traps, coercive policies, and hidden costs that might push their economies toward crisis. Crisis has come, and that logic has been turned on its head. After six weeks of the US and Israel's war on Iran and its ensuing counterattacks, it is the countries that bet on Chinese supply chains that are faring better than the ones that trusted Pax Americana. Consider Pakistan. By now it should have been in the middle of yet another economic and social implosion. It has always been vulnerable to energy price shocks, given that it imports almost all of its energy, much of it through the Strait of Hormuz. The country has \$130 billion in external debt and a persistent current account deficit, and so the slightest nudge should have tipped it over into a familiar spiral: Emergency requests to the International Monetary Fund, 18-hour power blackouts, unrest on the streets. None of that is visible. There are signs of stress, certainly: Islamabad has hiked fuel prices and is planning to shut off electricity for two to three hours each day. A sustained shortage of liquid natural gas will make it hard to keep power plants running. But, compared to the situation just a few years ago - when, after the Russian invasion of Ukraine, the economy had a full-scale meltdown - it's showing remarkable resilience. What's the difference? Chinese-made solar panels. Pakistanis have gleefully transitioned to solar power, importing about 17 gigawatts a year of photovoltaics since 2024. A quarter of households have installed solar panels for their own use. Islamabad didn't even have to spend too much money subsidizing the renewables rollout. They just had to ride Chinese overcapacity instead of fighting it, and make it work for their own citizens by keeping tariffs low. The price of imported solar panels dropped by almost 60% in 2024-25; Beijing's subsidies kept their factories humming, but also financed the electrification of millions of households across Pakistan. Many other countries made the opposite choice, in order to insulate domestic production or minimize political risk. Those that tried to keep cheap photovoltaic cells out have seen much slower rates of uptake - and are, in consequence, far more exposed to the chaos in the Gulf. Nor are solar panels the only way in which cheap Chinese goods are turning out to be sources of resilience rather than disruption. Nepal has a higher proportion of electric vehicles than any other country in the world, barring Norway. Its huge imported fleet of cheap EVs mean that it is far less worried about gasoline prices than most of its Asian neighbors. And they run on clean electricity, emerging from a hydropower infrastructure that is financed in part by Beijing. It's not hard to imagine policymakers from across the developing world looking at examples like these and concluding that betting on Beijing isn't actually the riskier option. Some may already have taken that chance; imports of Chinese solar panels have shot up in the past couple of years across sub-Saharan Africa in particular. If the only options are dependence on predictably mercantilist Beijing and on an erratic, self-centered and disruptive US, the choice is obvious. That may turn out to be the wrong call. It isn't wise to imagine that relying upon Beijing's goodwill is any safer. In just the past year, China has shown the willingness to weaponize control over supply chains, such as the production of magnets and rare earths. But right now, the contrast is glaring. Countries that believed that the open trading order, underpinned by American hegemony, would protect them from shocks are struggling; those who chose to run the risk of dependence upon Chinese imports and infrastructure are showing unexpected resilience. This will only get worse if Trump withdraws from the Gulf without making an effort to reopen the Strait of Hormuz. Then the lesson the world learns is even harsher: America will make decisions about your energy supply, take no responsibility for the consequences, and then leave. China will sell you the technology that allows you to stop caring about what the US does.

The Quiet 'Upheaval' Within US Military Over The Iran War

A series of developments inside the United States military has brought a deeper issue into focus: what happens when visible disagreement emerges between the military and political leadership during an ongoing war? The sequence of events in the Iran campaign is now reasonably clear. General Randy George, the US Army's chief and a highly decorated infantry officer who served in the Gulf War, Iraq, and Afghanistan, was removed while American forces remained engaged in operations against Iran. His tenure had not run its course. George's firing stemmed in part from Hegseth's long-running grievance with the Army and his troubled relationship with Army Secretary Dan Driscoll, with whom George had been an ally. Driscoll is widely seen as aligned with Vice President JD Vance, adding a dimension of internal political rivalry to what was formally presented as a routine leadership change. The Rumsfeld-Shinseki Episode The parallel with an earlier chapter of American civil-military history has not gone unnoticed. George's ouster carries echoes of Defence Secretary Donald Rumsfeld sidelining General Eric Shinseki after disagreements over troop requirements for the Iraq war. Shinseki paid professionally for his candour. The pattern, a serving chief removed mid-conflict amid reported differences over operational direction, is recognisable. Reporting suggests George opposed Hegseth's push for a land war in Iran, though whether Trump fully backs such a plan remains unclear. Additional developments reinforce the picture. Hegseth has been linked to interventions in promotion processes, including instances where Black officers and women were removed from consideration at senior levels. He intervened to remove multiple Army officers from a promotion list after Driscoll refused to do so, an unusual step that drew White House attention. A close associate from the Secretary's own office has reportedly been posi-



tioned as the leading candidate for the next Army chief, suggesting that the basis for top appointments is shifting. Institutional safeguards have been adjusted as well. Senior military legal officers, responsible for advising on the legality of operations, have been removed. These positions have traditionally served as an internal check within the chain of command, particularly during active operations. A further strand concerns the framing of the Iran campaign itself. Throughout the month of attacks, service members reported rhetoric from commanders invoking the idea of a "holy war", and the Military Religious Freedom Foundation received over 200 complaints from active-duty personnel. One non-commissioned officer described being told the conflict is part of "God's plan" and that the President was "anointed by Jesus to light the signal fire in Iran". Hegseth has used Christianity to justify the US-Israeli war against a Muslim-majority country, telling Americans to take a knee and pray for victory "in the name of Jesus Christ".

More than two dozen members of Congress have formally requested an Inspector-General-level investigation into whether such a war framing contravenes constitutional protections and professional military norms. Taken together, these developments describe a moment in which the military and executive are not fully aligned on a major conflict, and where that gap is being managed through changes in leadership, process, and internal structure, simultaneously, and under operational pressure. The Balance That Matters Most Civil-military systems are designed to accommodate disagreement. Professional militaries are expected to offer candid advice; political leaders are expected to decide. The strength of the system lies in its capacity to absorb that tension without fracturing institutional coherence. During wartime, that balance becomes especially consequential. An armed force engaged externally depends on internal stability, clarity of purpose, and continuity of command. When senior leadership

changes frequently, when promotion processes attract scrutiny, and when advisory mechanisms are restructured, the institution is required to adapt at multiple levels simultaneously while managing an active conflict. These conditions place heavier demands on the system precisely when those demands are already high. Lessons Closer Home Pakistan offers the starkest regional lesson: decades of military-sponsored religious nationalism did not strengthen the state. It hollowed it out, producing institutional decay, democratic erosion, and a security apparatus that ultimately became ungovernable. India is not immune to these pressures either, though it faces them on a far smaller scale; of late, veterans have flagged public displays of religious affiliations by some uniformed officers. The American situation in the Iran campaign is still developing. Its long-term impact will become clearer with time. What it has already demonstrated is that the management of internal military coherence is a wartime requirement.

How Iran Has Pierced The One 'Shield' That Protected America For 30 Years

If the early weeks of the 2026 Iran conflict were intended to showcase the return of decisive American airpower, the events of last week have served as a sobering corrective. Wars against capable state adversaries rarely conform to technological optimism, and this episode underscores the limits of even overwhelming military superiority. The downing of an American F-15E Strike Eagle over western Iran marks a significant inflexion point in the conflict not because of the scale of the loss, which remains limited, but because of its symbolism. For the first time in this war, a manned American combat aircraft has been brought down by enemy fire in hostile airspace. The potential loss of a crew member and the launch of a high-risk combat search-and-rescue operation by the US, though ultimately successful, reinforces the enduring reality that even a single aircraft loss can generate cascading operational, political, and psychological consequences. A Pattern, Not An Anomaly This incident did not occur in isolation. On the same day, an A-10 Thunderbolt II ground-attack aircraft was also lost to Iranian fire over Kuwait near the Persian Gulf, with the pilot ejecting. These developments point to a pattern rather than an anomaly. The vulnerability of non-stealth, low-altitude platforms operating in contested environments is once again being laid bare. The damage sustained by accompanying rescue helicopters - according to Iran's Revolutionary Guards, at least five people were killed, and several "flying objects" were destroyed, including a transport plane, during the rescue operation for the downed fighter jet crew member - further illustrates the layered risks of modern warfare, where efforts to recover personnel can expose additional assets to enemy fire. It is true that these setbacks do not fundamentally alter the strategic balance. The United States retains overwhelming advantages in terms of airpower, precision strike capability, and operational reach. American aircraft continue to conduct sustained sorties across Iranian territory, targeting infrastructure, missile systems, and military installations. Official statements from Washington have emphasised this asymmetry, highlighting the degradation of Iran's

air defences and the broader military pressure being exerted. US Manned vs Unmanned Systems Such assertions, however, deserve closer scrutiny. Degradation is not destruction. Iran's integrated air defence system, though weakened, has demonstrated resilience. The ability to shoot down advanced aircraft, even sporadically, suggests that sufficient capability remains to impose costs. This is not trivial. In high-intensity conflicts, the ability to inflict even limited attrition can shape operational choices, slow campaign tempo, and impose political constraints. The broader pattern of US losses reinforces this point. Earlier in the campaign, a significant number of MQ-9 Reaper drones were shot down over key Iranian locations such as Isfahan and Bushehr. These unmanned systems, often viewed as relatively expendable, have proven vulnerable against layered air defences. While individually less politically sensitive than manned aircraft, their cumulative loss, both in financial and operational terms, is far from negligible. More importantly, the distinction between manned and unmanned losses begins to blur in strategic impact. Drones enable persistence and reduce risk to personnel, but they are not immune to denial. Their attrition limits surveillance coverage, targeting precision, and operational flexibility. At the same time, the loss of even a single manned aircraft introduces a qualitatively different dimension - raising questions of escalation, domestic perception, and the risks associated with pilot capture or casualty. America's Air Superiority Isn't Absolute What emerges from these developments is a more complex and less reassuring picture of contemporary airpower. Air superiority, long viewed as the cornerstone of US military doctrine, no longer guarantees invulnerability. It provides access, freedom of manoeuvre, and the ability to shape the battlespace, but within constraints imposed by increasingly capable adversaries. This has implications that extend well beyond the immediate conflict. For much of the post-Cold War era, US air campaigns - in Iraq, Afghanistan, and Libya - were conducted against relatively weak or degraded air defences. This created an expectation, both within military planning and

public discourse, of low-risk intervention. Airpower was seen as a tool capable of delivering rapid, decisive outcomes with minimal cost. The Iran conflict challenges that assumption. Alongside lessons from the Russia-Ukraine war, it reinforces the reality that state-on-state conflicts involving capable adversaries are inherently contested. Integrated air defence systems, even when partially degraded, can deny airspace, impose attrition, and complicate operational planning. The battlefield is no longer permissive; it is dynamic, adaptive, and unforgiving. Where Does The US Go From Here? In response, doctrinal and technological shifts are likely to accelerate. Greater emphasis will be placed on stealth platforms, stand-off weapons, electronic warfare, and the suppression and destruction of enemy air defences (SEAD/DEAD). The role of autonomous systems and "loyal wingman" concepts will also gain prominence as militaries seek to distribute risk and enhance survivability. At the same time, the importance of human capital - pilot training, mission planning, and resilience under pressure - remains undiminished. Equally, the events of April 3 highlight the importance of multi-domain integration. Airpower alone, however advanced, cannot deliver decisive outcomes in isolation. It must be complemented by cyber operations, intelligence capabilities, ground manoeuvre, and diplomatic engagement. The notion of quick, clean wars driven primarily by aerial dominance appears increasingly untenable. Ultimately, the April 3 losses are a moment of strategic introspection. They don't fundamentally undermine US military superiority but puncture its narrative of effortless dominance. The United States continues to hold the advantage, but it is an advantage that must be exercised with caution, adaptability, and a clear recognition of its limits. In that sense, the real significance of these events lies not in what was lost, but in what they reveal. Contemporary warfare, even for the most advanced militaries, is neither frictionless nor predictable. The mythology of invulnerable airpower should give way to a more grounded understanding - one in which effectiveness coexists with risk, and dominance is always contested rather than absolute.

The Dantewada Massacre, And What India Needs To Do To Stay Maoist-Free

The government has announced that the Maoist menace has been 'wiped out' from the infamous Red Corridor, meeting the deadline of March 31 it had set for itself. While one can bask in the glory of this announcement, it must be remembered that the task of shaping a 'normal', threat-free life for those in the dense jungles of the far-and-beyond has just begun. This was driven home by an almost full-page 'In Memoriam' published today in a national newspaper by the Central Reserve Police Force (CRPF), which carried photographs of 75 of its jawans who were killed by Naxals in Bastar district this day, a decade and a half back. This touched a raw nerve in this writer. My father was the Additional Collector of Bastar district in 1982-83 and based in Kanker, a name that got synonymous with Naxal activities later. The place was peaceful, like any other village in the hinterland of tribal India, and our visits there were wonderful. So, when the Naxal menace became acute at the beginning of this century, I asked my old man what had transformed that quiet place into one where the government writ did not run. His reply shocked me - "We kept sending reports that a parallel organisation had started taking root and political steps were needed urgently to curb it, but to no avail." The results came to haunt us in the coming years. 2010, Then 2013, Then 2017 In 2010, I was Assistant Chief of the Air Staff controlling transport aircraft and helicopters, and on April 6 that year had to arrange An-32 aircraft to carry coffins of 75 CRPF jawans. The mayhem that must have happened is difficult to imagine. The brave hearts of No 62 Battalion, who were on an anti-Naxal operation, were ambushed by a group of 500-plus



Maoists positioned on high ground; the troopers, devoid of any reinforcements due to roads being booby-trapped with IEDs, fought for six hours before making the supreme sacrifice. That these large-scale killings were repeated on May 25, 2013, when 30 people lost their lives (including the Chattisgarh Congress leadership) and on April 24, 2017, when 26 CRPF jawans were killed, showed that, irrespective of the political party in power, the basics of governance had been given short shrift in the previous decades through political unprofessionalism. The steely determination to tackle the Naxal challenge began head-on in 2006 with Prime Minister Dr Manmohan Singh declaring it as the biggest internal security threat. Police forces were pumped in, and the Indian Air Force provided helicopters from 2009 for non-kinetic tasks; it is noteworthy that, though the helicopters were armed, calls for their offensive use were firmly rejected by the government. The rules of engagement were crystal clear - while helicopters would not initiate any proactive kinetic action, they would act firmly in self-defence if fired upon; the beligerents on the ground

were, after all, Indian citizens. It is to the credit of successive governments that the resolve to tackle the insurgency did not flag; in fact, it only went up. Insurgency As A Cancer An insurgency is like cancer. Even after its remission, the patient requires continuous tending in the long term to prevent its return. The lingering sub-surface threat lies in the famous Mao Tse Tung quote that insurgents are like fish in water - water being the local population. If the water is removed from the equation, the fish die. The villagers/tribals who call them the 'common man' must always see two aspects of official power favouring them: the government as a dependable provider of daily sustenance, and second, a deterrent capability that cannot be challenged by any alternate source of power. The insurgent 'fish' must be continuously denied a favourable human cocoon for sustenance. So, what should the long-term strategy be? First, 'winning hearts and minds' of the populace is the cornerstone of any anti-insurgency plan. Improved education facilities for the young would go a long way in strengthening the psychological link with the rest of India. The extensive ingress of gov-

ernment machinery into the erstwhile Maoist strongholds and the widespread road infrastructure and communication facilities created must be improved further to cement governmental writ. As the entry of 'outsiders' into tribal areas increases, it is vital to ensure that tribal traditions and lands are not usurped by unscrupulous elements; the bottom line is that 'exploitation' of people indigenous to the area must be prevented at all costs. Second, backing the administrative efforts should be deterrence, born of the gloved fist of the government's law-and-order machinery. Deterrence is built over time and is a 'process' of ensuring that an adversary follows one's guides without having to go kinetic - Sun Tzu termed it the 'acme of skill' for the warrior in conflict, but it is equally applicable in civil governance where the 'insurgent' is one's own citizen. In anti-insurgency action, the threat of retribution is more important than the actual implementation of punitive measures of law. The Sentencing Project, a 2010 study in the United States, stated that increasing the severity of a punishment does not have much effect on lawbreakers compared to an assurance of certainty of punishment.

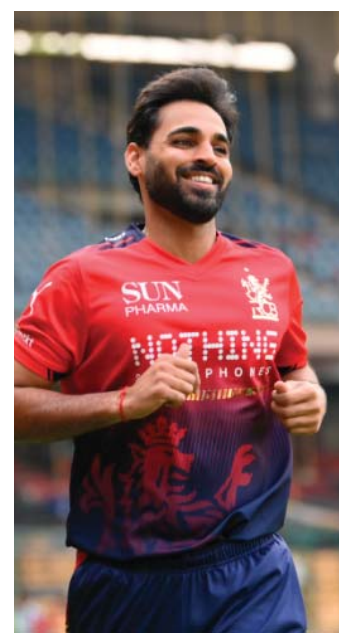

2026 TN elections | Sasikala's ticket picks trigger dissent within AIPTMMK ranks

Sources within the party said that individuals who recently joined from TTV Dhinakaran's Amma Makkal Munnetra Kazhagam are being given

prominence, while long-time loyalists claim they are being sidelined despite their continued support over the years. Allegations have also surfaced that candidates are being chosen based on caste considerations, further deepening internal dissatisfaction. Speaking to DT Next, disgruntled party members said Sasikala's approach has been one-sided and overlooked those who stood by her during challenging periods. Senior leaders, including former Government Whip Narasimman, former min-

ister Anandan and Pooval Kandan, are said to be considering quitting the party.

Candidates have been fielded in constituencies expected to be contested by the AIADMK, as well as in select seats where the AMMK has nominated candidates, in an apparent attempt to demonstrate electoral strength. However, functionaries alleged that several individuals who were denied opportunities in the AMMK but later joined Sasikala's party have been allotted seats.

Rising costs, match units to shut from April 12

CHENNAI: Matchbox manufacturers have announced the closure of around 2,000 units from April 12 to 25, citing a sharp rise in raw material prices linked to global supply disruptions amid the Iran-related conflict. The decision is expected to affect nearly 5 lakh workers, most of them women, engaged directly and indirectly in the industry across Kovilpatti, Sattur, Sivakasi, Sankarankovil, Thiruvengadam, Gudiyatham and Kaveripattinam. Manufacturers said prices of key raw materials, including phosphorus, chlorate, wax, paper and cardboard, have increased significantly. They reported supply constraints, particularly for wax, cardboard and polythene, which were sourced from Iran. They added that domestic suppliers have also raised prices, citing the conflict. Wax prices have increased from about Rs 80 per kg in recent months to Rs 150 per kg. Polythene bag prices have risen to between Rs 60 and Rs 100 per kg, depending on quality.

Tamil Nadu: Will Class 12 exam results be released before Assembly election results?



CHENNAI: The Election Commission is reportedly considering the early release of Tamil Nadu's Class 12 board examination results ahead of the 2026 Assembly election results. Income tax case against Gautham Vasudev Menon quashed by Madras High Court According to Thanthi TV, discussions are

underway to publish the results before May 4. At present, the Assembly election results are scheduled for May 4, while the Class 12 results are tentatively expected on May 8. Officials are assessing whether announcing the exam results around the same time as the election results could influence the electoral process.

Gulf war impact: Textile output cut by 50% in Palladam as unsold fabric piles up

CHENNAI: Textile manufacturers in Tirupur's Palladam town have decided to cut production by 50% from today (April 6) after large volumes of grey fabric remained unsold due to the ongoing Gulf war. Export demand has dropped sharply, with foreign buyers holding back imports, pushing the sector into a crisis, said a Daily Thanthi report. Industry representatives said cotton prices have surged to Rs 7,000 per kg, while polyester and rayon costs have risen by over 30%. Despite this, manufacturers are unable to increase fabric

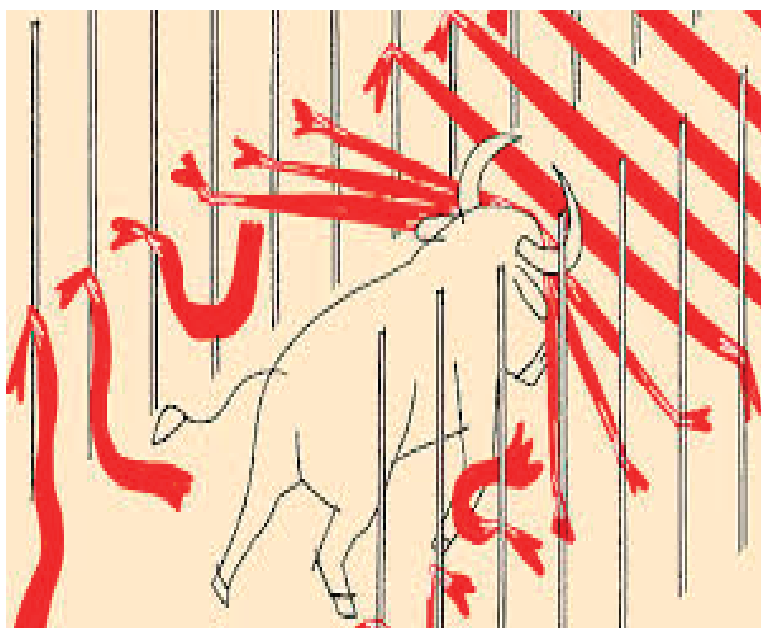
prices, worsening losses. They urged the Centre to remove the 11% import duty on cotton and regulate yarn exports, warning that production may be halted completely if no relief is provided. Around 2.5 lakh powerlooms and 20,000 shuttle-less looms operate across Tiruppur and Coimbatore, producing nearly 2 crore metres of grey fabric worth Rs 100 crore daily. However, with year-end financial closures and a halt in new orders, stocks have piled up, severely affecting sales and threatening the livelihood of lakhs of workers.

Global economy must adapt to avoid tumult this year

The global economy faced many hurdles in 2025. The US government upended longstanding economic wisdom in a manner many economists feared would harm both the American economy and those of other countries. International institutions were sidelined, tariffs levied, the independence of the Federal Reserve questioned — all while debt continued to rise.

Add that to geopolitical crises throughout the world and the nonchalant manner with which capital markets financed artificial intelligence, and there were many opportunities for market failures and recession. Yet the American and global economies recorded strong growth, and stock markets soared.

It's far from assured that we will be as lucky in 2026. To continue our run of economic and financial successes, there must be adjustments involving both the public and private sectors. Both must make smarter choices, focusing on structural reforms, rather than simply throwing money at problems and imposing tariffs on trading partners. Even though the Trump administration boycotted the Group of 20 summit, blanketed the globe in tariffs and dismantled the Washington consensus on liberalisation and free markets that US governments had repeatedly advocated to others, the American economy managed to accelerate real GDP growth to 4.3 per cent in the third quarter and avoid major trade retaliation from most countries. The global economy grew at a respectable 3 per cent; the Chinese economy demonstrated remarkable agility against America's protectionist measures, making up its roughly 30 per cent drop in exports to the United States by shipping more to Europe and Southeast Asia. China's trade surplus, for the first time, exceeded \$1 trillion — a staggering feat.



Then there were AI leaders and the capital markets that enabled them. Valuations soared, driving a 21 per cent gain in the Nasdaq and 17 per cent in the S&P 500 stock market indexes. Nvidia became the world's first \$5 trillion company. OpenAI announced a \$1 billion deal with Disney. It often seemed that financing had no limits for AI companies — even those with less-than-robust revenue and business models, and even worse, those that simply plastered an AI label on existing activities. We also saw the resurgence of self-financing, including when Nvidia essentially gave OpenAI money to buy Nvidia's products.

The same capital markets continued to fund enormous debts and deficits in the advanced world. Yet the much-anticipated general increase in borrowing costs did not materialise. In fact, interest rates ended the year lower. And while there were jitters over some fiscally weaker countries like France and Britain, these were limited and ultimately did little harm as both governments acted to

calm markets, at least in the short term. These achievements were all impressive. But they are essentially first-round wins. The new year will most likely bring risks to economic and financial well-being. There is no coasting on past successes, especially as the warning signs for stability are already mounting.

Lower-income consumer resilience can't be counted on. Trade retaliation might increase. Fiscal and monetary policies are loosening. The labour market is cooling, widening the decoupling of employment from economic growth. China's redirection of trade could cause reprisals from other countries. Add to that a growing divergence in performance among economies, and a picture emerges of a fragile global order. Meanwhile, some of the very narrowly focused AI companies will probably struggle to significantly raise revenues, failing to keep pace with the huge investments made in them.

To come through 2026 in a strong position, governments need to

enact sustainable productivity improvements, rather than stimulate the economy via spending and lower interest rates. We need coherent AI adoption policies — ones that attempt to maximise output gains while limiting labour market shocks — designed and carried out in collaboration with leading companies. And investors must make fewer reckless choices if we want to avoid market instability. Pouring money indiscriminately into AI should give way to backing a smaller group of winners in a more disciplined manner.

American foreign trade and investment policies must become more strategic. The United States needs to work with partners to avoid a fragmentation of the global order that threatens the dollar and risks a spiral in which zero-sum thinking causes countries to act against each other, ultimately making everyone worse off. China, on its side, needs to accelerate its economic restructuring that unleashes domestic consumption rather than redirecting exports around the world; otherwise, it risks becoming a catalyst for protectionism not just from America, but also European and other Asian countries. Political and social pressures around affordability are likely to mount in a US election year. Policymakers must address the so-called K-shaped economy, in which the wealthy see their incomes and assets grow while the less fortunate are hit hard by high prices, heavy debt burdens and decreasing buying power.

History is littered with those who celebrated too early — in sports, in war, and in economics and finance. In 2025, the American and global economy, led by AI and capital markets, skated through a series of obstacles. But the next round is just beginning. No number of successes in the last round will guarantee success in the next.

Gmail to let users change their addresses while keeping data



For more than 20 years, Gmail, the world's largest email account provider, has made it easy for users to change the sender name on their email accounts. But if a user wanted to keep all their data and services — like YouTube or Google Drive — connected to their @gmail account, the email address itself always had to stay the same.

Some users — like those who have been holding onto the same account names since they were teenagers, or people who have changed their names — wished that they were not locked into a state of permanence.

In recent days, though, Google has quietly started to roll out a way for users to change their Gmail addresses ending with @gmail.com, and keep all their emails — no matter how old their account. The change appears to have been first noticed in a "Google Pixel Hub" Telegram group. So far, the new feature is reflected only on the Hindi-language version of

Google's support page but it looks like it will be coming to other languages and regions. "The ability to change your Google Account email address is gradually rolling out to all users, so this option may not be available to you right now," according to an English translation of Gmail's support page. The same message was on Google's help centre in other languages.

Google did not immediately respond to questions about the rollout, and about which users would be next to gain the feature and when. On Sunday, the support page in English still read: "If your account's email address ends in @gmail.com, you usually can't change it." Under the new feature, users' old Gmail address won't disappear after they change their email address. Instead, the old email address will automatically become an alias, allowing it to still receive emails. Other email providers have allowed aliases for years.

Gmail users will be able to use their old or new email address to sign into Google services like Gmail, Maps, YouTube, Google Play or Drive. Crucially, all of a user's files, photos, subscriptions, calendar invites and purchase history stay on the existing account.

There also appears to be limitations, according to the Hindi-language version. Users can change their address only once every 12 months. Additionally, users will be able to create only up to three new email addresses for their account, for a lifetime total of four Gmail addresses. And they won't be allowed to delete their new email address either. Still, the changes ought to be welcomed by users who have clamoured for a change. It appears that any changes would apply only to @gmail.com addresses, and not to Google accounts obtained through employers, schools or other groups. Of course, users would still have to find a name that is not attached to another Gmail account in order for their requested change to be accepted.

Sitharaman flagged emerging risks on the supply side, particularly in energy and fertilisers, as the conflict begins to disrupt trade flows. Gas supplies from the region have been hit, with shipments being diverted and logistics becoming increasingly unpredictable. "There are too many moving parts," the minister said, pointing to challenges around insurance and freight. In some cases, insurers are unwilling to cover shipments,

adding to uncertainty for importers even when supplies are available. On fertilisers, Sitharaman said the situation for the upcoming kharif season remains comfortable, with adequate stocks of urea, DAP and potash already built up. However, she indicated that the government is moving early to secure supplies for the rabi season, even as global price discovery remains uncertain. Economists See Rates On Hold As Iran War Stokes Inflation Fears Suppliers themselves are unclear on pricing amid the volatility, she said, complicating advance procurement decisions. At the same time, the

government is mindful of demand pressures, noting that excess buying cannot be curtailed if it affects farmers. "This is uncertainty, even if we want to prep in advance, there are so many ifs," she said. The minister said the focus remains on staying prepared for contingencies, even as the situation continues to evolve with multiple uncertainties around supply chains, pricing and logistics. Speaking on the macro outlook, Sitharaman indicated that India's fiscal position allows room for the Reserve Bank of India to consider rate cuts, signalling policy flexibility at a time when global uncertainties are rising.

West Asia Tensions Push Companies To Move Backup Data Centers Farther Away; India Sees Demand Surge

The ongoing conflict in West Asia is changing how companies think about their data centers, with a growing shift away from keeping backup facilities nearby to placing them farther away to reduce risk. Earlier, companies preferred secondary data centers to be located in the same city or nearby regions to keep costs low and ensure faster data access. "That approach is now changing. "We're seeing a shift from proximity-related redundancy to risk-distributed resilience," said Sachin Tayal, Managing Director at Protiviti Member Firm. He added that firms are now preparing for scenarios where "an entire region goes down," not just a single facility. ALSO READ | No Truce In Sight? Iran Calls US 15-Point Plan 'Illogical', Prepares Counterproposal This shift is already showing up in demand. Co-Founder and CEO of Yotta Data Services Sunil Gupta said data center demand has jumped sharply in the past three to four weeks, with fresh requirements ranging between 200 and



500 megawatts. He added that this reflects companies reworking their infrastructure to hedge against geopolitical risks. India is emerging as a key alternative location. Gupta said India can offer nearly twice the data center capacity for the same investment compared to some Asia-Pacific regions, and could absorb 15-20% of workloads from the Gulf in the next three to six months. According to Tayal, companies are increasingly choosing multiple locations across

regions or countries instead of relying on a single geography. This is especially visible in sectors such as financial services and digital platforms, where downtime risks are high. At the same time, firms are trying to balance performance and safety. Critical, real-time operations are still kept closer to users, while backup systems are being moved to distant locations. "It's no longer about choosing between latency and resilience, but designing

systems that deliver both," Tayal said. Importantly, companies are now willing to spend more for this added safety. What was earlier seen as an optional cost is now being treated as essential risk protection. Taken together, executives say this marks a longer-term shift. Gupta noted that the move towards geographically spread-out data infrastructure is not temporary, but a "permanent structural change" in how companies build and manage their digital backbone.

SWIGGY VS ETERNAL: WHO WILL WIN THE Q4 EARNINGS BATTLE?

Analysts expect a mixed set of earnings from India's new-age technology companies in the March quarter, as rising macroeconomic uncertainty, competitive intensity and continued investment in quick commerce weigh on profitability even as revenue growth remains strong. Brokerages remain constructive on long-term growth, but near-term margins continue to be closely monitored. Brokerages on Eternak According to Kotak Institutional Equities, Eternak is expected to report healthy growth in Q4, driven by strong performance in both food delivery and quick commerce arm Blinkit. The brokerage expects food delivery net order value (NOV) to grow 17% year-on-year, while Blinkit NOV is projected to surge 99% year-on-year, supported by aggressive store additions and improving throughput at existing stores. Sequentially, food delivery NOV may decline 2.4% due to seasonality, while Blinkit NOV could rise around 10% quarter-on-quarter. Margins



are also expected to improve slightly. Food delivery Ebitda margin is estimated at around 5.7% of NOV, up 30 basis points quarter-on-quarter, driven by higher platform fees, improved restaurant take rates and increased advertising income. Contribution margin is expected to rise to 10.7% of NOV. For Blinkit, profitability may remain flat sequentially as operating leverage from older stores is offset by pricing actions amid rising competition. However, Kotak believes Blinkit remains best positioned among quick

commerce players due to improving ad monetisation and a higher proportion of mature stores over time. Meanwhile, HDFC Securities expects Eternak's NOV growth to be supported by dark store expansion and stable order growth. The brokerage expects adjusted Ebitda margins of around 5.6% of NOV, broadly stable quarter-on-quarter. It also noted that the food delivery growth gap between Eternak and Swiggy may narrow in quarter ended March due to user additions driven by membership programmes.

Nuvama Institutional Equities expects Eternak's food delivery NOV to grow about 18% year-on-year, with Blinkit continuing to drive overall growth. Margin improvement is expected to remain gradual, with profitability improving as scale increases. Brokerages on Swiggy Brokerages expect Swiggy to report steady revenue growth in quarter ended March, led by food delivery and Instamart, though profitability in quick commerce is likely to remain under pressure. Kotak Institutional Equities expects Swiggy's food delivery gross order value (GOV) to grow 19% year-on-year, with revenue growth of about 23% driven by higher take rates and platform fee hikes. Contribution margin is expected to improve by 20 basis points quarter-on-quarter to around 7.8%, while adjusted Ebitda margin may improve to 3.2%. Instamart is expected to report strong growth, with GOV rising 75% year-on-year and revenue growing 66% year-on-year.

The Easter Egg Roll is a long-running tradition at the White House, which first marked it in 1878. It's, in theory, a light-hearted event in which staff members, guests and even reporters bring their children along. This year's edition is expanded, and besides the hunt for Easter eggs there are activity stations such as "Hen to Home" - in which children can get a close look at live chicks, as well as a military card writing station and lunar exploration experience. The carefree, child-focused atmosphere, however, stands in stark contrast to President Trump's comments on Iran, which is says is "not so strong" now following more than a month of sustained US and Israeli bombing. We're expecting more substantive comments on the war at his later news conference in the White House briefing room. It is clear, however, that he is celebrating the success of the



complex and dangerous search-and-rescue mission inside Iran as a notable victory - in a war that seems to many Americans to be getting more complicated and difficult to get out of. US President Donald Trump has been now speaking at the White House's annual children's Easter event. Flanked by the Easter Bunny, Trump starts by speaking about the war in Iran and yesterday's

rescue of an injured airman left stranded in a remote mountainous region of Iran after his aircraft was shot down. "It's something that you rarely see," Trump says of the rescue, calling it difficult and high-risk. "I don't think it gets much more hostile than Iran." He says it's hard to conduct such an operation within the territory of an enemy that is "strong", but adds that Iran is

not as strong as it was a month ago. Trump also teased his news conference later today - around 13:00 local time (18:00 BST) - during which he's expected to speak more about the war and the rescue. According to Iranian state news agency IRNA, in its 10-point response Iran has rejected a ceasefire and emphasised the necessity of a permanent end to the war. It says the

response includes a list of Iranian demands - including an end to hostilities in the region, a protocol ensuring safe passage through the Strait of Hormuz, as well as reconstruction and the lifting of sanctions". IRNA adds that US President Donald Trump "by extending the repeated deadline once more, has stepped back from his previous threats." The state-run Iranian news agency IRNA is now reporting that Tehran has submitted its response to a US proposal to end the war. The agency reports the 10-point response includes a rejection to a proposed ceasefire, saying there needs to be a permanent end to the war. It's already extremely crowded at the White House, where dozens of reporters have come in early to stake their claims on limited real estate in the briefing room ahead of President Donald Trump's news conference this afternoon. When Trump steps up

to the podium at 13:00 local time, he will be peppered with questions about the successful rescue operation that recovered the two crew members of a US F-15, as well as where he sees the conflict going in coming days, weeks and months. One question that he is likely to face is about the lingering threats to US forces, despite his claims that Iran's military is largely unable to function. Trump has claimed that US forces have achieved "air superiority" over Iran. That does not mean they are immune to threats, as the pilots of at least two aircraft found out in recent days. It may, however, mean that any escalation could result in US casualties that might prove domestically difficult for the administration. Trump is also likely to be asked about the state of any ongoing negotiations or potential ceasefire - which the White House this morning described this morning as "an option".

DR CONGO AGREES TO TAKE DEPORTEES FROM THE US



The Democratic Republic of Congo has agreed to accept migrants deported from the US who are not themselves Congolese under a deal effective from this month, officials said. The Ministry of Communication said a temporary reception system had been set up, while facilities to accommodate arrivals had been selected in the capital, Kinshasa. "Logistical and technical support" will be provided by the US, the statement on Sunday said, adding that the Congolese government would bear no financial cost for the scheme. The government did not say how many deportees they would

accept. The US has already sent deportees to several other countries in Africa as part of Washington's crackdown on immigration. Amid concerns that migrants could be returned to their home countries - where some fear persecution - Congolese officials said no such transfers are being planned. The decision to receive what are known as third-country migrants - that is those who come from neither the sending nor receiving nation - aligns with DR Congo's commitment to human dignity, international solidarity and to protect the rights of migrants, the statement read.

US Secret Service investigates reports of gunfire near White House



The US Secret Service is investigating gunfire heard near the White House early on Sunday morning. Officers responded to reports of gunfire in the area around Washington DC's Lafayette Park just after midnight local time (04:00 GMT) and conducted a search of the park, just north of the president's residence, and the surrounding area, the agency said. No suspect was located and no injuries were reported, the Secret Service said. The agency and its partners are looking for a possible vehicle and person of interest. President Donald Trump was in Washington DC this weekend. The Secret Service said operations at the White House remain normal but "a heightened security posture is in place". The

investigation closed some roads in the area, but they have since reopened, Secret Service spokesman Anthony Guglielmi said in a post on X. A representative for the Secret Service confirmed to the BBC on Sunday evening that "the investigation continues". The president remained in the capital this weekend rather than flying to his Mar-a-Lago estate in Florida, where he often spends his weekends. In a post on X, White House communications director Steven Cheung said on Saturday that Trump "has been working non-stop in the White House and Oval Office" this Easter weekend. Trump is slated to host a family Easter dinner at the White House on Sunday, according to the BBC's US media partner CBS News.

YOUNG GRAY WHALE DIES AFTER SWIMMING UP RIVER IN WASHINGTON STATE



A young gray whale has been found dead after swimming 20 miles (32.2km) inland up a river in Washington state, a local scientific research group said, pointing to hunger as a possible cause. "We are saddened to confirm that the whale seen in the Willapa River over the past few days is deceased," the Cascadia Research Collective said in an update on Facebook on Saturday. It added the group was evaluating the safety of the location

to carry out an examination. The juvenile whale, affectionately dubbed "Willapa Willy" by locals, was first spotted last Wednesday in the north fork of the river, about 145 miles southwest of Seattle, the marine mammal research group said. The whale, "although thin, was behaving normally," the group said at the time, with no sign of injuries. Its teams had hoped the whale would find its own way out of the river but it failed to do so.

HOW RESCUE OF US AIRMAN IN REMOTE PART OF IRAN UNFOLDED

US special forces launched a high-stakes raid into Iran on Sunday to rescue an injured airman left stranded in a remote mountainous region after his aircraft was shot down two days earlier. While many details remain confidential, some information has begun to emerge about how the US raced against the clock and advancing Iranian operatives to find the officer deep inside hostile territory. The airman's ordeal began on Friday when an F-15E Strike Eagle jet was shot down over southwestern Iran - the first incident of its kind in more than 20 years. The two US military personnel on board ejected and, while the pilot was rescued the same day, the second crew member - a weapons operator - became separated and remained stranded in a sparsely popu-



lated, rugged region. Official confirmation soon followed swirling reports that a US airman was missing inside a war zone. While US aircraft were seen flying low over the area on Saturday, Iran offered a bounty of \$50,000 (\$86,100) to anyone who found him alive, and videos shared on social media, which have not been verified by the BBC, appeared to show armed civilians searching. The airman

was armed with a handgun, US officials said, and would have received training for this situation, which involves intermittently turning on a beacon signal to help American forces locate him, getting to high ground, establishing communications and concealing himself. According to reports in US media, the airman hid in a mountain crevice and restricted the use of his bea-

con signal out of concern it could be picked up by Iran. A senior Trump administration official said the CIA was able to trace the airman's exact location and informed the Pentagon, which would have also had to rule out the possibility the beacon signal was an Iranian trap. Donald Trump later said the injured airman's location was monitored "24 hours a day" as he was "being hunted down by our enemies, who were getting closer and closer by the hour". The CIA also reportedly ran a deception campaign inside Iran, falsely spreading word that US forces had already found him. As US special forces aboard several aircraft made their way towards the stranded officer, strikes were reportedly launched to keep Iranian troops away from the area.

Trump declares victory after rescue but threats to US operation in Iran still loom

US President Donald Trump was swift to declare victory after the second crew member of a F-15 fighter jet downed over Iran was recovered, claiming that the dramatic and successful rescue in Iranian territory "proves, once again, that we have achieved overwhelming air dominance and superiority". Observers, however, paint a more complicated picture of what this means for the US in Iran. While the mission was a success, the events of the last few days - in which two aircraft were downed and at least one helicopter was hit by gunfire - highlight that threats to US aircraft and personnel remain even after



weeks of heavy US and Israeli strikes against Iran's military infrastructure and boasts from the president that Tehran had "no anti-aircraft equipment" left. Several Washington sources who spoke to the BBC speculated that the loss of aircraft and the complexi-

ty of the operation to recover the pilots could potentially dissuade Trump from any ground operation to take control of Iran's key oil export terminal at Kharg Island and other sites in the Gulf, or to seize highly enriched uranium buried deep underground in Iran.

These operations - scoped by military planners and presented to the president as options - are deeply complex and risk exposing US forces to lingering Iranian capabilities, including difficult-to-find man portable air defence systems, known as Manpads, which are shoulder-launched missiles most effective against low-flying aircraft. On the other hand, the fact that US troops were able to enter a contested environment, and set up a forward airfield and refuelling point under the nose of the Iranians - then hold it for hours while two stuck aircraft were destroyed and replacements sent - might embolden him.

'Really feeling the love' - Savannah Guthrie returns to NBC as search for mother goes on



US television presenter Savannah Guthrie has returned to NBC's Today show, telling her co-anchors it was "good to be back", as the search for her mother continues. It was her first appearance in the studio since 30 January, two days before her 84-year-old mother Nancy was reported missing. Her co-anchors noted on Monday that many fans were standing outside the studios on a chilly New York morning carrying signs welcoming Guthrie back. "I'm really feeling the love," she said in response. Investigators believe Nancy Guthrie, who was last seen on 31 January, was taken against her will from her home near Tucson, Arizona, but they have not shared a possible motive or arrested a suspect. Before giving his typical weather report, NBC forecaster Al Roker blew her a kiss and said: "It's good to see you my dear." Guthrie carried on with the news as usual, telling viewers about the Artemis moon mission and the National Collegiate Athletic Association men's basketball tournament finals. Last month she said it was "part of my purpose right now" to return to work although she was unsure if she would still be able to do

it. On Easter Sunday, Savannah Guthrie reaffirmed her Christian faith in an Easter video message from a church in New York. "I still believe. And so I say with conviction, 'Happy Easter,'" she said in her closing message at the end of the Easter Sunday service at Good Shepherd New York. The NBC presenter, one of the most recognisable figures on morning television in the US, had temporarily stepped away from her anchoring duties after her mother's disappearance. She also stood down from NBC's coverage of the Winter Olympics. In an interview last month with Today, she said: "I can't not come back. This is my family." She also raised the possibility that her own fame may have been behind her mother's disappearance, saying that thought was too much to bear. Nancy Guthrie vanished without her medicines. She was dropped off at her home by relatives on the evening of 31 January and then failed to show up at a friend's house to watch a virtual Sunday service the following morning. The family announced in February a \$1m reward for information leading to her return.

Hungary alleges plot to blow up gas pipeline ahead of election



Hungarian Prime Minister Viktor Orban has convened an emergency meeting of the National Defence Council after explosives were found near a pipeline that transports Russian gas to Hungary. The discovery in a border area of neighbouring Serbia comes as Orban's party is badly trailing in opinion polls ahead of crucial elections next Sunday. Opposition leader Peter Magyar

accused him of "panic-mongering" orchestrated by "Russian advisers", days after security experts warned of a possible "false flag" operation that could be blamed on Ukraine. Orban, an ally of Russian President Vladimir Putin, has resisted EU calls to abandon Russian energy imports since the full-scale invasion of Ukraine. In recent weeks Hungarian security experts have raised the possibility of a staged operation, either on Hungarian or Serbian territory, intended to arouse enough sympathy for Orban to help his Fidesz party win the election - or to give Orban an excuse to declare an emergency and postpone or cancel the vote.

CSK Icons React As Franchise Suffers Third Consecutive Loss In IPL 2026

Bogged down by a third successive loss this IPL season, Chennai Super Kings team management must work on keeping a "hurting" dressing room in good spirits to arrest the slide, Indian spin legend R Ashwin has said. CSK suffered a crushing 43-run defeat to Royal Challengers Bengaluru on Sunday to remain at the bottom of the points table with three straight reverses. Speaking on JioHotstar, Ashwin and former South African captain Faf du Plessis analysed CSK's problems. "I am sure the dressing room atmosphere is going to be hurting. I am not too sure how hard the words can be, but honestly, with such a young side, there is only one way you can go and that is upwards. "The way to go upwards is to get a really good work ethic going and a good team atmosphere. I am sure it is going to be



extremely deflating inside that Chennai dressing room after this thumping defeat to RCB," Ashwin said. The former India spinner said it is not fair to expect accountability from the inexperienced players. "It is very tough to put CSK's defeat against RCB into words. The RCB-CSK contest is supposed to be one of the most

celebrated clashes in the IPL. "There are some issues in the squad, but there are a lot of inexperienced players in that line-up. We cannot really ask them for accountability. They are at an age where they need to go out and enjoy their cricket. You cannot push them into the legacy chase that is expected from a franchise of CSK's

calibre." Opting to bowl first after winning the toss, CSK ran into a rampaging Tim David, who hammered a 25-ball 70 to power RCB to an imposing 250/3. Du Plessis backed India's T20 World Cup hero Sanju Samson to come good after failing to fire in the first three matches. "If you take a close look at the CSK batting line-up, you

would say the quality is there. So, you back the quality. You back Ruturaj Gaikwad, the captain. He has proven it over and over again. Sanju Samson is a class player, who proved his doubters wrong in the T20 World Cup. "And then you have a mighty talented youngster in Ayush Mhatre, who has been exceptional so far in his short IPL career. So, you have the talent in the top three. It is just a matter of letting them put it together. "There is no way that Sanju Samson scores runs for fun in the T20 World Cup but ends up failing multiple times in the IPL. He is too good a player to fail multiple times. You just have to back him and give him time," Du Plessis said. Asked how the consecutive defeats will test Ruturaj Gaikwad as a leader, the South African said this tough phase will help him evolve in captaincy.

R Ashwin Explains How Quitting Test Cricket Made Virat Kohli A New Beast In T20 Cricket

Royal Challengers Bengaluru (RCB) batter Virat Kohli has looked like a different beast in T20 cricket, despite quitting T20 internationals two years ago. Kohli has looked in prime touch since the Indian Premier League (IPL) 2026 season started, as the Bengaluru franchise sets high expectations for the talismanic batter again for this campaign, former India spinner Ravichandran Ashwin explained how quitting the Test format helped Kohli unlock a few more shots in his arsenal. In the match against the Chennai Super Kings on Sunday, Kohli hit a no-look six, giving fans a Gen-Z vibe, matching young batters in playing an inventive style of cricket, Ashwin, speaking on 'Champions' vali Commentary' as a JioStar expert, explained how quitting Test cricket helped Kohli unlock such shots. "Virat was still playing Test cricket in 2024, he was very still, the bat wouldn't move much, but now, here in 2026, the bat is

FEMALE COACHES MAKE HUGE DIFFERENCE - SCARRATT



When Emily Scarratt returns to Allianz Stadium on Saturday, it will be in a different role to the one she played during England's World Cup win in September. The Red Roses' record points-scorer, who had been player-coaching at Loughborough Lightning, hung up her boots after England's final victory over Canada. Injury and high-level competition in the centres resulted in arguably the greatest England women's player being deployed on the ground as the team's water carrier. The role had her connected with the coaching team via an earpiece to bring on valuable information to the team. Now she returns for the 2026 Women's Six Nations as England's new lead attack and backs coach, replacing former assistant coach Lou Meadows. With Scarratt's former team-mate Sarah Hunter the side's defence coach, England are developing two of the game's biggest talents as the Red Roses' wait for a female head coach continues. When asked about the value of having women coaching women's teams, Scarratt told BBC Sport: "It is huge.

"I have spent so much of my career being coached by men, and brilliant men, and men who have had so much experience and can bring so much from their own experiences into our world. "Having females around the environment makes a big difference. Just being able to check in with players differently, have different sorts of conversations, be comfortably able to go into the changing room and grab somebody you know, just simple logistics like that. "I found it in terms of the girls feeling like they can say stuff to me that perhaps they wouldn't feel comfortable saying to either an older coach and/or a male coach." At the Women's World Cup last year, 32% of coaches were female, up from 15% in 2021. However, that number fell short of the 40% target set by World Rugby after the previous tournament in New Zealand. In March, it was announced that every team in Fifa's women's football tournaments must include at least one female head coach or assistant coach following the introduction of new regulations.

Richardson wins Stawell Gift despite 10m handicap

ShaCarri Richardson overcame a disadvantage of up to 10 metres to become only the third woman in history to win Australia's iconic Stawell Gift from the back of the field. At an event where athletes are handicapped according to form and ability, Olympic 100m silver medalist Richardson raced from the 'scratch' mark - meaning she was required to run the full 120 metres and overtake the entire field to claim the title. The 26-year-old clocked 13.08 seconds in the final on the uphill

grass track to record the fastest women's time in the 148-year history of the event. Richardson edged Australian 19-year-old Charlotte Nielsen, who began with a nine-metre head-start, in the closing stages to claim the prize pot of 40,000 Australian dollars (£20,900). Former world 100m champion Richardson, who almost missed out on the showpiece after easing up before the line in her semi-final, said she knew she was going to win well before the finish line. "I think I realised I was going to win right past 90

metres," Richardson told Australian broadcaster Seven Network. "This is one of the most exciting, fun and entertaining track meets I've ever ran in, not even just that, but the love, the true love and support for track and field, unbeatable." The three-day competition in the rural town of Stawell featured more than 700 competitors and offered total prize money of A\$155,000 (£81,000). Jamaican Asafa Powell, Britain's Linford Christie and Australian great Cathy Freeman are among the global champions to

compete at the event since it was first held in 1878. Richardson's partner and fellow American sprinter Christian Coleman, holder of the indoor 60m world record, contested the men's event. The former 100m world champion was eliminated in the semi-finals, where he finished fifth in 12.48 seconds. The men's event was won by Australian 21-year-old Olufemi Komolafe in 11.93 off a five-metre start - starting behind all but one of his competitors, with runner-up Jake Ireland starting at 4.5m.

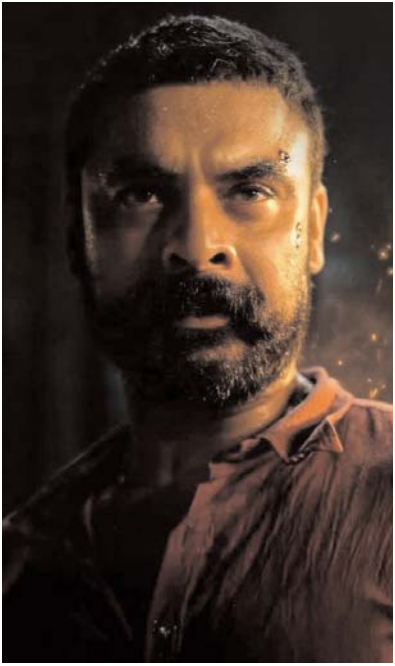

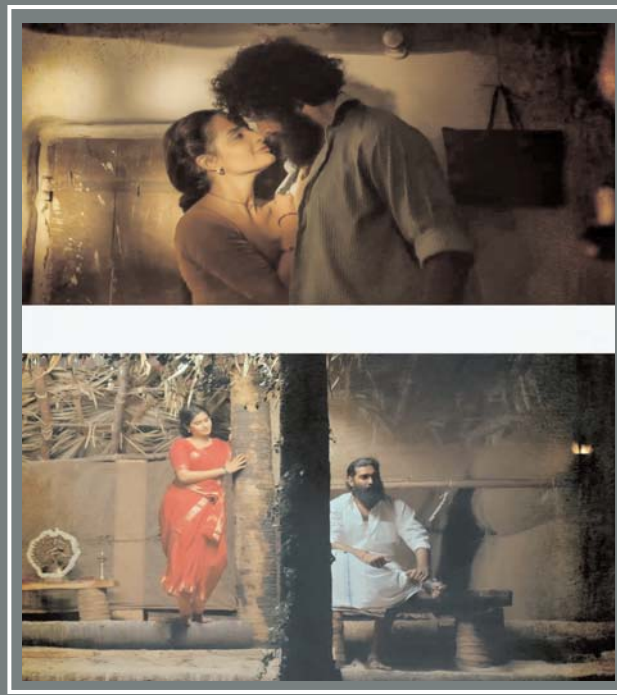
