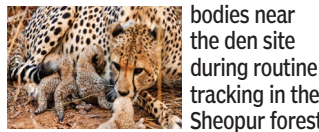

Four cheetah cubs die in Kuno

Sheepur (TSIT): Four cheetah cubs born to female cheetah KGP-12 were found dead at Kuno National Park in Madhya Pradesh's Sheepur on Tuesday morning, in a setback for India's cheetah reintroduction project. Forest officials suspect the cubs may have been killed by a wild predator. The cubs, born on April 11, were about one month old. A monitoring team discovered their bodies near the den site during routine tracking in the Sheepur forest area, the Cheetah Field Director at Kuno said while confirming the report. It stated that the same team had seen all four cubs alive on Monday evening, making the deaths sudden. The Field Director of Project Cheetah, in an official statement on Tuesday, said the cubs' bodies were partially eaten, which suggests an attack by a carnivorous animal.



Gold and silver prices gain up to 1 pc

Mumbai (TSIT): Gold and silver prices traded higher on Tuesday, with both precious metals witnessing gains of up to 1 per cent amid rising global uncertainty. On the Multi Commodity Exchange (MCX), gold futures (June 5) opened at Rs 1,53,999 per 10 grams, up Rs 336 or 0.22 per cent from the previous close of Rs 1,53,663. At around 10:25 am, gold was trading at Rs 1,53,808, higher by Rs 145 or 0.09 per cent. The yellow metal touched an intraday high of Rs 1,54,243, up Rs 580 or 0.37 per cent, while the intraday low stood at Rs 1,53,771, higher by Rs 108 or 0.07 per cent. On the other hand, silver futures (July 3) opened at Rs 2,80,229 per kg on MCX, rising Rs 1,988 or 0.70 per cent from the previous close of Rs 2,78,311. The white metal touched an intraday high of Rs 2,82,755, up Rs 4,444 or 1.6 per cent. It also touched an intraday low of Rs 2,79,244, higher by Rs 933 or 0.33 per cent.

International Nurses Day is observed every year to honour the vital role nurses play in hospitals, clinics, emergency departments and community healthcare systems around the world. Their responsibilities often extend well beyond patient treatment. Nurses provide emotional support, manage medical coordination, handle documentation, monitor patient conditions and respond to emergencies, often all within a single shift. The day is being marked globally to acknowledge the dedication and impact of nurses on healthcare systems every day. The date commemorates the birth anniversary of Florence Nightingale, whose contributions laid the foundation for modern nursing practices worldwide. This year's theme, "Our Nurses. Our Future. Empowered Nurses Save Lives," highlights the importance of supporting nurses through safer working conditions, better opportunities and stronger institutional backing to improve healthcare outcomes.



International Nurses Day is organised globally by the International Council of Nurses to emphasise the essential role nurses play in healthcare services. Every year, the council releases an IND Kit that includes educational resources, campaign materials and guidance for healthcare organisations and nursing professionals. The occasion is now observed in more than 100 countries, with hospitals, medical institutions and communities recognising the contributions nurses make to patient care and the overall functioning of healthcare systems. The origins of the observance date back several decades. In 1953, Dorothy Sutherland from

the US Department of Health proposed establishing a dedicated day to honour nurses, though the idea was not approved at the time. The International Council of Nurses later began commemorating the occasion in 1965 and officially established it in 1974.

The 2026 Nurses Day theme, "Our Nurses. Our Future. Empowered Nurses Save Lives," focuses on the relationship between strong healthcare systems and well-supported nursing staff. According to the campaign message, healthcare services improve when nurses receive fair salaries, adequate staffing support, leadership opportunities and access to quality education and training.

This year's campaign will also promote hashtags such as #IND2026 and #OurNursesOurFuture across social media platforms. The theme comes at a time when healthcare systems in many countries continue to face increasing pressure due to staff shortages, rising patient demand, climate-related emergencies and conflict situations. Nurses remain at the forefront of these challenges, often working under demanding conditions with limited support.

Cong alleges ECI-BJP nexus in Bengal appointments

New Delhi (TSIT)

The Congress on Tuesday launched a sharp attack on the BJP and the Election Commission of India over key appointments in West Bengal, alleging "brazen collusion" between the ruling party and the poll body. Congress general secretary in-charge communications Jairam Ramesh



alleged that former Chief Election Officer Manoj Agarwal and senior bureaucrat Subrata Gupta had been rewarded with top posts in West Bengal after allegedly helping the BJP gain electoral advantage through manipulation of electoral rolls.

In a post on social media platform X, Ramesh claimed that Manoj Agarwal, a 1990-batch IAS officer who oversaw the 2026 West Bengal Assembly election as the state's Chief Election Officer, had now been appointed as the new Chief Secretary to the Government of West Bengal. He further alleged that Subrata Gupta, also a 1990-batch IAS officer who served as Special Roll Observer overseeing deletions under the Special Intensive Revision (SIR) of electoral rolls, had been appointed Chief

Adviser to West Bengal Chief Minister Suwendu Adhikari.

"These appointments reflect the brazen collusion and connivance between the ECI and BJP. There is no longer even an attempt to keep the collusion discrete or concealed," Ramesh said in his post.

Leader of the Opposition Rahul Gandhi also attacked the BJP and the Election Commission in a separate post on X, writing: "In the BJP-EC's 'market of thieves,' the bigger the theft, the bigger the reward."



Claiming that the Election Commission acted in a partisan manner during the Assembly polls, the Congress leader alleged that "an entire state went to election with 27 lakh people being debarred from voting" and asserted that the exercise was "tactfully executed by the ECI to create an electoral advantage for BJP". The remarks come amid continuing Opposition criticism of the Election Commission over voter list revisions and alleged irregularities in several states.

Akhilesh slams BJP over economy & austerity call

Samajwadi Party president Akhilesh Yadav on Tuesday called the BJP a "threat" to the country's economy, and claimed that Prime Minister Narendra Modi's recent appeal to people for austerity reflected the ruling party's "decline".

Addressing mediapersons here, Yadav said the BJP-led government at the Centre has "ruined" the economy despite making tall claims over the years.

"The BJP is a threat to the country's economy. Prime Minister Narendra Modi's recent appeal to people reflected the ruling party's decline. The BJP has been in



power at the Centre for 12 years. Why has the economy weakened and gone off track? Why is the government having to make such appeals to people?" he asked.

Himanta Biswa Sarma sworn in as Assam Chief Minister for second term

Bengaluru (TSIT) Himanta Biswa Sarma was sworn in as the Chief Minister of Assam for a second consecutive term on Tuesday after leading the BJP-led NDA alliance to a massive victory in the Assam Assembly elections.

Assam Governor Lakshman Prasad Acharya administered the oath of office and secrecy to Sarma at a ceremony held at the Veterinary Ground in Guwahati. Four other ministers representing NDA alliance partners were also sworn in during the event. Prime Minister Narendra Modi, Union Home Minister Amit Shah, Defence Minister Rajnath Singh, Union Minister Nitin Gadkari, and Union Minister Sarbananda Sonowal attended



the swearing-in ceremony along with several NDA chief ministers and senior BJP leaders. Following the oath ceremony, Prime Minister Modi congratulated Sarma and praised his administration, describing it as a "great day for Assam." Among the ministers sworn in were Rameswar Teli, Ajanta Neog,

Atul Bora, and Charan Boro. After taking oath, Sarma said he felt honoured to serve the people of Assam again and pledged that the NDA government would continue working for the welfare and development of the state under the leadership of Prime Minister Modi.

India has ample crude, LNG and LPG reserves: Puri

New Delhi (TSIT)

India has adequate crude and LPG stocks and no immediate supply crisis, union Petroleum Minister Hardeep Singh Puri said on Tuesday, while highlighting that the country is maintaining strong energy buffers despite global volatility in oil markets. Speaking at the CII Annual Business Summit 2026, the minister said that India currently holds around 60 days of crude oil reserves and liquefied natural gas (LNG) as well as 45 days of liquefied petroleum gas (LPG), adding that these levels are sufficient to ensure stability in domestic supply. "We have 60 days of crude, which is the max we need. We have 60 days of LNG and 45 days of LPG," Puri said, stressing that India's energy preparedness remains strong even amid global price fluctuations and supply pressures.

'NEET & unclean': CBI registers FIR over 'paper leak'

New Delhi (TSIT)

The CBI lodged an FIR on Tuesday in connection with the alleged leak of the NEET (UG) 2026 paper, officials said. The high-stakes entrance examination, held on May 3 for admission to undergraduate medical courses, was cancelled by the National Testing Agency (NTA) on Tuesday after allegations of malpractice surfaced.

After receiving a reference from the Centre, the CBI moved with alacrity, registering a case of criminal conspiracy, cheating and other offences, the officials said. The agency will soon dispatch a team to Rajasthan to collect material from the Special Operations



Group (SOG) of the state police, which was investigating the case. The CBI had earlier solved the NEET paper-leak cases of 2024.

The Centre has referred the matter to the CBI for what the officials described

as a "comprehensive inquiry" into allegations of paper leak linked to the examination. The NEET-UG 2026 was conducted in 551 Indian cities and at 14 overseas centres. Nearly 23 lakh candidates had registered for the

test, which was administered by the NTA at centres across the country. According to the NTA, information relating to alleged malpractice was received on the evening of May 7, four days after the examination was held. The NTA said the inputs were escalated to central agencies the following morning for "independent verification and necessary action".

The Rajasthan Police's SOG had claimed that a "guess paper" for chemistry that was allegedly circulated among students ahead of the examination had approximately 410 questions, including roughly 120 questions that appeared in the test.

While the chemistry paper in the exam carries 45 questions, the test used four sets of question papers. "It is reported that this guess paper had been circulating among the students well in advance; it began reaching them as early as 15 days to a month prior to the actual examination. We are investigating on the basis of the guess paper and it is also available in open domain," ADG, SOG, Vishal Bansal, had said.

Arvind Kejriwal sees 'political patronage' behind NEET paper leak



New Delhi, May 12 : Aam Aadmi Party (AAP) convenor Arvind Kejriwal on Tuesday slammed the Central government over the NEET-UG 2026 paper leak and questioned its 'silence and inaction' against the examination mafia. Speaking to newsmen in a press conference,

Kejriwal claimed that the large-scale collusion at top levels and political patronage to those involved in such crimes are primarily the reasons behind the paper leak of such magnitude. He said that the lives of lakhs of students are at stake because of the NEET paper leak, but the govern-

ment is looking the other way, questioning whether it understands the scale of suffering that the children and their families go through during such times.

The NEET examinations, held on May 3, were cancelled on Tuesday by the National Testing Agency (NTA), the central body that conducts competitive exams, after incriminating inputs were received by the central agencies about irregularities in the examination process.

Kejriwal, accusing the Centre of gross failure as well as negligence, said that this was not the first time that the exam papers had been leaked.

Two Arrested in Shadnagar Murder-for-Gain Case



RANGAREDDY : The Shadnagar Police under the Future City Commissionerate solved a murder-for-gain case within 48 hours and arrested two persons for allegedly killing a farm worker for cash near SRR Venture on the outskirts of Shadnagar.

The victim, Palle Keshavulu, 39, a farm labourer from Sardar Nagar, was found dead with severe head injuries near Veerlapalli road on May 10 after police received a dial-100 alert.

Police said Keshavulu had returned to Shadnagar from Pargi after borrowing Rs.50,000 from his employer to settle a family land dispute. After handing over part of the amount to a relative, he was carrying the remaining cash when he reached

Shadnagar. Using technical evidence, police arrested Pullagoyi Bajarama, 40, and Bainla Yadamma, 48. According to police, Keshavulu met Bajarama at a wine shop near the bus stand on the night of May 9. After noticing the cash with the victim, the accused allegedly lured him to an isolated place near SRR Venture on the pretext of spending time there. Police said an argument broke out when Bajarama allegedly tried to rob Keshavulu, following which he attacked the victim with a stone, causing fatal head injuries. The accused later fled with Rs.7,500 on a motorcycle. Police recovered Rs.3,900 cash, a Honda Shine motorcycle and mobile phones linked to the case. Both the accused were remanded to judicial custody.

PMO Director stresses coordinated efforts for farmers' development under PMDDKY

Jogulamba Gadwal TSIT. Raghu stressed the need for coordinated efforts among all departments to ensure the economic development and overall welfare of farmers through the PM Dhan Dhanya Krishi Yojana (PMDDKY) and allied agricultural initiatives in Jogulamba Gadwal district.

A comprehensive review meeting on the implementation of PMDDKY, promotion of oil palm cultivation, intercropping practices, and development activities in agriculture and allied sectors was held at the IDOC Conference Hall on Tuesday. Officials from Agriculture, Horticulture, Animal Husbandry, Fisheries, Industries, Cooperation, and allied departments attended the meeting.

During the review, the PMO Director examined the progress of welfare schemes and development activities in various departments. He stated that the PM Dhan Dhanya Krishi Yojana should bring visible and meaningful changes in farmers' lives rather than remain limited to statistics and targets.

Raghu directed officials to work in coordination on increasing farmers' income, crop diversification, efficient water management, soil health conservation, sustainable agriculture, and strengthening market linkages. He instructed officials to encourage farmers to shift



towards oil palm cultivation, pulses, horticulture crops, and intercropping systems. He also called for an integrated action plan involving Agriculture, Horticulture, Animal Husbandry, Fisheries, Cooperation, and allied departments to ensure holistic rural development. Officials were instructed to ensure timely supply of quality seeds, saplings, fertilizers, irrigation facilities, institutional credit, and technical support to farmers.

Highlighting the importance of soil health management, Raghu directed officials to conduct regular soil fertility tests and create awareness on integrated nutrient management using Soil Health Cards. He also stressed expanding agricultural credit access through Kisan Credit Cards and cooperative institutions. The PMO

Director suggested identifying successful model farmers and promoting them as role models to motivate others through sharing of best farming practices at the village level. Senior Technical Officer Srikanth, District Horticulture Officer Akbar, District Agriculture Officer Veerappa, DRDO Mushaida Begum, Animal Husbandry Officer Shivananda Swamy, and officials from various departments participated in the meeting.

Later, Raghu visited oil palm nurseries near the Beechupally Oil Factory in Erravelli mandal, inspected a paddy procurement centre at Konduru village, and visited dairy, fish, and vegetable farms in the district to interact with farmers and review their challenges and farming practices.

BRS leaders demand resignation of Union Minister Bandi Sanjay

Bharat Rashtra Samithi leaders in Husnabad demanded the resignation of Union Minister Bandi Sanjay Kumar over the controversy involving his son, Bandi Bhagirath.

Addressing a press conference at the BRS party office in Husnabad on Tuesday, M.A. Anwar Pasha and Municipal Councillor Gadepaka Ravinder alleged that Bandi Sanjay no longer had the moral authority to continue as a Union Minister and demanded his immediate resignation.

The leaders accused the Union Minister of allegedly attempting to



influence the case involving the family of a minor girl and demanded strict legal action against those responsible. They urged the state government to arrest Bandi Bhagirath and ensure justice for the victim's family.

The BRS leaders questioned whether different

standards of justice were being applied to influential political families and ordinary citizens. They also alleged that law and order conditions in the state had deteriorated and claimed that such incidents were increasing due to administrative failures.

During the press conference, the leaders also raised concerns over several government offices in Husnabad functioning under in-charge officials instead of full-time officers, alleging that this was causing inconvenience and delays for the public.

These bonds are redeemable after five years. Daljeet Singh Khatri, P Subhas Reddy, and Achal Gupta also participated in the meeting.

D.S. Ramesh directs comprehensive action plan for storm water drain maintenance

Bengaluru :A review meeting on the maintenance of major storm water drains, progress of development works under CMIDP and SSIP grants, and removal of dilapidated structures in Bengaluru East City Corporation was held under the chairmanship of Commissioner D.S. Ramesh.

During the meeting, the Commissioner instructed officials to prepare ward-wise action plans for maintaining major storm water drains, including around 35 km of concrete drains in Mahadevapura Zone and 45 km in KR Puram Zone. He directed officials to carry out desilting operations four times a year and ensure continuous monitoring by Executive Engineers.

Officials were instructed to fix daily targets for drain cleaning and submit reports detailing the extent of drains cleaned. Heavy rain forecast in coastal dists from May 13; IMD issues warning

Mangaluru/Bengaluru, May 12: Pre-monsoon activities are picking up pace in the coastal regions, with the Meteorological Department forecasting heavy rainfall starting Wednesday, May 13. A depression is likely to form in the Bay of Bengal near the Tamil Nadu coast around May 12, which will trigger the change in weather patterns.

Under the influence of this system, widespread heavy rain accompanied by thunder and lightning is expected across coastal Karnataka, Kerala, and several parts of Tamil Nadu from May 13. Furthermore, the movement of the southwest monsoon winds over the Indian Ocean and the Arabian Sea is expected to intensify from May 15, paving the way for strong pre-monsoon showers along the coast.

Dakshina Kannada, Udupi, and Kasargod districts are highly likely to witness moderate to heavy rainfall over the next four

to five days. The weather department also noted that highly favorable conditions are forming, indicating that the southwest monsoon might arrive slightly earlier than usual this year in the coastal belt.

With gusty winds reaching speeds of 40 to 50 km/h predicted in certain areas, the India Meteorological Department (IMD) has

issued a warning to fishermen and residents living along the coastline to exercise utmost caution. Meanwhile, heavy rains lashed parts of Chikkamagaluru district, particularly around Kalasa and Koppa, as well as Haveri on May 11 evening, bringing much-needed respite from the heat in those regions.

NEET Cancellation Is Central Government's Biggest Scandal: Dr.Sharanaprakash Patil

BENGALURU : Karnataka Minister for Medical Education, Skill Development, Livelihood and Raichur District In-charge, Dr. Sharanaprakash R. Patil, has strongly condemned the Central Government's cancellation of the NEET examination, calling it a grave injustice to lakhs of aspiring medical students



across the country. The National Testing Agency (NTA) cancelled the NEET examination

held on May 3 & announcing reexamination following the leakage of question papers, throwing the futures of hundreds of thousands of students into uncertainty.

Speaking to media here on Tuesday, Dr. Patil said the NEET fiasco is the Central Government's biggest scandal. "For the past four to five years, irregu-

larities and controversies in NEET have been a recurring phenomenon with no end in sight. The BJP government at the Centre is entirely responsible for this mess," he said. The Minister pointed out that despite repeated representations to the Central Government and the concerned ministry, no corrective action was taken, leading to yet another massive failure.

The Central Government must take full responsibility. The guilty must be brought to justice. This is a testament to the incompetence of the BJP-led government at the Centre. Where there is question paper leakage, crores of rupees are changing hands — this is nothing but corruption," Dr. Patil said. Dr. Patil expressed deep concern for the mental well-being of students who had prepared sincerely and diligently for the examination. "Conducting the examination all over again is deeply unfair to honest, hardworking students. It causes immense stress and hardship to students and their families," he said.

The miracle of the guess paper "Guruji"

These days, the atmosphere surrounding the NEET exam is as if a web series full of mystery and thriller has been released. Every day, a new revelation, a new character, and a new story emerge. Some are saying that the question paper was circulating in advance, while others are claiming that the "guess paper" contained the same questions as the actual exam. Not only the questions, but the order of the options, the language, even commas and full stops are being reported as identical. Now, students and parents are wondering whether this was a "guess" or a miracle of some supernatural power?

If all this is true, then the people of the country certainly want to see the "Guruji" who performed this miracle. For years, large coaching institutes in Kota and Sikar have been building structures worth billions of rupees and claiming success. Thousands of teachers have been teaching day and night. Students have been risking their sleep, childhood, and even mental peace to prepare. But what lakhs of rupees in fees and years of hard work could not achieve, a single "guess paper" has accomplished. This is the most scathing satire on the education system.

It's being reported that 90 out of 90 questions in Biology and 45 out of 45 in Chemistry matched. If so, it can't be a mere coincidence. This is an insult to the hard work of millions of students who study diligently. It's a mockery of the struggle of a farmer father who sells his land to pay his child's fees. It's an attack on the hopes of a mother who sacrifices her dreams for her child's future.

An exam like NEET isn't just an exam; it's a door to millions of dreams. Here, a single mark can change the course of life. In such a situation, if there's a suspicion that the question paper has been leaked or is available in advance, trust is the first thing to be shattered. And when trust in the education system begins to wane, not just the exam, but the entire society is in crisis.

The most interesting thing is that the matter reached the police on the day of the exam. Some people were even arrested, but no FIR has been filed yet. This silence raises questions. Are influential people under attack? Has education become such a big business that people are afraid to expose the truth? Or is this the same old story where money and influence are more valuable than hard work? Today, the hardworking student feels betrayed. He spent years immersing himself in books, taking test series, and studying all night. But someone else "saw" the question paper before the exam. What value does all that hard work hold? It's natural for the student to wonder whether the mistake was his or her honesty's? This isn't just cheating on exams, but an attack on the morality of society.

When young people begin to see that the path to success isn't hard work, but rather through jugaad, networking, and leaks, the entire generation begins to lose faith.

The NEET crisis and the credibility of the examination system



The repeated breakdown of trust in the name of transparency, and the inevitable challenge of reform. The uncertainty surrounding NEET-2026 and the fear of its cancellation have increased the anxiety of millions of students and parents. Competitive exams are not just a selection process, but the foundation of a young person's future, hard work, and faith. If the examination system is repeatedly questioned, it has the greatest impact on students who are preparing sincerely. In such a situation, the administration's responsibility is not limited to conducting the exam; ensuring transparency, timely information, and fairness becomes equally important. Maintaining trust in the examination system is the paramount responsibility of any democratic education system. India's competitive examination system is not just an admission process, but the foundation of social justice, opportunity, and talent testing. When irregularities, doubts, or cancellations occur in a national examination like the National Eligibility cum Entrance Test (NEET), it impacts not just one exam but also the trust, time, and mental balance of millions of students. An examination is not merely a technical event; it symbolizes the trust the state ensures that hard



work, ability, and preparation are properly rewarded. Therefore, the credibility of the examination system is the backbone of any democratic education system. The most worrying aspect of cases like NEET is not just the fact that a single incident occurred, but why such incidents keep recurring. When a national exam comes under scrutiny, public confidence is shaken. Students, parents, teachers, coaching institutes, and the administration—all grapple with a question that cannot be answered by mere press releases. The question is: is our examination system truly robust enough to simultaneously deliver on all three fronts: transparency, fairness, and security? If not, the problem isn't just with one exam, but with the entire system. Crises in examination systems don't arise suddenly. They stem from small weaknesses that aren't addressed in a timely manner. If even one link at all these levels—question paper preparation, confidential material protection, logistics transportation, examination

center monitoring, technical verification, identification procedures, and answer sheet handling—is weak, the entire system can be put under scrutiny. In modern times, examinations are no longer merely a pen-and-paper affair; they have become a system interconnected with a highly complex network of information, security, and control. Therefore, negligence at any level directly impacts the future of students. It must also be understood that trust in the examination system is built not only on transparency, but also on consistency. If a student lacks assurance that the value of their hard work is stable and secure, their preparation becomes uncertain. Even before an honest student reaches the examination center, many questions arise—will the question paper be secure? Will no one gain unfair advantage? Will the entire process be fair? When such questions become commonplace, it should be understood that the crisis is not merely administrative, but also moral. The fundamental objective of education is equality

of opportunity, and if this is weakened, the system deviates from its purpose. This concern becomes even more acute in an examination like the National Eligibility cum Entrance Test, as it is not merely a professional entrance exam but the center of the socio-economic dreams of millions of families. Students from rural areas, lower-middle class candidates, and youth from small towns dream of advancing on the strength of their merit despite limited resources. But when the integrity of the examination is questioned, these same students suffer the most. Those with influence, resources, or networks often circumvent the system's weaknesses; but those with only hard work are the most affected. Therefore, examination transparency is not just a matter of administrative reform, but also a question of social justice. The crisis in the examination system also has a profound impact on students' mental health. Preparing for competitive exams is already extremely stressful. Students

endure long periods of strict discipline, limited social life, family expectations, and uncertainty about their future. When the future of the exam itself becomes uncertain, the mental pressure increases exponentially. Some students become frustrated, some repeatedly change their strategies, and some even fall into deep depression. Therefore, the examination administration must understand that it is not simply announcing dates or establishing centers, but is also handling the future of young people. The digital age has brought both convenience and new challenges to examination administration. Systems like online registration, digital identity, CCTV surveillance, encrypted data, and centralized control have modernized the examination system. However, this has also increased technological risks. Data leaks, software tampering, internal collusion, cyber intrusions, and the spread of misinformation have all emerged as new challenges. Therefore, simply adopting technology is not enough; its security, audit, and accountability must also be equally robust. If the technology itself is weak, claims of transparency will prove hollow. Improving the examination system requires establishing accountability first. When an examination becomes controversial, attention often focuses solely on the incident. But the real question is whose negligence allowed the incident to occur. A review of the role of everyone—the exam-organizing body, the relevant ministry, security agencies, central-level officials, and local administration—is essential. Accountability means not just removing individual officials, but re-evaluating the entire system. If the culprits are not caught, the shortcomings in the process are not made public, and corrective steps are not taken.

Built between 1632 and 1653, this marble mausoleum is now listed as one of the Seven Wonders of the World. However, controversies have periodically arisen regarding its origin and construction. Some claim it to be a Hindu temple or a palace, and others question its historicity based on the so-called "Tejo Mahalaya" theory. In recent years, the film "The Taj Story" has reignited this debate. Therefore, it is essential to understand this topic based on historical facts, archaeological evidence, and authenticated documents, rather than on emotions or rumors. The Taj Mahal is located on the southern bank of the Yamuna River in Agra. Contemporary historian Abdul Hameed Lahori, in his famous work "Padshahnama," detailed that after Mumtaz Mahal's death, Shah Jahan commissioned the construction of this mausoleum in her memory. According to historians, approximately 20,000 artisans and craftsmen worked for 22 years to complete the building. Persian, Turkish, Indian, and Central Asian artisans played a role in the construction. The use of white marble from Makrana (Rajasthan) and precious stones from various regions makes its grandeur unparalleled. The Taj Mahal's architecture is considered a fine example of the Mughal style, showcasing a beautiful blend of Islamic arches, Persian

domes, and Indian architectural elements. Its Charbagh-style garden, its surrounding minarets, its intricate marble carvings, and its artistic inscribing of Quranic verses make it a world-class heritage site. UNESCO declared it a World Heritage Site in 1983, calling it "the finest example of Mughal architecture." The Archaeological Survey of India (ASI) also clearly considers it a Mughal-era mausoleum. The modern controversy surrounding the Taj Mahal is believed to have begun in 1989 with Purushottam Nagesh Oak's book, "Taj Mahal: The True Story." Oak claimed that the Taj Mahal was actually a Shiva temple called "Tejo Mahalaya," which Shah Jahan captured and converted into a mausoleum. He cited the Sanskrit etymology of the word "Taj," certain architectural features, and enclosed chambers in his arguments. However, historians and archaeologists dismissed these claims as baseless. Most importantly, no contemporary Hindu text, inscription, official document, or British-era survey mentions a temple named "Tejo Mahalaya." If such a massive structure had existed as a temple in the past, references to it would surely be found in some historical record. Courts have also dismissed these claims from time to time. In petitions filed in 2000, 2005, and 2017, the courts stated that such claims were inconsistent with historical facts. The Supreme Court also rejected these claims due to the lack of concrete evidence. The so-called "22 Closed Rooms" of the Taj Mahal have long been a subject of curiosity and controversy. These rooms, located in the basement area of the Taj Mahal, have long been kept closed for security reasons. Some groups claim that Hindu idols, Shivalingas, or other religious relics are hidden in these rooms. However, the Archaeological Survey of India has clarified that these rooms are auxiliary chambers built for the structural strength of the building. They were kept closed to the public due to concerns about damage to the marble from high humidity, carbon dioxide, and tourist activity.

Several experts, including archaeologist K.K. Mohammed, have inspected these rooms. They say there's nothing unusual inside, except for the typical walls, arches, and damaged plaster. Even the photographs released in 2022 showed no religious symbols or idols in these rooms. This makes it clear that most of the rumors about these rooms are based on imagination and sensationalism. Recently, the film "The Taj Story" revived this controversy. The film attempts to portray the Taj Mahal as a Shiva temple and presents the mystery of the 22 locked rooms in a mysterious manner. However, historians believe this portrayal is driven more by imagination and political discourse than by historical facts. Art and cinema enjoy freedom of expression, but when presenting history, factual responsibility becomes equally important. The Taj Mahal is not just a building, but a symbol of India's shared cultural heritage. Its architecture reflects a remarkable blend of Indian and Persian artistic traditions. The use of Indian symbols such as the lotus indicates that Mughal architecture was influenced by local art and culture. Limiting it to a single religion or community would be a narrowing of the breadth of history. Today, the Taj Mahal attracts millions of tourists every year and contributes significantly to India's tourism economy. Challenges such as pollution, acid rain, the Yamuna's declining water level, and environmental damage are already raising serious questions about its preservation. At this time, the need for conservation and promotion of this World Heritage Site is greater than baseless controversies. Ultimately, the Taj Mahal is an immortal masterpiece of history, art, and human sensibility. History should be evaluated based on evidence and research, not rumors and political pressures. Rising above myths and controversies, we must view this monument as a symbol of India's cultural unity and shared heritage. This approach is the hallmark of a society that is responsible for its history and aware of its future.

Greedy owners extract milk and leave them to shovel in the garbage



A horrifying scene is becoming commonplace in almost every city, big or small, in India—cows searching for food in garbage heaps, calves swallowing plastic, animals wandering the streets, and a population struggling with filth. On one hand, society worships the cow as "mother," while on the other, those same cows are dying on the streets due to hunger, disease, and negligence. This is not just a failure of the sanitation system, but a living testament to our social insensitivity and duplicity. Today, the morning scene in most cities across the country is nearly identical. After milking, cattle owners let their cows loose. These animals then wander the streets, markets, and garbage dumps, searching for food. Rotten vegetables, plastic bags, medical waste, and toxic garbage enter their stomachs, gradually leading to their deaths. Many times, kilograms of plastic are removed from cows' stomachs during operations, yet society's sensibilities remain unabated. The biggest question is with those cattle breeders who consider animals merely "milking machines." Cows are worshipped as long as they generate income, but as soon as they are aban-

doned on the streets, their responsibility is considered over. This is the ugliest face of greed and inhumanity. What culture or religion is it to abandon the animal that sustains the household, pays the children's fees, and provides the family income, to forage in the garbage? Ironically, the cow is the most rousing emotion in the country. From political to religious platforms, "Mother Cow" is hailed. People post videos on social media of themselves feeding cows, claiming to be great animal lovers. But if there was true love and respect for the cow, no cow would be seen hungry, injured, or eating plastic on city streets. Today, the situation has deteriorated so much that stray animals in cities are not only losing their own lives but also posing a threat to the lives of ordinary people. Thousands of people are injured in road accidents every year. Animals suddenly appearing in the dark of night often cause fatal accidents. But neither the administration nor society seems serious. The municipal corporation and local administration periodically talk about launching campaigns, but the problem is never addressed at its root. Some animals are captured and sent to cow shelters, action is shown for a few days, and then everything returns to normal. The real problem is that animal owners are not held accountable. Why is there no strict action taken against someone who abandons their animal on the street? This crisis isn't limited to animals. The waste and

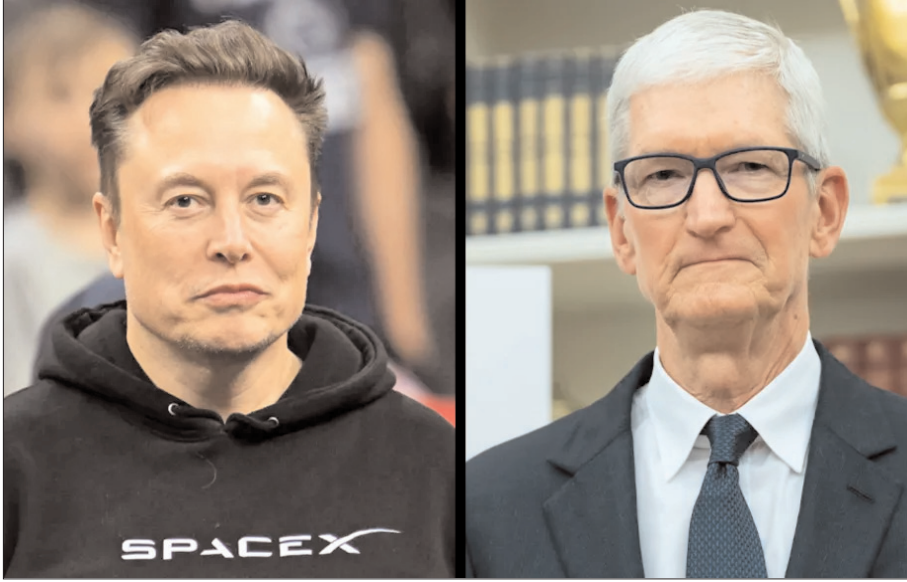
filth spread across cities has become a major threat to public health. Open garbage heaps are breeding grounds for mosquitoes, flies, and infections. During the rainy season, this garbage clogs drains, causing waterlogging and a disease crisis. Yet, we still try to shirk our responsibilities by considering cleanliness solely a government responsibility. India makes grand claims about "smart cities" and modern development. Shining roads, sprawling malls, and tall buildings have become symbols of progress. But true development is where both humans and animals can live with dignity and security. In a city where cows search for food in garbage and people pass by, taking the scene for granted, development is merely a sham. Our biggest problem is that we've turned sensitivity into a performance. It's easy to show compassion in front of the camera, but it's harder to demand systemic change. People donate to temples, go on pilgrimages, and debate cow issues, yet remain silent about the filth and plight of animals around them. Politics has also been solely focused on this issue for emotional gain. Elections are marked by speeches about cows and religion, but there's no concrete policy in sight to address the dying cows on the streets. Crores of rupees are claimed to be spent on cow shelters, yet the number of stray animals in cities continues to grow. Where is this money going? Who will hold accountable? The saddest thing is that

generations of children are becoming accustomed to this inhumane sight. The daily sight of injured animals on the streets, cows searching for food in garbage, and the filth of the environment slowly kills their senses. A society that cannot even be kind to its animals cannot remain humane towards humans for long. The solution is clear, all that is needed is willpower. First, the responsibility of livestock owners must be established. Registration of every animal should be mandatory, and heavy fines should be imposed for abandoning animals on the street. Municipal bodies should implement modern waste management systems. Strict action is needed against the open use of plastic and improper waste disposal. Transparent audits of the actual condition of cow shelters should be conducted. Society must also change its behavior. Throwing garbage on the streets, leaving plastic in the open, and blaming the government for every problem is an easy way out. Cities change through civic discipline and collective responsibility. Today, the garbage strewn across the streets and cows searching for food in it isn't just a spectacle of mismanagement. They reflect the moral decline of our society. There's a lot of noise about cows, but the silence about their real suffering is even greater. Until this double standard is eradicated, neither will cities be truly clean, nor will animals be safe, nor will our society remain worthy of being called sensitive.

Musk and Tim Cook among CEOs expected to accompany Trump on China trip

Washington: US President Donald Trump is expected to bring a host of top business and technology industry executives on his trip to China this week. Among those set to join the president on his official trip to Beijing are Tim Cook of Apple, Elon Musk of Tesla and SpaceX, Larry Fink of BlackRock, as well as other executives from Meta, Visa, JP Morgan, Boeing, Cargill and more.

In total, 17 US executives will join Trump on the trip, a White House official with knowledge of the plans told the BBC. The trip is seen as important for the US, as Trump will meet with President Xi Jinping at a time of growing economic and technological animosity between the two countries. In addition to Musk, Cook and Fink, the full list of the executives set to join Trump as part of the official US delegation to China is as follows: Dina Powell McCormick, president and vice chair of Meta; Kelly Ortberg, president and chief executive of Boeing; Ryan McInerney, chief executive of Visa; Stephen Schwarzman, chief executive of Blackstone



Brian Sikes, chief executive and chairman of Cargill; Jane Fraser, chief executive of Citigroup; Jim Anderson, chief executive of Coherent; Henry Lawrence Culp, chief executive of GE Aerospace; David Solomon, chief executive of Goldman Sachs; Jacob Thaysen, chief executive of Illumina; Michael Miebach, president of Mastercard. Absent from the list is Nvidia boss Jensen Huang, whose company is central to the rivalry between the US and China over computer chips and artificial intelligence (AI). The BBC has contacted Nvidia for comment. Last week, Huang told business news channel CNBC that it would be a "privilege" to represent the US in China if he was invited on the trip. It is also notable that Sanjay Mehrotra, the CEO of Micron Technology, will be part of Trump's delegation. His presence is interesting as Beijing restricted the use of some Micron chips in critical infrastructure in 2023 on national security grounds - a move the firm has said negatively impacted its business in China.

Semiconductors remain central to the US-China economic relationship, despite ongoing tensions over technology and export controls. Chuck Robbins, chief executive and chairman of Cisco, had been invited to be a part of the trip "but is unable to due to earnings," according to a company spokeswoman. Together, the executives represent a swath of US business interests, from social media and consumer hardware, to computer chips and commercial manufacturing. A spokeswoman for Illumina, a biotechnology company based in California,

said Thaysen "is honored to be part of the delegation" and that the company hopes the trip will be "an opportunity to strengthen relationships and shape the future of precision medicine." Representatives of the other companies did not immediately respond to requests for comment. Trump's visit to China will be the first by a US president in nearly a decade and marks a key test of a fragile trade truce between the two countries, following a tit-for-tat trade war which saw them roll out tariffs which at times topped 100%. The tariffs were paused in October 2025 after Trump's last meeting with Xi, which took place in South Korea. Looming large over the upcoming meeting will be the US and Israel's war in Iran, which has already forced a delay to Trump and Xi's meeting. Trump is expected to push China, which relies on Iran for cheap oil, to help facilitate an agreement between Tehran and Washington to end the war. China also wants the conflict to end. It has limited the supply of oil to the country, hitting the buying power of other countries around the world that import Chinese goods.

eBay rejects \$55.5bn offer from GameStop

Washington: Online marketplace eBay has rejected a \$55.5bn (£40.9bn) takeover offer from video game retailer GameStop, calling it "unsolicited" and "neither credible nor attractive". Analysts had expected the offer to be rejected as GameStop is much smaller than eBay, which said there was "uncertainty" over how the deal would be financed. Although eBay has suffered in recent years, partly due to more competition from online sellers like Amazon, Etsy and Temu, it insisted its turnaround plan was working. GameStop rose to prominence as a "meme stock", which sees retail investors buy up shares in unloved companies that professional investors have bet against, causing

the share price to rise and fall sharply. In a letter to GameStop chief executive Ryan Cohen rejecting the surprise offer, eBay's Board of Directors said the online auction giant was a "strong, resilient business". It cited as a reason for rejection "the impact of your proposal on eBay's long-term growth and profitability", adding it had also considered the offer's "operational risks, and leadership structure of a combined entity". It also cited "GameStop's governance" in the list of factors it had determined before rejecting last week's bid. But it wouldn't be the end of the line for GameStop if it chooses to take its proposal directly to eBay shareholders - which Cohen said last week he would do if faced with a "no" from the board.

eBay's net profit in 2025 rose to \$418.4m which, despite a fall in sales, was up from the previous year's \$131.3m. GameStop is worth about a quarter of online auction giant eBay. It has around 1,600 stores globally, mostly in the US. When it made its offer, GameStop said that it had a commitment letter from TD Securities to provide around \$20bn in debt to help finance the takeover. Cohen said eBay could be much more successful under his leadership and even rival Amazon. But analyst Sucharita Kodali, a retail analyst at research firm Forrester, told the BBC at the time that the proposal did not sound like a "terribly good offer" as it would saddle eBay with GameStop's debt. The BBC has approached GameStop for comment.

ASCI Releases Draft Guidelines for Responsible Labelling of AI-Generated Content in Advertising

Mumbai, May 12, 2026: The Advertising Standards Council of India (ASCI) today released draft guidelines for the responsible labelling of synthetically generated content in advertising. The guidelines are aligned with the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Amendment Rules (2026), amended on February 10, to ensure transparency while avoiding consumer label fatigue around synthetically-generated information. As brands increasingly turn to Artificial Intelligence (AI) to power their campaigns, the draft guidelines advocate a risk-based approach, focusing on consumer outcomes rather than regulating the technology itself. AI use in advertising is considered misleading or harmful only when it creates unfulfillable expectations, exploits vulnerable populations, depicts unsafe situations, or replicates a real person's likeness without consent.

on the risk it poses to consumers. The guidelines classify AI-generated advertising content into three risk categories:

- 1. High Risk (Prohibited Content):** High-risk advertisements are those that are illegal, infringe on rights, make misleading claims, or violate the ASCI Code. These will violate the code even if an AI label is used. Examples include:
 - Fabricating endorsements or testimonials
 - Exaggerating product results or features through claims or visual representations to create a misleading impression
 - Creating fake locations that appear realistic to the consumer
 - Using deepfakes, copy-righted work or a person's likeness without consent
 - Using AI to generate fictional authority figures with identifiable cues, such as an AI-generated fake doctor promoting a supplement, implying medical endorsement/expertise, etc

advertisements are those where AI use materially influences consumer decisions, and the lack of disclosure would mislead consumers. Labelling is mandatory in these cases to help consumers understand the nature of the representation. Examples include:

- Using virtual or synthetically generated influencers and ambassadors
- Replicating a real person's likeness or voice even with their consent for personalised messaging
- Using synthetically generated visuals for product performance unless the visuals replicate how the product actually performs
- Creating realistic events, settings or situations entirely with AI
- Demonstrating a product that does not currently exist
- Creating AI-generated exaggerated sound effects that are highly relevant to the product's core features
- Using AI for paid or sponsored product suggestions, which must specifically be labelled as 'sponsored by'

- 3. Low Risk (No Labelling Required):** Low-risk advertisements feature minor modifications or use AI in ways that have no material impact on a consumer's ability to make an informed choice. No label is required for:
 - Minor Enhancements: Routine editing, colour correction, noise reduction, standard blemish removal, and minor lighting tweaks that do not alter the substance or core claims of the ad
 - Background and Ambient Elements: Purely decorative AI-generated backgrounds, abstract skylines, ambient music, jingles, or background sound effects (like crowd cheers) that are unrelated to the product's actual capabilities or promise
 - Fantastical Elements: Obvious, unrealistic effects that audiences recognise as not depicting reality, such as dragons or fairies
 - Administrative and Text Uses: Generating or enhancing advertising copy, creating audio descriptions for the visually impaired.

Asian shares trade mixed after Wall Street rally despite Iran war worries

Tokyo: Asian shares traded mixed early Tuesday, May 12, as optimism encouraged by a record rally on Wall Street clashed with anxiety about surging oil prices and a possible AI bubble. Japan's benchmark Nikkei 225 added 0.7 per cent to 62,881.03. South Korea's Kospi dropped 1.2 per cent to 7,726.30, in what analysts are categorising as fallout from overreliance on fraying AI hopes. "Global equities remain dangerously dependent on a tiny cluster of AI leaders, creating a rally structure that looks powerful on the surface but increasingly fragile underneath," said Stephen Innes, analyst with SPI Asset Management. He believes South Korea may be among the first major economies that will undergo what he called "the political redistribution phase of the AI boom." Australia's S&P/ASX 200 dipped 0.3 per cent to



8,676.60. Hong Kong's Hang Seng gained 0.2 per cent to 26,467.50, while the Shanghai Composite lost 0.4 per cent to 4,208.00. Oil prices continued to rise, as the war with Iran threatens to drag on. Benchmark US crude rose 91 cents to USD 98.98 a barrel. Brent crude, the international standard, climbed 90 cents to USD 105.11 a barrel. Adding to worries were comments from President Donald Trump that the US-Iran ceasefire was on "life support" after rejecting Iran's

latest proposal to end their war. That raises the stakes for Trump's trip this week to China. China is the biggest buyer of Iran's sanctioned crude oil. The war has already sent the price for a barrel of Brent racing up from prewar levels of roughly USD 70 and delivered inflation through the global economy. The war has shut the Strait of Hormuz and kept oil tankers stuck in the Persian Gulf instead of delivering crude to customers worldwide. Still, some compa-

nies are reporting bigger profit than analysts expected, which means the US economy is holding up even though households are feeling discouraged by expensive gasoline and tariffs. On Wall Street, the S&P 500 rose 0.2 per cent from its prior all-time high set on Friday. The Dow Jones Industrial Average gained 95 points, or 0.2 per cent, and the Nasdaq composite added 0.1 per cent to reach its own all-time high. All told, the S&P 500 rose 13.91 points to 7,412.84. The Dow Jones Industrial Average added 95.31 to 49,704.47, and the Nasdaq composite gained 27.05 to 26,274.13. In the bond market, Treasury yields ticked higher. The 10-year yield rose to 4.40 per cent from 4.38 per cent late Friday. In currency trading, the US dollar rose to 157.57 Japanese yen from 157.12 yen. The euro cost USD 1.1761, down from USD 1.1787. Japan's benchmark Nikkei 225 added 0.7 per cent to 62,881.03.

Trump says Iran ceasefire is on 'massive life support'

Trump has said the month-long ceasefire between the US and Iran is on "massive life support". He told reporters in the Oval Office on Monday that while the ceasefire remained in place, it was "unbelievably weak". Following Trump's comments, Iranian parliamentary speaker Mohammad Ghalibaf wrote on X that Iran's armed forces were "ready to respond and to teach a lesson for any aggression." Iran laid out its demands to end the war and reopen the Strait of Hormuz in a counter-offer sent to the US on Sunday. Trump rejected the proposal, calling it "totally unacceptable" and a "piece of garbage".

After Trump's comments, Esmail Baghaei, a foreign ministry spokesperson for Iran, said Tehran's proposals were "responsible" and "generous". After his comments saying Iran's armed forces ready to respond, Ghalibaf said in a separate post on X that there was "no alternative but to accept the rights of the Iranian people as laid out in the 14-point proposal". "The longer they drag their feet, the more American taxpayers will pay for it," he said. Tehran's offer includes an immediate end to the war on all fronts - a reference to the continued Israeli attacks against Iran-supported Hezbollah in Lebanon - a halt to the US naval blockade of Iranian ports and guarantees of no further attacks on Iran, according to Iran's semi-official Tasnim news agency. It also reportedly includes a demand for compensation for

war damage and an emphasis on Iranian sovereignty over the Strait of Hormuz. Trump criticised the proposal, writing on Truth Social on Sunday: "I have just read the response from Iran's so-called 'Representatives.' I don't like it - TOTALLY UNACCEPTABLE." In response to Trump's comments, Baghaei said Iran would act "in any way necessary to secure our interests". Speaking in the Oval Office later on Monday, Trump addressed the ceasefire between the two countries which has largely been observed since April despite occasional exchanges of fire. He told reporters: "I would say the ceasefire is on massive life support... when the doctor walks in and says, 'Sir, your loved one has approximately a 1 percent chance of living.'" The US president said Iran's leaders were "very dishonourable people", adding: "Look, I've had to deal with

them four or five times - they change their mind." "That piece of garbage they sent us - I didn't even finish reading it," he said. Trump also accused Iran of going back on an agreement to allow the US to remove its supply of enriched uranium. He insisted that Iran would "never have a nuclear weapon". Iran's Tasnim news agency quoted a source close to the negotiating team as saying: "There is no such thing in Iran's proposal as accepting taking out enriched nuclear material." Earlier this week, Trump repeated that the war in Iran will be "over quickly". But Israeli Prime Minister Benjamin Netanyahu said that Iran's stockpile of enriched uranium must be "taken out" before the war can be considered over. "There's still enrichment sites that have to be dismantled," Netanyahu said in an interview on CBS's 60 Minutes show.

No sign of larger hantavirus outbreak, says UN health agency

Washington: There is "no sign" of a larger hantavirus outbreak after the evacuation of the last passengers from a disease-stricken cruise ship, the head of the UN health agency has said. But the World Health Organization's chief Tedros Adhanom Ghebreyesus warned "the situation could change" and there could still be more confirmed virus cases. The MV Hondius left Spain's Tenerife island on Monday and is sailing to the Dutch port of Rotterdam. Two flights with the final group of 28 passengers landed in nearby Eindhoven on Tuesday. Three people have

died after travelling on the ship. An American and a French national who previously returned home have tested positive. Overall, seven cases have been confirmed. Twelve employees at a Dutch hospital are now in quarantine over possible exposure to the virus after treating one of the evacuated passengers. The hospital in the city of Nijmegen said on Monday this was a precautionary measure, as the workers did not follow strict protocols while handling the patient's blood and urine samples. At Tuesday's press conference in Madrid, Ghebreyesus said: "At the moment."

UGANDA'S PRESIDENT SWORN IN FOR RECORD SEVENTH TERM

Uganda's President Yoweri Museveni, 81, has been sworn in for a record seventh consecutive term following his landslide victory in disputed elections in January, extending his tenure as one of Africa's longest-serving rulers. Heavy security, including armoured tanks, were deployed in the capital, Kampala, ahead of the inauguration in what police said were measures intended to maintain public order. Museveni told the crowd that his new term should be regarded as a time for "no more sleep for all Ugandans". He added that people should focus on creating more wealth and jobs - and build on the progress made over last 40 years through the achievement of peace and the development of infrastructure. Museveni was declared the winner of the election with more than 70% of the vote, with his term expected to end in 2031. His main rival, pop star turned politician Bobi Wine, rejected the result, saying the poll was marred by "ballot-stuffing". Election officials denied the allegation. The 44-year-old opposition leader, whose real name is Robert

Kyagulanyi Ssentamu, fled the country after the election, saying he feared that "the regime wanted to eliminate me". Museveni first came to power as a rebel leader in 1986 but since then has won seven elections. He is among the few African leaders in power for more than 40 years. Others include Congo-Brazzaville's Denis Sassou Nguesso, Equatorial Guinea's Teodoro Obiang and Cameroon's Paul Biya. The government declared the day a public holiday and the president's supporters thronged to the Kololo Independence Grounds in Kampala for the swearing-in ceremony. In his address, Museveni said that his government would use revenue from planned oil production to grow the economy and alleviate poverty. "We must protect what has been achieved, correct what still needs improvement and move forward together as one country," he added. African leaders who attended the ceremony included Tanzania's President Samia Suluhu Hassan, the Democratic Republic of Congo's Félix Tshisekedi, South Sudan's Salva Kiir and Somalia's Hassan Sheikh Mohamud.

MEXICO CANCELS PLANS TO END SCHOOL YEAR EARLY FOR WORLD CUP

Mexico: The Mexican government has cancelled plans to end the school year more than a month early to ease traffic during the Fifa World Cup and an anticipated heatwave. Mexico is due to co-host the football tournament with the United States and Canada from 11 June to 19 July. The reversal comes after an outcry by parents who warned that it would disrupt their children's studies. Many families also said that they had been thrown into a tailspin, trying to arrange for weeks of childcare to cover the early finish. After the U-turn, classes will now finish on 15 July - and not on the proposed earlier date of 5 June. The row was brought about by an announcement by the education minister on 7 May, when Mario Delgado said that "an extraordinary heatwave"

was expected to affect the country. He said that the government was "not willing to risk the health and safety of our students" and that the decision was "in the best interests of the country". The minister also said that the government would continue to work on improving the school system and that the cancellation of the early end to the school year was "a necessary step".

US INFLATION JUMPS TO 3.8% AS ENERGY COSTS SURGE FROM IRAN WAR

Washington: US prices rose in April at their fastest rate since May 2023 as the impact of the war in Iran was increasingly felt by consumers. A jump in the cost of gasoline and groceries pushed the consumer price index (CPI), showing the rate prices rose by in the past 12 months, to 3.8%. It is the highest level since inflation hit 4% three years ago. The Bureau of Labor Statistics (BLS) said almost half of the rise was driven by surging energy costs, while housing and food costs also contributed. The US-Israel war in Iran, and the resulting effective closure of the key Strait of Hormuz shipping lane, has led to a jump in oil prices and this has caused a surge in the price of gas in the US. The national average price for a gallon of unleaded



is at its highest level since July 2022, at \$4.50 (£3.33), according to data from the AAA motoring group. The rise in April's inflation figure, from 3.3% in March, makes it increasingly unlikely the Federal Reserve will cut interest rates this year. Isaac Stell, investment manager at the Wealth Club, said the inflation increase even left possible interest rate hikes "firmly on the table". It comes

days before Trump appointee Kevin Warsh is set to take over from Jerome Powell as chair of the US central bank. Stell said the incoming chair would enter the role with "little room for manoeuvre" and may be forced to take a more conservative approach. Trump had clashed with Powell over his reluctance to cut the central bank's interest rate, which the president hoped would spur on the US

economy, and has made it clear he expects Warsh to push for cuts. It also poses a challenge for US President Donald Trump and the Republicans ahead of November's midterm elections, after Trump's 2024 re-election campaign focused largely on his plans to cut inflation. Air fares and clothing also increased in the year to April, while the price of new cars fell slightly. April's inflation figure also marked the first time in three years that Americans' pay packets are no longer growing faster than prices are rising. While prices rose by 3.8% for the year to April, average paychecks grew by just 3.6%. US stock markets opened lower on the news with the S&P 500 falling 0.6% and the Dow Jones Industrial Average down 0.7%.

Canvas hack: Company pays criminals to delete students' stolen data

Washington: The company behind the popular Canvas software, which was hacked last week causing major disruption at thousands of universities and colleges, has paid the hackers not to publish stolen data online. The cyber-attack affected an estimated 9,000 institutions in the US, Canada, Australia and the UK, with exams disrupted after the Canvas service went down. The hackers threatened to publish 3.5 terabytes of student and university data they had stolen in the breach. Instructure, the maker of Canvas, has now confirmed it has "reached an agreement" with the hackers, who have said they deleted the data and



promised not to extort any students or institutions. Paying cyber criminals goes against the advice of law enforcement agencies around the world, as it can fuel further attacks and offers no guarantee the data has been deleted. In previous cases, criminals have accepted ransom payments but lied

about destroying stolen data, instead keeping it for resale. For example, when the notorious LockBit ransomware group was hacked by the National Crime Agency, police found stolen data had not been deleted even after payments had been made. Instructure said in a state-

ment on its website that protecting students' and education staff data was its primary motivation. "While there is never complete certainty when dealing with cyber criminals, we believe it was important to take every step within our control to give customers additional peace of mind, to the extent possible," the company said. Instructure did not set out the terms of the agreement but said that it meant that the data was returned to the company it received "digital confirmation of data destruction" it had been informed that no Instructure customers would be extorted as a result of the incident the agreement covers all affected customers.

EU needs to delay social media access for children - von der Leyen

Russels: European Commission President Ursula von der Leyen has proposed a "social media delay" for children in Europe and has said new legislation could be put forward in months. She told an EU summit in Copenhagen that an expert panel was due to come up with steps on how to protect minors online by July. Several countries in Europe and around the world have already introduced social media bans for minors, and von der Leyen did not rule that out. "The discussion about a minimum age for social media can no longer be ignored," she said. Denmark, where Tuesday's summit was being held, and nine other EU member states including France have proposed various minimum age limits for access to platforms. Australia became the first country in the world to introduce a ban for under-16s last December and European countries are planning to follow suit. In the UK, plans are under way for strict social media regulations, also for under-16s. This entails potential bans, age verification and content restrictions. A

major national consultation is due to close on 26 May 2026. France is pushing to ban social media access for children under 15, aiming for implementation by September this year. In Spain, there are plans to ban social media access for under-16s, to combat addiction, pornography, and harmful content. The Portuguese government passed a bill earlier this year requiring parental consent for users aged 13 to 16 and strengthening restrictions on those under 13. The plan includes mandatory age-verification technology. Plans are being formed by the German government focusing on a potential ban for children under 14, with restrictions for teenagers up to 16. Key measures include enforcing strict age verification, creating "safe" youth versions, and removing addictive algorithms. Norway plans to introduce a strict social media ban for under-16s by the end of 2026. The legislation will require technology companies to implement age verification systems. New Zealand, Malaysia and India have all proposed social media bans for children as well.

TEXAS ACCUSES NETFLIX OF SPYING ON USERS, INCLUDING CHILDREN

Washington: Netflix has been sued in Texas over claims it collects data belonging to children and adults in the US state without their consent, and uses "addictive" design to keep them hooked. Texas Attorney General Ken Paxton accused the streaming giant of "spying" on citizens saying it "records and monetises billions" of pieces of information about how users behave on the platform, despite suggesting otherwise. "Every interaction on the platform became a data point revealing information about the user," his office said. Netflix has rejected the claims and says it will challenge them in court, according to a statement



shared with Reuters. "Respectfully to the great state of Texas and Attorney General Paxton, this lawsuit lacks merit and is based on inaccurate and distorted information," a Netflix spokesperson told the news agency. "Netflix takes our members' privacy seriously and complies with privacy and data protection laws everywhere we operate."

The BBC has approached Netflix for comment. "When you watch Netflix, Netflix watches you," says the complaint filed on Monday by Texas' top prosecutor. According to the filing, the streaming company championed itself as unlike other big tech firms in how it processed data and advertised to users. It quotes the company's former boss Reed

Hastings as having said in 2019 and 2020 that it did not and would not collect or monetise user data, such as to sell ads. But the filing says Netflix used a combination of "addictive" design features, like auto-playing content, and extensive "logging" of user activity to keep people on the site. Among billions of technical events it recorded were what users would click and linger on, and for how long, the filing adds. In 2022, it says, the company also began "leveraging the mountains of data it quietly extracted from the children and families it kept fixated on their screen" - sharing this with commercial data brokers to help raise billions of dollars in revenue.

Snack giant switches to black and white packaging as Iran war hits ink supplies

Moscow: Japanese snack giant Calbee says it will temporarily switch to black and white packaging for some of its best-known products as supplies of an ingredient used in ink have been disrupted by the Iran war. The firm says new-style packets for 14 of its products, including crisps and prawn crackers, will start to appear in shops in Japan from 25

May. It marks the latest example of how everyday goods are being impacted after Iran effectively closed the key Strait of Hormuz waterway in retaliation for US and Israeli strikes on the country. In recent weeks, companies around the world have warned that supply disruptions to things like fuel, plastics and helium are pushing up costs for their businesses.

Where problems started with 2026 rules & calendar congestion

Washington: Rule changes have continued to be a big focus in Formula 1, with the previous race in Miami the first since a series of tweaks designed to address concerns about the 2026 engine regulations. Since then, F1 bosses have agreed to further changes to engine design for the 2027 season. With plenty to talk about, BBC F1 correspondent Andrew Benson answers your latest questions. How did the people who run F1 make such a mistake when implementing the new regulations? Having watched F1 for decades, this is the worst regulation change I can remember. - Michael Before answering this question directly, it's important to point out that not everyone views the new rules in such a negative way. There is an acceptance in F1 that qualifying has been significantly negatively affected, in terms of the driving experience of being on the limit. Efforts have already



been made to address that up to a point this year, and larger steps are in the making for next year. At the same time, most senior figures in F1 - including some of the drivers - agree that there has been a positive effect on the racing, even if some of the increased number of overtakes that have been seen can be argued to be artificial and down to offsets between states of charge. TV figures over the first three races were up by more than 20% - all three of Australia, China and Japan had significant increases. Miami's are not available yet. Now, as for the genesis of the new regulations, the target when talks started five or so years ago was to attract more manufacturers. At the time, the direction of road-car technology was firmly electric, so it was decided in concert with the manufacturers to increase the amount of electrification. A nominal 50-50 split between internal combustion and electric was agreed. Fully sustainable, carbon-neutral fuels were added for further environmental credibility. The MGU-H, a part of the hybrid system that recovered energy from the turbo, was removed.

'WON'T BE ABLE TO RETURN TO PAKISTAN':

Bangladesh Star's Brutal Taunt At Mohammad Rizwan Caught On Stump Mic

Dhaka: Bangladesh wicket-keeper Litton Das was caught on a stump-mic taking a brutal dig at Pakistan batter Mohammad Rizwan during the first Test match in Mirpur, Dhaka, on Monday. The incident took place during the 38th over of Pakistan's innings when Litton mocked Rizwan by claiming he has a "bad reputation" back home. "They are now trying to save the Test. They have no chance of winning. Rizwan's reputation is really bad back in Pakistan. If he gets out trying to hit a big shot, he won't even be able to set foot back in the country - his reputation is that bad," Litton was heard



saying. The fightback was short-lived as Rizwan was dismissed for 15. While Pakistan looked set to salvage a draw, a five-wicket haul from Nahid Rana triggered a dramatic collapse, and Bangladesh clinched the match by 104 runs. He

(Mohammad Rizwan) already has a poor reputation in his own country. If he tries to play aggressively and gets out, he may find it difficult to return home. Meanwhile, Pakistan's under-fire Test captain Shan Masood advised against

pressing the panic button after the loss to Bangladesh. Masood, who has been Test captain since December 2023 and seen his team suffer 11 defeats in 15 games, said he would not offer excuses but Pakistan were playing Tests after too many long gaps. "Definitely there should be accountability and everyone has to take responsibility and I don't believe in blaming anyone but it is disappointing to lose the Test in this manner as at one stage I felt we were in a position to get a draw," Masood told a media conference in Dhaka. "We played South Africa last year after nearly 12 months after hosting the West Indies at home.

first project with newcomers. Since the film is based on a real incident, I made it in a very realistic manner.

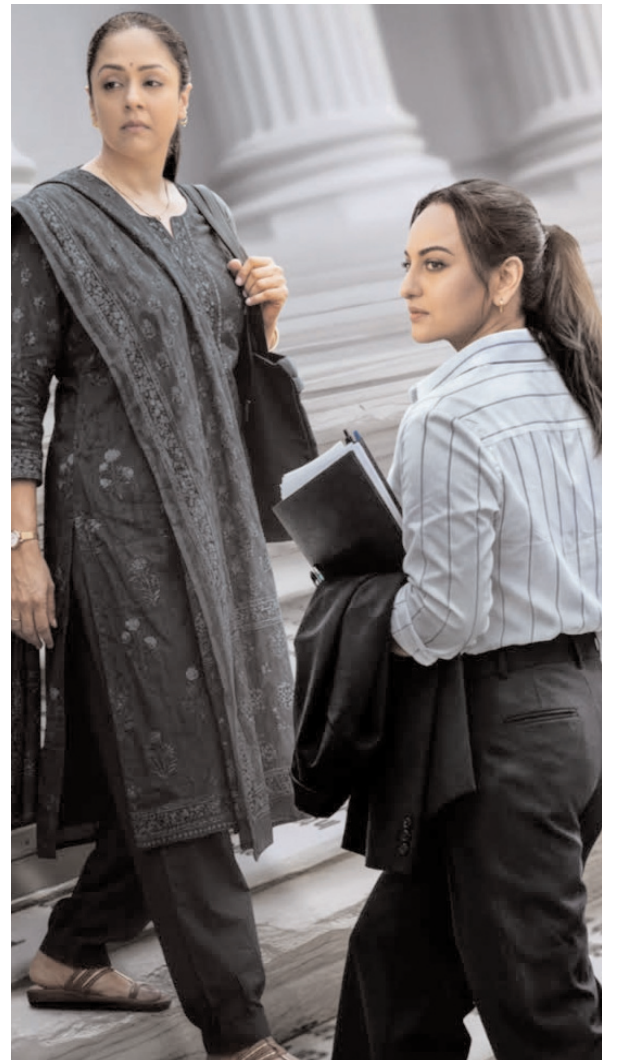
What is the story of "Doordarshini"?
