AP will become a
key player in gold
production: CM Naidu



Puttaparthi, AP (TSIT): Andhra Pradesh Chief Minister N. Chandrababu Naidu on Friday exuded confidence that in the coming days, the state will become a key player in gold production. He stated that Jonnagiri Gold Fields in the Kurnool district is projected to produce 600 kilograms of gold this year. The production in its second year is expected to reach 1,500 kilograms. "In the past, the mention of gold brought to mind KGF; now, it signifies JGF—the Jonnagiri Gold Fields," he said while speaking at an event to lay the foundation stone for various defence projects. The Chief Minister, along with Defence Minister Rajnath Singh, laid the foundation for the Advanced Medium Combat Aircraft (AMCA) programme facility being developed by the Aeronautical Development Agency under the Defence Research and Development Organisation. Naidu stated that under the leadership of Prime Minister Narendra Modi, India is rapidly advancing towards self-reliance in next-generation defence technologies. The AMCA programme will strengthen indigenous capabilities in stealth systems, advanced avionics, and integrated combat aviation, he said. He claimed that the foundation laid for key defence projects across the region and the signing of nine MoUs with companies in the defence and aerospace sectors will further position Andhra Pradesh as a major hub for strategic manufacturing and innovation. He described "Operation Sindoor" as a proud example of India's growing technological strength and the success of the Atmanirbhar Bharat initiative in the defence sector. The Chief Minister noted that the AMCA project, being established with an investment of Rs 15,803 crore across nearly 650 acres in Puttaparthi, would pave the way for the development of a dedicated township and generate employment opportunities for around 7,500 people. He believes that Puttaparthi is set to transform into a strategic defence hub that will be a source of pride for the nation. Through the AMCA project, Andhra Pradesh will play a pivotal role in realising the objectives of "Atmanirbhar Bharat", he said. "We were able to lay the foundation stone for this project in a mere 36 days—granting the necessary approvals with jet speed. This pivotal project in the aerospace sector is expected to pave the way for the arrival of several other defence-related projects."

CM Revanth outlines Telangana vision at Way2News Conclave

Telangana Chief Minister A. Revanth Reddy delivered a detailed address at the "Way2News Conclave 2026," sharing his government's long-term vision, governance philosophy, and development roadmap. Reflecting on his political journey, Revanth Reddy highlighted his understanding of both urban aspirations and rural hardships, particularly the struggles of farmers and government school students. He stressed women-centric initiatives, describing women as society's "growth engine," and highlighted the free RTC bus travel scheme, which has saved families costs while



moving the corporation toward profitability. Plans to replace diesel buses with 3,000 electric buses are expected to save nearly Rs.2,000 crore in fuel.

On education, he announced 100 Young India Integrated Schools with a

Revanth Reddy discussed urban reforms, anti-encroachment drives, rehabilitation of Musi River families, and the futuristic Bharat Future City project across 30,000 acres. He also announced three proposed bullet train corridors and a hub at Shamshabad. The Chief Minister concluded by stressing focus on reality over social media narratives.

NEET-UG re-exam on June 21; computer-based test from next year, says Dharmendra Pradhan

NEW DELHI (TSIT):

Union Education Minister Dharmendra Pradhan on Friday announced that the NEET-UG re-examination will be held on June 21, and said the medical entrance exam will be computer-based test from next year onwards as part of reforms in view of allegations of irregularities linked to it.



Addressing a press conference, Pradhan said

the government's "top-most priority" remains students and their future. He said strict action is being taken against irregularities found in the conduct of the NEET-UG. "Our topmost priority is the future of the students. We will not let malpractice happen this time. The government is with you," he said.

Petrol, diesel prices hiked by Rs 3/litre after elections as crude costs bite



NEW DELHI (TSIT):

Petrol and diesel prices were hiked by Rs 3 per litre each on Friday, the first rate increase in more than four years, amid mounting losses of fuel retailers due to surging global crude prices.

The increase comes 16 days after assembly elections concluded in Assam, Kerala, Tamil

Nadu and West Bengal. Fuel prices had remained unchanged through the polling period despite a sharp rise in international oil prices triggered by the West Asia conflict. Petrol price was hiked to Rs 97.77 per litre from Rs 94.77 in the national capital. Diesel now costs Rs 90.67 as against Rs 87.67 per litre previously, industry sources said.

Straits of Hormuz open to all except hostile countries: Iranian FM Araghchi

New Delhi (TSIT):

Iranian Foreign Minister Seyed Abbas Araghchi on Friday said that the Strait of Hormuz remains open to all vessels, except for those belonging to countries engaged in a conflict with Iran.

Addressing a press conference in New Delhi, Araghchi said that Iran continues to facilitate the passage of vessels, noting that it had already done so for several Indian ships.

He said safe passage of all vessels is Iran's policy and interest and that Tehran is ready to assist those seeking secure transit.

India ready to extend all possible support for peace in West Asia: PM Modi in UAE

ABU DHABI (TSIT):

India is ready to extend all possible support to bring peace in West Asia, Prime Minister Narendra Modi said on Friday during his talks with UAE President Sheikh Mohammed bin Zayed Al Nahyan.

The Modi-Al Nahyan meeting took place shortly after the prime minister landed in the Gulf nation in the first leg of his five-nation tour that also includes four European countries. We condemned the attacks on the UAE, Modi said in his opening remarks in the meeting with the UAE leader. The UAE, which hosts a prominent US military base, has been at the receiving end of Iranian strikes during the ongoing US-Israeli war on Iran.

Modi further said, "The way UAE has been targeted is not acceptable" but "the way UAE has handled the current situation with restraint is praiseworthy." The prime minister highlighted how the impact of the West Asian conflict is being felt globally, adding: "India is ready to extend all possible support to bring peace in

Telangana Govt to Tighten Groundwater Regulation Uttam Kumar Reddy

Hyderabad, May 15 (TSIT): N. Uttam Kumar Reddy on Friday directed officials to strengthen groundwater governance across Telangana by imposing stricter controls in over-exploited areas, improving rainwater harvesting mechanisms and enhancing coordination among departments to regulate groundwater extraction. The Minister chaired a high-level review meeting on the functioning of the Ground Water Department. The meeting was attended by Irrigation Secretary E. Sridhar, senior officials and hydrology experts.



During the meeting, Uttam Kumar Reddy instructed all District Collectors to convene district-level groundwater committees regularly to strengthen institutional monitoring of groundwater extraction and recharge activities. Officials informed the Minister that groundwater recharge in Telangana improved during 2025. Annual recharge was estimated at 19.61 lakh hectare metres compared to 18.44 lakh hectare metres in 2024, registering an increase of nearly 1.17 lakh hectare metres. However, groundwater extraction also rose from 8.45 lakh hectare metres to 9.18 lakh hectare metres during the same period. Expressing concern over increasing groundwater stress, the Minister directed officials to formally notify all over-exploited villages identified in the latest groundwater assessment and impose restrictions on additional borewell drilling and groundwater extraction in those areas. According to officials, groundwater stress has been reported in 16 districts, while Hyderabad alone has eight mandals classified under the over-exploited category. The review also focused on strengthening regulatory mechanisms related to sand mining operations. The Minister stressed the need for mandatory consultation with the Ground Water Department before granting approvals for sand mining projects. Officials informed the

meeting that Telangana currently monitors groundwater levels through 1,771 piezometers, 352 observation wells, 921 command-area observation wells and 64 stream-flow checkpoints. The meeting also reviewed SC and ST Sub-Plan borewell programmes. Officials stated that sanctioned borewells under the scheme were successfully drilled and handed over to beneficiaries. Uttam Kumar Reddy asked officials to study successful groundwater conservation models implemented in other states and develop innovative proposals suitable for Telangana's needs. He further emphasised stronger coordination among the Ground Water Department, Irrigation Department, Panchayat Raj Department and Industries Department to improve groundwater levels and ensure long-term water sustainability across the state.

Sridhar Babu Slams Centre Over Fuel Price Hike, Assures Farmers on Paddy Procurement

Says BJP burdening poor and middle class people demands accountability on NEET paper leak

Hyderabad TSIT: State IT and Industries Minister on Friday strongly criticised the Central Government over the hike in petrol and diesel prices, alleging that the BJP-led NDA government was imposing an additional financial burden on poor and middle-class families. Minister made the remarks after holding a review meeting with district officials at the residence of TPCC Working President in Sangareddy. MP also participated in the meeting. Addressing the media later, Sridhar Babu said the increase of 3 in petrol and diesel prices would severely affect common people and lead to a rise in the prices of essential commodities. He alleged that the Centre deliberately avoided increasing fuel prices until the completion of elections in four states and accused the BJP of misleading voters. Questioning the BJP-led government, the Minister asked whether the Centre



had ever provided relief to people when crude oil prices declined in the international market. "Now they have increased fuel prices by 3 and are giving indications of further hikes. By increasing the burden on essential commodities, the BJP is breaking the backbone of poor and middle-class families," he remarked. The Minister said international crude oil prices had fallen to historic lows during the past 12 years, but the Centre failed to pass on the benefits to the people. On political developments, Sridhar Babu alleged that the BJP's agenda was to create divi-

sions among people for political gains. He said Congress leader has been advocating harmony and unity among all sections of society. He asserted that Telangana people are politically aware and would not support what he described as divisive politics. The Minister reiterated that the State Government under Chief Minister is committed to welfare and development. He said all ministers in the Cabinet are working collectively and there are no differences within the government. Speaking on paddy procurement, Sridhar Babu said record quantities of

paddy had arrived in markets this season and assured farmers that the State Government would procure every last grain at Minimum Support Price without causing inconvenience to farmers. He stated that Chief Minister Revanth Reddy has been reviewing paddy procurement arrangements once every two days to ensure smooth operations across the State. Minister also reacted strongly to the NEET examination paper leak controversy, alleging that the NDA and BJP governments at the Centre had played with the future of nearly 23 lakh students. He demanded that the Central Government apologise to students who had worked hard for several years preparing for the examination. Referring to legal matters, Sridhar Babu said the Congress Government would not misuse laws for political purposes and added that "the law will take its own course."

Haritha Nidhi Projects Must Be Completed Expeditiously Minister Konda Surekha

Hyderabad TSIT: Forest, Environment and Endowments Minister Konda Surekha directed officials to ensure the speedy and effective implementation of projects taken up under the Haritha Nidhi initiative. Chairing the 7th State-Level Committee meeting of Haritha Nidhi at the Dr. B.R. Ambedkar Secretariat Minister Along with Pcf Dr C.Suvarna and prl secretary Ahmed Nadeem reviewed the progress of previously sanctioned projects and approved several new proposals aimed at strengthening environmental protection and green development across the State. The meeting approved projects related to the establishment of nurseries, development of urban parks, forest conservation, forest research activities,



training programmes, public awareness campaigns and eco-tourism development. Speaking on the occasion, Minister Konda Surekha said Haritha Nidhi has emerged as an important platform for environmental conservation in Telangana. She stated that the government is giving special priority to protecting forests and enhancing greenery in urban areas to ensure a healthier environment for future generations. Minister stressed that all ongoing and newly sanctioned projects should be completed within the stipulated timelines while strictly adhering to quality standards. She instructed officials to implement projects transparently and in a manner that directly benefits

the public. Konda Surekha further stated that the government is committed to protecting forest wealth, conserving biodiversity and promoting eco-tourism to create employment opportunities for local youth. She called upon officials to work in close coordination to successfully achieve the objectives of Haritha Nidhi.

Illegal activities will not be tolerated: East Zone DCP

Warangal, May 15: East Zone DCP Ankit Kumar conducted a counseling session at Mamoonur Divisional Police Office on Friday for rowdy sheeters under the division, under the guidance of Warangal Police Commissioner. Addressing the group, DCP Kumar warned that individuals with criminal tendencies must follow the law and avoid harming society. He urged them to refrain from intimidation, fighting, threats, and other violent behavior. Activities disrupting peace, such as illegal alcohol consumption, gambling, and extortion, are strictly prohibited. The DCP instructed participants to respect police directives, report



any neighborhood crimes promptly, and keep their personal information, like phone numbers and addresses, updated with authorities. He emphasized that those willing to reform and live within the law could earn a respectable place in society, while violators would face strict legal action. The program also encouraged rowdy sheeters to seek employment and lead constructive lives. TGEJAC Urges Telangana Govt to Resolve Employees' Pending Issues

Submits 45-point resolution to Chief Secretary seeking immediate action on PRC, OPS, DAs and employee welfare

Hyderabad TSIT: The Telangana Employees, Teachers and Pensioners Joint Action Committee (TGEJAC) has appealed to the State Government to immediately address a series of long-pending issues concerning government employees, teachers, pensioners and outsourced staff across Telangana.



In a memorandum submitted to Chief Secretary K.Ramakrishna Rao, the TGEJAC placed a 45-point resolution passed during its Joint Action Committee meeting held on April 10, 2026.The representation, signed by TGEJAC Chairman V. Lachi Reddy and Secretary General

Vodnala Rajasekhara, categorized the demands into top priority, non-financial and financial issues. Among the major demands, the

JAC sought implementation of the 2nd Pay Revision Commission (PRC) before June 2, 2026, release of five pending Dearness Allowances (DAs), restoration of the Old Pension Scheme (OPS) by abolishing CPS, and immediate clearance of pending employee and pensioner bills.

The employee unions also demanded cashless treatment through the Employees Health Scheme, regularisation of outsourced and Samagra Shiksha employees, and reinstatement of terminated computer operators and FTS staff in the Revenue Department.

Dasari Hari Chandana Reviews Preparedness for State-wide Disaster Mock Drills



Hyderabad TSIT: Secretary Dasari Hari Chandana on Friday reviewed the preparedness arrangements for the State-wide mock drills scheduled to be conducted across Telangana on May 18 to strengthen disaster response systems and emergency coordination.

The review meeting was held at the Command Control Centre with senior officials from various departments participating. During the meeting, Hari Chandana directed all departments and district administrations to ensure effective coordination and timely response during the mock exercises.

State-wide drills are aimed at assessing preparedness for floods, forest fires and industrial accidents. Officials said the exercise would evaluate the functioning of Emergency Operation Centres (EOCs), Incident Response Teams (IRTs), communication systems and inter-departmental coordination mechanisms during emergencies.

Speaking on the occasion, Director General of Fire Services Vikram Singh Mann said mock drills help identify operational gaps and improve preparedness to effectively tackle disasters while minimising loss of life and property.

Major General Sudhir Behl (Retd.), Lead Consultant, NDMA, gave a detailed presentation on the responsibilities of departments during emergency situations. He explained that the exercises would help improve communication systems, rescue operations, coordination and resource mobilisation.

As part of the exercise, flood mock drills will be conducted in Hyderabad, Kamareddy, Mulugu, Jayashankar Bhupalpally, Khammam, Nirmal, Nizamabad, Bhadradi Kothagudem, Warangal, Hanamkonda, Wanaparthy, Narayanpet and Jogulamba Gadwal districts.

Forest fire mock drills are planned in Kumuram Bheem Asifabad, Nagarkurnool, Jayashankar Bhupalpally, Mulugu and Bhadradi Kothagudem districts, while industrial accident mock exercises will be held in Rangareddy, Nalgonda, Sangareddy and Medchal-Malkajgiri districts.

Senior officials from NDRF, Police, Forest, Fire Services, CWC, Health, Industries, HYDRAA, TGICCC, CISF and other departments attended the review meeting.

Principal Secretary Reviews GVMC Development Projects



The South India Times, Visakhapatnam : State Municipal Administration and Urban Development Department Principal Secretary S. Suresh Kumar conducted a comprehensive review of various development projects being undertaken by the Greater Visakhapatnam Municipal Corporation. The review meeting was held on Friday at the GVMC headquarters in the presence of GVMC Commissioner Ketan Garg, VMRDA Commissioner N. Tej Bharat, senior officials, engineers, and zonal commissioners. During the meeting, the progress of several projects under GVMC limits, including 24/7 drinking water supply, Madhurawada STP, automation bulk and semi-bulk water supply, desalination

plant, slum development, water treatment plants, Integrated Traffic Management System, and Integrated Sports City, was reviewed. Officials were directed to thoroughly examine the proposals related to development works and prepare a special action plan. As part of the review, GVMC Commissioner Ketan Garg explained details of various development works to the Principal Secretary through a PowerPoint presentation. Suresh Kumar instructed officials to prepare proposals for the construction of Sewage Treatment Plants in Bhemili and Anakapalli and to undertake special measures for the development of identified slum areas. He also advised officials to study the methods being followed in other countries for the implementation of desalination projects. He directed officials to ensure uninterrupted drinking water supply to the public as per the Summer Action Plan and to provide water at scheduled timings without disruption. He suggested

installing GPS systems in water supply tankers and conducting door-to-door surveys through secretariats to identify problems being faced by residents. The Commissioner was instructed to implement a comprehensive action plan to further strengthen the water supply system. The Principal Secretary emphasized the need to focus particularly on sanitation, drinking water supply, and maintenance of streetlights among the civic amenities being provided to the public. In view of the increasing complaints on these issues, zonal commissioners were instructed to visit wards every morning, interact with residents, and immediately rectify deficiencies. He advised Chief Medical Officer Dr. Naresh Kumar to further improve sanitation management. Certificates and medals were presented to achievers from 180 schools. District Education Officer Praveen Kumar, Youth Sports Officer Rajasekhara Reddy, CMO Sudhakar Reddy, AMO Srinivas, GCDO Ashra Qadri, and other officials attended the program.

Chandrababu Makes Rules but Does Not Follow Them: Gudivada Amarnath



Visakhapatnam (TSIT) Former Minister and YSRCP Regional Coordinator Gudivada Amarnath strongly criticized Chief Minister N. Chandrababu Naidu, alleging that he imposes one set of rules on the public while failing to follow them himself. Speaking at a media conference held at the party city office in Visakhapatnam on Friday, Amarnath accused Chandrababu and Minister Nara Lokesh of wasting public money by traveling in special aircraft while advising people to reduce extravagant spending. He said that on one hand the government is asking people to practice austerity measures, while on the other hand its leaders are moving around in special flights and huge convoys, which reflects a double standard. He stated that the allocation of crores of rupees for repairs to official residences in Delhi and the huge expenditure on special flights are already known to the public. Gudivada Amarnath remarked that the YSRCP was formed to fulfill the ideals of YSR, whereas the Telugu Desam Party was

born out of backstabbing politics. Advising Nara Lokesh by saying "Both Are Not Same," he said political criticism on industrial platforms was damaging the reputation of the state. He alleged that hills in North Andhra were being destroyed in the name of development and stated that the YSRCP would launch agitations against excavations taking place in Rushikonda, Bhemili, Madhurawada, and Simhachalam areas. He claimed that during the YSRCP regime ports and fishing harbours were constructed, whereas the present government was focusing only on entertainment activities on beaches. Gudivada Amarnath further criticized Chandrababu, alleging that real estate interests in the 29 villages of the Amaravati region were more important to him than the welfare of the people of the state. He also alleged that not even one of the "Super Six" promises had been implemented and claimed that the entire TDP administration was running on publicity and falsehoods.

Will Withstand Cases, Says Puvvada

Khammam (TSIT): Alleging that the state government was foisting false cases against BRS leaders as part of political vendetta, the party would not be intimidated even if more cases were filed in the coming days and would continue to move forward strongly, said former minister Puvvada Ajay Kumar. Andhra Pradesh Holds 30% of India's Rare Earth Reserves, Eyes Rs.50,000 Crore Investment

Mumbai, May 14: Andhra Pradesh accounts for nearly 30% of India's monazite deposits, positioning the state as a key player in the country's rare earth element (REE) ecosystem. According to B2K Analytics, India holds the world's third-largest REE reserves, but heavy reliance on imports—particularly from China—persists due to insufficient processing capacity. Monazite, a mineral rich in light REEs such as cerium, lanthanum, and neodymium, is found along the coasts of Kerala, Tamil Nadu, Andhra Pradesh, and Odisha. These elements are critical for semiconductors, LEDs, solar cells, and microprocessors. Andhra Pradesh's 3.8 million-ton monazite stock is slated for a significant push, with the state plan-



ning investments exceeding Rs.50,000 crore over the next decade to promote mining, processing, research, and rare earth magnet manufacturing. However, regulatory hurdles remain. Monazite contains thorium, a radio-

active element, restricting private mining and processing under the Atomic Energy Act. Most other countries handle similar minerals under routine frameworks, highlighting India's unique legal constraints.

Rising domestic demand is evident: India imported 60-80% of its REEs by value between 2022-25 and spent USD 221 million on magnet-related imports in 2025. Consumption of rare earth permanent magnets, currently 4,000 tonnes annually, is expected to double by 2030 driven by EVs, renewable energy, defense, and electronics sectors. To reduce import dependence, the government has launched the National Critical Minerals Mission and plans rare earth corridors in Andhra Pradesh, Odisha, Kerala, and Tamil Nadu. While these efforts aim to strengthen domestic supply, gaps in heavy REE reserves and private sector participation remain challenges for India's rare earth ambitions.

TGILP Enhances Livelihoods of Chenchu Tribes: Collector Hemanta Keshav Patil



The South India Times // Nagarkurnool : District Collector Hemanta Keshav Patil directed officials to effectively implement the Telangana Inclusive Livelihoods Programme (TGILP) to improve the living standards of Chenchu tribal families and help the poorest households achieve economic self-reliance. Archakas demand minimum wage, job security in Telangana

Jogulamba Gadwal, May 15: The State President of the Dhupa Deepa Naivedyam Archakas Association, Daulatabad Vasudeva Sharma, has urged the Telangana Government to provide minimum wages and job security for temple priests working under the Dhupa Deepa Naivedyam scheme. Speaking at a meeting, Sharma said that nearly 6,780 archakas serve in temples under the Endowments Department across the state. He highlighted that the current remuneration of Rs.10,000 per month is insufficient to meet rising living costs, noting that only Rs.6,000 is paid directly to priests while Rs.4,000 is spent on puja materials and scheme-related expenses. Sharma stressed that many priest families are facing financial difficulties and called for a minimum salary of Rs.25,000 per month to ensure dignified living and stability. He also demanded that the government implement employment security measures and enhance the welfare of archakas. The meeting saw participation from several association leaders, including Jogulamba Gadwal District President Chakravarthy Charyulu, Wanaparthy District President P.V. Lakshminathacharyulu, State Vice-President Mangu Ravi, Treasurer Adivi Swamy, and other representatives. Archakas and mandal in-charges from Gadwal district also attended, voicing support for the proposed



CJI Surya Kant flags 'parasites' attacking institutions through social media

New Delhi, May 15: The Supreme Court on Friday came down heavily on what it described as a growing culture of attacks on the judiciary and the legal system, with Chief Justice of India (CJI) Surya Kant warning against "parasites" seeking to undermine institutions through social media and other platforms. The strong oral observations came from the Bench, also comprising Justice Joymalya Bagchi, while hearing a petition filed by an advocate challenging the Delhi High Court's refusal to consider him for senior designation — the third such application filed by the lawyer.



"There are already parasites in society who attack the system," the CJI orally observed, cautioning members of the Bar against "joining hands" with such elements. The CJI further made sharp observations about certain individuals active on social media and other platforms, remarking that some "youngsters like cockroaches", who fail to find a footing in any profession, end up becoming "media, social media, RTI activists, or other activists" and begin targeting everyone. "There are youngsters like cockroaches, who

don't get any employment and don't have any place in the profession. Some of them become media, some of them become social media, some of them become RTI activists, some of them become other activists, and they start attacking everyone," he said. The CJI also expressed concern over certain lawyers active on online platforms. CJI Surya Kant said he had serious doubts about the genuineness of the law degrees of some Delhi-based lawyers and orally remarked that he was awaiting an appropriate case to con-

sider ordering a probe into the issue. Referring to content posted online, the CJI orally observed that the top court was aware of material being circulated on platforms such as Facebook and YouTube. When the bench initially dictated an order that the petitioner did not deserve senior designation in view of his conduct and repeated filings, the lawyer apologised and requested that the remarks be withdrawn. Thereafter, the apex court recalled the dictated portion and eventually dismissed the plea as withdrawn.

KIMS Kurnool Doctors Save Kidney Failure Patient Using CRRT

Kurnool, May 15, 2026: In a remarkable medical success, doctors at KIMS Hospital, Kurnool, saved the life of a critically ill kidney failure patient using Continuous Renal Replacement Therapy (CRRT), a highly advanced dialysis technique. The case is notable as the patient's blood pressure had dropped to dangerously low levels, making conventional treatment extremely risky. According to Dr. K. Anantha Rao, Consultant Nephrologist and Transplant Physician, the patient, Mallikarjuna (47) from Adoni, had been suffering from kidney failure for the past six months and was undergoing regular dialysis while awaiting a kidney transplant. He was also battling severe diabetes. During the course of treatment, the patient's blood pressure, which is normally expected to be around 120 mmHg, suddenly plummeted to 60 mmHg, leading to septic shock — a life-threatening condition. He also developed seizures and had to be placed on a ventilator. At the same time, rising acid levels in his body necessitated urgent dialysis. "Performing conventional dialysis in such critically low blood pressure conditions can trigger cardiac arrest and

prove fatal. Therefore, we opted for CRRT, which allows slow and continuous dialysis without causing further hemodynamic instability," explained Dr. Anantha Rao. The patient underwent continuous dialysis for nearly 48 hours using CRRT, which gradually stabilized his condition. Following improvement, he was weaned off ventilator support and has since recovered well. He has now been discharged in a stable condition. The complex procedure was carried out by a multidisciplinary team including critical care specialists Dr. Rajesh Reddy, Dr. Shyam, and Dr. Ravindra. Doctors highlighted that CRRT is particularly beneficial for ICU patients with septic shock and kidney failure, where conventional dialysis may pose significant risks. Until recently, this advanced facility was largely available only in metro cities. With its availability at KIMS Kurnool, critically ill patients in the Rayalaseema region can now access life-saving treatment locally without the need to travel. This case once again underscores that timely intervention and expert medical care can save lives even in the most critical conditions.

The Inescapable Curse
Of Being A Woman
Politician In India

I know this is not an uncommon question, but it is an uncomfortable one. And that is precisely why it refuses to go away. There is something about powerful women in Indian politics that unsettles the public imagination. The discomfort rarely announces itself openly. Instead, it reveals itself slowly, through primetime ridicule, casual sexism disguised as humour, relentless commentary on appearance and temperament, and the tendency to scrutinise a woman's personality long before her politics are taken seriously. What makes this phenomenon particularly revealing is that it transcends party lines and ideology. India does not reserve this hostility for one kind of woman politician. Eventually, almost every woman in public life encounters it, regardless of where she stands politically.

Looking at a few more prominent women politicians of India, the first name that inevitably comes to our mind is that of Indira Gandhi. There are many valid criticisms of her politics, and there always will be. The Emergency alone ensures that her legacy will remain complicated forever. But if you go back and really examine the public language around Indira Gandhi over the decades, you realise people were reacting not only to her decisions but also to the sheer fact that a woman leader was occupying that seat of power. India had elected a woman Prime Minister long before many countries that now lecture the world about progressiveness. Yet, there was always an undertone of discomfort around her authority. Men with absolute political confidence are often described as commanding. With Indira Gandhi, the same traits came to be known as dangerous, power-hungry, and so on. At the height of her authority, she was described by political opponents and admirers alike as "the only man in the cabinet", as though strength, decisiveness, and political control could be understood only through masculinity. Another prominent leader that comes to mind is the former Chief Minister of West Bengal, Mamata Banerjee. Whether people support her or dislike her politically is irrelevant here. What matters is the way public discourse around her often becomes intensely personal in a way that feels disproportionate even by Indian political standards. And perhaps the clearest example of this came the moment she lost politically, because the mask fell almost immediately. The political criticism did not merely intensify, it became personal with startling speed. The language became crueler, uglier, and more mocking.

How Vijay Is Redefining The 'Visual Language' Of Chief Ministership

In the 2018 political thriller Sarkar, which was the story of one man taking on the ruling political party in Tamil Nadu, Vijay played a CEO of an American multinational company, who is considered an expert in branding. Eight years later, reel morphs into real, where the first three days in office as Chief Minister of Tamil Nadu have seen Vijay upping his branding game. If you analyse all that he has done since taking the oath of office and secrecy on Sunday, every step has been tailor-made to elevate Brand Vijay. By strategically moving away from traditional political tropes, Vijay, who is an outlier in the Tamil Nadu political theatre, is attempting to redefine the visual language of leadership in the state. It started with Vijay swapping his white shirt and beige trousers look that Tamil Nadu had seen him in during the election campaign, for a sharp, dapper black suit. It was a look inspired by his character Veera Raghavan, a RAW field agent in the 2022 movie Beast. The sleek matte black suit was specifically crafted for Vijay for his appearances at the swearing-in ceremony and the assembly session. It enabled him to stand out in a sea of white. Trust an actor to know what looks best on camera. But beyond the look on camera, the sartorial shift conveyed the power of the blazer as executive authority. In Tamil Nadu, the white shirt and veshti have been the uniform of the political establishment. In fact, in 2016, when political strategist Sunil Konagolu made MK Stalin discard his veshti for the trousers, the makeover became the talk of the town. By opting for the black suit look, Vijay has executed a brand differentiation. As if to say he is not an archetypal politician and more like the CEO of Tamil Nadu. It is also important to remember that the Gen-Z vote

played a major role in getting Vijay the top job. The smart look appeals to this constituency of the aspirational youth and the urban professional. No offence meant to the dignified veshti, but the blazer look signals efficiency, modernity and a 'let's get down to work' corporate ethos rather than the red tape of traditional bureaucracy. Brand Vijay is communicating to the New India, distancing himself from the old guard. Then came the oath. Most swearing-in ceremonies are solemn occasions, bordering on the sombre. Ministers-designate in many states have fumbled and stuttered in the past, prompting the Governor to come to the rescue. On May 10, at the Nehru Indoor Stadium, Vijay introduced a different vibe. The chief minister-elect came well-rehearsed and read the oath in an energetic manner, in one take. The message was: "I am prepared for the job." While purists may have wanted the oath to be read with unexcited tonality, the experienced actor's throw of voice, dynamic body language, and voice modulation were impressive. Vijay owned the stage, showing that he treated the oath as a high-stakes performance, ensuring a flawless take. Brands that convey clarity are always appreciated, and he demonstrated both command and control. In corporate terms, it reassured his stakeholders - the citizens of Tamil Nadu - that he is in charge. Meeting political rivals at their home was a political masterstroke, the likes of which Tamil Nadu had not seen since 1967. That year, after vanquishing the Congress, DMK leader CN Annadurai had visited former chief minister K Kamaraj at his residence before taking the oath of office. Now Vijay extended the olive branch to his predecessor MK Stalin and other political rivals like Anbumani Ramadoss, Seeman, Vaiko. From a branding point of view, Vijay was telling the world that talking only to your own echo chamber does not help you grow. If you

competitors. So Vijay the brand is a collaborator - or at least, gives that impression during his honeymoon period - instead of a hard-nosed competitor. Vijay conveyed inclusivity by visiting rivals on their home turf. In the process, he humanised his brand, signalling that Brand Vijay is secure, mature and confident of his place in the political ecosystem despite making a lateral entry. Usually, politicians are cagey about asserting their power in public, choosing instead to play the humble neta. Vijay was blunt, declaring himself as the sole power centre in the TVK. By doing so, he eliminated the brand dilution that often plagues coalition governments. His message was, "You voted for Vijay, you will get Vijay." That is brand clarity. Finally, Minister KA Sengottaiyan, who has been an MLA under the leadership of M G

Ramachandran and J Jayalithaa, continues to carry the latter's photograph in his shirt pocket. Any other leader would have felt insecure, but Vijay apparently insisted that Sengottaiyan should not change the practice. Most brands try to erase their predecessors, but Vijay allowed the legacy brand of Jayalithaa to coexist within his TVK ecosystem.



Yahya Khan To Munir, The Curious Pak Factor In Every US-China Thaw

After nine years, US President Donald Trump was in China for a state visit to meet President Xi Jinping, whom he called a "great leader", marking a dramatic shift in the choice of words he generally uses for China and its President. The shift may be driven by several factors: the conflict in the Gulf, the concurrent ascent of India and decline of Europe, a widespread energy crisis, the ongoing Russian war in Ukraine, and the presence of an unpredictable American President. The outreach, however, has also brought to mind an old geopolitical pattern: whenever Washington seeks strategic space with Beijing, Pakistan suddenly regains relevance. The events leading to Trump's visit to China and the growing Pakistan-US ties call for comparisons with 1970. Surely, in 56 years, the global political landscape has flipped 180 degrees. The Cold War The Sino-Soviet split in 1961 marked a turning point in US-China relations, and US President Richard Nixon and his Secretary of State Henry Kissinger were quick to grab the opportunity; however, the problem was how to start talks. In the fall of 1970, Pakistan's military dictator General Yahya Khan agreed to act as a secret mediator between China and the US, helping Kissinger arrange a secret trip to Beijing in July 1971 in return for military aid and turning a blind eye to the genocide in East Pakistan by the army. According to an unclassified report from the US State Department and Department of Defence, the US made an exception in October 1970 to an arms embargo placed on India and Pakistan after 1965. The US "offered to sell armoured personnel carriers, and some aircraft in response to long-standing requests from



Pakistan". The US exemption for Pakistan happened around the time when Yahya Khan was secretly negotiating talks with China to bring Washington and Beijing (formerly Peking) together. In a memorandum from the US President's Assistant for National Security Affairs (Kissinger) to President Nixon on 'Arms Supply Policy for South Asia', a recommendation was made to approve Secretary of State William Rogers' advice to make a one-time exception for Pakistan and approve the sale of tanks and B-57 Canberra tactical bombers. The recommendation was approved in October 1970, when Yahya Khan visited the Oval Office. He thanked President Nixon for the sale of B-57s and a \$100 million loan aid to Pakistan while it was negotiating a \$125 million standby agreement with the IMF, subject to changes in its foreign exchange system. After the 1970 elections in Pakistan, in which Mujibur Rehman's Awami League gained a majority, a civil strife began in the country, followed by a genocide. Archer Blood and American diplomat posted in the consulate in Dhaka (earlier Dacca), wrote a telegram to

Nixon and Kissinger, asking them to act. Though the US imposed an embargo on the sale of lethal weapons to Pakistan, it did not ban the sale or exports to Pakistan on licenses issued on or before March 25, 1971, the day when Operation Searchlight began, resulting in the export of munitions worth \$3.8 million between March and September 1971 and contracts worth \$10 million. It is a recurring phenomenon in US-Pakistan relations, which was once again observed in the aftermath of Operation Sindoor in 2025. On May 9, a day before the ceasefire, the IMF agreed to disburse a \$1 billion relief package for Pakistan. Islamabad is too important to fail for the US and the rest of the world, primarily because of nuclear weapons and the presence of Islamist radicals in the country, a conundrum beautifully exploited by Islamabad. A polarised and politically fractured Pakistan threatens global stability, and, therefore, it needs to be secured. 2026 To 1970 Before heading to China, Donald Trump reaffirmed his support for Pakistan to serve as a mediator between Iran and the US after Senator Lindsey Graham, an ally of Trump,

discredited Islamabad's ability to act as a mediator over news reports on how Pakistan parked Iranian jets at the Nur Khan air base. But Trump said, "Pakistanis have been great, and I think the field marshal and prime minister have been absolutely great." Last month, a US intelligence assessment said that Field Marshal Asim Munir is a red flag for the US and a liability because of his close ties with Iran's military and the IRGC. It appears strange, but in the US-Iran conflict, Pakistan emerged as the only party that maintains close ties with both countries. The context of Trump's China visit is certainly not similar to 1970 because trade war and US sale of weapons to Taiwan are on the agenda of the 2026 meet; however, the presence of Pakistan is common. Maleeha Lodhi, Pakistan's former Ambassador to the US and UK, summarises Islamabad and Rawalpindi's relationship with Washington. She says the "recent warmth shows that a hopeful beginning has been made for a reset in Pak-US ties, but one should avoid hastily concluding ties are on a sustainable upswing".

Garbage, polythene and animals

"Cities standing on heaps of garbage and animals swallowing polythene"

These days, cities are overflowing with garbage. Rotting heaps on the roadsides, foul smells permeating the streets, filth trapped in drains, and animals searching for food among them—this scene not only reflects the failure of the sanitation system, but also our collective social consciousness. Often, when sanitation workers go on strike in the city, the entire discussion is limited to the conflict between the administration and the workers. But behind this filth lies another major issue, one that society conveniently maintains silence on—polythene and its associated waste management. Ironically, polythene is banned by law. The Municipal Corporation periodically issues fines, raids shops, and runs awareness campaigns. Yet, the most common item in every garbage dump in the city is polythene bags, packaging, and plastic waste. It's natural to ask: how is this widespread when it's banned? And if it's so prevalent, why is the ban limited to paper? In fact, instead of understanding the root of the problem, our system has accepted symbolic action as the solution. Municipal officials occasionally issue challans to shopkeepers, assuming their responsibility is fulfilled. Campaigns last for a few days, photographs are taken, news is published, and then the situation returns to normal. Almost every item in the market, from milk to pulses, snacks to vegetables, online delivery to household items, is available in some form of plastic or polythene packaging. This means that the same system that banned polythene has failed to provide alternatives to the market. The truth is that polythene isn't just a shopkeeper's

problem. It's a result of our consumerist habits. The culture of convenience has accustomed us to such an extent that we consider carrying a cloth or jute bag a "goddamn habit." Carrying a new bag for every small item has become the norm. The market thrives on this mentality. If consumers demand, there will be supply. Therefore, society cannot absolve itself of its responsibility by simply blaming the shopkeeper or the corporation. The most worrying aspect is that this very polythene has now become a death trap for animals. The city may have been declared "animal-free," but the reality is that cows, bulls, dogs, and other animals are seen wandering every street and garbage heap in search of food. They ingest polythene along with rotten food. According to veterinarians, kilograms of polythene have been removed from the stomachs of many cows during operations. This is not just cruelty to animals, but the height of our insensitivity. The irony is that while society pays emotional respect to the cow by calling it "mother," it abandons it to die on garbage heaps. Such a stark contrast between religious belief and actual behavior is rarely seen in any other subject. Animals are treated with sentimentality during festivals and events, yet their lives are sustained by garbage and plastic in the city streets. This is not only a failure of the administration, but also a moral failure of society. The polythene crisis isn't limited to animals. It has become a serious threat to the environment, health, and urban life. Plastic stuck in drains causes waterlogging during the rainy season. Rotting waste releases toxic gases. Burning plastic increases air pollution. Gradually, this microplastic

is mixing with soil and water and reaching the food chain. Scientists are constantly warning that microplastic has now entered the human body as well. This means that the polythene, which we consider a convenience, could become a health crisis in the future. The other side of the problem is the failure of waste management. In our cities, even today, waste from most households ends up directly on the streets or in dumping sites without proper segregation. Separating wet and dry waste has been advocated for years, but in practice, this practice is virtually nonexistent. Unless waste is segregated at the household level, recycling cannot be effective. Municipal corporations consider mere garbage collection to be cleanliness, whereas true cleanliness implies scientific waste disposal. It's also worth noting that while cities frequently announce bans on single-use plastic, industries and large brands remain largely unaccounted for. Most products sold in the market come in plastic packaging. If we truly want to eliminate polythene, cracking down on small shopkeepers alone won't be enough. Large companies must also be forced to adopt alternative packaging. Unless changes occur at the production level, both consumers and shopkeepers will be left without a choice. Additionally, the administration must realign its priorities. Cleanliness can't simply be a photo campaign. The city's sanitation system must be sustainable and technically robust. Solid systems for door-to-door collection, waste segregation, recycling units, composting organic waste, and safe disposal of plastic waste are essential. Imposing fines alone won't solve the problem. Unless the system pro-

vides practical alternatives, restrictions will fail. The role of education and public awareness is also crucial. Schools, colleges, and social organizations must focus on behavior change rather than simply running formal campaigns. If children are taught from an early age to use cloth bags, reuse materials, and protect the environment, the next generation can mitigate this crisis. Society must foster an understanding that cleanliness is not just the responsibility of sanitation workers, but of every citizen. The need today isn't just to rid the city of garbage, but to change mindsets. No city can be truly clean if citizens continue to throw garbage on the streets, markets continue to sell plastic, the administration continues to take superficial action, and society continues to allow animals to forage in the garbage. We must acknowledge that garbage isn't just filth, it's the result of our habits. Polythene isn't just a bag; it's an environmental crisis created in the name of convenience. And animals rummaging through garbage aren't just stray animals, but the silent questions of an insensitive society that, amid claims of development, has forgotten its basic responsibilities. If we don't wake up now, cities will become not just concrete jungles but heaps of plastic and garbage, where both humans and animals will be deprived of their right to a clean life. The dream of a clean city won't be achieved simply by government slogans. It requires a confluence of administrative will, social responsibility, and personal discipline. Only then will cities be truly clean, animals safe, and the environment protected for the future.

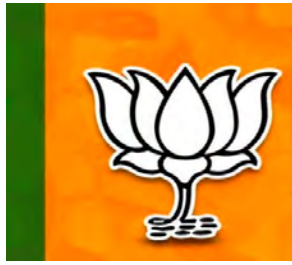

Party insiders claimed that candidates were allotted funds ranging from Rs 10 crore to Rs 20 crore, depending on the constituency's political sensitivity and profile. "In several constituencies, only a small portion of the allocated resources was visibly spent on campaign activities. The leadership wanted clarity on where the rest went," the source said.

During the deliberations, state leaders reportedly attributed the electoral setback to weak coordination from alliance partners and the sweeping Vijay wave that dominated the polls. However, sources said Santhosh remained unconvinced and pressed for granular details on campaign execution, booth management and expenditure patterns.

TASMAC bar owners oppose closure order, seek time to relocate shops

CHENNAI: The Tamil Nadu TASMAC Bar Owners' Association has urged the State-run liquor retailer to reconsider its decision to shut 717 liquor outlets located near places of worship, educational institutions and bus stands, saying the move would severely impact lakhs of workers and families dependent on the trade. In a representation submitted to TASMAC managing director on Friday, association president N Anbarasan objected to the order issued through press release No. 007 dated May 12, 2026, and sought adequate time for relocation of the affected shops. The association said TASMAC had not invested in setting up the liquor outlets and that bar owners themselves identified locations, developed infrastructure and established shops in compliance with official guidelines. It said crores of rupees had been spent on



buildings, electricity connections, maintenance and other facilities, while TASMAC provided only nominal rent. Anbarasan said bar owners had raised investments through bank and private loans and were continuing to pay monthly EMIs. He claimed the sudden closure order had pushed lakhs of employees,

their families and bar operators into uncertainty. The letter said building owners and licence holders had invested several lakhs of rupees in construction and related works by availing loans and using personal savings. Hundreds of workers' families were directly and indirectly dependent on the business.

Experts warn against leaving cut watermelon outside during summer heat



Health experts have cautioned people against consuming improperly stored cut watermelon during summer, warning that the fruit can quickly become unsafe if left outside for long periods in hot and humid weather.

Watermelon, one of the most popular summer fruits in India, is widely consumed for its cooling and hydrating properties. However, dieticians say sliced watermelon becomes highly vulnerable to bacterial contamination once cut open.

Samiksha Kalra, Senior Dietician at Madhukar Rainbow

Children's Hospital, said freshly cut watermelon is generally safe when prepared hygienically and refrigerated properly. But exposure to warm temperatures can allow harmful bacteria such as Salmonella and Listeria to multiply rapidly on the fruit's surface.

"These bacteria can increase the risk of foodborne illnesses, leading to symptoms such as stomach pain, vomiting, diarrhoea, fever and dehydration," she warned. Experts explained that while the thick outer rind naturally protects the fruit, cutting the watermelon exposes its soft, water-

rich flesh to air, moisture and possible contamination from hands, knives or surfaces.

The high water and sugar content in watermelon further creates conditions favourable for bacterial growth if the fruit is not refrigerated quickly.

Health experts advised that cut watermelon should always be stored in airtight containers or tightly covered before being placed in a refrigerator at temperatures below 4 degrees Celsius.

For best freshness and safety, sliced watermelon should ideally be consumed within one to two days. Experts also

stressed the importance of washing the outer rind thoroughly before cutting the fruit, as bacteria present on the surface can transfer to the edible portion through the knife. Using clean knives, chopping boards and storage containers can also help reduce contamination risks.

People have been advised to avoid consuming watermelon if it develops a sour smell, slimy texture, unusual taste, discoloration or foamy liquid, as these may indicate spoilage or bacterial growth.

Medical experts noted that food poisoning cases tend to rise during summer due to rapid bacterial growth in fruits, dairy products and cooked food exposed to heat and humidity.

Children, elderly individuals, pregnant women and those with weaker immunity are considered more vulnerable to complications arising from contaminated food. Experts said simple precautions such as proper refrigeration, timely consumption and maintaining food hygiene can help people safely enjoy watermelon and other summer fruits during the ongoing heat conditions.

Study finds antidepressants during pregnancy do not raise autism risk

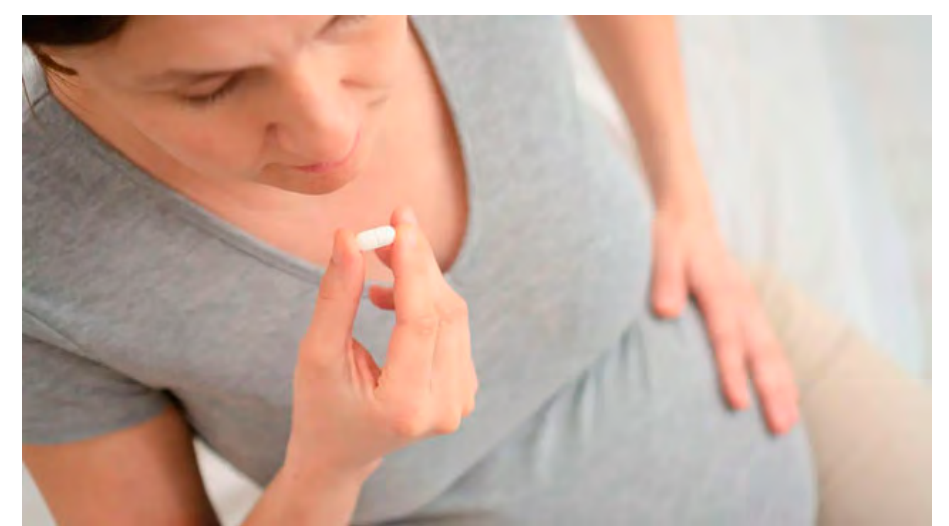
The use of antidepressants during pregnancy does not increase the risk of developmental disorders such as autism or attention deficit hyperactivity disorder (ADHD) in children, according to a large international analysis involving data from more than 25 million pregnancies.

The findings challenge claims made by US Health Secretary Robert F. Kennedy Jr., who has previously alleged without scientific evidence that certain antidepressants could increase autism risk in unborn children.

The study, published in The Lancet Psychiatry, was led by Dr Wing-Chung Chang of the University of Hong Kong.

"Our study provides reassuring evidence that commonly used antidepressants do not increase the risk of neurodevelopmental disorders such as autism and attention deficit hyperactivity disorder in children," Dr Chang said in a statement.

Researchers analysed data from 37 previous studies involving nearly 650,000 pregnancies where antidepressants were used and almost 25 million pregnancies without antidepressant exposure. The analysis initially found that children born to mothers who



took antidepressants during pregnancy appeared slightly more likely to be diagnosed with autism or ADHD. However, those links became significantly weaker or statistically insignificant after researchers adjusted for factors such as maternal mental health conditions, family history, genetics and other related variables. Experts said the findings highlighted the importance of separating the effects of underlying mental illness from the impact of medication itself.

"This is a really important point that is easy to get wrong," said Dr James Walker, professor emeritus of obstetrics and gynaecology at the University of

Leeds, who was not involved in the study.

"If you simply compare children whose mothers took antidepressants with children whose mothers did not, you may find a difference. But that does not mean the medicine caused the difference," he added.

Researchers also observed increased risks of autism and ADHD in children whose fathers used antidepressants while the mothers were pregnant, and among children whose mothers had used antidepressants before pregnancy but not during it. Scientists said those patterns further suggested that shared family or genetic factors — rather than medication exposure during pregnan-

cy — were more likely to explain the higher risks. "A father's medication obviously cannot reach the baby in the womb, so this pattern is very hard to explain by anything other than shared family traits," Walker said. The study further found that higher doses of antidepressants did not increase the risk of developmental disorders in children, another factor researchers said weakened claims that the medicines themselves were responsible. Among women with pre-existing mental health disorders, the older antidepressants amitriptyline and nortriptyline were associated with a higher risk of ADHD and autism in children.

DEFENCE DEALS, LPG SUPPLY, \$5 BILLION INVESTMENTS

MODI'S UAE VISIT BRINGS BIG RETURNS

Prime Minister Narendra Modi's visit to the United Arab Emirates on Friday produced a string of agreements spanning defence, energy, maritime infrastructure and banking, with a UAE investment commitment of \$5 billion announced in the presence of both leaders. Modi held delegation-level talks with UAE President Sheikh Mohamed bin Zayed Al Nahyan in Abu Dhabi, where he was accorded a guard of honour on arrival. The meeting, witnessed by both delegations, saw the exchange of several agreements and MoUs.



Defence Partnership, Formally Framed
The most significant agreement signed was the Framework for a Strategic Defence Partnership between the two countries. This formalises and elevates what has been a growing security relationship, giving it a structured basis for cooperation in defence manufacturing, procurement and strategic coordination. The signing comes at a time when the West Asia region is under acute stress from the

ongoing US-Iran conflict and the near-closure of the Strait of Hormuz.

Energy Cooperation At The Centre
Two energy agreements were inked. The first is an MoU on Strategic Petroleum Reserves — significant for India, which imports nearly 85 per cent of its crude oil and has been working to build buffer stocks against supply shocks. The second is an agreement on LPG sup-

plies, which will help India secure cooking gas imports as global energy markets remain volatile. The UAE is among India's key energy suppliers in the Gulf.

Ship Repair Cluster At Vadinar
In the maritime sector, both sides signed a MoU for setting up a ship repair cluster at Vadinar in Gujarat. Vadinar is home to one of India's largest private oil terminals and is well-posi-

tioned to become a hub for maritime services in the region. The cluster is expected to create jobs and reduce India's dependence on foreign shipyards for repair and maintenance work. 5 Billion Into Indian Infrastructure And Banking In a major financial announcement, UAE investments worth USD 5 billion were committed — directed at Indian infrastructure, RBL Bank, and Sammaan Capital. This adds to the sub-

stantial UAE investment presence in India, which has grown steadily under the Comprehensive Strategic Partnership the two countries elevated in recent years. The UAE is India's third-largest trade partner and its seventh-largest source of cumulative investment over the past 25 years. More than 4.5 million Indians live in the UAE, making people-to-people ties another anchor of the relationship.

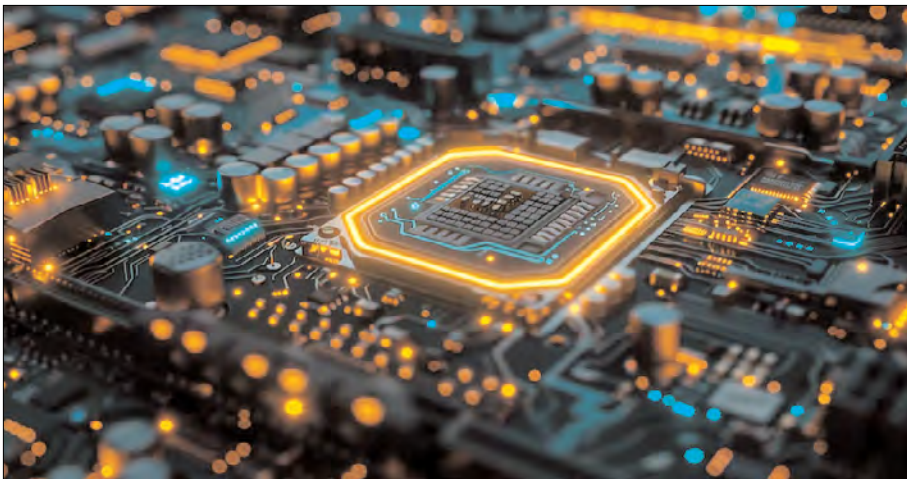

CHIP STOCKS TUMBLE:

Nvidia, AMD, Intel Down Up To 7% As Xi-Trump Summit Fails To Impress Silicon Valley

Global semiconductor stocks slid sharply on Friday after a summit between US President Donald Trump and Chinese President Xi Jinping ended without major announcements on semiconductor trade or expanded market access for US chip-makers. The selloff intensified across Wall Street and global markets as investors unwound bets that the high-profile meeting would pave the way for fresh AI chip deals with China. Shares of Nvidia fell more than 2.5% in premarket trade before extending losses after the opening bell. By 9:45 a.m. EST, Nvidia was down 4.12% at \$226.02. Intel declined 6.8% to \$107.97, while Advanced Micro Devices, or AMD, traded 4.8% lower at \$430.84 around 9:46 a.m. EST. Memory-chip maker Micron Technology also came under pressure, opening nearly 6% lower at \$730.01. The weakness spilled into Asian and European semiconductor counters. South Korean chip-maker SK Hynix, a key Nvidia supplier, closed 7.7% lower. In Europe,



STMicroelectronics dropped 4.8%, while Infineon Technologies and ASML Holding each fell 4.7%. Investor expectations had risen ahead of the summit after Nvidia CEO Jensen Huang joined a delegation of US business leaders traveling to China alongside Trump. The delegation also included Tim Cook of Apple and Elon Musk of Tesla. According to a report by The Wall Street Journal, the US has already authorised Nvidia to export its H200 chips to China, though

Beijing has yet to formally approve shipments. "Investors were betting on the trip for tangible news that could lift Nvidia's sales even further," Danni Hewson, head of financial analysis at AJ Bell, said in market commentary. However, US Trade Representative Jamieson Greer told Bloomberg that semiconductor and Nvidia "weren't front and centre" during summit discussions. The pullback marks a rare pause in the AI-driven rally that has propelled chip

stocks in recent months amid surging demand for data centre infrastructure and artificial intelligence computing. The broader backdrop remains dominated by rising technology tensions between Washington and Beijing. The US has tightened export restrictions on advanced semiconductors over concerns tied to military and AI applications, while China has accelerated efforts to build domestic alternatives and reduce reliance on foreign chipmakers.

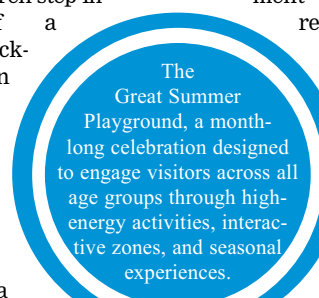

Saudi Arabia launched secret retaliatory airstrikes on Iran during regional war

Saudi: Arabia carried out a series of unpublicised airstrikes on Iran in late March in retaliation for attacks inside the kingdom during the Middle East conflict, according to sources cited by Reuters.

The strikes marked the first known case of Saudi Arabia directly conducting military action on Iranian soil, underscoring a major shift in the kingdom's approach toward its main regional rival.

The conflict began after the United States and Israel launched airstrikes on Iran on February 28. In the weeks that followed, Iran targeted all six Gulf Cooperation Council states with missiles and drones, striking US military bases, civilian sites, airports and oil infrastructure, while also closing the Strait of Hormuz and disrupting global trade.

Saudi Arabia, despite its close military relationship with the US, found itself vulnerable as attacks pierced the US security umbrella during the 10-week war.

The Saudi Air Force strikes were carried out as "tit-for-tat strikes in retaliation for when Saudi (Arabia) was hit," one Western official said.

The strikes reflected the widening scope of the conflict across the Middle East and revealed a regional confronta-



tion that had largely remained out of public view. The Wall Street Journal reported on Monday that the United Arab Emirates had also carried out military strikes on Iran.

Together, the Saudi and Emirati actions showed Gulf monarchies responding militarily after coming under Iranian attack. However, their approaches differed.

The UAE adopted a more hawkish position, seeking to impose costs on Iran and engaging only rarely in public diplomacy with Tehran. Saudi Arabia, meanwhile, sought to contain the conflict and remained in regular contact with Iranian officials, including through Tehran's ambassador in Riyadh, who did not

respond to a request for comment.

According to the Iranian and Western officials, Saudi Arabia informed Iran about the strikes, leading to intensive diplomatic engagement and Saudi warnings of further retaliation. The exchanges eventually produced an understanding between the two countries to de-escalate.

Ali Vaez, the Iran Project Director at the International Crisis Group, said retaliatory Saudi strikes followed by de-escalation would "show pragmatic recognition on both sides that uncontrolled escalation carries unacceptable costs."

Such a sequence would reflect "not trust, but a shared interest in imposing limits on

confrontation before it spiraled into a wider regional conflict," he said, as quoted by Reuters.

The informal de-escalation took effect in the week before Washington and Tehran agreed to a ceasefire in their broader conflict on April 7. The White House did not respond to a request for comment.

At a press conference in Riyadh on March 19, Saudi Foreign Minister Prince Faisal bin Farhan said the kingdom "reserved the right to take military actions if deemed necessary."

Three days later, Saudi Arabia declared Iran's military attaché and four embassy staff members personae non gratae.

A senior Saudi foreign ministry official did not directly address whether a de-escalation understanding had been reached with Iran, but said, "We reaffirm Saudi Arabia's consistent position advocating de-escalation, self-restraint and the reduction of tensions in pursuit of the stability, security and prosperity of the region and its people." According to reports, more than 105 drone and missile attacks targeted Saudi Arabia during the week of March 25-31. Between April 1-6, the number dropped to just over 25.

Hegseth pushes Trump's \$1.5 trillion defense budget for 2027 as Congress presses Pentagon over Iran war costs

Washington, D.C. US defense secretary Pete Hegseth defended President Donald Trump's proposed \$1.5 trillion military budget before House and Senate lawmakers on Tuesday, as Congress pressed the Pentagon over the rising cost of the Iran war, weapons stockpiles and the administration's long-term strategy in the conflict.

The hearings came as the Trump administration faces growing pressure from the economic impact of Iran's effective closure of the Strait of Hormuz, a vital shipping corridor through which about 20% of the world's oil normally flows.

Hegseth told lawmakers that the ceasefire with Iran remains in effect despite recent exchanges of fire. He appeared before Congress after testifying in the Senate, where one Democrat warned that "you've achieved a series of tactical successes but are on the verge of a strategic loss."

While Hegseth adopted a softer tone than in previous hearings, lawmakers from both parties raised concerns about the war's expanding cost and its impact on military readiness.

Pentagon officials told Congress that the cost of the Iran war has now climbed to nearly \$29 billion, up from the \$25 billion estimate provided nearly two weeks ago. Pentagon comptroller Jay Hurst said roughly \$24 billion of the total is tied to replacing munitions and repairing equipment, while the remainder covers operational costs for deployed forces.

The estimate does not include the cost of repairing or rebuilding damaged US military sites in the region.

Lawmakers also questioned whether the conflict was straining US weapons supplies, a suggestion Hegseth rejected.

At the same time, Hegseth acknowledged that the administration is moving to increase weapons production to support the conflict



and prepare for future military operations.

The administration's proposed 2027 defense budget includes \$750 billion for the "Golden Dome" missile defense system, \$102 billion for aircraft procurement and research and development, nearly \$75 billion for drone and counter-drone technologies and \$65 billion to build 18 Navy warships and 16 support ships.

In January, Trump said he wanted to increase the US military budget by half next year to reach \$1.5 trillion.

"I have determined that, for the Good of our Country, especially in these very troubled and dangerous times, our Military Budget for the year 2027 should not be \$1 Trillion Dollars, but rather \$1.5 Trillion Dollars," Trump said on Truth Social.

"This will allow us to build the 'Dream Military' that we have long been entitled to and, more importantly, that will keep us SAFE and SECURE, regardless of foe," the president said.

Trump said the increase would be supported by revenue generated from tariffs introduced since his return to office.

The administration plans to allocate about \$1.1 trillion for defense through the regular appropriations process, with another \$350 billion expected through budget reconciliation, which would allow Republicans to pass measures without Democratic support. The proposal comes as the United States faces annual deficits nearing \$2 trillion and a national

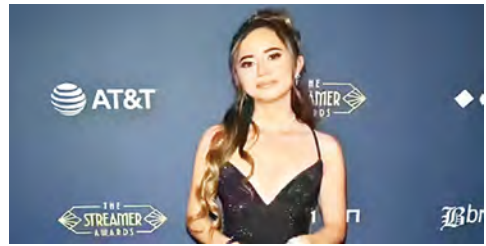
Who is Maya Higa? Twitch streamer makes history with first-ever TED Talk and standing ovation

Washington, D.C.: Maya Higa just reached a milestone no Twitch streamer has ever achieved before. The popular content creator and wildlife conservation advocate received a standing ovation after becoming the first Twitch streamer to deliver an official TED Talk. What began years ago as casual livestreaming has now evolved into one of the internet's most unexpected success stories, blending online entertainment with real-world environmental impact.

The emotional moment unfolded in Vancouver, Canada, where Maya stepped onto the TED stage to explain how livestreaming helped her build a global audience passionate about animal conservation. By the end of the presentation, the crowd rose to its feet, leaving the streamer visibly stunned as she quietly responded, "Thank you."

Maya Higa becomes first Twitch streamer to give TED Talk

During her speech, Maya reflected on how her career changed from gaming and variety streams into a mission-driven platform focused on wildlife education. She explained that traditional classroom outreach inspired her early goals,



but online content allowed her to reach people on a completely different scale.

"Instead of reaching 20 kids at a time in a classroom, I was reaching thousands of people at a time, all over the world. I wanted to do this for the rest of my life," she said.

That vision eventually became Alveus Animal Sanctuary, her Texas-based conservation centre that combines wildlife rescue efforts with livestream technology. The sanctuary broadcasts animals online around the clock while also supporting breeding programs for endangered species and educational outreach.

Maya revealed that her community has raised more than \$7.5 million for conservation causes since 2019. Even more remarkably, she said her streams reached over 250 million viewers in 2025 alone, which she compared to the

impact of millions of classrooms.

She also described Alveus as one of the most accessible zoo experiences in the world because anyone with an internet connection can learn about animals from anywhere.

Maya Higa's TED Talk standing ovation inspires Twitch fans

The standing ovation quickly became one of the most talked-about moments among Twitch fans and fellow creators online. Many praised Maya for helping change public perception around livestreaming and proving that content creators can make meaningful contributions far beyond entertainment.

US announces \$15 million bounty targeting Iran army funding mechanisms

Washington, D.C.: The US state department has announced a reward of up to \$15 million for information on financial networks linked to the Islamic Revolutionary Guard Corps (IRGC), as part of expanded sanctions and enforcement actions targeting Iran's alleged illicit oil trade and funding systems.

The announcement comes under the US "Rewards for Justice" program, which is offering the reward for information that could help disrupt the IRGC's financial infrastructure, including its various branches such as the IRGC-Quds Force. State department spokesperson Thomas "Tommy" Pigott said the US is stepping up pressure under its "Economic Fury" sanctions framework. The Trump Administration is intensifying pressure on the Islamic Revolutionary Guard Corps (IRGC) by targeting the financial networks that enable its illicit oil operations," the statement read.

The US also announced sanctions on a network it says is involved in selling and shipping Iranian oil to overseas buyers on behalf of the IRGC, along with three senior officials from the IRGC's Shahid Purja'fari Oil Headquarters. These individuals were described as being involved in coordinating oil-related



financial transactions.

According to the statement, the measures are aimed at cutting off funding channels that the US says are used to support proxy groups and military activities across the region.

"These actions disrupt illicit funding streams that finance Iran's support for terrorist proxies and regional aggression. These oil revenues belong to the Iranian people, who face daily economic hardship due to the Iranian regime's corruption, mismanagement, and prioritisation of funding terrorist militias and weapons programmes over addressing the basic needs of its citizens," the statement read. The Rewards for Justice program also said it is seeking information on IRGC-linked financing networks. This includes oil-for-money schemes, front companies, sanctions-evasion networks, financial institutions involved in transactions, and procurement channels for dual-use technologies.

Putin hails Russia's test launch of a new ballistic missile and calls it the world's most powerful



Washington, D.C.: MOSCOW - Russia on Tuesday test-fired a new intercontinental ballistic missile as part of efforts to modernize the country's nuclear forces, a launch hailed by President Vladimir Putin just days after his claim that the fighting in Ukraine is nearing an end.

Putin said that the nuclear-armed Sarmat missile would enter combat service at the end of the year. It was built to replace the aging Soviet-built Voyevoda.

"This is the most powerful missile in the world," Putin declared, adding that the combined power of the Sarmat's individually targeted warheads is more than four times higher than that of any Western counterpart.

The Russian leader has repeatedly brandished the nuclear sword after sending troops into Ukraine in February 2022 to try to deter the West from ramping up support for Ukraine.

Iran, US are at impasse ahead of Trump's China trip

DUBAI: Iran and the United States reached an impasse again Monday over how to end their war while their ceasefire grew increasingly shaky, with the two sides exchanging fire in recent days, ships and Gulf states being targeted, and fighting flaring between Israel and the Lebanese militant group Hezbollah.

The volatility could tip the Middle East back into open warfare and prolong the worldwide energy crisis sparked by the conflict, with Iran's chokehold on the Strait of Hormuz and America's blockade of Iranian ports still in place. US president Donald Trump is expected to use a trip this week to China to urge Chinese president Xi Jinping to pressure Iran into making concessions and end the current limbo. Beijing is the biggest buyer of the Islamic Republic's sanctioned crude oil, giving it leverage. But getting to any deal likely remains tough work. Iran insists it wants to see the American blockade end and sanctions lifted before beginning negotiations over its stockpile of highly enriched uranium. The US and Israel, want that material removed since it could be used to eventually build a bomb, should Iran choose to do so. Tehran



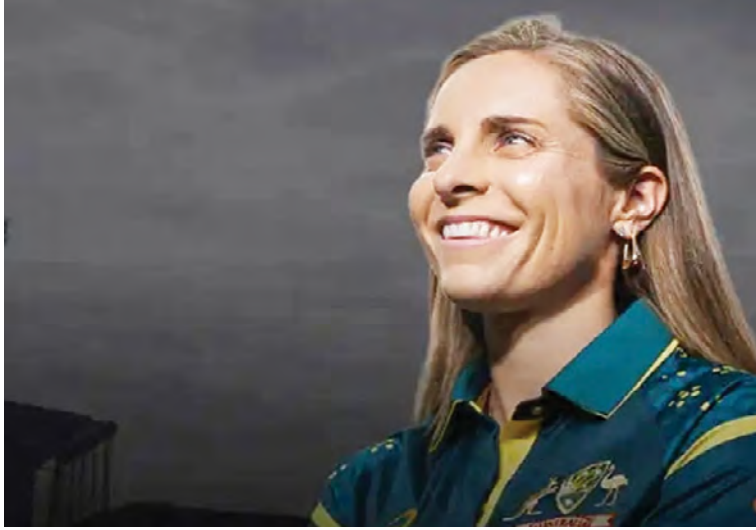
insists its program is peaceful, but it has enriched uranium beyond the levels needed for civilian power generation. Israel insists enriched uranium must be taken out of Iran.

Trump said on Sunday that Iran's response to his latest proposal was "TOTALLY UNACCEPTABLE!" Ending the blockade before discussing Iran's nuclear program would eliminate a major point of leverage for Trump in the talks.

In the meantime, the standoff over the strait, which is a key transit point for the world's oil and natural gas exports, has sent fuel prices skyrocketing and rattled world markets.

Australia will play three practice matches against South Africa at Arundel Castle on May 31, June 2, and June 4 before the World Cup. They will then begin their World Cup campaign against South Africa at Old Trafford on June 13.

Sai Sudarshan's big jump in the Orange Cap race

Gujarat Titans' opening batsman B Sai Sudarshan made a big jump in the Orange Cap race by playing a brilliant innings of 61 runs against Sunrisers Hyderabad. This was his third consecutive fifty and fourth half-century innings in the last five matches.

Sai Sudarshan briefly became the leading run-scorer, but was later surpassed by SRH wicketkeeper-batsman Heinrich Klaasen. Klaasen scored just 14 runs in the match, taking his total to 508, allowing him to retain the Orange Cap. Sai Sudarshan is in second place with 501 runs.

So far this season, only Klaasen

GT hand SRH their biggest IPL loss in terms of runs, continue dominant run against Men in Orange



Ahmedabad, Agency: Gujarat Titans (GT) registered the biggest win in their Indian Premier League (IPL) history, beating Sunrisers Hyderabad (SRH) by 82 runs at Ahmedabad, outdoing their two-day-old record.

While defending 169 runs, a sensational effort in the powerplay from Kagiso Rabada and Mohammed Siraj kept the pressure on SRH, who were skittled out for just 86 runs in 14.5 overs, without any of their batters touching the 20-run mark.

Just on May 9, GT had beaten Rajasthan Royals (RR) by 77 runs, bundling them out for 152 while chasing 230 runs, to register their biggest IPL win ever.

Also, this is the biggest loss for SRH in terms of runs, outdoing their 80-run loss to Kolkata Knight Riders (KKR) last season, skittled out for 120 runs in 16.4 overs while chasing 201 set by KKR, courtesy a three-wicket haul from pacer Vaibhav Arora.

For SRH, this is the first time since 2024 that they failed to

chase a sub-200 target in IPL. Being skittled out for 86 is their lowest all-out total in IPL history, 10 runs less than the 96 runs scored against the Mumbai Indians (MI) in 2019 at Hyderabad.

168 runs defended by GT is also the second-lowest total successfully defended in IPL 2026 after 159 by RR against LSG at Lucknow. This is the GT's sixth successive win against SRH in seven completed games, including four wins at their home turf of Ahmedabad.

Coming to the toss, SRH opted to bowl first and GT was reduced to 26/2, with Sai Sudarshan (61 in 44 balls, with five fours and two fifties) carrying out the repair job with Nishant Sindhu (22 in 14 balls, with three fours and a six) with a 38-run stand and then a 60-run stand with Washington Sundar (50 in 33 balls, with seven fours and a six). GT reached 168/5 in 20 overs, courtesy of fifties from Sudarshan and Washington.

Praful Hinge (2/17 in three

overs) and Sakib Hussain (2/37 in four overs) bowled superbly for SRH. Skipper Pat Cummins also had a four-over spell of 1/20.

During the chase, Mohammed Siraj (1/11 in three overs) started strong by removing Travis Head for a duck. Kagiso Rabada (3/28 in four overs) dismantled the top-order consisting of Abhishek Sharma (6), Ishan Kishan (11) and Smaran Ravichandran (9), reducing SRH to 32/4 in 5.5 overs.

Later, it was Jason Holder (3/20 in four overs) and Prasidh Krishna (2/23 in three overs) who skittled out SRH for just 86 runs, with SRH skipper Cummins (19) being the top scorer.

Rabada was adjudged to be the 'Player of the Match' for his sensational powerplay spell.

With eight wins and four losses, GT stays at the top of the table with 16 points, and SRH has slid to third with seven wins and five losses, with 14 points.

Cristiano Ronaldo's wait for Saudi Pro League title extended after 1-1 draw against Al-Hilal

Riyadh, Agency: Iconic striker Cristiano Ronaldo's wait for his first Saudi Pro League title has been extended as an own goal from Bento led to Al Nassr fumbling their chance at winning the league early after a 1-1 draw against rivals Al-Hilal on Tuesday night.

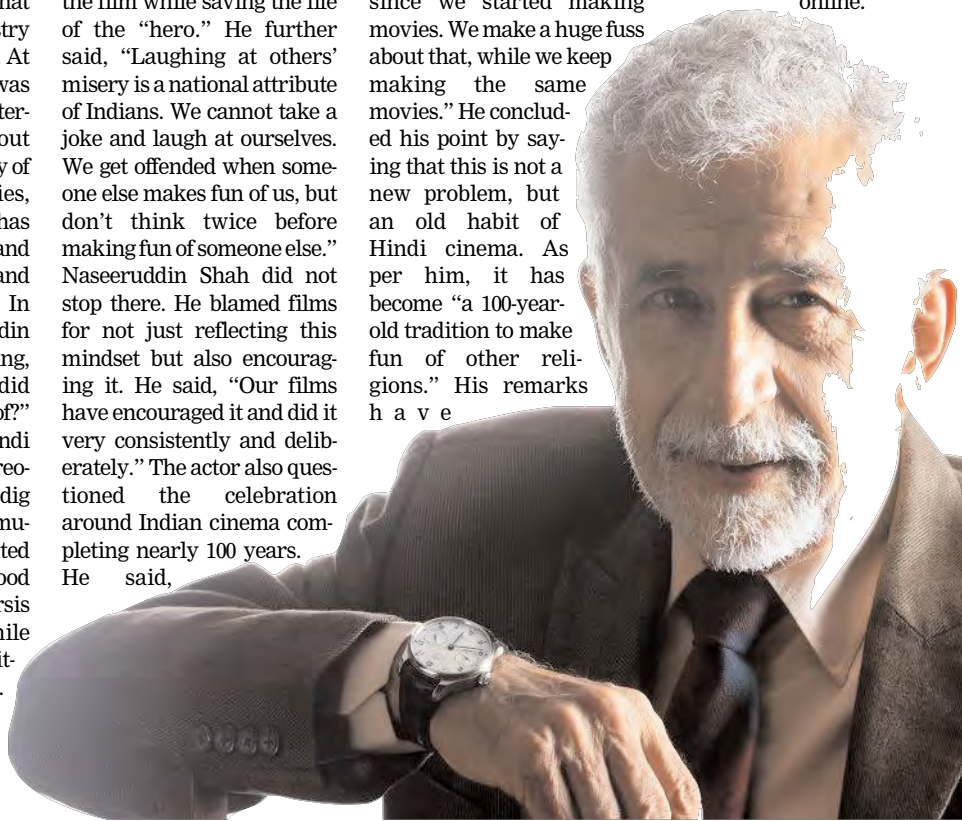

Saif Ali Khan: Kartavya is one of best roles that have come my way

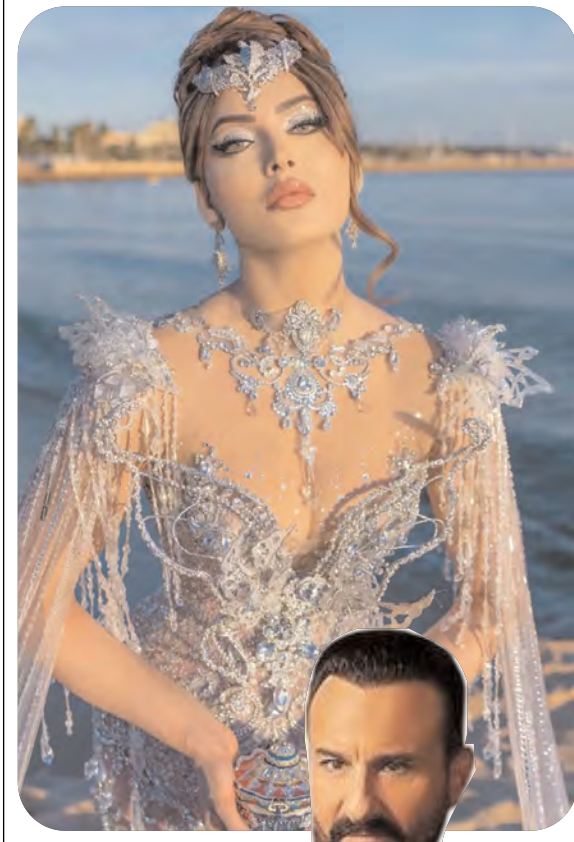

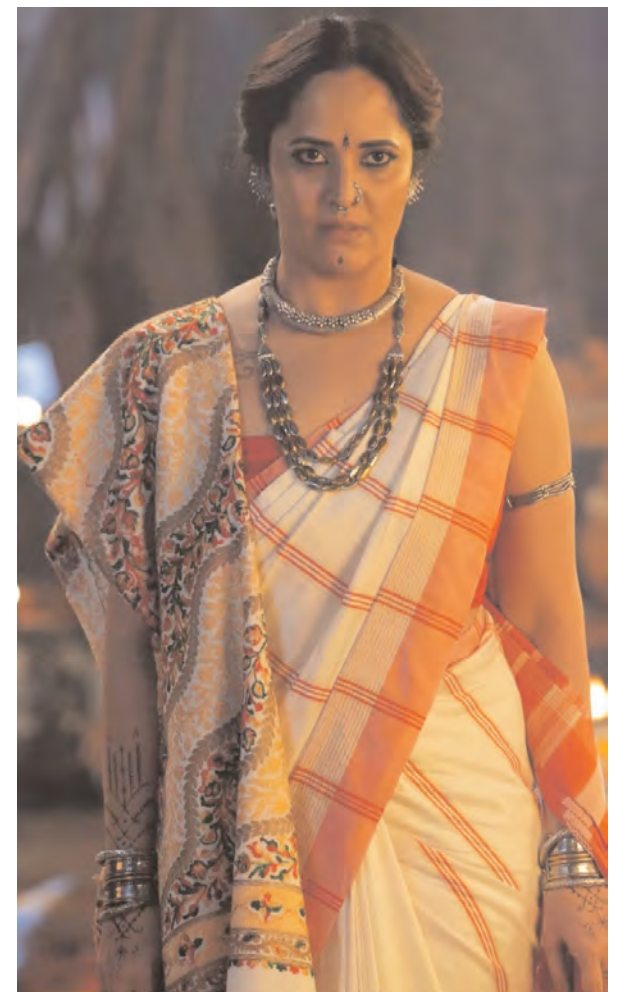
