CM Revanth slams Centre over fuel price hike, calls it betrayal of public trust

Hyderabad (TSIT):

Telangana Chief Minister Revanth Reddy on Saturday strongly criticised the Narendra Modi-led Central Government over the recent increase in petrol and diesel prices, terming the decision "unjustifiable" and a "betrayal of public trust." In a post on X, Revanth said the hike in fuel prices would adversely affect multiple sectors and lead to an increase in the prices of essential commodities, placing a severe burden on common people.

He alleged that the country's economy had weakened significantly due to what he described as the Modi government's ineffective governance and flawed economic policies.

"Atmanirbhar Bharat" has remained merely an election slogan rather than a policy that delivered real results," he said, adding that small and medium-scale industries had suffered badly and youth were facing uncertainty over employment opportunities.

He further claimed that the promise of doubling farmers' incomes had remained unfulfilled and alleged that the value



of the rupee had continued to decline over the past decade.

Referring to the Iran-Israel conflict, Revanth accused the Centre of using the war as a pretext for increasing fuel prices, saying the move amounted to "breaking the backs of common people."

Questioning the government's economic claims, he asked how the Centre could justify the price hike while simultaneously asserting that India had become the world's third-largest economy.

The Chief Minister also accused the BJP-led government of reneging on its assurances made ahead of elections in four states and one union Territory that petroleum prices would not be increased.

India dreaming big, youth aspires to lead in AI, semiconductors: PM Modi

New Delhi (TSIT):

Prime Minister Narendra Modi on Saturday said India is dreaming big and the country's youth now aspire to propel the nation forward in emerging sectors such as Artificial Intelligence (AI) and semiconductors. Addressing the Indian diaspora at an event in The Hague, PM Modi said today's India is going through a phase of unprecedented transformation and has emerged as a global leader in technology, innovation and digitalisation.

He said India recently hosted the world's largest and most successful AI Summit, following the successful hosting of the G20 Summit, adding that such achievements are no longer isolated events but have become the defining character of modern India.

The Prime Minister highlighted that India has carried out the world's largest unique identification programme and also implemented the world's biggest financial inclusion initiative. "The scale and speed of



digitalisation in the country are unprecedented, while India is also operating the world's largest government-funded health insurance scheme," the Prime Minister stated. Referring to India's achievements in science and technology, PM Modi said the country has reached parts of the Moon where no nation had gone before, underlining India's growing

capabilities in space exploration and innovation.

He noted that India is now home to nearly 125 active unicorns and said Indian startups are doing remarkable work in sectors such as AI, defence and space technology. According to the Prime Minister, the country's startup ecosystem has become the third-largest in

"India's progress is being powered by a combination of innovation, entrepreneurship, digital infrastructure and inclusive development initiatives, which are transforming the country at an unprecedented pace," the Prime Minister added.

Rahul extends Sikkim Statehood Day greetings, praises state's harmony and heritage

New Delhi: Congress leader Rahul Gandhi on Saturday extended greetings to the people of Sikkim on the occasion of the state's Statehood Day, praising its natural beauty, cultural richness and spirit of harmony. In a post on social media platform X, Gandhi said, "Best wishes to the people of Sikkim on their Statehood Day." Highlighting the state's unique identity and traditions, the Congress leader said, "Blessed with abundant natural



beauty, a rich cultural heritage, and vibrant traditions, Sikkim stands as a shining example of harmony and resilience." He also expressed hope for the state's continued progress and prosperity, adding, "May the state continue to flourish and thrive." The greetings came as Sikkim celebrated the 50th anniversary of its statehood with official ceremonies, cultural programmes and public events across the Himalayan state. Sikkim formally became the 22nd state of India on May 16, 1975, following a historic referendum that led to the abolition of the monarchy and its integration into the Indian Union. Known for its scenic mountain landscapes, biodiversity and multicultural traditions, Sikkim has emerged over the decades as a prominent destination for ecotourism and organic farming. The state also holds strategic importance for India because of its borders with China, Nepal and Bhutan. Political leaders from across the spectrum have extended greetings to the people of the state during the golden jubilee celebrations, highlighting Sikkim's development achievements and its contribution to the country's cultural and environmental heritage.

Attempts at coercion will not undermine principled positions: UAE rejects Iran's allegations

New Delhi (TSIT):

The United Arab Emirates categorically rejected allegations made by Iran accusing it of "direct involvement in aggression against Tehran" during the period of US strikes on Iran, and strongly condemned what it described as attempts to justify attacks on the UAE and other regional countries, calling them a "flagrant violation of the UN Charter, international law, and the principles of good neighbourliness."

At the BRICS Foreign Ministers' Meeting in New Delhi, UAE Minister of State Khalifa Shaheen Al Marar reaffirmed that such accusations, along with efforts at coercion or misinformation, would have no impact on the country's principled foreign policy. He stressed that the UAE remains firmly committed to safeguarding its sovereignty, national security, and independent decision-making, and retains all rights under international law to respond to any hostile act.

The United Arab Emirates categorically rejected any allegations or threats targeting its



sovereignty, national security, or independent decision-making, asserting that it "reserves its full sovereign, legal, diplomatic, and military rights to respond to any threat, allegation, or hostile act."

He stressed that "attempts at coercion, levelling accusations, or promoting malicious claims will not undermine the UAE's principled positions," reaffirming that the country will continue to safeguard its supreme national interests.

Al Marar noted that since 28 February 2026, the UAE has been subjected to repeated attacks that it attributes to Iran. He said UAE air defences have intercepted "around 3,000 attacks involving ballistic mis-

siles, cruise missiles, and drones" targeting civilian and critical infrastructure, including airports, ports, oil facilities, desalination plants, energy networks, service facilities, and residential areas.

He further stated that despite multiple international and regional condemnations, Iran has continued its actions, referring to United Nations Security Council Resolution 2817 (2026) and a resolution adopted by the United Nations Human Rights Council, which he said reflected a "clear international consensus rejecting these attacks."

The UAE also cited resolutions from the International Maritime Organization, the International Civil Aviation Organization, the International Telecommunication Union, and the Food and Agriculture Organization, stating they collectively condemn attacks on civilian infrastructure and threats to global stability.

On maritime security, the UAE accused Iran of obstructing key sea routes, warning that interference in the Strait of Hormuz constitutes "an act of piracy" and a serious threat to global energy security.

Gadchiroli declared Naxal-free as police arrest eight Naxals, five surrender

Gadchiroli (TSIT):

In a major breakthrough against Left Wing Extremism, police have declared Maharashtra's Gadchiroli district "Naxal-free" following the arrest of eight Naxals, including all six armed cadres active in the district as per official records, and the surrender of five others from neighbouring Chhattisgarh. The operation, codenamed 'Antim Prahar' (Final Strike), was led by Gadchiroli Superintendent of Police M Ramesh and jointly executed by the district police's Special Campaign Squad and the Central Reserve Police Force (CRPF) in the border areas adjoining Telangana and Chhattisgarh.

Police said four armed Naxals were arrested from Telangana, while four others were apprehended from Kurnool and Naitala villages near the Chhattisgarh border, taking the total number of arrests to eight. The arrested cadres have been identified as Raju alias Mangdu Weko, Jani alias Nagi Yemla, Jayaram Gawde, Mukesh alias Lachhu Awalam, Vijay alias Mangdu Tamo, Rajita alias Shambhatti Madavi, Jyoti alias Samita Potavi and Aanti alias



Aayti Idma Podiyam.

Of them, Jayaram Gawde, a resident of Etapalli in Gadchiroli, is the only local resident, while the remaining accused belong to Chhattisgarh. Addressing a press conference, SP Ramesh said that after March 31, only six armed members of Company No. 10 remained active in Gadchiroli district.

One cadre, Moni Madavi, had surrendered in Chhattisgarh, while the remaining five were arrested during the latest operation. "With this, no armed Naxal is currently active in Gadchiroli district," he said, adding that the arrested Naxals carried a combined reward of Rs 64 lakh. Meanwhile, five Naxals also surrendered before the police during the operation. They were identified as Madhu alias Rakesh Welada, Jeevan alias Jaggu Madkam, Rajni alias Durga Dhurwa, Mangli Kursam and Laxmi Punem.

India's jaggery exports value surge over 106 pc in 10 years

New Delhi, May 16 : India accounts for more than 70 per cent of global jaggery production and has seen jaggery exports rise 106.5 per cent in value between 2015-16 and 2024-25, the government said



on Saturday. Exports during April-January 2025-26 reached 450.1 metric tonnes, valued at \$384.4 million, up about 16.5 per cent in volume and 15.9 per cent in value on a year-on-year basis, an official statement said. Complementing this growth, government initiatives such as Pradhan Mantri Kisan SAMPADA Yojana, PM Formalisation of Micro Food Processing Enterprises Scheme, and One District One Product, along with GI tagging, contributed significantly to promote value addition, strengthen rural enterprises, and enhance export potential.

Vijay retains home, administration as TN govt finalises portfolio allocation

Chennai (TSIT):

Tamil Nadu Chief Minister C. Joseph Vijay has retained key departments including Home, Public Administration and Police, as the newly formed government formally completed the allocation of portfolios among ministers sworn in on May 10, marking an important administrative step in the functioning of the state's new government.

The portfolio allocation was approved by Governor Rajendra Vishwanath Arlekar following recommendations made by the Chief Minister. The announcement comes less than a week after Vijay and his Council of Ministers assumed office, with the new administration now moving towards establishing its governance structure and policy priorities. The allocation reflects



the government's emphasis on maintaining direct control over core administrative and law-and-order matters while distributing development and sector-specific responsibilities among cabinet colleagues. As Chief Minister, Vijay will oversee a broad range of departments, including Public Administration, Police, Home

Affairs, Special Programme Implementation, Women Welfare, Youth Welfare, Children's Welfare, welfare of senior citizens and differently abled persons, as well as Municipal Administration and Urban Water Supply. The decision places some of the state's most influential departments

directly under his supervision. N. Anand has been entrusted with Rural Development and Water Resources, including irrigation projects and poverty alleviation programmes.

Aadhav Arjuna will head Public Works and Sports Development, while Dr K.G. Arunraj has been assigned Health, Medical Education and Family Welfare. Senior leader K.A. Sengottaiyan has taken charge of Finance, along with pensions and pension allowances. P. Venkataramanan has been given Food and Civil Supplies, while R. Nirmalkumar will handle Energy Resources and Law, including electricity, courts, prisons and legislative affairs. Rajmohan has been assigned School Education, Tamil Development and Information and Publicity, while Dr T.K. Prabhu will oversee Natural Resources and mining-related sectors.

NEET CASE:

CBI arrests NTA-appointed teacher from Pune for Biology paper leak

New Delhi (TSIT):

In the NEET UG 2026 exam scandal, the CBI has arrested an NTA-appointed senior Botany teacher from Pune, as she is suspected to be the co-mastermind behind the leak of the Biology question paper, an official said on Saturday.

Botany teacher Manisha Gurnath Mandhare is the second Pune teacher - after Chemistry professor P.V. Kulkarni - to be identified and arrested after interrogation, the CBI said in a statement.

She was involved in the NEET-UG 2026 Examination process and appointed by the National Testing Agency (NTA) as an expert and had complete access to the Biology question paper, the CBI said. In



April 2026, she had mobilised prospective NEET examination candidates through Pune consultant Manisha Wagnmare, arrested on May 14, and conducted special coaching classes for these students at her Pune residence, the statement said.

During these classes, she explained and disclosed various questions from Biology and made the students note down the same in their notebooks and also mark these in their textbooks, the statement

said. A majority of these questions tallied with the actual question paper of the NEET-UG 2026 examination held on May 3 and cancelled later, the probe agency said.

In the last 24 hours, the CBI conducted searches at six locations across the country and seized several incriminating documents, laptops, bank statements and mobile phones. Detailed analysis of the seized items is going on, an official said. It may be recalled that CBI registered this case on May 12 based on the written complaint given by the Department of Higher Education, Ministry of Education, Government of India, pertaining to the alleged paper leak of NEET-UG 2026 Examination.

T-Consult Seeks CID Probe Over Alleged False Investment Claims, Harassment



Hyderabad TSIT: T-Consult Global Pvt Ltd has approached Telangana Police and CID authorities seeking investigation and protection over alleged false financial claims, intimidation, harassment of women directors, reputational targeting, and misuse of company identity by Challa Narendra Reddy. The complaint filed by the company has been registered under Petition No. CYB/RDR_CYB/150526/01888 and assigned to an enquiry officer for further investigation. In connection with the issue, T-Consult

directors met CID Chief Charu Sinha and submitted a formal complaint. According to the company, Challa Narendra Reddy was inducted only as a minority shareholder with officially documented participation. T-Consult stated that his recorded investment was around 8.75 lakh towards a 1 percent shareholding through formal banking channels and reflected in statutory and financial records. The company alleged that despite this, claims of investments worth 3 crore to 3.5 crore, including alleged cash and for-

eight transactions, were later made without legally sustainable supporting evidence such as bank records, remittance documents, audited entries, board approvals, shareholder agreements, ROC filings, or cash acknowledgements. T-Consult further stated that there is no legally enforceable document or corporate approval supporting the alleged claims of 25 percent shareholding, directorship, or management control. The complaint also alleged that after the company declined what it described as unsupported demands for additional shareholding and management rights, attempts were made to create pressure through circulation of allegations among media circles, startup ecosystem stakeholders, institutional contacts, business associates, and networks associated with T-Hub and other innovation platforms.

Shivanth Reddy Leads Youth Congress Protest Against NEET-2026 Paper Leak



Hyderabad TSIT: Telangana Youth Congress State General Secretary and Mahabubnagar district in-charge Shivanth Reddy led a protest at the Mahabubnagar district headquarters condemning the alleged NEET-2026 question paper leak and accusing the Central Government of negligence. As part of the protest, Youth Congress activists burnt an effigy of Prime Minister Narendra Modi and raised slogans demanding justice for students affected by the controversy. Protesters also carried placards highlighting concerns over repeated examination paper leaks across

the country. Addressing the gathering, Shivanth Reddy said the NEET paper leak had pushed the future of nearly 22 lakh students into uncertainty. He alleged that students who worked tirelessly day and night for the examination were suffering because of the failure of the Modi Government to ensure a transparent and secure examination system. He stated that 89 paper leaks had taken place across the country during the last ten years and examinations had to be conducted again on 48 occasions, which he described as proof of the Centre's inefficiency in handling the education system.

Land Grabbing Allegations Emerge in Pothireddypalli; Farmers Demand Action

Sangareddy, May 16 (TSIT): Allegations of large-scale encroachment and illegal sale of government-assigned lands have surfaced in Pothireddypalli village, Sangareddy district. Victims claim that land mafias, real estate firms, political leaders, and some revenue officials colluded to grab lands originally allotted to poor farmers. Around 75 acres, including Survey Nos. 153, 154, 155, and 161, are reportedly affected, with 52 acres in Survey No. 153 under



active dispute. Families allege that a real estate firm, TJR Infrastructure, removed boundary stones and began construction without consent, while officials allegedly issued NOCs to facilitate illegal conversions. Farmers demanded

immediate cancellation of all NOCs, a probe by the Anti-Corruption Bureau, and strict action against officials involved. They warned of pursuing legal remedies and meeting Telangana CM Revanth Reddy to reclaim their lands.

Born in 1954 in Thimmapur village, Mancherial district, Justice Chandraiah pursued LLB and LLM degrees from Osmania University before beginning his legal practice in 1980. He served as Government Pleader, member of the High Court Legal Services Committee, and the first Chairman of the Telangana Legal Services Authority. Elevated as a judge of the Andhra Pradesh High Court in 2006, he was known for his balanced



judgments and commitment to the rights of the underprivileged. After retiring in 2016, he became the first Chairman of the Telangana State Human Rights Commission in 2019. His demise has evoked widespread grief across the legal fraternity and human rights community. His last rites will be held at Maha Prasthanam crematorium, Hyderabad, on Sunday.

Comprehensive Plan Needed for Indira Mahila Dairy

Khammam (TSIT): A comprehensive action plan should be prepared for effective implementation of the Indira Mahila Dairy programme and steps must be taken to make it self-sustainable within two years, District Collector Divakara TS said. Reviewing the programme with officials at the Collectorate on Saturday, the Collector instructed officials to identify eligible beneficiaries after release of funds and prepare plans for grounding livestock units in a phased manner. He directed officials to coordinate with higher authorities of SC, ST and Minority Welfare departments for early release of funds and ensure continuous monitoring so that funds are utilised properly without any wastage. The Collector said infrastructure works required at village and mandal levels should be taken up simultaneously and administrative approvals for works under the employment guarantee scheme should be obtained immediately. He also instructed officials to ensure quality construction of cattle sheds and explore installation of solar systems for eligible beneficiaries in coordination with REDCO authorities. Divakara TS further directed officials to assess the quantity of milk required daily at each BMC to achieve break-even and prepare a detailed plan on milk procurement, marketing and financial management by next Tuesday.

India makes first-ever Captagon seizure worth Rs 182 crore under 'Operation RAGEPILL': HM Shah

New Delhi, May 16 : Union Home Minister Amit Shah on Saturday said enforcement agencies have made India's first-ever seizure of Captagon, a banned synthetic stimulant, commonly referred to as the "Jihadi Drug", valued at Rs 182 crore.

In a post on X, Shah said the seizure was made under "Operation Ragepill" and described it as a major step in the Centre's anti-narcotics campaign. He said the consignment was destined for the Middle East and confirmed that a foreign national had been arrested in connection with the case.

"Modi govt is resolved for a 'Drug-Free India'. Glad to share that through 'Operation RAGEPILL', our agencies have achieved the first-ever seizure of Captagon, the so-called 'Jihadi Drug', worth Rs 182 crore," he said in a post. He noted that the operation reflected the government's "zero tolerance against drugs" policy and reiterated that authorities would act against narcotics trafficking through or into India. "I repeat we will clamp down on



every gram of drugs entering India or leaving the country using our territory as the transit route," Shah said while congratulating officers of the Narcotics Control Bureau (NCB).

Captagon is a banned stimulant that has been

linked internationally to organised crime and conflict zones in parts of West Asia.

Indian authorities have in recent years intensified monitoring of synthetic drugs and transnational narcotics networks operating through maritime and

air cargo routes.

The latest seizure comes amid a series of major anti-drug operations highlighted by Shah over the past year. Earlier this month, the NCB seized 349 kg of high-grade cocaine worth Rs 1,745 crore in Mumbai after

uncovering what Shah described as a major international narcotics ring.

The agency said the operation followed a "bottom-to-top" investigation strategy tracing a smaller consignment to a larger network.

In another operation announced previously by Shah, the NCB recovered high-grade cocaine, ganja and cannabis gummies in Mumbai in a seizure estimated to be worth around Rs 200 crore.

Investigators said the syndicate involved overseas operators and international courier routes.

According to reports, the NCB seized more than 1.33 lakh kg of narcotic substances worth nearly Rs 1,980 crore in 2025 and arrested 994 traffickers, including 25 foreign nationals, in 447 cases across the country. Speaking at an anti-narcotics event on Friday, Shah said, "The government had prepared a roadmap to make India drug-free by 2047, and no narcotics consignment should be allowed to enter or transit through Indian territory."

SRM University-AP to Establish Quantum Secure Communications Test Bed with C-DOT

Amaravati, May 16 (TSIT): SRM University-AP, Amaravati, in collaboration with the Centre for Development of Telematics (C-DOT) and Amaravati Quantum Valley, will establish a state-of-the-art Quantum Security Test Bed for communications and cyberspace. The initiative, launched ahead of World Telecommunication and Information Society Day on May 17, aims to strengthen India's quantum-secure communication systems, cyber resilience, and next-generation digital infrastructure.

As the first university in India with a dedicated quantum laboratory, SRM University-AP is emerging as a national hub for quantum science and deep-tech innovation. The test bed will leverage C-DOT's expertise in Quantum Key Distribution (QKD), Post-Quantum Cryptography (PQC), AI, and next-generation telecom networks, offering a platform for research, testing, and innovation in quantum cryptography, distributed quantum computing, and secure communication networks. The initiative aligns with the National Quantum Mission and reinforces Andhra Pradesh's position as a centre for frontier technologies. SRM University-AP and Amaravati Quantum Valley aim to advance India's technological sovereignty and global leadership in quantum security.

HEAVY MENSTRUAL BLEEDING 'NOT NORMAL', SAY EXPERTS AT FIBROIDS SUMMIT IN HYDERABAD



Hyderabad, May 16: Experts at the Asian Leadership Summit on Fibroids, which began in the city on Saturday, stressed that heavy menstrual bleeding should not be considered normal and often signals underlying conditions such as uterine fibroids.

The two-day scientific meet, attended by over 350 national and international gynaecologists, is being hosted by Dr Rooma Sinha of Apollo Hospitals. The summit focuses on innovation, early diagnosis and advanced treatment strategies in fibroid care. Inaugurating the event, Dr Sangita Reddy highlighted that many women silently endure prolonged bleeding, fatigue and anaemia without seeking medical help. Citing NFHS-5 data,

she noted that nearly 57 per cent of Indian women are anaemic, with heavy menstrual bleeding a key contributor.

A fireside discussion featuring journalist Uma Sudhir and entrepreneur Upasana Kamineni Konidela emphasised informed choice in treatment, noting that fibroid diagnosis does not always require hysterectomy and that uterus-preserving options are available.

Sessions covered robotic surgery, minimally invasive procedures, AI-assisted imaging and fertility-preserving techniques. As part of the summit, a 'Red Strength Walk' will be held on May 17 to raise awareness on fibroids, anaemia and the need for timely medical intervention.

Vishaka City Police Crack Woman Murder Case Within Two Hours

The South India Times, Visakhapatnam : City Police successfully cracked the sensational murder and robbery case reported at Akkayyapalem within just two hours and arrested the accused. The details were disclosed by Visakhapatnam Crime DCP K. Latha Madhuri during a media conference held at the Police Commissioner's Office on Friday evening. According to the police, the victim, Pilla Parvathi (53), a resident of PRK Naga Anand Apartments in Srinivasa Nagar, was brutally murdered on Thursday evening. The accused was identi-



fied as Gannavarapu Ramu (53), who had rented a shop belonging to the victim's husband and was running a salon business there. The DCP stated that immediately after receiving information about the incident, police teams led by ACP

Crimes Bhavya Reddy, along with East Zone Crime staff and the Clues Team, rushed to the spot and launched an investigation. Based on CCTV footage from the apartment premises, the accused was identified and special teams were formed to

trace him. Police apprehended the accused at Visakhapatnam Railway Station while he was allegedly attempting to flee to Hyderabad with the stolen gold ornaments. During interrogation, the accused reportedly confessed that he was facing severe financial problems. As he had pending shop rent dues for the past three months, frequent demands for payment by the victim led to growing anger. Taking advantage of the woman being alone at home, he allegedly entered the house, argued with her over the rent issue, and strangled her to death.

Hypertension, a silent killer among youth in India: Experts

Hyderabad, May 16, 2026: Hypertension, once considered a health condition largely associated with old age, is now increasingly being detected among individuals in the 20-30 age group, emerging as a major public health concern worldwide. According to global estimates, nearly 1.4 billion people are living with high blood pressure, but only one in four has the condition under control. In India, nearly 220 million people are estimated to suffer from hypertension, while only about 12 per cent have their blood pressure adequately managed. Recent studies have revealed alarming trends, indicating that one in every ten individuals in the 18-25 age group is already affected by hypertension. Cases are rising rapidly, particularly among urban youth exposed to prolonged work stress and unhealthy lifestyles. Medical experts also noted a growing prevalence of blood pressure-related disorders among children and teenagers globally.

Marking "World Hypertension Day", Kamineni Hospitals, LB Nagar, organised a special awareness programme on Saturday under this year's theme, "Controlling Hypertension Together". Doctors highlighted the growing burden of hypertension among young adults due to modern lifestyle patterns, stress, sleep deprivation, and unhealthy dietary habits. They stressed that early detection, regular health check-ups, and lifestyle mod-



ifications can help prevent serious complications such as heart attacks and strokes. Speaking on the occasion, Kamineni Hospitals Senior Consultant Cardiologist and HOD Dr. A. Ravikanth said that hypertension has become one of the fastest-growing health concerns among the younger population. "Excessive screen time, inadequate sleep, junk food consumption, high salt intake, chronic stress, work pressure, lack of physical activity, smoking, and alcohol consumption are contributing to increased blood pressure levels even before the age of 30. This, in turn, is raising the risk of heart attacks at a much younger age. Hypertension is often referred to as a 'silent killer' because it may not show symptoms in the early stages. It is also a major risk factor for heart disease, stroke, and kidney complications. Regular blood pressure monitoring and adoption of a healthy lifestyle are therefore essential," he said.

Consultant interventional cardiologist Dr. G. Shiva Prasad said negligence towards hypertension could

lead to severe cardiac complications at a young age. "Mental stress and anxiety are significantly affecting the health of today's youth. Individuals with a family history of hypertension should remain particularly cautious. If detected early, hypertension can be effectively controlled through lifestyle changes and appropriate treatment. Greater awareness through collective efforts by families, doctors, and society is essential to tackle the condition effectively," he noted.

Consultant cardiologist Dr. Shashidhar Madaka observed that despite millions of people suffering from hypertension globally, many remain unaware of their condition. "The increasing prevalence of hypertension among young people is a matter of serious concern. Engaging in at least 30-45 minutes of physical activity daily, reducing salt intake, ensuring adequate sleep, and managing stress can significantly lower the risk of hypertension. A healthy lifestyle remains the best defence against high blood pressure," he said.

Lifestyle Stress Driving Early Hypertension, Say Doctors at CARE Hospitals

Hyderabad, May 16, 2026: India's cardiovascular risk profile is undergoing a worrying shift, hypertension, once largely associated with older adults, is now increasingly being detected among people in their 30s and early 40s. Doctors warn that this silent progression is becoming one of the most under-recognised public health challenges in urban India.

On the occasion of World Hypertension Day, specialists at CARE Hospitals highlighted that hypertension affects nearly one in four adults in urban India, with a significant proportion remaining undiagnosed until complications arise. Health experts caution that this gap in early detection is contributing to a growing burden of preventable heart attacks, strokes and kidney disease. Often termed the "silent killer," hypertension typically progresses without symptoms. Nearly half of those living with high blood pressure are unaware of their condition, as routine screening is still not widely adopted among asymptomatic adults below 40 years of age.

Doctors attribute the rising trend to prolonged stress, sedentary work culture, irregular sleep cycles, high-salt processed diets and declining physical activity, a combination increasingly seen among young professionals and urban populations. In many cases, individuals misinterpret early



physiological changes as fatigue or stress, delaying diagnosis and treatment. Dr. Lalukota Krishna Mohan, Director and Senior Interventional Cardiologist at CARE Hospitals, Hitech City, said, "Hypertension is no longer a condition of later life. We are now diagnosing it much earlier, often in individuals who are in the most active phase of their careers. The concern is not just prevalence, but the silent nature of damage it causes to the heart, brain and kidneys over time." He added, "Most patients do not experience warning symptoms. By the time blood pressure-related complications appear, organ damage may already be underway. Regular screening, especially for those with diabetes, obesity, family history, smoking habits or high stress, is essential. A simple BP check can significantly change long-term outcomes." Experts further noted that uncontrolled hypertension gradually

damages blood vessels, increasing the risk of life-threatening complications such as stroke, heart failure, kidney failure and vascular disease. It remains one of the leading preventable causes of cardiovascular mortality in India. Health specialists emphasised that lifestyle correction remains the first and most effective line of defence. Regular physical activity, reduced salt intake, balanced nutrition, weight management, adequate sleep, stress control and avoidance of tobacco and alcohol can significantly reduce risk.

Dr. Krishna Mohan also stressed the need for preventive health behaviour, stating, "Hypertension prevention begins with awareness and consistency. People should not wait for symptoms to appear. Annual blood pressure screening after the age of 30 should become a routine health habit, not an exception." Reinforcing its commitment to preventive cardiac care, CARE Hospitals called for greater public awareness and early screening adoption as part of long-term strategies to reduce India's growing cardiovascular disease burden. On World Hypertension Day, clinicians reiterated a simple message: detect early, act early — because hypertension rarely announces itself, but its consequences often arrive without warning.

What Next for the INDIA alliance?

In a rare moment of unity, the opposition parties came together to defeat The Constitution (One Hundred and Thirty-First Amendment) Bill in a Special Parliamentary Session on April 17, 2026. Soon after, the four state assembly elections in Assam, Kerala, Tamil Nadu and West Bengal threw up expected results in three, but not in the fourth. In Assam, communal and political gerrymandering by the Himanta Biswa Sarma administration and the Election Commission India (ECI) led to a massive victory for the Bharatiya Janata Party (BJP); in West Bengal, an even more massive BJP victory was engineered by the ECI's Special Intensive Revision (SIR) of electoral rolls and the Opposition parties' failure to jointly combat it on the ground through seat-sharing agreements. Kerala's results were no surprise for a different reason: they returned to the old pattern of alternating Left Democratic Front (LDF) and United Democratic Front (UDF) administrations. Unlike Assam and West Bengal, Kerala appears to have had a reasonably free and fair election. Tamil Nadu's results were a surprise. The Dravida Munnetra Kazhagam (DMK) ran a well-performing administration and was expected to win a second term until the Tamilaga Vettri Kazhagam (TVK) came along. In the runup to the election, it became clear that the TVK was a serious contender. The outcome was a hung house in which the governor intervened to manipulate government formation by the National Democratic Alliance (NDA) but was thwarted by smaller parties offering the TVK support. The Congress was the first and its speed was ill-taken by the DMK, with whom the Congress had jointly contested. The impact of the DMK's bitterness, supported by Akhilesh Yadav of the Samajwadi Party (SP), on the INDIA alliance could be considerable. DMK chief Stalin was a pillar of the alliance, while other parties wavered and some – the Trinamool Congress and the Aam Aadmi Party – walked out. Truth to tell, the alliance has been mainly dysfunctional, absent more often than present. This is why its unity against the Constitutional amendment was so notable. It showed what the Opposition could do when it came together and raised hope of further joint action at a time when we are rapidly losing each vestige of democracy. The threat that the Constitutional amendment embodied – an arbitrary expansion of Parliament that would make deliberation virtually impossible given weight of numbers, wholesale communal and political gerrymandering through delimitation – might have been averted for now but is bound to recur when the ongoing Census' results are published, given that the Atal Bihari Vajpayee administration's freeze on seat expansion ends this year. It may even recur earlier. "

MODI'S 'OPPOSITION-MUKT' BHARAT:

HOW DELHI DURBAR ENGINEERED BENGAL REGIME CHANGE

Adi Shankara's sarpa-sutra nyaya (snake-rope analogy) propounds two levels of truth: what the common man perceives and the absolute truth known only to those who have realised the Brahma (ultimate reality). Big media under prime minister Narendra Modi depicts only what the prime minister's office (PMO) wants them to portray. Nothing more or less. Consider the voluminous election analysis churned out by the pro-government big media ever since the election results were declared on May 4. People, they said, voted for the Bharatiya Janata Party (BJP) because under the Trinamool Congress (TMC) they were suffering due to unemployment, price rise and lack of minimum facilities. Some narrated how young voters, Gen Z, restive youth and the aspiring women saw better opportunities under the new double engine government. But the loyal media has obligingly avoided mentioning newly-crowned chief minister Suwendu Adhikari's dubious background. He has the distinction of having been neck deep in two of most vicious scams in Bengal: Saradha Ponzi scheme and Narada cash-for-favours scam. The BJP had officially labelled him a 'chor' (thief). In 2020, West Bengal chief minister Mamata Banerjee had alleged that he 'jumped into' Modi's washing machine' to escape the probe by central agencies. Look at some of brilliant explanations in godi media for the state voting for BJP: Government employees expected better deal under Modi; people hoped to get liberated from the entrenched goonda groups under TMC in villages and towns; how Mo-Shah's rallies helped expose Banerjee and other opposition leaders; how many rallies they



addressed and how the suffering poor and women waited hours for their leaders and so on. Also, how the BJP's top two identified themselves with the common people by eating fish and Jhalmuri. Then there were stories of how Shah strenuously scripted the BJP victory with meticulous planning at different levels and how the BJP had worked to save people from TMC's 'goondaraj'. Also, there were plenty of stories on the Opposition's governance failures, extortion by the 'mafia syndicates', Banerjee's selection of unpopular candidates under duress – all of which led to vitiate the atmosphere, according to these reports. After the results came out, sections of the media wrote long stories about outgoing chief minister Pinarayi Vijayan's 'centralised' model for his failure to win in Kerala. But the same media, understandably, carefully avoided mentioning the much more brutally con-

centrated power system under the Modi-Shah duo. Shah, no doubt, has performed an admirable feat in West Bengal. For this, he had deployed a mind-boggling number of 2.4 lakh to 2.5 lakh personnel from various central forces in the state. The troops covered all the 61,636 polling stations in West Bengal. In some districts, it worked out to an armed police officer per every 140 listed voters. The troops held frequent field marches in villages and towns to warn the 'trouble makers'. This was in addition to the 38,297 state police personnel, 142 general observers, 95 police observers, 100 expenditure observers, and several teams of the National Investigative Agency (NIA). They all roamed the streets and selectively picked Opposition workers. They stopped the opposition vehicles and pedestrians at will and searched for funds and incriminating documents.

The Election Commission of India's (ECI's) observers and armed personnel reportedly openly coordinated with the BJP's local workers who were seen giving them directions which they seemingly obligingly obeyed, the TMC has alleged. As additional precaution, on crucial days, the troops banned all two-wheelers on roads. Those returning from Bengal say the troops and observers acted in a patently partisan manner.

■ AN UNPRECEDENTED MEETING OF CENTRAL FORCES
Kolkata was also witness to an unprecedented meeting of all units of central armed police forces (CAPFs) at the iconic Science City. According to a media reports, the optics were hard to miss – the chiefs of the Central Reserve Police Force (CRPF), Border Security Force (BSF), Central Industrial Security Force (CISF), Indo Tibetan Border

Police (ITBP) and Sashastra Seema Bal (SSB) under one roof, with hundreds of personnel in a crowded conference hall in a poll-bound state. The sheer scale and extent of the gathering had only sharpened the standoff between the Union government and state government Bengal. The Trinamool Congress was quick to allege that the CRPF gathering resembled plans for a 'military-style takeover' rather than a routine meeting. Such happenings had prompted Mamata Banerjee to accuse the central observers of indulging in 'electoral terrorism.' Thus, paradoxically, the ECI, its special observers and central forces who should have acted in a non-partisan manner and thus earned the trust and cooperation of all parties in the fray, had themselves become the opposition's direct adversary. Even chief minister Banerjee repeatedly alleged that she was beaten up at the counting centre where the forces and EC officials alone were allowed. Now that the BJP's West Bengal conquest is complete, it is necessary to emphasise a few significant outcomes it has brought about. The first is the rise of Shah in the hierarchy of the ruling party. Modi cannot any more push any political initiative without Shah. He had begun impulsively following his home minister's advice. This is because Shah has established himself as a leader in his own right. The second is the BJP's expanding footprint. As a large state, the BJP can muster a formidable 30+ MPs in Parliament from West Bengal. This is something that deserves a deeper review which we will do later. Third, traditionally, Bengal was an exception with a strong secular credential. But in recent years the BJP has been able to force a considerable extent of Hindu consolidation.

An Invisible Subset of Private Schools Is Keeping Education Within Reach for India's Poor

People often ask how some private school-owners are so wealthy if schools are supposed to be not-for-profit. Others talk about how private schools exploit parents with high fees and extra charges. But there is an entire subset of private schools that has escaped notice. These private schools – who do not engage in profiteering – is where the average Indian turns to in the hope of a promising future for their children. These are small neighbourhood schools, commonly called budget schools, that educate the children of shopkeepers, daily-wage earners, drivers, domestic workers and many low-income families who dream of giving their children "something better" than what they had. These schools charge fees so low that most of us would not believe it if we heard the number ourselves. Often, parents fail to pay the fees on time. Nevertheless, these schools keep their engines running. They cannot afford to shut down – doing so would disenfranchise an entire community from its fundamental right to school education. This segment of private schools occupies the space between private schools and government schools – marginally better than the latter, far below the former. For many low-income families, they offer greater institutional accountability and access to English-medium education than government schools, without the prohibitive costs of elite institutions. They are present all across the country, quietly serving as the backbone of local education and significantly reducing transportation costs for many low-income families. A study from the 'Journal of Development Studies (2020)' also shows that 70-85% of children in private unaided elementary schools pay less



than Rs 500 a month, with only 15-30% paying higher fees. Further, UDISE+ 2024-25 data shows that private schools enroll nearly 95.9 million students, with about 41.5% at the primary level and 10.6% in pre-primary, reflecting their considerable role in foundational schooling. Much of this is driven by low-fee neighbourhood schools that are accessible to local communities. Staff salaries at budget schools are extremely low compared to their government school or elite-private school counterparts. According to a 2023 report by TISS, private school teachers at the ECCE (Early Childhood Care and Education) level earn almost 33% less than government school teachers. While primary school teachers earn more than ECCE teachers, they still earn 64.5% less than their government school counterparts at the same level; and similarly, secondary teachers earn 65% less than their government school teacher counterparts. In many such neighbourhood schools, primary school teachers often earn as little as Rs 5,000 – Rs 8,000 a month; a reality that is rarely acknowledged in mainstream policy conversations. Heads of budget schools that we interacted with expressed spoke of the correlation between low fees and

low salaries, but not because the budget schools want it this way – it is the only way they can survive. For many teachers and staff, this salary is often their first step towards financial independence and dignity. These schools are not just educating vulnerable communities; they are also supporting families that depend on this income. Conversations with such small private school owners reveals that these schools function in humane and collaborative ecosystem. One of the school heads described it as "a beautiful system built on humanitarian grounds and mutual collaboration". During the pandemic, when many parents lost their incomes, families tried to borrow small amounts to pay fees out of gratitude for the affordable education that their children receive here. "We too borrowed to pay salaries," he said, "because our teachers are also from underprivileged backgrounds. They cannot get into corporate schools, a government job is hard to secure, and they are not accustomed to farming to fall back on." Teachers, he noted, did not protest even when salaries were delayed or halved during the pandemic. Another head of a budget school told us, "If we were running for profits, we would not have survived

this long. We run mostly on service orientation." He further mentioned that they struggle with regulations, paperwork, and compliance just as much as the materially abundant elite schools. Their vulnerability stems largely from long-standing structural constraints – policy frameworks view schooling through a simple public-versus-private lens – failing to distinguish between elite private institutions and low-fee neighbourhood schools with vastly different capacities. For decades, public debates have circled around a familiar question: should private-school teachers be paid more? These discussions often frame the issue as one of underpayment. However, the foundational issue is that of a fragile financial ecosystem which remains unaddressed. A school principal from coastal Andhra added that during cyclones and floods, schools often waive fees because most parents depend on agriculture and are the first to be affected. She further expressed that sustained support, especially during periods of distress, could significantly strengthen the quality of education these schools provide. "The government knows our contribution very well," a senior teacher from the same school said, "and with some support, we can deliver even better quality."

THE REAL HEROES OF OUR CITIES: SANITATION WORKERS

A city isn't defined by its tall buildings, wide roads, or dazzling lights, but by its cleanliness and orderliness. When a person enters a city, the first thing they notice is its cleanliness, environment, and civic discipline. Clean cities not only look beautiful, but also symbolize better health, a safe life, and a civilized society. But the people who contribute most to this cleanliness often remain outside of society's attention and respect. These are our sanitation workers—the unseen, unheard, and neglected heroes, on whose labor the entire city's order depends. The recent strike by sanitation workers in various cities forced people to reflect on how quickly urban life can be disrupted if these workers stop working. Within days, streets were piled with garbage, drains clogged, stench spread, and the risk of disease increased. For the first time, people realized that the sanitation workers, whom they considered ordinary employees, were actually the heartbeat of the city. The irony is that while we make tall claims about modernity and development, we still lag far behind in civic responsibility. A large number of people in our cities consider it normal to throw garbage in public places, leave plastic on the streets, and litter. Even those who maintain cleanliness within their homes consider their responsibility over by dumping their garbage on the streets. This is why, in the absence of sanitation workers, cities quickly turn into garbage heaps. This situation is not only a testament to administrative weakness, but also to our weak civic sense. In developed countries, citizens are self-conscious about cleanliness. They consider throwing garbage on the streets a social crime. However, in our country, cleanliness is still considered the sole responsibility of sanitation workers and municipal corpora-

tions. Unless society itself embraces cleanliness as a part of its culture and habits, the success of any government campaign will remain incomplete. The lives of sanitation workers are full of struggles. They start work early in the morning when most people are still asleep. They clean roads, streets, and drains in all conditions—scorching heat, harsh cold, rain, or epidemics. Often, they have to work in extremely unhygienic conditions without adequate safety equipment. Every year, many workers die from inhaling toxic gases while cleaning sewers. Yet, society does not give them the respect they truly deserve. During the COVID-19 pandemic, when the entire country was confined to their homes, doctors, police officers, and sanitation workers risked their lives to keep society safe. People honored them with applause and thali banging, but over time, we have forgotten them again. Even today, many sanitation workers are forced to work in temporary jobs, with low wages and unsafe working conditions. A large segment of society still looks down upon sanitation work. This mindset is not only wrong but also inhumane. No job is small or large. If sanitation workers stop working for a day, the entire city's system could come to a standstill. Therefore, their work is not just a job, but a duty to protect public health and social life. The most painful scene in this entire situation is when cows are seen searching for food in the garbage scattered on the streets. In Indian society, cows are given the status of mother, but the reality is that these same cows are forced to eat plastic, rotten food, and toxic waste. This scene exposes our social insensitivity. Devotion is not just demonstrated by words and slogans, but by action. If we truly consider the cow sacred, we must ensure that it is not forced to search for food in the garbage. Today, the growing plastic problem in cities has exacerbated the situation. People use plastic thoughtlessly and then throw it away in the open. This plastic clogs drains, pollutes the environment, and poses a life-threatening threat to animals. Sanitation workers grapple with this filth daily, but the root of the problem lies in the negligence of citizens. Governments periodically launch cleanliness campaigns. The "Clean India Mission" attempted to raise public awareness, but campaigns alone

don't bring about lasting change. Unless citizens take responsibility themselves, cleanliness will remain limited to government posters and slogans. We must understand that cleanliness isn't just the responsibility of the municipal corporation. It's every citizen's duty to maintain cleanliness around them. Segregating waste into different categories, using less plastic, avoiding littering in public places, and raising awareness among others—these small habits can bring about big changes. Protecting the rights and dignity of sanitation workers is equally important. Providing them with fair wages, stable employment, healthcare, and safety equipment should be the government's primary responsibility. Machines should be used more extensively in hazardous processes like sewer cleaning to avoid putting human lives at risk. The education system also needs to incorporate practical aspects of cleanliness and civic responsibility. Teaching children about cleanliness in books alone won't suffice; they must be inspired to practice it in practice. Only when the new generation makes cleanliness a habit will real change in society be possible. The media and society should also highlight the problems and contributions of sanitation workers. People typically remember them only when there's a strike or the city is filthy. However, their daily struggles, hard work, and contributions are rarely discussed. If society honors them, it will not only boost their self-confidence but also strengthen the collective consciousness about cleanliness. We must also understand that cleanliness is not just a matter of aesthetics, but a question of health and civilization. Dirt breeds mosquitoes, flies, and many diseases. Unsanitary environments pose the greatest dangers to children, the elderly, and the poor. Therefore, the work of sanitation workers is directly linked to the health of society. The need today is not just to end the sanitation workers' strike, but to change our mindset. We must recognize that the responsibility for keeping cities clean cannot be placed solely on a few employees. Until citizens themselves become responsible, the problem of filth and disorder will persist. Sanitation workers are truly the heroes of our cities. They work every day to improve our lives without expecting any special recognition or fame.

Bangalore: Ramesh Babu, MLC & Chairman, KPCC Media & Communication Dept, welcomed Election Commission's assurance of conducting strict process on revision process and will not omit a single eligible voter in Karnataka.

Ramesh Babu has written a letter to Chief Electoral officer stating about, Election Commission has initiated the third phase of the Special Intensive Revision (SIR) of electoral rolls in 16 States and 3 Union Territories and has informed that the revision of approximately 5.55 crore voters in Karnataka will commence from June 20.

Under Article 326 of the Constitution, the Representation of the People Act 1950, and the Registration of Elector Rules 1960, the Special Revision of electoral rolls in Karnataka must be conducted impartially and without giving scope for any irregularities, ensuring that voters belonging to any religion or community are not excluded under any discriminatory approach.

Since 1951, Special Revision of electoral rolls has been con-

ducted eight times. However, during the last 21 years, the Election Commission has not conducted such a Special Intensive Revision exercise, nor has the Commission provided convincing reasons for the same till now.

In the background of recent Assembly elections where electoral roll revisions carried out in the name of "special revision" allegedly targeted certain political parties and influenced election outcomes, the Election Commission must ensure that no such irregularities occur in Karnataka.

In this regard, I urge the Election Commission to consider the following aspects during the Special Intensive Revision in Karnataka so that genuine voters are not removed from the electoral rolls in the name of revision:

1. Due to the 2008 delimitation in Karnataka, several Assembly constituencies no longer exist in their earlier form. Voters whose names do not correspond with the 2002 electoral rolls during the mapping process must be protected.
2. Voters whose names have been shifted to different Assembly constituencies due

to demographic changes in Karnataka.

3. Names of women voters whose constituencies have changed due to marriage, education or employment.
4. Government employees whose voter registration has been transferred to different constituencies due to official transfers.
5. Voters who have migrated for business, employment or livelihood purposes.
6. Voters residing in Karnataka by birth.
7. Voters belonging to nomadic, tribal and indigenous communities residing in Karnataka.
8. Voters who possess residence proof issued by local bodies, government institutions or semi-government institutions. Along with protecting the above categories of voters, since Karnataka is approaching a crucial election period, I request that the time limit for the Special Electoral Roll Revision process be extended by one year. In the interest of protecting constitutional values and in discharge of its constitutional responsibilities, I request the Election Commission to incorporate

Ashoka Slams Congress Over Pending Pensions, Questions 'Sadana' Convention

PENSIONS PENDING FOR ORPHANS, SENIOR CITIZENS, ACID ATTACK VICTIMS, AND TRANSGENDER MINORITIES



Bangalore : In the state, the Congress government has stopped providing subsidies and pensions to various exploited and helpless sections, including orphans, senior citizens, and transgender minorities. Opposition Leader R. Ashoka questioned what qualification Congress leaders have to hold a 'Sadana Samavesha' (achievement convention) even though the state treasury is empty.

Speaking at a press conference, he said that Chief Minister Siddaramaiah's Congress government is celebrating and holding a convention to cover up the sins it has committed. Financial assistance to beggars and subsidy beneficiaries has been stopped, and for the past three years, the government has been exploiting these people.

He alleged:

- 5,000 crore under Gruha Lakshmi and 700 crore under Annabhagya have not yet reached the beneficiaries.
- 73 crore grant for orphan children has not been released.
- 45,000 crore meant for Scheduled Castes has been looted.
- Farmers have not received compensation despite surveys.
- 12 types of pensions under the Revenue Department have not been paid for the last three months. There are 81.88 lakh beneficiaries under these pension schemes, requiring 894 crore per month. Although 10,736 crore is allocated every year in the budget, this money

has not reached the beneficiaries, he charged.

Old-age pensions, widow pensions, Sandhya Suraksha, and assistance to transgender minorities have not been paid. When he was a minister, he had taken steps to provide 10,000 per month to acid attack victims, but this government is not releasing it regularly. Devadasis are not getting 2,000, freedom fighters are not getting 10,000 — nothing is being paid. Asha workers were promised 10,000 honorarium by Siddaramaiah, but he has failed to keep his word. He has forgotten the promises he made, Ashoka said.

He criticised the government for repeatedly creating conditions for strikes by not fulfilling the demands of transport employees.

Ashoka said that while Chief

Minister Siddaramaiah asks ministers to conduct 'Janaspandana' (public outreach) programmes in their districts, the district in-charge ministers are only responding to commissions (bribes). Siddaramaiah, who promised to do a Bengaluru city tour every 15 days, has also fallen behind commissions. Deputy CM D.K. Shivakumar's announcement of an 'E-Khata' drive and converting B-Khata to A-Khata is like closing the fort gates after the city has been looted. Officials and staff are looting money from people under this scheme and accepting bribes via PhonePe. Even though this was raised with evidence in the Assembly, no action has been taken, he alleged.

"The land of the people has become the property of Congress.

BJP will put an end to all this," he declared.

He also criticised the 14% tax hike on garbage tenders in BBMP. A 1 crore tender will now cost 1.40 crore, putting an additional burden of 600 crore on the people. Along with this, the garbage cess will also increase.

Why the opposition to SIR?

There are more than 10 lakh Bangladeshi citizens in Karnataka. If anyone challenges this, I will personally take them and show the proof, Ashoka said. Recently, the Police Commissioner spent 65 lakh to deport 250 Bangladeshis by air. Thousands of Bangladeshis are living in Mahadevapura, Chikkamagaluru, and Kodagu coffee estates. The Special Intensive Revision (SIR) of electoral rolls will put an end to this. Those with genuine identity cards need not fear. With Congress, BJP, and JD(S) agents present at every booth, there is no chance of genuine voters' names being deleted, he said.

Congress had dreamt of winning with the votes of Bangladeshi Muslims. They are scared because SIR will stop this. In West Bengal, more Hindus were among those whose names were deleted, but Hindu organisations and BJP did not protest. In Karnataka, Congress has issued identity cards to 10 lakh Bangladeshi residents and does not want them sent back, he claimed.

Karnataka Gets Additional 1,122 Government Medical Seats: Dr. Sharanprakash Patil



Bangalore : The availability of medical seats in the state has increased, offering a golden opportunity for those aspiring to build a career in the medical field. An additional 1,122 seats will be made available to the state, announced Dr. Sharanprakash R. Patil, Minister for Medical Education, Skill Development, Livelihood, and In-charge Minister of Raichur District.

Addressing a press conference held at Vikasa Soudha on Saturday, the Minister stated

MINISTER DEMANDS COURT-MONITORED PROBE INTO NEET QUESTION PAPER LEAK

Bangalore : The recent NEET question paper leak is a grave injustice to the entire student community, and the Central Government has sabotaged the futures of thousands of students who dream of becoming doctors, criticized Dr. Sharanprakash R. Patil, Minister for Medical Education, Skill Development, Livelihood, and In-charge Minister of Raichur District.

Speaking at a press conference held at Vikasa Soudha on Saturday, the Minister said Karnataka's Common Entrance Test (CET) is a far superior model to NEET and should be adopted nationally. The state has urged the Central Government on multiple occasions to consider this, but those appeals have gone unheeded, he said. Chaos surrounds NEET every single year. The Minister demanded that the Union Minister concerned must resign over this latest debacle, and that the investigation must be conducted under the direction of a court of law. The Central Government's haphazard conduct of NEET has completely eroded public trust. The Minister also expressed his lack of confidence in the CBI, which is currently probing the scandal, stating that a transparent investigation under its watch is unlikely.

This scandal appears to have been orchestrated to enable the sale of MBBS seats, and there are strong suspicions that powerful individuals are behind the entire affair, he added. Seeing state BJP



leaders defend the NEET question paper leak scandal makes it abundantly clear that they have no shame or sense of decency, the Minister said sharply. Paper leaks are something the BJP has become notorious for. Under the previous BJP government, there was the PSI recruitment scandal — and now comes the NEET scandal. Misleading and exploiting the youth seems to be the BJP's defining pursuit, said Dr. Sharanprakash Patil.

BENGALURU WEST COMMISSIONER INSPECTS MONSOON READINESS, EQUIPMENT, AND STAFF

Bangalore, May 16 (TSIT): Bengaluru West City Corporation Commissioner Dr. Rajendra K.V. conducted an inspection parade of equipment, vehicles, and staff today at BGS Stadium, Govindajanager, to assess readiness for monsoon precautionary measures. EPS warns cadre against signing emergency GC proposal

CHENNAI: AIADMK general secretary Edappadi K Palaniswami on Saturday reportedly instructed party general council members not to sign any proposal seeking to convene an emergency general council meeting allegedly being initiated by the CV Shanmugam faction amid the continuing power struggle within the party. The rift within the AIADMK widened further on Saturday, with Palaniswami reportedly directing general council members not to extend support to efforts by the CV Shanmugam camp to convene an emergency meeting of the party's general council.

According to party sources, Palaniswami issued the instruction during a consultation meeting held with supporting MLAs and senior functionaries at his Greenways Road residence in Chennai. Reports had earlier emerged that the C.V. Shanmugam faction was attempting to collect signatures from general council members to con-

Under AIADMK party rules, an emergency general council meeting can be convened if three-fourths of the party's 2,646 general council members support the proposal through signatures. Sources said Palaniswami specifically advised party office-bearers and general council members not to sign any document if approached by the rival faction seeking consent for the meeting.

The consultation meeting also reportedly discussed political developments following the recent confidence motion moved in support of Chief Minister Vijay's Cabinet in the Assembly. Party sources further indicated that Palaniswami is likely to meet Governor Rajendra Arlekar, who is currently in Chennai on a one-day visit, and may seek action against 25 MLAs aligned with the CV Shanmugam faction for allegedly defying the AIADMK whip during the confidence vote.

DIG slaps, throws footwear at ministerial staff at Armed Reserve HQ, alleges association



CHENNAI: The Tamil Nadu Police Ministerial Service Association has accused DIG M Vijayalakshmi of slapping and hurling footwear at a junior assistant during office hours at the Armed Reserve Headquarters in Chennai, following a disagreement over an e-office file number.

According to a resolution passed by the association on May 13, the incident occurred around 3.10 pm on May 11. The association said junior assistant C Vignesh was performing his duties when the DIG allegedly expressed dissatisfaction with an e-office file number. She reportedly shouted at him, saying,

"You are only a new joinee. Do you think you are a big man? I will issue a charge memo against you." The association further alleged that the officer then slapped the employee, removed her footwear, and threw it at him in the presence of police personnel and ministerial staff.

The association alleged that this was not the first instance of such behaviour, claiming that the DIG had previously torn papers containing file numbers she disapproved of, particularly those related to office administration or salary matters. Staff members have been working in fear due to her conduct, the association said. The inci-

dent is said to have caused the employee severe mental distress and humiliation. Several witnesses, including police and ministerial staff, were reportedly present at the time of the incident. Following the assault, the staffer informed senior officials and submitted a written complaint seeking action.

Governor Arlekar cuts security convoy fleet, cites PM Modi's call to reduce fuel use

CHENNAI: The number of police escort vehicles deployed for Governor in-charge Rajendra Vishwanath Arlekar has been reduced from 10 to 4 following directions issued by the Governor himself, Lok Bhavan said on Saturday, linking the decision to Prime Minister Narendra Modi's appeal to curb fuel consumption and encourage the use of public transport. In a statement, Lok Bhavan said the Governor had instructed officials to scale down the convoy strength used during his official engagements and visits to government and private functions across the state.

"Considering one of the 7 appeals made by the Prime Minister to the people of India, to reduce petrol and

diesel consumption and use public transport, the Governor has directed that the number of police security vehicles provided to him be reduced," the statement said.

Until now, a fleet of 10 police vehicles accompanied the Governor during official movements and public appearances. The convoy strength has now been brought down to four vehicles with immediate effect, it added. CM Vijay retains Police, MAWS; Aadhav gets PWD, Highways; Sengottaiyan for Finance The move comes amid repeated public calls from the Centre on fuel conservation and sustainable mobility measures.



TNPDCL launches 'EB-Auto Pay' electricity bill payment facility; here's all you need to know

CHENNAI: The Tamil Nadu Power Distribution Corporation Limited (TNPDCL) has introduced "EB Auto-Pay", a new automated bill payment facility enabled through the National Automated Clearing House (NACH) platform, to promote seamless and hassle-free payment of electricity bills by low-tension (LT) consumers.



How can consumers register for the Auto-Pay facility?

Under the facility, consumers can register their service connection number on the TNPDCL web portal by providing bank account details, debit card details or Aadhaar-based authentication. Once registration is completed, the EB Auto-Pay facility will be activated for the respective service connection.

When will the bill amount be automatically debited?

Whenever a bill is generated, the total amount will be automatically debited from the consumer's bank account on the 10th day from the date of assessment. Following confirmation from the bank, an e-receipt will be generated automatically.

According to TNPDCL, consumers can choose

mandate start and end dates according to their convenience, including future years, as current consumption (CC) bills are continuous in nature. The mandate will enable recurring automatic debit for all bills generated during the active period.

Consumers can register mandates with any bank in which they hold an account. In case of insufficient funds, the bank will

notify the consumer about debit failure, following which payment must be made through an alternate online mode before the due date. Will there be any charges for using the facility?

TNPDCL said SMS and e-mail confirmations would be sent to consumers upon successful e-mandate registration or cancellation. The utility said the facility would help ensure timely payments and avoid belated payment surcharge (BPSC).

The corporation clarified that it is not charging any fee for the service and that Federal Bank is also not levying charges. However, consumers may incur charges imposed by their respective banks in case of insufficient funds on the date of debit.

MK Stalin asks DMK review panel to submit honest report on poll debacle

CHENNAI: DMK president MK Stalin on Saturday instructed the 36-member review committee constituted by the Dravida Munnetra Kazhagam (DMK) to submit an honest and unbiased ground report on the party's defeat in the recent Assembly election. Addressing a consultative meeting with the panel members, Stalin said the committee had been tasked with conducting field studies across all 234 Assembly constituencies to identify the reasons behind the party's poor performance. Describing the panel members as representatives of the party headquarters and "his ears" on the ground, the DMK president urged them to function without personal bias and report the views of cadre and functionaries truthfully.

"Your duty is neither to protect anyone nor to target anyone," Stalin told the committee members. He directed the panel to conduct consultations strictly in two-member teams and avoid individual meet-



ings during the review exercise. Stalin also instructed the committee to encourage cadre to speak freely about their grievances and opinions regarding the election setback.

"Even if criticism is directed against me as party leader, include it in your report," he said.

The former Chief Minister stressed that understanding the genuine feelings of party workers was essential to initiate corrective measures within the organisation.

"Doctors say the truth should never be hidden from them. I am now in that position. Do not conceal anything from me," Stalin remarked. Drawing an analogy with medical diagnosis, he said identifying the "disease" clearly was necessary to prescribe the correct "medicine". He also instructed that the findings and observations collected during the field study should remain confidential and should not be shared with those concerned.

Thailand declares hantavirus a dangerous disease, introduces strict monitoring measures



Thailand has officially classified Hantavirus infection as a "dangerous communicable disease," with authorities introducing strict surveillance, rapid reporting rules and quarantine measures to prevent potential outbreaks.

The decision was approved on Friday by Thailand's National Communicable Disease Committee, according to the Ministry of Public Health. Under the new guidelines, all suspected hantavirus cases must be reported within three hours, while disease investigations are required to begin within 12 hours. Authorities have also mandated a 42-day quarantine period

for individuals considered high-risk contacts.

In a statement, the ministry said hantavirus has become an increasing global health concern due to the risk posed by certain strains capable of spreading between humans through respiratory droplets, although such transmission remains relatively rare.

The ministry added that the new classification was necessary to strengthen preparedness and ensure a rapid national response to any potential cases. To support the enhanced measures, health officials are implementing an expanded action plan focused on disease sur-

veillance, laboratory testing, treatment readiness and local-level coordination.

Thailand's Department of Disease Control is also intensifying screening and monitoring procedures at international entry points. Officials are finalising updated "Patients Under Investigation" criteria and emergency investigation protocols for suspected domestic cases.

Somruet Chungsaman said provincial health departments and hospitals across the country have been instructed to closely monitor potential infections, immediately report suspected cases and communicate

health risks to local communities without delay.

He urged people who have recently travelled from high-risk regions or had contact with rodents to seek urgent medical care if they develop symptoms such as high fever or breathing difficulties. Health experts explained that hantaviruses are a group of viruses primarily carried by rodents and can cause severe illness in humans. Infection usually occurs through exposure to infected rodents or contact with their urine, saliva or droppings.

People may also contract the virus by touching contaminated surfaces or inhaling virus particles in areas with rodent infestations, particularly while cleaning enclosed spaces such as sheds, warehouses or abandoned buildings.

Although human-to-human transmission is uncommon, authorities warned that certain strains have shown the ability to spread through close respiratory contact. Human infections are most frequently reported in rural and agricultural settings, including forests, farms and fields, where rodent exposure is more likely.

Panic in Pulwama village after suspected rabid meat sale; Over 250 given anti-rabies vaccines

Health authorities in Jammu and Kashmir's Pulwama district administered anti-rabies vaccines to more than 250 residents after meat from a bovine animal suspected to be infected with rabies was allegedly sold in a village, triggering panic among locals.

The incident was reported from Parigam village, where a butcher allegedly sold the suspected meat earlier this week. Following rumours that the animal may have been rabid, residents rushed to nearby health centres seeking medical advice and precautionary vaccination. Officials immediately launched an awareness and vaccination drive in the area. Mosque announcements and ambulances were also used to spread public awareness and urge residents not to panic.

Medical Officer at PHC Parigam, Dr Jureeda, said the vaccination campaign was started as a preventive measure even though the infection had not been officially confirmed.

"We heard that contaminated meat was sold by a butcher. As a precautionary measure, we immediately began administering anti-rabies vaccines," she said.



The doctor clarified that properly cooked meat generally reduces the risk of infection, but precautions were being taken due to the possibility of contact with infected fluids while handling raw meat.

She advised residents to seek medical attention if they develop symptoms such as fever, vomiting, loose motion, or unusual behavioural changes.

Many villagers who had purchased meat from the butcher reportedly opted for vaccination despite the uncertainty surrounding

the case. Chief Medical Officer of Pulwama, Dr Tehmeena Jameel, confirmed that over 250 people had received anti-rabies vaccines so far.

She said the matter remains unconfirmed as the animal's head, which is usually required for laboratory testing, had already been destroyed before samples could be collected.

Officials from the Animal Husbandry Department reportedly disposed of the remaining meat after the issue came

to light. Meanwhile, police have registered an FIR and arrested the butcher for further investigation.

SHO Pulwama Zahoor Ahmad said authorities are questioning the individuals from whom the animal was purchased and are also consulting veterinarians who treated the bovine before slaughter. District authorities are expected to hold a high-level review meeting involving all concerned departments to assess the situation and decide further action.

Trump, Boeing say China will buy 200 jets, reopening key market for US plane maker

US: Aircraft manufacturer Boeing will make its first major sale to China in nearly a decade under an agreement for 200 planes announced Friday, May 15, after President Donald Trump's summit with Chinese President Xi Jinping. The deal represents a breakthrough in the US aerospace company's



efforts to reenter a market once central to its long-term growth. Speaking to reporters aboard Air Force One as he returned from Beijing, Trump said China also reserved the right to buy as many as 750 Boeing aircraft as part of the deal. Boeing confirmed the 200-plane order later Friday but did not specify the types of planes or provide any other details. "We had a very successful trip to China and accomplished our major goal of reopening the China market to orders for Boeing aircraft," the company said in a statement, adding that looked forward to "continually addressing China's aircraft

demand." Boeing CEO Kelly Ortberg was among a large group of American CEOs who joined Trump during the president's trip to Beijing, seeking to sell products and services to China. Trump said the potential aircraft deal also would benefit General Electric, which he said would supply 400 to 450 engines to China. GE Aerospace Chairman and CEO H. Lawrence Culp also joined the president on his trip. The company did not immediately comment on the agreement. Last month, Ortberg expressed confidence that any broad US-China trade agreement to emerge when Trump and Xi met would be a "meaningful opportunity" for Boeing. "President Trump has been very focused on supporting us in international campaigns, and he's been very successful in doing that," Ortberg told investors. Since Trump began serving his second term, his administration has made Boeing a focus of its plans to revive US manufacturing. A visit to the Middle East a year ago culminated in major aircraft agreements, including a Qatar Airways order for up to 210 Boeing jets in what the planemaker described at the time as its largest-ever widebody aircraft

order. Saudi Arabia also placed commercial jetliner orders during the trip. Other major Boeing agreements have followed meetings between Trump and foreign leaders. In August, Korean Air formalised a roughly USD 50 billion deal to buy more than 100 Boeing aircraft, spare engines and long-term maintenance services during South Korean President Lee Jae Myung's visit to Washington. The following month, a day after Turkish President Recep Tayyip Erdogan met with Trump in Washington, Turkish Airlines said it planned to add 225 Boeing aircraft to its fleet. In another win for Boeing, the biennial Dubai Air Show opened in November with hometown airline Emirates ordering 65 of Boeing's upcoming 777-9 aircraft. Days later, FlyDubai, the lower-cost sister carrier of Emirates, announced it had ordered 75 additional Boeing 737 MAX aircraft. Before the COVID-19 pandemic, roughly a third of the narrowbody airliners Boeing delivered went to China. But the company's business there plummeted as US-China relations soured. China also was the first country to ground the 737 Max in 2019 after two of the then-new models crashed

less than five months apart in Indonesia and Ethiopia, killing 346 people. Chinese airlines did not resume Max flights until January 2023, much later than carriers in many other countries. Ortberg took over as Boeing's CEO in 2024, a calamitous year for the company. In January of that year, a panel known as a door plug blew off a 737 Max shortly after takeoff from Portland, Oregon. Boeing faced mounting financial pressure as it came under intensifying scrutiny over alleged production and quality failures. While there were some hopes this week's US-China summit would result in concrete trade deal announcements, the president's trip ended with a lot of uncertainty about what the two sides agreed on, said Bonnie Glaser, managing director of the Indo-Pacific program at the German Marshall Fund. Glaser told a media briefing Friday that there had been little concrete information about trade agreements from the summit, including on Chinese purchases of US exports such as soybeans, liquefied natural gas and beef. "All that we have is really what the president has told the world that China has agreed to," Glaser said.

Hormuz Flashpoint: Iran Plans New Shipping Mechanism, Signals Specialised Maritime Service Fees



Iran has announced plans to introduce a new traffic management mechanism for the Strait of Hormuz, one of the world's most strategically vital maritime chokepoints amid the ongoing US naval blockade. The announcement was made by the head of national security commission of the Iranian parliament Ebrahim Azizi, who said the mechanism had been prepared under the framework of national sovereignty and international trade security. "Iran, within the framework of its national sovereignty and the guarantee of international trade security, has prepared a professional mechanism to manage

traffic in the Strait of Hormuz along a designated route, which will be unveiled soon," he wrote. The statement makes clear that access to the route will not be universal. "In this process, only commercial vessels and parties cooperating with Iran will benefit from it," Azizi said, adding that "the necessary fees will be collected for the specialized services provided under this mechanism." Most strikingly, he declared that "this route will remain closed to the operators of the so-called 'freedom project' — a pointed reference widely understood to be aimed at US-led naval operations in the region, which

Washington has framed as ensuring freedom of navigation. The Strait of Hormuz, the narrow waterway between Iran and Oman, is the single most important oil transit chokepoint in the world. Approximately 20 percent of global petroleum liquids pass through it daily, making any threat to navigation there a matter of acute international concern. The announcement comes amid an already volatile regional environment, with the US-Israel military campaign against Iran having dramatically escalated tensions in recent months. The mechanism is expected to be formally unveiled in the coming days.

BIKE TAXI CRACKDOWN:

MAHARASHTRA ASKS APPLE AND GOOGLE TO REMOVE UBER, OLA, RAPIDO APPS

In a fresh regulatory push, Maharashtra's cyber authorities have asked Apple and Google to remove Uber, Ola and Rapido from their app stores over alleged violations involving bike taxi services. The step underscores an expanding crackdown on two-wheeler ride-hailing aggregators. The Office of the Additional Director General of Police, Maharashtra Cyber, issued the notices on May 15, invoking provisions under Section 79(3)(b) of the Information Technology Act, 2000. The order requires the companies to remove the applications and disable access via the Apple App Store and Google Play Store. The step was taken after Maharashtra Transport Minister Pratap Sarnaik, in a letter dated May 12, requested the Cyber Department to act against bike taxi platforms operating in the state. The notices issued to Apple and Google stated that bike taxi services operating through the apps were "unlawful and in violation of the existing legal and regula-



tory framework". They further alleged that these passenger transport services were being provided without the requisite approvals, licences or adherence to Transport Department regulations and the Motor Vehicles Act. "These unauthorised bike taxi operations pose a serious threat to passenger safety. It has been reported that driver verification mechanisms, insurance protections, women's safety measures, and emergency response systems are highly

inadequate. Further, the rash and negligent driving commonly associated with such bike taxi operations creates a substantial risk to public safety," the notice read. "Recently, a serious incident came to light where in a bike taxi service operated through one of these applications allegedly resulted in the tragic death of a woman," it added. In the notices, the companies were alerted that failure to follow directives from Indian law enforcement could lead to legal consequences under provisions of

the Information Technology Act and associated intermediary liability rules. "Since your organisation has a physical presence and conducts business in India, it is subject to the jurisdiction of Indian laws. Failure to comply with directives from Indian law enforcement agencies may result in serious legal action against you. You are hereby warned that if any unlawful or disruptive incident occurs due to your failure to take timely action, you will be held liable," the notice said.

Govt Imposes Import Curbs On Silver, Days After Hiking Duty On Precious Metals

The government on Saturday tightened its grip on silver imports, imposing fresh restrictions that will require traders to obtain a government licence to bring the precious metal into the country.

The significant policy shift comes just days after it sharply raised customs duties on precious metals. The Directorate General of Foreign Trade (DGFT) issued a notification changing the import policy for specified silver bars from 'free' to 'restricted' with immediate effect.

The move covers silver bars containing 99.9% or more silver by weight, along with other specified silver bar categories, including silver plated with gold and platinum. Earlier, imports were freely allowed subject to Reserve Bank of India regulations. Under the new framework, goods under the restricted category require a government licence for imports — a procedural hurdle that effectively gives authorities control over the volume and pace of silver entering the



country. The timing is significant. Just days earlier, on May 13, the government had hiked import duty on precious metals from 6% to 15% — a steep nine percentage point jump that sent an immediate signal of intent to the market. Saturday's import restriction doubles down on that move, suggesting a coordinated policy effort to clamp

down on silver inflows rather than merely make them costlier. The dual policy action — higher duties followed by outright import curbs — is likely to tighten domestic supply, potentially pushing silver prices higher in the short term. Jewellers, industrial buyers and bullion traders are expected to feel the pinch

most immediately. The move follows the government's decision earlier this week to raise import duty on gold and silver to 15% from 6%, significantly increasing the cost of importing precious metals into India.

At the same time, the government has tightened rules for duty-free gold imports by gems and jewellery exporters under the Advance Authorisation (AA) scheme. Under the revised norms, gold imports through the scheme will now be capped at 100 kg per licence. The DGFT has also introduced stricter compliance checks for first-time applicants under the AA scheme. New applicants will now undergo mandatory physical inspection of manufacturing facilities before approvals are granted. The latest measures signal the government's intent to strengthen oversight of precious metals trade while curbing excessive imports and improving regulatory monitoring across the bullion sector.

Chick-fil-A franchisee sued by US government for religious discrimination

The US government is suing a Chick-fil-A franchisee for allegedly denying an employee's request to take Saturdays off work for religious reasons. The lawsuit claims that Hatch Trick Inc, the franchisee, violated federal law by denying an employee's request to refrain from work on Saturdays for religious reasons. The employee was a member of the United Church of God, which observes the Sabbath on that day. The US Equal Employment Opportunity Commission (EEOC) said in a press release. The federal agency is a workplace watchdog set up to fight workplace discrimination. According to the EEOC, the employee requested not to be scheduled for Saturday work during her initial August 2023 job interview. Hatch Trick honoured this request for a few months before eventually requiring her to work on Saturdays in February 2024, despite the employee requesting religious accommodation, the EEOC claims. The employee was responsible for



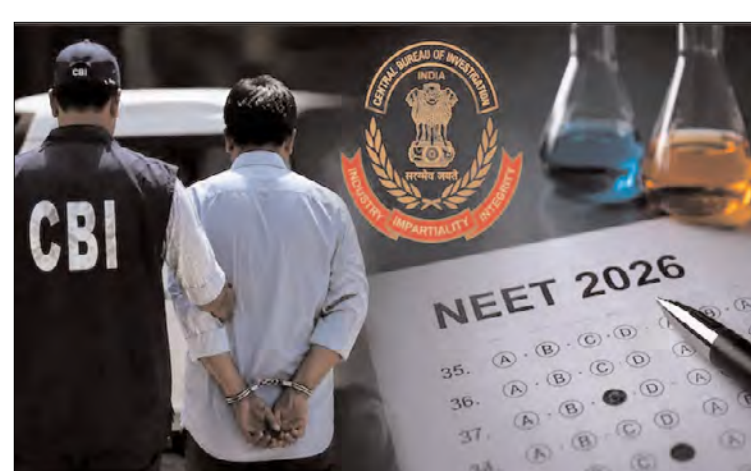
managing the delivery drivers at one of Hatch Trick's Chick-fil-A locations in Austin, Texas. According to court documents filed by the EEOC, the woman was paid hourly and worked 45 to 50 hours per week, Monday through Friday, as well as some additional Sunday hours. When she appealed to management, Hatch Trick allegedly told the employee that it was not possible for her to maintain her managerial role if she did not work on Saturdays. Instead, they told her that she had to accept a delivery driver position, which entailed lower pay,

reduced benefits and hours, the EEOC said. She proposed a number of accommodations that would have allowed her to keep her role, including having a driver work in the dispatch role on her day off and working only after sundown on Saturdays, according to the EEOC complaint. The watchdog agency said the company fired the employee when she refused to accept the driver position. "Religious discrimination in the workplace is unlawful, and employers must make reasonable accommodations for employees' sincerely held beliefs.

WHO IS P V KULKARNI?

CBI Arrests NEET Paper Leak 2026 Mastermind, A Chemistry Professor From Pune

The Central Bureau of Investigation (CBI) on Saturday arrested P.V. Kulkarni, described as the alleged mastermind behind the NEET UG 2026 paper leak, and his associate Manisha Waghmare from Pune. Subsequently, CBI produced them before the Rouse Avenue Court in New Delhi. The arrests mark a significant breakthrough in what is shaping up to be one of the most serious examination fraud cases in India's recent history. The examination was held on May 3 but was cancelled on May 12 due to the leak, and will now be held again on June 21. Around 22 lakh candidates had appeared for the exam. The case first came to light in Rajasthan on May 7. According to the Latur police, some parents had lodged complaints alleging that 42 questions from a mock test conducted by a coaching institute completely matched the questions in the NEET UG exam held on May 3. The CBI subsequently took over and traced the chain of the leak back to its source.



Who Is P.V. Kulkarni? Identified as PV Kulkarni, the accused was linked to the exam process on behalf of the National Testing Agency, which conducted the cancelled test. Officials told PTI that Kulkarni had served on the panel that prepared the NEET question paper for years. The chemistry teacher from Pune retired around four

years ago from a reputed college in Maharashtra's Latur district. Exploiting his privileged access to confidential material, Kulkarni hosted special coaching classes at his house in the last week of April and dictated to his students questions, options and answers which appeared in the NEET UG paper on May 3. The CBI said that during these special classes, the chemistry lec-

turer "dictated the questions with options and correct answers, which students wrote down in their notebooks. These handwritten notes matched exactly with the actual NEET-UG 2026 question paper." The CBI found that co-accused Dhananjay Lokhande had received the paper from Manisha Waghmare and passed it on to Nashik-based Shubham Khairnar, who in turn passed it on to Yash Yadav, who circulated it further. The agency had earlier arrested seven accused persons, including Ms. Waghmare. The others were identified as Dhananjay Lokhande from Ahilyanagar and Shubham Khairnar from Nashik in Maharashtra; Mangilal Biwal, Vikas Biwal, and Dinesh Biwal from Jaipur, Rajasthan; and Yash Yadav from Gurugram, Haryana. Of them, five accused are currently in CBI custody for interrogation. The remaining two are being produced before a court in Pune to secure transit remand for their transfer to Delhi for further proceedings.

Trump warns Taiwan against declaring independence, hours after summit

US President Donald Trump has cautioned Taiwan against formally declaring independence from China. "I'm not looking to have somebody go independent," the US president told Fox News on Friday, at the end of his two-day summit with his Chinese counterpart Xi Jinping in Beijing. Taiwanese President Lai Ching-te has previously stated that Taiwan does not need to declare formal independence because it already sees itself as a sovereign nation. The US has long supported Taiwan, including being bound by law to provide it with a means of self-defence, but has frequently had to square this alliance with maintaining a diplomatic relationship with China. Trump earlier said he had "made no commitment either way" about the self-governing island - which China claims as part of its territory and has not



ruled out taking by force. Washington's established position is that it does not support Taiwanese independence, with continued ties with Beijing being contingent on its acceptance that there is only one Chinese government. Beijing has been vocal in its dislike of Taiwan's president, who it has previously

described as a "troublemaker" and a "destroyer of cross-strait peace". Many Taiwanese consider themselves to be part of a separate nation - though most are in favour of maintaining the status quo in which Taiwan neither declares independence from China nor unites with it. In his interview with Fox News,

Trump reiterated that US policy on the matter had not changed. "You know, we're supposed to travel 9,500 miles (15,289km) to fight a war. I'm not looking for that. I want them to cool down. I want China to cool down." On the flight back to Washington, the US president had told reporters that he and Xi had spoken "a lot"

about the island, but said he had declined to discuss whether the US would defend it. Xi "feels very strongly" about the island and "doesn't want to see a movement for independence", Trump said. "The Taiwan question is the most important issue in China-US relations," Xi warned during the talks, according to Chinese state media, adding: "If mishandled, the two nations could collide or even come into conflict." Asked if he foresaw a conflict with China over Taiwan, Trump had said: "No, I don't think so. I think we'll be fine. [Xi] doesn't want to see a war." China has ramped up military drills around the island in recent years, raising tensions in the region and testing the balance that Washington has struck. Late last year, the Trump administration announced an \$11bn (\$8bn) package of weapons to be sold to

Taiwan, including advanced rocket launchers and a variety of missiles, which Beijing condemned. Trump said he would soon decide whether that sale could go ahead, adding that he and Xi had discussed it "in great detail". He added: "I'm going to say I have to speak to the person that right now is, you know, you know who he is, that's running Taiwan." The US does not have formal relations with Taiwan, though it maintains substantial unofficial relations. US presidents do not traditionally speak directly to Taiwan's leader, and to do so would be likely to cause significant tensions with Beijing, which considers Taiwan's President Lai Ching-te a separatist. Taiwan Deputy Foreign Minister Chen Ming-chi said on Saturday that Taiwan would need to clarify the exact meaning of Trump's remarks.

Rescue diver dies during search for bodies of Italians who drowned in Maldives caves



A rescue diver has died while searching for the bodies of four Italians who died in a scuba-diving accident in the Maldives. Staff Sgt Mohamed Mahdhee was taken to hospital in critical condition and later succumbed to his injuries, a government spokesman told the BBC on Saturday. The five Italians died while attempting to explore caves at a depth of around 50m (164ft). So far, just one of their bodies is thought to have been recovered, in a cave at a depth of around 60m (197ft). The incident is believed to be the worst single diving accident in the tiny Indian Ocean nation, a popular tourist destination because of its

string of coral islands. Maldivian President Mohamed Muizzu travelled to Vaavu Atoll on Saturday to observe the search operations. "Eight rescue divers went into the water today. When they surfaced, they realised Mr Mahdhee didn't come up," Mohamed Hossain Shareef, a Maldivian government spokesman told the BBC. The other divers immediately went into the water again and they found Mahdhee had blacked out. The Maldives military has described the operation as very high risk, with unfavourable weather conditions. Italian Foreign Minister Antonio Tajani sent condolences: "These days of grief for Italy are compounded by the news that one of your brave soldiers... died while attempting to dive to reach the bodies of our fellow Italians." "This tragedy unites Italy and the Maldives in grief and respect for the victims," he added.

NEW OUTBREAK OF EBOLA KILLS 80 IN EASTERN DR CONGO



Africa's top health agency has declared an Ebola outbreak in the Democratic Republic of Congo's eastern Ituri province. Around 246 cases and 80 deaths have been reported, mainly in the gold-mining towns of Mongwalu and Rwampara, said the Africa Centres for Disease Control and Prevention (Africa CDC). Ugandan officials confirmed one case of imported Ebola from DR Congo on Friday, with the country's health ministry stating that a 59-year-old male who died on Thursday had tested positive. Ebola was first discovered in 1976 in what is now DR Congo, and is thought to have spread from bats. This is the 17th outbreak of the deadly viral disease in the country. It is spread through direct contact with bodily fluids and through broken skin, causing severe bleeding and organ failure. Early symptoms include fever, muscle pain, fatigue, headache and sore throat, and are followed by vomiting, diarrhoea, a rash and bleeding. There is no proven cure for Ebola. According to the World Health Organisation (WHO), the average fatality rate is around 50%. Preliminary

tests conducted at the Institut National de Recherche Biomédicale (INRB) in the capital, Kinshasa, have detected the virus in 13 of 20 samples analysed, following consultations with DR Congo's Ministry of Health and National Public Institute. Tests are also being carried out to identify the strain of the virus. Of the 80 deaths, four were reported among lab-confirmed cases, Africa CDC said. Additional suspected cases have also been reported in Ituri's provincial capital, Bunia, with laboratory confirmation pending. Africa CDC said it was concerned by the high risk of further spread due to the urban settings of Rwampara and Bunia, and mining activities in Mongwalu. The health agency's executive director Dr Jean Kaseya added that "significant population movement" between the affected areas and neighbouring countries also meant regional co-ordination was essential. All affected communities and at-risk areas have been advised to follow guidelines from the national health authorities. The Congolese government has not yet officially declared an outbreak.

Man killed by 13ft great white shark in Western Australia



A 38-year-old man has been killed by a 13ft (4m) great white shark in Western Australia. On Saturday, the man was bitten just before 10:00 (03:00 BST) at Horseshoe Reef - north-west of the popular Rottnest Island near the city of Perth, local police said. Aerial footage showed the man being rushed to shore by boat where paramedics and police performed CPR at the Geordie Bay jetty, local media ABC reported. "Sadly

the man was unable to be revived," a police spokesperson said. The state's Department of Primary Industries and Regional Development told AFP news agency it received a report the man was bitten by the great white. The department urged the public to take "additional caution" in waters around the area. The attack is the first fatal incident in Western Australia since March last year.

SENIOR IS LEADER KILLED IN JOINT OPERATION, US AND NIGERIA SAY

Nigeria and the United States say they have killed a senior Islamic State (IS) leader in a joint-operation. Abu-Bilal al-Minuki was described by US President Donald Trump as the "second in command of ISIS globally" and "the most active terrorist in the world". IS has radically shifted in recent years, with around 90% of its attacks now taking place in sub-Saharan Africa. Its Nigeria-based branch is by far the most active. Nigerian President Bola Tinubu said the two countries had carried out a "daring joint operation that dealt a heavy blow" to IS. Al-Minuki was declared a Specially Designated Global Terrorist by Washington in 2023. He was killed along with "several of his lieutenants" during a strike on his compound in the Lake Chad



Basin, a huge region of waterways and swampland shared by Nigeria, Chad, Niger and Cameroon. A military spokesman said intelligence had established Minuki had established a fortified base in the area - in Metele, Borno state. The Lake Chad basin has long been a stronghold for Boko Haram and its rival faction, Islamic State West Africa Province (ISwap). The Nigerian military said the

operation began shortly after midnight on Saturday, after months of intelligence gathering and reconnaissance. It said the operation "zero casualties or loss of assets" were recorded, describing the operation as evidence of growing cooperation between Nigerian and US forces. It said that al-Minuki had been promoted to "Head of General Directorate of States", making him one of the most senior fig-

ures within the global IS hierarchy. He previously oversaw IS-linked operations across the Sahel and West Africa, including attacks targeting civilians and minority communities. The military also linked al-Minuki to the 2018 Dapchi schoolgirls kidnapping when more than 100 girls from a boarding school in north-eastern Nigeria were taken by militant group Boko Haram. Before pledging allegiance to IS in 2015, he was described as a senior Boko Haram commander. Boko Haram began its military campaign to impose Islamic rule in northern Nigeria in 2009. The group pledged its allegiance to IS after what was believed to be the then-leader Abubakar Shekau posted an audio statement on Boko Haram's X account in 2015.

US PLANNING TO CHARGE EX-CUBAN LEADER RAÚL CASTRO

The US justice department is reportedly preparing to indict aging Cuban leader Raúl Castro in the coming days over the shooting down of two aircraft three decades ago. The reported charges, which would need to be approved by a US grand jury, emerged as the director of the CIA travelled to Cuba to meet officials in Havana. Castro, 94, stepped down as Cuban Communist Party leader in 2021, ending his family's more than half a century in power. He led the country for 15 years, stepping in after his brother, Fidel, resigned. The potential indictment is the latest move in a US pressure campaign that has included an oil blockade and widespread sanctions.

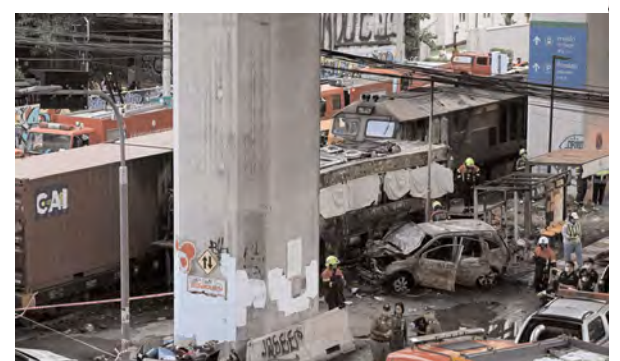


The charges are said to centre on the 1996 downing of two planes operated by the US activist-humanitarian group Brothers to the Rescue. Unnamed US Department of Justice (DoJ) officials told US media the indictment could come as soon as next Wednesday. Asked on Friday

about the reported indictment plan, President Donald Trump told reporters on Air Force One: "I'll let DoJ comment on it." He added: "But [Cubans] need help, as you know. And you talk about a declining country. They are really a nation, a country in decline." Trump has issued an

oil blockade against Cuba, which has exacerbated fuel shortages. This week the island's energy minister acknowledged that Cuba has, in essence, run out of fuel oil. Potential charges against Raúl Castro were unclear, but officials said the investigation centred on an attack on two small planes, which happened on 24 February 1996 while Fidel was president and Raúl was armed forces minister. Four people aboard were killed in the incident. Brothers to the Rescue, a Cuban exile group that searched for rafts carrying migrants from Cuba to the US, had previously dropped anti-Castro leaflets near the Cuban coast.

FREIGHT TRAIN AND BUS CRASH KILLS AT LEAST EIGHT IN BANGKOK



A crash between a freight train and a public bus killed at least eight people and injured dozens of others in Bangkok. Police and rescue officials said the collision triggered a fire that engulfed the public bus on Saturday. Several nearby vehicles were also hit during the incident, prompting firefighters and rescue crews to be dispatched. Teams worked to pull injured victims from the wreckage as fire crews contained the blaze. The fire has been brought under control, with crews now working

to cool the area, vent gas and continue to search for victims. The incident took place near Makkasan train station in the city centre on Saturday afternoon. Deputy Transport Minister Siripong Angkasakulkiat said initial reports suggested the bus had stopped on the tracks amid heavy traffic, preventing crossing barriers from closing. The train carrying containers was not able to stop in time, he added. The full cause of the crash is still under investigation, authorities say.

Switzerland to open secret files on Auschwitz 'Angel of Death' Mengele



The Swiss Federal Intelligence Service has said it will finally open long-sealed files on the notorious Nazi war criminal Josef Mengele, but without saying when. Mengele fled Europe after World War Two, but for years there have been rumours that he spent time in Switzerland, even though an international warrant was out for his arrest. Historians have

repeatedly requested access to the files, but until now the Swiss authorities have refused. Mengele was a doctor who served in Germany's Waffen SS. He was posted to the Auschwitz extermination camp in Nazi-occupied Poland, where he selected those to be sent to the gas chambers - an estimated 1.1 million people died, including about a million Jews.

"Zero Sense": Rituraj Gaikwad Blasted For Big Tactical Blunder, Made Even Before LSG Match Started

Chennai Super Kings' 3-game winning run came to an end against bottom-table Lucknow Super Giants in the Indian Premier League (IPL) 2026 campaign on Friday, putting their playoff qualification at risk. Punjab Kings' slip-up had opened the door for CSK to go fourth in the points table, but they couldn't capitalise on the opportunity. After the game, former Chennai batter Subramaniam Badrinath tore into skipper Rituraj Gaikwad for his 'tactical blunder' that played a role in the team's defeat against Lucknow. Rituraj himself blamed the bowling unit for the below-par show against LSG, after the batters took them to a challenging total of 187/5 on a tricky wicket. Lucknow chased down the total in just 16.4 overs. "CSK losing because of team selection errors is becoming a pattern this season. Leaving out Akeal Hosen on this track made zero sense. Another game, another missed opportunity," Badrinath said on X

Bryson DeChambeau's exit drew the sharpest clubhouse reaction after the two-time US Open champion failed to recover from a disastrous opening round. Tommy Fleetwood, Viktor Hovland and Robert MacIntyre also slipped out of



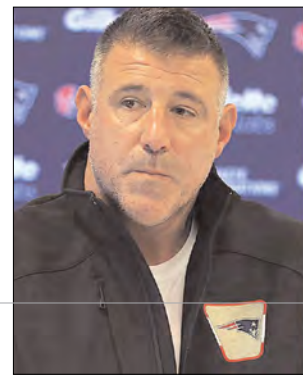

Virat Kohli's ODI World Cup Ultimatum Leaves BCCI In A Tight Spot

When a sporting icon like Virat Kohli has to justify his worth, we know that everything isn't right when it comes to his relationship with the coaches, the management or the board. Kohli has never been one to speak in half-measures, but his remarks regarding his future in One Day

Internationals are bound to force even the Board of Control for Cricket in India (BCCI) to think about the road forward for the 2027 ODI World Cup. Speaking candidly on the Royal Challengers Bengaluru podcast, Kohli addressed the relentless speculation surrounding his participation in the 2027 ICC ODI World Cup. In doing so, he sent a clear message straight to the BCCI bosses, the management and selectors. "Either tell me on day one I am not good enough or I am not needed. But if I am made to feel like I need to constantly prove my worth and my value, then I am not in that space," were Kohli's comments in the podcast, as he made it clear that he is in no mood to prove himself again,

especially at this stage of his career. If pushed, he hinted at moving on from "this space". For a player who has redefined modern cricket's fitness and run-scoring benchmarks, the statement is a fierce defence of his legacy. For the BCCI and the national selection committee, however, it complicates an already intricate relationship. The Complexities Of One-Format Following his T20 international retirement after India's 2024 World Cup triumph and his subsequent departure from Test cricket, Kohli's international career is now exclusively reserved for the 50-over format. With ODIs increasingly squeezed out of the global calendar, the lack of consistent game time naturally demands a debate about Kohli's continuity in interna-

tional cricket, especially at the age of 37. Yet, Kohli's counter-argument shifts the burden of proof entirely onto the management. By stressing that his year-round, elite lifestyle ensures he can "run boundary to boundary for 40 overs without complaint," Kohli is making it clear that any attempt to drop or phase him out cannot be masked as a "fitness" or "workload" decision. Last year, Kohli scored 651 runs in the ODI format at an average of 65.1, while also recording three centuries. This year, he already has a hundred to his name in one-day cricket. Abbavaram. He also knew me as an artist. Even at that time, he had a fan following. He mastered every craft and reached this stage through hard work.

NO FEAR ANYMORE...

- In these ten years of experience, I lost my fear of the camera. I learned how to perform in front of it. Theatre drama taught me dialogue delivery and diction. In one play, I performed five different roles continuously for one and a half hours. Director Muniraju used to explain every scene in great detail. The workshop helped us immensely.

EVERY CHARACTER CREATES AN IMPACT...

- I liked many performances in the movie, including those by Sai Tej and Lathesh. Most of the actors performed in single takes. Every character in the film creates an impact.

A MEMORABLE MOMENT...

- No one in my family knew that I was involved in acting. Only my sister knew a little about it. Without informing my parents, my sister brought them to the shooting location. Seeing my parents there, and them seeing me acting like that, was truly a memorable moment.
