IVANKA TRUMP TARGETTED BY TERRORIST TRAINED BY IRGC: REPORT

Washington : Ivanka Trump, daughter of US President Donald Trump, was allegedly targeted by a terrorist trained by the Islamic Revolutionary Guard Corps (IRGC), determined to avenge the killing of General Qasem Soleimani, eliminated by the United States in a raid in Baghdad in January 2020. The New York Post reported that the 32-year-old Iraqi Mohammad Bager Saad Dawood Al-Saadi allegedly "swore" to kill Ivanka and managed to obtain a floor plan of her Florida residence. According to sources cited by the newspaper, Al-Saadi reportedly said that "killing Ivanka would mean burning Trump's house as he burned ours."

Telangana cabinet approves 2.5 lac indiramma houses

MAJOR WELFARE AND DEVELOPMENT DECISIONS

HYDERABAD TSIT BUREAU

The Telangana Cabinet on Friday approved several major welfare and development decisions, including construction of 2.5 lakh Indiramma Housing Scheme houses under the second phase for poor families across the state.

The government decided to sanction 2,000 houses in every Assembly constituency. It also approved financial assistance to complete unfinished Indiramma houses started during the previous Congress regime in united Andhra Pradesh. Houses with only foundations completed will receive Rs. 3 lakh assistance, while houses with completed walls but unfinished slabs will get Rs. 2 lakh.

The Cabinet announced that nearly one lakh houses from the first phase are expected to be ready for housewarming ceremonies by June 2. It also approved construction of one lakh LIG houses in 24 constituencies under the Hyderabad Metropolitan CURE region.

Reddy and Deputy Chief Minister Mallu Bhatti Vikramarka are expected to participate in the inauguration of 28 newly built houses for Kolam tribal families in Kumuram Bheem Asifabad district on June 1. The Cabinet further approved Rs. 1,000 crore for development works related to the upcoming Godavari Pushkaralu, including immediate release of Rs. 300 crore in the

first phase. In the education sector, the government approved implementation of midday meals in junior colleges and decided to provide breakfast and milk to students in government schools and colleges.

The Cabinet also cleared proposals for strengthening power distribution infrastructure under the Centre's RDSS scheme and sanctioned Rs. 587 crore for land acquisition and rehabilita-

tion related to the Palamuru-Rangareddy Lift Irrigation Scheme. In a major industrial push, the Cabinet approved the Next Generation Life Sciences Policy 2026-30 aiming to make Telangana one of the world's top five life sciences hubs by 2030. The policy targets investments worth 25 billion US dollars and creation of five lakh jobs in pharma, biotech and medical innovation sectors.

CM Naidu launches sanjeevani healthcare programme in Chittoor

Yadamarri (TSIT):

Andhra Pradesh Chief Minister Nara Chandrababu Naidu said the government aims to provide comprehensive healthcare services to people through the Sanjeevani programme and develop Rayalaseema into a global horticulture hub.

The Chief Minister participated in the Sanjeevani programme at Kandriga village in Yadamarri mandal of Chittoor district along with District In-charge Minister Ram Prasad, MP Duggimalla Prasad Rao, Puthalapattu MLA Murali, District Collector Sumit Kumar and Tata Group CEO Girish Krishnamurthy.

Speaking on the occasion, Chandrababu Naidu said the government is implementing the Sanjeevani programme under a Predictive, Preventive and Curative healthcare model with the philosophy that "Health is the Greatest Wealth."

He announced that the programme, launched as a pilot



Doctor system for every family. The government is providing health insurance coverage of up to Rs. 2.5 lakh for every citizen, while assistance up to Rs. 25 lakh will be extended through NTR Vaidya Seva and the Chief Minister's Relief Fund in special cases.

Chandrababu Naidu urged people to adopt healthy lifestyles through proper nutrition, exercise, yoga and meditation under the concept of "Food as Medicine, Kitchen as Pharmacy."

Highlighting regional development plans, he said irrigation projects including Handri-Neva, Galeru-Nagari and the Somasila-Swarnamukhi Link Canal would be completed to make Rayalaseema green and prosperous.

The Chief Minister added that the government is promoting industries, data centres, drone cities, aerospace hubs and food processing sectors in Rayalaseema and aims to develop the region into a world-class horticulture centre.

Bengal govt cuts Bakrid holiday to one day from earlier two-day break

KOLKATA (TSIT):

The West Bengal government on Saturday issued a notification declaring May 28 as the Id-Ud-Zoha (Bakrid) holiday this year, cancelling the earlier notification issued under



the previous Mamata Banerjee-led regime that had declared a two-day holiday on May 26 and May 27. In terms of Notification No. 4188-F(P2) dated 27 November, 2025, 26 May, 2026 (Tuesday) and 27 May, 2026 (Wednesday) were declared as public holidays on account of the Day before Id-Ud-Zoha (Bakrid) and Id-Ud-Zoha (Bakrid) respectively. Now, information has been received that Id-Ud-Zoha (Bakrid) will be observed on 28 May, 2026 (Thursday).

No power can stop India from being biggest exporter of weapons in 25-30 years: Rajnath

SHIRDI (AHLIYANAGAR) (TSIT):

Signalling a major shift in India's defence manufacturing strategy, Defence Minister Rajnath Singh on Saturday said the private sector is no longer merely a supplier of "nuts and bolts" to the armed forces, but has evolved into an innovator and producer of advanced weapon systems, as the government seeks to transform India into a global hub for munitions and automated warfare systems. Addressing a gathering after inaugurating the state-of-the-art defence and aerospace innovation and production facilities of Nibe Limited in the temple town of Shirdi, Singh said the Centre aims to increase private sector participation in defence manufacturing from the current 25-30 per cent to nearly 50 per cent in the coming years.

"Earlier, the role of the private sector in defence production was negligible. Today, it has reached almost 25 to 30 per cent. We want to scale it up to 50 per cent," the Defence Minister said.



The remarks come amid the government's broader push for indigenisation and self-reliance in strategic sectors under the Atmanirbhar Bharat initiative, particularly in the backdrop of lessons drawn from the Russia-Ukraine conflict and rising geopolitical instability in West Asia, which have highlighted the importance of domestic defence manufacturing capacity and resilient supply chains.

"Our government is continuously emphasising that Make in India should be promoted in critical technologies and advanced systems. To ensure India emerges as a frontrunner in munitions and automated systems, the government is ready to take every necessary

step," Singh said.

Lauding the role of Indian industries, he said the country's private sector had developed a strong understanding of future warfare technologies and was increasingly contributing to next-generation defence capabilities. "To make India a hub for munitions and automation, everyone will have to work together. Only when the capabilities of Indian defence companies increase will the country's security framework become even stronger," he said.

Calling for complete self-reliance in defence and space technologies, Singh said: "Self-reliant India means a secure India, a capable India and a powerful India."

TN CM Vijay plans Delhi visit with political outreach, economic demands on agenda



CHENNAI (TSIT):

Tamil Nadu Chief Minister C. Joseph Vijay is preparing for a significant visit to New Delhi, one expected to carry both political and administrative importance. Unlike his previous trip to the national capital as a party leader for questioning in connection with the Karur crowd-tragedy case,

Vijay is now set to arrive in Delhi as the head of the Tamil Nadu government with an agenda focused on strengthening political ties and seeking financial support for the state.

Vijay had earlier appeared before the CBI in New Delhi on January 12 and January 19 in connection with investigations linked to the stampede at a public meeting held in Karur on September 27 last year, in which 41 people lost their lives. This time, however, the focus of the visit is expected to be entirely different. Sources indicate that Vijay plans to hold meetings with Prime Minister Narendra Modi, Union Home Minister Amit Shah, and senior Congress leaders, including Sonia Gandhi, Rahul Gandhi, and Congress president Mallikarjun Kharge.

NEW DELHI (TSIT)

Global oil prices climbed on the last day of trading week after Iran cast doubt on market hopes for a near-term agreement with the United States. Brent crude rose 0.94 per cent to \$103.5 per barrel, while US benchmark WTI gained 0.26 per cent to \$96.60 a barrel, reversing part of Thursday's selloff losses that had pushed both benchmarks to their lowest in nearly two weeks.

Iran's Foreign Ministry spokesperson said Tehran could not say an agreement with Washington was close, according to state-linked Tasnim news agency.

US Secretary of State Marco Rubio said there were "some good signs", while stressing that any Iranian attempt to

restrict movement through the Strait of Hormuz would remain a red line. The comments followed days of mixed messaging from both sides, while markets rallied on optimistic headlines, and then waited to ascertain if any-



thing actually changed on ground. Traders have grown wary of pricing in news of diplomatic breakthroughs without clear evidence, analysts said. Physical oil markets remain tight, inventories are falling and elevated fuel prices

are feeding broader inflation concerns, they added.

Petrol and diesel prices were raised on Saturday by state-owned oil marketing companies, marking the third such increase in about 10 days.

Petrol became costlier by Rs

0.87 per litre, while diesel prices were raised by Rs 0.91 per litre. There is no shortage of petrol, diesel or LPG in the country and petrol pumps that are not giving fuel or giving fuel in reduced quantities are being pulled up, senior government officials said.

The government is receiving feedback about petrol pumps across India and full supply of fuels is being maintained to all retail outlets. About 50 per cent of India's crude and almost 90 per cent of its LPG and LNG imports pass through Hormuz, making it India's single biggest energy vulnerability. Since the closure of the Strait of Hormuz, India has been sourcing 70 per cent of its crude imports via alternative, longer sea routes across the Arctic and the Baltic region.

Telangana Police Forms AI Tech Team for Smart Policing



Hyderabad TSIT: Telangana DGP C.V. Anand has announced the formation of a dedicated 'Tech Team' at the DGP Office to promote Artificial Intelligence (AI) and advanced technology in policing across the state.

A special AI Task Force will monitor all AI-related projects, including CCTNS 2.0, video analytics, drone technology, data intelligence and smart dashboards.

A five-member IPS core team has been formed to implement the projects within six months. Senior officials including DG (Technical Services) V.V. Srinivasa Rao and Hyderabad Joint CP N. Swetha attended the meeting.

Chandrababu Has Nothing to Show, Resorting to Empty Rhetoric: Opposition Leader Botsa Satyanarayana

● “Super Six Super Hit” is a Complete Lie ● We Will Continue to Question Government Failures: Botsa Satyanarayana

Visakhapatnam (TSIT): Leader of Opposition in the Legislative Council Botsa Satyanarayana alleged that even after completing two years in power, Chief Minister N. Chandrababu Naidu has nothing substantial to showcase and is spending time delivering empty speeches. He said Chandrababu's speech at the recent public meeting in Puthalapattu itself reflected the government's failures. Botsa Satyanarayana addressed the media at his campoffice in Visakhapatnam along with former minister Gudivada Amarnath, former MLA Karaman Dharmasri, and district party president KK Raju. On the occasion, he listed out what he termed as the failures and irregularities of the Chandrababu-led government during the last two years.

Speaking further, Botsa



Satyanarayana said Chandrababu, instead of speaking about the welfare initiatives undertaken by the government, was focusing on attacking opposition leaders in public meetings. He stated that the people of Andhra Pradesh were fully aware of Chandrababu's "manage-

ment and manipulation of systems." He alleged that despite serving four terms as Chief Minister, Chandrababu repeatedly deceived people by making promises during elections and failing to fulfil them after coming to power. Botsa questioned whether the promises made under the

"Super Six" scheme had actually been implemented. He asked whether the government had delivered the promised "Aadabidda Nidhi," unemployment allowance, and free gas cylinders to women. He also criticized the government for failing to control rising prices of essential commodities and questioned whether any section of society was truly satisfied under the current administration.

Referring to the COVID period, Botsa said former Chief Minister Y. S. Jagan Mohan Reddy had supported people during the crisis and ensured welfare measures reached the poor. He alleged that the current government was neglecting welfare schemes while focusing only on publicity and tours. Botsa also raised questions over the removal of the DSC merit list and demanded clarification from the government. He

alleged irregularities in the recruitment process and criticized the Education Department for failing to provide textbooks and kits to students on time. He accused Education Minister Nara Lokesh of speaking more about departments other than his own. Accusing the government of lacking transparency, Botsa alleged corruption and favoritism in several sectors. He claimed there was rampant corruption in Amaravati construction works and criticized the government for failing to deliver meaningful benefits to farmers, students, employees, and the poor. Botsa Satyanarayana asserted that the YSRCP would continue to question the failures, corruption, and irregularities of the government and would intensify public movements if necessary.

PROPERTY WORTH RS.1.04 CRORE RECOVERED AT RECOVERY MELA

51 Cases Detected – 60 Accused Arrested – 473 Mobile Phones Recovered

The South India Times, Visakhapatnam : Speaking to the media at the Recovery Mela conducted at the Visakhapatnam Police Commissionerate on Saturday, City Police Commissioner Dr. Shankhabrata Bagchi stated that Visakhapatnam Police achieved significant results in property offence cases registered in the city during April-2026. He said that a total of 68 property offence cases of various categories were registered, out of which 51 cases were detected and stolen property worth Rs.1,04,62,906 was recovered. He stated that special teams were formed and investigations were carried out from all angles using technical evidence. Under the supervision of the DCP (Crimes), a total of 60 accused persons were arrested, he added.

The recovered stolen property includes 924 grams of gold, 4.5 kilograms of silver, cash worth Rs.3.12 lakh, 12 motorcycles, 3



autos, 476 mobile phones, and 270 kilograms of copper wires. Out of these, 473 mobile phones were related to missing mobile cases, he said. The detected cases include 2 robbery cases, 3 daytime house burglary cases, 10 night house burglary cases, 1 chain-snatching case, 12 bike theft cases, 3 auto theft cases, and 20 general theft cases, he explained. As part of crime prevention measures, 502 CCTV

cameras were installed in various parts of the city during April, and 190 awareness meetings were conducted to educate the public about precautions against crimes and the importance of CCTV cameras, the Commissioner said. He further stated that special patrolling was being conducted in crime-prone areas and surveillance was being continued through drone beats.

No Compromise on Protection of Dalit Rights: SC Commission Member R. Seetharam

The South India Times, Visakhapatnam : Providing constitutional rights to Dalits is the responsibility of government institutions, stated State SC Commission Member R. Seetharam. On Saturday, he visited the VMRDA office and conducted a review meeting with officials. Speaking on the occasion, he suggested that adequate opportunities should be provided to SC communities in contract and outsourcing appointments in government offices and institutions like VMRDA. No overall shortage of petrol, diesel in country: Indian Oil Corporation

New Delhi, May 23 : There is no overall shortage of petrol and diesel in the country and outages reported at some retail outlets are "highly localised" and temporary, Indian Oil Corporation (IOC) said on Saturday.

These small outages are caused by regional demand-supply mismatches and shifting sales patterns, the IOC said in a statement. The company is closely monitoring the situation and taking adequate measures to address these isolated situations and ensure uninterrupted fuel supplies to consumers.

"We wish to reassure customers and the general public that there is no overall shortage of petrol and diesel in the country.

The current situation being witnessed at certain retail outlets is highly localised and temporary in nature, arising due to local demand-supply imbalances and redistribution of sales patterns in select areas," according to the statement.

Higher demand at certain retail outlets was caused by a seasonal rise in diesel consumption during the harvesting season, migration of customers from private pumps where retail prices were relatively higher, and increased institutional purchases at public sector outlets.

Only a very small number of outlets in its network of more than 42,000 fuel stations had witnessed supply disruptions, while



stocks and supplies at the majority of pumps remained normal and adequate, said IOC.

State-owned oil marketing

firms continued to maintain sufficient fuel inventories nationwide and were taking steps to address isolated disruptions and

ensure uninterrupted supplies. "Despite this sustained and exceptionally high growth in demand, IndianOil continues to consistently meet customer requirements across the country," it added. Earlier in the day, petrol and diesel prices were increased, marking the third revision in retail fuel rates in just 10 days. Petrol became costlier by Rs 0.87 per litre, while diesel prices were raised by Rs 0.91 per litre by state-owned oil marketing companies. The latest hike comes amid sustained pressure from rising global crude oil prices and ongoing geopolitical tensions in West Asia, which continue to impact international energy markets.

MEDICOVER DOCTORS SAVE STROKE PATIENT WITH RARE BRAIN PROCEDURE



Hyderabad, 23 May, 2026: Medicovert Hospitals, Hyderabad, announced the successful treatment of a 54-year-old patient from Andhra Pradesh who was suffering from recurrent posterior circulation strokes caused by a near-total blockage of the Basilar Artery — one of the brain's most critical blood vessels responsible for supplying blood to the brainstem and posterior brain regions.

The patient was admitted with progressive neurological symptoms including inability to speak and swallow, severe giddiness, imbalance while walking, and inability to walk without support. Despite being on continuous medical treatment, he had suffered multiple recurrent strokes over the past few months. He was also a known case of hypertension, Type 2 diabetes mellitus, coronary artery disease, and had previously undergone CABG surgery and angioplasty.

Advanced neurovascular imaging and diagnostic cerebral angiography (DSA) performed at Medicovert Hospitals revealed approximately 99% (critical) stenosis of the Basilar Artery — an extremely dangerous condition associated with a very high risk of major brainstem stroke, paralysis, coma, and sudden death. Considering

the repeated strokes despite optimal medical therapy, the multidisciplinary Neuro Sciences team proceeded with a highly specialized endovascular intervention. On March 17, 2026, the team successfully performed a technically challenging Basilar Artery Stenting procedure, restoring blood flow to the affected region of the brain. The procedure was led by Dr. Annappureddy Jagadish, Consultant Stroke and Interventional Neurologist, along with Dr. Kamepalli Hari Kishore, Consultant Neuro and Interventional Radiologist, supported by the Interventional Radiology, Neurocritical Care, and Rehabilitation teams.

Following the intervention, the patient showed steady neurological recovery with rehabilitation and physiotherapy support and was discharged in stable condition. Speaking on the occasion, Dr. Annappureddy Jagadish said, "Basilar artery stenosis is among the most life-threatening forms of stroke disease because it affects the brainstem, which controls breathing, consciousness, balance, swallowing, speech, and other vital neurological functions. In patients with recurrent strokes despite medication, timely neuro-intervention can become lifesaving."

Transparent and Intensive Revision of Electoral Rolls to be Conducted: Collector Abhishek Kishore

The South India Times Visakhapatnam : District Collector M. Abhishek Kishore directed officials to conduct the Special Intensive Revision (SIR) of electoral rolls in the district in a transparent and systematic manner. He reviewed the arrangements during a meeting held with election officials, Sub-Collectors and RDOs at the Collectorate on Saturday. The Collector instructed Booth Level Officers (BLOs) to conduct door-to-door verification and collect voter details from June 15 to July 14. He said BLOs must personally visit households, distribute enumeration forms and complete the prescribed procedures. Officials were also asked to clearly inform voters that their names would not be included in the electoral



rolls if the signed enumeration forms were not submitted back to the BLOs.

Stating that every Indian citizen above 18 years of age is eligible to register as a voter, the Collector said new voters should submit Form-6 along with the prescribed declaration form. He directed officials to improve the quality of electoral rolls by identifying and removing duplicate entries, deceased vot-

ers and permanently migrated persons. However, he clarified that no voter's name should be deleted without proper inquiry and without giving the concerned person an opportunity to respond. To accurately assess field-level changes, officials were instructed to compare the 2002 Intensive Revision electoral rolls with the present voter list. The Collector also appealed to political parties to coop-

erate in the revision process and appoint Booth Level Agents (BLAs) for every polling station. As per the official schedule, training for election staff will be conducted from June 5 to June 14, while the door-to-door survey will take place from June 15 to July 14. The draft electoral rolls will be published on July 21, and claims and objections will be accepted from July 21 to August 20. The final electoral rolls will be published on September 22, the Collector informed. GVMC Commissioner Ketan Garg, Joint Collector Gobbilla Vidyadhari, DRO M. Visweswara Naidu, RDOs Sessa Sailaja and Sangeet Madhur, Deputy Collector Govind, Election DT Murthy, zonal special officers, zonal commissioners and other officials participated in the meeting.

US-India Relations: Can Marco Rubio Fix It?

In the two-tiered Washington that is the second administration of US President Donald Trump, the top tier makes non-stop trouble, and the second tries to fix it. Marco Rubio, secretary of state and national security advisor, has arrived in India on his first visit as "Mr Fix It." He will attempt to calm Indian nerves and restore a sense that India (still) matters for a myriad geopolitical reasons even if it hasn't felt that way for one long year. On the side, he will talk business. Selling more US and Venezuelan oil for an India caught in a serious energy crisis caused by Trump's war against Iran is on his agenda.

The job of select cabinet members is to recreate old friendly feelings, re-package the past and re-sell a future in Trumpian terms. They recognize the need for allies and partners even if their leader doesn't seem to - only fellow bullies and field marshals get serious presidential attention.

It is in this spirit of repair and maintenance that Rubio's May 23-26 visit should be seen that takes him to Kolkata, Jaipur, Agra and Delhi. He will find that Indian diplomats have shed sentimentality in the year of living dangerously with Trump. The soft frame has changed - it's all hardcore. No lofty messaging, no unrealistic promises and no fuzzy expectations from Delhi. Can Rubio soften the edges and restore greater confidence?

The secretary did quite a job of reassuring the Europeans after Vice President J.D. Vance had berated them at the same venue a year earlier for suppression of free speech and untamed immigration. Rubio may have charmed Europe and celebrated colonialism, empires and missionaries but he raised eyebrows in more than half the world that was colonised. His efforts in India will, no doubt, be more refined because he can be skillful with words. Because Rubio wears two important hats and spends more time in the White House than any other cabinet member as a result, the conversations in Delhi will be real and substantive. Topics include defence cooperation, trade, the Iran war, the energy crisis, Pakistan, China, and the Quad even if Trump shows no interest in the grouping.

Rubio will attend a Quad foreign ministers' meeting with his counterparts - S. Jaishankar, Penny Wong of Australia and Toshimitsu Motegi of Japan - on his last day. To show the group is important, he is sure to recall the fact that his first official engagement after being sworn in as secretary of state was to convene Quad ministers who happened to be in DC for Trump's inauguration. That said, the failure of Quad to convene at the leaders' level does raise questions, especially in light of Trump's overly accommodative stance towards China. The main strategic purpose behind Quad's revival during the first Trump administration was to build a defensive fence of democracies around China and create options for smaller Asian countries. That purpose - never explicitly stated but consistently implied - has been obscured somewhat by the recent US-China summit where Trump and Chinese President Xi Jinping announced the start of a "constructive relationship of strategic stability."

The growing market takeover of public health

The challenge of providing health services to rural and poor India

In a vast and diverse country like India, public health is not just a question of medical care, but also a matter of social justice, economic equality, and democratic accountability. A nation's progress is measured by the health status of its citizens. If large segments of society are deprived of treatment, medicines, nutrition, and primary health care, claims of economic development prove hollow. Unfortunately, over the past few decades, the health sector has been rapidly commercialized in many countries around the world, including India. Healthcare, which should have been fundamentally a human right, has gradually transformed into a profit-making industry. Private hospitals, expensive medicines, insurance-based treatments, and corporate medical systems have alienated ordinary citizens, especially the poor and rural communities, from healthcare. At this juncture, the role of the Indian state becomes crucial to strengthen the public health system and ensure its access to the grassroots.

The biggest problem in India's healthcare sector is inequality. While metropolitan cities have state-of-the-art hospitals and super-specialty facilities, even primary health centers in remote rural areas lack adequate doctors, medicines, and equipment. According to the World Health Organization, the availability and accessibility of healthcare is a primary responsibility of any democratic state. However, in India, millions of people are unable to access treatment solely due to financial constraints. The cost of private hospitals is so



high that a serious illness can push an entire family into poverty. National Health Accounts reports indicate that out-of-pocket expenditure on healthcare in India remains very high. This means that people have to pay a significant portion of their treatment costs out of their own pockets. This is the most dangerous consequence of marketization. To expand public health services, the state must first strengthen the primary health care system. Primary Health Centers (PHCs) and Community Health Centers (CHCs) are considered the backbone of the health system in India's villages and small towns. However, most centers face problems such as a shortage of doctors, lack of medicines, poor buildings, and inadequate equipment. The government should substantially increase the health budget and equip these institutions with modern facilities. Every primary health center should be mandated to have a regular doctor, trained nurses, lab facilities, and essential medicines. If primary health care becomes easier to diagnose and treat, it will reduce pressure on large hospitals and prevent poor people from migrating to cities. Additionally, decentralization of

health services is essential. Relying solely on district hospitals poses significant challenges for people in remote areas. State governments should expand health services down to the Panchayat level. Strengthening ASHA workers, Anganwadi services, and community health volunteers can promote health awareness and primary care in rural areas. The COVID-19 pandemic has highlighted the crucial role of locally trained health workers. If these workers are provided with better training, respectable salaries, and resources, they can play a significant role in delivering health services to every household. The use of technology in the health sector can also be an effective means of increasing access at the grassroots level. Systems like telemedicine, mobile health units, and digital health records can help provide specialized services in remote areas. India has many villages where specialist doctors are difficult to reach. Online consultations and digital diagnostic services can play a vital role in such areas. However, technology must be developed as a complementary medium, not a substitute for human contact. Digital health services require the presence

of local health workers so that even people with low literacy can benefit from these services. Affordable and universal drug availability is also an essential aspect of public health expansion. Drug prices in the private market are constantly rising. The state should expand Jan Aushadhi Kendras and effectively implement the price-control policy for essential medicines. Availability of free or very affordable medicines for the poor and lower middle class can play a significant role in reducing health inequalities. Essential diagnostic facilities and medicines should also be made available free of charge in government hospitals so that people do not have to rely on private laboratories and medical stores. Lack of human resources is also a major challenge for expanding healthcare services in India. Rural areas face a severe shortage of doctors and specialists, as most physicians prefer to work in urban areas. To address this problem, the government should develop policies that encourage rural service. Making rural service mandatory for medical students, providing better salaries, housing, and security facilities, and providing opportunities for local

youth in medical education could be useful steps. Training doctors and health workers from the local community in rural areas would enhance both the sustainability and reliability of healthcare services. Preventive health care must also be prioritized in the public health sector. India's health system still focuses heavily on post-disease treatment, while investment in areas such as sanitation, nutrition, vaccination, and health education remains relatively low. If states strengthen programs such as clean drinking water, nutrition programs, mental health awareness, and regular health checkups, many diseases can be prevented at an early stage. This will not only improve public health but also reduce the financial burden on the health system. The state must also play an active role in regulating the private health sector. Exorbitant fees, unnecessary testing, and commercial exploitation by private hospitals have become commonplace. Patients' helplessness is often exploited as a means to profit. The government must develop a robust regulatory framework that monitors treatment fees, drug prices, and medical ethics. Leaving healthcare solely to the market would be an abdication of the democratic state's responsibility. It is also important to increase the effectiveness of health insurance schemes. Schemes like Ayushman Bharat have provided relief to poor families, but a large number of people remain outside their reach. Insurance schemes often limit hospital-based treatment to primary health services, and primary health services are underserved. The state must ensure that health insurance schemes cover not only treatment but also prevention, nutrition, and primary care. Additionally, public-private partnerships in the health sector must be balanced and transparent. While leveraging private sector expertise and resources can be beneficial, public interest must remain paramount. If profit-making becomes the primary objective, the poor and vulnerable will once again be marginalized.

New Study Links Daily Almond Consumption to Better Brain and Metabolic Health in Adults with Prediabetes

Research by Dr. Anoop Misra and Dr. Seema Gulati, published in the Journal of Nutrition, found improvements in executive function, blood sugar levels, and body composition after 24 weeks of daily almond consumption. New research published in the Journal of Nutrition indicates that a simple dietary change - eating just a few almonds each day - may benefit cognitive performance, metabolic health, and markers for inflammation and oxidative stress in middle-aged Asian Indian adults with prediabetes. Prediabetes affects more than 600 million people worldwide and is linked not only to an increased risk of type 2 diabetes but also to impaired brain function. In the 24-week study conducted in New Delhi, 60 Asian Indian adults aged 40 to 60 with prediabetes but no signs of cognitive decline were randomly assigned to either a control or intervention group after receiving guidance on following a balanced diet consistent with dietary guidelines for Asian Indians. While the control group continued with the same diet, the intervention group consumed a calorie-matched diet that included almonds, with almonds accounting for 20% of daily calories, equivalent to around 32-42g per day. Participants were monitored remotely twice a week and attended in-person visits every four weeks. Researchers assessed cognitive performance, blood glucose levels, HbA1c, blood



lipids, weight, BMI and waist circumference at the beginning and end of the study. At the end of the study, participants in the almond group experienced improvements in executive function and processing speed, both key measures of cognitive performance. The group also demonstrated better blood sugar control, including lower fasting blood glucose, lower blood glucose levels two hours after eating, and improvements in HbA1c, a marker of long-term blood sugar control. Additional metabolic benefits included significant reductions in body weight, body fat, BMI, waist circumference, total cholesterol and LDL cholesterol.

Participants consuming almonds also showed improvements in markers related to inflammation and oxidative stress. Previous studies by the same researchers found almonds helped improve blood glucose control and body composition in Asian Indians with prediabetes and type 2 diabetes. This study was the first to explore the potential impact of almonds on cognitive performance in middle-aged Asian Indian adults with prediabetes, a population particularly vulnerable to both metabolic disease and cognitive decline. Dr. Anoop Misra, co-investigator and Chairman, Fortis-CDOC Center of

Excellence for Diabetes, Metabolic Diseases, and Endocrinology in New Delhi, believes the findings from this exploratory study have the potential to support better brain health in millions of people around the world. "Adults with prediabetes are vulnerable to a decline in cognitive function," he says. "Our study indicates that just one simple dietary change - adding a small quantity of almonds to the daily diet - may help support brain health and improve cognitive performance in some populations." But almonds offer other health benefits as well. "As with our previous research, we found that diets enriched with almonds benefit metabolic health measures like blood sugar control and body weight," confirms Dr. Misra. "Together, these changes could help lower the risk of prediabetes progressing to type 2 diabetes, a condition associated with an increased risk of dementia." Discussing the findings, Ritika Samaddar said, "With the growing issue of prediabetes and lifestyle-related health concerns, it is encouraging to see research highlighting how a simple dietary addition like almonds may support both metabolic and cognitive health. The findings showing improvements in cognitive function, blood sugar control, body weight, and cholesterol levels reinforce the role of almonds as a superfood.

Rubio Is In India, But Trump's America Just Launched Its Sharpest Attack On Indian Immigrants

As US Secretary of State Marco Rubio arrives in India for the Quad meeting and strategic consultations, the Trump administration is preparing one of the sharpest reversals of long-standing American immigration policy in decades. At the centre of this shift is a new USCIS approach that seeks to restrict adjustment of status inside the United States and push many legal immigrants to complete green card processing from abroad. This is not merely an administrative change. It overturns the logic Congress itself built into the American immigration system. For decades, US law allowed legally admitted migrants to transition from temporary visas to permanent residency while remaining inside the country. Congress deliberately created categories such as the H-1B visa around the idea of "dual intent", where skilled workers could arrive temporarily while eventually seeking permanent settlement. That framework helped build modern American technological dominance. Indian engineers, doctors, researchers, entrepreneurs and students became central to the US economy under exactly this system. Silicon Valley, American hospitals, research universities and technology firms absorbed Indian talent at every level. Now, that same pipeline is being politically targeted. The implications for Indians are enormous because Indians dominate many high-skilled visa categories and already face massive green card backlogs unique to their nationality. Thousands of



Indian professionals who spent years following American laws, paying taxes and building lives in the US may now face the prospect of leaving the country during processing with no certainty of return timelines. Families could be split across continents. Careers built over decades could collapse overnight. Children raised in the United States may suddenly face instability because their parents entered a system whose rules are now being rewritten midway. This marks a major transformation in American politics. The Trump movement no longer limits immigration politics to illegal border crossings. Legal immigration itself is increasingly becoming the target. Student visas, employment-based migration, family sponsorship and status adjustment are now all drawn into the same political battle. Indians sit directly in the firing line because they represent one of the most visible

and successful immigrant communities in America's high-skilled sectors. The racial undercurrents have become increasingly difficult to ignore. Across sections of the MAGA ecosystem, Indian professionals are routinely portrayed as people "taking over tech", replacing American workers or changing the cultural balance of the country. Social media platforms are flooded with openly hostile narratives directed specifically at Indian migrants and Indian-Americans. The striking aspect is that many of these migrants represent exactly the profile American conservatives once claimed to support: educated, economically productive, low-crime and legally compliant. The hostility has, therefore, moved beyond questions of legality. It increasingly reflects demographic anxiety and identity politics. Bots, outrage algorithms and coordinated information war-

fare networks amplify this sentiment daily. Immigration outrage generates clicks, political engagement and emotional mobilisation. Complex immigration law gets reduced into viral slogans designed to trigger resentment. The result is a digital ecosystem where hostility towards Indian professionals has become politically useful. The political calculation behind this shift is straightforward. Trump and his allies see immigration as the most emotionally powerful issue available before the midterms. Expanding the target from illegal immigration to legal immigration broadens the culture war and creates a permanent atmosphere of grievance and anger. The strategy also helps redirect public frustration over inflation, economic uncertainty and governance failures toward immigrants and administrative "loopholes."

RCB Head Coach Andy Flower praised the team's consistency in a highly competitive tournament, saying finishing on top reflected the squad's strong performances over the league phase.

Cases Against Accused of Inciting Communal Violence Withdrawn; It Poses a Threat to the State's Security: Opposition Leader R. Ashok

Bengaluru : The Congress government has once again indulged in vote-bank politics by withdrawing cases against those accused of inciting communal violence in Kalaburagi. This has endangered the security of the state, said Opposition Leader R. Ashok.

Speaking to reporters, he said that the Congress government has withdrawn cases against those who attacked police near the Ladle Mashak Darga in Aland, Kalaburagi, those who attacked a minister's car, and those who incited communal violence in the name of the darga. In this case, cases against nearly 150 people, including members of the Popular Front of India (PFI), have been dropped purely for vote-bank politics. Ministers and the Chief Minister, who took oath under the Constitution, have acted against the Constitution. The Congress has sent a message that "it's enough if you vote for us; we will support you even if



you indulge in terrorism." Such actions pose a danger to the country's security, he said.

Bangladeshi citizens are infiltrating the country and engaging in anti-national activities. Similarly, some people are inciting communal violence. If the government does not back down from this decision, the BJP will launch a protest. Recently, permission has been given for hijab in schools and colleges, and

around Rs.600 crore has been sanctioned for the Muslim community. Through this, the Congress is blatantly appeasing Muslims with bumper rewards just for votes. It is acceptable to withdraw cases related to farmers and pro-Kannada activists. But for whom were those involved in communal violence fighting? This is an act of betrayal against the majority community, he said.

An international cricket stadium is being constructed in Anekal despite opposition from farmers and environmentalists. Chinnaswamy Stadium in Bengaluru is opened only four or five times a year. When such is the situation, why is a new stadium being built? This project has been designed only to sell land around the stadium and earn commissions. Has any sportsperson from Anekal approached the government requesting this? The sudden decision to build this clearly shows it is a plan to make money. Chinnaswamy Stadium was meant to provide cricket training facilities, but no new talent is being trained there. It is only open for IPL, which brings in crores of rupees, he said.

The increase in petrol and diesel prices will not bring even a single extra paise in tax to the Central Government. However, the state government will earn approximately Rs.7,000 crore

annually. If the Congress government has any respect for the people, it should announce that it is ready to forego this additional revenue. It is wrong to blame only the Central Government. 5-yr breast cancer survival rate in India stands at 66.4%

New Delhi: The five-year survival rate for breast cancer, the most common cancer in India, stands at 66.4 per cent, with variations across 11 geographical areas, according to a study led by the Indian Council of Medical Research (ICMR). Breast cancer is the most common cancer in India, accounting for 28.2 per cent of all female cancers, with an estimated 216,108 cases by 2022.

The age-standardised incidence rate of female breast cancer has increased by 39.1 per cent from 1990 to 2016, and this trend has been seen in every state of India over the past 26 years.

The study, published in Cancer, an international interdisciplinary journal of the American Cancer Society, showed disparity in survival rates across 11 geographical areas. Mizoram (74.9 per cent), Ahmedabad urban (72.7 per cent), Kollam (71.5 per cent), and Thiruvananthapuram (69.1 per cent) had higher survival rates than the national average. Conversely, Pasighat (Arunachal Pradesh) had the lowest survival rate (41.9 per cent). Manipur and Tripura also had low survival rate, while the national average stood at 66.4 per cent.

Deaths during the 5-year follow-up period were also the highest in Pasighat (53.6 per cent) and lowest in Mizoram. "Breast cancer survival in India has improved slightly, but it still lags behind that in developed countries. Comprehensive cancer control strategies have to be implemented widely in the country," said the researchers including Krishnan Sathishkumar, from ICMR's National Center for Disease Informatics and



Research, along with others.

"Early detection programmes, including breast cancer awareness and cost-effective screening, along with accessible and affordable multi-modality treatment, survivorship care, and palliative care, have to be prioritised," they suggested.

The study included 17,331 patients who had breast cancer diagnosed between 2012 and 2015 from 11 areas who were followed until June 30, 2021. The team conducted survival analysis by calculating the difference between the date of first diagnosis and the date of death or censoring to estimate observed survival and relative survival. The study also revealed that Indian patients diagnosed with local-stage cancer have a 4.4 times greater 5-year survival rate than those diagnosed with distant-stage cancer. In addition, patients older than 65 years had a 16 per cent lower chance of survival compared with those aged 15-39 years. Further, the study

found that the survival rates for localised, locoregional, and distant metastases in India were lower than those in the US, with rates of 81.0 per cent, 65.5 per cent, and 18.3 per cent, respectively, compared with 99.3 per cent, 86.3 per cent, and 31.0 per cent, respectively.

In India, the majority of patients with breast cancer were diagnosed at the locoregional stage (57 per cent) in contrast to the US, where large numbers of cases were identified at the localised stage (63 per cent). In light of the disparity, "it is imperative to implement comprehensive cancer control strategies widely throughout the country," the team said. "Newer treatment options, such as targeted therapies and immunotherapies, have been shown to improve the prognosis of certain subgroups of patients with breast cancer, but access to such expensive choices are extremely limited in a low-income to middle-income country like India," they noted.

Changing old viticulture for all the right rieslings

When April nights dip below freezing, Claude de Nicolay knows she won't be getting much sleep. At 4 a.m., she climbs out of bed and heads outside to light around 300 candles set up between the vines at Domaine Chandon de Briailles, a biodynamic vineyard in the Burgundy region in France that de Nicolay owns and manages. Spring buds are emerging earlier because of warming March temperatures, yet frosts are still common in April. The candles produce just enough heat to thaw the buds and protect them from being destroyed by the Sun's rays come daybreak.

Although the candles are "a lot of work", de Nicolay chooses to use them, rather than electric heaters, because they help to minimize her contribution to climate change — the problem that has caused her vineyard to become dangerously out of sync with nature. "Agriculturalists are the first people who are affected," de Nicolay says. "The future is really about how to be very gentle with the soils, to go back to more manual work, to stop using chemicals and to stop using too much energy."

Wine-growers around the world from California to South Africa are feeling the heat as global warming increases temperatures, throws patterns of precipitation out of whack and drives up the frequency and intensity of extreme weather events and wildfires. France's wine sector faces extra vulnerabilities, thanks to its strict appellation d'origine contrôlée — a classification system with rigid rules about geography, grape varieties and production techniques. Under this system, "the origin becomes a sort of collective brand", says Cornelis van Leeuwen, a viticulturist at Bordeaux Sciences Agro in Gradignan Cedex, France.

France is the leading wine-producing country in terms of value. Last year, it exported wine worth \$2.3 billion (US\$13.3 billion), accounting for about one-third of total global exports, according to the International Organisation of



Vine and Wine, based in Dijon, France. This is in large part owing to the strong branding that the appellation system has created, exemplifying "how you find identity in a competitive world", says Etienne Neethling, head of the international master programme in vine, wine and terroir management at the Higher School of Agriculture in Angers, France. Much of this has to do with terroir, which translates to 'land'. But in the context of French wine, terroir refers to an entire philosophy of production: environmental factors, such as soil type, are understood to influence the flavour profile of the grapes. It also factors in where the product came from and who produced it and how — growers in different regions have different approaches to winemaking, and value different characteristics in their wine.

Terroir and the appellation system might be canny cultural-marketing strategies, but both might prevent French wine-makers from being agile and innovative in the face of changing environmental conditions. The appellation system's strengths could become weaknesses if the country's wine regulators and makers adhere too closely to custom and do not keep pace with a rapidly changing

world. "We are extremely vulnerable because of our strict regulations," Neethling says. As climate change intensifies, French wine-growers have begun to advocate for legislative changes that reflect the realities of the pressures that they face in the field and cellar. In the meantime, they aren't waiting for decisions to be formalized on paper, but are finding creative solutions that still adhere to the rules. As de Nicolay says, "We have to react quicker than our governments, because otherwise it's going to be a real disaster."

Action imperative

Compared with the 1980s, the grape harvest in France is now starting around three weeks earlier. "All producers have observed this earlier harvest," says Jean-Marc Touzard, director of research at the Montpellier centre of the French National Research Institute for Agriculture, Food and Environment (INRAE). In 2019, Neethling and his colleagues conducted a survey of 3,636 wine-growers from 18 countries, which has not been published. Among the 1,298 French respondents, more than 80% were already noticing the impacts of climate change on vine performance and wine quality and were thinking about

short- and long-term adaptation strategies. "Being reactive is no longer sustainable," Neethling says. "We need to make sure our vineyards are the most climate-resilient possible."

In 2011, scientists and industry experts launched LACCAVE, a project aimed at examining the future of French winemaking. Sticking to business as usual, they found, was a strategy that "has no future", says Touzard, who coordinated the project. The team also steered away from plans that relied solely on technology to save the day, he adds, because "it leads to artificialization of the wine industry" and "disconnection from the terroir".

Solutions will need to incorporate both science and centuries of wine-growing knowledge. For example, van Leeuwen and his colleagues have used chemical analysis to detect key molecules that influence aroma. The findings could help wine-makers to more closely control the style and quality of their final product by basing decisions about harvest time on their grapes' chemical profiles. A research team at the University of Bordeaux in France has used gas chromatography, a technique to separate and analyse vaporized compounds, and tastings by a panel of experts to explore and better understand the fruitiness of red wines produced from grape varieties that seem ideal for Bordeaux's future climate. All solutions will need to be tailored to specific locations and driven by actions from a range of players, from individual growers and consumers to local and national authorities. This will all need to be done while "still trying to preserve the local identity of the wine", Touzard says, yet at the same time accepting that "the taste, the flavour, will evolve". Minor girl brutally killed in Coimbatore; CM Vijay orders detailed probe, oppn slams govt

Leader of Opposition Udhayanidhi Stalin and AIADMK chief Edappadi K Palaniswami among others sought justice in the matter.

COIMBATORE / CHENNAI: A 10-year-old girl in Coimbatore's Sular was brutally killed, leading to shock and outrage across the state with the government promising strict action on Saturday following opposition uproar.

Terming the incident as "horrific," Tamil Nadu Chief Minister C Joseph Vijay said two persons have been apprehended in connection with the incident and that the police were directed to conduct a detailed and expeditious probe into the killing.

Leader of Opposition Udhayanidhi Stalin and AIADMK chief Edappadi K Palaniswami among others sought justice in the matter.

On his official 'X' handle, Vijay said, "I have directed the police to conduct a thorough and expeditious investigation into the incident and take all necessary actions to file the chargesheet immediately." He expressed his deepest condolences to the family of the victim. "The horrific



incident that occurred yesterday to a 10-year-old girl in Coimbatore causes immense pain and shock." "Such inhuman and unforgivable criminal acts can never be tolerated in our society," the CM said. Stating that the government will firmly act to ensure that those who commit such heinous acts against women and children received severe punishment under the law, he said "all immediate and necessary actions for this will be taken".

Meanwhile, various political leaders, including DMK leader Udhayanidhi Stalin, condemned the incident.

"This heinous incident has sent shockwaves across the country. The voice demanding true justice for this murder is echoing from all quarters", Udhayanidhi wrote on his social media page.

Assuring the victim's family that the DMK stands by their side, he alleged "since the new government assumed office, in just 12 days, over 30 major incidents including sexual violence and ganja smuggling," had happened.

"Now the Coimbatore abduction and murder have made headlines, casting serious doubts on the state's law and order", he said, adding,

"on behalf of the people of Tamil Nadu, I urge the Chief Minister to accord top priority to law and order to ensure no such incident ever happens again".

Palaniswami said "it is heartbreaking that this government, which is duty-bound to ensure the safety of women and children, has failed to prevent such heinous incidents".

"Even though two individuals have been arrested in connection with this incident after hours of protests, the inability to save the life of an innocent child points to the government's negligence", he said on 'X'. Palaniswami also demanded that the perpetrators be given the strictest punishment under the law, and that the government take immediate and firm actions to ensure the safety of women and children in order to prevent recurrence of such incidents. AMMK leader TTV Dhinakaran said that "those inhuman perpetrators must face stern action."

State language criterion for SSC historic win: MP Su Venkatesan Posting on social media platform X minutes before the oath-taking ceremony of VCK leader Vanni Arasu and IUML representa-



tive Shahjahan as ministers in the TVK government, Raja wrote in Tamil: "If the coconut tree in my home garden bends and gives tender

coconut water to another house, it is called 'mudhathengu' (bent tree) in Tamil. If the same happens in politics, what should it be called?" He ended the post with the phrase, "Long Live Tamil." Raja's cryptic post is being widely viewed as a criticism aimed at the VCK and IUML, both of which were part of the DMK-led alliance during the 2026 Assembly elections, but later extended support to the TVK government and secured ministerial berths.

FDA proposes ban on bulk compounding of semaglutide and tirzepatide

The U.S. Food and Drug Administration (FDA) announced Trusted Source it is considering removing glucagon-like peptide-1 (GLP-1) Trusted Source receptor agonists from the 503B bulks list Trusted Source, as there is no current clinical need for pharmacies to be able to compound these medications.

This could include drugs such as semaglutide (the active ingredient in Ozempic and Wegovy), tirzepatide Trusted Source (the active ingredient in Zepbound and Mounjaro), and liraglutide Trusted Source (the active ingredient in Victoza and Saxenda).

According to the FDA's announcement, the organization is asking for submitted comments for or against this decision by the end of June 2026 before making their final determination.

Medical News Today spoke with 4 obesity experts to find out more about what the FDA's 503B bulks list is, the potential future availability of compounded GLP-1 medications, and what alternatives may be available for users who may not be able to afford the brand name drugs.

What is the FDA's 503B bulks list?

According to Douglas Ewing, MD, FACS, DABOM, a board-certified bariatric surgeon and medical



director of the Center for Weight Loss and Metabolic Health at Hackensack University Medical Center, and associate professor of surgery at Hackensack Meridian School of Medicine in New Jersey, the FDA's 503B bulks list identifies bulk drug substances that outsourcing facilities can use to compound medications. "These outsourcing facilities, regulated under section 503B of the Federal Food, Drug, and Cosmetic Act, can produce larger batches of compounded drugs than traditional 503A compounding Trusted Source pharmacies, which compound for individual patients with specific prescriptions," Ewing explained to MNT.

"The critical difference between a drug on the 503B list and an FDA-approved medication is the level of scrutiny," he continued.

"FDA-approved drugs undergo a long and rigorous process of clinical trials to prove their safety, effectiveness, and quality before they can be marketed to the public." "Compounded drugs, even from 503B facilities, do not go through this same pre-market approval process. While 503B facilities are required to follow current Good Manufacturing Practices (cGMP), the compounded drugs themselves are not FDA-approved." If semaglutide and tirzepatide are removed from the 503B bulks list, the availability of com-

pounded GLP-1s would drop significantly, Michael Snyder, MD, FACS, FASMB, DABOM, medical director of the Bariatric Surgery Center at Rose Medical Center, founder and director of the Denver Center for Bariatric Surgery Foundation, and in-house obesity specialist at FuturHealth, told MNT.

"Most current compounded supply is produced through 503B outsourcing facilities, which would no longer be able to compound them in bulk," Snyder said.

"There may still be limited use under 503A compounding rules, where a medication is prepared for an individual patient based on a specific clinical indication, but that pathway is much more restricted and not designed for widespread use." Jen Manne-Goehler, MD, ScD, assistant professor of medicine at Harvard Medical School, agreed.

"There may be some forms of compounded GLP-1 drugs still available despite this decision," Manne-Goehler told MNT. "Specifically, the FDA's decision not to include these GLP-1s on the bulk compounding list would not be expected to affect their use by 503A pharmacies. 503A compounding pharmacies compound according to specific patient prescriptions and are required by state boards of pharmacy to comply with standards."

WHO raises Ebola threat level in Congo as outbreak spreads across region

The World Health Organization (WHO) has elevated the public health risk posed by the ongoing Ebola outbreak in the Democratic Republic of Congo (DRC), warning that the rapidly spreading virus now represents a "very high" threat at the national level. WHO Director-General Tedros Adhanom Ghebreyesus announced the revised assessment during a press briefing on Friday, stating that the risk level has been upgraded to very high within the DRC, high at the regional level, and low globally.

As concerns grow over the outbreak's expansion, the Africa Centres for Disease Control and Prevention called for stronger regional cooperation and urgent international support to contain the disease in both the DRC and neighbouring Uganda.

In a statement, the African Union's public health agency stressed that rapid coordination, immediate action and sustained assistance are essential to support frontline workers and communities most affected by the outbreak.

The Africa CDC announced emergency funding of 1 million US dollars to reinforce response operations and confirmed the deployment of an eight-member multidisciplinary emergency team to Bunia in Ituri Province, where the outbreak was first detected. The agency also welcomed South Africa's contribution of 2.5 million US dollars toward Ebola response efforts and praised healthcare workers battling the outbreak for their dedication and continued service under difficult conditions.

To strengthen regional preparedness, the Africa CDC said it is organising a high-level cross-border coordination meeting involving Uganda, the DRC and South Sudan. The discussions aim to improve surveillance, information sharing and emergency

response systems across affected border regions.

According to figures released by DRC Health Minister Roger Kamba, the country has recorded 626 suspected Ebola cases and 159 probable deaths since officially declaring its 17th Ebola outbreak on May 15.

Initially concentrated in Ituri Province, the outbreak has now spread to North Kivu and South Kivu provinces. Authorities have also confirmed two Ebola cases in neighbouring Uganda, increasing fears of wider regional transmission.

Ebola Virus Disease is one of the world's deadliest infectious diseases and spreads through direct contact with infected bodily fluids. Symptoms typically include fever, vomiting, diarrhoea, severe weakness and pain, while advanced infections can lead to internal and external bleeding. According to the WHO, Ebola fatality rates can range between 50 percent and 89 percent depending on the virus strain and the speed of medical intervention. Health authorities continue to urge early detection, isolation of patients and coordinated international action to prevent further spread of the outbreak.



Why hot nights can be more dangerous than scorching days, doctors warn

New Delhi, May 23: As summer temperatures rise, health experts are cautioning that the most dangerous heat exposure may not occur during the day—but at night, when the body is supposed to recover.

At night, the human body naturally lowers its core temperature to support rest, recovery, and cardiovascular stability. However, when nighttime temperatures remain high, this cooling process is disrupted, leaving the body under continuous heat stress even during sleep.

According to Arvind K. Minz, sustained nighttime heat pre-



vents proper recovery and can place significant strain on multiple organs. He explained that prolonged exposure to heat during sleep leads to continuous sweating, fluid and electrolyte

loss, and increased cardiovascular workload. Over time, this disrupts sleep cycles, impairs cognition, and weakens immune function.

Doctors warn that this condition can quietly escalate into serious health risks, including heatstroke, kidney injury, stroke, and in severe cases, death—especially when the body is unable to cool down for consecutive nights.

Experts say vulnerable groups face the highest risk, including older adults, children, pregnant women, outdoor workers, and people with chronic illnesses.

Ageing reduces the body's ability to regulate temperature effectively, while children dehydrate faster and patients with existing health conditions have reduced physiological reserves to cope with heat stress.

To reduce risk, doctors recommend simple preventive measures such as staying well hydrated, using fans or ventilation to keep rooms cool, wearing light clothing, avoiding heavy meals at night, and taking cool showers before bedtime. They also stress the importance of monitoring vulnerable individuals closely during heatwaves.

Rubio meets Modi during India visit with energy high on agenda

US Secretary of State Marco Rubio has held talks with Indian Prime Minister Narendra Modi in Delhi as part of a four-day visit to the country. Rubio arrived in the eastern city of Kolkata (formerly Calcutta) on Saturday morning before travelling to the capital. He is also due to visit Jaipur and Agra. He extended an invitation to visit the White House to Modi during their meeting. US officials said. The Indian premier, meanwhile, said the pair had discussed "issues related to regional and global peace and security". The visit comes as the two nations seek to reshape their economic relationship, and amid a global energy crisis triggered by the Iran war that has become a flashpoint since Israel and the US attacked Iran - have virtually ground to a halt. Iran has used the effective closure of the strait, through which around 20% of the world's oil and natural gas flows, as a pressure tactic in the fragile peace negotiations with the US. India, which imports more than 80% of its energy needs, has



suffered as a result. Nearly half of India's crude oil imports usually pass through the strait. Rubio discussed the situation in the Middle East with Modi, his spokesman said following their meeting. "[He] emphasised that the United States will not let Iran hold the global energy market hostage and affirmed that US energy products have the potential to diversify India's energy supply," the US official added. Rubio had indicated ahead of the meeting that the US was keen to sell India "as much energy as they'll buy". There will be appetite in Delhi to

boost its energy imports from the US as it will also help bridge the trade deficit that has been in India's favour - something that has constantly irked US President Donald Trump. The US goods trade deficit with India was \$58.2bn (£43.3bn) in 2025, a 27.1% increase on 2024. But it's not a straightforward solution. It's a much longer and expensive route for India to get energy shipments from the US. And analysts say it is not logical for India to fill the current shortfall in its imports from the US. "Energy security is going to be the key theme of this visit because the Iran sit-

uation is not going to be resolved anytime soon," Vineet Prakash, associate professor of US studies at Delhi's Jawaharlal Nehru University, said. "The US has already given a waiver to India on buying Russian oil, but Delhi is likely to push for more concessions." Rubio's visit also comes under the shadow of prolonged tensions between Delhi and Washington over trade negotiations and conflicting claims on who settled the brief India-Pakistan conflict last year. While Trump has repeatedly claimed that he brokered peace between the

neighbours, Delhi has consistently denied this with its stated policy of not welcoming a third party to mediate between the nuclear-armed nations in South Asia. What also appears to have displeased Delhi is Trump's open affection for Pakistani army chief Asim Munir, whom the US president has called his "favourite field marshal". Pakistan's peace mediation efforts between Iran and the US appear to have brought Islamabad and Washington even closer. Prakash added that this wasn't surprising, as Pakistan shares a long border with Iran and is strategically important for the US to keep the country close. But Rubio is not likely to make statements around Pakistan on this trip. "Any talks around Pakistan are likely to stay behind closed doors when Rubio meets leaders in Delhi," Prakash added. Meanwhile, the last few months have also seen Washington and Delhi offering an olive branch to each other. Trump's decision to lower reciprocal tariffs on India earlier this year from 50% to 18% after a 10-month impasse was met with a huge sense of relief in Delhi.

SpaceX launches massive Starship V3 rocket on test flight



Elon Musk's SpaceX has launched the largest and most powerful rocket in history after its highly anticipated test flight was delayed. The uncrewed Starship V3 rocket blasted off from Texas just after 17:30 (22:30 GMT) on Friday, days after SpaceX revealed plans for a record-breaking stock market debut. Once in space, Starship deployed 20 dummy satellites before making re-entry and about an hour after launch it splashed down in the Indian Ocean, where it exploded as planned. "Congratulations @SpaceX team on an epic first Starship V3 launch & landing!" Musk wrote

on X. "You scored a goal for humanity." The first attempted launch on Thursday was postponed due to a launch-tower malfunction. The SpaceX team celebrated after the launch, and while the mission achieved most of its major objectives, it did not go exactly to plan. Both stages of the rocket suffered engine failures but the test flight was largely successful - a result that will likely boost confidence both for investors and for Nasa, which intends to use the Starship vehicle in future missions to the moon. Nasa Administrator Jared Isaacman congratulated Musk and the SpaceX team. "One step closer to the Moon... one

step closer to Mars," he posted on X. It was the 12th flight of a SpaceX rocket, and featured the latest design which stands 124m (407ft) high - more than 40 storeys. The debut of the Starship V3 comes ahead of SpaceX's initial public offering (IPO), which is set to be the largest in Wall Street history. It could start next month. Because of the shares Musk will own in SpaceX, which values itself at \$1.25tn, the listing could make him the first-ever trillionaire. SpaceX not only makes rockets, but has a satellite internet service called Starlink, and owns the controversial artificial intelligence (AI) firm xAI.

BIG TECH BETS ON NEW MASCOTS IN BID TO SEEM MORE CUDDLY

Some of the world's biggest and most powerful brands are attempting to be more cute and cuddly. Tech giants Microsoft and Apple are among a wave of businesses who have recently introduced new cartoon character mascots, a tactic experts say is often used to make a brand seem more human and friendly, and to build a stronger connection with customers. Apple's character, a blue and white figure with an outsized head, has become unofficially known as Little Finder Guy. Introduced in March in social media videos to promote a new laptop, it has gained some positive coverage. Microsoft, which years ago shelved its widely-disliked Clippy paper-clip virtual assistant, has also unveiled a new cartoon character for its AI assistant Copilot. The company says the avatar, called Mico and resembling a blob with a smiley face, is "not a mascot, but an optional visual identity for Copilot". It adds that Mico is "expressive, customizable and warm", and "makes voice conversations [with the AI] feel more natural". There are plenty of good reasons for firms to



adopt a cute character to embody their brand. Businesses whose marketing campaigns include mascots are 37% more likely to grow their market share than those which don't, according to research published back in 2019. "They give a voice, a personality, a face even, to a company that is cold and impersonal to many people," says Anthony Patterson, professor of marketing at Lancaster University Management School. Some firms, tech businesses among them, are finding new ways to make use of existing characters. This includes the little green robot

that Google uses as the mascot for its Android mobile operating system. Last September, Google launched an app that allows users to create personalised versions of the robot. You can upload a selfie and the mascot will start wearing your clothes and copying your hairstyle. Google said it is about people being able to give the robot "different vibes". Among others, online forum Reddit updated its alien character Snoo in 2023 to be more animated and emotive. And in March of this year, Mozilla, operator of the Firefox web browser, turned its Firefox logo into a fully-fledged mas-

cot called Kit. John Solomon, chief marketing officer at Mozilla, says: "If you think about our competition - look at a Chrome logo, look at a Safari logo, look at an Edge logo - they're very stark, somewhat similar, somewhat cold. As a challenger brand, we want to distinguish ourselves from them." Yet, while sweet characters may win over some customers, not everyone is happy. Nathalie Nahai, who writes books and lectures on the interplay of psychology, technology and business, says the resurgence of mascots coincides with growing mistrust in some big tech firms. "People are reaching a crisis point when it comes to our relationship with consumer-oriented technologies," she says. "So many companies are getting a massively bad rap for being these techno overlords. What better way to cut through than to create a cute and cuddly, anthropomorphic mascot?" Both Nahai and Patterson are concerned about the impact of combining AI and mascots, enabling them to interact with people in new, highly personalised ways.

stores, putting hundreds of jobs at risk. It also comes after it revealed last month that about 200 jobs were at risk at its Bradford headquarters. The supermarket chain said its proposal to take the "tough but necessary decision" to close more Morrisons Daily stores meant more staff would be at risk of redundancy and a consultation would start shortly. While Morrisons has not confirmed how many staff are at risk of redundancy, it is understood that hundreds of jobs will be affected. A Morrisons spokesperson said the business would try to find other opportunities for the staff affected by the closures.

Hyderabad to soon get Tesla showroom: IT Minister Sridhar Babu



Hyderabad: Tesla India representatives on Friday, May 22, expressed interest in establishing a sales and service centre in Hyderabad during a meeting with Telangana IT and Industries Minister Duddilla Sridhar Babu. The minister expressed happiness that Hyderabad

AT LEAST 90 KILLED IN CHINESE COAL MINE EXPLOSION, STATE MEDIA REPORTS

At least 90 people have been killed in a coal mine blast in northern China, according to state media. The gas explosion at the Liushenyu Coal Mine in Shanxi province is the worst mining disaster in China since 2009. There were 247 workers reportedly on duty when the blast happened at 19:29 local time on Friday (22:29 GMT), with more than 100 people reportedly pulled to safety and hundreds of rescuers sent to the site. Chinese President Xi Jinping called for no effort to be spared in efforts to treat the injured and search for survivors, and asked the government to investigate the cause of the blast and hold those responsible to account. Twenty-seven people remain in a local hospital, with one in critical condition, while the rest have minor injuries. Most were affected after inhaling poisonous gas, according to state media, though it is not clear what type of gas it was.



Wang Yong, an injured miner, told state media that when the incident happened, he did not hear a sound but saw a sudden plume of smoke. "I smelled sulphur, the same smell you get from blasting. I shouted at people to run. As we were

running I could see people collapsing from the fumes. Then I blacked out too," he said. "I lay there for about an hour or so before I came round on my own. I woke up the person next to me and we got out together." Some of the management team at the

mine have reportedly been detained. The cause of the gas explosion has not yet been revealed, but state media reported that the levels of carbon monoxide - a highly toxic, odourless gas - in the mine were found to have "exceeded limits".

China's Ministry of Emergency Management has sent 345 personnel from six rescue teams to help with the operation. State media said the rescue operation had encountered difficulties as water has built up near the explosion site, pre-

venting access to certain areas, while blueprints provided by the mine did not match the actual conditions. In 2024, the Liushenyu mine was listed as one of the "severe safety hazards" by the Chinese National Mine Safety Administration. Tongzhou Group, which runs the mine, has reportedly received two administrative penalties in 2025 for safety issues. Shanxi province produces more than a quarter of China's total coal output. This disaster is a reminder of the darkest days of China's coal mining industry. In the early 2000s, deadly accidents were common in coal mines across the country. Safety standards have been tightened in recent years, and there has also been a crack-down on illegal coal mines, especially in Shanxi. But accidents still happen. In 2023, a collapse at an open-pit coal mine in the northern Inner Mongolia region killed 53 people.

FRENCH PAIR HELD UNTIL TRIAL AFTER BOYS ABANDONED BY ROAD IN PORTUGAL

A French woman and her partner will remain in custody after allegedly abandoning her two young boys on a roadside in the south of Portugal, a court has ruled. The boys were found on Tuesday evening crying beside a road near Alcacer do Sal, about 100km (60 miles) south of Lisbon. The woman and her partner, identified by authorities as Marine R and Marc B, were arrested in Fatima on Thursday. As they were being led into court on Saturday morning, the man shouted "I love you" in French and the boys' mother sang. A judge subsequently ordered the pair be placed in pre-trial detention, French and Portuguese media report. They are accused of aggravated assault, endangerment and abandonment of the boys. In Portugal, suspects must be brought before a judge within 48 hours of their arrest to decide whether they remain in custody or are released ahead of their trial. The couple have



already been questioned by investigators for several hours. Meanwhile, the children, who are aged four and five, are with a French foster family in Lisbon and are expected to return to France. Authorities told the Setubal courthouse that the two boys had been living with their 41-year-old mother in the eastern French city of Colmar, while their father had limited and supervised visitation rights, local media report. On 11 May, the father reported them missing, prompting authorities to begin searching for the mother and children, and a European arrest warrant being issued.

UK officials suggested single market for goods with Europe



UK officials suggested establishing a single market for goods trade with the EU as part of the next phase of its Brexit reset, the BBC understands. Industry figures briefed on the move said the idea has not been taken forward at this point, after EU scepticism, as attention focuses on the details of existing negotiations over food, farm and energy trade. The move does show significant extra ambition for a closer post-Brexit economic relationship, ahead of a summit in the coming weeks. For weeks Chancellor Rachel Reeves and Prime Minister Sir Keir Starmer have been publicly calling for a much closer economic relationship with the EU in the next phase of post-Brexit talks. There has been little public detail of what that has meant beyond existing talks on single market treatment for the trade in food, farm products, electricity and emissions trading. It has now emerged that UK officials suggested that the agenda for the next summit could be much more ambitious, with one option covering frictionless trade within a UK-EU single market for all goods. A European Commission

spokesperson declined to comment on the UK's proposal to the Guardian, which first reported the story, but said they "see scope to deepen" industrial defence cooperation, citing the UK's desire for talks on a Ukraine loan. The government did not confirm the specifics of any conversations, but acknowledged that a range of options were put to the EU in recent months and conversations are ongoing. British business groups have been briefed on the move and the EU's pushback that such an ambitious ask would not be negotiable with the government's existing red lines on, for example, freedom of movement. Some ministers believe that significant recent changes in the US posture to Europe might lead to more flexible thinking in continental capitals about the opportunities of economic reintegration between the UK and EU. A summit is expected in July. In the recent King's Speech, the government announced a European Partnership Bill which will provide a method through which UK and EU law would be aligned in relevant sectors being negotiated.

TULSI GABBARD TO RESIGN AS US NATIONAL INTELLIGENCE DIRECTOR

Tulsi Gabbard will resign from her position as the US director of national intelligence in the Trump administration, citing her husband's recent bone cancer diagnosis. "His strength and love have sustained me through every challenge," she wrote in her resignation letter on Friday. "I cannot in good conscience ask him to face this fight alone while I continue in this demanding and time-consuming position." US President Donald Trump wrote in a social media post that Gabbard had "done an incredible job, and we will miss her". Her resignation is effective as of 30 June. Aaron Lukas, the principal deputy director, will step in as acting director, Trump said. Gabbard, a loyal sup-



porter of Trump during his 2024 presidential campaign, was confirmed as one of the most powerful figures in US intelligence-gathering weeks after he returned to the White House in 2025. But this year she has largely been out of public view even as the US took military action against Iran, put pressure on Cuba, and notably removed Venezuela's president.

Senegal's president sacks PM and former ally after months-long feud

Senegalese President Bassirou Diomaye Faye has sacked Prime Minister Ousmane Sonko and dissolved the nation's government after months of tensions between the two men. A shock decree, read out on TV by a presidential aide, said Faye had "ended the duties" of his one-time political ally Sonko and "consequently those of the ministers and secretaries of state who are members of the government". Sonko, a popular figure among Senegal's youth, said on social media that he would "sleep with a light heart". The split comes as the country faces mounting economic pressure, with its public debt having reached the equivalent of 132% of its GDP, according to the International Monetary



Fund (IMF). Sonko's dismissal followed a parliamentary session on Tuesday, during which the prime minister openly criticised Faye for his approach to the debt crisis. Faye was in the unusual situation of owing his position, in large part, to his prime minister's popularity. Sonko would almost certainly have taken the top job had he not been barred

from running in 2024's elections due to a defamation conviction. However, Sonko backed Faye's bid for presidency, using the slogan "Diomaye is Sonko, Sonko is Diomaye". The pair went on to unseat then-President Macky Sall - an extraordinary victory given they were both in prison until 10 days before the election. Late on Tuesday night, sev-

eral hundred students demonstrated on the streets of the capital city, Dakar, declaring their support for Sonko. No details have been provided on the appointment of a new prime minister. Tensions between Sonko and Faye have been on display for months. Faye had reportedly criticised Sonko's "excessive personalisation" within the ruling party Pastef, while Sonko accused the president of a "failure of leadership" for not defending him against his critics. Amid this feud, Senegal's leaders have been grappling with the colossal amount of debt they inherited from the previous government. The IMF has frozen its \$1.8bn (£1.3bn) lending programme with Senegal as a result.

Gaza flotilla activists allege abuse by Israeli forces while detained

Pro-Palestinian activists deported after their Gaza-bound aid flotilla was intercepted in international waters by Israeli forces have alleged they were subjected to abuse while held in detention. Canada said it had received information detailing "appalling abuse" of its citizens, while Germany and Spain confirmed that a number of their citizens had injuries. The flotilla's organisers alleged there were "at least 15 cases of sexual assaults" while other people who were detained said they were beaten and mistreated. The BBC has not been able to independently verify the allegations. Israel's prison service has dismissed them as false, saying



all detainees were "held in accordance with the law". The Israeli military similarly rejected the allegations, telling the BBC that its orders "require respectful and appropriate treatment of flotilla participants". Warning: This article contains details of alleged abuse some may find

distressing More than 50 boats in the Global Sumud Flotilla (GSF) set sail from Turkey last week, planning to breach Israel's maritime blockade of Gaza and deliver food and medical aid. Israel's government dismissed the action as a "PR stunt" serving the Palestinian armed group

Hamas, and ordered commandos to board the boats west of Cyprus on Monday and Tuesday. The detained activists were transferred to Israeli vessels and taken to an Israeli prison after arriving at the port of Ashdod. On Thursday, 422 people from 41 countries were deported by Israel. Many have since arrived home. Canadian Foreign Minister Anita Anand said on Friday that she had "received information from my officials which details the appalling abuse of Canadians who were detained in Israel", without giving further details. She added: "Canada unequivocally condemns the grave mistreatment of Canadians in Israel."

Fergie's former racehorse enjoying a retirement with beaches and beer



Sir Alex Ferguson's former champions have gone on to have varied post-sport careers, from Gary Neville's role as a pundit to Eric Cantona's Hollywood stardom. But it's a more relaxing life for one retired winner. Spirit Dancer was one of Ferguson's most successful racehorses and is now enjoying strolls on the beaches of County Donegal and even enjoying some beer each day. Instead of being put out to pasture in England after an injury, the gelding was placed in stables in Rathmullan. So how did this English-trained champion end up in Donegal? He had earned his retirement' Trainer Rachel Carton works at the stables in Rathmullan and her stepson is the top jockey Oisín Orr, who rode Spirit Dancer. Together Orr and the thoroughbred brought great success for Sir Alex and his co-owner. "Oisín rode him twice in Bahrain and he won the Bahrain International twice with him [Spirit Dancer] and Fergie, as we now affectionately call him," Carton said. She said her stepson later took up a job in England

with Richard Fahey, who was training Spirit Dancer. When the horse unfortunately suffered a career-ending injury, Orr stepped in with a solution. "He sprained his fetlock joint which is the equivalent of the ankle in a human," she said. "He had his rest and his rehab and his medication, but it became obvious last autumn when he started into his training again that the joint just wasn't going to stand up to racing again. "So the decision was made that he had earned his retirement." Orr then asked if it was possible to retire him to his home stables where he learned to ride. The horse has adapted well to his new surroundings and enjoys lapping up a locally-brewed beer with his dinner. But he is only allowed a few drops each time, Carton said. She said Spirit Dancer was a "step above most horses" whose "superior character as well as ability comes through". The horse's hugely successful career included winning about \$2m (£1.5m) in back-to-back successes in the Bahrain International Trophy in 2023 and 2024.

EBOLA RISK RAISED TO 'VERY HIGH' IN DR CONGO



The public health risk from the current Ebola outbreak in the Democratic Republic of Congo has been raised from "high" to "very high" by the World Health Organization (WHO). In an update on Friday, WHO head Dr Tedros Adhanom Ghebreyesus also said the risk in the wider region in Africa was "high", but it remained "low" globally. The rare species of Ebola, known as Bundibugyo, has no

proven vaccine and kills about a third of those infected. So far, the outbreak centred on DR Congo has resulted in 177 suspected deaths and 750 suspected cases. It comes as scientists at Oxford University in the UK are developing a new vaccine that could be ready for clinical trials within two to three months. Based on the same technology they developed for the AstraZeneca Covid vaccine.

EBOLA OUTBREAK FORCES DR CONGO WORLD CUP SQUAD INTO 21-DAY ISOLATION IN BELGIUM

It is the kind of problem no football federation plans for. DR Congo spent months fighting their way to a first World Cup since 1974, only to arrive at the final weeks of preparation facing a crisis that has nothing to do with tactics, form or fitness. An Ebola outbreak back home has put their entire participation under threat, and Washington has made it clear the rules are not negotiable. What the US has told DR Congo The message from American authorities was delivered bluntly. DR Congo's squad must stay in a sealed bubble in Belgium, where they are currently based for training, and complete a full 21-day isolation period before they will be allowed to cross into the United States. Giuliani told ESPN: "We've been very clear to Congo that they should maintain the integrity of their bubble for 21 days before they can then come to Houston on June 11. We've made it very clear to the Congo government as



well that they need to maintain that bubble or they risk not being able to travel to the US. We cannot be any clearer." The CDC has also announced that the US will ban entry of all foreign nationals who have been in Congo, Uganda and South Sudan within the past three weeks. That ban runs for 30 days. What is happening with the Ebola outbreak The strain at the centre of this outbreak is Bundibugyo Ebola, a rarer and particularly dangerous variant for which no

approved vaccine or treatment currently exists. That detail is what makes the US position so firm. The outbreak is thought to have killed more than 130 people and caused nearly 600 suspected cases, prompting the World Health Organization to declare it a public health emergency of international concern. Earlier this week, DR Congo cancelled a three-day training camp and a planned farewell event for fans in the capital, Kinshasa, as a direct result of the situation.

"Lawsuit Is Still Going On": Frogan Reacts After Reports Claim Ethan Klein Won Copyright Lawsuit Against Her

Twitch streamer Morgan "Frogan" is finally speaking out after reports claimed that Ethan Klein had won his copyright lawsuit against her through a default judgment. The situation started blowing up online after court-related details began circulating on X on May 20, 2026. Soon after that, multiple creators and commentary pages started reacting to the news, with many people believing the legal fight was already finished. But according to Frogan herself, that's not the case at all. During a recent livestream, the streamer pushed back against the narrative that she had already lost everything. Inside SoFi Stadium: The Most Expensive Venue Hosting USA's World Cup Opening Match Against Paraguay

There are 16 stadiums hosting the 2026 FIFA World Cup. None of them cost anything close to what SoFi Stadium cost to build. Sitting in Inglewood, just a short drive from downtown Los Angeles, it is the kind of venue that stops you mid-sentence. And on the day the United States kick off their World Cup campaign against Paraguay, it will be the most-watched stadium on the planet. How much did SoFi Stadium cost, and why so much? Construction started in 2016, and when the doors finally opened in September 2020, the total cost had landed some-



where between \$5 and \$6 billion. That figure alone put it in a category of its own. No sports venue in history had cost that much to

sheer scale. The stadium sits on 298 acres and forms the centerpiece of Hollywood Park, a full entertainment district built around it, complete with shops, offices, parks, and residential areas. This was never just a stadium. It was a city within a city, developed alongside the venue rather than bolted on later.

There was also a specific engineering challenge: because the site sits in the flight path of Los Angeles International Airport, height restrictions meant the entire stadium had to be built 30 metres below street level. That decision shaped everything from the structural design to the construction timeline. The Infinity Screen: a feature that has no real comparison. Walk into SoFi and the first thing that catches your eye is not the pitch. It is the screen above it. The Infinity Screen is the largest video board ever installed in a sports stadium. It weighs close to 100,000 kilograms and runs more than 304 metres around the interior of the roof. There is nothing else like it in world sport. BCCI Selectors Wants To 'Move On' From Struggling Suryakumar Yadav, But Final Decision With One Man: Report



Suryakumar Yadav's future as India's T20 captain could primarily be decided by head coach Gautam Gambhir, as the national selection committee is not entirely convinced that he can make it to the team purely as a batter, according to a senior BCCI source. Suryakumar, who was given the moniker SKY by Gambhir, has been struggling for form for a year now. Within the BCCI, it is understood that the selection panel is in favour of moving on from him, but the Board hierarchy also recognises that the coach-captain equation is integral to the dressing-room environment. And Gambhir's stated comfort with Suryakumar will make him a key figure in the final call. For close to a year now, Suryakumar's place in the side has remained under scrutiny. At the moment, it is understood that all five selectors largely believe that the current T20 captain should be dropped from the XI. The view has been gain-

ing ground ever since the emotional dust of the T20 World Cup triumph settled. The selectors, it is learnt, began seeing the future of Indian cricket through a wider lens instead of focusing on the glow of a single tournament. "Initially, the selectors thought that the IPL would help Suryakumar regain form like the last edition when he crossed 700 runs. But strangely, there hasn't been any technical course correction in his game. "Even the rookie of pacers are just bowling straight hard lengths, and he has no answer. Selectors don't see him playing the Los Angeles 2028 Olympics. It is as simple as that," a senior BCCI source told PTI. The numbers do make for grim reading. Suryakumar managed only 210 runs from 12 innings at a strike rate of 148 but, more alarmingly, averaged below 18 - statistics that have sharply contrasted with the aura surrounding one of modern T20 cricket's most inventive batters.

Jasprit Bumrah Played T20 World Cup With Niggle: MI Coach Mahela Jayawardene's Revelation Ahead Of Last IPL 2026 Match



Managing a niggle that Jasprit Bumrah carried from this year's T20 World Cup into the ongoing IPL season resulted in the pace spearhead losing his "sharpness", despite Mumbai Indians giving

him enough recuperation time, revealed head coach Mahela Jayawardene here on Saturday. Bumrah's reduced effectiveness meant that he has just four wickets to show from 13 games for MI, and Jayawardene said the 32-year-old was fighting that unspecified injury in the earlier part of IPL 2026. "It is due to a combination of a few things. Coming back from the (T20) World Cup, he had a slight niggle which he played with through the World Cup, so we gave him adequate rest to come back," Jayawardene told reporters on the eve of their last game in this IPL against Rajasthan Royals. In fact, MI allowed the India internationals

in their line-up - Bumrah, skipper Hardik Pandya, Suryakumar Yadav and Tilak Varma - to join the pre-season camp only five days ahead of the start of this IPL on March 28. India had defended their title at Ahmedabad after an intense campaign. For Jayawardene, Bumrah's drop in pace in the earlier part of the league was because the pacer was trying to make a "gradual build-up." "In the first 4-5 games, it was a gradual build-up for him to get over that niggle he had. You could see the pace was dropped because of that, and now he's back to his pace. The last 4-5 games have been good. "But obviously, when you're going through some-

thing like that, you do lose a little bit of sharpness of execution and all that because you're fighting something else. But I think health-wise, it's 100 per cent (but it is) unfortunate that the season is (now) over for us," Jayawardene said. It has been a tough season for Bumrah, who featured in four of the five matches that India played against New Zealand in a bilateral series before the T20 World Cup. Bumrah also emerged as the joint highest wicket-taker with Varun Chakravarty (14 wickets) - including a 4/15 in the final against New Zealand - while featuring in eight of the nine matches that India played in the T20 World Cup.
