ANTI-TERRORIST OPERATION ENTERS SECOND DAY IN J&K'S RAJOURI

Jammu, May 24 : The anti-terrorist operation in Jammu and Kashmir's Rajouri district entered its second day on Sunday as heavy security deployment continued to trace the hiding terrorists. An encounter had started on Saturday in the forest area of Ghambir Mughlan when hiding terrorists opened fire at the security forces. The terrorist fire was returned, after which an encounter started there. The security forces, including the Army, J&K Police and the CRPF, jointly started the anti-terrorist operation in the area following intelligence inputs about the presence of 2-3 terrorists in the Ghambir Mughlan forests of Rajouri district.

Severe heatwave grips Telangana as temperatures cross 46°C in districts

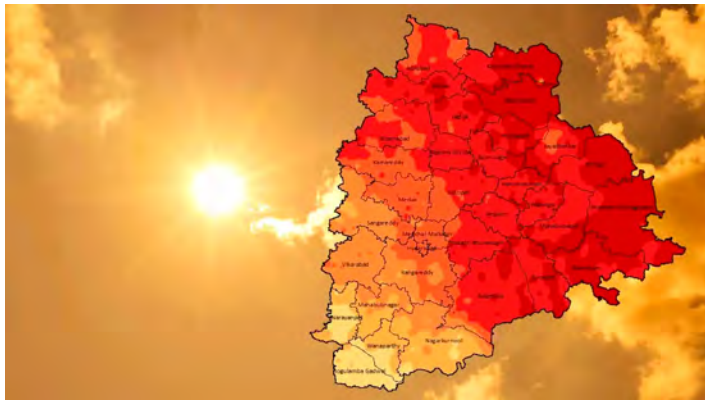
The heatwave will persist till May 28, after which there could be a gradual drop in temperature.

HYDERABAD, (TSIT):

Telangana continues to reel under a severe heatwave, mainly in northern and eastern regions, with temperatures touching above 45 degrees Celsius in some districts on Sunday, May 24.

Dahegaon village located in Komaram Bheem Asifabad, recorded the highest temperature at 46.5 degrees Celsius, followed by Dandepally in Mancherla and Maddirala in Suryapet at 46.4 degrees Celsius.

According to weather enthusiast T Balaji, popularly known as Telangana Weatherman and known for his accurate forecasting, the heatwave will persist till May 28, after which there could be a gradual drop in temperature. The highest number of deaths on Saturday was reported from the erstwhile Warangal district, where 23 people died. Eleven deaths were reported from the undivided Karimnagar district, seven from the Khammam region, and five each from Adilabad and Nalgonda districts.



Heatwave claims 16 lives in Telangana; govt announces Rs 4 lakh ex gratia

HYDERABAD, (TSIT):

Heatwave has so far claimed 16 lives in Telangana, officials said on Sunday, as the state continued to reel under severe weather conditions with several parts of north Telangana recording temperatures exceeding 45 degrees Celsius. The state government has confirmed 16 deaths in seven districts. It announced compensation of Rs 4 lakh each for the



families of the deceased. Revenue Minister Ponguleti Srinivas Reddy, who reviewed the situa-

tion due to intense heatwave conditions in the state, directed the administrative machinery to remain alert and take immediate action to ensure no inconvenience to the public. With the India Meteorological Department (IMD) warning that heatwave impact will intensify over the next three days, he advised district collectors to exercise even greater caution.

Responsible government must create awareness on SIR: Shivakumar

BENGALURU, (TSIT):

D. K. Shivakumar said it is the responsibility of a responsible government to create awareness among the public about the Special Intensive Revision (SIR) of electoral rolls and ensure that no eligible voter loses their voting rights.

Speaking to reporters at his residence in Sadashivanagar, he said a meeting of party leaders had been convened to protect the rights of people across Karnataka. He explained that only those who fill out the forms issued by the Election Commission and submit them with the required documents would retain their voting rights, while those who fail to do so risk losing them.

He said Booth Level Agents (BLAs) must ensure that people are informed about the process. According to him, similar issues related to SIR are occurring in several states, where lakhs of names are allegedly being removed from electoral rolls. Shivakumar stressed that poor and rural people must be



educated about SIR, as many may not understand the implications of failing to complete the process. He said migrant workers who travel to places like Goa and other states for livelihoods may face difficulties if they are absent during verification.

He warned that losing voting rights could also affect access to government welfare schemes, including Gruha Lakshmi benefits, pensions, housing schemes, and land-related benefits. He stated that governments must help citizens obtain the necessary doc-

uments and awareness to safeguard their rights.

"If there is a problem tomorrow, people will question us," he said, adding that while political parties may differ in elections, everyone must work to ensure citizens do not lose their right to vote.

Referring to the process, he claimed that even prominent individuals could lose voting rights if forms are not properly submitted, citing examples of people who allegedly faced such situations in the past. On Cabinet expansion speculation, Shivakumar dismissed reports of confusion and remarked that positions and status matter only when the party remains strong.

Reacting to the incident in Bhatkal where eight people reportedly drowned while collecting shellfish, he said District In-charge Minister Dinesh Gundu Rao would visit the area and that the government's immediate priority was rescue operations and saving lives rather than announcing compensation.

'India one of our key strategic partners,' says Marco Rubio after talks

NEW DELHI, (TSIT):

US Secretary of State Marco Rubio said on Sunday that India and the US are strategically aligned on several key global issues, including critical minerals, supply chains and terrorism. He called India "one of the most important strategic partners" for the US in the world. While



addressing a joint press briefing with External Affairs Minister S Jaishankar on Thursday, Rubio said that India and the US have suffered due to global terrorism networks. He noted that India and the US as democracies understand the importance of public scrutiny, accountability. Rubio said, "I have to go back and justify to the American people every decision we make and the president has to do the same on why it's good for our country and our counterparts here in India have to do the exact same thing."

Vijay speaks to parents of murdered ten-year-old, assures strict action

COIMBATORE, (TSIT):

Tamil Nadu Chief Minister C. Joseph Vijay on Sunday spoke to the parents of the 10-year-old girl who was found murdered near Sullur in Coimbatore district, offering condolences and assuring them that the government would ensure the strictest punishment for those responsible.

The tragic incident has sent shockwaves across the state and triggered widespread condemnation from political parties and the public. During the phone conversation, Vijay comforted the grieving parents and assured them that the state government would pursue the case with seriousness and ensure that justice is delivered.

The Chief Minister had earlier described the crime as an inhuman and unforgivable act that has no place in society. The victim, a resident of a village near Sullur, had reportedly gone out for shopping before she went missing. When she did not return home, her family approached the



police, prompting an intensive search operation.

Police teams launched a large-scale investigation, while local residents also joined efforts to trace the missing child. The search ended in tragedy when the girl was found dead in a bushy area in the locality. The horrifying nature of the crime sparked fear and anger among residents and quickly drew attention from across Tamil Nadu.

Following an extensive investigation, police identified the girl's neighbour as the prime suspect in the case. Authorities arrested Karthik, 33, in connection with the crime. Police have also taken Mohan Raj, who is suspected to be an accomplice, into custody and are questioning him as part of the ongoing investigation. The incident has reignited concerns over crimes against children and public safety, with many demanding stronger measures to prevent such incidents and tougher enforcement of laws against offenders.

KTR accuses Telangana govt of conspiring to scrap free power scheme for farmers



HYDERABAD, (TSIT):

BRS working president K. T. Rama Rao on Sunday alleged that the decision of the Congress government in Telangana to install meters on agricultural motors was taken with the sole intent of abolishing the free electricity scheme for farmers.

He also claimed that the government is trying to completely hand over the power sector to private entities under the guise of prepaid meters. Addressing a meeting at Bharat Rashtira Samithi (BRS) office, he said that Congress is conspiring to completely eliminate free electricity for farmers by installing meters on their agricultural motors. He claimed that the Congress government is plotting to remove the existing meters in every household and replace them with prepaid meters.

He said the State Cabinet reportedly took a decision on Saturday. He alleged that prepaid meters would also be introduced for all agricultural connections. KTR urged people to oust Congress from power before meters are installed on agricultural motors and before prepaid meters are introduced in every household. He urged the public to rise up against the "power conspiracies" being orchestrated by the Congress party within the electricity sector. He recalled that before the Assembly elections, BRS had warned the public that the free electricity scheme would be abolished if the Congress party came to power.

India sends medical supplies, protective kits to Africa amid Ebola outbreak

NEW DELHI, (TSIT):

Amid the Ebola outbreak in Africa, India on Thursday dispatched the first tranche of urgent medical supplies and protective kits to Africa Centres for Disease Control and Prevention (CDC). In a post on X, External Affairs Minister S Jaishankar expressed India's commitment to supporting Africa in responding to the emerging Ebola public health emergency.

"India dispatched the first tranche of urgent medical supplies and protective kits to Africa CDC today. Committed to support Africa in responding to the emerging Ebola public health emergency," EAM Jaishankar

posted on X. Ebola disease (EBOD) is a rare but severe illness in humans and is often fatal.

Meanwhile, the Indian government on Sunday advised Indian citizens, currently residing in or travelling to Congo, Uganda and South Sudan, to strictly follow public health guidance issued by local authorities and maintain heightened precautions, in light of the reported outbreak of Ebola disease in these countries. The World Health Organization (WHO) has declared the situation to be a Public Health Emergency of International Concern (PHEIC).

"In view of the evolving situation in the Democratic Republic of the Congo and



other affected countries, and in line with WHO's recommendations, Government of India advises all Indian citizens to avoid non-essential travel to the Democratic Republic of the Congo, Uganda and South Sudan until further notice," Health Ministry said in an advisory.

India has not reported any case of Ebola Disease caused by the Bundibugyo virus strain, the ministry added.

The Africa Centres for Disease Control and Prevention (Africa CDC) has officially declared the ongoing outbreak of Bundibugyo strain Ebola Virus Disease affecting the Democratic Republic of the Congo and Uganda as a Public Health Emergency of

Continental Security.

Further, the WHO IHR Emergency Committee on May 22 issued temporary recommendations to strengthen disease surveillance at Points of Entry to "detect, assess, report and manage travellers with unexplained febrile illness arriving from areas with documented Bundibugyo virus detection" while also "discouraging travel to areas with documented Bundibugyo virus detection". Countries bordering the Democratic Republic of the Congo and Uganda, including South Sudan, are assessed to be at high risk of disease transmission, according to the statement.

Uttam Launches 10-Day Mega Paddy Procurement Operation Across Telangana

Hyderabad TSIT: Telangana Irrigation and Civil Supplies Minister N. Uttam Kumar Reddy on Sunday launched a massive 10-day special paddy procurement drive across the State, declaring that every grain brought by farmers to procurement centres would be purchased without delay.

Describing the exercise as a “war-like operation,” the Minister said the government was making all-out efforts to overcome challenges such as untimely rains, heatwave conditions and labour shortages during the ongoing Rabi procurement season.

A high-level video conference was attended by Deputy Chief Minister Mallu Bhatti Vikramarka, Ministers Thummala Nageswara Rao, Ponnamp Prabhakar, Jupally Krishna Rao and Adhuri Laxman Kumar along with senior officials and district collectors.

Uttam Kumar Reddy said Telangana recorded



an estimated 140.81 lakh metric tonnes of paddy production during the current Rabi season from 65.91 lakh acres under cultivation. He said total arrivals are expected to touch 70-75 lakh metric tonnes and assured that the State Government would procure the entire stock despite operational pressures.

The Minister directed officials to clear the pending 8.78 lakh metric tonnes of arrived paddy within the next 72 hours and complete the entire procurement process within 10 days through result-oriented field action.

He also announced that even rain-exposed paddy would be procured to protect

farmers from losses caused by unseasonal weather conditions.

As of May 23, around 58.79 lakh metric tonnes of paddy had arrived at procurement centres, of which 50.01 lakh metric tonnes had already been procured. The Civil Supplies Department has fixed a daily procurement target of 3 lakh metric tonnes.

The State Government has already released 8,749.82 crore towards MSP payments to farmers. To support the large-scale procurement exercise, the government has deployed 8,575 procurement centres, over 12,900 transport vehicles and 20.86 crore gunny bags across Telangana.

The Minister said Telangana was conducting one of the biggest farmer-support procurement operations in the country and reiterated the government’s commitment to safeguarding farmers’ interests under all circumstances.

Cabinet Approves Rs.583 Cr for Lakshmidhevipalli Project: Minister Vakiti Srihari

RANGAREDDY : State Minister for Animal Husbandry, Sports and Youth Services Vakiti Srihari announced that the State government has sanctioned 583 crore for the construction of the long-pending Lakshmidhevipalli Project.

Addressing a press conference at the Shadnagar MLA camp office on Sunday, the minister said the State Cabinet approved the project following the special efforts of Shadnagar MLA Veerlapalli Shankar and under the directions of Chief Minister Revanth Reddy.

He stated that the project would greatly benefit farmers in Mahabubnagar and Rangareddy districts, particularly in drought-prone Palamuru region where even borewells



often fail to yield water. The minister said meetings would soon be conducted at the collectorates of Rangareddy and Mahabubnagar districts to take the project forward and that land acquisition and pending works would be completed at the earliest.

Criticising the previous BRS government, Vakiti Srihari alleged that former Chief Minister K. Chandrashekar Rao had misled the people of Palamuru in the name of irrigation projects. He

claimed that although 58,000 crore had been sanctioned for the Palamuru project, only around 28,000 crore was actually spent. He further alleged that works were undertaken without environmental clearances or proper land acquisition, resulting in misuse of public funds.

The minister questioned why the previous government had spent heavily on the Kaleshwaram project while allegedly neglecting Palamuru region

and urged the youth to question the same.

Speaking on the occasion, MLA Veerlapalli Shankar said the Lakshmidhevipalli Project was a decades-old dream of the people of Shadnagar constituency and farmers had been waiting for its completion for many years. He stated that the project could not progress due to the negligence of previous governments, but the Congress government under Chief Minister Revanth Reddy had revived hopes for its completion.

The MLA recalled that several protests and agitations had been organised in the past demanding the project and expressed happiness over the Cabinet approving 583 crore for its construction. Several local leaders and public representatives participated in the programme.

BJP State President Ramchander Rao urges Telangana govt to expedite Godavari projects

Hyderabad, May 24 (TSIT) Telangana BJP State President N Ramchander Rao has written an open letter to Chief Minister A Revanth Reddy, expressing concern over delays in planning and execution of irrigation projects in the Godavari basin, alleging underutilisation of Telangana’s assured water share and urging time-bound completion of key projects including Kaleshwaram, Seetharama Sagar and Sammakka Sagar.

In the letter, Ramchander Rao stated that Telangana is entitled to nearly 968 TMC of assured Godavari waters but has been unable to fully utilise its rightful share due to delays and inadequate planning. He noted that after the formation of Telangana in 2014, the union Government under

Prime Minister Narendra Modi cleared several major irrigation projects with a combined capacity of nearly 360 TMC, including Kaleshwaram, Seetharama Sagar, Sammakka Sagar, Chinna Kaleshwaram, Modikunta Vagu, Chanaka-Korata, Gudum Lift and CHLIS. The BJP leader pointed out that the Medigadda, Annaram and Sundilla barrages of the Kaleshwaram Lift Irrigation Project are yet to be fully restored despite recommendations from the National Dam Safety Authority.

He also alleged that delays in completing the Seetharama Project were depriving the state of 67 TMC of Godavari waters, while inadequate command area planning was slowing progress on the Sammakka Sarakka

Project despite hydrological clearance from the Central Water Commission. Ramchander Rao urged the Chief Minister to ensure proper utilisation of Telangana’s assured Godavari water allocation and to complete all major irrigation projects in a time-bound manner. He also raised concerns over reports suggesting possible changes in the alignment and source location of the proposed Godavari-Cauvery river interlinking project from Inchampalli, stating that Telangana’s interests should not be compromised under any circumstances. He called upon the state government to act with urgency and commitment to ensure that the people of Telangana receive the full benefits of the Godavari waters allocated to the state.

BJP Leader Vishnuvardhan Reddy Demands Immediate Procurement of Wet Paddy



RANGAREDDY : Senior BJP leader Palamuru Vishnuvardhan Reddy visited the Shadnagar Agricultural Market Yard following unseasonal rains that caused severe hardship to farmers and damaged large quantities of stored paddy. During his visit, Vishnuvardhan Reddy inspected the rain-soaked grain and interacted with farmers to understand their problems. He expressed concern that farmers were facing heavy financial losses as the paddy stored in the market yard had been completely drenched due to the sudden rains. Speaking on the occasion, he demanded that the State government immediately come to the aid of affected farmers and procure the wet paddy without delay to ensure justice to them. He also urged the government to provide adequate compensation for crop losses and take special measures to prevent farmers from facing further difficulties. The BJP leader reportedly spoke to the Market Secretary over the phone and criticised the alleged negligence in failing to arrange proper sheds to protect the paddy from rain. He warned that the BJP would stand by farmers and launch protest programmes if justice was not done to them. BJP district secretary Isnathi Srinivas, councillor Pyata Ashok and several BJP leaders, activists and farmers participated in the programme.

Women Welfare Week celebrations must be successful: Collector Prateek Jain

Sangareddy, May 24 (TSIT) District Collector Prateek Jain directed the concerned officials to expedite the paddy procurement process in view of the unseasonal rains in the district and complete the procurement by the end of this month. On Sunday, Deputy Chief Minister Mallu Bhatti Vikramarka, State Civil Supplies Minister Uttam Kumar Reddy, and State Chief Secretary Ramakrishna Rao, along with other officials, held a video conference with all District Collectors and departmental officers to review paddy procurement and the Women Welfare Week celebrations scheduled from May 25 to 30 as part of the Prajapalana-Pragathi programme.

During the conference, they instructed officials to complete the ongoing paddy procurement process across the state on a war footing. They also directed authorities to immediately address issues related to shortage of warehouses, lorries, and hamals wherever such prob-



lems exist. Officials were asked to ensure timely payments to farmers by regularly completing tab entries and updating procurement data.

Indiramma Bima scheme to be launched from June 2: Bhatti



Hyderabad, May 24 : The government of Telangana will launch 'Indiramma Jeevitha Bima' (Life Insurance) scheme across the state on June 2, marking the state formation day. Deputy Chief Minister Mallu Bhatti Vikarmarka on Sunday termed it as a historic scheme. He said this would be a gift to the people on Telangana formation day.

The objective of this people-centric government is to provide insurance coverage of Rs 5 lakh to 1.15 crore families across the state, transcending barriers of

caste and religion, and without any distinction between the rich and the poor, the Deputy Chief Minister said in a post on X. Vikaramarka, who is the finance and energy minister, said that to empower women as entrepreneurs, the government will not only allocate solar power plants but also increase interest-free loans for women's self-help groups to a total of Rs 1 lakh crore.

Through initiatives such as the distribution of fine-quality rice, 200 units of free electricity under the 'Gruha Jyothi'

scheme, and the construction of 'Indiramma' houses, this government is moving forward by delivering the benefits of welfare to every underprivileged family. With welfare as our guiding principle, and by fulfilling every promise made, we are steering Telangana along the path of progress, he said.

The State Cabinet, at its meeting on Saturday, approved the sanctioning of the second phase of 'Indiramma' houses within the state. The Cabinet gave its approval for the construction of Indiramma houses for a

total of 250,000 poor families. It was decided to sanction 2,000 houses for each Assembly constituency.

The State Cabinet also resolved to complete those Indiramma houses—the construction of which began under the Congress government in the united state—that currently remain stalled at the wall or roof-slab stage. Financial assistance of Rs 3 lakh will be provided for houses where the foundations are complete, but the walls and roof-slabs are yet to be built, while Rs 2 lakh will be provided for houses where the walls are complete but the roof-slabs remain pending.

To facilitate the completion of these unfinished Indiramma houses, the Cabinet passed a resolution allocating funds for 500 such houses per constituency, Revenue and Housing Minister P. Srinivas Reddy said.

"By June 2nd, housewarming ceremonies are scheduled to take place for approximately 100,000 Indiramma houses, the construction of which commenced during the first phase," he said.

Mallu Ravi calls for unity in Palakurthi Congress amid internal disputes

Hyderabad : MP and TPCC Disciplinary Committee Chairman Mallu Ravi on Sunday called upon Congress leaders and cadre in the Palakurthi constituency to work together to strengthen the party and resolve internal differences amicably.

Speaking to reporters at Gandhi Bhavan after a meeting with local leaders in Hyderabad, Mallu Ravi said that Jhansi Reddy had appeared before the TPCC Disciplinary Committee regarding recent disputes within the constituency. The TPCC leader said show-cause notices had already been issued to Hari Prasad and Krishna Kishore, who subsequently submitted their explanations along with documentary evidence. Jhansi Reddy had also provided relevant information and evidence to the committee, he said.

Mallu Ravi further stated that discussions would be held with the district-in-charge minister, Ponguleti Srinivas Reddy and other district leaders to resolve the issue and ensure unity within the party in Palakurthi constituency.

Harmful celiac disease and cancer due to eating hot food items packed in black boxes



Balasamudram, May 24, TSIT : Dr. Pallepada Damodar, President of Southern States Consumer Coordinating Committee, said that harmful food adulteration should be stopped immediately in many hotels in Warangal Hanumakonda.

He expressed concern that unsanitary kitchens, biryani dishes prepared on the roads without a roof, adulterated odors and "tasty salt" which is mostly used for taste are causing serious diseases to the consumers. Dr. Pallapadu Damodar said that along with hoteliers, consumers also need to be aware of the "tasty salt" that is being imported in large quantities from China.

On Saturday and Sunday, the Food Safety Officer Mounika along with the representatives of Consumers Council conducted inspections in several places in Warangal such as Warangal Chowrastha, JPN Road, Pochamma Maidan, Mandi Bazaar and other biryani hotels. She checked the colors used in the biryanis, inferior spices, chilli powder, expired chilli sauce, unhygienic chicken and cooking conditions in dark kitchens.

The Food Safety Officer expressed her silent anger over the harmful contamination caused by the preparation of biryani on the roadside in a small alley on the back side of JPN Road and the preparation of food items on roofless roads. Later, the National General

Secretary of the Consumer Council Sambaraju Chakrapani said that many youths who are not aware of biryani and other dishes prepared in various hotels in an unsanitary environment are buying biryani dishes online through companies like Swiggy and Zomato. Sambaraju Chakrapani has complained to the authorities that such dishes are being sold by online food companies by hoteliers packing them in harmful black boxes. He added that eating hot food items packed in black boxes can lead to harmful celiac diseases especially cancer.

Farmers raise concerns over maize procurement delays at leejia market yard



Jogulamba Gadwal TSIT. Serious concerns over delays in procurement, transportation issues, and alleged irregularities in weighing procedures were raised by maize farmers at the Ieeja Agricultural Market Yard in Jogulamba Gadwal district during a visit by the Telangana Rajyadhikara Party (TRP) district leadership on Sunday.

According to the farmers, maize produce brought to the market yard has been lying unattended for nearly 40 days, causing severe distress amid unseasonal rains. Farmers alleged that despite harvesting their crop after nearly five months of hard work, they are now being forced to wait for over 45 days to complete the sale process due to shortage of transport vehicles.

The issue came to light when TRP district president

Morugu Veeresh, along with party leaders and members of the district executive committee, visited the market yard and interacted directly with the affected farmers. During the interaction, farmers openly questioned the negligence of market authorities and demanded immediate intervention from the government.

Farmers expressed concern over who bears responsibility for safeguarding the produce after the grain has been weighed. They questioned whether the responsibility lies with the farmers themselves or with the concerned government officials managing the procurement process.

Another major allegation raised by the farmers was regarding the collection of money for moisture testing. Farmers claimed that they were being charged nearly Rs.1,000 in the name of mois-

ture checking and questioned whether the amount was an official market fee or an illegal bribe collected by officials.

The farmers also alleged discrepancies in the deduction of bag weight during procurement. While the actual empty bag weight is reportedly around one kilogram per quintal, officials were allegedly deducting 2.6 kilograms per quintal during weighing. Farmers questioned where the remaining excess deduction of 1.6 kilograms was going and demanded transparency in the procurement process.

During the visit, market officials reportedly failed to provide satisfactory explanations to the farmers' concerns. TRP leaders alleged that the responses given by the authorities were incomplete and misleading, leading to protests by party members in support of the affected farmers. Speaking on the occasion, TRP district president Morugu Veeresh demanded that the government immediately address the issues being faced by farmers, ensure timely transportation and procurement of maize stocks, and conduct a comprehensive inquiry into the alleged irregularities at the market yard. He further demanded strict action against officials found responsible for negligence or corruption.

Khammam family appeals for help as 26-year-old woman battles kidney failure

Khammam: A family from Khanapuram UPH Colony in Khammam is seeking public support after 26-year-old Umamaheshwari was diagnosed with complete kidney failure, leaving her mother struggling to arrange life-saving treatment.

After the death of her husband Venkateswarlu, Aruri Pramila has been working as a daily wage labourer to support her family. Her son, Nagendra Chari, works as a carpenter, while the family survives on limited daily earnings.

According to family members, Umamaheshwari's health deteriorated severely in recent months, prompting them to take her to Nizam's Institute of Medical Sciences for treatment.



Following several medical tests, doctors reportedly informed the family that both of her kidneys had failed and advised urgent treatment, including regular dialysis and a kidney transplant.

The family says the mounting medical expenses have pushed them into deep financial distress. Pramila, who earns a modest daily wage through

labour work, said arranging lakhs of rupees for treatment has become impossible.

Appealing for support, the family requested donors and well-wishers to come forward to help save the young woman's life. Contributions can reportedly be sent through PhonePe to the number provided by the family: 9392133306.

Hyderabad, Cyberabad traffic police book over 700 drunk driving cases in special drive

Hyderabad, May 24 : Hyderabad and Cyberabad Traffic Police booked more than 700 drunk driving cases during special enforcement drives conducted over the weekend to improve road safety and curb drunken driving violations.

According to the Hyderabad Traffic Police release on Sunday, a two-day special drive conducted on May 22 and 23 resulted in 438 motorists being caught driving under the influence of alcohol. Of them, 365 were two-wheeler riders, 25 were three-wheeler

drivers, 47 were four-wheeler drivers and one belonged to another vehicle category.

Police said 98 offenders recorded Blood Alcohol Concentration (BAC) levels between 30 and 50 mg/100 ml, while 191 cases were between 51 and 100 mg/100 ml. Several others recorded higher BAC levels, including five persons whose BAC exceeded 300 mg/100 ml.

Meanwhile, Cyberabad Traffic Police booked 294 drunk driving cases during a weekend special drive. The cases included 255 two-

wheelers, five three-wheelers and 34 four-wheelers.

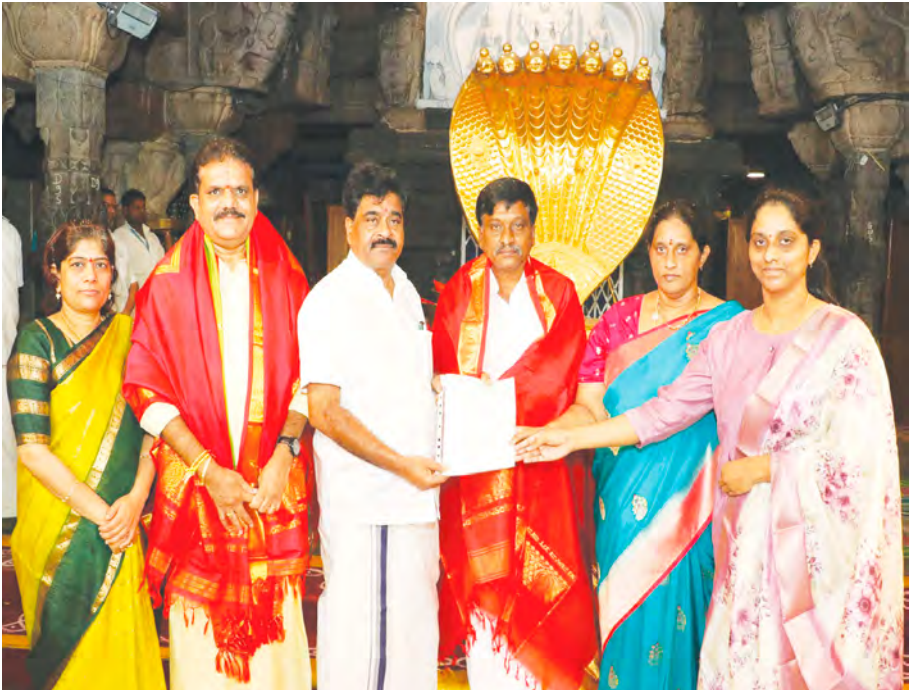

Suvendu Adhikari hails BJP's Falta victory; Abhishek Banerjee questions counting process

Kolkata, May 24 : Following the BJP's victory in the Falta Assembly bypoll, West Bengal Chief Minister Suvendu Adhikari on Sunday claimed that the "Diamond Harbour model" associated with Trinamool Congress national general secretary Abhishek Banerjee had failed politically. As soon as the election results became clear, Adhikari launched a sharp attack on the ruling Trinamool Congress.

The Falta Assembly constituency, which falls under the Diamond Harbour Lok Sabha seat, had long been considered a Trinamool Congress stronghold. However, after the change in the political equation following the bypoll, the BJP managed to wrest the seat from the ruling party with a massive margin.

Suvendu Adhikari wrote on his X handle: "I am especially grateful to the voters of Falta. I had appealed for the BJP candidate to win by one lakh votes. The margin of victory has crossed one lakh eight thousand. We will repay this debt to you through development."

He further stated: "A party without principles and ideals, which trans-



formed itself into a mafia company, has been exposed the moment it lost power. The leaders of this party took people for granted by abusing state power, looting government funds, extorting people's hard-earned money, and running syndicates and a threat culture. This time, when people regained the freedom to cast their own votes after 15 years, the true picture emerged. A tough fight against

'NOTA' awaits the Trinamool Congress leadership in the coming elections."

Abhishek Banerjee, meanwhile, questioned the counting process in the Falta Assembly bypoll. In a post on X, Banerjee said: "The Falta AC repoll counting today exposes glaring inconsistencies. By 3.30 p.m. today, all 21 rounds were completed. On May 4, till the same time, only two to four rounds had taken

place. The country deserves an explanation from the ECI. Although more than 1,000 workers from Falta have been forced to flee their homes in the last 10 days, the Election Commission continued to turn a blind eye. Party offices were vandalised in broad daylight even when the Model Code of Conduct was in force."

He also criticised the Election Commission over its conduct during

the West Bengal Assembly bypoll process and the Special Intensive Revision (SIR) exercise relating to Bengal's electoral rolls.

"The Election Commission has taken no action. Instead, the CEO, who was allegedly used by the ECI to delete names under the guise of SIR and manipulate the electoral process, was appointed Chief Secretary of the new WB government at a time when the Model Code of Conduct was still in force in Falta and the polling process had not even been completed," he alleged. The Trinamool Congress leader further said: "Even more worrying, counting agents of Trinamool and other political parties, except the BJP, were allegedly thrown out of the venue on May 4 by officials and central forces deployed under the Election Commission of India. This is deeply alarming and strikes at the heart of free and fair elections. Unless compromised officials are held accountable and an independent CCTV audit of the counting process is conducted, questions over the credibility of the mandate will only grow stronger."

AINU doctors remove massive pumpkin-sized kidney tumor from 53-year-old man

Hyderabad: Doctors at Asian Institute of Nephrology and Urology successfully removed a massive 20 cm kidney tumor from a 53-year-old man from Kurnool in a life-saving surgery.

The complex procedure was performed by a multi-disciplinary team led by Dr. Purna Chandra Reddy and Dr. Rajesh Kumar Reddy Adapala.

The patient was admitted with severe abdominal swelling, weakness, and loss of appetite. Medical examinations revealed a huge tumor originating from the right kidney. Doctors said the tumor had grown so large that it occupied the entire right side of the abdominal cavity and pushed the intestines toward the opposite side. As the patient was initially not stable enough for major surgery, doctors first stabilized him with intravenous fluids, antibiotics, and blood transfusions to improve his hemoglobin levels before proceeding with surgery.

The team later performed an open radical nephrectomy under general anesthesia. During the operation, surgeons found that the bleeding tumor had completely replaced the kidney and



displaced nearby organs, including the intestines, pancreas, and liver. After meticulous dissection and careful identification of kidney blood vessels, the surgeons successfully removed the giant tumor measuring nearly 20 cm.

Doctors confirmed that microscopic examination identified the growth as Renal Cell Carcinoma, a type of kidney cancer. Surgical margins were reported clear, indicating complete removal of the tumor.

Speaking about the surgery, Dr. Purna Chandra Reddy said managing such a large kidney tumor required extensive planning and surgical precision to safely remove the mass while protecting surrounding organs. He stressed the importance of

early diagnosis and routine ultrasound screening for detecting tumors at an early stage.

Dr. Rajesh Kumar Reddy Adapala described the case as exceptionally challenging due to the tumor's size and location, adding that advancements in surgical expertise and technology have enabled doctors to handle complex uro-oncology cases with improved outcomes.

Doctors at AINU also cautioned that urological cancers are increasing globally and emphasized the importance of early diagnosis. They noted that minimally invasive robotic and laparoscopic procedures can help preserve healthy portions of the kidney if cancers are detected in earlier stages.

Rare diagnosis at CARE Hospitals saves Hyderabad teen after months of suffering

Hyderabad: A 14-year-old boy from Hayathnagar, who suffered for nearly five months with persistent vomiting and severe digestive problems, finally recovered after doctors at CARE Hospitals diagnosed and treated a rare condition known as Superior Mesenteric Artery (SMA) Syndrome. The teenager initially experienced repeated vomiting, which gradually worsened into severe weakness, inability to eat properly, and constipation. Despite visiting multiple hospitals and undergoing several tests and treatments, the exact cause of his illness remained unidentified. Hope emerged when the family consulted Dr. Bhupathi Rajendra Prasad at CARE Hospitals, Malakpet. After evaluating the patient's medical history and symptoms, the doctor suspected



SMA Syndrome, a rare disorder in which a portion of the small intestine gets compressed between major blood vessels, leading to severe digestive complica-

tions. Although an initial Contrast-Enhanced CT (CECT) Abdomen scan was reported as normal, Dr. Bhupathi personally reviewed the scan films and discussed the case with radiologists. His continued suspicion led to a repeat evaluation, which eventually confirmed the rare diagnosis. The teenager subsequently underwent a successful laparoscopic duodenojejunostomy, a minimally invasive surgery performed to bypass the compressed section of the intestine. The procedure was successful, and the patient was discharged within three days. Doctors said the teenager is now completely symptom-free, eating normally, and has returned to his regular routine. Speaking about the case, Dr. Bhupathi Rajendra Prasad said the condition is often overlooked because its symptoms

resemble common gastric disorders. He stressed the importance of careful clinical judgement and detailed correlation with imaging in patients with unresolved digestive symptoms. Dr. Praveen Kumar Edla said the case highlighted the importance of expertise, persistence, and multidisciplinary teamwork in diagnosing and treating rare medical conditions. Doctors noted that SMA Syndrome is a rare gastrointestinal disorder that can be difficult to diagnose due to symptoms similar to common digestive illnesses. Specialists advised that persistent vomiting, unexplained abdominal discomfort, sudden weight loss, and prolonged digestive complaints should not be ignored, particularly when symptoms continue despite repeated treatment

ODR FOR MSMEs OPPORTUNITIES AND CHALLENGES

Former International Sr Advisor, United Nations The financial health of any growing market is strongly dependent on the survival of its Micro, Small, and Medium Enterprises (MSMEs). These tiny enterprises, which serve as the primary drivers of employment and industrial activity, operate within extraordinarily tight liquidity constraints. For them, business disagreements and late payments are more than just administrative hassles; they are an existential threat that stops financial flows and halts operations. In India, where traditional legal systems confront significant backlogs, the commercial dispute issue in the MSME sector has reached a critical point. According to data from the Ministry of MSMEs, MSME Samadhaan delayed payment monitoring system, the backlog is massive: more than 40,000 cases are currently pending before various state-level Micro and Small Enterprises Facilitation Councils (MSEFCs).

This backlog traps billions of rupees in essential working capital in bureaucratic pipes. While statutory rules in the MSME Development (MSMED) Act require these state councils to resolve references within 90 days, real-world constraints typically extend these schedules for years. In response to this mounting pressure, Online Dispute Resolution (ODR) has evolved from a novel technological trend to a critical policy answer. By combining algorithmic efficiency with alternative dispute resolution (ADR) frameworks, ODR provides a means of delivering speedy, transparent, and cost-effective justice to small businesses.

To fundamentally expand this approach, the Indian government has launched an ambitious drive to formalise public-private partnerships. Rather than regarding public institutions as the sole producers of legal remedy, the state is evolving into the designer of a regulated marketplace of specialised service providers. The Ministry of MSMEs' formal implementation of the MSE Scheme on Online Dispute Resolution for Delayed Payments (the MSE-ODR Scheme) as part of the World Bank-supported Raising and Accelerating MSME Performance (RAMP) initiative is a primary driver of this policy shift.

Along with this program, the Ministry issued its thorough Model Guidelines for Empanelment of Institutions or Centres Providing Alternative Dispute Resolution Services, which clearly require state governments and union territories to appoint qualified private ADR and ODR institutions. This regulation

enables state MSEFCs to lawfully unload and channel high-volume payment disputes directly to external, technology-enabled platforms. The Ministry's strategic rollout of the unified MSME ODR Portal, which succeeded the initial Samadhaan framework, strengthened this integration by allowing data-driven, time-bound virtual mediation and institutional arbitration to run seamlessly on a uniform state-backed infrastructure.

However, translating this macro-policy framework into local implementation reveals significant friction, particularly in the structural challenges that private ODR and ADR institutions encounter when attempting to overcome state-level empanelment hurdles. Despite national directives encouraging public-private collaboration, individual state departments frequently filter advanced digital platforms using rigid procurement frameworks built for traditional engineering or construction vendors.

Furthermore, commercial companies face ongoing scepticism from public sector organisations and large corporate customers about data ownership and algorithmic neutrality. These institutional actors commonly express concerns about cloud-hosting vulnerabilities, the security of important financial ledgers, and potential digital biases, fearing that an automated environment may damage proprietary data or favour partners with higher digital maturity. Resolving these empanelment issues necessitates targeted solutions focused at standardisation, risk minimisation, and technology inclusion. First, the central government must establish an objective, nationwide accreditation structure through a central entity, such as an optimised Arbitration Council of India or a separate branch of the Ministry of Law and Justice. This regulatory step should replace inconsistent, state-by-state tender requirements with uniform, tech-centric benchmarks that assess platforms based only on end-to-end encryption standards, Mediation Act compliance, and verifiable neutral-selection mechanics.

Alternatively, instead of allowing the different state governments to empanel the institutions, the central government itself empanel at the national level to avoid, multiplicity, duplicity, delay, and ensure uniformity in approach. Later, a list of empanelled institutions may be published by the centre. In the current situation, one institute functioning in one state can empanel itself on many state government portals.

This leaves the users with confusion. Choices can be offered to the user MSMEs by the centre taking the responsibility of empanelling the ADR/ODR institutions on its own. By turning the empanelment process from an administrative obstacle into a transparent, safe quality-assurance engine, India can develop a scalable digital justice framework capable of protecting the cash flows and commercial underpinnings of its small firm sector.

New Study Links Daily Almond Consumption to Better Brain and Metabolic Health in Adults with Prediabetes

New research published in the Journal of Nutrition indicates that a simple dietary change – eating just a few almonds each day – may benefit cognitive performance, metabolic health, and markers for inflammation and oxidative stress in middle-aged Asian Indian adults with prediabetes. Prediabetes affects more than 600 million people worldwide and is linked not only to an increased risk of type 2 diabetes but also to impaired brain function. In the 24-week study conducted in New Delhi, 60 Asian Indian adults aged 40 to 60 with prediabetes but no signs of cognitive decline were randomly assigned to either a control or intervention group after receiving guidance on following a balanced diet consistent with dietary guidelines for Asian Indians. While the control group continued with the same diet, the intervention group consumed a calorie-matched diet that included almonds, with almonds accounting for 20% of daily calories, equivalent to around 32-42g per day. Participants were monitored remotely twice a week and attended in-person visits every four weeks. Researchers assessed cognitive performance, blood glucose levels, HbA1c, blood lipids, weight, BMI and waist cir-



cumference at the beginning and end of the study.

At the end of the study, participants in the almond group experienced improvements in executive function and processing speed, both key measures of cognitive performance. The group also demonstrated better blood sugar control, including lower fasting blood glucose, lower blood glucose levels two hours after eating, and improvements in HbA1c, a marker of long-

term blood sugar control. Additional metabolic benefits included significant reductions in body weight, body fat, BMI, waist circumference, total cholesterol and LDL cholesterol. Participants consuming almonds also showed improvements in markers related to inflammation and oxidative stress.

Previous studies by the same researchers found almonds helped improve blood glucose control and body composition in Asian

Indians with prediabetes and type 2 diabetes. This study was the first to explore the potential impact of almonds on cognitive performance in middle-aged Asian Indian adults with prediabetes, a population particularly vulnerable to both metabolic disease and cognitive decline.

Dr. Anoop Misra, co-investigator and Chairman, Fortis-CDOC Center of Excellence for Diabetes, Metabolic Diseases, and Endocrinology in New Delhi, believes the findings from this exploratory study have the potential to support better brain health in millions of people around the world. "Adults with prediabetes are vulnerable to a decline in cognitive function," he says. "Our study indicates that just one simple dietary change – adding a small quantity of almonds to the daily diet – may help support brain health and improve cognitive performance in some populations."

But almonds offer other health benefits as well. "As with our previous research, we found that diets enriched with almonds benefit metabolic health measures like blood sugar control and body weight," confirms Dr. Misra. "Together, these changes could help lower

the risk of prediabetes progressing to type 2 diabetes, a condition associated with an increased risk of dementia."

Discussing the findings, Ritika Samaddar said, "With the growing issue of prediabetes and lifestyle-related health concerns, it is encouraging to see research highlighting how a simple dietary addition like almonds may support both metabolic and cognitive health. The findings showing improvements in cognitive function, blood sugar control, body weight, and cholesterol levels reinforce the role of almonds as a superfood. Their versatility and convenience make them an easy addition to everyday eating habits, while also providing important nutrients that support overall well-being."

Explaining the possible mechanisms behind the findings, Dr. Seema Gulati, lead researcher of the study and head of the Nutrition Research Group at the National Diabetes, Obesity and Cholesterol Foundation in New Delhi, explains, "Inflammation and oxidative stress are associated with cognitive decline. Our study found those in the almond group had lower levels of both, along with higher levels of a protective antioxidant (Vitamin E), compared with the control group."

How Marco Rubio Can Add Ambition To US-India Relationship

Some claim the US-India relationship is adrift, with New Delhi becoming an afterthought in Washington's world-view. However, Marco Rubio's first visit to India as Secretary of State has the potential to breathe more ambition into the partnership between the world's two largest democracies. US Ambassador Sergio Gor deserves great credit for his efforts to shore up a relationship buffeted by tariffs and sanctions, as well as Washington's approach to Islamabad. Secretary Rubio's visit can help advance key initiatives such as the Quad, which has been on pause for a year, by attending a foreign ministers' gathering of that key group.

There is much more that each side can do to infuse ambition and momentum. In a world of rising great power tension, Delhi and DC can signal a recommitment to a strategic convergence 25 years in the making. These can include a range of matters, detailed below.

Focus on critical minerals: Which minerals, in which countries, with which incentives to drive US and Indian private sector involvement? Copper from Zambia for data centres? Rhenium from Chile for jet turbines? Businesses will benefit from clear signals from both governments.

Data centres and nuclear power: Building on recent changes to laws in India that previously blocked American companies from nuclear power projects, both sides should encourage their private sectors to be at the vanguard of using civilian nuclear power to fuel the enormous investment in data centres in both countries.

Boost TRUST: In the bilateral spirit of "Transforming Relationship Utilising Strategic Technology", India could accelerate its leadership in digital public infrastructure by integrating American AI technology, a "win-win".

Quad shipbuilding: Japan, Australia, India and the US could usefully coordinate their comparative strengths to claw back China's lead in naval shipbuilding.

Pharmaceutical precursors: Two thirds of the material necessary for production of generic medicines comes from China, creating a vulnerability in healthcare supply chains. Delhi and Washington can usefully incentivise companies to source production in each other's countries for the general well-being of their citizens and greater security of supply chains.

Defence production: Delhi lacks trust in Washington, and Washington is frustrated by India's rejection of fighter plane proposals dating back to the 1980s. Both sides should focus on intensified, joint production of key deterrent items needed in quantities. For example, drones, where India has a burgeoning private sector innovation.

Trade deal: Glaringly absent in almost eight decades of bilateral relations is any framework for trade.

Completing negotiations on trade talks and giving reassurance to investors on both sides is essential.

If Washington and Delhi can advance their relations in a few key areas during Rubio's visit, it will expand mutual confidence and send a useful signal globally that official relations remain firmly on an ambitious track.

Happily, bilateral relationships extend far beyond government corridors to encompass people, business and academia. But even those areas face risks. As India rises as a global power, it needs to boost national spending on research and development.

WHY RUBIO'S VISIT SIGNALS BENGAL'S NEW ERA

Kolkata has once again entered an important diplomatic moment. For the first time in fourteen years, the city is hosting a serving United States Secretary of State. The visit carries symbolic and political significance, arriving at a time when Bengal has just witnessed a historic political transition and when India-US relations are moving through an important strategic phase.

US Secretary of State Marco Rubio, one of President Donald Trump's closest foreign policy advisers and also serving as Acting National Security Adviser, arrived in Kolkata as part of his four-day India visit from May 23 to May 26. His India itinerary includes Kolkata, Agra, Jaipur and New Delhi. Discussions during his broader India tour are expected to focus on energy cooperation, trade, defence and regional security issues. Rubio's flight landed at Kolkata airport at around 7:30 am. He visited the Missionaries of Charity and the Victoria Memorial before continuing with the next phase of his India tour. The timing of this visit is drawing attention for several reasons. It comes only weeks after Bengal experienced a major political change that ended a 15-year-old regime. It also arrives amid increasing strategic engagement between India and the United States. Before leaving for India, Rubio publicly described India as a "great partner" and indicated that Washington was prepared to expand energy exports substantially. That statement itself reflected a broader direction in US foreign policy toward India. Diplomatic visits are never random events. The itinerary of a visiting foreign dignitary is usually shaped through consultations between both countries. Yet the host government's priorities also influence these visits. Bengal now has a "double-engine" government, and there is a view within political circles that Delhi encouraged greater engagement with Kolkata at this stage. The state government is trying to project itself as investment-friendly, and officials believe this visit can help strengthen that narrative. There are indications that Chief Minister Suwendu Adhikari may also use the opportunity to brief foreign stakeholders about Bengal's economic possibilities, including infrastructure and



industrial projects such as the Falta Export Zone. For the present government, attracting investment is becoming central to its political and economic messaging. However, Kolkata and American diplomacy have a long and complicated history. The relationship has often moved through ideological disagreements, political resistance, and changing realities. There was a period when American diplomats visiting Kolkata faced a rough political climate. During the Left era, anti-American sentiment remained a visible political force. Opposition to American foreign policy, the Vietnam War, and what the Left described as American imperialism often shaped public discourse. One of the earliest examples came during the visit of former US Defence Secretary and later World Bank President Robert McNamara. McNamara, who served as US Defence Secretary from 1961 to 1968 and later became President of the World Bank from 1968 to 1981, visited West Bengal at a time when his role in the Vietnam War had made him a deeply controversial figure. As soon as McNamara arrived at the airport, CPM workers launched protests against him. Demonstrations were organised, reflecting the intensity of anti-American sentiment at the time.

Yet despite those protests, McNamara met state officials at the Writers' Building and continued with his scheduled engagements. That contradiction often defined Bengal politics. Ideology and practical governance frequently moved in parallel directions. Political observers have long argued that this anti-American approach shaped Bengal's political culture in many ways. Some believe it affected Bengal's work culture and industrial outlook as well. Whether one agrees or disagrees, that debate has existed for decades. Over time, however, things gradually changed. Under Jyoti Basu, a new form of political pragmatism emerged. Although the CPM maintained its ideological opposition to American policies, Basu also recognised the need for economic engagement. From 1977 to 2000, as one of India's longest-serving Chief Ministers, Jyoti Basu actively pitched West Bengal as an investment destination. He met American officials and business delegations and encouraged foreign investment. Political opponents often mocked this shift. Congress leaders coined phrases such as "from revolution to reception" and even joked about "Uncle Sam at Alimuddin Street." Critics argued that a party built on

anti-American rhetoric was now welcoming US officials. But Basu defended this approach. In 1994, Jyoti Basu himself visited the United States and met corporate leaders to encourage investment in Bengal. Later, during 1995 and 1996, efforts were made to facilitate technology partnerships connected with projects like Haldia Petrochemicals. Basu often argued that supporting socialism and engaging with the United States were not mutually contradictory positions. He could praise Cuba and at the same time, hold conversations with American diplomats. For him, governance required flexibility. Still, ideological tensions never completely disappeared. Controversies continued in later years as well. In 2011, then chief minister Mamata Banerjee made a statement on television claiming that US officials regularly visited Alimuddin Street. She remarked, "I am part of the government, and I know many things." The Left challenged her to reveal names. That statement triggered political debate at the time. The issue showed that relations between Kolkata and American diplomacy had remained active beneath the surface, regardless of changing governments. Then came another important visit. In 2012, then US Secretary of State Hillary Clinton

visited Kolkata and met Chief Minister Mamata Banerjee at Writers' Building. Many political observers believed that Kolkata formed only one part of a larger regional diplomatic strategy. After Kolkata, Clinton travelled to Bangladesh. Some analysts argued that Bangladesh itself was central to that diplomatic effort. Hillary Clinton had once remarked that despite travelling widely across the world, she had always wanted to visit Bangladesh. That added another layer of significance to her Kolkata stop. Now another chapter appears to be unfolding. Unlike earlier periods marked by ideological hesitation, the current political environment is different. With Suwendu Adhikari leading the government and receiving support from Delhi, there is a belief within sections of the administration that a larger flow of American investment could become possible, particularly under the present political climate. Rubio himself underlined the broader strategic value of India-US ties. His diplomatic engagement will culminate in New Delhi on May 26, when India hosts the Quad Foreign Ministers' meeting involving the United States, Japan and Australia. Yet beyond trade and diplomacy, a larger geopolitical context also exists.

Beyond Bakri Eid Debate, Decoding Suwendu Adhikari's Emerging Bengal Model

A series of developments around Bakri Eid in West Bengal have triggered political debate and opened a larger discussion about governance, administration, religious accommodation, and the evolving political approach of the new BJP government under Chief Minister Suwendu Adhikari. The developments are being viewed not as isolated administrative decisions but as signals of a broader political framework the BJP government appears to be building in Bengal. The first development concerns the traditional Eid prayers at Kolkata's Red Road. This year, the customary Eid congregation will not be held on Red Road. Instead, prayers are scheduled to take place at the nearby Brigade Parade Ground on May 28. For many years, the Khilafat Committee has organised Eid prayers in Kolkata. The Joint Commissioner of Kolkata Police, Suvdeep Sarkar, said Eid prayers will not be allowed on the roadway and that arrangements have been made at Brigade Parade Ground. There is also uncertainty regarding another long-standing Eid congregation at Park Circus and Syed Amir Ali Avenue. The second development relates to government holidays around Eid-ul-Adha. The West Bengal government revised the holiday schedule. According to earlier notifications, May 26 and May 27 had been designated as public holidays. Subsequently, changes were introduced, and the two-day holiday structure was modified. This move has



drawn political attention because such decisions are often viewed not only from an administrative perspective but also through the lens of symbolism and messaging. The third and perhaps most debated issue concerns animal sacrifice during Eid and the legal framework surrounding it. The matter has become linked with interpretations of the West Bengal Animal Slaughter Control Act. When the law came into force in the early 1950s, it included certain geographical provisions. There were questions whether it would be applicable only in municipal areas and how it would function in rural or panchayat regions. Debates subsequently intensified over whether enforcement could differ between urban and non-urban areas. The issue eventually reached courts. The state government had earlier issued a notification on the matter. Subsequently, a contempt notice was served

after allegations emerged that directions from the court had not been adequately followed. The Division Bench headed by Chief Justice Sujoy Paul had instructed the government to examine whether any procedural relaxations or clarifications regarding slaughter regulations were necessary under provisions of the West Bengal Animal Slaughter Control Act. The court reportedly observed that the state had neither submitted a satisfactory response nor taken visible steps following earlier directions. Consequently, notices were sent to senior officials, including the Chief Secretary, Secretaries of Animal Resources Development, Home, Health, and related departments. The legal challenge had been brought before the court by Citizen Forum for Social Justice, along with multiple petitions questioning the government on the matter. Supporters of the petition argued that uncer-

tainty had emerged regarding the conduct of Qurbani rituals. They also pointed out that cattle-rearers and livestock owners often prepare economically for this period, and uncertainty can create financial strain. Advocate Bikash Ranjan Bhattacharya argued before the court that the West Bengal Animal Slaughter Control Act was originally designed with broader agricultural and livestock protection objectives. As a result, the issue has now become part legal debate and part political conversation. Yet one thing appears clear: there is no visible shift in the broader political position of the BJP government under Suwendu Adhikari or the central BJP leadership. The BJP's position appears to be that every community should receive equal rights under a common framework and that no particular community should be perceived as receiving exceptional concessions beyond what others receive.

The Voice That Is Going Silent: What India Loses When Radio Dies

We have all experienced this in the early morning commute. A voice cuts through traffic noise with a local reference, something specific, a forthcoming event, traffic update, a joke about the weather, and then a song you had forgotten you loved. For two decades, that voice was FM radio. It knew your city. It talked to you as if it lived there too. Now, that voice is going quiet. Several major private FM operators in India have begun surrendering broadcast licences. Expansion plans have halted. Local programming is shrinking. The industry that once placed itself at the heart of urban India's daily rhythm is retreating. Sun TV Network, Music Broadcast Limited and other listed radio entities have reported sustained revenue pressure. India's radio advertising market, once growing at double digits, has been contracting in real terms against digital's explosive rise. At first glance, this makes no sense. India's appetite for audio content is growing unabated. Music consumption is at an all-time high. Podcasts are growing rapidly. Earphones are ubiquitous. Commutes still happen, and people spend hours in transit. Audio, as a medium, has never been more central to Indian daily life. So why is FM radio weakening to near collapse even as audio consumption grows? Radio is struggling because the world it was built for no longer exists. When, at first, private FM radio expanded aggressively in India from the early



2000s, the logic was airtight. Spectrum was scarce and controlled by the government. Music discovery depended on intermediaries, and you needed someone to play the songs for you. Cities had few entertainment options during commuting hours. The radio jockey was not merely a presenter but more the listener's primary guide to popular culture. Then the smartphone arrived and invalidated every one of those assumptions. Today, a listener can instantly access Spotify playlists, YouTube music streams, JioSaavn radio stations, algorithmically curated mood feeds, regional podcasts, devotional content and short-form audio entertainment, all free, all personalised, all available without a fixed schedule. Radio's historic advantage, that it was simply the easiest audio option available, was vaporised almost overnight. Still, technology alone does not explain the depth of the cri-

sis. The deeper failure is one of regulatory design. Private FM radio in India was, for years, effectively barred from broadcasting news, restricted from political commentary, constrained in content choices and trapped in a city-by-city licensing structure that made achieving programming economics at a national scale difficult. The result was a medium locked into a single format with Bollywood songs, RJ banter and local advertising. That format worked in the pre-streaming era. In the streaming era, it became indefensible. Spotify can do music better. Algorithms can do personalisation better. What radio could have built was a genuine spoken-word ecosystem, civic broadcasting, personality-driven commentary, and regional cultural programming; it was largely prevented from building. Compare this to the United States. American radio evolved beyond music

decades ago into talk radio, sports commentary, financial advice, political broadcasting and deeply loyal personality-driven formats. Radio personalities became intellectual and cultural brands in their own right. iHeartMedia, the largest US radio group, operates over 860 stations but derives substantial revenue from podcasts, live events, and digital content. India never developed that architecture. Indian private radio remained commercially narrow, and when digital platforms arrived with infinite supply at near-zero distribution cost, radio had almost no defensive moat left. Think of who loses most when local audio voices disappear. Streaming platforms are global. Audio intimacy is local. That connection, once lost, does not easily return. India has hundreds of millions of citizens who are comfortable passive listeners but who are not habitual readers or active screen users.

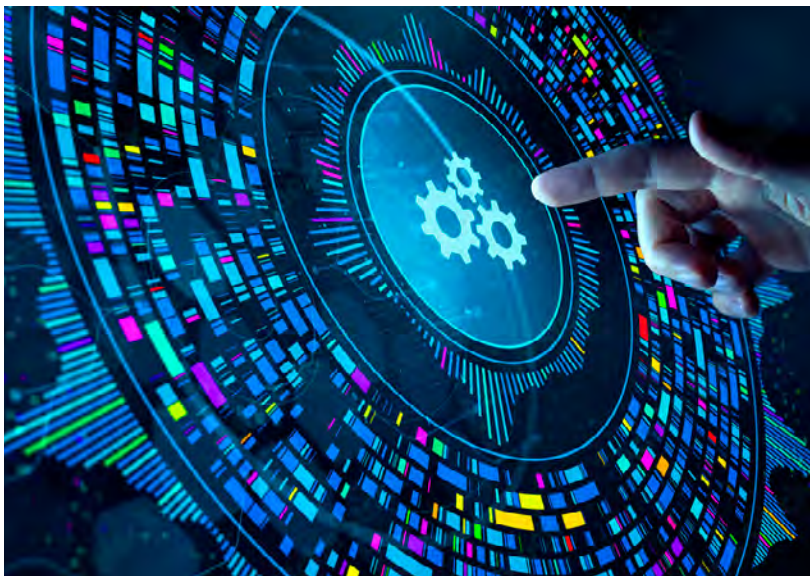
The Human Immunome Project’s Strategic Blueprint To Harness AI and Immunology

The Human Immunome Project has released a Scientific Plan to create the world’s largest immunological dataset and develop AI models to better understand and leverage the immune system for improved health outcomes globally. The plan involves establishing global study sites and developing advanced AI tools to analyze immune system variations and responses.

The Human Immunome Project (HIP), a global nonprofit scientific initiative, released its Scientific Plan today, April 29, on World Immunology Day, the organization announced. The plan provides a detailed roadmap of how the Human Immunome Project and its network of global study sites will generate the world’s largest and most diverse immunological dataset and use these data to power publicly available AI models of the immune system. Importance of the Immune System

“The immune system is the epicenter of human health, and our newly released Scientific Plan outlines an actionable, global strategy for how we can unlock the secrets of the immune system and harness its power to improve health for all,” said Dr. Hans Keirstead, CEO of the Human Immunome Project.

The human immune system is one of the most complex systems in the world—and one of its most important. It determines whether we survive infancy, which diseases we get, how we age, and how long we’ll live. Understanding our immune system is the key to fighting disease and improving health for all. Yet its complexity has limited our ability to tap



into its potential—until now. Despite these tremendous advances, our understanding of the immune system remains limited: less than one percent of the immunological data necessary to understand immune function and diversity on a global scale are available. As such, HIP’s first mission is generating diverse immunological datasets at scale.

Global Data Collection Efforts To generate these data, HIP is establishing a network of global study sites that reflect the diversity of humanity (across age, ethnicity, geography, sex, and socioeconomic status) and immune responses. Data will be generated through a phased approach and enabled by HIP-engineered Immune Monitoring Kits—a collection of assays and operating procedures that facilitate rapid, robust, and standardized data collection worldwide.

This collaborative, global effort will produce longitudinal, baseline datasets that enable

scientists to assess developmental and age-dependent changes and computationally stitch together the health trajectory of different population groups worldwide. For more details on the global study protocol, review the summary.

Pilot Sites and AI Development With the Scientific Plan now fully articulated, the Human Immunome Project is working to establish its initial Pilot Sites—up to 10 state-of-the-art sites that will collect data, help refine the site model, and prepare HIP for scale. These sites will be spread globally with a focus on the Global South and sub-Saharan Africa, specifically.

As data collection progresses, HIP will begin to develop AI models—first predictive, then mechanistic—that will deepen our understanding of immune responses and individual and population-based health trajectories. These models will provide a holistic view of the immune system and empower

scientists with a new, transformative tool to advance drug development, strengthen personalized medicine, and increase healthspans. These data and models will additionally produce new insights relevant to nearly all health conditions, including key global health challenges related to maternal health, aging and cognitive decline, and disease evolution.

Collaboration and Refinement of the Scientific Plan

An initial draft of HIP’s Scientific Plan was shared with a group of global experts at the “Human Immunome Project Into Action Conference,” hosted at CosmoCaixa Museum of Science by the Caixa Research Institute and HIP in November 2023. The conference provided participants an opportunity to input into the Scientific Plan and concluded with an endorsement of the mission and vision of the Human Immunome Project. Since November, HIP’s science team, led by Dr. John Tsang, Dr. Shai Shen-Orr, and Dr. Orit Lavi, has refined the plan using feedback gathered at the conference. The result is a detailed strategy to decode and model the immune system with the ultimate goal of improving health for all. “The Human Immunome Project is at the cutting edge of scientific discovery and is uniquely positioned to provide the scientific and medical communities with the knowledge and tools to innovate new diagnostics, drugs, vaccines, and immunotherapies that can address disease, elongate healthspans, and enable more personalized and more effective healthcare for all. I could not be prouder to lead this global effort,” said Dr. Keirstead.

From Theory to Therapy: MIT’s Computational Breakthrough in Protein Optimization

MIT researchers plan to search for proteins that could be used to measure electrical activity in the brain. To engineer proteins with useful functions, researchers usually begin with a natural protein that has a desirable function, such as emitting fluorescent light, and put it through many rounds of random mutation that eventually generate an optimized version of the protein. This process has yielded optimized versions of many important proteins, including green fluorescent protein (GFP). However, for other proteins, it has proven difficult to generate an optimized version. MIT researchers have now developed a computational approach that makes it easier to predict mutations that will lead to better proteins, based on a relatively small amount of data. Using this model, the researchers generated proteins with mutations that were predicted to lead to improved versions of GFP and a protein from adeno-associated virus (AAV), which is used to deliver DNA for gene therapy. They hope it could also be used to develop additional tools for neuroscience research and medical applications. “Protein design is a hard problem because the mapping from DNA sequence to protein structure and function is really complex. There might be a great protein 10 changes away in the sequence, but each intermediate change might correspond to a totally nonfunctional protein. It’s like trying to find your way to the river basin in a mountain range, when there are craggy peaks along the way that block your view. The current work tries to make the riverbed easier to find,” says Ila Fiete, a professor of brain and cognitive sciences at MIT, a member of MIT’s McGovern Institute for Brain Research, director of the K. Lisa Yang Integrative Computational Neuroscience Center, and one of the senior authors of the study.

Regina Barzilay, the School of Engineering Distinguished Professor for AI and Health at MIT, and Tommi Jaakkola, the Thomas Siebel Professor of Electrical Engineering and Computer Science at MIT, are also senior authors

of an open-access paper on the work, which will be presented at the International Conference on Learning Representations in May. MIT graduate students Andrew Kirjner and Jason Yim are the lead authors of the study. Other authors include Shahar Bracha, an MIT postdoc, and Raman Samusevich, a graduate student at Czech Technical University.

Optimizing Proteins Many naturally occurring proteins have functions that could make them useful for research or medical applications, but they need a little extra engineering to optimize them. In this study, the researchers were originally interested in developing proteins that could be used in living cells as voltage indicators. These proteins, produced by some bacteria and algae, emit fluorescent light when an electric potential is detected. If engineered for use in mammalian cells, such proteins could allow researchers to measure neuron activity without using electrodes.

While decades of research have gone into engineering these proteins to produce a stronger fluorescent signal, on a faster timescale, they haven’t become effective enough for widespread use. Bracha, who works in Edward Boyden’s lab at the McGovern Institute, reached out to Fiete’s lab to see if they could work together on a computational approach that might help speed up the process of optimizing the proteins. “This work exemplifies the human serendipity that characterizes so much science discovery,” Fiete says. “It grew out of the Yang Tan Collective retreat, a scientific meeting of researchers from multiple centers at MIT with distinct missions unified by the shared support of K. Lisa Yang. We learned that some of our interests and tools in modeling how brains learn and optimize could be applied in the totally different domain of protein design, as being practiced in the Boyden lab.” For any given protein that researchers might want to optimize, there is a nearly infinite number of possible sequences that could be generated by swapping in different amino acids at each position within the sequence.

In Coimbatore, youths wearing cockroach masks took part in a procession organised by the DYFI district unit. The rally started near the Corporation Boys Higher Secondary School in Sidhapudur, Gandhipuram, and concluded near the

Gandhipuram bus stand. Police personnel were deployed for security arrangements. Organisers said the protests were aimed at drawing the Union government’s attention to issues such as unemployment, alleged irregularities in the NEET examination, and rising petrol and diesel prices. They also demanded educational rights and action against corruption. The organisers further stated that the “Cockroach” identity emerged after recent remarks by the Chief Justice of India comparing youths to “cockroaches and parasites”. Following this, a satirical social media campaign named Cockroach Janata Party (CJP) gained traction online, especially among Gen Z users. According to organisers, youth facing unemployment and livelihood challenges across the country have started identifying themselves with the symbol as a form of protest.

TAMIL NADU: OVER 2.50 LAKH STUDENTS APPLY FOR OVER 82,888 RTE SEATS

CHENNAI: For the private school seats under the Right to Education (RTE) Act, over 2.50 lakh students have applied for 82,888 vacancies across Tamil NAs per the data released by the Directorate Of Matriculation School, over 82,000 seats have been listed from 7,740 schools across the state. And, for these vacancies, 2,51,537 students have applied. Also, the department has clarified that admission orders are yet to be consolidated because some students may be selected in more than one school. They will get admission as per the parent’s choice. A department official said, “The verification of documents was done till



May 19 after the applications were categorised as; eligible, ineligible and document missing. The lottery system was done in presence of officials for selecting seats on May 22. And, admissions are likely to be held soon.” As per the notification

from the Directorate of Private Schools, the number of seats (25% as per RTE Act) is calculated based on the total entry-level student strength in the Education Management Information System (EMIS) portal. The details of available seats were already published at all the school notice boards. Following this, parents have applied for the RTE seats from April 20 till May 18 online. Also, only schools with valid recognition and approvals are eligible to admit students under RTE for 25 reservations. And, as per Tamil Nadu Schools Fee Regulation Act, 2009, fee details of these schools have been uploaded in EMIS.

Coimbatore Horror: Accused says he strangled victim after she screamed

COIMBATORE: A 33-year-old construction worker arrested in connection with the sexual assault and murder of a 10-year-old girl near Sular in Coimbatore district allegedly told police that he strangled the child after she screamed during the assault, investigators said. The accused, Karthik, and his friend Mohan, 30, were arrested by Sular police after CCTV footage allegedly showed Karthik taking the girl on his motorcycle. The child’s body was later recovered from bushes near a coconut grove close to the Kannampalayam lake bund. According to investigators, the girl had been playing near her house when Karthik allegedly approached her, offering to buy chocolates and snacks. Police said he first stopped at a shop before taking the child towards an isolated stretch near the lake bund. During interrogation, Karthik allegedly told police that he sexually assaulted the child in a coconut grove area. Investigators said the

girl screamed during the assault and continued shouting despite threats, following which he allegedly strangled her, fearing that others might hear the noise. Police said the accused later abandoned the body in nearby bushes. Investigators further stated that Karthik allegedly informed Mohan about the crime, but the latter neither alerted authorities nor revealed the information while participating in the search for the missing child along with local residents and relatives.

Plant-based diets may reduce menopause weight gain: Study

Boston, May 23: A new study has found that plant-based diets rich in fruits, vegetables, legumes and whole grains may help women manage weight gain and reduce obesity risk during menopause. The research, conducted by scientists from Harvard University and the National University of Singapore, tracked the eating habits and weight changes of more than 38,000 women over a 12-year period surrounding menopause. The findings, published in JAMA Network Open on May 20, suggested that healthy dietary patterns could significantly influence metabolic health during menopause, a stage often associated with hormonal changes and weight gain. Researchers analysed dietary habits using data from the long-running Nurses’ Health Study II, which began in 1989 and involves female nurses across the United States. Participants completed detailed food questionnaires every four years, allowing researchers to assess adherence to various diets including the Mediterranean diet, DASH diet, plant-based diets and the Planetary Health Diet. The study found that women who followed healthier diets gained less weight and had a lower risk of obesity compared to those consuming diets high in processed foods, red meat and salty snacks. Researchers noted that the Planetary Health Diet offered the strongest protection against obesity. The diet focuses on plant proteins, healthy fats, fruits, vegetables and whole grains while limiting red meat and refined carbohydrates. The study also highlighted that diets with lower insulin-boosting potential were linked to the least weight gain. Foods such as processed meats, fried potatoes and salty snacks were associated with increased obesity risk. Consumption of ultra-processed foods, including sugary drinks and packaged snacks, was also linked to greater weight gain during menopause. Experts said menopause-related hormonal changes, particularly declining estrogen levels, often

Centre plans national registry to monitor implantable medical devices



The Centre is planning to tighten regulation of implantable medical devices by creating a national registry to track products and patients, a move aimed at improving accountability, monitoring safety and preventing the use of low-quality devices. According to officials, the proposal is currently under consideration at the highest levels of government and an announcement is expected soon. The proposed registry will initially focus on cardiac and orthopaedic implants, with manufacturers, suppliers and hospitals likely to be mandated to maintain detailed records of implanted devices. The system is expected to be expanded gradually to include all implantable medical devices. Officials said the registry would help authorities track devices in case of global recalls, adverse events or safety concerns, while also helping frame better procurement policies under government healthcare schemes. The move is also expected to strengthen oversight against cheap and low-quality imports entering the Indian market from neighbouring countries. India’s medical devices industry, currently estimated at around 15 billion dollars, is projected to grow to nearly 50 billion dollars by 2030. More than one million high-risk implantable devices — including cardiac stents, pacemakers,

artificial joints and spinal implants — are reportedly used annually across the country. Rajiv Nath, forum coordinator of the Association of Indian Medical Devices Industry, welcomed the proposal and said India currently lacks a proper mechanism to trace implanted devices. “India implants lakhs of devices every year but cannot trace them. A National Implant Registry will help identify patients during recalls, monitor real-world safety and build Indian evidence,” he said. Industry representatives believe the registry would create end-to-end accountability from manufacturers to patients and significantly improve patient safety standards. India’s implantable medical device sector has long faced concerns relating to regulatory gaps, heavy dependence on imports, rising costs and inadequate monitoring systems. The Centre had introduced the National Medical Devices Policy in 2023 to strengthen regulation and encourage domestic manufacturing in the sector. Cardiac stents continue to account for a significant number of reported adverse events involving medical devices in India, while concerns have also emerged in recent years over faulty knee and spinal implants.

Obesity, diabetes emerging as major health crisis in India: Experts

New Delhi, May 24: India is witnessing a sharp rise in obesity and diabetes cases, with health experts warning that sedentary lifestyles, unhealthy diets and increasing stress levels are driving a growing public health crisis across the country. Recent studies and health reports show that obesity levels are increasing rapidly among both adults and children, raising concerns over metabolic disorders, fatty liver disease, heart ailments and early-onset diabetes. According to the World Obesity Atlas 2026, India is among the top countries globally



in the number of overweight and obese children. Nearly 41 million children aged between 5 and 19 are living with high Body Mass

Index (BMI), reports stated. Experts said urban lifestyles marked by poor sleep, processed food consumption, reduced physical activity and excessive screen time are contributing significantly to the rise in obesity-related diseases among younger people. A recent report cited by health researchers estimated that India has over 101 million people living with diabetes and around 136 million at pre-diabetic risk. Medical experts have also warned that obesity increases the risk of severe infections, cardiovascular diseases and other

chronic illnesses. A Lancet study found that adults with obesity are significantly more likely to require hospitalisation due to infections. The Union government has recently intensified monitoring of GLP-1 weight-loss and diabetes drugs, cautioning against unsupervised use and misleading advertisements related to obesity treatment medications. Health specialists stressed the need for preventive healthcare measures, including regular exercise, balanced diets, early screening and greater public awareness to tackle the growing metabolic health burden.

STRAIT OF HORMUZ TO RE-OPEN?

Trump Says Agreement With Iran 'Largely Negotiated'

US President Donald Trump claimed that a truce deal with Iran had been "largely negotiated", as part of which the Strait of Hormuz will be reopened. Finer details of the deal are yet surface. "An Agreement has been largely negotiated, subject to finalisation between the United States of America, the Islamic Republic of Iran, and the various other Countries, as listed," he announced via a post on TruthSocial on Saturday. He highlighted that apart from the other aspects of the deal, the Strait of Hormuz will be opened.

However, Fars News, a semi-government Iranian media agency, has since then denied the claim that the key maritime shipping lane will be re-opened. Disputing Trump's social media post Fars outlined that the Strait of Hormuz will remain under Iranian control according to the latest version of the proposal exchanged between the US and Iran. America's version of finalising a truce deal would include points that aim to end hostilities with



Iran, while gradually opening the Strait of Hormuz and ending the US Blockade. Further, the agreement would unfreeze some Iranian assets that are held in banks outside Iran, as per reports. A clock of at least 30 days for continued negotiations will begin post a broad agreement is in place, meant to help break the remaining bones of contention between the two parties, such as Iran's nuclear programme and its stockpile of near-weapons-grade ura-

nium. Trump said final details were still being sorted, and it remained possible that some aspects of the memo could change. Fars News, on the other hand, emphasised that Trump's claims about the Strait reopening are "not true" and "inconsistent with reality." "Although Iran has agreed to allow the number of passing vessels to return to pre-war levels, this in no way means 'free passage' as it existed before the war," the outlet reported.

Trump stated he had a "very good call" on Saturday from the Oval Office with a group of Gulf and regional leaders, including officials from Saudi Arabia, the United Arab Emirates, Qatar, Pakistan, Turkey, Egypt, Jordan and Bahrain, to discuss negotiations surrounding Iran and what he described as a memorandum of understanding tied to "PEACE." A senior Iranian source told Reuters on Sunday that Tehran has not agreed to hand over its stock-

pile of highly enriched uranium, pushing back against earlier reports suggesting such a commitment was part of ongoing negotiations with the United States. The source said Iran's nuclear programme was not included in the preliminary understanding currently under discussion between Washington and Tehran. "The nuclear issue will be addressed in negotiations for a final agreement and is therefore not part of the current deal. There has been no agreement over Iran's highly enriched uranium stockpile to be shipped out of the country," the source told Reuters. The remarks come after two US officials told The New York Times that Iran had, in principle, agreed to relinquish its stockpile of highly enriched uranium as part of a broader diplomatic framework aimed at reducing tensions in West Asia. According to the report, the mechanism for transferring or neutralising the uranium would be worked out during subsequent negotiations after a formal agreement is reached.

MCAP OF 6 OF TOP-10 MOST VALUED FIRMS SURGES BY RS 74,111 CR

New Delhi: The combined market valuation of 6 of the top-10 most valued firms surged by Rs 74,111.57 crore last week, with Reliance Industries emerging as the biggest gainer. Last week, the BSE benchmark climbed 177.36 points, or 0.23 per cent. "Markets ended the week with marginal gains amid a highly volatile and range-bound trading environment. Benchmark indices witnessed sharp intraday swings throughout the week, driven by persistent rupee weakness, mixed global cues, sectoral rotation, and continued uncertainty around inflation and interest rates," Ajit Mishra – SVP, Research, Religare Broking Ltd, said. From the top-10 pack, Reliance Industries, ICICI Bank, Tata Consultancy Services (TCS), Bajaj Finance, Larsen & Toubro, and Life Insurance Corporation of India (LIC) were the gainers, while HDFC Bank, Bharti Airtel, State Bank of India and Hindustan Unilever faced erosion from their valuation. Reliance Industries added Rs 24,696.89 crore,



taking its market valuation to Rs 18,33,117.70 crore. The valuation of TCS jumped Rs 19,338.68 crore to Rs 8,38,401.33 crore, and that of ICICI Bank surged Rs 14,515.93 crore to Rs 9,06,901.32 crore. LIC's valuation climbed Rs 9,076.37 crore to Rs 5,14,443.69 crore. Jaishankar Raises Visa Concerns With Rubio, Says Legal Mobility Must Not Be Hit By US Immigration Curbs

External Affairs Minister S Jaishankar raised concerns on Sunday over the Trump administration's changes to visa and immigration policies during talks with US Secretary of State Marco Rubio, saying legal mobility should not be adversely impacted by the new approach. Speaking at a joint media briefing after wide-ranging discussions with Rubio, Jaishankar said people-to-people ties remain central to the India-US relationship and flagged challenges faced by legitimate Indian travellers in obtaining visas. "People-to-people ties are at the heart of the relationship. I apprised Secretary Rubio of challenges that legitimate travellers face in respect to visa issuance," Jaishankar said. "While we cooperate to deal with illegal and irregular mobility, our expectation is that legal mobility would not be adversely impacted as a consequence. After all, this is very relevant to our business, technology and research cooperation," he added. The remarks come amid concerns in India over changes to US immigration



rules, including higher HIB visa fees and revised green-card procedures that reportedly require applicants to file from their home countries. Responding to a question on alleged incidents of racism against Indians in the United States, Rubio dismissed suggestions of sys-

temic targeting while acknowledging isolated remarks by individuals. "I will take that very seriously about the comments. I'm sure that there are people who have made comments online and in other places because every country in the world has stupid people,"

Rubio said. "I am sure there are stupid people here; there are stupid people in the United States who make dumb comments all the time," he added. Rubio said immigrants had played a key role in shaping the United States. "Our nation has been enriched by people who have come to our country from all over the world, become Americans, assimilated into our way of life, and contributed greatly," he said. On the changes to Green Card norms, Rubio said the reforms were part of a broader overhaul of the immigration system and were not specifically directed at India. "We've had a migration crisis in the United States. This is not because of India, but broadly, we have had over 20 million people illegally enter the United States over the last few years, and we have had to address that challenge," he said. "The US is the most welcoming country in the world on immigration," Rubio added. Responding to a separate question, Jaishankar said both New Delhi and Washington were pursuing policies driven by national interests.

BLAST TARGETING TRAIN KILLS AT LEAST 20 IN PAKISTAN

At least 20 people have been killed and 70 others injured in an explosion targeting a train transporting military personnel in Pakistan. The blast occurred while the train was travelling through Chaman Phatak station in Quetta, the capital of the western Balochistan region, on Sunday morning. Railway officials told BBC Urdu that three coaches and the engine were derailed while two were overturned. The shuttle service had primarily been transporting service personnel and their families who had been returning home for Eid. The Balochistan Liberation Army (BLA) separatist group claimed responsibility for the attack, saying it was a suicide bombing. Pakistani officials have not yet confirmed this. Images from the scene show burnt-out and mangled carriages and nearby cars, as well as bomb damage to a nearby building. "The train was moving and there were passengers



on board when the explosion occurred," Naseer Ahmed, a local resident, told the BBC. He said that, as it had been a Sunday morning, his family had been asleep when the blast happened, shattering all

his windows. Eyewitnesses said a vehicle laden with explosives drove into the train, causing the explosion. A police officer and civil administration official in Balochistan confirmed to BBC

Urdu that 20 people had been killed, with fears the death toll could rise. Officials said three soldiers were among the dead. Pakistan's Prime Minister Shehbaz Sharif strongly condemned the attack, saying

"such cowardly acts of terrorism cannot weaken the resolve of the people of Pakistan". "The entire nation stands in solidarity with the people of Balochistan in this hour of grief," he added. An

emergency has been declared in hospitals treating victims. Those aboard the train had been on their way to Quetta's main railway station from a nearby military encampment, officials said. From there, they were due to travel to Peshawar and then on to their home towns for the holiday. It is not the first time the BLA has targeted trains in Balochistan. In the past two years, the Jaffar Express has come under attack from the armed group many times. Militants hijacked a train and took a number of passengers hostage while en route to Peshawar in March 2025. The BLA accuses Pakistan's federal government of exploiting the rich mineral resources of its largest province without the local population benefitting. Balochistan covers nearly 44% of the country's land, sharing volatile borders with Iran and Afghanistan, and covering part of the Arabian Sea coastline.

CALIFORNIA DECLARES EMERGENCY AS FIRE CREWS RACE TO CONTAIN TOXIC LEAK



California Governor Gavin Newsom has declared a state of emergency as crews race to contain a toxic chemical leak at a manufacturing facility in Orange County. A tank containing about 7,000 gallons of methyl methacrylate, a highly volatile and flammable substance used to make plastic, was at risk of failure, officials warned. Thousands of Garden Grove residents are under evacuation orders as a precaution. Officials said on Saturday that the temperature in the tank was higher than previously thought and it was continuing to rise. Orange

County Fire Authority division chief Craig Covey said they were planning for two scenarios: "Does it rupture and spill, or does it blow up?" The aerospace facility is about 5 miles (8km) from the Disneyland theme park, which is outside the evacuation zone and is open as normal. The facility is about 35 miles south-east of Los Angeles. The cause of the failing tank is under investigation and emergency crews have been spraying it with water to try to stabilise the temperature. Officials said an "inoperable valve" had created "additional operational challenges".

Bolivian minister's convoy ambushed while overseeing roadblock clearance



The convoy of Bolivia's public works minister was ambushed by protesters and briefly disappeared while overseeing the clearing of roadblocks on Saturday. Mauricio Zamora's vehicle was intercepted in the town of Copata on Saturday afternoon and became separated from the group, local media reported. He was later located and is now safe. He had been in command of an operation to clear barriers set up by anti-government protesters aimed at slowing the flow of goods into the administrative capital, La Paz, and nearby El Alto. The mission to create so-called "humanitarian corridors" was met by renewed violence from demonstrators, with some convoys reportedly attacked with stones and dynamite. Marches, protests and roadblocks by trade unions and supporters of left-wing former President Evo Morales have intensified this week, with clashes with security forces in La Paz. The demonstrators are hoping to put pressure on Bolivia's centre-right President Rodrigo Paz to resign just six months after taking

office over his government's austerity measures, with his alignment with the US another divisive issue. Bolivia's police and military were dispatched from major cities in the early hours of Saturday morning to clear the roadblocks, deploying bulldozers to clear rocks and concrete pillars, aiming to ease the flow of food and medicine into the capital. But in several places, clashes with protesters broke out and roadblocks were re-established. Zamora's convoy had been travelling through Copata, south of La Paz, when residents began pelting it with stones and dynamite, local media reported. His vehicle became separated from the others as they retreated but was able to take a dirt road, according to Agencia Noticias Fides (ANF). Here, though, it suffered a second ambush before eventually being able to reunite with the convoy. Elsewhere, protesters looted and burnt down a customs post in Achichá Arriba, on the highway into El Alto, after police used tear gas to attempt to disperse protesters there. Near Caracollo, north of Oruro, a convoy was attacked with explosives.

MAN KILLED IN SHARK ATTACK OFF AUSTRALIA'S NORTH-EAST COAST



A man has died after being attacked by a shark off the coast of the north-eastern Australian state of Queensland, police have confirmed. Emergency services were called to a boat ramp on the Cassowary Coast, between the cities of Cairns and Townsville, just before noon local time on Sunday, following reports of a 39-year-old being attacked

while swimming out at a nearby shoal. Queensland Police said in a statement that the man was retrieved from the water but died from his injuries. It is the second fatal shark attack in Australian coastal waters in as many weeks, after a 38-year-old was killed while spearfishing near Perth, in Western Australia, last Saturday.

Rubio says 'significant progress' made in Iran talks as details of potential deal emerge

Iranian President Masoud Pezeshkian says his country is "ready to assure the world" that it is not seeking nuclear weapons, according to state media. The Islamic Republic News Agency (IRNA) quotes the president in a post on Telegram as saying: "Prior to the martyrdom of Ayatollah Khamenei, Iran's late Leader, we declared - and we reiterate now - that we are ready to assure the world we do not seek nuclear weapons." According to the agency, the president adds that Iran "does not desire regional instability" and that it is "the Israeli regime... that seeks to destabilise the region". But he says Iranian negotiators will not "compromise on the dignity and honour of the country". It comes as US Secretary of State Marco Rubio has hinted that



President Donald Trump may make an announcement later today on negotiations. On Saturday, Iranian foreign ministry spokesman Esmail Baghaei told state television that US and Iranian positions had been converging in the last week, but also accused the US of "contradictory statements". Baghaei said Iran was in the process of finalising a "memorandum of understanding"

which would allow additional talks so that "ultimately a final agreement can be reached". Late on Saturday, US President Donald Trump said a deal with Iran had been "largely negotiated" and said details would soon be announced. Ishaq Dar, deputy prime minister of Pakistan, who has been mediating talks, has said that recent negotiations are "grounds for optimism" that

a positive outcome is "within reach". US Secretary of State Marco Rubio, speaking to reporters in New Delhi earlier, said "significant progress" had been made on a potential deal, but not "final progress". He hinted at news on the Strait of Hormuz, said Iran can "never possess a nuclear weapon" and added that there is still "work to do". Meanwhile, UK Prime Minister Keir Starmer and EU Commission President Ursula von der Leyen have both released statements welcoming reports of progress, with both stating Iran must not be allowed to possess a nuclear weapon. The effective closure of the Strait of Hormuz since the beginning of the conflict has impacted shipping across the globe.

SUSPECT KILLED AFTER OPENING FIRE ON SECRET SERVICE NEAR WHITE HOUSE

A suspect who shot at a White House checkpoint was killed in an exchange of fire with Secret Service agents on Saturday evening, officials have confirmed. The BBC's US media partner CBS has named the suspect as Nasire Best, a 21-year-old man who was known to the protection agency and had a documented history of mental health conditions. US President Donald Trump thanked the officers for their "swift and professional action" in apprehending the gunman, who he said in a Truth social post had a "violent history and possible obsession with our Country's most cherished structure".



The shooting comes only a month after a gunman opened fire at the White House Correspondents' Dinner. The incident on Saturday remains under investigation and road closures around the White House will likely stay in place overnight. Shortly

before 18:00 local time (23:00 GMT), a man pulled a gun from his bag and "began firing" outside the White House at the intersection of 17th Street and Pennsylvania Avenue NW in Washington DC, near the Eisenhower Executive Office Building. Secret

Service officers posted on the corner returned fire, striking the gunman. He was then taken to hospital, where he was pronounced dead. A bystander was also wounded in the shooting, but the Secret Service did not give further details on their condition. No officers were injured in the attack. Trump was at the White House at the time, but "no protectees or operations were impacted", the agency said. The suspect was later identified in US media as Best, who had been known to both the Secret Service and the Metropolitan Police Department and had used a revolver, law enforcement sources told CBS.

People trapped under collapsed building in Philippines



Around 20 people are feared to still be trapped under the rubble of a building that collapsed early on Sunday morning in a city near the Philippine capital, Manila. A search operation has so far rescued 24 people from the site in Angeles and two from a nearby hotel that was struck by falling debris, with no deaths reported. The nine-storey building had still been under construction when it suddenly gave way around 03:00 local time on Sunday (19:00 GMT on Saturday). Officials are now investigating the cause of the collapse. Many of those trapped are thought to be construction workers who were unable to escape in time. Images from the scene show a mangled heap of scaffolding and concrete spilling out onto the street, covered by green safety netting. City information officer Jay Pelayo told news agency AFP that the building's walls and scaffolding surrounding it had buckled, likely trapping people in a

pile of debris. "There are big chunks of concrete, and we need equipment to lift them up," he said. "That is what's challenging for the rescue right now." Five people have been confirmed as trapped, two of whom have been able to make contact with rescue workers, according to Reuters, with more feared to be under the rubble. An eyewitness told the Daily Tribune newspaper that she heard a loud rumbling moments before the collapse. She said she briefly lost consciousness, waking up to see debris covering two streets. Angeles sits around 90km (50 miles) to the north-west of Manila, on Luzon, the largest and most populous island in the Philippines. Construction work in the far east Asian nation is frequently beset by poor planning and project management, as well as design errors, research suggests. A landfill collapse in Cebu in January killed 11 waste workers, with others pulled from under the rubbish.



Large-scale Russian attack on Ukraine leaves four dead and dozens injured

RED CROSS VOLUNTEERS DIE FROM SUSPECTED EBOLA IN DR CONGO



Three Red Cross volunteers died in the Democratic Republic of Congo from suspected Ebola likely caught while managing dead bodies, the organisation has said. They are believed to have contracted Ebola on 27 March while working in the eastern region of Ituri on a project unrelated to the virus, before the outbreak was identified. The

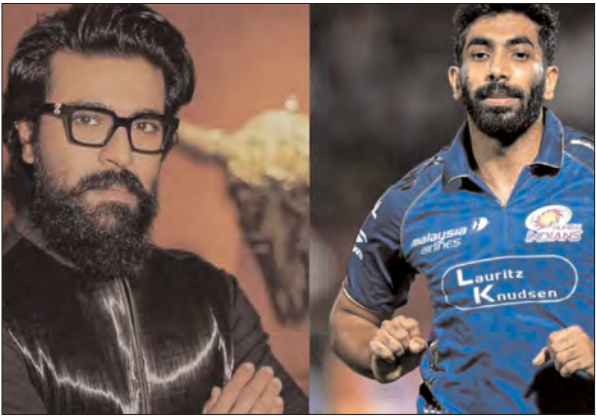
volunteers are among the first known victims of DR Congo's Ebola outbreak, which has resulted in more than 200 suspected deaths and more than 850 suspected cases. The International Federation of Red Cross and Red Crescent Societies (IFRC) said they had died after serving their communities "with courage and humanity".

Star actor Ram Charan issued an apology to Indian cricket team pacer Jasprit Bumrah after mistakenly calling him a 'footballer'. Ram Charan was present at the grand music launch of "Peddi" in Bhopal along with Janhvi Kapoor, AR Rahman and rest of the film's team. During a media interaction, he was asked to describe several India cricketers in a few words. He called Sachin Tendulkar's career a "Long legendary run", Dhoni "calm and cool", Virat Kohli "fire" and described Rohit Sharma as "He's everybody's man". However, when asked about Bumrah, he mixed up cricket with football. The video of his mistake quickly went viral on social media with fans commenting on his mistake and even creating memes. "Uff... I'm genuinely so forgetful with names sometimes. Apologies to @Jaspritbumrah93 Ji for the mix-up - it was a genuine human error in the



middle of all the excitement and the crowd," he posted on X (formerly Twitter). He added that he respected the India fast bowler and was a big fan on his game. Meanwhile, managing a niggles that Bumrah carried from this year's T20 World Cup into the ongoing IPL season resulted in the pace spearhead losing his "sharpness" despite Mumbai Indians giving him enough recuperation time, revealed head coach Mahela Jayawardene. Bumrah's reduced effective-

ness meant that he has just four wickets to show from 13 games for MI, and Jayawardene said the 32-year-old was fighting that unspecified injury in the earlier part of IPL 2026. "(It is due to) a combination of a few things. Coming back from the (T20) World Cup, he had a slight niggles which he played with through the World Cup, so we gave him adequate rest to come back," Jayawardene told reporters on the eve of their last game in this IPL against Rajasthan Royals.

Jalen Brunson Powers Knicks Within 1 Win Of NBA Finals After Dominating Cavaliers In Game 3

For years, the New York Knicks were the franchise other contenders laughed at during playoff conversations. Seasons collapsed early, stars came and went and Madison Square Garden's championship dreams kept drifting further away. Now, everything feels different. With Jalen Brunson controlling the postseason like a seasoned veteran and the roster finally clicking at the perfect moment, the Knicks are suddenly one win away from reaching the NBA Finals for the first time in nearly three decades after dismantling the Cleveland Cavaliers 121-108 in Game 3 of the Eastern Conference Finals on Saturday night. The Cavaliers came into the game hoping to protect home court and get back into the series, but the Knicks stayed in control throughout the night. Every time Cleveland tried to build momentum, New York reacted quickly with big shots, strong defence or another big play from Jalen Brunson. Brunson once again looked completely



in control despite the pressure of the Eastern Conference Finals. The Knicks star finished with 30 points and controlled the game from start to finish, continuing his incredible playoff run. This time, though, New York did not have to rely only on Brunson. The Knicks got contributions all across the floor and completely outplayed

Cleveland as a team. Mikal Bridges scored 22 points while also making things difficult for the Cavaliers defensively. Karl-Anthony Towns came close to a triple-double with 13 points, eight rebounds and seven assists, while Landry Shamet added 14 important points off the bench. Cleveland never really found its rhythm. Donovan Mitchell scored 23 points and Evan Mobley added 24, but the Cavaliers kept hurting themselves with turnovers and poor execution. The team gave the ball away 17 times, with Mitchell, Mobley and James Harden all committing at least five turnovers. Their struggles at the free-throw line also continued, as Cleveland made just 12 of 19 attempts. Knicks' NBA Finals Dream Suddenly Looks Very Real The bigger picture is that the Knicks have won 10 straight playoff games and are suddenly on the verge of another series sweep during what has become their best postseason run in decades.

Kansas City Chiefs WR Rashee Rice's Jail Sentence Could Lead To Fresh NFL Punishment After Failed Drug Test

The Kansas City Chiefs entered the offseason hoping Rashee Rice could finally move on from the legal issues that interrupted one of the NFL's brightest young careers. Instead, the situation has become even more serious. Rice is now serving a 30-day jail sentence after violating probation connected to last year's street-racing case, raising fresh questions about his availability for the upcoming season. With training camp getting closer and the NFL reviewing the matter again, the Chiefs are dealing with another major offseason distraction involving one of Patrick Mahomes' key targets. The latest issue reportedly began after Rice failed a drug test linked to THC use, which triggered an



immediate response tied to his felony case. Rice had earlier been given flexibility over when he would serve the sentence, but the probation violation sped up the process. He has now been booked into Dallas County Jail and is expected to remain there until mid-June. NFL Could Revisit Rashee Rice Discipline After Probation Violation What makes the situation

more complicated is the uncertainty surrounding possible league punishment. Rice already served an NFL suspension linked to the original incident, leaving questions around whether the league would now issue additional discipline tied specifically to the probation violation. As debate around the situation intensified online, OutKick's Bobby Burack

pointed to the unusual nature of the case. "The general consensus is that there is 'no precedent' for this. On one hand, he's technically serving time for a crime for which the NFL already suspended him. The 30-day jail sentence was already agreed upon; it was just expedited after his violation. On the other hand, the probation violation is 'new.'" Bobby Burack noted on X. "Under the PCP, anything that makes the NFL look bad can technically trigger a suspension. Back to the first hand, the NFL no longer suspends players for THC, which is the reason Rice was found in violation. Back to the other, he could still be suspended for violating probation, regardless of what caused it."

Russell edges Antonelli to claim Canada pole 'out of nowhere'



George Russell beat Mercedes team-mate Kimi Antonelli to pole position for the Canadian Grand Prix with the very last lap of the qualifying session. Russell, who won the sprint race earlier on Saturday, was on the back foot after aborting his first lap. But a final run on which he did two flying laps enabled him to pip Antonelli by 0.068 seconds and Russell whooped with delight on the radio after realising he had secured pole. "It is the most exhilarating feeling in the world when it comes at the last minute out of nowhere," he said over the radio. Antonelli had looked set to beat his team-mate when he eclipsed the time set by McLaren's Lando Norris on the Briton's first run, with Russell's first lap on his final run good enough only for third. But Russell had planned for two laps and he did the business on his second one. He said: "There are times when you expect to be on pole and every lap is the

quickest, but the times when it comes together at the end are the sweetest. "The car was out of sync, out of balance [for much of the session]. I knew I needed a big lap and on my preparation lap I saw Kimi on the TV screen going purple [fastest] and I was like, right, I need to bring something big here." Antonelli said: "It was very difficult to get the tyres in the right window. It was a pity to miss out by such a small amount but George did a great lap." Norris was also in the fight for pole, and set what before Russell's final run was the fastest middle sector as he tried to grasp top spot back from Antonelli. But the world champion fell 0.083secs short of the Italian's mark, before Russell raised the bar again. "It was such a challenging session but to do it on the very last lap was epic," said Russell, explaining that the team had made some changes to the car for qualifying with a view to predicting wet weather on Sunday.

Novak Djokovic Faces Tough Start In Quest For 25 As French Open Begins

Novak Djokovic will headline the opening day of Roland Garros on Sunday as the 24-time Grand Slam champion begins his latest tilt at history. Lifting the Coupe des Mousquetaires for a fourth time would send the 39-year-old clear as the player with the most major titles. Djokovic's last Grand Slam title came at the US Open in 2023, and every subsequent major has been claimed by tennis' two new dominant forces - Jannik Sinner and Carlos Alcaraz. With double-defending champion Alcaraz missing through injury, Djokovic will enter his first-round match in the night session on Stade Philippe Chatrier against France's Giovanni Mpetshi

Perricard knowing this may well be his best chance of claiming a record-breaking 25th crown. "It's been a lot of hours spent on the court and trying to perfect the game and the body and enable myself physically and game-wise to be ready for best of five (sets)," Djokovic told reporters Friday of his preparations as he returns from a shoulder issue. "Let's see. I don't know whether that's going to be the case for the entire tournament, however long that tournament will be for me. "But Grand Slams have been, and I have said this many times, always the priority list, particularly in the last couple of years... So I can't wait to get on a court and start compet-

ing." The third-seeded Serb enters the tournament with little match practice on clay after only competing in the Italian Open, where he was eliminated in his opening match earlier this month. Djokovic is a different beast when it comes to Grand Slams. Despite his reduced participation in ATP tournaments in recent years, he has nonetheless reached at least the semi-finals at each of the past five majors. He has, however, been handed a tough draw in the French capital. First on the menu is former world number 29 Mpetshi Perricard, who, in addition to having one of the biggest serves on the tour, will also enjoy raucous home backing on

Roland Garros' centre court. Second seed Alexander Zverev will also be in action on the opening day as the German faces home hope Benjamin Bonzi. Rising stars Joao Fonseca of Brazil and Czech Jakub Mensik will both open their bids on Court Simonne Mathieu. "Never tricky" Russia's Mirra Andreeva will be the highest-ranked woman playing on Sunday. The eighth seed meets French wildcard Fiona Ferro on Philippe Chatrier.

Independent filmmaker, actor, and film festival founder Venkat Sai Gunda attended the prestigious Cannes Film Festival this year, marking a significant milestone in his journey from a small-town upbringing in Karimnagar, Telangana - India to one of the world's most celebrated cinematic stages. Known for his psychological horror feature 'The Deserving',

Venkat has steadily built a name for himself in independent cinema through emotionally driven storytelling and unconventional narratives. The film received recognition across multiple international film festivals, earning numerous awards and helping establish him as a filmmaker to watch in the indie space. At Cannes, Venkat attended official festival screenings and premiere events as a filmmaker and founder of The Storyteller Universe, a New York-based film festival platform created to encourage and spotlight emerging and underrepresented filmmakers from around the world. Speaking about the experience, Venkat shared that Cannes represented more than just a red carpet moment. "For me, this journey is not about glamour. It is about reminding filmmakers from small towns and ordinary backgrounds that their stories matter too. Cinema has the power to cross borders, languages, and limitations." Founded with the vision of supporting bold and independent voices, The Storyteller Universe has been growing as a platform focused on creating opportunities for new storytellers who often struggle to find visibility in mainstream spaces.

A cinematographer is the creative force who beautifully translates a director's vision onto the screen. Not only that, but they are also the magician who multiplies the value of a producer's budget through visual storytelling. If the producer is the father of a film and the director is the mother, then the cinematographer is undoubtedly the elder son who stands by the film from beginning to end. One such talented cinematographer making his mark in this crucial department is Kishore Boyidapu. Starting his journey from the grassroots level in the camera department, he proved his talent not only in Telugu cinema but also by working in Bollywood and Hollywood films. Recently, he earned appreciation for the series “Memu Cop'lam”, directed by Pradeep Maddali with Naga Babu in the lead role. The series is currently streaming on Zee5. Kishore Boyidapu, who played a key role in completing the series shoot in just 17 days, shared several insights about his cinematic journey, the challenges he faced, and experiences from the series.

BACKGROUND
My full name is Durga Kishore Kumar. Since my entire family was associated with the film industry, I naturally developed an interest in it. My father used to take our photographs and narrate stories



through those photos. That's where my interest in this field began. From childhood itself, I was fascinated by cameras.

CINEMA JOURNEY..
I started my career in 2002 as a camera assistant in Ravi Prasad's unit. After about four years, I moved to Mumbai. My first project there was working in the camera department for Slumdog Millionaire. Later, I also worked on English films and gained experience working on nearly 15 Hollywood films, including Mission: Impossible 4. In 2012, I worked as the Director of Photography (DOP) for a film titled Boy Meets Girl. During that phase, my journey with Anil Mehta began in 2015. That journey started with

Ae Dil Hai Mushkil and continued until Jersey. In between, I also got the opportunity to work on nearly ten more films. Working with sir as one of the main assistants gave me immense happiness and valuable experience in my career. Everything I learned from him has been extremely useful in my cinematography journey. Every lesson from that phase remains very valuable to me. Thanks to Anil Mehta sir. After COVID, when I received opportunities for films like My Name Is Shruthi and 105 Minutes, I spoke with him. At that time, he encouraged me by saying, “Go ahead and start your own work independently.” That's how I restarted my journey as a cinematographer with a fresh beginning.
