FIRE BREAKS OUT AT RBI BUILDING IN NEW DELHI, NO INJURIES REPORTED

New Delhi (TSIT):

A fire broke out at the Reserve Bank of India (RBI) building here on Tuesday afternoon, but was controlled soon in a swift response from firefighting teams. No injuries or casualties were reported in the incident, officials said.

According to officials, the blaze originated from a box containing solar panels within the premises. Firefighters were alerted to the situation at around 1.05 pm, following which five fire tenders were rushed to the spot. The fire was brought under control within 15 minutes, preventing any major damage or escalation.

Authorities confirmed that the situation was handled quickly and safely, with no harm to personnel present at the building. The incident comes close on the heels of another fire reported in the city. A blaze had broken out earlier in the Chawri Bazar area of Delhi, for which a call was received by the Connaught Place Fire Station at around 7:21 pm on Sunday. Firefighting teams were immediately dispatched to manage the situation. Meanwhile, last week, the central bank said that 98.47 per cent of the Rs 2,000 denomination banknotes in circulation have been returned, nearly three years after it announced their withdrawal.

21 killed, 61 injured in China fireworks plant explosion

Changsha (TSIT):

The fireworks plant explosion in central China's Hunan Province has left 21 people dead and 61 others injured, authorities said Tuesday. The explosion occurred at around 4:43 p.m. Monday at the plant of Huasheng fireworks manufacturing and display company in Liuyang, a county-level city under Changsha, capital city of Hunan. More than 480 rescuers in five teams have been mobilised for the rescue, with three rescue robots deployed. As the explosion site is located near two black powder warehouses, the rescuers have evacuated nearby residents and set up a buffer zone to prevent a secondary accident. As of 8 a.m. Tuesday, the rescuers had confirmed the casualties following the first round of searching. The injured have been rushed to hospital for treatment and the second round of searching is underway.

CM Revanth chairs key meet with Raghuram Rajan; Focus on skills, startups & industrial

Chief Minister A. Revanth Reddy chaired a high-level meeting with former RBI Governor Raghuram Rajan to discuss Telangana's future development roadmap, with a focus on skill development, industrial growth, and emerging technologies. The meeting, held at the Chief Minister's residence in Jubilee Hills, covered key strategies to enhance employment opportunities and attract investments. Rajan emphasized that improving youth skills can unlock large-scale job creation and

to drive economic growth.

The Chief Minister informed that the state is planning to integrate Artificial Intelligence into school, higher, technical, and medical education, and sought Rajan's guidance on the initiative. He also outlined plans to boost mid-level employment through a Skills University and the upgradation of ITIs into Advanced Training Centres.

Rajan suggested adopting an industrial policy similar to Tamil Nadu to attract investments, while cautioning about the high resource requirements of sectors like data centres. He also expressed interest in visiting Hyderabad in the coming months.

Deputy Chief Minister Mallu Bhatti Vikramarka highlighted the state's infrastructure strengths, while Industries Minister D. Sridhar Babu underlined the conducive ecosystem for pharma, IT, and data centre sectors. Senior officials, including Chief Secretary K. Ramakrishna Rao and Special Chief Secretary Jayesh Ranjan, were present at the meeting.

Key proposals include AI integration in education, a Skills University, ITI upgrades, and investor-friendly policies, with Rajan stressing youth skill development, ease of doing business, and startup promotion.

CABINET CLEARS PROPOSAL TO INCREASE SUPREME COURT JUDGES' STRENGTH

New Delhi (TSIT):

The Union Cabinet, chaired by Prime Minister Narendra Modi, on Tuesday approved the introduction of the Supreme Court (Number of Judges) Amendment Bill, 2026, in the Parliament to increase the sanctioned strength of judges in the apex court. The proposed legislation seeks to amend the Supreme Court (Number of Judges) Act, 1956, enhancing the number of judges from the present 33 to 37, excluding the Chief Justice of India (CJI). According to an official statement, the move is aimed at improving the efficiency and functioning of the Supreme Court while ensuring the expeditious delivery of justice. "The increase in the number of judges will enable the Supreme Court to deal with cases more effectively and reduce pendency, thereby ensuring timely justice to litigants," the government said.

Mamata rules out resignation, vows to strengthen INDIA bloc

Kolkata (TSIT):

A day after Trinamool Congress witnessed a major defeat in West Bengal Assembly elections after 15 years of uninterrupted rule in the state, the outgoing Chief Minister, Mamata Banerjee, on Tuesday, stressed on the necessity of strengthening the INDIA Bloc to organise a movement nationally against the BJP and the NDA-ruled Centre. She also ruled out the possibility of voluntarily tendering her resignation to the Governor as the outgoing Chief Minister.

According to her, the "defeat" of Trinamool Congress this time, was not a "defeat" in the real sense as the results did not reflect the true public mandate. "Why shall I resign now? We are not defeated in the true sense. The results are reflections of massive misappropriation and vote-looting. So, where from the question of resignation comes," Mamata Banerjee told media persons on Tuesday afternoon at a press conference accompanied by her nephew and Trinamool Congress General Secretary, Abhishek Banerjee and a host of members of the outgoing state Cabinet led by her.

Ten Layers of Physics, One Founder's Promise - The Arun Teja Story

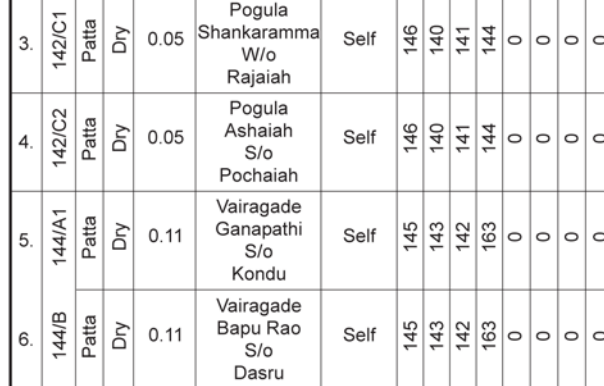
CONGRESSION WILL RETURN TO POWER IN TELANGANA, SAYS LAKPATHI YADAGIRI GOUD

Participants also visited the Quantum Reference Facility at the campus, showcasing ongoing developments in quantum technologies. The workshop reinforced SRM University-AP's role as a key player in India's growing quantum ecosystem and its commitment to nurturing future researchers and innovators.

VILLAGE TANK RESTORATION BOOSTS IRRIGATION, JOBS UNDER JALADHARA SCHEME

Srikalahasti: Village tanks are emerging as crucial assets for strengthening the rural economy, groundwater recharge, and environmental balance, with ongoing restoration works under government initiatives.

In Srikalahasti Mandal, the Jaladhara-Jalaharati programme has taken up 85 works, including feeder

channels and tank restoration projects. One such initiative at Gangalupudi village involves the development of a water conservation pit in the local tank at a cost of Rs.4 lakh, engaging around 75 MGNREGA workers.

The project is expected to channel rainwater from nearby tanks, helping recharge 15 borewells and 4



open wells, benefiting Gangalupudi and Velavedu villages. Once completed, the restored tank will provide irrigation to nearly 150

acres of farmland, supporting crops such as paddy and groundnut. Officials said the initiative is being implemented under the Mahatma

Gandhi National Rural Employment Guarantee Act, providing livelihood opportunities while improving water conservation. The scheme has been further strengthened under the VBGRJ Scheme, which increases guaranteed workdays from 100 to 125 days.

Local worker Koti Chandrababu said the works have helped prevent

rainwater wastage and improve groundwater levels, while also providing steady income of Rs.300-Rs.307 per day.

The initiative highlights how integrated water conservation efforts can simultaneously enhance agricultural productivity, ensure water security, and generate employment in rural areas.



Yashoda Hospital Doctors Save Woman from Septic Shock and Multi-Organ Failure



Khammam, May 5: Doctors at Yashoda Super Specialty Hospital, Malakpet achieved a major medical success by saving a 51-year-old woman suffering from life-threatening conditions including Septic Shock, multi-organ dysfunction, and Acute Kidney Injury.

The patient, from Khammam district, was admitted in critical condi-

tion due to Community-Acquired Pneumonia, with symptoms such as respiratory distress, swelling, and reduced urine output. Under the leadership of Chetan Veeramaneni, a multidisciplinary team from nephrology, pulmonology, cardiology, and general medicine provided intensive treatment. Advanced dialysis techniques, including

Continuous Renal Replacement Therapy (CRRT) using an Oxiris filter followed by Sustained Low-Efficiency Dialysis (SLED), were employed to stabilise kidney function and remove toxins.

The patient was also given targeted antibiotics, respiratory support, and cardiac care to address complications arising from infection and organ failure.

Doctors stated that timely diagnosis, coordinated care, and access to advanced medical technology played a crucial role in saving the patient, who has now fully recovered and been discharged without complications.

Srinivas Chidura, Associate Vice President of Yashoda Hospitals, said the successful treatment highlights the hospital's advanced ICU facilities and expertise in handling complex medical cases, particularly critical kidney-related conditions.

24/7 Helpline Launched for Water Supply Issues in Greater Visakhapatnam Municipal Corporation

Visakhapatnam (TSIT) The Greater Visakhapatnam Municipal Corporation has launched a dedicated 24/7 helpline to address drinking water supply issues and ensure prompt resolution of public complaints across the city. Commissioner Ketan Garg stated that the initiative aims to provide uninterrupted and adequate water supply, especially during the summer season. As part of its Summer Action Plan, GVMC has taken up 91 water supply-related works at a cost of Rs.8.90 crore to strengthen infrastructure and prevent disruptions.

The Commissioner said the corporation is already investing significant funds in a planned manner to ensure regular and sufficient water supply to all areas within its jurisdiction. To enhance public convenience, a toll-free helpline number 1800 4250 0009 has been made available. Citizens can report issues such as delay in water supply, pipeline leakages, contamination



due to drainage mixing, and supply interruptions through this number. Upon receiving complaints, the GVMC City Operations Centre will immediately alert the concerned Assistant Engineers and share their contact details with the complainants for quicker resolution. The details, including names and mobile numbers of Assistant Engineers across all 10 zones, have also been made accessible to the public. Commissioner Ketan Garg assured that all necessary measures have been put in place to avoid water scarcity during the summer and urged citizens to make effective use

He clarified that VIP darshan will be restricted to specific time slots — from 6 AM to 8 AM and 3 PM to 5 PM — ensuring that common devotees receive priority access.

Formation of South Coast Railway Zone – Major Reforms in Railway System with Visakhapatnam as Headquarters

The South India Times, Visakhapatnam : The Government of India has announced the formation of a new railway zone named "South Coast Railway" as part of significant administrative reforms in the railway sector. The decision has been notified through an official Gazette, exercising the powers conferred under the Railways Act, 1989. The new zone will come into effect from June 1, 2026. The Central Government has clarified that the headquarters of this new zone will be established in Visakhapatnam.

As part of this decision, certain key divisions from the existing East Coast Railway and South Central Railway zones are being reorganized to form the new zone. The Guntakal, Guntur, and Vijayawada divisions under South Central Railway will be included in the South Coast Railway. Additionally, the Waltair Division of East Coast Railway will be bifurcated, and a major portion of it will be converted into the "V i s a k h a p a t n a m Division" and merged into the new zone.

The bifurcation of the Waltair Division is a crucial aspect of this restructuring. The division will be split into two parts, with one part continuing under East Coast Railway



as a newly formed "Rayagada Division." The remaining portion will be renamed as the Visakhapatnam Division and incorporated into the South Coast Railway. The Rayagada Division will include important railway sections such as Koraput-Singapur Road, Kottavalasa-Kirandul, Kumeru-Theruvalli, and G u n t u r - Paralakhemundi.

The Visakhapatnam Division will cover major sections extending from Ichchapuram to Palasa, Visakhapatnam, and Duvvada, along with routes such as Vizianagaram-Kumeru, N a u p a d a - Paralakhemundi, and Bobbili-Salur. In addition, peripheral lines like Simhachalam North-Duvvada bypass and Vadalapudi-Duvvada will also fall under this division. Altogether, this division will span approximately 463 kilometers. Considering operation-

al requirements, certain railway sections will be transferred from one division to another. For instance, the Palasa-Ichchapuram section under Khurda Road Division will be shifted to the Visakhapatnam Division. Similarly, some sections among Guntakal, Guntur, Vijayawada, and Secunderabad divisions will also be reorganized. As a result, the divisional boundaries within the railway system will be redefined.

Officials believe that this restructuring will enhance administrative efficiency, improve the speed of services, and ensure better operational coordination. It is also expected to provide greater development opportunities for Andhra Pradesh, with Visakhapatnam emerging as a major railway hub. Experts view this decision as a significant milestone in the development of the Indian Railways system.

New Trident with Damarukam to be Inaugurated at Kailasagiri on May 9

Visakhapatnam: A newly constructed trident (Trishul) with a Damarukam at the popular tourist destination Kailasagiri will be inaugurated on May 9 (Saturday) at 8:00 AM. The event will be attended by Andhra Pradesh Chief Minister N. Chandrababu Naidu. Officials stated that the government is taking several initiatives to develop Visakhapatnam into an international tourism hub. As part of these efforts, adventure activities like sky cycling and zip-lining, along with attractions such as a glass bridge, have already been established.

VMRDA Chairman M.V. Pranav Gopal said that he personally inspected the ongoing works along with Metropolitan Commissioner N. Tej Bharat, IAS. He urged the citizens of Visakhapatnam to participate in large numbers and make the event a grand success. He also directed officials to expedite beautification works, enhance greenery by planting attractive saplings, and complete the installation of decorative electric poles at the earliest. Chief Engineer Vinay Kumar, Executive Engineer Ramaraju, and other officials were present during the inspection.

Indian Muslims should develop own political leadership: Owaisi

Hyderabad, May 5: AIMIM President Asaduddin Owaisi said on Tuesday that Muslims in India should develop their independent political leadership to become citizens with rights, instead of being mere voters for "so-called secular parties". Reacting to the results of the Assembly elections, especially in West Bengal and Assam, the Hyderabad MP told media persons here that the "so-called secular parties" have failed to stop the BJP.

"I want to reiterate that Muslims should try to create their own independent political leadership. Your vote is getting wasted because you are casting your vote in favour of so-called secular parties that are not secular. They failed to stop the BJP," he said. While acknowledging the need to stop fascist and communal forces, he said that this does not mean that there should be no political leadership of Muslims.

"Reposing faith for so many years in so-called secular parties has not given them any development nor eradicated injustice and discrimination. They (the community) should think about the value of their vote. You voted for them in Maharashtra, Bihar,



Delhi, and West Bengal, but the BJP won in all these states," he said.

"These so-called secular parties have not been able to stop the BJP. We have seen this in the past. In Delhi, Arvind Kejriwal played soft Hindutva. The same was done in Maharashtra by Uddhav Thackeray's party, and to a certain extent by the erstwhile Nationalist Congress Party as well. We have seen the same behaviour in West Bengal by Mamata Banerjee and the All India Trinamool Congress."

He alleged that Mamata Banerjee treated Muslims of West Bengal only as a vote bank and did nothing to improve their socio-economic conditions despite being in power for 15 years. Owaisi noted that West Bengal is the only state in the country where Muslims are in a majority in 60 Assembly constituencies, while there are 20

other segments where Muslims are 30-40 per cent, but still the BJP won there.

Stating that the people of West Bengal have given power to the BJP, he hoped that the BJP government would work for every section of society and stop the marginalisation of Muslims.

He believes that there are many reasons for the Trinamool's loss. "One of the reasons is SIR. There was a huge anti-incumbency, massive corruption, and huge exploitation of the Muslim community."

Owaisi stated that the image of Banerjee outside West Bengal as a very liberal and secular leader is completely wrong. "She has exploited the Muslims only as a vote bank. She has not treated them as citizens," he remarked.

Owaisi recalled that in 1998, the first BJP MP to win in West Bengal was Tapan Sikdar, who was supported by the Trinamool, and he won again in 1999. "Mamata Banerjee was part of the (PM Atal Behari) Vajpayee government as a Railway Minister. She left them and rejoined them. The same is the case with Uddhav Thackeray and AAP. It's high time Muslims must get united and create their own political leadership.

WARANGAL, May 5, TSIT : Veerlapati Ramaiah, senior faculty having with 32 years of teaching and research in the Department of Electrical & Electronics Engineering (EEE) Kakatiya Institute of Technology and Science, Warangal (KITSW), has been awarded Ph.D. degree by the Vel Tech Rangarajan Dr.Sagunthala R&D Institute of Science and Technology, Chennai said by the Principal Prof. K. Ashoka Reddy.

In a press note released on Tuesday, KITS Principal Prof. K. Ashoka Reddy said that Veerlapati Ramaiah had submitted his Ph.D thesis titled "Performance Assessment of Indian Electricity Distribution Utilities Using DEA-Malmquist Index". He did his research work under the supervision of Dr. P. Chandrasekar, Professor of EED, Vel Tech Rangarajan

Dr.Sagunthala R&D Institute of Science and Technology, Chennai.

Veerlapati Ramaiah has carried out the research to evaluate the operational efficiency and productivity of Indian Electricity DISCOMs using Data Envelopment Analysis (DEA) and Malmquist Productivity Index (MPI) techniques. Key Findings : The analysis reveals that most utilities operate below optimal efficiency levels, with significant input overutilization and high Aggregate Technical & Commercial (AT&C) losses. Although moderate improvements in operational efficiency were observed, technological progress has declined, resulting in an overall drop in productivity. Wide regional disparities highlight uneven reform implementation across the country.

Medicover Doctors Save Woman from Rare Post-Abortion Complication, Preserve Fertility

Hyderabad, April 2026:

In a remarkable feat of advanced gynecological and interventional care, Medicover Hospital's successfully managed an exceptionally rare and life-threatening post-abortion complication in a 32-year-old woman, preventing catastrophic bleeding and preserving her uterus through a highly coordinated multidisciplinary approach. The patient, who had a history of previous cesarean section and recurrent pregnancy losses, presented with continuous vaginal bleeding for over 25 days after undergoing a dilation and curettage (D&C) procedure for a missed abortion at six weeks of pregnancy. Despite initial medical treatment elsewhere, the bleeding persisted, significantly affecting her health and raising concerns of severe internal complications. Upon comprehensive evaluation at Medicover Hospitals, advanced ultrasound and MRI scans revealed a rare and life-threatening condition. Its a combination of Grade 3 retained products of conception (RPOC), secondary



uterine arteriovenous malformation (AVM), and a previous cesarean scar niche (Isthmocele). This complex condition posed an extremely high risk of sudden, life-threatening hemorrhage, where conventional treatment could have resulted in emergency hysterectomy and permanent loss of fertility. Recognizing the complexity and urgency, Medicover's specialists devised a carefully planned, step-wise, fertility-preserving treatment strategy involving interventional radiology and advanced minimally invasive gynecological surgery. A multidisciplinary team followed, Dr. Sai Teja, Consultant Interventional

Radiologist, performed a highly specialized Uterine Artery Embolisation (UAE), selectively blocking abnormal uterine blood vessels and significantly reducing the risk of massive bleeding. Simultaneously after Successful embolisation, Dr. Perum Prithivi, Consultant Robotic and Laparoscopic Gynecological Surgeon, performed Hysteroscopic RPOC Resection along with Laparoscopic Repair of the Previous Cesarean Scar Niche (Isthmocele). During the complex surgery, the team meticulously addressed dense adhesions between the uterus and anterior abdominal wall, bladder

adhesions at the scar site, and deeply embedded retained pregnancy tissue within the uterine wall—all through precision-driven minimally invasive techniques. Post-operative angiography confirmed complete exclusion of abnormal vascular circulation, and the procedure was completed successfully without major complications. The patient recovered well, with only a brief fever episode managed conservatively, and was discharged in stable condition. Speaking about the rare case, Dr. Perum Prithivi said, "This was an extraordinarily challenging case due to the coexistence of uterine AVM, retained products, and cesarean scar niche (Isthmocele). Such patients are at very high risk of severe hemorrhage, and hysterectomy often becomes the only life-saving option. Our multidisciplinary strategy with prior embolisation allowed us to safely control bleeding, completely avoid hysterectomy, and most importantly preserve the patient's fertility and reproductive future."

Shift to Oil Palm for Better Income: MLA Rajesh Reddy

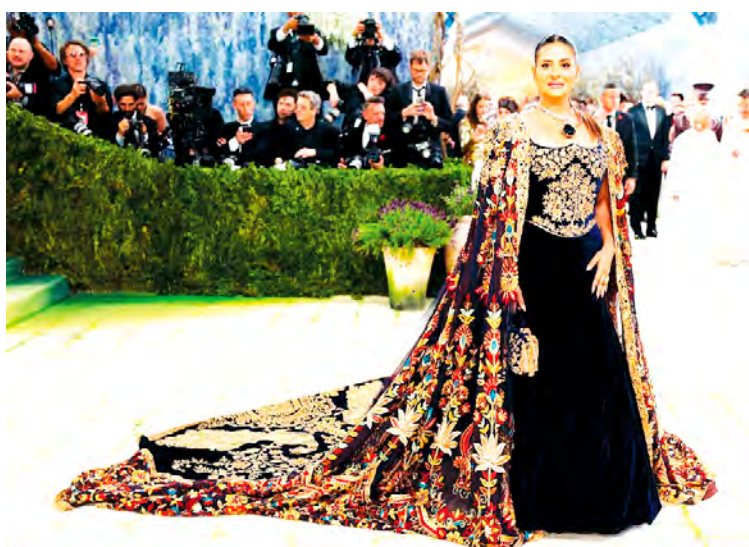

The Billionaire Philanthropist Championed Centuries Old Textile Art Form Kalamkari In Custom Manish Malhotra 'Tree Of Life' Couture That Took 3,459 Hours And 90 Artisans To Create

New York : - At the 2026 Met Gala, billionaire philanthropist and style icon Sudha Reddy returned to the red carpet with a look that balanced spectacle with substance, wearing a custom creation by India's leading couturier Manish Malhotra. Conceived in collaboration with global celebrity stylist Mariel Haenn, the ensemble titled "The Tree of Life" was a profound dialogue between heritage, craftsmanship and contemporary couture. Rooted in Machilipatnam style of Kalamkari, one of India's oldest textile traditions, the look reinterpreted the 3,000-year-old storied art form through a contemporary, sculptural lens. Traditionally hand-painted with natural dyes, Kalamkari is known for its intricate depictions of mythology, nature and cosmology. Its most enduring motif, the Tree of Life - symbolizing balance, growth and interconnectedness of all life forms, became the central anchor of the ensemble.

Drawing deeply from the landscape of her city of origin, the design incorporated symbolic motifs tied to the region's identity: the Palapitta (Indian Roller), the Jamma Chettu (Prosopis Cineraria), and the Tangedu (Tanner's Cassia alongside celestial references to Kalpavriksha (the wish-fulfilling tree of abundance), Surya (the Sun god) and Chandra (the Moon god). Each element, rooted in seasonal

festivals and cultural traditions of Telangana, was intricately embedded throughout the ensemble to portray a living map of heritage. A sculpted, corseted silhouette in deep royal blue formed the foundation of the ensemble, anchored by Manish Malhotra's signature swirl construction. Antique gold zari embroidery flowed across the surface, while the Tree of Life emerged in intricate zardozi spanning velvet, silk, and tulle. The Palapitta appeared delicately along the bodice in fine

marodi work, while peacock motifs unfurled across the embroidered 7 meter lavish trail, enhancing its sense of scale and drama. A sheer tulle cape softened the structured form, hand-embroidered in resham and subtly accented with antique gold zari, with delicate depictions of Hyderabad's flora and fauna. The ensemble was further elevated by a dramatic installation at the upper back—a sculpted metal vine crafted entirely by hand in brass, copper, and silver. At its centre stood the Kalpavriksha, surrounded by motifs including the Jamma Chettu, Tangedu, Surya, Chandra and the Palapitta.

The monochromatic sapphire-wash palette extended into the jewellery, drawn from Reddy's personal collection and valued at \$15 million, lending the look a sense of museum-worthy maximalism. At its centre was a Victorian-finished necklace featuring triangular and pear-shaped rose-cut diamonds arranged in delicate floral clusters, anchored by the striking 550-carat 'Queen of Merelani' deep violet-blue tanzanite sourced from Tanzania's Merelani Hills. EDITORIAL

The Strongman Who Underestimated His Opponent - And Paid The Price

The year was 2011, when the DMK found itself demolished by the AIADMK in the Tamil Nadu assembly elections. That election, MK Stalin had moved from his traditional Thousand Lights seat to the newly created Kolathur constituency. Stalin was up against Saidai Duraisamy of the AIADMK, and it was a tense see-saw electoral battle as there were several delays during the counting process due to disputes over EVMs. Meanwhile, at the Karunanidhi residence in Gopalapuram, the then DMK chief was anxious because Stalin's defeat would mean a rejection of the next-in-command of the party. It was only when Stalin finally scraped through by a margin of some 2,700-odd votes that his father heaved a sigh of relief, even though the party was voted out of power.

Kolathur Gives, Kolathur Takes

Fifteen years later, Kolathur gave Stalin heartache once again, keeping him worried through the course of Monday. This time, however, there was no good news at the end of the counting process. Stalin suffered the ignominy - like M Bhaktavatsalam, the last Congress chief minister of Tamil Nadu in 1967, and J Jayalalithaa in 1996 - of a sitting chief minister losing his own seat. VS Babu of the Tamilaga Vettri Kazhagam (TVK) defeated Stalin by 8,795 votes. Ironically, Babu is of the DMK DNA, having been a party MLA from Purasawalkam in 2006. Stalin's defeat in Kolathur is more than just a lost seat; it is the collapse of the strongman image. During the election campaign, Stalin wore a black shirt, burnt copies of the delimitation bill and cast himself in the role of a Tamil Nadu warrior taking on the might of the Delhi Sultanate. Little did he realise that in his backyard in Kolathur, ensconced inside the DMK's Chennai fortress, the ground was slipping under his feet. So, what went so horribly wrong for the DMK, considering that just three months ago, several opinion polls predicted that he would return as chief minister and achieve a feat even his celebrated father did not - that is, win a second consecutive term in office?

Udhayanidhi And Other Awkward Questions

The decision to elevate Udhayanidhi Stalin to the post of deputy Chief Minister presented the "dynastic politics" charge to his opponents on a platter. Therefore, when the DMK outsourced the job of attacking actor-turned-politician Vijay to the likes of Prakash Raj, it rang hollow. When Raj asked what work Vijay had done to deserve coming to power, people obviously asked the counter question - what did Udhayanidhi do to be elevated to the No. 2 position?

The second mistake Stalin made was to underestimate Vijay's star power. He treated Vijay as another Kamal Haasan who had just an urban appeal at best. When huge crowds thronged Vijay's roadshows, they were dismissed as crazy fans. By the time the DMK realised Vijay's aura transcended all divides - rural-urban, gender, caste, religion, social and economic status - enough holes had already been made in the DMK citadel.

Stalin thought the welfare template of the DMK regime was enough to make the electorate vote decisively for them for the fourth consecutive time since 2019. But what was different from the previous two Lok Sabha and one assembly election was the presence of a fresh political force - one that did not believe in bribing voters, one that did not mobilise crowds by paying money, or arrange tempos, liquor and biryani. The youth did not want freebies. They found the promise of an AI ministry, collateral-free education loans, anti-drug enforcement and start-up seed capital, more attractive. The Gen-Z gave the thumbs up to the empowerment promised by Vijay, rejecting Stalin's doles.

What really took away the women's vote from the DMK was the perception that the law and order situation was bad. The surge in drug-related crimes was the DMK's Achilles' heel. So, when Stalin spoke of the 'D-stock', referring to the Dravidian ideology of the party, critics lampooned it. For, 'D' in their book stood for 'drug culture', reportedly prevalent at every street corner.

Kill The Messenger

However, instead of remedying the situation, the DMK regime tried to control the narrative. Media management was put in place to ensure no negative news found its way into mainstream, digital and social media. Now, with the DMK out, many journalists are relieved that they will no longer be intimidated if they file a report or even put out a tweet critical of the government. There is a lesson there for ruling parties in other states in India.

In terms of strategy, the DMK used the template it had successfully employed and used in elections in the past. It kept trying to scare the voter, saying that AIADMK-BJP combine would mean that Chennai would be controlled by Delhi. But it was a line that no longer excited the voter because the voter had moved away from the DMK-AIADMK binary and started looking towards the new kid on the political block.

That Insurance Policy

When did it begin to look like Stalin was growing unsure about victory? When he went out of his way to include more than 20 parties in his alliance. The move was marketed as the trait of an 'accommodative' leader. It was not. It was an insurance policy the DMK was buying. In the end, the allies turned out to be paper tigers. The choice of candidates was another. Take the example of Katpadi. While the DMK gave the ticket yet again to 87-year-old Durai Murugan (who lost), the TVK presented an alternative in the form of Dr M Sudhakar against him. The DMK ecosystem dismissed Vijay's supporters as "tharkuris" (idiots). But the fact of the matter was that several professionals with expertise in different fields have now won on TVK tickets.

In the revolving door of Tamil Nadu politics, Stalin is no stranger to defeat. But the latest one comes at a particularly inopportune time. A re-election would have meant passing the baton to his son, Udhayanidhi, during the course of the term. The Tamil Nadu assembly would now see two actor-turned-politicians facing off, Chief Minister Joseph Vijay vs Leader of Opposition Udhayanidhi Stalin.

Self-Inflicted Wounds? How Mamata Became The Architect Of Her Own Collapse

May 4 has turned out to be much more than just another counting day in Bengal. It will go down as the day when a 15-year political order imploded in full public view. By mid-afternoon, it became clear that the Trinamool Congress's 15-year rule in West Bengal was coming to an end as news of the Bharatiya Janata Party's (BJP) electoral successes came pouring in from across the state. Out of a total of 294 seats in the assembly, the BJP has bagged a whopping 206, while the Trinamool Congress (TMC) has been reduced to a mere 81, a bitter loss of 133 against its 2021 sweep. The rest of the tally is divided among the CPI(M), the Congress and others, whose outcome could not tilt the scale. It was a six-to-seven per cent swing of votes in its favour that pulled the BJP from 77 seats in 2021 to where it is today, all thanks to a campaign where it not only capitalised on the TMC's mistakes but also steadily pushed its own goals. RG Kar, Nirbhaya, And How Governments Fall For the Trinamool, the main talking points in its election campaign were its welfare schemes that focused on women's empowerment, education, and rural development. Key initiatives included the flagship Lakshmir Bhandar scheme, which offers monthly financial aid to women, and other programmes such as Kanyashree, Swasthya Sathi, and Karmashree, targeting social security. The BJP, on the other hand, came with the promise of extending to Bengal its schemes from other states, and also raising the amount distributed through them. Many existing beneficiaries appear to have been convinced that even if a new government came in, the ongoing schemes would not be stopped.

Despite women's issues making up much of the core of Mamata Banerjee's policymaking - Ma, Mati, Manush was its clarion call this election - doubts about women's security in the state could not be dispelled.



Incidents like the rape and killing of a young doctor on duty at Kolkata's RG Kar Medical College in 2024 cast a long shadow over the effectiveness of the state government. One could almost draw a parallel between RG Kar and the Nirbhaya incidents, both of which eventually snowballed politically, and, coupled with other factors, unseated the governments of the day.

Mamata Made It Easy For BJP

It is fair to state that West Bengal's political and social landscape has undergone a drastic change in the past few decades when it comes to communal politics. Through its relentless Hindu-versus-Muslim narrative, the BJP was able to convince a large section of the electorate, especially in the urban and peri-urban areas, that Bengal faced an impending danger of being overrun by Muslims.

Banerjee herself handed such talking points to the BJP by aggressively engaging with the state's orthodox Islamic leaders and attending their religious events, often in hijab. Schemes such as honorariums for imams also met with disapproval

from a large section of Hindus. Banerjee tried to balance this by constructing lavish temples in Digha (the Jagannath temple) and Kolkata's New Town (Durga Angan), which further entrenched her in competitive communalism in a society that had, for long, imagined itself to be relatively resistant to these forces.

The Construction 'Syndicates'

Construction and material supply syndicates were another bane for the TMC. In the absence of large or medium-sized industries, a large section of Bengal's youth resorted to supply networks to earn a living. These often boiled down to extortion of money from local businessmen in exchange for protection. Such syndicate-controlled activities ranged from construction and road-building in rural areas to illegal coal supply and cattle smuggling. Syndicates also controlled bidding for state government contracts, and part of the money generated through such operations came back to the party via its local leaders. It will be interesting to see how the BJP dismantles this syndicate system, as it promised during its election campaign. It will

need to do this because syndicates often tend to co-opt whoever is in power.

No More An Outsider

The BJP owes the astounding result significantly to Narendra Modi and Amit Shah's election management. Both made Kolkata their second home in the run-up to voting in late April. While Modi spoke about big-picture issues, it was left to Shah to take care of the nuts and bolts. The campaign was also aided by a much harder booth-level and seat-level focus than before. Without putting Hindutva front and centre of its messaging, the BJP doubled down on the idea of "Paribartan" (change) - one of their campaign slogans was "Paltano dorkar, chai BJP sorkar" ("We need change, we need a BJP government") - giving the TMC a taste of the same medicine it had administered to the Left Front in 2011, the last time Bengal's political landscape shifted seismically.

The election also unfolded under an extraordinary security and administrative architecture. Shah deployed nearly 250,000 paramilitary forces of various kinds, aided by armoured

personnel carriers - the kind usually seen in insurgency-prone areas such as Jammu and Kashmir, Naxal-dominated regions, or conflict zones like Manipur. The entire state administration, from Chief Secretary to Block Development Officers, was transferred, replaced by handpicked officers from BJP-ruled states. Hundreds of special election observers from outside the state were deployed, right up to polling personnel, sending a clear message that the Election Commission (and the central government) did not trust officers from West Bengal. And all this after some 27 lakh people were struck off the electoral list through the much-debated Special Intensive Revision (SIR) exercise. With more than 92% average polling, it appears that the people of Bengal, especially its youth, have given the BJP the mandate it was desperately seeking. The state is beset with unemployment and a lack of opportunities, which have led to thousands of youth migrating to other parts of India in search of jobs. It is clear that the TMC's leadership and a section of Bengal's media - steeped in conventional modes of narrative-building - had little sense of the tectonic shift that was underway in Bengal.

Where The BJP Worked The Hardest

One of the sharper explanations for the result lies in electoral arithmetic. Back in 2021, the TMC's advantage was not evenly spread: nearly a third of its 215 seats had been won by margins of more than 20 percentage points. This meant the BJP did not need to overturn Bengal everywhere. It needed to write off difficult seats and concentrate on the competitive ones, where a five-to-seven percentage-point swing could be decisive. The results suggest that the BJP did exactly that: it overperformed in vital pockets, made inroads into peri-urban belts.

Mamata Banerjee Brought Down The Left, But Never Quite Learnt From Its Fall

When Mamata Banerjee first took West Bengal by storm in 2011 with the twin slogans of "poribartan" (change) and "Ma, Maati, Manush" (mother, earth, mankind), she came as a breath of fresh air in a state desperate to unshackle itself from 34 years of Left rule.

Fifteen years later, her heady slogans lie tattered in a corner of West Bengal's psyche. From the bhadrakol in urban areas to the rural peasantry, from the tribals in the north and the south to the Scheduled Castes and OBCs scattered across the state, disillusionment with Mamata appears to have outstripped disgust with the Left, to hand the Bharatiya Janata Party (BJP) a stunning breakthrough in a state whose cultural chauvinism was long considered impervious to the appeal of Hindi heartland Hindutva. Long after the dust has settled and the first BJP chief minister assumes office in a state that the party sees as the biggest jewel in its crown after Uttar Pradesh, Mamata and other Opposition leaders will continue to question how the verdict was shaped by aggressive state interventions, such as the Election Commission's hurried Special Intensive Review (SIR) of electoral rolls (which disenfranchised around 90 lakh voters, of whom 27 lakh are awaiting a verdict on their appeals) and the positioning of 2.5 lakh paramilitary forces across West Bengal.

There are no short answers to this debate in the face of the saffron surge evident from the numbers, which tell a story in themselves. The BJP pushed up its vote share by a whopping 8%, from 38% in 2021 to 46% this time, to streak past the TMC with a comfortable four-percentage point lead. The ground was fertile for change, and the

BJP, supported all the way by the Rashtriya Swayamsevak Sangh (RSS), seized the advantage with systematic and meticulous groundwork over the past couple of years.

When Mamata Arrived The rise and fall of Mamata Banerjee is a poignant saga of a self-made woman political leader who pushed her way into a men's club through sheer grit and determination. Unlike some of her contemporaries, such as the late AIADMK leader Jayalalithaa or the Bahujan Samaj Party (BSP)'s Mayawati, Mamata had neither family legacy nor a male mentor to help her rise. She cut her teeth fighting the Left Front government on the streets of West Bengal, only to be dismissed contemptuously by the men around her, both in her own party - which was the Congress at that time - as well as her political opponents in the Left, who called her a "mad, hysterical" woman. She even took lathi blows on her head during an anti-Left demonstration in Kolkata, necessitating 18 stitches. But that didn't quieten the rebel in her.

Her star started rising once she walked out of the Congress in late 1997 to form her own regional party, the Trinamool Congress. She wove in and out of alliances, first with Atal Bihari Vajpayee's BJP, and then with Sonia Gandhi's Congress - always mercurial, always dramatic, always playing to the gallery (and performing for the media).

Ultimately, however, the traits that served her well when she swept the Left out of power in West Bengal in 2011 are the very ones that would ultimately lead to her downfall. Politics cannot survive on populism alone. The 'Didi' image earned her the undying loyalty of women

Journalism is not just a game of microphone and camera

(Factless reporting in the game of views weakens public trust)

In today's digital age, the flow of information has become faster and more widespread than ever before. Smartphones and cheap internet have given everyone a platform for expression. While this is a positive sign for democracy, it also poses serious challenges. Especially when some people, armed with a microphone and camera costing just 100-200 rupees, declare themselves "journalists" and begin disseminating information without any responsibility. This problem isn't just about individuals, but about the mindset that transforms journalism into a game of views and likes rather than a responsible social obligation. Digital media has democratized journalism. Large media houses are no longer the sole purveyors of information; ordinary citizens can also record events and bring them to public attention. Often, this citizen journalism highlights issues that mainstream media ignores. This shift is also a source of strength for democracy, as it increases the diversity of voices and strengthens the demand for accountability at all levels of power. However, when



this openness is used recklessly, this very strength turns into a weakness. Today, going "viral" on social media has become the yardstick for success. In this race, some people try to gain popularity through controversy, sensationalism, and incomplete information. They know that harsh language, accusations, and provocation attract attention, so they focus more on inciting emotions than on facts. The biggest downside is that confusion spreads in society and the line between truth and falsehood becomes blurred. People accept any information as true without verifying it, causing rumors to spread rapidly and their impact to deepen. This also directly impacts government institutions. Government institutions are the administrative backbone of any nation, and their purpose is public service. If false or misleading information spreads about them, public trust is undermined. This trust is eroded not by a single news item, but by the continuous spread of incomplete or misleading information. As

a result, people begin to doubt the system, which can lead to unnecessary conflict and discontent. It is equally true that government institutions are not infallible, but the approach to exposing their shortcomings must be factual and responsible, not merely sensational. Calling every person with a small microphone a "fake journalist" is as wrong as assuming every viral news is true. The value of journalism is determined not by equipment, but by perspective, honesty, and responsibility. Often, it's small and independent journalists who uncover the ground truth, while even large organizations sometimes err under pressure. Therefore, it's more appropriate to understand the problem as "responsible versus irresponsible" rather than "small versus big." The real crisis is the decline in journalistic values, where haste and popularity have replaced ethics and fact-checking. The solution doesn't lie in a single step; it's only possible through collective effort. First, society must become media literate, so that people don't

accept every piece of information without verifying it. They must understand that the credibility of a news story is determined by its source, evidence, and context, not by its virality. Furthermore, strict and impartial action is essential against those spreading fake news, so that a clear message is sent that freedom of expression does not mean anarchy. Digital platforms must also understand their responsibility and develop effective mechanisms to control misleading content. The need for training and ethical standards in journalism is felt more than ever. While a formal degree may not be mandatory to become a journalist, a basic understanding, a grasp of fact-checking procedures, and a sense of responsibility to society are essential. It is equally important to encourage those who work with integrity and balance to set positive examples. The greatest need today is balance. It's not right to dismiss every small journalist, nor to blindly believe every news story. We must recognize that this new age of information brings both opportunities and dangers.

Rising temperatures trigger surge in heat stroke cases across Karnataka

Bengaluru, May 5: With temperatures steadily rising across various parts of the state, doctors and public health experts have warned of an increase in heat wave-related health issues among the public. Although sudden rainfall in some places has provided temporary relief, overall temperatures have not reduced significantly. As a result, hospitals are witnessing a growing number of

patients admitted with dehydration, headache, dizziness, vomiting, fatigue, and heat stroke-related complications. According to doctors, heat stroke-related illnesses often begin gradually and can progress to severe stages. Initial symptoms include headache, joint pain, weakness, discomfort, anxiety, and dizziness. If these symptoms are ignored, body temperature can rise beyond 40 degrees Celsius.

R. Ashok Seeks Governor's Intervention for Jeevaraj Oath, Warns of Protest

Bengaluru : Shringeri MLA D.N. Jeevaraj has not yet been administered the oath by Speaker U.T. Khader. Therefore, we have requested the Governor to directly administer the oath, said Opposition Leader R. Ashok.

Speaking to reporters after meeting the Governor, Ashok said: In the recount of votes in the Shringeri Assembly constituency, BJP's D.N. Jeevaraj has been declared the winner. He has

received the certificate of election from the Election Commission, just like all other MLAs. The state government has also issued the necessary gazette notification. All MLAs, including Chief Minister Siddaramaiah, have become legislators in the same manner. When I tried to call Speaker U.T. Khader regarding this, he deliberately did not take the call. When I met him, he started giving me lectures on the law. The Speaker himself became



an MLA in the same way and did not go to court at that time. Even though there is a 45-day window

for any MLA to approach the court, it does not prevent them from taking the oath. However, Speaker U.T. Khader alone is not allowing the oath and has started a new precedent, he alleged.

Regarding the complaint against Jeevaraj, the High Court has pulled up the state government. Congress people are committing daylight robbery. The CBI should investigate whether Siddaramaiah or D.K. Shivakumar called the

Returning Officer during vote counting and exerted pressure. Nowhere has it been said that the result should be submitted to the court. There is only a direction to declare the result immediately. When we meet the Speaker and ask, he says "Come tomorrow, we need to take legal opinion." If that is the case, he should have taken legal opinion for all 224 MLAs as well, Ashok said.

According to Article 188 of the Constitution, the Governor administers the

oath. If the Speaker is not available, the Governor has the power to nominate someone else. Therefore, we have requested the Governor to administer the oath instead of the Speaker. When Mamata Banerjee's government in West Bengal did something similar, two BJP MLAs approached the Governor. We have done the same. If this process does not happen, we will have to launch a fight against the Speaker, he warned.

The ISEG Foundation, which has come forward to sign this agreement with us, has already formulated such plans in Mumbai, Visakhapatnam, Pune, and Varanasi. They have been given 4 months, within which they will submit the blueprint. I am instructing our officials to extend all necessary cooperation to them. Citizens of Bengaluru, developers, industrialists, and educational institutions must be taken into confidence to create a grand Master Plan," he directed.

Udupi: Continued gas shortage hits hotel industry

Udupi, May 5: Along with the rise in commercial gas prices, the shortage of gas supply continues, further aggravating problems for the hotel industry.

As the supply of commercial gas falls short of demand, hotels are exploring alternative options. While some hotels have turned to traditional wood-fired stoves, others have modified their menus. A few establishments have adopted a shift system—serving only limited breakfast items along with tea and coffee in the morning, providing a simple lunch, and remaining closed during the evening and night.



Some hotels are offering lunch and dinner with a limited menu, while others are restricting operations to morning and evening snacks. In this way, hotels are currently managing their daily business activities based on the availability of gas cylinders.

Complete Storm Water Drain Development Works on Priority – D.S. Ramesh

Bengaluru: The Commissioner of Bengaluru East City Corporation, D.S. Ramesh, conducted a coordination meeting with officials to accelerate the storm water drain development works being undertaken with World Bank assistance and to ensure effective inter-departmental coordination in project execution. The Commissioner stated that the primary objective of the meeting was to review the progress of ongoing storm water drain development and modernization works, identify drain boundaries, clear encroachments, and implement pre-monsoon preparedness measures in a coordinated manner.

Key Directions Issued During the Meeting

The Commissioner directed that the overall responsibility for execution, maintenance, and development of storm water drain works under World Bank funding lies with the Project Implementation Unit Officials handling the projects. The PIU has been entrusted with full responsibility to coordinate with the Revenue Department for demar-



cation of drain boundaries and removal of encroachments, ensuring smooth execution of development works. In view of the upcoming monsoon, the Commissioner instructed that all precautionary measures, emergency works, and priority tasks must be taken up immediately by the PIU without delay. The Commissioner emphasized that completing storm water drain works with speed and quality is critical to preventing waterlogging during the monsoon season. All concerned officials were directed to work in close coordination and strictly implement precautionary measures to avoid inconvenience to the public.

Prepare Effectively to Face Monsoon: Dr. Rajendra K.V.



Bengaluru : The Commissioner of Bengaluru West City Corporation, Dr. Rajendra K.V. instructed officials to work with proactive preparation, planning, and coordination to prevent potential mishaps during the upcoming monsoon season. Addressing a meeting regarding monsoon and various development works within the jurisdiction of the Bengaluru West City Corporation, the Commissioner stated that the pre-monsoon has already begun and the monsoon season will start shortly. He warned that all teams must work actively in all 112 wards of the West City Corporation to ensure no accidents occur, failing which strict action would be taken. He directed officials to carry out desilting work in roadside drains and

shoulder drains of major roads, including arterial, sub-arterial, and high-density corridors, and to maintain cleanliness to ensure water flows smoothly through the gratings. He instructed officials to conduct site inspections to confirm that cleanliness is being maintained effectively. Clear Dilapidated Buildings and Walls: Work must be carried out effectively to remove dilapidated buildings, compound walls, shelter points, manholes, and potentially falling flex/banners within the West City Corporation limits. He instructed officials to conduct supervision, identify dilapidated structures/walls, and issue notices for their removal. Stay in Contact with Locals: Identify low-lying areas where water stagnates

and areas prone to damage, and maintain continuous contact with local residents. He directed that precautionary measures be taken in problematic areas to prevent accidents by coordinating with the Corporation, Fire and Emergency Services, and the Police Department. Road Marking: The work of marking humps and speed breakers to make them clearly visible must be completed quickly. Open slabs on footpaths, debris, dried trees, and branches must be removed immediately. Additionally, he instructed that action be taken to clear encroachments on footpaths. Other Key Points and Instructions Discussed in the Meeting: * Instructions were given to effectively utilize necessary equip-

ment, including saws and wood-cutting machines, to clear trees and branches that fall during the monsoon. * Instructions were issued to maintain cleanliness by completely desilting the primary storm-water drain (Rajakaluve) near the Gaali Anjaneya Temple. * Directions were given to fill potholes quickly. * Instructions were issued to immediately remove concrete poured around the base of saplings/trees. * Instructions were given to remove unauthorized cables. * Directions were issued to take necessary measures to prevent water stagnation in underpasses. * Officials were told to obtain prior information about programs/events held in wards to ensure no negligence occurs. * Instructions were given to replace streetlights and carry out repairs where necessary. Joint Commissioner Sangappa, Deputy Commissioners Shankareppa Vanikyala and Manjunath Swamy, Chief Engineers Swayamprabha and Basavaraj Kabade, Superintendent Engineers, heads of all departments, and Executive and Assistant Executive Engineers of all divisions were present.

Commissioner inspects various areas of city – directs immediate action

Bengaluru: Commissioner of Bengaluru North City Corporation, Pommala Sunil Kumar, conducted site inspections across various parts of the city this morning and reviewed waterlogging issues, storm water drainage systems, and the progress of road works in view of the upcoming monsoon. During the inspection, strict instructions were issued to the concerned officials to take immediate action on the issues identified at various locations. Puttenahalli Lake Road: Noting severe waterlogging and traffic congestion, directions were issued for immediate clearance. Officials were instructed to strengthen the drainage system and ensure continuous monitoring to prevent recurrence. Additionally, KRDCCL engineers were specifically instructed to clear debris from footpaths without delay and to complete desilting of drains on priority by Friday. Kogilu Circle: Emergency desilting of drains was directed to address water stagnation and foul smell. Removal of cable obstructions affecting free flow of rainwater and clearance of encroachments hindering drainage works were also instructed. Further, officials were directed to coordinate with National Highways and other concerned



departments to clear all pending and obstructed works on priority. Near Motherhood Hospital, Byatarayanapura: Drain blockages caused by metro construction debris were reviewed, and BMRCL officials were instructed to clear them immediately. National Highway authorities were directed to remove road debris and improve the service road, while BESCOM officials were instructed to relocate electric poles obstructing pedestrian pathways. Tata Nagar: Due to inadequate drain width causing waterlogging, directions were issued to widen the drain and expedite the land acquisition process. Parcel Bay Underpass: Waterlogging issues and drain conditions were reviewed, and directions were given to complete

desilting within a week and undertake beautification of the traffic circle. Hebbal: To address rainwater accumulation, instructions were issued to install a 600 mm diameter pipeline to ensure smooth flow of water. Bethel Church Area: In view of metro works, officials were directed to take preventive measures against future waterlogging, construct weep holes in the divider for smooth water flow, and clear debris on roads and service lanes. BWSSB Opposite Area: Immediate cleaning and desilting of drains were instructed, along with installation of trash barriers in canals to prevent waste entry. Officials were also directed to identify the source of dumping and take strict action. BMRCL was instructed to maintain the footpath.

Veerannapalya Junction: Directions were issued to clear silt and debris from drains connected to the lake and highway and to take action against illegal parking causing traffic obstruction. Nagawara Junction: The progress of road and drainage works was reviewed, and BWSSB was instructed to identify alternative routes to reduce traffic congestion. Kempegowda Road: Inspection of drain desilting works and ongoing new drainage projects was carried out, which are expected to resolve current issues within a month. Directions were issued to immediately clear silt removed from drains along the roadside. BDA was instructed to maintain the drains and take necessary measures to prevent waterlogging. Nagawara Main Road (Near Arabic College): Drain diversion works due to metro station construction were reviewed. With the onset of the rainy season, officials were instructed to immediately clear obstructions and resolve all related issues on an emergency basis to prevent waterlogging. The Commissioner emphasized the need for coordination among all departments and directed officials to complete all pre-monsoon preparedness works at the earliest.

Will continue to take important political decisions jointly with Left parties, says VCK chief

CHENNAI: VCK president Thol Thirumavalavan on Monday said the party would take any important political decision jointly with Left parties in the future and has not taken any decision or deliberation on extending support to TVK, as Tamil Nadu faces a hung Assembly with no party securing a clear majority.



"We have been travelling together in secular politics for a long time. We will continue to take important political decisions jointly in the future. We have not yet deliberated or arrived at any conclusion on the question you raised," he told

reporters after paying floral tributes to Karl Marx statue at Connemara Library.

On the fractured verdict, he said, "Let us wait and see. We are also like you, a spectator." He declined to

respond to questions on whether the party would join TVK alliance, stating that he would not answer speculative queries.

He said the party was not concerned about hypothetical scenarios

such as support from the PMK, and maintained that the people's verdict was favourable to the political line advanced by the party.

On the overall outcome, he said the DMK-led alliance had failed to secure a mandate to form the government, but had succeeded in its primary objective of preventing the BJP-AIADMK combine from gaining strength in the State. He said the TVK was not projected as the primary target of the alliance's campaign, and therefore no intensive campaign was mounted against it. "Our focus was on ensuring that the AIADMK-BJP combine

did not gain strength. The people of Tamil Nadu have endorsed that position through their vote," he said. While expressing disappointment that the votes had not entirely consolidated in favour of the alliance, he said the outcome still represented a significant political success. He added that the verdict had ensured that such forces would not be able to gain a foothold in Tamil Nadu.

Referring to his earlier statement, he said anti-BJP votes had split, with a portion possibly going to the TVK in addition to those expected for the party.

Hero of Tamil Nadu polls 2026 needs supporting actors to form government: Vijay's options with 108 seats

All eyes are on Tamil Nadu after actor-turned-politician C Joseph Vijay's Tamilaga Vettri Kazhagam (TVK) emerged as the single-largest party following the 23 April elections to the state Assembly. TVK's victory has all the trappings of a Vijay thriller. Widely considered to be enjoying the limelight that surrounds a successful action hero but not enough to pull off a victory, TVK ended the race with 108 seats in its kitty.



The DMK-led alliance, which sought a second term under the slogan "Dravidian Model 2.0," could win only 73 seats, while the AIADMK and allies, including the BJP, finished third with 53 seats. The TVK has now written to Governor Rajendra Vishwanath Arlekar, urging him to invite the party to form the next government, though the organisation is 10 MLAs short of the required 118 for a simple majority in the 234-member strong Assembly. The party has also stated in the letter its willingness to prove its majority on the floor of the Assembly within two weeks.

Numbers matter If the next Speaker is from the TVK, the party will need the support of 11 more MLAs to prove its strength in the House. Additionally, Vijay has won from two constituencies, Perambur and Trichy East, and will have to resign from one, most probably the latter. This would reduce the party's strength to 107, and it would need the support of 12 MLAs. TVK contested the polls alone, without allies. Therefore, the party would need the support of others currently aligned with the DMK, such as the Congress, Viduthala Chiruthaigal Katchi (VCK), the two Communist parties, and the Desiya Murpokku Dravida Kazhagam (DMDK). Alternatively, even if Vijay secures PMK's support, he

would still require the backing of parties in the DMK bloc. PMK has won four seats in the polls. This has triggered intense political debate over Vijay's possible move. Ever since launching TVK, Vijay has consistently spoken about "sharing power and governance" as a core principle. Based on this, the party has maintained that any alliance partners would be given a share in power, including representation in the Cabinet.

However, no party allied with TVK during the election. In this context, parties such as the Congress and VCK have begun reiterating their demand for a share in governance. Notably, VCK leader and Member of Parliament Thol Thirumavalavan stated that the idea of a coalition government in Tamil Nadu, strongly proposed by the VCK in 2016, has now been endorsed by the people a decade later.

He added that while it is disappointing that the secular DMK alliance was not given a mandate, it is equally satisfying that voters had rejected the AIADMK-BJP alliance. Meanwhile, MDMK leader Vaiko, speaking to reporters, categorically ruled out support for TVK by DMK alliance parties.

At the same time, leaders from the CPI, CPI(M), and VCK, M Veerapandian, P Shanmugam, and Thirumavalavan, respec-

tively, said that their parties would take a joint decision on the issue. Left leaders also noted that a final decision would be made only after discussions within their respective state committees. They further added that no formal invitation has been received so far from the TVK. With the neighbouring Kerala rejecting the LDF, the communist parties are out of power in the whole of India. Interestingly, the Indian National Congress, a key constituent of the DMK alliance, has so far remained silent on both the election defeat and its future course of action. However, whichever party extends support to Vijay is likely to demand a share in the Cabinet. This could potentially pave the way for a coalition government in Tamil Nadu after nearly 60 years.

Political analyst and professor Arun Kumar felt that TVK is not likely to accept AIADMK's outside support.

"AIADMK and DMK may not want each other to come to power. In this scenario, the AIADMK could extend outside support to TVK, saying they are opposing a common political rival. However, since the BJP is part of that equation, it remains uncertain whether TVK would accept such an arrangement," he said. Kumar noted that parties in the DMK alliance, such as the Congress and VCK, may support Vijay. Similarly,

Auto, loadvan drivers take 2 seats into TVK's kitty



CHENNAI: In Chennai's Royapuram constituency, an auto driver handed TVK a coveted win, defeating former AIADMK minister D Jayakumar and the son of former minister Rahman Khan, A Subair Khan of DMK.

Vijay Damu, a district secretary of TVK, secured 59,091 votes, about 14,000 votes more than the runner-up DMK candidate. Damu's gesture of falling at Vijay's feet and hugging after his surprise candidature drew attention on social media. He called him-

self a "normal auto driver", but on May 4, Damu prevailed over two strongmen. In a similar story, TVK's R Prakasam alias Kutty, a loadvan driver, became the Poonamallee MLA 1,61,309 votes, with a whopping 72,740 margin over DMK's Krishnaswamy A.

Don't scrap Stalin regime's welfare schemes, appeals Vaiko

CHENNAI: MDMK general secretary Vaiko on Tuesday said the party that forms the government must continue the welfare schemes implemented by the Stalin government, even as he ruled out any possibility of the DMK alliance extending support to the Tamilaga Vettri Kazhagam. After meeting DMK president MK Stalin at Anna Arivalayam, Vaiko said the DMK government had implemented several pioneering schemes benefiting women, schoolchildren, mothers, and various sections of society. "The responsibility now lies with the party that has won to continue these schemes without any interruption. Not a single scheme should be dropped," he said. He noted that though the DMK-led alliance had secured 73 seats, it had fallen short of the numbers required to form the government.



Drawing a parallel with the 1962 Assembly election, he said the DMK had then won 50 seats but did not celebrate as party founder C N. Annadurai had lost in Kanchipuram. "A similar sentiment prevails now as Stalin, who led a government noted for its achievements, has not emerged victorious," he said. Vaiko said the people's verdict must be accepted in a democracy. "The electorate has given more seats to another party. We respect that mandate," he added.

TN election results 2026: Big blow to Seeman as vote share shrinks to 4%



CHENNAI: Tamil nationalist party Naam Tamilar Katchi (NTK), which positioned itself as an alternative to the Dravidian majors, suffered multiple setbacks on May 4. On the one hand, its vote share has been hit, down to 4% at the time of the story going for print, from its previous best of

crossing 8%. It's rubbing salt on NTK's wound that the public has recognised new-bie TVK as the alternative to rule the State. NTK contested all 234 constituencies in the state, maintaining its long-standing strategy of going solo in both Assembly and parliamentary elections, but was dwarfed by Vijay's party, which scored major wins in its debut. The party fielded a diverse slate of candidates, including a notable transgender candidate.

Cong strike rate plummets to 17%; party weighs to side with TVK in hung Assembly

CHENNAI: The Congress, reeling from a sharp drop in its strike rate to 17% in the 2026 Assembly elections, is weighing a possible realignment with actor-politician Vijay's Tamilaga Vettri Kazhagam (TVK) amid indications of a hung Assembly. Congress leader Rahul Gandhi congratulating Vijay on the victory and a related social media post have fuelled speculation.

The party contested 28 seats after hard-fought negotiations with its ally DMK, but managed to win only five. Tamil Nadu

Congress Committee president K Selvaperunthagai was among those defeated, losing in Sriperumbudur.

The performance marks a steep fall from recent elections. In 2021, the Congress won 18 of 25 seats (72% strike rate), while in the 2024 Lok Sabha polls, it secured all nine seats it contested. By contrast, its 2026 Assembly strike rate dropped drastically to 17%.

One of the party's few bright spots came in Melur, where P Vishwanathan, a Dalit candidate contesting in a



general constituency, won by 2,724 votes, def-

ying earlier criticism over his candidature. With

TVK projected to win around 106 seats—short of

the majority mark of 118—the possibility of a hung Assembly has opened the door for post-poll alliances. Sources indicate that Congress may consider extending support to TVK to facilitate government formation. AICC Tamil Nadu in-charge Girish Chodankar said the party is closely monitoring the results and will submit a detailed report, including TVK's performance, to senior leaders Rahul Gandhi and Mallikarjun Kharge before taking a final call. He also confirmed that Gandhi had spoken to Vijay over the phone.

'Lazy eye' not always harmless: Experts warn of possible neurological causes

New Delhi, May 5: The commonly used term "lazy eye" may not always be as harmless as it sounds, with medical experts cautioning that similar symptoms in some cases could indicate serious neurological conditions, including brain tumours.

According to Dr Rahul Gupta, Senior Director and Head of Neuro and Spine Surgery at Fortis Noida, "lazy eye" medically refers to amblyopia — a childhood condition caused by improper visual development. It typically leads to reduced vision in one or both eyes, squint, and difficulty focusing.

"Lazy eye is basically amblyopia, which develops in childhood due to a neurodevelopmental issue where the child is unable to see properly," Dr Gupta explained, adding that the condition is not linked to brain tumours.

However, experts warn that symptoms resembling amblyopia, especially when they appear suddenly or later in life, should not be ignored. In such cases, the issue may stem from neurological causes rather than a



simple vision problem.

Patients experiencing sudden vision loss, double vision, abnormal eye movements, drooping eyelids, or a newly developed squint could be showing signs of underlying brain-related conditions.

Brain tumours can affect vision in multiple ways — by directly com-

pressing the optic nerve, increasing pressure inside the skull, or affecting cranial nerves responsible for eye movement. These changes may result in vision impairment or misalignment of the eyes, often mistaken for a benign condition.

The World Health Organisation classifies tumours of the central nervous system into grades 1 to 4 based on their aggressiveness, aiding in accurate diagnosis and treatment planning.

Dr Gupta emphasised that confusion between amblyopia and neurological symptoms can delay timely diagnosis. "These two conditions must be understood separately," he said. Doctors advise seeking immediate medical attention if symptoms such as sudden vision changes, persistent double vision, headaches with visual disturbances, or drooping eyelids are noticed. Early evaluation through eye examinations, neurological assessment, and imaging tests like MRI can help detect serious conditions at an early stage and improve treatment outcomes.

India strengthens rare disease framework with expanded care, funding, and research push

New Delhi, May 5: The government on Tuesday highlighted India's growing focus on tackling rare diseases, noting that the issue first gained policy attention under the National Health Policy, 2017 and was later formalised through the National Policy for Rare Diseases, 2021, establishing a comprehensive national framework.

Speaking at a conference, Punya Salila Srivastava, Union Health Secretary, said the government aims to better understand stakeholder challenges, promote innovation, and strengthen systems for managing rare diseases across the country. She explained that the policy is being implemented through a network of Centres of Excellence (CoEs), which are leading tertiary care hospitals. The number of such cen-



tres has grown from eight to fifteen, including two in the northeast, enhancing access to specialised care nationwide.

Financial assistance for patients has also been significantly increased, with support of up to ₹50 lakh now available for treatment of identified rare diseases, helping improve affordability and access.

Addressing the high cost of therapies, Srivastava noted that the government has exempted several life-saving drugs from basic customs duty, with further exemptions announced in

the latest Union Budget. She also invited stakeholders to recommend additional drugs that could be considered for such relief.

She acknowledged the role of the Indian Council of Medical Research in advancing indigenous research and therapy development for rare conditions. Rajiv Bahl, Secretary of the Department of Health Research and Director General of ICMR, reflected on how the rare disease landscape has evolved over the past three decades. He pointed out

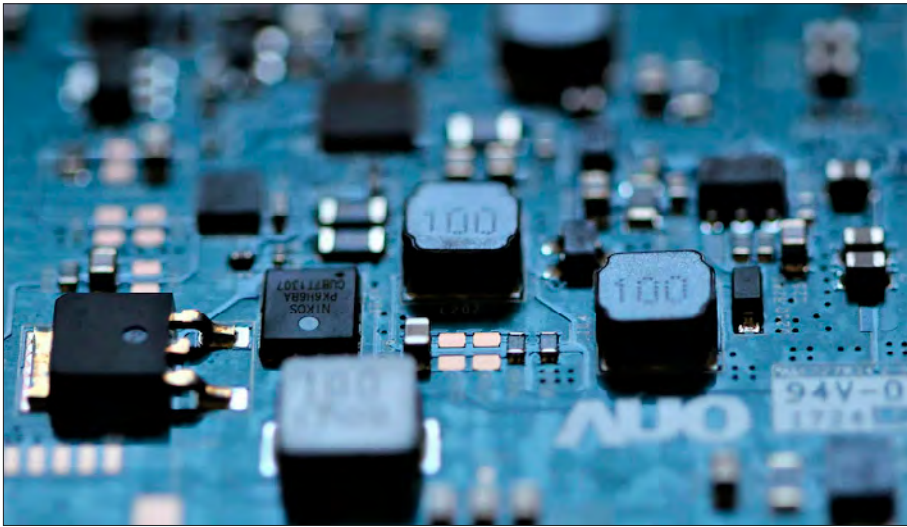
that in the 1990s, diagnosis was extremely difficult and treatment options were almost non-existent, often leaving doctors with limited options.

He stressed that India must develop its own context-specific approaches to diagnosis, treatment, and prevention, rather than depending entirely on Western models. He added that ICMR is actively working to expand diagnostic tools and treatment capabilities. Meanwhile, Sunita Sharma, Director General of Health Services, underlined the importance of strengthening healthcare systems for early detection and comprehensive care. She called for better integration of rare disease services across all levels of healthcare to ensure timely referrals and continuity of treatment through an efficient network.

Cabinet Clears Two New Semiconductor Units For Rs 3,900 Crore Under ISM 1.0

TOTAL APPROVED PROJECTS RISE TO 12

The Union Cabinet has approved two new semiconductor manufacturing projects under the India Semiconductor Mission (ISM) 1.0, taking the total number of cleared proposals to 12. The two projects, entailing a combined investment of about Rs 3,936 crore, will be set up in Gujarat and are expected to generate over 2,200 skilled jobs. Among the approvals is the country's first commercial facility for Mini/Micro-LED display manufacturing based on Gallium Nitride (GaN) technology. This project, led by Crystal Matrix, will come up in Dholera and include an integrated compound semiconductor fabrication and assembly unit. The facility will cater to a wide range of applications, from televisions and smartphones to automotive displays and emerging segments such as extended reality devices. The second project, by Suchi Semicon, will establish an outsourced semiconductor assembly and test (OSAT) facility in Surat. The unit will focus on discrete semiconductors with applications across power electronics, industrial systems, automotive and consumer electronics, with a pro-



posed capacity of over 1 billion chips annually. With these additions, cumulative investments under ISM have reached around Rs 1.64 lakh crore. The government said the approvals will strengthen India's broader semiconductor ecosystem, complementing ongoing efforts in chip design and manufacturing. Of the projects cleared so far, two have already begun commercial shipments, while several others are at advanced stages and expected to go online soon, signalling steady progress in India's ambition to build a domestic semiconductor

value chain. India's electronic manufacturing strategy is driven by the Prime Minister's vision of AtmaNirbhar Bharat and Making India a global manufacturing hub. The Government adopted a structured and targeted policy for electronics manufacturing across the entire value chain including semiconductors. As a result of these policies, electronics manufacturing in India has expanded significantly in the last 11 years. It can be seen from the following statistics: Semicon India Programme Semiconductors is a foundational and strate-

gic industry. Semiconductors are used in almost every device. To promote the development of its manufacturing ecosystem in India, the Government launched Semicon India Programme in January 2022. It aims at developing a complete ecosystem, ranging from design, fabrication, assembly, testing, packaging and module manufacturing. In a short span of four years, the Government has approved 10 projects with investment commitments of about ₹1.6 lakh crore. Commercial production from two plants (Micron and

Keynes) has commenced with 2 more plants to start commercial production this year. The details of the approved Semiconductor manufacturing units are placed at Annexure I. Developing India's chip design ecosystem: Government is developing India's chip design ecosystem in two ways: 1. Supporting Indian design engineers through chip design tools in one of its kind initiative in the world, Government has provided cutting edge chip design tools from 8 different companies to 315 universities at no cost. So far, their usage has exceeded 200 lakh hours. Using these tools 211, chips have been taped out by 75 institutions across India including 149 chips at 180nm, SCL Mohali and 62 chip at overseas foundries. 2. Supporting Indian design companies through grant, free design tool and fabrication support: Government has approved 24 projects for the design of semiconductor chips and SoCs. 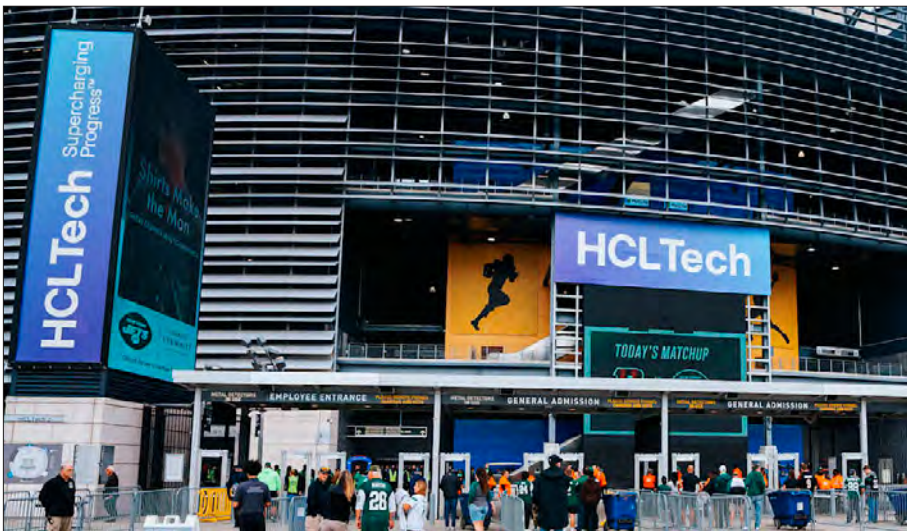

Hon'ble Mr. Justice Jasmeet Singh drew attention to the enduring centrality of the human element in arbitral proceedings, calling for progressive and purposive interpretation of Section 34 of the Arbitration and Conciliation Act — particularly in the context of rapidly advancing artificial intelligence. In his address, Chief Guest Hon'ble Mr. Justice V. Kameswar Rao reflected on ADR's inherent adaptability to technological and economic transformation, stressing that institutional arbitration — with its emphasis on transparency, accountability, and structured process — remains the most credible framework for navigating this evolution. He called for a deliberate balance between technological innovation and the irreplaceable quality of human understanding in dispute resolution.

Hegseth says the US-Iran ceasefire is 'not over' despite attacks in Strait of Hormuz

'Iran knows what not to do', Trump says when asked about ceasefire violations published at 21:21 21:21 "Well, you'll find out because I'll let you know." Trump says when asked what Iran would have to do to constitute a breach of the ceasefire. "They know what to do, or what not to do more importantly." He says they don't have any boats in their navy, instead they have eight "little boats" that are "all gone". "So they're looking around for little boats to try and compete with our great navy," he adds. On the US blockade of Iranian ports, Trump says not one Iranian ship has been able to pass. One ship tried and US forces "hit the engine with one shot" after being warned not to cross. More now from President Donald Trump, who says if the US hadn't engaged in the conflict "we would've had an Iran with a nuclear weapon". "Maybe we wouldn't all be here right now," he adds. For context,



the UN, US and EU imposed extensive economic sanctions on Iran from 2010, over suspicions that its nuclear programme was being used to develop a bomb. Iran says its nuclear programme is for civilian purposes only. The president says the US "have beaten [Iran] badly", adding that Iran is "reduced to little boats with a machine gun on

the front of them". It comes after the US attacked small Iranian boats in the Strait of Hormuz. In a Truth Social post on Monday, Trump said: "We've shot down seven small Boats or, as they like to call them, fast Boats". At the Oval Office, Trump claims Iran started the war with 159 ships, before saying "every single ship they had is rest-

ing underwater at the bottom of the sea". We've just heard Trump, who is speaking at the Oval Office, mention the ongoing war with Iran. "Iran has no chance," he says. "They never did. They know it. They express it to me when I talk to them and then they get on television and say how well they're doing." He repeats the

familiar lines that the US has wiped out Iran's military, navy, airforce, and leaders. "We can't let Iran have a nuclear weapon," he adds. Moving away from a focus on the Strait of Hormuz briefly, we can bring you this report from Lebanon where the conflict with Israel continues: Evacuation orders have become the norm for many Lebanese villages and towns in the south, and when people get these orders, they don't know when or if they will be able to go back. Yesterday several villages also got the order of evacuation and more strikes came from the Israel Defence Forces. Sometimes these orders are happening in areas that haven't been declared to be inside the yellow line, because the Israelis keep expanding their position on the ground and the areas they declare as a buffer zone to protect their borders. The Israelis maintained the same line

throughout the war that they are attacking Hezbollah infrastructure, Hezbollah personnel - but actually, if we look at figures and numbers and names of people who've been killed, most of them are civilians. Some are paramedics and journalists, even. There is mounting anger because villages and homes and towns have been destroyed or demolished completely, with the fear that these areas in the south will not go back to being residences. The Israelis have warned that no-one can come back. But the Lebanese want to come back - they have nowhere to stay. It's a really dire situation for people to go back to their homes. The manoeuvre, announced by Trump on Sunday, involves US forces guiding commercial ships and their crews through the Strait of Hormuz, which has been effectively blocked by Iran, the US Central Command (Centcom) says.

Popular Australian author pleads guilty over child exploitation material

Popular Australian author Craig Silvey, best known for his children's and young adult fiction books, has pleaded guilty to possessing and distributing child exploitation material. Silvey, 43, was arrested in January during a police raid at his Perth home in Western Australia where several electronic devices were seized. In court on Tuesday, the Jasper Jones and Runt author admitted to two charges relating to child exploitation material produced in January. Police dropped two extra charges, one over material allegedly produced in 2022. The father-of-three's bail was continued and he is due back in court in July. Since his arrest, publishers, shops and schools have pulled his books from shelves. Outside court, Silvey did not make any comments to the media. His 2009 novel Jasper Jones - a coming-of-age story featuring a 13-year-old boy as its protagon-



ist - garnered several awards in Australia and was shortlisted for the International Dublin Literary Awards. In 2017, it was made into a feature film, starring Toni Collette and Hugo Weaving. Another of his acclaimed works is 2022's Runt, about the adventures of an 11-year-old girl and her stray dog and set in the Australia outback. It was also adapted for film in 2024, featuring Celeste Barber.

ROMANIAN PM OUSTED IN NO-CONFIDENCE VOTE



Romanian MPs have voted to remove Prime Minister Ilie Bolojan in a no-confidence vote in parliament. The largest party, the left-wing Social Democrats, abandoned Bolojan's four-party coalition last month and joined the far-right opposition to call for the vote. The Social Democrats have repeatedly clashed with Bolojan, a liberal, over austerity measures aimed at reducing the budget deficit. President Nicusor Dan, who is now expected to try to rebuild the coalition under a different prime minister, has sought to give reassurances that Romania - an EU and Nato member which borders Ukraine - will retain its pro-Brussels stance. A total of 281 MPs voted for the no-confidence motion, well above the 233 needed for the measure to pass. Elections are not due until 2028, and though a snap poll is unlikely, financial markets are concerned that the turbulence could mean Romania wavers in its commitment to narrowing the EU's biggest budget deficit. Romania's currency, the leu, fell to a record

low against the euro ahead of Tuesday's vote. Bolojan's coalition came to power 10 months ago during efforts to curb the rise of the far-right Alliance for Uniting Romanians (AUR), which won one-third of parliamentary seats. Dan himself won a tense presidential poll last May, after a far-right victory in elections the previous year was annulled over allegations of campaign fraud and Russian interference. The coalition had started to reduce the deficit but frictions with the Social Democrats grew as the leftists' voter base was hit by austerity. The party has said it is prepared to rejoin a pro-EU coalition under a different prime minister. "Political discussions will be difficult, but it is my responsibility as president - and that of the political parties - to steer Romania in the right direction," Dan told reporters. The president is now expected to nominate a different member of Bolojan's party, or possibly a technocrat, to lead a new government. Bolojan will continue as caretaker prime minister until it is approved.

Robots move in as waste firms struggle to find staff

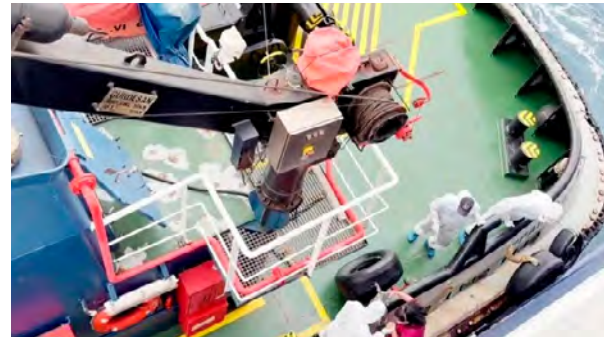


The dust at this busy recycling plant is pervasive and the steady noise of hoppers and conveyor belts makes this a challenging environment to work in. The facility in Rainham, east London is owned by Sharp Group, a family-run skip and waste management firm. Along the conveyor belts runs everything you could imagine, from shoes, to old VHS cassettes and blocks of concrete. The team here processes up to 280,000 tonnes of mixed

recycling every year with 24 agency workers on its rapid conveyor belts. This is a hazardous industry. While Sharp Group is proud of its safety record, work-related injury and ill-health in the sector is 45% higher than other industries. And the fatality rate is a sizeable multiple of the national average. These factors, along with the unpleasant nature of the work, mean keeping workers is difficult. Annual staff turnover runs at 40%.

Hantavirus may have spread between passengers on cruise ship, WHO says

The World Health Organization says there may have been rare human-to-human transmission of hantavirus on the Dutch cruise ship where three passengers have died. The virus is usually spread from rodents, but the WHO said in this instance it could have spread among "really close contacts" aboard the MV Hondius vessel. It stressed the risk to the public was low. Two crew members - one British and one Dutch - are due to be medically evacuated by aircraft to the Netherlands after displaying "acute respiratory symptoms", the ship's operator Oceanwide Expeditions said. MV Hondius set sail from Argentina on its voyage across the Atlantic Ocean around a month ago. It is



currently anchored near Cape Verde, off Africa's west coast. Medical teams from Cape Verde, supported by the WHO, have boarded the ship to help with the suspected cases, spokesperson Tarik Yasarevic told the BBC. Testing is taking place for other passengers and crew members who are displaying symptoms. Images taken from on board the cruise ship show workers in

hazmat suits in a smaller vessel alongside. Some 149 people from 23 countries remain aboard under "strict precautionary measures", Oceanwide said. They include around 20 British nationals, according to a UK government spokesperson. "We do believe that there may be some human-to-human transmission that is happening among the really close contacts," WHO offi-

cial Dr Maria Van Kerkhove said. She added that the WHO suspected the first person to fall ill could have contracted the virus before boarding the ship. Seven cases of hantavirus - two confirmed and five suspected - have so far been identified, according to the latest WHO update. A person "associated" with the German national who died is due to be medically evacuated alongside the two crew members. The two confirmed cases are a Dutch woman, who is among those who died, and a 69-year-old UK national who was evacuated to South Africa for medical treatment. The woman's husband also died but he is not a confirmed case, nor is the German national who passed away on 2 May.

Two killed and many injured after car driven into crowd in German city of Leipzig

Two people are dead and several others injured after a car drove into a crowd in the eastern German city of Leipzig on Monday afternoon, local authorities said. Leipzig Mayor Burkhard Jung said the suspected perpetrator - who authorities have confirmed is a 33-year-old German citizen - was arrested. Jung added that authorities were not yet clear about a motive. Police confirmed a car had struck several people in the central Grimmische Straße area before driving off. Authorities said 22 people were injured, including three seriously. Michael Kretschmer, the head of the state of Saxony, of which Leipzig is a part, said the sus-



pect previously suffered from mental illness. "We are utterly stunned by what has happened. A man has driven at high speed into the shopping area. We are currently mourning two deaths, three people with serious injuries and many others who have been injured," Jung said. "It is

impossible to find the right words to describe this horrific rampage." Leipzig police spokesperson, Susanne Luebecke, said that at about 17:35 (15:35 GMT) "a person drove a vehicle across Augustusplatz into Grimmische Street, continuing on past the market".

"Several people were injured in the incident. Unfortunately, we also have to report two fatalities," she added. "We are talking about a case of violent rampage here. We are working on the assumption that this was the act of a lone perpetrator and currently have no indications that there is still a threat to public safety." The Leipzig's public prosecutor's office confirmed the deceased were a 63-year-old woman and a 77-year-old man, both German citizens. It said they are investigating the suspect for murder and attempted murder, and that there was "no basis on current knowledge" to suggest there was either a religious or political motive involved.

NINE COAL MINERS DIE IN GAS EXPLOSION IN COLOMBIA



Nine people have died in an explosion at a coal mine in Colombia in the latest fatal accident to hit the country's mining sector. Emergency workers said they had rescued six miners from the shafts in Sutatausa, north of the capital, Bogotá. Colombia's national mining agency said a build-up of gases was thought to have caused the explosion at 16:00 (21:00 GMT) on Monday. It also published a list of recommendations it said it had made to the mine's operators after an inspection less than a month ago, in which it had warned of a "potentially dangerous gas build-up". Many mines in Colombia are operated informally and without proper safety standards. The captain of the regional fire department, Alvaro Farfán, said emergency workers were still working to retrieve the miners' bodies. Those who survived are being treated in hospital. Mining accidents are common in Colombia. Last July, 18

workers were rescued from an unlicensed gold mine after having been trapped underground for 18 hours due to a mechanical failure. One of the deadliest recent incidents also unfolded in Sutatausa in 2023, when 21 people died in a blast which tore through the tunnels of a complex of coal mines in the area. That explosion was caused by a build-up of methane gas, investigators said at the time. Sutatausa has been a coal-mining centre for decades with many of its residents working in the industry.

RUSSIA AND UKRAINE ANNOUNCE RIVAL CEASEFIRES AS DEADLY STRIKES CONTINUE

Russia and Ukraine have declared unilateral ceasefires starting this week, ahead of commemorations held by Russia to mark the Soviet Union's victory over Nazi Germany on Saturday. Russia said it would hold a ceasefire on 8 and 9 May and threatened a "massive missile strike" on central Kyiv if Ukraine violated the truce. But Kyiv announced it would observe an open-ended ceasefire from midnight on 6 May, and that Ukraine would act "symmetrically" from that point on. Volodymyr Zelensky's chief of staff Kyrylo Budanov said that if the ceasefire announced by the Ukrainian president was reciprocated, "we will continue to observe



it... The next move is Russia's". Shortly after the warring sides announced the moves, five people were killed and dozens injured in combined missile and drone

strikes across Ukraine overnight. In Russia, authorities in the Chuvash Republic said two people were killed and 32 injured in a drone attack on Tuesday

morning. The two ceasefires appear to be unilateral - meaning the two sides have not agreed on their terms, length or monitoring. "We have made our proposal,"

Zelensky said, urging Russia to lay down arms "and move to real diplomacy". "It's utter cynicism to ask for silence to hold propaganda celebrations and to launch such missile-drone attacks every day beforehand," he added. Ukraine's earlier, open-ended truce is likely a way for Zelensky to show that his country is willing to start an immediate and lasting ceasefire and that any violations will be pinned on Russia. "We believe that human life is of incomparably greater value than the 'celebration' of any anniversary," he wrote on Telegram. Ahead of its own midnight ceasefire on Wednesday (Tuesday 22:00 GMT), Ukraine also launched a series of aerial

attacks on Russia, hitting an industrial area in Kirishi in the Leningrad region and a factory that produces military components in Cheboksary, in the Chuvash Republic. Zelensky said domestically-produced Flamingo cruise missiles were used to strike the Cheboksary factory, some 1,500km (930 miles) away from the front line. An unverified nighttime video showed a fast-moving object and large explosion. The Russian defence ministry later confirmed it had downed six Ukrainian Flamingos as well as 601 drones. On Tuesday morning, several airports across Russia were temporarily shut.

"Unacceptable": Sunil Gavaskar Blasts Jasprit Bumrah For Big Error Against Lucknow Super Giants

Legendary Indian cricket team skipper Sunil Gavaskar blasted Mumbai Indians fast bowler Jasprit Bumrah for a major error during the IPL 2026 match against Lucknow Super Giants on Monday. During the 14th over of the LSG innings, Himmat Singh was foxed by a delivery from Bumrah and ended up getting caught behind by Ryan Rickelton. However, the bowler's joy was short-lived as the siren went off and the umpire signalled no-ball. Gavaskar was left fuming by Bumrah overstepping at such an important juncture and said that it is 'unacceptable' for a player of his calibre to bowl no-balls at that time. "This is not acceptable. You are a professional cricketer. Wides, I understand. But not no-balls," Gavaskar said on commentary. Mumbai Indians rode on sublime half-centuries from openers Rohit Sharma and Ryan Rickelton to outclass Lucknow Super Giants



by six wickets in a high-scoring Indian Premier League clash on Monday. Rohit hammered a fluent 84 off 44 balls and stitched a 143-run opening stand with Rickelton (83 off 32 balls) to power Mumbai Indians past Lucknow Super Giants' 228 for five, sealing the chase in 18.4 overs and notching up

their third win in 10 matches to move to six points. Lucknow, meanwhile, remained rooted to the bottom of the table with just four points from nine outings. Earlier, bottom-placed LSG finally found some spark as Nicholas Pooran smashed his maiden half-century of the season.

Dinesh Karthik is a journeyman of sorts in the IPL. He started his journey with Delhi Daredevils and then went on to play for Kings XI Punjab, Mumbai Indians, Royal Challengers Bengaluru, Gujarat Lions and Kolkata Knight Riders. The former Indian wicket-keeper-batter ended his IPL career with RCB in IPL 2024. His association with RCB, however, did not end there, as he joined the side as batting coach and mentor. Karthik has revealed that Virat Kohli played a big part in him taking up the role. "It manifested when, as I was finishing in 2024, Mo asked me if I would be keen or interested. I was in the middle of the tournament, and it was a very different IPL season - we had lost six out of seven or seven out of



eight games, I don't remember exactly - and we had a mountain to climb. To be fair, nobody gave us a chance," he said on a podcast. "But I was so invested in that. We were having discussions while I was playing, and I was also speaking to my wife and Mo. Malolan Rangarajan was also

giving me a picture of what it could be if I played. He never told me, 'Do this or do that.' He just showed me how it would look." "Mo was very confident I would be useful to the team. I trust Mo a lot - I've grown very fond of him and have a very good equation with him. He didn't convince me, but he

showed me exactly what it would look like and told me it's a good place to be, considering where I was in my career. I completely trusted him, and I dropped my hat," Karthik said on the RCB Podcast. Karthik said his multiple interactions with Kohli helped him make the decision. "In between all of this, towards the back end of the season, I spoke to Virat for a while, and he was very encouraging. He said, 'Think about it, I think it's good.' When the offer really came at the end of the season, after I hung up my boots, Mo called me and said they were keen. He also said Andy Flower was very happy and they were in a place where they felt a couple of Indian coaching staff would help as well," he said.

LSG Owner Sanjiv Goenka's Post For "Living Legend" Rohit Sharma Wins Internet

Marking a return from injury on Monday, Rohit Sharma played a pivotal role in the Mumbai Indians' victory over the Lucknow Super Giants in the Indian Premier League (IPL) 2026. Rohit emerged as the top-scoring batter in the match, registering an 84-run knock of 44 balls, while also orchestrating a match-winning partnership of 143 runs for the first wicket with Ryan Rickelton. After the game, Rohit engaged in a casual chat with the owner of the LSG franchise, Sanjiv Goenka, who shared a post on Tuesday, calling the MI stalwart a 'living legend'. The 39-year-old opener batter was making his return to the MI playing XI after missing a few matches due to injury, and he played an



impactful knock in just 44 balls with the help of six fours and seven sixes. As Goenka met Rohit after the game, he couldn't stop hailing his humility. "The warmth @ImRo45 carries shows up in every conversation I have with him. His humility is evident in every

moment spent around him. That's what makes him a champion and a living legend," the post from the LSG owner read. Speaking on Star Sports' 'Amul Cricket Live', the former Indian skipper Sunil Gavaskar lauded Rohit Sharma's batting display against LSG. "I

have been watching Rohit Sharma closely over the last year. Ever since he was removed as captain in white-ball cricket and the IPL, he has focused more on his batting. He scored runs in the ODI series against Australia, did well in the home series, and now he is doing the same in the IPL. In the IPL, he usually scores 400 to 500 runs a season, but his knocks are often impactful. He may not have many 80-plus innings, but his 40 to 50-run starts give his team early momentum," said Gavaskar. "The change in his game is clear: he now wants to bat deeper and leave a bigger impact. In this 84-run knock, we saw all the typical Rohit Sharma shots. The pull shot was on display.

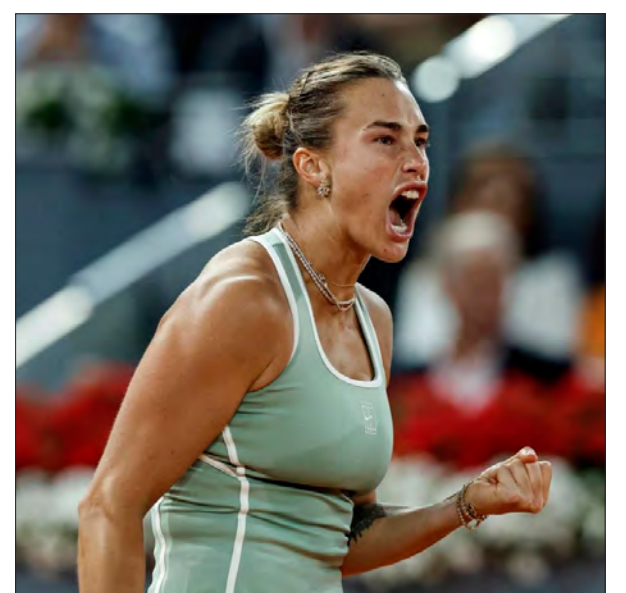

Coach Luis Enrique Has PSG On Brink Of Another Champions League Final



Luis Enrique will join a select group of coaching greats if he leads Paris Saint-Germain to Champions League glory again this season, and it is his remarkable management that has the French club tantalisingly close to reaching the final once again. PSG head to Munich for the second leg of their semi-final against Bayern on Wednesday defending a 5-4 lead from an incredible first meeting which was one of the greatest matches in the competition's history. "It was the best game I have been fortunate enough to be involved in as a coach," Luis Enrique said after that encounter at the Parc des Princes. He nevertheless believes his side will need to score another three goals at the Allianz Arena in order to see off the German champions and secure a place in the May 30 final in Budapest. But he and his side need not look too far back for inspiration - their last visit to Munich ended in PSG hammering Inter Milan 5-0 in last season's final as they won the Champions League for the first time in their history. Maybe, after all he has achieved in his career, Luis Enrique could have simply walked away following that triumph, his job done.

World No. 1 Calls For 'Boycott' Just Ahead Of French Open



Top-ranked Aryna Sabalenka believes tennis players should organize a boycott if they don't start receiving a bigger share of tournament revenues at the Grand Slams. Sabalenka and fellow No. 1 Jannik Sinner were among leading players - most of them ranked in the top 10 - who issued a statement on Monday expressing "deep disappointment" over the French Open prize money. "Without us there wouldn't be a tournament and there wouldn't be that entertainment. I feel like definitely we deserve to be paid more percentage," Sabalenka said on Tuesday at the Italian Open as she celebrated her 28th birthday. "I think at some point we will boycott it. I feel like that's going to be the only way to fight for our rights." The players are also seeking better representation, health options and pensions from the four

Grand Slam tournaments: Australian Open, French Open, Wimbledon and U.S. Open. French Open organizers announced last month they were increasing overall prize money by about 10% for an overall pot of 61.7 million euros (\$72.1 million), with the total amount up 5.3 million euros from last year. But the players' statement said "the underlying figures tell a very different story," claiming they will receive a smaller share of tournament revenues. "Players' share of Roland Garros tournament revenue has declined from 15.5% in 2024 to 14.9% projected in 2026," the players said. Iga Swiatek, a four-time French Open champion, said "the most important thing is to have proper communication and discussions with the governing bodies so we have some space to talk and maybe negotiate.

Record 1.3m apply for 2027 London marathon ballot

A record number of people have applied to participate in the 2027 London Marathon via the public ballot. In total, 1,338,544 people have applied for the event which will take place on 25 April, breaking last year's record of 1,133,813. The 2026 marathon had a record 59,830 finishers and was the biggest annual one-day fundraising event in the world. "This astonishing total of applicants firmly establishes London as the world's most sought-after marathon," said Hugh Brasher, chief executive of London Marathon Events. "Nothing else comes close. Our mission is to inspire people of every age and ability to get active - and these extraordinary numbers show the



massive draw and power of the London Marathon." The ballot results will be released early in July, with places allocated through a random

draw. It is the first time that more than a million applications from the UK alone have been submitted, and there was near parity in male and

female registrations. At last weekend's historic event, Kenya's Sebastian Sawe ran the first sub-two-hour marathon in a competitive

race, and Ethiopia's Tigst Assefa broke her own women's world record. The possibility of holding the 2027 London Marathon across two days - Saturday and Sunday - is still being explored. Brasher previously said the idea would be to hold the elite women's race on one of the days, alongside other women to have gained entry through their previous marathon times - and wheelchair races. The men's equivalents would take place on the other day, with mass races across both days. Speaking to BBC Breakfast on Tuesday, Brasher said he hoped it would be confirmed by the end of May. "This is for one year only. We are engaging, and have been

engaging for a long time, with a lot of stakeholders," he said. "Rightly, they want us to go through a process to ensure what we do is appropriate. People will get disrupted - it's never happened before on a Saturday. "There are lots of plans and mitigations that we've got and we would have to do some unique things. "But I think this shows the desire, the need, for the country. More than £400m of economic and social benefit would happen as a result of the two days, and we believe more than £150m would be raised for charities. "It would be a one-off. We hope to get there - we're not there yet. I'm positive it's the right thing to do."
