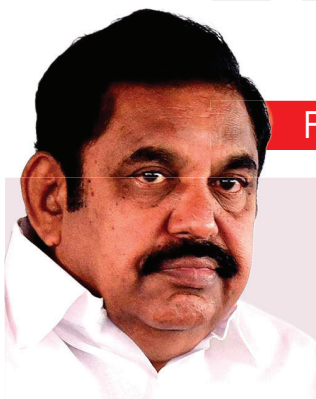

**Iran to hold talks with US if Washington meets 5 conditions**

Tehran: Iran will hold talks with the United States if Washington meets five conditions, the Fars news agency reported, citing a source. The conditions include ending the war on all fronts, particularly in Lebanon, lifting sanctions against Iran, unblocking Iranian assets, compensating for damages, and recognising Iran's sovereignty over the Strait of Hormuz, the report said on Tuesday. Tehran conveyed to Pakistan, the mediator in Iran's dialogue with the US, that the naval blockade has also reinforced the Iranian side's view that the US cannot be trusted. On February 28, the United States and Israel launched strikes on Iranian territory. Iran responded by striking Israeli territory and US military facilities in the Middle East. The US and Israel claimed their "preemptive" attack was necessary to counter the perceived threat coming from Iran's nuclear programme, but they soon made it clear that they wanted to see a change of power in Iran.

**Vijay wins floor test non-chalantly**

Chennai: Tamil Nadu Chief Minister C Joseph Vijay heading the TVK government in Tamil Nadu on Wednesday proved his majority in the 234-member Legislative Assembly, winning the confidence vote non-chalantly with the backing of the supporting parties and the members of the Rebel AIADMK camp, after the 59-member principal Opposition DMK staged a walk out, while the four-member PMK, an ally of AIADMK, and BJP abstained from voting. After a debate on the motion moved by Vijay reposing confidence in his government and floor leaders of various parties spoke on it, the motion was put to vote. Though there are two options, Speaker JCD Prabhakar chose the option of counting of those supporting the government, instead of voice vote. In the head count, of the total 171 members present in the 232-member House (Vijay resigned one seat, and Madras HC restrained one TVK MLA from taking part in trust vote), Vijay with the support of 144 members, including from the Rebel AIADMK MLAs, comfortably won the floor test.

## Centre raises import tariffs on gold and silver; prices rally on MCX

New Delhi (TSIT):

The Centre has raised import tariffs on gold and silver to 15 per cent from 6 per cent as part of efforts to curb overseas purchases of the metals and ease pressure on the country's foreign exchange reserves.

The move comes after Prime Minister Narendra Modi appealed to citizens to avoid buying gold for a year to help conserve foreign



exchange reserves. Global bullion prices are already soaring amid geopolitical uncertainty, volatile crude oil markets, and fears of a prolonged conflict in West Asia. India imports nearly all the gold it consumes, so higher

duties are expected to directly influence domestic gold prices, jewellery rates, and investment demand.

The move may help narrow India's trade deficit and support the rupee, one of Asia's worst-performing currencies. The government has imposed a 10 per cent basic customs duty and a 5 per cent Agriculture Infrastructure and Development Cess (AIDC) on gold and silver imports, taking the effective import tax to 15 per cent from 6 per cent.

## CM Naidu moots 'Work from Home' in administration



Amaravati (TSIT):

N. Chandrababu Naidu on Wednesday said the "Work from Home" culture is here to stay and announced plans to implement it in the government sector as well. Speaking at the groundbreaking ceremony of the Bollineni Institute of Skill, Education, and Research (BISER) in Nidamaru, the Chief Minister supported the austerity measures suggested by Narendra Modi amid the ongoing West Asia conflict and urged citizens to follow the Prime Minister's eight-point agenda.

Naidu called for reduc-

ing fuel consumption, curbing wasteful expenditure, limiting large vehicle convoys, and avoiding unnecessary foreign travel. He encouraged people to explore domestic tourist destinations instead of travelling abroad and advised citizens to reduce gold purchases.

The Chief Minister said Andhra Pradesh would soon announce its own action plan in line with the Centre's suggestions. He also stressed the importance of green energy and said solar rooftop units should be installed on farms and homes to reduce dependence on foreign

energy sources.

Highlighting development plans, Naidu said BISER would include a medical college and Skill University aimed at training one lakh people. He added that Amaravati would be developed as a futuristic city while Visakhapatnam would be transformed into a global city. He further announced that the foundation stone for a fighter jet manufacturing facility would be laid in Rayalaseema on May 15 and said regions like Kurnool and Sri City are emerging as major technology and industrial hubs.

## Telangana Youth Congress Protests Over Alleged NEET Paper Leak

Hyderabad (TSIT):

Telangana Youth Congress on Wednesday staged a massive protest at the Ambedkar statue in Himayatnagar, condemning the alleged NEET paper leak and cancellation of the examination. The protesters burnt effigies of Prime Minister Narendra Modi and Union Education Minister Dharmendra Pradhan, demanding their resignation over



what they called the "failure of the Central Government" in conducting national-level entrance examinations.

Telangana Youth Congress president Jakkidi Shiva Charan Reddy attended the protest as the chief guest and addressed the gathering.

Speaking on the occasion, Shiva Charan Reddy alleged that the Modi government had failed in protecting the future of students. He said that nearly 22 lakh candidates had

appeared for NEET with great hopes, but the cancellation of the examination had pushed students and their parents into distress.

He said repeated paper leaks and re-examinations under the present Central Government had exposed serious lapses in the examination system. He demanded a thorough inquiry into the leak, strict action against those responsible, and immediate resignation of the Prime

Minister and the Union Education Minister. He further said students prepare for such examinations for years, and forcing them to appear again within a short time causes severe mental pressure.

Youth Congress leaders Haridhar, Gurram Shyam Charan Reddy, Bommak Ajay, Santosh Goud, Keizer, Shivanth Reddy, Peer Muneer and others participated in the protest.

**NEET paper leak, cancellation proof of structural flaws, says TN CM Vijay**



Chennai (TSIT):

Tamil Nadu Chief Minister C Joseph Vijay on Wednesday said that the NEET exam paper leak and cancellation of the test was proof of structural flaws and demanded that it be abolished and states permitted to fill seats on their own based on Class 12 marks.

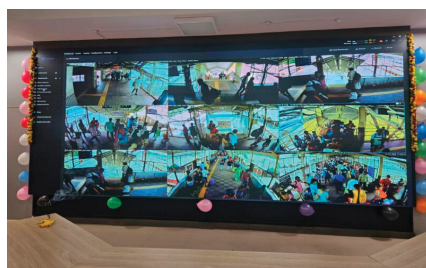
Vijay said the cancellation of the exam following the alleged leak of the question paper has shattered the hopes of lakhs of medical aspirants across the country. In a statement, the CM said the governments of Tamil Nadu has been consistently and unanimously opposing NEET since its very inception. The introduction of NEET has severely disadvantaged the students from rural areas, government schools, Tamil medium backgrounds, and socio-economically disadvantaged families. The CM reiterated the state's long pending demand to abolish NEET and urged the union government to permit the states to fill all seats under the state quota in MBBS, BDS, and AYUSH courses on the basis of Class 12 marks.

## State-of-the-art VSS commissioned at Bengaluru Railway station

Bengaluru (TSIT):

A state-of-the-art Video Surveillance System (VSS) equipped with advanced analytics and facial recognition capabilities has been commissioned at KSR Bengaluru City Railway Station to strengthen passenger safety and railway security infrastructure.

According to a release issued by the South Western Railway on Wednesday, the modern surveillance system became operational on May 13 and provides comprehensive monitoring coverage across the station premises, including entrances and exits, circulating areas, booking offices, reservation halls, concourses, platforms, subways, foot overbridges, waiting halls, and other sensitive locations. As part of the project, 168 IP-based high-definition CCTV cameras compliant with RDSO specifications have been installed to ensure round-the-clock surveillance and reliable monitoring of passenger movement and station activities.



The system has been integrated with an advanced Video Management System (VMS) and Video Analytics (VA) features that enable intelligent monitoring, automatic alerts, and detection of predefined security threats and suspicious activities. Railway authorities said the analytics-based monitoring would help security personnel respond more effectively to incidents. The surveillance network has also been integrated with Facial Recognition Software (FRS) to enhance identification and tracking capabilities. Officials said a database containing 1,086 criminal records has been uploaded into the FRS platform to assist security agencies in identifying suspicious persons.

## PM MODI RECALLS POKHRAN-II TESTS

SAYS INDIA SHOWED WORLD IT 'CANNOT BE BENT'

New Delhi (TSIT):

Prime Minister Narendra Modi on Wednesday invoked the legacy of the 1998 Pokhran-II nuclear tests, saying the operation demonstrated India's "unwavering resolve" and proved to the world that no external pressure could force the country to bow down. In a post on



social media platform X marking the anniversary of the nuclear tests, Modi said, "On this very day in 1998, the nuclear tests conducted by India showed the world how unwavering our nation's resolve is."

## CABINET OKAYS INCREASE IN MSP FOR 14 KHARIF CROPS

New Delhi (TSIT): The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, on Wednesday approved the increase in the Minimum Support Prices (MSP) for 14 kharif crops for Marketing Season 2026-27 to ensure remunerative



prices to farmers. The highest absolute increase in MSP over the previous year has been recommended for sunflower seed at Rs 622 per quintal, followed by cotton (Rs 557 per quintal), nigerseed (Rs 515 per quintal), and sesamum (Rs 500 per quintal), according to an official statement issued on Wednesday. The increase in MSP for kharif crops for Marketing Season 2026-27 is in line with the Union Budget 2018-19 announcement of fixing the MSP at a level of at least 1.5 times of the all-India weighted average cost of production.

## India's MoU with Korean firm for mega greenfield shipyard to generate 15,000 direct jobs

New Delhi, May 13: A tripartite memorandum of understanding (MoU) to develop India's first mega greenfield shipyard at Thoothukudi was signed, envisaging a 2.5 million gross tonnage (GT) capacity and around 15,000 direct jobs, an official statement said on Wednesday.

The statement from the Ministry of Ports, Shipping and Waterways said the MoU was signed between HD Korea Shipbuilding & Offshore Engineering (HD KSOE), National Shipbuilding & Heavy Industries Park, Tamil Nadu (NSHIP-TN), and Sagarmala Finance Corporation Ltd.

The MoU provides a foundation for the joint development, financing, construction and operation of a world-class mega shipyard at Thoothukudi, the statement noted. Around 15,000 direct jobs are estimated to be created upon stabilisation of operations, besides creating



substantial indirect employment opportunities across Tamil Nadu and the surrounding region.

Thoothukudi Greenfield Shipyard is one of the earliest implementation outcomes under the India-ROK maritime cooperation framework and reflects the growing strategic partnership between the two countries in the maritime domain.

Beyond shipbuilding capacity creation, the project is envisaged to catalyse the development of a comprehensive maritime industrial

ecosystem through ancillary and component manufacturing clusters, localisation of marine equipment and engineering supply chains, workforce skilling initiatives, and adoption of advanced manufacturing, digital shipbuilding and green shipping technologies. NSHIP is a Special Purpose Vehicle jointly promoted by V.O. Chidambaram Port Authority (VoCPA), a state-owned port and State Industries Promotion Corporation of Tamil Nadu (SIPCOT) of Tamil Nadu gov-

ernment. Sagarmala Finance Corporation Limited works under the Ministry of Ports, Shipping and Waterways (MoPSW).

The collaboration may also facilitate training of Indian shipbuilding professionals and workers at HD KSOE's facilities in the Republic of Korea. India-ROK Comprehensive Framework 'VOYAGES' (Shared Vision for Operation of Yard Assisted Growth with Efficiency and Scale) for Partnership in Shipbuilding, Shipping and Maritime Logistics was launched following the meeting between Prime Minister Narendra Modi and President Lee Jae Myung during the latter's State Visit to India. The proposed shipyard will serve as the anchor facility of the Thoothukudi Shipbuilding Cluster being developed by NSHIP-TN. The Techno-Economic Feasibility Report (TEFR) for the project has already been completed.

## Karnataka govt withdraws 2022 hijab ban order

Bengaluru: The Siddaramaiah-led Karnataka government has officially withdrawn the 2022 order issued by the previous BJP government that effectively restricted the wearing of hijab in educational institutions. The state government on Wednesday issued a fresh dress code order allowing students to wear traditional and religious symbols, including hijab, along with prescribed school uniforms.

The new uniform policy will apply to students from Class 1 to Class 12 and will come into effect from the current academic year. Under the revised guidelines, students will now be permitted to wear



religious and traditional symbols such as hijab, janivara, rudraksha, shivadhara, turban and other customary attire along with their uniforms, provided they remain complementary to the prescribed dress code. The government stated that the revised order replaces the controversial 2022 directive issued during the tenure of former chief minister Basavaraj

Bommai. The earlier order had sparked nationwide debate after Muslim students wearing hijab were denied entry into classrooms in parts of the state. The hijab controversy first erupted at a government PU college in Udupi, where Hindu students later began wearing saffron shawls in protest, triggering widespread tensions and political debate across the country.

## RBI chief says fuel prices may go up if Iran war continues

New Delhi (TSIT): RBI Governor Sanjay Malhotra said that if the Middle East conflict continues, India may be forced to raise petrol and diesel prices due to the soaring cost of crude oil in the global market. The RBI Governor highlighted that rising energy prices due to the Iran war are testing India's flexible inflation targeting,

necessitating potential policy intervention by the Reserve Bank. The central bank's next monetary policy meeting is slated for June 5, when it will take a call on key interest rates, which it has left untouched to promote economic growth. The Governor indicated that raising retail fuel prices is "a matter of time" if the West Asia crisis persists, which in turn would lead to an increase in transportation costs and inflation. In its April 2026 meeting, the RBI's Monetary Policy Committee unanimously decided to keep the repo rate unchanged at 5.25 per cent, maintaining a neutral stance.

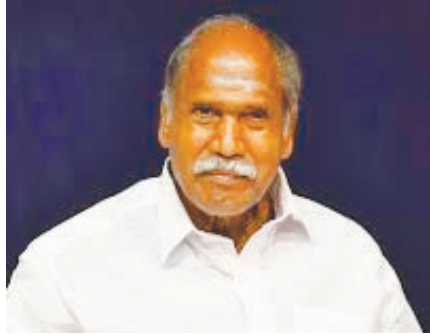


## NDA govt assumes office in Pondy for 2nd term in succession, AINRC Founder N Rangasamy sworn-in as CM

Puducherry : AINRC Founder-President N Rangasamy, heading the NDA in Puducherry, was on Wednesday sworn in as the Chief Minister for the fifth time. Along with Mr Rangasamy, heading the NDA government for a second successive term, two other MLAs, one each from AINRC and BJP, were sworn in as Cabinet Ministers.

Puducherry Lt Governor N Kailashanathan administered the office and secrecy to Mr Rangasamy and the two Ministers at a simple swearing in ceremony held at the Raj Nivas here. The two Ministers are BJP Legislature Party leader and former Home Minister A Namasivayam, elected from the Mannadipet constituency and AINRC MLA Malladi Krishna Rao, elected from Yanam Region of the union Territory.

BJP National President Nitin Nabin,



union Minister and BJP Puducherry Observer Mansukh Mandaviya, BJP election in-charge Nirmal Kumar Surana, leaders of the NDA partners, including the AIADMK and the Lakshya Jananaayaga Katchi (LJK), and senior officials of the territorial administration were among those present in the swear-

ing in ceremony. The new cabinet, which assumed office today, would be expanded in the coming days with the induction of more Ministers.

Of the total 30 seats, the AINRC-led NDA won 18 seats, AINRC alone won 12 seats, the BJP four seats and the AIADMK and LJK one each, while the Opposition Congress-DMK INDIA bloc won six seats, with the DMK bagging five and Congress (one). Of the remaining six seats were won by TVK and it allies and Independents.

In the April 9 elections, Mr Rangasamy won from two seats—his stronghold of Thattanchavady, defeating PCC President and his bete noire V Vaithilingam, also a Lok Sabha MP, who finished a distant fourth, and also from Mangalam constituency. Now having assumed office as the Chief Minister, he

would be resigning one of them, soon.

Mr Rangasamy had served as Chief Minister during his stint with his parent party Congress in the past. In 2008, when he was heading another Congress regime, differences cropped up between him and Vaithilingam leading to his resignation.

The rivalry between the two dated back to their days together in the Congress when Vaithilingam led a rebellion against Rangasamy and succeeded him as Chief Minister in September 2008 for a second time.

However, Rangasamy formed his own party AINRC and became the Chief Minister in 2011, before losing power to the Congress in 2016 only to return back as CM again in 2021 and retained power for second successive term and was sworn-in today.

## TRP RAISES CONCERNS OVER AADHAAR ATTENDANCE SYSTEM

Jogulamba Gadwal TSIT Leaders of the Telangana Rajyadhikara Party expressed serious concern over the implementation of the Face Aadhaar Authentication system under the MGNREGS after a labourer reportedly collapsed and died during attendance authentication in Induvasi Village. A TRP delegation led by District Labour Wing President G. Narsimulu visited several villages in Gattu Mandal and interacted with MGNREGS workers regarding difficulties faced at worksites. According to workers and party leaders, the deceased labourer, identified as Tholu Thimmappa, collapsed while the Face Aadhaar Authentication process was being conducted at the Gangambai Kunta worksite. The incident reportedly occurred under extreme heat conditions.

TRP leaders alleged that the mandatory authentica-

tion system has become a burden on workers and field staff, who are forced to stand in open areas under temperatures exceeding 46 degrees Celsius, often facing network issues while completing attendance procedures twice daily. The leaders also claimed that basic facilities such as drinking water, shade, and first aid were inadequate at worksites, increasing hardships for labourers during the ongoing heatwave. Demanding immediate government intervention, the party called for withdrawal of the Face Aadhaar Authentication system under MGNREGS and sought 5 lakh compensation for the deceased worker's family under the labour accident insurance scheme.

Officials, including MPDO Chennayya, APO Swamy, Gram Panchayat staff, technical assistants, and local representatives, were present during the visit and discussions.



## AIADMK chief Palaniswami removes key leaders in major organisational reshuffle

Chennai, May 13 : AIADMK General Secretary Edappadi K. Palaniswami on Wednesday announced a major organisational reshuffle within the party, removing several senior leaders and sitting MLAs from their posts as district secretaries and appointing a new set of office-bearers across Tamil Nadu. The sweeping changes come amid internal turbulence within the party following the recent political developments in Tamil Nadu and are being viewed as an attempt by the AIADMK leadership to strengthen the organisation at the grassroots level and consolidate



control over district units. Among the prominent leaders relieved of their district responsibilities are former Ministers Natham R. Viswanathan from Dindigul East, S.P. Velumani from

Coimbatore Suburban South, C.Ve. Shanmugam from Villupuram, R. Kamaraj from Thiruvarur and C. Vijayabaskar from Pudukkottai North. Other senior functionaries

removed from district secretary posts include P. Thangamani in Namakkal, K.P. Anbalagan in Dharmapuri, B. Benjamin in Tiruvallur Central, Udumalai K. Radhakrishnan in Tiruppur Suburban West and S.T.K. Jakkaiyan in Theni West.

The reshuffle also affected several other district leaders, including Isakki Subbiah, M.C. Sampath, K.C. Veeramani, M.R. Vijayabaskar, K.V. Ramalingam, P. Balakrishna Reddy and A. Arunmozhiidevan, along with a number of other office-bearers across the state.

## Farmers Allege Delays, Irregularities in Procurement



Hyderabad (TSIT) Farmers Allege Delays, Irregularities in Procurement Leaders of the Telangana Rajyadhikara Party visited the agricultural market yard in Jogulamba Gadwal and interacted with farmers facing difficulties in maize and paddy procurement. Farmers complained of severe delays in procurement,

shortage of transport lorries and hamalis, and alleged negligence by officials, forcing them to remain in the market yard for nearly 15 to 20 days.

They said that after spending months cultivating crops amid irrigation shortages, rising input costs, fake seed issues, and debts, they were still not receiving proper prices for their

produce. Party leaders alleged irregularities in maize procurement, claiming that traders and officials were deducting up to 2.6 kilograms per quintal instead of the permitted 1.3 kilograms, causing financial losses to farmers. Similar complaints were raised in paddy procurement over excessive deductions in the name of moisture content.

The leaders warned that unseasonal rains could damage the crops lying in the open market yard and demanded immediate completion of procurement and shifting of produce to warehouses. The delegation included district president Morugu Veeresh, working president Uppari Gangadhar Sagar Sindanur, farmers' wing district president R. Tippa Reddy, and other party leaders.

## Law Must Remain Supreme: Immediate and Impartial Action Needed in Bhageerath Case

The recent allegations and criminal case registered against Bandi Sai Bhageerath under serious provisions of the POCSO Act have triggered widespread public concern across Telangana and beyond. Whenever allegations involving crimes against women or minors emerge, society expects one thing above all else — swift, impartial, and transparent justice without political influence or selective treatment.

In a democratic nation governed by the Constitution and the rule of law, no individual can be considered above legal scrutiny, regardless of political background, family status, or influence. The law must function equally for all citizens. If the police have



found sufficient grounds to register a serious case under the POCSO Act, then the investigation must proceed fearlessly, professionally, and without delay.

The demand from civil society, journalists, women's organizations, and legal observers is not based on political rivalry but on the principle that justice must not only be done, but must also be seen to be done. In

cases involving sensitive allegations, any delay in investigation or action naturally raises public suspicion and damages confidence in the system. At the same time, it is equally important to remember that every accused person has the constitutional right to defend themselves before the court of law. The final verdict belongs only to the judiciary. However, legal accountability and proper investigation can-

not be weakened or avoided due to political stature or pressure. As a journalist who has consistently spoken for democratic accountability and ethical governance, I strongly believe that the authorities must ensure complete transparency in this matter. If evidence and investigation justify custodial action, then law enforcement agencies should proceed strictly according to legal procedure without hesitation.

India's democracy derives its strength from public trust in institutions. That trust survives only when justice is applied uniformly — whether the accused is ordinary or influential. Selective silence or selective action weakens democracy and encourages public cynicism. This case must therefore become an example of constitutional fairness, institutional courage, and equality before law. The people of Telangana are closely watching how the system responds. Justice, accountability, and truth must prevail above politics.

## CARE Hospitals Restores Breathing of 60-Year-Old Patient

Hyderabad, 13th May, 2026: A 60-year-old patient who had been struggling to breathe and unable to speak comfortably for several months following spinal surgery regained his voice and normal breathing after undergoing a highly specialised minimally invasive airway intervention at CARE Hospitals, Hitech City.

The patient, a Hyderabad resident, had earlier undergone spinal surgery following an accident, after which a tracheostomy procedure was performed to support breathing during recovery. The trachea, commonly known as the windpipe, is the main airway that carries air to the lungs. However, repeated attempts to remove the tracheostomy tube over the following weeks were unsuccessful, leaving the patient dependent on assisted airway support and significantly affecting his ability to speak and breathe normally.

Following repeated unsuccessful attempts to remove the tracheostomy tube and



persistent breathing difficulty, the patient was referred to the Pulmonology team at CARE Hospitals, Hitech City for further evaluation. A detailed bronchoscopy examination revealed severe tracheal stenosis, a critical narrowing of the windpipe, with nearly 90% airway blockage, a potentially life-threatening condition that can occasionally develop in patients requiring prolonged airway support or ventilation.

Following stabilisation, the multidisciplinary team comprising Dr. Sathish C Reddy, Senior Consultant -

Clinical & Interventional Pulmonologist, and Dr. M Abdul Amjad Khan, Consultant ENT, Head & Neck Surgery, performed a complex rigid bronchoscopy procedure using advanced electro-cautery knife techniques and CRE balloon dilatation to carefully reopen the critically narrowed airway. To prevent recurrence and maintain long-term airway patency, a silicone stent was subsequently deployed.

The advanced minimally invasive procedure helped avoid major open airway surgery and resulted in immediate improvement in

the patient's breathing. Soon after the intervention, the patient was able to speak comfortably again and breathe normally without distress, significantly improving his overall quality of life.

Speaking about the case, Dr. Sathish C Reddy, Senior Consultant - Clinical & Interventional Pulmonologist, said, "Tracheal stenosis is a serious but often under-recognised complication in patients requiring prolonged airway support. In this patient, the airway had narrowed almost completely, severely affecting both breathing and speech. In severe tracheal stenosis, even a small delay can turn into a breathing emergency. Using advanced interventional pulmonology techniques, we were able to restore the airway through a minimally invasive approach without the need for major open surgery. Early diagnosis and timely bronchoscopic intervention can make a life-changing difference for such patients."

# AP to soon move towards fully data-driven governance

Amaravati, May 13 : Andhra Pradesh would soon move towards fully data-driven governance, Chief Minister N. Chandrababu Naidu said on Wednesday.

During a review meeting of the Planning department held at the Secretariat, he said that the state would soon move towards fully data-driven governance, with an emphasis on real-time monitoring instead of relying solely on traditional methods for estimating the Gross State Domestic Product (GSDP).

He directed officials to strengthen institutional capacity to build a more robust state economy, stating that achieving 15 per cent growth is essential to realise the goals of Swarna Andhra-2047.

The Chief Minister emphasised the need for faster and more accurate data collection and instructed officials to

provide three months of



structured training to staff from the state level down to the mandal level.

The review focused on several key areas, including GSDP capacity building, AI-based economic analysis, major surveys to be conducted across the state, training for district and mandal-level officials, and integration of KPI auditing mechanisms and AI-based economic analysis.

The Chief Minister observed that current

GSDP estimates are prepared quarterly and annually, which limits the government's ability to gain timely insights into economic conditions. He noted that excessive dependence on historical data often delays policy decisions and stressed the need for a system capable of tracking economic growth every month, across every district and mandal in the state.

To support this transformation, the Chief Minister instructed officials to train government staff in understanding GSDP methodologies and generating faster, data-backed estimates. He proposed a three-month capacity-building programme covering all the districts.

The Chief Minister also directed that three officials from each Assembly constituency receive specialised training.

# Aqua feed price hike affecting AP farmers badly: YSRCP

Nellore, May 13 (UNI) The Opposition YSRCP today slammed the Naidu-headed state government for allegedly colluding with aqua feed companies and pushing the farmers to further distress by drastically increasing the prices.

Speaking to media here, former Minister Kakani Govardhan Reddy said most of the aqua feed companies are associated with TDP and prices have increased manifold by which farmers are badly affected.

The price of aqua feed has risen from Rs 8,000 to Rs 10,000 per tonne as the farmers are pushed into further hardships with the anti-farmer decisions of Chandrababu Naidu.

"The contrast is that while the aqua feed price is rising on hand the prices of shrimp are falling down and farmers are bearing the



brunt on both counts. The 100-count shrimp price fell from Rs 270 to Rs 255 in one month adding up to the woes of farmers," he lamented.

The former Minister slammed the feed companies over hiking the prices unilaterally, claiming that they are confident that the government will not intervene and the kickback

is not being passed on to the farmers," he said, adding that instead of reducing the hiked prices, the companies are having the support of the TDP leaders and aqua kickbacks are routed directly to TDP leaders. The alleged nexus is exploiting the farmers to the hilt.

Ever since the Naidu-

headed coalition government assumed office, farmers have been neglected as CM Chandrababu Naidu has always pursued anti-farmer policies. The hike in aqua feed price is hitting the farmers hard and the coalition is answerable to this ill-conceived decision, he stated.

EDITORIAL

The Beijing Visit: Why Does Trump Suddenly Need Xi Jinping?

The results of US President Donald Trump's visit to China will be carefully watched and analysed in many capitals. It is unlikely that it will produce major or durable results, although both sides would have done advance work to ensure that some positive outcomes can be announced. With his impetuosity and erratic policies, and his disruption of the global system, Trump has seriously eroded trust in the US and damaged its standing in the world. The US is no longer seen as a reliable partner by allies and friends.

Who Trump Is

A transactional approach to foreign relations does not build mutual confidence, as deal-making is based on a short-term perspective, not longer term strategic investment. Trump has shown that the deals he has made can be disavowed by him. Besides, in deal-making, he wants to emerge as the unqualified winner, which means he wants one-sided deals. Trump transgresses US constitutional checks and balances and defies domestic laws to get his way. It is this mindset that is behind his disregard of international law. His kidnapping of the serving head of state of Venezuela, his war on Iran, his blockade of Cuba and open threats to change the regime there show that his foreign policy is based on raw power, discarding even a diplomatic veneer of values or principles.

What Trump Can Do

While, as his wont, Trump is rhetorical about his personal ties with President Xi, lavishes praise on the Chinese leader - which is part of his patronising style and is intended to boost his own persona - the hard-nosed, un sentimental, coldly calculating, self-focused Chinese will hardly be duped by such talk. More to the point, the US is explicit in viewing China as a technology rival, with focus now on the AI domain. It intends to develop over time domestic production in the area of critical technologies and raw materials that China today virtually monopolises, and progressively reduce its dependence on China. The US has accused China of many sins, including supporting Russia and Iran militarily. It has threatened China with sanctions, to which the Chinese react sharply. If the US has denied advanced technology to China, especially its most advanced chips, the Chinese have retaliated with limiting US access to dual-use critical minerals, such as graphite items used in EV batteries, and, in principle, not permitting the export of gallium, germanium, antimony and super hard materials that have widespread military applications and are used in semiconductors.

SNAKES AND LADDERS:

How NEET Has Now Become A Trauma Machine For 22 Lakh Students

The journey of a NEET (National Eligibility cum Entrance Test) aspirant in the post-2024 era is no longer a conventional academic challenge. It has evolved into a prolonged psychological endurance test where uncertainty, institutional mistrust, and emotional exhaustion have become inseparable from preparation itself. For the student who began preparing in mid-2024 for the 2026 examination cycle, the experience did not begin with ambition alone. It began under the dark shadow of investigations, paper leak allegations, grace-mark controversies, and a national debate over the credibility of the examination system itself. For nearly 22 lakh students and their families, the NEET ecosystem transformed from a merit-based competition into an emotionally volatile environment where the rules themselves appeared unstable. From a psychological perspective, this is not merely academic stress. It is systemic trauma generated by repeated exposure to uncertainty, perceived injustice, and the fear that effort may no longer guarantee outcome.

I. Psychological Arc: The Snakes and Ladders of Despair

To truly understand the mental landscape of a NEET aspirant, one must imagine the preparation process as a giant board of Snakes and Ladders. In earlier years, students believed that discipline, consistency, and intelligence would eventually help them climb the ladders toward success. In the post-2024 atmosphere, however, the board itself appears distorted. The ladders are fragile, while the snakes are institutional and unpredictable.



1. The Starting Point (June 2024)

Unlike previous batches, the 2024-2026 cohort entered preparation carrying the psychological baggage of the previous controversy. The widely discussed issue of 67 toppers securing a perfect 720 score, followed by allegations involving grace marks and paper leaks, deeply altered the emotional starting point of aspirants.

This created what psychologists describe as Moral Injury, a condition in which individuals feel betrayed by systems that are expected to uphold fairness and ethics. Instead of studying with optimism, many students developed a defensive mindset. Their motivation subtly shifted from "I will succeed through hard work" to "I must outperform corruption itself". This distinction is critical. One mindset builds confidence; the other builds anxiety.

The first major "snake" in the game emerged here: the frightening real-

isation that effort and outcome may no longer have a reliable relationship.

2. The Monastic Grind (2025)

The next 18 months resembled a form of controlled social isolation. Students entered what can only be described as a monastic existence. Social outings disappeared. Friendships weakened. Festivals became distractions.

Hobbies were abandoned. Entire households reorganised themselves around study schedules, coaching classes, mock tests, and rank predictors. This phase generated a condition similar to Sensory Deprivation, where life narrows into a single repetitive objective.

Mock tests became the ladders that offered temporary emotional relief. Yet even these ladders became unstable because of score inflation trends following the 2024 controversy. A score of 600/720 - once cel-

ebrated as exceptional - began to feel inadequate. Students increasingly perceived anything below 680 as dangerous territory.

The emotional damage extended beyond students.

Parents became what trauma psychology calls 'Secondary Victims'. Their emotional states became directly tied to the child's performance. Every test score influenced household mood, financial planning, and even family relationships. This phenomenon is known as Vicarious Anxiety, where the parent psychologically experiences the child's stress as their own. For many middle-class families investing lakhs into coaching, hostel fees, transportation, and study materials, NEET preparation became the emotional and financial centre of life itself.

3. The Crescendo (May 3, 2026)

Exam day represented the climax

of two years of accumulated pressure. However, unlike earlier generations, the 2026 aspirant entered the examination hall carrying not only academic fear but also historical distrust. This produced a state of Acute Performance Pressure amplified by Historical Trauma. The internal dialogue of many students became painfully paradoxical: "If the paper is easy, cut-offs will become impossible. If it is difficult, I may fail. If another leak occurs, none of this effort will matter anyway." This is psychologically devastating because it creates a no-win cognitive environment. Physiologically, students experienced chronic activation of the sympathetic nervous system. Elevated cortisol levels, shallow breathing, nausea, tremors, headaches, digestive disturbances, and "tunnel vision" became common. The brain, instead of functioning as an adaptive learning organ, entered survival mode.

4. The 10-Day Purgatory (May 3 - May 12)

Traditionally, the post-exam period serves as psychological decompression. Students reconnect with life, sleep normally, and slowly regain emotional balance. For the 2026 cohort, the opposite occurred. The days after the examination became a phase of Hyper-Vigilance. Every news update involving the NTA, the CBI, alleged leaks, or discussions of cancellations triggered anxiety spikes. Students remained trapped in a suspended emotional state where the finish line constantly shifted. Instead of entering the restorative "Rest and Digest" phase, aspirants remained locked in "Fight or Flight" mode, resulting in emotional exhaustion without closure.

THE GREAT GULF DIVORCE:

The UAE Has Broken From The Arab Order - But For What, Really?

Between May 4 and 10, the UAE was struck by drones and missiles, with vital installations, including the Fujairah Oil Industry Zone, being hit. Even though Iran's Revolutionary Guards formally denied these strikes on May 4, they occurred after the US made a fresh naval attempt to open the Strait of Hormuz (Project Freedom). But while the US suspended the operation by May 6 (after the strikes on Fujairah), skirmishes between US naval forces and the IRGC Navy led to the United States bombing Iran's Qeshm Island and Bandar Abbas port on May 7. Iran's retaliation has specifically targeted the UAE along with US naval forces; the Emirati Defense Ministry issued announcements on May 8 that it was "dealing with missile and drone attacks originating from Iran". Iran's special focus on hitting the UAE has long been clear across this war. According to the Wall Street Journal's May 11 report, this had also led to unprecedented Emirati (unacknowledged) strikes on Iran's Lavan refinery on April 8 as the ceasefire began to take shape (which Iran had responded to with reciprocal strikes). Overall, the UAE has faced more drone/missile strikes than Israel - more than, in fact, what other GCC states have suffered combined. Among other aspects, these Iranian strikes represent a major challenge to the UAE's attempt at "strategic breakout" - a categorical break to decades of geopolitical alignment with the Kingdom of Saudi Arabia. This attempt was crystallized on May 1,



when the UAE quit the OPEC after spending 59 years as the second most powerful member of the world's largest oil cartel.

The Saudi Shadow

Since its formation in 1971, the UAE has had to contend between two foreign policy objectives - leveraging its economic might to project power and avoiding misalignment with Saudi Arabia on regional geopolitical choices. This equation was established firmly by Riyadh early, when it made the recognition of the UAE contingent upon the concession of the Buraimi Corridor - which otherwise made the UAE a border state to Qatar - through the 1974 Treaty of Jeddah. For the UAE, this concession was necessary to pre-empt a dangerous rivalry, if not to gain an uneasy and considerably larger ally. Functionally, this meant that the UAE's geopolitical choices would necessarily have to align with Saudi Arabia or keep Riyadh in confidence. This meant that in the decades since, while Iran

has been the UAE's most potent threat, the Emirates has consistently sought to build its bargaining power vis-à-vis both Tehran and Riyadh. Indeed, by 2009, US officials assessed that "while publicly expressing close ties with Riyadh, the UAE privately regarded the Kingdom as its second greatest security threat after Iran". In the subsequent decade, the UAE kept Iran diplomatically and economically engaged, especially at times when Riyadh maintained distance (such as in 2013-14 during negotiations for the US-Iran nuclear deal), and has consistently ranked among Iran's top regional trading partners; the annual UAE-Iran trade reached roughly \$29.2 billion (despite US sanctions) by early 2025. However, ultimately, the Emirati objective was not to seek ideological reconciliation with Tehran but to craft an independent approach to enhancing deterrence against the Islamic Republic, without being held down by Saudi sensitivities. To offset its

lack of geographic and military-industrial depth necessary to achieve this, the UAE's preference has long been to build a robust security relationship with both the United States and Israel. This has led to the UAE categorically aligning itself with Washington militarily, unlike the more partnership-of-equals strategy prioritised by Saudi Arabia, America's oldest Arab ally and a state that prides itself on its civilisational status and strategic depth. For Iran itself, this Emirati strategy has often caused discomfort, but Tehran has historically reciprocated the UAE's modus vivendi by keeping diplomatic and economic channels open.

MBZ Arrives

It is by 2017 that the UAE found fresh space to draw Saudi Arabia closer to the Emirati position vis-à-vis the US and Israel. Becoming de facto ruler of the UAE himself in 2014, Mohammad bin Zayed had already come to share a mentor-mentee relationship with Riyadh's Mohammad bin Salman (MBS), who became Crown Prince in 2017 and is primed to become the first Saudi king from a new generation. MBS's disregard for strict ideological rigor, unlike past Saudi kings, and preference for ruthless modernisation and economic diversification was a natural fit for MBZ, who leveraged his relationship with Washington to help sideline former Saudi Crown Prince Mohammad bin Nayef and personally lobbied for MBS with the incoming first Trump administration in 2016.

POPULIST POLITICS AND RISING DEBT BURDEN ON STATES



The ever-rising debt-to-GDP ratio of Indian states is no longer just an economic indicator, but a serious warning for the country's financial stability and cooperative federalism. Public debt in most states has risen sharply over the past few years. Revenue deficits, populist schemes, weak tax collection systems, and off-budget borrowings have weakened state finances. The Reserve Bank of India and Finance Commissions have also periodically expressed concern about this rising debt trend. If corrective measures are not taken in time, this crisis could impact both the state's growth potential and federal balance in the future. The biggest reason for the rising debt of states is the ever-growing revenue deficit. Many states are unable to meet expenses such as salaries, pensions, interest payments, and subsidies from their regular income. As a result, they are forced to borrow even for normal administrative activities. This situation is considered highly unsustainable from an economic perspective because borrowing is being used for daily expenses rather than productive investment. In states like Punjab, Kerala, and West Bengal, interest payments and pension expenses are continuously increasing, which is limiting resources for developmental projects. Populist politics has also

exacerbated this fiscal crisis. Electoral competition has led to the expansion of free electricity, farm loan waivers, free transportation, cash assistance, and various subsidy schemes. While social welfare schemes are essential to democratic governance, when they exceed fiscal capacity, they undermine fiscal discipline. Most freebies do not enhance long-term economic productivity, reducing future revenue generation potential and increasing the debt burden. The implementation of the Goods and Services Tax regime has also limited the financial autonomy of states. Previously, states had independent revenue sources through value-added tax and other indirect taxes, but now they are largely dependent on central transfers and goods and services tax compensation. Delays in goods and services tax compensation during the COVID-19 pandemic further exacerbated states' financial problems. This increased fiscal differences between the center and states, undermining the spirit of cooperative federalism. A weak tax base is also a significant factor contributing to the economic weakness of states. In many states, property taxes, user fees, and local body taxes are not effectively collected. Weak financial positions of municipalities and panchayats place additional pressure on states. The lack of digital tax administration and data-based monitoring contributes to the problem of tax evasion and revenue loss. Furthermore, off-budget borrowings and hidden liabilities further complicate the true financial situation of states. Many states borrow through public sector

undertakings, power distribution companies, and special purpose vehicles, which are not fully reflected in the official budget. This makes it difficult to accurately assess the actual debt situation. The Reserve Bank of India has repeatedly warned that such hidden liabilities could lead to a major financial crisis in the future. Low productivity of capital expenditures is also a major reason for debt growth. If borrowed projects are not completed on time or do not yield the expected economic benefits, they become a financial burden rather than a source of development. In many states, administrative delays, corruption, and poor project management prevent the full benefits of investments from being realized. The growing debt dependence of states is also affecting Indian federalism. When states are financially weak, they demand greater central assistance, special packages, and additional borrowing limits. This reduces their financial autonomy and increases their dependence on the central government. On the other hand, the central government's imposition of borrowing limits and financial conditions creates political controversy. The growing differences between the central government and states on issues such as goods and services tax compensation and central tax transfers are examples of this tension. Regional inequalities are also growing due to this crisis. Economically stronger states are able to mobilize resources relatively well, while weaker states are increasingly trapped in debt. This upsets the balance of development and reinforces inequality with-

in the federal structure. To address this growing debt crisis, states must practice fiscal discipline. Strict adherence to the goals of the Fiscal Responsibility and Budget Management Act is essential. Borrowing should be used primarily for capital expenditures and productive investments, not for daily expenses. States must strengthen their tax base. Increasing Goods and Services Tax compliance, implementing property tax reforms, and promoting digital tax administration can increase states' own revenues. Rationalization of unnecessary subsidies and populist schemes is also essential. Governments should increase investment in sectors such as education, health, infrastructure, and skill development, as these promote long-term economic growth and revenue growth. Furthermore, off-budget borrowings and government guarantees should be included in the budget with complete transparency to clarify the true fiscal situation. Structural reforms in loss-making public sector undertakings and power distribution companies are also the need of the hour. Financially empowering local bodies can reduce the burden on states. Decentralization will also be strengthened by providing municipalities and panchayats with greater financial powers and resources. In a vast and diverse country like India, the financial strength of states is the cornerstone of national development. Therefore, striking a balance between fiscal discipline and social welfare is the need of the hour. Simply borrowing and running free schemes is not a long-term solution.

**UAE:** Prime Minister Narendra Modi's upcoming visit to the United Arab Emirates on May 15 will focus heavily on strengthening India's energy security amid escalating tensions in West Asia, government sources said. The stopover in Abu Dhabi was added to the Prime Minister's wider Europe tour at a later stage as concerns grow over disruptions to global oil and gas supply routes. According to the sources, Modi's talks with UAE President Sheikh Mohamed bin Zayed Al Nahyan are expected to centre on securing long-term crude oil, LNG and LPG supplies for India, while also exploring alternative export routes that bypass the strategically sensitive Strait of Hormuz. A key area of discussion is likely to be deeper cooperation around the Fujairah Petroleum Industries Zone on the Gulf of Oman. India is exploring the possibility of increasing oil and LPG shipments from Fujairah, which offers a safer route outside



the Strait of Hormuz. The sources also said that both countries may also discuss expanding the Fujairah oil terminal and enhancing pipeline connectivity from Abu Dhabi's Habshan fields. The visit comes days after the UAE accused Iran-backed forces of targeting Fujairah's oil infrastructure with drones and missiles. PM Modi had strongly condemned the attack and stressed the importance of safe navigation through the Strait of Hormuz for global

energy stability. Energy cooperation remains central to India-UAE ties. The UAE currently supplies nearly 40 per cent of India's LPG requirements and is among India's top crude oil and LNG suppliers. Both countries are also expected to review cooperation on India's strategic petroleum reserves, where ADNOC already stores crude oil at the Mangaluru facility. Besides energy, discussions are expected to cover trade, investment and the welfare

of nearly 4.5 million Indians living in the UAE, sources added. The Prime Minister, Shri Narendra Modi shared an article by Union Minister Shri Ravneet Singh Bittu, on how modern railway stations and an improved network are opening new paths to progress in Punjab. Shri Modi remarked that this transformation is bringing a wealth of opportunities for the people.

**Shri Modi posted on X:** "In Punjab, modern railway

## Job Search Platform To Axe 5% Of Workforce, Says Report

**Mumbai:** Job search platform LinkedIn is planning to announce cut 5% of its workforce news agency Reuters reported as saying on Wednesday. The announcement will likely be made later in the day, the report said, adding that the layoffs come as the microsoft-owned company reorganises teams and concentrates staff on areas where its business is growing. The potential layoffs come in the backdrop of a rising year-over-year revenue. According to Microsoft's securities filings, the revenue has risen 12% in the latest ended quarter. The report underscored that an AI takeover of jobs is not the rationale for the job cuts. Currently, LinkedIn has over 17,500 full-time employees globally, according to its website. With over 1.3 billion members, it is the world's largest professional networking



platform. Before its acquisition by Microsoft, the company publicly listed on the New York Stock exchange, following an initial public offer (IPO) in 2011. Later, in 2026, Microsoft acquired the LinkedIn for \$26.2 billion. As of 10:30 a.m. EST, microsoft's stock ticked 1.15% lower to trade at \$403.02. 2026: The Year Of Layoffs? The tech industry saw the highest layoffs in two years in March 2026. Over 46,500 employees were let go, according to data compiled by Layoffs.fyi. Up to 1,03,571

tech employees were dismissed from 131 tech companies so far in 2026, as per the website on May 13. April and May saw comparatively lesser job axing, with the total number of dismissals standing at over 11,000 and over 9,000 (so far), respectively. Oracle had a considerable lead in the volume of employees that it laid off across the globe in March, with up to 30,000 employees fired. The official reason it gave was that they were part of a "broader organizational change".

# TRUMP ARRIVES IN CHINA FOR HIGH-STAKES MEETING WITH XI JINPING

**Washington:** US President Donald Trump descended the steps of Air Force One in Beijing on Wednesday evening, greeted with pomp and pageantry ahead of a high-stakes meeting with his Chinese counterpart, Xi Jinping. During his two-day visit, the global superpowers are expected to discuss tariffs, competition over tech, the Iran war and the US's relationship with Taiwan. Trump returns to a more assertive China since his last visit in 2017, as he faces growing scrutiny of his military campaign in the Middle East. Trump was originally scheduled to make the trip in March, but it was delayed because of the US and Israel's war in Iran, which continues to roil the global economy. When Trump exited the plane on Wednesday evening, he was greeted by Chinese Vice-President Han Zheng, one of China's top



leaders. The move is being read as a show of respect for the US president from Beijing, after a lower-level leader received Trump on his last visit. Also spotted at the welcome - as a red carpet

was unravelled across the tarmac - was Trump's son Eric Trump, and a slew of US tech industry titans, with Tesla's Elon Musk and Nvidia's Jensen Huang among them. "I will be asking

President Xi, a Leader of extraordinary distinction, to 'open up' China so that these brilliant people can work their magic, and help bring the People's Republic to an even higher level,"

Trump said in a post on social media ahead of his landing. Trump said that will be his "very first request" when he meets the Chinese leader. The war in Iran is expected to dominate

the agenda as Trump meets Xi Jinping. China relies a considerable amount on Iran for oil exports, which have effectively been cut off as ships are unable to navigate the Strait of Hormuz. The country also faces growing pressure from the US to use its economic and political influence over Iran. China and Iran have an alliance dating back decades, and Beijing is Tehran's biggest trading partner. The meeting will also be marked by tensions over Taiwan in the backdrop. The Trump administration has taken a mixed approach with Taipei, approving a massive arms deal while downplaying its willingness to defend the island from Chinese aggression. As for trade, Trump is expected to push to increase Chinese purchase of US agricultural products, while Beijing looks to pressure the US to reduce its tariffs on Chinese goods.

## Woman isolating on British island in South Pacific after hantavirus contact

**London:** A woman is isolating on the Pitcairn Islands, a remote British Overseas Territory in the South Pacific, after travelling on a hantavirus-hit cruise ship. A local government spokesperson told the BBC the person "had contact with a hantavirus-exposed individual" but was "showing no signs of illness". The UK foreign office said it was "aware of an individual from the MV Hondius who has travelled on to the Pitcairn Islands". Officials said she was not a suspected case and the risk to the public was low. The woman had flown from San Francisco on 7 May and travelled through

the island of Tahiti and then Mangareva in French Polynesia, the French Polynesian government said. No details have been released about when and where she left the cruise and travelled to the US. Three people have died after travelling on the Dutch-flagged MV Hondius ship. Two of them were confirmed virus cases. The third had earlier developed symptoms and is believed to have been the first infected in the outbreak, but died before he could be tested. The World Health Organization (WHO), the UN global health agency, has since confirmed nine cases, with two others suspected.

## More than 1,000 passengers held on cruise after gastrointestinal illness outbreak

**Washington:** More than 1,000 passengers are being held on a UK-operated cruise ship in France after 49 people fell ill from gastrointestinal sickness. Local health authorities in Bordeaux said three passengers had been isolated in their cabins on the Ambition, while other passengers will not be able to disembark in the port. They added that there was "no reason" to link the outbreak to the hantavirus outbreak on a separate cruise ship. The Essex-based Ambassador Cruise Line told the BBC a 92-year-old man had passed away on board on Sunday, but he did not report any related symptoms and his cause of death is yet to be established by a coroner. The cruise operator added: "We are providing every support to the deceased's friends and family and extend our most sincere condolences to them at this difficult time." Ambassador Cruise Line said in a separate statement that as of 11:00 BST on Wednesday, 48 passengers were displaying symptoms consistent with gastrointestinal illness, as well as one crew member. The cruise ship set sail from Belfast on 8 May, before heading to

Liverpool the next day. There are currently 1,187 guests and 514 crew members onboard the ship, according to its operator. In its statement, Ambassador said there was a reported increase in cases after guests boarded in Liverpool. It said "a number of guests and crew onboard Ambition have displayed or are displaying symptoms consistent with gastrointestinal illness". Gastrointestinal illness is a common condition that causes diarrhoea and vomiting. Cases in adults are usually caused by norovirus or food poisoning. David Munster from Dundonald in County Down is on the cruise with his wife. He said that after departing Liverpool they were informed that a number of passengers had "become ill". Munster said: "At this stage we don't know if we will be kept on the ship and just have to sit here until this is dealt with, or whether we'll be allowed to get off and see Bordeaux, which is obviously what we'd love to do." He said passengers were free to use the facilities that were open, but the people who were ill were isolating in their cabins.

## PHILIPPINE SENATE IN LOCKDOWN AFTER GUNSHOTS FIRED

**Philippines:** The Philippine Senate was locked down with military personnel seen entering the building where a senator wanted by the International Criminal Court (ICC) had sought refuge. Rounds of gunfire were heard but officials have not revealed who fired the shots. They said there were no casualties. Senator Ronald Dela Rosa said earlier

he believed his arrest was imminent and urged Filipinos to prevent it. He is safe and with security personnel, officials said. He is accused by the ICC of killing dozens of people when he was police chief during former president Rodrigo Duterte's war on drugs, in which thousands of alleged dealers were shot and killed. Duterte has been held at The Hague since March 2025.

## Court overturns Alex Murdaugh's murder convictions and orders new trial

**Washington:** A South Carolina court has overturned the 2023 murder convictions of Alex Murdaugh, a disgraced lawyer who was convicted of killing his wife and son. The state's supreme court on Wednesday ordered a new trial for Murdaugh over the June 2021 killings. Murdaugh has been in prison serving two life sentences for the murders of Maggie and Paul Murdaugh. He is also serving two additional 27- and 40-year sentences for state and federal financial crimes. Once a powerful lawyer, the 56-year-old and his legal troubles captivated a global audience and inspired documentaries, podcasts and book deals. The trial itself was also televised. In a 5-0 ruling, the South Carolina Supreme Court said Murdaugh deserved a new



trial because the local county clerk had unfairly biased a jury against him. "Both the State and Murdaugh's defense skillfully presented their cases to the jury as the trial court deftly presided over this complicated and high-profile matter," the justices wrote. "However, their efforts were in vain because Colleton County Clerk of Court Rebecca Hill placed her fingers on the scales of justice,

thereby denying Murdaugh his right to a fair trial by an impartial jury." Last December, Hill pleaded guilty to charges of misconduct in office, obstruction of justice and perjury over accusations that she misused public funds as a clerk and shared sealed court information with a reporter, among other claims. Wednesday's ruling cites a number of comments that Hill allegedly made to jurors dur-

ing the trial. One juror wrote in an affidavit that Hill made comments telling jurors to "watch [Murdaugh] closely", which she said influenced her decision to find Murdaugh guilty because she thought the clerk was implying he was. A jury found Murdaugh guilty of the murder of his wife and son - who were shot at close range near the family's dog kennels - after an extensive six-week long trial. Murdaugh was sentenced to life in prison. In their bid to overturn his conviction, Murdaugh's lawyers had argued that Hill tampered with the jury, telling them not to trust his testimony and to speed up the verdict. In the ruling, the justices cite testimony from jurors who say Hill told them "not to be fooled" by the evidence presented by the defence team.

## Israeli strikes on cars in southern Lebanon kill 12, health ministry says

**Tehran:** At least 12 people have been killed in seven separate Israeli air strikes on cars south of Beirut, Lebanon's health ministry says, as the war between Israel and the Lebanese armed group Hezbollah continues despite a ceasefire. Eight people, including two children, died when drones targeted three vehicles on the coastal highway in the Barja, Jiyeh and Saadiyat areas, around 20km (12 miles) from the capital, according to the ministry. The others were killed in strikes on four cars further south, in the city of Sidon and the towns of Maaliyeh, Chaaitiyeh and Naqoura. The Israeli military has not yet commented. But it



did say Israeli forces struck Hezbollah infrastructure in several southern areas. Hezbollah fighters also launched a number of drones that exploded near an area where Israeli troops were operating in southern Lebanon, it added, without reporting any casualties. On Tuesday, two

paramedics from the state-run Civil Defence emergency service were among 13 people killed in strikes in southern Lebanon, according to the Lebanese health ministry. It says more than 400 people have been killed across the country since the ceasefire was announced by US President

Donald Trump almost a month ago. Israel has intensified its air and artillery strikes in recent days, particularly in southern Lebanon, saying it is targeting Hezbollah fighters and infrastructure. Hezbollah has carried out drone, rocket and mortar attacks on Israeli troops occupying parts of southern Lebanon and on communities in northern Israel. On Thursday, Israeli and Lebanese officials are expected to hold a third round of direct talks in Washington to try to find a way to stop the fighting. In a letter released on Tuesday, Hezbollah's leader Naim Qassem dismissed those efforts and said his group would "not abandon the battlefield".

## Russian drone attacks kill 13 in Ukraine after ceasefire expires

**Moscow:** Thirteen people have been killed and at least 41 injured in a slew of Russian drone and bomb attacks across Ukraine between Tuesday and Wednesday, officials have said. The worst-hit was the central Dnipropetrovsk region, where eight people were killed and 11 injured throughout Tuesday. One casualty was reported in the eastern Donetsk region the same day. Russian attacks continued on Wednesday, with three people reported killed in the western Rivne region and one person in Zaporizhzhia, in the south. President Volodymyr Zelensky said 800 drones had been launched by Russia throughout the day and warned that missile launches could follow. In Russia, officials said Ukrainian drones hit three industrial facilities overnight. No casualties were reported. The latest attacks come shortly after a three-day US-brokered ceasefire expired late on Monday. Both Russia and Ukraine reported multiple violations - mostly along the vast frontline - during the truce, but no major aerial attacks. Russian President Vladimir Putin launched a

full-scale invasion of Ukraine in February 2022. In a post on Telegram on Wednesday morning, Dnipropetrovsk regional head Oleksandr Hanzha reported more than 30 Russian attacks on three districts throughout Tuesday. He said two people were killed in Zelensky's hometown of Kryvyi Rih, and another six in the Synelnykove district - just south-east of the regional capital Dnipro. "More than two dozen houses were damaged," Hanzha added. In the north-eastern Kharkiv region, five people were reported injured and a number of residential houses damaged. Russian drone strikes were also reported in the southern Odesa, Kherson and Zaporizhzhia regions, as well as in Poltava - Ukraine's central region. Writing on Telegram on Wednesday morning, Zelensky said 14 Ukrainian regions were attacked throughout Tuesday, and there were more attacks overnight. He accused Russia of "purposefully" targeting Ukraine's railway infrastructure and other civilian facilities. Ukraine's air force said Russia launched 139 drones in the past 24 hours.

## Epstein abused me while under house arrest, survivor tells US lawmakers

**Washington:** A survivor of Jeffrey Epstein's abuse has told how the late sex offender sexually abused her while he was under house arrest for soliciting prostitution from a minor. Roza, who was recruited from Uzbekistan as a teenager by Epstein's associate and modelling agent Jean-Luc Brunel, spoke publicly for the first time alongside a number of victims in a field hearing that was organised by House Democrats. She told the session that she was introduced to Epstein by Brunel in July 2009, was offered work by Epstein "to help me with my financial troubles", and he later subjected her to rape over a period of three years.



Democratic lawmaker Robert Garcia said the unofficial hearing was held in West Palm Beach, Florida, because it was where Epstein's "crimes first came to light". The hearing, which Garcia pointed out was also held in close proximity to US President Donald Trump's Mar-a-Lago residence, was held by Democrats from the US House Oversight

Committee and local Democratic members. The committee, which has a Republican majority, is currently investigating the financier's crimes. Democratic members of the committee have focused on scrutinising the Trump administration's handling of the Epstein files. The hearing carries no legal authority, but was planned with the

intention of keeping the Epstein case in the spotlight. Democratic lawmakers heard how Epstein and his accomplices evaded accountability for years, and how victims were repeatedly failed by the justice system. Roza, whose first name was only given in the hearing, said she was 18 when she met the late Brunel in 2008 and "promised a modelling career beyond my dreams". "Coming from a financially unstable background I was a perfect target for coercion," she added, during the tearful testimony. By May 2009, she was in New York City on a visa, and in July she met Epstein at his house in West Palm Beach while he was under house arrest, Roza said.

## Gaza sisters win prize for turning rubble into reusable bricks

**Gaza:** Two teenage sisters from Gaza have won an environmental award for turning rubble into reusable bricks, saying they wanted to "turn destruction into something useful". Farah and Tala Mousa, who live in a tent and have been repeatedly displaced since their home was bombed, have been named the Middle East regional winners of the youth-focused Earth Prize. "After our entire city turned

into rubble, everything around us pushed us to think about a solution," 17-year-old Tala told the BBC. The sisters plan to use their \$12,500 (£9,245) prize to teach others to produce the bricks and "participate in reconstruction themselves, instead of waiting only for outside help." 15-year-old Farah said. The UN estimates 1.9 million people in Gaza - nearly 90% of the population - have been displaced since war began in 2023.

## What Reports And Investigators Revealed About Grizzlies Star's Tragic Passing

**Berlin:** Brandon Clarke is a basketball player with the Memphis Grizzlies in the NBA. Clarke, who was born in Vancouver, Canada, and grew up in Phoenix, Arizona, was drafted 21st overall in the 2019 NBA Draft and quickly established himself with his athleticism, defense, and energy off the bench. He was also selected to the NBA All-Rookie First Team in 2020. However, Clarke died tragically at the age of 29 in May of 2026. The authorities believe he may have died from an overdose, but no cause has been confirmed because a death certificate or a toxicology report is not



yet available. Everyone is in shock at the unexpected death, and many NBA fans, teammates, and professional players have sent condolences to the Athletic department. What do reports and investigators say about Brandon Clarke's death?

Memphis Grizzlies forward Brandon Clarke died on May 11, 2026. No official cause of death has been determined, but the incident is being investigated as a possible drug overdose after drug substances were reportedly found at the scene, according

to multiple sources. In another report, Clarke's death is being probed as a possible overdose. The outlet cited authorities, reporting that the Los Angeles Fire Department responded to a 911 call of a medical emergency shortly after 5 p.m. local time Monday at a residence in the San Fernando Valley. Paramedics found Clarke deceased, and reports say drug paraphernalia was found in the home. By Tuesday, May 12, the medical examiner's website showed Clarke's body was ready to be released, but not the explanation his family, team, and the wider basketball world are still waiting for.

But for every primetime game or international battle, there is now a highly advanced and complex scheduling strategy that involves data from well beyond football. As the league prepares to announce the schedule for the regular season of 2026, the NFL will make heavy use of predictive analytics, looking at everything, including weather and streaming behavior. Given the NFL's increased use of streaming services, its holiday games, and even its games abroad, maximizing TV audiences has been difficult in recent years. This problem, in turn, has driven



the league further into advanced scheduling algorithms in conjunction with its analytics partner Receptive Analytics. How NFL Uses Advanced Analytics To Predict Fan Behaviors Beyond Football Receptive Analytics' founder Andy Tabrizi stated that their algorithms are purposefully more centered on what's happening outside football

rather than the sport itself. "Where we really try to focus all of our efforts is everything that has nothing to do with the NFL," said Tabrizi. "That may sound really strange to say when we're talking about forecasting NFL viewership, but the reason why our model is so accurate is that we've really been able to figure out the NFL as a function of everything else."

The event happened in Vancouver, Canada, where Maya stepped onto the TED stage to talk about how livestreaming helped her create a global community around animal conservation and wildlife education. By the end of the speech, the audience stood up and applauded while

Maya looked visibly overwhelmed before quietly saying, "Thank you." Clips from the moment immediately spread across social media, with fans and fellow creators calling it a huge moment not just for Maya, but for Twitch as a whole. ## RADUCANU TO MAKE RETURN WITH WILDCARD IN STRASBOURG

**London:** British number one Emma Raducanu will make her return to action in Strasbourg after being granted a wildcard, as she seeks match practice before the French Open. Raducanu, 23, withdrew from the Italian Open on health grounds earlier this month and has not competed since a third-round loss to American Amanda Anisimova at Indian Wells on 8 March. The clay-court event in Strasbourg begins on Sunday, one week before the start of the French Open on 24 May. Raducanu is set to miss out on a seeded posi-

tion at the second Grand Slam of the year following the post-viral infection which has kept her away from the tour. The 2021 US Open winner is currently ranked 30th in the world but will drop several places following the conclusion of this week's tournaments in Rome and Paris. Raducanu was granted a wildcard for last year's WTA 500 event in Strasbourg, where she beat top-20 player Daria Kasatkina before losing to American Danielle Collins. The Briton has won seven of her 14 matches this year, with four of those victories coming during her run to

the final of the Transylvania Open in February after her second-round exit at the Australian Open. Raducanu gave no clear indication that she would pull out of the Italian Open in March despite speaking to the media just 30 minutes before that decision was announced, but said she only wanted to return to competition when "100% ready". Taking a wildcard into Strasbourg means the 23-year-old will gain valuable time on the clay ahead of the French Open, which begins on May 24. Raducanu also received a wild card into the tourna-

ment 12 months ago, reaching the second round, and an announcement from the tournament on social media reading: "Welcome back, Emma! The 2021 US Open champion will be back on the clay courts in Strasbourg." It has been another difficult start to a season health-wise for Raducanu, who began 2026 battling to recover from a foot problem. Speaking to reporters in Rome about her illness, the former US Open champion said: "Post-viral, it's quite hard. You feel drained, you feel tired, no energy. It's difficult, and it lingered for quite a while."

## Distributors and Producers Also Have Their Own Challenges... The Industry Survives Only When Cinema Survives: Telugu Film Producers



Telugu film producers stated that not only exhibitors, but distributors and producers are also facing serious challenges in the current theatrical ecosystem. It is known that exhibitors recently held a press meet demanding the implementation of the percentage system, claiming they are under severe financial pressure.

Responding to this issue, Telugu film producers held a press meet on Wednesday evening.

Producers Yalamanchili Ravi Shankar, Suryadevara Naga Vamsi, Sahu Garapati, Sudhakar Cherukuri, Venkata Satish Kilaru and others participated in the media interaction. The producers stated that it was not appropriate for

exhibitors to conduct a one-sided press meet and speak in a threatening manner. They emphasized that all stakeholders should sit together and resolve the issue through discussions. While they are ready to address exhibitors' concerns, they also insisted that the problems faced by distributors and producers must be equally considered.

**Producer Yalamanchili Ravi Shankar said:**

"The main purpose of this press meet is to present the producers' perspective after yesterday's exhibitors' press meet, where they claimed injustice was being done to them. We want to clarify the facts and present the reality from our side."

We agree that exhibitors are facing difficulties. But distributors and producers are also suffering. Please understand that this is not a problem of one section alone. For many years, producers, distributors, and exhibitors have worked together as one system.

Today, none of the three sectors are truly comfortable. We cannot simply think only about our own benefit and move forward. All three sectors must sit together and discuss. These are not issues that can be solved overnight. This issue surfaced during the release of 'Hari Hara Veera Mallu,' and many films have been released since then. Why is this problem suddenly being pushed again now? Why the

urgency only at this moment? This is not the right approach.

For the last four to five months, everyone has been struggling due to the lack of strong theatrical content. At a time when a big film is arriving, creating such situations is not appropriate. We are not denying the issue exists, but all concerns must be discussed together and a solution acceptable to everyone should be reached.

Theatres must be graded because not all theatres offer the same facilities. Single-screen theatres especially need better infrastructure. These issues can only be solved through collective discussions. Let us all move forward together."

**Producer Suryadevara Naga Vamsi said:**

"If one part of the ecosystem suffers, all three suffer. Exhibitors, distributors, and producers are all going through difficulties.

Exhibitors themselves admitted that theatres had to be shut down due to lack of content in recent months. If such conditions and restrictions are imposed now, it will only reduce content further from producers, and that helps no one.

Please do not make unilateral decisions and issue deadlines in a threatening tone. Among the producers present here, there are at least 25 films that have already crossed 50% of shooting completion, with 70-80% of the budgets already spent.

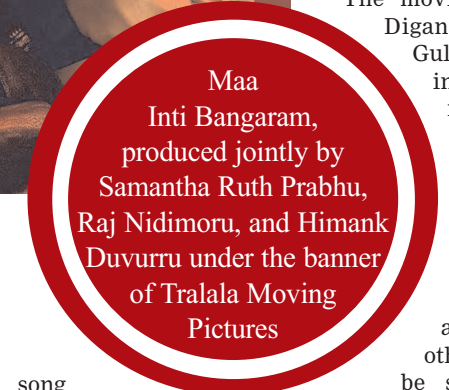
