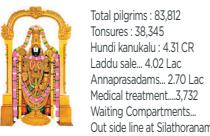

2 soldiers killed in accidental blast near LoC in Uri sector

Srinagar (TSIT): Two Army personnel lost their lives after sustaining critical injuries in an accidental explosion near the Line of Control (LoC) in the Uri sector of Jammu and Kashmir's Baramulla district on Wednesday, officials said.

According to official sources, the incident took place in the Kamalkote area of the Uri sector. The soldiers were critically injured in the explosion and were immediately evacuated to the Army's Base Hospital in the Badamibagh Cantonment area of Srinagar. "They have been identified as Arjun Jadhav and Vikram Balakrishna, both from Maharashtra. Despite the best efforts of doctors, they succumbed to their injuries," officials said. Both soldiers were serving with the 8 Rashtriya Rifles. The exact circumstances leading to the explosion were not immediately known, and further details are awaited. Jammu and Kashmir has a 740-km-long Line of Control running through the districts of Baramulla, Kupwara and Bandipora in Kashmir Valley, and Poonch, Rajouri and parts of Jammu district in the Jammu region. Apart from the LoC, the Union Territory also shares a 240-km-long International Border with Pakistan across the districts of Samba, Jammu and Kathua.

PM Modi urges NDA partners to keep focus on poor, middle class and youth

New Delhi, June 10 : Prime Minister Narendra Modi on Wednesday addressed NDA leaders at a conclave marking the completion of 12 years of his government, delivering a speech that blended reflection on past achievements with a call to action for the future.

Addressing Chief Ministers, alliance partners and senior leaders, PM Modi emphasised the need to safeguard the gains made by millions who have risen from poverty to join the neo-middle class, urging continuous efforts to prevent any reversal of their progress. "I believe that we must not let those who were poor yesterday, and have now become the 'neo-middle class', slip back. Therefore, as a government and as public representatives, we must work day and night," the Prime Minister said.

He stressed that the government has put in its utmost effort, driven by the resolve to fulfil the



expectations of India's 1.4 billion people.

PM Modi called for realising the aspirations of the country's youth, women, middle class and farmers, positioning these groups at the heart of the development agenda. The Prime Minister declared that the dream of a Viksit Bharat no longer belongs to any individual or political party but has become the collective resolve of every Indian.

"For me, people represent God," he added, underscoring his commitment to public service.

ing the Covid-19 pandemic, PM Modi pointed out that the country maintained strong growth while major economies struggled.

He cited India's economy growing at 7.7 per cent in 2025-26 as evidence of the benefits of stable governance.

"This era has repeatedly demonstrated the benefits of having a stable government," he remarked. The Prime Minister highlighted several measures aimed at the middle class, including simplified taxation, the massive expansion of infrastructure, and increased opportunities for employment and entrepreneurship.

These initiatives, he said, have helped create a more predictable and opportunity-rich environment for ordinary citizens.

"For us, if there is anything greater than party, it is our country. When we work with the spirit of 'nation first', no decision is difficult," he affirmed.

Jairam Ramesh accuses Modi of undermining Nehru's legacy as PM surpasses historic tenure milestone

New Delhi (TSIT) A fresh political confrontation erupted on Wednesday as the Congress launched a sharp attack on Prime Minister Narendra Modi on the day he surpassed Jawaharlal Nehru to become India's longest-serving Prime Minister, with senior Congress leader Jairam Ramesh accusing the Prime Minister of attempting to erase Nehru's legacy while presiding over what he termed a "Murder of Democracy" in the country.

In a post on social media platform X, Ramesh highlighted what he described as the transformative achievements of independent India's first five years under Jawaharlal Nehru's leadership and contrasted them with the present political climate under the Modi government.

"Jawaharlal Nehru became Prime Minister of India on August 15, 1947, presiding over a stellar Cabinet — the likes of



which have rarely been seen in the world. Over the next five years, modern India came into being," Ramesh said.

The Congress leader listed a series of milestones achieved between 1947 and 1952, including the peaceful integration of more than 560 princely states into the Indian Union, the framing and adoption of the Constitution, the abolition of the zamindari system, the introduction of reservations for Scheduled Castes and Scheduled Tribes, the launch of major irrigation and power projects, and the establishment of India's scientific and technological infrastructure, including in the field of nuclear energy.

Rahul, Abhishek Banerjee hold meeting

India-UAE partnership deepens economic ties, boosts energy and logistics cooperation

NEW DELHI (TSIT):

India-UAE relationship is driven by economic pragmatism and mutual investment opportunities, allowing both countries to pursue shared economic objectives while retaining flexibility in wider foreign policy ties, a new report has said. The report from Times Kuwait said India and the United Arab Emirates are deepening a sector-focused partnership that prioritises trade, energy security, logistics and technology cooperation.

The partnership has gained momentum through initiatives such as the India-Middle East-Europe Corridor (IMEC) and expanded energy cooperation. In May 2026, New Delhi and Abu Dhabi signed a strategic partnership agreement to deepen col-



laboration in advanced technology, innovation, industrial development, maritime security and information exchange. "The agreement is expected to create new opportunities for collaboration in high-value sectors, support technology transfer and enhance the capabilities of both countries in areas critical to future economic growth," the report forecasted.

Though not structured as

a formal alliance in the traditional sense, the new framework indicates growing interest in creating integrated economic corridors and strengthening commercial linkages across multiple regions.

UAE's Fujairah energy hub is a strategic asset for India due to its unique location, offering petroleum storage outside the Strait of Hormuz and helping diversify India's energy logistics and storage options. "The

arrangement strengthens India's energy security by diversifying storage options and improving supply-chain resilience during periods of market volatility or geopolitical uncertainty," the report said.

The Middle East occupies a key position in India's economic outlook, due to it being a vital source of energy supplies, investment and acting as a trade connectivity hub. The region also hosts a large Indian expatriate community that contributes significantly to bilateral economic ties.

The partnership also complements broader regional frameworks such as I2U2 — India, the UAE, Israel and the United States — which aims to promote cooperation in technology, infrastructure, logistics, food security and investment.

PM Modi becomes India's longest-serving elected PM; surpasses Jawaharlal Nehru

NEW DELHI (TSIT):

Prime Minister Narendra Modi on Wednesday became India's longest-serving Prime Minister, marking 12 years at the helm of the Central government. PM Modi crossed former Prime Minister Jawaharlal Nehru's record with 4,399 days in office as an elected Prime Minister.

Nehru's tenure from 1952 onwards is considered for this comparison, as he headed an interim government between 1947 and 1952 before the country's first general elections were held. While former Prime Minister Indira Gandhi served for more than 14 years in office, her tenure was not continuous, making Modi the longest continuously serving elected Prime Minister in the country's history. He has served from his first swearing-in ceremony in 2014 to securing successive mandates in 2019 and a historic third consecutive term in 2024. The PM Modi-led government's era has also been marked by a series of high-



profile infrastructure and nation-building projects, including the new Parliament building, Central Vista redevelopment, Kartavya Path, Vande Bharat trains, the Statue of Unity, INS Vikrant, the Kashmir rail link, Noida International Airport, Namohar RRTS and the Ganga Expressway. The National Democratic Alliance (NDA) will hold a crucial meeting in the national capital on Wednesday to celebrate the completion of 12 years of the NDA government at the Centre and to mark Prime Minister Narendra Modi becoming India's longest continuously serving elected Prime Minister.

3 Indians missing after attack on ship off Oman coast

NEW DELHI (TSIT):

Three out of 24 Indian crew members on board a commercial vessel that came under attack off the coast of Oman on Wednesday are missing, with India strongly condemning the strike.

In its reaction, New Delhi said the targeting of commercial shipping and civilian infrastructure in West Asia must end, and free and unimpeded navigation through the international waterways should be restored at the earliest. The attack on commercial vessel Settebello came two days after a Palao-flagged vessel with 24 Indians came under attack of the US Navy as the ship tried to evade the US blockade of Iranian ports.

"We condemn the attack on the commercial vessel Settebello off the coast of Oman, earlier today. Of the



24 Indian crew on board, 21 Indians have been rescued thus far and three Indians are reportedly missing," the Ministry of External Affairs (MEA) said. It said the Indian embassy in Oman is closely monitoring the situation and proactively coordinating with the local authorities in the ongoing search and rescue operation.

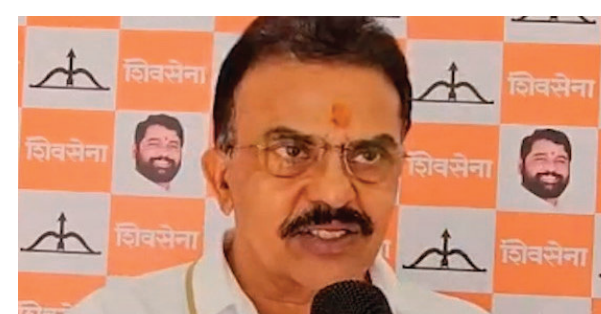
"The continuing incidents of attacks on shipping in the region are deeply worrisome and a direct result of the ongoing conflict in the region," the MEA said.

NDA says INDIA bloc 'shrinking', Congress hits back

New Delhi, June 10 : The National Democratic Alliance (NDA) on Wednesday remarked that the INDIA bloc is "shrinking" given the "internal conflicts" within the opposition parties. However, Congress said that the Opposition alliance is united despite having differences at the state level.

Talking to IANS, Shiv Sena spokesperson Sanjay Nirupam said: "On the one side, the INDIA bloc is continuously shrinking and there are reports of internal differences and conflicts among its leaders. On the other hand, the NDA alliance is continuously expanding and strengthening."

"The reason for this is that leaders of the National Democratic Alliance, led by the Bharatiya Janata



Party, remain actively connected with the people in their respective states and continuously serve the public, because of which the people give their blessings to them," he added. However, Congress MP Manickam Tagore stressed that the "INDIA bloc is united".

"It was formed to fight against the RSS, BJP, and Amit Shah. The alliance achieved significant suc-

cess," he told reporters.

While acknowledging that there are differences among the INDIA bloc allies at the state level, the Congress leader said: "The INDIA bloc, under the leadership of Rahul Gandhi and other senior Opposition leaders, remains united in its fight against the RSS and BJP."

He underlined that while the Aam Aadmi Party has announced its

exit, and the DMK has also made "certain announcements", "The Trinamool Congress remains an important part of the alliance." Tagore added: "Trinamool supremo Mamata Banerjee has been a pillar of strength for the INDIA bloc, so is Samajwadi Party's Akhilesh Yadav. As many as 25 opposition parties are united."

In a veiled reference to the DMK, the Congress MP Tagore said: "Those parties who are left should also recognise that state-level differences can be negotiated for national, larger ambition to fight against the RSS, BJP and Home Minister Amit Shah, because RSS and BJP are destroying each democratic process in India."

CJI Surya Kant steps in after threats to former Bombay HC judge Gautam Patel and family

New Delhi, Jun 10: Chief Justice of India (CJI) Surya Kant has intervened in the matter of alleged threats and intimidation directed at former Bombay High Court judge Justice Gautam Patel and his family, raising the issue with India's High Commissioner to the United Kingdom during his ongoing visit there.

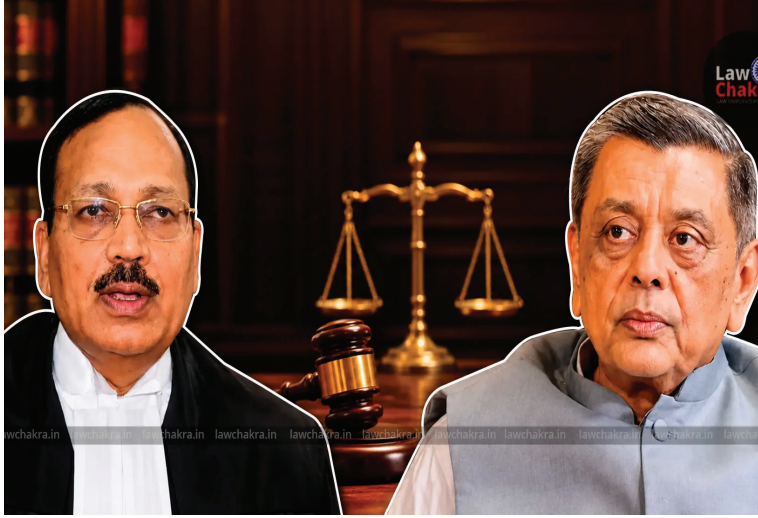
The intervention comes after Justice Patel revealed that a threatening letter had been delivered to his daughter's residence in London, allegedly in connection with a judgment he delivered in 2024 concerning the Dawoodi Bohra succession dispute.

According to reports, CJI Surya Kant discussed the matter with Indian High Commissioner to the UK P Kumaran and was assured that adequate security measures had been put in place.

"I had a discussion with the high commissioner, who assured that no harm would come to him or his family and that the London police have made adequate security arrangements," the CJI was quoted as saying.

Justice Patel said the latest threat letter was linked to his ruling in a case concerning the succession and identity of the Syedna, the spiritual leader of the Dawoodi Bohra community. The matter is currently under appeal.

The retired judge disclosed



that his family had received several anonymous letters over the past 10 months. One communication allegedly accused him of delivering the judgment fraudulently and under pressure.

According to Justice Patel, the letter demanded that he upload a video on YouTube declaring that he had delivered an incorrect verdict that had caused harm to the community. He also alleged that those behind the threats were attempting to exploit jurisdictional boundaries by targeting his daughter in the United Kingdom.

"This is a clever attempt to leverage the jurisdictional gap between Mumbai and London. There has been no attack on me in Mumbai, for that would result in immedi-

ate local action. Instead, the attack is directed against my daughter, a British citizen, on British soil," Justice Patel said.

Reports said the Indian High Commissioner informed the CJI that the threats appeared to have originated in India, as they were linked to litigation arising from Maharashtra.

Following the discussion, CJI Surya Kant said he had contacted the acting Chief Justice of the Bombay High Court and urged appropriate action. "I have sent a message to the acting chief justice of Bombay High Court to take appropriate steps on the judicial and administrative side as the litigation pertained to local parties," he said.

The Chief Justice is expect-

ed to return to India on June 12. Meanwhile, the Bar Association of India strongly condemned the alleged threats and intimidation against Justice Patel and his family, describing them as a serious attack on judicial independence and the rule of law. The association referred to reports of anonymous threats, demands that the former judge publicly retract his verdict, an alleged break-in at a family residence, an assault on his daughter in London and a fresh written threat received on June 5.

"The demand that a judge disown a verdict by video, under coercion, is an attempt to substitute intimidation for adjudication," the association said in a statement.

The body noted that judicial decisions can only be challenged through established legal procedures and pointed out that Justice Patel's 2024 ruling is already under challenge before a division bench of the Bombay High Court.

It also called on authorities in India and the United Kingdom to conduct a thorough investigation and ensure the safety of the former judge's family. In April 2024, Justice Patel upheld the position of Syedna Mufaddal Saifuddin as the 53rd Dai al-Mutlaq of the Dawoodi Bohra community, ruling that his appointment was valid.

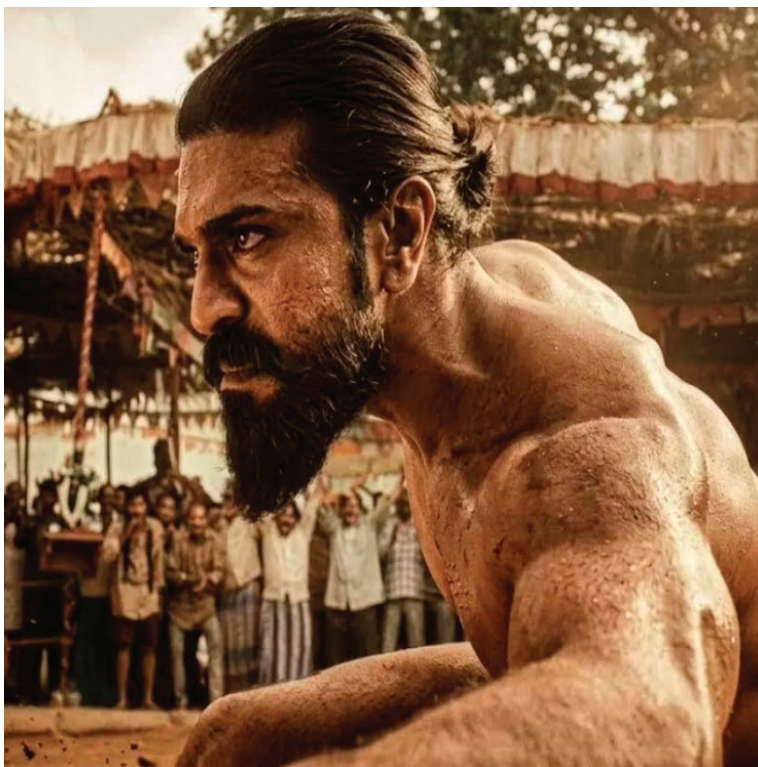
Prof Srinivas Rao concluded, "The media has persistently endeavoured to bring the existence of Telangana to rural areas, slums, student hostels, and univer-

Rare neurological disorder successfully treated at KIMS Hospital, Kurnool

Kurnool, June 10, 2026: Doctors at KIMS Hospitals, Kurnool, have successfully treated a 61-year-old man suffering from a rare neurological condition caused by a cerebrospinal fluid (CSF) leak, helping him recover after a prolonged and critical illness. According to Dr. N. Sumanth Kumar, Senior Consultant Neurosurgeon, the patient, Srinivasulu, a resident of Kurnool, had undergone two surgeries for recurrent blood clots over the surface of the brain. However, his condi-



tion continued to worsen despite treatment. Following a detailed evaluation, doctors identified a tear in the protective covering of the upper spinal cord, which had resulted in continuous leakage of cerebrospinal fluid. The

leak caused an abnormal reduction in intracranial pressure, leading to a rare condition known as cerebral hypotension. Dr. Sumanth Kumar said the condition is difficult to diagnose and treat because of its rarity and the complexity of the underlying pathology. Initially, the medical team attempted to seal the leak through three Epidural Blood Patch procedures. As the patient did not show adequate improvement, doctors proceeded with an open dural tear repair surgery.

Opposition Alleges Rs.39,437 Crore Garbage Scam, Files Lokayukta Complaint

Bengaluru: Just a week after D.K. Shivakumar assumed office as Karnataka Chief Minister, Opposition Leader R. Ashok has alleged a massive scam in Bengaluru's solid waste management contracts, claiming irregularities worth Rs. 39,437 crore.

Ashok filed a formal complaint with the Lokayukta, visiting the office and submitting documents to the Registrar. Speaking to reporters, he said the complaint detailed how the Congress government allegedly violated tender norms, awarding contracts to collect commissions and favour certain contractors. The Lokayukta has reportedly assured immediate action on the matter. The Opposition leader accused Congress leaders at both the Central and state levels of receiving kickbacks. He further alleged that despite recommendations from two com-



mittees, the government proceeded to award a 30-year contract with excessive payments, benefiting specific companies. Ashok condemned the move as a misuse of taxpayers' money and vowed to raise the issue in the Karnataka

Legislative Assembly. He claimed the Karnataka Congress High Command had "turned the state into an ATM," and accused the Chief Minister of hastily approving the contract for the benefit of one firm. "This is the biggest

scam to come to light within just one week of D.K. Shivakumar becoming Chief Minister," Ashok said, promising that the Opposition would fight the matter vigorously to hold those responsible accountable.

Puram to conduct an inquiry and submit an urgent report regarding allegations that the management of the deregistered Samar International Islamic School in Hegde Nagar, Thanisandra, is refusing to issue Transfer Certificates (TCs) to students and is engaging in illegal activities.

The inquiry has been ordered based on a complaint filed by Dr. Khurshi Ashraf Iqbal, a resident of Almas Colony, Bilal Park, Thane, Mumbai, and former Principal of Jamia Mohammadiya Mansoor Madrasa. According to the complaint, following the cancellation of the institution's recognition, the school management has allegedly been



threatening students and parents and refusing to issue Transfer Certificates despite repeated requests. KIADB to Go End-to-End Digital: Minister Sets a 100-day deadline



Bengaluru: The Karnataka Industrial Areas Development Board (KIADB) is set to digitise every stage of its operations, from land acquisition to the allotment of industrial plots. The move is expected to benefit all stakeholders, including farmers and industrial investors. Large and Medium Industries Minister M. B. Patil on Wednesday set a 100-day deadline for completing all work related to the digitisation initiative.

During the second departmental review meeting held at Khanija Bhavan after the formation of the new gov-

ernment, the minister outlined the key tasks to be completed within the next 100 days and issued clear directions to officials.

Speaking after the meeting, Patil said that every detail relating to plots in both old and newly developed industrial areas across the State would be digitised under the Integrated Land Management System developed by the Government's e-Governance Department. He added that as many as 77 data fields would be maintained for each industrial plot.

Details relating to plot allotments, their current status, industries operating on them, investments made, employment generated, compensation paid to affected farmers, court cases, and timelines granted to investors will be available instantly through the digital platform. He explained that the initiative would not only eliminate the challenges associated with preserving old records but also ensure that all information remains securely stored on a permanent basis.

Patil noted that in the past, inadequate record management had led to a few instances where compensation was paid twice for the same parcel of land. The new system, he said, would bring complete transparency and enable investors to access the required information from anywhere, eliminating the need for middlemen.

Karnataka currently has 224 industrial areas, and records relating to thousands of plots in these areas will soon be scanned and securely digitised. The minister said the initiative forms part of the government's broader effort to introduce citizen-friendly reforms in the Industries Department.

Why India Appointed A Non-Muslim Ambassador To Saudi Arabia, For First Time Ever

The appointment of Mr Vipul as the new Indian ambassador to the Kingdom of Saudi Arabia is a historic shift in India's diplomatic strategy. It breaks the established convention since 1948 of sending a Muslim ambassador to the country. In this regard, Vipul is the first non-Muslim Indian diplomat in Saudi Arabia. His appointment is significant not just from a geopolitical lens but also for the underlying signalling.

Geopolitically, Saudi Arabia matters to India for reasons that extend far beyond the traditional lens of oil and expatriate labour. Riyadh today occupies one of the most important positions in India's diplomatic landscape. It is a critical energy partner, a leading political actor in the Gulf, the custodian of Islam's two holiest sites, and an increasingly influential economic hub. Under its Vision 2030 transformation agenda, Saudi Arabia has emerged as a centre where investment, technology, infrastructure, culture, and geopolitics intersect, creating new opportunities and strategic considerations for countries such as India. In this backdrop, the appointment of Mr Vipul is a wise choice. A career diplomat from the 1998 batch of the Indian Foreign Service, he brings extensive experience in the Gulf and the wider region, having served in Cairo, Colombo, Geneva, and Dubai, and most recently as India's ambassador to Qatar. His appointment reflects expertise, seniority, and familiarity with a strategically vital region rather than any departure from diplomatic meritocracy. However, more than his professional credentials, it's the fact that he's the first non-Muslim diplomat to head the mission in Riyadh since diplomatic relations between the two countries were established that has gained more attention. In a highly polarised environment, the risk lies less in the appointment itself than in the narratives that may be constructed around it. Since the late 1940s, New Delhi had exclusively selected senior Muslim diplomats for the ambassadorial role in Riyadh and the consul general position in Jeddah. This practice was primarily rooted in logistics; the Indian mission in Saudi Arabia plays a massive role in coordinating the annual Hajj pilgrimage, which sees hundreds of thousands of Indian Muslims travel to Islam's holiest sites. India sends the second-largest Hajj contingent to Saudi Arabia after Indonesia - 1,75,000 is the official Hajj quota. With such a huge number of Indians coming in for Hajj, the role of the consul general in Jeddah and the ambassador in Riyadh becomes crucial in terms of coordination with Saudi authorities. According to senior diplomats posted earlier in the region, the coordination and management of Hajj often requires the ambassador's presence in Mecca and Medina, Jamarat for coordination, as the Saudi management also shifts to these areas. Since a non-Muslim is not allowed in the area where the Hajj pilgrimage is performed, the management of the pilgrimage may be adversely affected if the ambassador cannot be in the area. An example is the fire tragedy in the tent city of Mina in 1997, in which hundreds of Indians died, and the then ambassador, Hamid Ansari, rushed to the site of the tragedy for coordination with higher Saudi authorities.

Iran on Tuesday shot down a US Apache helicopter near the Strait of Hormuz, prompting Trump to say that America must, out of necessity, respond to the attack. His statement on Truth Social suggests caution rather than a boast about America's power and dominance, which he is more accustomed to. He had shown similar caution last weekend after Iran fired missiles at Israel, threatening both the precarious ceasefire and the deal Washington and Tehran have been negotiating to end the war. Trump pleaded with the Israeli Prime Minister, Benjamin Netanyahu, not to strike back at Iran. But the latter simply ignored him. This is the new reality 100 days after Trump joined Netanyahu's war against Iran. The leader of the so-called free world looks weak and humbled, and the power of the United States appears to have reached its limits, at least in West Asia.

Before the war, it was inconceivable that Iran would threaten Israel over its actions in Lebanon and then carry out that threat without fear of a US response. Iran's policy had been what it called "strategic patience". But its new leadership seems to believe that restraint is a sign of weakness. The cautious Ayatollah Khamenei, under whose leadership the policy of restraint was last seen during the 12-day war in 2025, is no longer alive. His son, Mojtaba, the new leader, has given full backing to the Iranian Revolutionary Guards Corps (IRGC) for an uncompromising, tough approach. A week ago, Tehran warned Israel of missile strikes if it continued bombing Lebanon, particularly if the southern outskirts of the capital, Beirut, were attacked. These areas are the stronghold of Iran's proxy group, Hezbollah. That came after Netanyahu ordered these areas to be bombed. An angry Trump called Netanyahu, shouting, "What the f--- are you doing?" "You're f---ing crazy." Netanyahu paused the attacks, but only for a week. On Sunday, when Israel bombed the Beirut suburbs, Iran responded as it had promised. Defying Trump's pleas, Israel not only struck Iran in retaliation but also targeted one of its petrochemical complexes, threatening further escalation. Later, both called off further strikes at each other.



Sabotaged By A Friend?

Trump is desperate to end the war, which has become deeply unpopular in the United States. But he is worried that Netanyahu's actions could jeopardise ongoing negotiations with Iran. The Israeli leader, on the other hand, wants to resume the war. Netanyahu fears that Trump might be conceding too much to Tehran. Iran's use of the Strait of Hormuz as a chokepoint has shifted the focus from the nuclear programme to the reopening of the narrow waterways, alarming Israelis. There is supposed to be a ceasefire in Lebanon, but Israel has not halted strikes on Hezbollah targets. The militant group has also been launching missiles at Israel. The Israeli military has killed more than 3,600 people, mostly Shia Muslims, since the war began in March and has displaced one-fifth of the population. Israel has advanced much deeper into Lebanon, occupying large parts of its territory. This has enraged Iran, hardening its stance in negotiations with the United States. As Tehran's latest military action in Lebanon shows, it is committed to backing its ally Hezbollah. Israel is well aware of that. Its military operations in Lebanon appear to be trying to sabotage a deal with Iran, despite Trump's repeated calls to Netanyahu for restraint.

Why Can't Trump Rein In Netanyahu?

Iran views Israel's behaviour in Lebanon as a test of Trump's power and his willingness to use it. Apart from angry telephone calls, Trump has not really used the leverage the US has over Israel to contain Netanyahu. Israel receives the largest amount of aid from the United States; no country is even close. In addition to \$3.8 billion annually, Israel has received billions more from the US in recent years. After the Hamas attack on Israel in 2023, the US Congress passed a law to provide \$10.6 billion in direct military aid to the Jewish state. Soon after he started his second term, Trump proposed an \$8 billion aid package for Israel, and this January, his government announced \$6.5 billion in weapons aid. Without this help, Israel can't carry out its military operations. Thus, Trump has options - if he is willing to use them. The aid has continued despite declining support for Israel among the US population. In April, the Pew Research Center reported that 60% of Americans now hold a negative view of Israel, an increase of nearly 20 percentage points from two years ago. However, the Israeli lobby remains highly influential in the US. The American Israel Public Affairs Committee (AIPAC) directly con-

tributes to US politicians' election funds. Netanyahu personally lobbies the American media and US lawmakers, especially those from Trump's Republican Party. Therefore, it's not easy for any American politician to rein in the Israeli leader. Even Trump finds it difficult to curb Netanyahu's actions.

All The Wrong Choices

Trump may feel betrayed by Netanyahu, but he is also responsible for the situation. His actions in favour of Israel and Netanyahu over the years have made him and the US deeply unpopular in West Asia and have damaged America's credibility. During his first term, he moved the US embassy from Tel Aviv to Jerusalem, a city claimed by both Israelis and Palestinians. He allowed Netanyahu to expand Israeli settlements in the occupied West Bank, an illegal and unpopular move internationally. Trump has worked hard to make Israel acceptable to Arab governments through the Abraham Accords, though people in these countries remain opposed to the decision. In February, US Ambassador to Israel, Mike Huckabee, a Trump appointee, angered the Arab world by suggesting that Israel has a right to much of the Middle East. Trump was the first and only US president in four decades whom the

Israelis, under Netanyahu, have managed to persuade to join the war against Iran. He is also the one at whose behest Trump pulled America out of the 2015 Iran nuclear deal and started the 12-day war with Iran last year, while the US was negotiating a new agreement with the country, and again this year. It was Netanyahu who ordered the targeted killing of Ayatollah Khamenei and most of Iran's other leaders early in the war, many of whom would have shown more flexibility on a deal, perhaps on US terms. These actions explain why Iranians don't trust the US with a new agreement.

It was also Netanyahu who prolonged the Gaza war, which has killed more than 72,000 people. Trump backed Netanyahu even after the World Court issued arrest warrants for him over war crimes in Gaza. Last year, Israel attacked a meeting of Hamas negotiators in Qatar, a close US ally, during Gaza negotiations, embarrassing the president. With Qatar's help, Trump negotiated a deal to end the Gaza war, but Israel has not stopped its military action against Palestinians there, creating mistrust not only of Israel but also of America. Since the Gaza accord was signed, nearly 900 people have been killed in the Palestinian territory. Trump's decision to join Israel in the war against Iran has weakened the US the most. While Iran is now more powerful than ever, support for America in West Asia is now at a level not seen since the Arab-Israeli war in 1973. Trump is widely seen as a leader who cares only about Israel. A survey by the Arab Barometer, a research group in West Asia, conducted after the 12-day war in 2025, found that people in the region had lost nearly all confidence in a US-led regional order. Instead, they now regard China, Iran, and Russia more favourably than the United States. Making America Weak Again America's position was not this weak until recently; in fact, it was riding high. The fall of the Bashar al-Assad regime in December 2024 was a major setback for Russia and Iran. Moscow was struggling in Ukraine, and China was concerned about the US's motives in the Indo-Pacific. In January, the removal of Venezuela's president, Nicholas Maduro, an ally of Beijing and Moscow.

THE FUTURE OF PARENTS AND CHILDREN AFTER FIFTY

Advances in medical science have opened the way to parenthood for couples who, for whatever reason, were unable to conceive naturally. Today, when some couples, at the age of 50-52 or even older, sometimes by taking on debt, decide to become parents through IVF, it becomes necessary to seriously consider this issue. However, considering average circumstances, age is certainly an important factor that cannot be ignored. In this context, adoption is also a worthwhile option. There are

thousands of children in our country who, for whatever reason, are deprived of parental love and protection. If capable families adopt them, not only can their futures be secured, but families can also experience the joy of having children. Unfortunately, even today, society places greater importance on biological children, which is why many people don't seriously consider a positive option like adoption. In reality, becoming a parent isn't just about fulfilling one's own desires. It means actively participating in a child's life for the next twenty to twenty-five years, supporting their dreams and standing by them through every circumstance. Therefore, when deciding to have children, one should consider not only present happiness but also future responsibilities. Emotions are important, but foresight is equally essential. Ultimately, the question isn't about IVF or medical science. The question is whether we're adequately considering the long-term consequences of our decisions. Having children is one of life's greatest joys, but it's also a huge responsibility. Therefore, before deciding to delay parenthood, it's essential to consider health, financial status, social circumstances, and, above all, the child's future. The best interests of a child should be the basis for every decision. Punjab And Its Discontents: How The Akali Factions Are Faring

The Shiromani Akali Dal (SAD) is one of India's oldest regional parties, founded in 1920 and almost as old as the RSS. For over a century, it has been deeply connected with Punjab's political, religious and social history. In contrast to many regional parties that emerged around personalities or electoral issues, SAD was born out of a mass movement and built its legitimacy through struggle and sacrifice. The party played a historic role in the Gurudwara Reform Movement, participated in the freedom struggle, led the Punjabi Suba agitation, and emerged as the principal political voice of Sikh aspirations. During the Emergency, Akali leaders were among the strongest defenders of democratic rights. For decades, SAD positioned itself as the champion of Punjab's federal rights, Sikh interests, and farmers' concerns, giving it a stature far beyond electoral politics. Electorally, SAD has been one of Punjab's most successful parties, forming governments multiple times and producing towering leaders such as Parkash Singh Badal, Gurcharan Singh Tohra, etc. Its long alliance with the BJP has often been cited as a successful model of Hindu-Sikh camaraderie and social harmony after the turmoil of the 80s. Together, the alliance dominated Punjab politics for nearly two decades. However, since 2015, the party has witnessed a dramatic decline. A number of reasons were behind this decline. Akali Dal's electoral success was based upon pragmatism and ruthless use of money and power, which led to a number of mafias - land, sand, transport, drugs, cable - dominating the party. Ideology and the old Jathedar base of the party was jettisoned for family, "Halqa incharges", and new "moneybags". Controversies like Beadabi, farm laws and Article 370 ensured that the Akalis alienated their core votebank of Sikhs and peasants. Meanwhile, new ascendant social forces - youth, NRIs, unemployed, influencers; new social movements - farmers and Panthic and new political outfits - PPP, AAP, using new digital technologies, prospered at the



expense of Akalis, painting them as the real villains of Punjab and holding them responsible for all its ills. At the same time, demographic changes - such as out-migration of the core Akali vote bank of Jatt Sikhs - also hurt the Akali Dal the most. All this ensured the dramatic decline of the Akali Dal as an electoral force. Its votebank has crashed from 35% to 13%, and its seat share in the state assembly has declined from 58 to three since 2012. It reached a nadir in the 2024 Lok Sabha elections, when it lost deposits on 10 of 13 seats and secured just 13.42% votes. Along with electoral decline, Akali Dal has to face a prolonged period of ideological confusion as it veered from one extreme - battling Bandi Singh and Rajoana in elections to another, like supporting Article 370 move and farm reforms. Electoral defeats were also accompanied by a challenge to Sukhbir's leadership from disgruntled Akalis - Dhindsa, Chandumajara, Jagir Kaur and from Jathedars along with resentment among the religious over the "Beadabi" issue. One of the most significant results of the decline of the Shiromani Akali Dal over the last decade has been the fragmentation of Punjab's Panthic political space. What was once largely monopolised by a single party is today contested by four

distinct formations - Akali Dal (Badal), Waris Punjab De, Akali Dal (Mann), and the various rebel Akali factions often described as Akali Dal Punar Surjit. Each seeks to position itself as the authentic voice of Panth and Punjab, but each carries its own strengths and limitations. Despite its dramatic decline, the Akali Dal under Sukhbir Badal remains the largest and most organised Panthic force. Its greatest strengths are its century-old legacy, extensive organisational network, Sukhbir Badal's leadership, financial resources, and deep roots in rural Punjab. It remains the only Panthic outfit with a proven record of governance and state-wide presence. Moreover, the party has shown signs of revival by its improved showings in bypolls and local elections in the last year. The party has held a series of rallies recently to bolster its support. It remains strong in the rural Malwa heartland and parts of Majha. However, its weaknesses are equally apparent. Akali Dal continues to suffer from a severe credibility deficit arising from the Beadabi, drug charges, alleged mafia links and pressure from "neo panthics". The ruling AAP continues to poach Akali leaders. Youngsters remain suspicious of its intentions and unconvinced by its attempts at reinvention.

SpaceX IPO opens door to retail investors, but here are the risks

New York: When SpaceX makes its debut on the US stock market, it wants smaller-pocketed, mom-and-pop investors to play a big role in what may be the biggest IPO ever. Elon Musk's rocket company, formally known as Space Exploration Technologies Corp., is steering some of its initial public offering of stock directly to what are called "retail" investors. These are people who buy stocks in a brokerage account on their phone, not pension funds or other big "institutional" investors routing orders to their professional trading desks. Here are some things to keep in mind as the IPO approaches: A chunk of SpaceX stock will go to regular investors. Most IPOs offer only 5 per cent to 10 per cent of the total offering to retail investors, according to Fidelity. In this case, though, it could be up to 30 per cent. SpaceX expects retail investors to participate in its IPO through Charles Schwab, Fidelity, Robinhood, SoFi and E-Trade by Morgan Stanley. At Fidelity, investors with as little as USD 2,000 in their accounts could potentially



snag SpaceX shares in the IPO. That's down from account minimums of USD 100,000 or even USD 500,000 that Fidelity has for other equity offerings. Demand from investors may be so high in this IPO that not everyone indicating interest will actually get a share.

Trying for a short-term flip has risks

Given all the hype around SpaceX, the temptation could be high to grab shares in the IPO and sell them quickly if a frenzy sends its price spiking. But brokerages have policies to block

investors from future offerings if they dump shares bought in an IPO quickly, like within a couple of weeks.

Big swings in price may be possible

Potentially high interest from retail investors following the IPO is one reason SpaceX is warning that its stock price could be volatile. These investors aren't known for moving as meticulously as a pension fund, which is trying to build money for payments it must make years or decades in the future.

It's retail investors, after all, who helped drive GameStop and other "meme stocks" to market-bending heights in 2021 that professional investors called irrational. IPOs can see a big first-day bounce, but that may not last. The typical IPO has seen a 7 per cent jump in its first day of trading, from 1980 through 2025, according to Jay Ritter, an IPO expert and a professor at the University of Florida's Warrington College of Business. But IPOs tend to lag similar-sized peers in the ensuing five years, not including their first day of trading. They do so by an average of 3.6 per cent per year, according to Ritter. SpaceX has debt and has been losing money. It's very expensive to launch things out of the Earth's atmosphere and to construct huge AI data centres, and SpaceX has built up USD 29.1 billion in debt, as of the end of March. The company also lost USD 4.9 billion last year and another USD 4.3 billion through the first three months of 2026. It acknowledges that it "may not achieve profitability in the

future." Over the long term, a stock's price tends to track with how much profit the company is making.

You don't have to buy SpaceX to own it

You could end up owning some of SpaceX even if you never intended to. Consider the many people who own shares of the popular QQQ exchange-traded fund, which tracks the Nasdaq 100 index and has roughly USD 460 billion in total assets. Historically, the Nasdaq 100 index would wait until each December to add new members in an annual reconstitution to make sure it includes the 100 largest non-financial companies on the Nasdaq. But Nasdaq recently made changes to allow some big companies to enter the Nasdaq 100 index after just 15 trading days. That means if SpaceX's IPO is as successful as expected, it could quickly join both the Nasdaq 100 and QQQ fund, all while QQQ holders do nothing on their own. The company behind the more popular S&P 500 index, though, is not making changes that would allow SpaceX faster entry.

Stock markets climb in early trade on buying in blue-chips



Mumbai: Benchmark indices Sensex and Nifty climbed in early trade on Wednesday, June 10, amid buying in blue-chip stocks. Reliance Industries, ICICI Bank and cooling crude oil prices. The 30-share BSE Sensex rallied 303.73 points to 74,222.49 in early deals. The 50-share NSE Nifty went up by 85.40 points to 23,327.50. From the 30-Sensex firms, Hindustan Unilever, Reliance Industries, Kotak Mahindra Bank, Asian Paints, Trent and ICICI Bank were among the biggest winners. Tata Steel, Eternal Ltd, Adani Ports and Tech Mahindra were among the laggards. Brent crude, the global oil bench-

mark, traded at around USD 91.90 per barrel. "The market is likely to largely ignore the escalation of the conflict in West Asia as a one off. The softness in crude price indicates that. Despite the escalation, Brent crude continues to trade below USD 93 level," VK Vijayakumar, Chief Investment Strategist, Geojit Investments Limited, said. A significant trend in global markets is the fatigue that is creeping in AI trade, he added. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index and Hong Kong's Hang Seng index quoted lower.

US markets ended mostly lower on Tuesday. "For Indian markets, a key positive is the cooling in crude oil prices. Brent crude has slipped below recent highs, easing some pressure on India's inflation outlook and current account concerns," Hari Prasad K, Research Analyst and Founder, Livelong Wealth, said. Foreign Institutional Investors (FIIs) offloaded equities worth Rs 4,566.03 crore on Tuesday, according to exchange data. On Tuesday, the Sensex climbed 394.50 points, or 0.54 per cent, to settle at 73,918.76. The Nifty ended 119.10 points, or 0.52 per cent, higher at 23,242.10.

Meta, FPEL partner on 88 MW renewable energy projects in India

New Delhi: Fourth Partner Energy (FPEL) said on Wednesday, June 10, it has partnered with Meta Platforms Inc. on 88 megawatts alternating current (MWac) of renewable energy projects across India, as the technology company seeks to advance its clean energy and emissions reduction goals in the country. Under the agreement, FPEL will own and operate a portfolio of solar and wind projects across the states of Tamil Nadu, Karnataka, Maharashtra and Uttar Pradesh. Meta will purchase 100 per cent of the environmental attributes associated with the projects, FPEL said in a statement. The deal supports the addition of renewable energy capacity to India's power grid and forms part of Meta's broader strategy to align its operations with clean energy sources. "These projects with Fourth Partner Energy represent a commitment to India's clean energy ecosystem, helping to bring new renewable energy capacity



onto the grid and address Meta's value chain emissions in the region. This is consistent with our broader goal of matching our global operations with 100 per cent clean and renewable energy," said Amanda Yang, Head of Clean and Renewable Energy at Meta. The agreement reflects growing demand from large corporations for renewable energy solutions to help reduce emissions across their operations and supply

chains. "This partnership with Meta highlights FPEL's expertise in delivering innovative, integrated renewable energy solutions to India's businesses," said Vivek Subramanian, Co-Founder and Executive Director of Fourth Partner Energy. "Corporates are increasingly keen to utilise clean energy across their Scope 2 and Scope 3 supply chains. This is where the complementary nature of solar and wind helps offer maximised

renewables. We are excited to work with Meta and continue being corporate India's preferred Net Zero enablers," he added. Fourth Partner Energy said it currently operates 1.7 gigawatts (GW) of solar and wind assets across India, with an additional 3 GW under development. The company has set a target portfolio of 9 GW by 2031. Meta will purchase 100 per cent of the environmental attributes associated with the projects.

VERSION OF AI TOOL 'TOO POWERFUL FOR PUBLIC' RELEASED TO PUBLIC

A version of an artificial intelligence (AI) tool which the company said was too powerful to be released to the public has just been released to the public. Claude Fable 5 is a version of Anthropic's Claude Mythos, an AI program which caused serious concerns among technology, finance, and government leaders when it was released privately in April for previewing and testing. Some worry the tool is so powerful it could pose financial security risks, though others have questioned how much of the hype is marketing spin. Anthropic said on Tuesday Fable will be released with safeguards and user limitations in place, though it said "releasing a model this capable comes with risks". "Fable's capabilities exceed those of any model we've ever made generally available", it added. When Mythos was first released to a small group of organisations to preview the tool, Anthropic said it was doing so because the tool was so intelligent that it



could be dangerous because of its ability to exploit or hack computer systems. Canadian Finance Minister François-Philippe Champagne told the BBC in April that the attention on Mythos was warranted, in part, because "it's the unknown, unknown". Meanwhile, despite Anthropic's ongoing lawsuit against the US Department of Defense over its refusal to accept government use of its AI tools, US government agencies have been testing Mythos too. Anthropic is expected to become a public company soon, as its

private valuation has neared \$1tn (£747bn). Consistently showing better and broader AI capabilities underlines its value to investors. The company also said on Tuesday that the roughly 150 groups that had been given access to preview Mythos will now have access to Claude Mythos 5, which does not have limitations on cybersecurity or biology, depending on an organization's specific uses. To date, groups and companies using Mythos have reported to Anthropic finding more than 10,000 critical security flaws in their

systems. Anthropic said the updated access was limited to a "small group of cyberdefenders and infrastructure providers" but is expected to go beyond that soon. "We intend to expand access to Mythos 5 through a broader trusted access program", the company said. Both Fable and Mythos, which are essentially the same model but with different safeguards and levels of access in place, can work "unattended" on human commands that the tools are given for longer periods of time "than any previous Claude models." Anthropic added. Anthropic co-founder Jack Clark last week told BBC Newsnight that the ability of AI tools was expanding so rapidly that the company thought there should be a way for the public to slow the technology's advancement. "You want the option to be able to take your foot off the gas and put your foot on the brake", Clark said. "Right now, it's like the AI industry has a gas pedal, but it doesn't have a brake pedal."

Kalshi to make some users reveal job details to tackle insider trading

People looking to place certain bets on prediction market operator Kalshi will soon have to reveal where they work in an attempt to stop insider trading, the firm has said. The platform - which lets users bet against each other on elections, sporting events, and culture - said Tuesday it will start to collect work information from users attempting to place bets that could benefit from insider information. Kalshi said the rule will apply to "markets with heightened insider or manipulation risk." It used as an example a possible trade on whether OpenAI or Anthropic will go public first. Prediction markets face growing concerns around insider trading as they continue to surge in popularity. Former Congressman George Santos is currently being investigated for alleged insider trading on Kalshi, according to NPR. And earlier this year, Kalshi said it had discovered candidates for Congress from Minnesota, Texas, and Virginia were betting on their



own races. Kalshi said that in the first quarter of this year, it made more than 20 referrals to law enforcement of possibly illegal trading activity after opening more than 150 of its own investigations. Last month, a Google employee was charged with insider trading for using company information to place bets on Polymarket, a rival prediction market operator. And earlier this year, a US special forces soldier was found to have allegedly made successful bets on the platform regarding the removal operation of Venezuelan President Nicolás Maduro. He has

pleaded not guilty. By requiring more information from users about where they work, Kalshi said it will be able to "identify presumptive insiders... and screen them out before a trade is ever placed". Kalshi said it would use a risk scoring method to identify markets that appear more at risk of manipulation or insider trading, such as those on national security matters. "By running an assessment on the national security risk a market might present before we list it, we can better prevent dangerous events from having a negative effect on our markets - or vice versa".

PREZ TRUMP SAYS US WILL HIT IRAN 'HARD' AGAIN ON WEDNESDAY

Donald Trump has said the US will hit Iran "hard" on Wednesday, after the two sides exchanged strikes overnight. Speaking to reporters in the Oval Office, the US president said the US and Iran were "close" to making a peace deal, but reiterated a call for Iran to "sign a deal". Following US strikes on Iran on Tuesday in response to the downing of a US army helicopter in the Gulf, Trump said strikes would continue. "We hit them hard yesterday and we're going to hit them hard again today," he said. Iran earlier said it launched strikes at US bases in the Middle East following the US's strikes on Iranian sites. Trump earlier said Tehran had taken "too long to negotiate a deal" and would now "have to pay the price", without giving specific details. It came after Iran's Foreign Minister Abbas Araghchi earlier warned his country would "leave no attack or threat unanswered". The US said it struck Iranian sites on Tuesday in response to the downing of a US army helicop-

ter in the Gulf. Separately, India's government said a commercial vessel had been attacked off the coast of Oman on Wednesday, with three Indian sailors reportedly missing. It did not give details of the source of the attack. The BBC has asked US military Central Command (Centcom) for comment. Earlier on Wednesday the UK's Maritime Trade Operations (UKMTO) Centre said it had received a report - which it marked under "suspicious activity" - that a tanker 20 nautical miles northeast of Sohar in Oman, had experienced a fire in its engine room. The US military said it had targeted Iranian defence systems, ground control stations and radar sites near the Strait of Hormuz. Iranian state media said US strikes had hit two reservoirs in the area, leaving thousands of people in the southern port town of Sirik without access to drinking water. Iran's Islamic Revolutionary Guard Corps (IRGC) said it launched strikes



on 21 targets at US bases in the region, one in Bahrain and the other in Jordan, while Kuwait's army said it was also intercepting an attack. Reuters cited a US official on Wednesday as saying nearly all of the Iranian missiles and drones launched at US bases in the Middle East in response were intercepted, with no reported casualties. Writing on his social media platform Truth Social on Wednesday, Trump said: "Iran's Military is a complete and total mess. Much of it, like their Navy and Air Force, doesn't even exist anymore - They have been completely defeated." He added: "They've taken too long to negotiate a deal that would have been great for them, now they will have to pay the price!!!" Trump's com-

ments were in contrast to Tuesday, when he told journalists the US and Iran were "in the final throes of what will be a very, very good deal". Also on Wednesday, Iran's foreign ministry spokesman Esmail Baqai accused the US of "damaging this diplomatic process through the contradictory messages it sends, its repeated shifts in positions and demands, and, worst of all, through repeated violations of the ceasefire". He said Iran needed to re-assess the situation, adding that any diplomatic process required a minimum of stability. On Tuesday, Centcom described its strikes on Iran as "a proportional response" for the Apache helicopter downing on Monday, with the IRGC describing them as "vicious". Trump previously said on Truth Social that the helicopter had been "shot down" as it was patrolling the Strait of Hormuz, a critical shipping channel that has been effectively closed since the conflict started in late February. Fox News quoted

Trump on Wednesday as saying that an Iranian drone had hit the helicopter without exploding as it flew "very low". The two crew members survived and were rescued by an American sea drone. According to US officials, Iran used a drone to launch the attack on the helicopter. But it is not clear whether the drone had deliberately attacked it, an unnamed US official told CBS News, the BBC's US partner. The semi-official Iranian Mehr News Agency reported that Iran had not claimed responsibility for the downed aircraft. The Indian Ministry of External Affairs said in a statement on Wednesday that 21 Indians had been rescued after an attack on the commercial vessel Settebello "earlier today". It said its embassy in Oman was coordinating with Omani authorities in the ongoing search and rescue operation for the three missing people, saying the "targeting of commercial shipping and civilian infrastructure in the region must end".

Norway crown princess's son to stay in custody before rape verdict, says court



A Norwegian appeal court has rejected a request by Marius Borg Høyby to be released from custody because of his mother's serious illness, ahead of a verdict in a rape trial. The appeal court's ruling in Oslo overturns a lower court's decision on Monday ordering the release of the crown princess's 29-year-old son pending next Monday's verdict on 40 criminal charges. He denies the most serious allegations. Princess Mette-Marit, 52, is suffering from pulmonary fibrosis, and her doctors last week placed her on a waiting list for a lung transplant, saying her condition had

declined significantly in recent months. Her son's lawyers argued that Høyby needed to be close to his mother. Høyby himself is not a member of the royal family. He has been in custody since the start of February, when he was detained before his trial over new allegations of assault and violating a restraining order requiring him not to go near an ex-girlfriend. The case against him began when he was first arrested at the woman's flat in the upmarket Frogner area of Oslo in August 2024. Repeated attempts by his lawyers to secure his release failed until a district court said on Monday he should be freed from custody. "Sitting inside when I know Mum is so sick is unbearable," Høyby had told the district court. It ruled that while there was a marginal risk of the crown princess's son re-offending, he had been free of drugs in prison and it would be "disproportionately intrusive" to keep him in jail.

MANHUNT UNDER WAY IN SOUTH AFRICA AFTER 12 KILLED IN MASS SHOOTING IN JOHANNESBURG



Police in South Africa have launched a manhunt after 12 people were killed in a mass shooting at an informal settlement in Johannesburg. At least 10 suspects, heavily armed with rifles, entered the Jumpers Informal Settlement in the suburb of Cleveland late on Tuesday night and opened fire before fleeing in a white vehicle, police said. The motive for what police called a "heartless" and "barbaric" attack, in which another nine people were injured, is still being investigated. Members of the Jumper's community believe the shooting may be linked to a turf war between groups of illegal miners living in the area. Illegal mining has been on the increase in South Africa, which has one of the highest murder rates in the world. Shootings in informal settlements are not uncommon, sometimes linked to gang violence and personal disputes. The local police department said its officers responded to a "complaint of shooting in progress" at about 23:10 local time (21:10 GMT) on Tuesday. "It is alleged that more than 10 suspects were dropped off by a white Toyota Quantum near a petrol station in Cleveland," the police said in

a statement. "The suspects allegedly entered the informal settlement through both entrances and moved through the area, opening fire on residents and community members at multiple locations before fleeing the scene in the same vehicle," the statement added. Police said eight men and three women died at the scene, while another man died from his injuries in hospital. At least nine others were taken to various medical facilities for treatment of gunshot wounds. The police have said that the motive for the attack is not known and forms part of the investigation. During a visit to the scene on Wednesday, provincial police commissioner Lt Gen Tommy Mthombeni reiterated this stance, but added that investigators could not rule out a connection to illegal mining. "As you know, this area is adjacent to the illegal mining area. We are having those suspicions," he told reporters, calling the attack "heartless" and "barbaric". Illegal mining is a lucrative, informal activity - with groups targeting disused gold mines and selling their finds on the black market. The trade is often violent - earlier this year.

INSIDE MYANMAR, REBELS ARE LOSING GROUND AS MILITARY FORCES MEN INTO ARMY

The four young men in the rebel camp hidden deep in jungle-covered mountains never wanted a part in Myanmar's civil war. They didn't choose to be soldiers for the military either. One had been a chef on his way home from work when he was grabbed off the street. His lack of ID was enough for the military to detain him and force him to sign up. Another was taken on his way back from a late-night karaoke session; a third had been working for the forestry department when he was arrested. The fourth man says on being arrested, drugs were slipped into his shoe, and he was framed and made to enlist. "Before we even understood what was happening, we were sent straight to the front lines," one of the men - all between



the ages of 19 and 25 - tells the BBC. "They made us do all kinds of things we didn't want to do," another adds. "We never got any real rest, not in the morning, not during the day, and not even at night." The conscripts had to do everything. While the regular soldiers hardly had to work. "They spent four months in basic training and then were sent to the front in Karen state - one night, on their way to get washed.

UKRAINE SAYS MISSILES HIT MILITARY PLANT DEEP INSIDE RUSSIA

Ukrainian forces have carried out a missile attack deep inside Russia, hitting a major military plant overnight, President Volodymyr Zelensky has said. He said FP-5 Flamingo cruise missiles struck the drone and missile plant in the city of Cheboksary, in the Chuvash Republic, more than 900km (560 miles) from the front line. Local officials said three people were injured in a missile attack on the city. Ukraine also said it had hit the Moscow-occupied port of Mariupol on the Sea of Azov, a Russian oil refinery in Samara and a "shadow fleet" oil tanker in the Black Sea. In recent months, Ukraine's military has intensified its drone strikes on key facilities across Russia. Kyiv says energy sites are legitimate targets, as they allow Moscow to continue its



war effort. However, missile attacks deep inside Russia have been rare. Russia's military said that its air defence units had intercepted or shot down 326 Ukrainian drones over a number of regions overnight. Meanwhile, Ukraine's air force said it downed 181 out of 207 drones fired by Russia during that time. It also admitted 21 direct hits in 14 locations. At least two people were killed and 26

injured, including two children, in four Ukrainian regions in the past 24 hours, local officials said. In a post on Telegram on Wednesday, President Zelensky wrote: "Overnight, Ukrainian FP-5 Flamingos hit a military plant in Cheboksary that supplies the occupier's army with components for drones and missiles". He also published footage said to be showing a missile flying toward its target and plumes of smoke from a facility. Ukraine's military later said the VNIIR-Progress plant had been struck and there had been a fire at the site. Chuvash Republic head Oleg Nikolaeov confirmed that Cheboksary had been hit, reporting three injuries. He did not say whether the military plant was damaged. The FP-5 Flamingo missile has a 1,150kg (2,535lbs) warhead and a reported range of 3,000km, putting Russia's capital Moscow and other major cities well within its range. Together with its Western allies, Ukraine has also been actively developing other types of missiles in order to maximise the costs of Russia's invasion and force Moscow to seek a settlement. Russian President Vladimir Putin has so far rejected all negotiation proposals.

PAKISTAN LAUNCHES DEADLY AIR STRIKES IN AFGHANISTAN, REIGNITING TENSIONS

Pakistan has launched deadly air strikes along its border with Afghanistan, breaking months of relative calm in the restive region. Information Minister Attaullah Tarar said 26 militants had been killed in "calibrated strikes" on four targets. Afghanistan's Taliban government said 13 people, mostly children, were killed in Pakistani strikes in three provinces. Pakistan has long accused Afghanistan of harbouring terrorists who carry out attacks on its soil, a claim the Taliban government rejects. In February, clashes between the two countries left dozens of people dead. In March a Pakistani



strike on a drug rehabilitation centre in Kabul killed hundreds. The two countries had agreed a ceasefire last October following weeks of deadly clashes. Tarar said Wednesday's strikes had been a response to "recent terrorist incidents in Pakistan" and had

targeted "hideouts and safe havens" near the border, including a training centre and an ammunition cache. The bombardment came a day after an attack on security forces near Peshawar, in which the Pakistani government said at least six officers were killed.

"Pakistan has always strived for maintaining peace and stability in the region, but at the same time the safety and security of our citizens remains our top priority," Tarar said. Earlier Taliban government spokesman Zabihullah Mujahid said that 11 children, one woman and one elderly man had been killed in Pakistani strikes in the provinces of Kunar, Khost and Paktika. He also said that 14 women and children were injured in the Pakistani bombing. Afghanistan has repeatedly said its territory is not being used to threaten other countries.

FIRST CHARGES LAID OVER DEADLY HONG KONG FIRE



Hong Kong authorities have laid their first charges over the devastating fire at the Wang Fuk housing complex last November. Two companies and seven people were handed a total of 25 charges, including manslaughter, conspiracy to defraud, attempting to pervert the course of public justice, and tax evasion. The blaze, which killed 168 people, was the deadliest fire the city had seen in more than 70 years. Authorities said they had charged the project consultancy firm and the main contractor tasked with delivering renovations, as well as individuals from both companies. Structural engineering consultancy firm Will Power Architects and contractor Prestige Construction and Engineering have both been charged with manslaughter. A director of Prestige, 52-year-old Ho Kin-yip, was also charged with manslaughter, along with a director of Will Power, 40-year-old Wong Hap-yin, and the firm's reg-

istered inspector, 44-year-old Ng Yeuk. Having been first arrested soon after the fire, all three were denied bail on Wednesday. An independent committee investigating the fire has identified several critical breaches that led to the massive blaze, which also left thousands of people homeless. Among other things, fire alarms in seven of the eight residential blocks were deactivated while windows were boarded up with flammable foam boards. "On the day of the fire, nearly all fire safety systems meant to protect lives failed because of human factors," the committee's lead lawyer Victor Dawes told a public inquiry earlier this year. Some residents had also said that construction workers had been littering cigarette butts throughout the site while they were still lit. The three men also face corruption charges laid by Hong Kong's anti-graft watchdog alongside four others - including Wong's wife and his friend.

Texas teen sentenced to 35 years for killing fellow student at athletics event

A Texas teenager accused of fatally stabbing one of his peers at a high school athletics event in the Dallas area was found guilty by a jury on Tuesday. The racially polarising trial of Karmelo Anthony over the April 2025 death of Austin Metcalf drew national attention, sparking a debate about self-defence and school safety. Both were 17 at the time of the incident. Prosecutors argued that Anthony threatened Metcalf before he intentionally killed him, while defence lawyers argued that Anthony was acting in self-defence. Anthony was sentenced to 35 years in prison. The young men were at a secondary school track meet when the incident happened. Metcalf's death was

the result of a dispute that escalated between the two rival secondary schools, according to police reports. Though Anthony was 17 at the time of the murder on 2 April 2025, under Texas law, he was able to be charged as an adult. The death penalty was not considered, as Anthony was a minor at the time of Metcalf's death. Throughout the trial, prosecutors called nearly two dozen witnesses, concentrating their evidence on eye-witness testimonies. One of the most emotional testimonies came from Collin County Chief Medical Examiner Dr Elizabeth Ventura, who described a large, gaping wound in Metcalf's chest and said the knife had pierced his heart.

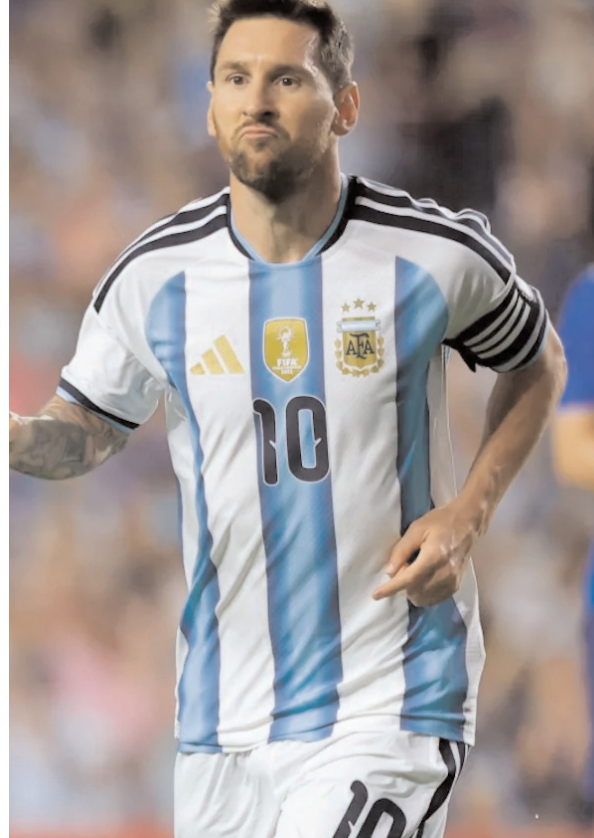


FRESH CONTROVERSY HITS FIFA WORLD CUP 2026, LIONEL MESSI AND ARGENTINA'S PASSPORT DATA LEAKED

Lionel Messi, and his Argentina teammates at the FIFA World Cup 2026, were victims of a major data breach at the FIFA World Cup. News agency Reuters stated in a report that a security oversight leaked the passport details of every player in the Argentina squad for Tuesday's pre-World Cup warm-up friendly against Iceland, including Lionel Messi. The passport numbers, listed on the official team sheet, should have been blurred before being released to the media and the public. But in Alabama's Jordan-Hare Stadium, they were circulated without redaction. However, Iceland players' passport numbers were not revealed as they did not submit their passport numbers in the team sheet. Reuters has contacted the Argentinian Football Federation and FIFA for comment. Other controversies in the FIFA World Cup

This marks the latest in the list of controversies to hit the FIFA World Cup. A video alleging Senegal players being subjected to excessive security checks at a US airport ahead of the FIFA World Cup 2026 has raised a storm. The team, which has superstars like Sadio Mane and Kalidou Koulibaly, was allegedly videographed getting checked by security with metal detectors on the airport tarmac in San Antonio after getting off a flight. Several social media users claimed that other teams like Spain were not subjected to such intensive checks, that too right on the tarmac. Some alleged even Uzbekistan was meted out with the same treatment in New York. A World Cup referee from Somalia who was denied entry to the United States was received by a crowd of supporters and officials Wednesday as he arrived home in the capital of

Mogadishu, where he said he plans to be at the next World Cup and urged Somali youth to be proud of their country. Omar Artan was set to be the first referee from Somalia to officiate at a World Cup after making FIFA's final list for the tournament. He is one of Africa's top referees and was named the continent's best male referee in 2025. He was denied entry at Miami International Airport on Saturday over "vetting concerns," U.S. Customs and Border Protection said in a statement, without giving details of the concerns. FIFA subsequently cut him from the tournament's referee list. Artan was issued a visa to travel to the U.S. last week, according to the Somalia Embassy in Kenya, which processed it. The U.S. is co-hosting with Mexico and Canada, and Artan was due to meet up with other World Cup referees at their training base in Miami.



Shubman Gill Now Highest Ranked Indian Test Batter, Displaces Yashasvi Jaiswal

Shubman Gill is now the highest-ranked Indian in ICC Test rankings. The India captain climbed two places to eighth spot after hitting a century in the recent one-off clash against Afghanistan, which the side won by an innings and 300 runs. He is currently ranked eighth, one place above compatriot Yashasvi Jaiswal. Overall, England batter Harry Brook leapfrogged teammate Joe Root to reclaim the No. 1 spot in the ICC Test rankings. His 56 was one of only two scores above fifty in the match, which was enough to push Root down to third spot after the senior batter managed just one and eight, with Australia's Travis Head climbing to second spot. Brook had first risen to the top spot in December 2024 and now regains the position ahead of the second Test starting at The Oval on June 17. Gill, meanwhile, moved up to eighth spot after making 126 against Afghanistan in New Chandigarh. The England trio of Ben Duckett (up three places to 15th),



Jamie Smith (up five spots to equal 23rd) and Glenn Phillips (up 15 places to 40th) also made progress in the batters' rankings. In the bowling chart, England pacer Gus Atkinson gained seven slots to break into the top 10 Test bowlers at tenth spot, while moving to sixth spot among all-rounders. New Zealand's Kyle Jamieson (22nd) and Ollie Robinson (23rd) have re-entered the rankings, while Kiwi pacer Nathan Smith jumped 16 places to 43rd. In ODIs, wrist spinner Abrar

Ahmed rose two places to second among bowlers after claiming six wickets in Pakistan's series win over Australia. Shaheen Afridi climbed four spots to ninth with seven scalps. Australia's Nathan Ellis improved 13 places to 31st, while Bangladesh's Nahid Rana surged 23 slots to 24th. Sri Lanka's Kusal Mendis (12th) and Janith Liyanage (22nd) made gains among ODI batters, alongside Bangladesh left-hander Tanzid Hasan, who moved up seven places to 33rd.

Gautam Gambhir Bypassed As 'India Seniors' Knock BCCI's Door Over ODI Future: Report

As Team India's preparations for next year's ODI World Cup begin with the 50-over assignment against Afghanistan, there are plenty of wrinkles that reportedly need to be ironed out. Gautam Gambhir, who has become a highly authoritative figure in Tests and T20Is, has reportedly yet to get into the same zone in ODI cricket. The constant talk around the future of Virat Kohli and Rohit Sharma in the format has not helped. It has now been reported that some 'senior players' in the team have bypassed Gambhir and directly sought clarity over their future for the 2027 World Cup from the top bosses in the Board of Control for Cricket in India (BCCI). Ever since Rohit and Kohli retired from T20Is, doubts have pre-



vailed over their status and plans for the 2027 World Cup. Many feel that Gautam Gambhir's approach and the selection committee's demands played a role in the duo's transition. During the Indian Premier League (IPL) 2026 season with the Royal

Challengers Bengaluru (RCB), Kohli made it crystal clear that he is not in a zone where he can be expected to 'prove himself again'. Rohit, on the other hand, seems to have taken a different approach in ODI cricket, shifting from the selfless style

he displayed in India's Champions Trophy-winning campaign. According to a report in the Times of India, the Gautam Gambhir-led team management and some of the senior players are yet to be brought onto the same page. At present, the said senior players are in direct contact with BCCI powerhouses over their future, leaving both Gambhir and selection committee chief Ajit Agarkar in a tricky situation. "With such big players in the team, Gill needs to have a stronger say in the dressing room. Gambhir hasn't got involved in the planning as intently as he has done in the other two formats. So far, he has let things take their course," a BCCI source told the paper.

Why Players At 2026 FIFA World Cup May Have To Battle More Than Their Opponents

The 2026 FIFA World Cup could be played under some of the hottest conditions in the tournament's history, with climate change increasing the risk of performance-sapping heat in nearly every match and prompting fresh warnings from health experts. A new analysis by Climate Central found that 97 of the tournament's 104 scheduled matches are now more likely to experience temperatures above 28 degree Celsius (82.4 degree Fahrenheit) - a threshold linked to declines in football performance. Researchers warn that rising heat could slow the game, alter tactics and increase health risks for players. Nearly half of all matches face at least a 50% chance of experiencing performance-impairing heat. In

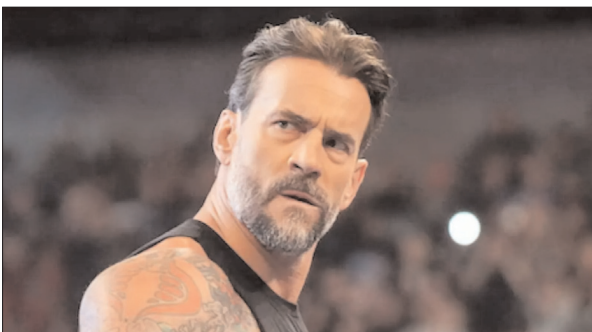


26 matches, climate change increased those odds by at least 10 percentage points. The biggest impact is expected during the June 26 group-stage clash between Uruguay and Spain in Guadalajara, where the probability of performance-affecting heat has risen to 70% - 37 percentage points

higher because of climate change, according to the analysis. Scientists say temperatures above 28 degree Celsius can reduce sprinting, total distance covered and recovery rates, affecting the speed and intensity of matches. "This analysis makes clear that rising temperatures are not only a seri-

ous health risk for players and fans, but they are also starting to affect the quality of the game itself," said Norway midfielder Morten Thorsby. "When heat impacts sprinting, recovery and overall intensity, it changes the way football is played." The findings come as health, climate and sports-performance experts intensify pressure on FIFA to strengthen heat-safety measures ahead of the tournament, which will be hosted across the United States, Mexico and Canada. An open letter signed by leading international experts argues that FIFA's current heat guidelines are inadequate and warns some host cities could exceed internationally recognised high-risk thresholds for athletic competition.

When Will CM Punk Return To WWE? 7-Time World Champion Expected Back Soon After WWE Break



CM Punk has not appeared on WWE television for weeks, and fans have been trying to figure out why one of the company's biggest stars suddenly disappeared. The timing only made the questions louder. It was confirmed on Tuesday that both Hardik and Rohit Sharma had proven their fitness at the BCCI Centre of Excellence in Bengaluru and were set to be available for the three ODIs against Afghanistan. Hardik was supposed to link up with the other members of the Indian team on 11 June in Dharamsala, but fate had a twist in store. Hardik had gone through a spell of injury-driven



absence from the Indian Premier League (IPL) 2026 season for the Mumbai Indians, too. Hardik was set to feature in an ODI for India after more than a year, but the BCCI selection committee is now forced to name a replacement for him at the eleventh hour. given the balance he lends to the side with his pace bowling and lusty hits during the death overs. 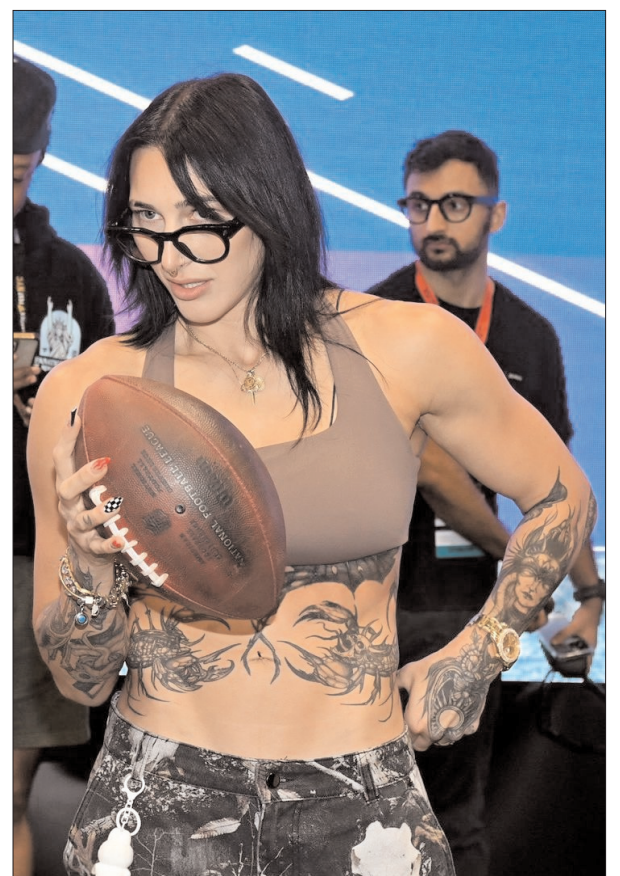


Men's Doubles Pair Of N Sriram Balaji, Miguel Angel Crashes Out Of Australia Open 2025

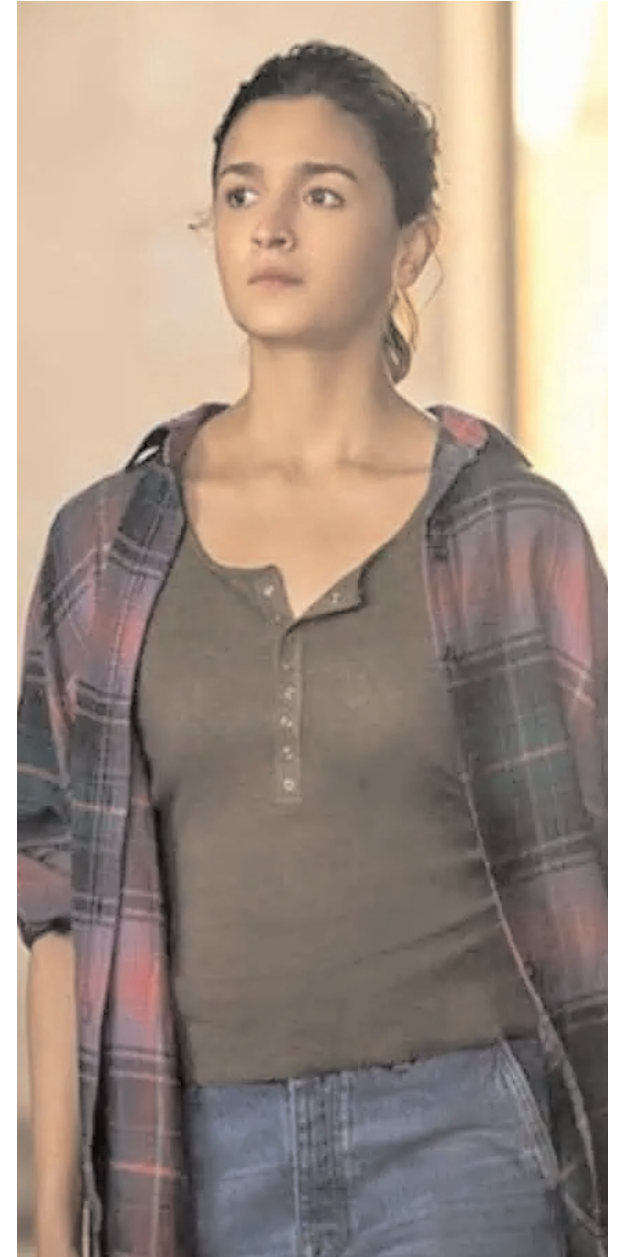
