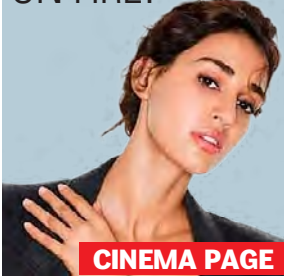

Telangana ready to fund Metro Rail Phase-II without Centre's share: CM Revanth



HYDERABAD (TSIT):

Chief Minister A. Revanth Reddy has said that the Telangana government is ready to implement the Metro Rail Phase-II project entirely with state funds, even without financial support from the Union Government, and urged the Centre to immediately issue the required No Objection Certificate (NOC).

Addressing a press conference at the Secretariat, the Chief Minister alleged that

the Union Government was creating hurdles in the expansion of the Hyderabad Metro Rail project and delaying approval for key financial arrangements, including an IRFC-backed loan.

He said the state had already taken steps to secure funding by replacing high-interest loans with a Rs.13,600 crore loan at a lower interest rate, and accused the Centre of delaying its transfer despite necessary approvals. He demanded immedi-

ate action from Union Ministers to release the funds.

Revanth Reddy stated that the state is prepared to take over Metro Rail Phase-I assets and proceed with Phase-II expansion, even if it has to bear the entire project cost. He said earlier discussions had included a 50:50 funding model, but approvals were not granted.

The Chief Minister also alleged discrimination against Telangana, claiming that Metro projects

were being cleared in other states while Hyderabad's expansion was being delayed. He stressed that the government's goal is to complete the project in the interest of Hyderabad's future growth.

He further criticised the previous BRS government for delays in Metro implementation and alleged neglect of expansion plans during its tenure, which he said led to cost escalation and operational challenges.

PM Modi welcomes US-Iran peace deal, hope it helps restore peace and stability in West Asia

BRATISLAVA (TSIT):

Prime Minister Narendra Modi on Monday welcomed the understanding reached between the US and Iran on ending the conflict in West Asia and expressed India's hope that the implementation of this understanding will help restore peace and stability in the region.

PM Modi's statement came after US President Donald Trump announced that the United States and Iran had completed a deal that would reopen the Strait of Hormuz and end the US naval blockade, marking what he described as a major breakthrough after months of conflict that rattled global energy markets and raised fears of a wider regional war. "I welcome the understanding reached between the United States and Iran on ending the conflict in West Asia, which has

caused serious economic disruption across the world and led to loss of life in many countries", PM Modi said in a post on X.

"India hopes that the implementation of this understanding will help restore peace and stability in the region and ensure the freedom of navigation and commerce. We look forward to deliberations on the remaining issues reaching a sustainable final agreement," he added.

Announcing the deal, the US President in a post on Truth Social wrote: "The Deal with the Islamic Republic of Iran is now complete. Congratulations to all! I hereby fully authorize the toll free opening of the Strait of Hormuz, and, simultaneously herewith, authorize the immediate removal of the United States Naval blockade. Ships of the World, start your engines."



DRDO conducts flight test of long-range land attack cruise missile



New Delhi, June 15: In a major boost to India's defence capabilities, the Defence Research & Development Organisation (DRDO) conducted the successful flight-test of the indigenously developed Long Range Land Attack Cruise Missile (LRLACM) on Monday. The flight test was conducted from Dr APJ Abdul Kalam Island off the coast of Odisha. "All the test objectives were fully met, as per the data captured by various tracking instruments deployed by Integrated Test Range, Chandipur," said the R&D wing of the Defence Ministry in a statement.

India-bound LNG carrier sails safely out of Hormuz



NEW DELHI (TSIT):

The Malta-flagged LNG carrier DISHA, managed by a Shipping Corporation of India-led consortium, safely transited the Strait of Hormuz on Monday with a cargo of 62,370 metric tonnes of LNG bound for Dahej in Gujarat, and is likely to reach India on June 18, according to an update issued by the Ministry of Ports, Shipping, and Waterways. The Ministry, through the Directorate General of Shipping (DG Shipping), remains in continuous coordination with the Ministry of External Affairs.

CM Naidu meets Singapore PM Lawrence Wong, discusses investment and tech cooperation

SINGAPORE (TSIT):

Andhra Pradesh Chief Minister N. Chandrababu Naidu, during his two-day visit to Singapore, met Singapore Prime Minister Lawrence Wong on Monday and held detailed discussions on strengthening bilateral cooperation in key sectors including economy, technology, education, and infrastructure.

The meeting, held at the Singapore Prime Minister's official residence for about half an hour, focused on exploring new opportunities for collaboration between Andhra Pradesh and Singapore. The Chief Minister requested Singapore's cooperation in importing horticultural



produce grown through natural farming methods and aquaculture products from Andhra Pradesh. He also informed that systems for international-standard certification and traceability of such products are being developed in the State.

Chandrababu Naidu sought Singapore's support in areas such as semiconductor manufacturing, quantum computing, artificial intelligence, and university-level research, along with skill development initiatives to build a future-ready workforce.

He also highlighted the importance of Singapore's expertise in urban governance and requested support for the development of Amaravati and other cities in Andhra Pradesh. Reports suggest that Prime Minister Lawrence Wong expressed interest in the progress of the Amaravati Capital City project and sought details on ongoing infrastructure and institutional development.

Cockroach Janta Party to stage protest in Nagpur



NAGPUR (TSIT):

The Cockroach Janta Party (CJP) will stage a protest here on Tuesday demanding resignation of Union Education Minister Dharmendra Pradhan, its founder Abhijeet Dipke announced. He would be arriving in the city on June 16. Dipke said in a video message on Social media on Monday, and asked Nagpur residents including students and the youth to gather at Samvidhan Square at 4 pm for a peaceful demonstration. The CJP has been demanding Pradhan's resignation over the last month's NEET (UG) paper leak scandal.

Cong asks PM to break silence on killing of Indian seafarers, raise issue with Trump

NEW DELHI (TSIT):

The Congress on Monday attacked the government over the killing of three Indian seafarers in American attacks on ships and demanded that Prime Minister Narendra Modi raise the issue with President Donald Trump as well as take diplomatic action to ensure the US pays a price for breaching the Geneva Conventions.

Cockroach Janta Party to stage protest in Nagpur
The opposition party strongly condemned the killing of the three Indian seafarers and questioned Prime Minister Modi's silence on the tragedy. The party accused Modi of compromising the country's sovereignty, independence and dignity by not even registering a strong protest



against such "brutal murders". Addressing a press conference here, Congress spokesperson Supriya Shrinete condoled the death of Aditya Sharma, Shivanand Chuarasiya and Patnala Suresh and expressed profound sympathies with the bereaved families.

She slammed US Secretary of State Marco Rubio's remarks while speaking with External Affairs Minister S Jaishankar as "rubbing salt into Indians' wounds".

CM Vijay announces breakfast scheme extension

CHENNAI (TSIT):

The State government would extend the Chief Minister's Breakfast Scheme to students of Classes 6 to 8 from September 17, coinciding with the birth anniversary of social reformer and Dravidian icon 'Periyar' EV Ramasamy, Chief Minister C Joseph Vijay announced on Monday. The announcement came after the chief minister chaired a meeting to review the functioning of the Social Welfare and



Women Empowerment Department and the welfare programmes implemented by the department. During the meeting at the Secretariat, officials briefed the chief minister on schemes being implemented for children, women, transgender persons, and senior citizens through the Social Welfare Department, Integrated Child Development Services, and Child Welfare and Special Services Department.

CM Reviews 99-Day Praja Palana Programme, Calls for Greater Accountability and Public Outreach

Hyderabad, TSIT BUREAU: Chief Minister A. Revanth Reddy on Monday said the State Government's Praja Palana - Pragathi Pranalika programme, implemented from March 16 to June 12, has brought the People's Government closer to citizens and strengthened grassroots governance across Telangana.

Chairing a review meeting at the Secretariat on the 99-day action plan, the Chief Minister assessed department-wise activities and outcomes. Raja Sabha MP V. Narendra Reddy, Chief Secretary K. Ramakrishna Rao, DGP C.V. Anand, CMO Principal Secretary



Sheshadri, and senior officials from various departments attended the meeting.

Chief Minister commended departments that actively participated in the programme and delivered measurable results. He reminded officials that all senior officers, from Principal Secretaries to District Collectors, were

instructed to undertake regular field visits and directed the Chief Secretary to submit a report on officials who failed to do so. He warned that disciplinary action would be initiated against officers who ignore government directives.

Expressing concern that some departments had not adequately publicized their achievements under the programme, Mr. Revanth Reddy directed officials to make better use of print, electronic, and digital media to communicate government initiatives and development works to the public.

Chief Minister instructed departments to document feedback received

from citizens and public representatives during field-level programmes and ensure that issues raised in villages are addressed promptly. He also directed officials to maintain comprehensive records of development works, foundation stones laid, and public assets created during the past three months.

In a key directive, the Chief Minister asked Panchayat Raj officials to identify villages that do not have Gram Panchayat buildings and prepare plans for the construction of new facilities. He also proposed the installation of solar power plants on all school buildings across the State.

Telangana Advocates Seek Representation in High Court Judge Appointments



Hyderabad TSIT: Telangana High Court Advocates Association has demanded due representation for eligible advocates from Telangana in the appointment of High Court judges. At an emergency general body meeting held at the Telangana High Court on Monday under the leadership of Association President S. Surender Reddy, a unanimous resolution was passed urging that judicial appointments reflect regional aspirations, social justice and fair representation. Senior advocates stated that Telangana has several talented, experienced and committed lawyers who deserve recognition and opportunity on the High Court Bench. The Association decided to submit representations to the Chief Justice of India, Supreme Court Collegium members, Union Law Minister, Telangana Governor, Chief Minister and political party presidents. Association also announced a protest programme at the Telangana High Court on June 17, demanding transparency, justice and rightful representation for Telangana advocates in judicial appointments.

Dr. Surya Sri Rao Appointed as DCHS

Yadadri Bhongir TSIT: Dr. Surya Sri Rao has been appointed as the District Coordinator of Hospital Services (DCHS). She assumed charge of the office on Monday. On the same day, she paid a courtesy call to District Collector Anurag Jayanthi and Additional Collector Bhaskara Rao, presenting them with flower bouquets. Dr. Chinna Naik, who previously served as the DCHS here, has been transferred to Ghatkesar. Speaking on the occasion, Dr. Surya Sri Rao stated that she would strive to provide improved medical services to the people of the district.



Commissioner Srijana Directs Swift Resolution of Public Grievances at Monday Prajavani

Hyderabad TSIT: Cyberabad Municipal Corporation Commissioner Srijana on Monday directed officials to ensure the prompt and time-bound disposal of public grievances received during the weekly Prajavani programme held at the Corporation Head Office.

The Commissioner personally interacted with citizens from various parts of the city, listened to their complaints, requests and suggestions, and instructed concerned department heads to take immediate action on priority. She stressed the importance of responsive and transparent governance, directing officials to address every grievance without delay and strictly in accordance with rules and regulations.

A total of 97 grievances were received during the programme and forwarded to respective departments for detailed examination and necessary action. Among them, the Town Planning Department accounted for the highest number with 77 petitions, followed by Engineering (8), Sanitation (3), Lakes (2), Revenue (2), Urban Biodiversity (2), Finance & Accounts (1), Transport (1), and Urban Community Development (1). Commissioner Srijana instructed officials to coordinate closely with field-level staff, conduct thorough reviews of each complaint, and ensure effective follow-up until resolution. She reiterated that grievance redressal remains a top priority for the Corporation and said Prajavani serves as a key platform for direct citizen-administration interaction, strengthening civic services and public trust.



No delay in resolving public complaints will be tolerated: Additional Collector Madhusudan Naik

Mahbubnagar: Additional Collector (Local Bodies) Madhusudan Naik has directed officials to ensure that all complaints received under Prajavani are resolved promptly, warning that delays in grievance redressal will not be tolerated. Addressing a public grievance programme held at the Collector meeting hall on Monday, along with Revenue Additional Collector J. L. B. Haripriya, he reviewed petitions submitted by citizens and assured that each application would be examined carefully and necessary action would be taken. Officials informed that a total of 119 petitions were received during the session.

During a subsequent review meeting with district officials, the Additional Collector expressed concern over pending applications across several departments, particularly in Revenue, MPDO offices, and other collectorate sections. He instructed officials to clear all pending cases immediately and ensure proper updating of details on the Prajavani portal.



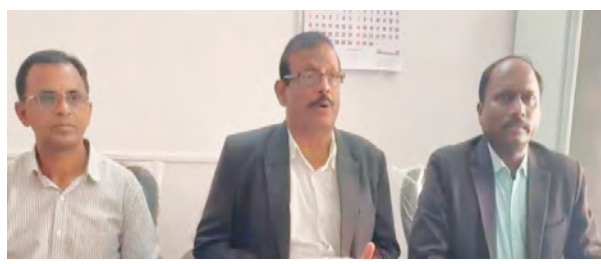

Health, BC Welfare, Banking, Rural Development, Police, SC Welfare, Gurukul Education, and Tribal Welfare.

Later, a review meeting was also held on Anganwadi strengthening and the Nasha Mukta Bharat Abhiyan. District Welfare Officer Zarina Begum informed that the "Amma Mata - Anganwadi Bata" programme is being conducted from June 13 to 19 to increase enrolment in Anganwadi centres, with support sought from ASHA workers, women's groups, and public representatives.

VC Umesh Kumar Inaugurates Physics and Computer Labs



The South India Times Husnabad, June 15 : University Vice-Chancellor Umesh Kumar visited the Satavahana University Engineering College in Husnabad, Siddipet district. He inaugurated the newly estab-

lished Chemistry, Physics, and Computer laboratories within the college building. On this occasion, VC Umesh Kumar announced that the Husnabad Engineering College has been designated as a center for TG ECET certificate verification, which is set to begin on the 17th of this month. He also stated that the TG EAPCET certificate verification center would commence at the college on the 19th. He noted that four courses—B.Tech CSE, CSE (AD), ECE, and IT—are available to students at the Husnabad University Engineering College, with a total of 240 seats (60 seats per course). He mentioned that all necessary facilities, including laboratories, have been provided for the students.

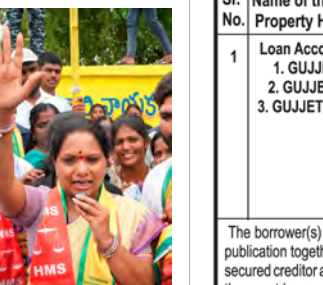

Health Minister reviews monsoon preparedness, orders vigilance against seasonal diseases

Hyderabad: With the monsoon season setting in, Health Minister Damodar Rajanarasimha conducted a high-level review meeting at the Rajiv Aarogyasri Health Care Trust office in Hyderabad to assess preparedness for seasonal diseases across Telangana.



Director of Public Health Dr. Ravinder Naik briefed the Minister on the spread of diseases such as dengue, malaria, chikungunya, diarrhoea and typhoid, along with district-wise data, hospital preparedness, availability of medicines, diagnostic kits, mosquito control measures and ongoing awareness drives.

The Minister stressed that prevention of outbreaks should be the top priority and directed officials to adopt proactive planning and continuous monitoring. He instructed all government hospitals to maintain adequate

stocks of medicines, ORS packets, diagnostic kits, platelets and emergency services, ensuring prompt testing and treatment for suspected cases.

He also called for intensified mosquito control measures in coordination with municipal and panchayat departments, and stressed strict implementation of weekly "Dry Day" programmes, along with fogging, larval control and fever surveys.

Special focus was directed towards villages, urban areas, schools, hos-

tels and construction sites, with ASHA workers and ANMs asked to conduct door-to-door awareness campaigns. The Minister further instructed inter-departmental coordination to strengthen sanitation and drinking water safety, and ordered weekly district-wise health reports and active rapid response teams.

Officials from the Medical Education and Public Health departments attended the review meeting.

District Collector Chitra Mishra congratulated the inter first year state first ranker

Commissioner Srijana Leads Extensive Monsoon Preparedness Drive in Madhapur and Serilingampally

Hyderabad, TSIT: Under the leadership of Cyberabad Municipal Corporation (CMC) Commissioner Srijana, extensive monsoon preparedness measures have been undertaken across Madhapur and Serilingampally circles to prevent waterlogging and ensure smooth rainwater drainage during the rainy season.



Following the Commissioner's directives, engineering, sanitation, and field-level teams carried out a series of preventive and corrective measures at key waterlogging-prone locations. The initiative focused on improving stormwater drainage networks, restoring nala capacities, removing obstructions, and strengthening the city's overall flood mitigation infrastructure.

In Madhapur Circle-50, officials identified five major waterlogging hotspots and implemented targeted interventions. At Vithal Rao Nagar near Durgam Cheruvu,

accumulated plastic waste and debris obstructing a box drain were removed and the inlet was widened to facilitate better water flow. Near Malkam Cheruvu, close to the Leather Institute, stormwater drains and cross-drains were thoroughly desilted to ensure uninterrupted flow of rainwater into the lake.

At Preston Prime Mall in Gachibowli, clogged gratings and obstructions in the drainage channel leading to Khajaguda Lake were cleared, restoring the system's original carrying capacity. Chief Minister Chandrababu Naidu Meets Singapore Foreign Minister Vivian Balakrishnan

Visakhapatnam (TSIT): Andhra Pradesh Chief Minister N. Chandrababu Naidu met Singapore Minister for Foreign Affairs Vivian Balakrishnan and held extensive discussions on strategic partnership opportunities between Andhra Pradesh and Singapore. During the nearly 30-minute meeting, several key issues, including state development, investments, air connectivity, green energy and the establishment of data centres, were discussed.

On the occasion, Chief Minister Chandrababu Naidu briefed the Singapore Foreign Minister on the development plans for the Amaravati Capital City Project. He stated that the Government was taking special measures to transform Amaravati into a "Quantum Valley." The Chief Minister noted that Andhra Pradesh was emerging as one of the leading states in the country in both the manufacturing and services sectors. He further explained that the State possesses vast land resources required for industrial development, while also having an abundant pool of skilled human resources to support the growth of the services sector.



Chandrababu Naidu highlighted Andhra Pradesh's growing role in the production of green energy, green ammonia and green hydrogen. The Chief Minister pointed out that the State's extensive coastline and strategically located ports offer significant advantages for cargo transportation and international trade.

He informed the Singapore Foreign Minister that the data centre ecosystem was expanding rapidly in regions such as Visakhapatnam, with undersea cable connectivity linking data services with countries across the globe.

Chandrababu Naidu also informed Vivian Balakrishnan about the proposed establishment of a major steel plant by global steel giant ArcelorMittal in North Andhra Pradesh. The two leaders further discussed the expansion of air services between Andhra Pradesh and Singapore, including the possibility of providing direct flight connectivity to various airports in the State.

State Minister P. Narayana, Shilpak Ambule, High Commissioner of India to Singapore, and other senior officials participated in the meeting.

Following the discussions, Singapore Foreign Minister Vivian Balakrishnan presented Chief Minister Chandrababu Naidu with a copy of the book titled "Fifty Secrets of Singapore's Success," which highlights the factors behind Singapore's remarkable development journey. Officials expressed the view that the meeting would further strengthen bilateral relations between Andhra Pradesh and Singapore and provide fresh momentum for future investment opportunities and development partnerships between the two sides.

Unprecedented Progress in Women, Child and Tribal Welfare Sectors in the Last Two Years: Minister Gummidi Sandhya Rani

The South India Times, Visakhapatnam : State Minister for Women Development, Child Welfare and Tribal Welfare Gummidi Sandhya Rani stated that under the leadership of Chief Minister N. Chandrababu Naidu and with the support of Deputy Chief Minister Pawan Kalyan, the State Government has accorded the highest priority to the welfare of women, children and tribal communities, implementing welfare and developmental programmes on an unprecedented scale over the past two years. The Minister said that welfare is not merely about providing financial assistance, but ensuring safety for every woman, nutritional support for every child, development opportunities for every tribal family and quality education for every student.

She stated that through 56,746 Anganwadi Centres across the State, nutritional support, healthcare services and pre-primary education are being provided to pregnant women, lactating mothers and children. Nearly 20 lakh beneficiaries are availing these ser-



vices. Strengthening the Anganwadi system, the Government has recruited 5,389 teachers and 5,287 helpers, creating employment opportunities for more than 11,000 people, she said. To improve infrastructure in Anganwadi centres, facilities such as drinking water supply, RO plants, sanitation amenities and cooking equipment have been provided with an expenditure of Rs.100 crore, the Minister explained. She further stated that the services offered through Anganwadi centres have been digitised by distributing 5G smartphones to Anganwadi staff at a cost

of Rs.72 crore. Emphasising the Government's commitment to women's safety, the Minister said that One Stop Centres have been established in all 26 districts of the State, providing legal, medical, psychological and police assistance under one roof. She revealed that 3,393 child marriages had been prevented during the last two years. In the tribal welfare sector, the Minister stated that quality education is being imparted to thousands of students through 2,715 educational institutions across the State. Necessary infrastructure, nutritious food and stationery are being pro-

vided to students residing in hostels and Ashram schools. She also noted that special measures have been initiated to control Sickle Cell Anaemia among tribal populations. The Minister further said that road development works are being undertaken in tribal areas with the objective of ending the practice of carrying patients in makeshift "dolis" due to lack of connectivity. To strengthen the economic condition of tribal farmers, the Government is promoting commercial crops such as coffee, pepper and turmeric, while facilitating TRICOR loans and marketing support to enhance their livelihoods.

Assistive Devices Distributed to Students with Special Needs Under ADIP Scheme

The South India Times, Visakhapatnam : A programme for the distribution of ALIMCO assistive devices to students with special needs was held on Monday under the joint aegis of the School Education Department and Samagra Shiksha, as part of the Government of India's ADIP Scheme. The event was conducted under the chairmanship of District Collector M. Abhishikt Kishore. On the occasion, the Collector distributed 141 assistive devices worth Rs.9,08,674 to 114 students with special needs from 11 Bhavita Centres in the district. Keeping in view the specific requirements of the students, devices such as wheelchairs, tricycles, hearing aids, walkers, crutches and rollators were provided.

Addressing the gathering, District Collector M. Abhishikt Kishore stated that the government has been continuously striving for the educational advancement, self-reliance and holistic development of students with disabilities. He advised



students and parents to make effective use of the services and facilities being provided through Samagra Shiksha. The Collector emphasised that no disability should become a barrier to the talent and progress of students. He called upon every section of society to extend support towards the growth and development of children with special needs.

Interacting with the students, he encouraged them to focus on education and further develop their skills and abilities. Speaking to parents, he urged them to ensure that the assistive devices

distributed are used regularly by their children so that they can benefit physically and mentally, thereby improving their overall quality of life. Among those present at the programme were District Additional Project Coordinator Dr. J. Chandrasekhar Rao, Superintendent of the Department for the Welfare of Persons with Disabilities Padmavathi, District Samagra Shiksha Coordinator U. Neeraja, Samagra Shiksha officials C.H. Srinivasa Rao and G. Lakshmi, special educators, parents and students.

AIIMS Mangalagiri Stands as a Testament to Healthy Andhra Pradesh Under Modi's 12 Years of Governance: Lanka Dinakar

Visakhapatnam (TSIT) Lanka Dinakar, Chairman of the Twenty Point Programme (Viksit Bharat - Swarna Andhra Pradesh), stated that significant progress has been achieved in the healthcare sector as a result of the people-centric welfare and development initiatives undertaken during the 12 years of Prime Minister Narendra Modi's leadership, and that AIIMS Mangalagiri stands as a testimony to this transformation. As part of an initiative to assess the impact of developmental programmes implemented by the Modi government, Lanka Dinakar visited AIIMS Mangalagiri on Monday. AIIMS In-charge Director and Dean (Research) Dr. Joy Ghoshal, Dean (Academic) Dr. Desu Ram Mohan, along with senior doctors and professors from various departments, briefed him on the institution's progress in providing medical services. He reviewed the advanced healthcare facilities available at the institute and interacted



with patients and their attendants to gather feedback on the quality of services being provided. Later, he conducted a review meeting on the progress of AIIMS. Speaking on the occasion, Lanka Dinakar said that under the provisions of the Andhra Pradesh Reorganisation Act, the Central Government had initiated the construction of AIIMS Mangalagiri in 2015 with an investment of Rs.1,618 crore across 183 acres. The institute, which commenced services to the public in 2019, was initially ranked last among AIIMS institutions in the

country but has now risen to the eighth position. Officials informed that AIIMS Mangalagiri provides outpatient services to an average of 4,000 patients daily with a nominal registration fee of just Rs.10. During 2025-26 alone, 9.85 lakh patients availed OP services, while a total of 35.26 lakh people have benefited from the institution since 2019. The hospital has so far performed 22,081 major surgeries and 9,238 minor surgeries, completing a total of 31,319 operations. Through its 35-bed dialysis unit, medical services have been extended to

16,586 patients. According to officials, the Department of Radiology conducts 600 to 700 X-rays and 250 to 300 ultrasound examinations every day. A total of 6,225 radiation therapy sessions have been provided to cancer patients so far. Facilities such as PET Scan, SPECT Scan and Radiotherapy units have been established at a cost of Rs.33 crore. The institution currently performs more than 80 MRI scans and over 130 CT scans daily. Through its 38 laboratories, AIIMS Mangalagiri has delivered more than 66.23 lakh diagnostic services to date, of which 21.85 lakh services

were provided during 2025-26 alone. Officials also highlighted that quality medicines are being made available to patients at affordable prices through the AMRIT Pharmacy and Jan Aushadhi Centre. Under the Ayushman Bharat programme, 3.86 lakh Health IDs have been issued. Additionally, 25.52 lakh health records have been linked, while 10.42 lakh records have been digitised, officials stated. Referring to infrastructure development, Lanka Dinakar alleged that between 2019 and 2024, the State Government had failed to provide essential facilities such as an access road and water supply required for the functioning of AIIMS. However, following the formation of the "double-engine government" in 2024, coordinated efforts by Prime Minister Narendra Modi, Chief Minister N. Chandrababu Naidu and Deputy Chief Minister Pawan Kalyan ensured the provision of the necessary infrastructure, resulting in significant improvement in the hospital's overall perfor-

Foundation Stone to be Laid for Rs.142-Crore Road Over Bridge at Mangalagiri on June 17

THE SOUTH INDIA TIMES, VISAKHAPATNAM: The foundation stone for the Road Over Bridge (ROB) proposed at Mangalagiri under the Guntur Railway Division will be laid on June 17, 2026 (Wednesday). The ROB will be constructed in place of Level Crossing No.14 at Mangalagiri. Dr. Pemmasani Chandra Sekhar, Hon'ble Union Minister of State for Rural Development and Communications, Government of India, and Shri Nara Lokesh, Hon'ble Minister for Food and Civil Supplies and Consumer Affairs, along with several public representatives and senior railway officials.



Minister, Shri Nadendra Manohar, Hon'ble Minister for Food and Civil Supplies and Consumer Affairs, along with several public representatives and senior railway officials. Level Crossing No.14, located on the Namburu-Mangalagiri main railway route in Guntur Division, is popularly known as the Mangalagiri Gate. A large number of motorists travelling between Mangalagiri and Amaravati use this route, leading to frequent traffic

congestion. To facilitate hassle-free movement for the public and to ensure uninterrupted road and rail transportation, a Road Over Bridge will be constructed at this level crossing at an estimated cost of Rs.142 crore, entirely funded by the Railway Department.

Upon completion of the ROB, both road and rail transportation are expected to become significantly smoother. The project will provide seamless connectivity to the State Capital, Amaravati. The travel dis-

tance and time between Mangalagiri and Amaravati are expected to reduce considerably, and the project is also anticipated to contribute to the region's social and economic development, railway officials said. The Road Over Bridge, which is set to become a crucial infrastructure project for the development of the State Capital Region, will not only enhance public transportation facilities but also strengthen infrastructure to meet future requirements.

established and long-experienced TDP and JD(U), who should actually be protesting their "downgrade" through such "underhand tactics" and in such a "disgusting" manner, Ramesh said. South Central Railway steps up monsoon preparedness to ensure safe train operations

How Choice of Political Successors Led to the Decline of Regional Satraps

Odd as it may sound, many regional satraps in India have bitten the dust or look like they are on the decline. All for the want of a credible successor. The latest glaring example is that of former West Bengal chief minister Mamata Banerjee, who has not only lost power in West Bengal, but her world is coming crashing down since the Bharatiya Janata Party (BJP) ousted her government last month after 15 years at the helm. Her promotion of her controversial nephew Abhishek Banerjee tore the Trinamool Congress (TMC) asunder as newly elected MLAs are abandoning the sinking ship of TMC in droves, leaving Mamata stunned. Through his brash actions and statements, Abhishek had brought an invisible split in the party with his supporters and opponents ranged against each other. Now Banerjee and the leaders still loyal to her are a beleaguered lot amid reports that Ritabrata Banerjee could emerge as the "Eknath Shinde" of Bengal. In Maharashtra, 85-year-old Sharad Pawar, once known as the Maratha strongman, is now like the legendary Bhisma lying on the battlefield strewn with arrows. His fault was choosing not the right successor, as his powerful nephew, the late Ajit Pawar, should have been the ideal candidate. However, the senior Pawar opted for his daughter Supriya Sule, who has hardly gone through the rough and tumble of politics. The result was a split in the party aided and abetted by an ambitious BJP. With Ajit Pawar's tragic death, his Nationalist Congress Party (NCP), too, is in turmoil, after senior leaders like Praful Patel and Sunil Tatkare, have been sidelined by Sunetra Pawar, who took over the party from her late husband. Reports have it that her sons, Parth and Jai, call the shots in the organisation.

It is the same sob story in the Shiv Sena led by Uddhav Thackeray, in the last four years after the BJP split the party by engineering a revolt by Eknath Shinde. The party founded by Bal Thackeray is being emaciated day by day with the rise of a resurgent BJP, which wants to further its footprint. Former Telangana CM, K. Chandrashekar Rao, who once dreamt of becoming the prime minister from a third front government, not only lost power but also failed to address the succession issue properly, resulting in squabbles in the family.

Biju Janata Dal (BJD) chief and former Odisha chief minister Naveen Patnaik, having a record of more than two decades at the helm, saw himself lose power in the last assembly polls for failing to throw up a successor. His close advisor and a controversial IAS officer from Tamil Nadu was seen as his successor, and it cooked the goose of Naveen. Almost the same applies to the late Jayalalitha, who once ruled Tamil Nadu with an iron hand. Her party has faced divisions and a split, and the advent of Tamilaga Vettri Kazhagam (TVK) in power in last month's polls has further accentuated the crisis. Former Tamil Nadu CM M.K. Stalin's Dravida Munnetra Kazhagam (DMK), which lost power, could be equally affected by the rise of TVK supremo and matinee idol Vijay, as the assembly polls virtually rejected Stalin's successor and son, Udhayanidhi Stalin. Doubts are being raised in Jammu and Kashmir over the competence and capability of chief minister Omar Abdullah, who has been anointed successor by National Conference (NC) chief Farooq Abdullah, as the son lacks the ability to take everyone along.

Hormuz Is Reopening, But It May Never Matter Quite The Same Way Again

US President Donald Trump recently announced that the US and Iran had reached a deal and that the Strait of Hormuz would be reopened soon. Coming over three months after the war started, however, many countries have by now explored alternate pathways to keep their economies running and to hedge against future disruptions.

THE INDIA-OMANI PARTNERSHIP

India has been one of the worst hit countries by this war, in particular by the closure of the Strait of Hormuz, as much of her energy imports from the Middle East transit through this critical waterway. While oil and gas are the most important, there are other major imports, like fertilizers, that also transit through Hormuz. Recently, Union Petroleum Minister Hardeep Singh Puri, revealed that India's oil marketing companies were losing Rs. 16,000 crore a day, something the recent fuel price hikes aim to address, to an extent. The rupee has fallen to a historical low to touch 95 to the dollar. Amidst these shocks, the news that the India-Omani Comprehensive Economic Partnership Agreement (CEPA) has been actualised was met with much glee. CEPA paves the way for more buoyant trade with the Oman Sultanate, especially facilitating Indian exports - a critical need for the economy currently. Most importantly, the location of Oman is significant now with all the tension around the Strait of Hormuz. Oman is located outside the Strait, directly on the Arabian Sea and the Gulf of Oman, and thus, goods can enter and exit its ports of Salalah and Duqm easily without having to go through Hormuz. Moreover, India also had a historical presence at Duqm. India's imports from Oman actually increased by 246.4%, rising from USD 430 million to nearly USD 1.5 billion, driven by higher purchases of crude oil and urea. The countries are now seeking to reactivate the proposal for the Rs.40,000-crore Oman-Gujarat deep-sea gas pipeline. The 2,000-km subsea project would bypass the Strait of Hormuz, offering a potentially safer and more direct route for natural gas imports, hedging against any similar disruptions in future.



OMAN'S SWEET SPOT

In fact, Oman is in a sweet spot now with its location outside the Strait of Hormuz as countries seek alternatives. One fifth of the world's energy supplies pass through Hormuz from countries of the Gulf like Saudi Arabia, Iraq, Kuwait, Bahrain, and the UAE to mainly Asian markets. Consequently, Oman has increased its oil exports to unprecedented levels, given that its ports are located outside Hormuz, enabling it to pump supplies to Asian markets. Beyond this, the gains from customs declarations have been remarkable. For example, revenues from declarations for shipments destined for Dubai alone jumped from \$270 million in March to \$2.16 billion in April. More important is the Sultanate's new positioning as a reliable hub for maritime and air transport and shipping through its ports and airports. For instance, food exports to Gulf countries through Hormuz have also been disrupted. Currently, shipments are travelling from Omani ports through the Hatta border crossing between Oman and the UAE and further into the wider Gulf region and markets. This will enable Oman to reap continuous benefits even after the Hormuz crisis ends. It will also attract massive investments for strategic road and railway projects linking the Gulf states to Oman, and oil and gas pipeline projects that bypass the Strait of Hormuz, like the one with

India. Oman will definitely aim to preserve the economic and geopolitical gains it achieved in the war.

THE FUJAIRAH TERMINAL

Other countries, too, are hedging. For many like the UAE, whose economy depends majorly on energy exports, it is an existential threat. The world has lost 1 billion barrels of oil due to Iran's closure of the Strait, according to Dr Sultan Al Jaber, the UAE's Minister of Industry and Advanced Technology. Therefore, the country is now accelerating the construction of the West-East oil pipeline to double its oil export capacity to 4 million barrels per day by 2027 via the port of Fujairah, which lies around 70 nautical miles outside the Strait of Hormuz. The Fujairah Oil Terminal FZC (FOT) is a premier, 1.177 million cubic meter independent onshore storage facility in the UAE, specialising in crude oil and refined products. With the disruptions in Hormuz, its strategic significance for global supply through it has increased manifold. This is just as significant for India, as the Fujairah oil terminal can still send supplies to us while also ramping up oil production. According to data, UAE oil exports to India rose to around 619,000 barrels per day in April this year, a 43% increase from previous averages.

SAUDI AND IRAQI LOOK ELSEWHERE, TOO

Saudi Arabia, OPEC's second largest oil producer has, similarly, diverted exports through its port of Yanbu on the Red Sea, via its East-West Pipeline. It consists of twin pipes that carry oil more than 1,200 km from the Abqaiq oil field in the Kingdom's Eastern Province to Yanbu. Interestingly, this pipeline, also known as Petrolina, was built in 1981 during the Iran-Iraq war as an emergency route, with the singular objective of bypassing the Strait of Hormuz to avoid any crisis there and promote energy security. That has now paid off, with the pipeline reported to be operating at full capacity. In fact, Saudi exports of jet fuel to Europe through Yanbu has actually increased after the war broke out this year. Like them, Iraq, another major oil producer, is also diversifying. As a major exporter through Hormuz, the Strait's closure has made it look elsewhere. It has begun exporting oil through Syria's Baniyas oil port, since early April. Iraqi fuel crossed through the Al-Tanf border crossing into Syrian territory, where from Baniyas on the Mediterranean coast Iraqi oil will make its way to global markets. With Syria's stabilisation and reconstruction, this route is sure to become a permanent one for at least some of Iraq's oil exports even after Hormuz reopens.

TWO UNINTENDED BENEFICIARIES

An unhappy fallout of the closure of Hormuz has been that it is essentially Asian markets that have been affected the most. These relied most on supplies through the strait, unlike, say, Israel, which together with the US began the war. While the US has benefited from oil sales, countries like India, Japan, South Korea have been vulnerable to the Hormuz crisis. They, too, have been looking for alternatives and have turned to non-traditional sources. Two such "non-traditional" sources that have become beneficiaries are Azerbaijan and Kazakhstan. On May 2, a Japan Times report noted how a tanker carrying some 45,000 kilolitres of crude oil from Azerbaijan arrived at an Eneos refinery in Yokohama, quoting officials at Eneos. The shipment of Azerbaijan oil arrived in Japan for the first time as it sought to diversify supply sources. Like India, Japan had also imported mostly Middle Eastern crude, and now has also procured US and Russian oil. This marks a major shift in its energy procurement as it diversifies its supply chains. It also stands to reason that once Hormuz reopens, Japan will no longer be totally reliant on the supplies through that route, at least not as much as pre-war levels. It has now also turned to Kazakhstan as an alternate source, which, logistically, will be cheaper for procurement than Middle-Eastern supplies. Kazakhstan has also become a beneficiary of the Hormuz crisis. The loss of Middle-Eastern oil in global markets has translated into a surge in demand for Kazakh oil, and disruption in traditional trade routes has meant greater traffic along the country's Middle Corridor or the Trans-Caspian International Transport Route, which traverses through Central Asia, the Caspian Sea, and the South Caucasus to reach Turkey, Black Sea and Mediterranean ports to Europe. Kazakhstan has ramped up supplies to European markets as well as to Japan and countries like Bangladesh. Jihad Azour, director of the International Monetary Fund (IMF)'s Middle East and Central Asia Department, recently described Central Asia as a "transit hedge", offering alternative routes for trade and energy flows amid rising geopolitical uncertainty.

Telangana: Emerging as India's Annapurna

The true measure of a state's progress lies in the welfare of its farmers. A prosperous farming community strengthens the rural economy, and a robust rural economy, in turn, accelerates overall development. Telangana's remarkable transformation in the agricultural sector stands as a testament to this enduring truth. Once known for irrigation challenges, market uncertainties and agrarian distress, the state has today emerged as one of the most significant contributors to India's food security, earning the distinction of being the nation's modern-day "Annapurna." The scale of Telangana's achievement is reflected in the numbers. During the 2025-26 financial year, the state recorded a historic procurement of 15 million tonnes of paddy. More significantly, Rs.35,537 crore was directly transferred into the bank accounts of 2.643 million farmers, ensuring that agricultural prosperity translated into tangible economic gains at the grassroots level. These figures are not merely statistics; they represent a governance model that prioritizes the farmer and recognizes agriculture as the backbone of economic growth.

For decades, farmers across India have struggled with issues ranging from delayed payments and exploitative middlemen to inadequate procurement infrastructure. Telangana has sought to address these challenges through a systematic and farmer-centric approach. The establishment of procurement centres at the village level, transparent purchasing mechanisms, and technology-driven payment systems have significantly reduced the burden on cultivators. Farmers are no longer compelled to travel long distances to market yards or wait endlessly for their dues. Payments are being credited directly to their accounts within 48 to 72 hours of procurement,



instilling confidence in the agricultural ecosystem. A major factor behind this success has been the extensive network of 8,575 paddy procurement centres established across the state. By taking procurement closer to the farmer, the government has reduced transportation costs, minimized dependence on intermediaries, and ensured that cultivators receive fair compensation for their produce. The efficiency demonstrated by the administrative machinery at the grassroots level has played a critical role in making the procurement process seamless and farmer-friendly. Under the leadership of Chief Minister Revanth Reddy, agriculture has emerged as a central pillar of public policy. The government's commitment to farmer welfare is evident in its efforts to streamline procurement, strengthen market access and ensure timely financial support. The coordinated efforts of Deputy Chief Minister Bhatti Vikramarka and Civil Supplies Minister Uttam Kumar Reddy have further reinforced the state's capacity to manage procurement, transportation, storage, milling and payments with remarkable efficiency. However, Telangana's agricultural success did not materialize overnight. It is the outcome of sustained investments in irrigation infrastructure, rural development, agricultural support systems and market reforms. The expansion of irrigation facilities, reliable power supply to the farm sector, improved rural connectivity and enhanced access to technology have collectively transformed Telangana into one of the country's leading food-producing states.

At the same time, the state



must prepare for the challenges of the future. Agricultural growth cannot rely solely on paddy cultivation. Climate variability, water sustainability concerns and changing market demands necessitate greater diversification. Encouraging farmers to cultivate pulses, oilseeds and horticultural crops can reduce dependence on water-intensive farming while enhancing income opportunities. Equally important is the expansion of agro-processing industries in rural areas, which can create value addition, generate employment and increase farmers' share in the agricultural value chain.

The infusion of thousands of crores into farmers' accounts is already generating positive ripple effects across rural Telangana. Increased purchasing power is stimulating local markets, strengthening small businesses and creating new avenues of employment. When farmers prosper, the benefits extend far beyond individual households; they strengthen the entire rural economy and contribute to broader social and economic development.

At a time when agriculture faces multiple challenges across the country, Telangana offers an instructive example of what can be achieved through effective governance and political commitment. The state's experience demonstrates that when farmers are assured of market support, timely payments and responsive administration, agricultural productivi-

ty and rural prosperity can rise simultaneously. Yet, sustaining this momentum will require a long-term vision. Enhancing storage infrastructure, promoting agricultural exports, strengthening Farmer Producer Organisations (FPOs), and encouraging value-added agricultural products must become policy priorities. Building resilience against climate change and ensuring sustainable income growth for farmers will be critical to maintaining Telangana's leadership in agriculture. The record procurement of 15 million tonnes of paddy is ultimately the result of the hard work of millions of farmers. It is also the product of a governance framework that respects their labour, values their produce and places their welfare at the centre of development policy. This combination of farmer effort and administrative commitment has positioned Telangana not merely as a state with high agricultural output, but as a crucial pillar of India's food security. A prosperous farmer is the foundation of a prosperous state. Telangana's recent achievements demonstrate that when governments place farmers at the heart of their development agenda, transformative outcomes are possible. By ensuring value for every grain produced, guaranteeing timely payments and strengthening rural livelihoods, Telangana is charting a path that other states may well seek to emulate. If this commitment continues with the same determination and foresight, Telangana will not only remain a leading contributor to the nation's food basket but also emerge as a national model for farmer welfare and agricultural governance. In giving practical meaning to the age-old belief that "the farmer is king," Telangana is steadily reinforcing its identity as the true Annapurna of India.

Setbacks Have Followed Since 2024, but INDIA Looks Ahead

All the criticism at the INDIA bloc meeting of June 8 in New Delhi was, appropriately, directed at Rahul Gandhi - and this points to his centrality to the grouping, not just to his party. This had not been evident in January 2023, at the inaugural meet of INDIA in Patna, although the senior Congress leader was then just coming off his 4,000-km long Bharat Jodo Yatra which established his credentials as the signifier of the opposition. What has brought clarity now is Gandhi's relentless ideological energy and drive, his unerring homing in to challenge the Hindutva ideology which, under Prime Minister Narendra Modi, is being sought to be made the nerve centre of the nation's political life, its new point of departure and the new narrative that permeates the country. Hindutva in the Modi scheme and domain seeks incessantly to negate the influence or even the reality of India's anti-colonial freedom struggle which defined and crowned composite Indian nationalism as modern India's leitmotif. Hindutva, in contrast, aims to make the country's religious minorities suspect, and thus to disable India emotionally, socially, materially. It is Gandhi's defining characteristic of challenging the regime's ideological edifice paired with his conceptual clarity on, and sharp intellectual analysis of, key national issues pertaining to nearly every aspect in the public sphere, which keeps his own



party going. And in turn it is the Congress which, not wholly but in large measure, binds opponents of the BJP together - no matter that they have grouses against the party based on local political grievances or circumstances or perceptions. This was revealed amply on June 6, as was the aspect that the Congress remained the fulcrum of the nation's opposition dynamics (and hence is the primary focus of regime attacks). In fact, the INDIA meeting after a hiatus of two years was called at the request of former West Bengal chief minister Mamata Banerjee in her hour of despair. It is useful to pay heed to CPI(M)'s John Brittas who pithily summed up the expectations from Congress. He pointed to something that is subtle, relevant, and catches the essence of INDIA. The Rajya Sabha MP from Kerala said that while the Congress-CPI (M) political competition in Kerala was understandable,

there would be no issue if a Congress leader from Kerala, such as K.C.Venugopal, the influential Congress general secretary, politically sought to take on the Left in the state. However, the complexion of the Congress' criticism/opposition - indeed the spirit of it - changed if it came from Rahul Gandhi (or Congress president Mallikarjuna Kharge) who, in the ideological sense, is the progenitor of INDIA. The tremendous national enthusiasm generated by Gandhi's long march, and the coalescing of anti-regime grievances from all parts of the country at the time, provided the moment - and the scaffolding - for the subsequent coming together of opposition voices, their contradictions notwithstanding. What had been brought forth in 2023 was the idea of a national coordinated opposition to the Narendra Modi government in parliament. For that reason, the criticism Brittas makes applies to all states,

although now it is only in Kerala that two INDIA constituents compete for power. For all the serious setbacks INDIA has faced in the two years since its spectacular showing in the 2024 Lok Sabha election, which reduced the Narendra Modi government to a minority in the parliament from its earlier lofty numbers, bloc leaders noted at the meet that the Congress remained the glue to hold the framework together. CPI (Marxist-Leninist) Liberation leader Dipankar Bhattacharya put it with finesse when he said that INDIA needed to move from being (just) an "idea" to becoming an "identity". The first necessary step in this direction, of course, is to work to make composite Indian nationalism prevail over religion-based ideas of pseudo-nationalism which are taking India back centuries. That triumph is a necessary condition for national advance, but not a sufficient one.

Rahul Gandhi invites students to join Congress stir starting from Kota on June 17

New Delhi, June 15 : Leader of Opposition in Lok Sabha, Rahul Gandhi, on Monday invited students preparing for competitive exams and young job seekers to support in large numbers the Congress party's "Chhatron ki Goonj" national agitation starting from Rajasthan's Kota on June 17.

Addressing students angered by paper leaks, cancelled exams and stall recruitments, Gandhi said on X, "I know you're exhausted. You're angry. But remember this - when the government refuses to listen, you have to raise your voice louder."

youth, including paper leaks, examination irregularities, unemployment, and recruitment-related concerns, party sources said. On Monday, in his message on X, Gandhi said, "Let's come together and



become a roar that can't be ignored. Starting from Kota - then reaching every corner of the country. This is a fight for your future. And I'm with you." Earlier, announcing the nationwide protest, All India Congress Committee (AICC) General Secretary (Organisation) K.C. Venugopal said, "Rahul Gandhi will address student conventions in various cities across the country. Beginning from Kota, he will engage directly with students and competitive exam aspirants."

According to Venugopal, the first phase of the campaign will continue with events in Allahabad on July 10, Patna on July 11, and Delhi on July 14.

The Congress has alleged that recurring examina-

Guarantee schemes will not be stopped, they aim at women's empowerment: CM D K Shivakumar

Bengaluru: Chief Minister D K Shivakumar has clarified that the government's guarantee schemes will continue and there is no question of discontinuing them, stating that the initiatives are designed with "love and affection" to empower women economically.

Speaking to reporters at Vydehi Hospital, the Chief Minister said the Opposition's role is to criticise the government and create hurdles whenever good initiatives are implemented. He said the government is working to ensure that welfare schemes reach only eligible beneficiaries.

He explained that in the initial stages, some errors were found in beneficiary



details, including incorrect or mismatched phone numbers, which led to funds reaching non-eligible persons. To address this, the government has decided to introduce identity cards for beneficiaries to ensure proper delivery of benefits.

Shivakumar further stated that Karnataka's guarantee schemes are meant exclusively for the state's residents and cannot be extended to people from other states. He

added that several states, including Maharashtra, Madhya Pradesh, and Andhra Pradesh, have taken inspiration from Karnataka's welfare model.

He also expressed concern over misuse of funds from schemes such as Gruha Lakshmi, alleging that some individuals are diverting benefits into fraudulent financial activities. He said strict action will be taken to prevent such misuse at all administrative levels.

On political criticism regarding land acquisition and the Bidadi project, the Chief Minister said similar large-scale land acquisitions have taken place in other states and questioned the Opposition's

Maheshwar Rao directed departments to ensure coordination among city corporations and complete pending works without delay. He also instructed officials to take up road widening works on key stretches such as Nagawara Road, Tannery Road, Dinnur Road, and Holiday Village Road before commencing white topping. He said land acquisition issues, if any, should be resolved through Transferable Development Rights (TDR).

R. Ashok urges citizens' letter campaign against garbage scam; demands scrap of Bidadi township project

Bengaluru: Leader of Opposition R. Ashok has called upon citizens, organisations, apartment associations, students, and senior citizens to launch a large-scale letter campaign to the Governor and the President of India, alleging irregularities in Bengaluru's solid waste management tender process and demanding intervention.

Addressing a press conference, he alleged that the Rs.39,437 crore solid waste management tender was a "massive scam" and claimed that serious concerns have been raised over its execution. He said he has already submitted complaints to the Lokayukta, the Governor, and a high-level inquiry committee, urging a thorough investigation into the matter.

Ashok alleged that the issue would impact Bengaluru's future for the next three decades



and said successive generations would be affected if corrective action is not taken. He further alleged that the government was pushing the project despite public concerns and called for either a Central Bureau of Investigation (CBI) probe or an independent inquiry.

He also criticised

Chief Minister D K Shivakumar over the Bidadi Township project, demanding that it be scrapped. He said the project was unnecessary given the availability of vacant sites and flats in and around Bengaluru and alleged that several earlier governments had already dropped similar propos-

als. Referring to farmer protests in Bidadi, Ashok said agricultural land should not be acquired for the township project and compared it with environmental concerns raised over other national projects, stating that development should focus on schools and hospitals instead.

On welfare schemes, he alleged that the government was attempting to revise the Gruha Lakshmi scheme and reduce beneficiaries, claiming that administrative lapses had led to irregularities. He also demanded that the guarantee scheme implementation committee be dissolved, alleging inefficiency in identifying beneficiaries. Ashok concluded by reiterating that public pressure must be built through written representations to constitutional authorities to safeguard Bengaluru's civic and environmental future.

Lanka Premier League gets multimillion-dollar boost as IPG Group announces strategic global funding

Colombo: The Lanka Premier League (LPL) has received a significant financial and structural boost ahead of its sixth season, scheduled to begin on July 10, following a major strategic funding announcement by its promoters, Innovative Production Group FZ, LLC (IPG).

The group has secured multimillion-dollar funding support from a United States-based Nasdaq-listed partner and completed a strategic all-stock merger with Flash Sports & Media, Inc., bringing its portfolio of T20 league commercial rights, including the LPL, under the Nasdaq-listed platform UGRO (NASDAQ: UGRO).

According to IPG, the move marks a major step toward strengthening governance, transparency, and global scalability of the league, positioning it within a publicly governed structure designed for long-term expansion. IPG also announced an investment commitment of USD 20 million over the next two years to enhance and expand the league's operations and commercial value. While the Lanka Premier League remains intellectual property owned by Sri Lanka Cricket, IPG continues to hold exclusive commercial and media rights, now backed by institutional capital and a structured growth

strategy. IPG Founder and Chairman Anil Mohan said the development would help scale the league responsibly, improve franchise value, and strengthen commercial discipline through better governance and access to capital. Flash Sports & Media CEO Bradley Natrass said the combined structure would enable faster execution across multiple cricket markets, including Malaysia and Zimbabwe, where IPG also holds long-term league development agreements. He added that the focus would be on stronger sponsorship integration, broadcast partnerships, and fan engagement.

Chief Financial Officer Eric Sherb noted that the public-market structure would allow phased capital deployment into league infrastructure while ensuring return-on-investment discipline and sustainable revenue generation. The partners also outlined plans to expand digital innovation, upgrade broadcast production to 4K standards, centralise sponsorship revenues, and develop a multi-market cricket enterprise spanning South Asia and emerging territories. With this development, the LPL is expected to enter a new phase of commercial growth and international expansion ahead of its upcoming season.

Udhayanidhi demands action on TN's law and order after death of alleged three-year-old rape victim

Chennai, June 15: Tamil Nadu's Leader of the Opposition Udhayanidhi Stalin on Monday urged Chief Minister C. Joseph Vijay to convene a high-level meeting of senior police officials and issue strict directions to district and regional officers to prevent what he described as the worsening law and order situation in the state. His remarks came in the wake of the death of a three-year-old girl who was allegedly sexually assaulted near Gummidipoondi in Tiruvallur district.

The incident has triggered widespread outrage and renewed concerns over the safety of women and children.

In a statement posted on social media, Udhayanidhi Stalin claimed that crimes

of this nature were once associated with certain northern parts of the country but alleged that similar incidents were now occurring with alarming frequency in Tamil Nadu.

He accused the Vijay-led government of failing to provide adequate protection to women and children despite highlighting their welfare prominently during the election campaign. The DMK leader pointed to a series of incidents that, according to him, reflected a breakdown in public safety across the state. He referred to allegations that members of the ruling party were involved in the sexual exploitation of more than 500 women in Salem, that a party functionary in Alandur had allegedly misbehaved with a widow, and



that a woman police constable in Sivaganga had allegedly been subjected to sexual assault.

Udhayanidhi Stalin alleged that although more than a month had

passed since the new government assumed office, no effective measures had been taken to strengthen law and order. He claimed the situation had deteriorated significantly and

said public confidence in the government's ability to maintain safety was being eroded.

Taking a swipe at the Chief Minister, he alleged that greater attention was

being paid to political activities than to governance and public safety. He urged Vijay to focus on restoring law and order and ensuring that women and children are protected from such crimes.

Warning of further action, Udhayanidhi said that if similar incidents continued to occur in Tamil Nadu, he would seek permission from the DMK leadership to launch a statewide protest against the government's handling of law and order. The statement adds to the growing political pressure on the government following the tragic death of the child, which has sparked strong reactions from political parties and civil society groups across the state.

Now, CMDA can directly clear high-rise projects in Chennai

CHENNAI: Doing away with the requirement of final government approval for high-rise building projects in Chennai Metropolitan Area, the State government on Monday authorised the Chennai Metropolitan Development Authority (CMDA) to directly issue planning permission.

Under the earlier system, developers submitted applications to the CMDA, which carried out field inspections and technical scrutiny before placing the proposals before the High Rise Buildings (HRB) Scrutiny Panel, which includes officials from Fire and Rescue Services, Tangedco, and TWAD Board to ensure safety and utility compliance. Based on the panel's recommendations, the proposals were then sent to the government for approval.

through a Government Order before planning permission was granted.

In the new system, which came after Chief Minister C. Joseph Vijay's direction to simplify and speed up the approval process for multi-storied buildings in Chennai, the CMDA can issue planning permission for high-rise projects on its own, based on the recommendations of the scrutiny panel.

Officials said the decision was taken to reduce delays in granting approvals and to ensure that applications are processed within a shorter timeframe. The revised procedure would help avoid delays caused by multiple stages of approval while maintaining compliance with planning norms and building regulations.

Deny permission for hydrocarbon wells in Cuddalore, DMK tells Tamil Nadu govt

CHENNAI: The Tamil Nadu government should not grant permission for the hydrocarbon wells project in the coastal Cuddalore district and take steps to immediately halt the project to safeguard the marine resources and fishermen's livelihood, the opposition DMK said on Monday.

Expressing concern over the proposed move to establish four hydrocarbon wells in the sea near Parangipettai in Cuddalore district, about 190 km from Chennai, former Finance Minister Thangam Thennarasu said that during its rule, the DMK under then Chief Minister MK Stalin took a firm decision on not allowing any hydrocarbon projects in the state in the interest of agriculture and to protect the environment.



"We advised the State Environment Impact Assessment Authority not to grant environmental clearance for the project when ONGC applied to study the hydrocarbon reserves in Ramanathapuram district, and thus stopped an attempt at the very beginning," Thennarasu

said in a post on 'X'. Similarly, the present TVK government should continue to maintain a firm stand in opposing the hydrocarbon project proposed to be constructed in the sea near Parangipettai, the legislator from Tiruchuli in Virudhunagar district, said.

Fishermen and environmentalists in the district have been opposing the proposal to drill four new offshore hydrocarbon wells off the Cuddalore coast, claiming the Rs 425 crore project would pose a serious risk to marine ecosystems, mangrove forests, and the livelihood of thousands of fishermen.

According to sources, the proposal is pending clearance as it is being examined by the Tamil Nadu Coastal Zone Management Authority. Official regulatory filing reveals that the project is being driven by the Hindustan Oil Exploration Company Limited.

The four new development wells are planned to be drilled up to 3,000 metres deep in the Bay of Bengal, about 18 km off the Parangipettai coast. Activists from the

Poovulagin Nanbargal, an environmental NGO, raised serious concerns, pointing out that the drilling site is located about 11.48 km away from the sensitive Pichavaram reserve forest containing the mangrove ecosystem and that it would endanger the biodiversity and marine life.

Speaking to reporters in Mayiladuthurai on Saturday, Anti-Methane Project Federation coordinator Professor T Jayaraman urged the state government not to grant permission for the project.

Fishermen and farmers claim that the heavy drilling and seismic surveys would permanently disrupt the marine ecosystem and destroy coastal livelihoods. Apart from the DMK, the PMK and MDMK are opposed to the project.

In massive rehaul, TN govt shifts 56 police officers

CHENNAI: The State government on Monday ordered the transfer and posting of 56 police officers with immediate effect. The reshuffle covers officers serving in the Greater Chennai Police, district police units, commissionerates, specialised wings and headquarters establishments. The changes are aimed at filling vacancies in key positions and strengthening law enforcement administration across districts and specialised units. Among the prominent postings, ES Uma, who was on compulsory wait, has been appointed Deputy Inspector General of Police (Headquarters), Greater Chennai Police (GCP). KS Balla Krishnan, Deputy Commissioner of Police (Headquarters), GCP, has been posted as the DCP of Cyber Crime Cell, GCP. S Selvaraj, DCP of Central Crime Branch-I, has been transferred as DCP, High Court Security, Chennai.

Shortage of govt gynaecologists drives 80% of deliveries to pvt hospitals in Dakshina Kannada

Mangaluru, Jun 15: A shortage of gynaecologists in government hospitals, coupled with the high concentration of medical colleges in Mangaluru, has made Dakshina Kannada one of the country's most private healthcare-dependent districts for maternity services.

According to 2025-26 data from the State Health Department, nearly 80% of the district's 28,278 institutional deliveries took place in private hospitals, almost double the national average of 41.4%. The New Indian Express reported.

Of the total institutional deliveries

recorded in the district, 22,410 occurred in private hospitals. The trend stands in stark contrast to the statewide pattern, where around 65.5% of deliveries take place in government health-care institutions. In rural Karnataka, the figure rises to nearly 70%.

Oil prices fall and shares jump after US-Iran deal announced

Oil prices have fallen and shares risen after the US and Iran said they had agreed a framework deal to end the war, which US President Donald Trump said would see the reopening of the key Strait of Hormuz shipping route. Brent crude, the global oil benchmark, dropped 4.7% to \$83.24 (\$61.94) a barrel, and shares in Asia and Europe jumped in reaction to the deal. Pakistan, which has been mediating an end to the US-Iran war, said an official signing ceremony would be held on Friday, 19 June in Switzerland. Iran's deputy foreign minister Kazem Gharibabadi confirmed in a phone call on state TV that a deal with the US had been finalised, while Trump posted on social media "let the oil flow". But Vandana Hari from energy markets analysis firm Vanda Insights said a lack of detail on what has been agreed was "likely to inject unease and uncertainty into the market". This could mean a week of uncertainty and volatility for the oil market, she added. The Strait of Hormuz has been effectively closed since shortly after the US and Israel launched airstrikes on Iran on 28 February. After the conflict began, Tehran



threatened to attack vessels using the crucial waterway, through which around 20% of the world's oil and liquefied natural gas (LNG) normally passes. Global energy markets have been on a wild ride in recent months, with prices often rising or falling sharply in response to developments in the US-Israel war with Iran. Brent crude, which was trading at around \$70 a barrel before the conflict started, peaked at about \$120 during the war. Asian stock markets surged on Monday as investors welcomed the framework deal.

Japan's Nikkei 225 share index closed 5% higher, while the Kospi in South Korea ended up 5.2%. The region was hit particularly hard by higher energy prices as it is heavily reliant on the Middle East for its oil and LNG supplies. In Europe, both Germany's Dax and France's Cac 40 indexes were up by about 1.7% and in London the FTSE 100 rose 0.6%. Energy market experts have also warned that the movement of oil through the strait is unlikely to immediately return to pre-war levels. Andrew Lipow from consult-

ing company Lipow Oil Associates said mines would first need to be cleared from the waterway, which could take from a few weeks to up to six months. He also said there is a large backlog of tankers waiting to use the waterway and that restarting oil production and getting the loading of ships back to normal levels could take weeks. Admiral Mark Montgomery, a retired US Navy rear admiral and senior fellow at the Foundation for the Defence of Democracies, told the BBC's Today programme that getting back to

normal would not be "an overnight thing". "I would say that's going to take a month or 45 days to kind of fully get till you're at a normal pumping balance, and vessels moving in and out smoothly," he said. "The market has bought time, but the reality is that inventories are a lot lower," Wirth said in an interview Friday, referring to backup sources of energy like the Strategic Petroleum Reserve. "We've moved from comfortable inventories under normal times to what would soon be uncomfortable," Wirth told Bloomberg. "I think that's the real question is, 'How much longer can these measures kind of ameliorate the risk?' At some point they may not be able to." Wirth suggested that efforts to offset even higher oil prices by dipping into strategic reserves could begin to lose their impact by July. "The evidence would say you shouldn't fully believe" any announcement of an Iran deal "until you see the agreement signed and the actions come into effect." Meanwhile, shipowners, insurers and vessel crews will need to be convinced that it is safe to pass through the Strait of Hormuz before full-scale maritime transit could resume.

Mumbai: Stock market benchmark indices Sensex and Nifty surged in early trade on Monday, June 15, mirroring a rally in global equities and a sharp decline in crude oil prices, after the US and Iran finalised a deal to end their 107-day war. The 30-share BSE Sensex jumped 1,112.70 points to 76,648.74 in early deals. The 50-share NSE Nifty surged 335.55 points to 23,956.40. The US and Iran finalised a deal to end their 107-day war and open the Strait of Hormuz, the narrow waterway used to ferry one-fifth of the global oil supplies, on Friday after an in-person signing of the agreement in Switzerland. US President Donald Trump made the announcement on Truth Social on Sunday evening, easing pressure on the global energy markets, as officials said the peace agreement would be signed on June 19 in Switzerland. From the 30-Sensex firms, InterGlobe Aviation, Eternal, Bajaj Finance, Bajaj Finserv, UltraTech Cement, and



Larsen & Toubro were among the major winners. Sun Pharma emerged as the only laggard from the blue-chip pack. Brent crude, the global oil benchmark, dropped 4.55 per cent to USD 83.36 per barrel. In Asian markets, South Korea's Kospi jumped nearly 6 per cent, while Japan's Nikkei 225 index climbed more than 5 per cent. Shanghai's SSE Composite index and Hong Kong's

Hang Seng index were also quoting higher. US markets ended in positive territory on Friday. "With the dawn of peace in West Asia, hopefully, and the consequent sharp correction in Brent crude to below USD 84 in early trade, the prospects for the Indian economy and stock market have turned for the better," V K Vijayakumar, Chief Investment Strategist, Geojit Investments

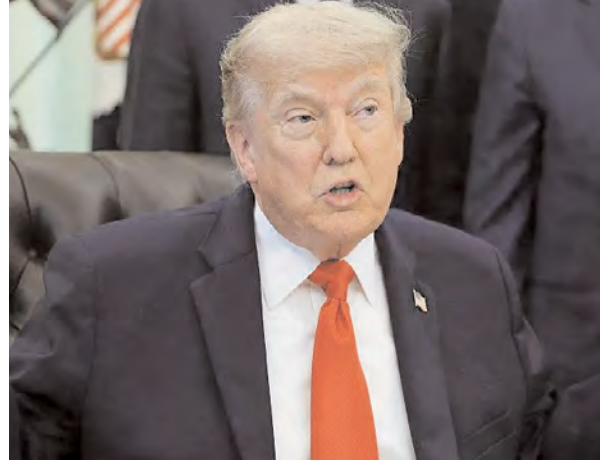

Iran and US agree deal to end war as Trump says Strait of Hormuz will be reopened

Ship-tracking data from MarineTraffic this morning shows there are more than 230 tankers and 250 cargo ships in the Gulf west of the Strait of Hormuz alongside large numbers of smaller vessels such as fishing boats and tugs. Only a minority of tracked tankers appear to be fully laden with cargo while most are empty or partially loaded. About 70% of the tankers in the data are stationary rather than moving. Many are gathered near major oil export terminals in Saudi Arabia, Iraq and the UAE. Most have remained in the Gulf over the past month. The total number of vessels in the area is likely to be higher, as many ships are not broadcasting their location and do not appear in the data. Natural gas prices in the UK have fallen by around 6% since the US-Iran deal was announced. But at around 110p per therm, they remain about 50% higher than they were before the conflict, and there is still plenty of uncertainty in the market. Qatar is normally a major producer of liquefied natural gas, or LNG. The loss of those supplies due to the closure of the Strait of Hormuz has increased competition for shipments from elsewhere, and pushed up prices in Europe. Even though the UK gets only a small part of its gas from Qatar, the knock on effect of the reduction in global supplies has been significant. If Qatari shipments resume, pressure on prices should ease. But it will take time. Getting an LNG production 'train' up and running is a complicated process that can take up to a month. Then transporting the gas to where it's needed can take several weeks. So experts say it could be six weeks from when the process begins before the new supplies become available. In the meantime Europe is working to refill its reserves in preparation for next winter, which is keeping demand relatively high. This was always a three-



party war, and Trump told the Wall Street Journal on Sunday that he was furious at Israeli Prime Minister Benjamin Netanyahu for ordering strikes on Lebanon this weekend that he believed might torpedo the almost-completed Iran deal. The deal held - at least long enough for it to be publicly announced. But if Israel begins new military operations in Lebanon, Iran could decide to close Hormuz again and again jeopardise the global economy. Energy market experts warned that moving of oil through the strait is unlikely to immediately return to pre-war levels. Clearing a large backlog of tankers, removing mines and restoring regular oil shipping and production could take weeks. At minimum, however, Sunday's deal should help alleviate, if not entirely remove, some of the economic strain from the

ongoing conflict. Far-right Israeli Finance Minister Bezalel Smotrich says the deal is "bad for Israel and for the entire free world". He says Israel "will have to continue the campaign to bring down the regime ourselves" and "ensure that Iran never acquires nuclear weapons," in a post on X, translated by the AFP news agency. "The joint [US-Israeli] campaign achieved many successes in weakening Iran, and those achievements have not been in vain," Smotrich says. Earlier, far-right Israeli National Security Minister Itamar Ben-Gvir also criticised the deal, and said: "We are not partners to this agreement that does not ensure our security, and it does not bind us in any way." Like Ben-Gvir, Smotrich has had sanctions imposed on him by the UK and other countries for "repeated incitements of violence against Palestinian communities". The front-page headline of Israel's biggest selling daily newspaper Yedioth Ahronoth this morning was "Confrontation". Not between the US and Iran, but between President Donald Trump and Prime Minister Benjamin Netanyahu. America and its strongest ally in the Middle East are not on the same page when it comes to this deal. Israel was told, not consulted. In a conversation with the New York Times last night, President Trump called Netanyahu "a very difficult guy". Under pressure in the opinion polls at home and with mid-term congressional elections coming up in November, Trump has clearly been keen to bring an end to this unpopular and costly war. But in Israel, Netanyahu has been under pressure to keep it going. He is also facing elections in a few months' time which opinion polls suggest could see an end to his time in office and increase the likelihood of him being jailed on corruption charges which he denies.

South African TV star arrested after allegedly kidnapping man in girlfriend dispute

South African TV presenter and rapper Molemo Maorohanye, also known as Jub Jub, has been arrested for allegedly kidnapping a taxi driver and shooting a gun in his direction. Maorohanye is said to have confronted the driver in Edenvale, a town roughly 25 km (16m) from Johannesburg, accusing him of forming a relationship with his girlfriend. According to the police, Maorohanye allegedly forced the unnamed man into his vehicle on Sunday and fired his gun towards him. The man escaped unharmed and immediately drove to a nearby police station, the police statement says. Maorohanye has not yet commented. The alleged confrontation took place at 07:30 local time (05:30 GMT), after the driver had dropped off a passenger. Maorohanye, who was at one time one of South Africa's most popular musicians, will appear in Germiston Magistrate's Court on Wednesday for an initial hearing, police say. It is not his first encounter with the



law - in 2012 he was convicted of murder and attempted murder after killing four schoolchildren and wounding two others while drag-racing. South Africa's high court overturned the verdicts two years later, convicting Maorohanye of manslaughter instead. In 2023, the musician was arrested on charges of rape, attempted murder and assault following allegations made by an ex-girlfriend. The National Prosecuting Authority (NPA) withdrew the charges in 2024, as there were "no reasonable prospects of a successful prosecution". Maorohanye currently presents Uyajola 9/9, a reality TV show that attempts to expose cheating partners.

UK announces sweeping social media ban for under-16s



British Prime Minister Keir Starmer said on Monday he would ban social media sites for under-16s and impose restrictions on gaming and livestreaming platforms, in some of the world's most far-reaching online restrictions to date. The sweeping changes will reflect Britain's values, helping to protect children online while pushing back against the power of big technology companies, Starmer told a press conference. "It is clear to me a full ban is the right choice," he said. "This will change the conversations that parents have and the expectations of children over time. It will make a huge difference, it will make our children safer, it will make our children happier, it will give them more time, more security, more freedom to grow up, more opportunity". As well as a ban on sites such as TikTok, Snapchat and Instagram, he said he would take action against gaming and livestreaming services

that allow children to talk to strangers. "Is there a situation in the offline world where you would just let your child pair up with a stranger, an adult that you don't know anything about? No, so we're taking action on that," Starmer said. The government already has the powers to take the first steps in any ban, he said, with regulation to follow by the end of the year and a prohibition in place around next spring. Britain has increasingly toughened its approach to tech companies in recent years, urging or forcing them to impose age verification, adapt their algorithms and, most recently, prevent children from circulating nude images taken on mobile phones. But with a growing awareness of the mental health risks posed by children spending too much time online, Starmer has decided to go further after speaking to parents and considering evidence from Australia.

A MAN WAS JAILED FOR MURDER. 15 YEARS AFTER HIS DEATH, HE WILL GET A RETRIAL

Tokyo — When a Japanese court granted Hiromu Sakahara a retrial, there was no defendant in the dock celebrating the prospect of freedom. Instead, family members gathered around his grave to share news that he had longed to hear in life after a decades-long fight for justice. Sakahara died in 2011 while serving a life sentence for murdering a store manager in the rural town of Hino in 1984 - based on a confession that he said was forced. A rare posthumous retrial is expected to begin soon, but the long delays in Sakahara's case added momentum to calls for reform to speed up the excruciatingly long process people must go through to seek redress in Japan. "I regret that we could not save



my father from prison," his son Koji Sakahara told CNN. "While I am happy about the decision to grant a retrial, it's still incredibly painful," said Koji, now 64 with hair that's turned grey during the long campaign to prove his father's innocence. Japan has a reputation for "hostage justice," a term used to describe the detention of suspects for questioning.

Norwegian crown princess's son found guilty of two counts of rape

Marius Borg Høiby, the 29-year-old son of Norway's Crown Princess Mette-Marit, has been found guilty of two counts of rape and sentenced to four years in prison. The three judges in courtroom 250 at Oslo District Court cleared him of two other counts of rape, but found him guilty of many of the other offences of which he had been accused. Høiby was not in court for the verdict for unspecified health reasons, but joined the session via video link. Prosecutors had called for Høiby to be given seven years and seven months in prison. His defence lawyers had called for a lesser term of 18 months and have said he intends to appeal. Even though Marius Borg Høiby is not himself a royal figure, the trial has cast



a shadow over the broader royal family. His mother married Crown Prince Haakon when he was four, and he grew up within the family. The palace has said it will not comment on Monday's verdict. Mette-Marit is very ill with a form of pulmonary fibrosis and has recently been placed on a

lung transplant list. Her son's lawyers have repeatedly sought his release from prison so he could spend time with his mother because of her declining health. After the verdict, Høiby's defence lawyer Petar Sekulic again asked the court for his release. Although Oslo district court initially

granted his release last week, the decision was overturned by the court of appeal. One of the three judges in the trial, Judge Jon Sverdrup Eijfstad, began the session early on Monday with a summary of their conclusions, before going into a 128-page ruling explaining the verdict. Høiby had denied all four counts of rape, but the judges convicted him of raping two women, including one on the Crown Prince's estate at Skaugum in 2018 and another involving a woman in Oslo in 2024. He was also convicted of abusing an ex-girlfriend, Norwegian influencer Nora Haukland and of causing serious bodily harm to another partner, in whose flat he was arrested in the upmarket Frogner area of Oslo in August 2024.

BRAZIL WOMAN DIES AFTER ROPE-JUMPING INSTRUCTORS FAIL TO ATTACH CORD

A woman has died in what appears to be a tragic extreme sports accident in Brazil. Three men have been arrested over the incident, in which instructors failed to attach a rope to her before helping her jump from a bridge in São Paulo state. Footage went viral over the weekend of Maria Eduarda Rodrigues de Freitas being carried to the edge of the abandoned bridge before being let go on Saturday. She fell 40m (130ft) and emergency services pronounced her dead at the scene. Police are now investigating whether the men are culpable of homicide with eventual intent - when someone does not have the direct intention



but assumes the risk of killing - local news site Globo reports. The incident happened in Ponte do Esqueleto, on the border of Limeira and Cordeirópolis, in the interior of São Paulo, Brazil. In the footage posted on social media, two men in white helmets can be seen holding

Freitas was buried the following day. Rope-jumping is an extreme sport that differs from bungee jumping. It uses low-stretch climbing ropes that convert the fall into a horizontal, pendulum swing, while bungee jumping uses an elastic rubber cord that creates a vertical, bouncing effect. The bridge, called "Skeleton Bridge" has been abandoned for years and falls under responsibility of the federal government. Brazil's Secretariat of Federal Assets (SPU) said it was "available to assist the authorities in the investigations". The City Hall of Limeira (SP) announced it would sue the federal government for failing to adequately manage the bridge.

US MUSICIAN OLIVER TREE DIES IN HELICOPTER COLLISION IN BRAZIL



The alt-pop US musician and internet personality Oliver Tree was among six people who died when the helicopter he was travelling in collided with another in Brazil. The 32-year-old had been on a world tour when the crash occurred over Rio de Janeiro on Sunday. One of the helicopters then fell onto the car park of a dealership, setting around 20 vehicles ablaze. Footage published by Brazilian media shows one of the helicopters dropping from the sky, as well as flames and thick smoke rising from the crash site. Authorities say an investigation into the cause of the collision is now under way. The Military Fire Department of the State of Rio de Janeiro said it was called to the crash site around 09:00 local time (12:00 GMT). Argentine content creator Gaspar Prim Diaz - also known as Gaspi -

was also believed to have been in one of the helicopters, according to the Associated Press. The other passengers on the helicopter's manifest were Lucas Brito Chaves, Lucas Vignale and pilot Alexandre Souza. The crew manifest for the second aircraft lists only the pilot, Charles Marsillac. Tree - born Oliver Tree Nickell in Santa Cruz, California in 1993 - first rose to fame in 2016 after going viral on social media. With his distinctive bowl haircut, he was known for hits including Life Goes On, Miss You and Alien Boy. Tree had just begun a world tour, with his most recent show in São Paulo, Brazil on 6 June. He was next scheduled to perform in Lisbon, in Portugal, on 1 July and had been due to play dates in Glasgow, Manchester and London in September.

China detains two leaders of influential underground church



An influential Protestant church in China has said two of its leaders were detained after more than dozens of congregants, including children, were rounded up for interrogation. They were midway through Sunday service in the south-western city of Jiangyou, when armed police officers stormed the room they were in. Early Rain Covenant said in a statement on Monday. Founded in 2008 in Chengdu city, the church has long been on the

Chinese Communist Party's radar given how religion is tightly controlled in the region. Founding pastor Wang Yi was detained in a raid in December 2018 and is serving a nine-year jail term for "inciting subversion of state power" and "illegal business operations". The grounds for detaining two of its leaders, Yan Hong and Wu Wuqing, on Sunday are still unclear, the church said in its statement posted on Telegram.



GAETHJE WINS AT TRUMP'S UFC WHITE HOUSE SHOW

Justin Gaethje provided the perfect ending for American fans at the White House as he shocked Ilia Topuria to win the UFC undisputed lightweight title. American Gaethje, 37, shrugged off his underdog tag as he stopped Topuria at the end of the fourth round to become undisputed champion for the first time. Gaethje hurt Topuria multiple times in a brutal contest as the Georgian-Spaniard retired on his stool before the fifth round for the first defeat of his 18-fight career. The one-of-a-kind show, billed as UFC Freedom 250, took place on US President Donald Trump's 80th birthday as part of celebrations to mark 250 years of American independence. After securing victory, which UFC commentator Joe Rogan called "one of the biggest upsets in the history of the sport", Gaethje did his signature backflip from the top of the cage before shaking hands



with Trump. In a rousing post-fight interview, Gaethje compared his underdog status to Americans who once fought for their country's independence. "I'm from America, 250 years ago we were way bigger than 6-1 dogs, and look at us thriving now," said Gaethje. "To all the current, former and future military service members, thank you so

much." In the co-main event, Ciry! Gane ended Alex Pereira's hopes of becoming the UFC's first three-division champion with a second-round stoppage in their interim heavyweight title fight. The White House has hosted recreational sports and events before, but the event on the South Lawn marked the first professional live sporting show to take

place on the grounds. There were worries in the build-up that thunderstorms in Washington DC could cause delays, and although rain postponed the start of the event by around half an hour, it ran smoothly from there. The show opened with President Trump and beaming UFC president Dana White walking through the

Balcony overlooking the octagon, before a rendition of the national anthem took place while US Air Force jets cruised overhead. About 4,300 people watched the event on the South Lawn, most of whom were members of the US military, who chanted "USA" in support of the American fighters on the card. Trump watched the event octagon-side alongside White, while the United States Marine Band serenaded fighters during their walkouts, which started from inside the White House. Gaethje started his walkout in the Oval Office, where he took a moment to soak in the occasion, before walking past portraits of previous US presidents. Topuria, who is a former champion at featherweight before he moved up to claim the lightweight belt, struggled to impose the power he has shown in previous bouts as Gaethje traded shots in the first round.

Neeraj Chopra To Return To Action At Doha Diamond League

Fit-again Indian javelin throw superstar Neeraj Chopra will return to competitive action at the Doha Diamond League on June 19. The 28-year-old has been recuperating from a back injury which has prevented him from competing so far in the season. "First throw of 2026 lands in Doha! Neeraj Chopra returns to competitive action on June 19," his management firm Vel Sports announced on Instagram. Chopra is a late addition to the event as his name was not in the list announced by the organisers on June 12. In May last year, the two-time Olympic medallist India had breached the coveted 90m mark at the same venue. He had recorded 90.23m to finish second behind Julian Weber (91.06m) of Germany. Chopra was on Sunday named in India's athletics squad for the upcoming Commonwealth Games, subject to achiev-



ing the Athletics Federation of India's (AFI) qualifying standard of 82.61m. The Doha Diamond League was to be originally held on May 8 as the season-opening event but was postponed due to the ongoing West Asia conflict.

'Snicko' In FIFA World Cup 2026? Cricket Technology Makes Stunning Debut In Sweden vs Tunisia Clash

Sweden started their FIFA World Cup 2026 on the perfect note with a 5-1 win over Tunisia at the Stadio Monterrey on Monday. Yasin Ayari scored twice while Viktor Gyokeres, Mattias Svanberg and Alexander Isak scored one each to guide Sweden to a commendable victory. While the performance by Sweden was enough to grab headlines, what left fans buzzing was the use of 'Snicko' technology when it came to Svanberg's goal. It took just 18 seconds for the Swedish footballer to find the back of the net after coming on as a substitute as he latched onto a Yasin Ayari set-piece. However, the goal was denied by the assistant referee who ruled



it to be offside - a decision that left the Swedish dugout fuming as they argued that the ball touched Isak before falling to Svanberg. In order to check the deflection, the officials used a ball contact technology which is extremely similar to the 'Snicko' used in cricket. The ball showed a clear spike when it came close to Isak

and as a result, the goal was allowed. Tunisia head coach Sabri Lamouchi called the team's FIFA World Cup 2026 opener loss against Sweden "difficult" and "painful". His team suffered a 1-5 loss to Sweden on Sunday (Local Time) as only Omar Rekik was able to find the net. Tunisia endured a difficult outing,

with several costly mistakes proving decisive. Goalkeeper Mouhib Chamakh was responsible for Sweden's opening goal in the 18th minute after misjudging a long clearance, while captain Ellyes Skhiri committed an error that led directly to Viktor Gyokeres's strike in the 59th minute. In the match, Sweden's Yasin Ayari opened and completed the scoring, and substitute Mattias Svanberg also scored a goal. It was Alexander Isak and Gyokeres who consistently troubled Tunisia's back line throughout the match. For Tunisia, Rekik was the only name on the scoresheet. Speaking at the post-match press conference.

Wheelchair-Bound Japan Fan Collects Trash After FIFA World Cup Match, Wins Internet

Japan began their FIFA World Cup 2026 campaign with a thrilling 2-2 draw against the Netherlands in a Group F clash on Sunday. Netherlands captain Virgil van Dijk opened the scoring with a powerful header in the 51st minute, but Japan quickly responded through Keito Nakamura. Crysenio Summerville later restored the Dutch lead with a brilliant curled finish just after the hour mark. However, Japan had the final say as Daichi Kamada scored a dramatic last-minute equaliser to seal the draw. Amid the on-field excitement, a heartwarming gesture by Japanese fans won widespread praise. After the match, they stayed back to clean up the litter in the sta-



dium, a tradition they have consistently followed across venues. The moment became even more special at the Dallas stadium when a differently-abled fan joined in. In a video that went viral on social media, a wheelchair-bound Japanese supporter

was seen picking up trash in the stands, with others stepping in to assist him. The touching act quickly captured attention online and left fans deeply impressed. In another video shared by FIFA, a Japanese fan explained the reason behind

this practice. "It's about showing respect - to the players, the supporters, and even the stadium. We are honoured to be here, so we don't want to leave a mess behind," the fan said. Talking about the match, Japan and the Netherlands are missing key players through injury, but on paper this was still one of the more attractive fixtures in the group stage. Both have been touted as dark horses capable of going far at the tournament - the Dutch have been runners-up three times whereas Japan have never gone beyond the last 16. "We are not completely satisfied with the draw," said Japan coach Hajime Moriyasu, whose side face Tunisia on Saturday in a competitive-looking Group F.

Real Madrid Confirm Marc Cucurella Signing From Chelsea On Six-Year Deal



Real Madrid announced the signing of Spanish defender Marc Cucurella from Chelsea on Monday, for a fee reported to be 55 million euros (\$63.8 million). "Real Madrid and Chelsea have reached an agreement for the transfer of the player Marc Cucurella, who will join our club for the next six seasons, until June 30, 2032," said Los Blancos in a statement. The 27-year-old left-back joined Chelsea from Brighton in 2022 after coming through La Liga champions Barcelona's academy and moving to Getafe. Cucurella is at the World Cup with Spain, and becomes the only Real Madrid player in Luis de la Fuente's squad. Real Madrid president

Florentino Perez was re-elected earlier in June, following two seasons without winning a major trophy and appointed Jose Mourinho as coach this week. Los Blancos are set to sign Liverpool defender Ibrahima Konate at the end of his contract at Anfield and have been linked with Bernardo Silva and Inter Milan's Denzel Dumfries. Chelsea finished 10th in the Premier League last season in a disappointing campaign, with Cucurella critical of the decision to sack Enzo Maresca in January. Cucurella had two years left on his deal at Stamford Bridge, where he won the Club World Cup and UEFA Conference League in 2025.

World Cup "Less Joyful" For Iran As Team Lands In US For World Cup 2026 Match

Iran's coach Amir Ghalenoei said on Sunday political tensions and visa issues have damaged his side's preparations for the World Cup but insisted his players will not "pay attention to any of the hype." Iran have arrived at the tournament under the shadow of a bitter diplomatic row, after the United States - in military conflict with Iran for months - refused to issue visas for some team support staff. They play their opener against New Zealand in Los Angeles on Monday, marking the first time that a World Cup host has hosted a country with which it is at war. Protests are planned outside the stadium by members of the Iranian diaspora opposed to the nation's hardline regime, and there have been threats



that the Iran team could walk off the pitch if anti-government banners are displayed. "We are here to perform a good match, a high-quality match. We don't pay attention to any of the hype and anything that goes on around us," Ghalenoei said in a press conference in response to a question from AFP. "Naturally, all teams have their own problems, and in

many countries, many things happen that have nothing to do with football." The coach said his team are simply at the World Cup to "represent the respectful people of Iran, be it the Iranians inside Iran or the Iranian diaspora." "We are not political people... football is separate from politics," said Ghalenoei. The press conference took place barely an hour after a peace

deal between the US and Iran was announced, bringing an "immediate and permanent" end to military operations on all fronts. Controversy surrounding the Iran team has drawn headlines but is far from the only political issue affecting the World Cup that the US is co-hosting with Mexico and Canada. Somali referee Omar Artan was denied entry to the US for the World Cup, as have been many fans. "It's not just Iran that has been impacted, as you know," said star striker Mehdi Taremi. "Others, including a referee, have been impacted." He said the tension surrounding the tournament "undermines that joy and it undermines the message of FIFA or people, which is about football that brings about peace."

India off-spinner Shreyanka Patil has revealed that she struggled with depression and even considered quitting cricket during a challenging injury layoff that kept her out of action for more than a year. The off-spinner, who delivered an economical spell in India's 64-run victory over Pakistan in the Women's T20 World Cup on Sunday, credited her strong support system for helping her navigate the difficult period and make a successful return to the national side. Shreyanka spent nearly 14 months on the sidelines after a fractured finger sustained

during an Asia Cup match against Pakistan in July 2024. Her injury woes continued with severe shin issues in both legs and a fractured left thumb, before she finally returned to action for Royal Challengers Bengaluru in the WPL earlier this year. "I'd be lying if I said I wasn't depressed or that I didn't think about giving up cricket. That's how I felt initially during the injury phase. But there was a voice inside me saying, 'No matter what, I love playing this sport. I'm here only because I love playing it,' Shreyanka told JioStar.
