**Indians among
13 killed in Qatar gas
plant explosion**

DOHA (TSIT): Indians were among 13 workers killed and 66 others injured in an explosion at a gas facility in Qatar's Ras Laffan Industrial City, authorities said on Monday. Qatar's Energy Minister Saad Sherida al-Kaabi announced the casualties at a press conference in Doha, describing the incident as an accident. Al-Kaabi said the explosion and subsequent fire occurred at around 10:30 pm on Sunday at the Barzan local gas supply facility. He said there was no indication that the incident was the result of sabotage or any hostile activity.

CM Revanth seeks Centre's support for Adilabad airport

NEW DELHI (TSIT):

Telangana Chief Minister A. Revanth Reddy met Defence Minister Rajnath Singh in New Delhi on Monday and requested cooperation for the large-scale establishment of cargo, MRO, and hangar facilities, alongside the Indian Air Force airport and the Civil Aviation terminal building at Adilabad.

Highlighting that Adilabad is an ideal location for world-renowned airlines to set up their hangars, particularly in light of recent developments in the Middle East, Revanth Reddy requested the development of the airport, keeping these requirements in mind.

According to the Chief Minister's Office (CMO), he pledged the state government's cooperation for the development and major expansion of the upcoming Indian Air Force airport at Adilabad.

The Chief Minister assured the Defence Minister of the state government's full cooperation regarding the develop-



ment of the Adilabad airport, a high-priority project. He assured cooperation, specifically with

regard to land acquisition and the shifting of utilities. He conveyed to the Union Minister that the

state government would extend all possible support, given the project's significance to national

integrity and defence.

Civil Aviation Minister K. Ram Mohan Naidu had announced in April that an airport for defence will be built at Adilabad, and have an enclave for civil operations.

While the defence already has an airstrip with 360 acres in Adilabad, the Civil Aviation Ministry has asked the state government to acquire another 450 acres for building the airport. The proposed airport will be a major facility with a runway capable of handling Airbus A320 aircraft.

The Chief Minister also requested the Defence Minister to expedite the sanction of a key DRDO/DRDL project at the site selected near Devarakadra in Mahabubnagar district.

He also expressed his gratitude to Rajnath Singh for the transfer of Defence Ministry lands for the Gandhi Sarovar project. The Centre last week granted permission to the state government to undertake work on its flagship Gandhi Sarovar Project on the defence land at Babu Ghat, Hyderabad.

18 killed in Lucknow fire

PM Modi, CM Yogi announce ex gratia for victims



LUCKNOW (TSIT):

At least 18 people, mostly aged between 20 and 24 years, were killed in a devastating fire that broke out in a three-storey commercial building in Aliganj's Purania area of Lucknow on Monday. The building housed a coaching centre, gaming zone and other establishments.

The fire erupted in the afternoon at the coaching centre and quickly spread through the structure, filling it with thick smoke and triggering panic among students and visitors. With exits blocked, several people rushed to windows and rooftops, while some jumped from upper floors to escape, suffering serious injuries. Fire brigade personnel, police and district administration teams rushed to the spot and launched

rescue operations. Rescue workers even drilled through a wall to create an emergency escape route for those trapped inside. Senior officials, including the District Magistrate and Police Commissioner, supervised relief efforts.

Chief Minister Yogi Adityanath cut short his visit to Aligarh and returned to Lucknow to review the situation and meet the injured. He announced Rs.5 lakh compensation for the families of the deceased and Rs.50,000 for the injured. Prime Minister Narendra Modi expressed grief and announced Rs.2 lakh ex gratia from the PMNRF for the families of the deceased and Rs.50,000 for the injured. Authorities have launched an investigation into the cause of the fire.

US Trade Deal Delayed Over 50% Tariff: Goyal



NEW DELHI (TSIT)

The trade deal with the United States (US) is taking a little longer to sign due to the 50 per cent tariff imposed on goods from the country, said union Minister for Commerce and Industry Piyush Goyal on Monday. While speaking at a media conclave, Goyal said,

"India aims to gain preferential access through the trade pact with the US." US Trade Representative Jamieson Greer and Piyush Goyal are set to hold two-day talks on the first phase of the bilateral trade agreement. The US delegation visited India from June 1 to 4 to finalize the details of the interim trade agreement and take forward negotiations under the broader Bilateral Trade Agreement (BTA). The visit was aimed at finalizing the details of the interim agreement and advancing negotiations under the broader BTA across multiple areas such as market access, non-tariff measures, customs and trade facilitation.

UK PM Keir Starmer announces resignation

LONDON (TSIT):

Keir Starmer on Monday announced that he is stepping down as the British Prime Minister and leader of the governing Labour Party. Making a statement outside 10 Downing Street, Starmer said that he will however remain in post as Prime Minister until a new Labour leader is chosen in the coming weeks. "The question my party is asking now is whether I am best placed to lead us into the next general election."



OPERATION TIGER COMPLETE

As six Uddhav Sena MPs join Shinde camp

MUMBAI (TSIT):

In a major political upheaval in Maharashtra, the Eknath Shinde-led Shiv Sena on Monday executed "Operation Tiger," engineering a split within Uddhav Thackeray's Shiv Sena (UBT). Six Lok Sabha Members of Parliament (MPs) from the UBT faction have formally joined the Shinde camp.

The six rebel MPs include Omprakash Bhupalsinh alias Omraje Nimbalkar (Dharashiv/Osmanabad), Nagesh Bapurao Patil Ashtikar (Hingoli), Sanjay Haribhau Jadhav (Parbhani), Sanjay Uttamrao Deshmukh (Yavatmal-Washim), Bhausaheb Rajaram Wakchaure (Shirdi) and Sanjay Dina Patil (Mumbai North East). This development reduces Shiv Sena UBT's strength in the Lok Sabha from nine to three,



while the Shinde faction's tally rises from seven to thirteen. The remaining loyalists with Uddhav Thackeray are Arvind Sawant (Mumbai South), Anil Desai (Mumbai South Central) and Rajabhau Waje (Nashik).

The cracks became evident when six of the nine UBT MPs skipped a crucial parliamentary party meeting in Delhi. Speculation turned into reality as the rebel MPs sent a formal letter to Lok Sabha Speaker Om Birla, requesting recog-

nitition as a separate group. By banding together as six, they bypassed the anti-defection law, which requires a minimum two-thirds majority to split without disqualification. Nagesh Ashtikar and Omraje Nimbalkar admitted that sitting in the Opposition for two years deprived their constituencies of development funds. They noted that the Rs 5 crore MPLAD scheme was restrictive and surviving without state-backed funding was crippling their

grassroots influence. Ashtikar said via Facebook Live that he held no personal malice toward Uddhav Thackeray but criticised the "harsh, abusive language" and lack of trust displayed by senior leaders like Sanjay Raut after they skipped the Delhi meeting. Omraje Nimbalkar's defection followed a sessions court acquitting the accused in the murder of his father, Pawanraje Nimbalkar. He said Deputy Chief Minister Eknath

Shinde and Chief Minister Devendra Fadnavis facilitated a conversation with Union Home Minister Amit Shah, assuring him that the CBI would appeal the verdict on merit. Uddhav Thackeray has launched a statewide outreach campaign to contain the damage, starting from the rebels' constituencies in Yavatmal, Washim and Hingoli. He accused the defectors of "selling themselves after increasing their value post-election."

Resolve PGRS petitions with a human-centric approach: CM Naidu

Andhra Pradesh Chief Minister N. Chandrababu Naidu directed officials to address all public grievances, including PGRS petitions, with a humane and citizen-centric approach. He issued the instructions while reviewing the performance of various departments from the RTGS Centre at the State Secretariat on Monday.

The Chief Minister emphasized that employees and officials should develop soft skills and focus on resolving complaints by placing themselves in the position of the petitioners. Courteous interaction with citizens would help build public confidence in governance, he said.

He also stressed the importance of field visits to understand ground realities and make informed decisions. Mr.



Naidu urged officials to remain vigilant against misinformation campaigns and attempts to create social divisions. He noted that several old criminal cases were being successfully traced and solved, sending a strong message that offenders cannot escape punishment indefinitely. The Chief Minister further directed departments to expedite the establishment of a Quantum Park and a

Semiconductor Park in the state. He called for greater focus on environmental sustainability, including increasing green cover, ensuring water security, conserving groundwater resources, and preventing river pollution. The review meeting was attended by Chief Secretary Sai Prasad, Director General of Police Harish Kumar Gupta, and senior officials from various departments.

CM Shivakumar accepts Kumaraswamy challenge on Bidadi project debate

BENGALURU (TSIT):

Karnataka Deputy Chief Minister D.K. Shivakumar has invited Union Minister H. D. Kumaraswamy for a detailed discussion on the controversial Bidadi Township Project near Bengaluru. In a letter sent on Monday, Shivakumar asked Kumaraswamy and five members of his team to attend a meeting at Vidhana Soudha on June 26 at 11 a.m.

The invitation comes in response to Kumaraswamy's challenge for a public debate on



the township project, which has triggered political controversy over the acquisition of agricultural land and alleged opposition from local farmers.

Earlier, Kumaraswamy claimed that farmers were against the project and challenged Shivakumar to publicly discuss the issue.

He pointed out that women and senior citizens had been protesting against the project for more than 450 days. The Union Minister also alleged that the project would not benefit the public and announced plans to challenge it legally, stating that a legal team would soon move court with relevant documents.

While acknowledging that the township proposal originated during his tenure as Chief Minister, Kumaraswamy maintained that it never moved beyond the preliminary stage.

Vance says Iran agrees to IAEA inspections



BURGENSTOCK (TSIT):

US Vice President JD Vance said on Monday that Iran has agreed to allow inspectors from the International Atomic Energy Agency (IAEA) back into the country, describing the move as a major breakthrough in negotiations aimed at permanently ending Tehran's nuclear

weapons programme and reducing tensions across the Middle East. After a fresh round of talks in Burgenstock, Vance told reporters that the development was among the most significant achievements of negotiations involving the United States, Iran and regional partners.

"The Iranians have agreed to invite IAEA inspectors back into their country," Vance asserted. "That is a major milestone for the American people, and the first step in permanently denuclearising or permanently ending a nuclear weapons programme in Iran."

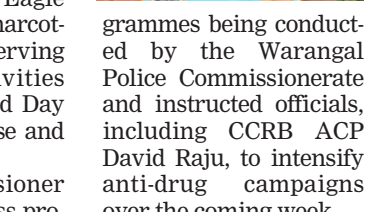

Uttam Reviews RDS Modernisation Vows to Protect Telangana's Water Rights



Hyderabad, TSIT: Irrigation Minister N. Uttam Kumar Reddy on Monday directed officials to expedite the modernisation of the Rajolibanda Diversion Scheme (RDS) and accelerate Phase-II works of the Tummilli Lift Irrigation Scheme to strengthen irrigation facilities in the region.

Chairing a high-level review meeting at the State Secretariat, the Minister examined issues related to

RDS infrastructure, Tungbhadra Dam operations, interstate water-sharing arrangements and irrigation requirements of farmers in the erstwhile Mahabubnagar district. Senior officials, irrigation experts and farmer representatives participated in the meeting.

Farmer leaders, led by former RDS Chairman G. Sitarami Reddy, highlighted the deteriorating condition

of RDS headworks, unauthorized diversions by neighbouring states, siltation in the Tungbhadra reservoir and delays in modernization works. They urged the government to take urgent measures to protect Telangana's rightful share of river waters.

Uttam Kumar Reddy directed officials to prepare a comprehensive roadmap for completing pending modernization works, strengthening canal embankments and improving water-use efficiency. He also instructed authorities to prioritize land acquisition for the proposed Mallammakunta, Julakal and Vallur reservoirs under Tummilli Lift Irrigation Scheme Phase-II and ensure fair compensation to affected farmers.

DGP C.V. Anand launches Anti-Drug Awareness Week in Telangana

HYDERABAD TSIT: Telangana Director General of Police C.V. Anand launched the Anti-Drug Awareness Week at the Hyderabad Police Command and Control Centre in Banjara Hills on Monday, calling for collective action to protect youth from drug abuse.

The week-long campaign will be conducted from June 22 to 26 across the state, covering schools, colleges, government departments, and community organizations ahead of the International Day Against Drug Abuse and Illicit Trafficking on June 26.



DGP Anand said drug addiction has emerged as a major social challenge affecting both urban and rural families. He stressed that reducing demand for drugs is a shared responsibility of society and warned that addiction destroys health, families, and social structures.

He urged the establishment of Anti-Drug Safety Clubs in educational institutions and emphasized early identification and rehabilitation of addicts through de-addiction centres. He also advised parents to closely monitor behavioural changes in children.

Congress Holds BLA Meeting in Warangal West Focus on Strengthening Booth-Level Organisation

Hanamkonda TSIT: A Congress BLA (Booth Level Agent) meeting was held in Warangal West constituency with the objective of strengthening the party's grassroots structure, expanding membership, and ensuring effective implementation of party programmes. Meeting was attended by TPCC President and MLC and AICC Telangana In-charge as chief guests. Public representatives, district leaders, Block Congress Committee members, booth-level leaders, and party workers participated in large numbers.



Addressing the gathering, Mahesh Kumar Goud said he shares a special bond with Warangal and stressed the importance of strengthening the party from the booth level. He expressed concern over what he described as attempts to weaken democratic values and the voting rights of citizens.

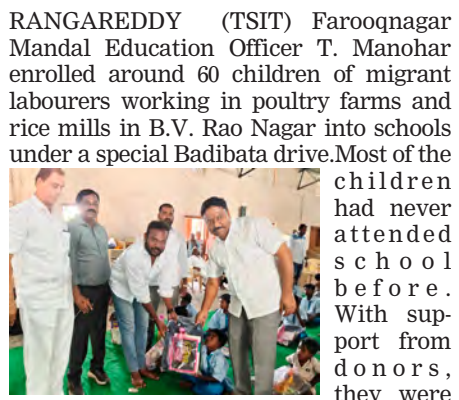

Rare disorder surgery restores child's growth hopes

Hyderabad, June 22: Doctors at Medicover Woman & Child Hospitals successfully performed a complex laparoscopic splenectomy on a seven-year-old boy suffering from a rare medical condition that had severely affected his growth and overall health.

Master Yashwanth from Kothur was diagnosed with Extra Hepatic Portal Vein Obstruction (EHPVO), severe portal hypertension, massive splenomegaly, hypersplenism and severe anaemia. Due to the prolonged illness, the child's physical development was significantly delayed, making him appear much younger than his actual age. Medical examinations revealed that Yashwanth had an enlarged spleen measuring 17 cm, a critically low hemoglobin level of 6 g/dL and a markedly reduced white blood cell count. Doctors said these



complications were affecting his immunity, nutrition and growth. The surgery was particularly challenging because the enlarged spleen occupied most of the abdominal cavity and was surrounded by extensive collateral blood vessels, increasing the risk of bleeding. Despite these difficulties, the surgical team successfully completed the procedure using minimally invasive laparoscopic techniques without converting to open surgery.

Dr. Kishore Reddy, Liver Transplant Surgeon, described the operation as one of the most technically demanding pediatric splenectomy cases. Senior Paediatric Surgeon Dr. Madhumohan Reddy said the child's growth retardation was a major concern and expressed confidence that his growth and overall development would improve significantly after surgery. The child is recovering well under medical supervision, and doctors expect substantial improvement in his health, immunity and physical growth in the coming months.

WHY GEN X MUST POLICE AUTHENTICITY IN THE AGE OF AI

In the bazaars of Mughal India, the muhtasib walked the lanes each morning with a unique authority. He carried no sword but only a set of weights and a practised eye. His tasks were unglamorous such as to check that the trader's scale was honest, that the ghee remained free of any added fat, that the silk sold as Banarasi was genuine, rather than cheaper cloth dressed up in a better story. He was, in effect, the guarantor of trust in a marketplace where the buyer could rarely verify the seller's claim alone. Civilisations have always needed someone whose job is to notice when something has been quietly substituted for something else. I think of the muhtasib often now, watching my own generation try to find its place in a marketplace flooded with artificial intelligence. The bazaar before optimisation Gen X built its instincts in a market that had yet to be engineered. We grew up before the feed was curated, before the search result was personalised, before recommendation became a science. Trust then was earned the slow way, through repetition, through reputation, through a neighbour's word. That apprenticeship in unmediated trust is, oddly, the asset AI finds hardest to replicate or erode in us. We remember what it costs to fake it, because we watched people try and fail at it long before software made faking effortless. Fluency mistaken for judgement. The generation entering workplaces today is dazzlingly fluent with these tools. They work faster, are less intimidated, and feel unburdened by our scepticism. That said, fluency and judgement are different inheritances entirely. Those who have never known an unoptimised world tend to mistake an answer that sounds confident for an answer that is correct. AI, like the cleverest trader in the bazaar, is built to please the customer first and serve the truth second. Without a muhtasib's eye, you will buy the cloth at the price of silk. The discipline of doubt What Gen X carries is calibration, more than nostalgia. We came of age watching technology overpromise and quietly fail. We encountered systems that misled, tools that broke exactly when they were needed, claims that crumbled on contact with reality. That history bred a habit of verification that is now, unexpectedly, a competitive advantage. Doubt, applied with craft rather than cynicism, is the only adulteration test that still works on a machine built to sound certain. Taste resists automation AI has already swallowed the blank page as also the throat-clearing first draft every brand used to pay weeks for. That is a liberation disguised as loss. It frees the marketer for the part of the craft that was always human in the form of curation, restraint, the editing out of ninety per cent of what is merely fluent so that the ten per cent that is true can be heard. Taste is a slower, more deliberate refusal. It is the opposite of a faster output. Bad is detected by everyone. It's the "good enough" that passes through and ruins standards. That's the advantage of being older in a manic, young world That's also the X, Y and Z of it.

India's Quality Testing Rule Puts Nepal's Tea Industry on the Brink

Around six dozen tea industries in eastern Nepal are at risk of closure because India has implemented a Standard Operating Procedure (SOP) that makes quality testing for tea exported from Nepal mandatory. Tea entrepreneurs argue that the time needed to meet these new requirements has significantly raised business risks. Although India introduced the new testing system on May 1, the issue gained wider attention a few days after Rabi Lamichhane, chairperson of the ruling Rastriya Swatantra Party and Foreign Minister Shishir Khanal visited India. It has led to questions being raised about the much-publicised "breakthrough" in bilateral relations the visit was expected to bring in. Bilateral trade is not a matter of merely calculating profits and losses; it is also an essential requirement to maintain continuity in relations between two nations. Every country has its own trade laws and regulations, which should help both sides manage potential challenges and disadvantages. However, not all difficulties can be addressed solely by policies and rules - practical considerations must also be taken into account. The crisis created by the India's SOP reflects the need for such practicality. Industry stakeholders in Nepal cite the two-week time for test reports as an impracticable risk to their business since sales are not permitted during this period. And if samples fail, the tea must be destroyed or returned. Globally, relations between countries are increasingly shaped by geo-economics, economic partnerships and trade rather than by ideology, philosophy, politics or geopolitics alone. National security remains a top priority in mutual relations, followed closely by physical infrastructure and connectivity. Over and above these,



economic growth, investment and employment opportunities, trade and commerce, supply chains, monetary policy and value chains play a key role in shaping the foundation and future direction of international relations. India and Nepal are not only friendly neighboring countries but major trading partners. India accounts for about 65% of Nepal's foreign trade. It is the principal trading partner in terms of both imports and exports. Nepal's geography, surrounded by India on three sides and sharing a difficult mountainous border with its northern neighbour, has made its trade relationship with India particularly intensive. Though China is Nepal's second-largest trading partner in terms of imports, its export potential towards China are limited. Thus, a distant-sky neighbour, the United States, has remained our second-largest export market. Nepal's relationship with India is naturally close,

shaped by geographical accessibility, ease of movement, shared cultural and civilisational heritage and strong people-to-people connections. This reality makes Nepal's trade relationship with India unique. For decades, Nepal has maintained a stable exchange rate with India, which has ensured both monetary stability and trade predictability. While exchange rate adjustments are sometimes discussed, businesses, investors and consumers in both countries understand the uncertainty such changes could introduce. In this sense, the fixed exchange rate system serves as an advantage for Nepal's economy rather than a constraint. Challenges come with opportunities. Indeed, deep and extensive relationships often bring challenges along with opportunities. Greater closeness can also create new complexities. For this reason, bilater-

al agreements, understandings, laws and established practices need regular review and continuous improvement. Problems in trade processes do not necessarily reflect strained relations but may simply indicate a lack of readiness for smooth and efficient facilitation. This reality should be understood in the context of Nepal-India economic relations. The open border between both countries also strengthens daily economic engagement, continuing a centuries-old economic and trade ties. Both sides should work to further modernise, upgrade and adapt this relationship to contemporary needs while improving ease of cooperation. Based on my long experience working with the Federation of Nepalese Chambers of Commerce and Industry (FNCCI), as well as its studies and findings over time, I believe both governments should focus on six key areas to facilitate trade more effectively.

Infrastructure at border points

Physical infrastructure along the Nepal-India border is inadequately developed and yet to be modernised. While the open border and bilateral agreements facilitate cross border movement, there is a growing need to develop roads and bridges that accommodate freight, large lorries and trucks.

As a landlocked country, Nepal has been granted access to the Indian ports of Kolkata, Haldia, and Visakhapatnam. However, there is still no dedicated railway link from these ports up to the border. This lack of dedicated connectivity increases transportation costs due to additional charges. Efforts to extend Indian freight rail services up to Nepal's dry ports have also not been fully effective so far. In this context, the proposed Raxaul-Kathmandu railway, if realised, could be a game

changer for cargo transportation.

Slow customs processes

The integrated check posts (ICPs) between the two countries should be managed scientifically. Currently, even vehicles waiting in queue for customs clearance are required to pay parking fees. Delays in customs procedures increase costs, which in turn affect market prices. Therefore, customs clearance processes need to be made simpler and more efficient. Taxes such as GST at checkpoints should be removed. Considering the Indian government's decision not to impose GST on exports to Nepal and Bhutan, its effective implementation should be ensured. Customs clearance offices should operate 24 hours to avoid detention problems. If freight vehicles wait for long hours at the border, it increases transportation costs. Moreover, vehicle charges should not be imposed on empty trucks returning after unloading goods on either side of the border. Security arrangements in customs areas, control of cross-border crimes, prevention of harassment of travellers on either side and control of illegal cross-border trade are equally important. The nearly 1,800-kilometer-long Nepal-India border has weak administrative control on both sides. It is not possible to establish checkpoints or customs offices at every point along such a long border. Therefore, joint patrolling, CCTV surveillance and other technological monitoring systems should be made more effective. Given the growing trade and interaction in border areas, it is necessary to strengthen the capacity of small customs offices and develop customs infrastructure. Recently, the Government of Nepal significantly reduced the number of small customs offices.

THE STORY OF SHWETA AND A FAILING SYSTEM

Shweta (name changed) was all of 14 years when she was raped by Rahul (name changed), a 17-year-old boy from her neighbourhood. The incident came to light after Shweta's mother discovered she was pregnant. After the FIR was recorded, Rahul, since he was a child in conflict with law (CCL), was produced before the Juvenile Justice Board (JJB) and immediately granted bail. The offence was categorised as a serious offence and a trial in summons would commence. But what ensued for Shweta was a painful ordeal - she had to undergo a medical termination of pregnancy, miss school and face grave humiliation in the locality. Rahul, having returned to the same neighbourhood, harasses Shweta and her family daily. He, his family and friends abuse Shweta when she is on her way to school or the public washroom. On one occasion, they went to her house and attacked them with sticks. The police merely filed an NC and let them go. With the help of her Support Person, Shweta approached the JJB for help. Then came the shock: the JJB has no space for child victims. Child victims and their families experience the JJB process as opaque, intimidating and deeply insensitive. While the JJ Act speaks extensively about rehabilitation and procedural safeguards for the CCL, it says remarkably little about the dignity, participation and protection of the



child victim appearing before the same board. The contrast with proceedings under the Protection of Children from Sexual Offences (POCSO) Act is striking. POCSO jurisprudence has evolved around the principle that a child survivor should not suffer secondary victimisation through the justice process. Child-friendly procedures, support persons, separate waiting spaces and protection from direct confrontation with the accused are central features of the legislation. These safeguards often disappear when the case is before the JJB. Many child victims describe arriving at the JJB only to find themselves waiting in crowded corridors alongside the CCL and his family members. There are no separate waiting areas or trauma-informed arrangements to prevent unnecessary confrontation. A child who has

survived sexual abuse has to relive that trauma while waiting outside the courtroom. Inside the courtroom the experience is even more frightening and basic provisions of POCSO are not followed. Proceedings are not conducted in camera. Defence lawyers are often accompanied by several junior lawyers when the evidence of the child victim is being recorded. The child victim is already in an uncomfortable position, having to recount the instance of sexual abuse in an unfamiliar environment - the presence of many unnecessary people creates an intimidating and uncomfortable environment for them. Often, the board does not allow the person whom the child trusts, or even the Support Person, to be with them while they are recording their evidence. The child victim is forced to face the CCL and his family directly while giving evi-

dence, as there is no separation in the courtroom. The JJB does not conduct the deposition in the chamber or use screening arrangements to shield the child victim. In addition, one finds the board granting leeway to defence lawyers, allowing them to question the child victim in an aggressive manner. The victim is intimidated as the questions are not explained to them. When the defence lawyer asks inappropriate, often character-assassinating questions, the board does not object and the child is forced to answer. In many instances, defence advocates snigger and pass insensitive comments, which creates a hostile atmosphere and affects the child emotionally. The Board frequently calls victims for recording of evidence and then adjourns the matter on frivolous grounds. When adjournments are granted, no costs are imposed.

Ending Child Marriage by Breaking the Intergenerational Cycle of Exploitation

In discussing children's and women's rights, it's difficult not to recognise that they aren't isolated principles but rather interwoven components within a larger and interconnected framework. Child and women exploitation mostly operate as a bouquet of rights infringements rather than a single and isolated issue. This blend of exploitation begins early, often from childhood, and continues into adulthood. Their effects continue to ripple across generations. Poverty and lack of access aside, gender discrimination and restrictive societal norms play equally crucial roles in driving these cycles, leaving communities entrenched in a spiral of marginalisation. Poverty exacerbates child marriages and dowry practices. In impoverished communities, girls tend to be married off at an early age to alleviate financial burdens from the reeling families. Child marriage is both a symptom and a cause of continued poverty. Once married, a young girl is unlikely to receive further education or vocational training. This further limits her capacity to contribute economically to households where only one earning member, mostly the husband, supports the entire family. As a result, the economic pressures are significant and increase as the family grows. Moreover, this single-earning structure is precarious. If any misfortune, such as an illness, disability, or job loss, befalls the breadwinner, the family's financial stability crumbles.



Women are predominantly relegated to domestic roles, which makes it challenging for them to step into the workforce without skills, education, or experience. This makes them and, by extension, their families more vulnerable to destitution. Consequently, women end up being seen as "economic burdens," and reinforcing a vicious cycle where they are married off before attaining majority, only to continue a life marked by dependence and poverty. An Unbreakable Cycle of Gender Discrimination And Child Marriages Child marriages also have unbearable consequences for women's physical and mental well-being. A young girl forced into child marriage is thrust into responsibilities of adulthood prematurely, often without being adequately prepared to shoulder them. Further, with restricted access to education, her ability to assert autonomy, make informed decisions, and participate in society is greatly curtailed under the addition-

al responsibilities that she is now expected to bear. This lack of personal agency continues a cycle of subjugation and solidifies her "inferior" status within the family and society at large. Deprived of education and isolated from opportunities for self-exploitation, a married girl child then grows into adulthood with limited life skills and resources. Likewise, the demand for dowry is another driving factor for child marriage. Families, hoping to reduce their economic burden, may marry off girls early after securing a dowry to be given to the prospective groom. The notion that daughters are liabilities and objects of economic exchange rather than individuals with rights and potential finds fertile ground to flourish. In turn, this devaluation of girls drives parents to marry them off early, creating a vicious cycle that is difficult to break. Intergenerational Cycles of Exploitation And Poverty When a child is married off, the consequences

are not limited to the immediate family. They permeate subsequent generations as we discussed. A woman who is married off as a child is more likely not to have the education and agency needed to advocate for her children's rights or prevent similar exploitation of them. In these situations, her children are also likely to experience poverty, limited educational opportunities, and child marriages. A daughter born to a mother who was married young may face the same fate, thus deepening the repeated effects of limited opportunities that are inherited across generations. For girls, in particular, this restricted access to resources leads to a decreased likelihood of escaping the poverty trap. At the same time, it makes child marriage a natural and viable outcome for families seeking financial relief. How Societal Norms Perpetuate Exploitation Societal expectations further compound this intergenerational cycle of exploitation.

SC closes plea on withheld CBSE result after Centre issues fresh policy for Gulf-based private students

New Delhi, June 22 : The Supreme Court on Monday disposed of a plea filed by a CBSE Class 12 private candidate from Saudi Arabia after the Centre informed it that a fresh national policy had been notified to address the concerns of students affected by the cancellation of CBSE examinations in West Asian countries due to war-related tensions and security concerns prevailing in the region.

A bench of Justices S.V.N. Bhatti and Vipul M. Pancholi took on record the policy notified on June 21 and the statement made by Solicitor General (SG) Tushar Mehta that the petition-



er's result had already been declared and communicated to him.

The matter arose out of a petition filed by Pransu Jigarkumar Patel, a CBSE Class 12 Improvement Examination candidate from Al Jubail in Saudi Arabia, who had approached the top court seeking the declaration of his result after it was withheld despite a spe-

cial assessment scheme framed for students affected by examination cancellations in West Asian countries. During the hearing, SG Mehta, appearing for the Union government, informed the Justice Bhatti-led Bench that CBSE examinations had been cancelled across seven Gulf countries, affecting two categories of students -- regular

school candidates and private candidates.

The Centre's second-highest law officer submitted that while regular students could be assessed under the existing evaluation framework based on school records, private candidates faced a distinct difficulty as they had no school to provide internal assessment data, such as quarterly, half-yearly and pre-board examination marks, which formed the basis of the assessment scheme issued on March 27.

To address this gap, the Centre framed a separate formula for private candidates under the newly notified policy.

According to the policy, for subjects in which examinations were cancelled, marks would be calculated by assigning 40 per cent weightage to theory marks obtained in the Class 10 Board examination, and 60 per cent weightage to theory marks secured in the Class 12 Board examination. SG Mehta further informed the Supreme Court that the petitioner's result, computed under the new formula, reflected marks higher than his earlier performance. He added that the result had been communicated to the student through email and would also be updated on DigiLocker.

Anand Kumar alleges fund misuse in Ayodhya

Bengaluru : Alleging that funds donated by crores of devotees from across the country for the construction of the Ram Mandir in Ayodhya are being misused, Dr. Anand Kumar, National Coordinator of the AICC SC Department and Maharashtra In-charge, has criticized the BJP, stating that the party is "looting the donation money collected in Lord Ram's name after coming to power."

He said that although the sentiments of countless devotees across the country have been hurt, Prime Minister Narendra Modi, Union Home Minister Amit Shah, and the BJP's national leadership have remained silent. "Is this silence a sign of consent?" he questioned. He further alleged that if similar irregularities had occurred at a place



of worship belonging to another religion, BJP leaders would have "created nationwide unrest." To him, the BJP came to power promising Ram Rajya (the ideal rule of Lord Ram), but has instead established a "state of plunder." He accused the party of using religion as a political

tool and claimed that, like the East India Company, it is exploiting the country. He also alleged that there has been neither transparency nor accountability in the management of temple funds, thereby betraying public trust. In a statement, Dr. Anand Kumar said that the concerns raised by ordinary citizens regarding the utilization of the Ram Mandir funds and the related financial accounts have not yet received any response. He asserted that those allegedly "missing Lord Ram's name" should face strict action. He questioned why the BJP was not taking steps to protect religion, adding that "for them, Lord Ram is not a deity but a shield for vote-bank politics." He further alleged that religion, devotion, and faith have all become mere slogans.

Kumaraswamy targets CM over Bidadi township



Bengaluru : Union Minister for Heavy Industries and Steel, H.D. Kumaraswamy, launched a sharp counter-attack against Chief Minister D.K. Shivakumar, urging him to revisit the statements he himself made on the floor of the Assembly in 2007 regarding the Bidadi Township project.

Issuing a challenge to the Chief Minister, who has recently claimed that those agitating against the project for the last 500 days are not genuine farmers, Kumaraswamy said: "Come to the protest site at Byramangala. You will then know whether those sitting there are real farmers or fake farmers. I am ready to come. Are you prepared to come to Byramangala?"

The Union Minister alleged that leaders who are today spearheading efforts to acquire fertile agricultural land from innocent farmers in pursuit of real estate interests had themselves vehemently opposed the very same Bidadi Township project inside the Assembly. He said the present Chief Minister was among the foremost critics of the project then, but now appears determined to implement it at any cost to facilitate real estate activities. Kumaraswamy pointed

ed out that Chief Minister D.K. Shivakumar, former Chief Minister Siddaramaiah, Leader of Opposition Mallikarjun Kharge and several other Congress leaders had strongly opposed the project in 2007. "Those who thundered against the project then are today speaking in its favour. This is a glaring contradiction. More importantly, Mallikarjun Kharge and Siddaramaiah are maintaining silence despite witnessing the irregularities allegedly being committed by the present Chief Minister," he charged.

He clarified that it was indeed his government that had conceptualised the development of five satellite townships, including Bidadi, with the objective of easing pressure on Bengaluru. A decision regarding the township project was taken on 23 September 2009, while a government notification had been issued on 18 October 2006.

"People say that H.D. Kumaraswamy was the architect of the Bidadi Township. I do not deny it. But I never conceived the project to dispossess farmers of their lands and hand them over to real estate interests."

Aneeshwar Gautam leads Hubli Tigers to victory

Mysuru : Captain Aneeshwar Gautam produced a composed unbeaten half-century as Hubli Tigers registered a comprehensive seven-wicket victory over defending champions Mysore Warriors in the DACSS Maharaja Trophy KSCA T20 tournament at the Srikantadatta Narasimha Raja Wadiyar Ground here on Monday.

After their opening fixture against Coastal Kings Mangaluru was washed out, the Tigers made an emphatic statement in their first completed game

of the season. Chasing a modest target of 162, they remained in control throughout the innings and comfortably reached 162/3 with 15 balls to spare.

The chase got off to a shaky start when Preethesh Ingle was dismissed off just the second ball of the innings, caught by Lavish Kaushal without a run on board. However, Mohammad Taha and Mayank Agarwal quickly steadied the innings, taking the attack to the Mysuru bowlers.

Taha was particularly severe on anything short or wide,

punishing the bowlers with an array of attacking strokes. Mysuru captain Vyshak Vijaykumar endured a difficult outing, conceding 47 runs from his four overs.

Taha and Agarwal added 49 runs in just 4.3 overs for the second wicket to steer the chase.

Agarwal departed for a brisk 19 off 11 balls, including three boundaries, but Taha continued his aggressive approach. He brought up his half-century off just 31 deliveries with a towering six over mid-wicket that sailed out

of the stadium. Taha's entertaining innings of 57 from 38 balls, featuring five fours and three sixes, laid the perfect platform before he was dismissed with 41 runs still required. Gautam then anchored the chase with a captain's knock, finishing unbeaten on 60 off 41 deliveries, striking two fours and four sixes.

Abhinav Manohar provided the finishing touches with an unbeaten 16 as Hubli Tigers sealed a convincing victory.

Earlier, Mysuru Warriors failed to capitalise after making a

promising start. Contributions from L R Chethan (18), S U Karthik (35), Ritesh Bhatkal (46) and K P Karthikeya (27) gave the innings momentum, but none converted their starts into a substantial score.

Having reached 99/2 in the 11th over, the defending champions suffered a dramatic collapse, losing their remaining eight wickets for just 62 runs. The lower order failed to offer any resistance as the Warriors were bowled out for 161 in 19.2 overs.

Kumar starred with the ball, claiming three wickets apiece to trigger the collapse and set up Hubli Tigers' comfortable chase.

Kumaraswamy alleges 'quota system' for cabinet berths

Bengaluru, June 22: Union Minister H. D. Kumaraswamy on Sunday made serious allegations regarding the proposed expansion of the Karnataka Cabinet, claiming that ministerial positions are being allocated through a "management quota" and "payment quota" system. Speaking to the media in Bengaluru, Kumaraswamy alleged that intense lobbying is underway among aspirants seeking berths in the state cabinet led by Chief Minister D. K. Shivakumar. He claimed that money was allegedly being collected from legislators aspiring to become ministers. According to Kumaraswamy, there were reports that funds were being sought from MLAs on the pretext of forwarding them to the party high command.

Commission Politics and Students' Hardships Caused by Congress Government: Opposition Leader R. Ashok

Bengaluru : Opposition Leader in the Legislative Assembly R. Ashok alleged that ever since the Congress government came to power, commission-driven politics has taken precedence over development in the state, and that several suspicions have now arisen even regarding the Adani projects. Speaking to reporters in Padmanabhanagar, he said that people have begun to suspect that the Congress government, which announces schemes worth crores in the name of the poor, is actually running the administration only to collect commissions.

Yesterday, due to the Congress party's event organised at Palace Grounds, heavy traffic congestion occurred in the city, causing thousands of NEET exam candidates and



their parents to face severe difficulties. This problem could have been avoided if the programme had been postponed by two or three hours. However, for Congress leaders, political propaganda was more important than the future of students. Prime Minister Narendra Modi shows such concern for students that he even changes his own programme schedule for

their benefit. But yesterday once again proved that the Congress government and its leaders have no sensitivity towards students, he said.

In the programme held in the presence of Congress National President Mallikarjun Kharge, he was not given due respect. Amid slogans of "DK, DK" from the stage, Kharge was not

even given full opportunity to speak. Ashok questioned how those who cannot show respect to their own party's national president can show any respect to the people of the state.

Regarding the cross-voting that took place in the Rajya Sabha election, he said that he would go to Delhi along with BJP State President B.Y. Vijayendra, meet the party's national president and provide complete information. A probe committee has already been constituted by the party, and appropriate action will be taken once the committee submits its report. Claims are being heard that those who indulged in cross-voting did so in the name of development. However, it is not possible to justify horse-trading by calling it development.

Manohar challenges Vijayendra over corruption claims



Bengaluru: KPC General Secretary S. Manohar has challenged to Vijayendra to swear in the presence of Dharmasthala that there was no corruption during Former CM B.S. Yediyurappa rule, and give clarity the people of the state.

In a press release, he said that the left-wing and corrupt politics you followed is destroying your own party's ideology today. Therefore, he demanded that the BJP and JDS party leaders apologize to the people of the state, and resign from their posts and stay away from public life. BJP state president B.Y. Vijayendra and leader of the opposition R. Ashok are trying to pollute Dharmasthala for political purposes, which is a disservice to Dharmasthala. Earlier, B.S. Yediyurappa and H.D. Kumaraswamy also lost power because they raised the issue of oath, he said. The statements being made by both the BJP and JDS parties regarding cross-voting in the Legislative Council elections highlight the lack of leadership. There has already been internal discontent against the BJP leadership, and now it has become clear that there is discontent among BJP MLAs about R. Ashok's actions and words. It has been proven once again that H.D. Kumaraswamy and Nikhil Kumaraswamy have complete control over the JDS party. JDS MLAs are also dissatisfied with their leadership, and it is clear that they voted against their policies and principles, he said. R. Ashok said that while BJP and JDS MLAs have voted conscientiously, he should remember that in 2019 what kind of "operation" has been conducted when he took several Congress and JDS MLAs to Maharashtra.

Take Action to Prevent Sewage Water from Entering Uttarahalli Lake: K N Ramesh

Bengaluru (TSIT): K. N. Ramesh, Commissioner of the Bengaluru South City Corporation, visited Uttarahalli Lake within the corporation's jurisdiction today and conducted a comprehensive inspection of the lake.

During the inspection, local leaders informed the Commissioner that stormwater drain (Rajakaluve) water and sewage water are mixing and entering Uttarahalli Lake, causing the lake water to become polluted and emit a foul odor. To prevent this, they requested the Commissioner to urgently repair the damaged retaining wall, ensure that sewage water flows through pipes to the Sewage Treatment Plant (STP), and that the treated water is directed through pipes into the stormwater drain outside the lake.

Maintain Cleanliness of

Lake Water
Until the complete DPR (Detailed Project Report) for the lake development work is prepared, the Commissioner instructed officials to clear the weeds in the lake to avoid inconvenience to local residents and to use bio-purification solutions to prevent foul odors from the polluted lake. He also directed officials to undertake desilting of the stormwater drain and to completely remove the blockade built across the canal to allow the smooth flow of water.

Instruction to Restart Suspended STP Work
Noting that the STP work in the lake area had been suspended, the Commissioner instructed BWSB officials to replace the small-diameter pipe with a larger-diameter pipe to ensure sewage water flows directly to the treat-



ment plant. He also directed them to restart the Sewage Treatment Plant and take measures to prevent sewage water from mixing with the stormwater drain.

Take Measures to Prevent Sewage Water from Entering the Lake:

During the lake inspection, it was observed that sewage water had mixed with stormwater drain water and entered the lake. The Commissioner instructed

corporation officials to take action by building a barrier to ensure that only stormwater flows into the lake after the lake water is cleaned, and to prevent sewage water from merging into the lake water.

Instruction to Issue Notices to CA Site Encroachers

Observing that sheds had been illegally erected and a nursery was being run on the CA (Civic Amenity) sites

located in front of Uttarahalli Lake, the Commissioner instructed officials to immediately conduct a survey of the CA land, issue notices to the encroachers, and clear the encroachment.

Instruction to Clear Encroachment at Poornaprajna Layout Park

Following complaints from locals that the park space in Poornaprajna Layout had been encroached upon and illegal activities were taking place in this area, he instructed officials to immediately install wire fencing around the park space. Executive Engineers Rajanna and Smt. Rekha, Senior Director of Horticulture Channegowda, and BWSB officials, along with corporation officials, were present on the occasion.

TN Assembly: LoP Udayanidhi Stalin questions governance, raises issues over anthem protocol, power cuts, welfare

CHENNAI: Tamil Nadu Assembly witnessed a sharp political exchange on Monday as Leader of Opposition and DMK leader Udayanidhi Stalin raised questions over governance, welfare schemes, power supply and administrative priorities, alongside a heated discussion on protocol related to the Tamil and National Anthem. TN Assembly: No mocking of fellow legislators in House, warns Speaker Prabhakar



Udayanidhi Stalin said the Opposition was "disappointed" as no new announcements or welfare schemes were expected for the people.

"We were waiting whether any new schemes and good things for people in the past 40 days, but we are disappointed," he said in the Assembly.

A key flashpoint in the House emerged over the singing of the Tamil Thai Vazhthu and the National Anthem at the start and end of the session. Udayanidhi Stalin objected to the repetition of the National Anthem, questioning the protocol. "As we appealed and asked, you made the Tamil Anthem be

sung first, which is right. But why is the National Anthem sung twice is what we ask," he said. Responding to the objection, Tamil Nadu Assembly Speaker JCD Prabhakar said he did not find any issue in singing the National Anthem. "I don't know what is wrong with singing the National Anthem. We made the Tamil Anthem sung first. If the Tamil Anthem is sung next, then it can be questioned," he said, adding that Assembly proceedings were being conducted as per established rules.

After this, Tamil Nadu

Minister Aadhav Arjun said, "For the last two to three years, the Tamil Anthem has not been sung properly before the Governor. We had to make hard compromises. There is no compromise that has happened." Responding to this, Udayanidhi Stalin said, "I appreciate the singing of the Tamil Anthem. If the National Anthem is sung two times, then the Tamil Anthem should have been sung three times." Meanwhile, the Speaker said, "According to this Assembly, due respect is being given, and the Assembly proceedings are

being conducted as per the rules laid down by the Speaker and as per established procedures." Furthermore, raising governance issues, Udayanidhi Stalin criticised the administration over power supply disruptions, alleging worsening conditions in the state. "Within one month, we cannot change the state," he said, adding that there was a "new habit of sticking labels on schemes brought by us and claiming them as first-time initiatives."

He also raised concerns over the proposed privatisation of sanitation work and demanded clarification from the Chief Minister during his address.

On welfare schemes, he appreciated the government for continuing certain initiatives, including the expansion of the morning breakfast scheme up to Class 8. He also thanked the government for the correct implementation of women's financial assistance schemes. However, he questioned reports of discontinuation of the "Naan Mudhalvan" skill development scheme, stating that thousands of students had benefited from it.

Farmers need complete loan waiver like Maharashtra, says PMK MLA Sowmiya Anbumani

CHENNAI: Pattali Makkal Katchi (PMK) MLA Sowmiya Anbumani on Monday called for a complete waiver of agricultural loans in Tamil Nadu, citing the financial hardships faced by farmers and rising farmer suicides.



Participating in the debate on the Governor's Address in the Assembly, she also thanked the state government for announcing a caste-based census and pressed for stronger action against crimes targeting women and children. MLA Sowmiya Anbumani extended her birthday greetings to the Chief Minister and expressed her gratitude to PMK founder S Ramadoss and party president Anbumani Ramadoss.

Access to clean water a fundamental right, says Bombay HC; flags scarcity in Maharashtra

MUMBAI: Access to clean and potable water is a fundamental right, the Bombay High Court on Monday said while expressing concern over water scarcity in the state, and sought to know from the government when the issue would be resolved.

A bench of Justices A S Gadkari and Kamal Khata was hearing a bunch of petitions over the issue of deaths of infants, pregnant and lactating mothers due to malnutrition in the tribal Melghat area of Amravati district in the Vidarbha region. The court was informed that amid soaring

summer temperatures, the area was severely affected due to a shortage of clean and potable water. In the last hearing in April, the court was informed that 13 persons had died in the area due to consumption of contaminated water. The government informed the bench on Monday that potable water tankers were being provided periodically, but the petitioners said the supply was erratic. The high court then said the government was not doing any "favours" by providing water tankers.

TN Assembly: No mocking of fellow legislators in House

CHENNAI: Tamil Nadu Assembly Speaker JCD Prabhakar on Monday cautioned members against using inappropriate facial expressions to mock fellow legislators during House proceedings, warning that strict action would be taken if such behaviour continued.

New molecule OLE offers hope in Alzheimer's treatment by restoring brain defence system

Scientists in Spain and Switzerland have identified a new experimental molecule that could help restore the brain's natural defence system against Alzheimer's disease, offering a potential new approach for future therapies.

The molecule, named OLE, was found to "reprogram" microglia — the immune cells of the brain — helping them regain their protective functions. Researchers found that the treatment reduced the buildup of toxic beta-amyloid plaques and improved memory performance in Alzheimer's disease models.

loid plaques, surround them and reduce their harmful impact on nearby brain cells. In animal experiments, the treatment also improved performance in memory-related tests.

Alzheimer's disease is characterised by the accumulation of beta-amyloid plaques in the brain. Normally, microglia help clear these harmful deposits, but as the disease progresses, these immune cells lose their effectiveness and may contribute to further brain damage.

The researchers discovered that OLE, a molecule produced by the

PM20D1 gene, can restore microglia to a more protective state. After treatment, the cells became more active in clearing plaques and formed protective barriers around them, reducing damage to surrounding neurons.

"One of the most significant findings is that we have identified a molecule capable of restoring microglia's protective function," Sanchez Mut said, adding that the findings suggest the impaired state of these cells in Alzheimer's could potentially be reversed. To test the molecule, scientists used genetically modified

worms and mouse models of Alzheimer's disease. In worms producing beta-amyloid, OLE reduced toxic protein buildup and improved movement. In mice treated with the molecule for three months, researchers observed improved memory performance and fewer beta-amyloid plaques compared to untreated animals.

Further analysis using single-cell studies showed that microglia were the cells most strongly affected by OLE. The treatment activated pathways linked to plaque removal and helped the cells move towards damaged areas.

"Single-cell analysis allowed us to determine that microglia were the cells that responded most strongly to the treatment," said Victoria Pozzi, the first author of the study.

Additional laboratory tests showed that microglia treated with OLE were more effective at removing beta-amyloid deposits. Experiments involving neurons also indicated that OLE could improve cell survival under Alzheimer's-like conditions.

The discovery has been protected through two European patents, including one owned by CSIC, strengthening its potential for future development into therapeutic applications. Researchers said further studies will be needed before the molecule can be considered for human treatment, but the findings open a promising new direction in Alzheimer's research.

Keir Starmer: The UK PM who got the India FTA over the line

London: Keir Starmer, the human rights barrister elected as Britain's Prime Minister with a landslide victory in July 2024, had pledged to get the much-anticipated Free Trade Agreement (FTA) with India over the line. Just days before announcing his resignation at the steps of 10 Downing Street in London on Monday morning, he met Prime Minister Narendra Modi on the sidelines of the G7 Summit in France, where both leaders set July 15 as the date for the FTA to come into force. Now, around the same time as the implementation of the India-UK Comprehensive Economic and Trade Agreement (CETA) - expected to significantly boost the 48 billion pounds bilateral trading relationship - the UK is expected to have a new leader in his place. "It's not just a piece of paper, it's a launchpad for growth. With India set to be the third biggest economy in the world by 2028, and trade with them about to become quicker and cheaper, the opportunities waiting to be seized are unparalleled," Starmer said, during his visit to Mumbai last October. The 63-year-old MP for Holborn and St Pancras in London was credited with achieving an impressive reversal of for-



tunes for Labour after the party's crushing election defeat in December 2019. Work on rebuilding connection with British Indians The other turnaround he worked hard on rebuilding was his party's connection with British Indians, alienated under former leader Jeremy Corbyn over a perceived anti-India stance on Kashmir. As Prime Minister, his approach towards India was reflected in Labour's 2024 election manifesto, which committed to seeking a "new strategic partnership with India, including a free trade agreement, as well as deepening cooperation in areas like

security, education, technology and climate change". "I have a clear message for you all today: this is a changed Labour Party," he declared just before the general election. During a visit to the Shree Swaminarayan Temple in Kingsbury, north London, on the campaign trail, he sought to reassure British Hindus that there is "absolutely no place for Hinduphobia in Britain". It is a message he has been reiterating over the past few years, including during celebrations of Diwali at 10 Downing Street. Sir Keir, who was knighted by the late Queen Elizabeth II for his services to

law and criminal justice, spent much of his career in the legal profession before stepping into the world of politics, first elected as Labour's member of Parliament from London in 2015. Starmer's family He is the father of two teenage kids kept out of the political spotlight by him and his National Health Service (NHS) employee wife, Victoria. Born in London to a toolmaker father and an NHS nurse mother, Starmer grew up in the town of Oxted in Surrey. He has spoken emotionally about his mother, Josephine, suffering from the debilitating condition of Still's disease, which she suc-

cumbed to a few weeks before he first became an MP in 2015. He believes he has inherited the grit and determination of his mother and the strong work ethic of his father, Rodney, whose manual labour drives much of Starmer's vision to ensure respect for those who work hard. In the televised general election debates, Starmer often played second fiddle to the natural debating charm of Rishi Sunak, his Tory predecessor, and was often branded as being quite dull. But just like Sunak, he also has a University of Oxford background, where he studied law and rose the ranks to be appointed the Director of Public Prosecutions (DPP) under a Labour-led government. He drew upon this experience as the chief prosecutor of the country in debates in the House of Commons and go head-to-head with sharp quips during weekly Prime Minister's Questions (PMQs). Experience As a new MP in 2016, the staunch anti-Brexiteer assumed the key role of shadow Brexit secretary under then leader Jeremy Corbyn and supported the latter to fight for what he says was the "future of the Labour Party".

Asian shares mixed, US futures fall as Iran talks make progress



Hong Kong: Asian stocks were mixed Monday, June 22, with markets in Japan and South Korea trading higher, while oil prices edged lower on fresh optimism over progress in US-Iran negotiations. US futures were trading lower. Tokyo's Nikkei 225 jumped 1.6% to 72,364.82, after reaching a new all-time record of 72,831.73 during intraday trading, helped by technology stocks that were fuelled by excitement over the global artificial intelligence boom. Japan's SoftBank Group, the multinational investment holding company with a strong AI focus, rose 2.4%. Chip equipment maker Tokyo Electron was up 2.3%. South Korea's Kospi gained 0.4% to 9,084.37 and was trad-

ing near its record high levels, led by AI-related shares. Memory chip maker SK Hynix surged 4.7%. "We're seeing another strong market today," Neil Newman, managing director and head of strategy at Astris Advisory Japan, said. He cautioned that the Japanese market is "probably getting a little stretched" from an investor's point of view, "especially with what's going (on) in the Middle East." Hong Kong's Hang Seng lost 1% to 23,690.86, while the Shanghai Composite index was 0.2% higher at 4,098.01. Australia's S&P/ASX 200 was down 0.1% to 8,822.80. Taiwan's Taiex rose 2.8%. India's Sensex was up 0.6%. Oil prices fell as talks progressed over a permanent end to the Iran war. Brent

crude, the international standard, was trading 1.4% lower to USD 79.42 per barrel. It was at roughly USD 70 a barrel before the start of the war in late February. High-level negotiations in Switzerland between the US and Iran concluded early Monday, with lower-level technical talks set for the rest of the week. Meanwhile, while Iran said the Strait of Hormuz, a key waterway for oil and gas transport, was shut again over the weekend, the US said that traffic had continued. "Moving towards a more permanent deal will be challenging, with very real risks of a flare-up in hostilities," ING commodities strategists Warren Patterson and Ewa Manthey wrote in a commentary on Monday.

Kunal Shah has long been one of India's most closely watched entrepreneurs, a founder known as much for his unconventional thinking as for building consumer internet businesses at scale. After selling FreeCharge in 2015, Shah spent the next few years investing, learning and reflecting on a simple question: Why can't trust be rewarded? That idea eventually became CRED, the fintech platform launched with \$1 million of his own capital to reward users for paying credit card bills on time. Over the next seven years, CRED evolved from a niche rewards platform into a broader financial services ecosystem spanning payments, lending, insurance, wealth, commerce and credit cards. The company grew to more than 17 million members, raised over \$900 million from global investors, completed four employee stock ownership plan (ESOP) buybacks and

secured a full suite of regulatory licences. Shah also became one of the most recognisable faces in India's startup ecosystem, helping build CRED's quirky brand identity through its IPL advertising campaigns and unconventional marketing. In a note announcing a leadership transition, Shah said CRED had scaled from zero to roughly \$325 million (about Rs 3,200 crore) in annual revenue and recently delivered its first profitable quarter. "Today, CRED is ready for its next phase," Shah wrote. "I am stepping back and Miten Sampat steps in as interim CEO, partnered with an incredibly talented team." Sampat, who has led strategy and finance at CRED since 2020, will take charge of day-to-day operations while Shah remains a shareholder. The leadership change comes alongside a major strategic deal with Meta Platforms Inc. According to

Bloomberg, Meta is investing \$900 million in CRED, valuing the company at \$4.5 billion post-money and giving the social media giant a stake of roughly 20%. As part of the arrangement, Shah will join Meta and succeed Will Cathcart as the global head of WhatsApp. Cathcart, who has led WhatsApp for about seven years and oversaw a period during which the platform's user base more than doubled, will remain at Meta in a new role focused on artificial intelligence-powered consumer products. Bloomberg reported that Shah's mandate will include expanding WhatsApp's business model through advertising, subscriptions and deeper integration of AI agents across the messaging platform. In his message, Shah emphasised that Meta's investment would not provide access to CRED member data.

RUSSIAN TROOP BUILD-UP THREATENS CITY SEEN AS KEY TO SEIZING UKRAINE'S DONBAS

Russian troops have infiltrated the strategic city of Kostyantynivka in eastern Ukraine and are now trying to surround it. The entire city is now effectively in a "grey zone", no longer controlled by anyone, Ukrainian soldiers have told the BBC. "They get into areas behind our backs and in urban conditions it's extremely difficult to push them out," says a Ukrainian drone pilot who operates in that area and prefers to remain anonymous. Kostyantynivka is a gateway to the rest of the Donbas region. If it falls, Russian forces would be able to push towards Ukraine's last remaining strongholds in the east, the cities of Kramatorsk and Sloviansk, and move closer to seizing Donbas completely, one of the Kremlin's key objectives in this war. For months Russia's full-scale war in Ukraine has stalled along the front line, and Ukrainian commanders say they have recaptured more territory this year than they have lost, disrupting



Moscow's crucial supply lines between the Russian border and occupied Crimea. On Sunday, Russian-appointed authorities in Crimea suspended fuel sales to the public because of the shortages. And Kyiv's repeated strikes on oil refineries in Moscow, St Petersburg and other cities have also sought to bring the conflict to the attention of Russians far from the front line. But in Kostyantynivka,

Russian soldiers have advanced from the south and have even been spotted at the other end of the city, on the city's northern outskirts. Moscow says its forces are rapidly advancing in the south-western part of Kostyantynivka and that they have encircled Ukrainian military units. That is denied by Kyiv and Brig Gen Oleksandr Bakulin, commander of Ukraine's 19th

Corp which is in charge of units defending the city and surrounding areas, insists "the situation remains under control" and "the enemy has no success". However, he does acknowledge there are about 130 Russian soldiers still inside the city. The situation on the ground may not be as critical as Moscow says, but it does appear far more serious than Ukrainian officials are ready to publicly

admit, a Ukrainian officer from a unit that operates inside Kostyantynivka told the BBC. He too has preferred to stay anonymous, but told the BBC: "We still have clean-up and assault groups inside the city, but the Russians manage to accumulate more and more soldiers there." Every building in Kostyantynivka acts as a potential shelter for soldiers to hide, and in the summer months the trees provide extra cover. So Russian forces have found a way to advance inside the "kill zone" where Ukrainian drones can detect any movement and instantly attack. Russian drone pilots have also focused on destroying Ukrainian drone launch sites. To give their infantry troops assaulting Ukrainian positions a breathing space, Russian pilots had made Ukrainian crews their priority target. The Ukrainian drone pilot told the BBC that while his colleagues were targeting Russia's infantry, enemy crews were not: "For such

tasks, they use artillery, multiple rocket launchers, military aviation." He and his comrades have limited numbers and resources, so they are often exhausted and have struggled to expand their operations. "Since we devote little time to [searching and targeting] enemy pilots, they can freely operate, detect our positions and we are forced to roll back. This is how the frontline moves," he explains. The Ukrainian officer whose unit is operating in the city maintains the pace of the Russian advance is very slow: "Sometimes they move 100m [109yds] a day. Sometimes they even crawl to reach the next building." The Ukrainian drone pilot told the BBC that while his colleagues were targeting Russia's infantry, enemy crews were not: "For such tasks, they use artillery, multiple rocket launchers, military aviation." Alan Greenspan, architect of the modern American economy, dies aged 100

Former US Federal Reserve chair Alan Greenspan has died aged 100, his wife has said. NBC News correspondent Andrea Mitchell said in a statement reported by her employer that her husband had died from complications of Parkinson's Disease. Mitchell's statement said Greenspan was "a giant of a man who helped shape the US economy for decades under presidents of both parties, but was always honest in acknowledging his mistakes". For nearly 20 years, Alan Greenspan was charged with safeguarding the US economy and keeping the dollar sound. As chairman of the Federal Reserve from 1987-2006, a post described as the second most important after the presidency, he presided over the longest sustained period of US economic growth in a generation. Described as the "God in the machine" of American finance, Greenspan declined all requests for interviews during his time at the Fed. But the media and the money markets hung on his few pub-



lic statements, and a sign in his office said simply, "the buck starts here". But critics argue that an over-reliance on easy credit fuelled the dot-com bubble of the late 1990s and caused the sub-prime mortgage crisis of 2008. The Fed said Greenspan's policies and economic thinking "left a lasting mark on this institution, on the broader field of economics, and on the country". In a statement on Monday, the central bank said: "He brought rigorous analytical discipline to monetary policymaking and helped establish the credibility that remains one of the Federal Reserve's most important assets."

GUINEA BANS EXPORTS OF RAW GOLD TO BOOST LOCAL REFINING



Guinea has banned the export of unrefined gold in an effort to promote domestic processing of the precious metal. The policy - effective immediately - comes after Guinea's President Mamadi Doumbouya met industrial and artisanal gold producers and buyers, and aims to boost the economy and create more jobs. "Guinea will now require its gold to be processed within its own borders. Raw gold will no longer leave Guinea," he said, adding that other countries have been reaping the economic benefits of processing and trading their raw materials. Guinea is Africa's sixth largest gold producer, according to the World Gold Council. Other African nations have taken similar steps to increase domestic processing and value addition in the mining sector in recent years. In Tanzania and Uganda, the export of unprocessed minerals and metals such

as gold and copper is already banned, while Ghana is set to ban raw gold exports by 2030. Africa's top lithium producer, Zimbabwe, has banned concentrate exports of the metal used to make batteries from 2027. Gold is one of Guinea's main exports, shipping more than 22 tonnes of the metal in the first quarter of this year, according to the authorities. A new refinery is near completion in the capital, Conakry, where the country's gold will be sent before processing and export. It has a reported capacity of 250 tonnes a year so should be able to handle the country's current production. Foreign companies operating in the country have been warned that they risk losing their licenses and having their mining contracts terminated if they violate the directive. Guinea is also the world's largest producer of bauxite, used to make aluminium.

Former Kenyan justice minister blocked from entering Uganda, lawyers' body says

Leading Kenyan lawyer and former Justice Minister Martha Karua has been blocked from entering Uganda and ordered to return home, according to the Uganda Law Society. Karua had just arrived at the Entebbe airport to join a team defending her Ugandan lawyer colleague Erias Lukwago, with whom they have been representing detained opposition leader Kizza Besigye, who is on trial for treason. Lukwago was himself charged with a treason-related offence last week, and his bail hearing had been due on Monday. A statement from Karua's office said she had been detained at the airport, adding that she was expected to return to the Kenyan capital, Nairobi, on Monday



but "remains incommunicado". "Her senior team reports that she is unreachable, with her mobile phones switched off and they continue to await direct communication regarding her status and expected return," it said. Ugandan authorities did not give a reason for blocking Karua, although Kenya's Law Society President Charles Kanjama

First round of US-Iran talks ends with encouraging progress, mediators say

The first round of negotiations between the US and Iran to reach a final deal to end the war has ended with "encouraging progress", mediators Qatar and Pakistan say. In a joint statement early on Monday, Qatar and Pakistan said that the parties had agreed to "a roadmap towards reaching a final deal within 60 days". Iran's foreign minister Seyed Abbas Araghchi said there had been "major progress" towards ending the conflict in Lebanon. The memorandum of understanding (MoU) signed last week includes a commitment to ending the fighting on "all fronts" - including Lebanon - and the reopening of the Strait of Hormuz. "Pakistani and Qatari mediation has delivered major progress to end



Lebanon War," Araghchi posted on social media. "Oil and petrochem exports are waived, blockade lifted, some frozen assets released, and major reconstruction & development plan launched for Iran." The Iranian lead negotiators left the talks in Switzerland on Monday, Iranian media said, with technical discussions between the parties due to

continue. The mediators' joint statement said that a "communication line" had been formed "to avoid incidents and miscommunication with the aim of safe passage for commercial vessels through the Strait of Hormuz." Both sides also agreed to the creation of a "de-confliction cell" between the US, Iran and Lebanon, facilitated by the mediating

countries, to end military operations in Lebanon, their statement said. Araghchi said the first "real test" would be the Lebanese de-confliction cell. Lebanese President Joseph Aoun spoke to senior officials from the US and Qatar on Monday about the issue, and more broadly about consolidating a ceasefire in Lebanon, his office said. Since the MoU was signed, there has been an upsurge in fighting between Lebanese armed group Hezbollah and Israeli forces in southern Lebanon, and Israeli air strikes that the health ministry says have killed dozens of Lebanese including women and children. A new ceasefire between Israel and Hezbollah was declared on Friday.

TRUMP-BACKED POLITICAL OUTSIDER WINS COLOMBIA ELECTION, INITIAL COUNT SHOWS

Right-wing candidate Abelardo de la Espriella has narrowly won Colombia's presidential election, an initial vote count shows, marking a dramatic shift in how the government will tackle the country's internal armed conflict and violence. De la Espriella, who was endorsed by Donald Trump, has pledged a military crackdown on illegal armed groups, drug trafficking and crime. He appeared to defeat left-wing Ivan Cepeda, a close ally of the president, Gustavo Petro. De la Espriella said "today begins a new stage for our country, a stage built on the free and democratic will of millions of citizens who chose to



believe in a great, safe, prosperous Colombia full of opportunities". With over 99% of votes counted, de la Espriella had won nearly 49.7% of the vote, while Cepeda won 48.7%, according to an initial count of the runoff election. Cepeda has not conceded, saying the pre-

liminary count was "not yet official or binding". "Once the official canvass takes place and its final result is produced, and the corresponding verifications have been carried out, we will recognize the official result that emerges from that structure." The verification

process showed little difference to initial counting in the first round of voting on 31 May, Reuters news agency reported. De la Espriella, who was raised in the Caribbean coastal region, enjoyed significant regional support there. After the initial vote count came through, de la Espriella addressed a huge crowd of supporters who had gathered to celebrate in Barranquilla, a city on the coast. "Tonight marks the beginning of a new story for the nation, tonight a new era begins, a change of order," said De la Espriella, who has nicknamed himself "El Tigre" (The Tiger). "I'm going to govern for all Colombians."

SCHOOLS CLOSE AS MORE THAN HALF OF FRANCE UNDER RED HEAT ALERTS



More than half of France's regions are under a red heat alert, as the country braces for sweltering temperatures in an intensifying heatwave. Highs of more than 40C (104F) are expected across parts of western France on Monday, with temperatures expected to hit 42C in Bordeaux, forecaster Météo-France said. Some 845 schools have been shut, while a further 1,800 are allowing pupils to finish classes early, the education ministry said. But more than a million high school students are due to take their oral final exams for the baccalaureate. The French government has warned people not to try to cool off in unsupervised areas such as lakes and rivers, after 13 drowning deaths at the weekend. A red heat alert is the highest of four warnings issued by Météo-France, and advises people to exercise extreme caution in conditions that are potentially life-threatening. Dozens of other regions in France are under an orange alert - the second-highest warning - with an estimated 63 million people in total affected across the country. The national

railway operator SNCF urged "vulnerable" people to avoid or postpone train travel this week, while in Paris, several train lines reduced their services on Monday due to the heat. Belgium's train operator also announced some peak hour trains would be cancelled for Monday and Tuesday. Temperatures in Belgium are expected to reach record levels in the coming week, the IRM meteorological institute said. Madrid is forecast to hit 39C on Monday and in Italy, temperatures are predicted to reach 37C in Rome. Red warnings are also in force across other parts of western and central Europe - taking effect in Germany and Switzerland on Monday and in Luxembourg on Tuesday. The rising temperatures are being driven by hot air moving north from the Sahara desert, which in turn trapping hot air over western and central Europe with forecasters suggesting the conditions could result in one of the longest heatwaves in recent years. Temperatures are expected to peak in many areas on Wednesday.

Japan quintuples visa fees in first price hike since 1978



Japan has implemented a five-fold increase to visa fees for all foreigners, marking the first price hike in nearly 50 years. From 1 July, single-entry visa fees will be raised from the current 3,000 yen (\$18.69; £14) to 15,000 yen, while multi-entry visas will now cost 30,000 yen, up from 6,000 yen. The visa fee revisions - the first since 1978 - were made to "reflect inflation and exchange rate fluctua-

tions", Foreign Minister Toshimitsu Motegi told reporters on Friday. "We do not anticipate that it will have an immediate impact on inbound tourism," he added. The Japanese yen has been weakening continually since 2021, and is now hovering near historic 40-year lows. This, along with a post-pandemic travel rebound, has led to a surge in tourists to Japan.



The Unreal Story Of Iran Goalkeeper Alireza Beiranvand

TWO GUINNESS RECORDS, 90 MINUTES OF DEFIANCE

Who said the 48-team FIFA World Cup was going to be boring, with too many one-sided matches? As the group stage of the tournament nears its conclusion, some heroic performances have been witnessed, especially from the goalkeepers of smaller nations like Cape Verde, Curacao, and Iran. After some brilliant performances in goal by Vozinha and Eloy Room, it was time for Iran's goalkeeper, Alireza Beiranvand, to shine. Beiranvand put in a heroic show between the sticks to help Iran earn a goalless draw against Belgium, a team ranked No. 9 in the world by FIFA. While the ongoing World Cup in the US, Canada, and Mexico has seen some phenomenal goalkeeping performances, Beiranvand's story sets him apart from the rest. As Belgium took on Iran in search of three



points, they came across a 6'4" man named Alireza Beiranvand. He made seven saves, collected the Player of the Match trophy, and held together a clean sheet that, by all sporting laws, should never have existed. Long before he was frustrating Europe's elite,

Beiranvand was a kid running away from home. Born into a nomadic Kurdish Lak family in the rugged hills of Lorestan, his childhood was defined by extreme poverty and a father who fiercely opposed his dream of playing football. To his family, football was an unafford-

able luxury; a pair of gloves was equivalent to throwing money away. So, as a teenager, Beiranvand took a gamble that would break most adults. He borrowed pocket money, ran away, and boarded a bus heading toward the chaos of Tehran.

When Beiranvand arrived in the Iranian capital, he didn't have a bed, a room, or an acquaintance. For months, he slept on the streets outside local football clubs, figuring that if he was going to freeze, he might as well do it close to the grass. To buy basic meals, he had to sweep streets, scrub down tyres at a car wash, work assembly lines in a dressmaking factory, and even prepare dough in a late-night pizza shop. It was during those punishing early years that coaches noticed something bizarre about Beiranvand's physiology. Growing up in the hills, he had spent his childhood playing a local game called Dalparan, which involved throwing heavy rocks over massive distances to protect sheep. That repetitive chore had forged an upper body unlike anything ever seen in modern football.

Women's T20 World Cup 2026 Semifinals Scenarios: What Loss Against South Africa Means For India

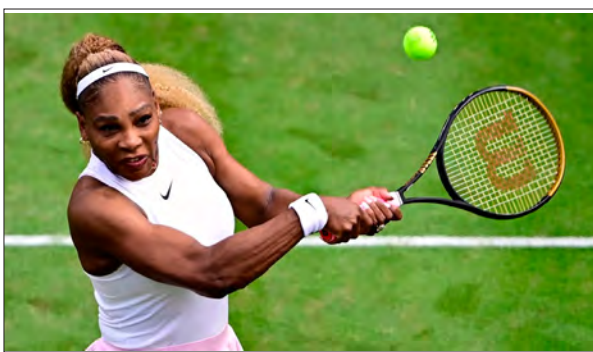

Organisers released their initial list of wildcards on Sunday, with Williams, a seven-time champion at the All England Club, one of eight players awarded a place in the ladies singles event. A social media post by the official Wimbledon Championships said: "This is not a drill" with a picture of Williams standing on a grass court captioned "Serena returns". "@serenawilliams will compete in the 2026 ladies' singles at #Wimbledon as a wildcard," read the post. The 44-year-old former world number one and 23-time Grand



Slam singles champion has not played a singles match since the 2022 US Open. However, she did make one appearance at Queen's last week alongside Canadian teenager Victoria Mboko. They knocked out the third seeds Nicole Melichar-Martinez and Erin Routliffe before an injury to Mboko ended their participation without playing another

match. Williams and Czech doubles partner Karolina Muchova then lost in their first match at the Berlin Open this week, hours after the American great and her sister Venus Williams were awarded a wildcard to play in the Wimbledon doubles event. They are six-time doubles winners at Wimbledon, last triumphing there a decade ago.

"Having Baby Doesn't Need To Be End Of Career": ICC Unveils Post-Pregnancy Return-To-Play Guidelines



To ensure a safe and sustainable return to cricket for women players post-pregnancy, the ICC on Monday announced guidelines to cover their early recovery after birth, structured training, and conditioning during a 16-week window before the comeback. The 'Return to Play Post-Pregnancy Guidelines' for female cricketers, ut-

line a six 'R's' framework: Ready, Review, Restore, Recondition, Return and Refine. "The approach covers early recovery after birth, medical and wellbeing reviews, gradual return to structured training, cricket-specific conditioning, return to

play and ongoing monitoring once a player is back in the cricket environment," the ICC stated in a press release. The document speaks about having a dedicated 'Case Manager' for the players returning to competitive cricket post-pregnancy. The Case Officer should be either a doctor or a physiotherapist.

The early review would include a focus on psychological support in the players' adjustment to life as a mother, followed by graded reintroduction of strength-based training. After eight weeks of these assessments, the player will return to running in collaboration with a doctor and physio.

EX-WIMBLEDON CHAMPION VONDROUSOVA GIVEN FOUR-YEAR BAN



Former Wimbledon champion Marketa Vondrousova has been banned for four years for refusing an anti-doping test last year. Vondrousova, 26, was charged by the International Tennis Integrity Agency (ITIA) after denying a doping control officer entry to her home to conduct the test in December 2025. The Czech player said in April she feared for her safety when the officer called and said they failed to follow "protocol". But a tribunal determined Vondrousova, who became the first unseeded player to win the Wimbledon women's singles title in 2023, provided "no compelling justification" for refusing a test. Vondrousova's suspension will end on 21 June 2030, but she has a right to appeal against the decision to the Court of Arbitration for Sport (Cas). Under anti-doping rules, the starting point for a sanction when a player refuses a test is the same as if

they had tested positive. During the hearing, Vondrousova explained stress and poor mental health had affected her decision-making, in addition to her safety concerns. ITIA chief executive officer Karen Moorhouse said while the agency understands the testing process is "uncomfortable" and also acknowledges the additional burden it can carry for players competing, "it is essential to protect fair competition". Moorhouse added: "Safety and welfare of players and our testers is really important to us. Our testers are well-trained, professional, and the gender of our testing witness always matches the player. "They carry ID at all times, and players are able to verify their identity in other ways if they are ever unsure." Vondrousova, who is ranked 122 in the world, said she felt scared when the officer approached her door late at night without properly identifying themselves or following protocol, adding: "In that moment it was about feeling safe."

"I Am Done": Virat Kohli Clears Air On Big Question About His Future

Indian batting icon Virat Kohli ruled out any possibility of returning to Test cricket, saying that he is "done with it". Virat was speaking at the launch event of the sportswear brand One8, a brand where he is a co-founder, in the national capital on Sunday. Famous host and comedian Danish Sait, observing that one of the shoes of the brand cost 9,230 rupees, the same number as his Test runs, asked the 37-year-old if he would like to return to Test cricket in order to score more runs and boost the item's profitability, to which Virat humorously replied, "I would rather undersell, I'm done with it (Test cricket), thank you." Kohli announced his retirement

from Test cricket in May last year, marking an end to an illustrious 14-year-old career which saw him dominate a variety of conditions, regions, and opponents in whites, both as a batter and captain. In his Test career, the 36-year-old made 123 appearances in white clothing, scoring 9,230 runs at an average of 46.85, with 30 centuries and 31 fifties in 210 innings and the best score of 254*. He is India's fourth-highest run-getter in the format, behind Sachin Tendulkar (15,921 runs), Rahul Dravid (13,265 runs) and Sunil Gavaskar (10,122 runs). Between 2016 and 2019, Virat had one of the strongest batting primes ever for a Test cricketer, piling up 4,208 runs

in 43 Tests at an average of 66.79, with 16 centuries and 10 fifties in 69 innings and the best score of 254*. This also included seven double centuries, most by a captain in Test cricket history. He was India's most successful Test captain, with 40 wins in 68 matches, since he first took over the reins in 2014 during the tour of Australia in the absence of an injured MS Dhoni. Later, while speaking in front of a packed crowd at Dwarka, Virat reflected on how his journey began as a cricketer in Delhi, and expressed happiness at being able to launch the brand where it all started for him. "Delhi is the place where everything started for me. I was born in Delhi, my cricket

journey started in Delhi, and Delhi will always remain a part of me. So, to be able to launch One8 in Delhi after so many years, a vision, a dream to come true like this, being the co-founder, is something that I always dreamt of.
