NEW DELHI (TSIT) Central Reserve Police Force (CRPF) Director General G.P. Singh has asked personnel deployed in Manipur to "neutralise" miscreants roaming around in civilian areas with weapons. Mr. Singh made the remarks during an interaction with CRPF personnel in Manipur on Saturday, according to a 6.05-minute video clip seen by The Hindu. He said that discussions were held at the highest levels in the government, and added, "It is expected that there will be a turnaround in the situation in the northeastern State in the next 1-1.5 years. More than 6,000 police weapons and thousands of rounds of ammunition were looted from armouries after ethnic violence erupted in the State on May 3, 2023. Security agencies have consistently flagged the availability of a large number of weapons with civilians as a major security challenge. In the video, the CRPF officer said that personnel need not worry about firing at miscreants and he, as a DG, would protect any "bona fide action". "If you do not fire at miscreants, why has the government given us so much arms and ammunition. I have your back. Till the time I am here, no need to worry about any (legal) action," Mr. Singh said, referring to an April 7 incident in which CRPF personnel opened fire as a mob stormed the force's camp at Gelmol, a buffer zone between Meitei and Kuki-Zo areas in Bishnupur district since 2023.

**India's Ease of Doing Business  
reforms drive investor confidence,  
digital transformation**

NEW DELHI (TSIT)

India's sweeping reforms in governance, regulation and digital infrastructure have significantly strengthened the country's business ecosystem, making it easier to start, operate and expand businesses while boosting investor confidence and global competitiveness.

According to a government review released on Saturday, sustained efforts to simplify regulations, reduce compliance burdens and digitise public services have transformed India's business landscape over the past decade. The reforms have helped improve transparency, efficiency and ease of access to markets, credit and government services for entrepreneurs, startups and businesses of all sizes.

The impact of these measures is reflected in India's rise in global rankings. The country improved its position in the World Bank's Doing Business Report from 142nd in 2014 to 63rd in 2019. India has also strengthened its standing in the IMD World Competitiveness Ranking, moving up from 43rd place in 2021 to 41st in 2025.

A major pillar of the reform agenda has been the promotion of entrepreneurship. Since the launch of the Startup India initiative in 2016, the number of recognised startups has surged from just 502 to over 2.23 lakh by March 2026, generating more than 23.3 lakh direct jobs. Nearly half of



these startups have at least one woman director or partner, underlining the growing inclusivity of India's startup ecosystem.

Business registration has also become significantly easier through digital platforms such as the SPICE system and MCA21 Version 3, which have streamlined company incorporation and compliance processes. For micro, small and medium enterprises (MSMEs), the Udyam Registration Portal has enabled paperless and self-declaration-based registration, helping millions of enterprises enter the formal economy.

Property registration and land governance have undergone a digital overhaul through the Digital India Land Records Modernisation Programme. More than 97 per cent of cadastral maps have been digitised, while over 36 crore land parcels have been assigned a Unique Land Parcel Identification Number (ULPIN), enhancing transparency and reducing disputes. The government has also

focused on reducing procedural hurdles in obtaining business permits and clearances. The National Single Window System now integrates approvals across multiple central and state departments, while the PARIVESH portal has substantially reduced the time required for environmental clearances. Market access has improved through initiatives such as the Government e-Marketplace (GeM), Open Network for Digital Commerce (ONDC), PM GatiShakti and advanced logistics platforms. GeM alone has recorded a cumulative transaction value of Rs 18.4 lakh crore, providing opportunities to startups, women entrepreneurs and MSMEs to participate in government procurement. On the financial front, easier access to credit has emerged as a key reform area. Schemes such as the Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSSE), Emergency Credit Line Guarantee Scheme (ECLGS) and Pradhan Mantri Mudra Yojana (PMMY) have expanded formal financing to millions of businesses.

**LPG price hikes: Govt will pay 'political price', says  
Sharad Pawar; Cong's Wadettiwar slams BJP**

KOLHAPUR (TSIT):

NCP (SP) chief Sharad Pawar on Sunday criticised the Centre over rising prices, claiming the government would pay a "political price" as frequent hikes in essential commodities were burdening the common man. People across the country were facing hardship due to inflation, the former Union minister claimed and questioned the government's stand that price rise was under control.

"The hike may have started with just two rupees, but over time the increases have kept piling up, and today we can see how far the prices have risen. All of this has a direct impact on the finances and daily lives of ordinary people," Pawar said.



Prime Minister Narendra Modi had initially claimed his government would keep inflation under control, the NCP (SP) supremo said. However, it now appears that their (Centre's) idea of 'control' is to deliver these price shocks step by step, he added. "Those responsible

will have to pay a political price," he said in response to media queries on the LPG price hike. Maharashtra Congress leader Vijay Wadettiwar accused the BJP of abandoning its earlier stand on price rise, and said the ruling party was no longer showing the same

concern for issues affecting ordinary people as it had done while in the opposition. In a statement, Wadettiwar said BJP leaders used to stage protests whenever cooking gas prices were increased during the UPA regime, but remained silent despite repeated hikes in fuel and LPG prices since coming to power.

"Commercial LPG cylinder prices have risen sharply over the past few months and petrol, diesel and CNG prices have also witnessed multiple revisions in recent years. Inflation was severely affecting household budgets and placing an additional burden on middle-class and economically weaker families," the Congress leader claimed.

**DK Shivakumar invites JD(S)  
workers, calls for unity**

KANAKAPURA (TSIT):

Chief Minister DK Shivakumar rolled out an open invitation to Janata Dal (Secular) party workers by saying that his doors were always open for them. "This D K Shivakumar is there for Janata Dal workers too. My door is open to you as well. You can make use of me and seek help," he said while addressing several gratitude events in his home constituency of Kanakapura. "I am ready to do good for you. God grants neither boons nor curses, but only grants opportunities. You must make use of the opportunities you receive. In the past, we had supported Anitha Kumaraswamy and Kumaraswamy in order to keep the BJP at bay. I will not discuss now what happened back then," he said.

In this constituency, everyone will be carried along together. I will not blame anyone, saying they did not support us in the Lok Sabha elections. Everyone must be treated equally. Mistakes happen, forgive that. You made me win in the Assembly elections, continue to support our people in

the same way going forward. Let us all move ahead as one. Our leaders should not harbour hatred against anyone. Pray that their hearts undergo a change," he said.

"During my difficult times, you prayed for me, made vows on my behalf, fought struggles, and even got charged with cases. Your hard work has now borne fruit. Even though it was delayed by a few days, Siddaramaiah has acted as he promised. I must act according to the party's guidance. You must enable me and Siddaramaiah, working together, to make the Congress party win in the 2028 elections and form the government," he said.

"I do not believe in discrimination based on caste or religion. As Kuvempu said, this state must be made a 'garden of peace' for all communities. I have regarded people of all communities as my brothers," he said. "Everyone must be cautious about the SIR (Special Intensive Review). **Dipke says Hindu-Muslim agenda  
dominates politics, jobs are main concern**CHHATRAPATI

Cockroach Janta Party founder Abhijeet Dipke on Sunday (June 7, 2026) alleged that politics in the country over the last decade is centred around the Hindu-Muslim agenda, calling for a change in the government's priorities and flagging unemployment as a pressing issue. Addressing a press conference in Chhatrapati Sambhajnagar, a day after leading an agitation in Delhi, Mr. Dipke reiterated the demand for Union Minister Dharmendra Pradhan's resignation amid the row over the alleged NEET paper leak and CBSE OSM glitches. He vowed to prepare an agenda to overhaul the education system after Pradhan's resignation. Mr.



Dipke stressed that the BJP movement cannot be compared with demonstrations that occurred in some neighbouring countries, asserting that BJP is exclusively for Gen Z and it won't be associated with any political party. "We are seeing that the country's politics has moved to the Hindu-Muslim agenda in the past 10-12 years. This issue can't provide jobs. We need to shift that focus, and the government's priorities should also change.

**Iran operation is not a new war: Trump**

WASHINGTON (TSIT)

US President Donald Trump on Sunday defended United States' military action against Iran and rejected suggestions that he abandoned his long-standing pledge to avoid new wars, saying that preventing Tehran from obtaining a nuclear weapon was necessary to protect the United States and its allies. In an exclusive interview with NBC's Meet the Press, Trump was asked whether the conflict contradicted a campaign promise he had repeated since 2015.

"No. No," the US President replied when asked if he had broken that promise. "I had to stop a country, very powerful, very dangerous country from having a nuclear weapon



because they'd use it," he said. "I'm doing our country a service. It's America first." Trump disputed the premise that he had guaranteed the United States would never enter another conflict. "First of all, I didn't guarantee no war," he said. "I don't like these endless wars. This is not an endless war." The President said he faced a choice between main-

taining favourable economic conditions and confronting what he described as a growing nuclear threat from Iran.

"At the hottest point in the history of our country, I took Scott Howard, I took Pete, I took everybody into a room. I said, I have to do this country, this world, the Middle East, Israel, everybody a favour. You have Iran. They're going to have a nuclear weapon," he added. Trump said he had ended the Obama-era nuclear agreement with Iran and later authorised military action against Iranian nuclear facilities. "I terminated the deal," he added. "Then I sent the B two bombers in about nine, 10 months ago. And they obliterated, totally obliterated the site." The President said that military intervention had significantly reduced Iran's capabilities.

# Vimal Negi death case: Himachal BJP demands impartial investigation

**SHIMLA:** BJP State general secretary Sanjeev Katwal on Saturday demanded a fair and comprehensive investigation and strict punishment for those responsible for the mysterious death of former Himachal Pradesh Power Corporation Limited (HPPCL) Chief Engineer Vimal Negi. Katwal told media persons that the allegations revealed by the CBI in the case -- concerning the issuance of fake completion certificates, manipulation of official records, and decisions made in violation of established rules -- raise serious concerns about the credibility and integrity of the administrative system. Lashing out at the Congress-led state government, the BJP leader said the Negi case is not merely about one individual but concerns administrative accountability, transparency, and good governance. Negi went missing on March 10,



2025. His body was found on March 18 in Bilaspur under mysterious circumstances, and his wife alleged that his seniors harassed him. The case stirred a political storm in the state, with the opposition BJP alleging a cover-up.

"If certificates were issued despite discrepancies between the actual status of a project and official records, if officers were allegedly subjected to pressure, and if those raising objections were sidelined from the decision-making process, then the matter is extremely serious and demands complete transparency," he said. Katwal said people of the state have a right to know under whose protection such activities continued. "If investigations indicate that rules were ignored to benefit certain individuals or entities, then the Congress government must explain why timely action was not taken despite the seriousness of the allegations," he said. He said if an officer was forced to work under pressure, if objections were ignored, and if institutional processes were weakened, then it reflects a much larger systemic failure that cannot be overlooked.

# Khan Sir to seek anticipatory bail over FIR on vandalism at his coaching centre in Patna

**PATNA:** A lawyer representing educator Faisal Khan, popularly known as Khan Sir, said that his client will file an anticipatory bail petition in Patna civil court as he has been named in an FIR in connection with vandalism at his coaching centre here. The lawyer, Arvind Kumar Mahuar, alleged that the FIR has been registered against his client as "part of a conspiracy to defame him". Patna SSP Kartikeya Sharma had said on Friday that the educator and YouTuber was named in an FIR in connection with the case of vandalism of Khan Global Studies Institute. Police had detained two guards of the coaching



centre for allegedly firing shots on Tuesday night when a group of 15-20 people allegedly tore down the coaching centre's poster and threw stones at its premises.

"Khan Sir has been named in the FIR as part of a retaliatory measure because his staff had registered a case against another coaching centre's director. He will not surrender and file an

anticipatory bail petition before the court," said the lawyer. Mahuar said the anticipatory bail petition is likely to be filed on Monday. He alleged that there are no actual charges against his client. "Based on videos and photos of the incident, it is clear that the guards fired shots in the air for safety purposes. There was no injury to anyone. His name has been inserted in the disclosure statement to implicate him," the lawyer said. Mahuar said the anticipatory bail petition will likely be filed by the educator on Monday when court proceedings resume after the weekend.

# TVK in power due to DMK's grace, take pledge to end Vijay-led regime's rule, says M K Stalin

**CHENNAI:** DMK president M K Stalin on Saturday asserted that the TVK is in power in Tamil Nadu only due to the benevolence of his party and its allies, and urged his party workers to take a pledge to put a full stop to Chief Minister C Joseph Vijay-led government. Welcoming more than 1,000 AIADMK workers who joined the DMK at a function held here, Stalin traced the party's history since its founding in 1949 and underlined that his party opposed the imposition of Emergency in 1975, knowing fully well that it would lead to the dismissal of the government. In 1976, the DMK government was dismissed and till 1989, the party could not win polls and form the government, he said, and recalled the ups and downs seen by the party till it formed the government yet



again in 2021. The former chief minister said that the reason for him recalling all that is to underscore that victory and defeat will alternate. He said: "That is why we are proving today that a DMK member is someone who neither goes wild chasing victory, nor loses heart and gives up when facing defeat, but continues to work forever."

It is in this situation, when the party has lost the opportunity to win and when it works as the principal opposition, so many have joined the party under the leadership of Gaja alias Gajendran, AIADMK Kattankolathur-North Union Secretary, who fought Assembly polls form the Chengelpet constituency as the candidate of that party,

he said. Further, Stalin said: "You have no reason to worry. You must not forget that the current regime is functioning only due to our grace (favour/benevolence). We (the DMK-led alliance) faced the election with the determination that we must win; the government must be formed under the leadership of the DMK, and that all opposition parties must be defeated. It is only with the grace of the parties that were in our alliance that this government is functioning today. It is only with the cooperation of the alliance parties, who wished for the DMK to come to power, that this government is running today." Furthermore, he said: "Let us take a pledge in this event to put a full stop to this government which is functioning due to our benevolence."

# Chandigarh University holds 8th CU Online Annual Convocation; 363 Degrees Awarded

**CHANDIGARH:** Chandigarh University organised the 8th Annual Convocation of CU Online and the Centre for Distance and Online Education (CDOE) during which degrees were conferred on 363 students from 19 states and UTs from across the country in the presence of students and their family members, faculty members and university officials. The graduating cohort consisted of 214 male and 149 female students. Out of the total degrees awarded, 330 were postgraduate (PG) degrees and 33 were undergraduate (UG) degrees. The graduates belonged to both Online Learning (OL) and Open and Distance Learning (ODL) programmes offered by Chandigarh University. Sanjeev Parkar, Senior Di-

rector, PwC India graced the prestigious convocation ceremony as the Chief Guest. The ceremony was also attended by Prof. (Dr.) Raviraja N Seetharam, Vice-Chancellor, Chandigarh University, Prof. (Dr.) SS Sehgal, Pro Vice-Chancellor (Operations) & Registrar, Chandigarh University and Prof. (Dr.) Gurpreet Singh, Director, Centre for Distance and Online Education (CDOE). Meanwhile, Chandigarh University also signed a Memorandum of Understanding with PwC - one of the world's 'Big Four' consulting firms of the world to offer an online MBA program thus becoming the first university in India to launch such a programme in collaboration with PwC. Participating in the 'Ek Ped Maa Ke Naam' plantation drive near here, Khandu said every tree planted would contribute to cleaner air, a healthier environment and a better future for the coming generations. "Planting trees is not something we do once a year and forget. It must become a lifelong mission," Khandu said in social media post after the event. "As the nation celebrates 12 years of transformative leadership and service under Prime Minister Narendra Modi, this campaign reminds us that development and environmental responsibility must go hand in hand," he said. Khadu also said that on the occasion of the



tree plantation drive, he had the opportunity to interact with students, teachers, and authorities at the Government Secondary School, Chimpu. "The visit also provided an opportunity to hear firsthand the concerns and grievances of the school. The state government has taken note of the issues raised and will work towards addressing them," he added.

# JMM nominates ex-minister Baidyanath Ram for RS polls

**RANCHI:** The Jharkhand Mukti Morcha (JMM) on Saturday nominated former minister Baidyanath Ram as its candidate for one of the two Rajya Sabha seats in the state, going to polls on June 18, a party official said. JMM general secretary and spokesperson Supriyo Bhattacharya told reporters that Ram will file his nomination papers in the presence of Chief Minister Hemant Soren on June 8. On the second seat, Bhattacharya said the final decision will be taken on this by party leadership following a discussion with the Congress. The Congress on Friday announced senior party functionary Pranav Jha as its candidate for one of the two Rajya Sabha seats from the state. The ruling JMM legislators, during a meeting chaired by the chief minister on Friday, had demanded that the party contest both the seats go-



ing to the polls. Meanwhile, AICC observers for the Rajya Sabha polls, Bhupesh Baghel and Ajay Sharma, on Saturday arrived in Ranchi, and they met Jharkhand Chief Minister Hemant Soren, hours after JMM announced

Ram as its candidate for the polls. Congress President Mallikarjun Kharge on Friday approved the proposal for the appointment of Baghel and Sharma as AICC observers for the upcoming Rajya Sabha Biennial Elections in Jharkhand. Baghel and Sharma met the CM to seek JMM's support for the Congress candidate Jha, a senior Congress leader said. Congress minister Radhakrishna Kishore claimed that of the two Rajya Sabha seats in Jharkhand, one will go to JMM and another to Congress, as the India bloc has 56 members in the 81-member assembly. The BJP has already announced that it will field a candidate for one of the two Rajya Sabha seats, but it has not yet announced the name of the candidate. One of the Rajya Sabha seats fell vacant following the death of JMM co-founder Shibu Soren, while BJP member Deepak Prakash will com-

plete his six-year term on June 21. The nomination process for the elections commenced on June 1, and the last date for filing papers is June 8. Polling will be held on June 18. As many as five candidates, including JMM's Baidyanath Ram, Congress's Pranav Jha, Rajya Sabha MP from Andhra Pradesh Parimal Nathwani and BJP leader Gaurav Vallabh, purchased nomination forms on Saturday, an election official at Jharkhand Vidhan Sabha said. To ensure victory, a candidate is required to secure a minimum of 28 first-preference votes. In the Jharkhand Assembly, the INDIA bloc has 56 members, comprising 34 from the JMM, 16 from the Congress, four from the RJD and two from CPI(M)L Liberation. The NDA has 24 MLAs -- 21 from the BJP and one each from the LJP (Ram Vilas), AJSU Party and JD(U). Jharkhand Loktantrik Krantikari Morcha has one MLA.

# Kerala govt will resist attempts to politicise education sector: Min John

**KOCHI:** Kerala Higher Education Minister Roji M John on Saturday said that the government would resist any attempt to politicise the state's education sector and would work towards creating better opportunities and facilities to prevent brain drain among students. Addressing reporters at a 'Meet the Press' programme organised by the Ernakulam Press Club here, the minister said the government had a responsibility to create an environment that encourages students to pursue higher education and career opportunities within the state. "The government has the responsibility, and we will take initiatives as part of it," he said. Responding to questions on differences between the Governor, who is the Chancellor of universities in Kerala, and the state government, John said such issues would be handled in a manner that does not adversely affect the higher education sector. "It does not always mean fighting with the Governor.

We will not compromise on our ideologies and principles," he said. Replying to queries regarding the appointment of Dr B Mavuth as the temporary Vice-Chancellor of Mahatma Gandhi University, the minister said the government was not asked to provide a panel of candidates. "The Chancellor has certain rights and powers under the statute. He was appointed within a few days of our assuming office. The government was not asked to provide a list and did not get time to examine the matter," he said. John said the government would move forward with its higher education policies while safeguarding the autonomy and credibility of academic institutions. "We do not agree with saffronisation and will take steps against it," he said, adding that the Chancellor was exercising powers available under the university statutes in making the temporary appointment. The minister said political influence should have no role in matters such as the appointment of vice-chan-

cellors and stressed that improving the quality and credibility of academic institutions remained the government's objective. He said the government was seriously examining issues such as declining student enrolment in some colleges and the presence of surplus teachers in certain institutions. Policy decisions on these matters would be taken after consulting experts and related announcements could be expected in the upcoming state budget, he said. The minister also criticised the manner in which the four-year undergraduate programme was implemented, saying it had been introduced without adequate preparation and had created practical difficulties for students and teachers. He said a special committee would be appointed to study various aspects of the programme and recommend necessary changes. On private and foreign universities, John said the government was keeping an "open mind" about allowing them in Kerala.

# Nadda, Kharge spar over NFHS-6 findings on health and nutrition

**NEW DELHI:** A political debate over the findings of the latest National Family Health Survey (NFHS-6) intensified on Saturday, with Health Minister J.P. Nadda rejecting criticism by Congress president Mallikarjun Kharge and arguing that the survey reflects improvements in several key health indicators over the past decade. The exchange began after Kharge questioned the Modi government's handling of health and nutrition challenges, citing findings from NFHS-6 and earlier surveys. In a post on X, the Congress chief alleged that malnutrition and anaemia continue to affect a large section of the population, particularly women and children. He claimed that one in five children suffers from acute malnutrition, around one-third are underweight, and over 84 per cent of children aged six to 23 months do not receive adequate nutrition. Highlighting the prev-



alence of high levels of anaemia among women, Kharge cited NFHS-5 figures showing that 57 per cent of women aged 15 to 49 are anaemic and one in five women is undernourished, while accusing the government of deliberately hiding crucial data which exposes its failures. Responding on Saturday, Nadda accused the Congress leader of selectively interpreting the survey findings. In a series of posts on X, the Health Minister said NFHS-6 showed improvements in maternal and child healthcare indicators compared with earlier rounds of the survey. According to Nadda, first-trimester antenatal registration, institution-

al deliveries and births attended by skilled health personnel have increased significantly since NFHS-3, conducted in 2005-06. The health minister in his post also highlighted that full immunisation coverage has increased to 87.1 per cent, health insurance coverage has risen from 4.9 per cent to 60.2 per cent, and the use of hygienic menstrual protection has reached 79.2 per cent. He further noted that child stunting has declined from 48 per cent to 29.3 per cent compared with data from two decades ago, attributing the changes to investments in healthcare, nutrition, sanitation and welfare programmes.

# Ranthambhore tigress spotted with cub, big cat count rises to 72

**JAIPUR:** A tigress in Rajasthan's Ranthambhore Tiger Reserve (RTR) has been sighted with a cub, taking the total number of big cats in the reserve to 72, officials said on Saturday. Tigress RBT-124, known as Riddhi, was recently spotted with the cub in the Gal Ghati area during routine patrolling and monitoring activities. Officials said the cub appeared healthy, and its movement was being closely monitored to ensure the safety of both the tigress and the offspring. "The sighting of the cub is an encouraging sign for tiger conservation efforts in Ranthambhore. Continuous monitoring is being carried out, and necessary protection measures have been put in place in the area," a forest department official said. He said that successful breeding reflects the effectiveness of habitat protection, anti-poaching measures, regular patrolling and support from local communities. With the latest addition, the number of big cats, comprising adult tigers and tigresses and cubs, in Ranthambhore Tiger Reserve has reached 72, the official said. Ranthambhore, one of India's premier tiger habitats, has witnessed steady growth in its tiger population over the years and is a key centre for wildlife tourism and conservation in the country.

# Three killed after assailants attack village in Kangpokpi

**IMPHAL:** Three people, including a woman, were killed after armed assailants launched an attack at a village in Manipur's Kangpokpi district early on Friday, officials said. At least seven houses were also gutted in a fire during the attack around 4 am at Loibol Khullen village in Saitu-Gamphazol subdivision of the district, they said. The three died amid exchange of fire between rival groups for several minutes, which prompted villagers to run for shelter in nearby forest areas, an official said. The deceased have been identified as Leththongam Haokip, Tinmary Haokip and Jangminlal Haokip.

Remembering  
Roy David

“Born in an unjust society, we shall not die in it, until we change it.” This tagline of the Coorg Organisation for Rural Development (CORD) captures the core conviction that shaped the life of its founder and director, Vijayasingh Ronald David, known to many as Roy David. The people he stood alongside over decades of grassroots activism and mobilisation saw how this principle animated everything he did. While I only had the opportunity to know him during the last two years of his life, as a young researcher I learnt much from him, his stories and his endless commitment to social change. For me, he was Roy sir. On May 16, many of us were devastated by the news of his sudden passing, caused by a cardiac arrest while he was driving home from Bangalore to Kushalnagara. He was 71.(I first met him in 2024, while doing research around Karnataka’s Nagarahole Tiger Reserve. Several people had told me to know the history of this place, you must go see David. After our initial interaction, I remember feeling unsure whether I would hear more from him. To my surprise, over the following months, we ended up spending several weeks together. He went from constantly reprimanding me during these visits, to convincing me – with big grins and offers of fish fry and boiled rice from the shop next door – to stay a few more days. Then he would stare intently at his phone as if his hearing had suddenly declined while I murmured complaints. I always ended up staying, and he would hand me a pile of papers or a messy folder on his old laptop to sort through. On the day of our scheduled first meeting, I had reached Kushalnagara several hours late. He was still waiting in the CORD office attached to his house. The room had a faint musty smell. The bookcases were crammed with papers, binders and framed certificates. The papers spilled over to his desk. Behind it sat David, peering at me through his glasses. He wore a long-sleeve shirt, hair and beard dyed jet black, his tall stature evident even while seated. One hand rested against his stomach. I had heard the stories – he lost full function of the hand after surviving an attack instigated by landlords in Mangalore in the 1970s; he had been demanding land rights for tenant cultivators. He began to ask me questions, probing my motivation for visiting him. Dissatisfied, he listed all the ways in which academics had neglected this region. “If you are here just to get information for yourself, I won’t talk to you. If someone wants to work for the people, contribute, then I have time,” David said. He shuffled across the room to hand me pamphlets as he spoke, stopping occasionally to cough. The slowness in his movements revealed as much about the 45 years he had dedicated to the Adivasi-led peoples’ struggle around Nagarahole as his narration did. “Anyway, what knowledge I have, I will share. Information must be shared, not held too close to the heart, hmmm”. David founded CORD in 1981. By 1984, the organisation began to focus entirely on the concerns of forest-dwelling communities in Kodagu and Mysore districts. He began by working alongside Soliga Adivasis in Periyapatna in their effort to organise their community and demand nutritious food and education for their children. They eventually started an informal school in one of the villages and enrolled 45 children in a nearby government school.

Anti-Muslim Politics Has Become  
Central to the Modi Era

Having been born and brought up in a Namboodiri landlord family in Kerala’s only Muslim majority district before independence, this author has seen how, as part of untouchability, Kerala also had ‘unapproachability’. For those practicing this casteist norm, an Ezhava, part of other backward classes (OBC), must be kept off 30 feet lest the ‘upper’ caste person get ‘polluted’. For Dalits, the rule was 60 feet, and for unassimilated tribals, 100 feet. The feudal system had ruthlessly imposed these social mores before the birth of the Indian constitution. Curiously, there was no such restriction for Muslims and Christians; they could approach an ‘upper’ caste Hindu without the latter fearing getting ‘polluted’ by them. I bring this up only to underline a curious aspect of the Kerala psyche. It was casteist towards Hindus but could be ‘syncretic’ towards others. Vavar, a Muslim associate of the Sabarimala deity, has a mosque near the temple and Hindus make it a point to visit it. The 14th century Koratti Muthi church was uniquely constructed on land gifted by the local Raja. It retains many Hindu features. There are several more such cases. For those coming from a pluralistic background, it is agonising to find the mindless ghettoisation being pursued by the Modi-Shah duo as a well thought out political strategy during the past 11 years. Communal ‘othering’ is the chief instrument in their toolkit to create and maintain an assured vote bank. Before Modi, the BJP could not come to power without the support of the minority groups. “The BJP believes that Indian Muslims are an integral part of the nation,” the party had said in a 2005 political resolution, adding: “However, since Independence, the Congress has viewed Muslims purely as a vote-bank. In the process, their pressing issues such as modern education, living conditions, livelihood and women’s rights have been glossed over. The BJP reiterates its principle of justice for all and appeasement of none. The party will always remain committed to this.” “I wanted the Hinduism of Vivekananda, not the



one based on ‘narrow-mindedness,’” Atal Bihari Vajpayee had once said in a taped speech in 2002. One may debate the sincerity and meaning of those words but the language of the BJP today is markedly different. Indeed, the Modi regime has been openly using Hindu-Muslim conflict as its winning strategy. That is the crucial difference between the two approaches: Modi and the previous BJP leadership. Consider the Modi-Shah regime’s single-minded efforts at saffronisation of history textbooks, elimination of opposition voters, imposition of Hindi, Nazi-style detention camps along borders, mandating the singing of Vande Mataram in Bengal’s madrasas, media control, concentration of powers through rule changes. The list is rather long. All this leads to political, administrative and judicial manipulation. The Modi-Shah regime seems to have no ‘illusion’ about Muslim support for the BJP. For instance, 38% of Assam’s population is Muslim, but there is none among the 102 new BJP MLAs in

the Himanta Sarma government. On the contrary, of the 19 Congress MLAs in the assembly, 18 are Muslim. In the past five years, the Modi government did not have a single Muslim minister or MP. This is deliberate ghettoisation, keeping a whole section of the polity outside of politics. Political observers also fear that the Modi-Shah regime intends to introduce some kind of separate electorate for the minorities. Such administrative measures get prompt support from the Hindutva groups at the ground level. For instance, every religious festival, Hindu or Muslim, is an occasion for heightening communal tension: Muharram, Id, Diwali, temple festivals and processions like Kawadias are used for creating communal tension. When the dates of festivals clash, it is all the more delightful for hate mongers. The VHP and other Hindutva groups take objection to Muslim artisans preparing the kits and costumes for kawariyas. The Supreme Court had to intervene when some BJP

governments ordered a ban on Muslims traders setting up shops along the route. Uttar Pradesh chief minister Adityanath, the most virulent anti-Muslim chief minister, recently warned Muslims against holding namaz in public places. When reminded there was hardly any place available to accommodate all of them, he advised them to control their population. His latest drive has been to shut Varanasi’s decade old Eid-eve goat market. In Kolkata, Amit Shah’s newly captured region, fresh curbs were imposed on Eid namaz this year. The venue was shifted and no public slaughter of animals allowed. In Maharashtra, ‘pig worship’ and a ban on goat sacrifice have been the highlights of pre-Eid harassment this year. Pig worship by Hindutva ardents in Muslim areas was reported from Mumbai, Delhi and West Bengal. The BMC also revoked permission granted for goat sacrifice. Goats were removed from residential areas in Thane

and a housing society cluster in Mumbai. A favourable high court judgment was used by Hindutva hardliners on the basis of a revised report by the ASI – a government department – on the Bhojshala dispute. The next in the firing line is the Kasmandi dispute. Earlier this year, the BJP’s Andhra Pradesh ally Chandrababu Naidu had announced cash incentives for couples having third and fourth child. This was to raise the state’s population. Later, the VHP urged Naidu to confine the incentive to Hindu parents, not Muslims. With almost the entire domestic media toeing Amit Shah’s blackout dictum, it will be rewarding to have a look at the much maligned foreign media. And most of them provide what our domestic media try to hide from the readers. In a lengthy piece with on-the-spot details, The New Yorker concluded that a “populist Prime Minister has legitimized India’s more militant groups”. Clearly, targeted attacks on minorities are on the rise, it found giving details.

The Most Dangerous Thing About Vaibhav  
Sooryavanshi Isn't Really His Age

Some batters have great technique; others have extraordinary power. Vaibhav Sooryavanshi sits in the intersection of technique and power because he seems to have more time than everyone else to play a ball. By the time the ball leaves the bowler’s hand, it almost feels like he already knows what he’s going to do. While everyone else is still reacting, he’s locked onto the ball, perfectly balanced, and his hands seem to find the right position without any hesitation. Every movement unfolds with the natural progression of Beethoven’s symphony. The best batters in the world are often defined by this tiny ability to pick up tiny clues before anyone else does, process information faster and turn them into a decisive advantage. It’s a rare combination of vision, anticipation, timing, and instinct-traits that defy simple explanation. Beyond all the runs, records, and accolades, what separates him is an almost uncanny understanding of the game as it unfolds. The kind of instinct that suggests he is not merely playing the game, but reading the bowler like a mentalist. His efforts and his approach have earned him a ticket to UK this summer for T20s against England, Ireland, and as well as in the Asian Games Team. Sooryavanshi thereby becomes the youngest Indian, even younger than Sachin Tendulkar, to be inducted into the Indian Cricket Team.

**The USP Of IPL Is No More King Khan**  
In 2008, somewhere in the middle of the first season of



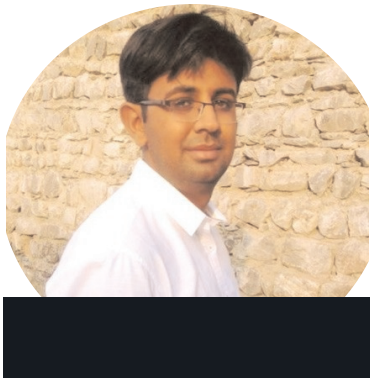
IPL, Shah Rukh Khan, the celebrated owner of Kolkata Knight Riders and Bollywood Badshah, had told NDTV, “I am the USP of IPL.” Enter the next-generation software-installed humanoid called Vaibhav Sooryavanshi, the Bollywood superstar would perhaps agree that the USP of IPL has now shifted. Jos Buttler, in fact, said, “Sooryavanshi was the IPL this year”. Nineteen seasons later the baton changed hands and now it is well and truly with the Bihari boy. Sooryavanshi is perhaps the single biggest brand to emerge out of Bihar. The most revealing thing about him is his unhurried approach.

**The Boy Who Has Extra Time**  
The ball leaves the bowler’s hand at the same speed it does for everyone else, yet Sooryavanshi often appears to inhabit a different zone. There is an extra beat before he commits. An extra fraction of a second before the bat comes down. An extra layer of

information being processed. Remember when he took down Pat Cummins for three successive sixes? The best batters do not simply react, they read the situation. And Vaibhav Sooryavanshi appears to read cricket in a language few others can speak. His father, Sanjeev Sooryavanshi, says, “Whenever he played, older boys would call him a kid. If I told him a particular bowler was the opposition’s biggest bowler, he would target that bowler. Vaibhav would say, “Papa, if I hit him for a six, the other bowlers won’t dominate me.” That has always been his strategy. He wants people to know him for his cricket, not judge him by his age.” That is why many international coaches who have watched him closely rarely begin with his age - they begin with perception. One international coach who observed him during his developmental years described elite batting as existing at the intersection of

vision, timing, balance and instinct. Great players, he argued, seem to receive information from the ball that others do not. In that framework, Sooryavanshi is not merely a talented batter. He is the point of intersection. The easiest mistake to make with a player this young is to focus entirely on the extraordinary acceleration of his career. A Ranji Trophy debut at 12. India Under-19 selection at 13. A hundred against Australia Under-19 in Chennai that left franchise scouts scrambling for reports and phone numbers. An IPL auction became a bidding war. The chronology of events that had unfolded up until this point made experienced coaches, scouts and talent evaluators speak about him with unusual conviction.

**That Boy From Tajpur**  
Former Bihar cricketer and Rajasthan Royals scout Samar Qadri remembers hearing whispers about a boy from Tajpur in Samastipur long before the wider cricketing world discovered him. In a local match in Patna, Qadri, who is a leg spinner bowled to him and watched the teenager dismantle attacks with a confidence that felt entirely disproportionate to his age. “He told me I don’t play bowlers, I play balls,” Qadri recalled while speaking to NDTV. The clue to understanding this teenager is embedded in that sentence. Most young players become overwhelmed by reputation. They see international bowlers, senior professionals, established names and historical achievements.



Whenever corruption, black money, and disproportionate assets are discussed in the country, a question repeatedly arises in the minds of ordinary citizens: when will a comprehensive and impartial investigation of assets be conducted? The luxurious mansions, expensive farmhouses, multi-story buildings, and real estate worth crores of rupees that are being built in urban sectors, posh colonies, and developed areas often leave people wondering. Citizens’ faith in democracy remains strong only when they believe that the law is equal for all. If a person becomes wealthy through their hard work, talent, business, employment, or investments, this is a testament to their success and should be respected. However, when an unusual discrepancy is observed between a person’s income and wealth, calls for investigation become natural. Acquiring wealth is not a crime, but its legality and source must be clear. This is the foundation of good governance and accountability. Today, most Indian cities have developed areas where mansions and buildings worth crores of rupees stand. Most of these assets must have been acquired

through legitimate means. There are millions of businessmen, industrialists, doctors, engineers, teachers, scientists, and entrepreneurs in the country who have achieved economic success through years of hard work and struggle. Doubting their hard work and achievements would not only be unfair but also send a negative message to society. However, it is equally true that in some cases, there is a discrepancy between the size of assets and declared income, which raises questions. An impartial investigation in such cases is a necessity of the democratic system. The common citizen’s concern isn’t just about wealth, but also about the inequality that exists within society. On one hand, middle-class families struggle to build a home, investing their entire life’s savings, taking out bank loans and paying installments over years. On the other hand, some individuals amass immense wealth in a short period of time. When this disparity becomes so stark, questions arise. If these questions aren’t answered through transparent investigation and accountability, distrust of the system grows. In any democratic society, greater trans-

parency is expected from those holding public office. Government officials, elected representatives, and those involved in the management of public resources are custodians of the public trust. Therefore, details of their income and assets should be more clear and public. If a public servant acquires assets commensurate with their legitimate income, they need not fear any investigation. Rather, such investigations can serve as a means of verifying their integrity. However, if irregularities are found, it is equally important to bring them to justice. The problem isn’t limited to declared assets. Benami property also poses a significant challenge to the country. Often, the true owner registers their property in the name of a relative, employee, or acquaintance. This makes it difficult to trace the true ownership and source of the funds. The government has enacted laws to prevent benami transactions, but their effective implementation remains a challenge. The goal of financial transparency will remain unfulfilled until the true beneficiary of the property is identified. From a technological perspective, asset verification is now much easier than ever before.

# West Asia crisis, oil prices to drive stock market this week

**New Delhi:** Stock market this week will track simmering tensions in West Asia, its impact on crude oil prices, and the trading activity of foreign investors, analysts said. The trading week may begin on a cautious note following a sharp decline in the US markets over the week-end, an expert said. Besides, progress of monsoon and inflation data announcement will also be important factors to watch out for. "This week will be driven by key inflation, and global macroeconomic data releases. In India, investors will closely track inflation data for May, scheduled for release on June 12, along with foreign exchange reserves data on the same day. "Globally, developments around the US-Iran negotiations and their implications for crude oil prices, currency movements, and overall risk sentiment will remain in focus," Ajit Mishra, SVP, Research, Religare Broking Ltd, said. US markets ended sharply lower on Friday, June 5, with the Nasdaq Composite tumbling 4.18 per cent. The S&P 500 dived 2.64 per cent and Dow Jones Industrial Average declined 1.35 per cent. "The week ahead is likely to begin on a



cautious note following a sharp decline in global markets, particularly AI-related technology stocks. On the positive side, domestic markets have some supportive factors in the form of resilient GDP growth, strength in the rupee following the RBI policy announcement, and a meaningful decline in crude oil prices," Santosh Meena, Head of Research at Swastika Investmart Ltd, said. Developments on the US-Iran front remain highly fluid and continue to generate volatility in global markets, he said. "This week will also be data-heavy, with sev-

eral important macroeconomic releases from both the US and China. Among them, the US inflation data scheduled for Wednesday will be particularly critical, as it could significantly influence expectations regarding the Federal Reserve's future policy path and set the tone for global markets," Meena added. Last week, the BSE benchmark Sensex declined 532.4 points, or 0.71 per cent, and the NSE Nifty dipped 181.05 points, or 0.76 per cent. "The Nasdaq fell 4 per cent, marking its worst single-day decline since April 2025, as investors aggressively

reduced exposure to semiconductor and technology stocks. Given the significant weight of IT in Indian indices, this weakness could spill over into domestic markets and keep sentiment under pressure during the early part of the week," Hariprasad K, Research Analyst and Founder, Livelong Wealth, said. Globally, the key event to watch will be the US CPI inflation data, he said, adding that a softer-than-expected reading could revive hopes of future Federal Reserve rate cuts and improve risk appetite across global mar-

kets. Domestic commodity markets ended the week lower, with MCX gold futures for August delivery falling Rs 5,317, or 3.3%, to Rs 1.55 lakh per 10 grams. Silver for July delivery fell Rs 18,461, or 7%, to Rs 2.48 lakh per kilogram on the Multi Commodity Exchange (MCX). "Gold witnessed a weak performance last week as rising crude oil prices diverted market attention away from safe-haven assets," Jateen Trivedi, VP Research Analyst, Commodity and Currency, LKP Securities, said. The rupee strengthened against the US dollar, adding further pressure on precious metals. As a result, domestic bullion underperformed than its international counterpart, with currency gains offsetting part of the support from global gold prices, he added. In the global markets, Comex gold futures shed \$27.7, or 5%, to end the week at \$4,365 per ounce, while silver fell \$6.77, or nearly 9%, to \$69.10 per ounce. Gold prices faced pressure in the overseas trade and closed the week down nearly 55, while silver, too, sold-off sharply tracking a sharp corrective move in industrial metals, Mer said.

## Coal stock in Singareni falls to lowest level in 10 years

Hyderabad: State-owned Singareni Collieries Company Limited (SCCL) on Saturday, June 6, said its coal stocks stood at 26.51 lakh tonne as of June 4, the lowest level recorded in the past decade. In a statement, the company said coal stocks are maintained as part of routine mining and transportation operations and are essential for ensuring uninterrupted supplies to thermal power stations, particularly during the monsoon season. According to SCCL, coal stockpiles at mines and coal handling plants averaged around 50 lakh tonne annually between 2014 and 2024. The company said stocks had touched 70 lakh tonne in 2015-16 and 74 lakh tonnes in 2016-17. SCCL said thermal power stations require a minimum reserve of around 30 lakh tonne, sufficient for about 15 days, to ensure uninterrupted electricity generation during periods when production or transportation may be affected. Site-visit norm introduced after contract disruptions The company also clarified that the site-visit certificate requirement for overburden removal tenders was introduced to ensure contractors fully understand local mining, geographical



and logistical conditions before bidding for projects. According to SCCL, some contractors in the past had either slowed down or abandoned projects midway after underestimating local conditions, affecting coal production targets and leading to financial and legal complications. It cited instances in the Srirampur OC-2 and IK Open Cast projects where contractors allegedly failed to properly assess site conditions, resulting in disruptions to overburden removal works. The site-visit certificate requirement was introduced in May 2025 and is intended to help bidders assess project conditions, safety requirements and work scope before quoting rates, SCCL said. The com-

pany added that similar provisions are followed by several public and private sector organisations, including mining and infrastructure companies, and that tenders awarded after the introduction of the rule have progressed without major issues. ACB probe into medical board continues SCCL also said an Anti-Corruption Bureau (ACB) investigation into alleged irregularities involving medical boards was continuing following complaints from both affected persons and the management. The company noted that two persons have already been arrested in connection with the case and said the probe was being conducted by the ACB.

## The gamers taking on the industry to stop it switching off games

Can a company take away something you've already paid for? In the world of online video games, some already do. Publishers can decide to switch off a game's servers, often leaving it effectively unplayable. Stop Killing Games, a growing consumer rights campaign started by American YouTuber Ross Scott in 2024, is challenging that practice. In January, the group submitted a petition featuring nearly 1.3 million signatures to the European Commission, triggering a public hearing in the European Parliament in April. What began as an online campaign is now awaiting a decision from one of the EU's most powerful institutions. Scott's campaign began following an announcement from the major studio Ubisoft, saying it would shut down the online-only racing game The Crew in 2024. The French company said it was taking the game, which attracted more than 12 million players during its lifetime, offline, citing "upcoming server infrastructure and licensing



constraints". For players such as Chemicalflood, who told me he had been playing The Crew for nearly a decade, the move - which left the game unplayable - felt personal. "I was around 18 at the time of the launch - it was a big part of my adult life growing up," he said. "It was a great escape from hardship at the time, so it has always been something special to me." Over the years, he said, the game became something he shared with his children, who enjoyed exploring its virtual recreation of the United States. "The shutdown itself wasn't upsetting," he explained. "But

how they handled it was the kick in the teeth." For Chemicalflood and many fans like him, the issue was not that Ubisoft ended support. It was that players lost access altogether. The announcement from Ubisoft caught the attention of Scott, also known online as Accursed Farms, who had already been creating content around the issue of ownership around games for several years. "I just hate seeing creative works effectively destroyed," he told me. He quickly decided to start a campaign, naming it Stop Killing Games - the killing referring to when "every

copy of that game that's ever been sold has been disabled, and no one on the planet can run it". Whammy4, a gamer who founded the fan community The Crew Unlimited and helped lead efforts to preserve the game after its shutdown, likened it to "someone just breaking into your home and stealing your bike or your car". "You buy a physical copy of a game, you bring it home and install the game, you play it for some amount of time. Then all of a sudden the publisher completely destroys all copies of the game worldwide, including yours." "No refunds, no actual heads-up at the time of purchase, and nothing you can do to keep it at all," he said. Industry response Ubisoft has already defended its position in court. Responding to a proposed class-action lawsuit brought by two The Crew players in California, the studio argued that customers had purchased a licence to use the game, not unlimited ownership rights, and that players had been warned online services would not be available forever.

## APEDA Facilitates First Export of Fresh Mangoes from Jharkhand to United Kingdom

In a significant development for agricultural exports from Jharkhand, the Agricultural and Processed Food Products Export Development Authority (APEDA), under the Ministry of Commerce and Industry, flagged off the first commercial consignment of fresh mangoes from the State to the United Kingdom. The flag-off ceremony was held in Kolkata on 4 June 2026. The consignment comprises 1.5 metric tonnes of fresh Amrapali mangoes sourced from Beura Farmer Producer Company Ltd., an all-women Farmer Producer Company (FPC) located in Bano Block of Simdega district, Jharkhand. The consignment is being exported by M/s JGB Agrofresh Pvt. Ltd., Kolkata, to London, United Kingdom. The export follows an



Export-Oriented Capacity Building Programme organized by APEDA on 5 May 2026 for Farmer Producer Companies (FPCs), Farmer Producer Organisations (FPOs) and progressive farmers of Simdega district. The programme focused on export requirements, quality standards and market opportunities. Subsequently, APEDA facilitated linkage between Beura Farmer Producer Company Ltd.

and M/s JGB Agrofresh Pvt. Ltd. for procurement of export-quality mangoes from the district. The present shipment is the outcome of this initiative. The linkage has enabled direct participation of the FPC in the export value chain and provided market access for its member farmers. The farmers associated with the FPC realized higher returns for their produce compared to prevailing domestic market prices.

## Indian households continue to pay among the lowest cooking gas prices in the world

The Indian household continues to buy cooking gas much cheaper than the household in any neighbouring country, and far below the price paid in advanced economies such as the United States, Australia and Canada. A beneficiary of the Pradhan Mantri Ujjwala Yojana (PMUY) pays an effective 642 for a 14.2 kg cylinder, and the general consumer in Delhi 942, against a cost to supply that has now risen to over 1,600. The prices of petroleum products in India are linked to the corresponding prices in the international market. The Government, however, continues to modulate the effective price to the consumer for domestic LPG. Any household can buy as many cylinders as it needs at 942. A PMUY beneficiary will additionally receive the direct benefit transfer of 300 a cylinder on the first four refills each year — broadly the average annual consumption of a typical Ujjwala household, about four refills a year — and so pays an effective 642 on those refills; this support is unchanged. Even a non-PMUY household would pay about 700 below the market-linked cost of the cylinder. Retail prices differ marginally across locations on account of distribution costs.



What the household does not bear the brunt of is the several hundred rupees a cylinder which the Government is bearing. Through a period of sharp international cost increases, that burden has been absorbed upstream rather than passed to the consumer. A pass-through that has been held back The commercial cylinder used by hotels and businesses is revised automatically every month, because its price is a direct pass-through of the international benchmark. The domestic

cooking cylinder is not. India used to import 60 per cent of its LPG requirements, and the landed cost of that import tracks the Saudi Contract Price (CP) that Saudi Aramco sets at the start of each month. This is an external price over which the Indian consumer has no control. Through the West Asia disruption the benchmark moved sharply higher. Expressed as the 50:50 propane-butane blend used for India's LPG, the Saudi CP for LPG stood at about US\$543 a tonne in February, before

the disruption. Following the closure of the Strait of Hormuz in late February, the April contract price — the first set after the disruption tightened Mideast Gulf exports — rose to US\$775 a tonne, with propane at US\$750 and butane at US\$800, and has since edged up further to US\$790 a tonne in June. The blended LPG benchmark has thus risen by about 46% since the pre-crisis February level. The cost of the imported molecule rose with it. The cost a consumer is not asked to pay Following the June contract price, the cost of supplying a 14.2 kg cylinder, were it priced on an import-linked basis, has risen to over 1,600. The under-recovery now absorbed on each domestic cylinder is about 700. The scale of this is visible in the fully market-priced commercial cylinder: the 19 kg cylinder used by hotels and restaurants sells in Delhi at 3,113.50, about 164 a kg, after five increases during the West Asia crisis. The domestic household, by contrast, pays about 66 a kg after the revision. Commercial gas carries a higher rate of tax and larger margins, so it sits above the household's cost-reflective level; even so, the import-linked cost of a domestic cylinder works out to over 1,600.

# Zelensky criticises 'vile' Chornobyl drone strike ahead of London talks

UK Prime Minister Sir Keir Starmer will host Volodymyr Zelensky in Downing Street later on Sunday, alongside French President Emmanuel Macron and German Chancellor Friedrich Merz, for talks on European support for Ukraine. Ahead of the meeting, Kyiv officials said a Russian drone had hit a storage facility for spent nuclear fuel near the Chornobyl nuclear plant in the north of Ukraine. They said a fire was put out and there were no injuries, with officials adding that radiation levels remained stable. Zelensky labelled it a deliberate and "vile Russian strike". Separately, at least three people were killed in a Russian strike in a village outside Zaporizhzhia in the south-east of the country, authorities said. Zaporizhzhia has come under relentless Russian attacks recently, with at



least two people killed there on Saturday. The Russian strike on Chornobyl "partially destroyed" a spent nuclear fuel storage building, according to Ukraine's state-owned nuclear operator, Enerhoatom. The operator said there were no injuries, and a fire in the building was put out, adding

that radiation remained at a normal level. The body also criticised Moscow for what it called a deliberate threat to nuclear safety, in words echoed by Zelensky. "Russia deliberately struck this particular nuclear infrastructure facility," Zelensky said in a post on X, describing the building as an "as

extremely critical infrastructure facility" and the attack as "vile". He went on to detail Russian overnight strikes in 13 regions, adding that Moscow had launched 88 missiles, more than 3,250 drones and 1,800 guided bombs over the past week. On Saturday, Ukraine targeted St Petersburg and the

surrounding area as the city hosted the final day of a major economic forum, in a drone attack described as "unprecedented" by Russian authorities. Days earlier, Kyiv had attacked the outskirts of the same city - some 1,000km (620 miles) from Ukraine - as Russian President Vladimir Putin's flagship forum was getting started, sending a large plume of black smoke over the city's skyline. In the four years since Moscow's invasion began, Ukraine has developed its defence sector, with Kyiv now able to regularly hit targets within Russia. The three Western powers represented at Downing Street - the so-called E3 group - are some of Kyiv's strongest allies. The UK and France lead the "coalition of the willing" initiative to provide security guarantees for Ukraine as part of a future potential peace process. The group had previously con-

vened in London in December, at a time when the US was pushing hard for Moscow and Kyiv to sign up quickly to a plan to end the war in Ukraine. Since then US efforts to mediate a truce have petered out, and Washington's focus has shifted to the Iran war. On Friday, Putin rejected a proposal by Zelensky for face-to-face talks on ending the war, saying he did not see any point in meeting the Ukrainian leader. Zelensky sent an open letter calling for a direct negotiations, writing that it would be "wrong to simply wait" for the conflict to once again become the focus of US attention. Speaking at the economic forum on Friday, Putin refused the request for a meeting with Zelensky and reiterated his position that a truce would only allow Ukraine to regroup. He said he would only end the war when Russia's goals had been met.

## INSECURITY AND INSTABILITY DRIVE VOTERS IN PERU'S TIGHT PRESIDENTIAL RACE



"If you don't meet our demands, we will kill your drivers." This message, demanding about \$15,000, was sent by a criminal gang to a bus company in a poor suburb of Peru's capital, Lima. It preceded an armed attack on bus driver, Toño. "They shot me in the legs and abdomen. I was out of work for four months, now I work with fear. Although my wounds are dry, internally I feel pain," he says. Toño's case was one of nearly 30,000 extortion incidents reported in Peru in 2025, many targeting small businesses or transport workers. This issue, along with rising homicides, is why insecurity and crime have

become top concerns for voters in Sunday's presidential election in Peru. The right-wing Keiko Fujimori, daughter of the late former president, Alberto Fujimori, is running for a fourth time against left-wing Roberto Sánchez. Fujimori has defined her campaign with an array of "tough-on-crime" policies, while Sánchez has promised sweeping changes to the state and higher public spending. In Lima's suburb of San Juan de Lurigancho, dusty hilltop neighbourhoods sprawl precariously down the slopes. Armed police guard the gate to the bus depot where Toño works.

## Hegseth attacks Europe over migration with beach 'invasion' D-Day speech



US Defence Secretary Pete Hegseth has criticised European nations over migration for allowing what he described as an "invasion" on their shores, during a D-Day anniversary speech in France. Hegseth was speaking in Normandy 82 years after allied forces stormed French beaches to liberate Nazi-occupied Europe in 1944. "Sadly, today, different European beaches are stormed by different dangerous ideologies," Hegseth said. "Beaches in Spain, in Italy, in Greece and Bulgaria. Boats and men arrive. When will European capitals do something about that invasion?" Migration has become a major political issue across Europe, with parties supporting hardline immigration policies surging in polls. The Trump administration sees an immigration crackdown as a key part of its domestic policy agenda, requesting billions more in funding for enforcement agencies. Hegseth's comments mark

a further criticism of European migration policy by senior members of the Trump administration. On Friday, US Vice-President JD Vance blamed the death of the 18-year-old British student Henry Nowak, who was fatally stabbed last year in Southampton by Vickrum Digwa, on the "mass invasion of migrants" and said the "only response" was "righteous anger". Downing Street responded by criticising "people trying to interfere in our democracy," adding that the Nowak family had "said they do not want his death to be used to create further division". And Deputy Prime Minister David Lammy told the BBC's Laura Kuenssberg that "politicians should be very careful and very cautious" about their language. "We're in this new online space that can rapidly become toxic," he explained, adding that concerns around Henry Nowak's case had become a "global" issue because of the "viral" footage of his arrest.

## HUNDREDS OF CAPTIVES FREED FROM BOKO HARAM MOUNTAIN HIDEOUT



At least 360 people kidnapped by Boko Haram jihadists from a mainly Muslim community in Nigeria's north-eastern Borno state in March have been freed from a remote mountain hideout. The circumstances of how they were freed are disputed. The army says it had launched an unprecedented intelligence-led operation that had

been weeks in the planning and taken the Islamist militants by surprise. But a local group, the Borno South Youth Initiative, says it mediated the unconditional release, putting the number of those freed at 416. Mass abductions by armed groups for ransom have become a common tactic in Nigeria in recent years - and though it is illegal to pay ransoms.

## STEVE ROSENBERG: Russia's economic forum overshadowed by drone attacks on St Petersburg

An evil sorcerer is the last person you'd expect to see at an economic forum. But there he stood working his wizardry. With sleight of hand Russian folklore villain "Koshchei the Deathless" (or, rather, someone dressed as him) produced coins out of thin air, "broke" and reassembled someone's glasses and shocked passers-by with occasional puffs of smoke from his fingers. "Russians are unpredictable people," he declared. "We do things no one expects." Perhaps. But in St Petersburg this week, the unexpected was delivered most dramatically by Ukraine. Ukrainian drones attacked the St Petersburg area on the opening - and closing - days of the set-piece



International Economic Forum (SPIEF). The abiding image of SPIEF 2026 will be the huge plume of thick black smoke which dominated the St Petersburg skyline on Wednesday. Without specifying what was hit, local officials admitted that drones had damaged "infrastructure". All the delegates saw the smoke as they arrived at

the expo centre on the edge of the city. Few could have predicted what came next. Volodymyr Zelensky published an open letter to Vladimir Putin. Ukraine's president taunted Russia's leader about his age and about Russian setbacks in the war but proposed the two leaders meet in a neutral country to talk peace. President Putin's

response? Nothing unpredictable about that. The Kremlin leader, who had rejected previous calls for direct talks with President Zelensky, criticised the letter's "rude" tone and dismissed the offer. "It's not the author of the letter I need to respond to," President Putin said, "but our soldiers on the frontline...I say to them: keep at it, brothers!" Vladimir Putin is not ready to end Russia's war on Ukraine. Not unless it's on his terms. I listened to what he said at the forum's plenary session. There were few surprises. The Putin we saw is the Putin we expected to see - uncompromising, unrepentant, determined to project an image of strength and unwavering conviction.

## ARMENIA VOTES AS RUSSIA PILES PRESURE ON PRO-WEST GOVERNMENT

Voting is under way in Armenia in an election which could decide whether the country continues edging towards the West, or returns to its traditional ally Russia. The small South Caucasus country of three million people has been under mounting economic pressure from Moscow, as Prime Minister Nikol Pashinyan seeks re-election on a promise of European integration. The election has drawn significant international attention to Armenia, which has steadily grown closer to the West while still intertwined with Russia, its largest trading partner. The rapprochement with the West is largely Pashinyan's doing.



Since coming to power in 2018, the prime minister has steered his country away from Moscow, passed a law to launch the process of joining the EU, and accelerated the peace process with neighbouring Azerbaijan via a US-brokered agreement. The latter

has won him US President Donald Trump's endorsement. Pashinyan also hosted a large summit of EU leaders and Ukrainian President Volodymyr Zelensky in the capital, Yerevan, earlier this year. Yet despite these successes, Pashinyan's domestic

support has fallen from 54% in 2021 to around 30% today. The main reason is Nagorno-Karabakh, a mountainous enclave inside Azerbaijan that was home to 100,000 ethnic Armenians until Azerbaijan took it by force in 2023. Pashinyan's critics have never forgiven him for making concessions in favour of peace with Azerbaijan, like refusing to campaign for the release of former leaders of Nagorno-Karabakh who are in jail in the neighbouring country. The peace deal with Azerbaijan, too, remains deeply divisive, with one recent poll showing 44% of public opinion in support and 41% opposed.

Aguilar said he started recording on his phone and then heard gunshots. He then ran from the area, he said, but eventually returned to find his own friends and saw several injuries from the shooting. Police Lt Dan Gerken expressed shock at the level of violence. "Twelve people being shot, that's the most I've been to a scene. I've been to a lot of scenes, but this is way over the top," he told reporters. Gerken said police were talking to victims and witnesses and reviewing camera footage. He appealed for help from locals. ## 'It was either killed or be killed' - ongoing nightmares of an ex-child soldier in Somalia

The 34-year-old became embroiled in the Islamist insurgency, which erupted nearly 20 years ago, and while the city's urban landscape is healing, few resources are devoted to those still suffering with the psychological scars of the conflict. When he was 14 years old, a coalition of Sharia courts seized power in Somalia and provided some sense of stability in a country that had been riven by devastating clan warfare since the regime of President Siad Barre collapsed in 1991. But the Union of Islamic Courts (UIC)

marked the first instance of political Islam gaining a foothold in the African continent since al-Qaeda's 11 September 2001 attacks on the US. Policymakers in Washington viewed the UIC with hostility, accusing it of having ties to al-Qaeda. Its military youth wing was known as al-Shabab, meaning "The Lads". In December 2006, thousands of Ethiopian troops invaded Somalia under the cover of American drones with the aim of toppling the courts just six months after they had taken over. Ethiopia's invasion was deeply unpopular in Somalia and was met with fierce opposition as al-Shabab and its allies, including a coalition of splinter groups known as the Muqawama, meaning "Resistance".

# FIFA Allows Water Bottles In World Cup Stadiums In USA And Canada

After days of confusion and multiple u-turns, FIFA has finally allowed fans to bring one soft plastic water bottle into stadiums during the World Cup that starts 11th of June. Football's governing body faced criticism after repeatedly changing its position. Fans and politicians have accused FIFA of commercialising even basic necessities like water, forcing supporters to pay for them inside venues. The latest "clarification" of FIFA's water bottle policy came just a couple of days after it said refillable water bottles would not be allowed. The approach mirrors policies followed by bodies such as the ICC and BCCI in India, where spectators are not permitted to bring water bottles from outside and are instead required to purchase them inside stadiums at higher prices. FIFA faced intense criticism from fans and politicians across several countries. Toronto Mayor Olivia Chow



described FIFA's decision to ban outside water bottles as a "pure money grab". Her city will host six World Cup matches. British Prime Minister Keir Starmer also criticised the policy, calling it "wrong" and suggesting it was primarily about revenue, as fans who had already paid high ticket prices were being forced to buy expensive water inside stadiums. After several U-

turns, FIFA has now introduced a new policy allowing water bottles inside stadiums in the United States and Canada. "All fans will be permitted to bring in one soft plastic 20-ounce (590ml), factory-sealed disposable water bottle into any FIFA World Cup 2026 match in the USA and Canada," World Cup chief operating officer Heimo Schirgi said in a video posted on FIFA's X account.

However, FIFA has yet to clarify whether the same rule will apply in Mexico, raising the possibility that fans attending matches in Mexico City, Monterrey and Guadalajara may not be allowed to bring water bottles into venues. Last week, FIFA had said it would allow transparent plastic bottles of up to one litre in capacity, which supporters could refill at fountains inside stadiums.

That policy has since undergone two further changes. So what is the fuss about? Fans argue that FIFA is effectively forcing them to buy drinks from concession stands inside stadiums. FIFA receives a significant share of concession revenue, while its soft-drink partner Coca-Cola will be selling both its sodas and bottled water brand Dasani at World Cup venues. However, New York City Mayor Zohran Mamdani welcomed FIFA's latest reversal. "I'm glad that FIFA decided to reverse this policy and allow water bottles to be brought into World Cup games. "No one should have to fear being priced out of staying hydrated, especially fans who are often waiting for hours before a game in extreme heat." So why is FIFA restricting water bottles in the first place? The governing body has defended the policy on safety grounds, saying it is intended "to prevent risk and injury to players and attendees."

batting or are we presiding over the permanent evisceration of the contest between bat and ball?" Chappell wrote. "When studying Sooryavanshi in full flight, one is immediately struck by a technical purity that elevates his work above the crude, muscle-bound power-hitting of the modern era. His clean, uninhibited bat swing possesses an organic symmetry that evokes cricket's finest aestheticians. In his elegant downswing and flawless balance, there are distinct echoes of the great Graeme Pollock and the incomparable Sir Garfield Sobers. When he slashes

across the line or lofts over extra cover, one glimpses the ferocious, instinctive genius of Brian Lara, combined with the devastating, ball-one intent of Adam Gilchrist." "It is a classic, pure method being deployed with contemporary violence, proving that his talent is a rare gift to the game. However, his unprecedented success at such a tender age serves as a profound warning sign." Chappell went on to point out that the dominance shown by Sooryavanshi shown against top bowlers in the IPL 2026 also shows a 'systemic illness' within the sport.

Antonelli's sensational lap came at the end of a sequence of dramatic laps in the final seconds of a classic session as, in turn, Ferrari's Charles Leclerc,

Verstappen and then the precocious Italian clocked pole laps. "I am very happy with that and massive thanks to the team because yesterday we struggled a little bit and today we were able to improve massively," said Antonelli, who last year finished 18th, three laps down on a triumphant Lando Norris of McLaren. "I think this is one of the most intensive, if not the most intense qualifying of the year and it takes a massive effort – and also the practices because you just keep trying to get close to the limit. "When it is about finding the last two tenths, it is not easy because the walls start to come closer and it is not easy to gain the confidence, but I felt great this morning and I am happy that we could finish the job today." He said despite mounting media attention and speculation, he had not felt any increased pressure. "For sure, I am just enjoying the driving, enjoying the car, enjoying the weekend," he said, with a customary grin.

## INDIAN NOLAN FANS FEAR ODYSSEY CUTS

Christopher Nolan's upcoming film Odyssey is already facing growing discussion in India even before its release on July 17, with censor fear trending among movie enthusiasts. The concern mainly stems from the film's R-rated classification in Hollywood, which often includes mature themes, intimate scenes, and strong visual content. Audiences in India are now worried that the Central Board of Film Certification (CBFC) may trim or modify several sequences to meet local guidelines. In past Hollywood releases, including major titles like Oppenheimer, Indian censors have removed or altered scenes involving nudity, intimacy, and smoking before granting certification, changing the viewing experience. Since Odyssey is associated with Christopher Nolan, expectations are even higher, as his films are known for immersive storytelling
