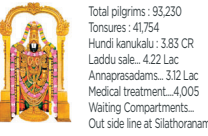

Internet suspended as Jaipur launches major anti-encroachment drive

Jaipur (TSIT): Internet services were suspended and more than 3,000 police personnel deployed across Jaipur on Monday as the Jaipur Development Authority (JDA) launched a large-scale anti-encroachment drive in the city's Jagatpura area.

The operation is part of a long-pending road-widening project on Nandpur Road, where authorities aim to expand a 1.5-km stretch running parallel to the railway line from its existing width of around 25-30 feet to the sanctioned width of 80 feet.

The Jaipur district administration said mobile internet services were temporarily suspended as a precautionary measure to prevent the spread of rumours and inflammatory content on social media that could affect law and order during the demolition exercise.

The drive includes the removal of five religious structures located within the proposed road alignment, including a mosque, two temples, a satsang hall and a mazar. Officials said the structures had been obstructing the road-widening project for several years. Notices were issued well in advance, and occupants were given sufficient time to voluntarily remove the constructions before direct action was initiated.

Tragedy at Visakhapatnam Steel Plant

8 Workers Killed as Molten Steel Spills; Several Others Seriously Injured

A major industrial accident at the Visakhapatnam Steel Plant on Monday evening claimed the lives of eight workers and left six others seriously injured. The mishap occurred in the Steel Melting Shop (SMS) when a massive ladle carrying molten steel reportedly exploded, causing metal heated to nearly 1,600 degrees Celsius to spill onto workers. Eight workers died on the spot, while six others sustained severe burn injuries and are undergoing treatment in hospitals.

According to preliminary information, the accident took place during production operations in the Continuous Casting Department of the Steel Melting Shop. A ladle carrying hundreds of tonnes of molten steel reportedly collapsed due to a technical failure, causing the red-hot metal to spread across the shop floor. Workers on duty at the time were caught in the blaze, result-



ing in heavy casualties.

Following the incident, plant safety personnel and fire service teams rushed to the spot and launched rescue operations. The injured workers were initially shifted to the Steel Plant General Hospital and later moved to specialized hospitals in the city for advanced treatment. Doctors said the condition of several injured workers remains critical.

Prime Minister Narendra Modi expressed deep grief over the tragedy and announced an ex gratia of Rs.2 lakh each for the families of the deceased and Rs.50,000 each for the injured. Andhra Pradesh Chief Minister N. Chandrababu Naidu also expressed shock and sorrow over the incident and directed officials to ensure the best possible medical treatment for the injured. He also ordered a comprehensive inquiry into the cause of the accident.

Meanwhile, workers' unions have expressed serious concern over the incident, alleging that lapses in safety standards and inadequate maintenance were responsible for the mishap. They demanded adequate compensation for the families of the deceased and employment opportunities for their family members. Authorities have temporarily suspended operations in the affected section, and an investigation into the incident is underway.

8 candidates file nominations for seven K'taka MLC seats

BENGALURU (TSIT).

A total of eight candidates have filed nominations for the seven Karnataka Legislative Council seats from the MLAs' quota, setting up a closely-watched contest that will reflect the current strength of parties in the State Assembly. According to the Election Commission schedule, polling will be held on June 18, with counting beginning the same evening. The entire election process will be completed by June 20. The last date for withdrawal of nominations is June 11, while scrutiny will be held on June 9.

The seven seats will fall vacant upon the retirement of members, including Govinda Raju, Naseer Ahmed, N Nagaraju (MTB), K Prathap Simha Nayak, Tippannappa, Sunil Vallayapur and BK Hariprasad, whose terms end on June 30.

Sources said the ruling Congress, which holds a numerical advantage in the Assembly, is confident of securing a majority of the seats. However, the presence



of an extra candidate has introduced uncertainty over the final distribution, raising the possibility of a tight contest for the last berth depending on cross-voting and party discipline.

The Opposition BJP, which has fielded candidates as part of its strategy to consolidate its presence in the Upper House, is also banking on support from its alliance arithmetic. The Janata Dal (Secular) has also entered the fray with a surprise nomination, adding a fresh political dimension to the contest and setting up a potential triangular contest in select voting rounds.

The elections are being seen as politically significant as they will determine the composition of the Upper House at a time when key legislative decisions are pending in the State.

Political observers say the outcome will be an important indicator of cohesion within party ranks, especially in a secret ballot system where cross-voting often plays a decisive role.

Iran retaliates, fires missiles at Israeli airbases after attacks on Tehran



TEHRAN/TEL AVIV:

The Middle East edged closer to a wider regional conflict on Monday as Iran launched missiles at Israel in retaliation for Israeli strikes on Iranian territory, defying diplomatic efforts by US President Donald Trump to contain the crisis. The exchange of attacks has raised fresh concerns that months of fragile diplomacy is in tatters as fresh military confrontation is underway.

The escalation came after Trump reportedly told Netanyahu that "it's enough" and urged him not to retaliate immediately following Iran's missile attack on Sunday night.

It was the first direct exchange of strikes between Israel and Iran since a ceasefire halted the US-Israel war with Iran in April. Iran's attack followed earlier Israeli strikes on Beirut's southern suburb of Dahiya.

The latest exchange of attacks threatens to deepen tensions across the region and comes after Trump spoke with Netanyahu, urging him not to respond immediately to Iran's missile barrage. According to media reports, Trump declared, "I call all the shots," suggesting that Netanyahu should refer to Washington's diplomatic efforts. Iranian state media reported explosions in Tehran, Isfahan, Karaj, and Tabriz. Iran's Revolutionary Guards claimed that Israel used air-launched ballistic missiles during the attack. Iran subsequently closed the airspace around Tehran's Imam Khomeini International Airport, the country's main international gateway.

ED conducts raids in Rs 142-cr cross-border drug money laundering case

NEW DELHI (TSIT):

The Enforcement Directorate (ED), Aizawl Sub-Zonal Office, is conducting searches at four locations along the Mizoram-Myanmar border, the Tripura-Bangladesh border, and in West Bengal in connection with a money laundering case on Monday.

The ED case is based on a case registered by the Narcotics Control Bureau (NCB), Agartala Zonal Unit, involving the seizure of 49.101 kg of methamphetamine and 40 grams of heroin in Tripura on August 21, 2025.

The locations searched in Tripura are situated just 200 metres from the Bangladesh border, while the location in Mizoram is approximately 500 metres from the Myanmar border. The investigation has



revealed the existence of an organised cross-border syndicate that sourced methamphetamine from Myanmar through the Champhai-Zokhawthar sector of Mizoram and supplied it to receivers in Tripura.

The proceeds of crime were allegedly layered through multiple bank accounts and shell entities. According to the ED, proceeds of crime amounting to more than Rs 142 crore have been identified so far. Search operations are currently underway.

AP tailoring skill program trains 60,000 women, Targets 2 lakh beneficiaries

AMARAVATI (TSIT):

The Andhra Pradesh Government has successfully trained more than 60,000 women from Backward Classes (BC) and Economically Weaker Sections (EWS) under a major tailoring skill development initiative aimed at promoting self-employment and economic empowerment.

Implemented through the Andhra Pradesh BC Financial Corporation in coordination with various EWS Corporations, the program equips women with industry-relevant tailoring and garment-making skills, helping them build sustainable livelihood opportunities.

The initiative follows a structured 360-hour training curriculum covering



tailoring techniques, garment construction, machine operations, and entrepreneurship development. Participants who complete the training and meet attendance requirements undergo assessments aligned with National Skill Development Corporation (NSDC) standards and receive certification upon successful completion.

To support self-employment, eligible trainees are provided sewing machines and toolkits, enabling them to start tailoring services, boutique businesses, garment production units, and other income-generating ventures.

According to official estimates, trained beneficiaries have the potential to earn monthly incomes

exceeding Rs.20,000 through tailoring and related entrepreneurial activities.

The State Government has set a target of training 2 lakh women over the next three years, focusing on enhancing skills, financial independence, and women-led entrepreneurship across Andhra Pradesh.

Officials said the initiative reflects the Government's commitment to creating sustainable livelihood opportunities and strengthening the economic participation of women from BC and EWS communities. The program is being expanded across districts as part of the State's broader efforts to promote skill development and inclusive economic growth.

32 killed, buildings damaged, schools suspended after strong quake in Philippines

MANILA (TSIT)

At least 32 people were killed, numerous buildings damaged, and schools and flights were suspended after a magnitude 7.8 earthquake struck Sarangani province in the southern Philippines on Monday morning, according to local authorities. Multiple countries had issued tsunami warnings, which were later lifted.

Junie Castillo, spokesperson for the Philippines' Office of Civil Defence, said 10 victims were reported in South Cotabato's General Santos, a port city with a population of over 700,000, and at least 12 people remain missing so far. The deaths were caused by falling debris, building collapse and landslides. The Philippine National Police



earlier said that no fewer than 134 people were injured, Xinhua news agency reported.

A two-storey school building in General Santos collapsed with students trapped inside, and authorities said they are verifying details of the incident. Online videos show university and restaurant buildings collapsed in disaster-hit areas. Some commercial facilities sustained structural damage,

with signs falling and window panes shattered. Local residents rushed outdoors to seek safety. The powerful earthquake hit shortly after schools across the Philippines started reopening following the summer break. Surveillance footage from several schools captured violent shaking during the quake. Teachers and students either evacuated urgently or took shelter under desks.

Sensex falls 719 points, Nifty drops over 1 pc as West Asia tensions spike

MUMBAI (TSIT):

Indian equity markets ended sharply lower on Monday as escalating tensions in West Asia triggered a risk-off sentiment across global markets, leading to a sell-off in domestic equities amid a



spike in crude oil prices. The benchmark index Sensex declined 719.08 points, or 0.97 per cent, to close at 73,524.26, tracking weakness in global equities and rising geopolitical uncertainty. Similarly, the 50-share Nifty index fell 243.70 points, or 1.04 per cent, to settle at 23,123.

Pinarayi slams Revanth over 'Hitler inspiration' remark on HYDRAA



Thiruvananthapuram, Jun 8: Former Kerala Chief Minister Pinarayi Vijayan on Monday criticised Telangana Chief Minister A Revanth Reddy over his remarks linking the name of the Hyderabad Disaster Response and Asset Protection Agency (HYDRAA) to Adolf Hitler. In a post on Facebook, Vijayan described Reddy's statement as shocking and an insult to democratic society. "The Chief Minister of a democratic country said on the stage that Hydra was Hitler's favourite word and that his inspiration is a system capable of killing anyone like them. It is a shame that the Congress party has a Chief Minister who openly worships the biggest fascist the world has ever seen," Vijayan wrote. He further alleged that it was unfortunate for the Congress to have a chief minister who appeared to glorify a fascist figure. The controversy stems from remarks made by Revanth Reddy during an event in Bengaluru on Saturday. While explaining the rationale behind establishing HYDRAA, he said he decided to create the agency after observing widespread encroach-

ments of lakes, nalas and other water bodies in Hyderabad. Speaking about the name, Reddy said, "Hydra was Hitler's favourite word. His core team, which can assassinate anyone, was called Hydra. So, I have taken inspiration from Hitler, and I have named it HYDRAA." He added that the agency, headed by a senior IPS officer, was tasked with protecting public assets and removing illegal encroachments. The Hyderabad Disaster Response and Asset Protection Agency was established by the Telangana government in July 2024 to safeguard government lands, lakes and other public assets from encroachments and illegal activities. Since its formation, the agency has carried out several operations against alleged encroachments and demolished a number of structures said to have been built illegally. The remarks have triggered political reactions, with opposition leaders questioning the Telangana Chief Minister's reference to Hitler while explaining the agency's name and purpose.

Modi highlights poor welfare as NDA marks 12 years in power

New Delhi, Jun 8: A day after the NDA government completed 12 years in office, Prime Minister Narendra Modi on Monday highlighted the government's achievements, saying the welfare of the poor and underprivileged had remained at the centre of its development agenda. Reflecting on the journey since 2014, Modi said India had witnessed significant transformation over the past 12 years, guided by the principle of Antyodaya and a commitment to ensuring that the benefits of development reached those who had remained on the margins for decades.



"Over the last 12 years, India has witnessed remarkable change, and at the core of these developments has been the welfare of the poor and the underprivileged. Inspired by the principle of Antyodaya, our constant endeavour has been to ensure that the benefits of development reach those who had been left behind for decades," the Prime Minister said. He noted that flagship initiatives such as the Pradhan Mantri

Jan Dhan Yojana, Direct Benefit Transfer programme, Swachh Bharat Mission, Pradhan Mantri Awas Yojana, Jal Jeevan Mission and Ayushman Bharat were launched to provide dignity, opportunity and a better quality of life to citizens. In a post on social media platform X, Modi said technology had played a crucial role in improving the delivery of welfare benefits. "It is also gladdening that technology has played a vital role in ensuring a better quality of life for the poor. Through Direct Benefit Transfer and digital platforms, support is reaching people directly and transparently. This has reduced leakages, improved efficiency and strengthened trust in govern-

ance," he said. The Prime Minister added that the government's efforts towards Garib Kalyan had evolved into a broader movement focused on human empowerment and the vision of a developed India. The BJP and its NDA allies marked the completion of 12 years of the Modi government under the theme "Garib Kalyan", using the hashtag #12YearsOfGaribKalyan on social media. A government publication released on the occasion stated that welfare of the poor had remained a key priority of the Centre over the past 12 years and described the approach as one based on genuine empowerment rather than appeasement.

CM inaugurates Bachupally flyover, launches Rs. 321 crore road projects

Hyderabad, June 8: Chief Minister A. Revanth Reddy on Monday inaugurated the Bachupally Flyover and laid the foundation stone for major infrastructure projects aimed at improving connectivity and easing traffic congestion in Hyderabad's western corridor.



Constructed by HMDA at a cost of Rs.65.53 crore, the 1.30-km-long Bachupally Flyover has been built at Bachupally X Roads to facilitate smooth traffic movement between Miyapur and Gandimaisamma. The four-lane flyover, along with slip roads, is expected to reduce travel time, improve road safety and enhance connec-

tivity in the rapidly growing area. The Chief Minister also launched the proposed construction of major bridges across the Musi River near ORR Exit No. 18A. The Rs.229-crore project includes service roads on both sides of the Outer Ring Road and a

new service road connecting the interchange to Narsingi Ring Road. The project aims to address flooding, traffic congestion and connectivity issues while ensuring all-weather access to Narsingi, Kokapet and the Financial District.

World Brain Tumor Day: From Silent Symptoms to Scarless Treatment

Hyderabad: Every year, World Brain Tumor Day observed on 8th June reminds us that early recognition, timely diagnosis, and advanced treatment are paramount for management of brain tumors. In India, the burden of brain and central nervous system tumors is steadily becoming more visible. According to GLOBOCAN 2022 estimates, India recorded over 32,000 new brain and CNS cancer cases and nearly 28,000 related deaths, making this an important public health concern. The overall cancer burden in India is also projected to rise significantly in the coming years, which makes awareness and access to specialized care even more critical. Brain

tumors can affect people across all age groups. They may be benign or malignant, slow-growing or aggressive, but even a benign tumor can become dangerous if it presses on critical areas of the brain. The challenge is that early symptoms are often ignored or mistaken for stress, migraine, ageing, or lifestyle-related fatigue. There are certain red flags that should never be ignored. A headache that is new, persistent, worsening over time, or more severe in the morning needs medical evaluation. A first-time seizure in an adult is always a warning sign. Repeated vomiting without a clear stomach-related cause, blurred or double vision, hearing loss, imbalance, weakness or numbness



on one side of the body, difficulty speaking, memory problems, personality changes, or unexplained drowsiness should prompt urgent consultation. The key is not to panic, but not to delay evaluation either. Modern MRI and CT imaging can identify brain lesions early and

help specialists decide the right treatment. The encouraging news is that treatment of brain tumors has changed dramatically. Earlier, many patients feared brain surgery because it meant opening the skull, longer hospital stay, and prolonged recovery. Today, neurosurgery is increasingly precise, minimally invasive, and personalized. Depending on the type, size, and location of the tumor, patients may benefit from microsurgery, endoscopic surgery, image-guided navigation, focused radiation, or a combination of treatments. A major advancement is stereotactic neuro-radiosurgery using platforms such as ZAP-

X® NeuroRadiosurgery. This technology delivers highly focused radiation to the tumor with sub-millimeter precision, without any incision and without opening the skull. For selected patients with brain tumors, brain metastases, skull-base tumors, AVMs, trigeminal neuralgia, and certain neurological conditions, it can offer non-invasive, day-care treatment with faster recovery. On this World Brain Tumor Day, the message is simple: recognise symptoms early, seek expert care promptly, and remember that modern technology is making brain tumor treatment safer, more precise, and less traumatic than ever before.

Not All Brain Tumours Are Cancerous, Says Dr. Raghavendra

Hyderabad: Not all tumours that develop in the brain are cancerous, but headaches occurring in the early hours of the morning or immediately after waking up should not be taken lightly, said Dr. Raghavendra, Chief Consultant Neurosurgeon and Spine Surgeon at KIMS Hospitals, Gachibowli.



Marking International Brain Tumour Day, KIMS Hospitals Gachibowli organised a Brain Health Walk to raise awareness about brain tumours and neurological health. The walk was flagged off by renowned Chief Joint Replacement Surgeon Dr. A.V. Guruva Reddy from the hospital premises and proceeded through Malkam Cheruvu and Raidurgam before concluding at KIMS Hospitals. Speaking on the occasion, Dr. Raghavendra stressed the importance of

consulting a doctor in cases of persistent headaches. He noted that while there is no single established cause for brain tumours, genetic factors may play a role in some individuals. Exposure to radiation can also be a contributing factor. Patients undergoing radiation therapy for cancers of the mouth, tongue, or throat may, in some cases, experience incidental radiation exposure to the brain, potentially increasing the risk of developing brain

tumours several years later. He said the walk was organised to create greater public awareness about brain tumours and brain health. Benign brain tumours, he explained, typically grow very slowly, often by only about 2 mm per year. Dr. Sandhya said, Brain tumours are sometimes detected incidentally during scans conducted following accidents or when patients present with symptoms such as sei-

zures or hearing impairment. Malignant brain tumours, however, behave differently. They tend to grow rapidly and can cause significant damage to surrounding brain tissue. Dr. Guruvareddy pointed out that advanced treatment options for brain tumours are now widely available. Early diagnosis and timely treatment can significantly improve patient outcomes and help prevent serious complications. Among those who participated in the walk were Dr. Ankita Chawla, Medical Director of KIMS Hospitals Gachibowli; Dr. Sandhya, Consultant Neurosurgeon, Dr Naveen kumar, Dr Shyam k Jaiswal, Dr vijay kumar and Dr Shashidhar Neurologists from the department of neurosciences and hospital staff; and a large number of local residents.

Railways approves Rs.285 crore traction upgrade on Mahbubnagar-Secunderabad-Medchal route

Hyderabad, June 8: Indian Railways has sanctioned a major infrastructure project to upgrade the electric traction system on the Mahbubnagar-Secunderabad-Medchal section of South Central Railway at an estimated cost of Rs.285.01 crore. Under the project, the existing 1x25 kV electric traction system will be upgraded to a modern 2x25 kV electric traction system across the approximately 141-km rail section. The initiative is aimed at enhancing capacity and improving operational efficiency on one of the country's important High-Density Network (HDN) routes.



The Mahbubnagar-Secunderabad-Medchal section forms part of the Dharmavaram-Dhone-Mahbubnagar-Secunderabad-Medchal-Mudkhed-Indore-Ajmer rail corridor, which handles significant passenger and freight traffic. Railway officials said the upgraded 2x25 kV system will provide a more stable and efficient power supply, enabling smoother, safer and more reliable train operations. The modernization is expected to improve train handling capacity

and support faster movement of both passenger and freight services. Upon completion, the project will significantly boost freight transportation efficiency, increasing the speed and carrying capacity of goods trains. The improved rail infrastructure is also expected to support trade, industry and economic activity across the region.

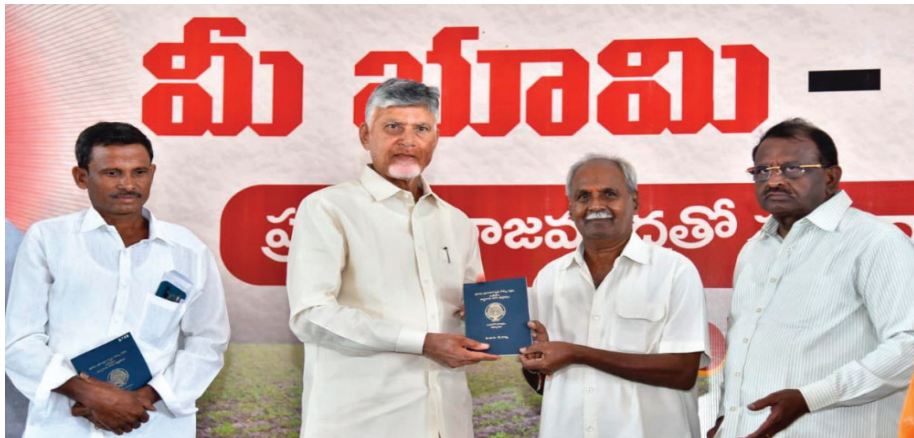

gramme at Siddhantham village in West Godavari district, the Chief Minister distributed new land title passbooks carrying the state emblem and advanced security features. He alleged that land records had been severely distorted during the previous administration, creating disputes and hardships for landowners. Naidu said the newly issued passbooks include QR codes and security features similar to those found in currency notes.



He also announced that Andhra Pradesh has become the first state in the country to implement a blockchain-based land records system, assigning permanent blockchain IDs to every land unit to prevent tampering and ensure transparency.

The Chief Minister stated that re-survey work has already been completed in 6,688 villages and that 2.646 million passbooks have been issued so far. Over the next nine months, surveys in another 10,357 villages will be completed, enabling the distribution of 6.732 million additional

passbooks. He expressed confidence that every farmer in the state would have a flawless land record by 2027. Highlighting reforms in the Revenue Department, Naidu said the government has introduced Webland 2.0, digitization of legacy records, and 100 percent auto-mutation for nearly 900,000 property transactions. He added that inheritance transfers have been simplified and made affordable for citizens. The Chief Minister also reiterated the government's support for the aquaculture sector, noting that power is being supplied to aquacul-

ture ponds at Rs.1.50 per unit in designated aqua zones. He said the government is promoting food processing industries and aquaculture development, particularly in the Godavari districts. During his speech, Naidu launched a strong attack on the YSR Congress Party, accusing its leaders of manipulating land records and engaging in large-scale irregularities. He alleged that fraudulent land transactions worth around Rs.1,500 crore had taken place and demanded that those responsible be held accountable.

The programme concluded with enthusiastic participation from party leaders and workers, who pledged to work towards expanding the party's presence across the erstwhile Palamuru district.

Rs 1 Lakh Crore Gone, And Counting: Worse May Be Coming For India's Oil Shock

The Al Hamra, a liquefied natural gas tanker operated by ADNOC Logistics, slipped out of the Strait of Hormuz late last month, bound for western India. The vessel had switched off its tracking signal on April 19, idling near the eastern entrance of the strait, and was loaded quietly at Abu Dhabi National Oil Company's Das Island export terminal during the silence. Its reappearance on Kpler's ship-tracking data was the first confirmed LNG shipment to India through Hormuz since the Iran war began three months ago. India received over half its LNG from Qatar and the UAE before the war. Those flows had essentially halted. And one tanker does not undo three months of disruption. The economic toll of the disruption has accumulated, meanwhile, in places that do not appear on news tickers. The Finance Minister, speaking at a SIDBI event in Mumbai on May 25, said the Centre is set to absorb over Rs 1 lakh crore in revenue forgone from the cut in central excise on petrol and diesel. The figure, however large, is only part of the bill. Brent crude futures traded near \$98 a barrel on May 26, having touched \$114 earlier in the month and peaked at \$126 in early March after the US-Israel strikes on Iran. The Indian basket has surged some 57% from below \$70 a barrel in early January. India imports about 85% of its crude requirement, and the pass-through is visible at every joint of the economy. Inflation Is Coming For Common Households Wholesale price inflation reached 8.3% in April, a forty-two-month high, against 3.88% in March. The fuel and power component rose 24.71% on the year, with petrol WPI at 32.40%, diesel at 25.19%, and LPG at 10.92%. Retail inflation, by contrast, stood at a deceptive 3.48%, fuel and electricity carrying a much smaller weight in the consumer basket. The divergence is the story. The wholesale number records what the economy has actually absorbed. The retail number records what households have so far been allowed to see. The gap closes over time. The pump price has, since May 15, begun to move. Four hikes in two weeks have lifted diesel in Delhi from 87.67 to 95.20, an aggregate increase of 7.53 a litre. A Business Standard survey on May 25 found that one in two respondents reported a rise in transport, product or service costs in consequence. Petrol crossed 100 in Delhi on May 25 and was at 102.12 by May 26. In Andhra Pradesh, it is above 115 across the state, touching 118 in Chittoor. The Prime Minister appealed for travel restraint and a preference for the metro. The exchequer has paid in several currencies. Cuts in central excise on petrol and diesel cost the Centre roughly \$1.18 billion a month in forgone revenue. The fertiliser subsidy, budgeted at 1.71 lakh crore for FY27, is now expected to swell by about 20% as urea and phosphatic inputs grow scarce and pricier. The Union Cabinet has already approved a 41,534 crore non-urea fertiliser subsidy for this year's kharif season, 12% above last year's. The Strait of Hormuz disruption hit, at once, 40% of India's crude imports, over 50% of its urea, and 90% of its LPG. The fiscal deficit target for FY27 is 4.3% of GDP. ICRA has flagged "sizeable upside risks" to that number. The Ever-Falling Rupee The rupee has carried the rest. It fell to 96.34 against the dollar on May 19, a record low, taking its decline this year to 7.04%, more than the full-year falls in 2025 (4.9%) and 2024 (2.9%) individually.

How A Photograph in Delhi Says Something Important About Trump's America

During her visit to New Delhi this week, Venezuela's acting president, Delcy Rodriguez, met US Ambassador Sergio Gor. Had the meeting taken place in Washington or Caracas, it would have attracted little attention. In Delhi, however, it carried a different significance. Rodriguez had come to India seeking investment, energy cooperation, and commercial partnerships. Yet the image suggested a deeper reality. Venezuela's leaders may travel the world in search of opportunities, but the country's economic future increasingly operates within a framework shaped by Washington. For example, recent US sanctions have restricted Venezuela's access to international financing and targeted the state-owned oil company PDVSA, dramatically limiting the government's ability to generate revenue and engage with global markets. The photograph captured more than a diplomatic encounter. It revealed a changing relationship between a weakened state and a dominant power. It also revealed something troubling about America itself. For decades, successive American administrations justified their policies towards Venezuela using the language of democracy, human rights, and constitutional governance. Critics often questioned those motives, but the rhetoric remained consistent. American power was presented as an instrument of universal principles. Donald Trump has adopted a strikingly different approach. The Return of Colonial Logic Rather than disguising the centrality of oil, he has repeatedly emphasised it. He has spoken openly about Venezuela's vast energy reserves, described Venezuelan oil in terms suggesting American entitlement, and supported arrangements under which the future of Venezuelan oil production and revenue flows would be shaped under strong American influence. The remarkable feature is not that a great power pursues its interests. Great powers have always done so. The remarkable feature is the disappearance of embarrassment. Trump appears willing to say aloud what previous administrations preferred to imply. While leaders like Obama or Bush focused their public statements on the promotion of democracy, human rights, and con-



stitutional order, often framing interventions in terms of universal values, Trump has spoken with unusual directness about oil, power, and strategic advantage. Where past rhetoric wrapped interests in the language of democratic idealism, the priorities now are openly transactional. Oil matters. Power matters. Strategic advantage matters. The language of democratic idealism has increasingly given way to the language of ownership and control. That shift is important because it exposes the underlying logic of the relationship. No American governor resides in Caracas. No American flag flies over Venezuelan government buildings. Venezuela remains a sovereign state in the formal legal sense. Yet colonial relationships have evolved. They no longer require occupation or direct administration. They operate through financial leverage, market access, licensing arrangements, sanctions regimes and influence over strategic resources. The question is, therefore, not whether Venezuela remains independent on paper. The question is whether meaningful sovereignty can survive when a nation's most important economic decisions increasingly depend

upon the approval of another state. Yet the most important consequence of this development may not be Venezuelan. It may be American. The Freedom Exception The United States occupies a unique place in modern history because it was founded in opposition to an empire. The American Revolution transformed resistance to external control into a defining national principle. Liberty, self-government and sovereignty became central elements of American identity. Generations of Americans were taught that freedom was not merely a national possession but a universal ideal. That is what makes the current moment so revealing. If a foreign government exercised similar influence over American oil production, energy exports, or resource revenues, the reaction would be immediate and furious. Americans would rightly regard such interference as an assault on national sovereignty. Politicians would denounce it. Commentators would condemn it. Citizens would reject it. Yet many of the same people appear remarkably unconcerned when comparable principles are applied elsewhere. This is particularly evident among Trump's politi-

cal base. Few political leaders speak openly unless they believe their supporters will tolerate or even reward them for doing so. Trump's confidence reflects the knowledge that many of his most enthusiastic supporters will view such rhetoric not as imperial overreach but as evidence of national strength. That fact should trouble Americans far more than it troubles Venezuelans. Many of those supporters present themselves as the strongest defenders of freedom, sovereignty and self-government. They condemn foreign influence in American affairs and invoke the nation's anti-colonial origins with understandable pride. Yet when another country's sovereignty becomes constrained by American power, the principle suddenly appears less important. The contradiction is difficult to ignore. The issue is not simply hypocrisy. Political hypocrisy is as old as politics itself. The issue is habituation. A society that repeatedly makes exceptions to its principles eventually ceases to regard them as principles at all. Freedom becomes something claimed for oneself rather than defended universally. Sovereignty becomes a right for the powerful and a privilege for the

weak. Liberty remains celebrated in speeches while becoming increasingly conditional in practice. History suggests that this process carries dangers far beyond foreign policy. The founders of the American Republic understood that imperial power could corrupt republican institutions. Their concern was not merely what power would do to foreign peoples. It was what the exercise of power would do to Americans themselves. A republic depends upon citizens who believe that principles apply consistently. Once exceptions become routine, cynicism follows. The language of freedom survives, but its substance gradually weakens. The photograph from New Delhi will soon be forgotten. Diplomats will move on. Oil contracts will be negotiated. Venezuela's future remains uncertain. Yet the image captured something larger than a diplomatic meeting. It showed a republic founded in opposition to an empire that was growing increasingly comfortable exercising imperial influence over another nation's most valuable resource. More troublingly, it suggested that millions of Americans no longer regard that contradiction as particularly troubling.

After Bengal Defeat, Is Mamata Banerjee Preparing For National Politics?

Mamata Banerjee has always been known as a leader who carefully calculates her political timing. She does not take steps impulsively, especially after a major electoral setback. That is why her recent shift toward more Delhi-centric politics is now becoming one of the most discussed developments in national opposition politics. The question many people are asking is simple: why is Mamata Banerjee suddenly giving so much importance to national opposition coordination and the INDIA alliance after the 2026 West Bengal Assembly election? There are several reasons behind this political repositioning. For a long time, Mamata Banerjee had maintained a certain distance from formal INDIA alliance meetings. But now she is regularly attending these meetings again and is showing renewed interest in opposition coordination at the national level. What makes this more politically significant is the fact that during the 2026 West Bengal assembly election, there was no alliance between the Trinamool Congress and the Congress party. In fact, Congress state president Subhankar Sarkar himself later admitted publicly that he personally wanted some kind of seat adjustment or tactical understanding with Mamata Banerjee. According to him, the Congress leadership in Bengal had been willing to explore an alliance framework, but Mamata Banerjee ultimately did not show interest at that time. Perhaps she did not anticipate that the political out-



come would unfold in the way it eventually did. Now, after the election setback, the political situation has changed considerably. The first and most immediate reason behind Mamata Banerjee's Delhi-focused politics is the post-election reality inside West Bengal itself. After the 2026 defeat, there is no immediate assembly election ahead, nor is there any realistic possibility of an instant change of government in Bengal. But at the same time, the BJP's political campaign against the Trinamool Congress has intensified almost every single day. Corruption allegations against Trinamool leaders continue to dominate political discourse. Several MLAs have left the party. In many ways, the legislative structure of the Trinamool Congress has weakened internally. Inside the Kolkata Municipal Corporation, too, several councillors have either resigned or openly revolted against the leadership. In such a politically

defensive situation, Mamata Banerjee appears to be trying to shift the centre of political debate away from Bengal-specific anti-incumbency and toward larger national issues where the BJP-led central government can be targeted more aggressively. That is a strategic political move. At the all-India level, the opposition still believes there are several issues on which the Narendra Modi government remains vulnerable. Unemployment, rising prices of cooking gas and fuel, economic uncertainty, foreign policy criticism, and delays in key international trade agreements, especially with the United States, are all issues being raised repeatedly by opposition parties. Questions are also being raised over what many opposition leaders describe as inconsistency or "topsy-turvy" trends in foreign policy management. Mamata Banerjee now appears to be repositioning herself within this broader anti-BJP national campaign narrative.

Another important factor is the experience of Bengal itself during the recent election. There is now a growing feeling within sections of the opposition that whatever administrative, electoral, and political challenges Bengal witnessed during the election period, including controversies surrounding voter management, administrative handling, and electoral processes, should be presented nationally as a larger democratic concern. Until now, opposition parties across India had not fully used the Bengal experience as a common reference point. But discussions have now started about turning Bengal into a "model case" to strengthen coordinated opposition attacks against the BJP nationally. At the same time, Mamata Banerjee's relationship with the Congress party is also entering a new phase. During the Bengal Assembly election, there was a visible political distance between the Congress and the Trinamool. But after the election, Mamata Banerjee has gradually started rebuilding communication with Congress leaders and other opposition parties. At this moment, Mamata Banerjee is not aggressively trying to project herself as the undisputed leader of the entire opposition bloc. Earlier, there had been intense debate within opposition circles over whether Mamata wanted to lead the anti-BJP front nationally. That debate had also created tensions among several regional parties. Now, at least for the time being, Mamata appears to be avoiding that direct leadership contest.

The engine of growth, but the insecure middle class

The challenge of the 'missing middle' and the question of economic security

India is today one of the world's fastest-growing major economies. Its growing economic power, large youth population, digital revolution, and expanding consumer market are constantly being discussed on the global stage. At the heart of this development journey, if any socio-economic class plays the most important role, it is India's middle class. This class drives consumption, saves, invests, pays taxes, invests in education and skills, and sustains economic activity. In any modern economy, the middle class is considered the engine of growth because its income and aspirations drive both production and the market. In India, too, the middle class is considered the foundation of future economic growth, social stability, and democratic strength. Yet, ironically, a large segment of the Indian middle class itself is not financially secure. While it has risen above poverty, it has not achieved lasting prosperity and security. This phenomenon is identified in economics as the "missing middle," or the "vanished or vulnerable middle class." The "missing middle" refers to a situation in which the middle class, situated between the rich and the poor, is not strong enough or economically stable enough to withstand a crisis. Millions of families in India are considered middle class based on income, but lack adequate savings, social security, access to quality healthcare, or long-term financial stability. As

a result, they can quickly fall into financial crisis in the face of illness, job loss, business losses, or economic recession. The COVID-19 pandemic brought this reality to a stark conclusion. During the pandemic, millions of families who considered themselves part of the middle class suddenly found themselves in financial difficulties due to the loss of income, rising medical expenses, and unstable employment. This made it clear that despite being large in numbers, India's middle class is vulnerable in terms of security. The greatest strength of the Indian middle class is its consumption potential. This class accounts for a significant portion of the country's demand for housing, vehicles, electronics, education, health, insurance, tourism, and digital services. As middle-class incomes rise, they purchase more goods and services, leading to industry expansion, increased investment, and the creation of new jobs. This is why a strong middle class is considered a key factor in the economic success of developed countries. If India, too, wants to progress towards becoming a developed nation, it must strengthen and secure its middle class. However, this class is currently faced with numerous challenges. The primary challenge relates to the quality and stability of employment. A large proportion of employment in India remains in the unorganized sector. Those employed here do not receive regular salaries, provident funds, pensions, health insurance, or other social security benefits. A significant number of educated youth are also working in jobs that are not commensurate with their qualifications. While employment opportunities are increasing, many are temporary, contract-based, or low-paying. The gig economy and platform-based employment have created new opportunities, but they too lack long-term security. This makes it difficult for the middle class to plan their future financially. Another major challenge is the rising cost of

health and education. In India, the limited availability of quality government health and education services forces the middle class to rely on private institutions. Expenditures on children's education, coaching, higher education, and healthcare consume a significant portion of a family's income. Years of savings can be wiped out in the event of a serious illness or accident. Numerous studies show that personal health expenditure in India remains high. This situation makes the middle class economically insecure and puts them under constant financial pressure. The third challenge is inflation and the rising cost of living. In metropolitan areas and large cities, prices of housing, transportation, energy, food, and other essential services have steadily risen. Although incomes are rising, they often do not keep pace with inflation. As a result, real income and purchasing power are affected. The middle class has to take on more debt to maintain their standard of living. The increasing burden of home loans, vehicle loans, education loans, and consumer loans also increases financial insecurity. A significant aspect of the "missing middle" problem relates to social security. India offers numerous welfare programs for the poor, such as free rations, health insurance, housing assistance, and other social benefits. Higher-income groups, on the other hand, have private resources and investments that can help them cope with risks. However, the middle class is often caught in the middle. They are not eligible for government assistance programs, while also finding it difficult to afford the full cost of private security and services. This is why they can quickly slide into economic instability in the event of an unexpected crisis. The limited growth of small and medium enterprises in India also exacerbates the problem of the "missing middle." Small businesses often lack adequate access to finance, technology, and markets, preventing them from scaling up.

Stock market jitters remain amid tech fears and renewed Middle East attacks

US stock markets recovered some of Friday's sharp losses on Monday, but other markets have fallen amid a sell-off in technology shares. In Asia, South Korea's stock market was forced to halt trading for 20 minutes, with its Kospi index shedding nearly 9% within minutes of opening. It eventually closed 8.3% lower, with Japan's Nikkei index falling 3.9% and European markets also trading lower - though suffering much smaller falls than those seen in Asia. But in the US, the tech-heavy Nasdaq index rose 1.2%, the S&P 500 opened 0.7% higher and the Dow Jones Industrial Average was up 0.2%. All had suffered steep drops on Friday following a strong US jobs report, which raised the prospect of interest rates staying high, or even climbing further this year. On Monday, markets were also rattled by a rise in oil prices, fuelling concerns of inflation, after Iran and Israel exchanged strikes for the first time since a ceasefire was agreed between the sides and the US in April. Traders are nervously watching a "messy mix" of several shocks to the market mainly tied to the tech sector and accelerated by rising energy prices, said chief investment



strategist Charu Chanana from Saxo. Tech stocks have seen a strong run in recent weeks, but investors are "repositioning" over fears the investments into artificial intelligence may be overvalued, she said. Markets like the Kospi and Nikkei are particularly exposed to such shocks given their exchanges are dominated by tech stocks. The Kospi's halt on Monday was part of a circuit breaker mechanism designed to prevent panic trading and was triggered for the third time this year following the plunge in tech stocks. Wall Street's sharp drop on Friday saw the sell-off in tech stocks wipe about 4% off the Nasdaq

- its biggest drop in more than a year. Part of the decline on Friday followed fears of a hike in US interest rates, due to a lower-than-expected US unemployment rate in April as well as persistently high inflation linked to the war in the Middle East. Most European markets were lower on Monday, although the UK's FTSE 100 reversed early losses to trade slightly higher. Earlier, major South Korean tech companies had fallen sharply, including those of chipmakers Samsung, which closed down 10%, and SK Hynix. South Korean President Lee Jae-myung said the stock market was expected to experience

volatility but he believed domestic shares were still "slightly undervalued". Overall, the tech-heavy Kospi has seen huge gains in recent months due to a wave of investment in the country's tech companies. Investors are more looking for clear signs that AI demand has translated into "real revenue", Chanana said. "The burden of proof has gone up." Other Asian stock exchanges, like the Hang Seng Index and the Shanghai Composite, all closed lower. Taiwan's TaieX was also down sharply after shares of semiconductor giant TSMC fell by 3%. The chipmaker is a key supplier to Nvidia,

whose boss Jensen Huang said the recent slide in tech stocks presented a buying opportunity for investors. Investors are opting for tech companies "with more reliable income streams and dividends", said Susannah Streeter, chief investment strategist at Wealth Club, adding there were "undercurrents of worry about the surge in tech stock prices". The price of the global benchmark Brent jumped by 4.6% to \$97.34 (£73.05) a barrel in Asia, after strikes were exchanged between Iran and Israel. Tehran warned the attacks were the start of a full week of strikes and were a response to a "repeated violation" of a ceasefire agreed on 17 April between the US, Israel and Iran. Israel later hit back with attacks on military targets in Iran. However, the price of oil then fell back after Iran said it would stop striking Israel, with Brent dropping back to around \$94 a barrel. Associate Professor Jiajia Yang from James Cook University in Australia said traders were again pricing in risks to global oil markets. The strikes show that many political issues remain unresolved and oil prices are expected to be volatile unless diplomatic efforts succeed, Yang said.

India auto sales hit record high in May; EV share tops 11 pc

New Delhi: India's automobile retail sales grew 9.55 per cent to a record 25,31,067 units in May, while EV penetration crossed 11 per cent for the first time, as dealers saw a surge in enquiries for fuel-efficient and green vehicles after last month's fuel price hikes amid the West Asia crisis, FADA said on Monday, May 8. The cumulative automobile retail sales in India stood at 23,10,451 units in the same month last year. According to the Federation of Automobile Dealers Associations (FADA), the figures reflect the best May performance ever recorded across commercial (CV), passenger vehicle (PV) and the overall EV penetration. "A notable feature of the month was the consumer response to May fuel-price revisions: dealers reported a visible rise in enquiries for fuel-efficient and alternative-powertrain options, reflected in the two-wheeler EV share climbing to 9.25 per cent from 6.11 per cent a



year ago," FADA stated. Passenger vehicles retail sales were at a record 4,02,591 units last month as compared to 3,26,656 units in May 2025, a growth of 23.25 per cent, data showed. Two-wheelers also clocked best-ever monthly numbers at 18,44,947 units in May this year as compared to 17,15,581 units in the same month a year ago, a growth of 7.54 per cent. FADA further said three-wheeler sales stood at 1,11,526 units last month as compared to 1,07,688 units in May 2025, up 3.56 per cent. Commercial vehicles also

witnessed a growth of 5.29 per cent to a record 83,823 units last month as compared to 79,614 units in May 2025, it added. "Overall, the outlook for June 2026 appears measured but cautiously optimistic, with monsoon progress and rural cash flows expected to provide the structural support even as near-term cost pressures persist," FADA stated. Looking ahead to June 2026, dealer sentiment is measured: 50.52 per cent of dealers expect growth, 39.90 per cent anticipate a flat market, and only 9.59 per cent foresee a decline.

Centre has coal reserves for 80 days, says Union Coal Minister Kishan Reddy

Hyderabad: Union Minister G Kishan Reddy on Monday, June 8, said that the Centre has adequate coal reserves to meet the requirements of power generation for 80 days. Speaking to reporters about the achievements of the National Democratic Alliance (NDA) government since 2014, Reddy also said that exploration has begun in the critical mineral blocks acquired in Argentina, and production should commence as early as possible. "Earlier, there used to be a shortage of coal. Now, the Government of India has coal reserves sufficient for 80 days of power generation. Since the monsoon season has begun, coal production could face disruptions due to heavy rainfall," the Union Coal and Mines Minister told reporters here. "Following the directives of Prime Minister Narendra Modi, we have maintained coal reserves for 80 days," he added. Highlighting the importance of critical minerals, Reddy said that the Centre is identifying critical mineral reserves and undertaking exploration activities. He added that auctions have also begun in areas where exploration has been completed. The Centre is encouraging private players to import either processed or semi-processed critical minerals into



Argentina, he said. Alleging that scams in the coal sector used to make headlines during the previous UPA regime, he said that the country is now producing a record 1,040 million tonnes of coal annually. He added that auctions have also begun in areas where exploration has been completed. Union Coal and Mines Minister G Kishan Reddy on Monday said India has adequate coal reserves to support power generation for the next 80 days, ensuring energy security even during the monsoon season when mining operations may face

disruptions. Speaking about the achievements of the NDA government since 2014, Reddy said the Centre has built sufficient coal stocks following Prime Minister Narendra Modi's directions to prevent any shortage in electricity generation. He added that despite potential monsoon-related challenges, the country is well-prepared to meet its energy requirements. The minister highlighted that India is actively exploring critical mineral reserves and has initiated exploration work in mineral blocks acquired in

Argentina. He said production from these overseas assets is expected to begin at the earliest. The government has also started auctioning explored critical mineral blocks and is encouraging private companies to import processed and semi-processed critical minerals. Reddy noted that the government has identified 143 abandoned coal mines for scientific closure, with the process expected to be completed by 2028. He also said reforms introduced over the past 12 years have helped India achieve record annual coal production of 1,040 million tonnes. According to the minister, India is now the world's second-largest producer and consumer of coal and possesses the fifth-largest coal reserves globally. He added that nearly 70 per cent of the country's electricity is generated using coal and asserted that there is currently no power shortage anywhere in India. Reddy further said the results of ongoing coal gasification projects are expected within the next two years. The Centre recently approved a ₹37,500-crore incentive scheme to promote coal gasification, a technology that converts coal into syngas for producing cleaner fuels, fertilisers, chemicals and hydrogen, while reducing dependence on imports.

Iranian military says it's stopping strikes on Israel, but will resume if Israel attacks Lebanon

In a televised statement, he describes Iran and Hezbollah as weaker than ever, but suggests a fight with them is not yet over. He says if there are further attacks on Israel from Iran then his government will respond forcefully, and they will exercise a right to self-defence. Netanyahu also mentions his conversations with US President Trump, who he is known to have spoken to since strikes began on Sunday. Israel's defence minister Israel Katz says that the country's military will continue to operate in Lebanon, after exchanging strikes with Iran over the last day. Katz says that the IDF will continue to operate against Hezbollah and Israel rejects threats from Iran. Earlier Iran said that it had ceased its attacks on Israel, but would resume them if Israel continued strikes in Lebanon. The IDF says a projectile struck an area in southern Lebanon where its soldiers

are operating. The strike triggered sirens in the nearby area of Zar'it, close to the border in northern Israel, but no injuries were reported, it added in a statement on Telegram. After the exchange of strikes between Iran and Israel reports are emerging that both countries will halt attacks against the other. Meanwhile, a semblance of normality is present in daily life in Tehran, as these pictures from today show: One person says that Iranians are "exhausted" as they ask "both sides to end the war". "People will suffer greatly in all this, whether they support it or oppose it," another adds. "But the reality is that Iran, our homeland, is becoming a victim of greed and excessive ambitions." One man says he is "constantly worried" the internet will be cut off - "and we don't know where this war is heading". Another person says: "The country's situation is already chaotic, and

people are paying an even greater price for this endless conflict between Iran and America. Most people just hope it ends as soon as possible so the country can return to some degree of stability." Pakistan's prime minister Shehbaz Sharif is urging "all sides" to exercise restraint in the pursuit of peace, especially when "the final objective is just about to be achieved", in a message on social media. Iran's military said it would stop strikes on Israel earlier, but warned that if attacks on Lebanon continue that it would respond more severely than before. Israeli media has also reported that Israel would stop attacks on Iran "at Trump's request". In a post on X, Shehbaz says: "The recent surge in violence in the Middle East is a stark reminder of the dangers associated with a tenuous ceasefire and the unbearable consequences it may lead to.

MALAWIANS REPATRIATED FROM SOUTH AFRICA AMID XENOPHOBIA CONCERNS



A group of 150 Malawians repatriated from South Africa amid growing worries about xenophobia are due to arrive by road in their home country on Monday, the Malawian authorities have said. The repatriation follows violence in South Africa's Western Cape Province where there were reports just over a week ago of door-to-door intimidation, as well as the deaths of two Mozambicans in Mossel Bay. The Malawians were "among a number of foreign nationals" who had "sought refuge in temporary camps" in Mossel Bay, according to a statement from Lilongwe. Ghana, Nigeria and Zimbabwe have also organ-

ised repatriation flights and transport after raising concerns about xenophobia in South Africa. Anti-migrant groups are demanding undocumented migrants leave the country - and have set 30 June as a deadline. In a national address on Sunday aimed at easing tensions, South African President Cyril Ramaphosa announced a raft of new measures to crackdown on illegal migration. But he also warned South Africans not to take the law into their own hands. He said there was "no space for xenophobia, racism, sexism, Afrophobia or any other forms of intolerance" in the country.

KNICKS' LONG-AWAITED NBA RUN ELECTRIFIES NYC, WITH TRUMP SET TO ATTEND KEY GAME



Heightened security, a strict no-bag policy and airport-style screening will greet fans, as US President Donald Trump attends a pivotal NBA Finals game on Monday evening in New York City. The New York Knicks will clash with the San Antonio Spurs for game three of the finals - the first on their home turf of Madison Square Garden (MSG). The Knicks, appearing in their first finals since 1999, hold a 2-0 lead in the best-of-seven series, fuelling championship fever across the city. The hottest ticket in town is drawing Mayor Zohran Mamdani as well as Trump. A parade of celebrities have been spotted at other recent games, including actors Timothée Chalamet and Ben Stiller, and filmmaker Spike Lee. This season has represented a stunning reversal of fortunes for the Knicks after decades as one of the worst teams in the league. Now with a 2-0 lead in the finals, they need to win just two more games, out of a possible seven, to win the national championship for the first time since 1973. And the mood across New York City is electric. From the Empire

State Building to One World Trade Center, skyscrapers have been lighting up the city's skyline orange and blue - the Knicks' team colours. A subway station near Madison Square Garden has been given a Knicks-themed makeover, and businesses across New York City's five boroughs are offering meal deals and special orange-and-blue ice cream and bagels. On game nights, throngs of supporters donning Knicks gear have been spilling out of packed bars, projecting the game onto the sides of buildings, and holding impromptu watch parties. Thousands of fans have taken over the streets near the arena on game nights - even though their team were playing the first two games at their opponents' arena in Texas - leading to dozens of arrests as fans climbed lampposts, jumped onto food carts, and blocked traffic. But many of the team's devoted fans will not have been able to afford tickets to the first home game of the series on Monday, with the cheapest online resale tickets currently going for more than \$10,000 (£7,468) and running up to more than \$100,000.

'No dead ends': What the Dutch can teach us about tackling youth unemployment

A landmark report last month found Britain is grappling with a youth engagement crisis - with nearly one in eight 16 to 24-year-olds not in education, employment or training (Neet). Alan Milburn, the former health secretary who authored the report, warned one in six young people could become Neet within five years unless urgent action is taken. What does Neet stand for and why does the UK have so many? He identified that the Dutch approach was one the UK could learn from. The Netherlands has one of the lowest Neet rates in the world, at 4.9% among 18 to 24-year-olds. The equivalent figure in the UK is 15.1%. So can the UK learn from a Dutch system that is designed around a simple principle? "No dead ends" is



the philosophy which underpins Dutch education and youth employment policy - every stage of a young person's journey is designed to lead somewhere. Under Dutch law, it is compulsory for children between five and 16 to attend school - then they must stay in education or training until they either secure a qualification or turn 18.

ARMENIA'S PRO-WEST GOVERNMENT WINS ELECTION DESPITE RUSSIAN PRESSURE

Armenian Prime Minister Nikol Pashinyan's party has won a crucial election billed as being key in deciding whether the country continues to move closer to the West. Pashinyan's centrist Civil Contract Party secured 49.8% of the vote, with the Strong Armenia Alliance coming in second with 23.2%. The Armenia Alliance was third with 9.9%. Sunday's vote was the first general election since Armenia, a small South Caucasus country of three million people, suffered a crushing military defeat by Azerbaijan in 2023. It was viewed as a test of the prime minister's push to deepen ties with the West while facing mounting economic pressure from Russia, its largest trading partner and traditional ally. Pashinyan, who has been in power since 2018,



declared victory on Monday after early results showed his party had secured more than 50% of the vote. "Armenian people voted for peace, regional prosperity and cooperation," he said. The election drew significant international attention to the country. On Monday, France and the EU were among European powers that congratulated Pashinyan, praising Armenia's closer ties with the

West. Russia's foreign ministry spokesperson Maria Zakharova was quoted by the Tass news agency as saying "unprecedented pressure" had been put on opposition parties and alleged there had been "interference" from the West. Zakharova also said the election had demonstrated that Armenian society was "extremely polarised". Civil Contract's success came despite Pashinyan's domestic

support falling from 54% in 2021 to around 30% today, according to polls. A total of 19 parties and alliances took part in the election but few of these earned enough votes to gain a seat in the national assembly. Turnout was 59%, the electoral commission said. The conservative Prosperous Armenia party, led by businessman Gagik Tsarukyan, came fourth with 4% of the vote. It, like the Strong Armenia Alliance - led by Russian-Armenian billionaire Samvel Karapetyan, and the Armenia Alliance - led by former President Robert Kocharyan, are pro-Russian. "We will continue the course of rapprochement with the West, but we will also continue our participation and membership in the Eurasian Economic Union," Pashinyan also said on Monday.

Zelensky's close European allies set out five conditions for peace talks

The leaders of Ukraine and its close European allies - the UK, France and Germany - have set out five conditions for reaching a "just and lasting" deal to end the war with Russia. In a joint statement after talks in London, Volodymyr Zelensky, UK Prime Minister Sir Keir Starmer, French President Emmanuel Macron and German Chancellor Friedrich Merz said they would "stand firmly with Ukraine". The five conditions include a stop to the fighting, starting negotiations from the current position in the field as well as "robust" security guarantees for Ukraine. The leaders reiterated the



need for the US to be part of the process at a time when US President Donald Trump's focus has shifted to the war with Iran. Back in December, the US pushed Russia and Ukraine to sign up quickly to a plan to end the war, which began with Russian

President Vladimir Putin's decision in February 2022 to launch a full-scale invasion of its neighbour. The warring sides have recently intensified attacks against each other, with Russia using missiles and drones to attack Ukrainian cities - and

Ukraine displaying increased abilities to reach deep into Russian territory with new technology. On Saturday, Ukrainian drones hit Russia's second-largest city, St Petersburg, as it hosted the final day of a major economic forum - an attack described as "unprecedented" by Russian authorities. Days earlier, Kyiv had attacked the outskirts of the same city - some 1,000km (620 miles) from Ukraine - as Putin's flagship forum was getting started. On the eve of the event, Zelensky sent an open letter to Putin calling for direct negotiations to end the war - an offer repeatedly rejected by the Russian leader.

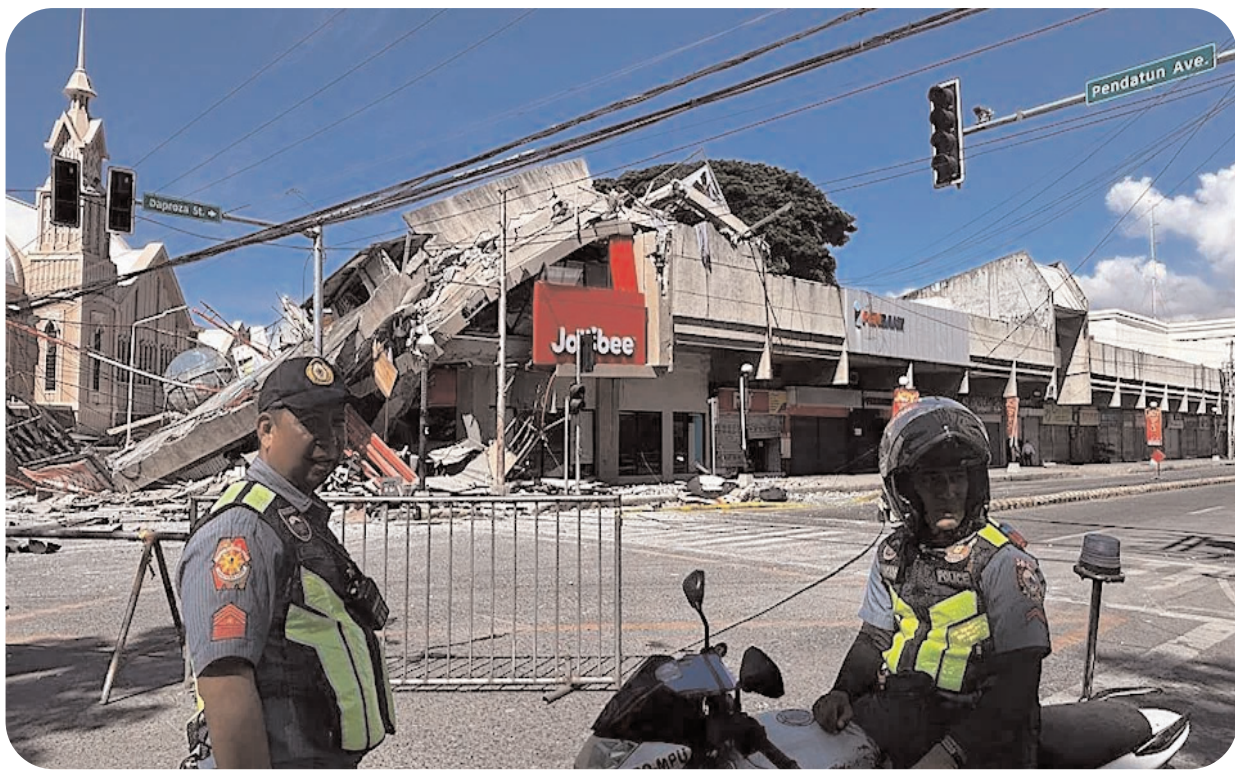
Peru election result close as vote counting continues



Peru's presidential election is stuck in a statistical tie, according to an early tally by the pollster Ipsos, echoing previous elections that have dragged on for days or even weeks.

It put the left-wing Roberto Sánchez on a marginal lead of 50.3% of the vote, compared with the right-wing Keiko Fujimori on 49.7%. While not an official count, the tally has been an accurate indicator of the final result in previous polls. Official results confirm the race is extremely tight with more than 91% of votes counted. The election pits Fujimori, a mainstay of Peruvian politics, against Sánchez, who is promising broad economic reforms. Concerns over crime and political instability have dominated the race. Recounts will likely be needed to confirm the winner, a process that could take weeks. Ipsos showed Fujimori dominating the capital Lima, carrying the urban vote and the coast, while Sánchez swept the rural vote and the mountainous Andes regions. Sánchez is expected to gain ground as ballots from rural areas are

tallied. Sánchez told supporters the early count was an "important lead that reaffirms the will of the people, who want democracy and justice." Fujimori, on the other hand, said the result showed a "dead heat" and that there will be long "days ahead" to declare a winner. She said it would be "irresponsible" to determine the result on early samples and that "every single tally sheet must be counted". Sánchez also reiterated that he would seek a "presidential pardon" that would free the former left-wing president Pedro Castillo. In 2021, Castillo also ran against Fujimori and finished with a similarly close result, which led to the declaration dragging on for weeks. Castillo was eventually jailed after trying to illegally disband Congress and govern by decree, and Sánchez served as a minister in his government. Fujimori is one of the most well-known figures in Peruvian politics, and this is her fourth time running for office. Her late father, Alberto Fujimori, was formerly the president of Peru and was eventually jailed for crimes against humanity.



At least 32 dead after major earthquake strikes southern Philippines

Hundreds of captives freed from Boko Haram mountain hideout

At least 360 people kidnapped by Boko Haram jihadists from a mainly Muslim community in Nigeria's north-eastern Borno state in March have been freed from a remote mountain hideout. The circumstances of how they were freed are disputed. The army says it had launched an unprecedented intelligence-led operation that had been weeks in the planning and taken the Islamist militants by surprise. But a local group, the Borno South Youth Initiative, says it mediated the unconditional release, putting the number of those freed at 416. Mass abductions by armed groups for ransom have become a common tactic in Nigeria in recent years - and though it is illegal to pay ransoms, it does happen. Boko Haram infamously kidnapped more

than 200 schoolgirls from the village of Chibok in 2014 - around 90 of whom remain missing. At the time the group forced its captives into sexual slavery, domestic servitude or used them as suicide bombers. But a range of groups across Nigeria now use kidnapping to raise funds, focusing on soft targets such as schools, churches, mosques and remote villages. Analysts say ransom payments by desperate families, intermediaries or, in some cases, state authorities have fuelled the abductions. Military spokesperson Lt-Col Haruna M Sani described the assault on Boko Haram's Mandara mountain hideout, "under cover of darkness", as one of the military's "most significant hostage rescue operations" in the north-east.



LEWIS HAMILTON KISSES KIM KARDASHIAN AT MONACO GP

Lewis Hamilton celebrated his second-place finish in the Monaco Grand Prix by kissing Kim Kardashian. The reality TV star and entrepreneur and the seven-time Formula 1 champion have been seen in public together at various events in recent months, including the Super Bowl, although neither has commented in detail on the nature of their relationship. Kim was in attendance throughout the race on Sunday, wearing Ferrari-branded headphones as she supported the Briton from the trackside. When Hamilton was asked about having a "high-profile supporter" at the track after the race, he said it was amazing to have "good people" around. "It's amazing to have her come this weekend and have the support," he said in reply, without mentioning her by name. "With my friends, it was an incredible turnout, just overall with people. I don't really know what else to



say. It's amazing to have good people around you and good people supporting you, and she does that for me every day." Hamilton also blew a kiss from the podium after receiving his second-place trophy, a result which matched his best finish in any Grand Prix since he joined Ferrari ahead of the 2025 season. After securing his podium finish, Hamilton let his guard down, greeting

Kim with a kiss on the cheek and a hug. Immediately afterwards, he escorted her closer to the celebrations, right before the podium ceremony was about to begin. Hamilton, a seven-time F1 champion, appeared to confirm that his Ferrari contract runs until 2027 when asked about next year following an up-and-down start to his second season with the Italian team. "I'm still in contract, so

everything's 100% clear to me. I'm still focused, I'm still motivated, I still love what I do with all my heart, and I'm going to be here for quite some time, so get used to it," he had said before the Canadian Grand Prix last month. "There's a lot of people that are trying to retire me, and that's not even in my thoughts. I'm already thinking of what will be next and planning for the next five

years. But yeah, I still plan to be here for some time." Kimi Antonelli's rise to the top of Formula 1 continued in bizarre circumstances as the 19-year-old Mercedes driver won a much-delayed Monaco Grand Prix on Sunday. Antonelli was on course for victory with 10 laps remaining when the race was red-flagged after parts of the asphalt broke away and two cars crashed in quick succession, one of them third-placed Charles Leclerc. After the race resumed from a standing start, Antonelli took his fifth Grand Prix win in a row and extended his already vast standings lead. He's the youngest F1 winner in Monaco. "Thank you so much guys, the car was a beast today," he told the Mercedes team. Ferrari's Lewis Hamilton crossed the line second and Alpine's Pierre Gasly third. Suryakumar has been with the Mumbai Indians since 2018, when he joined the side from Kolkata Knight Riders. Over the years, he became pivotal to the team's success in the Indian Premier League (IPL), but a horrendous 2026 season seems to have prompted the management to consider alternative options. When a search was conducted on the accounts Suryakumar is following on



Instagram, Mumbai Indians and Hardik Pandya's accounts could not be found. The only photo of the MI team Suryakumar had on his Instagram account was one in which he featured alongside Rohit Sharma and MS Dhoni, two of the biggest stalwarts in Indian cricket. Suryakumar scored just 270 runs for Mumbai in the IPL 2026 campaign, at an average of 20.77. He managed only two half-centuries as MI finished ninth in the ten-team points table. Suryakumar Yadav's SKYfall Since the decision to replace Suryakumar Yadav with Shreyas Iyer in India's T20I team was announced, reac-

tions have been pouring in thick and fast. Former India off-spinner Ravichandran Ashwin has expressed reservations over the decision. Ashwin said he could understand the disappointment Suryakumar might be feeling after being left out of the side. "Look, I think it's a very interesting precedent. I just want to put myself in Suryakumar Yadav's shoes and, for an instance, think how he would be feeling at this point in time. The pair were in the



crowd as the Cleveland Cavaliers faced the New York Knicks during the Eastern Conference Finals. While courtside seats are usually removed and replaced after games, this particular chair has attracted attention because of Swift's appearance at the event. The listing pres-

ents it as a collectible tied to both a major NBA playoff series and one of the most recognisable names in entertainment. The auction house argues that Swift's presence at the game transformed an ordinary courtside seat into a unique keepsake. It also points to the crossover

between sport and popular culture, a combination that has frequently followed Swift and Kelce's public appearances together. Inside The Adidas Trionda: The Sensor Equipped 2026 World Cup Ball That Must Be Charged Before Kickoff

There is a ritual happening at every 2026 World Cup venue before each match that would have sounded absurd ten years ago. The official match ball, the Adidas Trionda, is placed on a charging pad for approximately 90 minutes before kickoff. Without that charge, the sensor inside it will not work. With it, every touch, pass, shot and deflection across 90 minutes of football will be tracked 500 times per second and transmitted in real time to the VAR room. This is the ball that referees, coaches and broadcasters will be relying on across all 104 matches of the 2026 FIFA World Cup. Here is what is actually inside it and why it matters. The Technology Inside the Ball At the core of the Trionda is a 14-gram motion sensor chip, embed-



ded inside one of the ball's four panels with counterbalances across the other three to preserve flight stability. The chip is an inertial measurement unit operating at 500Hz, meaning it captures data 500 times per second covering ball speed, spin rate, trajectory, direction of movement and the exact point of

contact when a player strikes or touches it. That data is transmitted wirelessly in real time to the VAR system and combined with player-tracking cameras installed at each stadium. The primary application is Semi-Automated Offside Technology, which uses the ball's contact data alongside

player skeletal tracking to identify the exact moment a pass is played and resolve tight offside decisions in seconds rather than minutes. The sensor can also help identify individual ball touches, which has implications for handball reviews and any incident where pinpointing the precise moment of contact matters. A full charge takes around 90 minutes and powers the sensor for up to six hours, comfortably covering warm-ups and a full match including extra time. When not in motion, the sensor enters hibernation mode automatically to conserve battery. The Design and What It Represents The Trionda's name translates to three waves in Spanish, referencing the three host nations.

Who Is Manav Suthar? Meet India Spinner Who Claimed 6 Wickets On Test Debut



The rich talent pool of Indian cricket has unearthed another gem in the form of Manav Suthar. Earning his debut cap for the one-off Test against Afghanistan in Mullanpur, Suthar stood tallest for India with the ball, claiming six wickets in his debut innings. Suthar had received India Test cap No. 319 from Kuldeep Yadav, and was greeted with hugs and congratulations from teammates and support staff as he stepped onto the field. What followed was a dream start to his career in whites for the Indian national team. With India batting first, Suthar scored a brisk 28 off 41 balls, including two magnificent sixes. Titans in the Indian Premier League (IPL). He was bought for Rs 30 lakh by GT in the IPL 2025 mega auction. He played a total of four games for GT in IPL 2026, picking up two wickets. His IPL debut, however, had come in the 2024 season, when he played a solitary match. He first caught the selectors' eye during the 2022/23 Ranji Trophy season, when he finished the campaign with a whopping 39 wickets in just six matches. To date, he has taken over 120 first-class wickets. The Rahul Dravid Advice Long before Suthar was picked by the BCCI selection committee for the Afghanistan Test, the left-arm orthodox spinner had already caught the attention of one of India's finest cricketing servants, Rahul Dravid. His triumph over Carlsen was particularly significant as he completed a rare double victory over the Norwegian legend during the event.

Roger Federer Will Return To US Open, Set To Play Exhibition Event Ahead Of 'Hall Of Fame' Induction



Roger Federer will play in an exhibition at the U.S. Open this year, returning to the Grand Slam tournament that he is the only player to win five consecutive times. Days before being enshrined in the International Tennis Hall of Fame, Federer will play in New York on Aug. 25. The event, titled "Roger Federer: An Icon Returns to New York," also will include Andy Roddick, John McEnroe and Andre Agassi. It was announced Monday by the U.S. Tennis Association. Roddick won the 2003 U.S. Open, the year before Federer started dominating the event. He won every one from 2004-08 as part of his 20

Grand Slam singles titles. Federer last played the U.S. Open in 2019. "So many unforgettable moments of my career happened in New York, and Arthur Ashe Stadium is a place that means a great deal to me," he said in a statement. "I've missed being part of that atmosphere and feeling the incredible energy that the fans bring every year." The Hall of Fame induction ceremony is scheduled for Aug. 29 in Newport, Rhode Island. The USTA said there will be further announcements about the lineup for the event, which is during the week before singles play in the tournament begins.

Why Hull's US Open near-miss shows major win is close

All-out attack is rarely a winning recipe in US Opens, but at the Riviera Country Club it very nearly paid off for Charley Hull. She is surely on course to break her major duck sometime soon and in California last Sunday it was only the brilliance of a dominant world number one that bettered the British star. In an exhilarating US Women's Open at Riviera Country Club, Hull posted a record-equalling weekend charge while finishing a shot shy of Nelly Korda's winning total. It is a familiar tale for Hull. She is no stranger to slow starts and rapid finishes in the game's biggest tournaments and there were echoes of Pebble Beach three years ago when she was joint runner-up to Allisen Corpuz. That was when the 30-year-old from Kettering adopted the mantra of "shy girls don't get

sweets" and she ended up three shots behind. This time it was a more blunt, less family-friendly phrase that drove her "go for it" mentality. Hull followed her third-round 65, the lowest score of a thrilling week in Pacific Palisades, with an adrenaline-fuelled closing 67 that began with an eagle and a birdie inside the first three holes. "Just go for it," she said. "I love playing golf like that. I feel like sometimes, the first two days, I'm in a keep my head in the game. 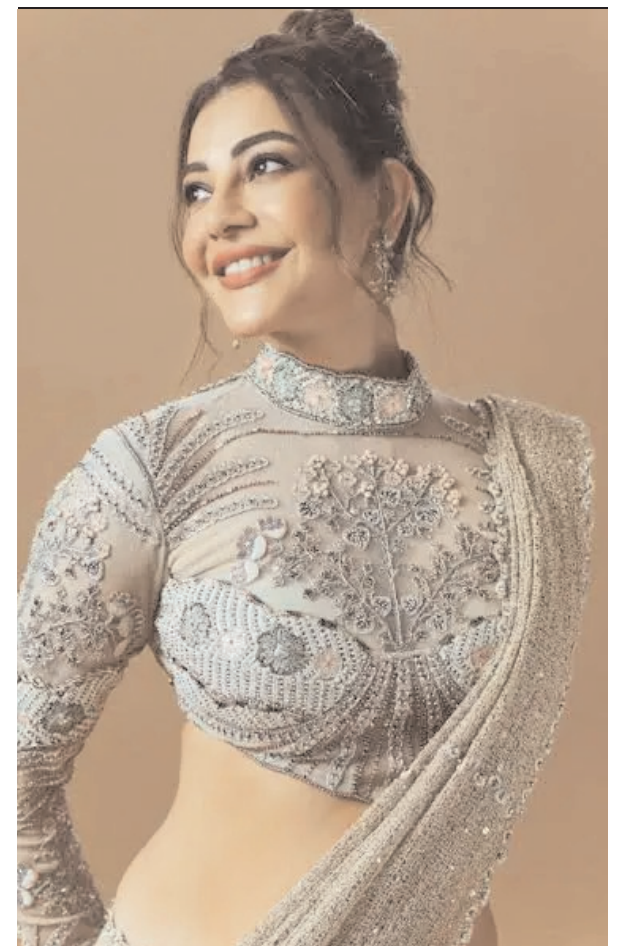
