POCSO case accused who allegedly killed 6 people dies by suicide

HYDERABAD (TSIT): A 35-year-old man wanted for allegedly killing six persons in neighbouring Rangareddy district, was found dead on Monday with police suspecting that he committed suicide. P Rajkumar, a farmer who was an accused in a POCSO case, had allegedly murdered six persons-including a minor girl and two members of the family that had filed the complaint against him besides his wife and two children on the night of July 10. Some residents alerted the police on 'Dial 100' after identifying the body in an area under Kothur police station limits on Monday, a senior police official told PTL. "His body has been found. One bottle of insecticide/pesticide was found beside the body. We are assuming he consumed it because froth was seen in his mouth," the official said. A police team went to the spot and informed his family members, who identified the body to be that of Rajkumar, the official further said. The man was booked under the POCSO Act in May this year for stalking and harassing the minor girl, based on a complaint filed by the girl's family. The accused had stabbed the six victims and slit their throats.

CM Revanth seeks Centre's nod for RRR north section

Hyderabad (TSIT) :

Telangana Chief Minister, Revanth Reddy, on Tuesday requested Union Minister for Road Transport, Nitin Gadkari, to secure Union Cabinet approval to commence work on the northern section of the Regional Ring Road (RRR), noting that 95 per cent of the land acquisition has already been completed. Chief Minister Reddy met Union Minister Gadkari at his residence in Delhi and also urged him to grant the necessary approvals for the Southern Section of the RRR.

CM Reddy stated that if work on both sections of the RRR begins simultaneously, construction would be completed faster and costs reduced. CM Reddy further appealed to Union Minister Gadkari to immediately grant approvals for the Greenfield Highway connecting Hyderabad to Andhra Pradesh's capital Amaravati, a project mandated by the Andhra Pradesh Reorganization Act. CM Reddy stated that sanc-



tioning a 12-lane highway from Bharat Future City to Bandar Port via Amaravati would reduce the travel distance between Hyderabad and Vijayawada by 100 kilometers. He explained that this would expedite freight transport between Hyderabad and Bandar Port. The Telangana CM requested Union Minister Gadkari to facilitate forest department clearances for the Mannanur-Srisaillam elevated corridor and noted that the Nallamala Sanctuary, Srisaillam Temple, and Srisaillam reservoirs fall within the scope of this corridor.

CM Reddy also appealed to Gadkari to sanction a six-lane

alternative highway from Mancherla to Hyderabad, serving as an alternative to the existing Rajiv Highway. He assured that the Telangana government would undertake the necessary land acquisition for this project, adding that the new highway would create fresh opportunities for agriculture and business.

During the meeting with Union Minister for Civil Aviation Ram Mohan Naidu, CM Reddy urged him to ensure that the upcoming airports at Warangal (Mamnoon) and Adilabad are constructed as per international standards. CM Reddy highlighted the strategic and commercial advantages offered by the Warangal and Adilabad airport locations.

K'taka allows hotels, restaurants to remain open till 3:30 a.m. during FIFA WC matches

Bengaluru (TSIT):

In a major relief for football enthusiasts in Bengaluru, Karnataka Chief Minister D.K. Shivakumar said on Tuesday that hotels and restaurants in the city will be permitted to serve food until 3:30 a.m. on three days to enable fans to watch late-night FIFA World Cup matches.

The decision has been taken following a representation from the National Restaurant Association of India (NRAI), which sought relaxation of the usual closing time for eateries during the tournament.

The extended operating hours will be applicable on July 14, July 15 and July 19, when key FIFA World Cup matches are scheduled to be played late at night in India due



to time-zone differences.

Sharing the announcement, Chief Minister Shivakumar described it as good news for football lovers in Bengaluru, saying the state government wanted to ensure fans could enjoy the matches without inconvenience.

The state government has issued the relaxation under the provisions of the Karnataka Police Act, allowing hotels and restaurants to continue serving food until 3:30 a.m. on the specified dates.

In accordance with the

state government's decision, Bengaluru City Police Commissioner Seemanth Kumar Singh has issued the necessary orders permitting late-night screening of the matches and the extended operation of hotels and restaurants on the notified dates.

The FIFA World Cup, one of the premier international club football tournaments, features champion clubs from different continental confederations competing for the world title. The competition attracts millions of viewers across the globe, including a large fan following in India, where football enthusiasts often stay awake through the night to watch marquee matches live because of the time difference with the host nation.

'Will be out soon': Aviation Minister on AAIB's final report into AI171 crash

Dholera/Ahmedabad (TSIT):

The investigation into the Air India Flight AI-171 crash in Ahmedabad has entered its final stages, with the final report expected to be released soon, Union Civil Aviation Minister Rammohan Naidu Kinjarapu said on Tuesday, stressing that establishing the exact cause of the accident is more important than issuing the report quickly. Speaking after reviewing the progress of the Dholera International Airport project, Naidu said the Aircraft Accident Investigation Bureau (AAIB) was conducting the probe transparently and professionally. "Regarding the Ahmedabad plane crash involving the Air India flight, the investigation is currently in its final stages. The AAIB, which is handling the probe, is fully capable and is carrying out the investigation in a completely transparent manner.

Data-driven governance key to better public services: CM Naidu

CM Reviews Governance with Ministers, Secretaries and Heads of Departments

Amaravati (TSIT):

Andhra Pradesh Chief Minister N. Chandrababu Naidu on Tuesday urged senior officials to strengthen field-level governance by interacting directly with the public and adopting data-driven decision-making to improve the delivery of government services.

Addressing a review meeting with Ministers, Secretaries and Heads of Departments (HoDs) in Amaravati, the Chief Minister directed all departments to achieve zero pendency in the Public Grievance Redressal System (PGRS). Stressing the need for proactive administration, he said governance should focus on preventing problems rather than merely responding to them.

Chandrababu Naidu said



the government had fulfilled its promise of not increasing electricity tariffs during its tenure so far and noted that the implementation of the True Down mechanism had further reduced the burden on consumers. He also called for promoting induction stoves, expanding solar power generation and exploring alternative energy sources.

Reviewing irrigation projects, the Chief Minister announced that the Polavaram Project would be completed and dedicated to the nation by March 2027. He

said Godavari water would reach Anakapalli through the Polavaram Left Main Canal on August 14, while the first phase of the Veligonda Project would be inaugurated on September 1.

He added that work on 36 priority irrigation projects was progressing on a fast track. The Chief Minister also directed officials to accelerate the implementation of centrally sponsored schemes, particularly the Jal Jeevan Mission, and to regularly monitor governance using the Monthly Economic Reports.

Telangana's Gruha Jyothi Scheme Illuminates 54 Lac Homes,

● Provides Rs.4,600 Crore Annual Relief to Poor and Middle-Class Families

Hyderabad: In a significant move aimed at easing the financial burden on economically vulnerable households, the Telangana Government's flagship welfare initiative, the Gruha Jyothi Scheme, has officially benefited over 5.413 million (54.13 lakh) families across the State. According to official data released by the government, the programme has disbursed a total electricity subsidy of Rs.4,659.91 crore, with Rs.3,900.54 crore already reimbursed to power distribution companies (DISCOMs) to cover the cost of zero bills.

Launched under the leadership of Chief Minister A. Revanth Reddy, who assumed office on December 7, 2023, the scheme fulfils a key electoral promise of the

Congress government. Implemented following Government Order (G.O. Ms. No. 7) issued on February 26, 2024, the programme provides free electricity up to 200 units per month to eligible households holding white ration cards. Beneficiaries began receiving zero electricity bills from March 2024 onward, provided their monthly consumption remained within the prescribed limit.

The initiative addresses a long-standing hardship faced by salaried and lower-income families, who often dread the arrival of the first day of the month due to mounting household expenses. For decades, the cycle of rising prices and stagnant incomes left little room for savings. The Gruha Jyothi Scheme has disrupted this pattern by eliminating a recurring month-



ly cost, enabling families to save between Rs.500 and Rs.1,500 every month.

Residents across Telangana have reported that these savings are now being redirected toward essential needs such as children's education, healthcare, nutrition, and grocery purchases, significantly improving their household financial stability. Notably, the benefit has also been extended to eligible families resid-

ing in rented accommodations, ensuring widespread coverage across urban and rural areas alike.

Eligibility and Conditions

The scheme applies exclusively to domestic electricity connections. Commercial and business connections are not eligible. The free electricity benefit is strictly contingent on consumption remaining within 200 units per month. As per the operational guidelines, if consumption exceeds the limit by even a single unit, the consumer is required to pay the entire monthly bill. The benefit is restricted to one domestic connection per eligible family, and applicants must possess a valid white ration card with Aadhaar linkage where applicable.

Economic Significance and Fiscal Sustainability

Experts note that the subsidy

serves a dual purpose: it directly strengthens the purchasing power of vulnerable groups while sustaining the financial health of the power sector through government reimbursements. However, the scheme also represents a substantial fiscal commitment. Senior Journalist Suresh Kashyap, reporting from Hyderabad, observed, "Electricity is no longer a luxury but a basic necessity. While this welfare measure has brought immense relief to millions, its long-term success will depend on the government's ability to balance public welfare with prudent fiscal management." He emphasised that achieving this equilibrium will require continued reforms in the power sector, an efficient subsidy framework, and greater adoption of renewable energy sources.

India not alone in E20 transition as countries worldwide push higher ethanol blending

New Delhi (TSIT) :

India's transition to E20 fuel is part of a broader global shift towards cleaner transportation fuels, with many developed and emerging economies already adopting higher ethanol-blended petrol to reduce carbon emissions, improve energy security and lower dependence on imported crude oil.

The rollout of petrol containing 20 per cent ethanol (E20) has sparked public debate in India in recent months, with concerns raised over vehicle compatibility and its broader impact. However, global trends indi-



cate that ethanol blending has become a key component of clean energy strategies across several countries, many of which have set ambitious targets to further increase ethanol content in transport fuels. According to various reports compiled in the 'Global Bioethanol Blending Policies Map', governments around the world are accelerating the use of bioethanol-blended petrol as part of efforts to curb fossil fuel consumption, reduce greenhouse gas emissions and strengthen domestic energy resilience.

Bhatti inaugurates power substations



Jogulamba Gadwal, July 15 (TSIT): Deputy Chief Minister and Energy Minister Mallu Bhatti Vikramarka inaugurated several 33/11 KV electricity substations in

Jogulamba Gadwal district and laid the foundation stone for new power infrastructure projects. Addressing a public meeting, he said the State Government is committed

to completing pending irrigation projects in the erstwhile Mahabubnagar district, strengthening electricity infrastructure and implementing welfare schemes. He highlighted free power for agriculture, the Gruha Jyothi scheme, Rythu Bharosa assistance and support for Self-Help Groups. He also assured adequate funds for irrigation projects and improved infrastructure to benefit farmers and rural communities.

Dy CM inaugurates power substations

Jogulamba Gadwal, July 14 (TSIT): Deputy Chief Minister Bhatti Vikramarka Mallu received a warm welcome from the district administration during his visit to inaugurate newly established electricity substations in various mandals. Superintendent of Police T. Srinivasa Rao welcomed the Deputy Chief Minister on behalf of the district police. The new substations are expected to strengthen the power distribution network, improve supply quality and ensure uninterrupted



electricity to domestic, agricultural, commercial and industrial consumers. Senior officials, public representatives and Electricity Department officials attended the programme, while police made elaborate security arrangements for the smooth conduct of the events.

Collector reviews SHG health screening



Mahabubnagar (TSIT): District Collector Khushboo Gupta directed officials to expedite the health screening programme for women Self-Help Group (SHG) members being implemented on a pilot basis in five mandals. Reviewing the programme on Tuesday, she stressed awareness, inter-departmental coordination and daily monitoring to improve participation. The Collector instructed officials to ensure timely health reports, medical advice, treatment and follow-up care for beneficiaries. Women diagnosed with hypertension, diabetes or anaemia should receive immediate counselling and medicines, she said. Assistant Collector Sai Shivani, DRDO Narasimulu, DMHO Dr. A. Srinivasulu and officials attended the review meeting.

Podu land issues to be resolved as per Forest Rights Act norms.

MANCHERIAL (TSIT): District Collector Kumar Deepak has said that issues relating to podu (forest) lands would be resolved strictly in accordance with the provisions of the Forest Rights Act (RoFR), and only eligible beneficiaries would be covered under the law. The Collector, accompanied by District Forest Officer Rahul Kishan Jadhav, Kotapalli Circle Inspector Krishna and Divisional Forest Officer Sarveshwar, inspected forest land allegedly brought under cultivation in violation of norms at Edagatta village in Kotapalli mandal on Tuesday. Addressing officials during the inspection, Mr. Deepak said the Act applies only to eligible Scheduled Tribe cultivators who had been cultivating forest land before 2005 and had acquired rights under the prescribed norms.

TTD revises donor privileges, clears key development works



Tirumala, July 14 (TSIT): The Tirumala Tirupati Devasthanams (TTD) Board on Tuesday approved revised privileges for donors contributing to various TTD trusts and schemes, with the new guidelines set to come into effect from midnight. Existing benefits for donors who have already contributed will remain unchanged. Addressing the media after the TTD Board meeting held at Annamayya Bhavan, TTD Chairman B.R. Naidu, accompanied by Executive Officer Muddada Ravi Chandra, said the revised norms were introduced to ensure greater transparency and uniformity in the management of donations. The Board approved several infrastructure and pilgrim welfare projects, including the construction of permanent shelters, queue lines and toilets for SSD token holders near Alwar Tank in Tirumala at a cost of Rs.6.31 crore. It also cleared the construction of a double-lane bridge near the Kumaradhara and Pasupudhara dams at Rs.2.77 crore and approved the installation of an 800-kW wind turbine generator to strengthen TTD's green energy initiatives. The Board sanctioned the construction of a 100-room pilgrims' rest house at the Sri Kodandarama Swamy Temple in Ontimitta at a cost of Rs.17.84 crore and approved Rs.2.11 crore for land acquisition to facilitate expansion of the North-East Mada Street and improve pilgrim amenities at the temple.

KOIL ALWAR TIRUMANJANAM IN VIEW OF ANNUAL BUDGET FEST HELD

Tirumala, 14 July 2026: On the occasion of the annual Salakatla Anivara Asthanam, scheduled to be observed on July 17, the sacred Koil Alwar Tirumanjanam was performed in accordance with the Agama traditions at the Sri Venkateswara Temple in Tirumala on Tuesday. Speaking to the media outside the temple, the TTD Executive Officer Sri Muddada Ravichandra, along with Additional EO Sri Ch. Venkaiah Chowdary, said that Koil Alwar Tirumanjanam is traditionally conducted four times a year—prior to Ugadi, Anivara Asthanam, Brahmotsavams, and Vaikuntha Ekadasi. As part of this ritual, the temple premises from Ananda Nilayam to the Bangaru Vakili, including the sub-shrines, temple courtyard, Potu, walls, roof, and puja articles, are thoroughly cleansed with water.



The presiding deity was completely covered with a cloth during the purification process. After the cleansing, the entire temple was sprinkled with a sacred aromatic mixture. Thereafter, the veil was removed, and the temple priests performed special pujas and Naivedyam and resumed

Darshan to devotees. In view of the ceremony, the Ashtadala Padapadmaradhana Seva was cancelled for the day. Among those present includes TTD JEO Dr. A. Sharath, CVSO Sri Muralikrishna, temple Deputy EO Sri Lokanatham, several TTD Board Members, and other officials.

Jagan Demands Rs.1 Cr Compensation for Families of Deceased Fishermen

Visakhapatnam (TSIT) Former Andhra Pradesh Chief Minister and YSR Congress Party President Y.S. Jagan Mohan Reddy visited the families of six fishermen who lost their lives after their fishing boat capsized off the Visakhapatnam coast. He also met and consoled Chinna, the lone survivor of the tragic incident.



Addressing the media at Jabbar Thota Junction, Jagan demanded that the State Government provide Rs.1 crore as compensation to each bereaved family and compensate the owners of the fishing boat that sank in the accident. He alleged that the tragedy claimed six lives due to the negligence of the authorities, who failed to respond promptly despite receiving information about the incident.

Jagan stated that the accident occurred barely 10 miles from the Visakhapatnam coast, yet

rescue agencies, including the Coast Guard and other authorities, failed to act in time. He criticized the government for what he described as a complete lack of urgency and compassion, pointing out that no minister had visited the affected families even days after the tragedy. Calling the government's announced compensation of Rs.5 lakh inadequate, Jagan argued that the deaths resulted from official negligence rather than an unavoidable accident. He assured the victims' families

that if the present government failed to provide adequate compensation, a future YSRCP government would grant Rs.1 crore each to the bereaved families and financial assistance to survivor Chinna within one month of assuming office. He also promised compensation for the sunken fishing boat. The former Chief Minister further accused the three-member inquiry committee constituted by the government of submitting a misleading report by claiming that information about the

incident had reached officials only in the early hours of July 5. He maintained that the authorities had been alerted much earlier but failed to initiate timely rescue operations.

Meanwhile, YSRCP Visakhapatnam District President K.K. Raju announced that the party would provide Rs.7 lakh each to the families of the six deceased fishermen and extend the same financial assistance to Chinna, the lone survivor of the accident.

Mortal Remains of Telugu Tourists Killed in Vietnam Boat Tragedy Brought Home

Visakhapatnam (TSIT): The mortal remains of the three Telugu tourists who lost their lives in the Vietnam boat tragedy have been successfully repatriated to India and are being transported to their respective hometowns with full state support and coordination. The repatriation was carried out under the guidance of Union Minister for Civil Aviation Kinjarapu Ram Mohan Naidu, with the active support of the Ministry of Civil Aviation, the Embassy of India in Vietnam, AP Bhavan, and other concerned agencies. The mortal



remains arrived at the Mumbai International Air Cargo Terminal at 9:35 p.m. on July 13, where all medical, customs, immigration, and cargo clearance formalities were completed swiftly through coordinated efforts. Chandana Nancharayya coordinated the entire opera-

tion and personally escorted the mortal remains on an IndiGo flight that departed Mumbai at 5:30 a.m. on July 14.

On their arrival at Hyderabad Airport at 7:20 a.m., the mortal remains were received by Andhra Pradesh Minister for MSME Kondapalli Srinivas. Ambulances arranged by Krishna Mohan (NRT), along with representatives of the respective District Collectors, were kept ready to transport the mortal remains with dignity to Machilipatnam,

Hindupur, and Kadapa. Officials ensured that the bereaved families were kept informed throughout the process and that all necessary local arrangements were made for the final journey. Team AP Bhavan continues to monitor and coordinate the transportation until the mortal remains are respectfully handed over to the respective families. The State Government also reiterated that all other Telugu tourists affected by the Vietnam boat tragedy had safely returned to their respective destinations on Sunday night.

Early Detection Can Prevent Serious Liver Disease, Says Dr. Gopi Srikanth



Visakhapatnam (TSIT) Early diagnosis and timely treatment of liver diseases can prevent serious complications and significantly improve recovery, said Dr. Gopi Srikanth, Liver Transplant Specialist at Yashoda Hospitals, during a media conference held at Sairam Ritz Comfort Hotel in Visakhapatnam. He advised people with diabetes, obesity, alcohol consumption habits, or a family history of liver

disease to undergo regular liver health screening. Dr. Srikanth said that along with routine liver function tests, FibroScan enables doctors to detect liver damage before it progresses to cirrhosis. He noted that fatty liver disease is increasingly linked not only to alcohol consumption but also to obesity and unhealthy lifestyles, adding that weight loss and lifestyle modifications can reverse the condition in many patients.

He emphasized that liver transplantation is a safe and globally accepted treatment for patients with end-stage liver disease. Nearly 90 per cent of transplant recipients can return to a normal and productive life after surgery. He explained that both deceased-donor and living-donor liver transplants are performed, and living donors generally do not suffer long-term health complications.

The cost of a liver transplant is around Rs.25 lakh. While the procedure is not yet fully covered under the Aarogyaasri scheme, efforts are underway to expand access. Dr. Srikanth said Yashoda Hospitals in Hyderabad performs liver transplant surgeries regularly and successfully completed eight deceased-donor liver transplants last year. Yashoda Hospitals Marketing Head S.V.V. Ramakrishna also attended the media interaction.

AP to Prepare Special Action Plan for Wildlife and Environmental Conservation

Speaker Ayyanna Patrudu Reviews Development of Visakhapatnam Zoo and Kambalakonda Sanctuary

Visakhapatnam (TSIT) Andhra Pradesh Legislative Assembly Speaker and Chairman of the Assembly Committee on Wildlife and Environmental Conservation, Chintakayala Ayyanna Patrudu, said the committee will submit a comprehensive report to the State Government recommending a special action plan for the protection of wildlife, forests, and the environment. He added that the committee would also suggest legal reforms, if required, to strengthen conservation efforts across the state.

Chairing a review meeting with officials from the Forest Department, Revenue Department, VMRDA, GVMC and other departments at the Visakhapatnam Collectorate on Tuesday, the Speaker said wildlife conservation has become a shared responsibility



in the face of growing environmental challenges. He noted that the committee had inspected the Kambalakonda Wildlife Sanctuary, Indira Gandhi Zoological Park, and the Animal Rescue Centre to assess infrastructure, wildlife management, staffing, visitor amenities and future development needs. Ayyanna Patrudu said the Visakhapatnam Zoo requires nearly Rs.10 crore annually for its effective management and announced that he would take the initiative to mobilize Rs.3 crore every year through

MPLADS funds from MPs representing North Andhra. He also called for improved visitor facilities, including additional toilets, modern food courts and better public amenities, while encouraging innovative revenue-generating initiatives.

Expressing concern over manpower shortages, the Speaker pointed out that 59 of the 81 sanctioned posts in the zoo remain vacant and that only one veterinarian and one assistant are available to care for 1,404 animals. He said the committee would recommend

immediate filling of vacancies to the State Government. The Speaker urged industries to utilize their CSR funds for the development of the zoo and wildlife conservation projects. He also suggested seeking support from banks and institutions such as the Tirumala Tirupati Devasthanams (TTD).

Committee members proposed developing the Visakhapatnam and Tirupati zoos into model zoological parks, strengthening tourism infrastructure, adopting PPP models, and studying international best practices such as the Singapore Mandai Zoo model. District Collector M. Abhishikt Kishore, Chief Conservator of Forests Kashi Viswanath Raju, VMRDA Commissioner Tej Bharat, District Forest Officer Ravinder Dama, Zoo Curator Dr. Mangamma, and senior officials from various departments.

CM Revanth urges Centre to complete Warangal, Adilabad airports by June 2028

He added that Kakatiya culture will be given prominence in the design of the Warangal airport. "A spirit of cooperation between the Central and state governments will continue, with development as the primary goal," he said.

Arrest Congress Youth Leaders, Demand BC Organisations

Khammam Govt Hospital needs major upgrade: CPM

Khammam town (TSIT): The CPM has demanded that the Khammam Government General Hospital be upgraded into a 1,000-bed super-speciality hospital, citing inadequate infrastructure and shortage of medical staff. Following a survey conducted at the hospital on Tuesday, CPM state secretary member Nunna Nageswara Rao said the hospital, the only major government referral facility in the district, caters not only to patients from Khammam but also from neighbouring districts of Telangana, Andhra Pradesh and Chhattisgarh. Despite the heavy patient load, basic medical facilities remain inadequate, he alleged.

He said patients are forced to wait for long hours at the outpatient registration and pharmacy counters and urged the government to increase the number of counters to ease overcrowding.Nageswara Rao demanded that the existing 575-bed hospital be expanded into a 1,000-bed super-speciality facility with permanent specialist doctors replacing con-

tractual appointments. He also called for the immediate appointment of gynaecologists at the Mother and Child Health Centre. The CPM leader urged the government to sanction Rs 300 crore for hospital infrastructure, commission the newly constructed building, install the MRI unit already sanctioned at a cost of Rs 6 crore, and revive the defunct CT scanning centre. The absence of MRI and scanning facilities is forcing poor patients to spend thousands of rupees at private diagnostic centres, he said.

He also sought the appointment of a full-time cardiologist, recruitment of additional medical and sanitation staff, faster laboratory and X-ray services, improved facilities for persons with disabilities at Sadaram camps, and uninterrupted supply of medicines in the hospital. Later, a memorandum highlighting the hospital's problems was submitted to Government General Hospital Superintendent Dr Narendra. Several CPM leaders participated in the survey.

Govt rules out private institutions on Telugu University campus



Hyderabad, July 14 (TSIT): The Telangana Government has clarified that no private individual or institution will be allotted space on the Suravaram Pratap Reddy Telugu University campus. The assurance was given during a meeting at the State Secretariat with Higher Education Department officials and university authorities. The government reaffirmed its commitment to strengthening the university and expanding programmes related to Telugu language, literature, culture and arts. Vice-Chancellor Prof. Nityananda Rao conveyed the decision to protesting students at the Nampally campus, ending their 15-day agitation. Students welcomed the announcement, and the university thanked all those who supported its cause.

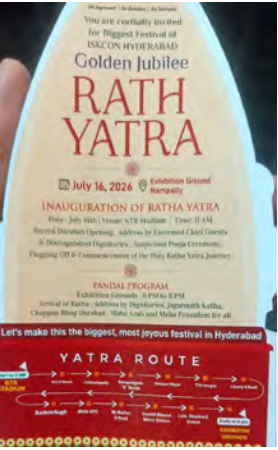

Apollo Hospitals Secunderabad Successfully Treats Achalasia Cardia Patients with Advanced POEM Procedure

Hyderabad: Doctors at Apollo Hospitals, Secunderabad have successfully treated patients suffering from Achalasia Cardia, a rare disorder in which the nerves controlling the food pipe (esophagus) fail to function properly, leading to difficulty in swallowing and other digestive complications. Dr. Bhaskar and Dr. Venu Gongati, Consultant Medical Gastroenterologists Apollo Hospitals Secunderabad said, there has been a noticeable rise in such cases in the post-COVID period, with infections believed to be a contributing factor. Patients commonly present with symptoms such as difficulty swallowing, chest pain, regurgitation of food, weight loss and chronic digestive discomfort.

He said Mrs. Vijayalakshmi, Age,37, from Warangal, had been suffering from severe



swallowing difficulties for nearly 10 years. Despite undergoing pneumatic dilatation five years ago, her symptoms persisted, significantly affecting her quality of life. Following the POEM procedure, she experienced remarkable relief and is recovering well.Another patient, Mr. Ravinder, Age, 50, from Karimnagar, presented with Achalasia Cardia along with cardiomyopathy and a severely reduced ejection fraction

(EF) of 30 per cent. As he was on dual antiplatelet therapy and considered a high-risk candidate for conventional surgery, treatment options were limited. The minimally invasive POEM procedure offered a safe and effective alternative, leading to successful treatment and recovery.

Dr. Bhaskar said traditionally, surgery has been the standard treatment for Achalasia Cardia. However, Apollo Hospitals is now offering an

advanced minimally invasive endoscopic procedure called Per Oral Endoscopic Myotomy (POEM). The procedure is performed through an endoscope without any external incisions and enables patients to return home the very next day.Dr. Venu Gongati, Consultant Medical Gastroenterologists Apollo Hospitals Secunderabad said, we are performed the procedure successfully on Vijayalakshmi (37) from Warangal, who had been suffering from the condition for the past three years. Following treatment, she has shown significant improvement and is recovering well. Another patient, Ravinder (50) from Karimnagar, also underwent the procedure successfully and experienced substantial relief from his symptoms.

EDITORIAL

*A Quiet Indo-Pacific
Revolution Is Underway,
And India Is At Its Centre*

It seems the building blocks of India's vision for the Indo-Pacific are being put in place rapidly. What's more, its receiving enthusiastic support from key countries that are actually in this region and have strong interests in making it happen. Certainly, there is much more to do, but the process has begun. Its not just the rather dizzying number of initiatives coming out of the visit by the Prime Minister to Indonesia and Australia, but also a squaring of the circle in another event that happened just before his travel. Besides, each of these are cooperating with the other in almost exactly the same areas, in an interlocking mesh of jigsaw moves, about as complicated to fathom. It's a process to watch, with huge implications.

Interlocking Parts

Take these visits in terms of their individual focus. Indonesia lies at the heart of ASEAN (Association of South East Asian Nations), and for years, the now rather shaky Quad - comprising India, Japan, Australia and the US - talked about the 'centrality' of ASEAN without anyone actually knowing how this was to be achieved. Now it's a done deal, at least as far as India and two other members of the Quad are concerned. In February 2026, Australian Prime Minister Albanese and Indonesian President Subianto signed the vital Australia-Indonesia Treaty on Common Security (the Jakarta Treaty). It not only commits the two nations to "consult each other on security threats", but also "establishes defense interoperability, and expands military education exchanges". In March, Japanese Prime Minister Takaichi Sanae was in Indonesia to sign an enhanced agreement to sanction the export of arms and equipment - a huge change in policy for pacifist Japan - and also signed protocols for exchange of sensitive information. And in July, there was the Indian Prime Minister, signing on to significantly enhanced defence cooperation, not just limited to BrahMos and air-to-air missile deals, but much more besides. Just before that, on July 2, the Japanese Prime Minister in Delhi signed on to a "Partnership of Strategic Convergence and Trust", again shared with the others. One can almost hear an audible 'click' as things fall into place.

The Mechanics On The Ground

Now break that up into its component parts in terms of mechanics on the ground. Australia has now embedded a senior Indonesian officer inside the Australian Defence forces, in addition to a joint training programme. India has just invited Indonesia to be part of the Indian Navy-run Information Fusion Centre - Indian Ocean Region (IFC-IOR), a multinational maritime security and information-sharing hub designed to monitor threats like piracy, trafficking, and illegal fishing. That means sharing of data on a real-time basis. Japan and Indonesia signed on to an Integrated Defence Dialogue Mechanism and "enhancing discussions on measures to protect classified military information, with a view to strengthening operational cooperation". Australia is already part of the Fusion Centre, as is Japan. Both are also signed on to vital logistics cooperation agreements, which essentially means each can use the others' ports and airfields.

THE POLITICS OF SATLUJ: A FILM THAT NO PARTY CAN FULLY OWN

The controversy surrounding Satluj has moved far beyond a debate over a film. It has become a political litmus test for every major party in Punjab, exposing decades of contradictions on the issue of justice for the victims of militancy, counter insurgency and the human rights violations of the 1980s and 1990s. For years, Punjab's mainstream parties have largely treated this painful chapter as an issue to be managed rather than confronted. Satluj has disrupted that equilibrium. Every statement, every silence and every political calculation is now being closely scrutinised. The sharpest intervention has come not from a political party but from Paramjit Kaur Khalsa, widow of human rights activist Jaswant Singh Khalsa, whose investigation into the alleged secret cremation of unidentified bodies cost him his life. In a strongly worded message ahead of the Harike Pattan remembrance ceremony, Paramjit Kaur Khalsa refused to spare any political formation. She accused the Congress of presiding over widespread human rights violations, alleged that successive Shiromani Akali Dal governments protected and rewarded police officers accused in such cases, charged the Aam Aadmi Party government with failing to ensure that convicted officials were brought to justice, and also referred to allegations against the BJP led Union government over targeted killings abroad. Her intervention is politically significant because it exposes a different vulnerability for each party. For the Congress, Satluj inevitably revives allegations linked to the counter insurgency period under its governments. For the Shiromani Akali Dal, which seeks to reclaim the Panthic space, the film also brings renewed scrutiny of its own tenure in power, when critics allege successive governments did little to pursue accountability against police officers facing serious allegations. The Aam Aadmi Party, despite presenting itself as a break from traditional politics, is now being asked whether it has fundamentally altered the state's approach to these unresolved cases. The BJP, meanwhile, must balance its



national security narrative with its efforts to expand politically among Sikhs, making the debate particularly sensitive. Rather than allowing any one party to claim the moral high ground, her statement places the entire political establishment under scrutiny. The political dilemma is evident. It explains why almost every political party has adopted a guarded approach. Their responses suggest they are still trying to assess how Punjab's Hindu and Sikh voters will react before taking an unequivocal stand. For the BJP, the issue carries particular sensitivity because any perception of endorsing a narrative critical of the state's counter insurgency operations could alienate sections of its core support base. At the same time, appearing insensitive to Sikh grievances risks reinforcing political barriers that have historically limited its expansion in Punjab. The Congress has to balance acknowledging historical wrongs without accepting political responsibility for decisions

taken during its tenure. The Akali Dal cannot afford to alienate its traditional Panthic constituency but also faces uncomfortable questions about its own record in government. The AAP government, which came to power promising clean governance and change, is under pressure to demonstrate that it is willing to revisit unresolved questions of justice rather than merely administer the status quo. Yet, electoral evidence suggests that Panthic politics has not disappeared from Punjab. The victories of Amritpal Singh from Khadoor Sahib and Sarabjeet Singh Khalsa from Faridkot in the 2024 Lok Sabha elections demonstrated that there remains significant political space for candidates campaigning around Sikh identity, justice and unresolved historical issues. Amritpal Singh's victory reflected the continuing appeal of Panthic mobilisation centred on questions of Sikh identity and perceived injustice, while Sarabjeet Singh Khalsa's election carried its own

symbolism. As the son of Beant Singh, one of the two bodyguards who assassinated then Prime Minister Indira Gandhi after Operation Blue Star, his victory underscored that the legacy of 1984 and its aftermath continues to influence sections of Punjab's electorate. Together, these victories showed that Panthic politics remains electorally relevant despite repeated assertions that it has receded. Satluj taps directly into that sentiment. For mainstream parties, this creates a dilemma. Remaining silent risks ceding political space to Panthic voices, while taking a clear position could unsettle carefully cultivated support bases across communities. The film, therefore, has the potential to reshape political messaging even if it does not immediately alter electoral outcomes. That is precisely why Satluj has become politically consequential. The film is not merely reopening old wounds; it is reopening unresolved political questions. Every party recognises that an aggressive embrace of the

film's narrative could consolidate one section of voters while alienating another. Conversely, distancing itself from the issue risks appearing indifferent to demands for justice. The result is a carefully calibrated politics of ambiguity. Satluj has already achieved one political outcome: it has forced every major party to revisit questions that have remained politically unresolved for four decades, how Punjab remembers the excesses of the militancy and counter insurgency years, whether successive governments did enough to deliver justice to victims' families, and how the State should reconcile competing narratives of national security, human rights and Sikh identity. These questions have rarely found political consensus, making them among Punjab's most enduring fault lines. In that sense, Satluj is no longer just a film. It has become a test of political credibility, revealing not only how parties remember Punjab's past, but also how they intend to navigate its future.

DIGNITY OF THE TEMPLE OF JUSTICE AND CIVIC DECORUM

The entire structure of Indian democracy rests on four key pillars—the legislature, the executive, the judiciary, and an independent media. Among these, the judiciary is the institution to which every citizen turns with ultimate hope. When the administrative system fails, when governance becomes frustrating, and when rights are violated, citizens approach the courts. Therefore, the courts are not only a constitutional institution but also a center of citizens' trust. If unruly behavior, outrage, threats, abusive language, or an atmosphere of chaos prevails during court proceedings, its impact is not limited to the court alone, but impacts the entire credibility of democracy. A recent incident in the Supreme Court has drawn national attention to the importance of maintaining a balance between judicial dignity and civil conduct. Individuals have the right to access justice, the right to express their views, and the right to criticize judicial decisions within constitutional limits. However, this does not mean disrupting court proceedings, showing disrespect to judges, or using the court as a platform for personal outrage. Such incidents violate democratic norms and undermine public confidence in the judicial system. It is equally true that such behavior by a citizen often does not arise overnight. Often, years of litigation, financial burdens, mental stress, social insecurity, and inordinate delays in justice can lead a person to a

state of deep despair. This can lead to dissatisfaction and anger towards the system. However, under no circumstances can this anger justify violating the dignity of the court. In a democratic system, duties and decorum are equally essential as rights. The Indian Constitution grants every citizen freedom of expression. This freedom is the soul of democracy, as a healthy democracy is unimaginable without the expression of opinions. However, the Constitution does not consider this freedom an absolute right. Appropriate restrictions have also been established on matters such as public order, national security, defamation, and contempt of court. This aim is not to suppress expression, but to maintain the dignity of democratic institutions and balance in society. Court decisions can be legally criticized, scholarly debated, and review petitions can be filed, but personal insults, abusive language, and disruption of the judicial process are unacceptable. The judiciary's greatest strength lies not in its police force or punitive powers, but in the public's trust. This trust is what makes every court order effective. If the court's dignity is repeatedly challenged and respect for it diminishes, the fundamental concept of the rule of law will begin to weaken. Therefore, protecting the institutional reputation of the judiciary is not only the responsibility of judges and lawyers, but also the constitutional obligation of every citizen. On the other hand, it must also be acknowledged that the

Indian judicial system faces numerous challenges. Crores of cases are pending in various courts across the country. In many cases, decisions take decades, not years. The process of obtaining justice becomes extremely difficult for the common citizen, both financially and psychologically. The lengthy duration of trials, repeated dates, mounting expenses, and uncertain outcomes drive individuals into despair. In such circumstances, the need for judicial reforms is felt more urgently than ever. Judicial reforms should not be limited to the creation of new laws. Expedient filling of vacancies in courts, maximum use of modern technology, expansion of the e-court system, digital records, timely hearings, and strengthening alternative dispute resolution mechanisms are the need of the hour. Speedy disposal of cases will also enhance citizens' trust and satisfaction with the judicial system. It's also essential that everyone who comes to court isn't viewed solely as a litigant. Many people arrive at court carrying years of social, economic, and psychological suffering. Therefore, counseling services and psychosocial support should be developed where necessary. This can help stressed parties maintain emotional balance and reduce the likelihood of unnecessary conflict. Security arrangements in courts are also a necessity. Courts receive a large number of litigants, advocates, and ordinary citizens daily. Therefore, security arrangements should not be merely formal, but rather effective

and well-trained, so that any untoward situation can be dealt with promptly and with dignity. Ensuring a fear-free, disciplined, and respectful court environment should be a priority in every democratic society. Today, there is also a need to promote judicial literacy in society. Most citizens are not fully familiar with the judicial process, rights, and responsibilities. If awareness about constitutional values and the judicial process is increased through schools, colleges, and social organizations, it will foster both respect and understanding for the courts. Criticism has an important place in democracy. Even the judiciary is not beyond criticism. Many landmark decisions have been subjected to serious debate from time to time by scholars, lawyers, and civil society. This is the hallmark of a healthy democracy. However, criticism must be based on facts, logic, and constitutional norms. Personal sarcasm, indecent behavior, and public insults to institutions undermine democratic culture. It must also be remembered that the court is not just an institution for judges, but for every citizen. Protecting its dignity is as important as protecting freedom of expression. There is no contradiction between the two. True democracy is one where citizens can speak their minds fearlessly while also maintaining the dignity of institutions. Today, as a large portion of social discourse has shifted to digital media, unverified information, emotional reactions, and derogatory comments about judicial institutions spread rapidly.

'Zalengam Diary' And Roads As New Language In Demand To Divide Manipur

Roads are no longer just roads in Manipur since May 2023 when the Meitei-Kuki ethnic violence erupted in the state bordering Myanmar. Every new bridge, bypass or transport corridor is seen as an attempt at setting a narrative for political geography, but not a development project. Infrastructure is no longer about engineering in the state where territory has become deeply contested. It is now connected with questions about identity, administration, security and competing visions of Manipur's future. The absence of official clarity over the approval, regulation and oversight of several such projects has added to the confusion and even raised questions about transparency. This has only deepened public suspicion and intensified the political significance attached to such projects. On July 10, a 270-foot Bailey bridge was inaugurated in Manipur's Chandel district. That has sparked a new debate over territory, mobility and the Kuki tribes' demand for breaking up Manipur. The Kukis say the bridge is a rural connectivity project that serves the underserved between Chandel district and Kuki settlements in southern Manipur's Churachandpur district. They say they had been cut off following the outbreak of the ethnic violence. The bridge took 18 months to complete at a cost of Rs 3.5 crore, all of it crowdfunded with no government help, Kuki organisations say. The Kuki Inpi Manipur has refuted allegations that the bridge would be used as a



route for carrying out unlawful activities, including drug trafficking. The bridge only restored an essential transport link severed by the violence that killed over 260 and displaced thousands. But the controversy refuses to go away because of one question: how did a project like this evade official scrutiny? In December 2025, a 'ring road' allegedly paved without the state government's approval and passing through forests in six districts was found in Manipur. The matter came to light after the National Green Tribunal (NGT) ordered the Manipur government to ensure no more construction work was done on the 'ring road'. After the NGT order, an umbrella body of civil society organisations of the Meitei community told reporters that the road has been locally referred to as "German Road" and at certain stretches as "Tiger Road". 'German' and 'Tiger' are nicknames of Kuki insurgents. Engineers say the 270-foot Bailey bridge needs specialised

steel components, engineered foundations, heavy equipment and professional supervision. They say the cost seems technically plausible if voluntary labour and donated resources were used, but there are no clear answers about the source of the bridge components, engineering certification, statutory approvals and compliance with public safety standards. Soon after the inauguration of the "crowdfunded bridge", several social media accounts that supported the demand for breaking up Manipur into separate territories on ethnic lines, described the bridge as a major achievement in connecting Kuki settlements in Churachandpur with Chandel, Tengnoupal and Moreh along the porous border with Myanmar. The online chatter after the bridge's inauguration showed that infrastructure had become inseparable from the Manipur crisis. The new bridge, called Khulmi, adds another chapter to the long list of contro-

versial projects in Manipur, such as the so-called "Tiger road" or "German road". Named after German H Haokip of the insurgent group Kuki National Front (MNC), the 'road' connects K a n g p o k p i , Churachandpur, Chandel and Tengnoupal, mostly bypassing the state capital Imphal, which lies in central Manipur's valley region. Built and upgraded in phases through mountainous terrain, this 'road' connects Kuki settlements that depended on routes passing through the valley. The Kuki tribes show the road as an example of community initiative undertaken through voluntary contributions and crowdfunding. The Manipur government has questioned the legality and strategic purpose of the road and clarified that it had not officially sanctioned the project. It said legal action would be taken for carrying out the illegal project. The NGT's scrutiny showed the matter's seriousness on the implications it would have on the environment.



Karnataka to set up India’s first govt AI University

Bengaluru, July 14 (TSIT): Karnataka Chief Minister D.K. Shivakumar on Tuesday announced that the state will establish India’s first government-driven Artificial Intelligence (AI) University and an AI Hub to promote research, innovation and startup incubation, reaffirming Karnataka’s ambition to become a global centre for responsible AI.

Making the announcement while inaugurating Google I/O Connect India 2026 at the Bangalore International Exhibition Centre (BIEC), the Chief Minister said the proposed AI University would nurture world-class talent, advance cutting-edge research and strengthen



collaboration between academia, industry and government. Shivakumar said the state also plans to establish an AI Hub as an incubation centre to support AI research and development by startups, companies and academic institutions.

Intelligence as the defining technological revolution of the present era, he said Karnataka aims to become an AI-native state, where AI is integrated into governance and public service delivery to improve education, healthcare, agriculture and citizen services. "AI must help teachers

teach better, doctors diagnose diseases earlier, farmers receive better advisory services and citizens access government services with dignity and speed," he said. Highlighting Karnataka’s leadership in the technology sector, the Chief Minister noted that the state contributes nearly 40 per cent of India’s software exports and that Bengaluru is home to more than 17,000 startups and numerous Global Capability Centres (GCCs).

He said the government would continue expanding digital infrastructure, including data centres and advanced computing facilities, to support AI innovation, cloud computing and research.

Congress Setting Up ‘Gruel Centers’ for Party Workers in the Name of Bharat Jodo: Opposition Leader R. Ashok

Bengaluru : Opposition Leader in the Legislative Assembly R. Ashok expressed strong anger, stating that under the name of Bharat Jodo Yuva Sanghas, the Congress is preparing to set up gruel centers (free food centers) for its party workers.

At a press conference on Tuesday, he sharply criticized the government, saying it has withheld assistance and pensions meant for farmers, senior citizens, orphans, widows, and other beneficiaries, while using taxpayers’ money to provide rehabilitation exclusively for Congress workers.

“The government has not yet released 5,000 crore under Gruhalakshmi and 750 crore under Annabhagya. Former Minister Lakshmi Hebbalkar even shed tears and admitted the truth during the Belagavi session. Yet the money has still not reached the beneficiaries. But the Congress is announc-



ing new schemes every day only for its leaders and workers. The Chairman of the Guarantee Implementation Committee, H.M. Revanna, has been given a house rent allowance of 58 lakh. Including salary, other allowances, facilities, and 12 staff members, the total expenditure comes to nearly 2 crore. The government has not even provided me, the Leader of Opposition, with an official residence. But it has allotted a government house to the Vice-Chairman of the committee and spent 58

lakh. Salaries are being paid to district and taluk committee presidents, allowances to members, and including office expenses in the districts, the monthly expenditure exceeds 150 crore,” he said.

Ashok alleged that under the banner of Rahul Gandhi’s Bharat Jodo, the Congress is creating organizations and providing employment to its unemployed workers. Trainers are being appointed for each committee with a fixed salary of 24,000. The total cost of this scheme is 1,010 crore. He criti-

cized this as a blatant misuse of taxpayers’ hard-earned money. “Primary health centers lack medicines and staff. If the same money had been allocated there, it would have helped people. Karnataka has been proven unsafe for new mothers. The government has not increased the honorarium for ASHA workers who are protesting. Pensions have not been paid to beneficiaries for three months. There is a pending amount of 78 crore for orphans for eight months. The money being given to the Youth Empowerment Department could have been used to build good sports facilities in rural areas. Instead, they have chosen to indulge in loot,” he charged. “Every taluk already has a Sports Department office. Yet a separate committee has been formed and Congress leaders appointed. With elections just 1.5 years away, the Congress has opened these gruel centers for its workers.

Bengaluru : Bengaluru Development Minister Krishna Byre Gowda chaired an important review meeting on matters relating to the Revenue Departments of the five City Corporations under the Greater Bengaluru Authority (GBA). Make all necessary preparations for the Government to undertake door-to-door distribution of e-Khata certificates to approximately 2.3 million properties across the GBA jurisdiction.

Identify properties that remain outside the property tax net and bring them under the tax system to improve property tax collection.

Detect cases where property tax is being underpaid, revise assessments where necessary, and ensure proper collection of property tax.

Ensure that all properties within the GBA jurisdiction are assigned Khatas and brought under an efficient property tax collection system. Expedite the process of converting B-Khatas into A-Khatas. Use GIS, drones and other technologies to integrate property-related



data available with BESCOM, the Bangalore Water Supply and Sewerage Board (BWSSB), and other departments in order to identify unassessed properties and bring them within the property tax framework, he said.

Following the implementation of the new advertisement policy, digital advertisements are being installed illegally across the city. All unauthorised advertisements erected without valid licences must be removed without any leniency. Even where licences have been obtained, if the advertisements are being used for commercial purposes contrary to the approved

permissions, appropriate action must also be initiated against such violations.

Mandatory Registration of Construction & Demolition Waste Transport Vehicles

All vehicles engaged in transporting construction and demolition (C&D) waste must be compulsorily registered. Installation of GPS tracking devices in all such vehicles will also be mandatory. Month long Freedom from Waste Campaign

A comprehensive plan should be prepared to organise a month-long "Freedom from Waste" campaign throughout August across the GBA area with the objective

of completely removing garbage, solid waste, construction debris, soil mounds, weeds and other waste materials. To enhance Bengaluru’s cleanliness and aesthetics, the City Corporations, K-RIDE, Railways, Metro and other departments should coordinate and jointly implement the campaign during August.

Under the Bengaluru Solid Waste Management Limited (BSWML), approximately 22,732 tonnes of waste have been identified across 1,616 locations within the GBA area. Officials have been directed to prepare a comprehensive plan for its removal.

Property Owners must Clean Vacant Sites

Property owners in the five City Corporations under the GBA will be given time until August 15 to clear weeds, overgrown vegetation and waste from their vacant sites.

If the sites are not cleaned by the deadline, the respective City Corporations will undertake the cleaning and recover the cost by adding it to the property’s tax dues.

India should ride AI wave to emerge as a product nation: Industry experts



Bengaluru: Industry experts speaking at a Confederation of Indian Industry (CII) event said India should ride the AI wave to emerge as a product nation. While the country has excelled in engineering and software services, it has yet to fully master the entire product value chain from design and development to engineering and manufacturing, said Kamal Bali, chairman of CII Innoverge 2026, the trade body’s flagship national innovation summit scheduled to be held in Bengaluru on July 22 and 23.

Speaking at the curtain-raiser event on Tuesday, he said the focus should now be on transforming India into a globally relevant product powerhouse, with AI embedded across every function and supported by the three pillars of innovation, trust and

technology. India’s world-class research institutions, supportive public policy framework, robust domestic market, skilled workforce and scalable manufacturing capabilities provide the ideal foundation for this transformation, Mr. Bali added.

Explaining how India can ride the AI wave to emerge as a product nation, Kris Gopalakrishnan, past president of CII and co-founder of Infosys, said the country should leverage the AI revolution to make the transition. He observed that AI’s entry into job markets was creating disruptions, but added that every technological shift also opened up new opportunities.

When asked about India’s biggest bottleneck in becoming an AI-led product nation, Mr. Gopalakrishnan identified

investment as the primary challenge. While India has grown from a handful of startups to over two lakh startups, including more than 4,500 deep-tech firms, funding remains limited, he said. Indian startups typically receive 1 crore to 2 crore in funding (around \$100,000 to \$200,000), whereas comparable startups in the United States often secure nearly \$20 million, he noted, highlighting the need for greater domestic and foreign investment in higher education, research and AI infrastructure.

Noting that India’s exports continue to be dominated by IT services, Mr. Gopalakrishnan stressed the need to develop indigenous technologies backed by strong research and development and intellectual property. He also underlined the importance of building a robust R&D and innovation ecosystem involving industry, academia, startups and entrepreneurs.

Also speaking at the event, Rabindra Srikantan, past chairman of CII, highlighted India’s strong digital foundation, expanding manufacturing ecosystem and supportive policy environment.

LoP Udhayanidhi Stalin seeks action against cops over Kumari youth's custodial death

CHENNAI: Leader of the Opposition Udhayanidhi Stalin on Tuesday (July 14) condemned the alleged custodial death of Sabarivarman in Nagercoil and demanded stringent action against the police personnel involved.

Referring to the police version, Udhayanidhi said the department had claimed that Sabarivarman was in good health at the time of his arrest and died after falling ill following the enquiry.

However, he said the victim's family had alleged that Sabarivarman, a person with a disability, was beaten by police personnel while in custody.



"Sabarivarman's family is protesting, alleging that he was assaulted by the police despite being a person with a disability. The Chief Minister

must respond appropriately to this,," Udhayanidhi said.

The DMK leader appealed to the State government to initiate immediate action against

cops responsible for the incident. He alleged that the TVK government was applying "one law for ordinary citizens and another for ruling party functionaries", contrasting the custodial death with the release of a TVK functionary accused in a similar gutka smuggling case.

TVK functionary Arun, who was arrested in Erode in a gutka-related case, was released on station bail the very same day, but Sabarivarman is dead, he pointed out. "The Chief Minister, who is in charge of the police department, must answer these allegations," he said.

Protect animal slaughter religious rights: DMK Ansari

TIRUCHY: Manithaneya Jananayaga Katchi general secretary and MLA who won from the DMK's rising sun symbol, M Thamimun Ansari, on Tuesday welcomed the court's placing the ban on slaughtering animals in public places in abeyance and urged the State government to frame guidelines, stating that slaughter for religious sacrifice should be treated differently from commercial slaughter.

Speaking to reporters in Tiruchy, Ansari said slaughtering animals for religious sacrifices during temple festivals and Bakrid was distinct from commercial slaughter and therefore required separate guidelines from the government.

Condemning Karnataka's insistence on proceeding with the proposed Mekedatu dam despite court directions, Ansari urged the Tamil Nadu government to file a contempt of court petition against Karnataka.

On the State government, Ansari said its performance could not be judged within 60 days and that at least six months should be given before assessing



its functioning. Commenting on recent appointments, he said the appointment of Layola Mani as Chairman of the Tamil Nadu Text Book Corporation was TVK's choice. Referring to the appointment of Venkata Narayana, a Kannadiga, as Tamil Nadu's representative in Delhi, he alleged that TVK had been appointing party associates to key posts and criticised the practice of assigning people from the film industry to crucial positions. Ansari also dismissed speculation about a DMK-AIADMK alliance to form the government, saying neither party's leadership had spoken about such a possibility and that it was unfair to debate it at this stage.

Fishers assured sustainable employment policy

CHENNAI: The Tamil Nadu government will evolve a permanent and legally sustainable employment policy for fishermen from eight villages around Ennore, Energy and Law Minister R Nirmalkumar said on Tuesday after holding talks with representatives of fishermen's associations over their long-pending demands. The meeting, held at the Tamil Nadu Electricity Board headquarters, focused on issues raised by fishermen from villages including Nettukuppam and Thazhankuppam, particularly employment opportunities, livelihood concerns, environmental protection and pollution control. The meeting was held days after the Southern bench of the National Green Tribunal (NGT) had restrained the Tamil Nadu Power Generation Corporation Ltd from carrying out any construction activity related to the 2x660 MW Ennore SEZ Thermal Power Plant at Vayalur village in Tiruvallur district for four weeks, as the project is proceeding without a valid Environmental



Clearance (EC).The applicant contended that the CRZ clearance granted to the project in January 2014 had expired and that construction was continuing without a valid clearance. He also argued that the EC had expired on December 31, 2025. Nirmalkumar said the government would formulate a recruitment framework that is legally tenable and can be followed not only for the current recruitment process but also for future appointments. He said the policy would be prepared after a detailed assessment of registered fishermen and fishing families in the eight villages, households that are genuinely dependent on fishing for their livelihood and those that are economically vulnerable.

NTK slams attack on students seeking Tasmac closure

CHENNAI: NTK chief coordinator Seeman on Tuesday condemned the alleged police action against schoolgirls who staged a protest seeking the closure of a Tasmac liquor outlet in Kodali village near Jayankondam in Ariyalur district. He accused the Tamilaga Vettri Kazhagam (TVK) government of using the police to suppress a peaceful protest and demanded stringent action against those responsible. In a statement, Seeman alleged that the students were protesting against a Tasmac outlet operating on a route frequently used by schoolchildren and claimed that the outlet posed a threat to their safety. He criticised the government for failing to close the liquor shop despite its announcement that Tasmac outlets located near educational institutions would be removed. The NTK leader questioned how the Kodali outlet was left out of the closure exercise and asked when similar shops functioning across the State would be shut down. He said it was a matter of concern that students had to leave their classrooms

Is it OK to eat mango if you're at risk for diabetes? Experts weigh in



In a recent study, mangoes more effectively improved pre-diabetes risk factors in a new study than low-sugar granola bars. The key to mangoes' better results likely lies in their being a whole food with natural fiber, vitamins, and nutrients.

However, experts agree that the best way to avoid type 2 diabetes is to eat a balanced, healthy diet and be physically active, rather than to depend on a single 'superfood' to prevent the condition. A new study suggests that at least one high-sugar tropical fruit, mangoes, may be more likely to help prevent type 2 diabetes than a low-sugar snack. The authors of the study, which appears in the journal Foods, suggest that the correlation between a preference for mango and a lower risk of diabetes may have to do with mangoes being more than simply a sweet treat, since they are a natural whole food that contains fiber, vitamins, and nutrients. Low-sugar snacks designed to be convenient and tasty, however, may not be as nutritionally rich, may contain additives, and may thus be less likely to be healthy.

For the study, funded by the National Mango Board, two dozen participants age 50 to 70 years in age were divided into two groups. None had received a diabetes diagnosis at baseline. The study was conducted at

Florida State University.

Mango vs low-sugar granola bar: Which is healthier?

Individuals in one group received a fresh mango each day containing 32 grams (g) of sugar, while members of the other group were instead provided with a calorically similar low-sugar granola bar containing 11 g of sugar.

During the 24-week trial, researchers tracked participants' blood glucose (sugar) levels, insulin sensitivity, and measured changes in body fat. Higher blood glucose, reduced insulin sensitivity, and increases in body fat are risk factors for type 2 diabetes.

Twenty-three participants completed the study. The authors found improved blood glucose control, enhanced insulin sensitivity, and reduced body fat for the 11 members of the mango group.

As a result, the study reports a reduced risk for developing type 2 diabetes, based primarily on improvements in blood glucose levels.

Its authors note that this focus is a limitation of the study. It is also the case, the authors say, that the limited racial and ethnic diversity of the participant sample may reduce their findings' generalizability. In addition, dietary adherence throughout the trial was self-reported, which

is not always reliable.

Whole fruits always better than manufactured sweets

"This study is an interesting contrast on [the] potential effects of natural sugars such as found in fruits, versus sugars from granola bars (in this case) that may be an added sugar, versus [sugars] naturally found in the environment," Jason Ng, MD, told Medical News Today.

Ng teaches endocrinology and metabolism in the Department of Medicine at the University of Pittsburgh, and was not involved in the study.

While it may seem surprising that a food with as much sugar in it as a mango could still be a healthy choice when one is trying to avoid type 2 diabetes, the idea makes sense to Ng and to ebem Ünlüler, MSc, genetic engineer and Chief Longevity Officer at the London Regenerative Institute in the United Kingdom, also not involved in the study.

Asked if tropical fruits really make sense as a dietary choice in this context, Ünlüler replied "broadly, yes." "Whole fruits — including mango.

— are generally safe and often beneficial as part of a balanced diet for diabetes prevention and for many people with type 2 diabetes, with a few important caveats," she told

What to eat and drink before and after a flu shot: Expert Q&A

All international and national health organizations, including the Centers for Disease Control and Prevention (CDC)Trusted Source, agree that it is important to get vaccinated against the flu on a yearly basis, typically in the autumn and winter season, to prevent not just getting ill due to infection with the influenza virus, but also potential serious complications that may arise from getting the flu. Flu shots are both safe and effective, but some people may still worry about potential side effects. The most common side effects are mild and do not last very long, and they can include low grade fever, headache, muscle aches, and nausea. These side effects are expected, and they are often a sign that the vaccine is working — it is teaching the body's immune system to fight the influenza virus, which can result in these mild and temporary inflammatory responses.

Other people might worry about feeling faint during vaccination — this can be due to anxiety around needles or about vaccines. So what can you do to prevent or mitigate these reactions during and after a flu shot? What you eat and drink before getting the vaccine could help your body go through this experience more smoothly. To get some expert tips on how to keep our flu shot experiences positive with the help of healthy dietary choices, Medical News Today spoke to Michelle Routhenstein, MS, RD, CDCES, CDN, a preventive cardiology dietitian at EntirelyNourished, and to Elena Rolt, MSc, DipION, IFMCP, rCNHC, nutritional therapist at Health.Miro, and ebem Ünlüler, MSc, genetic engineer and Chief Longevity Officer at the London Regenerative Institute in the United Kingdom.

For those worried about becoming dizzy and feeling



faint during or immediately after a flu shot, Routhenstein recommended hydrating well and eating light, whole foods.

"To help prevent dizziness or lightheadedness, stay well-hydrated and eat a light, balanced snack before a flu shot," she advised. "As a genetic engineer, I often look at how nutrition can support our immune system at a cellular level, particularly around vaccination. While food and drink cannot change the efficacy of the flu jab itself, certain choices may help the body respond more smoothly and ease common side effects," Ünlüler clarified.

She also emphasized the importance of stabilizing blood sugar levels before getting vaccinated, "particularly for those who may feel lightheaded or

anxious about needles."

Like Routhenstein, Ünlüler recommended a protein- and complex carb-rich snack pre-flu jab, suggesting yogurt with oats or wholegrain toast. She also cautioned that "even mild dehydration can increase feelings of dizziness," recommending drinking "water or an electrolyte-rich drink [as] a simple preventive measure."

What should you eat after a flu shot, and why?

Rolt told us that when it comes to what to eat and drink after a flu shot, it is important to have a balanced meal filled with an array of nutrients. "After receiving a flu vaccine, the immune system initiates an inflammatory response to process the vaccine antigens, followed by the formation of antibodies by B cells to provide protection against the virus," she explained.

"This process involves oxidative stress and inflammation as part of immune activation and memory cell development, which are essential for effective immunity but can also temporarily challenge the body's balance," the nutritional therapist detailed. "A balanced meal that would include all of these nutrients would be a chicken broth rich in easily digestible protein, garlic, onions, carrots, bok choy or broccoli, or any other leafy greens, and mushrooms (a great source of beta-glucans), paired with berry-based drinks like cranberry or sea buckthorn tea with manuka honey, providing vitamin C and polyphenols to modulate inflammation and oxidative stress," Rolt suggested.

According to Rolt, "this combination helps support the immune system's recovery, reduces potential side effects and optimises the body's response to the flu shot."

In addition, Ünlüler also recommended "turmeric and oily fish high in omega-3," which help moderate inflammation without blunting the immune system's adaptive response. "A diet with sufficient protein, such as lean meats, legumes, or tofu, also provides the amino acids necessary for antibody production," she added. Furthermore, while hydration is crucial before getting vaccinated, it is equally important after vaccination. "Staying hydrated is another important consideration as optimal blood circulation, as it helps the efficient delivery of nutrients and immune cells required for an effective vaccine response," Rolt explained.

"Hydration may also reduce the severity of side effects such as headache, fatigue, and muscle soreness, while helping the body to regulate temperature," she added. "Water, herbal teas, or broths can assist the body in regulating temperature and managing mild post-vaccine symptoms," said Ünlüler. Is there a diet you should maintain throughout the flu season?

CIC ORDERS OIL MINISTRY ARM TO DISCLOSE PETROL, ETHANOL DATA

New Delhi: The Central Information Commission (CIC) has directed the Petroleum Planning and Analysis Cell (PPAC), the oil ministry's planning arm, to reveal historical data on petrol production and imports, ethanol procurement and blending, and petroleum sector profits. The direction was given to share the information with an RTI applicant after the commission found that the cell provided only "partial information."

Information Commissioner Khushwant Singh Sethi also directed PPAC to provide the web link for ethanol blending notifications, transfer the query on ethanol suppliers to the concerned public authority, and invoke the appropriate exemption under the RTI Act, while responding to the request for company-wise petrol supplier information. The RTI application sought six sets of information relating to India's petrol and ethanol programme, including fuel production and



imports, ethanol blending norms, procurement and consumption of ethanol, supplier details and profits from petrol sales. The commission observed that "the respondent has provided partial information to the appellant" and directed it to furnish a revised response on different queries. The first query sought year-wise details from 2014-15 onwards of petrol purchased, imported, and produced in India, annual expenditure on petrol, and source-wise break-up. PPAC replied that import, export, production and state-wise data were available on its website, but company details were "of

commercial & confidential nature" and exempt under Sections 8(1)(d) and 8(1)(e) of the RTI Act. During the hearing, the appellant said he "could not find the sought information in (sic) the website." The commission directed PPAC to "send soft copy of the sought information, including historical data, as available on the website to the appellant's e-mail ID." On the second query, the applicant sought year-wise norms, guidelines and official notifications prescribing ethanol blending in petrol. PPAC replied that the National Policy on Biofuels, 2018, governed ethanol blending and

was available on the Ministry of Petroleum and Natural Gas website. The respondent also submitted during the hearing that the notifications were maintained by the ministry and available in the public domain. The commission directed PPAC to "provide the specific website link" for the relevant notifications and orders. The third query sought year-wise details of ethanol procured and consumed for blending, along with reasons for any difference between procurement and consumption. PPAC said Table 14 of its monthly Snapshot of India's Oil & Gas report contained information regarding "ethanol received and blended by PSU OMC's along with the blending percentage." The commission directed the authority to email the available historical data to the appellant. The fourth query related to the ethanol supply chain, with the applicant seeking a year-wise list of ethanol suppliers to oil marketing companies, quantities supplier.

Vivek Venkatswamy backs job security at Hyderabad BRICS summit

Indian students in Germany have doubled in five years: Shweta Guru, Auxilo

July 14, 2026: The United States, the United Kingdom, Canada and Australia still take the bulk of India's outbound students. But the old pecking order is loosening. With rising costs and tighter visa rules, Indian student interest is spilling toward emerging education destinations like Ireland, France, the Netherlands and Germany. In the last 5 years, the number of Indian students in Germany has more than doubled from 28,905 in 2020 to 59,419 in the 2024-25 academic year. India has now passed China to become the country's single largest group of international students, with Turkey a distant third. The Institute for Employment Research projects Germany will need around seven million skilled workers by 2035," informed Shweta Guru, CBO – GlobalEd, Auxilo Finserve. Low-cost education is the single biggest pull for Indian students. A 2025 Leap Scholar survey of more than three million student interactions found about 75% naming cost and affordability as their top concern, ahead of scholarships at 70% and career prospects at

International professionals on a work visa who earn more than about ₹49 lakh (45,300) can qualify for the EU Blue Card, which speeds up their work permit and, in time, facilitates permanent residency. "For Indian families, Germany has changed the maths of studying abroad. Germany offers an 18-month window to find work in Europe's largest economy. For a student in engineering, IT or data science, that is a clear path from classroom to career," added Ms. Guru. Germany ranks among the safer, steadier places for students, with low crime rates, compulsory health cover and public services that work.

ONLY 45 PC BENGALURU PROPERTY OWNERS PAY TAX, SAYS MINISTER

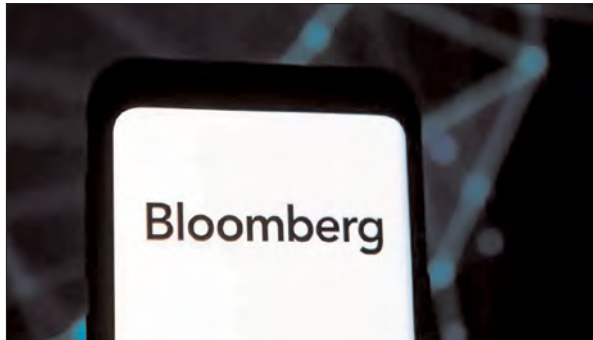


Bengaluru: The Karnataka government has ruled out any immediate increase in property tax in Bengaluru, with Bengaluru Development Minister Krishna Byre Gowda announcing a technology-driven drive to identify thousands of property owners who are allegedly evading taxes. Addressing reporters after reviewing civic administration with Greater Bengaluru Authority (GBA) officials on Tuesday, July 14, the minister said Bengaluru has approximately 36 lakh properties, but only about 16 lakh owners currently pay property tax. The remaining properties will

be surveyed using drones, GPS mapping and other digital tools to detect tax evasion. He emphasised that the government's priority is to widen the tax base rather than raise tax rates. According to the minister, if all eligible property owners pay taxes, civic bodies will have adequate resources for infrastructure development and public services without increasing the burden on honest taxpayers. Krishna Byre Gowda appealed to residents to pay their taxes voluntarily, saying compliance by every property owner would help improve Bengaluru's civic amenities and financial stability. The minister also announced strict action against owners of neglected vacant sites. Property owners have been directed to clean and maintain their vacant plots by August 15. If they fail to do so, the Greater Bengaluru Authority will clean the sites, recover the expenditure from the owners and initiate penalty proceedings as per the rules.

SINGAPORE COURT ORDERS BLOOMBERG TO PAY \$356,000 TO MINISTERS IN DEFAMATION CASE

A Singapore court has ordered Bloomberg and one of its reporters to pay \$460,000 (\$356,000; £266,000) to two ministers who had sued them for defamation over an article referencing their property transactions. Last year, the ministers, K Shanmugam and Tan See Leng, sued Bloomberg and reporter Low De Wei for a 2024 article which had mentioned their property deals. Bloomberg said it did not imply any wrongdoing and had used them as examples of a broader trend. The judge found that when read as a whole, the piece implied wrongdoing by the ministers as it also mentioned secrecy and money laundering. In a statement published by Bloomberg News, the outlet's editor-in-chief John Micklethwait said it was "very disappointed by this ruling but we will of course respect it". "We argued at trial that our reporting was accurate and served an important public interest, and we continue to believe that the ministers have imposed an extremely



strained meaning on what was a solid story," he said. What did the article say? The piece titled "Singapore Mansion Deals Are Increasingly Shrouded in Secrecy" looked at the ways in which some wealthy buyers in Singapore obscured their purchases of Good Class Bungalows - a category of multimillion-dollar mansions in Singapore - such as by using shell companies which hide their identities. It reported that Shanmugam, the Coordinating Minister for National Security and former law minister, had sold a bungalow for \$888m (\$68m; £51m) to an unnamed buyer using a

trust. The piece also noted that Tan, the Minister for Manpower, had bought a Good Class Bungalow for around \$827m - citing him as one example among a list of other public figures who had bought luxury estates through an arrangement known as a non-caveated deal, that makes it harder to track who is involved in the transaction. The article was taken down from Bloomberg's website after the verdict on Tuesday, as ordered by the court. Why did the ministers sue? Days after the article was published in December 2024, the ministers announced that they would take legal action.

How US commerce secretary's Epstein links were uncovered by British whistleblower



A British man has told the BBC how he unearthed evidence indicating that his former employer, Howard Lutnick - now US commerce secretary - failed to disclose a business relationship with the paedophile financier, Jeffrey Epstein. Simon Andriesz, previously a managing director at a Wall Street firm, discovered an email chain from 2018 in which Lutnick and Epstein had discussed the prospects of a start-up business they were both involved in. Andriesz shared his findings - from the millions of released Epstein files - with US politicians on the influential House Oversight Committee, ahead of an appearance there by Lutnick in May. Lutnick told the committee that, to the best of his knowledge, he had only learned this year that Epstein had been an investor in the firm. Speaking on his behalf, the US Commerce Department told us there was no evidence of wrongdoing. Andriesz also discovered

in the files that one of Lutnick's firms had made plans in 2013 to go into business with another figure linked to Epstein, the then-Prince Andrew, by commercially exploiting the contacts the former UK trade envoy had made. "What it involved was a loan to Andrew Mountbatten-Windsor of £1m... to basically buy a prince," he tells File on 4 Investigates. Searching 3.5 million documents "I was completely shocked," says Andriesz, describing the moment when he discovered his own name in the Epstein files - a massive collection of documents, photos, video and emails relating to the notorious sex offender, released by the US government in the past year. The specific files in which Andriesz appeared related to interviews he had given to the FBI while in dispute with his former employer, BGC Partners - a financial brokerage firm, part of Lutnick's Cantor Fitzgerald group.

Trump reverses threat of 20% fee on Strait of Hormuz cargo as US prepares to resume Iran ports blockade

US President Donald Trump is speaking with Iraqi Prime Minister Ali al-Zaidi at the White House. We'll bring you any remarks relating to the Iran conflict. You can also watch the stream at the top of this page. Kuwait's army says it is confronting "hostile aerial targets" in its airspace. "Any explosion sounds, if heard, are the result of air defence systems intercepting hostile attacks," the military says on X. The US ally has repeatedly come under attack from Iran during the ongoing conflict. The UN's maritime agency, the International Maritime Organization (IMO), says at least two people were killed and several others were injured as a result of the overnight attacks on



tankers in the Strait of Hormuz. Earlier, the UAE and Delhi reported that an Indian seafarer had died as a result of Tehran's strikes. Now, the IMO says a second seafarer on the same ship (Al Bahiyah) was also killed. The ship was 13 nautical miles (24 km or 14.9 miles) from the coast of Oman. Another vessel, Mombasa B, was also damaged by Iranian strikes.

Fourteen seafarers were injured during last night's attack. In a statement to the BBC, the maritime agency says it is working with authorities to "confirm the full circumstances" and demands an end to the "cycle of escalation". The IMO says that since the start of the US-Iran war 17 seafarers have died as a result of hostilities in the strait. Donald Trump's latest

Truth Social post suggests that his proposed 20% fee on traffic through the Strait of Hormuz was - at least in part - a bid to secure investment in the US. Foreign investment in the country has been a significant focus for his administration, and one that has cropped up periodically in dealings with foreign countries over the issue of tariffs. While Trump has promised that these deals will be "massive" and will see factories and equipment pour into the US, there are very few details, and we have yet to hear from the Gulf states that he says will be involved. The last line of his post - in which he says that Iran's days of killing protesters are "over" - is also something of a mystery.

TYRANNOSAURUS REX MOST EXPENSIVE DINOSAUR EVER SOLD



A 67 million-year-old Tyrannosaurus rex has been sold for £37.4m (\$50.1m) at a Sotheby's auction in New York - the most ever paid for a dinosaur. The fossil of this infamous predator stands more than 12 feet (4m) tall, and with over 60% of its bones recovered is one of "the most complete" specimens ever found, according to Sotheby's. The winning bidder at the sale on Tuesday has not yet been disclosed. Gus, as the T. rex has been affectionately named, was discovered in 2021 on a remote ranch in the US State of South Dakota. "It's really incredible to see and to have the level of public interest," said Cassandra Hatton, Sotheby's worldwide head of science and natural history. "I think anytime you've got this, it is good for science. In general, more people are going to go to the museums, it adds dinosaurs and natural history into the conversation." The sale exceeded the previous record set by a stegosaurus in 2024, and is the first to exceed the

\$50m benchmark. Some scientists have told the BBC that the auction may herald a new era in fossil collecting by the ultra-rich. Hatton says the price paid reflects the time and resources that went into uncovering the specimen. The bones were excavated over three summers, when it was warm enough for the ground to have thawed, from 2021 to 2023. But it took a further three years in the lab to piece the T. rex back together. This work revealed the skull had bite marks, and previously broken ribs that had healed in its lifetime. Both injuries were potentially sustained during scavenging or during a battle with other dinosaurs. It may be some time before the buyer is revealed, but Apex, the stegosaurus who held the last record, was loaned out to the American Natural History Museum for four years by its billionaire-owner Kenneth Griffin. So, even if Gus has attracted an ultra-wealthy buyer it still might be coming to a museum near you soon.

Yemen's Houthis launch missiles at Saudi Arabia after strikes on Sanaa airport

Yemen's Houthis said they launched missiles at Abha airport in south-western Saudi Arabia on Monday in response to air strikes on Sanaa's airport that they blamed on the kingdom. The Saudi-led coalition in Yemen, which backs the country's internationally-recognised government, said its air defences "dealt with" the missiles and no casualties were reported. The Houthis, who control north-western Yemen and are backed by Iran, earlier accused Saudi Arabia of "blatant aggression", saying it had struck the runway of Sanaa's airport. The strike was claimed by Yemen's government, which said it wanted to prevent an Iranian plane from landing. It was the most significant escalation in the largely dormant conflict between the Houthis and Saudi Arabia since an informal truce took effect four years ago. Yemen has been devastated by a civil war that began in 2014, when the Houthis ousted the government from Sanaa, the capital.



The conflict escalated in 2015, after the Saudi-led coalition of Arab states intervened in an attempt to restore the government's rule. The fighting has reportedly left more than 150,000 people dead and triggered one of the world's worst humanitarian crises, with more than 22 million people in need of some form of aid, according to the UN. On Monday afternoon, footage on social media showed plumes of smoke rising above rooftops in Sanaa after the strikes at the city's international airport. The Houthis' al-Masirah TV said the "departure and landing runways" were targeted.

The internationally-recognised Yemeni government, which is based in the southern port of Aden, said its forces had carried out the strikes amid a dispute over the plane used by a Houthi delegation returning from Iran after the funeral of the late supreme leader Ayatollah Ali Khamenei. "The terrorist Houthi militias, backed by the Iranian regime, prevented Yemeni national aircraft from landing at the airport in the capital, Sanaa, while insisting on allowing an Iranian plane to violate Yemeni territory; consequently, the airport runway was targeted," the Yemeni

defence ministry said. The Iranian plane had to divert and later landed in the Red Sea city of Hudaydah, about 150km (93 miles) to the south-west, according to the Houthis. For more than a decade, aircraft entering Yemeni airspace have required clearance from the Saudi-led coalition, which says it is acting at the Yemeni government's request. Houthi military spokesperson Yahya Saree accused Saudi Arabia of being behind the Sanaa strikes, which he said had ended "the de-escalation phase" of their conflict and would not go "unanswered or unpunished". Saudi authorities did not comment on the strikes before Saree announced on Monday evening that the Houthis had launched a number of ballistic missiles and drones at Abha International Airport "in response to this criminal Saudi aggression". He also warned airlines against flying through Saudi airspace "until the blockade on Sanaa International Airport is lifted".

Australian police reveal unseen photos 25 years after British backpacker murder

Police in Australia have released previously unseen photographs from their investigation into the murder of British backpacker Peter Falconio 25 years ago. Falconio, from Huddersfield, was shot on a remote stretch of highway near the Northern Territory town of Barrow Creek, about 186 miles (300km) north of Alice Springs on 14 July 2001. His body has never been found and police hope the images could jog memories that could lead to a tip-off. His killer, Bradley Murdoch, died of throat cancer aged 67 in jail last year, without disclosing where Falconio's remains might be. The images include a full length picture of Murdoch staring straight at a camera during the police investigation. Falconio's girlfriend Joanne Lees escaped from Murdoch, hiding in scrubland for several hours before she was able to wave down two men driving a truck. One of the photographs taken by police shows Lees looking traumatised in the hours after the attack. Others show injuries



she sustained, including after her wrists were bound with cable ties. Northern Territory Police Force Commissioner Martin Dole said that 25 years was a "significant milestone" and that he hoped the release of new images could jog memories or lead to a tip-off. "This was a traumatic and horrific event for Ms Lees, and for Peter's family, who have now gone such a long time without the answers they deserve," Dole said. "While a murderer has been held accountable for his crimes, this investigation can never be considered closed until Peter's remains are found and his family can lay him to rest."

HUNGARY PARLIAMENT VOTES TO REMOVE PRESIDENT FROM OFFICE

The Hungarian parliament has voted to remove President Tamás Sulyok from office, who was widely seen as a loyalist of former prime minister Viktor Orbán who lost power in April after 16 years. Prime Minister Péter Magyar's Tisza party used its two thirds majority to steamroll through the 17th amendment to the constitution, ending the term of Sulyok and the head of the Constitutional Court Péter Polt. It was the most dramatic day in parliament since the new government took office in early May, after its surprise landslide victory against Orbán's Fidesz party on 12 April. Sulyok now has five days to sign the amendment - his own political death warrant - or refer it to the Constitutional Court. If Sulyok refers it to the court,



Magyar has said he will launch impeachment proceedings against him, which would suspend him from office automatically. Another option would be to simply resign to avoid a constitutional crisis in the interest of the country, as the new government has been urging him to do. Deputies of the now opposition Fidesz party walked out of parliament before Monday's vote, accusing the Tisza party of building a tyranny. Fidesz argues that the amendment grants the government the arbitrary power to dismiss any public official from office, with immediate effect. The great irony of the situation is that Fidesz have fallen foul of their own concept of power," Péter Rona - a former opposition presidential candidate - told the BBC. The 2011 constitution, written by Orbán's

government, enshrined the principle that "the winner takes all". In office from 2010 until 2026, Fidesz reshaped the Hungarian state to its own will, and filled supposedly independent state positions with party loyalists - using its own two-thirds majority. The 141 Tisza deputies in parliament gave a standing ovation as the results of the vote were announced. The amendment also removes Constitutional Court judges who are over the age of 70, and forbids deputies who have served three terms in parliament from standing again - which applies to more than half the current Fidesz deputies. "I quite agree with the removal of the president," András Baka, former head of the Supreme Court, told the Agency.

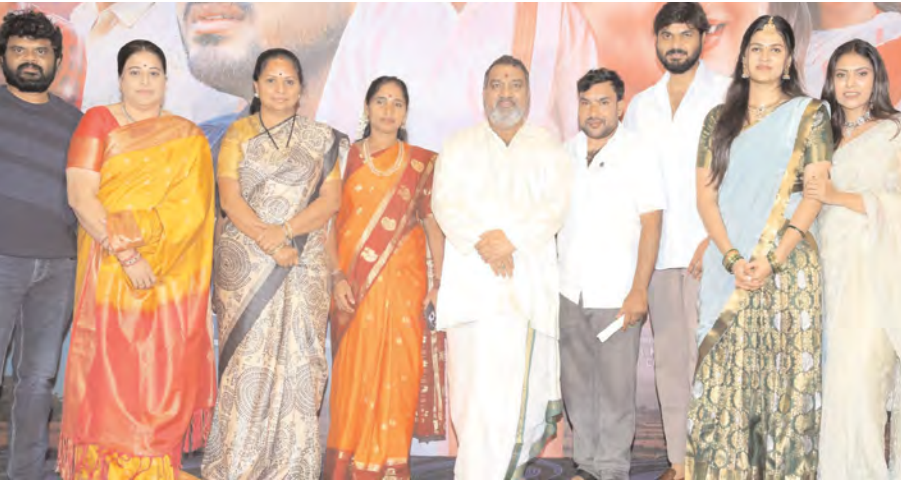
"We Will Release Our Film in Telugu"
