Patna (TSIT) : Rashtriya Janata Dal (RJD) national president and former Bihar Chief Minister Lalu Prasad Yadav was admitted to the Indira Gandhi Institute of Medical Sciences (IGIMS) in Patna on Friday after his health reportedly deteriorated suddenly. According to hospital sources, he was rushed to IGIMS after experiencing complications earlier in the day. A specialised team of doctors has been assigned to monitor his condition and provide necessary medical care. His wife and former Bihar Chief Minister Rabri Devi, along with his daughter and Rajya Sabha MP Misa Bharti, accompanied him to the hospital and remained there while doctors conducted medical evaluations.

Telangana Cabinet clears drought relief,

● Dharani probe and bullet train plans

Hyderabad
(TSIT Bureau):

The Telangana Cabinet, chaired by Chief Minister A. Revanth Reddy, on Friday approved a series of key decisions covering drought relief, governance reforms, infrastructure development and social inclusion.

With the state facing nearly a 40 per cent rainfall deficit due to the El Niño effect, the Cabinet decided to seek financial assistance from the Centre and request a special team to assess the drought situation. Officials were directed to ensure uninterrupted drinking water supply, continuous power without load shedding, and imple-



ment contingency plans for agriculture, irrigation and employment. Farmers were advised to take up low water-intensive crops.

The Cabinet approved the formation of a Special Enquiry Team (SET) to investigate alleged irregularities in the Dharani land records portal, includ-

ing land transactions, record changes, assigned land transfers, and the role of portal developer IL&FS.

It also cleared the establishment of a High-Level Committee under the Chief Secretary to streamline project appraisal, land acquisition, tendering and contract management. The

Cabinet approved amendments to enable the nomination of transgender persons as co-opted members in municipal corporations and allowed Gram Panchayats to deposit funds in nationalised, cooperative banks and post offices.

The Cabinet also approved plans for high-speed rail corridors linking Hyderabad with Mumbai, Bengaluru and Chennai, including a major rail hub near Shamshabad, and sanctioned completion of the Mukteshwar Lift Irrigation Scheme, which will irrigate 45,000 acres in Manthani constituency using 4.5 TMC of Godavari water.

PM Modi launches 75 redeveloped rail stations from Jalandhar

Jalandhar (TSIT):

In a major push to rail and road infrastructure projects, Prime Minister Narendra Modi on Friday inaugurated and laid the foundation stone of projects worth over Rs 5,470 crore, aimed at strengthening connectivity, improving passenger convenience and accelerating economic development, besides connecting India's most revered spiritual and cultural centres.

Before inaugurating 75 redeveloped railway stations and launching two trains, PM Modi met and interacted with Dera Sachkhand's dera's head, Sant Niranjan Dass, marking an outreach to the Dalit community, particularly in Punjab where elections are due in early next year, besides interacting with passengers onboard a train. PM Modi also received the blessings of



Sant Niranjan Dass, a significant meeting. The inaugurated redeveloped railway stations, including Jalandhar Cantonment, across 20 states marked a milestone under the Amrit Bharat Station Scheme, one of the world's largest station redevelopment programmes.

Developed at a cost of about Rs 1,570 crore, these stations have been transformed into modern, passenger-friendly facilities. Redeveloped in the spirit of 'Virasat Bhi, Vikas Bhi',

the stations incorporate elements reflecting local culture, heritage and architecture.

The Prime Minister also inaugurated the Daulatpur Chowk-Kartoli new rail line, constructed at a cost of about Rs 830 crore as part of the Nangal Dam-Talwara-Mukerian New Rail Line Project. It will significantly strengthen rail connectivity between Punjab and Himachal Pradesh, benefiting the districts of Hoshiarpur and Una.

Banks Must Become Partners in Andhra Pradesh's Growth: CM Naidu

Visakhapatnam (TSIT)

Chief Minister N. Chandrababu Naidu on Friday called upon banks to become active partners in Andhra Pradesh's development, stating that access to credit empowers farmers, youth, women and entrepreneurs to achieve economic self-reliance. Addressing the Mega Credit Outreach Programme organised jointly by the Union Finance Ministry and public sector banks at Narasaraopet, alongside Union Finance Minister Nirmala Sitharaman, the Chief Minister said the State had saved Rs.1,538 crore by restructuring high-interest loans inherited from the previous government with the Centre's support.

At the programme, loans worth Rs.3,216 crore were distributed to 1,03,246 beneficiaries across Palnadu dis-



trict, including DWCRA women, farmers, students and entrepreneurs. Chandrababu said the government aims to transform every eligible citizen into an entrepreneur through easy access to institutional credit and highlighted the 'One Family-One Entrepreneur' initiative to promote women-led enterprises.

Union Finance Minister Nirmala Sitharaman said the Centre, under the leadership of Prime Minister Narendra Modi, has strengthened the banking sector through major reforms and ensured easier access to credit for

small entrepreneurs and rural communities. She said banks are now proactively reaching beneficiaries through outreach programmes.

On the occasion, the Chief Minister and the Union Finance Minister also distributed loan sanction letters and inaugurated several CSR-supported initiatives, including an ambulance for a government hospital, mobile demonstration vehicles, bicycles for girl students, battery-operated vehicles for the Tourism Department and tricycles for persons with disabilities.

Terror sponsor Pakistan has no locus-standi to comment on India's internal matters: MEA

New Delhi, July 17 : India on Friday yet again slammed Pakistan for its support and sponsorship of cross-border terrorism while using it as an instrument of state policy.

Addressing a bi-weekly media briefing in New Delhi on Friday, Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said that that investigation continues in last year's heinous Pahalgam terror attack carried out by Pakistan-backed terror groups.

"The Pahalgam terror attack took several innocent lives. You all saw its barbarity. Our authorities have begun investigations in the matter and it continues. As far as cross-border terrorism is concerned, you are well aware of



Pakistan's decades-long sponsorship and support for it as also its continued use as instrument of state policy," he said in response to a question.

The terror attack in Pahalgam took place on April 22, 2025. The Pakistan-backed attackers singled out victims after asking about their religion, forcing them to recite the Islamic 'Kalma' to identify non-Muslims. Among those killed were

25 tourists and one local pony ride operator who tried to save the tourists. The Resistance Front (TRF), an offshoot of Pakistan-based Lashkar-e-Taiba (LeT), claimed responsibility for the attack.

During the briefing, Jaiswal also said that Pakistan has no locus-standi to comment on matters internal to India.

When asked about Pakistani leaders expressing support for Hurriyat leaders after National Investigation Agency (NIA) filed chargesheets against them, Jaiswal responded, "Pakistan has no locus-standi to comment on matters which are internal to India."

Sensex jumps 965 points, Nifty tops 24,300 on buying in banks, IT stocks

Mumbai (TSIT) : Indian equity benchmarks ended sharply higher on Friday, supported by strong buying in private banking, information technology and auto stocks. The Sensex rallied 964.58 points, or 1.25 per cent, to close at 78,151.45. The Nifty also ended firmly in the green, rising 261.55 points, or 1.09 per cent, to settle at 24,334.30. Commenting on Nifty technical outlook, experts said that the 24,400 level remains the immediate resistance and coincides with the 200-day Exponential Moving Average (EMA), making it a crucial hurdle for the index. "A sustained breakout above this zone could reinforce bullish momentum and pave the way for an advance towards the 24,500-24,600 region.

Govt employee remanded in harassment case

Accused municipal employee sent to judicial custody after police investigation; case was first highlighted by The South India Times.

Mahabubabad (TSIT):

A government employee accused in a harassment case was remanded to judicial custody on Friday following a police investigation into allegations of sexual exploitation, financial cheating, workplace harassment and criminal intimidation.

The case came into public focus after The South India Times published an exclusive front-page investigation on May 18, 2026, detailing the allegations made by a woman government employee. The report stated that the victim

alleged she was promised marriage, persuaded to arrange Rs.5 lakh, and later subjected to harassment and intimidation after seeking the return of the money. Following the victim's complaint, Maripeda Police registered Crime No. 147/2026 on June 4 under Sections 69, 318(4) and 351(2) of the Bharatiya Nyaya Sanhita (BNS) and initiated an investigation.

As part of the probe, police examined the complaint, recorded evidence and carried out the investigation in accordance with legal procedures. The

accused, Itikala Swamy, a Senior Assistant in the Mahabubabad Municipality, appeared before Maripeda Police on July 17. He was later produced before the jurisdictional court, which ordered his judicial remand.

Police also informed the Mahabubabad Municipal Commissioner about the arrest and the accused's production before the court after completing the required legal formalities.

The case has drawn considerable public attention in Mahabubabad district. Police said the investigation is continuing.

India's economy remains strong amid West Asia, weak monsoon risks: RBI chief

Mumbai (TSIT):

RBI Governor Sanjay Malhotra said on Friday that India's fundamentals remain strong, with a decent pace of economic expansion despite geopolitical uncertainties triggered by the West Asia crisis.

In an exclusive interview to Doordarshan, the RBI governor also admitted that the ongoing geopolitical tensions in West Asia and a potentially weak monsoon pose key risks to India's economy.

Malhotra defended the performance of the rupee in the backdrop of a strengthening US dollar. "After the war in West Asia, the dollar



has become strong. The currencies of many countries have weakened. If we look at it from a global perspective, India's rupee situation can be considered normal," the RBI governor observed. Malhotra said India's external sector should remain resilient, with strong services exports, remittance inflows, record foreign direct investment and new trade agreements kicking in which would boost exports.

Crop rotation urged to tackle El Niño impact



Bhadradri Kothagudem (TSIT):Farmers should adopt crop rotation and diversify cultivation to reduce the impact of El Niño, Collector Ankit said. During a tour of Palvancha mandal, he inspected the ongoing land re-survey in Sarekallu village, participated in a farmers' awareness programme at Kodipunjula Vagu, and later made a surprise visit to the Karakawagu Mandal Parishad Primary School.

Addressing farmers, the Collector advised cultivation of low water-consuming crops and millets such as ragi, jowar, bajra, fox-tail millet, pulses, sesame and sunflower instead of water-intensive crops. He also stressed water conservation, scientific farming and following technical guidance from agriculture officials.

Collector directs speedy four-lane road construction



Husnabad, July 17 (The South India Times): Karimnagar District Collector Chitra Mishra has directed officials to expedite the construction of the Kothapalli-Husnabad four-lane road while ensuring that the project causes no inconvenience to the public. During field inspections at Kothapalli in Thimmapur Mandal, Chigurumamidi and Mulkanoor on Friday, the Collector reviewed land survey and alignment works for the project. She instructed officials to speed up Phase-I, covering the stretch from Kothapalli to Sundaragiri.

229 SERP, MGNREGS Staff Screened at Free Health Camp in Suryapet



SURYAPET TSIT: A free health screening camp for employees of the Society for Elimination of Rural Poverty (SERP) and Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS-SRDS) was organised at the Integrated Collectorate in Suryapet on Friday as part of a State-wide employee wellness initiative. District Collector Tejas Nand Lal Pawar inaugurated the camp, which was conducted following the directions of SERP Chief Executive Officer D. Divya to promote preventive healthcare among rural development staff across Telangana. A total of 229 employees underwent comprehensive medical examinations, including cardiology, gynaecology, general physician consultations, blood pressure, blood sugar, ECG, Complete Blood Picture (CBP), lipid profile, cholesterol and calcium tests. Special eye screening and women's health check-ups were also conducted.



Lingachari recently took charge as Excise Superintendent of Wanaparthi district.sp.Sunitha Reddy was given a flower plant on Friday at the SP's office. Speaking on this occasion, the SP said that if the two departments work together to curb illegal activities like drugs, illegal liquor manufacturing and transportation, better results can be achieved. The SP suggested that they should work together to build a safe society by raising awareness among the people about laws.

Consumer representatives seek stricter checks on gold jewellery quality

Warangal, July 17 (TSIT): National consumer representatives on Friday met Warangal District Legal Metrology Officer Manohar, urging the department to intensify inspections to prevent adulteration in gold and silver jewellery and protect consumers from financial losses.

The delegation, comprising Sambaraju Chakrapani, Dr. Pallepada Damodar and Mogilicherla Sudarshan, alleged that inadequate monitoring of jewellery businesses in the erstwhile Warangal district and across the Telugu States has resulted in consumer



ers, particularly women, being cheated through adulterated ornaments. The representatives said the Bureau of Indian Standards (BIS) can inspect only licensed jewellers, while they claimed the Legal Metrology Department has wider powers under the Legal Metrology Rules, 2011 to conduct quality inspections.

They also called for joint test checks involving Legal Metrology officials and consumer representatives, as provided under the amended rules.They expressed concern that direct inspections of gold jewellery quality by the department had reportedly ceased after 2013, weakening consumer protection.

Robotic, fluorescence-guided surgery transforming cancer care

Khammam town (TSIT): Advances in robotic and fluorescence-guided surgery are transforming cancer treatment by enabling highly precise procedures with faster recovery and better quality of life for patients, said Dr Chinna Babu, Surgical Oncologist and Robotic Oncology Specialist at Yashoda Hospitals, Hitec City.

Addressing a press conference at the Khammam Press Club, he said modern cancer surgery aims not only to remove tumours but also to preserve organ function and improve patients' long-term well-being. Robotic surgery, equipped with high-definition 3D vision and precision instruments, allows surgeons to perform complex procedures through tiny incisions, result-



ing in less blood loss, reduced pain, minimal scarring and shorter hospital stays.

He said fluorescence-guided surgery helps surgeons accurately identify cancerous tissues and sentinel lymph nodes, reducing unnecessary removal of healthy tissue and lowering complications. The technology is proving effective in the treatment of breast, gynaecological, prostate, bladder, kidney, colorectal and thoracic cancers.

AP Introduces Major Urban Development Reforms to Boost Investments and Speed Project Approvals

Visakhapatnam (TSIT) In a significant push towards faster urban development and economic growth, the Andhra Pradesh Government has unveiled two major reforms by constituting an Implementation Committee for the Amaravati Economic Region (AER) and notifying the Common Zoning Regulations (CZR), 2026. The newly constituted AER Implementation Committee will coordinate the execution of infrastructure, industrial, logistics and investment projects across nine districts surrounding Amaravati.



The Government said the committee will ensure time-bound implementation, inter-departmental coordination, digital monitoring and effective resource mobilisation to transform Amaravati into a globally competitive economic hub

under the Swarna Andhra 2047 vision. At the same time, the Government has introduced the Common Zoning Regulations, 2026, establishing a uniform land-use framework across Andhra Pradesh. The regulations replace multiple zoning systems with nine standard

land-use categories and introduce a negative-list approach, enabling faster and more transparent approvals through the Online Building Permission System while safeguarding environmental and public interests. Officials said the twin reforms will help Andhra Pradesh move from "Ease of Doing Business" to "Speed of Doing Business" by reducing regulatory delays, ensuring uniform planning standards, improving coordination among government agencies, and creating a more investor-friendly environment. The Government expects these measures to accelerate sustainable urban expansion, infrastructure development, investment inflows and employment generation

Collector urges farmers to grow short-duration vegetables amid drought



Jogulamba Gadwal, July 17 (TSIT): With drought-like conditions prevailing due to the delayed southwest monsoon and the impact of El Niño, Jogulamba Gadwal District Collector Rizwan Basha Shaik has advised farmers to shift to short-duration vegetable crops that mature within 60-70 days to conserve water and secure better income.

The Collector said the district had received only 64.9 mm of rainfall since March, putting severe pressure on groundwater resources. He urged farmers

to assess borewell water availability before cultivation and reduce the area under water-intensive crops.

To promote vegetable farming, the district administration has supplied five varieties of vegetable seeds to all 252 Gram Panchayats. Farmers were encouraged to cultivate drought-tolerant crops such as tomato, brinjal, chilli, okra, beans, cluster beans, spinach, bottle gourd, bitter gourd, ridge gourd and cucumber.

He recommended grafted seedlings for tomato and brinjal, organic mulching, farmyard manure, vermicompost, ridge-and-furrow cultivation, drip irrigation and micro-sprinklers to improve water-use efficiency. Farmers were also advised to monitor pest attacks, follow Integrated Pest Management (IPM) practices, and use neem-based and scientifically recommended pesticides.

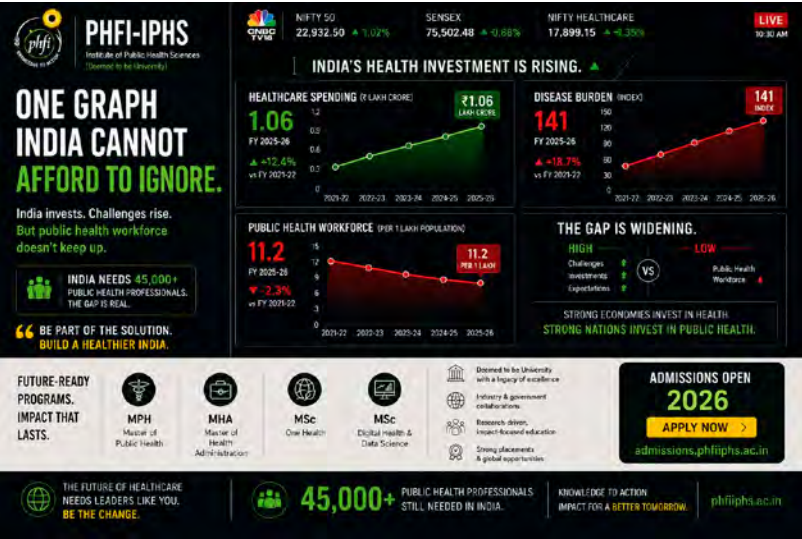

NEET crisis sparks fresh calls for education reforms

New Delhi (TSIT): India's competitive examination system is facing renewed scrutiny following a student suicide linked to the NEET-UG examination, continuing allegations of exam irregularities, and education reform advocate Sonam Wangchuk's indefinite hunger strike demanding greater accountability in the country's examination process. An 18-year-old NEET aspirant from Faridabad, Haryana, allegedly died by suicide after estimating her score using the National Testing Agency's (NTA) provisional answer key. According to reports, the student was distressed after finding her expected marks lower than anticipated. The incident has once again highlighted the immense psychological pressure faced by students preparing for one of India's most competitive entrance examinations. Mental health experts have repeatedly warned that prolonged academic stress, fear of failure, uncertainty surrounding examination outcomes, and societal

expectations are contributing to growing emotional distress among students. The tragedy comes amid continuing controversy over NEET-UG, with allegations of question paper leaks, examination irregularities, legal disputes, re-tests and delays affecting admissions. The developments have raised concerns among students, parents and educators over the credibility of the country's medical entrance examination system. Meanwhile, educationist and climate activist Sonam Wangchuk has continued his indefinite hunger strike at Jantar Mantar in New Delhi in support of the youth-led Cockroach Janta Party (CJP), a satirical movement demanding accountability and reforms in competitive examinations. The protest has called for action over alleged examination irregularities, including the NEET paper leak controversy, and has also demanded the resignation of Union Education Minister Dharmendra Pradhan. According to reports, Wangchuk's health has dete-

riorated as the fast has continued, with doctors monitoring his condition warning of potential health complications associated with prolonged fasting. The Union Government has informed the Delhi High Court that his medical condition is being regularly monitored. The ongoing developments have drawn widespread attention from students, parents, educators and civil society groups, many of whom have called for transparent investigations into examination irregularities, stronger safeguards against paper leaks, independent oversight of national examinations and enhanced mental health support for students.Education experts believe the present crisis extends beyond a single examination and underscores the need for systemic reforms to restore public confidence in India's examination system. They argue that ensuring fairness, transparency and student welfare must remain central to future education policies.

India, Japan agree on phased rollout of Mumbai-Ahmedabad bullet train

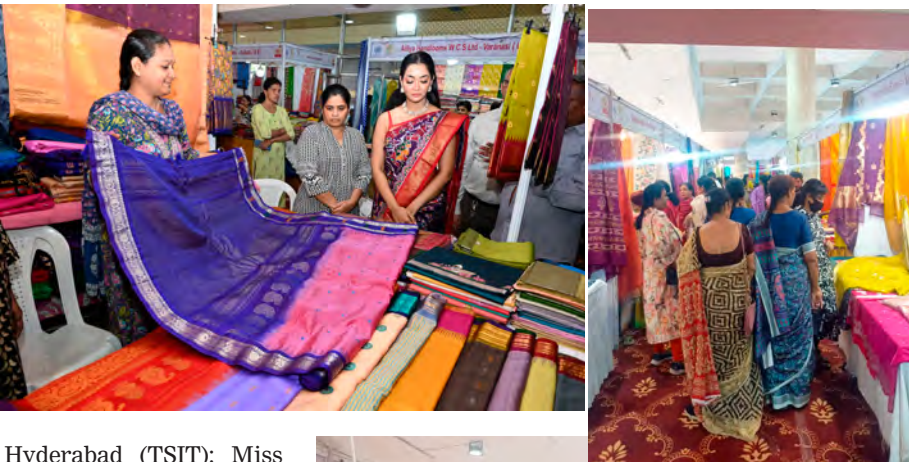
New Delhi: India and Japan have agreed to begin operations of the Mumbai-Ahmedabad High-Speed Rail corridor with Indian high-speed trains, while Japan's next-generation E10 series trains, currently under development, are expected to be introduced in the early 2030s. The decision follows progress in bilateral discussions on the ambitious high-speed rail project, with both countries reaffirming their commitment to launching services at the earliest. Construction of the Mumbai-Ahmedabad bullet train corridor has advanced rapidly, and the first section of the project is expected to become operational in 2027. Officials said the phased approach would allow commercial operations to



commence without waiting for the completion of the E10 series, which is still under development in Japan. The E10 series, regarded as Japan's next-generation Shinkansen train, is expected to be supplied to India in the early 2030s, further strengthening technological cooperation between the two countries. The move reflects the shared objective of India and Japan to expedite the implementation of the country's first high-speed rail project while ensuring a smooth transition to advanced rolling stock once the E10 trains become available.

Why Was A Russian Doomsday Plane In Iran Recently? Inside The 'Tu-214PU'

Russia dispatched a Tupolev Tu-214PU airborne command post, often referred to as a "doomsday plane", to Tehran's Imam Khomeini International Airport. A Tu-214PU aircraft took off from Moscow and landed in Tehran at around 10:10 am (IST) on July 13. The deployment coincided with escalating US and Israeli airstrikes on Iranian military infrastructure after the collapse of a regional ceasefire. The heavily modified Tupolev Tu-214 is operated by the Rossiya Special Flight Squadron and contains advanced, hardened communication and command systems. It enables senior officials to coordinate state affairs and military operations from the air in high-threat environments. The arrival is widely interpreted as a signal of high-level crisis diplomacy and tightening strategic cooperation between Moscow and Tehran. Analysts and commentators have pointed out that while this move doesn't mean Russian troops are entering the fight, it's a massive power signal to Washington, that Russia remains closely aligned with Iran and is prepared to support coordination at a high level. During the ongoing Ukraine war, at least on five occasions, President Putin or his foreign minister has used the 'N' word. Putin's nuclear sabre-rattling has been part of the Russian escalate-to-deescalate strategy that he himself was the author of as a young official. In late 2022, Putin even ordered a drill of Russia's strategic deterrence forces, which included intercontinental ballistic missiles (ICBMs), submarines, and heavy bombers, the entire Russian nuclear triad. Interestingly, both the US and Russia have special airborne presidential command posts to manage major hostilities, especially a nuclear war. These are appropriately called the "Doomsday" airborne command and control aircraft. Doomsday aircraft are essentially large transport aircraft fitted with special, long-range communication equipment, along with some other security features. Russian Doomsday Aircraft "Maxdome" The Russian President's "Doomsday" aircraft is a specially configured Ilyushin Il-80 "Maxdome", which is also referred to as "Flying Kremlin". Interestingly, it was seen flying low over Moscow in early May 2022 during a rehearsal for Victory Day celebrations. Given the repeated threats of nuclear weapon use in the early days of the Ukraine war, such a flypast raised concerns in the strategic community. Earlier, Russian President Putin had said that he won't "brag" about nuclear weapons but will use them "if necessary". The Maxdome had last participated in such a flypast in 2010. The Il-80 Maxdome is a modified Ilyushin Il-86 airliner converted into an airborne command-and-control centre and a presidential office in the sky. The aircraft reportedly made its first flight in 1985 and was inducted in 1987. Four were built, and three are still in service. Such aircraft are required for cases when the ground-based command infrastructure may be destroyed in the event of nuclear war or a major disaster.

PAKISTAN'S IRAN PROBLEM ISN'T GOING ANYWHERE

As fighting between the US and Iran returns to March 2026 levels, the Islamabad MoU that both sides signed on June 17-18 is under severe strain. Barring the possibility of ground operations in Iran by the US and its allies, both Washington and Tehran will inevitably return to the negotiating table, given the pressures on the global energy economy. While it remains to be seen how much the current fighting will force Washington to comply with the MoU's terms (especially vis-à-vis Hormuz), the MoU itself has a principal third signatory - the Prime Minister of Pakistan. This article does not debate the degree to which Pakistan has succeeded or failed at "mediating" the conflict between the US and Iran. Rather, it explores a crucial secondary question: what has Pakistan's unanticipated diplomatic blitz meant for the Iran-Pakistan relationship? The two states, which were once staunch but competitive allies within America's Cold War security architecture, have remained fundamentally at odds since the 1979 Islamic Revolution in Iran. Pakistan's role in the current conflict does not necessarily generate long-term strategic trust between the two, but rather entrenches the complicated outlook that these two Islamic Republics have long adopted towards each other.

Not Your Typical Mediator At the outset, it is important to recognise that Pakistan has not acted as a traditional mediator in the current conflict. It is not like the Middle East's traditional mediators, such as Oman, which has deep institutional memory and the credentials to act as an objective third-party actor bringing good faith between disputing parties. In fact, Islamabad's call-up to the mediating role was the result of a new and personal rapprochement between key figures from the Trump administration (and family) and the Pakistani administration, led de facto by Pakistan's Chief of Defence Forces, Asim Munir, and de jure by Prime Minister Shahbaz Sharif.



Catalysed by a crypto deal (signed with much ceremony in Islamabad) in January 2026, US-Pakistan ties had already evolved sufficiently enough since mid-2025, when President Trump hosted an unprecedented lunch meeting with Munir at the White House in June that year. This coincided with the 12-day war that saw Israel striking Iranian military and nuclear facilities. The relationship was nourished further as Trump's own appreciation of Munir grew, and, finally, matured as Islamabad became the site of talks to end the March war. For Tehran, this arguably meant little, until Pakistan emerged as the US's preferred mediator - especially over Oman, which had publicly expressed frustration with America's negotiating methods. However, given its 'overtly' positive ties with Islamabad, and with Washington conceding on the Iranian demand to have the US Vice-President himself as lead negotiator, Tehran had little reason to deny Pakistan the role. Where Pak's Influence Really Lies For Pakistan, the benefits it sought and still seeks to accrue from its mediatory role are actually rooted in its relationship with Washington, not Tehran. The instrumental element for Pakistan is the degree to which it can persuade Iran to make concessions.

For that, it naturally needed to gain Iran's good faith. For this, it went beyond the traditional ambit of a mediator-at-the-table by influencing the facts on the ground. For instance, across April, it enabled the transshipment of Iranian oil through Pakistani ports, helping Tehran bypass the American blockade of Iranian ports. That this did not fatally degrade Washington's trust in Islamabad proved the resilience of the new US-Pakistan ties. It also proved that Islamabad's actions were meant to reinforce its value in Tehran; they also cushion the fallout from Pakistan's advocacy of Washington's demands during negotiations - something that was explicitly mentioned by Iranian MP and National Security and Foreign Policy Commission Spokesperson, Ebrahim Rezaei.

The Afghanistan Chapter The question of whether mediation of this nature generates long-term trust between Pakistan and Iran is answered by Pakistan's own precedents in Afghanistan. Despite having initially supported Taliban's guerilla action against US/NATO troops in Afghanistan (both during and after Pakistan's overt role as Washington's principal regional partner in the Afghanistan theatre of the Global War on Terror), the ties between

Pakistan and Taliban are now at an all-time low, with Pakistan accusing the latter of orchestrating separatist/militant attacks on its territory. While the Iran-Pakistan relationship is fundamentally different, the Afghanistan-Pakistan experience shows that playing a brokering role does not inherently generate long-term strategic benefits with either party. In the case of Afghanistan, the US ultimately pivoted away from Afghanistan to focus on the Indo-Pacific, while the Taliban sought a more equitable relationship with Islamabad and is still asserting itself to that end. In the Pakistan-Iran case, apart from Iran's dissatisfaction with Pakistan over not curbing anti-Iran terror groups within its territory, it is Tehran's vastly different outlooks towards both the United States and Afghanistan that form the basis of the differences with Pakistan. Note that while Iran helped organise Pakistan-based Shia volunteers during the fight against the Islamic State in Syria (the Zainabiyoun Brigade, which Pakistan designated as a terror group in 2024), sectarian differences have often contributed to an undercurrent of bilateral mistrust.

A Complicated Past

THE NEXT CHAPTER FOR TIER-2 AND TIER-3 AVIATION

India's domestic aviation market is now the world's third largest. Airlines have ordered more than 1,500 aircraft. The number of airports has more than doubled since 2014, from 74 to 159. By the usual scorecard, this is a remarkable success. Look closer at what those assets actually do, and the story becomes more nuanced. Of the 669 routes launched under UDAN, the flagship scheme to connect smaller cities by air, only about half are still flying. An audit by the Comptroller and Auditor General found that once the subsidy supporting a route ends, about one in ten routes continues on its own. The easy explanation is that India's regional aviation market simply is not ready. But almost everything else moving between tier-2 and tier-3 cities is booming. Trains run close to capacity. Highways carry more traffic than planners expected. Business travel by road and rail continues to rise. The challenge, then, is not simply demand. It is that an airport is only one layer of the aviation stack, and the next phase of growth depends on getting two other layers right: what a route is designed around, and what kind of aircraft flies it. The government's recently revamped UDAN policy, often referred to as UDAN 2.0, acknowledges some of this by placing greater emphasis on airport viability, economic potential and industry participation. The next leap in regional aviation



will come from designing an integrated network around economically vibrant corridors, hub connectivity and the aircraft best suited to serve them. UDAN's original unit was the route: start a flight and keep it airborne for a certain period of time. But viability depends on whether that flight plugs into a wider network of onward connections. The smarter unit is the corridor: the business, tourism, healthcare and trade traffic already moving between two economic centres by road and rail. Even a strong corridor can fail if the route was never designed to connect beyond its destination. Another challenge is the aircraft flying on a corridor. India's regional fleet is effectively limited to two options, and neither fits many of the regional routes it is expected to serve. At the smaller end, ATR turboprops carry up to 70 passengers. They are efficient on short

hops but too slow to operate more than a couple of trips a day on regional corridors. At the larger end, airlines fly A320s and 737s seating 150 to 190 people, superbly efficient, but only when a route is busy enough to fill that many seats several times a day. Even when IndiGo expanded into regional connectivity, it turned to ATRs, leaving the gap in the middle largely unaddressed. What India needs is the aircraft in between: the 70-to-120-seat category represented by the likes of Embraer's E-Jets and rivals such as the Airbus A220. These aircraft exist precisely for corridors too thin to fill a 180-seat plane several times a day, but too important to be served only by a slow turboprop. Consider corridors like Coimbatore to Pune, Indore to Nagpur, or Lucknow to Bhubaneswar. These have real, growing demand that still cannot sus-

tain a mainline jet at high frequencies. The logic is simple: a 90-seat jet flying a route four times a day serves passengers better than a 180-seat jet flying it once. The total number of seats is the same, but the odds that a business traveller finds a flight that fits their schedule improve dramatically. On a mid-density corridor, what people value most is frequency, not size. Brazil built much of its domestic network around this. Embraer is a Brazilian company that grew up solving this problem for a country whose economy, like India's, is spread across dozens of mid-sized cities rather than concentrated in three or four. The United States similarly relies on regional jets to serve markets too large for turboprops and too small for mainline aircraft. IndiGo built its dominance by primarily operating A320s, one aircraft family.

Why A Post By A Senior US Defence Official About 'Allies' Should Worry India

"There is a great deal of hubbub about a collective 'middle powers' strategy these days ... we are more concerned that a few allies and partners will think it is and waste valuable time, money and political capital on a distraction." Elbridge Colby, the United States Under Secretary of War for Policy, posted these words on July 14, a week after the NATO Summit in Turkey. His immediate target was Canada. Prime Minister Mark Carney has made collective middle-power action the bedrock of Canadian foreign policy, telling a recent forum that the countries in between must combine to create a third path or find themselves on the menu. Colby's reply dismissed the entire approach as detached from the realities of power. The exchange deserves attention in India as it has structural implications. Colby's response to Ottawa is relevant to every state that is building networks of capable partners, including New Delhi. His post frames what could become the next major strategic question in India-US relations. India has embraced the idea that a network of capable middle powers can shoulder a larger share of Indo-Pacific stability. Washington, in Colby's words, will support stronger partners while remaining deeply sceptical of any framework that diminishes American centrality. Today, the difference is theoretical. Over time, it has the potential to become a structural source of friction between two otherwise converging partners. A Blunt Exposition About Power



Colby's argument rests on a straightforward realist proposition. Countries align because they face common threats, possess complementary capabilities, and pursue shared interests. Geography, economics, military strength, and threat perception determine alignments. Labels matter little. From that perspective, a coherent middle-power bloc is unviable. India worries about China and Pakistan. Australia watches the Western Pacific. Saudi Arabia's principal concern remains Iran. Canada's anxieties centre on its southern neighbour. These countries share only a notion and a label, nothing that matters. Colby's second argument is more important. The United States remains the indispensable military and technological hub of the democratic world. Its defence industrial base, intelligence and military machine and capacity to undertake large-scale operations independently are unmatched. He rejected the suggestion that frustrat-

ed partners will buy their weapons elsewhere, calling the idea neither feasible nor accurate. He further revealed increased demands for American engagement. Allies, he concluded, should build their own defence industries in ways that are collaborative with America. That final phrase summarises his argument. Washington welcomes stronger partners. Washington expects those partners to strengthen the existing American-led system. Capability is encouraged. Alternative centres of strategic gravity are unwelcome. India's Networked Approach India is moving on a different trajectory. Over the past decade, New Delhi has expanded its partnerships in the Indo-Pacific and beyond. The Quad has matured into a platform for maritime cooperation and critical technologies. The India-France partnership now encompasses defence production, space, artificial intelligence, and the Indian Ocean. The India-France-

UAE trilateral has introduced a new model of multilateral cooperation, and engagement with ASEAN, the Gulf, Europe and Africa have deepened simultaneously. Together, these initiatives reflect a coherent philosophy: India is constructing a networked regional order. In this system, several capable powers contribute to stability, free of formal alliances and hierarchical leadership. The purpose is to expand India's options: diversified partnerships, stronger indigenous capability, and insurance against dependence on any single external power, no matter how close. This philosophy has deep roots. Non-alignment faded as a slogan while its central objective endured. Successive governments have sought maximum freedom of action while engaging every major centre of power. Today's minilateralism is the latest evolution of that tradition. Colby's realism is valid in one aspect that must be acknowledged. Middle-power networks currently lack the hard-power depth to function without the American hub. Remove the United States from the Indo-Pacific equation, and the calculation against China collapses. India's planners know this. Their networks are hedges tacked onto the American relationship and designed as insurance rather than substitution. Dangerously, for the middle powers, Colby's post suggests Washington may come to read insurance itself as disloyalty. Two Organising Principles Therein lies the emerging tension.

RUPEE RISES 14 PAISE TO CLOSE AT 96.28 AGAINST US DOLLAR

Mumbai: The rupee rose 14 paise to settle at 96.28 (provisional) against the US dollar on Friday on possible intervention from the Reserve Bank of India after four consecutive sessions of decline. Elevated tensions in West Asia, which pushed up global oil prices, maintained pressure on the local unit, forex traders said. In the interbank foreign exchange market, the rupee opened at 96.35 against the greenback and traded in a narrow range of 96.27-96.41. Eventually it settled at 96.28 (provisional), up 14 paise from its previous close. The rupee depreciated for the fourth straight day on Thursday, shedding 17 paise to settle at 96.42 against the US dollar. The US expanded its airstrike campaign against Iran early on Friday by increasingly hitting bridges, part of President Donald Trump's threats to start striking infrastructure to pressure Tehran to



ease its chokehold on the Strait of Hormuz. Iran launched new missile attacks against US-allied nations in West Asia and warned that its attacks would escalate. "The rupee was broadly steady on Friday after a likely Reserve Bank of India (RBI) intervention halted its four-day decline," Anil Kumar Bhansali, Head of Treasury and Executive Director, Finrex Treasury Advisors LLP. "With no major domestic triggers,

the currency continued to consolidate after recent weakness. However, the broader bias for the rupee remains weak as elevated crude oil prices and cautious foreign fund flows continue to weigh on sentiment. "Market participants will closely monitor global developments, crude oil movement, and FII activity for the next directional move," Jateen Trivedi, VP Research Analyst — Commodity and Currency, LKP Securities,

said. Technically, the rupee is expected to trade in the 96.00-96.55 range, with the overall trend continuing to favour weakness, Trivedi said. Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading marginally down by 0.01 per cent at 100.75. Brent crude, the global oil benchmark, was trading 1.60 per cent higher at USD 85.58 per barrel in futures trade. On the domestic equity market front, Sensex jumped 964.58 points to settle at 78,151.45, while Nifty surged 261.55 points to 24,334.30. Foreign Institutional Investors offloaded equities worth Rs 4,205.56 crore on a net basis on Thursday, according to exchange data. The rupee depreciated for the fourth straight day on Thursday, shedding 17 paise to settle at 96.42 against the US dollar.

Narco-Terror Will Be Eliminated Through 'Detect, Disrupt and Destroy': Home Minister Unveils Three-Year Roadmap

When it comes to decisive leadership on complex and critical issues concerning India's internal security, Union Home Minister Amit Shah stands out prominently. A clear strategy, time-bound planning, and result-oriented execution have become the hallmarks of his leadership. After steering several major national security initiatives to decisive outcomes, his next mission is to free India from the entire ecosystem of drugs and narco-terror. To achieve this objective, the Home Minister has laid out a comprehensive three-year roadmap aimed not merely at increasing drug seizures, but at dismantling the entire network from production and trafficking to financing and distribution. With this vision, the 10th Apex-Level Meeting of the Narco-Coordination Centre (NCORD) was convened in New Delhi under the chairmanship of Union Home Minister Amit Shah. During the meeting, the Vision Document on Drug Control (2026-2029) was released, the Narcotics Control Bureau (NCB) Annual Report was presented, and an online Drug Disposal Fortnight Campaign was launched to destroy 209,500 kilograms



of seized narcotic substances worth approximately ₹6,000 crore. Far from being a routine government event, the meeting marked a significant step toward achieving the vision of a "Drug-Free India" through a structured, time-bound strategy backed by concrete action. In line with Prime Minister Narendra Modi's vision of a Nasha Mukta Bharat (Drug-Free India), Amit Shah has formulated a clear, multi-layered strategy founded on the principle of "Detect, Disrupt and Destroy." The approach begins with accurately identifying drug networks, followed by disrupting their supply chains, financial infrastructure, and operational mechanisms, and ultimately dismantling the

entire ecosystem in a manner that prevents its resurgence. This framework will serve as the cornerstone of India's national anti-drug strategy over the next three years. Under Amit Shah's leadership, India's campaign against narcotics has gained unprecedented momentum in recent years. Guided by a policy of zero tolerance and a network-centric enforcement approach, the country has, since the Modi government assumed office in 2014, seized narcotic substances valued at approximately ₹1.84 lakh crore, destroyed drugs worth nearly 290,000 crore, recovered millions of kilograms of narcotics, and carried out record action against illegal opium cultivation. New Delhi: NASDAQ-listed travel booking platform MakeMyTrip on Friday, July 17, said it has confidentially filed draft red herring prospectus (DRHP) papers with capital markets regulator Sebi for its proposed initial public offering (IPO) of its Indian subsidiary. The company said its wholly-owned subsidiary, MakeMyTrip (India) Ltd (MMT India), has submitted the confidential filing with the Securities and Exchange Board of India (Sebi), BSE, and the National Stock Exchange (NSE) for listing on the main board of the stock exchanges. The proposed IPO is expected to involve a sale of equity shares in MMT India by MakeMyTrip and its wholly owned subsidiary, ibibo Group Holdings (Singapore) Pte Ltd, the Gurugram-headquartered firm, said in a regulatory filing on NASDAQ. Following completion of the proposed IPO, MMT India will continue to remain a subsidiary of



MakeMyTrip and its financial results will continue to be consolidated with those of the parent company, it said. "MakeMyTrip expects the proposed initial public offering and listing of MMT India to enhance its brand visibility and support MMT India's ability to incentivise and promote talent in a competitive technology recruitment landscape," the filing stated. Net proceeds received by MakeMyTrip and ibibo Holdings from the sale of shares in MMT India will further strengthen the cash position of

MakeMyTrip and are expected to be utilised for long-term growth, strategic inorganic initiatives and repurchases of different classes of securities (including convertible securities) by MakeMyTrip, the company said in the filing. Subject to regulatory approvals, MakeMyTrip and MMT India may evaluate alternatives in medium-term to enable our respective shareholders to enjoy the benefits of a security at MMT India level that is fungible and listed across India and US capital markets, the company said.

Mumbai's Small Dairies Seek 2-Month Reprieve From Tukaram Mundhe's New Milk Hygiene Norms



Representatives of Mumbai's small dairy operators on Friday sought a two-month extension from the Maharashtra Food and Drug Administration (FDA) to comply with the state's new milk hygiene norms, arguing that an immediate shift away from loose milk sales would severely disrupt their businesses. A delegation from the Mewar Ekta Mandal, led by Shiv Sena leader Sanjay Nirupam, met FDA Commissioner Tukaram Mundhe after the regulator cancelled licences of loose milk sellers and directed immediate compliance with the new

rules, NDTV reported. Speaking to reporters after the meeting, Nirupam said the delegation was representing nearly 50,000 small dairies across Mumbai. "No one in the world can oppose hygiene and cleanliness. There must be proper cleanliness. We are not opposed to the drive launched by FDA Commissioner Tukaram Mundhe," Nirupam said. He said traders had requested a two-month grace period to transition to the new packaging norms. "Fresh milk can be sold in plastic packaging, but milk brought in tankers cannot be sold loose.

OnePlus begins exiting US, Europe; India could follow in 2027

Hyderabad: OnePlus, one of the most recognisable Android smartphone brands in India, could wind down its India operations as early as 2027, according to a Bloomberg report, even as the company begins shutting down its business in the US and Europe this week. The immediate move, confirmed by OnePlus itself early Thursday, July 16, sees the brand exit two of its biggest Western markets as part of a sweeping restructuring at parent company Oppo. Bloomberg, citing a person familiar with the matter, reported that the decision stems from a mix of declining sales, rising component costs and mounting geopolitical friction over Chinese phone brands operating in the West. Existing users won't be left stranded. OnePlus has said current users in the US and Europe won't be affected immediately and the company will continue offering after-sales support and software updates as devices transition to Oppo's ColorOS. However, no new OnePlus phones, tablets or wear-



ables will launch in these markets going forward. The brand's own OxygenOS is expected to be phased out entirely in favour of ColorOS, alongside sister brand Realme's UI. India's warning signs Speculation that OnePlus was preparing to scale back or exit key global markets, including the US, Europe and India, first surfaced in January this year, though the company publicly denied it at the time. The rumours resurfaced in March, around when OnePlus India CEO Robin Liu abruptly stepped down, officially to "pursue personal passions," fuelling further speculation about

the brand's future in the country. India has been one of OnePlus's most important markets outside China, powered in large part by the mid-range Nord series. But as per Bloomberg's reporting, that hasn't been enough to offset weaker demand, rising costs and supply-chain pressures now weighing on the business. For now, OnePlus will keep operating in India and China as usual, but sources told Bloomberg that the global pullback could extend to India and other markets by 2027. Part of a larger Oppo shake-up The changes extend well beyond OnePlus.

Trump alleges China meddled in 2020 election and questions voting security ahead of midterms



US President Donald Trump has delivered a primetime address in which he accused China of interfering in the 2020 election and alleged "shocking vulnerabilities" in American voting systems. Trump, who spoke from the White House on Thursday, has repeatedly made unsubstantiated claims about voter fraud and foreign meddling in the 2020 election, which he lost to Joe Biden. In the half-hour speech, delivered three months before the midterm elections, he said he had declassified hundreds of intelligence files which supported his claims that Beijing had tried to sway the election in Biden's favour. The US intelligence community has previously concluded China did not interfere in the 2020 election. In response to his speech, China's foreign ministry strongly denied the allegations of Chinese meddling in the 2020 presidential election, saying they were "entirely fabricated". Trump's claims are "malicious smears" which have "long been proven to be groundless", foreign ministry spokesman Lin Jian said. Trump spoke in front of

several members of his top team as he gave his address, but journalists were unable to put questions to the president. In his remarks, he accused China of the "illicit acquisition" of 220 million voter files including personal information. Trump said voter data in 18 states was "bought, stolen or hacked by China" and accused "those responsible for sounding the alarm" of not disclosing the discovery to government officials or Congress. A lot of voter data is publicly available and Trump did not in his speech present any evidence that China had used this information to alter voting systems or to influence election outcomes. Hundreds of pages of intelligence documents were released by the White House during Trump's address, many of them heavily redacted. The BBC is in the process of reviewing them. Democrats, meanwhile, accused Trump of attempting to sow doubts about the security of the upcoming November midterms which will decide control of Congress for the remainder of his presidency.

JAPAN RELAXES ROYAL SUCCESSION RULES - BUT BAN ON FEMALE EMPERORS REMAINS

The Japanese parliament has approved a bill to relax imperial succession rules, amid concerns over the dwindling size of the imperial family. The bill, passed by the upper house on Friday, allows the imperial family to adopt distant male relatives over the age of 15 and lets women keep their royal status after marrying outside the family. But it does not change the law barring women from ascending the throne despite wide public support for a female emperor, meaning Princess Aiko, the only child of the current emperor, is still not eligible to succeed the throne. The bill cleared the lower house last week, and will move through the final legal procedures before the changes take effect. Japan has the world's oldest continuous



hereditary monarchy, with a lineage that's believed to span more than 2,600 years. Currently first in line to the throne is 60-year-old Fumihito, the emperor's younger brother. Fumihito's son, 19-year-old Prince Hisahito, is second in line. Third-in-line, and the last eligible candidate for the throne, is the emperor's 90-year-old uncle. Without any amendments to the law, the

line of succession will end if Prince Hisahito does not have a male child. However, with the new bill, male descendants of 11 former imperial branches could be adopted back into the family. These family branches had been removed following the Second World War. Female members of the imperial family will also be able to retain their royal status if they marry commoners. They were previously made to give up their titles and leave their families - which is what Princess Mako did in 2021 to marry her college sweetheart. This allows for a larger royal family who will be able to keep up with official duties like attending court ceremonies and making public appearances. However, descendants of female members with commoners will still not be able to inherit the throne. The bill, the first amendment to the main text of the Imperial House Law since 1949, marks the biggest overhaul to Japan's imperial system in decades. There has long been public concern over the lack of male heirs in the imperial family - along with debate over whether women should be allowed to take the throne.

CHINA HITS OUT AT BRITISH STEEL NATIONALISATION



China has hit out at the nationalisation of British Steel, saying it "firmly opposes and is strongly dissatisfied with the British government's decision". On Thursday, the UK government said that taking the loss-making firm into public hands would protect jobs and safeguard a "vital national capability". The UK took control of British Steel's operations in Scunthorpe last year, though it was still owned by China's Jingye Group, limiting the government's ability to steer its future. China's commerce ministry said on Friday that the moves "seriously infringed upon Jingye's legitimate rights and interests and severely undermined the confidence of Chinese companies investing in the UK". It also called on Britain to "faithfully fulfil" its obligations under the China-UK Bilateral Investment Treaty. "Disregarding Jingye's significant contribution to the UK economy and society, the British side forcibly took control of the company in the name of national security," the ministry said. The statement added that Beijing would monitor developments closely and support Chinese firms to protect their rights, but did not specify what protecting Chinese companies' rights might involve. The decision to nationalise British Steel threatens to strain the relationship between London and Beijing just as Andy Burnham is set to

become the prime minister on Monday. The incoming PM will have to weigh his approach to the issue with the economic benefits of ties with the world's second largest economy. The China-UK Bilateral Investment Treaty is a legally binding agreement that was signed in 1986. It was designed to promote and protect investments between the two countries. The nationalisation came after Parliament on Wednesday passed legislation allowing the government to bring the steel industry into public ownership under circumstances where it met a public interest test. Jingye is seeking compensation, having previously said the business was losing £700,000 a day. The BBC has been unable to get a response from Jingye itself to Thursday's announcement. Small Business Minister Blair McDougall told the House of Commons on Thursday that the government will appoint an independent valuer in the autumn "to make a judgment on any compensation that is due, and that could be nil". By taking British Steel into public ownership the government now has the power and freedom to decide on the future of the plant, while keeping the blast furnaces going. It is unlikely the government will want to continue running the business in the long term as it is costing it more than a million pounds a day.

Canada fires prompt US air quality alerts as smoke blankets major cities

More than 800 wildfires are burning across Canada, with air quality alerts now extending south into multiple US states. A thick blanket of smoke clouded skylines from Detroit and Toronto to New York and across New England, causing "hazardous" air quality alerts across much of the region. Many outdoor events were cancelled as officials urged for people to stay indoors, stressing the dangerous health ramifications of inhaling the fumes. In Canada, one fire in northern Ontario forced residents from local First Nations to evacuate, with one chief saying that her community has been "burnt to ashes". Hazardous air quality alerts have been issued in cities, including Chicago and Grand Rapids in Michigan, Pittsburgh in Pennsylvania and Toledo in Ohio, according to the US Air Quality Index program. Many outdoor activities were cancelled on Thursday, including events for children's summer camps, and beaches were shuttered along popu-



lar lakes. An outdoor concert for the rock group The Black Keys was being rescheduled in Chicago due to the dangerous air quality. There are currently 858 fires actively burning in Canada, including 30 new fires that sparked on Thursday, according to the Canadian Wildland Fire Information System. The vast majority are burning out of control. The large cluster of fires affecting northwestern areas of Ontario are responsible for sending thick plumes of smoke and poor air quality across Thunder Bay and Toronto, with lower concentrations of smoke high in the atmosphere drift-

ing over the Great Lakes and above New York with hazy skies. "We're in a very serious health situation right now," New York Governor Kathy Hochul said in an announcement on Thursday. She noted thick smoke was "blanketing" much of the state, making it "very unhealthy to be outdoors" in many areas. "This is bad news for every New Yorker," she said. "There will be great impacts." In western regions of New York state, the air quality on Thursday is considered "very unhealthy", while in the New York City metro area the air quality is "unhealthy". Many across

the city - the most populous across the US - were wearing masks over their mouths and nose hoping to protect themselves. A thick haze of smoke blocked views across the city of sights including the Empire State Building and the Statue of Liberty. New York has extended its heat emergency plans and activated its air quality emergency protocols - with hundreds of cooling centres and KN95 masks being made available citywide. In Ontario, there will be quite widespread thunderstorms over the next few days, but the rain may not be enough to make much of a difference. Northwesterly winds will continue to blow the smoke into northern US states for the rest of this week and into the weekend, leading to concerns smoke will drift into New Jersey where Sunday's World Cup final is due to take place. A change in the wind direction by Monday means that the smoke will tend to be steered across Quebec with an improvement in air quality further south in the US.

GERMAN POLITICIAN FACES CALLS TO RESIGN OVER SURROGACY CHILD



German centre-right politician Jens Spahn has been accused of double standards, after he revealed he and his husband had become parents using a surrogate mother in the US. Surrogacy is banned in Germany - a policy firmly backed by his Christian Democrat party, and several years ago by Spahn himself. Although there is no German ban on bringing up a child born to a surrogate mother abroad, Spahn, 46, has been criticised by politicians from several parties, including his own. "Politicians who set standards for others must be measured by them too," said Marion Rosin, a Christian Democrat in Thuringia and part of the Women's Union. "If that credibility is gone,

resignation is a matter of consequence." Spahn, the parliamentary group leader of the Christian Democrats and Christian Social Union, announced on Wednesday that he and his husband Daniel Funke had become parents. "Georg is our greatest joy. This feeling is almost impossible to put into words," he told tabloid newspaper Bild. Then his husband posted a picture on Instagram of the couple with Spahn pushing a pram along with the words "We Are Family". Under the 1990 Embryo Protection Act, surrogacy in Germany is punishable with three years imprisonment or a fine, so Spahn and his partner looked to the US for a surrogate mother.

MORE THAN 500 ROHINGYA VANISHED AT SEA - WHAT HAPPENED?

Two boats carrying an estimated 530 Rohingya asylum seekers left Myanmar's Rakhine state on 29 June, and have not been heard from since. The equivalent of a jumbo jet full of people has vanished. It is very likely that they both capsized. The monsoon has started, the seas are rough, and the boats - usually old fishing trawlers converted to carry as many people as possible - are barely sea-worthy with unreliable engines. It is also very likely that there were few, or no survivors. Half of them may have been women and children. But we will never know for certain. Rakhine has been in a state of war for many years, with the insurgent Arakan Army driving the Myanmar military out of most of it and besieging its last stronghold in the state capital Sittwe, which is now



accessible only by air and sea. Almost all telecommunications have been cut by the military. Chris Lewa, who runs the Arakan Project that campaigns to improve the situation of Rohingyas, has been trying to piece together what may have happened to the two boats. This is extremely challenging. She no longer has contacts she can reach in Sittwe, or in Sin Tet Maw, the Arakan Army-controlled village from

where the boats departed. But through a series of other contacts, combined with other snippets of information, she is confident that both boats did leave on 29 June, one in the morning, the other later in the day. She says they would have been heading for the southern coast of Myanmar, where they would unload their human cargo. From there they would be transported by road, via rough transit camps in the for-

est, through Thailand to the Malaysian border. Normally their families would expect to hear from them within a week or 10 days. Nearly three weeks later, they have heard nothing. The Bangladesh authorities have recovered the body of one woman, washed up from the sea. Fishermen working the sea between the Irrawaddy delta and the coast of Mon state found several other bodies nine days later. Chris Lewa believes all this suggests that the boats capsized, one several hours after leaving Sin Tet Maw, the other after several days of sailing south east. There are more than a million Rohingyas living in overcrowded camps in southern Bangladesh, where aid is drying up, there are almost no jobs, and organised crime gangs operate freely. They are not allowed to leave.



IS LIONEL MESSI ABOVE DIEGO MARADONA IN WORLD CUPS?

Former India captain Bhaichung Bhutia rates Diego Maradona above Lionel Messi in their World Cup performances but said the current Argentine skipper would reach the status of the 1986 Cup-winning hero if the South American country wins the 2026 edition title on Sunday. Argentina face Spain in the 2026 World Cup final in New York on Sunday. Messi also led Argentina to title in the 2022 World Cup in Qatar. Maradona led the 1986 Argentina side to victory and was also the captain of the team that lost to Germany in the final in 1990. For Bhutia, Maradona's exploits of single-handedly winning the 1986 World Cup for Argentina would put him above Messi. But he said a second World Cup trophy for Messi on Sunday will take him on equal standing with Maradona. "It's difficult to compare. But

for me, it's Maradona because he single-handedly won the 1986 World Cup which I don't think any player in history has done that. I watched him in 1986 World Cup and other matches as well," Bhutia told PTI in an interview, when asked to rate Maradona and Messi in the World Cups. "I think Messi is almost near. If he can win this World Cup, I think he will obviously reach the status of Maradona. He (Messi) has already won one World Cup but to overtake Maradona I think he needs one more World Cup to win," said the former India striker. "Messi is a great player but he's got a great team around him who really works for him. For Maradona he had to work for everybody and also create those goal-scoring opportunities (for himself)." Maradona, who died in 2020 at the age of 60, played in four World Cups

(1982, 1986, 1990, 1994) and scored eight goals from 21 matches. Messi, on the other hand, is playing in his sixth World Cup (2006, 2010, 2014, 2018, 2022 and 2026) and has scored 21 goals from 33 appearances so far. He also led Argentina to a runners-up finish in the 2014 World Cup, losing 0-1 to Germany in the final.

'Spain slight favourites against Argentina'

For Bhutia, Spain are a complete side and they are the favourites to win the title against Argentina on Sunday, though he feels that the Messi-led team cannot be written off after the so many stupendous comeback wins. "Spain has a complete team structure, they have a better midfield, they don't really wait for a single player or moment," said Bhutia, Indian football's poster boy in the first decade of this century.

Rohit Sharma "Wasn't Happy": Report Shares Inside Details Of BCCI's 'Last ODI' Meeting



Indian cricket is abuzz with speculation about the curtains coming down on one of the most illustrious ODI batters, Rohit Sharma's career. The speculation had intensified even before the England series as BCCI and Team India chalk out plans for next year's ODI World Cup. Rohit Sharma will be over 40 by the time India play the ODI World Cup in late 2027. While his form has been decent, the fact that an in-form younger opener, Yashasvi Jaiswal, has been waiting on the sidelines for a long time has not escaped anyone's attention. On Thursday, multiple reports claimed that the third India vs England ODI at Lord's on July 19 might be the last time Rohit will be picked for the Indian team. The Indian Express reported that Rohit met with BCCI officials during the ongoing three-match ODI series against England, and the opener 'wasn't happy' with their decision. The report further claimed that the BCCI selec-

tion committee has informed Rohit that they have decided to 'move on' from the former India captain after the ODI series. The selection committee reportedly spoke with Sharma, along with coach Gautam Gambhir, last week. The BCCI selectors are intent on giving youngsters like Yashasvi Jaiswal game time while looking ahead to the 2027 World Cup. "The selectors have decided that henceforth they will not select Rohit Sharma in ODIs. If he wants to bow out gracefully or chooses not to call it a day immediately, that is entirely

his personal decision. However, the message is clear: the selectors will not pick him for ODIs after the game at Lord's on Sunday," a BCCI source told IANS on Thursday. On May 7, 2025, Rohit quit Test cricket ahead of India's five-match tour of England and was shortly replaced by Shubman Gill as the Test captain. In 286 ODI games, Rohit has amassed 11,731 runs and firmly established himself in Indian cricket folklore as one of the most explosive and dependable openers in the 50-over format.

Virat Kohli, Ravi Shastri Knew About Rohit Sharma? 2nd ODI Broadcast Drops Big Hints

Cricket fans around the world were left stunned after reports of Rohit Sharma's international retirement began circulating on Thursday. During the second ODI against England in Cardiff, which India lost by four wickets, Rohit once again failed to make a significant impact with the bat, scoring just 26 runs. However, a report by The Indian Express claimed that the third and final ODI between the two teams at the iconic Lord's on Sunday could be Rohit's last match for India. Rohit, who has already retired from Test and T20I cricket, had reportedly set his sights on playing the 2027 ODI World Cup. However, the report stated that the selection committee had informed him that he was no longer part of their plans for the tour-



nament. While the reports left fans heartbroken, several subtle moments during the second ODI against England fuelled speculation about Rohit's possible farewell. One picture, in particular, went viral on social media, showing a visibly dejected Virat Kohli seated between Rohit and pacer Jasprit Bumrah. The image was captured

shortly after Kohli was dismissed for 65 by Jofra Archer, and many initially assumed his expression reflected disappointment over his wicket. However, as reports of Rohit's retirement gathered momentum, fans began viewing the moment differently, adding to the emotional reaction online. Another poignant moment came during India's fielding

innings, when renowned commentator Ravi Shastri repeatedly highlighted Rohit's achievements as both a captain and a batter. His remarks on Rohit's leadership qualities and contributions to Indian cricket further intensified speculation that the ODI series finale could mark the end of an illustrious international career. "He's been on the side for a long time. Won the T20 World Cup but missed out on the 50-over World Cup. He's got the record for the most hundreds in the World Cup. Five of them in the UK in the 2019 edition," said Shastri. The Indian Express reported that Rohit met with BCCI officials during the ongoing three-match ODI series against England, and the opener 'wasn't happy' with their decision.

SLAVKO VINCIC: Argentina's Ultimate Bogeyman Appointed Referee For FIFA World Cup 2026 Final

The referee for the FIFA World Cup 2026 final has been decided, and it is Slovenia's Slavko Vincic who has been given both the honour and the responsibility of officiating the high-profile clash. Assisting him in the Argentina vs Spain clash in New York on Sunday will be the likes of Tomaz Klančnik (assistant referee 1), Andraz Kovacic (assistant referee 2), Adham Makhadmeh (fourth official), and Mohammad Alkalaf (reserve assistant referee). "Playing with golden stripes is something beautiful. I am sure you agree with me. It's beautiful and it's absolutely great. As well, it's great that the referee will be Slavko Vincic," head of refereeing at FIFA, Pierluigi Collina, said in a video



shared on social media, as Vincic's appointment was confirmed. Amid the chatter around FIFA 'favouring' Argentina in this World Cup, there has been an additional focus on the referees and the VAR (Video Assistant Referee) in this tournament.

Vincic was in tears as the announcement of his appointment was made. The video of the occasion was also shared by FIFA on social media. Who is Slavko Vincic? At 46 years old, Slovenia's Slavko Vincic reached the absolute pinna-

Max Verstappen has left his future in Formula 1 open again ahead of the Belgian Grand Prix and praised his "really good" relationship with Red Bull team principal Christian Horner. Verstappen has yet to commit to staying

with Red Bull for next year after he was linked to McLaren and suggested he'd consider leaving F1. "I don't want to go here, say yes, and no, and this and that about my future. I said already many times that if there was something new I would say it myself," the four-time world champion said Thursday. Mekies is marking a year in charge of the team after replacing longtime boss Christian Horner midway through 2025, and Verstappen had warm words for him. "It's been really good. I get on very well with Laurent. We speak a lot on track, but also off track," he said. "I think the relationship that he has also within the team is great. "Everything for me feels very posi-

tive and I think it's always nice when you can discuss a lot of things with your team boss. So from that sense, yeah, very happy. It's all very open and transparent." After faults with the rotating rear wing pitched Verstappen into the barriers at high speed two weeks running in Austria and Britain, Red Bull is reverting back to an old wing design for Belgium this week. "It's quite obvious, no, why? So we'll go back on the old one and then see whenever the latest or new one is ready again to be used for us," Verstappen said. He crashed out of the British Grand Prix and delivered an expletive-laden rant at the car over the radio before branding it "dangerous" to drive. It's the

third year running that Verstappen has kept his future open, only to recommit to Red Bull halfway through the season. Last year, he didn't pledge to stay with the team until the Hungarian Grand Prix on July 31. He has been part of Red Bull's racing program since childhood and has a contract through 2028, though it includes clauses potentially allowing an earlier exit. This time, a reported meeting between Verstappen's management and McLaren fueled the speculation of what would have been a blockbuster move. McLaren has also signed Verstappen's longtime engineer and confidant Gianpiero Lambiase as its "chief racing officer" in future.
